# The truncated EM method for stochastic differential equations with Poisson jumps

# Abstract

In this paper, we use the truncated EM method to study the finite time strong convergence for the SDEs with Poisson jumps under the Khasminskii-type condition. We establish the finite time  $\mathcal{L}^r$  ( $r \geq 2$ ) convergence rate when the drift and diffusion coefficients satisfy super-linear condition and the jump coefficient satisfies the linear growth condition. The result shows that the optimal  $\mathcal{L}^r$ -convergence rate is close to  $1/(1 + \gamma)$ , where  $\gamma$  is the super-linear growth constant. This is significantly different from the result on SDEs without jumps. When all the three coefficients of SDEs are allowing to grow super-linearly, the  $\mathcal{L}^r(0 < r < 2)$  strong convergence results are also investigated and the optimal strong convergence rate is shown to be not greater than 1/4. Moreover, we prove that the truncated EM method preserve nicely the mean square exponentially stability and asymptotic boundedness of the underlying SDEs with Piosson jumps. Several examples are given to illustrate our results.

*Keywords:* Stochastic differential equations, local Lipschitz condition, Khasminskii-type condition, truncated EM method, Piosson jumps.

#### 1. Introduction

Due to the broad applications in modeling uncertain phenomenon, stochastic differential equations (SDEs) driven by Brownian motions have been attracting lots of attentions [\[1,](#page-33-0) [2](#page-33-1)]. When some unexpected events happen, some jumps may be needed to model the effects of those

In their papers, the strong convergence, the convergence rates and stability of different implicit methods were proposed and investigated for some SDEs, whose drift coefficient satisfies non-

- <sup>15</sup> global Lipschitz condition, and both the diffusion coefficient and the coefficient for the Poisson jumps are global Lipschitzian. When the global Lipschitz condition on the diffusion coefficient is disturbed, the tamed Euler and the tamed Milstein methods were proposed for SDEs driven by the more generalised process, Lévy process  $[6, 7]$  $[6, 7]$  $[6, 7]$ . The taming techniques were original proposed in [\[8](#page-33-7)] for the construction of explicit methods for SDEs with non-globally Lipschitz
- <sup>20</sup> continuous coefficients. As indicated in [\[9](#page-33-8)], explicit methods have their own advantages on the relatively simple structure and the avoidance of solving some nonlinear systems in each iteration. Therefore, the studies on explicit methods for SDEs with non-global Lipschitz coefficients have been blooming in recent years. Sine and cosine functions were employed in [\[10\]](#page-33-9) to construct some explicit methods for SDEs with both the drift and diffusion coefficients growing super-<sup>25</sup> linearly. The taming techniques were modified and generalised in [\[11\]](#page-33-10) and [\[12\]](#page-33-11). The truncated
- Euler method were proposed in [\[13](#page-33-12), [14](#page-33-13)].

In this paper, we borrow the truncating idea to propose the truncated Euler method for SDEs with Poisson jumps. The main contributions of this work are twofold. Firstly, all the drift coefficient, the diffusion coefficient and the coefficient for Poisson jumps are allowed to grow <sup>30</sup> super-linear. To our best knowledge, this is the first work to study an explicit numerical method for SDEs with all the three coefficients that can grow super-linearly. Secondly, both the finite time convergence and asymptotic behaviours of the method are investigated.

It should be noted that the truncated Euler for SDEs with the global Lipschitzian pure jumps were studied in  $[15]$ . Other numerical methods for SDEs with Poisson jumps or Lévy process

For the detailed and systemic introductions to numerical methods for SDEs and SDEs with jump, we refer the readers to the monographs [\[21\]](#page-33-20) and [\[22\]](#page-33-21).
- This paper is constructed as follows. Section [2](#page-1-0) sees some necessary mathematical preliminaries. Section 3 contain the main results on the finite time convergence. The asymptotic behaviours, stability and boundedness, of the numerical solutions are presented in section 4. Several examples are given in the Section 5. Section [6](#page-29-0) concludes the paper and points out some future research.

### <span id="page-1-0"></span>2. Mathematical Preliminaries

- 45 Throughout this paper, unless otherwise specified, let  $(\Omega, \mathcal{F}, \mathbb{P})$  be a complete probability space with a filtration  $\{f_t\}_{t>0}$  satisfying the usual conditions (i.e., it is increasing and right continuous while  $\mathcal{F}_0$  contains all P-null sets). Let E denote the probability expectation with respect to  $\mathbb P$ . Let *B*(*t*) be an *m*-dimensional Brownian motion defined on the probability space and is  $\mathcal{F}_t$ adapted. *N*(*t*) is a scalar Poisson process with the compensated Poisson precess  $N(t) = N(t) - \lambda t$ ,
- where the parameter  $\lambda$  is a jump intensity. If *A* is a vector or matrix, its transpose is denoted by  $A^T$ . If  $x \in \mathbb{R}^d$ , then |*x*| is the Euclidean norm. If *A* is a matrix, its trace norm is denoted by  $|A| = \sqrt{(A^T A)}$ . For two real numbers *a* and *b*, we use  $a \vee b = \max(a, b)$  and  $a \wedge b = \min(a, b)$ . For a set *G*, its indicator function is denoted by  $\mathbb{I}_G$ . Moreover,  $\mathcal{L}^r = \mathcal{L}^r(\Omega, \mathcal{F}, \mathbb{P})$  denotes the space of random variables *X* with a norm  $|x|_r := (\mathbb{E}|X|^r)^{1/r} < \infty$  for  $r > 0$ . In what follows,

Consider a *d*-dimensional SDEs with Piosson jumps:

with the initial value  $x(0) = x_0 \in \mathbb{R}^d$ , where  $x(t^-)$  denotes  $\lim_{s \to t^-} x(s)$ . Here,  $f : \mathbb{R}^d \to \mathbb{R}^d$  is the drift coefficient,  $g : \mathbb{R}^d \to \mathbb{R}^{d \times m}$  is the diffusion coefficient,  $h : \mathbb{R}^d \to \mathbb{R}^d$  is the jumps coefficient.

# 3. Finite time convergence

 $\epsilon$ <sup>0</sup> 3.1. Convergence rate of the partially truncated EM method in  $\mathcal{L}^r$  ( $r \geq 2$ )

In order to discuss the convergence rates of the truncated EM method in  $L^r$  for  $r \geq 2$ . We assume that *f* and *g* can be decomposed as  $f(x) = F_1(x) + F(x)$  and  $g(x) = G_1(x) + G(x)$ , where  $F_1, F: \mathbb{R}^d \to \mathbb{R}^d$ , and  $G_1, G: \mathbb{R}^d \to \mathbb{R}^{d \times m}$ . Moreover, the coefficients *F*, *G*, *F*<sub>1</sub>, *G*<sub>1</sub> and *h* satisfy the following conditions.

**Assumption 3.1.** *There exist positive constant*  $L_1 > 0$  *and*  $\gamma \ge 0$  *such that*

The parameter  $\gamma$ , which we call super-linear growth constant. By Assumption [3.1,](#page-2-0) we can derive that there exists a positive constant  $K_1$  such that

which implies that  $F_1$ ,  $G_1$  and  $h$  satisfy the linear growth condition. Similarly, we have

**Assumption 3.2.** *There exists a pair of constant*  $\bar{r} > 2$  *and*  $L_2 > 0$  *such that*

(x - y)^{T} (F(x) - F(y)) + \frac{\bar{r} - 1}{2} |G(x) - G(y)|^{2} \le L_{2} |x - y|^{2}, \quad \forall x, y \in \mathbb{R}^{d}.

By Assumption [3.2,](#page-2-1) we can derive that for any  $r \in [2, \bar{r})$

(x - y)^{T} (f(x) - f(y)) + \frac{r - 1}{2} |g(x) - g(y)|^{2} \le L_{3} |x - y|^{2}.

where  $L_3 = 2L_1 + L_2 + \frac{L_1^2 + (r-1)(\bar{r}-1)}{\bar{r}-r}$  $\frac{-1}{r-r}$  (see [\[23\]](#page-33-22)).

Assumption 3.3. *(Khasminskii-type condition) There exist constants*  $\bar{p} > \bar{r}$ ,  $K_2 > 0$  *such that*

By Assumption [3.3,](#page-2-2) we also have that for any  $p \in [2, \bar{p})$

where  $K_3 = 2K_1 + K_2 + \frac{K_1^2 + (p-1)(\bar{p}-1)}{\bar{p}-p}$ *p*<sup>−1</sup><sub>*p*<sup>−1</sup></sub> (see [\[23\]](#page-33-22)).

The truncated idea is to deal with the super-linear coefficients. In the viewpoint of the finitetime convergence, the linear coefficient does not cause any problem to the EM scheme and hence there is no need to truncate it [\[23\]](#page-33-22). In our truncated EM method, we only truncate the super-linear terms, that is *F* and *G*. To define the truncated EM scheme, we first choose a strictly increasing function  $\mu : \mathbb{R}^+ \to \mathbb{R}^+$  such that  $\mu(n) \to \infty$ , as  $n \to \infty$ , and

$$
\sup_{|x| \le n} |F(x)| \vee |G(x)| \le \mu(n), \quad \forall n \ge 1.
$$

Denoted by  $\mu^{-1}$  is the inverse function of  $\mu$ . We also choose a strictly decreasing function  $\varphi$ :  $(0, 1) \rightarrow (0, \infty)$  such that

$$
\lim_{\Delta \to 0} \varphi(\Delta) = \infty \quad \text{and} \quad (\varphi(\Delta))^{\bar{p}} \le \Delta^{-1} \wedge \Delta^{-\bar{p}/4}, \quad \forall \Delta \in (0, 1]. \tag{3.8}
$$

For a given step size  $\Delta \in (0, 1)$ , let us define a mapping  $\pi_{\Delta}$  from  $\mathbb{R}^d$  to the closed ball {*x*  $\in \mathbb{R}^d$  :  $|x| \leq \mu^{-1}(\varphi(\Delta))$  by

We set  $x/|x| = 0$  when  $x = 0$ . We then define the partially truncated functions

F_{\Delta}(x) = F(\pi_{\Delta}(x)), \quad G_{\Delta}(x) = G(\pi_{\Delta}(x)), \quad \forall x \in \mathbb{R}^d

f_{\Delta}(x) = F_1(x) + F_{\Delta}(x) \quad \text{and} \quad g_{\Delta}(x) = G_1(x) + F_{\Delta}(x), \quad \forall x \in \mathbb{R}^d
$$

It is easy to see that

Obviously, *F*<sup>∆</sup> and *G*<sup>∆</sup> are bounded while *F* and *G* may not. The following lemma shows that the truncated functions maintain the Khaminskii-type condition nicely (see [\[13\]](#page-33-12)).

**Lemma 3.4.** *Let Assumption* [3.3](#page-2-2) *hold. Then, for all*  $\Delta$  ∈ (0, 1]*, we have* 

$$
x^{T} F_{\Delta}(x) + \frac{\bar{p} - 1}{2} |G_{\Delta}(x)|^{2} \le 2K_{2}(1 + |x|^{2}), \quad \forall x \in \mathbb{R}^{d}.
$$

We can show that for any  $p \in [2, \bar{p})$ , we have

where  $K_4 = 2K_1 + 2K_2 + \frac{K_1^2 + (p-1)(\bar{p}-1)}{\bar{p}-p}$  $p_{\bar{p}-p}^{(p-1)}$  (see [\[23\]](#page-33-22)). We now form the discrete-time truncated EM numerical solutions  $X_{\Delta}(t_k^-) \approx x(t_k^-)$ , for  $t_k^- = k\Delta t$  by setting  $X_{\Delta}(0) = x_0$  and computing

$$
X_{\Delta}(t_{k+1}^{-}) = X_{\Delta}(t_{k}^{-}) + f_{\Delta}(X_{\Delta}(t_{k}^{-}))\Delta t + g_{\Delta}(X_{\Delta}(t_{k}^{-}))\Delta B_{k} + h(X_{\Delta}(t_{k}^{-}))\Delta N_{k}, \quad 0 \le k \le M - 1, \quad (3.11)
$$

where  $\Delta B_k = B(t_{k+1}^-) - B(t_k^-)$ ,  $\Delta N_k = N(t_{k+1}^-) - N(t_k^-)$ . It is consentient to use the continuous-time step process  $\bar{x}_{\Delta}(t^{-})$  which is defined by

where  $\mathbb I$  is a indicator function. The other continuous-time process is defined by

$$
x_{\Delta}(t^-) = x_0 + \int_0^t f_{\Delta}(\bar{x}_{\Delta}(s^-))ds + \int_0^t g_{\Delta}(\bar{x}_{\Delta}(s^-))dB(s) + \int_0^t h(\bar{x}_{\Delta}(s^-))dN(s).
$$

It is easy to see that  $x_{\Delta}(t_k^-) = \bar{x}_{\Delta}(t_k^-) = X_{\Delta}(t_k^-)$ . Moreover,  $x_{\Delta}(t^-)$  is an Itô process with Itô differential

dx_{\Delta}(t^-) = f_{\Delta}(\bar{x}_{\Delta}(t^-))dt + g_{\Delta}(\bar{x}_{\Delta}(t^-))dB(t) + h(\bar{x}_{\Delta}(t^-))dN(t).
$$

Lemma 3.5. *Under Assumption [3.1](#page-2-0) and [3.3](#page-2-2) the SDE* [\(2.1\)](#page-2-3) *has a unique global solution x*(*t*)*, moreover, for any*  $p \in [2, \bar{p})$ *,*

In order to bound the *p*-th moment of the truncated EM solution, we need the following lemma.

**Lemma 3.6.** *For any*  $\Delta$  ∈ (0, 1] *and*  $t > 0$ *, we have*

\mathbb{E}|x_{\Delta}(t^{-}) - \bar{x}_{\Delta}(t^{-})|^{\hat{p}} \le C\Big((\varphi(\Delta))^{\hat{p}}\Delta^{\hat{p}/2} + (1 + \mathbb{E}|\bar{x}_{\Delta}(t^{-})|^{\hat{p}})\Delta\Big), \quad \forall \hat{p} \ge 2. \tag{3.13}

**Proof.** Fix any  $\Delta \in (0, 1]$ ,  $t \ge 0$  and  $\hat{p} \ge 2$ . There is a integer  $k \ge 0$  such that  $t_k^- \le t < t_{k+1}^-$ . By Assumption [3.1](#page-2-0) and [\(3.9\)](#page-3-0), we have

= \mathbb{E} \left| \int_{t_{k}^{-}}^{t} f_{\Delta}(\bar{x}_{\Delta}(s^{-})) ds + \int_{t_{k}^{-}}^{t} g_{\Delta}(\bar{x}_{\Delta}(s^{-})) dB(s) + \int_{t_{k}^{-}}^{t} h(\bar{x}_{\Delta}(s^{-})) dN(s) \right|^{\hat{p}} \leq C \left( \mathbb{E} \left| \int_{t_{k}^{-}}^{t} f_{\Delta}(\bar{x}_{\Delta}(s^{-})) ds \right|^{\hat{p}} + \mathbb{E} \left| \int_{t_{k}^{-}}^{t} g_{\Delta}(\bar{x}_{\Delta}(s^{-})) dB(s) \right|^{\hat{p}} + \mathbb{E} \left| \int_{t_{k}^{-}}^{t} h(\bar{x}_{\Delta}(s^{-})) dN(s) \right|^{\hat{p}} \right)

\leq C \left( \Delta^{\hat{p}-1} \mathbb{E} \int_{t_{k}^{-}}^{t} \left| f_{\Delta}(\bar{x}_{\Delta}(s^{-})) \right|^{\hat{p}} ds + \Delta^{(\hat{p}-2)/2} \mathbb{E} \int_{t_{k}^{-}}^{t} \left| g_{\Delta}(\bar{x}_{\Delta}(s^{-})) \right|^{\hat{p}} ds + \mathbb{E} \left| \int_{t_{k}^{-}}^{t} h(\bar{x}_{\Delta}(s^{-})) dN(s) \right|^{\hat{p}} \right)

\leq C \left( \Delta^{\hat{p}/2} (1 + \mathbb{E}|\bar{x}_{\Delta}(t^{-})|^{\hat{p}} + (\varphi(\Delta))^{\hat{p}}) + \mathbb{E} \left| \int_{t_{k}^{-}}^{t} h(\bar{x}_{\Delta}(s^{-})) dN(s) \right|^{\hat{p}} \right),

where  $C$  is a generic constant, the value of which may change between occurrences. By the characteristic function's argument [\[24\]](#page-33-23), for  $\Delta \in (0, 1]$

where  $c_0$  is a positive constant which is independent of  $\Delta$ . Therefore,

$$
\mathbb{E}\left|\int_{t_k^-}^t h(\bar{x}_\Delta(s^-))dN(s)\right|^{\hat{p}} = \mathbb{E}|h(X_\Delta(t_k^-))\Delta N_k|^{\hat{p}} \n= \mathbb{E}|h(X_\Delta(t_k^-))|^{\hat{p}}\mathbb{E}|\Delta N_k|^{\hat{p}} \le C(1 + \mathbb{E}|\bar{x}_\Delta(t^-)|^{\hat{p}})\Delta.

Inserting this into [\(3.14\)](#page-4-0) and combing with  $\Delta^{\hat{p}/2} \leq \Delta$  gives

**Proof.** Fix any  $\Delta \in (0, 1]$  and  $T > 0$ . By the Itô formula and [\(3.10\)](#page-3-1), we have

\mathbb{E}|x(T) - \bar{x}_{\Delta}(T)|^{r} \le C\Delta^{e(p-(1+\gamma)r)/(1+\gamma)\wedge(p-\gamma r)/p}.
$$
\n(3.53)

Proof. Condition [3.51](#page-11-0) means

<span id="page-11-2"></span><span id="page-11-1"></span><span id="page-11-0"></span>
$$
\varepsilon \leq \frac{1}{p} < \frac{r(1+\gamma)}{2p}
$$

which lead to

$$
\varepsilon(p - (1 + \gamma)r)/(1 + \gamma) < r(1 - 2\varepsilon)/2.
$$

By [\(3.40\)](#page-8-5) and [\(3.41\)](#page-8-6), we obtain [\(3.52\)](#page-11-1) and [\(3.53\)](#page-11-2).  $\Box$ 

**Remark 3.13.** *Replacing condition* [\(3.35\)](#page-8-0)*, that is*  $p > (1 + \gamma)\bar{r}$ *, by a weaker one*  $p > (1 + \gamma)r\sqrt{r}$ *does not a*ff*ect the results in Theorem [3.11.](#page-8-7) But, this small change will make the choice of p more* <sup>90</sup> *flexible in practice.*

**Remark 3.14.** Without loss of generality, we assume that  $\bar{p}$  is allowed to sufficiently large. In the *following discussion, we fixing*  $2 \le r < \bar{r}$ *. By Corollary* [3.12,](#page-10-4) we can conclude that when p, which *is a parameter in the Khaminskii-type condition defined in* [\(3.7\)](#page-3-3)*, is su*ffi*ciently large relative to* γ*r, then the order of* L*<sup>r</sup> -convergence of the truncated EM method is mainly determined by the expression which we call the convergence rate function, namely*

$$
R(p,\gamma) := \frac{\varepsilon(p - (1 + \gamma)r)}{1 + \gamma}, \quad \forall p \in ((1 + \gamma)r \lor \bar{r}, \bar{p}), \quad \forall \gamma \in [0, \infty),
$$
 (3.54)

*for some*  $0 < \varepsilon \leq 1/4 \wedge 1/p$ *. Noting that R is proportional linearly to*  $\varepsilon$ *, which means that letting* ε = 1/4 ∧ 1/*p will make convergence rate R as large as possible. Hence, this setting gives*

R(p,\gamma) = \frac{(1/4 \wedge 1/p)(p - (1 + \gamma)r)}{1 + \gamma}.
$$
\n(3.55)

*To discuss the optimal convergence rate function [3.55,](#page-11-3) let us consider the following two possible cases:*

• *If*  $2 < p < 4$  *and*  $(1 + \gamma)r \vee \bar{r} < p < \bar{p}$ *, then* [\(3.55\)](#page-11-3) *gives* 

$$
R(p,\gamma) = \frac{1}{4} \left( \frac{p}{1+\gamma} - r \right) = \frac{p}{4} \frac{1}{1+\gamma} - \frac{r}{4} < \frac{1}{1+\gamma}.\tag{3.56}
$$

• *If*  $p \ge 4$  *and*  $(1 + \gamma)r \vee \bar{r} < p < \bar{p}$ *, then* [\(3.55\)](#page-11-3) *gives*

R(p,\gamma) = \frac{p - (1+\gamma)r}{p(1+\gamma)} = \frac{1}{1+\gamma} - \frac{r}{p} < \frac{1}{1+\gamma}.\tag{3.57}

*From* [\(3.57\)](#page-11-4)*, we can see that R*(*p*, γ) *is a decreasing function with respect to* γ *and is a increasing function with respect to p. Fig [1](#page-12-0) and Fig [2](#page-12-0) show this relationship between convergence rate and Khasminskii-type condition parameter p, super-linear growth constant* γ*, repectively. Letting*  $p \rightarrow \infty$ *, then* [\(3.57\)](#page-11-4) *gives* 

$$
R \to \frac{1}{1+\gamma}.
$$

*This is almost the optimal* L*<sup>r</sup> -convergence rate of the truncated EM method in the case of jumps. Only in the case of*  $\gamma = 0$ *, i.e. the drift and diffusion coefficients grows linearly, this convergence rate is close to 1. It should be mentioned that this is significantly di*ff*erent from the result on SDEs without jumps. We already known that for any*  $r \geq 2$  *(see [\[25\]](#page-33-24))* 

$$
\mathbb{E}|x(T) - x_{\Delta}(T)|^{r} \le C\Delta^{r(1-2\varepsilon)/2}, \quad \forall \varepsilon \in (0, 1/4],
$$

*which means that the* L*<sup>r</sup> -convergence rate is close to r*/2 *when there is no jumps in SDE* [\(2.1\)](#page-2-3)*. In fact, this di*ff*erence is caused by the following reason: all moments of the Poisson increments* <sup>95</sup> ∆*N<sup>k</sup>* = *N*((*k* + 1)∆) − *N*(*k*∆) *have the same order* ∆ *(see* [\(3.15\)](#page-4-3)*), while the Brownian increments*  $\Delta B_k = B((k+1)\Delta) - B(k\Delta)$  *have different orders, namely*  $\mathbb{E}|\Delta B_k|^{2m} = o(\Delta^m)$  *and*  $\mathbb{E}|\Delta B_k|^{2m+1} = 0$ *. These properties force the control function*  $\varphi(\Delta) := \Delta^{-\varepsilon}$  *to be not greater than*  $\Delta^{-1/p} \wedge \Delta^{-1/4}$ *, when we are tring to bound the moments of the truncated EM solution in Lemma [3.7.](#page-5-1) This eventually leads to the di*ff*erences in the convergence rates between SDEs with and without jumps.*

<sup>100</sup> 3.2. Convergence and convergence rate of the truncated EM method in  $\mathcal{L}^r(0 < r < 2)$ 

In this subsection, we will discuss the convergence in  $\mathcal{L}^r(0 < r < 2)$  under the assumption that the drift, diffusion and jump terms behave like a polynomial. For this purpose, we first impose the following assumptions.

Assumption 3.15. *There exists positive constant K<sup>n</sup> such that*

**Assumption 3.16.** *There exist constants*  $\bar{K} > 0$  *such that* 

$$
2x^{T} f(x) + |g(x)|^{2} + \lambda (2x^{T} h(x) + |h(x)|^{2}) \le \bar{K} (1 + |x|^{2}), \quad \forall x \in \mathbb{R}^{d}.
$$
 (3.59)

We also give a known result as a lemma.

**Lemma 3.17.** *Under Assumption* [3.15](#page-12-1) *and* [3.16](#page-12-2) *the SDE* [\(2.1\)](#page-2-3) *has a unique global solution*  $x(t)$ *, moreover,*

\sup_{0 \le t \le T} \mathbb{E}|x(t)|^2 < \infty, \quad \forall T > 0. \tag{3.60}

In this subsection, all the three coefficients of the SDEs are allowed to grow super-linearly. Hence, we have to truncate the three terms. Similarly, we first choose a strictly increasing function  $\mu : \mathbb{R}^+ \to \mathbb{R}^+$  such that  $\mu(n) \to \infty$ , as  $n \to \infty$ , and

Denoted by  $\mu^{-1}$  is the inverse function of  $\mu$ . We also choose a constant  $\Delta^* \in (0, 1)$  and a strictly decreasing function  $\varphi$  :  $(0, \Delta^*) \to (0, \infty)$  such that

\varphi(\Delta^*) \ge \mu(1), \quad \lim_{\Delta \to 0} \varphi(\Delta) = \infty \quad \text{and} \quad \varphi(\Delta) \Delta^{1/4} \le 1.

For a given step size  $\Delta \in (0, \Delta^*)$ , the truncated functions are defined as below

$$
f_{\Delta}(x) = f(\pi_{\Delta}(x)), \quad g_{\Delta}(x) = g(\pi_{\Delta}(x)) \quad \text{and} \quad h_{\Delta}(x) = h(\pi_{\Delta}(x)), \quad \forall x \in \mathbb{R}^d,
$$

105 where  $\pi_{\Delta}$  is defined as the same as before. The following lemma also shows that the truncated functions preserve the Khaminskii-type condition. The proof is given in the Appendix.

where  $X_{\Delta}(t_k^-)$ ,  $\Delta B_k$  and  $\Delta N_k$  is defined the same as before. The continuous-time form is defined by

$$
x_{\Delta}(t^{-}) = x_0 + \int_0^t f_{\Delta}(\bar{x}_{\Delta}(s^{-}))ds + \int_0^t g_{\Delta}(\bar{x}_{\Delta}(s^{-}))dB(s) + \int_0^t h_{\Delta}(\bar{x}_{\Delta}(s^{-}))dN(s).

<span id="page-13-1"></span>where  $\bar{x}_{\Delta}(t^{-})$  is defined in [\(3.12\)](#page-4-4). In order to state our main result, we first give some useful lemmas.

where  $C_{\hat{p}}$  is a generic constant. The property of Poisson increments implies

*which means convergence rate R increases as r increases. In other words, the higher moment has a better convergence rate for SDEs with jumps when*  $0 < r \leq 2/(2 + \bar{\gamma})$ *. If we take*

# 4. Asymptotic behaviours

In this subsection, we will show that the partially truncated EM method can preserve the mean square exponential stability of the underlying SDEs [\(2.1\)](#page-2-3). For the purpose of stability, we also assume that

|F_{\Delta}(x)|^2 \le 4L_1|x|^2
$$
, if  $|x| \le 1$ ,

and

$$
|F_{\Delta}(x)|^2 \le (\varphi(\Delta))^2 \le (\varphi(\Delta))^2 |x|^2
$$
, if  $|x| > 1$ .

Hence, we have

$$
\Delta |f_{\Delta}(x)|^2 \le 2(K_1^2 + 4L_1 + (\varphi(\Delta))^2) \Delta |x|^2
$$
  
\n
$$
\le 2((K_1^2 + 4L_1)\Delta + \Delta^{1/2 \wedge (\bar{p} - 2)/\bar{p}})|x|^2
$$

for all  $x \in \mathbb{R}^d$ , where [\(3.8\)](#page-3-2) have been used. For any  $\epsilon \in (0, \alpha_1 - \alpha_2 - \lambda K_1(2 + K_1))$ , there is a  $\hat{\Delta}$  ∈ (0,  $\Delta^*$ ) sufficiently small such that for all  $\Delta$  ∈ (0,  $\hat{\Delta}$ ), ( $\alpha_1 - \alpha_2 - \lambda K_1(2 + K_1)\Delta \le 1$  and

$$
\begin{cases} 2(1+K_1\lambda)\left((K_1^2+4L_1)\Delta+\Delta^{1/2\wedge(\bar{p}-2)/\bar{p}}\right) \le 0.5\epsilon\\ (K_1^2\lambda^2+K_1\lambda)\Delta \le 0.5\epsilon. \end{cases} \tag{4.12}
$$

For each such ∆, we have

$$
(1+K_1\lambda)\Delta^2\mathbb{E}|f_\Delta(X_\Delta(t_k^-))|^2+(K_1^2\lambda^2+K_1\lambda)\Delta^2\mathbb{E}|X_\Delta(t_k^-)|^2\leq \epsilon \Delta \mathbb{E}|X_\Delta(t_k^-)|^2.
$$

Inserting this into [\(4.11\)](#page-22-0), we yield

$$
\mathbb{E}|X_{\Delta}(t_{k+1}^{-})|^2 \le (1 - (\alpha_1 - \alpha_2 - \lambda K_1(2 + K_1) - \epsilon))\Delta)\mathbb{E}|X_{\Delta}(t_k^{-})|^2
$$
  
 
$$
\le \cdots
$$
  
 
$$
\le |x_0|^2(1 - (\alpha_1 - \alpha_2 - \lambda K_1(2 + K_1) - \epsilon))\Delta)^{k+1}.
$$
 (4.13)

Elementary inequality  $1 + x \le e^x$ ,  $\forall x \in \mathbb{R}$  gives

$$
\mathbb{E}|X_{\Delta}(t_{k+1}^{-})|^2 \le |x_0|^2 e^{-(\alpha_1 - \alpha_2 - \lambda K_1(2 + K_1) - \epsilon)t_{k+1}^{-}}.
$$
\n(4.14)

Thus, the proof is complete.  $\Box$ 

# *4.2. Asymptotic boundedness*

<sup>140</sup> In this subsection, we will show that the truncated EM method maintains the asymptotic boundedness of the underlying of SDEs [\(2.1\)](#page-2-3). The additional assumption is the following one.

<span id="page-22-1"></span>**Assumption 4.4.** *Assume that there exist constant*  $\bar{\alpha}_1, \bar{\alpha}_2, \bar{\beta}_2 > 0$  *and*  $\bar{\beta}_1 > \bar{\beta}_2 + \max(\lambda(4K_1^2 +$ 1),  $2\lambda K_1(2 + K_1)$  *such that* 

$$
2x^{T}F_{1}(x) + (1+\theta)|G_{1}(x)|^{2} \leq \bar{\alpha}_{1} - \bar{\beta}_{1}|x|^{2}
$$

*and*

$$
2x^{T}F(x) + (1 + \theta^{-1})|G(x)|^{2} \le \bar{\alpha}_{2} + \bar{\beta}_{2}|x|^{2}
$$

*for all*  $a \in \mathbb{R}^d$ .

When there is no super-linear term  $G(x)$ , we set  $\theta = 0$  and  $\theta^{-1} |G(x)|^2 = 0$ . Similarly, if linear term  $G_1(x)$  is absent, we set  $\theta = \infty$  and  $\theta |G_1(x)|^2 = 0$ . Moreover, [\(3.2\)](#page-2-6) implies

$$
\lambda(2x^T h(x) + |h(x)|^2) \le \lambda(|x|^2 + 2|h(x)|^2) \le 4\lambda K_1^2 + \lambda(4K_1 + 1)|x|^2, \quad \forall x \in \mathbb{R}^d.
$$

Hence, by Assumption [4.4,](#page-22-1) we have

$$
2x^{T} f(x) + |g(x)|^{2} + \lambda (2x^{T} h(x) + |h(x)|^{2}) \leq \hat{\alpha} - \hat{\beta}|x|^{2}, \quad \forall x \in \mathbb{R}^{d}, \tag{4.15}
$$

<span id="page-23-2"></span>where  $\hat{\alpha} = \bar{\alpha}_1 + \bar{\alpha}_2 + 4\lambda K_1^2$  and  $\hat{\beta} = \bar{\beta}_1 - \bar{\beta}_2 - \lambda(4K_1^2 + 1)$ .

**Theorem 4.5.** Let Assumption [3.1,](#page-2-0) [3.2,](#page-2-1) [3.3](#page-2-2) and [4.4](#page-22-1) hold. Then for any initial value  $x_0 \in \mathbb{R}^d$ , the *solution of the SDEs* [\(2.1\)](#page-2-3) *satisfy*

\limsup_{t \to \infty} \mathbb{E}|x(t)|^2 \le \frac{\bar{\alpha}_1 + \bar{\alpha}_2 + 4\lambda K_1^2}{\bar{\beta}_1 - \bar{\beta}_2 - \lambda(4K_1^2 + 1)}.
$$
\n(4.16)

**Proof.** Let  $\tau_n$ ,  $\hat{\alpha}$ , and  $\hat{\beta}$  be the same as before,  $\sigma_n = t \wedge \tau_n$ . For any  $t \ge 0$ , the Itô formula gives that

$$
\mathbb{E}\Big[e^{\hat{\beta}\sigma_n}|x(\sigma_n)|^2\Big] = |x_0|^2 + \mathbb{E}\int_0^{\sigma_n} e^{\hat{\beta}\sigma_n}\Big(2x^T(s)f(x(s)) + |g(x(s))|^2 + 2x^T(s)h(x(s)) + |h(x(s))|^2 + \hat{\beta}|x(s)|^2\Big)ds.
$$

By  $(4.15)$ , we have

\mathbb{E}\Big[e^{\hat{\beta}\sigma_n}|x(\sigma_n)|^2\Big]\leq |x_0|^2+\hat{\alpha}\int_0^t e^{\hat{\beta}s}ds=|x_0|^2+\frac{\hat{\alpha}}{\hat{\beta}}(e^{\hat{\beta}t}-1).
$$

Letting  $n \to \infty$ , we have

\mathbb{E}\Big[e^{\hat{\alpha}t}|x(t)|^2\Big] \leq |x_0|^2 + \frac{\hat{\alpha}}{\hat{\beta}}(e^{\hat{\beta}t^-} - 1)

\mathbb{E}|x(t)|^2 \leq \frac{|x_0|^2}{e^{\hat{\beta}t}} + \frac{\hat{\alpha}}{\hat{\beta}}

\limsup_{k \to \infty} D_k \le \frac{B}{1 - A}.\tag{4.18}

**Theorem 4.7.** *Let Assumption* [3.1,](#page-2-0) [3.2,](#page-2-1) [3.3](#page-2-2) *and* [4.4](#page-22-1) *hold. Then for any*  $\epsilon \in (0, \bar{\beta}_1 - \bar{\beta}_2 - \bar{\beta}_3)$  $\max(\lambda(4K_1^2 + 1), 2\lambda K_1(2 + K_1))$ , there is a  $\hat{\Delta} \in (0, \Delta^*)$  and any initial value  $x_0 \in \mathbb{R}^d$ , the *solution of the partially truncated EM method satisfy*

$$
\limsup_{k \to \infty} \mathbb{E}|X_{\Delta}(t_k^-)|^2 \le \frac{\bar{\alpha}_1 + \bar{\alpha}_2 + 2\lambda K_1(2 + K_1) + \epsilon}{\bar{\beta}_1 - \bar{\beta}_2 - 2\lambda K_1(2 + K_1) - \epsilon}.\tag{4.19}
$$

**Proof.** Fix  $\varepsilon \in (0, \bar{\beta}_1 - \bar{\beta}_2)$ . In the same way as Theorem 5.3 in [\[23](#page-33-22)] was proved, we have

\le 2K_1^2 \lambda \Delta (1+\lambda \Delta) \mathbb{E}(1+|X_{\Delta}(t_k^-)|^2)

\le 2K_1^2 \lambda \Delta \mathbb{E}|X_{\Delta}(t_k^-)|^2 + 2K_1^2 \lambda \Delta + C\Delta^2,
$$
\n(4.22)

<span id="page-24-1"></span>
$$
2\mathbb{E}|X_{\Delta}(t_k^-)h(X_{\Delta}(t_k^-))\Delta N_k| \le 2K_1\mathbb{E}(|X_{\Delta}(t_k^-)|(1+|X_{\Delta}(t_k^-)|))\mathbb{E}|\Delta N_k|
$$
  
\n
$$
\le 4K_1\lambda\Delta\mathbb{E}|X_{\Delta}(t_k^-)|^2)
$$
  
\n
$$
\le 4K_1\lambda\Delta\mathbb{E}|X_{\Delta}(t_k^-)|^2 + 4K_1\lambda\Delta
$$
\n(4.23)

and

$$
2\mathbb{E}|\Delta f_{\Delta}(X_{\Delta}(t_{k}^{-}))h(X_{\Delta}(t_{k}^{-}))\Delta N_{k}| \leq 2K_{1}\Delta\mathbb{E}((1+|X_{\Delta}(t_{k}^{-}))||f_{\Delta}(X_{\Delta}(t_{k}^{-}))||\mathbb{E}|\Delta N_{k}|
$$
  
\n
$$
\leq K_{1}\lambda\Delta^{2}(\mathbb{E}(1+|X_{\Delta}(t_{k}^{-}))|^{2}) + \mathbb{E}|f_{\Delta}(X_{\Delta}(t_{k}^{-}))|^{2})
$$
  
\n
$$
\leq K_{1}\lambda\Delta^{2}\mathbb{E}|f_{\Delta}(X_{\Delta}(t_{k}^{-}))|^{2} + C\Delta^{2}.
$$
\n(4.24)

Fix  $x_0 \in \mathbb{R}^d$  arbitrarily. For any  $\Delta \in (0, \hat{\Delta}_1)$ , substituting [\(4.22\)](#page-24-0)-[\(4.24\)](#page-24-1) into [\(4.6\)](#page-21-2) gives

\mathbb{E}|X_{\Delta}(t_{k+1}^{-})|^2 \leq \mathbb{E}(|X_{\Delta}(t_{k}^{-})|^2 + 2X_{\Delta}(t_{k}^{-})^T f_{\Delta}(X_{\Delta}(t_{k}^{-}))\Delta + |g_{\Delta}(X_{\Delta}(t_{k}^{-}))|^2 \Delta)

+ 2\lambda K\_1(2 + K\_1)\Delta \mathbb{E}|X\_{\Delta}(t\_{k}^{-})|^2 + (1 + K\_1\lambda)\Delta^2 \mathbb{E}|f\_{\Delta}(X\_{\Delta}(t\_{k}^{-}))|^2  
+ 2\lambda K\_1(2 + K\_1)\Delta + C\Delta^2  
\n\leq (1 - (\bar{\beta}\_1 - \bar{\beta}\_2 - 2\lambda K\_1(2 + K\_1) - 0.5\varepsilon)\Delta) \mathbb{E}|X\_{\Delta}(t\_{k}^{-})|^2  
+ (\bar{\alpha}\_1 + \bar{\alpha}\_2 + 2\lambda K\_1(2 + K\_1))\Delta + C\Delta^2  
+ (1 + K\_1\lambda)\Delta^2 \mathbb{E}|f\_{\Delta}(X\_{\Delta}(t\_{k}^{-}))|^2, \tag{4.25}

where  $(4.20)$  have been used. By  $(3.2)$  and  $(3.9)$ , we have

|f_{\Delta}(x)|^2 \le 2|F_1(x)|^2 + 2|F(x)|^2 \le 4K_1^2(1+|x|^2) + 2(\varphi(\Delta))^2, \quad \forall x \in \mathbb{R}^d.

Hence, by [\(3.8\)](#page-3-2), we get

$$
\Delta |f_{\Delta}(x)|^2 \le 4K_1^2 \Delta (1+|x|^2) + 2\Delta^{1/2 \wedge (\bar{p}-2)/\bar{p}}, \quad \forall x \in \mathbb{R}^d.
$$

Consequently, there is a  $\hat{\Delta} \in (0, \hat{\Delta}_1)$  sufficiently small such that for any  $\Delta \in (0, \hat{\Delta})$ ,  $\Delta(\hat{\beta}_1 - \hat{\beta}_2 - \epsilon)$ 1 and

Applying Lemma [4.6](#page-23-1) to [\(4.27\)](#page-25-1) gives the required assertion [\(4.19\)](#page-24-4).  $\Box$ 

# 5. Examples

Example 5.1. *Consider the following scalar SDEs with jumps*

dx(t^-) = -x^5(t^-)dt + x^2(t^-)dB(t) + x^2(t^-)dN(t),

*with the initial value*  $x(0) = 1$ *, where B(t) is a scalar Brownian motion and N(t) is a scalar Poisson process with jump intensity*  $\lambda = 0.5$ *. Obviously, we have*

,  $g(x) = x^2$ ,  $h(x) = x^2$ .

*It is easy to check that Assumption [3.24](#page-16-4) is satisfied with*

|f(x) - f(y)| \vee |h(x) - h(y)| \le \bar{L}_2(1 + x^4 + y^4)|x - y| \tag{5.2}
$$

for a constant  $\bar{L}_2 > 0$ . The elementary inequality gives

-(x3y + xy3 + x2y2) = -xy(x2 + y2) - x2y2 \le 0.5(x4 + y4).
$$

*By* [\(5.3\)](#page-25-2) *and* [\(5.4\)](#page-25-3)*, we have*

$$
2(x - y)(f(x) - f(y)) + |g(x) - g(y)|^2 + 2\lambda(x - y)|h(x) - h(y)| + \lambda|h(x) - h(y)|^2
$$
  
\n
$$
\le (x - y)\Big( -(x - y)(x^4 + x^3y + x^2y^2 + xy^3 + y^4) \Big) + |x^2 - y^2|^2
$$
  
\n
$$
+ (2(x^2 + y^2) + 1)|x - y|^2
$$
  
\n
$$
\le -0.5(x^4 + y^4)|x - y|^2 + 2(x^2 + y^2)|x - y|^2 + (2(x^2 + y^2) + 1)|x - y|^2
$$
  
\n
$$
= (-0.5(x^4 + y^4) + 4(x^2 + y^2) + 1)|x - y|^2
$$
  
\n
$$
\le 17|x - y|^2.
$$
\n(5.5)

*Note that in the last inequality the elementary inequality*

$$
kab \le \frac{1}{2}a^2 + \frac{1}{2}k^2b^2, \quad \forall a, b, k \in \mathbb{R}
$$

*has been used. Hence, Assumption [3.23](#page-16-3) is satisfied. For Assumption [3.16,](#page-12-2) we have*

2x^{T} f(x) + |g(x)|^{2} + \lambda (2x^{T} h(x) + |h(x)|^{2})
$$
  
= -2x<sup>6</sup> + x<sup>4</sup> + 0.5(2x<sup>3</sup> + x<sup>4</sup>)  
= (-x<sup>6</sup> +  $\frac{3}{2}$ x<sup>4</sup>) + (x<sup>3</sup> - x<sup>6</sup>)  
= x<sup>2</sup>(-(x<sup>2</sup> -  $\frac{3}{4}$ )<sup>2</sup> +  $\frac{9}{16}$ ) + (x<sup>3</sup> - x<sup>6</sup>)  
 $\leq \frac{9}{16}x^{2} + \frac{1}{4}$ , (5.6)

*where we use the elementary inequality ab*  $\leq a^2 + b^2/4$  *in the last inequality. By* [\(5.2\)](#page-25-4)*, we can choose*  $\mu(n) = n^5$  *such that* 

$$
\sup_{|x| \le n} (|f(x)| \vee |g(x)| \vee |h(x)|) = \sup_{|x| \le n} (|x^5| \vee |x^2| \vee |x^2|) \le n^5, \quad \forall n \ge 1.
$$

*Letting*  $\bar{\gamma} = 4$ ,  $r = 2/(2 + \bar{\gamma}) = 1/3$  *and*  $\varepsilon = 1/4$ *. If we choose*  $\varphi(\Delta) = \Delta^{-\varepsilon} = \Delta^{-1/4}$ *, then all the conditions in* [\(3.62\)](#page-13-3) *hold for all* ∆ <sup>∗</sup> ∈ (0, 1]. *Hence, the truncating factor is defined as*  $\mu^{-1}(\varphi(\Delta)) = \Delta^{-1/20}$  and the truncated functions are defined as

$$
f_{\Delta}(x) = f((|x| \wedge \Delta^{-0.05})\frac{x}{|x|})
$$

$$
g_{\Delta}(x) = g((|x| \wedge \Delta^{-0.05})\frac{x}{|x|})
$$

$$
h_{\Delta}(x) = h((|x| \wedge \Delta^{-0.05})\frac{x}{|x|}).
$$

*For the given step size*  $\Delta$  *and the time T, the*  $X_{k+1}$  *is calculated by* 

$$
X_{k+1} = X_k + f_\Delta(X_k)\Delta + g_\Delta(X_k)\Delta B_k + h_\Delta(X_k)\Delta N_k, \quad 0 \le k \le T/\Delta - 1,
$$
 (5.7)

*with X*<sup>0</sup> = 1*. Then, by Corollary [3.27,](#page-19-5) the truncated EM scheme converges strongly with rate*  $r/2 - r\varepsilon = 1/(4 + 2\bar{\gamma}) = 1/12$  *to the true solution of the SDE* [5.1.](#page-25-5)

*As SDEs [5.1](#page-25-5) does not have any explicit solutions, the scheme* [\(5.7\)](#page-26-0) *with step size* 2 <sup>−</sup><sup>16</sup> *is treated as the solution of the SDEs [5.1](#page-25-5) in the numerical experiment. The number of simulation is* 500. The  $\mathcal{L}^{1/3}$  errors at time T = 4, that is

$$
\left(\mathbb{E}\left|X(T) - x_{\Delta}(T)\right|^{1/3}\right)^3 \approx \left(\frac{1}{500} \sum_{i=1}^{500} \left| [X(T)]^i - [x_{\Delta}(T)]^i \right|^{1/3}\right)^3,
$$

*with step sizes*  $2^{-15}$ ,  $2^{-14}$ ,  $2^{-13}$ ,  $2^{-12}$  and  $2^{-11}$  are displayed in Fig [3](#page-27-0) . The numerical result shows *that our numerical findings are consistent with the theoretical results obtained in this paper.*

Example 5.2. *Consider the following scalar SDEs with jumps*

$$
dx(t^-) = -(x(t^-) + x^5(t^-))dt + x^2(t^-)dB(t) + x(t^-)dN(t),
$$
\n(5.8)

*with the initial value*  $x(0) = 0.5$ *, where B(t) is a scalar Brownian motion and N(t) is a scalar Poisson process with jump intensity*  $\lambda = 0.5$ *. Obviously, we have* 

$$
F_1(x) = -x
$$
,  $F(x) = -x^5$ ,  $G_1(x) = 0$ ,  $G(x) = x^2$ ,  $h(x) = x$ ,

*and*

$$
|F_1(x)| \vee |G_1(x)| \vee |h(x)| = |x|, \quad with \quad K_1 = 1.
$$

*Setting*  $\theta = \infty$  *gives* 

<span id="page-27-1"></span>
$$
2xF_1(x) + (1+\theta)|G_1(x)|^2 = -2x^2,
$$

*and*

$$
2xF(x) + (1 + \theta^{-1})|G(x)|^2 = -2x^6 + x^4 \le -2x^2\left(x^2 - \frac{1}{4}\right)^2 + \frac{1}{8}x^2 \le \frac{1}{8}x^2.
$$

*Hence, Assumption* [4.1](#page-20-1) *is satisfied with*  $\alpha_1 = 2$  *and*  $\alpha_2 = 1/8$ *. Moreover, we have* 

$$
(x - y)(F(x) - F(y)) + \frac{\bar{r} - 1}{2}|G(x) - G(y)| \le \left(1 + \frac{(\bar{r} - 1)}{4}\right)|x - y|^2, \quad \forall x \in \mathbb{R}
$$

*which means that Assumption [3.2](#page-2-1) is satisfied for any r. Also, we can check that Assumption [3.3](#page-2-2)* ¯ *is fulfilled for any*  $\bar{p}$  (see [\[23\]](#page-33-22)). By Theorem [4.2,](#page-20-4) the SDE [5.8](#page-27-1) is stable exponentially in the mean *square sense for any initial value*  $x_0 \in \mathbb{R}$ *, and the solution of SDE* [5.8](#page-27-1) *satisfies* 

$$
\mathbb{E}|x(t^-)|^2 \le |x_0|^2 e^{-(\alpha_1 - \alpha_2 - \lambda K_1(2 + K_1))t^-} = |x_0|^2 e^{-0.375t^-}, \quad \forall t \ge 0.
$$

*Letting r* = 2,  $\bar{r}$  = 3. If we choose  $\mu(n) = n^5$ ,  $\gamma = 4$ ,  $\varphi(\Delta) = \Delta^{-1/40}$ , and  $p = 40$ , then by Corollary *[3.12,](#page-10-4) the numerical solution will converge strongly to the true solution in*  $\mathcal{L}^2$  *with convergence rate*  $1/(1 + \gamma) - r/p = 0.15$ *. Finally, by Theorem [4.3,](#page-21-4) for any*  $\epsilon \in (0, 0.375)$ *, there exists a*  $\hat{\Delta}$  ∈ (0,  $\Delta^*$ ) such that for all  $\Delta$  ∈ (0,  $\hat{\Delta}$ ) and any initial value  $x_0 \in \mathbb{R}^d$ , the solution of the truncated *EM method* [\(3.11\)](#page-3-4) *satisfies*

$$
\mathbb{E}|X_{\Delta}(t_k^-)|^2 \le |x_0|^2 e^{-(\alpha_1-\alpha_2-\lambda K_1(2+K_1)-\epsilon)t_k^-} = |x_0|^2 e^{-(0.375-\epsilon)t_k^-}, \quad \forall k \ge 0.
$$

*Fig [4](#page-28-0) and Fig [5](#page-28-0) demonstrate the mean square exponential stability of the truncated EM method.*

Example 5.3. *Consider the following scalar SDEs with jumps*

<span id="page-28-1"></span>
$$
dx(t^-) = (x(t^-) - x^3(t^-))dt + x(t^-)dB(t) + x(t^-)dN(t),
$$
\n(5.9)

*with the initial value*  $x(0) = x_0 \in \mathbb{R}$ *, where*  $B(t)$  *is a scalar Brownian motion and*  $N(t)$  *is a scalar Poisson process with jump intensity*  $\lambda = 0.1$ *. We decompose the drift and diffusion coefficient in the form with*

$$
F_1(x) = -2x
$$
,  $F(x) = 3x - x^3$ ,  $G_1(x) = x$ ,  $G(x) = 0$ ,  $h(x) = x$ , (5.10)

*which means*

$$
|F_1(x)| \vee |G_1(x)| \vee |h(x)| = 2|x|, \quad with \quad K_1 = 2.
$$

*Setting*  $\theta = 0$  *gives* 

<span id="page-28-2"></span>
$$
2xF_1(x) + (1+\theta)|G_1(x)|^2 = -3x^2,
$$

*and*

$$
2xF(x) + (1 + \theta^{-1})|G(x)|^2 = 2x(3x - x^3) = -2(x^2 - 1.5)^2 + 4.5 \le 4.5.
$$

*Hence, Assumption [4.4](#page-22-1) is satisfied with*

$$
\bar{\alpha}_1 = 0
$$
,  $\bar{\beta}_1 = 3$ ,  $\bar{\alpha}_2 = 4.5$ , and  $\bar{\beta}_2 = 0$ . (5.11)

*It is easy to check that coe*ffi*cients of the SDE [5.9](#page-28-1) with their decompositions in* [\(5.10\)](#page-28-2) *satisfy Assumption [3.1,](#page-2-0) [3.2](#page-2-1) and [3.3](#page-2-2) for any p*¯ > 2*. Applying Theorem [4.5](#page-23-2) gives that for any initial value*  $x_0 \in \mathbb{R}^d$ , the solution of SDE [5.9](#page-28-1) satisfies

$$
\limsup_{t \to \infty} \mathbb{E}|x(t)|^2 \le \frac{\bar{\alpha}_1 + \bar{\alpha}_2 + 4\lambda K_1^2}{\bar{\beta}_1 - \bar{\beta}_2 - \lambda(4K_1^2 + 1)} \approx 4.69. \tag{5.12}
$$

*Moreover, we can choose*  $\mu(n) = 4n^3$  *and*  $\varphi(\Delta) = \Delta^{-\varepsilon}$  *and let*  $r = 2$ ,  $\bar{\gamma} = 2$ ,  $p = 50$  *as well as*  $\varepsilon = 1/50$  *to define the numerical solution*  $X_{\Delta}(t_k)$  *by the partially truncated EM method. By Theorem* [3.11,](#page-8-7) this solution of truncated EM will converge to the true solution in  $\mathcal{L}^2$  with *convergence rate*  $1/(1 + \overline{\gamma}) - r/p \approx 0.2933$ *. Finally, by Theorem [4.7,](#page-23-3) for any*  $\epsilon \in (0, 1.3)$ *, there exists*  $a \, \hat{\Delta} \in (0, \Delta^*)$  *such that for all*  $\Delta \in (0, \hat{\Delta})$  *and any initial value*  $x_0 \in \mathbb{R}^d$ , *the numerical solution satisfies*

$$
\limsup_{k\to\infty}\mathbb{E}|X_{\Delta}(t_k^-)|^2\leq \frac{\bar\alpha_1+\bar\alpha_2+2\lambda K_1(2+K_1)+\epsilon}{\bar\beta_1-\bar\beta_2-2\lambda K_1(2+K_1)-\epsilon}=\frac{6.1+\epsilon}{1.4-\epsilon}.
$$

*The asymptotic boundedness of the numerical method is shown in Fig [6](#page-29-1) and Fig [7.](#page-29-1)*

#### <span id="page-29-0"></span><sup>155</sup> 6. Conclusions and future research

In this paper, the truncated EM method is investigated for SDEs driven by both Brownian motions and Possion jumps. Both the finite time convergence and asymptotic behaviours of the method are studied. The  $\mathcal{L}^r(r \geq 2)$  strong convergence is proved when the drift and diffusion coefficients satisfy super-linear growth condition and the coefficient for Possion jumps satisfies  $\frac{1}{160}$  linear growth condition. When  $0 < r < 2$ , we are able to prove the  $\mathcal{L}^r$  convergence of the methods to SDEs with all the three coefficients allowing to grow super-linearly.

In the future works, we will report on the SDEs driven by Lévy process and the  $\mathcal{L}^r$  convergence for SDEs whose all the three coefficients can grow super-linearly.

# Appendix A. Proof of Lemma [3.9](#page-7-4)

Proof. By the Itô formula and [\(3.7\)](#page-3-3), we have

$$
\mathbb{E}|x(t \wedge \tau_n)|^2 \le |x_0|^2 + \mathbb{E} \int_0^{t \wedge \tau_n} K_3(1+|x(s)|^2) ds
$$
  
+  $\lambda \mathbb{E} \int_0^{t \wedge \tau_n} (2x(s)^T h(x(s)) + |h(x(s))|^2) ds$   
 $\le |x_0|^2 + (K_3 + 2\lambda(2K_1 + K_1^2)) \int_0^t \mathbb{E}(1 + |x(s \wedge \tau_n)|^2) ds$ 

for any  $0 < t < T$ . The Gronwall inequality shows

$$
\mathbb{E}|x(T \wedge \tau_n)|^2 \leq C.
$$

This implies

$$
\mathbb{P}(\tau_n \leq T) \leq \frac{C}{n^2}.
$$

165 Thus, the proof is complete.  $\Box$ 

# Appendix B. Proof of Lemma [3.10](#page-7-5)

**Proof.** We write  $\rho_{\Delta,n} = \rho$  for simplicity. For  $0 \le t \le T$ , the Itô formula gives

$$
\mathbb{E}|x_{\Delta}(t\wedge\rho)|^{2} = |x_{0}|^{2} + \mathbb{E}\int_{0}^{t\wedge\rho} \left(2x_{\Delta}^{T}(s)f_{\Delta}(\bar{x}_{\Delta}(s^{-})) + |g_{\Delta}(\bar{x}_{\Delta}(s^{-}))|^{2}\right)ds
$$
  
+  $\lambda \mathbb{E}\int_{0}^{t\wedge\rho} \left(2x_{\Delta}^{T}(s)h(\bar{x}_{\Delta}(s^{-})) + |h(\bar{x}_{\Delta}(s^{-}))|^{2}\right)ds$   
=  $|x_{0}|^{2} + \mathbb{E}\int_{0}^{t\wedge\rho} \left(2\bar{x}_{\Delta}^{T}(s)f_{\Delta}(\bar{x}_{\Delta}(s^{-})) + |g_{\Delta}(\bar{x}_{\Delta}(s^{-}))|^{2}\right)ds$   
+  $\mathbb{E}\int_{0}^{t\wedge\rho} 2(x_{\Delta}(s^{-}) - \bar{x}_{\Delta}(s^{-}))^{T}f_{\Delta}(\bar{x}_{\Delta}(s^{-}))ds$   
+  $\lambda \mathbb{E}\int_{0}^{t\wedge\rho} \left(2x_{\Delta}^{T}(s)h(\bar{x}_{\Delta}(s^{-})) + |h(\bar{x}_{\Delta}(s^{-}))|^{2}\right)ds.$  (B.1)

By [\(3.2\)](#page-2-6), we obtain

$$
\mathbb{E} \int_0^{t \wedge \rho} \left( 2x_{\Delta}^T(s)h(\bar{x}_{\Delta}(s^-)) + |h(\bar{x}_{\Delta}(s^-))|^2 \right) ds
$$
\n
$$
\leq \mathbb{E} \int_0^{t \wedge \rho} \left( |x_{\Delta}(s^-)|^2 + 2|h(\bar{x}_{\Delta}(s^-))|^2 \right) ds
$$
\n
$$
\leq \mathbb{E} \int_0^{t \wedge \rho} \left( |x_{\Delta}(s^-)|^2 + 4K_1^2(1 + |\bar{x}_{\Delta}(s^-)|^2) \right) ds
$$
\n
$$
\leq 4K_1^2 T + (8K_1^2 T + 1) \mathbb{E} \int_0^{t \wedge \rho} |x_{\Delta}(s^-)|^2 ds + 8K_1^2 T \mathbb{E} \int_0^{t \wedge \rho} |x_{\Delta}(s^-) - \bar{x}_{\Delta}(s^-)|^2 ds. \tag{B.2}
$$

Substituting this into [\(B.1\)](#page-30-0) and applying [3.10,](#page-3-1) we have

$$
\mathbb{E}|x_{\Delta}(t \wedge \rho)|^{2} \leq |x_{0}|^{2} + \int_{0}^{t \wedge \rho} 2K_{4}(1 + |\bar{x}_{\Delta}(s^{-})|^{2})ds + 4\lambda K_{1}^{2}T
$$
  
+ 
$$
\mathbb{E} \int_{0}^{t \wedge \rho} 2(x_{\Delta}(s^{-}) - \bar{x}_{\Delta}(s^{-}))^{T} f_{\Delta}(\bar{x}_{\Delta}(s^{-}))ds
$$
  
+  $\lambda(8K_{1}^{2}T + 1)\mathbb{E} \int_{0}^{t \wedge \rho} |x_{\Delta}(s^{-})|^{2}ds + \lambda 8K_{1}^{2}T\mathbb{E} \int_{0}^{t \wedge \rho} |x_{\Delta}(s^{-}) - \bar{x}_{\Delta}(s^{-})|^{2}ds$   

$$
\leq (|x_{0}|^{2} + 2K_{4}T + 4\lambda L_{1}^{2}T) + (4K_{4} + \lambda(8K_{1}^{2}T + 1)) \int_{0}^{t} \mathbb{E}|x_{\Delta}(s \wedge \rho)|^{2}ds
$$
  
+  $(4K_{4} + 8\lambda K_{1}^{2}T) \int_{0}^{T} \mathbb{E}|x_{\Delta}(s^{-}) - \bar{x}_{\Delta}(s^{-})|^{2}ds$   
+  $2\mathbb{E} \int_{0}^{t \wedge \rho} |x_{\Delta}(s^{-}) - \bar{x}_{\Delta}(s^{-})||f_{\Delta}(\bar{x}_{\Delta}(s^{-}))|ds.$  (B.3)

By Lemma [3.6,](#page-4-1) we have

$$
\int_0^T \mathbb{E}|x_\Delta(s^-) - \bar{x}_\Delta(s^-)|^2 ds \leq C.
$$

By [\(3.2\)](#page-2-6), we have

$$
\mathbb{E} \int_0^{t \wedge \rho} |x_{\Delta}(s^-) - \bar{x}_{\Delta}(s^-)||f_{\Delta}(\bar{x}_{\Delta}(s^-))|ds
$$
\n
$$
\leq K_1 \mathbb{E} \int_0^{t \wedge \rho} |x_{\Delta}(s^-) - \bar{x}_{\Delta}(s^-)|(1 + |\bar{x}_{\Delta}(s^-)|)ds + I_5
$$
\n
$$
\leq C \Big( \mathbb{E} \int_0^{t \wedge \rho} |x_{\Delta}(s^-) - \bar{x}_{\Delta}(s^-)|^2 ds + \int_0^t \mathbb{E} |x_{\Delta}(s \wedge \rho)|^2 ds + 1 \Big) + I_5 \tag{B.4}
$$

where

$$
I_5 = \mathbb{E}\int_0^T |x_\Delta(s^-) - \bar{x}_\Delta(s^-)||F_\Delta(\bar{x}_\Delta(s^-))|ds.
$$

Using Lemma [\(3.8\)](#page-7-3), condition [3.8](#page-3-2) and [\(3.9\)](#page-3-0) gives

$$
I_5 \le \varphi(\Delta) \int_0^T \left( \mathbb{E}|x_\Delta(s^-) - \bar{x}_\Delta(s^-)|^2 \right)^{1/2} ds
$$
  

$$
\le C(\varphi(\Delta))^2 \Delta^{1/2} = C(\varphi(\Delta)\Delta^{1/4})^2 \le C.
$$

Hence, we have

$$
\mathbb{E}|x_{\Delta}(t\wedge\rho)|^2\leq C\Big(1+\int_0^t\mathbb{E}|x_{\Delta}(s\wedge\rho)|^2ds\Big).
$$

The Gronwall inequality gives

$$
\mathbb{E}|x_{\Delta}(T \wedge \rho)|^2 \leq C,
$$

which implies [\(3.72\)](#page-15-4). Thus, the proof is complete.  $\Box$ 32

# Appendix C. Proof of Lemma [3.18](#page-13-5)

**Proof.** Fix any  $\Delta \in (0, \Delta^*]$ . Recall that  $\mu^{-1}(\varphi(\Delta^*)) \ge 1$ , we get  $\mu^{-1}(\varphi(\Delta)) \ge 1$ . For  $x \in \mathbb{R}^d$ with  $|x| \leq \mu^{-1}(\varphi(\Delta))$ , by the definition of the truncated function, we obtain the required assertion [\(3.63\)](#page-13-6). For  $x \in \mathbb{R}^d$  with  $|x| > \mu^{-1}(\varphi(\Delta))$ , by [\(3.16\)](#page-12-2), we have

= 2(x -  $\pi_{\Delta}(x)$ )<sup>T</sup> f\_{\Delta}(x) + 2\lambda(x -  $\pi_{\Delta}(x)$ )<sup>T</sup> h\_{\Delta}(x)  
+ 2 $\pi_{\Delta}(x)$ <sup>T</sup> f\_{\Delta}(x) + |g\_{\Delta}(x)|^{2} + 2\lambda \pi\_{\Delta}(x)^{T} h\_{\Delta}(x) + \lambda |h\_{\Delta}(x)|^{2}  

$$
\leq \left(\frac{|x|}{\mu^{-1}(\varphi(\Delta))} - 1\right) \left(2\pi_{\Delta}(x)^{T} f(\pi_{\Delta}(x)) + 2\lambda \pi_{\Delta}(x)^{T} h(\pi_{\Delta}(x))\right) + \bar{K}(1 + |\pi_{\Delta}(x)|^{2})
$$
  

$$
\leq \left(\frac{|x|}{\mu^{-1}(\varphi(\Delta))} - 1\right) (\bar{K}(1 + |\pi_{\Delta}(x)|^{2})) + \bar{K}(1 + |\pi_{\Delta}(x)|^{2})
$$
  
= 
$$
\frac{|x|}{\mu^{-1}(\varphi(\Delta))} \bar{K}(1 + |\mu^{-1}(\varphi(\Delta))|^{2})
$$
  
= 
$$
\bar{K}|x| \left(\frac{1}{\mu^{-1}(\varphi(\Delta))} + |\mu^{-1}(\varphi(\Delta))|\right)
$$
  

$$
\leq \bar{K}|x|(1 + |x|) \leq \bar{K}(1 + |x|)^{2} \leq 2\bar{K}(1 + |x|).
$$

Thus, we complete the proof.  $\Box$ 

# <sup>170</sup> Appendix D. Proof of Lemma [4.6](#page-23-1)

Proof.  $(4.17)$  is equivalent to the following expression

D_k + \frac{B}{A-1} \le A\left(D_{k-1} + \frac{B}{A-1}\right)
$$
, for  $k = 0, 1, 2, \cdots$ .

Hence, we have

D_k + \frac{B}{A-1} \le A^k \left(D_0 + \frac{B}{A-1}\right).

It follows
