A Bismut-Elworthy-Li Formula for Singular SDE's Driven by a Fractional Brownian Motion and Applications to Rough Volatility Modeling

Abstract

In this paper we derive a Bismut-Elworthy-Li type formula with respect to strong solutions to singular stochastic differential equations (SDE's) with additive noise given by a multidimensional fractional Brownian motion with Hurst parameter $H < 1/2$. "Singular" here means that the drift vector field of such equations is allowed to be merely bounded and integrable. As an application we use this representation formula for the study of price sensitivities of financial claims based on a stock price model with stochastic volatility, whose dynamics is described by means of fractional Brownian motion driven SDE's.

Our approach for obtaining these results is based on Malliavin calculus and arguments of a recently developed "local time variational calculus".

1 Introduction

In recent years the construction and computation of risk measures have become an indispensable tool for the risk analysis and risk management of portfolios in banks and insurance companies worldwide. An important class of risk measures often applied by investors on financial markets to hedge their positions is given by the "greeks". These are market sensitivities usually denoted by Greek letters e.g. "Delta", "Gamma", "Rho", "Theta", "Vega"..., and hence the name. For example the Delta Δ , which can be used for the construction of delta hedges in portfolio management, measures the sensitivity of price changes of financial derivatives with respect to the initial price of the underlying asset. Roughly speaking, greeks are derivatives with respect to a parameter λ of a (risk-neutral) price, that is, for example of the form

where Φ is the payoff function of a claim and X_T^{λ} the underlying asset at terminal time T, which depends on λ .

In general, greeks cannot be obtained by closed-form formulas, especially in the case of discontinuous payoff functions. Therefore, one has to resort to numerical techniques to approximate such sensitivities. A ground breaking method in this direction, which is also applicable to path-dependent options, has been developed in Fournie et al. $[14]$, $[15]$. Assuming that the dynamics of asset prices $X_t = X_t^{\lambda}$ is modeled by a stochastic differential equation of the form

$$
dX(t) = b(t, X(t))dt + \sigma(t, X(t))dW_t, X_0 = x \in \mathbb{R}^d, 0 \le t \le T,
$$
\n⁽²⁾

where $W_t, 0 \le t \le T$ is a d-dimensional Wiener process and b, σ are continuously differentiable coefficients, the authors in [\[14\]](#page-30-0) were able to represent [\(1\)](#page-0-6) in a derivative-free form, that is by

$$
E[\phi(S(T))\pi],\tag{3}
$$

where π is the so called Malliavin weight. Such a representation is also referred to as Bismut-Elworthy-Li formula (BEL-formula) in the literature. See [\[7\]](#page-30-2) and [\[8\]](#page-30-3).

An advantage of this method is that the representation in [\(3\)](#page-1-0) does not involve derivatives of Φ and that it exhibits numerical tractability via efficient use of Monte-Carlo simulation. However, a deficiency of this approach is the requirement that the coefficients of the SDE, which describes the dynamics of the asset prices in [\(2\)](#page-1-1), are continuously differentiable. The latter assumption is rather restrictive and excludes the study of interesting financial models. Such models could e.g. pertain to a generalization of the Black-Scholes model with "regime-switching" drift, that is

$$
S_t^x = x \exp(Y_t),\tag{4}
$$

where

$$
dY_t = (b_1 \chi_{\{Y_t > R\}} + b_2 \chi_{\{Y_t \le R\}})dt - \frac{1}{2}\sigma^2 dt + \sigma dB_t
$$

for constants b_1 , b_2 and a "threshold" R.

Another possible application is to interest rate or commodity markets with a model whose dynamics is given by a generalized Ornstein-Uhlenbeck process with regime switching mean reversion rate, that is

$$
dY_t = (a_1 \chi_{\{Y_t > R\}} + a_2 \chi_{\{Y_t \le R\}})(b - Y_t)dt + \sigma dW_t
$$
\n(5)

for mean reversion coefficients $a_1, a_2 > 0$, a threshold R, the long-run average level $b \in \mathbb{R}$, interest rate volatility $\sigma > 0$.

In the above models [\(4\)](#page-1-2) and [\(5\)](#page-1-3) the drift coefficients are chosen to be discontinuous and used to capture regime-switching effects which may arise from regulations, credit rating changes, market crashes or other financial disasters.

We mention that a BEL-representation for Wiener process driven SDE's with merely bounded and measurable drift functions as e.g. the one in [\(5\)](#page-1-3) was first obtained in Menoukeu-Pamen et

al. [\[19,](#page-31-0) Theorem 4.6, Remark 4.7]. To be more precise, for strong solutions $X_t, 0 \le t \le T$ to SDE's with additive Wiener noise

$$
dX_t^x = b(t, X_t^x)dt + dW_t,
$$

where $b \in L^{\infty}([0,T] \times \mathbb{R}^d; \mathbb{R}^d)$, the authors prove, for bounded Borel measurable Φ and bounded open sets $U \subset \mathbb{R}^d$, that

$$
\frac{\partial}{\partial x}E[\Phi(X_T^x)] = E[\Phi(X_T^x)\pi]^*
$$
\n(6)

for all $x \in U$ a.e., where the Malliavin weight π is

$$
\int_0^T a(s) \left(\frac{\partial}{\partial x} X_s^x\right)^* dW_s.
$$

Here the derivatives appearing on both sides of [\(6\)](#page-2-0) are Sobolev derivatives on $U, a : [0, T] \longrightarrow \mathbb{R}$ is a bounded Borel measurable function with $\int_0^T a(s)ds = 1$ and * denotes transposition. See also the related articles [\[4\]](#page-30-4), [\[3\]](#page-30-5), [\[23\]](#page-31-1) and the references therein.

Using techniques from Malliavin calculus and arguments of a "local time variational calculus" as recently developed in the series of works [\[5\]](#page-30-6), [\[6\]](#page-30-7), [\[2\]](#page-29-0) in the case of fractional Brownian motion, we aim at obtaining in this paper an extension of the above mentioned results to the case of fractional Brownian motion driven singular SDE's. More precisely, we want to derive a BELformula of the type [\(6\)](#page-2-0) with respect to strong solutions to SDE's of the form

$$
dX_t = b(t, X_t)dt + dB_t^H, X_0 = x, 0 \le t \le T,
$$
\n(7)

where B_t^H , $0 \le t \le T$ is a d-dimensional fractional Brownian motion with Hurst parameter $H \in (0, \frac{1}{2})$ $\frac{1}{2}$ and where the vector field b is *singular* in the sense that

$$
b\in L^{1,\infty}_{\infty,\infty}:=L^1(\mathbb{R}^d;L^\infty([0,T];\mathbb{R}^d))\cap L^\infty(\mathbb{R}^d;L^\infty([0,T];\mathbb{R}^d)).
$$

As an application of the techniques used in connection with the BEL-formula, we also wish to study a Black-Scholes model with "turbulent" stochastic volatility, where the dynamics of stock prices is described by the (singular) SDE

$$
dX_t^x = \mu X_t^x dt + \sigma_t X_t^x dB_t, X_0^x = x, 0 \le t \le T.
$$

Here B_t , $0 \le t \le T$ is a one-dimensional Wiener process, μ the mean return and σ_t the volatility at time t , modeled by means of the SDE

$$
dY_t^y = b(t, Y_t^y)dt + B_t^H, Y_0^y = y, 0 \le t \le T
$$

for small Hurst parameters $H \in (0, 1/2)$ and singular vector fields $b \in L_{\infty,\infty}^{1,\infty}$, which can be used as explained above for the modeling of regime switching effects in stock markets. Let us also mention that the choice of fractional Brownian motion with small Hurst parameters H in the latter model, which becomes "rougher" the lower H is, is in fact supported by empirical evidence (see [\[16\]](#page-30-8)) and useful for the description of stock price volatilities σ_t in "turbulent" stock markets.

Finally, we also point out the interesting work [\[13\]](#page-30-9), where the authors derived BEL-formulas for (functional) SDE's driven by fractional Brownian motion with Hurst parameters $H \in (0,1)$ in the case of differentiable vector fields, which they applied to e.g. the study of Harnack type of inequalities.

The paper is organized as follows: In Section 2 we prove a BEL-formula with respect to the SDE [\(7\)](#page-2-1) for $H < \frac{1}{2(d+2)}$. See Theorem [6.](#page-5-0) We then show, in Proposition [10,](#page-15-0) that the BEL-representation has a continuous version, if $H < \frac{1}{2(d+3)}$. Finally, in Section 3 we discuss an application of our techniques used in Section 2 to the sensitivity analysis of prices of options based on a Black-Scholes model with "rough" stochastic volatility (Theorem [11\)](#page-21-0).

2 Bismut-Elworthy-Li formula

In this section we aim at deriving a new Bismut-Elworthy-Li type formula with respect to SDE's driven by discontinuous vector fields and a fractional Brownian motion with a Hurst parameter $H < \frac{1}{2}$. We also propose a stock price model with "rough" stochastic volatility, which allows for the description of regime switching effects with respect to volatility data caused e.g. by economical crises, political changes or other shocks on markets. Here, regime switching effects are modeled by means of singular coefficients of SDE's driven by a fractional Brownian motion. On the other hand, the "roughness" of the volatility paths in the sense of paths with low Hölder regularity is described through the driving fractional noise of such SDE's. Further, we also prove a BEL-representation for the delta of an option with respect to that model.

In what follows, let us consider a fractional Brownian motion $B_t^H, t \geq 0$ with Hurst parameter $H \in (0, 1)$ on some complete probability space $(\Omega, \mathcal{F}, \mu)$, which is (in the 1-dimensional case) a centered Gaussian process with a covariance structure $R_H(t, s)$ of the form

$$
R_H(t,s) = E[B_t^H B_s^H] = \frac{1}{2}(s^{2H} + t^{2H} - |t - s|^{2H})
$$

for all $t, s \geq 0$. See the Appendix. In the special case, when $H = \frac{1}{2}$ the fractional Brownian motion coincides with a Wiener process.

We also recall that the fractional Brownian motion is self-similar, that is

$$
\{B_{\alpha t}^H\}_{t\geq 0} \stackrel{law}{=} \{\alpha^H B_t^H\}_{t\geq 0}
$$

for all $\alpha > 0$. Further, B^H has a version with paths, which are $(H - \varepsilon)$ -Hölder continuous for all $\varepsilon \in (0, H)$. Another propertie satisfied by B^H , which actually rather complicate the study of fractional Brownian motion, is that it is neither a Markov process nor a semimartingale,

when $H \neq \frac{1}{2}$ $\frac{1}{2}$. See e.g. [\[20\]](#page-31-2) and the references therein for further information on the fractional Brownian motion.

In this Section, we consider for $H < \frac{1}{2}$ the SDE

$$
dX_t^x = b(t, X_t^x)dt + dB_t^H, X_0^x = x, 0 \le t \le T.
$$
\n(8)

We mention that B^H in this case has the representation

$$
B_t^H = \int_0^t K_H(t, s) I_{d \times d} dB_s \tag{9}
$$

for a d–dimensional Brownian motion B, where $I_{d \times d} \in \mathbb{R}^{d \times d}$ is the unit matrix and K_H the kernel as given in [\(32\)](#page-23-0) in the Appendix.

In the sequel, we also need the following notation for function spaces:

$$
L^1_{\infty} : = L^1(\mathbb{R}^d; L^{\infty}([0, T]; \mathbb{R}^d)),
$$

\n
$$
L^{\infty}_{\infty} : = L^{\infty}(\mathbb{R}^d; L^{\infty}([0, T]; \mathbb{R}^d)),
$$

\n
$$
L^{1, \infty}_{\infty, \infty} : = L^1_{\infty} \cap L^{\infty}_{\infty}.
$$

We have the following result for the existence and uniqueness of strong solutions to the SDE [\(8\)](#page-4-0) which is due to [\[5\]](#page-30-6) (compare also the results in [\[9\]](#page-30-10) and [\[21\]](#page-31-3), which cannot be used to treat the case $b \in L^{1,\infty}_{\infty,\infty}$ for $d > 1$):

Theorem 1 Let $b \in L_{\infty,\infty}^{1,\infty}$. Then if $H < \frac{1}{2(d+2)}$ there exists a unique (global) strong solution X^x of the SDE [\(8\)](#page-4-0). Moreover, for every $x \in \mathbb{R}^d, t \in [0,T]$ X^x_t is Malliavin differentiable in the direction of the Brownian motion B in [\(9\)](#page-4-1) and X_t is locally Sobolev differentiable $\mu - a.e.$

That is, more precisely,

$$
X_t\in \bigcap_{p\geq 2}L^2(\Omega;W^{1,p}(U))
$$

for bounded and open sets $U \subset \mathbb{R}^d$.

In preparation of our main result (Theorem [6\)](#page-5-0), we also need a series of auxiliary results:

Lemma 2 Let $b \in C_c^{\infty}((0,T) \times \mathbb{R}^d)$. Fix integers $p \geq 2$. Then, if $H < \frac{1}{2(d+2)}$, we have

$$
\sup_{x \in \mathbb{R}^d} E\left\| \left| \frac{\partial}{\partial x} X_t^x \right\|^p \right\| \le C_{p,H,d,T} \left(\|b\|_{L^{\infty}_{\infty}}, \|b\|_{L^1_{\infty}} \right) < \infty
$$

for some continuous function $C_{p,H,d,T} : [0,\infty)^2 \longrightarrow [0,\infty)$.

Proof. See [\[5\]](#page-30-6). \blacksquare

Lemma 3 Let $H < \frac{1}{2(d+2)}$, $b \in L_{\infty,\infty}^{1,\infty}$. Further, let X_{\cdot}^{n} , $n \geq 1$ be the sequence of strong solutions to [\(8\)](#page-4-0) associated with functions $b_n \in C_c^{\infty}((0,T) \times \mathbb{R}^d), n \ge 1$ such that

$$
b_n(t,x) \underset{n \to \infty}{\longrightarrow} b(t,x) \ (t,x) - a.e., \tag{10}
$$

$$
\sup_{n\geq 1} \|b_n\|_{L^1_\infty} < \infty \tag{11}
$$

and

$$
|b(t,x)| \le M < \infty, n \ge 1 \text{ a.e. for some constant } M. \tag{12}
$$

Fix $t \in [0, T]$ and $x \in \mathbb{R}^d$. Then there exists $a \beta \in (0, 1/2)$ such that

$$
\sup_{n\geq 1} \int_0^t \int_0^t \frac{E[\|D_\theta X_t^n - D_{\theta'} X_t^n\|^2]}{|\theta - \theta'|^{1+2\beta}} d\theta' d\theta \leq \sup_{n\geq 1} C_{H,d,T} (\|b_n\|_{L_\infty^\infty}, \|b_n\|_{L_\infty^1}) < \infty
$$

and

$$
\sup_{n\geq 1} \|D.X_t^n\|_{L^2(\Omega\times[0,T])} \leq \sup_{n\geq 1} C_{H,d,T}(\|b_n\|_{L_\infty^{\infty}}, \|b_n\|_{L_\infty^1}) < \infty
$$
\n(13)

for some continuous function $C_{H,d,T} : [0, \infty)^2 \longrightarrow [0, \infty)$.

Proof. See [\[5\]](#page-30-6). \blacksquare

Proposition 4 Let $X^{x,n}, n \geq 1$ be a sequence of strong solutions as in Lemma [3](#page-4-2) and X. the strong solution to [\(8\)](#page-4-0). Then

$$
X_t^{x,n} \underset{n \longrightarrow \infty}{\longrightarrow} X_t^x \text{ in } L^2(\Omega)
$$

for all t, x .

Proof. See [\[5\]](#page-30-6). \blacksquare

Lemma 5 Let $U \subset \mathbb{R}^d$ be an open and bounded subset. Consider the sequence $X^{x,n}, n \ge 1$ in Proposition [4.](#page-5-1) Then

$$
\frac{\partial}{\partial x} X^{n}, \quad \longrightarrow \infty \frac{\partial}{\partial x} X^{n}
$$

in $L^2([0,T] \times \Omega \times U)$ weakly.

Proof. This result is a consequence of Proposition [4](#page-5-1) and the estimate in Lemma [2.](#page-4-3)

We are coming now to the main result of our article:

Theorem 6 (Bismut-Elworthy-Li formula) Let $H < \frac{1}{2(d+2)}$ and let X^x be the unique strong solution to the SDE

$$
dX_t^x = b(t, X_t^x)dt + dB_t^H, X_0^x = x, 0 \le t \le T
$$

for $b \in L^{1,\infty}_{\infty,\infty}$. Further, assume that U is a bounded and open subset of \mathbb{R}^d and $\Phi : \mathbb{R}^d \longrightarrow \mathbb{R}$ a Borel measurable function such that

$$
\Phi(X_T) \in L^2(\Omega \times U, \mu \times dx).
$$

. In addition, consider a bounded Borel measurable function $a:[0,T] \longrightarrow \mathbb{R}$ such that

$$
\int_0^T a(s)ds = 1.
$$

Then

$$
\frac{\partial}{\partial x} E[\Phi(X_T^x)]
$$
\n
$$
= C_H E[\Phi(X_T^x) \int_0^T u^{-H-\frac{1}{2}} \int_u^T a(s-u)(s-u)^{\frac{1}{2}-H} s^{H-\frac{1}{2}} \left(\frac{\partial}{\partial x} X_{s-u}^x\right)^* d B_s du]^* \tag{14}
$$

for all $x \in U$ a.e., $0 < t \leq T$, where $*$ denotes the transposition of matrices and where $C_H =$ $1/(c_H \Gamma(\frac{1}{2}+H)\Gamma(\frac{1}{2}-H))$ for

$$
c_H = \left(\frac{2H}{(1-2H)B(1-2H,H+1/2)}\right)^{1/2}.
$$

Here Γ and B are the Gamma and Beta function, respectively.

Remark 7 Let P be the predictable σ -algebra with respect to the μ -augmented filtration $\{\mathcal{F}_t\}_{0\leq t\leq T}$ generated by B^H . Then $\frac{\partial}{\partial x}X_t^x$, $0 \le t \le T$ on the right hand side of Theorem [6](#page-5-0) stands for a process $Y : [0,T] \times \Omega \times U \longrightarrow \mathbb{R}^{d \times d}$ in $L^2([0,T] \times \Omega \times U, \mathcal{P} \otimes \mathcal{B}(U); \mathbb{R}^{d \times d})$ such that $Y_t^{\cdot}(\omega)$ is the Sobolev derivative of $X_t^{\cdot}(\omega)$ $(t, \omega) - a.e.$

Proof. Let $\Phi \in C_c^{\infty}(\mathbb{R}^d)$ and choose a sequence of functions $b_n \in C_c^{\infty}((0,T) \times \mathbb{R}^d)$, which approximates the vector field b in the sense of (10) , (11) and (12) .

Denote by $X_{\cdot}^{s,x,n}$ the unique strong solution to

$$
dX_t^{s,x,n} = b_n(t, X_t^{s,x,n})dt + dB_t^H, X_s^{s,x,n} = x, s \le t \le T
$$

for all n. Since $b_n \in C_c^{\infty}((0,T) \times \mathbb{R}^d)$, it follows that there exists a Ω^* with $\mu(\Omega^*) = 1$ such that for all $\omega \in \Omega^*, 0 \le s \le t \le T$

$$
(x \mapsto X_t^{s,x,n}(\omega)) \in C^\infty(\mathbb{R}^d).
$$

See e.g. [\[17\]](#page-30-11).

The latter and dominated convergence then give

$$
\frac{\partial}{\partial x}E[\Phi(X_T^{x,n})]=E[\Phi^{\scriptscriptstyle \rm I}(X_T^{x,n})\frac{\partial}{\partial x}X_T^{x,n}],
$$

where Φ is the derivative of Φ and $X_t^{x,n} = X_t^{0,x,n}$ $t^{0,x,n}$. On the other hand, we have that for all $0 \leq s \leq t \leq T, x \in U$

$$
X_t^{x,n} = X_t^{s,X_s^{x,n},n}
$$
 a.e.

So we obtain that

$$
\frac{\partial}{\partial x}E[\Phi(X_T^{x,n})] = E[\Phi'(X_T^{x,n})\frac{\partial}{\partial x}X_T^{s,X_s^{x,n},n}\frac{\partial}{\partial x}X_s^{x,n}].
$$

We also know that the Malliavin derivative $D_{\cdot}^{H} X_t^{s,x,n}$ $t^{s,x,n}_t$ of $X_t^{s,x,n}$ $t^{s,x,n}$ in the direction of B^H exists and satisfies the equation

$$
D_u^H X_t^{s,x,n} = \int_u^t b_n(t, X_r^{s,x,n}) D_u^H X_r^{s,x,n} dr + \chi_{(s,t]}(u) I_{d \times d},
$$

where $I_{d\times d}$ is the identity matrix. Further, we see that $\frac{\partial}{\partial x}X^{\mu,X_u^n,n}$ solves the same equation for $s = 0$. Therefore, we obtain by uniqueness of solutions that

$$
D_u^H X_t^{x,n} = \frac{\partial}{\partial x} X_t^{u, X_u^{x,n}, n}
$$

a.e. Hence

$$
\frac{\partial}{\partial x}E[\Phi(X_T^{x,n})] = E[\Phi'(X_T^{x,n})D_s^H X_T^{x,n} \frac{\partial}{\partial x} X_s^{x,n}].
$$

Let $\varphi \in C_c^{\infty}(U)$. Then

$$
-\int_{U} E[\Phi(X_T^{x,n})] \frac{\partial}{\partial x} \varphi(x) dx = \int_{U} \varphi(x) E[\Phi'(X_T^{x,n}) D_s^H X_T^{x,n} \frac{\partial}{\partial x} X_s^{x,n}] dx.
$$

Further, using the fact that the function a sums up to one combined with the chain rule for D^H . (see [\[20\]](#page-31-2)), we obtain that

- \int_{U} E[\Phi(X_{T}^{x,n})] \frac{\partial}{\partial x} \varphi(x) dx
$$

=
$$
\int_{U} \varphi(x) E[\int_{0}^{T} \{a(s)\Phi'(X_{T}^{x,n})D_{s}^{H} X_{T}^{x,n} \frac{\partial}{\partial x} X_{s}^{x,n} \} ds] dx
$$

=
$$
\int_{U} \varphi(x) E[\int_{0}^{T} \{a(s)D_{s}^{H} \Phi(X_{T}^{x,n}) \frac{\partial}{\partial x} X_{s}^{x,n} \} ds] dx
$$

On the other hand, Proposition 5.2.1 and p. 285 in [\[20\]](#page-31-2) shows that

$$
D_s^H \Phi(X_T^{x,n}) = Cs^{\frac{1}{2}-H} \Big(\int_s^T (u-s)^{-H-\frac{1}{2}} u^{H-\frac{1}{2}} D_u \Phi(X_T^{x,n}) du \Big).
$$

for a constant C depending on H . D stands here for the Malliavin derivative in the direction of the Brownian motion B .

Hence, we obtain by substitution (first for u substituted by $u + s$ in the above relation and then for s by $s - u$ in the next step), Fubini's theorem and the duality formula with respect to the Malliavin derivative D , that

-\int_{U} E[\Phi(X_{T}^{x,n})] \frac{\partial}{\partial x} \varphi(x) dx
$$

\n
$$
= C \int_{U} \varphi(x) E[\int_{0}^{T} \{a(s)Cs^{\frac{1}{2}-H} \times (\int_{s}^{T} (u-s)^{-H-\frac{1}{2}}u^{H-\frac{1}{2}}D_{u}\Phi(X_{T}^{x,n})du) \frac{\partial}{\partial x}X_{s}^{x,n}\} ds] dx
$$

\n
$$

In financial applications the right hand side of relation (14) , say M may be interpreted as a sensitivity measure- known as delta- for changes of the fair value of an option with payoff function Φ and underlying d stock price processes X^x (under a change of measure) with respect to the initial prices $x \in \mathbb{R}^d$ of the stocks. The quantity M, is a priori for $H < \frac{1}{2(d+2)}$ only defined for *almost all* initial values x. In practice, however, where a trader is interested in sensitivities with respect to specific initial prices of the stocks, the choice of M as a sensitivity measure would be not satisfactory. On the other hand, in order to make sense of M as a delta for all $x \in \mathbb{R}^d$, one can in fact choose a version of M, which is continuous and hence defined for all x. It turns out, however that such a version of M exists, if the Hurst parameter is allowed to be a little bit smaller than in Theorem [6,](#page-5-0) that is $H < \frac{1}{2(d+3)}$. See Proposition [10,](#page-15-0) whose proof requires the following new estimate, which is based on Theorem [18:](#page-27-0)

Proposition 10 Retain the conditions of Theorem [9.](#page-14-1) Let $p > max(d, 4)$ and $\Phi : \mathbb{R}^d \longrightarrow \mathbb{R}$ be a bounded continuous function. Then M has a continuous version on U, which is obtained by replacing in M on the right hand side of (14) the derivative of the flow by a predictable version $\{Y_t, 0 \le t \le T\} \in L^2([0,T] \times \Omega, dt \times \mu; W^{1,p}(U))$ with $Y_t^{\cdot}(\omega) \in C(U)$ for all (t, ω) .

Proof. As before denote by P the predictable σ -algebra on $[0, T] \times \Omega$ with respect to $\{\mathcal{F}_t\}_{0 \leq t \leq T}$. Then, by using almost the same proof of Theorem [9](#page-14-1) combined with Lemma [8,](#page-11-1) one shows that there exists a $\frac{\partial}{\partial x}X \in L^2([0,T] \times \Omega, \mathcal{P}, dt \times \mu; W^{1,p}(U))$ with $p > \max(d, 4)$ such that $\frac{\partial}{\partial x}X_t^{\cdot}(\omega)$ is the Sobolev derivative of $X_t(\omega)$ on U (t, ω) – a.e. So in particular, we see for $\phi \in L^\infty(\tilde{U}; \mathbb{R})$ that

3 Application: Stock price model with stochastic volatility

In this Section we propose a model for stock prices $S_t^{x_1,x_2}$, $0 \le t \le T$ with stochastic volatility $\sigma_t^{x_2}, 0 \le t \le T$ described by the following SDE

where W. is a Wiener process, which is independent of a fractional Brownian motion B^H with Hurst parameter $H < \frac{1}{2(d+2)} = \frac{1}{6}$ $\frac{1}{6}$, and where $\mu \in \mathbb{R}$, $b \in L^{1,\infty}_{\infty,\infty}$ and $g : \mathbb{R} \longrightarrow (\alpha,\infty)$ belongs to $C_b^2(\mathbb{R})$ for same $\alpha > 0$. Let us also assume that $\Omega = \Omega_1 \times \Omega_2$ for sample spaces Ω_1 , Ω_2 , on which W. and B^H are defined, respectively.

For a moment, let us assume that $b \in C_c^{\infty}((0,T) \times \mathbb{R}^d)$. Then $X_t^x := (S_t^{x_1,x_2}, \sigma_t^{x_2})^*, x =$ (x_1, x_2) is Malliavin differentiable with respect to $Z = (Z^{(1)}, Z^{(2)})^* = (W, B^H)^*$ with Malliavin derivative $D = (D^W, D^H)^*$ and we get

Theorem 11 Let $U \subset \mathbb{R}^2$ be a bounded, open set and $b \in L_{\infty,\infty}^{1,\infty}$ in the stock price model [\(29\)](#page-19-0). Further, assume that $g : \mathbb{R} \longrightarrow (\alpha, \infty)$ belongs to $C_b^2(\mathbb{R})$ for some $\alpha > 0$ and that $\Phi : \mathbb{R}^2 \longrightarrow \mathbb{R}$ satisfies

= (E[\Phi(X_T^x) \int_0^T a(s)(S_s^{x_1,x_2}g(\sigma_s^{x_2}))^{-1} \frac{\partial}{\partial x_1} S_s^{x_1,x_2} dW_s],
$$
\n
$$
E[\Phi(X_T^x) \int_0^T a(s)(S_s^{x_1,x_2}g(\sigma_s^{x_2}))^{-1} \frac{\partial}{\partial x_2} S_s^{x_1,x_2} dW_s]
$$
\n
$$
+ C_H E[\Phi(X_T^x) \int_0^T u^{-H-\frac{1}{2}} \int_u^T a(s-u)(s-u)^{\frac{1}{2}-H} s^{H-\frac{1}{2}} \frac{\partial}{\partial x} \sigma_{s-u}^{x_2} dB_s du])^* \qquad (30)
$$

for almost all $x = (x_1, x_2) \in U$, where C_H is a constant as given in Theorem [6.](#page-5-0)

 ${\bf Remark \ 12} \ \ If \ H < \frac{1}{2(d+3)} = \frac{1}{8}$ $\frac{1}{8}$, one can show just as in Theorem [10](#page-15-0) that the right hand side of [\(30\)](#page-22-0) has a continuous version.

4 Appendix

We want to recall here a version of Girsanov's theorem for the fractional Brownian motion, which we need in the the proof of Lemma [8.](#page-11-1) For this purpose, let us pass in review some basic concepts from fractional calculus (see [\[22\]](#page-31-4) and [\[18\]](#page-31-5)).

Let $a, b \in \mathbb{R}$ with $a < b$. Let $f \in L^p([a, b])$ with $p \ge 1$ and $\alpha > 0$. Introduce the *left*- and right-sided Riemann-Liouville fractional integrals as

$$
I_{a+}^{\alpha}f(x) = \frac{1}{\Gamma(\alpha)} \int_{a}^{x} (x - y)^{\alpha - 1} f(y) dy
$$

and

$$
I_{b^{-}}^{\alpha} f(x) = \frac{1}{\Gamma(\alpha)} \int_{x}^{b} (y - x)^{\alpha - 1} f(y) dy
$$

for almost all $x \in [a, b]$, where Γ is the Gamma function.

For a given integer $p \geq 1$, let $I_{a+}^{\alpha}(L^p)$ (resp. $I_{b-}^{\alpha}(L^p)$) be the image of $L^p([a, b])$ of the operator $I_{a^+}^{\alpha}$ (resp. $I_{b^-}^{\alpha}$). If $f \in I_{a^+}^{\alpha}(\mathring{L}^p)$ (resp. $f \in I_{b^-}^{\alpha}(L^p)$) and $0 < \alpha < 1$ then we can define the left- and right-sided Riemann-Liouville fractional derivatives by

$$
D_{a+}^{\alpha}f(x) = \frac{1}{\Gamma(1-\alpha)} \frac{d}{dx} \int_{a}^{x} \frac{f(y)}{(x-y)^{\alpha}} dy
$$

and

$$
D_{b^{-}}^{\alpha} f(x) = \frac{1}{\Gamma(1-\alpha)} \frac{d}{dx} \int_{x}^{b} \frac{f(y)}{(y-x)^{\alpha}} dy.
$$

The left- and right-sided derivatives of f can be also represented as

$$
D_{a+}^{\alpha}f(x) = \frac{1}{\Gamma(1-\alpha)} \left(\frac{f(x)}{(x-a)^{\alpha}} + \alpha \int_{a}^{x} \frac{f(x) - f(y)}{(x-y)^{\alpha+1}} dy \right)
$$

and

$$
D_{b-}^{\alpha}f(x) = \frac{1}{\Gamma(1-\alpha)} \left(\frac{f(x)}{(b-x)^{\alpha}} + \alpha \int_{x}^{b} \frac{f(x) - f(y)}{(y-x)^{\alpha+1}} dy \right).
$$

Using the above definitions, one obtains that

$$
I_{a^+}^{\alpha}(D_{a^+}^{\alpha}f)=f
$$

for all $f \in I^{\alpha}_{a^+}(L^p)$ and

$$
D_{a^+}^{\alpha}(I_{a^+}^{\alpha}f)=f
$$

for all $f \in L^p([a, b])$ and similarly for $I_{b^-}^{\alpha}$ and $D_{b^-}^{\alpha}$.

Let now $B^H = \{B_t^H, t \in [0,T]\}$ be a d-dimensional fractional Brownian motion with Hurst parameter $H \in (0, 1/2)$, that is B^H is a centered Gaussian process with a covariance function given by

$$
(R_H(t,s))_{i,j} := E[B_t^{H,(i)}B_s^{H,(j)}] = \delta_{ij}\frac{1}{2}(t^{2H} + s^{2H} - |t-s|^{2H}), \quad i,j = 1,\ldots,d,
$$

where δ_{ij} is one, if $i = j$, or zero else.

In the sequel we briefly recall the construction of the fractional Brownian motion, which can be found in [\[20\]](#page-31-2). For simplicity, consider the case $d = 1$.

Let $\mathcal E$ be the set of step functions on [0, T] and $\mathcal H$ be the Hilbert space given by the completion of $\mathcal E$ with respect to the inner product

$$
\langle 1_{[0,t]}, 1_{[0,s]} \rangle_{\mathcal{H}} = R_H(t,s).
$$

From that we get an extension of the mapping $1_{[0,t]} \mapsto B_t$ to an isometry between H and a Gaussian subspace of $L^2(\Omega)$ with respect to B^H . We denote by $\varphi \mapsto B^H(\varphi)$ this isometry.

If $H < 1/2$, one shows that the covariance function $R_H(t,s)$ has the representation

$$
R_H(t,s) = \int_0^{t \wedge s} K_H(t,u) K_H(s,u) du,
$$
\n(31)

where

$$
K_H(t,s) = c_H \left[\left(\frac{t}{s} \right)^{H - \frac{1}{2}} (t - s)^{H - \frac{1}{2}} + \left(\frac{1}{2} - H \right) s^{\frac{1}{2} - H} \int_s^t u^{H - \frac{3}{2}} (u - s)^{H - \frac{1}{2}} du \right].
$$
 (32)

Here $c_H = \sqrt{\frac{2H}{(1-2H)\beta(1-2H,H+1/2)}}$ and β is the Beta function. See [\[20,](#page-31-2) Proposition 5.1.3].

Based on the kernel K_H , one can introduce by means [\(31\)](#page-23-1) an isometry K_H^* between $\mathcal E$ and $L^2([0,T])$ such that $(K_H^*1_{[0,t]})(s) = K_H(t,s)1_{[0,t]}(s)$. This isometry has an extension to the Hilbert space H , which has the following representations by means of fractional derivatives

$$
(K_H^*\varphi)(s) = c_H \Gamma\left(H + \frac{1}{2}\right) s^{\frac{1}{2} - H} \left(D_{T}^{\frac{1}{2} - H} u^{H - \frac{1}{2}} \varphi(u)\right)(s)
$$

and

$$
(K_H^*\varphi)(s) = c_H \Gamma\left(H + \frac{1}{2}\right) \left(D_{T^-}^{\frac{1}{2}-H} \varphi(s)\right)(s)
$$

+
$$
c_H \left(\frac{1}{2} - H\right) \int_s^T \varphi(t)(t-s)^{H-\frac{3}{2}} \left(1 - \left(\frac{t}{s}\right)^{H-\frac{1}{2}}\right) dt.
$$

for $\varphi \in \mathcal{H}$. One also proves that $\mathcal{H} = I_{T^-}^{\frac{1}{2}-H}(L^2)$. See [\[11\]](#page-30-13) and [\[1,](#page-29-1) Proposition 6].

Since K_H^* is an isometry from H into $L^2([0,T])$, the d-dimensional process $W = \{W_t, t \in$ $[0, T]$ defined by

$$
W_t := B^H((K_H^*)^{-1}(1_{[0,t]}))
$$
\n(33)

is a Wiener process and the process B^H can be represented as

$$
B_t^H = \int_0^t K_H(t, s)dW_s.
$$
\n(34)

See [\[1\]](#page-29-1).

In what follows we also need the Definition of a fractional Brownian motion with respect to a filtration.

Definition 13 Let $\mathcal{G} = {\mathcal{G}_t}_{t \in [0,T]}$ be a filtration on (Ω, \mathcal{F}, P) satisfying the usual conditions. A fractional Brownian motion B^H is called a G-fractional Brownian motion if the process W defined by (33) is a $\mathcal G$ -Brownian motion.

In the following, let W be a standard Wiener process on a filtered probability space $(\Omega, \mathfrak{A}, P), \{\mathcal{F}_t\}_{t\in[0,T]},$ where $\mathcal{F} = \{\mathcal{F}_t\}_{t \in [0,T]}$ is the natural filtration generated by W and augmented by all P-null sets. Denote by $B := B^H$ the fractional Brownian motion with Hurst parameter $H \in (0, 1/2)$ as in [\(34\)](#page-24-1).

We aim at using a version of Girsanov's theorem for fractional Brownian motion which is due to [\[11,](#page-30-13) Theorem 4.9]. The version stated here corresponds to that in [\[21,](#page-31-3) Theorem 2]. To this end, we need the definition of an isomorphism K_H from $L^2([0,T])$ onto $I_{0+}^{H+\frac{1}{2}}(L^2)$ with respectively to the kernel $K_H(t, s)$ in terms of the fractional integrals as follows (see [\[11,](#page-30-13) Theorem 2.1]):

$$
(K_H\varphi)(s)=I_{0^+}^{2H}s^{\frac{1}{2}-H}I_{0^+}^{\frac{1}{2}-H}s^{H-\frac{1}{2}}\varphi,\quad \varphi\in L^2([0,T]).
$$

Using this and the properties of the Riemann-Liouville fractional integrals and derivatives, one can show that the inverse of K_H can be represented as

$$
(K_H^{-1}\varphi)(s) = s^{\frac{1}{2}-H} D_{0^+}^{\frac{1}{2}-H} s^{H-\frac{1}{2}} D_{0^+}^{2H} \varphi(s), \quad \varphi \in I_{0^+}^{H+\frac{1}{2}}(L^2).
$$

From this one obtains for absolutely continuous functions φ (see [\[21\]](#page-31-3)) that

$$
(K_H^{-1}\varphi)(s) = s^{H-\frac{1}{2}} I_{0^+}^{\frac{1}{2}-H} s^{\frac{1}{2}-H} \varphi'(s).
$$

Theorem 14 (Girsanov's theorem for fBm) Let $u = \{u_t, t \in [0,T]\}$ be an F-adapted process with integrable trajectories and set $\widetilde{B}_t^H = B_t^H + \int_0^t u_s ds$, $t \in [0, T]$. Suppose that

- (i) $\int_0^{\cdot} u_s ds \in I_{0+}^{H+\frac{1}{2}}(L^2([0,T])),\ P-a.s.$
- (*ii*) $E[\xi_T] = 1$ where

$$
\xi_T := \exp \left\{ - \int_0^T K_H^{-1} \left(\int_0^{\cdot} u_r dr \right) (s) dW_s - \frac{1}{2} \int_0^T K_H^{-1} \left(\int_0^{\cdot} u_r dr \right)^2 (s) ds \right\}.
$$

Then the shifted process \widetilde{B}^H is an *F*-fractional Brownian motion with Hurst parameter H under the new probability \widetilde{P} defined by $\frac{dP}{dP} = \xi_T$.

Remark 15 In the the multi-dimensional case, we define

$$
(K_H \varphi)(s) := ((K_H \varphi^{(1)})(s), \dots, (K_H \varphi^{(d)})(s))^*, \varphi \in L^2([0, T]; \mathbb{R}^d),
$$

where $*$ denotes transposition. Similarly for K_H^{-1} and K_H^* .

In this article we also resort to the following technical lemma (see [\[5,](#page-30-6) Lemma 4.3] for a proof):

Lemma 16 Let \tilde{B}^H_t be a d-dimensional fractional Brownian motion with respect to $(\Omega, \mathfrak{A}, \tilde{P})$. Then for every $k \in \mathbb{R}$ we have

$$
\tilde{E}\left[\exp\left\{k\int_0^T \left|K_H^{-1}\left(\int_0^{\cdot} b(r,\tilde{B}_r^H)dr\right)(s)\right|^2 ds\right\}\right] \leq C_{H,d,\mu,T}(\|b\|_{L_\infty^\infty})
$$

for some continuous increasing function $C_{H,d,k,T}$ depending only on H, d, T and k. In particular,

$$
\tilde{E}\left[\mathcal{E}\left(\int_0^T K_H^{-1}\left(\int_0^{\cdot} b(r,\tilde{B}_r^H)dr\right)^*(s)dW_s\right)^p\right] \leq C_{H,d,\mu,T}(\|b\|_{L_\infty^\infty}),
$$

where $\mathcal{E}(M_t)$ is the Dolean-Dade exponential of a local martingale $M_t, 0 \le t \le T$ and where \tilde{E} denotes expectation under \tilde{P} and $*$ transposition.

In this paper, we will also make use of an integration by parts formula for iterated integrals based on *shuffle permutations*. For this purpose, let m and n be integers. Denote by $S(m, n)$ the set of shuffle permutations, i.e. the set of permutations $\sigma : \{1, \ldots, m+n\} \to \{1, \ldots, m+n\}$ such that $\sigma(1) < \cdots < \sigma(m)$ and $\sigma(m+1) < \cdots < \sigma(m+n)$.

Introduce the *m*-dimensional simplex for $0 \le \theta < t \le T$,

$$
\Delta_{\theta,t}^m := \{ (s_m, \dots, s_1) \in [0,T]^m : \theta < s_m < \dots < s_1 < t \}.
$$

The product of two simplices can be represented as follows

$$
\Delta_{\theta,t}^m \times \Delta_{\theta,t}^n = \bigcup_{\sigma \in S(m,n)} \{(w_{m+n}, \ldots, w_1) \in [0,T]^{m+n} : \theta < w_{\sigma(m+n)} < \cdots < w_{\sigma(1)} < t\} \cup \mathcal{N},
$$

where the set N has null Lebesgue measure. So, if $f_i : [0, T] \to \mathbb{R}, i = 1, \ldots, m+n$ are integrable functions we get that

$$
\int_{\Delta_{\theta,t}^m} \prod_{j=1}^m f_j(s_j) ds_m \dots ds_1 \int_{\Delta_{\theta,t}^n} \prod_{j=m+1}^{m+n} f_j(s_j) ds_{m+n} \dots ds_{m+1}
$$
\n
$$
= \sum_{\sigma \in S(m,n)} \int_{\Delta_{\theta,t}^{m+n}} \prod_{j=1}^{m+n} f_{\sigma(j)}(w_j) dw_{m+n} \dots dw_1.
$$
\n(35)

A generalization of the latter relation is the following (see [\[5\]](#page-30-6)):

Lemma 17 Let n, p and k be non-negative integers, $k \leq n$. Suppose we have integrable functions $f_j : [0,T] \to \mathbb{R}, j = 1, \ldots, n$ and $g_i : [0,T] \to \mathbb{R}, i = 1, \ldots, p$. We may then write

$$
\int_{\Delta_{\theta,t}^n} f_1(s_1) \dots f_k(s_k) \int_{\Delta_{\theta,s_k}^p} g_1(r_1) \dots g_p(r_p) dr_p \dots dr_1 f_{k+1}(s_{k+1}) \dots f_n(s_n) ds_n \dots ds_1
$$

=
$$
\sum_{\sigma \in A_{n,p}} \int_{\Delta_{\theta,t}^{n+p}} h_1^{\sigma}(w_1) \dots h_{n+p}^{\sigma}(w_{n+p}) dw_{n+p} \dots dw_1,
$$

where $h_l^{\sigma} \in \{f_j, g_i : 1 \leq j \leq n, 1 \leq i \leq p\}$. Above $A_{n,p}$ stands for a subset of permutations of $\{1,\ldots,n+p\}$ such that $\#A_{n,p} \leq C^{n+p}$ for an appropriate constant $C \geq 1$. Here $s_0 := \theta$.

The proof of Lemma [8](#page-11-1) relies on an important estimate (see e.g. Proposition 3.3 in [\[6\]](#page-30-7) for a new proof (2018)). In order to state this result, we need some notation. Let m be an integer and let $f: [0, T]^m \times (\mathbb{R}^d)^m \to \mathbb{R}$ be a function of the form

$$
f(s, z) = \prod_{j=1}^{m} f_j(s_j, z_j), \quad s = (s_1, \dots, s_m) \in [0, T]^m, \quad z = (z_1, \dots, z_m) \in (\mathbb{R}^d)^m,
$$
 (36)

where $f_j : [0, T] \times \mathbb{R}^d \to \mathbb{R}, j = 1, \ldots, m$ are smooth functions with compact support. In addition, let $\kappa : [0, T]^m \to \mathbb{R}$ be a function of the form

$$
\varkappa(s) = \prod_{j=1}^{m} \varkappa_j(s_j), \quad s \in [0, T]^m,
$$
\n(37)

.

where $\varkappa_j : [0, T] \to \mathbb{R}, j = 1, \ldots, m$ are integrable functions.

Further, denote by α_j a multi-index and D^{α_j} its corresponding differential operator. For $\alpha = (\alpha_1, \ldots, \alpha_m)$ as an element of $\mathbb{N}_0^{d \times m}$ with $|\alpha| := \sum_{j=1}^m \sum_{l=1}^d \alpha_j^{(l)}$ $j^{(i)}$, we write

$$
D^{\alpha}f(s,z) = \prod_{j=1}^{m} D^{\alpha_j}f_j(s_j,z_j).
$$

Theorem 18 Let B^H , $H \in (0, 1/2)$ be a standard d–dimensional fractional Brownian motion and functions f and \varkappa as in [\(36\)](#page-26-1), respectively as in [\(37\)](#page-27-2). Let $\theta, t \in [0, T]$ with $\theta < t$ and

$$
\varkappa_j(s) = (K_H(s,\theta))^{\varepsilon_j}, \theta < s < t
$$

for every $j = 1, ..., m$ with $(\varepsilon_1, ..., \varepsilon_m) \in \{0, 1\}^m$. Let $\alpha \in (\mathbb{N}_0^d)^m$ be a multi-index. If

$$
H < \frac{\frac{1}{2} - \gamma}{(d-1 + 2\sum_{l=1}^d \alpha_j^{(l)})}
$$

for all j, where $\gamma \in (0, H)$ is sufficiently small, then there exists a universal constant C (depending on H, T and d, but independent of m, $\{f_i\}_{i=1,\dots,m}$ and α) such that for any $\theta, t \in [0, T]$ with $\theta < t$ we have

$$
\begin{aligned}\n&\left|E\int_{\Delta_{\theta,t}^m} \left(\prod_{j=1}^m D^{\alpha_j} f_j(s_j, B^H_{s_j}) \varkappa_j(s_j)\right) ds\right| \\
&\leq C^{m+|\alpha|} \prod_{j=1}^m \|f_j(\cdot, z_j)\|_{L^1(\mathbb{R}^d; L^\infty([0,T]))} \theta^{(H-\frac{1}{2})\sum_{j=1}^m \varepsilon_j} \\
&\times \frac{(\prod_{l=1}^d (2|\alpha^{(l)}|)!)^{1/4}(t-\theta)^{-H(md+2|\alpha|)-(H-\frac{1}{2}-\gamma)\sum_{j=1}^m \varepsilon_j+m}}{\Gamma(-H(2md+4|\alpha|)+2(H-\frac{1}{2}-\gamma)\sum_{j=1}^m \varepsilon_j+2m)^{1/2}}\n\end{aligned}
$$

Remark 19 The above theorem remains valid for time-homogeneous functions $\{f_i\}_{i=1,\dots,m}$ in the Schwartz function space.

The proof of Lemma [8](#page-11-1) also requires the following auxiliary result:

Lemma 20 Let n, p and k be non-negative integers, $k \leq n$. Assume we have functions f_i : $[0, T] \to \mathbb{R}, j = 1, \ldots, n$ and $g_i : [0, T] \to \mathbb{R}, i = 1, \ldots, p$ such that

$$
f_j\in \left\{\frac{\partial^{\alpha_j^{(1)}+\ldots+\alpha_j^{(d)}}}{\partial^{\alpha_j^{(1)}} x_1\ldots\partial^{\alpha_j^{(d)}} x_d}b^{(r)}(u,X_u^x),\ r=1,...,d\right\},\ j=1,...,n
$$

and

$$
g_i \in \left\{ \frac{\partial^{\beta_i^{(1)}} + \dots + \beta_i^{(d)}}{\partial^{\beta_i^{(1)}} x_1 \dots \partial^{\beta_i^{(d)}} x_d} b^{(r)}(u, X_u^x), \ r = 1, ..., d \right\}, \ i = 1, ..., p
$$

for $\alpha := (\alpha_i^{(l)})$ $j^{(l)}_j$) $\in \mathbb{N}_0^{d \times n}$ and $\beta := (\beta_i^{(l)})$ $\binom{l}{i} \in \mathbb{N}_0^{d \times p}$ $_0^{d\times p}$, where X^x_\cdot is the strong solution to

$$
X_t^x = x + \int_0^t b(u, X_u^x) du + B_t^H, \ 0 \le t \le T
$$

 $for b = (b^{(1)},...,b^{(d)})$ with $b^{(r)} \in C_c((0,T) \times \mathbb{R}^d)$ for all $r = 1,...,d$. So (as we shall say in the sequel) the product $g_1(r_1)\cdots g_p(r_p)$ has a total order of derivatives $|\beta| = \sum_{l=1}^d \sum_{i=1}^p \beta_i^{(l)}$ $i^{(i)}$. We know from Lemma [17](#page-26-0) that

$$
\int_{\Delta_{\theta,t}^n} f_1(s_1) \dots f_k(s_k) \int_{\Delta_{\theta,s_k}^p} g_1(r_1) \dots g_p(r_p) dr_p \dots dr_1 f_{k+1}(s_{k+1}) \dots f_n(s_n) ds_n \dots ds_1
$$
\n
$$
= \sum_{\sigma \in A_{n,p}} \int_{\Delta_{\theta,t}^{n+p}} h_1^{\sigma}(w_1) \dots h_{n+p}^{\sigma}(w_{n+p}) dw_{n+p} \dots dw_1,
$$
\n(38)

where $h_l^{\sigma} \in \{f_j, g_i : 1 \leq j \leq n, 1 \leq i \leq p\}$, $A_{n,p}$ is a subset of permutations of $\{1, \ldots, n+p\}$ such that $#A_{n,p} \leq C^{n+p}$ for an appropriate constant $C \geq 1$, and $s_0 = \theta$. Then the products

$$
h_1^{\sigma}(w_1)\cdot\cdots\cdot h_{n+p}^{\sigma}(w_{n+p})
$$

have a total order of derivatives given by $|\alpha| + |\beta|$.

Proof. The result is proved by induction on n. For $n = 1$ and $k = 0$ the result is trivial. For $k = 1$ we have

$$
\int_{\theta}^{t} f_1(s_1) \int_{\Delta_{\theta,s_1}^p} g_1(r_1) \dots g_p(r_p) \qquad dr_p \dots dr_1 ds_1
$$

=
$$
\int_{\Delta_{\theta,t}^{p+1}} f_1(w_1) g_1(w_2) \dots g_p(w_{p+1}) dw_{p+1} \dots dw_1,
$$

where we have put $w_1 = s_1, w_2 = r_1, \ldots, w_{p+1} = r_p$. Hence the total order of derivatives involved in the product of the last integral is given by $\sum_{l=1}^{d} \alpha_1^{(l)} + \sum_{l=1}^{d} \sum_{i=1}^{p} \beta_i^{(l)} = |\alpha| + |\beta|$.

Assume the result holds for n and let us show that this implies that the result is true for $n+1$. Either $k = 0, 1$ or $2 \leq k \leq n+1$. For $k = 0$ the result is trivial. For $k = 1$ we have

$$
\int_{\Delta_{\theta,t}^{n+1}} f_1(s_1) \int_{\Delta_{\theta,s_1}^p} g_1(r_1) \dots g_p(r_p) dr_p \dots dr_1 f_2(s_2) \dots f_{n+1}(s_{n+1}) ds_{n+1} \dots ds_1
$$
\n
$$
= \int_{\theta}^t f_1(s_1) \left(\int_{\Delta_{\theta,s_1}^n} \int_{\Delta_{\theta,s_1}^p} g_1(r_1) \dots g_p(r_p) dr_p \dots dr_1 f_2(s_2) \dots f_{n+1}(s_{n+1}) ds_{n+1} \dots ds_2 \right) ds_1.
$$

From [\(35\)](#page-26-2) we observe by using the shuffle permutations that the latter inner double integral on diagonals can be written as a sum of integrals on diagonals of length $p+n$ with products having a total order of derivatives given by $\sum_{l=1} \sum_{j=2}^{n+1} \alpha_j^{(l)} + \sum_{l=1}^d \sum_{i=1}^p \beta_i^{(l)}$ $i^{(i)}$. Hence we obtain a sum of products, whose total order of derivatives is $\sum_{l=1}^{d} \sum_{j=2}^{n+1} \alpha_j^{(l)} + \sum_{l=1}^{d} \sum_{i=1}^{p} \beta_i^{(l)} + \sum_{l=1}^{d} \alpha_1^{(l)} =$ $|\alpha| + |\beta|$.

For $k \geq 2$ we have (in connection with Lemma [17\)](#page-26-0) from the induction hypothesis that

\int_{\Delta_{\theta,t}^{n+1}} f_1(s_1) \dots f_k(s_k) \int_{\Delta_{\theta,s_k}^p} g_1(r_1) \dots g_p(r_p) dr_p \dots dr_1 f_{k+1}(s_{k+1}) \dots f_{n+1}(s_{n+1}) ds_{n+1} \dots ds_1
$$

= \int_{\theta}^t f_1(s_1) \int_{\Delta_{\theta,s_1}^n} f_2(s_2) \dots f_k(s_k) \int_{\Delta_{\theta,s_k}^p} g_1(r_1) \dots g_p(r_p) dr_p \dots dr_1
$$

\times f_{k+1}(s_{k+1}) \dots f_{n+1}(s_{n+1}) ds_{n+1} \dots ds_2 ds_1
$$

= \sum_{\sigma \in A_{n,p}} \int_{\theta}^t f_1(s_1) \int_{\Delta_{\theta,s_1}^{n+p}} h_1^{\sigma}(w_1) \dots h_{n+p}^{\sigma}(w_{n+p}) dw_{n+p} \dots dw_1 ds_1,
$$

where each of the products $h_1^{\sigma}(w_1) \cdots h_{n+p}^{\sigma}(w_{n+p})$ have a total order of derivatives given by $\sum_{l=1} \sum_{j=2}^{n+1} \alpha_j^{(l)} + \sum_{l=1}^d \sum_{i=1}^p \beta_i^{(l)}$ $i^{(t)}$. Thus we get a sum with respect to a set of permutations $A_{n+1,p}$ with products having a total order of derivatives which is

$$
\sum_{l=1}^{d} \sum_{j=2}^{n+1} \alpha_j^{(l)} + \sum_{l=1}^{d} \sum_{i=1}^{p} \beta_i^{(l)} + \sum_{l=1}^{d} \alpha_1^{(l)} = |\alpha| + |\beta|.
$$
