ASYMPTOTIC BEHAVIOR OF SOLUTIONS TO A HIGHER-ORDER KDV-TYPE EQUATION WITH CRITICAL NONLINEARITY

ABSTRACT. We consider the Cauchy problem of the higher-order KdV-type equation:

$$\partial_t u + \frac{1}{\mathfrak{m}} |\partial_x|^{\mathfrak{m}-1} \partial_x u = \partial_x (u^{\mathfrak{m}})$$

where $\mathfrak{m} \geq 4$. The nonlinearity is critical in the sense of long-time behavior. Using the method of testing by wave packets, we prove that there exists a unique global solution of the Cauchy problem satisfying the same time decay estimate as that of linear solutions. Moreover, we divide the long-time behavior of the solution into three distinct regions.

1. Introduction

We consider the Cauchy problem for the higher-order Korteweg-de Vries (KdV) type equation

(1.1)
$$\partial_t u + \frac{1}{\mathfrak{m}} |\partial_x|^{\mathfrak{m}-1} \partial_x u = \partial_x (u^{\mathfrak{m}}),$$

where u is a real valued function, $|\partial_x| = (-\partial_x^2)^{\frac{1}{2}}$, and $\mathfrak{m} \in \mathbb{Z}_{\geq 3}$. This equation describes the propagation of nonlinear waves in a dispersive medium. In particular, (1.1) with $\mathfrak{m} = 3,5$ are called the modified KdV (mKdV) and the modified Kawahara equations, respectively.

If u is a solution to (1.1), then the total mass, the momentum, and the energy are conserved:

$$\int_{\mathbb{R}} u(t,x)dx, \quad \int_{\mathbb{R}} u(t,x)^2 dx,$$

$$\int_{\mathbb{R}} \left\{ \frac{1}{2\mathfrak{m}} \left| \left| \partial_x \right|^{\frac{\mathfrak{m}-1}{2}} u(t,x) \right|^2 - \frac{1}{\mathfrak{m}+1} u(t,x)^{\mathfrak{m}+1} \right\} dx.$$

Local-in-time well-posedness of the Cauchy problem for (1.1) follows from the same argument as in [19] (see also [17, 18, 4] and references therein). Owing to the conserved quantities, the local-in-time solution can be extended to the global-in-time one if the values of the initial data are small. Thus, it is of interest to obtain the asymptotic behavior of solutions to (1.1).

Sidi et al. [27] studied the long-time behavior of solutions to the generalized KdV equations

(1.2)
$$\partial_t u + \frac{1}{\alpha} |\partial_x|^{\alpha - 1} \partial_x u = \partial_x (u^p)$$

for $\alpha \in \mathbb{R}$, $\alpha \geq 1$, and $p \in \mathbb{Z}_{\geq 2}$. More precisely, they proved that when the initial data values are small, the global-in-time solution scatters to a linear solution if $\alpha \geq 1$ and $p > \frac{\alpha + \sqrt{\alpha^2 + 4\alpha}}{2} + 1$. Kenig et al. [18] improved the results in [27], that is the scattering for small initial data values holds true if $\alpha \geq 1$ and $p > \max(\alpha + 1, \frac{\alpha}{2} + 3)$. Because there exists a blow up solution in some cases when initial data values are large ([21, 23]), the assumption of small initial data values is essential.

The asymptotic behavior for (1.2) with $\alpha = 3$ has been studied by several researchers (see [1, 7, 8, 9, 28, 22, 13, 5, 3, 2] and references therein). In particular, p = 3 is critical in the sense of long-time behavior. In other words, while the solutions scatter for p > 3, asymptotic behavior of the solution differs from that of the linear solutions when p = 3. Moreover, Hayashi and Naumkin [10, 12] showed the criticality of the quartic derivative fourth-order nonlinear Schrödinger equation (see also [11, 14]), which is related to (1.1) with $\mathfrak{m} = 4$.

From these results, we expect that the nonlinearity of (1.1) is critical in the sense of long-time behavior. However, there is a gap between the exponent of nonlinearity in previous results and that to be critical in general. In this paper, we study the asymptotic behavior of solutions to (1.1) for $\mathfrak{m} \geq 4$. Even though we used $u^{\mathfrak{m}}$ in (1.1) in our study, the same asymptotic behavior is obtained for (1.1) with short-range perturbations (see Remark 1.3).

To explain the critical phenomenon, we roughly derive the asymptotic behavior of linear solutions for Schwartz initial data $u_0 \in \mathcal{S}(\mathbb{R})$. Let $\mathcal{U}(t)$ denote the linear propagator, i.e., $\mathcal{U}(t) := e^{-\frac{1}{m}t|\partial_x|^{\mathfrak{m}-1}\partial_x}$. We note that, for t > 0, the linear solution is written as follows:

$$\mathcal{U}(t)u_0(x) = t^{-\frac{1}{m}} \int_{\mathbb{R}} Q_0\left(t^{-\frac{1}{m}}(x-y)\right) u_0(y) dy,$$

where Q_0 is defined by $Q_0(y) := \frac{1}{2\pi} \int_{\mathbb{R}} e^{i(y\xi - \frac{1}{\mathfrak{m}}|\xi|^{\mathfrak{m}-1}\xi)} d\xi$, that is, Q_0 satisfies the ordinary differential equation

$$\left| \frac{d}{dy} \right|^{\mathfrak{m}-1} Q_0 - yQ_0 = 0.$$

Sidi et al. [27] proved the following estimate for Q_0 :

$$\left| \frac{d^k Q_0}{dy^k}(y) \right| \lesssim \langle y \rangle^{\frac{k}{\mathfrak{m}-1} - \frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}},$$

where $\langle y \rangle := (1 + |y|^2)^{\frac{1}{2}}$.

The Hamiltonian flow corresponding to the linear equation is given by

$$(x,\xi) \mapsto (x+t|\xi|^{\mathfrak{m}-1},\xi).$$

We expect that, for v > 0, solutions initially localized spatially near zero and at frequencies near $\pm \xi_v$, where $\xi_v := v^{\frac{1}{m-1}}$, travel along the ray $\Gamma_v := \{x = vt\}$. Hence, the linear solution $\mathcal{U}(t)u_0(x)$ decays rapidly as $t^{-\frac{1}{m}}x \to -\infty$ and oscillates as $t^{-\frac{1}{m}}x \to +\infty$. In particular, the stationary phase method shows that, as $t^{-\frac{1}{m}}x \to +\infty$

 $+\infty$, there exists a constant c_0 such that

$$\mathcal{U}(t)u_0(x) = c_0 t^{-\frac{1}{\mathfrak{m}}} (t^{-\frac{1}{\mathfrak{m}}} x)^{-\frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}} \Re\left\{\widehat{u_0}\left(t^{-\frac{1}{\mathfrak{m}-1}} x^{\frac{1}{\mathfrak{m}-1}}\right) e^{i\phi(t,x)}\right\} + \text{error},$$

where the phase function is given by

(1.3)
$$\phi(t,x) := \frac{\mathfrak{m}-1}{\mathfrak{m}} t^{-\frac{1}{\mathfrak{m}-1}} |x|^{\frac{\mathfrak{m}}{\mathfrak{m}-1}} - \frac{\pi}{4}.$$

Moreover, in the self-similar region $|t^{-\frac{1}{m}}x| \lesssim 1$,

$$\mathcal{U}(t)u_0(x) = t^{-\frac{1}{m}}Q_0(t^{-\frac{1}{m}}x) \int_{\mathbb{R}} u_0(y)dy + \text{error.}$$

This observation implies that if $||u_0||_{L^2} + ||xu_0||_{L^2} \le \varepsilon$ then we have

$$\left|\partial_x^k \mathcal{U}(t) u_0(x)\right| \lesssim \varepsilon t^{-\frac{k+1}{\mathfrak{m}}} \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{\frac{k}{\mathfrak{m}-1} - \frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}}$$

for k = 0, 1, ..., m - 2. We expect that solutions to (1.1) satisfy the same pointwise estimates as linear solutions above when the initial data values are small. Then,

$$||u(t)||_{L_x^2} \lesssim ||u(1)||_{L^2} + \varepsilon^{\mathfrak{m}-1} \int_1^t ||u(t')||_{L_x^2} \frac{dt'}{t'}.$$

Because the integral is not bounded by $\sup_{t\geq 1} \|u(t)\|_{L^2}$, we only expect that the solution behaves like a linear solution up to $t\sim \exp(\varepsilon^{-\mathfrak{m}+1})$. Especially, the asymptotic behavior of the solution differs from that of linear solutions.

1.1. Main result. To state our results precisely, we introduce notation and function spaces. We denote the set of positive and negative real numbers by \mathbb{R}_+ and \mathbb{R}_- , respectively. We denote the usual Sobolev space by $H^s(\mathbb{R})$. For $s \in \mathbb{R}$, we denote the weighted Sobolev spaces by $\Sigma^s(\mathbb{R})$ equipped with the norm $||f||_{\Sigma^s} := ||f||_{H^s} + ||xf||_{L^2}$.

Theorem 1.1. Let $\mathfrak{m} \geq 4$. Assume that the initial datum u_0 at time 0 satisfies

$$||u_0||_{\Sigma^{\frac{\mathfrak{m}-1}{2\mathfrak{m}}}} \le \varepsilon \ll 1.$$

Then, there exists a unique global solution u to (1.1) with $\mathcal{U}(-t)u \in C(\mathbb{R}; \Sigma^{\frac{\mathfrak{m}-1}{2\mathfrak{m}}}(\mathbb{R}))$ satisfying the estimates

$$\left\| \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{-\frac{k}{\mathfrak{m}-1} + \frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}} \partial_x^k u(t) \right\|_{L^{\infty}} \lesssim \varepsilon t^{-\frac{k+1}{\mathfrak{m}}}$$

for $t \geq 1$ and $k = 0, 1, ..., \mathfrak{m} - 2$. Moreover, we have the following asymptotic behavior as $t \to +\infty$.

In the decaying region $\mathfrak{X}^-(t) := \{x \in \mathbb{R}_-: t^{-\frac{1}{\mathfrak{m}}}|x| \gtrsim t^{(\mathfrak{m}-1)\rho}\}$, where $\rho := \frac{1}{\mathfrak{m}}(\frac{1}{2\mathfrak{m}} - \varepsilon)$, we have

$$\left\|t^{\frac{1}{\mathfrak{m}}}\langle t^{-\frac{1}{\mathfrak{m}}}x\rangle^{\frac{2\mathfrak{m}-3}{2(\mathfrak{m}-1)}}u\right\|_{L^{\infty}(\mathfrak{X}^{-}(t))}+\left\|t^{\frac{1}{2\mathfrak{m}}}\langle t^{-\frac{1}{\mathfrak{m}}}x\rangle u\right\|_{L^{2}(\mathfrak{X}^{-}(t))}\lesssim \varepsilon.$$

In the self-similar region $\mathfrak{X}^0(t) := \{x \in \mathbb{R} : t^{-\frac{1}{m}}|x| \lesssim t^{(\mathfrak{m}-1)\rho}\}$, there exists a solution Q = Q(y) to the nonlinear ordinary differential equation

(1.5)
$$\left| \frac{d}{dy} \right|^{\mathfrak{m}-1} Q - yQ - \mathfrak{m}Q^{\mathfrak{m}} = 0,$$

satisfying $||Q||_{L^{\infty}_{y}} \lesssim \varepsilon$ and

$$\begin{split} & \left\| u(t) - t^{-\frac{1}{\mathfrak{m}}} Q(t^{-\frac{1}{\mathfrak{m}}} x) \right\|_{L^{\infty}(\mathfrak{X}^{0}(t))} \lesssim \varepsilon t^{-\frac{1}{\mathfrak{m}} - (\mathfrak{m} - \frac{3}{2})\rho}, \\ & \left\| u(t) - t^{-\frac{1}{\mathfrak{m}}} Q(t^{-\frac{1}{\mathfrak{m}}} x) \right\|_{L^{2}(\mathfrak{X}^{0}(t))} \lesssim \varepsilon t^{-\frac{1}{2\mathfrak{m}} - (\mathfrak{m} - 1)\rho}. \end{split}$$

In the oscillatory region $\mathfrak{X}^+(t) := \{x \in \mathbb{R}_+ : t^{-\frac{1}{\mathfrak{m}}}|x| \geq t^{(\mathfrak{m}-1)\rho}\}$, there exists a unique complex-valued function W satisfying $W(\xi) = \overline{W(-\xi)}$ and $\|W\|_{L^{\infty} \cap L^2} \lesssim \varepsilon$ such that

$$u(t) = \frac{2}{\sqrt{\mathfrak{m} - 1}} t^{-\frac{1}{\mathfrak{m}}} (t^{-\frac{1}{\mathfrak{m}}} x)^{-\frac{\mathfrak{m} - 2}{2(\mathfrak{m} - 1)}} \Re \left\{ W \left(t^{-\frac{1}{\mathfrak{m} - 1}} |x|^{\frac{1}{\mathfrak{m} - 1}} \right) e^{i\phi(t, x)} \right\} + \mathbf{err}_x,$$

where the error, \mathbf{err}_x , satisfied the estimates

$$\left\| t^{\frac{1}{\mathfrak{m}}} (t^{-\frac{1}{\mathfrak{m}}} x)^{\frac{3(\mathfrak{m}-2)}{4(\mathfrak{m}-1)}} \mathbf{err}_x \right\|_{L^{\infty}(\mathfrak{X}^+(t))} + \left\| t^{\frac{1}{2\mathfrak{m}}} (t^{-\frac{1}{\mathfrak{m}}} x)^{\frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}} \mathbf{err}_x \right\|_{L^2(\mathfrak{X}^+(t))} \lesssim \varepsilon.$$

In the corresponding frequency region $\widehat{\mathfrak{X}}^+(t) := \{ \xi \in \mathbb{R}_+ : t^{\frac{1}{\mathfrak{m}}} |\xi| \gtrsim t^{\frac{1}{\mathfrak{m}}(\frac{1}{2\mathfrak{m}} - \varepsilon)} \}, we have$

$$\widehat{u}(t,\xi) = W(\xi)e^{\frac{1}{\mathfrak{m}}it\xi^{\mathfrak{m}}} + \mathbf{err}_{\xi},$$

where the error, \mathbf{err}_{ξ} , satisfies

$$\left\| (t^{\frac{1}{\mathfrak{m}}}\xi)^{\frac{\mathfrak{m}-2}{4}}\mathbf{err}_{\xi} \right\|_{L^{\infty}(\widehat{\mathfrak{X}}^{+}(t))} + \left\| t^{\frac{1}{2\mathfrak{m}}} (t^{\frac{1}{\mathfrak{m}}}\xi)^{\frac{\mathfrak{m}-2}{2}}\mathbf{err}_{\xi} \right\|_{L^{2}(\widehat{\mathfrak{X}}^{+}(t))} \lesssim \varepsilon.$$

As (1.1) has time reversal symmetry given by $u(t,x) \mapsto u(-t,-x)$, we get the corresponding asymptotic behavior as $t \to -\infty$.

Theorem 1.1 presents the leading asymptotic term not only in $L^{\infty}(\mathbb{R})$, but also in $L^{2}(\mathbb{R})$. In addition, as with linear solutions, we divide the long-time behavior of the solution to (1.1) into three distinct regions. Moreover, Theorem (1.1) says that there is a difference between u and linear solutions in $\mathfrak{X}^{0}(t)$, while the leading term of u in $\mathfrak{X}^{+}(t)$ behaves like a linear solution.

The regularity assumption $u_0 \in H^{\frac{2m}{m-1}}(\mathbb{R})$ needs to show the existence of a local-in-time solution u with $\mathcal{U}(-t)u \in C([-T,T];\Sigma^0(\mathbb{R}))$ (see Remark 1.5 below). In other words, regularity is no longer required in the proof of the global existence and asymptotic behavior.

Remark 1.2. Because Q satisfies (1.5), $\mathfrak{u}(t,x) := t^{-\frac{1}{m}}Q(t^{-\frac{1}{m}}x)$ is a solution to (1.1) with the initial datum $\mathfrak{u}(0) = \int_{\mathbb{R}} u_0(x) dx \delta_0$, where δ_0 denotes the Dirac delta measure concentrated at the origin. Moreover, by (5.2) below, we can roughly state that

$$||u(t) - \mathfrak{u}(t)||_{L^{\infty}(\mathbb{R})} \lesssim \varepsilon t^{-\frac{1}{\mathfrak{m}} - \varepsilon}.$$

If $\int_{\mathbb{R}} u_0(x) dx = 0$, then the self-similar solution vanishes, and the solution u to (1.1) decays faster than $t^{-\frac{1}{m}}$. Accordingly, the nonlinearity of (1.1) is not critical in the long-time behavior in this case.

Remark 1.3. Theorem (1.1) is also true for short-range perturbations of the form

(1.6)
$$\partial_t u + \frac{1}{\mathfrak{m}} |\partial_x|^{\mathfrak{m}-1} \partial_x u = \partial_x (u^{\mathfrak{m}} + F(u)),$$

where there exists a real number $\mathfrak{p} > \mathfrak{m}$ such that $F \in C^3(\mathbb{R})$ and

$$\left| \frac{d^j}{du^j} F(u) \right| \lesssim |u|^{\mathfrak{p}-j}$$

for j=0,1,2,3. In fact, if $u_0\in \Sigma^{\frac{p-1}{2p}}(\mathbb{R})$ with $\|u_0\|_{\Sigma^{\frac{p-1}{2p}}}\leq \varepsilon$, then there exists a unique global solution u to (1.6) with $\mathcal{U}(-t)u\in C\left(\mathbb{R};\Sigma^{\frac{p-1}{2p}}(\mathbb{R})\right)$ satisfying the estimate (1.4). Moreover, the global solution has the same asymptotic behavior as in Theorem 1.1, as long as $\rho=\frac{1}{\mathfrak{m}}(\frac{1}{2\mathfrak{m}}-\varepsilon)$ is replaced with $\widetilde{\rho}:=\frac{1}{\mathfrak{m}}(\frac{1}{2\mathfrak{m}}-\mathfrak{a}-\varepsilon)$, where $\mathfrak{a}:=\max(\frac{2\mathfrak{m}+1-2\mathfrak{p}}{2\mathfrak{m}},0)<\frac{1}{2\mathfrak{m}}$. For completeness, we briefly outline these modifications in Appendix B.

1.2. Outline of the proof. We give an outline of the proof of Theorem 1.1. Let \mathcal{L} denote the linear operator of (1.1):

$$\mathcal{L} := \partial_t + \frac{1}{\mathfrak{m}} |\partial_x|^{\mathfrak{m} - 1} \partial_x.$$

To obtain pointwise estimates of solutions, we use the "vector field"

$$\mathcal{J} := \mathcal{U}(t)x\mathcal{U}(-t) = x - t|\partial_x|^{\mathfrak{m}-1}.$$

However, \mathcal{J} does not behave well with respect to the nonlinearity, so as in [7, 8, 5] we instead work with

$$\Lambda := \partial_x^{-1}(\mathfrak{m}t\partial_t + x\partial_x + 1).$$

Here, $S := \mathfrak{m}t\partial_t + x\partial_x + 1$ is the generator of the scaling transformation for (1.1):

$$(1.7) u(t,x) \mapsto \lambda u(\lambda^{\mathfrak{m}}t,\lambda x)$$

for any $\lambda > 0$. Moreover, \mathcal{S} is related to \mathcal{L} and \mathcal{J} as follows:

(1.8)
$$S = \mathfrak{m}t\mathcal{L} + \mathcal{J}\partial_x + 1.$$

We introduce the norm with respect to the spatial variable as follows:

$$\|u(t)\|_X := \left(\|u(t)\|_{H^{\frac{\mathfrak{m}-1}{2\mathfrak{m}}}}^2 + \|\Lambda u(t)\|_{L^2}^2\right)^{\frac{1}{2}}.$$

We note that

$$||u_0||_X \sim ||u_0||_{H^{\frac{m-1}{2m}}} + ||xu_0||_{L^2} \sim ||u_0||_{\Sigma^{\frac{m-1}{2m}}}.$$

Well-posedness in X follows from a similar argument as in [19].

Proposition 1.4. Let $\mathfrak{m} \geq 4$. If $u_0 \in \Sigma^{\frac{\mathfrak{m}-1}{2\mathfrak{m}}}(\mathbb{R})$, then there exists a time $T = T(\|u_0\|_{\Sigma^{\frac{\mathfrak{m}-1}{2\mathfrak{m}}}}) > 0$ and a unique solution $u \in C([-T,T];X)$ to (1.1) satisfying

$$\sup_{t \in [-T,T]} \|u(t)\|_{X} \lesssim \|u_0\|_{\Sigma^{\frac{m-1}{2m}}}.$$

Moreover, the flow map $u_0 \in \Sigma^{\frac{m-1}{2m}}(\mathbb{R}) \mapsto u \in C([-T,T];X)$ is locally Lipschitz continuous.

We give a proof of this well-posedness result in Appendix A.

Remark 1.5. Because (1.8) implies

(1.9)
$$\mathcal{J}u = \Lambda u - \mathfrak{m}t\partial_x^{-1}\mathcal{L}u = \Lambda u - \mathfrak{m}tu^{\mathfrak{m}},$$

the regularity $u_0 \in H^{\frac{m-1}{2m}}(\mathbb{R})$ ensures $\mathcal{J}u \in C([-T,T];L^2(\mathbb{R}))$, which is equivalent to $\mathcal{U}(-t)u \in C([-T,T];\Sigma^0(\mathbb{R}))$.

For initial data u_0 with $||u_0||_{\Sigma^{\frac{m-1}{2m}}} \ll 1$, we can find an existence time T > 1 and a unique solution $u \in C([-T,T];X)$ to (1.1). Moreover, Proposition 1.4 says that the existence of a global solution $u \in C(\mathbb{R};X)$ follows from the decay estimate (1.4).

Because (1.1) is time reversal invariant, it suffices to consider the case $t \geq 0$. We then make the bootstrap assumption that u satisfies the linear pointwise estimates: there exists a constant D with $1 \ll D \ll \varepsilon^{-\frac{1}{2}}$ such that

for $t \in [1, T]$ and $k = 0, 1, ..., \mathfrak{m} - 2$.

In §2, under this assumption, for $\varepsilon > 0$ sufficiently small, we have the energy estimate

$$\sup_{0 \le t \le T} \|u(t)\|_X \le C\varepsilon \langle T \rangle^{\varepsilon},$$

where C is a constant independent of D and T. To complete the proof of global existence, we need to close the bootstrap estimate (1.10).

In §3, we prove decay estimates in $L^{\infty}(\mathbb{R})$ and $L^{2}(\mathbb{R})$ that allow us to reduce closing the bootstrap argument to considering the behavior of u along the ray Γ_{v} . We also observe that (1.10) holds true at t=1.

To close the bootstrap argument, we use the method of testing by wave packets as in [5, 6, 15, 25]. Here, a wave packet is an approximate solution localized in both space and frequency on the scale of the uncertainty principle. Our main task in §4 is to construct a wave packet $\Psi_v(t,x)$ to the corresponding linear equation and observe its properties. Here, to show that $\Psi_v(t,x)$ is a good approximate solution to the linear solution, we use the fact that \mathbf{m} is a natural number. Because $\Psi_v(t,x)$ is essentially frequency localized near $\xi_v = v^{\frac{1}{\mathbf{m}-1}}$ (see Lemma 4.1), the linear operator \mathcal{L} acts on Ψ_v as $\partial_t + i(-i\partial_x)^{\mathbf{m}}$. Hence, we can avoid applying the nonlocal operator $|\partial_x|$ directly in the calculation of $\mathcal{L}\Psi_v$ (see (4.9)).

To observe decay of u along the ray Γ_v , we use the function

$$\gamma(t,v) := \int_{\mathbb{R}} u(t,x) \overline{\Psi_v(t,x)} dx.$$

In §4, we also prove that γ is a reasonable approximation of u. We then reduce closing the bootstrap estimate (1.10) to proving global bounds for γ .

In §5, we show that γ is the leading asymptotic term of u in $\mathfrak{X}^+(t)$. Moreover, we prove existence of a solution Q to (1.5).

1.3. **Notation.** We summarize the notation used throughout this paper. We set $\mathbb{N}_0 := \mathbb{N} \cup \{0\}$. We denote the space of all rapidly decaying functions on \mathbb{R} by $\mathcal{S}(\mathbb{R})$. We define the Fourier transform of f by $\mathcal{F}[f]$ or \widehat{f} .

In estimates, we use C to denote a positive constant that can change from line to line. If C is absolute or depends only on parameters that are considered fixed, then we often write $X \lesssim Y$, which means $X \leq CY$. When an implicit constant depends on a parameter a, we sometimes write $X \lesssim_a Y$. We define $X \ll Y$ to mean $X \leq C^{-1}Y$ and $X \sim Y$ to mean $C^{-1}Y \leq X \leq CY$. We write X = Y + O(Z) when $|X - Y| \lesssim Z$.

Let σ be a smooth even function with $0 \le \sigma \le 1$ and $\sigma(\xi) = \begin{cases} 1, & \text{if } |\xi| \le 1, \\ 0, & \text{if } |\xi| \ge 2. \end{cases}$ For any $R, R_1, R_2 > 0$ with $R_1 < R_2$, we set

$$\begin{split} \sigma_{\leq R}(\xi) := \sigma\left(\frac{\xi}{R}\right), \quad \sigma_{>R}(\xi) := 1 - \sigma_{\leq R}(\xi), \\ \sigma_{< R}(\xi) := \sigma_{\leq \frac{R}{2}}(\xi), \quad \sigma_{\geq R}(\xi) := 1 - \sigma_{< R}(\xi), \quad \sigma_{R}(\xi) := \sigma_{\leq R}(\xi) - \sigma_{< R}(\xi), \\ \sigma_{R_1 \leq \cdot \leq R_2}(\xi) := \sigma_{\leq R_2}(\xi) - \sigma_{< R_1}(\xi), \quad \sigma_{R_1 < \cdot < R_2}(\xi) := \sigma_{< R_2}(\xi) - \sigma_{\leq R_1}(\xi). \end{split}$$

For any $N, N_1, N_2 \in 2^{\mathbb{Z}}$ with $N_1 < N_2$, we define

$$P_N f := \mathcal{F}^{-1}[\sigma_N \widehat{f}], \quad P_{N_1 \le \cdot \le N_2} f := \mathcal{F}^{-1}[\sigma_{N_1 \le \cdot \le N_2} \widehat{f}].$$

We denote the characteristic function of an interval I by $\mathbf{1}_I$. For $N \in 2^{\mathbb{Z}}$, we define

$$P^{\pm}f := \mathcal{F}^{-1}[\mathbf{1}_{\mathbb{R}_{\pm}}\widehat{f}], \quad P_N^{\pm} := P^{\pm}P_N.$$

2. Energy estimates

We show energy estimates for solutions u to (1.1) under (1.10).

Lemma 2.1. Assume $\mathfrak{m} \geq 4$. Let u be a solution to (1.1) in a time interval [0,T] satisfying

$$||u_0||_{\Sigma^{\frac{\mathfrak{m}-1}{2\mathfrak{m}}}} \leq \varepsilon \ll 1$$

and (1.10). Then,

$$||u(t)||_X \lesssim \varepsilon \langle t \rangle^{\varepsilon},$$

where the implicit constant is independent of D, T, and ε .

To treat the fractional derivatives, we use the Kato-Ponce commutator estimate (see [16, 19]):

Lemma 2.2. For 0 < s < 1, we have

$$\||\partial_x|^s(fg) - f|\partial_x|^sg\|_{L^2} \lesssim \||\partial_x|^sf\|_{L^2}\|g\|_{L^\infty}.$$

Proof of Lemma 2.1. Because the desired bound for $0 \le t \le 1$ follows from Proposition 1.4, we consider the case $t \ge 1$.

Integration by parts yields

$$\frac{1}{2}\partial_t \|u(t)\|_{L^2}^2 = \int_{\mathbb{R}} \partial_x (u^{\mathfrak{m}}) u dx = 0.$$

By Lemma 2.2 and (1.10), we have

$$\begin{split} &\frac{1}{2}\partial_{t}\left\|\left|\partial_{x}\right|^{\frac{m-1}{2m}}u(t)\right\|_{L^{2}}^{2}\\ &=\mathfrak{m}\int_{\mathbb{R}}\left|\partial_{x}\right|^{\frac{m-1}{2m}}u\cdot\left|\partial_{x}\right|^{\frac{m-1}{2m}}(u^{\mathfrak{m}-1}\partial_{x}u)dx\\ &=\mathfrak{m}\int_{\mathbb{R}}\left|\partial_{x}\right|^{\frac{m-1}{2m}}u\cdot u^{\mathfrak{m}-1}\left|\partial_{x}\right|^{\frac{m-1}{2m}}\partial_{x}udx+O\left(\left\|u(t)\right\|_{H^{\frac{m-1}{2m}}}^{2}\left\|u(t)\right\|_{L^{\infty}}^{\mathfrak{m}-2}\left\|\partial_{x}u(t)\right\|_{L^{\infty}}\right)\\ &=-\frac{\mathfrak{m}(\mathfrak{m}-1)}{2}\int_{\mathbb{R}}u^{\mathfrak{m}-2}\partial_{x}u\left(\left|\partial_{x}\right|^{\frac{m-1}{2m}}u\right)^{2}dx+O\left(\left(D\varepsilon\right)^{\mathfrak{m}-1}t^{-1}\left\|u(t)\right\|_{H^{\frac{m-1}{2m}}}^{2}\right)\\ &\lesssim \left(D\varepsilon\right)^{\mathfrak{m}-1}t^{-1}\left\|u(t)\right\|_{H^{\frac{m-1}{2m}}}^{2}. \end{split}$$

From $[|\partial_x|^{\mathfrak{m}-1}\partial_x, x] = \mathfrak{m}|\partial_x|^{\mathfrak{m}-1}$, a simple calculation yields

$$[\mathcal{L}, \mathcal{S}] = \mathfrak{m}\mathcal{L}, \quad [\mathcal{S}, \partial_x] = -\partial_x,$$

which imply that for solutions u to (1.1)

(2.1)
$$\mathcal{L}\Lambda u = \partial_x^{-1} (\mathcal{S} + \mathfrak{m}) \mathcal{L} u = \mathfrak{m} u^{\mathfrak{m} - 1} \partial_x \Lambda u.$$

From (2.1), integration by parts, and (1.10), we obtain

$$\frac{1}{2}\partial_t \|\Lambda u(t)\|_{L^2}^2 = -\frac{\mathfrak{m}(\mathfrak{m}-1)}{2} \int_{\mathbb{R}} u^{\mathfrak{m}-2} \partial_x u(\Lambda u)^2 dx \lesssim (D\varepsilon)^{\mathfrak{m}-1} t^{-1} \|\Lambda u(t)\|_{L^2}^2.$$

From $(D\varepsilon)^{\mathfrak{m}-1} \ll \varepsilon$, Gronwall's inequality with the above estimates implies

$$||u(t)||_X \le 10||u(1)||_X t^{\varepsilon} \lesssim \varepsilon t^{\varepsilon}.$$

We define the auxiliary space

$$||u(t)||_{\widetilde{X}} := ||\mathcal{J}u(t)||_{L^2} + t^{\frac{1}{m}} ||\langle t^{\frac{1}{m}} \partial_x \rangle^{-1} u(t)||_{L^2}.$$

Lemma 2.3. Let u be a solution to (1.1) which satisfies $||u_0||_{\Sigma^{\frac{m-1}{2m}}} \le \varepsilon \ll 1$ and (1.10). Then, for $t \ge 1$, we have

$$||u(t)||_{\widetilde{X}} \lesssim \varepsilon t^{\frac{1}{2\mathfrak{m}}},$$

where the implicit constant is independent of D, T, and ε

Proof. By (1.10), we see that

$$||u^{\mathfrak{m}}||_{L^{2}} \leq (D\varepsilon)^{\mathfrak{m}} t^{-1} \left(\int_{|x| \leq t^{\frac{1}{\mathfrak{m}}}} dx + \int_{|x| \geq t^{\frac{1}{\mathfrak{m}}}} \left(t^{-\frac{1}{\mathfrak{m}}} |x| \right)^{-\mathfrak{m} \frac{\mathfrak{m}-2}{\mathfrak{m}-1}} dx \right)^{\frac{1}{2}} \leq \varepsilon t^{-1 + \frac{1}{2\mathfrak{m}}}.$$

From (1.9) and Lemma 2.1, we therefore have

$$\|\mathcal{J}u(t)\|_{L^2} \lesssim \|\Lambda u(t)\|_{L^2} + t \|u^{\mathfrak{m}}\|_{L^2} \lesssim \varepsilon t^{\frac{1}{2\mathfrak{m}}}.$$

We use a self-similar change of variables by defining

(2.2)
$$U(t,y) := t^{\frac{1}{m}} u(t, t^{\frac{1}{m}} y).$$

A direct calculation shows

(2.3)
$$\partial_t U(t,y) = \frac{1}{\mathfrak{m}} t^{-1 + \frac{1}{\mathfrak{m}}} (\mathcal{S}u)(t, t^{\frac{1}{\mathfrak{m}}}y) = \frac{1}{\mathfrak{m}} t^{-1} \partial_y \left((\Lambda u)(t, t^{\frac{1}{\mathfrak{m}}}y) \right).$$

Hence, we have

(2.4)
$$\partial_t \|\langle \partial_y \rangle^{-1} U(t) \|_{L^2_y} \lesssim t^{-1 - \frac{1}{2\mathfrak{m}}} \|\Lambda u(t)\|_{L^2_x} \lesssim \varepsilon t^{-1 - \frac{1}{2\mathfrak{m}} + \varepsilon}.$$

By integrating this with respect to t, we have

$$\|\langle \partial_y \rangle^{-1} U(t) \|_{L^2_y} \lesssim \varepsilon.$$

From
$$\|\langle \partial_y \rangle^{-1} U(t)\|_{L^2_y} = t^{\frac{1}{2\mathfrak{m}}} \|\langle t^{\frac{1}{\mathfrak{m}}} \partial_x \rangle^{-1} u(t)\|_{L^2}$$
, we obtain the desired bound. \square

Remark 2.4. The estimate $||u(t)||_{\widetilde{X}} \lesssim \varepsilon$ for 0 < t < 1 holds true. Indeed, by Proposition 1.4, Remark 1.5, and a sufficiently small value of $\varepsilon > 0$, we have

$$\sup_{0 \le t \le 1} \|u(t)\|_{\widetilde{X}} \lesssim \sup_{0 \le t \le 1} (\|\Lambda u(t)\|_{L^{2}} + \|u(t)^{\mathfrak{m}}\|_{L^{2}} + \|u(t)\|_{L^{2}})$$
$$\lesssim \sup_{0 \le t \le 1} (\|u(t)\|_{X} + \|u(t)\|_{X}^{\mathfrak{m}})$$
$$\lesssim \varepsilon.$$

3. Decay estimates

In this section, we prove a number of estimates for u without assuming (1.10). We divide u into two parts on which \mathcal{J} acts hyperbolically and elliptically. For simplicity, we use the following notation:

$$u_N := P_N u, \quad u^{\pm} := P^{\pm} u, \quad u_N^+ := P_N^+ u.$$

Since $\mathcal{J}u_N = P_N(\mathcal{J}u) + i\mathcal{F}^{-1}[\partial_{\xi}\sigma_N\widehat{u}]$ and u is real valued, we have

$$(3.1) \|u(t)\|_{\widetilde{X}} \sim \left(\left\| u_{\leq t^{-\frac{1}{\mathfrak{m}}}}(t) \right\|_{\widetilde{X}}^{2} + \sum_{\substack{N \in 2^{\mathbb{Z}} \\ N > t^{-\frac{1}{\mathfrak{m}}}}} \left\| u_{N}^{+}(t) \right\|_{\widetilde{X}}^{2} \right)^{\frac{1}{2}}, \quad u_{\leq t^{-\frac{1}{\mathfrak{m}}}} := \sum_{\substack{N \in 2^{\mathbb{Z}} \\ N < t^{-\frac{1}{\mathfrak{m}}}}} u_{N}.$$

For $t \ge 1$ and $N > t^{-\frac{1}{m}}$, we define the hyperbolic and elliptic parts of u_N^+ as follows:

$$u_N^{\text{hyp},+} := \sigma_N^{\text{hyp}} u_N^+, \quad u_N^{\text{ell},+} := u_N^+ - u_N^{\text{hyp},+},$$

where $\sigma_N^{\text{hyp}}(t,x) := \sigma_{\frac{1}{\kappa}tN^{\mathfrak{m}-1} \leq \cdot \leq \kappa tN^{\mathfrak{m}-1}}(x)\mathbf{1}_{\mathbb{R}_+}(x)$ and $\kappa := 2^{2\mathfrak{m}+3}$. This large constant κ is needed to show (3.6) in Lemma 3.3 below. Moreover, we define

$$u^{\mathrm{hyp},+} = \sum_{\substack{N \in 2^{\mathbb{Z}} \\ N > t^{-\frac{1}{\mathfrak{m}}}}} u_N^{\mathrm{hyp},+}, \quad u^{\mathrm{ell}} = u - 2\Re u^{\mathrm{hyp},+}.$$

We note that $u^{\text{hyp},+}$ is supported in $\{x \in \mathbb{R}_+ \colon t^{-\frac{1}{\mathfrak{m}}}x \geq \frac{1}{2\kappa}\}$. For $(t,x) \in \mathbb{R}^2$ with $t^{-\frac{1}{\mathfrak{m}}}|x| \geq \frac{1}{2\kappa}$, the number of dyadic numbers $N \in 2^{\mathbb{Z}}$ satisfying $\frac{1}{2\kappa}tN^{\mathfrak{m}-1} \leq |x| \leq 2\kappa tN^{\mathfrak{m}-1}$ is less than 10. Hence, $u^{\text{hyp},+}(t,x)$ is a finite sum of $u^{\text{hyp},+}_N(t,x)$'s.

(3.2)
$$\left\| \left(1 - P_{\frac{N}{2} \le \cdot \le 2N}^+ \right) |\partial_x|^a \left(|x|^b u_N^{\text{hyp},+} \right) \right\|_{L^2} \lesssim_{a,b,c} t^{-\frac{a-b}{\mathfrak{m}}} \left(t^{\frac{1}{\mathfrak{m}}} N \right)^{-c} \|u_N\|_{L^2},$$

(3.3)
$$\left\| \left(1 - P_{\frac{N}{2} \le \cdot \le 2N}^{+} \right) |\partial_{x}|^{a} u_{N}^{\text{ell},+} \right\|_{L^{2}} \lesssim_{a,c,n} t^{-\frac{a}{\mathfrak{m}}} \left(t^{\frac{1}{\mathfrak{m}}} N \right)^{-c} \|u_{N}\|_{L^{2}},$$

(3.4)

$$\left\| \left(1 - P_{\frac{N}{2} \le \cdot \le 2N}^+ \right) |\partial_x|^a \left(|x|^b \sigma_{> t^{\frac{1}{\mathfrak{m}}}}(x) u_N^{\mathrm{ell},+} \right) \right\|_{L^2} \lesssim_{a,b,c} t^{-\frac{a-b}{\mathfrak{m}}} \left(t^{\frac{1}{\mathfrak{m}}} N \right)^{-c} \|u_N\|_{L^2}.$$

These estimates are consequences of the following lemma (see, for example, [24, 25]):

Lemma 3.1. For $2 \le p \le \infty$, any $a, b, c \in \mathbb{R}$ with $a \ge 0$ and $a + c \ge 0$, and any R > 0, we have

$$\left\| \left(1 - P_{\frac{N}{2} \le \cdot \le 2N}^{+} \right) |\partial_{x}|^{a} (|x|^{b} \sigma_{R} P_{N}^{+} f) \right\|_{L^{p}} \lesssim_{a,b,c} N^{-c + \frac{1}{2} - \frac{1}{p}} R^{-a + b - c} \|P_{N}^{+} f\|_{L^{2}}.$$

Moreover, we may replace σ_R on the left hand side by $\sigma_{>R}$ if a+c>b+1 and by $\sigma_{< R}$ if $a+c\geq 0$ and b=0.

3.1. Frequency localized estimates. Since

$$\mathcal{J}u^{+} = \left(x - t(-i\partial_{x})^{\mathfrak{m}-1}\right)u^{+},$$

by factorizing out the term $x - t\xi^{\mathfrak{m}-1}$, we define

$$\mathcal{J}_{+} := |x|^{\frac{1}{\mathfrak{m}-1}} + it^{\frac{1}{\mathfrak{m}-1}} \partial_{x}, \quad \mathcal{J}_{-} := \sum_{j=0}^{\mathfrak{m}-2} |x|^{\frac{\mathfrak{m}-2-j}{\mathfrak{m}-1}} \left(-it^{\frac{1}{\mathfrak{m}-1}} \partial_{x} \right)^{j}.$$

These operators are useful in our analysis.

We begin with the following preliminary observation.

Lemma 3.2. Let a be a real number and let g be a (\mathbb{C} -valued) smooth function supported in \mathbb{R}_+ or \mathbb{R}_- . For any integer k > 0, the following equations hold:

$$\Re \int_{\mathbb{R}_{\pm}} |x|^{a} g(x) \overline{\partial_{x}^{2k-1} g(x)} dx = \sum_{l=1}^{k} C_{2k-1,l}^{a,\pm} \int_{\mathbb{R}_{\pm}} \left| |x|^{\frac{a+1}{2}-l} \partial_{x}^{k-l} g(x) \right|^{2} dx,$$

$$\Re \int_{\mathbb{R}_{\pm}} |x|^{a} g(x) \overline{\partial_{x}^{2k} g(x)} dx = \sum_{l=0}^{k} C_{2k,l}^{a,\pm} \int_{\mathbb{R}_{\pm}} \left| |x|^{\frac{a}{2}-l} \partial_{x}^{k-l} g(x) \right|^{2} dx,$$

$$\Im \int_{\mathbb{R}_{\pm}} |x|^{a} g(x) \overline{\partial_{x}^{2k-1} g(x)} dx = \sum_{l=0}^{k-1} D_{2k-1,l}^{a,\pm} \int_{\mathbb{R}} \xi \left| \mathcal{F} \left[|\cdot|^{\frac{a}{2}-l} \partial_{x}^{k-1-l} g \right] (\xi) \right|^{2} d\xi,$$

$$\Im \int_{\mathbb{R}_{\pm}} |x|^{a} g(x) \overline{\partial_{x}^{2k} g(x)} dx = \sum_{l=1}^{k} D_{2k,l}^{a,\pm} \int_{\mathbb{R}} \xi \left| \mathcal{F} \left[|\cdot|^{\frac{a+1}{2}-l} \partial_{x}^{k-l} g \right] (\xi) \right|^{2} d\xi,$$

where $C_{k,l}^{a,\pm}$ and $D_{k,l}^{a,\pm}$ are real constants depending on a, k, and l. In particular, $C_{2k,0}^{a,\pm} = D_{2k-1,0}^{a,\pm} = (-1)^k$.

Proof. For k = 1, integration by parts yields

$$\begin{split} &\Re \int_{\mathbb{R}_{\pm}} |x|^a g(x) \overline{\partial_x g(x)} dx = \mp \frac{a}{2} \int_{\mathbb{R}_{\pm}} \left| |x|^{\frac{a-1}{2}} g(x) \right|^2 dx, \\ &\Re \int_{\mathbb{R}_{\pm}} |x|^a g(x) \overline{\partial_x^2 g(x)} dx \\ &= -\Re \int_{\mathbb{R}_{\pm}} \left(|x|^a \partial_x g(x) \pm a |x|^{a-1} g(x) \right) \overline{\partial_x g(x)} dx \\ &= - \int_{\mathbb{R}_{+}} \left| |x|^{\frac{a}{2}} |\partial_x g(x)|^2 dx + \frac{1}{2} a (a-1) \int_{\mathbb{R}_{+}} \left| |x|^{\frac{a}{2}-1} g(x)|^2 dx. \end{split}$$

Similarly, we have

$$\Im \int_{\mathbb{R}_{\pm}} |x|^{a} g(x) \overline{\partial_{x} g(x)} dx = \Im \int_{\mathbb{R}_{\pm}} |x|^{\frac{a}{2}} g(x) \overline{\partial_{x} \left(|\cdot|^{\frac{a}{2}} g\right)(x)} dx$$

$$= -\int_{\mathbb{R}} \xi \left| \mathcal{F} \left[|\cdot|^{\frac{a}{2}} g\right](\xi) \right|^{2} d\xi,$$

$$\Im \int_{\mathbb{R}_{\pm}} |x|^{a} g(x) \overline{\partial_{x}^{2} g(x)} dx = -\Im \int_{\mathbb{R}_{\pm}} \left(|x|^{a} \partial_{x} g(x) \pm a |x|^{a-1} g(x)\right) \overline{\partial_{x} g(x)} dx$$

$$= \pm a \int_{\mathbb{R}} \xi \left| \mathcal{F} \left[|\cdot|^{\frac{a-1}{2}} g\right](\xi) \right|^{2} d\xi.$$

Hence, the equations hold when k=1 with $C_{1,1}^{a,\pm}=\mp\frac{a}{2},\ C_{2,0}^{a,\pm}=-1,\ C_{2,1}^{a,\pm}=\frac{1}{2}a(a-1),\ D_{1,0}^{a,\pm}=-1,$ and $D_{2,1}^{a,\pm}=\pm a.$ Next, we assume that these equalities hold up to k-1. Integration by parts

$$\left\|t|\partial_x|^{\mathfrak{m}-1}\left(\sigma_{\leq \frac{1}{\kappa}tN^{\mathfrak{m}-1}}u_N^{\mathrm{ell},+}(t)\right)\right\|_{L^2}\lesssim \|u_N(t)\|_{\widetilde{X}}.$$

From

$$\int_{\mathbb{R}} tx \left| \partial_x^{\frac{\mathfrak{m}}{2}+1} \left(\sigma_{\frac{1}{\kappa}tN^{\mathfrak{m}-1} < \cdot < \kappa tN^{\mathfrak{m}-1}}(x) u_N^{\mathrm{ell},+}(t,x) \right) \right|^2 dx < 0,$$

taking $f = \sigma_{\frac{1}{L}tN^{\mathfrak{m}-1} < \cdot < \kappa tN^{\mathfrak{m}-1}} u_N^{\mathrm{ell},+}$ in (3.9), we have

$$tN^{\mathfrak{m}-1} \left\| \sigma_{\frac{1}{\kappa}tN^{\mathfrak{m}-1} < \cdot < \kappa tN^{\mathfrak{m}-1}} u_N^{\mathrm{ell},+}(t) \right\|_{L^2} \lesssim \|u_N(t)\|_{\widetilde{X}}. \qquad \Box$$

3.2. **Decay estimates in** $L^2(\mathbb{R})$ **and** $L^{\infty}(\mathbb{R})$ **.** First, by summing up the frequency localized estimates, we show the L^2 -estimates.

Corollary 3.4. For $t \geq 1$, we have

(3.10)
$$\sum_{k=0}^{\mathfrak{m}-2} \sum_{l=0}^{k} \left\| t^{\frac{k+1}{\mathfrak{m}-1}} |x|^{-\frac{\mathfrak{m}k+1}{\mathfrak{m}-1}+l} \partial_x^l u^{\text{hyp},+} \right\|_{L^2} \lesssim \|u(t)\|_{\widetilde{X}},$$

(3.11)
$$\sum_{k=0}^{\mathfrak{m}-2} \left\| t^{\frac{k}{\mathfrak{m}-1}} |x|^{-\frac{k-\mathfrak{m}+2}{\mathfrak{m}-1}} \mathcal{J}_{+} \partial_{x}^{k} u^{\text{hyp},+} \right\|_{L^{2}} \lesssim \|u(t)\|_{\widetilde{X}},$$

(3.12)
$$\sum_{k=0}^{\mathfrak{m}-2} \left\| t^{\frac{k+1}{\mathfrak{m}}} \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{-\frac{k}{\mathfrak{m}-1}+1} \partial_x^k u^{\text{ell}} \right\|_{L^2} \lesssim \|u(t)\|_{\widetilde{X}}.$$

Proof. By (3.1) and (3.2), we have

$$\begin{split} &\sum_{k=0}^{\mathfrak{m}-2} \sum_{l=0}^{k} \left\| t^{\frac{k+1}{\mathfrak{m}-1}} |x|^{-\frac{\mathfrak{m}k+1}{\mathfrak{m}-1}+l} \partial_{x}^{l} u^{\mathrm{hyp},+} \right\|_{L^{2}} \\ &\lesssim \sum_{k=0}^{\mathfrak{m}-2} \sum_{l=0}^{k} \left(\sum_{N \in 2^{\mathbb{Z}}} \left\| t^{\frac{k+1}{\mathfrak{m}-1}} |x|^{-\frac{\mathfrak{m}k+1}{\mathfrak{m}-1}+l} \partial_{x}^{l} u_{N}^{\mathrm{hyp},+}(t) \right\|_{L^{2}}^{2} \right)^{\frac{1}{2}} \\ &+ \sum_{k=0}^{\mathfrak{m}-2} \sum_{l=0}^{k} \sum_{N \in 2^{\mathbb{Z}}} \left\| \left(1 - P_{\frac{N}{2} \le \cdot \le 2N} \right) t^{\frac{k+1}{\mathfrak{m}-1}} |x|^{-\frac{\mathfrak{m}k+1}{\mathfrak{m}-1}+l} \partial_{x}^{l} u_{N}^{\mathrm{hyp},+} \right\|_{L^{2}} \\ &\lesssim \sum_{k=0}^{\mathfrak{m}-2} \sum_{l=0}^{k} \left(\sum_{N \in 2^{\mathbb{Z}}} \left\| t^{-k+l} N^{-\mathfrak{m}k+(\mathfrak{m}-1)l-1} \partial_{x}^{l} u_{N}^{\mathrm{hyp},+}(t) \right\|_{L^{2}}^{2} \right)^{\frac{1}{2}} + \| u(t) \|_{\widetilde{X}} \\ &\lesssim \| u(t) \|_{\widetilde{X}}. \end{split}$$

We use (3.1), (3.2), and (3.5) to obtain

$$\begin{split} &\sum_{k=0}^{\mathfrak{m}-2} \left\| t^{\frac{k}{\mathfrak{m}-1}} |x|^{-\frac{k-\mathfrak{m}+2}{\mathfrak{m}-1}} \partial_{x}^{k} \mathcal{J}_{+} u^{\mathrm{hyp},+} \right\|_{L^{2}} \\ &\lesssim \sum_{k=0}^{\mathfrak{m}-2} \left(\sum_{N \in 2^{\mathbb{Z}}} \left\| t^{\frac{k}{\mathfrak{m}-1}} |x|^{-\frac{k-\mathfrak{m}+2}{\mathfrak{m}-1}} \partial_{x}^{k} \mathcal{J}_{+} u_{N}^{\mathrm{hyp},+}(t) \right\|_{L^{2}}^{2} \right)^{\frac{1}{2}} \\ &+ \sum_{k=0}^{\mathfrak{m}-2} \sum_{N \in 2^{\mathbb{Z}}} \left\| \left(1 - P_{\frac{N}{2} \le \cdot \le 2N} \right) t^{\frac{k}{\mathfrak{m}-1}} |x|^{-\frac{k-\mathfrak{m}+2}{\mathfrak{m}-1}} \partial_{x}^{k} \mathcal{J}_{+} u_{N}^{\mathrm{hyp},+}(t) \right\|_{L^{2}} \\ &\lesssim \|u(t)\|_{\widetilde{Y}}. \end{split}$$

This gives (3.11) with k = 0. For $k \ge 1$, because

$$\begin{split} &\mathcal{J}_{+}\partial_{x}^{k}u^{\text{hyp},+} \\ &= \partial_{x}^{k}\left(\mathcal{J}_{+}u^{\text{hyp},+}\right) + t^{-\frac{k}{\mathfrak{m}-1}}|x|^{\frac{k-\mathfrak{m}+2}{\mathfrak{m}-1}} \sum_{l=0}^{k-1} C_{k,l}t^{\frac{(k-1)+1}{\mathfrak{m}-1}}|x|^{-\frac{\mathfrak{m}(k-1)+1}{\mathfrak{m}-1}+l}\partial_{x}^{l}u^{\text{hyp},+}, \end{split}$$

the estimate (3.11) follows from (3.5) and (3.10). For the elliptic bound, we note that

(3.13)
$$u^{\text{ell}} = u_{\leq t^{-\frac{1}{\mathfrak{m}}}} + 2\Re \sum_{\substack{N \in 2^{\mathbb{Z}} \\ N > t^{-\frac{1}{\mathfrak{m}}}}} u_N^{\text{ell},+}.$$

We use (3.1), (3.3), and (3.6) to obtain

$$\begin{split} \sum_{k=0}^{\mathfrak{m}-2} \left\| t^{\frac{k+1}{\mathfrak{m}}} \partial_x^k u^{\text{ell}} \right\|_{L^2} &\lesssim t^{\frac{1}{\mathfrak{m}}} \| u_{\leq t^{-\frac{1}{\mathfrak{m}}}} \|_{L^2} + \sum_{k=0}^{\mathfrak{m}-2} \left(\sum_{N \in 2^{\mathbb{Z}} \\ N > t^{-\frac{1}{\mathfrak{m}}}} \left(t^{\frac{k+1}{\mathfrak{m}}} N^k \left\| u_N^{\text{ell},+} \right\|_{L^2} \right)^2 \right)^{\frac{1}{2}} \\ &+ \sum_{k=0}^{\mathfrak{m}-2} \sum_{N \in 2^{\mathbb{Z}} \\ N > t^{-\frac{1}{\mathfrak{m}}}} t^{\frac{k+1}{\mathfrak{m}}} \left\| \left(1 - P_{\frac{N}{2} \leq \cdot \leq 2N} \right) \partial_x^k u_N^{\text{ell},+} \right\|_{L^2} \\ &\lesssim \| u(t) \|_{\widetilde{X}}. \end{split}$$

From $t^{\frac{k}{\mathfrak{m}-1}}|x|^{-\frac{k}{\mathfrak{m}-1}+1}N^k\lesssim |x|+tN^{\mathfrak{m}-1}$ and (3.4), we have

$$\begin{split} t^{\frac{k}{\mathfrak{m}-1}} \left\| |x|^{-\frac{k}{\mathfrak{m}-1}+1} \partial_x^k u_N^{\mathrm{ell},+} \right\|_{L^2(|x| \geq t^{\frac{1}{\mathfrak{m}}})} &\lesssim N^{-k} \left\| (|x| + t N^{\mathfrak{m}-1}) \sigma_{>t^{\frac{1}{\mathfrak{m}}}}(x) \partial_x^k u_N^{\mathrm{ell},+} \right\|_{L^2} \\ &\lesssim \left\| (|x| + t N^{\mathfrak{m}-1}) u_N^{\mathrm{ell},+} \right\|_{L^2} + t^{-\frac{1}{\mathfrak{m}}} N^{-2} \|u_N\|_{L^2}. \end{split}$$

Because

$$\begin{split} t^{\frac{k}{\mathfrak{m}-1}} \Big\| |x|^{-\frac{k}{\mathfrak{m}-1}+1} \partial_x^k u_{\leq t^{-\frac{1}{\mathfrak{m}}}} \Big\|_{L^2(|x| \geq t^{\frac{1}{\mathfrak{m}}})} &\lesssim t^{\frac{k}{\mathfrak{m}}} \Big\| x \partial_x^k u_{\leq t^{-\frac{1}{\mathfrak{m}}}} \Big\|_{L^2(|x| \geq t^{\frac{1}{\mathfrak{m}}})} \\ &\lesssim \Big\| \mathcal{J} u_{\leq t^{-\frac{1}{\mathfrak{m}}}} \Big\| + t^{\frac{1}{\mathfrak{m}}} \Big\| u_{\leq t^{-\frac{1}{\mathfrak{m}}}} \Big\|_{L^2} \\ &\lesssim \|u(t)\|_{\widetilde{X}}, \end{split}$$

by (3.1), (3.4), and (3.6), we obtain

$$\begin{split} & \left\| t^{\frac{k+1}{\mathfrak{m}}} (t^{-\frac{1}{\mathfrak{m}}} |x|)^{-\frac{k}{\mathfrak{m}-1}+1} \partial_x^k u^{\text{ell}} \right\|_{L^2(|x| \geq t^{\frac{1}{\mathfrak{m}}})} \\ & \lesssim \| u(t) \|_{\widetilde{X}} + \left(\sum_{\substack{N \in 2^{\mathbb{Z}} \\ N > t^{-\frac{1}{\mathfrak{m}}}}} \left\| (|x| + t N^{\mathfrak{m}-1}) u_N^{\text{ell},+} \right\|_{L^2}^2 \right)^{\frac{1}{2}} + \sum_{\substack{N \in 2^{\mathbb{Z}} \\ N > t^{-\frac{1}{\mathfrak{m}}}}} t^{-\frac{1}{\mathfrak{m}}} N^{-2} \| u_N \|_{L^2} \\ & + \sum_{\substack{N \in 2^{\mathbb{Z}} \\ N > t^{-\frac{1}{\mathfrak{m}}}}} \left\| \left(1 - P_{\frac{N}{2} \leq \cdot \leq 2N} \right) t^{\frac{k+1}{\mathfrak{m}}} (t^{-\frac{1}{\mathfrak{m}}} |x|)^{-\frac{k}{\mathfrak{m}-1}+1} \sigma_{>t^{\frac{1}{\mathfrak{m}}}}(x) \partial_x^k u_N^{\text{ell},+} \right\|_{L^2} \\ & \lesssim \| u(t) \|_{\widetilde{Y}}. \end{split}$$

Second, we show the pointwise decay estimates.

Proposition 3.5. For $t \ge 1$ and $k = 0, 1, ..., \mathfrak{m} - 2$, we have

$$\left|t^{\frac{k+1}{\mathfrak{m}}}\langle t^{-\frac{1}{\mathfrak{m}}}x\rangle^{-\frac{k}{\mathfrak{m}-1}+\frac{\mathfrak{m}-3}{2(\mathfrak{m}-1)}}\partial_x^ku^{\mathrm{hyp},+}(t,x)\right|\lesssim t^{-\frac{1}{2\mathfrak{m}}}\|u(t)\|_{\widetilde{X}},$$

$$\left| t^{\frac{k+1}{\mathfrak{m}}} \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{-\frac{k}{\mathfrak{m}-1} + \frac{2\mathfrak{m}-3}{2(\mathfrak{m}-1)}} \partial_x^k u^{\mathrm{ell}}(t,x) \right| \lesssim t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}}.$$

Proof. The Gagliardo-Nirenberg inequality

$$|f| \lesssim ||f||_{L^2}^{\frac{1}{2}} ||\partial_x f||_{L^2}^{\frac{1}{2}}$$

with $f = e^{-i\phi}u_N^{\text{hyp},+}$, $\partial_x(e^{-i\phi}u^{\text{hyp},+}) = -it^{-\frac{1}{\mathfrak{m}-1}}e^{-i\phi}\mathcal{J}_+u^{\text{hyp},+}$, Lemma 3.3, and (3.2) imply

$$\begin{split} & \left| t^{\frac{k+1}{\mathfrak{m}}} \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{-\frac{k}{\mathfrak{m}-1} + \frac{\mathfrak{m}-3}{2(\mathfrak{m}-1)}} \partial_x^k u_N^{\text{hyp},+}(t,x) \right| \\ & \lesssim t^{\frac{\mathfrak{m}-1}{2\mathfrak{m}}} N^{\frac{\mathfrak{m}-3}{2} - k} \left\| \partial_x^k u_N^{\text{hyp},+}(t) \right\|_{L^{\infty}} \\ & \lesssim t^{\frac{\mathfrak{m}^2 - 3\mathfrak{m} + 1}{2\mathfrak{m}(\mathfrak{m}-1)}} N^{\frac{\mathfrak{m}-3}{2} - k} \left\| \partial_x^k u_N^{\text{hyp},+}(t) \right\|_{L^2}^{\frac{1}{2}} \left\| \mathcal{J}_+ \partial_x^k u_N^{\text{hyp},+}(t) \right\|_{L^2}^{\frac{1}{2}} \\ & \lesssim t^{-\frac{1}{2\mathfrak{m}}} \|N^{-1} u_N(t)\|_{L^2}^{\frac{1}{2}} \left\| t^{\frac{\mathfrak{m}-2}{\mathfrak{m}-1}} N^{\mathfrak{m}-2} \mathcal{J}_+ u_N^{\text{hyp},+}(t) \right\|_{L^2}^{\frac{1}{2}} + t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}} \\ & \lesssim t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}}. \end{split}$$

Because $u^{\text{hyp},+}(t,x)$ is a finite sum of $u_N^{\text{hyp},+}(t,x)$'s, this yields the desired hyperbolic bound (3.14).

Next, we show the elliptic bound. First, we consider the low frequency part. For $|x| \le t^{\frac{1}{m}}$, Bernstein's inequality implies

$$\left| t^{\frac{k+1}{\mathfrak{m}}} \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{-\frac{k}{\mathfrak{m}-1} + \frac{2\mathfrak{m}-3}{2(\mathfrak{m}-1)}} \partial_x^k u_{< t^{-\frac{1}{\mathfrak{m}}}}(t,x) \right| \lesssim t^{\frac{1}{2\mathfrak{m}}} \left\| u_{< t^{-\frac{1}{\mathfrak{m}}}}(t) \right\|_{L^2} \lesssim t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}}.$$

Similarly, for $|x| \ge t^{\frac{1}{m}}$, we have

$$\begin{split} & \left| t^{\frac{k+1}{\mathfrak{m}}} \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{-\frac{k}{\mathfrak{m}-1} + \frac{2\mathfrak{m}-3}{2(\mathfrak{m}-1)}} \partial_x^k u_{\leq t^{-\frac{1}{\mathfrak{m}}}}(t,x) \right| \\ & \lesssim t^{\frac{k}{\mathfrak{m}}} \left\| x \partial_x^k u_{\leq t^{-\frac{1}{\mathfrak{m}}}}(t) \right\|_{L^{\infty}} \\ & \lesssim t^{-\frac{1}{2\mathfrak{m}}} \left\| \mathcal{J} u_{\leq t^{-\frac{1}{\mathfrak{m}}}}(t) \right\|_{L^2} + t^{\frac{1}{2\mathfrak{m}}} \left\| u_{\leq t^{-\frac{1}{\mathfrak{m}}}}(t) \right\|_{L^2} \\ & \lesssim t^{-\frac{1}{2\mathfrak{m}}} \| u(t) \|_{\widetilde{X}}. \end{split}$$

Second, we consider the high frequency part. For $|x| \leq t^{\frac{1}{m}}$, the Gagliardo-Nirenberg inequality and (3.3) yield

$$\begin{split} & \left| t^{\frac{k+1}{\mathfrak{m}}} \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{-\frac{k}{\mathfrak{m}-1} + \frac{2\mathfrak{m}-3}{2(\mathfrak{m}-1)}} \partial_x^k u_N^{\mathrm{ell},+}(t,x) \right| \\ & \lesssim t^{\frac{k+1}{\mathfrak{m}}} N^k \left\| u_N^{\mathrm{ell},+}(t,x) \right\|_{L^2} + t^{\frac{1}{2\mathfrak{m}}} (t^{\frac{1}{\mathfrak{m}}} N)^{-2} \| u_N(t) \|_{L^2} \\ & = t^{\frac{k-\mathfrak{m}+1}{\mathfrak{m}}} N^{k-\mathfrak{m}+1} \left\| t N^{\mathfrak{m}-1} u_N^{\mathrm{ell},+}(t,x) \right\|_{L^2} + t^{\frac{1}{2\mathfrak{m}}} (t^{\frac{1}{\mathfrak{m}}} N)^{-2} \| u_N(t) \|_{L^2}. \end{split}$$

Thus, by (3.6), we have

$$\sum_{\substack{N \in 2^{\mathbb{Z}} \\ N > t^{-\frac{1}{\mathfrak{m}}}}} \left| t^{\frac{k+1}{\mathfrak{m}}} \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{-\frac{k}{\mathfrak{m}-1} + \frac{2\mathfrak{m}-3}{2(\mathfrak{m}-1)}} \partial_x^k u_N^{\mathrm{ell},+}(t,x) \right| \lesssim t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}}.$$

For $|x| > t^{\frac{1}{m}}$, there exists $M \in 2^{\mathbb{Z}}$ such that

$$u_N^{\text{ell},+}(t,x) = \sigma_{tM^{\mathfrak{m}-1}}(x)u_N^{\text{ell},+}(t,x).$$

Then, the Gagliardo-Nirenberg inequality and Lemma 3.1 lead to

$$\begin{split} & \left| t^{\frac{k+1}{\mathfrak{m}}} \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{-\frac{k}{\mathfrak{m}-1} + \frac{2\mathfrak{m}-3}{2(\mathfrak{m}-1)}} \partial_x^k u_N^{\mathrm{ell},+}(t,x) \right| \\ & \lesssim t^{\frac{2\mathfrak{m}-1}{2\mathfrak{m}}} M^{\frac{2\mathfrak{m}-3}{2} - k} \left| \sigma_{tM^{\mathfrak{m}-1}}(x) \partial_x^k u_N^{\mathrm{ell},+}(t,x) \right| \\ & \lesssim t^{\frac{2\mathfrak{m}-1}{2\mathfrak{m}}} M^{\frac{2\mathfrak{m}-3}{2} - k} N^{k + \frac{1}{2}} \left\| \sigma_{tM^{\mathfrak{m}-1}}(x) u_N^{\mathrm{ell},+}(t) \right\|_{L^2} \\ & + t^{-k + \frac{2\mathfrak{m}-1}{2\mathfrak{m}}} N^{\frac{1}{2}} M^{\frac{2\mathfrak{m}-3}{2} - \mathfrak{m}k} \max \left(1, tNM^{\mathfrak{m}-1} \right)^{-2} \|u_N(t)\|_{L^2}. \end{split}$$

Hence, we have

$$\begin{split} & \sum_{N \in 2^{\mathbb{Z}}} \left| t^{\frac{k+1}{\mathfrak{m}}} \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{-\frac{k}{\mathfrak{m}-1} + \frac{2\mathfrak{m}-3}{2(\mathfrak{m}-1)}} \partial_x^k u_N^{\mathrm{ell},+}(t,x) \right| \\ & \lesssim \sum_{N \in 2^{\mathbb{Z}}} t^{-\frac{1}{2\mathfrak{m}}} M^{-k-\frac{1}{2}} N^{k+\frac{1}{2}} \left\| x u_N^{\mathrm{ell},+}(t) \right\|_{L^2} \\ & t^{-\frac{1}{\mathfrak{m}}} < N \leq M \\ & + \sum_{N \in 2^{\mathbb{Z}}} t^{-\frac{1}{2\mathfrak{m}}} M^{\frac{2\mathfrak{m}-3}{2}-k} N^{-\frac{2\mathfrak{m}-3}{2}+k} \left\| t N^{\mathfrak{m}-1} u_N^{\mathrm{ell},+}(t) \right\|_{L^2} + t^{-\frac{1}{2\mathfrak{m}}} \| u(t) \|_{\widetilde{X}} \\ & \lesssim t^{-\frac{1}{2\mathfrak{m}}} \| u(t) \|_{\widetilde{Y}}. \end{split}$$

Remark 3.6. For $t \geq 1$, the estimate

$$\left| t^{\frac{k}{\mathfrak{m}} + \frac{3}{4\mathfrak{m}}} \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{-\frac{k}{\mathfrak{m} - 1} + \frac{\mathfrak{m} - 2}{2(\mathfrak{m} - 1)}} \partial_x^k u^{\mathrm{hyp}, +}(t, x) \right| \lesssim \|u(t)\|_{L^2} + t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}}$$

holds true. Indeed, the Gagliardo-Nirenberg inequality, (3.2), and (3.5) yield

$$\begin{split} & \left| t^{\frac{k}{\mathfrak{m}} + \frac{3}{4\mathfrak{m}}} \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{-\frac{k}{\mathfrak{m}-1} + \frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}} \partial_x^k u_N^{\text{hyp},+}(t,x) \right| \\ & \lesssim t^{\frac{2\mathfrak{m}-1}{4\mathfrak{m}}} N^{\frac{\mathfrak{m}-2}{2} - k} \left\| \partial_x^k u_N^{\text{hyp},+}(t) \right\|_{L^{\infty}} \\ & \lesssim t^{\frac{2\mathfrak{m}^2 - 5\mathfrak{m} + 1}{4\mathfrak{m}(\mathfrak{m}-1)}} N^{\frac{\mathfrak{m}-2}{2} - k} \left\| \partial_x^k u_N^{\text{hyp},+}(t) \right\|_{L^2}^{\frac{1}{2}} \left\| \mathcal{J}_+ \partial_x^k u_N^{\text{hyp},+}(t) \right\|_{L^2}^{\frac{1}{2}} \\ & \lesssim t^{-\frac{1}{4\mathfrak{m}}} \|u_N(t)\|_{L^2}^{\frac{1}{2}} \left\| t^{\frac{\mathfrak{m}-2}{2\mathfrak{m}-1}} N^{\mathfrak{m}-2} \mathcal{J}_+ u_N^{\text{hyp},+}(t) \right\|_{L^2}^{\frac{1}{2}} + t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}} \\ & \lesssim \|u(t)\|_{L^2} + t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}}. \end{split}$$

Accordingly, by combining this estimate with (3.15) and Remark 2.4, we obtain (1.4) at t = 1.

4. Wave packets

4.1. Construction of wave packets. Let $t \ge 1$. Setting

(4.1)
$$\lambda := t^{-\frac{1}{2}} v^{-\frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}} = t^{-\frac{1}{\mathfrak{m}}} (t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}} v)^{-\frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}},$$

we define, for $v \geq t^{-\frac{m-1}{m}}$,

$$\Psi_v(t,x) := \chi \left(\lambda(x - vt) \right) e^{i\phi(t,x)},$$

where χ is a smooth function with supp $\chi \subset [-\frac{1}{2}, \frac{1}{2}]$ and $\int_{\mathbb{R}} \chi(z) dz = 1$, and ϕ is defined by (1.3). The spatial support of Ψ_v is included in $[\frac{vt}{2}, \frac{3}{2}vt]$.

We show that $\Psi_v(t,x)$ is essentially localized at frequency $\xi_v := v^{\frac{1}{m-1}}$ in the following sense:

Lemma 4.1. For $t \ge 1$ and $v \ge t^{-\frac{m-1}{m}}$, we have

$$\mathcal{F}[\Psi_v](t,\xi) = \frac{1}{\sqrt{\mathfrak{m}-1}} \lambda^{-1} \chi_1 \left(\lambda^{-1} (\xi - \xi_v), \lambda^{-1} \xi_v \right) e^{-\frac{1}{\mathfrak{m}} i t \xi^{\mathfrak{m}}},$$

where $\chi_1(\cdot, \alpha) \in \mathcal{S}(\mathbb{R})$ satisfies

(4.2)
$$\sup_{\alpha \geq 1} \sup_{\zeta \in \mathbb{R}} \left| \langle \zeta \rangle^k \partial_{\zeta}^l \chi_1(\zeta, \alpha) \right| \lesssim_{k,l} 1$$

for any $k, l \in \mathbb{N}_0$. Moreover, there exists a constant $C_1 > 0$ such that for any $\alpha \geq 1$,

$$\left| \int_{\mathbb{R}} \chi_1(\zeta, \alpha) d\zeta - 1 \right| \le \frac{C_1}{\alpha}.$$

Proof. From Taylor's theorem, we can write for x > 0

$$\phi(t,x)$$

$$= \phi(t,vt) + \partial_x \phi(t,vt)(x-vt) + \frac{1}{2}\partial_x^2 \phi(t,vt)(x-vt)^2 + \int_{vt}^x \frac{(x-y)^2}{2} \partial_x^3 \phi(t,y) dy$$

$$= -\frac{\pi}{4} + \frac{\mathfrak{m}-1}{\mathfrak{m}} t \xi_v^{\mathfrak{m}} + \xi_v(x-vt) + \frac{1}{2(\mathfrak{m}-1)} \lambda^2 (x-vt)^2 + R\left(\lambda(x-vt), \lambda^{-1} \xi_v\right),$$

where

$$R(z,\alpha) := -\frac{\mathfrak{m} - 2}{2(\mathfrak{m} - 1)^2} \frac{z^3}{\alpha} \int_0^1 (1 - \theta)^2 \left(\theta \frac{z}{\alpha} + 1\right)^{-\frac{2\mathfrak{m} - 3}{\mathfrak{m} - 1}} d\theta.$$

We note that $R(z, \alpha)$ is well-defined provided that $z > -\alpha$. By a change of variables using $z = \lambda(x - vt)$, we have

$$\begin{split} &\mathcal{F}[\Psi_{v}](t,\xi) \\ &= \frac{1}{\sqrt{2\pi}} \int_{\mathbb{R}} e^{-ix\xi} \chi(\lambda(x-vt)) e^{i\phi(t,x)} dx \\ &= e^{-i\frac{\pi}{4}} \lambda^{-1} e^{\frac{1}{m}it(-\mathfrak{m}\xi\xi_{v}^{\mathfrak{m}-1} + (\mathfrak{m}-1)\xi_{v}^{\mathfrak{m}})} \frac{1}{\sqrt{2\pi}} \int_{\mathbb{R}} e^{-iz\lambda^{-1}(\xi-\xi_{v})} e^{\frac{i}{2(\mathfrak{m}-1)}z^{2} + iR(z,\lambda^{-1}\xi_{v})} \chi(z) dz \\ &= \frac{1}{\sqrt{\mathfrak{m}-1}} \lambda^{-1} \chi_{1} \left(\lambda^{-1}(\xi-\xi_{v}), \lambda^{-1}\xi_{v} \right) e^{-\frac{1}{\mathfrak{m}}it\xi^{\mathfrak{m}}}, \end{split}$$

where

$$\chi_1(\zeta,\alpha):=(1-i)\sqrt{\frac{\mathfrak{m}-1}{2}}e^{\frac{i}{\mathfrak{m}}\sum_{l=0}^{\mathfrak{m}-2}\binom{\mathfrak{m}}{l}}\varsigma^{\mathfrak{m}-l}\alpha^{-\mathfrak{m}+l+2}\mathcal{F}[e^{\frac{i}{2(\mathfrak{m}-1)}z^2+iR(z,\alpha)}\chi](\zeta).$$

By definition, $\chi_1(\cdot, \alpha) \in \mathcal{S}(\mathbb{R})$ for $\alpha \geq 1$. From the Fresnel integrals,

$$(1-i)\sqrt{\frac{\pi}{2}} = \int_{\mathbb{D}} e^{-i\left(\eta + \sqrt{\frac{\mathfrak{m}-1}{2}}(\zeta - \frac{z}{\mathfrak{m}-1})\right)^2} d\eta$$

holds for any $z, \zeta \in \mathbb{R}$. Accordingly, we have

$$\begin{split} &\mathcal{F}[e^{\frac{i}{2(\mathfrak{m}-1)}z^2+iR(z,\alpha)}\chi](\zeta) \\ &=e^{-i\frac{m-1}{2}\zeta^2}\frac{1}{\sqrt{2\pi}}\int_{\mathbb{R}}e^{i\frac{\mathfrak{m}-1}{2}(\zeta-\frac{z}{\mathfrak{m}-1})^2+iR(z,\alpha)}\chi(z)dz \\ &=\frac{1}{1-i}\sqrt{\frac{2}{\pi}}e^{-\frac{\mathfrak{m}-1}{2}i\zeta^2}\frac{1}{\sqrt{2\pi}}\int_{\mathbb{R}}\int_{\mathbb{R}}e^{-i\left(\eta^2+\sqrt{2(\mathfrak{m}-1)}\eta(\zeta-\frac{z}{\mathfrak{m}-1})\right)}e^{iR(z,\alpha)}\chi(z)d\eta dz \\ &=\frac{1}{1-i}\sqrt{\frac{2}{\pi}}e^{-\frac{\mathfrak{m}-1}{2}i\zeta^2}\int_{\mathbb{R}}e^{-i\eta^2}e^{-i\sqrt{2(\mathfrak{m}-1)}\eta\zeta}\widehat{\chi_2}\left(-\sqrt{\frac{2}{\mathfrak{m}-1}}\eta,\alpha\right)d\eta, \end{split}$$

where

$$\chi_2(\cdot,\alpha) := \chi e^{iR(\cdot,\alpha)} \in \mathcal{S}(\mathbb{R})$$

for $\alpha \geq 1$. Hence, we can write (4.4)

$$\chi_1(\zeta,\alpha) = \frac{\mathfrak{m}-1}{2} \sqrt{\frac{2}{\pi}} e^{\frac{i}{\mathfrak{m}} \sum_{l=0}^{\mathfrak{m}-3} \binom{\mathfrak{m}}{l} \zeta^{\mathfrak{m}-l} \alpha^{-\mathfrak{m}+l+2}} \int_{\mathbb{R}} e^{-i\frac{\mathfrak{m}-1}{2} \eta^2} e^{i(\mathfrak{m}-1)\eta \zeta} \widehat{\chi_2} \left(\eta,\alpha\right) d\eta.$$

As
$$\chi_2(\cdot, \alpha) \in \mathcal{S}(\mathbb{R})$$
, $e^{\frac{i}{\mathfrak{m}} \sum_{l=0}^{\mathfrak{m}-3} {\mathfrak{m} \choose l} \zeta^{\mathfrak{m}-l} \alpha^{-\mathfrak{m}+l+2}} = 1 + O\left(\frac{|\zeta|^3}{\alpha} \langle \zeta \rangle^{\mathfrak{m}-3}\right)$, and

(4.5)
$$\sup_{\alpha > 1} \sup_{\eta \in \mathbb{R}} |\langle \eta \rangle^k \partial_{\eta}^l \widehat{\chi}_2(\eta, \alpha)| \lesssim_{k,l} 1,$$

we obtain

$$\int_{\mathbb{P}} \chi_1(\zeta, \alpha) d\zeta = \sqrt{2\pi} \widehat{\chi}_2(0, \alpha) + O\left(\frac{1}{\alpha}\right).$$

Because $e^{iR(z,\alpha)} = 1 + O(\frac{1}{\alpha})$ for |z| < 1 and $\alpha \ge 1$, we have

$$\sqrt{2\pi}\widehat{\chi}_2(0,\alpha) = \int_{\mathbb{R}} \chi(z)e^{iR(z,\alpha)}dz = 1 + O\left(\frac{1}{\alpha}\right).$$

Finally, (4.2) follows from (4.4) and (4.5).

For $v \geq t^{-\frac{\mathfrak{m}-1}{\mathfrak{m}}}$, we define the nearest dyadic number to ξ_v by $N_v \in 2^{\mathbb{Z}}$. Then, $\frac{\xi_v}{2} < N_v < 2\xi_v$ holds.

Integration by parts with (4.2) yields

$$\left| \left(1 - P_{\frac{N_v}{s} < \cdot < 2N_v}^+ \right) |\partial_x|^a \Psi_v(t, x) \right| \lesssim_{a, l} t^{-\frac{a}{\mathfrak{m}}} \left(t^{\frac{\mathfrak{m} - 1}{\mathfrak{m}}} v \right)^{-l} \min(1, |x|^{-1} t v)^2$$

for any a, l > 0, which implies

for $v \ge t^{-\frac{m-1}{m}}$ and any $a, c \ge 0$.

Next, we show that Ψ_v is a good approximate solution for the linear equation. We begin with the following preliminary observation. Set

$$S_j := \{k = (k_1, \dots, k_j) \in \mathbb{N}_0 \colon 0 \le k_1 \le \dots \le k_j \le j, \ k_1 + \dots + k_j = j\}$$

for $j \in \mathbb{N}$.

Lemma 4.2. Let f be a smooth function. For any $j \in \mathbb{N}$, we have

(4.7)
$$\frac{d^j}{dx^j}e^{f(x)} = \sum_{k \in S_j} C_k^{(j)} e^{f(x)} \prod_{l=1}^j f^{(k_l)}(x),$$

where

$$f^{(l)} := \begin{cases} 1, & \text{if } l = 0, \\ \frac{d^l f}{dx^l}, & \text{otherwise,} \end{cases}$$

and $C_k^{(j)}$ is a constant depending on $j \in \mathbb{N}$, $k \in S_j$. In particular,

$$C_{(1,\dots,1)}^{(j)} = 1, \quad C_{(0,1,\dots,1,2)}^{(j)} = \begin{pmatrix} j \\ 2 \end{pmatrix}.$$

Proof. A direct calculation shows

$$\frac{d}{dx}e^{f(x)} = e^{f(x)}f'(x), \qquad \frac{d^2}{dx^2}e^{f(x)} = e^{f(x)}\left(f'(x)^2 + f''(x)\right),$$
$$\frac{d^3}{dx^3}e^{f(x)} = e^{f(x)}\left(f'(x)^3 + 3f'(x)f''(x) + f'''(x)\right).$$

Hence, we have

$$(4.8) C_{(1)}^{(1)} = C_{(1,1)}^{(2)} = C_{(0,2)}^{(2)} = C_{(1,1,1)}^{(3)} = C_{(0,0,3)}^{(3)} = 1, C_{(0,1,2)}^{(3)} = 3.$$

We assume that (4.7) holds up to j-1. Because

$$\frac{d^{j}}{dx^{j}}e^{f(x)}$$

$$= \frac{d}{dx} \left(\sum_{k \in S_{j-1}} C_{k}^{(j-1)} e^{f} \prod_{l=1}^{j-1} f^{(k_{l})} \right) (x)$$

$$= \sum_{k \in S_{j-1}} C_{k}^{(j-1)} e^{f(x)} \left(f'(x) \prod_{l=1}^{j-1} f^{(k_{l})}(x) + \sum_{\substack{n \in \{1, \dots, j-1\}\\k_{n} \neq 0}} f^{(k_{n}+1)}(x) \prod_{l \neq n} f^{(k_{l})}(x) \right),$$

the constants $C_k^{(j)}$ are determined by $C_k^{(j-1)}$, which shows (4.7). In particular, the following recurrence equations hold true:

$$C_{(1,\dots,1)}^{(j)} = C_{(1,\dots,1)}^{(j-1)}, \quad C_{(0,1,\dots,1,2)}^{(j)} = C_{(0,1,\dots,1,2)}^{(j-1)} + (j-1)C_{(1,\dots,1)}^{(j-1)}.$$

By (4.8), we obtain
$$C_{(1,...,1)}^{(j)}=1$$
 and $C_{(0,1,...,1,2)}^{(j)}=\binom{j}{2}.$

Set

$$S'_j := S_j \setminus \{(1, \dots, 1)\}, \quad S''_j := S'_j \setminus \{(0, 1, \dots, 1, 2)\}.$$

Lemma 4.2 and $\partial_t \phi = -\frac{1}{\mathfrak{m}} (\partial_x \phi)^{\mathfrak{m}}$ yield

$$\begin{split} &\left(\partial_{t} + \frac{i}{\mathfrak{m}}(-i\partial_{x})^{\mathfrak{m}}\right)\Psi_{v}(t,x) \\ &= -\frac{x+vt}{2t}\lambda\chi'e^{i\phi} + i\partial_{t}\phi\chi e^{i\phi} \\ &+ \frac{i}{\mathfrak{m}}(-i)^{\mathfrak{m}}\left\{\chi\partial_{x}^{\mathfrak{m}}\left(e^{i\phi}\right) + \mathfrak{m}\lambda\chi'\partial_{x}^{\mathfrak{m}-1}\left(e^{i\phi}\right) + \frac{\mathfrak{m}(\mathfrak{m}-1)}{2}\lambda^{2}\chi''\partial_{x}^{\mathfrak{m}-2}\left(e^{i\phi}\right) \\ &+ \frac{\mathfrak{m}(\mathfrak{m}-1)(\mathfrak{m}-2)}{6}\lambda^{3}\chi'''\partial_{x}^{\mathfrak{m}-3}\left(e^{i\phi}\right) + \sum_{j=0}^{\mathfrak{m}-4}\binom{\mathfrak{m}}{j}\lambda^{\mathfrak{m}-j}\chi^{(\mathfrak{m}-j)}\partial_{x}^{j}\left(e^{i\phi}\right) \right\} \\ &= -\frac{x+vt}{2t}\lambda\chi'e^{i\phi} + i\partial_{t}\phi\chi e^{i\phi} \\ &+ \frac{i}{\mathfrak{m}}\chi\left\{\left(\partial_{x}\phi\right)^{\mathfrak{m}} - i\binom{\mathfrak{m}}{2}\left(\partial_{x}\phi\right)^{\mathfrak{m}-2}\partial_{x}^{2}\phi + (-i)^{\mathfrak{m}}\sum_{k\in S_{m}''}C_{k}^{(\mathfrak{m})}\prod_{l=1}^{\mathfrak{m}}(i\phi)^{(k_{l})}\right\}e^{i\phi} \\ &+ \lambda\chi'\left\{\left(\partial_{x}\phi\right)^{\mathfrak{m}-1} - i\binom{\mathfrak{m}-1}{2}\left(\partial_{x}\phi\right)^{\mathfrak{m}-3}\partial_{x}^{2}\phi \\ &+ (-i)^{\mathfrak{m}-1}\sum_{k\in S_{m-1}''}C_{k}^{(\mathfrak{m}-1)}\prod_{l=1}^{\mathfrak{m}-1}(i\phi)^{(k_{l})}\right\}e^{i\phi} \\ &+ (-i)^{\mathfrak{m}-2}\sum_{k\in S_{m-2}''}C_{k}^{(\mathfrak{m}-2)}\prod_{l=1}^{\mathfrak{m}-2}(i\phi)^{(k_{l})}\right\}e^{i\phi} \\ &- \frac{\mathfrak{m}-1}{2}\lambda^{2}\chi''\left\{\left(\partial_{x}\phi\right)^{\mathfrak{m}-2} - i\binom{\mathfrak{m}-2}{2}\left(\partial_{x}\phi\right)^{\mathfrak{m}-4}\partial_{x}^{2}\phi \\ &+ (-i)^{\mathfrak{m}-2}\sum_{k\in S_{m-2}''}C_{k}^{(\mathfrak{m}-2)}\prod_{l=1}^{\mathfrak{m}-2}(i\phi)^{(k_{l})}\right\}e^{i\phi} \\ &+ \frac{i}{\mathfrak{m}}(-i)^{\mathfrak{m}}\sum_{j=0}^{\mathfrak{m}-4}\binom{\mathfrak{m}}{j}\lambda^{\mathfrak{m}-j}\chi^{(\mathfrak{m}-j)}\partial_{x}^{j}\left(e^{i\phi}\right) \\ &= \left\{\partial_{x}\left(\frac{x-vt}{2t}\chi\right) - i\frac{\mathfrak{m}-1}{2}t^{-\frac{\mathfrak{m}-2}{\mathfrak{m}-1}}\partial_{x}\left(\left|\cdot\right|^{\frac{\mathfrak{m}-2}{\mathfrak{m}-1}}\lambda\chi'\right) \\ &- \frac{(\mathfrak{m}-1)(\mathfrak{m}-2)}{6}t^{-\frac{\mathfrak{m}-3}{\mathfrak{m}-1}}\alpha\left(\left|\cdot\right|^{\frac{\mathfrak{m}-3}{\mathfrak{m}-1}}\lambda^{2}\chi''\right) - \frac{(\mathfrak{m}-2)(\mathfrak{m}-3)}{12}t^{-\frac{\mathfrak{m}-3}{\mathfrak{m}-1}}l^{-\frac{2}{\mathfrak{m}-1}}\lambda^{2}\chi'' \\ &+ \frac{i}{\mathfrak{m}}(-i)^{\mathfrak{m}}\chi\sum_{k\in S_{m}''}C_{k}^{(\mathfrak{m})}\prod_{l=1}^{\mathfrak{m}}(i\phi)^{(k_{l})} + (-i)^{\mathfrak{m}-1}\lambda\chi'\sum_{k\in S_{m-1}''}C_{k}^{(\mathfrak{m}-3)}\prod_{l=1}^{\mathfrak{m}-3}(i\phi)^{(k_{l})} \\ &- i\frac{\mathfrak{m}-1}{2}(-i)^{\mathfrak{m}-2}\lambda^{2}\chi''\sum_{k\in S_{m-1}''}C_{k}^{(\mathfrak{m}-3)}\prod_{l=1}^{\mathfrak{m}-3}(i\phi)^{(k_{l})} \\ &- \frac{(\mathfrak{m}-1)(\mathfrak{m}-2)}{6}(-i)^{\mathfrak{m}-3}\lambda^{3}\chi'''\sum_{k\in S_{m-2}''}C_{k}^{(\mathfrak{m}-3)}\prod_{l=1}^{\mathfrak{m}-3}(i\phi)^{(k_{l})} \end{aligned}$$

$$\begin{split} &+\frac{i}{\mathfrak{m}}(-i)^{\mathfrak{m}}\sum_{j=0}^{\mathfrak{m}-4}\binom{\mathfrak{m}}{j}\lambda^{\mathfrak{m}-j}\chi^{(\mathfrak{m}-j)}\sum_{k\in S_{j}}C_{k}^{(j)}\prod_{l=1}^{j}(i\phi)^{(k_{l})}\bigg\}e^{i\phi}\\ &=\frac{e^{i\phi}}{t\lambda}\partial_{x}\widetilde{\chi}+O\left(t^{-1}(t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}}v)^{-\frac{\mathfrak{m}}{\mathfrak{m}-1}}\boldsymbol{X}(\lambda(x-vt))\right), \end{split}$$

where

$$\widetilde{\chi}(t,x) := \lambda \frac{x - vt}{2} \chi(\lambda(x - vt)) - i \frac{\mathfrak{m} - 1}{2} \lambda^2 t^{\frac{1}{\mathfrak{m} - 1}} |x|^{\frac{\mathfrak{m} - 2}{\mathfrak{m} - 1}} \chi'(\lambda(x - vt)) - \frac{(\mathfrak{m} - 1)(\mathfrak{m} - 2)}{6} \lambda^3 t^{\frac{2}{\mathfrak{m} - 1}} |x|^{\frac{\mathfrak{m} - 3}{\mathfrak{m} - 1}} \chi''(\lambda(x - vt))$$

and X is a nonnegative continuous function supported in $\left[-\frac{1}{2}, \frac{1}{2}\right]$. Therefore, we obtain the following:

(4.9)
$$(\mathcal{L}\Psi_v)(t,x) = \frac{e^{i\phi}}{t\lambda} \partial_x \widetilde{\chi} + \frac{1}{\mathfrak{m}} \left(|\partial_x|^{\mathfrak{m}-1} \partial_x - i(-i\partial_x)^{\mathfrak{m}} \right) P^- \Psi_v(t,x)$$
$$+ O\left(t^{-1} \left(t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}} v \right)^{-\frac{\mathfrak{m}}{\mathfrak{m}-1}} X(\lambda(x-vt)) \right).$$

Because $\tilde{\chi}$ has the same localization as χ , the first term on the right hand side of (4.9) is essentially localized at frequency ξ_v . For the sake of completeness, we give a proof here, although the proof is similar to that of Lemma 4.1.

Lemma 4.3. For $t \ge 1$ and $v \ge t^{-\frac{m-1}{m}}$ and any $a, c \ge 0$, we have

$$(4.10) \qquad \left\| \left(1 - P_{\frac{N_v}{2} \le \cdot \le 2N_v}^+ \right) |\partial_x|^a (e^{i\phi} \widetilde{\chi}) \right\|_{L^1} \lesssim_{a,c} t^{\frac{1-a}{\mathfrak{m}}} \left(t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}} v \right)^{-c}.$$

Proof. We write

$$\widetilde{\chi}(t,x) := \widetilde{\chi}_0(\lambda(x-vt),\lambda vt),$$

where

$$\widetilde{\chi}_{0}(z,\alpha) := \frac{z}{2}\chi(z) - i\frac{\mathfrak{m}-1}{2}\alpha^{-\frac{\mathfrak{m}-2}{\mathfrak{m}-1}}|z+\alpha|^{\frac{\mathfrak{m}-2}{\mathfrak{m}-1}}\chi'(z) - \frac{(\mathfrak{m}-1)(\mathfrak{m}-2)}{6}\alpha^{-\frac{2(\mathfrak{m}-2)}{\mathfrak{m}-1}}|z+\alpha|^{\frac{\mathfrak{m}-3}{\mathfrak{m}-1}}\chi''(z).$$

The same calculation as in the proof of Lemma 4.1 yields

$$\mathcal{F}[e^{i\phi}\widetilde{\chi}](t,\xi) := \frac{1}{\sqrt{\mathfrak{m}-1}} \lambda^{-1} \widetilde{\chi}_1 \left(\lambda^{-1} (\xi - \xi_v), \lambda^{-1} \xi_v \right) e^{-\frac{1}{\mathfrak{m}} i t \xi^{\mathfrak{m}}},$$

$$\widetilde{\chi}_1(\zeta,\alpha) := (1-i)\sqrt{\frac{\mathfrak{m}-1}{2}}e^{\frac{i}{\mathfrak{m}}\sum_{l=0}^{\mathfrak{m}-2}\binom{\mathfrak{m}}{l}\zeta^{\mathfrak{m}-l}\alpha^{-\mathfrak{m}+l+2}}\mathcal{F}[e^{\frac{i}{2(\mathfrak{m}-1)}z^2+iR(z,\alpha)}\widetilde{\chi}_0(\cdot,\alpha)](\zeta).$$

Since $\widetilde{\chi}_0(\cdot, \alpha) \in \mathcal{S}(\mathbb{R})$ for $\alpha \geq 1$, we have

$$\sup_{\alpha > 1} \sup_{\zeta \in \mathbb{R}} |\langle \zeta \rangle^k \partial_{\zeta}^l \widetilde{\chi}_1(\zeta, \alpha)| \lesssim_{k, l} 1.$$

From $|\xi - \xi_v| \ge \frac{\xi_v}{2}$ provided that $\xi \notin [\frac{N_v}{4}, 4N_v]$, integration by parts yields

which implies the desired bound.

4.2. **Testing by wave packets.** Let $C_2 > 0$ be the constant appearing in (4.2) with k = 2 and l = 0, that is,

Here, C_1 is the constant appearing in (4.3). The large constant C_* is needed to show the pointwise estimate (4.13) in the frequency space.

We observe that the output $\gamma(t, v)$ defined by (1.11) is a "good" approximation of u for $v \in \Omega(t)$.

Proposition 4.4. For $t \ge 1$ and $k = 0, 1, ..., \mathfrak{m} - 2$, we have the bounds

$$\left\| t^{\frac{k}{\mathfrak{m}} + \frac{\mathfrak{m}+1}{2\mathfrak{m}}} (t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}} v)^{-\frac{k}{\mathfrak{m}-1} + \frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}} R_k(t,v) \right\|_{L_v^2(\Omega(t))} \lesssim t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}}.$$

Moreover, in the frequency space, we have

(4.13)
$$\widehat{u}(t,\xi_v) = \sqrt{\mathfrak{m} - 1} e^{-\frac{1}{\mathfrak{m}} it \xi_v^{\mathfrak{m}}} \gamma(t,v) + R_{\xi}(t,v),$$

where R_{ξ} is a function satisfying

$$\begin{split} \left\| (t^{\frac{m-1}{\mathfrak{m}}} v)^{\frac{\mathfrak{m}-2}{4(\mathfrak{m}-1)}} R_{\xi}(t,v) \right\|_{L^{\infty}_{v}(\Omega(t))} &\lesssim t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}}, \\ \left\| t^{\frac{m-1}{2\mathfrak{m}}} R_{\xi}(t,v) \right\|_{L^{2}_{v}(\Omega(t))} &\lesssim t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}}. \end{split}$$

$$\frac{d\widetilde{v}}{dv} = t \left\{ 1 + \frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)} (t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}} v)^{-\frac{\mathfrak{m}}{2(\mathfrak{m}-1)}} z \right\} \ge \frac{t}{2}.$$

for $v \in \Omega(t)$ and $|z| \leq \frac{1}{2}$. Then, we have

L.H.S. of (4.14)
$$\lesssim t^{\frac{1}{2}} \int_{\mathbb{R}} \left\| f\left(t, t^{\frac{1}{2}} v^{\frac{m-2}{2(m-1)}} z + vt\right) \right\|_{L_{v}^{2}(\Omega(t))} \chi(z) dz$$

 $\lesssim \left\| f(t, \cdot) \right\|_{L_{x}^{2}(\left[t^{\frac{1}{m}}, \infty\right))}.$

Second, we show that u in the definition of γ is replaced with $u^{\text{hyp},+}$ up to error terms;

$$(4.15) i^k \lambda v^{\frac{k}{m-1}} \gamma(t,v) = i^k \lambda v^{\frac{k}{m-1}} \int_{\mathbb{R}} u^{\text{hyp},+}(t,x) \overline{\Psi_v(t,x)} dx + R_k(t,v).$$

Moreover, (3.15) yields

$$\left| \int_{\mathbb{R}} u^{\text{ell}}(t,x) \overline{\Psi_{v}(t,x)} dx \right| \lesssim \lambda^{-1} (t^{\frac{m-1}{m}} v)^{-\frac{2m-3}{2(m-1)}} \left\| (t^{-\frac{1}{m}} |x|)^{\frac{2m-3}{2(m-1)}} u^{\text{ell}}(t) \right\|_{L^{\infty}} \\ \lesssim (t^{\frac{m-1}{m}} v)^{-\frac{1}{2}} \cdot t^{-\frac{1}{2m}} \|u(t)\|_{\widetilde{X}}.$$

In addition, by (4.14) and (3.12), we have

$$\begin{split} \left\| \int_{\mathbb{R}} u^{\text{ell}}(t,x) \overline{\Psi_{v}(t,x)} dx \right\|_{L_{v}^{2}(\Omega(t))} &\lesssim t^{-\frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}} \left\| |x|^{\frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}} u^{\text{ell}}(t) \right\|_{L_{x}^{2}([t^{\frac{1}{\mathfrak{m}}},\infty))} \\ &\lesssim t^{-\frac{\mathfrak{m}-2}{2\mathfrak{m}}} \left\| \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{\frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}} u^{\text{ell}}(t) \right\|_{L^{2}} \\ &\lesssim t^{-\frac{\mathfrak{m}-1}{2\mathfrak{m}}} \cdot t^{-\frac{1}{2\mathfrak{m}}} \| u(t) \|_{\widetilde{X}}. \end{split}$$

Hence, from $\lambda v^{\frac{k}{\mathfrak{m}-1}} = t^{-\frac{k+1}{\mathfrak{m}}} (t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}} v)^{\frac{k}{\mathfrak{m}-1} - \frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}}$, we obtain (4.15) Third, we observe that the equation

Here, (3.14) yields

$$\lesssim t^{\frac{k}{\mathfrak{m}}} (t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}} v)^{-\frac{k}{\mathfrak{m}-1} - \frac{\mathfrak{m}}{2(\mathfrak{m}-1)}} \int_{\mathbb{R}} \left| \partial_x^k u^{\text{hyp},+}(t,x) \chi(\lambda(x-vt)) \right| dx$$

$$\lesssim (t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}} v)^{-\frac{1}{2}} \cdot t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}}.$$

By (4.14) and (3.10), we have

$$\begin{split} & \left\| v^{-\frac{k-1}{\mathfrak{m}-1}} \int_{\mathbb{R}} t^{\frac{1}{\mathfrak{m}-1}} \left(x^{-\frac{1}{\mathfrak{m}-1}} - (vt)^{-\frac{1}{\mathfrak{m}-1}} \right) \partial_x^k u^{\mathrm{hyp},+}(t,x) \overline{\Psi_v(t,x)} dx \right\|_{L^2_v(\Omega(t))} \\ & \lesssim t^{-\frac{1}{2}} \left\| v^{-\frac{k}{\mathfrak{m}-1} - \frac{\mathfrak{m}}{2(\mathfrak{m}-1)}} \int_{\mathbb{R}} \partial_x^k u^{\mathrm{hyp},+}(t,x) \chi(\lambda(x-vt)) dx \right\|_{L^2_v(\Omega(t))} \\ & \lesssim t^{-\frac{1}{2}} \left\| \left(\frac{x}{t} \right)^{-\frac{k+1}{\mathfrak{m}-1}} \partial_x^k u^{\mathrm{hyp},+} \right\|_{L^2_x} \\ & \lesssim t^{-\frac{\mathfrak{m}-1}{2\mathfrak{m}}} \cdot t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\tilde{\mathcal{V}}}. \end{split}$$

Moreover, (3.11) implies

$$\begin{split} & \left| v^{-\frac{k}{\mathfrak{m}-1}} \int_{\mathbb{R}} t^{\frac{1}{\mathfrak{m}-1}} x^{-\frac{1}{\mathfrak{m}-1}} \partial_x \left(e^{-i\phi} \partial_x^k u^{\mathrm{hyp},+} \right) (t,x) \chi(\lambda(x-vt)) dx \right| \\ & \lesssim t^{\frac{k}{\mathfrak{m}-1}} (tv)^{-1} \lambda^{-\frac{1}{2}} \left\| |x|^{-\frac{k-\mathfrak{m}+2}{\mathfrak{m}-1}} \mathcal{J}_+ \partial_x^k u^{\mathrm{hyp},+} \right\|_{L^2} \\ & \lesssim (t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}} v)^{-\frac{3\mathfrak{m}-2}{4(\mathfrak{m}-1)}} \cdot t^{-\frac{1}{2\mathfrak{m}}} \| u(t) \|_{\widetilde{Y}} \end{split}$$

and

$$\begin{split} & \left\| v^{-\frac{k}{\mathfrak{m}-1}} \int_{\mathbb{R}} t^{\frac{1}{\mathfrak{m}-1}} x^{-\frac{1}{\mathfrak{m}-1}} \partial_x (e^{-i\phi} \partial_x^k u^{\mathrm{hyp},+})(t,x) \chi(\lambda(x-vt)) dx \right\|_{L^2_v(\Omega(t))} \\ & \lesssim \left\| (t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}} v)^{-\frac{3\mathfrak{m}-2}{4(\mathfrak{m}-1)}} \right\|_{L^2_v(\Omega(t))} \cdot t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}} \\ & \lesssim t^{-\frac{\mathfrak{m}-1}{2\mathfrak{m}}} \cdot t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}}. \end{split}$$

$$\lesssim t^{-\frac{1}{m-1}} \lambda^{-\frac{3}{2}} (tv)^{\frac{k-m+2}{m-1}} \left\| |x|^{-\frac{k-m+2}{m-1}} \mathcal{J}_{+} \partial_x^k u^{\text{hyp,+}}(t) \right\|_{L^2}$$

$$\lesssim t^{-\frac{k}{m}} (t^{\frac{m-1}{m}} v)^{\frac{k}{m-1} - \frac{m-2}{4(m-1)}} \cdot t^{-\frac{1}{2m}} \|u(t)\|_{\widetilde{X}}.$$

From (4.1), we obtain the L^{∞} -estimate in (4.12).

A change of variables using $z = \lambda(x - vt)$ and $\tilde{v} = vt + (1 - \theta)\lambda^{-1}z$, and (3.11) give

$$\begin{split} & \left\| t^{\frac{k}{\mathfrak{m}} + \frac{\mathfrak{m}+1}{2\mathfrak{m}}} (t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}} v)^{-\frac{k}{\mathfrak{m}-1} + \frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}} \lambda \int_{\mathbb{R}} |w_k(t,vt) - w_k(t,x)| \chi(\lambda(x-vt)) dx \right\|_{L^2_v(\Omega(t))} \\ & \leq t^{\frac{3\mathfrak{m}^2 - 6\mathfrak{m} + 1}{2\mathfrak{m}(\mathfrak{m}-1)}} \int_{\mathbb{R}} \int_0^1 \left\| v^{-\frac{k-\mathfrak{m}+2}{\mathfrak{m}-1}} \left(\mathcal{J}_+ \partial_x^k u^{\mathrm{hyp},+} \right) (t,vt + (1-\theta)\lambda^{-1}z) \right\|_{L^2_v(\Omega(t))} |z\chi(z)| d\theta dz \\ & \leq t^{\frac{k}{\mathfrak{m}-1} - \frac{1}{2\mathfrak{m}}} \left\| \widetilde{v}^{-\frac{k-\mathfrak{m}+2}{\mathfrak{m}-1}} \left(\mathcal{J}_+ \partial_x^k u^{\mathrm{hyp},+} \right) (t,\widetilde{v}) \right\|_{L^2_v} \\ & \lesssim t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}}, \end{split}$$

which shows the L^2 -estimate in (4.12).

Next, we consider the estimates in the frequency spaces. Because

$$\left| \int_{-\infty}^{0} \lambda^{-1} \chi_{1}(\lambda^{-1}(\xi - \xi_{v}), \lambda^{-1} \xi_{v}) d\xi \right| = \left| \int_{-\infty}^{-\lambda^{-1} \xi_{v}} \chi_{1}(\zeta, \lambda^{-1} \xi_{v}) d\zeta \right| \\ \leq C_{2} \left(t^{\frac{\mathsf{m}-1}{\mathsf{m}}} v\right)^{-\frac{\mathsf{m}}{2(\mathsf{m}-1)}},$$

Proposition 3.5, Lemma 4.1, (4.6), and (4.16) yield

$$\begin{split} & \left| \widehat{u}(t,\xi_{v}) - \sqrt{\mathfrak{m} - 1} e^{-\frac{1}{\mathfrak{m}} i t \xi_{v}^{\mathfrak{m}}} \gamma(t,v) \right| \\ & \leq \left| \int_{\mathbb{R}_{+}} \left(\widehat{u}(t,\xi_{v}) e^{\frac{1}{\mathfrak{m}} i t \xi_{v}^{\mathfrak{m}}} - \widehat{u}(t,\xi) e^{\frac{1}{\mathfrak{m}} i t \xi^{\mathfrak{m}}} \right) \lambda^{-1} \overline{\chi_{1}(\lambda^{-1}(\xi - \xi_{v}), \lambda^{-1}\xi_{v})} d\xi \right| \\ & + (C_{1} + C_{2}) (t^{\frac{\mathfrak{m} - 1}{\mathfrak{m}}} v)^{-\frac{\mathfrak{m}}{2(\mathfrak{m} - 1)}} |\widehat{u}(t,\xi_{v})| + C(t^{\frac{\mathfrak{m} - 1}{\mathfrak{m}}} v)^{-1} \cdot t^{-\frac{1}{2\mathfrak{m}}} ||u(t)||_{\widetilde{X}}. \end{split}$$

With a change of variables using $\zeta = \lambda^{-1}(\xi - \xi_v)$, we have

$$\left| \int_{\mathbb{R}_{+}} \left(\widehat{u}(t,\xi_{v}) e^{\frac{1}{\mathfrak{m}} it\xi_{v}^{\mathfrak{m}}} - \widehat{u}(t,\xi) e^{\frac{1}{\mathfrak{m}} it\xi^{\mathfrak{m}}} \right) \lambda^{-1} \overline{\chi_{1}(\lambda^{-1}(\xi-\xi_{v}),\lambda^{-1}\xi_{v})} d\xi \right|$$

$$(4.18) \qquad \leq \int_{\mathbb{R}} \left| \xi - \xi_{v} \right| \int_{0}^{1} \left| \widehat{\mathcal{J}} u(t,\theta(\xi_{v} - \xi) + \xi) \right| d\theta \lambda^{-1} |\chi_{1}(\lambda^{-1}(\xi - \xi_{v}),\lambda^{-1}\xi_{v})| d\xi$$

$$= \lambda \int_{\mathbb{R}} \int_{0}^{1} \left| \widehat{\mathcal{J}} u(t,\xi_{v} + \lambda\zeta(1-\theta)) \right| d\theta |\zeta\chi_{1}(\zeta,\lambda^{-1}\xi_{v})| d\zeta.$$

Because

$$|\widehat{u}(t,\xi_v)| \leq \left|\widehat{u}(t,\xi_v) - \sqrt{\mathfrak{m} - 1}e^{-\frac{1}{\mathfrak{m}}it\xi_v^{\mathfrak{m}}}\gamma(t,v)\right| + \sqrt{\mathfrak{m} - 1}|\gamma(t,v)|$$

and $\chi_1(\cdot, \alpha) \in \mathcal{S}(\mathbb{R})$ for $\alpha \geq 1$, by Proposition 3.5, (4.1), and (4.11), we have

$$\begin{split} & \left| \widehat{u}(t,\xi_{v}) - \sqrt{\mathfrak{m} - 1} e^{-\frac{1}{\mathfrak{m}} i t \xi_{v}^{\mathfrak{m}}} \gamma(t,v) \right| \\ & \lesssim \lambda^{\frac{1}{2}} \| \mathcal{J}u(t) \|_{L^{2}} + (t^{\frac{\mathfrak{m} - 1}{\mathfrak{m}}} v)^{-\frac{\mathfrak{m}}{2(\mathfrak{m} - 1)}} | \gamma(t,v) | + (t^{\frac{\mathfrak{m} - 1}{\mathfrak{m}}} v)^{-1} \cdot t^{-\frac{1}{2\mathfrak{m}}} \| u(t) \|_{\widetilde{X}}. \\ & \leq (t^{\frac{\mathfrak{m} - 1}{\mathfrak{m}}} v)^{-\frac{\mathfrak{m} - 2}{4(\mathfrak{m} - 1)}} \cdot t^{-\frac{1}{2\mathfrak{m}}} \| u(t) \|_{\widetilde{X}}. \end{split}$$

which shows the L^{∞} -estimate in (4.13).

For the L^2 -estimate in the frequency space, we change variables using $\tilde{\mathbf{v}} = \xi_v + \lambda \zeta(1-\theta)$. Because

$$\frac{d\widetilde{v}}{dv} = \frac{1}{\mathfrak{m} - 1} v^{-\frac{\mathfrak{m} - 2}{\mathfrak{m} - 1}} \left\{ 1 - \frac{\mathfrak{m} - 2}{2} \zeta (1 - \theta) t^{-\frac{1}{2}} v^{-\frac{\mathfrak{m}}{2(\mathfrak{m} - 1)}} \right\},\,$$

(4.18) yields

$$\begin{split} & \left\| \widehat{u}(t,\xi_v) - \sqrt{\mathfrak{m} - 1} e^{-\frac{1}{\mathfrak{m}} i t \xi_v^{\mathfrak{m}}} \gamma(t,v) \right\|_{L^2_v(\Omega(t))} \\ & \lesssim \int_0^1 \left\| \lambda \int_{\mathbb{R}} \left| \widehat{\mathcal{J}} u(t,\xi_v + \lambda \zeta(1-\theta)) \right| \left| \zeta \chi_1(\zeta,\lambda^{-1}\xi_v) \right| d\zeta \right\|_{L^2_v(\Omega(t))} d\theta \\ & + \left\| (t^{\frac{\mathfrak{m} - 1}{\mathfrak{m}}} v)^{-\frac{\mathfrak{m}}{2(\mathfrak{m} - 1)}} \widehat{u}(t,\xi_v) \right\|_{L^2_v(\Omega(t))} + t^{-\frac{\mathfrak{m} - 1}{2\mathfrak{m}}} \cdot t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}} \\ & \lesssim t^{-\frac{1}{2}} \left\| (\mathcal{J}u)(t,\widetilde{\mathbf{v}}) \right\|_{L^2_v} + t^{-\frac{\mathfrak{m} - 1}{2\mathfrak{m}}} \cdot t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}} \\ & \lesssim t^{-\frac{\mathfrak{m} - 1}{2\mathfrak{m}}} \cdot t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}}, \end{split}$$

which concludes the L^2 -estimate in (4.13)

5. Proof of the main theorem

We show the following estimate for $\dot{\gamma}$.

Proposition 5.1. Let u be a solution to (1.1) that satisfies (1.10). Then, for $t \ge 1$, we have

$$\left\| t \left(t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}} v \right)^{\frac{\mathfrak{m}-2}{4(\mathfrak{m}-1)}} \dot{\gamma}(t) \right\|_{L^{\infty}(\Omega(t))} + \left\| t^{\frac{3\mathfrak{m}-1}{2\mathfrak{m}}} \dot{\gamma}(t) \right\|_{L^{2}_{s}(\Omega(t))} \lesssim \varepsilon,$$

where the implicit constant is independent of D, T, and ε .

Proof. A direct calculation yields

$$\dot{\gamma}(t,v) = \int_{\mathbb{R}} \left(\mathcal{L}u \cdot \overline{\Psi_v} + u \overline{\mathcal{L}\Psi_v} \right) (t,x) dx$$
$$= -\int_{\mathbb{R}} \left(u^{\mathfrak{m}} \partial_x \overline{\Psi_v} \right) (t,x) dx + \int_{\mathbb{R}} \left(u \overline{\mathcal{L}\Psi_v} \right) (t,x) dx.$$

The bootstrap assumption (1.10) yields

$$\left| \int_{\mathbb{R}} \left(u^{\mathfrak{m}} \partial_x \overline{\Psi_v} \right) (t, x) dx \right| \lesssim t^{-1} \left(t^{\frac{\mathfrak{m} - 1}{\mathfrak{m}}} v \right)^{-\frac{\mathfrak{m}(\mathfrak{m} - 3)}{2(\mathfrak{m} - 1)}} (D \varepsilon)^{\mathfrak{m}} \leq t^{-1} \left(t^{\frac{\mathfrak{m} - 1}{\mathfrak{m}}} v \right)^{-\frac{\mathfrak{m}(\mathfrak{m} - 3)}{2(\mathfrak{m} - 1)}} \varepsilon.$$

Moreover, from (4.9), (4.6), Lemma 4.3, and Proposition 3.5, we have

$$\begin{split} & \left| \int_{\mathbb{R}} \left(u \overline{\mathcal{L} \Psi_{v}} \right)(t,x) dx \right| \\ & \lesssim \frac{1}{t\lambda} \left| \int_{\mathbb{R}} \left(e^{-i\phi} u^{\text{hyp},+} \overline{\partial_{x} \widetilde{\chi}} \right)(t,x) dx \right| + \frac{1}{t\lambda} \left| \int_{\mathbb{R}} \left(e^{-i\phi} \left(\overline{u^{\text{hyp},+}} + u^{\text{ell}} \right) \overline{\partial_{x} \widetilde{\chi}} \right)(t,x) dx \right| \\ & + \int_{\mathbb{R}} \left| (u \partial_{x}^{\mathfrak{m}} P^{-} \Psi_{v})(t,x) \right| dx + t^{-1} (t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}} v)^{-\frac{\mathfrak{m}}{\mathfrak{m}-1}} \int_{\mathbb{R}} |u(t,x) \boldsymbol{X}(\lambda(x-vt))| dx \\ & \lesssim t^{-\frac{\mathfrak{m}^{2}-\mathfrak{m}+1}{\mathfrak{m}(\mathfrak{m}-1)}} (t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}} v)^{\frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}} \int_{\mathbb{R}} \left| \mathcal{J}_{+} u^{\text{hyp},+}(t,x) \widetilde{\chi}(t,x) \right| dx \\ & + t^{-1} (t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}} v)^{-\frac{2\mathfrak{m}-1}{2(\mathfrak{m}-1)}} \cdot t^{-\frac{1}{2\mathfrak{m}}} \|u(t)\|_{\widetilde{X}}. \end{split}$$

Here, from (3.11), we obtain

$$t^{-\frac{\mathfrak{m}^{2}-\mathfrak{m}+1}{\mathfrak{m}(\mathfrak{m}-1)}}(t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}}v)^{\frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}}\int_{\mathbb{R}}\left|\mathcal{J}_{+}u^{\text{hyp},+}(t,x)\widetilde{\chi}(t,x)\right|dx$$

$$\lesssim t^{-\frac{\mathfrak{m}+1}{\mathfrak{m}}}(t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}}v)^{-\frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}}\left\||x|^{\frac{\mathfrak{m}-2}{\mathfrak{m}-1}}\mathcal{J}_{+}u^{\text{hyp},+}(t)\right\|_{L^{2}}\|\widetilde{\chi}(t)\|_{L^{2}}$$

$$\lesssim t^{-1}(t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}}v)^{-\frac{\mathfrak{m}-2}{4(\mathfrak{m}-1)}}\cdot t^{-\frac{1}{2\mathfrak{m}}}\|u(t)\|_{\widetilde{X}}.$$

In addition, we use (3.11) and (4.14) to obtain

$$\begin{split} & \left\| t^{-\frac{\mathsf{m}^2 - \mathsf{m} + 1}{\mathsf{m}(\mathsf{m} - 1)}} (t^{\frac{\mathsf{m} - 1}{\mathsf{m}}} v)^{\frac{\mathsf{m} - 2}{2(\mathsf{m} - 1)}} \int_{\mathbb{R}} \left| \mathcal{J}_{+} u^{\mathsf{hyp}, +}(t, x) \widetilde{\chi}(t, x) \right| dx \right\|_{L_{v}^{2}(\Omega(t))} \\ & \lesssim t^{-\frac{3}{2}} \left\| |x|^{\frac{\mathsf{m} - 2}{\mathsf{m} - 1}} \mathcal{J}_{+} u^{\mathsf{hyp}, +} \right\|_{L^{2}} \\ & \lesssim t^{-\frac{3\mathsf{m} - 1}{2\mathsf{m}}} \cdot t^{-\frac{1}{2\mathsf{m}}} \|u(t)\|_{\widetilde{X}}. \end{split}$$

First, we prove global existence of the solution to (1.1). From Proposition 1.4 and Lemma 2.1, this is equivalent to showing (1.4), that is to say, to closing the bootstrap estimate (1.10). When $t^{-\frac{1}{m}}|x| \lesssim 1$, Lemma 2.3 and Proposition 3.5 yield

$$\left\| \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{-\frac{k}{\mathfrak{m}-1} + \frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}} \partial_x^k u(t) \right\|_{L^{\infty}(t^{-\frac{1}{\mathfrak{m}}}|x| \lesssim 1)} \lesssim \varepsilon t^{-\frac{k+1}{\mathfrak{m}}}.$$

When $t^{-\frac{1}{m}}|x| \gtrsim 1$, owing to (4.12), we only need to show that

$$\|\gamma(t)\|_{L_v^\infty(\Omega(t))} \lesssim \varepsilon,$$

where the implicit constant is independent of D, T, and ε .

For $v \geq C_*$, where C_* is defined by (4.11), the Gagliardo-Nirenberg inequality, Proposition 1.4 and Lemma 4.1 lead to

$$|\gamma(1,v)| \lesssim \|\widehat{u}(1)\|_{L^{\infty}} = \left\| e^{\frac{1}{\mathfrak{m}}i|\xi|^{\mathfrak{m}-1}\xi} \widehat{u}(1) \right\|_{L^{\infty}} \lesssim \|u(1)\|_{L^{2}}^{\frac{1}{2}} \|\mathcal{J}u(1)\|_{L^{2}}^{\frac{1}{2}} \lesssim \varepsilon.$$

The fundamental theorem of calculus and Proposition 5.1 yield

$$\gamma(t,v) = \gamma(1,v) + O\left(\varepsilon(t^{\frac{m-1}{m}}v)^{-\frac{m-2}{4(m-1)}}\right),\,$$

which implies

$$|\gamma(t,v)| \lesssim \varepsilon$$

for $t \in [1, T]$.

When $0 < v < C_*$, set $t_0 := (C_* v^{-1})^{\frac{m}{m-1}} > 1$. Note that $v \in \Omega(t)$ for $t \ge t_0$. Then, Bernstein's inequality, (4.6), Proposition 3.5, and Lemma 2.3 yield

$$|\gamma(t_0, v)| \lesssim t_0^{\frac{1}{2m}} \sum_{\substack{N \in 2^{\mathbb{Z}} \\ N \sim t_0^{-\frac{1}{m}}}} ||u_N(t_0)||_{L^2} + \varepsilon \lesssim \varepsilon.$$

The fundamental theorem of calculus and Proposition 5.1 lead to

$$\gamma(t, v) = \gamma(t_0, v) + O(\varepsilon),$$

which implies

$$|\gamma(t,v)| \lesssim \varepsilon$$

for $t \in [t_0, T]$. Accordingly, we conclude that (1.4) holds for any $t \in [1, T]$.

Second, we show the existence of a self-similar solution. We use the self-similar change of variables (2.2). Let $\rho > 0$ be a constant specified later. We set $\mathfrak{Y}(t) :=$

 $\{y \in \mathbb{R} \colon |y| \le C_* t^{(\mathfrak{m}-1)\rho}\}$ and $\mathfrak{C} := 4(\kappa C_*)^{\frac{1}{\mathfrak{m}-1}}$. For $k = 0, 1, \ldots, \mathfrak{m} - 2$, estimates (2.4) and (3.6) and Lemmas 2.1 and 2.3 imply that

$$\begin{split} & \left\| \partial_t \left(P_{\leq \mathfrak{C} t^\rho} \partial_y^k U \right) \right\|_{L_y^\infty(\mathfrak{Y}(t))} \\ & \lesssim t^{(k+\frac{1}{2})\rho} \left\| P_{\leq \mathfrak{C} t^\rho} \partial_t U \right\|_{L_y^2} + t^{-1} \| P_{\mathfrak{C} t^\rho} \partial_y^k U \|_{L_y^\infty(\mathfrak{Y}(t))} \\ & \lesssim t^{(k+\frac{3}{2})\rho - \frac{1}{2\mathfrak{m}} - 1} \| \Lambda u \|_{L_x^2} + t^{(k+\frac{1}{2})\rho + \frac{1}{2\mathfrak{m}} - 1} \sum_{N \in 2^{\mathbb{Z}}} \| u_N^{\mathrm{ell},+} \|_{L^2} \\ & \leq \varepsilon t^{-1 + (k+\frac{3}{2})\rho - \min\left(\frac{1}{2\mathfrak{m}} - \varepsilon, \mathfrak{m}\rho\right)}. \end{split}$$

Furthermore, (3.3), (3.6), and Lemma 2.3 yield

$$\begin{split} \|P_{>\mathfrak{C}t^{\rho}}\partial_y^k U\|_{L_y^{\infty}(\mathfrak{Y}(t))} &\lesssim t^{\frac{k+1}{\mathfrak{m}}} \sum_{\substack{N \in 2^{\mathbb{Z}} \\ N > \mathfrak{C}t^{\rho - \frac{1}{\mathfrak{m}}}}} N^{k+\frac{1}{2}} \|u_N^{\mathrm{ell},+}\|_{L^2} \\ &+ t^{\frac{k+1}{\mathfrak{m}}} \sum_{\substack{N \in 2^{\mathbb{Z}} \\ N > \mathfrak{C}t^{\rho - \frac{1}{\mathfrak{m}}}}} \left\| \left(1 - P_{\frac{N}{2} \le \cdot \le 2N}\right) |\partial_x|^{k+\frac{1}{2}} u_N^{\mathrm{ell},+} \right\|_{L^2} \\ &\lesssim t^{(k-\mathfrak{m}+\frac{3}{2})\rho} \varepsilon, \\ \|P_{>\mathfrak{C}t^{\rho}}\partial_x^k U\|_{L_y^2(\mathfrak{Y}(t))} &\lesssim t^{\frac{k}{\mathfrak{m}}+\frac{1}{2\mathfrak{m}}} \sum_{\substack{N \in 2^{\mathbb{Z}} \\ N > \mathfrak{C}t^{\rho - \frac{1}{\mathfrak{m}}}}} N^k \|u_N^{\mathrm{ell},+}\|_{L^2} \\ &+ t^{\frac{k}{\mathfrak{m}}+\frac{1}{2\mathfrak{m}}} \sum_{\substack{N \in 2^{\mathbb{Z}} \\ N > \mathfrak{C}t^{\rho - \frac{1}{\mathfrak{m}}}}} \left\| \left(1 - P_{\frac{N}{2} \le \cdot \le 2N}\right) |\partial_x|^k u_N^{\mathrm{ell},+} \right\|_{L^2} \\ &\lesssim t^{(k-\mathfrak{m}+1)\rho} \varepsilon. \end{split}$$

By setting $\rho := \frac{1}{\mathfrak{m}}(\frac{1}{2\mathfrak{m}} - \varepsilon)$, there exists $Q = Q(y) \in L_y^{\infty}(\mathbb{R})$ such that (5.1)

$$\|\partial_y^k U(t) - \partial_y^k Q\|_{L^\infty_x(\mathfrak{Y}(t))} \lesssim \varepsilon t^{(k-\mathfrak{m}+\frac{3}{2})\rho}, \quad \|\partial_x^k U(t) - \partial_x^k Q\|_{L^2_x(\mathfrak{Y}(t))} \lesssim \varepsilon t^{(k-\mathfrak{m}+1)\rho}.$$

By (1.4) and the first estimate in (5.1), we see that (5.2)

$$\begin{split} \left\| \langle \cdot \rangle^{\frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}} Q \right\|_{L^{\infty}(\mathbb{R})} & \leq \lim_{t \to \infty} \left(t^{\frac{\mathfrak{m}-2}{2}\rho} \left\| Q - U(t) \right\|_{L^{\infty}(\mathfrak{Y}(t))} + \left\| \langle \cdot \rangle^{\frac{\mathfrak{m}-2}{2(\mathfrak{m}-1)}} U(t) \right\|_{L^{\infty}(\mathbb{R})} \right) \\ & \lesssim \varepsilon. \end{split}$$

Because Lemma 2.3 implies that

$$(5.3) \qquad \qquad \left\| |\partial_y|^{\mathfrak{m}-1} U - y U - \mathfrak{m} U^{\mathfrak{m}} \right\|_{L^2_y} = \left\| (\Lambda u)(t, t^{\frac{1}{\mathfrak{m}}} y) \right\|_{L^2_x} \lesssim t^{-\frac{1}{2\mathfrak{m}} + \varepsilon},$$

by taking the limit as $t \to \infty$, we have that Q is a solution to (1.5). Moreover, (5.1) and the mass conservation law yield

$$\int_{\mathbb{R}} Q(y)dy = \lim_{t \to \infty} \int_{\mathbb{R}} U(t, y)dy = \int_{\mathbb{R}} u_0(x)dx.$$

Therefore, $\mathfrak{u}(t,x) := t^{-\frac{1}{m}}Q(t^{-\frac{1}{m}}x)$ is a solution to (1.1) with $\mathfrak{u}(0) = \int_{\mathbb{R}} u_0(x)dx\delta_0$, where δ_0 denotes the Dirac delta measure concentrated at the origin.

Finally, we prove the asymptotic behavior of the global solution. The estimates in the self-similar region $\mathfrak{X}^0(t)$ follow from (5.1). Moreover, the estimates in the decaying region $\mathfrak{X}^-(t)$ are consequences of Lemma 2.3, (3.12), and (3.15). Hence, we only need to show the estimates in the oscillatory region $\mathfrak{X}^+(t)$. Proposition 5.1 yields

(5.4)
$$\gamma(t,v) = \gamma(1,v) + \widetilde{R}(t,v),$$

where

$$\left\|(t^{\frac{\mathfrak{m}-1}{\mathfrak{m}}}v)^{\frac{\mathfrak{m}-2}{4(\mathfrak{m}-1)}}\widetilde{R}(t,v)\right\|_{L^{\infty}(\Omega(t))}+\left\|t^{\frac{\mathfrak{m}-1}{2\mathfrak{m}}}\widetilde{R}(t,v)\right\|_{L^{2}(\Omega(t))}\lesssim \varepsilon.$$

Here, we set

$$W(\xi) := \sqrt{\mathfrak{m} - 1} \gamma(1, \xi^{\mathfrak{m} - 1}),$$

and extend W to \mathbb{R} by defining

$$W(-\xi) = \overline{W(\xi)}, \quad W(0) = \int_{\mathbb{R}} u_0(x) dx.$$

Then, from (1.4) and (4.14), we see that

$$||W||_{L^{\infty}\cap L^2} \lesssim ||u(1)||_{L^{\infty}\cap L^2} \lesssim \varepsilon.$$

Proposition 4.4 and (5.4) show the estimates in $\mathfrak{X}^+(t)$.

Appendix A. Well-posedness

In this appendix, we show the local-in-time well-posedness of the Cauchy problem of (1.6) as well as (1.1). Here, we assume $\mathfrak{p} \geq \mathfrak{m} \geq 3$.

To show well-posedness for (1.1), we can apply the Fourier restriction norm method. In fact, Grünrock [4] proved well-posedness for (1.1) in $H^s(\mathbb{R})$ for odd values of $\mathfrak{m} \geq 5$ and $s > -\frac{1}{2}$. On the other hand, because F may not be a polynomial with respect to u, some regularity is needed to be well-posed for (1.6).

We need to introduce some notation. Let $1 \le p, q \le \infty$ and T > 0. Define

$$||f||_{L^p_x L^q_T} := \left(\int_{-\infty}^{\infty} \left(\int_{-T}^T |f(t,x)|^q dt \right)^{\frac{p}{q}} dx \right)^{\frac{1}{p}},$$

$$||f||_{L^q_T L^p_x} := \left(\int_{-T}^T \left(\int_{-\infty}^\infty |f(t,x)|^p dt \right)^{\frac{q}{p}} dx \right)^{\frac{1}{q}},$$

with T = t to indicate the case when $T = \infty$.

The maximal function estimate and the local smoothing estimate are the main tools in the proof (see Theorems 2.5 and 4.1 in [18] respectively).

Theorem A.1.

$$\|\mathcal{U}(t)u_0\|_{L^4_xL^\infty_t} \lesssim \left\| |\partial_x|^{\frac{1}{4}}u_0 \right\|_{L^2}, \quad \left\| |\partial_x|^{\frac{m-1}{2}}\mathcal{U}(t)u_0 \right\|_{L^\infty_xL^2_t} \lesssim \|u_0\|_{L^2}.$$

Stein's interpolation [26] and Theorem A.1 yield the following.

Lemma A.2. For any value of α where $-\frac{1}{4} \leq \alpha \leq \frac{\mathfrak{m}-1}{2}$, we have

$$\|\partial_x|^{\alpha} \mathcal{U}(t) u_0\|_{L_x^{\frac{2(2m-1)}{m-1-2\alpha}} L_t^{\frac{2(2m-1)}{1+4\alpha}}} \lesssim \|u_0\|_{L^2}.$$

In particular, by setting $\alpha = 0$ or $\alpha = 1$, it follows that

(A.1)
$$\|\mathcal{U}(t)u_0\|_{L_x^{\frac{2(2m-1)}{m-1}}L_x^{2(2m-1)}} + \|\partial_x\mathcal{U}(t)u_0\|_{L_x^{\frac{2(2m-1)}{m-3}}L_x^{\frac{2(2m-1)}{5}}} \lesssim \|u_0\|_{L^2}.$$

Moreover, setting $\alpha = \frac{\mathfrak{p} + \mathfrak{m} - 3}{2(\mathfrak{p} - 1)}$, we have

(A.2)
$$\|\partial_x \mathcal{U}(t) u_0\|_{L_x^{p_0} L_t^{q_0}} \lesssim \|\partial_x|^{\frac{p-m+1}{2(p-1)}} u_0\|_{L^2},$$

where
$$(p_0, q_0) := \left(\frac{2(2\mathfrak{m}-1)(\mathfrak{p}-1)}{(\mathfrak{m}-2)(\mathfrak{p}-2)}, \frac{2(2\mathfrak{m}-1)(\mathfrak{p}-1)}{3\mathfrak{p}+2\mathfrak{m}-7}\right).$$

where $(p_0, q_0) := \left(\frac{2(2\mathfrak{m}-1)(\mathfrak{p}-1)}{(\mathfrak{m}-2)(\mathfrak{p}-2)}, \frac{2(2\mathfrak{m}-1)(\mathfrak{p}-1)}{3\mathfrak{p}+2\mathfrak{m}-7}\right)$. Our next result is a Sobolev type of estimate (the proof is the same as that of Lemma 3.15 in [19]).

Lemma A.3. For any $q \in \mathbb{R}$ with $\max\left(\frac{-\mathfrak{p}+2\mathfrak{m}-3}{2(2\mathfrak{m}-1)(\mathfrak{p}-1)},0\right) < \frac{1}{q} < \frac{\mathfrak{m}-2}{2\mathfrak{m}(\mathfrak{p}-1)}$, we have

$$||g||_{L_x^{r(q)}L_t^q} \lesssim ||\partial_x|^{\alpha(q)}g||_{L_x^{\frac{4q}{q-2}}L_t^q},$$

where
$$\frac{1}{r(q)} := -\frac{m}{q} + \frac{m-2}{2(\mathfrak{p}-1)}$$
 and $\alpha(q) := \frac{2m-1}{2q} - \frac{m-2}{2(\mathfrak{p}-1)} + \frac{1}{4}$.

Proof. The assumption implies that $0 < \alpha(q) < 1$. Fix t now and use the fractional integration in x to obtain the representation

$$g(t,x) = c_q \int_{-\infty}^{\infty} \frac{1}{|x-y|^{1-\alpha(q)}} \left(|\partial_x|^{\alpha(q)} g \right) (t,y) dy.$$

By Minkowski's inequality, we have

$$\|g(x)\|_{L_t^q} \lesssim \int_{-\infty}^{\infty} \frac{1}{|x-y|^{1-\alpha(q)}} \left\| \left(|\partial_x|^{\alpha(q)} g \right) (y) \right\|_{L_t^q} dy.$$

From $\alpha(q) = \frac{q-2}{4q} - \frac{1}{r(q)}$, Hardy-Littlewood-Sobolev's inequality yields the desired bound.

Lemma A.2 with $\alpha = \frac{2\mathfrak{m}-1}{2a} - \frac{1}{4}$ implies

(A.3)
$$\left\| |\partial_x|^{\alpha(q)} \mathcal{U}(t) u_0 \right\|_{L^{\frac{4q}{q-2}} L^{\frac{q}{4}}} \lesssim \left\| |\partial_x|^{\frac{\mathfrak{p}-\mathfrak{m}+1}{2(\mathfrak{p}-1)}} u_0 \right\|_{L^2}$$

provided that
$$q \in [2, \infty]$$
.
Setting $q_1 := \frac{(2\mathfrak{m}-1)(\mathfrak{p}-1)}{\mathfrak{m}-3}, \ q_2 := \frac{2(2\mathfrak{m}-1)(\mathfrak{p}-1)(\mathfrak{p}-2)}{(2\mathfrak{m}-5)\mathfrak{p}-4\mathfrak{m}+9}, \ \text{and} \ q_3 := \frac{2\mathfrak{m}\mathfrak{p}(\mathfrak{p}-1)}{(\mathfrak{m}-3)\mathfrak{p}+1}, \ \text{we define}$

$$||u||_{Y_T} := ||u||_{L_T^{\infty} L_x^2} + ||u||_{L_x^{\frac{2(2m-1)}{m-1}} L_T^{2(2m-1)}} + ||\partial_x u||_{L_x^{\frac{2(2m-1)}{m-3}} L_T^{\frac{2(2m-1)}{5}}},$$

$$||u||_{\widetilde{Y}_T} := ||\partial_x u||_{L_x^{p_0} L_T^{q_0}} + \sum_{j=1}^3 ||\partial_x|^{\alpha(q_j)} u||_{L_x^{\frac{4q_j}{q_j - 2}} L_T^{q_j}},$$

$$||u||_{Z_T^s} := ||\langle \partial_x \rangle^s u||_{Y_T} + ||\Lambda u||_{Y_T} + ||u||_{\widetilde{Y}_T},$$

$$Z_T^s := \{ u \in C([-T, T]; H^s(\mathbb{R})) \colon ||u||_{Z_T^s} < \infty \}$$

for $\mathfrak{p} \geq \mathfrak{m} \geq 3$, $s \in \mathbb{R}$, and T > 0.

The linear estimates (A.1), (A.2), and (A.3) lead to

(A.4)
$$\|\mathcal{U}(t)u_0\|_{Y_T} \lesssim \|u_0\|_{L^2}, \|\mathcal{U}(t)u_0\|_{\widetilde{Y}_T} \lesssim \|u_0\|_{L^{\frac{p-m+1}{2(p-1)}}}.$$

We note that if u is a solution to (1.6), then

(A.5)
$$\mathcal{L}\Lambda u = \left(\mathfrak{m}u^{\mathfrak{m}-1} + F'(u)\right)\partial_x \Lambda u + \mathfrak{m}F(u) - F'(u)u.$$

Proposition A.4. Let $\mathfrak{p} \geq \mathfrak{m} \geq 3$ and $\frac{\mathfrak{p}-\mathfrak{m}+1}{2(\mathfrak{p}-1)} \leq s < 1$. If $u_0 \in \Sigma^s(\mathbb{R})$, then there exists a value T > 0 that depends on $\|u_0\|_{\Sigma^{\frac{\mathfrak{p}-\mathfrak{m}+1}{2(\mathfrak{p}-1)}}}$ and a unique solution $u \in Z_T^s$ to (1.6) satisfying

$$\sup_{t \in [-T,T]} (\|u(t)\|_{H^s} + \|\Lambda u(t)\|_{L^2}) \lesssim \|u_0\|_{\Sigma^s}.$$

Moreover, the flow map $u_0 \in \Sigma^s(\mathbb{R}) \mapsto u \in Z_T^s$ is locally Lipschitz continuous.

 ${\it Proof.}$ The fractional Leibnitz and chain rules (see Appendix in [19]) and Lemma A.3 yield

$$\begin{split} & \||\partial_x|^s (F'(u)\partial_x u)\|_{L^2_{T,x}} \\ & \lesssim \||\partial_x|^s \partial_x u\|_{L^{\frac{2(2\mathfrak{m}-1)}{\mathfrak{m}-3}}_x L^{\frac{2(2\mathfrak{m}-1)}{5}}_T \||u|^{\mathfrak{p}-1}\|_{L^{\frac{2(2\mathfrak{m}-1)}{\mathfrak{m}+2}}_x L^{\frac{2\mathfrak{m}-1}{\mathfrak{m}-3}}_T \\ & + \||\partial_x|^s u\|_{L^{\frac{2(2\mathfrak{m}-1)}{\mathfrak{m}-1}}_x L^{2(2\mathfrak{m}-1)}_T \||\partial_x u\|_{L^{p_0}_x L^{q_0}_t} \||u|^{\mathfrak{p}-2}\|_{L^{\frac{2(2\mathfrak{m}-1)(\mathfrak{p}-1)}{2\mathfrak{p}+\mathfrak{m}-4}}_x L^{\frac{2(2\mathfrak{m}-1)(\mathfrak{p}-1)}{2\mathfrak{p}+\mathfrak{m}-4}}_t L^{\frac{2(2\mathfrak{m}-1)(\mathfrak{p}-1)}{2\mathfrak{m}-5)\mathfrak{p}-4\mathfrak{m}+9} \\ & \lesssim \||\partial_x|^s u\|_{Y_T} \left(\|u\|_{L^{r(q_1)}_x L^{q_1}_T}^{\mathfrak{p}-1} + \|\partial_x u\|_{L^{p_0}_x L^{q_0}_t} \|u\|_{L^{r(q_2)}_x L^{q_2}_t}^{\mathfrak{p}-2} \right) \\ & \lesssim \||\partial_x|^s u\|_{Y_T} \|u\|_{\widetilde{Y}_T}^{\mathfrak{p}-1}. \end{split}$$

In addition, Hölder's inequality and Lemma A.3 imply

We define the operator $K_{u_0}(u)$ by

$$K_{u_0}(u) = \mathcal{U}(t)u_0 + \int_0^t \mathcal{U}(t - t')\partial_x \left(u^{\mathfrak{m}} + F(u)\right)(t')dt'.$$

By (A.5), the estimates (A.4), (A.6), and (A.7) show that

$$||K_{u_0}(t)||_{Z_T^s}$$

$$\lesssim \|\mathcal{U}(t)u_0\|_{Z_T^s} + \int_{-T}^T \left(\|u^{\mathfrak{m}-1}\partial_x u\|_{H_x^s} + \|u^{\mathfrak{m}-1}\partial_x \Lambda u\|_{L_x^2} \right. \\ + \|F'(u)\partial_x u\|_{H_x^s} + \|F'(u)\partial_x \Lambda u\|_{L_x^2} + \||u|^{\mathfrak{p}}\|_{L_x^2} \right) (t) dt \\ \lesssim \|u_0\|_{H^s} + \|xu_0\|_{L^2} + T^{\frac{1}{2}} \left(\|\langle \partial_x \rangle^s (u^{\mathfrak{m}-1}\partial_x u)\|_{L_{T,x}^2} + \|u^{\mathfrak{m}-1}\partial_x \Lambda u\|_{L_{T,x}^2} \right. \\ + \|\langle \partial_x \rangle^s (F'(u)\partial_x u)\|_{L_{T,x}^2} + \|F'(u)\partial_x \Lambda u\|_{L_{T,x}^2} + \||u|^{\mathfrak{p}}\|_{L_{T,x}^2} \right) \\ \leq C \|u_0\|_{\Sigma^s} + CT^{\frac{1}{2}} \|u\|_{Z_T^s} \left(\|u\|_{\widetilde{Y}_T}^{\mathfrak{m}-1} + \|u\|_{\widetilde{Y}_T}^{\mathfrak{p}-1} \right).$$

A similar calculation as above yields

$$\begin{aligned} & \|K_{u_0}(u_1) - K_{u_0}(u_2)\|_{Z_T^s} \\ & \leq CT^{\frac{1}{2}} \left(\|u_1\|_{\widetilde{Y}_T}^{\mathfrak{m}-1} + \|u_2\|_{\widetilde{Y}_T}^{\mathfrak{m}-1} + \|u_1\|_{\widetilde{Y}_T}^{\mathfrak{p}-1} + \|u_2\|_{\widetilde{Y}_T}^{\mathfrak{p}-1} \right) \|u_1 - u_2\|_{Z_T^s}. \end{aligned}$$

Hence, taking T > 0 with

$$10CT^{\frac{1}{2}}\left\{ \left(2C\|u_0\|_{\Sigma^{\frac{p-m+1}{2(p-1)}}}\right)^{m-1} + \left(2C\|u_0\|_{\Sigma^{\frac{p-m+1}{2(p-1)}}}\right)^{p-1}\right\} \le 1,$$

we find that the mapping K_{u_0} is a contraction on the ball

$$B(2C||u_0||_{\Sigma^s}) := \{ u \in Z_T^s \colon ||u||_{Z_T^s} \le 2C||u_0||_{\Sigma^s} \}.$$

Accordingly, there exists a unique solution $u \in B(2C||u_0||_{\Sigma^s})$ to (1.6).

APPENDIX B. SHORT-RANGE PERTURBATIONS

In this appendix, we outline some modifications to Theorem 1.1 in the case of short-range perturbations (1.6). The main differences appear in the energy estimate.

Let $\mathfrak p$ be a real number with $\mathfrak p>\mathfrak m$. The existence of a local-in-time solution u with $\mathcal U(-t)u(t)\in \Sigma^{\frac{\mathfrak p-1}{2\mathfrak p}}(\mathbb R)$ follows from Proposition A.4 and $H^{\frac{\mathfrak p-1}{2\mathfrak p}}(\mathbb R)\hookrightarrow L^{2\mathfrak p}(\mathbb R)$.

We need some modifications in the energy estimate for Λu when $\mathfrak{p} \in (\mathfrak{m}, \mathfrak{m} + \frac{1}{2})$, because the second and third terms on the right hand side of (A.5) do not have enough decay. Set $\mathfrak{a} := \max(\frac{2\mathfrak{m}+1-2\mathfrak{p}}{2\mathfrak{m}}, 0)$. Because (1.10) yields

$$\begin{split} \|\mathfrak{m}F(u) - F'(u)u\|_{L^{2}} &\lesssim \||u|^{\mathfrak{p}}\|_{L^{2}} \\ &\lesssim (D\varepsilon)^{\mathfrak{p}} t^{-\frac{\mathfrak{p}}{\mathfrak{m}}} \left(\int_{|x| \leq t^{\frac{1}{\mathfrak{m}}}} dx + \int_{|x| \geq t^{\frac{1}{\mathfrak{m}}}} \langle t^{-\frac{1}{\mathfrak{m}}} x \rangle^{-\frac{\mathfrak{p}(\mathfrak{m}-2)}{\mathfrak{m}-1}} dx \right)^{\frac{1}{2}} \\ &\lesssim (D\varepsilon)^{\mathfrak{p}} t^{-\frac{2\mathfrak{p}-1}{2\mathfrak{m}}}, \end{split}$$

we have

$$\begin{split} &\frac{1}{2}\partial_{t}\left(t^{-\mathfrak{a}}\|\Lambda u(t)\|_{L^{2}}\right)^{2} \\ &= -\mathfrak{a}t^{-2\mathfrak{a}-1}\|\Lambda u(t)\|_{L^{2}}^{2} - \frac{\mathfrak{m}(\mathfrak{m}-1)}{2}t^{-2\mathfrak{a}}\int_{\mathbb{R}}u^{\mathfrak{m}-2}\partial_{x}u(\Lambda u)^{2}dx \\ &- \frac{1}{2}t^{-2\mathfrak{a}}\int_{\mathbb{R}}F''(u)\partial_{x}u(\Lambda u)^{2}dx + O\left((D\varepsilon)^{\mathfrak{p}}t^{-2\mathfrak{a}-\frac{2\mathfrak{p}-1}{2\mathfrak{m}}}\|\Lambda u(t)\|_{L^{2}}\right) \\ &\leq (D\varepsilon)^{\mathfrak{m}-1}t^{-1}\left(t^{-\mathfrak{a}}\|\Lambda u(t)\|_{L^{2}}\right)^{2} + (D\varepsilon)^{2\mathfrak{p}-\mathfrak{m}+1}t^{-2\mathfrak{a}+1-\frac{2\mathfrak{p}-1}{\mathfrak{m}}}. \end{split}$$

Hence, Gronwall's inequality shows

$$||u(t)||_X \lesssim \varepsilon \langle t \rangle^{\mathfrak{a} + \varepsilon}.$$

From $\mathfrak{a} < \frac{1}{2\mathfrak{m}}$, Lemma 2.3 holds true as long as $||u_0||_{\Sigma^{\frac{\mathfrak{p}-1}{2\mathfrak{p}}}} \leq \varepsilon \ll 1$. Moreover, (5.3) is replaced with

$$\left\| |\partial_y|^{\mathfrak{m}-1} U - y U - \mathfrak{m} U^{\mathfrak{m}} \right\|_{L^2_y} = \left\| (\Lambda u)(t, t^{\frac{1}{\mathfrak{m}}} y) + t F(u(t, t^{\frac{1}{\mathfrak{m}}} y)) \right\|_{L^2_y} \lesssim t^{-\frac{1}{2\mathfrak{m}} + \mathfrak{a} + \varepsilon}.$$

The remaining arguments in §5 are unchanged as long as $\rho = \frac{1}{\mathfrak{m}}(\frac{1}{2\mathfrak{m}} - \varepsilon)$ is replaced with $\widetilde{\rho} := \frac{1}{\mathfrak{m}}(\frac{1}{2\mathfrak{m}} - \mathfrak{a} - \varepsilon)$.
