GENERIC TORUS ORBIT CLOSURES IN FLAG BOTT MANIFOLDS

Abstract. In this article the generic torus orbit closure in a flag Bott manifold is shown to be a non-singular toric variety, and its fan structure is explicitly calculated.

1. INTRODUCTION

On the full flag manifold $\mathcal{F}\ell(\mathbb{C}^{n+1})$ there is an effective action of complex torus $(\mathbb{C}^*)^n$. The generic torus orbit closure, which is the closure of a generic $(\mathbb{C}^*)^n$ -orbit, in the full flag manifold is well-known to be a non-singular toric variety, called the permutohedral variety. The fan of the permutohedral variety consists of Weyl chambers of a Lie group of A_n -type as its maximal cones. Note that the closure of an arbitrary $(\mathbb{C}^*)^n$ -orbit is known to be normal hence a toric variety, see [\[CK00,](#page-11-0) Proposition 4.8], but non-singularity of it is not determined in general.

Generic torus orbit closures in a generalized flag manifold G/P are studied in [\[FH91\]](#page-12-0) and [\[Dab96\]](#page-11-1), and arbitrary orbit closures in Grassmannian manifolds are studied in [\[GGMS87\]](#page-12-1), [\[GS87\]](#page-12-2), [\[BT18\]](#page-11-2). Furthermore generic torus orbit closures in Schubert varieties are studied in [\[LM18\]](#page-12-3).

In [\[KLSS17\]](#page-12-4), the notion of flag Bott manifold is introduced as a generalization of both full flag manifolds and Bott manifolds. In fact, a flag Bott manifold F_m is the total space of an m -sequence of iterated fiber bundles whose fibers are full flag manifolds $\mathcal{F}\ell(\mathbb{C}^{n_j+1})$ for $j = 1, ..., m$, and there is an effective action of complex torus **H** of rank $n = n_1 + \cdots + n_m$. Therefore, it would be interesting to know when a torus orbit closure of F_m is a non-singular toric variety and to determine its fan structure.

Certain flag Bott manifolds are constructed from generalized Bott manifolds B_m , and such manifolds are called the associated flag Bott manifolds to B_m . It is shown in [\[KLSS17\]](#page-12-4) that the generic torus orbit closure in the associated flag Bott manifold to B_m is a non-singular toric variety, and such toric variety can be obtained from B_m through a sequence of blow-ups.

In this article, we consider the generic torus orbit closure X of an arbitrary flag Bott manifold F_m . The toric variety X is the total space of an m-sequence of iterated fiber bundles with permutohedral varieties as its fibers. We calculate the

fan of X in Theorem [3.2.](#page-4-0) As a consequence we can see that X is a non-singular toric variety, see Proposition [3.5.](#page-5-0)

2. Flag Bott Manifolds

In this section we recall flag Bott manifolds from [\[KLSS17\]](#page-12-4) and consider their orbit space construction. Let M be a complex manifold and E an n-dimensional holomorphic vector bundle over M. Recall from [\[BT82,](#page-11-3) p. 282] that the *associated* flag bundle $\mathcal{F}\ell(E) \to M$ is obtained from E by replacing each fiber E_p by the full flag manifold $\mathcal{F}\ell(E_p)$.

Definition 2.1 (KLSS17, Definition 2.1)). A flag Bott tower $F_{\bullet} = \{F_i | 0 \leq j \leq n\}$ m of height m (or an m-stage flag Bott tower) is a sequence,

$$
F_m \xrightarrow{p_m} F_{m-1} \xrightarrow{p_{m-1}} \cdots \xrightarrow{p_2} F_1 \xrightarrow{p_1} F_0 = \{a \text{ point}\},
$$

of manifolds $F_j = \mathcal{F}\ell\left(\bigoplus_{k=1}^{n_j+1} \xi_k^{(j)}\right)$ $\binom{(j)}{k}$ where $\xi_k^{(j)}$ $\binom{1}{k}$ is a holomorphic line bundle over F_{j-1} for each $1 \leq k \leq n_j + 1$ and $1 \leq j \leq m$. We call F_j the j-stage flag Bott manifold of the flag Bott tower.

The full flag manifold $\mathcal{F}\ell(\mathbb{C}^{n+1}) = \mathcal{F}\ell(n+1)$ is a flag Bott manifold, and the product of flag manifolds $\mathcal{F}\ell(n_1+1) \times \cdots \times \mathcal{F}\ell(n_m+1)$ is a flag Bott manifold. Also an m -stage Bott manifold, which is a smooth projective toric variety, is an m-stage flag Bott manifold, see [\[GK94\]](#page-12-5).

We call two flag Bott towers F_{\bullet} and F'_{\bullet} are *isomorphic* if there is a collection of holomorphic diffeomorphisms $\varphi_j \colon F_j \to F'_j$ which commute with the projections $p_j: F_j \to F_{j-1}$ and $p'_j: F'_j \to F'_{j-1}$ for all $1 \leq j \leq m$.

Suppose that F_{\bullet} is an *m*-stage flag Bott tower. To describe the orbit space construction of a flag Bott manifold, we first define the right action Φ_i . Suppose that $B_{GL(n)}$ is the set of upper triangular matrices in $GL(n) := GL(n, \mathbb{C})$ for $n \in \mathbb{Z}_{>0}$. Also let $H_{GL(n)}$ be the set of diagonal matrices in $GL(n)$. For positive integers *n* and *n'*, let *A* be an integer matrix of size $(n + 1) \times (n' + 1)$ whose row vectors are $\mathbf{a}_1, \ldots, \mathbf{a}_{n+1} \in \mathbb{Z}^{n'+1}$, i.e.,

$$
A = \begin{bmatrix} \mathbf{a}_1 \\ \mathbf{a}_2 \\ \vdots \\ \mathbf{a}_{n+1} \end{bmatrix}
$$

.

Since the character group $\chi(H_{GL(n'+1)})$ is isomorphic to $\mathbb{Z}^{n'+1}$, the matrix A defines a homomorphism $H_{GL(n'+1)} \to H_{GL(n+1)}$ given by

$$
h \mapsto \mathrm{diag}(h^{\mathbf{a}_1}, \ldots, h^{\mathbf{a}_{n+1}}).
$$

Here $h = \text{diag}(h_1, \ldots, h_{n'+1})$ is an element of $H_{GL(n'+1)}$ and $h^{\mathbf{a}} := h_1^{\mathbf{a}(1)} \cdots h_{n'+1}^{\mathbf{a}(n'+1)}$ $n'+1$ for $\mathbf{a} = (\mathbf{a}(1), \dots, \mathbf{a}(n'+1)) \in \mathbb{Z}^{n'+1}$. By composing the canonical projection $\Upsilon: B_{GL(n'+1)} \to H_{GL(n'+1)}$ which ignores entries not on the diagonals, the matrix A induces a homomorphism

$$
\Lambda(A) \colon B_{GL(n'+1)} \to H_{GL(n+1)}.
$$

Suppose that $(A_{\ell}^{(j)})$ $(\lambda_{\ell}^{(j)})_{1 \leq \ell < j \leq m} \in \prod_{1 \leq \ell < j \leq m} M_{(n_j+1) \times (n_{\ell}+1)}(\mathbb{Z})$ is a sequence of integer matrices. We define a right action Φ_j of $B_{GL(n_1+1)} \times \cdots \times B_{GL(n_j+1)}$ on the product $GL(n_1 + 1) \times \cdots \times GL(n_i + 1)$ by

$$
\Phi_j((g_1, g_2, \dots, g_j), (b_1, b_2, \dots, b_j))
$$
\n
$$
:= (g_1 b_1, \Lambda_1^{(2)}(b_1)^{-1} g_2 b_2, \Lambda_1^{(3)}(b_1)^{-1} \Lambda_2^{(3)}(b_2)^{-1} g_3 b_3, \dots, \Lambda_1^{(j)}(b_1)^{-1} \Lambda_2^{(j)}(b_2)^{-1} \dots \Lambda_{j-1}^{(j)}(b_{j-1})^{-1} g_j b_j)
$$

where $\Lambda_{\ell}^{(j)} := \Lambda(A_{\ell}^{(j)})$ $\binom{y}{\ell}$ for $1 \leq \ell < j \leq m$. Then the action Φ_j is free and proper, see [\[KLSS17,](#page-12-4) Lemma 2.7]. Hence we have complex manifolds

$$
(GL(n_1+1) \times \cdots \times GL(n_j+1))/\Phi_j \quad \text{for } 1 \le j \le m.
$$

These manifolds are actually flag Bott manifolds (see [\[KLSS17,](#page-12-4) Proposition 2.8]), and every flag Bott manifold can be obtained by this construction.

Proposition 2.2 (KLSS17, Proposition 2.11)). Let F_{\bullet} be a flag Bott tower of height m. Then there is a sequence of integer matrices

$$
(A_{\ell}^{(j)})_{1 \leq \ell < j \leq m} \in \prod_{1 \leq \ell < j \leq m} M_{(n_j+1) \times (n_\ell+1)}(\mathbb{Z})
$$

such that F_{\bullet} is isomorphic to

$$
\{(GL(n_1+1)\times\cdots\times GL(n_j+1))/\Phi_j\mid 0\leq j\leq m\}
$$

as flag Bott towers.

Remark 2.3. We notice that the sequence of integer matrices $(A_{\ell}^{(j)})$ $\binom{J}{\ell}$ 1 $\leq \ell < j \leq m$ \in $\prod_{1 \leq \ell < j \leq m} M_{(n_j+1)\times(n_\ell+1)}(\mathbb{Z})$ are associated to the first Chern classes of line bundles $\xi_k^{(j)}$ $\mathbf{k}^{(j)}$ in the construction of a flag Bott manifold. To be more precisely, suppose that $\mathbf{a}_{k,\ell}^{(j)}$ be the kth row vector of the matrix $A_{\ell}^{(j)}$ $\ell^{(1)}$. Then the set of vector $\{ \mathbf a_{k, 1}^{(j)}$ $\mathbf{a}_{k,1}^{(j)},\ldots,\mathbf{a}_{k,j}^{(j)}$ $\binom{(j)}{k,j-1}$ determines the first Chern class of the line bundle $\xi_k^{(j)}$ $k^{(j)}$. For more details, see [\[KLSS17,](#page-12-4) §2].

Example 2.4. Suppose that $n_1 = 2$ and $n_2 = 1$. Consider $A_1^{(2)} =$ $\begin{bmatrix} c_1 & c_2 & 0 \\ 0 & 0 & 0 \end{bmatrix}.$ Then the following Bott tower $\{F_j \mid 0 \leq j \leq 2\}$ is isomorphic to $\{(\tilde{GL}(n_1 + 1) \times$ $\cdots \times GL(n_j+1)/\Phi_j \mid 0 \leq j \leq 2$ as flag Bott towers.

$$
\mathcal{F}\ell(\xi(c_1, c_2, 0) \oplus \underline{\mathbb{C}}) \longrightarrow \mathcal{F}\ell(3) \longrightarrow \{a \text{ point}\}\
$$

 $\begin{array}{ccc}\n\downarrow & & \downarrow & & \downarrow \\
\downarrow & & & \downarrow & & \downarrow \\
F_2 & & & F_1 & & F_0\n\end{array}$

The line bundle $\xi(c_1, c_2, 0)$ over F_1 is $(GL(3) \times \mathbb{C})/B_{GL(3)}$, where the right action of $B_{GL(3)}$ is defined by

$$
(g,v)\cdot b=(gb,b_{11}^{-c_1}b_{22}^{-c_2}v)
$$

for $g \in GL(3)$ and $b = (b_{ij}) \in B_{GL(3)}$.

3. Generic torus orbit closures in flag Bott manifolds

Let F_m be an *m*-stage flag Bott manifold, and let $\mathbb{H} = H_{GL(n_1+1)} \times \cdots \times$ $H_{GL(n_m+1)}$. As introduced in [\[KLSS17,](#page-12-4) §3.1], the *canonical action* of $\mathbb H$ on F_j is defined to be

$$
(h_1, ..., h_m) \cdot [g_1, ..., g_j] := [h_1 g_1, ..., h_j g_j]
$$
 for $1 \leq j \leq m$.

Then $q_j : F_j \to F_{j-1}$ is an H-equivariant fiber bundle. Note that this action is not effective. If we write $h_j = \text{diag}(h_{j,1}, \ldots, h_{j,n_j+1}) \in GL(n_j + 1)$, then the subtorus

$$
\mathbf{H} := \{ (h_1, \dots, h_m) \in \mathbb{H} \mid h_{1,n_1+1} = \dots = h_{m,n_m+1} = 1 \} \cong (\mathbb{C}^*)^n
$$

acts effectively on F_m , where

$$
n := n_1 + \cdots + n_m.
$$

In order to consider the closure of torus orbit with respect to the canonical action, we define a generic element in F_m . Let $g = (g_{ij})$ be an element in $GL(n+1)$. For an ordered sequence $1 \leq i_1 < i_2 < \cdots < i_k \leq n+1$, we define the Plücker coordinate

$$
X_{i_1,\ldots,i_k}(g) := \det((g_{i_p,p})_{p=1,\ldots,k}).
$$

Definition 3.1 ([\[KLSS17,](#page-12-4) Definition 5.4]). We call an element $g \in GL(n + 1)$ is generic if $X_{i_1,\ldots,i_k}(g)$ is nonzero for any $k \in [n+1]$ and an ordered sequence $1 \leq i_1 < \cdots < i_k \leq n+1$. A point $[g_1, \ldots, g_m] \in F_m$ is generic if $g_j \in GL(n_j + 1)$ is generic for all $1 \leq j \leq m$. A *generic torus orbit* in F_m is the **H**-orbit of a generic point.

The above definition of generic elements and generic torus orbits can be found in [\[FH91\]](#page-12-0), [\[Kly95\]](#page-12-6), and [\[Dab96\]](#page-11-1). The closure X_n of a generic torus orbit in the flag manifold $\mathcal{F}\ell(n+1)$ is a smooth projective toric variety called the *permutohedral variety*, see [\[Kly85\]](#page-12-7). We recall the fan $\Sigma_{X_n} \subset \mathbb{R}^n$ of the permutohedral variety X_n for the later use. The rays in Σ_{X_n} are parametrized by the nonempty proper subsets of $[n+1]$:

$$
\Sigma_{X_n}(1) \stackrel{1-1}{\longleftrightarrow} \{ S \mid \emptyset \subsetneq S \subsetneq [n+1] \}
$$

More precisely, for a nonempty proper subset S of $[n+1]$, the corresponding ray ρ_S is generated by

$$
u_S := \begin{cases} \sum_{s \in S} \varepsilon_s & \text{if } n+1 \notin S, \\ -\sum_{s \in [n+1] \setminus S} \varepsilon_s & \text{otherwise,} \end{cases}
$$

where $\{\varepsilon_1,\ldots,\varepsilon_n\}$ is the standard basis vector of \mathbb{R}^n . Hence there are $2^{n+1}-2$ many rays in Σ_{X_n} , see Figure [1\(1\).](#page-4-1) And the maximal cones in Σ_{X_n} are indexed by the set of proper chain of nonempty proper subsets of $[n+1]$. For a given proper chain

$$
S_{\bullet}: \emptyset \subsetneq S_1 \subsetneq S_2 \subsetneq \cdots \subsetneq S_n \subsetneq [n+1]
$$

of nonempty proper subsets, we have the corresponding maximal cone

$$
Cone(u_{S_1}, u_{S_2}, \ldots, u_{S_n}).
$$

See Figure [1\(2\).](#page-4-1) Therefore $|\Sigma_{X_n}(n)| = (n+1)!$.

FIGURE 1. Fan Σ_{X_2} .

Suppose that F_m is an *m*-stage flag Bott manifold. Considering the effective canonical H-action, each fiber of a bundle $F_j \to F_{j-1}$ has the restricted $(\mathbb{C}^*)^{n_j}$. action, and its orbit closure of a generic point is the permutohedral variety X_{n_j} . Hence the closure of a generic torus orbit of the torus \mathbf{H} in F_m is an iterated permutohedral varieties bundles. Now we describe the fan of a generic torus orbit closure in F_m in the following theorem whose proof will be given in Section [4.](#page-6-0)

Theorem 3.2. Let F_m be a flag Bott manifold determined by the sequence of integer matrices $(A_{\ell}^{(j)}$ $\mathbb{Z}^{(j)}_{\ell}$ _{1≤ ℓ < j ≤m $\in \prod_{1 \leq \ell < j \leq m} M_{(n_j+1) \times (n_{\ell}+1)}(\mathbb{Z})$. Then the fan $\Sigma \subset \mathbb{R}^n$ of} a generic torus orbit closure X in F_m is described as follows:

(1) the rays in Σ are parametrized by

 $\{(\ell, S) \mid \emptyset \subsetneq S \subsetneq [n_{\ell}+1], 1 \leq \ell \leq m\}.$

For (ℓ, S) , the corresponding ray is generated by

$$
u_{S}^{\ell} := \begin{cases} \sum_{s \in S} \varepsilon_{\ell,s} - \sum_{p=\ell+1}^{m} \sum_{k=1}^{n_{p}+1} ((A_{\ell}^{(p)})_{k,d+1} + \dots + (A_{\ell}^{(p)})_{k,n_{\ell}+1}) \varepsilon_{p,k} & \text{if } n_{\ell}+1 \notin S, \\ - \sum_{s \in [n_{\ell}+1] \setminus S} \varepsilon_{\ell,s} + \sum_{p=\ell+1}^{m} \sum_{k=1}^{n_{p}+1} ((A_{\ell}^{(p)})_{k,1} + \dots + (A_{\ell}^{(p)})_{k,d}) \varepsilon_{p,k} & \text{otherwise,} \end{cases}
$$

where $d = |[n_{\ell}+1] \setminus S|$ and $\{\varepsilon_{\ell,k}\}_{1 \leq k \leq n_{\ell}, 1 \leq \ell \leq m}$ is the standard basis vector in $\mathbb{R}^n \cong Lie(\mathbf{T})$. Here we set $\varepsilon_{1,n_1+1} = \cdots = \varepsilon_{m,n_m+1} = 0$.

(2) The maximal cones in Σ are indexed by the sequences of proper chains of subsets

$$
\{(S_{\bullet}^1,\ldots,S_{\bullet}^m) \mid S_{\bullet}^{\ell} : \emptyset \subsetneq S_1^{\ell} \subsetneq S_2^{\ell} \subsetneq \cdots \subsetneq S_{n_{\ell}}^{\ell} \subsetneq [n_{\ell}+1], 1 \leq \ell \leq m\}.
$$

For $(S^1_{\bullet},...,S^m_{\bullet})$, the corresponding maximal cone is defined to be

$$
\text{Cone}\left(\bigcup_{\ell=1}^m \{u_{S_1^{\ell}}^{\ell},\ldots,u_{S_{n_{\ell}}^{\ell}}^{\ell}\}\right).
$$

We notice that if F_m is determined by the sequence of integer matrices such that each $A_{\ell}^{(j)}$ ℓ has nonzero value only on the first column, then F_m is an associated flag Bott manifold to a generalized Bott manifold (see, for more details, [\[KLSS17,](#page-12-4) §4]). The fan of generic torus orbit closure in an associated flag Bott manifold has been computed in [\[KLSS17,](#page-12-4) Theorem 5.5], and Theorem [3.2](#page-4-0) extends this result for considering any flag Bott manifold.

Example 3.3. Suppose that F_2 is a 2-stage flag Bott manifold given in Exam-ple [2.4.](#page-2-0) Then the fan $\Sigma \subset \mathbb{R}^3$ of the generic torus orbit closure in F_2 has eight rays with the ray vectors:

$$
u_{\{1\}}^1 = (1,0,0), \t u_{\{2\}}^1 = (0,1,0), \t u_{\{3\}}^1 = (-1,-1,c_1+c_2),
$$

\n
$$
u_{\{1,2\}}^1 = (1,1,-c_2), \t u_{\{2,3\}}^1 = (-1,0,c_1), \t u_{\{1,3\}}^1 = (0,-1,c_1),
$$

\n
$$
u_{\{1\}}^2 = (0,0,1), \t u_{\{2\}}^2 = (0,0,-1).
$$

Moreover the fan Σ has twelve maximal cones:

$$
\begin{array}{llll} \text{Cone}(u_{\{1\}}^1,u_{\{1,2\}}^1,u_{\{1\}}^2), & \text{Cone}(u_{\{1\}}^1,u_{\{1,3\}}^1,u_{\{1\}}^2), & \text{Cone}(u_{\{2\}}^1,u_{\{1,2\}}^1,u_{\{1\}}^2),\\ \text{Cone}(u_{\{2\}}^1,u_{\{2,3\}}^1,u_{\{1\}}^2), & \text{Cone}(u_{\{3\}}^1,u_{\{1,3\}}^1,u_{\{1\}}^2), & \text{Cone}(u_{\{3\}}^1,u_{\{2,3\}}^1,u_{\{1\}}^2),\\ \text{Cone}(u_{\{1\}}^1,u_{\{1,2\}}^1,u_{\{2\}}^2), & \text{Cone}(u_{\{1\}}^1,u_{\{1,3\}}^1,u_{\{2\}}^2), & \text{Cone}(u_{\{2\}}^1,u_{\{1,2\}}^1,u_{\{2\}}^2),\\ \text{Cone}(u_{\{2\}}^1,u_{\{2,3\}}^1,u_{\{2\}}^2), & \text{Cone}(u_{\{3\}}^1,u_{\{1,3\}}^1,u_{\{2\}}^2), & \text{Cone}(u_{\{3\}}^1,u_{\{2,3\}}^1,u_{\{2\}}^2). \end{array}
$$

Example 3.4. Suppose that F_3 is a 3-stage flag Bott manifold determined by

$$
A_1^{(2)} = \begin{bmatrix} x_{11} & x_{12} & 0 \\ x_{21} & x_{22} & 0 \\ 0 & 0 & 0 \end{bmatrix}, \quad A_1^{(3)} = \begin{bmatrix} y_1 & y_2 & 0 \\ 0 & 0 & 0 \end{bmatrix}, \quad A_2^{(3)} = \begin{bmatrix} z_1 & z_2 & 0 \\ 0 & 0 & 0 \end{bmatrix}.
$$

Then the fan $\Sigma \subset \mathbb{R}^5$ of the generic torus orbit closure in F_3 has fourteen rays which are generated by the following vectors:

$$
\begin{aligned} u_{\{1\}}^1 & = (1,0,0,0,0), & u_{\{2\}}^1 & = (0,1,0,0,0), \\ u_{\{3\}}^1 & = (-1,-1,x_{11}+x_{12},x_{21}+x_{22},y_1+y_2), & u_{\{1,2\}}^1 & = (1,1,-x_{12},-x_{22},-y_2), \\ u_{\{2,3\}}^1 & = (-1,0,x_{11},x_{21},y_1), & u_{\{1,3\}}^1 & = (0,-1,x_{11},x_{21},y_1), \\ u_{\{1\}}^2 & = (0,0,1,0,0), & u_{\{2\}}^2 & = (0,0,0,1,0), \\ u_{\{3\}}^2 & = (0,0,-1,-1,z_1+z_2), & u_{\{1,2\}}^2 & = (0,0,1,1,-z_2), \\ u_{\{2,3\}}^2 & = (0,0,-1,0,z_1), & u_{\{1,3\}}^2 & = (0,0,0,-1,z_1), \\ u_{\{1\}}^3 & = (0,0,0,0,1), & u_{\{2\}}^3 & = (0,0,0,0,-1). \end{aligned}
$$

Proposition 3.5. All generic torus orbit closures in a flag Bott manifold F_m are isomorphic non-singular toric varieties.

To give a proof of Proposition [3.5,](#page-5-0) we use the following lemma:

Lemma 3.6 ([\[Dab96,](#page-11-1) Corollary of Theorem 3.3]). The permutohedral variety X_n is smooth, i.e., for a proper chain $S_{\bullet} : \emptyset \subsetneq S_1 \subsetneq S_2 \subsetneq \cdots \subsetneq S_n \subsetneq [n+1]$ of nonempty proper subsets of $[n+1]$, the determinant of the matrix

$$
(3.1) \t\t [u_{S_1} \ u_{S_2} \ \cdots \ u_{S_n}]
$$

 $is \pm 1$.

Proof of Proposition [3.5.](#page-5-0) Let $\Sigma \in \mathbb{R}^n$ be the fan of a generic torus orbit closure X in F_m described in Theorem [3.2.](#page-4-0) To prove the claim, it is enough to show that every maximal cones in Σ are smooth, i.e., the set of ray generators of each maximal

cone forms a basis of \mathbb{Z}^n . For a maximal cone indexed by $(S^1_{\bullet},...,S^m_{\bullet}),$ consider the matrix whose column vectors are the corresponding ray generators:

(3.2)
$$
\left[u_{S_1^1}^1 \cdots u_{S_{n_1}^1}^1 \cdots u_{S_1^m}^m \cdots u_{S_{n_m}^m}^m \right].
$$

Then the matrix in [\(3.2\)](#page-6-1) is a block lower triangular matrix whose sizes of blocks are n_1, \ldots, n_m . Moreover, diagonal blocks has the form in [\(3.1\)](#page-5-1). Hence we have that the determinant of the matrix in [\(3.2\)](#page-6-1) is

$$
\det\left(\left[u_{S_1^1} \cdots u_{S_{n_1}^1}\right]\right) \cdot \det\left(\left[u_{S_1^2} \cdots u_{S_{n_2}^2}\right]\right) \cdots \det\left(\left[u_{S_1^m} \cdots u_{S_{n_m}^m}\right]\right) = \pm 1
$$

by Lemma [3.6.](#page-5-2) Here $\{u_{S_1^{\ell}}, \ldots, u_{S_{n_{\ell}}^{\ell}}\}$ is the set of ray generators of the maximal cone in the fan of the permutohedral variety $X_{n_{\ell}}$ indexed by the proper chain $\emptyset \subsetneq S_1^{\ell} \subsetneq \cdots \subsetneq S_{n_{\ell}}^{\ell} \subsetneq [n_{\ell}+1]$ for $1 \leq \ell \leq m$. Hence the non-singularity of X follows.

Since the ray vectors u_S^{ℓ} are determined independently of the choices of generic points, the fan of all generic torus orbit closures are identical. Therefore they are all isomorphic as smooth toric varieties.

Example 3.7. Suppose that F_3 is a 3-stage flag Bott manifold defined in Exam-ple [3.4.](#page-5-3) Consider a maximal cone σ indexed by

$$
({2} \subset {2,3}, {2} \subset {1,2}, {2}).
$$

Then the corresponding ray generators form the following matrix:

$$
\begin{bmatrix} u_{\{2\}}^1 & u_{\{2,3\}}^1 & u_{\{2\}}^2 & u_{\{1,2\}}^2 & u_{\{2\}}^3 \end{bmatrix} = \begin{bmatrix} 0 & -1 & 0 & 0 & 0 \\ 1 & 0 & 0 & 0 & 0 \\ 0 & x_{11} & 0 & 1 & 0 \\ 0 & x_{21} & 1 & 1 & 0 \\ 0 & y_1 & 0 & -z_2 & -1 \end{bmatrix}.
$$

We have that

$$
\det\begin{bmatrix} 0 & -1 & 0 & 0 & 0 \\ 1 & 0 & 0 & 0 & 0 \\ 0 & x_{11} & 0 & 1 & 0 \\ 0 & x_{21} & 1 & 1 & 0 \\ 0 & y_1 & 0 & -z_2 & -1 \end{bmatrix} = \det\begin{bmatrix} 0 & -1 \\ 1 & 0 \end{bmatrix} \det\begin{bmatrix} 0 & 1 \\ 1 & 1 \end{bmatrix} \det\begin{bmatrix} -1 \\ -1 \end{bmatrix} = 1,
$$

so that the maximal cone σ is smooth.

4. Proof of Theorem [3.2](#page-4-0)

In this section we prove Theorem [3.2](#page-4-0) using the combinatorial structure of the fan of toric varieties bundles and tangential representations around fixed points. To describe the fan Σ of the torus orbit closure in F_m , we first recall the following on equivariant fiber bundle of toric varieties:

Proposition 4.1 ([\[Oda78,](#page-12-8) Proposition 7.3] and [\[CLS11,](#page-11-4) §3.3]). Let Σ , respectively Σ' , be a complete fan in $N_{\mathbb{R}} := N \otimes_{\mathbb{Z}} \mathbb{R}$, respectively $N'_{\mathbb{R}} := N' \otimes_{\mathbb{Z}} \mathbb{R}$, for some lattice N, respectively N'. Let $\overline{\varphi} \colon N \to N'$ be compatible with fans Σ and Σ' , and let $N'' = \text{ker}(\overline{\varphi})$. Then $\varphi \colon X_{\Sigma} \to X_{\Sigma'}$ is an equivariant fiber bundle with the fiber $X_{\Sigma''}$, where $\Sigma'' = \{ \sigma \in \Sigma \mid \sigma \subset N''_{\mathbb{R}} \} \subset N''_{\mathbb{R}}$, if and only if the following conditions are satisfied:

(1) $\overline{\varphi}$: $N \to N'$ is surjective.

(2) There exists a lifting $\Sigma' \subset \Sigma$ of Σ' , i.e., for each $\sigma' \in \Sigma'$, there exists a unique $\widetilde{\sigma}' \in \widetilde{\Sigma}'$ such that $\overline{\varphi}$ induces a bijection

$$
\overline{\varphi} \colon \widetilde{\sigma}^{\prime} \xrightarrow{\sim} \sigma^{\prime}.
$$

(3) $\Sigma = \Sigma' \cdot \Sigma''$, i.e., Σ consists of cones

$$
\sigma = \widetilde{\sigma}' + \sigma''
$$

with
$$
\tilde{\sigma}'
$$
 and σ'' running through $\tilde{\Sigma}'$ and Σ'' .

The operation \cdot is called *join* in [\[Ewa96,](#page-11-5) III.1]. The closure of a generic torus orbit of the torus \mathbf{H} in F_m is an iterated permutohedral variety bundles. Hence we have the following lemma:

Lemma 4.2 (see [\[KLSS17,](#page-12-4) Lemma 5.11]). Let F_m be an m-stage flag Bott manifold. Let Σ be the fan of the closure of a generic torus orbit of the torus **H** in F_m . Then there are liftings $\Sigma_{n_1}, \ldots, \Sigma_{n_{m-1}}$ of fans of permutohedral varieties such that

$$
\Sigma = \widetilde{\Sigma}_{n_1} \cdot \cdots \cdot \widetilde{\Sigma}_{n_{m-1}} \cdot \Sigma_{n_m}.
$$

The above lemma proves that the combinatorial structure of the fan Σ is given as in Theorem $3.2(2)$. Now it is enough to show that the ray vectors are given as in Theorem $3.2(1)$. To complete the proof, we use the tangential representations around fixed points which have been computed in [\[KLSS17,](#page-12-4) §3].

Let F_m be an *m*-stage flag Bott manifold. Recall from [\[KLSS17,](#page-12-4) Proposition 3.3] that the fixed point set $\mathbf{F}_m^{\mathbf{H}}$ can be identified with $\mathfrak{S}_{n_1+1} \times \cdots \times \mathfrak{S}_{n_m+1}$. More precisely, for permutations $(v_1, \ldots, v_m) \in \mathfrak{S}_{n_1+1} \times \cdots \times \mathfrak{S}_{n_m+1}$, the corresponding fixed point in F_m is $[v_1, \ldots, v_m]$ where $v_j \in GL(n_j + 1)$ is the column permutation matrix of v_j . Also we have that $F_m^{\mathbf{H}} = X^{\mathbf{H}}$. Suppose that \mathbb{T} , respectively **T**, is the maximal compact torus in \mathbb{H} , respectively **H**. Then, for every fixed point $v := [v_1, \ldots, v_m]$, the weights of the isotropy representation $T_v F_m$ of $\mathbb T$ are explicitly computed in [\[KLSS17,](#page-12-4) Proposition 3.5].

We note that there is a one-to-one correspondence relation between the set $\mathfrak{S}_{n_1+1} \times \cdots \times \mathfrak{S}_{n_m+1}$ and the sequences of chains of subsets $\{(S_{\bullet}^1, \ldots, S_{\bullet}^m)\}\$ as follows. For a given $(v_1, \ldots, v_m) \in \mathfrak{S}_{n_1+1} \times \cdots \times \mathfrak{S}_{n_m+1}$, we define

(4.1)
$$
S_p^{\ell} := \{v(n_{\ell} + 2 - p), \dots, v(n_{\ell} + 1)\} \text{ for } 1 \le p \le n_{\ell}, 1 \le \ell \le m.
$$

Moreover, for a given maximal cone indexed by (v_1, \ldots, v_m) , the adjacent maximal cones are indexed by permutations

$$
(4.2) \t\t\t (v_1,\ldots,v_{j-1},v_j\cdot s_i,v_{j+1},\ldots,v_m)
$$

where s_i is the transposition $(i, i + 1)$ for $1 \le i \le n_j$ and $1 \le j \le m$.

For a smooth projective toric variety X_{Σ} of complex dimension n, the weights of the isotropy representations around fixed points and the ray generators are closely related to each other. Let ρ be a ray in $\Sigma(1)$ with $u_{\rho} =: u_1$ as its generating vector. Suppose that $\sigma = \text{Cone}(u_1, \ldots, u_n)$ is a maximal cone containing ρ . Let τ_1, \ldots, τ_n be the codimension-one faces of the cone σ . More precisely, we put

$$
\tau_j = \text{Cone}(u_1, \ldots, \hat{u}_j, \ldots, u_n).
$$

Then τ_1 is the unique codimension-one face of σ which does not contain ρ . By the orbit-cone correspondence, these cones correspond to torus invariant spheres S_1, \ldots, S_n in X_{Σ} . Then these spheres meet at a point $p \in X_{\Sigma}$ which is exactly the fixed point corresponding σ . Suppose that $w_1, \ldots, w_n \in \text{Lie}(\mathbf{T})^*$ are weights of the

isotropy representation T_pX_{Σ} , where **T** is the compact torus of dimension n. Let H_i be the identity component of the kernel of the map

$$
\exp(\sqrt{-1}w_i): \mathbf{T} \to S^1.
$$

Then, by reordering w_1, \ldots, w_n appropriately, one can see that the sphere S_i is the connected component of $X_{\Sigma}^{H_i}$ containing p. Moreover, we have the following:

Lemma 4.3 ([\[BP15,](#page-11-6) Proposition 7.3.18]). Let $u_1 = u_\rho, w_1, \ldots, w_n$ be as above. Then we have the following relation:

$$
\langle w_i, u_\rho\rangle = \begin{cases} 1 & \text{ if } i=1,\\ 0 & \text{ otherwise.} \end{cases}
$$

The above lemma implies that the ray generators are completely determined by weights of isotropy representations around fixed points. Moreover, one can see that the computation of the ray generator u_{ρ} is independent of the choice of a maximal cone containing ρ , see [\[KLSS17,](#page-12-4) Lemma 5.13].

We choose $1 \leq \ell \leq m$ and a nonempty proper subset S of $[n_{\ell}+1]$. To compute the generator u_S^{ℓ} of the ray ρ_S^{ℓ} , we consider a specific maximal cone σ_S^{ℓ} contains ρ_S^{ℓ} . We set $S = \{s_1 < s_2 < \cdots < s_{n_{\ell}+1-d}\}\$ and $[n_{\ell}+1] \setminus S = \{t_1 < t_2 < \cdots < t_d\}$. Let $v_{\ell,S}$ be a permutation in $\mathfrak{S}_{n_{\ell}+1}$ defined to be

$$
v_{\ell,S} = (t_1 \ t_2 \ \cdots \ t_d \ s_1 \ s_2 \ \cdots \ s_{n_{\ell}+1-d}).
$$

Then we choose a maximal cone σ_S^{ℓ} indexed by

(4.3)
$$
v = (v_1, \dots, v_m) := (\underbrace{e, \dots, e}_{\ell-1}, v_{\ell, S}, e, \dots, e),
$$

so that σ_S^{ℓ} contains the ray ρ_S^{ℓ} .

We recall from [\[KLSS17,](#page-12-4) Proposition 3.5 and Theorem 3.11] that the weight w_i^j corresponds to the codimension-one face of the cone σ_S^{ℓ} intersecting the maximal cone indexed by $(v_1, \ldots, v_{j-1}, v_j \cdot s_i, v_{j+1}, \ldots, v_m)$ is computed as follows:

Proposition 4.4 ([\[KLSS17,](#page-12-4) Proposition 3.5 and Theorem 3.11]). We have $w_i^j =$ $r_{i+1} - r_i$ where r_i is the ith row of the matrix

$$
\[X_1^{(j)}\ X_2^{(j)}\ \cdots\ X_{j-1}^{(j)}\ B_j\ O\ \cdots\ O\]\,.
$$

Here $X_{\ell}^{(j)}$ $\ell_{\ell}^{(j)}$ is the matrix of size $(n_j + 1) \times (n_{\ell} + 1)$ defined by

(4.4)
$$
X_{\ell}^{(j)} = \sum_{\ell < i_1 < \cdots < i_r < j} \left(B_j A_{i_r}^{(j)} \right) \left(B_{i_r} A_{i_{r-1}}^{(i_r)} \right) \cdots \left(B_{i_1} A_{\ell}^{(i_1)} \right) B_{\ell} + B_j A_{\ell}^{(j)} B_{\ell}
$$

for $1 \leq \ell < j \leq m$, and B_j is the row permutation matrix corresponding to v_j , i.e., $B_j = (\dot{v}_j)^T$.

We note that the codimension-one face of the cone σ_S^{ℓ} which does not contain the ray ρ_S^{ℓ} corresponds to the weight w_d^{ℓ} . Hence to complete the proof, it is enough to show that the vector

$$
u_S^{\ell} = \begin{cases} \sum_{s \in S} \varepsilon_{\ell,s} - \sum_{p=\ell+1}^{m} \sum_{k=1}^{n_p+1} ((A_{\ell}^{(p)})_{k,d+1} + \dots + (A_{\ell}^{(p)})_{k,n_{\ell}+1}) \varepsilon_{p,k} & \text{if } n_{\ell}+1 \notin S, \\ - \sum_{s \in [n_{\ell}+1] \setminus S} \varepsilon_{\ell,s} + \sum_{p=\ell+1}^{m} \sum_{k=1}^{n_p+1} ((A_{\ell}^{(p)})_{k,1} + \dots + (A_{\ell}^{(p)})_{k,d}) \varepsilon_{p,k} & \text{otherwise} \end{cases}
$$

in Theorem [3.2](#page-4-0) satisfies that

(4.5)
$$
\langle w_i^j, u_S^\ell \rangle = \begin{cases} 1 & \text{if } j = \ell \text{ and } i = d, \\ 0 & \text{otherwise.} \end{cases}
$$

The weight w_i^j , computed in [\[KLSS17,](#page-12-4) Proposition 3.5], is an element of Lie(T)^{*}. Since we have

$$
\mathbf{T} = \{(t_1, \ldots, t_m) \in \mathbb{T} \mid t_{1,n_1+1} = \cdots = t_{m,n_m+1} = 1\}
$$

where $t_j = (t_{j,1}, \ldots, t_{j,n_j+1}) \in (S^1)^{n_j+1}$, we regard

$$
\varepsilon_{1,n_1+1}=\cdots=\varepsilon_{m,n_m+1}=0
$$

to compute the pairing [\(4.5\)](#page-9-0).

To prove the claim, we separate cases as $j < \ell$, $j = \ell$, and $j > \ell$.

- **Case 1** $j < l$. By Proposition [4.4,](#page-8-0) the weight vector $w_i^j \in \text{Lie}(\mathbf{T})^*$ is a linear combination of $\varepsilon_{1,1}^*,\ldots,\varepsilon_{1,n_1}^*,\ldots,\varepsilon_{j,1}^*,\ldots,\varepsilon_{j,n_j}^*$, where $\{\varepsilon_{\ell,k}^*\}_{1\leq k\leq n_\ell,1\leq \ell\leq m}$ is the dual of the standard basis vector. On the other hand, since u_S^{ℓ} is a linear combination of $\varepsilon_{\ell,1},\ldots,\varepsilon_{\ell,n_{\ell}},\ldots,\varepsilon_{m,1},\ldots,\varepsilon_{m,n_m}$ and $j < \ell$, their pairings always vanish.
- **Case 2** $j = \ell$. By Proposition [4.4,](#page-8-0) the weight vector $w_i^{\ell} \in \text{Lie}(\mathbf{T})^*$ is a linear combination of $\varepsilon^*_{1,1},\ldots,\varepsilon^*_{1,n_1},\ldots,\varepsilon^*_{\ell,1},\ldots,\varepsilon^*_{\ell,n_\ell}$. More precisely, we have that

$$
w_i^{\ell} = (\varepsilon_{\ell, v_{\ell, S}(i+1)})^* - (\varepsilon_{\ell, v_{\ell, S}(i)})^* + \text{ other terms},
$$

where 'other terms' are the terms of $\varepsilon_{p,k}^*$ for $p < \ell$ and $v_{\ell,S}$ is a per-mutation defined in [\(4.3\)](#page-8-1). Since the vector u_S^{ℓ} is a linear combination of $\varepsilon_{\ell,1},\ldots,\varepsilon_{\ell,n_\ell},\ldots,\varepsilon_{m,1},\ldots,\varepsilon_{m,n_m}$, we have

(4.6)
$$
\langle w_i^{\ell}, u_S^{\ell} \rangle = \langle (\varepsilon_{\ell, v_{\ell, S}(i+1)})^* - (\varepsilon_{\ell, v_{\ell, S}(i)})^*, u_S^{\ell} \rangle.
$$

Because of the definition of permutation $v_{\ell,S}$, we have that $v_{\ell,S}(i) \in S$ if and only if $i \geq d+1$. Therefore for the case when $n_{\ell}+1 \notin S$, we have that the value $\langle (\varepsilon_{\ell,v_{\ell,S}(i)})^*, u_S^{\ell} \rangle$ equals to 0 if $i \leq d$, and 1 otherwise. Also for the case when $n_{\ell} + 1 \in S$, we get that the pairing $\langle (\varepsilon_{\ell,v_{\ell,S}(i)})^*, u_S^{\ell} \rangle$ is -1 if $i \leq d$ and 0 otherwise.

By applying [\(4.6\)](#page-9-1) for $n_{\ell} + 1 \notin S$, we have the following:

$$
\langle w_i^{\ell}, u_S^{\ell} \rangle = \begin{cases} 0 - 0 = 0 & \text{for } 1 \le i \le d - 1, \\ 1 - 0 = 1 & \text{for } i = d, \\ 1 - 1 = 0 & \text{for } d + 1 \le i \le n_{\ell}. \end{cases}
$$

Similarly, when $n_{\ell} + 1 \in S$, we get the following:

$$
\langle w_i^{\ell}, u_S^{\ell} \rangle = \begin{cases} -1 - (-1) = 0 & \text{for } 1 \le i \le d - 1, \\ 0 - (-1) = 1 & \text{for } i = d, \\ 0 - 0 = 0 & \text{for } d + 1 \le i \le n_{\ell}. \end{cases}
$$

Case 3 $j > l$. The matrix $X_j^{(l)}$ in Proposition [4.4](#page-8-0) is

$$
X_{\ell}^{(j)} = \sum_{\ell < i_1 < \dots < i_r < j} \left(B_j A_{i_r}^{(j)} \right) \left(B_{i_r} A_{i_{r-1}}^{(i_r)} \right) \dots \left(B_{i_1} A_{\ell}^{(i_1)} \right) B_{\ell} + B_j A_{\ell}^{(j)} B_{\ell}.
$$

Since $v_j = e$ for $j \neq \ell$, the matrix $X_{\ell}^{(j)}$ $\ell^{(J)}$ can be written by

$$
X_{\ell}^{(j)} = \left(\sum_{\ell < i_1 < \dots < i_r < j} A_{i_r}^{(j)} A_{i_{r-1}}^{(i_r)} \dots A_{\ell}^{(i_1)} + A_{\ell}^{(j)}\right) B_{\ell}.
$$

Moreover, we have that

$$
X_{\ell}^{(j)} B_{\ell}^{-1} = \sum_{\ell < i_1 < \dots < i_r < j} A_{i_r}^{(j)} A_{i_{r-1}}^{(i_r)} \dotsm A_{\ell}^{(i_1)} + A_{\ell}^{(j)}
$$
\n
$$
= X_{j-1}^{(j)} A_{\ell}^{(j-1)} + \dotsm + X_{\ell+2}^{(j)} A_{\ell}^{(\ell+2)} + X_{\ell+1}^{(j)} A_{\ell}^{(\ell+1)} + A_{\ell}^{(j)}
$$
\n
$$
= \sum_{p=\ell+1}^{j-1} X_p^{(j)} A_{\ell}^{(p)} + A_{\ell}^{(j)}.
$$

For notational simplicity, we denote the ith row vector of the matrix $X^{(j)}_\ell$ $\mathcal{L}_{\ell}^{(j)}$ by $x_{\ell,i}^{(j)}$. Then the weight r_i in Proposition [4.4](#page-8-0) equals to

$$
x_{1,i}^{(j)} + \dots + x_{j-1,i}^{(j)} + \varepsilon_{j,i}^*
$$

because B_j is the identity matrix. Hence the pairing

(4.8)

$$
\left\langle r_i, \sum_{p=\ell+1}^m \sum_{k=1}^{n_p+1} (A_{\ell}^{(p)})_{k,z} \varepsilon_{p,k} \right\rangle
$$

$$
= \left\langle x_{\ell+1,i}^{(j)} + \dots + x_{j-1,i}^{(j)} + \varepsilon_{j,i}^*, \sum_{p=\ell+1}^m \sum_{k=1}^{n_p+1} (A_{\ell}^{(p)})_{k,z} \varepsilon_{p,k} \right\rangle
$$

is the (i, z) entry of the matrix $\sum_{p=\ell+1}^{j-1} X_p^{(j)} A_\ell^{(p)} + A_\ell^{(j)}$ $\ell^{(j)}$ for $1 \leq z \leq n_{\ell}+1$. By [\(4.7\)](#page-10-0), the pairing [\(4.8\)](#page-10-1) is same as the (i, z) entry of the matrix $X_{\ell}^{(j)}B_{\ell}^{-1}$:

(4.9)
$$
\left\langle r_i, \sum_{p=\ell+1}^m \sum_{k=1}^{n_p+1} (A_{\ell}^{(p)})_{k,z} \varepsilon_{p,k} \right\rangle = (X_{\ell}^{(j)} B_{\ell}^{-1})_{i,z}.
$$

Subcase 1 $n_{\ell} + 1 \notin S$. In this case, we first note that

(4.10)
$$
\left\langle r_i, \sum_{s \in S} \varepsilon_{\ell,s} \right\rangle = \left\langle x_{\ell,i}^{(j)}, \sum_{s \in S} \varepsilon_{\ell,s} \right\rangle = \sum_{s \in S} (X_{\ell}^{(j)})_{i,s}.
$$

Since B_{ℓ}^{-1} is the column permutation matrix for $v_{\ell,A}$, the right hand side of [\(4.10\)](#page-10-2) coincides with

$$
(4.11) \qquad (X_{\ell}^{(j)}B_{\ell}^{-1})_{i,d+1} + (X_{\ell}^{(j)}B_{\ell}^{-1})_{i,d+2} + \cdots + (X_{\ell}^{(j)}B_{\ell}^{-1})_{i,n_{\ell}+1}.
$$

This is same as *i*th entry of the sum of $(d+1), \ldots, (n_\ell+1)$ th column vectors in $X_{\ell}^{(j)}B_{\ell}^{-1}$. Hence we have the following:

$$
\langle r_i, u_S^{\ell} \rangle = \left\langle r_i, \sum_{s \in S} \varepsilon_{\ell,s} - \sum_{p=\ell+1}^m \sum_{k=1}^{n_p+1} ((A_{\ell}^{(p)})_{k,d+1} + \dots + (A_{\ell}^{(p)})_{k,n_{\ell}+1}) \varepsilon_{p,k} \right\rangle
$$

=
$$
\sum_{s \in S} (X_{\ell}^{(j)})_{i,s}
$$

-
$$
\left((X_{\ell}^{(j)} B_{\ell}^{-1})_{i,d+1} + \dots + (X_{\ell}^{(j)} B_{\ell}^{-1})_{i,n_{\ell}+1} \right) \text{ (by (4.9) and (4.10))}
$$

= 0 (by (4.11)).

Since $w_i^j = r_{i+1} - r_i$, the pairing $\langle w_i^j, u_S^{\ell} \rangle$ vanishes. **Subcase 2** $n_{\ell} + 1 \in S$. In this case, we have

$$
(4.12) \quad \left\langle r_i, -\sum_{s \in [n_{\ell}+1] \setminus S} \varepsilon_{\ell,s} \right\rangle = \left\langle x_{\ell,i}^{(j)}, -\sum_{s \in [n_{\ell}+1] \setminus S} \varepsilon_{\ell,s} \right\rangle = -\sum_{s \in [n_{\ell}+1] \setminus S} (X_{\ell}^{(j)})_{i,s}.
$$

Since B_{ℓ}^{-1} is the column permutation matrix for $v_{\ell,A}$, the right hand side of [\(4.12\)](#page-11-7) coincides with

$$
(4.13) \t- (X_{\ell}^{(j)}B_{\ell}^{-1})_{i,1} - (X_{\ell}^{(j)}B_{\ell}^{-1})_{i,2} - \cdots - (X_{\ell}^{(j)}B_{\ell}^{-1})_{i,d}.
$$

This is same as *i*th entry of the sum of $1st, \ldots, dth$ column vectors in $-X_{\ell}^{(j)}B_{\ell}^{-1}$. Therefore, using the similar argument to Subcase 1, one can see that

$$
\langle r_i, u_S^{\ell} \rangle = \left\langle r_i, - \sum_{s \in [n_{\ell}+1] \setminus S} \varepsilon_{\ell,s} + \sum_{p=\ell+1}^m \sum_{k=1}^{n_p+1} ((A_{\ell}^{(p)})_{k,1} + \dots + (A_{\ell}^{(p)})_{k,d}) \varepsilon_{p,k} \right\rangle
$$

=
$$
- \sum_{s \in [n_{\ell}+1] \setminus S} (X_{\ell}^{(j)})_{i,s}
$$

$$
+ \left((X_{\ell}^{(j)} B_{\ell}^{-1})_{i,1} + \dots + (X_{\ell}^{(j)} B_{\ell}^{-1})_{i,d} \right) \text{ (by (4.9) and (4.12))}
$$

= 0 (by (4.13)).

Hence the pairing $\langle w_i^j, u_S^{\ell} \rangle$ vanishes since $w_i^j = r_{i+1} - r_i$.
