RANDOM JUMPS AND COALESCENCE IN THE CONTINUUM: EVOLUTION OF STATES OF AN INFINITE SYSTEM

Abstract. The dynamics of an infinite continuum system of randomly jumping and coalescing point particles is studied. The states of the system are probability measures on the corresponding configuration space Γ the evolution of which is constructed in the following way. The evolution of observables $F_0 \to F_t$ is obtained from a Kolmogorovtype evolution equation. Then the evolution of states $\mu_0 \to \mu_t$ is defined by the relation $\mu_0(F_t) = \mu_t(F_0)$ for F_0 belonging to a measure-defining class of functions. The main result of the paper is the proof of the existence of the evolution of this type for a bounded time horizon.

1. INTRODUCTION

The random motion of infinite systems in the course of which the constituents can merge attracts considerable attention. The Arratia flow introduced in [\[1](#page-24-0)] provides an example of this kind. In recent years, it has been being extensively studied, see [\[4,](#page-24-1) [7,](#page-24-2) [8,](#page-24-3) [11](#page-24-4)] and the references therein.

In Arratia's model, an infinite number of Brownian particles move in R independently up to their collision, then merge and move together as single particles. Correspondingly, the description of this motion (and its modifications) is performed in terms of stochastic (diffusion) processes. In this work, we propose an alternative look at this kind of motion. Similarly as in the Kawasaki model [\[3,](#page-24-5) [5](#page-24-6)], in the model which we propose and study here point particles perform random jumps with repulsion in \mathbb{R}^d , $d \geq 1$. Additionally, two particles (located at x and y) can merge into a particle (located at z) with intensity (probability per time) $c_1(x, y; z)$. Thereafter, this new particle participates in the motion. The phase space of such a system is the set Γ of all locally finite configurations $\gamma \subset \mathbb{R}^d$, see [\[3,](#page-24-5) [5](#page-24-6), [6](#page-24-7), [9](#page-24-8), [10\]](#page-24-9), and the states of the system are probability measures on Γ the set of which will be denoted as $\mathcal{P}(\Gamma)$. The description of their evolution $\mu_0 \to \mu_t$ is based on the relation $\mu_t(F_0) = \mu_0(F_t)$ where $F_0 : \Gamma \to \mathbb{R}$ is supposed to belong to a measure-defining class of functions, $\mu(F) := \int F d\mu$ and the evolution $F_0 \to F_t$ is obtained by solving the Kolmogorov equation

$$
\frac{d}{dt}F_t = LF_t, \qquad F_t|_{t=0} = F_0,\tag{1.1}
$$

in which the operator L specifies the model, see (3.1) below. The main result of this work (Theorem [3.3\)](#page-6-0) is the construction of the evolution of this kind for $t < T$ (with some $T < \infty$) and μ_0 belonging to a certain set of probability measures on Γ. The basic aspects of this construction can be outlined as follows. Let Ω stand for the set of all compactly supported continuous functions $\omega : \mathbb{R}^d \to (-1, 0]$. Set

Then the collection $\{F^{\omega} : \omega \in \Omega\}$ is a measure-defining class. The set of measures $P_{\text{exp}} \subset \mathcal{P}(\Gamma)$ with which we will work is defined by the condition that its members enjoy

the following property: the map $\Omega \ni \omega \mapsto \mu(F^{\omega}) \in \mathbb{R}$ can be continued to an exponential type entire function on $L^1(\mathbb{R}^d)$. Then, for $\mu \in \mathcal{P}_{\text{exp}}$, we set $B_{\mu}(\omega) = \mu(F^{\omega})$ and derive \widetilde{L} from L according to the rule $(\tilde{L}B_{\mu})(\omega) = \mu(LF^{\omega})$. Thereafter, we construct the evolution $B_{\mu_0} \rightarrow B_t$ by solving the corresponding evolution equation. The next (and the hardest) part of this scheme is to prove that $B_t = B_{\mu_t}$ for a unique $\mu_t \in \mathcal{P}_{\text{exp}}$.

In Section [2,](#page-1-0) we outline the mathematical background of the paper. In Section [3,](#page-3-1) we introduce the model and present the results in the form of Theorems [3.2](#page-5-0) and [3.3.](#page-6-0) Their proof is performed in Sections [4](#page-6-1) and [5,](#page-8-0) respectively.

2. Preliminaries

As mentioned above, we work with the phase space

 $\Gamma = \{ \gamma \subset \mathbb{R}^d : |\Lambda \cap \gamma| < \infty \text{ for any compact } \Lambda \subset \mathbb{R}^d \},$

where $|\cdot|$ denotes cardinality. It is equipped with the vague topology (see e.g., [\[6](#page-24-7), [10](#page-24-9)]) and the corresponding Borel σ -field $\mathcal{B}(\Gamma)$. The set of all finite configurations is denoted by Γ₀. It is the union of the sets $\Gamma^{(n)} = \{ \gamma \in \Gamma : |\gamma| = n \}, n \in \mathbb{N}_0$ that allows one to endow Γ_0 with the disjoint union topology and with the corresponding Borel σ -field $\mathcal{B}(\Gamma_0)$. The topology of each $\Gamma^{(n)}$ is obtained from the Euclidean topology of $(\mathbb{R}^d)^n$ by the symmetrization. Note that $\Gamma_0 \in \mathcal{B}(\Gamma)$.

It can be shown, cf. [\[6\]](#page-24-7), that a function $G: \Gamma_0 \to \mathbb{R}$ is measurable if and only if there exists a collection of symmetric Borel functions $G^{(n)} : (\mathbb{R}^d)^n \to \mathbb{R}$ such that, for any $n \in \mathbb{N}$,

Definition 2.1. A function $G: \Gamma_0 \to \mathbb{R}$ is said to have bounded support if there exist a compact set $\Lambda \subset \mathbb{R}^d$ (spatial support) and an integer $N \in \mathbb{N}$ (quantitative bound) such that $G(\eta) = 0$ whenever $\eta \cap \Lambda^c \neq \emptyset$ or $|\eta| > N$. By \mathcal{B}_{bs} we denote the set of all bounded measurable functions of bounded support.

The Lebesgue-Poisson measure λ on Γ_0 is defined by the integrals

holding for all $G \in \mathcal{B}_{bs}$. For a measurable set $\Lambda \subset \mathbb{R}^d$, we define $\Gamma_{\Lambda} = {\gamma \in \Gamma : \gamma \subset \Lambda}.$ Clearly, $\Gamma_{\Lambda} \in \mathcal{B}(\Gamma)$. We endow Γ_{Λ} with the topology induced from the vague topology of Γ, so that its Borel σ -field is $\mathcal{B}(\Gamma_{\Lambda}) = \{A \cap \Gamma_{\Lambda} : A \in \mathcal{B}(\Gamma)\}\.$ For a given measure $\mu \in \mathcal{P}(\Gamma)$, we define its projection μ^{Λ} by

For each $\mu \in \mathcal{P}(\Gamma)$, we can set, see [\(1.2\)](#page-0-0),

The collection $\{F^{\omega} : \omega \in \Omega\}$ is a measure-defining class in the sense that $\mu(F^{\omega}) = \nu(F^{\omega})$ holding for all $\omega \in \Omega$ implies $\mu = \nu$ for each $\mu, \nu \in \mathcal{P}(\Gamma)$, see [\[3](#page-24-5), page 426]. Then the action of L can be transferred to B_{μ} by means of the rule

This allows one to pass from [\(1.1\)](#page-0-1) to the following evolution equation

\frac{d}{dt}B_t = \widetilde{L}B_t, \qquad B_t|_{t=0} = B_{\mu_0}, \quad \mu_0 \in \mathcal{P}_{\text{exp}}.\tag{2.6}

The advantage of using \mathcal{P}_{exp} is that, for each of its members, the function B_{μ} admits the representation

Here every $k_{\mu}^{(n)}$ is a symmetric element of $L^{\infty}((\mathbb{R}^d)^n)$ such that

with one and the same $C > 0$ for all $n \in \mathbb{N}$. In the second line of [\(2.7\)](#page-2-0), we use the measure λ introduced in [\(2.2\)](#page-1-1), $k_{\mu} : \Gamma_0 \to \mathbb{R}$ is defined by $k_{\mu}(\eta) = k_{\mu}^{(n)}(x_1, \ldots, x_n)$ for $\eta = \{x_1, \ldots, x_n\}, \text{cf. (2.1), and}$ $\eta = \{x_1, \ldots, x_n\}, \text{cf. (2.1), and}$ $\eta = \{x_1, \ldots, x_n\}, \text{cf. (2.1), and}$

The function k_{μ} is called the correlation function of the state μ , whereas $k_{\mu}^{(n)}$ is its n-th order correlation function. k_{μ} completely characterizes $\mu \in \mathcal{P}_{\text{exp}}$. For instance, $k_{\pi_{\varrho}}(\eta) = e(\varrho;\eta)$ for the Poisson measure π_{ϱ} with density $\varrho : \mathbb{R}^d \to [0, +\infty)$. On the other hand, the following is known, see [\[10](#page-24-9), Theorems 6.1, 6.2 and Remark 6.3].

Proposition 2.2. A function $k : \Gamma_0 \to \mathbb{R}$ is a correlation function of a unique measure $\mu \in \mathcal{P}_{\rm exp}$ if and only if it satisfies the conditions: (a) $k(\emptyset) = 1$; (b) the estimate in [\(2.8\)](#page-2-1) holds for some $C > 0$ and all $n \in \mathbb{N}$; (c) for each $G \in \mathcal{B}_{bs}^*$, the following holds

Here

Notably, the cone $\{G \in \mathcal{B}_{bs} : G(\eta) \geq 0\}$ is a proper subset of \mathcal{B}_{bs}^* .

Corollary 2.3. An exponential type entire function $B: L^1(\mathbb{R}) \to \mathbb{R}$ satisfies [\(2.4\)](#page-1-3) for a unique $\mu \in \mathcal{P}_{\text{exp}}$ if and only if it admits the expansion as in [\(2.7\)](#page-2-0) with k satisfying the conditions of Proposition [2.2.](#page-2-2)

Having in mind the latter facts we will look for the solutions of [\(2.6\)](#page-1-4) in the form

where L^{Δ} is to be obtained from \tilde{L} (and thus from L) according to the rule, cf. [\(2.5\)](#page-1-5) and $(2.11),$ $(2.11),$

For $\mu \in \mathcal{P}_{\text{exp}}$ and a compact $\Lambda \subset \mathbb{R}^d$, the projection of μ defined in [\(2.3\)](#page-1-6) is absolutely continuous with respect to the Lebesgue-Poisson measure λ . Let R^{Λ}_{μ} be its Radon-Nikodym derivative. It is related to the correlation function k_{μ} by

One of our tools in this work is based on the Minlos lemma according to which, cf. [\[6](#page-24-7), eq. (2.2)],

3. The Results

Our model is specified by the operator L the action of which on an observable $F : \Gamma \to$ R is

Here $c_1 \geq 0$ is the intensity of the coalescence of the particles located at x and y into a new particle located at z. Note that c_1 does not depend on the elements of γ other than x and y. For simplicity, we assume that $c_1(x, y; z) = c_1(y, x; z) = c_1(x + u, y + u; z + u)$ for all $u \in \mathbb{R}^d$. For a more general version of this model, see [\[13](#page-25-0)]. The second summand in (3.1) describes jumps performed by the particles. As in $[3, 5]$ $[3, 5]$ $[3, 5]$, we set

with ϕ and c_2 being the repulsion potential and the jump kernel, respectively. By these assumptions the model is translation invariant. The functions c_1 , c_2 and ϕ take nonnegative values and satisfy the following conditions:

Now we pass to the equation in [\(2.12\)](#page-2-4). The corresponding operator L^{Δ} is to be calculated from (3.1) by (2.5) and (2.13) . It thus takes the form, cf. [\[13](#page-25-0)],

where $L_1^{\Delta} = L_{11}^{\Delta} + L_{12}^{\Delta} + L_{13}^{\Delta} + L_{14}^{\Delta}$ is the part responsible for the coalescence whereas $L_2^{\Delta} = L_{21}^{\Delta} + L_{22}^{\Delta}$ describes the jumps. Their summands are:

In view of [\(2.8\)](#page-2-1), the Banach spaces for [\(2.12\)](#page-2-4) ought to be of L^{∞} type. Thus, we set

By this definition it follows that each $k \in \mathcal{K}_{\theta}$ satisfies

With the help of this estimate and [\(3.3\)](#page-4-0), we show that the first three summands in L_1^{Δ} satisfy

Since L_2^{Δ} coincides with the corresponding operator of the Kawasaki model, by [\[3](#page-24-5), eq. (3.18)] we have

Let us now define L^{Δ} in a given \mathcal{K}_{θ} . To this end, we set

Then, similarly as in $(3.7) - (3.9)$ $(3.7) - (3.9)$, we obtain that both L_1^{Δ} and L_2^{Δ} map the elements of \mathcal{D}_{θ} into \mathcal{K}_{θ} . Let L^{Δ}_{θ} denote the operator $(L^{\Delta}, \mathcal{D}_{\theta})$. Then, in the Banach space \mathcal{K}_{θ} , the problem in [\(2.12\)](#page-2-4) takes the form

Definition 3.1. A classical solution of (3.11) on a given time interval $[0, T)$ is a continuous function $[0, T) \ni t \mapsto k_t \in \mathcal{D}_{\theta}$ that is continuously differentiable in \mathcal{K}_{θ} on $(0, T)$ and is such that both equalities in [\(3.11\)](#page-5-3) hold.

As is typical for problems like in [\(3.11\)](#page-5-3), in view of the complex character of the corresponding operator it might be unrealistic to expect the existence of classical solutions for all possible $k_0 \in \mathcal{D}_{\theta}$. Thus, we will restrict the choice of k_0 to a proper subset of the domain [\(3.10\)](#page-5-4). For $\theta' > \theta$, we have that $\mathcal{K}_{\theta} \hookrightarrow \mathcal{K}_{\theta'}$, i.e., \mathcal{K}_{θ} is continuously embedded in $\mathcal{K}_{\theta'}$. Similarly as in [\[3](#page-24-5), [5](#page-24-6), [6\]](#page-24-7) we will solve [\(3.11\)](#page-5-3) in the scale $\{\mathcal{K}_{\theta}\}_{\theta \in \mathbb{R}}$. By means of the estimates in $(3.7) - (3.9)$ $(3.7) - (3.9)$ one concludes that L^{Δ} can be defined as a bounded linear operator from \mathcal{K}_{θ} to $\mathcal{K}_{\theta'}$ whenever $\theta' > \theta$. We shall denote this operator by $L^{\Delta}_{\theta'\theta}$. By this estimate one also gets that

Theorem 3.2. For each $\alpha_0 \in \mathbb{R}$ and $\alpha_* > \alpha_0$, and for an arbitrary $k_0 \in \mathcal{K}_{\alpha_0}$, the problem in [\(3.11\)](#page-5-3) has a unique classical solution $k_t \in \mathcal{K}_{\alpha_*}$ on $[0, T(\alpha_*, \alpha_0))$.

A priori the solution k_t described in Theorem [3.2](#page-5-0) need not be a correlation function of any state, which means that the result stated therein has no direct relation to the evolution of states of the system considered. Our next result removes this drawback.

Theorem 3.3. Let $\mu_0 \in \mathcal{P}_{\text{exp}}$ be such that $k_{\mu_0} \in \mathcal{K}_{\alpha_0}$. Then, for each $\alpha_* > \alpha_0$, the evolution $k_{\mu_0} \to k_t$ described in Theorem [3.2](#page-5-0) has the property: for each $t < T(\alpha_*, \alpha_0)/2$, k_t is the correlation function of a unique state $\mu_t \in \mathcal{P}_{\mathrm{exp}}$.

By Theorem [3.3](#page-6-0) we also have the evolution $B_{\mu_0} \to B_t = B_{\mu_t} = \langle e(\cdot;\cdot), k_t \rangle$, where B_t solves [\(2.6\)](#page-1-4), cf. [\(2.11\)](#page-2-3). Along with its purely theoretical value, this result may serve as a starting point for a numerical study of the random motion of this type, cf. [\[12](#page-25-1)], including its consideration at different space and time scales [\[2,](#page-24-10) [14](#page-25-2)]. To this end one can use kinetic equations related to the model specified in [\(3.1\)](#page-3-0), see [\[13](#page-25-0)].

4. Proof of theorem [3.2](#page-5-0)

The solution in question will be obtained in the form

$$

where the family of bounded operators $Q_{\alpha*\alpha_0}(t) : \mathcal{K}_{\alpha_0} \to \mathcal{D}_{\alpha*} \subset \mathcal{K}_{\alpha_*}, t \in (0, T(\alpha_*, \alpha_0))$ satisfies

Additionally, $Q_{\alpha_*\alpha_0}(0)$ is considered as the embedding operator, and hence k_t given in [\(4.1\)](#page-6-2) satisfies the initial condition up to this embeding. Each $Q_{\alpha_*\alpha_0}(t)$ is constructed as a series of t-dependent operators, convergent in the operator norm topology for $t <$ $T(\alpha_*, \alpha_0)$. In estimating the norms of these operators we crucially use $(3.7) - (3.9)$ $(3.7) - (3.9)$.

As the right-hand sides of (3.7) and (3.8) contain different powers of $|\eta|$, it is convenient to split $L^{\Delta} = A + B$ with $A = L_{14}^{\Delta}$. By A_{θ} and B_{θ} we denote the unbounded operators $(A, \mathcal{D}_{\theta})$ and $(B, \mathcal{D}_{\theta})$, respectively. Likewise, we introduce $A_{\theta'\theta}$ and $B_{\theta'\theta}$, $\theta' > \theta$. Their operator norms are to be estimated by means of $(3.7) - (3.9)$ $(3.7) - (3.9)$ and the following inequalities

After some calculations we then get

with $\beta(\theta)$ given in [\(3.14\)](#page-5-6). Now, for $\theta' > \theta$ and $t > 0$, we define a bounded linear (multiplication) operator $S_{\theta'\theta}(t) : \mathcal{K}_{\theta} \to \mathcal{K}_{\theta'}$ by the formula

that readily follows by [\(4.3\)](#page-6-3). Note that the multiplication operator by $\exp(-t\Psi)$ acts from \mathcal{K}_{θ} to \mathcal{K}_{θ} for any θ ; hence, $S_{\theta'\theta}(t) : \mathcal{K}_{\theta} \to \mathcal{D}_{\theta'}$, see [\(3.12\)](#page-5-7). We define it, however, as above in order to have the continuity secured by the estimate in [\(4.5\)](#page-6-4). By [\(4.4\)](#page-6-5), for any $\theta'' \in (\theta, \theta')$, we have that

Let O be an operator acting in each \mathcal{K}_{θ} such that: (a) $O: \mathcal{D}_{\theta} \to \mathcal{K}_{\theta}$; (b) $O: \mathcal{K}_{\theta} \to \mathcal{K}_{\theta'}$ is a bounded operator whenever $\theta' > \theta$. As in the case of A and B, we define the operators $O_{\theta} = (O, \mathcal{D}_{\theta})$ and $O_{\theta' \theta}$. Similarly as in [\(3.13\)](#page-5-8), for these operators, we have

Now we can turn to constructing the resolving operators $Q_{\alpha_*\alpha_0}(t)$, see [\(4.1\)](#page-6-2). For a given $n \in \mathbb{N}$ and $q > 1$, we introduce

In particular $\alpha_{2n+1} = \alpha_*$. For these α_l , $l = 0, \ldots, 2n+1$ and $0 \le t_n \le t_{n-1} \le \ldots \le t_2 \le$ $t_1 \leq t$, we introduce the operator $\pi_{\alpha_{*}\alpha_{0}}^{(n)}(t, t_1, \ldots, t_n) : \mathcal{K}_{\alpha_{0}} \to \mathcal{K}_{\alpha_{*}}$ as follows

\times B_{\alpha_{2n-2}\alpha_{2n-3}}\cdots S_{\alpha_{3}\alpha_{2}}(t_{n-1}-t_{n})B_{\alpha_{2}\alpha_{1}}S_{\alpha_{1}\alpha_{0}}(t_{n}), \quad n \in \mathbb{N}.
$$

Similarly as in obtaining the second equality in [\(4.8\)](#page-7-0), we conclude that $\pi_{\alpha_*\alpha_0}^{(n)}(t, t_1, ..., t_n)$ is independent of the particular choice of the partition of (α_0, α_*) into subintervals (α_l, α_{l+1}) . In view of [\(4.6\)](#page-6-6), we have that

holding for all $\alpha \in (\alpha_0, \alpha_*)$. For the same α , by setting in [\(4.10\)](#page-7-1) $t_1 = t$ we obtain

\pi_{\alpha_*\alpha_0}^{(n)}(t, t, t_2, \dots, t_n) = S_{\alpha_*\alpha_{2n}}(0) B_{\alpha_{2n}\alpha_{2n-1}} \pi_{\alpha_{2n-1}\alpha_0}^{(n-1)}(t, t_2, \dots, t_n) \tag{4.12}

 $= B_{\alpha_*\alpha} \pi_{\alpha\alpha_0}^{(n-1)}(t,t_2,\ldots,t_n),$

see [\(4.8\)](#page-7-0). By [\(4.7\)](#page-6-7) and the second estimate in [\(4.3\)](#page-6-3) we get the following estimate of the operator norm of [\(4.10\)](#page-7-1)

Now we set $Q_{\alpha*\alpha_0}^{(0)}(t) = S_{\alpha*\alpha_0}(t)$ and

Then by [\(4.13\)](#page-7-2) it follows that

||Q_{\alpha_{*}\alpha_{0}}^{(n)}(t) - Q_{\alpha_{*}\alpha_{0}}^{(n-1)}(t)|| \leq \int_{0}^{t} \int_{0}^{t_{1}} \cdots \int_{0}^{t_{n-1}} \left(\frac{n}{e}\right)^{n} \cdot \left(\frac{q}{T(\alpha_{*}, \alpha_{0})}\right)^{n} dt_{1} dt_{2} \dots dt_{n} =
$$

=
$$
\frac{1}{n!} \left(\frac{n}{e}\right)^{n} \cdot \left(\frac{qt}{T(\alpha_{*}, \alpha_{0})}\right)^{n}.
$$

For each $\tau < T(\alpha_*, \alpha_0)$, by using [\(3.14\)](#page-5-6) we conclude that there exist $q > 1$ and $\alpha \in$ (α_0, α_*) such that $q\tau < T(\alpha, \alpha_0)$. Then by the above estimate it follows that, uniformly on

 $[0, \tau], \{Q_{\alpha\alpha_0}^{(n)}(t)\}\$ is a Cauchy sequence with respect to the operator norm. Let $Q_{\alpha\alpha_0}(t)$ be its limit. Clearly, this also applies to the sequence $\{Q_{\alpha_*\alpha_0}^{(n)}(t)\}\$, which therefore converges to $Q_{\alpha_*\alpha_0}(t)$ in the same sense. By this we have that: (a) for each $t \in [0, T(\alpha_*, \alpha_0))$, there exists $\alpha \in (\alpha_0, \alpha_*)$ such that

The latter follows by (3.12) and (4.15) . In the sequel, we will use the following estimate

Fix $\tau < T(\alpha_*, \alpha_0)$ and then pick $\alpha \in (\alpha_0, \alpha_*)$ such that $q\tau < T(\alpha, \alpha_0)$. By the arguments used above the right-hand side of [\(4.17\)](#page-8-2) converges as $n \to +\infty$, uniformly on [0, τ], to

This completes the proof that k_t given in [\(4.1\)](#page-6-2) is a solution of the problem in [\(3.11\)](#page-5-3) in the sense of Definition [3.1.](#page-5-9) The uniqueness stated in the theorem can be obtained similarly as in the proof of the same property in [\[3,](#page-24-5) Lemma 4.1].

5. Proof of Theorem [3.3](#page-6-0)

In this case, the proof is much longer and will be done in several steps. In view of [\(3.3\)](#page-4-0), the solution described by Theorem [3.2](#page-5-0) has the property $k_t(\emptyset) = k_0(\emptyset)$ for all $t < T(\alpha_*, \alpha_0)$ since $(L^{\Delta}k)(\emptyset) = 0$. By the very choice of the spaces [\(3.5\)](#page-4-1) this solution satisfies condition (b) of Proposition [2.2.](#page-2-2) Thus, it remains to prove that it has the positivity property defined in [\(2.9\)](#page-2-6). To this end we make the following. First, in subsection [5.1](#page-8-3) we introduce an auxiliary model, described by L^{σ} with some $\sigma > 0$. For this model, by repeating the proof of Theorem [3.2](#page-5-0) we obtain the evolution $k_0 \to k_t^{\sigma}$ in \mathcal{K}_{θ} -spaces. In subsection [5.3,](#page-11-0) we prove that

holding for all $G \in \mathcal{B}_{bs}$, cf. [\(2.9\)](#page-2-6) and [\(2.10\)](#page-2-7). In the proof, we use the predual evolution constructed in subsection [5.2.](#page-9-0) To show that k_t^{σ} has the positivity property [\(2.9\)](#page-2-6) we construct its approximations (subsection [5.4\)](#page-14-0). As we then show, these approximations coincide with the directly obtained local correlation functions, see [\(5.31\)](#page-15-0) and Corollary [5.8,](#page-21-0) that have the required positivity by construction. Finally, in subsection [5.4.4](#page-21-1) we eliminate the approximation and thus obtain the desired positivity of k_t^{σ} .

5.1. **Auxiliary model.** For a given $\sigma > 0$, we set $\psi_{\sigma}(x) = e^{-\sigma |x|^2}$, $x \in \mathbb{R}^d$. Obviously

Then we repeat the steps made in [\(2.5\)](#page-1-5) and [\(2.13\)](#page-2-5) to obtain the operator $L^{\Delta,\sigma} = L_1^{\Delta,\sigma} +$ $L_2^{\Delta,\sigma}$ $\frac{\Delta, \sigma}{2}$ in the following form, cf. [\(3.3\)](#page-4-0),

and then define the operators $A_{\theta}^{\sigma} = (A^{\sigma}, \mathcal{D}_{\theta}), B_{\theta}^{\sigma} = (B^{\sigma}, \mathcal{D}_{\theta}), L_{\theta}^{\Delta, \sigma} = A_{\theta}^{\sigma} + B_{\theta}^{\sigma}, A_{\theta^{\prime} \theta}^{\sigma},$ $B_{\theta'\theta}^{\sigma}$ for $\theta' > \theta$ and \mathcal{D}_{θ} defined in [\(3.10\)](#page-5-4). Since $\psi_{\sigma} \leq 1$, by the literal repetition of the proof of Theorem [3.2](#page-5-0) we construct the family of operators $Q_{\alpha_{*}\alpha_{0}}^{\sigma}(t)$, $\alpha_{0} \in \mathbb{R}$, $\alpha_{*} > \alpha$, $t \in [0, T(\alpha_*, \alpha_0))$ such that $k_t^{\sigma} = Q_{\alpha_* \alpha_0}^{\sigma}(t) k_0$ with $k_0 \in \mathcal{K}_{\alpha_0}$ is the unique classical solution – on the time interval $[0, T(\alpha_*, \alpha_0))$ with $T(\alpha_*, \alpha_0)$ as in (3.14) – of the problem

5.2. **Predual evolution.** To prove (5.1) we allow G to evolve accordingly to the rule

The proper context to this is to construct the corresponding evolution in the space predual to $\mathcal{K}_{\alpha*}$, which ought to be of L^1 -type. For $\theta \in \mathbb{R}$, we introduce

Notably, $G \in \mathcal{B}_{bs}$ lies in \mathcal{G}_{θ} with an arbitrary $\theta \in \mathbb{R}$. Indeed, let M be the bound of $|G|$ and N and Λ be as in Definition [2.1.](#page-1-7) Then we have

Let $Q_{\alpha_*\alpha_0}(t)$, $\alpha_0 \in \mathbb{R}$, $\alpha_* > \alpha_0$, $t < T(\alpha_*, \alpha_0)$, see [\(3.14\)](#page-5-6), be the family of bounded operators constructed in the proof of Theorem [3.2.](#page-5-0) Then there exists the family $H_{\alpha_0\alpha_*}(t): \mathcal{G}_{\alpha_*} \to \mathcal{G}_{\alpha_0}, t < T(\alpha_*, \alpha_0)$ such that: (a) the norm of $H_{\alpha_0\alpha_*}(t)$ satisfies [\(4.16\)](#page-8-4); (b) for each $G \in \mathcal{G}_{\alpha*}$ and $k \in \mathcal{K}_{\alpha_0}$, the following holds

(c) the map $[0, T(\alpha_*, \alpha_0)) \ni t \mapsto H_{\alpha_0 \alpha_*}(t)$ is continuous in the operator norm topology.

Proof. Clearly, the most challenging part is the continuity stated in (c). Thus, we start by deriving the corresponding generating operator. To this end, we use the rule

Like in the dual spaces \mathcal{K}_{θ} , cf. [\(3.12\)](#page-5-7), here we have that both \hat{A} and \hat{B} map $\hat{\mathcal{D}}_{\theta}$ in \mathcal{G}_{θ} . This allows one to introduce the operators $\hat{A}_{\theta} = (\hat{A}, \hat{\mathcal{D}}_{\theta})$ and $\hat{B}_{\theta} = (\hat{B}, \hat{\mathcal{D}}_{\theta})$ as well as bounded operators $\hat{A}_{\theta\theta'}$ and $\hat{B}_{\theta\theta'}$ mapping $\mathcal{G}_{\theta'}$ to \mathcal{G}_{θ} for $\theta' > \theta$. Their operator norms satisfy the same estimates as the norms of $A_{\theta'\theta}$ and $B_{\theta'\theta}$, respectively, see [\(4.3\)](#page-6-3).

For such θ and θ' , we also set $\hat{S}_{\theta\theta'}(t):\mathcal{G}_{\theta'}\to\mathcal{G}_{\theta}$ to be the multiplication operator by the function $\exp(-t\Psi(\eta))$. Similarly as in [\(4.5\)](#page-6-4) one shows that

Since the operator norms of all \hat{S} and \hat{B} satisfy the same estimates as the norms of respectively S and B, the operator norm of $\varpi_{\alpha_0\alpha_{**}}^{(n)}$ satisfies [\(4.13\)](#page-7-2). Hence, the series in [\(5.11\)](#page-11-1) converges in the norm topology, uniformly on compact subsets of $[0, T(\alpha_*, \alpha_0))$, which together with (5.9) yields the continuity stated in claim (c) and the bound stated in (a). In view of the convergence just mentioned, to prove [\(5.7\)](#page-10-1) it is enough to show that, for each $n \in \mathbb{N}$ and $0 \le t_n \le t_{n-1} \le \cdots \le t_1 \le t$, the following holds

To this end, we fix $t < T(\alpha_*, \alpha_0)/2$, take $\alpha_1 = (\alpha_* + \alpha_0)/2$ and $\alpha_2 = \alpha_1 + \epsilon \beta(\alpha_*)$ with $\epsilon > 0$ being chosen later and such that $\alpha_2 < \alpha_*$. For this choice, by [\(3.14\)](#page-5-6) we have that $T(\alpha_1, \alpha_0) \geq \frac{1}{2}$ $\frac{1}{2}T(\alpha_*, \alpha_0) > t$ since $\beta(\theta)$ is increasing. At the same time, $T(\alpha_*, \alpha_2)$) + ϵ = 1 $\frac{1}{2}T(\alpha_*, \alpha_0)$. Then we take $\epsilon = (\frac{1}{2}T(\alpha_*, \alpha_0) - t)/2$ in the choice of α_2 , which yields $\bar{t} < T(\alpha_*, \alpha_2).$

5.4. **Approximations.** Our aim now is to prove that $k_t^{\sigma} = Q_{\alpha*\alpha_0}^{\sigma}(t)k_0$ has the positivity property defined in [\(2.9\)](#page-2-6) whenever k_0 is the correlation function of a certain $\mu_0 \in \mathcal{P}_{\text{exp}}$. Then, for $t < T(\alpha_*, \alpha_0)/2$, the same positivity property of $k_t = Q_{\alpha_* \alpha_0}(t) k_0$ will follow by Lemma [5.2.](#page-11-7) Similarly as in [\[3](#page-24-5), [9\]](#page-24-8), the main idea of proving the positivity of k_t^{σ} is to approximate it by a correlation function of a finite system of this kind, which is positive by Proposition [2.2.](#page-2-2) Thereafter, one has to prove that the positivity is preserved when the approximation is eliminated.

5.4.1. The approximate evolution. For a compact $\Lambda \subset \mathbb{R}^d$, let μ_0^{Λ} be the projection of the initial state μ_0 , see [\(2.3\)](#page-1-6). Then its density $R_{\mu_0}^{\Lambda}$ and the correlation function k_0 are related to each other in (2.14) . For $N \in \mathbb{N}$, we set

By this fact, $q_t^{\Lambda,N}$ $t^{N,N}$ satisfies [\(5.29\)](#page-15-4), which will yield the proof. According to this, we proceed by constructing the evolution $R_0^{\Lambda,N} \to R_t^{\Lambda,N}$ $\frac{1}{t}$, $\frac{1}{t}$, which will allow us to use $q_t^{\Lambda,N}$ defined in [\(5.31\)](#page-15-0). The next step will be to prove [\(5.30\)](#page-15-5).

5.4.2. The local evolution. As just mentioned, the evolution $R_0^{\Lambda,N} \to R_t^{\Lambda,N}$ $t^{A,N}$ is related to the local evolution of the auxiliary model described by L^{σ} , see subsection [5.1.](#page-8-3) Here *local* means the following. Assume that the initial state ν_0 is such that $\nu_0(\Gamma_0) = 1$. That is, the system is finite and hence local. Assume also that it has density $R_{\nu_0} = \frac{d\nu_0}{d\lambda}$. Then the evolution related to the Kolmogorov equation with L^{σ} can be described as the evolution of densities by solving the corresponding Fokker-Planck equation

Our aim now is to show that L^{\dagger} is the generator of a stochastic semigroup $S^{\dagger} = \{S^{\dagger}(t)\}_{t \geq 0}$, which we will use to obtain $R_t^{\Lambda,N}$ $t_t^{\Lambda,N}$ in the form $S^{\dagger}(t)R_0^{\Lambda,N}$ $_{0}^{\Lambda,N}$. In doing this, we follow the scheme developed in [\[3](#page-24-5), Sect. 3.1].

The semigroup S^{\dagger} is supposed to act in the space \mathcal{G}_0 , see [\(5.5\)](#page-10-4). Along with this space we will also use

The construction of the semigroup S^{\dagger} is performed by means of the perturbation technique developed in [\[15\]](#page-25-3). We formulate here the corresponding statement borrowed from [\[3](#page-24-5), Proposition 3.2] in the form adapted to the present context.

By means of this statement we prove the following.

Lemma 5.5. The closure of the operator $(A^{\dagger}, \mathcal{D}^{\dagger})$ defined in [\(5.39\)](#page-16-1), [\(5.40\)](#page-16-2) generates a stochastic semigroup $S^{\dagger} = \{S^{\dagger}(t)\}_{t \geq 0}$ of operators in \mathcal{G}_0 that leaves invariant $\mathcal{G}_{\theta}^{fac}$ with any $\theta \in \mathbb{R}$.

Then $q_t^{\Lambda,N}$ $t^{ \Lambda, N }_{ t } (\emptyset) \ = \ | R_t^{ \Lambda, N }$ $\binom{\Lambda, N}{t}$ | 0 \le 1 and $q_t^{\Lambda, N}$ has both (b) and (c) properties of Proposition [2.2.](#page-2-2) By [\(5.33\)](#page-15-7) and then by [\(2.13\)](#page-2-5) and [\(2.5\)](#page-1-5) we conclude that

\forall \theta' > \theta \qquad \mathcal{G}_{\theta'}^{fac} \subset \mathcal{D}_{\theta}^{fac}.
$$

Lemma 5.6. For each $\theta \in \mathbb{R}$, the function $t \mapsto q_t^{\Lambda,N} \in \mathcal{D}_\theta^{fac} \subset \mathcal{G}_\theta^{fac}$ defined in [\(5.31\)](#page-15-0) is a unique global in time classical solution of the Cauchy problem

$$
\frac{d}{dt}G_t = L_{\theta}^{fac,\Delta,\sigma}G_t, \qquad G_t|_{t=0} = q_0^{\Lambda,N},\tag{5.52}
$$

with $R_0^{\Lambda,N}$ $\int_0^{\Lambda,\scriptscriptstyle{N}}$ defined in [\(5.26\)](#page-15-1).

Proof. The continuity and continuous differentiability of the function $t \mapsto q_t^{\Lambda,N} \in \mathcal{G}_{\theta}^{fac}$ follow by [\(5.46\)](#page-18-3) and the fact that S^{\dagger} is a C_0 -semigroup. The inclusion $q_t^{\Lambda,N} \in \mathcal{D}_{\theta}^{fac}$ follows by [\(5.48\)](#page-19-0) and the fact that $R_t^{\Lambda,N} \in \mathcal{G}_{\theta'}^{fac}$ with an arbitrary θ' , see [\(5.37\)](#page-16-6) and [\(5.50\)](#page-19-2). The fact that $q_t^{\Lambda,N}$ $t^{A,N}$ satisfies the first equality in [\(5.52\)](#page-19-3) can be proved by means of [\(5.47\)](#page-18-2). Thus, it remains to prove the stated uniqueness. Take any $\theta'' > \theta' > \theta$ and consider the problem in [\(5.52\)](#page-19-3) in $\mathcal{G}_{\theta\prime}^{fac}$ $f_{\theta'}^{fac}$. Since the initial condition $q_0^{\Lambda,N}$ $\mathcal{L}_{0}^{\Lambda,N}$ lies in $\mathcal{G}_{\theta^{\prime\prime}}^{fac}$ θ^{μ} , by means of the estimates in [\(5.51\)](#page-19-4) and the technique developed for the proof of Theorem [3.2](#page-5-0) one can prove the existence of a unique classical solution of the latter problem in $\mathcal{G}_{\theta\theta}^{fac}$ $_{\theta ^{\prime }}^{Jac},$ on a bounded time interval. The latter thus coincides with the one given in [\(5.31\)](#page-15-0), which yields the uniqueness in question of this interval. Its further continuation is performed by repeating the same arguments. \Box

5.4.3. The common evolution. Our aim now is to show that [\(5.30\)](#page-15-5) holds, which by [\(5.31\)](#page-15-0) would yield the desired positivity of $k_t^{\Lambda,N}$ $t^{A,N}_{t}$. A priori [\(5.30\)](#page-15-5) does not make any sense as $k^{\Lambda,N}_t$ $t_t^{\Lambda,N}$ and $q_t^{\Lambda,N}$ belong to different spaces (and are not defined pointwise). The resolution consists in placing $k_t^{\Lambda,N}$ $t_t^{\Lambda,N}$ and $q_t^{\Lambda,N}$ $t^{A,N}$ into a common subspace of these two spaces, that is $\mathcal{U}_{\theta}^{\sigma}$ which we define now.

For $u : \Gamma_0 \to \mathbb{R}$, we set

||u||_{\sigma,\theta} = \underset{\eta \in \Gamma_0}{\text{ess sup}} \frac{|u(\eta)|e^{-\theta|\eta|}}{e(\psi_{\sigma};\eta)},

where $e(\psi_{\sigma}; \eta) = \prod_{x \in \eta}$ $e^{-\sigma|x|^2}$. Analogously as in [\(3.6\)](#page-5-10), we have

\mathcal{U} \subset \mathcal{U}^{\sigma} \text{ we have } \mathcal{U}^{\sigma} = \mathcal{U}^{\sigma} \text{ as } \mathcal{U} \subset \mathcal{U}^{\sigma}.

By [\(5.53\)](#page-20-0) and [\(5.36\)](#page-16-7), for $u \in \mathcal{U}_{\theta}^{\sigma}$, we have that

|u|_{\text{fac},\theta'} \leq \int_{\Gamma_0} e(\psi_{\sigma}; \eta) e^{(\theta+\theta')|\eta|} |\eta|! |u|_{\sigma,\theta} \lambda(d\eta)
$$

= \|u\|_{\sigma,\theta} \sum_{n=0}^{\infty} \left(e^{\theta+\theta'} \int_{\mathbb{R}^d} \psi_{\sigma}(x) dx \right)^n = \|u\|_{\sigma,\theta} \sum_{n=0}^{\infty} \left(e^{\theta+\theta'} \left(\frac{\pi}{\sigma} \right)^{d/2} \right)^n,
$$

which yields, cf. [\(5.54\)](#page-20-1),

\mathcal{U}_{\theta}^{\sigma} \subset \mathcal{G}_{\theta'}^{\text{fac}}, \qquad \text{for} \ \theta' < -\theta - \frac{d}{2}(\ln \pi - \ln \sigma). \tag{5.55}

Since $k_0^{\Lambda,N} = q_0^{\Lambda,N}$ $\mathcal{O}_0^{\Lambda,N}$, it belongs to $\mathcal{U}_{\alpha_0}^{\sigma}$ and to $\mathcal{G}_{\beta_0}^{\text{fac}}$ with

To prove the former, by [\(5.27\)](#page-15-2) we readily get

Our aim now is to prove that both evolutions $q_0^{\Lambda,N} = k_0^{\Lambda,N} \to k_t^{\Lambda,N}$ $\Lambda^{A,N}_{t}$ and $q_0^{\Lambda,N} \to q_t^{\Lambda,N}$ t take place in $\mathcal{U}^{\sigma}_{\alpha^*}$. To this end, we define $L^{\Delta,\sigma}$ in $\mathcal{U}^{\sigma}_{\theta}$ and split it $L^{\Delta,\sigma} = A^{\sigma} + B^{\sigma}$, as we did in [\(5.3\)](#page-9-1). Then set

see [\(3.10\)](#page-5-4) and [\(5.54\)](#page-20-1). At the same time, similarly as in [\(5.55\)](#page-20-2) one shows that

\mathcal{D}_{\theta}^{\sigma} \subset \mathcal{D}_{\theta'}^{fac}, \quad \text{for} \quad \theta' < -\theta - \frac{d}{2}(\ln \pi - \ln \sigma). \tag{5.58}

Like above, one can show that $\mathcal{U}^{\sigma}_{\theta''} \subset \mathcal{D}^{\sigma}_{\theta}$ whenever $\theta'' < \theta$, cf. [\(3.12\)](#page-5-7). Thus, $A^{\sigma}: \mathcal{D}^{\sigma}_{\theta} \to$ $\mathcal{U}_{\theta}^{\sigma}$. Likewise, B^{σ} : $\mathcal{D}_{\theta}^{\sigma} \to \mathcal{U}_{\theta}^{\sigma}$, and hence we can define in $\mathcal{U}_{\theta}^{\sigma}$ the unbounded operators $A^{\sigma}_{u,\theta} = (A^{\sigma}, \mathcal{D}^{\sigma}_{\theta}), B^{\sigma}_{u,\theta} = (B^{\sigma}, \mathcal{D}^{\sigma}_{\theta})$ and $L^{\Delta,\sigma}_{u,\theta} = (A^{\sigma} + B^{\sigma}, \mathcal{D}^{\sigma}_{\theta})$. Note that $L^{\Delta,\sigma}_{u,\theta}$ satisfies, cf. [\(5.57\)](#page-20-3),

That is, $L_{u,\theta}^{\Delta,\sigma} = L_{\theta}^{\Delta,\sigma}$ $\partial_{\theta}^{\alpha, \sigma}|_{\mathcal{D}_{\theta}^{\sigma}}$, that holds for each $\theta \in \mathbb{R}$; as well as, $L_{u,\theta}^{\Delta,\sigma} = L_{\theta'}^{fac,\Delta,\sigma}$ $\int_{\theta'}^{fac,\Delta,\sigma} |_{\mathcal{D}_{\theta}^{\sigma}}$, holding for all θ and θ' satisfying [\(5.55\)](#page-20-2).

Let us now consider the problem

Its solution is to be understood according to Definition [3.1.](#page-5-9)

Lemma 5.7. Let α_* and α_0 be as in Theorem [3.2,](#page-5-0) and then $T(\alpha_*, \alpha_0)$ be as in [\(3.14\)](#page-5-6). Then the problem in [\(5.61\)](#page-20-5) has a unique classical solution in $\mathcal{U}^{\sigma}_{\alpha*}$ on the time interval $[0, T(\alpha_*, \alpha_0)).$

Proof. As in the case of Theorem [3.2,](#page-5-0) the present proof is based on the following estimates of the summands of $L^{\Delta,\sigma}$, cf. [\(3.7\)](#page-5-1) and [\(3.8\)](#page-5-5). By [\(5.53\)](#page-20-0) and [\(2.15\)](#page-3-2) together with [\(2.16\)](#page-3-3), for $\theta' > \theta$, we get

||L_{11}^{\Delta,\sigma}u||_{\sigma,\theta'} \le \underset{\eta \in \Gamma_0}{\text{ess sup}} \frac{e^{-\theta'|\eta|}}{e(\psi_{\sigma};\eta)} \cdot \frac{1}{2} \int\limits_{(\mathbb{R}^d)^2} \sum_{z \in \eta} \psi_{\sigma}(z) c_1(x,y;z) |u(\eta \backslash z \cup \{x,y\})| dxdy \quad (5.62)
$$

$$
\le \underset{\eta \in \Gamma_0}{\text{ess sup}} e^{-(\theta' - \theta)|\eta|} \cdot \frac{1}{2} e^{\theta} ||u||_{\sigma,\theta} \int\limits_{(\mathbb{R}^d)^2} \sum_{z \in \eta} c_1(x,y;z) \psi_{\sigma}(x) \psi_{\sigma}(y) dxdy
$$

$$
\le \frac{e^{\theta} \langle c_1 \rangle}{2e(\theta' - \theta)} ||u||_{\sigma,\theta}.
$$

Similarly, one obtains, cf. [\(3.7\)](#page-5-1), that $L_{12}^{\Delta,\sigma}$ and $L_{13}^{\Delta,\sigma}$ satisfy [\(5.62\)](#page-21-2), and furthermore, cf. [\(3.9\)](#page-5-2),

||L_2^{\Delta,\sigma}u||_{\sigma,\theta'} \leq \frac{2\langle c_2\rangle}{e(\theta'-\theta)} \exp\left(\langle \phi \rangle e^{\theta}\right) ||u||_{\sigma}.

By means of these estimates we define a bounded operator $(B_u^{\sigma})_{\theta'\theta}$ acting from $\mathcal{U}_{\theta}^{\sigma}$ to $\mathcal{U}_{\theta'}^{\sigma}$. Its norm satisfies the corresponding estimate in [\(4.3\)](#page-6-3) with the same right-hand side. Then the proof follows in the same way as in the case of Theorem [3.2.](#page-5-0)

Corollary 5.8. For each fixed $\sigma > 0$ and all $t < T(\alpha_*, \alpha_0)$, it follows that $k_t^{\Lambda, N} = q_t^{\Lambda, N}$ $\frac{1}{t}$, $\frac{1}{t}$, and hence $k_t^{\Lambda,N}$ $t^{A,N}$ satisfies [\(5.29\)](#page-15-4) for all $G \in \mathcal{B}_{bs}^*$.

Proof. We take

Then $k_t^{\Lambda,N} = Q_{\alpha_*\alpha_0}^{\sigma}(t) k_0^{\Lambda,N}$ $\int_{0}^{\Lambda,N}$ is a unique classical solution of the problem in [\(5.4\)](#page-9-3) with the initial condition $k_0^{\Lambda,N}$ $\int_0^{R,N}$. Let $u_t, t < T(\alpha_*, \alpha_0)$ be the solution of the problem in [\(5.61\)](#page-20-5). Then the map $t \mapsto u_t \in \mathcal{U}^{\sigma}_{\alpha_*} \subset \mathcal{K}_{\alpha_*}$, cf. [\(5.64\)](#page-21-3), is continuous and continuously differentiable in $\mathcal{K}_{\alpha*}$ as the corresponding embedding is continuous. By [\(5.59\)](#page-20-7) u_t satisfies also [\(5.4\)](#page-9-3) with the initial condition $q_0^{\Lambda,N} = k_0^{\Lambda,N}$ $_{0}^{\Lambda,N}$, and hence $u_t = k_t^{\Lambda,N} = Q_{\alpha_*\alpha_0}^{\sigma}(t) q_0^{\Lambda,N}$ $\int_0^{\Lambda,\Lambda}$ in view of the uniqueness of the solution of [\(5.4\)](#page-9-3). Likewise, by [\(5.60\)](#page-20-8) and Lemma [5.6](#page-19-5) one proves that $u_t = q_t^{\Lambda, N}$ $t_t^{\Lambda,N}, t < T(\alpha_*, \alpha_0)$, where $q_t^{\Lambda,N}$ $t_t^{\Lambda,N}$ is the unique solution of [\(5.52\)](#page-19-3) in $\mathcal{G}_{\beta_*}^{fac}$ β∗ with β_* as in [\(5.63\)](#page-21-4).

5.4.4. Eliminating the approximations. We recall that $k_t^{\Lambda,N} = Q_{\alpha_*\alpha_0}^{\sigma}(t) k_0^{\Lambda,N}$ $_{0}^{\Lambda, N}$ approximates $k_t^{\sigma} = Q_{\alpha_*\alpha_0}^{\sigma}(t) k_0$ that solves [\(5.4\)](#page-9-3) and is mentioned in Lemma [5.2.](#page-11-7) Our aim now is to eliminate this approximation. By a cofinal sequence of compact subsets $\{\Lambda_n\}_{n\in\mathbb{N}}$ we mean a sequence which is ordered by inclusion $\Lambda_n \subset \Lambda_{n+1}$ and exhaustive in the sense that each $x \in \mathbb{R}^d$ is eventually contained in its element.

Lemma 5.9. For each fixed $\sigma > 0$, $t < T(\alpha_*, \alpha_0)$ and any cofinal sequence $\{\Lambda_n\}_{n \in \mathbb{N}}$, it follows that

$$
\forall G \in \mathcal{B}_{bs} \qquad \lim_{n \to \infty} \left(\lim_{N \to \infty} \langle G, k_t^{\Lambda_n, N} \rangle \right) = \langle G, k_t^{\sigma} \rangle. \tag{5.65}

Proof. We mostly follow the line of arguments used in [\[5](#page-24-6), Appendix]. Throughout the proof $\sigma > 0$ will be fixed. For $t < T(\alpha_*, \alpha_0)$, by [\(5.7\)](#page-10-1) we have

J_{n,N}^{(2)} = \int_{\Gamma_0} G_t(\eta) \left(k_0(\eta) \mathbb{1}_{\Gamma_{\Lambda_n}}(\eta) - k_0^{\Lambda_n, N}(\eta)\right) \lambda(d\eta),
$$
\n(5.66)

and $1\!\!1_{\Gamma_{\Lambda_n}}$ is the indicator of Γ_{Λ_n} . Let us prove that, for each $n, J_{n,N}^{(2)} \to 0$ as $N \to +\infty$. To this end we rewrite it in the following form

= \int_{\Gamma_0} G_t(\eta) \int_{\Gamma_0} R_0^{\Lambda_n}(\eta \cup \xi) I_{\Gamma_{\Lambda_n}}(\eta \cup \xi) (1 - I_N(\eta \cup \xi)) \lambda(d\xi) \lambda(d\eta)
$$

$$
= \int_{\Gamma_{\Lambda_n}} \sum_{\xi \subset \eta} G_t(\xi) R_0^{\Lambda_n}(\eta) (1 - I_N(\eta)) \lambda(d\eta)
$$

\n
$$
= \sum_{m=N+1}^{\infty} \frac{1}{m!} \int_{(\Lambda_n)^m} R_0^{\Lambda_n}(\{x_1, \ldots, x_m\})
$$

\n
$$
\times \sum_{k=0}^m \sum_{\{i_1, \ldots i_k\} \subset \{1, \ldots m\}} G_t^{(k)}(x_{i_1}, \ldots, x_{i_k}) dx_1 \cdots dx_m,
$$

where $I_N(\eta) = 1$ whenever $|\eta| \leq N$ and $I_N(\eta) = 0$ otherwise. By (2.14) for $k_0 \in \mathcal{K}_{\alpha_0}$, it follows that

R_0^{\Lambda}(\{y_1,\ldots,y_s\}) \le k_0(\{y_1,\ldots,y_s\}) \le e^{\alpha_0 s} ||k_0||_{\alpha_0}.

\times \sum_{m=N+1}^{\infty} \frac{1}{m!} e^{\alpha_0 m} \int_{(\Lambda_n)^m} \sum_{k=0}^m \sum_{\{i_1,\dots i_k\} \subset \{1,\dots m\}} |G_t^{(k)}(x_{i_1},\dots,x_{i_k})| dx_1 \cdots dx_m
$$
\n
$$
\leq ||k_0||_{\alpha_0} \sum_{m=N+1}^{\infty} \frac{1}{m!} e^{\alpha_0 m} \sum_{k=0}^m \frac{m!}{k!(m-k)!} ||G_t^{(k)}||_{L^1((\mathbb{R}^d)^k)} |\Lambda_n|^{m-k},
$$
\n(5.68)

where $|\Lambda|$ stands for the Lebesgue measure of Λ . The sum over m in the last line of [\(5.68\)](#page-22-1) is the remainder of the series

|G_t|_{\alpha_0} \exp\left(e^{\alpha_0} |\Lambda_n|\right).

Hence, by [\(5.68\)](#page-22-1) we obtain that

For each $t < T(\alpha_*, \alpha_0)$, one finds $\epsilon > 0$ such that $t < T(\alpha_* + \epsilon, \alpha_0 + \epsilon)$, see [\(3.14\)](#page-5-6). We fix these t and ϵ . Since $G_0 \in \mathcal{B}_{bs}$, and hence $G_0 \in \mathcal{G}_{\alpha^*+\epsilon}$, by Lemma [5.1](#page-10-3) we have that $G_t \in \mathcal{G}_{\alpha_0 + \epsilon}$. We apply the latter fact in the estimate above and obtain

$$
|J_n^{(1)}| \le \frac{\|k_0\|_{\alpha_0}}{e\epsilon} \Delta_n, \tag{5.69}
$$

$$
\Delta_n := \sum_{p=1}^{\infty} \frac{1}{p!} e^{(\alpha_0 + \epsilon)p} \int_{\Lambda_n^c} \int_{\mathbb{R}^d} |G_t^{(p)}(x_1, \dots, x_p)| dx_1 \cdots dx_p.
$$

Furthermore, for each $M \in \mathbb{N}$, we have

$$
\Delta_n \leq \Delta_{n,M}^{(1)} + \Delta_M^{(2)},
$$
\n
$$
\Delta_{n,M}^{(1)} := \sum_{p=1}^M \frac{1}{p!} e^{(\alpha_0 + \epsilon)p} \int_{\Lambda_n^c} \int_{\{R^d\}^{p-1}} |G_t^{(p)}(x_1, \dots, x_p)| dx_1 \cdots dx_p,
$$
\n
$$
\Delta_M^{(2)} := \sum_{p=M+1}^\infty \frac{1}{p!} e^{(\alpha_0 + \epsilon)p} \int_{\{R^d\}^p} |G_t^{(p)}(x_1, \dots, x_p)| dx_1 \cdots dx_p,
$$
\n(5.70)

Fix some $\varepsilon > 0$, and then pick M such that $\Delta_M^{(2)} < \varepsilon/2$, which is possible since

$$
\sum_{p=1}^{\infty} \frac{1}{p!} e^{(\alpha_0 + \epsilon)p} \int\limits_{(\mathbb{R}^d)^p} |G_t^{(p)}(x_1, \dots, x_p)| dx_1 \cdots dx_p = |G_t|_{\alpha_0 + \epsilon},
$$

as $G_t \in \mathcal{G}_{\alpha_0+\epsilon}$. At the same time,

$$
\forall p \in \mathbb{N} \qquad g_p(x) := \int_{(\mathbb{R}^d)^{p-1}} |G_t^{(p)}(x, x_2, \dots, x_p)| dx_2 \cdots dx_p \in L^1(\mathbb{R}^d).
$$

Thus, since the sequence $\{\Lambda_n\}$ is exhausting, for M satisfying $\Delta_M^{(2)} < \varepsilon/2$, there exists n_1 such that, for $n > n_1$, the following holds

$$
\Delta_{n,M}^{(1)} = \sum_{p=1}^{M} \frac{1}{p!} e^{(\alpha_0 + \epsilon)p} \int\limits_{\Lambda_n^c} g_p(x) dx < \frac{\varepsilon}{2}.
$$

By [\(5.70\)](#page-23-0) this yields $\Delta_n < \varepsilon$ for all $n > n_1$, which by [\(5.69\)](#page-23-1) completes the proof.

5.4.5. The proof of Theorem [3.3.](#page-6-0) The proof will be done by showing that the solution k_t described in Theorem [3.2](#page-5-0) has the three properties mentioned in Proposition [2.2.](#page-2-2) As discussed at the beginning of Section [5,](#page-8-0) k_t surely has properties (a) and (b). By Corollary [5.8](#page-21-0) and Lemma [5.9](#page-22-4) we have that k_t^{σ} satisfies [\(2.9\)](#page-2-6) for all $t < T(\alpha_*, \alpha_0)$ and $\sigma > 0$. Then by Lemma [5.2](#page-11-7) we get that k_t also satisfies [\(2.9\)](#page-2-6) for $t < T(\alpha_*, \alpha_0)/2$, that completes the proof.
