#### Self-interacting Brownian motion\*

#### Abstract

We prove a property of Brownian bridges whose certain time-equidistant sequences of points are pairwise coupled by an interaction. Roughly saying, if the total time span t of the bridge tends to infinity while the distance of its end points is fixed or increases slower than  $\sqrt{t}$ , the process asymptotically forgets this distance, just as in the absence of interaction. The conclusion remains valid if the bridge interacts in a similar way also with another set of trajectories. The main example for the interaction is the Coulomb potential.

### 1 Introduction

The problem we consider in this paper arises in Quantum Statistical Physics when a system of interacting particles is investigated by utilizing the Feynman-Kac formula [F1-2, G1-4]. It is in relation with Bose-Einstein condensation that we do not discuss here. Let  $P_{0\mathbf{x}}^{\beta}(d\boldsymbol{\omega})$  denote the Wiener measure for Brownian paths  $\boldsymbol{\omega} : [0, \beta] \to \mathbb{R}^{\nu}$  with  $\boldsymbol{\omega}(0) = \mathbf{0}, \, \boldsymbol{\omega}(\beta) = \mathbf{x}$ . It is generated by the Gaussian functions

$$\psi_t(\mathbf{x}) = \lambda_t^{-\nu} e^{-\pi \mathbf{x}^2 / \lambda_t^2}, \quad 0 \le t \le \beta.$$
(1.1)

In physics  $\lambda_t$  is the thermal de Broglie wave length at inverse temperature t,  $\lambda_t = \sqrt{2\pi\hbar^2 t/m}$ , where m is the mass of the particle. In particular,

$$\int P_{\mathbf{0x}}^{\beta}(\mathrm{d}\boldsymbol{\omega}) = \lambda_{\beta}^{-\nu} e^{-\pi \mathbf{x}^{2}/\lambda_{\beta}^{2}}.$$
(1.2)

Our starting observation is that

$$\lim_{\mathbf{x}^2/\lambda_{\beta}^2 \to 0} \frac{\int P_{\mathbf{0x}}^{\beta}(\mathrm{d}\boldsymbol{\omega})}{\int P_{\mathbf{00}}^{\beta}(\mathrm{d}\boldsymbol{\omega})} = 1,$$
(1.3)

and we wish to prove a similar result in the case of interaction. For this we take a real function  $u(\mathbf{x})$ on  $\mathbb{R}^{\nu}$  that depends only on  $|\mathbf{x}|$ ; the interaction between points  $\mathbf{x}$  and  $\mathbf{y}$  is  $u(\mathbf{x} - \mathbf{y})$ . The time span of the bridge is  $n\beta$ , where  $\beta > 0$  and n is a positive integer. Given a trajectory  $\boldsymbol{\omega} : [0, n\beta] \to \mathbb{R}^{\nu}$ , its self-interaction is defined as

$$U(\boldsymbol{\omega}) = \frac{1}{\beta} \sum_{0 \le k < l \le n-1} \int_0^\beta u(\boldsymbol{\omega}(l\beta + t) - \boldsymbol{\omega}(k\beta + t)) \,\mathrm{d}t, \tag{1.4}$$

and our interest is to give a lower bound on

$$\int P_{\mathbf{0x}}^{\beta}(\mathrm{d}\boldsymbol{\omega})e^{-\beta U(\boldsymbol{\omega})} \left/ \int P_{\mathbf{00}}^{\beta}(\mathrm{d}\boldsymbol{\omega})e^{-\beta U(\boldsymbol{\omega})} \right.$$
(1.5)

As to the physical background, let

$$H_n = -\frac{\hbar^2}{2m} \sum_{i=1}^n \Delta_{\mathbf{x}_i} + \sum_{1 \le i < j \le n} u(\mathbf{x}_j - \mathbf{x}_i), \qquad (1.6)$$

the energy operator of n interacting particles of mass m. For suitable choices of u,  $e^{-\beta H_n}$  has an integral kernel, and by the Feynman-Kac formula we have

$$\int e^{-\beta H_n}(\mathbf{0}, \mathbf{x}_2, \dots, \mathbf{x}_n; \mathbf{x}_2, \dots, \mathbf{x}_n, \mathbf{x}) \, \mathrm{d}\mathbf{x}_2 \dots \, \mathrm{d}\mathbf{x}_n = \int P_{\mathbf{0}\mathbf{x}}^{n\beta}(\,\mathrm{d}\boldsymbol{\omega}) e^{-\beta U(\boldsymbol{\omega})}.$$
(1.7)

In addition, we shall consider also the problem when, apart from a Brownian bridge  $\omega_0$  of time span  $n\beta$  and self-interaction  $U_1$  generated by a pair potential  $u_1$ , there is also a set of M other trajectories  $\omega_i : [0, \beta] \to \mathbb{R}^{\nu}$ 

$$\boldsymbol{\omega}^{M} = (\boldsymbol{\omega}_{1}, \dots, \boldsymbol{\omega}_{M}), \qquad \boldsymbol{\omega}_{i}(0) = \mathbf{x}_{i}, \quad \boldsymbol{\omega}(\beta) = \mathbf{y}_{i}.$$
(1.8)

These may interact among themselves; their potential energy is then

$$U_2(\boldsymbol{\omega}^M) = \frac{1}{\beta} \sum_{1 \le i < j \le M} \int_0^\beta u_2(\boldsymbol{\omega}_i(t) - \boldsymbol{\omega}_j(t)) \,\mathrm{d}t,$$
(1.9)

with a pair potential  $u_2$ . The inclusion of this interaction is optional; what is important is an interaction between  $\omega_0$  and  $\omega^M$ ,

$$V(\omega_0, \omega^M) = \frac{1}{\beta} \sum_{k=0}^{n-1} \sum_{i=1}^M \int_0^\beta u_3(\omega_0(k\beta + t) - \omega_i(t)) \,\mathrm{d}t,$$
(1.10)

acting as an external field for  $\omega_0$ . Both  $u_2(\mathbf{x})$  and  $u_3(\mathbf{x})$  depend only on  $|\mathbf{x}|$ . The underlying energy operator in this case is that of n particles of mass  $m_1$  with pair interaction  $u_1$  and M particles of mass  $m_2$  with pair interaction  $u_2$ , the two sets pairwise interacting via  $u_3$ :

$$H_{n,M} = -\frac{\hbar^2}{2m_1} \sum_{i=1}^n \Delta_{\mathbf{x}_i} + \sum_{1 \le i < j \le n} u_1(\mathbf{x}_j - \mathbf{x}_i) + \sum_{i=1}^n \sum_{j=1}^M u_3(\mathbf{x}_i - \mathbf{y}_j) - \frac{\hbar^2}{2m_2} \sum_{i=1}^M \Delta_{\mathbf{y}_i} + \sum_{1 \le i < j \le M} u_2(\mathbf{y}_j - \mathbf{y}_i).$$
(1.11)

Some special cases of the external field will be presented in Section 3.

# 2 Isolated Brownian motion

Here we treat a Brownian bridge of time span  $n\beta$  under self-interaction alone.

**Theorem 2.1** Let u be twice differentiable outside **0**. If  $\Delta u \leq 0$ , then

$$\lim_{n \to \infty, \, \mathbf{x}^2/n \to 0} \frac{\int P_{\mathbf{0}\mathbf{x}}^{n\beta}(\,\mathrm{d}\boldsymbol{\omega})e^{-\beta U(\boldsymbol{\omega})}}{\int P_{\mathbf{0}\mathbf{0}}^{n\beta}(\,\mathrm{d}\boldsymbol{\omega})e^{-\beta U(\boldsymbol{\omega})}} \ge 1.$$
(2.1)

*Proof.* We start with the identity

$$\int P_{\mathbf{0x}}^{n\beta}(\mathrm{d}\boldsymbol{\omega})\phi(\boldsymbol{\omega}) = \exp\left\{-\frac{\pi\mathbf{x}^2}{n\lambda_{\beta}^2}\right\} \int P_{\mathbf{00}}^{n\beta}(\mathrm{d}\boldsymbol{\omega})\phi(\widetilde{\boldsymbol{\omega}})$$
(2.2)

where

$$\widetilde{\boldsymbol{\omega}}(t) = \boldsymbol{\omega}(t) + \frac{t}{n\beta}\mathbf{x},$$
(2.3)

see [G1]. Applying this to  $\phi(\boldsymbol{\omega}) = \exp{-\beta U(\boldsymbol{\omega})}$  and using the notation

r

$$E_{\boldsymbol{\omega}}(\mathbf{x}) = \sum_{0 \le k < l \le n-1} \int_0^\beta u\left(\boldsymbol{\omega}(l\beta + t) - \boldsymbol{\omega}(k\beta + t) + \frac{l-k}{n}\mathbf{x}\right) \,\mathrm{d}t \tag{2.4}$$

we obtain

$$\int P_{\mathbf{0x}}^{n\beta}(\mathrm{d}\boldsymbol{\omega})e^{-\beta U(\boldsymbol{\omega})} = \exp\left\{-\frac{\pi \mathbf{x}^2}{n\lambda_{\beta}^2}\right\} \int P_{\mathbf{00}}^{n\beta}(\mathrm{d}\boldsymbol{\omega})e^{-E_{\boldsymbol{\omega}}(\mathbf{x})}.$$
(2.5)

Now

$$\lim_{n \to \infty, \, \mathbf{x}^2/n \to \, 0} \exp\left\{-\frac{\pi \mathbf{x}^2}{n\lambda_\beta^2}\right\} = 1,\tag{2.6}$$

so for

$$I^{n\beta}(\mathbf{x}) := \int P_{\mathbf{00}}^{n\beta}(d\boldsymbol{\omega}) e^{-E_{\boldsymbol{\omega}}(\mathbf{x})}$$
(2.7)

we must prove that

$$\lim_{n \to \infty, \mathbf{x}^2/n \to 0} \frac{I^{n\beta}(\mathbf{x})}{I^{n\beta}(\mathbf{0})} \ge 1.$$
(2.8)

Actually, the stronger result

$$\frac{I^{n\beta}(\mathbf{x})}{I^{n\beta}(\mathbf{0})} \ge 1, \tag{2.9}$$

without taking the limit, also holds. Note that  $I^{n\beta}(\mathbf{x})$  is a spherical function, thus it has an extremum at **0**. We show that  $I^{n\beta}(\mathbf{0})$  is a global minimum by proving that  $\Delta I^{n\beta}(\mathbf{x}) \geq 0$  everywhere. Indeed, this implies that  $I^{n\beta}$  is a convex even function of  $\mathbf{x}$  along every axis passing through **0**. Now

$$\nabla I^{n\beta}(\mathbf{x}) = -\int P^{n\beta}_{\mathbf{00}}(d\boldsymbol{\omega})e^{-E_{\boldsymbol{\omega}}(\mathbf{x})}\nabla E_{\boldsymbol{\omega}}(\mathbf{x}), \qquad (2.10)$$

$$\Delta I^{n\beta}(\mathbf{x}) = \int P_{\mathbf{00}}^{n\beta}(d\boldsymbol{\omega}) e^{-E_{\boldsymbol{\omega}}(\mathbf{x})} \left[ |\nabla E_{\boldsymbol{\omega}}(\mathbf{x})|^2 - \Delta E_{\boldsymbol{\omega}}(\mathbf{x}) \right].$$
(2.11)

So  $\Delta I^{n\beta}(\mathbf{x}) \geq 0$  if  $\Delta E_{\boldsymbol{\omega}}(\mathbf{x}) \leq 0$ , and the result follows from

$$\Delta E_{\boldsymbol{\omega}}(\mathbf{x}) = \sum_{k < l} \int_{0}^{\beta} \Delta_{\mathbf{x}} u \left( \boldsymbol{\omega}(l\beta + t) - \boldsymbol{\omega}(k\beta + t) + \frac{l - k}{n} \mathbf{x} \right) dt$$
$$= \sum_{k < l} \left( \frac{l - k}{n} \right)^{2} \int_{0}^{\beta} \Delta u \left( \boldsymbol{\omega}(l\beta + t) - \boldsymbol{\omega}(k\beta + t) + \frac{l - k}{n} \mathbf{x} \right) dt.$$
(2.12)

The general solution of  $\Delta u \leq 0$  is easily obtained. Define  $f : [0, \infty) \to \mathbb{R} \cup \{\infty\}$  by  $u(\mathbf{y}) = f(\mathbf{y}^2)$ . Because

$$\Delta u(\mathbf{y}) = 2\left[\nu f'(\mathbf{y}^2) + 2\mathbf{y}^2 f''(\mathbf{y}^2)\right],\tag{2.13}$$

one must find those f satisfying

$$\nu f'(s) + 2sf''(s) \le 0 \quad \text{for any } s > 0.$$
 (2.14)

Let g(s) be a nonnegative function, and consider the differential equation

$$\nu f'(s) + 2sf''(s) = -g(s). \tag{2.15}$$

Choose some a, b > 0, then for the boundary conditions

$$f(a) = c_1, \qquad f'(b) = c_2 b^{-\nu/2}$$
 (2.16)

the solution of Eq. (2.15) is

$$f(s) = c_1 - \frac{1}{2} \int_a^s dx \, x^{-\nu/2} \int_b^x dt \, g(t) t^{\nu/2 - 1} + c_2 \begin{cases} \frac{s^{1 - \nu/2} - a^{1 - \nu/2}}{1 - \nu/2}, & \nu \neq 2\\ (\ln s - \ln a), & \nu = 2. \end{cases}$$

$$(2.17)$$

**Examples.** For g = 0 we can obtain the  $\nu$ -dimensional Coulomb potential of both signs. In general,  $f(s) = s^{-\alpha}$  is a solution of Eq. (2.15) for  $g(s) = \alpha(\nu - 2 - 2\alpha)s^{-\alpha - 1}$  which is nonnegative if  $\alpha \leq \nu/2 - 1$ . Another interesting solution is obtained in dimensions  $\nu \geq 3$  if

$$a = b = +\infty, \quad c_1 = c_2 = 0, \quad g(s) = s^{-\alpha}, \quad \alpha > \nu/2 > 1.$$
 (2.18)

It reads

$$f(s) = \frac{-s^{-\alpha+1}}{(\alpha-1)(2\alpha-\nu)} \quad \text{or} \quad u(\mathbf{x}) = \frac{-|\mathbf{x}|^{-2\alpha+2}}{(\alpha-1)(2\alpha-\nu)}.$$
 (2.19)

In three dimensions with  $\alpha = 4$  this is the form of the induced dipole-dipole interaction which appears in the Lennard-Jones potential.

## 3 Self-interacting Brownian bridge in an external field

The external field is created by a set of other trajectories, and is given by Eq. (1.10). Let

$$E_{\boldsymbol{\omega}_0}(\mathbf{x}) = \sum_{0 \le k < l \le n-1} \int_0^\beta u_1 \left( \boldsymbol{\omega}_0(l\beta + t) - \boldsymbol{\omega}_0(k\beta + t) + \frac{l-k}{n} \mathbf{x} \right) dt,$$
$$E_{\boldsymbol{\omega}_0,\boldsymbol{\omega}^M}(\mathbf{x}) = \sum_{k=0}^{n-1} \sum_{i=1}^M \int_0^\beta u_3 \left( \boldsymbol{\omega}_0(k\beta + t) - \boldsymbol{\omega}_i(t) + \frac{k\beta + t}{n\beta} \mathbf{x} \right) dt,$$
(3.1)

and

$$I_{\boldsymbol{\omega}^{M}}^{n\beta}(\mathbf{x}) = \int P_{\mathbf{00}}^{n\beta}(d\boldsymbol{\omega}_{0})e^{-E_{\boldsymbol{\omega}_{0}}(\mathbf{x}) - E_{\boldsymbol{\omega}_{0},\boldsymbol{\omega}^{M}}(\mathbf{x}) - \beta U_{2}(\boldsymbol{\omega}^{M})}.$$
(3.2)

As before,

$$\int P_{\mathbf{0x}}^{n\beta}(\mathrm{d}\boldsymbol{\omega}_0) e^{-\beta \left[U_1(\boldsymbol{\omega}_0) + V\left(\boldsymbol{\omega}_0, \boldsymbol{\omega}^M\right) + U_2\left(\boldsymbol{\omega}^M\right)\right]} = e^{-\pi \mathbf{x}^2/\lambda_{n\beta}^2} I_{\boldsymbol{\omega}^M}^{n\beta}(\mathbf{x}),$$
(3.3)

where  $\lambda_{n\beta} = \sqrt{2\pi\hbar^2 n\beta/m_1}$ .

**Proposition 3.1** If  $u_1$  and  $u_3$  are twice differentiable outside the origin and  $\Delta u_1 \leq 0$ ,  $\Delta u_3 \leq 0$ , then  $\Delta I_{\omega^M}^{n\beta} \geq 0$ .

Proof. Again, a direct computation gives

$$\Delta I_{\boldsymbol{\omega}^{M}}^{n\beta}(\mathbf{x}) = \int P_{\mathbf{00}}^{n\beta}(d\boldsymbol{\omega}_{0})e^{-E_{\boldsymbol{\omega}_{0}}(\mathbf{x})-E_{\boldsymbol{\omega}_{0},\boldsymbol{\omega}^{M}}(\mathbf{x})-\beta U_{2}(\boldsymbol{\omega}^{M})} \\ \times \left[\left|\nabla E_{\boldsymbol{\omega}_{0}}(\mathbf{x})+\nabla E_{\boldsymbol{\omega}_{0},\boldsymbol{\omega}^{M}}(\mathbf{x})\right|^{2}-\Delta E_{\boldsymbol{\omega}_{0}}(\mathbf{x})-\Delta E_{\boldsymbol{\omega}_{0},\boldsymbol{\omega}^{M}}(\mathbf{x})\right].$$
(3.4)

Recalling the identity (2.12) and

$$\Delta E_{\boldsymbol{\omega}_0,\boldsymbol{\omega}^M}(\mathbf{x}) = \sum_{k=0}^{n-1} \sum_{i=1}^M \int_0^\beta \left(\frac{k\beta+t}{n\beta}\right)^2 \Delta u_3 \left(\boldsymbol{\omega}_0(k\beta+t) - \boldsymbol{\omega}_i(t) + \frac{k\beta+t}{n\beta}\mathbf{x}\right) \,\mathrm{d}t \tag{3.5}$$

the result follows.  $\Box$ 

 $I^{n\beta}_{\omega^M}(\mathbf{x})$  is not a spherical function, so it may not be minimal at  $\mathbf{x} = \mathbf{0}$ . If, for example,

dist 
$$(\mathbf{x}, {\mathbf{x}_i}_{i=1}^M) \ll \operatorname{dist} \left(\mathbf{0}, {\mathbf{x}_i}_{i=1}^M\right)$$
 (3.6)

then possibly

$$E_{\boldsymbol{\omega}_0,\boldsymbol{\omega}^M}(\mathbf{x}) \gg E_{\boldsymbol{\omega}_0,\boldsymbol{\omega}^M}(\mathbf{0}) \tag{3.7}$$

and therefore  $I_{\boldsymbol{\omega}^{M}}^{n\beta}(\mathbf{x}) < I_{\boldsymbol{\omega}^{M}}^{n\beta}(\mathbf{0})$ . Let  $\mathcal{S}\left(I_{\boldsymbol{\omega}^{M}}^{n\beta}\right)(\mathbf{x})$  denote a spherical symmetrization of  $I_{\boldsymbol{\omega}^{M}}^{n\beta}(\mathbf{x})$ , obtained by integration over a set of  $\boldsymbol{\omega}^{M}$ . Examples will be given below. As a function of  $\mathbf{x}$ ,  $\mathcal{S}\left(I_{\boldsymbol{\omega}^{M}}^{n\beta}\right)(\mathbf{x})$  depends only on  $|\mathbf{x}|$ , and may preserve some dependence on  $\boldsymbol{\omega}^{M}$ . From Eq. (3.3),

$$\mathcal{S}\left(\int P_{\mathbf{0x}}^{n\beta}(\mathrm{d}\boldsymbol{\omega}_0)e^{-\beta\left[U_1(\boldsymbol{\omega}_0)+V\left(\boldsymbol{\omega}_0,\boldsymbol{\omega}^M\right)+U_2\left(\boldsymbol{\omega}^M\right)\right]}\right)(\mathbf{x})=e^{-\pi\mathbf{x}^2/\lambda_{n\beta}^2}\mathcal{S}\left(I_{\boldsymbol{\omega}^M}^{n\beta}\right)(\mathbf{x}).$$
(3.8)

One can differentiate inside the integral over  $\boldsymbol{\omega}^{M}$ , so

$$\Delta \mathcal{S}\left(I_{\boldsymbol{\omega}^{M}}^{n\beta}\right)(\mathbf{x}) = \mathcal{S}\left(\Delta I_{\boldsymbol{\omega}^{M}}^{n\beta}\right)(\mathbf{x}).$$
(3.9)

**Theorem 3.1** For  $u_1$  and  $u_3$  as in Proposition 3.1,

$$\lim_{n \to \infty, \mathbf{x}^2/n \to 0} \frac{\mathcal{S}\left(\int P_{\mathbf{0}\mathbf{x}}^{n\beta}(\mathrm{d}\boldsymbol{\omega}_0) e^{-\beta \left[U_1(\boldsymbol{\omega}_0) + V\left(\boldsymbol{\omega}_0, \boldsymbol{\omega}^M\right) + U_2\left(\boldsymbol{\omega}^M\right)\right]}\right)(\mathbf{x})}{\mathcal{S}\left(\int P_{\mathbf{0}\mathbf{x}}^{n\beta}(\mathrm{d}\boldsymbol{\omega}_0) e^{-\beta \left[U_1(\boldsymbol{\omega}_0) + V\left(\boldsymbol{\omega}_0, \boldsymbol{\omega}^M\right) + U_2\left(\boldsymbol{\omega}^M\right)\right]}\right)(\mathbf{0})} \ge 1.$$
(3.10)

*Proof.*  $\Delta I_{\boldsymbol{\omega}^{M}}^{n\beta} \geq 0$  implies  $\Delta S\left(I_{\boldsymbol{\omega}^{M}}^{n\beta}\right) \geq 0$  and, because  $S\left(I_{\boldsymbol{\omega}^{M}}^{n\beta}\right)(\mathbf{x})$  is spherical,  $\mathcal{S}\left(I_{\boldsymbol{\omega}^{M}}^{n\beta}\right)(\mathbf{x}) \geq \mathcal{S}\left(I_{\boldsymbol{\omega}^{M}}^{n\beta}\right)(\mathbf{0}).$ 

Then,

$$\lim_{n\to\infty,\mathbf{x}^2/n\to0} \frac{\mathcal{S}\left(\int P_{\mathbf{0x}}^{n\beta}(\mathrm{d}\boldsymbol{\omega}_0)e^{-\beta\left[U_1(\boldsymbol{\omega}_0)+V(\boldsymbol{\omega}_0,\boldsymbol{\omega}^M)+U_2(\boldsymbol{\omega}^M)\right]\right)}(\mathbf{x})}{\mathcal{S}\left(\int P_{\mathbf{0x}}^{n\beta}(\mathrm{d}\boldsymbol{\omega}_0)e^{-\beta\left[U_1(\boldsymbol{\omega}_0)+V(\boldsymbol{\omega}_0,\boldsymbol{\omega}^M)+U_2(\boldsymbol{\omega}^M)\right]\right)}(\mathbf{0})} = \lim_{n\to\infty,\mathbf{x}^2/n\to0} \frac{\mathcal{S}\left(I_{\boldsymbol{\omega}^M}^{n\beta}\right)(\mathbf{x})}{\mathcal{S}\left(I_{\boldsymbol{\omega}^M}^{n\beta}\right)(\mathbf{0})} \ge 1.$$
(3.11)

#### Examples.

(i) Fix some L > 0 and define

$$\mathcal{S}\left(I_{\cdot}^{n\beta}\right)(\mathbf{x}) = \sum_{\pi \in S_{M}} \prod_{i=1}^{M} \int_{|\mathbf{x}_{i}| < L} \mathrm{d}\mathbf{x}_{i} \int P_{\mathbf{x}_{i}\mathbf{x}_{\pi(i)}}^{\beta}(\mathrm{d}\boldsymbol{\omega}_{i}) I_{\boldsymbol{\omega}^{M}}^{n\beta}(\mathbf{x})$$
(3.12)

where  $S_M$  is the set of permutations of  $\{1, \ldots, M\}$ . This is the typical choice when the particles associated with  $\omega^M$  are bosons. The physically interesting case is  $n \propto M \propto L^{\nu}$  and  $n \to \infty$  replaced by  $L \to \infty$ . If  $n \propto L^{\nu}$ , for  $\mathbf{x}^2/n \to 0$  to hold one must have  $|\mathbf{x}| = o(L^{\nu/2})$ . In  $\nu \geq 3$  dimensions all  $\mathbf{x}$  of length  $|\mathbf{x}| = O(L)$  satisfy this condition. When n = M,  $u_1 = u_2 = -u_3 = u$  with  $\Delta u = 0$ , the system is a neutral two-component plasma.

(ii) The second set of particles can be treated classically. This is the  $m_2 = \infty$  limit in which both the kinetic and the potential energy of these particles (the last two terms of the Hamiltonian (1.11)) can be dropped. Now  $\omega_i(t) \equiv \mathbf{x}_i, \ \boldsymbol{\omega}^M = \mathbf{x}^M = (\mathbf{x}_1, \dots, \mathbf{x}_M)$ , and the interaction between the two sets becomes

$$V(\boldsymbol{\omega}_{0}, \mathbf{x}^{M}) = \frac{1}{\beta} \sum_{k=0}^{n-1} \sum_{i=1}^{M} \int_{0}^{\beta} u_{3}(\boldsymbol{\omega}_{0}(k\beta + t) - \mathbf{x}_{i}) \,\mathrm{d}t.$$
(3.13)

Spherical symmetrization can be done by keeping all  $|\mathbf{x}_i - \mathbf{x}_j|$  unchanged. Let g denote a general element of the rotation group  $SO(\nu)$ , and let  $\mu$  be the Haar measure on  $SO(\nu)$ . Define

$$\mathcal{S}\left(I_{(\mathbf{x}_1,\ldots,\mathbf{x}_M)}^{n\beta}\right)(\mathbf{x}) = \int I_{(g\mathbf{x}_1,\ldots,g\mathbf{x}_M)}^{n\beta}(\mathbf{x})\,\mu(\,\mathrm{d}g).$$
(3.14)

Because  $u_1$  and  $u_3$  are spherical functions and the measure  $P_{00}^{n\beta}$  is rotation invariant, one actually has

$$\mathcal{S}\left(I_{(\mathbf{x}_1,\ldots,\mathbf{x}_M)}^{n\beta}\right)(\mathbf{x}) = \int I_{(\mathbf{x}_1,\ldots,\mathbf{x}_M)}^{n\beta}(g\mathbf{x})\,\mu(\,\mathrm{d}g).$$
(3.15)

When n = M,  $u_1 = -u_3 = u$  with  $\Delta u = 0$ , we have a neutral system of light charged particles moving in the field of immobile heavy ions.
