# Self-interacting Brownian motion*

#### Abstract

We prove a property of Brownian bridges whose certain time-equidistant sequences of points are pairwise coupled by an interaction. Roughly saying, if the total time span $t$ of the bridge tends to infinity while the distance of its end points is fixed or increases slower than $\sqrt{t}$, the process asymptotically forgets this distance, just as in the absence of interaction. The conclusion remains valid if the bridge interacts in a similar way also with another set of trajectories. The main example for the interaction is the Coulomb potential.


## 1 Introduction

The problem we consider in this paper arises in Quantum Statistical Physics when a system of interacting particles is investigated by utilizing the Feynman-Kac formula [F1-2, G1-4]. It is in relation with BoseEinstein condensation that we do not discuss here. Let $P_{\mathbf{0 x}}^{\beta}(\mathrm{d} \boldsymbol{\omega})$ denote the Wiener measure for Brownian paths $\boldsymbol{\omega}:[0, \beta] \rightarrow \mathbb{R}^{\nu}$ with $\boldsymbol{\omega}(0)=\mathbf{0}, \boldsymbol{\omega}(\beta)=\mathbf{x}$. It is generated by the Gaussian functions

\begin{equation*}
\psi_{t}(\mathbf{x})=\lambda_{t}^{-\nu} e^{-\pi \mathbf{x}^{2} / \lambda_{t}^{2}}, \quad 0 \leq t \leq \beta \tag{1.1}
\end{equation*}
$$

In physics $\lambda_{t}$ is the thermal de Broglie wave length at inverse temperature $t, \lambda_{t}=\sqrt{2 \pi \hbar^{2} t / m}$, where $m$ is the mass of the particle. In particular,

\int P_{\mathbf{0 x}}^{\beta}(\mathrm{d} \boldsymbol{\omega})=\lambda_{\beta}^{-\nu} e^{-\pi \mathbf{x}^{2} / \lambda_{\beta}^{2}} \tag{1.2}
\end{equation*}
$$

Our starting observation is that

$$
\begin{equation*}
\lim _{\mathbf{x}^{2} / \lambda_{\beta}^{2} \rightarrow 0} \frac{\int P_{\mathbf{0 x}}^{\beta}(\mathrm{d} \boldsymbol{\omega})}{\int P_{\mathbf{0 0}}^{\beta}(\mathrm{d} \boldsymbol{\omega})}=1 \tag{1.3}
\end{equation*}
$$

and we wish to prove a similar result in the case of interaction. For this we take a real function $u(\mathbf{x})$ on $\mathbb{R}^{\nu}$ that depends only on $|\mathbf{x}|$; the interaction between points $\mathbf{x}$ and $\mathbf{y}$ is $u(\mathbf{x}-\mathbf{y})$. The time span of the bridge is $n \beta$, where $\beta>0$ and $n$ is a positive integer. Given a trajectory $\boldsymbol{\omega}:[0, n \beta] \rightarrow \mathbb{R}^{\nu}$, its self-interaction is defined as

U(\boldsymbol{\omega})=\frac{1}{\beta} \sum_{0 \leq k<l \leq n-1} \int_{0}^{\beta} u(\boldsymbol{\omega}(l \beta+t)-\boldsymbol{\omega}(k \beta+t)) \mathrm{d} t \tag{1.4}
\end{equation*}
$$

[^0]and our interest is to give a lower bound on
\[

$$
\begin{equation*}
\int P_{\mathbf{0 x}}^{\beta}(\mathrm{d} \boldsymbol{\omega}) e^{-\beta U(\boldsymbol{\omega})} / \int P_{\mathbf{0 0}}^{\beta}(\mathrm{d} \boldsymbol{\omega}) e^{-\beta U(\boldsymbol{\omega})} \tag{1.5}
\end{equation*}
$$

\]

As to the physical background, let

$$
\begin{equation*}
H_{n}=-\frac{\hbar^{2}}{2 m} \sum_{i=1}^{n} \Delta_{\mathbf{x}_{i}}+\sum_{1 \leq i<j \leq n} u\left(\mathbf{x}_{j}-\mathbf{x}_{i}\right) \tag{1.6}
\end{equation*}
$$

the energy operator of $n$ interacting particles of mass $m$. For suitable choices of $u, e^{-\beta H_{n}}$ has an integral kernel, and by the Feynman-Kac formula we have

\begin{equation*}
\int e^{-\beta H_{n}}\left(\mathbf{0}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n} ; \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}, \mathbf{x}\right) \mathrm{d} \mathbf{x}_{2} \ldots \mathrm{~d} \mathbf{x}_{n}=\int P_{\mathbf{0 x}}^{n \beta}(\mathrm{~d} \boldsymbol{\omega}) e^{-\beta U(\boldsymbol{\omega})} \tag{1.7}
\end{equation*}
$$

In addition, we shall consider also the problem when, apart from a Brownian bridge $\boldsymbol{\omega}_{0}$ of time span $n \beta$ and self-interaction $U_{1}$ generated by a pair potential $u_{1}$, there is also a set of $M$ other trajectories $\boldsymbol{\omega}_{i}:[0, \beta] \rightarrow \mathbb{R}^{\nu}$

$$
\begin{equation*}
\boldsymbol{\omega}^{M}=\left(\boldsymbol{\omega}_{1}, \ldots, \boldsymbol{\omega}_{M}\right), \quad \boldsymbol{\omega}_{i}(0)=\mathbf{x}_{i}, \quad \boldsymbol{\omega}(\beta)=\mathbf{y}_{i} \tag{1.8}
\end{equation*}
$$

These may interact among themselves; their potential energy is then

$$
\begin{equation*}
U_{2}\left(\boldsymbol{\omega}^{M}\right)=\frac{1}{\beta} \sum_{1 \leq i<j \leq M} \int_{0}^{\beta} u_{2}\left(\boldsymbol{\omega}_{i}(t)-\boldsymbol{\omega}_{j}(t)\right) \mathrm{d} t \tag{1.9}
\end{equation*}
$$

with a pair potential $u_{2}$. The inclusion of this interaction is optional; what is important is an interaction between $\boldsymbol{\omega}_{0}$ and $\boldsymbol{\omega}^{M}$,

$$
\begin{equation*}
V\left(\boldsymbol{\omega}_{0}, \boldsymbol{\omega}^{M}\right)=\frac{1}{\beta} \sum_{k=0}^{n-1} \sum_{i=1}^{M} \int_{0}^{\beta} u_{3}\left(\boldsymbol{\omega}_{0}(k \beta+t)-\boldsymbol{\omega}_{i}(t)\right) \mathrm{d} t \tag{1.10}
\end{equation*}
$$

acting as an external field for $\boldsymbol{\omega}_{0}$. Both $u_{2}(\mathbf{x})$ and $u_{3}(\mathbf{x})$ depend only on $|\mathbf{x}|$. The underlying energy operator in this case is that of $n$ particles of mass $m_{1}$ with pair interaction $u_{1}$ and $M$ particles of mass $m_{2}$ with pair interaction $u_{2}$, the two sets pairwise interacting via $u_{3}$ :

\begin{equation*}
H_{n, M}=-\frac{\hbar^{2}}{2 m_{1}} \sum_{i=1}^{n} \Delta_{\mathbf{x}_{i}}+\sum_{1 \leq i<j \leq n} u_{1}\left(\mathbf{x}_{j}-\mathbf{x}_{i}\right)+\sum_{i=1}^{n} \sum_{j=1}^{M} u_{3}\left(\mathbf{x}_{i}-\mathbf{y}_{j}\right)-\frac{\hbar^{2}}{2 m_{2}} \sum_{i=1}^{M} \Delta_{\mathbf{y}_{i}}+\sum_{1 \leq i<j \leq M} u_{2}\left(\mathbf{y}_{j}-\mathbf{y}_{i}\right) \tag{1.11}
\end{equation*}
$$

Some special cases of the external field will be presented in Section 3.

## 2 Isolated Brownian motion

Here we treat a Brownian bridge of time span $n \beta$ under self-interaction alone.
Theorem 2.1 Let $u$ be twice differentiable outside $\mathbf{0}$. If $\Delta u \leq 0$, then

\begin{equation*}
\lim _{n \rightarrow \infty, \mathbf{x}^{2} / n \rightarrow 0} \frac{\int P_{\mathbf{0 x}}^{n \beta}(\mathrm{~d} \boldsymbol{\omega}) e^{-\beta U(\boldsymbol{\omega})}}{\int P_{\mathbf{0 0}}^{n \beta}(\mathrm{~d} \boldsymbol{\omega}) e^{-\beta U(\boldsymbol{\omega})}} \geq 1 \tag{2.1}
\end{equation*}
$$

Proof. We start with the identity

$$
\begin{equation*}
\int P_{\mathbf{0 x}}^{n \beta}(\mathrm{~d} \boldsymbol{\omega}) \phi(\boldsymbol{\omega})=\exp \left\{-\frac{\pi \mathbf{x}^{2}}{n \lambda_{\beta}^{2}}\right\} \int P_{\mathbf{0 0}}^{n \beta}(\mathrm{~d} \boldsymbol{\omega}) \phi(\widetilde{\boldsymbol{\omega}}) \tag{2.2}
\end{equation*}
$$

where

$$
\begin{equation*}
\widetilde{\boldsymbol{\omega}}(t)=\boldsymbol{\omega}(t)+\frac{t}{n \beta} \mathbf{x}, \tag{2.3}
\end{equation*}
$$

see [G1]. Applying this to $\phi(\boldsymbol{\omega})=\exp -\beta U(\boldsymbol{\omega})$ and using the notation

$$
\begin{equation*}
E_{\boldsymbol{\omega}}(\mathbf{x})=\sum_{0 \leq k<l \leq n-1} \int_{0}^{\beta} u\left(\boldsymbol{\omega}(l \beta+t)-\boldsymbol{\omega}(k \beta+t)+\frac{l-k}{n} \mathbf{x}\right) \mathrm{d} t \tag{2.4}
\end{equation*}
$$

we obtain

$$
\begin{equation*}
\int P_{\mathbf{0 x}}^{n \beta}(\mathrm{~d} \boldsymbol{\omega}) e^{-\beta U(\boldsymbol{\omega})}=\exp \left\{-\frac{\pi \mathbf{x}^{2}}{n \lambda_{\beta}^{2}}\right\} \int P_{\mathbf{0 0}}^{n \beta}(\mathrm{~d} \boldsymbol{\omega}) e^{-E \boldsymbol{\omega}(\mathbf{x})} \tag{2.5}
\end{equation*}
$$

Now

$$
\begin{equation*}
\lim _{n \rightarrow \infty, \mathbf{x}^{2} / n \rightarrow 0} \exp \left\{-\frac{\pi \mathbf{x}^{2}}{n \lambda_{\beta}^{2}}\right\}=1 \tag{2.6}
\end{equation*}
$$

so for

$$
\begin{equation*}
I^{n \beta}(\mathbf{x}):=\int P_{\mathbf{0 0}}^{n \beta}(\mathrm{~d} \boldsymbol{\omega}) e^{-E_{\boldsymbol{\omega}}(\mathbf{x})} \tag{2.7}
\end{equation*}
$$

we must prove that

$$
\begin{equation*}
\lim _{n \rightarrow \infty, \mathbf{x}^{2} / n \rightarrow 0} \frac{I^{n \beta}(\mathbf{x})}{I^{n \beta}(\mathbf{0})} \geq 1 \tag{2.8}
\end{equation*}
$$

Actually, the stronger result

$$
\begin{equation*}
\frac{I^{n \beta}(\mathbf{x})}{I^{n \beta}(\mathbf{0})} \geq 1 \tag{2.9}
\end{equation*}
$$

without taking the limit, also holds. Note that $I^{n \beta}(\mathbf{x})$ is a spherical function, thus it has an extremum at $\mathbf{0}$. We show that $I^{n \beta}(\mathbf{0})$ is a global minimum by proving that $\Delta I^{n \beta}(\mathbf{x}) \geq 0$ everywhere. Indeed, this implies that $I^{n \beta}$ is a convex even function of $\mathbf{x}$ along every axis passing through $\mathbf{0}$. Now

$$
\begin{gather*}
\nabla I^{n \beta}(\mathbf{x})=-\int P_{\mathbf{0 0}}^{n \beta}(\mathrm{~d} \boldsymbol{\omega}) e^{-E_{\boldsymbol{\omega}}(\mathbf{x})} \nabla E_{\boldsymbol{\omega}}(\mathbf{x})  \tag{2.10}\\
\Delta I^{n \beta}(\mathbf{x})=\int P_{\mathbf{0 0}}^{n \beta}(\mathrm{~d} \boldsymbol{\omega}) e^{-E_{\boldsymbol{\omega}}(\mathbf{x})}\left[\left|\nabla E_{\boldsymbol{\omega}}(\mathbf{x})\right|^{2}-\Delta E_{\boldsymbol{\omega}}(\mathbf{x})\right] . \tag{2.11}
\end{gather*}
$$

So $\Delta I^{n \beta}(\mathbf{x}) \geq 0$ if $\Delta E_{\boldsymbol{\omega}}(\mathbf{x}) \leq 0$, and the result follows from

$$
\begin{align*}
\Delta E_{\boldsymbol{\omega}}(\mathbf{x}) & =\sum_{k<l} \int_{0}^{\beta} \Delta_{\mathbf{x}} u\left(\boldsymbol{\omega}(l \beta+t)-\boldsymbol{\omega}(k \beta+t)+\frac{l-k}{n} \mathbf{x}\right) \mathrm{d} t \\
& =\sum_{k<l}\left(\frac{l-k}{n}\right)^{2} \int_{0}^{\beta} \Delta u\left(\boldsymbol{\omega}(l \beta+t)-\boldsymbol{\omega}(k \beta+t)+\frac{l-k}{n} \mathbf{x}\right) \mathrm{d} t \tag{2.12}
\end{align*}
$$

The general solution of $\Delta u \leq 0$ is easily obtained. Define $f:[0, \infty) \rightarrow \mathbb{R} \cup\{\infty\}$ by $u(\mathbf{y})=f\left(\mathbf{y}^{2}\right)$. Because

\Delta u(\mathbf{y})=2\left[\nu f^{\prime}\left(\mathbf{y}^{2}\right)+2 \mathbf{y}^{2} f^{\prime \prime}\left(\mathbf{y}^{2}\right)\right] \tag{2.13}
\end{equation*}
$$

one must find those $f$ satisfying

$$
\begin{equation*}
\nu f^{\prime}(s)+2 s f^{\prime \prime}(s) \leq 0 \quad \text { for any } s>0 \tag{2.14}
\end{equation*}
$$

Let $g(s)$ be a nonnegative function, and consider the differential equation

$$
\begin{equation*}
\nu f^{\prime}(s)+2 s f^{\prime \prime}(s)=-g(s) \tag{2.15}
\end{equation*}
$$

Choose some $a, b>0$, then for the boundary conditions

$$
\begin{equation*}
f(a)=c_{1}, \quad f^{\prime}(b)=c_{2} b^{-\nu / 2} \tag{2.16}
\end{equation*}
$$

the solution of Eq. (2.15) is

$$
f(s)=c_{1}-\frac{1}{2} \int_{a}^{s} \mathrm{~d} x x^{-\nu / 2} \int_{b}^{x} \mathrm{~d} t g(t) t^{\nu / 2-1}+c_{2}\left\{\begin{array}{cc}
\frac{s^{1-\nu / 2}-a^{1-\nu / 2}}{1-\nu / 2}, & \nu \neq 2  \tag{2.17}\\
(\ln s-\ln a), & \nu=2
\end{array}\right.
$$

Examples. For $g=0$ we can obtain the $\nu$-dimensional Coulomb potential of both signs. In general, $f(s)=s^{-\alpha}$ is a solution of Eq. (2.15) for $g(s)=\alpha(\nu-2-2 \alpha) s^{-\alpha-1}$ which is nonnegative if $\alpha \leq \nu / 2-1$. Another interesting solution is obtained in dimensions $\nu \geq 3$ if

$$
\begin{equation*}
a=b=+\infty, \quad c_{1}=c_{2}=0, \quad g(s)=s^{-\alpha}, \quad \alpha>\nu / 2>1 \tag{2.18}
\end{equation*}
$$

It reads

$$
\begin{equation*}
f(s)=\frac{-s^{-\alpha+1}}{(\alpha-1)(2 \alpha-\nu)} \quad \text { or } \quad u(\mathbf{x})=\frac{-|\mathbf{x}|^{-2 \alpha+2}}{(\alpha-1)(2 \alpha-\nu)} \tag{2.19}
\end{equation*}
$$

In three dimensions with $\alpha=4$ this is the form of the induced dipole-dipole interaction which appears in the Lennard-Jones potential.

## 3 Self-interacting Brownian bridge in an external field

The external field is created by a set of other trajectories, and is given by Eq. (1.10). Let

\begin{array}{r}
E_{\boldsymbol{\omega}_{0}}(\mathbf{x})=\sum_{0 \leq k<l \leq n-1} \int_{0}^{\beta} u_{1}\left(\boldsymbol{\omega}_{0}(l \beta+t)-\boldsymbol{\omega}_{0}(k \beta+t)+\frac{l-k}{n} \mathbf{x}\right) \mathrm{d} t \\
E_{\boldsymbol{\omega}_{0}, \boldsymbol{\omega}^{M}}(\mathbf{x})=\sum_{k=0}^{n-1} \sum_{i=1}^{M} \int_{0}^{\beta} u_{3}\left(\boldsymbol{\omega}_{0}(k \beta+t)-\boldsymbol{\omega}_{i}(t)+\frac{k \beta+t}{n \beta} \mathbf{x}\right) \mathrm{d} t \tag{3.1}
\end{array}
$$

and

$$
\begin{equation*}
I_{\boldsymbol{\omega}^{M}}^{n \beta}(\mathbf{x})=\int P_{\mathbf{0 0}}^{n \beta}\left(\mathrm{~d} \boldsymbol{\omega}_{0}\right) e^{-E_{\boldsymbol{\omega}_{0}}(\mathbf{x})-E_{\boldsymbol{\omega}_{0}, \boldsymbol{\omega}^{M}}(\mathbf{x})-\beta U_{2}\left(\boldsymbol{\omega}^{M}\right)} \tag{3.2}
\end{equation*}
$$

As before,

$$
\begin{equation*}
\int P_{\mathbf{0 x}}^{n \beta}\left(\mathrm{~d} \boldsymbol{\omega}_{0}\right) e^{-\beta\left[U_{1}\left(\boldsymbol{\omega}_{0}\right)+V\left(\boldsymbol{\omega}_{0}, \boldsymbol{\omega}^{M}\right)+U_{2}\left(\boldsymbol{\omega}^{M}\right)\right]}=e^{-\pi \mathbf{x}^{2} / \lambda_{n \beta}^{2}} I_{\boldsymbol{\omega}^{M}}^{n \beta}(\mathbf{x}), \tag{3.3}
\end{equation*}
$$

where $\lambda_{n \beta}=\sqrt{2 \pi \hbar^{2} n \beta / m_{1}}$.
Proposition 3.1 If $u_{1}$ and $u_{3}$ are twice differentiable outside the origin and $\Delta u_{1} \leq 0, \Delta u_{3} \leq 0$, then $\Delta I_{\boldsymbol{\omega}^{M}}^{n \beta} \geq 0$.

Proof. Again, a direct computation gives

$$
\begin{align*}
\Delta I_{\boldsymbol{\omega}^{M}}^{n \beta}(\mathbf{x}) & =\int P_{\mathbf{0 0}}^{n \beta}\left(\mathrm{~d} \boldsymbol{\omega}_{0}\right) e^{-E_{\boldsymbol{\omega}_{0}}(\mathbf{x})-E_{\boldsymbol{\omega}_{0}, \boldsymbol{\omega}^{M}}(\mathbf{x})-\beta U_{2}\left(\boldsymbol{\omega}^{M}\right)} \\
& \times\left[\left|\nabla E_{\boldsymbol{\omega}_{0}}(\mathbf{x})+\nabla E_{\boldsymbol{\omega}_{0}, \boldsymbol{\omega}^{M}}(\mathbf{x})\right|^{2}-\Delta E_{\boldsymbol{\omega}_{0}}(\mathbf{x})-\Delta E_{\boldsymbol{\omega}_{0}, \boldsymbol{\omega}^{M}}(\mathbf{x})\right] . \tag{3.4}
\end{align*}
$$

Recalling the identity (2.12) and

$$
\begin{equation*}
\Delta E_{\boldsymbol{\omega}_{0}, \boldsymbol{\omega}^{M}}(\mathbf{x})=\sum_{k=0}^{n-1} \sum_{i=1}^{M} \int_{0}^{\beta}\left(\frac{k \beta+t}{n \beta}\right)^{2} \Delta u_{3}\left(\boldsymbol{\omega}_{0}(k \beta+t)-\boldsymbol{\omega}_{i}(t)+\frac{k \beta+t}{n \beta} \mathbf{x}\right) \mathrm{d} t \tag{3.5}
\end{equation*}
$$

the result follows.
$I_{\boldsymbol{\omega}^{M}}^{n \beta}(\mathbf{x})$ is not a spherical function, so it may not be minimal at $\mathbf{x}=\mathbf{0}$. If, for example,

\begin{equation*}
\operatorname{dist}\left(\mathbf{x},\left\{\mathbf{x}_{i}\right\}_{i=1}^{M}\right) \ll \operatorname{dist}\left(\mathbf{0},\left\{\mathbf{x}_{i}\right\}_{i=1}^{M}\right) \tag{3.6}
\end{equation*}
$$

then possibly

$$
\begin{equation*}
E_{\boldsymbol{\omega}_{0}, \boldsymbol{\omega}^{M}}(\mathbf{x}) \gg E_{\boldsymbol{\omega}_{0}, \boldsymbol{\omega}^{M}}(\mathbf{0}) \tag{3.7}
\end{equation*}
$$

and therefore $I_{\boldsymbol{\omega}^{M}}^{n \beta}(\mathbf{x})<I_{\boldsymbol{\omega}^{M}}^{n \beta}(\mathbf{0})$.
Let $\mathcal{S}\left(I_{\boldsymbol{\omega}^{M}}^{n \beta}\right)(\mathbf{x})$ denote a spherical symmetrization of $I_{\boldsymbol{\omega}^{M}}^{n \beta}(\mathbf{x})$, obtained by integration over a set of $\boldsymbol{\omega}^{M}$. Examples will be given below. As a function of $\mathbf{x}, \mathcal{S}\left(I_{\boldsymbol{\omega}^{M}}^{n \beta}\right)(\mathbf{x})$ depends only on $|\mathbf{x}|$, and may preserve some dependence on $\boldsymbol{\omega}^{M}$. From Eq. (3.3),

$$
\begin{equation*}
\mathcal{S}\left(\int P_{\mathbf{0 x}}^{n \beta}\left(\mathrm{~d} \boldsymbol{\omega}_{0}\right) e^{-\beta\left[U_{1}\left(\boldsymbol{\omega}_{0}\right)+V\left(\boldsymbol{\omega}_{0}, \boldsymbol{\omega}^{M}\right)+U_{2}\left(\boldsymbol{\omega}^{M}\right)\right]}\right)(\mathbf{x})=e^{-\pi \mathbf{x}^{2} / \lambda_{n \beta}^{2}} \mathcal{S}\left(I_{\boldsymbol{\omega}^{M}}^{n \beta}\right)(\mathbf{x}) . \tag{3.8}
\end{equation*}
$$

One can differentiate inside the integral over $\boldsymbol{\omega}^{M}$, so

$$
\begin{equation*}
\Delta \mathcal{S}\left(I_{\omega^{M}}^{n \beta}\right)(\mathrm{x})=\mathcal{S}\left(\Delta I_{\omega^{M}}^{n \beta}\right)(\mathrm{x}) . \tag{3.9}
\end{equation*}
$$

Theorem 3.1 For $u_{1}$ and $u_{3}$ as in Proposition 3.1,

$$
\begin{equation*}
\lim _{n \rightarrow \infty, \mathbf{x}^{2} / n \rightarrow 0} \frac{\mathcal{S}\left(\int P_{\mathbf{0 x}}^{n \beta}\left(\mathrm{~d} \boldsymbol{\omega}_{0}\right) e^{-\beta\left[U_{1}\left(\boldsymbol{\omega}_{\mathbf{0}}\right)+V\left(\boldsymbol{\omega}_{0}, \boldsymbol{\omega}^{M}\right)+U_{2}\left(\boldsymbol{\omega}^{M}\right)\right]}\right)(\mathbf{x})}{\mathcal{S}\left(\int P_{\mathbf{0} \mathbf{x}}^{n \beta}\left(\mathrm{~d} \boldsymbol{\omega}_{0}\right) e^{-\beta\left[U_{1}\left(\boldsymbol{\omega}_{\mathbf{0}}\right)+V\left(\boldsymbol{\omega}_{0}, \boldsymbol{\omega}^{M}\right)+U_{2}\left(\boldsymbol{\omega}^{M}\right)\right]}\right)(\mathbf{0})} \geq 1 . \tag{3.10}
\end{equation*}
$$

Proof. $\Delta I_{\omega^{M}}^{n \beta} \geq 0$ implies $\Delta \mathcal{S}\left(I_{\omega^{M}}^{n \beta}\right) \geq 0$ and, because $\mathcal{S}\left(I_{\omega^{M}}^{n \beta}\right)(\mathrm{x})$ is spherical,

$$
\mathcal{S}\left(I_{\boldsymbol{\omega}^{M}}^{n \beta}\right)(\mathbf{x}) \geq \mathcal{S}\left(I_{\boldsymbol{\omega}^{M}}^{n \beta}\right)(\mathbf{0}) .
$$

Then,

$$
\begin{equation*}
\lim _{n \rightarrow \infty, \mathbf{x}^{2} / n \rightarrow 0} \frac{\mathcal{S}\left(\int P_{\mathbf{0 x}}^{n \beta}\left(\mathrm{~d} \boldsymbol{\omega}_{0}\right) e^{-\beta\left[U_{1}\left(\boldsymbol{\omega}_{0}\right)+V\left(\boldsymbol{\omega}_{0}, \boldsymbol{\omega}^{M}\right)+U_{2}\left(\boldsymbol{\omega}^{M}\right)\right]}\right)(\mathbf{x})}{\mathcal{S}\left(\int P_{\mathbf{0 x}}^{n \beta}\left(\mathrm{~d} \boldsymbol{\omega}_{0}\right) e^{-\beta\left[U_{1}\left(\boldsymbol{\omega}_{0}\right)+V\left(\boldsymbol{\omega}_{0}, \boldsymbol{\omega}^{M}\right)+U_{2}\left(\boldsymbol{\omega}^{M}\right)\right]}\right)(\mathbf{0})}=\lim _{n \rightarrow \infty, \mathbf{x}^{2} / n \rightarrow 0} \frac{\mathcal{S}\left(I_{\boldsymbol{\omega}^{M}}^{n \beta}\right)(\mathbf{x})}{\mathcal{S}\left(I_{\boldsymbol{\omega}^{M}}^{n \beta}\right)(\mathbf{0})} \geq 1 . \tag{3.11}
\end{equation*}
$$

## Examples.

(i) Fix some $L>0$ and define

$$
\begin{equation*}
\mathcal{S}\left(I^{n \beta}\right)(\mathbf{x})=\sum_{\pi \in S_{M}} \prod_{i=1}^{M} \int_{\left|\mathbf{x}_{i}\right|<L} \mathrm{~d} \mathbf{x}_{i} \int P_{\mathbf{x}_{i} \mathbf{x}_{\pi(i)}}^{\beta}\left(\mathrm{d} \boldsymbol{\omega}_{i}\right) I_{\boldsymbol{\omega}^{M}}^{n \beta}(\mathbf{x}) \tag{3.12}
\end{equation*}
$$

where $S_{M}$ is the set of permutations of $\{1, \ldots, M\}$. This is the typical choice when the particles associated with $\boldsymbol{\omega}^{M}$ are bosons. The physically interesting case is $n \propto M \propto L^{\nu}$ and $n \rightarrow \infty$ replaced by $L \rightarrow \infty$. If $n \propto L^{\nu}$, for $\mathbf{x}^{2} / n \rightarrow 0$ to hold one must have $|\mathbf{x}|=o\left(L^{\nu / 2}\right)$. In $\nu \geq 3$ dimensions all $\mathbf{x}$ of length $|\mathbf{x}|=O(L)$ satisfy this condition. When $n=M, u_{1}=u_{2}=-u_{3}=u$ with $\Delta u=0$, the system is a neutral two-component plasma.
(ii) The second set of particles can be treated classically. This is the $m_{2}=\infty$ limit in which both the kinetic and the potential energy of these particles (the last two terms of the Hamiltonian (1.11)) can be dropped. Now $\boldsymbol{\omega}_{i}(t) \equiv \mathbf{x}_{i}, \boldsymbol{\omega}^{M}=\mathbf{x}^{M}=\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{M}\right)$, and the interaction between the two sets becomes

$$
\begin{equation*}
V\left(\boldsymbol{\omega}_{0}, \mathbf{x}^{M}\right)=\frac{1}{\beta} \sum_{k=0}^{n-1} \sum_{i=1}^{M} \int_{0}^{\beta} u_{3}\left(\boldsymbol{\omega}_{0}(k \beta+t)-\mathbf{x}_{i}\right) \mathrm{d} t \tag{3.13}
\end{equation*}
$$

Spherical symmetrization can be done by keeping all $\left|\mathbf{x}_{i}-\mathbf{x}_{j}\right|$ unchanged. Let $g$ denote a general element of the rotation group $S O(\nu)$, and let $\mu$ be the Haar measure on $S O(\nu)$. Define

$$
\begin{equation*}
\mathcal{S}\left(I_{\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{M}\right)}^{n \beta}\right)(\mathbf{x})=\int I_{\left(g \mathbf{x}_{1}, \ldots, g \mathbf{x}_{M}\right)}^{n \beta}(\mathbf{x}) \mu(\mathrm{d} g) \tag{3.14}
\end{equation*}
$$

Because $u_{1}$ and $u_{3}$ are spherical functions and the measure $P_{00}^{n \beta}$ is rotation invariant, one actually has

$$
\begin{equation*}
\mathcal{S}\left(I_{\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{M}\right)}^{n \beta}\right)(\mathbf{x})=\int I_{\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{M}\right)}^{n \beta}(g \mathbf{x}) \mu(\mathrm{d} g) \tag{3.15}
\end{equation*}
$$

When $n=M, u_{1}=-u_{3}=u$ with $\Delta u=0$, we have a neutral system of light charged particles moving in the field of immobile heavy ions.
