# Construction of solutions to parabolic and hyperbolic initial-boundary value problems

#### Abstract

We show that infinitely differentiable solutions to parabolic and hyperbolic equations, whose right-hand sides are analytical in time, are also analytical in time at each fixed point of the space. These solutions are given in the form of the Taylor expansion with respect to time $t$ with coefficients depending on $x$. The coefficients of the expansion are defined by recursion relations, which are obtained from the condition of compatibility of order $k=\infty$. The value of the solution on the boundary is defined by the right-hand side and initial data, so that it is not prescribed. We show that exact regular and weak solutions to the initial-boundary value problems for parabolic and hyperbolic equations can be determined as the sum of a function that satisfies the boundary conditions and the limit of the infinitely differentiable solutions for smooth approximations of the data of the corresponding problem with zero boundary conditions. These solutions are represented in the form of the Taylor expansion with respect to $t$. The suggested method can be considered as an alternative to numerical methods of solution of parabolic and hyperbolic equations.


Key words: Parabolic equation, hyperbolic equation, smooth solution, regular solution, Taylor expansion.

## 1 Introduction

Initial-boundary value (mixed) problems for parabolic and hyperbolic equations have since long ago led to a great number of works; see e.g. the monographs [7, 8, 11, 15, 19] and the references therein.

This paper is devoted to construction of infinitely differentiable solutions to parabolic and hyperbolic equations, and its applications to construction of regular and weak solutions to initial-boundary problems for these equations.

It is well known that, for the existence of a smooth solution to parabolic or hyperbolic equation, the compatibility condition of an order $k \in \mathbb{N}$, corresponding to the smoothness of the solution to the problem, should be satisfied.

The compatibility condition of order $k$ means that the functions $\left.\frac{\partial^{i} u}{\partial t^{i}}\right|_{t=0}, i=0,1,2, \ldots, k$ ( $u$ being the solution, $t$ time), which are determined from the equation, initial data, and the
right-hand side, should be equal on the boundary to $\left.\frac{\partial^{i} u_{b}}{\partial t^{i}}\right|_{t=0}, i=0,1,2, \ldots, k$, where $u_{b}$ is the given function of values of the solution on the boundary. In the case where the solution is infinitely differentiable, one has $k=\infty$.

We consider problems in a bounded domain $\Omega$ in $\mathbb{R}^{n}$ with a boundary $S$ of the $C^{\infty}$ class on the time interval $(0, T), T<\infty$.

We suppose that the coefficients of the equation, the right-hand side, and the initial data are infinitely differentiable, and furthermore the coefficients of the equation and the righthand side are given in the form of the Taylor expansion with respect to time $t$ with the origin at the point $t=0$ and with coefficients depending on $x$, where $x$ is a point in the space. Then the solution to the problem under consideration is informally given in the form of the Taylor expansion with respect to $t$ in which coefficients depend on $x$, i.e.,

The coefficients $\frac{\partial^{i} u}{\partial t^{i}}(\cdot, 0)$ are determined by recurrence relations, more exactly, they are determined by the derivatives with respect to time $t$ at $t=0$ of the right-hand side $f$, the coefficients of the equation, and by the initial data $u_{0}$ for a parabolic equation and $u_{0}, u_{1}$ for a hyperbolic equation.

We prove converges of the series (1.1) in the space $C^{\infty}(\bar{Q}), Q=\Omega \times(0, T)$ by using the existence of an infinitely differentiable solution to the problem. So that, the value of the solution $u$ on the boundary $\left.u\right|_{S \times(0, T)}=u_{b}$ is uniquely determined by $f$ and $u_{0}$ for a parabolic equation, and by $f, u_{0}$ and $u_{1}$ for a hyperbolic equation.

This peculiarity is for the first time shown in our work. In the usual, accepted approach, one prescribes for parabolic and hyperbolic equations a right-hand side, initial, and boundary conditions.

For the zero Dirichlet boundary condition, we assume that $u_{0}$ and $u_{1}$ are elements of $\mathcal{D}(\Omega)$ and $f \in C^{\infty}([0, T] ; \mathcal{D}(\Omega))$. Then the compatibility condition of order $k=\infty$ is satisfied, and the solution to parabolic and hyperbolic equations can be represented in the form of (1.1).

It is known that the space $C^{\infty}(\bar{Q})$ is dense both in $W_{q}^{l}(Q)$ and in the space $\left(W_{g}^{l}(Q)\right)^{*}$, $1 / q+1 / g=1$, that is the dual of $W_{q}^{l}(Q)$ for any $l \in \mathbb{N}, q \geq 2$. By the corollary to the Weierstrass-Stone theorem, the set of products of polynomials with respect to $x$ and polynomials with respect to $t$ is dense in $C^{\infty}(\bar{Q})$. Therefore, the set of functions that are represented in the form of the Taylor expansion with respect to $t$ with coefficients which are elements of the space $C^{\infty}(\bar{\Omega})$, is dense in $C^{\infty}(\bar{Q})$, in $W_{q}^{l}(Q)$, and in $\left(W_{g}^{l}(Q)\right)^{*}$.

Because of these properties, one can approximate smooth and non-smooth data of the problem and the coefficients of equation by corresponding infinitely differentiable functions with an arbitrary accuracy.

We apply the Taylor representation (1.1) to construction of regular and weak solutions to parabolic and hyperbolic equations for which we prescribe the right-hand side, initial, and boundary conditions. We consider well-posed parabolic and hyperbolic problems for which the solution depends continuously on the data of the problem. The problems with inhomogeneous boundary conditions are reduced to problems with homogeneous boundary conditions. The data of these problems are approximated by corresponding infinitely differentiable functions for which the compatibility condition of order $k=\infty$ is satisfied. The solution to the problem
with homogeneous boundary condition is constructed in the form (1.1). The solution to the problem with non-smooth data is determined as a limit of solutions for smooth approximated data.

The convergence of the Taylor series in the corresponding spaces is proved on the basis of the existence result for corresponding data.

Numerical solution of a parabolic problem with large convection, when one of the coefficients of the equation by the derivative with respect to some $x_{i}$ is large for the norm of $L^{\infty}(Q)$, is a very difficult problem. There are many publications dealing with these problems. Many methods $s$ where developed for numerical solution of such problems, see e.g. [1,3, 6]. However, for significantly large convection, this problem is practically not solved.

The method proposed in this paper permits one to construct exact solutions to such problems for infinitely differentiable approximations of the right-hand side $f$ and initial data $u_{0}$. Moreover, if an approximation of $f$ is represented in the form of a finite sum of terms in the Taylor expansion in $t$ with coefficients depending on $x$, then the exact solution for this approximation of $f$ is also represented in the form of a finite sum of the Taylor expansion. The exact solution to the problem for given data is the limit of solutions for smooth approximations of $f$ and $u_{0}$.

Thus, the suggested method of construction of solutions to parabolic and hyperbolic equations is an alternative to methods of numerical solution of parabolic and hyperbolic equations.

Below in Section 2, we consider problems for linear and nonlinear parabolic equations. Regular solutions to these equations with homogeneous and nonhomogeneous boundary conditions are constructed. In the case of a nonhomogeneous boundary condition, the solution is represented as a sum of a function satisfying the boundary condition and a limit of solutions to the this problem with zero boundary condition for infinitely differentiable data. These solutions are represented in the form (1.1)

In much the same way, we construct regular solutions to a system of parabolic equations in Section 3.

In Section 4, we consider an initial boundary value problem for a system of hyperbolic equations for homogeneous and nonhomogeneous boundary conditions. Solutions to these problems are constructed.

In Section 5, we formulate a nonlinear problem on vibration of an orthotropic plate in a viscous medium. We show that there exists a unique solution to this problem, and this solution is obtained as a limit of solutions $u^{n}$ to this problem for corresponding approximations of the data of the problem; the functions $u^{n}$ are computed in the form of Taylor expansion.

In Section 6, we consider a 3-dimensional problem for Maxwell equations and a problem on diffraction of electromagnetic wave by a superconductor, i.e., a slotted antenna's problem. Solutions to these problems are constructed.

## 2 Parabolic equations

### 2.1 Linear problem and Taylor expansion

Let $\Omega$ be a bounded domain in $\mathbb{R}^{n}$ with a boundary $S$ of the class $C^{\infty}$. Let $Q=\Omega \times(0, T)$, where $T \in(0, \infty)$. Consider the problem: Find $u$ such that

\left.u\right|_{t=0}=u_{0} \text { in } \Omega,\left.\quad u(\cdot, 0)\right|_{S}=\left.u_{0}\right|_{S} . \tag{2.2}
\end{gather*}

Here and below the Einstein convention on summation over repeated index is applied. As seen from (2.2), we prescribe the value of the function $u$ on the boundary at the point $t=0$ only.

Since the boundary $S$ is of the class $C^{\infty}$, we can assume that the coefficients of equation (2.1) and the right-hand side $f$ are given in a bounded domain $Q_{1}=\Omega_{1} \times(0, T)$, where $\Omega_{1} \supset \bar{\Omega}$, and $u_{0}$ is prescribed in $\Omega_{1}$, see [14], Theorem 9.1, Chapter 1.

We denote the space of infinitely differentiable functions with support in $\Omega_{1}$ by $\mathcal{D}\left(\Omega_{1}\right)$, and the space of infinitely differentiable functions on $\Omega_{1} \times[0, T]$ with support in $\Omega_{1}$ for each $t \in[0, T]$ by $C^{\infty}\left([0, T] ; \mathcal{D}\left(\Omega_{1}\right)\right)$.

Topologies in both $\left.\mathcal{D}\left(\Omega_{1}\right)\right)$ and $C^{\infty}\left([0, T] ; \mathcal{D}\left(\Omega_{1}\right)\right)$ are defined by the families of corresponding seminorms.

We assume that

A topology on $U$ is defined by the product of the topologies of $C^{\infty}\left([0, T] ; \mathcal{D}\left(\Omega_{1}\right)\right)$ and $\mathcal{D}\left(\Omega_{1}\right)$.
Denote

Then equation (2.1) can be represented in the form

We differentiate equation (2.8) in $t k-1$ times and set $t=0$. This gives the following recurrence relation:

=\sum_{j=0}^{k-1} C_{k-1}^{j}\left(\frac{\partial^{j} A}{\partial t^{j}}\left(x, t, \frac{\partial}{\partial x}\right)\right)(\cdot, 0)\left(\frac{\partial^{k-1-j}}{\partial t^{k-1-j}} u\right)(\cdot, 0)+\frac{\partial^{k-1} f}{\partial t^{k-1}}(\cdot, 0), \quad k=1,2, \ldots \tag{2.9}
\end{gather*}

Here $u(\cdot, 0)=u_{0}, C_{k-1}^{j}$ are the binomial coefficients, $\frac{\partial^{j} A}{\partial t^{j}}\left(x, t, \frac{\partial}{\partial x}\right)$ is the operator obtained from the operator $A$ by differentiation of its coefficients in $t j$ times.

A smooth solution $u$ satisfies the condition

For $m=0$, we get $u_{0}(x)=u_{b}(x, 0), x \in S$.
We say that the compatibility condition of order $k$ is satisfied if (2.10) holds for $m=$ $0,1,2, \ldots, k$.

For infinitely differentiable solutions the compatibility condition of order $k=\infty$ is satisfied.

Theorem 2.1. Let $\Omega$ be a bounded domain in $\mathbb{R}^{n}$ with a boundary $S$ of the class $C^{\infty}$ and $T \in(0, \infty)$. Suppose that the conditions (2.3) -(2.6) are satisfied. Then there exists a unique solution to the problem (2.1), (2.2) such that $u \in C^{\infty}(\bar{Q})$, and this solution is represented in the form of a Taylor expansion

The coefficients $\frac{\partial^{k} u}{\partial t^{k}}(\cdot, 0)$ are defined by the recurrence relation (2.9). Furthermore, the boundary condition function $u_{b}=\left.u\right|_{S_{T}}, S_{T}=S \times[0, T]$, is determined as follows:

The function $\left(f, u_{0}\right) \mapsto u$ defined by the solution to the problem (2.1), (2.2) is a continuous mapping of $U$ into $C^{\infty}(\bar{Q})$.

Proof. We consider the problem: Find $\check{u}$ satisfying

where $S_{1 T}=S_{1} \times[0, T], S_{1}$ is the boundary of $\Omega_{1}$. By (2.4), $S_{1}$ is of the class $C^{\infty}$. It follows from (2.3), (2.9) and (2.13) that the compatibility condition of any order $k \in \mathbb{N}$ is satisfied, and by [11], Theorem 5.2, Chapter IV and [19], Theorem 5.4, Chapter V, there exists a unique solution to the problem (2.13) such that $\check{u} \in W_{q}^{2(k+1), k+1}\left(Q_{1}\right), k \in \mathbb{N}=\{0,1,2, \ldots\}, q \geq 2$. Therefore, $\check{u} \in C^{\infty}\left(\bar{Q}_{1}\right)$.

The functions $\frac{\partial^{k} \check{u}}{\partial t^{k}}(\cdot, 0)$ are defined by formula (2.9) in which $\Omega$ is replaced by $\Omega_{1}$ and $u$ by $\check{u}$. (2.4) implies $\frac{\partial^{k} \breve{u}}{\partial t^{k}}(\cdot, 0) \in \mathcal{D}\left(\Omega_{1}\right), k \in \mathbb{N}$.

Informally, the solution to the problem (2.13) is represented in the form of a Taylor expansion

The function $\check{u}$ defined by (2.14) represents a smooth solution to the problem (2.13) for all points $t \in[0, T]$ such that the series (2.14) converges at $t$ in $\mathcal{D}\left(\Omega_{1}\right)$.

Let us prove this. Denote

(2.9) and (2.15) imply that the function $\check{u}_{m}$ is a solution to the problem

It follows from (2.4) that

\end{equation*}

It is known that the solution of a parabolic problem depends continuously on the data of the problem $f, u_{b}, u_{0}$, see [11], Theorem 5.2, Chapter IV and [19], Theorem 5.4, Chapter V. Because of this, (2.13) and (2.16) yield

Therefore

\check{u}_{m} \rightarrow \check{u} \text { in } W_{q}^{2(l+1), l+1}\left(Q_{1}\right), \quad l \in \mathbb{N}, q \geq 2
$$

and $\breve{u}_{m} \rightarrow \check{u}$ in $C^{\infty}\left(\bar{Q}_{1}\right)$. The function $u=\left.\breve{u}\right|_{Q}$ is a solution to the problem (2.1), (2.2), and it is determined by (2.9) and (2.11). This solution is unique.

It follows from 11 and [19] that the function $\left(f, u_{0}\right) \mapsto \check{u}$ defined by the solution to the problem (2.13), is a continuous mapping of $U$ into $W_{q}^{2(l+1), l+1}\left(Q_{1}\right)$ for any $l \in \mathbb{N}, q \geq 2$. Therefore, the function $\left(f, u_{0}\right) \mapsto u$, where $u$ is the solution to the problem (2.1), (2.2), is a continuous mapping of $U$ into $C^{\infty}(\bar{Q})$.

Remark 2.1. It is customary to prescribe for a parabolic equation the functions $f, u_{0}$ and the boundary condition $u_{b}$. However, it follows from Theorem 2.1 that under the conditions of this theorem, one prescribes only $f$ and $u_{0}$. In this case, there exists a unique solution to the problem (2.1), (2.2) that is represented in the form (2.11) and the function $u_{b}$ is determined by $f$ and $u_{0}$.

Corollary 2.1. Let $f$ be a function in $Q$ that is represented in the form of the Taylor expansion in $t$ with coefficients depending on $x$. Let $u$ be a solution to the problem (2.1) such that $u \in C^{\infty}(\bar{Q})$. Then, for any fixed point $x \in \bar{\Omega}$, the partial function $t \mapsto u(x, t)$ is analytical, and $u$ is represented in the form (2.11).

Proof. Indeed, in this case, $f \in C^{\infty}(\bar{Q}), u_{0} \in C^{\infty}(\bar{\Omega})$, the compatibility condition of order infinity is satisfied, and it follows from the Theorem 2.1 that $u$ represented in the form (2.11).

Consider the following problem on existence of an infinitely differentiable solution to a parabolic problem with given boundary and initial conditions:

Here $A\left(x, t, \frac{\partial}{\partial x}\right)$ is defined by (2.7).
We define the following spaces:

We define an operator $\gamma: X \rightarrow Z$ by

Note that $X_{0}$ is the kernel of the operator $\gamma$.
Let $X / X_{0}$ be the factor space. If $u^{1}$ and $u^{2}$ are elements of $X$ such that $u^{1}-u^{2} \in X_{0}$, then $u^{1}$ and $u^{2}$ belong to the same class in $X / X_{0}$, say $\bar{u}$. We say that $\bar{u}$ is of class $\left(u_{0}, u_{b}\right) \in Z$ if $\gamma(u)=\left(u_{0}, u_{b}\right)$ for all $u \in \bar{u}$. The result bellow follows from Theorem 2.1.

Corollary 2.2. Let $\left(u_{0}, u_{b}\right) \in Z$ and let $\bar{u}$ be the class $\left(u_{0}, u_{b}\right)$ from $X / X_{0}$. Then any function $\left.u \in \bar{u}\right|_{\bar{Q}}$ is the solution to the problem (2.20), (2.21) for $u_{0}, u_{b}$, and $f$ that is determined as follows:

Then there exists a unique solution to the problem (2.26) that is represented in form (2.11), and the function $\left(f, u_{0}, 0\right) \mapsto$ $u$ is a continuous mapping of $U_{1}$ into $C^{\infty}([0, T] ; \mathcal{D}(\Omega))$.

### 2.2 Solution of initial-boundary value problems in Sobolev space

We consider the problem (2.20), (2.21) in which we are given $f, u_{0}, u_{b}$. We suppose that

For the sake of simplicity, we assume that the coefficients of the equation (2.20) are elements of $C^{\infty}(\bar{Q})$, and they are represented in the form of Taylor expansion in $t$ with coefficients depending on $x$, i.e., (2.5), (2.6) hold, and the boundary $S$ is of the class $C^{\infty}$.

It follows from the corollary to the Stone-Weierstrass theorem that the set of tensor products of polynomials in $x$ and polynomials in $t$ is dense in $C^{\infty}(\bar{Q})$. Therefore, the solution to the equation with non-smooth coefficients is obtained as the limit of solutions of equations with smooth coefficients as above.

By analogy, a non-smooth boundary $S$ can be approximated by boundaries of the class $C^{\infty}$. In this case, solutions for smooth boundaries converge to the solution for non-smooth boundary in the corresponding space, see [16].

It follows from the known results, see e.g. [15], Chapter 4, Theorems 2.3 and 6.2, [19], Chapter V, Theorem 5.4 that, under the above conditions, there exists a unique solution to the problem (2.20), (2.21) such that

Then by Theorem 2.1, there exists a unique solution to our problem in $Q_{1}$, and it is determined by (2.14), where the functions $\check{u}$ and $\check{u}_{0}$ are replaced by $\tilde{u}_{m}$ and $\tilde{u}_{0 m}$. Thus, the solution to the problem (2.36) belongs to $C^{\infty}(\bar{Q})$ and it is represented in the form

Then, there exists a unique solution to the problem (2.20), (2.21) that satisfies (2.28), and it is represented in the form $u=\tilde{u}+w$, where $w$ is given by (2.29), and $\tilde{u}$ is determined by (2.39).

Remark 2.2. When applying Theorem 2.2 in practice, one can compute the solution to the problem (2.36) directly by (2.37) and (2.9), without the extension that was used to prove converges of the series.
Remark 2.3. Theorem 2.2 also holds in the case where $u_{b}=0$. Indeed, we just need to take $w=0$ in the above computations.
Remark 2.4. In practical applications the data of the problem are usually not accurately given, often they are determined by intuition, or even are plucked out of thin air. Therefore, in such a case, it makes no sense to solve the problem (2.36) for a series of functions $\left\{\tilde{f}_{m}, \tilde{u}_{0 m}\right\}$ which satisfy the condition (2.35). It is sufficient to solve problem (2.36) for one or two pairs $\tilde{f}_{m}, \tilde{u}_{0 m}$ which are close to $\tilde{f}$ and $\tilde{u}_{0}$ with not a high precision. Moreover, here $\tilde{f}_{m}$ can be taken in a form of a finite sum of the Taylor expansion, which is suitable for a given $T$. In this case, if $\tilde{f}_{m}=\tilde{f}_{m l}$, where

Numerical solution of the problem (2.20), (2.21) in the case of a large convection, when the norm of one of the coefficients $a_{i}$ of the operator $A$ is large in $L^{\infty}(Q)$ is a very hard problem. Our method permits one to construct the exact solution to the problem (2.36) in the form (2.37). Moreover, if $\tilde{f_{m}}=\tilde{f_{m l}}$ is represented in the form (2.40), then the solution to the problem (2.36) is represented in the form (2.41).

Therefore, the series (2.49) converges in $W_{q, 0}^{2 l+2, l+1}(Q)$, and gives the solution to the problem (2.42), (2.43).

We remark that, in the case $f \in L^{2}(Q)$ and $u_{0} \in H_{0}^{1}(\Omega)$, the solution to the problem (2.42), (2.43) can be defined as the limit of solutions to this problem for $f=\tilde{f}_{m}$ and $u_{0}=\tilde{u}_{0 m}$ that are determined by (2.35) with $w=0$.

### 2.4 Construction of functions of $\mathcal{D}(\Omega)$

Let $\Omega_{2}$ be a domain in $\mathbb{R}^{n}$ such that $\bar{\Omega}_{2} \subset \Omega$, and $S_{2}$ be the boundary of $\Omega_{2}$. We suppose that

The boundary of polyhedron is infinitely differentiable everywhere with exception of angular points, at which it is not differentiable. Nevertheless, in small vicinities of angular points this boundary can be regularized by convolution of the function $F_{k}$, see (2.61), with an infinitely differentiable function with a small support, in particular, with the bump function.

If the boundary of a polyhedron is not regularized, then the computation of the solution to the problem in exteriors of any small vicinities of angular points can be fulfilled.

For the case of non-convex polyhedron, one can identify the faces of the polyhedron with local cards, without using a partition of unity. That is, one assumes that $f_{k}$ are the identity mappings of the sets

## 5 Problem on vibration of an orthotropic plate in a viscous medium.

Plates fabricated from composite materials are used in modern constructions. Such plates are orthotropic. The strain energy of the orthotropic plate is defined by the following formula, see 16

The viscous medium resists the vibration of the plate. The resistance force $F_{\mathrm{rm}}$ that it induces is opposite in direction to the velocity $\frac{\partial u}{\partial t}, F_{\mathrm{rm}}=-\varphi \frac{\partial u}{\partial t}$, where $\varphi$ is the resistance coefficient which is an increasing function of $\left|\frac{\partial u}{\partial t}\right|$ that takes positive values.

We take the resistance force in the form

\gamma_{2 n} & =\operatorname{curl}\left(\left(\hat{\xi}-\hat{\xi}_{n}\right) D_{n}\right) \tag{6.40}
\end{align*}
$$

(6.21) and (6.31) yield

$$
\begin{equation*}
\gamma_{1 n} \rightarrow 0 \quad \text { in } L^{\infty}\left(0, T ; L_{2}(\Omega)^{3}\right), \quad \gamma_{2 n} \rightarrow 0 \quad \text { in } L^{\infty}\left(0, T ; L_{2}(\Omega)^{3}\right) \tag{6.41}
\end{equation*}
$$

By (6.39) (6.41) equations (6.35), (6.36) take the form

$$
\begin{aligned}
& \frac{\partial}{\partial t}\left(D-D_{n}\right)-\operatorname{curl}\left(\hat{\mu}\left(B^{1}-B_{n}^{1}\right)\right)+\sigma \hat{\xi}\left(D-D_{n}\right)+\gamma_{1 n}=G_{1}+\operatorname{curl}\left(\hat{\mu} B^{2}\right)-G_{1 n} \\
& \frac{\partial}{\partial t}\left(B^{1}-B_{n}^{1}\right)+\operatorname{curl}\left(\hat{\xi}\left(D-D_{n}\right)\right)+\gamma_{2 n} .=G_{2}-\frac{\partial B^{2}}{\partial t}-G_{2 n}
\end{aligned}
$$

From here and (6.30), taking (6.19), (6.20), and (6.41) into account, we obtain (6.29).
According to the theory of electromagnetism, the function $B$ should satisfy the condition

\operatorname{div} B=0 \quad \text { in } Q \tag{6.42}
\end{equation*}
$$

Theorem 6.3. Suppose that the conditions of Theorem 6.1 are satisfied and, in addition,

\operatorname{div} G_{2}=0 \quad \text { in } Q, \quad \operatorname{div} B_{0}=0 \quad \text { in } \Omega \tag{6.43}
\end{equation*}

Then the function $B$ of the solution $(D, B)$ to the problem (6.1) -(6.4) also meets the condition $\operatorname{div} B=0$ in $Q$.

Indeed, applying the operator div, in the sense of distributions, to both sides of equation (6.2), we obtain

That is

Theorem 6.4. Suppose that the conditions of Theorem 6.2 are satisfied and, in addition,

& B^{2}=\operatorname{curl} P, P \in L^{\infty}\left(0, T ; H^{2}(\Omega)^{3}\right), \frac{\partial P}{\partial t} \in L^{\infty}\left(0, T ; H^{1}(\Omega)^{3}\right), \\
& \frac{\partial^{2} P}{\partial t^{2}} \in L^{2}\left(0, T ; H^{1}(\Omega)^{3}\right), \\
& B_{0}^{1}=\operatorname{curl} M^{1}, M^{1} \in H_{0}^{2}(\Omega)^{3}, B_{0}^{2}=\operatorname{curl} M^{2}, M^{2} \in H^{2}(\Omega)^{3},\left.P\right|_{t=0}=M^{2} . \tag{6.44}
\end{align*}
$$

The corresponding functions $G_{2 n}$ and $B_{0 n}^{1}$ are given as follows

$$
\begin{align*}
& G_{2 n}=\operatorname{curl} F_{n}, \quad F_{n} \in C^{\infty}\left([0, T] ; \mathcal{D}(\Omega)^{3}\right), \\
& F_{n}(x, t)=\sum_{k=0}^{\infty} \frac{1}{k!} \frac{\partial^{k} F_{n}}{\partial t^{k}}(x, 0) t^{k}, \quad(x, t) \in Q,  \tag{6.45}\\
& \operatorname{curl} F_{n} \rightarrow \operatorname{curl}\left(F-\frac{\partial P}{\partial t}\right) \quad \text { in } L^{2}(Q)^{3}, \\
& \operatorname{curl} \frac{\partial F_{n}}{\partial t} \rightarrow \operatorname{curl}\left(\frac{\partial F}{\partial t}-\frac{\partial^{2} P}{\partial t^{2}}\right) \quad \text { in } L^{2}(Q)^{3},  \tag{6.46}\\
& B_{0 n}^{1}=\operatorname{curl} M_{n}^{1}, \quad M_{n}^{1} \in \mathcal{D}(\Omega)^{3}, \quad M_{n}^{1} \rightarrow M^{1} \quad \text { in } H_{0}^{2}(\Omega)^{3} . \tag{6.47}
\end{align*}
$$

Then the solution $D_{n}, B_{n}^{1}$ to the problem (6.22) (6.25) also meets the condition $\operatorname{div} B_{n}^{1}=0$, (6.29) holds and $\operatorname{div} B=0$.

Theorem 6.4 follows from results of Theorems 6.2 and 6.3.

### 6.2 Slotted antenna

We consider the problem on diffraction of electromagnetic wave by a superconductor, see [5], Chapter 7, Section 3.4. Let $\Omega_{1}$ be a bounded domain in $\mathbb{R}^{3}$, of a superconductor, the boundary $S$ of $\Omega_{1}$ is of the class $C^{\infty}$. We consider a problem in a domain $\Omega$ in $\mathbb{R}^{3}$ with an internal boundary $S$. We assume that $\Omega$ is a bounded domain.

We seek a solution to the following problem: Find vector functions $D$ and $B$ such that

& \frac{\partial D}{\partial t}-\operatorname{curl}(\hat{\mu} B)+\sigma \hat{\xi} D=G_{1} \quad \text { in } Q  \tag{6.48}\\
& \frac{\partial B}{\partial t}+\operatorname{curl}(\hat{\xi} D)=G_{2} \quad \text { in } Q \tag{6.49}
\end{align*}
$$

$$
\begin{align*}
& \operatorname{div} D=0 \quad \text { in } Q, \quad \nu \wedge D=0 \quad \text { on } S_{T}  \tag{6.50}\\
& \operatorname{div} B=0 \quad \text { in } Q, \quad \nu \cdot B=0 \quad \text { on } S_{T}  \tag{6.51}\\
& \left.D\right|_{t=0}=D_{0},\left.\quad B\right|_{t=0}=B_{0} \quad \text { in } \Omega \tag{6.52}
\end{align*}
$$

We introduce the following spaces:

$$
\begin{align*}
& X_{2}=\left\{h \mid h=\operatorname{curl} w, w \in L^{2}(0, T ; V), \quad \frac{\partial w}{\partial t} \in L^{2}(0, T ; V)\right\}, \\
& X_{3}=\left\{h \mid h=\operatorname{curl} w, w \in L^{2}\left(0, T ; H^{1}(\Omega)^{3}\right),\right.  \tag{6.53}\\
& \left.h \cdot \nu=0 \text { in } L^{2}\left(0, T ; H^{-\frac{1}{2}}(S)\right), \frac{\partial w}{\partial t} \in L^{2}\left(0, T ; H^{1}(\Omega)^{3}\right)\right\} . \tag{6.54}
\end{align*}
$$

We assume

$$
\begin{align*}
& G_{1}=\operatorname{curl} w \in X_{2}, \quad G_{2}=\operatorname{curl} u \in X_{3}, \quad D_{0}=\operatorname{curl} p, \quad p \in H_{0}^{2}(\Omega)^{3}, \\
& B_{0}=\operatorname{curl} v, \quad v \in H^{2}(\Omega)^{3}, \quad \operatorname{curl} v \cdot \nu=0 \quad \text { on } S . \tag{6.55}
\end{align*}
$$

Theorem 6.5. Let $\Omega$ be a bounded domain in $\mathbb{R}^{3}$ with a boundary $S$ of the class $C^{\infty}$. Suppose that the conditions (6.55) are satisfied. Let also $\hat{\xi}, \hat{\mu}, \sigma$ be positive constants. Then, there exists a unique solution to the problem (6.48) -(6.52) such that

$$
\begin{array}{ll}
D \in L^{\infty}\left(0, T ; H_{0}^{1}(\Omega)^{3}\right), & \frac{\partial D}{\partial t} \in L^{\infty}\left(0, T ; L^{2}(\Omega)^{3}\right), \\
B \in L^{\infty}\left(0, T ; H^{1}(\Omega)^{3}\right), & \frac{\partial B}{\partial t} \in L^{\infty}\left(0, T ; L^{2}(\Omega)^{3}\right) . \tag{6.56}
\end{array}
$$

Indeed, the existence of a unique solution to the problem (6.48), (6.49), (6.51), such that $\nu \wedge D=0$ on $S_{T}$ and $\operatorname{div} B=0$ in $Q$, follows from Theorems 6.1 and 6.3. The conditions $\nu \cdot B=0$ on $S_{T}$, $\operatorname{div} D=0$ in $Q$, and (6.56) follow from Theorems 5.3, 6.3 and 6.4 in [5], Chapter 7.

As before, we represent the function $B$ in the form $B=B^{1}+B^{2}$, where $B^{2}$ is a given function such that

\begin{align*}
& B^{2}=\operatorname{curl} \alpha^{2}, \quad \alpha^{2} \in L^{\infty}\left(0, T ; H^{2}(\Omega)^{3}\right), \quad \operatorname{curl} \alpha^{2} \cdot \nu=0 \quad \text { on } S_{T}, \\
& \frac{\partial \alpha^{2}}{\partial t} \in L_{\infty}\left(0, T ; H^{1}(\Omega)^{3}\right), \quad \frac{\partial^{2} \alpha^{2}}{\partial t^{2}} \in L^{2}\left(0, T ; H^{1}(\Omega)^{3}\right), \\
& \operatorname{curl} \frac{\partial \alpha^{2}}{\partial t} \cdot \nu=0 \quad \text { on } S_{T} . \tag{6.57}
\end{align*}
$$

Let $B_{\tau}$ be the tangential component of the vector $B$ on $S_{T}$. It is determined as $B_{\tau}=$ $\left.B\right|_{S_{T}}-B \cdot \nu$. Since $B \cdot \nu=0$. we get $\left.B\right|_{S_{T}}=B_{\tau}$ and the following boundary condition for $B^{2}$ :

$$
\begin{equation*}
\left.B^{2}\right|_{S_{T}}=\left.B\right|_{S_{T}} \quad \text { in } H^{\frac{1}{2}}\left(S_{T}\right)^{3} . \tag{6.58}
\end{equation*}
$$

According to (6.57), (6.58), we set

\begin{align*}
& B_{0}=B_{0}^{1}+B_{0}^{2}, \quad B_{0}^{2}=\left.B^{2}\right|_{t=0}=\left.\operatorname{curl} \alpha^{2}\right|_{t=0} \in H^{1}(\Omega)^{3}, \\
& \left.B_{0}^{1}=\operatorname{curl} v-\left.\operatorname{curl} \alpha^{2}\right|_{t=0} \in H_{0}^{1}(\Omega)^{3}\right) \tag{6.59}
\end{align*}
$$

Now for the functions $D, B^{1}$, we obtain the following problem:

$$
\begin{align*}
& \frac{\partial D}{\partial t}-\operatorname{curl}\left(\hat{\mu} B^{1}\right)+\sigma \hat{\xi} D=G_{1}+\operatorname{curl}\left(\hat{\mu} B^{2}\right) \quad \text { in } Q \\
& \frac{\partial B^{1}}{\partial t}+\operatorname{curl}(\hat{\xi} D)=G_{2}-\frac{\partial B^{2}}{\partial t} \quad \text { in } Q \\
& \operatorname{div} D=0 \quad \text { in } Q, \quad \nu \wedge D=0 \quad \text { on } S_{T} \\
& \operatorname{div} B^{1}=0 \quad \text { in } Q, \quad \nu \wedge B^{1}=0 \quad \text { on } S_{T} \\
& \left.D\right|_{t=0}=D_{0},\left.\quad B^{1}\right|_{t=0}=B_{0}^{1}=B_{0}-B_{0}^{2} \quad \text { in } \Omega \tag{6.60}
\end{align*}
$$

By analogy with the above, we get the next result.
Theorem 6.6. Let $\Omega$ be a bounded domain in $\mathbb{R}^{3}$ with a boundary $S$ of the class $C^{\infty}$. Suppose that the conditions (6.55) and (6.57) -(6.59) are satisfied. Let also $\hat{\xi}, \hat{\mu}, \sigma$ be positive constants. Then, there exists a unique solution $\left(D, B^{1}\right)$ to the problem (6.60) that meets the conditions

$$
\begin{array}{ll}
D \in L^{\infty}\left(0, T ; H_{0}^{1}(\Omega)^{3}\right), & \frac{\partial D}{\partial t} \in L^{\infty}\left(0, T ; L^{2}(\Omega)^{3}\right) \\
B^{1} \in L^{\infty}\left(0, T ; H_{0}^{1}(\Omega)^{3}\right), & \frac{\partial B^{1}}{\partial t} \in L^{\infty}\left(0, T ; L^{2}(\Omega)^{3}\right) \tag{6.61}
\end{array}
$$

Thus, if the pair $(D, B)$ is the solution to the problem (6.48)-(6.51), and $B^{2}$ meets (6.57), (6.58), then the pair $\left(D, B^{1}\right)$ with $B^{1}=B-B^{2}$ is the solution to the problem (6.60).

On the contrary, if the couple $\left(D, B^{1}\right)$ is the solution to the problem (6.60), where $B^{2}$ meets (6.57), then the couple ( $D, B$ ) with $B=B^{1}+B^{2}$ is the solution to the problem (6.48)-(6.51), and (6.58) holds.

Therefore, the formulations (6.1)-(6.4) and (6.14)-(6.17) are equivalent in the above sense.
Let $\left\{G_{1 n}, G_{2 n}, D_{0 n}, B_{0 n}^{1}\right\}$ be a sequence such that

& G_{i n}=\operatorname{curl} w_{i n}, \quad w_{\text {in }} \in C^{\infty}\left([0, T] ; \mathcal{D}(\Omega)^{3}\right), \\
& w_{i n}(x, t)=\sum_{k=0}^{\infty} \frac{1}{k!} \frac{\partial^{k} w_{i n}}{\partial t^{k}}(x, 0) t^{k}, \quad(x, t) \in Q, \quad i=1,2, \\
& G_{1 n} \rightarrow G_{1}+\operatorname{curl}\left(\hat{\mu} B^{2}\right) \quad \text { in } H^{0,1}(Q)^{3}, \\
& G_{2 n} \rightarrow G_{2}-\frac{\partial B^{2}}{\partial t} \quad \text { in } H^{0,1}(Q)^{3},  \tag{6.62}\\
& D_{0 n}=\operatorname{curl} p_{n}, p_{n} \in \mathcal{D}(\Omega)^{3} . \operatorname{curl} p_{n} \rightarrow \operatorname{curl} p \quad \text { in } H_{0}^{1}(Q)^{3}, \\
& B_{0 n}^{1}=\operatorname{curl} e_{n}, e_{n} \in \mathcal{D}(\Omega)^{3}, \operatorname{curl} e_{n} \rightarrow \operatorname{curl} v-\left.\operatorname{curl} \alpha^{2}\right|_{t=0} \in H_{0}^{1}(\Omega)^{3} . \tag{6.63}
\end{align*}
$$

We consider the problem: Find functions $D_{n}$ and $B_{n}^{1}$ such that

\begin{align*}
& \frac{\partial D_{n}}{\partial t}-\operatorname{curl}\left(\hat{\mu} B_{n}^{1}\right)+\sigma \hat{\xi} D_{n}=G_{1 n} \quad \text { in } Q, \\
& \frac{\partial B_{n}^{1}}{\partial t}+\operatorname{curl}\left(\hat{\xi} D_{n}\right)=G_{2 n} \quad \text { in } Q, \\
& \operatorname{div} D_{n}=0 \quad \text { in } Q, \quad \nu \wedge D_{n}=0 \quad \text { on } S_{T}, \\
& \operatorname{div} B_{n}^{1}=0 \quad \text { in } Q, \quad \nu \wedge B_{n}^{1}=0 \quad \text { on } S_{T}, \\
& \left.D_{n}\right|_{t=0}=D_{0 n},\left.\quad B_{n}^{1}\right|_{t=0}=B_{0 n}^{1} \quad \text { in } \Omega . \tag{6.64}
\end{align*}
$$

Theorem 6.7. Let $\Omega$ be a bounded domain in $\mathbb{R}^{3}$ with a boundary $S$ of the class $C^{\infty}$. Suppose that the conditions (6.62), (6.63) are satisfied, and let $\hat{\xi}, \hat{\mu}, \sigma$ be positive constants. Then for any $n \in \mathbb{N}$, there exists a unique solution $D_{n}, B_{n}^{1}$ to the problem (6.64) that is represented in the form (6.26) - (6.28) and

$$
\begin{array}{ll}
D_{n} \rightarrow D \quad \text { in } L^{\infty}\left(0, T ; H_{0}^{1}(\Omega)^{3}\right), & \frac{\partial D_{n}}{\partial t} \rightarrow \frac{\partial D}{\partial t} \quad \text { in } L^{\infty}\left(0, T ; L^{2}(\Omega)^{3}\right), \\
B_{n}^{1} \rightarrow B^{1} \quad \text { in } L^{\infty}\left(0, T ; H_{0}^{1}(\Omega)^{3}\right), & \frac{\partial B_{n}^{1}}{\partial t} \rightarrow \frac{\partial B^{1}}{\partial t} \quad \text { in } L^{\infty}\left(0, T ; L^{2}(\Omega)^{3}\right) . \tag{6.65}
\end{array}
$$

The proof of this theorem is analogous to the proof of Theorem 6.2.
Remark 6.1. The problem (6.48) - 6.51) is connected with finding functions $y$ such that $\operatorname{div} y=0$ in $\Omega, y \cdot \nu=0$ on $S$, see (6.54), (6655). These functions can be determined in the form

$$
\begin{equation*}
y=\operatorname{curl} v+\operatorname{grad} h, v \in H^{1}(\Omega)^{3}, h \in H^{1}(\Omega), \tag{6.66}
\end{equation*}
$$

where $h$ is the solution to the problem

$$
\begin{gather*}
\operatorname{div} \operatorname{grad} h=\Delta h=0 \\
\operatorname{grad} h \cdot \nu=\left.\frac{\partial h}{\partial \nu}\right|_{S}=-\operatorname{curl} v \cdot \nu . \tag{6.67}
\end{gather*}
$$

We mention that the suggested method based on the Taylor expansion with respect to $t$ can also be used to construct solutions to other equations and system of equations, which contain derivatives with respect to time for all unknown functions.
