# Multiplicity and Hölder regularity of solutions for a nonlocal elliptic PDE involving singularity

#### Abstract

In this paper we prove the existence of multiple solutions for a nonlinear nonlocal elliptic PDE involving a singularity which is given as $$
\begin{aligned} \left(-\Delta_{p}\right)^{s} u & =\frac{\lambda}{u^{\gamma}}+u^{q} \text { in } \Omega, \\ u & =0 \text { in } \mathbb{R}^{N} \backslash \Omega, \\ u & >0 \text { in } \Omega, \end{aligned}
$$ where $\Omega$ is an open bounded domain in $\mathbb{R}^{N}$ with smooth boundary, $N>p s$, $s \in(0,1), \lambda>0,0<\gamma<1,1<p<\infty, p-1<q \leq p_{s}^{*}=\frac{N p}{N-p s}$. We employ variational techniques to show the existence of multiple positive weak solutions of the above problem. We also prove that for some $\beta \in(0,1)$, the weak solution to the problem is in $C^{1, \beta}(\bar{\Omega})$. keywords: Elliptic PDE, PS condition, Mountain Pass theorem, Gâteaux derivative.

## 1. Introduction

The study of elliptic PDEs involving fractional $p$-Laplacian operator plays an important role in many field of sciences, like in the field of finance, optimization, electromagnetism, astronomy, water waves, fluid dynamics, probability theory, phase transitions etc. The

[^0]application to Lévy processes in probability theory can be seen in [7, 11] and that in finance can be seen in 50. For further details on applications, one can refer to 51] and the references therein.
In the recent past, a vast investigation has been done for the following local problem.

where $1<p<N, M \geq 0, a: \Omega \rightarrow \mathbb{R}$ is a nonnegative bounded function. For $M=0$, the existence of weak solutions and regularity of solutions for singular problem as in (1.1) has been widely studied in [10, 19, 21, 36, 42] and the references therein. Recently, for $M \neq 0$ the problem (1.1) has been studied to show the existence of multiple solutions in [1, 2, 5, 18, 19, 20, 27, 29, 30, 32, 33] and the references therein. In most of these references, the multiplicity results were proved by the variational methods, Nehari manifold method, perron method, concentration compactness and the moving hyperplane method.
For $p=2, a(x) \equiv 1$ and $M=1$, Haitao [32] used the variational method to show that for $0<\lambda<\Lambda<\infty$, the problem (1.1) has two solutions. For $a(x) \equiv 1$ and $M=1$ Giacomoni \& Sreenadh [30] had studied the problem (1.1) for $1<p<\infty$, to show the existence of atleast two solutions by using shooting method. Later Giacomoni et al. [29] had proved the multiplicity result using the variational method. In [5] the authors showed the multiplicity of solutions using the moving hyperplane method. In [20] the authors applied the concentration compactness method to establish the multiplicity results. The Nehari manifold method is used in [53] to show the existence of multiple solutions.
Recently, the study of nonlocal elliptic PDEs involving singularity with Dirichlet boundary condition has drawn interest by many researchers. The investigation for the existence of weak solutions for a nonlocal elliptic pdes with concave-convex type nonlinearity, i.e. $u^{p}+\lambda u^{q}$, for $p, q>0$ has been extensively studied in [6, 8, 9, 12, 17, 52] and the references therein. The existence results for the Brezis-Nirenberg type problem has been studied in [8, 38, 46]. The eigenvalue problem for fractional $p$-Laplacian and the properties of first and second eigen values can be found in [13, 23, 37].
The following nonlocal problem has been studied by many authors,

\end{align*}

where $N>p s, M \geq 0, a: \Omega \rightarrow \mathbb{R}$ is a nonnegative bounded function. For $p=2$, $M=0, \lambda=1$ and $a(x) \equiv 1$ the problem (1.2) was studied by [22]. In [22] the author had shown that for $0<\gamma<1$, the problem (1.2) has a unique solution $u \in C^{2, \alpha}(\Omega)$ for $0<\alpha<1$. For $1<p<\infty, M=0$ and $\lambda=1$ the problem (1.2) was studied by Canino et al. [16]. For $0<\gamma<1$ and $\lambda=1$, Ghanmi \& Saoudi [26] established the existence of two solutions by Nehari manifold method for fractional Laplacian operator. For $p=2$, $f(x, u)=u^{2_{s}^{*}-1}$, Mukherjee \& Sreenadh [40] studied the problem (1.2) by variational method. Ghanmi \& Saoudi [24] guaranteed the existence of multiple weak solutions to the problem (1.2), for $0<\gamma<1$ and $1<p-1<q \leq p_{s}^{*}$. The authors in [24] have used the Nehari manifold method.
Besides the existence and multiplicity of solutions, the regularity of these solutions for PDEs involving a nonlocal elliptic operator with a power nonlinearity has been studied by Iannizzotto et al [35], K. Saoudi [45]. For the results on the local operator with a power nonlinearity refer to $[15,43]$ and the references therein. The regularity of solution to the PDE involving a local elliptic operator, viz. Laplacian, p-Laplacian, involving singularity and a power nonlinearity has been studied by [28] and [29] respectively. However, to our knowledge there are no investigation on regularity of solutions to a PDE invovling a nonlocal elliptic operator with a singularity and a power nonlinearity. In the present article we will prove the existence of multiple solutions and its regularity for the following nonlocal problem

where $\Omega$ is a open bounded domain of $\mathbb{R}^{N}$ with smooth boundary, $N>p s, s \in(0,1)$, $\lambda>0,0<\gamma<1,1<p<\infty, p-1<q \leq p_{s}^{*}=\frac{N p}{N-p s}$ and $\left(-\Delta_{p}\right)^{s}$ is the fractional $p$-Laplacian operator which is defined as

with $C_{N, s}$, being the normalizing constant.
Similar problems to that in (1.3) has been studied by a few authors like Mukherjee \& Sreenadh [41, Saoudi [44. In [41], the authors established the existence of multiple solutions by using the Nehari manifold method. In [44], for $p=2$ the multiplicity result for the problem (1.3) is proved with the help of the variational method, where the author proved the existence result by converting the nonlocal problem to a local problem.
In this article we show the existence of multiple solutions to the nonlocal problem (1.3)
by combining some variational techniques developed in [3]. We first show the existence of a weak solution using sub-super solution method. To show the existence of a second solution, we use a modified version of the Mountain Pass lemma due to Ambrosetti \& Rabinowitz [3], which can be found in Ghoussoub \& Preiss [31]. We further proved that the weak solution to (1.3) is in $C^{1, \beta}(\bar{\Omega})$ for some $\beta \in(0,1)$.
The article is organised in the following sequence. In Section 2 we give the mathematical formulation with the appropriate functional analytic setup. Section 3 is devoted to establish the existence of a weak solution. In Section 4 we prove the multiplicity of solutions using the Ekeland's variational principle.
The main results proved in this manuscript are the followings

Theorem 1.1. There exists $\Lambda \in(0, \infty)$ such that,
(i) $\forall \lambda \in(0, \Lambda)$, the problem (1.3) has a minimal solution.
(ii) For $\lambda=\Lambda$ the problem (1.3) has atleast one solution.
(iii) $\forall \lambda \in(\Lambda, \infty)$ the problem (1.3) has no solution.

Theorem 1.2. For every $\lambda \in(0, \Lambda)$, the problem (1.3) has multiple solutions.
Theorem 1.3. With the growth conditions of $f$ in tact. Let $u_{0} \in C^{1}(\bar{\Omega})$ satisfying

be a local minimizer of $I$ in $C^{1}(\bar{\Omega})$ topology; that is,

\exists \epsilon>0 \text { such that } u \in C^{1}(\bar{\Omega}),\left\|u-u_{0}\right\|_{C^{1}(\bar{\Omega})}<\epsilon \Rightarrow I\left(u_{0}\right) \leq I(u) .

Then, $u_{0}$ is a local minimum of $I$ in $W_{0}^{s, p}(\Omega)$ also.

## 2. Mathematical formulation and Space setup

This section is entirely devoted to a brief discussion about a few definitions, notations and function spaces which will be used henceforth in this manuscript. We begin by defining the following function space. Let $\Omega \subset \mathbb{R}^{N}$ and $Q=\mathbb{R}^{2 N} \backslash\left(\left(\mathbb{R}^{N} \backslash \Omega\right) \times\left(\mathbb{R}^{N} \backslash \Omega\right)\right)$, then the space $\left(X,\| \|_{X}\right)$ is defined by

equipped with the Gagliardo norm

Here $\|u\|_{p}$ refers to the $L^{p}$-norm of $u$. We further define the space

equiped with the norm

The best Sobolev constant is defined as

We now define a weak solution to the problem defined in (1.3).
Definition 2.1. A function $u \in X_{0}$ is a weak solution to the problem (1.3), if
(i) $u>0, u^{-\gamma} \phi \in L^{1}(\Omega)$ and
(ii) $\int_{Q} \frac{|u(x)-u(y)|^{p-2}(u(x)-u(y))(\phi(x)-\phi(y))}{|x-y|^{N+p s}} d x d y-\int_{\Omega} \frac{\lambda}{u^{\gamma}} \phi-\int_{\Omega} u^{q} \phi=0$
for each $\phi \in X_{0}$.
Following are the definitions of a sub and a super solution to the problem (1.3).
Definition 2.2. A function $\underline{u} \in X_{0}$ is a weak subsolution to the problem (1.3), if
(i) $\underline{u}>0, \underline{u}^{-\gamma} \phi \in L^{1}(\Omega)$ and
(ii) $\int_{Q} \frac{|\underline{u}(x)-\underline{u}(y)|^{p-2}(\underline{u}(x)-\underline{u}(y))(\phi(x)-\phi(y))}{|x-y|^{N+p s}} d x d y-\int_{\Omega} \frac{\lambda}{\underline{u}^{\gamma}} \phi-\int_{\Omega} \underline{u}^{q} \phi \leq 0$
for every nonnegative $\phi \in X_{0}$.
Definition 2.3. A function $\bar{u} \in X_{0}$ is a weak supersolution to the problem (1.3), if
(i) $\bar{u}>0, \bar{u}^{-\gamma} \phi \in L^{1}(\Omega)$ and
(ii) $\int_{Q} \frac{|\bar{u}(x)-\bar{u}(y)|^{p-2}(\bar{u}(x)-\bar{u}(y))(\phi(x)-\phi(y))}{|x-y|^{N+p s}} d x d y-\int_{\Omega} \frac{\lambda}{\bar{u}^{\gamma}} \phi-\int_{\Omega} \bar{u}^{q} \phi \geq 0$
for all nonnegative $\phi \in X_{0}$.

We now list out the embedding results in the form of a Lemma pertaining to the function space $X_{0}$ [47, 48].

Lemma 2.4. The following embedding results holds for the space $X_{0}$.

1. If $\Omega$ has a Lipshitz boundary, then the embedding $X_{0} \hookrightarrow L^{q}(\Omega)$ for $q \in\left[1, p_{s}^{*}\right)$, where $p_{s}^{*}=\frac{N p}{N-p s}$.
2. The embediing $X_{0} \hookrightarrow L^{p_{s}^{*}}(\Omega)$ is continuous.

The main goal achieved in this article is the existence of two distinct, positive weak solutions to the problem (1.3) in $X_{0}$. To establish that we will engage ourselves to find the existence of two distinct critical points to the following energy functional, $I_{\lambda}: X_{0} \rightarrow \mathbb{R}$ defined as

I_{\lambda}(u)=\frac{1}{p} \int_{Q} \frac{|u(x)-u(y)|^{p}}{|x-y|^{N+p s}} d x d y-\frac{\lambda}{1-\gamma} \int_{\Omega}\left(u^{+}\right)^{1-\gamma} d x-\frac{1}{q+1} \int_{\Omega}\left(u^{+}\right)^{q+1} d x .
$$

Here, $u^{+}=\max \{u, 0\}$ and $u^{-}=\max \{-u, 0\}$. It is easy to observe that $I_{\lambda}$ is not $C^{1}$ due the presence of the singular term in it. Therefore the usual approach by Mountain Pass lemma [3] fails. So, we will proceed with a cut off functional argument as in Ghoussoub \& Preiss [31. Let us define

## 3. Main results

We begin this section with the following two comparison results.
Lemma 3.1 (Weak Comparison Principle). Let $u, v \in X_{0}$. Suppose, $\left(-\Delta_{p}\right)^{s} v-\frac{\lambda}{v^{\gamma}} \geq$ $\left(-\Delta_{p}\right)^{s} u-\frac{\lambda}{u^{\gamma}}$ weakly with $v=u=0$ in $\mathbb{R}^{N} \backslash \Omega$. Then $v \geq u$ in $\mathbb{R}^{N}$.
Proof. Since, $\left(-\Delta_{p}\right)^{s} v-\frac{\lambda}{v^{\gamma}} \geq\left(-\Delta_{p}\right)^{s} u-\frac{\lambda}{u^{\gamma}}$ weakly with $u=v=0$ in $\mathbb{R}^{N} \backslash \Omega$, we have

In particular choose $\phi=(u-v)^{+}$. To this choice, the inequlity in (3.1) looks as follows.

Let $\psi=u-v$. The identity

with $a=v(x)-v(y), b=u(x)-u(y)$ gives

We choose the test function $\phi=(u-v)^{+}$. We express,

to further obtain

The equation in (3.6) implies

& =-(p-1) \frac{Q(x, y)}{|x-y|^{N+s p}}\left(\psi^{+}(x)-\psi^{+}(y)\right)^{2} \\
& \geq 0 . \tag{3.7}
\end{align*}

This leads to the conclusion that the Lebesgue measure of $\Omega^{+}$, i.e., $\left|\Omega^{+}\right|=0$. In other words $v \geq u$ a.e. in $\Omega$.

Lemma 3.2. Consider the problem

where $f \in L^{\infty}(\Omega)$ and $g \in W^{s, p}\left(\mathbb{R}^{N}\right)$. If $u \in W^{s, p}\left(\mathbb{R}^{N}\right)$ is a weak super-solution of (3.8) with $f=0$ and $g \geq 0$, then $u \geq 0$ a.e. and admits a lower semicontinuous representation in $\Omega$.

Proof. We first show that $u \geq 0 \in W^{s, p}\left(\mathbb{R}^{N}\right)$. We already have $u=g \geq 0$ in $\mathbb{R}^{N} \backslash \Omega$. Thus by an elementary inequality $(a-b)\left(a_{-}-b_{-}\right) \leq-\left(a_{-}-b_{-}\right)^{2}$ we have

From (3.9) we have $u \geq 0$ a.e. in $\Omega$.
We now define the following

\end{equation*}

Cleary $u^{*} \geq 0$ a.e. in $\Omega$ since $u \geq 0$ a.e. in $\Omega$. Let $x_{0} \in \Omega$ be a Lebesgue point. By the definition of a Lebesgue point we have

We now prove the reverse inequality, i.e. $u \leq u^{*}$ a.e. in $\Omega$. Consider the function $-u$, which serves as a weak subsolution to (3.8), with $k=u\left(x_{0}\right)$ to obtain

Passing the limit $r \rightarrow 0^{+}$, we have

since, $x_{0} \in \Omega$ is a Lebesgue point. Also by the Hölder's inequality we have

& \times\left(\int_{\mathbb{R}^{N} \backslash B_{r}\left(x_{0}\right)} \frac{1}{\left|x_{0}-x\right|^{N+p s}} d x d y\right)^{1 / q} \\
& \leq C r^{s}\left(\int_{\mathbb{R}^{N}} \frac{\left|u\left(x_{0}\right)-u(x)\right|^{p}}{\left|x-x_{0}\right|^{N+p s}} d x\right)^{1 / p} \rightarrow 0 \text { as } r \rightarrow 0^{+} . \tag{3.14}
\end{align*}
$$

Thus we have

\end{equation*}

This implies $u^{*}\left(x_{0}\right) \geq u\left(x_{0}\right)$ for every Lebesgue point in $\Omega$ and hence for almost all $x \in \Omega$. From (3.11) and (3.15), we obtain the lower semicontinuous representation of $u$.

Corollary 3.3 (Strong Maximum Principle). Let $u \in X_{0}$. Suppose $u \geq 0 \in \mathbb{R}^{N} \backslash \Omega$ and for all $\phi \in X_{0}$ with $\phi \geq 0$, we have

\int_{Q} \frac{|u(x)-u(y)|^{p-2}(u(x)-u(y))}{|x-y|^{N+p s}}(\phi(x)-\phi(y)) d x d y \geq 0 .
$$

Then $u$ has a lower semicontinuous representation in $\Omega$, such that either $u \equiv 0$ or $u>0$.

Proof. See Lemma 2.3 of [39].

### 3.1 Existence of weak solutions

We begin the section by considering the problem

We now state an existence result due to [16].
Lemma 3.4. Assume $0<\gamma<1$ and $\lambda>0$. Then the problem (3.16) has a unique solution, $\underline{u}_{\lambda} \in W_{0}^{1, p}(\Omega)$, such that for every $K \subset \subset \Omega$, ess.inf $\underline{u}_{\lambda}>0$.

With this Lemma in consideration, we now prove our first major theorem.
Lemma 3.5. Assume $0<\gamma<1<q \leq p_{s}^{*}-1$. Then $0<\Lambda<\infty$.
Proof. Define,

\bar{f}(x, t)= \begin{cases}f(t), & \text { if } t>\bar{u}_{\lambda} \\ f\left(\underline{u}_{\lambda}\right), & \text { if } t \leq \underline{u}_{\lambda}\end{cases}
$$

where, $f(u)=\frac{\lambda}{u^{\gamma}}+u^{q}$ and $\underline{u}_{\lambda}$ is the solution to (3.16). Let $\bar{F}(x, s)=\int_{0}^{s} \bar{f}(x, t) d s$, $\lambda>0$. Define a function $\bar{I}_{\lambda}: X_{0} \rightarrow \mathbb{R}$ as follows.

\bar{I}_{\lambda}(u)=\frac{1}{p} \int_{Q} \frac{|u(x)-u(y)|^{p}}{|x-y|^{N+p s}} d x d y-\int_{\Omega} \bar{F}(x, u) d x \tag{3.17}
\end{equation*}
$$

The functional is $C^{1}$ (refer to Lemma 6.4 in the Appendix) and weakly lower semicontinuous. From the Hölder's inequality and Lemma (2.4), we obtain

$$
\begin{aligned}
\bar{I}_{\lambda}(u) & =\frac{1}{p}\|u\|^{p}-\int_{\Omega} \bar{F}(x, u) d x \\
& \geq \frac{1}{p}\|u\|^{p}-\lambda c_{1}\|u\|^{1-\gamma}-c_{2}\|u\|^{q+1}
\end{aligned}
$$

where, $c_{1}, c_{2}$ are constants. We choose $r>0$ small enough and $\lambda>0$ sufficiently small so that the term $\frac{1}{2}\|u\|^{2}-\lambda c_{1}\|u\|^{1-\gamma}-c_{2}\|u\|^{q+1}>0$. Thus we have a pair of $(\lambda, r)$ such that

\min _{u \in \partial B_{r}}\left\{\bar{I}_{\lambda}(u)\right\}>0 .
$$

Now, for $\phi>0 \in X_{0}$, we have

\begin{equation*}
\bar{I}_{\lambda}(\phi)=\frac{|t|^{p}}{p}\|\phi\|^{p}-\frac{|t|^{1-\gamma}}{1-\gamma} \int_{\Omega}|\phi|^{1-\gamma} d x-\frac{|t|^{q+1}}{q+1} \int_{\Omega}|\phi|^{q+1} d x . \tag{3.18}
\end{equation*}
$$

The above equation (3.18) holds since $1-\gamma<1<q+1$. Thus $\bar{I}_{\lambda}(t \phi) \rightarrow-\infty$ as $t \rightarrow \infty$. Therefore we have $\inf _{\|u\|_{0} \leq r} \bar{I}_{\lambda}(u)=c<0$. By the definition of infimum, we consider a minimizing sequence $\left\{u_{n}\right\}$ for $c$. By the reflexivity of $X_{0}$ there exists a subsequence, still denoted by $\left\{u_{n}\right\}$, which weakly converges to, say, $u$. such that

& u_{n} \rightarrow u \text { weakly in } L^{p_{s}^{*}}(\Omega) \\
& u_{n} \rightarrow u \text { strongly in } L^{r}(\Omega) \text { for } 1 \leq r<p_{s}^{*} \\
& u_{n} \rightarrow u \text { pointwise a.e. in } \Omega . \tag{3.19}
\end{align*}
$$

Therefore, by the Brezis-Lieb lemma [14], we get

$$
\begin{align*}
\left\|u_{n}\right\|^{p} & =\|u\|^{p}+\left\|u_{n}-u\right\|^{p}+o(1) \\
\left\|u_{n}\right\|_{q+1}^{q+1} & =\|u\|_{q+1}^{q+1}+\left\|u_{n}-u\right\|^{q+1}+o(1) . \tag{3.20}
\end{align*}
$$

On using the Hölder's inequality and passing the limit $n \rightarrow \infty$, we obtain

$$
\begin{align*}
\int_{\Omega} u_{n}^{1-\gamma} d x & \leq \int_{\Omega} u^{1-\gamma} d x+\int_{\Omega}\left|u_{n}-u\right|^{1-\gamma} d x \\
& \leq \int_{\Omega} u^{1-\gamma} d x+c_{1}\left\|u_{n}-u\right\|_{p}^{1-\gamma} \\
& =\int_{\Omega} u^{1-\gamma} d x+o(1) . \tag{3.21}
\end{align*}
$$

Therefore, on similar lines, we have

$$
\begin{align*}
\int_{\Omega} u^{1-\gamma} d x & \leq \int_{\Omega} u_{n}^{1-\gamma} d x+\int_{\Omega}\left|u_{n}-u\right|^{1-\gamma} d x \\
& \leq \int_{\Omega} u_{n}^{1-\gamma} d x+c_{1}\left\|u_{n}-u\right\|_{p}^{1-\gamma} \\
& =\int_{\Omega} u^{1-\gamma} d x+o(1) . \tag{3.22}
\end{align*}
$$

Combining (3.21) and (3.22), we obtain the following

\int_{\Omega} u_{n}^{1-\gamma} d x=\int_{\Omega} u^{1-\gamma} d x+o(1) \tag{3.23}
\end{equation*}
$$

Thus, clubbing equations (3.20), (3.21) and (3.22), we deduce that

\bar{I}_{\lambda}\left(u_{n}\right)=\bar{I}_{\lambda}(u)+\frac{1}{p}\left\|u_{n}-u\right\|^{p}-\frac{1}{q+1}\left\|u_{n}-u\right\|_{q+1}^{q+1}+o(1) . \tag{3.24}
\end{equation*}
$$

We also observe from (3.20) that for $n$ sufficiently large $u, u_{n}-u \in B_{r}$ and $\frac{1}{p} \| u_{n}-$ $u\left\|^{p}-\frac{1}{q+1}\right\| u_{n}-u \|_{q+1}^{q+1} \geq o(1)$. Since $r>0$ was chosen to be sufficiently small, we have

& \frac{1}{p}\left\|u_{n}-u\right\|^{p}-\frac{1}{q+1}\left\|u_{n}-u\right\|_{q+1}^{q+1}>0 \text { on } \partial B_{r} \\
& \frac{1}{p}\left\|u_{n}-u\right\|^{p}-\frac{1}{q+1}\left\|u_{n}-u\right\|_{q+1}^{q+1} \geq 0 \text { in } B_{r} . \tag{3.25}
\end{align*}
$$

As a consequence, we can conclude that

\begin{equation*}
\frac{1}{p}\left\|u_{n}-u\right\|^{p}-\frac{1}{q+1}\left\|u_{n}-u\right\|_{q+1}^{q+1} \geq o(1) \tag{3.26}
\end{equation*}
$$

Therefore on passing the limit $n \rightarrow \infty$ to (3.24), we obtain $\bar{I}_{\lambda}\left(u_{n}\right) \geq \bar{I}_{\lambda}(u)+o(1)$. Since $\inf _{\|u\|_{X_{0}} \leq r} \bar{I}_{\lambda}(u)=c$ we have $u \neq 0$ which is a minimizer of $\bar{I}_{\lambda}$ over $X_{0}$. Thus we have

\left(-\Delta_{p}\right)^{s} u & =f(x, u) \text { in } \Omega \\
u & >0 \text { in } \Omega \\
u & =0 \text { in } \mathbb{R}^{N} \backslash \Omega . \tag{3.27}
\end{align*}
$$

By the comparison principle (refer to lemma 3.1 in the Appendix) of fractional $p$ Laplacian we conclude that $\bar{u}_{\lambda} \leq u$ in $\Omega$. Thus $\Lambda>0$ since the choice $\lambda>0$ has been made.
We now claim that $\Lambda<\infty$. We let $\lambda_{1}$ to denote the principal eigenvalue of $\left(-\Delta_{p}\right)^{s}$ in $\Omega$ and let $\phi_{1}>0$ be the associated eigenfunction. In other words, we have

\begin{align*}
\left(-\Delta_{p}\right)^{s} \phi_{1} & =\lambda_{1}\left|\phi_{1}\right|^{p-2} \phi_{1} \text { in } \Omega, \\
\phi_{1} & >0 \text { in } \Omega \\
\phi & =0 \text { in } \mathbb{R}^{N} \backslash \Omega . \tag{3.28}
\end{align*}
$$

We choose, $\phi_{1}$ as a test function in the weak formulation of (1.3), to get

\begin{align*}
\lambda_{1} \int_{\Omega} u\left|\phi_{1}\right|^{p-2} \phi_{1} d x & =\int_{\Omega}\left(-\Delta_{p}\right)^{s} \phi_{1} u d x \\
& =\int_{\Omega}\left(\frac{\lambda}{u^{\gamma}}+u^{q}\right) \phi_{1} d x . \tag{3.29}
\end{align*}
$$

Let $\tilde{\Lambda}$ be any constant such that $\tilde{\Lambda} t^{-\gamma}+t^{q}>p \lambda_{1} t, \forall t>0$. This leads to a contradiction to the equation (3.29). Hence we conclude that $\Lambda<\infty$.

Lemma 3.6. Let $0<\gamma<1$. Suppose that $\underline{u}$ is a weak subsolution while $\bar{u}$ is a weak supersolution to the problem (1.3) such that $\underline{u} \leq \bar{u}$, then for every $\lambda \in 0, \Lambda$ ) there exists a weak solution $u_{\lambda}$ such that $\underline{u} \leq u_{\lambda} \leq \bar{u}$ a.e. in $\Omega$. This $u_{\lambda}$ is a local minimizer of $\bar{I}_{\lambda}$ defined over $X_{0}$.

Proof. We begin by showing that $\underline{u} \leq \bar{u}$. For this let us consider the problem (1.3). Let $\mu \in(0, \Lambda)$. By the definition of $\Lambda$, there exists $\lambda_{0} \in(\mu, \Lambda)$ such that (1.3) with $\lambda=\lambda_{0}$ has a solution by the Lemma [3.5, say $u_{\lambda_{0}}$. Then $\bar{u}=u_{\lambda_{0}}$ happens to be a supersolution of the problem (1.3). Consider the function $\phi_{1}$ an eigenfunction of $\left(-\Delta_{p}\right)^{s}$ corresponding to the smallest eigenvalue $\lambda_{1}$. Thus $\phi_{1} \in L^{\infty}(\Omega)$ 37] and

$$
\begin{align*}
\left(-\Delta_{p}\right)^{s} \phi_{1} & =\lambda_{1}\left|\phi_{1}\right|^{p-2} \phi_{1} \\
\phi_{1} & >0 \text { in } \Omega \\
\phi_{1} & =0 \text { in } \mathbb{R}^{N} \backslash \Omega . \tag{3.30}
\end{align*}
$$

Choose, $t>0$ such that $t \phi_{1} \leq \bar{u}$ and $t^{p+q-1} \phi_{1}^{p+q-1} \leq \frac{\lambda}{\lambda_{1}}$. On defining $\underline{u}=t \phi_{1}$ we have

$$
\begin{align*}
\left(-\Delta_{p}\right)^{s} \underline{u} & =\lambda_{1} t^{p-1} \phi_{1}^{p-1} \\
& \leq \lambda t^{-q} \phi_{1}^{-q}+t^{\alpha} \phi_{1}^{\alpha} \\
& =\lambda \underline{u}^{-q}+\underline{u}^{\alpha} \tag{3.31}
\end{align*}
$$

i.e., $\underline{u}$ is a subsolution of the problem (1.3). This implies that $\underline{u} \leq \bar{u}$.

We now show the existence of a $u_{\lambda}$. For this, we define

$$
\tilde{f}(x, t)= \begin{cases}f_{\lambda}(x, \bar{u}), & \text { if } t \geq \bar{u} \\ f_{\lambda}(x, t), & \text { if } \underline{u} \leq t \leq \bar{u} \\ f_{\lambda}(x, \underline{u}), & \text { if } t \leq \underline{u}\end{cases}
$$

We further define $\tilde{I}(u)=\frac{1}{p}\|u\|^{p}-\int_{\Omega} \tilde{F}(x, u) d x$, where $\tilde{F}(x, t)=\int_{0}^{t} \tilde{f}(x, s) d s$. Let $u_{\lambda}$ be a global minimizer of the functional $\tilde{I}$ due to the definition of $\tilde{f}$. We first observe that the $C^{1}$ functional $\tilde{I}$ is sequentially weakly lower semicontinuous and coercive. This can be seen from the dominated convergence theorem and the Sobolev embedding. Due to the monotonicity of $\tilde{f}$ we have,

\left(-\Delta_{p}\right)^{s}\left(\bar{u}-u_{\lambda}\right) & \geq f(x, \bar{u})-\tilde{f}(x, \bar{u}) \\
& \geq 0 \text { in } \Omega \tag{3.32}
\end{align*}
$$

along with $\bar{u}-u_{\lambda} \geq 0$, in $\mathbb{R}^{N} \backslash \Omega$. We now refer to a result proved in the Lemma 3.2 in the Appendix that $\bar{u}-u_{\lambda} \geq 0$ and is a weak supersolution to the problem (1.3).

On using the Lemma 2.7 in [35], we have $\frac{\bar{u}-u_{\lambda}}{\delta^{s}} \geq c_{2}>0$ in $\bar{\Omega}$. Similarly we prove $\frac{u_{\lambda}-\underline{u}}{\delta^{s}} \geq c_{2}>0$ in $\bar{\Omega}$. Then $u_{\lambda}$ is a weak solution to the problem (1.3).
Now, we prove that $u_{\lambda}$ is a local minimizer of $\bar{I}_{\lambda}$. Due to Theorem 4.4 in [34], we have $u_{\lambda} \in C_{s}^{0}(\Omega)$. Thus for any $u \in B_{\frac{c_{2}}{2}}^{\delta}\left(u_{\lambda}\right)$, we obtain $\frac{\bar{u}-u}{\delta^{s}}=\frac{\bar{u}-u_{\lambda}}{\delta^{s}}+\frac{u_{\lambda}-u}{\delta^{s}} \geq c_{2}-\frac{c_{2}}{2}$ in $\bar{\Omega}$. Hence, by the maximum principle we get $\bar{u}-u_{\lambda}>0$ in $\Omega$. using similar argument, it follows that $\underline{u}-u_{\lambda}>0$ in $\Omega$. Therefore, $\tilde{I}$ and $\bar{I}_{\lambda}$ becomes identical over $B_{\frac{c_{2}}{2}}^{\delta}\left(u_{\lambda}\right) \cap X_{0}$. Further we have $u_{\lambda}$ is local minimizer of $\bar{I}_{\lambda}$ in $C_{s}^{0}(\Omega) \cap X_{0}$. Hence, Theorem 1.1 in [35], implies that $u_{\lambda}$ is a local minimizer of $\bar{I}_{\lambda}$.

We now prove the following theorem.
Theorem 3.7. The problem in (1.3) has at least one solution if $\lambda=\Lambda$.
Proof. Consider an increasing sequence $\left\{\lambda_{n}\right\}$, which converges to $\Lambda$, as $n \rightarrow \infty$. Let $u_{n}=u_{\lambda_{n}}$ be a weak solution to the problem (1.3) for $\lambda=\lambda_{n}$. Thus

\begin{gather*}
\int_{Q} \frac{\left|u_{n}(x)-u_{n}(y)\right|^{p-2}\left(u_{n}(x)-u_{n}(y)\right)(\phi(x)-\phi(y))}{|x-y|^{N+p s}} d x d y \\
\quad-\lambda_{n} \int_{\Omega} u_{n}^{-\gamma} \phi d x-\int_{\Omega} u_{n}^{q} \phi d x=0, \forall \phi \in X_{0} \tag{3.33}
\end{gather*}
$$

Hence putting $\phi=u_{n}$, we have

$$
\begin{equation*}
\int_{Q} \frac{\left|u_{n}(x)-u_{n}(y)\right|^{p}}{|x-y|^{N+p s}} d x d y-\lambda_{n} \int_{\Omega} u_{n}^{1-\gamma} d x-\int_{\Omega} u_{n}^{q+1} d x=0 \tag{3.34}
\end{equation*}
$$

From the Lemma 3.6, the energy functional

$$
\begin{align*}
I\left(u_{n}\right) & =\frac{1}{p} \int_{Q} \frac{\left|u_{n}(x)-u_{n}(y)\right|^{p}}{|x-y|^{N+p s}} d x d y-\frac{\lambda_{n}}{1-\gamma} \int_{\Omega} u_{n}^{1-\gamma} d x-\frac{1}{q+1} \int_{\Omega} u_{n}^{q+1} d x \\
& \leq B \tag{3.35}
\end{align*}
$$

for every $0<\gamma<1$. Using (3.34) in (3.35) we get

$$
\begin{equation*}
\frac{1}{p}\left(\lambda_{n} \int_{\Omega} u_{n}^{1-\gamma} d x+\int_{\Omega} u_{n}^{q+1} d x\right)-\frac{\lambda_{n}}{1-\gamma} \int_{\Omega} u_{n}^{1-\gamma} d x-\frac{1}{q+1} \int_{\Omega} u_{n}^{q+1} d x \leq B \tag{3.36}
\end{equation*}
$$

From (3.36) we get

$$
\begin{equation*}
\left(\frac{1}{p}-\frac{1}{q+1}\right) \int_{\Omega} u_{n}^{q+1} d x \leq B+\lambda_{n}\left(\frac{1}{1-\gamma}-\frac{1}{p}\right) \int_{\Omega} u_{n}^{1-\gamma} d x \tag{3.37}
\end{equation*}
$$

Using (3.37) in (3.34) we obtain

$$
\begin{equation*}
\left\|u_{n}\right\|_{X_{0}}^{p-1+\gamma} \leq A_{1}+\frac{A_{2}}{\left\|u_{n}\right\|_{X_{0}}^{1-\gamma}} . \tag{3.38}
\end{equation*}
$$

From the inequality in (3.38), it is easy to see that $\sup _{n \in \mathbb{N}}\left\|u_{n}\right\|_{X_{0}}<\infty$. Thus by the reflexivity of $X_{0}$, we have a subsequence, which will still be denoted by $\left\{u_{n}\right\}$, such that $u_{n} \rightharpoonup u$ weakly in $X_{0}$, as $n \rightarrow \infty$. This establishes that $u$ is a weak solution corresponding to $\Lambda$.

We now prove a corollary based on the Theorem 3.7.
Corollary 3.8. Let $1<q \leq p_{s}^{*}-1,0<\gamma<1$ and $0<\lambda \leq \Lambda$. Then there exists $a$ smallest solution in $X_{0}$ to the problem (1.3).

Proof. From Lemma [3.6, we guarantee the existence of a weak solution $u_{\lambda}$ to the problem (1.3) for $\lambda \in(0, \Lambda)$. We now define a sequence $\left\{v_{n}\right\}$ by the following iterative sequence of problems. Define $v_{1}=\underline{u}$, a subsolution of (1.3). The remaining terms of the sequence can be defined by the following iterative scheme.

\begin{align*}
\left(-\Delta_{p}\right)^{s} v_{n}-\frac{\lambda}{v_{n}^{\gamma}} & =v_{n-1}^{q} \text { in } \Omega \\
v_{n} & >0 \text { in } \Omega \\
v_{n} & =0 \text { in } \mathbb{R}^{N} \backslash \Omega \tag{3.39}
\end{align*}
$$

for each $n \in \mathbb{N}$. By the choice of $v_{1}$ we have $v_{1} \leq u$, where $u$ is a weak solution to (1.3), whose existence is again attributed to the Lemma 3.6, By the weak comparison principle (refer Lemma 3.1 in the Appendix), it is clear that $v_{1} \leq v_{2} \leq \ldots \leq u$. Owing to the Theorem 6.4 in [40], we have $u$ is in $L^{\infty}(\Omega)$, which further implies that the sequence $\left\{v_{n}\right\}$ is bounded in $X_{0}$. Thus we have a subsequence such that $v_{n} \rightharpoonup \hat{u}$. To conclude that $\hat{u}$ is the minimal solution, we let $\hat{v}$ to be a solution to (1.3). We have $v_{n} \leq \hat{v}$ which on passing the limit $n \rightarrow \infty$ we get $\hat{u} \leq \hat{v}$.

## $3.2 C^{1}$ versus $W^{s, p}$ local minimizers of the energy

The following lemma is useful to prove the multiplicity of solutions. More precisely, we now turn our attention to the main theorem.

Theorem 3.9. With the growth conditions of $f$ in tact. Let $u_{0} \in C^{1}(\bar{\Omega})$ satisfying

$$
\begin{equation*}
u_{0} \geq \eta d(x, \partial \Omega) \text { for some } \eta>0 \tag{3.40}
\end{equation*}
$$

be a local minimizer of $I$ in $C^{1}(\bar{\Omega})$ topology; that is,

$$
\exists \epsilon>0 \text { such that } u \in C^{1}(\bar{\Omega}),\left\|u-u_{0}\right\|_{C^{1}(\bar{\Omega})}<\epsilon \Rightarrow I\left(u_{0}\right) \leq I(u) .
$$

Then, $u_{0}$ is a local minimum of $I$ in $W_{0}^{s, p}(\Omega)$ also.

For proving Theorem 3.9, we will need uniform $L^{\infty}$-estimates for a family of solutions to $\left(P_{\epsilon}\right)$ as below.

Theorem 3.10. Let $\left\{u_{\epsilon}\right\}_{\epsilon \in(0,1)}$ be a family of solutions to $\left(\mathrm{P}_{\epsilon}\right)$, where $u_{0}$ satisfies (3.40) and solves $(\mathrm{P})$; let $\sup _{\epsilon \in(0,1)}\left(\left\|u_{\epsilon}\right\|_{W_{0}^{s, p}(\Omega)}\right)<\infty$. Then, there exists $C_{1}, C_{2}>0$ (independent of $\epsilon$ ) such that

$$
\sup _{\epsilon \in(0,1)}\left\|u_{\epsilon}\right\|_{L^{\infty}(\Omega)}<\infty \text { and } C_{1} d(x, \partial \Omega) \leq u_{\epsilon} \leq C_{2} d(x, \partial \Omega)
$$

The proof of the above theorem is a consequence of the results proved in section .
Proof. Let $K \Subset \Omega$. We divide the proof into two cases.
Case 1: subcritical case when $q<p_{s}^{*}-1$.
We prove by contradiction, i.e. suppose $u_{0}$ is not a local minimizer. Let $r \in\left(q, p_{s}^{*}-1\right)$ and define

\begin{equation*}
K(w)=\frac{1}{r+1} \int_{K}\left|w-u_{0}\right|^{r+1} d x,\left(w \in W^{s, p}(K)\right) \tag{3.41}
\end{equation*}
$$

Case $i$ : $K\left(v_{\epsilon}\right)<\epsilon$.
Define $S_{\epsilon}=\left\{v \in W_{0}^{s, p}(\Omega): 0 \leq K(v) \leq \epsilon\right\}$. Consider the problem $I_{\epsilon}=\inf _{v \in S_{\epsilon}}\{I(v)\}$. The infimum exists since the set $S_{\epsilon}$ is bounded and the functional $I$ is $C^{1}$. In addition, $I$ is also w.l.s.c. and $S_{\epsilon}$ is closed, convex. Thus $I_{\epsilon}$ is actually attained, at say $v_{\epsilon} \in S_{\epsilon}$, and $I_{\epsilon}=I\left(v_{\epsilon}\right)<I\left(u_{0}\right)$.
Claim: We will now show that $\exists \eta>0$ such that $v_{\epsilon} \geq \eta \phi_{1}$.
Proof: The proof is again by contradiction., i.e. $\forall \eta>0$ let $\left|\Omega_{\eta}\right|=\left|\operatorname{supp}\left\{\left(\eta \phi_{1}-v_{\epsilon}\right)^{+}\right\}\right|>$ 0 . Define $v_{\eta}=\left(\eta \phi_{1}-v_{\epsilon}\right)^{+}$. For $0<t<1$ define $\xi(t)=I\left(v_{\epsilon}+v_{\eta}\right)$. Thus

\xi^{\prime}(1) & =\left\langle I^{\prime}\left(v_{\epsilon}+v_{\eta}\right), v_{\eta}\right\rangle \\
& =\left\langle I^{\prime}\left(\eta \phi_{1}\right), v_{\eta}\right\rangle  \tag{3.43}\\
& =\left\langle\left(-\Delta_{p}\right)^{s}\left(\eta \phi_{1}\right)-\left(\eta \phi_{1}\right)^{-\alpha}-f\left(x, \eta \phi_{1}\right), v_{\eta}\right\rangle<0
\end{align*}
$$

for sufficiently small $\eta>0$. Moreover,

-\xi^{\prime}(1)+\xi^{\prime}(t) & =\left\langle\left(-\Delta_{p}\right)^{s}\left(v_{\epsilon}+t v_{\eta}\right)-\left(-\Delta_{p}\right)^{s}\left(v_{\epsilon}+v_{\eta}\right)\right. \\
& \left.+\left(\left(v_{\epsilon}+v_{\eta}\right)^{-\alpha}-\left(v_{\epsilon}+t v_{\eta}\right)^{-\alpha}\right)+\left(f\left(x, v_{\epsilon}+v_{\eta}\right)-f\left(x, v_{\epsilon}+t v_{\eta}\right)\right), v_{\eta}\right\rangle \tag{3.44}
\end{align*}
$$

Since $s^{-\alpha}+f(x, s)$ is a uniformly nonincreasing function with respect to $x \in \Omega$ for sufficiently small $s>0$. Also from the monotonicity of $\left(-\Delta_{p}\right)^{s}$ we have, for sufficiently small $\eta>0,0 \leq \xi^{\prime}(1)-\xi^{\prime}(t)$. From the Taylor series expansion and the fact that $K\left(v_{\epsilon}\right)<\epsilon$ we have $\exists 0<\theta<1$ such that

Thus for $t=\theta$ we have $\xi^{\prime}(\theta) \geq 0$ which is a contradicton to $\xi^{\prime}(\theta) \leq \xi^{\prime}(1)<0$ as obtained above. Thus $v_{\epsilon} \geq \eta \phi_{1}$ for some $\eta>0$. In fact from the Lemma 5.5, 5.6 we have $\sup _{\epsilon \in(0,1]}\left\{\left\|u_{\epsilon}\right\|_{C^{1, \alpha}(\bar{\Omega})}\right\} \leq C$. By the compact embedding $\left.C^{1, \alpha}(\bar{\Omega}) \hookrightarrow C^{1, \kappa} \bar{\Omega}\right)$, for any $\kappa<\alpha$, we have $u_{\epsilon} \rightarrow u_{0}$ which contradicts the assumption made.
Case ii: $K\left(v_{\epsilon}\right)=\epsilon$
In this case, from the Lagrange multiplier rule we have $I^{\prime}\left(v_{\epsilon}\right)=\mu_{\epsilon} K\left(v_{\epsilon}\right)$. We will first show that $\mu_{\epsilon} \leq 0$. Suppose $\mu_{\epsilon}>0$, then $\exists \phi \in X$ such that

which is a contradiction to $v_{\epsilon}$ being a minimizer of $I$ in $S_{\epsilon}$.
Case $i$ : $\left(\mu_{\epsilon} \in(-l, 0)\right.$ where $\left.l>-\infty\right)$.
Consider the sequence of problems

where $\gamma\left(\mu_{\epsilon}, x, t\right)=t^{-\alpha}+f(x, t)+\mu_{\epsilon}\left|t-u_{0}\right|^{r-1}\left(t-u_{0}\right)$. From the weak comparison principle we have $v_{\epsilon} \leq \eta \phi_{1}$ for some $\eta>0$ small enough, independent of $\epsilon$. This is beacuse $\eta \phi_{1}$ is a strict subsolution to $P_{\epsilon}$. Further, since $-l \leq \mu_{\epsilon} \leq 0$, there exists $M$, $c$ such that

Therefore $\exists L>0$ such that $\eta \phi_{1} \leq v_{\epsilon} \leq L \phi_{1}$. By using the arguments previously used, we end up getting $\left|v_{\epsilon}\right|_{C^{\alpha}(\bar{\Omega})} \leq C^{\prime}$. The conclusion follows as in the previous case of $K(v)<\epsilon$. Case ii: $\inf _{\mu_{\epsilon}}=-\infty$
Let us assume $\mu_{\epsilon} \leq-1$. As above, we can similarly obtain $v_{\epsilon \phi_{1}}$ for $\eta>0$ small enough
and independent of $\epsilon$. Further, there exists a constant $M>0$ such that $\gamma(s, x, t)<0$ $\forall(s, x, t) \in(-\infty,-1] \times \Omega \times(M, \infty)$.
Then from the weak comparison principle on $\left(-\Delta_{p}\right)^{s}$, we gate $v_{\epsilon} \leq M$ for $\epsilon>0$ sufficiently small. Since $u_{0}$ is a local $C^{1}$ - minimizer, $u_{0}$ is a weak solution to (P) and hence

$\forall \phi \in C_{c}^{\infty}(\Omega)$. In fact from lemma (to be written next) we have for every function $w \in W_{0}^{s, p}(\Omega), u_{0}$ satisfies

On subtracting the relations, i.e. (3.50)-(3.49) and testing with $w=\left|v_{\epsilon}-u_{0}\right|^{\beta}-1\left(v_{\epsilon}-\right.$ $u_{0}$ ), where $\beta \geq 1$, we obtain

& =\int_{\Omega}\left(f\left(x, v_{\epsilon}\right)-f\left(x, u_{0}\right)\right)\left|v_{\epsilon}-u_{0}\right|^{\beta}-1\left(v_{\epsilon}-u_{0}\right) d x  \tag{3.51}\\
& +\mu_{\epsilon} \int_{\Omega}\left|v_{\epsilon}-u_{0}\right|^{\beta+r} d x .
\end{align*}

By Hölder's inequality and the bounds of $v_{\epsilon}, u_{0}$ we get

Here $C$ is independent of $\epsilon$ and $\beta$. On passing the limit $\beta \rightarrow \infty$ we get $-\mu_{\epsilon}\left\|v_{\epsilon}-u_{0}\right\|_{\infty} \leq$ $C$. Working on similar lines we end up getting $v_{\epsilon}$ is bounded in $C^{\alpha}(\bar{\Omega})$ independent of $\epsilon$ and the conclusion follows. This marks an end to the subcritical case.

Case 2: $q=p_{s}^{*}-1$
The proof again follows by contradiction, i.e. we assume that the conclusion of the Theorem is untrue. Let

$$

where $f_{j}(x, u)=f\left(x, T_{j}(s)\right)$ and

T_{j}(s)= \begin{cases}-j & s \leq-j \\ s & -j \leq s \leq j \\ j & s \geq j\end{cases}
$$

By the 'Lebesgue theorem' we have, for any $v \in W_{0}^{s, p}(\Omega), I_{j}(v) \rightarrow I(v)$ as $j \rightarrow \infty$. It follows from the truncation and this convergence that for each $\epsilon>0$, there is some $j_{\epsilon}$ (with $j_{\epsilon} \rightarrow \infty$ as $\epsilon \rightarrow 0^{+}$) such that $I_{j_{\epsilon}}\left(v_{\epsilon}\right) \leq I\left(v_{\epsilon}\right) \leq I\left(u_{0}\right)$.
On the other hand, since $C_{\epsilon}$ is closed, convex and since $I_{j_{\epsilon}}$ is weakly lower semicontinuous we deduce that $I_{j_{\epsilon}}$ achieves its infimum at some $u_{\epsilon} \in C_{\epsilon}$. Therefore, for $\epsilon>0$ small enough, we have

By Lagrange multiplier, there exists $\mu_{\epsilon} \leq 0$ such that $I^{\prime}\left(u_{\epsilon}\right)=\mu_{\epsilon} \chi^{\prime}\left(u_{\epsilon}\right)$. By the construction we have $u_{\epsilon} \rightarrow u_{0}$ as $\epsilon \rightarrow 0$ in $L^{p_{s}^{*}}(\Omega)$.
Claim: $\left(u_{\epsilon}\right)$ is bounded in $L^{\infty}(\Omega)$ as $\epsilon \rightarrow 0$.
Case $i$ : $\inf _{0<\epsilon<1}\left\{\mu_{\epsilon}\right\}>-\infty$.
Look at

which is satisfied weakly by $u_{\epsilon}$. Similar to the argument in the subcritical case we find $M>0$ independent of $\epsilon$, such that,

By the Moser iteration method we get $\left(u_{\epsilon}\right)$ is bounded in $L^{\infty}(\Omega)$. Going by the steps in the subcritical case we conclude Case i.
case ii: $\inf _{0<\epsilon<1}\left\{\mu_{\epsilon}\right\}=-\infty$
By similar argument as used earlier we get $u_{\epsilon \geq \eta \phi_{1}}$ for some $\eta>0$ independent of $\epsilon$. Moreover, there exists $M>0$, independent of $\epsilon$, such that

Taking $\left(u_{\epsilon}-M\right)^{+}$as a test function, we conclude that $u_{\epsilon} \leq M$ in $\Omega$. Continuing the proof as in the subcritical case we prove the claim of Case ii.

Remark: Note that in all the above cases, since we already have $u_{\epsilon} \geq \eta \phi_{1}$ for $\eta>0$ sufficiently large and $u_{\epsilon}$ is an $L^{\infty}$-function, then there exists $L$ sufficiently large such that $\eta \phi_{1} \leq u_{\epsilon} \leq L \phi_{1}$. Thus $\eta \leq \frac{u_{\epsilon}}{\phi_{1}} \leq L$.

## 4. Multiplicity of weak solutions

This section is devoted to show the existence of a critical point $v_{\lambda}$ of the functional $\bar{I}_{\lambda}$ since, the functional $I_{\lambda}$ fails to be $C^{1}$. The critical point $v_{\lambda}$ of $\bar{I}_{\lambda}$ is also a point where the Gâteaux derivative of the functional $I_{\lambda}$ vanishes. Therefore, $v_{\lambda}$ will solve the problem (1.3). We will prove $v_{\lambda} \neq u_{\lambda}$, where, $u_{\lambda}$ is the solution to the problem (1.3) as proved in the Lemma 3.6. We have the following theorem proved in Ghoussoub-Preiss [31].

Theorem 4.1 (Ghoussoub-Preiss). Let $\varphi: X \rightarrow \mathbb{R}$ be a continuous and Gâteaux differentiable function on a Banach space $X$ such that $\varphi: X \rightarrow X^{*}$ is continuous from the norm topology on $X$ to the weak* topology of $X^{*}$. Take two point $u_{\lambda}$ and $v_{\lambda}$ in $X$ and consider the number

c=\inf _{g \in \Gamma, 0 \leq t \leq 1} \max \varphi(g(t))
$$

where $\Gamma=\left\{g \in C([0,1], X): g(0)=u_{\lambda} \& g(1)=v_{\lambda}\right\}$. Suppose $F$ is a closed subset of $X$ such that $F \cup\{x \in X: \varphi(x) \geq c\}$ seperates $u_{\lambda}$ and $v_{\lambda}$, then, there exists a sequence $\left\{x_{n}\right\}$ in $X$ verifying the following:
(i) $\lim _{n \rightarrow \infty} \operatorname{dist}\left(x_{n}, F\right)=0$
(ii) $\lim _{n \rightarrow \infty} \varphi\left(x_{n}\right)=c$
(iii) $\lim _{n \rightarrow \infty}\left\|\varphi^{\prime}\left(x_{n}\right)=0\right\|$

Definition 4.2. Let $F \subset \Omega$, be closed and $c \in \mathbb{R}$. Then a sequence $\left\{v_{n}\right\} \subset X_{0}$ is said be a Palais Smale sequence [in short $(P S)_{F, c}$ ] for the functional $\bar{I}_{\lambda}$ around $F$ at the level $c$, if

\lim _{n \rightarrow \infty} \operatorname{dist}\left(x_{n}, F\right)=0, \quad \lim _{n \rightarrow \infty} \bar{I}_{\lambda}\left(x_{n}\right)=c \quad \& \quad \lim _{n \rightarrow \infty}\left\|\bar{I}_{\lambda}^{\prime}\left(x_{n}\right)\right\|=0
$$

Every $(P S)_{F, c}$ sequence for $\bar{I}_{\lambda}$ have the following compactness property.
Lemma 4.3. Let $F \subset \Omega$ be closed and $c \in \mathbb{R}$. Let $\left\{v_{n}\right\} \subset X_{0}$ be a $(P S)_{F, c}$ sequence for the functional $\bar{I}_{\lambda}$, then $\left\{v_{n}\right\}$ is bounded in $X_{0}$ and there exists a subsequence $\left\{v_{n}\right\}$ such that $v_{n} \rightharpoonup v_{\lambda}$ in $X_{0}$, where $v_{\lambda}$ is a weak solution of the problem (1.3).

Proof. We use the Definition4.2, which says, there exists $K>0$ such that the following holds

this implies,

Again, by using the Definition 4.2, we get

& +o_{n}(1)\left\|v_{n}\right\| \tag{4.2}
\end{align*}
$$

Therefore, from (4.1) and (4.2), we have

\end{align*}

By using (4.3) we can conclude that the sequence $\left\{v_{n}\right\}$ is bounded in $X_{0}$. Since the space $X_{0}$ is reflexive, there exists $v_{\lambda} \in X_{0}$ such that $v_{n} \rightharpoonup v_{\lambda}$ in $X_{0}$ upto a subsequence. Thus

\end{aligned}

Passing the limit as $n \rightarrow \infty$ and applying the embedding result in Lemma 2.4 we have, for $\phi \in X_{0}$

Therefore, using the strong maximum principle and (4.4) we conclude that $v_{\lambda}$ is a weak solution of the problem (1.3). This completes the proof.

We observe from Lemma 3.6 and the fact that $\bar{I}_{\lambda}(t u) \rightarrow-\infty$ as $t \rightarrow \infty$ for all $u \in$ $X_{0}, u>0$, we can conclude that $\bar{I}_{\lambda}$ has a Mountain pass geometry near $u_{\lambda}$. Therefore, we may fix $e \in X_{0}, e>0$ such that $\bar{I}_{\lambda}(e)<\bar{I}_{\lambda}\left(u_{\lambda}\right)$. Let $R=\left\|e-u_{\lambda}\right\|$ and $r_{0}>0$ be small enough such that $u_{\lambda}$ is a minimizer of $\bar{I}_{\lambda}$ on $\overline{B\left(u_{\lambda}, r_{0}\right)}$. Consider the following complete metric space consisting of paths which is defined as

\Gamma=\left\{\eta \in C\left(\left[0, \frac{1}{2}\right], X_{0}\right): \eta(0)=u_{\lambda}, \eta\left(\frac{1}{2}\right)=e\right\}
$$

and the min-max value for mountain pass level

\delta_{0}=\inf _{\eta \in \Gamma, 0 \leq t \leq \frac{1}{2}} \max _{\lambda}(\eta(t))
$$

Let us distinguish between the following two cases.
Case 1: (Zero altitude case). There exists $R_{0}>0$, such that

\inf \left\{\bar{I}_{\lambda}(\tilde{u}): \tilde{u} \in X_{0},\left\|\tilde{u}-u_{\lambda}\right\|=r\right\} \leq \bar{I}_{\lambda}\left(u_{\lambda}\right), \text { for all } r<R_{0} \tag{4.5}
\end{equation*}
$$

Case 2: There exists $r_{1}<r_{0}$ such that

\end{equation*}

Remark 4.4. Observe that, (4.5) implies $\delta_{0}=\bar{I}_{\lambda}\left(u_{\lambda}\right)$, whereas (4.6) implies $\delta_{0}>\bar{I}_{\lambda}\left(u_{\lambda}\right)$.
For the "Zero altitude case" let us consider $F=\partial B\left(u_{\lambda}, r\right)$ with $r \leq R_{0}$. We can then construct a $(P S)_{F, \delta_{0}}$ sequence and get a second weak solution. We have the following result.

Lemma 4.5. Suppose Case 1 holds, then for $1<p<\infty, p-1<q \leq p_{s}^{*}-1,0<\gamma<1$ and $\lambda \in(0, \Lambda)$, there exists a weak solution $v_{\lambda}$ of the problem (1.3) such that $v_{\lambda} \neq u_{\lambda}$.

Proof. From Theorem 4.1 we can guarantee the existence of a $(P S)_{F, \delta_{0}}$ sequence $\left\{v_{n}\right\}$ for every $r \leq R_{0}$. From Lemma4.3, we can conclude that the sequence $\left\{v_{n}\right\}$ is bounded in $X_{0}$ and it converges, upto a subsequence, to a weak solution $v_{\lambda}$ of the problem (1.3). To show $v_{\lambda} \neq u_{\lambda}$, it is enough to show the strong convergence of $\left\{v_{n}\right\}$ to $v_{\lambda}$, i.e. $v_{n} \rightarrow v_{\lambda}$ strongly in $X_{0}$ as $n \rightarrow \infty$. Since $v_{n} \rightharpoonup v_{\lambda}$ weakly as $n \rightarrow \infty$ and from the embedding result $v_{n} \rightarrow v_{\lambda}$ in $L^{r}(\Omega)$ for $1 \leq r<p_{s}^{*}$, hence $v_{n}(x) \rightarrow v_{\lambda}(x)$ a.e. in $\Omega$. We have the following result due to Brezis \& Lieb [14]. As $n \rightarrow \infty$, we have

Further, by the Sobolev embedding theorem, we get

\end{align*}
$$

Hence, by using (4.7), (4.10) and (4.9) the following holds as $n \rightarrow \infty$

(a). $\bar{I}_{\lambda}\left(v_{\lambda}\right) \neq \bar{I}_{\lambda}\left(u_{\lambda}\right)$
(b). $\bar{I}_{\lambda}\left(v_{\lambda}\right)=\bar{I}_{\lambda}\left(u_{\lambda}\right)$

In case (a) holds, then we are through. Otherwise, from (4.7) we get,

Therefore, from (4.11) and (4.13), we get $\left\|v_{n}-v_{\lambda}\right\| \rightarrow 0$ as $n \rightarrow \infty$. Hence $\left\|u_{\lambda}-v_{\lambda}\right\|=r$ and $v_{\lambda} \neq u_{\lambda}$. This completes the proof.

Before we state the multiplicity result for Case 2, let us accumulate the necessary tools for this. Let $U(x)=\left(1+|x|^{p^{\prime}}\right)^{-\frac{N-s p}{p}}$ and $U_{\epsilon}(x)=\epsilon^{-\frac{N-s p}{p}} U\left(\frac{|x|}{\epsilon}\right)$, where $\epsilon>0, x \in \mathbb{R}^{N}$ and $p^{\prime}=\frac{p}{p-1}$. Therefore,

& \leq C \epsilon^{-\frac{(N-s p)}{p}}\left[\left(1+\left|\frac{x}{\epsilon}\right|^{p^{\prime}}\right)^{-\frac{N-s p}{p}}+\frac{1}{\rho}\left|\frac{x}{\epsilon}\right|^{p^{\prime}}\left(1+\left|\frac{x}{\epsilon}\right|^{p^{\prime}}\right)^{-1-\frac{N-s p}{p}}\right] \\
& \leq C \epsilon^{-\frac{(N-s p)}{p}}\left(1+\frac{1}{\rho}\right)\left(1+\left|\frac{x}{\epsilon}\right|^{p^{\prime}}\right)^{-\frac{N-s p}{p}} \\
& \leq C \epsilon^{-\frac{(N-s p)}{p}}\left(1+\frac{1}{\rho}\right)\left(\frac{\epsilon}{\rho}\right)^{\frac{(N-s p p) p^{\prime}}{p}} \\
& \leq C \epsilon^{-\frac{(N-s p)}{p}} \cdot \epsilon^{\frac{(N-s p) p^{\prime}}{p}} \\

Proof. (a) For $x \in \mathbb{R}^{N}, y \in \mathbb{R}^{N} \backslash B_{r}$ with $|x-y| \leq \frac{r}{2}$, let $z$ be any point on the line segment joining $x$ and $y$, i.e. $z=t x+(1-t) y$ for some $t \in[0,1]$. Observe that

We will try to estimate the last three terms of (4.22). From (4.21), we have

& \leq C \epsilon^{(N-p s)\left(\frac{p^{\prime}}{p}\right)} \int_{|x| \leq r} d x \int_{|z| \leq \frac{r}{2}} \frac{1}{|z|^{N+p s-p}} d z  \tag{4.24}\\
& =o\left(\epsilon^{(N-p s)\left(\frac{p^{\prime}}{p}\right)}\right), \quad \text { as } \epsilon \rightarrow 0 .

& \leq C \epsilon^{(N-p s)\left(\frac{p^{\prime}}{p}\right)} \int_{|x| \leq r} d x \int_{|z|>\frac{r}{2}} \frac{1}{|z|^{N+p s-p}} d z \\
& =o\left(\epsilon^{(N-p s)\left(\frac{p^{\prime}}{p}\right)}\right) .

\leq & 2^{p} \int_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{\left|U_{\epsilon}(x)-U_{\epsilon}(y)\right|^{p}}{|x-y|^{N+p s}} d x d y+o\left(\epsilon^{(N-p s)\left(\frac{p^{\prime}}{p}\right)}\right)
\end{aligned}

For every $\epsilon>0$, the functions $U_{\epsilon}(x)$ are the minimizer of the problem

Proof. From Theorem 5.3, we have the weak solution $u_{\lambda}$ of the problem (1.3) is bounded. Therefore, there exists positive real numbers $m$ and $M$ such that $m \leq$ $u_{\lambda}(x) \leq M, \forall x \in \Omega$. We have, by Mosconi et al. [38], that the Palais Smale(PS) condition is satisfied, if

By the Definitions of $I_{\lambda}$ and $\bar{I}_{\lambda}$, we have $\bar{I}_{\lambda}\left(u_{\lambda}+t \eta_{\epsilon}\right)=I_{\lambda}\left(u_{\lambda}+t \eta_{\epsilon}\right)$ and $\bar{I}_{\lambda}\left(u_{\lambda}\right)=I_{\lambda}\left(u_{\lambda}\right)$. Using the estimates given in the page 946, of Azorero and Alonso [4], one can conclude that

for every $\alpha>\frac{N-p s}{p}$. Therefore, we have

& \leq \frac{t^{p}}{p} \int_{Q} \frac{\left.\mid \eta_{\epsilon}(x)-\eta_{\epsilon}(y) u_{\lambda}^{-\gamma} \eta_{\epsilon}(x) d x-\int_{\Omega} u_{\lambda}^{q} \eta_{\epsilon}(x) d x\right]}{|x-y|^{N+p s}} d x d y \\

Hence, by the result in [38], $\left\{v_{n}\right\}$ is a (PS) sequence. Thus the sequence $\left\{v_{n}\right\}$ has a strongly convergent subsequence, from which we conclude that $\delta_{0}=I_{\lambda}\left(v_{\lambda}\right)>I_{\lambda}\left(u_{\lambda}\right)$. Therefore $v_{\lambda} \neq u_{\lambda}$. This completes the proof.

## 5. Regularity of the weak solutions

Firstly, let us recall the following elementary inequality needed for the proof of the $L^{\infty}$ estimate:

Lemma 5.1. (Generalization of the Lemma 3.1 in [35]) For all $a, b \in \mathbb{R}, r \geq p, p \geq 2$, $k>0$ we have

Define $v_{\eta}=\left(\eta \phi_{1}-u_{0}\right)^{+}$. For $0<t<1$ define $\xi(t)=I\left(v_{\epsilon}+v_{\eta}\right)$. Thus

for sufficiently small $\eta>0$. Moreover,

Since $s^{-\alpha}+f(x, s)$ is a uniformly nonincreasing function with respect to $x \in \Omega$ for sufficiently small $s>0$. Also from the monotonicity of $\left(-\Delta_{p}\right)^{s}$ we have, for sufficiently
small $\eta>0,0 \leq \xi^{\prime}(1)-\xi^{\prime}(t)$. From the Taylor series expansion and the fact that $K\left(v_{\epsilon}\right)<\epsilon$ we have $\exists 0<\theta<1$ such that

It has already been proved in lemma 5.3 that $u_{0}$ is $L^{\infty}$ bounded. Therefore, there exists $B>0$, sufficiently large, such that $0 \leq u_{0} \leq B \phi_{1}$.

Theorem 5.3. Let $f: \Omega \times \mathbb{R} \rightarrow \mathbb{R}$ be a nonlinear, Carathéodory function which satisfy the growth condition $|f(x, t)| \leq a\left(1+|t|^{q-1}\right)$ a.e. in $\Omega$ and for all $t \in \mathbb{R}(a>0$, $\left.1 \leq q \leq p_{s}^{*}\right)$, then for any weak solution $u \in X$ we have $u \in L^{\infty}(\Omega)$.

Proof. Case 1: (Subcritical case $1 \leq q<p_{s}^{*}$ ) Let $u$ be a weak solution to the given probem and $\gamma=\left(\frac{p_{s}^{*}}{p}\right)^{\frac{1}{p}}$. For every $r \geq p(p-1), p \geq 2, k>0$, the mapping $t \mapsto t|t|_{k}^{r-p}$ is Lipshitz in $\mathbb{R}$. Thus $u|u|_{k}^{r-p} \in X$. Here, in general for any $t$ in $\mathbb{R}$ and $k>0$, we have defined $t_{k}=\operatorname{sgn}(t) \min \{|t|, k\}$. We apply the Sobolev inequality, previous lemma, test with the test function $u|u|_{k}^{r-p}$ and on using the growth condition of $f$ which is given in the theorem to get

Here onwards we try to develope an argument to guarantee that $u \in L^{p_{1}}(\Omega)$ for all $p_{1} \geq 1$. Towards this, we divide our attempt into two cases, viz. sub and supercritical cases. Define a recurssive sequence $\left(r_{n}\right)$ by choosing $\mu>\mu_{0}$ and setting $r_{0}=\mu$, $r_{n+1}=\gamma^{p} r_{n}+p-q$.

Case 1: (Subcritical case $q<p_{s}^{*}$ )
We fix $\mu=p_{s}^{*}+p-q>\max \left\{p, \mu_{0}\right\}$. Since, $r_{0}+q-p=p_{s}^{*}$ we have $u \in L^{r_{0}+q-p}(\Omega)$ (because $u$ is a weak solution and by the embedding result). Therefore, on choosing $r=r_{0}$ in (5.6) we obtain a finite right side, so $u \in L^{\gamma^{p} r_{0}}(\Omega)=L^{r_{1}+q-p}(\Omega)$. Iterating this argument and using the fact $r \mapsto r^{1 / r}$ is bounded in $[2, \infty)$ for all $n$, we have $u \in L^{\gamma^{p} r_{n}}(\Omega)$. We further have

& \leq H\left(\|u\|_{p_{s}^{*}}\right)|\Omega|_{\gamma^{p^{p-1} r}}^{\frac{1}{r}}\|u\|_{\gamma^{p-1} r}^{r-p}
\end{aligned}

We note that $t \mapsto|\Omega|^{p /\left(\gamma^{p-1} t\right)}$ is a bounded map in $[p, \infty)$ and hence

The function $M$ here has been obtained from the function $H$ which was previously. Therefore, we have $\|u\|_{\infty} \leq \infty$.
Case 2: (Critical case $q=p_{s}^{*}$ ) We use $r=q+p-1>p$ in (5.5) and fix $\delta>0$ such that $C r^{p} \delta<\frac{1}{p}$. There exists $K_{0}>0$ (depending on $u$ ) such that $\left(\int_{\left\{|u|>K_{0}\right\}}|u|^{q}\right)^{1-\frac{p}{q}} \leq \delta$. Thus by the Hölder's inequality in $\left(\int_{\left\{|u|>K_{0}\right\}}|u|^{q}\right)^{1-\frac{p}{q}} \leq \delta$ we get

\int_{\Omega}|u|^{q}|u|_{k}^{r-p} d x & \leq K_{0}^{q+r-p}\left|\left\{|u| \leq K_{0}\right\}\right|+\int_{\left\{|u|>K_{0}\right\}}|u|^{q}|u|_{k}^{r-p} d x \\
& \leq K_{0}^{q+r-p}\left|\left\{|u| \leq K_{0}\right\}\right| \\
& +\left(\int_{\Omega}\left(|u|^{p}|u|_{k}^{r-p}\right)^{q / p} d x\right)^{\frac{p}{q}}\left(\int_{\left\{|u|>K_{0}\right\}}\left(|u|^{q} \mid d x\right)^{1-\frac{p}{q}}\right.  \tag{5.11}\\
& \leq K_{0}^{q+r-p}|\Omega|+\delta\left\|u|u|_{k}^{\frac{r-p}{p}}\right\|_{q}^{p} .
\end{align*}
$$

Using the choice of $C r \delta<\frac{1}{2}$ and the Lemma 5.1 to obtain

$$
\begin{equation*}
\frac{1}{2}\left\|u|u|_{k}^{\frac{r-p}{p}}\right\|_{q}^{p} \leq C(q+p-1)^{p}\left(\|u\|_{q}^{q}+K_{0}^{q+p-1}|\Omega|+\|u\|_{q-\alpha}^{q-\alpha}\right) . \tag{5.12}
\end{equation*}
$$

On passing the limit $k \rightarrow \infty$ we have

$$
\begin{equation*}
\|u\|_{\frac{q(q+p-1)}{p}} \leq N\left(K_{0},\|u\|_{q}\right) \tag{5.13}
\end{equation*}
$$

The rest of the proof follows from the same argument and words as in the subcritical case.

Lemma 5.4. $\left|\left(-\Delta_{p}\right)^{s} u\right| \leq K$ in $B_{r}(x)$ where $u$ is a weak solution to the problem ( $P$ ). Proof. By definition

$$
\begin{align*}
\left|\left(-\Delta_{p}\right)^{s} u(x)\right| & =C \int_{B_{r}(x)} \frac{|u(x)-u(y)|^{p-1}}{|x-y|^{N+p s}} d y \\
& =C \int_{B_{r}(x)} \frac{|u(x)-u(y)|^{p-1}}{|x-y|^{N+(p-1) s}} \frac{1}{|x-y|^{p s-(p-1) s}} d y \tag{5.14}
\end{align*}
$$

Converting this into polar coordinates and applying the Hölder's inequality we obtain $\left|\left(-\Delta_{p}\right)^{s} u(x)\right| \leq C$ in $B_{r}(x)$. The proof follows verbatim when $\left|\left(-\Delta_{p}\right)^{s} u^{\prime}\right|$ is considered.

We now generalize two of the results of Iannizzoto.
Lemma 5.5. There exists $0<\alpha \leq s$ such that $\left[u / \delta^{s}\right]_{C^{\alpha}(\bar{\Omega})} \leq C$ for all weak solutions of the problem.

Proof. Observe that

$$
\begin{align*}
\operatorname{Tail}\left(u / \delta^{s} ; x, R_{0}\right)^{p-1} & =R_{0}^{p s} \int_{B_{R_{0}(x) c}^{c}} \frac{|u(y)|^{p-1}}{\delta(y)^{s(p-1)}|x-y|^{N+s p}} d y \\
& \leq C R_{0}^{p s}\left(\int_{B_{2 R_{0}}\left(x_{0}\right) \backslash B_{R_{0}\left(x_{0}\right)}} \frac{\left\|u / \delta^{s}\right\|_{L^{\infty}\left(B_{2 R_{0}}\left(x_{0}\right)\right)}^{p-1}}{|x-y|^{N+p s}} d y\right. \\
& \left.+\int_{B_{2 R_{0}\left(x_{0}\right)^{c}}} \frac{|u(y)|^{p-1}}{\delta(y)^{s(p-1)}|x-y|^{N+p s}} d y\right) \\
& \leq C\left(\left\|u / \delta^{s}\right\|_{L^{\infty}\left(B_{\left.2 R_{0}\left(x_{0}\right)\right)}^{p-1}\right.}+R_{0}^{p s} \int_{B_{2 R_{0}\left(x_{0}\right)^{c}}} \frac{|u(y)|^{p-1}}{\delta(y)^{s(p-1)}|x-y|^{N+p s}} d y\right) \\
& =C Q\left(u / \delta^{s} ; x_{0}, 2 R_{0}\right) . \tag{5.15}
\end{align*}
$$

Here $K$ is the bound of $\left(-\Delta_{p}\right)^{s} u$ in $B_{2 R_{0}}\left(x_{0}\right)$ (refer Appendix). Thus we obtained $Q\left(u / \delta^{s} ; x_{0}, R_{0}\right) \leq C Q\left(u / \delta^{s} ; x_{0}, 2 R_{0}\right)$ which implies the following Hölder seminorm estimate.

$$
\begin{equation*}
\left[u / \delta^{s}\right]_{C^{\alpha}\left(B_{R_{0}}\left(x_{0}\right)\right)} \leq C\left[\left(K R_{0}^{p s}\right)^{1 /(p-1)}+Q\left(u / \delta^{s} ; x_{0}, 2 R_{0}\right)\right] R_{0}^{-\alpha} \tag{5.16}
\end{equation*}
$$

We assume that $\alpha \in(0, s]$. Let $\Omega^{\prime} \Subset \Omega$. Then we have through the compactness of $\Omega^{\prime}$ and the the estimate (5.19) that $\left\|u / \delta^{s}\right\|_{C^{\alpha}\left(\overline{\Omega^{\prime}}\right)} \leq C$.
Let $\Pi: V \rightarrow \partial \Omega$ be a metric projection map defined as $\Pi(x)=\operatorname{Argmin}_{y \in \partial \Omega^{c}}\{|x-y|\}$ where $V=\{x \in \bar{\Omega}: d(x, \partial \Omega) \leq \rho\}$. By (5.19) we have

$$
\begin{equation*}
\left[u / \delta^{s}\right]_{C^{\alpha}\left(B_{r / 2}(x)\right)} \leq C\left[\left(K r^{p s}\right)^{1 /(p-1)}+\left\|u / \delta^{s}\right\|_{L^{\infty}\left(B_{r}(x)\right)}+\operatorname{Tail}\left(u / \delta^{s} ; x, r\right)\right] r^{-\alpha} \tag{5.17}
\end{equation*}
$$

We now try to control the growth of the terms on the right hand side of (5.20). The first term is trivially controlled since $\alpha \leq s \leq \frac{s p}{p-1}$. The other terms are controlled uniformly due to the compactness of the set $V$.

Lemma 5.6. There exists $0<\alpha \leq s$ such that $\left[u^{\prime}\right]_{C^{\alpha}(\bar{\Omega})} \leq C$ for all weak solutions of the problem.

Proof. Observe that

$$
\begin{align*}
\operatorname{Tail}\left(u^{\prime} ; x, R_{0}\right)^{p-1} & =R_{0}^{p s} \int_{B_{R_{0}(x)^{c}}} \frac{\left|u^{\prime}(y)\right|^{p-1}}{|x-y|^{N+s p}} d y \\
& \leq C R_{0}^{p s}\left(\int_{B_{2 R_{0}}\left(x_{0}\right) \backslash B_{R_{0}\left(x_{0}\right)}} \frac{\left\|u^{\prime}\right\|_{L^{\infty}\left(B_{2 R_{0}}\left(x_{0}\right)\right)}^{p-1}}{|x-y|^{N+p s}} d y\right. \\
& \left.+\int_{B_{2 R_{0}\left(x_{0}\right)^{c}}} \frac{\left|u^{\prime}(y)\right|^{p-1}}{|x-y|^{N+p s}} d y\right)  \tag{5.18}\\
& \leq C\left(\left\|u^{\prime}\right\|_{L^{\infty}\left(B_{2 R_{0}}\left(x_{0}\right)\right)}^{p-1}+R_{0}^{p s} \int_{B_{2 R_{0}\left(x_{0}\right)^{c}}} \frac{\left|u^{\prime}(y)\right|^{p-1}}{|x-y|^{N+p s}} d y\right) \\
& =C Q\left(u^{\prime} ; x_{0}, 2 R_{0}\right) .
\end{align*}
$$

Here $K$ is the bound of $\left(-\Delta_{p}\right)^{s} u^{\prime}$ in $B_{2 R_{0}}\left(x_{0}\right)$ (refer Appendix). Thus we obtained $Q\left(u^{\prime} ; x_{0}, R_{0}\right) \leq C Q\left(u^{\prime} ; x_{0}, 2 R_{0}\right)$ which implies the following Hölder seminorm estimate.

$$
\begin{equation*}
\left[u^{\prime}\right]_{C^{\alpha}\left(B_{R_{0}}\left(x_{0}\right)\right)} \leq C\left[\left(K R_{0}^{p s}\right)^{1 /(p-1)}+Q\left(u^{\prime} ; x_{0}, 2 R_{0}\right)\right] R_{0}^{-\alpha} . \tag{5.19}
\end{equation*}
$$

We assume that $\alpha \in(0, s]$. Let $\Omega^{\prime} \Subset \Omega$. Then we have through the compactness of $\Omega^{\prime}$ and the the estimate (5.19) that $\left\|u^{\prime}\right\|_{C^{\alpha}\left(\overline{\Omega^{\prime}}\right)} \leq C$.
Let $\Pi: V \rightarrow \partial \Omega$ be a metric projection map defined as $\Pi(x)=\operatorname{Argmin}_{y \in \partial \Omega^{c}}\{|x-y|\}$ where $V=\{x \in \bar{\Omega}: d(x, \partial \Omega) \leq \rho\}$. By (5.19) we have

$$
\begin{equation*}
\left[u^{\prime}\right]_{C^{\alpha}\left(B_{r / 2}(x)\right)} \leq C\left[\left(K r^{p s}\right)^{1 /(p-1)}+\left\|u^{\prime}\right\|_{L^{\infty}\left(B_{r}(x)\right)}+\operatorname{Tail}\left(u^{\prime} ; x, r\right)\right] r^{-\alpha} \tag{5.20}
\end{equation*}
$$

We now try to control the growth of the terms on the right hand side of (5.20). The first term is trivially controlled since $\alpha \leq s \leq \frac{s p}{p-1}$. The other terms are controlled uniformly due to the compactness of the set $V$.

## 6. Appendix

We now prove the following two Lemmas with the help of Lemma 6.1, to establish the Gâteaux differentiability of the functional $I_{\lambda}: X_{0} \rightarrow \mathbb{R}$, for $0<\gamma<1$.

Lemma 6.1. For every $0<\gamma<1$, there exists $C_{\gamma}>0$, depending on $\gamma$, such that the following inequality holds true

$$
\begin{equation*}
\int_{0}^{1}|a+t b|^{-\gamma} d t \leq C_{\gamma}\left(\max _{t \in[0,1]}|a+t b|\right)^{-\gamma} \tag{6.1}
\end{equation*}
$$

Proof. The proof of this can be found in Lemma A.1. of [49].

Lemma 6.2. Let $0<\gamma<1,1<p<\infty, p-1<q \leq p_{s}^{*}-1$ and $\phi_{1}$ be the first eigenvector of the fractional p-Laplacian operator. Suppose $u, v \in X_{0}$ with $u \geq \epsilon \phi_{1}$, for some $\epsilon>0$. Then we have

$$
\begin{align*}
\lim _{t \rightarrow 0} \frac{I_{\lambda}(u+t v)-I_{\lambda}(u)}{t}=\int_{Q} & \frac{|u(x)-u(y)|^{p-2}(u(x)-u(y))}{|x-y|^{N+p s}}(v(x)-v(y)) d x d y  \tag{6.2}\\
& -\lambda \int_{\Omega} u^{-\gamma} v d x-\int_{\Omega} u^{q} v d x
\end{align*}
$$

Proof. In order to estimate (6.2), it is enough to prove the convergence of the singular term $\int_{\Omega} u^{-\gamma} v d x$. Let $v \in X_{0}$ and $t>0$ be sufficiently small. Then we have

$$
\begin{align*}
& 0 \leq \frac{I_{\lambda}(u+t v)-I_{\lambda}(u)}{t}= \frac{1}{p}  \tag{6.3}\\
&\left(\frac{\|u+t v\|^{p}-\|u\|^{p}}{t}\right)-\lambda\left(\frac{F(u+t v)-F(u)}{t}\right) \\
&-\frac{1}{q+1} \int_{\Omega}\left(\frac{|u+t v|^{q+1}-|u|^{q+1}}{t}\right)
\end{align*}
$$

where,

$$
F(u)=\frac{1}{1-\gamma} \int_{\Omega}\left(u^{+}\right)^{1-\gamma} d x, \text { for all } x \in X_{0}
$$

We see that as $t \rightarrow 0^{+}$, we get
(a) $\frac{\|u+t v\|^{p}-\|u\|^{p}}{t} \longrightarrow p \int_{Q} \frac{|u(x)-u(y)|^{p-2}(u(x)-u(y))}{|x-y|^{N+p s}}(v(x)-v(y)) d x d y$
(b) $\frac{1}{q+1} \int_{\Omega}\left(\frac{|u+t v|^{q+1}-|u|^{q+1}}{t}\right) d x \longrightarrow \int_{\Omega}|u|^{q} v d x$

We now define for $z \in \mathbb{R} \backslash\{0\}$,

$$
\begin{align*}
V(x) & =\frac{1}{1-\gamma} \frac{d}{d z}\left(z^{+}\right)^{1-\gamma} \\
& =\left\{\begin{array}{l}
z^{-\gamma}, \text { if } z>0 \\
0, \text { if } z<0
\end{array}\right. \tag{6.4}
\end{align*}
$$

Therefore, for every $x \in \Omega$

$$
\begin{equation*}
\frac{F(u+t v)-F(u)}{t}=\int_{\Omega}\left(\int_{0}^{1} V(u+s t v) d s\right) v d x \tag{6.5}
\end{equation*}
$$

Hence we get for all $x \in \Omega, u(x)>0$, and

$$
\lim _{t \rightarrow 0^{+}} \int_{0}^{1} V\left(u(x)+\operatorname{stv}(x) d s=V(u(x))=u(x)^{-\gamma}\right.
$$

Also we have

$$
\mid \int_{0}^{1} V\left(u(x)+\operatorname{stv}(x) d s\left|\leq \int_{0}^{1}\right| u(x)+s t v(x) \mid d s\right.
$$

Now using the estimate in the previous Lemma 6.1, we get

$$
\begin{aligned}
\mid \int_{0}^{1} V(u(x)+s t v(x) d s \mid & \leq C_{\gamma}\left(\max _{s \in[0,1]}|u(x)+s t v(x)|\right)^{-\gamma} \\
& \leq C_{\gamma} u(x)^{-\gamma} \\
& \leq C_{\gamma}\left(\epsilon \phi_{1}(x)\right)^{-\gamma} \\
& =C_{\epsilon, \gamma} \phi_{1}(x)^{-\gamma}
\end{aligned}
$$

where, the constant $C_{\epsilon, \gamma}>0$ is independent of $x \in \Omega$. Therefore, by the Hardy's inequality and for all $v \in X_{0}$, we have $v \phi_{1}^{-\gamma} \in L^{1}(\Omega)$. Hence the Lemma follows by applying Lesbegue dominated convergence theorem in (6.5) and taking the limit as $t \rightarrow 0^{+}$. In fact we have the following Corollary to the Lemma 6.2,

Corollary 6.3. Let $0<\gamma<1,1<p<\infty, p-1<q \leq p_{s}^{*}-1$. If $u \in X_{0}$ is such that $u \geq \epsilon \phi_{1}$, for some $\epsilon>0$. Then the functional $I_{\lambda}: X_{0} \rightarrow \mathbb{R}$ is Gâteaux differentiable at $u$. The Gâteaux derivative $I_{\lambda}(u)$ at $u$ is given by

$$
\begin{gather*}
\left\langle I_{\lambda}(u), v\right\rangle=\int_{Q} \frac{|u(x)-u(y)|^{p-2}(u(x)-u(y))}{|x-y|^{N+p s}}(v(x)-v(y)) d x d y  \tag{6.6}\\
-\lambda \int_{\Omega} u^{-\gamma} v d x-\int_{\Omega} u^{q} v d x, \text { for all } v \in X_{0} .
\end{gather*}
$$

Lemma 6.4. Let $0<\gamma<1,1<p<\infty, p-1<q \leq p_{s}^{*}-1$. Let $w \in X_{0}$ is such that $w \geq \epsilon \phi_{1}$, for some $\epsilon>0$. For each $x \in \Omega$, we consider

$$
f_{\lambda}(x, s)=\left\{\begin{array}{l}
\lambda w(x)^{-\gamma}+w(x)^{q}, \quad \text { if } s<w(x) \\
\lambda s^{-\gamma}+s^{q}, \quad \text { if } s \geq w(x)
\end{array}\right.
$$

with $F_{\lambda}(x, s)=\int_{0}^{s} f_{\lambda}(x, t) d t$. For each $u \in X_{0}$ we define

$$
\bar{I}_{\lambda}(u)=\frac{1}{p} \int_{Q} \frac{|u(x)-u(y)|^{p}}{|x-y|^{N+p s}} d x d y-\int_{\Omega} F_{\lambda}(x, u) d x
$$

Then the energy functional $\bar{I}_{\lambda}$ belongs to $C^{1}\left(X_{0}, \mathbb{R}\right)$.
Proof. To establish the result we emphasize only on the singular term. Let

$$
g(x, s)=\left\{\begin{array}{l}
w(x)^{-\gamma}, \text { if } s<w(x) \\
s^{-\gamma}, \text { if } s \geq w(x)
\end{array}\right.
$$

where, $w \in X_{0}$ such that $w \geq \epsilon \phi_{1}$. Let us define $G(x, s)=\int_{0}^{s} g(x, t) d t$ and $J(u)=$ $\int_{\Omega} G(x, u) d x$. Proceeding with the arguments as in Lemma 6.2, we get $J(u)$ has a Gâteaux derivative $J^{\prime}(u)$ for all $u \in X_{0}$ and it is given by

$$
\left\langle J^{\prime}(u), v\right\rangle=\int_{\Omega}(\max \{u(x), w(x)\})^{-\gamma} v(x) d x
$$

Now, let $u_{n} \in X_{0}$ be such that $u_{n} \rightarrow u$. Then we have, for all $v \in X_{0}$

$$
\begin{aligned}
\left|\left\langle J^{\prime}\left(u_{n}\right)-J^{\prime}(u), v\right\rangle\right| & =\left|\int_{\Omega}\left[\left(\max \left\{u_{n}(x), w(x)\right\}\right)^{-\gamma}-(\max \{u(x), w(x)\})^{-\gamma}\right] v(x) d x\right| \\
& \leq 2 \int_{\Omega} w^{-\gamma}|v| d x \\
& \leq 2 \epsilon^{-\gamma} \int_{\Omega} \phi_{1}^{-\gamma}|v| d x
\end{aligned}
$$

Now as in Lemma 6.2, using the Hardy's inequality we conclude that $\phi_{1}^{-\gamma} v \in L^{1}(\Omega)$. Hence by Lesbegue dominated convergence theorem we conclude that the Gâteaux derivative of $J$ is continuous which guaranties that $J \in C^{1}\left(X_{0}, \mathbb{R}\right)$.
