A Trudinger-Moser inequality for conical metric in the unit ball

Abstract

In this note, we prove a Trudinger-Moser inequality for conical metric in the unit ball. Precisely, let \mathbb{B} be the unit ball in \mathbb{R}^N ($N \ge 2$), $p > 1$, $g = |x|^{\frac{2p}{N}\beta} (dx_1^2 + \cdots + dx_N^2)$ be a conical metric on **EXECUTE ON EXECUTE IN EXECUTE 1 N** $(N \ge 2)$, $p > 1$, $g = |x|$, $(a x_1 + b x_1 a x_N)$ be a concentrated on \mathbb{B} , and $\lambda_p(\mathbb{B}) = \inf \left\{ \int_{\mathbb{B}} |\nabla u|^N dx : u \in W_0^{1,N}(\mathbb{B})$, $\int_{\mathbb{B}} |u|^p dx = 1 \right\}$. We prove that for any $\beta \$ $\alpha < (1 + \frac{p}{\lambda})$ $\frac{p}{N}\beta$ ^{N-1+ $\frac{N}{p}$} $\lambda_p(\mathbb{B})$, there exists a constant *C* such that for all radially symmetric functions $u \in W_0^{1,N}(\mathbb{B})$ with $\int_{\mathbb{B}} |\nabla u|^N dx - \alpha (\int_{\mathbb{B}} |u|^p |x|^{p\beta} dx)^{N/p} \le 1$, there holds

$$
\int_{\mathbb{B}} e^{\alpha_N(1+\frac{p}{N}\beta)|u|^{\frac{N}{N-1}}} |x|^{p\beta} dx \leq C,
$$

where $|x|^{p\beta}dx = dv_g$, $\alpha_N = N\omega_{N-1}^{1/(N-1)}$ $\mu_{N-1}^{1/(N-1)}$, ω_{N-1} is the area of the unit sphere in \mathbb{R}^N ; moreover, extremal functions for such inequalities exist. The case $p = N$, $-1 < \beta < 0$ and $\alpha = 0$ was considered by Adimurthi-Sandeep [\[1\]](#page-10-0), while the case $p = N = 2$, $\beta \ge 0$ and $\alpha = 0$ was studied by de Figueiredo-do Ó-dos Santos [\[8\]](#page-10-1).

Key words: Trudinger-Moser inequality, blow-up analysis, conical metric *2010 MSC:* 35J15; 46E35.

1. Introduction

Let Ω be a smooth bounded domain in \mathbb{R}^N ($N \ge 2$), $W_0^{1,N}(\Omega)$ be the completion of $C_0^{\infty}(\Omega)$ under the Sobolev norm

$$
||u||_{W_0^{1,N}(\Omega)} = \left(\int_{\Omega} |\nabla u|^N dx\right)^{1/N},
$$

where ∇ denotes the gradient operator. Write $\alpha_N = N \omega_{N-1}^{1/(N-1)}$ $\frac{N}{N-1}$, where ω_{N-1} stands for the area of the unit sphere in \mathbb{R}^N . Then the classical Trudinger-Moser inequality [\[39](#page-11-0), [29](#page-11-1), [28](#page-11-2), [33](#page-11-3), [24](#page-11-4)] says

$$
\sup_{u \in W_0^{1,N}(\Omega), ||u||_{W_0^{1,N}(\Omega)} \le 1} \int_{\Omega} e^{\alpha |u|^{\frac{N}{N-1}}} dx < \infty, \quad \forall \alpha \le \alpha_N. \tag{1}
$$

This inequality is sharp in the sense that if $\alpha > \alpha_N$, all integrals in [\(1\)](#page-0-0) are still finite, but the supremum is infinite. While the existence of extremal functions for it was solved by Carleson-Chang [\[5](#page-10-2)], Flucher [\[12\]](#page-10-3) and Lin [\[21\]](#page-11-5).

Using a symmetrization argument and a change of variables, Adimurthi-Sandeep [\[1\]](#page-10-0) generalized [\(1\)](#page-0-0) to the following singular version:

$$
\sup_{u \in W_0^{1,N}(\Omega), ||u||_{W_0^{1,N}(\Omega)} \le 1} \int_{\Omega} \frac{e^{\alpha_N \gamma |u|^{\frac{N}{N-1}}}}{|x|^{N\beta}} dx < \infty, \quad \forall \ 0 \le \beta < 1, \ 0 < \gamma \le 1 - \beta. \tag{2}
$$

Also, it is sharp in the sense that if $\gamma > 1 - \beta$, integrals are still finite, but the above supremum is infinite. The inequality [\(2\)](#page-1-0) was extended to the whole Euclidean space \mathbb{R}^N by Adimurthi-Yang [\[2\]](#page-10-4). The existence of extremal functions for [\(2\)](#page-1-0) in the case $N = 2$ was due to Casto-Roy [\[6](#page-10-5)], Yang-Zhu [\[38\]](#page-11-6) and Iula-Mancini [\[13\]](#page-10-6). An interesting question is whether or not [\(2\)](#page-1-0) still holds for $\beta < 0$. Generally, the answer is negative. To see this, we choose $x_0 \neq 0$, $r_0 > 0$ such that $B_{2r_0}(x_0) \subset \Omega \setminus \{0\}$. For any $0 < \epsilon < r_0$, we write the Moser function

$$
m_{\epsilon}(x) = \begin{cases} \frac{1}{\omega_{N-1}^{1/N}} \left(\log \frac{r_0}{\epsilon} \right)^{\frac{N-1}{N}}, & \text{when} \quad |x - x_0| \le \epsilon\\ \frac{1}{\omega_{N-1}^{1/N}} \frac{\log \frac{r_0}{k} - x_0}{(\log \frac{r_0}{\epsilon})^{1/N}}, & \text{when} \quad \epsilon < |x - x_0| \le r_0\\ 0, & \text{when} \quad |x - x_0| > r_0. \end{cases}
$$

An easy computation shows $||m_{\epsilon}||_{W_0^{1,N}(\Omega)} = 1$. Since $\beta < 0$, we have

$$
\int_{\Omega}e^{\alpha_N(1-\beta)m_\epsilon^{\frac{N}{N-1}}}|x|^{-N\beta}dx\geq \int_{B_\epsilon(x_0)}e^{\alpha_N(1-\beta)m_\epsilon^{\frac{N}{N-1}}}|x|^{-N\beta}dx\rightarrow \infty \quad \text{as} \quad \epsilon\rightarrow 0.
$$

Even worse, the above estimate still holds if $\alpha_N(1-\beta)$ is replaced by any $\alpha > \alpha_N$. In conclusion, the singular Trudinger-Moser inequality [\(2\)](#page-1-0) does not hold for $\beta < 0$.

Let us consider the unit ball $\mathbb{B} \subset \mathbb{R}^N$, which is centered at the origin. Let \mathscr{S} be a set of all radially symmetric functions. With a slight abuse of notations, we say that *u* is radially symmetric if $u(x) = u(|x|)$ for almost every $x \in \mathbb{B}$. It was proved by Ni [\[27\]](#page-11-7) that $W_0^{1,N}(\mathbb{B}) \cap \mathscr{S}$ can be imbedded in $L^p(\mathbb{B}, |x|^\alpha)$ with $\alpha > 0$ and $p = 2(N + \alpha)/(N - 2)$ greater than $2^* = 2N/(N - 2)$. Motivated by results of Bonheure-Serra-Tarallo [\[3\]](#page-10-7), Calanchi-Terraneo [\[4\]](#page-10-8) and de Figueiredo-dos Santos-Miyagaki [\[7](#page-10-9)], de Figueiredo-do Ó-dos Santos [\[8\]](#page-10-1) observed that in the case $N = 2$,

$$
\sup_{u \in W_0^{1,2}(\mathbb{B}) \cap \mathscr{S}, ||u||_{W_0^{1,2}(\mathbb{B})} \le 1} \int_{\mathbb{B}} e^{\alpha u^2} |x|^{2\gamma} dx < \infty, \quad \forall \alpha \le 4\pi (1 + \gamma), \ \gamma \ge 0; \tag{3}
$$

moreover, extremal function for the above supremum exists. Of course they discussed more general weight $h(|x|)$ and fast growth $F(u)$ instead of $|x|^\alpha$ and $e^{4\pi(1+\alpha)u^2}$ respectively.

Our aim is to generalize [\(3\)](#page-1-1) to higher dimensional case and to stronger versions. We first have the following:

Theorem 1. Let $\mathbb B$ *be the unit ball in* $\mathbb R^N$ ($N \ge 2$), $W_0^{1,N}(\mathbb B)$ *and* $\mathscr S$ *be as above. Then there holds for any* $\beta \geq 0$ *,*

$$
\sup_{u \in W_0^{1,N}(\mathbb{B}) \cap \mathcal{S}, ||u||_{W_0^{1,N}(\mathbb{B})} \le 1} \int_{\mathbb{B}} e^{\gamma |u|^{\frac{N}{N-1}}} |x|^{N\beta} dx < \infty, \quad \forall \gamma \le \alpha_N (1 + \beta). \tag{4}
$$

Here $\alpha_N(1 + \beta)$ *is the best constant in the sense that if* $\gamma > \alpha_N(1 + \beta)$ *, all integrals are finite but the supremum is infinity. Moreover, for any* $\beta \ge 0$ *and any* $\gamma \le \alpha_N(1+\beta)$ *, the supremum in* [\(4\)](#page-1-2) *can be attained.*

By a rearrangement argument, for any $\gamma \le \alpha_N$, there holds

$$
\sup_{u \in W_0^{1,N}(\mathbb{B}), ||u||_{W_0^{1,N}(\mathbb{B})} \le 1} \int_{\mathbb{B}} e^{\gamma |u|^{\frac{N}{N-1}}} dx = \sup_{u \in W_0^{1,N}(\mathbb{B}) \cap \mathcal{S}, ||u||_{W_0^{1,N}(\mathbb{B})} \le 1} \int_{\mathbb{B}} e^{\gamma |u|^{\frac{N}{N-1}}} dx.
$$
 (5)

Therefore, when $\Omega = \mathbb{B}$, Theorem [1](#page-1-3) includes the classical Trudinger-Moser inequality [\(1\)](#page-0-0) as a special case and complements Adimurthi-Sandeep's inequality [\(2\)](#page-1-0).

Motivated by [\[34,](#page-11-8) [41,](#page-11-9) [40\]](#page-11-10), we would generalize Theorem [1](#page-1-3) to a version involving eigenvalue of the *N*-Laplace. For $p > 1$, define

$$
\lambda_p(\mathbb{B}) = \inf_{u \in W_0^{1,N}(\mathbb{B}), u \neq 0} \frac{\int_{\mathbb{B}} |\nabla u|^N dx}{(\int_{\mathbb{B}} |u|^p dx)^{N/p}}.
$$
\n(6)

For $\alpha < \lambda_p(\mathbb{B})$, we write for simplicity

$$
||u||_{1,\alpha} = \left(\int_{\mathbb{B}} |\nabla u|^N dx - \alpha \left(\int_{\mathbb{B}} |u|^p dx\right)^{N/p}\right)^{1/N}.\tag{7}
$$

Theorem 2. *Given p* > 1*. In addition to the assumptions of Theorem [1,](#page-1-3) let* $\lambda_p(\mathbb{B})$ *and* $\|\cdot\|_{1,\alpha}$ *be defined as in [\(6\)](#page-2-0) and [\(7\)](#page-2-1) respectively. Then if* $\alpha < \lambda_p(\mathbb{B})$ *, there holds*

$$
\sup_{u\in W_0^{1,N}(\mathbb{B}), ||u||_{1,\alpha}\leq 1}\int_{\mathbb{B}}e^{\gamma |u|^{\frac{N}{N-1}}}dx<\infty, \quad \forall \gamma\leq \alpha_N.
$$

Moreover, the above supremum can be attained.

When $p = N$, Theorem [2](#page-2-2) was proved by Nguyen [\[26](#page-11-11)] for a smooth bounded domain. As a consequence of Theorem [2,](#page-2-2) we improve Theorem [1](#page-1-3) as follows:

Theorem 3. *Given p* > 1*. Under the same assumptions of Theorem [2,](#page-2-2) for any* $\beta \ge 0$ *and any* α < (1 + $\frac{p}{N}$ $\frac{p}{N}\beta$ ^{N-1+N/p} $\lambda_p(\mathbb{B})$ *, there holds*

$$
\sup_{u \in W_0^{1,N}(\mathbb{B}) \cap \mathscr{S}, \int_{\mathbb{B}} |\nabla u|^N dx - \alpha (\int_{\mathbb{B}} |u|^p |x|^{p\beta} dx)^{N/p} \le 1} \int_{\mathbb{B}} e^{\gamma |u|^{\frac{N}{N-1}}} |x|^{p\beta} dx < \infty, \quad \forall \gamma \le \alpha_N (1 + \frac{p}{N}\beta), \tag{8}
$$

where $\alpha_N(1 + \frac{p}{N})$ *N* β) *is the best constant in the same sense as in Theorem [1.](#page-1-3) Furthermore, the supremum in [\(8\)](#page-2-3) can be attained.*

We now explain the geometric meaning of the term $|x|^{p\beta}dx$. Let g_0 be the standard Euclidean metric, namely $g_0(x) = dx_1^2 + \cdots + dx_N^2$. Define a metric $g(x) = |x| \frac{2p}{N} g_0(x)$ for $x \in \mathbb{B}$. Then (\mathbb{B}, g) is a conical manifold with the volume element $dv_g = |x|^{p\beta}dx$. Moreover, $|\nabla u|^N dx = |\nabla_g u|^N dv_g$.

The proof of Theorems [1](#page-1-3) and [3](#page-2-4) is based on a change of variables. While the proof of Theorem [2](#page-2-2) is based on blow-up analysis. In the remaining part of this note, we shall prove Theorems [1-](#page-1-3)[3](#page-2-4) respectively.

2. Proof of Theorem [1](#page-1-3)

Let $\beta \ge 0$ and $\gamma \le \alpha_N(1 + \beta)$. Write for simplicity $u(x) = u(r)$ with $r = |x|$. Following Smets-Willem-Su [\[31](#page-11-12)] and Adimurthi-Sandeep [\[1](#page-10-0)], we make a change of variables. Define a function

$$
v(r) = (1+\beta)^{1-1/N} u(r^{1/(1+\beta)}).
$$

A straightforward calculation shows

$$
\int_{\mathbb{B}} |\nabla v|^{N} dx = \omega_{N-1} \int_{0}^{1} |v'(r)|^{N} r^{N-1} dr
$$
\n
$$
= \frac{\omega_{N-1}}{1+\beta} \int_{0}^{1} |u'(r^{1/(1+\beta)})|^{N} r^{(N-1-\beta)/(1+\beta)} dr
$$
\n
$$
= \omega_{N-1} \int_{0}^{1} |u'(t)|^{N} t^{N-1} dt = \int_{\mathbb{B}} |\nabla u|^{N} dx
$$
\n(9)

and

$$
\int_{\mathbb{B}} e^{\gamma |u| \frac{N}{N-1}} |x|^{N\beta} dx = \omega_{N-1} \int_0^1 e^{\gamma |u(r)| \frac{N}{N-1}} r^{N-1+N\beta} dr
$$
\n
$$
= \omega_{N-1} \int_0^1 e^{\frac{\gamma}{1+\beta} |v(r| + \beta)| \frac{N}{N-1}} r^{N-1+N\beta} dr
$$
\n
$$
= \frac{\omega_{N-1}}{1+\beta} \int_0^1 e^{\frac{\gamma}{1+\beta} |v(r)| \frac{N}{N-1}} r^{N-1} dr = \frac{1}{1+\beta} \int_{\mathbb{B}} e^{\frac{\gamma}{1+\beta} |v| \frac{N}{N-1}} dx. \tag{10}
$$

Then it follows from (9) , (10) and (5) that

$$
\sup_{u \in W_0^{1,N}(\mathbb{B}) \cap \mathscr{S}, ||u||_{W_0^{1,N}(\mathbb{B})} \le 1} \int_{\mathbb{B}} e^{\gamma |u|^{\frac{N}{N-1}}} |x|^{N\beta} dx = \frac{1}{1+\beta} \sup_{v \in W_0^{1,N}(\mathbb{B}), ||v||_{W_0^{1,N}(\mathbb{B})} \le 1} \int_{\mathbb{B}} e^{\frac{\gamma}{1+\beta}|v|^{\frac{N}{N-1}}} dx. \tag{11}
$$

According to Carleson-Chang [\[5](#page-10-2)], the supremum on the right-hand side of [\(11\)](#page-3-2) can be attained, so does the supremum on the left-hand side. This concludes Theorem [1.](#page-1-3)

3. Proof of Theorem [2](#page-2-2)

In this section, we use the standard blow-up analysis to prove Theorem [2.](#page-2-2) This method was originally introduced by Ding-Jost-Li-Wang [\[9](#page-10-10)] and Li [\[17,](#page-11-13) [18\]](#page-11-14), and extensively employed by Yang [\[34,](#page-11-8) [35,](#page-11-15) [36,](#page-11-16) [37](#page-11-17)], Lu-Yang [\[23\]](#page-11-18), Li-Ruf [\[19\]](#page-11-19), Zhu [\[41](#page-11-9)], do Ó-de Souza [\[10,](#page-10-11) [11](#page-10-12)], Li-Yang [\[16\]](#page-11-20), Li [\[15\]](#page-10-13), Nguyen [\[25](#page-11-21), [26\]](#page-11-11) and others. Comparing with the case $p \le N$ [\[41,](#page-11-9) [26](#page-11-11)], we need more analysis to deal with the general case $p > 1$.

3.1. The existence of maximizers for subcritical functionals

Let $\alpha < \lambda_p(\mathbb{B})$. Denote

$$
\Lambda_{\gamma,\alpha} = \sup_{u \in W_0^{1,N}(\mathbb{B}),\,||u||_{1,\alpha} \leq 1} \int_{\mathbb{B}} e^{\gamma |u|^{\frac{N}{N-1}}} dx.
$$

Lemma 4. *For any positive integer k, there exists a decreasing radially symmetric function* $u_k \in W_0^{1,N}(\mathbb{B}) \cap C^1(\overline{\mathbb{B}})$ with $||u_k||_{1,\alpha} = 1$ such that $\int_{\mathbb{B}} e^{\gamma_k |u_k|^{\frac{N}{N-1}}} dx = \Lambda_{\gamma_k,\alpha}$, where $\gamma_k = \alpha_N - 1/k$. *Moreover, u^k satisfies the Euler-Lagrange equation*

$$
\begin{cases}\n-\Delta_N u_k - \alpha \left(\int_{\mathbb{B}} u_k^p dx \right)^{\frac{N}{p}-1} u_k^{p-1} = \frac{1}{\lambda_k} u_k^{\frac{1}{N-1}} e^{\gamma_k u_k^{\frac{N}{N-1}}} \\
u_k \ge 0 \quad \text{in} \quad \mathbb{B} \\
u_k = 0 \quad \text{on} \quad \partial \mathbb{B} \\
\lambda_k = \int_{\mathbb{B}} u_k^{\frac{N}{N-1}} e^{\gamma_k u_k^{\frac{N}{N-1}}} dx,\n\end{cases} \tag{12}
$$

 $where \Delta_N u_k = \text{div}(|\nabla u_k|^{N-2} \nabla u_k).$

Proof. Let *k* be a positive integer. By a rearrangement argument, there exists a sequence of decreasing radially symmetric functions $u_j \in W_0^{1,N}(\mathbb{B})$ with $||u_j||_{1,\alpha} \le 1$ and $\int_{\mathbb{B}} e^{\gamma_k|u_j|^{\frac{N}{N-1}}} dx \to$ $\Lambda_{\gamma_k,\alpha}$ as $j \to \infty$. Since $\alpha < \lambda_p(\mathbb{B})$, u_j is bounded in $W_0^{1,N}(\mathbb{B})$. Without loss of generality, we assume u_j converges to some function u_k weakly in $W_0^{1,N}(\mathbb{B})$, strongly in $L^s(\mathbb{B})$ for any $s > 1$ and almost everywhere in \mathbb{B} . If $u_k \equiv 0$, then $||u_j||_{W_0^{1,N}(\mathbb{B})} \le 1 + o_j(1)$. Thus $e^{\gamma_k u_j^{N/(N-1)}}$ is bounded in $L^q(\mathbb{B})$ for some $q > 1$. It follows that $e^{\gamma_k u_j^{N/(N-1)}}$ converges to 1 in $L^1(\mathbb{B})$. This implies that $\Lambda_{\gamma_k, \alpha} = |\mathbb{B}|$, the volume of \mathbb{B} , which is impossible. Therefore $u_k \neq 0$. Clearly u_k is also decreasingly radially symmetric and $||u_k||_{1,\alpha} \leq 1$. Define a function sequence

$$
v_j = \frac{u_j}{\left(1 + \alpha (\int_{\mathbb{B}} u_j^p dx)^{N/p}\right)^{1/N}}.
$$

It follows that $||v_j||_{W_0^{1,N}(\mathbb{B})} \le 1$, v_j converges to $v_k = u_k/(1 + \alpha(\int_{\mathbb{B}} u_k^p)$ $\int_{k}^{p} dx$)^{*N*}/*p*)^{1/*N*} weakly in *W*₀^{1,*N*}(\mathbb{B}). By a result of Lions ([\[22\]](#page-11-22), Theorem I.6), for any $q < 1/(1 - ||v_k||_u^N)$ $W_{W_0^{1,N}(\mathbb{B})}^{N}$ ^{1/(N−1)}, there holds

$$
\lim_{j \to \infty} \int_{\mathbb{B}} e^{q \alpha_N v_j^{\frac{N}{N-1}}} dx < \infty. \tag{13}
$$

0

One can easily check that

$$
\left(1 + \alpha \left(\int_{\mathbb{B}} u_k^p dx\right)^{N/p}\right) \left(1 - ||v_k||_{W_0^{1,N}(\mathbb{B})}^N\right) = 1 - ||u_k||_{1,\alpha}^N < 1. \tag{14}
$$

It follows from [\(13\)](#page-4-0) and [\(14\)](#page-4-1) that $e^{\gamma_k u_j^{N/(N-1)}}$ is bounded in $L^r(\mathbb{B})$ for some $r > 1$, and thus $e^{\gamma_k u_j^{N(N-1)}} \to e^{\gamma_k u_k^{N(N-1)}}$ in $L^1(\mathbb{B})$ as $j \to \infty$. Hence $\int_{\mathbb{B}} e^{\gamma_k u_k^{N(N-1)}} dx = \Lambda_{\gamma_k,\alpha}$ and u_k is the desired extremal function. Clearly $||u_k||_{1,\alpha} = 1$. Moreover, the Euler-Lagrange equation of u_k is [\(12\)](#page-4-2). According to the regularity theory for degenerate elliptic equations, see Serrin [\[30](#page-11-23)], Tolksdorf [\[32\]](#page-11-24) and Lieberman [\[20](#page-11-25)], we have $u_k \in C^1$ $\overline{(\mathbb{B})}$.

It is indicated by Lemma [4](#page-4-3) that for any $\gamma < \alpha_N$ and $\alpha < \lambda_p(\mathbb{B})$, the supremum $\Lambda_{\gamma,\alpha}$ can be attained. In particular, for any $\gamma_k = \alpha_N - 1/k$, there exists a maximizer $u_k \ge 0$ satisfies [\(12\)](#page-4-2). It is not difficult to see that

$$
\lim_{k \to \infty} \int_{\mathbb{B}} e^{\gamma_k u_k^{\frac{N}{N-1}}} dx = \Lambda_{\alpha_N, \alpha} = \sup_{\substack{u \in W_0^{1,N}(\mathbb{B}), ||u||_{1,\alpha} \le 1}} \int_{\mathbb{B}} e^{\alpha_N |u|^{\frac{N}{N-1}}} dx.
$$
 (15)

Since $||u_k||_{1,\alpha} = 1$, without loss of generality, we can assume that u_k converges to u_0 weakly in $W_0^{1,N}(\mathbb{B})$, strongly in $L^s(\mathbb{B})$ for any $s > 1$, and almost everywhere in \mathbb{B} . Let $c_k = u_k(0) = \max_{\mathbb{B}} u_k$. If c_k is bounded, then applying the Lebesgue dominated convergence theorem to [\(15\)](#page-4-4), we know that u_0 is the desired extremal function for the supremum $\Lambda_{\alpha_N,\alpha}$. Hereafter we assume

$$
c_k \to \infty \quad \text{as} \quad k \to \infty. \tag{16}
$$

Lemma 5. Let u_0 be the limit of u_k as above. Then $u_0 \equiv 0$ and $|\nabla u_k|^N dx \to \delta_0$ weakly in the *sense of measure, where* δ_0 *stands for the Dirac measure centered at the origin.*

Proof. We first prove $u_0 \equiv 0$. Suppose not. It follows from Lions' lemma that $e^{\gamma k u_k^{N/(N-1)}}$ is bounded in $L^q(\mathbb{B})$ for some $q > 1$. Then applying elliptic estimates to [\(12\)](#page-4-2), we conclude u_k is uniformly bounded in B, which contradicts our assumption [\(16\)](#page-5-0). Therefore $u_0 \equiv 0$.

Next we prove $|\nabla u_k|^N dx \to \delta_0$. Suppose not. Since $||u_k||_{1,\alpha} = 1$ and $u_0 \equiv 0$, there would hold $||u_k||_{W_0^{1,N}(\mathbb{B})} = 1 + o_k(1)$. Thus there exists some $0 < r_0 < 1$ such that

$$
\limsup_{k\to\infty}\int_{|x|\le r_0}|\nabla u_k|^Ndx<1.
$$

It follows from the classical Trudinger-Moser inequality [\(1\)](#page-0-0) that $e^{\gamma_k(u_k - u_k(r_0))^{N/(N-1)}}$ is bounded in $L^q(B_{r_0})$ for some $q > 1$. Since u_k is decreasing radially symmetric and $||u_k||_{1,\alpha} = 1$ with $\alpha < \lambda_p(\mathbb{B})$, we have

$$
u_k^N(r_0) \leq \left(\frac{1}{|B_{r_0}|}\int_{|x|\leq r_0} u_k^p dx\right)^{N/p} \leq \frac{1}{(\lambda_p(\mathbb{B}) - \alpha)|B_{r_0}|^{N/p}}.
$$

Hence $e^{\gamma_k u_k^{N/(N-1)}}$ is also bounded in $L^{q_1}(B_{r_0})$ for some $q_1 > 1$. Then applying elliptic estimates to [\(12\)](#page-4-2), we conclude that u_k is uniformly bounded in $\mathbb B$. This contradicts [\(16\)](#page-5-0) and ends the proof of the lemma. \square

3.2. Blow-up analysis

Let $r_k = \lambda_k^{\frac{1}{N}} c_k^{-\frac{1}{N-1}} e^{-\frac{\gamma_k}{N} c_k^{N/(N-1)}}$. Using the same argument as in the proof of ([\[34](#page-11-8)], Lemma 4.3), one has by Lemma [5](#page-5-1) and the classical Trudinger-Moser inequality [\(1\)](#page-0-0) that

$$
r_k e^{au_k^{N/(N-1)}} \to 0 \quad \text{as } k \to \infty, \ \forall a < \alpha_N / N. \tag{17}
$$

For $x \in B_{r_k^{-1}}$, we define $\psi_k(x) = c_k^{-1} u_k(r_k x)$ and $\varphi_k(x) = c_k^{\frac{1}{N-1}} (u_k(r_k x) - c_k)$.

Lemma 6. *Up to a subsequence, there holds* $\psi_k \to 1$ *in* $C^1_{loc}(\mathbb{R}^N)$ *and* $\varphi_k \to \varphi$ *in* $C^1_{loc}(\mathbb{R}^N)$ *as* $k \rightarrow \infty$ *, where*

$$
\varphi(x) = -\frac{N-1}{\alpha_N} \log \left(1 + \frac{\alpha_N}{N^{N/(N-1)}} |x|^{\frac{N}{N-1}} \right). \tag{18}
$$

Proof. A simple calculation gives

$$
-\Delta_N \psi_k = \alpha c_k^{p-N} r_k^N ||u_k||_p^{N-p} \psi_k^{p-1} + c_k^{-N} e^{\gamma_k (u_k^{N/(N-1)} - c_k^{N/(N-1)})} \psi_k^{1/(N-1)}
$$
(19)

and

$$
-\Delta_N \varphi_k = \alpha c_k^p r_k^N ||u_k||_p^{N-p} \psi_k^{p-1} + e^{\gamma_k (u_k^{N/(N-1)} - c_k^{N/(N-1)})} \psi_k^{1/(N-1)}.
$$
\n(20)

Since u_k is bounded in $L^p(\mathbb{B})$, one has by [\(16\)](#page-5-0) and [\(17\)](#page-5-2) that

$$
\left(\int_{B_{r_k^{-1}}} \left(c_k^{p-N} r_k^N ||u_k||_p^{N-p} \psi_k^{p-1}\right)^{p/(p-1)} dx\right)^{(p-1)/p} = c_k^{1-N} r_k^{N/p} ||u_k||_p^{N-1} \to 0 \text{ as } k \to \infty. \tag{21}
$$

Since $0 \leq \psi_k \leq 1$, there holds

$$
c_k^{-N} e^{\gamma_k (u_k^{N/(N-1)} - c_k^{N/(N-1)})} \psi_k^{1/(N-1)} \to 0 \text{ as } k \to \infty.
$$
 (22)

It follows from [\(21\)](#page-6-0) and [\(22\)](#page-6-1) that $\Delta_N \psi_k$ is bounded in $L^{p/(p-1)}(B_{r_k^{-1}})$. Applying the regularity theory [\[32\]](#page-11-24) to [\(19\)](#page-5-3), one obtains

$$
\psi_k \to \psi \text{ in } C^0_{\text{loc}}(\mathbb{R}^N) \text{ as } k \to \infty,
$$
\n(23)

where

$$
\psi(0) = 1, \quad 0 \le \psi(x) \le 1, \ \forall x \in \mathbb{R}^N. \tag{24}
$$

When $1 < p \leq N$, one can easily see that

$$
c_k^p r_k^N ||u_k||_p^{N-p} \psi_k^{p-1} \to 0 \tag{25}
$$

uniformly in $x \in B_{r_k^{-1}}$ as $k \to \infty$. When $p > N$, we have for any $R > 0$ and sufficiently large k

$$
||u_k||_p^{N-p} = \left(\int_{\mathbb{B}} u_k^p dx\right)^{N/p-1} \le \left(\int_{B_{Rr_k}} u_k^p dx\right)^{N/p-1} = c_k^{N-p} r_k^{N^2/p-N} \left(\int_{B_R} \psi_k^p dx\right)^{N/p-1}.\tag{26}
$$

In view of [\(24\)](#page-6-2), we conclude $\int_{B_R} \psi^p dx > 0$, which together with [\(23\)](#page-6-3) and [\(26\)](#page-6-4) leads to

$$
||u_k||_p^{N-p} \le 2\left(\int_{B_R} \psi^p dx\right)^{N/p-1} c_k^{N-p} r_k^{N^2/p-N}
$$

for sufficiently large *k*. This together with [\(17\)](#page-5-2) gives

$$
c_k^p r_k^N ||u_k||_p^{N-p} \psi_k^{p-1} \le 2 \left(\int_{B_R} \psi^p dx \right)^{N/p-1} c_k^N r_k^{N^2/p} \to 0 \text{ as } k \to \infty.
$$
 (27)

It then follows from [\(25\)](#page-6-5) and [\(27\)](#page-6-6) that $\Delta_N \psi_k$ is bounded in $L^\infty(B_R)$. Applying again the regu-larity theory [\[32\]](#page-11-24) to [\(19\)](#page-5-3), we conclude that $\psi_k \to \psi$ in $C^1(B_{R/2})$. Since *R* is arbitrary, up to a subsequence, there holds

$$
\psi_k \to \psi
$$
 in $C^1_{loc}(\mathbb{R}^N)$ as $k \to \infty$,

where ψ is a solution of

$$
-\Delta_N \psi = 0 \text{ in } \mathbb{R}^N, \quad 0 \le \psi \le \psi(0) = 1.
$$

The Liouville theorem implies that $\psi \equiv 1$ in \mathbb{R}^N .

Recalling [\(25\)](#page-6-5) and [\(27\)](#page-6-6), c_k^p $\int_k^p r_k^N ||u_k||_p^{N-p} \psi_k^{p-1} \to 0$ in $L_{loc}^{\infty}(\mathbb{R}^N)$. Then using the same argument as in ([\[19\]](#page-11-19), Section 3) or ([\[16\]](#page-11-20), Lemma 17), we have by applying elliptic estimates to [\(20\)](#page-6-7),

$$
\varphi_k \to \varphi
$$
 in $C^1_{loc}(\mathbb{R}^N)$ as $k \to \infty$,

where φ satisfies

$$
\begin{cases}\n-\Delta_N \varphi = e^{\alpha_N \frac{N}{N-1} \varphi} & \text{in} \quad \mathbb{R}^N \\
\sup_{\mathbb{R}^N} \varphi = \varphi(0) = 0.\n\end{cases}
$$

Observing that φ is radially symmetric, one gets [\(18\)](#page-5-4) by solving the corresponding ordinary differential equation.

Lemma [6](#page-5-5) describes the asymptotic behavior of u_k near the blow-up point 0. To know u_k 's behavior away from 0, by the same argument as in the proof of ([\[34\]](#page-11-8), Lemma 4.11), we have that

$$
\begin{cases}\n c_k^{1/(N-1)} u_k \rightharpoonup G & \text{weakly in} \\
 c_k^{1/(N-1)} u_k \rightharpoonup G & \text{strongly in} \\
 c_k^{1/(N-1)} u_k \rightharpoonup G & \text{in} \\
 c_k^{1/(N-1)} u_k \rightharpoonup G & \text{in} \\
 c_{\text{loc}}^{1}(\overline{\mathbb{B}} \setminus \{0\}),\n\end{cases}\n\quad\n\begin{cases}\n c_1^{1/(N-1)} u_k \rightharpoonup G & \text{in} \\
 c_{\text{loc}}^{1}(\overline{\mathbb{B}} \setminus \{0\}),\n\end{cases}
$$

where *G* is a distributional solution of

$$
-\Delta_N G - \alpha ||G||_p^{N-p} G^{p-1} = \delta_0 \quad \text{in} \quad \mathbb{B}.
$$
 (28)

According to Kichenassamy-Veron [\[14](#page-10-14)], *G* can be represented by

$$
G(x) = -\frac{N}{\alpha_N} \log |x| + A_0 + w(x),
$$

where A_0 is a constant, $w \in C^{\nu}(\mathbb{B})$ for some $0 < \nu < 1$ and $w(0) = 0$. In view of [\(15\)](#page-4-4), we also have an analog of ([\[34\]](#page-11-8), Proposition 5.2), namely

$$
\Lambda_{\alpha_N,\alpha} \leq |\mathbb{B}| + \frac{\omega_{N-1}}{N} e^{\alpha_N A_0 + \sum_{j=1}^{N-1} \frac{1}{j}}.
$$
 (29)

For its proof, since no new idea comes out, we omit the details but refer the readers to [\[34\]](#page-11-8) (see also [\[41](#page-11-9), [15](#page-10-13), [25](#page-11-21)]).

3.3. Test function computation

In this subsection, we construct a sequence of functions to show that

$$
\Lambda_{\alpha_N,\alpha} > |\mathbb{B}| + \frac{\omega_{N-1}}{N} e^{\alpha_N A_0 + \sum_{j=1}^{N-1} \frac{1}{j}}.
$$
\n(30)

The contradiction between [\(30\)](#page-7-0) and [\(29\)](#page-7-1) indicates that c_k is a bounded sequence, and whence the desired extremal function exists. This completes the proof of Theorem [2.](#page-2-2)

For any positive integer *k*, we set

$$
\phi_k(x) = \begin{cases}\n c + \frac{1}{c^{1/(N-1)}} \left(-\frac{N-1}{\alpha_N} \log(1 + c_N |kx|^{\frac{N}{N-1}}) + b \right), & |x| < \frac{\log k}{k} \\
 \frac{G}{c^{1/(N-1)}}, & 8\n \end{cases}\n \tag{31}
$$

where *c* and *b* are constants, depending only on *k*, to be determined later. To ensure $\phi_k \in W_0^{1,N}(\mathbb{B})$, we need $\ln \alpha k$

$$
c + \frac{1}{c^{1/(N-1)}} \left(-\frac{N-1}{\alpha_N} \log(1 + c_N |\log k|^{\frac{N}{N-1}}) + b \right) = \frac{G(\frac{\log k}{k})}{c^{1/(N-1)}},
$$

which implies that

$$
c^{\frac{N}{N-1}} = G(\frac{\log k}{k}) + \frac{N-1}{\alpha_N} \log(1 + c_N(\log k)^{\frac{N}{N-1}}) - b.
$$
 (32)

We now calculate the energy of ϕ_k . In view of [\(31\)](#page-7-2), a straightforward calculation gives

$$
\int_{|x| < \frac{\log k}{k}} |\nabla \phi_k|^N dx = \frac{1}{c^{N/(N-1)}} \frac{N-1}{\alpha_N} \left\{ -\sum_{j=1}^{N-1} \frac{1}{j} + \log(1 + c_N (\log k)^{\frac{N}{N-1}}) + O((\log k)^{-\frac{N}{N-1}}) \right\}.
$$

By [\(28\)](#page-7-3) and the divergence theorem

$$
\int_{\frac{\log k}{k} \leq |x| \leq 1} |\nabla G|^{N} dx = \int_{\frac{\log k}{k} \leq |x| \leq 1} G(-\Delta_{N}G) dx + \int_{|x| = \frac{\log k}{k}} G|\nabla G|^{N-1} ds
$$
\n
$$
= \alpha (\int_{\frac{\log k}{k} \leq |x| \leq 1} G^{p} dx)^{N/p} + G(\frac{\log k}{k}) \int_{|x| = \frac{\log k}{k}} |\nabla G|^{N-1} ds
$$
\n
$$
= G(\frac{\log k}{k}) + \alpha (\int_{\mathbb{B}} G^{p} dx)^{N/p} + O\left(\frac{(\log k)^{N+p-1}}{k^{N}}\right).
$$

As a consequence

$$
\int_{\mathbb{B}} |\nabla \phi_k(x)|^N dx = \frac{1}{c^{N/(N-1)}} \left\{ -\frac{N-1}{\alpha_N} \sum_{j=1}^{N-1} \frac{1}{j} + \frac{N-1}{\alpha_N} \log(1 + c_N (\log k)^{\frac{N}{N-1}}) + G(\frac{\log k}{k}) + \alpha (\int_{\mathbb{B}} G^p dx)^{N/p} + O((\log k)^{-\frac{N}{N-1}}) \right\}.
$$

Noting also that

$$
\left(\int_{\mathbb{B}} \phi_k^p(x) dx\right)^{N/p} = \frac{1}{c^{N/(N-1)}} \left(\int_{\mathbb{B}} G^p dx + O(\frac{(\log k)^{2N}}{k^N})\right)^{N/p},
$$

we obtain

$$
\|\phi_k\|_{1,\alpha}^N = \frac{1}{c^{N/(N-1)}} \left(-\frac{N-1}{\alpha_N} \sum_{j=1}^{N-1} \frac{1}{j} + \frac{N-1}{\alpha_N} \log(1 + c_N (\log k)^{\frac{N}{N-1}}) + G(\frac{\log k}{k}) + O((\log k)^{-\frac{N}{N-1}}) \right).
$$

Set $\|\phi_k\|_{1,\alpha} = 1$. It then follows that

$$
c^{\frac{N}{N-1}} = \frac{N}{\alpha_N} \log k - \frac{N-1}{\alpha_N} \sum_{j=1}^{N-1} \frac{1}{j} + \frac{N-1}{\alpha_N} \log c_N + A_0 + O((\log k)^{-\frac{N}{N-1}}). \tag{33}
$$

This together with [\(32\)](#page-8-0) leads to

$$
b = \frac{N-1}{\alpha_N} \sum_{j=1}^{N-1} \frac{1}{j} + O((\log k)^{-\frac{N}{N-1}}). \tag{34}
$$

When $|x| < \frac{\log k}{k}$ $\frac{g}{k}$, we calculate

$$
\alpha_N \phi_k^{\frac{N}{N-1}}(x) = \alpha_N c^{\frac{N}{N-1}} \left(1 + \frac{1}{c^{N/(N-1)}} \left(-\frac{N-1}{\alpha_N} \log(1 + c_N |kx|^{\frac{N}{N-1}}) + b \right) \right)^{\frac{N}{N-1}}
$$

\n
$$
\geq \alpha_N c^{\frac{N}{N-1}} \left(1 + \frac{N}{N-1} \frac{1}{c^{N/(N-1)}} \left(-\frac{N-1}{\alpha_N} \log(1 + c_N |kx|^{\frac{N}{N-1}}) + b \right) \right)
$$

\n
$$
= \alpha_N c^{\frac{N}{N-1}} + \frac{N \alpha_N b}{N-1} - N \log(1 + c_N |kx|^{\frac{N}{N-1}}). \tag{35}
$$

In view of [\(33\)](#page-8-1) and [\(34\)](#page-9-0),

$$
\alpha_N c^{\frac{N}{N-1}} + \frac{N\alpha_N b}{N-1} = N \log k + \sum_{j=1}^{N-1} \frac{1}{j} + (N-1) \log c_N + \alpha_N A_0 + O((\log k)^{-\frac{N}{N-1}}). \tag{36}
$$

Moreover, integration by parts leads to

$$
\int_{|x| < \frac{\log k}{k}} e^{-N \log(1 + c_N |kx|^{\frac{N}{N-1}})} dx = k^{-N} \int_{|y| < \log k} \frac{dy}{(1 + c_N |y|^{\frac{N}{N-1}})^N}
$$
\n
$$
= k^{-N} \int_0^{(\log k)^{\frac{N}{N-1}}} \frac{N - 1}{N} \frac{t^{N-2} dt}{(1 + c_N t)^N}
$$
\n
$$
= k^{-N} (1 + O((\log k)^{-\frac{N}{N-1}})). \tag{37}
$$

Combining [\(35\)](#page-9-1), [\(36\)](#page-9-2) and [\(37\)](#page-9-3), we obtain

$$
\int_{|x| < \frac{\log k}{k}} e^{\alpha_N \phi_k^{\frac{N}{N-1}}(x)} dx \ge \frac{\omega_{N-1}}{N} e^{\alpha_N A_0 + \sum_{j=1}^{N-1} \frac{1}{j}} + O((\log k)^{-\frac{N}{N-1}}). \tag{38}
$$

Using an inequality $e^t \geq 1 + t$, we have

 $\ddot{}$

$$
\int_{\frac{\log k}{k} \le |x| \le 1} e^{\alpha_N \phi_k^{\frac{N}{N-1}}(x)} dx \ge |\mathbb{B}| + \frac{\alpha_N \int_{\mathbb{B}} G^{\frac{N}{N-1}} dx}{c^{N/(N-1)^2}} + O((\log k)^{-\frac{N}{N-1}}). \tag{39}
$$

Then [\(30\)](#page-7-0) follows from [\(38\)](#page-9-4) and [\(39\)](#page-9-5) immediately.

4. Proof of Theorem [3](#page-2-4)

As in the proof of Theorem [1,](#page-1-3) we set $v(r) = (1 + \frac{p}{N})$ $\frac{p}{N}\beta$ ^{1–1/*N*}*u*($r^{1/(1+\frac{p}{N}\beta)}$). Note that

$$
\int_{\mathbb{B}} |u|^p |x|^{p\beta} dx = \omega_{N-1} \int_0^1 |u(r)|^p r^{N-1+p\beta} dr
$$
\n
$$
= \frac{\omega_{N-1}}{(1 + \frac{p}{N}\beta)^{p-p/N}} \int_0^1 |v(r^{1+\beta})|^N r^{N-1+N\beta} dr
$$
\n
$$
= \frac{\omega_{N-1}}{(1 + \frac{p}{N}\beta)^{p+1-p/N}} \int_0^1 |v(t)|^N t^{N-1} dt = \frac{1}{(1 + \frac{p}{N}\beta)^{p+1-p/N}} \int_{\mathbb{B}} |v|^p dx.
$$

Similar calculations as in [\(9\)](#page-3-0) and [\(10\)](#page-3-1) tell us that

$$
\sup_{u \in W_0^{1,N}(\mathbb{B}) \cap \mathcal{S}, \int_{\mathbb{B}} |\nabla u|^N dx - \alpha(\int_{\mathbb{B}} |u|^p |x|^{p\beta} dx)^{N/p} \le 1} \int_{\mathbb{B}} e^{\gamma |u|^{\frac{N}{N-1}}} |x|^{p\beta} dx
$$
\n
$$
= \frac{1}{1 + \frac{p}{N}\beta} \sup_{v \in W_0^{1,N}(\mathbb{B}) \cap \mathcal{S}, \int_{\mathbb{B}} |\nabla v|^N dx - \frac{\alpha}{(1 + \frac{p}{N}\beta)^{N-1+N/p}} (\int_{\mathbb{B}} |v|^p dx)^{N/p} \le 1} \int_{\mathbb{B}} e^{\frac{\gamma}{1 + \frac{\gamma}{N}\beta} |v|^{\frac{N}{N-1}}} dx. \tag{40}
$$

By a rearrangement argument, we have

$$
\sup_{v \in W_0^{1,N}(\mathbb{B}) \cap \mathscr{S}, \int_{\mathbb{B}} |\nabla v|^N dx - \frac{\alpha}{(1 + \frac{p}{N}\beta)^{N-1+N/p}} (\int_{\mathbb{B}} |v|^p dx)^{N/p} \le 1} \int_{\mathbb{B}} e^{\frac{\gamma}{1 + \frac{p}{N}\beta} |v|^{\frac{N}{N-1}}} dx
$$
\n
$$
= \sup_{v \in W_0^{1,N}(\mathbb{B}), \int_{\mathbb{B}} |\nabla v|^N dx - \frac{\alpha}{(1 + \frac{p}{N}\beta)^{N-1+N/p}} (\int_{\mathbb{B}} |v|^p dx)^{N/p} \le 1} \int_{\mathbb{B}} e^{\frac{\gamma}{1 + \frac{p}{N}\beta} |v|^{\frac{N}{N-1}}} dx. \tag{41}
$$

Since $\alpha < (1 + \frac{p}{N})$ $\frac{p}{N}$ β)^{*N*-1+*N*/*p*} λ_p (\mathbb{B}) and $\gamma \le \alpha_N(1 + \frac{p}{N})$ $\frac{p}{N}$ β), in view of [\(40\)](#page-10-15) and [\(41\)](#page-10-16), Theorem [3](#page-2-4) follows from Theorem [2](#page-2-2) immediately.
