# NONLINEAR STABILITY AND EXISTENCE OF VORTEX SHEETS FOR INVISCID LIQUID-GAS TWO-PHASE FLOW

#### Abstract

We are concerned with the vortex sheet solutions for the inviscid two-phase flow in two dimensions. In particular, the nonlinear stability and existence of compressible vortex sheet solutions under small perturbations are established by using a modification of the Nash-Moser iteration technique, where a priori estimates for the linearized equations have a loss of derivatives. Due to the jump of the normal derivatives of densities of liquid and gas, we obtain the normal estimates in the anisotropic Sobolev space, instead of the usual Sobolev space. New ideas and techniques are developed to close the energy estimates and derive the tame estimates for the two-phase flows.


## 1. Introduction

Two-phase flows or multi-phase flows are important in many industrial applications, for instance, in aerospace, chemical engineering, micro-technology and so on. They have attracted studies from many mechanical engineers, geophysicists and astrophysicists. In multi-phase flows, two or more states of matters are considered simultaneously. We focus on the mixed flow of liquid and gas, which is an interesting phenomenon in nature that occurs in boilers, condensers, pipelines for oil and natural gas, etc. For more physical background, we refer the readers to [31]. In this paper, we consider the following compressible inviscid liquid-gas two-phase isentropic flow of drift-flux type:

where, $m=\alpha_{g} \rho_{g}$ and $n=\alpha_{l} \rho_{l}$ represent the mass of gas and liquid respectively, $\alpha_{g}, \alpha_{l} \in$ $[0,1]$ are the gas and liquid volume fractions satisfying $\alpha_{g}+\alpha_{l}=1, \rho_{g}$ and $\rho_{l}$ denote the density of gas and liquid respectively; $p$ is the pressure of two phases, $\mathbf{u}_{\mathbf{g}}, \mathbf{u}_{\mathbf{1}}$ denote the velocity of gas and liquid respectively. Here, we study the simplified two-phase flows, assuming that the velocities of gas and liquid are equal in the fluid region, $\mathbf{u}_{\mathbf{g}}=\mathbf{u}_{\mathbf{l}}=\mathbf{u}$. It is also quite interesting to study the slip case, i.e., the two phase velocities are different. Due to the fact that the liquid phase is much heavier than the gas phase, the momentum of gas phase in the mixture momentum equations is small in comparison with that of liquid

[^0]phase and thus neglected. Hence, we write the simplified model as follows:

We will follow the simplification of pressure term $p(m, n)$ as in [13]. It guarantees that the model is consistent in the sense of thermal-mechanics, which helps to get basic energy estimate. The pressure term $p$ is a smooth function of $(m, n)$ defined on $(0,+\infty) \times(0,+\infty)$. We take the pressure of the following form:

where $c_{1}, c_{2}$ are two positive constants and $P=P(\rho)$ is a smooth function. For example, the pressure satisfies $\gamma$-law $P(\rho)=\rho^{\gamma-1}, \gamma>1$. Without loss of generality, we take $c_{1}=$ $c_{2}=1$ and take the pressure term as

The system (1.2) is a non-strictly hyperbolic system of conservation law in the region $(m, n) \in(0, \infty) \times(0, \infty)$.

For the viscous two-phase flow, the well-posedness in various one-dimensional and multidimensional cases has been studied in [11, 14, 17, 18, 20]. For the inviscid two-phase flow, limited theoretic works have been done before. We are concerned with the vortex sheet problem for the two phase-flow (1.2) in the two-dimensional space $\mathbb{R}^{2}$. Vortex sheet is a surface across which there is a discontinuity in the fluid tangential velocity, such as in slippage of one layer of fluid over another. The tangential components of the flow velocity are discontinuous across the vortex sheet, however, the normal component of the flow velocity is continuous. For a brief introduction to the compressible vortex sheets in the applications of multi-dimensional hyperbolic conservation laws, please refer to [19, 34 and for the related studies of incompressible flows, please refer to [22, 23, 39, 43] and their references.

Our paper is inspired by the stability of planar and rectilinear vortex sheets for the compressible isentropic Euler equations [9, 10], the non-isentropic Euler equations [27] and the ideal compressible MHD equations [2,37]. The linear stability of compressible vortex sheets for the isentropic Euler equations in two dimensions was studied by CoulombelSecchi [9]. Using the linear analysis and Nash-Moser technique, the nonlinear stability for the compressible Euler equations was proved in [10]. These two papers are the pioneering work of compressible vortex sheets. Later on, the result on the linear stability for the isentropic Euler equations was extended to the non-isentropic Euler equations in [27] (see also [28] for a very recent preprint on nonlinear stability). Recently, Morando-SecchiTrebeschi in [26] provided an alternative way to prove the linear stability of compressible vortex sheets in two space dimensions using the evolution equation for the discontinuity front of the vortex sheet. For the MHD equations, the linear and nonlinear stability of compressible current-vortex sheets was proved in [2,37,41]. Recently, Chen-Hu-Wang [4],6] studied the linear and nonlinear stability of compressible vortex sheets in two dimensional elastodynamics, using the method of upper triangularization, delicate spectrum analysis,
and Nash-Moser technique. Some other models of contact discontinuities can be found and have been studied in [3, 21, $29,38,40,42$.

In this paper, we establish the nonlinear stability and local existence of compressible vortex sheet solutions for the two-phase flow. Strongly motivated by the paper of Coulombel and Secchi [10, we extend the linear stability result in Ruan-Wang-Weng-Zhu [34] to the nonlinear stability using the estimates in anisotropic Sobolev spaces. The difficulty for the two-phase flow, compared with the Euler flow, is that the difference of the densities of the liquid and gas makes the analysis more complicated and much harder. We have one more equation and one more variable density than the Euler equations. Moreover, since the vortex sheet is a contact discontinuity, the free boundary is characteristic. The linearized problems could be solved with the price of a loss of derivatives. As usual, we are thus led to employing the Nash-Moser procedure to compensate the loss of derivatives with respect to the source terms in each iteration step. It requires to derive the tame estimates on the higher order derivatives of the solutions of the linear systems. If we adopt the usual method in [10, we also can estimate the normal derivatives, using certain vorticity equation that is a transport equation with some source containing lower order derivatives of the unknowns than the terms in certain form of transport equation. However, comparing this form of equations with the Euler equations, some new extra terms appear, which come from the jump of the normal derivatives of the density. These terms cannot be controlled in energy estimates. In order to overcome this new obstacle occurring in the normal derivatives, we restrict our solution into the anisotropic Sobolev space, instead of the usual Sobolev space. The key point is that the one-order gain of normal differentiation could be compensated by two-order loss of tangential differentiation. Using the weighted functions on the normal derivatives and the properties of the anisotropic space, we can close all the derivative estimates and derive the tame estimates. We can prove the weighted energy estimates for the equations with transport structures, even though the source terms contain some higher order derivatives. Applications of anisotropic spaces may be found in [7, 35]. We remark that in [34, a good symmetric form of the linearized version of liquid-gas two-phase flow was introduced, which plays a crucial role in the linear stability analysis. This symmetrizer is different from [10] and [27]. Focusing on the linearized problem with variable coefficients, we can prove the well-posedness for the effective linearized equations in $L^{2}$ where the source terms are in $L^{2}\left(H^{1}\right) \times H^{1}$. As a first step, we obtain the a priori estimates of the tangential derivatives. Next, we prove the unweighted and weighted normal derivatives in anisotropic spaces instead of the usual Sobolev spaces in [10. Finally, we obtain the whole a priori tame estimate in the weighted anisotropic Sobolev spaces, which is linearly dependent on higher order norms multiplied by the lower order norms. This is the key step to obtain the solvability of linearized equations in preparation for the Nash-Moser iteration. There is a fixed loss of derivatives with respect to the source terms and the coefficients. The idea in our paper can be also extended to study the nonlinear stability of non-isentropic two-phase flow. We remark that in the recent preprint [33], Ruan and Trakhinin introduced a different symmetrization for the two-phase flow models to prove the local existence of compressible shock waves and 2D compressible vortex sheets by the result in [28].

The rest of the paper is organized as follows. In Section 2, we introduce the set-up of the vortex sheet problem, and provide some definitions and notations. In Section 3, we first formulate the weighted Sobolev spaces and norms and then derive the effective
linearized equations. After that, we prove the well-posedness of the linearized problems. In Section 4. we construct the approximate solutions, which will be useful in Section 5, where the Nash-Moser iteration scheme is introduced to get the local existence of the linearized problems. In Section 6, we summarize all the tame estimates that will be needed in the proof of Theorem 2.1. In Section 7, we complete the proof of our main Theorem 2.1 by proving the convergence of the Nash-Moser scheme. In Appendices A and B, some basic estimates in weighted Sobolev spaces, anisotropic Sobolev spaces and the proof of a priori estimates of tangential derivatives are provided separately.

## 2. Vortex Sheet Problem

In this section, we shall introduce the vortex sheet problem and its formulation as an initial boundary-value problem for hyperbolic conservation laws. We will consider the liquid-gas two-phase flow (1.2) in the whole space $\mathbb{R}^{2}$. Let $\left(x_{1}, x_{2}\right)$ be the space variable in $\mathbb{R}^{2}$ and let $v$ and $u$ represent the components of two velocities, $\mathbf{u}=(v, u) \in \mathbb{R}^{2}$. Then, for

we can define the following matrices:

For simplicity, we write the spatial partial derivatives by $\partial_{1}=\partial_{x_{1}}, \partial_{2}=\partial_{x_{2}}$. When $(m, n, \mathbf{u})$ is smooth, (1.2) is equivalent to the following quasilinear form:

It is noted that the system (2.2) or (1.2) is linearly degenerate with respect to the second characteristic field. Hence, we focus on the vortex sheet (contact discontinuity) solutions for the two-phase flow.

Definition 2.1. Suppose that $(m, n, \mathbf{u})$ is a smooth function of $\left(t, x_{1}, x_{2}\right)$ on either side of a smooth surface $\Gamma:=\left\{x_{2}=\varphi\left(t, x_{1}\right), t>0, x_{1} \in \mathbb{R}\right\}$. Then, $(m, n, \mathbf{u})$ is a weak solution of (1.2) if and only if $(m, n, \mathbf{u})$ is a classical solution of (1.2) on both sides of $\Gamma$ and the Rankine-Hugoniot conditions hold at each point of $\Gamma$ :

where $\nu:=\left(-\partial_{1} \varphi, 1\right)$ is a spatial normal vector to $\Gamma$, and $[q]=q^{+}-q^{-}$denotes the jump of a quantity $q$ across the interface $\Gamma$.

Following the definition of contact discontinuity solutions in the sense of Lax [24], we present the definition of a vortex sheet solution of the liquid-gas two-phase flow.

Definition 2.2. A piecewise smooth function $(m, n, \mathbf{u})$ is a vortex sheet solution of (1.2) if $(m, n, \mathbf{u})$ is a classical solution of (1.2) on either side of the surface $\Gamma$ and the RankineHugoniot conditions (2.3) hold at each point of $\Gamma$ as follows:

Since $p$ is monotone, the previous relations in (2.4) read

Then we can formulate the vortex sheet problem as the following free-boundary value problem: determine

satisfying the Rankine-Hugoniot conditions on $\Gamma$ :

where $\varphi_{0}\left(x_{1}\right)=\varphi\left(0, x_{1}\right)$. To prove the existence of vortex sheet solutions for the freeboundary problem (2.6) and (2.7), we need to find a solution $U\left(t, x_{1}, x_{2}\right)$ and $\varphi\left(t, x_{1}\right)$ of the problem (2.6) and (2.7) at least locally in time. In this paper, we establish the nonlinear stability of the linearized problem resulting from the linearization of (2.6) and (2.7) around a background vortex sheet (piecewise constant) solution. It is convenient to reformulate the problem in the fixed domain $\left\{t \in[0, T], x_{1} \in \mathbb{R}, x_{2} \geq 0\right\}$ by introducing a change of variables which can be found in [9]. After fixing the unknown front, we construct smooth solutions $U^{ \pm}=\left(m^{ \pm}, n^{ \pm}, v^{ \pm}, u^{ \pm}\right)^{\top}, \Phi^{ \pm}$from the following system:

Here, $I_{4 \times 4}$ denotes the $4 \times 4$ identity matrix in (2.8). For the initial data, we write:

The functions $\Phi^{ \pm}$should satisfy

for some $\kappa>0$. For contact discontinuities, one can choose the change of variables $\Phi^{ \pm}$ satisfying the eikonal equations:

in the whole closed half-space $\left\{x_{2} \geq 0\right\}$. We can rewrite the equation (2.8) into a compact form by defining the left side as a differential operator $\mathbb{L}$. Then, the system (2.8) becomes

where $U$ denotes the vector $\left(U^{+}, U^{-}\right)$and $\Phi$ for $\left(\Phi^{+}, \Phi^{-}\right)$. The boundary conditions (2.9)(2.12) can be written into the following compact form:

There are many simple solutions of (2.16), (2.18), (2.15), and (2.14), that correspond to the stable background states:

for the two-phase flow system (1.2) in the original variables, where $\bar{m}^{ \pm}>0, \bar{n}^{ \pm}>0, \bar{v} \in \mathbb{R}$ are constants. In the straightened variables, these stationary vortex sheets correspond to the following smooth stationary solution to (2.16), (2.18), (2.15), and (2.14):

Here we assume $\bar{v}^{+}>0$ without loss of generality. We write piecewise constant functions (2.20) into the following form:

With the notations of Sobolev spaces and norms to be introduced in the next section, we state our main result as follows.

Theorem 2.1. Let $T>0, \alpha \in \mathbb{N}, \alpha \geq 15$, and the stationary solution defined by (2.21) satisfy the "supersonic" condition:

where $\bar{c}_{r, l}=\sqrt{\left(1+\frac{\bar{m}_{r, l}}{\bar{n}_{r, l}}\right) p_{n}\left(\bar{m}_{r, l}, \bar{n}_{r, l}\right)}$. Assume that the initial data $\left(U_{0}^{ \pm}, \varphi_{0}\right)$ has the form $U_{0}^{ \pm}=\bar{U}^{ \pm}+\dot{U}_{0}^{ \pm}$, with $\dot{U}_{0}^{ \pm} \in H_{*}^{2 \alpha+15}\left(\mathbb{R}_{+}^{2}\right)$ and $\varphi_{0} \in H^{2 \alpha+16}(\mathbb{R})$ compatible up to order $\alpha+7$ in the sense of Definition 4.1 and compactly supported. Then, there exists $\delta>0$, such that, if $\left[\dot{U}_{0}^{ \pm}\right]_{2 \alpha+15, *, T}+\left\|\varphi_{0}\right\|_{H^{2 \alpha+16}} \leq \delta$, (2.8) $-\left(\sqrt{2.15)}\right.$ has a unique solution $U^{ \pm}=$ $\bar{U}^{ \pm}+\dot{U}^{ \pm}, \Phi^{ \pm}= \pm x_{2}+\dot{\Phi}^{ \pm}, \varphi$ on $[0, T]$, satisfying $\left(\dot{U}^{ \pm}, \dot{\Phi}^{ \pm}\right) \in H_{*}^{\alpha-1}\left((0, T) \times \mathbb{R}_{+}^{2}\right)$, and $\varphi \in H^{\alpha}((0, T) \times \mathbb{R})$.

Remark 2.1. It is noted that when the support of $\varphi_{0}$ is included in $[-1,1]$ and the support of $\dot{U}_{0}^{ \pm}$is included in $\left\{x_{2} \geq 0, \sqrt{x_{1}^{2}+x_{2}^{2}} \leq 1\right\}$, the corresponding solution $\dot{U}^{ \pm}, \dot{\Phi}^{ \pm}, \varphi$ will have a compact support:

because of the finite speed of propagation of the two-phase flow equations and the eikonal equation, where $\lambda_{\max }$ is the maximum characteristic speed of the two-phase flow equations in a small neighborhood of the background state $\bar{U}^{ \pm}$.
Remark 2.2. For the critical case $\bar{v}_{r}-\bar{v}_{l}=\sqrt{2}\left(\bar{c}_{r}+\bar{c}_{l}\right)$, the linear stability with variable coefficients of compressible vortex sheets is still open for the two-phase flows 34 and non-isentropic Euler equations [27], due to the existence of double roots of the Lopatinskii determinant.

## 3. Tame Estimates for the Linearized Equations

3.1. Weighted spaces and norms. First, we introduce the weighted Sobolev spaces. Define the half-space

For all real numbers $s \in \mathbb{R}$ and $\lambda \geq 1$, we define the weighted space:

Now, we introduce the weighted anisotropic Sobolev space as in 11. For an integer $s \geq 0$ and a real number $\lambda \geq 1$, we define

Remark 3.1. The weight $\sigma\left(x_{2}\right)$ can also be assumed to satisfy $\sigma\left(x_{2}\right)=x_{2}$ for sufficiently small $x_{2}>0$.

For simplicity, we present the following trace theorem and extension theorem in the weighted anisotropic Sobolev spaces from [1].
Lemma 3.1. If $s>1$ and $u \in H_{*}^{s, \lambda}\left(\Omega_{T}\right)$, then $\left.u\right|_{x_{2}=0} \in H_{\lambda}^{s-1}\left(\omega_{T}\right)$ and

3.2. The effective linearized equations. We introduce the linearized equations around a state that is given as a perturbation of the stationary solution (2.21). We consider the following functions:

We shall solve the nonlinear problems (2.16), (2.18), (2.15), and (2.14) by constructing a sequence of linear equations of the form (3.11). The remaining terms in (3.9) are regarded as error terms in each iteration step. It is important to obtain energy estimates and define the dual problem. From previous analysis [34], we know that the effective linearized equation (3.9) form a symmetrizable hyperbolic system. The Friedrichs symmetrizer for the operator $\mathbb{L}_{e}^{\prime}\left(U_{r, l}, \Phi_{r, l}\right)$ is

We observe that the operator $\mathbb{B}_{e}^{\prime}$ only involves $\left.\mathbb{P}(\varphi) \dot{V}_{ \pm}\right|_{x_{2}=0}$. Here, $\mathbb{P}(\varphi)$ is defined by (3.14).
3.3. The basic $L^{2}$ a priori estimate. In [34], we have already derived $L^{2}$ a priori estimate for (3.11) and (3.16). We assume that the perturbations satisfy

3.4. Well-posedness of the linearized equations. In this section, we will show the well-posedness result of the linearized equations (3.11), (3.16) similar to [8]. What we need to do is to check the existence of the dual problem that satisfies some a priori estimate with a loss of one tangential derivative. Now, the definitions of the dual problem of (3.11), (3.16) are given below first. On the boundary $\left\{x_{2}=0\right\}$, the matrix in front of the normal
derivative $\partial_{2}$ in the operator $\mathbb{L}_{e}^{\prime}\left(U_{r, l}, \Phi_{r, l}\right)$ is equal to:

The new boundary conditions (3.31) only involve the "noncharacteristic" part of the vector $W=$ $\left(W_{+}, W_{-}\right)^{\top}$, the sub-vector $W^{n c}:=\left(W_{+, 3}, W_{+, 4}, W_{-, 3}, W_{-, 4}\right)^{\top}$. These are the components whose trace can be controlled on the boundary $\left\{x_{2}=0\right\}$. We always assume that $\lambda \geq \lambda_{0}$ and $K \leq K_{0}$, where $\lambda_{0}$ and $K_{0}$ are given in Theorem 3.2. Then, we can rewrite (3.24) as

From the linear analysis [34], we know that there is at least one order of loss of tangential derivative, therefore, we need to use the Nash-Moser technique in the nonlinear analysis. To this end, we strengthen the smallness assumption in (3.17) on the perturbed background states as

3.6. A priori estimate of tangential derivatives. Let $s \in \mathbb{N}$, and $l \in[1, s]$ be a fixed integer. Applying the tangential derivative $D^{\beta}=\partial_{t}^{\alpha_{0}} \partial_{1}^{\alpha_{1}}$ with $l=\alpha_{0}+\alpha_{1}$ to system (3.28) yields the equation for $D^{\beta} W_{ \pm}$that involves the linear terms of the derivatives: $D^{\beta-\beta^{\prime}} \partial_{t} W_{ \pm}$ and $D^{\beta-\beta^{\prime}} \partial_{1} W_{ \pm}$, with $\left|\beta^{\prime}\right|=1$. These terms cannot be treated simply as source terms, owning to the loss of derivatives in the energy estimate (3.33). To overcome such difficulty, we adopt the idea of 10 and deal with a boundary value problem for all the tangential derivatives of order $l$, i.e., for $W^{(l)}:=\left\{\partial_{t}^{\alpha_{0}} \partial_{1}^{\alpha_{1}}, \alpha_{0}+\alpha_{1}=l\right\}$. Such a problem satisfies the same regularity and stability properties as the original problem (3.28) and (3.31). We can find that $W^{(l)}$ obeys an energy estimate similar to (3.33) with new source terms $\mathcal{F}^{(l)}$ and $\mathcal{G}^{(l)}$. Then, we can use the Gagliardo-Nirenberg and Moser-type inequalities in [10 to derive the following estimate for the tangential derivatives; see Appendix B for the proof.

& \left.+\left([F]_{6, \lambda, T}+\|g\|_{H_{\lambda}^{6}\left(\omega_{T}\right)}\right)\left([(\dot{U}, \nabla \dot{\Phi})]_{s+2, \lambda, T}+\left\|\left.\left(\dot{U}, \partial_{2} \dot{U}, \nabla \dot{\Phi}\right)\right|_{x_{2}=0}\right\|_{H_{\lambda}^{s+1}\left(\omega_{T}\right)}\right)\right\} \\

for $s \geq 5$. From (3.28), we know $W_{ \pm}:=T^{-1} \dot{V}_{ \pm}$and $F_{ \pm}=A_{0}^{r, l} T^{-1} f_{ \pm}$. Then,

## 4. Compatibility Conditions for the Initial Data

4.1. The compatibility conditions. Let $\mu \in \mathbb{N}$. Given the initial data

such that $U_{0}^{ \pm}=\bar{U}^{ \pm}+\dot{U}_{0}^{ \pm}$with $\dot{U}_{0}^{ \pm} \in H_{*}^{2 \mu+1}\left(\mathbb{R}_{+}^{2}\right)$, and $\varphi_{0} \in H^{2 \mu+2}(\mathbb{R})$, we need to prescribe the necessary compatibility conditions for the existence of a smooth solution $\left(U^{ \pm}, \Phi^{ \pm}\right)$to (2.8)-(2.15). We also assume without loss of generality that the initial data $\dot{U}_{0}^{ \pm}$and $\varphi_{0}$ have compact support:

To introduce the compatibility conditions, we need to determine the traces $\dot{U}_{l}^{ \pm}$and $\dot{\Phi}_{l}^{ \pm}$ in terms of the initial data $\dot{U}_{0}^{ \pm}$and $\dot{\Phi}_{0}^{ \pm}$through (2.8) and (2.15). As in [10, we set $\mathcal{W}^{ \pm}:=\left(\dot{U}, \nabla_{x} \dot{U}, \nabla_{x} \dot{\Phi}\right) \in \mathbb{R}^{14}$ and rewrite (2.8) and (2.15) as

where $\mathcal{W}_{i}^{ \pm}$denotes the traces $\left(\dot{U}_{i}, \nabla_{x} \dot{U}_{i}, \nabla_{x} \dot{\Phi}_{i}\right)$ at $t=0$. From (4.7), we can determine $\left(\dot{U}_{l}^{ \pm}, \dot{\Phi}_{l}^{ \pm}\right)_{l \geq 0}$ inductively as functions of the initial data $\left(\dot{U}_{0}^{ \pm}, \dot{\Phi}_{0}^{ \pm}\right)$. Furthermore, we have the following lemma from [32].
Lemma 4.1. The equations (4.6) and (4.7) determine $\dot{U}_{l}^{ \pm} \in H_{*}^{2(\mu-l)+1}\left(\mathbb{R}_{+}^{2}\right)$ for $l=$ $1, \cdots, \mu$ and $\dot{\Phi}_{l}^{ \pm} \in H_{*}^{2(\mu-l)+3}\left(\mathbb{R}_{+}^{2}\right)$ for $l=1, \cdots, \mu+1$. Moreover, these functions satisfy

To construct a smooth approximate solution, we impose certain assumptions on traces of $\dot{U}_{l}^{ \pm}$and $\dot{\Phi}_{l}^{ \pm}$. Now we state the compatibility conditions of initial data.
Definition 4.1. For $\mu \in \mathbb{N}, \mu \geq 2$, let $U_{0}^{ \pm}=\left(m_{0}^{ \pm}, n_{0}^{ \pm}, v_{0}^{ \pm}, u_{0}^{ \pm}\right)^{T}$ have the form $U_{0}^{ \pm}=\bar{U}^{ \pm}+$ $\dot{U}_{0}^{ \pm}$with $\dot{U}_{0}^{ \pm} \in H_{*}^{2 \mu+1}\left(\mathbb{R}_{+}^{2}\right), \varphi_{0} \in H^{2 \mu+2}(\mathbb{R})$ satisfying (4.1). Consider the functions $\Phi_{0}^{ \pm}=$ $\pm x_{2}+\dot{\Phi}_{0}^{ \pm}$that satisfy (4.2)-(4.4), where $\varphi_{0}$ is sufficiently small. The initial data ( $\left.\dot{U}_{0}^{ \pm}, \varphi_{0}\right)$ is said to be compatible up to order $\mu$ if the traces of the functions $\dot{U}_{1}^{ \pm}, \cdots \dot{U}_{\mu}^{ \pm}, \dot{\Phi}_{1}^{ \pm}, \cdots \dot{\Phi}_{\mu+1}^{ \pm}$ satisfy the following:

& \int_{\mathbb{R}_{+}^{2}}\left|\partial_{2}^{\mu-j}\left(\dot{n}_{j}^{+}-\dot{n}_{j}^{-}\right)\right|^{2} d x_{1} \frac{d x_{2}}{x_{2}}<+\infty, \quad \text { for } j=0, \cdots, \mu .

4.2. Construction of approximate solutions. We shall take $\mu=\alpha+7$ in the previous paragraph and consider the compatibility of initial data ( $\dot{U}_{0}^{ \pm}, \varphi_{0}$ ) in the sense of Definition 4.1 in Theorem 2.1. In particular, the initial data are compatible up to order $\alpha+7$. We have the following result similar to [10].
Lemma 4.2. If $\dot{U}_{0}^{ \pm}$and $\varphi_{0}$ are sufficiently small, there exist some functions $U^{a \pm}, \Phi^{a \pm}, \varphi^{a}$, such that $U^{a \pm}-\bar{U}^{a \pm}=\dot{U}^{a \pm} \in H_{*}^{\mu+1}\left(\Omega_{T}\right), \Phi^{a \pm} \mp x_{2}=\dot{\Phi}^{a \pm} \in H_{*}^{\mu+2}\left(\Omega_{T}\right), \varphi^{a} \in H^{\mu+1}\left(\omega_{T}\right)$, and

where we denote by $\varepsilon_{0}(\cdot)$ a function that tends to 0 , when $\cdot$ tends to 0 .
We write $U^{a}:=\left(U^{a+}, U^{a-}\right)^{T}, \Phi^{a}:=\left(\Phi^{a+}, \Phi^{a-}\right)^{T}$ and turn to reformulate the original problem into one with zero initial data by using the approximate solution $\left(U^{a}, \Phi^{a}\right)$. Set

Given the approximate solution $\left(U^{a}, \Phi^{a}\right)$ of Lemma 4.2 and $f^{a}$ defined in (4.19), we see that $(U, \Phi)=\left(U^{a}, \Phi^{a}\right)+(V, \Psi)$ is a solution of the original problem on $\Omega_{T}$ of (2.8)-(2.15), if $V=\left(V^{+}, V^{-}\right)^{T}, \Psi=\left(\Psi^{+}, \Psi^{-}\right)^{T}$ satisfy the following problem:

The original nonlinear problem on $[0, T] \times \mathbb{R}_{+}^{2}$ can be reformulated as a problem on $\Omega_{T}$ whose solutions vanish in the past.

## 5. Nash-Moser Theorem

In this section, we prove the local existence of solutions to (4.22) by a suitable iteration scheme of Nash-Moser type. First, we introduce the smoothing operators $S_{\theta}$ and describe the iterative scheme for problem (4.22). For more details, please refer to $2,10,38$.

Lemma 5.1. We can define a family of smoothing operators $\left\{S_{\theta}\right\}_{\theta \geq 1}$ on the anisotropic Sobolev space $H_{*}^{s, \lambda}\left(\Omega_{T}\right)$, vanishing in the past, such that

where $\alpha, \beta \in \mathbb{N},(\beta-\alpha)_{+}:=\max \{0, \beta-\alpha\}$ and $C>0$ is a constant depending only on $\mu$. In particular, if $u=v$ on $\omega_{T}$, then $S_{\theta} u=S_{\theta} v$ on $\omega_{T}$.

Now, we begin to formulate the Nash-Moser iteration scheme.
5.1. Iteration Scheme. The scheme starts from $\left(V_{0}, \Psi_{0}, \psi_{0}\right)=(0,0,0)$, and $\left(V_{i}, \Psi_{i}, \psi_{i}\right)$ is given such that

Hence, we see $\delta \Psi_{i}^{ \pm}$vanishing in the past and satisfying $\left.\delta \Psi_{i}^{ \pm}\right|_{x_{2}=0}=\delta \psi_{i}$ as the unique smooth solutions to the transport equation (5.23)-(5.24). Once $\delta \Psi_{i}$ is determined, we can obtain $\delta V_{i}$ from (5.8) and $\left(V_{i+1}, \Psi_{i+1}, \psi_{i+1}\right)$ from (5.6). These error terms: $e_{i}^{\prime}, e_{i}^{\prime \prime}, e_{i}^{\prime \prime \prime}, \tilde{e}_{i}^{\prime}, \tilde{e}_{i}^{\prime \prime}, \tilde{e}_{i}^{\prime \prime \prime}, \hat{e}_{i}^{\prime}, \hat{e}_{i}^{\prime \prime}, \hat{e}_{i}^{\prime \prime \prime}$ are calculated from (5.15), (5.16), (5.25). Then, $e_{i}, \tilde{e}_{i}, \hat{e}_{i}$ are obtained from (5.18) and (5.26). Using (5.7) and (5.20), we sum from $i=0$ to $N$ to obtain

Since $S_{\theta_{N}} \rightarrow I$ as $N \rightarrow \infty$, we can formally obtain the solution to problem (4.22) from $\mathcal{L}\left(V_{N+1}, \Psi_{N+1}\right) \rightarrow f^{a}, \mathcal{B}\left(\left.V_{N+1}\right|_{x_{2}=0}, \psi_{N+1}\right) \rightarrow 0$, and $\mathcal{E}\left(V_{N+1}, \Psi_{N+1}\right) \rightarrow 0$, as error terms $\left(e_{N}, \tilde{e}_{N}, \hat{e}_{N}\right) \rightarrow 0$.

## 6. More Tame Estimates

Now, we present the following lemma for the second derivatives of the system and the tame estimates for the effective linearized problem (5.7).

Lemma 6.1. Let $T>0, s \in \mathbb{N}$, and $\lambda \geq 1$. Assume that the perturbations $\dot{U}, \dot{\Phi}$ satisfy

Now, we turn to derive a priori estimates for $\delta \Psi_{i}$ constructed in (5.23) and (5.24). We take the weighted energy estimate on (5.23) and write it in terms of $\delta \tilde{\Psi}_{i}:=e^{-\lambda t} \delta \Psi_{i}$ as

which is crucial in the proof of the convergence of the iteration scheme in the next section.

## 7. Proof Of the Main Result

From the sequence $\left\{\theta_{i}\right\}$ defined in (5.13), we set $\Delta_{i}:=\theta_{i+1}-\theta_{i}$. Then, the sequence $\left\{\Delta_{i}\right\}$ is decreasing and tends to 0 as $i$ goes to infinity. Moreover, we have

Our goal is to show that $\left(H_{0}\right)$ holds and $\left(H_{i-1}\right)$ implies $\left(H_{i}\right)$, for a suitable choice of parameter $\theta_{0} \geq 1$ and $\delta>0$, and for $f^{a}$ small enough. Then, we conclude that $\left(H_{i}\right)$ holds for all $i \in \mathbb{N}$.

Assume that, for $\alpha \geq 15, \tilde{\alpha}=\alpha+4, \mu=\tilde{\alpha}+3$, (7.1) holds, $\delta>0$ and $\left[f^{a}\right]_{\alpha+1, \lambda, T} / \delta$ are sufficiently small, and $\theta_{0} \geq 1$ is large enough, we first show that ( $H_{0}$ ) holds, then show that $\left(H_{i-1}\right)$ implies $\left(H_{i}\right)$.

We now prove $\left(H_{0}\right)$.
Lemma 7.1. If $\left[f^{a}\right]_{\alpha+1, \lambda, T} / \delta$ is sufficiently small, then $\left(H_{0}\right)$ holds.

\mathcal{L}\left(V_{i}, \Phi_{i}\right)-f^{a}=\left(S_{\theta_{i-1}}-I\right) f^{a}+\left(I-S_{\theta_{i-1}}\right) E_{i-1}+e_{i-1} .
$$

First, we estimate $\left[\left(S_{\theta_{i-1}}-I\right) f^{a}\right]_{s, \lambda, T}$. If $s \in[\alpha+1, \tilde{\alpha}-2]$,

& \leq C \theta_{i-1}^{s-\alpha-1}\left[f^{a}\right]_{\alpha+1, \lambda, T}+\left[f^{a}\right]_{\tilde{\alpha}-2, \lambda, T} \leq C \theta_{i}^{s-\alpha-1}\left(\left[f^{a}\right]_{\alpha+1, \lambda, T}+\delta\right) .
\end{aligned}
$$

If $s \in[7, \alpha+1]$, we have

Combining all the terms and taking $\delta$ and $\left[f^{a}\right]_{\alpha+1, \lambda, T} / \delta$ small enough, we obtain (7.37). (7.38) and (7.39) can be proved similarly and hence we have proved Lemma 7.13.

Proof of Theorem 2.1: Given the initial data $\left(U_{0}^{ \pm}, \varphi_{0}\right)$ satisfying all the assumptions of Theorem 2.1, $\alpha \geq 15$ and let $\tilde{\alpha}=\alpha+4$ and $\mu=\tilde{\alpha}+3$. Then the initial data $U_{0}^{ \pm}$and $\varphi_{0}$ are compatible up to order $\mu=\tilde{\alpha}+3$. From (4.16) and (4.21), we can obtain (7.1) and all the requirements of Lemma 7.12, Lemma 7.13 and Lemma 7.1 provided that $\left(\dot{U}_{0}^{ \pm}, \varphi_{0}\right)$ is sufficiently small in $H_{*}^{2 \mu+1}\left(\mathbb{R}_{+}^{2}\right) \times H^{2 \mu+2}(\mathbb{R})$ with $\dot{U}_{0}^{ \pm}:=U_{0}^{ \pm}-\bar{U}^{ \pm}$. Hence, for small initial data, property $\left(H_{i}\right)$ holds for all integers $i$. In particular, we have

Thus, sequence $\left(V_{i}, \Psi_{i}\right)$ converges to some limit $(V, \Psi)$ in $H_{\lambda}^{\alpha-1}\left(\Omega_{T}\right)$, and sequence $\psi_{i}$ converges to some limit $\psi$ in $H_{\lambda}^{\alpha}\left(\omega_{T}\right)$. Passing to the limit in (7.37) and (7.38) for $s=\alpha-1$ and in (7.39), we obtain (4.22). Therefore, $(U, \Phi)=\left(U^{a}+V, \Phi^{a}+\Psi\right)$ is a solution on $\Omega_{T}$ of nonlinear systems (2.8)-(2.15).

## Appendix A. Some Basic Estimates

We present some nonlinear tame estimates in the weighted Sobolev space $H_{\lambda}^{s}\left(\omega_{T}\right)$ and anisotropic Sobolev space $H_{*}^{s, \lambda}\left(\Omega_{T}\right)$. For more details, see [36]. First, we consider the weighted Sobolev space $H_{\lambda}^{s}\left(\omega_{T}\right)$.
Theorem A. 1 (Gagliardo-Nirenberg). Let $s>1$ be an integer, $\lambda \geq 1$ and $T \in \mathbb{R}$. There is a constant $C$ which is independent of $\lambda$ and $T$ such that for all $u \in H_{\lambda}^{s}\left(\omega_{T}\right) \cap L^{\infty}\left(\omega_{T}\right)$ and all multi-index $\alpha \in \mathbb{N}^{3}$ with $|\alpha| \leq s$, we have

\left\|\partial^{\alpha} u\right\|_{L_{\lambda}^{2 p}\left(\omega_{T}\right)} \leq C\|u\|_{L^{\infty}\left(\omega_{T}\right)}^{1-\frac{1}{p}}\|u\|_{H_{\lambda}^{s}\left(\omega_{T}\right)}^{\frac{1}{p}}, \quad \frac{1}{p}=\frac{|\alpha|}{s} .
$$

This result can be used to prove the following tame estimates for products of functions in $H_{\lambda}^{s}\left(\omega_{T}\right)$.
Theorem A.2. Let $s \geq 1$ be an integer, $\lambda \geq 1$ and $T \in \mathbb{R}$. There exists a constant $C$ which is independent of $\lambda$ and $T$ such that for all functions $u, v \in H_{\lambda}^{s}\left(\omega_{T}\right) \cap L^{\infty}\left(\omega_{T}\right)$, the product uv belongs to $H_{\lambda}^{s}\left(\omega_{T}\right)$ and satisfies the estimate

$$

Furthermore, there is a tame estimate for the composed functions.
Theorem A.3. Let $s \geq 1$ be an integer, $\lambda \geq 1$ and $T \in \mathbb{R}$. Assume that $F$ is a $C^{\infty}$ function such that $F(0)=0$. Then, there is an increasing function $C(\cdot)$ which is independent of $\lambda$ and $T$ such that for all $u \in H_{\lambda}^{s}\left(\omega_{T}\right) \cap L^{\infty}\left(\omega_{T}\right)$, the composed function $F(u)$ belongs to $H_{\lambda}^{s}\left(\omega_{T}\right)$ and satisfies

Then, we introduce the following Sobolev embedding estimates in $H_{\lambda}^{s}\left(\omega_{T}\right)$.
Theorem A.4. The following inequalities hold with constants $C$ which are independent of $\lambda \geq 1$,

$$

Next, we focus on the weighted anisotropic Sobolev space $H_{*}^{s, \lambda}\left(\Omega_{T}\right)$. We note that the estimate in $H_{*}^{s, \lambda}\left(\Omega_{T}\right)$ are different for $s$ to be odd and even. First, we present the estimates when $s$ is even.
Theorem A. 5 (Gagliardo-Nirenberg). Let $s>1$ be an even integer, $\lambda \geq 1$ and $T \in \mathbb{R}$. There is a constant $C$ which is independent of $\lambda$ and $T$ such that for all $u \in H_{*}^{s, \lambda}\left(\Omega_{T}\right) \cap$ $L^{\infty}\left(\Omega_{T}\right)$ and all multi-index $\alpha \in \mathbb{N}^{3}, k \in \mathbb{N}$ with $|\alpha|+2 k \leq s$, we have

\left\|\partial_{*}^{\alpha} \partial_{2}^{k} u\right\|_{L_{\lambda}^{2 p}\left(\Omega_{T}\right)} \leq C\|u\|_{L^{\infty}\left(\Omega_{T}\right)}^{1-\frac{1}{p}}[u]_{s, \lambda, T}^{\frac{1}{p}}, \frac{1}{p}=\frac{|\alpha|+2 k}{s} .
$$

Similarly to $H_{\lambda}^{s}\left(\omega_{T}\right)$, we also have the following estimates for the products and composed functions.
Theorem A.6. Let $s \geq 1$ be an even integer, $\lambda \geq 1$ and $T \in \mathbb{R}$. Then, for all functions $u, v \in H_{*}^{s, \lambda}\left(\Omega_{T}\right) \cap L^{\infty}\left(\Omega_{T}\right)$ and $C^{\infty}$ function $F$ of $u, F(0)=0$, we have

{[u v]_{s, \lambda, T} \leq C_{1}\left(\|u\|_{L^{\infty}\left(\Omega_{T}\right)}[v]_{s, \lambda, T}+\|v\|_{L^{\infty}\left(\Omega_{T}\right)}[u]_{s, \lambda, T}\right)} \\
{[F(u)]_{s, \lambda, T} \leq C_{2}\left(\|u\|_{L^{\infty}\left(\Omega_{T}\right)}\right)[u]_{s, \lambda, T},}
\end{gathered}
$$

where $C_{1}$ is a constant and $C_{2}$ is an increasing function. They are both independent of $\lambda$ and $T$.

For the Sobolev embedding theorem, we have
Theorem A.7. The following inequalities hold with constants $C$ which are independent of $\lambda \geq 1$,

where $C_{1}$ is a constant and $C_{2}$ is an increasing function, and both are independent of $\lambda$ and $T$.

For the Sobolev embedding theorem, we have
Theorem A.9. The following inequalities hold with constants $C$ which are independent of $\lambda \geq 1$,

## Appendix B. A priori Estimate of Tangential Derivatives

We prove Lemma 3.2 here. We differentiate (3.28) with the $l$ th order tangential derivatives $D^{\beta}=\partial_{t}^{\alpha_{0}} \partial_{1}^{\alpha_{1}}$, with the multi-index $\beta=\left(\alpha_{0}, \alpha_{1}, 0,0\right), l=\alpha_{0}+\alpha_{1}$ and $0 \leq l \leq s$, and obtain

& +\sum_{\left\langle\beta^{\prime}\right\rangle \geq 2, \beta^{\prime} \leq \beta} c_{\beta^{\prime}}\left[D^{\beta^{\prime}} A_{0} D^{\beta-\beta^{\prime}} \partial_{t} W+D^{\beta^{\prime}} A_{1} D^{\beta-\beta^{\prime}} \partial_{1} W\right]+\sum_{\left\langle\beta^{\prime}\right\rangle \geq 1, \beta^{\prime} \leq \beta} c_{\beta^{\prime}}\left[D^{\beta^{\prime}} C D^{\beta-\beta^{\prime}} W\right], \tag{B.1}

We focus on the term $D^{\beta^{\prime}} A_{0} \partial_{t} D^{\beta-\beta^{\prime}} W$ in $L^{2}\left(H_{\lambda}^{1}\left(\omega_{T}\right)\right)$, where $\left\langle\beta^{\prime}\right\rangle \geq 2$. For fixed $x_{2}>0$, we apply the Gagliardo-Nirenberg inequalities (Theorem A.1 and Theorem A.3). Then, we integrate with respect to $x_{2}$. Decomposing

& \leq C(K)\left\{\|W\|_{L^{2}\left(H_{\lambda}^{l}\left(\omega_{T}\right)\right)}+\|W\|_{W^{1, t a n}\left(\Omega_{T}\right)}\|(\dot{U}, \nabla \dot{\Phi})\|_{L^{2}\left(H_{\lambda}^{l+1}\left(\omega_{T}\right)\right)}\right\} . \tag{B.8}
\end{align*}
$$

Thus, we have

& \leq C(K)\left\{\lambda\|W\|_{L^{2}\left(H_{\lambda}^{l}\left(\omega_{T}\right)\right)}+\|W\|_{W^{1, t a n}\left(\Omega_{T}\right)}\|(\dot{U}, \nabla \dot{\Phi})\|_{L^{2}\left(H_{\lambda}^{l+1}\left(\omega_{T}\right)\right)}\right\} \tag{B.9}

& \leq C(K)\left\{\lambda\|W\|_{L^{2}\left(H_{\lambda}^{l}\left(\omega_{T}\right)\right)}+\|W\|_{W^{1, t a n}\left(\Omega_{T}\right)}\|(\dot{U}, \nabla \dot{\Phi})\|_{L^{2}\left(H_{\lambda}^{l+1}\left(\omega_{T}\right)\right)}\right\}, \\
& \left\|D^{\beta^{\prime}} C D^{\beta-\beta^{\prime}} W\right\|_{L^{2}\left(H_{\lambda}^{1}\left(\omega_{T}\right)\right)}, \\

& \leq C(K)\left\{\|F\|_{L^{2}\left(H_{\lambda}^{l+1}\left(\omega_{T}\right)\right)}+\lambda\|W\|_{L^{2}\left(H_{\lambda}^{l}\left(\omega_{T}\right)\right)}+\|W\|_{W^{1, t a n}\left(\Omega_{T}\right)}\|(\dot{U}, \nabla \dot{\Phi})\|_{L^{2}\left(H_{\lambda}^{l+2}\left(\omega_{T}\right)\right)}\right\} . \tag{B.11}

Similarly, we estimate the right hand side of (B.3) and obtain

& \quad+\left\|\left.W^{n c}\right|_{x_{2}=0}\right\|_{H_{\lambda}^{l}\left(\omega_{T}\right)}+\|\psi\|_{H_{\lambda}^{l+1}\left(\omega_{T}\right)}+\left\|\left.W^{n c}\right|_{x_{2}=0}\right\|_{L^{\infty}\left(\omega_{T}\right)}\left\|\left(\left.\dot{U}\right|_{x_{2}=0}, \nabla \psi\right)\right\|_{H_{\lambda}^{l+1}\left(\omega_{T}\right)} \\
& \left.\quad+\left.\|\psi\|_{W^{1, \infty}\left(\omega_{T}\right)}| |\left(\dot{U}, \partial_{2} \dot{U}, \nabla \dot{\Phi}\right)\right|_{x_{2}=0} \|_{H_{\lambda}^{l+1}\left(\omega_{T}\right)}\right\} . \tag{B.12}
\end{align*}

Substituting (B.11) and (B.12) into (B.5), multiplying the obtained inequality by $\lambda^{s-l}$, summing over $l=0, \cdots, s$, and choosing $\lambda$ large enough, we can complete the proof of Lemma 3.2.
