RATE OF CONVERGENCE FOR PERIODIC HOMOGENIZATION OF CONVEX HAMILTON–JACOBI EQUATIONS IN ONE DIMENSION

ABSTRACT. Let u^{ϵ} and u be viscosity solutions of the oscillatory Hamilton-Jacobi equation and its corresponding effective equation. Given bounded, Lipschitz initial data, we present a simple proof to obtain the optimal rate of convergence $O(\epsilon)$ of $u^{\epsilon} \rightarrow u$ as $\epsilon \rightarrow 0^+$ for a large class of convex Hamiltonians H(x, y, p) in one dimension. This class includes the Hamiltonians from classical mechanics with separable potential. The proof makes use of optimal control theory and a quantitative version of the ergodic theorem for periodic functions in dimension n = 1.

1. INTRODUCTION

We first give a brief description of the periodic homogenization theory for Hamilton–Jacobi equations in the framework of viscosity solutions (see [2, 14, 10, 15]). The oscillatory Hamilton–Jacobi equation is given by the following Cauchy problem with parameter ε :

$$\begin{cases} u_t^{\varepsilon} + H\left(x, \frac{x}{\varepsilon}, Du^{\varepsilon}\right) &= 0 & \text{in } \mathbb{R} \times [0, \infty) \\ u^{\varepsilon}(x, 0) &= u_0(x) & \text{on } \mathbb{R}, \end{cases}$$
(C_{\varepsilon})

where the initial data u_0 is contained in BUC(\mathbb{R}^n), the set of bounded uniformly continuous functions on \mathbb{R}^n . Given a Hamiltonian $H(x, y, p) \in C(\mathbb{R}^n \times \mathbb{R}^n \times \mathbb{R}^n)$ satisfying some conditions (H1)–(H4) below, define the effective Hamiltonian as follows: For each $(x, p) \in \mathbb{R}^n \times \mathbb{R}^n$, let $\overline{H}(x, p) \in \mathbb{R}$ be the unique constant for which the cell (ergodic) problem

$$H(x, y, p + D_{y}v(y)) = \overline{H}(x, p) \qquad \text{in } \mathbb{T}^{n}$$
(CP)

has a continuous viscosity solution v(y) = v(y; x, p). That such a constant exists and is unique is proven in [16] and [11, 12]. It is worth mentioning that in general the solution v(y; x, p) to the cell problem (CP) is not unique even up to the addition of a constant. The effective Hamilton-Jacobi equation corresponding to (C_{ε}) is given by the following Cauchy problem:

 $\begin{cases} u_t + \overline{H}(x, Du) &= 0 & \text{in } \mathbb{R} \times [0, \infty) \\ u(x, 0) &= u_0(x) & \text{on } \mathbb{R}. \end{cases}$ (C)

Some papers treating the properties of the effective Hamiltonian \overline{H} are [5, 8, 9, 17, 23], and the references given therein.

The theory of periodic homogenization studies the behavior of viscosity solutions $u^{\varepsilon} \in C(\mathbb{R}^n \times [0, \infty))$ to (C_{ε}) as the period of oscillation ε approaches 0^+ . The first results in the theory of periodic homogenization were proved under the following assumptions on the Hamiltonian $H = H(x, y, p) \in C(\mathbb{R}^n \times \mathbb{T}^n \times \mathbb{R}^n)$:

(H1) For each $(x, p) \in \mathbb{R}^n \times \mathbb{R}^n$, $y \mapsto H(x, y, p)$ is \mathbb{Z}^n -periodic.

(H2) $p \mapsto H(x, y, p)$ is uniformly coercive in $(x, y) \in \mathbb{R}^n \times \mathbb{T}^n$. That is,

$$\lim_{|\mathbf{p}|\to+\infty} \left(\inf_{(\mathbf{x},\mathbf{y})\in\mathbb{R}^n\times\mathbb{T}^n} H(\mathbf{x},\mathbf{y},\mathbf{p})\right) = +\infty.$$

Here $\mathbb{T}^n = \mathbb{R}^n \setminus \mathbb{Z}^n$.

- (H3) $\sup \left\{ |H(x,y,p)| : (x,y) \in \mathbb{R}^{2n}, |p| \leq R \right\} < \infty \text{ for all } R > 0.$
- (H4) For each R > 0, there exists $\omega_{R}(\cdot) \in C([0,\infty))$, with $\omega_{R}(0) = 0$, such that for all $x, y \in \mathbb{R}^{n}$, p, q $\in B(0, R)$ then

$$|\mathsf{H}(\mathsf{x},\mathsf{y},\mathsf{p}) - \mathsf{H}(\mathsf{x},\mathsf{y},\mathsf{q})| \leq \omega_{\mathsf{R}}(|\mathsf{p}-\mathsf{q}|)$$

where B(0, R) denotes the open ball centered at 0 with radius R in \mathbb{R}^n .

Under the assumptions (H1)–(H4), the viscosity solutions u^{ε} converge to a limit u locally uniformly on $\mathbb{R}^n \times [0, \infty)$, where u is a viscosity solution to the effective equation (C). This was first proved by P.-L. Lions, G. Papanicolau and S.R.S. Varadhan [16] in the case that H is independent of x, namely H(x, y, p) = H(y, p). The more general case in which H = H(x, y, p) can depend on x was established later by L. C. Evans [11, 12], who developed the perturbed test functions method for studying the homogenization problem in the framework of viscosity solutions.

The rate of convergence of $u^{\varepsilon} \rightarrow u$ was first studied by I. Capuzzo-Dolcetta and H. Ishii in [7] using a PDE approach. They consider the stationary problem

$$w^{\varepsilon}(x) + H\left(x, \frac{x}{\varepsilon}, Dw^{\varepsilon}(x)\right) = 0 \quad \text{in } \mathbb{R}^{n}.$$
 (S_{\varepsilon})

As $\varepsilon \to 0$, $w^{\varepsilon} \to w$ locally uniformly on \mathbb{R}^n and w solves the effective equaition

$$w(x) + \overline{H}(x, Dw(x)) = 0$$
 in \mathbb{R}^n . (S)

Under this stationary setting, the authors of [7] establish the rate of convergence is *at least* $O(\varepsilon^{1/3})$ for general (including nonconvex) Lipschitz Hamiltonians under quite general assumptions. In the case that H(x, y, p) = H(y, p), Capuzzo-Dolcetta and Ishii obtain the rate of convergence $O(\varepsilon)$ of w^{ε} to *w* by a simple comparison argument. Their approach can be easily adjusted to handle the Cauchy problem (C_{ε}) giving the same rate $O(\varepsilon^{1/3})$. This approach is quite robust, and it works for various different situations. Another example occurs in [19], where C. Marchi considers the case where H depends on more scales, and establishes the rate $O(\varepsilon^{1/3}) + \omega(\varepsilon)$ for some modulus of continuity of H using the method of [7], Heuristically, the rate of convergence $O(\varepsilon)$ seems to be optimal. By using an ansatz $u^{\varepsilon} = u^{0} + \varepsilon u^{1} + \varepsilon^{2} u^{2} + \ldots$ and plugging it into (C_{ε}) , we can derive the following two–scale asymptotic expansion (see [14, 16, 21]),

$$u^{\varepsilon}(x,t) \approx u(x,t) + \varepsilon v\left(\frac{x}{\varepsilon}; x, Du(x,t)\right) + O(\varepsilon^2),$$
 (1.1)

in which the rate of convergence looks like $O(\varepsilon)$. However, it is hard to justify (1.1) rigorously as the solution u(x, t) to (C) is only Lipschitz in (x, t), and is usually not C¹. Also, the solution v to the ergodic problem (CP) is not unique even up to the addition of a constant (Example 6.1 in [14] or Proposition 5.4 in [15]).

Recently, H. Mitake, H. V. Tran and Y. Yu established in [21] that the rate $O(\varepsilon)$ is optimal in the case that the dimension n = 1 and the Hamiltonian H is convex and independent of x. They provide the following example of a family of $u^{\varepsilon'}s$ that converge to u at the strict rate of $O(\varepsilon)$:

Proposition 1.1 (Proposition 4.3, [21]). Let n = 1 and $H(y, p) = \frac{1}{2}|p|^2 + V(y)$ where $V \in C(\mathbb{T})$ with $\max_{\mathbb{T}} V = 0$ and $V \leq -1$ in $\left[-\frac{1}{3}, \frac{1}{3}\right]$. Then in this case $u \equiv 0$, $\|u^{\varepsilon}\|_{L^{\infty}(\mathbb{R}\times[0,\infty))} \leq C\varepsilon$ and $u^{\varepsilon}(0,1) \geq \frac{1}{6}\varepsilon$ for all $\varepsilon \in (0,1)$.

Proposition 1.1 and other important results in higher dimensional spaces are proved in [21] using tools from dynamical systems and weak KAM theory.

Mitake, Tran, and Yu also present in [21] an essential obstacle to improving the convergence rate $O(\varepsilon^{1/3})$ by the method used by Capuzzo-Dolcetta and Ishii in [7]. More precisely, for each $(x, p) \in \mathbb{R}^n \times \mathbb{R}^n$, instead of using v(y; x, p) directly in (1.1), the authors of [7] use $v^{\lambda}(y) = v^{\lambda}(y; x, p)$ as the unique solution to the following discount problem

$$\lambda v^{\lambda}(y) + H\left(x, y, p + D_{y}v^{\lambda}(y)\right) = 0$$
 in \mathbb{T}^{n} , (S _{λ})

and approximate Du(x, t) by $\frac{x-y}{\epsilon^{\beta}}$ in (1.1) using the doubling variable method. By optimizing λ and β , $O(\epsilon^{1/3})$ is the best convergence rate that can be obtained. In order to improve the convergence rate, it is necessary to have a nice selection of viscosity solutions $v(\cdot; x, p)$ to the ergodic problem (CP) with respect to (x, p), so that one can use directly v(y; x, p) instead of $v^{\lambda}(y; x, p)$ in (1.1). In the case that H(x, y, p) = H(y, p), assume that

$$\begin{cases} \text{For each } p \in \mathbb{R}^n \text{ there exists a solution } v(\cdot; p) \text{ of (CP)} \\ \text{such that } p \mapsto v(\cdot; p) \text{ is Lipschitz.} \end{cases}$$
(1.2)

Then, the convergence rate can be improved from $O(\varepsilon^{1/3})$ to $O(\varepsilon^{1/2})$, as one needs only introduce one parameter into the doubling variable formulation (see Section 7.2 in [24]) instead of two parameters as before. However, condition (1.2) is quite restrictive in general and does not always hold (see Section 5 in [21]).

Closely related to the results outlined above for the problem (C_{ε}) are the recent developments in the case of the viscous Hamilton–Jacobi equations. Let $H = H(x, y, p, X) : \mathbb{R}^n \times \mathbb{R}^n \times \mathbb{R}^n \times \mathbb{S}^n \to \mathbb{R}$ be the Hamiltonian that is \mathbb{Z}^n -periodic

in the y variable, and S^n denotes the set of $n \times n$ symmetric matrices. The associated viscous Cauchy problem is

$$\begin{cases} u_{t}^{\varepsilon} + H\left(x, \frac{x}{\varepsilon}, Du^{\varepsilon}, D^{2}u^{\varepsilon}\right) &= 0 & \text{ in } \mathbb{R} \times [0, \infty) \\ u^{\varepsilon}(x, 0) &= u_{0}(x) & \text{ on } \mathbb{R}, \end{cases}$$

$$(C_{\varepsilon}^{*})$$

One can find the effective Hamiltonian \overline{H} with a method similar to that used in the non-viscous case and obtain a solution u to the Cauchy problem associated to \overline{H} , such that the solutions u^{ε} to (C_{ε}^*) converge locally uniformly to u (see [6, 12]). The following analogous results on the rate of convergence of $u^{\varepsilon} \rightarrow u$ for the viscous Hamilton–Jacobi equation below are important to note:

- In the stationary setting, F. Camilli and C. Marchi ([6]) show that the rate is O(ε) if H = H(y, p, X). It can be upgraded to O(ε²) if H = H(y, X).
- F. Camilli, C. Annalisa and C. Marchi ([4]) show that the rate is O(ε) for the vanishing viscosity problem u^ε + H (^x/_ε, Du^ε, εD²u^ε) = 0 in ℝⁿ.
- For the Cauchy problem $u_t^{\varepsilon} + H\left(\frac{x}{\varepsilon}, Du^{\varepsilon}, \varepsilon D^2 u^{\varepsilon}\right) = 0$ in $\mathbb{R}^n \times (0, \infty)$ with initial data u(x, 0) = g(x) on \mathbb{R}^n , S. Kim and K.-A. Lee ([13]) obtain high order rates of convergence for special chosen initial data.

In both situations, viscous and nonviscous, the case when H depends on x is significantly harder. In particular, the methods used in [4, 6] provide the rate $O(\epsilon^{\alpha})$ for some $\alpha < 1$.

We refer to [6, 4, 13] and the references therein for more related results on the viscous case. See also [1, 3, 18, 20] and the references therein for related results to the rate of convergence of Hamilton–Jacobi equations in stochastic homogenization and other settings.

When H is convex and depends on x, the situation is more complicated and requires a harder analysis of the dynamics of optimal paths in the optimal control formula. Up to now, the best-known convergence rate in this setting is $O(\varepsilon^{1/3})$, obtained in [7]. The main goal of this paper is to obtain the optimal rate of convergence of $u^{\varepsilon} \rightarrow u$ in one dimension: more precisely, to obtain an optimal bound for $\|u^{\varepsilon} - u\|_{L^{\infty}([-R,R]\times[0,T])}$ for any given R, T > 0 as $\varepsilon \rightarrow 0^+$. Our paper is the first work that improves the rate of convergence $u^{\varepsilon} \rightarrow u$ for (C_{ε}) to $O(\varepsilon)$ in the one-dimensional case, as far as we know. Our method develops the results of [21] further and uses deep dynamical properties of optimal paths in the optimal control formula. Higher-dimensional cases will be investigated in future works. We state our main results precisely:

1.1. **Main results.** In this paper, we consider the one dimensional case n = 1 and the convex Hamiltonian is of the form:

H(x, y, p) = H(p) + V(x, y) for all $(x, y, p) \in \mathbb{R} \times \mathbb{T} \times \mathbb{R}$.

We present a simplified proof for obtaining the rate of convergence using optimal control theory. The main theorem is as follows:

Theorem 1.2. Let n = 1 and $H(x, y, p) = H(p) + V(x, y) + C_0$ where C_0 is a constant, $H \in C^2(\mathbb{R}, [0, \infty))$ is strictly convex with $\min_{p \in \mathbb{R}} H(p) = H(0) = 0$. Define

$$\begin{split} & \mathsf{G}_1 = \left(\mathsf{H}'|_{[0,\infty)}\right) \circ \left(\mathsf{H}|_{[0,\infty)}\right)^{-1} \textit{ and } \mathsf{G}_2 = \left(\mathsf{H}'|_{(-\infty,0]}\right) \circ \left(\mathsf{H}|_{(-\infty,0]}\right)^{-1} \textit{. Assume (H1)-(H4),} \\ & \mathsf{V}(\mathsf{x},\mathsf{y}) \textit{ is continuously differentiable in } \mathsf{x} \textit{ variable for each } \mathsf{y} \in \mathbb{T}, \textit{ and:} \\ & (\mathsf{Ao}) \end{split}$$

$$\limsup_{p \to 0} \left| \frac{\mathsf{H}''(p)}{\mathsf{H}'(p)} \sqrt{\mathsf{H}(p)} \right| < \infty.$$
(1.3)

(A1) $\max_{\mathbb{R}\times\mathbb{T}} V(x, y) = 0$, there exists $y_0 \in \mathbb{T}$ such that $V(x, y_0) = 0$ for all $x \in \mathbb{R}$. For each compact interval $I \subset \mathbb{R}$ and i = 1, 2 we have:

(A2)

$$\limsup_{\mathbf{r}\to 0^+}\left\{|V_{\mathbf{x}}(\mathbf{x},\mathbf{y})|.\frac{|\mathsf{G}'_{\mathbf{i}}(\mathbf{r}-V(\mathbf{x},\mathbf{y}))|}{|\mathsf{G}_{\mathbf{i}}(\mathbf{r}-V(\mathbf{x},\mathbf{y}))|}\ :\ (\mathbf{x},\mathbf{y})\in \mathbf{I}\times\mathbb{T}\right\}<\infty.$$

 (A_3)

$$\sup_{(x,y)\in I\times\mathbb{T}}\left|\frac{V_x(x,y)}{G_i\left(|V(x,y)|\right)}\right|<\infty.$$

(A4)

$$\limsup_{r \to 0^+} \left(\frac{\max_{x \in I} \int_0^1 \frac{dy}{|G_i(r - V(x, y))|}}{\min_{x \in I} \int_0^1 \frac{dy}{|G_i(r - V(x, y))|}} \right) < \infty.$$

If $u_0 \in Lip(\mathbb{R}) \cap BUC(\mathbb{R})$ *then for any* R, T > 0 *we have*

 $\|\boldsymbol{\mathfrak{u}}^{\varepsilon} - \boldsymbol{\mathfrak{u}}\|_{L^{\infty}([-R,R]\times[0,T])} \leqslant C\varepsilon$ (1.4)

where C is a constant depends only on $R, T, Lip(u_0), H(p)$ and V(x, y).

To help the readers better understand the main ideas of the paper, we consider the classical mechanics Hamiltonian in Theorem 1.3. Theorem 1.2 is an adaptation of these ideas to the general situation with new technical changes to overcome the arising difficulties.

Theorem 1.3. Assume n = 1 and $H(x, y, p) = \frac{1}{2}|p|^2 + V(x, y)$ where V is of the separable form $V(x, y) = a(x)b(y) + C_0$ where C_0 is a constant and

- (i) $a(x) \in C^1(\mathbb{R})$ is bounded with a(x) > 0 for all $x \in \mathbb{R}$,
- (ii) $b(y) \in C(\mathbb{T})$ and $\max_{y \in \mathbb{T}} b(y) = 0$.

Assume $u_0 \in \text{Lip}(\mathbb{R}) \cap \text{BUC}(\mathbb{R})$, then for each R, T > 0 we have

$$\|\mathbf{u}^{\varepsilon} - \mathbf{u}\|_{\mathbf{L}^{\infty}([-\mathbf{R},\mathbf{R}]\times[0,T])} \leqslant C\varepsilon \tag{1.5}$$

where C is a constant depends on R, T, $Lip(u_0)$, a(x) and max |b(y)|.

Remark 1. In Theorem 1.3 if V(x,y) = V(y) does not depend on x, then we can choose C explicitly as $C = 2 \|u'_0\|_{L^{\infty}(\mathbb{R})} + 8 \|V\|_{L^{\infty}}^{1/2}$. As a consequence, the convergence is uniform in the sense that $\|u^{\varepsilon} - u\|_{L^{\infty}(\mathbb{R} \times [0,\infty))} \leq C\varepsilon$ (Section 2 and Remark 4).

Remark 2. Let us give some quick comments on the assumptions of Theorem 1.2.

- (i) The assumptions (A₂)–(A₄) are technical assumptions that are needed for the arguments to work. These assumptions are natural in the sense that they are satisfied by a large class of interesting Hamiltonians (cf. Corollary 1.4).
- (ii) Assumption (A1) plays a key role in establishing the result. Roughly speaking, the rate of convergence of u^{ε} to u is related to the asymptotic behavior of its corresponding minimizer path via an optimal control formulation as in (3.5). Any minimizer path conserves the total energy as in (3.6). Assumption (A1) implies that any minimizer with negative total energy is uniformly bounded independent of $\varepsilon > 0$.
- (iii) Condition (Ao) is satisfied for a vast class of strictly convex C² Hamiltonians, including those with H''(0) > 0, $H \in C^3$, or $|p|^{\gamma}$ with $\gamma \ge 2$ (Lemma 2.8).

Remark 3. If V(x, y) = V(y) does not depend on x, then assumptions (A1)–(A4) automatically hold, while (Ao) is satisfied after approximating H with uniformly convex Hamiltonians. Indeed, the method can be used to get the result for general convex Hamiltonians. We thus recover Theorem 1.3 in [21] and the convergence is uniform in this case. By Proposition 1.1, the rate $O(\varepsilon)$ is optimal.

The following corollary gives some nice examples in which (A1)–(A4) hold, and Theorem 1.2 applies.

Corollary 1.4. If H(x, y, p) = H(p) + V(x, y) where $H(p) \ge H(0) = 0$ such that:

- $H(p) \in C^2(\mathbb{R})$ is strictly convex with H''(0) > 0, or $H(p) = |p|^{\gamma}$ where $\gamma \ge 2$.
- $\max_{\mathbb{R}\times\mathbb{T}} V(x,y) = 0$, there exists $y_0 \in \mathbb{T}$ such that $V(x,y_0) = 0$ for all $x \in \mathbb{R}$.
- For every compact interval $I \subset \mathbb{R}$ then $\alpha_I f_I(y) \leq |V(x, y)| \leq \beta_I f_I(y)$ for $\alpha_I, \beta_I > 0$, $f_I \in C(\mathbb{R}, [0, \infty))$ and

$$\sup_{(\mathbf{x},\mathbf{y})\in\mathbf{I}\times\mathbb{T}}\left|\frac{V_{\mathbf{x}}(\mathbf{x},\mathbf{y})}{V(\mathbf{x},\mathbf{y})}\right|\leqslant C_{\mathbf{I}}<\infty.$$
(1.6)

If $u_0 \in Lip(\mathbb{R}) \cap BUC(\mathbb{R})$ then for any R, T > 0 we have

$$\|\mathbf{u}^{\varepsilon}-\mathbf{u}\|_{\mathbf{L}^{\infty}([-\mathbf{R},\mathbf{R}]\times[0,T])}\leqslant C\varepsilon$$

where C is a constant depends only on $R, T, Lip(u_0), H(p)$ and V(x, y).

1.2. **Organization of the paper.** The paper is organized as follows. Section 2 is devoted to the proof of Theorem 1.3. In section 3 we only sketch the proof of Theorem 1.2 with highlights on major technical difficulties, and where assumptions (Ao)–(A4) appear since the ideas are similar to the classical mechanics' case. We provide proofs of some lemmas in the Appendix for the reader's convenience.

2. Classical Mechanics Hamiltonian setting

Proof of Theorem 1.3. We observe that the estimate (1.5) does not depend on the smoothness of $b(\cdot)$, by approximation, without loss of generality we can assume

that $V \in C^2(\mathbb{R} \times \mathbb{T})$. Also, by replacing u by u + C we can normalize that $C_0 = 0$. Let us fix R, T > 0, $\varepsilon \in (0, 1)$ and $(x_0, t_0) \in [-R, R] \times [0, T]$, thanks to the optimal control formula (see [2, 14]) we have

$$u^{\varepsilon}(x_{0},t_{0}) = \inf_{\eta \in \mathbb{T}} \left\{ \varepsilon \int_{0}^{\varepsilon^{-1}t_{0}} \left(\frac{|\dot{\eta}(s)|^{2}}{2} - V(\varepsilon\eta(s),\eta(s)) \right) ds + u_{0}\left(\varepsilon\eta(\varepsilon^{-1}t_{0})\right) \right\}, \quad (2.1)$$

where $\mathfrak{T} = \{\eta(\cdot) \in AC([0, \varepsilon^{-1}t_0]), \varepsilon\eta(0) = x_0\}$. Here AC([a, b]) denotes the set of absolutely continuous functions from [a, b] to \mathbb{R} . Let $\eta_{\varepsilon}(\cdot) \in \mathfrak{T}$ be a minimizer to the optimization problem (2.1), it is clear that $\eta_{\varepsilon}(\cdot)$ must satisfy the following Euler-Lagrange equation

$$\begin{cases} \ddot{\eta}_{\epsilon}(s) &= -\nabla V \big(\epsilon \eta_{\epsilon}(s), \eta_{\epsilon}(s) \big) \cdot (\epsilon, 1) & \text{ on } \big(0, \epsilon^{-1} t_0 \big) , \\ \eta_{\epsilon}(0) &= \epsilon^{-1} x_0. \end{cases}$$
(2.2)

Here ∇V means the full gradient of V. In particular, this implies the following conservation of energy:

$$\frac{\mathrm{d}}{\mathrm{d}s}\left(\frac{|\dot{\eta}_{\varepsilon}(s)|^{2}}{2} + V(\varepsilon\eta_{\varepsilon}(s),\eta_{\varepsilon}(s))\right) = \dot{\eta}_{\varepsilon}(s)\Big(\ddot{\eta}_{\varepsilon}(s) + \nabla V(\varepsilon\eta_{\varepsilon}(s),\eta_{\varepsilon}(s))\cdot(\varepsilon,1)\Big) = 0$$

for all $s \in (0, \epsilon^{-1}t_0)$. There exists a constant $r = r(\eta_{\epsilon}) \in [V(0, 0), +\infty)$ such that

$$\frac{|\dot{\eta}_{\varepsilon}(s)|^2}{2} + V(\varepsilon \eta_{\varepsilon}(s), \eta_{\varepsilon}(s)) = r \quad \text{for all} \quad s \in (0, \varepsilon^{-1} t_0). \tag{2.3}$$

For each $r \in [V(x_0, \epsilon^{-1}x_0), \infty)$ the Euler-Lagrange equation (2.2) is

We proceed to get different estimates for $r \leq 0$ and r > 0. For simplicity, let us introduce the following notation. For I be an interval of \mathbb{R} , we define $\inf_{r \in I} A^{\epsilon}[\eta_{\epsilon}]$ which means the infimum over all solutions $\eta_{\epsilon}(\cdot)$ that solve (2.2) and with all energies $r \in I$.

respectively. To be precise, there are two cases:

- $V(x_0, \varepsilon x_0) = 0$, by Lemma 2.8 we have $x \mapsto \sqrt{-V(\varepsilon x, x)}$ is Lipschitz on $[\varepsilon^{-1}x_0, \varepsilon^{-1}x_0 + 1]$. Indeed, $\gamma_+(\cdot)$ remains staying inside $[\varepsilon^{-1}x_0, \varepsilon^{-1}x_0 + 1]$ and hence solution exists on $(0, +\infty)$. To see this, we first observe that $\gamma_+(\cdot)$ is increasing and for each time t > 0, from (2.8) we have

$$\left| \int_{x_0}^{\epsilon \eta_{\epsilon}(\epsilon^{-1}t_0)} \frac{-V(x,\epsilon^{-1}x)}{\sqrt{2(r-V(x,\epsilon^{-1}x))}} \, dx - \int_{x_0}^{c_{1,r}} \int_0^1 \frac{-V(x,y)}{\sqrt{2(r-V(x,y))}} \, dy \, dx \right| \leq (2F_1 + F_2c_0 + F_1C_K)\epsilon.$$
(2.38)

From (2.38) we obtain our claim (2.33) with

$$C_{\rm F} = \left(\|V\|_{\rm L^{\infty}}\right)^{1/2} \left(2 + 2\sqrt{\frac{\beta_{\rm T}}{\alpha_{\rm T}}} + c_0 \left(\frac{3}{2\sqrt{2}} + \frac{1}{2}\sqrt{\frac{\beta_{\rm T}}{\alpha_{\rm T}}}\right) \max_{\mathbf{x}\in I_0} \left|\frac{a'(\mathbf{x})}{a(\mathbf{x})}\right|\right).$$
(2.39)

Proposition 2.5. We have the following estimate:

$$\left|\inf_{\substack{0 < r < r_0 \\ i=1,2}} A^{\varepsilon}[\eta_{i,r,\varepsilon}] - \inf_{0 < r < r_0} I(r)\right| \leq C\varepsilon$$
(2.40)

where C is a constant depends only on R,T, $\alpha(x)$ and $\|V\|_{L^\infty},$ $I(r)=min\{I_1(r),I_2(r)\}$ where

$$I_{1}(r) = rt_{0} + 2 \int_{x_{0}}^{c_{1,r}} \int_{0}^{1} \frac{-V(x,y)}{\sqrt{2(r - V(x,y))}} \, dy dx + u_{0}(c_{1,r}), \qquad (2.41)$$

$$I_{2}(r) = rt_{0} + 2 \int_{c_{2,r}}^{x_{0}} \int_{0}^{1} \frac{-V(x,y)}{\sqrt{2(r-V(x,y))}} \, dy \, dx + u_{0}(c_{2,r}).$$
(2.42)

Proof. Within our notation $\eta_{\varepsilon} \equiv \eta_{1,r,\varepsilon}$, we have

$$\left| u_0 \left(\varepsilon \eta_{\varepsilon} (\varepsilon^{-1} t_0) \right) - u_0 (c_{1,r}) \right| \leq \| u_0' \|_{L^{\infty}} \left| \varepsilon \eta_{\varepsilon} (\varepsilon^{-1} t_0) - c_{1,r} \right|.$$
(2.43)

since $u_0 \in \text{Lip}(\mathbb{R})$. In view of (2.17) and (2.23), (2.33), (2.43) we conclude that

$$\begin{split} |A^{\varepsilon}[\eta_{\varepsilon}] - I_{1}(r)| &\leq 2C_{F}\varepsilon + \|u_{0}'\|_{L^{\infty}} \left| \varepsilon\eta_{\varepsilon}(\varepsilon^{-1}t) - c_{1,r} \right| \\ &\leq \left(2C_{F} + C_{K} \|u_{0}'\|_{L^{\infty}} \right) \varepsilon. \end{split}$$

$$(2.44)$$

Taking the infimum over $0 < r < r_0$ we obtain

$$\left|\inf_{0 < r < r_0} A^{\varepsilon}[\eta_{1,r,\varepsilon}] - \inf_{0 < r < r_0} I_1(r)\right| \leq C_1 \varepsilon$$
(2.45)

where $C_1 = 2C_F + C_K \|u'_0\|_{L^{\infty}}$. Similarly for the case $\eta_{2,r,\epsilon}$ solves (2.14), we obtain

$$\inf_{0 < r < r_0} A^{\varepsilon}[\eta_{2,r,\varepsilon}] - \inf_{0 < r < r_0} I_2(r) \bigg| \leqslant C_2 \varepsilon$$
(2.46)

where C_2 is some constant depends on R, T, a(x) and $||V||_{L^{\infty}}$ in the same manner as C_1 . Thus our claim (2.40) is correct with $C = \max\{C_1, C_2\}$.

From (2.6), (2.21) and (2.40) we conclude that

and the proof is complete.

Corollary 2.6. We have the following representation formula

where $I_1(r)$ and $I_2(r)$ are defined in (2.41) and (2.42) respectively.

Remark 4. If V(x, y) = V(y) is independent of x, then the constants C_K in (2.39) and C_F in (2.39) are independent of R and T. Therefore the convergence is uniform in $\mathbb{R} \times [0, \infty)$ and by carefully keeping track of all constants, we get

$$C = 2\left(\|u_0'\|_{L^{\infty}(\mathbb{R})} + 4\sqrt{\max_{y\in\mathbb{T}}|V(y)|} \right).$$

Also Proposition 2.1 is no longer needed in this case.

We provide a proof for Lemma 2.7 (see [22]) with an explicit bound in Appendix. This lemma is a quantitative version of the ergodic Theorem for periodic functions in one dimension. This is a generalized version of Lemma 4.2 in [21].

Lemma 2.7. If $F(x, y) \in C^1(\mathbb{R} \times \mathbb{T})$ then for any real numbers a < b we have

$$\left|\int_{a}^{b} F\left(x, \frac{x}{\varepsilon}\right) dx - \int_{a}^{b} \left(\int_{0}^{1} F(x, y) dy\right) dx\right| \leq C\varepsilon$$

where

$$C = 2 \max_{x \in [a,b]} \int_0^1 |F(x,y)| \, dy + (b-a) \max_{x \in [a,b]} \int_0^1 \left| \frac{\partial F}{\partial x}(x,y) \right| \, dy.$$

The following lemma is crucial in handling the minimizer paths that correspond to nonpositive energies. We provide the proof of this lemma in Appendix.

Lemma 2.8. Let $\mathcal{V} \in C^2(\mathbb{R}, [0, \infty))$ with $\min_{x \in \mathbb{R}} \mathcal{V}(x) = 0$. There exists a constant L > 0 such that $|\mathcal{V}'(x)| \leq L\sqrt{\mathcal{V}(x)}$ for all $x \in \mathbb{R}$. As a consequence, $x \mapsto \sqrt{\mathcal{V}(x)}$ is Lipschitz in \mathbb{R} .

3. General strictly convex Hamiltonians setting

3.1. Setting and simplifications. Similarly to the proof of Theorem 1.3, we can assume $C_0 = 0$ and $V \in C^2(\mathbb{R} \times \mathbb{T})$. We have the following estimate ([14]):

$$\|\boldsymbol{\mathfrak{u}}_{t}^{\varepsilon}\|_{L^{\infty}} + \|\boldsymbol{\mathsf{D}}\boldsymbol{\mathfrak{u}}^{\varepsilon}\|_{L^{\infty}} \leqslant M \tag{3.1}$$

in the viscosity sense for all $\varepsilon > 0$. Since values of H(p) for |p| > M are irrelevant. This fact together with H(0) = H'(0) = 0 allows us to assume that

$$\max\left\{\frac{|\mathbf{p}|^2}{2} - K_0, \frac{|\mathbf{p}|^2}{2} - K_0|\mathbf{p}|\right\} \leqslant H(\mathbf{p}) \leqslant \min\left\{\frac{|\mathbf{p}|^2}{2} + K_0, \frac{|\mathbf{p}|^2}{2} + K_0|\mathbf{p}|\right\}$$
(3.2)

for all $p \in \mathbb{R}$ and for some $K_0 > 0$. Let $L(v) = \sup_{p \in \mathbb{R}} (p \cdot v - H(p))$ for $v \in \mathbb{R}^n$ be the Legendre transform of H, then L is C^2 and strictly convex, L(v) > L(0) = 0 for $v \neq 0$ as well as L(0) = L'(0) = 0, and

$$\max\left\{\frac{|\nu|^2}{2} - K_0, \frac{|\nu|^2}{2} - K_0|\nu|\right\} \le L(\nu) \le \min\left\{\frac{|\nu|^2}{2} + K_0, \frac{|\nu|^2}{2} + K_0|\nu|\right\}$$
(3.3)

for $\nu \in \mathbb{R}^n$. Denote:

$$\begin{cases} H_1^{-1} & := \left(H|_{[0,\infty)}\right)^{-1} \\ (L_1')^{-1} & := \left(L'|_{[0,\infty)}\right)^{-1} \\ \tilde{G}_1 & := (L_1')^{-1} \circ H_1^{-1} \end{cases} \text{ and } \begin{cases} H_2^{-1} & := \left(H|_{0,+\infty)}\right)^{-1} \\ (L_2')^{-1} & := \left(L'|_{(-\infty,0]}\right)^{-1} \\ \tilde{G}_2 & := (L_2')^{-1} \circ H_2^{-1}. \end{cases}$$

We have $H'_i = (L_i)^{-1}$ and thus $\tilde{G}_i \equiv G_i$ for i = 1, 2 where G_i are defined in the statement of Theorem 1.2. We see that $x \mapsto |G_i(x)|$ is increasing on $[0, \infty)$, $x \mapsto (L'_i)^{-1}(x)$ is increasing for i = 1, 2 and for all $x \ge K_0$ then

$$\begin{cases} (1/\sqrt{2})\sqrt{x-K_0} \leqslant G_1(x) \leqslant 2K_0 + 2\sqrt{2(x+K_0)}, \\ -(1/\sqrt{2})\sqrt{x-K_0} \geqslant G_2(x) \geqslant 2K_0 - 2\sqrt{2(x+K_0)}. \end{cases}$$
(3.4)

As a consequence, we have $|G_i(x)| \to +\infty$ as $x \to \infty$ for i = 1, 2.

3.2. Sketch of the proof of Theorem 1.2. For $\varepsilon > 0$ and R, T > 0, let us fix $(x_0, t_0) \in [-R, R] \times [0, T]$. Thanks to the optimal control formula we have

$$u^{\varepsilon}(x_{0},t_{0}) = \inf_{\eta(\cdot)\in\mathbb{T}} \left\{ \varepsilon \int_{0}^{\varepsilon^{-1}t_{0}} \left(L\left(\dot{\eta}(s)\right) - V\left(\varepsilon\eta(s),\eta(s)\right) \right) ds + u_{0}\left(\varepsilon\eta(\varepsilon^{-1}t_{0})\right) \right\}$$
(3.5)

where $\mathfrak{T} = \{\eta(\cdot) \in AC([0, \varepsilon^{-1}t_0]), \varepsilon\eta(0) = x_0\}$. For each minimizer $\eta_{\varepsilon}(\cdot) \in \mathfrak{T}$ to (3.5), there exists $r = r(\eta_{\varepsilon}) \in [V(0, 0), +\infty)$ such that

$$H(L'(\dot{\eta}_{\varepsilon}(s))) + V(\varepsilon \eta_{\varepsilon}(s), \eta_{\varepsilon}(s)) = r$$
(3.6)

for all $s \in (0, \varepsilon^{-1}t_0)$. For $r \in [V(0, 0), \infty)$ we have the Euler–Lagrange equation

$$\begin{cases} L''(\dot{\eta}_{\epsilon}(s))\ddot{\eta}_{\epsilon}(s) = -\nabla V(\epsilon\eta_{\epsilon}(s),\eta_{\epsilon}(s)) \cdot (\epsilon,1) & \text{on} \quad (0,\epsilon^{-1}t_{0}), \\ \dot{\eta}_{\epsilon}(0) = G_{i}(r - V(x_{0},\epsilon^{-1}x_{0})), \\ \eta_{\epsilon}(0) = \epsilon^{-1}x_{0}. \end{cases}$$
(E-L)

where i = 1, 2. For simplicity, let us define the following action functional

$$A^{\varepsilon}[\eta] = \varepsilon \int_{0}^{\varepsilon^{-1}t_{0}} \left(L\left(\dot{\eta}(s)\right) - V\left(\varepsilon\eta(s), \eta(s)\right) \right) ds + u_{0}\left(\varepsilon\eta(\varepsilon^{-1}t_{0})\right)$$

for $\eta(\cdot) \in T$. Thanks to (3.6), the optimization problem (3.5) is equivalent to

$$u^{\varepsilon}(x_0, t_0) = \inf_{r} \Big\{ A^{\varepsilon}[\eta_{\varepsilon}] : \text{among all } \eta_{\varepsilon}(\cdot) \text{ solve (E-L) with energy } r \Big\}.$$
(3.7)

For an interval $I \subset \mathbb{R}$ we denote by $\inf_{r \in I} A^{\epsilon}[\eta_{\epsilon}]$ the infimum over all solutions $\eta_{\epsilon}(\cdot)$ that solve (E-L) and with all energies $r \in I$. We proceed as follows:

- 1. Estimate for $r \leq 0$ with rate $O(\varepsilon)$ (Proposition 3.1).
- 2. There is $r_0 > 0$ such that we can ignore $r \ge r_0$ in (3.7) (Proposition 3.2).
- 3. For $0 < r < r_0$, $A^{\epsilon}[\eta_{\epsilon}]$ can be written as in (3.14), then we proceed to get estimates for each individual term by using an quantitative ergodic theorem (Propositions 3.4, 3.3 and 3.5).

Proposition 3.1. *If* $r \leq 0$ *then*

$$\left|\inf_{r\leqslant 0} A^{\varepsilon}[\eta_{\varepsilon}] - \mathfrak{u}_{0}(x_{0})\right| \leqslant \left(\mathsf{H}_{1}^{-1}\left(\|\mathsf{V}\|_{\mathsf{L}^{\infty}}\right) + \|\mathfrak{u}_{0}'\|_{\mathsf{L}^{\infty}}\right)\varepsilon.$$
(3.8)

Sketch of the proof. The proof is similar to Proposition 2.1 where the crucial Lemma 2.8 is replaced with Lemma 3.6.

For each $r \in (0, \infty)$, (E-L) has exactly two distinct solutions $\eta_{1,r,\epsilon}(\cdot)$ and $\eta_{2,r,\epsilon}(\cdot)$ thanks to the conservation of energy (3.6). They are

$$\begin{cases} \dot{\eta}_{\varepsilon}(s) &= G_{i}(r - V(\varepsilon \eta_{\varepsilon}(s), \eta_{\varepsilon}(s))) & \text{on} \quad (0, \varepsilon^{-1} t_{0}), \\ \eta_{\varepsilon}(0) &= \varepsilon^{-1} x_{0}, \end{cases}$$
(3.9)

for i = 1, 2 respectively. Let us consider the first case $\eta_{\epsilon}(\cdot)$ solves (3.9) with i = 1 since the other case is similar. Since $\dot{\eta}_{\epsilon}(s) > 0$ for all $s \ge 0$, we have

$$t_{0} = \varepsilon \int_{0}^{\varepsilon^{-1}t_{0}} \frac{\dot{\eta}_{\varepsilon}(s)}{\dot{\eta}_{\varepsilon}(s)} ds = \varepsilon \int_{\eta_{\varepsilon}(0)}^{\eta_{\varepsilon}(\varepsilon^{-1}t_{0})} \frac{dx}{G_{1}(r - V(\varepsilon x, x))}.$$
 (3.10)

Let $\varepsilon \to 0$ we deduce that $\eta_{\varepsilon} (\varepsilon^{-1} t_0) \to +\infty$. It is also clear from (3.9) that

$$t_0G_1(r) \leqslant \epsilon\eta_{\epsilon}(\epsilon^{-1}t_0) - \epsilon\eta_{\epsilon}(0) \leqslant t_0G_1(r + \max|V|). \tag{3.11}$$

Proposition 3.2. There exists $r_0 > 0$ depends on $Lip(u_0)$ and H(p) such that

$$\inf_{r \ge r_0} A^{\varepsilon}[\eta_{\varepsilon}] = \inf_{r \ge r_0} \left\{ A^{\varepsilon}[\eta_{1,r,\varepsilon}], A^{\varepsilon}[\eta_{2,r,\varepsilon}] \right\} \ge u^{\varepsilon}(x_0, t_0) + t_0.$$
(3.12)

Sketch of the proof. The proof is similar to Proposition 2.2 where we utilize the fact that G_1 is increasing and satisfies (3.4).

With (3.12), the optimization problem (3.7) can be reduced to

$$\mathfrak{u}^{\varepsilon}(\mathfrak{x}_{0},\mathfrak{t}_{0}) = \min\left\{\inf_{r\leqslant 0}A^{\varepsilon}[\eta_{\varepsilon}], \inf_{0< r< r_{0}}A^{\varepsilon}[\eta_{1,r,\varepsilon}], \inf_{0< r< r_{0}}A^{\varepsilon}[\eta_{2,r,\varepsilon}]\right\}.$$
(3.13)

Let $\eta_{\epsilon} = \eta_{1,r,\epsilon}$, we have $L(\dot{\eta}_{\epsilon}(s)) - V(\epsilon \eta_{\epsilon}(s), \eta_{\epsilon}(s)) = -r + \dot{\eta}_{\epsilon}(s)L'(\dot{\eta}_{\epsilon}(s))$. From that and (3.9) we can rewrite the action functional as

$$A^{\varepsilon}[\eta_{\varepsilon}] = -rt_{0} + \varepsilon \int_{\eta_{\varepsilon}(0)}^{\eta_{\varepsilon}(\varepsilon^{-1}t_{0})} H_{1}^{-1}(r - V(\varepsilon x, x)) dx + u_{0}(\varepsilon \eta_{\varepsilon}(\varepsilon^{-1}t_{0})).$$
(3.14)

Define $I_0 = I_0(T, R) = [-R, c_0 + R]$ where $c_0 = TG_1(r_0 + ||V||_{L^{\infty}})$. Since (3.11) is true for all $0 < r < r_0$ and $(x_0, t_0) \in [-R, R] \times [0, T]$ we have $\epsilon \eta_{\epsilon}(\epsilon^{-1}t_0) \in I_0$. Let $c_{1,r}$ and $c_{2,r}$ be unique numbers such that

$$\int_{x_0}^{c_{1,r}} \int_0^1 \frac{dy dx}{G_1(r - V(x,y))} = \int_{c_{2,r}}^{x_0} \int_0^1 \frac{dy dx}{G_2(r - V(x,y))} = t_0.$$
(3.15)

Proposition 3.3. For $0 < r < r_0$ we have

$$\left|\epsilon\eta_{\varepsilon}(\varepsilon^{-1}t_{0})-c_{1,r}\right|\leqslant C_{K}\varepsilon.$$
(3.16)

where $C_K = C_K(R, T, H, V)$ is a constant independent of r.

Sketch of the proof. Let $\mathcal{K}_r(x,y) = \frac{1}{G_1(r - V(x,y))}$ for $(x,y) \in \mathbb{R} \times \mathbb{T}$. Similarly to proof of Proposition 2.3, we obtain

$$C_{K} = 2\left(1 + 2c_{0}\tilde{K}\right) \sup_{0 < r < r_{0}} \left(\frac{\max_{x \in I_{0}} \int_{0}^{1} \mathcal{K}_{r}(x, y) \, dy}{\min_{x \in I_{0}} \int_{0}^{1} \mathcal{K}_{r}(x, y) \, dy}\right) < \infty$$

by assumption (A4) and

$$\tilde{\mathsf{K}} = \sup_{0 < r < r_0} \left\{ |\mathsf{V}_x(x,y)| \cdot \left| \frac{\mathsf{G}_1'(r - \mathsf{V}(x,y))}{\mathsf{G}_1(r - \mathsf{V}(x,y))} \right| : (x,y) \in \mathsf{I}_0 \times \mathbb{T} \right\} < \infty$$

by assumption (A2).

Proposition 3.4. For $0 < r < r_0$, in view of (3.14) we have

$$\left|\int_{x_0}^{\varepsilon\eta_{\varepsilon}(\varepsilon^{-1}t_0)} H_1^{-1}\left(r - V(x,\varepsilon^{-1}x)\right) dx - \int_{x_0}^{c_{1,r}} \int_0^1 H_1^{-1}\left(r - V(x,y)\right) dy dx\right| \leqslant C_F \varepsilon$$

where C_F is a constant independent of r.

Sketch of the proof. Define $\mathcal{F}_r(x, y) = H_1^{-1} (r - V(x, y))$ for $(x, y) \in \mathbb{R} \times \mathbb{T}$. The proof is similar to Proposition 2.4. We use (A3) to get the bound F_2 :

$$I_{1}(r) = -rt_{0} + \int_{x_{0}}^{c_{1,r}} \int_{0}^{1} H_{1}^{-1}(r - V(x, y)) \, dy \, dx + u_{0}(c_{1,r}), \qquad (3.18)$$

$$I_{2}(r) = -rt_{0} + \int_{c_{2,r}}^{x_{0}} \int_{0}^{1} H_{2}^{-1} \left(r - V(x, y) \right) dy \, dx + u_{0} \left(c_{2,r} \right).$$
(3.19)

The proof is omitted since it is similar to Proposition 2.5. Finally, using (3.8) and (3.17) in (3.13) we obtain the claim of Theorem 1.2.

(ii) If H, defined in Theorem 1.2, satisfies H''(0) > 0 then we have something stronger than (3.20)

In this case we have further that $C_{1,I}\sqrt{x} \leq |G_i(x)| \leq C_{2,I}\sqrt{x}$ on any bounded subset $I \subset \mathbb{R}$, where i = 1, 2 and $C_{I,1}, C_{I,2} > 0$.

(iii) If H, defined in Theorem 1.2, satisfies $H \in C^3(\mathbb{R})$ then

$$\limsup_{p \to 0} \frac{|\mathsf{H}''(\mathsf{p})|}{\sqrt{|\mathsf{H}'(\mathsf{p})|}} < \infty. \tag{3.22}$$

As a consequence, we have something stronger than (3.20)

$$\limsup_{p \to 0} \left| \frac{H''(p)}{H'(p)} \sqrt{\frac{H(p)}{|p|}} \right| < \infty.$$
(3.23)

(iv) If $H(p) = |p|^{\gamma}$ where $\gamma \ge 2$ then (3.20) holds true.

Corollary 3.7. We have the following representation formula

$$u(x_0, t_0) = \min \left\{ u_0(x_0), \min \left\{ \inf_{0 < r < r_0} I_1(r), \inf_{0 < r < r_0} I_2(r) \right\} \right\}.$$

where $I_1(r)$ and $I_2(r)$ are defined in (3.18) and (3.19), respectively.

Proof of Corollary 1.4. In order to apply Theorem 1.2 we need to check conditions (Ao),(A2),(A3),(A4). Let us fix a compact interval $I \subset \mathbb{R}$, in the assumption of V let us denote α , β , f by α_I , β_I , f_I for simplicity.

If $H(p) = |p|^{\gamma}$ where $\gamma \ge 2$ then $|G_i(p)| = \gamma |p|^{1-\frac{1}{\gamma}}$ and $|G'_i(p)| = (\gamma - 1)|p|^{-\frac{1}{\gamma}}$. Therefore conditions (Ao),(A2),(A3) follow from direct computation. (A4) follows since $p \mapsto |G_i(p)|$ is increasing and for any compact interval $I \subset \mathbb{R}$ then

$$\max_{x\in I}\int_0^1\frac{dy}{|G_i(r-V(x,y))|} \leq \frac{1}{\gamma}\left(\frac{\beta}{\alpha}\right)^{1-\frac{1}{\gamma}}\min_{x\in I}\int_0^1\frac{dy}{|G_i(r-V(x,y))|}.$$

In general when H''(0) > 0, condition (Ao) follows from Lemma 3.6. On the bounded set $[0, ||V||_{L^{\infty}} + 1]$ by Lemma 3.6 we have $C_1\sqrt{x} \leq |G_i(x)| \leq C_2\sqrt{x}$ for i = 1, 2 and for some $C_1, C_2 > 0$. For i = 1, 2, 0 < r < 1 and $x \in I$ we have

$$|V_{x}(x,y)| \cdot \frac{|G'_{i}(r-V(x,y))|}{|G_{i}(r-V(x,y))|} \leq \frac{|V_{x}(x,y)|}{|V(x,y)|} \left(\frac{\sqrt{H(\xi)}}{|G_{i}(H(\xi))|}\right) \left(\frac{|H''(\xi)|}{|H'(\xi)|}\sqrt{H(\xi)}\right)$$

where $\xi = H_i^{-1}(r - V(x, y))$. The right hand side is bounded as $r \to 0^+$ due to (Ao), $C_1\sqrt{x} \leq |G_i(x)| \leq C_2\sqrt{x}$ and (1.6), thus (A2) follows. Condition (A3) is true since for $x \in I$ then

$$\left|\frac{V_{x}(x,y)}{G_{i}(V(x,y))}\right| \leqslant \left|\frac{V_{x}(x,y)}{V(x,y)}\right| \cdot \frac{\sqrt{|V(x,y)|}}{|G_{i}(|(V(x,y)|)|)} \cdot \sqrt{|V(x,y)|}.$$

Finally, for i = 1, 2 then $x \mapsto |G_i(x)|$ is increasing, using $C_1\sqrt{x} \leqslant |G_i(x)| \leqslant C_2\sqrt{x}$ we deduce that for 0 < r < 1 then

$$\begin{split} \max_{x\in I} \int_0^1 \frac{dy}{|G_i(r-V(x,y))|} &\leq \int_0^1 \frac{dy}{|G_i(r+\alpha f(y))|} \leq \int_0^1 \frac{dy}{C_1\sqrt{r+\alpha f(y)}}\\ \min_{x\in I} \int_0^1 \frac{dy}{|G_i(r-V(x,y))|} &\geq \int_0^1 \frac{dy}{|G_i(r+\beta f(y))|} \geq \int_0^1 \frac{dy}{C_2\sqrt{r+\beta f(y)}}. \end{split}$$

Since $\alpha \leqslant \beta$, we have $\sqrt{r + \alpha f(y)} \ge \sqrt{\frac{\alpha}{\beta} (r + \beta f(y))}$ and therefore

$$\int_{0}^{1} \frac{\mathrm{d}y}{C_{1}\sqrt{r+\alpha f(y)}} \leq \left(\frac{C_{2}}{C_{1}}\sqrt{\frac{\beta}{\alpha}}\right) \int_{0}^{1} \frac{\mathrm{d}y}{C_{2}\sqrt{r+\beta f(y)}}$$

and thus (A4) follows.

4. Appendix

Proof of Lemma 2.7. Since $y \mapsto F(x,y)$ is periodic, we have $y \mapsto \frac{\partial F}{\partial x}(x,y)$ is also periodic. Let us define

$$G(x,y) = \int_0^y \left(F(x,z) - \int_0^1 F(x,\zeta) \, d\zeta \right) \, dz$$

then $\frac{\partial G}{\partial y}(x, y) = F(x, y) - \int_0^1 F(x, \zeta) d\zeta$. Since G is periodic in y, $\frac{\partial G}{\partial x}$ is also periodic in y. Thus G and $\frac{\partial G}{\partial x}$ are bounded in y. The fact that $\frac{\partial F}{\partial x}$ is bounded in x implies $\frac{\partial G}{\partial x}$ is bounded in x as well. Let $g_{\varepsilon}(x) = \varepsilon G(x, \frac{x}{\varepsilon})$ we obtain

$$\frac{\mathrm{d}}{\mathrm{d}x}\left(g_{\varepsilon}(x)\right) = \varepsilon \frac{\partial G}{\partial x}\left(x,\frac{x}{\varepsilon}\right) + \frac{\partial G}{\partial y}\left(x,\frac{x}{\varepsilon}\right) = \varepsilon \frac{\partial G}{\partial x}\left(x,\frac{x}{\varepsilon}\right) + F\left(x,\frac{x}{\varepsilon}\right) - \int_{0}^{1} F(x,\zeta) \,\mathrm{d}\zeta.$$

Thus

$$\int_{a}^{b} F\left(x,\frac{x}{\varepsilon}\right) dx - \int_{a}^{b} \int_{0}^{1} F(x,\zeta) d\zeta dx = \varepsilon \left[G\left(b,\frac{b}{\varepsilon}\right) - G\left(a,\frac{a}{\varepsilon}\right) - \int_{a}^{b} \frac{\partial G}{\partial x}\left(x,\frac{x}{\varepsilon}\right) dx \right].$$

Note that by the way we defined G, we also have

?

$$\max_{(x,y)} |G(x,y)| \leq \max_{x \in [a,b]} \int_0^1 |F(x,y)| \, dy$$
$$\left| \int_a^b \frac{\partial G}{\partial x} \left(x, \frac{x}{\varepsilon} \right) \, dx \right| \leq \int_a^b \max_{(x,y)} \left| \frac{\partial G}{\partial x} (x,y) \right| \, dx \leq (b-a) \max_{x \in [a,b]} \int_0^1 \left| \frac{\partial F}{\partial x} (x,y) \right| \, dy$$

and hence the proof is complete.

Proof of Lemma 2.8. For each $a \in [0, 1]$, an δ -neighborhood $\mathcal{N}_{a,\delta}$ of a is defined as $(a - \delta, a + \delta)$ if $a \in (0, 1)$ and $[0, \delta) \cup (1 - \delta, 1]$ if $a \in \{0, 1\}$. It is clear that $\mathcal{N}_{a,\delta}$ is open in [0, 1]. We claim that there exists $\delta = \delta(a) > 0$ such that

$$\sup_{x \in \mathcal{N}_{\alpha,\delta}^*} \frac{|\mathcal{V}'(x)|}{\sqrt{\mathcal{V}(x)}} \leqslant C_{\alpha} < \infty \tag{4.1}$$

for some constant C_a , where $\mathbb{N}^*_{a,\delta} = \{x \in \mathbb{N}_{a,\delta} : \mathcal{V}(x) \neq 0\}$. Assume that (4.1) is false, then there exists a sequence $x_k \to a^+$ such that $\mathcal{V}(x_k) \neq 0$ for all $k \in \mathbb{N}$ and

$$\lim_{k \to \infty} \frac{|\mathcal{V}'(\mathbf{x}_k)|}{\sqrt{\mathcal{V}(\mathbf{x}_k)}} = +\infty.$$
(4.2)

It is clear that $\mathcal{V}'(x_k) \neq 0$ for all $k \in \mathbb{N}$. We can assume that $\mathcal{V}'(x_k) > 0$ for all k. Let $g_k = \sqrt{\mathcal{V}(x_k)}$ and $h_k = \mathcal{V}'(x_k)$, and

$$a_k = \sup\left\{r > 0: \mathcal{V}'(x) \geqslant \frac{h_k}{2} \text{ for all } x \in (x_k - r, x_k)\right\}.$$

Clearly $\mathcal{V}'(x_k - \mathfrak{a}_k) = \frac{h_k}{2}$. By mean value theorem we have

$$g_k^2 = \mathcal{V}(x_k) \ge \mathcal{V}(x_k) - \mathcal{V}(x_k - a_k) \ge \frac{1}{2}h_k a_k.$$

By mean value theorem again, there exists $\xi_k \in (x_k - a_k, x_k)$ such that

$$\mathcal{V}^{\,\prime\prime}(\xi_k) = \frac{\mathcal{V}^{\,\prime}(x_k) - \mathcal{V}^{\,\prime}(x_k - a_k)}{a_k} = \frac{1}{2} \frac{h_k}{a_k} \ge \frac{1}{4} \left(\frac{h_k}{g_k}\right)^2 \to \infty$$

as $k \to \infty$ due to (4.2). It is a contradiction since $\mathcal{V} \in C^2([0, 1])$, thus (4.1) must be correct. By compactness of [0, 1], we can pick a finite subcover of [0, 1] from the open cover { $N_{a,\delta} : a \in [0, 1]$ }. From (4.1) there exists a constant L > 0 such that

$$\frac{|\mathcal{V}'(\mathbf{x})|}{\sqrt{\mathcal{V}(\mathbf{x})}} \leq L \quad \text{whenever} \quad \mathcal{V}(\mathbf{x}) \neq 0. \tag{4.3}$$

For $0 < \varepsilon < 1$ let $f_{\varepsilon}(x) = \sqrt{\mathcal{V}(x) + \varepsilon} \in C^2([0, 1])$. It $\mathcal{V}(x) = 0$ then $\mathcal{V}'(x) = 0$, hence $f'_{\varepsilon}(x) = 0$ as well, while if $\mathcal{V}(x) \neq 0$ then from (4.3) we have

$$|f_{\varepsilon}'(x)| = \left|\frac{\mathcal{V}'(x)}{2\sqrt{\mathcal{V}(x) + \varepsilon}}\right| \leq \frac{1}{2} \frac{|\mathcal{V}'(x)|}{\sqrt{\mathcal{V}(x)}} \leq \frac{L}{2}$$

Thus $f_{\varepsilon}(x)$ is Lipschitz on [0, 1] with a Lipschitz constant independent of ε . Let $\varepsilon \to 0$ we deduce that $x \mapsto \sqrt{\mathcal{V}(x)}$ is Lipschitz on [0, 1].

Proof of Lemma 3.6.

(i) It suffices to show for G_1 since the argument is similar for G_2 . For simplicity, let us denote G_1 , H_1^{-1} by G, H^{-1} . For $0 < \epsilon < 1$ let $f_{\epsilon}(x) = G(\mathcal{V}(x) + \epsilon)$ then $f_{\epsilon} \in C^2([0, 1])$ and

$$f_{\epsilon}'(x) = \frac{\mathcal{V}'(x)}{\sqrt{\mathcal{V}(x) + \epsilon}} \left(\frac{H''\big(H^{-1}\left(\mathcal{V}(x) + \epsilon\right)\big)}{H'\big(H^{-1}\left(\mathcal{V}(x) + \epsilon\right)\big)} \sqrt{\mathcal{V}(x) + \epsilon} \right).$$

For $x \in [0, 1]$ such that $\mathcal{V}(x) = \mathcal{V}'(x) = 0$ then obviously $f'_{\varepsilon}(x) = 0$, while if $x \in [0, 1]$ such that $\mathcal{V}(x) \neq 0$ then from (3.20) and Lemma 2.8 we have

$$|f_{\varepsilon}'(x)| \leq \left|\frac{\mathcal{V}'(x)}{\sqrt{\mathcal{V}(x)}}\right| \cdot \left|\frac{H''(\xi)}{H'(\xi)}\sqrt{H(\xi)}\right| \leq L\left(\sup_{[0,p^*]}\left|\frac{H''(p)}{H'(p)}\sqrt{H(p)}\right|\right) < \infty$$

where $\xi = H^{-1}(\mathcal{V}(x) + \varepsilon)$ and $p^* = H^{-1}(||V||_{L^{\infty}} + 1)$. Therefore f_{ε} is Lipschitz on [0, 1] with a Lipschitz constant independent of $\varepsilon > 0$. Let $\varepsilon \to 0$ we deduce that $x \mapsto G(\mathcal{V}(x))$ is Lipschitz on [0, 1].

(ii) If H''(0) > 0 then there exists $\delta > 0$ so that $H''(p) \ge c > 0$ for $p \in (-\delta, \delta)$, thus there are some m, M > 0 such that

$$\mathfrak{m}|\mathfrak{p}|^2 \leqslant \mathfrak{H}(\mathfrak{p}) \leqslant \mathfrak{M}|\mathfrak{p}|^2$$
 and $\mathfrak{m}|\mathfrak{p}| \leqslant |\mathfrak{H}'(\mathfrak{p})| \leqslant \mathfrak{M}|\mathfrak{p}|.$ (4.4)

From that (3.21) follows. On the other hand, since $G_i(x) = H'(H_i^{-1}(x))$ for i = 1, 2 and (4.4) we deduce that for all x small then

$$\sqrt{\frac{\mathfrak{m}}{M}}\sqrt{x} \leqslant |\mathsf{H}'(\mathsf{H}_{\mathfrak{i}}^{-1}(\mathfrak{x}))| \leqslant \sqrt{\frac{\mathfrak{M}}{\mathfrak{m}}}\sqrt{x}.$$
(4.5)

Since $G_i(x) = 0$ if and only if x = 0, we have (4.5) is true for any bounded set of \mathbb{R} after modifying the upper bound and lower bound.

(iii) Using the convexity of H we have $H(p) \leq pH'(p)$ for all p, hence

$$\left|\frac{\mathsf{H}''(\mathsf{p})}{\mathsf{H}'(\mathsf{p})}\sqrt{\mathsf{H}(\mathsf{p})}\right| \leqslant \frac{\mathsf{H}''(\mathsf{p})}{\sqrt{|\mathsf{H}'(\mathsf{p})|}}\sqrt{|\mathsf{p}|}.$$
(4.6)

Let $g(p) = H'(p) \in C^2(\mathbb{R})$ is strictly increasing on $(0, \infty)$ and is strictly decreasing on $(-\infty, 0)$ with g(0) = 0, we claim that indeed

$$\limsup_{p \to 0} \frac{g'(p)}{\sqrt{|g(p)|}} < \infty.$$
(4.7)

This can be done by a similar argument to Lemma 2.8, hence (3.23) follows.

(iv) It is clear from direct computation.
