Strichartz estimates for Schrödinger equations with slowly decaying potentials

Abstract

For Schrödinger equations with a class of slowly decaying repulsive potentials, we show that the solution satisfies global-in-time Strichartz estimates for any admissible pairs. Our admissible class of potentials includes the positive homogeneous potential $Z|x|^{-\mu}$ with Z > 0and $0 < \mu < 2$ in three and higher dimensions, especially the repulsive Coulomb potential. The proof employs several techniques from scattering theory such as the long time parametrix construction of Isozaki-Kitada type, propagation estimates and local decay estimates.

1 Introduction

1.1 Main results

Let $H = -\Delta + V(x)$ be the Schrödinger operator on \mathbb{R}^n with a real-valued potential V(x) decaying at infinity. Consider the Cauchy problem of Schrödinger equation

$$i\partial_t u = Hu + F, \quad (t,x) \in \mathbb{R} \times \mathbb{R}^n; \quad u|_{t=0} = u_0,$$

$$(1.1)$$

where $u_0 : \mathbb{R}^n \to \mathbb{C}$ and $F : \mathbb{R} \times \mathbb{R}^n \to \mathbb{C}$ are given data. The present paper is concerned with the so-called *Strichartz estimates*, which is a family of space-time inequalities of the form

$$\|u\|_{L^{p}(\mathbb{R};L^{q}(\mathbb{R}^{n}))} \leq C \|u_{0}\|_{L^{2}(\mathbb{R}^{n})} + C \|F\|_{L^{\tilde{p}'}(\mathbb{R};L^{\tilde{q}'}(\mathbb{R}^{n}))}$$
(1.2)

where (p,q) and (\tilde{p},\tilde{q}) satisfy the admissible condition

$$p \ge 2, \quad 2/p = n(1/2 - 1/q), \quad (n, p, q) \ne (2, 2, \infty).$$
 (1.3)

There is a vast literature on Strichartz estimates for Schrödinger equations with potentials (see the discussion below). However, the case when V is slowly decaying in the sense that

$$|V(x)| \sim |x|^{-\mu}, \quad |x| \to \infty, \tag{1.4}$$

for some $\mu \in (0, 2)$, is less understood. To the author's best knowledge, there is only one negative result in this case given by Goldberg-Vega-Visciglia [18] where they showed that if

$$V \in C^3(\mathbb{R}^n \setminus \{0\}; \mathbb{R}), \quad V(x) = |x|^{-\mu} \widetilde{V}(\theta), \quad \theta = x/|x|, \quad \mu \in [0, 2),$$

and \tilde{V} has a non-degenerate minimum point so that min $\tilde{V} = 0$ then, for any admissible pair, (global-in-time) Strichartz estimates cannot hold in general. Note that radially symmetric potentials clearly do not satisfy the above condition for the counterexample.

In light of those observations, the purpose of this paper to prove Strichartz estimates for a class of slowly decaying potentials which particularly includes radially symmetric positive potentials $|x|^{-\mu}$ with $\mu \in (0, 2)$. More precisely, we first consider the following condition.

Key words and phrases. Schrödinger equation, Strichartz estimates, slowly decaying potentials.

(H1) For all $\alpha \in \mathbb{Z}^n_+$, there exists $C_{\alpha} > 0$ such that

$$|\partial_x^{\alpha} V(x)| \le C_{\alpha} (1+|x|)^{-\mu-|\alpha|}, \quad x \in \mathbb{R}^n.$$

(H2) There exists $C_1 > 0$ such that

$$V(x) \ge C_1 (1+|x|)^{-\mu}, \quad x \in \mathbb{R}^n.$$

(H3) There exists $R_0, C_2 > 0$ such that

$$-x \cdot \nabla V(x) \ge C_2 (1+|x|)^{-\mu}, \quad |x| \ge R_0.$$

Under condition (H1), $-\Delta + V$ is essentially self-adjoint on $C_0^{\infty}(\mathbb{R}^n)$ and we denote by H its unique self-adjoint extension on $L^2(\mathbb{R}^n)$ with domain $D(H) = D(-\Delta)$. The solution u to (1.1) is given by Duhamel's formula

$$u = e^{-itH}u_0 - i\int_0^t e^{-i(t-s)H}F(s)ds$$

Moreover, H is purely absolutely continuous: $\sigma(H) = \sigma_{ac}(H) = [0, \infty)$. In particular, H has no eigenvalue. The main result for smooth potentials then is as follows.

Theorem 1.1. Let $n \ge 2$, $\mu \in (0,2)$ and $V \in C^{\infty}(\mathbb{R}^n;\mathbb{R})$ satisfy (H1)–(H3). Then, for any (p,q) and (\tilde{p},\tilde{q}) satisfying (1.3), there exists C > 0 such that

$$\|e^{-itH}u_0\|_{L^p(\mathbb{R};L^q(\mathbb{R}^n))} \le C\|u_0\|_{L^2(\mathbb{R}^n)},\tag{1.5}$$

$$\left\| \int_{0}^{t} e^{-i(t-s)H} F(s) ds \right\|_{L^{p}(\mathbb{R}; L^{q}(\mathbb{R}^{n}))} \leq C \|F\|_{L^{\tilde{p}'}(\mathbb{R}; L^{\tilde{q}'}(\mathbb{R}^{n}))},$$
(1.6)

for all $u_0 \in L^2(\mathbb{R}^n)$ and $F \in L^{\tilde{p}'}(\mathbb{R}; L^{\tilde{q}'}(\mathbb{R}^n)) \cap L^1_{\text{loc}}(\mathbb{R}; L^2(\mathbb{R}^n)).$

Here we have taken the condition $F \in L^1_{\text{loc}}(\mathbb{R}; L^2(\mathbb{R}^n))$ to make sure that the map $F \mapsto \int_0^t e^{-i(t-s)H} F(s) ds$ has clear sense. Of course, (1.6) implies that it extends to a bounded operator from $L^{\tilde{p}'}(\mathbb{R}; L^{\tilde{q}'}(\mathbb{R}^n))$ to $L^p(\mathbb{R}; L^q(\mathbb{R}^n))$. The same remark also applies to the next theorem.

We next consider potentials with local singularity. Combining with Theorem 1.1 and weighted space-time L^2 -estimates proved by [4], we have the following.

Theorem 1.2. Let $n \geq 3$, Z > 0 and $\mu \in (0,2)$. Suppose that $V_S \in C^{\infty}(\mathbb{R}^n; \mathbb{R})$ satisfies

$$\left|\partial_x^{\alpha} V_S(x)\right| \le C_{\alpha} (1+|x|)^{-1-\mu-|\alpha|}, \quad x \in \mathbb{R}^n,$$

for all $\alpha \in \mathbb{Z}_+^n$. Let $H_1 = -\Delta + Z|x|^{-\mu} + \varepsilon V_S(x)$. Then there exists $\varepsilon_* = \varepsilon_*(Z, \mu, V_S) > 0$ such that for all $\varepsilon \in [0, \varepsilon_*)$ and (p, q) and (\tilde{p}, \tilde{q}) satisfying (1.3), there exists C > 0 such that

$$\|e^{-itH_1}u_0\|_{L^p(\mathbb{R};L^q(\mathbb{R}^n))} \le C\|u_0\|_{L^2(\mathbb{R}^n)},$$
$$\left\|\int_0^t e^{-i(t-s)H_1}F(s)ds\right\|_{L^p(\mathbb{R};L^q(\mathbb{R}^n))} \le C\|F\|_{L^{\tilde{p}'}(\mathbb{R};L^{\tilde{q}'}(\mathbb{R}^n))}$$

for all $u_0 \in L^2(\mathbb{R}^n)$ and $F \in L^{\tilde{p}'}(\mathbb{R}; L^{\tilde{q}'}(\mathbb{R}^n)) \cap L^1_{\text{loc}}(\mathbb{R}; L^2(\mathbb{R}^n)).$

Remark 1.3. Under the conditions in Theorem 1.2, H_1 is defined as the unique self-adjoint operator generated by the lower semi-bounded sesquilinear form $\langle (-\Delta + Z|x|^{-\mu} + \varepsilon V_S)f, g \rangle$ on $C_0^{\infty}(\mathbb{R}^n)$. Moreover, H_1 is purely absolutely continuous and has no eigenvalue.

Remark 1.4. It will be seen in the proof that one can choose $\varepsilon_* = \min(Z/M_0, \ \mu Z/M_1)$ in Theorem 1.2, where $M_{\ell} = |||x|^{\mu} (x \cdot \nabla)^{\ell} V_S||_{\infty}$.

Remark 1.5. Both of conditions (H1)–(H3) and conditions in Theorem 1.2 do not intersect with one for the above counterexample by [18].

Remark 1.6. The restriction $n \ge 3$ on the space dimension in Theorem 1.2 is due to the use of the following space-time L^2 -estimate with a singular weight

$$\|\chi(x)|x|^{-\mu/2}e^{-it(-\Delta+V)}u_0\|_{L^2(\mathbb{R}^{1+n})} \le C\|u_0\|_{L^2(\mathbb{R}^n)}$$

for V satisfying (H1)–(H3), where $\chi \in C_0^{\infty}(\mathbb{R}^n)$. This estimate immediately follows from the endpoint Strichartz estimate if $n \geq 3$ since $\chi(x)|x|^{-\mu/2} \in L^n$, but this is not the case if n = 2since the endpoint Strichartz estimate cannot hold in two space dimensions. It might be possible to obtain this estimate by revisiting the argument of Subsection 2.5 in this paper with a more careful analysis. However, we do not pursue this issue for the sake of simplicity.

We here recall some known results. When $V \equiv 0$, *i.e.*, the free case $H = -\Delta$, Strichartz estimates (1.2) were found by Strichartz [41] in case of p = q and then extended by [16, 43] for all admissible pairs, except for the endpoint cases: p or $\tilde{p} = 2$. The endpoint cases were settled by [27]. While the original proof of Strichartz [41] relied on a Fourier restriction theorem, the proof by [16, 43, 27] employed the so-called TT^* -argument which is based on the L^2 -boundedness of the unitary group $e^{it\Delta}$ and the following dispersive estimate

$$\|e^{it\Delta}\|_{1\to\infty} \le C|t|^{-n/2}, \quad t\in\mathbb{R}\setminus\{0\}.$$

In fact, Keel-Tao [27] showed in a quite abstract setting that these two estimates imply Strichartz estimates for all admissible pairs. In case with decaying potentials V, there is also a huge literature on Strichartz estimates. In particular, in a seminal paper [36], Rodnianski-Schlag showed that if V is of very-short range in the sense that there exists $\varepsilon > 0$ such that

$$|V(x)| \le C(1+|x|)^{-2-\varepsilon},$$

then Strichartz estimates holds for all non-endpoint admissible pairs, provided that initial data belong to the continuous subspace of H and the zero energy is neither an eigenvalue nor a resonance of H. Moreover, in the proof, they introduced a simple but very useful perturbation method which states briefly that, for two self-adjoint operators H_0 and $H = H_0 + V$, if e^{-itH_0} satisfies the Strichartz estimate for a non-endpoint admissible pair (p,q), and there exists a decomposition $V = A^*B$ such that A is H_0 -smooth and $BP_{\rm ac}(H)$ is H-smooth in the sense of Kato [26], then $e^{-itH}P_{\rm ac}(H)$ satisfies the Strichartz estimate for the same pair (p,q). For further results on Strichartz estimates with very short-range potentials in a more general sense, we refer to [17, 1, 30]. There are also many results in the case when V is of the inverse-square type in the sense that $|x|^2 V \in L^{\infty}(\mathbb{R}^n)$ (see [8, 4, 29]). In the slowly decaying case, there are several results on weighted L^2 estimates, or equivalently, uniform resolvent estimates [32, 15, 33, 4]. However, as explained above, there is no known positive result on global-in-time Strichartz estimates. Note that, even if $1 < \mu < 2$, the property (1.4) is too weak to apply Rodnianski-Schlag's method since $\langle x \rangle^{-\alpha}$ is Δ -smooth if and only if $\alpha \geq 1$ for $n \geq 3$ and $\alpha > 1$ for n = 2 (see [42]).

We conclude this subsection by stating a simple application of the above theorems. As is well known, Strichartz estimates are very useful for studying scattering theory for nonlinear dispersive and wave equations. It is hence very likely that Theorems 1.1 and 1.2 could be used to study the following nonlinear Schrödinger equation

$$(i\partial_t + \Delta - V)v = \sigma |v|^p v, \quad (t,x) \in \mathbb{R} \times \mathbb{R}^n; \quad v(0,x) = v_0(x), \quad x \in \mathbb{R}^n,$$
(1.7)

for V satisfying (H1)–(H3) or the assumption in Theorem 1.2 and a suitable range of p, where $\sigma = \pm 1$. For instance, we let $n \geq 3$, $H = -\Delta + V$ satisfy (H1)–(H3) and consider the mass-critical case p = 4/n. Then one can show in both cases $\sigma = \pm 1$ the small data scattering, namely if $||v_0||_{L^2}$ is sufficiently small then there exists a unique (mild) solution $v \in C(\mathbb{R}; L^2(\mathbb{R}^n)) \cap L^{2+4/n}(\mathbb{R}^{1+n})$ to (1.7) such that v scatters in the sense that there exist $v_{\pm} \in L^2$ such that

$$\lim_{t \to \pm \infty} \|v(t) - e^{-itH} v_{\pm}\|_{L^2} = 0.$$

This is a straightforward consequence of Theorem 1.1 and the proof is analogous to the free case (see, for instance, [28, Section 3]). Moreover, by linear scattering theory (see, *e.g.*, [12]), we see that, for the short-range case $1 < \mu < 2$, the wave operators

$$W^{\pm} := \operatorname{s-lim}_{t \to \pm \infty} e^{itH} e^{it\Delta}$$

exist and are asymptotically complete: Range $W_{\pm} = \mathcal{H}_{ac}(H)$, the absolutely continuous subspace of H, while in the long-range case $0 < \mu \leq 1$, the modified wave operators

$$W_S^{\pm} := \operatorname{s-lim}_{t \to \pm \infty} e^{itH} e^{-iS(t,D)}$$

exist and are asymptotically complete: Range $W_S^{\pm} = \mathcal{H}_{ac}(H)$, where $S(t, D) = \mathcal{F}^{-1}S(t,\xi)\mathcal{F}$ is a Fourier multiplier by an approximate solution to the Hamilton-Jacobi equation

$$\partial_t S(t,\xi) = |\xi|^2 + V(\nabla_\xi S(t,\xi))$$

Since $\mathcal{H}_{ac}(H) = L^2(\mathbb{R}^n)$ in the present case, we have proved the following corollary.

Corollary 1.7. Let $n \geq 3$, p = 4/n and $\sigma = \pm 1$. If $||v_0||_{L^2}$ is small enough, then (1.7) admits a unique global mild solution $v \in C(\mathbb{R}; L^2(\mathbb{R}^n)) \cap L^{2+4/n}(\mathbb{R}^{1+n})$. Moreover, there exist $\tilde{v}_{\pm} \in L^2$ such that

$$\lim_{t \to \pm \infty} \|v(t) - e^{it\Delta} \tilde{v}_{\pm}\|_{L^2} = 0 \quad if \quad 1 < \mu < 2$$

and that

$$\lim_{t \to \pm \infty} \|v(t) - e^{-iS(t,D)} \tilde{v}_{\pm}\|_{L^2} = 0 \quad if \quad 0 < \mu \le 1.$$

1.2 Notation

Throughout the paper we use the following notation. $\langle x \rangle$ stands for $\sqrt{1+|x|^2}$. $\mathcal{S}(\mathbb{R}^n)$ denotes the Schwartz space. For Banach spaces X and Y, $\mathbb{B}(X, Y)$ denotes the Banach space of bounded linear operators from X to Y, $\mathbb{B}(X) = \mathbb{B}(X, X)$ and $\|\cdot\|_{X \to Y} := \|\cdot\|_{\mathbb{B}(X,Y)}$. We write $L^q = L^q(\mathbb{R}^n)$, $L^p_t L^q_x = L^p(\mathbb{R}; L^q(\mathbb{R}^n))$,

$$\|\cdot\|_q := \|\cdot\|_{L^q}, \quad \|\cdot\|_{p \to q} := \|\cdot\|_{L^p \to L^q}, \quad \|\cdot\| := \|\cdot\|_{2 \to 2^q}$$

 $\langle f,g \rangle$ stands for the inner product $\int f\overline{g}$ on L^2 . $\mathcal{H}^{\gamma}(\mathbb{R}^{\ell})$ denotes the L^2 -Sobolev space on \mathbb{R}^{ℓ} of order γ with norm $\|f\|_{\mathcal{H}^{\gamma}} = \|\langle D \rangle^{\gamma} f\|_2$. For $p \in [1,\infty]$, p' = p/(p-1) denotes its Hölder conjugate exponent. We denote the Sobolev critical exponent and its dual by

$$2^* = \begin{cases} \frac{2n}{n-2}, & n \ge 3, \\ \infty, & n = 2, \end{cases}, \quad 2_* = (2^*)' = \frac{2n}{n+2},$$

For positive constants or operators $A, B, A \leq B$ (resp. $A \geq B$) means that there exists a non-essential constant C > 0 such that $A \leq CB$ (resp. $A \geq CB$). In particular, the symbols \leq and \geq will be often used when inequalities are uniform with respect to the frequency parameters λ, h or to the temporal parameter t.

1.3 Outline of the proof

Here we briefly explain the ideas of the proof of Theorem 1.1. We employ the scheme developed by [7, 5, 6, 3] in the study of Strichartz estimates on manifolds.

For simplicity, we may consider the homogeneous estimate (1.5) only. At first, since V is nonnegative, an abstract argument shows that the square function estimates for the homogeneous Littlewood-Paley decomposition associated with H hold true. Then the proof can be reduced to proving following energy localized estimate

$$\|\varphi(\lambda^{-2}H)e^{-itH}u_0\|_{L^p_*L^q_x} \lesssim \|u_0\|_{L^2}, \quad \lambda > 0,$$

where $\varphi \in C_0^{\infty}((0,\infty))$ and the implicit constant should be independent of λ . Since the high energy case $\lambda \geq 1$ can be handled similarly, we here focus on the low energy case $\lambda \in (0,1]$.

We next decompose the energy localized solution $\varphi(\lambda^{-2}H)e^{-itH}u_0$ into two regions $\{\lambda|x| \leq 1\}$ and $\{\lambda|x| \geq 1\}$. For the part $\{\lambda|x| \leq 1\}$, by virtue of Bernstein's inequality $\|\varphi(\lambda^{-2}H)\|_{2\to 2^*} \lesssim \lambda$, the desired Strichartz estimate can be deduced from a weighted L^2 -estimate

$$\|\langle x \rangle^{-1} e^{-itH} u_0 \|_{L^2_t L^2_x} \lesssim \|u_0\|_{L^2}$$

which follows from the uniform resolvent estimate proved by Nakamura [32] under the conditions (H1)–(H3) and Kato's smooth perturbation theory [26]. For the non-compact part $\{\lambda | x | \geq 1\}$, we approximate the energy localization $\varphi(\lambda^{-2}H)$ by a suitable rescaled pseudodifferential operator $\mathcal{D} \operatorname{Op}(a^{\lambda})^* \mathcal{D}^*$ modulo an error term, where $\mathcal{D}f(x) = \lambda^{n/2}f(\lambda x)$ is the usual dilation and $a^{\lambda}(x,\xi)$ is a smooth bounded symbol supported in the region $\{|x| \geq 1, |\xi|^2 + V^{\lambda}(x) \sim 1\}$ and $V^{\lambda}(x) = \lambda^{-2}V(\lambda^{-1}x)$. Then the error term can be handled by a similar argument as that for the compact part. By rescaling, the main term $\mathcal{D} \operatorname{Op}(a^{\lambda})^* \mathcal{D}^* e^{-itH}$ can be written in the form

$$\mathcal{D}\operatorname{Op}(a^{\lambda})^{*}e^{-it\lambda^{2}H^{\lambda}}\mathcal{D}^{*}$$
(1.8)

where $H^{\lambda} = -\Delta + V^{\lambda}(x)$. Here note that $V^{\lambda}(x)$ only satisfies

$$|V^{\lambda}(x)| \lesssim \lambda^{-2} (1 + \lambda^{-1}|x|)^{-\mu} = \lambda^{-2+\mu} (\lambda + |x|)^{-\mu}$$

and, thus, may blow up as $\lambda \to 0$. Hence it seems to be difficult to handle the operator (1.8) uniformly in small λ . To overcome this difficulty, we introduce another small parameter

$$h = \lambda^{2/\mu - 1}$$

By a scaling argument with respect to h, the problem then is reduced to treat the operator

$$\operatorname{Op}_{h}(a_{h})^{*}e^{-itH_{h}/h},\tag{1.9}$$

where $H_h = -h^2 \Delta + V_h(x)$, $V_h(x) = \lambda^{-2} V(\lambda^{-2/\mu} x)$, and $Op_h(a_h)$ is a semiclassical pseudodifferential operator with the symbol a_h supported in $\{|x| \ge 1, |\xi|^2 + V_h(x) \sim 1\}$. The main advantage to introduce the parameter h is that, since V_h obeys

$$|V_h(x)| \lesssim (\lambda^{2/\mu} + |x|)^{-\mu} \lesssim \langle x \rangle^{-\mu}$$

for $|x| \gtrsim 1$ uniformly in h, we can use the semiclassical analysis to handle the operator (1.9) uniformly in h. Then, we further decompose $\operatorname{Op}_h(a_h)^* e^{-itH_h}$ into two regions $\{|x| \sim 1\}$ and $\{|x| \gg 1\}$. For the former part, we employ a similar idea as in Staffilani-Tataru [39] which yields that the desired Strichartz estimate can be deduced from the semiclassical WKB parametrix construction for sufficiently small t, and the local smoothing estimate of the form

$$\|\langle x \rangle^{-1} \varphi(H_h) e^{-itH_h/h} u_0 \|_{L^2_t L^2} \lesssim \|u_0\|_{L^2}$$

which can be obtained by using a semiclassical version of Mourre's theory. It follows from this step that we may assume that a_h is supported in $\{|x| \gg 1, |\xi| \sim 1\}$. We then decompose a_h into the outgoing part a_h^+ and incoming part a_h^- . Thanks to the abstract TT^* -argument by Keel-Tao [27], it suffices to show the following dispersive estimate

$$\|\operatorname{Op}_{h}(a_{h}^{\pm})^{*}\varphi(H_{h})e^{-itH_{h}/h}\operatorname{Op}_{h}(a_{h}^{\pm})\|_{1\to\infty} \lesssim |th|^{-n/2}, \quad t\neq 0, \ h\in(0,1].$$

To this end, we essentially follow the idea of Bouclet-Tzvetkov [6]. The main ingredient for the proof of this dispersive estimate is the construction of the semiclassical Isozaki-Kitada (IK) parametrix of $e^{-itH_h/h} \operatorname{Op}_h(a_h^+)$ whose main term is of the form

$$J_{h}^{+}(c^{+})e^{ith\Delta}J_{h}^{+}(d^{+})^{*},$$

where $J_h^+(w)$, which is called the IK modifier, is a semiclassical Fourier integral operator with a time-independent phase function $S^+(x,\xi) = x \cdot \xi + O(\langle x \rangle^{1-\mu})$. The dispersive estimate for the main part of the IK parametrix is a simple consequence of the standard stationary phase theorem, while several propagation estimates will be used in order to deal with the error term. To prove such propagation estimates, we employ the local decay estimate for the propagator which can be obtained by means of the semiclassical version studied by Nakamura [31] of the multiple commutator method by Jensen-Mourre-Perry [24].

The paper is organized as follows. We collect several preliminary materials in Section 2 which include a brief review on the semiclassical pseudodifferential operator calculus, the dilation and rescaled Hamiltonians, basic properties of the spectral multiplier $\varphi(\lambda^{-2}H)$ and an associated Littlewood-Paley decomposition, the approximations of the spectral multiplier in terms of rescaled pseudodifferential operators, and local smoothing and local decay estimates for the propagator. The proofs of homogeneous estimates (1.5) and inhomogeneous estimates (1.6) of Theorem 1.1 are given in Sections 3 and 4, respectively. Section 5 concerns with the proof of Theorem 1.2 which is based on Theorem 1.1 and Rodnianski-Schlag's method. Appendix A is devoted to the proof of a uniform weighted bound for the power of semiclassical resolvent which will be used in the proof of local decay estimates.

2 Preliminaries

We start with collecting several preliminary results which will be used in the sequel.

2.1 Semiclassical pseudodifferential calculus

Let $S^{\mu,m} = S(\langle x \rangle^{\mu} \langle \xi \rangle^{m}, \langle x \rangle^{-2} dx^{2} + \langle \xi \rangle^{-2} d\xi^{2})$ be a family of symbols $a \in C^{\infty}(\mathbb{R}^{2n})$ satisfying

$$|\partial_x^{\alpha}\partial_{\xi}^{\beta}a(x,\xi)| \le C_{\alpha\beta}\langle x \rangle^{\mu-|\alpha|} \langle \xi \rangle^{m-|\beta|}, \quad x,\xi \in \mathbb{R}^n.$$
(2.1)

As usual, we set $S^{\mu,-\infty} = \bigcap_{m\geq 0} S^{\mu,-m}$ and $S^{-\infty,m} := \bigcap_{\mu\geq 0} S^{-\mu,m}$. Henceforth, for a given *h*-dependent symbol $a_h \in C^{\infty}(\mathbb{R}^{2n})$ with a small parameter $h \in (0,1]$, we also say that $a_h \in S^{\mu,m}$ if $\{a_h\}_{h\in(0,1]}$ is bounded in $S^{\mu,m}$, namely $C_{\alpha\beta}$ in (2.1) may be taken uniformly in $h \in (0,1]$.

For $a \in S^{\mu,m}$, the semiclassical pseudodifferential operator (h-PDO) $Op_h(a)$ is defined by

$$Op_h(a)f(x) = a(x,hD)f(x) := \frac{1}{(2\pi h)^n} \int e^{i(x-y)\cdot\xi/h} a(x,\xi)f(y)dyd\xi.$$

We also use the notation $\operatorname{Op}(a) := \operatorname{Op}_1(a)$ when h = 1. $\operatorname{Op}_h(a)$ maps from $\mathcal{S}(\mathbb{R}^n)$ to $\mathcal{S}'(\mathbb{R}^n)$ for any $\mu, m \in \mathbb{R}$. If $a \in S^{0,0}$ then Calderón-Vaillancourt's theorem shows that

$$\sup_{h \in (0,1]} \|\operatorname{Op}_{h}(a)\| \lesssim \sum_{|\alpha+\beta| \le N} \|\partial_{x}^{\alpha}\partial_{\xi}^{\beta}a\|_{L^{\infty}(\mathbb{R}^{2n})}$$

with some $N \in \mathbb{N}$ depending only on n. If $a \in S^{\mu,m}$ with $\mu \leq 0$ and m < -n, then $Op_h(a)$ extends to a bounded operator from L^p to L^q for any $1 \leq p \leq q \leq \infty$, satisfying

$$\sup_{h \in \{0,1\}} h^{n(\frac{1}{p} - \frac{1}{q})} \| \operatorname{Op}_{h}(a) \|_{p \to q} \le C_{npq} < \infty$$
(2.2)

(see [5, Proposition 2.4]). The following symbolic calculus is also well known (see [21]).

Proposition 2.1. Let $\mu, \mu', m, m', \in \mathbb{R}$, $a \in S^{\mu,m}$ and $b \in S^{\mu',m'}$. Then there exists $a \# b \in S^{\mu+\mu',m+m'}$ such that $\operatorname{Op}_h(a) \operatorname{Op}_h(b) = \operatorname{Op}_h(a \# b)$ and

$$a\#b = \sum_{|\alpha| < N} \frac{h^{|\alpha|}}{\alpha!} \partial_{\xi}^{\alpha} a D_x^{\alpha} b + h^N r_N, \quad r_N \in S^{\mu + \mu' - N, m + m' - N}.$$
 (2.3)

Moreover, there exists $a^* \in S^{\mu,m}$ such that $\operatorname{Op}_h(a)^* = \operatorname{Op}_h(a^*)$ and

$$a^* = \sum_{|\alpha| < N} \frac{h^{|\alpha|}}{\alpha!} \partial_{\xi}^{\alpha} D_x^{\alpha} \overline{a} + h^N r_N^*, \quad r_N^* \in S^{\mu - N, m - N},$$
(2.4)

where $\operatorname{Op}_h(a)^*$ is the formal adjoint of $\operatorname{Op}_h(a)$.

Remark 2.2. The remainder r_N in the expansion (2.3) can be written explicitly as

$$r_N(x,\xi) = \frac{N}{(2\pi h)^n} \sum_{|\alpha|=N} \frac{1}{\alpha!} \iiint_0^1 e^{-y \cdot \eta/h} \frac{\eta^{\alpha}}{h^{\alpha}} (1-t)^{N-1} (\partial_{\xi}^{\alpha} a)(x,\xi+t\eta) b(x+y,\xi) dt dy d\eta.$$

In particular, if $\partial_{\xi}^{\alpha} a \equiv 0$ on \mathbb{R}^{2n} for all $|\alpha| \geq N$ then $r_N \equiv 0$. This is the case when N = 3 and $a = |\xi|^2 + V(x)$, the symbol of H. This fact will be used in the proof of Proposition 2.12 below.

2.2 Dilation and rescaled Hamiltonians

The dilation group $\mathcal{D}(\theta)$ defined by $\mathcal{D}(\theta)f(x) := \theta^{n/2}f(\theta x)$ for $\theta > 0$ plays a crucial role throughout the paper. $\mathcal{D}(\theta)$ is unitary on $L^2(\mathbb{R}^n)$ and its dual is given by $\mathcal{D}(\theta)^* = \mathcal{D}(\theta^{-1})$. Moreover, $\mathcal{D}(\theta)$ is bounded on L^q satisfying

$$\|\mathcal{D}(\theta)f\|_{q} = \theta^{n(\frac{1}{2} - \frac{1}{q})} \|f\|_{q}, \quad 1 \le q \le \infty.$$
(2.5)

For a Borel measurable function φ on \mathbb{R}^n , the actions of $\mathcal{D}(\theta)$ on $\varphi(x)$ and $\varphi(D)$ are given by

$$\varphi(x) = \mathcal{D}(\theta)\varphi(\theta^{-1}x)\mathcal{D}(\theta)^*, \ \varphi(D) = \mathcal{D}(\theta)\varphi(\theta D)\mathcal{D}(\theta)^*,$$
(2.6)

respectively, where $D = -i\nabla$ and $\varphi(D) := \mathcal{F}^{-1}\varphi(\xi)\mathcal{F}$ is the Fourier multiplier. Given a parameter $\lambda > 0$, we will use dilations with two different scaling parameters

$$\mathcal{D} := \mathcal{D}(\lambda), \quad \mathcal{D}_{\mu} := \mathcal{D}(\lambda^{2/\mu})$$

The actions of \mathcal{D} and \mathcal{D}_{μ} on H are given by

$$H = \lambda^2 \mathcal{D} H^{\lambda} \mathcal{D}^* = \lambda^2 \mathcal{D}_{\mu} H_{h_{\lambda}} \mathcal{D}_{\mu}^*, \qquad (2.7)$$

where the rescaled Hamiltonians H^{λ} and $H_{h_{\lambda}}$ are defined by

$$H^{\lambda} := -\Delta + V^{\lambda}(x), \qquad V^{\lambda}(x) := \lambda^{-2} V(\lambda^{-1} x),$$

$$H_{h_{\lambda}} := -h_{\lambda}^{2} \Delta + V_{h_{\lambda}}(x), \qquad V_{h_{\lambda}}(x) := \lambda^{-2} V(\lambda^{-2/\mu} x) = h_{\lambda}^{-\frac{2\mu}{2-\mu}} V(h_{\lambda}^{-\frac{2}{2-\mu}} x)$$

with $h_{\lambda} = \lambda^{2/\mu-1}$. In what follows we drop the subscript λ and use the notation

$$h = \lambda^{2/\mu - 1}$$

everywhere. It follows from (2.7) that the actions of \mathcal{D} and \mathcal{D}_{μ} on $\psi(H)$ are given by

$$\psi(\lambda^{-2}H) = \mathcal{D}\psi(H^{\lambda})\mathcal{D}^* = \mathcal{D}_{\mu}\psi(H_h)\mathcal{D}_{\mu}^*.$$
(2.8)

Here, for a Borel measurable function ψ on \mathbb{R} , the spectral multiplier $\psi(H)$ is defined by

$$\psi(H) = \int \psi(\rho) \, dE_H(\rho),$$

where E_H is the spectral measure associated with H.

Lemma 2.3. Assume (H1)–(H3). Then V^{λ} and V_h satisfy the following estimates:

$$|\partial_x^{\alpha} V^{\lambda}(x)| \le C_{\alpha} \lambda^{-2+\mu} (\lambda + |x|)^{-\mu - |\alpha|}, \quad x \in \mathbb{R}^n,$$
(2.9)

$$V^{\lambda}(x) \ge C_1 \lambda^{-2+\mu} (\lambda + |x|)^{-\mu}, \quad x \in \mathbb{R}^n,$$
(2.10)

$$x \cdot (\nabla V^{\lambda})(x) \le -C_2 \lambda^{-2+\mu} (\lambda + |x|)^{-\mu}, \quad |x| \ge \lambda R_0, \tag{2.11}$$

$$|\partial_x^{\alpha} V_h(x)| \le C_{\alpha} (\lambda^{2/\mu} + |x|)^{-\mu - |\alpha|}, \quad x \in \mathbb{R}^n,$$
(2.12)

$$V_h(x) \ge C_1 (\lambda^{2/\mu} + |x|)^{-\mu}, \quad x \in \mathbb{R}^n,$$
(2.13)

$$x \cdot (\nabla V_h)(x) \le -C_2 (\lambda^{2/\mu} + |x|)^{-\mu}, \quad |x| \ge \lambda^{2/\mu} R_0.$$
(2.14)

Proof. The lemma follows immediately from (H1)–(H3).

Remark 2.4. By virtue of this lemma, the action of \mathcal{D} is well adapted to an analysis in the high energy regime $\lambda \geq 1$, while the action of \mathcal{D}_{μ} is well adapted to an analysis in the low energy regime $0 < \lambda \leq 1$. Moreover H_h can be regarded as a semiclassical Hamiltonian with the semiclassical parameter $h = \lambda^{2/\mu-1}$ if $\lambda \leq 1$.

2.3 Spectral multiplier and Littlewood-Paley decomposition

This subsection concerns with mapping properties of the spectral multiplier and square function estimates for the Littlewood-Paley decomposition associated with H. We also show here that Theorem 1.1 follows from corresponding energy localized estimates (see Theorem 2.10). Throughout this subsection, we assume that $V \ge 0$ and $V \in L^1_{loc}$ so that $H = -\Delta + V$ is defined as the unique self-adjoint operator associated with the non-negative quadratic form $\langle (-\Delta + V)u, u \rangle$ on $C_0^{\infty}(\mathbb{R}^n)$. We begin with stating Hörmander's type multiplier theorem.

Lemma 2.5. Let $m \in L^{\infty}(\mathbb{R})$ satisfy, with some $\gamma > (n+1)/2$ and non-trivial $\varphi \in C_0^{\infty}((0,\infty))$,

$$|m|_{\gamma} := \sup_{t>0} \|\varphi(\cdot)m(t\cdot)\|_{\mathcal{H}^{\gamma}(\mathbb{R})} < \infty.$$

Then all of $m(\lambda^{-2}H), m(H^{\lambda})$ and $m(H_h)$ are bounded on L^p for any $1 and <math>\lambda > 0$. Moreover, their operator norms on L^p are uniformly bounded with respect to $\lambda > 0$.

Proof. Since $V \ge 0$, the kernel $e^{-tH}(x, y)$ of e^{-tH} satisfies the upper Gaussian bound (see [37])

$$0 \le e^{-tH}(x,y) \le e^{t\Delta}(x,y) = (4\pi t)^{-\frac{n}{2}} e^{-\frac{|x-y|^2}{4t}}, \quad t > 0, \ x,y \in \mathbb{R}^n,$$

which, together with the formula $e^{-tH^{\lambda}} = \mathcal{D}^* e^{-\lambda^{-2}tH} \mathcal{D}$, implies

$$e^{-tH^{\lambda}}(x,y) = \lambda^{-n} e^{-\lambda^{-2}tH}(\lambda^{-1}x,\lambda^{-1}y) \le (4\pi t)^{-\frac{n}{2}} e^{-\frac{|x-y|^2}{4t}}.$$
(2.15)

Then an abstract theorem [9, Theorem 1.2] applies to H, yielding

$$\|m(H^{\lambda})f\|_{p} \lesssim (p+(p-1)^{-1})(1+|m|_{\gamma}+\|m\|_{L^{\infty}}^{2})\|f\|_{L^{p}}, \quad f \in \mathcal{S}(\mathbb{R}^{n}),$$

for all $1 uniformly in <math>\lambda > 0$. This estimate, combined with the fact

$$||m(\lambda^{-2}H)||_{p\to p} = ||m(H^{\lambda})||_{p\to p} = ||m(H_h)||_{p\to p}$$

which follows from (2.5) and (2.8), implies the desired assertion.

Lemma 2.6. Let $m \in S(\mathbb{R})$, $1 \le p \le q \le \infty$ and $(p,q) \ne (1,1), (\infty,\infty)$. Then

$$||m(\lambda^{-2}H)||_{p \to q} \le C_{pq} \lambda^{n(\frac{1}{p} - \frac{1}{q})}, \quad \lambda > 0.$$
 (2.16)

Proof. Since $||m(\lambda^{-2}H)||_{p\to q} = \lambda^{n(1/p-1/q)} ||m(H^{\lambda})||_{p\to q}$ by (2.5) and (2.8), it suffices to show $m(H^{\lambda}) \in \mathbb{B}(L^p, L^q)$ with uniform bounds in λ . We also may assume $q = \infty$ since other cases follow from the duality argument, Riesz-Thorin's theorem and Lemma 2.5. Taking a large constant M specified later, we write $m(H^{\lambda}) = (H^{\lambda} + 1)^{-M} \widetilde{m}(H^{\lambda})(H^{\lambda} + 1)^{-M}$, where $\widetilde{m}(t) = (t+1)^{2M}m(t)$. Since \widetilde{m} satisfies the condition in Lemma 2.5, $\widetilde{m}(H^{\lambda})$ is bounded on L^r uniformly in λ for any $1 < r < \infty$. Let r > p. It remains to show $(H^{\lambda} + 1)^{-M} \in \mathbb{B}(L^p, L^r) \cap \mathbb{B}(L^r, L^{\infty})$ with uniform bounds in λ . To this end, we use the well-known formula

$$(H^{\lambda} + 1)^{-M} = \frac{1}{\Gamma(M)} \int_0^\infty t^{M-1} e^{-t} e^{-tH^{\lambda}} dt$$

which, together with the following decay estimates of the semi-group

$$\|e^{-tH^{\lambda}}\|_{r_1 \to r_2} \lesssim t^{-\frac{n}{2}(\frac{1}{r_1} - \frac{1}{r_2})}, \quad t > 0, \quad 1 \le r_1 \le r_2 \le \infty, \ (r_1, r_2) \ne (1, 1), (\infty, \infty),$$

obtained from (2.15) and Lemma 2.5, shows that $(H^{\lambda} + 1)^{-M} \in \mathbb{B}(L^{p}, L^{r}) \cap \mathbb{B}(L^{r}, L^{\infty})$ with operator norms being independent of λ , provided that M > n + 1.

Remark 2.7. Let $V_{\pm} \geq 0$ be such that $V = V_{+} - V_{-}$. It was proved by [25] that if $V_{+} \in \mathcal{K}_{n}^{\text{loc}}$, $V_{-} \in \mathcal{K}_{n}$ and $m^{(k)}(t) = O(\langle t \rangle^{-\varepsilon - k})$ with some $\varepsilon > 0$ and all $k \geq 0$, then $m(H) \in \mathbb{B}(L^{p})$ for any $1 \leq p \leq \infty$. Here \mathcal{K}_{n} and $\mathcal{K}_{n}^{\text{loc}}$ are Kato and local Kato classes, respectively [37]. We do not know whether m(H) is bounded on L^{p} at p = 1 or ∞ under the condition $0 \leq V \in L_{\text{loc}}^{1}$ only, even if $m \in S(\mathbb{R})$. However, the above lemma is sufficient for the purpose of this paper.

Remark 2.8. In contrast to Sobolev's inequality $||f||_{2^*} \leq C ||\nabla f||_2$ which fails if n = 2, (2.16) with $(p,q) = (2,2^*)$ holds for all $n \geq 2$. This fact will play a crucial role in case of n = 2.

We next recall the square function estimates for the Littlewood-Paley decomposition associated with H. Consider a homogeneous dyadic partition of unity on $(0, \infty)$:

$$\sum_{j \in \mathbb{Z}} f(2^{-j}s) = 1, \quad s > 0,$$
(2.17)

where $f \in C_0^{\infty}(\mathbb{R})$, supp $f \subset [1/2, 2]$, f(s) = 1 for 3/4 < s < 3/2 and $0 \le f \le 1$.

Proposition 2.9. Suppose that $H = -\Delta + V$ has no eigenvalue and $1 < q < \infty$. Then

$$C_q^{-1} \|v\|_q \le \left\| \left(\sum_{j \in \mathbb{Z}} |f(2^{-j}H)v|^2 \right)^{1/2} \right\|_q \le C_q \|v\|_q.$$
(2.18)

with some $C_q > 1$. In particular, we have

$$\|v\|_{q} \le C_{q} \Big(\sum_{j \in \mathbb{Z}} \|f(2^{-j}H)v\|_{q}^{2} \Big)^{1/2} \quad if \quad 2 \le q < \infty,$$
(2.19)

$$\left(\sum_{j \in \mathbb{Z}} \|f(2^{-j}H)v\|_q^2\right)^{1/2} \le C_q \|v\|_q \quad if \quad 1 < q \le 2.$$
(2.20)

Proof. The proof follows essentially the same argument as that in [38, Section 0.2]. In order to prove (2.18) we consider the following square function associated with H:

$$Sv(x) = \left(\sum_{j \in \mathbb{Z}} |f(2^{-j}H)v(x)|^2\right)^{1/2}, \quad v \in \mathcal{S}(\mathbb{R}^n).$$

Let $u, v \in S(\mathbb{R}^n)$. Since H has no eigenvalue and hence $\mathbb{1}_{\{0\}}(H) = 0$, it follows from (2.17) that

$$\langle u, v \rangle = \sum_{j,k \in \mathbb{Z}} \langle f(2^{-j}H)u, f(2^{-k}H)v \rangle.$$

Moreover, the support property

$$f(2^{-j}s)f(2^{-k}s) = 0, \quad |j-k| > 2, \quad s > 0,$$
 (2.21)

implies that $f(2^{-j}H)$ satisfies the following almost orthogonality:

$$f(2^{-j}H)f(2^{-k}H) = 0, \quad |j-k| > 2.$$

Hence Hölder's inequality implies

$$|\langle u,v\rangle| \leq \sum_{|j-k|\leq 2} |\langle f(2^{-j}H)u, f(2^{-k}H)v\rangle| \lesssim \|Su\|_q \|Sv\|_{q'}.$$

By duality, it remains to show that S is bounded on L^q . To this end, we set

$$S_{\pm}v(x) = \left(\sum_{\pm j \ge 0} |f(2^{-j}H)v(x)|^2\right)^{1/2}$$

and may prove the L^q -boundedness of S_+ , the proof for S_- being analogous. Let $r_j(t)$, j = 0, 1, ..., be Rademacher functions on [0, 1] and consider the spectral multiplier $m_t(H)$, where

$$m_t(s) = \sum_{j=0}^{\infty} r_j(t) f(2^{-j}s).$$

Using (2.21), we see that for any k = 0, 1, 2, ... there exists C_k independent of $t \in [0, 1]$ such that

$$|\partial_s^k m_t(s)| \le C_k s^{-k}, \quad s > 0.$$

In particular, m_t satisfies the conditions in Lemma 2.5 and hence $||m_t(H)||_{q \to q} \leq 1$ uniformly in $t \in [0, 1]$ by Lemma 2.5 with $\lambda = 1$. Combining with Khintchine's inequality, we have

$$\|S_{+}v\|_{q} \lesssim \left\| \|m_{t}(H)v\|_{L^{q}([0,1]_{t})} \right\|_{L^{q}(\mathbb{R}^{n}_{x})} \lesssim \|m_{t}(H)v\|_{L^{q}([0,1]_{t};L^{q}(\mathbb{R}^{n}_{x}))} \lesssim \|v\|_{q}$$

This completes the proof of (2.18). (2.19) and (2.20) follow immediately from (2.18).

We conclude this subsection by observing that, by virtue of Proposition 2.9, Theorem 1.1 follows from the following energy localized version.

Theorem 2.10. Assume that $n \geq 2$ and V satisfies (H1)–(H3). Let (p,q) and (\tilde{p},\tilde{q}) satisfy (1.3). Then, for any $\varphi \in C_0^{\infty}(\mathbb{R})$ with $\operatorname{supp} \varphi \subseteq (0,\infty)$ one has, uniformly in $\lambda > 0$,

$$\|\varphi(\lambda^{-2}H)e^{-itH}u_0\|_{L^p(\mathbb{R};L^q(\mathbb{R}^n))} \lesssim \|u_0\|_{L^2(\mathbb{R}^n)},$$
(2.22)

$$\left\|\int_0^t \varphi(\lambda^{-2}H) e^{-i(t-s)H} F(s) ds\right\|_{L^p(\mathbb{R};L^q(\mathbb{R}^n))} \lesssim \|F\|_{L^{\tilde{p}'}(\mathbb{R};L^{\tilde{q}'}(\mathbb{R}^n))}.$$
(2.23)

Proof of Theorem 1.1, assuming Theorem 2.10. Let f be as that in Proposition 2.9 and $\varphi \in C_0^{\infty}((0,\infty))$ so that $\varphi \equiv 1$ on supp f. Consider the inhomogeneous estimate (1.6). We may assume without loss of generality that $n \geq 3$ and $(p,q) = (\tilde{p},\tilde{q}) = (2,2^*)$ since other cases follow from complex interpolation or the homogeneous estimates (1.5) and Christ-Kiselev's lemma [10]. Since $2_* < 2 < 2^*$, (2.19), (2.20) and (2.23) with $\lambda = 2^{j/2}$ imply

$$\begin{split} \left\| \int_{0}^{t} e^{-i(t-s)H} F(s) ds \right\|_{L^{2}_{t}L^{2*}_{x}}^{2} &\lesssim \sum_{j \in \mathbb{Z}} \left\| \int_{0}^{t} \varphi(2^{-j}H) e^{-i(t-s)H} f(2^{-j}H) F(s) ds \right\|_{L^{2}_{t}L^{2*}_{x}}^{2} \\ &\lesssim \sum_{j \in \mathbb{Z}} \left\| f(2^{-j}H) F \right\|_{L^{2}_{t}L^{2*}_{x}}^{2} \\ &\lesssim \left\| F \right\|_{L^{2}_{t}L^{2*}_{x}}^{2}. \end{split}$$

The homogeneous estimate (1.5) is verified similarly.

2.4 Functional calculus

Let $\varphi \in C_0^{\infty}(\mathbb{R})$ and $\chi \in C_0^{\infty}(\mathbb{R}^n)$ be such that $0 \leq \chi \leq 1$, $\chi(x) = 1$ for |x| < 1, $\chi(x) = 0$ for |x| > 2 and set $\chi_R(x) = \chi(x/R)$ with R > 0. This subsection is devoted to the construction of approximations of the operators $(1 - \chi_R(x))\varphi(H^{\lambda})$ and $(1 - \chi_R(x))\varphi(H_h)$ in terms of suitable PDOs. We begin with rough weighted bounds of $(H^{\lambda} - z)^{-1}$ and $\varphi(H^{\lambda})$.

Lemma 2.11. For any $\alpha \in \mathbb{R}$ there exists $C_{\alpha} > 0$ such that, for any $\lambda > 0$ and $z \in \mathbb{C} \setminus \mathbb{R}$,

$$\|\langle x \rangle^{\alpha} (H^{\lambda} - z)^{-1} \langle x \rangle^{-\alpha} \| \le C_{\alpha} \langle z \rangle^{|\alpha|/2} |\operatorname{Im} z|^{-|\alpha|-1}.$$
(2.24)

Moreover, $\langle x \rangle^{\alpha} \varphi(H^{\lambda}) \langle x \rangle^{-\alpha}$ is bounded on L^2 uniformly in $\lambda > 0$.

Proof. By Stein's complex interpolation [40], we may assume that $\alpha = N \in \mathbb{N} \cup \{0\}$ and prove (2.24) by induction in N. The case when N = 0 is trivial. Next, a direct calculation yields

$$\langle x \rangle^{N} (H^{\lambda} - z)^{-1} \langle x \rangle^{-N} = (H^{\lambda} - z)^{-1} + (H^{\lambda} - z)^{-1} [-\Delta, \langle x \rangle^{N}] (H^{\lambda} - z)^{-1} \langle x \rangle^{-N},$$

where the second term of the right hand side is written in the form

$$(H^{\lambda} - z)^{-1} \langle H^{\lambda} \rangle^{1/2} \cdot \langle H^{\lambda} \rangle^{-1/2} \langle D \rangle \cdot \langle D \rangle^{-1} [-\Delta, \langle x \rangle^{N}] \langle x \rangle^{-N+1} \cdot \langle x \rangle^{N-1} (H^{\lambda} - z)^{-1} \langle x \rangle^{-N} \langle x \rangle^{-N} \langle x \rangle^{N-1} (H^{\lambda} - z)^{-1} \langle x \rangle^{-N} \langle x \rangle^{-N} \langle x \rangle^{N-1} (H^{\lambda} - z)^{-1} \langle x \rangle^{-N} \langle x \rangle^{-N} \langle x \rangle^{N-1} (H^{\lambda} - z)^{-1} \langle x \rangle^{-N} \langle x \rangle^{-N} \langle x \rangle^{N-1} (H^{\lambda} - z)^{-1} \langle x \rangle^{-N} \langle x \rangle^{N-1} (H^{\lambda} - z)^{-1} \langle x \rangle^{-N} \langle x \rangle^{N-1} (H^{\lambda} - z)^{-1} \langle x \rangle^{-N} \langle x \rangle^{N-1} (H^{\lambda} - z)^{-1} \langle x \rangle^{-N} (H^{\lambda} - z)^{-1} \langle x \rangle^{-N} (H^{\lambda} - z)^{-1} \langle x \rangle^{-N} (H^{\lambda} - z)^{-1} (H^{\lambda} - z)^{-1} \langle x \rangle^{-N} (H^{\lambda} - z)^{-1} (H^{\lambda} - z)^{-N} (H^{\lambda} - z)^{-1} (H^{\lambda} - z)^{-1$$

By the spectral theorem, $||(H^{\lambda} - z)^{-1} \langle H^{\lambda} \rangle^{1/2}|| \leq C \langle z \rangle^{1/2} |\operatorname{Im} z|^{-1}$. Since $H^{\lambda} \geq -\Delta$, we also obtain $||\langle H^{\lambda} \rangle^{-1/2} \langle D \rangle|| \leq 1$. Moreover, since $\langle \xi \rangle^{-1} \{|\xi|^2, \langle x \rangle^N \} \langle x \rangle^{-N+1} \in S^{0,0}$, Calderón-Vaillancourt's theorem shows $\langle D \rangle^{-1} [-\Delta, \langle x \rangle^N] \langle x \rangle^{-N+1} \in \mathbb{B}(L^2)$, where $\{f, g\} = \nabla_x f \cdot \nabla_{\xi} g - \nabla_{\xi} f \cdot \nabla_x g$ is the Poisson bracket. Hence

$$\|(H^{\lambda}-z)^{-1}[-\Delta,\langle x\rangle^{N}](H^{\lambda}-z)^{-1}\langle x\rangle^{-N}\| \le C_{N}\langle z\rangle^{N/2}|\operatorname{Im} z|^{-N-1}$$

for all N by the hypothesis of induction. This completes the proof of (2.24). The assertion for $\langle x \rangle^N \varphi(H^\lambda) \langle x \rangle^{-N}$ is a consequence of (2.24) and Helffer-Sjöstrand's formula

$$\varphi(H^{\lambda}) = -\frac{1}{\pi} \int_{\mathbb{C}} \frac{\partial \Phi}{\partial \overline{z}}(z) (H^{\lambda} - z)^{-1} dL(z), \qquad (2.25)$$

where $\Phi(z)$ is an almost analytic extension of φ such that Φ is independent of λ , $\Phi|_{\mathbb{R}} = \varphi$, supp Φ is compact, and $|\partial_{\overline{z}} \Phi(z)| \leq C_N |\operatorname{Im} z|^N$ for any $N \geq 0$ (see [20, 21]).

Proposition 2.12. Let $N \in \mathbb{N} \cup \{0\}$ and R > 0. Then there exist a bounded set $\{a^{\lambda}\}_{\lambda > 0} \subset S^{0, -\infty}$ satisfying supp $a^{\lambda} \subset \text{supp}[(1 - \chi_R)\varphi \circ p^{\lambda}]$ and $Q^{\lambda} \in \mathbb{B}(L^2)$ such that

$$(1 - \chi_R)(x)\varphi(H^{\lambda}) = \operatorname{Op}(a^{\lambda})^* + Q^{\lambda}, \quad \sup_{\lambda > 0} \|\langle D \rangle^N \langle x \rangle^N Q^{\lambda} \langle x \rangle^N \| \le C_N < \infty,$$
(2.26)

where $p^{\lambda}(x,\xi) = |\xi|^2 + V^{\lambda}(x)$ is the symbol of H^{λ} .

Proof. The proof is based on a standard argument using Helffer-Sjöstrand's formula and a microlocal parametrix of the resolvent (see, e.g., [14] or [7, Proposition 2.1]). However, these previous literatures cannot be applied directly to the present case since V^{λ} may not uniformly bounded as $\lambda \to 0$, so we give a complete proof. We shall show that

$$\varphi(H^{\lambda})(1-\chi_R)(x) = \operatorname{Op}(a^{\lambda}) + \widetilde{Q}^{\lambda}, \quad ||\langle x \rangle^N Q^{\lambda} \langle x \rangle^N \langle D \rangle^N || \lesssim 1.$$

Taking $d_0 > 0$ with supp $\Phi \subset \{|z| \leq d_0\}$, we construct the parametrix of $(H^{\lambda} - z)^{-1}(1 - \chi_R)$ for $|z| \leq d_0$. By (2.3) and Remark 2.2, for any symbol q, the symbol of $(H^{\lambda} - z) \operatorname{Op}(q)$ is given by

$$(p^{\lambda}-z)\#q|_{h=1} = (p^{\lambda}-z)q - 2i\xi \cdot \nabla_x q - \Delta_x q.$$

With this expansion at hand, we define $q_k^{\lambda} = q_k^{\lambda}(z, x, \xi)$ inductively by

$$q_0^{\lambda} = \frac{1 - \chi_R}{p^{\lambda} - z}, \quad q_1^{\lambda} = \frac{2i\xi \cdot \nabla_x q_0^{\lambda}}{p^{\lambda} - z}, \quad q_k^{\lambda} = \frac{2i\xi \cdot \nabla_x q_{k-1}^{\lambda} + \Delta_x q_{k-2}^{\lambda}}{p^{\lambda} - z}, \quad k \ge 2.$$
(2.27)

We shall show that q_k^{λ} satisfy

$$\left|\partial_x^{\alpha}\partial_{\xi}^{\beta}q_k^{\lambda}(z,x,\xi)\right| \le C_{k\alpha\beta}\langle x\rangle^{-k-|\alpha|}\langle \xi\rangle^{-2-k-|\beta|} |\operatorname{Im} z|^{-1-2k-|\alpha|-|\beta|}, \quad x,\xi \in \mathbb{R}^n,$$
(2.28)

uniformly in $\lambda > 0$. To this end we observe from Lemma 2.3 that

$$V^{\lambda}(x) \ge C_1 \lambda^{-2+\mu} (\lambda + |x|)^{-\mu}, \quad |\partial_x^{\alpha} V^{\lambda}(x)| \le C_{\alpha} \langle x \rangle^{-|\alpha|} V^{\lambda}(x)$$
(2.29)

uniformly in $\lambda > 0$ and $|x| \ge R$. Also note that, by Leibniz's rule, $\partial_x^{\alpha} \partial_{\xi}^{\beta} q_0^{\lambda}$ is of the form

$$\partial_x^{\alpha} \partial_{\xi}^{\beta} q_0^{\lambda} = \sum_{j=0}^{|\alpha|} \sum_{\ell=0}^{|\beta|} \frac{d_{j\ell}^{\lambda}(x,\xi)}{(p^{\lambda}(x,\xi) - z)^{1+j+\ell}},\tag{2.30}$$

where $d_{j\ell}^{\lambda}$ is independent of z, a polynomial in ξ of degree at most ℓ , supported in supp $(1 - \chi_R)$ in the x-variable. Moreover, it follows from an induction argument in j that $d_{j\ell}^{\lambda}$ is of the form

$$d_{j\ell}^{\lambda}(x,\xi) = Q_{\ell}(\xi) \sum \partial_x^{\gamma} \left((1 - \chi_R(x)) \partial_x^{\alpha_1} V^{\lambda}(x) \cdots \partial_x^{\alpha_j} V^{\lambda}(x) \right)$$

where $|\gamma| = |\alpha| - j$, $|\alpha_1| = \cdots = |\alpha_j| = 1$, $Q_{\ell}(\xi)$ is a polynomial in ξ of degree at most ℓ and independent of x, z and λ . Therefore, we know by (2.30) and Leibniz's rule that

$$|d_{j\ell}^{\lambda}(x,\xi)| \le C_{j\alpha\ell} (V^{\lambda}(x))^{j} \langle x \rangle^{-|\alpha|} \langle \xi \rangle^{\ell}.$$
(2.31)

The proof of (2.28) is then divided into two cases $p^{\lambda} \leq 2d_0$. In case of $p^{\lambda} \leq 2d_0$, we have $V^{\lambda}(x) \leq p^{\lambda}(x,\xi) \leq 2d_0$ which, together with (2.29), yields that, for all $\gamma \in \mathbb{Z}^n_+$,

$$|\partial_x^{\gamma} V^{\lambda}(x)| \le C_{\gamma} \langle x \rangle^{-|\gamma|} \tag{2.32}$$

uniformly in $x \in \text{supp}(1-\chi)$ and $\lambda > 0$. Moreover, since V^{λ} is positive we have

$$|p^{\lambda} - z| \ge C |\operatorname{Im} z| \langle \xi \rangle^{2}.$$
(2.33)

(2.29)-(2.33) imply (2.28) for k = 0. On the other hand, if $p^{\lambda}(x,\xi) \ge 2d_0$ then we have

$$|p^{\lambda} - z| \ge p^{\lambda}/2 \gtrsim |\xi|^2 + V^{\lambda}(x) + 1$$

which, together with (2.29)–(2.31), implies (2.28) for k = 0. (2.28) for $k \ge 1$ follows from an induction argument in k. Moreover, we learn from (2.27) and (2.30) that q_k^{λ} is of the finite sum

$$q_k^{\lambda} = \sum_{j=k}^{2k+1} \frac{\tilde{d}_{kj}^{\lambda}(x,\xi)}{(p^{\lambda}(x,\xi) - z)^{j+1}}$$

where \tilde{d}_{kj}^{λ} are independent of z, polynomials in ξ of degree less than j. Moreover, \tilde{d}_{kj}^{λ} are supported in supp $(1-\chi)$ in the x-variable for all ξ and satisfies

$$|\partial_x^{\alpha} \partial_{\xi}^{\beta} \tilde{d}_{kj}^{\lambda}(x,\xi)| \le C_{\alpha\beta} (V^{\lambda}(x))^j \langle x \rangle^{-j-|\alpha|} \langle \xi \rangle^{j-|\beta|}.$$
(2.34)

By the construction of q_k^{λ} and Proposition 2.1, we obtain

$$(H^{\lambda} - z)^{-1}(1 - \chi_R)(x) = \sum_{k=0}^{N-1} \operatorname{Op}(q_k^{\lambda}) + (H^{\lambda} - z)^{-1} \operatorname{Op}(r_N^{\lambda}),$$

where $r_N^{\lambda} := \Delta_x q_{N-2}^{\lambda} + 2i\xi \cdot \nabla_x q_{N-1}^{\lambda} + \Delta q_{N-1}^{\lambda}$. By (2.28), $\{r_N^{\lambda}\}_{\lambda>0}$ is a bounded set in $S^{-N,-N-2}$. Plugging this formula into (2.25) and applying Cauchy-Pompeiu's formula give us the formula

$$\varphi(H^{\lambda})(1-\chi_R)(x) = \operatorname{Op}(a^{\lambda}) + \widetilde{Q}^{\lambda},$$

where $a^{\lambda} = b_0^{\lambda} + \dots + b_{N-1}^{\lambda}$ and \widetilde{Q}^{λ} are given by

$$b_0^{\lambda}(x,\xi) = (1-\chi_R)(x)(\varphi \circ p^{\lambda})(x,\xi),$$

$$b_k^{\lambda}(x,\xi) = \sum_{j=k}^{2k+1} \frac{(-1)^j}{j!} \tilde{d}_{kj}^{\lambda}(x,\xi)(\varphi^{(j)} \circ p^{\lambda})(x,\xi), \quad 1 \le k \le N-1,$$

$$\widetilde{Q}^{\lambda} = -\frac{1}{\pi} \int_{\mathbb{C}} \frac{\partial \Phi}{\partial \bar{z}}(z) (H^{\lambda} - z)^{-1} \operatorname{Op}(r_N^{\lambda}) dL(z).$$

Note that Φ is an almost analytic extension of φ given in (2.25). It is easy to see that $\operatorname{supp} a^{\lambda} \subset \operatorname{supp}(1-\chi) \cap \operatorname{supp}(\varphi \circ p^{\lambda})$. In particular, $p^{\lambda} \leq 2d_0$ on $\operatorname{supp} a^{\lambda}$ and, thus, the same argument as above implies that $\partial_x^{\alpha} V^{\lambda} = O(\langle x \rangle^{-|\alpha|})$ uniformly in $\lambda > 0$ on $\operatorname{supp} a^{\lambda}$. This bound and (2.34) show that $\{a^{\lambda}\}_{\lambda>0}$ is bounded in $S^{0,-\infty}$. Finally, (2.28) implies

$$\sup_{\lambda>0} \|\langle x \rangle^{N/2} \operatorname{Op}(r_N^{\lambda}) \langle x \rangle^{N/2} \langle D \rangle^{N/2} \| \le C_N |\operatorname{Im} z|^{-n(N)}$$

with some n(N) depending only on N, which, combined with Lemma 2.11, implies

$$\begin{split} \sup_{\lambda>0} \|\langle x \rangle^{N/2} \widetilde{Q}^{\lambda} \langle x \rangle^{N/2} \langle D \rangle^{N/2} \| \\ &\leq C_N \int_{\mathbb{C}} \left| \frac{\partial \Phi}{\partial \overline{z}}(z) \right| \sup_{\lambda>0} \|\langle x \rangle^{N/2} (H^{\lambda} - z)^{-1} \langle x \rangle^{-N/2} \| \sup_{\lambda>0} \|\langle x \rangle^{N/2} \operatorname{Op}(r_N^{\lambda}) \langle x \rangle^{N/2} \langle D \rangle^{N/2} \| |dL(z)| \\ &\leq C_{N,M} \int_{\operatorname{supp} \Phi} \langle z \rangle^{N/4} |\operatorname{Im} z|^{M-N/2-1-n(N)} |dL(z)| < \infty. \end{split}$$

provided $M \ge N/2 + 1 + n(N)$. Replacing N by 2N, we complete the proof.

The following analogous results for $\varphi(H_h)$ will also be needed later.

Proposition 2.13. Let $\alpha \in \mathbb{R}$, $N \in \mathbb{N} \cup \{0\}$ and $h = \lambda^{2/\mu-1}$. Then $\langle x \rangle^{\alpha} \varphi(H_h) \langle x \rangle^{-\alpha}$ is bounded on L^2 uniformly in $\lambda \in (0, 1]$. Moreover, for any R > 0, there exists $b_h \in S^{0, -\infty}$ supported in $\operatorname{supp}[(1 - \chi_R)\varphi \circ p_h]$, where $p_h(x, \xi) = |\xi|^2 + V_h$, such that

$$(1-\chi_R)(x)\varphi(H_h) = \operatorname{Op}_h(b_h)^* + Q_h, \quad \sup_{h \in (0,1]} (h^{-N} \| \langle hD \rangle^N \langle x \rangle^N Q_h \langle x \rangle^N \|) \le C_N.$$

Proof. The proof is similar to that for $\varphi(H^{\lambda})$. Indeed, since $\langle hD \rangle^{-1} [h^2 \Delta, \langle x \rangle^N] \langle x \rangle^{-N+1} = O_{L^2}(1)$, the uniform L^2 -boundedness of $\langle x \rangle^{\alpha} \varphi(H_h) \langle x \rangle^{-\alpha}$ in $h \in (0, 1]$ can be verified analogously. On the other hand, since the semiclassical symbol of $(H_h - z) \operatorname{Op}_h(q)$ has the expansion

$$(p_h - z) # q = (p_h - z)q - 2ih\xi \cdot \nabla_x q - h^2 \Delta_x q,$$

if we define q_k^{λ} by the same manner as in (2.27) with p^{λ} replaced by p_h , then, thanks to Lemma 2.3, q_k^{λ} satisfies the same estimate (2.28) and we have

$$(H_h - z)^{-1}(1 - \chi_R)(x) = \sum_{k=0}^{N-1} h^k \operatorname{Op}_h(q_k^\lambda) + h^N (H_h - z)^{-1} \operatorname{Op}(r_N^\lambda)$$

with $r_N^{\lambda} = \Delta_x q_{N-2}^{\lambda} + 2i\xi \cdot \nabla_x q_{N-1}^{\lambda} + h\Delta q_{N-1}^{\lambda} \in S^{-N,-N-2}$. The rest of the proof is completely analogous to that of Proposition 2.12 and we omit it.

Remark 2.14. Under the hypothesis (H1) and (H2), it follows by essentially the same proof as that of Proposition 2.12 that, for each $N \in \mathbb{N}$, $\varphi(H)$ can be decomposed as a sum of $\operatorname{Op}(a_N)$ with some $a_N \in S^{0,-\infty}$ and an error term Q_N satisfying $\langle D \rangle^N \langle x \rangle^N Q_N \langle x \rangle^N \in \mathbb{B}(L^2)$. This remark will be used in the proof of Proposition 2.17 below.

2.5 Weighted space-time and local decay estimates

Here we collect several results on wighted space-time and local decay estimates, which will play a crucial role in the proof of Theorem 2.10.

Proposition 2.15. We have

$$\|\langle x \rangle^{-1} e^{-itH} u_0 \|_{L^2(\mathbb{R}^{1+n})} \lesssim \|u_0\|_{L^2(\mathbb{R}^n)}, \tag{2.35}$$

$$\left\| \langle x \rangle^{-1} \int_0^t e^{-i(t-s)H} \langle x \rangle^{-1} F(s) ds \right\|_{L^2(\mathbb{R}^{1+n})} \lesssim \|F\|_{L^2(\mathbb{R}^{1+n})}.$$
 (2.36)

Proof. By Kato's smooth perturbation theory [26, Theorem 5.1] (see also [11]), (2.35) and (2.36) are consequences of the following uniform resolvent estimate

$$\sup_{z \in \mathbb{C} \setminus \mathbb{R}} \| \langle x \rangle^{-1} (H - z)^{-1} \langle x \rangle^{-1} \| < \infty$$

which was proved by Nakamura [32, Theorem 1.8].

Remark 2.16. It was actually proved in [32] that $\langle x \rangle^{-\rho} (H-z)^{-1} \langle x \rangle^{-\rho}$ is bounded on L^2 uniformly in $z \in \mathbb{C} \setminus \mathbb{R}$ if $\rho > 1/2 + \mu/4$, which implies (2.35) with $\langle x \rangle^{-1}$ replaced by $\langle x \rangle^{-\rho}$. However, Proposition 2.15 is sufficient for our purpose.

In the proof of Theorem 2.10, the energy localized version of Proposition 2.15 will be also required. The following proposition concerns with low energy estimates.

Proposition 2.17. Let $\varphi \in C_0^{\infty}((0,\infty))$. Then we have

$$\|\langle x \rangle^{-1} \varphi(H_h) e^{-itH_h/h} u_0 \|_{L^2(\mathbb{R}^{1+n})} \lesssim \|u_0\|_{L^2(\mathbb{R}^n)}, \qquad (2.37)$$

$$\left\| \langle x \rangle^{-1} \varphi(H_h) \int_0^t e^{-i(t-s)H_h/h} \langle x \rangle^{-1} F(s) ds \right\|_{L^2(\mathbb{R}^{1+n})} \lesssim \|F\|_{L^2(\mathbb{R}^{1+n})}$$
(2.38)

uniformly in $h = \lambda^{1/2-\mu} \in (0,1]$. Moreover, for any s > s' > 0 and $\varepsilon > 0$,

$$\|\langle x \rangle^{-s} e^{-itH_h/h} \varphi(H_h) \langle x \rangle^{-s} \| \lesssim h^{-\varepsilon} \langle t \rangle^{-s'}, \quad t \in \mathbb{R}, \quad \lambda \in (0, 1].$$
(2.39)

Proof. We may replace φ by φ^2 . It suffices to show that, for any $N \in \mathbb{N}$ and $\gamma > N - 1/2$,

$$\sup_{z \in \mathbb{C} \setminus \mathbb{R}} \| \langle x \rangle^{-\gamma} \varphi(H_h) (H_h - z)^{-N} \varphi(H_h) \langle x \rangle^{-\gamma} \| \lesssim h^{-N}$$
(2.40)

holds uniformly in $h \in (0, 1]$. Indeed, as before, (2.37) and (2.38) follow from (2.40) with N = 1. (2.39) is a consequence of (2.40) and an abstract method by Jensen-Mourre-Perry [24] (see also [31, Theorem 2] for its semiclassical version). A sketch of the proof of the bound (2.40) can be found in [32, Lemma 2.1]. We give its details in Appendix A for the sake of completeness.

In the high energy regime $\lambda \geq 1$, we also have the following similar bounds.

Proposition 2.18. For any $\varphi \in C_0^{\infty}((0,\infty))$ one has

$$\|\langle x \rangle^{-1} \varphi(H^{\lambda}) e^{-itH^{\lambda}} u_0\|_{L^2(\mathbb{R}^{1+n})} \lesssim \|u_0\|_{L^2(\mathbb{R}^n)}, \qquad (2.41)$$

$$\left\| \langle x \rangle^{-1} \varphi(H^{\lambda}) \int_0^t e^{-i(t-s)H^{\lambda}} \langle x \rangle^{-1} F(s) ds \right\|_{L^2(\mathbb{R}^{1+n})} \lesssim \|F\|_{L^2(\mathbb{R}^{1+n})}$$
(2.42)

uniformly in $\lambda \geq 1$. Moreover, for all s > s' > 0, one has

$$\|\langle x \rangle^{-s} \varphi(H^{\lambda}) e^{-itH^{\lambda}} \langle x \rangle^{-s} \| \lesssim \langle t \rangle^{-s'}, \quad \lambda \ge 1, \quad t \in \mathbb{R}.$$
 (2.43)

Proof. As for the previous proposition, the results follow from the uniform bound

$$\sup_{\lambda \ge 1} \sup_{z \in \mathbb{C} \setminus \mathbb{R}} \| \langle x \rangle^{-\gamma} \varphi(H^{\lambda}) (H^{\lambda} - z)^{-N} \varphi(H^{\lambda}) \langle x \rangle^{-\gamma} \| < \infty$$
(2.44)

which can be proved by the same argument as that of (2.40). We thus omit it.

3 Homogeneous estimates

In this section we prove (2.22), completing the proof of (1.5). Let φ and χ_R be as in the beginning of Subsection 2.4 and $\tilde{\varphi} \in C_0^{\infty}((0,\infty))$ with $\tilde{\varphi} \equiv 1$ on $\operatorname{supp} \varphi$. Let $\varphi^{\lambda}(H) = \varphi(\lambda^{-2}H)$, $\tilde{\varphi}^{\lambda}(H) = \tilde{\varphi}(\lambda^{-2}H)$, $\chi^{\lambda}(x) = \chi_R(\lambda x)$ and

$$A^{\lambda} := \mathcal{D}\operatorname{Op}(a^{\lambda})^{*}\mathcal{D}^{*}, \quad R^{\lambda} := \mathcal{D}Q^{\lambda}\mathcal{D}^{*} + \chi^{\lambda}\widetilde{\varphi}^{\lambda}(H),$$
(3.1)

Proposition 2.12 then yields that

$$\varphi^{\lambda}(H) = \widetilde{\varphi}^{\lambda}(H)\widetilde{\varphi}^{\lambda}(H)\varphi^{\lambda}(H) = \widetilde{\varphi}^{\lambda}(H)A^{\lambda}\varphi^{\lambda}(H) + \widetilde{\varphi}^{\lambda}(H)R^{\lambda}\varphi^{\lambda}(H).$$
(3.2)

The following proposition provides desired Strichartz estimates for the remainder term.

Proposition 3.1. We have, uniform in $\lambda > 0$,

$$\|\widetilde{\varphi}^{\lambda}(H)R^{\lambda}\varphi^{\lambda}(H)e^{-itH}u_{0}\|_{L^{2}(\mathbb{R};L^{2^{*}}(\mathbb{R}^{n}))} \lesssim \|u_{0}\|_{L^{2}(\mathbb{R}^{n})}.$$
(3.3)

Remark 3.2. Note that (3.3) holds for all $n \ge 2$. Interpolating between (3.3) and the trivial $L_x^2 - L_t^{\infty} L_x^2$ estimate also implies (3.3) with $(2, 2^*)$ replaced by any admissible pair (p, q).

Proof. Since $\|\widetilde{\varphi}^{\lambda}(H)\|_{2\to 2^*} \lesssim \lambda$ by Lemma 2.6, it suffices to show the following uniform bound

$$\lambda \| R^{\lambda} \varphi^{\lambda}(H) e^{-itH} u_0 \|_{L^2_t L^2_x} \lesssim \| u_0 \|_{L^2}, \quad \lambda > 0.$$
(3.4)

When $0 < \lambda \leq 1$, the support property of χ implies $\lambda \chi^{\lambda}(x) \lesssim \langle x \rangle^{-1}$. Proposition 2.12, the formula $\langle x \rangle^{-1} \mathcal{D}^* = \mathcal{D}^* \langle \lambda x \rangle^{-1}$ and the unitarity of \mathcal{D} also imply

$$\lambda \| \mathcal{D}Q^{\lambda} \mathcal{D}^* f \|_2 \lesssim \lambda \| \langle \lambda x \rangle^{-1} f \|_2 \lesssim \| \langle x \rangle^{-1} f \|_2.$$

These two bounds and Proposition 2.15 gives us (3.4) for $\lambda \leq 1$. When $\lambda \geq 1$, we use (2.5)–(2.8), the change of variable $s = t\lambda^2$ and Proposition 2.18 to obtain

$$\begin{split} \lambda \| R^{\lambda} \varphi^{\lambda}(H) e^{-itH} u_0 \|_{L^2_t L^2_x} &= \lambda \Big\| \Big(Q^{\lambda} + \chi(x) \widetilde{\varphi}(H^{\lambda}) \Big) \varphi(H^{\lambda}) e^{-it\lambda^2 H^{\lambda}} \mathfrak{D}^* u_0 \Big\|_{L^2_t L^2_x} \\ &\lesssim \| \langle x \rangle^{-1} \varphi(H^{\lambda}) e^{-isH^{\lambda}} \mathfrak{D}^* u_0 \|_{L^2_t L^2_x} \\ &\lesssim \| u_0 \|_{L^2} \end{split}$$

which completes the proof.

By virtue of this proposition and Lemma 2.6, it remains to show that the estimate

$$\|A^{\lambda}\varphi^{\lambda}(H)e^{-itH}u_0\|_{L^p_t L^q_x} \lesssim \|u_0\|_{L^2}$$

$$(3.5)$$

holds uniformly in $\lambda > 0$. The proof of (3.5) is divided into the high energy $\lambda \ge 1$ and the low energy $0 < \lambda \le 1$ cases. In the high energy regime, using (2.6) we have the equality

$$A^{\lambda}\varphi^{\lambda}(H)e^{-itH} = \mathcal{D}\operatorname{Op}(a^{\lambda})^{*}\varphi(H^{\lambda})e^{-it\lambda^{2}H^{\lambda}}\mathcal{D}^{*}$$

which, together with (2.5), implies that (3.5) with $\lambda \geq 1$ is equivalent to the estimate

$$\|\operatorname{Op}(a^{\lambda})^*\varphi(H^{\lambda})e^{-itH^{\lambda}}u_0\|_{L^p_tL^q_x} \lesssim \|u_0\|_{L^2}, \quad \lambda \ge 1.$$
(3.6)

On the other hand, when $\lambda \leq 1$, we use $\mathcal{D}_{\mu} = \mathcal{D}(\lambda^{2/\mu})$ to write

$$A^{\lambda}\varphi^{\lambda}(H)e^{-itH} = \mathcal{D}_{\mu}\operatorname{Op}_{h}(a_{h})^{*}\varphi(H_{h})e^{-it\lambda^{2}H_{h}}\mathcal{D}_{\mu}^{*},$$

where $a_h(x,\xi) = a^{\lambda}(h^{-1}x,\xi)$. By (2.5), (3.5) with $0 < \lambda \leq 1$ then is equivalent to

$$\|\operatorname{Op}_{h}(a_{h})^{*}\varphi(H_{h})e^{-itH_{h}/h}u_{0}\|_{L^{p}_{t}L^{q}_{x}} \lesssim h^{-1/p}\|u_{0}\|_{L^{2}}, \quad h = \lambda^{2/\mu-1} \in (0,1].$$
(3.7)

The proof of the high energy estimate (3.6) is simpler than that of the low energy estimate (3.7). Therefore, we first give the proof of (3.7) in detail and, then, explain necessary modifications for the high energy estimate (3.6).

3.1 The low energy case

We begin with observing that a_h belongs to $S^{0,-\infty}$ and satisfies the support property

$$\operatorname{supp} a_h \subset \{ (x,\xi) \in \mathbb{R}^{2n} \mid |x| > c_0, \ |\xi| < c_1 \}$$
(3.8)

with some $c_0, c_1 > 0$ being independent of $h \in (0, 1]$. Indeed, since $V^{\lambda}(h^{-1}x) = V_h(x)$, a_h is supported in supp $[(1 - \chi_R)(h^{-1} \cdot)\varphi \circ p_h]$ and hence

supp
$$a_h \subset \{(x,\xi) \in \mathbb{R}^{2n} \mid |x| \ge \lambda^{2/\mu - 1} R, \ d^{-1} < |\xi|^2 + V_h(x) < d\}$$

with some d > 0. This, together with Lemma 2.3, yields that $C_1(\lambda^{2/\mu} + |x|)^{-\mu} < d$ and hence

$$|x| \ge \max\{(C_1/d)^{1/\mu} - \lambda^{2/\mu}, \lambda^{2/\mu-1}R\} \ge (C_1/d)^{1/\mu}/2$$

provided $R \geq 1$. Since $\{a^{\lambda}\}_{\lambda>0}$ is bounded in $S^{0,-\infty}$, this support property of a_h implies

$$|\partial_x^{\alpha}\partial_{\xi}^{\beta}a_h(x,\xi)| \le C_{\alpha\beta N}h^{-|\alpha|}\langle h^{-1}x\rangle^{-|\alpha|}\langle \xi\rangle^{-N-|\beta|} \le C_{\alpha\beta N}\langle x\rangle^{-|\alpha|}\langle \xi\rangle^{-N-|\beta|}$$

for any $N \ge 0$. This shows $a_h \in S^{0,-\infty}$. Note that c_0 in (3.8) is not necessarily large and, thus, (3.8) is not enough to construct a long-time parametrix of $\operatorname{Op}_h(a_h)^* \varphi(H_h) e^{-itH_h/h}$. Therefore, we further decompose a_h into compact and non-compact parts as follows:

$$a_h = a_h^{\text{com}} + a_h^{\infty}, \quad a_h^{\text{com}} = \chi_R(x)a_h, \quad a_h^{\infty} = (1 - \chi_R)(x)a_h$$

with $\chi_R(x) = \chi(x/R)$ and $\chi \in C_0^{\infty}(\mathbb{R}^n)$ satisfying $\chi \equiv 1$ near the origin. The following proposition provides desired Strichartz estimates for the compact part.

Proposition 3.3. Let $c_1 > c_0 > 0$ and $b_h \in S^{0,-\infty}$ be supported in $\{c_0 < |x| < c_1, |\xi| \le c_1\}$. Then for any admissible pair (p,q) one has

$$\|\operatorname{Op}_{h}(b_{h})^{*}e^{-itH_{h}/h}u_{0}\|_{L^{p}(\mathbb{R};L^{q}(\mathbb{R}^{n}))} \lesssim h^{-1/p}\|u_{0}\|_{L^{2}(\mathbb{R}^{n})}, \quad h \in (0,1].$$

Remark 3.4. a_h^{com} satisfies the condition on b_h in this proposition.

The following is a key ingredient in the proof of this proposition.

Lemma 3.5. Let b_h be as in Proposition 3.3 and $\tilde{b} \in S^{0,-\infty}$ such that $\tilde{b} \equiv 1$ on $\operatorname{supp} b_h$ and $\operatorname{supp} \tilde{b} \subset \{c_0/2 < |x| < 2c_1, |\xi| \le 2c_1\}$. Then there exists $\varepsilon_0 > 0$ such that, for any interval I with $|I| \le 2\varepsilon_0$ and admissible pair (p,q),

$$\|\operatorname{Op}_{h}(\widetilde{b})^{*}e^{-itH_{h}/h}f\|_{L^{p}(I;L^{q}(\mathbb{R}^{n}))} \lesssim h^{-1/p}\|f\|_{L^{2}(\mathbb{R}^{n})}, \quad h \in (0,1].$$
(3.9)

Proof. By the standard TT^* -argument in [27], it suffices to show the following dispersive estimate

$$\|\operatorname{Op}_{h}(\widetilde{b})^{*}e^{-itH_{h}/h}\operatorname{Op}_{h}(\widetilde{b})\|_{1\to\infty} \lesssim |th|^{-n/2}, \quad 0 < |t| \le 2\varepsilon_{0},$$
(3.10)

whose proof is based on a semiclassical parametrix of $e^{-itH_h/h} \operatorname{Op}_h(\widetilde{b})$ and the stationary phase method. Since such a parametrix construction is well known (see [34]), we only outline it.

Note that, since $|x| > c_0$ on $\operatorname{supp} \widetilde{b}$, V_h satisfies $\partial_x^{\alpha} V_h(x) = O(\langle x \rangle^{-\mu - |\alpha|})$ on $\operatorname{supp} \widetilde{b}$ uniformly in $h \in (0, 1]$. Using this fact, for all $N \in \mathbb{N}$ and sufficiently small $\varepsilon_0 > 0$, one can construct smooth functions $\Psi_h, d_h \in C^{\infty}((-3\varepsilon_0, 3\varepsilon_0) \times \mathbb{R}^{2n})$ satisfying the following properties: First, Ψ_h satisfies the Hamilton-Jacobi equation

$$\partial_t \Psi_h + p_h(x, \nabla_x \Psi_h) = 0; \quad \Psi_h|_{t=0} = x \cdot \xi,$$

on a small neighborhood of supp b. Second, $\{d_h(t)\}_{|t|\leq 3\varepsilon_0}$ is bounded in $S^{-\infty,-\infty}$. Moreover, d_h approximately solves the following transport equation in such a way that

$$\partial_t d_h + \mathfrak{X}_h \cdot \nabla_x d_h + \mathfrak{Y}_h d_h = h^N r_h; \quad d_h|_{t=0} = \widetilde{b}$$
(3.11)

with some bounded set $\{r_h(t)\}_{|t|\leq 3\varepsilon_0} \subset S^{-\infty,-\infty}$, where $\mathfrak{X}_h = 2\nabla_x \Psi_h$ and $\mathfrak{Y}_h = \Delta_x \Psi_h$. Finally, for all $(t, x, \xi) \in (-3\varepsilon_0, 3\varepsilon_0) \times \mathbb{R}^{2n}$, Ψ_h satisfies

$$\left|\partial_x^{\alpha}\partial_x^{\beta}\Psi_h(t,x,\xi)\right| \le C_{\alpha\beta}, \quad |\alpha| + |\beta| \ge 2, \tag{3.12}$$

$$|\nabla_x \otimes \nabla_\xi \Psi_h(t, x, \xi) - \mathrm{Id}| \le C|t|, \tag{3.13}$$

$$|\nabla_{\xi}^{2}\Psi_{h}(t,x,\xi) - 2t \operatorname{Id}| \le C|t|^{2}.$$
 (3.14)

To Ψ_h and $a \in S^{0,-\infty}$, we associate with a semiclassical Fourier integral operator (h-FIO)

$$J_{\Psi_h(t)}(a)f(x) = (2\pi h)^{-n} \iint e^{i(\Psi_h(t,x,\xi) - y \cdot \xi)/h} a(x,\xi)f(y) dy d\xi.$$

If we compute $\int_0^t \frac{d}{ds} e^{isH_h/h} J_{\Psi_h(s)}(d_h(s)) ds$, then by virtue of (3.11), we have Duhamel's formula

$$e^{-itH_h/h}\operatorname{Op}_h(\widetilde{b}) = J_{\Psi_h(t)}(d_h(t)) + ih^{N-1} \int_0^t e^{-i(t-s)H_h/h} J_{\Psi_h(s)}(r_h(s)) ds.$$
(3.15)

With (3.12) and (3.13) at hand, we learn from a standard theory of h-FIO (see [35]) that

$$\|J_{\Psi_h(t)}(d_h(t))\| \lesssim 1, \quad \|J_{\Psi_h(t)}(r_h(t))\|_{\mathbb{B}(\mathcal{H}^{-s},\mathcal{H}^s)} \lesssim h^{-2s}$$
 (3.16)

for all $s \in \mathbb{R}$, uniformly in $|t| \leq 2\varepsilon_0$ and $h \in (0,1]$. Moreover, (3.14) and the stationary phase method yield the following decay estimate

$$\|J_{\Psi_h(t)}(d_h(t))\|_{1\to\infty} \lesssim \min\{h^{-n}, |th|^{-n/2}\}, \quad |t| \le 2\varepsilon_0, \ h \in (0,1].$$
(3.17)

(3.10) follows from (3.15)–(3.17), (2.2) and Sobolev's embedding.

To prove Proposition 3.3, one more technical lemma will be needed.

Lemma 3.6. For any $N \in \mathbb{N}$ there exist $c_h, r_{1,h}, r_{2,h} \in S^{-\infty, -\infty}$ such that

$$Op_h(b_h)^* = Op_h(b)^* Op_h(b_h)^* + h^N Op_h(r_{1,h}),$$
(3.18)

$$[\operatorname{Op}_{h}(b_{h})^{*}, H_{h}] = h \operatorname{Op}_{h}(c_{h}) + h^{N} \operatorname{Op}_{h}(r_{3,h})(1+V_{h}).$$
(3.19)

Proof. (3.18) follows from Proposition 2.1 since $b_h \tilde{b} \equiv b_h$. To show (3.19), we first observe from Proposition 2.1 and (3.18) that there exist $c'_h \in S^{-\infty,-\infty}$ and $r'_h \in S^{-\infty,\infty}$ such that

$$[\operatorname{Op}_h(b_h)^*, -h^2\Delta] = h\operatorname{Op}(c_h') + h^N\operatorname{Op}_h(r_h').$$

To deal with $[Op_h(b_h)^*, V_h]$, we take $\chi \in C_0^{\infty}(\mathbb{R}^n)$ satisfying $\chi \equiv 1$ on $\operatorname{supp} b_h$ and $\operatorname{supp} \chi \Subset \pi_x(\operatorname{supp} \widetilde{b})$, where π_x is the projection onto the x-space. Then we obtain by Proposition 2.1 that

$$\operatorname{Op}_h(b_h)^* = \operatorname{Op}_h(b_h)^* \chi = \chi \operatorname{Op}_h(b_h)^* \chi + h^N \operatorname{Op}_h(r_h''), \quad r_h'' \in S^{-\infty, -\infty},$$

and hence $[\operatorname{Op}_h(b_h)^*, V_h] = [\operatorname{Op}_h(b_h)^*, \chi V_h] + h^N \operatorname{Op}_h(r_h'')V_h$. Since $|\partial_x^{\alpha}(\chi V_h)| = O(\langle x \rangle^{-\mu - |\alpha|})$ uniformly in h (note that $\operatorname{supp} \chi V_h \subset \{|x| > c_0/2\}$), the symbol of $[\operatorname{Op}_h(b_h)^*, \chi V_h]$ belongs to $hS^{-\infty, -\infty}$ and, thus, (3.19) follows. Proof of Proposition 3.3. The proof is based on a similar argument as that in [39, 5]. Let $u_h = \varphi(H_h)e^{-itH_h/h}u_0$ and $N \gg 1$ be large enough (specified later). It follows from (3.18) that

$$\operatorname{Op}_{h}(b_{h})^{*} = \operatorname{Op}_{h}(b)^{*} \operatorname{Op}_{h}(b_{h})^{*} + h^{N} \operatorname{Op}_{h}(r_{h})^{*}$$

with some $r_h \in S^{-\infty, -\infty}$. By (2.2) and (2.37), the remainder $h^N \operatorname{Op}_h(r_h)^* u_h$ satisfies

$$\|h^{N}\operatorname{Op}_{h}(r_{h})^{*}u_{h}\|_{L^{2}_{t}L^{2*}_{x}} \lesssim h^{N-1}\|\langle x\rangle^{-1}u_{h}\|_{L^{2}_{t}L^{2}_{x}} \lesssim h^{N-3/2}\|u_{0}\|_{L^{2}} \lesssim \|u_{0}\|_{L^{2}}$$
(3.20)

if $N \geq 3/2$. To deal with the main term we consider a decomposition of the time interval

$$\mathbb{R} = \bigcup_{j \in \mathbb{Z}} I_j, \quad I_j = [(j - 1/2)\varepsilon_0, (j + 1/2)\varepsilon_0], \tag{3.21}$$

and choose intervals \widetilde{I}_j centered at $j\varepsilon_0$ satisfying $I_j \in \widetilde{I}_j$, $|\widetilde{I}_j| \leq 3\varepsilon_0/2$. Let $\theta_j \in C_0^{\infty}(\mathbb{R})$ be such that $\theta_j \equiv 1$ on I_j , $I_j \in \operatorname{supp} \theta_j \in \widetilde{I}_j$. Set $v_j(t) = \theta_j(t) \operatorname{Op}_h(b_h)^* u_h$. Then

$$\left\|\operatorname{Op}_{h}(\widetilde{b})^{*}\operatorname{Op}_{h}(b_{h})^{*}u_{h}\right\|_{L^{p}_{t}L^{q}_{x}}^{p} \leq \sum_{j \in \mathbb{Z}}\left\|\operatorname{Op}_{h}(\widetilde{b})^{*}v_{j}\right\|_{L^{p}(\widetilde{I}_{j};L^{q})}^{p}$$

by the almost orthogonality of θ_j . Now we claim that v_j satisfies

$$\|\operatorname{Op}_{h}(\widetilde{b})^{*}v_{j}\|_{L^{p}(\widetilde{I}_{j};L^{q})} \lesssim \begin{cases} h^{-1/p} \|u_{0}\|_{L^{2}}, \quad j = 0, \\ h^{-1/p} \|\langle x \rangle^{-1} u_{h}\|_{L^{2}(\widetilde{I}_{j};L^{2})}, \quad j \neq 0. \end{cases}$$
(3.22)

Since $p \ge 2$, this claim, together with (2.37) and Minkowski's inequality, implies

$$\sum_{j \in \mathbb{Z}} \|\operatorname{Op}_{h}(\widetilde{b})^{*} v_{j}\|_{L^{p}(\widetilde{I}_{j};L^{q})}^{p} \lesssim h^{-1}(\|u_{0}\|_{L^{2}}^{p} + \|\langle x \rangle^{-1} e^{-itH_{h}/h} u_{0}\|_{L^{2}_{t}L^{2}_{x}}^{p}) \lesssim h^{-1} \|u_{0}\|_{L^{2}}^{p}$$

which, combined with (3.20), shows (3.9). It thus remains to show (3.22). The case j = 0 follows directly from (3.9). For $j \neq 0$ we observe that v_j satisfies

$$(ih\partial_t - H_h)v_j = -ih\theta'_j(t)\operatorname{Op}_h(b_h)^* u_h(t) + \theta_j(t)[H_h, \operatorname{Op}_h(b_h)^*]u_h(t); \quad v_j|_{t=0} = 0,$$

which leads to Duhamel's formula for $\operatorname{Op}_h(\widetilde{b})^* v_j$:

$$\operatorname{Op}_{h}(\widetilde{b})^{*}v_{j}(t) = -i \int_{0}^{t} \operatorname{Op}_{h}(\widetilde{b})^{*}e^{-i(t-s)H_{h}/h}w_{h}(s)ds,$$

where $w_h(s) = \{-i\theta'_j(s) \operatorname{Op}_h(b_h)^* + h^{-1}\theta_j(s)[\operatorname{Op}_h(b_h)^*, H_h]\}u_h(s)$. Note that $w_h(s)$ is supported in \widetilde{I}_j with respect to s. Now we observe from (3.9) and Lemma 3.6 that

$$\begin{split} \left\| \int_{0}^{\infty} \operatorname{Op}_{h}(\tilde{b})^{*} e^{-i(t-s)H_{h}/h} w_{h}(s) ds \right\|_{L^{p}(\tilde{I}_{j};L^{q})} \\ &\lesssim h^{-1/p} \left\| \int_{0}^{\infty} e^{isH_{h}/h} w_{h}(s) ds \right\|_{L^{2}} \\ &\lesssim h^{-1/p} \| w_{h} \|_{L^{1}(\tilde{I}_{j};L^{2})} \\ &\lesssim h^{-1/p} (1+h^{N-2/(2-\mu)}) \| \langle x \rangle^{-1} u_{h} \|_{L^{1}(\tilde{I}_{j};L^{2})} \end{split}$$
(3.23)

for any $N \ge 0$, where we used the fact $b_h \langle x \rangle \in C_0^{\infty}(\mathbb{R}^{2n})$ and $|V_h| \lesssim h^{-2/(2-\mu)}$ in the last line. Since p > 1, Christ-Kiselev's lemma [10] shows that, in the left hand side of (3.23), the integral over $[0, \infty)$ can be replaced by an integral over [0, t]. Since $|\widetilde{I}_j| \le 2\varepsilon_0$, this implies that

$$\begin{aligned} \|\operatorname{Op}_{h}(\widetilde{b})^{*}v_{j}(t)\|_{L^{p}(\widetilde{I}_{j};L^{q})} &\lesssim h^{-1/p}(1+h^{N-2/(2-\mu)})\|\langle x\rangle^{-1}u_{h}\|_{L^{1}(\widetilde{I}_{j};L^{2})} \\ &\lesssim h^{-1/p}(1+h^{N-2/(2-\mu)})\|\langle x\rangle^{-1}u_{h}\|_{L^{2}(\widetilde{I}_{j};L^{2})} \end{aligned}$$

Choosing $N \ge 2/(2-\mu)$, we complete the proof of (3.22).

By virtue of Proposition 3.3, in order to obtain (3.7), it remains to show that

$$\|\operatorname{Op}_{h}(a_{h}^{\infty})^{*}\varphi(H_{h})e^{-itH_{h}/h}u_{0}\|_{L_{t}^{p}L_{x}^{q}} \lesssim h^{-1/p}\|u_{0}\|_{L^{2}}$$
(3.24)

holds uniformly in $h = \lambda^{2/\mu-1} \in (0,1]$. Note that, for $R \ge 1$ large enough, there exists a relatively compact open interval $I \Subset (0,\infty)$ such that a_h^{∞} is supported in the region

$$\{(x,\xi) \in \mathbb{R}^{2n} \mid |x| > R, \ |\xi|^2 \in I\}.$$

We first introduce some notation. For $R \ge 1$, a relatively compact interval $I \Subset (0, \infty)$ and $\sigma \in (-1, 1)$, the outgoing/incoming regions are defined respectively by

$$\Gamma^{\pm}(R, I, \sigma) := \{ (x, \xi) \in \mathbb{R}^{2n} \mid |x| > R, \ |\xi|^2 \in I, \ \pm \cos(x, \xi) > -\sigma \}$$
(3.25)

where $\cos(x,\xi) = x \cdot \xi/(|x||\xi|)$. Note that $\{|x| > R, |\xi|^2 \in I\} \subset \Gamma^+(R,I,\sigma) \cup \Gamma^-(R,I,\sigma)$ if $\sigma > 0$. Also note that $\Gamma^{\pm}(R,I,\sigma)$ are decreasing in R and increasing in I,σ , namely

$$\Gamma^{\pm}(R_1, I_1, \sigma_1) \subset \Gamma^{\pm}(R_2, I_2, \sigma_2)$$
 if $R_2 < R_1, I_1 \Subset I_2, \sigma_1 < \sigma_2.$

Given $R \ge 2$ and $I_1 \Subset I_2, \sigma_1 < \sigma_2$, one can construct $\chi_{1 \to 2}^{\pm} \in S^{0, -\infty}$ which is of the form

$$\chi_{1\to 2}^{\pm}(x,\xi) = \rho_R(x)\rho_{I_1,I_2}(\xi)\rho_{\sigma_1,\sigma_2}(\pm\cos(x,\xi))$$

with some $\rho_R \in C^{\infty}(\mathbb{R}^n)$, $\rho_{I_1,I_2} \in C_0^{\infty}(\mathbb{R}^n)$ and $\rho_{\sigma_1,\sigma_2} \in C^{\infty}(\mathbb{R})$ such that $\chi_{1\to2}^{\pm} \equiv 1$ on $\Gamma^{\pm}(R, I_1, \sigma_1)$ and $\operatorname{supp} \chi_{1\to2}^{\pm} \subset \Gamma^{\pm}(R^{1/2}, I_2, \sigma_2)$ (see [5, Proposition 3.2]). Now we decompose a_h^{∞} into outgoing and incoming parts

$$a_h^{\infty} = a^+ + a^-, \quad a^{\pm} \in S^{0, -\infty}, \quad \operatorname{supp} a^{\pm} \subset \Gamma^{\pm}(R, I, 1/2).$$

As in Lemma 3.5, (3.24) is a consequence of the following dispersive estimate

$$\|\operatorname{Op}_{h}(a^{\pm})^{*}\varphi(H_{h})e^{-itH_{h}/h}\operatorname{Op}_{h}(a^{\pm})\|_{1\to\infty} \lesssim |th|^{-n/2}, \quad t \neq 0, \ h \in (0,1].$$
(3.26)

We actually show a slightly more general statement as follows:

Theorem 3.7. Let $I \in (0,\infty)$ be a relatively compact interval, $\sigma \in (-1,1)$, $\varphi \in C_0^{\infty}((0,\infty))$ and $a^{\pm}, b^{\pm} \in S^{0,-\infty}$ be supported in $\Gamma^{\pm}(R, I, \sigma)$. Then, for sufficiently large R,

$$\|\operatorname{Op}_{h}(b^{\pm})^{*}\varphi(H_{h})e^{-itH_{h}/h}\operatorname{Op}_{h}(a^{\pm})\|_{1\to\infty} \lesssim |th|^{-n/2}$$
 (3.27)

uniformly in $\pm t \leq 0$ and $h \in (0, 1]$.

Proof of (3.26), assuming Theorem 3.7. We use a the same argument as that in [5]. Let

$$U^{\pm}(t) = \operatorname{Op}_{h}(a^{\pm})^{*}\varphi(H_{h})e^{-itH_{h}/h}\operatorname{Op}_{h}(a^{\pm})$$

and $K^{\pm}(t, x, y)$ denote the Schwartz kernel of $U^{\pm}(t)$. Since $U^{\pm}(t)^* = U^{\pm}(-t)$, K^{\pm} satisfies

$$K^{\pm}(t, x, y) = \overline{K^{\pm}(-t, y, x)}.$$

Therefore, if (3.27) with $b^{\pm} = a^{\pm}$ holds for $\pm t \leq 0$, then so does it for $\pm t \geq 0$ and (3.26) follows.

Remark 3.8. Although the case with $b^{\pm} = a^{\pm}$ is sufficient to obtain the homogeneous estimate (2.22), the general case will be used in the proof of the inhomogeneous estimate (2.23).

The proof of Theorem 3.7 basically follows the same line as that in Bouclet-Tzvetkov [6, Sections 4 and 5] in which long-range metric perturbations of the Laplacian (without potentials) were considered. However, since several propositions in the proof will be also used in the proof of inhomogeneous estimates (2.23) which was not considered in [6], we give a complete proof. The proof is based on the so-called semiclassical Isozaki-Kitada (IK for short) parametrix for $e^{-itH_h/h}$ Op_h(a^{\pm}). Such a parametrix was originally introduced by Isozaki-Kitada [22] in the non-semiclassical regime, in order to show the existence and asymptotic completeness of modified wave operators for the pair ($-\Delta, H$) under the condition (H1). Since then, the IK parametrix has been extensively used in the study of long-range scattering theory in both non-semiclassical and semiclassical settings (see [23, 35, 13] and references therein), and more recently, used in the proof of Strichartz estimates (see [5, 6, 3] and references therein). To construct the IK parametrix, we basically follow the argument in [35, Section 4], [5, Section 3] and [6, Section 4]. For a basic theory of semiclassical FIOs, we refer to [34].

Henceforth, although all the statements will be stated for both the outgoing (+) and incoming
(-) cases, we will give the proofs for the outgoing case only, the incoming case being analogous.
We begin with constructing the phase function.

Lemma 3.9. Let $I \in (0, \infty)$ and $\sigma \in (-1, 1)$. Then there exist $R_{\text{IK}} \geq 1$ and a family of smooth functions $S_{h,R}^{\pm} \in C^{\infty}(\mathbb{R}^{2n})$ with parameters $R \geq R_{\text{IK}}$ and $h \in (0, 1]$ such that, for all $\alpha, \beta \in \mathbb{Z}_{+}^{n}$,

$$\begin{split} |\partial_x^{\alpha} \partial_{\xi}^{\beta} (S_{h,R}^{\pm}(x,\xi) - x \cdot \xi)| &\leq C_{\alpha\beta} \langle x \rangle^{1-\mu-|\alpha|}, \\ |\partial_x^{\alpha} \partial_{\xi}^{\beta} (S_{h,R}^{\pm}(x,\xi) - x \cdot \xi)| &\leq C_{\alpha\beta} \min\{\langle x \rangle^{1-\mu-|\alpha|}, R^{1-\mu-|\alpha|}\}, \quad |\alpha| \geq 1, \end{split}$$

where $C_{\alpha\beta}$ is independent of h, x, ξ and R. Moreover, $S_{h,R}^{\pm}$ satisfies

$$|\nabla_x S_{h,R}^{\pm}(x,\xi)|^2 + V_h(x) = |\xi|^2, \quad (x,\xi) \in \Gamma^{\pm}(R,I,\sigma).$$
(3.28)

Proof. Let $\widetilde{V}_h \in C^{\infty}(\mathbb{R}^n; \mathbb{R})$ be such that $\widetilde{V}_h \equiv V_h$ for $|x| \ge 1$ and $\partial_x^{\alpha} \widetilde{V}_h(x) = O(\langle x \rangle^{-\mu - |\alpha|})$ on \mathbb{R}^n uniformly in h. It then follows from [35, Proposition 4.1] (see also [5, Proposition 3.2]) that there exists $R_{\text{IK}} \ge 1$ such that, for any $R \ge R_{\text{IK}}$, one can construct $\widetilde{S}_{h,R}^+ \in C^{\infty}(\mathbb{R}^{2n})$ satisfying

$$|\partial_x^{\alpha}\partial_{\xi}^{\beta}(\widetilde{S}_{h,R}^+(x,\xi) - x \cdot \xi)| \le C_{\alpha} \langle x \rangle^{-\mu - |\alpha|}, \quad (x,\xi) \in \mathbb{R}^{2n}$$

and $|\nabla_x \widetilde{S}_{h,R}^+(x,\xi))|^2 + \widetilde{V}_h(x) = |\xi|^2$ on $\Gamma^+(R,I,\sigma)$. Let $R_1 = R, I_1 = I$ and $\sigma_1 = \sigma$ and take $I_1 \in I_2$ and $-1 < \sigma_1 < \sigma_2 < 1$. Using the cut-off function $\chi_{1\to 2}^+$ introduced above, we define

$$S_{h,R}^+(x,\xi) := x \cdot \xi + \chi_{1\to 2}^+(x,\xi) (\widetilde{S}_{h,R}^+(x,\xi) - x \cdot \xi).$$

Then it is not hard to check that $S_{h,R}^+$ satisfies the desired properties.

In what follows we drop the subscript R and write $S_h^{\pm} = S_{h,R}^{\pm}$ for simplicity. To a symbol $a \in S^{0,-\infty}$ we associate h-FIOs $J_h^{\pm}(a) : S(\mathbb{R}^n) \to S'(\mathbb{R}^n)$ defined by

$$J_{h}^{\pm}(a)f(x) = \frac{1}{(2\pi h)^{n}} \iint e^{i(S_{h}^{\pm}(x,\xi) - y \cdot \xi)/h} a(x,\xi)f(y) dy d\xi$$

Here we record a few basic properties of J_h^+ without proofs (see [34, 2] for details). For $a, b \in S^{0,-\infty}$, the kernel of $J_h^+(a)(J_h^+(b))^*$ is given by

$$\frac{1}{(2\pi h)^n} \int e^{i(S_h^+(x,\xi) - S_h^+(y,\xi))/h} a(x,\xi) \overline{b(y,\xi)} d\xi,$$

where, by Lemma 3.9, the phase function obeys

$$S_{h}^{+}(x,\xi) - S_{h}^{+}(y,\xi) = (x-y) \cdot \xi_{h}(x,y,\xi), \ \partial_{x}^{\alpha} \partial_{\xi}^{\beta} \partial_{y}^{\gamma}(\xi_{h}(x,y,\xi) - \xi) = O(R^{-\mu}).$$

Hence the standard Kuranishi's trick implies that, for sufficiently large R

$$J_h^+(a)(J_h^+(b))^* = \operatorname{Op}_h(c_h), \quad c_h \in S^{0,-\infty}$$

In particular, $J_h^+(a)$ is bounded on L^2 uniformly in $h \in (0,1]$. Using the following property

$$J_h^+(a)x_j = J_h^+(a\partial_{\xi_j}S_h^+) - ihJ_h^+(\partial_{\xi_j}a)$$

and the fact $\langle x \rangle^{-1} a \partial_{\xi_j} S_h^+ \in S^{0,-\infty}$ and a duality argument, we also see that, for any $\alpha \in \mathbb{R}$,

$$\sup_{h \in (0,1]} \|\langle x \rangle^{\alpha} J_h^+(a) \langle x \rangle^{-\alpha} \| \le C_{\alpha} < \infty.$$

Next we recall a microlocal parametrix construction of an elliptic *h*-FIO. Take $N \in \mathbb{N}$, $I_1 \Subset I_2 \Subset I_3 \Subset (0,\infty)$ and $-1 < \sigma_1 < \sigma_2 < \sigma_3 < 1$ arbitrarily. Let $R \ge R_{\text{IK}}^3$ be large enough and consider a symbol $b = b_0 + hb_1 + \cdots + h^N b_N$ with $b_j \in S^{-j,-\infty}$ supported in $\Gamma^+(R^{1/3}, I_3, \sigma_3)$. Assume that b_0 is elliptic in such a way that

$$b_0 \gtrsim 1$$
 on $\Gamma^+(R^{1/2}, I_2, \sigma_2)$.

Then, for any $a \in S^{0,-\infty}$ supported in $\Gamma^+(R, I_1, \sigma_1)$, there exist a sequence $c_j \in S^{-j,-\infty}$ supported in $\Gamma^+(R^{1/2}, I_2, \sigma_2)$ and $r_N \in S_N^{-N,-\infty}$ such that, with $c = c_0 + hc_1 + \cdots + h^N c_N$,

$$\operatorname{Op}_{h}(a) = J_{h}^{+}(b)J_{h}^{+}(c)^{*} + \operatorname{Op}_{h}(r_{N}).$$

Finally, we consider the composition $\operatorname{Op}_h(a)J_h^+(b)$ for $a, b \in S^{0,-\infty}$. By a direct calculation by means of Taylor's expansion, $\operatorname{Op}_h(a)J_h^+(b)$ is also an *h*-FIO $J_h^+(c_h)$ with the amplitude

$$c_h(x,\xi) = \frac{1}{(2\pi h)^n} \iint e^{i[S_h^+(y,\xi) - S_h^+(x,\xi) + (x-y)\cdot\eta]/h} a(x,\eta) b(y,\xi) dy d\eta$$

having the following asymptotic expansion

$$c_h(x,\xi) - \sum_{|\alpha| < N} \frac{i^{-|\alpha|} h^{|\alpha|}}{\alpha!} (\partial_{\xi}^{\alpha} a)(x, \nabla_x S_h^+(x,\xi)) \partial_y^{\alpha} \left[e^{i\Psi_h(x,y,\xi)} b(y,\xi) \right] \Big|_{y=x} \in h^N S^{-N,-\infty}$$
(3.29)

for any $N \ge 0$, where $\Psi_h(x, y, \xi) = S_h^+(y, \xi) - S_h^+(x, \xi) + (x - y) \cdot \nabla_x S_h^+(x, \xi)$. In particular, since $\nabla_x S_h^+(x, \xi) = \xi + O(R^{-\mu})$, for any neighborhood U of supp $a \cap$ supp b, there exists R' > 0 such that, modulo an error term in $S_N^{-N, -\infty}$, c_h is supported in U provided that $R \ge R'$.

Proposition 3.10 (Semiclassical Isozaki-Kitada parametrix). Let $I_1 \subseteq I_2 \subseteq I_3 \subseteq I_4 \subseteq (0, \infty)$ be relatively compact open intervals and $-1 < \sigma_1 < \sigma_2 < \sigma_3 < \sigma_4 < 1$ so that

$$\Gamma^{\pm}(R^{1/j}, I_j, \sigma_j) \subset \Gamma^{\pm}(R^{1/(j+1)}, I_{j+1}, \sigma_{j+1}), \quad 1 \le j \le 4.$$

For $R \ge R_{\text{IK}}^4$ large enough, any $a^{\pm} \in S^{0,-\infty}$ supported in $\Gamma^{\pm}(R, I_1, \sigma_1)$ and any $N \ge 0$, we have

$$e^{-itH_h/h} \operatorname{Op}_h(a^{\pm}) = J_h^{\pm}(c^{\pm}) e^{ith\Delta} J_h^{\pm}(d^{\pm})^* + \sum_{j=1}^4 Q_j^{\pm}(t,h)$$

where the remainder terms $Q_j^{\pm}(t,h), 1 \leq j \leq 4$, are given by

$$\begin{split} Q_{1}^{\pm}(t,h) &= h^{N}e^{-itH_{h}/h}\operatorname{Op}_{h}(r_{1}^{\pm}), \\ Q_{2}^{\pm}(t,h) &= -ih^{N-1}\int_{0}^{t}e^{-i(t-s)H_{h}/h}J_{h}^{\pm}(r_{2}^{\pm})e^{ish\Delta}J_{h}^{\pm}(d^{\pm})^{*}ds, \\ Q_{3}^{\pm}(t,h) &= -\frac{i}{h}\int_{0}^{t}e^{-i(t-s)H_{h}/h}\operatorname{Op}_{h}(\widetilde{e}_{\mathrm{com}}^{\pm})J_{h}^{\pm}(e_{\mathrm{com}}^{\pm})e^{ish\Delta}J_{h}^{\pm}(d^{\pm})^{*}ds \\ Q_{4}^{\pm}(t,h) &= -\frac{i}{h}\int_{0}^{t}e^{-i(t-s)H_{h}/h}\operatorname{Op}_{h}(\widetilde{e}^{\pm})J_{h}^{\pm}(e^{\pm})e^{ish\Delta}J_{h}^{\pm}(d^{\pm})^{*}ds \end{split}$$

and S_h^{\pm} is given by Lemma 3.9 with R, I, σ replaced by $R^{1/4}, I_4, \sigma_4$. Moreover, the amplitudes satisfy the following properties:

- $c^{\pm}, d^{\pm}, e^{\pm}, \tilde{e}^{\pm} \in S^{0, -\infty}, r_1^{\pm}, r_2^{\pm} \in S^{-N, \infty} \text{ and } e_{\text{com}}^{\pm} \in C_0^{\infty}(\mathbb{R}^{2n});$
- supp $c^{\pm} \subset \Gamma^{\pm}(R^{1/3}, I_3, \sigma_3)$, supp $d^{\pm} \subset \Gamma^{\pm}(R^{1/2}, I_2, \sigma_2)$;
- supp e_{com}^{\pm} , supp $\tilde{e}_{\text{com}}^{\pm} \subset \Gamma^{\pm}(R^{1/4}, I_4, \sigma_4) \cap \{|x| \le R^{4/9}\};$
- $\operatorname{supp} e^{\pm}, \operatorname{supp} \widetilde{e}^{\pm} \subset \Gamma^{\pm}(R^{1/4}, I_4, \sigma_4) \cap \Gamma^{\mp}(R^{1/4}, I_4, -\widetilde{\sigma}) \text{ with some } \widetilde{\sigma} \in (\sigma_2, \sigma_3).$

Proof. This proposition is basically known (see [35] and also [6, Proposition 4.2]). Hence, we only give a brief outline of the proof. Given a symbol $c \in S^{0,-\infty}$, we obtain, by computing $\int_0^t \frac{d}{ds} (e^{isH_h/h} J_h^+(c) e^{ish\Delta}) ds$ in two ways, the following Duhamel formula

$$e^{-itH_{h}/h}J_{h}^{+}(c) = J_{h}^{+}(c)e^{ith\Delta} - \frac{i}{h}\int_{0}^{t} e^{-i(t-s)H_{h}/h} \Big(H_{h}J_{h}^{+}(c) + J_{h}^{+}(c)h^{2}\Delta\Big)e^{ish\Delta}ds.$$
(3.30)

Here $H_h J_h^+(c) + J_h^+(c) h^2 \Delta$ is an *h*-FIO with the phase S_h^+ and the amplitude

$$e^{-\frac{i}{\hbar}S_{h}^{+}}H_{h}(e^{\frac{i}{\hbar}S_{h}^{+}}c) - \xi^{2}$$

= $(|\nabla_{x}S_{h}^{+}|^{2} + V_{h} - |\xi|^{2})c + ih\{-2(\nabla_{x}S_{h}^{+}) \cdot \nabla_{x}c + (\Delta_{x}S_{h}^{+})c\} - h^{2}\Delta_{x}c.$

With Lemma 3.9 at hand, one then can construct, by means of Hamilton-Jacobi theory, $\tilde{c}_j^+ \in S^{-j,\infty}$ supported in $\Gamma^+(R^{1/3}, I_3, \sigma_3)$ such that $\tilde{c}^+ = \tilde{c}_0^+ + h\tilde{c}_1^+ + \cdots + h^N \tilde{c}_N^+$ satisfies

$$r_0^+ := ih\{-2(\nabla_x S_h^+) \cdot \nabla_x \tilde{c}^+ + (\Delta_x S_h^+)\tilde{c}^+\} - h^2 \Delta_x \tilde{c}^+ \in h^N S^{-N, -\infty}.$$
(3.31)

Let $\chi^+ \in S^{0,-\infty}$ be such that $\chi^+ \equiv 1$ on $\Gamma^+(R^{1/3}, I_3, \sigma_3)$, χ^+ is supported in a sufficiently small neighborhood of $\Gamma^+(R^{1/3}, I_3, \sigma_3)$, and is of the form

$$\chi^+(x,\xi) = \rho_1(x/R^{1/3})\rho_2(\xi)\rho_3(\cos(x,\xi))$$

with some $\rho_1 \in C^{\infty}(\mathbb{R}^n)$, $\rho_2 \in C_0^{\infty}(\mathbb{R}^n)$ and $\rho_3 \in C^{\infty}(\mathbb{R})$ such that $\rho_1(x) = 1$ if $|x| \ge 1$, $\rho_2(\xi) = 1$ if $|\xi|^2 \in I_3$ and $\rho_3(s) = 1$ if $s > -\sigma_3$. We set $c^+ := \chi^+ \tilde{c}^+ \in S^{0,-\infty}$ which is well defined on \mathbb{R}^{2n} and, by virtue of (3.28), satisfies

$$(|\nabla_x S_h^+|^2 + V_h - |\xi|^2)c^+ \equiv 0, \quad x, \xi \in \mathbb{R}^{2n}.$$
(3.32)

Moreover, by (3.31) and (3.32), we have

$$ih(-2(\nabla_x S_h^+) \cdot \nabla_x c^+ + (\Delta_x S_h^+)c^+) - h^2 \Delta_x c^+ = h^N r_2' + e_{\rm com}^+ + e^+$$

where $r'_2 = \chi^+ r_0^+$, and $e_{\rm com}^+$ (resp. e^+) consists of the parts for which at least one derivative in x falls on the factor ρ_1 (resp. ρ_3). Then, it is easy to see that $|x| \leq R^{1/3}$ on $\operatorname{supp} e_{\rm com}^+$ and that $\cos(x,\xi) \leq -\sigma_3$ on $\operatorname{supp} e^+$ which show that e^+ and $e_{\rm com}^+$ satisfy desired properties in the statement. By using the formula (3.29), one can also construct $\tilde{e}_{\rm com}^+, \tilde{e}^+ \in S^{0,-\infty}$ such that $\tilde{e}_{\rm com}^+ \equiv 1$ (resp. $\tilde{e}^+ \equiv 1$) on a sufficiently small neighborhood of $e_{\rm com}^+$ (resp. $\operatorname{supp} e^+$) and that

supp
$$\widetilde{e}_{com}^+ \subset \Gamma^+(R^{1/4}, I_4, \sigma_4) \cap \{ |x| < R^{4/9} \},$$

supp $\widetilde{e}^+ \subset \Gamma^+(R^{1/4}, I_4, \sigma_4) \cap \Gamma^-(R^{1/4}, I_4, -\widetilde{\sigma})$

with some $\sigma_2 < \tilde{\sigma} < \sigma_3$ and that

$$J_{h}^{+}(e_{\text{com}}^{+}) = \operatorname{Op}_{h}(\tilde{e}_{\text{com}}^{+})J_{h}^{+}(e_{\text{com}}^{+}) + h^{N}J_{h}^{+}(r_{2}''),$$

$$J_{h}^{+}(e^{+}) = \operatorname{Op}_{h}(\tilde{e}^{+})J_{h}^{+}(e^{+}) + h^{N}J_{h}^{+}(r_{2}''')$$

with some $r_2'', r_2'' \in S^{-N,-\infty}$. If we define $r_2^+ = r_2' + r_2'' + r_2'''$ then r_2^+ satisfies the desired properties. By construction, we have

$$H_h J_h^+(c^+) + J_h^+(c^+) h^2 \Delta = h^N J_h^+(r_2^+) + \operatorname{Op}_h(\widetilde{e}_{\operatorname{com}}^+) J_h^+(e_{\operatorname{com}}^+) + \operatorname{Op}_h(\widetilde{e}^+) J_h^+(e^+).$$

Finally, since $c_0 \gtrsim 1$ on $\Gamma^+(R^{1/3}, I_3, \sigma_3)$ by construction, one can also construct $d^+ \in S^{0,-\infty}$ and $r_1^+ \in S^{-N,-\infty}$ such that d^+ is supported in $\Gamma^+(R^{1/2}, I_2, \sigma_2)$ and

$$Op_h(a^+) = J_h^+(c^+)J_h^+(d^+)^* - h^N Op_h(r_1^+).$$

Multiplying (3.30) with $c = c^+$ by $J_h^+(d^+)^*$ from the right hand side, we complete the proof.

Now we give the proof of Theorem 3.7 which is divided into a series of propositions.

Proposition 3.11. Let $I \in (0, \infty)$ be a relatively compact interval. For sufficiently large $R \ge R_{\text{IK}}$ and any symbols $a, b \in S^{0,-\infty}$ satisfying $|\xi|^2 \in I$ on supp a and on supp b, we have

$$\|J_{h}^{\pm}(a)e^{ith\Delta}J_{h}^{\pm}(b)^{*}\|_{1\to\infty} \lesssim \min\{|th|^{-n/2}, h^{-n}\}, \quad t \in \mathbb{R}, \ h \in (0, 1].$$
(3.33)

Proof. The kernel $I_{a,b}(t, x, y)$ of $J_h^+(a)e^{ith\Delta}J_h^+(b)^*$ is given by

$$I_{a,b}(t,x,y) = \frac{1}{(2\pi\hbar)^n} \int e^{i\Phi^+(t,x,\xi)/\hbar} a(x,\xi) \overline{b(y,\xi)} d\xi$$

where $\Phi^+(t, x, \xi) = -t|\xi|^2 + S_h^+(x, \xi) - S_h^+(y, \xi)$. By virtue of Lemma 3.9, Φ^+ satisfies

$$\nabla_{\xi} \Phi^{+}(t, x, \xi) = -2t\xi + \left(1 + Q^{+}(x, y, \xi)\right)(x - y)$$
(3.34)

with some Q^+ satisfying, for all $\alpha, \beta, \gamma \in \mathbb{Z}^n_+$,

$$|\partial_x^{\alpha}\partial_y^{\beta}\partial_{\xi}^{\gamma}Q^+(x,y,\xi)| \le C_{\alpha\beta\gamma}R^{-\mu}, \quad x,y,\xi \in \mathbb{R}^n, \ h \in (0,1].$$

Since (3.33) is trivial if $|t| \leq h$, we may assume $|t| \geq h$. Then, for sufficiently large R, there exists $C_0 > 0$ such that if $|(x - y)/t| \geq C_0$ then

$$\left|\frac{\nabla_{\xi}\Phi^{+}(t,x,\xi)}{t}\right| \gtrsim \left|\frac{x-y}{t}\right| \ge C_{0}$$

and we have, by integration by parts in ξ , that

$$|I(t, x, y)| \le C_N h^{-n} |th^{-1}|^{-N} \lesssim |th|^{-n/2}$$

for all $|t| \gtrsim h$ provided $N \geq n/2$. Otherwise, we have that

$$\frac{\nabla_{\xi}^{2}\Phi^{+}(t,x,\xi)}{t} = -2\operatorname{Id} + O(R^{-\mu}), \quad \frac{\partial_{x}^{\alpha}\partial_{y}^{\beta}\partial_{\xi}^{\gamma}\Phi^{+}(t,x,\xi)}{t} = O(1)$$

for all $\alpha, \beta, \gamma \in \mathbb{Z}^n_+$ and $x, y \in \mathbb{R}^n$, $h \in (0, 1]$, $|\xi|^2 \in I$. Therefore, choosing $R \geq R_{\text{IK}}$ sufficiently large if necessary, we can apply the stationary phase theorem to obtain

$$|I_{a,b}(t,x,y)| \lesssim h^{-n} |th^{-1}|^{-n/2} = |th|^{-n/2}$$

for $|t| \gtrsim h$, which completes the proof.

Proposition 3.12. Let d^{\pm} , r_2^{\pm} , e_{com}^{\pm} and e^{\pm} be as in Proposition 3.10. Let $R \ge 1$ be large enough. Then for all $s \in \mathbb{R}$ and sufficiently large $N \ge 1$, we have

$$\|\langle D\rangle^{s} \langle x\rangle^{N/4} J_{h}^{\pm}(r_{2}^{\pm}) e^{ith\Delta} J_{h}^{\pm}(d^{\pm})^{*} \langle x\rangle^{N/8} \langle D\rangle^{s} \| \lesssim h^{-n-2s} \langle t\rangle^{-N/8}$$
(3.35)

uniformly in $\pm t \ge 0$ and $h \in (0,1]$. Moreover, for any $M \ge 0$ and $s \in \mathbb{R}$,

$$\|\langle D\rangle^{s} \langle x\rangle^{M} J_{h}^{\pm}(\chi^{\pm}) e^{ith\Delta} J_{h}^{\pm}(d^{\pm})^{*} \langle x\rangle^{M} \langle D\rangle^{s} \| \lesssim h^{M-2s} \langle t\rangle^{-M},$$
(3.36)

 $\textit{uniformly in } \pm t \geq 0 \textit{ and } h \in (0,1], \textit{ where } \chi^{\pm} = e^{\pm}_{\mathrm{com}} \textit{ or } e^{\pm}.$

To prove this proposition, we need the following elementary fact (see [6, Lemma 4.1]).

Lemma 3.13. Let $x, y, \xi \in \mathbb{R}^n \setminus \{0\}, -1 < \sigma < 1 \text{ and } -1 < \sigma_2 < \sigma_3 < 1.$

- (1) If $\pm \cos(x,\xi) > -\sigma$ and $\pm t \ge 0$, then $\pm \cos(x+2t\xi,\xi) > -\sigma$ and $|x+2t\xi| \ge |x|+t|\xi|$.
- (2) If $\pm \cos(x,\xi) \leq -\sigma_3$ and $\pm \cos(y,\xi) > -\sigma_2$ then $|x-y| \gtrsim |x| + |y|$.

Here implicit constants are independent of x, y and t.

Proof of Proposition 3.12. Let I_{b,d^+} be the kernel of $J_h^+(b)e^{ith\Delta}J_h^+(d^+)^*$. By (3.13) (1), one has

$$|y| \ge R^{1/2}, \quad |y + 2t\xi| \gtrsim |y| + t$$
 (3.37)

for $t \ge 0$ on the support of $d^+(y,\xi)$. We first consider (3.35) with s = 0. Take $\chi \in C_0^{\infty}(\mathbb{R}^n)$ supported in a unit ball $\{x \mid |x| \le 1\}$ and decompose $I_{r_2^+, d^+}$ as

$$I_{r_{2}^{+},d^{+}} = \frac{1}{(2\pi h)^{n}} \int e^{i\Phi^{+}(t,x,\xi)/h} \chi \Big(\nabla_{\xi} \Phi^{+}(t,x,\xi) \Big) r_{2}^{+}(x,\xi) \overline{d^{+}(y,\xi)} d\xi + \frac{1}{(2\pi h)^{n}} \int e^{i\Phi^{+}(t,x,\xi)/h} (1-\chi) \Big(\nabla_{\xi} \Phi^{+}(t,x,\xi) \Big) r_{2}^{+}(x,\xi) \overline{d^{+}(y,\xi)} d\xi =: I^{(1)} + I^{(2)}.$$

For the first part $I^{(1)}$, we know by (3.34) that

$$1 \ge |\nabla_{\xi} \Phi^+| \ge |y + 2t\xi| - |x| - C(1 + |x| + |y|)^{1-\mu}$$

with some universal C > 0, which, together with (3.37) implies $\langle x \rangle^{-1} \leq (1 + |y| + |t|)^{-1}$ on the support of the amplitude of $I^{(1)}$ provided R is large enough. This bound implies

$$|I^{(1)}(t,x,y)| \lesssim h^{-n} \langle x \rangle^{-N/2} \langle y \rangle^{-N/4} \langle t \rangle^{-N/4}$$
(3.38)

since $r_2^+ \in S^{-N,-\infty}$. On the other hand, when $|\nabla_{\xi} \Phi^+| \geq 1$, we have

$$|y| + t \leq |y + 2t\xi| = \left|\nabla_{\xi}\Phi^{+}(t, x, \xi) - x + O((1 + |x| + |y|)^{1-\mu})\right| \leq |\nabla_{\xi}\Phi^{+}|\langle x \rangle + C|y|^{1-\mu}$$

which yields $|\nabla_{\xi}\Phi^+|^{-1} \lesssim \langle x \rangle \langle y \rangle^{-1/2} \langle t \rangle^{-1/2}$ if R is large enough. Integrating by parts with respect to the operator

$$L_{\Phi^+} = \frac{h}{i|\nabla_{\xi}\Phi^+|^2} (\nabla_{\xi}\Phi^+) \cdot \nabla_{\xi},$$

we thus obtain that

$$|I^{(2)}(t,x,y)| \lesssim h^{N/2} \langle x \rangle^{-N/2} \langle y \rangle^{-N/4} \langle t \rangle^{-N/4}, \quad t \ge 0.$$
(3.39)

Then (3.35) with s = 0 and $b = r_2^+$ easily follows from (3.38) and (3.39) provided N is large enough. When $s \in \mathbb{N}$, taking into account the bound

$$\nabla_x \Phi^+(t, x, \xi) = \xi + O(\langle x \rangle^{-\mu})$$

and the formula $J_h^+(a)\partial_{x_j} = ih^{-1}J_h^+(\xi_j a)$, we obtain (3.35) by the same argument. For general $s \ge 0$, (3.35) with $b = r_2^+$ then follows from the case with $s \in \mathbb{N} \cup \{0\}$ and complex interpolation. In case of (3.36) with $\chi^+ = e_{\text{com}}^+$, since $|x| \le R^{1/3}$ on $\operatorname{supp} e_{\text{com}}^+$ and $|y| \ge R^{1/2}$ on $\operatorname{supp} d^+$,

we know by Lemma 3.13 (1) that $|x - y - 2t\xi| \gtrsim 1 + |x| + |y| + t$ and thus

$$|\nabla_{\xi}\Phi^{+}| = |x - y - 2t\xi + O((1 + |x| + |y|)^{1-\mu})| \gtrsim 1 + |x| + |y| + t$$

for $t \ge 0$ on the support of the amplitude of $I_{e_{\text{com}}^+,d^+}$ provided that R is large enough. Therefore, integrating by parts with respect to L_{Φ^+} shows

$$|I_{e^+_{\rm com},d^+}(t,x,y)| \le h^M (1+|x|+|y|+t)^{-M}, \quad t\ge 0,$$

for all $M \ge 0$ and (3.36) follows. Finally, to obtain (3.36) with $\chi^+ = e^+$, we use the support properties of e^+ and d^+ which yield that

$$\cos(x,\xi) < -\widetilde{\sigma} < -\sigma_2 < \cos(y+2t\xi,\xi)$$

for all $t \ge 0$. Lemma 3.13 (2) then implies

$$|x - y - 2t\xi| \gtrsim 1 + |x| + |y| + |t|$$

for all $t \ge 0$ on the support of the amplitude of I_{e^+,d^+} which gives us (3.35) as above.

Using Propositions 2.39, 3.11 and 3.12 we have the following propagation estimates.

Proposition 3.14. Let $R \ge 1$ be large enough and $b^{\pm} \in S^{0,-\infty}$ supported in $\Gamma^{\pm}(R, I, \sigma)$. Then the following statements are satisfied with implicit constants independent of t and $h \in (0, 1]$.

• For sufficiently large integer N and all $s \ge 0$,

$$\|\langle x\rangle^{-N}\varphi(H_h)e^{-itH_h/h}\operatorname{Op}_h(b^{\pm})\langle D\rangle^s\| \lesssim h^{-n-s-1}\langle t\rangle^{-N/8}, \quad \pm t \ge 0.$$
(3.40)

• For any $\chi \in C_0^{\infty}(\mathbb{R}^n)$ supported in a unit ball $\{|x| < 1\}$ and all $M, s \ge 0$,

$$\|\chi(x/R^{1/3})\varphi(H_h)e^{-itH_h/h}\operatorname{Op}_h(b^{\pm})\langle D\rangle^s\| \lesssim h^{M-s}\langle t\rangle^{-M}, \quad \pm t \ge 0.$$
(3.41)

• If $\chi^{\mp} \in S^{0,-\infty}$ is supported in $\Gamma^{\mp}(R^{1/4}, I_4, -\widetilde{\sigma})$ with some $\widetilde{\sigma} > \sigma$, then for all $M, s \ge 0$

$$\|\langle D\rangle^{s} \operatorname{Op}_{h}(\chi^{\mp})^{*} \varphi(H_{h}) e^{-itH_{h}/h} \operatorname{Op}_{h}(b^{\pm}) \langle x \rangle^{M} \langle D \rangle^{s} \| \lesssim h^{M-2s} \langle t \rangle^{-M}, \quad \pm t \ge 0.$$
(3.42)

Proof. We may prove the proposition for the case s = 0 only. The case s > 0 follows from the case s = 0 since $b^{\pm} \langle \xi \rangle^s$, $\chi^{\mp} \langle \xi \rangle^s \in S^{0,-\infty}$ and $\|\langle hD \rangle^{-s} \langle D \rangle^s \| \lesssim h^{-s}$.

In order to prove (3.40), choosing $N\gg M$ large enough , we decompose the operator in (3.40) into corresponding five parts

$$\langle x \rangle^{-N} \varphi(H_h) J_h^+(c^+) e^{ith\Delta} J_h^+(d^+)^*, \quad \langle x \rangle^{-N} \varphi(H_h) Q_j^+(t,h), \quad 1 \le j \le 4,$$

where $c^+, d^+ \in S^{0,-\infty}$ are given by Proposition 3.10. We shall show that

$$\|\langle x \rangle^{-N} \varphi(H_h) J_h^+(c^+) e^{ith\Delta} J_h^+(d^+)^* \| \lesssim h^{-n-1} \langle t \rangle^{-N/8},$$
(3.43)

$$\|\langle x \rangle^{-N} \varphi(H_h) Q_j^+(t,h)\| \lesssim h^{N-n-2} \langle t \rangle^{-N/8}, \qquad (3.44)$$

for $t \ge 0$ and $h \in (0,1]$ and $1 \le j \le 4$. (3.43) is a direct consequence of (3.35) since $\langle x \rangle^{-N} \varphi(H_h) \langle x \rangle^N$ is bounded on L^2 uniformly in $h \in (0,1]$ by Proposition 2.13. For the part

$$\langle x \rangle^{-N} \varphi(H_h) Q_1^+(t,h) = h^N \langle x \rangle^{-N} \varphi(H_h) e^{-itH_h/h} \langle x \rangle^{-N} \langle x \rangle^N \operatorname{Op}_h(r_1^+),$$

we use (2.39) and the fact $\langle x \rangle^N r_1^+ \in S^{0,-\infty}$ to obtain (3.44). To deal with the term

$$\langle x \rangle^{-N} \varphi(H_h) Q_2^+(t,h) = -ih^{N-1} \int_0^t \langle x \rangle^{-N} \varphi(H_h) e^{-i(t-s)H_h/h} J_h^+(r_2^+) e^{irh\Delta} J_h^+(d^+)^* ds,$$

we again use (2.39) and (3.35) to obtain for $s \leq t$ that

$$\begin{aligned} \|\langle x\rangle^{-N}\varphi(H_h)e^{-i(t-s)H_h/h}\langle x\rangle^{-N/4}\| &\lesssim h^{-1}\langle t-s\rangle^{-N/8},\\ \|\langle x\rangle^{N/4}J_h^+(r_2^+)e^{ish\Delta}J_h^+(d^+)^*\| &\lesssim h^{-n}\langle s\rangle^{-N/8}, \end{aligned}$$

which imply (3.44) since

$$\int_0^t \langle t-s\rangle^{-\frac{N}{8}} \langle s\rangle^{-\frac{N}{8}} ds \lesssim \int_0^{t/2} \langle t\rangle^{-\frac{N}{8}} \langle s\rangle^{-\frac{N}{8}} ds + \int_{t/2}^t \langle t-s\rangle^{-\frac{N}{8}} \langle t\rangle^{-\frac{N}{8}} ds \lesssim \langle t\rangle^{-\frac{N}{8}}.$$
 (3.45)

The estimate (3.44) for the terms $\langle x \rangle^{-N} \varphi(H_h) Q_j^+(t,h)$, j = 3, 4, can be also verified similarly by means of (2.39) and (3.36) (instead of (3.35)). This completes the proof of (3.40).

We next show (3.41) which, as above, follows from the following estimates

$$\begin{aligned} \|\chi(x/R^{1/3})\varphi(H_h)J_h^+(c^+)e^{ith\Delta}J_h^+(d^+)^*\langle x\rangle^M \| &\lesssim h^M \langle t\rangle^{-M}, \\ \|\chi(x/R^{1/3})\varphi(H_h)Q_j(t,h)\langle x\rangle^M \| &\lesssim h^M \langle t\rangle^{-M}, \ 1 \le j \le 4. \end{aligned}$$

The latter bounds for the remainder terms follow from the same argument as that for (3.44). To deal with the main term, we observe from the support property $|x| > R^{1/4}$ on $\operatorname{supp} c^+$ that

$$\varphi(H_h)J_h^+(c^+) = \varphi(H_h)(1-\tilde{\chi})(x/R^{1/4})J_h^+(c^+)$$

with some $\tilde{\chi} \in C_0^{\infty}(\mathbb{R}^n)$. By Proposition 2.13, we then see that $\chi(x/R^{1/3})\varphi(H_h)(1-\tilde{\chi})(x/R^{1/4})$ is a sum of $\operatorname{Op}(\tilde{c}^+)$ and an error term $O_{L^2}(h^N \langle x \rangle^{-N})$, where $\tilde{c}^+ \in S^{0,-\infty}$ is supported in $\Gamma^+(R^{1/4}, I_4, \sigma_4) \cap \{|x| < R^{1/3}\}$. Then the error term can be estimated by using (3.35). Hence it suffices to deal with the operator $\operatorname{Op}(\tilde{c}^+)J_h^+(c^+)e^{ith\Delta}J_h^+(d^+)^*$. Moreover, by virtue of (3.29), we may replace $\operatorname{Op}(\tilde{c}^+)J_h^+(c^+)$ by $J_h^+(c_0^+)$ with some $c_0^+ \in S^{-\infty,-\infty}$ supported in $\Gamma^+(R^{1/4}, I_4, \sigma_4) \cap \{|x| < R^{1/3}\}$ without loss of generality. Then, since $|x| < R^{1/3}$ on $\operatorname{supp} c_0^+$ and $|x| > R^{1/2}$ on $\operatorname{supp} d^+$, the same argument as that in the proof of (3.36) shows

$$\|J_h^+(c_0^+)e^{ith\Delta}J_h^+(d^+)^*\| \lesssim h^M \langle t \rangle^{-M}$$

for all $M \ge 0$ uniformly in $t \ge 0$, which completes the proof of (3.41).

In order to prove (3.42), by a similar argument as above, it suffices to show that

$$\|\operatorname{Op}_{h}(\chi^{-})^{*}\varphi(H_{h})J_{h}^{+}(c^{+})e^{ith\Delta}J_{h}^{+}(d^{+})^{*}\langle x\rangle^{M}\| \lesssim h^{M}\langle t\rangle^{-M},$$
(3.46)

$$\|\operatorname{Op}_{h}(\chi^{-})^{*}\varphi(H_{h})Q_{j}(t,h)\langle x\rangle^{M}\| \lesssim h^{M}\langle t\rangle^{-M}.$$
(3.47)

Using (3.40) with $b^- = \chi^-$, we see that

$$\|\operatorname{Op}_{h}(\chi^{-})^{*}\varphi(H_{h})e^{-itH_{h}/h}\langle x\rangle^{-N}\| = \|\langle x\rangle^{-N}\varphi(H_{h})e^{itH_{h}/h}\operatorname{Op}_{h}(\chi^{-})\| \lesssim h^{-n}\langle t\rangle^{N/8}$$

for $-t \leq 0$, that is $t \geq 0$. This bound, together with (3.35), (3.36) and (3.44), implies (3.47). To deal with the main term, we recall that d^+ is supported in $\Gamma^+(R^{1/2}, I_2, \sigma_2)$, where one can choose σ_2 sufficiently close to σ so that $\sigma < \sigma_2 < \tilde{\sigma}$. Then (3.46) can be verified by essentially the same argument as above, as follows. At first, by means of Proposition 2.13 and (3.29), we may replace without loss of generality $\operatorname{Op}_h(\chi^-)^* \varphi(H_h) J_h^+(c^+)$ by $J_h^+(\tilde{\chi}^-)$ with some $\tilde{\chi}^- \in S^{0,-\infty}$ supported in $\operatorname{supp} \chi^-$. Next, by means of Lemma 3.13 (1), we have the following property

$$\cos(x,\xi) < -\widetilde{\sigma} < -\sigma_2 < \cos(y+2t\xi,\xi)$$

for all $t \ge 0$ on the support of the amplitude of $J_h^+(\tilde{\chi}^-)e^{ith\Delta}J_h^+(d^+)^*\langle x \rangle^M$. By virtue of Lemma 3.13 (2), this support property implies $|x - y - 2t\xi| \ge |x| + |y| + t$ for all $t \ge 0$. Then the same argument as that in the proof of Proposition 3.12 yields

$$\|J_h^+(\widetilde{\chi}^-)e^{ith\Delta}J_h^+(d^+)^*\langle x\rangle^M\| \lesssim h^M\langle t\rangle^{-M}, \quad t \ge 0,$$

for all $M \ge 0$, which completes the proof.

We are now ready to show Theorem 3.7.

Proof of Theorem 3.7. Let $t \leq 0$. As before, by means of Proposition 3.10 we decompose the operator $\operatorname{Op}_h(b^+)^* \varphi(H_h) e^{-itH_h/h} \operatorname{Op}_h(a^+)$ into five parts

$$U_0(t) := \operatorname{Op}_h(a^+)^* \varphi(H_h) J_h^+(c^+) e^{ith\Delta} J_h^+(d^+)^*, U_i(t) := \operatorname{Op}_h(a^+)^* \varphi(H_h) Q_i^+(t,h), \quad 1 \le j \le 4.$$

To deal with the main term $U_0(t)$, thanks to Proposition 3.11, it is enough to check that $\operatorname{Op}_h(a^+)^*\varphi(H_h)$ is bounded on L^∞ uniformly in h. To this end, taking into account the fact that $\operatorname{Op}_h(a^+) = \operatorname{Op}_h(a^+)^*\rho(x/R)$ with some $\rho \in C_0^\infty$ supported away from the origin, we use Proposition 2.13 to write $\rho(x/R)\varphi(H_h) = \operatorname{Op}_h(b_h)^* + Q_h$ with some $b_h \in S^{0,-\infty}$ and Q_h satisfying $\|Q_h\langle x\rangle^N\| \leq h^N$ for N > n/2. Then $\|\operatorname{Op}_h(a^+)^*\operatorname{Op}_h(b_h)^*\|_{\infty \to \infty} \leq 1$ by (2.2). Moreover, (2.2) and the embedding $L^\infty(\mathbb{R}^n) \subset \langle x\rangle^N L^2(\mathbb{R}^n)$ show that

$$\|\operatorname{Op}_{h}(a^{+})^{*}Q_{h}f\|_{\infty} \leq \|\operatorname{Op}_{h}(a^{+})^{*}\|_{2\to\infty}\|Q_{h}\langle x\rangle^{N}\|\|\langle x\rangle^{-N}f\|_{L^{2}} \lesssim h^{N-n/2}\|f\|_{\infty} \lesssim \|f\|_{\infty}.$$

To deal with $U_1(t)$, we take $N \ge 4n$ and use (2.2), the dual estimate of (3.40) to see that

$$\begin{aligned} \|U_1(t)^*f\|_{\infty} &\lesssim h^{N-n/2} \|\operatorname{Op}_h(a^+)^*\varphi(H_h)e^{-itH_h/h}\operatorname{Op}_h(r_1^+)f\|_2\\ &\lesssim h^{N-n}\langle t\rangle^{-N/8} \|\langle x\rangle^N\operatorname{Op}_h(r_1^+)f\|_2\\ &\lesssim \langle t\rangle^{-n/2} \|f\|_1. \end{aligned}$$

To deal with $U_2(t)$ which is of the form

$$-ih^{N-1} \int_0^t \operatorname{Op}_h(a^+)^* \varphi(H_h) e^{-i(t-s)H_h/h} J_h^+(r_2^+) e^{ish\Delta} J_h^+(d^+)^* ds$$

we also use the dual estimate of (3.40), Proposition 3.12 and Sobolev's embedding to see that

$$\| \operatorname{Op}_{h}(a^{+})^{*} \varphi(H_{h}) e^{-i(t-s)H_{h}/h} \langle x \rangle^{-N} \|_{\infty \to \infty} \lesssim h^{-3n/2-1} \langle t-s \rangle^{-N/8}, \\ \| \langle x \rangle^{N} J_{h}^{+}(r_{2}^{+}) e^{ish\Delta} J_{h}^{+}(d^{+})^{*} \|_{1 \to \infty} \lesssim \min\{h^{-n}, |sh|^{-n/2}\}$$

for $t \leq s$. Thus, choosing $N \geq 4n + 2$ large enough, we obtain

$$\|U_2(t)\|_{1\to\infty} \lesssim h^{N-3n/2-2} \left| \int_0^t \langle t-s \rangle^{-n} \min\{h^{-n}, |sh|^{-n/2}\} ds \right| \lesssim \min\{h^{-n}, |th|^{-n/2}\}, \quad t \le 0.$$

Taking the embedding $\langle x \rangle^{-n/2-\varepsilon} L^{\infty}(\mathbb{R}^n) \subset L^2(\mathbb{R}^n)$ into account, by using the dual estimates of (3.41) and (3.42) instead of (3.40), one can also obtain for $b = \tilde{e}_{\rm com}$ or \tilde{e}^+ that

$$\|\operatorname{Op}_{h}(a^{+})^{*}\varphi(H_{h})e^{-i(t-s)H_{h}/h}\operatorname{Op}_{h}(b)\|_{\infty\to\infty} \lesssim h^{M}\langle t-s\rangle^{-M}, \quad t \leq s,$$

which, together with (3.33), implies the desired bounds for the terms $U_3(t)$ and $U_4(t)$.

By Theorem 3.7 and the TT^* - argument, we have obtained (3.24) for $0 < \lambda \leq 1$ which, combined with Proposition 3.3, concludes the proof of (3.7) for $0 < \lambda \leq 1$.

3.2 The high energy case

The proof of the high energy estimate (3.6) basically follows the same line as that of (3.24). Note however that we do not have to decompose a^{λ} into the compact and non-compact parts in contrast to the low energy case since, for $R \geq 1$ large enough, a^{λ} is supported in the region

$$\{(x,\xi) \in \mathbb{R}^{2n} \mid |x| > R, \ |\xi|^2 \in I\}$$

with some interval $I \subseteq (0, \infty)$.

As in the low energy case, decomposing a^{λ} as $a^{\lambda} = a_{+} + a_{-}$ with some $a_{\pm} \in S^{0,-\infty}$ supported in $\Gamma^{\pm}(R, I, 1/2)$, we see that (3.6) is deduced from the following dispersive estimate

$$\|\operatorname{Op}(a_{\pm})^*\varphi(H^{\lambda})e^{-itH^{\lambda}}\operatorname{Op}(a_{\pm})\|_{1\to\infty} \lesssim |t|^{-n/2}, \quad t\neq 0, \ \lambda \ge 1.$$
(3.48)

In what follows, we summarize several propositions from which (3.48) follows as in the low energy case. The proofs of these propositions are essentially same as those of the corresponding propositions in the low energy case. Indeed, by using Lemma 2.11, Propositions 2.12 and 2.18, instead of Propositions 2.13 and 2.17, all the propositions can be obtained by simply adapting the proof of the low energy case with, firstly, replacing V_h by V^{λ} and, then, taking h = 1.

Proposition 3.15 (IK parametrix). Let $I_1 \in I_2 \in I_3 \in I_4 \in (0, \infty)$ be relatively compact open intervals and $-1 < \sigma_1 < \sigma_2 < \sigma_3 < \sigma_4 < 1$. Then there exists a large constant $R_{\text{IK}} \geq 1$ such that, for all $R \geq R_{\text{IK}}^4$, the following statements are satisfied:

• There exist $\{S^{\lambda}_{+}\}_{\lambda>1} \subset C^{\infty}(\mathbb{R}^{2}n;\mathbb{R})$ such that

$$\begin{aligned} |\partial_x^{\alpha} \partial_{\xi}^{\beta} (S_{\pm}^{\lambda}(x,\xi) - x \cdot \xi| &\leq C_{\alpha\beta} \langle x \rangle^{1-\mu-|\alpha|}, \\ |\partial_x^{\alpha} \partial_{\xi}^{\beta} (S_{\pm}^{\lambda}(x,\xi) - x \cdot \xi| &\leq C_{\alpha\beta} \min\{\langle x \rangle^{1-\mu-|\alpha|}, R^{1-\mu-|\alpha|}\}, \quad |\alpha| \geq 1, \end{aligned}$$

uniformly in $\lambda \geq 1$, and that

$$|\nabla_x S^{\lambda}_{\pm}(x,\xi)|^2 + V_h(x) = |\xi|^2, \quad (x,\xi) \in \Gamma^{\pm}(R^{1/4}, I_4, \sigma_4).$$

 \Box

• For any $a_{\pm} \in S^{0,-\infty}$ supported in $\Gamma^{\pm}(R, I_1, \sigma_1)$ and any $N \ge 0$, we have

$$e^{-itH^{\lambda}} \operatorname{Op}(a_{\pm}) = J_{\pm}^{\lambda}(c_{\pm})e^{it\Delta}J_{\pm}^{\lambda}(d_{\pm})^{*} + \sum_{j=1}^{4} Q_{j,\pm}(t,\lambda),$$

where the remainder terms $Q_{j,\pm}$, $1 \leq j \leq 4$, are given by

$$Q_{1,\pm}(t,\lambda) = e^{-itH^{\lambda}} \operatorname{Op}(r_{1,\pm}),$$

$$Q_{2,\pm}(t,\lambda) = -i \int_{0}^{t} e^{-i(t-s)H^{\lambda}} J_{\pm}^{\lambda}(r_{2,\pm}) e^{is\Delta} J_{\pm}^{\lambda}(d_{\pm})^{*} ds,$$

$$Q_{3,\pm}(t,\lambda) = -i \int_{0}^{t} e^{-i(t-s)H^{\lambda}} \operatorname{Op}(\tilde{e}_{\pm}^{\operatorname{com}}) J_{\pm}^{\lambda}(e_{\pm}^{\operatorname{com}}) e^{is\Delta} J_{\pm}^{\lambda}(d_{\pm})^{*} ds,$$

$$Q_{4,\pm}(t,\lambda) = -i \int_{0}^{t} e^{-i(t-s)H^{\lambda}} \operatorname{Op}(\tilde{e}_{\pm}) J_{\pm}^{\lambda}(e_{\pm}) e^{is\Delta} J_{\pm}^{\lambda}(d_{\pm})^{*} ds$$

and the amplitudes satisfy the following properties:

- $-c_{\pm}, d_{\pm}, e_{\pm}, \widetilde{e}_{\pm} \in S^{0, -\infty}, r_{1,\pm}, r_{2,\pm} \in S^{-N, \infty} \text{ and } e_{\pm}^{\operatorname{com}} \in C_0^{\infty}(\mathbb{R}^{2n});$
- $\operatorname{supp} c_{\pm} \subset \Gamma^{\pm}(R^{1/3}, I_3, \sigma_3), \operatorname{supp} d_{\pm} \subset \Gamma^{\pm}(R^{1/2}, I_2, \sigma_2);$
- $\operatorname{supp} e_{+}^{\operatorname{com}}, \operatorname{supp} \widetilde{e}_{+}^{\operatorname{com}} \subset \Gamma^{\pm}(R^{1/4}, I_4, \sigma_4) \cap \{|x| \leq R^{4/9}\};$
- $\operatorname{supp} e_{\pm}, \operatorname{supp} \widetilde{e}_{\pm} \subset \Gamma^{\pm}(R^{1/4}, I_4, \sigma_4) \cap \Gamma^{\mp}(R^{1/4}, I_4, -\widetilde{\sigma}) \text{ with some } \widetilde{\sigma} \in (\sigma_2, \sigma_3).$

Here $J^{\lambda}_{\pm}(a)$ denotes the FIO with the phase function S^{λ}_{\pm} and the amplitude a, namely

$$J^{\lambda}_{\pm}(a)f(x) = \frac{1}{(2\pi)^n} \iint e^{i(S^{\lambda}_{\pm}(x,\xi) - y \cdot \xi)} a(x,\xi)f(y) dy d\xi$$

Proposition 3.16. Let $I \in (0, \infty)$ be a relatively compact interval. For sufficiently large $R \ge R_{\text{IK}}$ and any symbols $a, b \in S^{0,-\infty}$ satisfying $|\xi|^2 \in I$ on supp a and on supp b, we have

$$\|J_{\pm}^{\lambda}(a)e^{it\Delta}J_{\pm}^{\lambda}(b)^{*}\|_{1\to\infty} \lesssim |t|^{-n/2}, \quad t\neq 0, \ \lambda\geq 1.$$

Proposition 3.17. Let d_{\pm} , $r_{2,\pm}$, e_{\pm}^{com} and e_{\pm} be as above. Then for all $s \in \mathbb{R}$ and large $N \ge 1$,

$$\|\langle D\rangle^s \langle x\rangle^{N/4} J_{\pm}^{\lambda}(r_{2,\pm}) e^{it\Delta} J_{\pm}^{\lambda}(d_{\pm})^* \langle x\rangle^{N/8} \langle D\rangle^s \| \lesssim \langle t\rangle^{-N/8}$$

uniformly in $\pm t \ge 0$ and $\lambda \ge 1$. Moreover, for any $M \ge 0$ and $s \in \mathbb{R}$,

$$\|\langle D\rangle^s \langle x\rangle^M J^{\lambda}_{\pm}(\chi_{\pm}) e^{it\Delta} J^{\lambda}_{\pm}(d_{\pm})^* \langle x\rangle^M \langle D\rangle^s \| \lesssim \langle t\rangle^{-M},$$

uniformly in $\pm t \ge 0$ and $\lambda \ge 1$, where $\chi_{\pm} = e_{\pm}^{\text{com}}$ or e_{\pm} .

Proposition 3.18. Let $R \ge 1$ be large enough and $b_{\pm} \in S^{0,-\infty}$ supported in $\Gamma^{\pm}(R, I, \sigma)$. Then the following statements are satisfied with constants independent of t and $\lambda \ge 1$.

• For sufficiently large integer N and all $s \ge 0$,

$$\|\langle x \rangle^{-N} \varphi(H^{\lambda}) e^{-itH^{\lambda}} \operatorname{Op}(b_{\pm}) \langle D \rangle^{s} \| \lesssim \langle t \rangle^{-N/8}, \quad \pm t \ge 0.$$

• For any $\chi \in C_0^{\infty}(\mathbb{R}^n)$ supported in a unit ball $\{|x| < 1\}$ and all $M, s \ge 0$,

$$\|\chi(x/R^{1/3})\varphi(H^{\lambda})e^{-itH^{\lambda}}\operatorname{Op}(b_{\pm})\langle D\rangle^{s}\| \lesssim \langle t\rangle^{-M}, \quad \pm t \ge 0$$

• If $\chi_{\mp} \in S^{0,-\infty}$ is supported in $\Gamma^{\mp}(R^{1/4}, I_4, -\widetilde{\sigma})$ with some $\widetilde{\sigma} > \sigma$, then for all $M, s \ge 0$

$$\|\langle D \rangle^s \operatorname{Op}(\chi_{\mp})^* \varphi(H^{\lambda}) e^{-itH^{\lambda}} \operatorname{Op}(b_{\pm}) \langle x \rangle^M \langle D \rangle^s \| \lesssim \langle t \rangle^{-M}, \quad \pm t \ge 0.$$

4 Inhomogeneous estimates

This section is devoted to the proof of the inhomogeneous estimate (2.23). As in case of homogeneous estimates, the proof for the high energy case is almost identical to that for the low energy case. We thus may assume $\lambda \leq 1$. Since the non-endpoint inhomogeneous estimates follow from the homogeneous estimates and Christ-Kiselev's lemma [10], we also may assume $n \geq 3$ and $(p,q) = (\tilde{p}, \tilde{q}) = (2, 2^*)$. By duality, (2.23) is a consequence of the sesquilinear estimate

$$\left| \int_{\mathbb{R}} \int_{0}^{t} \langle \varphi^{\lambda}(H) e^{-i(t-s)H} F(s), G(t) \rangle ds dt \right| \lesssim \|F\|_{L^{2}_{t}L^{2*}_{x}} \|G\|_{L^{2}_{t}L^{2*}_{x}}.$$
(4.1)

On the other hand, we have already proved the homogeneous endpoint estimate (2.22), which implies (4.1) with the time interval [0, t] replaced by $I = [0, \infty), (-\infty, 0]$ or \mathbb{R} . Therefore, (4.1) is deduced from the retarded estimate

$$\left| \iint_{s < t} \langle \varphi^{\lambda}(H) e^{-i(t-s)H} F(s), G(t) \rangle ds dt \right| \lesssim \|F\|_{L^{2}_{t}L^{2*}_{x}} \|G\|_{L^{2}_{t}L^{2*}_{x}}.$$
(4.2)

In what follows the notation in the previous section will be used. We then write $\varphi^{\lambda}(H)e^{-itH}$ as

$$\varphi^{\lambda}(H)e^{-itH} = \widetilde{\varphi}^{\lambda}(H)^{2}\varphi^{\lambda}(H)e^{-itH}(\widetilde{\varphi}^{\lambda}(H)^{*})^{2}$$
$$= \widetilde{\varphi}^{\lambda}(H)\Big(\mathcal{D}_{\mu}\operatorname{Op}_{h}(a_{h})^{*}\mathcal{D}_{\mu}^{*} + R^{\lambda}\Big)\varphi^{\lambda}(H)e^{-itH}\Big(\mathcal{D}_{\mu}\operatorname{Op}_{h}(a_{h})\mathcal{D}_{\mu}^{*} + (R^{\lambda})^{*}\Big)\widetilde{\varphi}^{\lambda}(H).$$

 a_h is further decomposed as $a_h = a^+ + a^- + a^{\text{com}}$, where $a^{\pm}, a^{\text{com}} \in S^{-0,-\infty}$, $\operatorname{supp} a^{\pm} \subset \Gamma^{\pm}(R, I, 1/2)$ and $\operatorname{supp} a^{\text{com}} \subset \{|x| < 2R, |\xi| \le c_1\}$ with some $R \gg 1$, $I \in (0, \infty)$ and $c_1 > 0$ being independent of h. Then $\varphi^{\lambda}(H)e^{-itH}$ is a sum of operators

$$\begin{split} Y_{1}^{\pm}(t) &= \tilde{\varphi}^{\lambda}(H) \mathcal{D}_{\mu} \operatorname{Op}_{h}(a^{\pm})^{*} \mathcal{D}_{\mu}^{*} \varphi^{\lambda}(H) e^{-itH} \mathcal{D}_{\mu} \operatorname{Op}_{h}(a^{\pm}) \mathcal{D}_{\mu}^{*} \tilde{\varphi}^{\lambda}(H), \\ Y_{2}(t) &= \tilde{\varphi}^{\lambda}(H) \mathcal{D}_{\mu} \operatorname{Op}_{h}(a^{\operatorname{com}})^{*} \mathcal{D}_{\mu}^{*} \varphi^{\lambda}(H) e^{-itH} \mathcal{D}_{\mu} \operatorname{Op}_{h}(a^{\operatorname{com}}) \mathcal{D}_{\mu}^{*} \tilde{\varphi}^{\lambda}(H), \\ Y_{3}(t) &= \tilde{\varphi}^{\lambda}(H) \mathcal{R}^{\lambda} \varphi^{\lambda}(H) e^{-itH} (\mathcal{R}^{\lambda})^{*} \tilde{\varphi}^{\lambda}(H), \\ Z_{1}^{\pm}(t) &= \tilde{\varphi}^{\lambda}(H) \mathcal{D}_{\mu} \operatorname{Op}_{h}(a^{\mp})^{*} \mathcal{D}_{\mu}^{*} \varphi^{\lambda}(H) e^{-itH} \mathcal{D}_{\mu} \operatorname{Op}_{h}(a^{\pm}) \mathcal{D}_{\mu}^{*} \tilde{\varphi}^{\lambda}(H), \\ Z_{2}^{\pm}(t) &= \tilde{\varphi}^{\lambda}(H) \mathcal{D}_{\mu} \operatorname{Op}_{h}(a^{\operatorname{com}})^{*} \mathcal{D}_{\mu}^{*} \varphi^{\lambda}(H) e^{-itH} \mathcal{D}_{\mu} \operatorname{Op}_{h}(a^{\pm}) \mathcal{D}_{\mu}^{*} \tilde{\varphi}^{\lambda}(H), \\ Z_{3}^{\pm}(t) &= Z_{2}^{\pm}(-t)^{*} &= \tilde{\varphi}^{\lambda}(H) \mathcal{D}_{\mu} \operatorname{Op}_{h}(a^{\pm})^{*} \mathcal{D}_{\mu}^{*} \varphi^{\lambda}(H) e^{-itH} \mathcal{D}_{\mu} \operatorname{Op}_{h}(a^{\operatorname{com}}) \mathcal{D}_{\mu}^{*} \tilde{\varphi}^{\lambda}(H), \\ Z_{4}^{\pm}(t) &= \tilde{\varphi}^{\lambda}(H) \mathcal{R}^{\lambda} \varphi^{\lambda}(H) e^{-itH} \mathcal{D}_{\mu} \operatorname{Op}_{h}(a^{\pm}) \mathcal{D}_{\mu}^{*} \tilde{\varphi}^{\lambda}(H), \\ Z_{5}^{\pm}(t) &= Z_{4}^{\pm}(-t)^{*} &= \tilde{\varphi}^{\lambda}(H) \mathcal{D}_{\mu} \operatorname{Op}_{h}(a^{\pm})^{*} \mathcal{D}_{\mu}^{*} \varphi^{\lambda}(H) e^{-itH} (\mathcal{R}^{\lambda})^{*} \tilde{\varphi}^{\lambda}(H), \\ Z_{6}(t) &= \tilde{\varphi}^{\lambda}(H) \mathcal{D}_{\mu} \operatorname{Op}_{h}(a^{\operatorname{com}})^{*} \mathcal{D}_{\mu}^{*} \varphi^{\lambda}(H) e^{-itH} (\mathcal{R}^{\lambda})^{*} \tilde{\varphi}^{\lambda}(H), \\ Z_{7}(t) &= Z_{6}(-t)^{*} &= \tilde{\varphi}^{\lambda}(H) \mathcal{R}^{\lambda} \varphi^{\lambda}(H) e^{-itH} \mathcal{D}_{\mu} \operatorname{Op}_{h}(a^{\operatorname{com}}) \mathcal{D}_{\mu}^{*} \tilde{\varphi}^{\lambda}(H), \end{split}$$

where Y_j, Y_j^{\pm} (resp. Z_j, Z_j^{\pm}) correspond to the diagonal (resp. off-diagonal) terms. To prove (4.2), it is sufficient to show

$$\left| \iint_{s < t} \langle W(t - s)F(s), G(t) \rangle ds dt \right| \lesssim \|F\|_{L^2_t L^{2*}_x} \|G\|_{L^2_t L^{2*}_x}$$
(4.3)

for all $W \in \{Y_1^{\pm}, Y_2, Y_3, Z_1^{\pm}, ..., Z_5^{\pm}, Z_6, Z_7\}$. Before starting its proof, we make a small but useful remark.

Remark 4.1. Since $\mathcal{D}^*_{\mu} = \mathcal{D}(\lambda^{-\mu/2})$ and $R^{\lambda} = \varphi^{\lambda}(H) - \mathcal{D}\operatorname{Op}(a^{\lambda})^*\mathcal{D}$, by (2.2) and (2.5) and Lemma 2.6, all of operators $\tilde{\varphi}^{\lambda}(H), \mathcal{D}_{\mu}\operatorname{Op}_{h}(a^{\pm})^*\mathcal{D}^*_{\mu}, \mathcal{D}_{\mu}\operatorname{Op}_{h}(a^{\operatorname{com}})^*\mathcal{D}^*_{\mu}, R^{\lambda}$ and their adjoints are bounded on L^{2*} uniformly in $h = \lambda^{2/\mu-1} \in (0, 1]$. Hence (2.22) implies

$$\left| \iint \langle W(t-s)F(s), G(t) \rangle ds dt \right| \lesssim \|F\|_{L^2_t L^{2*}_x} \|G\|_{L^2_t L^2_x}$$

for all $W \in \{Y_1^{\pm}, Y_2, Y_3, Z_1^{\pm}, ..., Z_5^{\pm}, Z_6, Z_7\}$. Therefore, (4.3) is equivalent to

$$\left| \iint_{s>t} \langle W(t-s)F(s), G(t)\rangle ds dt \right| \lesssim \|F\|_{L^2_t L^{2*}_x} \|G\|_{L^2_t L^{2*}_x}.$$
(4.4)

In particular, for each $W \in \{Y_1^{\pm}, Y_2, Y_3, Z_1^{\pm}, ..., Z_5^{\pm}, Z_6, Z_7\}$, one can fix the sign of t-s for which W(t-s) behaves better than the case when t-s has the opposite sign. Such an observation was previously pointed out by Hassell-Zhang [19].

With this remark at hand, one sees that (4.3) follows from the following Lemmas 4.2–4.7. By density, we may assume $F, G \in \mathcal{S}(\mathbb{R} \times \mathbb{R}^n)$ in the sequel.

Lemma 4.2. Let $W = Y_1^{\pm}$. Then (4.3) holds.

Proof. Using a similar argument as in the previous section based on (2.5) and the change of variable $t \mapsto \lambda^2 h^{-1} t$, (4.3) with $W = Y_1^{\pm}$ is equivalent to

$$\begin{split} & \left| \iint_{s < t} \langle \operatorname{Op}_h(a^{\pm})^* \varphi(H_h) e^{-i(t-s)H_h/h} \operatorname{Op}_h(a^{\pm}) \widetilde{\varphi}(H_h) F(s), \widetilde{\varphi}(H_h) G(t) \rangle ds dt \right| \\ & \lesssim h^{-1} \|F\|_{L^2_t L^{2*}_x} \|G\|_{L^2_t L^{2*}_x} \end{split}$$

which, by virtue of the TT^* -argument by Keel-Tao [27] and the fact that $\tilde{\varphi}(H_h)$ is bounded on L^{2*} uniformly in h, follows from (3.26).

For $W = Y_2$ and Y_3 , we consider the original estimate (4.1).

Lemma 4.3. We have

$$\left\| \int_0^t Y_2(t-s)F(s)ds \right\|_{L^2_t L^{2*}_x} \lesssim \|F\|_{L^2_t L^{2*}_x}.$$

Proof. By the same scaling considerations as in Lemma 4.2, it suffices to show

$$\left\| \int_0^t \operatorname{Op}_h(a^{\operatorname{com}})^* \varphi(H_h) e^{-i(t-s)H_h/h} \operatorname{Op}_h(a^{\operatorname{com}}) F(s) ds \right\|_{L^2_t L^{2*}_x} \lesssim h^{-1} \|F\|_{L^2_t L^{2*}_x}.$$
(4.5)

To this end, we shall first show the following estimate

$$\left\| \int_{0}^{t} \operatorname{Op}_{h}(a^{\operatorname{com}})^{*} \varphi(H_{h}) e^{-i(t-s)H_{h}/h} F(s) ds \right\|_{L_{t}^{2} L_{x}^{2^{*}}} \lesssim h^{-1/2} \|\langle x \rangle F\|_{L_{t}^{2} L_{x}^{2}}.$$
(4.6)

Set

$$u(t) = -i \int_0^t \varphi(H_h) e^{-i(t-s)H_h/h} F(s) ds.$$

Choosing $\tilde{a}^{\text{com}} \in C_0^{\infty}(\mathbb{R}^{2n})$ satisfying $\tilde{a}^{\text{com}} \equiv 1$ on $\operatorname{supp} a^{\text{com}}$, we know by Proposition 2.1 that

$$\operatorname{Op}_h(a^{\operatorname{com}})^* u = \operatorname{Op}_h(\widetilde{a}^{\operatorname{com}}) \operatorname{Op}_h(a^{\operatorname{com}})^* u + h^N \operatorname{Op}_h(r) u$$

with some $r \in S^{-N,-\infty}$ and $N \gg 1$. For the remainder, (2.2) and (2.38) imply

$$\|h^{N} \operatorname{Op}_{h}(r)u\|_{L^{2}_{t}L^{2*}_{x}} \lesssim h^{N} \|\operatorname{Op}_{h}(r)\langle x\rangle\|_{2\to 2^{*}} \|\langle x\rangle^{-1}u\|_{L^{2}_{t}L^{2}_{x}}$$

$$\lesssim \|\langle x\rangle F\|_{L^{2}_{t}L^{2}_{x}}$$

$$(4.7)$$

Let $\theta_i, \tilde{\theta}_i$ be as that in the proof of Proposition 3.3. To deal with the main term, we consider

$$v_j(t) = \theta_j(t) \operatorname{Op}_h(a^{\operatorname{com}})^* u(t)$$

which satisfies the Cauchy problem

$$i\partial_t v_j(t) = h^{-1} H_h v_j(t) + G_j(t); \quad v_j(0) = 0,$$

and thus Duhamel's formula

$$v_j(t) = -i \int_0^t e^{-i(t-s)H_h/h} G_j(s) ds$$

where $G_j = i\theta'_j \operatorname{Op}_h(a^{\operatorname{com}})^* u + h^{-1}\theta_j [\operatorname{Op}_h(a^{\operatorname{com}})^*, H_h] u + i\theta_j \operatorname{Op}_h(a^{\operatorname{com}})^* \varphi(H_h) F$. Therefore, since $\tilde{\theta}_j \theta_j = \theta_j$, $\operatorname{Op}_h(\tilde{a}^{\operatorname{com}}) v_j(t)$ is a linear combination of

$$w_{1,j}(t) = \tilde{\theta}_j(t) \operatorname{Op}_h(\tilde{a}^{\operatorname{com}}) \int_0^t e^{-i(t-s)H_h/h} \theta'_j(s) \operatorname{Op}_h(a^{\operatorname{com}})^* u(s) ds,$$

$$w_{2,j}(t) = \tilde{\theta}_j(t) \operatorname{Op}_h(\tilde{a}^{\operatorname{com}}) \int_0^t e^{-i(t-s)H_h/h} \theta_j(s) h^{-1}[\operatorname{Op}_h(a^{\operatorname{com}})^*, H_h] u(s) ds,$$

$$w_{3,j}(t) = \tilde{\theta}_j(t) \operatorname{Op}_h(\tilde{a}^{\operatorname{com}}) \int_0^t e^{-i(t-s)H_h/h} \theta_j(s) \operatorname{Op}_h(a^{\operatorname{com}})^* \varphi(H_h) F(s) ds.$$

Let us set

$$\widetilde{w}_{1,j}(t) = \widetilde{\theta}_j(t) \operatorname{Op}_h(\widetilde{a}^{\operatorname{com}}) \int_0^\infty e^{-i(t-s)H_h/h} \theta'_j(s) \operatorname{Op}_h(a^{\operatorname{com}})^* u(s) ds.$$

Since $|\operatorname{supp} \theta_j| \ll 1$, we apply (3.9) to the operator $\tilde{\theta}_j(t) \operatorname{Op}_h(\tilde{a}^{\operatorname{com}}) e^{-itH_h/h}$ yielding

$$\|\widetilde{w}_{1,j}\|_{L^2_t L^{2*}_x} \lesssim h^{-1/2} \|\theta'_j(s) \operatorname{Op}_h(a^{\operatorname{com}})^* u\|_{L^1_t L^2_x}$$
(4.8)

Since the exponents of Lebesgue norms with respect to t of the left and right hand sides in (4.8) are different from each other, Christ-Kiselev's lemma can be applied to see that $w_{1,j}$ also satisfies the same estimate as (4.8). Therefore, we have

$$\begin{split} \|w_{1,j}\|_{L^{2}_{t}L^{2*}_{x}} &\lesssim h^{-1/2} \|\theta'_{j} \operatorname{Op}_{h}(a^{\operatorname{com}})^{*}u\|_{L^{1}_{t}L^{2}_{x}} \\ &\lesssim h^{-1/2} \|\theta'_{j} \operatorname{Op}_{h}(a^{\operatorname{com}})^{*}u\|_{L^{2}_{t}L^{2}_{x}} \\ &\lesssim h^{-1/2} \|\operatorname{Op}_{h}(a^{\operatorname{com}})^{*}\langle x \rangle \|\|\theta'_{j}\langle x \rangle^{-1}u\|_{L^{2}_{t}L^{2}_{x}} \\ &\lesssim h^{-1/2} \|\theta'_{j}\langle x \rangle^{-1}u\|_{L^{2}_{t}L^{2}_{x}} \end{split}$$

uniformly in $j \in \mathbb{Z}$ and $h \in (0, 1]$, where we have used Hölder's inequality and the uniform bound $|\operatorname{supp} \theta'_j| \leq 1$ with respect to j in the second line.

Similarly, we have

$$\|w_{3,j}\|_{L^2_t L^{2^*}_x} \lesssim h^{-1/2} \|\theta_j F\|_{L^2_t L^2_x}$$

For $w_{2,j}$, we find by the same argument that

$$\|w_{2,j}\|_{L^2_t L^{2^*}_x} \lesssim h^{-3/2} \|[\operatorname{Op}_h(a^{\operatorname{com}})^*, H_h] \theta_j u\|_{L^2_t L^2_x} \lesssim h^{-1/2} \|\theta_j \langle x \rangle^{-1} u\|_{L^2_t L^2_x},$$

where we have used (3.19) with sufficiently large $N = N(\mu) \in \mathbb{N}$ in the last line. These bounds for $w_{k,j}$, the almost orthogonality of $\{\theta_j\}_{j\in\mathbb{Z}}$ and (2.38) show that

$$\begin{split} \|\operatorname{Op}_{h}(\widetilde{a}^{\operatorname{com}})^{*}\operatorname{Op}_{h}(a^{\operatorname{com}})^{*}u\|_{L_{t}^{2}L_{x}^{2*}}^{2} \\ \lesssim h^{-1}\sum_{j\in\mathbb{Z}} \left(\|\theta_{j}\langle x\rangle^{-1}u\|_{L_{t}^{2}L_{x}^{2}}^{2} + \|\theta_{j}'\langle x\rangle^{-1}u\|_{L_{t}^{2}L_{x}^{2}}^{2} + \|\theta_{j}F\|_{L_{t}^{2}L_{x}^{2}}^{2} \right) \\ \lesssim h^{-1} \left(\|\langle x\rangle^{-1}u\|_{L_{t}^{2}L_{x}^{2}}^{2} + \|F\|_{L_{t}^{2}L_{x}^{2}}^{2} \right) \\ \lesssim h^{-1} \|\langle x\rangle F\|_{L_{t}^{2}L_{x}^{2}}^{2} \end{split}$$

which, together with (4.7), implies (4.6).

Next, we obtain by (4.6), duality and the change of variables $t\mapsto -t,s\mapsto -s$ that

$$\left\| \int_0^t \langle x \rangle^{-1} \varphi(H_h) e^{-i(t-s)H_h/h} \operatorname{Op}_h(a^{\operatorname{com}}) F(s) ds \right\|_{L^2_t L^2_x} \lesssim h^{-1/2} \|F\|_{L^2_t L^{2*}_x}.$$
(4.9)

Now we set

$$\widetilde{u}(t) = \int_0^t \varphi(H_h) e^{-i(t-s)H_h/h} \operatorname{Op}_h(a^{\operatorname{com}}) F(s) ds$$

Then, by repeating the same argument as above with (4.9) instead of (2.38), we have

$$\begin{split} \|\operatorname{Op}_{h}(a^{\operatorname{com}})^{*}\widetilde{u}\|_{L_{t}^{2}L_{x}^{2}}^{2} \\ \lesssim h^{-1} \sum_{j \in \mathbb{Z}} \left(\|\theta_{j} \langle x \rangle^{-1} \widetilde{u}\|_{L_{t}^{2}L_{x}^{2}}^{2} + \|\theta_{j}' \langle x \rangle^{-1} \widetilde{u}\|_{L_{t}^{2}L_{x}^{2}}^{2} \right) + h^{-2} \sum_{j \in \mathbb{Z}} \|\theta_{j}F\|_{L_{t}^{2}L_{x}^{2}}^{2} \\ \lesssim h^{-1} \|\langle x \rangle^{-1} \widetilde{u}\|_{L_{t}^{2}L_{x}^{2}}^{2} + h^{-2} \|F\|_{L_{t}^{2}L_{x}^{2}}^{2} \\ \lesssim h^{-2} \|F\|_{L_{t}^{2}L_{x}^{2}}^{2}, \end{split}$$

which completes the proof of (4.5).

Lemma 4.4. We have

$$\left\| \int_0^t Y_3(t-s)F(s)ds \right\|_{L^2_t L^{2^*}_x} \lesssim \|F\|_{L^2_t L^{2^*}_x}.$$

Proof. It follows from the proof of Proposition 3.1 that

$$\|\widetilde{\varphi}^{\lambda}(H)R^{\lambda}\langle x\rangle\|_{2\to 2^*} + \|\langle x\rangle(R^{\lambda})^*\widetilde{\varphi}^{\lambda}(H)\|_{2_*\to 2} \lesssim 1$$

uniformly in $0 < \lambda \leq 1$. This bound allows us to deduce the desired estimate from (2.36).

Lemma 4.5. For $W = Z_1^+$ (resp. $W = Z_1^-$), (4.3) (resp. (4.4)) holds.

Proof. We shall consider the case $W = Z_1^+$ only, the proof for the other case being analogous. As in case of Y_1^+ , it suffices to show the following dispersive estimate

$$\|\operatorname{Op}_{h}(a^{-})^{*}\varphi(H_{h})e^{-itH_{h}/h}\operatorname{Op}_{h}(a^{+})\|_{1\to\infty} \lesssim |th|^{-n/2}, \quad t > 0.$$
(4.10)

By Proposition 3.10, we decompose the operator in (4.10) into five parts

$$Op_h(a^-)^*\varphi(H_h)J_h^+(c^+)e^{ith\Delta}J_h^+(d^+)^*, \quad Op_h(a^-)^*\varphi(H_h)Q_j^+(t,h), \quad 1 \le j \le 4.$$

The estimate for the main term follows from (3.33) as in the proof of Theorem 3.7. The desired estimate for the term

$$\operatorname{Op}_h(a^-)^*\varphi(H_h)Q_1^+(t,h) = h^N \operatorname{Op}_h(a^-)^*\varphi(H_h)e^{-itH_h/h} \operatorname{Op}_h(r_1^+)$$

follows from the dual estimate of the incoming case of (3.40) and (2.2). To deal with the term

$$Op_h(a^-)^*\varphi(H_h)Q_2^+(t,h) = -ih^{N-1} \int_0^t Op_h(a^-)^*\varphi(H_h)e^{-i(t-\tau)H_h/h} J_h^+(r_2^+)e^{i\tau h\Delta} J_h^+(d^+)^* d\tau,$$

we again use the dual estimate of the incoming case of (3.40) and also (3.35) to see that

$$\begin{aligned} \|\langle D\rangle^{s} \operatorname{Op}_{h}(a^{-})^{*}\varphi(H_{h})e^{-i(t-\tau)H_{h}/h}\langle x\rangle^{-N/4} \| &\lesssim h^{-n-s-1}\langle t-\tau\rangle^{-N/8} \\ \|\langle x\rangle^{N/4}J_{h}^{+}(r_{2}^{+})e^{i\tau h\Delta}J_{h}^{+}(d^{+})^{*}\langle D\rangle^{s} \| &\lesssim h^{-n-s}\langle \tau\rangle^{-N/8} \end{aligned}$$

for $0 \le \tau \le t$ and all $s \in \mathbb{R}$. Then, by using Sobolev's embedding and integrating over [0, t], we obtain the desired estimate provided that N is large enough. The term $\operatorname{Op}_h(a^-)^*\varphi(H_h)Q_3^+(t, h)$ can be dealt with similarly to the second term by using (3.42) instead of (3.40). Finally, to deal with the last term

$$Op_h(a^-)^* \varphi(H_h) Q_4^+(t,h) = -\frac{i}{h} \int_0^t Op_h(a^-)^* \varphi(H_h) e^{-i(t-\tau)H_h/h} Op_h(\tilde{e}^+) J_h^+(e^+) e^{i\tau h\Delta} J_h^+(d^+)^* d\tau,$$

taking into account the support property

supp
$$a^- \subset \Gamma^-(R, I, 1/2) \subset \Gamma^-(R^{1/4}, I_4, \sigma_4)$$
,
supp $e^+ \subset \Gamma^-(R^{1/4}, I_4, -\widetilde{\sigma}) \subset \Gamma^-(R^{1/4}, I_4, \sigma_4)$

. . .

since $1/2 < \tilde{\sigma} < \sigma_4$, we use the incoming case of Theorem 3.7 and (3.42) to obtain

$$\|\operatorname{Op}_{h}(a^{-})^{*}\varphi(H_{h})e^{-i(t-\tau)H_{h}/h}\operatorname{Op}_{h}(\tilde{e}^{+})\|_{1\to\infty} \lesssim \min\{h^{-n}, |(t-\tau)h|^{-n/2}\}, \\ \|J_{h}^{+}(e^{+})e^{i\tau h\Delta}J_{h}^{+}(d^{+})^{*}\|_{1\to1} \lesssim h^{M}\langle\tau\rangle^{-M}$$

for $0 \le \tau \le t$ and all M > 0. These two bounds imply the desired dispersive estimate for the last term and we complete the proof of (4.10).

Lemma 4.6. For $W = Z_6, Z_7$ we have

$$\left\| \int_0^t W(t-s)F(s)ds \right\|_{L^2_t L^{2*}_x} \lesssim \|F\|_{L^2_t L^{2*}_x}$$

Proof. We may prove the lemma for Z_7 only. Let

$$\widetilde{u}(t) = \int_0^t \varphi(H_h) e^{-i(t-s)H_h/h} \operatorname{Op}_h(a^{\operatorname{com}}) F(s) ds.$$

As before, by a scaling consideration, it is enough to show

$$\|\widetilde{\varphi}(H_h)R_h\widetilde{u}\|_{L^2_t L^{2*}_x} \lesssim h^{-1} \|F\|_{L^2_t L^{2*}_x}$$
(4.11)

uniformly in $h = \lambda^{2/\mu-1} \in (0, 1]$, where $R_h = \mathcal{D}_{\mu}^* R^{\lambda} \mathcal{D}_{\mu}$. The proof is similar to that of (4.5). At first note that $\|\langle x \rangle R_h^*\| \lesssim 1$ uniformly in $h \in (0, 1]$. Indeed, by (2.6), (2.26) and unitarity of \mathcal{D} and \mathcal{D}_{μ} , we have stronger bounds

$$\|\langle x\rangle^N R_h^*\| \le \|\langle h^{-1}x\rangle^N R_h^*\| = \|\langle x\rangle^N (Q^\lambda + \chi(x)\varphi(H^\lambda))\| \le C_N < \infty, \quad h \in (0,1],$$
(4.12)

for all $N \ge 0$. This bound and (4.6) imply

$$\left\| \int_{0}^{t} \operatorname{Op}_{h}(a^{\operatorname{com}})^{*} \varphi(H_{h}) e^{-i(t-s)H_{h}/h} R_{h}^{*} \widetilde{\varphi}(H_{h}) F(s) ds \right\|_{L_{t}^{2} L_{x}^{2^{*}}} \lesssim h^{-1/2} \|F\|_{L_{t}^{2} L_{x}^{2}}.$$
(4.13)

Then (4.9) and the dual estimate of (4.13) imply

$$\|\langle x \rangle^{-1} \widetilde{u}\|_{L^{2}_{t}L^{2}_{x}} + \|R_{h} \widetilde{u}\|_{L^{2}_{t}L^{2}_{x}} \lesssim h^{-1/2} \|F\|_{L^{2}_{t}L^{2*}_{x}}.$$
(4.14)

Using $\theta_j, \tilde{\theta}_j$ given in the proof of Lemma 4.3, we set $\tilde{v}_j = \theta_j R_h \tilde{u}$ which satisfies

$$\widetilde{v}_j = -i \int_0^t e^{-i(t-s)H_h/h} \widetilde{G}_j(s) ds$$

where $\widetilde{G}_j = i\theta'_j R_h \widetilde{u} + \theta_j h^{-1} [R_h, H_h] \widetilde{u} + i\theta_j R_h \varphi(H_h) \operatorname{Op}_h(a^{\operatorname{com}}) F(s)$. For the last term of \widetilde{G}_j , we know by Lemma 4.4 and the scaling argument as above that

$$\left\| \int_0^t \widetilde{\theta}_j \widetilde{\varphi}(H_h) R_h e^{-i(t-s)H_h/h} \theta_j R_h \varphi(H_h) \operatorname{Op}_h(a^{\operatorname{com}}) F(s) ds \right\|_{L^2_t L^{2*}_x} \lesssim h^{-1} \|\theta_j F\|_{L^2_t L^{2*}_x}.$$
(4.15)

To deal with the second term of G_i , we note that by definition of R_h ,

$$h^{-1}[R_h, H_h] = h^{-1}[\varphi(H_h) - \operatorname{Op}_h(a_h)^*, H_h] = -h^{-1}[\operatorname{Op}_h(a_h)^*, H_h].$$

Since $|x| \gtrsim 1$ on supp a_h (see (3.8)), it follows from the same proof as that for (3.19) that $h^{-1}[\operatorname{Op}_h(a_h)^*, H_h] = \operatorname{Op}(c_h)$ with some $c_h \in S^{-1,-\infty}$. Then, by the homogeneous Strichartz estimate (2.22), (4.15) and similar computations as in the proof of Lemma 4.3, we have

$$\|\widetilde{\theta}_{j}\widetilde{\varphi}(H_{h})R_{h}\widetilde{u}\|_{L_{t}^{2}L_{x}^{2^{*}}}^{2} \lesssim h^{-1}\|\theta_{j}'R_{h}\widetilde{u}\|_{L_{t}^{2}L_{x}^{2}} + h^{-1}\|\theta_{j}\langle x\rangle^{-1}\widetilde{u}\|_{L_{t}^{2}L_{x}^{2}} + h^{-2}\|\theta_{j}F\|_{L_{t}^{2}L_{x}^{2}}$$

which, together with (4.14) and the almost orthogonality of θ_j and θ_j , implies the desired bound (4.11). This completes the proof.

Lemma 4.7. For $W = Z_2^+, Z_3^-, Z_4^+, Z_5^-$ (resp. $W = Z_2^-, Z_3^+, Z_4^-, Z_5^+$), (4.3) (resp. (4.4)) holds.

Proof. By duality, it suffices to show the lemma for Z_2^+ and Z_4^+ . We first consider the case with Z_2^+ . As before, we may show

$$\iint_{s < t} \langle \widetilde{\varphi}(H_h) \operatorname{Op}_h(a^{\operatorname{com}})^* \varphi(H_h) e^{-i(t-s)H_h/h} \operatorname{Op}_h(a^+) \widetilde{\varphi}(H_h) F(s), G(t) \rangle ds dt \lesssim h^{-1} \|F\|_{L^2_t L^{2*}_x} \|G\|_{L^2_t L^{2*}_x}.$$

$$(4.16)$$

Decompose $a^+ = \tilde{a}^+ + b^{\text{com}}$ with $a^+ \in S^{0,-\infty}$, $b^{\text{com}} \in S^{-\infty,-\infty}$ satisfying $\operatorname{supp} a^+ \subset \Gamma^+(R^2, I, 1/2)$ and $\operatorname{supp} b^{\text{com}} \subset \{c_0 < |x| < 2R^2, |\xi|^2 \in I\}$. The part associated with b^{com} can be dealt with the same argument as that for Y_2 . Moreover, since $|x| \leq 2R$ on $\operatorname{supp} a^{\text{com}}$, the same argument as in the proof of (3.42) yields that

$$\begin{aligned} &\|\widetilde{\varphi}(H_h)\operatorname{Op}_h(a^{\operatorname{com}})^*\varphi(H_h)e^{-i(t-s)H_h/h}\operatorname{Op}_h(\widetilde{a}^+)\widetilde{\varphi}(H_h)\|_{1\to\infty} \\ &\lesssim h^{-n}\|\operatorname{Op}_h(a^{\operatorname{com}})^*\varphi(H_h)e^{-i(t-s)H_h/h}\operatorname{Op}_h(\widetilde{a}^+)\| \\ &\lesssim h^{M-n}\langle t-s\rangle^{-M}, \quad s\leq t, \end{aligned}$$

for all $M \ge 0$ which, together with the TT^* -argument, implies (4.16) with a^+ replaced by \tilde{a}^+ . This completes the proof of (4.16).

In case of $W = Z_4^+$, taking the bound (4.12) into account, we decompose R_h as

$$R_h = B_1 \chi(x) + h^N B_2 \langle x \rangle^{-N}$$

where $||B_1|| + ||B_2|| \leq 1$ uniformly in $h \in (0,1]$, $\chi \in C_0^{\infty}(\{|x| < 1\})$ and $N \gg n$. Then, using (3.40) and (3.41), we similarly obtain

$$\begin{aligned} &\|\widetilde{\varphi}(H_h)R_h\varphi(H_h)e^{-i(t-s)H_h/h}\operatorname{Op}_h(\widetilde{a}^+)\widetilde{\varphi}(H_h)\|_{1\to\infty} \\ &\lesssim h^{-n}\|\chi(x)\varphi(H_h)e^{-i(t-s)H_h/h}\operatorname{Op}_h(\widetilde{a}^+)\| + h^{N-n}\|\langle x\rangle^{-N}\varphi(H_h)e^{-i(t-s)H_h/h}\operatorname{Op}_h(\widetilde{a}^+)\| \\ &\lesssim h^{N-2n-1}\langle t-s\rangle^{-N/8} \end{aligned}$$

for $s \leq t$. Choosing $N \gg n$ large enough and applying the TT^* -argument, we obtain (4.3).

5 Proof of Theorem 1.2

In this section we prove Theorem 1.2. For a given self-adjoint operator A on L^2 , U_A and Γ_A denote the homogeneous and inhomogeneous propagators

$$U_A = e^{-itA} : L_x^2 \to L_t^\infty L_x^2, \quad \Gamma_A[F] = \int_0^t e^{-i(t-s)A} F(s) ds : L_t^1 L_x^2 \to L_t^\infty L_x^2.$$

The following space-time weighted L^2 -estimates play a crucial role in the proof of Theorem 1.2.

Proposition 5.1. Let $\mu \in (0,2)$ and $W \in C^2(\mathbb{R}^n \setminus \{0\})$ satisfy

$$W(x) \gtrsim |x|^{-\mu}, \quad -x \cdot \nabla W(x) \gtrsim |x|^{-\mu}, \ |(x \cdot \nabla)^2 W(x)| \lesssim |x|^{-\mu}.$$
 (5.1)

Let $\chi \in C_0^{\infty}(\mathbb{R}^n)$ and $\rho(x) = \chi(x)|x|^{-\mu/2}$. Then, for $H_1 = -\Delta + W(x)$,

$$\|\rho e^{-itH_1} u_0\|_{L^2_t L^2_x} \lesssim \|u_0\|_{L^2}, \ \|\rho \Gamma_{H_1}[\rho F]\|_{L^2_t L^2_x} \lesssim \|F\|_{L^2_t L^2_x}.$$

Proof. Under the above conditions, W fulfills the conditions in [4, Example 2.18]. Then the result is a consequence of [4, Corollary 2.21].

Proof of Theorem 1.2. Let $M_{\ell} = |||x|^{\mu}(x \cdot \nabla)^{\ell} V_S||_{\infty}$ for $\ell = 0, 1$ and assume $M_{\ell} > 0$ without loss of generality. It is easy to see that if we choose $\varepsilon_* = \min(Z/M_0, \ \mu Z/M_1)$, then $W(x) := Z|x|^{-\mu} + \varepsilon V_S(x)$ fulfills (5.1) provided $\varepsilon \in [0, \varepsilon_*)$. Choose $\chi \in C_0^{\infty}(\mathbb{R}^n)$ such that $0 \le \chi \le 1$ and $\chi \equiv 1$ on a unit ball, and decompose $Z|x|^{-\mu} + \varepsilon V_S(x) = V_1(x) + V_2(x)$ where

$$V_1(x) = \chi(x) + (1 - \chi(x))(Z|x|^{-\mu} + \varepsilon V_S(x)), \quad V_2(x) = \chi(x)(Z|x|^{-\mu} + \varepsilon V_S(x) - 1).$$

It is easy to see that V_1 satisfies (H1)–(H3) and $|V_2(x)| \leq |\chi(x)| |x|^{-\mu}$. Let $H_1 = H + Z|x|^{-\mu} + \varepsilon V_S(x)$ and $H = -\Delta + V_1(x)$. Decompose $V_2 = v_1 v_2$ with $v_1 = |V_2|^{1/2}$ and $v_2 = v_1 \operatorname{sgn} V_2$. Note that $|v_1|, |v_2| \leq |\chi(x)| |x|^{-\mu/2}$ and thus $v_1, v_2 \in L^n$ since $\mu < 2$.

Now we use a perturbation method, originated from Rodnianski-Schlag [36, Section 4] and extended by [8, 4], which is based on Duhamel's formulas (See [4, Proposition 4.4])

$$U_{H_1}u_0 = U_H u_0 - i\Gamma_H [V_2 U_{H_1} u_0]$$
(5.2)

$$\Gamma_{H_1}[F] = \Gamma_H[F] - i\Gamma_H[V_2\Gamma_{H_1}[F]], \qquad (5.3)$$

$$\Gamma_{H_1}[F] = \Gamma_H[F] + i\Gamma_{H_1}[V_2\Gamma_H[F]].$$
(5.4)

We may prove the theorem in the endpoint case only: the other cases follow from complex interpolation. By (5.2), (5.3) and Theorem 1.1, it suffices to deal with the inhomogeneous terms $\Gamma_H V_2 U_{H_1}$ and $\Gamma_H V_2 \Gamma_{H_1}$. By Theorem 1.1, Hölder's inequality and Proposition 5.1,

$$\|\Gamma_{H}[V_{2}U_{H_{1}}u_{0}]\|_{L^{2}_{t}L^{2*}_{x}} \lesssim \|\Gamma_{H}\|_{L^{2}_{t}L^{2*}_{x} \to L^{2}_{t}L^{2*}_{x}} \|v_{1}\|_{L^{n}} \|v_{2}U_{H_{1}}u_{0}\|_{L^{2}_{t}L^{2}_{x}} \lesssim \|u_{0}\|_{L^{2}}$$

which gives us the desired estimate for $\Gamma_H V_2 U_{H_1}$. We similarly have

$$\|\Gamma_{H}[V_{2}\Gamma_{H_{1}}[F]]\|_{L^{2}_{t}L^{2*}_{x}} \lesssim \|v_{2}\Gamma_{H_{1}}[F]\|_{L^{2}_{t}L^{2}_{x}}$$

Then, using (5.4), Theorem 1.1, Hölder's inequality and Proposition 5.1, we see that

$$\begin{aligned} \|v_{2}\Gamma_{H_{1}}[F]\|_{L_{t}^{2}L_{x}^{2}} &\leq \|v_{2}\Gamma_{H}[F]\|_{L_{t}^{2}L_{x}^{2}} + \|v_{2}\Gamma_{H_{1}}[V_{2}\Gamma_{H}[F]]\|_{L_{t}^{2}L_{x}^{2}} \\ &\lesssim (\|v_{2}\|_{L^{n}} + \|v_{2}\Gamma_{H_{1}}v_{1}\|_{L_{t}^{2}L_{x}^{2} \to L_{t}^{2}L_{x}^{2}} \|v_{2}\|_{L^{n}})\|\Gamma_{H}[F]\|_{L_{t}^{2}L_{x}^{2}} \\ &\lesssim \|F\|_{L_{t}^{2}L_{x}^{2*}} \end{aligned}$$

which implies the double endpoint estimate for $\Gamma_H V_2 \Gamma_{H_1}$. This completes the proof.

A Proof of the resolvent bound (2.40)

Here we give the proof of (2.40). Let $I \Subset (0, \infty)$ be a compact interval such that $\operatorname{supp} \varphi \subset I$ and set $I_{\pm} = \{z \mid \operatorname{Re} z \in I, 0 \leq \pm \operatorname{Im} z \leq 1\}$. When $z \in (I_{+} \cup I_{-})^{c}$, the spectral theorem implies

$$\sup_{h \in (0,1]} \sup_{z \in (I_+ \cup I_-)^c} \|\langle x \rangle^{-\gamma} \varphi(H_h) (H_h - z)^{-N} \varphi(H_h) \langle x \rangle^{-\gamma} \|$$

$$\lesssim \sup_{(z,\rho) \in (I_+ \cup I_-)^c \times \operatorname{supp} \varphi} |\rho - z|^{-N} < \infty.$$

To deal with the case when $z \in I_{\pm}$, we first show that

$$\sup_{z \in I_{\pm}} \|\langle A_h \rangle^{-\gamma} (H_h - z)^{-N} \langle A_h \rangle^{-\gamma} \| \le Ch^{-N}, \quad h \in (0, 1],$$
(A.1)

with some C > 0 independent of h, where $A_h = hA$ and $A = -\frac{i}{2}(x \cdot \nabla + \nabla \cdot x)$ is the generator of the dilation \mathcal{D} . The proof of (A.1) is based on a semiclassical version [31, Theorem 1] of the multiple commutator method by [24]. At first, by decomposing I into finitely many intervals, we may assume that |I| is sufficiently small. We also note that, for each fixed $h_0 > 0$, there exists $C = C(h_0)$ such that (A.1) with $h \in [h_0, 1]$ holds true. Indeed, we obtain by (2.8) that

$$\langle A_h \rangle^{-\gamma} (H_h - z)^{-N} \langle A_h \rangle^{-\gamma} = \mathcal{D}^*_{\mu} \langle A_h \rangle^{-\gamma} (\lambda^{-2} H - z)^{-N} \langle A_h \rangle^{-\gamma} \mathcal{D}_{\mu}$$

which, combined with the fact $\langle A_h \rangle^{-\gamma} \lesssim h^{-\gamma} \langle A \rangle^{-\gamma}$ as a bounded operator, implies

$$\|\langle A_h \rangle^{-\gamma} (H_h - z)^{-N} \langle A_h \rangle^{-\gamma} \| \lesssim h^{-2\gamma} \lambda^{2N} \|\langle A \rangle^{-\gamma} (H - \lambda^2 z)^{-N} \langle A \rangle^{-\gamma} \|.$$

Let $I = [a, b] \Subset (0, \infty)$ and $\lambda_0 \in (0, 1]$ be such that $h_0 = \lambda_0^{2/\mu - 1}$. Since

$$\lambda^2 I_{\pm} \subset \{ Z \mid \operatorname{Re} Z \in [\lambda_0^2 a, b], \ 0 \le \pm \operatorname{Im} Z \le 1 \} =: \tilde{I}^{\pm}, \quad \lambda \in [\lambda_0, 1],$$

the proof for $h \in [h_0, 1]$ is reduced to that of the uniform bound for $\|\langle A \rangle^{-\gamma} (H - Z)^{-N} \langle A \rangle^{-\gamma}\|$ with respect to $Z \in \tilde{I}^{\pm}$. It is easy to see that H satisfies the hypothesis a)-e in [24, Definition 2.1] (see [24, Section 5]). Taking the fact that H has no eigenvalue into account, we thus can apply [24, Theorem 2.2] to obtain

$$\sup_{Z \in \tilde{I}_{\pm}} \|\langle A \rangle^{-\gamma} (H - Z)^{-N} \langle A \rangle^{-\gamma} \| \le C(\lambda_0)$$

with some $C(\lambda_0) > 0$. This implies (A.1) with $C = h_0^{N-2\gamma} \lambda_0^{2N} C(\lambda_0)$ for $h \in [h_0, 1]$.

Next, we shall check that all of hypothesis (H1)–(H3) and (H5) in [31, Section 2] are satisfied for the pair (H_h, A_h) and $h \in (0, h_0]$ with sufficiently small h_0 . Note that the hypothesis (H4) in [31, Section 2] is not necessary in the present case (see [31, Remark after Theorem 1]). At first, $D(A_h) \cap D(H_h)$ is dense in $D(H_h)$ since $C_0^{\infty}(\mathbb{R}^n) \subset D(A_h)$ and $D(H_h) = \mathcal{H}^2$. By Lemma 2.3,

$$|(x \cdot \nabla)^{j} V_{h}(x)| \le C_{j} (\lambda^{2/\mu} + |x|)^{-\mu} \le C_{j} V_{h}(x), \quad x \in \mathbb{R}^{n}, \quad j = 0, 1, \dots$$
(A.2)

with some $C_i > 0$. Therefore, if we define B_i inductively by $B_0 = H_h$ and

$$B_j = [B_{j-1}, iA_h] = h^j (-2^j h^2 \Delta - (x \cdot \nabla)^j V_h), \quad j \in \mathbb{N},$$

then B_j are well-defined as forms on $D(A_h) \cap D(H_h)$ and extended to bounded operators from $D(H_h)$ to L^2 . Thus H_h is smooth with respect to A_h in the sense of [24]. Since $B_j \leq h^j H_h$ by the above computations, it is also easy to see that $\|B_j(H_h+i)^{-1}\| \leq C_j h^j$. This proves

(H1)–(H3) in [31, Section 2]. Next, choosing $\chi \in C_0^{\infty}(\mathbb{R}^n)$ satisfying $0 \le \chi \le 1$ and $\chi \equiv 1$ on $\{|x| < R_0\}$, we know by (2.12)–(2.14) and (A.2) that there exists constants $a_0, a_1 > 0$ such that

$$[H_h, iA_h] = h(-2h^2\Delta - x \cdot \nabla V_h)$$

$$\geq ha_0H_h - ha_1\chi(\lambda^{-2/\mu}x)V_h$$

$$\geq h(a_0 - a_1\chi(\lambda^{-2/\mu}x))H_h.$$

Here we claim that there exists $h_0 > 0$ such that

$$\|E_{H_h}(I)\chi(\lambda^{-2/\mu}x)H_hE_{H_h}(I)\| \le \frac{a_0}{2a_1}$$
(A.3)

for all $h \in (0, h_0]$, where E_{H_h} is the spectral measure for H_h . We postpone the proof of this claim to Lemma A.1 below. It follows from this claim that semiclassical strict Mourre's inequality

$$E_{H_h}(I)[H_h, iA_h]E_{H_h}(I) \gtrsim hE_{H_h}(I) \tag{A.4}$$

holds uniformly in $h \in (0, h_0]$. Hence (H1)–(H3) and (H5) in [31, Section 2] are satisfied for (H_h, A_h) and we can apply [31, Theorem 3] obtaining (A.1) for $h \in (0, h_0]$.

To pass (2.40) from (A.1), it remains to show the following uniform bound:

$$\|\langle x \rangle^{-\gamma} \varphi(H_h) \langle A_h \rangle^{\gamma} \| \lesssim 1, \quad h = \lambda^{2/\mu - 1} \in (0, 1].$$
(A.5)

We first prove as an intermediate step that

$$\|\langle x \rangle^{-\gamma} \langle A_h \rangle^{2\gamma} \varphi(H_h) \langle x \rangle^{-\gamma} \| \lesssim h^{-4\gamma}.$$
(A.6)

To this end, using (2.6) and the fact that A_h commutes with \mathcal{D}_{μ} , we see that

$$\|\langle x\rangle^{-\gamma}\langle A_h\rangle^{2\gamma}\varphi(H_h)\langle x\rangle^{-\gamma}\| = \|\langle \lambda^{2/\mu}x\rangle^{-\gamma}\langle A_h\rangle^{2\gamma}\varphi(\lambda^{-2}H)\langle \lambda^{2/\mu}x\rangle^{-\gamma}\|.$$
 (A.7)

Since $\langle \lambda^{2/\mu} x \rangle^{-1} \leq \lambda^{-2/\mu} \langle x \rangle^{-1}$ for $\lambda \in (0,1]$ and $\|\langle A_h \rangle^{\gamma} \langle A \rangle^{-\gamma}\| \leq 1$ for all $h \in (0,1]$ by the spectral theorem, the right of (A.7) is dominated by $\lambda^{-4\gamma/\mu} \|\langle x \rangle^{-\gamma} \langle A \rangle^{2\gamma} \varphi(\lambda^{-2}H) \langle x \rangle^{-\gamma} \|$. To deal with this term, we take $\tilde{\varphi} \in C_0^{\infty}(\mathbb{R})$ so that $\tilde{\varphi} \equiv 1$ on $(-1, \sup(|\sup \varphi|) + 1)$ and write

$$\langle x \rangle^{-\gamma} \langle A \rangle^{2\gamma} \varphi(\lambda^{-2}H) \langle x \rangle^{-\gamma} = \langle x \rangle^{-\gamma} \langle A \rangle^{2\gamma} \widetilde{\varphi}(H) \langle x \rangle^{-\gamma} \langle x \rangle^{\gamma} \varphi(\lambda^{-2}H) \langle x \rangle^{-\gamma}$$

where we have used the fact $\tilde{\varphi}(x)\varphi(\lambda^{-2}x) = \varphi(\lambda^{-2}x)$ for $x \in \mathbb{R}$, $0 < \lambda \leq 1$. By the same proof as that of Lemma 2.11, we have $\|\langle x \rangle^{\gamma}\varphi(\lambda^{-2}H)\langle x \rangle^{-\gamma}\| \leq \lambda^{-2}$. Moreover, by Remark 2.14, $\tilde{\varphi}(H)\langle x \rangle^{-\gamma} = \operatorname{Op}(a_{\gamma}) + Q_{\gamma}$ with some $a_{\gamma} \in S^{-N,-\infty}$ and Q_{γ} satisfying $\langle x \rangle^{\gamma}\langle D \rangle^{2\gamma}Q_{N} \in \mathbb{B}(L^{2})$. Since $\langle x \rangle^{-\gamma}\langle A \rangle^{2\gamma}\langle D \rangle^{-2\gamma}\langle x \rangle^{-\gamma} \in \mathbb{B}(L^{2})$ by Proposition 2.1 and complex interpolation, we thus conclude that

$$\|\langle x\rangle^{-\gamma}\langle A\rangle^{2\gamma}\varphi(\lambda^{-2}H)\langle x\rangle^{-\gamma}\| \lesssim \lambda^{-4\gamma/\mu-2},$$

which implies (A.6). Next we shall show

$$\sup_{h \in (0,1]} \|\langle x \rangle^{-\gamma} \varphi(H_h) \langle A_h \rangle^{2\gamma} \varphi(H_h) \langle x \rangle^{-\gamma} \| < \infty$$

which implies (A.5). We decompose the operator in the left hand side into two parts

$$\langle x \rangle^{-\gamma} \varphi(H_h) \chi_R(x) \langle A_h \rangle^{2\gamma} \varphi(H_h) \langle x \rangle^{-\gamma}, \quad \langle x \rangle^{-\gamma} \varphi(H_h) (1 - \chi_R(x)) \langle A_h \rangle^{2\gamma} \varphi(H_h) \langle x \rangle^{-\gamma},$$

where χ_R is as in Section 3. For the first term, [32, Theorem 1.1 and (2.4)] implies

$$\|\langle x \rangle^{-\gamma} \varphi(H_h) \chi_R \langle x \rangle^{\gamma}\| \le C_{M,R} h^M$$

for any $M \in \mathbb{N}$ if R > 0 is small enough. Choosing $M \ge 4\gamma$, we thus learn by (A.6) that

$$\|\langle x\rangle^{-\gamma}\varphi(H_h)\chi_R(x)\langle A_h\rangle^{2\gamma}\varphi(H_h)\langle x\rangle^{-\gamma}\| \lesssim 1.$$

On the other hand, Proposition 2.13 yields that $\langle x \rangle^{-\gamma} \varphi(H_h)(1-\chi_R) = \operatorname{Op}(a_h) + Q_h$ with some $a_h \in S^{-\gamma,-\infty}$ and Q_h satisfying $\|Q_h \langle x \rangle^{2\gamma} \langle hD \rangle^{2\gamma}\| \lesssim h^{2\gamma}$ for each R > 0. Therefore,

$$\begin{aligned} \|\langle x \rangle^{-\gamma} \varphi(H_h)(1-\chi_R(x)) \langle A_h \rangle^{2\gamma} \varphi(H_h) \langle x \rangle^{-\gamma} \| \\ &\leq \|\operatorname{Op}(a_h) \langle A_h \rangle^{2\gamma} \langle x \rangle^{-\gamma} \| \|\langle x \rangle^{\gamma} \varphi(H_h) \langle x \rangle^{-\gamma} \| + \|Q_h \langle A_h \rangle^{2\gamma} \| \|\varphi(H_h) \langle x \rangle^{-\gamma} \| \lesssim 1, \end{aligned}$$

which completes the proof of (A.5).

Lemma A.1. For sufficiently small $h_0 > 0$, (A.3) holds for all $h \in (0, h_0]$.

Proof. By the spectral theorem, $||H_h E_{H_h}(I)|| \leq |\sup I| \leq 1$ uniformly in $h \in (0, 1]$. Moreover, (2.8) implies $E_{H_h}(I)\chi(\lambda^{-2/\mu}x) = \mathcal{D}^*_{\mu}E_{\lambda^{-2}H}(I)\chi(x)\mathcal{D}_{\mu}$ where $h = \lambda^{2/\mu-1}$. Since $\mathbb{1}_I(\lambda^{-2}x) = \mathbb{1}_{\lambda^{2}I}(x)$, we also have $E_{\lambda^{-2}H}(I) = \mathbb{1}_{\lambda^{2}I}(H)$. Therefore, it suffices to show $||\mathbb{1}_{\lambda^{2}I}(H)\chi(x)|| \to 0$ as $\lambda \to 0$. Taking into account the formula $\mathbb{1}_{\lambda^{2}I}(H)\chi(x) = \mathbb{1}_{\lambda^{2}I}(H)\mathbb{1}_J(H)\chi(x)$ for $0 < \lambda \leq 1$ where $J = (0, \sup |I|)$, we see that this norm convergence follows from the facts that $\mathbb{1}_{\lambda^{2}I}(H) \to 0$ strongly as $\lambda \to 0$ since $|\lambda^{2}I| \leq \lambda^{2} \sup |I|$ and $\mathbb{1}_J(H)\chi(x)$ is compact. \Box
