NONTANGENTIAL ESTIMATES ON LAYER POTENTIALS AND THE NEUMANN PROBLEM FOR HIGHER ORDER ELLIPTIC EQUATIONS

ABSTRACT. We solve the Neumann problem, with nontangential estimates, for higher order divergence form elliptic operators with variable *t*-independent coefficients. Our results are accompanied by nontangential estimates on higher order layer potentials.

1. Introduction

Consider the higher order elliptic differential operator L given by

(1.1)
$$Lu = (-1)^m \sum_{|\alpha| = |\beta| = m} \partial^{\alpha} (A_{\alpha\beta} \partial^{\beta} u)$$

for $m \geq 1$ a positive integer. The study of such operators, for $2m \geq 4$, is still fairly new. However, some results are known in the case of constant coefficients; see, for example, [DKPV97, Ver05, She07, MM13b] for some results related to those of the present paper.

In this paper we will consider coefficients A that are variable, but are bounded, elliptic, and t-independent in the sense that

(1.2)
$$\mathbf{A}(x,t) = \mathbf{A}(x,s) = \mathbf{A}(x)$$
 for all $x \in \mathbb{R}^n$ and all $s, t \in \mathbb{R}$.

Such t-independent coefficients have been studied extensively in the second order case. In particular, layer potentials have been used extensively in this case; see [HKMP15, HMM15a, HMM15b] for some recent examples. In [BHM17a, Bar17] we generalized layer potentials to the higher order case; we will continue to use them in the present paper.

The main result of the present paper (see Theorem 1.14 below) is existence of solutions to the Neumann problem

(1.3)
$$\begin{cases} Lw = 0 \text{ in } \mathbb{R}^{n+1}_+, \\ \dot{\mathbf{M}}^+_{\boldsymbol{A}} w = \dot{\boldsymbol{g}}, \\ \|\widetilde{N}_+(\nabla^m w)\|_{L^2(\mathbb{R}^n)} \le C \|\dot{\boldsymbol{g}}\|_{L^2(\mathbb{R}^n)} \end{cases}$$

and the rough Neumann problem (or subregularity problem)

(1.4)
$$\begin{cases} Lv = 0 \text{ in } \mathbb{R}^{n+1}_+, \\ \dot{\mathbf{M}}^+_{\mathbf{A}} v = \dot{\mathbf{h}}, \\ \|\widetilde{N}_+(\nabla^{m-1}v)\|_{L^2(\mathbb{R}^n)} \le C \|\dot{\mathbf{h}}\|_{\dot{W}^2_{-1}(\mathbb{R}^n)} \end{cases}$$

where $\dot{\mathbf{M}}_{A}^{+}$ denotes the Neumann boundary value operator (given in the second order case by $-\vec{e}_{n+1} \cdot A\nabla$, and by formula (1.10) below or by [Bar, formula (2.16)] in the general case), and where \tilde{N}_{+} denotes the modified nontangential maximal operator; this is the natural sharp estimate on solutions to boundary value problems. This work builds on our earlier results [BHM17c, BHM17a, BHM18], in which we established well posedness in terms of the Lusin area integral. We will solve the problems (1.3–1.4) by establishing nontangential bounds on the double layer potential; we will in the process establish nontangential bounds on the single layer potential.

1.1. Solutions to the Neumann problem. We begin by reviewing the history of the Neumann problem with L^2 or \dot{W}_{-1}^2 boundary data. In the case of harmonic functions, solutions to the problem

$$\Delta u = 0 \text{ in } \Omega, \quad \nu \cdot \nabla u = g \text{ on } \partial \Omega, \quad \|N_{\Omega}(\nabla u)\|_{L^{2}(\partial \Omega)} \leq C\|g\|_{L^{2}(\partial \Omega)}$$

for an arbitrary bounded C^1 domain Ω were constructed using the method of layer potentials in [FJR78]. Here ν denotes the unit outward normal vector to $\partial\Omega$, and N_{Ω} denotes the standard nontangential maximal function $N_{\Omega}F(X)=\sup\{|F(Y)|:Y\in\Omega,\, \mathrm{dist}(Y,\partial\Omega)<2|X-Y|\}.$

By the divergence theorem, if ∇u is continuous up to the boundary, $\nu \cdot \nabla u = g$ on $\partial \Omega$, and $\Delta u = \nabla \cdot \nabla u = 0$ in Ω , then

$$(1.5) \qquad \qquad \int_{\partial\Omega} \varphi \, g \, d\sigma = \int_{\Omega} \nabla \varphi \cdot \nabla u$$

for any smooth test function φ . The left hand side converges provided only that ∇u is integrable up to the boundary; thus, if $\Delta u = 0$ in Ω then we say that $\nu \cdot \nabla u = g$ on $\partial \Omega$ in the weak sense if the above equation is satisfied for all nice test functions φ .

The L^2 Neumann problem for harmonic functions was shown to be well posed in bounded Lipschitz domains in [JK81], and in [Ver84] it was shown that the solution to the Neumann problem may be written as a single layer potential. In [KP93], Kenig and Pipher solved the Neumann problem in starlike Lipschitz domains for operators of the form (1.1) of second order, (that is, with 2m = 2,) with real symmetric radially independent coefficients; essentially the same argument establishes well posedness of the Neumann problem for operators with real symmetric t-independent coefficients in the domain above a Lipschitz graph.

In the case of second order equations (but not higher order equations), a simple change of variables allows one to pass from the the half space \mathbb{R}^{n+1}_+ to a domain above a Lipschitz graph. This change of variables preserves *t*-independence. Thus, much recent work in the second order case has considered the Neumann problem in the half space

(1.6)
$$\nabla \cdot \mathbf{A} \nabla u = 0 \text{ in } \mathbb{R}^{n+1}_+, \quad \mathcal{M}^+_{\mathbf{A}} u = g, \quad \|\widetilde{N}_+(\nabla u)\|_{L^2(\mathbb{R}^n)} \le C\|g\|_{L^2(\mathbb{R}^n)}$$

where the Neumann boundary values $\mathbf{M}_{\mathbf{A}}^{+}u$ of a solution u to div $\mathbf{A}\nabla u=0$ are given by

$$(1.7) \qquad \int_{\mathbb{R}^n} \varphi(x,0) \, \mathcal{M}_{\boldsymbol{A}}^+ \, u(x) \, dx = \int_{\mathbb{R}^{n+1}_+} \nabla \varphi \cdot \boldsymbol{A} \nabla u \quad \text{for all } \varphi \in C_0^\infty(\mathbb{R}^{n+1}).$$

If u and \mathbf{A} are sufficiently smooth, then $\mathbf{M}_{\mathbf{A}}^+ u = -\vec{e}_{n+1} \cdot \mathbf{A} \nabla u = \nu \cdot \mathbf{A} \nabla u$.

If the coefficients \boldsymbol{A} are real, symmetric, and t-independent, recall that well posedness of the problem (1.6) was established in [KP93]. This problem is also known to be well posed for certain classes of complex t-independent coefficients. If \boldsymbol{A} is complex and constant, then the problem may be solved using the Fourier transform. Well posedness of the Neumann problem in \mathbb{R}^{n+1} in the case where \boldsymbol{A} is a t-independent matrix in "block" form follows from the resolution of the Kato square root problem in \mathbb{R}^n established in [AHL+02]. See [Ken94, Remark 2.5.6] and [AAA+11, AAH08] for a discussion of block matrices. Well posedness was extended from the case of block matrices to that of block lower triangular matrices in [AMM13].

Furthermore, well posedness of the L^2 Neumann problem in the half-space was shown in [AAA⁺11, AAM10] to be stable under t-independent L^{∞} perturbations; in particular, if \boldsymbol{A} is t-independent and close in L^{∞} to a constant matrix, a variable self-adjoint matrix, or a variable block or block lower triangular matrix, then the Neumann problem is well posed.

The Neumann problem with L^2 boundary data is known not to be well posed for arbitrary real nonsymmetric coefficients; see the appendix to [KR09]. (One of the two main results of [KR09] is that the Neumann problem with L^p boundary data, for p > 1 sufficiently small, is well posed in \mathbb{R}^2_+ .)

We now turn to the case of the Neumann problem with boundary data in a negative Sobolev space \dot{W}_{-1}^2 , that is, the dual space to the space \dot{W}_{1}^2 of functions whose gradient is square integrable.

In [Ver05, Proposition 4.2], Verchota established well posedness of the Neumann subregularity problem for harmonic functions in Lipschitz domains

$$\Delta u = 0 \text{ in } \Omega, \quad \mathbf{M}_I^{\Omega} u = h, \quad \|N_{\Omega} u\|_{L^2(\partial \Omega)} \le C \|h\|_{\dot{W}^2_{-1}(\partial \Omega)}.$$

For subregular solutions, (that is, for u with $N_{\Omega}u \in L^2(\partial\Omega)$ rather than $N_{\Omega}(\nabla u) \in L^2(\partial\Omega)$,) the definition of Neumann boundary values $M_I^{\Omega}u$ must be modified, as the integral on the right hand side of formula (1.5) need not converge for all test functions $\varphi \in C_0^{\infty}(\mathbb{R}^{n+1})$; we refer the reader to [Ver05, Definition 4.1] for a precise definition.

In [AM14, Section 11], it was shown that if \boldsymbol{A} is real or if the ambient dimension n+1=3, (or, more generally, if all solutions u to either div $\boldsymbol{A}\nabla u=0$ or div $\boldsymbol{A}^*u=0$ satisfy the De Giorgi-Nash-Moser condition of local Hölder continuity,) then solvability of the L^2 Neumann problem (1.6) implies solvability of the \dot{W}^2_{-1} -Neumann problem

$$\nabla \cdot \boldsymbol{A} \nabla u = 0 \text{ in } \mathbb{R}^{n+1}_+, \quad \mathrm{M}^+_{\boldsymbol{A}} u = h, \quad \|\mathcal{A}^+_2(t \nabla u)\|_{L^2(\mathbb{R}^n)} \leq C \|h\|_{\dot{W}^2_{-1}(\mathbb{R}^n)}.$$

Note that in this case, the estimates on solutions are given not in terms of non-tangential maximal functions, but in terms of area integral estimates. (See formula (2.6) below for a definition of \mathcal{A}_2^+ .) In a few cases, (see also the Dirichlet problem (D2) in [AAA+11] and Dirichlet problems in [AMM13, Theorem 6.6] and [AM14, Section 11],) it has proven more convenient to solve boundary value problems posed with area integral estimates; however, it is much more common to phrase well posedness in terms of nontangential estimates.

We now turn to the higher order L^2 Neumann problem. Higher order Neumann boundary values may be constructed as a generalization of the second order Neumann boundary values given by formula (1.7).

In [CG85, Ver05, Agr07, Ver10, MM13a], the Neumann boundary values of a solution u to Lu = 0 in Ω , with $\nabla^m u$ locally integrable up to the boundary, were essentially given by

$$(1.8) \sum_{j=0}^{m-1} \int_{\partial\Omega} \partial_{\nu}^{j} \varphi \, (\vec{\mathcal{M}}_{\boldsymbol{A}}^{\Omega} u)_{j} \, d\sigma = \sum_{|\alpha|=|\beta|=m} \int_{\Omega} \partial^{\alpha} \varphi \, A_{\alpha\beta} \, \partial^{\beta} u \quad \text{for all } \varphi \in C_{0}^{\infty}(\mathbb{R}^{n+1}).$$

An integration by parts argument gives a precise formula for $\vec{\mathbf{M}}_{\boldsymbol{A}}^{\Omega}u$ in the case where u, \boldsymbol{A} and Ω are sufficiently smooth; see [CG85, Ver05] in the case where $L = \Delta^2$ is the biharmonic operator, and [MM13b, Proposition 4.3] for general constant coefficients.

The biharmonic L^2 -Neumann problem

(1.9)
$$\begin{cases} \Delta^2 u = 0 \text{ in } \Omega, \quad \vec{\mathbf{M}}_{\mathbf{A}}^{\Omega} u = (\Lambda, f) \text{ on } \partial \Omega, \\ \|N(\nabla^2 u)\|_{L^2(\partial \Omega)} \le C \|f\|_{L^2(\partial \Omega)} + C \|\Lambda\|_{\dot{W}_{-1}^2(\partial \Omega)} \end{cases}$$

was shown to be well posed in [CG85] in planar C^1 domains, and in [Ver05] in Lipschitz domains of arbitrary dimension. Even in the case of general constant coefficients the Neumann problem is not known to be well posed for L^2 boundary data (although see [Ver10] for some general discussion of this case and [Agr07, MM13b, MM13a, Bar] for the case of boundary data in a Besov space).

In [BHM17c, BHM18, Bar17, Bar], we used the formulation

$$(1.10) \qquad \int_{\mathbb{R}^n} \sum_{|\gamma|=m-1} \partial^{\gamma} \varphi(x,0) \, (\dot{\mathbf{M}}_{\boldsymbol{A}}^+ \, u(x))_{\gamma} \, dx = \sum_{|\alpha|=|\beta|=m} \int_{\mathbb{R}_+^{n+1}} \partial^{\alpha} \varphi \, A_{\alpha\beta} \, \partial^{\beta} u$$

for all $\varphi \in C_0^{\infty}(\mathbb{R}^{n+1})$, provided $\nabla^m u$ is locally integrable up to the boundary. (We must modify the definition if $\nabla^m u$ satisfies weaker estimates; see [BHM17b] for a precise definition and for further discussion.)

It is generally much more difficult to construct a formula for $\dot{\mathbf{M}}_{A}^{+}u$ in this case (although see [BHM17c, formula (2.13)] in the biharmonic case). In fact, observe that $\dot{\mathbf{M}}_{A}^{+}u$ is an operator on $\{\nabla^{m-1}\varphi\big|_{\partial\mathbb{R}^{n+1}_{+}}:\varphi\in C_{0}^{\infty}(\mathbb{R}^{n+1})\}$. By equality of mixed partials, the components of $\nabla^{m-1}\varphi$ must satisfy certain compatibility conditions; thus, this is not a dense subspace of the set of arrays of distributions, and so $\dot{\mathbf{M}}_{A}^{+}u$ as given by formula (1.10) lies in a quotient space of the space of tempered distributions.

However, we have preferred the formulation (1.10) to the formulation (1.8) because the different components of $\dot{\mathbf{M}}_{A}^{+}u$ given by formula (1.10) generally have the same order of smoothness, and the different components of $\dot{\mathbf{M}}_{A}^{\Omega}u$ given by formula (1.8) do not; observe the presence of both a L^{2} norm and a \dot{W}_{-1}^{2} norm in the problem (1.9).

In [BHM18], we established well posedness of the L^2 and \dot{W}_{-1}^2 Neumann problems. Specifically, suppose that L is an operator of the form (1.1) associated to coefficients \boldsymbol{A} that are bounded, t-independent in the sense of formula (1.2), self-adjoint in the sense that $A_{\alpha\beta}(x) = \overline{A_{\beta\alpha}(x)}$ for all $|\alpha| = |\beta| = m$, and satisfy the ellipticity condition

(1.11)
$$\operatorname{Re}\langle \nabla^m \varphi(\,\cdot\,,t), \mathbf{A} \nabla^m \varphi(\,\cdot\,,t) \rangle_{\mathbb{R}^n} \ge C \|\nabla^m \varphi(\,\cdot\,,t)\|_{L^2(\mathbb{R}^n)}^2$$

for all φ smooth and compactly supported in \mathbb{R}^{n+1} and all $t \in \mathbb{R}$. Then by [BHM18, Theorems 1.7 and 1.11], the Neumann problem

(1.12)
$$\begin{cases} Lw = 0 \text{ in } \mathbb{R}^{n+1}_{+}, \\ \dot{\mathbf{M}}^{+}_{A} w \ni \dot{\boldsymbol{g}}, \\ \|\mathcal{A}^{+}_{2}(t\nabla^{m}\partial_{t}w)\|_{L^{2}(\mathbb{R}^{n})} + \sup_{t>0} \|\nabla^{m}w(,\cdot,t)\|_{L^{2}(\mathbb{R}^{n})} \le C\|\dot{\boldsymbol{g}}\|_{L^{2}(\mathbb{R}^{n})} \end{cases}$$

and the rough Neumann problem

(1.13)
$$\begin{cases} Lv = 0 \text{ in } \mathbb{R}^{n+1}_{+}, \\ \dot{\mathbf{M}}^{+}_{\mathbf{A}} v \ni \dot{\mathbf{h}}, \\ \|\mathcal{A}^{+}_{2} (t\nabla^{m} v)\|_{L^{2}(\mathbb{R}^{n})} \leq C \|\dot{\mathbf{h}}\|_{\dot{W}^{2}_{-1}(\mathbb{R}^{n})}. \end{cases}$$

are well posed. That is, if $\dot{\boldsymbol{g}} \in L^2(\mathbb{R}^n)$ or $\dot{\boldsymbol{h}} \in \dot{W}^2_{-1}(\mathbb{R}^n)$, then there is a solution w or v to the problem (1.12) or (1.13), and this solution is unique up to adding polynomials of degree m-1.

By $\dot{\mathbf{M}}_{A}^{+} w \ni \dot{\mathbf{g}}$ we mean that $\dot{\mathbf{g}}$ is a representative of the equivalence class $\dot{\mathbf{M}}_{A}^{+} w$ given by formula (1.10); that is, if we replace $\dot{\mathbf{M}}_{A}^{+} w$ by $\dot{\mathbf{g}}$, then formula (1.10) is true for all $\varphi \in C_{0}^{\infty}(\mathbb{R}^{n+1})$.

In the problem (1.13), the gradient $\nabla^m v$ of the solution v is not assumed to be locally integrable up to the boundary; it is only assumed to satisfy

$$\int_{\mathbb{R}^n} \mathcal{A}_2^+(t\nabla^m v)^2 = c_n \int_{\mathbb{R}^n} \int_0^\infty |\nabla^m v(x,t)|^2 t \, dt \, dx < \infty.$$

As mentioned above, in this case the notion of Neumann boundary value of formula (1.10) must be modified somewhat; we refer the reader to [BHM17b, formula (2.16)] for the necessary generalization.

We remind the reader that it is somewhat unusual to formulate boundary value problems in terms of area integrals; of the results mentioned above, [FJR78, JK81, Ver84, KP93, KR09, Ver05] formulated solutions in terms of nontangential maximal estimates, while [AAM10] established both square function and area integral estimates, and [AAA+11, AMM13, AM14] formulated solutions for some problems in terms of nontangential estimates and others in terms of square function estimates.

Thus, one of the two main results of this paper is the addition of nontangential estimates to the higher order Neumann problem.

Theorem 1.14. Suppose that L is an elliptic operator of the form (1.1) of order 2m associated with coefficients \mathbf{A} that satisfy $\|\mathbf{A}\|_{L^{\infty}(\mathbb{R}^n)} = \Lambda < \infty$ and the ellipticity condition (1.11), are t-independent in the sense of formula (1.2), and are self-adjoint, that is, satisfy $A_{\alpha\beta}(x) = \overline{A_{\beta\alpha}(x)}$.

Let $\dot{\mathbf{g}} \in L^2(\mathbb{R}^n)$ and $\dot{\mathbf{h}} \in \dot{W}^2_{-1}(\mathbb{R}^n)$, and let w and v be the solutions to the problems (1.12) and (1.13), respectively.

There is a constant C, depending only on Λ , the ambient dimension n+1, order 2m of the operator L, and the ellipticity constant λ in the bound (1.11), such that

$$\|\widetilde{N}_+(\nabla^m w)\|_{L^2(\mathbb{R}^n)} \le C\|\dot{\boldsymbol{g}}\|_{L^2(\mathbb{R}^n)}.$$

Recall that v is unique up to adding polynomials of degree m-1. There is some such additive normalization of v that satisfies

$$\|\widetilde{N}_{+}(\nabla^{m-1}v)\|_{L^{2}(\mathbb{R}^{n})} \leq C\|\dot{h}\|_{\dot{W}_{-1}^{2}(\mathbb{R}^{n})}.$$

1.2. Layer potentials. The proof of Theorem 1.14 is as follows. An examination of the proofs of [BHM18, Theorems 1.7 and 1.11] in [BHM18, Section 7] reveals that

$$w = \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}}$$
 and $v = \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{f}}$,

where $\mathcal{D}^{\mathbf{A}}$ is the higher order double layer potential introduced in [BHM17c, Bar17] (and defined in formula (2.11) below), and where $\dot{\boldsymbol{\varphi}} = (\dot{\mathbf{M}}_{\mathbf{A}}^{+}\mathcal{D}^{\mathbf{A}})^{-1}\dot{\boldsymbol{g}}$ and $\dot{\boldsymbol{f}} = (\dot{\mathbf{M}}_{\mathbf{A}}^{+}\mathcal{D}^{\mathbf{A}})^{-1}\dot{\boldsymbol{h}}$ lie in the Whitney spaces $\dot{W}A_{m-1,1}^{2}(\mathbb{R}^{n})$ and $\dot{W}A_{m-1,0}^{2}(\mathbb{R}^{n})$, respectively, used in [BHM18] (see Definition 2.9 below). Theorem 1.14 then follows from the bounds

$$\|\widetilde{N}_{+}(\nabla^{m}\mathcal{D}^{\mathbf{A}}\dot{\boldsymbol{\varphi}})\|_{L^{2}(\mathbb{R}^{n})} \leq C\|\dot{\boldsymbol{\varphi}}\|_{\dot{W}A^{2}_{m-1,1}(\mathbb{R}^{n})},$$
$$\|\widetilde{N}_{+}(\nabla^{m-1}\mathcal{D}^{\mathbf{A}}\dot{\boldsymbol{f}})\|_{L^{2}(\mathbb{R}^{n})} \leq C\|\dot{\boldsymbol{f}}\|_{\dot{W}A^{2}_{m-1,0}(\mathbb{R}^{n})}.$$

Thus, the double layer potential is of great interest in the theory of the higher order Neumann problem. The related single layer potential \mathcal{S}^L is also of interest. It is often possible to use bounds on the single layer potential \mathcal{S}^L to establish bounds on the double layer potential $\mathcal{D}^{\mathbf{A}}$; see, for example, Section 5.1 below. Bounds on the single layer potential were used to establish [BHM17b, Theorem 1.6]; this Fatou type result establishes existence of Dirichlet and Neumann boundary values of solutions. In the second order case, the single layer potential was used to construct solutions to the Dirichlet or Dirichlet regularity problem in [FJR78, Ver84, MM04, AAA⁺11, Bar13, BM16, HKMP15, HMM15b, HMM15a]; we hope that in future work, we may similarly use the single layer potential to solve the higher order Dirichlet problem.

Thus, nontangential bounds on layer potentials are of independent interest. The following theorem is the second main result of this paper; note that Theorem 1.14 follows from Theorem 1.15, and in particular from the bounds (1.18) and (1.19).

Theorem 1.15. Suppose that L is an elliptic operator of the form (1.1) of order 2massociated with coefficients A that satisfy the ellipticity conditions (2.2) and (2.3)and are t-independent in the sense of formula (1.2).

Then there is an $\varepsilon > 0$, depending only on the dimension n+1, the order 2m of the operator L, and the constants λ and Λ in the bounds (2.2) and (2.3), with the following significance.

If $2 - \varepsilon , then there is a constant <math>C_p$ such that if $\dot{\mathbf{g}} \in L^p(\mathbb{R}^n)$, $\dot{\boldsymbol{h}} \in L^p(\mathbb{R}^n), \ \dot{\boldsymbol{f}} \in \dot{W}A^p_{m-1,0}(\mathbb{R}^n) \ and \ \dot{\boldsymbol{\varphi}} \in \dot{W}A^p_{m-1,1}(\mathbb{R}^n), \ then$

$$(1.16) \|\widetilde{N}_{+}(\nabla^{m}\mathcal{S}^{L}\dot{\boldsymbol{g}})\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p}\|\dot{\boldsymbol{g}}\|_{L^{p}(\mathbb{R}^{n})}, 2-\varepsilon
$$(1.17) \|\widetilde{N}_{+}(\nabla^{m-1}\mathcal{S}^{L}_{\nabla}\dot{\boldsymbol{h}})\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p}\|\dot{\boldsymbol{h}}\|_{L^{p}(\mathbb{R}^{n})}, 2-\varepsilon
$$(1.18) \|\widetilde{N}_{+}(\nabla^{m}\mathcal{D}^{\boldsymbol{A}}\dot{\boldsymbol{\varphi}})\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p}\|\dot{\boldsymbol{\varphi}}\|_{\dot{W}A^{p}_{m-1,1}(\mathbb{R}^{n})}, 2-\varepsilon$$$$$$

$$(1.18) \|\widetilde{N}_{+}(\nabla^{m}\mathcal{D}^{\mathbf{A}}\dot{\boldsymbol{\varphi}})\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p}\|\dot{\boldsymbol{\varphi}}\|_{\dot{W}A_{m-1,1}^{p}(\mathbb{R}^{n})}, 2-\varepsilon$$

$$(1.19) \qquad \|\widetilde{N}_{+}(\nabla^{m-1}\mathcal{D}^{\mathbf{A}}\dot{\mathbf{f}})\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p}\|\dot{\mathbf{f}}\|_{\dot{W}A^{p}_{m-1,0}(\mathbb{R}^{n})}, \qquad 2-\varepsilon$$

Here $\dot{W}A^p_{m-1,1}(\mathbb{R}^n)$ and $\dot{W}A^p_{m-1,0}(\mathbb{R}^n)$ are closed proper subsets of $\dot{W}^p_1(\mathbb{R}^n)$ and $L^p(\mathbb{R}^n)$, respectively; these subsets are the natural domain of \mathcal{D}^A in those spaces. See Definition 2.9. The modified single layer potential \mathcal{S}^L_{∇} is the higher order analogue of the operator $S^L \nabla$ used in [AAA+11, HMM15b, HMM15a]. We will define S^L and S^L_{∇} in Section 2.5. Loosely speaking (see Lemma 4.4 below), we have that $S^L_{\nabla}(h\dot{\boldsymbol{e}}_{\alpha}) = -S^L(\partial_j h\dot{\boldsymbol{e}}_{\zeta})$ whenever $1 \leq j \leq n$ and $\alpha = \zeta + \vec{e}_j$; thus, formula (1.17) gives a bound on the standard single layer potential with inputs in a negative smoothness space.

We now summarize the known bounds on higher order layer potentials. We will use these bounds to establish the nontangential estimates of Theorem 1.15. By definition (see formulas (2.11) and (2.13) below), we have the bounds

$$\|\nabla^m \mathcal{S}^L \dot{\boldsymbol{g}}\|_{L^2(\mathbb{R}^{n+1})} \le C \|\dot{\boldsymbol{g}}\|_{\dot{B}^{2,2}_{-1/2}(\mathbb{R}^n)}, \quad \|\nabla^m \mathcal{D}^A \dot{\boldsymbol{f}}\|_{L^2(\mathbb{R}^{n+1}_+)} \le C \|\dot{\boldsymbol{f}}\|_{\dot{W}A^2_{m-1,1/2}(\mathbb{R}^n)}$$

for all $\dot{\boldsymbol{g}} \in \dot{B}^{2,2}_{-1/2}(\mathbb{R}^n)$ and all $\dot{\boldsymbol{f}} \in \dot{W}A^2_{m-1,1/2}(\mathbb{R}^n)$. The main result of [BHM17c] is that the double and single layer potentials extend by density to operators that satisfy the bounds

(1.20)
$$\|\mathcal{A}_{2}^{+}(t\nabla^{m}\partial_{t}\mathcal{D}^{A}\dot{\varphi})\|_{L^{2}(\mathbb{R}^{n})} \leq C\|\dot{\varphi}\|_{\dot{W}A^{2}_{m-1,1}(\mathbb{R}^{n})},$$

(1.21)
$$\|\mathcal{A}_{2}^{+}(t\nabla^{m}\partial_{t}\mathcal{S}^{L}\dot{\boldsymbol{g}})\|_{L^{2}(\mathbb{R}^{n})} \leq C\|\dot{\boldsymbol{g}}\|_{L^{2}(\mathbb{R}^{n})}$$

for all $\dot{\boldsymbol{\varphi}} \in \dot{W}A^2_{m-1,1}(\mathbb{R}^n)$ and all $\dot{\boldsymbol{g}} \in L^2(\mathbb{R}^n)$.

In [BHM17a, Theorem 1.6], it was shown that if $\dot{\mathbf{f}} \in \dot{W}A^2_{m-1,0}(\mathbb{R}^n)$, then

(1.22)
$$\|\mathcal{A}_{2}^{+}(t\nabla^{m}\mathcal{D}^{A}\dot{f})\|_{L^{2}(\mathbb{R}^{n})} \leq C\|\dot{f}\|_{\dot{W}A^{2}_{m-1,0}(\mathbb{R}^{n})}.$$

Finally, in [BHM17a, Theorem 1.13], the bound (1.21) was extended to $\dot{\boldsymbol{g}} \in L^p$ for some p < 2, and a bound on \mathcal{S}^L_{∇} was established. Specifically, it was shown that there was some $\varepsilon > 0$ such that, if $2 - \varepsilon , then there is a <math>C_p$ such that for all $\dot{\boldsymbol{g}} \in L^p(\mathbb{R}^n)$ and all $\dot{\boldsymbol{h}} \in L^p(\mathbb{R}^n)$,

Observe that these known bounds all involve inputs in L^p for p=2 or p<2. In the course of proving Theorem 1.15, we will also establish the following area integral estimates for inputs in L^p with p>2.

Theorem 1.25. Let L and Abe as in Theorem 1.15. Then there is an $\varepsilon > 0$ such that, if $2 , then there is a constant <math>C_p$ such that if $\dot{\mathbf{g}} \in L^p(\mathbb{R}^n)$, $\dot{\boldsymbol{h}} \in L^p(\mathbb{R}^n), \ \dot{\boldsymbol{f}} \in \dot{W}A^p_{m-1,0}(\mathbb{R}^n) \ and \ \dot{\boldsymbol{\varphi}} \in \dot{W}A^p_{m-1,1}(\mathbb{R}^n), \ then$

$$(1.28) \|\mathcal{A}_{2}^{+}(t\nabla^{m}\partial_{t}\mathcal{D}^{A}\dot{\boldsymbol{\varphi}})\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p}\|\dot{\boldsymbol{\varphi}}\|_{\dot{W}A_{m-1,1}^{p}(\mathbb{R}^{n})}, 2$$

(1.29)
$$\|\mathcal{A}_{2}^{+}(t\nabla^{m}\mathcal{D}^{A}\dot{f})\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p}\|\dot{f}\|_{\dot{W}A^{p}_{m-1,0}(\mathbb{R}^{n})}, \qquad 2$$

In a forthcoming paper, we will show that the bounds (1.28) and (1.29) extend to the case $2-\varepsilon (that is, we will establish the analogues to the bounds$ (1.23) and (1.24) for the double layer potential).

The theory of layer potentials for higher order operators is still relatively new, and thus to our knowledge the above represents a nearly comprehensive survey of bounds on layer potentials for operators of order $2m \geq 4$ with t-independent coefficients in the half-space. (Some additional bounds on $\partial_t^k \mathcal{S}^L$ and $\partial_t^k \mathcal{S}^L_{\nabla}$, for klarge enough, were established in [BHM17a] and used in [BHM17b].)

However, the theory of variable coefficient higher order operators builds on the extensive and well developed theory of second order operators (that is, the case 2m=2) and the reasonably well developed theory of constant coefficient higher order operators.

In the special case of constant coefficient operators (in particular, in the theory of harmonic functions) in Lipschitz domains, boundedness of layer potentials follows from boundedness of the Cauchy integral on Lipschitz curves; the Cauchy integral was famously bounded by Coifmann, McIntosh and Meyer in [CMM82]. Layer potentials for the Laplacian $-\Delta$ were used in [FJR78, Ver84, DK87, PV92, FMM98, Zan00], for the biharmonic operator Δ^2 in [CG83, CG85, Ver05, MM13a], and for general higher order constant coefficient equations in [Agm57, MM13b].

In the case of second order operators with variable t-independent coefficients, bounds on layer potentials were established in [KR09, Rul07, Bar13] in two dimensions for real (or almost real) coefficients.

Turning to higher dimensions, in [AAA⁺11] the p=2 cases of the bounds (1.16) and (1.26) were established for operators of order 2m=2 with real symmetric t-independent coefficients, and a stability result under L^{∞} perturbation was established. (The authors also established numerous more specialized bounds on layer potentials.) In [Ros13], Ròsen showed that layer potentials coincide with certain operators appearing in the theory of semigroups investigated in [AAH08, AAM10, AA11]. In particular, numerous bounds in the p=2 case follow.

The theory of boundary value problems and layer potentials for second order operators was subsequently investigated extensively in the case where $L = -\operatorname{div} \mathbf{A} \nabla$ and $L^* = -\operatorname{div} \mathbf{A}^* \nabla$ satisfy the De Giorgi-Nash-Moser condition; this condition is always satisfied if the ambient dimension n+1 satisfies n+1=2, if n+1=3 and \mathbf{A} is t-independent, or if 2m=2 and \mathbf{A} is real valued. In these cases, it is often possible to establish at least some bounds on layer potentials using the theory of Calderón-Zygmund operators with kernels that satisfy Littlewood-Paley estimates. See, for example, [KR09, Section 4] or [AAA+11, Section 8].

In particular, the p=2=2m case of the bounds (1.26) and (1.16) on the single layer potential \mathcal{S}^L were established in [GdlHH16] directly using Tb theorems, without recourse to the theory of semigroups used in [Ros13]. Building on this bound, the 2m=2 case of all eight of the bounds (1.16)–(1.19) and (1.26)–(1.29) may be found in [AM14, HMM15b, HMM15a, HKMP15] for a fairly broad range of p.

Finally, returning to the theory of semigroups, if 2m = 2 then these eight bounds were established in [AS16, Theorem 12.7] without assuming the De Giorgi-Nash-Moser condition, that is, using only boundedness, ellipticity and t-independence of the coefficients.

1.3. **Outline.** The organization of this paper is as follows.

In Section 2 we will define our terminology. In Section 3 we will recall some known estimates on solutions that we will use extensively throughout the paper, and will prove a few lemmas involving the nontangential and area integral estimates of a general solution u to Lu=0. In particular, given the known area integral estimates (1.20)-(1.24) and the nontangential estimates of Theorem 1.15, most of the work involved in establishing the area integral estimates of Theorem 1.25 is contained in Lemma 3.20.

Section 4 will be devoted to the nontangential bounds (1.16) and (1.17) on the single layer potential (and modified single layer potential). Section 5 will mainly be concerned with establishing the nontangential estimate (1.18) on the double layer potential; the bound (1.19) (and the area integral bounds (1.28) and (1.29)) follow fairly quickly once this bound is established. We remark that we will establish area integral bounds (1.26) and (1.27) on the single layer potential in Section 4 using the nontangential bounds (1.16) and (1.17), and will use these nontangential bounds in order to establish preliminary estimates on the double layer potential.

2. Definitions

In this section, we will provide precise definitions of the notation and concepts used throughout this paper.

We will work with elliptic operators L of order 2m in the divergence form (1.1) acting on functions defined on \mathbb{R}^{n+1} .

As usual, we let B(X,r) denote the ball in \mathbb{R}^n of radius r and center X. We let \mathbb{R}^{n+1}_+ and \mathbb{R}^{n+1}_- denote the upper and lower half-spaces $\mathbb{R}^n \times (0,\infty)$ and $\mathbb{R}^n \times (-\infty,0)$; we will identify \mathbb{R}^n with $\partial \mathbb{R}^{n+1}_\pm$. If $Q \subset \mathbb{R}^n$ or $Q \subset \mathbb{R}^{n+1}$ is a cube, we will let $\ell(Q)$ be its side-length, and we let $\ell(Q)$ be the concentric cube of side-length $\ell(Q)$. If $\ell(Q)$ is a set of finite measure, we let

$$\oint_E f(x) \, dx = \frac{1}{|E|} \int_E f(x) \, dx.$$

If $f \in L^1_{loc}(\mathbb{R}^n)$, then the Hardy-Littlewood maximal function $\mathcal{M}f$ is given by

$$\mathcal{M}f(x) = \sup_{Q \ni x} \int_{Q} |f|$$

where the supremum is over all cubes $Q \subset \mathbb{R}^n$ with $x \in Q$.

If E is a measurable set, we will let $\mathbf{1}_E$ denote the characteristic function of E; that is, $\mathbf{1}_E(x) = 1$ if $x \in E$ and $\mathbf{1}_E(x) = 0$ if $x \notin E$. We will use $\mathbf{1}_{\pm}$ as a shorthand for $\mathbf{1}_{\mathbb{R}^{n+1}_+}$.

2.1. **Multiindices and arrays of functions.** We will routinely work with multiindices in $(\mathbb{N}_0)^{n+1}$. (We will occasionally work with multiindices in $(\mathbb{N}_0)^n$.) Here \mathbb{N}_0 denotes the nonnegative integers. If $\zeta = (\zeta_1, \zeta_2, \dots, \zeta_{n+1})$ is a multiindex, then we define $|\zeta|$ and ∂^{ζ} in the usual ways, as $|\zeta| = \zeta_1 + \zeta_2 + \dots + \zeta_{n+1}$ and $\partial^{\zeta} = \partial_{x_1}^{\zeta_1} \partial_{x_2}^{\zeta_2} \cdots \partial_{x_{n+1}}^{\zeta_{n+1}}$.

We will routinely deal with arrays $\dot{\mathbf{F}} = (F_{\zeta})$ of numbers or functions indexed by multiindices ζ with $|\zeta| = k$ for some $k \geq 0$. In particular, if φ is a function with weak derivatives of order up to k, then we view $\nabla^k \varphi$ as such an array.

The inner product of two such arrays of numbers \dot{F} and \dot{G} is given by

$$\left\langle \dot{\boldsymbol{F}}, \dot{\boldsymbol{G}} \right
angle = \sum_{|\zeta|=k} \overline{F_{\zeta}} \, G_{\zeta}.$$

If \dot{F} and \dot{G} are two arrays of functions defined in a set Ω in Euclidean space, then the inner product of \dot{F} and \dot{G} is given by

$$\langle \dot{F}, \dot{G} \rangle_{\Omega} = \int_{\Omega} \langle \dot{F}(X), \dot{G}(X) \rangle dX = \sum_{|\zeta|=k} \int_{\Omega} \overline{F_{\zeta}(X)} G_{\zeta}(X) dX.$$

We let \vec{e}_j be the unit vector in \mathbb{R}^{n+1} in the jth direction; notice that \vec{e}_j is a multiindex with $|\vec{e}_j| = 1$. We let \dot{e}_{ζ} be the "unit array" corresponding to the multiindex ζ ; thus, $\langle \dot{e}_{\zeta}, \dot{F} \rangle = F_{\zeta}$.

We will let ∇_{\parallel} denote either the gradient in \mathbb{R}^n , or the *n* horizontal components of the full gradient ∇ in \mathbb{R}^{n+1} . (Because we identify \mathbb{R}^n with $\partial \mathbb{R}^{n+1}_{\pm} \subset \mathbb{R}^{n+1}$, the two uses are equivalent.) If ζ is a multiindex with $\zeta_{n+1} = 0$, we will occasionally use the terminology $\partial_{\parallel}^{\zeta}$ to emphasize that the derivatives are taken purely in the horizontal directions.

2.2. Elliptic differential operators. Let $\mathbf{A} = (A_{\alpha\beta})$ be a matrix of measurable coefficients defined on \mathbb{R}^{n+1} , indexed by multtiindices α , β with $|\alpha| = |\beta| = m$. If $\dot{\mathbf{F}}$ is an array indexed by multiindices of length m, then $\mathbf{A}\dot{\mathbf{F}}$ is the array given by

$$(\mathbf{A}\dot{\mathbf{F}})_{\alpha} = \sum_{|eta|=m} A_{lphaeta} F_{eta}.$$

We let L be the 2mth-order divergence form operator associated with \boldsymbol{A} . That is, we say that

(2.1) Lu = 0 in Ω in the weak sense if $\langle \nabla^m \varphi, \mathbf{A} \nabla^m u \rangle_{\Omega} = 0$ for all $\varphi \in C_0^{\infty}(\Omega)$.

 $\|A\|_{L^{\infty}(\mathbb{R}^{n+1})} \leq \Lambda$

and the Gårding inequality

(2.2)

(2.3)
$$\operatorname{Re}\left\langle \nabla^{m}\varphi, \mathbf{A}\nabla^{m}\varphi\right\rangle_{\mathbb{R}^{n+1}} \geq \lambda \|\nabla^{m}\varphi\|_{L^{2}(\mathbb{R}^{n+1})}^{2} \text{ for all } \varphi \in \dot{W}_{m}^{2}(\mathbb{R}^{n+1})$$

for some $\Lambda > \lambda > 0$. (The stronger Gårding inequality (1.11) will not be used in the proof of Theorem 1.15 or 1.25; it was used only in the statement and proof of Theorem 1.14.)

The numbers C and ε denote constants whose value may change from line to line, but which are always positive and depend only on the dimension n+1, the order 2m of any relevant operators, and the numbers λ and Λ in the bounds (2.3) (or (1.11)) and (2.2).

2.3. Function spaces and boundary data. Let $\Omega \subseteq \mathbb{R}^n$ or $\Omega \subseteq \mathbb{R}^{n+1}$ be a measurable set in Euclidean space. We let $C_0^{\infty}(\Omega)$ be the space of all smooth functions that are compactly supported in Ω . We let $L^p(\Omega)$ denote the usual Lebesgue space with respect to Lebesgue measure with norm given by

$$||f||_{L^p(\Omega)} = \left(\int_{\Omega} |f(x)|^p dx\right)^{1/p}.$$

If Ω is a connected open set, then we let the homogeneous Sobolev space $W_k^p(\Omega)$ be the space of equivalence classes of functions u that are locally integrable in Ω and have weak derivatives in Ω of order up to k in the distributional sense, and whose kth gradient $\nabla^k u$ lies in $L^p(\Omega)$. Two functions are equivalent if their difference is a polynomial of order k-1. We impose the norm

$$||u||_{\dot{W}_k^p(\Omega)} = ||\nabla^k u||_{L^p(\Omega)}.$$

Then u is equal to a polynomial of order k-1 (and thus equivalent to zero) if and only if its $\dot{W}_k^p(\Omega)$ -norm is zero. We say that $u \in L^p_{loc}(\Omega)$ or $u \in \dot{W}_{k,loc}^p(\Omega)$ if $u \in L^p(U)$ or $u \in \dot{W}_k^p(U)$ for any bounded open set U with $\overline{U} \subset \Omega$.

We will need a number of more specialized norms on functions. The modified nontangential operator \widetilde{N}_+ was introduced in [KP93] and (in the half space) is given by

$$(2.4) \qquad \widetilde{N}_{+}H(x) = \sup \bigg\{ \bigg(\int_{B((y,s),s/2)} |H|^2 \bigg)^{1/2} : s > 0, \ y \in \mathbb{R}^n, \ |x-y| < s \bigg\}.$$

We will also use a two-sided nontangential maximal function, which we define as

$$(2.5) \quad \ \widetilde{N}_*H(x) = \sup \biggl\{ \biggl(\int_{B((y,s),|s|/2)} |H|^2 \biggr)^{1/2} : s \in \mathbb{R}, \ y \in \mathbb{R}^n, \ |x-y| < |s| \biggr\}.$$

Finally, we will use the Lusin area integral operator \mathcal{A}_2^+ given by

(2.6)
$$\mathcal{A}_2^+ H(x) = \left(\int_0^\infty \int_{|x-y| < t} |H(y,t)|^2 \frac{dy \, dt}{t^{n+1}} \right)^{1/2}.$$

2.3.1. Boundary values and boundary function spaces. Following [BHM17b], we define the boundary values $\operatorname{Tr}^{\pm} u$ of a function u defined in \mathbb{R}^{n+1}_+ by

(2.7)
$$\operatorname{Tr}^{\pm} u = \mathbf{f} \quad \text{if} \quad \lim_{t \to 0^{\pm}} \|\partial^{\gamma} u(\cdot, t) - f\|_{L^{1}(K)} = 0$$

for all compact sets $K \subset \mathbb{R}^n$. We define

(2.8)
$$\dot{\mathbf{T}}\mathbf{r}_{j}^{\pm} u = \operatorname{Tr}^{\pm} \nabla^{j} u.$$

We remark that if ∇u is locally integrable up to the boundary, then $\operatorname{Tr}^{\pm} u$ exists, and furthermore $\operatorname{Tr}^{\pm} u$ coincides with the traditional trace in the sense of Sobolev spaces.

We are interested in functions with boundary data in Lebesgue or Sobolev spaces. However, observe that if $j \geq 1$, then the components of $\mathbf{Tr}_j^{\pm}u$ are derivatives of a common function and so must satisfy certain compatibility conditions. We thus define the following Whitney-Lebesgue, Whitney-Sobolev and Whitney-Besov spaces of arrays that satisfy these conditions.

Definition 2.9. Let

$$\mathfrak{D} = \{ \dot{\mathbf{T}} \mathbf{r}_{m-1} \, \varphi : \varphi \text{ smooth and compactly supported in } \mathbb{R}^{n+1} \}.$$

If $1 \leq p < \infty$, then we let $\dot{W}A^p_{m-1,0}(\mathbb{R}^n)$ be the completion of the set \mathfrak{D} under the L^p norm. We let $\dot{W}A^p_{m-1,1}(\mathbb{R}^n)$ be the completion of \mathfrak{D} under the $\dot{W}^p_1(\mathbb{R}^n)$ norm, that is, under the norm $\|\dot{\boldsymbol{f}}\|_{\dot{W}A^p_{m-1,1}(\mathbb{R}^n)} = \|\nabla_{\parallel}\dot{\boldsymbol{f}}\|_{L^p(\mathbb{R}^n)}$.

Finally, we let $\dot{W}A^2_{m-1,1/2}(\mathbb{R}^n)$ be the completion of \mathfrak{D} under the norm in the Besov space $\dot{B}^{2,2}_{1/2}(\mathbb{R}^n)$; this norm may be written as

$$\|\dot{\boldsymbol{f}}\|_{\dot{B}^{2,2}_{1/2}(\mathbb{R}^n)} = \|\dot{\boldsymbol{f}}\|_{\dot{W}A^2_{m-1,1/2}(\mathbb{R}^n)} = \left(\sum_{|\gamma|=m-1} \int_{\mathbb{R}^n} |\widehat{f_{\gamma}}(\xi)|^2 |\xi| \, d\xi\right)^{1/2}.$$

It is widely known that $\dot{\mathbf{f}} \in \dot{W}A^2_{m-1,1/2}(\mathbb{R}^n)$ if and only if $\dot{\mathbf{f}} = \dot{\mathbf{T}}\mathbf{r}^+_{m-1}F$ for some F with $\nabla^m F \in L^2(\mathbb{R}^{n+1}_+)$.

Recall that Theorem 1.14 is concerned with Neumann boundary values $\dot{\mathbf{M}}_{A}^{+}u$ of solutions u to Lu=0. However, as discussed at the beginning of Section 1.2, Theorem 1.14 follows from Theorem 1.15 and the proof of [BHM18, Theorems 1.7]

and 1.11], and thus we will not use any particular properties of $\dot{\mathbf{M}}_{A}^{+}u$ in the proof; in this case we refer the reader to [BHM18, Section 2.3.2] for a definition of $\dot{\mathbf{M}}_{A}^{+}$.

In the proof of Lemma 5.1 below we will use some properties of $\dot{\mathbf{M}}_{A}^{-}$ from [Bar17] and [BHM17b]. In these cases we refer the reader to [BHM17b] for a definition of $\dot{\mathbf{M}}_{A}^{\pm}u$; we remark only that if $u\in \dot{W}_{m}^{2}(\mathbb{R}^{n+1}_{\pm})$ and Lu=0 in \mathbb{R}^{n+1}_{\pm} , then the definitions of $\dot{\mathbf{M}}_{A}^{\pm}u$ used in [Bar17] and in [BHM17b] coincide.

2.4. The double layer potential and the Newton potential. In this section we define the double layer potential mentioned in Theorem 1.15.

We begin by defining the related Newton potential. For any $\dot{\mathbf{H}} \in L^2(\mathbb{R}^{n+1})$, by the Lax-Milgram lemma there is a unique function $\Pi^L\dot{\mathbf{H}}$ in $\dot{W}_m^2(\mathbb{R}^{n+1})$ that satisfies

(2.10)
$$\langle \nabla^m \varphi, \mathbf{A} \nabla^m \Pi^L \dot{\mathbf{H}} \rangle_{\mathbb{R}^{n+1}} = \langle \nabla^m \varphi, \dot{\mathbf{H}} \rangle_{\mathbb{R}^{n+1}}$$

for all $\varphi \in \dot{W}_m^2(\mathbb{R}^{n+1})$. We refer to the operator Π^L as the Newton potential.

Now, suppose that $\dot{\mathbf{f}} \in \dot{W}A^2_{m-1,1/2}(\mathbb{R}^n)$. Recall that $\dot{\mathbf{f}} = \dot{\mathbf{Tr}}^+_{m-1}F$ for some $F \in \dot{W}^2_m(\mathbb{R}^{n+1}_+)$. We define

(2.11)
$$\mathcal{D}^{\mathbf{A}}\dot{\mathbf{f}} = -\mathbf{1}_{+}F + \Pi^{L}(\mathbf{1}_{+}\mathbf{A}\nabla^{m}F).$$

This operator is well-defined, that is, does not depend on the choice of F. See [Bar17, Lemma 4.2] or [BHM17c, section 2.4]. Furthermore, it is antisymmetric about exchange of \mathbb{R}^{n+1}_+ and \mathbb{R}^{n+1}_- ; that is, if $\dot{\mathbf{Tr}}_{m-1}^-F = \dot{\boldsymbol{f}}$ and $F \in \dot{W}^2_m(\mathbb{R}^{n+1}_-)$, then

(2.12)
$$\mathcal{D}^{\mathbf{A}}\dot{\mathbf{f}} = -\Pi^{L}(\mathbf{1}_{-}\mathbf{A}\nabla^{m}F) + \mathbf{1}_{-}F.$$

See [BHM17c, formula (2.27)] or [Bar17, formula (4.8)].

2.5. The single layer potential. Let $\dot{\boldsymbol{g}}$ be a bounded linear operator on the space $\dot{W}A^2_{m-1,1/2}(\mathbb{R}^n)$. Observe that $\dot{\boldsymbol{g}}$ extends to an operator on $\dot{B}^{2,2}_{1/2}(\mathbb{R}^n)$, and so $\dot{\boldsymbol{g}} \in (\dot{W}A^2_{m-1,1/2}(\mathbb{R}^n))^*$ if and only if there is a representative of $\dot{\boldsymbol{g}}$ that lies in $\dot{B}^{2,2}_{-1/2}(\mathbb{R}^n)$, that is, that satisfies

$$\left(\sum_{|\gamma|=m-1} \int_{\mathbb{R}^n} \frac{1}{|\xi|} |\widehat{g_{\gamma}}(\xi)|^2 d\xi\right)^{1/2} = \|\dot{\boldsymbol{g}}\|_{\dot{B}^{2,2}_{-1/2}(\mathbb{R}^n)} < \infty.$$

The operator $F \mapsto \langle \dot{\mathbf{T}}\mathbf{r}_{m-1} F, \dot{\boldsymbol{g}} \rangle_{\mathbb{R}^n}$ is a bounded linear operator on $\dot{W}_m^2(\mathbb{R}^{n+1})$, and so by the Lax-Milgram lemma there is a unique function $\mathcal{S}^L \dot{\boldsymbol{g}} \in \dot{W}_m^2(\mathbb{R}^{n+1})$ that satisfies

$$(2.13) \qquad \langle \nabla^m \varphi, \mathbf{A} \nabla^m \mathcal{S}^L \dot{\mathbf{g}} \rangle_{\mathbb{R}^{n+1}} = \langle \dot{\mathbf{T}} \mathbf{r}_{m-1} \varphi, \dot{\mathbf{g}} \rangle_{\mathbb{R}^n} \qquad \text{for all } \varphi \in \dot{W}_m^2(\mathbb{R}^{n+1}).$$

See [Bar17]. We remark that this definition coincides with the definition of $\mathcal{S}^L\dot{\boldsymbol{g}}$ given in [BHM17c, BHM17a]. This defines \mathcal{S}^L as a bounded operator $\dot{B}^{2,2}_{-1/2}(\mathbb{R}^n) \mapsto \dot{W}^2_m(\mathbb{R}^{n+1})$; by [BHM18, formula (4.3)] (see Section 4.1 below) we have that \mathcal{S}^L extends by density to an operator that is bounded $L^2(\mathbb{R}^n) \mapsto \dot{W}^2_m(\mathbb{R}^n \times (a,b))$ for any numbers $-\infty < a < b < \infty$.

As observed in [BHM17a, formula (2.23)], if $\dot{\boldsymbol{g}} \in \dot{B}^{2,2}_{-1/2}(\mathbb{R}^n)$ and if $|\alpha| = m$, then for almost every $(x,t) \in \mathbb{R}^{n+1}$ we have that

(2.14)
$$\partial^{\alpha} \mathcal{S}^{L} \dot{\boldsymbol{g}}(x,t) = \sum_{|\zeta|=m-1} \int_{\mathbb{R}^{n}} \partial_{x,t}^{\alpha} \partial_{y,s}^{\zeta} E^{L}(x,t,y,0) g_{\zeta}(y) dy$$

where E^L is the fundamental solution for the operator L constructed in [Bar16]. By the bound [Bar16, formula (63)] (reproduced as formula (3.7) below), for almost every $(x,t) \in \mathbb{R}^{n+1}_{\pm}$ we have that $\partial_{x,t}^{\alpha} E^L(x,t,\cdot,\cdot) \in \dot{W}_m^2(\mathbb{R}^{n+1}_{\mp})$ and so $v(y) = \partial_{x,t}^{\alpha} \partial_{y,s}^{\zeta} E^L(x,t,y,0)$ lies in $\dot{B}_{1/2}^{2,2}(\mathbb{R}^n)$. Thus, the right hand side converges provided $g_{\zeta} \in \dot{B}_{-1/2}^{2,2}(\mathbb{R}^n)$.

As in [BHM17a, formula (2.27)], if $|\gamma| = m - 1$, then we define

(2.15)
$$\partial^{\gamma} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}}(x,t) = \sum_{|\beta|=m} \int_{\mathbb{R}^{n}} \partial_{x,t}^{\gamma} \partial_{y,s}^{\beta} E^{L}(x,t,y,0) h_{\beta}(y) dy.$$

We will see (Lemma 4.4 below) that if $\dot{\boldsymbol{h}} \in L^2(\mathbb{R}^n)$, then the integral converges absolutely for almost every $(x,t) \in \mathbb{R}^{n+1}$, and the functions $\partial^{\gamma} \mathcal{S}^{L}_{\nabla} \dot{\boldsymbol{h}}$ given by formula (2.15) are indeed derivatives of a common $\dot{W}^2_{m-1,loc}(\mathbb{R}^n)$ -function that we may call $\mathcal{S}^{L}_{\nabla} \dot{\boldsymbol{h}}$.

3. Preliminaries

In Section 4, we will establish the bounds (1.16), (1.17), (1.26), and (1.27) on the single layer potential. In Section 5, we will establish the bounds (1.18), (1.19), (1.28), and (1.29) on the double layer potential. In this section, we will collect some known results and establish some preliminary estimates that will be of use in both Section 4 and Section 5.

3.1. **Regularity results.** We begin by recalling some known regularity results for solutions to elliptic differential equations.

The following lemma is the higher order analogue of the Caccioppoli inequality. It was proven in full generality in [Bar16] and some important preliminary versions were established in [Cam80, AQ00].

Lemma 3.1 (The Caccioppoli inequality). Let L be an operator of the form (1.1) of order 2m associated to coefficients \mathbf{A} that satisfy the bounds (2.2) and (2.3). Let $u \in \dot{W}_m^2(B(X_0, 2r))$ with Lu = 0 in $B(X_0, 2r)$.

Then we have the bound

$$\int_{B(X,r)} |\nabla^{j} u(x,s)|^{2} dx ds \leq \frac{C}{r^{2}} \int_{B(X,2r)} |\nabla^{j-1} u(x,s)|^{2} dx ds$$

for any j with $1 \le j \le m$.

We next state the higher order generalization of Meyers's reverse Hölder inequality for gradients. The k=0 case of the bound (3.3) was established in [Cam80, AQ00]. The $k\geq 1$ case was established in [Bar16] and is a relatively straightforward consequence of the k=0 case and the Gagliardo-Nirenberg-Sobolev inequality.

Theorem 3.2. Let L be an operator of the form (1.1) of order 2m associated to coefficients A that satisfy the bounds (2.2) and (2.3). Let $X_0 \in \mathbb{R}^{n+1}$ and let r > 0. Suppose that $u \in \dot{W}_m^2(B(X_0, 2r))$ with Lu = 0 in $B(X_0, 2r)$.

If k is an integer with $0 \le k \le m$ and 2k < n+1, then there is a number $p_k^+ = p_{L,k}^+ > 2(n+1)/(n+1-2k)$, depending only on the standard constants, such that if 0 , then

$$(3.3) \qquad \left(\int_{B(X_0,r)} |\nabla^{m-k}u|^q\right)^{1/q} \le \frac{C_{p,q}}{r^{(n+1)/p-(n+1)/q}} \left(\int_{B(X_0,2r)} |\nabla^{m-k}u|^p\right)^{1/p}$$

for some constant $C_{p,q}$ depending only on p, q and the standard constants.

If $0 \le m - k \le m - (n+1)/2$, then $\nabla^{m-k}u$ is Hölder continuous and satisfies the bound

(3.4)
$$\sup_{B(X_0,r)} |\nabla^{m-k} u| \le \frac{C_p}{r^{(n+1)/p}} \left(\int_{B(X_0,2r)} |\nabla^{m-k} u|^p \right)^{1/p}$$

for all 0 .

Finally, if A is t-independent then solutions to Lu=0 have additional regularity. The following lemma was proven in the case m=1 in [AAA⁺11, Proposition 2.1] and generalized to the case $m \geq 2$ in [BHM17a, Lemma 3.20].

Lemma 3.5. Let L be an operator of the form (1.1) of order 2m associated to t-independent coefficients A that satisfy the bounds (2.2) and (2.3). Let $t \in \mathbb{R}$ be a constant, and let $Q \subset \mathbb{R}^n$ be a cube.

If Lu = 0 in $2Q \times (t - \ell(Q), t + \ell(Q))$, then

$$\int_{Q} |\nabla^{j} \partial_{t}^{k} u(x,t)|^{p} dx \leq \frac{C_{p}}{\ell(Q)} \int_{2Q} \int_{t-\ell(Q)}^{t+\ell(Q)} |\nabla^{j} \partial_{s}^{k} u(x,s)|^{p} ds dx$$

for any $0 \le j \le m$, any $0 , and any integer <math>k \ge 0$, where p_{m-j}^+ is as in Theorem 3.2.

3.2. **The fundamental solution.** Recall from formula (2.14) that the single layer potential, originally constructed via the Lax-Milgram lemma, has an explicit representation as an integral operator involving the fundamental solution. We will often make use of this representation; thus, we now state the following result of [Bar16] concerning the fundamental solution for higher order operators.

Theorem 3.6 ([Bar16, Theorem 62 and Lemma 69]). Let L be an operator of the form (1.1) of order 2m associated to coefficients \boldsymbol{A} that satisfy the bounds (2.2) and (2.3). Then there exists a function $E^L(X,Y)$ with the following properties.

Let s = 0 or s = 1 and let q = 0 or q = 1. There is some $\varepsilon > 0$ such that if X_0 , $Y_0 \in \mathbb{R}^{n+1}$, if $0 < r < R < |X_0 - Y_0|/3$, and if either q = 0 or $n + 1 \ge 3$, then

$$(3.7) \qquad \int_{B(Y_0,r)} \int_{B(X_0,R)} |\nabla_X^{m-s} \nabla_Y^{m-q} E^L(X,Y)|^2 \, dX \, dY \le C r^{2q} R^{2s} \left(\frac{r}{R}\right)^{\varepsilon}.$$

If 2q = 2 = n + 1 then we instead have the bound

$$(3.8) \qquad \int_{B(Y_0,r)} \int_{B(X_0,R)} |\nabla_X^{m-s} \nabla_Y^{m-1} E^L(X,Y)|^2 dX dY \le C_\delta r^2 R^{2s} \left(\frac{R}{r}\right)^{\delta}$$

for all $\delta > 0$ and some constant C_{δ} depending on δ .

We have the symmetry property

(3.9)
$$\partial_Y^{\zeta} \partial_Y^{\xi} E^L(X, Y) = \overline{\partial_Y^{\zeta} \partial_Y^{\xi} E^{L^*}(Y, X)}$$

as locally L^2 functions, for all multiindices ζ , ξ with $m-1 \le |\zeta| \le m$, $m-1 \le |\xi| < m$.

Furthermore, if $|\alpha| = m$ then

(3.10)
$$\partial^{\alpha} \Pi^{L} \dot{\mathbf{H}}(X) = \sum_{|\beta|=m} \int_{\mathbb{R}^{n+1}} \partial_{X}^{\alpha} \partial_{Y}^{\beta} E^{L}(X, Y) H_{\beta}(Y) dY$$

for almost every $X \notin \text{supp } \dot{\mathbf{H}}$, and for all $\dot{\mathbf{H}} \in L^2(\mathbb{R}^{n+1})$ whose support is not all of \mathbb{R}^{n+1} .

Finally, if \widetilde{E}^L is any other function that satisfies the bounds (3.7), (3.8) and formula (3.10), then

$$\nabla_X^{m-q} \nabla_Y^{m-s} \widetilde{E}^L(X, Y) = \nabla_X^{m-q} \nabla_Y^{m-s} E^L(X, Y)$$

as locally L^2 functions provided $0 \le q \le 1$ and $0 \le s \le 1$.

Here Π^L is the Newton potential defined by formula (2.10).

We remark that in particular, if ξ is a multiindex with $m-1 \leq |\xi| \leq m$, and if we let

$$u(z,r) = \partial_{y,s}^\xi E^L(z,r,y,s), \quad v(z,r) = \partial_{x,t}^\xi E^L(x,t,z,r)$$

then $u \in \dot{W}^2_{m,loc}(\mathbb{R}^{n+1} \setminus \{(y,s)\})$ and $v \in \dot{W}^2_{m,loc}(\mathbb{R}^{n+1} \setminus \{(x,t)\})$ for almost every $(x,t) \in \mathbb{R}^{n+1}$ and $(y,s) \in \mathbb{R}^{n+1}$, and furthermore

$$Lu = 0 \text{ in } \mathbb{R}^{n+1} \setminus \{(y, s)\}, \qquad L^*v = 0 \text{ in } \mathbb{R}^{n+1} \setminus \{(x, t)\}.$$

In particular, we may apply Lemma 3.5 to the fundamental solution in either the first or second variables.

By uniqueness of the fundamental solution, if \boldsymbol{A} is t-independent, and if $m-1 \le |\zeta| \le m$ and $m-1 \le |\xi| \le m$, then

$$\partial_{x,t}^{\xi} \partial_{y,s}^{\zeta} E^L(x,t+r,y,s+r) = \partial_{x,t}^{\xi} \partial_{y,s}^{\zeta} E^L(x,t,y,s)$$

and so

(3.13)
$$\partial_t \partial_{x,t}^{\xi} \partial_{y,s}^{\zeta} E^L(x,t,y,s) = -\partial_s \partial_{x,t}^{\xi} \partial_{y,s}^{\zeta} E^L(x,t,y,s).$$

3.3. The lower half space. Recall that Theorem 1.15 involves bounds on the quantities $\widetilde{N}_+(\nabla^{m-k}u)$ and $\mathcal{A}_2^+(t\nabla^m\partial_t^ku)$, where k=0 or k=1 and where u denotes various potentials. It is notationally convenient to work only in the upper half space.

However, estimates in terms of the two-sided nontangential maximal operator \widetilde{N}_* defined in formula (2.5) will also be of use. In particular, in Lemma 3.20 we will pass from bounds on $\widetilde{N}_*(\nabla^{m-1}u)$ to bounds on $\mathcal{A}_2^+(t\nabla^m u)$, and in Lemma 4.17 we will pass from bounds on $\widetilde{N}_*(\partial_{n+1}^m \mathcal{S}^L \dot{\boldsymbol{g}})$ to bounds on $\widetilde{N}_+(\nabla^m \mathcal{S}^L \dot{\boldsymbol{g}})$.

We observe that we may easily translate bounds valid in the upper half space to bounds valid in the lower half space, using the following argument.

Let $A_{\alpha\beta}^- = (-1)^{\alpha_{n+1}+\beta_{n+1}} A_{\alpha\beta}$. Observe that if \mathbf{A} is bounded or t-independent then so is \mathbf{A}^- . Let φ and u be scalar valued functions defined on \mathbb{R}^{n+1} and let

 $\varphi^-(x,t)=\varphi(x,-t),\ u^-(x,t)=u(x,-t).$ A straightforward change of variables argument establishes that

$$\langle \nabla^m \varphi, \mathbf{A} \nabla^m u \rangle_{\mathbb{R}^{n+1}} = \langle \nabla^m \varphi^-, \mathbf{A}^- \nabla^m u^- \rangle_{\mathbb{R}^{n+1}}.$$

Choosing $u = \varphi$, we see that if A satisfies the ellipticity condition (2.3) then so does A^- .

Let $\dot{\mathbf{H}} \in L^2(\mathbb{R}^{n+1})$ and let $u = \Pi^L \dot{\mathbf{H}}$. Because $\Pi^L \dot{\mathbf{H}}$ is the unique solution to the problem (2.10), we have that if $H_{\alpha}^-(x,t) = (-1)^{\alpha_{n+1}} H_{\alpha}(x,-t)$, then

(3.14)
$$\Pi^{L} \dot{\mathbf{H}}(x, -t) = \Pi^{L^{-}} \dot{\mathbf{H}}^{-}(x, t).$$

By the definition (2.11) of the double layer potential and formula (2.12),

(3.15)
$$\mathcal{D}^{\mathbf{A}}\dot{\mathbf{f}}(x,-t) = -\mathcal{D}^{\mathbf{A}^{-}}\dot{\mathbf{f}}^{-}(x,t)$$

where if $\dot{\mathbf{f}} = \mathbf{\dot{T}r}_{m-1} F$, then $\dot{\mathbf{f}}^- = \mathbf{\dot{T}r}_{m-1} F^-$. Similarly, by formula (2.13), if $g_{\gamma}^-(x) = (-1)^{\gamma_{n+1}} g_{\gamma}(x)$, then

(3.16)
$$\mathcal{S}^{L}\dot{\boldsymbol{g}}(x,-t) = \mathcal{S}^{L^{-}}\dot{\boldsymbol{g}}^{-}(x,t).$$

We may establish the similar formula

(3.17)
$$\mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}}(x, -t) = \mathcal{S}_{\nabla}^{L^{-}} \dot{\boldsymbol{h}}^{-}(x, t),$$

where $h_{\beta}^{-} = (-1)^{\beta_{n+1}} h_{\beta}$, using either uniqueness of the fundamental solution, or using formulas (4.5) and (4.6) below.

Thus, we may easily pass from bounds in the upper half space to bounds in the lower half space.

3.4. **Nontangential bounds.** In Sections 4 and 5 we will use the following two lemmas to establish nontangential bounds.

Lemma 3.18. If $F \in L^2_{loc}(\mathbb{R}^{n+1}_+)$ and $x_0 \in \mathbb{R}^n$, then

$$\widetilde{N}_{+}F(x_{0}) \leq C \sup_{t_{0}>0} \left(\oint_{Q(x_{0},t_{0})} \int_{t_{0}/6}^{t_{0}/2} |F|^{2} \right)^{1/2}$$

where $Q(x_0, t_0)$ is the cube in \mathbb{R}^n with midpoint x_0 and side length t_0 .

Proof. Recall from the definition (2.4) that

$$\widetilde{N}_{+}F(x_{0}) = \sup \left\{ \left(\int_{B((y,t_{0}/3),t_{0}/6)} |F|^{2} \right)^{1/2} : |x-y| < t_{0}/3 \right\}.$$

But $B((y,t_0/3),t_0/6) \subset Q(x_0,t_0) \times (t_0/6,t_0/2)$, and so

$$\widetilde{N}_{+}F(x_{0}) \leq \sup_{t_{0}>0} \left(\frac{6^{n+1}}{\omega_{n+1}t_{0}^{n+1}} \int_{Q(x_{0},t_{0})} \int_{t_{0}/6}^{t_{0}/2} |F|^{2}\right)^{1/2}$$

where ω_{n+1} is the volume of the unit ball in \mathbb{R}^{n+1} , as desired

The following lemma is very useful for bounding solutions in cubes, and in particular in $Q(x_0, t_0) \times (t_0/6, 7t_0/6)$ or in $Q(x_0, t_0) \times (-t_0/2, t_0/2)$.

Lemma 3.19. Let L be an operator of the form (1.1) of order 2m associated to t-independent coefficients A that satisfy the bounds (2.2) and (2.3).

Let $Q \subset \mathbb{R}^n$ be a cube and let $\widetilde{Q} = Q \times (s_0 - \ell(Q)/2, s_0 + \ell(Q)/2)$ be a cube in \mathbb{R}^{n+1} .

Suppose that $u \in \dot{W}_m^2(2\widetilde{Q})$ and that Lu = 0 in $2\widetilde{Q}$. Let $0 \le j \le m$, and let $s_0 - \ell(Q)/2 \le \tau \le s_0 + \ell(Q)/2$. Then

$$\int_{\widetilde{Q}} |\nabla^j u(x,t)|^2 \, dt \, dx \leq C \ell(Q)^2 \left(\int_{2\widetilde{Q}} |\partial_t^{j+1} u(x,t)| \, dt \, dx \right)^2 + C \left(\int_{2Q} |\nabla^j u(x,\tau)| \, dx \right)^2.$$

Proof. Let $0 \le k \le j$. Let $\varepsilon > 0$ be a small positive number and let $\widetilde{Q}_k = (1 + k\varepsilon)\widetilde{Q}$. By Theorem 3.2,

$$\int_{\widetilde{Q}_k} |\nabla^{j-k} \partial_t^k u(x,t)|^2 dt dx \le C_{\varepsilon} \left(\int_{\widetilde{Q}_{k+1/2}} |\nabla^{j-k} \partial_t^k u(x,t)| dt dx \right)^2.$$

If $(x,t) \in \widetilde{Q}_{k+1/2}$, then

$$\begin{split} |\nabla^{j-k}\partial_t^k u(x,t)|^2 &\leq |\nabla^{j-k}\partial_t^k u(x,t) - \nabla^{j-k}\partial_t^k u(x,\tau)| + |\nabla^{j-k}\partial_t^k u(x,\tau)| \\ &\leq C \int_{s_0-\ell(Q_{k+1/2})/2}^{s_0+\ell(Q_{k+1/2})/2} |\nabla^{j-k}\partial_t^{k+1} u(x,t)| \, dt + |\nabla^{j-k}\partial_t^k u(x,\tau)|. \end{split}$$

Thus, by Hölder's inequality

$$\int_{\widetilde{Q}_k} |\nabla^{j-k} \partial_t^k u(x,t)|^2 dt dx \le C_{\varepsilon} \ell (Q_{k+1/2})^2 \int_{\widetilde{Q}_{k+1/2}} |\nabla^{j-k} \partial_t^{k+1} u(x,t)|^2 dt dx
+ C_{\varepsilon} \left(\int_{Q_{k+1/2}} |\nabla^{j-k} \partial_t^k u(x,0)| dx \right)^2.$$

If $k \leq j-1$, then by the Caccioppoli inequality,

$$\oint_{\widetilde{Q}_k} |\nabla^{j-k} \partial_t^k u(x,t)|^2 dt dx \le C_{\varepsilon} \oint_{\widetilde{Q}_{k+1}} |\nabla^{j-k-1} \partial_t^{k+1} u(x,t)|^2 dt dx
+ C_{\varepsilon} \left(\oint_{Q_{k+1}} |\nabla^{j-k} \partial_t^k u(x,\tau)| dx \right)^2.$$

Iterating, we see that

$$\int_{\widetilde{Q}} |\nabla^{j} u(x,t)|^{2} dt dx \leq C_{\varepsilon} \ell(Q_{j+1/2})^{2} \int_{\widetilde{Q}_{j+1/2}} |\partial_{t}^{j+1} u(x,t)|^{2} dt dx
+ C_{\varepsilon} \left(\int_{Q_{j+1/2}} |\nabla^{j} u(x,0)| dx \right)^{2}.$$

A final application of Theorem 3.2 yields that

$$\oint_{\widetilde{Q}} |\nabla^{j} u(x,t)|^{2} dt dx \leq C_{\varepsilon} \ell(Q_{j+1/2})^{2} \left(\oint_{\widetilde{Q}_{j+1}} |\partial_{t}^{j+1} u(x,t)| dt dx \right)^{2} + C_{\varepsilon} \left(\oint_{Q_{j+1/2}} |\nabla^{j} u(x,0)| dx \right)^{2}.$$

Letting $\varepsilon = 1/(j+1)$ and so $Q_{j+1} = 2Q$ completes the proof.

3.5. Area integral bounds. We will use the following lemma to establish the area integral bounds in Theorem 1.25.

Lemma 3.20. Let $\dot{\boldsymbol{u}} \in L^2_{loc}(\mathbb{R}^{n+1}_{\pm})$ satisfy $\mathcal{A}^+_2(t\dot{\boldsymbol{u}}) \in L^2(\mathbb{R}^n)$. Suppose that there is a nonnegative real-valued function φ defined on \mathbb{R}^n , and a family of functions $\dot{\boldsymbol{u}}_Q$ indexed by cubes $Q \subset \mathbb{R}^n$, such that if $Q \subset \mathbb{R}^n$ is a cube, then

$$\|\mathcal{A}_2^+(t\dot{\boldsymbol{u}}_Q)\|_{L^2(\mathbb{R}^n)}^2 + \int_{(3/2)Q} \int_0^{\ell(Q)/4} |\dot{\boldsymbol{u}}(x,t) - \dot{\boldsymbol{u}}_Q(x,t)|^2 t \, dt \, dx \leq \|\varphi\|_{L^2(4Q)}^2.$$

Then there is some $\varepsilon > 0$ such that

$$\|\mathcal{A}_{2}^{+}(t\,\dot{\boldsymbol{u}})\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p} \|\varphi\|_{L^{p}(\mathbb{R}^{n})}$$

for any $2 \le p < 2 + \varepsilon$.

In particular, let L be an operator of the form (1.1) of order 2m associated to t-independent coefficients A that satisfy the bounds (2.2) and (2.3), and let $u \in \dot{W}^2_{m,loc}(\mathbb{R}^{n+1}_+ \cup \mathbb{R}^{n+1}_-)$. If for each cube $Q \subset \mathbb{R}^n$ there is a function u_Q such that $u - u_Q \in \dot{W}^2_m(3Q \times (-\ell(Q), \ell(Q)))$ and $L(u - u_Q) = 0$ in $3Q \times (-\ell(Q), \ell(Q))$, and if

$$\|\mathcal{A}_{2}^{+}(t\nabla^{m}u_{Q})\|_{L^{2}(\mathbb{R}^{n})}^{2} + \|\widetilde{N}_{*}(\nabla^{m-1}u_{Q})\|_{L^{2}(\mathbb{R}^{n})}^{2} \leq \|\psi\|_{L^{2}(4Q)}^{2},$$

then there is some $\varepsilon > 0$ such that

$$\|\mathcal{A}_{2}^{+}(t\,\nabla^{m}u)\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p}\|\psi\|_{L^{p}(\mathbb{R}^{n})} + C_{p}\|\widetilde{N}_{*}(\nabla^{m-1}u)\|_{L^{p}(\mathbb{R}^{n})}$$

for any $2 \le p < 2 + \varepsilon$.

We will use the following lemma.

Lemma 3.21 ([Iwa98, Lemma 3.2]). Suppose that $g, h \in L^q(\mathbb{R}^n)$ are nonnegative real-valued functions, $1 < q < \infty$, and that for some $C_0 > 0$ and for all cubes $Q \subset \mathbb{R}^n$,

$$\left(\oint_{Q} g^{q} \right)^{1/q} \le C_0 \oint_{4Q} g + \left(\oint_{4Q} h^{q} \right)^{1/q}.$$

Then there exist numbers s > q and C > 0 depending only on n, q and C_0 such that if $h \in L^s(\mathbb{R}^n)$, then

$$\int_{\mathbb{R}^n} g^s \le C \int_{\mathbb{R}^n} h^s.$$

We remark that the assumption $h \in L^q(\mathbb{R}^n)$ is not necessary; it suffices to require $h \in L^q_{loc}(\mathbb{R}^n)$. To see this, we may, for example, use a local version of this lemma (e.g., [Iwa98, Proposition 6.1]) in larger and larger localized regions.

Proof of Lemma 3.20. We begin with the special case where Lu = 0. By the Caccioppoli inequality,

$$\int_{(3/2)Q} \int_0^{\ell(Q)/4} |\nabla^m (u - u_Q)(x, t)|^2 dt dx$$

$$\leq \frac{C}{\ell(Q)^2} \int_{3Q} \int_{-\ell(Q)}^{\ell(Q)} |\nabla^{m-1} (u - u_Q)(y, t)|^2 dy dt.$$

It is straightforward to bound the right hand side by $\widetilde{N}_*(\nabla^{m-1}(u-u_Q))$, and so

$$\frac{\ell(Q)}{4} \int_{(3/2)Q} \int_0^{\ell(Q)/4} |\nabla^m (u - u_Q)(x, t)|^2 dt dx
\leq C \int_{3Q} (\widetilde{N}_* (\nabla^{m-1} u)^2 + \widetilde{N}_* (\nabla^{m-1} u_Q)^2).$$

By assumption, and because $0 < t < \ell(Q)/4$ in the region of integration, we have that

$$\|\mathcal{A}_{2}^{+}(t\nabla^{m}u_{Q})\|_{L^{2}(\mathbb{R}^{n})}^{2} + \int_{(3/2)Q} \int_{0}^{\ell(Q)/4} |\nabla^{m}(u - u_{Q})(x, t)|^{2} t \, dt \, dx$$

$$\leq C \int_{3Q} (\widetilde{N}_{*}(\nabla^{m-1}u)^{2}) + C \int_{4Q} \psi^{2}.$$

Choosing $\varphi^2 = C\psi^2 + C\widetilde{N}_*(\nabla^{m-1}u)^2$, $\dot{\boldsymbol{u}} = \nabla^m u$ and $\dot{\boldsymbol{u}}_Q = \nabla^m u_Q$, we may reduce to the general case.

We now turn to the general case. Let $Q \subset \mathbb{R}^n$ be a cube. By definition of \mathcal{A}_2^+ ,

$$\int_{Q} \mathcal{A}_{2}^{+}(t\,\dot{\boldsymbol{u}})(x)^{2}\,dx = \int_{Q} \int_{0}^{\infty} \int_{|x-y|< t} |\dot{\boldsymbol{u}}(y,t)|^{2} \frac{1}{t^{n-1}}\,dy\,dt\,dx.$$

We consider the cases $t > \ell(Q)/4$ and $t \le \ell(Q)/4$ separately, so

$$\int_{Q} \mathcal{A}_{2}^{+}(t\,\dot{\boldsymbol{u}})(x)^{2}\,dx \leq \int_{Q} \int_{0}^{\ell(Q)/4} \int_{|x-y|< t} |\dot{\boldsymbol{u}}(y,t)|^{2} \frac{1}{t^{n-1}}\,dy\,dt\,dx \\
+ \int_{Q} \int_{\ell(Q)/4}^{\infty} \int_{|x-y|< t} |\dot{\boldsymbol{u}}(y,t)|^{2} \frac{1}{t^{n-1}}\,dy\,dt\,dx.$$

The first term satisfies

$$\begin{split} \int_{Q} \int_{0}^{\ell(Q)/4} \int_{|x-y| < t} |\dot{\boldsymbol{u}}(y,t)|^{2} \frac{1}{t^{n-1}} \, dy \, dt \, dx \\ & \leq 2 \int_{Q} \int_{0}^{\ell(Q)/4} \int_{|x-y| < t} |\dot{\boldsymbol{u}}_{Q}(y,t)|^{2} \frac{1}{t^{n-1}} \, dy \, dt \, dx \\ & + 2 \int_{Q} \int_{0}^{\ell(Q)/4} \int_{|x-y| < t} |\dot{\boldsymbol{u}}(y,t) - \dot{\boldsymbol{u}}_{Q}(y,t)|^{2} \frac{1}{t^{n-1}} \, dy \, dt \, dx. \end{split}$$

But

$$\int_{Q} \int_{0}^{\ell(Q)/4} \int_{|x-y| < t} |\dot{\boldsymbol{u}}_{Q}(y,t)|^{2} \frac{1}{t^{n-1}} \, dy \, dt \, dx \leq \int_{\mathbb{R}^{n}} \mathcal{A}_{2}^{+} (t \dot{\boldsymbol{u}}_{Q})^{2} \leq \int_{4Q} \varphi^{2}.$$

We have that

$$\int_{Q} \int_{0}^{\ell(Q)/4} \int_{|x-y|$$

By assumption the right hand side is bounded. Thus,

$$\int_{Q} \mathcal{A}_{2}^{+}(t\,\dot{\boldsymbol{u}})(x)^{2}\,dx \leq C\int_{4Q} \varphi^{2} + \int_{Q} \int_{\ell(Q)/4}^{\infty} \int_{|x-y|< t} |\dot{\boldsymbol{u}}(y,t)|^{2} \frac{1}{t^{n-1}}\,dy\,dt\,dx.$$

Suppose that $x \in Q$, that t > 0, and that |x - y| < t. Then $\operatorname{dist}(y, (3/2)Q) \le \max(0, t - \ell(Q)/4)$, and so

$$\int_{Q} \int_{\ell(Q)/4}^{\infty} \int_{|x-y| < t} |\dot{\boldsymbol{u}}(y,t)|^{2} \frac{1}{t^{n-1}} dy dt dx
\leq |Q| \int_{\ell(Q)/4}^{\infty} \int_{\text{dist}(y,(3/2)Q) < t-\ell(Q)/4} |\dot{\boldsymbol{u}}(y,t)|^{2} \frac{1}{t^{n-1}} dy dt.$$

Let \mathcal{G} be a grid of $(3N/2)^n$ cubes contained in (3/2)Q with side-length $\ell(Q)/N$ and pairwise-disjoint interiors, for N a large even integer to be chosen momentarily. Then

$$\begin{split} |Q| \int_{\ell(Q)/4}^{\infty} \int_{\mathrm{dist}(y,(3/2)Q) < t - \ell(Q)/4} |\dot{\boldsymbol{u}}(y,t)|^2 \, \frac{1}{t^{n-1}} \, dy \, dt \\ & \leq |Q| \sum_{R \in \mathcal{G}} \int_{\ell(Q)/4}^{\infty} \int_{\mathrm{dist}(y,R) < t - \ell(Q)/4} |\dot{\boldsymbol{u}}(y,t)|^2 \, \frac{1}{t^{n-1}} \, dy \, dt. \end{split}$$

If $z \in R$ and $\operatorname{dist}(y,R) < t - \ell(Q)/4$, then $|z-y| < t - \ell(Q)/4 + \ell(R)\sqrt{n} = t + \ell(Q)(\sqrt{n}/N - 1/4)$. Choosing $N \ge 4\sqrt{n}$, we see that for any $z \in R$,

$$\begin{split} \int_{\ell(Q)/4}^{\infty} \int_{\mathrm{dist}(y,R) < t - \ell(Q)/4} |\dot{\boldsymbol{u}}(y,t)|^2 \, \frac{1}{t^{n-1}} \, dy \, dt \\ & \leq \int_{\ell(Q)/4}^{\infty} \int_{|z-y| < t} |\dot{\boldsymbol{u}}(y,t)|^2 \, \frac{1}{t^{n-1}} \, dy \, dt \leq \mathcal{A}_2^+(t \, \dot{\boldsymbol{u}})(z)^2. \end{split}$$

Averaging over all $z \in R$, we see that

$$|Q| \sum_{R \in \mathcal{G}} \int_{\ell(Q)/4}^{\infty} \int_{\text{dist}(y,R) < t - \ell(Q)/4} |\dot{\boldsymbol{u}}(y,t)|^2 \frac{1}{t^{n-1}} \, dy \, dt$$

$$\leq |Q| \sum_{R \in \mathcal{G}} \left(\int_{R} \mathcal{A}_2^+(t \, \dot{\boldsymbol{u}})(z) \, dz \right)^2 \leq |Q| (3N/2)^n \left(\frac{|2Q|}{|R|} \int_{2Q} \mathcal{A}_2^+(t \, \dot{\boldsymbol{u}})(z) \, dz \right)^2$$

and so

$$\int_{Q} \int_{\ell(Q)/4}^{\infty} \int_{|x-y| < t} |\dot{\boldsymbol{u}}(y,t)|^{2} \frac{1}{t^{n-1}} \, dy \, dt \, dx \le C|Q| \left(\oint_{2Q} \mathcal{A}_{2}^{+}(t \, \dot{\boldsymbol{u}})(z) \, dz \right)^{2}.$$

Thus

$$\int_{Q} \mathcal{A}_{2}^{+}(t\,\dot{\boldsymbol{u}})(x)^{2}\,dx \leq C\int_{4Q} \varphi^{2} + C|Q| \left(\oint_{2Q} \mathcal{A}_{2}^{+}(t\,\dot{\boldsymbol{u}})(z)\,dz \right)^{2}.$$

By Lemma 3.21, there is some p > 2 depending on n and C such that

$$\int_{\mathbb{R}^n} \mathcal{A}_2^+(t\,\dot{\boldsymbol{u}})(x)^p\,dx \le C \int_{\mathbb{R}^n} \varphi^p$$

as desired.

4. The single layer potential

In this section we will establish the nontangential estimates (1.16-1.17) and area integral estimates (1.26-1.27) on the single layer potential (and modified single layer potential).

We will begin (Sections 4.1 and 4.2) by showing that \mathcal{S}^L and \mathcal{S}^L_{∇} are well defined operators from $L^2(\mathbb{R}^n)$ to $\dot{W}^2_{m,loc}(\mathbb{R}^{n+1}_{\pm})$ and $\dot{W}^2_{m-1,loc}(\mathbb{R}^{n+1}_{\pm})$, respectively, and recalling or establishing some bounds on $\mathcal{S}^L\dot{\boldsymbol{g}}$ and $\mathcal{S}^L_{\nabla}\dot{\boldsymbol{h}}$ in the cases $\dot{\boldsymbol{g}}$, $\dot{\boldsymbol{h}}\in L^2(\mathbb{R}^n)$. In particular, we will show that the boundary operators $\dot{\mathbf{T}}\mathbf{r}^{\pm}_m\mathcal{S}^L$ and $\dot{\mathbf{T}}\mathbf{r}^{\pm}_{m-1}\mathcal{S}^L_{\nabla}$ are bounded from $L^2(\mathbb{R}^n)$ to itself.

In Section 4.3, we will show that if the order 2m of the operator L is high enough, then the boundary operators $\mathbf{\dot{T}r}_{m}^{\pm} \mathcal{S}^{L}$ and $\mathbf{\dot{T}r}_{m-1}^{\pm} \mathcal{S}^{L}_{\nabla}$ are also bounded from $L^{p}(\mathbb{R}^{n})$ to itself, for p near but not necessarily equal to 2. In Section 4.4 we will pass to the case of operators L of lower order, and finally in Section 4.5 will pass from boundary estimates to nontangential (and area integral) estimates.

4.1. \mathcal{S}^L as an operator on $L^2(\mathbb{R}^n)$. Recall from the definition (2.13) that the single layer potential \mathcal{S}^L was originally defined as an operator from $(\dot{W}A^2_{m-1,1/2}(\mathbb{R}^n))^*$ (or $\dot{B}^{2,2}_{-1/2}(\mathbb{R}^n)$) to $\dot{W}^2_m(\mathbb{R}^{n+1})$. Suppose that $\dot{\boldsymbol{g}} \in \dot{B}^{2,2}_{-1/2}(\mathbb{R}^n) \cap L^2(\mathbb{R}^n)$. Then by [BHM18, formula (4.5)], we have that

(4.1)
$$\sup_{t \neq 0} \|\nabla^m \mathcal{S}^L \dot{\boldsymbol{g}}(\cdot, t)\|_{L^2(\mathbb{R}^n)} \leq C \|\dot{\boldsymbol{g}}\|_{L^2(\mathbb{R}^n)}.$$

Because $\dot{B}^{2,2}_{-1/2}(\mathbb{R}^n) \cap L^2(\mathbb{R}^n)$ is dense in $L^2(\mathbb{R}^n)$, we have that $\mathcal{S}^L\dot{\boldsymbol{g}}$ extends to an operator that is bounded from $L^2(\mathbb{R}^n)$ to $\dot{W}^2_m(\mathbb{R}^n\times(a,b))$ for any $-\infty < a < b < \infty$. We have some further properties of $\mathcal{S}^L\dot{\boldsymbol{g}}$ for $\dot{\boldsymbol{g}} \in L^2(\mathbb{R}^n)$.

By Lemma 3.5 and the bound (3.7), if $\dot{\boldsymbol{g}} \in L^2(\mathbb{R}^n)$ is compactly supported then the integral in formula (2.14) for $\nabla^m \mathcal{S}^L \dot{\boldsymbol{g}}(x,t)$ converges absolutely for almost every $(x,t) \in \mathbb{R}^{n+1}_{\pm}$; by density the formula is valid for such $\dot{\boldsymbol{g}}$.

By density, we have that $L(S^L\dot{\boldsymbol{g}})=0$ in the weak sense in \mathbb{R}^{n+1}_{\pm} for any $\dot{\boldsymbol{g}}\in L^2(\mathbb{R}^n)$. By [BHM17b, Theorem 5.3], and by the bounds (1.23) and (4.1),

(4.2)
$$\lim_{t \to +\infty} \|\nabla^m \mathcal{S}^L \dot{\boldsymbol{g}}(\cdot, t)\|_{L^2(\mathbb{R}^n)} = 0 \quad \text{for all } \dot{\boldsymbol{g}} \in L^2(\mathbb{R}^n).$$

Furthermore, the operators $\dot{\mathbf{T}}\mathbf{r}_m^{\pm}\mathcal{S}^L$ are bounded from $L^2(\mathbb{R}^n)$ to itself and satisfy

$$(4.3) \qquad \lim_{t \to 0^{\pm}} \|\nabla^m \mathcal{S}^L \dot{\boldsymbol{g}}(\cdot, t) - \dot{\mathbf{T}} \mathbf{r}_m^{\pm} \mathcal{S}^L \dot{\boldsymbol{g}}\|_{L^2(\mathbb{R}^n)} = 0 \quad \text{for all } \dot{\boldsymbol{g}} \in L^2(\mathbb{R}^n).$$

4.2. The modified single layer potential $\mathcal{S}^L_{\nabla}\dot{\boldsymbol{h}}$. The gradient $\nabla^{m-1}\mathcal{S}^L_{\nabla}$ of the modified single layer potential was defined by formula (2.15) as an integral operator. We begin this section by showing that there is a function $\mathcal{S}^L_{\nabla}\dot{\boldsymbol{h}}$ in $\dot{W}^2_{m-1,loc}(\mathbb{R}^{n+1}_{\pm})$ whose gradient $\nabla^{m-1}\mathcal{S}^L_{\nabla}\dot{\boldsymbol{h}}$ is given by formula (2.15), and that $L(\mathcal{S}^L_{\nabla}\dot{\boldsymbol{h}})=0$ in \mathbb{R}^{n+1}_{\pm} .

Lemma 4.4. Let L be an operator of the form (1.1) of order 2m associated to t-independent coefficients A that satisfy the bounds (2.2) and (2.3).

If $|\gamma| = m - 1$, and if $\dot{\boldsymbol{h}} \in L^2(\mathbb{R}^n)$, then the integral in the definition (2.15) of $\partial^{\gamma} \mathcal{S}^{L}_{\nabla} \dot{\boldsymbol{h}}(x,t)$ converges absolutely for almost every $(x,t) \in \mathbb{R}^{n+1}_{\pm}$. Furthermore, if $K \subset \mathbb{R}^{n+1}_{\pm}$ is compact, then $\partial^{\gamma} \mathcal{S}^{L}_{\nabla}$ is bounded $L^2(\mathbb{R}^n) \mapsto L^2(K)$.

If $|\beta| = m$ and $\beta_{n+1} \ge 1$, and if $h \in \dot{B}^{2,2}_{-1/2}(\mathbb{R}^n)$ or $h \in L^2(\mathbb{R}^n)$, then the function $\nabla^{m-1} \mathcal{S}^L_{\nabla}(h\dot{\mathbf{e}}_{\beta})$ given by formula (2.15) satisfies

(4.5)
$$\nabla^{m-1} \mathcal{S}^{L}_{\nabla}(h\dot{\boldsymbol{e}}_{\beta})(x,t) = -\nabla^{m-1} \partial_{t} \mathcal{S}^{L}(h\dot{\boldsymbol{e}}_{\zeta})(x,t) \quad \text{where } \beta = \zeta + \vec{e}_{n+1}.$$

If $h \in L^2(\mathbb{R}^n) \cap \dot{B}^{2,2}_{1/2}(\mathbb{R}^n)$, and if $\beta_{n+1} < |\beta| = m$, then the gradient $\nabla^m \mathcal{S}^L_{\nabla}(h\dot{\boldsymbol{e}}_{\beta})$ of the function $\nabla^{m-1} \mathcal{S}^L_{\nabla}(h\dot{\boldsymbol{e}}_{\beta})$ given by formula (2.15) satisfies

(4.6)
$$\nabla^m \mathcal{S}^L_{\nabla}(h\dot{\boldsymbol{e}}_{\beta})(x,t) = -\nabla^m \mathcal{S}^L(\partial_{x_j} h\dot{\boldsymbol{e}}_{\zeta})(x,t) \quad \text{where } \beta = \zeta + \vec{e}_j$$

where j is any number with $1 \le j \le n$ and with $\vec{e}_j \le \beta$.

Thus by density, if $\dot{\boldsymbol{h}} \in L^2(\mathbb{R}^n)$, then there is a function $\mathcal{S}^L_{\nabla} \dot{\boldsymbol{h}} \in \dot{W}^2_{m-1,loc}(\mathbb{R}^n)$ such that, if $|\gamma| = m-1$, then $\partial^{\gamma} \mathcal{S}^L_{\nabla} \dot{\boldsymbol{h}}$ is given by formula (2.15). Furthermore,

$$L(\mathcal{S}_{\nabla}^{L}\dot{\boldsymbol{h}}) = 0$$
 in \mathbb{R}_{+}^{n+1} .

Proof. By Lemma 3.5 and the bound (3.7) or (3.8), if $Q \subset \mathbb{R}^n$ is a cube of side length $\ell > 0$, then

$$(4.7) \quad \int_{Q} \int_{\ell}^{2\ell} \int_{\mathbb{R}^{n}} |\partial_{x,t}^{\gamma} \nabla_{y,s}^{m} E^{L}(x,t,y,0)|^{2} \, dy \, dt \, dx$$

$$+ \int_{Q} \int_{-2\ell}^{-\ell} \int_{\mathbb{R}^{n}} |\partial_{x,t}^{\gamma} \nabla_{y,s}^{m} E^{L}(x,t,y,0)|^{2} \, dy \, dt \, dx \leq C\ell.$$

In particular, $\partial_{x,t}^{\gamma} \nabla_{y,s}^m E^L(x,t,\cdot,0) \in L^2(\mathbb{R}^n)$ for almost every $(x,t) \in \mathbb{R}^{n+1}_{\pm}$. A straightforward covering argument establishes the local boundedness of $\partial^{\gamma} S_{\nabla}^L$.

We now turn to formula (4.5). Choose some β with $|\beta| = m$ and $\beta_{n+1} \geq 1$. Let $\zeta + \vec{e}_{n+1} = \beta$. If $h \in \dot{B}^{2,2}_{-1/2}(\mathbb{R}^n)$, then by formula (2.14) the function $-\partial_t \mathcal{S}^L(h\dot{\boldsymbol{e}}_{\zeta})$ satisfies

$$-\partial^{\gamma}\partial_{t}\mathcal{S}^{L}(h\dot{\boldsymbol{e}}_{\zeta})(x,t) = -\int_{\mathbb{R}^{n}} \partial_{x,t}^{\gamma}\partial_{t}\partial_{y,s}^{\zeta} E^{L}(x,t,y,0) h(y) dy.$$

and by formula (3.13)

$$-\partial^{\gamma}\partial_{t}\mathcal{S}^{L}(h\dot{\boldsymbol{e}}_{\zeta})(x,t) = \int_{\mathbb{R}^{n}} \partial_{x,t}^{\gamma} \partial_{y,s}^{\beta} E^{L}(x,t,y,0) h(y) dy.$$

Thus, formula (4.5) is valid for all $h \in \dot{B}^{2,2}_{-1/2}(\mathbb{R}^n)$; because $\partial^{\gamma} \mathcal{S}^L_{\nabla}$ and $\nabla^m \mathcal{S}^L$ are both bounded $L^2(\mathbb{R}^n) \mapsto L^2_{loc}(\mathbb{R}^{n+1}_{\pm})$, by density formula (4.5) is valid for all $h \in L^2(\mathbb{R}^n)$.

Finally, we turn to formula (4.6). If $\beta_{n+1} < |\beta| = m$, then there is some j with $1 \le j \le n$ such that $\vec{e}_j \le \beta$. Let $\zeta + \vec{e}_j = \beta$. If $h \in \dot{B}^{2,2}_{1/2}(\mathbb{R}^n)$, then the (formal) derivative $\partial_j h$ lies in $\dot{B}^{2,2}_{-1/2}(\mathbb{R}^n)$, and

$$-\partial^{\alpha} \mathcal{S}^{L}(\partial_{j} h \dot{\boldsymbol{e}}_{\zeta})(x,t) = -\int_{\mathbb{R}^{n}} \partial_{x,t}^{\alpha} \partial_{y,s}^{\zeta} E^{L}(x,t,y,0) \, \partial_{y_{j}} h(y) \, dy.$$

Recall from the remarks following formula (2.14) that for almost every $(x,t) \in \mathbb{R}^{n+1}_{\pm}$, the right hand side converges provided $h \in \dot{B}^{2,2}_{1/2}(\mathbb{R}^n)$. But if $h \in L^2(\mathbb{R}^n)$, then

$$\int_{\mathbb{R}^n} \partial_{x,t}^{\alpha} \partial_{y,s}^{\beta} E^L(x,t,y,0) h(y) dy$$

converges absolutely for almost every $(x,t) \in \mathbb{R}^{n+1}_{\pm}$. Thus, we may integrate by parts to see that

$$-\partial^{\alpha} \mathcal{S}^{L}(\partial_{j} h \dot{\boldsymbol{e}}_{\zeta})(x,t) = \int_{\mathbb{R}^{n}} \partial_{x,t}^{\alpha} \partial_{y,s}^{\beta} E^{L}(x,t,y,0) h(y) dy.$$

If $|\gamma| = m - 1$ and $1 \le k \le n + 1$, then

$$-\partial_k \partial^{\gamma} \mathcal{S}^L(\partial_j h \dot{\boldsymbol{e}}_{\zeta})(x,t) = \partial_k \int_{\mathbb{R}^n} \partial_{x,t}^{\gamma} \partial_{y,s}^{\beta} E^L(x,t,y,0) h(y) dy.$$

Thus, formula (4.6) is valid. This completes the proof.

We now establish bounds similar to the bounds (4.1), (4.2), and (4.3).

Lemma 4.8. Let L be an operator of the form (1.1) of order 2m associated to t-independent coefficients A that satisfy the bounds (2.2) and (2.3).

For all $\dot{\mathbf{h}} \in L^2(\mathbb{R}^n)$, we have that

(4.9)
$$\sup_{t \neq 0} \|\nabla^{m-1} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}}(\cdot, t)\|_{L^{2}(\mathbb{R}^{n})} \leq C \|\dot{\boldsymbol{h}}\|_{L^{2}(\mathbb{R}^{n})},$$

(4.10)
$$\lim_{t \to \pm \infty} \|\nabla^{m-1} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}}(\cdot, t)\|_{L^{2}(\mathbb{R}^{n})} = 0.$$

Furthermore, the boundary operator $\mathbf{\dot{T}r}_{m-1}^{\pm} \mathcal{S}_{\nabla}^{L}$ is bounded from $L^{2}(\mathbb{R}^{n})$ to itself and satisfies

(4.11)
$$\lim_{t \to 0^{\pm}} \|\nabla^{m-1} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}}(\cdot, t) - \dot{\mathbf{T}}_{m-1}^{\pm} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}}\|_{L^{2}(\mathbb{R}^{n})} = 0$$

for all $\dot{\boldsymbol{h}} \in L^2(\mathbb{R}^n)$.

Proof. By formula (4.5), if $\dot{\boldsymbol{h}} = h\dot{\boldsymbol{e}}_{\beta}$ for some β with $\beta_{n+1} \geq 1$, then the theorem follows from the bounds (4.1–4.3).

More generally, by [BHM17b, Theorem 5.1] and the bound (1.24), if $\dot{\mathbf{h}} \in L^2(\mathbb{R}^n)$, then there are two polynomials P_{\pm} of degree m-1 that satisfy

$$\sup_{\pm t>0} \|\nabla^{m-1} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}}(\cdot,t) - \nabla^{m-1} P_{\pm}\|_{L^{2}(\mathbb{R}^{n})} \leq C \|\dot{\boldsymbol{h}}\|_{L^{2}(\mathbb{R}^{n})},
\|\dot{\mathbf{T}}\mathbf{r}_{m-1}^{\pm} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}} - \nabla^{m-1} P_{\pm}\|_{L^{2}(\mathbb{R}^{n})} \leq C \|\dot{\boldsymbol{h}}\|_{L^{2}(\mathbb{R}^{n})},
\lim_{t \to \pm \infty} \|\nabla^{m-1} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}}(\cdot,t) - \nabla^{m-1} P_{\pm}\|_{L^{2}(\mathbb{R}^{n})} = 0,
\lim_{t \to 0^{\pm}} \|\nabla^{m-1} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}}(\cdot,t) - \dot{\mathbf{T}}\mathbf{r}_{m-1}^{\pm} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}}\|_{L^{2}(\mathbb{R}^{n})} = 0.$$

We need only show that $\nabla^{m-1}P_{\pm}=0$.

We will consider only P_+ . Let Q be a cube in \mathbb{R}^n of side length t. Then

$$|\nabla^{m-1}P_{+}|^{2} = \int_{Q} |\nabla^{m-1}P_{+}|^{2}$$

$$\leq 2 \int_{Q} |\nabla^{m-1}S_{\nabla}^{L}\dot{\boldsymbol{h}}(x,t) - \nabla^{m-1}P_{+}|^{2} dx + 2 \int_{Q} |\nabla^{m-1}S_{\nabla}^{L}\dot{\boldsymbol{h}}(x,t)|^{2} dx.$$

By the given bound on $\nabla^{m-1} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}}(x,t) - \nabla^{m-1} P_{+}$

$$|\nabla^{m-1}P_{+}|^{2} \leq \frac{C}{t^{n}} \|\dot{\boldsymbol{h}}\|_{L^{2}(\mathbb{R}^{n})}^{2} + 2 \oint_{O} |\nabla^{m-1}S_{\nabla}^{L}\dot{\boldsymbol{h}}(x,t)|^{2} dx.$$

By the bound (4.7) and Lemma 3.5,

$$|\nabla^{m-1}P_{+}|^{2} \leq \frac{C}{t^{n}} ||\dot{\boldsymbol{h}}||_{L^{2}(\mathbb{R}^{n})}.$$

Letting $t \to \infty$, we see that $\nabla^{m-1}P_+ = 0$, as desired.

4.3. Boundary values and operators of high order. In this section, we will show that if $2m \geq n+3$, then the boundary operators $\mathbf{\dot{T}r}_m^{\pm} \mathcal{S}^L$ and $\mathbf{\dot{T}r}_{m-1}^{\pm} \mathcal{S}^L_{\nabla}$ are bounded on $L^p(\mathbb{R}^n)$ for some values of $p \neq 2$. We will also establish some preliminary nontangential estimates. In Section 4.4 we will show how to generalize to operators of low order, and in Section 4.5 we will pass to nontangential and area integral estimates.

We begin with the purely vertical derivatives.

Lemma 4.12. Let L be an operator of the form (1.1) of order 2m, with $2m \ge n+3$, associated to t-independent coefficients \mathbf{A} that satisfy the bounds (2.2) and (2.3). Suppose that $2 \le p < \infty$. Then for all $\dot{\mathbf{g}} \in L^p(\mathbb{R}^n) \cap L^2(\mathbb{R}^n)$ and all $\dot{\mathbf{h}} \in L^p(\mathbb{R}^n) \cap L^2(\mathbb{R}^n)$, we have that

$$\|\operatorname{Tr}^{\pm} \partial_{t}^{m-1} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}}\|_{L^{p}(\mathbb{R}^{n})} \leq C \|\dot{\boldsymbol{h}}\|_{L^{p}(\mathbb{R}^{n})},$$
$$\|\operatorname{Tr}^{\pm} \partial_{t}^{m} \mathcal{S}^{L} \dot{\boldsymbol{g}}\|_{L^{p}(\mathbb{R}^{n})} \leq C \|\dot{\boldsymbol{g}}\|_{L^{p}(\mathbb{R}^{n})}.$$

Proof. By the bounds (4.3) and (4.11), we have that $\operatorname{Tr}^{\pm} \partial_t^{m-1} \mathcal{S}_{\nabla}^L \dot{\boldsymbol{h}}$ and $\operatorname{Tr}^{\pm} \partial_t^m \mathcal{S}^L \dot{\boldsymbol{g}}$ do exist as L^2 functions. The bound on \mathcal{S}_{∇}^L follows from the bound on \mathcal{S}_{∇}^L by formula (4.5). By formula (2.14) for \mathcal{S}^{L^*} , the definition (2.15) of \mathcal{S}_{∇}^L , and the symmetry relations (3.9) and (3.12) for the fundamental solution, we have the duality relation

$$(4.13) \qquad \langle \dot{\boldsymbol{g}}, \nabla^{m-1} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}}(\cdot, t) \rangle_{\mathbb{R}^{n}} = \langle \nabla^{m} \mathcal{S}^{L^{*}} \dot{\boldsymbol{g}}(\cdot, -t), \dot{\boldsymbol{h}} \rangle_{\mathbb{R}^{n}}$$

for all $t \neq 0$. Taking limits, we see that it suffices to show that the bound

$$\|\mathbf{\dot{T}}\mathbf{r}_m^{\mp}\,\mathcal{S}^{L^*}(g\boldsymbol{\dot{e}}_{\perp})(\,\cdot\,,t)\|_{L^q(\mathbb{R}^n)}\leq C\|g\|_{L^q(\mathbb{R}^n)}$$

is valid for all $1 < q \le 2$. Here $\dot{\boldsymbol{e}}_{\perp} = \dot{\boldsymbol{e}}_{(m-1)\vec{e}_{n+1}}$, so $\langle \dot{\boldsymbol{e}}_{\perp}, \nabla^{m-1}\varphi \rangle = \partial_{n+1}^{m-1}\varphi$ for all functions φ with weak derivatives of order up to m-1.

Let $|\alpha| = m$, and let

$$T_{\alpha}g = \operatorname{Tr}^{\mp} \partial^{\alpha} \mathcal{S}^{L^*}(g\dot{\boldsymbol{e}}_{\perp}).$$

Again by formula (4.3), T_{α} is a well-defined, bounded operator on $L^{2}(\mathbb{R}^{n})$.

We now show that T_{α} satisfies a weak bound on $L^{1}(\mathbb{R}^{n})$; by interpolation this operator satisfies a strong bound on $L^{q}(\mathbb{R}^{n})$ for any q in the range 1 < q < 2.

Let $g \in L^1(\mathbb{R}^n)$. Fix some number $\mu > 0$. We seek to show that

$$|\{x: |T_{\alpha}g(x)| > \mu\}| < \frac{C||g||_{L^{1}(\mathbb{R}^{n})}}{\mu}.$$

We apply a standard Calderón-Zygmund decomposition to g. That is, there exists a collection $\{Q_i\}$ of closed cubes with pairwise-disjoint interiors, a bounded function s, and unbounded functions u_i such that

$$g = s + \sum_{i} u_i,$$

such that each u_i is supported in Q_i , and such that the following bounds are valid:

$$||s||_{L^{\infty}(\mathbb{R}^n)} \le \mu, \qquad \int_{Q_i} u_i = 0, \qquad \int_{Q_i} |u_i| \le 2\mu |Q_i|, \qquad \sum_i |Q_i| \le \frac{2^n}{\mu} \int_{\mathbb{R}^n} |g|.$$

As usual, if $|T_{\alpha}g(x)| > \mu$ then either $|T_{\alpha}s(x)| > \mu/2$ or $|T_{\alpha}u(x)| > \mu/2$, where $u = \sum_{i} u_{i}$. Notice that

$$||s||_{L^2(\mathbb{R}^n)} \le \left(\int_{\mathbb{R}^n \setminus \cup_i Q_i} |s|^2 + \sum_i |Q_i| \mu^2 \right)^{1/2}.$$

For almost every $x \notin \bigcup_i Q_i$, we have that s(x) = g(x) and $|s(x)| \leq \mu$; thus

$$||s||_{L^2(\mathbb{R}^n)} \le \left(\int_{\mathbb{R}^n \setminus \cup_i Q_i} |g|\mu + \sum_i |Q_i|\mu^2 \right)^{1/2} \le C\mu^{1/2} ||g||_{L^1(\mathbb{R}^n)}^{1/2}.$$

Applying boundedness of T_{α} on $L^{2}(\mathbb{R}^{n})$, we see that

$$|\{x \in \mathbb{R}^n : |T_{\alpha}s(x)| > \mu/2\}| \le 4 \frac{\|T_{\alpha}s\|_{L^2(\mathbb{R}^n)}^2}{\mu^2} \le C \frac{\|s\|_{L^2(\mathbb{R}^n)}^2}{\mu^2} \le C^2 \frac{\|g\|_{L^1(\mathbb{R}^n)}}{\mu}$$

as desired

We now turn to the set $|\{x \in \mathbb{R}^n : |T_{\alpha}u(x)| > \mu/2\}|$. We have that $\sum_i |8Q_i| \le C||g||_{L^1(\mathbb{R}^n)}/\mu$, and so we will consider only the set

$$\{x \in \mathbb{R}^n : |T_{\alpha}u(x)| > \mu/2\} \setminus \bigcup_i 8Q_i.$$

If $x \notin Q_i$, then by formula (2.14),

$$T_{\alpha}u_{i}(x) = \int_{Q_{i}} (\partial_{x,t}^{\alpha} \partial_{s}^{m-1} E^{L^{*}}(x,t,y,s) - \partial_{x,t}^{\alpha} \partial_{s}^{m-1} E^{L^{*}}(x,t,y_{0},s)) \big|_{s=t=0} u_{i}(y) dy$$

for any y_0 ; in particular, we choose y_0 to be the midpoint of Q_i . Let $A_j = 2^{j+1}Q_i \setminus 2^jQ_i$. Suppose that $j \geq 3$. Then

$$\int_{A_i} |T_{\alpha} u_i(x)| \, dx \le \int_{O_i} |u_i(y)| \int_{A_i} |\partial_{x,t}^{\alpha} \partial_s^{m-1} (E^{L^*}(x,0,y,0) - E^{L^*}(x,0,y_0,0))| \, dx \, dy.$$

Let $w(y,s) = \partial_{x,t}^{\alpha} \partial_s^{m-1} E^{L^*}(x,t,y,s)$. We observe that $L^*w = 0$ away from the point (x,t). If $2m \ge n+3$, then by Theorem 3.2, ∇w is continuous and pointwise bounded away from (x,t), and so if $j \ge 3$ then

$$\int_{A_{j}} |\partial_{x,t}^{\alpha} \partial_{s}^{m-1} (E^{L^{*}}(x,0,y,0) - E^{L^{*}}(x,0,y_{0},0))| dx$$

$$\leq C\ell(Q_{i}) \int_{A_{j}} \int_{2^{j-2} \widetilde{Q}_{i}} |\partial_{x,t}^{\alpha} \nabla_{y,s}^{m} E^{L^{*}}(x,0,y,s)| dy ds dx$$

where $\widetilde{Q}_i = Q_i \times (-\ell(Q_i)/2, \ell(Q_i)/2)$ is a cube in \mathbb{R}^{n+1} . We change the order of integration and apply Lemma 3.5 to the function $v(x,t) = \nabla_{y,s}^m E^{L^*}(x,t,y,s)$ to see that

$$\begin{split} \int_{A_{j}} |\partial_{x,t}^{\alpha} \partial_{s}^{m-1} (E^{L^{*}}(x,0,y,0) - E^{L^{*}}(x,0,y_{0},0))| \, dx \\ & \leq \frac{C}{2^{j}} \int_{2^{j-2} \widetilde{Q}_{i}} \int_{\widetilde{A}_{j,1}} |\partial_{x,t}^{\alpha} \nabla_{y,s}^{m} E^{L^{*}}(x,t,y,s)| \, dx \, dt \, dy \, ds \end{split}$$

where $\widetilde{A}_{j,1} = (A_j \cup A_{j-1} \cup A_{j+1}) \times (-2^j \ell(Q), 2^j \ell(Q)).$ By Hölder's inequality and the bound (3.7),

$$\int_{A_s} |\partial_{x,t}^{\alpha} \partial_s^{m-1} (E^{L^*}(x,0,y,0) - E^{L^*}(x,0,y_0,0))| \, dx \le C 2^{-j}$$

and so

$$\int_{\mathbb{R}^n\backslash 8Q_i} \left|T_\alpha u_i(x)\right| dx \leq C \int_{Q_i} \left|u_i(y)\right| dy.$$

Thus,

$$\int_{\mathbb{R}^n \setminus \cup_i 8Q_i} |T_{\alpha} u| \le C \int_{\mathbb{R}^n} |g|$$

and so

$$|\{x: |T_{\alpha}u(x)| > \mu/2\}| \le \frac{C}{\mu} \int_{\mathbb{R}^n} |g|$$

as desired.

We will now establish nontangential estimates on the purely vertical derivatives of the single layer potential. We observe that the conditions of the following lemma are met when $2m \geq n+3$, k=m and $2 \leq q . We will later apply the lemma in the <math>k=0$ and q<2 cases.

Lemma 4.14. Let L be an operator of the form (1.1) of order 2m, with $2m \ge n+1$, associated to t-independent coefficients \boldsymbol{A} that satisfy the bounds (2.2) and (2.3). Let $p_j^+ = p_{L^*,j}^+$ be as in Theorem 3.2 with L replaced by L^* , and let $1/p_j^+ + 1/p_j^- = 1$. Let $0 \le k \le m$, let γ be a multiindex with $|\gamma| = m - 1$, and let q and p satisfy $p_j^- < q < p \le \infty$, where $j = \gamma_{n+1} + 1$. Suppose that the boundary value operator

$$g \mapsto \mathbf{\dot{T}}\mathbf{r}_{m-k}^{+}\,\partial_{n+1}^{k}\mathcal{S}^{L}(g\mathbf{\dot{e}}_{\gamma}),$$

which is well defined for all $g \in L^2(\mathbb{R}^n)$, extends by density to an operator that is bounded $L^q(\mathbb{R}^n) \mapsto L^q(\mathbb{R}^n)$ and $L^p(\mathbb{R}^n) \mapsto L^p(\mathbb{R}^n)$.

Then we have the bound

$$\|\widetilde{N}_{+}(\nabla^{m-k}\partial_{n+1}^{k}\mathcal{S}^{L}(g\dot{\boldsymbol{e}}_{\gamma}))\|_{L^{p}(\mathbb{R}^{n})} \leq C\|g\|_{L^{p}(\mathbb{R}^{n})}$$

for all $g \in L^p(\mathbb{R}^n) \cap L^2(\mathbb{R}^n)$, for some constant C depending only on q, p and the standard parameters.

Similarly, if $1 \le k \le m$, if $|\alpha| = m$, and if

$$h \mapsto \mathbf{\dot{T}r}_{m-k}^+ \, \partial_{n+1}^{k-1} \mathcal{S}_{\nabla}^L(h \dot{\boldsymbol{e}}_{\alpha})(\,\cdot\,,t)$$

is bounded $L^q(\mathbb{R}^n) \mapsto L^q(\mathbb{R}^n)$ and $L^p(\mathbb{R}^n) \mapsto L^p(\mathbb{R}^n)$ for some $p_j^- < q < p \le \infty$, where $j = \alpha_{n+1}$, then

$$\|\widetilde{N}_{+}(\nabla^{m-k}\partial_{n+1}^{k-1}\mathcal{S}_{\nabla}^{L}(h\dot{\boldsymbol{e}}_{\alpha}))\|_{L^{p}(\mathbb{R}^{n})} \leq C\|h\|_{L^{p}(\mathbb{R}^{n})}$$

for all $h \in L^p(\mathbb{R}^n) \cap L^2(\mathbb{R}^n)$.

Proof. Let $\zeta = \alpha - j\vec{e}_{n+1}$ or $\zeta = \gamma - (j-1)\vec{e}_{n+1}$, so $\alpha = (\zeta, j)$ or $\gamma = (\zeta, j-1)$. By formulas (2.14) and (2.15) for \mathcal{S}^L and \mathcal{S}^L_{∇} , and by formula (3.13), we have that

if $f \in L^2(\mathbb{R}^n)$ is compactly supported, then for almost every $(x,t) \in \mathbb{R}^{n+1}_{\pm}$,

$$(4.15) \quad -\nabla^{m-k}\partial_t^k \mathcal{S}^L(f\dot{\boldsymbol{e}}_\gamma)(x,t) = (-1)^j \int_{\mathbb{R}^n} \nabla_{x,t}^{m-k} \partial_t^{k+j-1} \partial_y^\zeta E^L(x,t,y,0) f(y) \, dy,$$

$$(4.16) \nabla^{m-k} \partial_t^{k-1} \mathcal{S}_{\nabla}^L (f \dot{\boldsymbol{e}}_{\alpha})(x,t) = (-1)^j \int_{\mathbb{R}^n} \nabla_{x,t}^{m-k} \partial_t^{k+j-1} \partial_y^{\zeta} E^L(x,t,y,0) f(y) dy.$$

Choose some $g \in L^p(\mathbb{R}^n) \cap L^2(\mathbb{R}^n)$, and let either $u = -\partial_{n+1}^k \mathcal{S}^L(g\dot{\boldsymbol{e}}_{\gamma})$ or $u = \partial_{n+1}^{k-1} \mathcal{S}^L_{\nabla}(g\dot{\boldsymbol{e}}_{\alpha})$.

In either case we wish to bound $\widetilde{N}_+(\nabla^{m-k}u)$. Let $x_0 \in \mathbb{R}^n$. By Lemma 3.18,

$$\widetilde{N}_{+}(\nabla^{m-k}u)(x_0) \le C \sup_{t_0 > 0} \left(\oint_{Q(x_0, t_0)} \oint_{t_0/6}^{t_0/2} |\nabla^{m-k}u|^2 \right)^{1/2}.$$

Choose some $t_0 > 0$ and let $Q = Q(x_0, t_0)$. Let $\widetilde{Q} = Q \times (-\ell(Q)/2, \ell(Q)/2) = Q \times (-t_0/2, t_0/2)$. Let $u_Q = -\partial_{n+1}^k \mathcal{S}^L(\mathbf{1}_{4Q} g \dot{\boldsymbol{e}}_{\gamma})$ or $u_Q = \partial_{n+1}^{k-1} \mathcal{S}^L_{\nabla}(\mathbf{1}_{4Q} g \dot{\boldsymbol{e}}_{\alpha})$. Observe that

$$\left(\int_Q \int_{t_0/6}^{t_0/2} |\nabla^{m-k} u|^2 \right)^{1/2} \leq \left(\int_Q \int_{t_0/6}^{t_0/2} |\nabla^{m-k} u_Q|^2 \right)^{1/2} + \left(3 \int_{\widetilde{Q}} |\nabla^{m-k} (u - u_Q)|^2 \right)^{1/2}.$$

By formulas (4.15) and (4.16) and by Hölder's inequality,

$$\begin{split} & \oint_{Q} \oint_{t_{0}/6}^{t_{0}/2} |\nabla^{m-k} u_{Q}|^{2} \\ & \leq \oint_{Q} \oint_{t_{0}/6}^{t_{0}/2} \left(\int_{4Q} |\nabla^{m-k}_{x,t} \partial^{k+j-1}_{t} \partial^{\zeta}_{y} E^{L}(x,t,y,0)|^{q'} \, dy \right)^{2/q'} dt \, dx \left(\int_{4Q} |g|^{q} \right)^{2/q}. \end{split}$$

If $q > p_j^-$, then $q' < p_j^+$ and so we may use Lemma 3.5, Theorem 3.2 and the bound (3.7) to bound the integral of E^L . Thus,

$$\left(\oint_Q \int_{t_0/6}^{t_0/2} |\nabla^{m-k} u_Q|^2 \right)^{1/2} \le C \left(\oint_{4Q} |g|^q \right)^{1/q} \le C \mathcal{M}(|g|^q) (x_0)^{1/q}.$$

By Lemma 3.19,

$$\left(\oint_{\widetilde{Q}} |\nabla^{m-k}(u - u_Q)|^2 \right)^{1/2} \le C\ell(Q) \oint_{2\widetilde{Q}} |\partial_t^{m-k+1}(u - u_Q)(x, t)| dt dx
+ C \oint_{2Q} |\dot{\mathbf{T}}\mathbf{r}_{m-k}^+ u_Q| + C \oint_{2Q} |\dot{\mathbf{T}}\mathbf{r}_{m-k}^+ u|.$$

The last term is at most $C\mathcal{M}(\mathbf{\dot{T}r}_{m-k}^+u)$. By Hölder's inequality,

$$\int_{2Q} |\dot{\mathbf{T}}\mathbf{r}_{m-k}^{+} u_{Q}| \le \left(\int_{2Q} |\dot{\mathbf{T}}\mathbf{r}_{m-k}^{+} u_{Q}|^{q} \right)^{1/q}.$$

By assumption,

$$\left(\oint_{2Q} |\dot{\mathbf{T}} \mathbf{r}_{m-k}^+ u_Q|^q \right)^{1/q} \le C \left(\oint_{4Q} |g|^q \right)^{1/q} \le C \mathcal{M}(|g|^q)(x_0)^{1/q}.$$

Finally, we consider the term involving $\partial_t^{m-k+1}(u-u_Q)$. By formula (4.15) or (4.16), for almost every $(x,t) \in \mathbb{R}^{n+1}_+$ we have that

$$\partial_t^{m-k+1}(u-u_Q)(x,t) = (-1)^j \int_{\mathbb{R}^n \setminus 4Q} \partial_t^{m+j} \partial_y^{\zeta} E^L(x,t,y,0) g(y) dy.$$

Let $A_{\ell} = 2^{\ell+1}Q \setminus 2^{\ell}Q$. Then

$$\partial_t^{m-k+1}(u-u_Q)(x,t) = (-1)^j \sum_{\ell=2}^{\infty} \int_{A_\ell} \partial_t^{m+j} \partial_y^{\zeta} E^L(x,t,y,0) g(y) dy.$$

Let

$$u_{\ell}(x,t) = \int_{A_{\ell}} \partial_t^{m+j} \partial_y^{\zeta} E^L(x,t,y,0) g(y) dy.$$

Observe that $Lu_{\ell} = 0$ away from $A_{\ell} \times \{0\}$. If $2m \geq n+1$ and $\ell \geq 2$, then by Theorem 3.2,

$$\sup_{(x,t)\in 2\widetilde{Q}} \lvert u_{\ell}(x,t) \rvert \leq C \bigg(f_{2^{\ell-1/2}\widetilde{Q}} \lvert u_{\ell} \rvert^2 \bigg)^{1/2}.$$

As before, by Hölder's inequality, Lemma 3.5, Theorem 3.2 and the bound (3.7), if $q' < p_i^+$, then

$$\left(\int_{2^{\ell-1/2}\widetilde{Q}} |u_{\ell}|^2\right)^{1/2} \leq \frac{C}{2^{\ell}t_0} \left(\int_{A_{\ell}} |g|^q\right)^{1/q} \leq \frac{C}{2^{\ell}t_0} \mathcal{M}(|g|^q)(x_0)^{1/q}.$$

Thus,

$$\left(\int_{C} \int_{t_0/6}^{t_0/2} |\nabla^{m-k} u|^2 \right)^{1/2} \le C \mathcal{M}(|g|^q) (x_0)^{1/q} + C \mathcal{M}(\mathbf{\dot{T}r}_{m-k}^+ u)(x_0)$$

and so by Lemma 3.18,

$$\widetilde{N}_{+}(\nabla^{m-k}u)(x_0) \leq C\mathcal{M}(|g|^q)(x_0)^{1/q} + C\mathcal{M}(\mathbf{\dot{T}r}_{m-k}^+u)(x_0).$$

By assumption, if $g \in L^p(\mathbb{R}^n)$ then $\mathbf{\dot{T}r}_{m-k}^+ u \in L^p(\mathbb{R}^n)$. We have that p > 1 and so \mathcal{M} is bounded on $L^p(\mathbb{R}^n)$, and so $\mathcal{M}(\mathbf{\dot{T}r}_{m-k}^+ u) \in L^p(\mathbb{R}^n)$. Furthermore, if $g \in L^p(\mathbb{R}^n)$, then $|g|^q \in L^{p/q}(\mathbb{R}^n)$. If p > q, then p/q > 1 and so \mathcal{M} is bounded on $L^{p/q}(\mathbb{R}^n)$. Thus, the right-hand side is in $L^p(\mathbb{R}^n)$ and the proof is complete. \square

We now extend from boundary values of the purely vertical derivatives to boundary values of the full gradient.

Lemma 4.17. Let L be an operator of the form (1.1) of order 2m associated to t-independent coefficients A that satisfy the bounds (2.2) and (2.3).

Then there is some p > 2 such that, if $\dot{\mathbf{g}} \in L^p(\mathbb{R}^n) \cap L^2(\mathbb{R}^n)$, then

$$\|\dot{\mathbf{T}}\mathbf{r}_m^+ \mathcal{S}^L \dot{\boldsymbol{g}}\|_{L^p(\mathbb{R}^n)} \le C \|\dot{\boldsymbol{g}}\|_{L^p(\mathbb{R}^n)} + C \|\widetilde{N}_*(\partial_{n+1}^m \mathcal{S}^L \dot{\boldsymbol{g}})\|_{L^p(\mathbb{R}^n)}$$

whenever the right hand side is finite.

Similarly, there is some p>2 such that, if $\dot{\mathbf{h}}\in L^p(\mathbb{R}^n)\cap L^2(\mathbb{R}^n)$, then

$$\|\dot{\mathbf{T}}\mathbf{r}_{m-1}^{+} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}}\|_{L^{p}(\mathbb{R}^{n})} \leq C \|\dot{\boldsymbol{h}}\|_{L^{p}(\mathbb{R}^{n})} + C \|\widetilde{N}_{*}(\partial_{n+1}^{m-1} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{g}})\|_{L^{p}(\mathbb{R}^{n})}$$

whenever the right hand side is finite.

Proof. We follow the proof of a similar inequality in [HMM15b, pp. 17–19]. Choose some $\dot{\boldsymbol{g}} \in L^2(\mathbb{R}^n) \cap L^p(\mathbb{R}^n)$, and let $u = s^L \dot{\boldsymbol{g}}$ or $u = \mathcal{S}^L_{\nabla} \dot{\boldsymbol{g}}$. Assume that $\widetilde{N}_*(\partial_{n+1}^\ell u) \in L^p(\mathbb{R}^n)$, where $\ell = m$ or $\ell = m-1$. We wish to show that for some p > 2 we have that $\dot{\mathbf{Tr}}^+_{\ell} u \in L^p(\mathbb{R}^n)$.

As in the proof of Lemma 3.20, we will use Lemma 3.21. For each cube $Q \subset \mathbb{R}^n$, let $\dot{\boldsymbol{g}}_Q = \dot{\boldsymbol{g}} \boldsymbol{1}_{4Q}$ and $\dot{\boldsymbol{g}} = \dot{\boldsymbol{g}}_Q + \dot{\boldsymbol{g}}_{Q,f}$, and let $u_Q = \mathcal{S}^L \dot{\boldsymbol{g}}_Q$ or $\mathcal{S}^L_{\nabla} \dot{\boldsymbol{g}}_Q$. Then

$$\oint_{Q} |\dot{\mathbf{T}}\mathbf{r}_{\ell}^{+} u|^{2} \leq 2 \oint_{Q} |\dot{\mathbf{T}}\mathbf{r}_{\ell}^{+} u_{Q}|^{2} + 2 \oint_{Q} |\dot{\mathbf{T}}\mathbf{r}_{\ell}^{+} (u - u_{Q})|^{2}.$$

By the bounds (4.3) and (4.11),

$$\label{eq:def_Q} \int_{Q} |\dot{\mathbf{T}}\mathbf{r}_{\ell}^{+} \, u|^{2} \leq C \int_{4Q} |\dot{\mathbf{g}}|^{2} + 2 \int_{Q} |\dot{\mathbf{T}}\mathbf{r}_{\ell}^{+} (u - u_{Q})|^{2}.$$

Observe that $L(u-u_Q)=0$ in a neighborhood of $Q\times\{0\}$, and so we may write

$$\oint_{Q} |\mathbf{\dot{T}}\mathbf{r}_{\ell}^{+}(u - u_{Q})|^{2} = \oint_{Q} |\nabla^{\ell}(u - u_{Q})(x, 0)|^{2} dx.$$

By Lemma 3.5,

$$\oint_{Q} |\dot{\mathbf{T}}\mathbf{r}_{\ell}^{+}(u - u_{Q})|^{2} \le C \oint_{(3/2)Q} \oint_{-\ell(Q)/2}^{\ell(Q)/2} |\nabla^{\ell}(u - u_{Q})(x, t)|^{2} dt dx.$$

By Lemma 3.19 and Hölder's inequality,

$$\oint_{Q} |\dot{\mathbf{T}}\mathbf{r}_{\ell}^{+}(u - u_{Q})|^{2} \le C\ell(Q)^{2} \oint_{2Q} \oint_{-\ell(Q)}^{\ell(Q)} |\partial_{t}^{\ell+1}(u - u_{Q})(x, t)|^{2} dt dx
+ C \left(\oint_{2Q} |\nabla^{\ell}(u - u_{Q})(x, 0)| dx \right)^{2}.$$

By the Caccioppoli inequality,

$$\ell(Q)^{2} \int_{2Q} \int_{-\ell(Q)}^{\ell(Q)} |\partial_{t}^{\ell+1}(u - u_{Q})(x, t)|^{2} dt dx$$

$$\leq C \int_{3Q} \int_{-(3/2)\ell(Q)}^{(3/2)\ell(Q)} |\partial_{t}^{\ell}(u - u_{Q})(x, t)|^{2} dt dx$$

Now,

$$\int_{3Q} \int_{-(3/2)\ell(Q)}^{(3/2)\ell(Q)} |\partial_t^{\ell} u_Q(x,t)|^2 dt dx \le \frac{C}{|Q|} \sup_{t \ne 0} ||\partial_t^{\ell} u_Q(\cdot,t)||_{L^2(\mathbb{R}^n)}^2$$

which by the bound (4.1) or (4.9) is at most $C|Q|^{-1}\|\dot{\boldsymbol{g}}_Q\|_{L^2(\mathbb{R}^n)}^2$. Thus,

$$\oint_{Q} |\dot{\mathbf{T}}\mathbf{r}_{\ell}^{+}(u - u_{Q})|^{2} \le C \oint_{3Q} \oint_{-(3/2)\ell(Q)}^{(3/2)\ell(Q)} |\partial_{n+1}^{\ell}u(x,t)|^{2} dt dx + C \oint_{4Q} |\dot{\boldsymbol{g}}(x)|^{2} dx
+ C \left(\oint_{2Q} |\nabla^{\ell}(u - u_{Q})(x,0)| dx \right)^{2}.$$

An elementary argument shows that

$$\int_{3Q} \int_{-(3/2)\ell(Q)}^{(3/2)\ell(Q)} |\partial_{n+1}^{\ell} u(x,t)|^2 dt dx \le C \int_{3Q} \widetilde{N}_* (\partial_{n+1}^{\ell} u)(x)^2 dx.$$

By Hölder's inequality,

$$\int_{2Q} |\nabla^{\ell}(u - u_Q)(x, 0)| \, dx \le \int_{2Q} |\mathbf{\dot{T}r}_{\ell}^+ u(x)| \, dx + \left(\int_{2Q} |\mathbf{\dot{T}r}_{\ell}^+ u_Q(x)|^2 \, dx \right)^{1/2}$$

which by the bound (4.3) or (4.11) is at most

$$\oint_{2Q} |\dot{\mathbf{T}} \mathbf{r}_{\ell}^{+} \, u(x)| \, dx + C \bigg(\oint_{4Q} |\dot{\boldsymbol{g}}(x)|^{2} \, dx \bigg)^{1/2}.$$

Thus, we see that

$$\int_{Q} |\dot{\mathbf{T}}\mathbf{r}_{\ell}^{+} u|^{2} \leq C \int_{4Q} |\dot{\mathbf{g}}|^{2} + C \int_{3Q} \widetilde{N}_{*}(\partial_{n+1}^{\ell} u)(x)^{2} dx + C \left(\int_{2Q} |\dot{\mathbf{T}}\mathbf{r}_{\ell}^{+} u(x)| dx \right)^{2}.$$

We will use Lemma 3.21. Let $g=|\dot{\mathbf{T}}\mathbf{r}_{\ell}^{+}u|$, let $h=|\dot{\mathbf{g}}|+\widetilde{N}_{*}(\partial_{n+1}^{\ell}u)$ and let q=2. Then there is some p>2 such that

$$\int_{\mathbb{R}^n} |\dot{\mathbf{T}}\mathbf{r}_{\ell}^+ u(x)|^p dx \le C \int_{\mathbb{R}^n} |\dot{\boldsymbol{g}}(x)|^p + \widetilde{N}_* (\partial_{n+1}^{\ell} u)(x)^p dx$$

as desired. \Box

4.4. Reduction to operators of high order. The following formulas were established in [Bar16, BHM17c, BHM17a] and inspired by an argument in [AHMT01, Section 2.2]; we will use them to pass from the case $2m \ge n+3$ to the general case.

Choose some large number M. There are constants κ_{ζ} such that

$$\Delta^M = \sum_{|\zeta|=M} \kappa_\zeta \, \partial^{2\zeta}.$$

In fact, $\kappa_{\zeta} = M!/\zeta! = M!/(\zeta_1!\zeta_2!...\zeta_{n+1}!)$, and so we have that $\kappa_{\zeta} \geq 1$ for all $|\zeta| = M$.

Define the differential operator $\widetilde{L} = \Delta^M L \Delta^M$; that is, \widetilde{L} is the operator of order 4M + 2m associated to coefficients \widetilde{A} that satisfy

(4.18)
$$\langle \nabla^{m+2M} \varphi, \widetilde{\mathbf{A}} \nabla^{m+2M} \psi \rangle = \langle \nabla^m \Delta^M \varphi, \mathbf{A} \nabla^m \Delta^M \psi \rangle$$

for all nice test functions φ and ψ . Observe that $\widetilde{\boldsymbol{A}}$ is t-independent and satisfies the bounds (2.2) and (2.3). A precise formula for \widetilde{A} may be found in [BHM17c, formula 11.1].

Let $\widetilde{g}_{\varepsilon}(x) = \sum_{\gamma+2\xi=\varepsilon} \kappa_{\xi} g_{\gamma}(x)$. By [BHM17c, formula (11.2)], if $|\alpha| = m$ then

(4.19)
$$\partial^{\alpha} \mathcal{S}^{L} \dot{\boldsymbol{g}}(x,t) = \sum_{|\zeta|=M} \kappa_{\zeta} \partial^{\alpha+2\zeta} \mathcal{S}^{\widetilde{\boldsymbol{A}}} \dot{\widetilde{\boldsymbol{g}}}(x,t) = \partial^{\alpha} \Delta^{M} \mathcal{S}^{\widetilde{\boldsymbol{A}}} \dot{\widetilde{\boldsymbol{g}}}(x,t).$$

Similarly, let $\widetilde{h}_{\varepsilon} = \sum_{\alpha+2\xi=\varepsilon} \kappa_{\xi} h_{\alpha}$. If $|\gamma| = m-1$, then [BHM17a, formula (3.10)],

(4.20)
$$\partial^{\gamma} \mathcal{S}_{\nabla}^{L} \dot{\boldsymbol{h}}(x,t) = \sum_{|\zeta|=M} \kappa_{\zeta} \partial^{\gamma+2\zeta} \mathcal{S}_{\nabla}^{\widetilde{L}} \dot{\boldsymbol{h}}(x,t) = \partial^{\gamma} \Delta^{M} \mathcal{S}_{\nabla}^{\widetilde{L}} \dot{\boldsymbol{h}}(x,t).$$

4.5. Nontangential and area integral estimates. We now establish the nontangential bounds (1.16) and (1.17) on the single layer potential.

Lemma 4.21. Let L be an operator of the form (1.1) of order 2m associated to t-independent coefficients A that satisfy the bounds (2.2) and (2.3).

Then the bounds (1.16) and (1.17) are valid. That is, there is some number $\varepsilon > 0$ such that the bounds

$$\|\widetilde{N}_*(\nabla^m \mathcal{S}^L \dot{\boldsymbol{g}})\|_{L^p(\mathbb{R}^n)} \le C_p \|\dot{\boldsymbol{g}}\|_{L^p(\mathbb{R}^n)}$$

and

$$\|\widetilde{N}_*(\nabla^{m-1}\mathcal{S}^L_{\nabla}\dot{\boldsymbol{h}})\|_{L^p(\mathbb{R}^n)} \le C_p \|\dot{\boldsymbol{h}}\|_{L^p(\mathbb{R}^n)}$$

are valid whenever $2 - \varepsilon .$

Proof. Let M be large enough that $2\widetilde{m} = 2m + 4M \ge n + 3$, and let L be the operator of order $2\tilde{m}$ associated to the coefficients A given by formula (4.18).

By Lemmas 4.12 and 4.14 (with $k = \tilde{m}$ or $k = \tilde{m} - 1$), and by Section 3.3, we have that the bounds

$$\|\widetilde{N}_*(\partial_{n+1}^{\widetilde{m}}\mathcal{S}^{\widetilde{L}}\dot{\widetilde{\boldsymbol{g}}})\|_{L^p(\mathbb{R}^n)} \leq C_p \|\dot{\widetilde{\boldsymbol{g}}}\|_{L^p(\mathbb{R}^n)}, \qquad \|\widetilde{N}_*(\partial_{n+1}^{\widetilde{m}-1}\mathcal{S}_{\nabla}^{\widetilde{L}}\dot{\widetilde{\boldsymbol{h}}})\|_{L^p(\mathbb{R}^n)} \leq C_p \|\dot{\widetilde{\boldsymbol{h}}}\|_{L^p(\mathbb{R}^n)}$$

are valid for all $2 and all <math>\dot{\tilde{g}}$, $\dot{\tilde{h}} \in L^p(\mathbb{R}^n) \cap L^2(\mathbb{R}^n)$. Thus, by Lemma 4.17, there is some $\tilde{p} > 2$ such that if $p = \tilde{p}$, then

$$(4.22) \quad \|\dot{\mathbf{T}}\mathbf{r}_{\tilde{m}}^{\pm} \mathcal{S}^{\tilde{L}} \dot{\tilde{\boldsymbol{g}}}\|_{L^{p}(\mathbb{R}^{n})} \leq C \|\dot{\tilde{\boldsymbol{g}}}\|_{L^{p}(\mathbb{R}^{n})}, \quad \|\dot{\mathbf{T}}\mathbf{r}_{\tilde{m}-1}^{\pm} \mathcal{S}_{\nabla}^{\tilde{L}} \dot{\tilde{\boldsymbol{h}}}\|_{L^{p}(\mathbb{R}^{n})} \leq C \|\dot{\tilde{\boldsymbol{h}}}\|_{L^{p}(\mathbb{R}^{n})}.$$

By interpolation, the inequalities (4.22) are valid for all p with 2 .

The adjoint operator L^* to L is also of the form (1.1), of order $2\widetilde{m}$, and associated to t-independent coefficients A^* that satisfy the bounds (2.2) and (2.3). Thus, there is some $\tilde{p}_* > 0$ such that the inequalities (4.22) are valid, with L replaced by L^* , for all p with $2 \leq p \leq \tilde{p}_*$.

By the duality relation (4.13), the inequalities (4.22) (with the original L) are valid for all $\tilde{p}'_* \leq p \leq \tilde{p}$.

By Lemma 4.14 (with k=0), we have that if $\max(\tilde{p}'_*, p_0^-) , then$

$$\|\widetilde{N}_*(\nabla^{\widetilde{m}}\mathcal{S}^{\widetilde{L}}\dot{\widetilde{\boldsymbol{g}}})\|_{L^p(\mathbb{R}^n)} \leq C_p \|\dot{\widetilde{\boldsymbol{g}}}\|_{L^p(\mathbb{R}^n)}, \qquad \|\widetilde{N}_*(\nabla^{\widetilde{m}-1}\mathcal{S}^{\widetilde{L}}_{\nabla}\dot{\widetilde{\boldsymbol{h}}})\|_{L^p(\mathbb{R}^n)} \leq C_p \|\dot{\widetilde{\boldsymbol{h}}}\|_{L^p(\mathbb{R}^n)}$$
An application of formulas (4.19) and (4.20) completes the proof.

As an immediate corollary we have area integral estimates.

Lemma 4.23. Let L be an operator of the form (1.1) of order 2m associated to t-independent coefficients A that satisfy the bounds (2.2) and (2.3).

Then the bounds (1.26) and (1.27) are valid. That is, there is some number $\varepsilon > 0$ such that the bounds

(4.25)
$$\|\mathcal{A}_2^+(t\,\nabla^m\mathcal{S}_{\nabla}^L\dot{\boldsymbol{h}})\|_{L^p(\mathbb{R}^n)} \le C_p\|\dot{\boldsymbol{h}}\|_{L^p(\mathbb{R}^n)}$$

are valid whenever $2 - \varepsilon .$

Proof. The case $2-\varepsilon is known (see formulas (1.23) and (1.24) above). The$ p > 2 case follows from Lemma 3.20 with $u = \partial_t \mathcal{S}^L \dot{\boldsymbol{g}}$ or $u = \mathcal{S}^L_{\nabla} \dot{\boldsymbol{h}}, u_Q = \partial_t \mathcal{S}^L (\mathbf{1}_{4Q} \dot{\boldsymbol{g}})$ or $u_Q = \mathcal{S}^L_{\nabla}(\mathbf{1}_{4Q}\dot{\boldsymbol{h}})$; by the bounds (1.23) and (1.24) and Lemma 4.21, the conditions of the lemma are satisfied with $\psi = C|\dot{\boldsymbol{h}}|$ or $\psi = C|\dot{\boldsymbol{q}}|$.

5. The double layer potential

In this section we will establish the nontangential estimates (1.18–1.19) and the area integral estimates (1.28–1.29) on the double layer potential.

We will begin (Section 5.1) by showing that the boundary values $\mathbf{Tr}_m \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}}$ and $\mathbf{Tr}_{m-1} \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{f}}$ lie in $L^p(\mathbb{R}^n)$, for p near 2 and for appropriate inputs $\dot{\boldsymbol{\varphi}}$ and $\dot{\boldsymbol{f}}$. We will then (Section 5.2) establish the nontangential estimate (1.18) on $\nabla^m \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}}$ in the special case where $2m \geq n+1$. In Section 5.3 we will extend to the case 2m < n+1. Finally, in Section 5.4, we will complete the proof of Theorem 1.15 by establishing the bounds (1.19) and (1.28–1.29).

5.1. Boundary values of the double layer potential. We begin by bounding the boundary values of the double layer potential.

Lemma 5.1. Let L be an operator of the form (1.1) of order 2m associated to t-independent coefficients \boldsymbol{A} that satisfy the bounds (2.2) and (2.3). Then there is an $\varepsilon > 0$ such that if $2 - \varepsilon , then$

(5.2)
$$\|\dot{\mathbf{T}}\mathbf{r}_{m-1}^{+} \mathcal{D}^{\mathbf{A}} \dot{\mathbf{f}}\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p} \|\dot{\mathbf{f}}\|_{\dot{W}A_{m-1,0}^{p}(\mathbb{R}^{n})},$$

(5.3)
$$\|\dot{\mathbf{T}}\mathbf{r}_m^+ \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}}\|_{L^p(\mathbb{R}^n)} \le C_p \|\dot{\boldsymbol{\varphi}}\|_{\dot{W}A^p_{m-1,1}(\mathbb{R}^n)}$$

whenever $\dot{\mathbf{f}} \in \dot{W}A^2_{m-1,1/2}(\mathbb{R}^n) \cap \dot{W}A^p_{m-1,0}(\mathbb{R}^n)$ and whenever $\dot{\boldsymbol{\varphi}} = \dot{\mathbf{T}}\mathbf{r}_{m-1}\Phi$ for some $\Phi \in C_0^{\infty}(\mathbb{R}^{n+1})$.

Proof. By [Bar17, formulas (5.4) and (5.6)], we have the duality relation

$$\langle \dot{\boldsymbol{g}}, \dot{\mathbf{T}}\mathbf{r}_{m-1}^{+} \mathcal{D}^{\boldsymbol{A}} \dot{\boldsymbol{f}} \rangle_{\mathbb{R}^{n}} = -\langle \dot{\mathbf{M}}_{\boldsymbol{A}^{*}}^{-} \mathcal{S}^{L^{*}} \dot{\boldsymbol{g}}, \dot{\boldsymbol{f}} \rangle_{\mathbb{R}^{n}}$$

for all $\dot{\boldsymbol{f}} \in \dot{W}A^2_{m-1,1/2}(\mathbb{R}^n)$ and all $\dot{\boldsymbol{g}} \in \dot{B}^{2,2}_{-1/2}(\mathbb{R}^n)$. Here $\dot{\mathbf{M}}^-_{\boldsymbol{A}^*}$ represents the Neumann boundary operator of [Bar17]; if $u \in \dot{W}^2_m(\mathbb{R}^{n+1}_-)$ then the definition of $\dot{\mathbf{M}}^-_{\boldsymbol{A}^*}$ u in [Bar17] coincides with that in [BHM17b].

Recall from the definition (2.13) of \mathcal{S}^{L^*} that if $\dot{\boldsymbol{g}} \in \dot{B}^{2,2}_{-1/2}(\mathbb{R}^n)$ then $\mathcal{S}^{L^*}\dot{\boldsymbol{g}} \in \dot{W}^2_m(\mathbb{R}^{n+1})$. By [BHM17b, Theorem 6.2], if $\mathcal{S}^{L^*}\dot{\boldsymbol{g}} \in \dot{W}^2_m(\mathbb{R}^{n+1})$ and 1 , then

$$\begin{split} |\langle \dot{\boldsymbol{g}}, \dot{\mathbf{T}}\mathbf{r}_{m-1}^{+} \, \mathcal{D}^{\boldsymbol{A}} \dot{\boldsymbol{f}} \rangle_{\mathbb{R}^{n}}| &= |\langle \dot{\mathbf{M}}_{\boldsymbol{A}^{*}}^{-} \, \mathcal{S}^{L^{*}} \dot{\boldsymbol{g}}, \dot{\boldsymbol{f}} \rangle_{\mathbb{R}^{n}}| \\ &\leq C \|\dot{\boldsymbol{f}}\|_{\dot{W}\boldsymbol{A}_{m-1,0}^{p}(\mathbb{R}^{n})} \big(\|\mathcal{A}_{2}^{-} (t\nabla^{m} \partial_{t} \mathcal{S}^{L^{*}} \dot{\boldsymbol{g}})\|_{L^{p'}(\mathbb{R}^{n})} + \|\widetilde{N}_{-} (\nabla^{m} \mathcal{S}^{L^{*}} \dot{\boldsymbol{g}})\|_{L^{p'}(\mathbb{R}^{n})} \big). \end{split}$$

Here \mathcal{A}_2^- and \widetilde{N}_- are defined analogously to \mathcal{A}_2^+ and \widetilde{N}_+ in the lower half space. By Lemmas 4.21 and 4.23, if $\dot{\boldsymbol{g}} \in L^{p'}(\mathbb{R}^n) \cap \dot{B}^{2,2}_{-1/2}(\mathbb{R}^n)$ for some $2-\varepsilon < p' < 2+\varepsilon$, then

$$|\langle \dot{\boldsymbol{g}}, \dot{\mathbf{T}}\mathbf{r}_{m-1}^{+}\,\mathcal{D}^{\boldsymbol{A}}\dot{\boldsymbol{f}}\rangle_{\mathbb{R}^{n}}| \leq C\|\dot{\boldsymbol{f}}\|_{\dot{W}A_{m-1,0}^{p}(\mathbb{R}^{n})}\|\dot{\boldsymbol{g}}\|_{L^{p'}(\mathbb{R}^{n})}.$$

Because $L^{p'}(\mathbb{R}^n) \cap \dot{B}^{2,2}_{-1/2}(\mathbb{R}^n)$ is dense in $L^{p'}(\mathbb{R}^n)$, the bound (5.2) is valid.

We now turn to the bound (5.3). We wish to bound $\operatorname{Tr}^+ \partial^{\alpha} \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}}$ for all $|\alpha| = m$. We will need separate arguments for the cases $\alpha_{n+1} < m$ and $\alpha_{n+1} > 0$.

We begin with the case $\alpha_{n+1} < |\alpha| = m$; then there is some j with $1 \le j \le n$ such that $\alpha_j \ge 1$, and so $\alpha = \gamma + \vec{e_j}$ for some multiindex γ with nonnegative entries. Integrating by parts, we have that if $h \in C_0^{\infty}(\mathbb{R}^n)$ then

$$\langle h, \operatorname{Tr}^+ \partial^{\alpha} \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}} \rangle_{\mathbb{R}^n} = -\langle \partial_{x_i} h, \operatorname{Tr}^+ \partial^{\gamma} \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}} \rangle_{\mathbb{R}^n}.$$

By formula (5.4), if $\dot{\boldsymbol{\varphi}} \in \dot{W}A^2_{m-1,1/2}(\mathbb{R}^n)$ then

$$\langle h, \operatorname{Tr}^+ \partial^{\alpha} \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}} \rangle_{\mathbb{R}^n} = \langle \dot{\mathbf{M}}_{\mathbf{A}^*}^- \mathcal{S}^{L^*} (\partial_{x_i} h \dot{\boldsymbol{e}}_{\gamma}), \dot{\boldsymbol{\varphi}} \rangle_{\mathbb{R}^n}.$$

The function $\partial_{x_j} h$ is in $\dot{B}^{2,2}_{-1/2}(\mathbb{R}^n)$, and so $\mathcal{S}^{L^*}(\partial_j h \dot{\boldsymbol{e}}_{\gamma}) \in \dot{W}^2_m(\mathbb{R}^{n+1})$. By [BHM17b, Theorem 6.1], if $1 < p' < \infty$ then

$$|\langle \dot{\mathbf{M}}_{A^*}^{-}\,\mathcal{S}^{L^*}(\partial_{j}h\dot{\boldsymbol{e}}_{\gamma}),\dot{\boldsymbol{\varphi}}\rangle_{\mathbb{R}^{n}}|\leq C\|\dot{\boldsymbol{\varphi}}\|_{\dot{W}\!A^{p}_{m-1,1}(\mathbb{R}^{n})}\|\mathcal{A}_{2}^{-}(t\nabla^{m}\mathcal{S}^{L^*}(\partial_{j}h\dot{\boldsymbol{e}}_{\gamma}))\|_{L^{p'}(\mathbb{R}^{n})}.$$

By formula (4.6), $\nabla^m \mathcal{S}^{L^*}(\partial_j h \dot{\boldsymbol{e}}_{\gamma}) = -\nabla^m \mathcal{S}^{L^*}_{\nabla}(h \dot{\boldsymbol{e}}_{\alpha})$. Thus,

$$|\langle h, \operatorname{Tr}^+ \partial^\alpha \mathcal{D}^{\boldsymbol{A}} \dot{\boldsymbol{\varphi}} \rangle_{\mathbb{R}^n}| \leq C \|\dot{\boldsymbol{\varphi}}\|_{\dot{W}A^p_{m-1,1}(\mathbb{R}^n)} \|\mathcal{A}_2^-(t\nabla^m \mathcal{S}^{L^*}_\nabla(h\dot{\boldsymbol{e}}_\alpha))\|_{L^{p'}(\mathbb{R}^n)}.$$

By Lemma 4.23, if $h \in L^{p'}(\mathbb{R}^n)$ for some $2 - \varepsilon < p' < 2 + \varepsilon$, then

$$|\langle h, \operatorname{Tr}^+ \partial^{\alpha} \mathcal{D}^{\boldsymbol{A}} \dot{\boldsymbol{\varphi}} \rangle_{\mathbb{R}^n}| \leq C \|\dot{\boldsymbol{\varphi}}\|_{\dot{W}A^p_{m-1,1}(\mathbb{R}^n)} \|h\|_{L^{p'}(\mathbb{R}^n)}.$$

By duality and by density, we have that

$$\|\operatorname{Tr}^{+} \partial^{\alpha} \mathcal{D}^{A} \dot{\varphi}\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p} \|\dot{\varphi}\|_{\dot{W}A^{p}_{m-1,1}(\mathbb{R}^{n})}$$

whenever $\alpha_{n+1} < m$.

Finally, we turn to $\partial_{n+1}^m \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}}$. In fact, we will bound $\partial^{\alpha} \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}}$ for any α with $|\alpha| = m$ and $\alpha_{n+1} > 0$. Recall that $\dot{\boldsymbol{\varphi}} = \mathbf{\dot{T}r}_{m-1} \Phi$ for some $\Phi \in \dot{W}_m^2(\mathbb{R}^{n+1})$. As in the proof of [BHM17a, formula (6.3)], for almost every $(x,t) \in \mathbb{R}_+^{n+1}$, by formulas (2.12) and (3.10) we have that

$$(5.5) \ \partial^{\alpha} \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}}(x,t) = -\sum_{|\xi|=|\beta|=m} \int_{\mathbb{R}^{n+1}_{-}} \partial_{x,t}^{\alpha} \partial_{y,s}^{\xi} E^{L}(x,t,y,s) \, A_{\xi\beta}(y) \, \partial^{\beta} \Phi(y,s) \, ds \, dy.$$

Let $\gamma = \alpha - \vec{e}_{n+1}$. By assumption, $\gamma \in (\mathbb{N}_0)^{n+1}$ is a multiindex with nonnegative entries. By formula (3.13),

$$\partial^{\gamma} \partial_{t} \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}}(x,t) = \sum_{|\xi| = |\beta| = m} \int_{\mathbb{R}^{n+1}_{-}} \partial_{x,t}^{\gamma} \partial_{s} \partial_{y,s}^{\xi} E^{L}(x,t,y,s) \, A_{\xi\beta}(y) \, \partial^{\beta} \Phi(y,s) \, ds \, dy.$$

If $\Phi \in C_0^{\infty}(\mathbb{R}^{n+1})$, then we may integrate by parts in s to see that

$$\partial^{\gamma} \partial_{t} \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}}(x,t) = -\sum_{|\xi|=|\beta|=m} \int_{\mathbb{R}_{-}^{n+1}} \partial_{x,t}^{\gamma} \partial_{y,s}^{\xi} E^{L}(x,t,y,s) A_{\xi\beta}(y) \partial^{\beta} \partial_{s} \Phi(y,s) ds dy$$
$$-\sum_{|\xi|=|\beta|=m} \int_{\mathbb{R}^{n}} \partial_{x,t}^{\gamma} \partial_{y,s}^{\xi} E^{L}(x,t,y,0) A_{\xi\beta}(y) \partial^{\beta} \Phi(y,0) dy.$$

By formulas (2.12) and (2.15), we have that if $\Phi \in C_0^{\infty}(\mathbb{R}^{n+1})$ and $|\gamma| = m-1$, then

(5.6)
$$\partial^{\gamma} \partial_t \mathcal{D}^{\mathbf{A}} (\mathbf{\dot{T}r}_{m-1} \Phi)(x,t)$$

$$= \partial^{\gamma} \mathcal{D}^{\mathbf{A}} (\mathbf{\dot{T}r}_{m-1} \, \partial_{n+1} \Phi)(x,t) - \partial^{\gamma} \mathcal{S}^{L}_{\nabla} (\mathbf{A} \, \mathbf{\dot{T}r}_{m} \, \Phi)(x,t).$$

Let $\Psi(x,t) = \Phi(x,t) - \eta(t) t^m \partial_{n+1}^m \Phi(x,0)/m!$ for a smooth cutoff function η equal to 1 near t=0. Then $\mathbf{\dot{T}r}_{m-1}\Psi = \mathbf{\dot{T}r}_{m-1}\Phi$ and $\partial_{n+1}^m \Psi(x,0) = 0$, and so

$$\|\dot{\mathbf{T}}\mathbf{r}_{m-1}^{+}\,\partial_{n+1}\Psi\|_{\dot{W}A_{m-1,0}^{p}(\mathbb{R}^{n})}+\|\boldsymbol{A}\,\dot{\mathbf{T}}\mathbf{r}_{m}^{+}\,\Psi\|_{L^{p}(\mathbb{R}^{n})}\leq C\|\dot{\boldsymbol{\varphi}}\|_{\dot{W}A_{m-1,1}^{p}(\mathbb{R}^{n})}.$$

Thus, by the bounds (5.2) and (4.22), we have that

$$\|\operatorname{Tr}^+ \partial^{\alpha} \mathcal{D}^{\boldsymbol{A}} \dot{\boldsymbol{\varphi}}\|_{L^p(\mathbb{R}^n)} \le C_p \|\dot{\boldsymbol{\varphi}}\|_{\dot{W}A^p_{m-1,1}(\mathbb{R}^n)}$$

whenever $\alpha_{n+1} > 0$ and p is sufficiently close to 2. This completes the proof.

5.2. Nontangential estimates for operators of high order. In this section we will establish the bound (1.18) in the special case $2m \ge n+1$. In Section 5.3 we will pass to the case of lower order operators, and in Section 5.4 we will establish the bounds (1.19), (1.28) and (1.29).

Lemma 5.7. Let L be an operator of the form (1.1) of order $2m \ge n+1$ associated to t-independent coefficients **A** that satisfy the bounds (2.2) and (2.3). Then the bound (1.18) is valid; that is, there is some $\varepsilon > 0$ such that if $2 - \varepsilon , then$

$$\|\widetilde{N}_{+}(\nabla^{m}\mathcal{D}^{\boldsymbol{A}}\dot{\boldsymbol{\varphi}})\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p}\|\dot{\boldsymbol{\varphi}}\|_{\dot{W}A^{p}_{m-1,1}(\mathbb{R}^{n})}$$

for any $\dot{\varphi} = \dot{\mathbf{Tr}}_{m-1} \Phi$ for some Φ smooth and compactly supported.

The remainder of this section will be devoted to a proof of this lemma.

We will apply Lemma 3.18 to $\nabla^m u$, where $u = \mathcal{D}^{\tilde{\mathbf{A}}}\dot{\boldsymbol{\varphi}}$. Let $Q = Q(x_0, t_0) \subset \mathbb{R}^n$ be a cube of side length t_0 and with midpoint x_0 . As in the proof of Lemma 4.14, by Lemma 3.19, if u_Q satisfies $L(u - u_Q) = 0$ in $2Q \times (-\ell(Q), \ell(Q))$, then

$$(5.8) \qquad \left(\oint_{Q} \int_{t_{0}/6}^{t_{0}/2} |\nabla^{m} u|^{2} \right)^{1/2} \leq \left(\oint_{Q} \int_{t_{0}/6}^{t_{0}/2} |\nabla^{m} u_{Q}|^{2} \right)^{1/2}$$

$$+ C\ell(Q) \oint_{2Q} \int_{-\ell(Q)}^{\ell(Q)} |\partial_{t}^{m+1}(u - u_{Q})|$$

$$+ C \oint_{2Q} |\dot{\mathbf{T}}\mathbf{r}_{m}^{+} u_{Q}| + C \oint_{2Q} |\dot{\mathbf{T}}\mathbf{r}_{m}^{+} u|.$$

The final term is at most $C\mathcal{M}(\dot{\mathbf{T}}\mathbf{r}_m^+ u)(x_0) = C\mathcal{M}(\dot{\mathbf{T}}\mathbf{r}_m^+ \mathcal{D}^{\mathbf{A}}\dot{\boldsymbol{\varphi}})(x_0)$, which we may control using Lemma 5.1 and boundedness of the maximal operator. We will bound the remaining terms much as in the proof of Lemma 4.14. Our first step is to construct an appropriate u_O .

Definition 5.9. Suppose that $\dot{\varphi} = \mathbf{\dot{T}r}_{m-1} \Phi$ for some $\Phi \in C_0^{\infty}(\mathbb{R}^{n+1})$, and let $R \subset \mathbb{R}^n$ be a cube. We define $\dot{\varphi}_R$ as follows.

Let $\rho_R : \mathbb{R}^n \mapsto [0, \infty)$ be smooth, supported in (4/3)R and identically equal to 1 in R, and let $\eta : \mathbb{R} \mapsto [0, \infty)$ be smooth, supported in (-2, 2) and equal to 1 in (-1, 1).

Let $\Phi_R(x,t) = \rho_R(x)\eta(2t/\ell(R))(\Phi(x,t) - P_R(x,t)) + P_R(x,t)$, where P_R is the polynomial of degree m-1 that satisfies $\int_{(4/3)R} \nabla^k \Phi(x,0) - \nabla^k P_R(x,0) dx = 0$ for any $0 \le k \le m-1$. Observe that $\nabla^m \Phi_R = 0$ outside of $(4/3)R \times (-\ell(R),\ell(R))$ and that $\Phi_R = \Phi$ in $R \times (-\ell(R)/2,\ell(R)/2)$.

Let $\dot{\boldsymbol{\varphi}}_R = \dot{\mathbf{T}}\mathbf{r}_{m-1}\,\Phi_R$. Observe that $\dot{\boldsymbol{\varphi}}_R = \dot{\boldsymbol{\varphi}}$ in R and $\dot{\boldsymbol{\varphi}}_R$ is constant outside (4/3)R.

By the Poincaré inequality, $\dot{\boldsymbol{\varphi}}_R \in \dot{W}A^p_{m-1,1}(\mathbb{R}^n)$ for any $1 \leq p < \infty$, with $\|\dot{\boldsymbol{\varphi}}_R\|_{\dot{W}A^p_{m-1,1}(\mathbb{R}^n)} \leq C\|\nabla_{\parallel}\dot{\boldsymbol{\varphi}}\|_{L^p((4/3)R)}$. Furthermore, by formula (2.12) for the double layer potential,

$$\mathcal{D}^{\boldsymbol{A}}\boldsymbol{\dot{\varphi}}-\mathcal{D}^{\boldsymbol{A}}\boldsymbol{\dot{\varphi}}_{R}=\mathbf{1}_{-}\boldsymbol{\Phi}-\mathbf{1}_{-}\boldsymbol{\Phi}_{R}-\boldsymbol{\Pi}^{L}(\mathbf{1}_{-}\boldsymbol{A}\boldsymbol{\nabla}^{m}\boldsymbol{\Phi})+\boldsymbol{\Pi}^{L}(\mathbf{1}_{-}\boldsymbol{A}\boldsymbol{\nabla}^{m}\boldsymbol{\Phi}_{R})$$

and so $\mathcal{D}^{\mathbf{A}}\dot{\boldsymbol{\varphi}} - \mathcal{D}^{\mathbf{A}}\dot{\boldsymbol{\varphi}}_R \in \dot{W}_m^2(R \times (-\ell(R)/2, \ell(R)/2))$ with $L(\mathcal{D}^{\mathbf{A}}\dot{\boldsymbol{\varphi}} - \mathcal{D}^{\mathbf{A}}\dot{\boldsymbol{\varphi}}_R) = 0$ in $R \times (-\ell(R)/2, \ell(R)/2)$.

We will use this definition again in the proof of Corollary 5.15.

Let $u_Q = \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}}_{8Q}$, so $\dot{\boldsymbol{\varphi}} = \dot{\boldsymbol{\varphi}}_{8Q}$ in 8Q and $L(u - u_Q) = 0$ in $8Q \times (-4\ell(Q), 4\ell(Q))$.

Let $q \geq 1$. We will impose further conditions on q throughout the proof. By Hölder's inequality,

$$\int_{2Q} |\dot{\mathbf{T}}\mathbf{r}_{m}^{+} u_{Q}(x)| dx \leq \left(\int_{2Q} |\dot{\mathbf{T}}\mathbf{r}_{m}^{+} u_{Q}(x)|^{q} dx \right)^{1/q}$$

and by Lemma 5.1 and the definition 5.9 of $\dot{\varphi}_{8Q}$, if |q-2| is small enough then

$$\int_{2Q} |\dot{\mathbf{T}}\mathbf{r}_m^+ \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}}_{8Q}| \le C \left(\frac{1}{|2Q|} \int_{\mathbb{R}^n} |\nabla_{\parallel} \dot{\boldsymbol{\varphi}}_{8Q}|^q \right)^{1/q} \le C \mathcal{M}(|\nabla_{\parallel} \dot{\boldsymbol{\varphi}}|^q)(x_0)^{1/q}.$$

To contend with the remaining terms in the bound (5.8), we will need a decomposition $\dot{\varphi} = \sum_{j=0}^{\infty} \dot{\varphi}_j$ and functions Ψ_j such that $\dot{\mathbf{T}}\mathbf{r}_{m-1} \Psi_j = \dot{\varphi}_j$.

Let $\Phi_0 = \overline{\Phi}_{8Q}$ and $\dot{\boldsymbol{\varphi}}_0 = \dot{\boldsymbol{\varphi}}_{8Q} = \mathbf{\dot{T}r}_{m-1}\Phi_0$, and for each $j \geq 1$, let $\Phi_j = \Phi_{2^{j+3}Q} - \Phi_{2^{j+2}Q}$ and $\dot{\boldsymbol{\varphi}}_j = \mathbf{\dot{T}r}_{m-1}\Phi_j = \dot{\boldsymbol{\varphi}}_{2^{j+3}Q} - \dot{\boldsymbol{\varphi}}_{2^{j+2}Q}$, where Φ_R and $\dot{\boldsymbol{\varphi}}_R$ are as in Definition 5.9.

Then $\dot{\boldsymbol{\varphi}} = \sum_{i=0}^{\infty} \dot{\boldsymbol{\varphi}}_i$, $\nabla_{\parallel} \dot{\boldsymbol{\varphi}}_i = \text{outside of } (4/3)2^{j+3}Q \subset 2^{j+4}Q$, and

$$\|\nabla_{\|}\dot{\varphi}_{j}\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p}\|\nabla_{\|}\dot{\varphi}_{j}\|_{L^{p}(2^{j+4}Q)}$$

for any $1 \leq p < \infty$. Furthermore, if $j \geq 1$ then $\dot{\boldsymbol{\varphi}}_j = 0$ in $2^{j+2}Q$. We will need extensions Ψ_j with $\dot{\boldsymbol{\varphi}}_j = \mathbf{\dot{T}r}_{m-1}\Psi_j$. We have that $\dot{\boldsymbol{\varphi}}_j = \mathbf{\dot{T}r}_{m-1}\Phi_j$; however, we will need Ψ_j to satisfy some bounds in terms of the norms of the boundary values $\dot{\boldsymbol{\varphi}}_i$, and so we cannot use the obvious extensions $\Psi_i = \Phi_i$.

We define extensions Ψ_j as follows. Let $\varphi_{j,k}(x) = \partial_{n+1}^k \Phi_j(x,0)$; we have that $|\nabla_{\parallel}^{m-k}\varphi_{j,k}(x)| \leq |\dot{\boldsymbol{\varphi}}_k(x)|$. Let $\theta: \mathbb{R}^n \mapsto \mathbb{R}$ be smooth, nonnegative, and satisfy the conditions $\int_{\mathbb{R}^n} \theta = 1$, $\theta(x) = 0$ whenever |x| > 1, and $\int_{\mathbb{R}^n} x^{\zeta} \theta(x) dx = 0$ for all multiindices $\zeta \in (\mathbb{N}_0)^n$ with $1 \leq |\zeta| \leq m-1$. Let $\theta_t(x) = t^{-n}\theta(x/t)$. Define

$$H_j(x,t) = \sum_{k=0}^{m-1} \frac{1}{k!} t^k \varphi_{j,k} * \theta_t(x) = \sum_{k=0}^{m-1} \frac{1}{k!} t^k \int_{\mathbb{R}^n} \varphi_{j,k}(x - ty) \,\theta(y) \,dy.$$

By the proof of [BHM17c, Lemma 3.3], we have that $\mathbf{\dot{T}r}_{m-1} H_j = \boldsymbol{\dot{\varphi}}_i$. Furthermore, if $x \in \mathbb{R}^n \setminus 2^{j+4}Q$ and $|t| < \operatorname{dist}(x, 2^{j+4}Q)$, then $\nabla^m H_j(x, t) = 0$. Finally, if $j \geq 1$, if $x \in 2^{j+2}Q$, and if $|t| < \operatorname{dist}(x, \mathbb{R}^n \setminus 2^{j+2}Q)$, then $\nabla^{m-1}H_j(x,t) = 0$.

Observe that if $\zeta \in (\mathbb{N}_0)^n$ is a multiindex, then $\|(\partial_{\parallel}^{\zeta}\theta)_t\|_{L^1(\mathbb{R}^n)}$ is bounded, uniformly in t, and so convolution with $(\partial_{\parallel}^{\zeta}\theta)_t$ represents a bounded operator on $L^q(\mathbb{R}^n)$ for any $1 \leq q \leq \infty$. Using this fact, it is elementary to show that

$$\sup_{t\in\mathbb{R}} \|\nabla^m H_j(\cdot,t)\|_{L^q(\mathbb{R}^n)} \le C \|\nabla_{\parallel} \dot{\varphi}_j\|_{L^q(\mathbb{R}^n)} \le C \|\nabla_{\parallel} \dot{\varphi}\|_{L^q(2^{j+4}Q)}.$$

This is not true of the function Φ_i .

However, observe that $\nabla^m H_j$ is not compactly supported. Let

$$\Psi_j(x,t) = (H_j(x,t) - P_j(x,t)) \eta\left(\frac{t}{2^{j+2}\ell(Q)}\right) + P_j(x,t),$$

where $\eta(t) = 1$ if $|t| \le 1$ and $\eta(t) = 0$ if $|t| \ge 2$, and where $P_j(x, t)$ is the polynomial of degree m-1 with

$$\int_{2^{j+5}Q} \int_{-2^{j+3}\ell(Q)}^{-2^{j+2}\ell(Q)} \nabla^k (H_j(x,t) - P_j(x,t)) dt dx = 0$$

for all $0 \le k \le m-1$. Observe that $H_j(x,t) = \Psi_j(x,t)$ whenever $|t| < -2^{j+2}\ell(Q)$. By the Poincaré inequality, $\int_{\mathbb{R}^{n+1}_-} |\nabla^m \Psi_j|^q \le C 2^j \ell(Q) \|\nabla_{\parallel} \dot{\varphi}\|_{L^q(2^{j+4}Q)}^q$ for any $1 \le q < \infty$.

We now return to the terms in the bound (5.8). By Theorem 3.2,

$$\left(\oint_Q \oint_{t_0/6}^{t_0/2} |\nabla^m u_Q|^2 \right)^{1/2} \le \frac{C}{\ell(Q)^{(n+1)/q}} \|\nabla^m u_Q\|_{L^q(\mathbb{R}^{n+1})}.$$

By formula (2.12), if $|\alpha| = m$, $x \in \mathbb{R}^n$ and t > 0, then

$$\partial^{\alpha} u_Q(x,t) = \partial^{\alpha} \mathcal{D}^{\mathbf{A}} \dot{\boldsymbol{\varphi}}_0(x,t) = \partial^{\alpha} \Pi^L (\mathbf{1}_{-} \mathbf{A} \nabla^m \Psi_0)(x,t).$$

By [Bar16, Lemma 43], if $p_{L^*,0}^- < q < p_{L,0}^+$, where $p_{L,0}^+$ is as in Theorem 3.2 and where $1/p_{L^*,0}^+ + 1/p_{L^*,0}^- = 1$, then $\nabla^m \Pi^L$ is bounded $L^q(\mathbb{R}^{n+1}) \mapsto L^q(\mathbb{R}^{n+1})$, and so

$$\left(\int_{Q} \int_{t_0/6}^{t_0/2} |\nabla^m u_Q|^2 \right)^{1/2} \le \frac{C}{\ell(Q)^{(n+1)/q}} \|\nabla^m \Psi_0\|_{L^q(\mathbb{R}^{n+1})}.$$

By our bounds on Ψ_0 .

$$\left(\oint_{Q} \oint_{t_{0}/6}^{t_{0}/2} |\nabla^{m} u_{Q}|^{2} \right)^{1/2} \leq \frac{C}{\ell(Q)^{n/q}} \|\nabla_{\parallel} \dot{\varphi}_{0}\|_{L^{q}(\mathbb{R}^{n})} \leq \frac{C}{\ell(Q)^{n/q}} \|\nabla_{\parallel} \dot{\varphi}\|_{L^{q}(8Q)}
\leq C \mathcal{M}(|\nabla_{\parallel} \dot{\varphi}|^{q}) (x_{0})^{1/q}.$$

Finally, let $u_f = u - u_Q = \mathcal{D}^{\mathbf{A}}(\dot{\boldsymbol{\varphi}} - \dot{\boldsymbol{\varphi}}_0)$. By formula (2.12) for the double layer potential, and because $\dot{\boldsymbol{\varphi}} = \sum_{j=0}^{\infty} \dot{\boldsymbol{\varphi}}_j$, we have that

$$\begin{aligned} |\partial_t^{m+1} u_f(x,t)| &= \left| \partial_t^{m+1} \Pi^L \left(\sum_{j=1}^{\infty} \mathbf{1}_{-} \mathbf{A} \nabla^m \Psi_j \right) (x,t) \right| \\ &\leq \sum_{j=1}^{\infty} |\partial_t^{m+1} \Pi^L (\mathbf{1}_{-} \mathbf{A} \nabla^m \Psi_j) (x,t)|. \end{aligned}$$

Let $x \in 2Q$ and let $-\ell(Q) < t < \ell(Q)$. Recall that if $j \ge 1$, then $\nabla^m \Psi_j = 0$ in $\{(y,s): |s| < \operatorname{dist}(y,\mathbb{R}^n \setminus 2^{j+2}Q)\}$, and so $\mathbf{1}_{-} \mathbf{A} \nabla^m \Psi_j = 0$ in $2^{j+1}Q \times (-2^{j}\ell(Q),\infty)$. Thus, $L(\Pi^L(\mathbf{1}_{-} \mathbf{A} \nabla^m \Psi_j)) = 0$ in this set. If m is large enough, then by the bound (3.4),

$$|\partial_t^{m+1} u_f(x,t)| \leq \sum_{j=1}^{\infty} C \int_{2^{j+1/3}Q} \int_{-2^{j-2/3}\ell(Q)}^{2^{j-2/3}\ell(Q)} |\partial_t^{m+1} \Pi^L(\mathbf{1}_- \mathbf{A} \nabla^m \Psi_j)(y,s)| \, ds \, dy.$$

By Hölder's inequality and the Caccioppoli inequality,

$$|\partial_t^{m+1} u_f(x,t)| \leq \sum_{i=1}^{\infty} \frac{C}{2^{j}\ell(Q)} \left(\oint_{2^{j+2/3}Q} \oint_{-2^{j-1/3}\ell(Q)}^{2^{j-1/3}\ell(Q)} |\partial_t^m \Pi^L(\mathbf{1}_- \mathbf{A} \nabla^m \Psi_j)(y,s)|^2 \, ds \, dy \right)^{1/2}$$

and by Theorem 3.2, if q > 0 then

$$|\partial_t^{m+1} u_f(x,t)| \leq \sum_{j=1}^{\infty} \frac{C}{2^{j}\ell(Q)} \bigg(\oint_{2^{j+1}Q} \oint_{-2^{j}\ell(Q)}^{2^{j}\ell(Q)} |\partial_t^{m} \Pi^L(\mathbf{1}_{-} \mathbf{A} \nabla^m \Psi_j)|^q \bigg)^{1/q}.$$

If $p_{L^*,0}^- < q < p_{L,0}^+$, then again by boundedness of $\nabla^m \Pi^L$ and our bounds on $\nabla^m \Psi_j$,

$$|\partial_t^{m+1} u_f(x,t)| \leq \sum_{j=1}^{\infty} \frac{C}{(2^{j}\ell(Q))^{n/q+1}} \|\nabla_{\parallel} \dot{\varphi}\|_{L^q(2^{j+4}Q)} \leq \frac{C}{\ell(Q)} \mathcal{M}(|\nabla_{\parallel} \dot{\varphi}|^q) (x_0)^{1/q}.$$

Thus, by Lemma 3.18,

$$\widetilde{N}_{+}(\nabla^{m}\mathcal{D}^{A}\dot{\boldsymbol{\varphi}})(x_{0}) \leq C\mathcal{M}(|\nabla_{\parallel}\dot{\boldsymbol{\varphi}}|^{q})(x_{0})^{1/q} + \mathcal{M}(\dot{\mathbf{Tr}}_{m}^{+}\mathcal{D}^{A}\dot{\boldsymbol{\varphi}})$$

for any q sufficiently close to 2. Choosing q < p, we have that by boundedness of the maximal operator \mathcal{M} and by Lemma 5.1,

$$\|\widetilde{N}_{+}(\nabla^{m}\mathcal{D}^{A}\dot{\boldsymbol{\varphi}})\|_{L^{p}(\mathbb{R}^{n})} \leq C\|\nabla_{\parallel}\dot{\boldsymbol{\varphi}}\|_{L^{p}(\mathbb{R}^{n})}$$

as desired.

5.3. Reduction to operators of high order. We must now extend to the case of operators of lower order. Recall formulas (4.19) and (4.20). Our goal is to establish an analogous formula for \mathcal{D}^{A} . That is, we wish to find an operator \mathcal{O} such that

$$\mathcal{D}^{A}\dot{\boldsymbol{\varphi}} = \Delta^{M}\mathcal{D}^{\widetilde{A}}(\mathcal{O}\dot{\boldsymbol{\varphi}}),$$

where \widetilde{A} is given by formula (4.18). We remark that we will need to take somewhat more care in this case, as the natural domain of $\mathcal{D}^{\widetilde{A}}$ is not $\dot{B}_{1/2}^{2,2}$ but instead a closed proper subset $\dot{W}A^2_{m-1,1/2}$. Let $m \geq 1$ and $M \geq 1$ be integers. Let $\dot{\varphi}$ be an array indexed by multiindices

of length m-1. We define $\mathcal{O}\dot{\boldsymbol{\varphi}}$ as follows.

If $\delta \in (\mathbb{N}_0)^{n+1}$ is a multiindex with $|\delta| = m + 2M - 1$, then there is some nonnegative integer $\ell = \delta_{n+1}$ and some multiindex $\xi \in (\mathbb{N}_0)^n$ with $|\xi| = 2M + m - 1$ $1 - \ell$ such that $\delta = (\xi, \ell)$. We define

$$(\mathcal{O}\dot{\boldsymbol{\varphi}})_{(\boldsymbol{\varepsilon},\ell)} = 0, \qquad \qquad \ell < 2M,$$

$$(\mathcal{O}\dot{\boldsymbol{\varphi}})_{(\xi,\ell)} = \varphi_{(\xi,\ell-2M)} - \sum_{k=1}^{M} \sum_{|\zeta|=k} \tilde{\kappa}_{\zeta}^{M} (\mathcal{O}\dot{\boldsymbol{\varphi}})_{(\xi+2\zeta,\ell-2k)}, \quad 2M \le \ell \le 2M + m - 1$$

where $\tilde{\kappa}_{\zeta}^{M} = \kappa_{(\zeta, M-k)} = M!/\zeta!(M-k)!$ whenever $|\zeta| = k$, and where κ_{ξ} and $\zeta!$ are

There are then constants $\mu_{\gamma,\delta}$ depending only on γ, δ, m, M and the dimension n+1 such that

$$(\mathcal{O}\dot{\boldsymbol{\varphi}})_{\delta} = \sum_{|\gamma|=m-1} \mu_{\gamma,\delta} \varphi_{\gamma}$$

for all $|\delta| = m + 2M - 1$. As such, \mathcal{O} is bounded on $L^p(\mathbb{R}^n)$ and $\dot{W}_1^p(\mathbb{R}^n)$ for any $1 \le p \le \infty$.

We now show that if $\dot{\varphi}$ is in the domain of \mathcal{D}^{A} , then $\mathcal{O}\dot{\varphi}$ is in the domain of $\mathcal{D}^{\tilde{A}}$.

Lemma 5.10. Let $m \ge 1$ and let $M \ge 1$.

If $\dot{\boldsymbol{\varphi}} = \dot{\mathbf{T}}\mathbf{r}_{m-1} F$ for some $F \in C_0^{\infty}(\mathbb{R}^{n+1})$, then $\mathcal{O}\dot{\boldsymbol{\varphi}} = \dot{\mathbf{T}}\mathbf{r}_{m+2M-1} H$ for some $H \in C_0^{\infty}(\mathbb{R}^{n+1}).$

If $\dot{\boldsymbol{\varphi}} = \dot{\mathbf{T}}\mathbf{r}_{m-1}F$ for some $F \in \dot{W}_{m}^{2}(\mathbb{R}^{n+1})$, then $\mathcal{O}\dot{\boldsymbol{\varphi}} = \dot{\mathbf{T}}\mathbf{r}_{m+2M-1}H$ for some $H \in \dot{W}_{m+2M}^{2}(\mathbb{R}^{n+1})$.

Proof. Let $F_j=\operatorname{Tr}^+\partial_{n+1}^jF$. If $F\in C_0^\infty(\mathbb{R}^{n+1})$ then $F_j\in C_0^\infty(\mathbb{R}^n)$. If $F\in \dot{W}_m^2(\mathbb{R}^{n+1})$, then $\partial_{n+1}^jF\in \dot{W}_{m-j}^2(\mathbb{R}^{n+1})$ for all $0\leq j\leq m-1$, and so $F_j=\operatorname{Tr}^+\partial_{n+1}^jF$ lies in the space $\dot{B}_{m-j-1/2}^{2,2}(\mathbb{R}^n)$. Observe that if $|\gamma|=m$ and $\gamma=(\xi,j)$ for some $0\leq j\leq m-1$ and some

 $\xi \in (\mathbb{N}_0)^n$, then $\varphi_{\gamma} = \partial_{\parallel}^{\xi} F_j$.

Claim. There exist functions Φ_{ℓ} , in either $C_0^{\infty}(\mathbb{R}^n)$ or $\dot{B}_{m+2M-\ell-1/2}^{2,2}(\mathbb{R}^n)$, such that

(5.11)
$$(\mathcal{O}\dot{\varphi})_{(\xi,\ell)} = \partial_{\parallel}^{\xi} \Phi_{\ell}.$$

We will prove this by induction on ℓ .

If $\ell < 2M$ (and in particular if $\ell = 0$ or $\ell = 1$), let $\Phi_{\ell} = 0$. By definition of \mathcal{O} , formula (5.11) is valid for all $\ell < 2M$.

If $\ell \geq 2M$, then by the induction hypothesis

$$(\mathcal{O}\dot{\boldsymbol{\varphi}})_{(\xi,\ell)} = \partial_{\parallel}^{\xi} F_{\ell-2M} - \sum_{k=1}^{M} \sum_{|\zeta|=k} \widetilde{\kappa}_{\zeta}^{M} \partial^{\xi+2\zeta} \Phi_{\ell-2k}.$$

Recall from Section 4.4 that $\Delta^M = \sum_{|\delta|=M} \kappa_{\delta} \partial^{2\delta}$. Observe that $\Delta^M = (\Delta_{\parallel} + 1)^{-1}$ $\partial_{n+1}^2)^M$, where Δ_{\parallel} denotes the Laplacian in \mathbb{R}^n or in the n horizontal variables in \mathbb{R}^{n+1} , and so by definition of $\widetilde{\kappa}_{\zeta}^{M}$ and the binomial theorem,

$$\sum_{k=0}^M \sum_{\|\zeta\|=k} \widetilde{\kappa}_\zeta^M \partial_{\parallel}^{2\zeta} \partial_{n+1}^{2M-2k} = \sum_{k=0}^M \binom{M}{k} \Delta_{\parallel}^k \partial_{n+1}^{2M-2k}.$$

Therefore,

$$\sum_{|\zeta|=k} \widetilde{\kappa}_{\zeta}^{M} \partial^{2\zeta} = \binom{M}{k} \Delta_{\parallel}^{k}$$

and so

$$(\mathcal{O}\dot{oldsymbol{arphi}})_{(\xi,\ell)} = \partial_{\parallel}^{\xi} F_{\ell-2M} - \sum_{k=1}^{M} \partial^{\xi} \Delta_{\parallel}^{k} \Phi_{\ell-2k}.$$

Taking $\Phi_{\ell} = F_{\ell-2M} - \sum_{k=1}^{M} \Delta_{\parallel}^{k} \Phi_{\ell-2k}$, we see that the claim is valid.

We now must assemble the function H from the functions Φ_{ℓ} .

If $F \in C_0^{\infty}(\mathbb{R}^{n+1})$, let η be a smooth cutoff function, and let

$$H(x,t) = \sum_{\ell=0}^{m+2M-1} \frac{1}{\ell!} t^{\ell} \, \eta(t) \, \Phi_{\ell}(x).$$

If $F \in \dot{W}^2_m(\mathbb{R}^{n+1})$, and so $\Phi_\ell \in \dot{B}^{2,2}_{m+2M-\ell-1/2}(\mathbb{R}^n)$ for all $0 \le \ell \le m+2M-1$, it is well known that there is a function $H \in \dot{W}^2_{m+2M}(\mathbb{R}^{n+1})$ such that $\partial_{n+1}^\ell H(x,0) =$

 $\Phi_{\ell}(x)$ for all such ℓ . For example, as in Lemma 5.7 we may let

$$H(x,t) = \sum_{\ell=0}^{m+2M-1} \frac{1}{\ell!} t^{\ell} \, \Phi_{\ell} * \rho_{t}(x)$$

where $\rho_t(x) = t^{-n}\rho(x/t)$ for some function ρ that is smooth, compactly supported, and satisfies $\int_{\mathbb{R}^n} \rho = 1$, $\int_{\mathbb{R}^n} x^{\gamma} \rho(x) dx = 0$ for all γ with $1 \leq |\gamma| \leq m - 1$. An elementary argument involving the Fourier transform completes the proof.

We have now shown that $\mathcal{O}\dot{\boldsymbol{\varphi}}$ is the trace of some function H. We now make explicit the relationship between $\dot{\boldsymbol{\varphi}}$ and H.

Lemma 5.12. Let $m \geq 1$ and let $M \geq 1$. Let $\dot{\varphi}$ and H be as in the previous lemma. Then $\dot{\varphi} = \dot{\mathbf{T}}\mathbf{r}_{m-1} \Delta^M H$.

Proof. Let $\gamma=(\xi,j)$ for some $0\leq j\leq m-1$ and some $|\xi|=m-1-j$. Recall that $\widetilde{\kappa}_{\vec{0}}^M=\kappa_{(\vec{0},M)}=1$. We then have that

$$\varphi_{\gamma}(x) = \varphi_{(\xi,j)}(x) = \sum_{k=0}^{M} \sum_{|\zeta|=k} \widetilde{\kappa}_{\zeta}^{M}(\mathcal{O}\dot{\varphi})_{\xi+2\zeta,j+2M-2k}(x).$$

By definition of H,

$$\varphi_{\gamma}(x) = \sum_{k=0}^{M} \sum_{|\zeta|=k} \widetilde{\kappa}_{\zeta}^{M} \partial_{\parallel}^{\xi} \partial_{n+1}^{j} \partial_{\parallel}^{2\zeta} \partial_{n+1}^{2M-2k} H(x,0)$$

and by definition of $\widetilde{\kappa}_{\zeta}^{M}$,

$$\varphi_{\gamma}(x) = \partial_{\parallel}^{\xi} \partial_{n+1}^{j} \Delta^{M} H(x,0) = \partial^{\gamma} \Delta^{M} H(x,0)$$

as desired.

Finally, we establish the analogue to formulas (4.19) and (4.20) for the double layer potential.

Lemma 5.13. Let L be an operator of the form (1.1) of order 2m associated to t-independent coefficients \mathbf{A} that satisfy the bounds (2.2) and (2.3). Let $M \geq 1$ and let $\widetilde{\mathbf{A}}$ be as in formula 4.18.

Let $H \in \dot{W}^2_{m+2M}(\mathbb{R}^{n+1})$. Then

$$\mathcal{D}^{\boldsymbol{A}}(\mathbf{\dot{T}r}_{m-1}\,\Delta^{M}H) = \Delta^{M}\mathcal{D}^{\widetilde{\boldsymbol{A}}}(\mathbf{\dot{T}r}_{m+2M-1}\,H).$$

In particular, by Lemma 5.12, if $\dot{\varphi} \in \dot{W}A^2_{m-1,1/2}(\mathbb{R}^n)$, then

$$\mathcal{D}^{\mathbf{A}}\dot{\boldsymbol{\varphi}} = \Delta^{M}\mathcal{D}^{\widetilde{\mathbf{A}}}(\mathcal{O}\dot{\boldsymbol{\varphi}}).$$

Proof. Recall that by formula (2.12) for the double layer potential

$$\mathcal{D}^{\boldsymbol{A}}(\mathbf{\dot{T}}\mathbf{r}_{m-1}\,\Delta^{M}H)=\mathbf{1}_{-}\Delta^{M}H-\Pi^{L}(\mathbf{1}_{-}\boldsymbol{A}\nabla^{m}\Delta^{M}H)$$

and

$$\Delta^{M} \mathcal{D}^{\widetilde{\mathbf{A}}} (\dot{\mathbf{T}} \mathbf{r}_{m+2M-1} H) = \mathbf{1}_{-} \Delta^{M} H - \Delta^{M} \Pi^{\widetilde{L}} (\mathbf{1}_{-} \widetilde{\mathbf{A}} \nabla^{m+2M} H).$$

Thus, we need only show that $\Delta^M \Pi^{\widetilde{L}}(1_{-}\widetilde{A}\nabla^{m+2M}H) = \Pi^L(1_{-}A\nabla^m\Delta^M H)$.

By the definition (2.10) of the Newton potential, we have that

$$u = \Pi^L(\mathbf{1}_- \mathbf{A} \nabla^m \Delta^M H)$$

is the unique element of $\dot{W}_{m}^{2}(\mathbb{R}^{n+1})$ that satisfies

$$\langle \nabla^m \varphi, \mathbf{A} \nabla^m u \rangle_{\mathbb{R}^{n+1}} = \langle \nabla^m \varphi, \mathbf{A} \nabla^m \Delta^M H \rangle_{\mathbb{R}^{n+1}}$$

for all $\varphi \in \dot{W}_{m}^{2}(\mathbb{R}^{n+1})$.

Choose some such φ . Then there is a $\Phi \in \dot{W}^2_{m+2M}(\mathbb{R}^{n+1})$ such that $\Delta^M \Phi = \varphi$. Let $v = \Delta^M \Pi^{\widetilde{L}}(\mathbf{1}_{-} \widetilde{A} \nabla^{m+2M} H)$. Then

$$\langle \nabla^m \varphi, \boldsymbol{A} \nabla^m v \rangle_{\mathbb{R}^{n+1}} = \langle \nabla^m \Delta^M \Phi, \boldsymbol{A} \nabla^m \Delta^M \Pi^{\widetilde{L}} (\mathbf{1}_{-} \widetilde{\boldsymbol{A}} \nabla^{m+2M} H) \rangle_{\mathbb{R}^{n+1}}.$$

It is clear from the definition of \widetilde{L} in Section 4.4 that

$$\langle \nabla^m \varphi, \mathbf{A} \nabla^m v \rangle_{\mathbb{R}^{n+1}} = \langle \nabla^{m+2M} \Phi, \widetilde{\mathbf{A}} \nabla^{m+2M} \Pi^{\widetilde{L}} (\mathbf{1}_{-} \widetilde{\mathbf{A}} \nabla^{m+2M} H) \rangle_{\mathbb{R}^{n+1}}.$$

Again by formula (2.10),

$$\langle \nabla^m \varphi, \boldsymbol{A} \nabla^m v \rangle_{\mathbb{R}^{n+1}} = \langle \nabla^{m+2M} \Phi, \widetilde{\boldsymbol{A}} \nabla^{m+2M} H \rangle_{\mathbb{R}^{n+1}}$$

and again by the definition of \widetilde{L} ,

$$\langle \nabla^m \varphi, \mathbf{A} \nabla^m v \rangle_{\mathbb{R}^{n+1}} = \langle \nabla^m \Delta^M \Phi, \mathbf{A} \nabla^m \Delta^M H \rangle_{\mathbb{R}^{n+1}} = \langle \nabla^m \varphi, \mathbf{A} \nabla^m \Delta^M H \rangle_{\mathbb{R}^{n+1}}.$$

This equation is valid for all $\varphi \in \dot{W}_{m}^{2}(\mathbb{R}^{n+1})$, and so u = v, as desired. \square

5.4. Nontangential and area integral estimates. By Lemmas 5.7 and 5.13, we have that the bound (1.18) is valid; that is, if L and A are as in Theorem 1.15, then there is some $\varepsilon > 0$ such that if $2 - \varepsilon , then$

(5.14)
$$\|\widetilde{N}_{+}(\nabla^{m}\mathcal{D}^{A}\dot{\boldsymbol{\varphi}})\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p} \|\dot{\boldsymbol{\varphi}}\|_{\dot{W}A^{p}_{m-1,1}(\mathbb{R}^{n})}$$

for any $\dot{\varphi}$ that satisfies $\dot{\varphi} = \dot{\mathbf{T}}\mathbf{r}_{m-1}\Phi$ for some Φ smooth and compactly supported. By density, we may extend $\mathcal{D}^{\mathbf{A}}$ to an operator from $\dot{W}A^p_{m-1,1}(\mathbb{R}^n)$ to $\dot{W}^2_{m,loc}(\mathbb{R}^{n+1}_+)$ that satisfies this bound.

Using this bound, it is straightforward to establish the bounds (1.19)–(1.29).

Corollary 5.15. Let L and **A** be as in Theorem 1.15. Then the bound (1.19) is valid; that is, there is some $\varepsilon > 0$ such that

$$(5.16) \qquad \|\widetilde{N}_{+}(\nabla^{m-1}\mathcal{D}^{\boldsymbol{A}}\boldsymbol{\dot{f}})\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p}\|\boldsymbol{\dot{f}}\|_{\dot{W}A^{p}_{m-1,0}(\mathbb{R}^{n})} \qquad \text{if } 2-\varepsilon \leq p < 2+\varepsilon,$$

whenever $\dot{\mathbf{f}} = \mathbf{\dot{T}r}_{m-1} F$ for some $F \in C_0^{\infty}(\mathbb{R}^{n+1})$.

Furthermore, there is some $\varepsilon > 0$ such that the bounds (1.28) and (1.29) are valid; that is,

$$(5.17) \qquad \|\mathcal{A}_{2}^{+}(t\nabla^{m}\partial_{t}\mathcal{D}^{A}\dot{\boldsymbol{\varphi}})\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p}\|\dot{\boldsymbol{\varphi}}\|_{\dot{W}A^{p}_{m-1,1}(\mathbb{R}^{n})} \qquad \text{if } 2 \leq p < 2 + \varepsilon,$$

(5.18)
$$\|\mathcal{A}_{2}^{+}(t\nabla^{m}\mathcal{D}^{\mathbf{A}}\dot{\mathbf{f}})\|_{L^{p}(\mathbb{R}^{n})} \leq C_{p}\|\dot{\mathbf{f}}\|_{\dot{W}A_{m-1,0}^{p}(\mathbb{R}^{n})} \quad if \ 2 \leq p < 2 + \varepsilon,$$

whenever
$$\dot{\mathbf{f}} = \dot{\mathbf{T}}\mathbf{r}_{m-1} F$$
 and $\dot{\boldsymbol{\varphi}} = \dot{\mathbf{T}}\mathbf{r}_{m-1} \Phi$ for some $F, \Phi \in C_0^{\infty}(\mathbb{R}^{n+1})$.

Proof. We will use Lemma 3.20 to establish the bound (5.17). Let $u = \partial_{n+1} \mathcal{D}^{A} \dot{\boldsymbol{\varphi}}$ and $u_{Q} = \partial_{n+1} \mathcal{D}^{A} \dot{\boldsymbol{\varphi}}_{3Q}$, where $\dot{\boldsymbol{\varphi}}_{R}$ is as in Definition 5.9, and let $\psi = C|\dot{\boldsymbol{\varphi}}|$. By the bounds (5.14) and (1.20), the conditions of Lemma 3.20 are satisfied, and so the bound (5.17) is valid.

By formula (5.6), if
$$F$$
, $\Phi \in C_0^{\infty}(\mathbb{R}^n)$ and $\mathbf{\dot{T}r}_{m-1} F = \mathbf{\dot{T}r}_{m-1} \partial_{n+1} \Phi$, then

$$\mathcal{D}^{\mathbf{A}}(\dot{\mathbf{T}}\mathbf{r}_{m-1} F) = \mathcal{S}^{L}_{\nabla}(\mathbf{A} \dot{\mathbf{T}}\mathbf{r}_{m} \Phi) + \partial_{t} \mathcal{D}^{\mathbf{A}}(\dot{\mathbf{T}}\mathbf{r}_{m-1} \Phi).$$

As in the proof of [BHM17a, formula (6.3)], given $\mathbf{Tr}_{m-1} F$ we may find an appropriate Φ such that

$$\|\mathbf{A}\dot{\mathbf{T}}\mathbf{r}_{m}\,\Phi\|_{L^{p}(\mathbb{R}^{n})} + \|\dot{\mathbf{T}}\mathbf{r}_{m-1}\,\Phi\|_{\dot{W}A^{p}_{m-1,1}(\mathbb{R}^{n})} \leq \|\dot{\mathbf{T}}\mathbf{r}_{m-1}\,F\|_{\dot{W}A^{p}_{m-1,0}(\mathbb{R}^{n})}.$$

Thus, the bound (5.16) follows from Lemma 4.21 and the bound (5.14), and the bound (5.18) follows from Lemma 4.23 and the bound (5.17).
