# THE INFLUENCE OF THE COEFFICIENTS OF A SYSTEM OF WAVE EQUATIONS COUPLED BY VELOCITIES ON ITS STABILIZATION

Abstract. In this work, we consider a system of two wave equations coupled by velocities in one-dimensional space, with one boundary fractional damping. First, we show that the system is strongly asymptotically stable if and only if the coupling parameter b of the two equations is outside a discrete set of exceptional real values. Next, we show that our system is not uniformly stable. Hence, we look for a polynomial decay rate for smooth initial data. Using frequency domain approach combining with multiplier method, we prove that the energy decay rate is greatly influenced by the nature of the coupling parameter b, the arithmetic property of the ratio of the wave propagation speeds  $a$ , the order of the fractional damping  $\alpha$ . Indeed, under the equal speed propagation condition *i.e a* = 1, we establish an optimal polynomial energy decay rate of type  $t^{-\frac{2}{1-\alpha}}$  if the coupling parameter  $b \notin \pi \mathbb{Z}$  and of type  $t^{-\frac{2}{5-\alpha}}$  if the coupling parameter  $b \in \pi \mathbb{Z}$ . Furthermore, when the wave propagate with different speeds i.e  $a \neq 1$ , we prove that, for any rational number  $\sqrt{a}$  and almost all irrational propagate with different speeds i.e  $a \neq 1$ , we prove that, for any rational number  $\sqrt{a}$  and almos number  $\sqrt{a}$ , the energy of our system decays polynomially to zero like as  $t^{-\frac{2}{5-\alpha}}$ . 1.1. The problem. In this work, we investigate the energy decay rate of a coupled wave equations with only one fractional dissipation law. The system is described by

where  $\eta \geq 0$ ,  $\alpha \in ]0,1[$ ,  $a > 0$  and  $b \in \mathbb{R}^*$  are constants. Fractional calculus includes various extensions of the usual definition of derivative from integer to real order, including the Riemann-Liouville derivative, the Caputo derivative, the Riesz derivative, the Weyl derivative, etc. In this paper, we consider the Caputo's fractional derivative  $\partial_t^{\alpha,\eta}$  of order  $\alpha \in ]0,1[$  with respect to time variable t defined by

The fractional differentiation  $D^{\alpha,\eta}$  is inverse operation of fractional integration that is defined by

From equations  $(1.7)-(1.8)$  $(1.7)-(1.8)$ , we have

The fractional derivatives are nonlocal and involve singular and non-integrable kernels  $(t^{-\alpha}, 0 < \alpha < 1)$ . We refer the readers to [\[52\]](#page-28-0) and the rich references therein for mathematical description of the fractional derivative. The fractional order or, in general, of convolution type are not only important from the theoretical point of

view but also for applications. They naturally arise in physical, chemical, biological, ecological phenomena see for example [\[48\]](#page-28-1), and the rich references therein. They are used to describe memory and hereditary properties of various materials and processes. For example, in viscoelasticity, due to the nature of the material microstructure, both elastic solid and viscous fluid like response qualities are involved. Using Boltzmann assumption, we end up with a stress-strain relationship defined by a time convolution. Viscoelastic response occurs in a variety of materials, such as soils, concrete, rubber, cartilage, biological tissue, glasses, and polymers (see [\[17,](#page-27-0) [18,](#page-27-1) [19\]](#page-27-2) and [\[42\]](#page-28-2)). In our case, the fractional dissipation describes an active boundary viscoelastic damper designed for the purpose of reducing the vibrations (see [\[43,](#page-28-3) [44\]](#page-28-4)).

1.2. Motivation. Since the work of [\[35\]](#page-28-5), the study of the stabilization of damped wave equations retains the attention of many authors sees, for instance, [\[33,](#page-28-6) [20,](#page-27-3) [34,](#page-28-7) [58,](#page-28-8) [28,](#page-28-9) [29\]](#page-28-10). Let us recall the scalar fractional damped wave equation, that is

where  $\gamma > 0$ ,  $\eta \ge 0$  and  $\alpha \in ]0,1[$ . In [\[43\]](#page-28-3), it was proved that the energy of system [\(1.10\)](#page-1-0) does not decay uniformly (exponentially) to zero but polynomial energy decay rate of type  $t^{-1}$  is obtained. This result has been recently improved by Akil and Wehbe [\[2\]](#page-27-4), where an improved polynomial decay rate of the energy of the multi-dimensional case of system [\(1.10\)](#page-1-0) in a bounded domain  $\Omega \subset \mathbb{R}^d$  with smooth boundary  $\Gamma$  has been established. Roughly speaking, the authors proved that the energy of smooth solutions converges to zero as  $t$ goes to infinity, as  $t^{-\frac{1}{1-\alpha}}$ .

The question we are interested in this paper is what are the stability properties of our wave-wave coupled system  $(1.1)-(1.4)$  $(1.1)-(1.4)$  $(1.1)-(1.4)$ . Indeed, this system involves two wave equations coupled by velocities with only one fractional damping acting on a part of the boundary of the first equation. The second equation is indirectly damped through the coupling between the two equations (see the Literature below for the history of this kind of damping). So, from the mathematical point of view, it is important to study the stability of a system coupling a polynomially stable wave equation with a conservative one. Moreover, the study of this kind of systems is also motivated by several physical considerations. Indirect damping of reversible systems occurs in many applications in engineering and mechanics (see the literature below). It is well known that when the boundary damping is static; i.e., when

the energy of the solution decays exponentially under the conditions that  $b$  is outside a well determined discrete set of exceptional values,  $a = 1$  and  $b \neq k\pi$ , for some  $k \in \mathbb{Z}$  and polynomially under some arithmetic conditions on a and b (see [\[45\]](#page-28-11)). As mentioned above, the presence of the fractional time derivative at the boundary has a great impact on the stabilization of the system and its interesting from the theoretical point of view and also in several applications. The stability of a system of wave equations coupled by velocities with only one fractional damping remains an interesting open problem.

1.3. The main goal of this paper. In this paper, we provide a complete analysis for the stability of system  $(1.1)-(1.4)$  $(1.1)-(1.4)$  $(1.1)-(1.4)$ . Unlike the static damping case, the resolvent of the operator associated with system  $(1.1)-(1.4)$  is not compact. First, using general criteria of Arendt and Batty [\[16\]](#page-27-5), we show that our system is strongly stable if and only if the coupling parameter b is outside a well determined discrete set  $D_{a,b}$  of exceptional values. Next, using a spectral analysis, we prove that our system is not uniformly (exponentially) stable even when  $b \notin D_{a,b}$ . Consequently, we look for a polynomial energy decay rate for smooth initial data by applying a frequency domain approach combining with a multiplier technique. Indeed, we show that, for  $b \notin D_{a,b}$ , the energy decay rate of system  $(1.1)-(1.4)$  $(1.1)-(1.4)$  is greatly influenced by the order of the fractional derivative  $\alpha$ , the algebraic nature of the coupling parameter  $b$  (an additional condition on  $b$ ) and by the arithmetic property of the ratio of the wave propagation speeds a. Indeed, under the equal speed propagation condition *i.e a* = 1, we establish an optimal polynomial energy decay rate of type  $t^{-\frac{2}{1-\alpha}}$  if the coupling parameter  $b \notin \pi \mathbb{Z}$  and of type  $t^{-\frac{2}{5-\alpha}}$  if the coupling parameter  $b \in \pi \mathbb{Z}$ . Furthermore, when the wave propagate with different speeds type  $i^{q-1}$  if the coupling parameter  $i \in \mathbb{Z}$ . Furthermore, when the wave propagate with different speeds i.e  $a \neq 1$ , we prove that, for any rational number  $\sqrt{a}$  and almost all irrational number  $\sqrt{a}$ , the en system decays polynomially to zero like as  $t^{-\frac{2}{5-\alpha}}$ . This result still be holds if  $a \in \mathbb{Q}$ ,  $\sqrt{a} \notin \mathbb{Q}$  and b small enough.

1.4. Literature. The notion of indirect damping mechanisms has been introduced by Russell in [\[51\]](#page-28-12), and since this time, it retains the attention of many authors. In particular, the fact that only one equation of the coupled system is damped refers to the so-called class of "indirect" stabilization problems initiated and studied in [\[3,](#page-27-6) [4,](#page-27-7) [5\]](#page-27-8), and further studied by many authors, see for instance [\[57,](#page-28-13) [38,](#page-28-14) [10\]](#page-27-9) and the rich references therein. In [\[3,](#page-27-6) [5\]](#page-27-8), Alabau studied the boundary indirect stabilization of a system of two second order evolution equations coupled through the zero order terms. The lack of uniform stability was proved by a compact perturbation argument and a polynomial energy decay rate of type  $t^{-1/2}$  is obtained by a general integral inequality in the case where the waves propagate at the same speed and  $\Omega$  is a star-shaped domain in  $\mathbb{R}^N$ , or in the case where the ratio of the wave propagation speeds of the two equations is equal  $k^{-2}$  with k being an integer and  $\Omega$ , is a cubic domain of  $\mathbb{R}^3$ . Under appropriate geometric conditions, these results have been generalized by Alabau and Léautaud in  $[10]$ , to the cases for which the coupling parameter is a non negative function can vanish in some part of  $\Omega$ . The polynomial decay rate and the control of a 1 – d hyperbolic-parabolic coupled system has been studied by Zhang and Zuazua in [\[57\]](#page-28-13). In [\[38\]](#page-28-14), Liu and Rao considered a system of two coupled wave equations with one boundary damping and they proved that the energy of the system decays at the rate  $t^{-1}$  for smooth initial data on a N-dimensional domain  $\Omega$  with usual geometrical condition when the waves propagate at the same speed. On the contrary, under some arithmetic condition on the ratio of the wave propagation speeds of the two equations, they established a polynomial energy decay rate for smooth initial data on a one-dimensional domain. In [\[13\]](#page-27-10), Ammar-Khodja and Bader studied the simultaneous boundary stabilization of a system of two wave equations coupling through the velocity terms. In addition to the previously cited papers, we rapidly recall some previous studies done on the coupled systems with different kinds of damping. Ammari and Mehrenberger in [\[15\]](#page-27-11), gave a characterization of the stability of a system of two evolution equations coupling through the velocity terms subject to one bounded viscous feedback damping. Note nevertheless that the above system does not enter in the framework of this paper. In [\[9\]](#page-27-12), Alabau, Cannarsa, and Guglielmi studied the indirect stabilization of weakly coupled systems with hybrid boundary conditions, they proved polynomial decay for the energy of solutions. Alabau, Wang, and Yu in [\[12\]](#page-27-13) studied the stability of the hyperbolic system of a wave-wave type which is coupled through the velocities with only one equation is directly damped by a nonlinear damping. They established an explicit energy decay formula in terms of the behavior of the nonlinear feedback close to the origin. Last but not least, we refer to [\[3,](#page-27-6) [4,](#page-27-7) [7,](#page-27-14) [6,](#page-27-15) [21,](#page-27-16) [22,](#page-27-17) [31,](#page-28-15) [56,](#page-28-16) [36,](#page-28-17) [54,](#page-28-18) [55,](#page-28-19) [46,](#page-28-20) [30,](#page-28-21) [1,](#page-27-18) [50,](#page-28-22) [32,](#page-28-23) [41,](#page-28-24) [14\]](#page-27-19) for the indirect stabilization and the indirect exact controllability of distributed systems with different kinds of damping.

The indirect control and stabilization of reversible systems occur in many applications in engineering and mechanics we quote [\[54,](#page-28-18) [55,](#page-28-19) [21,](#page-27-16) [22,](#page-27-17) [8\]](#page-27-20) for the Timoshenko system in bounded or unbounded domains, [\[39,](#page-28-25) [56,](#page-28-16) [47,](#page-28-26) [11,](#page-27-21) [46\]](#page-28-20) for the Bresse system.

1.5. Description of the paper. This paper is organized as follows: In Section [2,](#page-2-0) first, we show that the system  $(1.1)-(1.6)$  $(1.1)-(1.6)$  can be replaced by an augmented model by coupling the wave equation with a suitable diffusion equation for can reformulate into an evolution equation and we deduce the well-posedness property of the problem by the semigroup approach. Second, using a criteria of Arendt-Batty we show that the augmented model is strongly stable in absence of compactness of the resolvent under a condition on b. In Section [3,](#page-9-0) we show that the augmented model is non uniformly stable; i.e., (non exponential), this result is due to the fact that a subsequence of eigenvalues is due to the imaginary axis. In Section [4,](#page-17-0) we show the polynomial energy decay rate for the system  $(1.1)-(1.6)$  $(1.1)-(1.6)$ . Roughly speaking, we show that the energy of smooth solutions converges to zero as t goes to infinity, as  $t^{-s(\alpha)}$ , where

# 2. Well-Posedness and Strong Stability

<span id="page-2-0"></span>In this Section, we will study the strong stability of system  $(1.1)-(1.6)$  $(1.1)-(1.6)$  in the absence of the compactness of the resolvent. First, we will study the existence, uniqueness, and regularity of the solution of our system.

2.1. **Augmented model and Well-Posedness.** Firstly, we reformulate system  $(1.1)-(1.6)$  $(1.1)-(1.6)$  into an augmented system. For this aim, we recall Theorem 2 in [\[43\]](#page-28-3).

u(0) = 0, \quad u_x(1) + M_2(\eta, \alpha)u(1) = M_2(\eta, \alpha)f_1(1) - M_1(\eta, \alpha) \quad \text{and} \quad y(0) = y(1) = 0,
$$

where

<span id="page-4-2"></span><span id="page-4-1"></span>
$$
M_1(\eta,\alpha) = \gamma \kappa(\alpha) \int_{\mathbb{R}} \frac{\mu(\xi) f_5(\xi)}{1 + \eta + \xi^2} d\xi \quad \text{and} \quad M_2(\eta,\alpha) = \gamma \kappa(\alpha) \int_{\mathbb{R}} \frac{\mu^2(\xi)}{1 + \eta + \xi^2} d\xi.
$$

Using the fact  $f_5 \in L^2(\mathbb{R})$ , the definition of  $\mu(\xi)$  and the fact that  $\alpha \in ]0,1[$ ,  $\eta \ge 0$ , it is easy to check that  $M_1(\eta,\alpha)$  and  $M_2(\eta,\alpha)$  are well defined. So, using Lax-Milligram Theorem and the fact that the second members of  $(2.17)$  and  $(2.18)$  are in  $L^2(0,1)$ , we deduce that there exists  $(u, y) \in H^2(0,1) \cap H^1_L(0,1) \times H^2(0,1) \cap H^1_0(0,1)$ unique strong solution of  $(2.17)-(2.19)$  $(2.17)-(2.19)$ . Consequently, defining  $v = u - f_1$ ,  $z = y - f_3$  and  $\omega$  by  $(2.16)$ , we deduce that  $U = (u, v, y, z, \omega) \in D(\mathcal{A})$  is the unique solution of  $(2.10)$ . The proof is thus complete.

From Proposition [2.2,](#page-4-5) the operator A is m-dissipative on H and consequently, generates a  $C_0$ -semigroup of contractions  $e^{tA}$  following Lummer-Phillips Theorem (see in [\[40\]](#page-28-27) and [\[49\]](#page-28-28)). Then the solution of the evolution equation [\(2.9\)](#page-4-6) admits the following representation

$$
U(t) = e^{t\mathcal{A}}U_0, \quad t \ge 0,
$$

which leads to the well-posedness of  $(2.9)$ . Hence, we have the following result.

**Theorem 2.3.** Let  $U_0 \in \mathcal{H}$  then, problem [\(2.9\)](#page-4-6) admits a unique weak solution U satisfies

Moreover, if  $U_0 \in D(\mathcal{A})$  then, problem [\(2.9\)](#page-4-6) admits a unique strong solution U satisfies

 $U(t) \in C^1 (\mathbb{R}^+, \mathcal{H}) \cap C^0 (\mathbb{R}^+, D(\mathcal{A})).$ 

.

2.2. Strong Stability. In this part, we study the strong stability of system [\(2.1\)](#page-3-1)-[\(2.8\)](#page-3-2) in the sense that its energy converges to zero when t goes infinity for all initial data in  $H$ . Since the resolvent of  $A$  is not compact, then the classical methods such as Lasalle's invariance principle [\[53\]](#page-28-29) or the spectrum decomposition theory of Benchimol [\[25\]](#page-27-22) are not applicable in this case. Then, we will use a general criteria of Arendt-Batty [\[16\]](#page-27-5), following which a  $C_0$ -semigroup of contractions  $e^{tA}$  in a Banach space is strongly stable, if A has no pure imaginary eigenvalues and  $\sigma(A) \cap i\mathbb{R}$  contains only a countable number of elements. So, we will prove the following stability result.

<span id="page-5-0"></span>**Theorem 2.4.** Assume that  $\eta \geq 0$ , then, the C<sub>0</sub>−semigroup of contractions  $e^{t\mathcal{A}}$  is strongly stable on H in the sense that  $\lim_{t\to+\infty} \|e^{t\mathcal{A}}U_0\|_{\mathcal{H}} = 0$  for all  $U_0 \in \mathcal{H}$  if and only if

$$
(SC) \t b2 \neq \frac{(k_1^2 - ak_2^2)(ak_1^2 - k_2^2)}{(a+1)(k_1^2 + k_2^2)}\pi^2, \quad \forall k_1, k_2 \in \mathbb{Z}.
$$

For the proof of Theorem [2.4,](#page-5-0) we need the following Lemmas.

<span id="page-5-7"></span>**Lemma 2.5.** Assume that  $\eta \geq 0$  and b satisfying condition (SC). Then, for all  $\lambda \in \mathbb{R}$ , we have

Like as  $[45]$ , we distinguish two cases:

**Case 1.** If  $\lambda = 0$ , by direct calculation, we deduce that  $u = 0$ ,  $y = 0$ , and consequently  $U = 0$ .

**Case 2.** If  $\lambda \neq 0$ , combining equations [\(2.27\)](#page-5-4)-[\(2.29\)](#page-5-4), we get the following systems

If  $\lambda = \pm b$ , then system [\(2.30\)](#page-5-5)-[\(2.33\)](#page-5-5) admits only the trivial solution, in this case the proof is complete. Otherwise, if  $\lambda \neq \pm b$ , since  $r_1^2 - r_3^2 \neq 0$ , then using boundary conditions [\(2.31\)](#page-5-5), we get

admits a unique strong solution  $(u, y) \in (H^2(0, 1) \cap H^1_L(0, 1)) \times (H^2(0, 1) \cap H^1_0(0, 1)),$  where

c_1(\lambda, \eta, \alpha) = \gamma \kappa(\alpha) \int_{\mathbb{R}} \frac{\mu^2(\xi)}{\lambda^2 + (\xi^2 + \eta)^2} d\xi \quad and \quad c_2(\lambda, \eta, \alpha) = \gamma \kappa(\alpha) \int_{\mathbb{R}} \frac{\mu^2(\xi)(\xi^2 + \eta)}{\lambda^2 + (\xi^2 + \eta)^2} d\xi.
$$

**Remark 2.8.** Using the definition of  $\mu$  and the fact that  $\alpha \in ]0,1[$ ,  $\eta \geq 0$ , we deduce that the coefficients  $c_1(\lambda, \eta, \alpha)$  and  $c_2(\lambda, \eta, \alpha)$  are well defined.

*Proof.* In the case  $\eta > 0$  and  $\lambda = 0$ , by applying Lax-Milligram Theorem, it is easy to see that problem [\(2.43\)](#page-7-0) admits a unique strong solution  $(u, y) \in (H^2(0, 1) \cap H^1_L(0, 1)) \times (H^2(0, 1) \cap H^1_0(0, 1))$ . So, we study the existence of strong solution of [\(2.43\)](#page-7-0) in the case  $\eta \geq 0$  and  $\lambda \in \mathbb{R}^*$ . To this aim, we define the following linear unbounded operator  $\mathcal L$  by

It follows, from the above inequality and the compactness of the embeddings  $H_L^1(0,1) \times H_0^1(0,1)$  into  $L^2(0,1) \times$  $L^2(0,1)$ , that the inverse operator  $\mathcal{L}^{-1}$  is compact in  $L^2(0,1) \times L^2(0,1)$ . On the other hand, since  $b$  satisfies condition (SC), by same computation used in Lemma [2.5,](#page-5-7) we show that ker  $(\lambda^2 \mathcal{L}^{-1} - I) = \{0\}$ . Then, following Fredholm's alternative, system  $(2.43)$  admits a unique solution. The proof is thus complete.  $\Box$

Assume that  $\eta > 0$  and let  $\lambda \in \mathbb{R}$ . Set  $F = (f_1, f_2, f_3, f_4, f_5) \in \mathcal{H}$ , we look for  $U = (u, v, y, z, \omega) \in D(\mathcal{A})$  solution of

where  $c_1(\lambda, \eta, \alpha)$  and  $c_2(\lambda, \eta, \alpha)$  are defined in  $(2.44)$  and  $I_1(\lambda, \eta, \alpha)$ ,  $I_2(\lambda, \eta, \alpha)$  are given by

$$
I_1(\lambda, \eta, \alpha) = i\lambda \gamma \kappa(\alpha) \int_{\mathbb{R}} \frac{f_5(\xi)\mu(\xi)}{\lambda^2 + (\xi^2 + \eta)^2} d\xi \quad \text{and} \quad I_2(\lambda, \eta, \alpha) = -\gamma \kappa(\alpha) \int_{\mathbb{R}} \frac{f_5(\xi)\mu(\xi)(\xi^2 + \eta)}{\lambda^2 + (\xi^2 + \eta)^2} d\xi.
$$

Using the definition of  $\mu$  and the fact that  $f_5 \in L^2(\mathbb{R})$ ,  $\eta \geq 0$  and  $\alpha \in ]0,1[$ , we deduce that the integrals  $I_1(\lambda, \eta, \alpha)$  and  $I_2(\lambda, \eta, \alpha)$  are well defined. Now, let  $(\varphi, \psi) \in (H^2(0, 1) \cap H^1_L(0, 1)) \times (H^2(0, 1) \cap H^1_0(0, 1))$  be the strong solution of

Setting  $\tilde{u} = u + \varphi$  and  $\tilde{y} = y + \psi$ . Then, from [\(2.47\)](#page-8-0) and [\(2.48\)](#page-8-1), we get

\tilde{u}_x(1) + (\lambda^2 c_1(\lambda, \eta, \alpha) + i\lambda c_2(\lambda, \eta, \alpha))\tilde{u}(1) & = \mathcal{Y}\n\end{cases}

where

$$
\mathcal{Y} = -i\lambda c_1(\lambda, \eta, \alpha) f_1(1) + c_2(\lambda, \eta, \alpha) f_1(1) + (\lambda^2 c_1(\lambda, \eta, \alpha) + i\lambda c_2(\lambda, \eta, \alpha)) \varphi(1).

Next, let  $\theta \in H^2(0, 1) \cap H^1_L(0, 1)$ , such that

Using Lemma [2.7,](#page-7-3) problem  $(2.50)$  has a unique solution  $(\chi, \tilde{y}) \in (H^2(0, 1) \cap H^1_L(0, 1)) \times (H^2(0, 1) \cap H^1_0(0, 1))$ and therefore problem  $(2.47)$  has a unique solution  $(u, y) \in (H^2(0, 1) \cap H^1_L(0, 1)) \times (H^2(0, 1) \cap H^1_0(0, 1))$ . So, defining  $v = i\lambda u - f_1$ ,  $z = i\lambda y - f_3$  and

\omega(\xi) = \frac{f_5(\xi)}{i\lambda + \xi^2 + \eta} + \frac{i\lambda u(1)\mu(\xi)}{i\lambda + \xi^2 + \eta} - \frac{f_1(1)\mu(\xi)}{i\lambda + \xi^2 + \eta},
$$

we obtain  $U = (u, v, y, z, \omega) \in D(\mathcal{A})$  solution of [\(2.46\)](#page-7-4). The proof is thus complete.

**Proof of Theorem [2.4.](#page-5-0)** Following a general criteria of Arendt-Batty see [\[16\]](#page-27-5), the  $C_0$ -semigroup of contractions  $e^{tA}$  is strongly stable, if  $\sigma(A) \cap i\mathbb{R}$  is countable and no eigenvalue of A lies on the imaginary axis. First, using Lemma [2.5,](#page-5-7) we directly deduce that  $A$  has no pure imaginary eigenvalues. Next, using Lemmas [2.6,](#page-6-8) [2.9](#page-7-5) and with the help of the closed graph Theorem of Banach, we deduce that  $\sigma(\mathcal{A}) \cap i\mathbb{R} = \{\emptyset\}$  if  $n > 0$ and  $\sigma(\mathcal{A}) \cap i\mathbb{R} = \{0\}$  if  $\eta = 0$ . Consequently, the  $C_0$ -semigroup  $e^{t\mathcal{A}}$  is strongly stable and the proof is thus complete.

#### <span id="page-9-2"></span>3. Non Uniform Stability

<span id="page-9-0"></span>In this section we show that uniform stability (i.e. exponential stability) does not hold even in the case  $a = 1$ and  $b \notin \pi \mathbb{Z}$ . This result is due to the fact that a sub-sequence of eigenvalues of A is close to the imaginary axis.

<span id="page-9-10"></span>3.1. Non Uniform Stability in the case  $a = 1$ . In this part, we assume that  $a = 1$ ,  $\eta > 0$  and

(SC1) 
$$
b \neq \frac{\pi}{\sqrt{2}} \frac{k_1^2 - k_2^2}{\sqrt{k_1^2 + k_2^2}}.
$$

Our goal is to show that system  $(2.1)-(2.8)$  $(2.1)-(2.8)$  is not exponentially stable. This result is due to the fact that a subsequence of the eigenvalues of  $A$  is close to the imaginary axis.

<span id="page-9-1"></span>**Theorem 3.1.** Assume that  $a = 1$  and that condition (SC1) holds. Then the semigroup of contractions  $e^{t\mathcal{A}}$  is not uniformly stable in the energy space  $\mathcal{H}$ .

For the proof of Theorem [3.1,](#page-9-1) we aim to show that an infinite number of eigenvalues of  $A$  approach the imaginary axis. Since A is dissipative, we fix  $\alpha_0 > 0$  large enough and we study the asymptotic behavior of the large eigenvalues  $\lambda$  of  $\mathcal A$  in the strip

$$
S = \{ \lambda \in \mathbb{C} : -\alpha_0 \leq \Re(\lambda) \leq 0 \} .
$$

For the aim, let  $\lambda \in \mathbb{C}^*$  be an eigenvalue of A and let  $U = (u, \lambda u, y, \lambda y, \omega) \in D(\mathcal{A})$  be an associated eigenvector such  $||U||_{\mathcal{H}} = 1$ . Then, we have

\lambda^2 u - u_{xx} + b\lambda y = 0,
$$

\lambda^2 y - y_{xx} - b\lambda u = 0,
$$

\omega(\xi) = \frac{|\xi|^{\alpha - \frac{1}{2}}}{\lambda + \xi^2 + \eta} \lambda u(1),
$$

with the boundary conditions

y(0) = y(1) = u(0) = 0,

u_x(1) = -\gamma \kappa(\alpha) \int_{\mathbb{R}} |\xi|^{\alpha - \frac{1}{2}} \omega(\xi) d\xi.
$$

First, from  $(3.2)$ , we have

The general solution of equation  $(3.12)$  is given by

From the boundary conditions in [\(3.12\)](#page-10-0) at  $x = 0$  and using the fact that  $r_1^2 \neq r_2^2$ , we get  $c_3 = c_4 = 0$ , therefore

\frac{2}{n^3} \left( \zeta_{1,n} - \frac{\gamma b^6 \left( i \cos \left( \frac{\pi \alpha}{2} \right) - \sin \left( \frac{\pi \alpha}{2} \right) \right)}{128 \pi^{5-\alpha} n^{2-\alpha}} + O\left( \frac{1}{n^2} \right) \right) = 0,
$$

,

hence, we obtain

(3.42) 
$$
\zeta_{1,n} = \frac{\gamma b^6 \left( i \cos \left( \frac{\pi \alpha}{2} \right) - \sin \left( \frac{\pi \alpha}{2} \right) \right)}{128 \pi^{5-\alpha} n^{2-\alpha}} + O\left( \frac{1}{n^2} \right).
$$

Inserting  $(3.42)$  in  $(3.40)$ , we get estimation  $(3.17)$ .

**Step 4. Asymptotic behavior of**  $\epsilon_{2,n}$ . First, using  $(3.28)$  we obtain

\sinh(2\lambda_{2,n}) = -\sinh(2\epsilon_{2,n}) = -2\epsilon_{2,n} + O\left(\epsilon_{2,n}^3\right)

(3.44)

\cosh(2\lambda_{2,n}) = -\cosh(2\epsilon_{2,n}) = -1 + O(\epsilon_{2,n}^2),

\frac{1}{\lambda_{2,n}} = -\frac{i}{n\pi} + O\left(\frac{1}{n^2}\right)
$$

and

\frac{1}{\lambda_{2,n}^{1-\alpha}} = \frac{1}{(in\pi)^{1-\alpha}} + O\left(\frac{1}{n^{2-\alpha}}\right).

Next, by inserting [\(3.43\)](#page-13-2)-[\(3.46\)](#page-13-3) in the identity  $f(\lambda_{1,n}) = 0$ , we find after simplification

$$

and thus

$$
(3.48) \qquad \epsilon_{2,n} = \frac{\gamma \left(1 + \cos(b)\right) \left(-\sin\left(\frac{\pi\alpha}{2}\right) + i\cos\left(\frac{\pi\alpha}{2}\right)\right)}{2(n\pi)^{1-\alpha}} + i\frac{b \left(b - 2\sin(b)\right)}{8n\pi} + O\left(\frac{1}{n^{2-\alpha}}\right) + O\left(\frac{\epsilon_{1,n}^2}{n^{1-\alpha}}\right).

We distinguish two cases:

**Case 1.** There exists no integer  $k \in \mathbb{Z}$  such that  $b = \pi + 2k\pi$ . Then, we have

**Case 2.** If there exists  $k \in \mathbb{Z}$  such that  $b = \pi + 2k\pi$ , then

Since in this case the first real part of  $\lambda_{2,n}$  still does not exists, we need to increase the order of the finite expansion. Inserting [\(3.51\)](#page-14-1) in [\(3.13\)](#page-10-1) and using the asymptotic expansion, we get

\sinh(r_1 - r_2) = -\frac{ib^3}{8\pi^2 n^2} + O\left(\frac{1}{n^3}\right), \\
\cosh(r_1 + r_2) - \cosh(r_1 - r_2) = -\frac{2\tilde{\varepsilon}_{2,n}^2}{n^2} + O\left(\frac{1}{n^3}\right).\n\end{cases}
$$

Inserting  $(3.51)$  and  $(3.52)$  in  $(3.21)$ , then using the asymptotic expansion, we get

again the first real part of  $\lambda_{2,n}$  still does not exists, so we need to increase the order of the finite expansion. For this aim, inserting [\(3.54\)](#page-14-4) in [\(3.13\)](#page-10-1) and using the asymptotic expansion, we get

\begin{cases}\n r_1 + r_2 = 2in\pi + i\pi + \frac{2\zeta_{2,n}}{n} - \frac{ib^2(4\pi^2 + 3b^2)}{64\pi n^3} + \frac{b^2(4i\pi^2 + 9ib^2 + 32\pi\zeta_{2,n})}{128\pi^3 n^4} + O\left(\frac{1}{n^5}\right), \\
 r_1 - r_2 = ib + \frac{ib^3}{8\pi^2 n^2} - \frac{ib^3}{8\pi^2 n^3} + \frac{3ib^3(4\pi^2 + b^2)}{128\pi^4 n^4} + O\left(\frac{1}{n^5}\right).\n\end{cases}
$$

Therefore, we have

\begin{cases}\n\sinh(r_1 + r_2) = -\frac{2\zeta_{2,n}}{n} + \frac{ib^2(4\pi^2 + 3b^2)}{64\pi n^3} - \frac{b^2(4i\pi^2 + 9ib^2 + 32\pi\zeta_{2,n})}{128\pi^3 n^4} + O\left(\frac{1}{n^5}\right), \\
\sinh(r_1 - r_2) = -\frac{ib^3}{8\pi^2 n^2} + \frac{ib^3}{8\pi^2 n^3} - \frac{3ib^3(4\pi^2 + b^2)}{128\pi^4 n^4} + O\left(\frac{1}{n^5}\right), \\
\cosh(r_1 + r_2) - \cosh(r_1 - r_2) = -\frac{2\zeta_{2,n}^2 + \frac{b^6}{128\pi^4}}{n^4} + O\left(\frac{1}{n^5}\right).\n\end{cases}
$$

Inserting  $(3.54)$  and  $(3.55)$  in  $(3.21)$ , then using the asymptotic expansion, we get

-\frac{2}{n^2}\left(\zeta_{2,n}-\frac{ib^2\left(4\pi^2+7b^2\right)}{128\pi^3n}+\frac{ib^2\left(4\pi^2+21b^2\right)}{256\pi^3n^2}-\frac{\gamma b^6\left(i\cos\left(\frac{\pi\alpha}{2}\right)-\sin\left(\frac{\pi\alpha}{2}\right)\right)}{256\pi^4\pi^{1-\alpha}n^{3-\alpha}}+O\left(\frac{1}{n^3}\right)+O\left(\frac{\zeta_{2,n}^2}{n^{3-\alpha}}\right)\right)=0,
$$

hence, we get

Finally, inserting  $(3.56)$  in  $(3.54)$ , we get  $(3.20)$ . The proof is thus complete.

**Proof of Theorem [3.1.](#page-9-1)** From Proposition [3.2,](#page-10-8) the operator  $A$  has two branches of eigenvalues, the energy corresponding to the first and second branch of eigenvalues has no exponential decaying. Therefore the total energy of system  $(2.1)-(2.8)$  $(2.1)-(2.8)$  has no exponential decaying when  $a = 1$ . Thus, the proof is complete.

3.2. Non Uniform Stability for  $a \neq 1$ . In this part, we assume that  $a \neq 1$ ,  $\eta > 0$  and b verified condition (SC). Our goal is to show that  $(2.1)-(2.8)$  $(2.1)-(2.8)$  is not exponentially stable. This result is due to the fact that a subsequence of eigenvalues of  $A$  is close to the imaginary axis.

<span id="page-15-1"></span>**Theorem 3.3.** Assume that  $a \neq 1$  and that condition (SC) holds. Then, the semigroup of contractions  $e^{t\mathcal{A}}$  is not uniformly (exponentially) stable in the energy space  $\mathcal{H}$ .

For the proof of Theorem [3.3,](#page-15-1) we aim to show that an infinite number of eigenvalues of  $A$  approach the imaginary axis. We determine the characteristic equation satisfied by the eigenvalues of A. For the aim, let  $\lambda \in \mathbb{C}^*$  be an eigenvalue of A and let  $U = (u, \lambda u, y, \lambda y, \omega) \in D(\mathcal{A})$  be an associated eigenvector such that  $||U||_{\mathcal{H}} = 1$ . Then, we have

$$
\lambda^2 u - u_{xx} + b\lambda y = 0,
$$
  
\n
$$
\lambda^2 y - a y_{xx} - b\lambda u = 0,
$$
  
\n
$$
\omega(\xi) = \frac{\mu(\xi)}{\lambda + \xi^2 + \eta} \lambda u(1)
$$

with the following boundary conditions

$$
y(0) = y(1) = u(0) = 0,
$$
  

$$
u_x(1) = -\gamma \kappa(\alpha) \int_{\mathbb{R}} |\xi|^{\alpha - \frac{1}{2}} \omega(\xi) d\xi.
$$

Equivalently, we get the following system

(3.57) 
$$
\begin{cases} ay_{xxxx} - (a+1)\lambda^2 y_{xx} + \lambda^2(\lambda^2 + b^2)y = 0, \\ y(0) = y(1) = y_{xx}(0) = 0, \\ ay_{xxx}(1) + a\gamma\lambda(\lambda + \eta)^{\alpha - 1}y_{xx}(1) - \lambda^2 y_x(1) = 0. \end{cases}
$$

The general solution of equation  $(3.57)$  is given by

y(x) = c_1 \sinh(r_1 x) + c_2 \sinh(r_2 x) + c_3 \cosh(r_1 x) + c_4 \cosh(r_2 x),
$$

where  $c_1$ ,  $c_2$ ,  $c_3$ ,  $c_4 \in \mathbb{C}$ , and

r_1 = \lambda \sqrt{\frac{(a+1)+(a-1)\sqrt{1-\frac{4ab^2}{(a-1)^2\lambda^2}}}{2a}}
$$
 and  $r_2 = \lambda \sqrt{\frac{(a+1)-(a-1)\sqrt{1-\frac{4ab^2}{(a-1)^2\lambda^2}}}{2a}}$ .

Using the boundary conditions in [\(3.57\)](#page-15-2) at  $x = 0$  and the fact that  $r_1^2 \neq r_2^2$ , we get  $c_3 = c_4 = 0$ . Therefore  $y(x) = c_1 \sinh(r_1x) + c_2 \sinh(r_2x)$ .

Moreover, the boundary conditions in  $(3.57)$  at  $x = 1$  can be expressed by

$$
\mathcal{M}\begin{pmatrix}c_1\\c_2\end{pmatrix}=0,
$$

where

$$
\mathcal{M} = \begin{pmatrix} \sinh(r_1) & \sinh(r_2) \\ \left( ar_1^2 - \lambda^2 \right) r_1 \cosh(r_1) + a\gamma \lambda (\lambda + \eta)^{\alpha - 1} r_1^2 \sinh(r_1) & \left( ar_2^2 - \lambda^2 \right) r_2 \cosh(r_2) + a\gamma \lambda (\lambda + \eta)^{\alpha - 1} r_2^2 \sinh(r_2) \end{pmatrix}.
$$

Then the determinant of  $M$  is given by

$$
det(\mathcal{M}) = -a\gamma\lambda(\lambda+\eta)^{\alpha-1}(r_1^2-r_2^2)\sinh(r_1)\sinh(r_2)-r_1(ar_1^2-\lambda^2)\cosh(r_1)\sinh(r_2)+r_2(ar_2^2-\lambda^2)\sinh(r_1)\cosh(r_2).
$$

Hence a non trivial solution y of [\(3.57\)](#page-15-2) exists if and only if  $det(\mathcal{M}) = 0$ . Set  $F(\lambda) = \frac{det(\mathcal{M})}{(a-1)\lambda^3}$ , thus the characteristic equation is equivalent to  $F(\lambda) = 0$ .

In the sequel, since A is dissipative, we study the asymptotic behavior of the large eigenvalues  $\lambda$  of A in the strip  $-\alpha_0 \leq \Re(\lambda) \leq 0$ , for some  $\alpha_0 > 0$  large enough.

<span id="page-16-4"></span>**Proposition 3.4.** Assume that  $a \neq 1$  and that condition (SC) holds. Then there exists  $n_0 \in \mathbb{N}$  sufficiently large and two sequences  $(\lambda_{1,n})_{|n|\geq n_0}$  and  $(\lambda_{2,n})_{|n|\geq n_0}$  of simple roots of f (that are also simple eigenvalues of A) satisfying the following asymptotic behavior

(3.59) 
$$
\lambda_{1,n} = in\pi\sqrt{a} + o(1) \quad and \quad \lambda_{2,n} = i\left(n + \frac{1}{2}\right)\pi + o(1).
$$

Proof. The proof is divided into two steps.

Step 1. In this step, we proof the following asymptotic behavior estimate

(3.60)

F(\lambda) = F_0(\lambda) + \frac{F_1(\lambda)}{\lambda^{1-\alpha}} + O\left(\frac{1}{\lambda}\right),
$$

where

From equation [\(3.58\)](#page-15-3) it follows that for  $\lambda$  large enough, we have

(3.61) 
$$
r_1 = \lambda + O\left(\frac{1}{\lambda}\right)
$$
 and  $r_2 = \frac{\lambda}{\sqrt{a}} + O\left(\frac{1}{\lambda}\right)$ .

From  $(3.61)$  and using the fact that real part of  $\lambda$  is bounded, we get

$$
\begin{cases}\n\sinh(r_1)\cosh(r_2) = \sinh(\lambda)\cosh\left(\frac{\lambda}{\sqrt{a}}\right) + O\left(\frac{1}{\lambda}\right), \\
\cosh(r_1)\sinh(r_2) = \cosh(\lambda)\sinh\left(\frac{\lambda}{\sqrt{a}}\right) + O\left(\frac{1}{\lambda}\right), \\
\sinh(r_1)\sinh(r_2) = \sinh(\lambda)\sinh\left(\frac{\lambda}{\sqrt{a}}\right) + O\left(\frac{1}{\lambda}\right).\n\end{cases}
$$

Inserting  $(3.61)$  and  $(3.62)$  in det $(\mathcal{M})$ , then using the asymptotic expansion, we get

**Step 2.** We look at the roots of  $F(\lambda)$ . First, the roots of  $F_0$  are given by

 and/or  $i\left(n+\frac{1}{2}\right)\pi$   $n \in \mathbb{Z}$ .

Now, with help of Rouché's Theorem, and using the asymptotic equation [\(3.60\)](#page-16-2), it easy to see that the large roots of  $F(\lambda)$  (denoted by  $\lambda_{1,n}$  and  $\lambda_{2,n}$ ) are simple and close to those of  $F_0(\lambda)$ ; i.e., there exists  $n_0 \in \mathbb{N}$ , such that for all  $|n| > n_0$ , we have

$$
\lambda_{1,n} = in\pi\sqrt{a} + o(1)
$$

and/or

$$
\lambda_{2,n}=i\left(n+\frac{1}{2}\right)\pi+o(1),
$$

hence we get  $(3.59)$ . The proof is thus complete.

**Proof of Theorem [3.3.](#page-15-1)** From Proposition [3.4,](#page-16-4) the operator  $A$  has two branches of eigenvalues, the energy corresponding to the first and second branch of eigenvalues has no exponential decaying. Therefore the total energy of system  $(2.1)-(2.8)$  $(2.1)-(2.8)$  has no exponential decaying when  $a \neq 1$ . Thus, the proof is complete.

# <span id="page-17-3"></span>4. Polynomial Stability

<span id="page-17-0"></span>4.1. Polynomial Stability in the case  $\eta > 0$  and  $a = 1$ . From the subsection [3.1,](#page-9-10) if  $\eta > 0$ ,  $a = 1$  and b satisfies condition (SC1), then system  $(2.1)-(2.8)$  $(2.1)-(2.8)$  is not uniformly (exponentially) stable, so it is natural to hope for a polynomial stability. For that purpose, we will use a frequency domain approach, namely we will use Theorem 2.4 of  $[26]$  (see also  $[23, 24, 37]$  $[23, 24, 37]$  $[23, 24, 37]$  $[23, 24, 37]$ ) that we partially recall.

<span id="page-17-8"></span>**Lemma 4.1.** Let  $(T(t))_{t\geq0}$  be a bounded  $C_0$ -semigroup on a Hilbert space H with generator A such that  $i\mathbb{R} \subset \rho(A)$ . Then for a fixed  $\ell > 0$  the following conditions are equivalent

(4.1) 
$$
\|(is - A)^{-1}\| = O(|s|^{\ell}), \ s \to \infty,
$$

(4.2) 
$$
||T(t)A^{-1}|| = O(t^{-1/\ell}), t \to \infty.
$$

The aim of this section is to prove the following result:

<span id="page-17-2"></span>**Theorem 4.2.** Assume that  $\eta > 0$ ,  $a = 1$  and that condition (SC1) holds. Then, for all initial data  $U_0 =$  $(u_0, u_1, y_0, y_1, \omega_0) \in D(\mathcal{A})$ , there exists a constant  $c > 0$  independent of  $U_0$ , such that the energy of system  $(2.1)-(2.8)$  $(2.1)-(2.8)$  $(2.1)-(2.8)$  satisfies the following estimation:

(4.3) 
$$
E(t) \leq c \frac{1}{t^{p(\alpha)}} \|U_0\|_{D(\mathcal{A})}^2, \quad \forall t > 0,
$$

where

<span id="page-17-1"></span>
$$
p(\alpha) = \begin{cases} \frac{2}{1-\alpha} & \text{if} \quad b \in \pi \mathbb{Z}, \\ \frac{2}{5-\alpha} & \text{if} \quad b \notin \pi \mathbb{Z}. \end{cases}
$$

In addition, the energy decay rate  $(4.3)$  is optimal in the sense that for any  $\varepsilon > 0$ , we can not expect the decay rate  $\frac{1}{t^{p(\alpha)+\varepsilon}}$  for all initial data  $U_0 \in D(\mathcal{A})$ .

Since condition  $i\mathbb{R} \subset \rho(A)$  was already checked in Theorem [2.4](#page-5-0) in the case  $\eta > 0$ , then the proof of Theorem [4.2](#page-17-2) is reduced to show that condition [\(4.1\)](#page-17-3) holds with

\ell = \begin{cases} 1 - \alpha & \text{if } b \notin \pi \mathbb{Z}, \\ 5 - \alpha & \text{if } b \in \pi \mathbb{Z}. \end{cases}

This is checked by using a contradiction argument. Indeed assume that it does not hold, then there exist a sequence  $\lambda_n \in \mathbb{R}, n \in \mathbb{N}$  such that  $\lambda_n \to +\infty$  as  $n \to +\infty$ , and a sequence  $U_n = (u^n, v^n, y^n, z^n, \omega^n) \in D(\mathcal{A})$ such that

(4.4) 
$$
||U^n||_{\mathcal{H}} = ||(u^n, v^n, y^n, z^n, \omega^n)||_{\mathcal{H}} = 1,
$$

(4.5) 
$$
\lambda_n^{\ell} (i\lambda_n I - A) U^n = (f_1^n, g_1^n, f_2^n, g_2^n, f_3^n) \to 0 \text{ in } \mathcal{H}.
$$

For simplificity, we replace  $\lambda_n$  by  $\lambda$ ;  $U_n = (u^n, v^n, y^n, z^n, \omega^n)$  by  $U = (u, v, y, z, \omega)$  and  $F_n = \lambda_n^l (i\lambda_n I - A)U_n =$  $(f_1^n, g_1^n, f_2^n, g_2^n, f_3^n)$  by  $F = (f_1, g_1, f_2, g_2, f_3)$ . Next, by detailing  $(4.5)$ , we obtain

(4.6) 
$$
i\lambda u - v = \frac{f_1}{\lambda^{\ell}} \longrightarrow 0 \text{ in } H^1_L(0,1),
$$

(4.7) 
$$
i\lambda v - u_{xx} + bz = \frac{g_1}{\lambda^{\ell}} \longrightarrow 0 \text{ in } L^2(0,1),
$$

(4.8) 
$$
i\lambda y - z = \frac{f_2}{\lambda^{\ell}} \longrightarrow 0 \text{ in } H_0^1(0,1),
$$

(4.9) 
$$
i\lambda z - y_{xx} - bv = \frac{g_2}{\lambda_n^{\ell}} \longrightarrow 0 \text{ in } L^2(0,1),
$$

(4.10) 
$$
(i\lambda + \xi^2 + \eta)\omega(\xi) - v(1)\mu(\xi) = \frac{f_3(\xi)}{\lambda^{\ell}} \longrightarrow 0 \text{ in } L^2(\mathbb{R}).
$$

Proof of Theorem [4.2.](#page-17-2) We divide the proof in two steps.

Step1. The energy decay estimation. First, taking

\ell = \begin{cases} 1 - \alpha & \text{if } b \notin \pi \mathbb{Z}, \\ 5 - \alpha & \text{if } b \in \pi \mathbb{Z} \end{cases}
$$

in Lemma [4.5,](#page-19-7) we get

Then using equation [\(4.25\)](#page-19-4), we deduce that  $y_x(0) = o(1)$  and  $u_x(0) = o(1)$ . Then, by taking  $h = x$  in equation [\(4.24\)](#page-19-3), we get

where  $(\lambda_{1,n})_{|n|\geq n_0}$  and  $(\lambda_{2,n})_{|n|\geq n_0}$  are the simple eigenvalues of A defined in Proposition [3.2.](#page-10-8) Moreover, let  $U_n \in D(\mathcal{A})$  be the normalized eigenfunction corresponding to  $\lambda_n$ . So, set the real sequence  $(\beta_n)_{n \geq n_0}$  by

\beta_n = \begin{cases}\n n\pi + \frac{\gamma (1 - \cos{(b)}) \cos{\left(\frac{\pi \alpha}{2}\right)}}{2(n\pi)^{1-\alpha}}, & \text{if } b \notin \pi \mathbb{Z}^\star, \\

 n\pi + \frac{\pi}{2} + \frac{b^2}{8n\pi} - \frac{b^2}{16\pi n^2} + \frac{b^2 (4\pi^2 + 7b^2)}{128\pi^3 n^3} - \frac{b^2 (4\pi^2 + 21b^2)}{256\pi^3 n^4} + \frac{\gamma b^6 \cos{\left(\frac{\pi \alpha}{2}\right)}}{256\pi^{5-\alpha} n^{5-\alpha}}, & \text{if } b \in \pi (2\mathbb{Z} + 1),\n\end{cases}

4.2. Polynomial Stability in the case  $\eta > 0$  and  $a \neq 1$ . In this part, we study the asymptotic behavior of solution of system  $(2.1)-(2.8)$  $(2.1)-(2.8)$  in the general case when  $a \neq 1$ . Our main result is the following Theorem.

**Case 3.** Assume that Cases 1 and 2 are not true, for almost real number  $\sqrt{a}$ , subtracting [\(4.64\)](#page-25-4) from [\(4.65\)](#page-25-4), we get

(4.71) 
$$
\frac{n}{m} - \sqrt{a} = \frac{(a+1)b^2}{2(a-1)\pi m\lambda} + o\left(\frac{1}{\lambda}\right).
$$

From  $(4.65)$ , we get

(4.72) 
$$
\frac{1}{\lambda} = \frac{1}{m\pi\sqrt{a}} + \frac{o(1)}{m^2}.
$$

Inserting  $(4.72)$  in  $(4.71)$ , we get

(4.73) 
$$
\frac{n}{m} - \sqrt{a} = \frac{(a+1)b^2}{2\sqrt{a}(a-1)\pi^2 m^2} + \frac{o(1)}{m^2}.
$$

From Theorem 1.10 in [\[27\]](#page-28-31), we have for almost all real numbers  $\xi$  there exists infinitely many integers n, m such that

(4.74) 
$$
\left|\xi - \frac{n}{m}\right| < \frac{1}{m^2 \ln |m|}
$$

Let  $\xi = \sqrt{a}$ , then from [\(4.73\)](#page-26-4) and [\(4.74\)](#page-26-5) there exist infinitely many integers n, m such that

(4.75) 
$$
\left| \frac{(a+1)b^2}{2\sqrt{a}(a-1)\pi^2 m^2} + \frac{o(1)}{m^2} \right| = \left| \frac{n}{m} - \sqrt{a} \right| < \frac{1}{m^2 \ln |m|}.
$$

Since  $m \sim \lambda$ , then estimation [\(4.75\)](#page-26-6) can be written as

<span id="page-26-6"></span><span id="page-26-5"></span><span id="page-26-4"></span>
$$
\left| \frac{(a+1)b^2}{2\sqrt{a}(a-1)\pi^2} + o(1) \right| = o(1).
$$

Equivalently, we have

<span id="page-26-7"></span>
$$
\left|\frac{(a+1)b^2}{2\sqrt{a}\left(a-1\right)\pi^2}\right| = o(1)
$$

and this a contradiction. Therefore, we get  $|y_x(1)| = o(1)$  for almost real number  $\sqrt{a}$ .

Hence, in the three cases, we get  $(4.51)$ . The proof is thus complete.

**Proof of Theorem [4.6.](#page-22-3)** Let  $\ell = 5 - \alpha$ . By tacking  $h = 1$  in equation [\(4.50\)](#page-23-1), we get

(4.76) 
$$
|y_x(1)|^2 - |y_x(0)|^2 - |u_x(0)|^2 = \frac{o(1)}{\lambda^{\ell-1+\alpha}}.
$$

It follows from, Lemma [4.9,](#page-23-8) that

(4.77) 
$$
|y_x(1)|^2 = |y_x(0)|^2 = |u_x(0)|^2 = o(1).
$$

Finally, by taking  $h = x$  in equation [\(4.50\)](#page-23-1) and using [\(4.77\)](#page-26-7), we get  $||U||_{\mathcal{H}} = o(1)$  which contradicts[\(4.42\)](#page-22-1), consequently condition  $(4.1)$  holds. This implies, from Lemma [4.1,](#page-17-8) the energy decay estimation  $(4.41)$ . The proof is thus complete.

#### **CONCLUSION**

We have studied the influence of the coefficients on the indirect stabilization of a system of two wave equations coupled by velocities, with only one fractional derivative control. In this work, we consider the Caputo's fractional derivative of order  $\alpha \in ]0,1[$  and  $\eta \ge 0$ . If the wave speeds are equal (i.e.,  $a = 1$ ),  $\eta > 0$  and if the coupling parameter  $b = k\pi$  (resp.  $b \neq k\pi$ ),  $k \in \mathbb{Z}$  and it is outside a discrete set of exceptional values, a non-uniform stability is expected. Then, using a frequency domain approach combining with a multiplier method, we have proved an optimal polynomial energy decay rate of type  $t^{-\frac{2}{1-\alpha}}$  (resp.  $t^{-\frac{2}{5-\alpha}}$ ). In the general method, we have proved an optimal polynomial energy decay rate of type  $t^{-1-\alpha}$  (resp.  $t^{-\alpha-\alpha}$ ). In the general case, when  $a \neq 1$  a non uniform stability is expected. Finally, if  $\sqrt{a}$  is a rational number or (a is case, when  $a \neq 1$  a non-unnorm stability is expected. Finally, if  $\sqrt{a}$  is a fational number of  $\sqrt{a}$  and if b is outside another discrete set experiment and b is small enough or for almost irrational number  $\sqrt{a}$ of exceptional values, using a frequency domain approach, we proved a polynomial energy decay rate of type  $t^{-\frac{2}{5-\alpha}}$ . We conjecture that the remaining cases could be analyzed in the same way with a slower polynomial decay rate.
