# ON THE STABLE PROPERTY OF PROJECTIVE DIMENSION

Abstract. We introduce the concept of monomial ideals with stable projective dimension, as a generalization of the Cohen-Macaulay property. Indeed, we study the class of monomial ideals I, whose projective dimension is stable under monomial localizations at monomial prime ideals **p**, with height  $p \geq \text{pd } S/I$ . We study the relations between this property and other sorts of Cohen-Macaulayness. Finally, we characterize some classes of polymatroidal ideals with stable projective dimension.

### **INTRODUCTION**

Throughout the paper,  $S = K[x_1, \ldots, x_n]$  denotes the polynomial ring in *n* indeterminates over an arbitrary field  $K$ . Let  $M$  be a finitely generated graded  $S$ -module. Then

(1) \qquad \{ \mathfrak{p} \in \mathrm{Supp}(M) \; : \; \mathrm{pd}\,M = \mathrm{pd}\,M_{\mathfrak{p}} \} \subseteq \{ \mathfrak{p} \in \mathrm{Supp}(M) \; : \; \mathrm{height}\, \mathfrak{p} \geq \mathrm{pd}\,M \},
$$

where  $pd(-)$  denotes the projective dimension (cf. Lemma [1.1\)](#page-1-0). If M has positive depth, then the equality holds in  $(1)$ , precisely when M is Cohen-Macaulay (cf. Proposition [1.2\)](#page-1-1). If we replace M with  $S/I$ , for a monomial ideal I in S, it is natural to consider only monomial prime ideals in Supp $(S/I) = V(I)$ . The monomial localization of a monomial ideal  $I \subset$ S at a monomial prime ideal p, is the monomial ideal  $I(\mathfrak{p}) \subseteq S(\mathfrak{p}) = K[x_i : x_i \in \mathfrak{p}]$ obtained from I by setting  $x_i = 1$ , for all variables  $x_i \notin \mathfrak{p}$ . Note that  $\text{pd}(S(\mathfrak{p})/I(\mathfrak{p})) =$  $\text{pd}(S/I)_{\mathfrak{p}}$  (cf. Remark [1.4\)](#page-2-0). Let  $V^*(I)$  denote the set of monomial prime ideals  $\mathfrak{p}$  in  $V(I)$ . Example [1.6,](#page-2-1) provides a monomial ideal I, with depth $(S/I) > 0$ , that satisfies

(2) \quad \{ \mathfrak{p} \in V^*(I) \; : \; \mathrm{pd}\,S/I = \mathrm{pd}(S(\mathfrak{p})/I(\mathfrak{p})) \} = \{ \mathfrak{p} \in V^*(I) \; : \; \mathrm{height} \, \mathfrak{p} \geq \mathrm{pd}\,S/I \},
$$

but  $S/I$  is not Cohen-Macaulay. The main interest in this paper, is to study the class of monomial ideals  $I$ , with property  $(2)$ . In other words, we study the class of monomial ideals I whose projective dimension is stable under monomial localizations at monomial prime ideals **p**, with height  $p \geq \text{pd } S/I$ . In this case, I is said to have *stable projective dimension* (cf. Definition [1.7\)](#page-3-0). This class contains all monomial ideals I, where  $S/I$  is a Cohen-Macaulay ring (cf. Proposition [1.8\)](#page-3-1). Indeed the set of monomial ideals with Cohen-Macaulay quotient rings, is precisely the set of monomial ideals  $I$  with stable projective dimension such that  $\text{Ass}(S/I) = \text{Min}(I)$  (cf. Proposition [1.17\)](#page-5-0). Taking into account that the monomial localization is a simple operation which turns out a monomial ideal in a smaller polynomial ring, the class of ideals with some stable algebraic properties under monomial localizations, have significant role in monomial algebra.

Beginning in Section [1,](#page-1-2) we study  $\text{Ext}^{n-t}(M, S)$ , where M is a finitely generated graded S-module with depth $(M) = t$ . Expressing Supp $(\text{Ext}^{n-t}(M, S))$ , as the set of prime ideals

<span id="page-1-4"></span> $\mathfrak{p} \in \text{Supp}(M)$  with pd  $M_{\mathfrak{p}} = \text{pd } M$ , we specify when the equality holds in [\(1\)](#page-0-0). Then we discuss the relations between the property of having stable projective dimension, and some weaker sorts of Cohen-Macaulayness. Several examples are included to indicate that the set of monomial ideals with stable projective dimension, is disjoint from the set of monomial ideals I, where  $S/I$  is generalized Cohen-Macaulay or sequentially Cohen-Macaulay, and non of them contains the other. More over, it is shown that a monomial ideal I, where  $S/I$  is a generalized Cohen-Macaulay ring, has stable projective dimension if and only if, either S/I is Cohen-Macaulay or depth  $S/I = 0$  (cf. Proposition [1.12\)](#page-4-0).

Section [2,](#page-5-1) is devoted to characterizing some classes of polymatroidal ideals who have stable projective dimension. We show that polymatroidal ideals generated in degree 2 with at least one pure power and Veronese type ideals have stability property of projective dimension. We also characterize transversal polymatroidal ideals with this property.

<span id="page-1-2"></span>Several explicit examples are provided along the paper to illustrate the property of having stable projective dimension. Many of them have been computed by using CoCoA [\[1\]](#page-9-0).

## 1. Stability of projective dimension under localizations

In this paper, we consider the natural grading on the polynomial ring  $S = k[x_1, \ldots, x_n]$ and all S-modules are graded. We use several times the Auslander-Buchsbaum formula [\[6,](#page-9-1) A.4.3], saying that

$$
pd(M) + depth(M) = n,
$$

for all finitely generated graded S-modules M. We start with the following easy lemma, that is a crucial point in our approach.

<span id="page-1-0"></span>Lemma 1.1. *Let* M *be a finitely generated graded* S*-module with* depth M = t*. Then*

$$
\mathrm{Supp}(\mathrm{Ext}^{n-t}(M,S)) = \{\mathfrak{p} \in \mathrm{Supp}(M) : \mathrm{pd} M = \mathrm{pd} M_{\mathfrak{p}}\}
$$

(4) 
$$
\subseteq \{ \mathfrak{p} \in \text{Supp}(M) : \text{height } \mathfrak{p} \geq \text{pd } M \}.
$$

*Proof.* By the Auslander-Buchsbaum formula, pd  $M = n - t$ . Since, pd  $M_p \leq$  pd M for any prime ideal p of S,  $\text{Ext}^{n-t}(M_{\mathfrak{p}}, S_{\mathfrak{p}}) \neq 0$  precisely when pd  $M_{\mathfrak{p}} = \text{pd } M$ . This provides the first equality. The inequality, follows from the fact that pd  $M_{\mathfrak{p}} =$  height  $\mathfrak{p} -$  depth  $M_{\mathfrak{p}}$ .

The following result, specifies when the equality holds in [\(4\)](#page-1-3).

<span id="page-1-1"></span>Proposition 1.2. *Let* M *be a nonzero finitely generated graded* S*-module. Then the following statements are equivalent.*

- (a) pd  $M = \text{pd } M_{\mathfrak{p}}$ , for all  $\mathfrak{p} \in \text{Supp}(M)$  with height  $\mathfrak{p} \geq \text{pd } M$ .
- (b) *Either M* is *Cohen-Macaulay or* depth  $M = 0$ *.*

If the above conditions hold, then dim  $\text{Ext}^{n-t}(M, S) = t$ .

*Proof.* (a)  $\Rightarrow$  (b). By Lemma [1.1,](#page-1-0) { $\mathfrak{p} \in \text{Supp}(M)$ ; height  $\mathfrak{p} = \text{pd } M$ } = Min(Ext<sup>n-t</sup>(M, S)), is a finite set. Hence either  $\text{pd}(M) = \text{height}(\mathfrak{p})$  for all minimal primes  $\mathfrak{p}$  of M, or  $\text{pd}(M) = n$ , from Ratliff's weak existence theorem [\[11,](#page-9-2) Theorem 31.2]. Consequently depth  $M = \dim M$ or depth $(M) = 0$ .

(b)  $\Rightarrow$  (a). If depth  $M = 0$ , then pd  $M = n$  and so the graded maximal ideal of S is the only prime ideal of height greater than or equal to pd  $M$ . Assume that  $M$  is Cohen-Macaulay. Let  $I = \text{Ann } M$ . Then  $M_{\mathfrak{p}}$  is Cohen-Macaulay, for all  $\mathfrak{p} \in \text{Supp } M$  and

 $\operatorname{pd} M_{\mathfrak{p}} = \operatorname{height} \mathfrak{p} - \dim M_{\mathfrak{p}} = \operatorname{height} I_{\mathfrak{p}} = \operatorname{height} I = \operatorname{pd} M,$ 

<span id="page-2-3"></span>which implies (a). For the last statement, let  $J = \text{Ann}(\text{Ext}^{n-t}(M, S))$  and  $I = \text{Ann } M$ . Then

$$
I \subseteq J
$$
 and height  $I \leq \text{pd } M$ .

If pd  $M <$  height J, then there exists  $\mathfrak{p} \in \text{Supp}(M)$  such that

$$
\mathrm{pd}\,M\leq\mathrm{height}\,\mathfrak{p}<\mathrm{height}\,J.
$$

By stability property of projective dimension,  $\mathfrak{p} \in \text{Supp Ext}^{n-t}(M, S)$ , consequently  $J \subseteq \mathfrak{p}$ , a contradiction. Hence pd  $M \geq$  height J and so

$$
\text{pd } M = n - \text{depth } M \leq n - \dim \text{Ext}^{n-t}(M, S) = \text{height } J \leq \text{pd } M,
$$

which completes the proof.  $\Box$ 

<span id="page-2-2"></span>**Corollary 1.3.** Let M be a nonzero finitely generated graded S-module. If pd  $M = pd M<sub>p</sub>$  $for \ all \ \mathfrak{p} \in \text{Supp}(M) \ with \ height \ \mathfrak{p} \geq \text{pd }M, \ then \ Ext^{n-t}(M, S) \ is \ a \ Cohen-Macaulay \ module$ *of dimension*  $t = \text{depth}(M)$ .

*Proof.* We have that M is Cohen-Macaulay or depth $(M) = 0$ , by Proposition [1.2.](#page-1-1) If M is Cohen-Macaulay of dim( $M$ ) = t, then  $Ext^{n-t}(M, S)$  is a Cohen-Macaulay module of dimen-sion t, [\[9,](#page-9-3) Theorem 1.4]. Now, if depth $(M) = 0$ , then pd  $M = n$ . Hence by Lemma [1.1,](#page-1-0)  $\text{Supp}(\text{Ext}^{n-t}(M, S)) = \{\mathfrak{m}\}, \text{ and } \dim(\text{Ext}^{n-t}(M, S)) = 0.$ 

The monomial localization of a monomial ideal  $I \subset S$  with respect to a monomial prime ideal **p** is the monomial ideal  $I(\mathfrak{p}) \subset K[x_i : x_i \in \mathfrak{p}]$  which is obtained from I by substituting the variables  $x_i \notin \mathfrak{p}$  by 1.

<span id="page-2-0"></span>**Remark 1.4.** Let **p** be a monomial prime ideal containing the monomial ideal I. Then  $I(\mathfrak{p})$ is the unique monomial ideal with the property that  $I(\mathfrak{p})S_{\mathfrak{p}} = IS_{\mathfrak{p}}$ . For a polynomial  $f \in S$ , let  $f(\mathfrak{p})$  denote the polynomial in  $S(\mathfrak{p})$ , obtained from f by substituting the variables  $x_i \notin \mathfrak{p}$ by 1. If I is an ideal in S generated by monomials  $u_1, \ldots, u_r$ , then  $I(\mathfrak{p})$  is the monomial ideal generated by  $u_1(\mathfrak{p}), \ldots, u_r(\mathfrak{p})$  in  $S(\mathfrak{p})$ . Note that  $u_i = u_i(\mathfrak{p})v_i$ , for some  $v_i \notin \mathfrak{p}$ . As  $v_i$  is an invertible element in  $S_p$ , it is not difficult to see that  $\text{depth}(S/I)_p = \text{depth}(S(p)/I(p))$  and  $\dim(S/I)_{\mathfrak{p}} = \dim S(\mathfrak{p})/I(\mathfrak{p}).$  In particular  $\text{pd}(S/I)_{\mathfrak{p}} = \text{pd } S(\mathfrak{p})/I(\mathfrak{p}).$ 

The following example, shows that the converse of Corollary [1.3](#page-2-2) is not true.

**Example 1.5.** Let  $S = K[x, y, z, u]$ ,  $I = (x, y) \cap (y, z, u)$  and  $M = S/I$ . Then depth $(M) = 1$ and pd  $M = 3$ . Note that  $\text{Supp}(Ext^3(M, S)) \subseteq \text{Supp}(M) = V(I)$  and  $(x, y)$  is the only prime ideal of height 2, in  $V(I)$ . Since  $pd(M_{(x,y)}) = 2$  and  $pd(M_{(y,z,u)}) = 3$ , we have  $(x, y) \notin \text{Supp}(\text{Ext}^3(M, S))$  and  $(y, z, u) \in \text{Supp}(\text{Ext}^3(M, S))$ . In particular dim  $\text{Ext}^3(M, S)$  =  $\dim S/(y, z, u) = 1 = \text{depth } M$ . We may also see that depth  $\text{Ext}^3(M, S) = 1$ , using computations by CoCoA [\[1\]](#page-9-0).

If pd  $M = \text{pd } M_{\mathfrak{p}}$  only for monomial prime ideals  $\mathfrak{p}$ , with height( $\mathfrak{p}$ )  $\geq$  pd(M), that is a finite set, then we don't necessarily get the statement (b) in Proposition [1.2.](#page-1-1) Here is an example:

<span id="page-2-1"></span>**Example 1.6.** Let  $S = K[x, y, z]$  and  $M = S/I$ , where I is the monomial ideal  $I =$  $x(xy, xz, yz) = (x) \cap (x^2, y) \cap (x^2, z) \cap (y, z)$ . Then dim  $M = 2$ , depth  $M = 1$  and pd( $M$ ) = 2. Let  $\mathfrak{p} \neq \mathfrak{m}$  be a monomial prime ideal in Supp $(M)$ , with height $(\mathfrak{p}) \geq 2$ . Then  $\mathfrak{p} \in Ass(M)$ and so  $\text{pd}(M_{\mathfrak{p}}) = 2 - \text{depth}(M_{\mathfrak{p}}) = 2$ . But it does not hold for the non-monomial prime  $\mathfrak{q} = (x, y + z)$ . Since  $M_{\mathfrak{q}} = S_{\mathfrak{q}}/(x^2)S_{\mathfrak{q}} = (S/(x^2))_{\mathfrak{q}}$  is Cohen-Macaulay of dimension one, we have  $pd(M_q) = \text{height}(q) - \text{depth } M_q = 2 - 1 = 1.$ 

<span id="page-3-3"></span>In the sequel, we consider stability property for monomial ideals with localization in monomial prime ideals. In other words, we are interested to study the class of S-modules, which intersecting the sets in [\(4\)](#page-1-3) with the set of monomial ideals, the equality holds.

<span id="page-3-0"></span>**Definition 1.7.** A monomial ideal  $I \subset S$  *has stable projective dimension* if pd  $S/I$  =  $\text{pd } S(\mathfrak{p})/I(\mathfrak{p})$  for all monomial prime ideals  $\mathfrak{p} \in V^*(I)$  with height  $\mathfrak{p} \geq \text{pd } S/I$ .

Note that a monomial ideal  $I$  has stable projective dimension if and only if

$$
V^*(I) \cap \operatorname{Supp}(\operatorname{Ext}^{n-t}(S/I, S)) = \{ \mathfrak{p} \in V^*(I) \ : \ \operatorname{height}(\mathfrak{p}) \geq \operatorname{pd} S/I \},
$$

where  $t = \text{depth } S/I$ .

<span id="page-3-1"></span>**Proposition 1.8.** Let  $I \subset S$  be a monomial ideal. Then the following conditions are equiv*alent:*

- (a) S/I *is Cohen–Macaulay.*
- (b)  $\text{pd } S/I = \text{pd } S(P)/I(P) \text{ for all } P \in V^*(I).$

*In particular, if* S/I *is Cohen-Macaulay, then* I *has stable projective dimension.*

*Proof.* (a)  $\Rightarrow$  (b): Since S/I is Cohen-Macaulay, then  $S(P)/I(P)$  is Cohen-Macaulay for all  $P \in V^*(I)$ . Therefore

$$
\operatorname{pd} S(P)/I(P) = \operatorname{height} I(P) = \operatorname{height} I = \operatorname{pd} S/I
$$

for  $P \in V^*(I)$ , as desired.

(b)  $\Rightarrow$  (a): We choose  $P \in V^*(I)$  such that height  $P = n - \dim S/I$ . Then we get

$$
n - \operatorname{depth} S/I = \operatorname{pd} S/I = \operatorname{pd} S(P)/I(P) \le \operatorname{height} P = n - \dim S/I.
$$

It follows that depth  $S/I = \dim S/I$ . In other words,  $S/I$  is Cohen–Macaulay.

<span id="page-3-2"></span>Corollary 1.9. *All monomial ideals in* S *of height* n − 1*, have stable projective dimension.*

 $\Box$ 

*Proof.* Let  $I \subset S$  be a monomial ideal of height  $n-1$ . So either depth  $S/I = 0$  or depth  $S/I \ge$  $1 = \dim S/I$ . Hence either depth  $S/I = 0$  or  $S/I$  is Cohen-Macaulay. So by proposition [1.2,](#page-1-1) I has stable projective dimension.  $\Box$ 

For a monomial ideal I, the ring  $S/I$  is called *generalized Cohen-Macaulay*, if  $(S/I)_{p/I}$ is Cohen-Macaulay for all prime ideals  $\mathfrak{p} \in V(I) \setminus \{\mathfrak{m}\}\)$ , and I is equidimensional, i.e.  $\dim(S/\mathfrak{p}) = \dim(S/I)$  for all  $\mathfrak{p} \in \text{Min } I$ . Let I be a monomial ideal of S, then the ring  $S/I$  is generalized Cohen-Macaulay precisely when I is equidimensional and the ring  $S(\mathfrak{p})/I(\mathfrak{p})$  is Cohen-Macaulay for all monomial prime ideals  $\mathfrak{p} \in V^*(I)$  with  $\mathfrak{p} \neq \mathfrak{m}$  (cf. [\[3,](#page-9-4) Lemma 4.1]).

**Example 1.10.** Let I be the ideal in Example [1.6.](#page-2-1) Then I has stable projective dimension, but S/I is not generalized Cohen-Macaulay, because I is not equidimensional.

**Example 1.11.** Let  $I = (x_1, x_2) \cap (x_3, x_4)$  be an ideal in  $S = K[x_1, \ldots, x_4]$ . Then pd  $S/I = 3$ , while  $\text{pd } S(\mathfrak{p})/I(\mathfrak{p}) = \text{pd}(K[x_1, x_2, x_3]/(x_1, x_2)) = 2$ , for  $\mathfrak{p} = (x_1, x_2, x_3)$ . Therefore, I does not have stable projective dimension. Since, any monomial prime ideal  $\mathfrak{p} \in V^*(I) \setminus \{\mathfrak{m}\}\$ contains only one of  $(x_1, x_2)$  or  $(x_3, x_4)$ ,  $S(\mathfrak{p})/I(\mathfrak{p})$  is Cohen-Macaulay. In particular,  $S/I$  is generalized Cohen-Macaulay.

<span id="page-4-2"></span>The above two examples, show that the class of monomial ideals with stable projective dimension, and the class of monomial ideals I such that  $S/I$  is a generalized Cohen-Macaulay ring, are disjoint. The following result, specifies the intersection of these classes. Recall that for a finitely generated S-module M,  $\text{Assh}(M) = {\mathfrak{p} \in \text{Ass}(M)}$ : dim  $S/\mathfrak{p} = \dim M$ .

<span id="page-4-0"></span>**Proposition 1.12.** Let  $I \subset S = K[x_1, \ldots, x_n]$  be a generalized Cohen-Macaulay. Then the *following conditions are equivalent:*

- (a) I *has stable projective dimension.*
- (b) *Either*  $S/I$  *is Cohen-Macaulay or depth*  $S/I = 0$ *.*

*Proof.* (a)  $\Rightarrow$  (b): Let I have stable projective dimension with depth  $S/I \neq 0$  which is not Cohen-Macaulay. Since I is not Cohen-Macaulay, it follows that  $\text{pd } S/I > \text{height } I$ . Let  $\mathfrak{p}' \in \operatorname{Assh} S/I$  and  $\mathfrak{p} = \mathfrak{p}' + \mathfrak{q} \in V^*(I)$  be a monomial prime ideal with height  $\mathfrak{p} = \text{pd } S/I$ . Since height  $\mathfrak{p} = \text{pd } S/I = n - \text{depth } S/I < n$ , it follows that  $\mathfrak{p} \neq \mathfrak{m}$ . Hence since I is generalized Cohen-Macaulay, we have that  $S(\mathfrak{p})/I(\mathfrak{p})$  is Cohen-Macaulay. Therefore

$$
\operatorname{pd} S(\mathfrak{p})/I(\mathfrak{p})=\operatorname{height} I(\mathfrak{p})\leq \operatorname{height} I=\operatorname{height}\mathfrak{p}^{\prime}<\operatorname{height}\mathfrak{p}=\operatorname{pd} S/I.
$$

So I does not have stable projective dimension.

 $(b) \Rightarrow (a)$  is obvious by Proposition [1.2.](#page-1-1)

**Remark 1.13.** For a monomial ideal I with height(I) =  $n-1$ , the ring  $S/I$  is a one dimensional generalized Cohen-Macaulay ring. Proposition [1.12](#page-4-0) interprets the argument of the proof of Corollary [1.9,](#page-3-2) in a more general content.

For a finitely generated S-module M, of dimension d, let  $M_i$  denote the largest submodule of M such that  $\dim M_i \leq i$ , for  $0 \leq i < d$ . Note that  $M_{i-1} \subseteq M_i$ . The increasing filtration  $\{M_i\}_{i=0}^d$ , is called the dimension filtration. Note that Ass  $M_i/M_{i-1} = \{\mathfrak{p} \in \text{Ass } M :$  $\dim S/\mathfrak{p} = i$  (cf. [\[12,](#page-9-5) Corollary 2.3]). Therefore,  $M_i/M_{i-1}$  is either zero or an *i*-dimensional module. M is called *sequentially Cohen-Macaulay*, if  $M_i/M_{i-1}$  is a Cohen-Macaulay S-module for  $i = 1, \ldots, d$ .

<span id="page-4-1"></span>**Remark 1.14.** Let M be a finitely generated S-module of dimension d. If  $\text{Ass}(M)$  = Assh $(M)$ , then  $M_i = 0$ , for  $i = 0, \ldots, d-1$  and  $M_d = M$ . In particular, M is Cohen-Macaulay if and only if M is sequentially Cohen-Macaulay and  $\operatorname{Ass}(M) = \operatorname{Assh}(M)$ .

**Example 1.15.** Let  $S = K[x_1, \ldots, x_4]$  and  $I = (x_1x_2, x_2x_3, x_3x_4, x_1x_4, x_1x_3) = (x_1, x_3) \cap I$  $(x_1, x_2, x_4) \cap (x_2, x_3, x_4)$ . Since I is the edge ideal of a chordal graph,  $S/I$  is sequentially Cohen-Macaulay, by [\[4,](#page-9-6) Theorem 3.2].  $R/I$  is a two dimensional ring, which is not Cohen-Macaulay and does not have the maximal ideal in its associated prime ideals. Therefore, depth  $S/I = 1$  and pd  $S/I = 3$ . Let  $\mathfrak{p} = (x_1, x_2, x_3)$ . Then  $S(\mathfrak{p})/I(\mathfrak{p}) = K[x_1, x_2, x_3]/(x_1, x_3)$ is of projective dimension 2. Hence  $I$  does not have stable projective dimension.

By definition, all monomial ideals I with depth $(S/I) = 0$ , have stable projective dimensions. But  $S/I$  is not necessarily sequentially Cohen-Macaulay. Here is an example in the class of monomial ideals, with positive depth.

Example 1.16. Let  $S = K[x_1, \ldots, x_4]$  and  $I = (x_1, x_4) \cap (x_2, x_3) \cap (x_1, x_2, x_3)^2 \cap (x_1, x_2, x_4)^2 \cap$  $(x_1, x_3, x_4)^2 \cap (x_2, x_3, x_4)^2$ . Then pd  $S/I = 3$ . As all monomial prime ideals of height 3, are among the associated radical ideals, depth  $S(\mathfrak{p})/I(\mathfrak{p}) = 0$ , which implies pd  $S(\mathfrak{p})/I(\mathfrak{p}) = 3$ , for all **p** with height **p** = 3. Therefore, I has stable projective dimension. Note that,  $\sqrt{I}^{\vee}$  =  $((x_1, x_4) \cap (x_2, x_3))^{\vee} = (x_1x_4, x_2x_3)$ , does not have linear resolution. Therefore,  $S/\sqrt{I}$  is not

<span id="page-5-3"></span>sequentially Cohen-Macaulay, by [\[4,](#page-9-6) Theorem 3.1]. Now, [\[10,](#page-9-7) Theorem 2.6], implies that  $S/I$ is not sequentially Cohen-Macaulay.

The above examples, show that the class of monomial ideals I, where  $S/I$  is sequentially Cohen-Macaulay and the class of ideals with stable projective dimension, are disjoint and non of them contains the other.

<span id="page-5-0"></span>**Proposition 1.17.** Let  $I \subset S$  be a monomial ideal with  $\text{Ass}(S/I) = \text{Min}(I)$ . Then I has *stable projective dimension if and only if* S/I *is Cohen-macaulay.*

*Proof.* If  $S/I$  is Cohen-Macaulay, then obviously I has stable projective dimension. Now if  $S/I$  is not Cohen-Macaulay, we show that I does not have stable projective dimension. Since  $S/I$  is not Cohen-Macaulay, it follows that pd  $S/I >$  height I. Let  $\mathfrak{p}' \in \text{Assh } S/I$  and  $\mathfrak{p} = \mathfrak{p}' + \mathfrak{q}$  be a monomial prime ideal with height  $\mathfrak{p} = \text{pd } S/I$ . Since  $\text{Ass}(S/I) = \text{Min}(I)$  and  $\mathfrak{p}' \subsetneq \mathfrak{p}$ , it follows that  $\mathfrak{p} \notin \text{Ass } S/I$ , so depth  $S(\mathfrak{p})/I(\mathfrak{p}) \neq 0$ . Therefore

$$
\operatorname{pd} S(\mathfrak{p})/I(\mathfrak{p})=\operatorname{height}\mathfrak{p}-\operatorname{depth} S(\mathfrak{p})/I(\mathfrak{p})=\operatorname{pd} S/I-\operatorname{depth} S(\mathfrak{p})/I(\mathfrak{p})<\operatorname{pd} S/I.
$$

So I does not have stable projective dimension.

<span id="page-5-2"></span>Remark 1.18. The above result implies that for squarefree or unmixed monomial ideals (ideals I with  $\text{Ass}(S/I) = \text{Assh}(S/I)$ ), stable projective dimension property of I, is equivalent with Cohen-Macaulay property of  $S/I$ . Example [2.6,](#page-7-0) provides an equidimensional monomial ideal I with stable projective dimension, such that  $S/I$  is not Cohen-Macaulay.

The following result is a consequence of Proposition [1.17](#page-5-0) and Remark [1.14.](#page-4-1)

Corollary 1.19. *Let*  $I \subset S$  *be a monomial ideal, such that*  $\text{Ass}(S/I) = \text{Assh}(S/I)$ *. Then the following statement are equivalent.*

- (a) I *has stable projective dimension.*
- (b) S/I *is Cohen-Macaulay.*
- (c) S/I *is sequentially Cohen-Macaulay.*

In the above corollary, (b) always implies (a) and (c), without any assumption on  $\text{Ass}(S/I)$ . The following example, shows that the condition  $\text{Ass}(S/I) = \text{Assh}(S/I)$  is necessary for the inverse.

**Example 1.20.** Let  $S = K[x_1, x_2, x_3]$  and  $I = (x_1) \cap (x_2, x_3) \cap (x_1^2, x_2) \cap (x_1^2, x_3)$ . Then  $p \cdot dS/I = 2$ . As all monomial prime ideals **p** with height(**p**) = 2, belong to the associated prime ideals of I, pd  $S(\mathfrak{p})/I(\mathfrak{p}) = 2$ . In particular, I has stable projective dimension. Since  $\dim S = 3$ , the ideal I is pretty clean by [\[13,](#page-9-8) Theorem 1.10]. Therefore,  $S/I$  is sequentially Cohen-Macaulay by [\[7,](#page-9-9) Corollary 4.3].

## 2. Polymatroidal ideals with stable projective dimension

<span id="page-5-1"></span>In this section we characterize some special classes of polymatroidal ideals with stable projective dimension. Let  $I \subset S = K[x_1, \ldots, x_n]$  be a monomial ideal generated in a single degree and  $G(I)$  be the unique minimal set of monomial generators of I. Then I is said to be polymatroidal, if for any two elements  $u, v \in G(I)$  such that  $\deg_{x_i}(u) > \deg_{x_i}(v)$  there exists an index j with  $\deg_{x_j}(u) < \deg_{x_j}(v)$  such that  $x_j(u/x_i) \in I$ . In the sequel a monomial prime ideal  $\mathfrak p$  will be denoted by  $\mathfrak p_{\{i_1,\dots,i_t\}}$ , where  $\{i_1,\dots,i_t\} = [n] \setminus \{x_i; x_i \in \mathfrak p\}.$ 

**Proposition 2.1.** Let  $I \subset S = K[x_1, \ldots, x_n]$  be a polymatroidal generated in degree 2 with at least one pure power  $x_i^2 \in I$ , for some  $1 \le i \le n$ . Then I has stable projective dimension.

$$
\Box
$$

<span id="page-6-2"></span>*Proof.* Without loss of generality, we may assume that I is fully supported. By [\[2,](#page-9-10) Proposition 2.1 (e)], after relabeling of the variables there exists integer  $1 \leq k \leq n$  such that

$$
I=(x_1,\ldots,x_k)(x_1,\ldots,x_n)+J,
$$

where *J* is a squarefree monomial ideal in the variables  $x_{k+1}, \ldots, x_n$ . Set  $\mathfrak{q} := (x_1^2, x_2, \ldots, x_n)$ . Obviously q is one of the irreducible component of minimal primary decomposition of I. Hence  $\mathfrak{m} = \sqrt{\mathfrak{q}} \in \text{Ass}(S/I)$ , and depth  $S/I = 0$ . As  $\mathfrak{m}$  is the only monomial ideal with height equal to  $n = \text{pd}(S/I)$ , I has stable projective dimension.

The following example shows that the condition of having at least one pure power is essential.

Example 2.2. Let  $I = (x_1x_2, x_1x_3) \subset K[x_1, x_2, x_3]$ . I is matroidal ideal generated in degree 2. As  $S/I$  is not Cohen-Macaulay, I does not have stable stable projective dimension by Remark [1.18.](#page-5-2)

An interesting special case of polymatroidal ideals is that of ideals of Veronese type. Given positive integers  $d, a_1, \ldots, a_n$  such that  $1 \le a_i \le d$ . We let  $I_{(d;a_1,\ldots,a_n)} \subset S = K[x_1,\ldots,x_n]$  be the monomial ideal generated by the monomials  $u \in S$  of degree d satisfying  $\deg_{x_i}(u) \leq a_i$ for all  $i = 1, \ldots, n$ . Monomial ideals of this type are called ideals of *Veronese type*.

For the proof of the next theorem, we need the following results.

<span id="page-6-0"></span>**Lemma 2.3.** [\[5,](#page-9-11) Theorem 3.3] *Let*  $I = I_{(d;a_1,\ldots,a_n)}$  *with*  $1 \leq a_i \leq d$  *for all i. Then* 

$$
\text{pd } S/I = \min\{n, \sum_{i=1}^{n} a_i - d + 1\}.
$$

<span id="page-6-1"></span>Lemma 2.4. *Let* J *be a Veronese type ideal of* S *and* p *be a monomial prime ideal of* S *with* height  $\mathfrak{p} \geq \text{pd } S/J$ *. Then*  $\mathfrak{p} \in V^*(J)$ *.* 

*Proof.* Let  $J = I_{(d;a_1,...,a_n)}$  with  $1 \leq a_i \leq d$  for all i, and p be a monomial prime ideal of S with height  $\mathfrak{p} \geq \text{pd } S/J$ . If  $\text{pd } S/J = n$ , then  $\mathfrak{m} \in \text{Ass}(S/J)$  and height  $\mathfrak{p} \geq n$ . Hence  $\mathfrak{p} = \mathfrak{m} \in V^*(J)$ . Now let  $\text{pd}(S/J) = \sum_{i=1}^n a_i - d + 1$ . If  $\sum_{i=1}^n a_i = d$ , then  $J = (x_1^{a_1})$  $\binom{a_1}{1} \cdots \binom{a_n}{n}$ . Since  $a_i \geq 1$  for all  $i \in [n]$ ,  $\mathfrak{p} \in V^*(\overline{J})$ . Now assume that  $\sum_{i=1}^n a_i > d$ . We want to show that  $\mathfrak{p} \in \text{Ass}(S/J^k)$ , where  $k = \text{height } \mathfrak{p} - 1$ , then obviously  $\mathfrak{p} \in V^*(J)$ . Since height  $\mathfrak{p} \geq$  $\sum_{i=1}^{n} a_i - d + 1$  and  $\sum_{i=1}^{n} a_i > d$ , we have that  $k \ge 1$ . By [\[8,](#page-9-12) Lemma 5.1],  $J^k = I_{(kd;ka_1,...,ka_n)}$ . Since  $\sum_{i=1}^{n} a_i > d$ , it follows that  $k(\sum_{i=1}^{n} a_i - d) \geq k =$  height  $\mathfrak{p} - 1$ . Hence  $k(\sum_{i=1}^{n} a_i) \geq$  $kd - 1 + \text{height } \mathfrak{p}$ . On the other hand, Since  $a_i \geq 1$ , for all i, then

height 
$$
\mathfrak{p} \ge \sum_{i=1}^n a_i - d + 1 = \sum_{x_i \in \mathfrak{p}} a_i + \sum_{x_i \notin \mathfrak{p}} a_i - d + 1 \ge \text{height } \mathfrak{p} + \sum_{x_i \notin \mathfrak{p}} a_i - d + 1.
$$

Hence  $\sum_{x_i\notin p} a_i - d \leq -1$ , so  $k(\sum_{x_i\notin p} a_i - d) \leq -1$ . Therefore by [\[8,](#page-9-12) Proposition 5.2],  $\mathfrak{p} \in \text{Ass}(S/J^k).$ ).

**Theorem 2.5.** Let  $I = uJ$  be a polymatroidal ideal of  $S = K[x_1, \ldots, x_n]$ , where u is a *monomial ideal and* J *is a Veronese type ideal of* S*. Then* I *has stable projective dimension.*

*Proof.* First, we show that if I is a Veronese type ideal, then I has stable projective dimension. Let  $I = I_{(d;a_1,...,a_n)}$  with  $1 \le a_i \le d$  for all i. If  $\text{pd } S/I = n$ , then there is nothing to prove. Now let  $\operatorname{pd} S/I = \sum_{i=1}^n a_i - d + 1$ . Let  $\mathfrak{p} \in V^*(I)$  with height  $\mathfrak{p} \geq \operatorname{pd} S/I$ . We want to show that  $\text{pd } S/I = \text{pd } S(\mathfrak{p})/I(\mathfrak{p})$ . We may assume that  $\mathfrak{p} = \mathfrak{p}_{\{1,\ldots,k\}}$ . Therefore,

<span id="page-7-3"></span> $n - k =$  height  $\mathfrak{p} \geq \text{pd } S/I$ . We claim that  $a_j \leq d - \sum_{i=1}^k a_i$  $\sum$  $k - k = \text{height } \mathfrak{p} \geq \text{pd } S/I$ . We claim that  $a_j \leq d - \sum_{i=1}^k a_i$  for all  $j \notin [k]$ . We have  $\frac{n}{i} a_i \leq n - k + d - 1$ , because  $\text{pd } S/I \leq n - k$ . Hence, since  $a_i \geq 1$  for all *i*, it follows that

$$
a_j + n - k - 1 \le a_j + \sum_{\substack{k+1 \le i \le n \\ i \ne j}} a_i = \sum_{i=k+1}^n a_i \le n - k + d - 1 - \sum_{i=1}^k a_i,
$$

for all  $j \notin [k]$ . This implies that  $a_j \leq d - \sum_{i=1}^k a_i$  for all  $j \notin [k]$ . Therefore, since  $I(\mathfrak{p}) =$  $I_{(d-\sum_{i=1}^k a_i; a_{k+1},...,a_n)}$ , it follows that  $\text{pd } S(\mathfrak{p})/\overline{I(\mathfrak{p})} = \min\{n-k,\sum_{i=1}^n a_i - d + 1\}$ , by Lemma [2.3.](#page-6-0) Hence pd  $S(\mathfrak{p})/I(\mathfrak{p}) = \sum_{i=1}^n a_i - d + 1 = \text{pd } S/I$ , because  $\sum_{i=1}^n a_i - d + 1 \leq n - k$ .

Now we assume more generally that  $I = uJ$  is a polymatroidal, where J is a Veronese type ideal of S. Let  $\mathfrak{p} \in V^*(I)$  with height  $\mathfrak{p} \geq \text{pd } S/I$ . Then since  $\text{pd } S/I = \text{pd } S/J$ , it follows that height  $\mathfrak{p} \geq \text{pd } S/J$  and also by Lemma [2.4,](#page-6-1)  $\mathfrak{p} \in V^*(J)$ . By the first part of the proof we know that  $\text{pd } S/J = \text{pd } S(\mathfrak{p})/J(\mathfrak{p})$ . Hence  $\text{pd } S/I = \text{pd } S(\mathfrak{p})/I(\mathfrak{p})$ , as desired.

<span id="page-7-0"></span>**Example 2.6.** The Veronese type ideal  $I = I_{(3,2,2,1)} \subset S = K[x_1, x_2, x_3]$  has stable projective dimension. Although  $I = (x_1^2, x_2) \cap (x_1, x_2^2) \cap (x_1, x_3) \cap (x_2, x_3) \cap (x_1^2, x_2^2, x_3)$  is equidimensional, it is not Cohen-Macaulay.

Let I be a *transversal polymatroidal ideal*, say,  $I = \mathfrak{p}_1 \cdots \mathfrak{p}_r$  for monomial prime ideals  $\mathfrak{p}_1, \ldots, \mathfrak{p}_r$ . As in [\[8\]](#page-9-12) we define the graph  $G_I$  associated with I as follows: the vertex set of  $G_I$ is [r] and  $\{i, j\}$  is an edge of  $G_I$  if and only if  $G(\mathfrak{p}_i) \cap G(\mathfrak{p}_j) \neq \emptyset$ .

The projective dimension of a transversal polymatroidal ideal is readable from its connected components:

<span id="page-7-1"></span>**Lemma 2.7.** [\[8,](#page-9-12) Theorem 4.12] *Let*  $I = \mathfrak{p}_1 \cdots \mathfrak{p}_r$  *be a transversal polymatroidal ideal, and let*  $H_1, \ldots, H_s$  *be the connected components of*  $G_I$ *. Then* 

$$
\text{pd}\,I = \sum_{j=1}^{s} (|\bigcup_{i \in H_j} G(\mathfrak{p}_i)| - 1) = |\operatorname{supp}(I)| - s.
$$

<span id="page-7-2"></span>**Theorem 2.8.** Let I be a transversal polymatroidal ideal of  $S = K[x_1, \ldots, x_n]$ . Then I has *stable projective dimension if and only if one of the following conditions is satisfied:*

- (a) I *is a product of principal ideals.*
- (b) I *is the power of a monomial prime ideal.*
- (c)  $G_I$  *is connected and* I *is fully supported.*

*Proof.* Assume that I has stable projective dimension. Let  $I = \mathfrak{p}_1 \cdots \mathfrak{p}_r$  and  $H_1, \ldots, H_s$  be the connected components of  $G_I$ , and set  $I_j = \prod_{i \in H_j} \mathfrak{p}_i$ . We first show that if  $|\mathfrak{p}_i| \geq 2$  for each  $i \in [r]$ , then  $G_I$  is connected and I is fully supported or I is the power of a monomial prime ideal.

For each  $j \in [s-1]$ , we choose  $i_j \in H_j$ , and set  $\mathfrak{p} = \mathfrak{p}_{\{i_1,\dots,i_{s-1}\}}$ . Since  $\bigcup_{i \in H_s} G(\mathfrak{p}_i) \subseteq \mathfrak{p}$ , it follows that  $\mathfrak{p} \in V^*(I)$ . Moreover, height  $\mathfrak{p} = n - (s - 1) \geq \text{pd } S/I = |\text{supp}(I)| - (s - 1)$ , see Lemma [2.7.](#page-7-1) Therefore, since I has stable projective dimension, it follows that pd  $I = pd I(p)$ .

Next we show that  $\text{pd } I_i(\mathfrak{p}) \leq |\text{supp}(I_i)| - 2$  for all  $j \in [s-1]$ . Indeed, if  $I_i(\mathfrak{p}) = S(\mathfrak{p})$  for some  $j \in [s-1]$ , then pd  $I_i(\mathfrak{p}) = 0$ , and the assertion is trivial because  $|\text{supp}(I_i)| \geq 2$ . On the other hand, if  $I_j(\mathfrak{p}) \neq S(\mathfrak{p})$ , then by using Lemma [2.7,](#page-7-1) we obtain

$$
\text{pd}\,I_j(\mathfrak{p}) = |\,\text{supp}(I_j(\mathfrak{p}))| - h \leq |\,\text{supp}(I_j)| - 1 - h \leq |\,\text{supp}(I_j)| - 2,
$$

<span id="page-8-0"></span>where  $h \geq 1$  is the number of connected components of  $G_{I_j(\mathfrak{p})}$ . So in each case we have that  $p d I_j(\mathfrak{p}) \leq |\text{supp}(I_j)| - 2 \text{ for all } j \in [s-1].$ 

Since  $I(\mathfrak{p}) = (\prod_{j=1}^s I_j(\mathfrak{p}))$ , it follows that  $\text{pd } I(\mathfrak{p}) = \sum_{j=1}^{s-1} \text{pd } I_j(\mathfrak{p}) + \text{pd } I_s$  because  $G(I_s) =$  $G(I<sub>s</sub>(\mathfrak{p}))$ . Therefore, by using Lemma [2.7,](#page-7-1) we get

$$
\text{pd } I = \text{pd } I(\mathfrak{p}) \le \sum_{j=1}^{s-1} (|\text{supp}(I_j)| - 2) + |\text{supp}(I_s)| - 1 = \text{pd } I - (s - 1),
$$

which implies that  $s = 1$ . Hence  $G_I$  is connected.

Now, assuming that  $I$  is not the power of a monomial prime ideal, we show that  $I$  is fully supported. Suppose to the contrary that  $|\text{supp}(I)| < n$ . Since I is not the power of a monomial prime, there exist  $1 \leq j, k \leq r$  and  $x_t \in G(\mathfrak{p}_j) \setminus G(\mathfrak{p}_k)$ . Let  $\mathfrak{p} = \mathfrak{p}_{\{x_t\}}$ . Then  $\mathfrak{p} \in V^*(I)$  because  $\mathfrak{p}_k \subset \mathfrak{p}$  and height $(\mathfrak{p}) = n - 1 \geq \text{pd } S/I$ .

Suppose  $I(\mathfrak{p}) = S(\mathfrak{p})$ , then  $0 = \text{pd } I(\mathfrak{p}) = \text{pd } I = |\text{supp}(I)| - 1 \geq 1$ , a contradiction. On the other hand, if  $I(\mathfrak{p}) \neq S(\mathfrak{p})$ , then pd  $I(\mathfrak{p}) = |\text{supp}(I(\mathfrak{p}))| - d$ , where  $d \geq 1$  is the number of connected components of  $I(\mathfrak{p})$ . Hence  $\text{pd } I(\mathfrak{p}) \leq |\text{supp}(I)| - 1 - d \leq |\text{supp}(I)| - 2 =$  $pd I - 1 < pdi>I$ , which is again a contraction. Thus we must have that I is fully supported.

In order to conclude our proof that I must satisfy one of the conditions  $(a), (b)$  or  $(c)$ , it remains to be shown that if there exists  $l \in [r]$ , such that  $\mathfrak{p}_l$  is principal, then I satisfies one of the conditions (a) or (c). If  $\mathfrak{m} \in \text{Ass}(S/I)$ , then  $G_I$  is connected and I is fully supported by [\[8,](#page-9-12) Theorem 4.3]. Otherwise, we show that  $\mathfrak{p}_i$  is principal for all  $i \in [r]$ . If  $\mathfrak{p}_d$  is not principal for some  $d \in [r]$ , then there exists  $x_t \in \mathfrak{p}_d \setminus \mathfrak{p}_l$ , and  $\mathfrak{p} = \mathfrak{p}_{\{x_t\}} \in V^*(I)$ , because  $\mathfrak{p}_l \subset \mathfrak{p}$ . Since  $\mathfrak{m} \notin \text{Ass}(S/I)$ , hence pd  $S/I \leq n-1$  = height(p). We may assume that  $\mathfrak{p}_d$  is one of the factors of the ideal  $I_1$ , as defined in the first part of the proof. Then pd  $I_1 = |\text{supp}(I_1)| - 1 \ge 1$ . If  $I_1(\mathfrak{p}) = S(\mathfrak{p})$ , then pd  $I_1(\mathfrak{p}) <$  pd  $I_1$ , and if  $I_1(\mathfrak{p}) \neq S(\mathfrak{p})$ , then by Lemma [2.7,](#page-7-1) pd  $I_1 =$  $|\supp(I_1)| - 1 > |\supp(I_1(\mathfrak{p}))| - 1 \geq \text{pd } I_1(\mathfrak{p})$ . So in each case  $\text{pd } I_1 > \text{pd } I_1(\mathfrak{p})$ . Hence since  $\text{pd } I_j \geq \text{pd } I_j(\mathfrak{p})$  for all  $j \in [s]$ , it follows that  $\text{pd } I = \sum_{i=1}^s \text{pd } I_i > \sum_{i=1}^s \text{pd } I_i(\mathfrak{p}) = \text{pd } I(\mathfrak{p}),$ which contradicts our assumption that I has stable projective dimension.

Conversely, it is obvious that I has stable projective dimension in the cases (a) and (b). Now, assume condition (c) is satisfied. Then Lemma [2.7](#page-7-1) implies that pd  $I = n-1$ , and hence depth  $S/I = 0$ , so I has stable projective dimension. depth  $S/I = 0$ , so I has stable projective dimension.

The following examples, show that stability property of projective dimension is not inherited by radical and power.

- **Example 2.9.** (a) Let  $I = (x_1, x_2, x_3)(x_1, x_4) \subset S = K[x_1, \ldots, x_4]$ . Since I is connected and fully supported transversal polymatroidal ideal, it follows by Theorem [2.8](#page-7-2) that I has stable projective dimension, but  $\sqrt{I} = (x_1, x_2x_4, x_3x_4)$  is not Cohen-Macaulay, so does not have stable projective dimension.
	- (b) Let  $I = (x_1x_2, x_2x_3, x_3x_4)$ .  $S/I$  is Cohen-Macaulay and  $Ass(S/I^2) = Min(I^2)$ , but  $S/I^2$ is not Cohen-Macaulay. So by Proposition [1.17,](#page-5-0)  $S/I^2$  does not have stable projective dimension.
