CRITICAL GROUPS OF VAN LINT-SCHRIJVER CYCLOTOMIC STRONGLY REGULAR GRAPHS.

ABSTRACT. The *critical* group of a finite connected graph is an abelian group defined by the Smith normal form of its Laplacian. Let *q* be a power of a prime and *H* be a multiplicative subgroup of $K = \mathbb{F}_q$. By Cay(*K*, *H*) we denote the Cayley graph on the additive group of *K* with "connection" set *H*. A strongly regular graph of the form Cay(*K*, *H*) is called a *cyclotomic strongly regular graph*. Let $\ell > 2$ and *p* be primes such that *p* is primitive (mod ℓ). We compute the *critical* groups of a family of *cyclotomic strongly regular graphs* for which $q = p^{(\ell-1)t}$ (with $t \in \mathbb{N}$) and *H* is the unique multiplicative subgroup of order $k = \frac{q-1}{\ell}$. These graphs were first discovered by van Lint and Schrijver in [24].

1. INTRODUCTION

Let $\Gamma = (V, E)$ be a finite, simple, and connected graph. Let A be the adjacency matrix of Γ with respect to some arbitrary but fixed ordering of the vertex set V. Define the matrix D to be the diagonal matrix of size |V| whose *i*th diagonal entry is the valency of the *i*th vertex of Γ . The matrix L := D - A is called the Laplacian matrix of Γ . By \mathbb{Z}^V we denote the free \mathbb{Z} -module with V as a basis set. By abuse of notation, we may consider L to be an element of End_{\mathbb{Z}} (\mathbb{Z}^V). The *critical* group $C(\Gamma)$ is the finite part of the cokernal of L.

This group is an invariants of Γ . By Kirchhoff's Matrix-tree theorem, it can be deduced that the order of $C(\Gamma)$ is equal to the number of spanning trees of Γ . (For instance, see [22].) The critical groups of various graphs arise in graph theory in the context of the chip firing game (cf. [4]), as the *abelian sandpile group* in statistical physics (cf. [9]), and also in arithmetic geometry (cf. [16]). Early works with computations of critical groups include [25] and [17]. In [25], the critical groups of Wheel graphs and complete bipartite graphs were computed. In the same paper, it was shown that the group depends only on the cycle matroid of the graph. The critical groups of complete bipartite graphs were computed independently in [17] as well.

Other papers that include computation of critical groups of families of graphs include [15], [8], [2], [14], [10], [6], and [18]. In [15], Lorenzini examined the proportion of graphs with cyclic critical groups among graphs with critical groups of particular order. There are relatively few classes of graphs with known critical groups. A particular class of groups that has proved amenable to computations is the class of strongly regular graphs (for instance, see section 3 of[15]). In this paper we describe the critical groups of the *cyclotomic strongly regular graphs* discovered in [24].

Consider a finite field *K* of characteristic *p* and a subgroup *H* of K^{\times} . By Cay(*K*, *H*) we denote the Cayley graph on the additive group of *K* with "connection" set *H*. If Cay(*K*, *H*) is a strongly regular graph, then we speak of a *cyclotomic strongly regular graph* (*cyclotomic SRG*). The Paley graph is a well known example of a *cyclotomic SRG*. This family of SRGs has been studied extensively by many authors; see [24, 5, 19, 12]. We refer the reader to section 4 of [26] for a survey on these graphs. If *H* is the multiplicative group of a non-trivial subfield of *K*, then Cay(*K*, *H*) is a *cyclotomic SRG*. A graph of this form is called a *subfield cyclotomic SRG*. Other examples of *cyclotomic SRGs* are the *semi-primitive cyclotomic SRGs*. Consider a subgroup *H* of K^{\times} with $N := [K^{\times} : H] > 1$ and $N \mid \frac{|K^{\times}|}{p-1}$. Further assume that there exists an integer *s* such that $p^s \equiv -1 \pmod{N}$. These arithmetic restrictions on *H* ensure that the adjacency matrix of the regular graph Cay(*K*, *H*) has exactly 3 eigenvalues and thus is a *cyclotomic SRG* (see for example, Section 4 of [26]). A graph of this form is called a *semi-primitive cyclotomic SRG*. According to a conjecture by Schmidt and White (Conjecture 4.4 of [19]/ Conjecture 4.1 of [26]), other than the above mentioned classes, there are only 11 sporadic examples of *cyclotomic SRGs*. In this paper we consider a class of *semi-primitive cyclotomic SRGs* discovered in [24].

Consider a pair of primes (p, ℓ) with $\ell \neq 2$, and a positive integer $t \in \mathbb{N}$. The graph $G(p, \ell, t)$ denotes Cay(K, S), where $K = \mathbb{F}_{p^{(\ell-1)t}}$ and S is the subgroup of index ℓ in K^{\times} . Further assume (a) $p^{(\ell-1)t/2} \neq \ell - 1$ whenever t is odd; and (b) p is primitive in $\mathbb{Z}/\ell\mathbb{Z}$. The arithmetic constraint (a) is equivalent to the graph being connected, and (b) implies

that $G(p, \ell, t)$ is a *semi-primitive SRG*. These *semi-primitive cylclotomic SRGs* were discovered in [24]. In this paper we describe the critical groups of this family of graphs. The construction of this family is similar to that of Paley and Peisert graphs. The critical group of the Paley graph was computed in [8], and that of Peisert graph was described in [20]. We extend the techniques used in [8] and [20] to compute the critical group of $G(p, \ell, t)$ (with (p, ℓ, t) satisfying arithmetic constraints (a) and (b)).

We denote the critical group of $G(p, \ell, t)$ by C. Our results giving the elementary divisors of C are stated in §4. As C is an abelian group, we can find subgroups C_p (the Sylow p-subgroup of C), $C_{p'}$ such that $C \cong C_p \oplus C_{p'}$ and $p \nmid |C_{p'}|$. We use different approaches to compute these two subgroups. Theorem 3 describes $C_{p'}$. We apply a standard method of diagonalizing the Laplacian using the character table of $K = \mathbb{F}_q$ (here $q = p^{(\ell-1)t}$). A different approach is required to obtain a description of C_p . In §6, we study the permutation action of S on R-free module R^K with basis K, where R is the ring of integers of a suitable extension of \mathbb{Q}_p . Let \hat{S} be the group of R-valued characters of S. We obtain the decomposition $R^K = \bigoplus_{\chi \in \hat{S}} N_{\chi}$, where N_{χ} is the isotypic component of the S-module R^K corresponding to the character χ . Since S preserves adjacency, each of these isotypic components is invariant under the Laplacian L. Some Jacobi sums naturally arise in the computation of the Smith normal form of L restricted to these isotypic components. The description of C_p is reduced to computation of p-adic valuations of Jacobi sums. Classical results by Stickelberger and Gauss describe the p-adic valuations of Jacobi sums in combinatorial terms. Theorem 1 gives a description of C_p in terms of p-adic valuations of Jacobi sums. At this point, writing the elementary divisor form of C is now reduced to a counting problem. We use the transfer matrix method to determine the elementary divisor form in the case $\ell = 3$. For a fixed t, Theorem 2 leads to a recursive algorithm that yields the p-elementary divisors of the critical group of G(p, 3, t), where p is any prime with $p \equiv 2 \pmod{3}$. As a consequence we were able to show that the *p*-rank of the Laplacian of G(p, 3, t) is $\left(\frac{p+1}{3}\right)^{2t} (2^{t+1}-2)$ (see Cor. 16). We were not able to obtain a similar results

in the case $\ell \neq 3$.

2. DEFINITIONS AND NOTATION.

Let (p, ℓ) be a pair of primes such that $\ell > 2$ and p is primitive $(\mod \ell)$. Let $t \in \mathbb{Z}_{>0}$ and $q = p^{(\ell-1)t}$. Moreover we assume that $\sqrt{q} = p^{(\ell-1)t/2} \neq \ell - 1$ whenever t is odd. Consider the field $K = \mathbb{F}_q$ and the unique subgroup S of K^{\times} of order $k := (q-1)/\ell$. Then by $G(p, \ell, t)$ we denote the graph with vertex set K and edge set $\{\{x, y\} \mid x, y \in K \text{ and } x - y \in S\}$. This is the undirected Cayley graph associated with (K, S). By A we denote the adjacency matrix of $G(p, \ell, t)$ with respect to some fixed but arbitrary ordering of the vertex set K. The Laplacian matrix L of $G(p, \ell, t)$ is the matrix kI - A.

Given an Integral domain \mathcal{R} , by \mathcal{R}^K we denote the \mathcal{R} -free module with $\{[x]|x \in K\}$ as a basis. Let μ_A , μ_L be endmorphisms of \mathcal{R}^K defined by $\mu_A([x]) := \sum_{s \in S} [x + s]$ and $\mu_L([x]) := k[x] - \sum_{s \in S} [x + s]$ respectively. The matrix representation of μ_L (respectively μ_A) with respect to the basis set $\{[x]|x \in K\}$ is the Laplacian matrix L (respectively A). The *critical* group C of $G(p, \ell, t)$ is the finite part of the cokernal of $\mu_L : \mathbb{Z}^K \to \mathbb{Z}^K$. Let C_p be the Sylow p-subgroup of C. Let $C_{p'}$ be the largest subgroup of C whose order is not divisible by p. As C is abelian, we have $C = C_p \oplus C_{p'}$.

3. Some properties of $G(p, \ell, t)$.

In section 2 of [24], the authors show that $G(p, \ell, t)$ is a strongly regular graph.

Theorem (van Lint-Schrijver). The graph $G(p, \ell, t)$ is a strongly regular graph with parameters

$$\left(q, \frac{q-1}{\ell}, \frac{q-3\ell+1+(-1)^{t+1}(\ell-1)(\ell-2)\sqrt{q}}{\ell^2}, \frac{q-\ell+1+(-1)^t(\ell-2)\sqrt{q}}{\ell^2}\right),$$

where $q = p^{(\ell-1)t}$. The eigenvalues of the adjacency matrix A of $G(p, \ell, t)$ are $k = \frac{q-1}{\ell}$, r_{χ_1} , $r_{\chi_{\alpha}}$, with multiplicities 1, k, and q - k - 1 respectively. Here $r_{\chi_{\alpha}} = \frac{-1 + (-1)^t \sqrt{q}}{\ell}$ and $r_{\chi_1} = r_{\chi_{\alpha}} + (-1)^{t+1} \sqrt{q}$.

We now give a brief sketch of the proof of the above given in §2 of [24]. We recall from §2 that $K = \mathbb{F}_q$ and *S* is the unique subgroup of K^{\times} of size *k*. Given $a \in S$, $b \in K$, $n \in \mathbb{Z}$, define $T_{(a,b,n)} : K \to K$ by $T_{(a,b,n)}(x) := ax^{p^n} + b$. Let *G* be the group of transformations $T_{(a,b,n)}$. The action of *G* on *K* is shown to be a permutation action of rank 3. It is also

shown that the orbits of the natural action of *G* on $K \times K$ are $\{(x, x) | x \in K\}$, $\Omega := \{(x, y) | x, y \in K \text{ and } x - y \in S\}$ and $\Delta := \{(x, y) | x, y \in K \text{ and } x - y \notin S \cup \{0\}\}$. The graph $G(p, \ell, t)$ is the graph with vertex set *K* and edge set Ω . Standard results on rank 3 permutation groups of even order show that $G(p, \ell, t)$ is a strongly regular graph.

Following notation in §2, we have $\mu_A([x]) = \sum_{s \in S} [x + s]$. Let \hat{K} be the group of complex valued characters of K. Given an additive character $\chi \in \hat{K}$, consider $[\chi] := \sum_{y \in K} \chi(y)[y]$ and $r_{\chi} = \sum_{s \in S} \chi(s)$. We have $\mu_A([\chi]) = r_{\chi}[\chi]$. By orthogonality of characters, we may observe that $\{[\chi] | \chi \in \hat{K}\}$ is a basis of \mathbb{C}^K and thus that all eigenvalues of μ_A are of the form r_{χ} for some additive character χ . Consider the character χ_1 defined by $\chi_1(x) := e^{\frac{2\pi iT(x)}{p}}$. It is a well-known result that every character χ is of the form $\chi = \chi_a$, where $\chi_a(x) = \chi_1(ax)$, for $a \in K$. Let α be a generator of K^{\times} . We observe that for all $s \in S$, we have $r_{\chi_s} = r_{\chi_1}$; and for all $b \notin S \cup \{0\}$, we have $r_{\chi_b} = r_{\chi_a}$. Thus the adjacency matrix has (at most) three eigenvalues $k = r_{\chi_0}, r_{\chi_1}, r_{\chi_a}$, with geometric multiplicities 1, |S| = k, and $q - k - 1 = |S \cup \{0\}|$ respectively. The parameters given in the Theorem above can now be deduced from the general theory of strongly regular graphs.

Now the eigenvalues of the Laplacian L = kI - A are 0, $u := k - r_{\chi_1}$ and $v := k - r_{\chi_a}$, with multiplicities 0, k, and q - k - 1 respectively. We can see that $v = \sqrt{q} \frac{\sqrt{q} + (-1)^{t+1}}{\ell}$ and $u = v + (-1)^t \sqrt{q}$. It is well known that the nullity of the Laplacian matrix of a graph is equal to the number of connected components. Clearly $v \neq 0$, and thus $G(p, \ell, t)$ is connected if and only if either t is even, or t is odd and $\sqrt{q} \neq \ell - 1$. We will assume throughout that $p^{(\ell-1)t/2} \neq \ell - 1$ whenever t is odd.

Given an element *a* in an unramified extension of of \mathbb{Q}_p , the *p*-adic valuation of *a* is denoted by $v_p(a)$. Let $v_p(\ell-1) = d$, then $v_p(u) = \frac{1}{2}(\ell-1)t + d$ and $v_p(v) = \frac{1}{2}(\ell-1)t$.

By Theorem 8.1.2 of [7], we have

$$L(L - (v + u)I) = vuI + \mu J,$$
 (3.1)

where $\mu = \frac{q - \ell + 1 + (-1)^t (\ell - 2) \sqrt{q}}{\ell^2}$. Observing that LJ = 0, we see that the minimal polynomial of *L* is (x)(x - u)(x - v) = 0. Therefore *L* is diagonalizable. As a consequence of Kirchhoff's Matrix-Tree Theorem (cf. [22]), the order of critical group of $G(p, \ell, t)$ is $\frac{u^k v^{q-k-1}}{q}$.

4. MAIN RESULTS

Let (p, ℓ) be a pair of primes with $\ell > 2$ and p primitive modulo ℓ . Given $t \in \mathbb{N}$, let $q = p^{(\ell-1)t}$ and $k = \frac{q-1}{\ell}$. Let C denote the critical group of $G(p, \ell, t)$. Let C_p be the Sylow p-subgroup of C. Let $C_{p'}$ be the largest subgroup of C whose order is not divisible by p. As C is abelian, we have $C = C_p \oplus C_{p'}$.

The following theorem describes the Sylow *p*-subgroup C_p of the critical group C of $G(p, \ell, t)$.

Theorem 1. Consider the graph $G(p, \ell, t)$ with $\sqrt{q} = p^{(\ell-1)t/2} \neq \ell - 1$ whenever t is odd. Let d denote $v_p(\ell - 1)$. Given integers a, b not divisible by q - 1, let c(a, b) denote the number of carries when adding the p-adic expansions of a and b (mod q - 1). Let L be the Laplacian matrix and let C be the critical group of $G(p, \ell, t)$. For $1 \le i \le k - 1$, let

$$\min(i) = \min(\{c(i + mk, nk) | 0 \le m \le \ell - 1 \text{ and } 0 < n \le \ell - 1\}).$$

Given a non-zero positive integer j, let e_j be the multiplicity of p^j as a p-elementary divisor of C. By e_0 we denote the p-rank of the Laplacian L of G(p, l, t). Then the following are true.

$$\begin{aligned} (1) \ e_0 &= |\{i \mid 1 \le i \le k - 1 \text{ and } \min(i) = 0\}| + 2 \text{ and } e_{(\ell-1)t+d} = |\{i \mid \min(i) = 0\}|\\ (2) \ e_j &= |\{i \mid 1 \le i \le k - 1 \text{ and } \min(i) = j\}| \text{ for } 0 < j < \frac{(\ell-1)t}{2}.\\ (3) \ e_j &= e_{(\ell-1)t+d-j} \text{ for } 0 < j < \frac{(\ell-1)t}{2}.\\ (4) \ If \ p \nmid \ell - 1, \text{ then } e_{\frac{(\ell-1)t}{2}} = q + 1 - 2\sum_{j < t} e_j.\\ (5) \ If \ p \mid \ell - 1, \text{ then } e_{\frac{(\ell-1)t}{2}} = k + 2 - \sum_{j < t} e_j \text{ and } (b) \ e_{\frac{(\ell-1)t}{2}} = (\ell-1)k - \sum_{j < t} e_j.\\ (6) \ e_j &= 0 \text{ for all other } j. \end{aligned}$$

We prove the above Theorem in §7.

In the case of G(p, 3, t), application of the transfer matrix method (cf. Section 4.7 of [21]) leads us to a recursive algorithm that outputs closed form expressions for multiplicities of *p*-elementary divisors of *C*. As a consequence, we also determine a closed form expression for the *p*-rank (i.e e_0 in the context of the Theorem above) of the Laplacian. The following theorem gives a quick recursive algorithm to compute *p*-elementary divisors. The proof of the following result is in §8.

Let
$$P = \left(\left(\frac{p+1}{3} \right)^2 (x^2y^2 + x^2y + xy^2 + x + y + 1) + \left(\frac{p-2}{3} \right)^2 3xy \right), R = p^2 x^3 y^3$$
 and
 $Q = \left(\left(\frac{p+1}{3} \right)^2 (xy)(x^2y^2 + x^2y + xy^2 + x + y + 1) + \left(\frac{2p-1}{3} \right)^2 3x^2 y^2 \right)$. We define the polynomial $C(2t) \in \mathbb{C}[x, y]$ recursively as follows:

$$C(2) = 2P$$

$$C(4) = 2(P^2 - 2Q),$$

$$C(6) = 6R + 2(P^3 - 2QP) - 2PQ,$$
and $C(2t) = PC(2t - 2) - QC(2t - 4) + RC(2t - 6)$ for $t > 3.$

$$(4.1)$$

Theorem 2. Let C_p be the Sylow p-subgroup of the critical group of the graph G(p, 3, t) (with $(p, t) \neq (2, 1)$). Given a non-zero positive integer j, let e_j be the multiplicity of p^j as a p-elementary divisor of C. By e_0 we denote the p-rank of the Laplacian L of G(p, 3, t). Let $e_{(a,b)}$ be the coefficient of $x^a y^b$ in C(2t). Then the following are true. (Here δ_{ij} is the Kronecker delta function.)

(1) $e_0 = e_{2t+\delta_{2,p}} + 2 = \left(\frac{(p+1)}{3}\right)^{2t} (2^{t+1} - 2).$ (2) For a < t, we have $e_a = e_{2t+\delta_{2,p}-a} = \sum_{a < b \le t} e_{(a,b)}$ (3) $e_{t+\delta_{2,p}} = (k+2-\sum_{j < t} e_j) + (1-\delta_{2,p})(2k-\sum_{j < t} e_j).$ (4) $e_t = (1-\delta_{2,p})(k+2-\sum_{j < t} e_j) + (2k-\sum_{j < t} e_j).$ (5) $e_a = 0$ for all other a.

Let *X* be the complex character table of *K* and *A* the adjacency matrix of $G(p, \ell, t)$. Then all the entries of *X* lie in $\mathbb{Z}[\zeta]$ for some primitive *p*th root of unity ζ . We have by character orthogonality $\frac{1}{q}XX^t = I$ and

$$\frac{1}{q}XAX^{t} = \operatorname{diag}(r_{\psi})_{\psi}, \tag{4.2}$$

where ψ runs over additive characters of K and r_{ψ} is as defined in §3. Note that r_{ψ} is an eigenvalue of A. We note that every prime $m \neq p$ is unramified in $\mathbb{Q}[\zeta]$. Let \mathfrak{m} be a prime lying over m, then the relation (4.2) shows similarity of matrices over the local PID $(\mathbb{Z}[\zeta])_{\mathfrak{m}}$. We can now conclude that L = kI - A is similar to diag $(0, \underbrace{u \dots u}_{k \text{ times } q-k-1 \text{ times }})$,

over $(\mathbb{Z}[\zeta])_{\mathfrak{m}}$, for all primes $m \neq p$. This similarity implies $(\mathbb{Z}[\zeta])_{\mathfrak{m}}$ -equivalence of matrices. We have now proved the following result.

Theorem 3. Consider the graph $G(p, \ell, t)$ with $p^{(\ell-1)t/2} \neq \ell - 1$. Let $C_{p'}$ be the largest subgroup of C whose order is not divisible by p. Then $C_{p'} \cong \left(\frac{\mathbb{Z}}{u'\mathbb{Z}}\right)^k \times \left(\frac{\mathbb{Z}}{v'\mathbb{Z}}\right)^{q-k-1}$. Here v' is the biggest divisor of $\sqrt{q} \frac{\sqrt{q} + (-1)^{t+1}}{\ell}$ that is coprime to p, and u' is the biggest divisor of $u = v + (-1)^t \sqrt{q}$ that is coprime to p.

Example 1. Implementing the Recursion in (4.1) in a computer algebra system such as Sage, we can compute C(8). Now application of Theorems 2 and 3 yield the critical groups of the family of graphs $(G(p, 3, 4))_p$, with p running over primes primitive (mod 3).

The 2-part of the critical group of G(2, 3, 4) is $\prod_{i=1}^{9} \left(\frac{\mathbb{Z}}{2^{i}\mathbb{Z}}\right)^{e_i}$, where $[e_i]_{i=1}^{9} = [32, 8, 16, 84, 1, 16, 8, 32, 28]$. The 2-complement of the critical group of G(2, 3, 4) is $\mathbb{Z}/15\mathbb{Z}$.

The Sylow *p*-subgroup of the critical group of G(p, 3, 4) (with $p \neq 2$) $\prod_{i=1}^{8} \left(\frac{\mathbb{Z}}{p^{i}\mathbb{Z}}\right)^{e_{i}(p)}$, where

(1)
$$e_8(p) = 510 \left(\frac{(p+1)}{3}\right)^8 - 2,$$

- (2) $e_1(p) = e_7(p) = 256/6561p^8 + 1040/6561p^7 + 1120/6561p^6 784/6561p^5 2240/6561p^4 784/6561p^3 + 1120/6561p^2 + 1040/6561p + 256/6561$,
- (3) $e_2(p) = e_6(p) = 776/6561p^8 + 592/6561p^7 2248/6561p^6 1904/6561p^5 + 320/6561p^4 1904/6561p^3 2248/6561p^2 + 592/6561p + 776/6561$,
- (4) $e_3(p) = e_5(p) = 304/2187p^8 448/2187p^7 128/2187p^6 + 608/2187p^5 32/2187p^4 + 608/2187p^3 128/2187p^2 448/2187p + 304/2187,$
- (5) and $e_4(p) = 871/2187p^8 352/2187p^7 + 448/2187p^6 544/2187p^5 56/2187p^4 544/2187p^3 + 448/2187p^2 352/2187p + 871/2187$.

The *p*-complement of the critical group of G(p, 3, 4) (with $p \neq 2$) is $\mathbb{Z}/u'v'\mathbb{Z}$, where $u' = \frac{p^4 - 1}{3}$ and $v' = \frac{p^4 + 2}{3}$.

Remark. For a fixed t, Theorem 2 implies that the multiplicities of the p-elementary divisors of the Laplacian of G(p, 3, t) are polynomial expressions in p of degree 2t. We were however unable to extend the techniques in §8 to prove similar results in the general case.

5. Smith Normal Form

Let \mathfrak{R} be a Principal Ideal Domain, $\mathfrak{p} \in \mathfrak{R}$ a prime, and $Z : \mathfrak{R}^m \to \mathfrak{R}^n$ be a linear transformation. By the structure theorem for finitely generated modules over PIDs, we have $\{\alpha_i\}_{i=1}^s \subset \mathfrak{R} \setminus \{0\}$ such that $\alpha_i \mid \alpha_{i+1}$ and

$$\operatorname{coker}(Z) \cong \mathfrak{R}^{n-s} \oplus \bigoplus_{i=1}^{s} \mathfrak{R}/\alpha_i \mathfrak{R}.$$

Let [Z] denote the matrix representation of Z with respect to the standard basis. Then the above equation tells us that we can find $P \in GL_n(\mathfrak{R})$, and $Q \in GL_m(\mathfrak{R})$ such that

$$P[Z]Q = \begin{bmatrix} Y & 0_{(s \times n-s)} \\ \hline 0_{(m-s \times s)} & 0_{(n-s \times n-s)} \end{bmatrix},$$

where $Y = \text{diag}(\alpha_1 \dots \alpha_s)$. The diagonal form P[Z]Q is called the Smith normal form of Z. Its uniqueness (up to multiplication of α_i by units) is also guaranteed by the aforementioned structure theorem. By invariant factors (elementary divisors) of Z, we mean the invariant factors (respectively elementary divisors) of the module coker(Z).

The following is a well known result (for eg. see Theorem 2.4 of [22]) that gives a description of the Smith normal form in terms of minor determinants.

Lemma 4. Let Z, [Z], and $\{\alpha_i\}_{1 \le i \le s}$ be as described above. Given $1 \le i \le s$, let $d_i(Z)$ be the GCD of all $i \times i$ minor determinants of [Z], and let $d_0(Z) = 1$. We then have $\alpha_i = d_i([Z])/d_{i-1}([Z])$.

Define $e_j(Z) = |\{\alpha_i | v_p(\alpha_i) = j\}|$. Now $e_j(Z)$ is the multiplicity of p^j as p-elementary divisors of the \Re -module coker(*Z*). If $R = \mathbb{Z}$, then $e_j(Z)$ is the multiplicity of p^j as an elementary divisor of the abelian group coker(*Z*).

Let $\mathfrak{R}_{\mathfrak{p}}$ be the p-adic completion of \mathfrak{R} . We have

$$\mathfrak{R}_{\mathfrak{p}}^{n}/T(\mathfrak{R}_{\mathfrak{p}}^{m}) \cong \mathfrak{R}_{\mathfrak{p}}^{n-s} \oplus \bigoplus_{i \geq 0} \left(\mathfrak{R}_{\mathfrak{p}}/\mathfrak{p}^{j}\mathfrak{R}_{\mathfrak{p}}\right)^{e_{j}(\mathfrak{p})}.$$

Define $M_j(Z) := \{x \in \mathfrak{R}_p^m | Z(x) \in \mathfrak{p}^j \mathfrak{R}_p^n\}$. We have $\mathfrak{R}^m = M_0(Z) \supset M_1(Z) \supset \ldots \supset M_n(Z) \supset \cdots$.

Let $\mathbb{F} = \Re_{\mathfrak{p}}/\mathfrak{p}\mathfrak{R}_{\mathfrak{p}}$. If $M \subset \mathfrak{R}_{\mathfrak{p}}^m$ is a submodule, define $\overline{M} = (M + \mathfrak{p}\mathfrak{R}_{\mathfrak{p}}^m)/\mathfrak{p}\mathfrak{R}_{\mathfrak{p}}^m$. Then \overline{M} is an \mathbb{F} -vector space. The following Lemma follows from the structure theorem.

Lemma 5. $e_j(Z) := \dim(\overline{M_j(Z)}/\overline{M_{j+1}(Z)}).$

So we have,

$$\dim(\overline{M_j(Z)}) - \dim(\overline{\ker(Z)}) = \sum_{t \ge j} e_t(Z).$$
(5.1)

The following is Lemma 3.1 of [11]. We include a short proof for the convenience of the reader.

Lemma 6. Let Z, \mathfrak{p} , $M_i(Z)$, and $e_i(Z)$ be as defined above. Let $\kappa(Z)$ be the \mathfrak{p} -adic valuation of the product of a complete set of non-zero invariant factors of Z, counted with multiplicities. Suppose that we have two sequences of integers $0 < t_1 < t_2 \dots < t_j$ and $s_1 > s_2 \dots > s_j > s_{j+1} = \dim(\ker(Z))$ satisfying the following conditions.

(1) $\dim(\overline{M_{t_i}(Z)}) \ge s_i \text{ for } 1 \le i \le j$

(2)
$$\kappa(Z) = \sum_{i=1}^{J} (s_i - s_{i+1})t_i$$
,

Then the following hold.

(a) $e_0(Z) = m - s_1$. (b) $e_{t_i}(Z) = s_i - s_{i+1}$. (c) $e_a(Z) = 0$ for $a \notin \{t_1 \dots t_i, \dots t_j\}$.

Proof. We have

$$\kappa(Z) = \sum_{i \ge 1} ie_i(Z) \ge \sum_{k=1}^{j-1} \left(\sum_{t_k \le i < t_{k+1}} ie_i(Z) \right) + \sum_{i \ge t_j} ie_i(Z) \ge \sum_{k=1}^{j-1} \left(t_k \sum_{t_k \le i < t_{k+1}} e_i(Z) \right) + t_j \sum_{i \ge t_j} e_i(Z).$$
(5.2)

Application of equation (5.1) given above yields

$$\sum_{k=1}^{j-1} \left(t_k \sum_{t_k \le i < t_{k+1}} e_i(Z) \right) + t_j \sum_{i \ge t_j} e_i(Z) = \sum_{k=1}^{j-1} \left(t_k (\dim(\overline{M_{t_k}(Z)}) - \dim(\overline{M_{t_{k+1}}(Z)})) \right) + t_j \left(\dim(\overline{M_{t_j}(Z)}) - \dim(\overline{\ker(Z)}) \right).$$

Now application of conditions (1) and (2) in the statement gives us

$$\sum_{k=1}^{J-1} \left(t_k(\dim(\overline{M_{t_k}(Z)}) - \dim(\overline{M_{t_{k+1}}(Z)})) \right) + t_j\left(\dim(\overline{M_{t_j}(Z)}) - \dim(\overline{\ker(Z)})\right) \ge \sum_{i=1}^{J} (s_i - s_{i+1})t_i = \kappa(Z).$$
(5.3)

So the inequations (5.2) and (5.3) are in fact equations and thus the lemma follows.

The following result is 12.8.4 of [7].

Lemma 7. Let $Z : \mathbb{R}^n \to \mathbb{R}^n$ be a linear transformation and $\phi \in \mathbb{R}$ be an eigenvalue for Z, with geometric multiplicity c. Then $\dim(\overline{M_{\nu_n(\phi)}}(Z)) \ge c$.

Proof. Let Fr(R) be the field of fractions of \mathfrak{R}_p . We can extend Z to a unique element of $\operatorname{End}_{Fr(R)}(Fr(R)^n)$. For convenience, let us denote this element by Z as well. Consider the eigenspace $V_{\phi} = \{x \in Fr(R)^n | Z(x) = \phi x\}$. Then $V_{\phi} \cap \mathfrak{R}_p^n$ is a pure \mathfrak{R}_p -submodule $(\mathfrak{R}_p$ -direct summand) of \mathfrak{R}_p^n of rank $c = \dim(V_{\phi})$. It is clear that $V_{\phi} \cap \mathfrak{R}_p^n \subset M_d(Z)$. As $V_{\phi} \cap \mathfrak{R}_p^n$ is pure, we have $\overline{V_{\phi} \cap \mathfrak{R}_p^n} \subset \overline{M_{\nu_p(\phi)}(Z)}$.

6. Character sums and block diagonal form of L.

We recall the definition of the graph $G(p, \ell, t)$, its adjacency matrix A and Laplaicain matrix L. This is the graph with vertex set $K = \mathbb{F}_q$ (with $q = p^{(\ell-1)t}$) and edge set $\{\{x, y\} \mid x, y \in K \text{ and } x - y \in S\}$, where S is the subgroup of K^{\times} with index ℓ . By C, we denote the critical group of $G(p, \ell, t)$. We saw in §3 that L has eigenvalues $0, v = \sqrt{q} \frac{\sqrt{q} + (-1)^{t+1}}{\ell}$ and $u = v + (-1)^t \sqrt{q}$, with multiplicities 1, q - k - 1 and k respectively.

Let ξ be a primitive (q - 1)-st root of unity in the algebraic closure of \mathbb{Q}_p . Then $\mathbb{Q}_p(\xi)$ is the unique unramified extension of degree $(\ell - 1)t$ over \mathbb{Q}_p . Let R be the ring of integers in $\mathbb{Q}_p(\xi)$, then pR is maximal in R with $R/pR \cong \mathbb{F}_q = K$. Let R^K denote the free R-module with $\{[x] | x \in K\}$ as a basis set. We recall from §2, endomorphisms $\mu_A, \mu_L \in \text{End}_R(R^K)$, with matrix representations (with respect to $\{[x] | x \in K\}$) A and L respectively. We have $\mu_L([x]) = k[x] - \sum_{s \in S} [x + s]$ and $\mu_A([x]) = \sum_{s \in S} [x + s]$, $x \in K$. As R is an unramified extension of \mathbb{Z}_p , the multiplicity of p^j as an

elementary divisor of μ_L is the same as that of p^j as an elementary divisor of the integer matrix L.

Let $T : K^{\times} \to R^{\times}$ be the Teichmüller character generating the cyclic group Hom (K^{\times}, R^{\times}) . Then K^{\times} acts R^{K} , which decomposes as the direct sum $R[0] \oplus R^{K^{\times}}$. Now the regular module $R^{K^{\times}}$ decompose further into a direct sum of K^{\times} -invariant submodules of rank 1, affording the characters T^{i} , $i = 0, \ldots, q - 2$. The component affording T^{i} is spanned by $f_{i} := \sum_{x \in K^{\times}} T^{i}(x^{-1})[x]$. Therefore $\{1, f_{1} \ldots f_{q-2}, [0]\}$ is a basis for R^{K} , where $\mathbf{1} := f_{0} + [0] = \sum_{x \in K} [x]$.

Given an *R*-free *RS*-module *M* and a character $\chi : S \to R^{\times}$, the isotypic component of *M* corresponding to χ is the *RS*-submodule $M_{\chi} := \{m \in M | sm = \chi(s)m \text{ for all } s \in S\}$. For $0 < j \le k - 1$, let N_j denote the *R*-submodule of R^K with $\{f_{j+mk} \mid 0 \le m \le \ell - 1\}$ as a basis set. Define N_0 to be the *R*-submodule of \mathbb{R}^K with $\{\mathbf{1}, [0], f_k, \dots, f_{(\ell-1)k}\}$ as a basis set. Then N_i is the isotypic component for the character $T^i|_S$ of the group S. We now have

$$R^{K} = N_0 \oplus N_1 \dots \oplus N_{k-1}. \tag{6.1}$$

Since S is a group of automorphisms for $G(p, \ell, t)$, the R-linear maps μ_A and μ_L are in fact RS-module endomorphisms. It follows that μ_A and μ_L preserve the decomposition (6.1). For $0 < i \le k - 1$, let L_i denote the matrix of $\mu_L|_{N_i}$ with respect to the ordered basis $(f_{i+mk}| 0 \le m \le \ell - 1)$. Let L_0 be the matrix of $\mu_L|_{N_0}$ with respect to the ordered basis $(1, [0], f_k, \dots, f_{(\ell-1)k})$. So with respect to the ordered basis $(1, [0], f_k, \dots, f_{(\ell-1)k}) \cup_{i=1}^{k-1} (f_{i+mk}| 0 \le m \le \ell - 1)$, the matrix representation of the *R*-linear map μ_L is diag $(L_0, L_1, \ldots, L_{k-1})$. We proved the following Lemma.

Lemma 8. As *R*-matrices, *L* is similar to the block diagonal matrix $diag(L_0, L_1, \ldots, L_{k-1})$.

Following conventions in [1], we extend the T^{i} 's to K. As per this convention, the character T^{0} maps every element of K to 1, while T^{q-1} maps 0 to 0. All other characters map 0 to 0. For two integers a, b the Jacobi sum $J(T^a, T^b)$ is $\sum_{x \in K} T^a(x)T^b(1-x)$. We refer the reader to Chapter 2 of [3] for formal properties of Jacobi sums. Following the

conventions established, for $a \neq 0 \pmod{(q-1)}$, we have $J(T^a, T^0) = 0$ and $J(T^a, T^{q-1}) = -1$.

The following Lemma describes action of L_i on N_i .

Lemma 9. (1) If
$$k \nmid i$$
, we have $\mu_L(f_i) = \frac{1}{\ell} \left(qf_i - \sum_{m=1}^{\ell-1} J(T^{-i}, T^{-mk}) f_{i+mk} \right)$.
(2) For $1 \leq j \leq \ell - 1$, we have $\mu_L(f_{jk}) = \frac{1}{\ell} \left(\mathbf{1} + qf_{jk} - \sum_{m \neq -j,0} J(T^{-jk}, T^{-mk}) f_{jk+mk} - q[0] \right)$.
(3) $\mu_L([0]) = \frac{1}{\ell} \left(q[0] - \sum_{m=1}^{\ell-1} f_{mk} - \mathbf{1} \right)$.
(4) $\mu_L(\mathbf{1}) = 0$.

Proof. For $x \in K$, we have $\mu_A[x] = \sum_{y \in S} [x + y]$. Let δ_S denote the characteristic function of *S*, treated as a subset of *K*. We now have $\mu_A[x] = \sum_{z \in K} \delta_S(z - x)[z]$.

Writing δ_S as a linear combination of characters of S, we have $\delta_S = \frac{1}{\ell} \left(\sum_{m=0}^{\ell-1} T^{mk} - \delta_0 \right)$. Here δ_0 is 1 at 0 and 0 elsewhere.

We have

$$\ell\mu_{A}(f_{i}) = \ell\mu_{A}\left(\sum_{x\in K^{\times}} T^{-i}(x)[x]\right)$$

= $\ell\sum_{x\in K^{\times}} T^{-i}(x)\sum_{z\in K} \delta_{S}(z-x)[z]$
= $\sum_{x\in K^{\times}} T^{-i}(x)\sum_{z\in K} T^{0}(z-x)[z] + \sum_{m=1}^{\ell-1} \sum_{x\in K^{\times}} T^{-i}(x)\sum_{z\in K} T^{mk}(z-x)[z] - \sum_{x\in K^{\times}} T^{-i}(x)\sum_{z\in K^{\times}} \delta_{0}(z-x)[z].$ (6.2)

From definition of f_i and δ_0 , we have $\sum_{x \in K^{\times}} T^{-i}(x) \sum_{z \in K^{\times}} \delta_0(z-x)[z] = f_i$. We recall from character theory that for a character χ of K^{\times} ,

$$\sum_{x \in K^{\times}} \chi(x) = \begin{cases} q - 1 \text{ if } \chi \text{ is trivial, and} \\ 0 \text{ otherwise.} \end{cases}$$
(6.3)

Using (6.3), we see that

$$\sum_{x \in K^{\times}} T^{-i}(x) \sum_{z \in K^{\times}} T^{0}(z-x)[z] = \left(\sum_{x \in K^{\times}} T^{-i}(x)\right) \left(\sum_{z \in K} [z]\right) = 0$$
(6.4)

We now turn our attention to $\sum_{x \in K^{\times}} T^{-i}(x) \sum_{z \in K} T^{mk}(z-x)[z]$, with $1 \le m \le \ell - 1$. We have

$$\sum_{eK^{\times}} T^{-i}(x) \sum_{z \in K} T^{mk}(z-x)[z] = \sum_{(x,z) \in K^{\times} \times K^{\times}} T^{-i}(x) T^{mk}(z-x)[z] + \sum_{x \in K^{\times}} T^{-i}(x) T^{mk}(-x)[0]$$
(6.5)

For $z \in K^{\times}$, we have $T^{-i}(x)T^{mk}(z-x) = T^{i}(z^{-1})T^{mk}(z)T^{-i}((x/z))T^{mk}(1-(x/z))$. Now, we have

$$\sum_{(x,z)\in K^{\times}\times K^{\times}} T^{-i}(x)T^{mk}(z-x)[z] = \sum_{(x,z)\in K^{\times}\times K^{\times}} T^{i}(z^{-1})T^{mk}(z)T^{-i}((x/z))T^{mk}(1-(x/z))[z]$$
$$= \sum_{(y,z)\in K^{\times}\times K^{\times}} T^{i-mk}(z^{-1})T^{-i}(y)T^{mk}(1-y)[z]$$
$$= \left(\sum_{y\in K^{\times}} T^{-i}(y)T^{mk}(1-y)\right) \times \left(\sum_{z\in K^{\times}} T^{i-mk}(z^{-1})[z]\right)$$
$$= J(T^{-i}, T^{mk})f_{i-mk}.$$

Using the above equality along with (6.2), (6.4), (6.5), we have

$$\ell\mu_A(f_i) = \sum_{m=0}^{\ell-1} J(T^{-i}, T^{mk}) f_{i-mk} + \sum_{m=1}^{\ell-1} \sum_{x \in K^{\times}} T^{-i}(x) T^{mk}(-x) [0] - f_i$$
(6.6)

As $-1 \in S$ and $[K^{\times} : S] = k$, we have $T^{mk}(-x) = T^{mk}(x)$. Thus the middle sum above is $\left(\sum_{x=1}^{\ell-1} \sum_{x \in K^{\times}} T^{i-mk}(x)\right)[0]$. Using this along with (6.3) in (6.6), we conclude that

a) if $k \nmid i$, we have $\ell \mu_A(f_i) = \sum_{m=1}^{\ell-1} J(T^{-i}, T^{-mk}) f_{i+mk} - f_i$, and; b) for $1 \le j \le \ell - 1$, we have $\ell \mu_A(f_{jk}) = \sum_{m=1}^{\ell-1} J(T^{-jk}, T^{mk}) f_{jk-mk} + (q-1)[0] - f_{jk}$.

Using L = kI - A now readily yields (1). From the general theory of Jacobi sums, we have for any character λ , $J(\lambda, \lambda^{-1}) = -\lambda(-1)$. Since $-1 \in S$, we have $T^{jk}(-1) = 1$, and therefore we have $J(T^{-mk}, T^{mk}) = -1$. Thus $\ell \mu_A(f_{jk}) = -1$. $\sum_{m=1}^{\ell-1} J(T^{-jk}, T^{mk}) f_{jk-mk} + (q-1)[0] - f_{jk} = \sum_{m \neq -j, 0} J(T^{-jk}, T^{mk}) f_{jk-mk} - \mathbf{1} + q[0].$ Now the (2) follows by using L = KI - A. П

The proof of the remaining statements is straight forward.

We observed in §3 that L is diagonalizable and thus so are L_i 's. We recall from §3 that the eigenvalues of L are 0, u and v, with multiplicities 1, k and $(\ell - 1)k$ (same as q - k - 1), respectively. Again from §3 we know that the nullity of L is 1. Now since the nullity of L_0 is 1 (c.f Lemma 9), all other L_i 's are invertible. It follows that for $i \neq 0$, the characteristic polynomial of L_i is a polynomial of the form $(x - u)^a (x - v)^b$ with $a + b = \ell$. By Lemma 9 and diagonalizability of L_i , we have $q = tr(L_i) = au + bv$. It now follows that a = 1 and $b = \ell - 1$. By similar arguments, we may show that the eigenvalues of L_0 are 0, u and v with geometric multiplicities 1, 1 and $\ell - 1$, respectively. We have proved the following Lemma.

Lemma 10. (1) For $i \neq 0$, the eigenvalues of L_i are u and v with geometric multiplicities 1 and $\ell - 1$, respectively. (2) The eigenvalues of L_0 are 0, u and v with geometric multiplicities 1, 1 and $\ell - 1$, respectively.

7. The Sylow *p*-subgroup of the critical group of $G(p, \ell, t)$

By Lemma 8, it is clear that finding the elementary divisors of *R*-matrices L_i's will determine the *p*-elementary divisors of the critical group. As ℓ is a unit in R, the Smith normal form of L_i is the same as that of ℓL_i . Lemma 9 shows that the any entry of ℓL_i is either q or is a Jacobi sum of the form $J(T^{-(i+mk)}, T^{-nk})$, where $0 \le m \le \ell - 1$ and $0 < n \le \ell - 1$. In the context of Lemma 4, it is worth investigating the *p*-adic valuations of Jacobi sums.

An integer a not divisible by q-1 has, when reduced modulo q-1, a unique p-digit expansion $a \equiv a_0 + a_1p + a_2p +$ $\dots + a_{(\ell-1)t-1}p^{(\ell-1)t-1} \pmod{q-1}$, where $0 \le a_i \le p-1$. We represent this expansion by the tuple of digits $(a_0,\ldots,a_i,\ldots,a_{(\ell-1)t-1})$. By s(a) we denote the sum $\sum a_i$. For example, 1 has the expansion $(1,\ldots,0,\ldots,0)$ and s(1) = 1.

Applying Stickelberger's theorem on Gauss Sums [23] and the well know relation between Gauss and Jacobi sums we can deduce the following theorem.

Theorem 11. Let q be a power of a prime p and let a and b be integers not divisible by q - 1. If $a + b \not\equiv 0 \pmod{q-1}$, then we have

$$v_p(J(T^{-a}, T^{-b})) = \frac{s(a) + s(b) - s(a+b)}{p-1}.$$

In other words, the p-adic valuation of $J(T^{-a}, T^{-b})$ is equal to the number of carries, when adding p-expansions of a and b modulo q - 1.

Given $b \in \mathbb{Z}$, by [b] denote the unique positive integer less than ℓ satisfying $b \equiv [b] \pmod{\ell}$. We can now see that

$$k = \frac{q-1}{\ell}$$

= $\frac{p^{\ell-1}-1}{\ell} \times \frac{p^{(\ell-1)t}-1}{p^{\ell-1}-1}$
= $\sum_{i=0}^{\ell-2} \left(\frac{[p^i]p-[p^{i+1}]}{\ell}\right) p^{\ell-2-i} \times \sum_{i=0}^{t-1} p^{(\ell-1)i}.$

Thus in the notation we adopted, the tuple for k is the tuple in which the string

$$\left(\frac{[p^{\ell-2}]p-1}{\ell},\ldots,\frac{[p^i]p-[p^{i+1}]}{\ell},\ldots,\frac{p-[p]}{\ell}\right)$$

repeats *t* times. As *p* is primitive modulo ℓ , we have $\{[p^i]|0 \le i \le \ell - 2\} = \{1, 2, \dots, \ell - 1\}$. We can now conclude that $s(k) = t \sum_{i=0}^{\ell-2} \left(\frac{[p^i]p - [p^{i+1}]}{\ell}\right) = \frac{(\ell-1)t}{2}(p-1).$

Now for $0 \le i, j \le \ell - 1$, we can find $r_{i,j} \in \mathbb{Z}$ such that $[p^i][p^j] = [p^{i+j}] + r_{i,j}\ell$. Given any $m \in \{1, 2, \dots, \ell - 1\}$, as p is primitive (mod ℓ), there is a positive integer j such that $[p^j] = m$. We have $mk = \left([p^j]\frac{p^{\ell-1}-1}{\ell}\right) \times \frac{p^{(\ell-1)\ell}-1}{p^{\ell-1}-1}$. Now we have

$$\begin{split} \left([p^{j}] \frac{p^{\ell-1}-1}{\ell} \right) &= \sum_{i=0}^{\ell-2} [p^{j}] \left(\frac{[p^{i}]p - [p^{i+1}]}{\ell} \right) p^{\ell-2-i} \\ &= \sum_{i=0}^{\ell-2} \left(\frac{[p^{i+j}]p + pr_{i,j}\ell - [p^{i+1+j}] - r_{i+1,j}\ell}{\ell} \right) p^{\ell-2-i} \\ &= \sum_{i=0}^{\ell-2} \left(\frac{[p^{i+j}]p - [p^{i+1+j}]}{\ell} \right) p^{\ell-2-i} + \sum_{i=0}^{\ell-2} r_{i,j}p^{\ell-1-i} - \sum_{i=0}^{\ell-2} r_{i+1,j}p^{\ell-2-i} \\ &= \sum_{i=0}^{\ell-2} \left(\frac{[p^{i+j}]p - [p^{i+1+j}]}{\ell} \right) p^{\ell-2-i} + r_{0,j}p^{\ell-1} - r_{\ell-1,j}. \end{split}$$

As $r_{0,j} = r_{\ell-1,j} = 0$, from the above computation we observe that

$$\left([p^{j}]\frac{p^{\ell-1}-1}{\ell}\right) \times \frac{p^{(\ell-1)t}-1}{p^{\ell}-1} = \sum_{i=0}^{\ell-2} \left(\frac{[p^{i+j}]p-[p^{i+1+j}]}{\ell}\right) p^{\ell-2-i} \times \sum_{i=0}^{t-1} p^{(\ell-1)i}$$

Thus in the notation we adopted, the tuple for $[p^{j}]k$ is the tuple in which the string

$$\left(\frac{[p^{\ell+j-2}]p-1}{\ell}, \dots, \frac{[p^{i+j}]p-[p^{i+j+1}]}{\ell}, \dots, \frac{[p^j]p-[p^{j+1}]}{\ell}\right)$$

repeats t times. So the digits of $mk = [p^j]k$ can be obtained by permuting the digits of k, and thus $s(mk) = s(k) = \frac{(\ell-1)t}{2}(p-1)$.

Given *a*, *b* as described in the theorem above, by c(a, b) we denote $v_p(J(T^{-a}, T^{-b}))$. Then by Lemma 9 the offdiagonal entries of L_i (with $i \neq 0$) are $u_{mn}p^{c(i+mk,nk)}$ for some units u_{mn} of *R*, and the diagonal entries are all q/ℓ . Lemma 10 shows that L_i satisfies (x - u)(x - v) = 0. We make use of this to arrive at the following lemma.

Lemma 12. Given $j < \frac{(\ell-1)t}{2}$ and $0 < i \le k-1$, the multiplicity of p^j as an elementary divisor of L_i is the same as that of $p^{v_p(uv)-j}$.

Proof. As L_i satisfies (x - u)(x - v) = 0, we have $(L_i)(L_i - (v + u)I) = vuI$. Let *P* and *Q* be *R*-matrices such that PL_iQ is the Smith normal form of L_i . Now consider $PL_iQQ^{-1}(L_i - (v + u)I)P^{-1} = vuI$. This shows that the multiplicity of $p^{v_p(uv)-j}$ as an elementary divisor of L_i is the same as the multiplicity of p^j as an elementary divisor of $L_i - (v + u)I$. Since L_i and $L_i - (u + v)I$ are congruent modulo $p^{v_p(v)} = p^{(\ell-1)t/2}$, for $0 \le j < (\ell - 1)t/2$, the multiplicity of p^j as an elementary divisor of $L_i - (v + u)I$.

We now compute the Smith normal forms of L_i 's.

Lemma 13. (i) For
$$0 < i \le \ell - 1$$
, the Smith normal form of L_i over R is the diagonal matrix
 $\operatorname{diag}(p^{\min(i)}, \underbrace{p^{(\ell-1)t/2}, \ldots, p^{(\ell-1)t/2}}_{(\ell-2) \text{ repetitions}}, p^{v_p(uv) - \min(i)}).$
Here $\min(i) = \min(\{c(i + mk, nk)| 0 \le m \le \ell - 1 \text{ and } 0 < n \le \ell - 1\}).$
(ii) The Smith normal form of L_0 over R is $\operatorname{diag}(1, 1, p^{(\ell-1)t/2}, p^{v_p(u)}, 0).$

Proof. Given an *R*-matrix *X*, by $\kappa(X)$, we denote the *p*-adic valuation of the product of a complete set of non-zero invariant factors of *X*, counted with multiplicities. By the notation in §5, $e_i(X)$ denotes the multiplicity of p^i as an elementary divisor of *X*. Following the notation in §5, we consider the vector spaces $\overline{M_y(X)}$ with $y \in \mathbb{Z}_{\geq 0}$. We use Lemma 6 to prove our results.

As a consequence of Kirchhoff's Matrix-Tree theorem, we have $\kappa(L) = v_p(|C|) = v_p\left(\frac{u^{k}v^{q-k-1}}{q}\right) = kv_p(u) + (\ell - 1)kv_p(v) - v_p(q)$. Lemma 10 implies that for $i \neq 0$, we have $\kappa(L_i) = v_p(\det(L_i)) = v_p(u) + (\ell - 1)v_p(v)$. Application of Lemma 8 gives us $\kappa(L_0) = \kappa(L) - \sum_{i\neq 0} \kappa(L_i) = v_p(u) + (\ell - 3)v_p(v)$.

(i) By Theorem 11, we have $c(i + mk, nk) + c(i + (m + n)k, (\ell - n)k) = (\ell - 1)t$. We can now conclude that $\min(i) \le (\ell - 1)t/2$. Let $\operatorname{diag}(\beta_1, \beta_2, \dots, \beta_\ell)$ be the Smith normal form of L_i . Then by Lemma 9 and Lemma 4, it follows that $\min(i) = v_p(\beta_1)$. By definition of $M_{\min(i)}(L_i)$ it follows that $M_{\min(i)}(L_i) = N_i$ and thus $\dim(\overline{M_{\min(i)}(L_i)}) = \ell$. First we assume that $\min(i) < (\ell - 1)t/2$. In this case, by Lemma 12 we have $e_{v_p(uv)-\min(i)}(L_i) = e_{\min(i)}(L_i) \ge 1$ and thus $\dim(\overline{M_{v_p(uv)-\min(i)}(L_i)}) \ge 1$. Lemma 10 tell us that geometric multiplicity of v as an eigenvalue of L_i is $\ell - 1$. Now Lemma 7 implies that $\dim(\overline{M_{(\ell-1)t/2}(L_i)}) \ge \ell - 1$. Applying (5.1), we have $\dim(\overline{M_{\min(i)}(L_i)}) - \dim(\overline{M_{(\ell-1)t/2}(L_i)}) = \sum_{\substack{\sum \\ \min(i) \le j < (\ell-1)t/2}} e_j(L_i) \ge 1$, and thus $\dim(\overline{M_{\min(i)}(L_i)}) \ge \ell$. Therefore by Lemma 6, setting j = 3, $s_1 = \ell$, $s_2 = \ell - 1$, $s_3 = \min(i) \le j < (\ell-1)t/2$.

1, $s_4 = \overline{\ker(L_i)} = 0$, $t_1 = \min(i)$, $t_2 = (\ell - 1)t/2$, and $t_3 = v_p(uv) - \min(i)$, we have $e_{\min(i)}(L_i) = e_{v_p(uv) - \min(i)}(L_i) = 1$, $e_{(\ell-1)t/2}(L_i) = \ell - 2$, and $e_i(L_i) = 0$ for all other *i*. Now assume that $\min(i) = (\ell - 1)t/2$. Lemma 7 implies that $\dim(\overline{M_{v_p(u)}(L_i)}) \ge 1$, since *u* is an eigenvalue of multiplicity 1. Therefore by Lemma 6, setting j = 2, $s_1 = \ell$, $s_2 = 1$, $s_3 = \overline{\ker(L_i)}$, $t_1 = \min(i) = (\ell - 1)t/2$, and $t_2 = v_p(u) = v_p(uv) - (\ell - 1)t/2$, we have $e_{(\ell-1)t/2}(L_i) = \ell - 1$, $e_{v_p(uv) - \min(i)}(L_i) = 1$, and $e_i(L_i) = 0$ for all other *i*. Thus we have (i).

(ii) By Lemma 9 and Theorem 11, there are units $v_{(mn)}$ in R such that the matrix ℓL_0 is

The determinant of the 2 × 2 minor $\begin{bmatrix} q & -1 \\ 1 & -1 \end{bmatrix}$ of ℓL_0 is a unit in *R*. Observe that any 3 × 3 minor of ℓL_0 has *p*-valuation of atleast $v_p(q)$. Now applying Lemma 4 yields that the multiplicity of $p^0 = 1$ as an elementary divisor of L_0 is 2, that is $e_0(L_0) = 2$. Now Lemma 5 implies that $\dim(\overline{M_0(L_0)}) - \dim(\overline{M_1(L_0)}) = 2$, and thus we have $\dim(\overline{M_1(L_0)}) = \ell + 1 - 2 = \ell - 1$. By Lemma 10 and Lemma 7, we have $\dim(\overline{M_{v_p(v)}(L_0)}) \ge \ell - 1$. Since $\overline{M_1(L_0)} \supset \overline{M_{v_p(v)}(L_0)}$, we have $\dim(\overline{M_{v_p(v)}(L_0)}) \ge \ell - 1$. Lemma 9 implies that $\operatorname{im}(L_0)$ is generated by 1 and $\sum_{j\neq 0} f_{jk} + 1$. Therefore $\dim(\operatorname{im}(L_0)) = 2$. As LJ = 0, by (3.1) the restriction of L to $\operatorname{im}(L)$ satisfies L(L - v + uI) = vuI. As $\operatorname{im}(L_0) \subset \operatorname{Im}(L)$, we can conclude that $\operatorname{im}(L_0) \subset \overline{M_{v_p(uv)}(L_0)} \subset \overline{M_{v_p(uv)}(L_0)}$.

We have $\kappa(L_0) = v_p(v)(\ell - 1 - 2) + v_p(u)(2 - 1) = \frac{(\ell - 1)t}{2}(\ell - 1 - 2) + v_p(u)(2 - 1)$. Now application of Lemma 6 yields (ii).

7.1. **Proof of Theorem 1.** Lemma 8 shows the Laplacian matrix L is similar over R to the block diagonal matrix

If $p \nmid \ell - 1$, we have $d = v_p(\ell - 1) = 0$ and $v_p(u) = \frac{(\ell-1)t}{2} = v_p(v) = v_p(uv) - \frac{(\ell-1)t}{2}$. From (5.1), we have $q - 1 = \sum_{j \neq \frac{(\ell-1)t}{2}} e_j + e_{\frac{(\ell-1)t}{2}}$. Now application of (1) and (3) yields (4).

If $p \mid \ell - 1$, then $v_p(u) > \frac{(\ell-1)t}{2} = v_p(v)$ and $v_p(u) = v_p(uv) - \frac{(\ell-1)t}{2}$. Now by Lemma 8 and Lemma 13, we deduce that $e_{v_p(u)} = |\{i| \ 1 \le i \le k - 1 \text{ and } \min(i) = \frac{(\ell-1)t}{2}\}| + 1$. We may also deduce that $e_{\frac{(\ell-1)t}{2}} = (\ell-2)|\{i| \ 1 \le i \le k - 1 \text{ and } \min(i) = \frac{(\ell-1)t}{2}\}| + 1$. $\frac{(\ell-1)t}{2} || + (\ell-3)|\{i| \ 1 \le i \le k-1 \text{ and } c(i) < \frac{(\ell-1)t}{2}\}| + \ell-3 \text{ and thus that } e_{v_p(u)} - 1 + (\ell-2)(k-1) + (\ell-3) = e_{\frac{(\ell-1)t}{2}}.$ From (5.1), we have $q-1 = e_{v_p(u)} + e_{\frac{(\ell-1)t}{2}} + \sum_{j \notin \{\frac{(\ell-1)t}{2}, v_p(u)\}} e_j.$ Now application of (1) and (3) yield (5).

8. The Critical group of G(p, 3, t)

We now turn our focus to graphs of the form G(p, 3, t). We assume that $(p, t) \neq (2, 1)$ and $p \equiv 2 \pmod{3}$, so these graphs are connected and strongly regular. Recall that this is the Cayley graph on the additive group of the field $K = \mathbb{F}_q$ $(q = p^{2t})$ with "connection" set S, where S is the unique subgroup of K^{\times} satisfying $k := |S| = \frac{q-1}{3}$. All the results in the previous sections transfer to this case by setting $\ell = 3$.

Lemma 13 shows that for $i \neq 0$, the Smith normal form of L_i over R is diag $(p^c, p^t, p^{v_p(uv)-c})$. Here c is the least among the p-adic valuations of the entries of L_i . In this case, $v = \sqrt{q} \frac{\sqrt{q} + (-1)^{t+1}}{3}$ and $u = v + (-1)^t \sqrt{q}$ are the non-zero eigenvalues of the Laplacian of G(p, 3, t).

Given integers a, b not divisible by q-1, let c(a, b) denote the number of carries when adding the p-adic expansions of a and b (mod q-1). Consider the following counting problem.

Counting Problem: For $1 \le i \le k-1$, by min(i) we denote min $\{c(i + mk, nk) \mid 0 \le m \le 2, \text{ and } n = 1, 2\}$. Given $0 \le a < t$, find $|\{i | \min(i) = a\}|$.

Given a positive integer a, by e_a we denote the multiplicity of p^a as an elementary divisor of the critical group of G(p, 3, t). Let e_0 be the p-rank of the Laplacian of G(p, 3, t). Theorem 1 implies that, for 0 < a < t, we have $e_a = |\{i | \min(i) = a\}|$, and $e_0 = |\{i | \min(i) = 0\}| + 2$. Thus the solution to this problem will immediately provide us with the *p*-elementary divisors of the critical groups of graphs of the form G(p, 3, t).

Every integer *a* that is not divisible by q-1, when reduced modulo q-1, has a unique *p*-adic expansion $a \equiv \sum_{n=1}^{2t-1} a_m p^m$ (mod q-1), where $0 \le a_m \le p-1$. By s(a), we denote $\sum a_m$. The *p*-adic expression for *k* is $\sum_{m=0}^{t-1} \left(\frac{p-2}{3}\right) p^{2m} + \left(\frac{2p-1}{3}\right) p^{2m+1}$

and that of 2k is $\sum_{m=0}^{t-1} \left(\frac{2p-1}{3}\right) p^{2m} + \left(\frac{p-2}{3}\right) p^{2m+1}$. Thus we have s(k) = s(2k) = t(p-1). We may observe from Theorem 11 that

 $c(a,b) = \frac{s(a) + s(b) - s(a+b)}{p-1}.$

(8.1)

Given $j \in \mathbb{Z}$, by \overline{j} we denote the unique element of $\{0, 1, \dots, q-2\}$ satisfying $j \equiv \overline{j} \pmod{q-1}$. The following follows from (8.1).

Lemma 14. Given an integer $j \not\equiv 0 \pmod{q-1}$ and m = -1, 1, the following hold.

(1) $c(\overline{j}, \overline{mk}) + c(\overline{j + mk}, \overline{-mk}) = 2t$ (2) $c(\overline{j}, \overline{mk}) + c(\overline{j + mk}, \overline{mk}) = t + c(\overline{j}, \overline{-mk})$ (3) $c(\overline{j}, \overline{mk}) = c(\overline{-j - mk}, \overline{mk})$

Let $j \in \{1, ..., q-2\} \setminus \{k, 2k\}$, define $g(j) := \{c(j, k), c(j, 2k)\}$. For every j, there is a unique $\phi(j) \in \{1, 2, ..., k-1\}$ such that $i - \phi(i) \in \{0, k, 2k\}$. Note that $\phi^{-1}(i) = \{i, i + k, i + 2k\}$.

For $0 \le a \le t$, we define $Y_a := \{j \mid g(j) = \{a, b\}$ for some b such that $a \le b \le t\}$ and $R_a = \{i \mid 1 \le i \le k-1 \text{ and } \min(i) = i \le k-1\}$ *a*}. From Theorem 1, we have i) $e_a = |R_a|$, for 0 < a < t and; ii) $e_0 = |R_0| + 2$.

Lemma 15. Given Y_a and ϕ defined above and a < t, the following are true.

- (1) If ϕ_a is the restriction of ϕ to Y_a , then $\phi_a(Y_a) = R_a$.
- (2) Let $i \in R_a$. If $j \in \phi_a^{-1}(i)$ and $m_j \in \{1, 2\}$ such that $c(j, m_j k) = a$, then

(a) $\overline{j+m_jk} \notin \phi_a^{-1}(i)$

- (b) $\phi_a^{-1}(i) = \{j\}$ if and only if $t \notin g(j)$;
- (c) and $\phi_a^{-1}(i) = \{j, \overline{j-m_jk}\}$ if and only if $t \in g(j)$.
- (3) For $0 \le a < t$, we have $|R_a| = |Y_a| \frac{1}{2} |\{j \mid g(j) = \{a, t\}\}| = |Y_a| |\{j \mid g(j) = \{a\}\}|$

Proof. 1) Let $m \in \{1, 2\}$ and $j \in Y_a$ such that c(j, mk) = a and c(j, -mk) = b. Then by Lemma 14, we have $\{c(\overline{j+mk}, nk) | 0 \le m \le 2, \text{ and } n = 1, 2\} = \{a, b, t - a + b, t - b - a, 2t - a, 2t - b\}$. Since $a \le b \le t$, we have $\min(\phi(j)) = a$ and thus $\phi_a(Y_a) \subset R_a$. If $i \in R_a$, then there exists $j \in \{i, i+k, i+2k\}$ and $m \in 1, 2$ such that c(j, mk) = a. Using $a = \min(\{c(i+mk, nk) | 0 \le m \le 2, \text{ and } n = 1, 2\})$, and Lemma 14, we have $c(j, mk) \le c(\overline{j-mk}, -mk) = t + c(j, mk) - c(\overline{j, -mk})$. Thus we have $c(\overline{j, -mk}) \le t$ and therefore $j \in Y_a$ and $\phi_a(\overline{j}) = i$.

2) From Lemma 14 we have $c(j, m_jk) + c(\overline{j + m_jk}, -m_j\overline{k}) = 2t$ and $c(j, m_jk) + c(\overline{j + m_jk}, m_j\overline{k}) = t + c(j, -m_j\overline{k})$. As $c(j, m_j\overline{k}) = a < t$, Lemma 14 implies $c(\overline{j + m_jk}, -m_j\overline{k}) = 2t - a > t$. As $j \in Y_a$, we have $c(\overline{j, -m_j\overline{k}}) \ge c(\overline{j, m_j\overline{k}})$ and thus $c(\overline{j + m_j\overline{k}}, -m_j\overline{k}) = t + c(\overline{j, -m_j\overline{k}}) - c(\overline{j, m_j\overline{k}}) \ge t$. Thus $\overline{j + m_j\overline{k}} \notin \phi_a^{-1}(i)$. We have $\phi_a^{-1}(i) \subset \{\overline{j, j - m\overline{k}}\}$

As $j \in Y_a$, we have that $a = c(j, m_j K) \le c(j, \overline{-m_j k}) \le t$. Now, application of Lemma 14 yields $c(\overline{j - m_j k}, m_j k) = 2t - c(j, mk) \ge t$. By Lemma 14, we have $c(\overline{j - m_j k}, \overline{-m_j k}) + c(j, \overline{-m_j k}) = t + c(j, m_j k)$, and thus $c(\overline{j - m_j k}, \overline{-m_j k}) = a$ if and only if $c(j, \overline{-m_j k}) = t$. Therefore $\overline{j - m_j k} \in Y_a$ is and only if $c(j, \overline{-m_j k}) = t$. Thus (2) is true.

if and only if $c(j, -m_jk) = t$. Therefore $\overline{j - m_jk} \in Y_a$ is and only if $c(j, -m_jk) = t$. Thus (2) is true. 3) From (1) and (2), we have $|R_a| = \sum_{i \in Y_a} \frac{i}{|\phi_a^{-1}(i)|} = |Y_a| - \frac{1}{2}|\{j| g(j) = \{a, t\}\}|$. Given $j \in \{j| g(j) = \{a, t\}\}$, let

 $m_j \in \{1, 2\}$ such that $c(j, m_j k) = a$. We then have $c(j, -m_j k) = t$. By Lemma 14, we have $c(j, m_j k) + t = c(j, -m_j k) + c(j - m_j k, -m_j k)$ and thus $c(j - m_j k, -m_j k) = c(j, m_j k) = a$. Using c(j, mk) = c(-j - mk, mk) and c(-j - mk, -mk) = c(j - mk, -mk) from Lemma 14, we have $c(-j - m_j k, m_j k) = c(j, m_j k) = c(j - m_j k, -m_j k) = c(-j - m_j k, -m_j k)$. Thus if $j \in \{j \mid g(j) = \{a, t\}\}$, then $-j - m_j k \in \{j \mid g(j) = \{a\}\}$. Now the map $\lambda : \{j \mid g(j) = \{a, t\}\} \rightarrow \{j \mid g(j) = \{a\}\}$ defined by $\lambda(j) = -j - m_j k$ is well-defined. For $j \in \{j \mid g(j) = \{a\}\}$, we have $\lambda^{-1}(j) \subset \{-j, -j + k, -j + 2k\}$. Given $m \in \{1, 2\}$, Lemma 14 gives us c(-j, mk) = c(j - mk, mk) = 2t - c(j, -mk) = 2t - a, c(-j + mk, mk) = c(j + mk, mk) = t + c(j, -mk) - c(j, mk) = t + a - a = t, and c(-j + mk, -mk) = c(j, -mk) = a. Thus the map λ is a 2 to 1 map and therefore $\frac{1}{2}|\{j \mid g(j) = \{a, t\}\}| = |\{j \mid g(j) = \{a\}\}|$.

Corollary 16.
$$e_0 = \left(\frac{p+1}{3}\right)^{2t} (2^{t+1}-2).$$

Proof. Lemma 15 and Theorem 1 imply $e_0 = |R_0| + 2 = |Y_0| - \{j|g(j) = \{0\}\} + 2$. We recall that $k = \sum_{m=0}^{t-1} \left(\frac{p-2}{3}\right) p^{2m} + \left(\frac{2p-1}{3}\right) p^{2m+1}$ and $2k = \sum_{m=0}^{t-1} \left(\frac{2p-1}{3}\right) p^{2m} + \left(\frac{p-2}{3}\right) p^{2m+1}$. Therefore set $\{j|(c(j,k), c(j,2k)) = (0,b)\}$ is made up of numbers of the form $j = \sum_{m=0}^{t-1} a_{2m} p^{2m} + a_{m+1} p^{2m+1}$ satisfying: i) $0 \le a_{2m} < \frac{p+1}{3}$, ii) $0 \le a_{2m+1} < \frac{2(p+1)}{3}$ and, iii) $j \notin \{k, 2k\}$. Thus this set has size $2^t \left(\frac{p+1}{3}\right)^{2t} - 2$. Similar arguments yield $|\{j|j \neq 0 \text{ and } (c(j,k), c(j,2k)) = (b,0)\}| = 2^t \left(\frac{p+1}{3}\right)^{2t} - 2$ and $|\{j|j \neq 0 \text{ and } g(j) = \{0\}\}| = \left(\frac{p+1}{3}\right)^{2t} - 1$. The result now follows by the principle of inclusion-exclusion.

For 0 < a < t, Lemma 15 shows that $e_a = |R_a|$. We will use the transfer matrix method to compute $|R_a|$. We construct a weighted digraph *D*, and change the problem of computing e_a to that of counting closed walks in *D* of certain length and weight.

Let *D* be a digraph with vertex set *V*, edge set *E*, and with a weight function $wt : E \to \Re$ with values in some commutative ring \Re . By *M*, we denote the adjacency matrix of *D* with respect to the weight wt. Given $n \in \mathbb{Z}_{>0}$, let $C(n) = \sum_{\psi} wt(\psi)$, where the sum is over closed walks in *D* of length *n*. The following Lemma which is Corollary 4.7.3 of [21] gives us the generating function $\sum_{n>1} C(n)z^n$.

Lemma 17. Let T(z) = det(I - zM), then $\sum_{n \ge 1} C(n)z^n = -\frac{zT'(z)}{T(z)}$.

Consider $A_1 = \{(\alpha, \gamma, \delta) | (\alpha, \gamma, \delta) \in \{0, 1, \dots, p-1\} \times \{1, 2\} \times \{1, 2\}\}$ and $A_2 = \{[\alpha, \gamma, \delta] | (\alpha, \gamma, \delta) \in \{0, 1, \dots, p-1\} \times \{1, 2\} \times \{1, 2\}\}$. We construct a bipartite digraph $D = (A_1 \cup A_2, E)$. There is an arc $e \in E$ from $(\alpha, \gamma, \delta) \in A_1$ to

 $[\alpha', \gamma', \delta'] \in A_2$ if an only if

$$\alpha + \frac{2p-1}{3} + \gamma = \beta + p\gamma'$$
and

$$\alpha + \frac{p-2}{3} + \delta = \epsilon + p\delta$$

for some $\beta, \epsilon \in \{0, 1, \dots, p-1\}$. There is an arc $e_{\lambda} \in E$ from $[\alpha, \gamma, \delta] \in A_2$ to $(\alpha', \gamma', \delta') \in A_1$ if and only if

$$\alpha + \frac{p-2}{3} + \gamma = \beta + p\gamma'$$

and
$$\alpha + \frac{2p-1}{3} + \delta = \epsilon + p\delta'$$

for some $\beta, \epsilon \in \{0, 1, \dots, p-1\}$. The arcs in D of type e and e_{λ} are assigned label α and weights $wt(e) = wt(e_{\lambda}) = x^{\gamma'}y^{\delta'}$. So we have a weight function $wt : E \to \mathbb{C}[x, y]$ on D. The weight of a walk on D will be the products of the weights of its arcs.

Given $a, b \in \{0, 1, 2, \dots, 2t + 1\}$, let $E_{(a,b)}$ be the set of closed walks of length 2t and weight $x^a y^b$. A closed walk of length 2t with its initial vertex in A_1 is said to be of type A_1 , and is of type A_2 otherwise. Let $Y_{a,b}$ = $\{j \in \{1, 2, \dots, q-2\} \setminus \{k, 2k\} | g(j) = \{a, b\}\}$. Let a_0, a_1, \dots, a_{2t} be the labels of arcs of a walk $w \in \bigcup E_{(a,b)}$, then define $\psi(w) = \sum a_i p^i$. When $\{a, b\} \cap \{0, 2t\} = \emptyset$, we have $\psi(E_{(a,b)}) \subset Y_{a,b}$. By the *p*-ary add-with-carry-algorithm described in Theorem 4.1 of [13], given $j \in Y_{a,b}$, there exist carry sequences $(\gamma_0, \gamma_1, \dots, \gamma_{2t-1})$ and $(\delta_0, \delta_1, \dots, \delta_{2t-1})$ with $\gamma_i, \delta_i \in \{1, 2\}$ such that

$$a_{i} + \frac{2p-1}{3} + \gamma_{i} = b_{i} + \gamma_{i+1}p \qquad a_{i} + \frac{p-2}{3} + \delta_{i} = d_{i} + \delta_{i+1}p , \text{ for even } i \text{ and};$$

$$a_{i} + \frac{p-2}{3} + \gamma_{i} = b_{i} + \gamma_{i+1}p \qquad a_{i} + \frac{2p-1}{3} + \delta_{i} = d_{i} + \delta_{i+1}p , \text{ for odd } i.$$

Here $j = \sum a_i p^i$, $j + k = \sum b_i p^i$ and $j + 2k = d_i p^i$. We can now see that there are exactly two closed walks, one of each type which map to j under ψ . If $w(j, A_1)$ (respectively $w(j, A_2)$) is the walk of type A_1 (respectively type A_2) such that $\psi(w(j,A_1)) = j$ (respectively $\psi(w(j,A_2)) = j$), then $wt(w(j,A_1)) = x^{c(j,k)}y^{c(j,2k)}$ (respectively $wt(w(j,A_2)) = j$) $x^{c(j,2k)}y^{c(j,k)}$). We can now conclude that for $a \neq b$, the restriction of ψ is a bijection from $E_{(a,b)}$ to $Y_{a,b}$. Applying Lemma 15 3) gives us

$$e_a = \sum_{b=a+1}^{r} |E_{(a,b)}|, \tag{8.2}$$

for all 0 < a < t.

We observe that for all $\alpha, \alpha' \in \{0, 1, \dots, p-1\}$ and $\gamma, \delta \in \{1, 2\} \times \{1, 2\}$, there is no arc from (α, γ, δ) (resp. $[\alpha, \gamma, \delta]$) to $[\alpha', 0, 1]$ (resp. $(\alpha', 1, 0)$). We may also conclude that

- (1) there is an edge from (α, γ, δ) to $[\alpha', 0, 0]$ if and only if $0 \le \alpha < \frac{p+1}{3} \gamma$;
- (1) there is an edge from (α, γ, δ) to $[\alpha', 1, 0]$ if and only if $\frac{p+1}{3} \gamma \le \alpha < \frac{2(p+1)}{3} \delta$; (3) there is an edge from (α, γ, δ) to $[\alpha', 1, 1]$ if and only if $\frac{2(p+1)}{3} \delta \le \alpha < p$;
- (4) there is an edge from $[\alpha, \gamma, \delta]$ to $(\alpha', 0, 0)$ if and only if $0 \le \alpha < \frac{p+1}{3} \delta$;
- (5) there is an edge from $[\alpha, \gamma, \delta]$ to $(\alpha', 0, 1)$ if and only if $\frac{p+1}{3} \delta \le \alpha < \frac{2(p+1)}{3} \gamma$; (6) and there is an edge from $[\alpha, \gamma, \delta]$ to $(\alpha', 1, 1)$ if and only if $\frac{2(p+1)}{3} \gamma \le \alpha < p$.

Let M be the adjacency matrix of the weighted digraph D and let U be the $\mathbb{C}(x, y)$ vector space generated by the vertex set $A_1 \cup A_2$ (of D) as a basis. By abuse of notation, we may assume $M \in \text{End}(U)$.

Let
$$h_1 := \sum_{(\gamma,\delta)} \sum_{\alpha' < \frac{p+1}{3} - \gamma} [\alpha', \gamma, \delta], h_2 := \sum_{(\gamma,\delta)} \sum_{\frac{p+1}{3} - \gamma \le \alpha' < \frac{2(p+1)}{3} - \delta} [\alpha', \gamma, \delta], h_3 := \sum_{(\gamma,\delta)} \sum_{\alpha' \ge \frac{2(p+1)}{3} - \delta} [\alpha', \gamma, \delta],$$

 $h'_1 := \sum_{(\gamma,\delta)} \sum_{\alpha' < \frac{p+1}{3} - \delta} (\alpha', \gamma, \delta), h'_2 = \sum_{(\gamma,\delta)} \sum_{\frac{p+1}{3} - \delta \le \alpha' < \frac{2(p+1)}{3} - \gamma} [\alpha', \gamma, \delta], \text{ and } h'_3 := \sum_{(\gamma,\delta)} \sum_{\alpha' \ge \frac{2(p+1)}{3} - \gamma} (\alpha', \gamma, \delta).$
We can see that $M(A_1 \cup A_2) = \{h_1, h_2, h_3, h', h'_5, h'_5\}$. We also have,

 $(A_1 \cup A_2) = \{n_1, n_2, n_3, n_1, n_2, n_3\}$

$$\begin{split} M(h_1') &= \frac{p+1}{3}h_1 + \frac{p+1}{3}xh_2 + \frac{p-2}{3}xyh_3, \\ M(h_2') &= \frac{p+1}{3}h_1 + \frac{p-2}{3}xh_2 + \frac{p+1}{3}xyh_3, \\ M(h_3') &= \frac{p-2}{3}h_1 + \frac{p+1}{3}xh_2 + \frac{p+1}{3}xyh_3, \\ M(h_1) &= \frac{p+1}{3}h_1' + \frac{p+1}{3}yh_2' + \frac{p-2}{3}xyh_3', \\ M(h_2) &= \frac{p+1}{3}h_1' + \frac{p-2}{3}yh_2' + \frac{p+1}{3}xyh_3', \text{ and} \\ M(h_3) &= \frac{p-2}{3}h_1' + \frac{p+1}{3}yh_2' + \frac{p+1}{3}xyh_3'. \end{split}$$

Let W be the subspace of U generated by $\{h_i, h'_i | i = 1, 2, 3\}$, then M(U) = W. The set $\beta = \{h_i, h'_i | i = 1, 2, 3\}$ is linearly independent, and thus is a basis for W. Let $M_{[\beta]}$ be the matrix representation of $M|_W$ with respect to the basis β of W. From above we see that $M_{[\beta]}$ is

As $det(M_{[\beta]}) = -p^2 x^3 y^3 \neq 0$, we have $W \cap ker(M) = \{0\}$ and thus $U = ker(M) \oplus W$. Thus the characteristic polynomial of M is $f(z) = z^{8p-6}det(zI - M_{[\beta]})$. Careful computation shows that $det(zI - M_{[\beta]}) = z^6 - Pz^4 + Qz^2 - R$,

where
$$P = \left(\left(\frac{p+1}{3}\right)^2 (x^2y^2 + x^2y + xy^2 + x + y + 1) + \left(\frac{p-2}{3}\right)^2 3xy\right),$$

 $Q = \left(\left(\frac{p+1}{3}\right)^2 (xy)(x^2y^2 + x^2y + xy^2 + x + y + 1) + \left(\frac{2p-1}{3}\right)^2 3x^2y^2\right),$ and $R = p^2x^3y^3.$ Thus $f(z) = z^{8p} - Pz^{8p-2} + Qz^{8p-4} - Rz^{8p-6}.$

Let $C(n) = \sum_{\psi} wt(\psi)$, where the sum is over closed walks in D of length n. As D is a bipartite graph, we have C(n) = 0 for all odd *n*. By Lemma 17, we have

$$\sum_{t\geq 1} C(2t)z^{2t} = -\frac{zT'(z)}{T(z)},$$

where T(z) = det(I-zM). The characteristic polynomial of *M* was computed above to be $z^{8p} - Pz^{8p-2} + Qz^{8p-4} - Rz^{8p-6}$, and thus we have

$$\sum_{t \ge 1} C(2t)z^{2t} = \frac{2Pz^2 - 4Qz^4 + 6Rz^6}{1 - (Pz^2 - Qz^4 + Rz^6)}$$

Let C(2t) = 0 for $t \le 0$. We have $\sum_{t\ge 1} (C(2t) - PC(2t-2) + QC(2t-4) - RC(2t-6))z^t = 2Pz - 4Qz^2 + 6Rz^3$. Thus

$$C(2) = 2P$$

$$C(4) = 2(P^2 - 2Q),$$

$$C(6) = 6R + 2(P^3 - 2QP) - 2PQ,$$
and
$$C(2t) = PC(2t - 2) - QC(2t - 4) + RC(2t - 6) \text{ for } t > 3.$$

The coefficient of $x^a y^b$ in C(2t) is $|E_{(a,b)}|$. Given a < t, we have from (8.2) that $e_a = \sum_{a < b \le t} |E_{(a,b)}|$. Application of Theorem 1 and Corollary 16 yields Theorem 2.
