Electromagnetic proton-neutron mass difference

We discuss the Cottingham formula and evaluate the proton-neutron electromagnetic mass difference exploiting the state-of-the-art phenomenological input. We decompose individual contributions to the mass splitting into Born, inelastic and subtraction terms. We evaluate the subtractionfunction contribution connecting the input based on experimental data with the operator product expansion matched to QCD which allows us to avoid model dependence and to reduce errors of this contribution. We evaluate inelastic and Born terms accounting for modern low- Q^2 data.

Two isospin-violating effects inside nucleons, the difference between the up and down quark masses and electromagnetic interaction, result in the shift between the proton M_p and neutron M_n masses δM_{p-n} [\[1\]](#page-4-0):

$$
\delta M_{p-n} = M_p - M_n = -1.29333217(42) \text{ MeV.} \tag{1}
$$

It is well known that the QED contributions enter Eq. [\(1\)](#page-0-0) with a positive sign. The leading electromagnetic correction was related to the phenomenological input from the electron-proton scattering by Cottingham in Ref. [\[2\]](#page-4-1) and investigated in detail together with ideas about the negative sign contributions in a historical review of Ref. [\[3\]](#page-4-2). The origin of the negative sign due to the difference between up and down quark masses was pointed in Ref. [\[4\]](#page-4-3), where authors evaluated as well the electromagnetic contribution: $\delta M_{p-n}^{\gamma} = 0.76 \pm 0.30$ MeV. In Ref. [\[5\]](#page-4-4), the author has renormalized the Cottingham formula explicitly and pointed on the small correction from the high-energy counterterms. Recent studies of Ref. [\[6\]](#page-4-5) accounted for the modern experimental data on the inelastic proton structure and have corrected the elastic contribution of Ref. [\[4\]](#page-4-3). The new result $\delta M_{p-n}^{\gamma} = 1.30 \pm 0.47$ MeV [\[6\]](#page-4-5) is within uncertainties of Refs. [\[4,](#page-4-3) [7,](#page-4-6) [8\]](#page-4-7). However, the central values are quite different, which motivates to explore individual contributions to the Cottingham formula in detail. The electromagnetic effect was studied also in Refs. $[7, 9-11]$ $[7, 9-11]$ $[7, 9-11]$, while the QCD contribution to splitting was investigated in Refs. [\[12](#page-4-10)[–16\]](#page-4-11). Both corrections were evaluated on the lattice in Ref. [\[17\]](#page-4-12) with small lattice and relatively heavy pions as well with lower pion masses by BMW Collaboration [\[18,](#page-4-13) [19\]](#page-4-14). The dispersive estimate of Ref. [\[9\]](#page-4-8): $\delta M_{p-n}^{\gamma} = 1.04 \pm 0.11$ MeV, gave smaller uncertainty due to very optimistic assumptions about our knowledge of the subtraction function and of the isovector nucleon polarizability. The best lattice result with four nondegenerate quark flavors for the electromagnetic contribution is $\delta M_{p-n}^{\gamma} = 1.00 \pm 0.16$ MeV [\[19\]](#page-4-14). It is in a good agreement with phenomenological estimates and has smaller error. The four-flavor result [\[19\]](#page-4-14) is 1-2 σ smaller than the three-flavor calculation of Ref. [\[20\]](#page-4-15): $\delta M_{p-n}^{\gamma} = 1.71 \pm 0.30$ MeV, and agrees within er-rors with Ref. [\[18\]](#page-4-13): $\delta M_{p-n}^{\gamma} = 1.59 \pm 0.46$ MeV as well

as with earlier three-flavor studies of Ref. [\[17\]](#page-4-12) with the shift $\delta M_{p-n}^{\gamma} = 0.38 \pm 0.68$ MeV and with an exploratory work of Ref. [\[11\]](#page-4-9): $\delta M_{p-n}^{\gamma} = 0.53 - 0.84$ MeV, which has demonstrated a new approach for such calculations exploiting an ensemble with the pion mass far from its physical value. To put constraints on the up-down quark mass difference, the lattice result of Ref. [\[19\]](#page-4-14) requires an independent cross check by dispersive calculation.

In this paper, we present the derivation of the Cottingham formula considering the decomposition into the Born, inelastic and subtraction contributions. We update the size of all terms relying on modern experimental input.

The forward doubly virtual Compton scattering (VVCS) process on a nucleon (see Fig. [1](#page-0-1) for kinematics): $\gamma^*(q) + N(p) \to \gamma^*(q) + N(p)$, is described by the amplitude T. The latter can be expressed in terms of the forward VVCS tensor $\mathbf{M}^{\mu\nu}$ as

$$
T = \varepsilon_{\nu} (q) \, \varepsilon_{\mu}^{*} (q) \, \bar{N} (p) \left(4 \pi M^{\mu \nu} \right) N (p) \,, \tag{2}
$$

where N, \overline{N} denote the nucleon spinors, $\varepsilon_{\nu}, \varepsilon_{\mu}^*$ are the initial and final virtual photon polarization vectors. The nucleon is at rest in the laboratory frame, i.e., $p = (M, 0)$, while the photon energy is given by $\nu_{\gamma} = (p \cdot q)/M$ and the virtuality is $Q^2 = -q^2$.

The nucleon self-energy correction is determined by the

symmetric part of the forward VVCS tensor $M_S^{\mu\nu}$:

$$
M_S^{\mu\nu} = \left(-g^{\mu\nu} + \frac{q^{\mu}q^{\nu}}{q^2}\right) T_1(\nu_\gamma, Q^2)
$$

+
$$
\left(p^{\mu} - \frac{(p \cdot q)}{q^2} q^{\mu}\right) \left(p^{\nu} - \frac{(p \cdot q)}{q^2} q^{\nu}\right) \frac{T_2(\nu_\gamma, Q^2)}{M^2},
$$
\n(3)

with the unpolarized forward Compton amplitudes T_1 and T_2 , which enter Eq. [\(3\)](#page-1-0) in a gauge-invariant way, i.e., $q_{\mu}M^{\mu\nu} = q_{\nu}M^{\mu\nu} = 0$. The imaginary parts of the forward VVCS amplitudes T_1 and T_2 are related to the unpolarized proton structure functions F_1 and F_2 by

$$
\Im T_1(\nu_\gamma, Q^2) = \frac{e^2}{4M} F_1(\nu_\gamma, Q^2),\tag{4}
$$

$$
\Im T_2(\nu_\gamma, Q^2) = \frac{e^2}{4\nu_\gamma} F_2(\nu_\gamma, Q^2),\tag{5}
$$

where e denotes the electric charge.

The real part of the even amplitude T_1 is related to the imaginary part through the subtracted dispersion relation:

$$
\Re T_1(\nu_\gamma, Q^2) = T_1^{\text{subt}}(0, Q^2) + \Re T_1^{\text{Born}}(\nu_\gamma, Q^2) + \frac{e^2 \nu_\gamma^2}{2\pi} \int_{\nu_{\text{thr}}^{\text{inel}}}^{\infty} \frac{F_1(\nu', Q^2) d\nu'}{M\nu'(\nu'^2 - \nu_\gamma^2)},
$$
(6)

with the pion-nucleon production threshold: $\nu_{\text{thr}}^{\text{inel}}$ = $m_{\pi} + (m_{\pi}^2 + Q^2) / (2M)$, where m_{π} denotes the pion mass, $T_1^{\text{subt}}(0, Q^2)$ is the subtraction function at zero photon energy $\nu_{\gamma} = 0$, and F_1 contains only the inelastic contributions since we have separated the Born piece [\[21\]](#page-4-16). The real part of the unpolarized amplitude T_2 can be obtained from the unsubtracted dispersion relation:

$$
\Re T_2(\nu_\gamma, Q^2) = \Re T_2^{\text{Born}}(\nu_\gamma, Q^2) + \frac{e^2}{2\pi} \int_{\nu_{\text{thr}}^{\text{inel}}}^{\infty} \frac{F_2(\nu', Q^2) d\nu'}{\nu'^2 - \nu_\gamma^2}.
$$
\n(7)

The self-energy electromagnetic correction to the nucleon propagator, see Fig. [2,](#page-1-1) is given by

$$
S - S_0 = S_0 \left(\frac{1}{2} \int \frac{d^4 q}{(2\pi)^4} \frac{-ig_{\mu\nu}}{q^2} 4\pi i M^{\mu\nu} \right) S, \quad (8)
$$

with the full propagator S and the free propagator S_0 :

$$
S_0 = \frac{i}{\hat{p} - M},\tag{9}
$$

where $\hat{a} = \gamma^{\mu} a_{\mu}$. Multiplying Eq. [\(8\)](#page-1-2) by S_0^{-1} from the left and by S^{-1} from the right, we obtain:

$$
S_0^{-1} - S^{-1} = \int \frac{i d^4 q}{(2\pi)^3} \frac{M_\mu^{\mu}}{q^2},
$$
 (10)

resulting into the electromagnetic mass shift δM^{γ} [\[2\]](#page-4-1):

$$
\delta M^{\gamma} = \int \frac{i\mathrm{d}^4 q}{(2\pi)^3} \frac{\mathrm{M}_{\mu}^{\mu}}{q^2}.
$$
 (11)

To relate it to the experimental input, we perform the Wick rotation first: $q_0 \rightarrow i\nu_\gamma$, and introduce the spacelike virtuality $Q^2 = -q^2$. The mass shift is given by

$$
\delta M^{\gamma} = \int \frac{\mathrm{d}\nu \mathrm{d}^{3}q}{(2\pi)^{3}} \frac{\mathrm{M}_{\mu}^{\mu}}{Q^{2}} = \int \frac{\mathrm{d}\nu_{\gamma} \mathrm{d}Q^{2}}{(2\pi)^{2}} \frac{\sqrt{Q^{2} - \nu_{\gamma}^{2}} \mathrm{M}_{\mu}^{\mu}}{Q^{2}}. (12)
$$

Changing the integration order and accounting for the crossing properties of the Compton scattering, the Cottingham formula [\[2\]](#page-4-1) gives:

$$
\delta M^{\gamma} = \int_{0}^{\infty} \frac{\mathrm{d}Q^2}{(2\pi)^2} \int_{0}^{1} \frac{\sqrt{1-\tilde{\tau}} \mathrm{d}\tilde{\tau}}{\sqrt{\tilde{\tau}}} \mathbf{M}_{\mu}^{\mu},\tag{13}
$$

with $\tilde{\tau} = \nu_{\gamma}^2/Q^2$ and the trace of the forward VVCS tensor:

$$
M^{\mu}_{\mu} = -3T_1(i\nu_{\gamma}, Q^2) + (1 - \tilde{\tau}) T_2(i\nu_{\gamma}, Q^2). \quad (14)
$$

Following the decomposition of the forward VVCS amplitudes of Eqs. [\(6\)](#page-1-3) and [\(7\)](#page-1-4), we introduce the Born contribution $\delta M^{\rm Born}$, the inelastic correction $\delta M^{\rm inel}$ and the subtraction term $\delta M^{\rm subt}$:

$$
\delta M^{\gamma} = \delta M^{\text{Born}} + \delta M^{\text{inel}} + \delta M^{\text{subt}}.\tag{15}
$$

Exploiting the integral:

$$
\int_{0}^{1} \frac{\sqrt{1-\tilde{\tau}}d\tilde{\tau}}{\sqrt{\tilde{\tau}}} = \frac{\pi}{2},\tag{16}
$$

the contribution of the subtraction function $T_{1,p-n}^{\text{subt}}(0,Q^2)$ to the proton-neutron mass difference $\delta M_{p-n}^{\text{subt}}$ can be easily expressed as [\[4,](#page-4-3) [6,](#page-4-5) [7\]](#page-4-6)

$$
\delta M_{p-n}^{\text{subt}} = -\frac{3}{8\pi} \int_{0}^{\infty} dQ^2 T_{1,p-n}^{\text{subt}} (0, Q^2).
$$
 (17)

Instead of evaluating the isovector magnetic polarizability from the derivative of the longitudinal to transverse cross sections ratio at origin relying on four data points

at relatively large virtuality $Q^2 \gtrsim 0.75 \text{ GeV}^2$ [\[22,](#page-4-17) [23\]](#page-4-18) with assumption of energy independence and isospin symme-try [\[7\]](#page-4-6), we take the difference between the proton β_M^p and neutron β_M^n magnetic polarizabilities:

$$
\beta_M^{p-n} = \beta_M^p - \beta_M^n = (-1.2 \pm 1.3) \times 10^{-4} \text{ fm}^3, \quad (18)
$$

from p.d.g. [\[1\]](#page-4-0) and estimate the subtraction function at higher Q^2 evaluating the unsubtracted dispersion relation for the amplitude free from the Regge high-energy behavior (Refs. $[24, 25]$ $[24, 25]$ $[24, 25]$) with an input from Refs. $[26-$ [29\]](#page-4-22). We estimate the uncertainty of the proton structure functions at 3 % level, double the error for the neutron structure functions and assign a 30 % uncertainty to a Reggeon pole residue [\[7\]](#page-4-6). We connect the experimental isovector magnetic polarizability, with the p.d.g. value at zero virtuality $\beta_M^{p-n}(0) = \beta_M^{p-n}$, and higher- Q^2 region on the level of $\beta_M^{p-n} (Q^2) = {\rm T}_{1,p-n}^{\rm subt} (0,Q^2) / Q^2$; see Fig. [3](#page-2-0) for details. The subtraction term contributes:

$$
\delta M_{p-n}^{\text{subt}} = 0.33 \pm 0.30 \text{ MeV},\tag{19}
$$

where we have chosen the upper integration limit at relatively low $Q^2 = 1 \text{ GeV}^2$ and have exploited the pQCD result based on the operator product expansion [\[30\]](#page-4-23) above which gives a rough estimate above and in the region of hadronic physics.¹ According to Ref. [\[30\]](#page-4-23), the resulting Compton amplitude $T_{1,p-n}(0, Q^2)$ is much smaller than the Born contribution. Consequently, the subtraction function in QCD region can be well approximated as $T_{1,p-n}^{\text{subt}}(0, Q^2) \approx -T_{1,p-n}^{\text{Born}}(0, Q^2)$ which has the same sign but is smaller up to an order of magnitude than any phenomenological estimate [\[6,](#page-4-5) [9\]](#page-4-8), and contributes 0.06 MeV to mass difference from this region.

We have added uncertainties of the subtraction-function contribution: 0.28 MeV, and due to the variation of the upper integration limit over the range $1 - 1.5 \text{ GeV}^2$: 0.1 MeV, in quadrature. Our result is within uncertainties of previous estimates: $\delta M_{p-n}^{\text{subt}} = 0.47 \pm 0.47$ MeV [\[6\]](#page-4-5), $\delta M_{p-n}^{\text{subt}} = 0.21 \pm 0.11 \text{ MeV } [6, 9].$ $\delta M_{p-n}^{\text{subt}} = 0.21 \pm 0.11 \text{ MeV } [6, 9].$ $\delta M_{p-n}^{\text{subt}} = 0.21 \pm 0.11 \text{ MeV } [6, 9].$ $\delta M_{p-n}^{\text{subt}} = 0.21 \pm 0.11 \text{ MeV } [6, 9].$ $\delta M_{p-n}^{\text{subt}} = 0.21 \pm 0.11 \text{ MeV } [6, 9].$ Our central value is determined by the isovector nucleon magnetic polarizability [\[31–](#page-4-24)[34\]](#page-4-25), and our error is smaller than the previous data-driven evaluations. In order to compete with the lattice calculation of Ref. [\[19\]](#page-4-14), besides the necessary improvement in the structure functions in the resonance and DIS regions, the uncertainty on the isovector magnetic polarizability has to be reduced to $(0.4-0.5) \times 10^{-4}$ fm³, at least. Moreover, additional studies within the framework of low-energy effective field theories [\[35,](#page-4-26) [36\]](#page-4-27) could shed more light on the most uncertain low- Q^2 region.

We obtain the Born contribution substituting the corresponding unpolarized Compton amplitudes T_1^{Born} and $\mathrm{T}_2^{\mathrm{Born}}$:

$$
T_1^{\text{Born}}\left(\tilde{\tau}, Q^2\right) \,=\, \frac{\alpha}{M} \left(\frac{G_M^2\left(Q^2\right)}{1 - \frac{\tilde{\tau}}{T} - i\varepsilon} - F_D^2\left(Q^2\right) \right), (20)
$$

$$
T_2^{\text{Born}}\left(\tilde{\tau}, Q^2\right) \,=\, \frac{\alpha}{M} \frac{G_{\text{E}}^2\left(Q^2\right) + \tau_{\text{P}} G_{\text{M}}^2\left(Q^2\right)}{\tau_{\text{P}}\left(1 + \tau_{\text{P}}\right)\left(1 - \frac{\tilde{\tau}}{\tau_{\text{P}}} - i\varepsilon\right)},\tag{21}
$$

with the Dirac (F_D) , Sachs electric (G_E) and magnetic (G_M) form factors, the electromagnetic coupling constant $\alpha \equiv e^2/(4\pi)$ and the notation $\tau_{\rm P} = Q^2/(4M^2)$. Introducing the additional notation $\rho(\tau)$:

$$
\rho(\tau) = 2\left(\tau - \sqrt{\tau(1+\tau)}\right),\tag{22}
$$

and exploiting the integral:

$$
\int_{0}^{1} \frac{\sqrt{1-\tilde{\tau}}d\tilde{\tau}}{\sqrt{\tilde{\tau}}\left(1+\frac{\tilde{\tau}}{\tilde{\tau}}\right)} = -\frac{\pi}{2}\rho\left(\tau\right),\tag{23}
$$

we express the Born contribution to the proton-neutron mass difference $\delta M_{p-n}^{\text{Born}}$ as

$$
\delta M_{p-n}^{\text{Born}} = \frac{3\alpha}{8\pi M} \int_0^\infty \mathrm{d}Q^2 \left(\mathrm{F}_{\text{D}}^2 \left(Q^2 \right) + \rho \left(\tau_{\text{P}} \right) \mathrm{G}_{\text{M}}^2 \left(Q^2 \right) \right) - \frac{\alpha}{8\pi M} \int_0^\infty \mathrm{d}Q^2 \left(1 + \frac{1+\tau_{\text{P}}}{\tau_{\text{P}}} \rho \left(\tau_{\text{P}} \right) \right) \times \frac{\mathrm{G}_{\text{E}}^2 \left(Q^2 \right) + \tau_{\text{P}} \mathrm{G}_{\text{M}}^2 \left(Q^2 \right)}{1+\tau_{\text{P}}},
$$
(24)

implying that the difference between proton and neutron contributions should be taken. For the numerical evaluation, we take the up-to-date proton form factors with uncertainties from Refs. [\[37,](#page-4-28) [38\]](#page-4-29) and the neutron form factors from Refs. [\[39–](#page-4-30)[43\]](#page-4-31). For the neutron, we obtain the central value averaging over the form factor parameterizations and estimate the uncertainty as a difference

between the largest and smallest results. The resulting Born contribution is given by

$$
\delta M_{p-n}^{\text{Born}} = 0.74 \pm 0.01 \text{ MeV}.
$$
 (25)

The corrections to the proton mass δM_p^{Born} :

$$
\delta M_p^{\text{Born}} = 0.53 \pm 0.01 \text{ MeV},\tag{26}
$$

and neutron mass δM_n^{Born} :

$$
\delta M_n^{\text{Born}} = -0.21 \pm 0.01 \text{ MeV},\tag{27}
$$

have an opposite sign enhancing the electromagnetic mass difference.² Note that the analytical expression of Eq. (24) has no analogous in Ref. [\[6\]](#page-4-5); the difference is in the G_M^2 contribution to the subtraction term [\[6,](#page-4-5) [21\]](#page-4-16). Apparently, this mismatch was accounted in the numerical evaluation, since the result of Ref. [\[6\]](#page-4-5) for the whole elastic contribution: 0.77 MeV, is quite close to ours.

With the same integrals of Eqs. (16) and (23) , the inelastic contribution is expressed in terms of the unpolarized structure functions as

$$
\delta M_{p-n}^{\text{inel}} = -\frac{\alpha}{4\pi} \int_0^\infty \mathrm{d}Q^2 \int_{\nu_{\text{thr}}^{\text{inel}}}^{\infty} \frac{\mathrm{d}\nu_{\gamma}}{\nu_{\gamma}} \left\{ \rho\left(\tilde{\tau}\right) \frac{\mathrm{F}_2\left(\nu_{\gamma}, Q^2\right)}{\nu_{\gamma}} - (1 + \rho\left(\tilde{\tau}\right)) \left(\frac{3\mathrm{F}_1\left(\nu_{\gamma}, Q^2\right)}{M} - \frac{\nu_{\gamma} \mathrm{F}_2\left(\nu_{\gamma}, Q^2\right)}{Q^2} \right) \right\},\tag{28}
$$

implying that the difference between proton and neutron contributions should be taken. This is exactly the result of Refs. [\[4,](#page-4-3) [6,](#page-4-5) [7\]](#page-4-6). We account for the inelastic correction relying on structure function from Refs. [\[27–](#page-4-32)[29\]](#page-4-22):

$$
\delta M_{p-n}^{\text{inel}} = 0.034 \pm 0.010 \text{ MeV},\tag{29}
$$

where only the error due to the variation of upper integration region in the range $1.5 \text{ GeV}^2 < Q^2 < 2.5 \text{ GeV}^2$ included and the central value corresponds with the upper limit $Q^2 \leq 2 \text{ GeV}^2$. Neglecting the counterterms contribution [\[5,](#page-4-4) [6\]](#page-4-5), the resulting mass difference δM_{p-n}^{γ} is given by

$$
\delta M_{p-n}^{\gamma} = 1.09 \pm 0.3 \text{ MeV}.
$$
 (30)

Note that a conservative assignment of 100 % error to inelastic contribution³ as well as increase in uncertainty from the Born term will not change the error of the resulting mass difference within significant digits.

We have presented the Cottingham formula in terms of the phenomenological input. We have updated the Born correction and estimated the subtraction term based on the experimental input. Our total result is within errors of the previous estimates $[4, 6, 9]$ $[4, 6, 9]$ $[4, 6, 9]$ $[4, 6, 9]$ $[4, 6, 9]$ due to the large uncertainty of the correction from the subtraction function. However, the knowledge of the Born contribution and the subtraction term is improved. Precise studies of the proton and neutron magnetic polarizabilities, inelastic structure functions and Regge trajectories will be able to improve the dispersive evaluation further.

² The proton and neutron mass corrections based on the state-ofthe-art fits from Ref. [\[44\]](#page-4-33) are in agreement with our results and have smaller uncertainties.

³ A naive assignment of 3-5 $\%$ error to nucleon structure functions gives an uncertainty estimate comparable to the inelastic contribution. A proper error estimate calls for reanalysis of nucleon structure functions taking correlations into account.
