# DEGREE COUNTING THEOREMS FOR SINGULAR LIOUVILLE SYSTEMS

#### Abstract

Let $(M, g)$ be a compact Riemann surface with no boundary and $u=\left(u_{1}, \ldots, u_{n}\right)$ be a solution of the following singular Liouville system: $$
\Delta_{g} u_{i}+\sum_{j=1}^{n} a_{i j} \rho_{j}\left(\frac{h_{j} e^{u_{j}}}{\int_{M} h_{j} e^{u_{j}} d V_{g}}-\frac{1}{\operatorname{vol}_{g}(M)}\right)=\sum_{t=1}^{N} 4 \pi \gamma_{t}\left(\delta_{p_{t}}-\frac{1}{v_{0 o l_{g}(M)}}\right)
$$ where $i=1, \ldots, n, h_{1}, \ldots, h_{n}$ are positive smooth functions, $p_{1}, \ldots, p_{N}$ are distinct points on $M, \delta_{p_{t}}$ are Dirac masses, $\rho=\left(\rho_{1}, \ldots, \rho_{n}\right)\left(\rho_{i} \geq 0\right)$ and $\left(\gamma_{1}, \ldots, \gamma_{N}\right)$ $\left(\gamma_{t}>-1\right)$ are constant vectors. If the coefficient matrix $A=\left(a_{i j}\right)_{n \times n}$ satisfies standard assumptions we identify a family of critical hyper-surfaces $\Gamma_{k}$ for $\rho=\left(\rho_{1}, . ., \rho_{n}\right)$ so that a priori estimate of $u$ holds if $\rho$ is not on any of the $\Gamma_{k} \mathrm{~s}$. Thanks to the a priori estimate, a topological degree for $u$ is well defined for $\rho$ staying between every two consecutive $\Gamma_{k} \mathrm{~s}$. In this article we establish this degree counting formula which depends only on the Euler Characteristic of $M$ and the location of $\rho$. Finally if the Liouville system is defined on a bounded domain in $\mathbb{R}^{2}$ with Dirichlet boundary condition, a similar degree counting formula that depends only on the topology of the domain and the location of $\rho$ is also determined.


## 1. Introduction

In this article we study the following Liouville system defined on a compact Riemann surface $(M, g)$ with no boundary:

& \text { for } \quad i \in I:=\{1, \ldots, n\}, \quad \gamma_{i l}>-1, \text { for } i \in I, l=1, \ldots, N ; \tag{1.1}

where $h_{1}^{*}, \ldots, h_{n}^{*}$ are positive smooth functions on $M, \rho_{1}, \ldots, \rho_{n}$ are nonnegative constants, $\operatorname{vol}_{g}(M)$ is the volume of $M, p_{1}, \ldots, p_{N}$ are distinct points on $M, \delta_{p_{l}}$ are singular sources at $p_{l}$ and $\gamma_{i l}>-1(i=1, \ldots, n, l=1, \ldots N)$ are constants as well. Equation (1.1) is called Liouville system if all the entrees in the coefficient matrix $A=\left(a_{i j}\right)_{n \times n}$ are nonnegative.

System (1.1), in its generality, covers a large number of models in different subjects of mathematics, physics and other disciplines as well. In physics Liouville systems can be derived from the mean field limit of point vortices of the Euler flow ( see [8, 9, 23, 10]). The study of Liouville systems finds applications in nonabelian Chern-Simons-Higgs theory ([18, 20, 21, 41]) and the electroweak theory (see [1,

[^0]35, 36, 37, 38, 39, 40, 41]).Various Liouville systems are also used to describe models in theories of chemotaxis ([11, 22]), the physics of charged particle beams [6, 17, 24, 25], and other gauge field models [19, 26]. Even if the system is reduced to one equation, it has profound background in geometry: if the equation has no singular source, it interprets the Nirenberg problem of prescribing Gauss curvature; if the equation has singular sources, the solution represents a metric with conic singularity [27]. It is just impossible to overestimate the importance of Liouville systems.

One of the main goals in the study of Liouville system is to identity the role that the topology of $M$ plays in the structure of solutions. In particular, people seek to identity a family of hyper-surfaces for $\rho:=\left(\rho_{1}, \ldots, \rho_{n}\right)$, so that if $\rho$ does not belong to these hyper-surfaces, a priori estimate of $u$ holds and the Leray-Schauder degree can be defined. The explicit computation of the Leray-Schauder degree, which depends on the topology of $M$, gives rise to existence of solution if the degree is not zero. Usually the identification of critical hyper-surfaces requires detailed study of blowup solutions, and it is well known that local, geometric information, such as the Gauss curvature plays a crucial role in determining the asymptotic behavior of blowup solutions, the main purpose of this article is to establish a link between local analysis, the structure of solutions and the topology of 2-manifolds for a class of singular Liouville systems.

If the system is reduced to Liouville equation, Chen and Lin completed the program in a series of pioneering works [12, 13, 14]. The readers may read into [28, 29, 42, 3, 4, 43] for background and related discussions. Chen-Lin's work was extended by Lin and the second author [32, 33, 34] to Liouville systems with no Dirac sources. Since singular sources have significant geometric applications, the main purpose of this article is to extend Lin-Zhang's degree counting formula to systems with Dirac poles.

For the coefficient matrix $A$ we postulate two conditions: The first one is called a standard assumption:

(H 1): \quad A \text { is symmetric, non-negative, irreducible and invertible. }
$$

Here we note that $A$ being irreducible means there is no partition of the index set $I:=\{1, \ldots, n\}$ into two disjoint subsets $I=I_{1} \cup I_{2}$ such that $a_{i j}=0$ for all $i \in I_{1}$ and $j \in I_{2}$. In other words the Liouville system cannot be written as two separated subsystems. The second assumption, which is made on the inverse of $A^{-1}=\left(a^{i j}\right)_{n \times n}$, is called a strong interaction assumption: For $I=\{1, \ldots, n\}$,

The reason that (H2) is called a strong interaction assumption can be justified from the following two examples: For $n=2$, the matrix

a_{12} & a_{22}

satisfies $(H 1)$ and $(H 2)$ if and only if $a_{i j} \geq 0, \max \left(a_{11}, a_{22}\right) \leq a_{12}$, and $\operatorname{det}(A) \neq 0$. For $n=3$, the following matrix

satisfies both $(H 1)$ and (H2) if and only if $a_{i}>0$ and $a_{i}+a_{j} \geq a_{k}$ for $i, j, k$ all different from one another.

The second main assumption is that around each singular source, the strength of the singular source for each component is the same: $\gamma_{i l}=\gamma_{l}>-1$ for all $i=$ $1, \ldots, n$. This assumption is crucial to for ruling out all partial blowups later. Also for convenience we assume that the volume of the manifold is 1 , thus (1.1) can be written as

\end{equation*}

Around each singular source, the leading term of $u_{i}^{*}$ is a logarithmic function that comes from the following Green's function $G(x, q)$ :

\int_{M} G(x, q) d x=0
\end{array}\right.

It is a common practice to define

$$
u_{i}=u_{i}^{*}-4 \pi \sum_{l=1}^{N} \gamma_{l} G\left(x, p_{l}\right),
$$

and rewrite (1.2) as

where

$$
h_{i}(x)=h_{i}^{*}(x) \exp \left\{-\sum_{l=1}^{N} 4 \pi \gamma_{l} G\left(x, p_{l}\right)\right\},
$$

which implies that around each singular source, say, $p_{l}$, in local coordinates, $h_{j}$ can be written as

h_{j}(x)=|x|^{2 \gamma_{l}} g_{j}(x)
$$

for some positive, smooth function $g_{j}(x)$.
Obviously, equation (1.4) remains the same if $u_{i}$ is replaced by $u_{i}+c_{i}$ for any constant $c_{i}$. Thus we might assume that each component of $u=\left(u_{1}, \ldots, u_{n}\right)$ is in

Then equation (1.4) is the Euler-Lagrange equation for the following nonlinear functional $J_{\rho}(u)$ in $\dot{H}^{1}(M)$ :

Let $\mathbb{N}^{+}$be the set of positive integers. We shall use the following notation:

\Sigma:=\left\{8 m \pi+\sum_{p_{l} \in A} 8 \pi\left(1+\gamma_{l}\right) ; \quad A \subset\left\{p_{1}, \ldots, p_{N}\right\}, \quad m \in \mathbb{N}^{+} \cup\{0\} \quad\right\} \backslash\{0\} .

Writing $\Sigma$ as

we first establish the following a priori estimate:
Theorem 1.1. Let $A=\left(a_{i j}\right)_{n \times n}$ satisfy (H1) and (H2). For $k \in \mathbb{N}^{+} \cup\{0\}$, and

Suppose $h_{i}^{*}$ s are positive and $C^{1}$ functions on $M$ and $K$ is a compact subset of $\mathscr{O}_{k}$. Then there exists a constant $C$ such that for any solution $u=\left(u_{1}, \ldots, u_{n}\right)$ of (1.4) with $\rho \in K$ and $u_{i} \in \dot{H}^{1}(M)$, we have

\left|u_{i}(x)\right| \leq C, \quad \text { for } i \in I, \quad \text { and } \quad x \in M .
$$

Note that the set $\mathscr{O}_{k}$ is bounded if all $a_{i i}>0$ and is unbounded if $a_{i i}=0$ for some $i$. By Theorem (1.1) the critical parameter set for (1.4) is

\Gamma_{k}=\left\{\rho ; \quad 8 \pi n_{k} \sum_{i \in I} \rho_{i}=\sum_{i, j \in I} a_{i j} \rho_{i} \rho_{j}\right\} .

Thanks to Theorem 1.1, for $\rho \notin \Gamma_{k}$, we can define the nonlinear map $T_{\rho}=\left(T^{1}, \ldots, T^{n}\right)$ from $\dot{H}^{1, n}=\dot{H}^{1}(M) \times \ldots \times \dot{H}^{1}(M)$ to $H^{1, n}$ by

Obviously $T_{\rho}$ is compact from $\dot{H}^{1, n}$ to itself. Then we can define the LeraySchauder degree of (1.4) by

where $R$ is sufficiently large and $B_{R}=\left\{u ; \quad u \in \dot{H}^{1, n}\right.$, and $\left.\sum_{i=1}^{n}\left\|u_{i}\right\|_{H^{1}}<R\right\}$. By the homotopic invariance and Theorem 1.1, $d_{\rho}$ is constant for $\rho \in \mathscr{O}_{k}$ and is independent of $h=\left(h_{1}, \ldots, h_{n}\right)$.

To state our degree counting formula for $d_{\rho}$ we consider the following generating function $g$ :

where $\chi(M)=2-2 g_{e}(M)$ is the Euler Characteristic of $M\left(g_{e}(M)\right.$ is the genus of $M)$. It is obvious to observe that if $-\chi(M)+N>0$,

$$

Writing $g(x)$ in the following form

we use $b_{1}, b_{2}, \ldots$ to describe our degree counting theorem:
Theorem 1.2. Let $d_{\rho}$ be the Leray-Schauder degree for (1.4). Suppose

then

$$

For most applications $\gamma_{l}$ are positive integers, which implies that

\Sigma=\left\{8 \pi m ; \quad m \in \mathbb{N}^{+}\right\}
$$

Thus in this case $\left(\gamma_{l} \in \mathbb{N}^{+}\right)$if $\chi(M) \leq 0$ we have

=\left(1+x+x^{2}+\ldots\right)^{-\chi(M)} \Pi_{l=1}^{N}\left(1+x+\ldots+x^{\gamma_{l}}\right) \\
=1+b_{1} x+b_{2} x^{2}+\ldots+b_{k} x^{k}+. .
\end{array}
$$

obviously $b_{j} \geq 0$ for all $j \geq 1$, which implies

d_{\rho}=1+\sum_{j=1}^{k} b_{j}>0
$$

Corollary 1.1. Suppose all $\gamma_{l} \in \mathbb{N}^{+}$and $\chi(M) \leq 0$. Then $d_{\rho}>0$ if

\sum_{i j \in I} a_{i j} \rho_{i} \rho_{j} \neq 8 \pi m \sum_{i \in I} \rho_{i} \quad \forall m \in \mathbb{N}^{+}
$$

Thus (1.4) always has a solution in this case.
For an open, bounded smooth domain in $\mathbb{R}^{2}$, we are also interested in the following system of equations:

\left.u_{i}\right|_{\partial \Omega}=0, \quad i \in I
\end{array}\right.
$$

where $h_{1}^{*}, \ldots, h_{n}^{*}$ are smooth functions on $\bar{\Omega}$ and $p_{1}, \ldots, p_{N}$ are distinct points in the interior of $\Omega$.

Let

$$
g(x)=\left(1+x+x^{2}+\ldots\right)^{-\chi(\Omega)+N} \prod_{l=1}^{N}\left(1-x^{1+\gamma_{l}}\right)=\sum_{j=0}^{\infty} b_{j} x^{n_{j}}
$$

where $\chi(\Omega)=1-g_{e}(\Omega)\left(g_{e}(\Omega)\right.$ is the number of holes bounded by $\left.\Omega\right)$ is the Euler Characteristic number of $\Omega$, and $b_{0}=1$. Then we have

Theorem 1.3. Suppose

$$

Then $d_{\rho}=\sum_{j=0}^{k} b_{j}$. If $\gamma_{1}, \ldots, \gamma_{N} \in \mathbb{N}^{+}, \Omega$ is not simply connected and $\sum_{i j} a_{i j} \rho_{i} \rho_{j} \neq$ $8 \pi m \sum_{i} \rho_{i}$ for any $m \in \mathbb{N}$, we have $d_{\rho}>0$ and the existence of a solution to (1.7).

If the Liouville system on $(M, g)$ is written as

with the same assumptions on $A, h_{i}^{*}, \gamma_{l}$ and $\operatorname{vol}(M)=1$, we first remark that (1.8) is a special case of (1.4). Indeed, integrating (1.8) on both sides, we have

Setting

\rho_{i}=\left(\sum_{j \in I} a^{i j}\right)\left(4 \pi \sum_{l} \gamma_{l}\right), \quad i \in I,
$$

we can write (1.8) as

$$

If $M$ is a torus $(\chi(M)=0)$ and $\gamma_{l} \in \mathbb{N}^{+}$we can compute the Leray-Schauder degree if $\sum_{l} \gamma_{l}$ is odd.
Theorem 1.4. Suppose $M$ is a torus, $\gamma_{l} \in \mathbb{N}^{+}$and $\sum_{l} \gamma_{l}$ is odd. Then LeraySchauder degree for (1.8) is $\frac{1}{2} \Pi_{l=1}^{N}\left(1+\gamma_{l}\right)$.

Here we would like to point out that if the topology of the manifold is trivial, Bartolucci [2] studied another delicate Liouville system and proved some existence results when the topological degree is zero.

The main ideas of proofs in this article are motivated by a number of related works. One major difficulty comes from the "partial blowup phenomenon", which means when a system is scaled according to the maximum of all its branches, some components disappear after taking the limit. One crucial step is to prove that no component is lost after scaling. We call this a fully bubbling phenomenon. For this
part we use the idea in [33]. Another major difficulty comes from the non-simple blowup phenomenon. When a singular source happens to be a blowup point, it is possible to have a finite number of disjoint bubbling disks all tending to the singular source. Such a blowup picture is called "non-simple blowup", studied by Kuo-Lin [27] and independently by Bartolucci-Tarantello [5] for singular Liouville equations. In this article, using ideas in [30, 31] we extend the results of Kuo-Lin, Bartolucci-Tarantello to Liouville systems and prove that the non-simple blowup phenomenon can only occur if the strength of the singular source is a multiple of $4 \pi$.

Finally we would like to explain the role of $(H 1)$ and $(H 2)$ and how the blowup analysis of Liouville systems is different from that of Toda systems [30, 31]. For Liouville systems, the total integration (energy) of global solutions belongs to a hypersurface [32], which means the energy is not discrete. To rule out the difficulty caused by the abundance of energy we need to use $(H 1)$ and $(H 2)$ to prove that the profiles of bubbling solutions around different blowup points are the same. Moreover, there is almost no energy outside the bubbling disks. However, for Toda systems, even though the energy of global solutions is quantized, a major difficulty comes from the fact that there is a lot of energy outside bubbling disks. In [31], tools in algebraic geometry are used to prove that energy outside bubbling disks is also quantized.

The organization of this article is as follows: In section two we analyse the asymptotic behavior of solutions near a blowup point and we prove, using ideas in [33] that the energy of $u_{i}^{k}$ must satisfy certain rules around different blowup points. In this section we also establish certain estimates for non-simple blowup points. Then in section three we prove all the main theorems. In particular the proof of degree counting theorems is by reducing the systems to Liouville equation and use the previous results of Chen-Lin [13, 14].

## 2. Asymptotic behavior around a singular source

Since the proof of all the main theorems boils down to detailed analysis of locally defined blow up solutions, in this section we consider a locally defined Liouville system

where $h_{1}^{k}, \ldots, h_{n}^{k}$ are positive smooth functions on $B_{\delta}$ (the ball centered at the origin with radius $\delta>0$ ) with uniform bounds:

0<c_{1} \leq h_{i}^{k} \leq c_{2}, \quad\left\|h_{i}^{k}\right\|_{C^{1}} \leq c_{3}, \quad i \in I, \tag{2.2}
\end{equation*}

for $c_{1}, c_{2}, c_{3}>0$ independent of $k$. Let $\gamma>-1$ is the strength of $\delta_{0}, A=\left(a_{i j}\right)_{n \times n}$ satisfy (H1), (H2), and we assume the uniform bound on the integral of $h_{i}^{k} e^{u_{i}^{k}}$ and its oscillation on $\partial B_{\delta}$ (the boundary of $B_{\delta}$ ):

\begin{equation*}
\max _{i} \max _{x, y \in \partial B_{\delta}}\left|u_{i}^{k}(x)-u_{i}^{k}(y)\right| \leq C, \tag{2.4}
\end{equation*}
$$

for some $C$ independent of $k$. Then in this section we consider the case that the origin is the only blowup point in $B_{\delta}$ : let

$$
\begin{equation*}
\tilde{u}_{i}^{k}(x)=u_{i}^{k}(x)-2 \gamma \log |x|, \quad i \in I:=\{1, \ldots, n\} \tag{2.5}
\end{equation*}
$$

and write the equation for $\tilde{u}^{k}=\left(\tilde{u}_{1}^{k}, \ldots, \tilde{u}_{n}^{k}\right)$ as

$$
\begin{equation*}
\Delta \tilde{u}_{i}^{k}+\sum_{j} a_{i j}|x|^{2 \gamma} h_{j}^{k} e^{u_{j}^{k}}=0, \quad \text { in } \quad B_{\delta} . \tag{2.6}
\end{equation*}
$$

Then we assume that

$$
\begin{equation*}
M_{k}=\max _{i} \max _{x \in B_{\delta}} \frac{\tilde{u}_{i}^{k}(x)}{\mu} \quad \text { where } \quad \mu=1+\gamma \tag{2.7}
\end{equation*}
$$

tends to infinity:

$$
\begin{equation*}
M_{k} \rightarrow \infty \quad \text { and given } \varepsilon \in(0, \delta), \max _{i} \max _{x \in B_{\delta} \backslash B_{\varepsilon}} u_{i}^{k} \leq C(\varepsilon) \tag{2.8}
\end{equation*}
$$

for some $C(\varepsilon)>0$ independent of $k$.
In this case the profile of blowup solutions is more intriguing than that around a regular point. There are two possibilities: either

$$
\begin{equation*}
\max _{i} \max _{x \in B_{\delta}} u_{i}^{k}(x)+2 \log |x| \leq C \tag{2.9}
\end{equation*}
$$

or along a subsequence

$$
\begin{equation*}
\max _{i} \max _{x \in B_{\delta}} u_{i}^{k}(x)+2 \log |x| \rightarrow \infty . \tag{2.10}
\end{equation*}
$$

We call the blowup phenomenon "simple" if (2.9) holds. Otherwise, if (2.10) holds we use "non-simple-blowup" to describe $u^{k}$.
2.1. Simple-blowup. First we consider the case when (2.9) holds. Let

$$
\tilde{v}_{i}^{k}(y)=\tilde{u}_{i}^{k}\left(\varepsilon_{k} y\right)+2 \mu \log \varepsilon_{k}, \quad \text { where } \quad \varepsilon_{k}=e^{-\frac{1}{2} M_{k}} .
$$

Then it is easy to verify that $\tilde{v}_{i}^{k} \leq 0$ and

$$
\begin{equation*}
\Delta \tilde{v}_{i}^{k}(y)+\sum_{j} a_{i j} h_{j}\left(\varepsilon_{k} y\right)|y|^{2 \gamma} e^{\tilde{v}_{j}^{k}(y)}=0, \quad|y| \leq \delta \varepsilon_{k}^{-1} . \tag{2.11}
\end{equation*}
$$

Then we prove

## Lemma 2.1.

$$
\begin{equation*}
\max _{i} \tilde{v}_{i}^{k}(0) \geq-C \tag{2.12}
\end{equation*}
$$

Proof: From (2.8) we see that there exists $y_{k} \in B\left(0, \delta \varepsilon_{k}^{-1}\right)$ such that $\max _{i} \tilde{v}_{i}^{k}\left(y_{k}\right)=0$ and $\left|y_{k}\right|=o(1) \varepsilon_{k}^{-1}$. Let $r_{k}=\left|y_{k}\right|$ and

$$
z_{i}^{k}(y)=\tilde{v}_{i}^{k}\left(r_{k} y\right)+2 \mu \log r_{k}-c_{0}, \quad|y| \leq 2, \quad i \in I
$$

where $c_{0}$ is chosen to make $z_{i}^{k} \leq-1$ (see (2.9)). We write the equation of $z_{i}^{k}$ as

$$
\Delta z_{i}^{k}+\frac{\sum_{j} a_{i j}|y|^{2 \gamma} h_{j}^{k} e^{z_{j}^{k}+c_{0}}}{z_{i}^{k}} z_{i}^{k}=0, \quad|y| \leq 2
$$

Using $z_{i}^{k} \leq-1$ we see that $\left|\frac{\sum_{j} a_{i j} h_{j}^{k} j_{i}^{k_{i}^{k}}+c_{0}}{z_{i}^{k}}\right|$ is bounded. Standard Harnack inequality for linear equation gives

$$
\begin{equation*}
\max _{\partial B_{1}}\left(-z_{i}^{k}\right) \leq C \min _{\partial B_{1}}\left(-z_{i}^{k}\right), \quad i \in I . \tag{2.13}
\end{equation*}
$$

Thus $\max _{i} \min \tilde{v}_{i}^{k} \geq-C$ on $\partial B_{r_{k}}$. Then (2.12) follows easily from standard maximum principle. Lemma 2.1 is established.

The proof of Lemma 2.1 also implies that at least one component of $\tilde{v}_{i}^{k}$ is bounded below over any compact subset of $\mathbb{R}^{2}$, which means these components converge to a global function along a subsequence. Thus we use $I_{1}$ to be the indexes of converging components. In other words, for indexes not in $I_{1}$, the corresponding components tend to minus infinity over any fixed compact subset of $\mathbb{R}^{2}$.

Let $\tilde{v}_{i}$ be the limit of $\tilde{v}_{i}^{k}$ and we use

$$
\sigma_{i}=\frac{1}{2 \pi} \int_{\mathbb{R}^{2}}|y|^{2 \gamma} e^{\tilde{r}_{i}}, \quad i \in I_{1}
$$

to denote the energy of $\tilde{v}_{k}$ in $\mathbb{R}^{2}$. Here for convenience we assumed $h_{i}^{k}(0)=1$, but this assumption is not essential. Traditional method can be used to prove

$$
\tilde{v}_{i}(y)=-m_{i} \log |y|+O(1), \quad|y|>1, \quad i \in I_{1},
$$

where $m_{i}=\sum_{j=1}^{n} a_{i j} \sigma_{j}$. For $i \in I_{1}$ we have

$$
\begin{equation*}
m_{i}>2 \mu, \quad \mu=1+\gamma, \quad i \in I_{1} . \tag{2.14}
\end{equation*}
$$

Let $\sigma_{i}^{k}$ denote the energy of $u_{i}^{k}$ in $B_{\delta}$ :

$$
\sigma_{i}^{k}=\frac{1}{2 \pi} \int_{B_{\delta}} h_{i}^{k}|x|^{2 \gamma} e^{\tilde{u}_{i}^{k}}, \quad i=1, \ldots, n,
$$

Then it is immediate to observe that

$$
\lim _{k \rightarrow \infty} \sigma_{i}^{k} \geq \sigma_{i}, \quad i \in I_{1}
$$

Corresponding to $\sigma_{i}^{k}$ we set $m_{i}^{k}$ to be

$$
m_{i}^{k}=\sum_{j=1}^{n} a_{i j} \sigma_{j}^{k} .
$$

Before we proceed we extend (2.14) to all $i \in I$ :
Lemma 2.2.

$$
\begin{equation*}
m_{i}=\sum_{j \in I} a_{i j} \sigma_{j}>2 \mu, \quad i \in I \backslash I_{1} . \tag{2.15}
\end{equation*}
$$

Proof: First we invoke a result from [33]: For $A$ satisfying (H1) and (H2), $a_{i j}>0$ if $i \neq j$. We prove (2.15) by contradiction. Suppose $m=\min \left\{m_{i}, \quad i \in I\right\} \leq 2 \mu$. Then we immediately observe two facts: first $m_{i}>m$ for all $i \in I_{1}$ because $m_{i}>2 \mu$ for $i \in I_{1}$. Second $m>0$ because $\sigma_{i}=0$ if $i \notin I_{1}$ and $a_{i j}>0$ if $i \neq j$. Let $J=\{i \in$ $\left.I ; \quad m_{i}=m\right\}$. Clearly $J$ is not empty, $I_{1} \cap J=\emptyset$ and we use $J_{1}$ to denote $I \backslash\left\{I_{1} \cup J\right\}$. Moreover we use $\bar{m}=\min \left\{m_{i} ; \quad i \in I_{1} \cup J_{1}\right\}$. Clearly $\bar{m}>m$. For each $i \in J$, we have $\sigma_{i}=0$ since $i \notin I_{1}$. Thus

$$
0=\sigma_{i}=\sum_{j} a^{i j} m_{j}=\sum_{i \in J} m a^{i j}+\sum_{j \in J_{1} \cup I_{1}} a^{i j} m_{j} .
$$

Using $m_{j}>\bar{m}$ for $i \notin J$ and $a_{i j}>0$ for $i \neq j$, we have

$$
\begin{equation*}
0 \geq m \sum_{j \in J} a^{i j}+\sum_{j \notin J} a_{i j} \bar{m}=m \sum_{j \in I} a^{i j}+\sum_{j \notin J} a^{i j}(\bar{m}-m) . \tag{2.16}
\end{equation*}
$$

In view of (H2), which includes $\sum_{j} a^{i j} \geq 0$, we see that equality in (2.16) holds and

$$
a^{i j}=0, \quad \forall i \in J \text { and } \quad \forall j \in I \backslash J .
$$

Thus $A^{-1}$ can be written as a block-diagonal form, which means $A$ can also be written as a block diagonal form (after possible rearrangement of indexes), which is a contradiction to the irreducibility of $A$. (2.15) and Lemma 2.2 are established.

The following lemma gives an estimate of the behavior of $u_{i}^{k}$ near $\partial B_{\delta}$ :
Lemma 2.3. Let $M_{k}$ be defined in (2.7) and 0 be a simple blowup point of $u^{k}$, then we have

$$
\begin{gathered}
\sigma_{i}^{k}=\sigma_{i}+o(1), \quad i=1,2 \ldots, n, \\
\tilde{u}_{i}^{k}(x)=-m_{i}^{k} \log |x|-\frac{m_{i}^{k}-2 \mu}{2} M_{k}+O(1), \quad x \in \partial B_{\delta}, \quad i \in I_{1},
\end{gathered}
$$

and

$$
\tilde{u}_{i}^{k}(x)=-m_{i}^{k} \log |x|-\frac{m_{i}^{k}-2 \mu}{2} M_{k}+\left(\tilde{u}_{i}^{k}(0)-\mu M_{k}\right)+O(1), \quad x \in \partial B_{\delta}, \quad i \notin I_{1} .
$$

Remark 2.1. Note that we use o(1) to denote a quantity tending to 0 as $k \rightarrow \infty$, and $O(1)$ to denote a quantity whose absolute value does not tend to infinity as $k \rightarrow \infty$. For $i \notin I_{1}, \tilde{u}_{i}^{k}(0)-\mu M_{k} \rightarrow-\infty$. Also even for $i \notin I_{1}, \lim _{k \rightarrow \infty} m_{i}^{k}>0$ because $a_{i j}>0$ for $i \neq j$.

Proof of Lemma 2.3: As mentioned before, at least one component of $\tilde{v}_{k}$ converges uniformly over any fixed compact subset of $\mathbb{R}^{2}$. Then it is easy to find $R_{k} \rightarrow \infty$ to make the following hold:

$$
\begin{aligned}
& \frac{1}{2 \pi} \int_{B_{R_{k}}}|y|^{2 \gamma} h_{i}^{k}\left(\varepsilon_{k} y\right) e^{e_{i}^{k}(y)} d y=\sigma_{i}+o(1), \quad i \in I_{1}, \\
& \frac{1}{2 \pi} \int_{B_{R_{k}}}|y|^{2 \gamma} h_{i}^{k}\left(\varepsilon_{k} y\right) e^{v_{i}^{k}(y)} d y=o(1), \quad i \in I \backslash I_{1} .
\end{aligned}
$$

Let $\overline{\tilde{v}_{i}^{k}}(r)$ be the spherical average of $\tilde{v}_{i}^{k}$ on $\partial B_{r}$, the differentiation of $\overline{\tilde{v}_{i}^{k}}(r)$ gives

$$
\frac{d}{d r} \overline{\tilde{v}_{i}^{k}}(r)=\frac{1}{2 \pi r} \int_{B_{r}} \Delta \tilde{v}_{i}^{k}=-\frac{1}{2 \pi r} \int_{B_{r}} \sum_{j} a_{i j} h_{j}^{k}\left(\varepsilon_{k} y\right)|y|^{2 \gamma_{i}} e^{\nabla_{j}^{k}} .
$$

Since $a_{i j} \geq 0$ and all $m_{i}>2 \mu$, it is easy to use Green's representation of $\tilde{v}_{i}^{k}$ to prove

$$
\overline{\tilde{v}_{i}^{k}}(r)=\tilde{v}_{i}^{k}(y)+O(1), \quad|y|=r, \quad R_{k} \leq r \leq \frac{\delta}{2} \varepsilon_{k}^{-1}
$$

and

$$
\begin{equation*}
\tilde{v}_{i}^{k}(y) \leq-\overline{\tilde{v}_{i}^{k}}\left(R_{k}\right)-\left(2 \mu+\delta_{1}\right) \log |y|+O(1), \quad|y| \geq R_{k}, \quad i \in I \tag{2.17}
\end{equation*}
$$

for some $\delta_{1}>0$ independent of $k$. Even though $\delta_{1}>0$ may be small, it leads to the smallness of the energy of $\tilde{v}_{i}^{k}$ :

$$
\int_{B_{\varepsilon_{k}^{-1} \delta} \backslash B_{r}}|y|^{2 \gamma} h_{i}^{k}\left(\varepsilon_{k} y\right) e^{\tau_{i}^{k}}=O\left(r^{-\delta_{1}}\right)
$$

Thus we can give an accurate estimate of the energy of $\tilde{v}_{i}^{k}$ as:

$$
\begin{equation*}
\frac{1}{2 \pi} \int_{B_{r}}|y|^{2 \gamma} h_{i}^{k}\left(\varepsilon_{k} y\right) e^{\nabla_{i}^{k}}=m_{i}^{k}-O\left(r^{-\delta_{1}}\right), \quad R_{k} \leq r \leq \delta \varepsilon_{k}^{-1} . \tag{2.18}
\end{equation*}
$$

By the smallness of the error term in (2.18) and standard estimates from the Green's representation for $\tilde{v}_{i}^{k}$, we easily obtain

$$
\tilde{v}_{i}^{k}(y)=-m_{i}^{k} \log |y|+O(1), \quad 1<|y|<\varepsilon_{k}^{-1} \delta, \quad \forall i \in I_{1} .
$$

The estimate for $\tilde{v}_{i}^{k}$ near infinity can be translated into the following estimate for $\tilde{u}_{i}^{k}$ :

$$
\begin{align*}
\tilde{u}_{i}^{k}(x) & =\tilde{v}_{i}^{k}(y)-2 \mu \log \varepsilon_{k} \quad \text { for }|x|=\delta, \quad|y|=\varepsilon_{k}^{-1} \delta, \\
= & -m_{i}^{k} \log |y|-2 \mu\left(-\frac{1}{2} M_{k}\right)+O(1) \\
= & -m_{i}^{k} \log |x|+m_{i}^{k} \log \varepsilon_{k}+\mu M_{k}+O(1) \\
= & -m_{i}^{k} \log |x|-\frac{m_{i}^{k}-2 \mu}{2} M_{k}+O(1) . \tag{2.19}
\end{align*}
$$

Thus the estimate for $i \in I_{1}$ for $u_{i}^{k}$ is established.
It is also straight forward to prove that for all $i \notin I_{1}$,

$$
\int_{B\left(0, \varepsilon_{k}^{-1} \delta\right) \backslash B_{r}}|y|^{2 \mu} h_{i}^{k}\left(\varepsilon_{k} y\right) e^{-\nabla_{i}^{k}(y)}=O\left(r^{-\delta_{1}}\right), \quad R_{k} \leq r \leq \varepsilon_{k}^{-1} \delta .
$$

With this estimate the behavior of $\tilde{v}_{i}^{k}$ for $i \notin I_{1}$ can be written as

$$
\tilde{v}_{i}^{k}(y)=\tilde{v}_{i}^{k}(0)-\left(\sum_{j \in I_{1}} a_{i j} \sigma_{j}^{k}\right) \log |y|+O(1), \quad i \notin I_{1} .
$$

Consequently for $\tilde{u}_{i}^{k}$ we have, for $|x|=\delta$ and $|y|=\varepsilon_{k}^{-1}|x|$,

$$
\begin{aligned}
\tilde{u}_{i}^{k}(x) & =\tilde{v}_{i}^{k}(y)-2 \mu \log \varepsilon_{k} \\
& =\tilde{v}_{i}^{k}(0)-\left(\sum_{j \in I_{1}} a_{i j} \sigma_{j}^{k}\right) \log |y|+\mu M_{k} \\
& =-m_{i}^{k} \log |x|-\frac{m_{i}^{k}-2 \mu}{2} M_{k}+\left(\tilde{u}_{i}^{k}(0)-\mu M_{k}\right) .
\end{aligned}
$$

Lemma 2.3 is established.
Remark 2.2. Even though some components of $\left(\sigma_{1}, \ldots, \sigma_{n}\right)$ may be zero, $\left(\sigma_{1}, \ldots, \sigma_{n}\right)$ still satisfies the standard Pohozaev identity:

$$
\begin{equation*}
\sum_{i, j \in I} a_{i j} \sigma_{i} \sigma_{j}=4 \sum_{i}(1+\gamma) \sigma_{i} \tag{2.20}
\end{equation*}
$$

The derivation of $(2.20)$ is standard and we mention the argument here for the convenience of readers. The Pohozaev identity for $u^{k}$ on $\Omega$ is

$$
\begin{gathered}
\sum_{i \in I}\left(\int_{\Omega}\left(x \cdot \nabla h_{i}^{k}\right) e^{u_{i}^{k}}+2 h_{i}^{k} e^{u_{i}^{k}}\right) \\
=\int_{\partial \Omega}\left(\sum_{i}(x \cdot v) h_{i}^{k} e^{u_{i}^{k}}+\sum_{i, j} a^{i j}\left(\partial_{v} u_{j}^{k}\left(x \cdot \nabla u_{i}^{k}\right)-\frac{1}{2}(x \cdot v)\left(\nabla u_{i}^{k} \cdot \nabla u_{j}^{k}\right)\right)\right)
\end{gathered}
$$

Setting $\Omega=B_{\delta} \backslash B_{\varepsilon}$ and let $\varepsilon \rightarrow 0$, we have

$$
\begin{array}{r}
\delta \int_{\partial B_{\delta}} \sum_{i j \in I} a^{i j}\left(\partial_{v} u_{i}^{k} \partial_{v} u_{j}^{k}-\frac{1}{2} \nabla u_{i}^{k} \cdot \nabla u_{j}^{k}\right)+\sum_{i \in I} \delta \int_{\partial B_{\delta}} h_{i}^{k} e^{u_{i}^{k}} \\
\quad=2 \sum_{i \in I} \int_{B_{\delta}} h_{i}^{k} e^{u_{i}^{k}}+\sum_{i \in I} \int_{B_{\delta}}\left(x \cdot \nabla h_{i}^{k}\right) e^{u_{i}^{k}}+4 \pi \sum_{i j \in I} a^{i j} \gamma^{2} .
\end{array}
$$

where we have used

$$
\nabla u_{i}^{k}=2 \gamma x /|x|^{2}+a \text { bounded function }
$$

near the origin. In order to evaluate other terms we can use standard elliptic estimate to obtain

$$
\nabla u_{i}^{k}(x)=\left(\sum_{i \in I} a_{i j} \sigma_{j}-2 \gamma+o(1)\right) /|x|, \quad|x|=\delta
$$

Then (2.20) follows from direct computation. We refer the readers to [30] and [32] for more detailed computation.

Remark 2.3. If the blowup point $p$ is not a singular source, the scaling is centered at $p_{k} \rightarrow p$ where the maximum of $\tilde{u}_{i}^{k}$ is attained. In this case we have $\max _{i} v_{i}^{k}(0)=0$ and the non-simple blow-up does not happen.
2.2. The comparison of blowup solutions around different blowup points. Under the same context as in the previous subsection, we establish the following lemma which compares the behavior of solutions outside bubbling disks.

Lemma 2.4. Let $p$ and $q$ be two disjoint blowup points of

$$
\Delta u_{i}^{k}+\sum_{j} a_{i j} h_{j}^{k} e^{u_{j}^{k}}=4 \pi \gamma_{p} \delta_{p}+4 \pi \gamma_{q} \delta_{q}, \quad i \in I
$$

in $\Omega \subset \subset \mathbb{R}^{2}$ where $p, q \in \Omega, \gamma_{p}, \gamma_{q}>-1$. Suppose the assumption on $h_{i}^{k}$ is the same as before: Uniformly bounded above and below by positive constants and uniformly bounded in $C^{1}$ norm. And we also have the uniform bound energy and finite oscillation assumptions:

$$
\int_{\Omega} h_{i}^{k} e^{u_{i}^{k}} \leq C, \quad \max _{x, y \in \partial \Omega}\left|u_{i}^{k}(x)-u_{i}^{k}(y)\right| \leq C
$$

We use $\left(\sigma_{1}^{k}, \ldots, \sigma_{n}^{k}\right)$ and $\left(\bar{\sigma}_{1}^{k}, \ldots, \bar{\sigma}_{n}^{k}\right)$ to denote the integration of $u^{k}$ in $B(p, \delta)$ and $B(q, \delta)$, respectively:

$$
\sigma_{i}^{k}=\frac{1}{2 \pi} \int_{B(p, \delta)} h_{i}^{k} e^{u_{i}^{k}}, \quad \bar{\sigma}_{i}^{k}=\frac{1}{2 \pi} \int_{B(q, \delta)} h_{i}^{k} e^{u_{i}^{k}}
$$

If $p$ or $q$ is a regular point instead of a singular source, we have $\gamma_{p}=0$ or $\gamma_{q}=0$.
Correspondingly we set

$$
m_{i}^{k}=\sum_{j \in I} a_{i j} \sigma_{j}^{k}, \quad \bar{m}_{i}^{k}=\sum_{j=1}^{n} a_{i j} \bar{\sigma}_{j}^{k}
$$

Assume in addition that

$$
\left.u_{i}^{k}\right|_{\partial B(p, \delta)}=\left.u_{i}^{k}\right|_{\partial B(q, \delta)}+O(1)
$$

Then if $p$ and $q$ are both simple blowup points, we have

$$
\begin{equation*}
\frac{\mu_{q}}{\mu_{p}} \lim _{k \rightarrow \infty} \sigma_{i}^{k}=\lim _{k \rightarrow \infty} \bar{\sigma}_{i}^{k}, \quad i \in I \tag{2.21}
\end{equation*}
$$

Remark 2.4. If $p$ or $q$ is a regular point, it is a simple blowup already.

## Proof of Lemma 2.4;

Since $p$ and $q$ can be a singular source or a regular point on the manifold, we use $\mu_{p}=1+\gamma_{p}$ if $p$ is a singular source. Otherwise $\mu_{p}=1$. Let $M_{k}=\max _{i \in I} \tilde{u}_{i}^{k}(x) / \mu_{p}$ for $x \in B(p, \delta)$ and $\bar{M}_{k}=\max _{i} \tilde{u}_{i}^{k}(x) / \mu_{q}$ in $B(q, \delta)$, where $\tilde{u}_{i}^{k}$ is $u_{i}^{k}$ minus a corresponding logarithmic term in local coordinates. Suppose $M_{k}$ is attained at $p_{k}$ that tends to $p$ and $\bar{M}_{k}$ is attained at $q_{k}$ that tends to $q$. Using Lemma 2.3 we have, for $i \in I$

$$
\begin{equation*}
\frac{m_{i}^{k}-2 \mu_{p}}{2} M_{k}+\left(\mu_{p} M_{k}-\tilde{u}_{i}^{k}\left(p_{k}\right)\right)=\frac{\bar{m}_{i}^{k}-2 \mu_{q}}{2} \bar{M}_{k}+\left(\mu_{q} \bar{M}_{k}-\tilde{u}_{i}^{k}\left(q_{k}\right)\right)+O(1) \tag{2.22}
\end{equation*}
$$

Here we further remark that, say around $p$, if the first $l$ components of $\tilde{u}^{k}$ converge to a system of $l$ equations after scaling, $\mu_{p} M_{k}-\tilde{u}_{i}^{k}\left(p_{k}\right)$ are uniformly bounded for $1 \leq i \leq l$. In this case $\mu_{p} M_{k}-\tilde{u}_{i}^{k}\left(p_{k}\right)$ can be replaced by $O(1)$. For $i>l$,
$\mu_{p} M_{k}-\tilde{u}_{i}^{k}\left(p_{k}\right)$ tends to infinity. The right hand side of (2.22) can be understood similarly. For each $i \in I$, if

\mu_{p} M_{k}-\tilde{u}_{i}^{k}\left(p_{k}\right)>\mu_{q} \bar{M}_{k}-\tilde{u}_{i}^{k}\left(q_{k}\right)
$$

we let

l_{i}^{k}=\left(\mu_{p} M_{k}-\tilde{u}_{i}^{k}\left(p_{k}\right)\right)-\left(\mu_{q} \bar{M}_{k}-\tilde{u}_{i}^{k}\left(q_{k}\right)\right), \quad \text { and } \quad \vec{l}_{i}^{k}=0 .
$$

On the other hand, if

$$
\mu_{p} M_{k}-\tilde{u}_{i}^{k}\left(p_{k}\right) \leq \mu_{q} \bar{M}_{k}-\tilde{u}_{i}^{k}\left(q_{k}\right),
$$

we let

$$
l_{i}^{k}=0, \quad \text { and } \quad \bar{l}_{i}^{k}=\left(\mu_{q} \bar{M}_{k}-\tilde{u}_{i}^{k}\left(q_{k}\right)\right)-\left(\mu_{p} M_{k}-\tilde{u}_{i}^{k}\left(p_{k}\right)\right) .
$$

Set

$$
I_{1}:=\left\{i \in I ; \quad \lim _{k \rightarrow \infty} \frac{l_{i}^{k}}{M_{k}}>0\right\} \quad, \quad \text { and } \quad I_{2}:=\left\{i \in I ; \quad \lim _{k \rightarrow \infty} \frac{\bar{l}_{i}^{k}}{M_{k}}>0\right\} .
$$

It is easy to observe that $I_{1} \cap I_{2}=\emptyset$. We claim that $I_{1}=\emptyset$, which is now proved by contradiction:

Suppose $I_{1} \neq \emptyset$, then we consider two cases: $I_{2} \neq \emptyset$ and $I_{2}=\emptyset$.
Case one: $I_{2} \neq \emptyset$.
Let

\lambda=\lim _{k \rightarrow \infty} \frac{M_{k}}{\bar{M}_{k}}, \quad \delta_{i}=\lim _{k \rightarrow \infty} \frac{l_{i}^{k}}{\bar{M}_{k}}, \quad \bar{\delta}_{i}=\lim _{k \rightarrow \infty} \frac{\bar{l}_{i}^{k}}{\bar{M}_{k}} .

We claim that these limits exist along a subsequence. Indeed, using the definition of $l_{i}^{k}$ and $\bar{l}_{i}^{k}(2.22)$ can be written as

Take $i \in I_{1}$, the right hand side tends to $\frac{\bar{m}_{i}-2 \mu_{q}}{2}$, which means along a subsequence, the two terms on the left hand side tend to $\frac{m_{i}-2 \mu_{p}}{2}$ and $\delta_{i}$, respectively (we use $\sigma_{i}$ to denote the limit of $\sigma_{i}^{k} . m_{i}, \bar{m}_{i}, \bar{\sigma}_{i}$ are understood in a similar fashion). On the other hand for $j \in I_{2}$, the left hand side tends to $\frac{m_{i}-2 \mu_{p}}{2} \lambda$, which forces the right hand side to converge to $\frac{\bar{m}_{i}-2 \mu_{q}}{2}+\bar{\delta}_{i}$ along a subsequence. Now (2.22) leads to

Here we recall that $\delta_{i}>0$ in $I_{1}$ and $\bar{\delta}_{i}>0$ in $I_{2}$. We also will use $\sigma_{i} \delta_{i}=0$ for all $i$. From $\bar{\sigma}_{i}=0$ in $I_{2}$, we have

Since $A$ is irreducible, there exist $i \in I_{2}$ and $j \notin I_{2}$ such that $a^{i j}>0$. Multiplying $\bar{\delta}_{i}$ on both sides and taking the summation for $i \in I_{2}$, we have

$$

The second term on the left is nonnegative because $\delta_{i}=0$ if $i \in I_{2}$ and $a^{i j} \geq 0$ if $\tilde{i} \neq j$. The first term on the right is 0 , the last term on the right is negative. Thus the equation above is reduced to

Since all $\bar{\delta}_{i}=0$ we have

which is equivalent to the Pohozaev identity for $\left(\bar{\sigma}_{1}, \ldots, \bar{\sigma}_{n}\right)$ (see Remark 2.2) we have

\lambda^{2} \sum_{i j} a^{i j} \mu_{p}^{2}+2 \lambda \sum_{i j} a^{i j}\left(\frac{m_{i}-2 \mu_{p}}{2}\right) \delta_{j}+\sum_{i, j \in I_{1}} a^{i j} \delta_{i} \delta_{j}=\sum_{i j} a^{i j} \mu_{q}^{2} \tag{2.25}
\end{equation*}
$$

where we have used

$$
\sum_{i j} a^{i j}\left(\frac{m_{i}-2 \mu_{p}}{2}\right)\left(\frac{m_{j}-2 \mu_{p}}{2}\right)=\sum_{i j} a^{i j} \mu_{p}^{2} .
$$

The second term on the left hand side of (2.25) can be written as

\lambda\left(\sum_{j} \sigma_{j} \delta_{j}-2 \mu_{p} \sum_{j}\left(\sum_{i} a^{i j}\right) \delta_{j}\right),
$$

which is nonpositive because $\sigma_{i} \delta_{i}=0$ and $\sum_{i} a^{i j} \geq 0$. We further claim that the third term on the left hand side of (2.25) is nonpositive. This is because all the eigenvalues of $\left(a^{i j}\right)_{I_{1} \times I_{1}}$ are non-positive. This is proved in [33] and we include
it here for convenience: Without loss of generality we assume $I_{1}=\left\{1, \ldots, i_{0}\right\}$ and let $\mathbb{F}=\left(a^{i j}\right) i_{0} \times i_{0}$ for $i, j \in I_{1}$. Let $\mu$ be the largest eigenvalue of $\mathbb{F}$ and $\eta=$ $\left(\eta_{1}, \ldots, \eta_{i_{0}}\right)$ be an eigenvector corresponding to $\mu$. Here $\eta$ is the vector that attains

\max _{v \in \mathbb{R}^{i_{0}}} v^{T} \mathbb{F} v, \quad v^{T} v=1

Since $a^{i j} \geq 0$ for all $i \neq j$, we can choose $\eta_{i} \geq 0$ for all $i \in I_{1}$. For each $i \in I_{1}$,

Note that we have used $\sum_{i j} a^{i j}>0$ because otherwise $A^{-1}$ would not be invertible. Next using the proof of $(2.24)$ we can find some $i \in I_{1}$ such that $\sum_{j \in I_{1}} a^{i j} \delta_{j}<0$. For this $i$, from

where we have use $\sigma_{i}=0$ for $i \in I_{1}$. Using $\bar{\sigma}_{i} \geq 0$ and $\sum_{j \in I_{1}} a^{i j} \delta_{j}<0$ we have

Therefore this case $\left(I_{1} \neq \emptyset, I_{2}=\emptyset\right)$ is also ruled out. We have proved that $I_{1}=\emptyset$. In a similar manner $I_{2}=\emptyset$ can also be established.

Finally using

in the Pohozaev identity for $\left(\bar{\sigma}_{1}, \ldots, \bar{\sigma}_{n}\right)$ we have

\lambda=\lim _{k \rightarrow \infty} \frac{M_{k}}{\bar{M}_{k}}=\frac{\mu_{q}}{\mu_{p}} \tag{2.27}
\end{equation*}
$$

Using (2.27) in (2.26) we further have

$$
\begin{equation*}
\frac{\mu_{q}}{\mu_{p}} m_{i}=\bar{m}_{i}, \quad \frac{\mu_{q}}{\mu_{p}} \sigma_{i}=\bar{\sigma}_{i}, \quad i \in I \tag{2.28}
\end{equation*}
$$

Lemma2.4 is established
Finally we deduce the asymptotic behavior of $u^{k}$ when non-simple-blowup occurs.
2.3. Non-simple blowup. Now we consider the second possibility, the non-simple blowup. This phenomenon happens when (2.10) holds. Recall that $u^{k}=\left(u_{1}^{k}, \ldots, u_{n}^{k}\right)$ satisfies (2.1). If (2.10) holds, a standard selection process ( [30] ) determines a finite number of bubbling disks: $B\left(p_{l}^{k}, r_{l}^{k}\right)$ for $l=1, \ldots, N$ where $p_{l}^{k}$ are local maximums of some $u_{i}^{k}$ and $r_{l}^{k} \mathrm{~s}$ are determined as follows: Scale $u^{k}$ with respect to the maximum of $\max _{i} u_{i}^{k}\left(p_{l}^{k}\right)$, then the system converges to a possibly smaller global system with finite energy. Note that we use $B(p, \delta)$ to denote the ball centered at $p$ with radius $\delta$. Then it is easy to choose $R_{k} \rightarrow \infty$ such that the integral of the scaled functions over $B\left(0, R_{k}\right)$ is only $o(1)$ different from the energy of entire solutions. Scaling back to $u_{k}$ we have that the integral of $e^{u_{i}^{k}}$ over $B\left(p_{l}^{k}, r_{l}^{k}\right)$ is $o(1)$ different from the energy of its global limit. Moreover, if we use $\left(\sigma_{l 1}^{k}, \ldots, \sigma_{l n}^{k}\right)$ to denote the energy in $B\left(p_{l}^{k}, r_{l}^{k}\right)$ we have

$$
\sum_{i, j \in I} a_{i j} \sigma_{l i}^{k} \sigma_{l j}^{k}=4 \sum_{i} \sigma_{l i}^{k}+o(1)
$$

Here we shall invoke some argument in [30]. The main result in this part is:
Proposition 2.1. If (2.10) holds, $\mu \in \mathbb{N}^{+}$.
First we mention the following simple lemma:
Lemma 2.5. Let $A=\left(a_{i j}\right)_{n \times n}$ be a matrix that satisfies (H1). Suppose $\left(\sigma_{1}^{(1)}, \ldots, \sigma_{n}^{(1)}\right)$ and $\left(\sigma_{1}^{(2)}, \ldots, \sigma_{n}^{(2)}\right)$ are two vectors with nonnegative components. If they both satisfy

\sum_{i, j} a_{i j} \sigma_{i}^{(l)} \sigma_{j}^{(l)}=4 \mu \sum_{i=1}^{n} \sigma_{i}^{(l)}

for $l=1,2$ and some $\mu>0$. Then if

\end{equation*}

and

\sigma_{i}^{(2)} \geq \sigma_{i}^{(1)} \quad i=1, \ldots, n
$$

Then

$$
\sigma_{i}^{(1)}=\sigma_{i}^{(2)}, \quad i=1, \ldots, n .
$$

Proof of Lemma 2.5; The proof is immediate. Let $s_{i}=\sigma_{i}^{(2)}-\sigma_{i}^{(1)}$. Then $s_{i} \geq 0$. The difference between the two equations in (2.29) gives

\sum_{i, j}\left(a_{i j} \sigma_{j}^{(1)}-2 \mu\right) s_{i}+\sum_{i, j} a_{i j} s_{i} s_{j}=0 .

By the assumption $(H 1)$ and the nonnegativity of $s_{i}$ we have $s_{i}=0$ for all $i$.
Proof of Proposition 2.1: First we use

to denote the set of blowup points and the origin. Note that there may also be a bubbling disk centered at the origin, as described in Lemma 2.1. Here we invoke the definition of group in [30]. If a few bubbling disks are of comparable distance to one another and are much further to other bubbling disks, the set of these bubbling disks ( that of comparable distance to one another) is called a group. See [31, 30] for more detailed discussions. For example, $p_{1}^{k}, p_{2}^{k}, p_{3}^{k}$ are called in a group if $\operatorname{dist}\left(p_{1}^{k}, p_{2}^{k}\right) \sim \operatorname{dist}\left(p_{1}^{k}, p_{3}^{k}\right) \sim \operatorname{dist}\left(p_{2}^{k}, p_{3}^{k}\right)$ and

$$
\operatorname{dist}\left(p_{1}^{k}, q\right) / \operatorname{dist}\left(p_{1}^{k}, p_{2}^{k}\right) \rightarrow \infty
$$

for any $q \in \Sigma_{k} \backslash\left\{p_{1}^{k}, p_{2}^{k}, p_{3}^{k}\right\}$.
Now we make two important observations: First, there is no group far away from the origin. The reason is if there were such a group, say $B\left(p_{k}, l_{k}\right)$ and $B\left(q_{k}, l_{k}\right)$ belong to a group and $\operatorname{dist}\left(0, p_{k}\right) / \operatorname{dist}\left(p_{k}, q_{k}\right) \rightarrow \infty$. First by the argument of Lemma 2.14 and Lemma 2.3 all the components of $u_{i}^{k}$ have faster decay than harmonic function near $\partial B\left(p_{k}, l_{k}\right)$ and $\partial B\left(q_{k}, l_{k}\right)$ : in precise terms, if we use $\left(\sigma_{p 1}^{k}, \ldots, \sigma_{q n}^{k}\right)$ and $\left(\sigma_{q 1}^{k}, \ldots, \sigma_{q n}^{k}\right)$ to denote the energy in $B\left(p_{k}, l_{k}\right)$ and $B\left(q_{k}, l_{k}\right)$, respectively, we have

$$
\sum_{i j} a_{i j} \sigma_{p i}^{k} \sigma_{p j}^{k}=4 \sum_{i} \sigma_{p i}+o(1)
$$

and

$$
\sum_{i j} a_{i j} \sigma_{q i}^{k} \sigma_{q j}^{k}=4 \sum_{i} \sigma_{q i}+o(1)
$$

Moreover, as in Lemma 2.14

$$
\begin{equation*}
m_{p i}^{k}:=\sum_{i j} a_{i j} \sigma_{p j}^{k}>2, \quad m_{q i}^{k}:=\sum_{j} a_{i j} \sigma_{q j}^{k}>2, \quad \forall i \in I . \tag{2.30}
\end{equation*}
$$

Let $d_{k}$ be the distance from $p_{k}$ to the nearest member in $\Sigma_{k}$ not in the group of $p_{k}$ and $q_{k}$. Then (2.30) means all components of $u^{k}$ decay so fast that there is little energy in $B\left(p_{k}, d_{k} / 2\right) \backslash\left(B\left(p_{k}, l_{k}\right) \cup B\left(q_{k}, l_{k}\right)\right)$. Looking at the average of $u_{i}^{k}$ it is easy to find $\bar{l}_{k} \leq d_{k} / 2$ which satisfies

\bar{l}_{k} / l_{k} \rightarrow \infty, \bar{l}_{k}=o(1) \operatorname{dist}\left(p_{k}, \Sigma_{k} \backslash \text { the group of } p_{k}\right)
$$

And on $\partial B\left(p_{k}, \bar{l}_{k}\right)$ we still have

$$
\begin{equation*}
u_{i}^{k}(x)+2 \log l_{k} \rightarrow-\infty, \quad i \in I \tag{2.31}
\end{equation*}
$$

From (2.31) it is easy to use the Green's representation formula to evaluate the Pohozaev identity and obtain (see [30])

\sum_{i, j} a_{i j} \sigma_{\bar{l} \bar{l}}^{k} \sigma_{\bar{l} j}^{k}=4 \sum_{i} \sigma_{\bar{l} i}^{k}+o(1) \tag{2.32}
\end{equation*}

where $\sigma_{\bar{l} i}^{k}=\frac{1}{2 \pi} \int_{B\left(p_{k}, \bar{l}_{k}\right)} h_{i}^{k} e^{u_{i}^{k}}$. Since $\left(\sigma_{\bar{l} 1}^{k}, \ldots, \sigma_{\overline{l n}}^{k}\right)$ and $\left(\sigma_{p 1}^{k}, \ldots, \sigma_{p n}^{k}\right)$ satisfy the same equation but $\sigma_{\bar{l} i}^{k} \geq \sigma_{p i}^{k}+\sigma_{q i}^{k}$, by Lemma 2.5 we easily get a contradiction. Here we briefly review how (2.31) leads to (2.32). Roughly speaking (2.31) means the value of $u_{i}^{k}$ is very small on $\partial B\left(p_{k}, \bar{l}_{k}\right)$ and by Harnack inequality, most energy of
$u_{i}^{k}$ in $B\left(p_{k}, \bar{l}_{k}\right)$ is concentrated near $p_{k}$, which implies that all the derivatives of $u_{i}^{k}$ is very easy to estimate on $\partial B\left(p_{k}, \bar{l}_{k}\right)$. The evaluation of the derivatives of $u_{i}^{k}$ and the smallness of $e^{u_{i}^{k}}$ on $\partial B\left(p_{k}, \bar{l}_{k}\right)$ lead to (2.32).

The second main observation is that for the group containing the orgin, there is no bubbling disk centered at the origin. In other words, if there is a group that contains the origin, it has to be case that there are finitely many bubbling disks, say $B\left(p_{1}^{k}, r_{1}^{k}\right), \ldots, B\left(p_{l}^{k}, r_{l}^{k}\right)$, with $p_{1}^{k}, \ldots, p_{l}^{k}$ all of comparable distance to the origin and there is no bubbling disk centered at the origin. This fact is also proved by contradiction. Suppose around the origin there is a bubbling disk whose energy is $\left(\sigma_{1}^{k}, \ldots \sigma_{n}^{k}\right)$. We have already known that

$$
\sum_{i j} a_{i j} \sigma_{i}^{k} \sigma_{j}^{k}=4 \mu \sum_{i} \sigma_{i}^{k}+o(1)
$$

If there is another bubbling disk, say $B\left(p_{1}^{k}, l_{k}\right)$ in the group, we can find $\bar{l}_{k}$ such that $B\left(0, \bar{l}_{k}\right)$ encloses all the bubbling disks in this group and $\bar{l}_{k}$ is less than half of the distance from 0 to any member in $\Sigma_{k}$ outside the group. The fast decay property as before also gives

u_{i}^{k}(x)+2 \log \bar{l}_{k} \rightarrow-\infty, \quad x \in \partial B\left(0, \bar{l}_{k}\right)
$$

Using the same argument as in [30] we have

\sum_{i j} \sigma_{\bar{l} i}^{k} \sigma_{\bar{l} j}^{k}=4 \mu \sum_{i} \sigma_{\bar{l} i}^{k}+o(1)
$$

where $\sigma_{\bar{i}}^{k}=\frac{1}{2 \pi} \int_{B\left(0, \bar{l}_{k}\right)} h_{i}^{k} e^{u_{i}^{k}}$. Since $\sigma_{\bar{l} \bar{i}}$ is significantly greater than $\sigma_{i}^{k}$ for at least one component, Lemma 2.5 gives a contradiction as before.

By the two observations before we only need to consider the case that there are finitely many bubbling disks around the origin and their centers are of comparable distance to the origin. Suppose these local maximums are $p_{1}^{k}, \ldots, p_{N}^{k}$, and we suppose $\left|p_{t}^{k}\right| \sim \delta_{k}$.

Let

$$
\Lambda_{k}=\max _{i} \max _{x} u_{i}^{k}(x)+2 \log |x| .
$$

Without loss of generality we suppose $\Lambda_{k}$ is attained at $p_{1, k}$. Let $\delta_{k}=\left|p_{1, k}\right|$ and

\begin{equation*}
v_{i}^{k}(y)=u_{i}^{k}\left(p_{1, k}+\delta_{k} y\right)+2 \log \delta_{k}, \quad i \in I \tag{2.33}
\end{equation*}
$$

It is immediate to observe that the domain of $v_{i}^{k}$ contains $B\left(0, \delta \delta_{k}^{-1}\right)$ for some small $\delta>0$. Standard selection process can be employed to obtain finite bubbling disks centered at $p_{2, k}, \ldots, p_{N, k}$ such that not only $\left|p_{j, k}\right| \sim \delta_{k}$, but also $\left|p_{m, k}-p_{l, k}\right| \sim \delta_{k}$ for all $l \neq m$. Let $z_{l}^{k}$ be the images of $p_{l, k}$ by the scaling in (2.33). Then clearly $z_{1}^{k}$ is the origin and the distance between any two $z_{l}^{k} \mathrm{~s}$ is comparable to 1 . So we assume, $B\left(z_{l}^{k}, \delta\right)$ are mutually disjoint for some small $\delta>0$. The definition of $v_{i}^{k}$ clearly implies that

Let $I_{1}$ be the set of convergent components after scaling according to the maximum of all components. Then using previous discussion we have

\end{aligned}\right.
$$

for some $\delta>0$. Here we use $\left(\sigma_{1}^{k}, \ldots, \sigma_{n}^{k}\right)$ and $\left(m_{1}^{k}, \ldots, m_{n}^{k}\right)$ to denote the energy around $p_{1, k}$ :

If we use $\left(\bar{\sigma}_{1}^{k}, \ldots, \bar{\sigma}_{n}^{k}\right)$ and $\left(\bar{m}_{1}^{k}, \ldots, \bar{m}_{n}^{k}\right)$ to denote energy around another bubbling disk in this group. Lemma 2.4 gives

The equation for $\left(\bar{\sigma}_{1}^{k}, \ldots, \bar{\sigma}_{n}^{k}\right)$ is the same. If we use $\bar{\Lambda}_{k}$ to denote the maximum around the bubbling disk that $\bar{\sigma}_{i}^{k}$ represents, the proof of Lemma2.4 gives

Next we derive the asymptotic behavior of $u_{i}^{k}$ on $\partial B_{\delta}$ for some $\delta>0$ small if the non-simple blowup phenomenon occurs. Recall that $\delta_{k}$ is the distance from 0 to a local maximum of $u_{i}^{k}$. Here we abuse the notation of $v_{i}^{k}$ by defining it slightly differently:

If we use $\bar{v}_{i}^{k}(r)$ to denote the spherical average of $v_{i}^{k}$ at $\partial B_{r}$, we have, for $r \gg 1$ ( so $B_{r}$ contains all the $N$ bubbling disks around the origin),

Thus based on the asymptotic behavior of $v_{i}^{k}$ around each of the $N$ bubbling disks, we have

=-\frac{m_{i}^{k}-2}{2}\left(\Lambda_{k}+2 N \log \delta_{k}\right)+O(1), \quad i \in I_{1}
\end{gather*}
$$

For $i \in I \backslash I_{1}$, we have

From (2.35) and (2.36) we see that even if the non-simple blowup phenomenon happens around a singular source, still the argument of Lemma 2.4 can be applied to compare the energy of two blowup points, regardless of they are simple or not. Thus under the same context of Lemma 2.4 except that we remove the simpleblowup requirement, we still have

## 3. PROOF OF THE A PRIORI ESTIMATES AND THE DEGREE COUNTING THEOREMS

## Proof of Theorem 1.1;

Let $u=\left(u_{1}, \ldots, u_{n}\right)$ be a solution of (1.4). We set

Case one: $\rho_{i}^{k} \rightarrow \rho_{i}>0$ as $k \rightarrow \infty$, for all $i \in I$.
The equation for $v^{k}$ is

Since $v_{i}^{k}$ is uniformly bounded above in any compact subset away from the blowup set, $v_{i}^{k}$ converges to $\sum_{l=1}^{N} m_{i l} G\left(x, p_{l}\right)$ uniformly in compact sets away from $\left\{p_{1}, \ldots, p_{n}\right\}$. Here we use the notation

for some $\delta>0$, such that $B\left(p_{l}, 2 \boldsymbol{\delta}\right) \cap B\left(p_{s}, \boldsymbol{\delta}\right)=\emptyset$ for all $l \neq s$. To apply the local estimate we rewrite the equation for $v_{i}^{k}$ in local coordinates. For $p \in M$, let $y=\left(y^{1}, y^{2}\right)$ be the isothermal coordinates near $p$ such that $y_{p}(p)=(0,0)$ and $y_{p}$ depends smoothly on $p$. In this coordinates $d s^{2}$ has the form

\end{equation*}

for $i \in I$ and any pair of $l, m$ between 1 and $N$.
If we use $\mu_{p_{l}}$ to represent the possible strength of the singular source at each $p_{l}$, by (2.37) we have, for each $i \in I$,

Case two: Some of $\rho_{i}^{k}$ tend to 0 . Without loss of generality we assume that $\lim _{k \rightarrow \infty} \rho_{i}^{k}=\rho_{i}>0, \quad i \in I_{1}:=\{1, \ldots, l\}, \lim _{k \rightarrow \infty} \rho_{i}^{k}=0$ for $i>l$.

Let $M_{k}=\max \left\{v_{1}^{k}, \ldots, v_{l}^{k}\right\}$ and $\bar{M}_{k}=\max \left\{v_{l+1}^{k}, \ldots, v_{n}^{k}\right\}$. We first show that

We use the same notation as in Case one. Let $p_{1}, \ldots, p_{N}$ be blowup points for $v_{i}^{k}$. The around each blowup point, say, $p_{1}$, the equation for $v^{k}$ can be written in local coordinates as (3.10) with $\tilde{v}_{i}^{k}$ and $H_{i}^{k}$ defined as in case one. Without loss of generality we assume that $\rho_{i}^{k}>0$ for all $k$ and $l+1 \leq i \leq L$ and $\rho_{i}^{k}=0$ for all $k$ and $i>L$. Then we observe from the definition of $H_{i}^{k}$ and $H_{i}^{k} \rightarrow 0$ for $l+1 \leq i \leq L$ and $H_{i}^{k}=0$ for $i>L$.

To reduce case two to case one, we need to adjust the terms involving vanishing $H_{i}^{k}$ s. To do this we let $\hat{f}_{i}^{k}$ as

\hat{H}_{i}^{k}=\left\{\begin{array}{l}
H_{i}^{k} e^{-\hat{f}_{i}^{k}}, \quad 1 \leq i \leq l, \\
\frac{H_{i}^{k}}{\rho_{i}^{k}} e^{-\hat{f}_{i}^{k}}=e^{\phi+f_{i}^{k}-\hat{f}_{i}^{k}} h_{i}, \quad l+1 \leq i \leq L, \\
e^{f_{i}^{k}}, \quad L+1 \leq i \leq n .
\end{array}\right.
$$

The definition of $\hat{H}_{i}^{k}$ immediately gives

for some $c>0$ independent of $k$. Next the equation for $\tilde{v}_{i}^{k}$ is

It is easy to see that $\max \hat{v}_{i}^{k}-M_{k} \rightarrow-\infty$ for $l+1 \leq i \leq n$. Therefore case two is reduced to case one, which gives

Proof of Theorem 1.2: The main idea of the proof of the degree counting theorem is to reduce the whole system to the single equation.
Case one: At least one of $a_{i i}>0$. We may assume $a_{11}>0$. Thanks to Theorem 1.1 the Leray-Schauder degree of (1.4) for $\rho \in \mathscr{O}_{k}$ is equal to the degree for the following specific system corresponding to $\left(\rho_{1}, 0, \ldots, 0\right)$ :

It is easy to see that $\left(\rho_{1}, 0, \ldots, 0\right) \in \mathscr{O}_{k}$, using the degree counting formula of ChenLin [14] for the single equation, we obtain the desired formula.
Case two: $a_{i i}=0$ for all $i \in I$.
Using $a_{12}>0$, we reduce the degree counting formula for $\rho \in \mathscr{O}_{k}$ to the following system:
where $\rho_{1}, \rho_{2}$ satisfy

8 \pi n_{k}\left(\rho_{1}+\rho_{2}\right)<2 a_{12} \rho_{1} \rho_{2}<8 \pi n_{k+1}\left(\rho_{1}+\rho_{2}\right)
$$

It is easy to see that $\left(\rho_{1}, \rho_{2}, 0, \ldots, 0\right) \in \mathscr{O}_{k}$. Now we consider the special case $\rho_{1}=$ $\rho_{2}, h_{1}=h_{2}=h$. In this case a simple application of the maximum principle gives $u_{1}=u_{2}+C$, since they both have average equal to 0 , we have $u_{1}=u_{2}$. Then the first two equations in (3.17) turn out to be

$$
\Delta_{g} u+a_{12} \rho\left(\frac{h e^{u}}{\int_{M} h e^{u} d V_{g}}-1\right)=0
$$

where $\rho \in\left(8 \pi n_{k}, 8 \pi n_{k+1}\right)$. Again the degree counting formula of Chen-Lin [14] for the single equation gives the desired formula. Theorem 1.2 is established.

Remark 3.1. The proof of Theorem 1.3 requires that there is no blowup point on $\partial \Omega$. Since all the singular sources are in the interior of $\Omega$, a standard moving plane argument can be employed to prove this fact. The interested readers may read into [33] for the detail of the proof. Then the remaining part is similar to the proof of Theorem 1.2

Finally we prove Theorem 1.4: Since the genus of the torus $M$ is $1, \chi(M)=0$ and the generating function is

$$
\begin{aligned}
g(x) & =\Pi_{p=1}^{N} \frac{1-x^{\mu_{p}}}{1-x}=\Pi_{p=1}^{N}\left(1+x+x^{2}+\ldots+x^{\gamma_{p}}\right) \\
& =1+b_{1} x+b_{2} x^{2}+\ldots+b_{k} x^{k}+\ldots+x^{m} .
\end{aligned}
$$

where $m=\sum_{p} \gamma_{p}$. Let

$$
\rho_{i}=\left(\sum_{j \in I} a^{i j}\right) 4 \pi \sum_{p=1}^{N} \gamma_{p},
$$

it is easy to see that

$$
8 \pi n_{k} \sum_{i} \rho_{i}<\sum_{i j} a_{i j} \rho_{i} \rho_{j}<8 \pi n_{k+1} \sum_{i} \rho_{i}
$$

for $n_{k}=(m-1) / 2$ and $n_{k+1}=(m+1) / 2$. Thus the Leray-Schauder degree $d_{\rho}$ can be computed as

$$
d_{\rho}=\sum_{l=0}^{(m-1) / 2} b_{l} .
$$

Using $b_{m-l}=b_{l}$ for $l=0,1, . ., m$ we further write $d_{\rho}$ as

$$
d_{\rho}=\frac{1}{2} \sum_{l=1}^{m} b_{l}=\frac{g(1)}{2}=\frac{\Pi_{p=1}^{N}\left(1+\gamma_{p}\right)}{2} .
$$

Theorem 1.4 is established.
