NORM-PARALLELISM AND THE DAVIS–WIELANDT RADIUS OF HILBERT SPACE OPERATORS

Abstract. We present a necessary and sufficient condition for the normparallelism of bounded linear operators on a Hilbert space. We also give a characterization of the Birkhoff–James orthogonality for Hilbert space operators. Moreover, we discuss the connection between norm-parallelism to the identity operator and an equality condition for the Davis–Wielandt radius. Some other related results are also discussed.

1. Introduction and preliminaries

Let $\mathbb{B}(\mathcal{H})$ denote the C^* -algebra of all bounded linear operators on a complex Hilbert space H with an inner product $\langle \cdot, \cdot \rangle$ and the corresponding norm $\|\cdot\|$. The symbol I stands for the identity operator on H. For $T \in \mathbb{B}(\mathcal{H})$, let $||T||$ and $m(T)$ denote the usual operator norm and the minimum modulus of T, respectively. Here $m(T)$ is defined to be the supremum of the set of all $\alpha \geq 0$ such that $||Tx|| \ge \alpha ||x||$ for all $x \in \mathcal{H}$. In addition, we denote by M_T the set of all unit vectors at which T attains its norm, i.e.,

$$
\mathbb{M}_T = \{ x \in \mathcal{H} : ||x|| = 1, ||Tx|| = ||T|| \}.
$$

The notion of orthogonality in $\mathbb{B}(\mathcal{H})$ can be introduced in many ways; see [\[1,](#page-9-0) [11\]](#page-9-1) and references therein. When $T, S \in \mathbb{B}(\mathcal{H})$, we say that T is Birkhoff–James orthogonal to S, and we write $T \perp_B S$, if

$$
||T + \gamma S|| \ge ||T|| \qquad (\gamma \in \mathbb{C}).
$$

This notion of orthogonality plays a very important role in the geometry of Hilbert space operators. Furthermore, we say that $T \in \mathbb{B}(\mathcal{H})$ is norm-parallel to $S \in \mathbb{B}(\mathcal{H})$ (see [\[19\]](#page-10-0)), in short T $\parallel S$, if there exists $\lambda \in \mathbb{T} = \{ \alpha \in \mathbb{C} : |\alpha| = 1 \}$ such that

$$
||T + \lambda S|| = ||T|| + ||S||.
$$

In the context of bounded linear operators, the well-known Daugavet equation $||T + I|| = ||T|| + 1$ is a particular case of parallelism. Such equation is a useful property in solving a variety of problems in approximation theory; see [\[15,](#page-10-1) [19\]](#page-10-0) and the references therein. Some characterizations of the norm-parallelism for

Hilbert space operators and elements of an arbitrary Hilbert C^* -module were given in [\[6,](#page-9-3) [15,](#page-10-1) [17,](#page-10-2) [19,](#page-10-0) [20\]](#page-10-3).

The numerical radius and the Crawford number of $T \in \mathbb{B}(\mathcal{H})$ are defined by

$$
w(T) = \sup \{ |\langle Tx, x \rangle| : x \in \mathcal{H}, ||x|| = 1 \}
$$

and

$$
c(T) = \inf \{ |\langle Tx, x \rangle| : x \in \mathcal{H}, ||x|| = 1 \},\
$$

respectively. These concepts are useful in studying linear operators and have attracted the attention of many authors in the last few decades (e.g., see [\[7\]](#page-9-5), and their references). It is well known that $w(\cdot)$ defines a norm on $\mathbb{B}(\mathcal{H})$ such that for all $T \in \mathbb{B}(\mathcal{H}),$

$$
\frac{1}{2}||T|| \le w(T) \le ||T||. \tag{1.1}
$$

The inequalities in (1.1) are sharp. The first inequality becomes an equality if $T^2 = 0$. The second inequality becomes an equality if T is normal. Another basic fact about the numerical radius is the power inequality, which asserts that

$$
w(T^n) \le w^n(T) \qquad (n = 1, 2, \cdots)
$$

for all $T \in \mathbb{B}(\mathcal{H})$. For more material about the numerical radius and other results on numerical radius inequality, see, e.g., [\[3,](#page-9-6) [5,](#page-9-7) [8,](#page-9-8) [16\]](#page-10-4), and the references therein.

Motivated by theoretical study and applications, there have been many generalizations of the numerical radius; see [\[7,](#page-9-5) [10\]](#page-9-9). One of these generalizations is the Davis–Wielandt radius of $T \in \mathbb{B}(\mathcal{H})$ defined by

$$
dw(T) = \sup \{ \sqrt{|\langle Tx, x \rangle|^2 + ||Tx||^4} : x \in \mathcal{H}, ||x|| = 1 \};
$$

see [\[4,](#page-9-10) [14\]](#page-10-5). For $T, S \in \mathbb{B}(\mathcal{H})$ one has

(i) $dw(T) > 0$ and $dw(T) = 0$ if an (i) $dw(T) \geq 0$ and $dw(T) = 0$ if and only if $T = 0$; (ii) $dw(\alpha T)$ $\sqrt{ }$ \int $\overline{\mathcal{L}}$ $\geq |\alpha|dw(T)$ if $|\alpha| > 1$, $= |\alpha|dw(T)$ if $|\alpha| = 1$, $\leq |\alpha|d w(T)$ if $|\alpha| < 1$, for all $\alpha \in \mathbb{C}$;

(ii)
$$
dw(T+S) \le \sqrt{2(dw(T) + dw(S)) + 4(dw(T) + dw(S))^{2}}
$$
,

and therefore $dw(\cdot)$ cannot be a norm on $\mathbb{B}(\mathcal{H})$. In spite of this, it has many interesting properties. The following property of $dw(\cdot)$ is immediate:

$$
\max\left\{w(T), \|T\|^2\right\} \le dw(T) \le \sqrt{w^2(T) + \|T\|^4}.\tag{1.2}
$$

We remark that the upper bound and lower bound in (1.2) are both attainable. In fact, if $T = \begin{bmatrix} 1 & 0 \\ 0 & 0 \end{bmatrix}$ and $S = \begin{bmatrix} 0 & 1 \\ 0 & 0 \end{bmatrix}$, then simple computations show that $dw(T) = \sqrt{w^2(T) + ||T||^4} = \sqrt{2}$ and max $\{w(S), ||S||^2\} = dw(S) = 1.$

This paper is organized as follows. In the second section, we present a necessary and sufficient condition for $T \in \mathbb{B}(\mathcal{H})$ to be norm-parallel to $S \in \mathbb{B}(\mathcal{H})$. We also give a characterization of the Birkhoff–James orthogonality in $\mathbb{B}(\mathcal{H})$ for Hilbert space operators. Moreover, we obtain some new refinements of numerical radius inequalities for Hilbert space operators. In Section 3, the relation of the normparallelism of operators and their Davis–Wielandt radii is discussed. In particular,

we show that T || I if and only if $dw(T) = \sqrt{w^2(T) + ||T||^4}$. Some other related results are also presented.

2. Characterization of norm-parallelism and Birkhoff–James ORTHOGONALITY OF OPERATORS

We begin with a useful lemma which we will use frequently in the present paper.

Lemma 2.1. *Let* H *be a Hilbert space and* $a, b \in H$ *. Then*

$$
\|a + \gamma b\|^2 \|b\|^2 - |\langle a + \gamma b, b \rangle|^2 = \|a\|^2 \|b\|^2 - |\langle a, b \rangle|^2 \qquad (\gamma \in \mathbb{C}).
$$

Proof. The proof is straightforward so we omit it. □

Remark 2.2*.* According to the above lemma, we have

$$
||b||^2 \inf_{\gamma \in \mathbb{C}} ||a + \gamma b||^2 = ||a||^2 ||b||^2 - |\langle a, b \rangle|^2 \qquad (a, b \in \mathcal{H}) \tag{2.1}
$$

which is a well-known identity. In particular, a and b are linearly dependent if and only if $\inf_{\gamma \in \mathbb{C}} ||a + \gamma b||^2 = 0$, that is, if and only if $|\langle a, b \rangle| = ||a|| ||b||$. Further, The equality (2.1) shows that two elements a and b of a Hilbert space are orthogonal in the sense of the inner product precisely when they are the Birkhoff–James orthogonal, that is, $\inf_{\gamma \in \mathbb{C}} ||a + \gamma b|| = ||a||.$

For elements $T, S \in \mathbb{B}(\mathcal{H})$, it was proved in [\[19,](#page-10-0) Theorem 3.3] that $T \parallel S$ if and only if there exists a sequence of unit vectors $\{x_n\}$ in $\mathcal H$ such that

$$
\lim_{n \to \infty} |\langle Tx_n, Sx_n \rangle| = ||T|| ||S||. \tag{2.2}
$$

It follows then that if the Hilbert space $\mathcal H$ is finite dimensional, $T \parallel S$ if and only if there exists a unit vector $x \in \mathcal{H}$ such that $|\langle Tx, Sx \rangle| = ||T|| ||S||$. Notice that the condition of finite dimensionality is essential (see [\[20,](#page-10-3) Example 2.17]). In addition, for compact operators T, S on a Hilbert space H (not necessarily finite dimensional) it was proved in [\[17,](#page-10-2) Theorem 2.10] that $T \parallel S$ if and only if there exists $x \in M_T \cap M_S$ such that

$$
|\langle Tx, Sx \rangle| = ||T|| ||S||. \tag{2.3}
$$

Next we obtain a necessary and sufficient condition for $T \in \mathbb{B}(\mathcal{H})$ to be normparallel to $S \in \mathbb{B}(\mathcal{H})$.

Theorem 2.3. Let H be a Hilbert space and $T, S \in \mathbb{B}(\mathcal{H})$ be compact operators. *Then the following statements are equivalent:*

- (i) T \parallel *S*.
- (ii) *There exists* $x \in \mathbb{M}_T \cap \mathbb{M}_S$ *such that for every* $\gamma \in \mathbb{C}$ *the vectors* $Tx + \gamma Sx$ *and* Sx *are linearly dependent.*

Proof. (i)⇒(ii) Let T || S. From [\(2.3\)](#page-2-1), there exists $x \in M_T \cap M_S$ such that $|\langle Tx, Sx \rangle| = ||T|| ||S||$. Choose $a = Tx$ and $b = Sx$ in Lemma [2.1](#page-2-2) to get

$$
||Tx + \gamma Sx||^{2}||Sx||^{2} - |\langle Tx + \gamma Sx, Sx \rangle|^{2} = ||Tx||^{2}||Sx||^{2} - |\langle Tx, Sx \rangle|^{2}, \quad (2.4)
$$

for all $\gamma \in \mathbb{C}$. It follows from [\(2.4\)](#page-2-3) that

$$
||Tx + \gamma Sx||^2||Sx||^2 - |\langle Tx + \gamma Sx, Sx \rangle|^2 = 0,
$$

or equivalently,

$$
|\langle Tx + \gamma Sx, Sx \rangle| = ||Tx + \gamma Sx|| ||Sx|| \qquad (\gamma \in \mathbb{C}).
$$

By the condition for equality in the Cauchy–Schwarz inequality we conclude that the vectors $Tx + \gamma Sx$ and Sx are linearly dependent.

The implication (ii) \Rightarrow (i) follows also by the same argument.

For $T, S \in \mathbb{B}(\mathcal{H})$, Bhatia and Šemrl [[1,](#page-9-0) Theorem 1.1 and Remark 3.1] proved that $T \perp_B S$ if and only if there exists a sequence of unit vectors $\{x_n\}$ in H such that

$$
\lim_{n \to \infty} ||Tx_n|| = ||T|| \text{ and } \lim_{n \to \infty} \langle Tx_n, Sx_n \rangle = 0.
$$

For a compact operator T on H and $S \in \mathbb{B}(\mathcal{H})$ it was shown in [\[13,](#page-10-6) Corollary 2.6] that $T \perp_B S$ if and only if there exists $x \in \mathbb{M}_T$ such that

$$
\langle Tx, Sx \rangle = 0. \tag{2.5}
$$

In the following, we give a characterization of the Birkhoff–James orthogonality for operators in $\mathbb{B}(\mathcal{H})$.

Theorem 2.4. Let $T, S \in \mathbb{B}(\mathcal{H})$ and suppose that T is compact. Then the fol*lowing statements are equivalent:*

- (i) $T \perp_B S$.
- (ii) *There exists* $x \in M_T$ *such that for every* $\gamma \in \mathbb{C}$

$$
||Tx + \gamma Sx||^2 = ||Tx||^2 + |\gamma|^2 ||Sx||^2.
$$

Proof. (i)⇒(ii) Let $T \perp_B S$. By [\(2.5\)](#page-3-0), there exists $x \in \mathbb{M}_T$ such that $\langle Tx, Sx \rangle =$ 0. As in the proof of Theorem [2.3,](#page-2-4) equality [\(2.4\)](#page-2-3) gives

$$
||Tx + \gamma Sx||^{2}||Sx||^{2} - |\gamma|^{2}||Sx||^{4} = ||Tx||^{2}||Sx||^{2},
$$

and hence

$$
||Tx + \gamma Sx||^{2} = ||Tx||^{2} + |\gamma|^{2}||Sx||^{2} \qquad (\gamma \in \mathbb{C}).
$$

The same proof works for the implication (ii) \Rightarrow (i).

Recently, Turnšek [\[13\]](#page-10-6) introduced a weaker notions of operator Birkhoff-James orthogonality. It is said that $T \in \mathbb{B}(\mathcal{H})$ is r-orthogonal to $S \in \mathbb{B}(\mathcal{H})$, denoted by $T \perp_B^r S$ if $||T + \gamma S|| \ge ||T||$ for all $\gamma \in \mathbb{R}$. Some applications of the r-orthogonality in the geometry of Hilbert space operators can be found in [\[13\]](#page-10-6). In [\[13,](#page-10-6) Corollary 2.6] (see also [\[2,](#page-9-2) Theorem 2.6]) the author proved that for compact operator T on \mathcal{H} and $S \in \mathbb{B}(\mathcal{H})$, we have $T \perp_B^r S$ if and only if there exists $x \in \mathbb{M}_T$ such that

$$
Re\langle Tx, Sx\rangle = 0.
$$
\n(2.6)

We next give a characterization of r-orthogonality of operators in $\mathbb{B}(\mathcal{H})$.

Theorem 2.5. Let $T, S \in \mathbb{B}(\mathcal{H})$ and suppose that T is compact. Then the fol*lowing statements are equivalent:*

$$
\sqcup
$$

- (i) $T \perp_B^r S$.
- (ii) *There exists* $x \in M_T$ *such that for every* $\gamma \in \mathbb{R}$

$$
||Tx + \gamma Sx||^2 = ||Tx||^2 + \gamma^2 ||Sx||^2.
$$

Proof. Let $a, b \in \mathcal{H}$. A direct calculation shows that

$$
\|a + \gamma b\|^2 \|b\|^2 - (\text{Re}\langle a + \gamma b, b \rangle)^2 = \|a\|^2 \|b\|^2 - (\text{Re}\langle a, b \rangle)^2 \qquad (\gamma \in \mathbb{R}). \tag{2.7}
$$

As in the proof of Theorem [2.4,](#page-3-1) the equivalence (i)⇔(ii) follows from [\(2.6\)](#page-3-2) and (2.7). The details are left to the reader. [\(2.7\)](#page-4-0). The details are left to the reader.

We finish this section with some new refinements of numerical radius inequalities for Hilbert space operators. The following auxiliary results are needed.

Lemma 2.6. [\[5\]](#page-9-7) *If* $a, b, e \in \mathcal{H}$ *and* $||e|| = 1$ *, then*

$$
2|\langle a,e\rangle\langle e,b\rangle| \le ||a|| ||b|| + |\langle a,b\rangle|.
$$

Lemma 2.7. [\[18,](#page-10-7) Corollary 2.3] *Let* $T \in \mathbb{B}(\mathcal{H})$ *. Then*

$$
||T||2 + c2(T) \le ||Tx||2 + |\langle Tx, x \rangle|2 \le 4w2(T) \qquad (x \in \mathcal{H}, ||x|| = 1).
$$

Theorem 2.8. *Let* $T \in \mathbb{B}(\mathcal{H})$ *and* $\xi \in \mathbb{C} - \{0\}$ *. Then*

(i)
$$
||T||^2 - w^2(T) \le \inf_{\gamma \in \mathbb{C}} \left\{ ||T - \gamma I||^2 - c^2(T - \gamma I) \right\}.
$$

\n(ii) $\left(1 - \frac{||T - \xi I||^2}{|\xi|^2}\right) ||T||^2 \le w^2(T) - \frac{c^2(T^*T - \xi T^*)}{|\xi|^2}.$
\n(iii) $w^2(T) - w(T^2) \le \inf_{\gamma \in \mathbb{C}} \left\{ \frac{||T - \gamma T^*||^2 ||T||^2 - c^2(T^2 - \gamma TT^*)}{||T||^2 + c^2(T)} \right\}.$

Proof. (i) Suppose that $x \in \mathcal{H}$ with $||x|| = 1$. Choose $a = Tx$ and $b = -x$ in Lemma [2.1](#page-2-2) to give

$$
||Tx||^2 - |\langle Tx, x \rangle|^2 = ||Tx - \gamma x||^2 - |\langle Tx - \gamma x, x \rangle|^2 \qquad (\gamma \in \mathbb{C}),
$$

whence

$$
||Tx||^2 - |\langle Tx, x \rangle|^2 \le ||T - \gamma I||^2 - c^2 (T - \gamma I) \qquad (\gamma \in \mathbb{C}).
$$

Thus

$$
||Tx||^2 - |\langle Tx, x \rangle|^2 \le \inf_{\gamma \in \mathbb{C}} \left\{ ||T - \gamma I||^2 - c^2 (T - \gamma I) \right\}.
$$
 (2.8)

Now, if we take the supremum over all $x \in \mathcal{H}$ with $||x|| = 1$ in [\(2.8\)](#page-4-1), then we get

$$
||T||^2 - w^2(T) \le \inf_{\gamma \in \mathbb{C}} \{ ||T - \gamma I||^2 - c^2(T - \gamma I) \}.
$$

(ii) Put $a = -\xi x$, $b = Tx$ and $\gamma = 1$, where $x \in \mathcal{H}$, $||x|| = 1$, in Lemma [2.1.](#page-2-2) We get

$$
|\xi|^2 \|Tx\|^2 - |\xi|^2 |\langle x, Tx \rangle|^2 = \| - \xi x + Tx\|^2 \|Tx\|^2 - |\langle -\xi x + Tx, Tx \rangle|^2.
$$

Thus

$$
||Tx||^{2} - |\langle Tx, x \rangle|^{2} = ||Tx||^{2} \frac{||Tx - \xi x||^{2}}{|\xi|^{2}} - \frac{|\langle T^{*}Tx - \xi T^{*}x, x \rangle|^{2}}{|\xi|^{2}},
$$

which implies

$$
||Tx||^2 - |\langle Tx, x \rangle|^2 \le ||T||^2 \frac{||T - \xi I||^2}{|\xi|^2} - \frac{c^2 (T^*T - \xi T^*)}{|\xi|^2}.
$$

Taking the supremum over all $x \in \mathcal{H}$, $||x|| = 1$, we deduce

$$
||T||^2 - w^2(T) \le ||T||^2 \frac{||T - \xi I||^2}{|\xi|^2} - \frac{c^2 (T^*T - \xi T^*)}{|\xi|^2},
$$

and then also $\left(1 - \frac{||T - \xi I||^2}{|\xi|^2}\right)$ $\frac{-\xi I\|^2}{|\xi|^2}$ $||T||^2 \leq w^2(T) - \frac{c^2(T^*T - \xi T^*)}{|\xi|^2}$ $\frac{1-\xi I}{|\xi|^2}.$

(iii) Put $a = Tx$ and $b = -T^*x$, where $x \in \mathcal{H}$, $||x|| = 1$, in Lemma [2.1.](#page-2-2) For any $\gamma \in \mathbb{C}$, we deduce that

$$
||Tx||^2||T^*x||^2 - |\langle Tx, T^*x \rangle|^2 = ||Tx - \gamma T^*x||^2||T^*x||^2 - |\langle Tx - \gamma T^*x, T^*x \rangle|^2,
$$

that is

$$
||Tx||^{2}||T^{*}x||^{2} = |\langle T^{2}x, x \rangle|^{2} + ||Tx - \gamma T^{*}x||^{2}||T^{*}x||^{2} - |\langle T^{2}x - \gamma TT^{*}x, x \rangle|^{2}.
$$

This ensures

$$
||Tx||^2||T^*x||^2 \le w^2(T^2) + ||T - \gamma T^*||^2||T||^2 - c^2(T^2 - \gamma TT^*).
$$
 (2.9)

Now, putting $a = Tx$, $b = T^*x$ and $e = x$ in Lemma [2.6](#page-4-2) gives

$$
2|\langle Tx, x\rangle\langle x, T^*x\rangle| \le ||Tx|| ||T^*x|| + |\langle Tx, T^*x\rangle|,
$$

whence

$$
2|\langle Tx,x\rangle|^2 \le ||Tx|| ||T^*x|| + |\langle T^2x,x\rangle|.
$$

Thus

$$
2|\langle Tx, x\rangle|^2 \le ||Tx|| ||T^*x|| + w(T^2). \tag{2.10}
$$

By (2.9) and (2.10) , we obtain

$$
2|\langle Tx, x\rangle|^2 \le \sqrt{w^2(T^2) + ||T - \gamma T^*||^2 ||T||^2 - c^2(T^2 - \gamma TT^*)} + w(T^2).
$$

Taking the supremum in the above inequality over all $x \in \mathcal{H}$, $||x|| = 1$, we get

$$
2w^{2}(T) \leq \sqrt{w^{2}(T^{2}) + ||T - \gamma T^{*}||^{2}||T||^{2} - c^{2}(T^{2} - \gamma TT^{*})} + w(T^{2}),
$$

or equivalently,

$$
(2w^{2}(T) - w(T^{2}))^{2} \le w^{2}(T^{2}) + ||T - \gamma T^{*}||^{2}||T||^{2} - c^{2}(T^{2} - \gamma TT^{*}).
$$

This yields

$$
w^{2}(T) - w(T^{2}) \le \frac{||T - \gamma T^{*}||^{2}||T||^{2} - c^{2}(T^{2} - \gamma TT^{*})}{4w^{2}(T)}.
$$

Furthermore, by Lemma [2.7](#page-4-3) we have $||T||^2 + c^2(T) \le 4w^2(T)$. So, from the above inequality we get

$$
w^{2}(T) - w(T^{2}) \le \frac{\|T - \gamma T^{*}\|^{2} \|T\|^{2} - c^{2}(T^{2} - \gamma TT^{*})}{\|T\|^{2} + c^{2}(T)}
$$
 (\gamma \in \mathbb{C}).

Finally we conclude that

$$
w^{2}(T) - w(T^{2}) \le \inf_{\gamma \in \mathbb{C}} \left\{ \frac{\|T - \gamma T^{*}\|^{2} \|T\|^{2} - c^{2}(T^{2} - \gamma TT^{*})}{\|T\|^{2} + c^{2}(T)} \right\}.
$$

3. Norm-parallelism of operators and an equality condition for the Davis–Wielandt radius

To establish the following result we use some ideas of [\[9,](#page-9-11) Lemma 1].

Theorem 3.1. *Let* $T \in \mathbb{B}(\mathcal{H})$ *. Then the following conditions are equivalent:*

- (i) $T \parallel I$.
- (ii) $dw(T) = \sqrt{w^2(T) + ||T||^4}.$

Proof. (i)⇒(ii) Let T || I. From [\(2.2\)](#page-2-5), there exists a sequence of unit vectors ${x_n}$ in H such that

$$
\lim_{n \to \infty} |\langle Tx_n, x_n \rangle| = ||T||. \tag{3.1}
$$

We have

$$
\left| \langle Tx_n, x_n \rangle \right| \le \|Tx_n\| \le \|T\| \quad \text{and} \quad \left| \langle Tx_n, x_n \rangle \right| \le w(T) \le \|T\|. \tag{3.2}
$$

Hence, by (3.1) and (3.2) , we obtain

$$
\lim_{n \to \infty} ||Tx_n|| = ||T|| \quad \text{and} \quad \lim_{n \to \infty} |\langle Tx_n, x_n \rangle| = w(T). \quad (3.3)
$$

Also, by the definition of $dw(T)$ we have

$$
\sqrt{|\langle Tx_n, x_n \rangle|^2 + ||Tx_n||^4} \le dw(T) \le \sqrt{w^2(T) + ||T||^4}
$$
\n(3.4)

It follows from (3.3) and (3.4) that

$$
dw(T) = \sqrt{w^2(T) + ||T||^4}
$$

(ii) \Rightarrow (i) Let $dw(T) = \sqrt{w^2(T) + ||T||^4}$. So, by the definition of $dw(T)$, there exists a sequence of unit vectors $\{x_n\}$ in H such that

$$
\lim_{n \to \infty} \sqrt{|\langle Tx_n, x_n \rangle|^2 + ||Tx_n||^4} = \sqrt{w^2(T) + ||T||^4}.
$$

Then we have

$$
\lim_{n \to \infty} |\langle Tx_n, x_n \rangle| = w(T) \quad \text{and} \quad \lim_{n \to \infty} ||Tx_n|| = ||T||. \quad (3.5)
$$

Our aim is to show that $w(T) = ||T||$, and hence by [\(3.5\)](#page-6-4) we obtain

$$
\lim_{n \to \infty} |\langle Tx_n, x_n \rangle| = ||T||,
$$

or equivalently $T \parallel I$. Write

$$
Tx_n = \alpha_n x_n + \beta_n y_n \tag{3.6}
$$

with $\langle x_n, y_n \rangle = 0$, $||y_n|| = 1$ and $\alpha_n, \beta_n \in \mathbb{C}$. It follows from [\(3.5\)](#page-6-4) and [\(3.6\)](#page-6-5) that $\alpha_n = \langle Tx_n, x_n \rangle, \, \beta_n = \langle Tx_n, y_n \rangle, \, \lim_{n \to \infty} |\alpha_n| = w(T)$ and $\lim_{n \to \infty} |\alpha_n|^2 + |\beta_n|^2 = ||T||^2.$

Put
$$
\gamma_n = \langle Ty_n, x_n \rangle
$$
, $\delta_n = \langle Ty_n, y_n \rangle$ and $T_n = \begin{bmatrix} \alpha_n & \gamma_n \\ \beta_n & \delta_n \end{bmatrix}$. Since
 $|\alpha_n| \leq w(T_n) \leq w(T)$

then

$$
\lim_{n \to \infty} w(T_n) = w(T). \tag{3.7}
$$

Furthermore, we have

$$
|\alpha_n|^2 \leq w \left(\begin{bmatrix} |\alpha_n|^2 & \frac{\overline{\alpha}_n \gamma_n + \alpha_n \overline{\beta}_n}{2} \\ \frac{\overline{\alpha}_n \beta_n + \alpha_n \overline{\gamma}_n}{2} & \frac{\overline{\alpha}_n \delta_n + \alpha_n \overline{\delta}_n}{2} \end{bmatrix} \right) = w \left(\text{Re}(\overline{\alpha}_n T_n) \leq w(\overline{\alpha}_n T_n) \leq w^2(T) \right).
$$

Thus $\lim_{n\to\infty} w(\text{Re}(\overline{\alpha}_nT_n) = w^2(T)$ and $\lim_{n\to\infty} \frac{\overline{\alpha}_n\gamma_n+\alpha_n\beta_n}{2} = 0$. It follows that $\lim_{n \to \infty} |\gamma_n| = \lim_{n \to \infty} |\beta_n|.$ (3.8)

On the other hands, we have

$$
T_n^*T_n = \begin{bmatrix} |\alpha_n|^2 + |\beta_n|^2 & \overline{\alpha}_n \gamma_n + \overline{\beta}_n \delta_n \\ \alpha_n \overline{\gamma}_n + \beta_n \overline{\delta}_n & |\gamma_n|^2 + |\delta_n|^2 \end{bmatrix}.
$$

Therefore, we obtain

$$
|\alpha_n|^2 + |\beta_n|^2 \le ||T_n^*T_n|| = ||T_n||^2 \le ||T||^2.
$$

It follows from the above inequality that $\lim_{n\to\infty} ||T_n^*T_n|| = ||T||^2$ and hence we get $\lim_{n\to\infty} \overline{\alpha}_n \gamma_n + \beta_n \delta_n = 0$. This yields

$$
\lim_{n \to \infty} |\delta_n| = \lim_{n \to \infty} |\alpha_n|.
$$
\n(3.9)

By (3.8) and (3.9) we reach

$$
\lim_{n \to \infty} |\gamma_n|^2 + |\delta_n|^2 = \lim_{n \to \infty} |\alpha_n|^2 + |\beta_n|^2 = ||T||^2,
$$

from which we get

$$
\lim_{n \to \infty} T_n^* T_n = \begin{bmatrix} ||T||^2 & 0 \\ 0 & ||T||^2 \end{bmatrix}.
$$

It follows that

$$
\lim_{n \to \infty} w(T_n) = ||T||. \tag{3.10}
$$

From [\(3.7\)](#page-7-2) and [\(3.10\)](#page-7-3) we conclude that $w(T) = ||T||$.

As a consequence of Theorem [3.1,](#page-6-6) we have the following result.

Corollary 3.2. *Let* $T \in \mathbb{B}(\mathcal{H})$ *. Then the following conditions are equivalent:*

(i) $dw(T) = \sqrt{w^2(T) + ||T||^4}.$ (ii) $w(T) = ||T||$. (iii) $dw(T) = ||T|| \sqrt{1 + ||T||^2}$. (iv) $T^*T \leq w^2(T)I$.

Proof. The equivalence (i) \Leftrightarrow (ii) follows from the proof of Theorem [3.1.](#page-6-6)

- (i)⇒(iii) This implication follows from the equivalence (i)⇔(ii).
- $(iii) \Rightarrow (i)$ Let (iii) holds. Since $w(T) \leq ||T||$, we have

$$
||T||\sqrt{1+||T||^2} = dw(T) \le \sqrt{w^2(T) + ||T||^4} \le ||T||\sqrt{1+||T||^2},
$$

and so $dw(T) = \sqrt{w^2(T) + ||T||^4}$.

(i)⇔(iv) By the equivalence (i)⇔(ii), $dw(T) = \sqrt{w^2(T) + ||T||^4}$ if and only if $w(T) = ||T||$, that is, $||Tx|| \leq w(T)||x||$ for all $x \in \mathcal{H}$. This is equivalent to $||Tx||^2 \leq w^2(T)||x||^2$ for all $x \in \mathcal{H}$, that is, $\langle Tx, Tx \rangle \leq \langle w^2(T)x, x \rangle$ for all $x \in \mathcal{H}$, and finally $\langle T^*Tx - w^2(T)x, x \rangle \leq 0$ for all $x \in \mathcal{H}$, or equivalently, $T^*T \leq w^2$ $(T)I.$

Recall that if $x, y \in \mathcal{H}$, then $||x \otimes y|| = ||x|| ||y||$ and $w(x \otimes y) = \frac{1}{2} (|\langle x, y \rangle| + ||x|| ||y||)$, where $x \otimes y$ is the rank one operator defined by $(x \otimes y)(z) := \langle z, y \rangle x$ for all $z \in \mathcal{H}$.

Corollary 3.3. *For* $x, y \in \mathcal{H}$ *, the following conditions are equivalent:*

- (ii) $dw(x \otimes y) = \sqrt{w^2(x \otimes y) + ||x \otimes y||^4}.$
- (ii) *The vectors* x *and* y *are linearly dependent.*

Proof. This follows form the equivalence (i) \Leftrightarrow (ii) of Corollary [3.2.](#page-7-4)

For $T \in \mathbb{B}(\mathcal{H})$ the following results were obtained in [\[19\]](#page-10-0):

 $T \parallel I \Leftrightarrow T \parallel T^*$ and $T \parallel I \Leftrightarrow T^*T \parallel T^*$ (3.11)

As an immediate consequence of (2.2) , (3.11) and Theorem [3.1,](#page-6-6) we have the following result.

Corollary 3.4. *Let* $T \in \mathbb{B}(\mathcal{H})$ *. The following statements are equivalent:*

- (i) $dw(T) = \sqrt{w^2(T) + ||T||^4}.$
- (ii) *There exists a sequence of unit vectors* $\{x_n\}$ *in* $\mathcal H$ *such that*

$$
\lim_{n \to \infty} |\langle T^2 x_n, x_n \rangle| = ||T||^2.
$$

(iii) There exists a sequence of unit vectors $\{x_n\}$ in $\mathcal H$ such that

$$
\lim_{n \to \infty} |\langle TT^*Tx_n, x_n \rangle| = ||T||^3.
$$

Corollary 3.5. Let H be a finite dimensional Hilbert space and $T \in \mathbb{B}(\mathcal{H})$. The *following statements are equivalent:*

- (i) $dw(T) = \sqrt{w^2(T) + ||T||^4}.$
- (ii) *There exists a unit vector* $x \in \mathcal{H}$ *such that* $|\langle Tx, x \rangle| = ||T||$ *.*
- (iii) *There exists* $x \in M_T$ *such that for every* $\gamma \in \mathbb{C}$ *the vectors* $Tx + \gamma x$ *and* x *are linearly dependent.*

Proof. This follows immediately form (2.3) and Theorems [3.1,](#page-6-6) [2.3.](#page-2-4)

The following example shows that the condition of finite dimensionality in the implication (i)⇒(ii) of Corollary [3.5](#page-8-1) is essential.

Example 3.6. Consider the shift operator $T : \ell^2 \longrightarrow \ell^2$ defined by

$$
T(\xi_1, \xi_2, \xi_3, \cdots) = (0, \xi_1, \xi_2, \xi_3, \cdots).
$$

One can easily observe that $dw(T) = \sqrt{w^2(T) + ||T||^4} = \sqrt{2}$, but there is no unit vector $x \in \ell^2$ such that $|\langle Tx, x \rangle| = ||T||$.

For a subspace \mathcal{H}_0 of a Hilbert space \mathcal{H} let $\mathbb{S}_{\mathcal{H}_0} = \{x \in \mathcal{H}_0 : ||x|| = 1\}$ and $||T||_{\mathcal{H}_0^{\perp}} = \sup \{ ||Tx|| : x \in \mathcal{H}_0^{\perp}, ||x|| = 1 \}.$ Let us quote a result from [\[20\]](#page-10-3).

Lemma 3.7. *Let* $T \in \mathbb{B}(\mathcal{H})$ *. If* $\mathbb{S}_{\mathcal{H}_0} = \mathbb{M}_T$ *, where* \mathcal{H}_0 *is a finite dimensional sub*space of H and $||T||_{\mathcal{H}_0^{\perp}} < ||T||$. Then for any $S \in \mathbb{B}(\mathcal{H})$ the following statements *are equivalent:*

- (i) T \parallel *S*.
- (ii) *There exists a unit vector* $x \in \mathcal{H}_0$ *such that* $|\langle Tx, Sx \rangle| = ||T|| ||S||$.

As an immediate consequence of Theorem [3.1](#page-6-6) and Lemma [3.7,](#page-9-12) we have the following result.

Corollary 3.8. Let $T \in \mathbb{B}(\mathcal{H})$. If $\mathbb{S}_{\mathcal{H}_0} = \mathbb{M}_T$ *, where* \mathcal{H}_0 *is a finite dimensional* $subspace$ of H and $||T||_{\mathcal{H}_0^{\perp}} < ||T||$. Then the following statements are equivalent:

- (i) $dw(T) = \sqrt{w^2(T) + ||T||^4}.$
- (ii) *There exists a unit vector* $x \in \mathcal{H}_0$ *such that* $|\langle Tx, x \rangle| = ||T||$ *.*
