# LIOUVILLE TYPE THEOREM FOR CRITICAL ORDER HÉNON EQUATIONS ON A HALF SPACE AND ITS APPLICATIONS

Abstract. In this paper, we are concerned with the critical order Hénon equations with Navier boundary condition on a half space $\mathbb{R}_{+}^{n}$ :

$$
\begin{cases}(-\Delta)^{\frac{n}{2}} u(x)=|x|^{a} u^{p}(x), \quad u(x) \geq 0, & x \in \mathbb{R}_{+}^{n}  \tag{0.1}\\ u=(-\Delta) u=\cdots=(-\Delta)^{\frac{n}{2}-1} u=0, & x \in \partial \mathbb{R}_{+}^{n}\end{cases}
$$

where $u \in C^{n}\left(\mathbb{R}_{+}^{n}\right) \cap C^{n-2}\left(\overline{\mathbb{R}_{+}^{n}}\right), a \geq 0, n \geq 2$ is even and $1<p<\infty$. We first prove the super poly-harmonic properties and establish the equivalence between (0.1) and the corresponding integral equation

$$
\begin{equation*}
u(x)=\int_{\mathbb{R}_{+}^{n}} G(x, y)|y|^{a} u^{p}(y) d y \tag{0.2}
\end{equation*}
$$

where $G(x, y)$ denotes the Green's function for $(-\Delta)^{\frac{n}{2}}$ on $\mathbb{R}_{+}^{n}$ with Navier boundary conditions. Then, we establish Liouville theorem for (0.2) via "the method of scaling spheres" in integral forms developed initially in [18] by Dai and Qin, and hence we obtain the Liouville theorem for (0.1) on $\mathbb{R}_{+}^{n}$. As an immediate application of the Liouville theorem on $\mathbb{R}_{+}^{n}$ (Theorem (1.6) and Liouville theorems in $\mathbb{R}^{n}$ established in Chen, Dai and Qin [4] for $n \geq 4$ and Bidaut-Véron and Giacomini [1] for $n=2$, we derive a priori estimates and existence of positive solutions to critical order Lane-Emden equations in bounded domains for all $n \geq 2$ and $1<p<\infty$.

Keywords: The method of scaling spheres in integral forms; Critical order; Hénon equations; Liouville theorems; a priori estimates; Navier problems.

## 1. Introduction

1.1. Liouville theorems on a half space $\mathbb{R}_{+}^{n}$. In this paper, we first establish Liouville theorem for the following higher order Hénon equations with Navier boundary condition:

\left\{\begin{array}{l}
(-\Delta)^{\frac{n}{2}} u(x)=|x|^{a} u^{p}(x), \quad u(x) \geq 0, \quad x \in \mathbb{R}_{+}^{n},  \tag{1.1}\\
u=(-\Delta) u=\cdots=(-\Delta)^{\frac{n}{2}-1} u=0 \quad \text { on } \partial \mathbb{R}_{+}^{n},
\end{array}\right.
$$

where $\mathbb{R}_{+}^{n}=\left\{x=\left(x_{1}, \cdots, x_{n}\right) \in \mathbb{R}^{n} \mid x_{n}>0\right\}$ is the upper half Euclidean space, $u \in$ $C^{n}\left(\mathbb{R}_{+}^{n}\right) \cap C^{n-2}\left(\overline{\mathbb{R}_{+}^{n}}\right), n \geq 2$ is even, $0 \leq a<+\infty$ and $1<p<+\infty$. Equations of type (1.1) was first proposed by Hénon in [26] when he studied rotating stellar structures.

For $0<\alpha \leq n$, PDEs of the form

(-\Delta)^{\frac{\alpha}{2}} u(x)=|x|^{a} u^{p}(x) \tag{1.2}
\end{equation*}
$$

are called the fractional order or higher order Hénon, Lane-Emden, Hardy equations for $a>0, a=0, a<0$, respectively. These equations have numerous important applications in conformal geometry and Sobolev inequalities. In particular, in the case $a=0$, (1.2) becomes the well-known Lane-Emden equation, which models many phenomena in mathematical physics and astrophysics.

We say equations (1.2) have critical order if $\alpha=n$ and non-critical order if $0<\alpha<n$. Being essentially different from the non-critical order equations, the fundamental solution $c_{n} \ln \frac{1}{|x-y|}$ of $(-\Delta)^{\frac{n}{2}}$ changes its signs in critical order case $\alpha=n$. The nonlinear terms in (1.2) are called critical if $p=p_{s}(a):=\frac{n+\alpha+2 a}{n-\alpha}(:=+\infty$ if $n=\alpha)$ and subcritical if $0<p<p_{s}(a)$.

Liouville type theorems (i.e., nonexistence of nontrivial nonnegative solutions) and related properties for equations (1.2) in the whole space $\mathbb{R}^{n}$ and the half space $\mathbb{R}_{+}^{n}$ have been extensively studied (see [4, 6, 7, 9, 12, 14, 17, 18, 19, 20, 21, 22, 24, 27, 28, 30, 31, 34, 35, 36, 37, 38] and the references therein). These Liouville theorems, in conjunction with the blowing up and re-scaling arguments, are crucial in establishing a priori estimates and hence existence of positive solutions to non-variational boundary value problems for a class of elliptic equations on bounded domains or on Riemannian manifolds with boundaries (see [4, 10, 18, 25, 33]).

In the critical order case $\alpha=n$, Liouville theorems for (1.2) have been established in [1] for $n=2$ and in [4] for $n \geq 4$ in whole space $\mathbb{R}^{n}$. For the special case $a=0$, their results can be concluded as the following theorem.

Theorem 1.1. ( 1,4$]$ ) Suppose $n \geq 2$ is an even integer, $1<p<+\infty$ and $u$ is a nonnegative classical solution of

(-\Delta)^{\frac{n}{2}} u(x)=u^{p}(x), \quad \forall x \in \mathbb{R}^{n}
$$

Then, we have $u \equiv 0$ in $\mathbb{R}^{n}$.
For $a=0$, there are also many works on the Liouville type theorems for Lane-Emden equations on half space $\mathbb{R}_{+}^{n}$, for instance, see [6, 7, 12, 13, 18, 21, 29, 35, 36] and the references therein. Reichel and Weth [35] proved Liouville theorem in the class of bounded nonnegative solutions for Dirichlet problem of higher order Lane-Emden equations (1.2) (i.e., $a=0$ and $\alpha=2 m$ with $1 \leq m<\frac{n}{2}$ ) on $\mathbb{R}_{+}^{n}$ in the cases $1<p \leq \frac{n+2 m}{n-2 m}$, subsequently they also derived in [36] Liouville theorem for general nonnegative solutions in the cases $1<p<\frac{n+2 m}{n-2 m}$. In [6], Chen, Fang and Li established Liouville theorem for Navier problem of Lane-Emden equation (1.2) on $\mathbb{R}_{+}^{n}$ in the higher order cases $\alpha=2 m$ with $1 \leq m<\frac{n}{2}$ and $\frac{n}{n-2 m}<p \leq \frac{n+2 m}{n-2 m}$. In a recent work [18], Dai and Qin developed the method of scaling spheres, which is essentially a frozen variant of the method of moving spheres invented by Li and Zhu [29] and becomes a powerful tool in deriving asymptotic estimates for solutions. As one of many immediate applications, they established in [18] the Liouville theorem for higher order Lane-Emden equations with Navier boundary conditions on $\mathbb{R}_{+}^{n}$ for all $1<p \leq \frac{n+2 m}{n-2 m}$.

For Liouville theorem on $\mathbb{R}_{+}^{n}$, the cases $a \neq 0$ have not been fully understood. For $a \geq 0$, by using the method of scaling spheres developed initially in [18], Dai, Qin and Zhang [21] proved the Liouville theorem for non-critical higher order Hénon equations (1.2) (i.e., $\alpha=2 m$ with $1 \leq m<\frac{n}{2}$ ) with Navier boundary conditions on $\mathbb{R}_{+}^{n}$ in the cases $1<p<\frac{n+2 m+2 a}{n-2 m}$.

In this paper, by applying the method of scaling spheres in integral forms, we will establish Liouville theorem for the Navier problem of critical order Hénon equation (1.1) on $\mathbb{R}_{+}^{n}$ in all the cases that $a \geq 0, n \geq 2$ and $1<p<+\infty$.

It's well known that the super poly-harmonic properties of solutions are crucial in establishing Liouville type theorems and the integral representation formulae for higher order or fractional order PDEs (see e.g. [4, 5, 6, 17, 21, 38]). In order to prove the equivalence between PDE (1.1) and corresponding integral equation, we will first prove the following generalized theorem on super poly-harmonic properties, namely, we allow $-n<a<0$ and assume that $u \in C^{n}\left(\mathbb{R}_{+}^{n}\right) \cap C^{n-2}\left(\overline{\mathbb{R}_{+}^{n}}\right)$ if $-n<a<0$.

Theorem 1.2. (Super poly-harmonic properties) Assume $n \geq 4$ is even, $-n<a<+\infty$, $1<p<+\infty$ and $u$ is a nonnegative solution of (1.1). If one of the following two assumptions

$$
a \geq-2 p-2 \quad \text { or } \quad u(x)=o\left(|x|^{2}\right) \quad \text { as }|x| \rightarrow+\infty
$$

holds, then

$$
(-\Delta)^{i} u(x) \geq 0
$$

for every $i=1,2, \cdots, \frac{n}{2}-1$ and all $x \in \overline{\mathbb{R}_{+}^{n}}$.
Based on the above super poly-harmonic properties, we can deduce the equivalence between PDE (1.1) and the following integral equation

$$
\begin{equation*}
u(x)=\int_{\mathbb{R}_{+}^{n}} G^{+}(x, y)|y|^{a} u^{p}(y) d y \tag{1.3}
\end{equation*}
$$

where

$$
\begin{equation*}
G^{+}(x, y):=C_{n}\left(\ln \frac{1}{|x-y|}-\ln \frac{1}{|\bar{x}-y|}\right) \tag{1.4}
\end{equation*}
$$

denotes the Green's function for $(-\Delta)^{\frac{n}{2}}$ on $\mathbb{R}_{+}^{n}$ with Navier boundary conditions, and $\bar{x}:=$ $\left(x_{1}, \cdots,-x_{n}\right)$ is the reflection of $x$ with respect to the boundary $\partial \mathbb{R}_{+}^{n}$. That is, we have the following theorem.

Theorem 1.3. If $u$ is a nonnegative classical solution of (1.1), then $u$ is also a nonnegative solution of integral equation (1.3), and vice versa.

Next, we consider the integral equations (1.3) instead of PDE (1.1). We will study the integral equation (1.3) via the method of scaling spheres in integral forms developed by Dai and Qin in [18]. Our Liouville type result for IE (1.3) is the following theorem,

Theorem 1.4. Assume $n \geq 1,1 \leq p<+\infty$ and $-n<a<+\infty$. If $u \in C\left(\overline{\mathbb{R}_{+}^{n}}\right)$ is $a$ nonnegative solution to (1.3), then $u \equiv 0$.

Remark 1.5. Note that we do not assume $n$ to be even in Theorem 1.4. It is also unexpected that the above Theorem 1.4 still holds for $n=1$.

As a consequence of Theorem 1.3 and 1.4 we obtain immediately the following Liouville type theorem on PDE (1.1).

Theorem 1.6. Assume $n \geq 2$ is even, $0 \leq a<+\infty$ and $1<p<+\infty$. Suppose $u \in$ $C^{n}\left(\mathbb{R}_{+}^{n}\right) \cap C^{n-2}\left(\overline{\mathbb{R}_{+}^{n}}\right)$ is a nonnegative classical solution to (1.1), then $u \equiv 0$.
1.2. A priori estimates and existence of positive solutions in bounded domains. As an immediate application of the Liouville theorems (Theorem 1.1 for $\mathbb{R}^{n}$ and Theorem 1.6 for $\mathbb{R}_{+}^{n}$ ), we can derive a priori estimates and existence of positive solutions to critical order Lane-Emden equations in bounded domains $\Omega$ for all $1<p<+\infty$.

In general, let the critical order uniformly elliptic operator $L$ be defined by

$$
\begin{align*}
L & :=\left(\sum_{i, j=1}^{n} a_{i j}(x) \frac{\partial^{2}}{\partial x_{i} \partial x_{j}}\right)^{\frac{n}{2}}+\sum_{|\beta| \leq n-1} b_{\beta}(x) D^{\beta}  \tag{1.5}\\
& =: A^{\frac{n}{2}}+\sum_{|\beta| \leq n-1} b_{\beta}(x) D^{\beta},
\end{align*}
$$

where $n \geq 2$ is even and the coefficients $b_{\beta} \in L^{\infty}(\Omega)$ and $a_{i j} \in C^{n-2}(\bar{\Omega})$ such that there exists constant $\tau>0$ with

$$
\begin{equation*}
\tau|\xi|^{2} \leq \sum_{i, j=1}^{n} a_{i j}(x) \xi_{i} \xi_{j} \leq \tau^{-1}|\xi|^{2}, \quad \forall \xi \in \mathbb{R}^{n}, x \in \Omega \tag{1.6}
\end{equation*}
$$

Consider the Navier boundary value problem:

$$
\left\{\begin{array}{l}
L u(x)=f(x, u), \quad x \in \Omega  \tag{1.7}\\
u(x)=A u(x)=\cdots=A^{\frac{n}{2}-1} u(x)=0, \quad x \in \partial \Omega
\end{array}\right.
$$

where $n \geq 2$ is even, $u \in C^{n}(\Omega) \cap C^{n-2}(\bar{\Omega})$ and $\Omega$ is a bounded domain with boundary $\partial \Omega \in C^{n-2}$.

By virtue of the Liouville theorem in $\mathbb{R}^{n}$ established in [1, 4] (see also Theorem 1.1) and Liouville theorem in $\mathbb{R}_{+}^{n}$ (Theorem [1.6), using entirely similar blowing-up and re-scaling methods as in the proof of Theorem 6 in Chen, Fang and Li [6], we can derive the following a priori estimate for classical solutions (possibly sign-changing solutions) to the critical order Navier problem (1.7) in the full range $1<p<+\infty$.
Theorem 1.7. Assume $n \geq 2$ is even, $1<p<+\infty$ and there exist positive, continuous functions $h(x)$ and $k(x): \bar{\Omega} \rightarrow(0,+\infty)$ such that

$$
\begin{equation*}
\lim _{s \rightarrow+\infty} \frac{f(x, s)}{s^{p}}=h(x), \quad \lim _{s \rightarrow-\infty} \frac{f(x, s)}{|s|^{p}}=k(x) \tag{1.8}
\end{equation*}
$$

uniformly with respect to $x \in \bar{\Omega}$. Then there exists a constant $C>0$ depending only on $\Omega$, $n, p, h(x), k(x)$, such that

$$
\begin{equation*}
\|u\|_{L^{\infty}(\bar{\Omega})} \leq C \tag{1.9}
\end{equation*}
$$

for every classical solution $u$ of Navier problem (1.7).
Remark 1.8. The proof of Theorem 1.7 is entirely similar to that of Theorem 6 in [6] (see also Theorem 1.13 in [18]). We only need to replace the Liouville theorems for non-critical order Lane-Emden equations in $\mathbb{R}^{n}$ (see Lin [27] for fourth order and Wei and Xu 38] for general even order) by Liouville theorems for critical order equations in $\mathbb{R}^{n}$ (see Bidaut-Véron and Giacomini [1] for $n=2$ and Chen, Dai and Qin [4] for $n \geq 4$, see also Theorem (1.1), and replace the Liouville theorems for non-critical order Lane-Emden equations on $\mathbb{R}_{+}^{n}$ (Theorem 5 in [6], or further, Theorem 1.10 in [18]) by Theorem 1.6 in the proof. Thus we omit the details of the proof.

One can immediately apply Theorem 1.7 to the following critical order Navier problem:

$$
\left\{\begin{array}{l}
(-\Delta)^{\frac{n}{2}} u(x)=u^{p}(x)+t \quad \text { in } \Omega  \tag{1.10}\\
u(x)=-\Delta u(x)=\cdots=(-\Delta)^{\frac{n}{2}-1} u(x)=0 \quad \text { on } \partial \Omega,
\end{array}\right.
$$

where $n \geq 2, \Omega \subset \mathbb{R}^{n}$ is a bounded domain with boundary $\partial \Omega \in C^{n-2}$ and $t$ is an arbitrary nonnegative real number.

We can deduce the following corollary from Theorem 1.7.
Corollary 1.9. Assume $1<p<+\infty$. Then, for any nonnegative solution $u \in C^{n}(\Omega) \cap$ $C^{n-2}(\bar{\Omega})$ to the critical order Navier problem (1.10), we have

$$
\begin{equation*}
\|u\|_{L^{\infty}(\bar{\Omega})} \leq C(n, p, \Omega) \tag{1.11}
\end{equation*}
$$

Remark 1.10. In [4], due to the lack of Liouville theorem in $\mathbb{R}_{+}^{n}$ (Theorem 1.6), the authors first applied the method of moving planes in local way to derive a boundary layer estimates, then by using blowing-up arguments (see [2, 6]), they could only establish the a priori estimates for the critical order Navier problem (1.10) under the assumptions that either $1<p<+\infty$ and $\Omega$ is strictly convex, or $1<p \leq \frac{n+2}{n-2}$ (see Theorem 1.3 in [4]). Now, as an immediate consequence of Theorem 1.7, we derive in Corollary 1.9 a priori estimates for the critical order Navier problem (1.10) for all the cases $1<p<+\infty$ with no convexity assumptions on $\Omega$, which extends Theorem 1.3 in [4] remarkably.

As a consequence of the a priori estimates (Corollary 1.9), by applying the Leray-Schauder fixed point theorem (see Theorem 4.1 in (4), we can derive existence result for positive solution to the following Navier problem for critical order Lane-Emden equations in the full range $1<p<+\infty$ :

$$
\left\{\begin{array}{l}
(-\Delta)^{\frac{n}{2}} u(x)=u^{p}(x) \quad \text { in } \Omega  \tag{1.12}\\
u(x)=-\Delta u(x)=\cdots=(-\Delta)^{\frac{n}{2}-1} u(x)=0 \quad \text { on } \partial \Omega
\end{array}\right.
$$

where $n \geq 2$ is even, $1<p<+\infty$ and $\Omega \subset \mathbb{R}^{n}$ is a bounded domain with boundary $\partial \Omega \in C^{n-2}$.

By virtue of the a priori estimates (Theorem 1.3 in [4]), using the Leray-Schauder fixed point theorem, Chen, Dai and Qin [4] obtained existence of positive solution for the critical order Navier problem (1.12) under the assumptions that either $p \in(1,+\infty)$ and $\Omega$ is strictly convex, or $p \in\left(1, \frac{n+2}{n-2}\right]$ (Theorem 1.4 in [4]). For existence results on non-critical higher order Hénon-Hardy equations on bounded domains, please see [15, 16, 17, 18, 23, 32] and the references therein. Since Corollary [1.9 extends Theorem 1.3 in [4] to the full range $1<p<+\infty$ with no convexity assumptions on $\Omega$, through entirely similar arguments, we can improve Theorem 1.4 in [4] remarkably and derive the following existence result for positive solution to the critical order Navier problem (1.12) in the full range $1<p<+\infty$.

Theorem 1.11. Assume $1<p<+\infty$. Then, the critical order Navier problem (1.12) possesses at least one positive solution $u \in C^{n}(\Omega) \cap C^{n-2}(\bar{\Omega})$. Moreover, the positive solution u satisfies

$$
\|u\|_{L^{\infty}(\bar{\Omega})} \geq\left(\frac{\sqrt{2 n}}{\operatorname{diam} \Omega}\right)^{\frac{n}{p-1}}
$$

Remark 1.12. The proof of Theorem 1.11 is entirely similar to that of Theorem 1.4 in [4]. We only need to replace Theorem 1.3 in [4] by Corollary 1.9 in the proof. Thus we omit the details of the proof.

The rest of this paper is organized as follows. In section 2, we prove the super polyharmonic properties for nonnegative solutions to (1.1) (i.e., Theorem (1.2) via a variant of the method used in [6]. In section 3, we show the equivalence between PDE (1.1) and IE (1.3), namely, Theorem 1.3. Section 4 is devoted to the proof of Theorem 1.4, then Theorem 1.6 follows immediately as a consequence of Theorem 1.4.

In the following, we will use $C$ to denote a general positive constant that may depend on $n, a, p$ and $u$, and whose value may differ from line to line.

## 2. SUPER POLY-HARMONIC PROPERTIES

In this section, we will prove Theorem [1.2, To this end, we make an odd extension of $u$ to the whole space $\mathbb{R}^{n}$. Define

$$
\begin{equation*}
u\left(x^{\prime}, x_{n}\right)=-u\left(x^{\prime},-x_{n}\right) \quad \text { for } x_{n}<0 \tag{2.1}
\end{equation*}
$$

where $x^{\prime}=\left(x_{1}, \cdots, x_{n-1}\right) \in \mathbb{R}^{n-1}$. Then $u$ satisfies

$$
\begin{equation*}
(-\Delta)^{\frac{n}{2}} u=|x|^{a}|u|^{p-1} u(x), \quad x \in \mathbb{R}^{n} . \tag{2.2}
\end{equation*}
$$

Let $v_{i}:=(-\Delta)^{i} u$. We aim to show that

$$
\begin{equation*}
v_{i}(x) \geq 0 \tag{2.3}
\end{equation*}
$$

for any $x \in \overline{\mathbb{R}_{+}^{n}}$ and $i=1,2, \cdots, \frac{n}{2}-1$. Our proof will be divided into two steps.
Step 1. We first show that

$$
\begin{equation*}
v_{\frac{n}{2}-1}=(-\Delta)^{\frac{n}{2}-1} u \geq 0 \tag{2.4}
\end{equation*}
$$

If (2.4) does not hold, then there exists $x_{0} \in \mathbb{R}_{+}^{n}$, such that

$$
\begin{equation*}
v_{\frac{n}{2}-1}\left(x_{0}\right)<0 . \tag{2.5}
\end{equation*}
$$

Now, let

$$
\begin{equation*}
\bar{f}(r)=\bar{f}\left(\left|x-x_{0}\right|\right):=\frac{1}{\left|\partial B_{r}\left(x_{0}\right)\right|} \int_{\partial B_{r}\left(x_{0}\right)} f(x) d \sigma \tag{2.6}
\end{equation*}
$$

be the spherical average of $f$ with respect to the center $x_{0}$. Then by the well-known property $\overline{\Delta u}=\Delta \bar{u}$, we have

$$
\left\{\begin{array}{l}
-\Delta \overline{v_{\frac{n}{2}-1}}(r)=\overline{|x|^{a}|u|^{p-1} u}(r)  \tag{2.7}\\
-\Delta \overline{v_{\frac{n}{2}-2}}(r)=\overline{v_{\frac{n}{2}-1}}(r) \\
\cdots \cdots \bar{u}(r)=\overline{v_{1}}(r) \\
-\Delta \bar{m}
\end{array}\right.
$$

From the first equation in (2.7), integrating both sides from 0 to $r$, we have

$$
\begin{align*}
-r^{n-1} \overline{v \frac{n}{2}-1}^{\prime}(r) & =\int_{0}^{r} s^{n-1} \overline{|x|^{a}|u|^{p-1} u}(s) d s \\
& =\frac{1}{\omega_{n}} \int_{0}^{r} \int_{\partial B_{s}\left(x_{0}\right)}|x|^{a}|u|^{p-1} u d \sigma d s  \tag{2.8}\\
& =\frac{1}{\omega_{n}} \int_{B_{r}\left(x_{0}\right)}|x|^{a}|u|^{p-1} u d x \geq 0
\end{align*}
$$

where $\omega_{n}$ denotes the area of unit sphere in $\mathbb{R}^{n}$. Here we have used the fact that, since $x_{0} \in \mathbb{R}_{+}^{n}$, more than half of the ball $B_{r}\left(x_{0}\right)$ is contained in $\mathbb{R}_{+}^{n}$, so (2.8) follows from the odd symmetry of $u$ with respect to $\partial \mathbb{R}_{+}^{n}$. From (2.5) and (2.8), one has

$$
\begin{equation*}
\overline{v \frac{n}{2}-1}^{\prime}(r) \leq 0, \quad \overline{v \frac{n}{2}-1}(r) \leq \overline{v_{\frac{n}{2}-1}}(0)=v_{\frac{n}{2}-1}\left(x_{0}\right)<0, \quad \forall r \geq 0 \tag{2.9}
\end{equation*}
$$

Then from the second equation in (2.7), we have

$$
\begin{equation*}
-\frac{1}{r^{n-1}}\left(r^{n-1} \overline{v_{\frac{n}{2}-2}}(r)\right)^{\prime}=\overline{v_{\frac{n}{2}}-1}(r) \leq \overline{v_{\frac{n}{2}-1}}(0):=-c_{0}<0, \quad \forall r \geq 0 \tag{2.10}
\end{equation*}
$$

which means

Let $\widetilde{\Omega_{\tau}^{-}}$be the reflection of $\Omega_{\tau}^{-}$with respect to $\partial \mathbb{R}_{+}^{n}$ and $\Omega_{\tau}=\Omega_{\tau}^{+} \backslash \widetilde{\Omega_{\tau}^{-}}$.

We can choose $\lambda$ large such that $\left|x_{0, \lambda}\right|<\frac{1}{4}$, then it is easy to see that given $1 \leq \tau \leq 2$, for all $x \in \Omega_{\tau}$, we have $|x|^{a} \geq\left(1-\left|x_{0, \lambda}\right|\right)^{a}>\left(\frac{3}{4}\right)^{a}$ if $a \geq 0$, and $|x|^{a} \geq\left(2+\left|x_{0, \lambda}\right|\right)^{a}>\left(\frac{9}{4}\right)^{a}$
if $a<0$. By the first equation of (2.16), Jensen's inequality and odd symmetry of $u_{\lambda}$ with respect to $\partial \mathbb{R}_{+}^{n}$, we have, for any $1 \leq r \leq 2$,

& =C_{0}^{\prime} \int_{1}^{r} \frac{\left|\Omega_{\tau}\right|}{\tau^{n-1}}\left(\frac{1}{\left|\Omega_{\tau}\right|} \int_{\Omega_{\tau}} u_{\lambda}^{p}(x) d x\right) d \tau \\
& \geq C_{0}^{\prime} \int_{1}^{r} \frac{\left|\Omega_{\tau}\right|}{\tau^{n-1}}\left(\frac{1}{\left|\Omega_{\tau}\right|} \int_{\Omega_{\tau}} u_{\lambda}(x) d x\right)^{p} d \tau \\
& =C_{0}^{\prime} \int_{1}^{r} \frac{1}{\left|B_{\tau}\left(x_{0, \lambda}\right)\right|^{p-1} \tau^{n-1}}\left(\frac{\left|B_{\tau}\left(x_{0, \lambda}\right)\right|}{\left|\Omega_{\tau}\right|}\right)^{p-1}\left(\int_{\Omega_{\tau}} u_{\lambda}(x) d x\right)^{p} d \tau \\
& \geq C_{0}^{\prime \prime} \int_{1}^{r} \frac{1}{\tau^{n p-p}}\left(\int_{B_{\tau}\left(x_{0, \lambda}\right)} u_{\lambda}(x) d x\right)^{p} d \tau \\
& =C_{0}^{\prime \prime} \int_{1}^{r} \frac{1}{\tau^{n p-p}}\left(\int_{0}^{\tau} \int_{\partial B_{s}\left(x_{0, \lambda}\right)} u_{\lambda}(x) d \sigma d s\right)^{p} d \tau \\
& =C_{0} \int_{1}^{r} \frac{1}{\tau^{n p-p}}\left(\int_{0}^{\tau} \overline{u_{\lambda}}(s) s^{n-1} d s\right)^{p} d \tau

where $C_{0} \in(0,1]$ is a positive constant depending only on $n, p$ and $a$ if $\lambda$ is large enough.
It follows from (2.23) and $\frac{n+a}{p-1}+n-2>0$ that, we can choose $\lambda$ sufficiently large to make $\phi_{0, \lambda}(r)$ as large as we wish for $1 \leq r \leq 2$. Apparently, $u_{0, \lambda}(r) \geq 0$, from $\overline{u_{\lambda}}=u_{0, \lambda}+\phi_{0, \lambda}$ and (2.23), we can choose $\lambda$ sufficiently large such that

Here we have used the fact that, since $x_{0} \in \mathbb{R}_{+}^{n}$, more than half of the ball $B_{r}\left(x_{0}\right)$ is contained in $\mathbb{R}_{+}^{n}$, so (2.41) follows from the odd symmetry of $v_{\frac{n}{2}-i+1}$ with respect to $\partial \mathbb{R}_{+}^{n}$.

As in Step 1, we can also derive a contradiction if $\frac{n}{2}-i$ is even, hence we assume that $\frac{n}{2}-i$ is odd hereafter. By the same arguments as in deriving (2.13) in Step 1, we can obtain that

\bar{u}(r) \geq c_{0} r^{2\left(\frac{n}{2}-i\right)}+\sum_{j=1}^{\frac{n}{2}-i} c_{j} r^{2\left(\frac{n}{2}-i-j\right)}, \quad \forall r \geq 0 \tag{2.42}
\end{equation*}
$$

where $c_{0}>0$ and $c_{\frac{n}{2}-i}=\bar{u}(0)=u\left(x_{0}\right) \geq 0$. Therefore, if we assume that $u(x)=o\left(|x|^{2}\right)$ as $|x| \rightarrow+\infty$, we will get a contradiction from (2.42) immediately. We only need to discuss under the assumptions $-2 p-2 \leq a<+\infty$ hereafter.

Notice that there exists $r_{0}$ large enough such that if $r \geq r_{0}$, then $\forall x \in \Omega_{r},|x|^{a} \geq$ $\left(r-\left|x_{0}\right|\right)^{a} \geq C r^{a}$ if $a \geq 0$, and $|x|^{a} \geq\left(r+\left|x_{0}\right|\right)^{a} \geq C r^{a}$ if $a<0$, furthermore, by (2.42), we can also get, if $r \geq r_{0}$,

Similar to (2.24), by (2.8), Jensen's inequality and odd symmetry of $u$ with respect to $\partial \mathbb{R}_{+}^{n}$, we have for any $r \geq r_{0}$,

& =\frac{1}{\omega_{n}} \int_{\Omega_{r}}|x|^{a} u^{p} d x \geq \frac{C r^{a}}{\omega_{n}} \int_{\Omega_{r}} u^{p} d x \\
& \geq \frac{C\left|\Omega_{r}\right| r^{a}}{\omega_{n}}\left(\frac{1}{\left|\Omega_{r}\right|} \int_{\Omega_{r}} u^{p} d x\right)^{p} \\
& \geq \frac{C\left|\Omega_{r}\right| r^{a}}{\omega_{n}}\left(\frac{1}{\left|\Omega_{r}\right|} \int_{\Omega_{r}} u d x\right)^{p} \\
& =C r^{a}\left(\frac{\left|B_{r}\left(x_{0}\right)\right|}{\left|\Omega_{r}\right|}\right)^{p-1} \frac{1}{\omega_{n}\left|B_{r}\left(x_{0}\right)\right|^{p-1}}\left(\int_{B_{r}\left(x_{0}\right)} u d x\right)^{p} \\
& \geq \frac{C r^{a}}{\omega_{n}\left|B_{r}\left(x_{0}\right)\right|^{p-1}}\left(\int_{B_{r}\left(x_{0}\right)} u d x\right)^{p} \\
& =\frac{C r^{a}}{\omega_{n}\left|B_{r}\left(x_{0}\right)\right|^{p-1}}\left(\int_{0}^{r} \int_{\partial B_{s}\left(x_{0}\right)} u d \sigma d s\right)^{p} \\
& =\frac{C \omega_{n}^{p-1} r^{a}}{\left|B_{r}\left(x_{0}\right)\right|^{p-1}}\left(\int_{0}^{r} \bar{u}(s) s^{n-1} d s\right)^{p} \\
& =\frac{C}{r^{n p-n-a}}\left(\int_{0}^{r} \bar{u}(s) s^{n-1} d s\right)^{p} .
\end{align*}
$$

Combining (2.44) with (2.43), we have, for all $r \geq 2 r_{0}$,

\begin{align*}
-r^{n-1} \overline{v \frac{n}{2}-1}^{\prime}(r) & \geq \frac{C}{r^{n p-n-a}}\left(\int_{0}^{r} \bar{u}(s) s^{n-1} d s\right)^{p}  \tag{2.45}\\
& \geq \frac{C}{r^{n p-n-a}}\left(\int_{r_{0}}^{r} s^{2\left(\frac{n}{2}-i\right)} s^{n-1} d s\right)^{p} \\
& \geq \frac{C}{r^{n p-n-a}} r^{n p+2\left(\frac{n}{2}-i\right) p} \\
& \geq C r^{n+2\left(\frac{n}{2}-i\right) p+a} .
\end{align*}
$$

That is,

\overline{v \frac{n}{2}-1}^{\prime}(r) \leq-C r^{2\left(\frac{n}{2}-i\right) p+a+1} \tag{2.46}
\end{equation*}
$$

Integrating (2.46) in both sides from fixed $r_{1} \geq 2 r_{0}$ to $r$, we obtain, if $a>-2-2 p$, then

\end{equation*}
$$

if $a=-2-2 p$, then

\overline{v_{\frac{n}{2}-1}}(r) \leq-C\left(\ln r-\ln r_{1}\right)+\overline{v_{\frac{n}{2}-1}}\left(r_{1}\right) \rightarrow-\infty, \quad \text { as } r \rightarrow+\infty . \tag{2.48}
\end{equation*}
$$

However, from the proven fact that $v_{\frac{n}{2}-1}(x) \geq 0, x \in \overline{\mathbb{R}_{+}^{n}}$, the odd symmetry of $v_{\frac{n}{2}-1}$ with respect to $\partial \mathbb{R}_{+}^{n}$ and (2.47), (2.48), we get that

& =\frac{1}{\omega_{n}} \int_{B_{r_{1}\left(x_{0}\right)}} v_{\frac{n}{2}-1}(x) d x+\frac{1}{\omega_{n}} \int_{B_{r}\left(x_{0}\right) \backslash B_{r_{1}}\left(x_{0}\right)} v_{\frac{n}{2}-1}(x) d x \\
& =\frac{1}{\omega_{n}} \int_{B_{r_{1}\left(x_{0}\right)}} v_{\frac{n}{2}-1}(x) d x+\int_{r_{1}}^{r} s^{n-1 \overline{v_{\frac{n}{2}-1}}(s) d s \rightarrow-\infty, \quad \text { as } r \rightarrow+\infty} .
\end{align*}
$$

This is a contradiction! Therefore, we arrive at $v_{k}(x) \geq 0, k=1,2, \cdots, \frac{n}{2}-2, \forall x \in \overline{\mathbb{R}_{+}^{n}}$.
This finishes our proof of Theorem 1.2.

## 3. Equivalence between PDE and IE

In this section, we prove the equivalence between PDE (1.1) and IE (1.3), namely, Theorem 1.3. We only need to prove that any nonnegative solution of PDE (1.1) also satisfies IE (1.3).
(i) We first consider the cases that $n \geq 4$ is even.

In section 2, we have proved that $v_{i}=(-\Delta)^{i} u \geq 0$ for $i=1,2, \cdots, \frac{n}{2}-1$, then (1.1) is equivalent to the following system

-\Delta v_{\frac{n}{2}-1}(x)=|x|^{a}|u|^{p}(x)  \tag{3.1}\\
-\Delta v_{\frac{n}{2}-2}(x)=v_{\frac{n}{2}-1}(x) \\
\cdots \cdots \\
-\Delta u(x)=v_{1}(x)
\end{array}\right.
$$

In the following, similar as in [6], we define

\begin{equation*}
G(x, y, i):=c_{n}\left(\frac{1}{|x-y|^{n-i}}-\frac{1}{|\bar{x}-y|^{n-i}}\right), \quad x, y \in \mathbb{R}_{+}^{n}, \quad i=2,4, \ldots, n-2 \tag{3.2}
\end{equation*}
$$

and $G^{+}(x, y):=G(x, y, n)=C_{n}\left(\ln \frac{1}{|x-y|}-\ln \frac{1}{|\bar{x}-y|}\right)$.
Let $B_{R}^{+}=B_{R}(0) \cap R_{+}^{n}$. In [3], Cao and Chen derived the Green's function $G_{R}(x, y, 2)$ associated with $-\Delta$ for the half ball $B_{R}^{+}$, that is,

G_{R}(x, y, 2):=\frac{c_{n}}{|x-y|^{n-2}}- & \frac{c_{n}}{\left(|x-y|^{2}+\left(R-\frac{|x|^{2}}{R}\right)\left(R-\frac{|y|^{2}}{R}\right)\right)^{\frac{n-2}{2}}} \\
& -\left(\frac{c_{n}}{|\bar{x}-y|^{n-2}}-\frac{c_{n}}{\left(|\bar{x}-y|^{2}+\left(R-\frac{|x|^{2}}{R}\right)\left(R-\frac{|y|^{2}}{R}\right)\right)^{\frac{n-2}{2}}}\right)
\end{aligned}
$$

Now we list some essential properties of the above Green's functions, which have been proved in [3] and [6]. First,

G_{R}(x, y, 2) \rightarrow G(x, y, 2)=\frac{c_{n}}{|x-y|^{n-2}}-\frac{c_{n}}{|\bar{x}-y|^{n-2}}, \quad \text { as } R \rightarrow+\infty \tag{3.3}
\end{equation*}
$$

Second, let $\Gamma_{R}$ be the hemisphere part of $\partial B_{R}^{+}$, then for each fixed $x \in B_{R}^{+}$and any $y \in \Gamma_{R}$,

\frac{\partial G_{R}(x, y, 2)}{\partial \nu_{y}}=(2-n) R\left(1-\frac{|x|^{2}}{R^{2}}\right)\left(\frac{1}{|x-y|^{n}}-\frac{1}{|\bar{x}-y|^{n}}\right)<0 \tag{3.4}
\end{equation*}
$$

moreover, for each fixed $x \in B_{R}^{+}$, any $y \in \Gamma_{R}$ and $R$ sufficiently large,

$$
\begin{align*}
G(x, y, 2) & =\frac{c_{n}}{|x-y|^{n-2}}-\frac{c_{n}}{|\bar{x}-y|^{n-2}} \sim \frac{y_{n}}{R^{n}}, \quad \text { as } R \rightarrow+\infty,  \tag{3.5}\\
\left|\frac{\partial G_{R}(x, y, 2)}{\partial \nu_{y}}\right| & =(n-2) R\left(1-\frac{|x|^{2}}{R^{2}}\right)\left(\frac{1}{|x-y|^{n}}-\frac{1}{|\bar{x}-y|^{n}}\right) \sim \frac{y_{n}}{R^{n+1}} . \tag{3.6}
\end{align*}
$$

In [6], the authors prove the following property of Green's functions with different orders on a half space:

G(x, y, 2 k)=\int_{\mathbb{R}_{+}^{n}} G(x, z, 2) G(z, y, 2(k-1)) d z, \quad \forall k=2, \cdots, \frac{n}{2}-1 \tag{3.7}
\end{equation*}
$$

To continue, we need to prove that the above property is still valid for the critical order $k=\frac{n}{2}$, this is the following crucial lemma.

Lemma 3.1. Assume that $n \geq 4$ is even, then

G^{+}(x, y)=\int_{\mathbb{R}_{+}^{n}} G(x, z, 2) G(z, y, n-2) d z \tag{3.8}
\end{equation*}
$$

Proof. By elementary calculations, one can easily verify that

G^{+}(x, y)=0, \quad \text { if } x \text { or } y \in \partial \mathbb{R}_{+}^{n} \tag{3.10}

For fixed $x, z \in B_{R}^{+}, z \neq x$ and $\epsilon$ sufficiently small, multiplying both side of (3.9) by $G_{R}(y, z, 2)$ and integrating on $B_{R}^{+} \backslash B_{\epsilon}(z)$ by parts, we have

= & \int_{B_{R}^{+} \backslash B_{\epsilon}(z)} G^{+}(x, y)\left(-\Delta_{y} G_{R}(y, z, 2)\right) d y \\
& +\int_{\partial B_{\epsilon}(z)}\left\{-\frac{\partial G^{+}(x, y)}{\partial \nu_{y}} G_{R}(y, z, 2)+\frac{\partial G_{R}}{\partial \nu_{y}}(y, z, 2) G^{+}(x, y)\right\} d \sigma_{y} \\
& +\int_{\partial B_{R}^{+}}\left\{-\frac{\partial G^{+}(x, y)}{\partial \nu_{y}} G_{R}(y, z, 2)+\frac{\partial G_{R}}{\partial \nu_{y}}(y, z, 2) G^{+}(x, y)\right\} d \sigma_{y} \\
= & \int_{\partial B_{\epsilon}(z)}\left\{-\frac{\partial G^{+}(x, y)}{\partial \nu_{y}} G_{R}(y, z, 2)+\frac{\partial G_{R}}{\partial \nu_{y}}(y, z, 2) G^{+}(x, y)\right\} d \sigma_{y} \\
& +\int_{\Gamma_{R}}\left\{\frac{\partial G_{R}}{\partial \nu_{y}}(y, z, 2) G^{+}(x, y)\right\} d \sigma_{y}
\end{align*}
$$

Next, we will estimate the above integrals on the boundary. For arbitrarily fixed $x \in B_{R}^{+}$, by mean value theorem, we have

G^{+}(x, y) & =C_{n}\left(\ln \frac{1}{|x-y|}-\ln \frac{1}{|\bar{x}-y|}\right) \\
& =\frac{C_{n}}{2}\left\{\ln (|\bar{x}-y|)^{2}-\ln (|x-y|)^{2}\right\}  \tag{3.12}\\
& =C \frac{x_{n} y_{n}}{\xi^{2}} \sim \frac{y_{n}}{R^{2}}, \quad \forall y \in \partial B_{R}^{+}, \quad \text { as } R \rightarrow+\infty
\end{align*}
$$

where $\xi$ is valued between $|x-y|^{2}$ and $|\bar{x}-y|^{2}$. By (3.6) and (3.12), we obtain

\left|\int_{\Gamma_{R}}\left\{\frac{\partial G_{R}}{\partial \nu_{y}}(y, z, 2) G^{+}(x, y)\right\} d \sigma_{y}\right| \sim \frac{y_{n}^{2}}{R^{4}} \leq \frac{C}{R^{2}} \rightarrow 0, \quad \text { as } R \rightarrow+\infty \tag{3.13}
\end{equation*}
$$

Since $\frac{\partial G_{R}}{\partial \nu_{y}}(y, z, 2) \sim \frac{1}{\epsilon^{n-1}}, G_{R}(y, z, 2) \sim \frac{1}{\epsilon^{n-2}}$ on $\partial B_{\epsilon}(z)$ and $G^{+}(x, y)$ is smooth in $B_{\epsilon}(z)$ for $\epsilon$ sufficiently small, we have

\int_{\partial B_{\epsilon}(z)}\left\{-\frac{\partial G^{+}(x, y)}{\partial \nu_{y}} G_{R}(y, z, 2)+\frac{\partial G_{R}}{\partial \nu_{y}}(y, z, 2) G^{+}(x, y)\right\} d \sigma_{y} \rightarrow G^{+}(x, z) \tag{3.14}
\end{equation*}
$$

as $\epsilon \rightarrow 0+$. First let $\epsilon \rightarrow 0+$ and then let $R \rightarrow+\infty$, combining (3.11), (3.13) and (3.14), we derive

As to the right-hand side, we have

Since $G_{R}(y, z, 2)$ is smooth in $B_{R}^{+} \backslash B_{\epsilon}(z), G(x, y, n-2) \sim \frac{1}{|x-y|^{2}}$ near $x=y$ and $n \geq 4$, we derive from (3.15) that

First let $\epsilon \rightarrow 0$ and then let $R \rightarrow \infty$, by (3.3) and dominated convergence theorem, we deduce

This completes the proof of Lemma 3.1.

Now we can prove $u$ is also a solution of the integral equation (1.3) using Lemma 3.1. Multiplying both sides of (3.1) by $G_{R}(x, y, 2)$ and integrating on $B_{R}^{+}$by parts, we have

\int_{B_{R}^{+}} G_{R}(x, y, 2) v_{\frac{n}{2}-1}(y) d y=v_{\frac{n}{2}-2}(x)+\int_{\Gamma_{R}} v_{\frac{n}{2}-2}(y) \frac{\partial G_{R}(x, y, 2)}{\partial \nu_{y}} d \sigma_{y} \\
\ldots \ldots \\
\int_{B_{R}^{+}} G_{R}(x, y, 2) v_{1}(y) d y=u(x)+\int_{\Gamma_{R}} u(y) \frac{\partial G_{R}(x, y, 2)}{\partial \nu_{y}} d \sigma_{y}
\end{array}\right.
$$

By Theorem 1.2, (3.4) and (3.20), we derive

\int_{B_{R}^{+}} G_{R}(x, y, 2)|y|^{a} u^{p}(y) d y \leq v_{\frac{n}{2}-1}(x)  \tag{3.21}\\
\int_{B_{R}^{+}} G_{R}(x, y, 2) v_{\frac{n}{2}-1}(y) d y \leq v_{\frac{n}{2}-2}(x) \\
\ldots \ldots \\
\int_{B_{R}^{+}} G_{R}(x, y, 2) v_{1}(y) d y \leq u(x)
\end{array}\right.
$$

Letting $R \rightarrow \infty$, and by (3.3), we deduce

\int_{\mathbb{R}_{+}^{n}} G(x, y, 2)|y|^{a} u^{p}(y) d y<\infty  \tag{3.22}\\
\int_{\mathbb{R}_{+}^{n}} G(x, y, 2) v_{\frac{n}{2}-1}(y) d y<\infty \\
\ldots \ldots \\
\int_{\mathbb{R}_{+}^{n}} G(x, y, 2) v_{1}(y) d y<\infty
\end{array}\right.
$$

By (3.22), we conclude that there exists a sequence $R_{j} \rightarrow \infty$ such that

& R_{j} \int_{\Gamma_{R_{j}}} G(x, y, 2)|y|^{a} u(y) d \sigma_{y} \rightarrow 0, \quad \text { as } R_{j} \rightarrow \infty \tag{3.24}
\end{align*}
$$

Then from (3.5), it follows easily that

& \frac{1}{R_{j}^{n-1}} \int_{\Gamma_{R_{j}}} v_{i}(y) y_{n} d \sigma_{y} \rightarrow 0, \quad \text { as } R_{j} \rightarrow \infty, \quad i=1, \ldots, \frac{n}{2}-1,  \tag{3.25}\\
& \frac{1}{R_{j}^{n-1-a}} \int_{\Gamma_{R_{j}}} u^{p}(y) y_{n} d \sigma_{y} \rightarrow 0, \quad \text { as } R_{j} \rightarrow \infty \tag{3.26}
\end{align*}
$$

As an immediate consequence of (3.25), we have

\end{equation*}

By (3.26), Hölder inequality and the fact that $1+a+p>0$, we derive

\frac{1}{R_{j}^{n+1}} \int_{\Gamma_{R_{j}}} u(y) y_{n} d \sigma_{y} & \leq \frac{R_{j}^{\frac{n-1-a}{p}}}{R_{j}^{n+1}}\left(\frac{1}{R_{j}^{n-1-a}} \int_{\Gamma_{R_{j}}} u^{p}(y) y_{n} d \sigma_{y}\right)^{\frac{1}{p}}\left(\int_{\Gamma_{R_{j}}} y_{n} d \sigma_{y}\right)^{1-\frac{1}{p}} \\
& \leq \frac{R_{j}^{\frac{n-1-a}{p}}}{R_{j}^{n+1}}\left(\frac{1}{R_{j}^{n-1-a}} \int_{\Gamma_{R_{j}}} u^{p}(y) y_{n} d \sigma_{y}\right)^{\frac{1}{p}} R_{j}^{n\left(1-\frac{1}{p}\right)} \\
& \leq R_{j}^{-\frac{1+a+p}{p}} o(1) \rightarrow 0, \quad \text { as } R_{j} \rightarrow \infty
\end{aligned}
$$

Substituting (3.6) into (3.20), and by (3.3), (3.27), (3.28), we arrive at

\end{array}\right.

Then by (3.7) and Lemma 3.1, it is easy to see that

& =\int_{\mathbb{R}_{+}^{n}} G(x, y, 2) \int_{\mathbb{R}_{+}^{n}} G(y, z, 2) v_{2}(z) d z d y \\
& =\int_{\mathbb{R}_{+}^{n}} G(x, y, 4) v_{2}(y) d y \\
& =\cdots \\
& =\int_{\mathbb{R}_{+}^{n}} G^{+}(x, y)|y|{ }^{a} u^{p}(y) d y
\end{align*}
$$

(ii) Next, we consider the case $n=2$.

For $n=2$, the Green's function $G_{R}^{+}(x, y)$ associated with $-\Delta$ for the half disk $B_{R}^{+}$is given by

\begin{equation*}
G_{R}^{+}(x, y):=\frac{1}{2 \pi}\left(\ln \frac{1}{|x-y|}-\ln \frac{1}{\left|\frac{R^{2} x}{|x|^{2}}-y\right|}\right)-\frac{1}{2 \pi}\left(\ln \frac{1}{|\bar{x}-y|}-\ln \frac{1}{\left|\frac{R^{2} \bar{x}}{|x|^{2}}-y\right|}\right) \tag{3.31}
\end{equation*}
$$

Now we give some essential properties of the above Green's functions. First,

G_{R}^{+}(x, y) \rightarrow G^{+}(x, y)=\frac{1}{2 \pi}\left(\ln \frac{1}{|x-y|}-\ln \frac{1}{|\bar{x}-y|}\right), \quad \text { as } R \rightarrow+\infty \tag{3.32}
\end{equation*}
$$

Second, let $\Gamma_{R}$ be the semi-circle part of $\partial B_{R}^{+}$, then for each fixed $x \in B_{R}^{+}$and any $y \in \Gamma_{R}$,

$$
\begin{equation*}
\frac{\partial G_{R}^{+}(x, y)}{\partial \nu_{y}}=-\frac{1}{2 \pi} R\left(1-\frac{|x|^{2}}{R^{2}}\right)\left(\frac{1}{|x-y|^{2}}-\frac{1}{|\bar{x}-y|^{2}}\right)<0 \tag{3.33}
\end{equation*}
$$

moreover, for each fixed $x \in B_{R}^{+}$, any $y \in \Gamma_{R}$ and $R$ sufficiently large,

$$
\begin{align*}
& G^{+}(x, y)=\frac{1}{2 \pi}\left(\ln \frac{1}{|x-y|}-\ln \frac{1}{|\bar{x}-y|}\right) \sim \frac{y_{2}}{R^{2}}, \quad \text { as } R \rightarrow+\infty  \tag{3.34}\\
& \left|\frac{\partial G_{R}^{+}(x, y)}{\partial \nu_{y}}\right|=\frac{1}{2 \pi} R\left(1-\frac{|x|^{2}}{R^{2}}\right)\left(\frac{1}{|x-y|^{2}}-\frac{1}{|\bar{x}-y|^{2}}\right) \sim \frac{y_{2}}{R^{3}} \tag{3.35}
\end{align*}
$$

Multiplying both sides of PDE (1.1) by $G_{R}^{+}(x, y)$ and integrating on $B_{R}^{+}$by parts, we have

$$
\begin{equation*}
\int_{B_{R}^{+}} G_{R}^{+}(x, y)|y|^{a} u^{p}(y) d y=u(x)+\int_{\Gamma_{R}} u(y) \frac{\partial G_{R}^{+}(x, y)}{\partial \nu_{y}} d \sigma_{y} . \tag{3.36}
\end{equation*}
$$

By (3.33) and (3.36), we derive

$$
\begin{equation*}
\int_{B_{R}^{+}} G_{R}^{+}(x, y)|y|^{a} u^{p}(y) d y \leq u(x) \tag{3.37}
\end{equation*}
$$

By letting $R \rightarrow \infty$ and (3.32), we deduce

$$
\begin{equation*}
\int_{\mathbb{R}_{+}^{2}} G^{+}(x, y)|y|^{a} u^{p}(y) d y<\infty \tag{3.38}
\end{equation*}
$$

By (3.38), we conclude that there exists a sequence $R_{j} \rightarrow \infty$ such that

\begin{equation*}
R_{j} \int_{\Gamma_{R_{j}}} G^{+}(x, y)|y|^{a} u(y) d \sigma_{y} \rightarrow 0, \quad \text { as } R_{j} \rightarrow \infty \tag{3.39}
\end{equation*}
$$

and hence, from (3.34), it follows easily that

\frac{1}{R_{j}^{1-a}} \int_{\Gamma_{R_{j}}} u^{p}(y) y_{2} d \sigma_{y} \rightarrow 0, \quad \text { as } R_{j} \rightarrow \infty \tag{3.40}
\end{equation*}
$$

By (3.40), Hölder inequality and the fact that $1+a+p>0$, we derive

\begin{aligned}
\frac{1}{R_{j}^{3}} \int_{\Gamma_{R_{j}}} u(y) y_{2} d \sigma_{y} & \leq \frac{R_{j}^{\frac{1-a}{p}}}{R_{j}^{3}}\left(\frac{1}{R_{j}^{1-a}} \int_{\Gamma_{R_{j}}} u^{p}(y) y_{2} d \sigma_{y}\right)^{\frac{1}{p}}\left(\int_{\Gamma_{R_{j}}} y_{2} d \sigma_{y}\right)^{1-\frac{1}{p}} \\
& \leq \frac{R_{j}^{\frac{1-a}{p}}}{R_{j}^{3}}\left(\frac{1}{R_{j}^{1-a}} \int_{\Gamma_{R_{j}}} u^{p}(y) y_{2} d \sigma_{y}\right)^{\frac{1}{p}} R_{j}^{2\left(1-\frac{1}{p}\right)} \\
& \leq R_{j}^{-\frac{1+a+p}{p}} o(1) \rightarrow 0, \quad \text { as } R_{j} \rightarrow \infty
\end{aligned}
$$

Substituting (3.35) into (3.36), and by (3.32), (3.41), we finally arrive at

u(x)=\int_{\mathbb{R}_{+}^{2}} G^{+}(x, y)|y|^{a} u^{p}(y) d y \tag{3.42}
\end{equation*}
$$

This completes our proof of Theorem 1.3.

## 4. The proof of theorem 1.4

In this section, we will carry out the proof of Theorem 1.4 by applying the method of scaling spheres in integral forms developed by Dai and Qin in [18].

Suppose $u$ is a nonnegative continuous solution of IE (1.3) but $u \not \equiv 0$, we will derive a contradiction via the method of scaling spheres in integral forms.

In order to apply the method of scaling spheres, we first give some definitions. One can easily see that $u \not \equiv 0$ implies $u>0$ in $\mathbb{R}_{+}^{n}$. Let $\lambda>0$ be an arbitrary positive real number and let the scaling half sphere be

S_{\lambda}^{+}=\left\{x \in \overline{\mathbb{R}_{+}^{n}}:|x|=\lambda\right\} . \tag{4.1}
\end{equation*}
$$

We denote the reflection of $x$ about the sphere $\left\{x \in \mathbb{R}^{n}| | x \mid=\lambda\right\}$ by $x^{\lambda}:=\frac{\lambda^{2} x}{|x|^{2}}$ and let

$$
\begin{equation*}
B_{\lambda}^{+}(0):=B_{\lambda}(0) \cap \mathbb{R}_{+}^{n}, \quad \widetilde{B_{\lambda}^{+}}(0):=\left\{x \in \mathbb{R}_{+}^{n}: x^{\lambda} \in B_{\lambda}^{+}(0)\right\} \tag{4.2}
\end{equation*}
$$

Define the Kelvin transform of $u$ centered at 0 by

$$
\begin{equation*}
u_{\lambda}(x)=u\left(\frac{\lambda^{2} x}{|x|^{2}}\right) \tag{4.3}
\end{equation*}
$$

for arbitrary $x \in \overline{\mathbb{R}_{+}^{n}} \backslash\{0\}$. It's obvious that the Kelvin transform $u_{\lambda}$ may have singularity at 0 and $\lim _{|x| \rightarrow \infty} u_{\lambda}(x)=u(0)=0$. By (4.3), one can infer from the regularity assumptions on $u$ that $u_{\lambda} \in C\left(\overline{\mathbb{R}_{+}^{n}} \backslash\{0\}\right)$.

By direct calculations, one can verify that

$$
\begin{gather*}
G^{+}(x, y)>G^{+}\left(x, y^{\lambda}\right), \quad \forall x, y \in B_{\lambda}^{+}(0),  \tag{4.4}\\
\left|x^{\lambda}-y\right|=\frac{|y|}{|x|}\left|x-y^{\lambda}\right|, \quad|x|=|\bar{x}|, \overline{x^{\lambda}}=\bar{x}^{\lambda} . \tag{4.5}
\end{gather*}
$$

We can deduce from (1.3), (4.3) and (4.5) that (for the invariance properties of fractional or higher order Laplacians under the Kelvin type transforms, please refer to [8, 9, 11, 27, 38])

$$
\begin{align*}
u_{\lambda}(x) & =u\left(\frac{\lambda^{2} x}{|x|^{2}}\right)=\int_{\mathbb{R}_{+}^{n}} G^{+}\left(x^{\lambda}, y\right)|y|^{a} u^{p}(y) d y  \tag{4.6}\\
& =C_{n} \int_{\mathbb{R}_{+}^{n}}\left(\ln \frac{1}{\left|x^{\lambda}-y\right|}-\ln \frac{1}{\left|\overline{x^{\lambda}}-y\right|}\right)|y|^{a} u^{p}(y) d y \\
& =C_{n} \int_{\mathbb{R}_{+}^{n}}\left(\ln \frac{1}{\left|x^{\lambda}-y\right|}-\ln \frac{1}{\left|\bar{x}^{\lambda}-y\right|}\right)|y|^{a} u^{p}(y) d y \\
& =C_{n} \int_{\mathbb{R}_{+}^{n}}\left(\ln \frac{|x|}{|y|\left|x-y^{\lambda}\right|}-\ln \frac{|\bar{x}|}{|y|\left|\bar{x}-y^{\lambda}\right|}\right)|y|^{a} u^{p}(y) d y \\
& =C_{n} \int_{\mathbb{R}_{+}^{n}}\left(\ln \frac{1}{\left|x-y^{\lambda}\right|}-\ln \frac{1}{\left|\bar{x}-y^{\lambda}\right|}\right)|y|^{a} u^{p}(y) d y \\
& =\int_{\mathbb{R}_{+}^{n}} G^{+}\left(x, y^{\lambda}\right)|y|^{a} u^{p}(y) d y .
\end{align*}
$$

Let $\omega^{\lambda}(x):=u_{\lambda}(x)-u(x)$ for any $x \in \overline{B_{\lambda}^{+}(0)} \backslash\{0\}$. Since $u$ satisfies (1.3), by changing variables, we have

$$
\begin{align*}
u(x) & =\int_{\mathbb{R}_{+}^{n}} G^{+}(x, y)|y|{ }^{a} u^{p}(y) d y  \tag{4.7}\\
& =\int_{B_{\lambda}^{+}(0)} G^{+}(x, y)|y|^{a} u^{p}(y) d y+\int_{\mathbb{R}_{+}^{n} \backslash B_{\lambda}^{+}(0)} G^{+}(x, y)|y|^{a} u^{p}(y) d y \\
& =\int_{B_{\lambda}^{+}(0)} G^{+}(x, y)|y|^{a} u^{p}(y) d y+\int_{B_{\lambda}^{+}(0)}\left(\frac{\lambda}{|y|}\right)^{2(n+a)} G^{+}\left(x, y^{\lambda}\right)|y|^{a} u_{\lambda}^{p}(y) d y
\end{align*}
$$

Similarly, by (4.6), we obtain

$$
\begin{align*}
u_{\lambda}(x) & =\int_{\mathbb{R}_{+}^{n}} G^{+}\left(x, y^{\lambda}\right)|y|^{a} u^{p}(y) d y  \tag{4.8}\\
& =\int_{B_{\lambda}^{+}(0)} G^{+}\left(x, y^{\lambda}\right)|y|^{a} u^{p}(y) d y+\int_{B_{\lambda}^{+}(0)}\left(\frac{\lambda}{|y|}\right)^{2(n+a)} G^{+}(x, y)|y|^{a} u_{\lambda}^{p}(y) d y
\end{align*}
$$

Then, by (4.7) and (4.8), we arrive at

$$
\begin{align*}
\omega^{\lambda}(x) & =u_{\lambda}(x)-u(x)  \tag{4.9}\\
& =\int_{B_{\lambda}^{+}(0)}\left(G^{+}(x, y)-G^{+}\left(x, y^{\lambda}\right)\right)|y|^{a}\left(\left(\frac{\lambda}{|y|}\right)^{2(n+a)} u_{\lambda}^{p}(y)-u^{p}(y)\right) d y
\end{align*}
$$

for every $x \in B_{\lambda}^{+}(0)$.
Now we can carry out the process of scaling spheres in two steps.
Step 1. Start dilating the sphere from near $\lambda=0$. We will first show that, for $\lambda>0$ sufficiently small,

$$

\omega^{\lambda}(x) \geq 0, \quad \forall x \in B_{\lambda}^{+}(0) \tag{4.10}
\end{equation*}
$$

Define

\begin{equation*}
\left(B_{\lambda}^{+}\right)^{-}:=\left\{x \in B_{\lambda}^{+}(0) \mid \omega_{\lambda}(x)<0\right\} \tag{4.11}
\end{equation*}
$$

Through elementary calculations, one can obtain that for any $x, y \in B_{\lambda}^{+}(0), x \neq y$,

G^{+}(x, y) & =C_{n}\left(\ln \frac{1}{|x-y|}-\ln \frac{1}{|\bar{x}-y|}\right)  \tag{4.12}\\
& =\frac{C_{n}}{2} \ln \frac{|\bar{x}-y|^{2}}{|x-y|^{2}} \\
& =C \ln \left(1+\frac{4 x_{n} y_{n}}{|x-y|^{2}}\right) \\
& \leq C \ln \left(1+\frac{4 \lambda^{2}}{|x-y|^{2}}\right)
\end{align*}
$$

It is well known that

$$
\begin{equation*}
\ln (1+t)=o\left(t^{\varepsilon}\right), \quad \text { as } t \rightarrow+\infty \tag{4.13}
\end{equation*}
$$

where $\varepsilon$ is an arbitrary positive real number. This implies, for any given $\varepsilon>0$, there exists a $\delta(\varepsilon)>0$ such that

$$
\begin{equation*}
\ln (1+t) \leq t^{\varepsilon}, \quad \forall t>\frac{4}{\delta(\varepsilon)^{2}} \tag{4.14}
\end{equation*}
$$

Therefore, by (4.12), (4.14) and straightforward calculations, we have the following lemma that states some basic estimates for Green's function $G^{+}(x, y)$.

Lemma 4.1. Assume $G^{+}(x, y)$ be the Green's functions in integral equation (1.3). Then we have

\begin{gather*}
G^{+}(x, y) \leq C \lambda^{2 \varepsilon} \frac{1}{|x-y|^{2 \varepsilon}}, \quad \text { if }|x-y|<\lambda \delta(\varepsilon) ;  \tag{4.15}\\
G^{+}(x, y) \leq C \ln \left(1+\frac{4}{\delta(\varepsilon)^{2}}\right), \quad \text { if }|x-y| \geq \lambda \delta(\varepsilon) ;  \tag{4.16}\\
G^{+}(x, y) \leq C^{\prime} \frac{4 x_{n} y_{n}}{|x-y|^{2}}, \quad \forall x, y \in \mathbb{R}_{+}^{n}, \quad x \neq y ;  \tag{4.17}\\
G^{+}(x, y) \geq C^{\prime \prime} \frac{4 x_{n} y_{n}}{|x-y|^{2}}, \quad \forall x, y \in \mathbb{R}_{+}^{n}, \quad \frac{|x|}{|y|} \leq \frac{1}{100} \text { or } \frac{|y|}{|x|} \leq \frac{1}{100} . \tag{4.18}
\end{gather*}
$$

By the assumption $a>-n$, (4.4), (4.9) (4.15) and (4.16), we have, for any $x \in\left(B_{\lambda}^{+}\right)^{-}$,

$$
\begin{align*}
\omega^{\lambda}(x)= & \int_{B_{\lambda}^{+}(0)}\left(G^{+}(x, y)-G^{+}\left(x, y^{\lambda}\right)\right)|y|^{a}\left(\left(\frac{\lambda}{|y|}\right)^{2(n+a)} u_{\lambda}^{p}(y)-u^{p}(y)\right) d y \\
\geq & \int_{B_{\lambda}^{+}(0)}\left(G^{+}(x, y)-G^{+}\left(x, y^{\lambda}\right)\right)|y|^{a}\left(u_{\lambda}^{p}(y)-u^{p}(y)\right) d y \\
\geq & \int_{\left(B_{\lambda}^{+}\right)^{-}}\left(G^{+}(x, y)-G^{+}\left(x, y^{\lambda}\right)\right)|y|^{a}\left(u_{\lambda}^{p}(y)-u^{p}(y)\right) d y  \tag{4.19}\\
\geq & \int_{\left(B_{\lambda}^{+}\right)^{-}} G^{+}(x, y)|y|^{a}\left(u_{\lambda}^{p}(y)-u^{p}(y)\right) d y \\
\geq & C \lambda^{\lambda^{\varepsilon}} \int_{\left(B_{\lambda}^{+}\right)^{-} \cap B_{\lambda \delta(\varepsilon)}(x)} \frac{1}{|x-y|^{2 \varepsilon}}|y|^{a} u^{p-1}(y) \omega^{\lambda}(y) d y \\
& +C(\delta(\varepsilon)) \int_{\left(B_{\lambda}^{+}\right)^{-} \backslash B_{\lambda \delta(\varepsilon)}(x)}|y|^{a} u^{p-1}(y) \omega^{\lambda}(y) d y .
\end{align*}
$$

By (4.19), Hardy-Littlewood-Sobolev inequality and Hölder inequality, for arbitrary $\frac{n}{2 \varepsilon}<$ $q<\infty$, we obtain

$$
\begin{align*}
\left\|\omega^{\lambda}\right\|_{L^{q}\left(\left(B_{\lambda}^{+}\right)^{-}\right)} \leq & C \lambda^{2 \varepsilon}\left\|\int_{\left(B_{\lambda}^{+}\right)^{-} \cap B_{\lambda \delta(\varepsilon)}(x)} \frac{1}{|x-y|^{2 \varepsilon}}|y|^{a} u^{p-1}(y) \omega^{\lambda}(y) d y\right\|_{L^{q}\left(\left(B_{\lambda}^{+}\right)^{-}\right)} \\
& +C(\delta(\varepsilon))\left|\left(B_{\lambda}^{+}\right)^{-}\right|^{\frac{1}{q}} \int_{\left(B_{\lambda}^{+}\right)^{-}}|y|^{a} u^{p-1}(y)\left|\omega^{\lambda}(y)\right| d y \\
\leq & C \lambda^{2 \varepsilon}\left\|\int_{\left(B_{\lambda}^{+}\right)^{-}} \frac{1}{|x-y|^{2 \varepsilon}}|y|^{a} u^{p-1}(y) \omega^{\lambda}(y) d y\right\|_{L^{q}\left(\left(B_{\lambda}^{+}\right)^{-}\right)} \\
& +C(\delta(\varepsilon))\left|\left(B_{\lambda}^{+}\right)^{-}\right|^{\frac{1}{q}} \int_{\left(B_{\lambda}^{+}\right)^{-}}|y|^{a} u^{p-1}(y)\left|\omega^{\lambda}(y)\right| d y  \tag{4.20}\\
\leq & C \lambda^{2 \varepsilon}\left\||x|^{a} u^{p-1} \omega^{\lambda}\right\|_{L^{\frac{n q}{n+(n-2 \varepsilon) q}}\left(\left(B_{\lambda}^{+}\right)^{-}\right)} \\
& +C(\delta(\varepsilon))\left|\left(B_{\lambda}^{+}\right)^{-}\right|^{\frac{1}{q}} \int_{\left(B_{\lambda}^{+}\right)^{-}}|y|^{a} u^{p-1}(y)\left|\omega^{\lambda}(y)\right| d y \\
\leq & C \lambda^{2 \varepsilon}\left\||x|^{a} u^{p-1}\right\|_{L^{\frac{n}{n-2 \varepsilon}}\left(\left(B_{\lambda}^{+}\right)^{-}\right)}\left\|\omega^{\lambda}\right\|_{L^{q}\left(\left(B_{\lambda}^{+}\right)^{-}\right)} \\
& +C(\delta(\varepsilon))\left|\left(B_{\lambda}^{+}\right)^{-\frac{1}{q}}\left\||x|^{a} u^{p-1}\right\|_{L^{\frac{q}{q-1}}\left(\left(B_{\lambda}^{+}\right)^{-}\right)}\left\|\omega^{\lambda}\right\|_{L^{q}\left(\left(B_{\lambda}^{+}\right)^{-}\right)}\right.
\end{align*}
$$

Since $a>-n$, we first choose $\varepsilon>0$ sufficiently small such that $\frac{n a}{n-2 \varepsilon}>-n$, then choose $q>\frac{n}{2 \varepsilon}$ sufficiently large such that $\frac{q a}{q-1}>-n$. Then from the assumption that $u$ is continuous in $\overline{\mathbb{R}_{+}^{n}}$, it is obvious that $|x|^{a} u^{p-1} \in L_{\text {loc }}^{\frac{n}{n-2 \varepsilon}}\left(\overline{\mathbb{R}_{+}^{n}}\right) \cap L_{\text {loc }}^{\frac{q}{q-1}}\left(\overline{\mathbb{R}_{+}^{n}}\right)$. Therefore, there exists $\delta_{0}>0$ sufficiently small, such that

$$
\begin{equation*}
C \lambda^{2 \varepsilon}\left\||x|^{a} u^{p-1}\right\|_{L^{\frac{n}{n-2 \varepsilon}}\left(\left(B_{\lambda}^{+}\right)^{-}\right)}+C(\delta(\varepsilon))\left|\left(B_{\lambda}^{+}\right)^{-}\right|^{\frac{1}{q}}\left\||x|^{a} u^{p-1}\right\|_{L^{\frac{q}{q-1}}\left(\left(B_{\lambda}^{+}\right)^{-}\right)}<\frac{1}{2} \tag{4.21}
\end{equation*}
$$

for any $0<\lambda<\delta_{0}$. Thus, by (4.20), we must have

$$
\begin{equation*}
\left\|\omega^{\lambda}\right\|_{L^{q}\left(\left(B_{\lambda}^{+}\right)^{-}\right)}=0 \tag{4.22}
\end{equation*}
$$

for any $0<\lambda<\delta_{0}$. From the continuity of $\omega^{\lambda}$ in $\overline{\mathbb{R}_{+}^{n}} \backslash\{0\}$ and the definition of $\left(B_{\lambda}^{+}\right)^{-}$, we immediately get that $\left(B_{\lambda}^{+}\right)^{-}=\emptyset$ and hence (4.10) holds true for any $0<\lambda<\delta_{0}$. This completes Step 1.

Step 2. Dilate the half sphere $S_{\lambda}^{+}$outward until $\lambda=+\infty$ to derive lower bound estimates on $u$ in a cone. Step 1 provides us a starting point to dilate the half sphere $S_{\lambda}^{+}$from near $\lambda=0$. Now we dilate the half sphere $S_{\lambda}^{+}$outward as long as (4.10) holds. Let

$$
\begin{equation*}
\lambda_{0}:=\sup \left\{\lambda>0 \mid \omega^{\mu} \geq 0 \text { in } B_{\mu}^{+}(0), \forall 0<\mu \leq \lambda\right\} \in(0,+\infty] \tag{4.23}
\end{equation*}
$$

and hence, one has

$$
\begin{equation*}
\omega^{\lambda_{0}}(x) \geq 0, \quad \forall x \in B_{\lambda_{0}}^{+}(0) \tag{4.24}
\end{equation*}
$$

In what follows, we will prove $\lambda_{0}=+\infty$ by driving a contradiction under the assumption that $\lambda_{0}<+\infty$.

In fact, suppose $\lambda_{0}<+\infty$, we must have

$$
\begin{equation*}
\omega^{\lambda_{0}}(x) \equiv 0, \quad \forall x \in B_{\lambda_{0}}^{+}(0) \tag{4.25}
\end{equation*}
$$

Suppose on the contrary that (4.25) does not hold, that is, there exists a $x_{0} \in B_{\lambda_{0}}^{+}(0)$ such that $\omega^{\lambda_{0}}\left(x_{0}\right)>0$. Then, by (4.9) and (4.24), we have

\begin{equation*}
\omega^{\lambda_{0}}(x)>0, \quad \forall x \in B_{\lambda_{0}}^{+}(0) \tag{4.26}
\end{equation*}
$$

Choose $\delta_{1}>0$ sufficiently small, which will be determined later. Define the narrow region

$$
\begin{equation*}
A_{\delta_{1}}:=\left\{x \in B_{\lambda_{0}}^{+}(0) \mid \operatorname{dist}\left(x, \partial B_{\lambda_{0}}^{+}(0)\right)<\delta_{1}\right\} . \tag{4.27}
\end{equation*}
$$

Note that $A_{\delta_{1}}=\left\{x \in B_{\lambda_{0}}^{+}(0) \mid x_{n}<\delta_{1}\right.$ or $\left.\lambda_{0}-\delta_{1}<|x|<\lambda_{0}\right\}$.
Since that $\omega^{\lambda_{0}}$ is continuous in $\overline{\mathbb{R}_{+}^{n}} \backslash\{0\}$ and $A_{\delta_{1}}^{c}:=B_{\lambda_{0}}^{+}(0) \backslash A_{\delta_{1}}$ is a compact subset, there exists a positive constant $C_{0}$ such that

$$
\begin{equation*}
\omega^{\lambda_{0}}(x)>C_{0}, \quad \forall x \in A_{\delta_{1}}^{c} \tag{4.28}
\end{equation*}
$$

By continuity, we can choose $\delta_{2}>0$ sufficiently small, such that, for any $\lambda \in\left[\lambda_{0}, \lambda_{0}+\delta_{2}\right]$,

$$
\begin{equation*}
\omega^{\lambda}(x)>\frac{C_{0}}{2}, \quad \forall x \in A_{\delta_{1}}^{c} \tag{4.29}
\end{equation*}
$$

Hence we must have

$$
\begin{equation*}
\left(B_{\lambda}^{+}\right)^{-} \subset B_{\lambda}^{+}(0) \backslash A_{\delta_{1}}^{c}:=\left(B_{\lambda}^{+}(0) \backslash B_{\lambda_{0}}^{+}(0)\right) \cup A_{\delta_{1}} \tag{4.30}
\end{equation*}
$$

for any $\lambda \in\left[\lambda_{0}, \lambda_{0}+\delta_{2}\right]$. By (4.20) and local integrability of $|x|^{a} u^{p-1}$ in $\overline{\mathbb{R}_{+}^{n}}$, we can choose $\delta_{1}$ and $\delta_{2}$ sufficiently small such that, for any $\lambda \in\left[\lambda_{0}, \lambda_{0}+\delta_{2}\right]$,

$$
\begin{equation*}
C \lambda^{2 \varepsilon}\left\||x|^{a} u^{p-1}\right\|_{L^{\frac{n}{n-2 \varepsilon}}\left(\left(B_{\lambda}^{+}\right)^{-}\right)}+C(\delta(\varepsilon))\left|\left(B_{\lambda}^{+}\right)^{-}\right|^{\frac{1}{q}}\left\||x|^{a} u^{p-1}\right\|_{L^{\frac{q}{q-1}}\left(\left(B_{\lambda}^{+}\right)^{-}\right)}<\frac{1}{2} . \tag{4.31}
\end{equation*}
$$

Then, by the same argument as in step 1 , we obtain that for any $\lambda \in\left[\lambda_{0}, \lambda_{0}+\delta_{2}\right]$,

$$
\begin{equation*}
\omega^{\lambda}(x) \geq 0, \quad \forall x \in B_{\lambda}^{+}(0) \tag{4.32}
\end{equation*}
$$

This contradicts the definition of $\lambda_{0}$. Hence, (4.25) must hold true.
However, by (4.4), (4.9), (4.25) and the fact that $n+a>0$, we obtain

$$
\begin{align*}
0 & =\omega^{\lambda_{0}}(x)=u_{\lambda_{0}}(x)-u(x)  \tag{4.33}\\
& =\int_{B_{\lambda_{0}}^{+}(0)}\left(G^{+}(x, y)-G^{+}\left(x, y^{\lambda_{0}}\right)\right)|y|^{a}\left(\left(\frac{\lambda_{0}}{|y|}\right)^{2(n+a)}-1\right) u^{p}(y) d y>0
\end{align*}
$$

for any $x \in B_{\lambda_{0}}^{+}(0)$, which is absurd. Thus we must have $\lambda_{0}=+\infty$, that is,

$$
\begin{equation*}
u(x) \geq u\left(\frac{\lambda^{2} x}{|x|^{2}}\right), \quad \forall x \in \mathbb{R}_{+}^{n}, \quad|x| \geq \lambda, \quad \forall 0<\lambda<+\infty \tag{4.34}
\end{equation*}
$$

Therefore, we obtain that $u$ is radially nondecreasing. For arbitrary $|x| \geq 1, x \in \mathbb{R}_{+}^{n}$, let $\lambda:=\sqrt{|x|}$, then (4.34) yields that

$$
\begin{equation*}
u(x) \geq u\left(\frac{x}{|x|}\right) \tag{4.35}
\end{equation*}
$$

and hence, we arrive at the following lower bound estimate:

$$
\begin{equation*}
u(x) \geq \min _{|x|=1, x_{n} \geq \frac{1}{\sqrt{n}}} u(x):=C_{0}>0, \quad \forall|x| \geq 1, \quad x_{n} \geq \frac{|x|}{\sqrt{n}} \tag{4.36}
\end{equation*}
$$

The lower bound estimate (4.36) can be improved remarkably using the "Bootstrap" iteration technique and the integral equation (1.3).

In fact, let $\mu_{0}:=0$, we infer from the integral equation (1.3), (4.18) and (4.36) that, for any $|x| \geq 1$ and $x_{n} \geq \frac{|x|}{\sqrt{n}}$,

$$
\begin{align*}
u(x) & \geq \int_{0<|y| \leq \frac{1}{100}|x|, y_{n} \geq \frac{|y|}{\sqrt{n}}} G^{+}(x, y)|y|^{a} C_{0}^{p}|y|^{p \mu_{0}} d y  \tag{4.37}\\
& \geq C \int_{0<|y| \leq \frac{1}{100}|x|, y_{n} \geq \frac{|y|}{\sqrt{n}}} \frac{x_{n} y_{n}}{|x-y|^{2}}|y|^{p \mu_{0}+a} d y \\
& \geq \frac{C}{|x|} \int_{0}^{\frac{|x|}{100}} r^{n+a+p \mu_{0}} d r \\
& \geq C_{1}|x|^{p \mu_{0}+(n+a)},
\end{align*}
$$

where we have used the fact $(n+a)+p \mu_{0}>0$ since $a>-n$ and $1 \leq p<+\infty$. Let $\mu_{1}:=p \mu_{0}+(n+a)$. Due to $1 \leq p<+\infty$ and $a>-n$, our important observation is

$$
\begin{equation*}
\mu_{1}:=p \mu_{0}+(n+a)>\mu_{0} . \tag{4.38}
\end{equation*}
$$

Thus we have obtained a better lower bound estimate than (4.36) after one iteration, that is,

$$
\begin{equation*}
u(x) \geq C_{1}|x|^{\mu_{1}}, \quad \forall|x| \geq 1, \quad x_{n} \geq \frac{|x|}{\sqrt{n}} \tag{4.39}
\end{equation*}
$$

For $k=0,1,2, \cdots$, define

$$
\begin{equation*}
\mu_{k+1}:=p \mu_{k}+(n+a) \tag{4.40}
\end{equation*}
$$

Since $a>-n$ and $1 \leq p<+\infty$, it is easy to see that the sequence $\left\{\mu_{k}\right\}$ is monotone increasing with respect to $k$ and $(n+a)+p \mu_{k}>0$ for any $k=0,1,2, \cdots$. Continuing the above iteration process involving the integral equation (1.3), we have the following lower bound estimates for every $k=0,1,2, \cdots$,

$$
\begin{equation*}
u(x) \geq C_{k}|x|^{\mu_{k}}, \quad \forall|x| \geq 1, \quad x_{n} \geq \frac{|x|}{\sqrt{n}} \tag{4.41}
\end{equation*}
$$

From (4.41) and the obvious property that

$$
\begin{equation*}
\mu_{k} \rightarrow+\infty, \quad \text { as } k \rightarrow+\infty \tag{4.42}
\end{equation*}
$$

we can conclude the following lower bound estimates for positive solution $u$.
Theorem 4.2. Assume $n \geq 1, a>-n$ and $1 \leq p<+\infty$. Suppose $u \in C\left(\overline{\mathbb{R}_{+}^{n}}\right)$ is a positive solution to IE (1.3), then it satisfies the following lower bound estimates: for all $x \in \mathbb{R}_{+}^{n}$ satisfying $|x| \geq 1$ and $x_{n} \geq \frac{|x|}{\sqrt{n}}$,

$$
\begin{equation*}
u(x) \geq C_{\kappa}|x|^{\kappa}, \quad \forall \kappa<+\infty \tag{4.43}
\end{equation*}
$$

The lower bound estimates in Theorem 4.2 obviously contradicts the integral equation (1.3). In fact, since $a>-n$, by (4.18) and (4.36), we have

$$
\begin{align*}
+\infty>u\left(\frac{e_{n}}{100}\right) & =\int_{\mathbb{R}_{+}^{n}} G\left(\frac{e_{n}}{100}, y\right)|y|^{a} u^{p}(y) d y  \tag{4.44}\\
& \geq \int_{|y| \geq 1, y_{n} \geq \frac{|y|}{\sqrt{n}}} G\left(\frac{e_{n}}{100}, y\right)|y|^{a} u^{p}(y) d y \\
& \geq C \int_{|y| \geq 1, y_{n} \geq \frac{|y|}{\sqrt{n}}} \frac{y_{n}}{|y|^{2}}|y|^{a+1} d y \\
& \geq C \int_{|y| \geq 1, y_{n} \geq \frac{|y|}{\sqrt{n}}}|y|^{a} d y \\
& =+\infty,
\end{align*}
$$

where the unit vector $e_{n}:=(0, \cdots, 0,1) \in \mathbb{R}_{+}^{n}$. This is a contradiction! Thus we must have $u \equiv 0$ in $\overline{\mathbb{R}_{+}^{n}}$.

This concludes our proof of Theorem (1.4.
