ON THE ZEROS OF EPSTEIN ZETA FUNCTIONS NEAR THE CRITICAL LINE

ABSTRACT. Let Q be a positive definite quadratic form with integral coefficients and let E(s,Q) be the Epstein zeta function associated with Q. Assume that the class number of Q is bigger than 1. Then we estimate the number of zeros of E(s,Q) in the region $\Re s > \sigma_T(\theta) := 1/2 + (\log T)^{-\theta}$ and $T < \Im s < 2T$, to provide its asymptotic formula for fixed $0 < \theta < 1$ conditionally. Moreover, it is unconditional if the class number of Q is 2 or 3 and $0 < \theta < 1/13$.

1. Introduction

Let $K = \mathbb{Q}(\sqrt{D})$ be a quadratic imaginary field of class number $h := h_D$ and let χ_1, \dots, χ_h be its ideal class characters. The Hecke *L*-function attached to χ_j is defined by

$$L_j(s) := L(s, \chi_j) := \sum_{\mathfrak{n}} \frac{\chi_j(\mathfrak{n})}{\mathcal{N}(\mathfrak{n})^s} = \prod_{\mathfrak{p}} \left(1 - \frac{\chi_j(\mathfrak{p})}{\mathcal{N}(\mathfrak{p})^s} \right)^{-1}$$

for $\Re s > 1$, where \mathcal{N} is the norm. Each L_j has an analytic continuation to \mathbb{C} except for a possible pole at s = 1 and it satisfies the functional equation

$$\left(\frac{\sqrt{-D}}{2\pi}\right)^{s} \Gamma(s) L_{j}(s) = \left(\frac{\sqrt{-D}}{2\pi}\right)^{1-s} \Gamma(1-s) L_{j}(1-s). \tag{1.1}$$

By the Euler product and (1.1), L_j has no zeros in $\Re s > 1$ and the negative integers are the only zeros of L_j in $\Re s < 0$. All the other zeros are on the strip $0 \le \Re s \le 1$ and we believe that they are actually on the line $\Re s = 1/2$.

These Hecke L-functions have a functional relation with an Epstein zeta function. To be precise, let Q be a positive definite quadratic form with integral coefficients and its fundamental discriminant D. The Epstein zeta function E(s,Q) associated with Q is defined by

$$E(s,Q) := \sum_{\substack{m,n \in \mathbb{Z} \\ (m,n) \neq (0,0)}} \frac{1}{Q(m,n)^s}$$

for $\Re s > 1$. It satisfies

$$E(s,Q) = \frac{w_D}{h_D} \sum_j \overline{\chi_j(\mathfrak{a}_Q)} L_j(s), \qquad (1.2)$$

where w_D is the number of roots of unity in K and \mathfrak{a}_Q is an integer ideal in the ideal class corresponding to the equivalence class of Q. If $h_D = 1$, then the Epstein zeta function $E(s,Q) = w_D L_1(s)$ is nothing but a Hecke L-function up to a constant factor. Hence we expect E(s,Q) satisfy the generalized Riemann hypothesis. However, if $h_D > 1$, the distribution of zeros of E(s,Q) is different to the Riemann zeta function and indeed E(s,Q)

has zeros off the line $\Re s = 1/2$. Davenport and Heilbronn [3] showed that E(s,Q) has infinitely many zeros on $\Re s > 1$. Voronin [11] showed that the number of zeros of E(s,Q) in the rectangle $\sigma_1 < \Re s < \sigma_2$ and $T < \Im s < 2T$ is

$$N_{E(s,Q)}(\sigma_1,\sigma_2:T,2T)\gg T$$

for any fixed $1/2 < \sigma_1 < \sigma_2 < 1$ as a consequence of a joint universality of Hecke *L*-functions. The author in [8] proved that

$$\lim_{T \to \infty} \frac{1}{T} N_{E(s,Q)}(\sigma_1, \sigma_2 : T, 2T) = \int_{\sigma_1}^{\sigma_2} g(\sigma) d\sigma$$

holds for any $1/2 < \sigma_1 \le \sigma_2$ and some nonnegative continuous function $g(\sigma)$. By a straightforward adaptation of [7], the author in [9] improved the above asymptotic formula to

$$\frac{1}{T} N_{E(s,Q)}(\sigma_1, \sigma_2 : T, 2T) = \int_{\sigma_1}^{\sigma_2} g(\sigma) d\sigma + O\left(\frac{\log \log T}{(\log T)^{\sigma_1/2}}\right)$$

for h=2,3 and fixed $1/2<\sigma_1<\sigma_2<1$. The author with Gonek in [4] considered the case h>3 and proved that

$$\frac{1}{T}N_{E(s,Q)}(\sigma_1,\sigma_2:T,2T) = \int_{\sigma_1}^{\sigma_2} g(\sigma)d\sigma + O(e^{-b\sqrt{\log\log T}})$$

for fixed $1/2 < \sigma_1 < \sigma_2 < 1$.

Now we examine the zero-density on or near the 1/2-line for a linear combination of L-functions with a same functional equation, which generalizes our Epstein zeta functions. Bombieri and Hejhal in [2] proved that almost all zeros of a linear combination F(s) of inequivalent L-functions with a same functional equation are simple and on the 1/2-line assuming RH and a zero-spacing assumption for each L-function. Hejhal in [6] investigated the zeros of $F(s) = (\cos \alpha)e^{iw_1}L_1(s) + (\sin \alpha)e^{iw_2}L_2(s)$ near the 1/2-line and showed that

$$\frac{T \log T}{G\sqrt{\log \log T}} \ll N_{F(s)}(\sigma_1, \infty : T, 2T) \ll \frac{T \log T}{G\sqrt{\log \log T}}$$
(1.3)

for $\sigma_1 = 1/2 + G/\log T$ and for almost all α , where $(\log \log T)^{\kappa} \leq G \leq (\log T)^{1-\delta}$, $\kappa \in (1,3)$ and $\delta \in (0,1/10)$. We expect that it holds for all α except for the cases $\cos \alpha = 0$ and $\sin \alpha = 0$, but it is still an open question whether a given Epstein zeta function with class number 2 or 3 satisfy (1.3). Selberg in [10] sketched his idea which proves (1.3) for almost all linear combinations F(s) of L-functions.

The aim of this paper is finding an asymptotic formula for the zero counting function

$$N_{E(s,Q)}(\sigma_T,\infty:T,2T)$$

of a given Epstein zeta function E(s,Q) as $T\to\infty$, where

$$\sigma_T = \sigma_T(\theta) = \frac{1}{2} + \frac{1}{(\log T)^{\theta}}$$

for fixed $0 < \theta < 1$. Let L_1, \ldots, L_J be inequivalent Hecke L-functions on K, i.e., $L_j(s) = L(s, \chi_j)$ and $\chi_j \neq \chi_\ell, \overline{\chi}_\ell$ for $j \neq \ell$. By the Euler product, we may write

$$\log L(s, \chi_j) = \sum_{p} \sum_{n=1}^{\infty} \frac{a_j(p^n)}{p^{ns}}$$

for $\Re s > 1$, then it is well-known that

$$\sum_{p} \frac{a_j(p)a_\ell(p)}{p^{2\sigma_T}} = \delta_{j,\ell}\xi_j\theta\log\log T + c_{j,\ell} + O\left(\frac{1}{(\log T)^{\theta}}\right)$$
(1.4)

for $j, \ell \leq J$, where $\delta_{j,\ell} = 1$ if $j = \ell$, $\delta_{j,\ell} = 0$ if $j \neq \ell$, $\xi_j = 4$ if χ_j is real, $\xi_j = 2$ if χ_j is nonreal and the $c_{j,\ell}$ are some constants. Consider

$$F_J(s) := \sum_{j=1}^J b_j L_j(s)$$

for $b_1, \ldots, b_J \in \mathbb{C} \setminus \{0\}$ satisfying

$$|b_1|^2 + \dots + |b_J|^2 = 1.$$

The Epstein zeta function E(s,Q) is a special case of $F_J(s)$ up to a constant factor by (1.2) and the relation $L(s,\chi) = L(s,\bar{\chi})$. In this case, J is the sum of the number of real characters and the half of the number of non-real characters. Hence, J=2 if h=2,3 and J>2 if h>3.

By Littlewood's lemma, the zero counting function

$$N_{F_I}(\sigma:T) := N_{F_I}(\sigma,\infty:T,2T)$$

for $\sigma > 1/2$ is essentially a derivative of the integral

$$\frac{1}{2\pi} \int_{T}^{2T} \log |F_J(\sigma + it)| dt.$$

Moreover, we believe that the following conjecture is true.

Conjecture 1.1. Let J > 1, $0 < \theta < 1$ and $\sigma_T = 1/2 + (\log T)^{-\theta}$. Then there exists $\eta > 0$ such that

$$\frac{1}{T} \int_{T}^{2T} \log|F_{J}(\sigma_{T} + it)|dt = \mathbb{E}\left[\log|F_{J}(\sigma_{T} : X)|\right] + O\left(\frac{1}{(\log T)^{\eta}}\right)$$
(1.5)

as $T \to \infty$, where

$$F_J(s:X) := \sum_{j=1}^J b_j L_j(s:X)$$

and

$$L_j(s:X) := \prod_{\mathfrak{p}} \left(1 - \frac{\chi_j(\mathfrak{p}) X(\mathcal{N}(\mathfrak{p}))}{\mathcal{N}(\mathfrak{p})^s} \right)^{-1}$$

are the random models of $F_J(s)$ and $L_j(s)$ for j = 1, ..., J. Here, the X(p) are uniformly and independently distributed on the unit circle \mathbb{T} and $X(p^{\ell}) := X(p)^{\ell}$.

Conjecture 1.1 for J > 2 is technically more difficult than the estimates in [4] for fixed $\sigma > 1/2$, since there are more logarithmic singularties near the 1/2-line. However, if J = 2, it is possible to prove Conjecture 1.1 for a small θ . One sees that

$$\int_{T}^{2T} \log |F_2(\sigma_T + it)| dt = \int_{T}^{2T} \log |b_1 L_2(\sigma_T + it)| dt + \int_{T}^{2T} \log \left| \frac{L_1}{L_2}(\sigma_T + it) + \frac{b_2}{b_1} \right| dt.$$

The first integral on the right hand side can be estimated by an usual Dirichlet polynomial approximation for $\log |L_2(\sigma_T + it)|$ and the second integral can be estimated by adapting [5]. Since its proof is straightforward from [5], we state it without a proof as follows.

Theorem 1.2. Conjecture 1.1 holds for J = 2 and $0 < \theta < 1/13$ with $\eta < (1 - 13\theta)/4$.

The main feature of this paper is our estimation of

$$\mathbb{E}\big[\log|F_J(\sigma_T:X)|\big]$$

as $T \to \infty$ for J > 1.

Theorem 1.3. Let J > 1, $0 < \theta < 1$ and $\sigma_T = 1/2 + (\log T)^{-\theta}$. Then

$$\mathbb{E}\left[\log|F_{J}(\sigma_{T}:X)|\right] = \frac{\sqrt{\theta \log \log T}}{\sqrt{\xi \pi^{J}}} \sum_{\ell=1}^{J} \int_{\mathcal{R}_{\ell}} u_{\ell} e^{-\sum_{j} u_{j}^{2}/\xi_{j}} d\boldsymbol{u}$$
$$+ \sum_{\ell=1}^{J} \frac{\log|b_{\ell}|}{\sqrt{\xi \pi^{J}}} \int_{\mathcal{R}_{\ell}} e^{-\sum_{j} u_{j}^{2}/\xi_{j}} d\boldsymbol{u} + O\left(\frac{1}{(\log \log T)^{1/4}}\right)$$

as $T \to \infty$, where

$$\xi := \prod_{j} \xi_{j},$$

$$\mathcal{R}_{\ell} := \{ (u_{1}, \dots, u_{J}) \in \mathbb{R}^{J} : u_{\ell} = \max\{u_{1}, \dots, u_{J}\} \}$$

$$for \ \ell = 1, 2, \dots, J \ and \ d\mathbf{u} = du_{1} \cdots du_{J}.$$

$$(1.6)$$

One expects that Littlewood's lemma, Conjecture 1.1 and Theorem 1.3 imply an asymptotic of $N_{F_J}(\sigma_T:T)$ as $T\to\infty$, but the O-term in Theorem 1.3 is too big. Instead, we estimate the difference

$$\mathbb{E}\big[\log|F_J(\sigma_T(\theta_1):X)|\big] - \mathbb{E}\big[\log|F_J(\sigma_T(\theta_2):X)|\big]$$

for a small $|\theta_1 - \theta_2|$ to prove our main theorem.

Theorem 1.4. Let $J \ge 2$ and $0 < \theta < 1$ and assume Conjecture 1.1, then

$$N_{F_{J}}(\sigma_{T}(\theta):T) = \frac{1}{4\pi^{1+J/2}} \frac{T(\log T)^{\theta}}{\sqrt{\xi\theta \log \log T}} \sum_{\ell=1}^{J} \int_{\mathcal{R}_{\ell}} u_{\ell} e^{-\sum_{j} u_{j}^{2}/\xi_{j}} d\boldsymbol{u} + O\left(\frac{T(\log T)^{\theta}}{(\log \log T)^{5/4}}\right)$$

as $T \to \infty$, where ξ and \mathcal{R}_{ℓ} are defined in Theorem 1.3.

By Theorem 1.2, we see that Theorem 1.4 holds for J=2 and $0<\theta<1/13$ unconditionally. When $F_J(s)$ is the Epstein zeta function E(s,Q) up to a constant factor, it is interesting to see that

$$\xi = 2^{3J-h}.$$

2. Proof of Theorems 1.3 and 1.4

Let

$$\mathbf{L}(\sigma:X) := \big(\log|L_1(\sigma:X)|, \ldots, \log|L_J(\sigma:X)|, \Im\log L_1(\sigma:X), \ldots, \Im\log L_J(\sigma:X)\big).$$

Define

$$\Psi_{\theta,T}(\mathbf{B}) := \mathbb{P}(\mathbf{L}(\sigma_T : X) \in \mathbf{B}) = \max\{X \in \mathbb{T}^\infty : \mathbf{L}(\sigma_T : X) \in \mathbf{B}\}$$
(2.1)

for a Borel set **B** in \mathbb{R}^{2J} . It is known that the measure $\Psi_{\theta,T}$ has a density function $G_{\theta,T}$, so that for

$$\Psi_{\theta,T}(\mathbf{B}) = \int_{\mathbf{B}} G_{\theta,T}(\boldsymbol{u}, \boldsymbol{v}) d\boldsymbol{u} d\boldsymbol{v},$$

where $\mathbf{u} = (u_1, \dots, u_J), \mathbf{v} = (v_1, \dots, v_J) \in \mathbb{R}^J$. (For instance, see the proof of Lemma 3.3 in [4].) Then we see that

$$\mathbb{E}\left[\log|F_{J}(\sigma_{T}:X)|\right] = \int_{\mathbb{R}^{2J}} \log\left|\sum_{j\leq J} b_{j} e^{u_{j}+iv_{j}}\right| d\Psi_{\theta,T}(\boldsymbol{u},\boldsymbol{v})$$

$$= \int_{\mathbb{R}^{2J}} \log\left|\sum_{j\leq J} b_{j} e^{u_{j}+iv_{j}}\right| G_{\theta,T}(\boldsymbol{u},\boldsymbol{v}) d\boldsymbol{u} d\boldsymbol{v}$$
(2.2)

and

$$\hat{\Psi}_{\theta,T}(\boldsymbol{x},\boldsymbol{y}) = \int_{\mathbb{R}^J} e^{2\pi i (\boldsymbol{u}\cdot\boldsymbol{x} + \boldsymbol{v}\cdot\boldsymbol{y})} d\Psi_{\theta,T}(\boldsymbol{u},\boldsymbol{v}) = \int_{\mathbb{R}^J} e^{2\pi i (\boldsymbol{u}\cdot\boldsymbol{x} + \boldsymbol{v}\cdot\boldsymbol{y})} G_{\theta,T}(\boldsymbol{u},\boldsymbol{v}) d\boldsymbol{u} d\boldsymbol{v},$$

where $\mathbf{u} = (u_1, \dots, u_J), \mathbf{v} = (v_1, \dots, v_J), \mathbf{x} = (x_1, \dots, x_J), \mathbf{y} = (y_1, \dots, y_J) \in \mathbb{R}^J, \mathbf{u} \cdot \mathbf{x} = u_1x_1 + \dots + u_Jx_J \text{ and } \mathbf{v} \cdot \mathbf{y} = v_1y_1 + \dots + v_Jy_J.$ Since $G_{\theta,T}(\mathbf{u}, \mathbf{v})$ is the inverse Fourier transform of $\hat{\Psi}_{\theta,T}(\mathbf{x}, \mathbf{y})$

$$G_{\theta,T}(\boldsymbol{u}, \boldsymbol{v}) = \int_{\mathbb{R}^J} e^{-2\pi i (\boldsymbol{u} \cdot \boldsymbol{x} + \boldsymbol{v} \cdot \boldsymbol{y})} \hat{\Psi}_{\theta,T}(\boldsymbol{x}, \boldsymbol{y}) d\boldsymbol{u} d\boldsymbol{v},$$

we examine various properties of $\hat{\Psi}_{\theta,T}(\boldsymbol{x},\boldsymbol{y})$ to study $G_{\theta,T}(\boldsymbol{u},\boldsymbol{v})$.

Proposition 2.1. There exist constants $c_1, c_2 > 0$ such that

$$|\hat{\Psi}_{\theta,T}(\boldsymbol{x},\boldsymbol{y})| \le \exp\left(-c_1 \frac{(\sum_j x_j^2 + y_j^2)^{1/2\sigma_T}}{\log(\sum_j x_j^2 + y_j^2)}\right)$$

for $\sum_j x_j^2 + y_j^2 \ge c_2$,

$$|\hat{\Psi}_{\theta,T}(\boldsymbol{x},\boldsymbol{y})| \le \exp\left(-\left(\frac{\pi^2\theta}{2}\log\log T + O(1)\right)\sum_{j\le J}(x_j^2 + y_j^2)\right)$$

for $\sum_{j \le J} (x_j^2 + y_j^2) \le e^{(\log T)^{\theta/2}}$, and

$$\hat{\Psi}_{\theta,T}(\boldsymbol{x},\boldsymbol{y}) = e^{-\pi^2\theta \log \log T \sum_{j \le J} \xi_j(x_j^2 + y_j^2)} \left(P(\boldsymbol{x},\boldsymbol{y}) + O\left(\sum_{j=1}^J (x_j^2 + y_j^2)^3 + \frac{1}{(\log T)^{\theta}}\right) \right)$$

for $\sum_{j} x_j^2 + y_j^2 \le c_2$, where

$$P(\boldsymbol{x}, \boldsymbol{y}) := \sum_{\boldsymbol{k}, \boldsymbol{\ell} \in (\mathbb{Z}_{\geq 0})^J} \tilde{B}_{\boldsymbol{k}, \boldsymbol{\ell}} \boldsymbol{x}^{\boldsymbol{k}} \boldsymbol{y}^{\boldsymbol{\ell}}$$

and the coefficients $\tilde{B}_{k,\ell}$ are independent to θ and T satisfying

$$\tilde{B}_{0,0} = 1$$

and

$$\tilde{B}_{k,\ell} = 0$$

if $K(\mathbf{k} + \mathbf{\ell}) = 1$ or > 5. Here, $\mathbf{x} = (x_1, \dots, x_J), \mathbf{y} = (y_1, \dots, y_J) \in \mathbb{R}^J$, $\mathbf{k} = (k_1, \dots, k_J), \mathbf{\ell} = (\ell_1, \dots, \ell_J) \in (\mathbb{Z}_{\geq 0})^J$ and

$$\mathcal{K}(\boldsymbol{k}) := k_1 + \dots + k_J, \qquad \boldsymbol{x}^{\boldsymbol{k}} := \prod_{j \leq J} x_j^{k_j}.$$

Proposition 2.2. Let k, ℓ, m, n be vectors in $(\mathbb{Z}_{\geq 0})^J$ and

$$q_{\boldsymbol{k},\boldsymbol{\ell}:\boldsymbol{m},\boldsymbol{n}} = \frac{\tilde{B}_{2\boldsymbol{k}+\boldsymbol{m},2\boldsymbol{\ell}+\boldsymbol{n}}}{i^{\mathcal{K}(\boldsymbol{m}+\boldsymbol{n})}\pi^{2J+\mathcal{K}(2\boldsymbol{k}+2\boldsymbol{\ell}+\boldsymbol{m}+\boldsymbol{n})}} \prod_{j} \bigg(\frac{\Gamma(k_{j}+1/2)\Gamma(\ell_{j}+1/2)}{\xi_{j}^{k_{j}+\ell_{j}+m_{j}+n_{j}+1}} \bigg) \frac{(2\boldsymbol{k}+\boldsymbol{m})!(2\boldsymbol{\ell}+\boldsymbol{n})!}{(2\boldsymbol{k})!\boldsymbol{m}!(2\boldsymbol{\ell})!\boldsymbol{n}!}.$$

Then, we have

$$G_{\theta,T}(\boldsymbol{u},\boldsymbol{v}) = \exp\left(-\sum_{j} \frac{u_{j}^{2} + v_{j}^{2}}{\theta \xi_{j} \log \log T}\right) \sum_{\boldsymbol{k},\boldsymbol{\ell},\boldsymbol{m},\boldsymbol{n} \in (\mathbb{Z}_{\geq 0})^{J}} \frac{q_{\boldsymbol{k},\boldsymbol{\ell}:\boldsymbol{m},\boldsymbol{n}}}{(\theta \log \log T)^{J+\mathcal{K}(\boldsymbol{k}+\boldsymbol{\ell}+\boldsymbol{m}+\boldsymbol{n})}} \boldsymbol{u}^{\boldsymbol{m}} \boldsymbol{v}^{\boldsymbol{n}} + O\left(\frac{1}{(\log \log T)^{J+3}}\right)$$

for all $\mathbf{u} = (u_1, \dots, u_J), \mathbf{v} = (v_1, \dots, v_J) \in \mathbb{R}^J$, and there exists a constant c > 0 such that

$$G_{\theta,T}(\boldsymbol{u}, \boldsymbol{v}) \ll \exp\left(-c\sum_{j \leq J} \frac{u_j^2 + v_j^2}{\log\log T}\right)$$

for all $\mathbf{u} = (u_1, \dots, u_J), \mathbf{v} = (v_1, \dots, v_J) \in \mathbb{R}^J$.

Note that

$$q_{0,0:0,0} = \pi^{-J} \prod_{i} \xi_{j}^{-1} = \pi^{-J} \xi^{-1}$$

and

$$q_{\boldsymbol{k},\boldsymbol{\ell}:\boldsymbol{m},\boldsymbol{n}}=0$$

if $\mathcal{K}(2\mathbf{k} + 2\mathbf{\ell} + \mathbf{m} + \mathbf{n}) = 1$ or > 5. We also need the following lemma.

Lemma 2.3. Let k be a positive integer, $M \ge 1$ and $b_j \in \mathbb{C}$ for $j \le J$. Then there exists an absolute constant C > 0 such that

$$\int_{\mathbb{R}^{2J}} \left| \log \left| \sum_{j < J} b_j e^{u_j + iv_j} \right| \right|^{2k} e^{-\sum_j (u_j^2 + v_j^2)/M} d\boldsymbol{u} d\boldsymbol{v} \ll M^{J+k} (Ck)^k + M^J (Ck)^{2k}.$$

We prove the propositions and the lemma in §3. Now we shall estimate the integral in (2.2). By the Cauchy-Schwarz inequality, Proposition 2.2 and Lemma 2.3, we find that

$$\mathbb{E}\left[\left.\log\left|F_{J}(\sigma_{T}:X)\right|\right] = \int_{[-M_{1},M_{1}]^{2J}}\log\left|\sum_{j\leq J}b_{j}e^{u_{j}+iv_{j}}\right|G_{\theta,T}(\boldsymbol{u},\boldsymbol{v})d\boldsymbol{u}d\boldsymbol{v} + O\left(\frac{1}{(\log\log T)^{\eta}}\right)$$

for any $\eta > 0$, where $M_1 = \eta' \sqrt{\log \log T \log \log \log T}$ with $\eta' > 0$ depending on η . By the Cauchy-Schwarz inequality and Lemma 2.3, we also have

$$\left(\int_{[-M_1,M_1]^{2J}} \log \left| \sum_{j \leq J} b_j e^{u_j + iv_j} \right| d\boldsymbol{u} d\boldsymbol{v} \right)^2 \\
\leq (2M_1)^{2J} \int_{[-M_1,M_1]^{2J}} \left(\log \left| \sum_{j \leq J} b_j e^{u_j + iv_j} \right| \right)^2 d\boldsymbol{u} d\boldsymbol{v}$$

$$\ll M_1^{2J} \int_{\mathbb{R}^{2J}} \left(\log \left| \sum_{j \leq J} b_j e^{u_j + iv_j} \right| \right)^2 e^{-\sum_j (u_j^2 + v_j^2)/M_1^2} d\boldsymbol{u} d\boldsymbol{v}$$

$$\ll M_1^{4J+2}.$$

Hence, by Proposition 2.2

$$\mathbb{E}\left[\log|F_{J}(\sigma_{T}:X)|\right] = \sum_{\boldsymbol{k},\boldsymbol{\ell},\boldsymbol{m},\boldsymbol{n}\in(\mathbb{Z}_{\geq0})^{J}} \frac{q_{\boldsymbol{k},\boldsymbol{\ell}:\boldsymbol{m},\boldsymbol{n}}}{(\theta\log\log T)^{J+\mathcal{K}(\boldsymbol{k}+\boldsymbol{\ell}+\boldsymbol{m}+\boldsymbol{n})}}$$

$$\int_{[-M_{1},M_{1}]^{2J}} \log\left|\sum_{j\leq J} b_{j}e^{u_{j}+iv_{j}}\right| \exp\left(-\sum_{j} \frac{u_{j}^{2}+v_{j}^{2}}{\theta\xi_{j}\log\log T}\right) \boldsymbol{u}^{\boldsymbol{m}}\boldsymbol{v}^{\boldsymbol{n}}d\boldsymbol{u}d\boldsymbol{v}$$

$$+O\left(\frac{(\log\log\log T)^{J+1/2}}{(\log\log T)^{5/2}}\right).$$

Once again, by the Cauchy-Schwarz inequality, Proposition 2.2 and Lemma 2.3, we find that $\mathbb{E}[\log|F_J(\sigma_T:X)|]$

$$= \sum_{\boldsymbol{k},\boldsymbol{\ell},\boldsymbol{m},\boldsymbol{n}\in(\mathbb{Z}_{\geq 0})^{J}} \frac{q_{\boldsymbol{k},\boldsymbol{\ell}:\boldsymbol{m},\boldsymbol{n}}}{(\theta \log \log T)^{J+\mathcal{K}(\boldsymbol{k}+\boldsymbol{\ell}+\boldsymbol{m}+\boldsymbol{n})}}$$

$$\int_{\mathbb{R}^{2J}} \log \left| \sum_{j\leq J} b_{j} e^{u_{j}+iv_{j}} \right| \exp\left(-\sum_{j} \frac{u_{j}^{2}+v_{j}^{2}}{\theta \xi_{j} \log \log T}\right) \boldsymbol{u}^{\boldsymbol{m}} \boldsymbol{v}^{\boldsymbol{n}} d\boldsymbol{u} d\boldsymbol{v}$$

$$+ O\left(\frac{(\log \log \log T)^{J+1/2}}{(\log \log T)^{5/2}}\right)$$

$$= \sum_{\boldsymbol{k},\boldsymbol{\ell},\boldsymbol{m},\boldsymbol{n}\in(\mathbb{Z}_{\geq 0})^{J}} \frac{q_{\boldsymbol{k},\boldsymbol{\ell}:\boldsymbol{m},\boldsymbol{n}}}{(\theta \log \log T)^{\mathcal{K}(\boldsymbol{k}+\boldsymbol{\ell})+\mathcal{K}(\boldsymbol{m}+\boldsymbol{n})/2}} I_{\boldsymbol{m},\boldsymbol{n}}(\theta,T) + O\left(\frac{(\log \log \log T)^{J+1/2}}{(\log \log T)^{5/2}}\right),$$

$$(2.3)$$

where

$$I_{\boldsymbol{m},\boldsymbol{n}}(\theta,T) := \int_{\mathbb{R}^{2J}} \log \left| \sum_{j < J} b_j e^{(u_j + iv_j)\sqrt{\theta \log \log T}} \right| e^{-\sum_j (u_j^2 + v_j^2)/\xi_j} \boldsymbol{u}^{\boldsymbol{m}} \boldsymbol{v}^{\boldsymbol{n}} d\boldsymbol{u} d\boldsymbol{v}.$$

The logarithm is dominated by the biggest term in the j-sum, so that we divide \mathbb{R}^{2J} into J pieces

$$I_{\boldsymbol{m},\boldsymbol{n}}(\boldsymbol{\theta},T) = \sum_{\ell=1}^J \int_{\mathbb{R}^J} \int_{\mathcal{R}_\ell} \log \bigg| \sum_{j \leq J} b_j e^{(u_j + iv_j)\sqrt{\theta \log \log T}} \bigg| e^{-\sum_j (u_j^2 + v_j^2)/\xi_j} \boldsymbol{u^m} \boldsymbol{v^n} d\boldsymbol{u} d\boldsymbol{v},$$

where \mathcal{R}_{ℓ} is defined in (1.6). By symmetry, it is enough to consider \mathcal{R}_1 . Then

$$\begin{split} \int_{\mathbb{R}^{J}} \int_{\mathcal{R}_{1}} \log \left| \sum_{j \leq J} b_{j} e^{(u_{j}+iv_{j})\sqrt{\theta \log \log T}} \right| e^{-\sum_{j} (u_{j}^{2}+v_{j}^{2})/\xi_{j}} \boldsymbol{u}^{\boldsymbol{m}} \boldsymbol{v}^{\boldsymbol{n}} d\boldsymbol{u} d\boldsymbol{v} \\ &= \int_{\mathbb{R}^{J}} \int_{\mathcal{R}_{1}} \log \left| b_{1} e^{(u_{1}+iv_{1})\sqrt{\theta \log \log T}} \right| e^{-\sum_{j} (u_{j}^{2}+v_{j}^{2})/\xi_{j}} \boldsymbol{u}^{\boldsymbol{m}} \boldsymbol{v}^{\boldsymbol{n}} d\boldsymbol{u} d\boldsymbol{v} + \mathcal{E}_{\boldsymbol{m},\boldsymbol{n},1}(\boldsymbol{\theta},T) \\ &= d_{\boldsymbol{n}} \int_{\mathcal{R}_{1}} (\sqrt{\theta \log \log T} u_{1} + \log |b_{1}|) e^{-\sum_{j} u_{j}^{2}/\xi_{j}} \boldsymbol{u}^{\boldsymbol{m}} d\boldsymbol{u} + \mathcal{E}_{\boldsymbol{m},\boldsymbol{n},1}(\boldsymbol{\theta},T), \end{split}$$

where

$$\mathcal{E}_{\boldsymbol{m},\boldsymbol{n},1}(\boldsymbol{\theta},T) := \int_{\mathbb{R}^J} \int_{\mathcal{R}_1} \log \left| 1 + \sum_{j=2}^J \frac{b_j}{b_1} e^{(u_j - u_1 + i(v_j - v_1))\sqrt{\theta \log \log T}} \right| e^{-\sum_j (u_j^2 + v_j^2)/\xi_j} \boldsymbol{u}^{\boldsymbol{m}} \boldsymbol{v}^{\boldsymbol{n}} d\boldsymbol{u} d\boldsymbol{v}$$

and

$$d_{\boldsymbol{n}} := \int_{\mathbb{R}^J} e^{-\sum_j v_j^2/\xi_j} \boldsymbol{v}^{\boldsymbol{n}} d\boldsymbol{v} = \prod_{j \le J} \left(\xi_j^{(n_j+1)/2} \int_{\mathbb{R}} v^{n_j} e^{-v^2} dv \right). \tag{2.4}$$

Note that $\int_{\mathbb{R}} v^{n_j} e^{-v^2} dv = 0$ if n_j is odd, and $= \Gamma((n_j + 1)/2)$ otherwise. Therefore,

$$+ d_{n} \sum_{\ell=1}^{J} \int_{\mathcal{R}_{\ell}} \log |b_{\ell}| e^{-\sum_{j} u_{j}^{2}/\xi_{j}} \boldsymbol{u}^{m} d\boldsymbol{u} + \mathcal{E}_{m,n}(\theta,T),$$

$$(2.5)$$

where

$$\mathcal{E}_{m,n}(\theta,T) := \sum_{\ell=1}^{J} \mathcal{E}_{m,n,\ell}(\theta,T).$$

By estimating $\mathcal{E}_{m,n}(\theta,T)$ in §3.4, we prove the following proposition.

Proposition 2.4. Let $J \geq 2$. Then we have

$$+ \sum_{\mathcal{K}(\boldsymbol{m})=1} q_{0,0:\boldsymbol{m},0} d_{0} \sum_{\ell=1}^{J} \int_{\mathcal{R}_{\ell}} u_{\ell} e^{-\sum_{j} u_{j}^{2}/\xi_{j}} \boldsymbol{u}^{\boldsymbol{m}} d\boldsymbol{u} + O\left(\frac{1}{(\log \log T)^{1/4}}\right)$$

$$= \pi^{-J/2} \prod_{j} \xi_{j}^{-1/2} \sqrt{\theta \log \log T} \sum_{\ell=1}^{J} \int_{\mathcal{R}_{\ell}} u_{\ell} e^{-\sum_{j} u_{j}^{2}/\xi_{j}} d\boldsymbol{u}$$

$$+ \pi^{-J/2} \prod_{j} \xi_{j}^{-1/2} \sum_{\ell=1}^{J} \log|b_{\ell}| \int_{\mathcal{R}_{\ell}} e^{-\sum_{j} u_{j}^{2}/\xi_{j}} d\boldsymbol{u} + O\left(\frac{1}{(\log \log T)^{1/4}}\right).$$

$$(2.6)$$

This proves Theorem 1.3.

Next we prove Theorem 1.4 assuming Conjecture 1.1. By Littlewood's lemma and (2.3) we see that

$$= \frac{T}{2\pi} \left(\mathbb{E}\left[\log |F_{J}(\sigma_{T}(\theta_{1}) : X)|\right] - \mathbb{E}\left[\log |F_{J}(\sigma_{T}(\theta_{2}) : X)|\right] \right) + O\left(\frac{T}{(\log T)^{\eta}}\right),$$
(2.7)

where $\sigma_T(\theta) = 1/2 + (\log T)^{-\theta}$ and $0 < \theta_2 < \theta_1$. We need the following lemma.

Lemma 2.5. Let α be a real number, $\theta_1 > \theta_2 > 0$ and $H_T = \theta_1 - \theta_2$. Suppose that $H_T \to 0$ as $T \to \infty$. Then for each i = 1, 2 we have

$$+ H_{T}d_{\boldsymbol{n}}\alpha\theta_{i}^{\alpha-1}\sum_{\ell=1}^{J}\int_{\mathcal{R}_{\ell}}\log|b_{\ell}|e^{-\sum_{j}u_{j}^{2}/\xi_{j}}\boldsymbol{u}^{\boldsymbol{m}}d\boldsymbol{u}$$

$$+ O\left(\frac{H_{T}}{(\log\log T)^{1/4}} + H_{T}^{2}\sqrt{\log\log T}\right).$$

We prove it in §3.5. Suppose that $H_T \log \log T = o(1)$, then

$$\left(\sqrt{\log\log T}d_{\boldsymbol{n}}\left(-\mathcal{K}(\boldsymbol{k}+\boldsymbol{\ell}) + \frac{1-\mathcal{K}(\boldsymbol{m}+\boldsymbol{n})}{2}\right)\theta^{-1/2}\sum_{\ell=1}^{J}\int_{\mathcal{R}_{\ell}}u_{\ell}e^{-\sum_{j}u_{j}^{2}/\xi_{j}}\boldsymbol{u}^{\boldsymbol{m}}d\boldsymbol{u}\right) + d_{\boldsymbol{n}}\left(-\mathcal{K}(\boldsymbol{k}+\boldsymbol{\ell}) - \frac{\mathcal{K}(\boldsymbol{m}+\boldsymbol{n})}{2}\right)\theta^{-1}\sum_{\ell=1}^{J}\int_{\mathcal{R}_{\ell}}\log|b_{\ell}|e^{-\sum_{j}u_{j}^{2}/\xi_{j}}\boldsymbol{u}^{\boldsymbol{m}}d\boldsymbol{u}\right) + O\left(\frac{T(\log\log\log T)^{J+1/2}}{(\log\log T)^{5/2}} + \frac{H_{T}T}{(\log\log T)^{1/4}} + H_{T}^{2}T\sqrt{\log\log T}\right).$$

Choose $H_T = (\log \log T)^{-2}$ to optimize it, we see that

$$\left(\sqrt{\theta \log \log T} \left(-\mathcal{K}(\mathbf{k}+\ell) + \frac{1-\mathcal{K}(\mathbf{m}+\mathbf{n})}{2}\right) \sum_{\ell=1}^{J} \int_{\mathcal{R}_{\ell}} u_{\ell} e^{-\sum_{j} u_{j}^{2}/\xi_{j}} \mathbf{u}^{\mathbf{m}} d\mathbf{u}\right)$$

$$+ \left(-\mathcal{K}(\mathbf{k}+\ell) - \frac{\mathcal{K}(\mathbf{m}+\mathbf{n})}{2}\right) \sum_{\ell=1}^{J} \int_{\mathcal{R}_{\ell}} \log |b_{\ell}| e^{-\sum_{j} u_{j}^{2}/\xi_{j}} \mathbf{u}^{\mathbf{m}} d\mathbf{u}\right)$$

$$+ O\left(\frac{T(\log T)^{\theta}}{(\log \log T)^{5/4}}\right).$$

We see that the summands are smaller than the O-term unless $\mathbf{k} = \mathbf{\ell} = 0$ and $\mathcal{K}(\mathbf{m} + \mathbf{n}) = 0, 1$. Moreover, $q_{0,0:\mathbf{m},\mathbf{n}} = 0$ if $\mathcal{K}(\mathbf{m} + \mathbf{n}) = 1$. Hence,

$$= \mathbb{E}\left[\exp\left(i \sum_{j\leq J} \bar{z}_j \log L_j(\sigma_T:X) + z_j \log L_j(\sigma_T:\bar{X})\right)\right].$$

Write

$$\log L_j(\sigma:X) := \sum_p g_j(p,\sigma:X), \qquad g_j(p,\sigma:X) := \sum_{n=1}^{\infty} \frac{a_j(p^n)X(p)^n}{p^{n\sigma}},$$

then

$$\hat{\Psi}_{\theta,T}(\boldsymbol{x},\boldsymbol{y}) = \prod_{p} \mathbb{E} \left[\exp \left(i \sum_{j \leq J} \bar{z}_{j} g_{j}(p, \sigma_{T} : X) + z_{j} g_{j}(p, \sigma_{T} : \bar{X}) \right) \right]$$

$$= \prod_{p} \mathbb{E} \left[\prod_{j \leq J} \exp \left(i \left(\bar{z}_{j} g_{j}(p, \sigma_{T} : X) + z_{j} g_{j}(p, \sigma_{T} : \bar{X}) \right) \right) \right]$$

and we see that

$$\left| \mathbb{E} \left[\prod_{j \le J} \exp \left(i \left(\bar{z}_j g_j(p, \sigma_T : X) + z_j g_j(p, \sigma_T : \bar{X}) \right) \right) \right] \right| \le 1.$$
 (3.1)

By Lemma 2.5 in [8] and the argument to justify the equation (3.28) in [8, p. 1828 –1829], there is a constant $C_1 > 0$ such that

for $p^{-\sigma_T} \sqrt{\sum_j x_j^2 + y_j^2} \ge 1$. Hence if $p^{\sigma_T} \le C_2 \sqrt{\sum_j x_j^2 + y_j^2}$ with $C_2 = \min\{1, C_1^{-2}e^{-1}\}$, then

for $\mathbf{k} = (k_1, \dots, k_J)$ and $\mathbf{\ell} = (\ell_1, \dots, \ell_J)$, then each factor of $\hat{\Psi}_{\theta,T}(\mathbf{x}, \mathbf{y})$ is

$$\sum_{\mathbf{k},\ell\geq 0} \frac{i^{\mathcal{K}(\mathbf{k}+\ell)}}{\mathbf{k}!\ell!} \mathbb{E} \left[\prod_{j\leq J} g_j(p,\sigma_T:X)^{k_j} g_j(p,\sigma_T:\bar{X})^{\ell_j} \right] \bar{\mathbf{z}}^{\mathbf{k}} \mathbf{z}^{\ell}$$

$$= \sum_{\mathbf{k},\ell\geq 0} \frac{i^{\mathcal{K}(\mathbf{k}+\ell)}}{\mathbf{k}!\ell!} A_{\mathbf{k},\ell}(p,\sigma_T) \bar{\mathbf{z}}^{\mathbf{k}} \mathbf{z}^{\ell},$$

where the sums are over all $\mathbf{k} = (k_1, \dots, k_J), \mathbf{\ell} = (\ell_1, \dots, \ell_J) \in (\mathbb{Z}_{\geq 0})^J$ and $\mathcal{K}(\mathbf{k}) = k_1 + \dots + k_J, \mathbf{k}! = k_1! \dots k_J!$ and $\mathbf{z}^{\mathbf{k}} = \prod_{j \leq J} z_j^{k_j}$. Since $A_{0,0}(p,\sigma) = 1$ and $A_{0,\mathbf{k}}(p,\sigma) = A_{\mathbf{k},0}(p,\sigma) = 0$ for $\mathbf{k} \neq 0$, the above sum equals

$$1 + \sum_{k,\ell}^* \frac{i^{\mathcal{K}(k+\ell)}}{k!\ell!} A_{k,\ell}(p,\sigma_T) \bar{z}^k z^\ell =: 1 + \mathcal{A}_{\theta,T,x,y}(p),$$

where the *-sum is over all nonzero $k, \ell \in (\mathbb{Z}_{\geq 0})^J$. By estimating (3.3) one can show that

$$|A_{k,\ell}(p,\sigma_T)| \le C_5 p^{-\sigma_T \mathcal{K}(k+\ell)}$$

for some $C_5 > 0$ and all nonzero $k, \ell \in (\mathbb{Z}_{\geq 0})^J$. Thus,

$$|\mathcal{A}_{\theta,T,\boldsymbol{x},\boldsymbol{y}}(p)| \le C_5 \sum_{\boldsymbol{k},\boldsymbol{\ell}}^* \frac{1}{\boldsymbol{k}!\boldsymbol{\ell}!} \prod_{j \le J} \left(\frac{|z_j|}{p^{\sigma_T}}\right)^{k_j + \ell_j} = C_5 \left(\exp\left(\frac{\sum_{j=1}^J |z_j|}{p^{\sigma_T}}\right) - 1\right)^2.$$
(3.4)

Let $Y = e^{(\log T)^{\theta/2}}$, then there exists a constant $C_6 > 0$ such that

$$|\mathcal{A}_{\theta,T,\boldsymbol{x},\boldsymbol{y}}(p)| \le C_6 \frac{\sum_{j=1}^J |z_j|^2}{p^{2\sigma_T}} \le C_6$$

for $\sum_{j \leq J} |z_j|^2 \leq Y$ and $p \geq Y$. Thus, by (3.1)

$$|\hat{\Psi}_{\theta,T}(\boldsymbol{x},\boldsymbol{y})| \leq \left| \prod_{p \geq Y} (1 + \mathcal{A}_{\theta,T,\boldsymbol{x},\boldsymbol{y}}(p)) \right|$$

$$= \left| \prod_{p \geq Y} \exp \left(\mathcal{A}_{\theta,T,\boldsymbol{x},\boldsymbol{y}}(p) + O\left(\frac{\left(\sum_{j=1}^{J} |z_{j}|^{2}\right)^{2}}{p^{4\sigma_{T}}} \right) \right) \right|$$

$$= \left| \exp \left(\sum_{p \geq Y} \mathcal{A}_{\theta,T,\boldsymbol{x},\boldsymbol{y}}(p) + O\left(\sum_{j=1}^{J} |z_{j}|^{2}\right) \right) \right|.$$

The p-sum is

$$\sum_{p \geq Y} \mathcal{A}_{\theta,T,x,y}(p) = \sum_{p \geq Y} \sum_{k,\ell}^{*} \frac{i^{\mathcal{K}(k+\ell)}}{k!\ell!} A_{k,\ell}(p,\sigma_{T}) \bar{z}^{k} z^{\ell}$$

$$= -\sum_{p \geq Y} \sum_{j_{1},j_{2} \leq J} \mathbb{E} \left[g_{j_{1}}(p,\sigma_{T}:X) g_{j_{2}}(p,\sigma_{T}:\bar{X}) \right] \bar{z}_{j_{1}} z_{j_{2}} + O\left(\sum_{j=1}^{J} |z_{j}|^{2}\right)$$

$$= -\sum_{j_{1},j_{2} \leq J} \sum_{p \geq Y} \frac{a_{j_{1}}(p) a_{j_{2}}(p)}{p^{2\sigma_{T}}} \bar{z}_{j_{1}} z_{j_{2}} + O\left(\sum_{j=1}^{J} |z_{j}|^{2}\right)$$

$$= -\sum_{j \leq J} |z_{j}|^{2} \left(\sum_{p \geq Y} \frac{a_{j}(p)^{2}}{p^{2\sigma_{T}}} + O(1)\right)$$

$$\leq -\left(\frac{\pi^{2}\theta}{2} \log \log T + O(1)\right) \sum_{j \leq J} (x_{j}^{2} + y_{j}^{2}).$$

Therefore,

$$|\hat{\Psi}_{\theta,T}(\boldsymbol{x},\boldsymbol{y})| \le \exp\left(-\left(\frac{\pi^2\theta}{2}\log\log T + O(1)\right)\sum_{j\le J}(x_j^2 + y_j^2)\right)$$

holds for $\sum_{j \leq J} (x_j^2 + y_j^2) \leq e^{(\log T)^{\theta/2}}$, which proves the second inequality in Proposition 2.1.

Next, we find an asymptotic of $\hat{\Psi}_{\theta,T}(\boldsymbol{x},\boldsymbol{y})$ for $\sum_{j\leq J}(x_j^2+y_j^2)\leq C_7$. By (3.4) and choosing $C_7>0$ sufficiently small, we have that $|\mathcal{A}_{\theta,T,\boldsymbol{x},\boldsymbol{y}}(p)|\leq 1/2$ for every prime p. Thus,

$$\hat{\Psi}_{\theta,T}(\boldsymbol{x},\boldsymbol{y}) = \prod_{p} (1 + \mathcal{A}_{\theta,T,\boldsymbol{x},\boldsymbol{y}}(p))$$

$$= \prod_{p} \exp\left(\mathcal{A}_{\theta,T,\boldsymbol{x},\boldsymbol{y}}(p) - \frac{1}{2}(\mathcal{A}_{\theta,T,\boldsymbol{x},\boldsymbol{y}}(p))^{2} + O\left(\frac{\sum_{j=1}^{J} (x_{j}^{2} + y_{j}^{2})^{3}}{p^{6\sigma_{T}}}\right)\right)$$

$$= \exp\left(\sum_{p} \mathcal{A}_{\theta,T,\boldsymbol{x},\boldsymbol{y}}(p) - \frac{1}{2}\sum_{p} (\mathcal{A}_{\theta,T,\boldsymbol{x},\boldsymbol{y}}(p))^{2} + O\left(\sum_{j=1}^{J} (x_{j}^{2} + y_{j}^{2})^{3}\right)\right).$$

The sum

$$\sum_{p} \mathcal{A}_{\theta,T,\boldsymbol{x},\boldsymbol{y}}(p) - \frac{1}{2} \sum_{p} (\mathcal{A}_{\theta,T,\boldsymbol{x},\boldsymbol{y}}(p))^{2}$$

has a power series representation in $z_1, \bar{z}_1, \dots, z_J, \bar{z}_J$, so let it be

$$\sum_{k,\ell}^* B_{k,\ell}(\sigma_T) \bar{z}^k z^\ell.$$

For $\mathcal{K}(\mathbf{k} + \mathbf{\ell}) \geq 3$, we have

$$B_{\mathbf{k},\boldsymbol{\ell}}(\sigma_T) = B_{\mathbf{k},\boldsymbol{\ell}}(1/2) + O\left(\frac{1}{(\log T)^{\theta}}\right).$$

For $\mathcal{K}(\mathbf{k}) = \mathcal{K}(\mathbf{\ell}) = 1$, we have

$$\sum_{\mathcal{K}(\mathbf{k})=\mathcal{K}(\boldsymbol{\ell})=1} B_{\mathbf{k},\boldsymbol{\ell}}(\sigma_T) = \sum_{p} \sum_{\mathcal{K}(\mathbf{k})=\mathcal{K}(\boldsymbol{\ell})=1} \frac{i^{\mathcal{K}(\mathbf{k}+\boldsymbol{\ell})}}{\mathbf{k}!\boldsymbol{\ell}!} A_{\mathbf{k},\boldsymbol{\ell}}(p,\sigma_T) \bar{\boldsymbol{z}}^{\mathbf{k}} \boldsymbol{z}^{\boldsymbol{\ell}}$$

$$= -\sum_{p} \sum_{j_1,j_2 \leq J} \mathbb{E} \left[g_{j_1}(p,\sigma_T : X) g_{j_2}(p,\sigma_T : \bar{X}) \right] \bar{z}_{j_1} z_{j_2}.$$

By (1.4), we find that

$$\mathbb{E}\left[g_{j_1}(p, \sigma_T : X)g_{j_2}(p, \sigma_T : \bar{X})\right] = C_{j_1, j_2} + O\left(\frac{1}{(\log T)^{\theta}}\right)$$

for $j_1 \neq j_2$ and

$$\mathbb{E}\left[g_j(p, \sigma_T : X)g_j(p, \sigma_T : \bar{X})\right] = \sum_p \frac{a_j(p)^2}{p^{2\sigma_T}} + C'_j + O\left(\frac{1}{(\log T)^{\theta}}\right)$$
$$= \xi_j \theta \log \log T + C_{j,j} + O\left(\frac{1}{(\log T)^{\theta}}\right)$$

for some constants C_{j_1,j_2} , $C_{j,j}$, C'_j independent to θ . Thus,

$$\sum_{\mathcal{K}(\mathbf{k}) = \mathcal{K}(\mathbf{\ell}) = 1} B_{\mathbf{k}, \mathbf{\ell}}(\sigma_T) = -\theta \log \log T \sum_{j \le J} \xi_j |z_j|^2 + \sum_{j_1, j_2 \le J} C_{j_1, j_2} \bar{z}_{j_1} z_{j_2} + O\left(\frac{1}{(\log T)^{\theta}}\right).$$

Therefore, we have

$$\hat{\Psi}_{\theta,T}(\boldsymbol{x},\boldsymbol{y}) = e^{-\theta \log \log T \sum_{j \le J} \xi_j |z_j|^2} \exp\left(\sum_{j_1,j_2 \le J} C_{j_1,j_2} \bar{z}_{j_1} z_{j_2} + \sum_{\mathcal{K}(\boldsymbol{k}+\boldsymbol{\ell})=3,4,5} B_{\boldsymbol{k},\boldsymbol{\ell}}(1/2) \bar{\boldsymbol{z}}^{\boldsymbol{k}} \boldsymbol{z}^{\boldsymbol{\ell}}\right)$$

$$\times \exp\left(O\left(\sum_{j=1}^{J} (x_j^2 + y_j^2)^3 + \frac{1}{(\log T)^{\theta}}\right)\right)$$

$$= e^{-\pi^2 \theta \log \log T \sum_{j \le J} \xi_j (x_j^2 + y_j^2)} \left(P(\boldsymbol{x},\boldsymbol{y}) + O\left(\sum_{j=1}^{J} (x_j^2 + y_j^2)^3 + \frac{1}{(\log T)^{\theta}}\right)\right)$$

for $\sum_{j\leq J}(x_j^2+y_j^2)\leq C_7$, where $P(\boldsymbol{x},\boldsymbol{y})$ is a polynomial of degree ≤ 5 and may be written as

$$1 + \sum_{\mathcal{K}(\boldsymbol{k}+\boldsymbol{\ell})=2,3,4,5} \tilde{B}_{\boldsymbol{k},\boldsymbol{\ell}} \boldsymbol{x}^{\boldsymbol{k}} \boldsymbol{y}^{\boldsymbol{\ell}}.$$

This completes the proof of Proposition 2.1.

3.2. **Proof of Proposition 2.2.** By Proposition 2.1, we have

$$G_{\theta,T}(\boldsymbol{u},\boldsymbol{v}) = \int_{\mathbb{R}^{2J}} \hat{\Psi}_{\theta,T}(\boldsymbol{x},\boldsymbol{y}) e^{-2\pi i (\boldsymbol{x}\cdot\boldsymbol{u}+\boldsymbol{y}\cdot\boldsymbol{v})} d\boldsymbol{x} d\boldsymbol{y}$$

$$= \int_{\sum_{j} (x_{j}^{2}+y_{j}^{2}) \leq C_{7}} e^{-\pi^{2}\theta \log \log T \sum_{j \leq J} \xi_{j} (x_{j}^{2}+y_{j}^{2}) - 2\pi i (\boldsymbol{x}\cdot\boldsymbol{u}+\boldsymbol{y}\cdot\boldsymbol{v})} P(\boldsymbol{x},\boldsymbol{y}) d\boldsymbol{x} d\boldsymbol{y}$$

$$+ O\left(\frac{1}{(\log \log T)^{J+3}}\right)$$

$$= \int_{\mathbb{R}^{2J}} e^{-\pi^{2}\theta \log \log T \sum_{j \leq J} \xi_{j} (x_{j}^{2}+y_{j}^{2}) - 2\pi i (\boldsymbol{x}\cdot\boldsymbol{u}+\boldsymbol{y}\cdot\boldsymbol{v})} P(\boldsymbol{x},\boldsymbol{y}) d\boldsymbol{x} d\boldsymbol{y}$$

$$+ O\left(\frac{1}{(\log \log T)^{J+3}}\right),$$

where P(x, y) is the polynomial defined in Proposition 2.1. By the change of variables

$$x_j = \frac{\tilde{x}_j}{\pi \sqrt{\theta \xi_j \log \log T}} - \frac{i u_j}{\pi \theta \xi_j \log \log T}$$

and

$$y_j = \frac{\tilde{y}_j}{\pi \sqrt{\theta \xi_j \log \log T}} - \frac{i v_j}{\pi \theta \xi_j \log \log T},$$

one finds that

$$P(\boldsymbol{x},\boldsymbol{y}) = \sum_{\boldsymbol{k},\boldsymbol{\ell},\boldsymbol{m},\boldsymbol{n} \in (\mathbb{Z}_{\geq 0})^J} \frac{p_{\boldsymbol{k},\boldsymbol{\ell}:\boldsymbol{m},\boldsymbol{n}}}{(\theta \log \log T)^{\mathcal{K}(\boldsymbol{k}+\boldsymbol{\ell})/2 + \mathcal{K}(\boldsymbol{m}+\boldsymbol{n})}} \tilde{\boldsymbol{x}}^{\boldsymbol{k}} \tilde{\boldsymbol{y}}^{\boldsymbol{\ell}} \boldsymbol{u}^{\boldsymbol{m}} \boldsymbol{v}^{\boldsymbol{n}},$$

where

$$p_{\boldsymbol{k},\boldsymbol{\ell}:\boldsymbol{m},\boldsymbol{n}} = \frac{\tilde{B}_{\boldsymbol{k}+\boldsymbol{m},\boldsymbol{\ell}+\boldsymbol{n}}}{\pi^{\mathcal{K}(\boldsymbol{k}+\boldsymbol{\ell}+\boldsymbol{m}+\boldsymbol{n})}i^{\mathcal{K}(\boldsymbol{m}+\boldsymbol{n})}} \frac{(\boldsymbol{k}+\boldsymbol{m})!(\boldsymbol{\ell}+\boldsymbol{n})!}{\boldsymbol{k}!\boldsymbol{m}!\boldsymbol{\ell}!\boldsymbol{n}!} \prod_{i} \xi^{-(k_{j}+\ell_{j})/2-m_{j}-n_{j}}.$$

Then we see that

$$G_{\theta,T}(\boldsymbol{u},\boldsymbol{v}) = \exp\bigg(-\sum_{j} \frac{u_j^2 + v_j^2}{\theta \xi_j \log \log T}\bigg) \frac{1}{\prod_{j} (\pi^2 \theta \xi_j \log \log T)}$$

$$\int_{\mathbb{R}^{2J}} e^{-\sum_{j} (\tilde{x}_{j}^{2} + \tilde{y}_{j}^{2})} \sum_{\mathbf{k}, \ell, \mathbf{m}, \mathbf{n} \in (\mathbb{Z}_{\geq 0})^{J}} \frac{p_{\mathbf{k}, \ell: \mathbf{m}, \mathbf{n}}}{(\theta \log \log T)^{\mathcal{K}(\mathbf{k} + \ell)/2 + \mathcal{K}(\mathbf{m} + \mathbf{n})}} \tilde{\mathbf{x}}^{\mathbf{k}} \tilde{\mathbf{y}}^{\ell} \mathbf{u}^{\mathbf{m}} \mathbf{v}^{\mathbf{n}} d\tilde{\mathbf{x}} d\tilde{\mathbf{y}}$$

$$+ O\left(\frac{1}{(\log \log T)^{J+3}}\right)$$

$$= \exp\left(-\sum_{j} \frac{u_{j}^{2} + v_{j}^{2}}{\theta \xi_{j} \log \log T}\right) \sum_{\mathbf{k}, \ell, \mathbf{m}, \mathbf{n} \in (\mathbb{Z}_{\geq 0})^{J}} \frac{c_{\mathbf{k}, \ell} p_{\mathbf{k}, \ell: \mathbf{m}, \mathbf{n}}}{(\theta \log \log T)^{J+\mathcal{K}(\mathbf{k} + \ell)/2 + \mathcal{K}(\mathbf{m} + \mathbf{n})}} \mathbf{u}^{\mathbf{m}} \mathbf{v}^{\mathbf{n}}$$

$$+ O\left(\frac{1}{(\log \log T)^{J+3}}\right),$$

where

$$c_{\boldsymbol{k},\boldsymbol{\ell}} := \pi^{-2J} \left(\prod_{j} \xi_{j}^{-1} \right) \int_{\mathbb{R}^{2J}} e^{-\sum_{j} (\tilde{x}_{j}^{2} + \tilde{y}_{j}^{2})} \tilde{\boldsymbol{x}}^{\boldsymbol{k}} \tilde{\boldsymbol{y}}^{\boldsymbol{\ell}} d\tilde{\boldsymbol{x}} d\tilde{\boldsymbol{y}}$$
$$= \pi^{-2J} \prod_{j} \left(\xi_{j}^{-1} \int_{\mathbb{R}} e^{-x^{2}} x^{k_{j}} dx \int_{\mathbb{R}} e^{-y^{2}} y^{\ell_{j}} dy \right).$$

Thus, if there is odd k_j or odd ℓ_j , then $c_{k,\ell} = 0$. Otherwise,

$$c_{k,\ell} = \pi^{-2J} \prod_{j} \left(\xi_j^{-1} \Gamma\left(\frac{k_j + 1}{2}\right) \Gamma\left(\frac{\ell_j + 1}{2}\right) \right).$$

Hence, we have

$$G_{\theta,T}(\boldsymbol{u},\boldsymbol{v}) = \exp\left(-\sum_{j} \frac{u_{j}^{2} + v_{j}^{2}}{\theta \xi_{j} \log \log T}\right) \sum_{\boldsymbol{k},\boldsymbol{\ell},\boldsymbol{m},\boldsymbol{n} \in (\mathbb{Z}_{\geq 0})^{J}} \frac{c_{2\boldsymbol{k},2\boldsymbol{\ell}}p_{2\boldsymbol{k},2\boldsymbol{\ell}:\boldsymbol{m},\boldsymbol{n}}}{(\theta \log \log T)^{J+\mathcal{K}(\boldsymbol{k}+\boldsymbol{\ell}+\boldsymbol{m}+\boldsymbol{n})}} \boldsymbol{u}^{\boldsymbol{m}} \boldsymbol{v}^{\boldsymbol{n}} + O\left(\frac{1}{(\log \log T)^{J+3}}\right).$$

Letting $q_{\mathbf{k},\ell:\mathbf{m},\mathbf{n}} = c_{2\mathbf{k},2\ell}p_{2\mathbf{k},2\ell:\mathbf{m},\mathbf{n}}$, we prove the first identity of the proposition. The second one can be deduced by modifying the proof of Theorem 6 in [1].

3.3. **Proof of Lemma 2.3.** Our proof is basically the same as the proof of Lemma 3.3 in [4], but we need the dependency on M. We first see that

$$\begin{split} & \int_{\mathbb{R}^{2J}} \left| \log \left| \sum_{j \leq J} b_{j} e^{u_{j} + iv_{j}} \right| \right|^{2k} e^{-\sum_{j} (u_{j}^{2} + v_{j}^{2})/M} d\boldsymbol{u} d\boldsymbol{v} \\ & = \int_{\mathbb{R}^{J}} \int_{[0,2\pi]^{J}} \sum_{\boldsymbol{k} \in \mathbb{Z}^{J}} \left| \log \left| \sum_{j \leq J} b_{j} e^{u_{j} + i(v_{j} + 2\pi k_{j})} \right| \right|^{2k} e^{-\sum_{j} (u_{j}^{2} + (v_{j} + 2\pi k_{j})^{2})/M} d\boldsymbol{v} d\boldsymbol{u} \\ & = \int_{\mathbb{R}^{J}} \int_{[0,2\pi]^{J}} \left| \log \left| \sum_{j \leq J} b_{j} e^{u_{j} + iv_{j}} \right| \right|^{2k} \sum_{\boldsymbol{k} \in \mathbb{Z}^{J}} e^{-\sum_{j} (v_{j} + 2\pi k_{j})^{2}/M} d\boldsymbol{v} e^{-\sum_{j} u_{j}^{2}/M} d\boldsymbol{u} \\ & \ll M^{J/2} \int_{\mathbb{R}^{J}} \int_{[0,2\pi]^{J}} \left| \log \left| \sum_{j \leq J} b_{j} e^{u_{j} + iv_{j}} \right| \right|^{2k} d\boldsymbol{v} e^{-\sum_{j} u_{j}^{2}/M} d\boldsymbol{u}. \end{split}$$

Next we need the inequality

$$\int_0^{2\pi} \left(\log|a - be^{iv}| \right)^{2k} dv \ll (C_1 \log|a|)^{2k} + (C_1 \log|b|)^{2k} + (C_1 k)^{2k}$$

for some constant $C_1 > 0$. (See Lemma 2.1 in [4] for a proof.) Hence, we see that

$$\int_{\mathbb{R}^{J}} \int_{[0,2\pi]^{J}} \left| \log \left| \sum_{j \leq J} b_{j} e^{u_{j} + iv_{j}} \right| \right|^{2k} d\boldsymbol{v} e^{-\sum_{j} u_{j}^{2}/M} d\boldsymbol{u} \\
\ll \int_{\mathbb{R}^{J}} \left(\sum_{j \leq J} \left(C_{2} \log |b_{j} e^{u_{j}}| \right)^{2k} + (C_{2}k)^{2k} \right) e^{-\sum_{j} u_{j}^{2}/M} d\boldsymbol{u} \\
\ll \sum_{j \leq J} \int_{\mathbb{R}^{J}} \left((C_{3}u_{j})^{2k} + C_{3}^{2k} \right) e^{-\sum_{j} u_{j}^{2}/M} d\boldsymbol{u} + M^{J/2} (C_{2}k)^{2k} \\
\ll M^{J/2} \sum_{j \leq J} \int_{\mathbb{R}^{J}} \left((C_{3}u_{j})^{2k} M^{k} + C_{3}^{2k} \right) e^{-\sum_{j} u_{j}^{2}} d\boldsymbol{u} + M^{J/2} (C_{2}k)^{2k} \\
\ll M^{J/2} (C_{4}kM)^{k} + M^{J/2} (C_{2}k)^{2k}.$$

Thus,

$$\int_{\mathbb{R}^{2J}} \left| \log \left| \sum_{j \le J} b_j e^{u_j + iv_j} \right| \right|^{2k} e^{-\sum_j (u_j^2 + v_j^2)/M} d\boldsymbol{u} d\boldsymbol{v} \ll M^{J+k} (Ck)^k + M^J (Ck)^{2k}.$$

3.4. Proof of Proposition 2.4. By symmetry, it is enough to estimate

$$\mathcal{E}_{\boldsymbol{m},\boldsymbol{n},1}(\theta,T) := \int_{\mathbb{R}^J} \int_{\mathcal{R}_1} \log \left| 1 + \sum_{j=2}^J \frac{b_j}{b_1} e^{(u_j - u_1 + i(v_j - v_1))\sqrt{\theta \log \log T}} \right| e^{-\sum_j (u_j^2 + v_j^2)/\xi_j} \boldsymbol{u}^{\boldsymbol{m}} \boldsymbol{v}^{\boldsymbol{n}} d\boldsymbol{u} d\boldsymbol{v}.$$

Let $A_T = (\log \log \log T)/4$. We divide \mathcal{R}_1 into a disjoint union of the sets:

$$\mathcal{R}_{1,S} := \{ (u_1, \dots, u_J) \in \mathcal{R}_1 : -\frac{A_T}{\sqrt{\theta \log \log T}} < u_\ell - u_1 \le 0 \text{ for } \ell \in S,$$
$$u_j - u_1 \le -\frac{A_T}{\sqrt{\theta \log \log T}} \text{ for } j \in \{2, \dots, J\} \setminus S \}$$

for $S \subset \{2, \dots, J\}$. Let

$$\mathcal{E}_S := \mathcal{E}_{m,n,1,S}(\theta,T)$$

$$:= \int_{\mathbb{R}^J} \int_{\mathcal{R}_{1,S}} \log \left| 1 + \sum_{j=2}^J \frac{b_j}{b_1} e^{(u_j - u_1 + i(v_j - v_1))\sqrt{\theta \log \log T}} \right| e^{-\sum_j (u_j^2 + v_j^2)/\xi_j} \boldsymbol{u^m} \boldsymbol{v^n} d\boldsymbol{u} d\boldsymbol{v},$$

so that

$$\mathcal{E}_{m,n,1}(\theta,T) = \sum_{S \subset \{2,\dots,J\}} \mathcal{E}_S.$$

First consider \mathcal{E}_{\emptyset} . In this case it is easy to see that

$$\mathcal{E}_{\emptyset} = \int_{\mathbb{R}^J} \int_{\mathcal{R}_{1,\emptyset}} O(e^{-A_T}) e^{-\sum_j (u_j^2 + v_j^2)/\xi_j} \boldsymbol{u^m} \boldsymbol{v^n} d\boldsymbol{u} d\boldsymbol{v} = O(e^{-A_T}).$$

Next consider $S \neq \emptyset$, then there is at least one element $\ell \in S$. We first observe the u_{ℓ} integral:

$$\int_{u_{1}-\frac{A_{T}}{\sqrt{\theta \log \log T}}}^{u_{1}} \log \left| 1 + \sum_{j=2}^{J} \frac{b_{j}}{b_{1}} e^{(u_{j}-u_{1}+iv_{j}-iv_{1})\sqrt{\theta \log \log T}} \right| e^{-u_{\ell}^{2}/\xi_{\ell}} u_{\ell}^{m_{\ell}} du_{\ell}$$

$$\ll \int_{-\frac{A_{T}}{\sqrt{\theta \log \log T}}}^{0} \left| \log \left| \frac{b_{\ell}}{b_{1}} e^{(u_{\ell}+iv_{\ell}-iv_{1})\sqrt{\theta \log \log T}} + \sum_{j\neq \ell} \frac{b_{j}}{b_{1}} e^{(u_{j}-u_{1}+iv_{j}-iv_{1})\sqrt{\theta \log \log T}} \right| \right| du_{\ell}$$

$$\ll \frac{1}{\sqrt{\log \log T}} \int_{e^{-A_{T}}}^{1} \left| \log \left| \frac{b_{\ell}}{b_{1}} w e^{i(v_{\ell}-v_{1})\sqrt{\theta \log \log T}} + \sum_{j\neq \ell} \frac{b_{j}}{b_{1}} e^{(u_{j}-u_{1}+iv_{j}-iv_{1})\sqrt{\theta \log \log T}} \right| \left| \frac{dw}{w} \right| \right| dw$$

$$\ll \frac{A_{T}}{\sqrt{\log \log T}} + \frac{1}{\sqrt{\log \log T}} \int_{e^{-A_{T}}}^{1} \left| \log \left| w + \sum_{j\neq \ell} \frac{b_{j}}{b_{\ell}} e^{(u_{j}-u_{1}+iv_{j}-iv_{\ell})\sqrt{\theta \log \log T}} \right| \frac{dw}{w}$$

$$\ll \frac{e^{A_{T}}}{\sqrt{\log \log T}}$$

$$\ll \frac{e^{A_{T}}}{\sqrt{\log \log T}}$$

by the substitution $w = e^{u_\ell \sqrt{\theta \log \log T}}$. Here, the last inequality holds by the following lemma.

Lemma 3.1. Let B be a fixed positive real number and let $\epsilon_T > 0$ be a decreasing function to 0 as $T \to \infty$. Then we have

$$\int_{\epsilon_T}^1 |\log|u + z| |\frac{du}{u} = O\left(\frac{1}{\epsilon_T}\right)$$

as $T \to \infty$ uniformly for all $|z| \leq B$.

Proof. We first observe that it is enough to prove that

$$\int_0^1 |\log |u + z| |du = O(1)$$

uniformly for bounded $z = \alpha + i\beta$. By the inequality

$$-|\log |u + \alpha|| \le \log |u + \alpha| \le \log |u + z| = \log \sqrt{(u + \alpha)^2 + \beta^2} \le \log \sqrt{2 \max\{(u + \alpha)^2, \beta^2\}}$$
$$= \log \sqrt{2} + \max\{\log |u + \alpha|, \log |\beta|\} \le \log \sqrt{2} + |\log |u + \alpha|| + \log B,$$

we see that

$$\int_0^1 |\log |u + z| |du \le \int_0^1 |\log |u + \alpha| |du + O(1).$$

If $|\alpha| \geq 2$, then it is easy to see that

$$\int_0^1 |\log |u + \alpha| |du = \int_0^1 |\log |\alpha| + O(1) |du = O(1).$$

If $|\alpha| < 2$, then we split the interval into two intervals depending on the condition $\log |u+\alpha| \ge 0$. Thus,

$$\int_0^1 |\log |u + \alpha| |du = \int_{|u + \alpha| \ge 1} \log |u + \alpha| du + \int_{|u + \alpha| < 1} -\log |u + \alpha| du.$$

It is easy to see that

$$0 \le \int_{[0,1] \cap \{|u+\alpha| \ge 1\}} \log|u+\alpha| du \le \log(1+B)$$

and

$$0 \leq \int_{[0,1] \cap \{|u+\alpha| < 1\}} -\log |u+\alpha| du \leq 2 \int_0^1 -\log u du \leq 2.$$

Hence, we find that

$$\mathcal{E}_S = O\left(\frac{e^{A_T}}{\sqrt{\log\log T}}\right)$$

for $S \neq \emptyset$ and

$$\mathcal{E}_{m,n,1}(\theta,T) = O(e^{-A_T}) + O\left(\frac{e^{A_T}}{\sqrt{\log\log T}}\right) = O\left(\frac{1}{(\log\log T)^{1/4}}\right).$$

3.5. **Proof of Lemma 2.5.** We see that for a fixed real β and for each i=1,2

$$\theta_1^{\beta} - \theta_2^{\beta} = H_T (\beta \theta_i^{\beta - 1} + O(H_T)).$$

Thus, by (2.5)

$$\theta_{1}^{\alpha}I_{\boldsymbol{m},\boldsymbol{n}}(\theta_{1},T) - \theta_{2}^{\alpha}I_{\boldsymbol{m},\boldsymbol{n}}(\theta_{2},T)$$

$$= H_{T}\sqrt{\log\log T}d_{\boldsymbol{n}}\left(\alpha + \frac{1}{2}\right)\theta_{i}^{\alpha-1/2}\sum_{\ell=1}^{J}\int_{\mathcal{R}_{\ell}}u_{\ell}e^{-\sum_{j}u_{j}^{2}/\xi_{j}}\boldsymbol{u}^{\boldsymbol{m}}d\boldsymbol{u}$$

$$+ H_{T}d_{\boldsymbol{n}}\alpha\theta_{i}^{\alpha-1}\sum_{\ell=1}^{J}\int_{\mathcal{R}_{\ell}}\log|b_{\ell}|e^{-\sum_{j}u_{j}^{2}/\xi_{j}}\boldsymbol{u}^{\boldsymbol{m}}d\boldsymbol{u}$$

$$+ \theta_{1}^{\alpha}\mathcal{E}_{\boldsymbol{m},\boldsymbol{n}}(\theta_{1},T) - \theta_{2}^{\alpha}\mathcal{E}_{\boldsymbol{m},\boldsymbol{n}}(\theta_{2},T) + O(H_{T}^{2}\sqrt{\log\log T})$$

for each i=1,2. Recall that $\mathcal{E}_{m,n}(\theta,T):=\sum_{\ell=1}^J \mathcal{E}_{m,n,\ell}(\theta,T)$. Hence, without loss of generality, we consider

$$\begin{aligned} &\theta_1^{\alpha} \mathcal{E}_{\boldsymbol{m},\boldsymbol{n},1}(\theta_1,T) - \theta_2^{\alpha} \mathcal{E}_{\boldsymbol{m},\boldsymbol{n},1}(\theta_2,T) \\ &= \int_{\mathbb{R}^J} \int_{\mathcal{R}_1} \log \left| 1 + \sum_{j=2}^J \frac{b_j}{b_1} e^{(u_j - u_1 + i(v_j - v_1))\sqrt{\log\log T}} \right| \\ &\times \left(\theta_1^{\alpha'} e^{-\sum_j (u_j^2 + v_j^2)/(\theta_1 \xi_j)} - \theta_2^{\alpha'} e^{-\sum_j (u_j^2 + v_j^2)/(\theta_2 \xi_j)} \right) \boldsymbol{u}^{\boldsymbol{m}} \boldsymbol{v}^{\boldsymbol{n}} d\boldsymbol{u} d\boldsymbol{v}, \end{aligned}$$

where

$$\alpha' = \alpha - J - \frac{\mathcal{K}(m+n)}{2}.$$

We see that

$$\begin{split} \theta_{1}^{\alpha'} e^{-\sum_{j}(u_{j}^{2}+v_{j}^{2})/(\theta_{1}\xi_{j})} &- \theta_{2}^{\alpha'} e^{-\sum_{j}(u_{j}^{2}+v_{j}^{2})/(\theta_{2}\xi_{j})} \\ &= \int_{\theta_{2}}^{\theta_{1}} \frac{\partial}{\partial w} \bigg(w^{\alpha'} e^{-\sum_{j}(u_{j}^{2}+v_{j}^{2})/(w\xi_{j})} \bigg) dw \end{split}$$

$$= \int_{\theta_2}^{\theta_1} \left(\sum_{j \le J} \frac{u_j^2 + v_j^2}{w^2 \xi_j} + \frac{\alpha'}{w} \right) w^{\alpha'} e^{-\sum_j (u_j^2 + v_j^2)/(w \xi_j)} dw$$

$$\ll H_T \left(\sum_{j \le J} (u_j^2 + v_j^2) + 1 \right) e^{-\sum_j (u_j^2 + v_j^2)/(\theta_2 \xi_j)}.$$

Thus, by adapting the proof of Proposition 2.4 we find that

$$\theta_{1}^{\alpha} \mathcal{E}_{\boldsymbol{m},\boldsymbol{n},1}(\theta_{1},T) - \theta_{2}^{\alpha} \mathcal{E}_{\boldsymbol{m},\boldsymbol{n},1}(\theta_{2},T)$$

$$\ll H_{T} \int_{\mathbb{R}^{J}} \int_{\mathcal{R}_{1}} \left| \log \left| 1 + \sum_{j=2}^{J} \frac{b_{j}}{b_{1}} e^{(u_{j} - u_{1} + i(v_{j} - v_{1}))\sqrt{\log \log T}} \right| \left| e^{-\sum_{j} (u_{j}^{2} + v_{j}^{2})/(\theta_{2}\xi_{j})} \right|$$

$$\left(\sum_{j \leq J} (u_{j}^{2} + v_{j}^{2}) + 1 \right) \left| \boldsymbol{u}^{\boldsymbol{m}} \boldsymbol{v}^{\boldsymbol{n}} \right| d\boldsymbol{u} d\boldsymbol{v}$$

$$\ll \frac{H_{T}}{(\log \log T)^{1/4}}$$

and this completes the proof of the lemma.
