# ON CONSTRUCTION OF A NEW INTERPOLATION TOOL: CUBIC $q$-SPLINE

#### Abstract

This work presents a new interpolation tool, namely, cubic $q$ spline. Our new analogue generalizes a well known classical cubic spline. This analogue, based on the Jackson $q$-derivative, replaces an interpolating piecewise cubic polynomial function by $q$-polynomials of degree three at most. The parameter $q$ provides a solution flexibility.


## 1. INTRODUCTION

The interpolation problem of an unknown function $f(x)$ when only the values of $f\left(x_{i}\right)$ at some point $x_{i}$ are given arises in different areas. One of widely used methods is a spline interpolation, and, particularly, cubic spline interpolation. That means that the function $f(x)$ is interpolated between two adjacent points $x_{i}$ and $x_{i+1}$ by a polynomial of degree three at most. Such interpolation is very suitable for smooth functions which do not have oscillating behaviour (cf. [1]). Another advantage of the cubic polynomial interpolation is that it leads to a system of linear equations which is described by a tridiagonal matrix. This linear system has a unique solution which can be fast obtained. A generalization of cubic spline interpolation was done by Marsden (see [2]). He chose a $q$-representation for knots and normalized $B$-splines as interpolating functions. $B$-splines are the generalization of the Bezier curves which are built with the help of Bernstein polynomials and they play an important role in the theory of polynomial interpolation. Their $q$-analogues were defined and studied in [3, 4]. For further information and other details related to q -analogues of Bernstein polynomials, Bezier curves and splines, see the recent works [5, 6, 7, 8, 9, 10]. Another $q$-generalization of polynomial interpolation was studied in 11]. Despite the popularity of $B$-spline, new generalizations of spline continue to appear. Some of them concerns about preserving of convexity [12], some of them about smoothness of interpolation 13], and others about degrees of freedom [14]. Classical cubic spline already proved itself in data and curve fitting problems. Our new $q$-generalization gives it a new interesting twist. The matrix describing the linear system is tridiagonal like in the classic case, and a solution of this linear system can be obtained by simple recursive algorithm (see for example [15]). The $q$-parameter provides a flexibility of the solution.

We start from a short review of definitions coming from the quantum calculus (cf. [16]). The $q$-derivative is given by

D_{q} f(x)=\frac{f(q x)-f(x)}{q x-x}
$$

For any complex number $c$, its $q$-analogue is defined as $[c]_{q}=\frac{q^{c}-1}{q-1}$. For natural $n$, a $q$-factorial is defined as $[n]_{q}!=\prod_{k=1}^{n}[k]_{q}$, with $[0]_{q}!=1$.

The $q$-analogue of the polynomial is $(x-c)_{q}^{n}=\prod_{k=1}^{n}\left(x-c q^{k-1}\right)$ by assuming as usually that $(x-c)_{q}^{0}=1$. It is easy to show that $D_{q}(x-c)_{q}^{n}=[n]_{q}(x-c)_{q}^{n-1}$. We will denote by $D_{q}^{k}$ the $k$-th $q$-derivative. The Jackson $q$-integral of $f(x)$ is defined as (cf. 16, 17])

$$
\int f(x) d_{q} x=(1-q) x \sum_{j=0}^{\infty} q^{j} f\left(q^{j} x\right)
$$

and $D_{q} \int f(x) d_{q} x=f(x)$. Note that $q$ is usually considered to be $0<q<1$.
In the next section we describe a process of building of a cubic $q$-spline.

## 2. BUILDING OF A $q$-ANALOGUE OF CUBIC SPLINE

Let a function $f(x)$ is given by its values $f\left(x_{i}\right)=f_{i}, 0 \leq i \leq n$, at $n+1$ nodes $a=x_{0}<x_{1}<\ldots<x_{n}=b$. We define the cubic $q$-spline function $S(x ; q)$ as a function of a variable $x$ with parameter $q$ as following:

$$
S(x ; q)=\left\{\begin{align*}
S_{1}(x ; q) & x_{0} \leq x \leq x_{1}  \tag{1}\\
S_{2}(x ; q) & x_{1}<x \leq x_{2} \\
\ldots & \cdots \\
S_{n}(x ; q) & x_{n-1}<x \leq x_{n}
\end{align*}\right.
$$

where each $S_{i}(x ; q), 1 \leq i \leq n$, is a $q$-polynomial in variable $x$ of degree at most three, and $S(x ; q), D_{q} S(x ; q), D_{q}^{2} S(x ; q)$ are continuous on $[a, b]$. To provide these properties we demand

$$
\begin{gather*}

S_{i}\left(x_{i-1} ; q\right)=f\left(x_{i-1}\right), & i=1, \ldots, n, \\
S_{i}\left(x_{i} ; q\right)=f\left(x_{i}\right), & i=1, \ldots, n,
\end{array}\right.  \tag{2}\\
D_{q} S_{i}\left(x_{i} ; q\right)=D_{q} S_{i+1}\left(x_{i} ; q\right),  \tag{3}\\
D_{q}^{2} S_{i}\left(x_{i} ; q\right)=D_{q}^{2} S_{i+1}\left(x_{i} ; q\right),  \tag{4}\\
i=1, \ldots, n-1,
\end{gather*},
$$

The boundary conditions for the clamped cubic $q$-spline are

$$
\left\{\begin{array}{l}
D_{q} S_{1}\left(x_{0} ; q\right)=D_{q} f\left(x_{0}\right),  \tag{5}\\
D_{q} S_{n}\left(x_{n} ; q\right)=D_{q} f\left(x_{n}\right) .
\end{array}\right.
$$

Let us denote by $\mu_{i}(q), i=0, \ldots, n$ the value of the second $q$-derivative of the spline $S(x ; q)$ at the node $x_{i}$, that is $\mu_{i}(q)=D_{q}^{2} S\left(x_{i} ; q\right)$. Since the spline $S(x ; q)$ is a polynomial of degree at most three, its second derivative is a polynomial of degree at most one. Therefore it can be written as

$$
D_{q}^{2} S_{i}(x ; q)=\mu_{i-1}(q) \frac{x_{i}-x}{h_{i}}+\mu_{i}(q) \frac{x-x_{i-1}}{h_{i}}
$$

where $h_{i}=x_{i}-x_{i-1}$ and $x_{i-1} \leq x \leq x_{i}$ for $1 \leq i \leq n$. By performing $q$-integration we obtain
(6) $D_{q} S_{i}(x ; q)=\int D_{q}^{2} S_{i}(x ; q) d_{q} x=\frac{\mu_{i}(q)}{[2]_{q} h_{i}}\left(x-x_{i-1}\right)_{q}^{2}-\frac{\mu_{i-1}(q)}{[2]_{q} h_{i}}\left(x-x_{i}\right)_{q}^{2}+A_{i}(q)$.

Let us denote by $f\left[x_{i-1}, x_{i}\right]=\frac{f\left(x_{i}\right)-f\left(x_{i-1}\right)}{x_{i}-x_{i-1}}$ the first order divided difference of a function $f(x)$ at nodes $x_{i-1}, x_{i}$. By integrating (6), we obtain
$S_{i}(x ; q)=\int D_{q} S_{i}(x ; q) d_{q} x=\frac{\mu_{i}(q)}{[3]_{q}!h_{i}}\left(x-x_{i-1}\right)_{q}^{3}-\frac{\mu_{i-1}(q)}{[3]_{q}!h_{i}}\left(x-x_{i}\right)_{q}^{3}+A_{i}(q)\left(x-x_{i-1}\right)+B_{i}(q)$,
where $A_{i}(q)$ and $B_{i}(q)$ depend on parameter $q$ only and can be found by substituting $x=x_{i}$ and $x=x_{i-1}$ in (7) respectively and using the conditions (2) as following

$$
\begin{align*}
& \text { (8) } B_{i}(q)=f\left(x_{i-1}\right)+\frac{\mu_{i-1}(q)}{[3]_{q}!h_{i}}\left(x_{i-1}-x_{i}\right)_{q}^{3}  \tag{8}\\
& \text { (9) } A_{i}(q)=\frac{f\left(x_{i}\right)-f\left(x_{i-1}\right)}{h_{i}}-\frac{\mu_{i}(q)}{[3]_{q}!h_{i}^{2}}\left(x_{i}-x_{i-1}\right)_{q}^{3}-\frac{\mu_{i-1}(q)}{[3]_{q}!h_{i}^{2}}\left(x_{i-1}-x_{i}\right)_{q}^{3} .
\end{align*}
$$

By substituting the detailed expressions (8) for functions $A_{i}(q)$ and $B_{i}(q)$, we obtain the $i$ th spline function as following
$S_{i}(x ; q)=\frac{\mu_{i}(q)}{[3]_{q}!h_{i}}\left(x-x_{i-1}\right)_{q}^{3}-\frac{\mu_{i-1}(q)}{[3]_{q}!h_{i}}\left(x-x_{i}\right)_{q}^{3}$

$$
\begin{align*}
& +\left(f\left[x_{i-1}, x_{i}\right]-\frac{\mu_{i}(q)}{[3]_{q}!h_{i}^{2}}\left(x_{i}-x_{i-1}\right)_{q}^{3}-\frac{\mu_{i-1}(q)}{[3]_{q}!h_{i}^{2}}\left(x_{i-1}-x_{i}\right)_{q}^{3}\right)\left(x-x_{i-1}\right)  \tag{10}\\
& +\quad f\left(x_{i-1}\right)+\frac{\mu_{i-1}(q)}{[3]_{q}!h_{i}}\left(x_{i-1}-x_{i}\right)_{q}^{3}
\end{align*}
$$

In order to obtain the unknown moments $\mu_{i}(q), i=0, \ldots, n$ we use the conditions (3) for the first derivative of the $q$-spline (6). Hence, for $i=1, \ldots, n-1$, we have

$$
\begin{aligned}
\frac{\mu_{i}(q)}{[2]_{q} h_{i}}\left(x_{i}-x_{i-1}\right)_{q}^{2} & +f\left[x_{i-1}, x_{i}\right]-\frac{\mu_{i}(q)}{[3]_{q}!h_{i}^{2}}\left(x_{i}-x_{i-1}\right)_{q}^{3}-\frac{\mu_{i-1}(q)}{[3]_{q}!h_{i}^{2}}\left(x_{i-1}-x_{i}\right)_{q}^{3} \\
& =-\frac{\mu_{i}(q)}{[2]_{q} h_{i+1}}\left(x_{i}-x_{i+1}\right)_{q}^{2}+f\left[x_{i}, x_{i+1}\right]-\frac{\mu_{i+1}(q)}{[3]_{q}!h_{i+1}^{2}}\left(x_{i+1}-x_{i}\right)_{q}^{3} \\
& -\frac{\mu_{i}(q)}{[3]_{q}!h_{i+1}^{2}}\left(x_{i}-x_{i+1}\right)_{q}^{3}
\end{aligned}
$$

Moreover, from the boundary conditions (5) for the clamped $q$-spline we obtain

$$
\begin{align*}
D_{q} S_{1}\left(x_{0} ; q\right) & =-\frac{\mu_{0}(q)}{[2]_{q} h_{1}}\left(x_{0}-x_{1}\right)_{q}^{2}+f\left[x_{0}, x_{1}\right] \\
& -\frac{\mu_{1}(q)}{[3]_{q}!h_{1}^{2}}\left(x_{1}-x_{0}\right)_{q}^{3}-\frac{\mu_{0}(q)}{[3]_{q}!h_{1}^{2}}\left(x_{0}-x_{1}\right)_{q}^{3}=D_{q} f\left(x_{0}\right)  \tag{12}\\
D_{q} S_{n}\left(x_{n} ; q\right) & =\frac{\mu_{n}(q)}{[2]_{q} h_{n}}\left(x_{n}-x_{n-1}\right)_{q}^{2}+f\left[x_{n-1}, x_{n}\right] \\
& -\frac{\mu_{n}(q)}{[3]_{q}!h_{n}^{2}}\left(x_{n}-x_{n-1}\right)_{q}^{3}-\frac{\mu_{n-1}(q)}{[3]_{q}!h_{n}^{2}}\left(x_{n-1}-x_{n}\right)_{q}^{3}=D_{q} f\left(x_{n}\right)
\end{align*}
$$

The equations (11) form a system of $(n+1)$ linear equations with respect to the moments $\mu_{i}(q)$ that can be written shortly as $A \mu=b$. With the notation $\mathcal{H}_{i}(q)=\frac{\left(q x_{i}-x_{i-1}\right)\left(x_{i}-q x_{i-1}\right)}{x_{i}-x_{i-1}}$, we have

$$
A=\left(\begin{array}{cccccc}
{[2]_{q} \mathcal{H}_{1}(q)} & \frac{\left(x_{1}-q x_{0}\right)_{q}^{2}}{x_{1}-x_{0}} & 0 & 0 & \ldots & 0  \tag{14}\\
\frac{\left(x_{0}-q x_{1}\right)^{2}}{x_{1}-x_{0}} & {[2]_{q}\left(\mathcal{H}_{1}(q)+\mathcal{H}_{2}(q)\right)} & \frac{\left(x_{2}-q x_{1}\right)_{q}^{2}}{x_{2}-x_{1}} & 0 & \ldots & 0 \\
\ldots & \ldots & \ldots & \ldots & \ldots & \ldots \\
0 & 0 & 0 & 0 & \frac{\left(x_{n-1}-q x_{n}\right)_{q}^{2}}{x_{n}-x_{n-1}} & {[2]_{q} \mathcal{H}_{n}(q)}
\end{array}\right)
$$

$$
b=[3]_{q}!\left(\begin{array}{c}
f\left[x_{0}, x_{1}\right]-D_{q} f\left(x_{0}\right)  \tag{15}\\
f\left[x_{1}, x_{2}\right]-f\left[x_{0}, x_{1}\right] \\
\vdots \\
f\left[x_{n-1}, x_{n}\right]-f\left[x_{n-2}, x_{n-1}\right] \\
D_{q} f\left(x_{n}\right)-f\left[x_{n-1}, x_{n}\right]
\end{array}\right), \quad \mu=\left(\begin{array}{c}
\mu_{0}(q) \\
\vdots \\
\mu_{n}(q)
\end{array}\right)
$$

The unknown moments $\mu=\mu(q)$ (15) are the solution of the matrix equation $A \mu=b$, where $A$ is given by (14) and $b$ is given by (15). In view of the fact that $A$ is a tridiagonal matrix, the method proposed in [15] may be used for evaluating the moments $\mu_{i}(q), i=0 . ., n$.

The moments $\mu_{i}(q), i=0, \ldots, n$ are the solution of the matrix equation $A \mu=b$, therefore they are the unique functions of parameter $q$. Thus we can state the following result.

Theorem 1. Let the piecewise function $S(x ; q)$ be defined by (1) and (10), where $\mu=\mu(q)$ is a unique solution of the matrix equation $A \mu=b$, with $A$ given by (14) and $b$ given by (15). Then $S(x ; q)$ is a $q$-analogue of the cubic spline interpolation of a function $f(x)$.

Example 2. Let us consider a q-spline interpolation of a function $f(x)=x^{4}$ on the interval $x \in[-1,1]$ at the knots $x_{0}=-1, x_{1}=0, x_{2}=1$. We assume that the values of the function itself and its first derivation at the knots are given. The classical cubic spline solution is given in Example 1 on page 824-825 of [18]. By using the above proposed method, one can obtain the cubic $q$-spline solution:

$$
S(x ; q)= \begin{cases}\frac{q^{3}-3 q^{2}-2 q-2}{2 q^{2}+q} x^{3}+\frac{q^{3}-q^{2}-q-2}{2 q^{2}+q} x^{2}, & -1 \leq x \leq 0 \\ -\frac{q^{3}-3 q^{2}-2 q-2}{2 q^{2}+q} x^{3}+\frac{q^{3}-q^{2}-q-2}{2 q^{2}+q} x^{2}, & 0 \leq x \leq 1\end{cases}
$$

It is easy to obtain the classical cubic spline solution corresponding to $q \rightarrow 1$. One can see that there exist a slight oscillation of the spline regarding to the original function. Decreasing the parameter $q$ leads to more intensive oscillation. However, increasing the parameter $q$ overcomes the oscillation effect and interpolates the original function with significant improvement.
