# High-Energy Smoothing Estimates for Selfadjoint Operators

#### Abstract

We prove the limiting absorption principle on the non-compact interval $I$, on which the uniformly positive Mourre estimate holds. We reveal that such a result yields so-called smoothing estimates.


Keywords; Mourre theory; Kato's smoothing; Limiting absorption principle; scattering theory.

## 1 Introduction

In this paper, we show the limiting absorption principle (LAP) for generalized selfadjoint operators $H$ by using Mourre's theory. In the paper by Mourre [9, the energy localized LAP was deduced for $H$. Hence in this paper, we deduce the global in the highenergy LAP and a smoothing-type LAP by modifying Mourre's approach. The key to doing so is the so-called positive commutator $A$ (called the conjugate operator), such that $f(H) i[H, A] f(H) \geq c f(H)^{2}$ with $c>0$ and energy cut-off $f \in C_{0}^{\infty}(\mathbf{R})$. In the background of Mourre theory, a pair of Schrödinger operators $H_{S}=p^{2}$ are considered, along with the generator of dilation group $A_{S}=x \cdot p+p \cdot x$, where $x=\left(x_{1}, \ldots, x_{n}\right) \in \mathbf{R}^{n}$ and $p=-i \nabla_{x}$. Formally, it then holds that $f\left(H_{S}\right) i\left[H_{S}, A_{S}\right] f\left(H_{S}\right)=f\left(H_{S}\right)\left(4 p^{2}-2 \nabla V\right) f\left(H_{S}\right)$ on $L^{2}\left(\mathbf{R}^{n}\right)$. By selecting $f$ such that $\{0\} \cup\left\{\sigma_{\mathrm{pp}}(H)\right\} \notin \operatorname{supp}(f)$, we have $f\left(H_{S}\right) 4 p^{2} f\left(H_{S}\right) \geq 2 c_{0} f\left(H_{S}\right)^{2}$, $c_{0}>0$, and by selecting a very narrow $f, f\left(H_{S}\right)|2 \nabla V| f\left(H_{S}\right) \leq c_{0} f\left(H_{S}\right)^{2}$ holds if $V$ and $f$ satisfy the suitable conditions. Consequently, we can deduce that $f\left(H_{S}\right) i\left[H_{S}, A_{S}\right] f\left(H_{S}\right)$ is positive with a suitable energy cut-off. The condition for the support of $f$ is mainly used to deduce the smallness of $V f\left(H_{S}\right)$ and to deduce the positiveness and boundedness of the commutator $f\left(H_{S}\right) i\left[H_{S}, A_{S}\right] f\left(H_{S}\right)$. On the other hand, the Yokoyama-type conjugate operator $A_{Y}:=x \cdot p\left(1+p^{2}\right)^{-1}+\left(1+p^{2}\right)^{-1} p \cdot x$ (see Yokoyama [13]) gives $i\left[H_{S}, A_{Y}\right]=4 p^{2}\langle p\rangle^{-2}+\langle p\rangle^{-2} \times$ (bounded operators) if $V$ is smooth and satisfies a suitable decaying condition, where $\langle\cdot\rangle=\left(1+{ }^{2}\right)^{1 / 2}$. For the high-energy cut-off $f\left(H_{S}\right)$ (i.e., $p^{2} \gg 1$ holds on $f\left(H_{S}\right)$ ), it holds that $f\left(H_{S}\right) i\left[H_{S}, A_{Y}\right] f\left(H_{S}\right) \geq 3 f\left(H_{S}\right)^{2}$ even if the support of $f$ is not narrow. Moreover $i\left[H_{S}, A_{Y}\right]$ can be extended to a bounded operator without the energy cut-off. Additionally, in many physical situations the Hamiltonian $H$ has a conjugate operator $A$, which gives the positive and bounded commutator for the high-energy cut-off. Judging from these, we expect that we can deduce the limiting absorption principle from Mourres theory with a pair of $H, A$ and $\varphi$ such that $i[H, A]$ is positive and bounded with a high-energy cut-off $\varphi(H)$, with $\varphi \in C^{\infty}((-\infty,-R] \cup[R, \infty))$ (not $C_{0}^{\infty}(\mathbf{R})$ ), where $R$ is a given large constant.

Consider the Hamiltonian $H$, where $H$ is a selfadjoint operator acting on Hilbert space $\mathscr{H}$. The norm on $\mathscr{H}$ and the operator norm on $\mathscr{H}$ are denoted by the same notation, $\|\cdot\|$, and $(\cdot, \cdot)$ denotes the inner product of $\mathscr{H}$. Let $A$ be a selfadjoint operator and suppose $D=\mathscr{D}(H) \cap \mathscr{D}(A) \subset \mathscr{H}$ is dense. We define the form $q_{H, A}(\cdot, \cdot)$ on $D$ as
$q_{H, A}(u, v):=i(A u, H v)-i(H u, A v)$ for $u, v \in D$. Then, we say that $i[H, A]$ can be extended to a bounded operator from $\mathscr{H}$ to $\mathscr{H}$ if there exists a bounded selfadjoint operator $T$ such that the closure of $q_{H, A}(\cdot, \cdot), \tilde{q}_{H, A}(\cdot, \cdot)$, satisfies $\tilde{q}_{H, A}(u, v)=(T u, v)$, $u, v \in \mathscr{H}$, and denote this by $T=i[H, A]^{0}$. We now introduce the first assumption on $H, A$ and energy cut-off $\varphi$ in order to derive the high-energy LAP:

Assumption 1.1. Let $H$ and $A$ be selfadjoint operators satisfying the following statements: (a), (b), (c), (d), (e), and (f) (all conditions stated in Mourre [9] are fulfilled, regarding which see also [2]):
(a). $\overline{\left.H\right|_{\mathscr{O}(H) \cap \mathscr{O}(A)}}=H$.
(b). $e^{i t A} \mathscr{D}(H) \subset \mathscr{D}(H),|t|<1$ and for $u \in \mathscr{D}(H), \sup _{|t|<1}\left\|H e^{i t A} u\right\|<\infty$.
(c). The commutator $i[H, A]^{0}$ can be defined in the form and can be extended to a bounded operator from $\mathscr{H}$ to $\mathscr{H}$.
(d). There exists a constant $c_{2}>0$ such that for all $u, v \in \mathscr{D}(A)$,

\left|\left(A u, i[H, A]^{0} v\right)-\left(i[H, A]^{0} u, A v\right)\right| \leq c_{2}\|u\|\|v\|
$$

(e). Let $R>0$ be a given constant and $\varphi=\varphi_{R} \in C^{\infty}(\mathbf{R})$ with $0 \leq \varphi \leq 1$ is smooth cut-off function so that $\varphi(s)=0$ if $|s| \leq R$ and $\varphi(s)=1$ if $|s| \geq 2 R$. Then there exists $0<c_{0} \leq c_{1}$, such that

$$
c_{0} \varphi(H)^{2} \leq \varphi(H) i[H, A]^{0} \varphi(H) \leq c_{1} \varphi(H)^{2} \leq c_{1}
$$

Moreover, $\varphi^{\prime}(s)>0$ for all $s$ in $R<|s|<2 R$.
(f). $i\left[H, i[H, A]^{0}\right]^{0}$ and $i\left[i[H, A]^{0}, H\right]^{0}$ can be extended to the bounded operators.

Under this assumption, we have the Mourre estimates for the high-energy case, which provide the following nonexistence-of-eigenvalues property and limiting absorption principle for $H$ :

Theorem 1.2. Under Assumption 1.1, $H$ has no eigenvalues on $(-\infty,-3 R] \cup[3 R, \infty)$.
Theorem 1.3. For any fixed $0<\hat{\varepsilon}<1$, we select $\tilde{R}$ arbitrarily in $\left(0, R^{1-\hat{\varepsilon}}\right]$. Under Assumption 1.1, for large $R$, there exists a constant $\delta=\delta_{R}>1$ with $\delta_{R} \rightarrow 1$ (as $\left.R \rightarrow \infty\right)$ such that the limiting absorption principle

$$
\begin{align*}
& \sup _{|\lambda| \geq 3 R, \mu>0}\left\|\langle A\rangle^{-s}(H-\lambda \mp i \mu)^{-1}\langle A\rangle^{-s} \phi\right\| \\
& \quad \leq c_{0}^{-1}\left(\left(\frac{\delta}{\tilde{R}}\right)^{1 / 2}+\delta(\tilde{R})^{s-1 / 2} \frac{(1-s)^{1-s}(2-s)}{(2 s-1)}\right)^{2} e^{\delta c_{2} \tilde{R} / c_{0}}\|\phi\| \tag{1}
\end{align*}
$$

holds for all $1 / 2<s \leq 1$ and $\phi \in \mathscr{H}$, where $\langle\cdot\rangle=\left(1+\cdot^{2}\right)^{1 / 2}$. Moreover, for all $s \geq 1$,

$$
\begin{align*}
& \sup _{|\lambda| \geq 3 R, \mu>0}\left\|\langle A\rangle^{-s}(H-\lambda \mp i \mu)^{-1}\langle A\rangle^{-s} \phi\right\| \\
& \quad \leq c_{0}^{-1}\left(\left(\frac{\delta}{\tilde{R}}\right)^{1 / 2}+2 \delta s^{-s}(s-1)^{s-1}(\tilde{R})^{1 / 2}\right)^{2} e^{\delta c_{2} \tilde{R} / c_{0}}\|\phi\| \tag{2}
\end{align*}
$$

holds. In particular, if we can select $s>0$ such that it is sufficiently large and $c_{2}=c_{2}(R)$ satisfies $c_{2} \tilde{R} \rightarrow 0$ as $R \rightarrow \infty$, then for some $0<\varepsilon_{R, s} \ll 1$,

$$
\sup _{|\lambda| \geq 3 R, \mu>0}\left\|\langle A\rangle^{-s}(H-\lambda \mp i \mu)^{-1}\langle A\rangle^{-s} \phi\right\| \leq \varepsilon_{R, s}\|\phi\|
$$

holds.
Here, we define $\tilde{\varphi} \in C^{\infty}(\mathbf{R})$, which satisfies $\tilde{\varphi}(s)=1$ if $|s| \geq 5 R$ and $=0$, if $|s| \leq 4 R$. Then, it follows that

$$
\begin{aligned}
& \sup _{\lambda \in \mathbf{R}, \mu>0}\left\|\langle A\rangle^{-s} \tilde{\varphi}(H)(H-\lambda \mp i \mu)^{-1} \tilde{\varphi}(H)\langle A\rangle^{-s} \phi\right\| \\
& \leq \sup _{|\lambda| \leq 3 R, \mu\rangle 0}\left\|\tilde{\varphi}(H)(H-\lambda \mp i \mu)^{-1} \tilde{\varphi}(H)\right\|\left\|\langle A\rangle^{-s}\right\|^{2}\|\phi\| \\
& \quad+\sup _{|\lambda| \geq 3 R, \mu>0}\left\|\langle A\rangle^{-s} \tilde{\varphi}(H)\langle A\rangle^{s^{\prime}}\right\|^{2}\left\|\langle A\rangle^{-s^{\prime}}(H-\lambda \mp i \mu)^{-1}\langle A\rangle^{-s^{\prime}}\right\|\|\phi\|,
\end{aligned}
$$

where $1 / 2<s^{\prime} \leq s$ with $s^{\prime} \leq 1$. By noting commutator expansion (see, $\S 2$ ), we get

$$
\begin{aligned}
\sup _{|\lambda| \leq 3 R, \mu\rangle 0}\left\|\tilde{\varphi}(H)(H-\lambda \mp i \mu)^{-1} \tilde{\varphi}(H)\right\| & \leq C R^{-1} \\
& \left\|\langle A\rangle^{-s} \tilde{\varphi}(H)\langle A\rangle^{s^{\prime}}\right\|^{2} \leq 1+C R^{-1}
\end{aligned}
$$

which yields the LAP:

$$
\begin{aligned}
& \sup _{\lambda \in \mathbf{R}, \mu>0}\left\|\langle A\rangle^{-s} \tilde{\varphi}(H)(H-\lambda \mp i \mu)^{-1} \tilde{\varphi}(H)\langle A\rangle^{-s} \phi\right\| \\
& \quad \leq c_{0}^{-1} \delta\left(\left(\frac{\delta}{\tilde{R}}\right)^{1 / 2}+\delta(\tilde{R})^{1 / 2} \frac{(1-s)^{1-s}(2-s)}{(2 s-1)}\right)^{2} e^{\delta c_{2} \tilde{R} / c_{0}}\|\phi\|
\end{aligned}
$$

for all $1 / 2<s \leq 1$. As the direct consequence of Kato [7] (see also D'Ancona [3]), we obtain the following theorem:

Theorem 1.4. Under the same assumptions in Theorem 1.3,

$$
\begin{aligned}
& \frac{1}{2 \pi} \int_{\mathbf{R}}\left\|\langle A\rangle^{-s} \tilde{\varphi}(H) e^{-i t H} \phi\right\|^{2} d t \\
& \leq c_{0}^{-1} \delta\left(\left(\frac{\delta}{\tilde{R}}\right)^{1 / 2}+\delta(\tilde{R})^{s-1 / 2} \frac{(1-s)^{1-s}(2-s)}{(2 s-1)}\right)^{2} e^{\delta c_{2} \tilde{R} / c_{0}}\|\phi\|^{2}
\end{aligned}
$$

holds for all $1 / 2<s \leq 1$ and $\phi \in \mathscr{H}$, where $\tilde{\varphi} \in C^{\infty}(\mathbf{R})$, which satisfies $\tilde{\varphi}(s)=1$ if $|s| \geq 5 R$ and $=0$ if $|s| \leq 4 R$.

Theorems 1.2 and 1.3 yield the following corollary:
Corollary 1.5. Let $I:=\sigma(H) \cap((-\infty,-5 R] \cup[5 R, \infty))$. Then $I \subset \sigma_{\mathrm{ac}}(H)$, where $\sigma_{\mathrm{ac}}$ denotes a set of all absolutely continuous spectra of $H$.

Remark 1.6. As usual, $c_{0}>0$ is not a large number. For example, consider $H=p^{2}$, $p=-i d / d x, \mathscr{H}=L^{2}(\mathbf{R})$ and the Yokoyama-type conjugate operator $A=\left(x p\left(1+p^{2}\right)^{-1}+\right.$ $\left.\left(1+p^{2}\right)^{-1} p x\right) / 2, x \in \mathbf{R}$. Formally, it then follows that

$$
i[H, A]^{0}=2 p^{2}\left(1+p^{2}\right)^{-1}=2+\mathcal{O}\left(R^{-1}\right), \quad i\left[[H, A]^{0}, A\right]^{0}=\mathcal{O}\left(R^{-2}\right)
$$

Hence, deducing the smallness exclusively with (1) may be difficult. On the other hand, by taking $\tilde{R}=4$ and $s=4$, (21) deduces $\sup _{|\lambda| \geq 3 R}\left\|\langle A\rangle^{-s}(H-\lambda \mp i \mu)^{-1}\langle A\rangle^{-s} \phi\right\|<1$, such that the estimate can be applied to an operator written as a form (selfadjoint operator + complex perturbation). See, e.g., Wang [12] and the references therein.
Remark 1.7. Under some situations, it follows that

$$
\sup _{|\lambda| \geq 3 R}\left\|\langle A\rangle^{-s}(H-\lambda \mp i \mu)^{-1}\langle A\rangle^{-s} \phi\right\| \rightarrow 0, \quad \text { as } R \rightarrow \infty
$$

and it may be expected that the same estimate holds for the general Hamiltonian $H$ and its conjugate operator $A$. However, there are some counterexamples, e.g., by taking $H=p$ on $L^{2}(\mathbf{R})$. Then, $i[H, x]^{0}=1 \geq 0$, such that for any fixed $\lambda_{0}$ there exists $\nu>0$, where

$$
\begin{equation*}
\lim _{\mu \rightarrow 0+}\left\|\langle x\rangle^{-s}\left(H-\lambda_{0}-i \mu\right)^{-1}\langle x\rangle^{-s}\right\|=\nu \tag{3}
\end{equation*}
$$

holds. On the other hand, suppose that for all $\varepsilon>0$, there exists $R=R_{\varepsilon} \gg 1$ such that

$$
\begin{equation*}
\lim _{\mu \rightarrow 0+}\left\|\langle x\rangle^{-s}(H-R-i \mu)^{-1}\langle x\rangle^{-s}\right\| \leq \varepsilon \tag{4}
\end{equation*}
$$

holds. Then, by the unitary transform $e^{i\left(R-\lambda_{0}\right) x}$, we notice that (4) is equivalent to

$$
\lim _{\mu \rightarrow 0+}\left\|\langle x\rangle^{-s}\left(H-\lambda_{0}-i \mu\right)^{-1}\langle x\rangle^{-s}\right\| \leq \varepsilon
$$

which contradicts (3) by taking a sufficiently small $\varepsilon>0$ compared to $\nu$. Hence, some additional assumptions are needed with regard to $H, A$, and $\varphi$ in order to prove the high-energy decay property for the resolvent. (The decaying estimate with a micro local parameter has been proven by Royer [10].)

With a similar approach, we can prove a smoothing-type limiting absorption principle. In this paper, we additionally assume the following statements:
Assumption 1.8. Suppose Assumption 1.1 and let $B:=i[H, A]^{0}$. Then, commutators

$$
\operatorname{ad}_{A}^{2}(H):=i[B, A]^{0}, \quad \operatorname{ad}_{A}^{3}(H):=i\left[[B, A]^{0}, A\right]^{0}, \quad \operatorname{ad}_{A}^{4}(H):=i\left[\operatorname{ad}_{A}^{3}(H), A\right]^{0}
$$

are well-defined and can be extended to bounded operators. Moreover, for some $c_{0} \leq \tilde{c} \leq$ $c_{1}$, the commutator $i[H, A]^{0}$ can be written as

$$
\begin{equation*}
i[H, A]^{0}=\tilde{c} I+J+K \tag{5}
\end{equation*}
$$

where $I$ is the identity operator on $\mathscr{H}$, and $J$ and $K$ are bounded operators. Moreover, they satisfy the following four conditions:
(g). For large $R$, there exists a sufficiently small constant $\delta>0$, such that

$$
\|K \varphi(H)\| \leq \delta
$$

(h). $J$ commutes with $H$.
(i). For the same $0 \leq \beta \leq 1 / 2,\left[\langle H\rangle^{\beta}, K\right]^{0}\langle H\rangle^{\beta} A$ is a bounded operator.
(k). For the same $0 \leq \beta \leq 1 / 2$, the operator $\langle H\rangle^{\beta} i\left[i[H, A]^{0}, A\right]^{0}\langle H\rangle^{\beta}$ is a bounded operator.

Theorem 1.9. For the same $\beta$ in Assumption 1.8, let us define

$$
P:=\langle H\rangle^{2 \beta} A+A\langle H\rangle^{2 \beta}
$$

Then, under Assumptions 1.1 and 1.8, for all $s>1 / 2$, the following limiting absorption principle holds:

$$
\begin{equation*}
\sup _{|\lambda| \geq 3 R, \mu>0}\left\|\langle P\rangle^{-s}\langle H\rangle^{\beta}(H-\lambda \mp i \mu)^{-1}\langle H\rangle^{\beta}\langle P\rangle^{-s} \phi\right\| \leq C\|\phi\| . \tag{6}
\end{equation*}
$$

Moreover, for all $1 / 2<s \leq 1$, the high-energy smoothing estimates are

$$
\int_{\mathbf{R}}\left\|\langle P\rangle^{-s}\langle H\rangle^{\beta} \tilde{\varphi}(H) e^{-i t H} \phi\right\|^{2} d t \leq C\|\tilde{\varphi}(H) \phi\|^{2}
$$

where $\tilde{\varphi} \in C^{\infty}(\mathbf{R})$, which satisfies $\tilde{\varphi}(s)=1$, if $|s| \geq 5 R$, and $=0$, if $|s| \leq 4 R$.

## 2 Preliminaries

In this section, we introduce the most important Lemma in this paper:
Lemma 2.1. Under Assumption 1.1, the following statements hold:
(a1) $\mathscr{D}(A)$ reduces $\varphi(H)$, i.e.,

$$
\varphi(H) \mathscr{D}(A) \subset \mathscr{D}(A) .
$$

(a2) $\|[\varphi(H), A]\| \leq C R^{-1}$ holds, (denoted by $[\varphi(H), A]=\mathcal{O}\left(R^{-1}\right)$ ).
(a3) Additionally, if we suppose Assumption [1.8, then for all $0 \leq \beta \leq 1 / 2,\left[\langle H\rangle^{2 \beta}, i[H, A]^{0}\right]^{0}$ is a bounded operator. Moreover, $\left[\langle H\rangle^{\beta}, A\right]^{0}\langle H\rangle^{\beta}$ is also a bounded operator.

Proof. We employ so-called commutator expansion: Let $A_{0}$ and $B_{0}$ be selfadjoint operators with

$$
\left\|i\left[A_{0}, B_{0}\right]^{0}\right\|<\infty, \quad\left\|\operatorname{ad}_{A_{0}}^{j}\left(B_{0}\right)\right\|<0
$$

for some integer $2 \leq j$. For $0 \leq \rho \leq 1$, suppose $f \in C^{\infty}(\mathbf{R})$ satisfies $\left|\partial_{s}^{k} f(s)\right| \leq C_{k}\langle s\rangle^{\rho-k}$, $k \geq 0$. Then,

$$
i\left[f\left(A_{0}\right), B_{0}\right]=\sum_{k=1}^{j-1} \frac{1}{k!} f^{(k)}\left(A_{0}\right) \operatorname{ad}_{A_{0}}^{k}\left(B_{0}\right)+R_{j}\left(f, A_{0}, B_{0}\right)
$$

where $R_{j}\left(f, A_{0}, B_{0}\right)$ satisfies

$$
\left\|\left(A_{0}+i\right)^{j-1} R_{j}\left(f, A_{0}, B_{0}\right)\right\| \leq C\left(f^{(j)}\right)\left\|\operatorname{ad}_{A_{0}}^{j}\left(B_{0}\right)\right\| .
$$

The proof of this lemma is given in Sigal-Soffer [11] and as Lemma C.3.1 in Dereziński and Gérard [4]. Commutator expansion with $j=2$ is such that

$$
A \varphi(H)\langle A\rangle^{-1}=[A, \varphi(H)]\langle A\rangle^{-1}+\varphi(H) A\langle A\rangle^{-1}
$$

will be a bounded operator, since $\varphi^{\prime}$ and $\varphi^{\prime \prime}$ are bounded functions. Moreover, by the construction of $\varphi$, we have $\left|\varphi^{\prime}\right|,\left|\varphi^{\prime \prime}\right| \leq \mathcal{O}\left(R^{-1}\right)$, and hence (a1) and (a2) are proven. Now we prove (a3): by $2 \beta \leq 1$ and Assumption $1.8,\left\|[B, H]^{0}\right\| \leq C$ with $B=i[H, A]^{0}$, we can use commutator expansion to a pair of operators, $B$ and $\langle H\rangle^{2 \beta}$. Hence, $\left\|\left[\langle H\rangle^{2 \beta}, B\right]^{0}\right\| \leq C$. Moreover, formally we have

$$
i\left[\langle H\rangle^{\beta}, A\right]^{0}\langle H\rangle^{\beta}=i\langle H\rangle^{\beta} A\langle H\rangle^{\beta}-i A\langle H\rangle^{2 \beta}=\langle H\rangle^{\beta} i\left[A,\langle H\rangle^{\beta}\right]^{0}+i\left[\langle H\rangle^{2 \beta}, A\right]^{0}
$$

By commutator expansion with $j=2$, we have $\langle H\rangle^{\beta} i\left[A,\langle H\rangle^{\beta}\right]^{0}$ as a bounded operator, since $\left|\langle s\rangle^{\beta}\left(\langle s\rangle^{\beta}\right)^{\prime}\right| \leq C\langle s\rangle^{2 \beta-1} \leq C$.

## 3 Proof of Theorems

We now prove Theorems 1.2 and 1.3 , The proof for Theorem 1.3 involves imitates the approach of [9] (see Isozaki [6]).

### 3.1 Proof of Theorem 1.2

Let $\lambda_{0} \in(-\infty,-3 R] \cup[3 R, \infty)$ be an eigenvalue of $H$, and let $\psi \in \mathscr{H}$ be an eigenfunction: i.e., $H \psi=\lambda_{0} \psi$. Then, using Virial's theorem, Assumption (e), and $\varphi\left(\lambda_{0}\right)=1$, we have

$$
0=\left(i\left[\lambda_{0}, A\right] \varphi(H) \psi, \varphi(H) \psi\right)=\left(i[H, A]^{0} \varphi(H) \psi, \varphi(H) \psi\right) \geq c_{0}\|\varphi(H) \psi\|^{2}=c_{0}\|\psi\|^{2}
$$

which implies $\psi \equiv 0$.

### 3.2 Proof of Theorem 1.3

For a small parameter $\varepsilon>0, \mu>0$ and a large parameter $\lambda \in \mathbf{R}$ with $|\lambda| \geq 3 R$, we define

(b1). $T(\varepsilon)$ is a closed operator, and for all $z \in \mathbf{C}_{+}, 0 \in \rho(T(\varepsilon))$, and $G(\varepsilon)$ is analytic on $C_{+}$.
(b2). Let $M_{1}$ satisfy $M_{1}^{*} M_{1} \leq M^{*} M$. Then, for all bounded operators $\mathcal{B}$,

(b3). For some $0<\hat{\varepsilon}<1$, suppose that $\varepsilon<R^{1-\hat{\varepsilon}}$. Then there exists $\delta=\delta(R)$, with $\delta \rightarrow 1$ as $R \rightarrow \infty$ such that $\|G(\varepsilon)\| \leq \delta\left(c_{0} \varepsilon\right)^{-1}$.
(b4). $\|(\varphi(H)-1) G(\varepsilon)\| \leq C R^{-1}$.

Proof. We only need to prove (b3) and (b4). Proofs for (b1) and (b2) can be found in [9] and [2] (or see the proof for Lemma 4.2 with $\beta=0$ ). We divide $G(\varepsilon)$ into $\varphi(H) G(\varepsilon)+$ $(1-\varphi(H)) G(\varepsilon)$. By $(\mathrm{b} 2)$ with $\left(\varphi(H) \sqrt{c_{0}}\right)^{2} \leq M^{*} M$ and $\mathcal{B}=1$, we have $\|\varphi(H) G(\varepsilon)\| \leq$ $\left(c_{0} \varepsilon\right)^{-1 / 2}\|G(\varepsilon)\|^{1 / 2}$. On the other hand, by

First, we prove that

$$

We divide $-i L_{4}$ into $L_{5}+L_{6}$ with

By (9) and (11),

By Lemma 2.1(a2) and

\left[M^{2}, A\right]=[\varphi(H), A] i[H, A] \varphi(H)+\varphi(H) i[[H, A], A] \varphi(H)+\varphi(H) i[H, A][\varphi(H), A]
$$

we have

\left\|L_{6}\right\| & \leq \varepsilon\left(\mathcal{O}\left(R^{-1}\right)+\left\|F /\left(\varepsilon c_{0}\right)\right\|^{1 / 2}\right)^{2}\left(\mathcal{O}\left(R^{-1}\right)+c_{2}\right) \\
& \leq\left(\left(c_{2} / c_{0}\right)+\mathcal{O}\left(R^{-1}\right)\right)\|F\|+\varepsilon^{1 / 2} \mathcal{O}\left(R^{-1}\right)\|F\|^{1 / 2}+\varepsilon \mathcal{O}\left(R^{-2}\right)
\end{aligned}
$$

Then, for some $\delta=\delta_{R}>1$ with $\delta \rightarrow 1$ as $R \rightarrow \infty$,

\left\|F^{\prime}\right\| \leq \sum_{j=1}^{6}\left\|L_{j}\right\| \leq 2 \delta(2-s) c(s) c_{0}^{-1 / 2} \varepsilon^{s-3 / 2}\|F\|^{1 / 2}+\left(\delta c_{2} / c_{0}\right)\|F\|+\mathcal{O}\left(R^{-1}\right)
$$

holds. By following the argument in [9], for all $0<\tilde{R} \leq R^{1-\hat{\varepsilon}}$ and for some $\delta$ it holds that

& \leq c_{0}^{-1}\left(\left(\frac{\delta}{\tilde{R}}\right)^{1 / 2}+\frac{2 \delta(2-s)\left(\tilde{R}^{s-1 / 2}\right)}{2 s-1} c(s)\right)^{2} e^{\delta \tilde{R} c_{2} / c_{0}}
\end{aligned}
$$

which proves (1). Here, we remark that

& \leq c_{0}^{-1}\left(\left(\frac{\delta}{\tilde{R}}\right)^{1 / 2}+2 \delta C(s)(\tilde{R})^{1 / 2}\right) e^{\delta c_{2} \tilde{R} / c_{0}}
\end{aligned}
$$

holds, which gives (2).

## 4 Smoothing estimate with high-energy cut-off

In this section, we prove Theorem 1.9, In the case where $\varphi \in C_{0}^{\infty}(\mathbf{R})$, a more generalized estimate was obtained by Møller-Skibsted [8]. For $0 \leq \beta \leq 1 / 2$, we define

M_{\beta} & :=\left(\varphi(H)\langle H\rangle^{\beta} i[H, A]^{0}\langle H\rangle^{\beta} \varphi(H)\right)^{1 / 2},
\end{aligned}
$$

where we always assume that $\mu>0$ and $\varepsilon>0$ are sufficiently small. For simplicity, we may denote

$$

Lemma 4.1. For any fixed $\varepsilon$ and $\mu$, we define $H(\varepsilon):=\langle H\rangle^{\beta} G(\varepsilon)\langle H\rangle^{\beta}$. Then, $H(\varepsilon)$ satisfies

& -\left(i \varepsilon\left[\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta},\langle H\rangle^{-\beta} M^{*} M\langle H\rangle^{-\beta}\right] u, u\right) \\
\geq & I_{1}+I_{2}+I_{3},
\end{aligned}
$$

where

$$
\begin{aligned}
& I_{1}:=\left\|\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta} u\right\|^{2}, \\
& I_{2}:=\mu^{2}\left\|\langle H\rangle^{-2 \beta} u\right\|^{2}+\mu \varepsilon c_{0}\|\varphi(H) u\|^{2}+\varepsilon^{2} c_{0}^{2}\left\|\varphi(H)^{2} u\right\|^{2}, \\
& I_{3}:=-\varepsilon\left(i\left[\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta}, \varphi(H) i[H, A]^{0} \varphi(H)\right] u, u\right) .
\end{aligned}
$$

By (5) and the boundedness of $\left\|\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta} u\right\|$, we get

& +2 \varepsilon \operatorname{Im}\left(K \varphi(H) u,\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta} \varphi(H) u\right) .
\end{aligned}
$$

By the assumption of $J$ and $K$, we have

+4 \varepsilon \delta\left\|\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta} \varphi(H)^{2} u\right\|
\end{gathered}
$$

Here, we define

$$
\begin{aligned}
I_{4} & :=\left\|\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta}\left(1-\varphi(H)^{2}\right) u\right\|^{2} \\
& \geq\left\|\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta}(1-\varphi(H)) u\right\|^{2} \\
I_{5} & :=\left\|\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta} \chi(|H| \leq 2 \lambda) \varphi(H)^{2} u\right\|^{2} \\
I_{6} & :=\left\|\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta} \chi(|H| \geq 2 \lambda) u\right\|^{2}, \\
I_{7} & :=\left\|\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta} \varphi(H)(1-\varphi(H)) u\right\|^{2}
\end{aligned}
$$

where we use $\varphi(H) \chi(|H| \geq 2 \lambda)=\chi(|H| \geq 2 \lambda)$. Then, we have $I_{1} \geq I_{4}+I_{5}+I_{6}$, $I_{3} \leq 4 \varepsilon \delta\left(\sqrt{I_{5}}+\sqrt{I_{6}}+\sqrt{I_{7}}\right)$ and

J_{2} & :=I_{4} / 2+I_{5} / 2-4 \varepsilon \delta \sqrt{I_{7}}-64 \varepsilon^{2} \delta^{2}\|(1-\varphi(H)) u\|^{2}, \\
J_{3} & :=I_{4} / 2+I_{2}-64 \varepsilon^{2} \delta^{2}\|\varphi(H) \chi(|H| \leq 2 \lambda) u\|^{2}
\end{aligned}
$$

First, we estimate $J_{1}$. It is clear that for large $|y| \geq 2 \lambda$

\end{align*}

where we assume $v_{1}:=\left(1-1028 \varepsilon^{2} \delta^{2}\right) \geq 1 / 2$. If $\chi(|H| \geq 2 \lambda) u \equiv 0$, then (13) $=0=$ $\|\chi(|H| \geq 2 \lambda) u\|^{2}$, and if $\chi(|H| \geq 2 \lambda) u \neq 0$, (12) implies $\sqrt{I_{6}} \geq 1 / 4$ then for some certain $\varepsilon$-independent positive constant $v_{2}>0$,

& +\left\|\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta} \varphi(H)(1-\varphi(H)) \chi(|H| \leq 3 R / 2) u\right\| \\
= & I_{8}+I_{9} .
\end{aligned}

On the support of $(1-\varphi(H))$,

& \left\|\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta}(1-\varphi(H)) u\right\| \geq R\left(1+4 R^{2}\right)^{-\beta}\|(1-\varphi(H)) u\| \\
& \geq 5^{-\beta} R^{1-2 \beta}\|(1-\varphi(H)) u\|
\end{aligned}
$$

holds. Hence, there is a positive constant $v_{3} \geq 1 / 4$ such that

& I_{4} / 2-64 \varepsilon^{2} \delta^{2}\|(1-\varphi(H)) u\|^{2}-4 \varepsilon \delta I_{9} \geq v_{3} I_{4}-4 \varepsilon \delta I_{9}  \tag{14}\\
& \geq v_{3}\left\|\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta}(1-\varphi(H)) \chi(|H| \leq 3 R / 2) u\right\|^{2} \\
& \quad-4 \varepsilon \delta\left\|\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta}(1-\varphi(H)) \chi(|H| \leq 3 R / 2) u\right\|
\end{align*}
$$

holds. On the support of $\chi(|H| \leq 3 R / 2),(1-\varphi(H))$ is not always 0 , since $\varphi^{\prime}(s)>0$ on $R<|s|<2 R$, which gives (14) $\geq 0$, by selecting $\varepsilon \delta>0$ enough small. In the same manner, we get $I_{5} / 2-4 \varepsilon \delta I_{8} \geq 0$. Thus, we have $J_{2} \geq 0$. These yield

& \quad+\left(\varepsilon^{2} c_{0}^{2}\left\|\chi(3 R / 2 \leq|H| \leq 2 \lambda) \varphi(H)^{2} u\right\|^{2}-64 \varepsilon^{2} \delta^{2}\|\chi(3 R / 2 \leq|H| \leq 2 \lambda) \varphi(H) u\|^{2}\right) \\
& \quad+\left(\frac{1}{4}\left\|\langle H\rangle^{-\beta}(H-\lambda)\langle H\rangle^{-\beta}\left(1-\varphi(H)^{2}\right) \chi(|H| \leq 3 R / 2) u\right\|^{2}\right. \\
& \left.\quad-64 \varepsilon^{2} \delta^{2}\|\chi(|H| \leq 3 R / 2) \varphi(H) u\|^{2}\right) \\
& \geq v_{4}\left\|\left(1-\varphi(H)^{2}\right) u\right\|^{2}+\mu^{2}\langle\lambda\rangle^{-4 \beta}\left\|\varphi(H)^{2} \chi(|H| \leq 2 \lambda) u\right\|^{2} \\
& \quad+v_{5} \varepsilon^{2} c_{0}^{2}\left\|\chi(3 R / 2 \leq|H| \leq 2 \lambda) \varphi(H)^{2} u\right\|^{2}+v_{6}\|\chi(|H| \leq 3 R / 2) u\|^{2} \\
& \geq v_{4}\left\|\left(1-\varphi(H)^{2}\right) u\right\|^{2}+v_{7}\left(\varepsilon^{2}+\left(\mu /|\lambda|^{2 \beta}\right)^{2}\right)\left\|\varphi(H)^{2} \chi(|H| \leq 2 \lambda) u\right\|^{2}
\end{aligned}
$$

for some $(\varepsilon, \mu, \lambda)$-independent positive constants $v_{4}, v_{5}, v_{6}$, and $v_{7}$. Finally, we obtain

\geq & C\left(\varepsilon^{2}+\left(\mu /|\lambda|^{2 \beta}\right)^{2}\|u\|^{2}\right. \tag{15}
\end{align*}

where we take $0<\delta^{2} \ll c_{0}^{2}$ and we use $\varphi^{2} \leq \varphi$. Inequality (15) entails that there exists a strict inverse operator of $\hat{T}$ :

which proves ( c 2 ), where we remark that

### 4.1 Proof of Theorem 1.2

Now, we prove (6). The fundamental approach is exactly the same as in the proof of (11). We define

& F=F_{\beta}(\varepsilon):=W_{\beta}(\varepsilon)\langle H\rangle^{\beta} G_{\beta}(\varepsilon)\langle H\rangle^{\beta} W_{\beta}(\varepsilon), \\
& T=T_{\beta}(\varepsilon):=H-\lambda-i \mu-i \varepsilon \varphi(H)\langle H\rangle^{\beta} i[H, A]^{0}\langle H\rangle^{\beta} \varphi(H)
\end{aligned}
$$

For simplicity, we use notations $F_{\beta}(\varepsilon)=F, G_{\beta}(\varepsilon)=G, T_{\beta}(\varepsilon)=T,\langle H\rangle^{\beta}=Z, B=$ $i[H, A]^{0}, g=g(H)=Z \varphi(H), M=(\varphi(H) Z B Z \varphi(H))^{1 / 2}$ and $d / d \varepsilon=^{\prime}$. A straightforward calculation shows

& L_{5}=i(W Z G Z T A Z G Z W-W Z G Z A T Z G Z W), \\
& L_{6}=i \varepsilon W Z G Z i[g B g, A] Z G Z W .
\end{aligned}

By (8), Lemma 4.2(c4) and

## 5 Application to Schrödinger-type operators

We now apply the main theorem to dissipative operators. Unfortunately, complex and long calculations are needed in order to check all of the conditions stated in Assumption 1.8. Thus, we here only provide a sketch of the calculation. In what follows, let $|\lambda| \gg 1$, $\mathscr{H}=L^{2}\left(\mathbf{R}^{n}\right), p=-i \nabla$ on $\mathbf{R}^{n}$, and where $V$ is smooth and satisfies the condition that for all multi-index $\alpha$ and for some $\rho>0$, there exists a constant $C_{\alpha}>0$ such that

Let us consider the Schrödinger-type operators

where $a>0, b \in \mathbf{R}$, and $\gamma \geq 1 / 2$, and its conjugate operator

A=\left(1+\left(p^{2}+b^{2}\right)\right)^{-\gamma} p \cdot x+x \cdot p\left(1+\left(p^{2}+b^{2}\right)\right)^{-\gamma} . \tag{19}
\end{equation*}
$$

By simple calculation, formally, we have

i[H, A]= & 4 \gamma a p^{2}\left(p^{2}+b^{2}\right)^{\gamma-1}\left(1+\left(p^{2}+b^{2}\right)\right)^{-\gamma} \\
& -x \cdot \nabla V \times\left(1+p^{2}+b^{2}\right)^{-\gamma}+(\text { similar terms }) \\
i[i[H, A], A]= & 16 \gamma a p^{2}\left(p^{2}+b^{2}\right)^{\gamma-1}\left(1+p^{2}+b^{2}\right)^{-2 \gamma}+(\text { similar terms }) \\
& +x^{2}(\Delta V)\left(1+p^{2}+b^{2}\right)^{-2 \gamma}+(\text { similar terms })
\end{aligned}
$$

and

$$
\begin{aligned}
i[H, i[H, A]]= & -8 \gamma a \nabla V \cdot p\left(p^{2}+b^{2}\right)^{-\gamma-1}\left(1+\left(p^{2}+b^{2}\right)\right)^{-\gamma}+(\text { similar terms }) \\
& +2 a \gamma p \cdot \nabla V \times\left(1+p^{2}+b^{2}\right)^{-\gamma}+(\text { similar terms }) .
\end{aligned}
$$

Here, let $R$ be sufficiently larger than $C_{\alpha}$ with $a, b$, and $\gamma$ as constants. Then, on the support of $\varphi(H)$, it follows that $H_{0}=H-V$ is sufficiently large. Now we prove (5) and the four statements in Assumption 1.8. A straightforward calculation gives

& p^{2}\left(p^{2}+b^{2}\right)^{-\gamma-1}\left(1+\left(p^{2}+b^{2}\right)\right)^{-\gamma} \\
& =\left(p^{2}+b^{2}\right)^{\gamma}\left(1+p^{2}+b^{2}\right)^{-\gamma}-b^{2}\left(p^{2}+b^{2}\right)^{\gamma-1}\left(1+p^{2}+b^{2}\right)^{-\gamma} \\
& =1+\mathcal{O}\left(\left(\left(p^{2}+b^{2}\right)^{\gamma}\right)^{-1 / \gamma}\right) \\
& =1+\mathcal{O}\left(H^{-1 / \gamma}\right)+\mathcal{O}\left(V\left(p^{2}+b^{2}\right)^{-1-1 / \gamma}\right),
\end{aligned}
$$

and hence we can divide $i[H, A]$ into $\tilde{c} I+J+K$ with $\tilde{c}=4 \gamma a, J=J(H)=\mathcal{O}\left(H^{-1 / \gamma}\right)$ and $K=\mathcal{O}\left(V\left(p^{2}+b^{2}\right)^{-1-1 / \gamma}\right)-x \nabla V\left(1+p^{2}+b^{2}\right)^{-\gamma}+($ similar terms $)$. Since $V$ is smooth, $i[H, K]$ can be written as $\nabla V \cdot p \times \mathcal{O}\left(1+p^{2}+b^{2}\right)^{-1}$. Hence, (g), (h), and (i) can be proven. Moreover, by $i[i[H, A], A]=\mathcal{O}\left(\left(1+p^{2}+b^{2}\right)^{-\gamma}\right)$, we also have $(\mathrm{k})$. Hence, we have the following smoothing estimate:

Let $\theta \in \mathbf{R}$ be a constant given later. Inequality

\begin{aligned}
& \left\|\langle x\rangle^{-s}\langle p\rangle^{\theta} \tilde{\varphi}(H) e^{-i t H} \phi\right\| \\
& \leq\left\|\langle x\rangle^{-s}\langle p\rangle^{\theta}\langle H\rangle^{-\beta}\langle P\rangle^{s}\right\|\left\|\langle P\rangle^{-s}\langle H\rangle^{\beta} \tilde{\varphi}(H) e^{-i t H} \phi\right\|
\end{aligned}
$$

gives the following smoothing estimates:
Corollary 5.1. Suppose $H$ and $A$ are written in the form in (18) and (19), respectively, and $\gamma \geq 1 / 2$. Let

Moreover, by $\left[p \cdot x,\langle p\rangle^{-4 \beta \gamma-1+2 \gamma}\right]=$ (bounded operator), we have

holds if $\beta \leq \beta^{*}$. Again, we only consider the case of $\beta \geq \beta^{*}$. By Helffer-Sjöstrand's formula (see [5), we get

with

\left\|\langle p\rangle^{\theta} \mathcal{L}\langle p\rangle^{4 \beta \gamma s+s-2 \gamma s}\right\| \leq C\left\|\langle p\rangle^{\theta-2 \gamma}\right\|\left\|\langle p\rangle^{4 \beta \gamma s+s-2 \gamma s-2 \gamma-1}\right\| \leq C
$$

where we use $\beta \geq \beta^{*}, \theta-2 \gamma \leq 2 \beta \gamma-2 \gamma \leq 0$ and $4 \beta \gamma s+s-2 \gamma s-1 \leq s-1 \leq 0$. Moreover, a symbol calculation of the pseudo-differential operator gives

$$
\left\|\langle x\rangle^{-s}\langle p\rangle^{\theta}\langle x\rangle^{s}\langle p\rangle^{-s}\right\| \leq C
$$

which proves (24). By (22) and (24) or (23) and (25), we get

$$
\begin{aligned}
\left\|\langle x\rangle^{-s}\langle p\rangle^{\theta} \tilde{\varphi}(H) e^{-i t H} \phi\right\| & \leq\left\|\langle x\rangle^{-s}\langle p\rangle^{\theta}\langle H\rangle^{-\beta}\langle P\rangle^{s}\right\|\left\|\langle P\rangle^{-s}\langle H\rangle^{\beta} \tilde{\varphi}(H) e^{-i t H} \phi\right\| \\
& \leq C\left\|\langle P\rangle^{-s}\langle H\rangle^{\beta} \tilde{\varphi}(H) e^{-i t H} \phi\right\|
\end{aligned}
$$

and, together with (20), we obtain (21).
By $\max _{0 \leq \beta \leq 1 / 2} \theta=\gamma-1 / 2$, we finally obtain the following smoothing estimate:
Theorem 5.2. For the operator $H=a\left(p^{2}+b^{2}\right)^{\gamma}+V$ in (18),

$$
\begin{aligned}
& \sup _{|\lambda| \geq 3 R}\left\|\langle x\rangle^{-s}\langle p\rangle^{\gamma-1 / 2}(H-\lambda \mp 0)^{-1}\langle p\rangle^{\gamma-1 / 2}\langle x\rangle^{-s} \phi\right\| \leq C\|\phi\|, \\
& \int_{\mathbf{R}}\left\|\langle x\rangle^{-s}\langle p\rangle^{\gamma-1 / 2} \tilde{\varphi}(H) e^{-i t H} \phi\right\|^{2} d t \leq C\|\phi\|^{2}
\end{aligned}
$$

holds.
If $\gamma=1$, this estimate corresponds to the smoothing estimate for the Schrödinger operator with a high-energy cut-off (see, e.g., 1].
