# Blow up and global existence for the periodic Phan-Thein-Tanner model

#### Abstract

In this paper, we mainly investigate the Cauchy problem for the periodic Phan-Thein-Tanner (PTT) model. This model is derived from network theory for the polymeric fluid. We prove that the strong solutions of PTT model will blow up in finite time if the trace of initial stress tensor $\operatorname{tr} \tau_{0}(x)$ is negative. This is a very different with the other viscoelastic model. On the other hand, we obtain the global existence result with small initial data when $\operatorname{tr} \tau_{0}(x) \geq c_{0}>0$ for some $c_{0}$. Moreover, we study about the large time behaviour.

## 1. Introduction

In this paper, we consider the initial value problem for the following periodic incompressible Phan-Thein-Tanner (PTT) model [20, 19]:

Here $u$ stands for the velocity and $p$ is the scalar pressure of fluid, $\tau$ is the stress tensor. $D(u)$ is the symmetric part of $\nabla u$, that is

[^0]$Q(\tau, \nabla u)$ is a given bilinear form

where $\Omega(u)$ is the skew-symmetric part of $\nabla u$, namely

\Omega(u)=\frac{1}{2}\left(\nabla u-(\nabla u)^{T}\right)

$\mu>0$ is the viscosity coefficient and $\mu_{1}$ is the elastic coefficient. $a$ and $\mu_{2}$ are associated to the Debroah number $D e=\frac{\mu_{2}}{a}$, which indicates the relation between the characteristic flow time and elastic time [3]. $\lambda \in[-1,1]$ is a physical parameter. In particular, we call the system co-rotational case when $\lambda=0$. $b \geq 0$ is a constant relate to the rate of creation or destruction for the polymeric network junctions.

If $b=0$. the system ( $\overline{\mathrm{PTT}})$ reduce to the famous Oldroyd-B model (See [17]) which has been studied widely. Let us review some mathematical results for the related Oldroyd type model. C. Guillopé and J. C. Saut [9, 10] proved the existence of local strong solutions and the global existence of one dimensional shear flows. In [7], E. Fernández-Cara, F. Guillén and R. Ortega studied the local well-posedness in Sobolev spaces. J. Chemin and N. Masmoudi (4] proved the local well-posedness in critical Besov spaces and give a low bound for the lifespan. In the co-rotational case, P. L. Lions and N. Masmoudi [14] proved the global existence of weak solutions. In [13], F. Lin, C. Liu and P. Zhang proved that if the initial data is a small perturbation around equilibrium, then the strong solution is global in time. The similar results were obtained in several papers by virtue of different methods, see Z. Lei and Y. Zhou [12], Z. Lei, C. Liu and Y. Zhou [11], T. Zhang and D. Fang [21], Y. Zhu [22]. D. Fang, M.Hieber and R. Zi proved the global existence of strong solutions with a class of large data [5, 6]. For the Oldroyd-B model, the global existence of strong solutions in two dimension without small conditions is still an open problem.

In this paper, we focus on the PTT model $b \neq 0$. To our knowledge, there are a lot of numerical results about the PTT model (See, [18, 16, 15, 2, 8]). However, there is no any well-posedness results about the PTT model. The nonlinear term $(\operatorname{tr} \tau) \tau$ in the PTT model will leads to some interesting phenomenon that is quiet different between the Oldroyd-B model. By virtue of the characteristic method, we prove that the strong solution of (PTT will blow up in finite time when the initial data $\operatorname{tr} \tau_{0}<0$. This phenomenon can not be founded in other viscoelastic model.

On the other hand, when $\operatorname{tr} \tau_{0}$ has a positive low bound $c_{0}$, we can prove the global existence of strong solution with small initial data. The idea is inspired by the method applied in [22]. The main different is to deal with the nonlinear $\operatorname{term}(\operatorname{tr} \tau) \tau$. In [22], the author observe that the linearized
system of the Oldroyd-B model has the form

where $\mathbb{P}$ is the Leray project operator. Then, one can see that both $u$ and $\mathbb{P} \operatorname{div} \tau$ satisfy the following wave equation with damping term:

Based on the above dissipative structure of $u$ and $\mathbb{P} \operatorname{div} \tau$, the author in [22] proves the global existence of the strong solution for the Oldroyd-B model with small initial data. However, from the linearized system, we can not obtain any dissipation for $\tau$. Thus the nonlinear term $(\operatorname{tr} \tau) \tau$ is a difficult term even though the initial data is small. In order to deal with this difficult term, we use the Lagrange coordinate to write the equation of $\operatorname{tr} \tau$, and then we can obtain some decay estimate of the quantity $\operatorname{tr} \tau$. In the later, we will see that the estimate of $\operatorname{tr} \tau$ is depend on some power of $\frac{1}{c_{0}}$ and the initial data. Since the initial data is small, it follows that $\frac{1}{c_{0}}$ is very large. The key point in this paper is to control the power of $\frac{1}{c_{0}}$ such that $\operatorname{tr} \tau$ is still small for any time. Combining the decay estimate of $\operatorname{tr} \tau$ with the dissipative structure for the linearized system of (PTT), we can prove the global existence.

Throughout of the paper, we assume that $a=\lambda=0$ and $b=\mu=\mu_{1}=\mu_{2}=1$. There is no derivative in the additional term $(\operatorname{tr} \tau) \tau$ in ( $\overline{\mathrm{PTT}}$ ), the proof of local well-posedness for ( PTT ) is similar to the Oldroyd-B model(See [7, 13]) and we omit the detail here.

Our main results can be stated as follow:
Theorem 1.1. Let $\left(u_{0}, \tau_{0}\right) \in H^{2}\left(\mathbb{T}^{3}\right)$, assume that $\operatorname{tr} \tau_{0}\left(x_{0}\right)<0$ for some $x_{0} \in \mathbb{T}^{3}$, then the corresponding solution to the system (PTT) blows up in finite time. More precisely, there exists a time $T$ with $0<T \leq-\frac{1}{\operatorname{tr} \tau_{0}\left(x_{0}\right)}$ such that

Theorem 1.2. Suppose that $\operatorname{div} u_{0}=0, \int_{\mathbb{T}^{3}} u_{0} d x=0,\left(\tau_{0}\right)_{i j}=\left(\tau_{0}\right)_{j i}$, and the initial data $\left(u_{0}, \tau_{0}\right) \in$ $H^{2}\left(\mathbb{T}^{3}\right)$. There exists $\epsilon_{0}, \tilde{\epsilon}_{0}$ such that if

then the problem ( (PTT) admits a unique global solution $(u(t), \tau(t))$ satisfying that for all $t \geq 0$ :

$$

where $C>0$ is a positive constant independent of $t$. Moreover, we have

\|u\|_{H^{2}\left(\mathbb{T}^{3}\right)}+\|\mathbb{P} \operatorname{div} \tau\|_{L^{2}\left(\mathbb{T}^{3}\right)} \leq C\left(\left\|u_{0}\right\|_{H^{2}\left(\mathbb{T}^{3}\right)},\left\|\tau_{0}\right\|_{H^{2}\left(\mathbb{T}^{3}\right)}\right)(1+t)^{-\frac{3}{2}+\frac{\epsilon}{2}} \tag{1.2}
\end{equation*}

where $\epsilon>0$ is a small constant.
Remark 1.3. By virtue of Sobolev's embedding, one can see that

$$
c_{0} \leq \operatorname{tr} \tau_{0} \leq 3\left\|\tau_{0}\right\|_{L^{\infty}} \leq 3\left\|\tau_{0}\right\|_{H^{2}}=3 \delta_{0}
$$

it follows that $c_{0}=k \delta_{0}$ for some $k \leq 3$. For simplicity, we choose $k=\frac{1}{2}$ to prove our main result.
Remark 1.4. The conditions $c_{0}^{-2}\left\|\nabla^{2} \operatorname{tr} \tau_{0}\right\|_{L^{2}\left(\mathbb{T}^{3}\right)}^{2} \leq \tilde{\epsilon}_{0}$ and $\operatorname{tr} \tau_{0} \geq c_{0}$ are feasible. For example, choose a periodic stress tensor $\tau_{0}$ such that

As $c_{0}>0$ is a small constant, one can easily check that

0<c_{0}^{-2}\left\|\nabla^{2} \operatorname{tr} \tau_{0}\right\|_{L^{2}\left(\mathbb{T}^{3}\right)}^{2} \leq \tilde{\epsilon}_{0}, \quad \operatorname{tr} \tau_{0}(x) \geq c_{0}
$$

Remark 1.5. If $x \in \mathbb{R}^{3}$ and $\tau \in H^{2}\left(\mathbb{R}^{3}\right)$, we see that $\lim _{|x| \rightarrow \infty} \tau=0$. Thus, we can't suppose that $\operatorname{tr} \tau_{0} \geq c_{0}$ for some positive constant $c_{0}$. The Theorem 1.2 is false in this case. The global wellposedness of (PTT) in the whole space is also an interesting problem.

Remark 1.6. For the periodic Navier-Stokes equation, if $\int_{\mathbb{T}^{3}} u_{0}=0$, one can obtain the $H^{2}$-norm decay rate of velocity $u$ is $e^{-c t}$. However, for the system ( PTT ), there is no any decay for the stress tensor $\tau$, and we only obtain an algebra decay in Theorem 1.2.

The remainder of the paper is organized as follows. In Section 2 we give some key lemmas which will be used in the sequel. In Section 3, we prove the blow up phenomenon of the system (PTT). Section 4 is devoted to study about the global existence and decay rate of the strong solution with small initial data.

## 2. Preliminary

We recall a few estimates for the flow of a smooth vector field.
Lemma 2.1. [1] Let $v$ be a smooth time-dependent vector field with bounded first order space derivatives. Let $q_{t}$ satisfy

Then the flow $q_{t}$ is a $C^{1}$ diffeomorphism over $\mathbb{T}^{3}$, and for all $t \in \mathbb{R}^{+}$we have

Lemma 2.2. For any smooth tensor $\left[\tau_{i j}\right]_{3 \times 3}$ and three dimensional vector $u$, it always holds that

\end{aligned}

where

(\nabla u \cdot \nabla \tau)_{i}=\sum_{j} \partial_{j} u \cdot \nabla \tau_{i j}, \quad\left(\nabla u \cdot \nabla \triangle^{-1} \operatorname{div} \operatorname{div} \tau\right)_{i}=\partial_{i} u \cdot \nabla \triangle^{-1} \operatorname{div} \operatorname{div} \tau

Proof. The first equality has been proved in [22]. We only deal with the second equality. Using direct computation we have

\mathbb{P} \operatorname{div}((\operatorname{tr} \tau) \tau)=\mathbb{P}(\tau \cdot \nabla(\operatorname{tr} \tau)+(\operatorname{tr} \tau) \operatorname{div} \tau)=\mathbb{P}(\tau \cdot \nabla(\operatorname{tr} \tau))+\mathbb{P}((\operatorname{tr} \tau) \operatorname{div} \tau)
$$

Denote $\mathbb{P}^{\perp}=\triangle^{-1} \nabla$ div, we compute as follows

\mathbb{P}((\operatorname{tr} \tau) \operatorname{div} \tau) & =\mathbb{P}((\operatorname{tr} \tau) \mathbb{P} \operatorname{div} \tau)+\mathbb{P}\left((\operatorname{tr} \tau) \triangle^{-1} \nabla \operatorname{div} \operatorname{div} \tau\right) \\
& =\mathbb{P}((\operatorname{tr} \tau) \mathbb{P} \operatorname{div} \tau)+\mathbb{P} \nabla\left((\operatorname{tr} \tau) \triangle^{-1} \operatorname{div} \operatorname{div} \tau\right)-\mathbb{P}\left(\nabla(\operatorname{tr} \tau) \triangle^{-1} \operatorname{div} \operatorname{div} \tau\right) \\
& =\mathbb{P}((\operatorname{tr} \tau) \mathbb{P} \operatorname{div} \tau)-\mathbb{P}\left(\nabla(\operatorname{tr} \tau) \triangle^{-1} \operatorname{div} \operatorname{div} \tau\right)
\end{aligned}
$$

Hence we proof the Lemma.

By a directly calculation, the following technical lemma holds true.
Lemma 2.3. Let $r>0, c_{0}>0$, one has

c_{0}^{-1} e^{-\frac{t}{2}}\left(1+c_{0} t\right)^{\epsilon}, \quad \text { for } \quad r=1 \\
c_{0}^{-1} e^{-\frac{t}{2}}\left(1+c_{0} t\right)^{1-r}, \quad \text { for } r<1
\end{array}\right.
$$

and

\int_{\frac{t}{2}}^{t} e^{-(t-s)}\left(1+c_{0} s\right)^{-r} d s \lesssim\left(1+\frac{c_{0} t}{2}\right)^{-r} \int_{\frac{t}{2}}^{t} e^{-(t-s)} d s \lesssim\left(1+c_{0} t\right)^{-r}
$$

where $\epsilon>0$ is a small but fixed constant.

Notation. Since all function spaces in through out the paper are over $\mathbb{T}^{3}$, for simplicity, we drop $\mathbb{T}^{3}$ in the notation of function spaces if there is no ambiguity. $A \lesssim B$ stands for $A \leq C B$ for some constant $C>0$ independent of $A$ and $B$.

## 3. Proof of the Theorem 1.1

In this section, we are going to prove that the solution will blow up in finite time.
Proof. Suppose that $T^{*}$ is the maximal existence time for the solution $(u, \tau)$ with the initial data $u_{0}$ and $\tau_{0}$. Applying operator tr to the second equation of (PTT), and using the fact that $\operatorname{tr} D(u)=\operatorname{div} u=0$ and $\operatorname{tr} Q(u, \tau)=0$, we get

$$

\operatorname{tr} \tau_{t}+u \cdot \nabla \operatorname{tr} \tau+(\operatorname{tr} \tau)^{2}=0 \tag{3.1}
\end{equation*}
$$

Let us consider the trajectory equation,

$$
\frac{d}{d t} q(t, x)=u(t, q(t, x)), \quad q(0, x)=x
$$

Thanks to (3.1), we have

$$
\frac{d}{d t}(\operatorname{tr} \tau)(t, q(t, x))=-(\operatorname{tr} \tau)^{2}(t, q(t, x))
$$

which yields that

$$

\operatorname{tr} \tau(t, q(t, x))=\frac{\operatorname{tr} \tau_{0}(x)}{1+\operatorname{tr} \tau_{0}(x) t}, \quad \forall t \in[0, T] \tag{3.2}
\end{equation*}
$$

where $0<T<T^{*}$. Since $\operatorname{tr} \tau_{0}\left(x_{0}\right)<0$, it follows that $\operatorname{tr} \tau\left(t, q\left(t, x_{0}\right)\right) \rightarrow-\infty$ as $t \rightarrow-\frac{1}{\operatorname{tr} \tau_{0}\left(x_{0}\right)}$. Hence the maximal existence time $T^{*} \leq-\frac{1}{\operatorname{tr} \tau_{0}\left(x_{0}\right)}$.

Remark 3.1. Thanks to

$$
\lim _{t \rightarrow T^{*-}} \operatorname{tr} \tau\left(t, q\left(t, x_{0}\right)\right)=-\infty
$$

we have $\lim _{t \rightarrow T^{*-}}\|\operatorname{tr} \tau\|_{L^{\infty}}=\infty$. Using the Sobolev embedding, we see that

$$
\lim _{t \rightarrow T^{*-}}\|\tau\|_{H^{2}} \geq \lim _{t \rightarrow T^{*-}} C\|\tau\|_{L^{\infty}} \geq \lim _{t \rightarrow T^{*-}} C\|\operatorname{tr} \tau\|_{L^{\infty}}=\infty
$$

Thus, our theorem implies that the $H^{2}$-norm of $\tau$ will blow up in finite time. However, we do not know whether the velocity will blow up or not before $T^{*}$.

Remark 3.2. If $a \neq 0$ and $b>0$, by the same token we have

\frac{d}{d t}(\operatorname{tr} \tau)(t, q(t, x))=-b(\operatorname{tr} \tau)^{2}(t, q(t, x))-a \operatorname{tr} \tau(t, q(t, x)) \leq-\frac{b}{2}(\operatorname{tr} \tau)^{2}(t, q(t, x))+\frac{a^{2}}{2 b}
$$

From the above estimate, we can also obtain a blow up result when the initial data satisfy that $\operatorname{tr} \tau_{0}\left(x_{0}\right)<$ $-\frac{|a|}{b}$.

Remark 3.3. Indeed we can obtain the blow up rate. Since

$$
\frac{d}{d t}(\operatorname{tr} \tau)(t, q(t, x))=-(\operatorname{tr} \tau)^{2}(t, q(t, x))
$$

it follows that

$$
\frac{d}{d t} \frac{1}{\operatorname{tr} \tau(t, q(t, x))}=-1
$$

which yields that $\left.\lim _{t \rightarrow T^{*-}} \operatorname{tr} \tau(t, q(t, x))\right)(T-t)=-1$.

## 4. Proof of the Theorem 1.2

Now we turn our attention to prove the global existence and decay rate of the strong solution with small initial data and $\operatorname{tr} \tau_{0}(x) \geq c_{0}>0$. First, we give the some basic energies and time-weighted energies as follows,

\mathcal{E}_{1}(t)=\sup _{0 \leq s \leq t}\left(\|u(s)\|_{H^{2}\left(\mathbb{T}^{3}\right)}^{2}+\|\tau(s)\|_{H^{2}\left(\mathbb{T}^{3}\right)}^{2}\right)+\int_{0}^{t}\|\nabla u(s)\|_{H^{2}\left(\mathbb{T}^{3}\right)}^{2} d s+\int_{0}^{t}\|\mathbb{P} \operatorname{div} \tau(s)\|_{H^{1}\left(\mathbb{T}^{3}\right)}^{2} d s,  \tag{4.2}\\
\mathcal{E}_{2}(t)=\sup _{0 \leq s \leq t}\left(1+c_{0} s\right)^{3-\epsilon}\left(\left\|\nabla^{2} u(s)\right\|_{L^{2}\left(\mathbb{T}^{3}\right)}^{2}+\|\nabla \mathbb{P} \operatorname{div} \tau(s)\|_{L^{2}\left(\mathbb{T}^{3}\right)}^{2}\right) \\

\lesssim & \mathcal{E}_{1}^{\frac{1}{2}}(t) \mathcal{E}_{2}(t)+c_{0}^{\frac{1}{2}} \mathcal{E}_{1}^{\frac{1}{2}}(t) \mathcal{E}_{2}^{\frac{1}{2}}(t)\left(\mathcal{E}_{4}^{\frac{1}{2}}(t)+\mathcal{E}_{5}^{\frac{1}{2}}(t)\right) .
\end{aligned}

Taking advantage of integration by parts and $\operatorname{div} u=0$, we can compute

\end{array}\right)=\binom{\widehat{N}(t, k)}{\widehat{M}(t, k)}

Then we have the following decomposition for the Fourier transform of ( $u, \mathbb{P} \operatorname{div} \tau$ ) as

\end{equation*}
$$

Finally, we have

$$
\begin{aligned}
& \quad \int_{0}^{t}(1+c s)^{3-\epsilon}\left\|\nabla^{2} \operatorname{tr} \tau(s)\right\|_{L^{2}}^{2} d s \\
& \lesssim c_{0}^{-1}\left(\left\|\nabla^{2} \operatorname{tr} \tau_{0}\right\|_{L^{2}}^{2}+c_{0}^{-2}\left\|\nabla \operatorname{tr} \tau_{0}\right\|_{L^{2}}\left\|\nabla^{2} \operatorname{tr} \tau_{0}\right\|_{L^{2}}^{3}\right) \exp \left(c_{0}^{-\frac{1}{2}} \mathcal{E}_{2}^{\frac{1}{2}}(t)\right) \\
& \quad+c_{0}^{-1}\left\|\nabla \operatorname{tr} \tau_{0}\right\|_{L^{2}}^{2} \exp \left(c_{0}^{-\frac{1}{2}} \mathcal{E}_{2}^{\frac{1}{2}}(t)\right)\left(\mathcal{E}^{\frac{1}{2}}(0)+c_{0}^{-1} \mathcal{E}_{1}^{\frac{1}{2}}(t) \mathcal{E}_{2}^{\frac{1}{2}}(t)+c_{0}^{-\frac{1}{2}} \mathcal{E}_{1}^{\frac{1}{2}}(t) \mathcal{E}_{4}^{\frac{1}{2}}(t)\right) .
\end{aligned}
$$

Combining with the above estimates yields that

$$
\begin{align*}
& \mathcal{E}_{5}(t) \lesssim\left(\tilde{\mathcal{E}}(0)+c_{0}^{-1} \mathcal{E}^{\frac{1}{2}}(0) \tilde{\mathcal{E}}^{\frac{3}{2}}(0)\right) \exp \left(c_{0}^{-\frac{1}{2}} \mathcal{E}_{2}^{\frac{1}{2}}(t)\right)+c_{0}^{-2} \mathcal{E}(0) \exp \left(c_{0}^{-\frac{1}{2}} \mathcal{E}_{2}^{\frac{1}{2}}(t)\right)  \tag{4.31}\\
& \quad \times\left(\mathcal{E}^{\frac{1}{2}}(0)+c_{0}^{-1} \mathcal{E}_{1}^{\frac{1}{2}}(t) \mathcal{E}_{2}^{\frac{1}{2}}(t)+c_{0}^{-\frac{1}{2}} \mathcal{E}_{1}^{\frac{1}{2}}(t) \mathcal{E}_{4}^{\frac{1}{2}}(t)\right)
\end{align*}
$$

### 4.5. Proof of the main theorem

Proof. In this subsection, we will combine the above a priori estimates of $\mathcal{E}_{1}(t), \mathcal{E}_{2}(t), \mathcal{E}_{3}(t), \mathcal{E}_{4}(t)$, $\mathcal{E}_{5}(t)$ together and give the proof of the Theorem 1.2. For any $t \in[0, T]$, we have

$$
\begin{align*}
& \Lambda_{1}(t)=\mathcal{E}_{1}(t)+\mathcal{E}_{2}(t) \\
& \leq C^{*} \mathcal{E}(0)+C c_{0}^{-\frac{1}{2}}\left(\mathcal{E}_{1}^{\frac{3}{2}}(t)+\mathcal{E}_{2}^{\frac{3}{2}}(t)\right)+C c_{0}^{\frac{1}{2}}\left(\mathcal{E}_{1}(t)+\mathcal{E}_{2}(t)\right)\left(\mathcal{E}_{4}^{\frac{1}{2}}(t)+\mathcal{E}_{5}^{\frac{1}{2}}(t)\right)  \tag{4.32}\\
& \quad+C \mathcal{E}_{1}(t)\left(\mathcal{E}_{4}^{\frac{1}{4}}(t) \mathcal{E}_{5}^{\frac{1}{4}}(t)+\mathcal{E}_{5}^{\frac{1}{2}}(t)\right), \\
& \Lambda_{2}(t)=\mathcal{E}_{4}(t) \lesssim c_{0}^{-2} \mathcal{E}(0) \exp \left(c_{0}^{-\frac{1}{2}} \mathcal{E}_{2}^{\frac{1}{2}}(t)\right),  \tag{4.33}\\
& \Lambda_{3}(t)=\mathcal{E}_{5}(t) \lesssim\left(\tilde{\mathcal{E}}(0)+c_{0}^{-1} \mathcal{E}^{\frac{1}{2}}(0) \tilde{\mathcal{E}}^{\frac{3}{2}}(0)\right) \exp \left(c_{0}^{-\frac{1}{2}} \mathcal{E}_{2}^{\frac{1}{2}}(t)\right)+c_{0}^{-2} \mathcal{E}(0) \exp \left(c_{0}^{-\frac{1}{2}} \mathcal{E}_{2}^{\frac{1}{2}}(t)\right)  \tag{4.34}\\
& \quad \times\left(\mathcal{E}^{\frac{1}{2}}(0)+c_{0}^{-1} \mathcal{E}_{1}^{\frac{1}{2}}(t) \mathcal{E}_{2}^{\frac{1}{2}}(t)+c_{0}^{-\frac{1}{2}} \mathcal{E}_{1}^{\frac{1}{2}}(t) \mathcal{E}_{4}^{\frac{1}{2}}(t)\right) .
\end{align*}
$$

Due to the local existence theory, there exists a positive time $T$ such that

$$
\begin{equation*}
\Lambda_{1}(t) \leq 2 C^{*} \delta_{0}^{2}, \quad \Lambda_{2}(t) \leq C^{*}, \quad \Lambda_{3}(t) \leq C^{*}\left(\tilde{\epsilon}_{0}+\delta_{0}^{\frac{1}{2}}\right), \quad \forall t \in[0, T] \tag{4.35}
\end{equation*}
$$

Let $T^{*}$ be the maximal time for what (4.35) holds. Since $\mathcal{E}(0) \leq \delta_{0}^{2} \leq \epsilon_{0}, \tilde{\mathcal{E}}(0) \leq \tilde{\epsilon}_{0}, c_{0}=\frac{1}{2} \delta_{0}$, then it follows that for any $t \in\left[0, T^{*}\right)$

$$
\begin{gathered}
c_{0}^{-\frac{1}{2}}\left(\mathcal{E}_{1}^{\frac{3}{2}}(t)+\mathcal{E}_{2}^{\frac{3}{2}}(t)\right) \lesssim \delta_{0}^{\frac{5}{2}} \\
c_{0}^{\frac{1}{2}}\left(\mathcal{E}_{1}(t)+\mathcal{E}_{2}(t)\right)\left(\mathcal{E}_{4}^{\frac{1}{2}}(t)+\mathcal{E}_{5}^{\frac{1}{2}}(t)\right) \lesssim c_{0}^{\frac{1}{2}}\left(\mathcal{E}_{1}(t)+\mathcal{E}_{2}(t)\right), \\
\mathcal{E}_{1}(t)\left(\mathcal{E}_{4}^{\frac{1}{4}}(t) \mathcal{E}_{5}^{\frac{1}{4}}(t)+\mathcal{E}_{5}^{\frac{1}{2}}(t)\right) \lesssim\left(\tilde{\epsilon}_{0}+\delta_{0}^{\frac{1}{2}}\right)^{\frac{1}{4}} \mathcal{E}_{1}(t), \\
\left(\tilde{\mathcal{E}}(0)+c_{0}^{-1} \mathcal{E}^{\frac{1}{2}}(0) \tilde{\mathcal{E}}^{\frac{3}{2}}(0)\right) \exp \left(c_{0}^{-\frac{1}{2}} \mathcal{E}_{2}^{\frac{1}{2}}(t)\right) \lesssim \tilde{\epsilon}_{0}, \quad \mathcal{E}^{\frac{1}{2}}(0)+c_{0}^{-1} \mathcal{E}_{1}^{\frac{1}{2}}(t) \mathcal{E}_{2}^{\frac{1}{2}}(t)+c_{0}^{-\frac{1}{2}} \mathcal{E}_{1}^{\frac{1}{2}}(t) \mathcal{E}_{4}^{\frac{1}{2}}(t) \lesssim \delta_{0}^{\frac{1}{2}}
\end{gathered}
$$

Under the setting of initial data, there exists small enough numbers $\epsilon_{0}, \tilde{\epsilon}_{0}$ such that $\mathcal{E}(0) \leq \delta_{0}^{2} \leq \epsilon_{0}$, $\tilde{\mathcal{E}}(0) \leq \tilde{\epsilon}_{0}$. By virtue of (4.32), (4.33), (4.34) and the smallness assumption on $\delta_{0}$ and $\tilde{\epsilon}_{0}$, we get that

$$
\begin{gathered}
\Lambda_{1}(t) \leq C^{*} \delta_{0}^{2}+C \delta_{0}^{\frac{5}{2}}+C\left(c_{0}^{\frac{1}{2}}+\left(\tilde{\epsilon}_{0}+\delta_{0}^{\frac{1}{2}}\right)^{\frac{1}{4}}\right) \Lambda_{1}(t)<2 C^{*} \delta_{0}^{2} \\
\Lambda_{2}(t) \leq C<C^{*} \\
\Lambda_{3}(t) \leq C \tilde{\epsilon}_{0}+C \delta_{0}^{\frac{1}{2}}<C^{*}\left(\tilde{\epsilon}_{0}+\delta_{0}^{\frac{1}{2}}\right)
\end{gathered}
$$

By standard continuity argument and total energy (4.32), (4.33), (4.34), we can show that $T^{*}=\infty$ provided that $\delta_{0}$ and $\tilde{\epsilon}_{0}$ is small enough. Moreover, we deduce the time decay estimate for the velocity $u$ and the quantity $P \operatorname{div} \tau$ from (4.28) that

$$
\|u\|_{H^{2}}+\|\mathbb{P} \operatorname{div} \tau\|_{L^{2}} \lesssim(1+t)^{-\frac{3}{2}+\frac{\epsilon}{2}}
$$

Hence, we finish the proof of the Theorem 1.2
