A COMPREHENSIVE SUBCLASS OF ANALYTIC AND BI-UNIVALENT FUNCTIONS ASSOCIATED WITH SUBORDINATION

Abstract. In the present paper, we define a new general subclass of bi-univalent functions involving a differential operator in the open unit disk U. For this purpose, we use the Faber polynomial expansions. Several connections to some of the earlier known results are also pointed out.

1. INTRODUCTION

Let A denote the class of all analytic functions f defined in the open unit disk $\mathbb{U} = \{z \in$ $\mathbb{C}: |z| < 1$ and normalized by the conditions $f(0) = 0$ and $f'(0) = 1$. Thus each $f \in \mathcal{A}$ has a Taylor-Maclaurin series expansion of the form:

$$
f(z) = z + \sum_{n=2}^{\infty} a_n z^n, \ \ (z \in \mathbb{U}).
$$
 (1.1)

Further, let S denote the class of all functions $f \in \mathcal{A}$ which are univalent in U (for details, see [\[10\]](#page-6-0); see also some of the recent investigations [\[3,](#page-6-1) [6,](#page-6-2) [7,](#page-6-3) [8,](#page-6-4) [23\]](#page-6-5)). And let $\mathcal C$ be the class of functions $\Phi(z) = 1 + \sum_{n=1}^{\infty}$ $n=1$ $\Phi_n z^n$ that are analytic in U and satisfy the condition $\text{Re}(\Phi(z)) > 0$ in U. By the Caratheodory's lemma (see [\[10\]](#page-6-0)) we have $|\Phi(z)| \leq 2$.

Let the functions f, g be analytic in U. If there exists a Schwarz function ϖ , is analytic in U under the conditions

$$
\varpi(0) = 0, \ |\varpi(z)| \le 1,
$$

such that

$$
f(z) = g(\varpi(z)), \ z \in \mathbb{U},
$$

then, the function f is subordinate to g in U, and we write $f(z) \prec g(z)$.

The Koebe one-quarter theorem (for details, (see [\[10\]](#page-6-0)), we know that the image of U under every function $f \in \mathcal{A}$ contains a disk of radius $\frac{1}{4}$. According to this, every function $f \in \mathcal{A}$ has an inverse map f^{-1} that satisfies the following conditions:

$$
f^{-1}(f(z)) = z \quad (z \in \mathbb{U}),
$$

and

$$
f(f^{-1}(w)) = w \quad (|w| < r_0(f); r_0(f) \ge \frac{1}{4}).
$$

In fact, the inverse function is given by

$$
g(w) = f^{-1}(w) = w - a_2w^2 + (2a_2^2 - a_3)w^3 - (5a_2^3 - 5a_2a_3 + a_4)w^4 + \cdots
$$
 (1.2)

A function $f \in \mathcal{A}$ is said to be bi-univalent in U if both $f(z)$ and $f^{-1}(z)$ are univalent in U. Let Σ denote the class of bi-univalent functions in U given by [\(1.1\)](#page-0-0). Examples of functions in the class Σ are

$$
\frac{z}{1-z}, -\log(1-z), \ \frac{1}{2}\log\left(\frac{1+z}{1-z}\right), \cdots.
$$

It is worth noting that the familiar Koebe function is not a member of Σ , since it maps the unit disk U univalently onto the entire complex plane except the part of the negative real axis from $-1/4$ to $-\infty$. Thus, clearly, the image of the domain does not contain the unit disk U. For a brief history and some intriguing examples of functions and characterization of the class Σ , see Srivastava et al. [\[20\]](#page-6-6), Yousef et al. [\[24,](#page-6-7) [25,](#page-6-8) [26\]](#page-7-0), and Frasin and Aouf [\[12\]](#page-6-9).

In 1967, Lewin [\[18\]](#page-6-10) investigated the bi-univalent function class Σ and showed that $|a_2| < 1.51$. Subsequently, Brannan and Clunie [\[9\]](#page-6-11) conjectured that $|a_2| \leq \sqrt{2}$. On the other hand, Netanyahu [\[19\]](#page-6-12) showed that $\max_{f \in \Sigma} |a_2| = \frac{4}{3}$ $\frac{4}{3}$. The best known estimate for functions in Σ has been obtained in 1984 by Tan [\[21\]](#page-6-13), that is, $|a_2|$ < 1.485. The coefficient estimate problem for each of the following Taylor-Maclaurin coefficients $|a_n|$ $(n \in \mathbb{N} \setminus \{1, 2\})$ for each $f \in \Sigma$ given by [\(1.1\)](#page-0-0) is presumably still an open problem.

The Faber polynomials introduced by Faber [\[11\]](#page-6-14) play an important role in various areas of mathematical sciences, especially in geometric function theory. The recent publications [\[13\]](#page-6-15) and [\[14\]](#page-6-16) applying the Faber polynomial expansions to meromorphic bi-univalent functions motivated us to apply this technique to classes of analytic bi-univalent functions. In the literature, there are only a few works determining the general coefficient bounds $|a_n|$ for the analytic bi-univalent functions given by [\(1.1\)](#page-0-0) using Faber polynomial expansions (see for example, [\[15,](#page-6-17) [16,](#page-6-18) [17\]](#page-6-19)). Hamidi and Jahangiri [\[15\]](#page-6-17) considered the class of analytic bi-close-to-convex functions. Jahangiri and Hamidi [\[17\]](#page-6-19) considered the class defined by Frasin and Aouf [\[12\]](#page-6-9), and Jahangiri et al. [\[16\]](#page-6-18) considered the class of analytic bi-univalent functions with positive real-part derivatives.

2. THE CLASS $\mathfrak{B}_{\Sigma}(\mu, \lambda, \Phi, \xi)$

Yousef et al. [\[25\]](#page-6-8) have introduced and studied the following subclass of analytic biunivalent functions:

Definition 2.1. For $\lambda \geq 1$, $\mu \geq 0$, $\delta \geq 0$ and $0 \leq \alpha < 1$, a function $f \in \Sigma$ given by [\(1.1\)](#page-0-0) is said to be in the class $\mathfrak{B}_{\Sigma}^{\mu}$ $\mathcal{L}_{\Sigma}(\alpha,\lambda,\delta)$ if the following conditions hold for all $z, w \in \mathbb{U}$:

$$
\operatorname{Re}\left((1-\lambda)\left(\frac{f(z)}{z}\right)^{\mu} + \lambda f'(z)\left(\frac{f(z)}{z}\right)^{\mu-1} + \xi \delta z f''(z)\right) > \alpha \tag{2.1}
$$

and

$$
\operatorname{Re}\left((1-\lambda)\left(\frac{g(w)}{w}\right)^{\mu} + \lambda g'(w)\left(\frac{g(w)}{w}\right)^{\mu-1} + \xi \delta w g''(w)\right) > \alpha, \tag{2.2}
$$

where the function $g(w) = f^{-1}(w)$ is defined by [\(1.2\)](#page-1-0) and $\xi = \frac{2\lambda + \mu}{2\lambda + 1}$.

Using the Faber polynomial expansion of functions $f \in \mathcal{A}$ of the form [\(1.1\)](#page-0-0), the coefficients of its inverse map $g = f^{-1}$ may be expressed as in [\[1\]](#page-6-20):

$$
g(w) = f^{-1}(w) = w + \sum_{n=2}^{\infty} \frac{1}{n} K_{n-1}^{-n} (a_2, a_3, ...) w^n,
$$
\n(2.3)

where

$$
K_{n-1}^{-n} = \frac{(-n)!}{(-2n+1)!(n-1)!} a_2^{n-1} + \frac{(-n)!}{(2(-n+1))!(n-3)!} a_2^{n-3} a_3 + \frac{(-n)!}{(-2n+3)!(n-4)!} a_2^{n-4} a_4
$$

+
$$
\frac{(-n)!}{(2(-n+2))!(n-5)!} a_2^{n-5} \left[a_5 + (-n+2) a_3^2\right] + \frac{(-n)!}{(-2n+5)!(n-6)!} a_2^{n-6}
$$

$$
\left[a_6 + (-2n+5) a_3 a_4\right] + \sum_{j \ge 7} a_2^{n-j} V_j,
$$
\n(2.4)

such that V_j with $7 \leq j \leq n$ is a homogeneous polynomial in the variables $a_2, a_3, ..., a_n$ [\[2\]](#page-6-21).

In particular, the first three terms of K_{n-1}^{-n} are

$$
K_1^{-2} = -2a_2, K_2^{-3} = 3(2a_2^2 - a_3), K_3^{-4} = -4(5a_2^3 - 5a_2a_3 + a_4).
$$
 (2.5)

In general, for any $p \in \mathbb{N} := \{1, 2, 3, ...\}$, an expansion of K_n^p is as in [\[1\]](#page-6-20),

$$
K_n^p = pa_n + \frac{p(p-1)}{2}D_n^2 + \frac{p!}{(p-3)!3!}D_n^3 + \dots + \frac{p!}{(p-n)!n!}D_n^n,\tag{2.6}
$$

where $D_n^p = D_n^p(a_2, a_3, ...)$, and by [\[22\]](#page-6-22), $D_n^m(a_1, a_2, ..., a_n) = \sum_{n=1}^{\infty}$ $n=1$ $m!$ $\frac{m!}{i_1!...i_n!}a_1^{i_1}$ $i_1^{i_1}...a_n^{i_n}$ while $a_1 = 1$, and the sum is taken over all non-negative integers $i_1, ..., i_n$ satisfying $i_1 + i_2 + ... + i_n = m$, $i_1 + 2i_2 + \cdots + ni_n = n$, it is clear that $D_n^m(a_1, a_2, ..., a_n) = a_1^n$.

Now, we are ready to establish a new subclass of analytic and bi-univalent functions based on subordination.

Definition 2.2. For $\lambda \geq 1$, $\mu \geq 0$, and $\delta \geq 0$, A function $f \in \Sigma$ is said to be in the class $\mathfrak{B}_{\Sigma}(\mu, \lambda, \Phi, \xi)$, if the following subordinations are satisfied:

$$
(1 - \lambda) \left(\frac{f(z)}{z}\right)^{\mu} + \lambda f'(z) \left(\frac{f(z)}{z}\right)^{\mu - 1} + \xi \delta z f''(z) \prec \Phi(z)
$$
 (2.7)

and

$$
(1 - \lambda) \left(\frac{g(w)}{w}\right)^{\mu} + \lambda g'(w) \left(\frac{g(w)}{w}\right)^{\mu - 1} + \xi \delta w g''(w) \prec \Phi(w) \tag{2.8}
$$

where the function $g(w) = f^{-1}(w)$ is defined by [\(1.2\)](#page-1-0) and $\xi = \frac{2\lambda + \mu}{2\lambda + 1}$.

3. COEFFICIENT BOUNDS FOR THE FUNCTION CLASS $\mathfrak{B}_{\Sigma}(\mu, \lambda, \Phi, \xi)$

Theorem 3.1. For $\lambda \geq 1$, $\mu \geq 0$, and $\delta \geq 0$, let the function $f \in \mathfrak{B}_{\Sigma}(\mu, \lambda, \Phi, \xi)$ be given by (1.1) . Then

$$
|a_2| \le \min\left\{\frac{2}{\mu + \lambda + 2\xi\delta}, \sqrt{\frac{8}{(\mu + 2\lambda + 6\xi\delta)(\mu + 1)}}\right\}
$$

and

$$
|a_3| \le \min \left\{ \frac{\frac{1}{\left(1+\frac{6\delta}{2\lambda+1}\right)} \left[\frac{4}{\left(\mu+\lambda+2\xi\delta\right)^2} + \frac{2}{\left(\mu+2\lambda+6\xi\delta\right)}\right], \frac{1}{\left(1+\frac{6\delta}{2\lambda+1}\right)} \left[\frac{8}{\left(\mu+2\lambda+6\xi\delta\right)\left(\mu+1\right)} + \frac{2}{\left(\mu+2\lambda+6\xi\delta\right)}\right] \right\}.
$$

Proof. Let $\mathfrak{B}_{\Sigma}(\mu, \lambda, \Phi, \xi)$. The inequalities [\(2.7\)](#page-3-0) and [\(2.8\)](#page-3-1) imply the existence of two positive real part functions

$$
\varpi(z) = 1 + \sum_{n=1}^{\infty} t_n z^n
$$

and

$$
\varphi(w) = 1 + \sum_{n=1}^{\infty} s_n z^n
$$

where $\text{Re}(\varpi(z)) > 0$ and $\text{Re}(\varphi(w)) > 0$ in C so that

$$
(1 - \lambda) \left(\frac{f(z)}{z}\right)^{\mu} + \lambda f'(z) \left(\frac{f(z)}{z}\right)^{\mu - 1} + \xi \delta z f''(z) = \Phi\left(\varpi(z)\right),\tag{3.1}
$$

$$
(1 - \lambda) \left(\frac{g(w)}{w}\right)^{\mu} + \lambda g'(w) \left(\frac{g(w)}{w}\right)^{\mu - 1} + \xi \delta w g''(w) = \Phi\left(\varphi(w)\right). \tag{3.2}
$$

It follows from [\(3.1\)](#page-3-2) and [\(3.2\)](#page-3-3) that

$$
(\mu + \lambda + 2\xi \delta) a_2 = \Phi_1 t_1 \tag{3.3}
$$

$$
(\mu + 2\lambda + 6\xi)\left[\frac{\mu - 1}{2}a_2^2 + \left(1 + \frac{6\delta}{2\lambda + 1}\right)a_3\right] = \Phi_1 t_2 + \Phi_2 t_1^2,\tag{3.4}
$$

and

$$
-(\mu + \lambda) a_2 = \Phi_1 s_1, \tag{3.5}
$$

$$
(\mu + 2\lambda + 6\xi)\left[\frac{\mu + 3}{2}a_2^2 - \left(1 + \frac{6\delta}{2\lambda + 1}\right)a_3\right] = \Phi_1 s_2 + \Phi_2 s_1^2. \tag{3.6}
$$

From (3.3) and (3.5) , we find

$$
|a_2| \le \frac{|\Phi_1 t_1|}{\mu + \lambda + 2\xi\delta} = \frac{|\Phi_1 s_1|}{\mu + \lambda + 2\xi\delta} \le \frac{2}{\mu + \lambda + 2\xi\delta}.
$$
 (3.7)

From (3.4) and (3.6) , we get

$$
(\mu + 2\lambda + 6\xi)\left(\mu + 1\right)a_2^2 = \Phi_1(t_2 + s_2) + \Phi_2\left(t_1^2 + s_1^2\right)
$$

or, equivalently

$$
|a_2| \le \sqrt{\frac{8}{\left(\mu + 2\lambda + 6\xi\delta\right)\left(\mu + 1\right)}}.\tag{3.8}
$$

Next, in order to find the bound on the coefficient $|a_3|$, we subtract [\(3.6\)](#page-4-0) from [\(3.4\)](#page-3-6). We thus get

$$
2\left(\mu + 2\lambda + 6\xi\delta\right) \left[\left(1 + \frac{6\delta}{2\lambda + 1}\right) a_3 - a_2^2 \right] = \Phi_1 \left(t_2 - s_2\right) + \Phi_2 \left(t_1^2 - s_1^2\right) \tag{3.9}
$$

or

$$
|a_3| \le \frac{1}{\left(1 + \frac{6\delta}{2\lambda + 1}\right)} \left[|a_2|^2 + \frac{|\Phi_1(t_2 - s_2)|}{2(\mu + 2\lambda + 6\xi\delta)} \right]
$$
\n
$$
= \frac{1}{\left(1 + \frac{6\delta}{2\lambda + 1}\right)} \left[|a_2|^2 + \frac{2}{(\mu + 2\lambda + 6\xi\delta)} \right].
$$
\n(3.10)

Upon substituting the value of a_2^2 from (3.7) and (3.8) into (3.10) , it follows that

$$
|a_3| \le \frac{1}{\left(1 + \frac{6\delta}{2\lambda + 1}\right)} \left[\frac{4}{\left(\mu + \lambda + 2\xi\delta\right)^2} + \frac{2}{\left(\mu + 2\lambda + 6\xi\delta\right)}\right]
$$

and

$$
|a_3| \le \frac{1}{\left(1 + \frac{6\delta}{2\lambda + 1}\right)} \left[\frac{8}{\left(\mu + 2\lambda + 6\xi\delta\right)\left(\mu + 1\right)} + \frac{2}{\left(\mu + 2\lambda + 6\xi\delta\right)} \right]
$$

Which completes the proof of [3.1.](#page-3-7) \Box

Theorem 3.2. Let $\mathfrak{B}_{\Sigma}(\mu, \lambda, \Phi, \xi)$. If $a_m = 0$ with $2 \le m \le n - 1$, then

$$
|a_n| \le \frac{2}{\mu + (n-1)\lambda + n(n-1)\xi\delta} \ (n \ge 4). \tag{3.11}
$$

Proof. By using the Faber polynomial expansion of functions $f \in \mathcal{A}$ of the form [\(1.1\)](#page-0-0) and its inverse map $g = f^{-1}$, we can write

$$
(1 - \lambda) \left(\frac{f(z)}{z}\right)^{\mu} + \lambda f'(z) \left(\frac{f(z)}{z}\right)^{\mu - 1} + \xi \delta z f''(z) = 1 + \sum_{n=2}^{\infty} F_{n-1}(a_2, a_3, ..., a_n) z^{n-1}
$$
(3.12)

and

$$
(1 - \lambda) \left(\frac{g(w)}{w}\right)^{\mu} + \lambda g'(w) \left(\frac{g(w)}{w}\right)^{\mu - 1} + \xi \delta w g''(w) = 1 + \sum_{n=2}^{\infty} F_{n-1}(A_2, A_3, ..., A_n) w^{n-1}
$$
\n(3.13)

where

$$
F_1 = (\mu + \lambda + 2\xi \delta)a_2, \ F_2 = (\mu + 2\lambda + 6\xi \delta) \left[\frac{\mu - 1}{2} a_2^2 + \left(1 + \frac{6\delta}{2\lambda + 1} \right) a_3 \right]
$$
(3.14)

and, in general (see [\[5\]](#page-6-23))

$$
F_{n-1}(a_2, a_3, ..., a_n) = [\mu + (n-1)\lambda + n(n-1)\xi\delta] \times [(\mu-1)!]
$$
\n(3.15)

$$
\times \left[\sum_{n=2}^{\infty} \frac{a_2^{i_1} a_3^{i_2} \dots a_n^{i_{n-1}}}{i_1! i_2! \cdots i_n! \left[\mu - (i_1 + i_2 + \cdots + i_{n-1}) \right]!} \right] \tag{3.16}
$$

Next, by using the Faber polynomial expansion of functions $\varpi, \varphi \in \mathcal{C}$, we also obtain

$$
\Phi\left(\varpi(z)\right) = 1 + \sum_{n=1}^{\infty} \sum_{k=1}^{\infty} \Phi_n F_n^k\left(t_1, t_2, ..., t_n\right) z^n, \tag{3.17}
$$

and

$$
\Phi\left(\varphi(z)\right) = 1 + \sum_{n=1}^{\infty} \sum_{k=1}^{\infty} \Phi_n F_n^k\left(s_1, s_2, ..., s_n\right) w^n.
$$
\n(3.18)

Comparing the corresponding coefficients yields

$$
[\mu + (n-1)\lambda + n(n-1)\xi\delta] a_n = \sum_{k=1}^{n-1} \Phi_n F_{n-1}^k(t_1, t_2, ..., t_{n-1}) \quad (n \ge 2)
$$

and

$$
\left[\mu + (n-1)\lambda + n\left(n-1\right)\xi\delta\right]A_n = \sum_{k=1}^{n-1} \Phi_n F_{n-1}^k\left(s_1, s_2, ..., s_{n-1}\right) \ (n \ge 2). \tag{3.19}
$$

Note that for $a_m = 0, 2 \le m \le n - 1$, we have $A_n = -a_n$ and so

$$
[\mu + (n - 1)\lambda + n (n - 1)\xi\delta] a_n = \Phi_1 t_{n-1},
$$

-
$$
[\mu + (n - 1)\lambda + n (n - 1)\xi\delta] a_n = \Phi_1 s_{n-1},
$$
(3.20)

Now taking the absolute values of either of the above two equations and using the facts that $|\Phi_1| \leq 2$, $|t_{n-1}| \leq 1$, and $|s_{n-1}| \leq 1$, we obtain

$$
|a_n| \le \frac{|\Phi_1 t_{n-1}|}{\mu + (n-1)\lambda + n(n-1)\xi\delta} = \frac{|\Phi_1 s_{n-1}|}{\mu + (n-1)\lambda + n(n-1)\xi\delta}
$$
(3.21)

$$
\leq \frac{2}{\mu + (n-1)\lambda + n(n-1)\xi\delta} \tag{3.22}
$$

This evidently completes the proof of [3.2.](#page-4-4) \Box

Remark 3.3. As a final remark, for $\delta = 0$ in

- (i) Theorem [3.1](#page-3-7) we obtain Theorem 1 in [\[4\]](#page-6-24).
- (ii) Theorem [3.2](#page-4-4) we obtain Theorem 2 in [\[4\]](#page-6-24).
