JUMP FORMULAS FOR SINGULAR INTEGRALS AND LAYER POTENTIALS ON RECTIFIABLE SETS

XAVIER TOLSA

ABSTRACT. In this paper the jump formulas for the double layer potential and other singular integrals are proved for arbitrary rectifiable sets, by defining suitable non-tangential limits. The arguments are quite straightforward and only require some Calderón-Zygmund techniques.

1. Introduction

Let $K: \mathbb{R}^{n+1} \to \mathbb{R}$ (or $K: \mathbb{R}^{n+1} \to \mathbb{R}^{n+1}$) be an odd Calderón-Zygmund kernel of homogeneity -n. That is, K satisfies the estimate

$$(1.1) |K(x)| \le \frac{C}{|x|^n} \text{for } x \ne 0,$$

and there exists some $\eta > 0$ such that

(1.2)
$$|K(x) - K(x+y)| \le C \frac{|y|^{\eta}}{|x|^{\eta+\eta}} \quad \text{if } |y| \le \frac{1}{2}|x|,$$

and moreover K is of the form $K(x) = \frac{\Omega(x)}{|x|^n}$, with $\Omega : \mathbb{R}^{n+1} \to \mathbb{R}^{n+1}$ being homogeneous of degree 0. Given a signed Radon measure ν in \mathbb{R}^{n+1} we denote

$$T\nu(x) = \int K(x-y) \, d\nu(y),$$

whenever the integral makes sense, and for $\varepsilon > 0$

$$T_{\varepsilon}\nu(x) = \int_{|x-y|>\varepsilon} K(x-y) \, d\nu(y)$$

and also

$$T_*\nu(x) = \sup_{\varepsilon>0} |T_{\varepsilon}\nu(x)$$
 and $\operatorname{pv} T\nu(x) = \lim_{\varepsilon\to0} T_{\varepsilon}\nu(x)$,

whenever the last limit exists.

Given a positive Radon measure μ , we consider the operators T_{μ} , $T_{\mu,\varepsilon}$, $T_{\mu,*}$ defined by

$$T_{\mu}f = T(f\mu), \qquad T_{\mu,\varepsilon}f = T_{\varepsilon}(f\mu), \qquad T_{\mu,*}f = T_{*}(f\mu),$$

for $f \in L^1_{loc}(\mu)$. As usual, one says that T_{μ} is bounded in $L^p(\mu)$ if the operators $T_{\mu,\varepsilon}$ are bounded in $L^p(\mu)$ uniformly on $\varepsilon > 0$. Analogously, T is bounded from the space of (signed) finite Radon measures $M(\mathbb{R}^{n+1})$ to $L^{1,\infty}(\mu)$ if the operators T_{ε} are bounded from $M(\mathbb{R}^{n+1})$

to $L^{1,\infty}(\mu)$ uniformly on $\varepsilon > 0$. That is, there exists some constant C such that for all $\nu \in M(\mathbb{R}^{n+1})$, all $\varepsilon > 0$, and all $\lambda > 0$,

$$\mu(\left\{x \in \mathbb{R}^{n+1} : |T_{\varepsilon}\nu(x)| > \lambda\right\}) \le C \frac{\|\nu\|}{\lambda}.$$

Recall that if μ satisfies the polynomial growth condition

$$\mu(B(x,r)) \le C r^n$$
 for all $x \in \mathbb{R}^{n+1}$, $r > 0$,

then the $L^2(\mu)$ boundedness of T_{μ} implies the $L^p(\mu)$ boundedness of T_{μ} and $T_{\mu,*}$ for $1 , and also the boundedness from <math>M(\mathbb{R}^{n+1})$ to $L^{1,\infty}(\mu)$, by results essentially due to Nazarov, Treil and Volberg in the non-doubling setting (see Chapter 2 of [To2], for example).

A set $E \subset \mathbb{R}^{n+1}$ is called *n*-rectifiable if there is a collection of *n*-dimensional Lipschitz (possibly rotated) graphs $\Gamma_k \subset \mathbb{R}^{n+1}$ such that

$$\mathcal{H}^n\Big(E\setminus\bigcup_{k\geq 1}\Gamma_k\Big)=0.$$

An equivalent definition (that will be used below) is obtained if the graphs are required to be C^1 and with maximal slope as close to 0 as wished.

As shown by Mas [Ma], for any *n*-rectifiable set $E \subset \mathbb{R}^{n+1}$ and any measure $\nu \in M(\mathbb{R}^{n+1})$, if the kernel K is odd and C^2 away from the origin and satisfies

(1.3)
$$|\nabla^{j}K(x)| \leq \frac{C}{|x|^{n+j}}$$
 for $j = 0, 1, 2$ and $x \neq 0$,

then pv $T\nu(x)$ exists for \mathcal{H}^n -a.e. $x \in E$. Previously, under the same assumptions in [To1] it was proved that if μ is uniformly n-rectifiable, then T_{μ} is bounded in $L^2(\mu)$. Under stronger smoothness conditions on the kernel, this had been proved previously by David and Semmes [DS].

In this paper we will see how one can prove a very general form of the jump formulas (also known as Plemelj formulas in the case of the Cauchy transform) for the operators described above. Recall that these formulas play an important role in the solution of the Dirichlet problem by the method of layer potentials. To state precisely our results we need to introduce some additional notation. For a point $x \in \mathbb{R}^{n+1}$, a unit vector u, and an aperture parameter $a \in (0,1)$ we consider the one sided cone with axis in the direction of u defined by

$$X_a(x, u) = \{ y \in \mathbb{R}^{n+1} : (y - x) \cdot u > a|y - x| \}.$$

We say that E has a classical tangent n-plane at $x \in E$ if there exists a unit vector u such that, for all $a \in (0,1)$, there exists some $r_0 > 0$ such that

$$E \cap (X_a(x,u) \cup X_a(x,-u)) \cap B(x,r) = \emptyset$$
 for $0 < r \le r_0$.

The n-plane L orthogonal to u through x is called a (classical) tangent n-plane at x.

We say that E has an approximate tangent n-plane at $x \in E$ if there exists a unit vector u such that, for all $a \in (0,1)$,

$$\lim_{r \to 0} \frac{\mathcal{H}^n \left(E \cap \left(X_a(x, u) \cup X_a(x, -u) \right) \cap B(x, r) \right)}{r^n} = 0.$$

The n-plane L orthogonal to u through x is called approximate tangent n-plane.

If $\mathcal{H}^n(E) < \infty$ (or $\mathcal{H}^n|_E$ is locally finite) and E is n-rectifiable, it is well known that there is a unique approximate tangent n-plane at \mathcal{H}^n -a.e. $x \in E$. We denote by L_x the approximate tangent n-plane at x and by N_x a unit vector orthogonal to L_x . We also write

$$X_a^+(x) = X_a(x, N_x), \qquad X_a^-(x) = X_a(x, -N_x), \qquad X_a(x) = X_a^+(x) \cup X_a^-(x).$$

As mentioned above, the *n*-plane L_x is uniquely defined for \mathcal{H}^n -a.e. $x \in E$. On the other hand, for \mathcal{H}^n -a.e. $x \in E$ there are two possible choices for N_x , depending on the sense of the normal to L_x that one chooses. For us, the choice $x \mapsto N_x$ does not matter as soon as it is \mathcal{H}^n -measurable (or Borel, say if E is Borel). Notice that any $y \in X_a^+(x) \cup X_a^-(x)$ satisfies

$$dist(y, L_x) > a |y - x| > 0.$$

Fix $b \in (0, a)$, so that $\bar{B}(y, b|y - x|) \cap L_x = \emptyset$ for all $y \in X_a^+(x) \cup X_a^-(x)$. We define the non-tangential limits

(1.4)
$$T^{+}\nu(x) = \lim_{X_{a}^{+}(x)\ni y\to x} T_{b|x-y|}\nu(y), \qquad T^{-}\nu(x) = \lim_{X_{a}^{-}(x)\ni y\to x} T_{b|x-y|}\nu(y),$$

whenever they exist. Note that we use the truncated operators $T_{b|x-y|}$ in these definitions, which may appear rather unusual.

Our main result is the following.

Theorem 1.1. Let T be the operator associated with an odd Calderón-Zygmund kernel of homogeneity -n satisfying (1.3), C^2 away from the origin. Let $E \subset \mathbb{R}^{n+1}$ be an n-rectifiable set and let $\nu \in M(\mathbb{R}^{n+1})$. For fixed $a \in (0,1)$ and $b \in (0,a)$ as above, the non-tangential limits $T^+\nu(x)$ and $T^-\nu(x)$ exist \mathcal{H}^n -a.e. $x \in E$ and moreover the following identities hold \mathcal{H}^n -a.e. $x \in E$ too:

(1.5)
$$\frac{1}{2} (T^{+} \nu(x) + T^{-} \nu(x)) = \operatorname{pv} T \nu(x),$$

and

(1.6)
$$\frac{1}{2} (T^{+} \nu(x) - T^{-} \nu(x)) = C_K(N_x) f(x),$$

where f is the density

$$f(x) = \frac{d\nu}{d\mathcal{H}^n|_E}(x),$$

and $C_K(N_x)$ is defined by

(1.7)
$$C_K(N_x) = \int_{L(N_x)} \frac{\Omega(y + N_x) - \Omega(y - N_x)}{2(|y|^2 + 1)^{n/2}} d\mathcal{H}^n(y),$$

where $L(N_x)$ is the hyperplane orthogonal to N_x through the origin.

Some remarks are in order:

• Write $\nu = \nu_{abs} + \nu_s$, where ν_{abs} is absolutely continuous with respect to $\mathcal{H}^n|_E$ and ν_s is singular with respect to $\mathcal{H}^n|_E$. Then, for \mathcal{H}^n -a.e. $x \in E$,

$$\frac{d\nu}{d\mathcal{H}^n|_E}(x) = \frac{d\nu_{abs}}{d\mathcal{H}^n|_E}(x).$$

• If E has a classical tangent n-plane at x and supp $\nu \subset E$, then

(1.8)
$$T^{+}\nu(x) = \lim_{X_{a}^{+}(x)\ni y\to x} T\nu(y), \qquad T^{-}\nu(x) = \lim_{X_{a}^{-}(x)\ni y\to x} T\nu(y),$$

because, for any r > 0 small enough, $\bar{B}(y, b|x - y|) \cap E = \emptyset$ for all $y \in X_a(x) \cap B(x, r)$ and thus $T_{b|x-y|}\nu(y) = T\nu(y)$. The identities in (1.8) may fail (even at \mathcal{H}^n -a.e. $x \in E$) if there is not a classical tangent. It is not difficult to construct an example showing this.

Notice that if E is n-AD regular and rectifiable, then any approximate tangent n-plane is also a classical tangent n-plane.

- Theorem 1.1 is also valid for any operator T associated with a kernel satisfying (1.1) and (1.2), assuming that for any n-dimensional Lipschitz graph Γ (possibly rotated) the operator $T_{\mathcal{H}^n|_{\Gamma}}$ is bounded in $L^2(\mathcal{H}^n|_{\Gamma})$ and that pv $T\mathcal{H}^n|_{\Gamma\cap E}$ exists \mathcal{H}^n -a.e. in Γ for all $E \subset \Gamma$ with $\mathcal{H}^n(E) < \infty$.
- If $T_{\mathcal{H}^n|_E}$ is bounded in $L^2(\mathcal{H}^n|_E)$, then the jump formulas (1.5) and (1.6) can be extended to any $f \in L^p(\mathcal{H}^n|_E)$, $1 \leq p < \infty$, by very standard arguments, just by replacing ν by $f \mathcal{H}^n|_E$.
- Theorem 1.1 can be extended to n-rectifiable sets $E \subset \mathbb{R}^d$ with n < d 1. In this case, given an approximate tangent n-plane L_x at $x \in E$, there are infinitely many unit vectors orthogonal to L_x . Then we just fix one such vector N_x , we define $X_a(x, N_x)$ as above and we denote

$$X_a(x, N_x, L_x) = X_a(x, N_x) \cap [L_x, N_x],$$

where $[L_x, N_x]$ is the affine (n+1)-plane that contains L_x and $x + N_x$. We set

$$X_a^+(x) = X_a(x, N_x, L_x), \qquad X_a^-(x) = X_a(x, -N_x, L_x),$$

and define $T^+\nu(x)$, $T^-\nu(x)$ as in (1.4). Then Theorem 1.1 still holds, with the same proof essentially, with the integral in (1.7) over the *n*-plane parallel to L_x through the origin.

• When K is the n-dimensional Riesz kernel, i.e.,

$$K(x) = \frac{x}{|x|^{n+1}}, \qquad \Omega(x) = \frac{x}{|x|},$$

for all $y \in L(N_x)$ we have

$$\Omega(y + N_x) - \Omega(y - N_x) = \frac{y + N_x}{|y + N_x|} - \frac{y - N_x}{|y - N_x|} = \frac{2N_x}{(|y|^2 + 1)^{1/2}}$$

and thus

$$C_K(N_x) = \int_{L(N_x)} \frac{N_x}{(|y|^2 + 1)^{(n+1)/2}} d\mathcal{H}^n(y)$$

$$= N_x \int_{\mathbb{R}^n} \frac{1}{(|y|^2 + 1)^{(n+1)/2}} d\mathcal{H}^n(y) = \frac{\pi^{(n+1)/2}}{\Gamma(\frac{n+1}{2})} N_x = \frac{\omega_n}{2} N_x,$$

where we assumed \mathcal{H}^n to be defined so that it coincides with *n*-dimensional Lebesgue measure in \mathbb{R}^n and ω_n is the *n*-dimensional volume of the unit sphere in \mathbb{R}^{n+1} .

So in the case of the double layer potential, defined by

$$R_{\mathcal{H}^n|_E} f(x) = \frac{1}{\omega_n} \int \frac{x - y}{|x - y|^{n+1}} N_y f(y) d\mathcal{H}^n|_E,$$

by applying (1.5) and (1.6) to the vectorial measure $f(y) N_y d\mathcal{H}^n|_{E}(y)$, it follows that

$$\frac{1}{2} \left(R_{\mathcal{H}^n|_E}^+ f(x) + R_{\mathcal{H}^n|_E}^- f(x) \right) = \text{pv } R_{\mathcal{H}^n|_E} f(x),$$

and

$$\frac{1}{2} \left(R_{\mathcal{H}^n|_E}^+ f(x) - R_{\mathcal{H}^n|_E}^- f(x) \right) = \frac{1}{2} N_x \cdot N_x f(x) = \frac{1}{2} f(x)$$

for \mathcal{H}^n -a.e. $x \in E$.

• For an odd integer $j \geq 1$, consider the kernel K in the complex plane defined by

$$K(z) = \frac{z^j}{|z|^{j+1}}, \qquad \Omega(z) = \frac{z^j}{|z|^j},$$

for $z \in \mathbb{C} \setminus \{0\}$. Then we have, for $z \in L(N_x)$,

$$\Omega(z+N_x) - \Omega(z-N_x) = \frac{(z+N_x)^j - (z-N_x)^j}{(|z|^2+1)^{j/2}} = N_x^j \frac{\left(\frac{z}{N_x}+1\right)^j - \left(\frac{z}{N_x}-1\right)^j}{(|z|^2+1)^{j/2}}$$

Hence, using the change of variable given by the rotation $y = z/(iN_x)$ (which transforms L_{N_x} into \mathbb{R}), we obtain

$$C_K(N_x) = \int_{\mathbb{R}} N_x^j \frac{(iy+1)^j - (iy-1)^j}{2(y^2+1)^{(j+1)/2}} dy = \frac{(iN_x)^j}{2} \int_{\mathbb{R}} \frac{(y-i)^j - (y+i)^j}{(y-i)^{(j+1)/2}(y+i)^{(j+1)/2}} dy$$
$$= \frac{(iN_x)^j}{2} \int_{\mathbb{R}} \left(\frac{(y-i)^{(j-1)/2}}{(y+i)^{(j+1)/2}} - \frac{(y+i)^{(j-1)/2}}{(y-i)^{(j+1)/2}} \right) dy.$$

By the residue theorem, it is easy to check that the last integral equals $2\pi i$, and thus

$$C_K(N_x) = \pi i^{j+1} N_x^j = (-1)^{(j+1)/2} \pi N_x^j.$$

Some of the known proofs of the jump formulas for the Cauchy and Riesz transforms suggest that one needs to use complex analysis or Clifford analysis to deduce them (see [To2] or [HMT], for example), and E has to coincide with the boundary of a "reasonable" domain. For example, in [HMT] the authors ask these domains to have locally finite perimeter and their boundaries to be uniformly rectifiable. The proof of Theorem 1.1 in the present paper is of real variable nature and avoids such assumptions. I think that this approach is rather elementary and has its own interest, even in the case when one asks E to be as in [HMT] and the result is not new.

An important tool for the proof of Theorem 1.1 is the boundedness of the maximal singular integrals from $M(\mathbb{R}^{n+1})$ to $L^{1,\infty}(\mu)$, which allows an easy reduction of the proof to the case where E is a subset of a C^1 graph. As far as I know, the idea of using the boundedness from $M(\mathbb{R}^{n+1})$ to $L^{1,\infty}(\mu)$ in connection with principal values for singular integrals stems from a paper from Mattila and Melnikov [MM] on the existence of principal values for the Cauchy transform. See [To2, Chapter 8] for a more modern exposition of such techniques.

2. Proof of Theorem 1.1

In the arguments below we allow all the implicit constants in the relation \lesssim to depend on the Calderón-Zygmund constants of the kernel and also on the aperture parameter a and on the constant b.

To prove the theorem we can assume that E is a compact subset of a C^1 (possibly rotated) graph $\Gamma \subset \mathbb{R}^{n+1}$ with slope at most 1/10. Further, it is enough to prove that for, \mathcal{H}^n -a.e. $x \in E$,

(2.1)
$$\lim_{X_a^+(x)\ni y\to x} \left(T_{b|x-y|}\nu(y) + T_{b|x-y|}\nu(2x-y) \right) = 2 \operatorname{pv} T\nu(x),$$

and that

(2.2)
$$\lim_{X_a^+(x)\ni y\to x} \left(T_{b|x-y|}\nu(y) - T_{b|x-y|}\nu(2x-y) \right) = 2C_K(N_x) f(x),$$

with $C_K(N_x)$ and f as defined in the statement of the theorem. Notice that 2x - y is the point symmetric to y with respect to x, and thus it belongs to $X_a^-(x)$ if $y \in X_a^+(x)$. In fact, from the preceding identities one deduces that $T^+\nu(x) \equiv \lim_{X_a^+(x)\ni y\to x} T_{b|x-y|}\nu(y)$ exists for \mathcal{H}^n -a.e. $x\in E$ and that

(2.3)
$$T^{+}\nu(x) = \operatorname{pv} T\nu(x) + C_{K}(N_{x}) f(x).$$

It is immediate to check also that $T^-\nu(x) \equiv \lim_{X_a^+(x)\ni y\to x} T_{b|x-y|}\nu(2x-y)$ and thus, again by (2.1) and (2.2), it exists and

(2.4)
$$T^{-}\nu(x) = \operatorname{pv} T\nu(x) - C_{K}(N_{x}) f(x).$$

Clearly, (2.3) and (2.4) are equivalent to (1.5) and (1.6).

To prove (2.1) and (2.2), write $\mu = \mathcal{H}^n|_E$, $y_x^* = 2x - y$. For a given $\delta > 0$ we consider the maximal operators

$$S_{\delta}\nu(x) = \sup_{y \in X_a^+(x), |x-y| \le \delta} \Big| \operatorname{pv} T\nu(x) - \frac{1}{2} \big(T_{b|x-y|}\nu(y) + T_{b|x-y|}\nu(y_x^*) \big) \Big|,$$

$$\widetilde{S}_{\delta}\nu(x) = \sup_{y \in X_a^+(x), |x-y| \le \delta} \left| C_K(N_x) \frac{d\nu_{abs}}{d\mu}(x) - \frac{1}{2} \left(T_{b|x-y|}\nu(y) - T_{b|x-y|}\nu(y_x^*) \right) \right|.$$

By standard arguments, it suffices to show that, for all $\lambda > 0$,

(2.5)
$$\mu(\{x \in E : S_{\delta}\nu(x) + \widetilde{S}_{\delta}\nu(x) > \lambda\}) \to 0 \quad \text{as } \delta \to 0.$$

Note first that S_{δ} and \widetilde{S}_{δ} are subadditive. Moreover, they are bounded from $M(\mathbb{R}^{n+1})$ to $L^{1,\infty}(\mu)$ uniformly on $\delta > 0$. Indeed, for all $x \in \Gamma$ and $y \in X_a^+(x)$, by standard estimates,

$$|T_{b|x-y|}\nu(y)| + |T_{b|x-y|}\nu(y_x^*)| \lesssim T_*\nu(x) + M_n\nu(x),$$

where M_n is the maximal operator $M_n\nu(x) = \sup_{r>0} \frac{|\nu|(B(x,r))}{r^n}$. Hence,

$$S_{\delta}\nu(x) \lesssim T_*\nu(x) + M_n\nu(x)$$

for all $x \in \Gamma$. Since both T_* and M_n are bounded from $M(\mathbb{R}^{n+1})$ to $L^{1,\infty}(\mu)$, the same holds for S_{δ} . Regarding \widetilde{S}_{δ} , we argue analogously and take also into account that, by the smoothness

of $\Omega(\cdot)$, it holds that $C_K(N_x)$ is uniformly bounded, and thus

$$\left\| C_K(N_x) \frac{d\nu_{abs}}{d\mu} \right\|_{L^1(\mu)} \lesssim \|\nu_{abs}\| \le \|\nu\|.$$

Given an arbitrary $\varepsilon > 0$, let $\tau > 0$ be such that $|\nu|(\mathcal{U}_{\tau}(E) \setminus E) \leq \varepsilon$, where $\mathcal{U}_{\tau}(E)$ stands for the open τ -neighborhood of E. Write

$$\mu(\left\{x \in E : S_{\delta}\nu(x) + \widetilde{S}_{\delta}\nu(x) > \lambda\right\})$$

$$\leq \mu(\left\{x \in E : S_{\delta}(\chi_{(\mathcal{U}_{\tau}(E))^{c}}\nu)(x) + \widetilde{S}_{\delta}(\chi_{(\mathcal{U}_{\tau}(E))^{c}}\nu)(x) > \lambda/3\right\})$$

$$+ \mu(\left\{x \in E : S_{\delta}(\chi_{\mathcal{U}_{\tau}(E)\setminus E}\nu)(x) + \widetilde{S}_{\delta}(\chi_{\mathcal{U}_{\tau}(E)\setminus E}\nu)(x) > \lambda/3\right\})$$

$$+ \mu(\left\{x \in E : S_{\delta}(\chi_{E}\nu)(x) + \widetilde{S}_{\delta}(\chi_{E}\nu)(x) > \lambda/3\right\})$$

$$=: A_{1}(\delta) + A_{2}(\delta) + A_{3}(\delta).$$

By the continuity of $T(\chi_{(\mathcal{U}_{\tau}(E))^c}\nu)$ in $\mathcal{U}_{\tau/2}(E)$ and the fact that $|(\chi_{(\mathcal{U}_{\tau}(E))^c}\nu_{abs})|(E) = 0$, it follows easily that $A_1(\delta) = 0$ for δ small enough (depending on τ and thus on ε). Also, by the boundedness of S_{δ} and \widetilde{S}_{δ} from $M(\mathbb{R}^{n+1})$ to $L^{1,\infty}(\mu)$,

$$A_2(\delta) \lesssim \frac{|\nu|(\mathcal{U}_{\tau}(E) \setminus E)}{\lambda} \lesssim \frac{\varepsilon}{\lambda}.$$

To estimate $A_3(\delta)$, let V be an open set such that $\mu(V) < \varepsilon$ and $|\nu_s|(V^c) = 0$, and consider a compact set $K \subset V \cap E$ such that $|\nu|(V \cap E \setminus K) \le \varepsilon$. Also, take a compactly supported C^1 function g on Γ such that

$$\left\|\chi_E \frac{d\nu_{abs}}{d\mu} - g\right\|_{L^1(\mu)} \le \varepsilon.$$

Then we split

$$\chi_E \nu = g\mu + (\chi_E \nu_{abs} - g\mu) + \chi_{V \cap E \setminus K} \nu_s + \chi_K \nu_s.$$

We have

$$\mu(A_{3}(\delta)) \leq \mu(\{x \in E : S_{\delta}(g\mu)(x) + \widetilde{S}_{\delta}(g\mu)(x) > \lambda/12\})$$

$$+ \mu(\{x \in E : S_{\delta}(\chi_{E}\nu_{abs} - g\mu)(x) + \widetilde{S}_{\delta}(\chi_{E}\nu_{abs} - g\mu)(x) > \lambda/12\})$$

$$+ \mu(\{x \in E : S_{\delta}(\chi_{V \cap E \setminus K}\nu_{s})(x) + \widetilde{S}_{\delta}(\chi_{V \cap E \setminus K}\nu_{s})(x) > \lambda/12\})$$

$$+ \mu(\{x \in E \setminus V : S_{\delta}(\chi_{K}\nu_{s})(x) + \widetilde{S}_{\delta}(\chi_{K}\nu_{s})(x) > \lambda/12\}) + \mu(V)$$

$$=: B_{1}(\delta) + B_{2}(\delta) + B_{3}(\delta) + B_{4}(\delta) + \mu(V).$$

Again by the boundedness of S_{δ} and \widetilde{S}_{δ} from $M(\mathbb{R}^{n+1})$ to $L^{1,\infty}(\mu)$,

$$B_2(\delta) + B_3(\delta) \lesssim \frac{1}{\lambda} \left\| \chi_E \frac{d\nu_{abs}}{d\mu} - g \right\|_{L^1(\mu)} + \frac{|\nu|(V \cap E \setminus K)}{\lambda} \lesssim \frac{\varepsilon}{\lambda}.$$

Also, by continuity, $B_4(\delta) = 0$ for δ small enough.

Summarizing, we have shown that

$$\mu(\left\{x \in E : S_{\delta}\nu(x) + \widetilde{S}_{\delta}\nu(x) > \lambda\right\}) \lesssim \mu(\left\{x \in E : S_{\delta}(g\mu)(x) + \widetilde{S}_{\delta}(g\mu)(x) > \lambda/12\right\}) + \varepsilon + \frac{\varepsilon}{\lambda}$$

for δ small enough. We will prove now that, for every $x \in E$ for which pv $T_{\mu}g(x)$ exists,

$$S_{\delta}(g\mu)(x) + \widetilde{S}_{\delta}(g\mu)(x) \to 0$$
 as $\delta \to 0$.

This will imply that

$$\mu(\lbrace x \in E : S_{\delta}(g\mu)(x) + \widetilde{S}_{\delta}(g\mu)(x) > \lambda/12\rbrace) \le \varepsilon$$

for δ small enough and will conclude the proof of (2.5).

First we deal with $S_{\delta}(g\mu)(x)$. So fix $x \in E$ such that pv $T_{\mu}g(x)$ exists, and given $\varepsilon > 0$ let $\delta > 0$ be small enough so that

(2.6)
$$|\operatorname{pv} T(g\mu)(x) - T_{A\delta}(g\mu)(x)| \le \varepsilon,$$

for some $A \gg 1$ to be fixed below. For a fixed $y \in X_a^+(x)$, with $|x-y| \le \delta$, denote $d_y = |x-y|$ and observe that $T_{bd_y}(g\mu)(y) = T(g\mu)(y)$ and $T_{bd_y}(g\mu)(y_x^*) = T(g\mu)(y_x^*)$ for δ small enough (depending on the continuity of the tangent at x), because $g\mu$ is supported on Γ , which is a C^1 graph. Write

$$\left| \operatorname{pv} T(g\mu)(x) - \frac{1}{2} \left(T_{bd_y}(g\mu)(y) + T_{bd_y} \nu(y_x^*) \right) \right| \leq \left| \operatorname{pv} T(g\mu)(x) - T_{Ad_y}(g\mu)(x) \right|$$

$$+ \frac{1}{2} \left| T(\chi_{\bar{B}(x,Ad_y)^c}g\mu)(x) - T(\chi_{\bar{B}(x,Ad_y)^c}g\mu)(y) \right|$$

$$+ \frac{1}{2} \left| T(\chi_{\bar{B}(x,Ad_y)^c}g\mu)(x) - T(\chi_{\bar{B}(x,Ad_y)^c}g\mu)(y_x^*) \right|$$

$$+ \frac{1}{2} \left| T(\chi_{\bar{B}(x,Ad_y)}g\mu)(y) + T(\chi_{\bar{B}(x,Ad_y)}g\mu)(y_x^*) \right| .$$

The first term on the right hand side is smaller or equal that ε . The second one satisfies

$$|T(\chi_{\bar{B}(x,Ad_y)^c}g\mu)(x) - T(\chi_{\bar{B}(x,Ad_y)^c}g\mu)(y)| \lesssim \frac{1}{A} \|g\|_{\infty},$$

by standard estimates, taking into account that $|x-y| = d_y \le \frac{1}{A} \text{dist}(x, \text{supp}(\chi_{\bar{B}(x,Ad_y)^c}g\mu))$ and the polynomial growth of μ . Indeed, we just have to write

$$\left| T(\chi_{\bar{B}(x,Ad_y)^c} g\mu)(x) - T(\chi_{\bar{B}(x,Ad_y)^c} g\mu)(y) \right| \lesssim \int_{\bar{B}(x,Ad_y)^c} \left| K(x-z) - K(y-z) \right| |g(z)| d\mu(z)
\lesssim ||g||_{\infty} \int_{\bar{B}(x,Ad_y)^c} \frac{|x-y|}{|x-z|^{n+1}} d\mu(z)$$

and estimate the last integral by splitting the domain of integration into annuli centered at x, say. The same estimate holds replacing y by y_x^* , and thus choosing $A = \varepsilon^{-1}$ we get

(2.8)
$$\left| \operatorname{pv} T(g\mu)(x) - \frac{1}{2} \left(T_{bd_y}(g\mu)(y) + T_{bd_y} \nu(y_x^*) \right) \right| \\ \leq \varepsilon + C\varepsilon \|g\|_{\infty} + \frac{1}{2} \left| T(\chi_{\bar{B}(x,Ad_y)}g\mu)(y) + T(\chi_{\bar{B}(x,Ad_y)}g\mu)(y_x^*) \right|.$$

To estimate the last term above we write (2.9)

$$\begin{split} \left| T(\chi_{\bar{B}(x,Ad_y)}g\mu)(y) + T(\chi_{\bar{B}(x,Ad_y)}g\mu)(y_x^*) \right| &\leq |g(x)| \left| T(\chi_{\bar{B}(x,Ad_y)}\mu)(y) + T(\chi_{\bar{B}(x,Ad_y)}\mu)(y_x^*) \right| \\ &+ \left| T(\chi_{\bar{B}(x,Ad_y)}(g-g(x))\mu)(y) \right| \\ &+ \left| T(\chi_{\bar{B}(x,Ad_y)}(g-g(x))\mu)(y_x^*) \right|. \end{split}$$

It is immediate to check that the two last summands on the right hand side are bounded above by (2.10)

$$C \sup_{z \in \bar{B}(x, Ad_y)} |g(z) - g(x)| \frac{\mu(B(x, Ad_y))}{d_y^n} \lesssim A^n \sup_{z \in \bar{B}(x, A\delta)} |g(z) - g(x)| = \varepsilon^{-n} \sup_{z \in \bar{B}(x, A\delta)} |g(z) - g(x)|.$$

By the continuity of g, the right hand side is at most ε if δ is small enough.

Hence it just remains to estimate the first term on the right hand side of (2.9). We will compare this term to the analogous one replacing μ by $\mathcal{H}^n|_{L_x}$ (recall that L_x is the tangent n-plane of Γ at x). Notice that the reflection $R_x : z \mapsto 2x - z$ leaves invariant the measure $\mathcal{H}^n|_{L_x}$ (i.e., the image measure $R_x \# \mathcal{H}^n|_{L_x}$ equals $\mathcal{H}^n|_{L_x}$) and also the ball $B(x, Ad_y)$. Thus,

$$\begin{split} T(\chi_{\bar{B}(x,Ad_y)}\mathcal{H}^n|_{L_x})(y_x^*) &= \int_{B(x,Ad_y)} K(y_x^*-z) \, d\mathcal{H}^n|_{L_x}(z) \\ &= \int_{B(x,Ad_y)} K(y_x^*-z) \, dR_x \# \mathcal{H}^n|_{L_x}(z) \\ &= \int_{B(x,Ad_y)} K(y_x^*-(2x-z)) \, d\mathcal{H}^n|_{L_x}(z) \\ &= \int_{B(x,Ad_y)} K(z-y) \, d\mathcal{H}^n|_{L_x}(z) = -T(\chi_{\bar{B}(x,Ad_y)}\mathcal{H}^n|_{L_x})(y), \end{split}$$

by the antisymmetry of K. Thus,

$$\begin{aligned} & (2.11) \\ & \left| T(\chi_{\bar{B}(x,Ad_y)}\mu)(y) + T(\chi_{\bar{B}(x,Ad_y)}\mu)(y_x^*) \right| \\ & = \left| \left(T(\chi_{\bar{B}(x,Ad_y)}\mu)(y) + T(\chi_{\bar{B}(x,Ad_y)}\mu)(y_x^*) \right) - \left(T(\chi_{\bar{B}(x,Ad_y)}\mathcal{H}^n|_{L_x})(y) + T(\chi_{\bar{B}(x,Ad_y)}\mathcal{H}^n|_{L_x})(y_x^*) \right) \right| \\ & \leq \left| T(\chi_{\bar{B}(x,Ad_y)}\mu)(y) - T(\chi_{\bar{B}(x,Ad_y)}\mathcal{H}^n|_{L_x})(y) \right| + \left| T(\chi_{\bar{B}(x,Ad_y)}\mu)(y_x^*) - T(\chi_{\bar{B}(x,Ad_y)}\mathcal{H}^n|_{L_x})(y_x^*) \right|. \end{aligned}$$

We will now estimate the first term on the right hand side of (2.11). To show that this is small is a routine task. Since Γ is the graph of a C^1 function, there is some $\delta > 0$ small enough such that, for all $w \in \Gamma \cap B(x, \delta)$, the angle between the tangent planes L_w and L_x is at most $A^{-n-1}\varepsilon$. As a consequence, $\Gamma \cap B(x, \delta)$ coincides with the graph of a C^1 function $F_x : L_x \to \mathbb{R}$ with slope at most $CA^{-n-1}\varepsilon$. More precisely, denoting by Π the orthogonal projection on L_x and writing $\widetilde{F}_x(z) = z + F_x(z)N_x$ for $z \in L_x$, we have

$$\Gamma \cap B(x, \delta) = \widetilde{F}_x(\Pi(\Gamma \cap B(x, \delta))),$$

with $\|\nabla F_x\|_{\infty} \lesssim CA^{-n-1}\varepsilon$. Then we can write

$$T(\chi_{\bar{B}(x,Ad_y)}\mu)(y) = \int_{\Pi(\bar{B}(x,Ad_y)\cap\Gamma)} K(y - \tilde{F}_x(z)) d\Pi \# \mathcal{H}^n|_{\Gamma}(z).$$

Therefore,

$$\begin{split} \left| T(\chi_{\bar{B}(x,Ad_y)}\mu)(y) - T(\chi_{\bar{B}(x,Ad_y)}\mathcal{H}^n|_{L_x})(y) \right| \\ & \leq \left| \int_{\Pi(\bar{B}(x,Ad_y)\cap\Gamma)} \left(K(y-\tilde{F}_x(z)) - K(y-z) \right) d\Pi \# (\mathcal{H}^n|_{\Gamma})(z) \right| \\ & + \left| \int_{\Pi(\bar{B}(x,Ad_y)\cap\Gamma)} K(y-z) d(\Pi \# (\mathcal{H}^n|_{\Gamma}) - \mathcal{H}^n|_{L_x})(z) \right| \\ & + \mathcal{H}^n \left((\bar{B}(x,Ad_y)\cap L_x) \setminus (\Pi(\bar{B}(x,Ad_y)\cap\Gamma)) \right) \sup_{z \in L_x} |K(y-z)| \\ & =: I_1 + I_2 + I_3. \end{split}$$

Since $|y-z| \gtrsim |y-x| = d_y$ for $z \in L_x$, we derive

$$\sup_{z \in L_x} |K(y - z)| \lesssim \frac{1}{d_y^n}.$$

Observe also that, by the fact that the slope of F_x is at most $A^{-n-1}\varepsilon$, for all $w \in \Gamma \cap B(x, Ad_y)$,

$$\operatorname{dist}(w, L_x) \lesssim A^{-n-1} \varepsilon A d_y = A^{-n} \varepsilon d_y.$$

Then it easily follows that, for some absolute constant C

$$\mathcal{H}^{n}((\bar{B}(x,Ad_{y})\cap L_{x})\setminus \Pi(\bar{B}(x,Ad_{y})\cap \Gamma))$$

$$\leq \mathcal{H}^{n}(B(x,Ad_{y})\cap L_{x}\setminus B(x,Ad_{y}-CA^{-n}\varepsilon d_{y}))\lesssim \varepsilon d_{y}^{n}.$$

and thus $I_3 \lesssim \varepsilon$. Also, taking into account that

$$d\Pi \# (\mathcal{H}^n|_{\Gamma})(z) = (1 + |\nabla F_x(z)|^2)^{1/2} d\mathcal{H}^n|_{L_x}(z)$$

and again that $\|\nabla F_x\|_{\infty} \lesssim A^{-n-1}\varepsilon$, we derive

$$I_2 \lesssim \sup_{z \in L_x} |K(y-z)| A^{-n-1} \varepsilon \mathcal{H}^n(B(x,Ad_y) \cap L_x) \lesssim \frac{1}{d_y^n} A^{-n-1} \varepsilon (Ad_y)^n \leq \varepsilon.$$

Concerning I_1 , we use the fact that for $z \in \Pi(\bar{B}(x, Ad_y) \cap \Gamma)$,

$$|z - \widetilde{F}_x(z)| \lesssim A^{-n-1} \varepsilon A d_y \le A^{-n} \varepsilon d_y \ll |y - z|,$$

and thus

$$\left|K(y-\widetilde{F}_x(z))-K(y-z)\right| \lesssim \frac{|\widetilde{F}_x(z)-z|}{|y-z|^{n+1}} \lesssim \frac{A^{-n}\varepsilon d_y}{d_y^{n+1}} = \frac{A^{-n}\varepsilon}{d_y^n}.$$

Hence,

$$I_1 \lesssim \frac{A^{-n}\varepsilon}{d_y^n} \mu(\bar{B}(x, Ad_y)) \lesssim \varepsilon.$$

So we have shown that

$$\left| T(\chi_{\bar{B}(x,Ad_y)}\mu)(y) - T(\chi_{\bar{B}(x,Ad_y)}\mathcal{H}^n|_{L_x})(y) \right| \lesssim \varepsilon$$

for δ small enough. The same estimates above work replacing y by y_x^* , and thus by (2.11) it follows that

$$\left| T(\chi_{\bar{B}(x,Ad_y)}\mu)(y) + T(\chi_{\bar{B}(x,Ad_y)}\mu)(y_x^*) \right| \lesssim \varepsilon.$$

Together with (2.8) and (2.9) (and recalling also that the last two terms in (2.9) are bounded by ε), we deduce that, for all $y \in X_a(x) \cap B(x, \delta)$,

$$\left| \operatorname{pv} T(g\mu)(x) - \frac{1}{2} \left(T_{bd_y}(g\mu)(y) + T_{bd_y} \nu(y_x^*) \right) \right| \le \varepsilon + C\varepsilon \|g\|_{\infty}$$

for δ small enough, which proves that $S_{\delta}(g\mu)(x) \to 0$ as $\delta \to 0$, as wished.

Next we have to show that $\widetilde{S}_{\delta}(g\mu)(x) \to 0$ as $\delta \to 0$. Again we take $A = \varepsilon^{-1}$ and δ small enough and we fix $y \in X_a^+(x)$, with $|x-y| = d_y \le \delta$. We want to show that

$$\left| C_K(N_x)g(x) - \frac{1}{2} \left(T(g\mu)(y) - T(g\mu)(y_x^*) \right) \right| \le \varepsilon$$

if δ is small enough, depending on ε . First we write

$$\begin{aligned}
\left| C_K(N_x)g(x) - \frac{1}{2} \left(T(g\mu)(y) - T(g\mu)(y_x^*) \right) \right| \\
&\leq \left| C_K(N_x)g(x) - \frac{1}{2} \left(T(\chi_{\bar{B}(x,Ad_y)}g\mu)(y) - T(\chi_{\bar{B}(x,Ad_y)}g\mu)(y_x^*) \right) \right| \\
&+ \frac{1}{2} \left| T(\chi_{\bar{B}(x,Ad_y)^c}g\mu)(y) - T(\chi_{\bar{B}(x,Ad_y)^c}g\mu)(y_x^*) \right|.
\end{aligned}$$

Arguing as in (2.7) we deduce that

$$\left| T(\chi_{\bar{B}(x,Ad_y)^c}g\mu)(y) - T(\chi_{\bar{B}(x,Ad_y)^c}g\mu)(y_x^*) \right| \lesssim \frac{1}{A} \|g\|_{\infty} = \varepsilon \|g\|_{\infty}.$$

Concerning the first term on the right hand side of (2.12) we split

$$\begin{aligned}
& \left| C_K(N_x)g(x) - \frac{1}{2} \left(T(\chi_{\bar{B}(x,Ad_y)}g\mu)(y) - T(\chi_{\bar{B}(x,Ad_y)}g\mu)(y_x^*) \right) \right| \\
& \leq \frac{1}{2} \left| T(\chi_{\bar{B}(x,Ad_y)}(g - g(x))\mu)(y) \right| + \frac{1}{2} \left| T(\chi_{\bar{B}(x,Ad_y)}(g - g(x))\mu)(y_x^*) \right| \\
& + \frac{1}{2} \left| g(x) \right| \left| T(\chi_{\bar{B}(x,Ad_y)}\mu)(y) - T(\chi_{\bar{B}(x,Ad_y)}\mathcal{H}^n|_{L_x})(y) \right| \\
& + \frac{1}{2} \left| g(x) \right| \left| T(\chi_{\bar{B}(x,Ad_y)}\mu)(y_x^*) - T(\chi_{\bar{B}(x,Ad_y)}\mathcal{H}^n|_{L_x})(y_x^*) \right| \\
& + \left| g(x) \right| \left| C_K(N_x) - \frac{1}{2} \left(T(\chi_{\bar{B}(x,Ad_y)}\mathcal{H}^n|_{L_x})(y) - T(\chi_{\bar{B}(x,Ad_y)}\mathcal{H}^n|_{L_x})(y_x^*) \right) \right| \\
& = J_1 + J_2 + J_3 + J_4 + J_5.
\end{aligned}$$

The terms J_1 and J_2 coincide with the last two terms on the right hand of (2.9) (modulo the factor $\frac{1}{2}$), which are bounded above by ε if δ is small enough, as shown in (2.10). Also, the terms J_3 and J_4 coincide with the last two terms in (2.11) (except for the factor $\frac{1}{2}|g(x)|$) and, as shown above, they do not exceed $|g(x)|\varepsilon$ if δ is small enough too. So altogether we obtain

$$\left| C_K(N_x)g(x) - \frac{1}{2} \left(T(g\mu)(y) - T(g\mu)(y_x^*) \right) \right| \le C \varepsilon \|g\|_{\infty} + J_5.$$

It remains to estimate J_5 . To this end, we write

$$(2.13) J_{5} \leq |g(x)| \left| C_{K}(N_{x}) - \frac{1}{2} \left(T \mathcal{H}^{n}|_{L_{x}}(y) - T \mathcal{H}^{n}|_{L_{x}}(y_{x}^{*}) \right) \right|$$

$$+ \frac{1}{2} |g(x)| \left| T(\chi_{\bar{B}(x,Ad_{y})^{c}} \mathcal{H}^{n}|_{L_{x}})(y) - T(\chi_{\bar{B}(x,Ad_{y})^{c}} \mathcal{H}^{n}|_{L_{x}})(y_{x}^{*}) \right|.$$

Indeed, above one should understand $T\mathcal{H}^n|_{L_x}(y) - T\mathcal{H}^n|_{L_x}(y_x^*)$ and $T(\chi_{\bar{B}(x,Ad_y)^c}\mathcal{H}^n|_{L_x})(y) - T(\chi_{\bar{B}(x,Ad_y)^c}\mathcal{H}^n|_{L_x})(y_x^*)$ in a "BMO sense". As in the estimate (2.7), by standard estimates we get

$$\left|T(\chi_{\bar{B}(x,Ad_y)^c}\mathcal{H}^n|_{L_x})(y) - T(\chi_{\bar{B}(x,Ad_y)^c}\mathcal{H}^n|_{L_x})(y_x^*)\right| \lesssim \frac{1}{A} = \varepsilon.$$

Finally we will show that the first term on the right hand side of (2.13) vanishes. First note that if $\widetilde{y} \in \mathbb{R}^{n+1}$ is any point which equals the translation of y along any direction parallel to L_x , then

$$T\mathcal{H}^n|_{L_x}(y) - T\mathcal{H}^n|_{L_x}(\widetilde{y}) = 0.$$

In other words, the function $T\mathcal{H}^n|_{L_x}$ (which we should understand in a suitable BMO sense) is invariant by translations parallel to L_x . Therefore, when computing $T\mathcal{H}^n|_{L_x}(y) - T\mathcal{H}^n|_{L_x}(y_x^*)$ we can assume that y and y_x^* are of the form

$$y = x + t N_x$$
 and $y_x^* = x - t N_x$, for some $t > 0$.

Then, using also the fact that K is a convolution kernel

$$T\mathcal{H}^{n}|_{L_{x}}(y) - T\mathcal{H}^{n}|_{L_{x}}(y_{x}^{*}) = T\mathcal{H}^{n}|_{L_{x}}(x + t N_{x}) - T\mathcal{H}^{n}|_{L_{x}}(x - t N_{x})$$
$$= T\mathcal{H}^{n}|_{L(N_{x})}(t N_{x}) - T\mathcal{H}^{n}|_{L(N_{x})}(t N_{x})$$

(recall that $L(N_x)$ is the *n*-plane parallel to L_x through the origin). Taking now into account that K is homogeneous of degree -n, it follows that

$$T\mathcal{H}^{n}|_{L_{x}}(y) - T\mathcal{H}^{n}|_{L_{x}}(y_{x}^{*}) = T\mathcal{H}^{n}|_{L(N_{x})}(N_{x}) - T\mathcal{H}^{n}|_{L(N_{x})}(N_{x}).$$

By the definition (1.7), the right hand equals $C_K(N_x)$ and thus the first term on the right hand side of (2.13) vanishes, as wished.

Gathering the estimates above we deduce that

$$\left| C_K(N_x)g(x) - \frac{1}{2} \left(T(\chi_{\bar{B}(x,Ad_y)}g\mu)(y) - T(\chi_{\bar{B}(x,Ad_y)}g\mu)(y_x^*) \right) \right| \lesssim \varepsilon + \varepsilon \|g\|_{\infty}$$

for all $y \in X_a^+(x) \cap B(x, \delta)$ if δ is small enough, which proves that $\widetilde{S}_{\delta}(x) \to 0$ as $\delta \to 0$ and concludes the proof of the theorem.
