# THE GAMMA FILTRATIONS FOR THE SPIN GROUPS 

NOBUAKI YAGITA


#### Abstract

Let $G$ be a compact Lie group and $T$ its maximal torus. In this paper, we try to compute $g r_{\gamma}^{*}(G / T)$ the graded ring associated with the gamma filtration of the complex $K$-theory $K^{0}(G / T)$ for $G=\operatorname{Spin}(n)$. In particular, we give a counterexample for a conjecture by Karpenko when $G=\operatorname{Spin}(17)$. The arguments for $E_{7}$ in $\S 11$ of the old version were not correct, and they are deleted in this version.


## 1. Introduction

Let us fix a prime number $p$, and assume all theories $\left(H^{*}(X), C H^{*}(X), K^{*}(X)\right)$ are $p$-localized theories. Let $G$ and $T$ be a simply connected compact Lie group and its maximal torus. Given a field $k$ with $\operatorname{ch}(k)=0$, let $G_{k}$ and $T_{k}$ be the split reductive group and a split maximal torus over the field $k$, corresponding to $G$ and $T$. Let $B_{k}$ be the Borel subgroup containing $T_{k}$. Let $\mathbb{G}$ be a $G_{k}$-torsor. Then $\mathbb{F}=\mathbb{G} / B_{k}$ is a twisted form of the flag variety $G_{k} / B_{k}$.

In this paper, we study the graded ring $\operatorname{gr}_{\gamma}(\mathbb{F})$ associated to the $\gamma$-filtration of the algebraic $K$-theory $K_{a l g}^{0}(\mathbb{F})$, mainly for $G=\operatorname{Spin}(o d d)$ and $p=2$. Since $K_{\text {alg }}^{0}(\mathbb{F})$ is isomorphic to the topological $K$-theory $K_{\text {top }}^{0}(G / T)$ [Pa], we know $g r_{\gamma}(\mathbb{F}) \cong g r_{\gamma}^{*}(G / T)$ for the algebraic and topological $\gamma$-filtrations.

Moreover we take $\mathbb{G}$ a versal $G_{k}$-torsor i.e., $\mathbb{G}$ is isomorphic to $G_{k(S)}$-torsor over $\operatorname{Spec}(k(S))$ given by the generic fiber of $G L_{N} \rightarrow S$ where $S=G L_{N} / G_{k}$ for an embedding $G \subset G L_{N}$ ( for the properties of a versal $G_{k}$-torsor, see $\S 3$ below or see Ga-Me-Se, To2], Me-Ne-Za], Ka1]. When $\mathbb{G} / B_{k}=\mathbb{F}$ is a versal flag variety, it is known $(\mathbb{M e}-\mathrm{Ne}-\mathrm{Za}, \mathrm{Ka1})$ that $C H^{*}(\mathbb{F})$ is generated by Chern classes. Hence we know $g r_{\gamma}^{*}(\mathbb{F}) \cong g r_{\text {geo }}^{*}(\mathbb{F})$; the graded ring associated the geometric filtration (defined from degree of $C H^{*}(X)$ ) (see Chapter 15 in [To3], Ya5]).

Lemma 1.1. Let $G$ be a compact simply connected Lie group. Let $\mathbb{F}=\mathbb{G} / B_{k}$ be the versal flag variety. Then

$$
g r_{\gamma}^{*}(G / T) \cong g r_{g e o}^{*}(\mathbb{F}) \cong C H^{*}(\mathbb{F}) / I(1) \quad \text { for some ideal } I(1) \subset C H^{*}(\mathbb{F})
$$

Karpenko conjectured that the above $I(1)=0($ Ka1, Ka2 $)$. In this paper, we try to compute $g r_{\gamma}^{*}(G / T)$ for $G=\operatorname{Spin}(2 \ell+1)$. In particular, we see $I(1) \neq 0$ for $G=\operatorname{Spin}(17)$.

For these computations, we use the generalized Rost motive $R(\mathbb{G})$ defined by Petrov-Semenov-Zainoulline [Pe-Se-Za] such that the ( $p$-localized) motive $M(\mathbb{F})$ of the flag variety $\mathbb{F}$ is written

$$
M(\mathbb{F}) \cong R(\mathbb{G}) \otimes\left(\oplus_{s} \mathbb{T}^{\otimes s}\right), \quad \text { for the Tate motive } \mathbb{T} .
$$

[^0]For $G=\operatorname{Spin}(2 \ell+1), G^{\prime \prime}=\operatorname{Spin}(2 \ell+2)$, we know $R(\mathbb{G}) \cong R\left(\mathbb{G}^{\prime \prime}\right)$ from a theorem by Vishik-Zainoulline Vi-Za]. So in this paper, we only study $\operatorname{Spin}($ odd $)$ but many arguments for $S$ pin(even) are similar.

For $\ell \leq 2, H^{*}(G)$ has no torsion. For $\ell=3,4, g r_{\gamma}^{*}(\mathbb{F})$ are given in [Ya4 and $I(1)=0$. For $\ell=5, g r_{\gamma}^{*}(\mathbb{F})$ is given in Ya5, Ka2]. Moreover Karpenko shows $I(1)=0$ and this Karpenko result is the first example that $R(\mathbb{G})$ is not the original Rost motive, but $C H^{*}(R(\mathbb{G}))$ is given. For $\ell=6, g r_{\gamma}^{*}(\mathbb{F})$ is given $\S 9$ in this paper, while we can not see $I(1)=0$ or not. For $\ell \geq 7$, very partial results are only given here. However, we see $I(1) \neq 0$ for $\ell=8$.

Let us write by $\Lambda(a, \ldots, b)$ the exterior algebra over $\mathbb{Z} / 2$ generated by $a, \ldots, b$. We note the following fact
Lemma 1.2. Let $G=\operatorname{Spin}(2 \ell+1)$ and $\mathbb{G}$ be versal. Let $2^{t} \leq \ell<2^{t+1}$. Then there are elements $c_{2}, \ldots, c_{\ell}$ and $e_{2^{t+1}}$ with $\operatorname{deg}\left(c_{i}\right)=i, \operatorname{deg}\left(e_{j}\right)=j$ such that there is an additive surjection

$$
\Lambda\left(c_{2}, \ldots, c_{\ell}\right) \otimes \mathbb{Z} / 2\left[e_{2^{t+1}}\right] \rightarrow C H^{*}(R(\mathbb{G})) / 2
$$

Here $c_{i}$ is represented by some $i$-th Chern class. For a ring $A$, let us write by $A\{a, \ldots, b\}$ the $A$-free module generated by $a, \ldots, b$. For example, we can write

Theorem 1.3. Let $G=\operatorname{Spin}(13)$ and $\mathbb{G}$ be versal. Then $\operatorname{gr}_{\gamma}^{*}(R(\mathbb{G}))$ is additively generated by products of $1, c_{2}, c_{3}, \ldots, c_{6}$ and $e_{8}$ as follows

$$
g r_{\gamma}^{*}(R(\mathbb{G})) \cong A \otimes\left(\mathbb{Z}_{(2)}\left\{1, c_{6}\right\} \oplus \mathbb{Z} / 2\left\{c_{4}\right\}\right) \oplus \mathbb{Z} / 2\left\{c_{6} c_{4}\right\}
$$

where $A=\mathbb{Z}_{(2)}\left\{1, c_{3}, c_{5}, e_{8}\right\} \oplus \mathbb{Z} / 2\left\{c_{2}\right\}$.
When $G=\operatorname{Spin}(17)$, elements in the Chow ring $C H^{*}(R(\mathbb{G})) / 2$ are additively generated by products of $1, c_{2}, \ldots, c_{7}$. Moreover the torsion index $t(G)=2^{4}$. Then we can see for $x=c_{2} c_{3} c_{6} c_{7}$,

$$
x=0 \in g r_{\gamma}^{*}(R(\mathbb{G})) / 2, \quad \text { but } \quad x \neq 0 \in \operatorname{gr}(2)^{*}(R(\mathbb{G})) / 2
$$

Here $\operatorname{gr}(n)^{*}(X)$ is the graded associated ring for the integral Morava $\tilde{K}(n)$-theory, so that

$$
g r(n)^{*}(X) \cong C H^{*}(X) / I(n) \quad \text { for some ideal } I(n)
$$

and $g r(1)^{*}(X) \cong g r_{g e o}^{*}(X)$. Hence this $x$ is nonzero in $C H^{*}(R(\mathbb{G})) / 2$, i.e., $0 \neq$ $x \in I(1)$.

Remark. The arguments (for $\left.(G, p)=\left(E_{7}, 2\right)\right)$ in $\S 11$ and Theorem 1.4 of the old version were not correct, and they are deleted in this version.

The plan of this paper is the following. In $\S 2$, we recall and prepare the topological arguments. In $\S 3$, we recall the decomposition of the motive of a versal flag variety. In $\S 4$, we recall the filtrations of the $K$-theory. In $\S 5$, we study the connective $K$-theory $k^{*}(\bar{R}(\mathbb{G}))$. In $\S 6$, we study the general properties when $G=S \operatorname{pin}(2 \ell+1)$. In $\S 7, \S 8$, we study cases $\ell=3$ (and 4 ), $\ell=5$ respectively. In $\S 9$, we study the case $\ell=6$. In $\S 10$ we study the cases $\ell \geq 7$ and see the counterexample when $\ell=8$. In $\S 11$, we note the cases $\ell$ large.

## 2. Lie groups $G$ and the flag manifolds $G / T$

Let $G$ be a connected compact Lie group. By Borel ([Bo, Mi-Tod]), its $\bmod (p)$ cohomology is written as
$(*) \quad \operatorname{gr} H^{*}(G ; \mathbb{Z} / p) \cong P(y) / p \otimes \Lambda\left(x_{1}, \ldots, x_{\ell}\right), \quad \ell=\operatorname{rank}(G)$

$$
\text { with } P(y)=\mathbb{Z}_{(p)}\left[y_{1}, \ldots, y_{k}\right] /\left(y_{1}^{p^{r_{1}}}, \ldots, y_{k}^{p^{r_{k}}}\right)
$$

where the degree $\left|y_{i}\right|$ of $y_{i}$ is even and $\left|x_{j}\right|$ is odd. In this paper, we only consider this $g r H^{*}(G ; \mathbb{Z} / p)$ in $(*)$, and write it simply $H^{*}(G ; \mathbb{Z} / p)$.

Let $T$ be the maximal torus of $G$ and $B T$ be the classifying space of $T$. We consider the fibering $([\overline{\mathrm{Tod}}, \overline{\mathrm{Mi}-\mathrm{Ni}]}) G \xrightarrow{\pi} G / T \xrightarrow{i} B T$ and the induced spectral sequence

$$
E_{2}^{*, *^{\prime}}=H^{*}\left(B T ; H^{*^{\prime}}(G ; \mathbb{Z} / p)\right) \Longrightarrow H^{*}(G / T ; \mathbb{Z} / p)
$$

The cohomology of the classifying space of the torus is given by $H^{*}(B T) \cong S(t)=$ $\mathbb{Z}\left[t_{1}, \ldots, t_{\ell}\right]$ with $\left|t_{i}\right|=2$, where $t_{i}=p r_{i}^{*}\left(c_{1}\right)$ is the 1 -st Chern class induced from $T=S^{1} \times \ldots \times S^{1} \xrightarrow{p r_{i}} S^{1} \subset U(1)$ for the $i$-th projection $p r_{i}$. Note that $\ell=\operatorname{rank}(G)$ is also the number of the odd degree generators $x_{i}$ in $H^{*}(G ; \mathbb{Z} / p)$.

It is well known that $y_{i}$ are permanent cycles (i.e., exist in $E_{\infty}^{0, *^{\prime}}$ ) and that there is a regular sequence (Tod, Mi-Ni] $\left(\bar{b}_{1}, \ldots, \bar{b}_{\ell}\right)$ in $H^{*}(B T) /(p)$ such that $d_{\left|x_{i}\right|+1}\left(x_{i}\right)=\bar{b}_{i}$ (this $\bar{b}_{i}$ is called the transgressive element). Thus we get

$$
E_{\infty}^{*, *^{\prime}} \cong g r H^{*}(G / T ; \mathbb{Z} / p) \cong P(y) / p \otimes S(t) /\left(\bar{b}_{1}, \ldots, \bar{b}_{\ell}\right)
$$

Moreover we know that $G / T$ is a manifold such that $H^{*}(G / T)$ is torsion free, and

$$
\operatorname{gr} H^{*}(G / T) \cong P(y) \otimes S(t) /\left(b_{1}, \ldots, b_{\ell}\right) \quad \text { where } b_{i}=\bar{b}_{i} \bmod (p)
$$

For ease of he notation, let us write simply $S(t) /(b)=S(t) /\left(b_{1}, \ldots, b_{\ell}\right)$.
Let $B P^{*}(-)$ be the Brown-Peterson theory with the coefficients ring $B P^{*} \cong$ $\mathbb{Z}_{(p)}\left[v_{1}, v_{2}, \ldots\right],\left|v_{i}\right|=-2\left(p^{i}-1\right)$ (Ha, Ras). Since $H^{*}(G / T)$ is torsion free, the Atiyah-Hirzebruch spectral sequence (AHss) collapses. Hence we also know $\operatorname{gr} B P^{*}(G / T) \cong B P^{*} \otimes \operatorname{gr} H^{*}(G / T)$.

Recall the Morava $K$-theory $K(n)^{*}(X)$ with the coefficient ring $K(n)^{*}=\mathbb{Z} / p\left[v_{n}, v_{n}^{-1}\right]$. Similarly we can define connected or integral Morava K-theories with

$$
k(n)^{*}=\mathbb{Z} / p\left[v_{n}\right], \quad \tilde{k}(n)^{*}=\mathbb{Z}_{(p)}\left[v_{n}\right], \quad \tilde{K}(n)^{*}=\mathbb{Z}_{(p)}\left[v_{n}, v_{n}^{-1}\right]
$$

It is known that $\tilde{K}(1)^{*}(X) \cong B P^{*}(X) \otimes_{B P^{*}} \tilde{K}(1)^{*}$ as the Conner-Floyd theorem. The relation to the usual $K$-theory $K^{*}(X)$ is given using the Bott periodicity $B$

$$
K^{*}(X) \cong \tilde{K}(1)^{*}(X) \otimes_{\tilde{K}(1)^{*}} \mathbb{Z}_{(p)}\left[B, B^{-1}\right], \quad \text { with } B^{p-1}=v_{1}
$$

We recall the Milnor operation $Q_{i}: H^{*}(X ; \mathbb{Z} / p) \rightarrow H^{*+2 p^{i}-1}(X ; \mathbb{Z} / p)$, which is defined by $Q_{0}=\beta$ and $Q_{i+1}=P^{p^{i}} Q_{i}-Q_{i} P^{p^{i}}$ for the Bockstein operation $\beta$ and the reduced power operation $P^{j}$. This $Q_{i}$-operation relates to the Morava $k(i)^{*}$-theory. Recall the fibering $G \xrightarrow{\pi} G / T \rightarrow B T$. Let us write $v_{0}=p$ and $k(0)^{*}(X)=H^{*}(X)$. Let $I_{\infty}=\left(p, v_{1}, \ldots\right)$ be the invariant prime ideal in $B P^{*}$. Then we can prove

Corollary 2.1. (\Ya4) Let $d_{|x|+1}(x)=b \neq 0 \in H^{*}(G / T) / p$ for $x \in H^{*}(G ; \mathbb{Z} / p)$. Then there is a lift $b \in B P^{*}(B T) \cong B P^{*} \otimes S(t)$ of $b \in S(t) / p$ such that

$$
\left.b=\sum_{i=0} v_{i} y(i) \in B P^{*}(G / T) / I_{\infty}^{2} \quad\left(i . e ., b=v_{i} y(i) \in k(i)^{*}(G / T)\right) /\left(v_{i}^{2}\right)\right)
$$

where $y(i) \in H^{*}(G / T ; \mathbb{Z} / p)$ with $\pi^{*} y(i)=Q_{i} x$.

## 3. VERSAL FLAG VARIETIES

Let $G_{k}$ be the split reductive algebraic group corresponding to $G$, and $T_{k}$ be the split maximal torus corresponding to $T$. Let $B_{k}$ be the Borel subgroup with $T_{k} \subset B_{k}$. Note that $G_{k} / B_{k}$ is cellular, and $C H^{*}\left(G_{k} / T_{k}\right) \cong C H^{*}\left(G_{k} / B_{k}\right)$. Hence we have $C H^{*}\left(G_{k} / B_{k}\right) \cong H^{2 *}(G / T)$ and $C H^{*}\left(B B_{k}\right) \cong H^{2 *}(B T)$.

Remark. In this paper, for $x \in C H^{*}(X)$, degree $|x|$ means two times of the usual degree for the Chow ring i.e., $|x|=2 *$.

Let us write by $\Omega^{*}(X)$ the $B P$-version of the algebraic cobordism defined by Levine-Morel (Le-Mo, Ya1, Ya2]) such that

$$
\Omega^{*}(X)=M G L^{2 *, *}(X)_{(p)} \otimes_{M U_{(p)}^{*}} B P^{*}, \quad \Omega^{*}(X) \otimes_{B P^{*}} \mathbb{Z}_{(p)} \cong C H^{*}(X)
$$

where $M G L^{*, *^{\prime}}(X)$ is the algebraic cobordism theory defined by Voevodsky with $M G L^{2 *, *}(p t.) \cong M U^{*}$ the complex cobordism ring. There is a natural (realization) $\operatorname{map} \Omega^{*}(X) \rightarrow B P^{*}(X(\mathbb{C}))$. In particular, we have $\Omega^{*}\left(G_{k} / B_{k}\right) \cong B P^{*}(G / T)$. Recall $I_{n}=\left(p, v_{1}, \ldots, v_{n-1}\right)$ and we also note

$$
\Omega^{*}\left(G_{k} / B_{k}\right) / I_{\infty} \cong C H^{*}\left(G_{k} / B_{k}\right) / p \cong H^{*}(G / T) / p
$$

Let $\mathbb{G}$ be a nontrivial $G_{k}$-torsor. We can construct a twisted form of $\mathbb{G}_{k} / B_{k}$ by $\left(\mathbb{G} \times G_{k} / B_{k}\right) / G_{k} \cong \mathbb{G} / B_{k}$. We will study the twisted flag variety $\mathbb{F}=\mathbb{G} / B_{k}$.

Let us consider an embedding of $G_{k}$ into the general linear group $G L_{N}$ for some large $N$. This makes $G L_{N}$ a $G_{k}$-torsor over the quotient variety $S=G L_{N} / G_{k}$. Let $F$ be the function field $k(S)$ and define the versal $G_{k^{-}}$-torsor $E$ to be the $G_{k^{-}}$ torsor over $F$ given by the generic fiber of $G L_{N} \rightarrow S$. (For details, see Ga-Me-Se, [To2, $\mathrm{Me}-\mathrm{Ne}-\mathrm{Za}$, Ka1].)

The corresponding flag variety $E / B_{k}$ is called the versal flag variety, which is considered as the most complicated twisted flag variety (for given $G_{k}$ ). It is known that the Chow ring $C H^{*}\left(E / B_{k}\right)$ is not dependent to the choice of generic $G_{k}$-torsors $E$ (Remark 2.3 in Ka1]).

Karpenko proves the following result for a versal flag variety.
Theorem 3.1. (Karpenko Lemma 2.1 in Ka , $\mathrm{Me}-\mathrm{Ne}-\mathrm{Za}$ ) Let $\mathbb{G} / B_{k}$ be a versal flag variety. Let $h^{*}(-)$ be an oriented cohomology theory e.g., $h^{*}(X)=$ $C H^{*}(C), K^{*}(X), \Omega^{*}(X)$. Then the natural map $h^{*}\left(B B_{k}\right) \rightarrow h^{*}\left(\mathbb{G} / B_{k}\right)$ is surjective.

Corollary 3.2. If $\mathbb{G}$ is versal, then $h^{*}(\mathbb{F})=h^{*}\left(\mathbb{G} / B_{k}\right)$ is multiplicatively generated by elements $t_{i}$ in $S(t)$.

The versal case of the main result in Petrov-Semenov-Zainoulline $\mathrm{Pe}-\mathrm{Se}-\mathrm{Za}$ is given as

Theorem 3.3. (Theorem 5.13 in $\mathrm{Pe}-\mathrm{Se}-\mathrm{Za}$ and Theorem 4.3 in Se Zh ) Let $\mathbb{G}$ be a versal $G_{k}$-torsor, and $\mathbb{F}=\mathbb{G} / B_{k}$. Then there is a p-localized motive $R(\mathbb{G})$ such that the (p-localized) motive $M(\mathbb{F})$ of the variety $\mathbb{F}$ is decomposed

$$
M(\mathbb{F})_{(p)} \cong R(\mathbb{G}) \otimes T \quad \text { with } T=\left(\oplus_{u} \mathbb{T}^{\otimes u}\right)
$$

Here $\mathbb{T}^{\otimes u}$ are Tate motives with $C H^{*}(T) / p \cong S(t) /(p, b)=S(t) /\left(p, b_{1}, \ldots, b_{\ell}\right)$. Hence

$$
C H^{*}(\mathbb{F}) / p \cong C H^{*}(R(\mathbb{G})) \otimes S(t) /(p, b)
$$

For $\bar{R}(\mathbb{G})=R(\mathbb{G}) \otimes \bar{k}$, we have $C H^{*}(\bar{R}(\mathbb{G})) / p \cong P(y) / p$.

Remark. In this paper, $A \cong B$ for rings $A, B$ means a ring isomorphism. However $C H^{*}(R(\mathbb{G}))$ does not have a canonical ring structure. Hence an isomorphism $A \cong C H^{*}(R(\mathbb{G}))$ means only a (graded) additive isomorphism.

Hereafter in this section, we always assume that $\mathbb{G}$ (and hence $\mathbb{F}$ ) is versal.
Hence we have surjections for a variety $\mathbb{F}$

$$
C H^{*}\left(B B_{k}\right) \rightarrow C H^{*}(\mathbb{F}) \xrightarrow{p r .} C H^{*}(R(\mathbb{G}))
$$

We study in Ya4 what elements in $C H^{*}\left(B B_{k}\right)$ generate $C H^{*}(R(\mathbb{G}))$.
For ease of notations, let us write $A(b)=\mathbb{Z} / p\left[b_{1}, \ldots, b_{\ell}\right]$. By giving the filtration on $S(t)$ by $b_{i}$, we can write $g r S(t) / p \cong A(b) \otimes S(t) /(b)$.

In particular, we have maps $A(b) \xrightarrow{i_{A}} C H^{*}(\mathbb{F}) / p \rightarrow C H^{*}(R(\mathbb{G})) / p$. We also see that the above composition map is surjective (see also Lemma 3.6 below).

Lemma 3.4. Suppose that there are $f_{1}(b), \ldots, f_{s}(b) \in A(b)$ such that $C H^{*}(R(\mathbb{G})) / p \cong$ $A(b) /\left(f_{1}(b), \ldots, f_{s}(b)\right)$. Moreover if $f_{i}(b)=0$ for $1 \leq i \leq s$ also in $C H^{*}(\mathbb{F}) / p$, we have the isomorphism

$$
C H^{*}(\mathbb{F}) / p \cong S(t) /\left(p, f_{1}(b), \ldots, f_{s}(b)\right)
$$

Lemma 3.5. Let $p r: C H^{*}(\mathbb{F}) / p \rightarrow C H^{*}(R(\mathbb{G})) / p$, and $0 \neq x \in \operatorname{Ker}(p r)$. Then $x=\sum b^{\prime} t^{\prime}$ with $b^{\prime} \in A(b), 0 \neq t^{\prime} \in S(t)^{+} /(p, b)$ i.e., $\left|t^{\prime}\right|>0$.

Let us write

$$
y_{t o p}=\Pi_{i=1}^{s} y_{i}^{p_{i}-1} \quad\left(\text { resp. } t_{\text {top }}\right)
$$

the generator of the highest degree in $P(y)$ (resp. $S(t) /(b)$ ) so that $f=y_{\text {top }} t_{t o p}$ is the fundamental class in $H^{2 d}(G / T)$ for $2 d=\operatorname{dim}_{\mathbb{R}}(G / T)$. For $N>0$, let us write

$$
A_{N}=\mathbb{Z} / p\left\{b_{i_{1}} \ldots b_{i_{k}}| | b_{i_{1}}\left|+\ldots+\left|b_{i_{k}}\right| \leq N\right\} \subset A(b)\right.
$$

Lemma 3.6. For $N=\left|y_{t o p}\right|$, the map $A_{N} \rightarrow C H^{*}(R(\mathbb{G})) / p$ is surjective.
Proof. In the preceding lemma, $A_{N} \otimes t^{\prime}$ for $\left|t^{\prime}\right|>0$ maps zero in $C H^{*}(R(\mathbb{G})) / p$. Since each element in $S(t)$ is written by an element in $A_{N} \otimes S(t) /(b)$, we have the lemma.

Corollary 3.7. If $b_{i} \neq 0$ in $C H^{*}(X) / p$, then so in $C H^{*}\left(R\left(\mathbb{G}_{k}\right)\right) / p$.
Proof. Let $\operatorname{pr}\left(b_{i}\right)=0$. From Lemma 3.6, $b_{i}=\sum b^{\prime} t^{\prime}$ for $\left|t^{\prime}\right|>0$, and hence $b^{\prime} \in \operatorname{Ideal}\left(b_{1}, \ldots, b_{i-1}\right)$. This contradict to that $\left(b_{1}, \ldots, b_{\ell}\right)$ is regular.

Now we consider the torsion index $t(G)$. Let $\operatorname{dim}_{\mathbb{R}}(G / T)=2 d$. Then the torsion index is defined as

$$
t(G)=\left|H^{2 d}(G / T ; \mathbb{Z}) / i^{*} H^{2 d}(B T ; \mathbb{Z})\right| \quad \text { where } i: G / T \rightarrow B T
$$

Let $n(\mathbb{G})$ be the greatest common divisor of the degrees of all finite field extension $k^{\prime}$ of $k$ such that $\mathbb{G}$ becomes trivial over $k^{\prime}$. Then by Grothendieck Gr , it is known that $n(\mathbb{G})$ divides $t(G)$. Moreover, $\mathbb{G}$ is versal, then $n(\mathbb{G})=t(G)$ (To2], Me-Ne-Za, Ka1], which implies that each element in $t(G) P(y)$ is represented by element in $C H^{*}\left(B B_{k}\right)$.

It is well known that if $H^{*}(G)$ has a $p$-torsion, then $p$ divides the torsion index $t(G)$. Torsion index for simply connected compact Lie groups are completely determined by Totaro To1, To2.

Lemma 3.8. (【Ya4) Let $\tilde{b}=b_{i_{1}} \ldots b_{i_{k}}$ in $S(t)$ such that in $H^{*}(G / T)$

$$
\tilde{b}=p^{s}\left(y_{t o p}+\sum y t\right), \quad|t|>0
$$

for some $y \in P(y)$ and $t \in S(t)^{+}$. Then $t(G)_{(p)} \leq p^{s}$.

## 4. Filtrations of $K$-Theories

In this section, we recall the properties of the graded rings $g r_{\text {top }}^{*}(X), g r_{g e o}^{*}(X)$, $g r_{\gamma}^{*}(X)$ related to AHss and Chern classes. For their definition, see [Ga-Za], [Za], [Ju], [To3], [Ya3,5]), while definition itself is not used in this paper.

Let $X$ be a topological space. Let $K_{\text {top }}^{*}(X)$ be the complex $K$-theory. Consider the AHss

$$
E_{2}^{*, *^{\prime}}(X) \cong H^{*}(X) \otimes K_{t o p}^{*^{\prime}} \Longrightarrow K_{\text {top }}^{*}(X)
$$

Then $g r_{\text {top }}^{*}(X)$ is characterized as
Lemma 4.1. (Atiyah At]) $g r_{\text {top }}^{*}(X) \cong E_{\infty}^{*, 0}(X)$.
Let $X$ be a smooth algebraic variety over a subfield $k$ of $\mathbb{C}$. Let $K_{\text {alg }}^{*}(X)$ be the algebraic $K$-theory. This $K$-theory can be written by the motivic $K$-theory $A K^{*, *^{\prime}}(X)($ Vo1, Vo2, Ya1 $)$, i.e., $K_{\text {alg }}^{i}(X) \cong \oplus_{j} A K^{2 j-i, j}(X)$. In particular $K_{\text {alg }}^{0}(X) \cong A K^{2 *, *}(X)$. We recall the motivic AHss (Ya1, Ya2])

$$
A E_{2}^{*, *^{\prime}, *^{\prime \prime}}(X) \cong H^{*, *^{\prime}}\left(X ; K^{*^{\prime \prime}}\right) \Longrightarrow A K^{*, *^{\prime}}(X)
$$

where $K^{2 *}=A K^{2 *, *}(p t$.$) . Here we have$

$$
A E_{2}^{2 *, *, *^{\prime \prime}}(X) \cong H^{2 *, *}\left(X ; K^{*^{\prime \prime}}\right) \cong C H^{*}(X) \otimes K^{*^{\prime \prime}}
$$

Hence $A E_{\infty}^{2 *, *, 0}(X)$ is a quotient of $C H^{*}(X)$, since $d_{r} A E_{r}^{2 *, *, *^{\prime \prime}}(X)=0$ for smooth $X$. Then $g r_{g e o}^{*}(X)$ is characterized as
Lemma 4.2. (To3], Lemma 6.2 in [Ya3]) We have

$$
g r_{g e o}^{2 *}(X) \cong A E_{\infty}^{2 *, *, 0}(X) \cong C H^{*}(X) / I(1)
$$

where $I(1)=\cup_{r} \operatorname{Im}\left(d_{r}\right)$.
Lemma 4.3. (To3], Ya3]) The realization induces $g r_{\text {geo }}^{*}(X) \rightarrow g r_{\text {top }}^{*}(X(\mathbb{C}))$.
At last, we consider the gamma filtration. Let $\lambda^{i}(x)$ be the exterior power of the vector bundle $x \in K_{\text {alg }}^{0}(X)$ and $\lambda_{t}(x)=\sum \lambda^{i}(x) t^{i} \in K_{\text {alg }}^{*}(X)[t]$. The total $\gamma$-class is defined by $\lambda_{t /(1-t)}(x)=\gamma_{t}(x)$ so that $\gamma^{i}(x) \in K_{a l g}^{0}(X)$ if so is $x$. The gamma filtration is defined by using this $\gamma^{i}(x)$, which relates Chern classes as so does $\lambda^{i}(x)$. There is a natural map $g r_{\gamma}^{*}(X) \rightarrow g r_{\text {geo }}^{*}(X)$.
Lemma 4.4. ( At, To3], Ya3]) The condition $g_{\gamma}^{2 *}(X) \cong g r_{\text {top }}^{2 *}(X)\left(\right.$ resp. $g r_{\gamma}^{2 *}(X) \cong$ $\left.g r_{\text {geo }}^{2 *}(X)\right)$ is equivalent to that $E_{\infty}^{2 *, 0}(X)$ (resp. $\left.A E_{\infty}^{2 *, *, 0}(X)\right)$ is (multiplicatively) generated by Chern classes in $H^{2 *}(X)$ (resp. $C H^{*}(X)$ ).

Recall that $A \tilde{K}(1)^{*, *^{\prime}}(X)$ is the algebraic Morava $K$-theory with $\tilde{K}(1)^{*}=$ $\mathbb{Z}_{(p)}\left[v_{1}, v_{1}^{-1}\right]$. The motivic $K$-theory $A K^{*, *^{\prime}}(X)$ is written by using this Morava $K$-theory $A \tilde{K}(1)^{*, *^{\prime}}(X)$ and the Bott periodicity $B$ with $\operatorname{deg}(B)=(-2,-1)$, as the topological case stated in $\S 2$ Ya3

$$
A \tilde{K}^{*, *^{\prime}}(X) \cong A \tilde{K}(1)^{*, *^{\prime}}(X) \otimes_{\tilde{K}(1) *} \mathbb{Z}\left[B, B^{-1}\right] \quad \text { with } v_{1}=B^{p-1}
$$

Lemma 4.5. (Ya3) Let $E(A K)_{r}$ (resp. $\left.E(A \tilde{K}(1))_{r}\right)$ be the AHss converging to $A K^{*, *^{\prime}}(X)$ (resp. $A \tilde{K}(1)^{*, *^{\prime}}(X)$ ). Then

$$
g r_{g e o}^{2 *}(X) \cong E(A K)_{\infty}^{2 *, *, 0} \cong E(A \tilde{K}(1))_{\infty}^{2 *, *, 0}
$$

From the above lemmas, it is sufficient to consider the Morava $K$-theory $A \tilde{K}(1)^{2 *, *}(X)$ when we want to study $A K^{2 *, *}(X)$. For ease of notations, let us write simply (for smooth $X$ )

$$
K^{2 *}(X)=A \tilde{K}(1)^{2 *, *}(X), \quad \text { so that } K^{*}(p t .) \cong \mathbb{Z}_{(p)}\left[v_{1}, v_{1}^{-1}\right]
$$

and $k^{2 *}(X)=A \tilde{k}(1)^{2 *, *}(X)$, so that $k^{*}(p t.) \cong \mathbb{Z}_{(p)}\left[v_{1}\right]$. Hereafter of this paper, we only use this Morava $K$-theory $K^{2 *}(X)$ instead of $A K^{2 *, *}(X)$ or $K_{\text {alg }}^{0}(X)$.

For each $n>1$ we can also define the integral Morava $\tilde{K}(n)^{*}$-theory and let $\operatorname{gr}(n)^{*}(X)$ be the induced graded ring, that is,

$$
g r(n)^{*}(X)=E(A \tilde{K}(n))_{\infty}^{2 *, *, 0}
$$

where $E(A \tilde{K}(n))_{r}^{*, *^{\prime}, *^{\prime \prime}}$ is the AHss converging to the motivic integral Morava K-theory $A \tilde{K}(n)^{*, *^{\prime}}(X)$. In particular, we see $\operatorname{gr}(1)^{*}(X) \cong g r_{g e o}^{*}(X)$. The case $n=2$, the ring $\operatorname{gr}(2)^{*}(X)$ will used in $\S 10$ below.

We have the surjection $E_{2}^{2 *, *, 0} \cong C H^{*}(X) \rightarrow E_{\infty}^{2 *, *, 0} \cong \operatorname{gr}(n)^{*}(X)$, which induces the isomorphism

$$
C H^{*}(X) / I(n) \cong g r(n)^{*}(X), \quad I(n): \text { ideal in } C H^{*}(X)
$$

Note that for a sufficient large $n$, we see $I(n)=0$, but res : $A \tilde{K}(n)^{*}(X) \rightarrow$ $A \tilde{K}(n)^{*}(\bar{X})$ is far from an isomorphism. Moreover, it seems that there is no direct relation to $g r_{\gamma}^{*}(X)$, when $n>1$.

Hereafter this paper, for ease of notations, we write

$$
\tilde{k}(n)^{*}(X)=A \tilde{k}(n)^{*}(X), \quad \text { and } \quad \tilde{K}(n)^{*}(X)=\tilde{k}(n)^{*}(X)\left[v_{n}^{-1}\right]
$$

so that $\tilde{k}(n)^{*} \cong \mathbb{Z}_{(p)}\left[v_{n}\right] .\left(\right.$ So $K^{*}(X)=\tilde{K}(1)^{*}(X)$.)
Similar but different approaches using the Morava $K(n)$-theory are given by Sechin and Semenov Sec-Se, Sec.

At last of this section, we consider the restriction map $\operatorname{res}_{K}: K^{*}(X) \rightarrow K^{*}(\bar{X})$. By Panin [Pa], it is known that $K_{\text {alg }}^{0}(\mathbb{F})$ is torsion free for each twisted flag varieties $\mathbb{F}=\mathbb{G} / B_{k}$. For each simply connected Lie group $G$, it is well known that $r e s_{K}$ is surjective from Chevalley. Hence we have

Theorem 4.6. (Chevalley, Panin Pa ) When $G$ is simply connected, res $_{K}$ is an isomorphism. This implies $K^{*}(\mathbb{F}) \cong K^{*}(\overline{\mathbb{F}}) \cong K^{*}(G / T)$.

Hence we see $g r_{\gamma}(\mathbb{F}) \cong g r_{\gamma}\left(G_{k} / B_{k}\right) \cong g r_{\gamma}(G / T)$. Moreover if $\mathbb{G}$ is versal, then we have $g r_{\gamma}(\mathbb{F}) \cong g r_{g e o}^{*}(\mathbb{F})$ from Theorem 3.1 and Lemma 4.4. Thus we have Lemma 1.1 in the introduction.

## 5. CONNECTIVE $K$-THEORY $k^{*}(\bar{R}(\mathbb{G}))$

Let $h^{*}(-)$ be one of coneccted oriented integral theories $\Omega^{*}(X), k^{*}(-)=\tilde{k}(1)^{*}(X)$, $\tilde{k}(n)^{*}(X)$. . Since $H^{*}(G / T)$ is torsion free and the AHss collapses, we have the $h^{*}$-algebra isomorphism

$$
h^{*}(\overline{\mathbb{F}}) \cong h^{*}(G / T) \cong h^{*}\left[y_{1}, \ldots, y_{k}\right] \otimes S(t) /\left(p_{1}, \ldots, p_{r}, \bar{b}_{1}, \ldots, \bar{b}_{\ell}\right)
$$

where $p_{i}=y_{i}^{p^{r_{i}}} \bmod \left(S(t)^{+}\right), \bar{b}_{i}=b_{i} \bmod \left(I_{\infty} S(t)^{+}\right)$.
Recall that additively

$$
h^{*}\left(\bar{R}(\mathbb{G}) / p \cong h^{*}(\overline{\mathbb{F}}) /\left(p, S(t)^{+}\right) \cong h^{*} \otimes P(y) / p\right.
$$

(Recall $h^{*}(\mathbb{T}) \cong h^{*}(\overline{\mathbb{T}})$ for the Tate motive $\mathbb{T}$ in Theorem 3.3, and it is contained in $h^{*} \otimes S(t)^{+}$.) Hence we can identify

$$
h^{*}(\overline{\mathbb{F}}) \supset h^{*} \otimes P(y) \xrightarrow{(*)} h^{*}(\bar{R}(\mathbb{G})) \cong h^{*} \otimes P(y)
$$

where $(*)=\left.p r\right|_{k^{*} \otimes P(y)}$ is additive isomorphism.
For the following Lemma 5.1-Corollary 5.5, we assume $h^{*}(X)=\tilde{k}(n)^{*}(X)$. (However, note $\tilde{K}(n)^{*}(\overline{\mathbb{F}}) \not \not K K(n)^{*}(\mathbb{F})$ for $n \geq 2$, in general.)

From Lemma 4.3, we see

$$
\begin{gathered}
g r(n)^{*}(X) / p \cong C H^{*}(X) /(p, I(n)) \\
\cong\left(h^{*}(X) \otimes_{h^{*}} \mathbb{Z} / p\right) / I(n) \cong h^{*}(X) /\left(I(n), I_{\infty}\right) .
\end{gathered}
$$

Here note $I(n)$ is the ideal of (higher) $v_{n}$-torsion elements in $h^{*}(X) \otimes_{h^{*}} \mathbb{Z} / p$. Hence for $a \in h^{m}(X)$, the following conditions are equivalent

$$
a=0 \in \operatorname{gr}(n)^{m}(X) / p \quad \Longleftrightarrow \quad a \in\left(I_{\infty}, I(n)\right) h^{*}(X)
$$

Lemma 5.1. Let $a \neq 0 \in \tilde{K}(n)^{0}(X)$. Then there is $s \geq 0$ such that $v_{1}^{-s} a=a^{\prime} \in$ $k^{*}(X), a^{\prime} \neq 0 \in \operatorname{gr}(n)^{2 s}(X)$, and $a^{\prime} \notin \operatorname{Im}\left(I_{\infty} h^{*}(X)\right)$.
Proof. Suppose that $a \neq 0 \in \tilde{K}(n)^{0}(X)$. Since $K(n)^{*}(X) \cong h^{*}(X)\left[v_{1}^{-1}\right]$, there is $s$ such that

$$
a=v_{n}^{s} a^{\prime} \quad \text { for some } a^{\prime} \in h^{2 s}(X)
$$

Let us take the largest such $s$. Then $a^{\prime}$ is a $k^{*}$ module generator of $h^{*}(X) / p$. So $s$ must be nonnegative.

Lemma 5.2. For $a \in h^{m}(\bar{R}(\mathbb{G})) \subset h^{*} \otimes P(y)$, if $a=0 \in \operatorname{gr}(n)^{*}(R(\mathbb{G})) / p$, then

$$
a \in \operatorname{Im}\left(I_{\infty} A(b)\right) \subset h^{*}(\bar{R}(\mathbb{G})) \cong h^{*} \otimes P(y)
$$

Proof. The fact $a=0 \in \operatorname{gr}(n)^{*}(R(\mathbb{G})) / p$ implies that $a \in I_{\infty} h^{*}(R(\mathbb{G}))$ in $h^{*}(\bar{R}(\mathbb{G})) \cong$ $k^{*} \otimes P(y)$ (which is no $v_{n}$-torsion). When $\mathbb{G}$ is versal, we see

$$
a=0 \quad \bmod \left(I_{\infty}\left(h^{*}(R(\mathbb{G}))\right)=\bmod \left(I_{\infty}\left(h^{*} \otimes S(t)\right)\right)=\bmod \left(I_{\infty} \otimes A(b)\right)\right.
$$

in $h^{m}(\bar{R}(\mathbb{G}))$.
The converse of the above lemma seems difficult to show. We only see
Lemma 5.3. If $a \neq 0 \in \operatorname{gr}(n)^{m}(R(\mathbb{G})) / p$ and $a \in \operatorname{Im}\left(I_{\infty} A(b)\right) \subset h^{*} \otimes P(y) / p$, then there is $a^{\prime} \in \operatorname{Im}\left(I_{\infty} A(b) \subset h^{*}(R(\mathbb{G})) / p\right.$ such that $a-a^{\prime}=0 \in \operatorname{gr}(n)^{m}(X)$.

From Lemma 3.5, we show additively

$$
\operatorname{Ker}(p r)=k^{*} \otimes P(y) \otimes S(t)^{+} /(b) \subset h^{*}(\mathbb{F}) \cong k^{*} \otimes H^{*}(G / T)
$$

Lemma 5.4. Let $y, y^{\prime} \in h^{*} \otimes P(y) \subset h^{*}(\mathbb{F})$. Moreover $a, a^{\prime} \in \operatorname{Ker}(p r)$ with $a \in I_{\infty}^{s} h^{*}(\overline{\mathbb{F}}), a^{\prime} \in I_{\infty}^{r} h^{*}(\overline{\mathbb{F}})$. Then we have in $h^{*}(\overline{\mathbb{F}})$

$$
(y+a)\left(y^{\prime}+a^{\prime}\right)=y y^{\prime} \quad \bmod \left(\operatorname{Ker}(p r), I_{\infty}^{s+r+1}\right)
$$

That is, $\operatorname{pr}\left((y+a)\left(y^{\prime}+a^{\prime}\right)\right)=\operatorname{pr}\left(y y^{\prime}\right)$ in $h^{*}(\bar{R}(\mathbb{G})) /\left(I_{\infty}^{s+r+1}\right)$.

Proof. Let $x=y+a, x^{\prime}=y^{\prime}+a^{\prime} \in h^{*}(\overline{\mathbb{F}})$ and $a \in I_{\infty}^{r} h^{*}(\overline{\mathbb{F}})$. From Lemma 3.5, we can write

$$
a=\sum a_{I} y_{I} t_{I} \quad a_{I} \in I_{\infty}^{s}, \quad t_{I} \in S(t)^{+} /(b) \quad \text { in } h^{*}(\overline{\mathbb{F}}) .
$$

Similarly we take $a^{\prime}=\sum a_{I^{\prime}} y_{I^{\prime}} t_{I^{\prime}}$. Then

$$
x \cdot x^{\prime}-y \cdot y^{\prime}=x_{1}+x_{2} \quad \text { in } h^{*}(\overline{\mathbb{F}})
$$

with $x_{1}=y \sum a_{I^{\prime}} y_{I^{\prime}} t_{I^{\prime}}+y^{\prime} \sum a_{I} y_{I} t_{I}, \quad$ and $\quad x_{2}=\left(\sum a_{I} y_{I} t_{I}\right)\left(\sum a_{I^{\prime}}^{\prime} y_{I^{\prime}} t_{I^{\prime}}\right)$.
Here we see $\operatorname{pr}\left(x_{1}\right)=0$ also from Lemma 3.5. Let us write

$$
\begin{gathered}
x_{2}=x_{21}+x_{22} \quad \text { with } x_{21}=\sum a_{I^{\prime \prime}} y_{I^{\prime \prime}} t_{I^{\prime \prime}}, a_{I^{\prime \prime}} \in I_{\infty}^{r+s} \\
\text { and } \quad x_{22}=\sum a_{J} y_{J} t_{J} b_{J} \text { with } a_{J} \in I_{\infty}^{r+s}, b_{J} \in A_{(p)}^{+}(b)=\mathbb{Z}_{(p)}\left[b_{1}, \ldots, b_{\ell}\right]^{+}
\end{gathered}
$$

Here we have $\operatorname{pr}\left(x_{21}\right)=0$ and $x_{22}=0 \bmod \left(I_{\infty}^{r+s+1}\right)$, since $b_{J} \in\left(I_{\infty}\right)$.
Corollary 5.5. Let $\operatorname{pr}\left(b_{i_{j}}\right)=\operatorname{pr}\left(b_{i_{j}}^{\prime}\right)$ for $b_{i}^{\prime} \in k^{*}(\overline{\mathbb{F}})$. Then

$$
\operatorname{pr}\left(b_{i_{1}} \ldots b_{i_{s}}\right)=\operatorname{pr}\left(b_{i_{1}}^{\prime} \ldots b_{i_{s}}^{\prime}\right) \quad \text { in } k^{*}(\bar{R}(\mathbb{G})) /\left(I_{\infty}^{s+1}\right)
$$

Proof. Let $x=b_{i_{1}} \ldots b_{i_{s-1}}$. Then $x \in I_{\infty}^{s-1}$. So $y=p r(x)$ and $a=x-y \in \operatorname{Ker}(p r)$ are also in $\left(I_{\infty}^{s-1}\right)$. Hence we have the result from the preceding lemma.

The results Lemma 5.1-Corollary 5.5 hold also for $\Omega^{*}(X)=k(\infty)^{*}(X)$. Here we identify $h^{*}(-)$ (resp. $\tilde{K}(n)^{*}(\infty), g r(\infty)^{*}(X), v_{n}$-torsion) by $\Omega^{*}(X)$ (resp. , $\left.\Omega^{*}(X)\left[v_{i}^{-1} \mid i \geq 1\right], g r(\infty)^{*}(n),\left(v_{i} \mid i \geq 1\right)\right)$.

## 6. The spin group $\operatorname{Spin}(2 \ell+1)$ and $p=2$

At first we consider the orthogonal groups $G=S O(m)$ and $p=2$, while it is not simply connected. The $\bmod (2)$-cohomology is written as ( see for example (Mi-Tod, Ni )

$$
\operatorname{gr} H^{*}(S O(m) ; \mathbb{Z} / 2) \cong \Lambda\left(x_{1}, x_{2}, \ldots, x_{m-1}\right)
$$

where $\left|x_{i}\right|=i$, and the multiplications are given by $x_{s}^{2}=x_{2 s}$.
For ease of argument, we only consider the case $m=2 \ell+1$ so that

$$
\begin{gathered}
H^{*}(G ; \mathbb{Z} / 2) \cong P(y) \otimes \Lambda\left(x_{1}, x_{3}, \ldots, x_{2 \ell-1}\right) \\
\operatorname{grP} P(y) / 2 \cong \Lambda\left(y_{2}, \ldots, y_{2 \ell}\right), \quad \text { letting } y_{2 i}=x_{2 i} \quad\left(\text { hence } y_{4 i}=y_{2 i}^{2}\right)
\end{gathered}
$$

The Steenrod operation is given as $S q^{k}\left(x_{i}\right)=\binom{i}{k}\left(x_{i+k}\right)$. The $Q_{i}$-operations are given by Nishimoto Ni

$$
Q_{n} x_{2 i-1}=y_{2 i+2^{n+1}-2}, \quad Q_{n} y_{2 i}=0
$$

It is well known that the transgression $b_{i}=d_{2 i}\left(x_{2 i-1}\right)=c_{i}$ is the $i$-th elementary symmetric function on $S(t)$. Moreover we see that $Q_{0}\left(x_{2 i-1}\right)=y_{2 i}$ in $H^{*}(G ; \mathbb{Z} / 2)$. From Corollary 2.1, we have
Corollary 6.1. In $B P^{*}(G / T) / I_{\infty}^{2}$, we have

$$
c_{i}=2 y_{2 i}+\sum_{n \geq 1} v_{n} y\left(2 i+2^{n+1}-2\right)
$$

for some $y(j)$ with $\pi^{*}(y(j))=y_{j}$.
We have $c_{i}^{2}=0$ in $C H^{*}(\mathbb{F}) / 2$ from the natural inclusion $S O(2 \ell+1) \rightarrow S p(2 \ell+1)$ (see $\overline{\mathrm{Pe}}], \mathrm{Ya} 4]$ ) for the symplectic group $S p(2 \ell+1)$. Thus we have

Theorem 6.2. ([Pe, Ya4]) Let $(G, p)=(S O(2 \ell+1), 2)$ and $\mathbb{F}=\mathbb{G} / B_{k}$ be versal. Then $C H^{*}(\mathbb{F})$ is torsion free, and

$$
C H^{*}(\mathbb{F}) / 2 \cong S(t) /\left(2, c_{1}^{2}, \ldots, c_{\ell}^{2}\right), \quad C H^{*}(R(\mathbb{G})) / 2 \cong \Lambda\left(c_{1}, \ldots, c_{\ell}\right)
$$

Corollary 6.3. We have $\operatorname{gr}(\mathbb{F}) \cong g r_{\text {geo }}(\mathbb{F}) \cong C H^{*}(\mathbb{F})$.
From Corollary 2.2, we see $c_{i}=2 y_{i}+v_{1} y_{2 i+2} \bmod \left(v_{1}^{2}\right)$. Here we consider the $\bmod (2)$ theory version $\operatorname{res}_{K / 2}: K^{*}(\mathbb{F}) / 2 \rightarrow K^{*}(\overline{\mathbb{F}}) / 2$.

Lemma 6.4. We have $\operatorname{Im}\left(\right.$ res $\left._{K / 2}\right) \cong K^{*} \otimes \Lambda\left(y_{2 i} \mid 2 i \geq 4\right)$. Hence res ${ }_{K}$ is not surjective.

Now we consider $\operatorname{Spin}(2 \ell+1)$. Throughout this section, let $p=2, G=S O(2 \ell+$ 1) and $G^{\prime}=\operatorname{Spin}(2 \ell+1)$. It is well known that $G / T \cong G^{\prime} / T^{\prime}$ for the maximal torus $T^{\prime}$ of the spin group.

By definition, we have the 2 covering $\pi: G^{\prime} \rightarrow G$. It is well known that $\pi^{*}: H^{*}(G / T) \cong H^{*}\left(G^{\prime} / T^{\prime}\right)$. Let $2^{t} \leq \ell<2^{t+1}$, i.e. $t=\left[\log _{2} \ell\right]$. The $\bmod 2$ cohomology is

$$
\begin{gathered}
H^{*}\left(G^{\prime} ; \mathbb{Z} / 2\right) \cong H^{*}(G ; \mathbb{Z} / 2) /\left(x_{1}, y_{2}\right) \otimes \Lambda(z) \\
\cong P(y)^{\prime} \otimes \Lambda\left(x_{3}, x_{5}, \ldots, x_{2 \ell-1}\right) \otimes \Lambda(z), \quad|z|=2^{t+2}-1
\end{gathered}
$$

where $P(y) \cong \mathbb{Z} / 2\left[y_{2}\right] /\left(y_{2}^{2^{t+1}}\right) \otimes P(y)^{\prime}$. (Here $z$ is defined by $d_{2^{t+2}}(z)=y^{2^{t+1}}$ for $0 \neq y \in H^{2}(B \mathbb{Z} / 2 ; \mathbb{Z} / 2)$ in the spectral sequence induced from the fibering $G^{\prime} \rightarrow G \rightarrow B \mathbb{Z} / 2$.) Hence

$$
\operatorname{grP}(y)^{\prime} \cong \otimes_{2 i \neq 2^{j}} \Lambda\left(y_{2 i}\right) \cong \Lambda\left(y_{6}, y_{10}, y_{12}, \ldots, y_{2 \bar{\ell}}\right)
$$

where $\bar{\ell}=\ell-1$ if $\ell=2^{j}$ for some $j$, and $\bar{\ell}=\ell$ otherwise.
The $Q_{i}$ operation for $z$ is given by Nishimoto Ni ]

$$
Q_{0}(z)=\sum_{i+j=2^{t+1}, i<j} y_{2 i} y_{2 j}, \quad Q_{n}(z)=\sum_{i+j=2^{t+1}+2^{n+1}-2, i<j} y_{2 i} y_{2 j} \quad \text { for } n \geq 1
$$

We know that

$$
\operatorname{gr} H^{*}\left(G^{\prime} / T^{\prime}\right) / 2 \cong P(y)^{\prime} \otimes S\left(t^{\prime}\right) /\left(2, c_{2}^{\prime}, \ldots ., c_{\ell}^{\prime}, c_{1}^{2^{t+1}}\right)
$$

Here $c_{i}^{\prime}=\pi^{*}\left(c_{i}\right)$ and $d_{2^{t+2}}(z)=c_{1}^{2^{t+1}}$ in the spectral sequence converging $H^{*}\left(G^{\prime} / T^{\prime}\right)$.
Take $k$ such that $\mathbb{G}$ is a versal $G_{k}$-torsor so that $\mathbb{G}_{k}^{\prime}$ is also a versal $G_{k}^{\prime}$-torsor. Let us write $\mathbb{F}=\mathbb{G} / B_{k}$ and $\mathbb{F}^{\prime}=\mathbb{G}^{\prime} / B_{k}^{\prime}$. Then

$$
C H^{*}\left(\bar{R}\left(\mathbb{G}^{\prime}\right)\right) / 2 \cong P(y)^{\prime} / 2, \quad \text { and } \quad C H^{*}(\bar{R}(\mathbb{G})) / 2 \cong P(y) / 2
$$

The Chow ring $C H^{*}\left(R\left(\mathbb{G}^{\prime}\right)\right) / 2$ is not computed yet (for general $\ell$ ), while we have the following lemmas.

Lemma 6.5. Let $2^{t} \leq \ell<2^{t+1}$ and $\mathbb{G}$ be versal. Then there is a surjection

$$
\Lambda\left(c_{2}^{\prime}, \ldots c_{\bar{\ell}}^{\prime}\right) \otimes \mathbb{Z} / 2\left[c_{1}^{2^{t+1}}\right] \rightarrow C H^{*}\left(R\left(\mathbb{G}^{\prime}\right)\right) / 2
$$

Let $G^{\prime \prime}=\operatorname{Spin}(2 \ell+2)$. Then the inclusion $i: G^{\prime} \subset G^{\prime \prime}$ induces

$$
C H^{*}\left(\bar{R}\left(\mathbb{G}^{\prime \prime}\right)\right) \cong P(y)^{\prime} \stackrel{i^{*}}{\cong} C H^{*}\left(\bar{R}\left(\mathbb{G}^{\prime}\right)\right)
$$

Hence by a (main) theorem by Vishik-Zainoulline Vi-Za, we have
Lemma 6.6. Let $G^{\prime}=\operatorname{Spin}(\ell+1)$ and $G^{\prime \prime}=\operatorname{Spin}(2 \ell+2)$. Then $R\left(\mathbb{G}^{\prime}\right) \cong R\left(\mathbb{G}^{\prime \prime}\right)$.

Therefore, in this paper, we consider only $G=\operatorname{Spin}(2 \ell+1)$, but the arguments for $G=\operatorname{Spin}(2 \ell+2)$ are similar.
Lemma 6.7. The restriction res $_{K}: K^{*}\left(\mathbb{F}^{\prime}\right) \rightarrow K^{*}\left(\overline{\mathbb{F}}^{\prime}\right)$ is isomorphic. In fact, we have $K^{*}\left(R\left(\mathbb{G}^{\prime}\right)\right) / 2 \cong K^{*} / 2 \otimes \Lambda\left(c_{i}^{\prime} \mid i \neq 2^{j}-1\right)$.

$$
\text { 7. } \operatorname{Spin}(7), \operatorname{Spin}(9)
$$

From this section to the last section, we only consider $G=\operatorname{Spin}(2 \ell+1)$. Hereafter in this paper, we change notations as follows. Let us write the element $c_{1}^{j}$, in the preceding section, by $e_{j}$, and take off the dash of $c_{i}^{\prime}$, i.e.

$$
e_{2^{t+1}}=c_{1}^{2^{t+1}}, \quad c_{2}=c_{2}^{\prime}, c_{3}=c_{3}^{\prime}, \ldots, c_{\ell}=c_{\ell}^{\prime}
$$

Now we consider examples. For groups $\operatorname{Spin}(7), \operatorname{Spin}(9)$, the rank $\ell=3,4$ respectively and the cohomology is given

$$
\operatorname{gr} H^{*}(G ; \mathbb{Z} / 2) \cong\left\{\begin{array}{l}
\mathbb{Z} / 2\left[y_{6}\right] /\left(y_{6}^{2}\right) \otimes \Lambda\left(x_{3}, x_{5}, z_{7}\right) \quad G=\operatorname{Spin}(7) \\
\mathbb{Z} / 2\left[y_{6}\right] /\left(y_{6}^{2}\right) \otimes \Lambda\left(x_{3}, x_{5}, x_{7}, z_{15}\right) \quad G=\operatorname{Spin}(9)
\end{array}\right.
$$

We can take $v_{1} y_{6}=c_{2}, 2 y_{6}=c_{3}$ in $k^{*}(\overline{\mathbb{F}})$. The Chow groups of the Rost motives $R(\mathbb{G})$ ) are isomorphic

$$
C H^{*}(R(\mathbb{G})) \cong g r_{\gamma}^{*}(R(\mathbb{G})) \cong \mathbb{Z}_{(2)}\left\{1, c_{3}\right\} \oplus \mathbb{Z} / 2\left\{c_{2}\right\}
$$

The Chow ring of the flag manifolds are Ya4

$$
g r_{\gamma}(G / T) \cong C H^{*}(\mathbb{F}) \cong\left\{\begin{array}{l}
S(t) /\left(2 c_{2}, c_{2}^{2}, c_{3}^{2}, c_{2} c_{3}, e_{4}\right) \quad G=\operatorname{Spin}(7), \ell=3 \\
S(t) /\left(2 c_{2}, c_{2}^{2}, c_{3}^{2}, c_{2} c_{3}, e_{8}, c_{4}\right) \quad G=\operatorname{Spin}(9), \ell=4
\end{array}\right.
$$

where $S(t)=\mathbb{Z}_{(2)}\left[t_{1}, \ldots, t_{\ell}\right]$.

## 8. $\operatorname{Spin}(11)$

In this section we consider $G=\operatorname{Spin}(11)$. The cohomology is written as

$$
H^{*}(G ; \mathbb{Z} / 2) \cong \mathbb{Z} / 2\left[y_{6}, y_{10}\right] /\left(y_{6}^{2}, y_{10}^{2}\right) \otimes \Lambda\left(x_{3}, x_{5}, x_{7}, x_{9}, z_{15}\right)
$$

By Nishimoto, we know $Q_{0}\left(z_{15}\right)=y_{6} y_{10}$. It implies $2 y_{6} y_{10}=d_{16}\left(z_{15}\right)=e_{8}$. Since $y_{\text {top }}=y_{6} y_{10}$, we have $t(G)=2$. From Corollary 2.1, we can take in $k^{*}(\overline{\mathbb{F}})$ such that $c_{2}=v_{1} y_{6}, c_{4}=v_{1} y_{10}$. Moreover in $k^{*}(\overline{\mathbb{F}}) /\left(I_{\infty}^{2}\right)$ we have $c_{3}=2 y_{6}, c_{5}=2 y_{10}$.

Lemma 8.1. For $x \in k^{*} \otimes S(t)$, let $x \in I_{\infty}^{3} k^{*}(\overline{\mathbb{F}})$. Then $x \in I_{\infty} \cdot S(t)$, i.e., $x=0$ in $g r_{\gamma}(\mathbb{F}) / 2$.

Proof. Take off product of $c_{i}$ and $t \neq 0 \in S(t) /(b)$ from $x$, we get the result. For example, let $x=8 y_{6} y_{10} \bmod \left(4 v_{1}\right)$. We consider $x^{\prime}=x-2 c_{3} c_{5}$ or $x^{\prime}=x-4 e_{8}$. Then $x^{\prime} \in I_{\infty}^{3}$ and $\left|x^{\prime}\right|>|x|$. Since $x=0 \in C H^{*}(\mathbb{F}) / 2$ for $|x|>2 \operatorname{dim}(\mathbb{F})$, we get the result, by continuing this argument.

Theorem 8.2. (Ka2, Ya4, Ya5]) For $(G, p)=(\operatorname{Spin}(11), 2)$, we have the isomorphisms

$$
g r_{\gamma}(R(\mathbb{G})) / 2 \cong \mathbb{Z} / 2\left\{1, c_{2}, c_{3}, c_{4}, c_{5}, c_{2} c_{4}, e_{8}\right\}
$$

where $c_{2} c_{4}=\operatorname{pr}\left(c_{2} \cdot c_{4}\right)$ for the cup product $\cdot \operatorname{in} \operatorname{gr}_{\gamma}^{*}(\mathbb{F})$, and

$$
g r_{\gamma}(\mathbb{F}) / 2 \cong S(t) /\left(2, c_{i} c_{j}, c_{i} e_{8}, e_{8}^{2} \mid 2 \leq i \leq j \leq 5,(i, j) \neq(2,4)\right)
$$

Proof. We will compute $g r_{\text {geo }}^{*}(R(\mathbb{G})) / 2 \cong g r_{\gamma}^{*}(R(\mathbb{G})) / 2$. Consider the restriction map res ${ }_{K}$

$$
K^{*}(R(\mathbb{G})) \cong K^{*}\left\{1, c_{2}, c_{4}, c_{2} c_{4}\right\} \xlongequal{\rightrightarrows} K^{*}\left\{1, y_{6}, y_{10}, y_{6} y_{10}\right\} \cong K^{*}(\bar{R}(\mathbb{G}))
$$

by $\operatorname{res}_{K}\left(c_{2}\right)=v_{1} y_{6}, \operatorname{res}_{K}\left(c_{4}\right)=v_{1} y_{10}$ in $K^{*}(\overline{\mathbb{F}})$. Note $c_{2} c_{4} \neq 0 \in C H^{*}(R(\mathbb{G})) / 2$, from the fact that $v_{1} y_{6} y_{10} \notin \operatorname{Im}\left(\right.$ res $\left._{K}\right)$.

Next using $\operatorname{res}_{K}\left(c_{3}\right)=2 y_{6}, \operatorname{res}_{K}\left(c_{5}\right)=2 y_{10}$, and $\operatorname{res}_{K}\left(e_{8}\right)=2 y_{6} y_{10}$, we have

$$
\operatorname{gr} K^{*}(R(\mathbb{G})) \cong K^{*} / 2\left\{c_{2}, c_{4}, c_{2} c_{4}\right\} \oplus K^{*}\left\{1, c_{3}, c_{5}, e_{8}\right\}
$$

From this, we show the first isomorphism. Note generators $c_{2}, \ldots, e_{8}$ are all nonzero in $C H^{*}(R(\mathbb{G})) / 2$ by Corollary 3.7. (Of course $e_{8} \neq 0$ and $e_{8}^{2}=0$ in $C H^{*}(R(\mathbb{G})) / 2$, since $y_{6} y_{10} \notin r e s_{C H}$ and $\left.\left|e_{8}^{2}\right|>\left|y_{6} y_{10}\right|\right)$

Let us write $y_{6}^{2}=y_{6} t+y_{10} t^{\prime} \in C H^{*}(\overline{\mathbb{F}}) / 2$ for $t \in S(t)$. Then

$$
\left.c_{2} c_{3}=2 v_{1} y_{6}^{2}=2 v_{1}\left(y_{6} t+y_{10} t\right)^{\prime}=v_{1}\left(c_{3} t+c_{5} t^{\prime}\right) \quad \text { in } K^{*}(\overline{\mathbb{F}}) \cong K^{( } \mathbb{F}\right)
$$

Hence we see $c_{2} c_{3}=0$ in $C H^{*}(\mathbb{F}) / I(1) \cong g r_{\gamma}^{*}(\overline{\mathbb{F}})$. We also note

$$
c_{2} c_{5}=c_{3} c_{4}=v_{1} e_{8}, \quad c_{3} c_{5}=4 y_{6} y_{10}=2 e_{8} \quad \text { in } K^{*}(\overline{\mathbb{F}}) \quad\left(\text { so in } k^{*}(\overline{\mathbb{F}})\right)
$$

By arguments for $\operatorname{gr}_{\text {geo }}^{*}(\mathbb{F})$, similar to Lemma 3.4, we can show the second isomorphism. For example,

$$
x=c_{2} e_{8}=v_{1} y_{6} \cdot 2 y_{6} y_{10}=v_{1}\left(2 y_{6}^{2} y_{10}\right)=v_{1}\left(2 y_{6} t+2 y_{10} t^{\prime}\right)
$$

Then we consider $x^{\prime}=x-v_{1}\left(c_{3} t+c_{5} t^{\prime}\right)$. Then $\left|x^{\prime}\right|>|x|$, and continue this argument, we get the result.

The other cases are proved similarly.
Karpenko computes $C H^{*}(\mathbb{F})$ and proves $(\boxed{\mathrm{Ka} 2})$ the following theorem.
Theorem 8.3. (【Ka2) Let $G=\operatorname{Spin}(11)$ and $\mathbb{G}$ be versal. Then $\operatorname{gr}_{\gamma}(R(\mathbb{G})) \cong$ $C H^{*}(R(\mathbb{G}))$.

Proof. (Karpenko Ka2]) We consider the following commutative diagram


Since $C H^{*}(\bar{R}(\mathbb{G}))$ is torsion free, the both norm maps $N$ are injective. Hence if $f_{2}$ is isomorphic, then so is $f_{1}$.

The norm map $N$ is given by (using res $\cdot N \cdot$ res $=2$ res and $C H^{*}(\bar{R}(\mathbb{G}))$ is torsion free)

$$
N\left(y_{6}\right)=c_{3}, \quad N\left(y_{10}\right)=c_{5}, \quad N\left(y_{6} y_{10}\right)=e_{8}
$$

Hence $C H^{*}(R(\mathbb{G})) / N$ (and $\left.g r_{g e o}^{*}(R(\mathbb{G})) / N\right)$ is isomorphic to a quotient of

$$
\Lambda_{\mathbb{Z}}\left(c_{2}, \ldots, c_{5}, e_{8}\right) / \operatorname{Ideal}\left(2, c_{3}, c_{5}, e_{8}\right) \cong \Lambda\left(c_{2}, c_{4}\right)
$$

We see from the preceding theorem that $\operatorname{grgeo}(R(\mathbb{G})) / N \cong \Lambda\left(c_{2}, c_{4}\right)$. So $f_{1}$ is isomorphic.

Hence the ring in Theorem 7.1 is isomorphic to $C H^{*}(\mathbb{F}) / 2$. Moreover, Karpenko conjectured

Conjecture 8.4. (Ka1, Ka2) Let $G$ be simply connected and $\mathbb{G}$ be a versal $G_{k}$-torsor. Then $C H^{*}(\mathbb{F}) \cong g r_{\gamma}^{*}(\mathbb{F})$.

We recall here the algebraic cobordism theory $\Omega^{*}(X)$ defined in $\S 4$. For a nonzero pure symbol $a$ in the Milnor $K$-theory $K_{n+1}^{M}(k) / 2$, let $V_{a}$ be the norm variety. The usual Rost motive $R_{n}$ is defined by as an irreducible motive $M\left(V_{a}\right)$.

Then we know ( $[\mathrm{Vi}-\mathrm{Ya}],[\mathrm{Ya}])$ that the restriction

$$
\operatorname{res}_{\Omega}: \Omega^{*}\left(R_{n}\right) \rightarrow \Omega^{*}\left(\bar{R}_{n}\right) \cong B P^{*}[y] /\left(y^{p}\right) \quad|y|=2\left(p^{n}-1\right) /(p-1)
$$

is an injection. Moreover, we have

$$
\operatorname{Im}\left(r e s_{\Omega}\right)=B P^{*}\{1\} \oplus I_{n} \otimes \mathbb{Z}_{(p)}[y]^{+} /\left(y^{p}\right)
$$

where $I_{n}=\left(p, \ldots, v_{n-1}\right)$ and $\mathbb{Z}_{(p)}[y]^{+} /\left(y^{p}\right)=\mathbb{Z}_{(p)}\left\{y, \ldots, y^{p-1}\right\}$.
When $G=\operatorname{Spin}(7), \operatorname{Spin}(9)$, the motive $R(\mathbb{G})) \cong R_{2}$ and $\operatorname{Im}\left(r e s_{\Omega}\right) \cong B P^{*}\{1\} \oplus$ $I_{2}\left\{y_{6}\right\}$. The similar fact holds for $R(\mathbb{G})$ with $G=\operatorname{Spin}(11)$.
Corollary 8.5. Let $G=\operatorname{Spin}(11)$ and $\mathbb{G}$ be versal. Then the restriction map

$$
r e s_{\Omega}: \Omega^{*}(R(\mathbb{G})) \rightarrow \Omega^{*}(\bar{R}(\mathbb{G})) \cong B P^{*}\left\{1, y_{6}, y_{10}, y_{6} y_{10}\right\}
$$

is an injection, and

$$
\operatorname{Im}\left(r e s_{\Omega}\right)=B P^{*}\{1\} \oplus\left(2, v_{1}\right)\left\{y_{6}, y_{10}\right\} \oplus\left(2, v_{1}^{2}\right)\left\{y_{6} y_{10}\right\}
$$

Proof. Since $C H^{*}(X) \otimes B P^{*} \cong g r \Omega^{*}(X)$, we have

$$
\operatorname{gr} \Omega^{*}(R(\mathbb{G})) \cong B P^{*} / 2\left\{c_{2}, c_{4}, c_{2} c_{4}\right\} \oplus B P^{*}\left\{1, c_{3}, c_{5}, e_{8}\right\}
$$

This induces an injection to

$$
\begin{aligned}
\operatorname{gr}\left(\operatorname{Im}_{\Omega}\right) \cong & B P^{*} / 2\left\{v_{1} y_{6}, v_{1} y_{10}, v_{1}^{2} y_{6} y_{10}\right\} \oplus B P^{*}\left\{1,2 y_{6}, 2 y_{10}, 2 y_{6} y_{10}\right\} \\
& \subset g r \Omega^{*}(\bar{R}(\mathbb{G}))=\Omega^{*}(\bar{R}(\mathbb{G})) / 2 \oplus 2 \Omega^{*}(\bar{R}(\mathbb{G}))
\end{aligned}
$$

We give here a conjecture
Conjecture 8.6. Let $G$ be a connected compact Lie group and $\mathbb{G}$ be a $G_{k}$-torsor. Then the restriction map

$$
r e s_{\Omega}: \Omega^{*}(R(\mathbb{G})) \rightarrow \Omega^{*}(\bar{R}(\mathbb{G})) \subset B P^{*} \otimes P(y)
$$

is injective, i.e., $\Omega^{*}(R(\mathbb{G}))$ is torsion free.
When $G$ is simply connected and $\mathbb{G}$ is versal, this conjecture is weaker than the Karpenko conjecture.

Lemma 8.7. If $K^{*}(X) \cong K^{*}(\bar{X})$ and $g r_{\text {geo }}^{*}(X) \cong C H^{*}(X)$, then the restriction map res $\Omega_{\Omega}$ is injective.
Proof. Let $0 \neq x \in \operatorname{Ker}\left(\operatorname{res}_{\Omega}\right)$. In the AHss $E_{r}^{2 *, *, *^{\prime}}$ converging to $\Omega^{*}(X)$, let

$$
x=a x^{\prime} \quad a \in B P^{*}, 0 \neq x^{\prime} \in C H^{*}(X)
$$

Suppose $a \in B P^{0} \cong \mathbb{Z}_{(p)}$, that is, $0 \neq x \in C H^{*}(X) \cong g r_{\text {geo }}^{*}(X)$. Hence $x$ is non-zero in $K^{*}(X) \cong K^{*}(\bar{X})$. Since $K^{*}(\bar{X}) \cong \Omega^{*}(\bar{X}) \otimes_{B P^{*}} K^{*}$, we see $0 \neq x \in \Omega^{*}(\bar{X})$, and this is a contradiction.

Suppose $a \in B P^{<0}$. Considering the Quillen operation $r_{p^{1} \Delta_{n-1}}\left(v_{n}\right)=v_{1}$ ( Ra , [Ha, Ya4). we can take the operation $r_{\alpha}$ such that

$$
r_{\alpha}\left(a x^{\prime}\right)=r_{\alpha}(a) \cdot x^{\prime}=\lambda v_{1}^{s} x^{\prime} \quad \text { for } \quad s, \lambda \in \mathbb{Z}
$$

Hence there is a nonzero element $\lambda^{\prime} x^{\prime} \neq 0 \in C H^{*}(X)$, for $\lambda^{\prime} \in \mathbb{Z}$, but it is $v_{1}^{s}$ torsion in $E_{\infty}^{2 *, *, *^{\prime}} \cong g r \Omega^{*}(X)$. Since $\Omega^{*}(X) \otimes_{B P^{*}} \mathbb{Z}_{(p)}\left[v_{1}, v_{1}^{-1}\right] \cong K^{*}(X)$, we see $0 \neq \lambda^{\prime} x^{\prime} \in I(1)$.

Remark. The converse of the above lemma is not correct. In fact, for the original Rost motive $R_{n}, g r_{\gamma}\left(R_{n}\right) \not \not C H^{*}\left(R_{n}\right)$ for $n \geq 3$, while $r e s_{\Omega}$ is injective.

## 9. $\operatorname{Spin}(13)$

In this section, we consider the case $\operatorname{Spin}(13)$, i.e., $\ell=6$. Then we have

$$
\operatorname{gr} P(y) \cong \Lambda\left(y_{6}, y_{10}, y_{12}\right)
$$

Hence $y_{\text {top }}=y_{6} y_{10} y_{12}$. Since $2^{t} \leq \ell<2^{t+1}$, so $t=2$. Hence $e_{8}$ exists in $C H^{*}(R(\mathbb{G}))$. Note $e_{8}^{2}=\operatorname{pr}\left(e_{8} \cdot e_{8}\right)=0$ in $C H^{*}(R(\mathbb{G}))$ since $\left|e_{8}^{2}\right|>\left|y_{t o p}\right|$. We also note $t(G)=2^{2}=4$ by Totaro, in fact $e_{8} c_{6}=4 y_{\text {top }}$.

Note. From Corollary 5.5 , the projection $\operatorname{pr}\left(c_{i_{1}} \ldots c_{i_{s}}\right)$ is uniquely determined in $k^{*}(\bar{R}(\mathbb{G})) /\left(I_{\infty}^{s+1}\right) \cong k^{*} \otimes P(y) /\left(I_{\infty}^{s+1}\right)$.

We take $y_{6}, y_{10}, y_{12}$ such that

$$
c_{2}=v_{1} y_{6}, \quad c_{4}=v_{1} y_{10}, \quad y_{12}=y_{6}^{2} \quad \text { in } k^{*}(\overline{\mathbb{F}})
$$

(For example, let $y_{6}=v_{1}^{-1} c_{2}$ and let us write $y_{12}=y_{6}^{2}$ in $k^{*}(\mathbb{F})$.) Recall that the invariant ideal $I_{\infty}$ in $k^{*}$-theory is

$$
I_{\infty}=\operatorname{Ideal}\left(2, v_{1}\right) \subset k^{*}(\bar{R}(\mathbb{G})) \cong \mathbb{Z}_{(2)}\left[v_{1}\right] \otimes P(y)
$$

Note that $\operatorname{pr}\left(I_{\infty}\right) \subset I_{\infty}$. Then we can take $c_{i} \in k^{*}(R(\mathbb{G}))$ such that in $k^{*}(\bar{R}(\mathbb{G})) /\left(I_{\infty}^{3}\right)$,

$$
\begin{gathered}
c_{3}=2 y_{6}+\mu v_{1}^{2} y_{10}, \quad c_{5}=2 y_{10}+v_{1} y_{12}, \quad c_{6}=2 y_{12}+\mu^{\prime} v_{1}^{2} y_{6} y_{10}, \quad \mu, \mu^{\prime} \in \mathbb{Z}_{(2)} \\
e_{8}=2 y_{6} y_{10}+v_{1} y_{6} y_{12}
\end{gathered}
$$

Here we used $P(y)^{*}=0$ for $*=8,14,20$, and $Q_{1} x_{9}=y_{12}, Q_{1} z_{15}=y_{6} y_{12}$. Moreover, we write (new) $c_{3}$ (resp. $c_{6}$ ) as the (old) element $c_{3}-\mu v_{1} c_{4}$ (resp. $\left.c_{6}-2 \mu^{\prime} c_{2} c_{4}\right)$ such that $\left(\bmod \left(I_{\infty}^{3}\right)\right)$

$$
c_{3}=2 y_{6}, \quad c_{6}=2 y_{12}
$$

Let us write $\mathbb{Z}_{(p)}$-free module

$$
\Lambda_{\mathbb{Z}}\left(a_{1}, \ldots, a_{n}\right)=\mathbb{Z}_{(p)}\left\{a_{i_{1}} \ldots a_{i_{s}} \mid 1 \leq i_{1}<\ldots<i_{s} \leq n\right\}
$$

Lemma 9.1. Let $A(c)=\Lambda_{\mathbb{Z}}\left(c_{2}, \ldots, c_{6}, e_{8}\right)$. For $x \in A(c)$, let $x \in I_{\infty}^{4} k^{*}(\bar{R}(\mathbb{G}))$. Then $x \in I_{\infty} \cdot A(c)$, i.e., $x=0$ in $g r_{\gamma}(R(\mathbb{G})) / 2$.

Proof. Let $x \in I_{\infty}^{4} k^{*}(\bar{R}(\mathbb{G}))$. Then $x$ is a sum of

$$
v_{1}^{4} y, 2 v_{1}^{3} y, 4 v_{1}^{2} y, 8 v_{1} y, 16 y \quad \text { for } y \in P(y)
$$

Since the torsion index $t(G)=4$, we see $4 y_{6} y_{10} y_{12} \in k_{*}(R(\mathbb{G}))$. When $y=y_{i} y_{j}$, we consider $4 y-c_{i^{\prime}} c_{j^{\prime}}$ instead of $4 y$ where $2 y_{i}=c_{i^{\prime}}, 2 y_{j}=c_{j^{\prime}} \bmod \left(v_{1}\right)$. Then $4 v_{1}^{2} y, 8 v_{1} y, 16 y$ are in $I_{\infty} A(c)$. Hence we only need to consider the cases

$$
x=v_{1}^{4} y \quad \text { or } \quad x=2 v_{1}^{3} y
$$

Let $x=v_{1}^{4} y$. When $y=y_{t o p}$, we consider

$$
x^{\prime}=x-c_{2} c_{4}\left(c_{2}\right)^{2}=v_{1}^{4} y_{\text {top }}-v_{1} y_{6} v_{1} y_{10}\left(v_{1}^{2} y_{12}\right)=0 \quad \text { in } \quad k^{*}(\overline{\mathbb{F}})
$$

Here $\left(c_{2}^{2}\right)=0$ in $g r_{\gamma}(\overline{\mathbb{F}}) / 2$, and hence $x=x^{\prime}=0 \in g r_{\gamma}^{*}(R(\mathbb{G})) / 2$. When $y=$ $y_{10} y_{12}$, taking $x^{\prime}=x-v_{1} c_{4} c_{2}^{2}$, similar arguments work. When $y=y_{6} y_{10}$, we consider

$$
x^{\prime}=x-v_{1}^{2} c_{2} c_{4}=0 \quad \text { in } k^{*}(\bar{R}(\mathbb{G})) .
$$

This means $x=0 \in g r_{\gamma}(R(\mathbb{G})) / 2$. Thus we can see the lemma for $x=v_{1}^{4} y$.
Let $x=2 v_{1}^{3} y$ with $y=y_{t o p}$. Then we see

$$
x^{\prime}=x-v_{1} c_{2} c_{4} c_{6}=2 v_{1}^{3} y_{t o p}-v_{1}\left(v_{1} y_{6}\right)\left(v_{1} y_{10}\right)\left(2 y_{12}\right)=0 \quad \bmod \left(I_{\infty}^{5}\right)
$$

which is zero in $g r_{\gamma}^{*}(R(\mathbb{G})) / 2$ since $x^{\prime}=v_{1}^{5} y^{\prime}$ or $x^{\prime}=2 v_{1}^{4} y^{\prime}$. The other cases are proved similarly.

Lemma 9.2. $c_{2} c_{3}=0 \in \operatorname{gr} r_{\gamma}(R(\mathbb{G})) / 2$.
Proof. We have $c_{2} c_{3}=v_{1} y_{6}\left(2 y_{6}\right) \bmod \left(I_{\infty}^{4}\right)$ in $k^{*}(\bar{R}(\mathbb{G}))$. (Here we used Lemma 5.4 and that $c_{3}=2 y_{6}$ in $k^{*}(\overline{\mathbb{F}}) / I_{\infty}^{2}$ from Corollary 2.1.) We consider $x=c_{2} c_{3}-v_{1} c_{6}$ with $\bmod \left(I_{\infty}^{4}\right)$. That is,

$$
x=v_{1} y_{6}\left(2 y_{6}\right)-v_{1}\left(2 y_{12}\right)=0 \quad \bmod \left(I_{\infty}^{4}\right) .
$$

Hence from the preceding lemma, we see $c_{2} c_{3}=0 \in \operatorname{gr}(R(\mathbb{G})) / 2$.
We will compute $g r_{g e o}^{*}(R(\mathbb{G})) / 2 \cong g r_{\gamma}^{*}(R(\mathbb{G})) / 2$ (by using Lemma 5.2 ). We will seek generators of

$$
g r_{2}\left(K^{*}(R(\mathbb{G}))=K^{*}(R(\mathbb{G})) / 2 \oplus 2 K^{*}(R(\mathbb{G}))\right.
$$

which are nonzero in $C H^{*}(R(\mathbb{G})) / 2$. If $x$ is a generator of $K^{*}(R(\mathbb{G})) / 2$ but is zero in $C H^{*}(R(\mathbb{G})) / 2$, then we seek an element $x^{\prime} \neq 0 \in C H^{*}(R(\mathbb{G})) / 2$ with $x=v_{1}^{s} x^{\prime}$ in $K^{*}(\bar{R}(\mathbb{G}))$ for some $s \geq 1$.

We note that

$$
\begin{aligned}
& K^{*}(R(\mathbb{G})) / 2 \cong K^{*} \otimes \Lambda\left(c_{2}, c_{4}, c_{5}\right) \\
& \cong K^{*} \otimes \Lambda\left(y_{6}, y_{10}, y_{12}\right) \cong K^{*}(\bar{R}(G)) / 2
\end{aligned}
$$

by $c_{2} \mapsto v_{1} y_{6}, c_{4} \mapsto v_{1} y_{10}$ and $c_{5} \mapsto 2 v_{1}^{-1} c_{4}+v_{1} y_{12}$.
At first we study elements in $\Lambda\left(c_{2} . c_{4}, c_{5}\right)$. Of course $c_{2}, c_{4}, c_{5}$ are nonzero in $g r_{\gamma}^{*}(R(\mathbb{G})) / 2$. We also know $c_{2} c_{4} \neq 0 \in g r_{\gamma}^{*}(R(\mathbb{G})) / 2$ since so for $G=\operatorname{Spin}(11)$.

We have (with $\bmod \left(I_{\infty}^{4}\right)$ )

$$
c_{2} c_{5}=v_{1} y_{6}\left(2 y_{10}+v_{1} y_{12}\right)=v_{1} e_{8} .
$$

Hence we get $c_{2} c_{5} c_{4}=v_{1} e_{8} c_{4}$, where $e_{8} c_{4}=v_{1}^{2} y_{\text {top }} \bmod \left(I_{\infty}^{3}\right)$ which is nonzero in $g r_{\gamma}^{*}(R(\mathbb{G})) / 2$. (Here we note $c_{2} c_{4} \mapsto v_{1}^{2} y_{6} y_{10}, c_{2} c_{5}-c_{3} c_{4} \mapsto v_{1}^{2} y_{6} y_{12}$, and they are nonzero in $g r_{\gamma}^{*}(R(\mathbb{G})) / 2$.)

For the element $c_{4} c_{5}$, we compute

$$
c_{4} c_{5}=v_{1} y_{10}\left(2 y_{10}+v_{1} y_{12}\right)=v_{1}^{2} y_{10} y_{12} \quad \bmod \left(I_{\infty}^{3}\right)
$$

which is also non zero in $\operatorname{gr}_{\gamma}^{*}(R(\mathbb{G})) / 2$. Thus we have
Lemma 9.3. We have some filtration and the graded ring

$$
\begin{aligned}
& \operatorname{gr} P(c) /(2) \cong \mathbb{Z} / 2\left\{1, c_{2}, c_{4}, c_{5}, c_{2} c_{4}, c_{4} c_{5}\right\} \oplus \mathbb{Z} / 2\left\{e_{8}, e_{8} c_{4}\right\} \\
& \cong P(c) /\left(2, c_{2} c_{5}, c_{2} c_{5} c_{4}\right) \oplus \mathbb{Z} / 2\left\{e_{8}, e_{8} c_{4}\right\} \subset \operatorname{gr} r_{\gamma}(R(\mathbb{G})) / 2,
\end{aligned}
$$

where $P(c)=\Lambda_{\mathbb{Z}}\left(c_{2}, c_{4}, c_{5}\right)$.

We consider elements in $2 K^{*}(\bar{R}(\mathbb{G})) \cap \operatorname{Im}\left(\right.$ res $\left._{k}\right)$. First note

$$
2 y_{6}=c_{3}, \quad 2 y_{12}=c_{6} \quad \text { with } \bmod \left(I_{\infty}^{3}\right)
$$

and $c_{3}, c_{6} \neq 0$ in $g r_{\gamma}^{*}(R(\mathbb{G})) / 2$. Next we see $\left(\right.$ with $\left.\bmod \left(I_{\infty}^{3}\right)\right)$

$$
2 v_{1} y_{6} y_{10}=c_{3} c_{4}, \quad 2 v_{1} y_{6} y_{12}=c_{2} c_{6}, \quad 2 v_{1} y_{10} y_{12}=c_{4} c_{6}
$$

Here $c_{3} c_{4}, c_{2} c_{6}, c_{4} c_{6} \neq 0 \in C H^{*}(R(\mathbb{G})) / 2$ since $2 y_{6} y_{10}, 2 y_{6} y_{12}, 2 y_{10} y_{12} \notin \operatorname{Im}\left(\right.$ res $\left._{C H}\right)$. These $c_{3} c_{4}, c_{2} y_{6}, c_{4} c_{6}$ are 2 -torsion in $g r_{\gamma}(R(\mathbb{G}))$, in fact, we see

$$
2 c_{3} c_{4}=v_{1} c_{2} c_{6}, \quad 2 c_{2} c_{6}=v_{1} c_{3} c_{6}, \quad 2 c_{4} c_{6}=v_{1} c_{5} c_{6}
$$

Next we consider elements $4 y$ in $y \in P(y)$. In particular,

\begin{gathered}
4 y_{10}=2 c_{5}+v_{1} c_{6}, \quad 4 y_{6} y_{10}=2 e_{8}+c_{2} c_{6} \\
4 y_{6} y_{12}=c_{3} c_{6}, \quad 4 y_{10} y_{12}=c_{5} c_{6}
\end{gathered}
$$

here $c_{3} c_{6}, c_{5} c_{6} \neq 0$ in $C H^{*}(R(\mathbb{G})) / 2$. Moreover $4 y_{6} y_{10} y_{12}=e_{8} c_{6}$ here $e_{8} c_{6} \neq 0 \in$ $C H^{*}(R(\mathbb{G})) / 2$ since $t(G)=4$. Thus we have

Lemma 9.4. The graded ring $\operatorname{gr} r_{\gamma}(R(\mathbb{G}))$ contains

$$
\mathbb{Z} / 2\left\{c_{4} c_{3}, c_{2} c_{6}, c_{4} c_{6}\right\} \oplus \mathbb{Z}_{(2)}\left\{c_{3}, c_{5}, c_{6}, e_{8}, c_{3} c_{6}, c_{5} c_{6} . e_{8} c_{6}\right\}
$$

From preceding two lemmas, we have
Theorem 9.5. Let $G=\operatorname{Spin}(13)$ and $\mathbb{G}$ be versal. Then we have

$$
\begin{aligned}
g r_{\gamma}(R(\mathbb{G})) \cong & P(b) /\left(c_{2} c_{5}, c_{2} c_{4} c_{5}\right) \oplus \mathbb{Z} / 2\left\{c_{4} c_{3}, e_{8} c_{4}, c_{2} c_{6}, c_{4} c_{6}\right\} \\
& \oplus \mathbb{Z}_{(2)}\left\{1, c_{3}, c_{6}, e_{8} \cdot c_{3} c_{6}, c_{5} c_{6}, e_{8} c_{6}\right\}
\end{aligned}
$$

where $P(b)=\Lambda_{\mathbb{Z}}\left(c_{2}, c_{4}, c_{5}\right) /\left(2 c_{2}, 2 c_{4}\right)$
Corollary 9.6. We have the additive isomorphism

$$
g r_{\gamma}(R(\mathbb{G})) \cong A \otimes\left(\mathbb{Z}_{(2)}\left\{1, c_{6}\right\} \oplus \mathbb{Z} / 2\left\{c_{4}\right\}\right) \oplus \mathbb{Z} / 2\left\{c_{6} c_{4}\right\}
$$

where $A=\mathbb{Z}_{(2)}\left\{1, c_{3}, c_{5}, e_{8}\right\} \oplus \mathbb{Z} / 2\left\{c_{2}\right\}$.
Corollary 9.7. Let $G=\operatorname{Spin}(13), \mathbb{G}$ be versal, and $\mathbb{F}=\mathbb{G} / B_{k}$. To state the formula simply, let us write $e_{8}=c_{8}$. Then we have additive (graded) isomorphism

$$
g r_{\gamma}(\mathbb{F}) / 2 \cong S(t) /\left(2, c_{i} c_{j}, c_{m} c_{n} c_{k} \mid(i, j) \neq(s, 4),\left(s^{\prime}, 6\right) \text { for } s \neq 4, s^{\prime} \neq 6\right)
$$

where $i, j, k, m, n, s, s^{\prime}$ are one of $2, \ldots, 6,8$.
Note that the above isomorphism is not that of rings. In fact, we see

$$
c_{2} e_{8}-c_{4} c_{6}=0 \quad \text { in } g r_{\gamma}^{*}(\mathbb{F}) / 2
$$

We also can not get $C H^{*}(R(\mathbb{G}))$ here, but we do some arguments using norm map. The norm $\operatorname{map} N$ is given explicitly

$$
\begin{gathered}
N\left(y_{6}\right)=2 c_{3}, N\left(y_{10}\right)=2 c_{5}, N\left(y_{6} y_{10}\right)=2 e_{8}, N\left(y_{12}\right)=2 c_{6} \\
N\left(y_{6} y_{12}\right)=c_{3} c_{6}, N\left(y_{10} y_{12}\right)=c_{5} c_{6}, N\left(y_{t o p}\right)=e_{8} c_{6}
\end{gathered}
$$

Lemma 9.8. We have $g r_{\text {geo }}^{*}(R(\mathbb{G})) / N \cong g r_{\text {geo }}^{*}(R(\mathbb{G})) /\left(2, c_{3} c_{6}, c_{5} c_{6}, e_{8} c_{6}\right)$.
Lemma 9.9. If we can see that $c_{2} c_{3}=0$ and $c_{2} e_{8}-c_{4} c_{6}=0$ in $C H^{*}(R(\mathbb{G})) / 2$, then $\operatorname{gr}_{\gamma}^{*}(R(\mathbb{G})) \cong C H^{*}(R(\mathbb{G}))$.

Proof. By the Wu formula, we have

$$
\begin{gathered}
c_{2} c_{3}=0 \stackrel{P^{2}}{\Longrightarrow} c_{2} c_{5}=0 \stackrel{P^{1}}{\Longrightarrow} c_{3} c_{5}=0, \\
c_{2} e_{8}-c_{4} c_{6}=0 \stackrel{P^{1}}{\Longrightarrow} c_{3} e_{8}-c_{5} c_{6}=0 \xlongequal{P^{2}} c_{5} e_{8}=0 .
\end{gathered}
$$

Let us write $c_{8}=e_{8}$ and $c_{7}=0$, and $A(c)^{\prime}=\mathbb{Z} / 2\left\{1, c_{k}, c_{i} c_{j} \mid 1 \leq i, j, k \leq 8, i<j\right\}$. Then from Theorem 9.5, we can see

$$
g r_{\gamma}^{*}(R(\mathbb{G})) / 2 \cong A(c)^{\prime} /\left(c_{2} c_{3}, c_{2} c_{5}, c_{3} c_{5}, c_{2} e_{8}, c_{3} e_{8}, c_{5} e_{8}\right)
$$

Hence we have the lemma.
Lemma 9.10. Let $G=\operatorname{Spin}(13)$ and $\mathbb{G}$ be versal. Then for the restriction map res $_{k}: k^{*}(R(\mathbb{G})) \rightarrow k^{*}(\bar{R}(\mathbb{G}))$, the image $\operatorname{Im}\left(\operatorname{res}_{k}\right) \subset \operatorname{grk}^{*}(\bar{R}(\mathbb{G}))$ is given by

$$
\operatorname{res}\left(k^{*}\left(R\left(\mathbb{G}^{\prime}\right)\right) \oplus(2)\left\{y_{12}\right\} \oplus\left(4,2 v_{1}, v_{1}^{2}\right)\left\{y_{6} y_{12}, y_{10} y_{12}\right\} \oplus\left(4, v_{1}^{2}\right)\left\{y_{t o p}\right\}\right.
$$

where $G^{\prime}=\operatorname{Spin}(11)$ and $(a, \ldots, b) \subset k^{*}$ is the ideal generated by $a, \ldots, b$.
Proof. The image of the restriction map is written $\left(\right.$ with $\left.\bmod \left(I_{\infty}^{3}\right)\right)$ as follows

$$
\begin{gathered}
c_{6} \mapsto 2 y_{12}, \quad c_{6} c_{3} \mapsto 4 y_{6} y_{12}, \quad c_{6} c_{5} \mapsto 4 y_{10} y_{12}, \quad c_{6} e_{8} \mapsto 4 y_{\text {top }} \\
c_{6} c_{2} \mapsto 2 v_{1} y_{6} y_{12}, \quad c_{6} c_{4} \mapsto 2 v_{1} y_{10} y_{12}, \quad\left(e_{8} c_{5} \mapsto 4 v_{1} y_{t o p}\right) \\
\left(c_{3} c_{4}-v_{1} e_{8}\right) \mapsto v_{1}^{2} y_{6} y_{12}, \quad c_{4} c_{5} \mapsto v_{1}^{2} y_{10} y_{12}, \quad e_{8} c_{4} \mapsto v_{1}^{2} y_{t o p}
\end{gathered}
$$

These facts imply the lemma from Theorem 9.5.
If the Karpenko conjecture holds for this case, then from the above lemma, we see that the maps $r e s_{k}$ and res $_{\Omega}$ are injective (as stated in Lemma 8.7).

## 10. $\operatorname{Spin}(15), \operatorname{Spin}(17)$ and the Counterexample

At first, we consider the case $\operatorname{Spin}(15)$, i.e., $\ell=7$. Then we have

$$
\operatorname{gr} P(y) \cong \Lambda\left(y_{6}, y_{10}, y_{12}, y_{14}\right), \quad y_{6}^{2}=y_{12}
$$

So $y_{\text {top }}=y_{6} y_{10} y_{12} y_{14}$ and there is $e_{8}$ in $C H^{*}(R(\mathbb{G}))$. By Totaro, it is known that the torsion index is $2^{3}=8$.

Lemma 10.1. We have $c_{2} c_{3} \neq 0$ in $g r_{\gamma}(R(\mathbb{G})) / 2$.
Proof. The element $x=c_{2} c_{3}-v_{1} c_{6}$ is written for $y^{\prime}, y^{\prime \prime} \in k^{*} \otimes P(y)$

$$
v_{1} y_{6}\left(2 y_{6}-v_{1}^{2} y^{\prime}\right)-v_{1}\left(2 y_{12}+v_{1} y_{14}+v_{1}^{2} y^{\prime \prime}\right)=-v_{1}^{2} y_{14} \quad \bmod \left(I_{\infty}^{3}\right) .
$$

Let us write $A(c)=\Lambda_{\mathbb{Z}}\left(c_{2}, \ldots, c_{7}\right) \otimes \mathbb{Z}\left[e_{8}\right]$. If $x=v_{1} x^{\prime}$ with $x^{\prime} \in k^{*} \otimes \Lambda(c)$, then $x^{\prime}=v_{1} y_{14}$. But such $x^{\prime}$ does not exist, because there does not exist $x_{i}$ such that $Q_{1} x_{i}=y_{14}$ but $Q_{0} x_{i}=0\left(\right.$ note $\left.Q_{0} x_{11}=y_{12}\right)$.

Next we consider the case $G=\operatorname{Spin}(17)$ and $\mathbb{G}$ be versal. Hence $P(y)$ is the same as the case $G=\operatorname{Spin}(15)$, that is, $\operatorname{grP}(y) \cong \Lambda\left(y_{6}, y_{10}, y_{12}, y_{14}\right)$. So $y_{\text {top }}=y_{6} y_{10} y_{12} y_{14}$. But by Totaro, it is known that $t(G)=2^{4}=16$. Note that we have the element $e_{16} \in C H^{*}(R(\mathbb{G}))$.

Lemma 10.2. Let $G=\operatorname{Spin}(17)$ and $\mathbb{G}$ be versal. We have $c_{2} c_{3} c_{6} c_{7}=0$ in $g r_{\gamma}(R(\mathbb{G})) / 2$.

Proof. The element $x=c_{2} c_{3} c_{6} c_{7}$ is computed in $k^{*}(\overline{\mathbb{F}})$ (See Lemma 5.3.)

$$
x=v_{1} y_{6}\left(2 y_{6}+v_{1}^{2} y^{\prime}\right)\left(2 y_{12}+v_{1} y_{14}+v_{1}^{2} y^{\prime \prime}\right)\left(2 y_{14}+v_{1}^{2} y^{\prime \prime \prime}\right)=0 \quad \bmod \left(I_{\infty}^{5}\right)
$$ for $y^{\prime}, y^{\prime \prime}, y^{\prime \prime \prime} \in k^{*} \otimes P(y)$, because $y_{12}^{2}, y_{14}^{2} \in I_{\infty}$.

The degrees are given $|x|=\left|y_{\text {top }}\right|-6$ and $\left|v_{1}^{3}\right|=-6$. So

$$
(*) \quad x=2^{2} \lambda v_{1}^{3} y_{t o p}, \quad \text { with } \lambda \in \mathbb{Z}
$$

Here we note that $x$ is decided with $\bmod \left(v_{1}^{4}\right)$. However if $x=2^{2} \lambda v_{1}^{3} y_{t o p}+v_{1}^{4} y^{\prime}$, then $\left|y^{\prime}\right|>\left|y_{\text {top }}\right|$ and $(*)$ holds exactly in $k^{*}(\bar{R}(\mathbb{G}))$.

Let us write $x^{\prime \prime}=c_{2} c_{4} c_{6} c_{7}$, i.e.,

$$
x^{\prime \prime}=v_{1} y_{6} v_{1} y_{10}\left(2 y_{12}+v_{1} y_{14}\right) \cdot 2 y_{14}=2^{2} v_{1}^{2} y_{t o p} \quad \bmod \left(v_{1}^{3}\right)
$$

Then we have $x-\lambda v_{1} x^{\prime \prime}=0 \bmod \left(v_{1}^{4}\right)$. Hence $x=0$ in $g r_{\gamma}^{*}(R(\mathbb{G})) / 2$.
In the above proof, torsion index and elements $e_{8}, e_{16}$ do not appear. Hence the above proof is seen also the proof for $G=\operatorname{Sin}(15)$.

We will disprove the Karpenko conjecture by using the algebraic integral Morava $A \tilde{K}(n)$-theory, and its associated graded ring $\operatorname{gr}(n)^{*}(X)=C H^{*}(X) / I(n)$. Recall the Nishimoto result $Q_{i}\left(x_{3}\right)=y_{2^{i+1}+2}$, and $Q_{i}\left(x_{5}\right)=y_{2^{i+1}+4}$. Hence, in $\Omega^{*}(\bar{R}(\mathbb{G})) / I_{\infty}^{2}$, we have

$$
\left\{\begin{array}{l}
c_{2}=v_{1} y_{6}+v_{2} y_{10}+v_{3} y_{18}+\ldots \\
c_{3}=2 y_{6}+v_{2} y_{12}+v_{3} y_{20}+\ldots
\end{array}\right.
$$

Now we consider $\tilde{k}(2)$-theory with $\tilde{k}(2)^{*}=\mathbb{Z}_{(2)}\left[v_{2}\right]$. (Note the res $\tilde{K}(2)^{*}(R(\mathbb{G})) \rightarrow$ $\tilde{K}(2)^{*}(R(\mathbb{G}))$ is not isomorphism, in general.)
Lemma 10.3. Let $G=\operatorname{Spin}(17)$ and $\mathbb{G}$ be versal. We have

$$
\left.c_{2} c_{3} c_{6} c_{7} \neq 0 \quad \text { in } \operatorname{gr}(2)^{*}(R(\mathbb{G})) / 2 \quad \text { (hence in } C H^{*}(R(\mathbb{G})) / 2\right)
$$

Proof. We can write in $\tilde{k}(2)^{*}(\bar{R}(\mathbb{G})) /\left(I_{\infty}^{5}\right)$.

$$
x=\operatorname{pr}\left(c_{2} c_{3} c_{6} c_{7}\right)=\left(v_{2} y_{10}\right)\left(2 y_{6}+v_{2} y_{12}\right)\left(2 y_{12}+v_{2} y^{\prime}\right)\left(2 y_{14}+v_{2} y^{\prime \prime}\right)
$$

for $y^{\prime}, y^{\prime \prime} \in \tilde{k}(2)^{*} \otimes P(y)$. Hence we have

$$
x=2^{3} v_{2} y_{t o p} \quad \bmod \left(v_{2}^{2}\right)
$$

Suppose that $x=0 \in \operatorname{gr}(2)^{*}(R(\mathbb{G})) / 2$. Then there is $x^{\prime} \in \tilde{k}(2)^{*} \otimes \Lambda(c)=$ $\tilde{k}(2)^{*} \otimes \Lambda\left(c_{2}, \ldots, c_{7}\right) \otimes \mathbb{Z}_{(2)}\left[e_{16}\right]$ such that we have

$$
x=v_{2} x^{\prime} \quad \text { or } \quad x=2 x^{\prime} .
$$

Suppose $x=v_{2} x^{\prime}$. Then $x^{\prime}=2^{3} y_{\text {top }} \bmod \left(v_{2}\right)$. Therefore we see $t(G) \leq 2^{3}$, and this contradicts to $t(G)=2^{4}$.

The case $x=2 x^{\prime}$ is proved similarly using the Quillen operation $r_{\Delta_{2}}\left(v_{2}\right)=2$. In fact $r_{\Delta_{2}} x^{\prime}=2^{3} y_{\text {top }}$ also. (For $j \neq 2, r_{\Delta_{2}}\left(v_{j}\right)=0 \bmod \left(I_{\infty}^{2}\right)$ and we can define this Quillen operation in $\tilde{k}(2)^{*}(-)$.)

Remark. For $G=\operatorname{Spin}(15)$, we have $c_{2} c_{3} c_{6} c_{7}=0$ also in $\operatorname{gr}(2)^{*}(R(\mathbb{G})) / 2$. form $t(G)=2^{3}$. Indeed $e_{8} c_{6} c_{7}=2^{3} y_{\text {top }}$. For $G=\operatorname{Spin}(13)$, we have $c_{2} c_{3}=0$ also in $\operatorname{gr}(2)^{*}(R(\mathbb{G})) / 2$.
Theorem 10.4. When $G=\operatorname{Spin}(17)$ and $\mathbb{G}$ be versal. Then $I(1) \neq 0$.
Similarly, we have

Lemma 10.5. Let $G=\operatorname{Spin}(19)$ and $\mathbb{G}$ be versal. For $x=c_{2} c_{3} c_{6} e_{16}$, we have $x \neq 0 \in C H^{*}(R(\mathbb{G})) / 2$ but $x=0 \in g r_{\gamma}(R(\mathbb{G})) / 2$.

Proof. We note that from $Q_{0}(z)=y_{14} y_{18}$, we see $e_{16}=2\left(y_{14} y_{18}\right)$ in $C H^{*}(\bar{R}(\mathbb{G}))$, The torsion index $t(G)=2^{4}$ by Totaro (in fact, $c_{3} c_{5} c_{6} e_{16}=2^{4} y_{t o p}$ ). The results are gets by arguments exchanging $c_{7}$ by $e_{16}$ in the proofs of Lemma 10.2, 10.3 for $\operatorname{Spin}(17)$. The results are gets by arguments similar to the preceding lemmas.

Corollary 10.6. Let $G=\operatorname{Spin}(17)$ and $\mathbb{G}$ be versal. Then we have

$$
\left(2^{4}, 2^{3} v_{1}, 2^{3} v_{2}\right)\left\{y_{t o p}\right\} \subset \operatorname{Im}\left(\operatorname{res}_{\Omega}\right) \subset g r B P^{*}(\bar{R}(\mathbb{G}))
$$

Proof. We see $c_{2} c_{3} c_{6} c_{7}=2^{3} v_{2} y_{\text {top }} \bmod \left(I_{\infty}^{5}\right)$. Hence the ideal $\left(2^{4}, 2^{3} v_{1}, 2^{3} v_{2}\right) \subset$ $B P^{*}$ is invariant under $r_{\Delta_{1}}, r_{2 \Delta_{1}}$, and $r_{\Delta_{2}}$, we have the corollary. In fact

$$
c_{3} c_{5} c_{6} c_{7} \mapsto 2^{4} y_{\text {top }}, \quad c_{2} c_{5} c_{6} c_{7} \mapsto 2^{3} v_{1} y_{\text {top }}, \quad c_{2} c_{3} c_{6} c_{7} \mapsto 2^{3} v_{2} y_{\text {top }}
$$

## 11. $\operatorname{Spin}(N), N$; Large

At first we see that fixed $*>0$, the Chow group $C H^{*}(R(\mathbb{G}))$ is constant when $\ell$ becomes bigger.

Theorem 11.1. Let $G(n)=\operatorname{Spin}(n)$ and $\mathbb{G}(n)$ be the versal $G(n)_{k}$-torsor. Then we have the additive isomorphism

$$
\lim _{\leftarrow N} C H^{*}(R(\mathbb{G}(N))) / 2 \cong \Lambda\left(c_{2}, c_{3}, \ldots, c_{n}, \ldots\right)
$$

Proof. Let $N=2 \ell+1$, and $2^{2} \leq 2^{n}<2^{t} \leq \ell<2^{t+1}$. We will see

$$
C H^{*}\left(R(\mathbb{G}(N)) / 2 \cong \Lambda\left(c_{2}, \ldots, c_{2^{n}-1}\right) \quad \text { for } *<2^{n}\right.
$$

Suppose that

$$
x=\sum c_{i_{1}} \ldots c_{i_{s}}=0 \in C H^{*}(R(\mathbb{G}(N))) / 2 \quad \text { for } 2 \leq i_{1}<\ldots<i_{s}<2^{n} .
$$

Here $c_{i_{j}}=v_{n} y_{m}$ with $m=2^{n}-2+2 i_{j}$ in $k(n)^{*}\left(\bar{R}(\mathbb{G}) / 2\right.$. Since $2^{n}<m<2^{n+1}$, $m$ is not a form $2^{r}, r>3$. Hence $y_{m}$ is a generator of $\operatorname{grP}(y) \cong \Lambda_{s \neq 2^{i}} y_{2 s}$.

Moreover recall that

$$
e_{2^{t+1}}=v_{n} y_{2^{t+1}-2+2^{n}-2} y_{2^{t}+2}+\ldots
$$

This element is in the $\operatorname{ideal}\left(v_{n}^{2}, E\right)$ with $E=\left(y_{2 j} \mid j>2^{t}\right)$. Hence we see $c_{i_{j}}=v_{n} y_{m}$ is also nonzero $\bmod \left(v_{n}^{2}, E\right)$ since $n<t$.

Thus we see that for $x^{\prime}=y_{2^{n}-2+2 i_{1}}^{\ldots} . y_{2^{n}-2+2 i_{s}}$

$$
x=\sum v_{n}^{s} x^{\prime} \neq 0 \in k(n)^{*}(\bar{R}(\mathbb{G})) / 2 \cong k(n)^{*} \otimes P(y)
$$

Moreover $v_{n}^{s-1} x^{\prime} \notin \operatorname{Im}($ res $)$, because $\operatorname{Im}($ res $)$ is generated by $\operatorname{res}\left(c_{j_{1}}\right) \ldots r e s\left(c_{j_{r}}\right)$ and each $\operatorname{res}\left(c_{j}\right)=0 \bmod \left(v_{n}\right)$.

We note the following general properties for $\ell \geq 5$.
Lemma 11.2. Let $2^{t}<\ell<2^{t+1}$ with $\ell \geq 5$. Then $e_{2^{t+1}} \neq 0$ in $\operatorname{gr}_{\gamma}^{*}(R(\mathbb{G})) / 2$.

Proof. At first, we recall the case $\ell=5$. Then $e_{8} \neq 0$ in $C H^{*}(R(\mathbb{G})) / 2$ from Theorem 7.1. By the naturality $e_{8} \neq 0$ for $\ell=6,7$. Moreover we note

$$
2^{3}=t(\operatorname{Spin}(15))<t(\operatorname{Spin}(19))=2^{4} \quad(\text { while } t(\operatorname{Spin}(7))=2=t(\operatorname{Spin}(11)))
$$

Let us write $d=2^{t+1}$ and assume $d \geq 16$ (i.e., $t \geq 3$ ). We consider the group $G=\operatorname{Spin}(d+3)$. Since $Q_{0}(z)=y_{d-2} y_{d+2}$ and $d(z)=e_{d}$ by Nishimoto, we have

$$
2 y_{d-2} y_{d+2}=e_{d} \quad \in C H(\bar{R}(\mathbb{G})) / 2
$$

Here we recall

$$
(*) \quad t(\operatorname{Spin}(d-1))<t(\operatorname{Spin}(d+3)) .
$$

In fact, by Totaro, for $t(\operatorname{Spin}(2 n+1))=2^{u}, u$ is close to $n-2 \log _{2}(n)+1$. Then we can see that $e_{d} \neq 0$ in $C H^{*}(R(\mathbb{G})) / 2$. Otherwise $1 / 2 e_{d}=y_{d-2} y_{d+2} \in$ Res. This implies

$$
t(\operatorname{Spin}(d-1)) y_{6} \ldots y_{d-4} \cdot y_{d-2} y_{d+2} \in \operatorname{Res}\left(C H^{*}(R(\mathbb{G}))\right)
$$

which contradicts to $(*)$. Hence From Corollary 3.7, we also see $e_{d} \neq 0 \in$ $C H^{*}\left(R\left(\mathbb{G}_{k}\right)\right) / 2$ for $\ell=d / 2+1$.

For groups $\operatorname{Spin}(2 \ell+1), d / 2<\ell<d$, we see

$$
d(z)=c_{1}^{d}=2\left(y_{d-2} y_{d+2}+y_{d-4} y_{d+4}+\ldots\right)
$$

We have $e_{d} \neq 0$ for the group $\operatorname{Spin}(2 \ell+1)$, by the naturality for $\operatorname{Spin}(d+3) \rightarrow$ $\operatorname{Spin}(2 \ell+1)$.
