# Global well-posedness of strong solutions of Doi model with large viscous stress

#### Abstract

We study models of dilute rigid rod-like polymer solutions. We establish the global wellposedness the Doi model for large data, and for arbitrarily large viscous stress parameter. The main ingredient in the proof is the fact that the viscous stress adds dissipation to high derivatives of velocity.


## 1 Introduction

Study of rod-like polymer suspensions has various applications. In particular liquid crystals are successfully modeled as rigid rod. We are interested in a dilute suspension of rigid rod-like polymers, in dimension 2. In particular, we investigate the Doi model:

where $u$ is the velocity field of the fluid, $p$ is the pressure, $\sigma$ is the added stress field due to the presence of polymer, $f=f(x, t, m)$ is the polymer distribution, and $u_{0}, f_{0}$ are initial data. Also constant parameters $k, \nu>0$ represents configurational and spatial diffusivity of polymers, respectively, and $\eta>0$ is a constant parameter representing the concentration of the polymers. We prove global well-posedness of strong solution of (Doil). The term

is the projection to the tangent space of $\mathbb{S}^{1}$ at $m$, and $\nabla_{m}=\partial_{\theta}$ in local coordinates. The polymer stress tensor $\sigma$ can be decomposed into two terms: $\sigma=\sigma_{E}+\sigma_{V}$, where

The presence of viscous stress tensor is the main difficulty for the well-posedness of the Doi model. Viscous stress tensors arise from rigidity constraint of the polymer( [14]), and mathematically $\sigma_{V}(f)$ is not elliptic in $u$, which makes the momentum equation of (Doi) non-parabolic for large $\eta$. This difficulty can be clearly illustrated in the approximate Doi model:

The model (DA) is an approximate closure of Doi model (Doil) obtained by letting $A=$ $\int_{S^{1}} n \otimes n f d n$ and adopting the decoupling approximation $\sigma \simeq \eta\left(\nabla_{x} u: A\right) A$ and ignoring elastic stress part. We establish the energy estimate:

and we see that in fact viscous stress is another dissipative structure for $u$. Based on this remarkable property, which holds in (Doil) also, Lions and Masmoudi proved global existence of weak solution of (Doil) in [17]. However, when we apply the vorticity estimate, at first point we can only obtain

which makes the right hand side for the second inequality intractable if $\eta>\eta_{c}$ for some threshold $\eta_{c}$.

Recently, in [19], the authors numerically discovered that, when $\eta$ exceeds some threshold $\eta_{c}$, the flow governed by (DA) becomes chaotic. It was hence unclear this phenomenon supports the claim that the systems (Doil) and (DA) lack structure to control higher regularity of $u$. However, in this work we find that actually the viscous stress tensor adds dissipation for higher derivatives of $u$ also, modulo derivatives in polymer variables ( (C-Doi2D), (C2-Doi2D). This observation is crucial in proving global well-posedness of (Doil) and (DA) in diffusive systems $\nu>0$.

Notion of the solution. For the notion of solution, we follow the argument in [15]. By focusing on the evolution of macroscopic variables (trigonometric moments in this case), we can set up well-posedness of strong solutions for large class of initial data. In particular, higher regularity of Fokker-Planck equation is not necessary, and weak solution for FokkerPlanck equation is sufficient. On the other hand, since the effect of polymer to the flow are characterized by stresses, which are moments in (Doi), requiring spatial regularity for appropriate moments is necessary. In this regard, we introduce a terminology: for any $n \in$ $\mathbb{Z}_{>0}$, we let

be the vector of all moments of $f$ of order $n$. Also, we define the weak solution as following (4]):
Definition 1. Given a divergence-free vector field $v \in L^{\infty}\left(0, T ; W^{2,2}\right) \cap L^{2}\left(0, T ; W^{3,2}\right), \mu$ is a weak solution to the Cauchy problem

Our main result is the following:
Theorem 1. Suppose that $u_{0} \in \mathbb{P} W^{2,2}\left(\mathbb{T}^{2}\right), f_{0} \geq 0 \in L^{1}\left(\mathbb{T}^{2} \times \mathbb{S}^{1}\right)$ with $\sigma_{E}\left(f_{0}\right) \in W^{1,2}\left(\mathbb{T}^{2}\right), \int_{\mathbb{T}^{2}} \int_{\mathbb{S}^{1}}\left(f_{0} \log f_{0}-\right.$ $\left.f_{0}+1\right) d m d x<\infty, M_{0} \in L^{\infty}\left(\mathbb{T}^{2}\right), M_{4}\left(f_{0}\right) \in W^{2,2}\left(\mathbb{T}^{2}\right)$, and $M_{6}\left(f_{0}\right) \in W^{1,2}\left(\mathbb{T}^{2}\right)$. Then there is a unique solution $(u, f)$ to (Doil), where $u \in L^{\infty}\left(0, T ; W^{2,2}\right) \cap L^{2}\left(0, T ; W^{3,2}\right)$ is the strong solution of the evolution equation of $u$ for (Doi), $\sigma_{E}(f), M_{6}(t) \in L^{\infty}\left(0, T ; W^{1,2}\right) \cap L^{2}\left(0, T ; W^{2,2}\right)$, and $M_{4}(f) \in L^{\infty}\left(0, T ; W^{2,2}\right) \cap L^{2}\left(0, T: W^{3,2}\right)$. Also $f$ is given by a density $f(x, t, m)$, and $f$ is a weak solution to the Cauchy problem of the Fokker-Planck equation of (Doil). Furthermore, the estimates $(\overline{F E}),(M 0 B),(M n B 1)$ for $n=4$, (ESB $),(V-D 0 i), ~ M 4 B 2)$, and (V2-Doil) hold. In addition, $f(t) \in W^{1,1}\left(\mathbb{T}^{2} \times \mathbb{S}^{1}\right)$ holds.

Previous works The system (Doil) is an example of more general Fokker-Planck-NavierStokes systems. When viscous stress is ignored, global well-posedness is established by various authors including Constantin, Fefferman, Kevrekidis, Masmoudi, Seregin, Titi, Vukadinovic, and Zarnescu ([5], [6], 8], 9], [10, [11, [12], [13]) even in non-diffusive regime. Also Otto and Tzavaras proved global existence of weak solution in 3D Doi model, without viscous stress, coupled with Stokes flow in [20]. For Doi models (Doi), Lions and Masmoudi proved global existence of weak solution in [17] with important observation of dissipative nature of viscous stress. Also Zhang and Zhang proved local and small data global well-posedness for (Doil) models for small $\eta$ in [22]. Compressible Doi model is discussed by Bae and Trivisa in [1], [2], and [3]. The relationship between rigid rod-like polymer suspension models and Ericksen-Leslie model for nematic liquid crystal has been investigated in 21]. For more general introduction for complex fluids, there are excellent references including [18], [16], and [7].

## 2 Global well-posedness of the strong solution of (DA)

In this section, we prove the following theorem.
Theorem 2. Given $\left(u_{0}, A_{0}\right) \in \mathbb{P} W^{2,2}\left(\mathbb{T}^{2}\right) \times W^{2,2}\left(\mathbb{T}^{2}\right)$, where $A_{0}$ is a $2 \times 2$ positive definite matrix valued function with $\operatorname{Tr} A_{0} \equiv 1$, then for any $T>0$ there is a unique strong solution $(u, A) \in\left(L^{\infty}\left(0, T ; \mathbb{P} W^{2,2}\left(\mathbb{T}^{2}\right)\right) \cap L^{2}\left(0, T ; \mathbb{P} W^{3,2}\left(\mathbb{T}^{2}\right)\right)\right) \times\left(L^{\infty}\left(0, T ; W^{2,2}\left(\mathbb{T}^{2}\right)\right) \cap L^{2}\left(0, T ; W^{3,2}\left(\mathbb{T}^{2}\right)\right)\right)$ satisfying (DA) and $\operatorname{Tr} A \equiv 1$ and $A$ remains positive definite. Furthermore, the solution satisfies the estimates (Energy), (A1), (A2), Vorticity), (A3), and (GV).

### 2.1 A priori estimates

First we have the propagation of positive-definiteness and Trace 1 for $A$.
Proposition 1. Suppose that $\left(\nabla_{x} u\right): A \in L^{1}\left(0, T ; L^{\infty}\right)$ and $\operatorname{Tr} A(0) \equiv 1$ and $A(0)$ is positive definite. Then $A(t)$ remains positive definite with $\operatorname{Tr} A \equiv 1$.

Proof. We need to check $\operatorname{det} A>0$ and $\operatorname{Tr} A \equiv 1$. For $\operatorname{Tr} A \equiv 1$, we take the trace of the third equation of ( (DA) to get

and by the maximum principle we are done. For $\operatorname{det} A>0$, we have

(Det)
where we used $\operatorname{Tr} A \equiv 1$. Then by the maximum principle we are done again.
We investigate a priori estimates. First, usual energy estimates give us

(Energy)
For $\|A\|_{L^{\infty}\left(0, T ; L^{1} \cap L^{\infty}\right)}$, we know that from $\operatorname{Tr} A \equiv 1$ and $A$ is positive definite, $\|A(t)\|_{L^{\infty}} \leq 1$ for all $t$. Also $0<\operatorname{det} A(x, t) \leq \frac{1}{4}$ is obtained. On the other hand, using (Det), we can obtain an estimate for $\left\|\nabla_{x} A\right\|_{L^{2}\left(0, T ; L^{2}\right)}$. Integrating (Det) with respect to $x$, it can be written as

However, using that $\operatorname{det} A \leq \frac{1}{4}$, that $|A|^{2}=\sum_{i j} A_{i j}^{2}=1-2 \operatorname{det} A$ by $\operatorname{Tr} A \equiv 1$, and CauchySchwarz inequality we have

Also, by multiplying $-\Delta_{x} A$ to the fourth equation of (DA) and integrating we obtain

where $C_{1}$ depends only on the norm of initial data. Then we take the curl $\left(-\partial_{2}, \partial_{1}\right)$. to the velocity equation of (DA), multiply $\omega=\partial_{1} u_{2}-\partial_{2} u_{1}$, and integrate to obtain

Controlling $\int \omega \nabla_{x}^{\perp} \cdot\left(\nabla_{x} \cdot \sigma\right) d x$. Conventional estimate for the term $\int \omega \nabla_{x}^{\perp} \cdot\left(\nabla_{x} \cdot \sigma\right) d x$ is to use Cauchy-Schwarz inequality, which makes the term $\left\|\nabla_{x} \omega\right\|_{L^{2}}^{2}$ uncontrollable, however a closer look at the term allows us a better estimate. Note that

Also, note that

and we introduce the stream function $\psi$, that is, $u=\nabla^{\perp} \psi=\left(-\partial_{2} \psi, \partial_{1} \psi\right)$. Then we have

=\eta \int\left(\Delta_{x}\left(\partial_{1}^{2}-\partial_{2}^{2}\right) \psi A_{12}+\Delta_{x} \partial_{1} \partial_{2} \psi\left(A_{22}-A_{11}\right)\right)\left(\partial_{1} \partial_{2} \psi\left(A_{22}-A_{11}\right)+\left(\partial_{1}^{2}-\partial_{2}^{2}\right) \psi A_{12}\right) d x \\
=-\eta \int\left|A_{12} \nabla_{x}\left(\partial_{1}^{2}-\partial_{2}^{2}\right) \psi+\left(A_{22}-A_{11}\right) \nabla_{x}\left(\partial_{1} \partial_{2}\right) \psi\right|^{2} d x+I

Remark 1. Same cancellation argument works for the original Doi model (Doil), so we can prove global well-posedness of diffusive Doi model for any $\eta>0$. In the presence of an external forcing (applied to the fluid field), the global well-posedness can still be proved by similar estimates.

### 2.2 Local well-posedness

In this section we prove the local well-posedness. Before we start, we briefly check the difficulty in the usual contraction mapping scheme. We define the Banach space $B=X \times Y$, where

The problem is in $L(u, A)$ : to find a contraction mapping we need to guarantee that $F$ is a mapping from a ball $B(0, R) \subset B$ to itself: however, the bounds for $\left\|u^{n e w}(t)\right\|_{X}$ that we can obtain from this method is $U_{0}+\|u\|_{X}\left(C_{1} T_{0}\|u\|_{X}+C_{2}\|A\|_{Y}\right)$, and if $\|A\|_{Y} \geq \frac{1}{C_{2}}$ then this method fails to bound which holds for both $\|u\|_{X}$ and $\left\|u^{n e w}\right\|_{X}$. Therefore, instead of contraction mapping principle, we use an approximation scheme for $u$ equation and go with contraction mapping principle for $A$ equation.

Approximation scheme. Suppose that $u_{n} \in X$ is given with $\left\|u_{n}\right\|_{X}<\infty$ and $u_{n}(0)=$ $u_{0}$. We solve

For this equation contraction mapping works well, and local well-posedness is guaranteed, and proposition [1, a priori estimates (A1), (A22), (A3) are satisfied except that all the estimates concerning $u$ are replaced by $u_{n}$. This means that $A_{n}$ is guaranteed to exist until the time of existence of $u_{n}$. Our approximation scheme for $u_{n+1}$ is the following.

Then we can prove the local well-posedness of the system (UA) via contraction mapping, since for the modified polymer-induced nonlinear structure

This estimate can be obtained in the same manner as (Energy), (Vorticity), and (GV), which is essentially the usual energy method together with the cancellation structures (Cancellation), Cancellation2), and those estimates hold with the bound depending only on initial data and $T_{0}$, independent of $n$. Then we have the uniform bounds

## 3 A priori estimate for (Doi)

In this section, we establish a priori estimates for (Doil). More precisely, we prove the following theorem:

Theorem 3. Let $(u, f)$ be a stroong solution of (Doil) on $[0, T]$ with initial data satisfying $M_{0}(0) \in L^{\infty}, \sigma_{E}(0) \in W^{1,2}, M_{4}(0) \in W^{2,2}, M_{6}(0) \in W^{1,2}, \int_{\mathbb{T}^{2}} \int_{\mathbb{S}^{1}}(f \log f-f+1)(0) d m d x<$ $\infty$, and $u_{0} \in \mathbb{P} W^{2,2}$. Then $(u, f)$ satisfies the bounds (FE), (M0B), (MnB1) for $n=4$, (ESB), (V-Doil), M4B2), and (V2-Doil).

### 3.1 Free energy estimate

The first one is the well-known free energy estimate.

### 3.2 Estimate on moments

In this section, we investigate bounds on moments, which are useful in establishing bounds of elastic and viscous stresses.

Local coordinates. To study the evolution of moments and elastic tensors, it is useful to write the Fokker-Planck equation of (Doil) in the local expression. The configuration space $\mathbb{S}^{1}$ can be represented by $m(\theta)=(\cos \theta, \sin \theta)$, and the Fokker-Planck equation of (Doi) is

## 4 Local well-posedness of (Doi)

In this section, we prove local well-posedness of (Doil). Once local well-posedness is established, global well-posedness follows from the a priori estimates established in the previous section.

### 4.1 Local existence of the solution

We follow the method presented in Constantin and Seregin: the existence of the system follows from uniform bounds on the approximate system

Existence of (Doi-Approx) follows from standard arguments in Fokker-Planck equation: first each system in (Doi-Approx2) has smooth solution (same regularity as in the a priori estimate, uniform bounds in $n$ ), and therefore we have weakly convergent subsequence $u_{n}$ converging to $u$ in $L^{\infty}\left(0, T ; W^{2,2}\right) \cap L^{2}\left(0, T ; W^{3,2}\right)$, and by Aubin-Lions and Rellich-Kondrachov we have $u_{n} \rightarrow u \in L^{2}\left(0, T ; W^{2-\epsilon, 2}\right)$, which is a strong convergence. Also we establish similar strong convergence in moments, and we establish convergence of evolution equation of $u_{n}$ to that of $u$, which proves that the limit $u$ is a weak solution of (Doi-Approx), and since $u$ has enough regularity it is a strong solution. We also find the limit $f$ of $f_{n}$, using the results from the trigonometric moment problem. We see that $f$ is a weak solution of (Doi-Approx), and that $f$ is given by the density, and the standard theory gives the free energy estimate (FE).

Uniform bounds on solutions of (Doi-Approx2). Also, $\mathbb{P} \Delta_{x} u_{n+1} \rightarrow \mathbb{P} \Delta_{x} u \in C\left([0, T] ; W^{-1,2}\right), \mathbb{P} \nabla_{x} \cdot \mathcal{J}_{\ell}\left(\sigma_{E}\left(f_{n}\right)\right) \rightarrow \mathbb{P} \nabla_{x}$. $\mathcal{J}_{\ell}\left(\sigma_{E}\right) \in C\left([0, T] ; W^{1-\epsilon, 2}\right)$ (uniformly in $\ell$ ), and finally since $M_{4}\left(f_{n}\right) \rightarrow M_{4} \in C\left([0, T] ; L^{\infty}\right)$ by Agmon and $\nabla_{x} u_{n+1} \rightarrow \nabla_{x} u \in C\left([0, T] ; L^{2}\right), T\left(\mathcal{J}_{\ell}\left(\nabla_{x} u_{n+1}\right), M_{4}\left(f_{n}\right)\right) \rightarrow T\left(\mathcal{J}_{\ell}\left(\nabla_{x} u\right), M_{4}\right) \in$ $C\left([0, T] ; L^{2}\right)$ and so $\nabla_{x} \cdot \mathcal{J}_{\ell} T\left(\mathcal{J}_{\ell}\left(\nabla_{x} u_{n+1}\right), M_{4}\left(f_{n}\right)\right) \rightarrow \nabla_{x} \cdot \mathcal{J}_{\ell} T\left(\mathcal{J}_{\ell}\left(\nabla_{x} u\right), M_{4}\right) \in C\left([0, T] ; W^{-1,2}\right)$ (uniformly in $\ell$ ). Finally, since $\partial_{t} u_{n}$ is weakly convergent to $\partial_{t} u$ in $L^{2}\left(0, T ; L^{2}\right)$, we see that $u$ is a weak solution of $u$-part of (Doi-Approx).

Convergence of $f_{n}$ to $f$. To deal with this issue, we recall the result from the trigonometric moment problem:
Theorem 4 (Carathéodory-Toeplitz). For a complex sequence $s=\left(s_{j}\right) \in \mathbb{N} \cup\{0\}$ the following are equivalent:

1. There exists a (nonnegative) radon measure $\mu$ on $\mathbb{T}^{1}$ such that

$$
s_{j}=\int_{\mathbb{S}^{1}} e^{-i j \theta} d \mu(\theta)
$$

for all $j \in \mathbb{Z}$. Here $s_{-j}:=\overline{s_{j}}$ for $n \geq 1$.
2. $\sum_{j, k=0}^{\infty} s_{j-k} c_{k} \overline{c_{j}} \geq 0$ for all finite complex sequences $\left(c_{j}\right)_{j \in \mathbb{N} \cup\{0\}}$.

The measure $\mu$ is uniquely determined by determined by $s_{j}$.
In this regard, we define the trigonometric moments

$$
s_{j}\left(f_{n}\right)=\int_{\mathbb{S}^{1}} e^{-i j \theta} f_{n}(\theta) d \theta
$$

By the very similar argument as before, we obtain

$$
\left\|s_{j}\left(f_{n}\right)\right\|_{L^{\infty}\left(0, T ; L^{2}\right)}^{2}+\left\|\nabla_{x} s_{j}\left(f_{n}\right)\right\|_{L^{2}}^{2} \leq B_{4}^{2}\left(1+j^{2} B_{a p p}^{0}\right)
$$

which is uniform in $n$, and $\left\|\partial_{t} s_{j}\left(f_{n}\right)\right\|_{W^{-1,2}} \leq\left(\sqrt{B_{a p p}^{2}}+C \nu\right)\left\|\nabla_{x} s_{j}\left(f_{n}\right)\right\|_{L^{2}}+C j B_{4}\left\|\nabla_{x} u\right\|_{L^{2}}$ so $\partial_{t} s_{j}\left(f_{n}\right)$ is uniformly bounded in $L^{2}\left(0, T ; W^{-1,2}\right)$. Therefore, again by Aubin-Lions and diagonalization argument, we can find a further subsequence of $f_{n}$ such that $s_{j}\left(f_{n}\right)$ converges to some $s_{j}$ strongly in $L^{2}\left(0, T ; L^{2}\right)$, and therefore almost everywhere, for all $j$. Also, we see that

$$
\sum_{j, k=0}^{\infty} s_{j-k}\left(f_{n}\right)(x, t) c_{k} \overline{c_{j}} \geq 0
$$

for all $x, t$ for all finite complex sequences $\left(c_{j}\right)_{j \in \mathbb{N} \cup\{0\}}$, and by almost everywhere convergence $\sum_{j, k=0}^{\infty} s_{j-k}(x, t) c_{k} \overline{c_{j}} \geq 0$ for almost every $(x, t)$. Therefore, we see that there exists a (nonnegative) radon measure $\mu$ such that $s_{j}=\int_{\mathbb{S}^{1}} e^{-i j \theta} d \mu(\theta)$ for all $j \in \mathbb{Z}$. Next we show that for almost every $(x, t) f_{n}(x, t, m) d m$ converges to $\mu(x, t ; d m)$ weakly. The argument is analogous to the method of moment: since $\int_{\mathbb{S}^{1}} f_{n}(x, t, m) d m \leq B_{4},\left(f_{n}(x, t) d m\right)$ is uniformly bounded and obviously uniformly tight. Therefore, by Prokhorov's theorem $f_{n}(x, t, m) d m$ converges weakly to some Radon measure $\nu(x, t ; d m)$. Thus, $s_{j}\left(f_{n}\right)(x, t, m) d m$ converges to $\int e^{-i j \theta} d \nu(x, t ; d m)$ for each $j$, but this equals to $s_{j}=\int_{\mathbb{S}^{1}} e^{-i j \theta} d \mu(\theta)$. Since $\mu$ is determined by the trigonometric moments, $\nu=\mu$. Note that $M_{k}[\mu]=M_{k}$ also holds.
$f$ is a weak solution of (Doi-Approx). To show that $\mu$ is the weak solution of (Doi-Approx), we write the Fokker-Planck equation of (Doi-Approx2) in the weak form as in (Cauchy-FP), and check the convergence. First, we note that
$|E|=\mid\left\{t \in(0, T): \mid\left\{x \in \mathbb{T}^{2}: f_{n}(x, t, d m)\right.\right.$ does not converge weakly to $\left.\left.\mu(x, t ; d m)\right\} \mid>0\right\} \mid=0$.
For $t \in(0, T)-E$, for almost all $x, \int_{\mathbb{S}^{1}} \phi_{m}(m) f_{n+1}(x, t, m) d m \rightarrow \int_{\mathbb{S}^{1}} \phi_{m}(m) \mu(x, t ; d m)$ by weak convergence, and $\left|\int_{\mathbb{S}^{1}} \phi_{m}(m) f_{n+1}(x, t, m) d m\right| \leq C_{\phi_{m}} B_{4}$ for almost every $x$, so by Dominated convergence theorem,

$$
\int_{\mathbb{T}^{2} \times \mathbb{S}^{1}} \phi_{x}(x) \phi_{m}(m) f_{n+1}(x, t ; m) d m d x \rightarrow \int_{\mathbb{T}^{2} \times \mathbb{S}^{1}} \phi_{x}(x) \phi_{m}(m) \mu(x, t ; d m) d x
$$

The second term is easy since the initial data of $f_{n}$ are just mollified ones of $f(0)$. We can show convergence for other terms except for the ones involving velocity field $u$, using the very same argument: by weak convergence we have almost everywhere convergence for $m$ integral part first, and for that term we have uniform bound (depending on $\phi_{m}$ ), then we apply dominated convergence theorem. For the terms involving velocity fields $u$, we apply the generalized dominated convergence theorem instead. Then standard parabolic regularity theory guarantees that actually $\mu$ is given by density $f(x, t, m) d m d x$, and if initial entropy is finite, then it remains finite, with $f(t) \in W^{1,1}\left(\mathbb{T}^{2} \times \mathbb{S}^{1}\right)$, and $\int_{0}^{T} \int_{\mathbb{T}^{2} \times \mathbb{S}^{1}} \frac{\left|\nabla_{x, m}\right|^{2}}{f} d m d t<\infty$.

Solution of (Doi). Existence of a solution of (Doi) is just a repetition of arguments for establishing solutions of (Doi-Approx). In this case, we set up $\ell \rightarrow \infty$.

### 4.2 Uniqueness of the solution

Uniqueness of the solution follows from relative energy method. Suppose that $(u, f)$ and $(v, g)$ are two solutions of (Doi) with same initial data ( $u_{0}, f_{0}$ ) satisfying our assumptions.

Control of $u-v$. By taking $L^{2}$ estimates, vorticity estimate, and $W^{1,2}$ norm estimates for $u-v$, we have

$$
\begin{gathered}
\frac{d}{d t}\|u-v\|_{W^{2,2}}^{2}+\|(u-v)\|_{W^{3,2}}^{2} \leq C_{1}(t)\|u-v\|_{W^{2,2}}^{2} \\
+C\left\|\sigma_{E}(f)-\sigma_{E}(g)\right\|_{W^{2,2}}^{2}+C_{2}(t)\left\|M_{4}(f)-M_{4}(g)\right\|_{W^{2,2}}^{2}
\end{gathered}
$$

(Rel-Energy-Doi)
where $C_{1}(t), C_{2}(t) \in L^{1}(0, T)$ coming from norms of $v$ and $C$ is a constant independent of time.

Control of $\int_{\mathbb{S}^{1}}|f-g| d m$. The key quantity of control is $\int_{\mathbb{S}^{1}}|f-g| d m$. Let $\operatorname{sgn}_{\beta}$ be a smooth, increasing regularization of the sign function such that $\operatorname{sgn}_{\beta}(s)=\operatorname{sign}(s)$ for $|s| \geq \beta$, and let $|s|_{\beta}=\int_{0}^{s} \operatorname{sgn}_{\beta}(r) d r$. Then as $\beta \rightarrow 0$, we have $|s|_{\beta} \rightarrow|s|$. Then by subtracting two Fokker-Planck equations of (Doil) for $f$ and $g$, then by replacing $\phi_{x}(x) \phi_{m}(m)$ in Cauchy-FP) by $\operatorname{sgn}_{\beta}(f-g) \int|f-g|_{\beta} d m$ (we can do this since $C^{\infty}\left(\mathbb{T}^{2}\right) \otimes C^{\infty}\left(\mathbb{S}^{1}\right)$ is dense in $L^{p}\left(\mathbb{T}^{2} \times \mathbb{S}^{1}, f(x, t, m) d x d m(g(x, t, m) d x d m)\right)$ for any $\left.p \geq 1\right)$, then by checking that terms from diffusion are positive, and finally taking the limit $\beta \rightarrow 0$ (and dividing by $\left\|\int_{\mathbb{S}^{1}}|f-g| d m\right\|_{L^{2}}$ ), we obtain

$$
\begin{equation*}
\left\|\int_{\mathbb{S}^{1}}|f-g| d m\right\|_{L^{2}}(t) \leq \int_{0}^{t}\left(\|u-v\|_{W^{1, \infty}}\left\|\int_{\mathbb{S}^{1}}\left|\nabla_{x, m} g\right| d m\right\|_{L^{2}}+C B_{4}\left\|\nabla_{x}(u-v)\right\|_{L^{2}}\right) d s \tag{FPdiff}
\end{equation*}
$$

Noting that

$$
\left\|\int_{\mathbb{S}^{1}}|\nabla g| d m\right\|_{L^{2}}=\left(\int_{\mathbb{T}^{2}}\left(\int_{\mathbb{S}^{1}}|\nabla g| d m\right)^{2} d x\right)^{\frac{1}{2}} \leq\left(\int_{\mathbb{T}^{2}} B_{4} \int_{\mathbb{S}^{1}} \frac{|\nabla g|^{2}}{g} d m d x\right)^{\frac{1}{2}}
$$

we obtain

$$
\begin{gather*}
\left\|\int_{\mathbb{S}^{1}}|f-g| d m\right\|_{L^{2}}(t) \leq \int_{0}^{t}\left(B_{4}^{\frac{1}{2}}\left(\int_{\mathbb{T}^{2} \times \mathbb{S}^{1}} \frac{\left|\nabla_{x, m} g\right|^{2}}{g}(s) d m d x\right)^{\frac{1}{2}}+C B_{4}\right)\|(u-v)(s)\|_{W^{3,2}} d s \\
\leq C\|u-v\|_{L^{2}\left(0, t ; W^{3,2}\right)}\left(\sqrt{t}+\left(\int_{0}^{t} \int_{\mathbb{T}^{2} \times \mathbb{S}^{1}} \frac{\left|\nabla_{x, m} g\right|^{2}}{g}(s) d m d x d s\right)^{\frac{1}{2}}\right) \leq C\left(\sqrt{B_{1}}+\sqrt{t}\right)\|u-v\|_{L^{2}\left(0, t ; W^{3,2}\right)} \tag{58}
\end{gather*}
$$

thanks to the free energy estimate (FE). Therefore,

$$
\begin{equation*}
\left\|\int_{\mathbb{S}^{1}}|f-g| d m(t)\right\|_{L^{2}}^{2} \leq C(1+t)\|u-v\|_{L}^{2}\left(0, t ; W^{3,2}\right)^{2} . \tag{FPdiff2}
\end{equation*}
$$

Control of moments. Finally, we apply the relative energy estimates for evolution equation of moments (ME), and apply (FPdiff2) in closing the effect of higher moments to obtain the following:

$$
\begin{gather*}
\frac{d}{d t}\left\|M_{n}(f)-M_{n}(g)\right\|_{W^{1,2}}^{2}+\nu\left\|M_{n}(f)-M_{n}(g)\right\|_{W^{2,2}}^{2} \\
\leq C^{n}\left\|M_{n}(f)-M_{n}(g)\right\|_{W^{1,2}}^{2}+C_{n}\|u-v\|_{W^{1,2}}^{2}+C_{3}(t)\left\|\int_{\mathbb{S}^{1}}|f-g| d m\right\|_{L^{2}}^{2} \\
\frac{d}{d t}\left\|M_{n}(f)-M_{n}(g)\right\|_{W^{2,2}}^{2}+\nu\left\|M_{n}(f)-M_{n}(g)\right\|_{W^{3,2}}^{2}  \tag{Mdiff}\\
\leq C^{n}\left\|M_{n}(f)-M_{n}(g)\right\|_{W^{2,2}}^{2}+C^{n}\|u-v\|_{W^{2,2}}^{2}+\frac{\nu}{2}\left\|\Delta_{x}\left(M_{n+2}(f)-M_{n+2}(g)\right)\right\|_{L^{2}}^{2} \\
+\frac{C^{n}}{\nu}\left(\left\|\int_{\mathbb{S}^{1}}|f-g| d m\right\|_{L^{2}}^{2}+\| \nabla_{x}\left(M_{n+2}(f)-M_{n+2}(g) \|_{L^{2}}^{2}\right),\right.
\end{gather*}
$$

where $C_{3} \in L^{1}(0, T)$ depending on the norms of $v$ and $g$, and $C^{n}$ are constants depending only on $n$ and norms of $v$ and $g$. Summing up (Rel-Energy-Doi), (FPdiff2), and (Mdiff), we finally obtain

$$
\begin{gather*}
\frac{d}{d t} F(t)+G(t) \leq \phi(t)\left(F(t)+\int_{0}^{t} G(s) d s\right), \phi \in L^{1}(0, T), G(t)=\|(u-v)(t)\|_{W^{3,2}}^{2}, \\
F(t)=\|u-v\|_{W^{2,2}}^{2}+\left\|\sigma_{E}(f)-\sigma_{E}(g)\right\|_{W^{2,2}}^{2}+\left\|M_{4}(f)-M_{4}(g)\right\|_{W^{2,2}}^{2}+\left\|M_{6}(f)-M_{6}(g)\right\|_{W^{1,2}}^{2}(t) \tag{59}
\end{gather*}
$$

as desired. Noting that $F(0)=0$ and applying Grönwall's inequality, we see that $F(t)=$ $\int_{0}^{t} G(s) d s=0$. This proves the uniqueness of the solution, and completes the proof of Theorem 1 .

## 5 Conclusion

We proved Theorem [1 which states that the well-posedness of strong solutions of (Doi) with free energy estimates. Also we showed well-posedness of strong solutions of (DA), which is an approximate closure of (Doil). In addition, we report that the condition $\eta<\eta_{c}$ for some critical $\eta_{c}$, which was used to control viscous stress term, was not necessary and we can show global well-posedness for all $\eta>0$.
