Second order difference approximation for a class of Riesz space fractional advection-dispersion equations with delay

Abstract

In this paper, we propose numerical scheme for the Riesz space fractional advectiondispersion equations with delay (RFADED). Firstly, analytical solution for RFADED in terms of the functions of Mittag-Leffler type is derived. Secondly, the fractional backward differential formulas (FBDF) method and shifted Grünwald method are introduced to the Riesz space fractional derivatives. Next, stability and convergency of these methods have been proved. Thirdly, Crank-Nicolson scheme for solving this problem is proposed. We prove that the scheme is conditionally stable and convergent with the order accuracy of $O(\kappa^2 + h^2)$. Finally, some numerical results are given to demonstrate that presented method is a computationally efficient and accurate method for solving RFADED.

1. Introduction

In the past few decades, fractional calculus has attracted increasing interest due to its applications in science, for examples, physics, engineering, biology, economics and finance [\[1,](#page-29-0) [2,](#page-30-0) [3,](#page-30-1) [4\]](#page-30-2). The fractional-order models have proved to be more accurate than integer-order models for the memory and hereditary properties of the fractional-order

derivative [\[5,](#page-30-3) [6\]](#page-30-4). Fractional differential equations (FDEs) provide a powerful and flexible tool for modeling and describing the behavior of science such as real materials [\[1](#page-29-0)], fluid dynamics [\[3\]](#page-30-1), finance, electromagnetic waves, electrochemical process [\[2\]](#page-30-0), biological systems, control theory [\[7\]](#page-30-5) and so on. Some numerical methods to solve the FDEs have been discussed in [\[8](#page-30-6), [9,](#page-30-7) [10](#page-30-8), [11,](#page-30-9) [12](#page-31-0), [13\]](#page-31-1). A delay differential equation is a differential equation in which the derivative of the function at any time depends on the solution at the previous time. The fractional differential equations with delay (FDDEs) have important applications in many fields, such as, chemistry, physics, biology and finance [\[14](#page-31-2)]. Analytical solutions of FDDEs are complicated and hence the numerical solutions play an important role. Numerical methods for solving FD-DEs are very important. For more details we refer the reader to a series of articles [\[15,](#page-31-3) [16,](#page-31-4) [17,](#page-31-5) [18,](#page-31-6) [19](#page-31-7)]. Partial differential equations with delays appear in many fields such as in biology, medicine, population ecology, control systems and climate models [\[7\]](#page-30-5). Some numerical methods for solving delay partial differential equations are studied in [\[20](#page-31-8), [21](#page-32-0), [22\]](#page-32-1). Numerical methods for solving fractional partial differential equations are investigated in [\[23,](#page-32-2) [24,](#page-32-3) [25\]](#page-32-4).

In this paper, we consider a class of Riesz space fractional advection-dispersion equations (RFADEs)[\[26\]](#page-32-5) with delay:

subject to the initial condition:

where $0 < \gamma < 1$, $0 < \alpha < 1$, $1 < \beta \le 2$. *u* is a solute concentration, K_{α} and K_{β} are the dispersion coefficient and the average fluid velocity, respectively. Here, we take $K_{\alpha} > 0$, $K_{\beta} \geq 0$, $K_{\gamma} \geq 0$. Also *f* is a continuous function on $[0, T] \times [0, L]$, $T > 0, L >$ 0 and *g* is a continuous function on $[-\tau, 0] \times [0, L]$, $\tau > 0$. The Riesz space fractional operator on a finite domain [0, L] is defined as [\[26\]](#page-32-5)

Also, the left and right Riemann-Liouville derivatives of order $0 < \zeta \leq 2$, for a given function $u(x,t)$ on a finite interval [0, L], are defined as [\[6\]](#page-30-4):

Note that the time fractional derivative $\frac{\partial^{\gamma}}{\partial x^{\gamma}}$ $\frac{\partial}{\partial t^{\gamma}}$ at the Eq [\(1\)](#page-1-0) is the left Riemann-Liouville derivatives. Analytical and numerical solution of partial fractional differential equations (PFDEs) with delay are more complicated and less studied in the literature. The solutions of PFDEs are different from the ones for PFDEs with delay. Let us consider the case $0 \le t \le \tau$ in the our model. Since $-\tau \le t - \tau \le 0$, then $u(x, t - \tau) = g(x, t - \tau)$ and therefore Eq [\(1\)](#page-1-0) can be rewritten as

where $\hat{g}(x,t) = f(x,t) - K_\gamma \frac{\partial^{\gamma} g(x,t-\tau)}{\partial x^{\gamma}}$ $\frac{f(x,t-\tau)}{\partial t^{\gamma}}$. Since *f* and $\frac{\partial^{\gamma} g(x,t-\tau)}{\partial t^{\gamma}}$ $\frac{\partial f}{\partial t^{\gamma}}$ are continuous functions, $\hat{g}(x,t)$ is also continuous and so [\(6\)](#page-2-0) is solvable. Thus, we can change initial delay function to control dynamic properties of solutions.

We consider the following three fractional advection–dispersion models as the following form

- When $K_{\gamma} = 0$, Eq [\(1\)](#page-1-0) reduces to RFADE [\[26](#page-32-5)].
- When $K_{\gamma} = 0$ and $K_{\alpha} = 0$, Eq [\(1\)](#page-1-0) reduces to Riesz space fractional diffusion equation(RFDE)[\[26\]](#page-32-5).
- When $K_{\gamma} > 0$, Eq [\(1\)](#page-1-0) reduces to RFADE with delay (RFADED) (our main problem).

The fractional advection-dispersion equation is used in groundwater hydrology to model the transport of passive tracers carried by fluid flow in a porous medium [\[27,](#page-32-6) [28](#page-32-7), [29\]](#page-32-8). At the second models, physical considerations of a fractional advection–dispersion transport model restrict $0 < \alpha < 1$, $1 < \beta \le 2$ and we assume $K_{\alpha} > 0$ and $K_{\beta} \ge 0$ so that the flow is from left to right. The physical meaning of using homogeneous Dirichlet boundary conditions is that the boundary is set far enough away from an evolving plume such that no significant concentrations reach that boundary [\[30](#page-33-0)]. In this paper we consider RFADE with delay $(K_\gamma = 1)$.

Many models with Riesz-space fractional derivatives have recently been studied by many authors. To approximate the Riesz fractional derivative and use to numerical solving FDEs and FPDEs, there have existed several analytical and numerical methods. Zhang and Liu [\[31\]](#page-33-1) obtained the analytical solutions of space Riesz and time Caputo fractional partial differential equations. Chen et al. [\[32](#page-33-2)] studied the analytical solution for the space Riesz fractional reaction dispersion equation by using the Laplace and Fourier transform. Yang et al. [\[26\]](#page-32-5) studied the space Riesz fractional diffusion and advection–dispersion equations and solving these problems on a finite domain by using the L1, L2 methods. Later on, they [\[33](#page-33-3)] presented two numerical methods for solving the Riesz fractional advectiondispersion equation by using the Galerkin finite element and a backward difference methods. Shen et al. [\[34\]](#page-33-4) used a second-order numerical scheme for the space Riesz fractional advection-dispersion equation based on fractional central difference operator. Yang et al. [\[26](#page-32-5)] presented three numerical methods for the space Riesz fractional diffusion and advection-dispersion equations on a finite domain. Celik and Duman [\[35](#page-33-5)] obtained the numerical solutions of the fractional diffusion equation with the space Riesz fractional derivative on a finite domain based on the fractional central difference operator. Recently, Ding et al. [\[36\]](#page-33-6) constructed two different fourth-order numerical schemes for the Riesz derivative and applied to the spatial Riesz fractional diffusion equation. Later on, they [\[37\]](#page-33-7) developed two highorder approximate schemes (sixth- and eighth-order) for the Riesz fractional derivative and use to solve the following space Riesz fractional reaction-dispersion equation. Very recently, Ding and Li [\[38\]](#page-33-8) constructed high-order (from 2nd-order to 6th-order) numerical schemes to approximate the Riesz derivatives and develop three kinds of difference

schemes for the Riesz space fractional turbulent diffusion equation. Also, Ding and Li [\[39\]](#page-33-9) derived even-order fractional-compact numerical differential formulas for Riesz derivatives and the fourth-order formula applied to solving the Riesz spatial fractional telegraph equation. To study the long-term dynamic behaviors of these models based on Riesz derivatives, analytical solution will play a vital role. In general, since the fractional integral and fractional derivatives have non-local properties. Therefore, it seems difficult to find the analytical solution of most of these equations. Thus, it is necessary and important to design the numerical schemes to solve these equations. Other numerical methods for solving the fractional advection-dispersion equation are investigated in [\[40](#page-34-0), [41](#page-34-1), [42](#page-34-2), [43](#page-34-3), [36](#page-33-6), [44,](#page-34-4) [26\]](#page-32-5).

In this paper, we consider Eqs.[\(1-](#page-1-0)[2\)](#page-1-1). Firstly, we obtain analytical solution of this equation. Secondly, we use fractional backward differential formulas method of second order for $0 < \alpha < 1$ and shifted Grünwald difference (WSGD) operators for $1 < \beta \leq 2$ to approximate the Riesz space fractional derivative. Next, we obtain the Crank-Nicolson scheme by using the finite difference method for the RFADED. Also, we prove that the Crank-Nicolson scheme is conditionally stable and convergent with the accuracy $O(\kappa^2 + h^2)$.

The paper is organized as follows. In Section 2, we recall some basic definitions of fractional calculus. In Section 3, analytical solution of problem is presented. Fractional backward differential formulas(FBDF) method of second order is introduced in Section 4. In Section 5, shifted Grünwald method is presented. The presented numerical method is proposed and applied to solve the Riesz space fractional advectiondispersion equations with delay (RFADED), stability and convergency of method are proved in Section 6. Finally, some numerical results are given in order to confirm the theoretical analyzes in Section 7.

2. Preliminaries

In this section, we will introduce some of the fundamental definitions. Let $\mathbb{C}(\mathbb{J},\mathbb{R})$ denotes the Banach space of all continuous functions from $\mathbb{J} = [0, T]$ into $\mathbb R$ with the norm

 $\mathbb{C}^n(\mathbb{J},\mathbb{R})$ denotes the class of all real valued functions defined on $\mathbb{J} = [0,T]$, $T > 0$ which have continuous *n*th order derivatives.

Definition 2.1 ([\[6](#page-30-4)]). The fractional integral of order $\alpha > 0$ of the function $f \in$ $\mathbb{C}(\mathbb{J},\mathbb{R})$ is defined as

If $\lambda \in \mathbb{C}$, $\alpha, \beta, \tau \in \mathbb{R}$ and $m \in \mathbb{Z}$ then laplace transform of $G^{\lambda, \tau, m}_{\alpha, \beta}$ $\alpha, \beta^{n, \tau, m}(t)$ is:

3. Analytical solution of problem

Lemma 1. ([\[45](#page-34-5)]) Suppose the Laplacian $(-\Delta)$ has complete set of orthonormal eigenfunctions φ_n corresponding to eigenvalue λ_n^2 on a bounded region Ω i.e. $(-\Delta)\varphi_n =$ $\lambda_n^2 \varphi_n$ on Ω ; $B(\Omega) = 0$ on $\partial \Omega$ where $B(\Omega)$ is one of the standard three homogeneous boundary conditions. Let

We consider Eqs. [\(1–](#page-1-0)[2\)](#page-1-1), where $\mu_1(t)$ and $\mu_2(t)$ are nonzero smooth functions with order–one continuous derivatives. Let

4. Fractional Backward Differential Formulas(FBDF) method of second order

4.1. Discrete convolution quadratures

We consider the initial value problem

4.2. Fractional linear multistep methods

Fractional linear multistep methods (FLMMs) for the approximate solution of Eq. [\(39\)](#page-9-0) is as the following form (see[\[11\]](#page-30-9))

As shown in [\[47](#page-34-7)], FLMMs ([\[11](#page-30-9), [46\]](#page-34-6)) can be equivalently reformulated as Eq. [\(42\)](#page-9-3) with weights ω_j obtained as the coefficients in the FPS of the fractional-order power of the generating function (see [\[11\]](#page-30-9)):

Methods of this kind, named as FLMMs, when applied to [\(39\)](#page-9-0) we will have Eq. [\(42\)](#page-9-3) where weights are given in [\(44\)](#page-10-0).

4.3. The second order FBDF

The n-step backward differentiation formulas is the implicit linear multistep formula with $\beta_0 = \beta_1 = ... = \beta_{n-1} = 0$ in [\(43\)](#page-10-1). The second order BDF formulas for ODEs is given by

4.5. Analysis of linear stability and consistency

In order to study consistency and linear stability of FBDF consider the linear test problem

4.5.1. Consistency of FBDF2

Theorem 2. The FBDF2 method is consistent of second order. **Proof.** A convolution quadrature $\omega^{(\alpha)}$ is consistent of order p if

The relation is true for $n = 4$. Suppose $1-\varepsilon < \frac{\omega_{n-1}}{\omega_{n-2}}$ $\frac{\omega_{n-1}}{\omega_{n-2}}$ < 1, 0 < ε < $\frac{1}{3}$ is true. We will prove it for *n*. If $\zeta_n = \frac{\alpha+1}{n}$ and $n \ge 4$ then we have

Theorem 3. Numerical solution of problem [\(54\)](#page-12-0) obtained by FBDF2 is unconditionally stable.

Proof. By using FBDF2 method for [\(54\)](#page-12-0), the matrix form of the problem will be as the

If λ < 0 then by means of Lemma's 2-3, coefficient matrix is strictly diagonally dominant. Therefore numerical solution of problem obtained by the FBDF2 method will be unconditionally stable.

4.5.3. Convergent of FBDF2

Theorem 4. ([\[11](#page-30-9)]) A convolution quadrature $\omega^{(\alpha)}$ is convergent of order p if and only if it is stable and consistent of order *p*.

Theorem 5. The FBDF2 method is convergent of second order.

Proof. Since FBDF2 is consistence of second order and stable by means of Theorem 4, therefore the present method is convergent of second order.

6. Numerical method for the RFADE with delay

In this section, we approximate the Riesz space fractional derivative and derive the Crank-Nicolson scheme of the equation. We partition the interval [0,*L*] into an uniform mesh with the space step $h = L/M$ and the time step $t = T/N$, where M, N being two positive integers. The set of grid points are denoted by $x_i = ih$ and $t_j = j\kappa$ for $i = 1, ..., M$ and $j = 1, ..., M$.

We consider Eq [\(1\)](#page-1-0) and suppose $u(x_i, t_j) = u_i^j$, $f(x_i, t_j) = f_i^j$ and $\frac{\partial^{\gamma} g(x_i, t - \tau)}{\partial t^{\gamma}}$ $\frac{(x,t-\tau)}{\partial t^{\gamma}}=g(x,t).$ We take $\eta_{\alpha} = \frac{c_{\alpha} \kappa K_{\alpha} h^{-\alpha}}{2}$ $\frac{K_{\alpha}h^{-\alpha}}{2}$ and $\eta_{\beta} = \frac{c_{\beta} \kappa K_{\beta}h^{-\beta}}{2}$ $\frac{2}{2}$. Therefore, we have

\varepsilon^j = L\varepsilon^{j-1} + X,
$$

with iterating and by using initial condition of main problem, we have

\varepsilon^{j} = (L^{j-1} + L^{j-2} + \dots + I)X.
$$

By using Lemma 6, we have

\|\varepsilon^{j}\|_{\infty} \leq (\|L^{j-1}\|_{\infty} + \|L^{j-2}\|_{\infty} + \dots + \|I\|_{\infty}) \|X\|_{\infty}
$$

= (\|L\|_{\infty}^{j-1} + \|L\|_{\infty}^{j-2} + \dots + \|I\|_{\infty}) \|X\|_{\infty}
\leq (1 + 1 + \dots + 1) \|X\|_{\infty}
\leq jO(\kappa^{3} + \kappa h^{2}) = TO(\kappa^{2} + h^{2}).

Therefore, we have

$$
\|\varepsilon^j\|_{\infty} \leq C O(\kappa^2 + h^2).
$$

7. Test examples

Since this model [\(1\)](#page-1-0) has not been considered so far, thus we consider three cases in this section. We consider the Riesz space fractional advection-dispersion equation without a source term and delay ($K_{\gamma} = 0$, $\tau = 0$, $f(x,t) = 0$). Next, the Riesz space fractional advection-dispersion equation with a source term and without delay $(K_\gamma = 0, \tau = 0)$ is considered. Finally, an example with delay and a source term is given to demonstrate the applicability and accuracy of the presented numerical method. Example 1. ([\[26\]](#page-32-5)) We consider the following Riesz space fractional advection-dispersion equation

$$
\frac{\partial u(x,t)}{\partial t} = K_{\alpha} \frac{\partial^{\alpha} u(x,t)}{\partial |x|^{\alpha}} + K_{\beta} \frac{\partial^{\beta} u(x,t)}{\partial |x|^{\beta}}, \ 0 < x < \pi, \ 0 < t \le T,
$$

\n
$$
u(x,0) = x^{2}(\pi - x),
$$

\n
$$
u(0,t) = u(\pi,t) = 0.
$$
\n(79)

where, $0 < \alpha < 1$, $1 < \beta \le 2$. From [\[26](#page-32-5)] we know the exact solution of [79](#page-23-0) is given by

$$
u(x,t) = \sum_{n=1}^{\infty} \left[\frac{8}{n^3} (-1)^{n+1} - \frac{4}{n^3} \right] \sin(nx) \exp\left(-\left[K_\alpha (n^2)^{\frac{\alpha}{2}} + K_\beta (n^2)^{\frac{\beta}{2}} \right] t \right). \tag{80}
$$

The absolute errors of MTM scheme given in Yang et al.[\[26\]](#page-32-5) and presented scheme are shown in Tables 1 and they are compared for different values of *h* and $\alpha = 0.4$, $\beta =$ 1.8, $t = 0.4$ and $K_{\alpha} = K_{\beta} = 0.25$.

Figure 2: The numerical approximation by the presented method for example 1, with different values of $\alpha = 0.1, 0.3, 0.5, 0.7, 0.9$, when $\beta = 1.8$ and $T = 0.5, 1.5, 2.5, 3.5$.

Figure 3: The numerical approximation by the presented method for example 1, with different values of $\beta = 1.2, 1.4, 1.6, 1.8, 2$, when $\alpha = 0.4$ and $T = 0.5, 1.5, 2.5, 3.5$.

Figure 4: The numerical approximation and exact solution by the presented method for example3, for $\alpha = 0.8$, $\gamma = 0.7$, $\beta = 1.2$, when T = 1.

From Table 1 and Figs 2-3, it can be observed that the errors of the presented method are significantly compared with the literature.

Example 2. [\[26](#page-32-5)] We consider the following Riesz space fractional advection-

\frac{K_{\alpha} t^{\alpha} e^{\beta t}}{2 \cos(\frac{\alpha \pi}{2})} \left[\frac{24((1 - x)^{4 - \alpha} + x^{4 - \alpha})}{\Gamma(5 - \alpha)} - \frac{12((1 - x)^{3 - \alpha} + x^{3 - \alpha})}{\Gamma(4 - \alpha)} + \frac{2((1 - x)^{2 - \alpha} + x^{2 - \alpha})}{\Gamma(3 - \alpha)} \right]
$$

+
$$
\frac{K_{\beta} t^{\alpha} e^{\beta t}}{2 \cos(\frac{\beta \pi}{2})} \left[\frac{24((1 - x)^{4 - \beta} + x^{4 - \beta})}{\Gamma(5 - \beta)} - \frac{12((1 - x)^{3 - \beta} + x^{3 - \beta})}{\Gamma(4 - \beta)} + \frac{2((1 - x)^{2 - \beta} + x^{2 - \beta})}{\Gamma(3 - \beta)} \right]

The exact solution of Eq.[\(81\)](#page-26-0) is given by $u(x,t) = t^{\alpha} e^{\beta t} x^2 (1-x)^2$.

The absolute errors of $L1/L2$ approximation method and the standard/shifted Grünwald

approximation method given in Yang et al.[\[26\]](#page-32-5) and presented scheme are shown in Tables 2 and they are compared for different values of *h* and $\alpha = 0.4$, $\beta = 1.7$, $t = 2$ and $K_{\alpha} = K_{\beta} = 2$.

Example 3. We consider the following Riesz space fractional advection-dispersion equation with a source term and delay

\frac{\partial u(x,t)}{\partial t} + \frac{\partial^{\gamma} u(x,t-1)}{\partial t^{\gamma}} = \frac{\partial^{\alpha} u(x,t)}{\partial |x|^{\alpha}} + \frac{\partial^{\beta} u(x,t)}{\partial |x|^{\beta}} + f(x,t),
$$
(82)

subject to the initial condition:

u(x,t) = x^2(1-x)^2t^2, \ -1 \le t \le 0, \ 0 \le x \le 1,
$$

u(0,t) = 0, \ u(1,t) = 0, \ 0 \le t \le 1,
$$

where $0 < \gamma < 1$, $0 < \alpha < 1$, $1 < \beta \le 2$ and

$$
f(x,t) = 2x^{2}(1-x)^{2}t + \left[\frac{\Gamma(3)}{\Gamma(3-\gamma)}t^{2-\gamma} - 2\frac{\Gamma(2)}{\Gamma(2-\gamma)}t^{1-\gamma} + \frac{\Gamma(1)}{\Gamma(1-\gamma)}t^{-\gamma}\right]x^{2}(1-x)^{2} + \frac{t^{2}}{2\cos(\frac{\alpha\pi}{2})}\left[\frac{24((1-x)^{4-\alpha}+x^{4-\alpha})}{\Gamma(5-\alpha)} - \frac{12((1-x)^{3-\alpha}+x^{3-\alpha})}{\Gamma(4-\alpha)} + \frac{2((1-x)^{2-\alpha}+x^{2-\alpha})}{\Gamma(3-\alpha)}\right] + \frac{t^{2}}{2\cos(\frac{\beta\pi}{2})}\left[\frac{24((1-x)^{4-\beta}+x^{4-\beta})}{\Gamma(5-\beta)} - \frac{12((1-x)^{3-\beta}+x^{3-\beta})}{\Gamma(4-\beta)} + \frac{2((1-x)^{2-\beta}+x^{2-\beta})}{\Gamma(3-\beta)}\right].
$$

Its exact solution is $u(x,t) = x^2(1-x)^2t^2$. Some numerical results are reported at Tables 3–5.

8. Conclusion

In this paper, the fractional backward differential formulas method and shifted Grünwald difference (WSGD) operators are used to approximate the Riesz space fractional derivative. The presented numerical method is proposed and applied to solve the Riesz space fractional advection-dispersion equations with delay. We prove that the difference scheme is conditionally stable and convergent with the accuracy $O(\kappa^2 + h^2)$.

Furthermore, the analytical solution for RFADED in terms of the functions of Mittag– Leffler type has been obtained. Finally, some results are given to demonstrate the effectiveness of theoretical analysis. In the future, we would like to investigate this method and technique of high order for solving this problem.
