# Concentration Behavior of Nonlinear Hartree-type Equation with almost Mass Critical Exponent

& \text { Abstract } \\
& \text { We study the following nonlinear Hartree-type equation } \\
& -\Delta u+V(x) u-a\left(\frac{1}{|x|^{\gamma}} *|u|^{2}\right) u=\lambda u \text {, in } \mathbb{R}^{N},
\end{aligned}
$$

where $a>0, N \geq 3, \gamma \in(0,2)$ and $V(x)$ is an external potential. We first study the asymptotic behavior of the ground state of equation for $V(x) \equiv 1, a=1$ and $\lambda=0$ as $\gamma \nearrow 2$. Then we consider the case of some trapping potential $V(x)$, and show that all the mass of ground states concentrate at a global minimum point of $V(x)$ as $\gamma \nearrow 2$, which leads to symmetry breaking. Moreover, the concentration rate for maximum points of ground states will be given.
Keywords: Hartree-type equation; Energy estimate; Concentration; Symmetry breaking; Almost mass critical

## 1 Introduction

In this paper, we consider the concentration behavior of the following nonlinear Hartree-type equation as $\gamma \nearrow 2$

$$
\begin{equation*}
-\Delta u+V(x) u-a\left(\frac{1}{|x|^{\gamma}} *|u|^{2}\right) u=\lambda u, \quad \text { in } \mathbb{R}^{N} \tag{1.1}
\end{equation*}
$$

where $\gamma>0, N \geq 3, a>0$ is the parameter, $\lambda \in \mathbb{R}$, and $V(x)$ is an external potential. This equation can be used to describe the standing waves of the form $\psi(t, x)=e^{i \lambda t} u(x)$ of the focusing time-dependent equation

$$
\begin{equation*}
i \psi_{t}=-\Delta \psi+V(x) \psi-a\left(\frac{1}{|x|^{\gamma}} *|\psi|^{2}\right) \psi, \quad \text { in } \mathbb{R}^{N} \times \mathbb{R}_{+} . \tag{1.2}
\end{equation*}
$$

[^0]Equation (1.2) can describe the geometry of stars and planets in celestial mechanics [15], and quantum mechanics for investigating Bose-Einstein condensates (BEC) and ThomasFermi type problems [2]. In particular, for $a>0$ and $\gamma=1$, the interaction is attractive Coulomb action, the model can describe the quantum mechanics of a polaron, see [17, 21].

There have been a great deal of papers devote to equation (1.1) in different aspects. For results about the existence of positive ground states, one can see [1, 13, 14, 18, 19, 20, [26]; Cingolani [29] and Clap [31] investigated the existence of multiple solutions; for the uniqueness of the ground state, see for example [13, 16, 22, 24, 25]; and the semi-classical analysis results, see [28, 30] and the references therein.

When $\gamma=2$, the above Hartree-type nonlinearity in $\mathbb{R}^{N}$ is corresponding to mass critical case for all $N \geq 3$. The authors in [3, 14, 27] considered a minimizing variational problem corresponding to (1.1), and proved that there exists a constant $a^{*}$ such that (1.6) admits at least one minimizer if and only if $a<a^{*}$, where $a^{*}=\left\|Q_{2}\right\|_{2}^{2}$, and $Q_{2}$ is the positive radially symmetric ground state of the following equation

$$
\begin{equation*}
-\Delta u+u-\left(\frac{1}{|x|^{2}} *|u|^{2}\right) u=0, \quad \text { in } \mathbb{R}^{N} \tag{1.3}
\end{equation*}
$$

Furthermore, the concentration and symmetry breaking of minimizers as $a \nearrow a^{*}$ were also obtained for different potentials $V(x)$. We mention that such kind of mass critical problems have been studied for cubic nonlinearity in $\mathbb{R}^{2}$ in the past few years, see [4, 5, 6, 7, 8, and the references therein.

Here we state the work of Guo, Zeng and Zhou [7], in which they studied concentration behavior of the following almost mass critical nonlinear Schrödinger equations as $q \nearrow 2$ (2 is mass critical exponent)

$$
-\triangle u+(V(x)+\lambda) u-a|u|^{q} u=0, \quad(t, x) \in \mathbb{R}^{1} \times \mathbb{R}^{2}
$$

where $a>a^{*}=\|Q\|_{2}^{2}, Q$ is the unique (up to translations) radially symmetric positive solution of the following limiting equation

$$
\begin{equation*}
-\triangle u+u-|u|^{2} u=0, \quad \text { in } \mathbb{R}^{2} \tag{1.4}
\end{equation*}
$$

By using constrained variational method and energy estimates they present a detailed analysis of the concentration and symmetry breaking of the solutions for above equation as $q \nearrow 2$.

Inspired by [7], our focuses here will be on concentration behavior of nonlinear Hartreetype equation (1.1) as almost mass critical exponent $\gamma \nearrow 2$. Comparing with the results in [7], we should deal with the nonlocal term $\left(\frac{1}{|x|^{\gamma}} *|u|^{2}\right) u$, and the almost mass critical exponent comes from Hartree action $\frac{1}{|x|^{\gamma}}$, not the power exponent of $u$, this will bring some difficulties; on the other hand, in this case we can consider in $\mathbb{R}^{N}$ for all $N \geq 3$, while [7] only studied the cubic power exponent in $\mathbb{R}^{2}$.

Firstly, we study the asymptotic behavior of ground states of equation (1.1) for $V(x) \equiv$ $1, a=1$ and $\lambda=0$ as $\gamma \nearrow 2$, that is

\begin{equation*}
-\Delta u+u-\left(\frac{1}{|x|^{\gamma}} *|u|^{2}\right) u=0 \tag{1.5}
\end{equation*}
$$

We have the following Theorem.

Theorem 1.1. Let $Q_{\gamma}=Q_{\gamma}(|x|)$ be a positive radial ground state for equation (1.5) with $0<\gamma<2$. Then we have that

$$
\left\|Q_{\gamma}\right\|_{L^{2}\left(\mathbb{R}^{N}\right)} \rightarrow\left\|Q_{2}\right\|_{L^{2}\left(\mathbb{R}^{N}\right)} \quad \text { as } \gamma \nearrow 2 .
$$

Here $Q_{2}=Q_{2}(|x|)>0$ is a positive radial ground states for equation (1.3).
This is not an easy result, we shall employ the mountain pass structure of corresponding energy functional to obtain the uniform bound for $\left\|Q_{\gamma}\right\|_{H^{1}}$, and then obtain the above convergence by Pohozaev identity.

Next we will show asymptotic behaviors of ground states of equation (1.1) for general $V(x)$. We consider a corresponding minimizing variational problem. Notice that, (1.1) is an Euler-Lagrange equation of following minimizing problem:

\begin{align*}
e_{a}(\gamma) & =\inf _{\left\{u \in \mathcal{H}, \int_{\mathbb{R}^{N}} u^{2}=1\right\}} E_{\gamma}(u) ;  \tag{1.6}\\
E_{\gamma}(u) & =\int_{\mathbb{R}^{N}}\left(|\nabla u|^{2}+V(x)|u|^{2}\right)-\frac{a}{2} D_{\gamma}(u, u), \quad D_{\gamma}(u, u):=\int_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{|u(x)|^{2}|u(y)|^{2}}{|x-y|^{\gamma}} d x d y .
\end{align*}
$$

Where

$$
\mathcal{H}:=\left\{u \in H^{1}\left(\mathbb{R}^{N}\right): \int_{\mathbb{R}^{N}} V(x)|u|^{2} d x<\infty\right\} .
$$

Here we assume that $V(x): \mathbb{R}^{N} \rightarrow \mathbb{R}^{+}$is locally bounded and satisfies $V(x) \rightarrow \infty$ as $|x| \rightarrow \infty$. Without loss of generality, by adding a suitable constant we may assume that

$$
\inf _{x \in \mathbb{R}^{N}} V(x)=0,
$$

and $\inf _{x \in \mathbb{R}^{N}} V(x)$ can be attained. In this paper we are interested in addressing the limit behavior of minimizers for (1.6) when $\gamma \nearrow 2$ and $a>a^{*}$. By [10, 11] we have the following Gagliardo-Nirenberg inequality:

\begin{equation*}
D_{\gamma}(u, u) \leq C_{\gamma}\left(\int_{\mathbb{R}^{N}}|\nabla u|^{2} d x\right)^{\frac{\gamma}{2}}\left(\int_{\mathbb{R}^{N}}|u|^{2} d x\right)^{\frac{4-\gamma}{2}} \tag{1.7}
\end{equation*}
$$

where the best constant $C_{\gamma}=\frac{4}{4-\gamma}\left(\frac{4-\gamma}{\gamma}\right)^{\frac{\gamma}{2}} \frac{1}{\left\|Q_{\gamma}\right\|_{2}^{2}}$ and $N \geq 3 . Q_{\gamma}$ is an optimal minimizer of above inequality, satisfying equation (1.5), and also a positive radial ground state for (1.5).

Theorem 1.2. Assume that $N \geq 3, a>a^{*}=\left\|Q_{2}\right\|_{2}^{2}$ and $Q_{2}$ is the positive radially symmetric ground state of (1.3). And also assume that

$$
V \in \mathcal{C}^{1}\left(\mathbb{R}^{N}\right), \quad \lim _{|x| \rightarrow \infty} V(x)=\infty \quad \text { and } \quad \inf _{x \in \mathbb{R}^{N}} V(x)=0
$$

Let $u_{\gamma} \in \mathcal{H}$ be a non-negative minimizer of (1.6) with $\gamma \in(0,2)$. Then for each sequence $\left\{\gamma_{k}\right\}$ with $\gamma_{k} \nearrow 2$ as $k \rightarrow \infty$, there exists a subsequence of $\left\{\gamma_{k}\right\}$, still denoted by $\left\{\gamma_{k}\right\}$, such that $u_{\gamma_{k}}$ concentrates at a global minimum point $y_{0}$ of $V(x)$ in the following sense: for each large $k$, $u_{\gamma_{k}}$ has a unique global maximum point $\bar{z}_{k} \in \mathbb{R}^{N}$, satisfies

$$
\begin{equation*}
\lim _{k \rightarrow \infty}\left(\frac{a}{\left\|Q_{\gamma_{k}}\right\|_{2}^{2}}\right)^{-\frac{2}{2-\gamma_{k}}} u_{\gamma_{k}}\left(\left(\frac{a}{\left\|Q_{\gamma_{k}}\right\|_{2}^{2}}\right)^{-\frac{1}{2-\gamma_{k}}} x+\bar{z}_{k}\right)=\frac{1}{\left\|Q_{2}\right\|_{2}} Q_{2}(|x|) \text { in } H^{1}\left(\mathbb{R}^{N}\right), \tag{1.8}
\end{equation*}
$$

where $\bar{z}_{k} \rightarrow y_{0}$ as $k \rightarrow \infty$.

Remark 1. Under the assumption of $V(x)$ in Theorem 1.2, we have $\mathcal{H} \hookrightarrow L^{p}\left(\mathbb{R}^{N}\right)$ is compact, where $p \in\left[2, \frac{2 N}{N-2}\right)$. The existence of the non-negative minimizer of (1.6) is similar to [19, 32].

Remark 2. It follows from [24] that the uniqueness of positive ground state of (1.3) holds for $N=4$. If $N \geq 3$ and $N \neq 4$, we do not know that the positive ground state of equation (1.3) is unique. Therefore, if $N=4$, we can obtain that $Q_{\gamma} \rightarrow Q_{2}$ strongly in $H^{1}\left(\mathbb{R}^{4}\right)$ and the right-hand side of the (1.8) is unique. However, if $N \neq 4$, we only know that there exists a positive radial ground state such that the above limit convergence to it.

In the following we shall assume that the external potential $V$ satisfies that there exist $n \geq 1$ distinct points $x_{i} \in \mathbb{R}^{N}$ with $V\left(x_{i}\right)=0$, while $V(x)>0$ otherwise. Moreover, there are numbers of $p_{i}>0$ such that

$$
\begin{equation*}
V(x)=O\left(\left|x-x_{i}\right|^{p_{i}}\right) \text { near } x_{i}, \text { where } i=1,2, \ldots, n, \tag{1.9}
\end{equation*}
$$

and $\lim _{x \rightarrow x_{i}} \frac{V(x)}{\left|x-x_{i}\right|^{p_{i}}}$ exists for all $1 \leq i \leq n$.
Let $p=\max \left\{p_{1}, p_{2}, \ldots, p_{n}\right\}$, and let $\lambda_{i} \in(0, \infty]$ be given by

$$
\begin{equation*}
\lambda_{i}=\lim _{x \rightarrow x_{i}} \frac{V(x)}{\left|x-x_{i}\right|^{p_{i}}} \tag{1.10}
\end{equation*}
$$

Define $\lambda=\min \left\{\lambda_{1}, \ldots, \lambda_{n}\right\}$ and let

$$
\begin{equation*}
\mathcal{Z}:=\left\{x_{i}: \lambda_{i}=\lambda\right\} \tag{1.11}
\end{equation*}
$$

denote the locations of the flattest global minima of $V(x)$. By the above notations, we have the following result, which tells us some further about the concentration point $y_{0}$ given by Theorem 1.2.

Theorem 1.3. Under the assumptions of Theorem 1.2 and let $V(x)$ satisfy also the additional condition (1.9), then the unique concentration point $y_{0}$ obtained in Theorem 1.2 has the properties:

$$
\begin{equation*}
\lim _{k \rightarrow \infty}\left|\bar{z}_{k}-y_{0}\right|\left(\frac{a}{\left\|Q_{\gamma_{k}}\right\|_{2}^{2}}\right)^{\frac{1}{2-\gamma_{k}}}=0 \text { and } y_{0} \in \mathcal{Z} \tag{1.12}
\end{equation*}
$$

This paper is organised as follows. Section 2 is devoted to the proof of Theorem 1.1 by using the mountain pass structure. In section 3, we prove Lemma 3.2 on energy estimates of minimizers for (1.6). Finally, we use Lemma 3.2 to prove Theorem 1.2 and then utilize the blowup analysis to complete the proof of Theorem 1.3 in section 4.

## 2 The proof of Theorem 1.1

First note from [19] that the equation (1.5) has a radially symmetric and monotone decreasing positive ground state solution $Q_{\gamma}$ which satisfies the following Pohozaev identity:

\begin{equation*}
\frac{N-2}{2} \int_{\mathbb{R}^{N}}\left|\nabla Q_{\gamma}(x)\right|^{2} d x+\frac{N}{2} \int_{\mathbb{R}^{N}}\left|Q_{\gamma}(x)\right|^{2} d x=\frac{2 N-\gamma}{4} D_{\gamma}\left(Q_{\gamma}, Q_{\gamma}\right) \tag{2.1}
\end{equation*}
$$

for all $0<\gamma<4$, one can derive from (1.5) and (2.1) that $Q_{\gamma}(x)$ satisfies

$$
\begin{equation*}
\frac{1}{\gamma} \int_{\mathbb{R}^{N}}\left|\nabla Q_{\gamma}(x)\right|^{2} d x=\frac{1}{4-\gamma} \int_{\mathbb{R}^{N}}\left|Q_{\gamma}(x)\right|^{2} d x=\frac{1}{4} D_{\gamma}\left(Q_{\gamma}, Q_{\gamma}\right) . \tag{2.2}
\end{equation*}
$$

Now we define the energy functional of equation (1.3) and (1.5) by

$$
J_{\gamma}(u)=\frac{1}{2} \int_{\mathbb{R}^{N}}|\nabla u|^{2}+|u|^{2}-\frac{1}{4} D_{\gamma}(u, u), \quad \gamma \in(1,2] .
$$

Let

$$
G:=\left\{Q_{2}(x) \in H^{1}\left(\mathbb{R}^{N}\right): Q_{2}(x) \text { is a positive radial ground state of (1.3) }\right\} .
$$

Combining (2.1) and (2.2), we get the ground state energy

$$
J_{2}\left(Q_{2}\right)=\frac{1}{2} \int_{\mathbb{R}^{N}}\left|Q_{2}(x)\right|^{2} d x, \quad Q_{2} \in G .
$$

Then we have $a^{*}=\int_{\mathbb{R}^{N}}\left|Q_{2}(x)\right|^{2} d x$. That is, all positive ground states of equation (1.3) have the same $L^{2}$-norm. Similarly, we can obtain that all positive ground states of equation (1.5) have the same $L^{2}$-norm if $\gamma$ is fixed.

To prove Theorem 1.1, we divide the proof into several lemmas. The ground state energy level $J_{\gamma}$ satisfies the mountain pass characterization, i.e.,

$$
I_{\gamma}=\min _{u \in H^{1}\left(\mathbb{R}^{N}\right) \backslash\{0\}} \max _{t \geq 0} J_{\gamma}(t u) .
$$

First, we have the following convergence holds.
Lemma 2.1. Let $\left\{\gamma_{n}\right\}<2$ be a sequence converging to 2 . Then for any $u \in H_{\text {rad }}^{1}\left(\mathbb{R}^{N}\right)$

$$
D_{\gamma_{n}}(u, u) \rightarrow D_{2}(u, u), \text { as } n \rightarrow \infty .
$$

Let $\left\{u_{n}\right\} \subset H_{r a d}^{1}\left(\mathbb{R}^{N}\right)$ be a sequence converging weakly in $H_{r a d}^{1}\left(\mathbb{R}^{N}\right)$ to some $u_{0} \in H_{r a d}^{1}\left(\mathbb{R}^{N}\right)$. Then as $n \rightarrow \infty$

$$
D_{\gamma_{n}}\left(u_{n}, u_{n}\right) \rightarrow D_{2}\left(u_{0}, u_{0}\right) .
$$

Proof. By combining Hardy-Littlewood-Sobolev inequality and the compact Sobolev embedding. It is easy to see the above convergence holds.

Next, we prove the following uniform estimate for the ground states $Q_{\gamma}$.
Lemma 2.2. Assume that $Q_{\gamma} \in H^{1}\left(\mathbb{R}^{N}\right)$ be the positive radial ground state of equation (1.5), where $\gamma \in(1,2)$. Then there exists a positive constant $C>0$ such that

$$
\left\|Q_{\gamma}\right\|_{H^{1}} \leq C
$$

Proof. We claim that

$$
\limsup _{\gamma \rightarrow 2} I_{\gamma} \leq I_{2}
$$

Indeed, let $Q_{2}$ be a ground state of (1.3). Define $t_{\gamma}$ by the positive number satisfying

$$
J_{\gamma}\left(t_{\gamma} Q_{2}\right)=\max _{t>0} J_{\gamma}\left(t Q_{2}\right) .
$$

Elementary computation shows that

$$
t_{\gamma}=\left(\frac{\left\|Q_{2}\right\|_{H^{1}}^{2}}{D_{\gamma}\left(Q_{2}, Q_{2}\right)}\right)^{\frac{1}{2}}
$$

and $\lim _{\gamma \rightarrow 2} t_{\gamma}=1$. Now, by Lemma 2.1, we see from the mountain pass characterization of the ground states that as $\gamma \rightarrow 2$,

$$
\begin{aligned}
J_{\gamma}\left(Q_{\gamma}\right) & \leq J_{\gamma}\left(t_{\gamma} Q_{2}\right) \\
& =J_{2}\left(t_{\gamma} Q_{2}\right)+\frac{1}{4}\left(\int_{\mathbb{R}^{N}}\left(\frac{1}{|x|^{2}} *\left|t_{\gamma} Q_{2}\right|^{2}\right)\left|t_{\gamma} Q_{2}\right|^{2}-\int_{\mathbb{R}^{N}}\left(\frac{1}{|x|^{\gamma}} *\left|t_{\gamma} Q_{2}\right|^{2}\right)\left|t_{\gamma} Q_{2}\right|^{2}\right) \\
& \leq J_{2}\left(Q_{2}\right)+o(1) .
\end{aligned}
$$

Multiplying the equation (1.5) by $Q_{\gamma}$ and integrating by part, we get

$$
\left(\frac{1}{2}-\frac{1}{4}\right)\left\|Q_{\gamma}\right\|_{H^{1}}^{2}=J_{\gamma}\left(Q_{\gamma}\right) .
$$

By the above argument, we know that $\left\|Q_{\gamma}\right\|_{H^{1}}$ is uniformly bounded for $0<\gamma<2$.
The above Lemma 2.2 implies that $\left\{Q_{\gamma}\right\}$ is a bounded sequence in $H^{1}\left(\mathbb{R}^{N}\right)$. Therefore we can assume that, up to a subsequence, $Q_{\gamma_{n}}$ converges weakly to a nonnegative radial function $Q_{\infty} \in H_{r a d}^{1}\left(\mathbb{R}^{N}\right)$, that is

$$
Q_{\gamma_{n}} \rightharpoonup Q_{\infty} \text { in } H^{1}\left(\mathbb{R}^{N}\right)
$$

Moreover, by the compact embedding $H_{\text {rad }}^{1}\left(\mathbb{R}^{N}\right) \hookrightarrow L^{q}\left(\mathbb{R}^{N}\right)$ for any $2<q<\frac{2 N}{N-2}$ (see Strauss [23]), we can assume that

$$
Q_{\gamma_{n}} \rightarrow Q_{\infty} \quad \text { in } L^{q}\left(\mathbb{R}^{N}\right)
$$

for any $2<q<\frac{2 N}{N-2}$, and

$$
Q_{\gamma_{n}} \rightarrow Q_{\infty} \text { a.e. in } \mathbb{R}^{N} .
$$

By Lemma 2.1, we easily deduce that

$$
\lim _{\gamma_{n} \rightarrow 2} \int_{\mathbb{R}^{N}}\left(|x|^{-\gamma_{n}} *\left|Q_{\gamma_{n}}\right|^{2}\right)\left|Q_{\gamma_{n}}\right|^{2} d y=\int_{\mathbb{R}^{N}}\left(|x|^{-2} *\left|Q_{\infty}\right|^{2}\right)\left|Q_{\infty}\right|^{2} d y
$$

Furthermore, we multiply the equation (1.5) by $Q_{\gamma}$ and multiply the equation (1.3) by $Q_{\infty}$ to get

$$
\left\|Q_{\gamma_{n}}\right\|_{H^{1}}=D_{\gamma_{n}}\left(Q_{\gamma_{n}}, Q_{\gamma_{n}}\right) \rightarrow D_{2}\left(Q_{\infty}, Q_{\infty}\right)=\left\|Q_{\infty}\right\|_{H^{1}}
$$

Combining this with the weak convergence of $Q_{\gamma_{n}}$, we obtain the strong convergence of $Q_{\gamma_{n}}$ to $Q_{\infty}$ in $H^{1}\left(\mathbb{R}^{N}\right)$.

Lemma 2.3. It satisfies

$$
\liminf _{\gamma_{n} \rightarrow 2} I_{\gamma_{n}} \geq I_{2}
$$

Proof. We see from the mountain pass characterization of ground states to (1.5), that for every $t>0$,

$$
\begin{aligned}
I_{\gamma_{n}} & \geq J_{\gamma_{n}}\left(t Q_{\gamma_{n}}\right) \\
& =J_{2}\left(t Q_{\gamma_{n}}\right)+\frac{t^{4}}{4}\left(\int_{\mathbb{R}^{N}}\left(\frac{1}{|x|^{2}} *\left|Q_{\gamma_{n}}\right|^{2}\right)\left|Q_{\gamma_{n}}\right|^{2}-\int_{\mathbb{R}^{N}}\left(\frac{1}{|x|^{\gamma_{n}}} *\left|Q_{\gamma_{n}}\right|^{2}\right)\left|Q_{\gamma_{n}}\right|^{2}\right) \\
& =J_{2}\left(t Q_{\gamma_{n}}\right)+o(1) t^{4}
\end{aligned}
$$

as $\gamma_{n} \rightarrow 2$. Taking $t=t_{\gamma_{n}}$ such that $t_{\gamma_{n}}$ satisfies

$$
J_{2}\left(t_{\gamma_{n}} Q_{\gamma_{n}}\right)=\max _{t \geq 0} J_{2}\left(t Q_{\gamma_{n}}\right) .
$$

Elementary computation shows

$$
t_{\gamma_{n}}=\left(\frac{\left\|Q_{\gamma_{n}}\right\|_{H^{1}\left(\mathbb{R}^{N}\right)}^{2}}{D_{\gamma_{n}}\left(Q_{\gamma_{n}}, Q_{\gamma_{n}}\right)}\right)^{\frac{1}{2}} \rightarrow\left(\frac{\left\|Q_{\infty}\right\|_{H^{1}\left(\mathbb{R}^{N}\right)}^{2}}{D_{2}\left(Q_{\infty}, Q_{\infty}\right)}\right)^{\frac{1}{2}}=1 \text { as } \gamma_{n} \rightarrow 2
$$

as in the proof of Lemma 2.2. Then we get

$$
I_{\gamma_{n}} \geq J_{2}\left(t_{\gamma_{n}} Q_{\gamma_{n}}\right)+o(1) \geq I_{2}+o(1)
$$

where the last inequality comes from the mountain pass characterization of $I_{2}$. The proof is complete.

Proof of Theorem 1.1. Combining Lemma 2.2 and Lemma [2.3, we conclude

$$
\lim _{\gamma_{n} \rightarrow 2} I_{\gamma_{n}}=I_{2}
$$

Hence we get

$$
J_{2}\left(Q_{\infty}\right)=I_{2}
$$

In other words, $Q_{\infty}$ is a positive radial ground state to (1.3), i.e. $Q_{\infty} \in G$ (defined above).
On the other hand, from the identity (2.2), we know that

$$
I_{\gamma}=J_{\gamma}\left(Q_{\gamma}\right)=\frac{1}{4-\gamma} \int_{\mathbb{R}^{N}}\left|Q_{\gamma}(x)\right|^{2} d x \text { and } I_{2}=J_{2}\left(Q_{2}\right)=\frac{1}{2} \int_{\mathbb{R}^{N}}\left|Q_{2}(x)\right|^{2} d x
$$

Therefore, from above we can obtain that

$$
\int_{\mathbb{R}^{N}}\left|Q_{\gamma}(x)\right|^{2} d x \rightarrow \int_{\mathbb{R}^{N}}\left|Q_{\infty}(x)\right|^{2} d x=a^{*}
$$

Let $\left\{Q_{\gamma}\right\} \subset H_{r a d}^{1}\left(\mathbb{R}^{N}\right)$ be a family of positive radial ground state to (1.5) for $\gamma$ near 2 and $\gamma<2$. Suppose $\left\|Q_{\gamma}\right\|_{L^{2}\left(\mathbb{R}^{N}\right)}$ does not converge to the $\left\|Q_{2}\right\|_{L^{2}\left(\mathbb{R}^{N}\right)}$. Then there exist a positive number $\varepsilon_{0}$ and a sequence $\left\{\gamma_{k}\right\} \rightarrow 2$ such that $\left\|Q_{\gamma_{k}}\right\|_{L^{2}\left(\mathbb{R}^{N}\right)}-\left\|Q_{2}\right\|_{L^{2}\left(\mathbb{R}^{N}\right)} \geq \varepsilon_{0}$ which contradicts to Lemma 2.2 and Lemma 2.3, The proof of Theorem[1.1] is complete.

## 3 Energy estimate

In this section, the main purpose is to establish Lemma 3.2. One can obtain from [19] that there exist positive constants $\delta, C$ and $R_{0}$ independent of $\gamma \in(0,2]$, such that $|x|>R_{0}$

\begin{equation*}
\left|Q_{\gamma}\right|+\left|\nabla Q_{\gamma}\right| \leq C e^{-\delta|x|} \text { for } \gamma \in(0,2] . \tag{3.1}
\end{equation*}
$$

We next denote $\tilde{E}_{\gamma}(u)$ the following energy functional without the potential:

$$
\begin{equation*}
\tilde{E}_{\gamma}(u):=\int_{\mathbb{R}^{N}}|\nabla u(x)|^{2} d x-\frac{a}{2} D_{\gamma}(u, u) u \in H^{1}\left(\mathbb{R}^{N}\right), \tag{3.2}
\end{equation*}
$$

and consider the associated minimization problem

$$
\tilde{e}_{a}(\gamma)=\inf _{\left\{u \in H^{1}\left(\mathbb{R}^{N}\right):\|u\|_{2}^{2}=1\right\}} \tilde{E}_{\gamma}(u)
$$

Then the following Lemma gives refined information on the minimum energy $\tilde{e}_{a}(\gamma)$ as well as it minimizers.

Lemma 3.1. Let $\gamma \in(0,2)$ and $Q_{\gamma}$ be the radially symmetry positive solution of (1.5), then

$$
\begin{equation*}
\tilde{e}_{a}(\gamma)=\left(1-\frac{2}{\gamma}\right)\left(\frac{4-\gamma}{\gamma}\right)\left(\frac{a}{\left\|Q_{\gamma}\right\|_{2}^{2}}\right)^{\frac{2}{2-\gamma}} \tag{3.3}
\end{equation*}
$$

and the positive minimizers of $\tilde{e}_{a}(\gamma)$ must be of the form

$$
\begin{equation*}
\tilde{Q}_{\gamma}(x)=\frac{\tau_{\gamma}^{N / 2}}{\left\|Q_{\gamma}\right\|_{2}} Q_{\gamma}\left(\tau_{\gamma} x\right), \text { where } \tau_{\gamma}=\sqrt{\frac{\gamma}{4-\gamma}}\left(\frac{a}{\left\|Q_{\gamma}\right\|_{2}^{2}}\right)^{\frac{1}{2-\gamma}} . \tag{3.4}
\end{equation*}
$$

Proof. By using the Gagliardo-Nirenberg inequality (1.7), it follows from (3.2) that

$$
\tilde{E}_{\gamma}(u) \geq \int_{\mathbb{R}^{N}}|\nabla u|^{2} d x-\frac{2 a}{4-\gamma}\left(\frac{4-\gamma}{\gamma}\right)^{\frac{\gamma}{2}} \frac{1}{\left\|Q_{\gamma}\right\|_{2}^{2}}\left(\int_{\mathbb{R}^{N}}|\nabla u|^{2} d x\right)^{\frac{\gamma}{2}},
$$

for any $u \in H^{1}\left(\mathbb{R}^{N}\right)$ and $\int_{\mathbb{R}^{N}} u^{2}=1$.
Let

$$
\begin{equation*}
g(s)=s-\frac{2 a}{4-\gamma}\left(\frac{4-\gamma}{\gamma}\right)^{\frac{\gamma}{2}} \frac{1}{\left\|Q_{\gamma}\right\|_{2}^{2}} s^{\frac{\gamma}{2}} \text { for any } s \in[0, \infty) . \tag{3.5}
\end{equation*}
$$

We known that $g(s)$ attains its minimum at $s=\left(\frac{\gamma}{4-\gamma}\right)\left(\frac{a}{\left\|Q_{\gamma}\right\|_{2}^{2}}\right)^{\frac{2}{2-\gamma}}$, i.e. $s=\tau_{\gamma}^{2}$, which then implies that

$$
\tilde{E}_{\gamma}(u) \geq g\left(\tau_{\gamma}^{2}\right)=\left(1-\frac{2}{\gamma}\right)\left(\frac{\gamma}{4-\gamma}\right)\left(\frac{a}{\left\|Q_{\gamma}\right\|_{2}^{2}}\right)^{\frac{2}{2-\gamma}}
$$

This yields that

$$
\begin{equation*}
\tilde{e}_{a}(\gamma) \geq g\left(\tau_{\gamma}^{2}\right)=\left(1-\frac{2}{\gamma}\right)\left(\frac{\gamma}{4-\gamma}\right)\left(\frac{a}{\left\|Q_{\gamma}\right\|_{2}^{2}}\right)^{\frac{2}{2-\gamma}} \tag{3.6}
\end{equation*}
$$

On the other hand, we introduce the following trial function

$$
\psi_{\gamma}^{t}(x)=\frac{t^{\frac{N}{2}}}{\left\|Q_{\gamma}\right\|_{2}} Q_{\gamma}(t x)
$$

and $\int_{\mathbb{R}^{N}}\left|\psi_{\gamma}^{t}\right|^{2} d x \equiv 1$ for all $t \in(0, \infty)$. We then obtain from (2.2) that

$$
\tilde{e}_{a}(\gamma) \leq \tilde{E}_{\gamma}\left(\psi_{\gamma}^{t}\right)=\frac{\gamma}{4-\gamma} t^{2}-\frac{a}{2}\left(\frac{4}{4-\gamma}\right) \frac{t^{\gamma}}{\left\|Q_{\gamma}\right\|_{2}^{2}}, \text { for any } t \in(0, \infty)
$$

Set

$$
h(t)=\frac{\gamma}{4-\gamma} t^{2}-\frac{a}{2}\left(\frac{4}{4-\gamma}\right) \frac{t^{\gamma}}{\left\|Q_{\gamma}\right\|_{2}^{2}} .
$$

We then obtain its minimum

$$
h_{\min }(t)=\left(1-\frac{2}{\gamma}\right)\left(\frac{\gamma}{4-\gamma}\right)\left(\frac{a}{\left\|Q_{\gamma}\right\|_{2}^{2}}\right)^{\frac{2}{2-\gamma}} .
$$

This and (3.6) then imply the estimate (3.3). Moreover, $\tilde{e}_{a}(\gamma)$ is attained at $\tilde{Q}_{\gamma}(x)=$ $\frac{\tau_{\gamma}^{N / 2}}{\left\|Q_{\gamma}\right\|_{2}} Q_{\gamma}\left(\tau_{\gamma} x\right)$, and the proof is complete.
Remark 3. For any fixed $a>a^{*}$, from the Theorem 1.1 we know that there exists a constant $\sigma>1$, independent of $\gamma$, such that $\frac{a}{\left\|Q_{\gamma}\right\|_{2}^{2}}>\sigma>1$ as $\gamma$ is sufficiently close to $2^{-}$. Therefore, we further have

$$
\begin{equation*}
\tau_{\gamma}=\sqrt{\frac{\gamma}{4-\gamma}}\left(\frac{a}{\left\|Q_{\gamma}\right\|_{2}^{2}}\right)^{\frac{1}{2-\gamma}} \rightarrow+\infty \text { and } \tilde{e}_{a}(\gamma) \rightarrow-\infty \text { as } \gamma \nearrow 2 \tag{3.7}
\end{equation*}
$$

By applying Lemma 3.1, we are able to establish the following estimates.
Lemma 3.2. Let $a>a^{*}$ be fixed, and suppose that

$$
V(x) \in L_{l o c}^{\infty}\left(\mathbb{R}^{N}\right), \quad \lim _{|x| \rightarrow \infty} V(x)=\infty \text { and } \inf _{x \in \mathbb{R}^{N}} V(x)=0
$$

Then

$$
\begin{equation*}
e_{a}(\gamma)-\tilde{e}_{a}(\gamma) \rightarrow 0, \text { as } \gamma \nearrow 2 \tag{3.8}
\end{equation*}
$$

Furthermore, we have

$$
\begin{equation*}
\int_{\mathbb{R}^{N}} V(x)\left|u_{\gamma}(x)\right|^{2} d x \rightarrow 0 \text { as } \gamma \nearrow 2 \tag{3.9}
\end{equation*}
$$

and there exist two positive constants $C_{1}$ and $C_{2}$ independent of $\gamma$, such that

$$
\begin{gather*}
C_{1}\left(\frac{a}{\left\|Q_{\gamma}\right\|_{2}^{2}}\right)^{\frac{2}{2-\gamma}} \leq \int_{\mathbb{R}^{N}}\left|\nabla u_{\gamma}(x)\right|^{2} d x \leq C_{2}\left(\frac{a}{\left\|Q_{\gamma}\right\|_{2}^{2}}\right)^{\frac{2}{2-\gamma}} \text { as } \gamma \nearrow 2,  \tag{3.10}\\
C_{1}\left(\frac{a}{\left\|Q_{\gamma}\right\|_{2}^{2}}\right)^{\frac{2}{2-\gamma}} \leq D_{\gamma}\left(u_{\gamma}, u_{\gamma}\right) \leq C_{2}\left(\frac{a}{\left\|Q_{\gamma}\right\|_{2}^{2}}\right)^{\frac{2}{2-\gamma}} \text { as } \gamma \nearrow 2,
\end{gather*}
$$

where $u_{\gamma}(x)$ is a positive minimizer of (1.6).

Proof. We choose a suitable trial function to estimate the upper bound of $e_{a}(\gamma)-\tilde{e}_{a}(\gamma)$. For $R \geq 0$ fixed, let $\varphi_{R}(x) \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ be a cut-off function such that $\varphi_{R}(x) \equiv 1$ if $x \in B_{R}(0)$, $\varphi_{R}(x) \equiv 0$ if $x \in B_{2 R}^{c}(0)$, and $0 \leq \varphi_{R}(x) \leq 1, \nabla \varphi(x) \leq \frac{C_{0}}{R}$ for any $x \in B_{2 R}(0) \backslash B_{R}(0)$. Set

$$
\begin{equation*}
\omega_{R, \gamma}(x)=A_{R, \gamma} \tilde{\omega}_{R, \gamma}(x)=A_{R, \gamma} \varphi_{R}\left(x-x_{0}\right) \tilde{Q}_{\gamma}\left(x-x_{0}\right) \text { with } x_{0} \in \mathbb{R}^{N} \tag{3.11}
\end{equation*}
$$

where $\tilde{Q}_{\gamma}(x)$ defined in (3.4) is the positive minimizer of $\tilde{e}_{a}(\gamma)$, and $A_{R, \gamma}>0$ is chosen so that $\left\|\omega_{R, \gamma}\right\|_{2}^{2}=1$. Now, we can calculate that

$$
\begin{aligned}
0 \leq & e_{a}(\gamma)-\tilde{e}_{a}(\gamma) \leq E_{\gamma}\left(\omega_{R, \gamma}(x)\right)-\tilde{e}_{a}(\gamma) \\
= & E_{\gamma}\left(A_{R, \gamma} \tilde{\omega}_{R, \gamma}(x)\right)-\tilde{E}_{\gamma}\left(\tilde{\omega}_{R, \gamma}(x)\right)+\tilde{E}_{\gamma}\left(\tilde{\omega}_{R, \gamma}(x)\right)-\tilde{E}_{\gamma}\left(\tilde{Q}_{\gamma}(x)\right) \\
\leq & \left(A_{R, \gamma}^{2}-1\right) \int_{\mathbb{R}^{N}}\left|\nabla \tilde{\omega}_{R, \gamma}(x)\right|^{2} d x+\frac{a}{2}\left(A_{R, \gamma}^{4}-1\right) D_{\gamma}\left(\tilde{\omega}_{R, \gamma}, \tilde{\omega}_{R, \gamma}\right) \\
& +\int_{\mathbb{R}^{N}} V(x)\left|\omega_{R, \gamma}(x)\right|^{2} d x+\left.\left|\int_{\mathbb{R}^{N}}\right| \nabla \tilde{Q}_{\gamma}(x)\right|^{2} d x-\int_{\mathbb{R}^{N}}\left|\nabla \tilde{\omega}_{R, \gamma}(x)\right|^{2} d x \mid \\
& +\frac{a}{2}\left|D_{\gamma}\left(\tilde{Q}_{\gamma}, \tilde{Q}_{\gamma}\right)-D_{\gamma}\left(\tilde{\omega}_{R, \gamma}, \tilde{\omega}_{R, \gamma}\right)\right| \\
= & A_{1}+A_{2}+A_{3}+A_{4}+A_{5} .
\end{aligned}
$$

By using (3.1) and $\tau_{\gamma} \rightarrow \infty$ as $\gamma \nearrow 2$, we then have

$$
0 \leq A_{R, \gamma}^{2}-1 \leq \frac{\int_{B_{R_{\tau}}^{c}}\left|Q_{\gamma}(x)\right|^{2} d x}{\int_{B_{R_{\tau \gamma}}}\left|Q_{\gamma}(x)\right|^{2} d x} \leq C R_{\tau_{\gamma}} e^{-2 \delta R_{\tau_{\gamma}}} \leq C e^{-\delta R_{\tau_{\gamma}}} \text { as } \gamma \nearrow 2,
$$

where $\delta>0$ is as in (3.1). It hence follows from the above that

$$
1 \leq A_{R, \gamma}^{4} \leq\left(1+C e^{-\delta R_{\tau_{\gamma}}}\right)^{2} \leq 1+4 C e^{-\delta R_{\tau_{\gamma}}}
$$

Direct calculations show that

$$
\begin{aligned}
A_{4} & \leq\left.\left|\int_{\mathbb{R}^{N}}\right| \nabla \tilde{Q}_{\gamma}(x)\right|^{2} d x-\int_{\mathbb{R}^{N}}\left(\left|\nabla \varphi_{R}\right|^{2}\left|\tilde{Q}_{\gamma}\right|^{2}+\left|\varphi_{R}\right|^{2}\left|\nabla \tilde{Q}_{\gamma}\right|^{2}+2 \nabla \varphi_{R} \varphi_{R} \nabla \tilde{Q}_{\gamma} \tilde{Q}_{\gamma}\right) d x \mid \\
& \leq \int_{B_{R}^{c}}\left|\nabla \tilde{Q}_{\gamma}(x)\right|^{2} d x+\frac{C}{R^{2}} \int_{B_{R}^{c}}\left|\tilde{Q}_{\gamma}\right|^{2} d x+\frac{2 C}{R} \int_{B_{R}^{c}}\left|\nabla \tilde{Q}_{\gamma}\right|\left|\tilde{Q}_{\gamma}\right| d x \leq C e^{-\delta R_{\tau \gamma}},
\end{aligned}
$$

where we use (3.1). One can also calculate that

$$
A_{5} \leq C e^{-\delta R_{\tau_{\gamma}}}
$$

Moreover, we have

$$
\lim _{\gamma \nearrow^{2}} \int_{\mathbb{R}^{N}} V(x)\left|\omega_{R, \gamma}\right|^{2} d x=\lim _{\gamma \nearrow 2} \frac{A_{R, \gamma}^{2}}{\left\|Q_{\gamma}\right\|_{2}^{2}} \int V\left(\frac{x}{\tau_{\gamma}}+x_{0}\right) \varphi_{R}^{2}\left(\frac{x}{\tau_{\gamma}}\right) Q_{\gamma}^{2}(x) d x=V\left(x_{0}\right)
$$

holds for almost every $x_{0} \in \mathbb{R}^{N}$. Therefore, we choose $x_{0} \in \mathbb{R}^{N}$ such that $V\left(x_{0}\right)=0$, it follows from the above estimate that

$$
\begin{equation*}
0 \leq e_{a}(\gamma)-\tilde{e}_{a}(\gamma) \leq C e^{-\delta R_{\tau_{\gamma}}}+\int_{\mathbb{R}^{N}} V(x)\left|\omega_{R, \gamma}\right|^{2} d x \rightarrow 0 \text { as } \gamma \nearrow 2 \tag{3.12}
\end{equation*}
$$

which then implies (3.8). Therefore, from (3.8), we can obtain (3.9). Nowadays the proof of (3.10) is standard, and therefore we omit it.

## 4 Concentration and symmetry breaking

This section is devoted to proving Theorem 1.2 and Theorem 1.3 on the concentration and symmetry breaking of minimizers for (1.6) as $\gamma \nearrow 2$, where $a>\left\|Q_{2}\right\|_{2}^{2}$ is fixed. Set

$$
\begin{equation*}
\varepsilon_{\gamma}:=\varepsilon(\gamma)=\left(\frac{a}{\left\|Q_{\gamma}\right\|_{2}^{2}}\right)^{-\frac{1}{2-\gamma}}>0 \tag{4.1}
\end{equation*}
$$

then $\varepsilon_{\gamma} \rightarrow 0$ by Remark 3, Define the $L^{2}\left(\mathbb{R}^{N}\right)$-normalized function

$$
\begin{equation*}
\tilde{v}_{\gamma}(x):=\varepsilon_{\gamma}^{\frac{N}{2}} u_{\gamma}\left(\varepsilon_{\gamma} x\right) . \tag{4.2}
\end{equation*}
$$

It then follows from Lemma 3.2 that there exist two positive constants $C_{1}$ and $C_{2}$, independent of $\gamma$, such that

$$
\begin{equation*}
C_{1} \leq \int_{\mathbb{R}^{N}}\left|\nabla \tilde{v}_{\gamma}(x)\right|^{2} \leq C_{2} \quad \text { and } \quad C_{1} \leq D_{\gamma}\left(\tilde{v}_{\gamma}, \tilde{v}_{\gamma}\right) \leq C_{2} \tag{4.3}
\end{equation*}
$$

By the above inequality (4.3), we easily obtain that there exist a sequence $\left\{y_{\varepsilon_{\gamma}}\right\}, R_{0}>0$ and $\eta>0$ such that

$$
\liminf _{\varepsilon_{\gamma} \rightarrow 0} \int_{B_{R_{0}}\left(y_{\varepsilon_{\gamma}}\right)}\left|\tilde{v}_{\gamma}(x)\right|^{2} d x \geq \eta>0
$$

where $\tilde{v}_{\gamma}(x)$ is defined as (4.2). For the sequence $\left\{y_{\varepsilon_{\gamma}}\right\}$ given by above, set

$$
\begin{equation*}
v_{\gamma}(x)=\tilde{v}_{\gamma}\left(x+y_{\varepsilon_{\gamma}}\right)=\varepsilon_{\gamma}^{\frac{N}{2}} u_{\gamma}\left(\varepsilon_{\gamma}\left(x+y_{\varepsilon_{\gamma}}\right)\right) . \tag{4.4}
\end{equation*}
$$

Then

$$
\begin{equation*}
\liminf _{\varepsilon_{\gamma} \rightarrow 0} \int_{B_{R_{0}}(0)}\left|v_{\gamma}(x)\right|^{2} d x \geq \eta>0 \tag{4.5}
\end{equation*}
$$

which therefore implies that $v_{\gamma}(x)$ cannot vanish as $\gamma \nearrow 2$. We shall need the following technical result, proof of which can be found in [7].
Lemma 4.1. Assume $V(x) \in C^{1}\left(\mathbb{R}^{N}\right)$ satisfies $\lim _{|x| \rightarrow \infty} V(x)=\infty$ and $\inf _{x \in \mathbb{R}^{N}} V(x)=0$. Then $\left\{\varepsilon_{\gamma} y_{\varepsilon_{\gamma}}\right\}$ is bounded uniformly for $\gamma \nearrow 2$. Moreover, for any sequence $\left\{\gamma_{k}\right\}$ with $\gamma_{k} \rightarrow 2$ as $k \rightarrow \infty$, there exists a subsequence, still denoted by $\left\{\gamma_{k}\right\}$, such that $z_{k}:=\varepsilon_{k} y_{\varepsilon_{k}} \rightarrow^{k} y_{0}$, where $\varepsilon_{k}:=\varepsilon_{\gamma_{k}}$ is given by (4.1), and $y_{0} \in \mathbb{R}^{N}$ is a global minimum point of $V(x)$, i.e., $V\left(y_{0}\right)=0$.

Since $u_{\gamma}$ is a minimizer of (1.6), it satisfies the Euler-Lagrange equation

$$
\begin{equation*}
-\Delta u_{\gamma}(x)+V(x) u_{\gamma}(x)=\mu_{\gamma} u_{\gamma}(x)+a\left(\frac{1}{|x|^{\gamma}} *\left|u_{\gamma}\right|^{2}\right) u_{\gamma}(x) \text { in } \mathbb{R}^{N}, \tag{4.6}
\end{equation*}
$$

where $\mu_{\gamma} \in \mathbb{R}$ is a Lagrange multiplier and satisfies

$$
\mu_{\gamma}=e_{a}(\gamma)-\frac{a}{2} D_{\gamma}\left(u_{\gamma}, u_{\gamma}\right) .
$$

It then follows from Lemma 3.2 and (4.3) that there exist two positive constants $C_{1}$ and $C_{2}$, independent of $\gamma$, such that

$$
-C_{2}<\mu_{\gamma} \varepsilon_{\gamma}^{2}<-C_{1} \text { as } \gamma \nearrow 2
$$

By (4.1) and (4.6), $v_{\gamma}(x)$ satisfies

$$
\begin{equation*}
-\Delta v_{\gamma}(x)+\varepsilon_{\gamma}^{2} V\left(\varepsilon_{\gamma}\left(x+y_{\varepsilon_{\gamma}}\right)\right) v_{\gamma}(x)=\varepsilon_{\gamma}^{2} \mu_{\gamma} v_{\gamma}(x)+\left\|Q_{\gamma}\right\|_{2}^{2}\left(\frac{1}{|x|^{\gamma}} *\left|v_{\gamma}\right|^{2}\right) v_{\gamma}(x) \text { in } \mathbb{R}^{N} \tag{4.7}
\end{equation*}
$$

Therefore, by passing to a subsequence if necessary, we can assume that, for some number $\beta>0$,

$$
\mu_{\gamma_{k}} \varepsilon_{k}^{2} \rightarrow-\beta^{2}<0 \text { and } v_{k}:=v_{\gamma_{k}} \rightharpoonup v_{0} \geq 0 \text { in } H^{1}\left(\mathbb{R}^{N}\right) \text { as } \gamma_{k} \nearrow 2,
$$

for some $v_{0} \in H^{1}\left(\mathbb{R}^{N}\right)$. By passing to the weak limit of (4.7), we deduce from Lemma 3.2 and Theorem 1.1 that the non-negative function $v_{0}$ satisfies

Furthermore, we infer from (4.5) that $v_{0} \not \equiv 0$ in $\mathbb{R}^{N}$, and the strong maximum principle then yields that $v_{0}>0$ in $\mathbb{R}^{N}$. By the simple rescaling, we thus conclude from the positive ground state of (1.3) that

where $Q_{0}$ is the positive radially symmetric solution of equation (1.3). Since $J_{2}\left(Q_{0}\right) \geq$ $J_{2}\left(Q_{2}\right)=I_{2}$, where $I_{2}$ is the ground state energy, and $\left.J_{2}\left(Q_{0}\right)=\frac{1}{2} \right\rvert\,\left\|Q_{0}\right\|_{2}^{2}$, then we have $\left\|Q_{0}\right\|_{2}^{2} \geq a^{*}$. Therefore $\int_{\mathbb{R}^{N}}\left|v_{0}(x)\right|^{2} d x \geq 1$. On the other hand, it follows from the Fatou's lemma that $\int_{\mathbb{R}^{N}}\left|v_{0}(x)\right|^{2} d x \leq 1$. Then $\int_{\mathbb{R}^{N}}\left|v_{0}(x)\right|^{2} d x=1$, which implies that $\left\|Q_{0}\right\|_{2}=$ $\left\|Q_{2}\right\|_{2}=a^{*}$. Thus, $Q_{0}$ is a positive radially symmetric ground state of equation (1.3). Note that $\left\|v_{k}\right\|_{2}^{2}=1$, then $v_{k}$ converges to $v_{0}$ strongly in $L^{2}\left(\mathbb{R}^{N}\right)$ and in fact, strongly in $L^{p}\left(\mathbb{R}^{N}\right)$ for any $2 \leq p<\frac{2 N}{N-2}$ because of $H^{1}\left(\mathbb{R}^{N}\right)$ boundedness. Furthermore, since $v_{k}$ and $v_{0}$ satisfy (4.7) and (4.8) respectively, standard elliptic regularity theory gives that $v_{k}$ converges to $v_{0}$ strongly in $H^{1}\left(\mathbb{R}^{N}\right)$.

Proof of Theorem 1.2. Motivated by [7, 8], we are now ready to complete the proof of Theorem 1.1 by the following three steps.

Step1: The decay property of $u_{k}:=u_{\gamma_{k}}$. For any sequence $\left\{\gamma_{k}\right\}$. Let $v_{k}:=v_{\gamma_{k}} \geq 0$ be defined by (4.4). The above analysis shows that there exists a subsequence, still dented by $\left\{v_{k}\right\}$, satisfying (4.7) and $v_{k} \rightarrow v_{0}$ strongly in $H^{1}\left(\mathbb{R}^{N}\right)$ for some positive function $v_{0}$. Hence for any $2<\alpha<\frac{2 N}{N-2}$,

where $1+\frac{1}{q}=\frac{1}{p}+\frac{\gamma}{N}$. In particular, if $q=\frac{N}{\gamma}>\frac{N}{2}$, then $p=1$. Since $v_{k} \in H^{1}\left(\mathbb{R}^{N}\right)$, by the Sobolev embedding theorem, we get

Step2 : The detailed concentration behavior. Let $\bar{z}_{k}$ be any local maximum point of $u_{k}$. By the definition of $\phi_{u_{k}}\left(\bar{z}_{k}\right)$, we have

$$

Since $0<\gamma<2$, then it follows from the Hölder inequality that

\int_{\left|\bar{z}_{k}-y\right|<\delta} \frac{\left|u_{k}(y)\right|^{2-\frac{1}{N}}}{\left|\bar{z}_{k}-y\right|^{\gamma}} d y & \leq\left(\int_{\left|\bar{z}_{k}-y\right|<\delta}\left|\bar{z}_{k}-y\right|^{-\frac{\gamma N}{2}} d y\right)^{\frac{2}{N}}\left(\int_{\left|\bar{z}_{k}-y\right|<\delta}\left|u_{k}(y)\right|^{2+\frac{3}{N-2}}\right)^{\frac{N-2}{N}} \\
& \leq C<\infty,
\end{aligned}
$$

where $C>0$ is independent of $k$, since $u_{k}$ is uniformly bounded in $H^{1}\left(\mathbb{R}^{N}\right)$.
On the other hand, combining Hölder inequality and Sobolev inequality yields that

& \leq C<\infty,
\end{aligned}
$$

where $C>0$ is independent of $k$. According to the above two estimates, we deduce that

This estimate and the above decay property thus imply that $\bar{z}_{k} \rightarrow y_{0}$ as $k \rightarrow \infty$. Set

-\Delta \tilde{v}_{k}(x)+\varepsilon_{k}^{2} V\left(\varepsilon_{k} x+\bar{z}_{k}\right) \tilde{v}_{k}(x)=\varepsilon_{\gamma_{k}}^{2} \mu_{\gamma_{k}} \tilde{v}_{k}(x)+\left\|Q_{\gamma}\right\|_{2}^{2}\left(\frac{1}{|x|^{\gamma}} *\left|\tilde{v}_{k}\right|^{2}\right) \tilde{v}_{k}(x) \text { in } \mathbb{R}^{N} \tag{4.14}
\end{equation*}
$$

The same argument as proving (4.8) yields that there exists a subsequence of $\left\{\tilde{v}_{k}\right\}$, still denoted by $\left\{\tilde{v}_{k}\right\}$, such that $\tilde{v}_{k} \rightarrow \tilde{v}_{0}$ as $k \rightarrow \infty$ in $H^{1}\left(\mathbb{R}^{N}\right)$ for some nonnegative function $\tilde{v}_{0} \geq 0$, where $\tilde{v}_{0}$ satisfies (4.8) for some constant $\beta>0$. We derive from (4.14) that

which implies that $\tilde{v}_{0}(0)>0$. Thus, the strong maximum principle yields that $\tilde{v}_{0}(x)>0$ in $\mathbb{R}^{N}$. Since $x=0$ is a critical point of $\tilde{v}_{k}$ for all $k>0$, it is also a critical point of $\tilde{v}_{0}$. We therefore conclude from the positive radial solutions of equation (1.3) that $\tilde{v}_{0}$ is spherically symmetric about the origin, and

Step3: The exact value of $\beta$ defined in (4.15). Let $\left\{\gamma_{k}\right\}$, where $\gamma_{k} \nearrow 2$ as $k \rightarrow \infty$, be the subsequence obtained in Step 2, and denoted $u_{k}:=u_{\gamma_{k}}$. Recall from Lemma 3.2 that

\end{equation*}

On the other hand,

e_{a}\left(\gamma_{k}\right) & =\int_{\mathbb{R}^{N}}\left(\left|\nabla u_{\gamma_{k}}\right|^{2}+V(x)\left|u_{\gamma_{k}}\right|^{2}\right) d x-\frac{a}{2} D_{\gamma_{k}}\left(u_{\gamma_{k}}, u_{\gamma_{k}}\right) \\
& =\varepsilon_{k}^{-2}\left(\int_{\mathbb{R}^{N}}\left|\nabla \tilde{v}_{k}\right|^{2} d x-\frac{\left\|Q_{\gamma_{k}}\right\|_{2}^{2}}{2} D_{\gamma_{k}}\left(\tilde{v}_{k}, \tilde{v}_{k}\right)\right)+\int_{\mathbb{R}^{N}} V(x)\left|u_{\gamma_{k}}\right|^{2} d x \\
& \geq \varepsilon_{k}^{-2}\left(\int_{\mathbb{R}^{N}}\left|\nabla \tilde{v}_{k}\right|^{2} d x-\frac{2}{4-\gamma_{k}}\left(\frac{4-\gamma_{k}}{\gamma_{k}}\right)^{\frac{\gamma_{k}}{2}}\left(\int_{\mathbb{R}^{N}}\left|\nabla \tilde{v}_{k}\right|^{2} d x\right)^{\frac{\gamma_{k}}{2}}\right) \tag{4.17}
\end{align*}
$$

where $\tilde{v}_{k}:=\tilde{v}_{\gamma_{k}}$ is as in (4.13). Set $\beta_{\gamma_{k}}^{2}:=\int_{\mathbb{R}^{N}}\left|\nabla \tilde{v}_{k}\right|^{2} d x$. Since $\tilde{v}_{k}(x) \rightarrow \tilde{v}_{0}(x)$ strongly in $H^{1}\left(\mathbb{R}^{N}\right)$, we have

A simple analysis shows that $f_{k}(\cdot)$ attains its global minimum at the unique point $t_{k}=\frac{\gamma_{k}}{4-\gamma_{k}}$ and also $f_{k}\left(t_{k}\right)=$ $\frac{\gamma_{k}-2}{4-\gamma_{k}}$. We hence deduce from (4.17) that

Following the proof of Theorem 1.2, we next address Theorem 1.3 on the local properties of concentration points. Under the assumption (1.9), we first denoted

& \leq \frac{A_{R, \gamma_{k}}^{2}}{\tau_{\gamma_{k}}^{p}\left\|Q_{\gamma_{k}}\right\|_{2}^{2}} \int_{B_{2 R_{\tau_{\gamma_{k}}}}} \bar{V}_{i_{0}}\left(\frac{x}{\tau_{\gamma_{k}}+x_{i_{0}}}\right)|x|^{p} Q_{\gamma_{k}}^{2}(x) d x+C e^{-\delta R_{\tau_{\gamma_{k}}}} \\
& \leq \frac{A_{R, \gamma_{k}}^{2}}{\tau_{\gamma_{k}}^{p}\left\|Q_{\gamma_{k}}\right\|_{2}^{2}} \int_{\mathbb{R}^{N}} \mathcal{X}_{B_{2 R_{\tau_{\gamma_{k}}}}} \bar{V}_{i_{0}}\left(\frac{x}{\tau_{\gamma_{k}}+x_{i_{0}}}\right)|x|^{p} Q_{\gamma_{k}}^{2}(x) d x+C e^{-\delta R_{\tau_{\gamma_{k}}} .} \tag{4.19}
\end{align*}

where $\tau_{\gamma_{k}}>0$ satisfies $\tau_{\gamma_{k}}=\sqrt{\frac{\gamma}{4-\gamma}} \frac{1}{\varepsilon_{k}}$ in view of Lemma 3.1 and (4.1), and $\mathcal{X}_{R_{2 R_{\tau_{\gamma_{k}}}}}$ is the characteristic function of the set $B_{2 R_{\tau \gamma_{k}}}$. Combining Theorem 1.1 and (3.1), we deduce that

\end{equation*}
$$

On the other hand, following the proof of Theorem 1.2 we denote $\bar{z}_{k}$ to be the unique global maximum point of $u_{k}$, and let $\tilde{v}_{k}$ be defined as in (4.13). Denote also $y_{0} \in \mathbb{R}^{N}$ to be the limit of $\bar{z}_{k}$ as $k \rightarrow \infty$. Since $V\left(y_{0}\right)=0$, then there exists an $x_{j}=y_{0}$ for some $1 \leq j \leq n$. We claim that $\left\{\frac{\bar{z}_{k}-x_{j}}{\varepsilon_{k}}\right\}$ is bounded in $\mathbb{R}^{N}$. Indeed, if there exists a subsequence, still denoted by $\left\{\gamma_{k}\right\}$, such that $\left|\frac{\bar{z}_{k}-x_{j}}{\varepsilon_{k}}\right| \rightarrow \infty$ as $k \rightarrow \infty$, it then follows from Fatou's Lemma that, for any $C>0$ sufficiently large,

$$
\begin{aligned}
\lim _{k \rightarrow \infty} \frac{e_{a}\left(\gamma_{k}\right)-\tilde{e}_{a}\left(\gamma_{k}\right)}{\varepsilon_{k}^{p_{i}}} & \geq \lim _{k \rightarrow \infty} \int_{\mathbb{R}^{N}} \bar{V}_{j}\left(\varepsilon_{k}+\bar{z}_{k}\right)\left|x+\frac{\bar{z}_{k}-x_{j}}{\varepsilon_{k}}\right|^{p_{j}} \tilde{v}_{k}^{2} d x \\
& \geq \int_{\mathbb{R}^{N}} \lim _{k \rightarrow \infty} \bar{V}_{j}\left(\varepsilon_{k}+\bar{z}_{k}\right)\left|x+\frac{\bar{z}_{k}-x_{j}}{\varepsilon_{k}}\right|^{p_{j}} \tilde{v}_{k}^{2} d x \geq C \bar{V}_{j}\left(x_{j}\right)
\end{aligned}
$$

which however contradicts (4.20) owing to $p_{j} \leq p=\max \left\{p_{1}, p_{2}, \ldots, p_{n}\right\}$, and the claim is therefore true. Consequently, there exists a subsequence, still denoted by $\left\{\gamma_{k}\right\}$, such that

$$
\frac{\bar{z}_{k}-x_{j}}{\varepsilon_{k}} \rightarrow \bar{z}_{0} \text { for some } \bar{z}_{0} \in \mathbb{R}^{N}
$$

Since $Q_{2}$ is a radial decreasing function and decays exponentially as $|x| \rightarrow \infty$, we then deduce that

$$
\begin{align*}
\lim _{k \rightarrow \infty} \frac{e_{a}\left(\gamma_{k}\right)-\tilde{e}_{a}\left(\gamma_{k}\right)}{\varepsilon_{k}^{p_{i}}} & \geq \lim _{k \rightarrow \infty} \int_{\mathbb{R}^{N}} \bar{V}_{j}\left(\varepsilon_{k}+\bar{z}_{k}\right)\left|x+\frac{\bar{z}_{k}-x_{j}}{\varepsilon_{k}}\right|^{p_{j}} \tilde{v}_{k}^{2} d x \\
& \geq \bar{V}_{j}\left(x_{j}\right) \int_{\mathbb{R}^{N}}\left|x+\bar{z}_{0}\right|^{p_{j}} \tilde{v}_{0}^{2} d x \\
& \geq \frac{\bar{V}_{j}\left(x_{j}\right)}{\left\|Q_{2}\right\|_{2}^{2}} \int_{\mathbb{R}^{N}}|x|^{p_{j}} Q_{2}^{2} d x \tag{4.21}
\end{align*}
$$

where $\tilde{v}_{0}>0$ is as in (4.15), and " $="$ in the last inequality of (4.21) holds if and only if $\bar{z}_{0}=0$.

Applying (4.20) and (4.21), it is not difficult to see that $p_{j}=p$ and then $V_{j}\left(x_{j}\right)=V_{i_{0}}\left(x_{i_{0}}\right)$. Hence, $x_{j}=y_{0} \in \mathcal{Z}$ must be the flattest global minimum point of $V(x)$. Based on these facts, using (4.20) and (4.21) we see that (4.21) is essentially an equality. Therefore, $\bar{z}_{0}=0$ and (1.12) holds. The proof of Theorem 1.3 is completed.
