# SDES WITH RANDOM AND IRREGULAR COEFFICIENTS 

Guohuan Zhao


#### Abstract

We consider Itô uniformly nondegenerate equations with random coefficients. When the coefficients satisfy some low regularity assumptions with respect to the spatial variables and Malliavin differentiability assumptions on the sample points, the unique solvability of singular SDEs is proved by solving backward stochastic Kolmogorov equations and utilizing a modified Zvonkin type transformation.


## 1. Introduction

The main purpose of this work is to study the well-posedness of stochastic differential equations (SDEs) with random and irregular coefficients. More precisely, we are concerned with the following SDE in $\mathbb{R}^{n}$ :

X_{t}(\omega)=X_{0}(\omega)+\int_{0}^{t} \sigma_{s}\left(X_{s}, \omega\right) \mathrm{d} W_{s}(\omega)+\int_{0}^{t} b_{s}\left(X_{s}, \omega\right) \mathrm{d} s \tag{1.1}
\end{equation*}
$$

Here $\left\{W_{t}\right\}_{t \in[0,1]}$ is a $d$-dimensional Brownian motion defined on a complete filtered probability space $\left(\Omega, \mathscr{F}, \mathscr{F}_{t}, \mathbf{P}\right), \mathscr{F}$ and $\mathscr{F}_{t}$ are generalized by $\left\{W_{s}\right\}_{s \in[0,1]}$ and $\left\{W_{s}\right\}_{s \in[0, t]}$, respectively. $\mathscr{B}$ is the Borel algebra on $\mathbb{R}^{n}$ and $\mathscr{P}$ is the collection of all the progressively measurable sets on $[0,1] \times \Omega$. The coefficients $\sigma: \mathbb{R}^{n} \times[0,1] \times \Omega \rightarrow \mathbb{R}^{n} \otimes \mathbb{R}^{d}$ and $b: \mathbb{R}^{n} \times[0,1] \times \Omega \rightarrow \mathbb{R}^{n}$ are $\mathscr{B} \times \mathscr{P}$-measurable .

In the past half century, a great deal of mathematical effort in stochastic analysis has been devoted to the study of the existence, uniqueness and regularity properties of strong solutions to Itô uniformly nondegenerate stochastic equations with deterministic and irregular drifts. When $\nabla \sigma \in L_{l o c}^{2 d}$ and $b$ is bounded, Veretennikov [19] proved the strong existence and uniqueness of solutions to SDE (1.1) by developing the original idea proposed by Zvonkin in [26]. In the case that $\sigma=\mathbb{I}$ and $b \in L_{t}^{q} L_{x}^{p}$ with $\frac{n}{p}+\frac{2}{q}<1$, using Girsanov's transformation and $L_{t}^{q} L_{x}^{p}$-estimate for parabolic equations, Krylov-Röckner [11] obtained the existence and uniqueness of strong solutions to (1.1). After that, a lot of works appeared to investigate properties of the strong solution to (1.1) with singular drifts. Among all, we mention that the Hölder continuity of the stochastic flow was proved
by Fedrizzi and Flandoli in [5], provided that the coefficients meet the same condition in [11]. When $b$ is bounded, Menoukeu et al. [15] obtained the weak differentiability of the stochastic flow and the Malliavin differentiability of $X_{t}$ with respect to the sample $\omega$ by using Malliavin's calculus. Zhang [21] extended Veretennikov's unique strong solvability result to the case that $\nabla \sigma, b \in L_{t}^{q} L_{x}^{p}$ with $\frac{n}{p}+\frac{2}{q}<1$. Under similar conditions, the regularities of strong solutions with respect to the initial data and sample point were also shown in [22] and [20]. For more recent results, we refer the reader to [12] and [16]. We also note that martingale problems and stochastic Lagrangian flows corresponding to (1.1) were studied by many researchers, among which we quote [2, 17, 23-25].

The well-posedness and regularities of strong solutions to SDEs with singular coefficients is not only a fundamental theoretical problem, but also has a wide range of applications in many mathematical and physical problems. For instance, in the remarkable paper [7], Flandoli, Gubinelli and Priola studied the following linear stochastic transport equation (see also [6]):

\end{equation*}

where $b: \mathbb{R}^{n} \times[0,1] \rightarrow \mathbb{R}^{n}$ is deterministic. Using the stochastic flow of the corresponding SDE (or stochastic characteristics), they proved the existence and uniqueness for the above equation in $L^{\infty}$-setting, provided that the drift $b$ is $\alpha$-Hölder continuous uniform in $t$ and the divergence of $b$ satisfies some integrability conditions. However, as mentioned in [7], one of the major obstacles to extending the regularization by noise phenomenon to the case where $b$ is random is the fact that even when $b$ is Hölder continuous in $x$ the stochastic characteristics corresponding to (1.2) may not uniquely exist. Below is a simple but typical example:
Example 1. Let $d=n=1$. Assume $\sigma=1$ and

b_{t}(x)=\sqrt{\left|x-W_{t}\right|} \wedge 1, \quad X_{0}=0
$$

Denote $Y_{t}:=X_{t}-W_{t}$, then $Y_{t}$ satisfies the following random ODE:

\mathrm{d} Y_{t}(\omega)=b_{t}\left(Y_{t}(\omega)+W_{t}(\omega), \omega\right) \mathrm{d} t=\left(\sqrt{\left|Y_{t}(\omega)\right|} \wedge 1\right) \mathrm{d} t, \quad Y_{0}=0
$$

One can verify that $y_{t}^{(1)} \equiv 0$ and $y_{t}^{(2)}=\frac{t^{2}}{4}$ are two solutions of the above ODE, which implies $X_{t}^{(1)}=W_{t}$ and $X_{t}^{(2)}=\frac{t^{2}}{4}+W_{t}$ are two $\mathscr{F}_{t}$-adapted solutions to equation

$$
X_{t}=\int_{0}^{t} b_{s}\left(X_{s}\right) \mathrm{d} s+W_{t}, \quad t \in[0,1] .
$$

The above example demonstrates that the non degeneracy of the noise and the uniformly Hölder continuity of $b_{t}(\cdot, \omega)$ are insufficient to guarantee the well-posedness of (1.1). To the best of our knowledge, there is little literature was written to address this issue so far. The main work before this paper is [4], which is a foundational work but misses some important requirements, in particular because it asks a specific form of Malliavin derivative for the drift, and in certain situations, $W^{1, p}$ regularity for drift with respect to
$x$, which makes the results not so competitive. This paper attempts to make some progress in this direction. Roughly speaking, our main result, Theorem 1.1, shows that if the noise is additive and nondegenerate, and $b$ is Hölder in $x$, the well-posedness of the Itô equation (1.1) is guaranteed when $D b_{t}(x)$, the Malliavin differentiable of $b_{t}(x)$, also satisfies a Hölder continuity assumption with respect to $x$.

With a little abuse of notation, in this paper $L^{p}\left(\Omega, \mathscr{F}, \mathbf{P} ; \mathbb{R}^{m}\right)$ is abbreviated as $L^{p}(\Omega)$, where $m$ is an integer that may take different values in different places. Our main result is
Theorem 1.1. Let $\alpha \in(0,1), p>n / \alpha, \Lambda>1, \Delta:=\left\{(s, t) \in[0,1]^{2}: 0 \leqslant s \leqslant t \leqslant 1\right\}$ and let $D$ be the Malliavin derivative operator. Assume that $\sigma$ and $b$ are $\mathscr{B} \times \mathscr{P}$ measurable, then equation (1.1) admits a unique solution if $\sigma$ and $b$ satisfy the following assumptions:
(i) for almost surely $\omega \in \Omega, \sigma(\omega)$ and $b(\omega)$ are bounded, and for all $x, y \in \mathbb{R}^{n}, t \in$ $[0,1]$,

\left|b_{t}(x, \omega)-b_{t}(y, \omega)\right| \leqslant \Lambda|x-y|^{\alpha}, \quad\left|\sigma_{t}(x, \omega)-\sigma_{t}(y, \omega)\right| \leqslant \Lambda|x-y|
$$

(ii) for almost surely $\omega \in \Omega$ and all $(x, t) \in \mathbb{R}^{n} \times[0,1]$,

$$
\Lambda^{-1}|\xi|^{2} \leqslant \frac{1}{2} \sigma_{t}^{i k} \sigma_{t}^{j k}(x, \omega) \xi_{i} \xi_{j} \leqslant \Lambda|\xi|^{2}, \quad \forall \xi \in \mathbb{R}^{d}
$$

(iii) for each $(x, t) \in \mathbb{R}^{n} \times[0,1], \sigma_{t}(x), b_{t}(x)$ are Malliavin differentiable and the random fields $D_{s} \sigma_{t}(x)$ and $D_{s} b_{t}(x)$ have continuous versions as maps from $\mathbb{R}^{n} \times \Delta$ to $L^{2 p}(\Omega)$ such that

\sup _{(s, t) \in \Delta}\left(\left\|D_{s} \sigma_{t}\right\|_{C^{\alpha}\left(\mathbb{R}^{n} ; L^{2 p}(\Omega)\right)}+\left\|D_{s} b_{t}\right\|_{C^{\alpha}\left(\mathbb{R}^{n} ; L^{2 p}(\Omega)\right)}\right) \leqslant \Lambda . \tag{1.3}
\end{equation*}
$$

We give an example of $b$ meeting the conditions in Theorem 1.1.
Example 2. Let $n=d=1, \alpha \in(0,1), p>1 / \alpha$. Assume $\bar{b}:[0,1] \times \mathbb{R}^{2} \rightarrow \mathbb{R}$ is bounded function satisfying

\left(\left|\bar{b}_{t}(x, y)-\bar{b}_{t}\left(x^{\prime}, y\right)\right|+\left|\partial_{y} \bar{b}_{t}(x, y)-\partial_{y} \bar{b}_{t}\left(x^{\prime}, y\right)\right|\right) \leqslant C\left|x-x^{\prime}\right|^{\alpha}, \quad \forall x, x^{\prime}, y \in \mathbb{R}^{n}, t \in[0,1]
$$

and

$$
b_{t}(x, \omega):=\bar{b}_{t}\left(x, \int_{0}^{t} h_{r}(\omega) \mathrm{d} W_{r}(\omega)\right) .
$$

Here $h$ is an adapted process satisfying

$$
\sup _{s \in[0,1]} \mathbf{E}\left(\left|h_{s}\right|^{2 p}+\int_{0}^{1}\left|D_{s} h_{r}\right|^{2 p} \mathrm{~d} r\right)<\infty .
$$

Noting that

$$
D_{s} b_{t}(x)=\partial_{y} \bar{b}_{t}\left(x, \int_{0}^{t} h_{r} \mathrm{~d} W_{r}\right)\left(\int_{s}^{t} D_{s} h_{r} \mathrm{~d} W_{r}+h_{s}\right) \mathbf{1}_{\Delta}(s, t),
$$

by Burkholder-Davis-Gundy's inequality, one sees that

$$
\begin{aligned}
& \sup _{t \in[0,1] ; \omega \in \Omega}\left\|b_{t}(\cdot, \omega)\right\|_{C^{\alpha}(\mathbb{R})}+\sup _{(s, t) \in \Delta}\left\|D_{s} b_{t}\right\|_{C^{\alpha}\left(\mathbb{R} ; L^{2 p}(\Omega)\right)} \\
\leqslant & {\left[1+\sup _{s \in[0,1]} \mathbf{E}\left(\left|h_{s}\right|^{2 p}+\int_{0}^{1}\left|D_{s} h_{r}\right|^{2 p} \mathrm{~d} r\right)^{1 / 2 p}\right]<\infty, }
\end{aligned}
$$

so $b$ satisfies the conditions in (i) and (iii) in Theorem 1.1.
Our approach of studying the well-posedness of (1.1) is using a modified Zvonkin transformation. Such kind of trick was first proposed in [26] for solving SDEs with deterministic and bounded coefficients. To explain our main idea, let us first give a brief introduction to Zvonkin's idea. Denote

$$
a=\frac{1}{2} \sigma \sigma^{*}, \quad L_{t} u=a_{t}^{i j} \partial_{i j} u+b_{t}^{i} \partial_{i} u
$$

When $a$ and $b$ are deterministic, $a, b \in L_{t}^{\infty} C_{x}^{\alpha}$ and $a$ is uniformly elliptic, by Schauder's estimate, the following backward equation

$$
\partial_{t} u+L_{t} u=-b, \quad u_{T}(x)=0
$$

admits a unique solution $u \in L_{t}^{\infty} C_{x}^{2+\alpha}$ with $\partial_{t} u \in L_{t}^{\infty} C_{x}^{\alpha}$. Moreover, if $T$ is sufficiently small, the map $x \mapsto \phi_{t}(x):=x+u_{t}(x)$ is a $C^{2}$-homeomorphism. Assuming that $X_{t}$ solves (1.1), by Itô's formula, $Y_{t}:=\phi_{t}\left(X_{t}\right)$ satisfies a new SDE with Lipschitz continuous coefficients. Thus, the strong uniqueness of the solution to the original equation is given by the one of the new equation. Coming to the case that $\sigma, b$ are progressive measurable and

$$
\operatorname{ess} \sup _{\omega \in \Omega}\left(\|\sigma(\omega)\|_{L_{t}^{\infty} C_{x}^{\alpha}}+\|b(\omega)\|_{L_{t}^{\infty} C_{x}^{\alpha}}\right)<\infty .
$$

Thanks to the classic Schuader's estimate, pointwisely, one can solve the backward equation

$$
\begin{equation*}
\partial_{t} w+L_{t} w+f=0, \quad w_{T}(x)=0 . \tag{1.4}
\end{equation*}
$$

Moreover, $w$ satisfies

$$
\operatorname{ess} \sup _{\omega \in \Omega}\left(\|w(\omega)\|_{L_{t}^{\infty} C_{x}^{2+\alpha}}+\left\|\partial_{t} w(\omega)\right\|_{L_{t}^{\infty} C_{x}^{\alpha}}\right) \leqslant C \operatorname{ess} \sup _{\omega \in \Omega}\|f(\omega)\|_{L_{t}^{\infty} C_{x}^{\alpha}} .
$$

However, in this case for each $x \in \mathbb{R}^{d}$, the process $w \cdot(\cdot, x):(t, \omega) \mapsto w_{t}(x, \omega)$ is nonadapted, so one cannot apply the Itô-Wentzell formula as in the deterministic case. A very natural way to overcome this difficulty is to consider the function $u_{t}:=\mathbf{E}\left(w_{t} \mid \mathscr{F}_{t}\right)$ instead of $w_{t}$. Formally, $u_{t}$ satisfies the following backward stochastic Kolmogorov equation (see Lemma 3.1):

\begin{equation*}
\mathrm{d} u_{t}+\left(L_{t} u_{t}+f_{t}\right) \mathrm{d} t=v_{t} \cdot \mathrm{~d} W_{t}, \quad u_{T}(x)=0 . \tag{1.5}
\end{equation*}
$$

On this point, a more general class of semi-linear equations including (1.5) were already studied by Du-Qiu-Tang [3] in $L^{p}$-spaces and also by Tang-Wei [18] in Hölder spaces.

However, the main obstacle of applying their result for our purpose is that one can only expect that the vector field $v$ is in some $L^{p}$ (or $C^{\alpha}$ ) space, which is far from enough to apply the Itô-Wentzell formula (see Lemma 5.7). On the other hand, Duboscq-Réveillac [4], studied the stochastic regularization effects of diffusions with random drift coefficients on random functions. After adding some Malliavin differentiability conditions on $b$ and $f$, they extended the boundedness of time average of a deterministic function $f$ depending on a diffusion process $X$ with deterministic drift coefficient $b$ to random mappings $f$ and $b$ by investigate the backward stochastic Kolmogorov equation (1.5) ( $a \equiv \mathbb{I}$ ) in some $L^{p}$-type space. Inspired by [4] and [26], in this paper we prove a $C^{2+\alpha}$ type estimate (Theorem 3.4) for $(u, v)$, provided that the coefficients satisfy some Malliavin differentiability conditions. To achieve this purpose, we first extend the classic Schauder estimate to random PDEs with Banach variables. Such kind of extension gives the $C^{2+\alpha}$ estimate for $u$, as well as $C^{\alpha}$ estimate for $v$ (see Lemma 3.1). The main ingredient of this paper is Theorem 3.4, where we give the $C^{2+\alpha}$ estimate for $v$, provided that the Malliavin derivatives of the coefficients satisfy (1.3). To us, such kind of result is new and intriguing. With such regularity estimate in hand, we then use a modified Itô-Wentzell's formula and Zvonkin type transformation to prove the well-posedness of (1.1). We believe our results have the potential to be applied to stochastic transport equations with random coefficients and some other nonlinear stochastic PDEs.

This paper is organized as follows: In Section 2, we investigate a random Banachvalued non-adapted Kolmogorov equation and prove its well-posedness in some Hölder type spaces. In Section 3, we study the solvability of backward stochastic Kolmogorov equation (1.5) in some $C^{2+\alpha}$ space. Our main result was proved in Section 4. A ItôWenzell type formula and some auxiliary lemmas used in our main proofs were presented in Appendix.

## 2. Schauder Estimates for Random Banach-valued PDEs

In this section, we give a self-contain proof of Schauder type estimate for random Banchvalued parabolic PDEs by using Littlewood-Paley decomposition.

Let $T \in(0,1], D$ be a domain of $\mathbb{R}^{n}, D_{T}=D \times[0, T]$ and $\mathcal{B}$ be a real Banach space. For any $\alpha \in(0,1)$ and strongly continuous function $g: D \rightarrow \mathcal{B}$, we define

\|g\|_{0 ; D}:=\sup _{x \in D}|g(x)|_{\mathcal{B}}, \quad[g]_{\alpha ; D}:=\sup _{x, y \in D} \frac{|g(x)-g(y)|_{\mathcal{B}}}{|x-y|^{\alpha}} .
$$

For $k \in \mathbb{N}$,

$$
\|g\|_{C^{k+\alpha}(D ; \mathcal{B})}:=\sum_{i=0}^{k}\left\|\nabla^{i} g\right\|_{0 ; D}+\left[\nabla^{k} g\right]_{\alpha ; D}
$$

Here and below, all the derivatives of an $\mathcal{B}$-valued function are defined with respect to the spatial variable in the strong sense, namely, $\nabla g$ is the unique map from $\mathbb{R}^{n}$ to $\mathcal{L}\left(\mathbb{R}^{n} ; \mathcal{B}\right)$ such that $\lim _{|h| \rightarrow 0}|g(x+h)-g(x)-\nabla g(x) \cdot h|_{\mathcal{B}}=0$. For any $\beta \geqslant 0$, the space
$C_{x, t}^{\beta, 0}\left(D_{T} ; \mathcal{B}\right)$ consists all continuous function $f: D_{T} \rightarrow \mathcal{B}$ such that

\|f\|_{C_{x, t}^{\beta, 0}\left(D_{T} ; \mathcal{B}\right)}:=\sup _{t \in[0, T]}\|f(t)\|_{C^{\beta}(D ; \mathcal{B})}<\infty .
$$

Below we always denote $Q_{T}=\mathbb{R}^{n} \times[0, T]$ and $Q=Q_{1}$. If there is no confusion on the time parameter $T$ and underlying Banach space $\mathcal{B}$, we simply write $C^{\beta}$ and $C_{x, t}^{\beta}$ instead of $C^{\beta}\left(\mathbb{R}^{n} ; \mathcal{B}\right)$ and $C_{x, t}^{\beta, 0}\left(Q_{T} ; \mathcal{B}\right)$, respectively.

### 2.1. Littlewood-Paley decomposition

Let $\mathcal{\delta}\left(\mathbb{R}^{n}\right)$ be the Schwartz space of all rapidly decreasing complex valued functions on $\mathbb{R}^{n}$, and $\mathcal{S}^{\prime}\left(\mathbb{R}^{n}\right)$ be the dual space of $\mathcal{S}\left(\mathbb{R}^{n}\right)$ (tempered distribution space). Given $f \in$ $\mathcal{S}\left(\mathbb{R}^{n}\right)$, the Fourier transform and inverse transform of $f$ are defined by

& \mathscr{F}(f)(\xi):=(2 \pi)^{-n / 2} \int_{\mathbb{R}^{n}} \mathrm{e}^{-\mathrm{i} \xi \cdot x} f(x) \mathrm{d} x, \\
& \mathscr{F}^{-1} f(\xi):=(2 \pi)^{-n / 2} \int_{\mathbb{R}^{n}} \mathrm{e}^{\mathrm{i} \xi \cdot x} f(x) \mathrm{d} x .
\end{aligned}

Let $\chi: \mathbb{R}^{n} \rightarrow[0,1]$ be a smooth radial function with

\chi(\xi)=1,|\xi| \leqslant 1 ; \chi(\xi)=0,|\xi| \geqslant 3 / 2 .
$$

Define

\varphi(\xi):=\chi(\xi)-\chi(2 \xi), \quad \varphi_{-1}(\cdot):=\chi(2 \cdot), \quad \varphi_{j}(\cdot):=\varphi\left(2^{-j} \cdot\right)(j=0,1,2, \cdots) .
$$

It is easy to see that $\varphi \geqslant 0$ and $\operatorname{supp} \varphi \subset B_{3 / 2} \backslash B_{1 / 2}$ and formally

\sum_{j=-1}^{k} \varphi_{j}(\xi)=\chi\left(2^{-k} \xi\right) \xrightarrow{k \uparrow \infty} 1 . \tag{2.1}

In particular, if $\left|j-j^{\prime}\right| \geqslant 2$, then

Let $\widetilde{\varphi}$ be another smooth radial function, $\operatorname{supp} \widetilde{\varphi} \in B_{\frac{7}{4}} \backslash B_{\frac{1}{4}}$ and $\widetilde{\varphi}(x)=1$ for all $x \in B_{\frac{3}{2}} \backslash B_{\frac{1}{2}}$. Denote

h_{j}:=\mathscr{F}^{-1}\left(\varphi_{j}\right), \quad \widetilde{h}_{j}:=\mathscr{F}^{-1}\left(\widetilde{\varphi}_{j}\right) .
$$

For any $f \in L^{1}\left(\mathbb{R}^{n} ; \mathcal{B}\right)+L^{\infty}\left(\mathbb{R}^{n} ; \mathcal{B}\right)$, define

$$
\Delta_{j} f:=\int_{\mathbb{R}^{n}} h_{j}(x-y) f(y) \mathrm{d} y, \quad \widetilde{\Delta}_{j} f:=\int_{\mathbb{R}^{n}} \widetilde{h}_{j}(x-y) f(y) \mathrm{d} y .
$$

### 2.2. A basic apriori estimate

Assume $(\Omega, \mathscr{F}, \mathbf{P})$ is a complete probability space, $\mathcal{H}$ is a real Hilbert spaces and $\mathcal{B}=$ $L^{p}(\Omega, \mathscr{F}, \mathbf{P} ; \mathcal{H})$ for some $p \geqslant 2$. Let $a^{i j}, b^{i}, c$ be real-valued measurable functions on $Q \times \Omega$ and define

L_{t}:=a_{t}^{i j} \partial_{i j}+b_{t}^{i} \partial_{i}+c_{t} .
$$

Fix $T \in(0,1]$, we first give the precise definition of solutions to the following $\mathcal{B}$-valued PDE

w_{T}=0 \text { on } \mathbb{R}^{n}
\end{array}\right.

Definition 2.1. A fucntion $w: Q_{T} \rightarrow \mathcal{B}$ is called a solution of (2.2) if
(1) For each $t \in[0, T], w(t, \cdot)$ is a twice strongly differentiable function from $\mathbb{R}^{n}$ to $\mathcal{B}$;
(2) For each $x \in \mathbb{R}^{n}$, the process $w(\cdot, x)$ is absolutely continuous from $[0, T]$ to $\mathcal{B}$ satisfying

w_{t}(x)=\int_{t}^{T}\left(L_{s} w_{s}+f_{s}\right)(x) \mathrm{d} s
$$

In order to study the solvability of (2.2), we need the following
Assumption 1. The map $(x, t, \omega) \mapsto\left(a_{t}(x, \omega), b_{t}(x, \omega), c_{t}(x, \omega), f_{t}(x, \omega)\right)$ is $\mathscr{B}(Q) \times \mathscr{F}$ measurable and there are constants $\alpha \in(0,1)$ and $\Lambda>1$ such that for almost surely $\omega \in \Omega$,

Our main result in this section is
Theorem 2.2. Under Assumption 1, for any $f \in C_{x, t}^{\alpha}$, equation (2.2) admits a unique solution $w$ in $C_{x, t}^{2+\alpha}$. Moreover,

& \leqslant\left\|\Delta_{j} g\right\|_{0} \int_{\mathbb{R}^{n}}\left[\operatorname{ess} \sup _{\omega \in \Omega}\left|p_{t, s}^{a(\omega)} * \widetilde{h}_{j}(y)\right|\right] \mathrm{d} y .

= & \int_{\mathbb{R}^{n}} \mathrm{~d} x \sup _{\mathbb{I} / \Lambda \leqslant a \leqslant \Lambda \mathbb{I}}\left|\int_{\mathbb{R}^{n}} p_{t, s}^{a}(x-y) 2^{j n} \widetilde{h}_{0}\left(2^{j} y\right) \mathrm{d} y\right| \\
= & \int_{\mathbb{R}^{n}} \mathrm{~d} x \sup _{\mathbb{I} / \Lambda \leqslant a \leqslant \Lambda \mathbb{I}}\left|\int_{\mathbb{R}^{n}} 2^{j n} p_{t, s}^{2^{2 j} a}\left(2^{j} x-z\right) \widetilde{h}_{0}(z) \mathrm{d} z\right| \\

& \leqslant C N^{k p-n} \mathbf{E} \sup _{\|h\|_{\mathcal{H}}=1}\left\|\left\langle v_{t_{1}}^{\varepsilon}-v_{t_{2}}^{\varepsilon}, h\right\rangle\right\|_{W^{k, p}\left(B_{N}\right)}^{p} \\
& \leqslant C N^{k p-n} \mathbf{E} \sum_{i=0}^{k} \int_{B_{N}}\left|\nabla^{i} \int_{t_{1}}^{t_{2}}\left(a^{i j} \partial_{i j} v_{s}^{\varepsilon}\right)(x) \mathrm{d} s\right|_{\mathcal{H}}^{p} \mathrm{~d} x \\
& \leqslant C N^{k p-n}\left|t_{2}-t_{1}\right|^{p-1} \sum_{i=2}^{k+2} \int_{B_{N}} \int_{t_{1}}^{t_{2}} \mathbf{E}\left|\int_{B_{N+1}} v_{s}(y) \nabla^{i} \rho_{\varepsilon}(x-y) \mathrm{d} y\right|_{\mathcal{H}}^{p} \mathrm{~d} s \mathrm{~d} x \\
& \leqslant C_{\varepsilon} N^{k p+n p-n}\left|t_{2}-t_{1}\right|^{p-1} \int_{t_{1}}^{t_{2}} \int_{B_{N+1}} \mathbf{E}\left|v_{s}(y)\right|_{\mathcal{H}}^{p} \mathrm{~d} y \\
& \leqslant C_{\varepsilon} N^{(k+n) p}\left|t_{2}-t_{1}\right|^{p}\|v\|_{C_{x, t}^{0}}^{p} .

Due to Kolmogorov's criterion, for almost surely $\omega \in \Omega$ and all $\varepsilon \in(0,1),(x, t) \in Q_{T}$,

So $\left\|w_{t}(x)-\widetilde{w}_{t}(x)\right\|_{\mathcal{B}} \leqslant \lim _{\varepsilon \rightarrow 0}\left\|w_{t}(x)-\left(w * \varrho_{\varepsilon}\right)_{t}(x)\right\|_{\mathcal{B}}+\lim _{\varepsilon \rightarrow 0}\left\|\widetilde{w}_{t}(x)-\left(\widetilde{w} * \varrho_{\varepsilon}\right)_{t}(x)\right\|_{\mathcal{B}}=$ 0 . So we complete our proof.

Proof of Theorem 2.2. Thanks to Lemma 2.3 and the method of continuity, we only need to prove the aprior estimate (2.3). Assume $w \in C_{x, t}^{2+\alpha}$ is a solution to (2.2). Let $\chi \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$
so that $\chi(x)=1$ if $|x| \leqslant 1$ and $\chi(x)=0$ if $|x| \geqslant 2$. Fix a number $\delta>0$, which will be determined later. Define $\chi_{\delta}^{z}=\chi((x-z) / \delta)$, then

\leqslant & C \sup _{z \in \mathbb{R}^{n}}\left\|w \chi_{\delta}^{z}\right\|_{C_{x, t}^{2+\alpha}} \leqslant C \sup _{z \in \mathbb{R}^{n}}\left\|f \chi_{\delta}^{z}+\left[\chi_{\delta}^{z} L_{t} w-L_{t}^{z}\left(w \chi_{\delta}^{z}\right)\right]\right\|_{C_{x, t}^{\alpha}} \\
\leqslant & C \delta^{\alpha} \sup _{z \in \mathbb{R}^{n}}\|w\|_{C_{x, t}^{2+\alpha, 0}\left(B_{2 \delta}(z) \times[0, T] ; \mathcal{B}\right)}+C\left(\delta^{-\alpha}\left\|\nabla^{2} w\right\|_{C_{x, t}^{0}}+\delta^{-1-\alpha}\|\nabla w\|_{C_{x, t}^{\alpha}}\right. \\
& \left.+\delta^{-2-\alpha}\|w\|_{C_{x, t}^{\alpha}}+\delta^{-\alpha}\|f\|_{C_{x, t}^{\alpha}}\right) .

It remains to show that $\|w\|_{C_{x, t}^{0}}$ can be controlled by $\|f\|_{C_{x, t}^{\alpha}}$. By Minkowski's inequality, for any $t \in[0, T]$,

& \left(\mathbf{E} \int_{B_{r}(x)}\left|w_{t}(y)\right|_{\mathcal{H}}^{p} \mathrm{~d} y\right)^{1 / p}=\left(\mathbf{E} \int_{B_{r}(x)}\left|\int_{t}^{T} \partial_{s} w_{s}(y) \mathrm{d} s\right|_{\mathcal{H}}^{p} \mathrm{~d} y\right)^{1 / p}  \tag{2.10}\\
= & \left(\mathbf{E} \int_{B_{r}(x)}\left|\int_{t}^{T}\left(L_{s} w_{s}+f_{s}\right)(y) \mathrm{d} s\right|_{\mathcal{H}}^{p} \mathrm{~d} y\right)^{1 / p} \\
\leqslant & C \int_{t}^{T}\left(\mathbf{E} \int_{B_{r}(x)}\left|L_{s} w_{s}+f_{s}\right|_{\mathcal{H}}^{p}(y) \mathrm{d} y\right)^{1 / p} \mathrm{~d} s \\
\leqslant & C T r^{n / p}\left(\|w\|_{C_{x, t}^{2}}^{2}+\|f\|_{C_{x, t}^{0}}\right) .
\end{align*}
$$

One the other hand, by Hölder's inequality,
(2.11) $\left|w_{t}(x)\right|_{\mathcal{B}} \leqslant f_{B_{r}(x)}\left|w_{t}(x)-w_{t}(y)\right|_{\mathcal{B}} \mathrm{d} y+f_{B_{r}(x)}\left|w_{t}(y)\right|_{\mathcal{B}} \mathrm{d} y$

$$
\begin{aligned}
& \leqslant\|\nabla w\|_{C_{x, t}^{0}} f_{B_{r}(x)}|x-y| \mathrm{d} y+f_{B_{r}(x)}\left(\mathbf{E} \int_{B_{r}(x)}\left|w_{t}(y)\right|_{\mathcal{H}}^{p}\right)^{1 / p} \mathrm{~d} y \\
& \leqslant r\|\nabla w\|_{C_{x, t}^{0}}+r^{-n / p}\left(\mathbf{E} \int_{B_{r}(x)}\left|w_{t}(y)\right|_{\mathcal{H}}^{p} \mathrm{~d} y\right)^{1 / p} .
\end{aligned}
$$

Combining (2.10) and (2.11), we obtain

\|w\|_{C_{x, t}^{0}} \leqslant r\|\nabla w\|_{C_{x, t}^{0}}+C T\left(\|w\|_{C_{x, t}^{2}}+\|f\|_{C_{x, t}^{0}}\right) .

Combining the above two inequalities and letting $r \rightarrow 0$, we get

By choosing $T$ sufficiently small such that $C T \leqslant 1 / 2$, we get

This together with (2.9) implies that (2.3) holds for some small $T>0$. The same estimate for arbitrary $T \in(0,1]$ can be obtained by induction.

Remark 2.4. If $f$ satisfies

& \left.+T^{-1}\|w(\omega)\|_{C_{x, t}^{\alpha, 0}\left(Q_{T} ; \mathbb{R}\right)}\right) \leqslant C \operatorname{ess} \sup _{\omega \in \Omega}\|f(\omega)\|_{C_{x, t}^{\alpha, 0}\left(Q_{T} ; \mathbb{R}\right)} .
\end{align*}

## 3. Schauder estimate for Backward SPDE

In this section, we prove the solvability of (1.5) in $C_{x, t}^{2+\alpha} \times C_{x, t}^{2+\alpha}$ space. Recall that $W_{t}$ is a $d$-dimensional Brownian motion on a complete probability space $(\Omega, \mathscr{F}, \mathbf{P}), \mathscr{F}_{t}=\sigma\left\{W_{s}\right.$ : $s \leqslant t\} \bigvee \mathcal{N}$ and $\mathscr{F}=\mathscr{F}_{1}$. For any $t \in[0,1]$ and $X \in \mathscr{F}$, we denote $\mathbf{E}^{t} X:=\mathbf{E}\left(X \mid \mathscr{F}_{t}\right)$. Throughout this section, we always assume $T \in(0,1], \mathcal{H}$ is a real Hilbert space, $\mathcal{B}=$ $L^{p}(\Omega ; \mathcal{H})$ for some $p \geqslant 2$ and $H=L^{2}\left([0,1] ; \mathbb{R}^{d}\right)$. With a little abuse of notation, $L^{p}(\Omega)=$ $L^{p}\left(\Omega ; \mathbb{R}^{m}\right)$ for some integer $m \geqslant 1$ that can be changed in different places.

Lemma 3.1. Let $\mathcal{H}=\mathbb{R}$. Assume that $a, b, c$ are $\mathscr{B} \times \mathscr{P}$ measurable and satisfy Assumption 1, then the following BSPDE

has an $\mathscr{F}_{t}$-adapted solution $(u, v)$ in $C_{x, t}^{2+\alpha} \times C^{\alpha}\left(\mathbb{R}^{n} ; L^{p}(\Omega ; H)\right.$ and $u_{t}=\mathbf{E}^{t} w_{t}$, where $w$ is the solution to (2.2). Moreover,

\|u\|_{C_{x, t}^{2+\alpha}}+T^{-1}\|u\|_{C_{x, t}^{0}}+\|v\|_{C^{\alpha}\left(\mathbb{R}^{n} ; L^{p}(\Omega ; H)\right)} \leqslant C\|f\|_{C_{x, t}^{\alpha}},
$$

where $C$ only depends on $n, d, p, \alpha, \Lambda$.
Proof. Let $w$ be the solution of (2.2). Define $u_{t}(x)=\mathbf{E}^{t} w_{t}(x)$. By Theorem 2.2 and Lemma 5.4,

Since $a_{t}(x), b_{t}(x) \in \mathscr{F}_{t}$, by the definitions of $u$, we have

& +\left\{\int_{t}^{T} \mathbf{E}^{t}\left[\left(L_{s} w_{s}+f_{s}\right)(x)\right] \mathrm{d} s-\int_{t}^{T} \mathbf{E}^{s}\left[\left(L_{s} w_{s}+f_{s}\right)(x)\right] \mathrm{d} s\right\} \\
= & \int_{t}^{T}\left(L_{s} u_{s}+f_{s}\right)(x) \mathrm{d} s+m_{t}(x)-m_{T}(x) .
\end{aligned}
$$

Here

$$
\begin{align*}
m_{t}(x)=\int_{t}^{T} \mathbf{E}^{t}\left[\left(L_{s} w_{s}\right.\right. & \left.\left.+f_{s}\right)(x)\right] \mathrm{d} s  \tag{3.1}\\
& +\int_{0}^{t} \mathbf{E}^{s}\left[\left(L_{s} w_{s}+f_{s}\right)(x)\right] \mathrm{d} s \in \mathscr{F}_{t}
\end{align*}
$$

For any $t \in[0, T]$, noting that

$$
\begin{aligned}
\mathbf{E}^{t} m_{T}(x) & =\mathbf{E}^{t} \int_{0}^{T} \mathbf{E}^{s}\left[\left(L_{s} w_{s}+f_{s}\right)(x)\right] \mathrm{d} s \\
& =\mathbf{E}^{t} \int_{0}^{t} \mathbf{E}^{s}\left[\left(L_{s} w_{s}+f_{s}\right)(x)\right] \mathrm{d} s+\mathbf{E}^{t} \int_{t}^{T} \mathbf{E}^{s}\left[\left(L_{s} w_{s}+f_{s}\right)(x)\right] \mathrm{d} s \\
& =\int_{0}^{t} \mathbf{E}^{s}\left[\left(L_{s} w_{s}+f_{s}\right)(x)\right] \mathrm{d} s+\int_{t}^{T} \mathbf{E}^{t}\left[\left(L_{s} w_{s}+f_{s}\right)(x)\right] \mathrm{d} s=m_{t}(x),
\end{aligned}
$$

$m .(x)$ is a $\mathscr{F}_{t}$-martingale. By Theorem 2.2, (3.1) and Lemma 5.4, one can see that $m \in$ $C_{x, t}^{\alpha}$. Thanks to martingale representation, there is an $\mathscr{F}_{t}$-adapted process $v .(x)$ such that

= & C \mathbf{E}\left|\int_{0}^{T} \mathbf{E}^{s}\left[\left(L_{s} w_{s}+f_{s}\right)(x)-\left(L_{s} w_{s}+f_{s}\right)(y)\right] \mathrm{d} s\right|^{p} \\
\leqslant & C \int_{0}^{T} \mathbf{E}\left|\mathbf{E}^{s}\left[\left(L_{s} w_{s}+f_{s}\right)(x)-\left(L_{s} w_{s}+f_{s}\right)(y)\right]\right|^{p} \mathrm{~d} s \\
\leqslant & C \int_{0}^{T} \mathbf{E}\left|\left(L_{s} w_{s}+f_{s}\right)(x)-\left(L_{s} w_{s}+f_{s}\right)(y)\right|^{p} \mathrm{~d} s \\
\leqslant & C|x-y|^{\alpha p}\left(\|w\|_{C_{x, t}}^{p}+\|f\|_{C_{x, t}^{\alpha}}^{p}\right) \leqslant C|x-y|^{\alpha p}\|f\|_{C_{x, t}^{\alpha}}^{p},
\end{aligned}

So we complete our proof.
As we mentioned in the introduction, the Zvonkin type transform is an effective way to prove the well-posedeness of SDEs with singular coefficients. However, the $C^{\alpha}$-regularity of $v$ in the spatial variable is not enough to apply this trick. So we need to get better regularity estimate for $v$ under some mild conditions. To achieve this goal, we start with some definitions and lemmas. Let $\mathcal{S}_{b}$ be the set of random variables of the form

For any $p \in[1, \infty), \mathbb{D}^{1, p}$ is the closure of the set $\mathcal{S}_{b}$ with respect to the norm $\|F\|_{\mathbb{D}^{1, p}}:=$ $\|F\|_{p}+\|D F\|_{L^{p}(\Omega ; H)}$.
Lemma 3.2. Suppose $\left\{y_{t}\right\}_{t \in[0,1]}$ is a process (may not be adapted) on $(\Omega, \mathbf{P}, \mathscr{F})$ and

y_{t}=y_{0}+\int_{0}^{t} \dot{y}_{r} \mathrm{~d} r
$$

with $y_{0} \in \mathbb{D}^{1,2}$ and $\dot{y} \in L^{2}\left([0,1] ; \mathbb{D}^{1,2}\right)$. Then there exists a random field $\left\{y_{s, t}\right\}_{(s, t) \in[0,1]^{2}}$ such that for each $t \in[0,1], y_{, t}=D . y_{t}$ in $L^{2}(\Omega ; H)$; for each $s \in[0,1]$, the map $[0,1] \ni$ $t \mapsto y_{s, t} \in L^{2}\left(\Omega ; \mathbb{R}^{d}\right)$ is absolutely continuous and

\mathbf{E}^{t} y_{t}=\mathbf{E} y_{0}+\int_{0}^{t} \mathbf{E}^{s} \dot{y}_{s} \mathrm{~d} s+\int_{0}^{t} \mathbf{E}^{s} y_{s, s} \mathrm{~d} W_{s} \tag{3.3}
\end{equation*}

Proof. By our condition that $y_{0} \in \mathbb{D}^{1,2}$ and $\dot{y} \in L^{2}\left([0,1] ; \mathbb{D}^{1,2}\right)$, we have $D y_{0} \in L^{2}([0,1] \times$ $\left.\Omega ; \mathbb{R}^{d}\right)$ and the map $(s, t, \omega) \mapsto D_{s} \dot{y}_{t}(\omega)$ is an element in $L^{2}\left([0,1]^{2} \times \Omega ; \mathbb{R}^{d}\right)$. By Fubini's theorem, there is a Lebesgue null set $\mathcal{N} \subseteq[0,1]$ such that for each $s \notin \mathcal{N}$, the map $t \mapsto$ $D_{s} \dot{y}_{t}$ is an element in $L^{2}\left([0,1] ; L^{2}(\Omega)\right)$ and $D_{s} y_{0} \in L^{2}(\Omega)$. For any $s \in[0,1]$, define

y_{s, t}= \begin{cases}D_{s} y_{0}+\int_{0}^{t} D_{s} \dot{y}_{r} \mathrm{~d} r & s \notin \mathcal{N}, t \in[0,1] \\ 0 & s \in \mathcal{N}, t \in[0,1] .\end{cases}

Obviously, for each $s \in[0,1]$, the map $[0,1] \ni t \mapsto y_{t, s} \in L^{2}(\Omega)$ is absolutely continuous. By our assumption

$$

i.e. $\dot{y}:[0,1] \rightarrow \mathbb{D}^{1,2}$ is Bochner integrable. Since $D$ is a continuous operator from $\mathbb{D}^{1,2}$ to $L^{2}(\Omega)$, we get

\end{aligned}

which means $y_{s, s}$ is an element of $L^{2}\left([0,1] \times \Omega ; \mathbb{R}^{d}\right)$. By Lemma 5.6, we have

\stackrel{(5.8)}{=} & \int_{0}^{t}\left(\mathbf{E}^{r} \dot{y}_{r}-\mathbf{E} \dot{y}_{r}\right) \mathrm{d} r=\int_{0}^{t} \mathbf{E}^{r} \dot{y}_{r} \mathrm{~d} r+\mathbf{E} y_{0}-\mathbf{E} y_{t} .

Assumption 2. For each $(x, t) \in Q, a_{t}(x), b_{t}(x), c_{t}(x)$ are Malliavin differentiable and each of the random fields $D_{s} a_{t}(x), D_{s} b_{t}(x), D_{s} c_{t}(x)$ has a continuous version as a map from $\mathbb{R}^{n} \times \Delta$ to $L^{2 p}(\Omega)$ such that
$\left(\mathbf{H}_{3}\right)$

The next Theorem is the key to the main purpose of this paper.

has an $\mathscr{F}_{t}$-adapted solution $(u, v) \in C_{x, t}^{2+\alpha} \times C_{x, t}^{2+\alpha}$, provided that $f \in C_{x, t}^{\alpha, 0}\left(Q_{T} ; L^{q}(\Omega)\right)$ and $D f \in C_{x, t}^{\alpha, 0}\left(Q_{T} ; L^{2 p}(\Omega ; H)\right)$. Moreover, there is a constant $C$ only depends on $n, d, p, q, \alpha, \Lambda, \Lambda^{\prime}$ such that

\|u\|_{C_{x, t}^{2+\alpha}}+\|v\|_{C_{x, t}^{2+\alpha}} \leqslant C\left(\|f\|_{C_{x, t}^{\alpha, 0}\left(Q_{T} ; L^{q}(\Omega)\right)}+\sup _{(s, t) \in \Delta_{T}}\left\|D_{s} f_{t}\right\|_{C^{\alpha}\left(\mathbb{R}^{n} ; L^{2 p}\left(\Omega ; \mathbb{R}^{d}\right)\right)}\right) .
$$

Proof. We divide the proof into four steps.
Step 1. Let

and $w$ be the unique solution to equation (2.2) in $C_{x, t}^{2+\alpha, 0}\left(Q_{T} ; L^{q}(\Omega)\right)$. Below we show that for each $(x, t), w_{t}(x)$ is Malliavin differentiable, and $D w$ satisfies the following $L^{p}(\Omega ; H)$ valued equation:

\end{gathered}

Recalling that $q>2 p \geq 4$, Hölder's inequality yields,

Next we show that $D_{\varepsilon}^{h} w_{t}(x)$ (see (3.5) for the definition) convergence to $\mathcal{D}^{h} w_{t}(x)$ in $L^{p}(\Omega)$, and as a consequence, we have $\mathcal{D} w_{t}(x)=D w_{t}(x)$. By the definition of $D_{\varepsilon}^{h} w$, one sees

= & \int_{t}^{T}\left[D_{\varepsilon}^{h} f_{r}+D_{\varepsilon}^{h} a_{r}^{i j} \partial_{i j} w_{r}+D_{\varepsilon}^{h} b_{r}^{i} \partial_{i} w_{r}+D_{\varepsilon}^{h} c_{r} w_{r}\right] \mathrm{d} r .
\end{align*}

Noting that for any $F \in \mathbb{D}^{1, p}$ and $h \in H$,

& \leqslant \sup _{0 \leqslant \theta \leqslant \varepsilon}\left\|\tau_{\theta h}\left(D^{h} f_{r}(x)-D^{h} f_{r}(y)\right)\right\|_{L^{q^{\prime}(\Omega)}}^{q^{\prime}}
\end{aligned}

& \leqslant C\left\|D f_{r}\right\|_{C^{\alpha}\left(\mathbb{R}^{n} ; L^{2 p}(\Omega ; H)\right)}^{q^{\prime}}|h|_{H}^{q^{\prime}}|x-y|^{\alpha q^{\prime}}
\end{aligned}

& \left.+\left\|D_{\varepsilon}^{h} c_{r}\right\|_{C_{x, t}^{\alpha, 0}\left(Q_{T} ; L^{q^{\prime \prime}}(\Omega)\right)}\right] \leqslant C .

& -\varepsilon\left(D_{\varepsilon}^{h} a^{i j} \partial_{i j} D_{\varepsilon}^{h} w+D_{\varepsilon}^{h} b^{i} \partial_{i} D_{\varepsilon}^{h} w+D_{\varepsilon}^{h} c D_{\varepsilon}^{h} w\right)=:-\sum_{i=1}^{3} F^{\varepsilon, i}
\end{align*}
$$

i.e. $\delta_{\varepsilon}^{h} w$ is a $L^{p}(\Omega)$-valued solution to (2.2) with $f$ replaced by $F_{t}^{\varepsilon}:=\sum_{i=1}^{3} F_{t}^{\varepsilon, i}$. Estimates (3.10) and (3.14) yield

\end{aligned}

where $\chi_{R}(x)=\chi(x / R)$. Due to our assumptions and (3.16),

Similarly, we have $F^{\varepsilon_{n_{k}}, 2} \chi_{R} \rightarrow 0$ and $F^{\varepsilon_{n_{k}}, 3} \chi_{R} \rightarrow 0$ in $C_{x, t}^{\alpha^{\prime}}$ as $k \rightarrow \infty$. Thus, $\lim \sup _{\varepsilon \rightarrow 0}\left\|F^{\varepsilon} \chi_{R}\right\|_{C_{x, t}^{\alpha^{\prime}}}=0$. So by (3.17), for any $R_{0}>0$,

& \left.+\sum_{i}\left\|D_{s} b^{i}\right\|_{C_{x, t}^{\alpha, 0}\left(Q_{T} ; L^{2 p}(\Omega)\right)}+\left\|D_{s} c\right\|_{C_{x, t}^{\alpha, 0}\left(Q_{T} ; L^{2 p}(\Omega)\right)}\right) \\
\leqslant & \leqslant\|f\|_{C_{x, t}^{\alpha, 0}\left(Q_{T} ; L^{q}(\Omega)\right)}+C \sup _{(s, t) \in \Delta_{T}}\left\|D_{s} f_{t}\right\|_{C^{\alpha}\left(\mathbb{R}^{n} ; L^{p}(\Omega)\right)} \leqslant C \Lambda_{f} .
\end{aligned}

\mathcal{W}_{s, s}(x) & =D_{s} w_{0}(x)+\int_{0}^{s} D_{s} \dot{w}_{r}(x) \mathrm{d} r=\int_{s}^{T} D_{s}\left[L_{r} w_{r}+f_{r}\right](x) \mathrm{d} r \\
& =\int_{s}^{T}\left[L_{r} D_{s} w_{r}+g_{r}^{s}\right](x) \mathrm{d} r=\int_{s}^{T}\left[L_{r} w_{r}^{s}+g_{r}^{s}\right](x)=w_{s}^{s}(x), s \in[0, T] \text { a.e., }
\end{aligned}
$$

we get

$$
\begin{aligned}
u_{t}(x) & =u_{0}(x)-\int_{0}^{t} \mathbf{E}^{s}\left(L_{s} w_{s}+f_{s}\right)(x) \mathrm{d} s+\int_{0}^{t} \mathbf{E}^{s} w_{s}^{s}(x) \cdot \mathrm{d} W_{s} \\
& =u_{0}(x)-\int_{0}^{t}\left(L_{s} u_{s}+f_{s}\right)(x) \mathrm{d} s+\int_{0}^{t} \mathbf{E}^{s} w_{s}^{s}(x) \cdot \mathrm{d} W_{s}
\end{aligned}
$$

Note $u_{T}(x)=0$, we have

Let $\varrho \in C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$ satisfying $\int \varrho=1$, and $\varrho_{m}(x):=m^{n} \varrho(m x)$. For any function $g$ : $\mathbb{R}^{n} \rightarrow \mathbb{R}^{m}$, set $g^{m}:=g * \rho_{m}$.

The following corollary of Theorem 3.4 is standard.
Corollary 3.5 (Stability). Assume $a, b$, c satisfy Assumption 1 and 2. Let $w_{t}^{m}$ (respectively $\left(u^{m}, v^{m}\right)$ ) be the solution to (2.2) (respectively (3.6)) in $C_{x, t}^{2+\alpha}$ (respectively $C_{x, t}^{2+\alpha} \times C_{x, t}^{2+\alpha}$ ) with $a, b, c, f$ replaced by $a^{m}, b^{m}, c^{m}, f^{m}$. Then for any $\beta \in(0, \alpha)$, it holds that

## 4. SDEs with random singular coefficients

In this section, we give the proof for our main result.
Proof of Theorem 1.1. We first point out that it is enough to prove the well-posedness of (1.1) for $t \in[0, T / 2]$, where $T$ is a universal constant depending only on $n, \alpha, \Lambda, p$.

Pathwise uniqueness: Assume $X_{t}$ is a solution to (1.1). We prove the uniqueness by Zvonkin type transformation. With a little abuse of notation, we denote $C_{x, t}^{\beta}=C_{x, t}^{\beta, 0}\left(Q_{T} ; L^{p}\left(\Omega ; \mathbb{R}^{m}\right)\right)$, where $m$ is an integer that can be changed in different places. Recalling that $L_{t}=a_{t}^{i j} \partial_{i j}+$ $b_{t}^{i} \partial_{i}$. We consider the following BSPDE:

By our assumptions and Theorem 3.4, (4.1) has an $\mathscr{F}_{t}$-adapted solution $\left(u_{t}, v_{t}\right)$ and

By Remark 2.4, we have

& \operatorname{ess} \sup _{\omega \in \Omega} \sup _{t \in[0, T]}\left(\left\|w_{t}(\cdot, \omega)\right\|_{C^{2+\alpha}}+T^{-1}\left\|w_{t}(\cdot, \omega)\right\|_{C^{\alpha}}\right) \\
\leqslant & C \operatorname{ess} \sup _{\omega \in \Omega} \sup _{t \in[0, T]}\left\|b_{t}(\cdot, \omega)\right\|_{C^{\alpha}} .
\end{aligned}
$$

Interpolation inequality and above estimate yield

where $C_{T} \rightarrow 0$ as $T \rightarrow 0$. Below we fix $T=T(n, \alpha, \Lambda, p)>0$ so that

\end{equation*}

So for almost surely $\omega \in \Omega, \phi_{t}(\cdot, \omega)$ is a stochastic $C^{2+\alpha}$-differential homeomorphism from $\mathbb{R}^{n}$ to $\mathbb{R}^{n}$. By the definition of $\phi$,

\end{equation*}
$$

We want to show that $\phi, g, u, v$ and $X$ are regular enough to apply the Itô-Wenzell formula (see Lemma 5.7). Since $\|v\|_{C_{x, t}^{2+\alpha}}<\infty$, we have

\leqslant & C_{N} \int_{B_{N}} \int_{B_{N}}|x-y|^{-d+(\alpha-\beta) p} \leqslant C_{N} .
\end{aligned}
$$

Combining this and the fact that $\sup _{t \in[0, T]} \mathbf{E}\left|\nabla^{2} v_{t}(0)\right|^{p}<\infty$, we get

\leqslant & C \mathbf{E} \int_{0}^{t}\left|\nabla^{k} v_{s}(x)-\nabla^{k} v_{s}(y)\right|^{p} \mathrm{~d} s \leqslant C|x-y|^{\alpha p}\left\|\nabla^{k} v\right\|_{C_{x, t}^{\alpha}}^{p},
\end{aligned}
$$

which together with (4.2) implies

Thanks to Lemma 5.3, for any $\beta \in(n / p, \alpha)$ and $\theta=\frac{1}{2}+\frac{\alpha-\beta}{2} \in\left(\frac{1}{2}, 1\right)$, we have

& \leqslant C_{N}\left|t_{1}-t_{2}\right|^{\theta}, \quad \theta \in(1 / 2,1)
\end{aligned}
$$

On the other hand, $\mathbf{E}\left|X_{t_{1}}-X_{t_{2}}\right|^{p^{\prime}} \leqslant C\left|t_{1}-t_{2}\right|^{\frac{p^{\prime}}{2}}\left(p^{\prime}=p /(p-1)\right)$. So $\phi, g, v, X$ satisfy all the conditions in Lemma 5.7. Using (5.10), we get

& +\left[b_{t}^{i}\left(X_{t}\right) \partial_{i} \phi_{t}\left(X_{t}\right)+a_{t}^{i j}\left(X_{t}\right) \partial_{i j} \phi_{t}\left(X_{t}\right)+\partial_{i} v_{t}^{k}\left(X_{t}\right) \sigma_{t}^{i k}\left(X_{t}\right)\right] \mathrm{d} t \\
& +\partial_{i} \phi_{t}\left(X_{t}\right) \sigma_{t}^{i k}\left(X_{t}\right) \mathrm{d} W_{t}^{k} \\
= & \partial_{i} v_{t}^{k}\left(X_{t}\right) \sigma_{t}^{i k}\left(X_{t}\right) \mathrm{d} t+\partial_{i} \phi_{t}\left(X_{t}\right) \sigma_{t}^{i k}\left(X_{t}\right) \mathrm{d} W_{t}^{k}+v_{t}^{k}\left(X_{t}\right) \mathrm{d} W_{t}^{k} .
\end{aligned}
$$

Set

$$
Y_{t}=\phi_{t}\left(X_{t}\right), \quad \widetilde{b}_{t}(y)=\partial_{i} v_{t}^{k} \sigma_{t}^{i k} \circ \phi_{t}^{-1}(y) \text { and } \widetilde{\sigma}_{t}(y)=\left[\nabla \phi_{t} \sigma_{t}+v_{t}\right] \circ \phi_{t}^{-1}(y) .
$$

By the above calculations, one sees that

Thanks to Lemma 5.2, $\widetilde{b}$ and $\widetilde{\sigma}$ are $\mathscr{B} \times \mathscr{P}$-measurable. For any $x, y \in B_{N}$ and $t \in[0, T]$, by the definitions of $\widetilde{b}$ and $\widetilde{\sigma}$, we have

where $K_{t}^{N}:=\left\|u_{t}\right\|_{C^{2}\left(B_{N}\right)}+\left\|v_{t}\right\|_{C^{2}\left(B_{N}\right)}$. It is not hard to see that $K_{t}^{N}$ is progressive measurable and satisfies

For any $N, k \in \mathbb{N}$, let $K_{t}^{m, N}:=\left\|u_{t}^{m}\right\|_{C^{2}\left(B_{N}\right)}+\left\|v_{t}^{m}\right\|_{C^{2}\left(B_{N}\right)}$,

& +\left|\left[\partial_{i} v_{t}^{m^{\prime}, k} \sigma_{t}^{i k}\right] \circ\left(\phi_{t}^{m}\right)^{-1}(x)-\left[\partial_{i} v_{t}^{m^{\prime}, k} \sigma_{t}^{i k}\right] \circ\left(\phi_{t}^{m^{\prime}}\right)^{-1}(x)\right| \\
\leqslant & C\left\|\nabla v_{t}^{m}-\nabla v_{t}^{m^{\prime}}\right\|_{L^{\infty}\left(B_{N}\right)}+C\left\|v_{t}^{m^{\prime}}\right\|_{C^{2}\left(B_{N}\right)}\left|\left(\phi_{t}^{m}\right)^{-1}(x)-\left(\phi_{t}^{m^{\prime}}\right)^{-1}(x)\right| \\
\leqslant & C\left\|v_{t}^{m}-v_{t}^{m^{\prime}}\right\|_{C^{2}\left(B_{N}\right)}+C\left\|v_{t}^{m^{\prime}}\right\|_{C^{2}\left(B_{N}\right)} \sup _{y \in B_{N}}\left|\phi_{t}^{m^{\prime}}(y)-\phi_{t}^{m}(y)\right| \\
\leqslant & C_{k}\left(\left\|u_{t}^{m}-u_{t}^{m^{\prime}}\right\|_{C^{2}\left(B_{N}\right)}+\left\|v_{t}^{m}-v_{t}^{m^{\prime}}\right\|_{C^{2}\left(B_{N}\right)}\right) .

## 5. appendix

In this section, we give some Lemmas used in the previous sections. The following basic result is useful.

Lemma 5.1. Let $f \in L^{1}\left(\mathbb{R}^{n} ; \mathcal{B}\right)+L^{\infty}\left(\mathbb{R}^{n} ; \mathcal{B}\right)$.
(1) (Bernstein's inequality) For any $k=0,1,2, \cdots$, there is a constant $C=C(n, k)>0$ such that for all $j=-1,0,1, \cdots$,

One can find the proof of above lemma in [1] for $\mathcal{B}=\mathbb{R}$. We present its Banach-valued version below for the reader's convenience.

& =\left\|\int_{B_{2^{k} \varepsilon}} \mathscr{F}^{-1}(\chi)(z)\left[f(x)-f\left(x-2^{-k} z\right)\right] \mathrm{d} z\right\|_{\mathcal{B}} \\
& \quad+\left\|\int_{B_{2^{k} \varepsilon}^{c}} \mathscr{F}^{-1}(\chi)(z)\left[f(x)-f\left(x-2^{-k} z\right)\right] \mathrm{d} z\right\|_{\mathcal{B}} \\
& \leqslant \operatorname{osc}_{B_{\varepsilon}(x)} f \cdot \int_{\mathbb{R}^{n}}\left|\mathscr{F}^{-1}(\chi)(y)\right| \mathrm{d} y+2\|f\|_{0} \int_{B_{2^{k} \varepsilon}^{c}}\left|\mathscr{F}^{-1}(\chi)(y)\right| \mathrm{d} y .
\end{aligned}
$$

Let $k \rightarrow \infty$ and then $\varepsilon \rightarrow 0$, we obtain that for each $f \in C_{b}\left(\mathbb{R}^{n} ; \mathcal{B}\right)$ and $x \in \mathbb{R}^{n}, f(x)=$ $\sum_{j \geqslant-1} \Delta_{j} f(x)$. Thus, for any $K>0$,

& \leqslant C_{\alpha}\left(|x-y| 2^{(1-\alpha) K}+C 2^{-\alpha K}\right) \sup _{j \geqslant-1} 2^{\alpha j}\left\|\Delta_{j} f\right\|_{0} .

For any $|x-y|<1$, by choosing $K=-\log _{2}(|x-y|)$, we obtain

So we complete our proof.

Suppose $f: \mathbb{R}^{n} \rightarrow \mathbb{R}^{n}$ is a continuous homeomorphism on $\mathbb{R}^{n}$, its inverse map is denoted by $f^{-1}$. Our next auxiliary lemma is used in the proof of Theorem 1.1.

Lemma 5.2. Suppose $(S ; \mathcal{S})$ is a measurable space, $F:\left(S \times \mathbb{R}^{n} ; \mathcal{S} \times \mathscr{B}\right) \rightarrow\left(\mathbb{R}^{n} ; \mathscr{B}\right)$.
(1) Assume $X$ is another measurable map from $(S ; \mathcal{S})$ to $\left(\mathbb{R}^{n} ; \mathscr{B}\right)$. Then the map $a \mapsto F(a, X(a))$ is measurable from $(S ; \mathcal{S})$ to $\left(\mathbb{R}^{n} ; \mathscr{B}\right)$.
(2) For any $L>0$ define

H_{L}:=\left\{f: \mathbb{R}^{n} \rightarrow \mathbb{R}^{n} \mid f\right. \text { is a continuous homeomorphism and } \\
\left.L^{-1}|x-y| \leqslant|f(x)-f(y)| \leqslant L|x-y|\right\} .
\end{gathered}
$$

If $F:\left(S \times \mathbb{R}^{n} ; \mathcal{S} \times \mathscr{B}\right) \rightarrow\left(\mathbb{R}^{n} ; \mathscr{B}\right)$ and for each $a \in S, F(a, \cdot) \in H_{L}$, then the map

F^{-1}: S \times \mathbb{R}^{n} \ni(a, x) \mapsto\left[F^{-1}(a, \cdot)\right](x) \in \mathbb{R}^{n}
$$

is $\mathcal{S} \times \mathscr{B} / \mathscr{B}$ measurable.
Proof. (1) This conclusion is trivial since the map $a \mapsto(a, X(a))$ is $\mathcal{S} / \mathcal{S} \times \mathscr{B}$ measurable.
(2). Define

So the map $\bar{F}:(S, \mathcal{S}) \rightarrow\left(H_{L}, \mathscr{B}\left(H_{L} ; d\right)\right)$ is measurable. Obviously, the map

is well-defined. Now assume $d\left(f_{n}, f\right) \rightarrow 0$. Given $x \in \mathbb{R}^{n}$, assume $y=f^{-1}(x)$, then

which implies $d\left(f_{n}^{-1}, f^{-1}\right) \leqslant C_{f, L} d\left(f_{n}, f\right) \rightarrow 0$. Thus, the map Inv : $H_{L} \rightarrow H_{L}$ is continuous. Hence, the map $\bar{F}^{-1}:=\operatorname{Inv} \circ \bar{F}$ from $(S, \mathcal{S})$ to $\left(H_{L}, \mathscr{B}\left(H_{L}\right)\right)$ is also measurable. As a consequence, the map

is $\mathcal{S} \times \mathscr{B} / \mathscr{B}$ measurable.
Roughly speaking, the above lemma shows that if $(a, x) \mapsto F(a, x)$ is measurable then $(a, x) \mapsto F^{-1}(a, \cdot)(x)$ is also measurable.

The following interpolation lemma is used several times in our paper.
Lemma 5.3. Let $0 \leqslant \gamma_{0}<\gamma_{1}<\gamma_{2}$ with $\gamma_{1} \notin \mathbb{N}$ and $\theta:=\left(\gamma_{2}-\gamma_{1}\right) /\left(\gamma_{2}-\gamma_{0}\right) \in(0,1)$, $Q_{T}=\mathbb{R}^{n} \times[0, T]$ and $\mathcal{B}$ be a Banach space. Then there is a constant $C>0$, such that for all $f \in C_{x, t}^{\gamma_{2}}$ with $\partial_{t} f \in C_{x, t}^{\gamma_{0}}$,

\frac{\left\|f_{t_{1}}-f_{t_{0}}\right\|_{C^{\gamma_{1}}}^{q}}{\left|t_{1}-t_{0}\right|^{\beta q-1}} & \leqslant C \int_{t_{0}}^{t_{1}} \int_{t_{0}}^{t_{1}} \frac{\left\|f_{t}-f_{s}\right\|_{C^{\gamma_{1}}}^{q}}{|t-s|^{1+\beta q}} \mathrm{~d} s \mathrm{~d} t \\
& \leqslant C \int_{t_{0}}^{t_{1}} \int_{t_{0}}^{t_{1}}\left\|f_{t}-f_{s}\right\|_{C^{\gamma_{0}}}^{\theta q}\left\|f_{t}-f_{s}\right\|_{C^{\gamma_{2}}}^{(1-\theta) q}|t-s|^{-1-\beta q} \mathrm{~d} s \mathrm{~d} t \\
& \leqslant C\left(\int_{t_{0}}^{t_{1}} \int_{t_{0}}^{t_{1}} \frac{|t-s|^{\theta q}}{|t-s|^{1+\beta q}} \mathrm{~d} s \mathrm{~d} t\right)\left\|\partial_{t} f\right\|_{C_{x, t}^{\gamma_{0}}}^{\theta q}\|u\|_{C_{x, t}}^{(1-\theta) q} \\
& =C\left|t_{1}-t_{0}\right|^{\theta q-\beta q+1}\left\|\partial_{t} f\right\|_{C_{x, t}^{\gamma_{0}}}^{\theta q}\|u\|_{C_{x, t}^{\gamma_{2}}}^{(1-\theta) q},
\end{aligned}
$$

which gives (5.3).
Lemma 5.4. Suppose $\beta \geqslant 0, \mathcal{H}$ is a real Hilbert space and $C_{x}^{\beta}=C^{\beta}\left(\mathbb{R}^{n} ; L^{p}(\Omega ; \mathcal{H})\right)$. Assume $\mathscr{G}$ is a subalgebra of $\mathscr{F}$, then

$$
\begin{equation*}
\|\mathbf{E}(X \mid \mathscr{G})\|_{C_{x}^{\beta}} \leqslant\|X\|_{C_{x}^{\beta}} . \tag{5.4}
\end{equation*}
$$

Moreover, for any $k \in \mathbb{N}$ with $k \leqslant \beta$,

$$
\begin{equation*}
\nabla^{k} \mathbf{E}(X(x) \mid \mathscr{G})=\mathbf{E}\left(\nabla^{k} X(x) \mid \mathscr{G}\right) \tag{5.5}
\end{equation*}
$$

Proof. We only prove (5.4) when $\beta \in(0,1)$. Denote $\mathbf{E}^{\mathscr{G}} X(\cdot):=\mathbf{E}(X(\cdot) \mid \mathscr{G})$, by Jensen's inequality,

$$
\begin{aligned}
& \quad \mathbf{E}\left|\mathbf{E}^{\mathscr{G}} X(x)-\mathbf{E}^{\mathscr{G}} X(y)\right|_{\mathcal{H}}^{p} \leqslant \mathbf{E}\left[\mathbf{E}^{\mathscr{G}}|X(x)-X(y)|_{\mathcal{H}}\right]^{p} \\
& \leqslant \mathbf{E}\left[\mathbf{E}^{\mathscr{G}}|X(x)-X(y)|_{\mathcal{H}}^{p}\right]=\mathbf{E}|X(x)-X(y)|_{\mathcal{H}}^{p} \leqslant|x-y|^{\beta p}\|X\|_{C_{x}^{\beta}}^{p},
\end{aligned}
$$

which yields

$$
\left\|\mathbf{E}^{\mathscr{G}} X\right\|_{C_{x}^{\beta}}=\sup _{x, y \in \mathbb{R}^{d}} \frac{\left[\mathbf{E}\left|\mathbf{E}^{\mathscr{G}} X(x)-\mathbf{E}^{\mathscr{G}} X(y)\right|_{\mathcal{H}}^{p}\right]^{1 / p}}{|x-y|^{\beta}} \leqslant\|X\|_{C_{x}^{\beta}} .
$$

For (5.5), we only give the proof for $k=1$. Again by Jensen's inequality,

$$
\begin{aligned}
& \left|\mathbf{E}^{\mathscr{G}} X(x+h)-\mathbf{E}^{\mathscr{G}} X(x)-\left[\mathbf{E}^{\mathscr{G}} \nabla X(x)\right] \cdot h\right|_{\mathcal{H}} \\
\leqslant & \mathbf{E}^{\mathscr{G}}|X(x+h)-X(x)-\nabla X(x) \cdot h|_{\mathcal{H}} .
\end{aligned}
$$

Thus,

$$
\begin{aligned}
& \mathbf{E}\left|\mathbf{E}^{\mathscr{G}} X(x+h)-\mathbf{E}^{\mathscr{G}} X(x)-\left[\mathbf{E}^{\mathscr{G}} \nabla X(x)\right] \cdot h\right|_{\mathcal{H}}^{p} \\
\leqslant & \mathbf{E} \mathbf{E}^{\mathscr{G}}\left(|X(x+h)-X(x)-\nabla X(x) \cdot h|_{\mathcal{H}}^{p}\right) \\
= & |X(x+h)-X(x)-\nabla X(x) \cdot h|_{\mathcal{B}}^{p} \rightarrow 0(h \rightarrow \infty),
\end{aligned}
$$

which gives the desired result.

Lemma 5.5. Suppose $f: \mathbb{R}^{n} \times \Omega \rightarrow \mathbb{R}^{m}$ is $\mathscr{B} \times \mathscr{F}$ measurable and $f \in C^{1}\left(\mathbb{R}^{n} ; \mathbb{D}^{1, p}\right)$, then $\nabla f \in C\left(\mathbb{R}^{n} ; \mathbb{D}^{1, p}\right)$ and

$$
\begin{equation*}
\nabla D f=D \nabla f \tag{5.6}
\end{equation*}
$$

Proof. We assume $n=m=1$ for simple. For any $x \in \mathbb{R}$, by definition

$$
\partial_{x, \theta} f(x):=\frac{f(x+\theta)-f(x)}{\theta} \xrightarrow{L^{p}(\Omega)} \partial_{x} f(x)(\theta \rightarrow 0) .
$$

On the other hand, since $D f \in C^{1}\left(\mathbb{R} ; L^{p}(\Omega, H)\right)$, we have

$$
D \partial_{x, \theta} f(x)=\frac{D f(x+\theta)-D f(x)}{\theta} \xrightarrow{L^{p}(\Omega ; H)} \partial_{x}(D f)(x)(\theta \rightarrow 0) .
$$

By the closability of Mallivian derivate, we get $D \partial_{x} f(x)=\partial_{x} D f(x) \in \mathbb{D}^{1, p}$ and

$$
\left\|\partial_{x} f(x)\right\|_{\mathbb{D}^{1, p}}=\liminf _{|\theta| \rightarrow 0}\left\|\frac{f(x+\theta)-f(x)}{\theta}\right\|_{\mathbb{D}^{1}, p} \leqslant\|f\|_{C^{1}\left(\mathbb{R} ; \mathbb{D}^{1, p}\right)} .
$$

For any $F \in \mathbb{D}^{1,2}$, we have the following remarkable Clark-Ocone formula,

$$
\begin{equation*}
F=\mathbf{E}(F)+\int_{0}^{1} \mathbf{E}^{t} D_{t} F \cdot d W_{t}:=\mathbf{E}(F)+\sum_{k=1}^{d} \int_{0}^{1} \mathbf{E}\left(D_{t}^{k} F \mid \mathscr{F}_{t}\right) d W_{t}^{k} . \tag{5.7}
\end{equation*}
$$

(5.7) implies the following simple lemma.

Lemma 5.6. Suppose $F \in \mathbb{D}^{1,2}$, then for each $t \in[0,1]$,

$$
\begin{equation*}
\mathbf{E}^{t} F=\mathbf{E} F+\int_{0}^{t} \mathbf{E}^{s} D_{s} F \cdot \mathrm{~d} W_{s} \tag{5.8}
\end{equation*}
$$

Proof. By Clark-Ocone's formula,

$$
m_{t}=\mathbf{E} F+\int_{0}^{t} \mathbf{E}^{s} D_{s} F \cdot \mathrm{~d} W_{s}
$$

is a $\mathscr{F}_{t}$-martingale with $m_{1}=F$. Thus,

$$
\mathbf{E}^{t} F=\mathbf{E}^{t} m_{1}=m_{t}=\mathbf{E} F+\int_{0}^{t} \mathbf{E}^{s} D_{s} F \cdot \mathrm{~d} W_{s}
$$

The following Lemma is a modification of Theorem 1.1 in [13], which is need in our proof of main result. Similar result on distributional valued processes can be found in [10].

Lemma 5.7 (Itô-Wentzell's formula). Let $\left(\Omega, \mathscr{F}, \mathscr{F}_{t}, \mathbf{P}\right)$ be a standard filtered probability space satisfying the common conditions, $p, p^{\prime} \in[1, \infty]$ with $\frac{1}{p}+\frac{1}{p^{\prime}}=1$ and $\alpha_{1}, \alpha_{2} \in(0,1)$ with $\alpha_{1}+\alpha_{2}>1$. Suppose $X_{t}=\left(X_{t}^{1}, \cdots, X_{t}^{n}\right)$ be continuous semimartingales and $\phi_{t}(x)$ be a random field continuous in $(x, t) \in Q$ almost surely. Assume $\phi$ and $X$ satisfy
(1) for each $t \in[0,1], \mathbb{R}^{n} \ni x \mapsto \phi_{t}(x) \in \mathbb{R}$ is $C^{2}$ continuous a.s.,
(2) for each $x \in \mathbb{R}^{n}, t \mapsto \phi_{t}(x)$ is a continuous $\mathscr{F}_{t}$-semimartingale represented as

$$
\begin{equation*}
\phi_{t}(x)=\phi_{0}(x)+\int_{0}^{t} g_{s}(x) \mathrm{d} s+\int_{0}^{t} v_{s}^{k}(x) \mathrm{d} m_{s}^{k}, \tag{5.9}
\end{equation*}
$$

where $m^{1}, \cdots, m^{d}$ are continuous martingales, and the random field $g, v$ are locally bounded and
(a) for each $x \in \mathbb{R}^{n}, t \mapsto g_{t}(x)$ and $t \mapsto v_{t}(x)$ are $\mathscr{F}_{t}$-adapted processes;
(b) for each $t \in[0,1], x \mapsto v_{t}(x)$ is $C^{1}$ a.s.;
(c) for each $t \in[0,1], x \mapsto g_{t}(x)$ is continuous,

$$
\begin{aligned}
& \mathbf{E} \sup _{x \in B_{N}}\left|\nabla \int_{t_{1}}^{t_{2}} g_{s}(x) \mathrm{d} s\right|^{p} \lesssim_{p, N}\left|t_{1}-t_{2}\right|^{\alpha_{1} p}, \\
& \mathbf{E}\left|X_{t_{1} \wedge \tau_{N}}-X_{t_{2} \wedge \tau_{N}}\right|^{p^{\prime}} \lesssim_{p^{\prime} N}\left|t_{1}-t_{2}\right|^{\alpha_{2} p^{\prime}},
\end{aligned}
$$

$$
\text { where } \tau_{N}=\inf \left\{t>0:\left|X_{t}\right|>N\right\} .
$$

Then we have

$$
\begin{align*}
d \phi_{t}\left(X_{t}\right)= & g_{t}\left(X_{t}\right) \mathrm{d} t+v_{t}^{k}\left(X_{t}\right) \mathrm{d} m_{t}^{k}+\partial_{i} \phi_{t}\left(X_{t}\right) \mathrm{d} X_{t}^{i} \\
& +\frac{1}{2} \partial_{i j} \phi_{t}\left(X_{t}\right) \mathrm{d}\left\langle X^{i}, X^{j}\right\rangle_{t}+\partial_{i} v_{t}^{k}\left(X_{t}\right) \mathrm{d}\left\langle m^{k}, X^{i}\right\rangle_{t} \tag{5.10}
\end{align*}
$$

Proof. The proof is similar with Theorem 1.1 of [13]. Without loss of generality, we can assume $\left|X_{t}\right|$ is bounded by a constant $N$. For any $t>0$, let $t_{l}=l t / n, l=0, \cdots, n$. $s(n):=t[s n / t] / n$ and $X_{s}^{n}:=X_{s(n)}$. Then,

$$
\begin{aligned}
\phi_{t}\left(X_{t}\right)-\phi_{0}\left(X_{0}\right) & =\sum_{l=0}^{n-1}\left[\phi_{t_{l+1}}\left(X_{t_{l}}\right)-\phi_{t_{l}}\left(X_{t_{l}}\right)\right]+\sum_{l=0}^{n-1}\left[\phi_{t_{l+1}}\left(X_{t_{l+1}}\right)-\phi_{t_{l+1}}\left(X_{t_{l}}\right)\right] \\
& =: I_{1}^{n}+I_{2}^{n} .
\end{aligned}
$$

By (5.9) and the definition of $X^{n}$

$$
I_{1}^{n}=\sum_{l=0}^{n-1} \int_{t_{l}}^{t_{l+1}} g_{s}\left(X_{t_{l}}\right) \mathrm{d} s+\sum_{l=0}^{n-1} \int_{t_{l}}^{t_{l+1}} v_{s}^{k}\left(X_{t_{l}}\right) \mathrm{d} m_{s}^{k}=\int_{0}^{t} g_{s}\left(X_{s}^{n}\right) \mathrm{d} s+\int_{0}^{t} v_{s}^{k}\left(X_{s}^{n}\right) \mathrm{d} m_{s}^{k}
$$

Since $g_{s}\left(X_{s}^{n}\right) \rightarrow g_{s}\left(X_{s}\right), v_{s}\left(X_{s}^{n}\right) \rightarrow v_{s}\left(X_{s}\right)$ a.s. and $g, v$ are uniformly bounded in $[0,1] \times$ $B_{N}$, we obtain

$$
I_{1}^{n} \xrightarrow{\mathbf{P}} \int_{0}^{t} g_{s}\left(X_{s}\right) \mathrm{d} s+\int_{0}^{t} v_{s}^{k}\left(X_{s}\right) \mathrm{d} m_{s}^{k},(n \rightarrow \infty) .
$$

By Taylor expansion,

$$
\begin{aligned}
I_{2}^{n} & =\sum_{l=0}^{n-1} \partial_{i} \phi_{t_{l+1}}\left(X_{t_{l}}\right)\left(X_{t_{l+1}}^{i}-X_{t_{l}}^{i}\right)+\frac{1}{2} \sum_{l=0}^{n-1} \partial_{i j} \phi_{t_{l+1}}\left(\xi_{l}\right)\left(X_{t_{l+1}}^{i}-X_{t_{l}}^{i}\right)\left(X_{t_{l+1}}^{j}-X_{t_{l}}^{j}\right) \\
& =: I_{21}^{n}+I_{22}^{n}
\end{aligned}
$$

where $\xi_{l}$ are some random variables between $X_{t_{l}}$ and $X_{t_{l+1}}$. It is standard to show that

$$
I_{22}^{n} \xrightarrow{\mathbf{P}} \frac{1}{2} \int_{0}^{t} \partial_{i j} \phi_{s}\left(X_{s}\right) \mathrm{d}\left\langle X^{i}, X^{j}\right\rangle_{s}, \quad(n \rightarrow \infty) .
$$

For $I_{21}^{n}$, we rewrite it as

$$
\begin{aligned}
I_{21}^{n} & =\sum_{i=0}^{n-1} \partial_{i} \phi_{t_{l}}\left(X_{t_{l}}\right)\left(X_{t_{l+1}}^{i}-X_{t_{l}}^{i}\right)+\sum_{l=0}^{n-1}\left[\partial_{i} \phi_{t_{l+1}}\left(X_{t_{l}}\right)-\partial_{i} \phi_{t_{l}}\left(X_{t_{l}}\right)\right]\left(X_{t_{l+1}}^{i}-X_{t_{l}}^{i}\right) \\
& =: I_{211}^{n}+I_{212}^{n} .
\end{aligned}
$$

Like before,

$$
I_{211}^{n} \xrightarrow{\mathbf{P}} \int_{0}^{t} \partial_{i} \phi_{s}\left(X_{s}\right) \mathrm{d} X_{s}^{i}, \quad(n \rightarrow \infty) .
$$

Again by (5.9),

$$
\begin{aligned}
I_{212}^{n} & =\sum_{l=0}^{n-1} \partial_{i}\left(\int_{t_{l}}^{t_{l+1}} g_{s}\left(X_{t_{l}}\right) \mathrm{d} s\right)\left(X_{t_{l+1}}^{i}-X_{t_{l}}^{i}\right)+\sum_{l=0}^{n-1}\left(\int_{t_{l}}^{t_{l+1}} \partial_{i} v_{s}^{k}\left(X_{t_{l}}\right) \mathrm{d} m_{s}^{k}\right)\left(X_{t_{l+1}}^{i}-X_{t_{l}}^{i}\right) \\
& =: I_{2121}^{n}+I_{2122}^{n} .
\end{aligned}
$$

By our assumption (c) and Hölder inequality,

$$
\begin{aligned}
\mathbf{E}\left|I_{2121}^{n}\right| & \lesssim \sum_{l=0}^{n-1}\left[\mathbf{E} \sup _{x \in B_{N}}\left|\nabla \int_{t_{l+1}}^{t_{l}} g_{s}(x) \mathrm{d} s\right|^{p}\right]^{1 / p}\left[\mathbf{E}\left|X_{t_{l+1}}-X_{t_{l}}\right|^{p^{\prime}}\right]^{1 / p^{\prime}} \\
& \lesssim \sum_{l=0}^{n-1}\left|t_{l+1}-t_{l}\right|^{\alpha_{1}+\alpha_{2}} \lesssim n^{-\alpha_{1}-\alpha_{2}+1} \rightarrow 0, \quad(k \rightarrow \infty)
\end{aligned}
$$

It is standard to show

$$
I_{2122}^{n} \xrightarrow{\mathbf{P}} \int_{0}^{t} \partial_{i} v^{k}\left(X_{s}\right) \mathrm{d}\left\langle m^{k}, X^{i}\right\rangle_{s}, \quad(k \rightarrow \infty) .
$$

Combine all the above calculations, we obtain (5.10).
