Analysis of a Helmholtz preconditioning problem motivated by uncertainty quantification

Abstract

This paper analyses the following question: let \mathbf{A}_j , j = 1, 2, be the Galerkin matrices corresponding to finite-element discretisations of the exterior Dirichlet problem for the heterogeneous Helmholtz equations $\nabla \cdot (A_j \nabla u_j) + k^2 n_j u_j = -f$. How small must $||A_1 - A_2||_{L^q}$ and $||n_1 - n_2||_{L^q}$ be (in terms of k-dependence) for GMRES applied to either $(\mathbf{A}_1)^{-1}\mathbf{A}_2$ or $\mathbf{A}_2(\mathbf{A}_1)^{-1}$ to converge in a k-independent number of iterations for arbitrarily large k? (In other words, for \mathbf{A}_1 to be a good left- or right-preconditioner for \mathbf{A}_2 ?). We prove results answering this question, give theoretical evidence for their sharpness, and give numerical experiments supporting the estimates.

Our motivation for tackling this question comes from calculating quantities of interest for the Helmholtz equation with *random* coefficients A and n. Such a calculation may require the solution of many deterministic Helmholtz problems, each with different A and n, and the answer to the question above dictates to what extent a previously-calculated inverse of one of the Galerkin matrices can be used as a preconditioner for other Galerkin matrices.

Keywords: Helmholtz equation, preconditioning, heterogeneous, variable wave speed, high frequency, uncertainty quantification.

1 Introduction

1.1 Statement of the problem

Let $D_{-} \subset \mathbb{R}^{d}, d = 2, 3$, be a bounded Lipschitz open set such that the open complement $D_{+} := \mathbb{R}^{d} \setminus \overline{D_{-}}$ is connected. Given f with compact support and coefficients $A_{j}, n_{j}, j = 1, 2$, let $u_{j}, j = 1, 2$, satisfy the heterogeneous Helmholtz equation

$$\nabla \cdot (A_j \nabla u_j) + k^2 n_j u_j = -f \quad \text{in } D_+, \tag{1.1}$$

the Dirichlet boundary condition $u_i = 0$ on $\Gamma := \partial D_-$, and the Sommerfeld radiation condition

$$\frac{\partial u_j}{\partial r}(\mathbf{x}) - \mathrm{i}ku_j(\mathbf{x}) = o\left(\frac{1}{r^{(d-1)/2}}\right) \tag{1.2}$$

as $r := \|\mathbf{x}\|_2 \to \infty$ (uniformly in $\hat{\mathbf{x}} := \mathbf{x}/r$), where k > 0 is the wavenumber; in this paper, we are interested in the case when the wavenumber is arbitrarily large. In Equation (1.1) the obstacle D_{-} and the coefficients A_j and n_j satisfy the natural conditions for the scattering problem to make sense; see Assumption 3.1 and Definition 3.2 (to present the main results as close to the beginning of the paper as possible, we postpone to §3 the precise definitions of the Helmholtz problem, the finite-element method, and GMRES).

Let \mathbf{A}_j , j = 1, 2, be the Galerkin matrices corresponding to the *h*-version finite-element discretisations (with decreasing mesh size *h* and any fixed polynomial degree *p*) of (1.1) truncated to $D := D_+ \cap \widetilde{D}$, where \widetilde{D} is some open set containing D_- (the simplest case is when $\widetilde{D} = B_R := {\mathbf{x} : ||\mathbf{x}||_2 < R}$ for some sufficiently large *R*). We consider the cases where *either* the radiation condition is realised exactly on $\partial \widetilde{D}$ via the exact Dirichlet-to-Neumann (DtN) map *or* the DtN map is approximated on $\partial \widetilde{D}$ by an impedance boundary condition (a.k.a. a first-order absorbing boundary condition). See (3.10) for the precise definitions of \mathbf{A}_j , j = 1, 2, and Definition 3.2 and Remark 3.3 for the truncation procedure.

This paper considers the following question:

Q1. How small must $||A_1 - A_2||_{L^q}$ and $||n_1 - n_2||_{L^q}$ be (in terms of k-dependence) for the generalised minimum residual method (GMRES) applied to either $(\mathbf{A}_1)^{-1}\mathbf{A}_2$ or $(\mathbf{A}_2)^{-1}\mathbf{A}_1$ to converge in a k-independent number of iterations for arbitrarily large k?

Before stating results answering Q1 in §2 we describe our motivation for studying Q1.

1.2 Motivation from uncertainty quantification of the Helmholtz equation

Consider the Helmholtz equation

$$\nabla \cdot \left(A(\mathbf{x};\omega) \nabla u(\mathbf{x},\omega) \right) + k^2 n(\mathbf{x};\omega) u(\mathbf{x};\omega) = -f(\mathbf{x}), \quad \mathbf{x} \in D_+,$$
(1.3)

where $A(\mathbf{x}; \omega)$ and $n(\mathbf{x}; \omega)$ are random fields, and ω is an element of an underlying probability space. Suppose Q(u) is a functional of the solution of (1.3) (usually called a quantity of interest). In the forward problem of uncertainty quantification (UQ), one task is to compute $\mathbb{E}[Q(u)]$, and the arguably simplest way to do this uses sampling, i.e. using the approximation

$$\mathbb{E}[Q(u)] \approx \frac{1}{N} \sum_{\ell=1}^{N} Q(u(\omega_{\ell})), \qquad (1.4)$$

where the ω_{ℓ} are elements of the sample space Ω . To calculate the right-hand side of (1.4), one must solve many deterministic Helmholtz problems, corresponding to different samples ω_{ℓ} , i.e. corresponding to different realisations of the coefficients $A(\cdot, \omega)$ and $n(\cdot, \omega)$. Solving all these deterministic problems is a very computationally-intensive task because linear systems arising from discretisations of the Helmholtz equation are notoriously difficult to solve; this difficulty is due to the following three reasons:

- (a) The solutions of the homogeneous Helmholtz equation $\Delta u + k^2 u = 0$ oscillate on a scale of 1/k, and so to approximate them accurately with piecewise-polynomial functions one needs the total number of degrees of freedom, N, to be proportional to k^d as k increases.
- (b) The *pollution effect* means that, for fixed-order finite-element methods, having $N \sim k^d$ is still not enough to keep the relative finite-element error bounded independently of k as k increases (see the references in §4.3 for how N must depend on k).
- (c) When iterative methods such as GMRES are applied to the linear system $\mathbf{Au} = \mathbf{f}$, the number of iterations grows with k. Part of the explanation for this is that the standard variational formulation of the Helmholtz equation is not coercive (i.e. it is sign-indefinite) when k is sufficiently large, and this indefiniteness is inherited by the Galerkin linear system. The design of good preconditioners for discretisations of the Helmholtz equation is therefore a very active area of research; see, e.g., the literature reviews in [35, §1.3], [27, §4].

The question therefore arises of how to compute $Q(u(\omega_{\ell}))$, $\ell = 1, ..., N$, in an efficient way. To simplify the discussion, initially suppose that one calculates the LU factorisation of the Galerkin matrix for one realisation of the coefficients A and n. The answer to Q1 above makes k-explicit the extent to which this factorisation can be used as an effective preconditioner for Galerkin matrices arising from different realisations of A and n. The benefit of "reusing" an LU factorisation in this way can be seen by recalling that direct solvers involving the LU decomposition of the linear system have a computational cost of the order $\mathcal{O}(N^{3/2})$ in 2-d [15, Section 1] and $\mathcal{O}(N^2)$ in 3-d [15, Equation 3], with this analysis assuming sufficient grid regularity. However, if one already has computed the LU decomposition, then the cost of applying backsolves using it is much cheaper; $\mathcal{O}(N \log N)$ in 2-d [15, Section 1] and $\mathcal{O}(N^{4/3})$ in 3-d [15, Equation 4], hence the LU decomposition of **A** could be efficiently used as a preconditioner for matrices "near" **A**.

More generally, for *any* preconditioner for the Helmholtz equation, one could ask when the preconditioner corresponding to one realisation of (1.3) can be re-used for other realisations. The answer to Q1 does not answer this more-complicated scenario, but forms the first step in analysing it.

In §2.4 we discuss the implications of our answer to Q1 on such a preconditioning strategy. However, we highlight that to perform a complete k-explicit analysis of this type of preconditioning strategy applied to computing $\mathbb{E}[Q(u)]$, in addition to the answer to Q1, one also needs the answers to the following two questions.

Q2 How must the number of samples, N, depend on k for the error

$$\left| \mathbb{E}[Q(u)] - \frac{1}{N} \sum_{\ell=1}^{N} Q(u(\omega_{\ell})) \right|$$
(1.5)

to be controllably small, independent of k, for arbitrarily large k?

Q3 How do $||A(\cdot, \omega_{\ell_1}) - A(\cdot, \omega_{\ell_2})||$ and $||n(\cdot, \omega_{\ell_1}) - n(\cdot, \omega_{\ell_2})||$ depend on $\omega_{\ell_1}, \omega_{\ell_2}$? In standard UQ applications, the random fields are parametrised in terms of vectors of i.i.d. random variables $\mathbf{y}(\omega)$. In this context $A(\cdot, \omega)$, $n(\cdot, \omega)$ may be written as $A(\cdot, \mathbf{y}(\omega))$, $n(\cdot, \mathbf{y}(\omega))$; this question then asks how "closeness" in parameter space (measured by $||\mathbf{y}(\omega_{\ell_1}) - \mathbf{y}(\omega_{\ell_2})||$) translates to "closeness" in coefficient space.

We do not address these two questions in this paper, but remark that (i) the recent paper [28] gives results related to Q2 for a non-standard variational formulation of the heterogeneous Helmholtz equation given in [29] (based on the formulation for the homogeneous Helmholtz equation introduced in [48]), and (ii) the answer to Q3 follows from the specific structure of the randomness assumed in the coefficients A and n.

1.3 Novelty of the main results

To our knowledge, this paper is the first time that preconditioning a discretisation of the heterogeneous Helmholtz equation with a discretisation corresponding to a Helmholtz problem with "nearby" coefficients has been analysed.

This paper is part of a growing body of work on the analysis and numerical analysis of the heterogeneous Helmholtz equation, with the analysis explicit in both the wavenumber and the coefficients [12, 25, 31, 32, 33, 43, 49, 53, 62]. Indeed, our main results (Theorems 2.2, 2.3, 2.9, and 2.10) are proved under Conditions 4.1 and 4.2, and these other works give sufficient conditions for Conditions 4.1 and 4.2 to hold; see §4.2 and §4.3.

Furthermore, we believe that the idea of preconditioning with "nearby" coefficients will be relevant to other PDEs with random coefficients (this technique can then then be seen as a generalisation of the mean-based preconditioning discussed in $\S2.4$). We expect that the ideas in our analysis – in particular Lemmas 5.7 and 5.8 which combine bounds on the continuous problem and on the finite-element error to prove bounds on preconditioned matrices – would then be useful in analysing such strategies.

Outline of the paper. §2 states the main results and gives supporting numerical experiments. §3 gives the precise definitions of the Helmholtz boundary value problem, its finite-element solution, and weighted GMRES. §4 give the precise definitions of the conditions under which the main results hold. §5 and §6 prove the main results.

2 Statement of the main results

We state in §2.1 the results obtained when the differences $A_1 - A_2$ and $n_1 - n_2$ are measured in the L^{∞} norm (Theorems 2.2 and 2.3). We discuss in §2.2 the sharpness of these results. We then state in §2.3 generalisations of Theorems 2.2 and 2.3 where the differences are measured in the L^q norm for $2 < q \leq \infty$ (Theorems 2.9 and 2.10). We discuss in §2.4 the implications of these results for calculating quantities of interest of the Helmholtz equation with random coefficients (following on from the discussion in §1.2).

We consider both standard GMRES (which uses the Euclidean norm $\|\cdot\|_2$ on vectors) and weighted GMRES, a short description of which is given in §3. In weighted GMRES, we use the weighted vector norms $\|\cdot\|_{\mathbf{D}_k}$ and $\|\cdot\|_{\mathbf{D}_k^{-1}}$ defined by

$$\|\mathbf{v}\|_{\mathbf{D}_{k}}^{2} := (\mathbf{D}_{k}\mathbf{v}, \mathbf{v})_{2} \quad \text{and} \quad \|\mathbf{v}\|_{\mathbf{D}_{k}^{-1}}^{2} := (\mathbf{D}_{k}^{-1}\mathbf{v}, \mathbf{v})_{2}$$
(2.1)

where

$$\mathbf{D}_k := \mathbf{S}_I + k^2 \mathbf{M}_1,$$

with \mathbf{S}_I is the standard stiffness matrix for the finite-element discretisation of the Laplacian, and \mathbf{M}_1 is the mass matrix – see (3.9) for a precise definition. The key point is that, for a finite-element function $v_h = \sum_i v_i \phi_i$,

$$\|\mathbf{v}\|_{\mathbf{D}_{k}}^{2} = \|v_{h}\|_{H_{k}^{1}(D)}^{2} := \|\nabla v_{h}\|_{L^{2}(D)}^{2} + k^{2}\|v_{h}\|_{L^{2}(D)}^{2}$$

$$(2.2)$$

where \mathbf{v} is the vector with *i*th entry v_i ; i.e., $\|\cdot\|_{\mathbf{D}_k}$ is the norm on the finite-element space induced by the weighted H^1 norm $\|\cdot\|_{H^1_k(D)}$ in which the PDE analysis of the Helmholtz equation naturally takes place. (Results about convergence of domain-decomposition methods in the norms (2.1) were recently obtained for the Helmholtz equation in [34, 35, 31] and for the time-harmonic Maxwell equations in [7].) We further define $\|A\|_{L^{\infty}(D; \operatorname{op})} := \operatorname{ess\,sup}_{\mathbf{x}\in D} \|A(\mathbf{x})\|_2$, where here $\|\cdot\|_2$ denotes the *spectral/operator* norm on matrices, induced by the Euclidean norm $\|\cdot\|_2$ on vectors.

To make the statements of the main results more concise, we make the following definition for weighted/standard GMRES.

Definition 2.1 We say that GMRES applied to $\mathbf{Cu} = \mathbf{f}$, with zero starting guess and in a norm $\|\cdot\|$ on \mathbb{C}^n , converges in a k-independent number of iterations if, given $\varepsilon > 0$ and $k_0 > 0$, there exists $C_1(\varepsilon, k_0) > 0$ and $C_2(k_0) > 0$, both independent of k, h, and p, such that

if
$$m \ge C_1$$
 then $\frac{\|\mathbf{u}^m - \mathbf{u}\|}{\|\mathbf{u}\|} \le C_2 \varepsilon$, for all $k \ge k_0$

In this paper we only consider GMRES in one of the three norms $\|\cdot\|$, $\|\cdot\|_{\mathbf{D}_k}$, and $\|\cdot\|_{\mathbf{D}_k^{-1}}$ (with the last two defined in (2.1)).

2.1 Results on Q1 involving $||A_1 - A_2||_{L^{\infty}}$ and $||n_1 - n_2||_{L^{\infty}}$

These results are proved under Conditions 4.1 and 4.2. These conditions can be informally stated, respectively, as

- the obstacle D_{-} and the coefficients A_j and n_j are such that u_j exists, is unique, and the problem is *nontrapping* (in the sense described in §4.2), and
- the meshsize h and polynomial degree p in the finite-element method are chosen to depend on k to ensure that the finite-element approximation to the solution of the problem with coefficients A_j and n_j exists, is unique, and has bounded error in the H_k^1 -norm (defined in (2.12)) as $k \to \infty$.

Theorem 2.2 (Answer to Q1: k-independent weighted GMRES iterations) Assume that

• D_{-} , A_{j} , and n_{j} , j = 1, 2, satisfy Condition 4.1, and

• D_{-} , A_j , n_j , j = 1, 2, h and p, satisfy Condition 4.2.

Given $k_0 > 0$, there exist $C_1, C_2 > 0$ independent of h and k (but dependent on D_-, A_1, n_1, p , and k_0) such that if

$$C_{1} k \left\| A_{1} - A_{2} \right\|_{L^{\infty}(D; \mathrm{op})} + C_{2} k \left\| n_{1} - n_{2} \right\|_{L^{\infty}(D; \mathbb{R})} \leq \frac{1}{2}$$

$$(2.3)$$

for all $k \ge k_0$, then both weighted GMRES working in the vector norm $\|\cdot\|_{\mathbf{D}_k}$ (and the associated inner product) applied to

$$(\mathbf{A}_1)^{-1}\mathbf{A}_2\mathbf{u} = (\mathbf{A}_1)^{-1}\mathbf{f}$$
(2.4)

and weighted GMRES working in the vector norm $\|\cdot\|_{(\mathbf{D}_k)^{-1}}$ (and the associated inner product) applied to

$$\mathbf{A}_2(\mathbf{A}_1)^{-1}\mathbf{v} = \mathbf{f} \tag{2.5}$$

with initial guess the zero vector converge in a k-independent number of iterations (in the sense of Definition 2.1) for all $k \ge k_0$.

Theorem 2.3 (Answer to Q1: k-independent standard GMRES iterations) Assume that

- D_- , A_j , and n_j , j = 1, 2, satisfy Condition 4.1, and
- D_{-} , A_j , n_j , j = 1, 2, h and p, satisfy Condition 4.2.

Given $k_0 > 0$, let C_1 and C_2 be as in Theorem 2.2, and let s_+ and m_{\pm} be as in Lemma 5.1 (note that all of these constants are independent of k and h). Then if

$$C_1\left(\frac{s_+}{m_-}\right)\frac{1}{h}\|A_1 - A_2\|_{L^{\infty}(D;\mathrm{op})} + C_2\left(\frac{m_+}{m_-}\right)k\|n_1 - n_2\|_{L^{\infty}(D;\mathbb{R})} \le \frac{1}{2}$$
(2.6)

for all $k \ge k_0$, then standard GMRES (working in the Euclidean norm and inner product) applied to either of the equations (2.4) or (2.5) with initial guess the zero vector converge in a k-independent number of iterations (in the sense of Definition 2.1) for all $k \ge k_0$.

We make the following remarks.

- (a) The constants C_1 and C_2 are given explicitly in (5.6) and (5.7) in terms of
 - $-C_{\text{bound}}^{(1)}$ given in Condition 4.1,
 - $C_{\text{FEM1}}^{(1)}$ and $C_{\text{FEM2}}^{(1)}$ given in Condition 4.2,
 - $-n_{1\max}$, $n_{1\min}$, and $A_{1\min}$ given in (3.1) and (3.2) (with *n* replaced by n_1 and *A* replaced by A_1),
- (b) The constant 1/2 on the right-hand sides of (2.3) and (2.6) can be replaced by any number < 1 and the overall result that GMRES converges in a k-independent number of iterations still holds, although the actual number of GMRES iterations depends on this number (but not on k).
- (c) If $A_1 = A_2$, then only Part 1 of Condition 4.2 is needed. If $n_1 = n_2$, then only Part 2 of Condition 4.2 is needed.
- (d) When $h \sim k^{-1}$, the bounds (2.3) and (2.6) are identical in their k-dependence; however, when $h \ll k^{-1}$ (as one needs to take to overcome the pollution effect, as discussed in §4.3) and $A_1 \neq A_2$, the bound (2.6) for standard GMRES is more pessimistic than the bound (2.3) for weighted GMRES.
- (e) Because of the discrepancy when A₁ ≠ A₂ between our bound for standard GMRES and our bound for weighted GMRES, we include the following lemma relating standard and weighted GMRES. This result is based on [31, Corollary 5.8, Part (ii)], and shows that if the condition (2.3) for k-independent convergence of weighted GMRES holds, then standard GMRES takes at most ~ log k additional iterations to ensure the same error guaranteed for weighted GMRES by Theorem 2.2.

Lemma 2.4 (Bound on standard GMRES from condition on weighted GMRES) Given $k_0 > 0$, assume that (2.3) holds (so that weighted GMRES with initial guess the zero vector converges in a k-independent number of iterations). If $h = Ck^{-1-\delta}$ with $\delta \ge 0$, then there exists C > 0, depending only on s_+, m_{\pm}, C, δ , and k_0 , such that if standard GMRES is applied to the linear system (2.4) with initial guess the zero vector, and

$$m \ge \left(\log\left(\frac{3}{2\sqrt{2}}\right)\right)^{-1} \left(\log\left(\frac{1}{\varepsilon}\right) + \gamma \log k + \mathcal{C}\right), \tag{2.7}$$

then

$$\frac{\|\mathbf{u}^m - \mathbf{u}\|_2}{\|\mathbf{u}\|_2} \le \frac{9}{4}\varepsilon, \quad \text{for all } k \ge k_0.$$
(2.8)

This result is not of the same form as Theorems 2.2 and 2.3, which give sufficient conditions for weighted/standard GMRES to converge in a k-independent number of iterations (in the sense of Definition 2.1). To better understand Lemma 2.4, we observe that the proof of Theorem 2.2 (see §5.3) shows that, given $k_0 > 0$, if (2.3) holds, and

if
$$m \ge \left(\log\left(\frac{3}{2\sqrt{2}}\right)\right)^{-1} \log\left(\frac{1}{\varepsilon}\right)$$
, then $\frac{\|\mathbf{u}^m - \mathbf{u}\|_{\mathbf{D}_k}}{\|\mathbf{u}\|_{\mathbf{D}_k}} \le \frac{9}{4}\varepsilon$ for all $k \ge k_0$. (2.9)

Comparing (2.7)-(2.8) and (2.9), we see that Lemma 2.4 guarantees the same error for standard GMRES as Theorem 2.2 guarantees for weighted GMRES, with the conditions on m showing at most $\sim \log k$ additional iterations are required for standard GMRES. This result indicates (but does not prove) that the factor h^{-1} on the left-hand side of (2.6) is suboptimal, and we expect the result of Theorem 2.3 holds if this factor is replaced by k (as in (2.3)).

Remark 2.5 (Sufficient conditions for the relative residual to be controllably small)

Theorems 2.2 and 2.3 give sufficient conditions for GMRES to converge in a k-independent number of iterations in the sense of Definition 2.1. These conditions are also sufficient for the GMRES relative residual to be controllably small, independent of k, in the sense that, given $\varepsilon > 0$ and $k_0 > 0$, there exists $C_1(\varepsilon, k_0) > 0$ and $C_2(k_0) > 0$, both independent of k, h, and p, such that

if
$$m \ge C_1$$
 then $\frac{\|\mathbf{r}^m\|}{\|\mathbf{r}^0\|} \le C_2 \varepsilon$, for all $k \ge k_0$. (2.10)

Indeed, the proofs of Theorems 2.2 and 2.3 first obtain conditions for (2.10) to hold via the Elman estimate (see Theorem 5.4 below), and then bound $\|\mathbf{u}^m - \mathbf{u}\| / \|\mathbf{u}\|$ by a k-independent multiple of $\|\mathbf{r}^m\| / \|\mathbf{r}^0\|$.

2.2 How sharp are Theorems 2.2 and 2.3 in their k-dependence?

2.2.1 Sharpness of an analogous result at the PDE level

We now state results showing that the condition

$$k \|A_1 - A_2\|_{L^{\infty}(D;\mathrm{op})}$$
 and $k \|n_1 - n_2\|_{L^{\infty}(D;\mathbb{R})}$ both sufficiently small (2.11)

is not only an answer to Q1 but is also the natural answer to an analogue of Q1 at the level of PDEs, namely

Q1' Let u_j , j = 1, 2, be the Helmholtz solution with coefficients A_j and n_j ; how small must $||A_1 - A_2||_{L^{\infty}(D; \text{op})}$ and $||n_1 - n_2||_{L^{\infty}(D; \mathbb{R})}$ be (in terms of k) for the relative error in approximating u_2 by u_1 to be bounded independently of k for arbitrarily-large k?

(The claim that Q1' is an analogous question to Q1 at the level of PDEs is made precise in Remark 6.2.)

Furthermore Lemma 2.7 shows that the condition " $k \|n_1 - n_2\|_{L^{\infty}(D;\mathbb{R})}$ sufficiently small" is the provably-sharp answer to Q1' when $A_1 = A_2 = I$.

Before stating these PDE results, we recall from (2.2) the definition of the weighted H^1 norm

$$\|v\|_{H^{1}_{k}(D)}^{2} := \|\nabla v\|_{L^{2}(D)}^{2} + k^{2} \|v\|_{L^{2}(D)}^{2} \quad \text{for } v \in H^{1}_{0,D}(D),$$
(2.12)

where the space $H^1_{0,D}(D)$, defined by (3.6), is the natural space containing the solution of the exterior Dirichlet problem. Finally, let $(H^1_{0,D}(D))^*$ denote the dual space of $H^1_{0,D}(D)$.

Theorem 2.6 (Answer to Q1') Given $F \in (H^1_{0,D}(D))^*$ and coefficients $A_j, n_j, j = 1, 2$, let u_j , j = 1, 2, be the solutions of the variational problem (3.5) with coefficients A_j, n_j . Assume that D, A_1 , and n_1 satisfy Condition 4.1 and that D, A_2 , and n_2 are such that u_2 exists.

Then, given $k_0 > 0$, there exists $C_3 > 0$, independent of k and F and given explicitly in terms of D_- , A_1 , and n_1 in (6.2), such that

$$\frac{\left\|u_{1}-u_{2}\right\|_{H_{k}^{1}(D)}}{\left\|u_{2}\right\|_{H_{k}^{1}(D)}} \leq C_{3} k \max\left\{\left\|A_{1}-A_{2}\right\|_{L^{\infty}(D; \mathrm{op})}, \left\|n_{1}-n_{2}\right\|_{L^{\infty}(D; \mathbb{R})}\right\}$$
(2.13)

for all $k \geq k_0$.

...

In stating the next result (and elsewhere in the paper), for a, b > 0 we write $a \leq b$ when $a \leq Cb$ for some C > 0, independent of k and h. We also write $a \sim b$ if $a \leq b$ and $b \leq a$.

Lemma 2.7 (Sharpness of the bound (2.13) when $A_1 = A_2 = I$) Assume that there exist 0 < I $R_1 < R_2$ such that $\overline{D_-} \subset B_{R_1} \subset B_{R_2} \subset \widetilde{D}$ (i.e. there exists an annulus between D_- and $\partial \widetilde{D}$).

Then there exist particular choices of F, n_1 , and n_2 (with $n_1 \neq n_2$, and both continuous functions on D_+) such that the corresponding solutions u_1 and u_2 of the variational problem (3.5) with $A_1 = A_2 = I$ exist, are unique, and, given $k_0 > 0$,

$$\frac{\|u_1 - u_2\|_{H_k^1(D)}}{\|u_2\|_{H_k^1(D)}} \sim \frac{\|u_1 - u_2\|_{L^2(D)}}{\|u_2\|_{L^2(D)}} \sim k \|n_1 - n_2\|_{L^\infty(D;\mathbb{R})},\tag{2.14}$$

for all $k \geq k_0$.

Remark 2.8 (Physical interpretation of the condition (2.11)) Recall that the wavelength of the wave u (at least when A = I and n = 1) is $2\pi/k$. Since this is the natural length scale associated with u, one expects from physical considerations that perturbations of magnitude $\leq c/k$, for c > 0sufficiently small, are 'unseen' by the PDE or numerical method. This is indeed what we see in Theorems 2.2, 2.3, and 2.6: perturbations of this form (i.e. A_i and n_j satisfying (2.11)) give bounded relative difference (for Q1') and bounded GMRES iterations for the nearby-preconditioned linear system (for Q1).

2.2.2Numerical experiments to test the sharpness of Theorems 2.2 and 2.3

We now present experiments testing the sharpness of the condition

$$k\|A_1 - A_2\|_{L^{\infty}(D; op)} + k\|n_1 - n_2\|_{L^{\infty}(D; op)} \text{ sufficiently small}$$
(2.15)

for the k-independent convergence of standard GMRES. While Theorem 2.3 gives " $h \|A_1 - A_2\|_{L^{\infty}(D; \text{op})} + k \|n_1 - n_2\|_{L^{\infty}(D; \text{op})}$ sufficiently small" as a sufficient condition for the k-independent convergence of standard GMRES, we recall from the discussion below Lemma 2.4 that we expect (2.15) to be sufficient. While we do not present any experiments with weighted GMRES in this paper, we highlight that in [34] the number of iterations for standard GMRES and weighted GMRES with the weight \mathbf{D}_k were found to be almost identical when applied to preconditioned linear systems arising from the Helmholtz FEM.

Description of the set-up. We consider the solution of the variational problem (3.5) with $D_{-} = \emptyset$, $D_{+} = [0, 1]^2$, and T = ik. These choices correspond to the interior impedance problem on the unit square in 2-d. We set $A_1 = I$, $n_1 = 1$, f = 0, and define g_I so that the exact solution u_1 is a plane wave incident from the bottom left passing through the homogeneous medium given by coefficients A_1 and n_1 .

We solve this variational problem via the finite-element method defined in (3.8); we choose the family of finite-dimensional subspaces $(V_{h,p})_{h>0}$ to be first-order (i.e. p = 1) continuous finite elements on regular grids with $h = k^{-3/2}$; this choice of h means that the finite-element approximation u_h is uniformly accurate as $k \to \infty$ (see §4.3 and the references therein). All finite-element calculations were carried out using the Firedrake software library [59, 44], which itself uses the PETSc [3, 13], Chaco [38], and MUMPS [1, 2] software packages. The code used in this paper can be found at https://github.com/orpembery/running-nbpc. The exact versions of the code used in this paper, and the corresponding computational data can be found in the releases [54, 55, 56].

Description of the four different A_2 and n_2 considered.




Figure 1: Maximum GMRES iteration counts for solving systems with matrix $(\mathbf{A}_1)^{-1}\mathbf{A}_2$, where $A_1 = A_2 = I$ and $\|n_1 - n_2\|_{L^{\infty}(D;\mathbb{R})} \leq 0.5 \times k^{-\beta}$. Grey markers indicate GMRES reached 500 iterations without convergence.

- 1. $A_2 = I$ and 100 realisations of randomly-chosen n_2 that are piecewise constant with respect to a 10×10 square grid on D (experiments in Figure 1).




Figure 2: Maximum GMRES iteration counts for solving systems with matrix $(\mathbf{A}_1)^{-1}\mathbf{A}_2$, where $n_1 = n_2 = 1$ and $||A_1 - A_2||_{L^{\infty}(D; \text{op})} \leq k^{-\beta}$.

- 2. $n_2 = 1$ and 100 realisations of randomly-chosen A_2 that are piecewise constant with respect to a 10×10 square grid on D (experiments in Figure 2).




Figure 3: GMRES iteration counts for solving systems with matrix $(\mathbf{A}_1)^{-1}\mathbf{A}_2$, where $A_1 = A_2 = I$ and $\|n_1 - n_2\|_{L^{\infty}(D;\mathbb{R})} = 0.5 \times k^{-\beta}$ and n_2 is a 10 × 10 checkerboard. Grey markers indicate GMRES reached 500 iterations without convergence.

- 3. $A_2 = I$ and deterministic n_2 that are piecewise constant in a checkerboard pattern on a 10×10 square grid on D (experiments in Figure 3).




Figure 4: GMRES iteration counts for solving systems with matrix $(\mathbf{A}_1)^{-1}\mathbf{A}_2$, where $A_1 = A_2 = I$ and $\|n_1 - n_2\|_{L^{\infty}(D;\mathbb{R})} = 0.5 \times k^{-\beta}$ and n_2 is 2×2 checkerboard. Grey markers indicate GMRES reached 500 iterations without convergence.

- 4. $A_2 = I$ and deterministic n_2 that are piecewise constant in a checkerboard pattern on a 2×2 square grid on D (experiments in Figure 4).

Regarding 1: Each instance of n_2 is piecewise constant with respect to a 10×10 square grid on $D := (0, 1)^2$ with values chosen independently from the Unif $(1 - \alpha, 1 + \alpha)$ distribution, where

$$\alpha := 0.5 \times k^{-\beta}, \quad \text{for} \quad \beta \in \{0, 0.1, \dots, 0.9, 1\},$$
(2.16)

so that $||n_1 - n_2||_{L^{\infty}(D,\mathbb{R})} \leq 0.5 \times k^{-\beta}$.

Regarding 2: On each element of the grid we set

$$A_2 = \left[\begin{array}{cc} 1+a & b \\ b & 1+c \end{array} \right],$$

where $a, c \in \text{Unif}(0, \alpha)$ and α as given in (2.16). For each draw of a, c we choose $b \in \text{Unif}(0, \delta)$, where $\delta = \min\{\alpha, \sqrt{(1+a)(1+c)}\}$. It follows that each draw of A_2 is positive definite almost surely. Since the elements of $A_1 - A_2 = I - A_2$ are all bounded above by α , direct computation shows that

$$\|A_1 - A_2\|_{L^{\infty}(D; \mathrm{op})} \le 2\alpha \le k^{-\beta}.$$
(2.17)

Regarding 3: As in 1., n_2 is piecewise constant with respect to a 10×10 square grid on D, but now n_2 alternates between the values $1 - \alpha$ and $1 + \alpha$ (with α as in (2.16)) in a checkerboard pattern. In this case, $||n_1 - n_2||_{L^{\infty}(D,\mathbb{R})} = 0.5 \times k^{-\beta}$.

Regarding 4: This set up is exactly the same as in 3., except that now the square grid on D is 2×2 . The motivation for this checkerboard is that now there are just under 16 wavelengths in each piece of the board (of width 0.5) when k = 100 (i.e., at the largest k considered), whereas in the 10×10 checkerboard there is only just over one wavelength in each piece of the board at k = 100.

In all four cases, to obtain the action of $(\mathbf{A}_1)^{-1}$, we calculate the exact LU decomposition of \mathbf{A}_1 . We then solve the linear system (2.4) using standard GMRES (i.e. with residual minimisation in the Euclidean norm) and zero initial guess, and record the number of GMRES iterations taken to achieve a relative residual of 10^{-5} . In the first and second experiments, we consider k between 20 and 100, and in the third and fourth experiments we consider k between 20 and 200.

Description and discussion of results. In all cases we see the number of GMRES iterations being bounded (over the ranges considered) for $\beta \in \{0.8, 0.9, 1.0\}$, and growing for $\beta \in \{0., ..., 0.5\}$, with the growth worse for the two deterministic cases in Figures 3 and 4. For $\beta \in \{0.6, 0.7\}$ we see either growth or boundedness, depending on the problem. To check if the number of samples in Figures 1 and 2 were large enough, we repeated the experiments leading to Figures 1 and 2 with 200 realisations of n_2 (as opposed to 100 realisations in Figure 1), but observed very little change in the results.

This behaviour is better than expected from the condition (2.15), which covers $\beta = 1$. Because of the results about Q1' at the PDE level in Theorem 2.6 and Lemma 2.7, we expect that the number of iterations will eventually grow for $\beta < 1$ for k sufficiently large.

2.3 Results involving $||A_1 - A_2||_{L^q}$ and $||n_1 - n_2||_{L^q}$ for $2 < q \le \infty$

Motivation. The results in Theorems 2.2 and 2.3 involving $||A_1 - A_2||_{L^{\infty}}$ and $||n_1 - n_2||_{L^{\infty}}$ give an answer to Q1 that fits well with both PDE considerations (via Theorem 2.6) and physical intuition (via Remark 2.8), and is consistent with the numerical experiments for moderate k in §2.2.2. However, the following example shows the disadvantage of measuring the difference in coefficients in the L^{∞} norm. Let $D = \{\mathbf{x} : ||\mathbf{x}||_2 = 2\}$, $A_1 = A_2 = I$, and

$$n_1(\mathbf{x}) = \begin{cases} 1 & \text{if } \|\mathbf{x}\|_2 \ge \frac{1}{2}, \\ 1/2 & \text{if } \|\mathbf{x}\|_2 < \frac{1}{2}, \end{cases} \quad \text{and} \quad n_2(\mathbf{x}) = \begin{cases} 1 & \text{if } \|\mathbf{x}\|_2 \ge \frac{1}{2} + \alpha, \\ 1/2 & \text{if } \|\mathbf{x}\|_2 < \frac{1}{2} + \alpha, \end{cases}$$
(2.18)

for some $0 < \alpha < 1/2$. Then $||n_1 - n_2||_{L^{\infty}(D;\mathbb{R})} = 1/2$ for all α , but one may expect that GMRES applied to $(\mathbf{A}_1)^{-1}\mathbf{A}_2$ would converge in a k-independent number of iterations for small α . In this subsection, we therefore state analogues of Theorems 2.2 and 2.3, with the differences in $n_1 - n_2$ and $A_1 - A_2$ measured in weaker norms than the L^{∞} norm.

Statement of the results. To state these results, we need the definition that

$$\|A\|_{L^{q}(D,\mathrm{op})} := \left(\int_{D} \|A(\mathbf{x})\|_{2}^{q} \,\mathrm{d}\mathbf{x}\right)^{1/q}.$$
(2.19)

Similar to in §2.1, Theorem 2.10 gives results for standard GMRES (i.e., using the vector Euclidean norm $\|\cdot\|_2$), whereas Theorem 2.9 gives results in the weighted vector norms $\|\cdot\|_{\mathbf{D}_k}$ and $\|\cdot\|_{\mathbf{D}_k^{-1}}$.

Theorem 2.9 (Answer to Q1: *k*-independent weighted GMRES iterations) Assume that

- D_{-} , A_j , and n_j , j = 1, 2, satisfy Condition 4.1, and
- D_- , A_j , n_j , j = 1, 2, h and p, satisfy Condition 4.2.

Given $k_0 > 0$ and q > 2, there exist constants \widetilde{C}_1 and \widetilde{C}_2 independent of h and k (but dependent

on D_-, A_1, n_1, p , and k_0) such that if

$$\widetilde{C}_{1}kh^{-d/q}\|A_{1} - A_{2}\|_{L^{q}(D,\mathrm{op})} + \widetilde{C}_{2}kh^{-d/q}\|n_{1} - n_{2}\|_{L^{q}(D,\mathbb{R})} \leq \frac{1}{2}$$
(2.20)

for all $k \ge k_0$, then both weighted GMRES working in $\|\cdot\|_{\mathbf{D}_k}$ (and the associated inner product) applied to

$$(\mathbf{A}_1)^{-1}\mathbf{A}_2\mathbf{u} = \mathbf{f}$$

and weighted GMRES working in $\|\cdot\|_{(\mathbf{D}_k)^{-1}}$ (and the associated inner product) applied to

$$\mathbf{A}_2(\mathbf{A}_1)^{-1}\mathbf{v} = \mathbf{f}$$

with initial guess the zero vector converge in a k-independent number of iterations (in the sense of Definition 2.1) for all $k \ge k_0$.

Theorem 2.10 (Answer to Q1: *k*-independent standard GMRES iterations) Assume that

- D_{-} , A_{j} , and n_{j} , j = 1, 2, satisfy Condition 4.1, and
- D_- , A_j , and n_j , j = 1, 2, h and p, satisfy Condition 4.2.

Given $k_0 > 0$, and q > 2, let \widetilde{C}_1 and \widetilde{C}_2 be as in Theorem 2.9, and let $s_+ > 0$ and $m_{\pm} > 0$ be as in Lemma 5.1 (note that all these constants are independent of k, h, and p). Then if

$$\widetilde{C}_1\left(\frac{s_+}{m_-}\right)\frac{h^{-d/q}}{h}\|A_1 - A_2\|_{L^q(D,\mathrm{op})} + \widetilde{C}_2\left(\frac{m_+}{m_-}\right)kh^{-d/q}\|n_1 - n_2\|_{L^q(D,\mathbb{R})} \le \frac{1}{2}$$
(2.21)

for all $k \ge k_0$, then standard GMRES (working in the Euclidean norm and inner product) applied to either (2.4) or (2.5) with initial guess the zero vector converges in a k-independent number of iterations (in the sense of Definition 2.1) for all $k \ge k_0$.

We make the following remarks.

- The constants \widetilde{C}_1 and \widetilde{C}_2 are given explicitly in (5.6) and (5.7) in terms of q and
 - $C_{\text{bound}}^{(1)}$ given in Condition 4.1,
 - $C_{\text{FEM1}}^{(1)}$ and $C_{\text{FEM2}}^{(1)}$ given in Condition 4.2,
 - $-n_{1\max}$, $n_{1\min}$, and $A_{1\min}$ given in (3.1) and (3.2) (with *n* replaced by n_1 and *A* replaced by A_1),
 - $-C_{\text{inv},s}$ given in (5.1).
- Theorems 2.2 and 2.3 can be viewed as special cases of Theorems 2.9 and 2.10, respectively, with q formally set to ∞ .
- In the conditions (2.20) and (2.21) there is a trade-off between the norm used to measure $n_1 n_2$ and the restriction on the magnitude of this norm. Indeed, as $q \searrow 2$, $n_1 n_2$ is measured in a weaker norm, but the condition on $||n_1 n_2||_{L^q}$ in (2.20) and (2.21) becomes more restrictive since $h^{-d/q}$ becomes larger. Conversely, as $q \nearrow \infty$, $n_1 n_2$ is measured in a stronger norm, but the condition on $||n_1 n_2||_{L^q}$ in (2.20) and (2.21) becomes less restrictive since $h^{-d/q}$ becomes smaller.
- The condition (2.3) contains no powers of h, but the analogous condition (2.20) does. The reason is that, in the proofs of Theorems 2.2 and 2.3, we use the inequality $||(n_1 n_2)v_h||_{L^2(D)} \leq ||n_1 n_2||_{L^{\infty}(D)} ||v_h||_{L^2(D)}$, where $v_h \in V_{h,p}$, to "pull out" the L^{∞} norm of $n_1 n_2$. In Theorems 2.9 and 2.10 we want to "pull out" the L^q norm of $n_1 n_2$, so we use the inequality $||(n_1 n_2)v_h||_{L^2(D)} \leq ||n_1 n_2||_{L^q(D;\mathbb{R})} ||v_h||_{L^s(D)}$ where 1/2 = 1/q + 1/s (see (5.23)). We then need to convert the L^s norm of v_h into an L^2 norm (essentially because the PDE (1.1) is posed in the L^2 -based Sobolev space $H^1_{0,D}(D)$), and we do this using the inverse inequality (5.1), introducing powers of h. Similar considerations hold for $A_1 A_2$.

- The remarks in Points (b), (c), and (d) in §2.1 (for Theorems 2.2 and 2.3) hold here for Theorems 2.9 and 2.10. Similarly, Lemma 2.4 also applies.
- The numerical experiments in [53, §4.5.2] consider $A_1 = A_2 = I$ and n_j defined in a similar way to (2.18) (but jumping across a half-plane) designed so that $||n_1-n_2||_{L^q(D)} = Ck^{-\beta}$ (with C > 0 independent of all parameters) for $\beta \in \{0, 0.1, \ldots, 0.9, 1.0\}$ for all $1 \le q < \infty$. These experiments show similar behaviour to those in §2.2.2, with the number of GMRES iterations levelling off over the range $10 \le k \le 100$ for $\beta \in \{0.7, 0.8, 0.9, 1.0\}$. These experiments indicate that the conditions (2.20) and (2.21) for k-independent GMRES iterations may not be sharp in their q- and h-dependence.

2.4 Implications of these results for uncertainty quantification for the Helmholtz equation

The results of Theorems 2.2, 2.3, 2.9, and 2.10 and the numerical results in §2.2.2 show that $||A_1 - A_2||$ and $||n_1 - n_2||$ must decrease as k increases for \mathbf{A}_1 to be a good preconditioner for \mathbf{A}_2 .

This suggests that the idea of "reusing" preconditioners in calculating $Q(u(\omega_{\ell}))$, $\ell = 1, \ldots, N$ in (1.4) becomes less effective as $k \to \infty$. However, numerical experiments in [53, §4.6.3, Page 183], with A = I and n given by an artificial Karhunen-Loève-type expansion, show that the number of samples N in (1.4) must increase with k to make the error (1.5) controllably small as $k \to \infty$. There is therefore a trade-off between how quickly N increases with k and how quickly the region in coefficient space for which a preconditioner is effective decreases with k.

In the rest of this subsection we give some more details about the experiments in [53, §4.6.3] about "reusing" preconditioners in calculating $Q(u(\omega_{\ell}))$. Before doing this, however, we highlight that this strategy is related to *mean-based preconditioning*, where a single preconditioner is calculated corresponding to the mean of the random coefficient. The initial computational work on mean-based preconditioning for the equation $-\nabla \cdot (A\nabla u) = f$ was carried out by [30], [52], and [42], with theory following from [58] and [20]. In the Helmholtz context, mean-based preconditioning has been used in [41] and [65] (see the literature review in [53, §4.7] for more discussion).

Preliminary experiments in [53, §4.6.3] show that, at least for moderate k, the idea of "reusing nearby preconditioners" can give a significant speedup in the implementation of Quasi-Monte-Carlo (QMC) methods for Helmholtz problems. One of the experiments in [53, §4.6.3] concerned the UQ of various quantities of interest for the solution of (1.1) on the unit square $D = (0, 1)^2$ with an impedance boundary condition, and with coefficients taken to be A = I and $n(\mathbf{x}, y) =$ $1 + \sum_{j=1}^{s} y_j \psi_j(\mathbf{x})$, with $\mathbf{x} \in D$, $y_j \in \text{Unif}(-1/2, 1/2)$ i.i.d. and $\psi_j(\mathbf{x}) = j^{-2} \cos(j\pi x_1/4) \cos((j + 1)\pi x_2/4)$. For the UQ, a randomly shifted QMC rule taken from [51] was used.

The first part of the experiment uses extrapolation to determine how the number of QMC points N = N(k) need to be chosen to ensure that the error in the expected value of each of the quantities of interest is bounded with respect to k. These experiments suggest that for $k \in [10, 60]$, N(k) needs to grow somewhere between linearly and quadratically in k to keep the error bounded; thus providing an empirical answer in this case to Q2 in §1.2 (see (1.5)).

Since N(k) instances of the boundary value problem have to be solved for each k, [53, §4.6.2] looks at speeding this computation up by computing a set of 'preconditioning points' on a (coarse) sublattice of the QMC points. By the theory above, for the sublattice to be guaranteed useful, for each point y on it, there should be another coarse lattice point y' satisfying approximately $||n(\cdot, y) - n(\cdot, y')||_{L^{\infty}(D)} \leq k^{-1}$. In practice, it is hard to compute such a lattice (see Q3 in §1.2), so in [53, §4.6.3] a coarse sublattice of $N_c = N_c(k)$ points is computed that instead equidistributes the right-hand side of the upper bound

$$\|n(\cdot, y) - n(\cdot, y')\|_{L^{\infty}(D)} \leq \sum_{j=1}^{s} j^{-2} |y_j - y'_j|,$$

with the value of N_c again determined by extrapolation from small values of k. Results for this procedure are given in [53, Table 4.5] and these show that the ratio N_c/N is never bigger than 0.016 for $k \in [10, 60]$ in dimension s = 10. Therefore, more than 98% of the required linear systems can be solved by preconditioned GMRES. Moreover, the average number of GMRES iterations needed

for the solution of all the required linear systems varies between 6.46 to 7.41 as k increases from 10 to 60, showing the good quality and "k-robustness" of the set of preconditioning points. In the experiments in [53], the restarted version of GMRES (the default in Firedrake) was used with restarts after 30 iterations. This preconditioning strategy for Helmholtz UQ will be investigated in more detail elsewhere.

3 Definitions of the Helmholtz boundary value problem, its finite-element solution, and weighted GMRES

Function-space notation: Let SPD be the set of all symmetric-positive-definite matrices in $\mathbb{R}^d \times \mathbb{R}^d$. For $D \subseteq \mathbb{R}^d$, let $L^{\infty}(D; SPD)$ be the set of all matrix-valued functions $A : D \to SPD$ such that $A_{i,j} \in L^{\infty}(D; \mathbb{R})$ for all $i, j = 1, \ldots, d$. Where the range of functions is \mathbb{C} we suppress the second argument in a function space, e.g. writing $L^2(D)$ for $L^2(D; \mathbb{C})$.

Assumption 3.1 (Assumption on the domain and the coefficients)

(i) D_{-} is an open bounded Lipschitz set such that the open complement $D_{+} := \mathbb{R}^{d} \setminus \overline{D_{-}}$ is connected. \widetilde{D} is a bounded connected Lipschitz open set such that $\overline{D_{-}} \subset \widetilde{D}$. Let $D := \widetilde{D} \setminus \overline{D_{-}}$.

(ii) $n \in L^{\infty}(D; \mathbb{R})$ is such that $\operatorname{supp}(1-n) \subset \widetilde{D}$ and there exist $0 < n_{\min} \leq n_{\max} < \infty$ such that

$$n_{\min} \le n(\mathbf{x}) \le n_{\max}$$
 for almost every $\mathbf{x} \in D$, (3.1)

(iii) $A \in L^{\infty}(D; SPD)$ is such that $supp(I - A) \subset \widetilde{D}$ and there exist $0 < A_{\min} \leq A_{\max} < \infty$ such that

$$A_{\min}|\boldsymbol{\xi}|^{2} \leq (A(\mathbf{x})\boldsymbol{\xi}) \cdot \overline{\boldsymbol{\xi}} \leq A_{\max}|\boldsymbol{\xi}|^{2} \quad \text{for all } \boldsymbol{\xi} \in \mathbb{C}^{d} \text{ for almost every } \mathbf{x} \in D,$$
(3.2)

Let $\Gamma_D := \partial D_-$, and $\Gamma_I := \partial \widetilde{D}$. (Observe that, by construction, $\partial D = \Gamma_D \cup \Gamma_I$ and $\Gamma_D \cap \Gamma_I = \emptyset$.) Let $\gamma : H^1(D) \to H^{1/2}(\partial D)$ denote the Dirichlet trace operator, and $\partial_{\nu} : H^1(D, \Delta) \to H^{-1/2}(\partial D)$ the Neumann trace operator.

Definition 3.2 (Truncated Exterior Dirichlet Problem (TEDP)) Given D_- , D, A, and n satisfying Assumption 3.1, k > 0, $f \in L^2(D)$, $g_I \in L^2(\Gamma_I)$, and a bounded linear map $T : H^{1/2}(\Gamma_I) \to H^{-1/2}(\Gamma_I)$, we say $u \in H^1(D)$ satisfies the truncated exterior Dirichlet problem if

$$\nabla \cdot (A\nabla u) + k^2 n u = -f \text{ in } D, \qquad (3.3)$$

$$\gamma u = 0, \text{ on } \Gamma_D \text{ and}$$

 $\partial_{\nu} u - T(\gamma u) = g_I \text{ on } \Gamma_I,$ (3.4)

where the equation (3.3) is understood in the following weak sense:

$$\int_D \nabla u \cdot (A \overline{\nabla \phi}) - k^2 n u \overline{\phi} = \int_D f \overline{\phi} \quad \text{for all } \phi \in C^\infty_{\text{comp}}(D),$$

where $C^{\infty}_{\text{comp}}(D) := \{ \phi \in C^{\infty}(D) : \text{supp } \phi \text{ is a compact subset of } D \}.$

Green's identity (see, e.g., [45, Lemma 4.3]) then implies that the solution of the TEDP is the solution of the following variational problem (and vice versa):

find
$$u \in H^1_{0,D}(D)$$
 such that $a(u,v) = F(v)$ for all $v \in H^1_{0,D}(D)$, (3.5)

where

$$H^{1}_{0,D}(D) := \{ v \in H^{1}(D) : \gamma v = 0 \text{ on } \Gamma_{D} \},$$
(3.6)

$$a(w,v) := \int_{D} \left((A\nabla w) \cdot \nabla \overline{v} - k^2 n \, w \overline{v} \right) - \langle T\gamma_I w, \gamma_I v \rangle_{\Gamma_I} \quad \text{and} \quad F(v) = \int_{D} f \, \overline{v} + \langle g, v \rangle_{\Gamma_I}, \quad (3.7)$$

where $\langle \cdot, \cdot \rangle_{\Gamma_I}$ denotes the duality pairing on Γ_I that is linear in the first argument and antilinear in the second argument. When $A = A_j$ and $n = n_j$, for either j = 1 or j = 2, we denote the sesquilinear form $a(\cdot, \cdot)$ by $a_j(\cdot, \cdot)$. Remark 3.3 (Choices of the operator T) We consider the two choices T = ik and T = DtN, where $DtN : H^{1/2}(\Gamma_R) \to H^{-1/2}(\Gamma_R)$ is the Dirichlet-to-Neumann (DtN) map for the equation $\Delta u + k^2 u = 0$ posed in the exterior of \widetilde{D} with the Sommerfeld radiation condition (1.2); when \widetilde{D} is a ball, the definition of DtN in terms of Hankel functions and polar coordinates (when d =2)/spherical polar coordinates (when d = 3) is given in, e.g., [11, Equations 3.5 and 3.6], [50, §2.6.3]. When T = DtN, g = 0, and $supp f \subset \widetilde{D}$, the solution of the TEDP equals the restriction to D of the solution of the exterior Dirichlet problem posed in D_+ with the Sommerfeld radiation condition at infinity; see, e.g., [32, Lemma 3.3].

A simple approximation to DtN is the operator of multiplication by ik. The boundary condition (3.4) then becomes the impedance boundary condition, which is also known as a first-order absorbing boundary condition (see, e.g, [5], [40, §3.3]). See [24, Equation 5.3] for analysis of the approximation DtN \approx ik in the case when \tilde{D} is a ball, and [23] for upper and lower bounds on the relative error between the solution of the TEDP and the exterior Dirichlet problem for more general \tilde{D} .

Remark 3.4 (Existence and uniqueness) With either of the choices T = ik and T = DtN, $a(\cdot, \cdot)$ satisfies a Gårding inequality (for T = ik this is straightforward; for T = DtN see, e.g., [50, Theorem 2.6.6]). Therefore, once uniqueness is established the Fredholm alternative then gives existence. The unique continuation principle (UCP) holds (and therefore gives uniqueness) when $n \in L^{\infty}$ and (i) d = 2 and $A \in L^{\infty}$, (ii) d = 3 and $A \in C^{0,1}$; see the references in [32, §1], [33, §2] (where the latter paper applies these results specifically to the Helmholtz equation). The UCP does not hold in general when d = 3 and A is rougher than Lipschitz (see [22]), but uniqueness is proved for a particular class of $A \in L^{\infty}$ in [32, Theorem 2.7].

Finite-element solution of the TEDP. Let $(V_{h,p})_{h>0}$ consist of continuous piecewise-polynomials on a family of quasi-uniform simplicial meshes \mathcal{T}_h with mesh-size h and fixed polynomial degree p (i.e. we consider the "h-FEM"). Note that the dimension N of $V_{h,p}$ then satisfies $N \sim h^{-d}$, with hidden constant dependent on p. (The assumption of quasi-uniformity can, in principle, be relaxed, see Remark 5.2.)

Recall that our main results, Theorems 2.2, 2.3, 2.9, and 2.10, are proved under Conditions 4.1 and 4.2. Some of the cases under which these conditions hold require ∂D to be at least $C^{1,1}$. For such D it is not possible to fit ∂D exactly with simplicial elements, and some analysis of non-conforming error is therefore necessary; since this is standard (see, e.g., [8, Chapter 10]), we ignore this issue here.

Definition 3.5 (Finite-element approximation of the solution of the TEDP) With $a(\cdot, \cdot)$ and F given in (3.7), find $u_h \in V_{h,p}$ such that

$$a(u_h, v_h) = F(v_h) \text{ for all } v_h \in V_{h,p}.$$
(3.8)

We say that $u_h \in V_{h,p}$ is the finite-element approximation of u.

Conditions on k, h, and p under which u_h exists and is unique are discussed in §4.3. (Regarding the notation u_h : although the finite-element approximation depends on both h and p, since we consider decreasing h with p fixed in this paper, for brevity the notation only reflects the h-dependence.)

The matrices associated with our finite-element discretisation are defined as follows. Let $\{\phi_i, i = 1, \ldots, N\}$ be a nodal basis for $V_{h,p}$ with each ϕ_i real-valued. Let

$$\left(\mathbf{S}_{A}\right)_{ij} \coloneqq \int_{D} \left(A\nabla\phi_{j}\right) \cdot \nabla\phi_{i}, \quad \left(\mathbf{M}_{n}\right)_{ij} \coloneqq \int_{D} n \,\phi_{i} \,\phi_{j}, \quad \text{and} \quad \left(\mathbf{N}\right)_{ij} \coloneqq \int_{\Gamma_{R}} T(\gamma\phi_{j}) \,\gamma\phi_{i} \quad (3.9)$$

be the stiffness, domain-mass, and boundary-mass matrices, respectively. Note that both \mathbf{S}_A and \mathbf{M}_n are *real-valued*, but in general **N** is *complex-valued* (because both the DtN operator DtN and the impedance operator ik are complex-valued). Let

$$\mathbf{A} := \mathbf{S}_A - k^2 \mathbf{M}_n - \mathbf{N}_n$$

and let $u_h := \sum_j u_j \phi_j$. Then (3.8) implies that $\mathbf{A}\mathbf{u} = \mathbf{f}$, where $(\mathbf{u})_i := u_i$ and $(\mathbf{f})_i := F(\phi_i)$. For j = 1, 2, let

$$\mathbf{A}_j := \mathbf{S}_{A_j} - k^2 \mathbf{M}_{n_j} - \mathbf{N} \tag{3.10}$$

and let

$$\mathbf{D}_k := \mathbf{S}_I + k^2 \mathbf{M}_1;$$

with \mathbf{S}_I and \mathbf{M}_1 the standard stiffness and mass matrices defined by (3.9) above (thus \mathbf{D}_k is independent of the coefficients A and n). We then define the weighted norm $\|\cdot\|_{\mathbf{D}_k}$ by (2.1).

Weighted GMRES. We now give the set-up for weighted GMRES, introduced in [21] (with GMRES introduced in [60]). Consider the abstract linear system $\mathbf{C}\mathbf{x} = \mathbf{d}$ in \mathbb{C}^N , where $\mathbf{C} \in \mathbb{C}^{N \times N}$ is invertible. Let \mathbf{x}^0 be the initial guess, and define the initial residual $\mathbf{r}^0 := \mathbf{C}\mathbf{x}^0 - \mathbf{d}$ and the standard Krylov spaces:

$$\mathcal{K}^m(\mathbf{C}, \mathbf{r}^0) := \operatorname{span} \{ \mathbf{C}^j \mathbf{r}^0 : j = 0, \dots, m-1 \}.$$

Analogously to the definition of $\|\cdot\|_{\mathbf{D}_k}$ above, let $(\cdot, \cdot)_{\mathbf{D}}$ denote the inner product on \mathbb{C}^n induced by some Hermitian positive-definite matrix \mathbf{D} , i.e. $(\mathbf{v}, \mathbf{w})_{\mathbf{D}} := (\mathbf{D}\mathbf{v}, \mathbf{w})_2$, and let $\|\cdot\|_{\mathbf{D}}$ be the induced norm. For $m \geq 1$, define the *m*th GMRES iterate \mathbf{x}^m to be the unique element of \mathcal{K}^m such that its residual $\mathbf{r}^m := \mathbf{C}\mathbf{x}^m - \mathbf{d}$ satisfies the minimal residual property:

$$\|\mathbf{r}^m\|_{\mathbf{D}} = \|\mathbf{C}\mathbf{x}^m - \mathbf{d}\|_{\mathbf{D}} = \min_{\mathbf{x}\in\mathcal{K}^m(\mathbf{C},\mathbf{r}^0)} \|\mathbf{C}\mathbf{x} - \mathbf{d}\|_{\mathbf{D}}.$$
 (3.11)

The algorithm stops when $\|\mathbf{r}^m\|_2/\|\mathbf{r}^0\|_2 \leq \varepsilon$ for some prescribed tolerance ε . Observe that when $\mathbf{D} = \mathbf{I}$ this is the standard GMRES algorithm. We also note that in general, weighted GMRES requires the use of weighted Arnoldi process, also introduced in [21], see also the alternative implementations of the weighted Arnoldi process in [37].

4 Conditions 4.1 and 4.2

4.1 Definitions of Conditions 4.1 and 4.2

Condition 4.1 is a condition on the domain D and coefficients A and n in the TEDP of Definition 3.2, and involves a constant C_{bound} (see (4.2)). When D, A_j , and n_j satisfy Condition 4.1, we write the corresponding constant as $C_{\text{bound}}^{(j)}$.

Condition 4.2 is a condition on h and p in the finite-dimensional subspaces $V_{h,p}$ and implicitly also a condition on D, A, and n in the TEDP (since D, A, and n must satisfy certain properties for the finite-element approximation to exist). Condition 4.2 involves the constants C_{FEM1} and C_{FEM2} ; when D, A_j , and n_j satisfy this, we write the corresponding constants as $C_{\text{FEM1}}^{(j)}$ and $C_{\text{FEM2}}^{(j)}$.

Condition 4.1 (Nontrapping bound on u) D, A, and n are such that, given $f \in L^2(D)$ the solution of the variational problem (3.5) with

$$F(v) = \int_D f\overline{v},\tag{4.1}$$

u, exists, is unique, and, given $k_0 > 0$, u satisfies the bound

$$||u||_{H^1_k(D)} \le C_{\text{bound}} ||f||_{L^2(D)} \quad \text{for all } k \ge k_0,$$
(4.2)

where C_{bound} is independent of k, but dependent on A, n, D, and k_0 .

To state Condition 4.2 we need the definition of the norm on $(H_k^1(D))^*$,

$$\|F\|_{(H^1_k(D))^*} := \sup_{v \in H^1_{0,D}(D)} \frac{|F(v)|}{\|v\|_{H^1_k(D)}}.$$
(4.3)

Condition 4.2 (k-independent accuracy of the FE solution for $a(\cdot, \cdot)$) Given $k_0 > 0$,

- 1. D, A, n, h and p are such that, if $f = \tilde{n} \sum_{j} \alpha_{j} \phi_{j}$ for some $\alpha_{j} \in \mathbb{C}$ and $\tilde{n} \in L^{\infty}(D; \mathbb{R})$ (i.e. f is an arbitrary element of $V_{h,p}$ multiplied by \tilde{n}), then for all $k \geq k_{0}$,
 - the solution u_h of (3.8) with F(v) given by (4.1) exists and is unique, and
 - the error bound

$$\|u - u_h\|_{H^1_k(D)} \le C_{\text{FEM1}} \|f\|_{L^2(D)} \quad \text{for all } k \ge k_0,$$
(4.4)

holds, where C_{FEM1} is independent of k and h, but dependent on A, n, D, k_0 , and p.

- 2. D, A, n, h and p are such that, if $F(v) = (\widetilde{A}\nabla \widetilde{f}, \nabla v)_{L^2(D)}$, where $\widetilde{A} \in L^{\infty}(D; \text{SPD})$ and $\widetilde{f} := \sum_j \alpha_j \phi_j$ with $\alpha_j \in \mathbb{C}$ (i.e. \widetilde{f} is an arbitrary element of $V_{h,p}$), then for all $k \ge k_0$,
 - the solution u_h of (3.8) exists and is unique, and
 - the error bound

$$\|u - u_h\|_{H^1_k(D)} \le C_{\text{FEM2}} k \|F\|_{(H^1_k(D))^*} \quad \text{for all } k \ge k_0, \tag{4.5}$$

holds, where C_{FEM2} is independent of k and h, but dependent on A, n, D, k_0 , and p.

4.2 When does Condition 4.1 hold?

The summary is the following:

- 1. Condition 4.1 holds when D, A, and n are such that the problem is *nontrapping*, in the sense that all rays starting in D hit Γ_I after some uniform time.
- 2. The definition of nontrapping is subtle in the case when either $D_{-} \neq \emptyset$ or A and n are discontinuous.
- 3. Expressions for C_{bound} that are explicit in A_1 and n_1 have recently been obtained [25], [32], [49]; essentially C_{bound} is a constant multiple of the length of the longest ray in D.

Regarding 1: In the case when $D_{-} = \emptyset$, and A and n are C^{∞} , the rays of the Helmholtz equation $\nabla \cdot (A\nabla u) + k^2 n u = -f$ are defined as the projections in \mathbf{x} of the solutions $(\mathbf{x}(s), \boldsymbol{\xi}(s)) \in \mathbb{R}^d \times \mathbb{R}^d$ of the Hamiltonian system

$$\frac{\mathrm{d}x_i}{\mathrm{d}s}(s) = \frac{\partial}{\partial\xi_i} H\big(\mathbf{x}(s), \boldsymbol{\xi}(s)\big), \qquad \frac{\mathrm{d}\xi_i}{\mathrm{d}s}(s) = -\frac{\partial}{\partial x_i} H\big(\mathbf{x}(s), \boldsymbol{\xi}(s)\big),$$

where the Hamiltonian $H(\mathbf{x}, \boldsymbol{\xi})$ given by

$$H(\mathbf{x},\boldsymbol{\xi}) := \frac{1}{n(\mathbf{x})} \sum_{i=1}^{d} \sum_{j=1}^{d} A_{ij}(\mathbf{x})\xi_i\xi_j - 1$$

(observe that H is the *semiclassical principal symbol* of the Helmholtz equation; see, e.g., [32, §7] for an introductory discussion on this).

When T = DtN, the propagation of singularities results of [16, §VI] (see also, e.g., [39, Chapter 24], [68, §12.3]) combined with the parametrix argument of [64] then imply that Condition 4.1 is satisfied. These arguments, however, do not give an explicit expression for C_{bound} in terms of (properties of) A and n.

When T = ik the results [4, Theorems 5.5 and 5.6 and Proposition 5.3] imply that Condition 4.1 is satisfied, but do not give an explicit expression for C_{bound} in terms of (properties of) A and n.

Regarding 2: When A and n are C^{∞} , but $D_{-} \neq \emptyset$, defining how the rays interact with the boundary Γ is subtle, and requires the notion of the Melrose–Sjöstrand generalized-bicharacteristic flow [39, §24.3], [46], [47]. However, under a suitable nontrapping hypothesis [47, Definition 7.20], the results of [64] then imply that Condition 4.1 is satisfied when T = DtN. When T = ik, the analogous result is given in [4] (with the specific case of a nontrapping Dirichlet obstacle covered by [4, Equation 5.2]). When A and n are discontinuous, the signs of the jumps dictate whether the problem is nontrapping or trapping; see [57], [10], and [49].

Regarding 3: When T = DtN, D, A, and n are such that the problem is nontrapping, both n_1 and A_1 are globally $C^{1,1}$ and C^{∞} in a neighbourhood of D_- , and no rays are tangent to Γ_D to infinite order then [25, Theorem 2 and Equation 6.32] proves that Condition 4.1 holds with

$$C_{\text{bound}} := \frac{2\sqrt{2}}{\pi} \frac{1}{(n_{\min})^{1/2}} L(A, n, D),$$

where L(A, n, D) is the length of the longest ray in a fixed neighbourhood of D; this result also holds when $D_{-} = \emptyset$ and both n_1 and A_1 are globally $C^{1,1}$. (When $A_1 = I$ and $n_1 = 1$ the rays are straight lines, and so no rays being tangent to Γ_D to infinite order means that the boundary is never flat to infinite order.)

When (i) T = DtN and D_{-} is star-shaped with respect to a point, or (ii) T = ik and D_{-} and D are both star-shaped with respect to the same point, then expressions for C_{bound} are given in [32] when A and n satisfy certain monotonicity conditions in the radial direction. These monotonicity conditions allow for A and n to be discontinuous (with nontrapping jumps), and the results of [32] thus recover the earlier results of [49] for piecewise constant A and n when T = DtN.

4.3 When does Condition 4.2 hold?

Part 1 of Condition 4.2: When D, A, and n satisfy both Condition 4.1 and additional smoothness requirements, Part 1 of Condition 4.2 holds (at least when T = ik) when $k(hk)^{2p} \leq C_1$ for some C_1 depending on C_{bound} .

Indeed, by [53, Theorem 2.39], when D, A, and n satisfy Condition 4.1, T = ik, $\partial D \in C^{p,1}$, $A \in C^{p-1,1}$, and $n \in H^{\max\{p-1, \lceil d/2 \rceil+1\}}$ there exist $C_2, C_3 > 0$, depending on A and n (but not on C_{bound}), such that if

$$k(hk)^{2p} \le \mathcal{C}_2(C_{\text{bound}})^{-1},$$
(4.6)

then Part 1 of Condition 4.1 holds with $C_{\text{FEM1}} = C_3 C_{\text{bound}}$. (We remark that the condition $n \in H^{\max\{p-1, \lceil d/2 \rceil+1\}}$ is imposed in [53, Theorem 2.39] so that if $v \in H^{p-1}(D)$, then $nv \in H^{p-1}(D)$ [53, Page 63, paragraph under Assumption 2.35]; by [36, Theorem 1.4.1.1, Page 21] this property is also ensured by requiring $n \in C^{\min\{p-2,0\},1}(D)$.)

Furthermore, the arguments in [43] show that, when D, A, and n satisfy Condition 4.1, T = DtN, p = 1, $\partial D \in C^{0,1}$, $A \in C^{0,1}$, and $n \in L^{\infty}$, there exist $C_2, C_3 > 0$, depending on A and n (but not on C_{bound}), such that if (4.6) holds, then Part 1 of Condition 4.1 holds with $C_{\text{FEM1}} = C_3 C_{\text{bound}}$. Indeed, while [43, Theorem 1.5] obtains a bound on the *relative error* of the finite-element approximation (rather than the error in terms of the data as in (4.4)), using the bound $\|u\|_{H^2} \leq k C_{\text{bound}} \|f\|_{L^2}$ in [43, Equation 2.5] gives (4.4), with this bound on the H^2 norm following from (4.2) by elliptic regularity; see, e.g., [32, Remark 2.14] and the references therein.

The arguments in both [53] and [43] use the "elliptic-projection" modification of the Schatz duality argument from [66], [67], [14], with these latter papers pioneering this argument for the case A = I and n = 1 (and [14], and subsequently [53], using an additional "error-splitting" technique).

Part 2 of Condition 4.2: When D, A, and n satisfy both Condition 4.1 and additional smoothness requirements, Part 2 of Condition 4.2 holds (at least when T = ik) when $k(hk)^p \leq C_4$ for some C_4 depending on C_{bound} .

Indeed, by [12, Theorem 2.15 and Remark 2.2], when D, A, and n satisfy Condition 4.1, T = ik, $\partial D \in C^{p,1}, A \in C^{p-1,1}$, and $n \in C^{p-1,1}$ then there exists $C_4, C_5 > 0$, depending on A, n (but not C_{bound}) such that if

$$k(hk)^p \leq \mathcal{C}_4(C_{\text{bound}})^{-1},$$

then

$$\|u - u_h\|_{H^1_k(D)} \le \mathcal{C}_5 \min_{v_h \in V_{h,p}} \|u - v_h\|_{H^1_k(D)}$$
(4.7)

i.e. the finite-element approximation is quasi-optimal. Lemma 5.10 shows that, if Condition 4.1 holds, then $||u||_{H_{L}^{1}(D)} \leq k ||F||_{(H_{L}^{1}(D))^{*}}$, and then, setting $v_{h} = 0$ in (4.7), we see that (4.5) holds.

5 Proofs of Theorems 2.2, 2.3, 2.9 and 2.10 and Lemma 2.4

5.1 Preliminary results about the variational formulation and finiteelement method

Inverse inequality. Recall that for $s \ge 2$ there exists $C_{inv,s} > 0$ (depending on the constant in the definition of quasi-uniformity – see [8, Equation 4.4.15]) such that

$$\|v_{h,p}\|_{L^{s}(D)} \leq C_{\text{inv},s} h^{d\left(\frac{1}{s} - \frac{1}{2}\right)} \|v_{h,p}\|_{L^{2}(D)} \quad \text{for all } v_{h,p} \in V_{h,p};$$
(5.1)

see [8, Theorem 4.5.11 and Remark 4.5.20]; observe that if s = 2 then $C_{inv,s} = 1$.

Lemma 5.1 (Norm equivalences of FE functions) There exist $m_{\pm} > 0$ and $s_{\pm} > 0$, independent of h (but dependent on p), such that

$$m_{-}h^{d/2} \|\mathbf{v}\|_{2} \le \|v_{h}\|_{L^{2}(D)} \le m_{+}h^{d/2} \|\mathbf{v}\|_{2},$$
(5.2)

and

$$\|\nabla v_h\|_{L^2(D)} \le s_+ h^{d/2 - 1} \|\mathbf{v}\|_2,\tag{5.3}$$

for all finite-element functions $v_h = \sum_i v_i \phi_i \in V_{h,p}$.

Sketch proof The inequalities (5.2) can be proved by direct computation, and then (5.3) obtained from (5.2) by the inverse inequality

$$\|\nabla v_h\|_{L^2} \lesssim h^{-1} \|v_h\|_{L^2} \tag{5.4}$$

[8, Theorem 4.5.11 and Remark 4.5.20]. For the details, see [53, Proof of Lemma 4.6]. \Box

Remark 5.2 (Relaxing the assumption of quasi-uniformity) We assume that $(\mathcal{T}_h)_{h>0}$ is a quasi-uniform family of meshes so that we can use the inverse inequalities (5.1) and (5.4). Nevertheless,

(i) We see below that the proof of Theorem 2.2 does not use either (5.1) or (5.4), and so Theorem 2.2 holds without the quasi-uniformity assumption.

(ii) We expect that analogues of some of the results in Theorems 2.3, 2.9, and 2.10 can be obtained for shape-regular meshes, following the techniques in the proofs [26, Section 3.4 and 4.1.2] (see Remark 5.11 for discussion on how the results of [26] are related to those in the present paper). Indeed, [26] contains bounds on preconditioned mass matrices, analogous to those in Lemma 5.7. From the way Lemma 5.7 is used in the proofs of Theorems 2.3, 2.9, and 2.10, we expect that analogues of these results with $A_1 = A_2$ hold in the case of shape-regular meshes. However, [26] does not contain any results on preconditioned stiffness matrices analogous to Lemma 5.8. Therefore, from the way Lemma 5.8 is used in the proofs of Theorems 2.3, 2.9, and 2.10, it is unclear at this point whether analogues of these results with $A_1 \neq A_2$ can be obtained in the case of shape-regular meshes.

5.2 Proofs of Theorems 2.9 and 2.10

In this subsection we prove Theorems 2.9 and 2.10; in the next subsection we indicate how the proofs can be modified slightly to prove Theorems 2.2 and 2.3.

The main ingredient of the proofs of Theorems 2.9 and 2.10 is the following lemma, which we prove in §5.2.2.

Lemma 5.3 Assume that

- D_- , A_1 , and n_1 , satisfy Condition 4.1, and
- D_- , A_1 , n_1 , h and p, satisfy Condition 4.2.

Let m_{\pm} and s_{\pm} be given as in Lemma 5.1. Given $k_0 > 0$ and q > 2, let

(5.8)

and

$$\max\left\{\left\|\mathbf{I} - (\mathbf{A}_{1})^{-1}\mathbf{A}_{2}\right\|_{2}, \left\|\mathbf{I} - \mathbf{A}_{2}(\mathbf{A}_{1})^{-1}\right\|_{2}\right\}$$

$$\leq \widetilde{C}_{1}\left(\frac{s_{+}}{m_{-}}\right)h^{-d/q-1}\|A_{1} - A_{2}\|_{L^{q}(D, \mathrm{op})} + \widetilde{C}_{2}\left(\frac{m_{+}}{m_{-}}\right)kh^{-d/q}\|n_{1} - n_{2}\|_{L^{q}(D, \mathbb{R})}.$$

5.2.1 Proofs of Theorems 2.9 and 2.10 assuming Lemma 5.3

 Let

$$W_{\mathbf{D}}(\mathbf{C}) := \Big\{ (\mathbf{C}\mathbf{x}, \mathbf{x})_{\mathbf{D}} : \mathbf{x} \in \mathbb{C}^{N}, \|\mathbf{x}\|_{\mathbf{D}} = 1 \Big\};$$

 $W_{\mathbf{D}}(\mathbf{C})$ is called the *numerical range* or *field of values* of \mathbf{C} (in the $(\cdot, \cdot)_{\mathbf{D}}$ inner product).

Theorem 5.4 (Elman estimate for weighted GMRES) Let C be a matrix with $0 \notin W_{\mathbf{D}}(\mathbf{C})$. Let $\beta \in [0, \pi/2)$ be defined such that

If the matrix equation $\mathbf{C}\mathbf{x} = \mathbf{y}$ is solved using weighted GMRES then, for $m \in \mathbb{N}$, the GMRES residual \mathbf{r}_m satisfies

The bound (5.11) with $\mathbf{D} = \mathbf{I}$ was first proved in [18, Theorem 6.3] (see also [17, Theorem 3.3]) and was written in the above form in [6, Equation 1.2]. The bound (5.11) for arbitrary Hermitian positive-definite \mathbf{D} was stated implicitly (without proof) in [9, p. 247] and proved in [34, Theorem 5.1].

Theorem 5.4 has the following corollary, and the proofs of Theorems 2.9 and 2.10 follow from combining this with Lemma 5.3.

Corollary 5.5 If $\|\mathbf{I} - \mathbf{C}\|_{\mathbf{D}} \le \alpha < 1$, then, with β defined as in (5.10),

Proof of Theorem 2.9 We first prove the bound for the left-preconditioned system (2.4) (i.e. involving $(\mathbf{A}_1)^{-1}\mathbf{A}_2$). By (2.20) and Lemma 5.3 we can apply Corollary 5.5 with $\mathbf{C} = (\mathbf{A}_1)^{-1}\mathbf{A}_2$, $\mathbf{D} = \mathbf{D}_k$, and $\alpha = 1/2$. Therefore

The bound (5.8) in Lemma 5.3 implies that $\|(\mathbf{A}_1)^{-1}\mathbf{A}_2\|_{\mathbf{D}_k} \leq 1 + \alpha = 3/2$. To obtain a bound on $\|(\mathbf{A}_2)^{-1}\mathbf{A}_1\|_{\mathbf{D}_k}$, we observe that, since D, A_2, n_2, h , and p are assumed to satisfy Conditions 4.1 and 4.2, the argument of Lemma 5.3 can be repeated with the indices 1 and 2 swapped, resulting in the bound $\|(\mathbf{A}_2)^{-1}\mathbf{A}_1\|_{\mathbf{D}_k} \leq 3/2$. Inputting these bounds on $\|(\mathbf{A}_1)^{-1}\mathbf{A}_2\|_{\mathbf{D}_k}$ and $\|(\mathbf{A}_2)^{-1}\mathbf{A}_1\|_{\mathbf{D}_k}$ into (5.13), the result follows.

The bound for the right-preconditioned system (2.5) follows in an analogous way, with $\mathbf{C} = \mathbf{A}_2(\mathbf{A}_1)^{-1}$, $\mathbf{D} = (\mathbf{D}_k)^{-1}$, and $\alpha = 1/2$.

Proof of Theorem 2.10 This follows from Lemma 5.3 in an analogous way to the proof of Theorem 2.9, except with $\mathbf{D} = \mathbf{I}$ and using (5.9) instead of (5.8).

Remark 5.6 (The improvement of the Elman estimate (5.11) in [6]) A stronger result than (5.11) is given for standard (unweighted) GMRES in [6, Theorem 2.1], and then converted to a result about weighted GMRES in [7, Theorem 5.3]. In the bound of [6, Theorem 2.1], the convergence factor $\sin \beta$ is replaced by a function of β strictly less than $\sin \beta$ for $\beta \in (0, \pi/2)$. Using this stronger result, however, does not improve the k-dependence in the bounds of Theorems 2.9 or 2.10.

5.2.2 Proof of Lemma 5.3

To prove Lemma 5.3 we need the following two lemmas.

Lemma 5.7 (Bounds on $(\mathbf{A}_1)^{-1}\mathbf{M}_n$ and $\mathbf{M}_n(\mathbf{A}_1)^{-1}$) Assume that D, A_1 , and n_1 satisfy Condition 4.1 and that D, A_1, n_1, h , and p satisfy Part 1 of Condition 4.2. Let m_{\pm} be as in Lemma 5.1 and let \widetilde{C}_1 and \widetilde{C}_2 be given by (5.5). Then, for all $n \in L^{\infty}(D; \mathbb{R}), q > 2$, and $k \ge k_0$,

(5.14)

and

$$\max\left\{ \left\| \left(\mathbf{A}_{1}\right)^{-1} \mathbf{M}_{n} \right\|_{2}, \left\| \mathbf{M}_{n} \left(\mathbf{A}_{1}\right)^{-1} \right\|_{2} \right\} \leq \widetilde{C}_{2} \left(\frac{m_{+}}{m_{-}} \right) h^{-d/q} \frac{\|n\|_{L^{q}(D,\mathbb{R})}}{k}.$$
 (5.15)

Lemma 5.8 (Bounds on $(\mathbf{A}_1)^{-1}\mathbf{S}_A$ and $\mathbf{S}_A(\mathbf{A}_1)^{-1}$) Assume that D, A_1 , and n_1 satisfy Condition 4.1 and that D, A_1, n_1, h , and p satisfy Part 2 of Condition 4.2. Let m_{\pm} and s_{\pm} be as in Lemma 5.1 and let \widetilde{C}_1 and \widetilde{C}_2 be given by (5.5). Then for all $A \in L^{\infty}(D, \mathsf{SPD})$, q > 2, and $k \ge k_0$,

$$\max\left\{ \left\| (\mathbf{A}_{1})^{-1} \mathbf{S}_{A} \right\|_{\mathbf{D}_{k}}, \left\| \mathbf{S}_{A} (\mathbf{A}_{1})^{-1} \right\|_{\mathbf{D}_{k}^{-1}} \right\} \leq \widetilde{C}_{1} h^{-d/q} k \|A\|_{L^{q}(D, \mathrm{op})}$$
(5.16)

and

$$\max\left\{ \left\| \left(\mathbf{A}_{1}\right)^{-1} \mathbf{S}_{A} \right\|_{2}, \left\| \mathbf{S}_{A} \left(\mathbf{A}_{1}\right)^{-1} \right\|_{2} \right\} \leq \widetilde{C}_{1} \left(\frac{s_{+}}{m_{-}} \right) h^{-d/q-1} \|A\|_{L^{q}(D,\mathbb{R})}.$$
(5.17)

Proof of Lemma 5.3 using Lemmas 5.7 and 5.8 Using the definition of the matrices \mathbf{A}_j , \mathbf{S}_A , and \mathbf{M}_n in (3.10) and (3.9), we have

and similarly

The bounds in (5.8) on $\|\mathbf{I} - (\mathbf{A}_1)^{-1}\mathbf{A}_2\|_{\mathbf{D}_k}$ and $\|\mathbf{I} - \mathbf{A}_2(\mathbf{A}_1)^{-1}\|_{\mathbf{D}_k^{-1}}$ then follow from using the bounds (5.14), (5.16) in (5.18) and (5.19). The bounds in (5.9) on $\|\mathbf{I} - (\mathbf{A}_1)^{-1}\mathbf{A}_2\|_2$ and $\|\mathbf{I} - \mathbf{A}_2(\mathbf{A}_1)^{-1}\|_2$ follow completely analogously, except we use the bounds (5.15) and (5.17).

Remark 5.9 (Bounds for right-preconditioning) For brevity, we only prove the bounds on $(\mathbf{A}_1)^{-1}\mathbf{M}_n$ in Lemma 5.7 and not those on $\mathbf{M}_n(\mathbf{A}_1)^{-1}$. Similarly, we only prove the bounds on $(\mathbf{A}_1)^{-1}\mathbf{S}_A$ in Lemma 5.8 and not those on $\mathbf{S}_A(\mathbf{A}_1)^{-1}$. The proofs of the bounds on $\mathbf{M}_n(\mathbf{A}_1)^{-1}$ can be found in [53, Proof of Lemma 4.19], and the proofs of the bounds on $\mathbf{S}_A(\mathbf{A}_1)^{-1}$ can be found in [53, Proof of Lemma 4.20].

These proofs rely on the fact that, from the definitions of $\|\cdot\|_{\mathbf{D}_k}$ and $\|\cdot\|_{(\mathbf{D}_k)^{-1}}$ in (2.1), for any matrix $\mathbf{C} \in \mathbb{C}^{N \times N}$, $\|\mathbf{C}\|_{\mathbf{D}_k} = \|\mathbf{C}^{\dagger}\|_{(\mathbf{D}_k)^{-1}}$, where \mathbf{C}^{\dagger} is the conjugate transpose of \mathbf{C} (i.e. the adjoint with respect to $(\cdot, \cdot)_2$). This result follows from the fact that, for all $\mathbf{v}_j \in \mathbb{C}^N$,

where $\mathbf{w}_j := (\mathbf{D}_k)^{-1} \mathbf{v}_j$, j = 1, 2, . Therefore, since \mathbf{M}_n and \mathbf{S}_A are real, symmetric matrices

The matrix $(\mathbf{A}_1)^{\dagger}$ is the Galerkin matrix corresponding to the adjoint variational problem to (3.5). The key point is that if Conditions 4.1 and 4.2 are satisfied for the variational problem (3.5), then one can also show that they are satisfied for the adjoint problem. Therefore, the bound in (5.14) on $\|\mathbf{M}_n(\mathbf{A}_1)^{-1}\|_{(\mathbf{D}_k)^{-1}}$ follows from the bound on $\|(\mathbf{A}_1)^{-1}\mathbf{M}_n\|_{\mathbf{D}_k}$, and the bound in (5.16) on $\|(\mathbf{A}_1)^{-1}\mathbf{S}_A\|_{\mathbf{D}_k}$ also holds for $\|((\mathbf{A}_1)^{\dagger})^{-1}\mathbf{S}_A\|_{\mathbf{D}_k}$. This type of duality argument was first used in [26] and [34].

Proof of the bounds on $(\mathbf{A}_1)^{-1}\mathbf{M}_n$ in Lemma 5.7 We first concentrate on proving (5.14). Given $\mathbf{f} \in \mathbb{C}^N$ and $n \in L^{\infty}(D; \mathbb{R})$, we create a variational problem whose Galerkin discretisation leads to the equation $\mathbf{A}_1 \widetilde{\mathbf{u}} = \mathbf{M}_n \mathbf{f}$. Indeed, let $\tilde{f} := \sum_j f_j \phi_j \in H^1_{0,D}(D)$. Define \widetilde{u} to be the solution of the variational problem

and let $\widetilde{\mathbf{u}}$ be the vector of nodal values of \widetilde{u}_h . The definition of \widetilde{f} then implies that (5.21) is equivalent to the linear system $\mathbf{A}_1 \widetilde{\mathbf{u}} = \mathbf{M}_n \mathbf{f}$. Since $\mathbf{f} \in \mathbb{C}^N$ was arbitrary, to obtain a bound on $\|(\mathbf{A}_1)^{-1}\mathbf{M}_n\|_{\mathbf{D}_k}$ we need to bound $\|\widetilde{\mathbf{u}}\|_{\mathbf{D}_k}$ in terms of $\|\mathbf{f}\|_{\mathbf{D}_k}$. Because of the definition (2.1) of $\|\cdot\|_{\mathbf{D}_k}$, this is equivalent to bounding $\|\widetilde{u}_h\|_{H^1_t(D)}$ in terms of $\|\widetilde{f}\|_{H^1_t(D)}$.

Using the triangle inequality and the bounds (4.4) and (4.2) from Conditions 4.2 and 4.1 respectively, we find

Hölder's inequality implies that, if q, s > 2 such that 1/2 = 1/q + 1/s, then

Since $\tilde{f} \in V_{h,p}$, we can use the inverse inequality (5.1) in (5.23), and combining the result with (5.22) we obtain that

(5.24)

The bound on $\|(\mathbf{A}_1)^{-1}\mathbf{M}_n\|_{\mathbf{D}_k}$ in (5.14) then follows from the definition (2.1) of $\|\cdot\|_{\mathbf{D}_k}$ and the definition (5.5) of \widetilde{C}_2 .

To prove the bound on $\|(\mathbf{A}_1)^{-1}\mathbf{M}_n\|_2$ in (5.15), we use the consequences of (5.2)

The proof of the bounds on $(\mathbf{A}_1)^{-1}\mathbf{S}_A$ in Lemma 5.8 uses the following lemma, which one can prove using fact that the sesquilinear form *a* satisfies a Gårding inequality; see [32, Lemma 5.1].

Proof of the bounds on $(\mathbf{A}_1)^{-1}\mathbf{S}_A$ in Lemma 5.8 In a similar way to the proof of Lemma 5.7, given $\mathbf{f} \in \mathbb{C}^N$ and $A \in L^{\infty}(D; \text{SPD})$, let $\tilde{f} := \sum_j f_j \phi_j$ and observe that $\tilde{f} \in H^1_{0,D}(D)$. Define \tilde{u} to be the solution of the variational problem

$$a_1(\widetilde{u}, v) = \widetilde{F}(v) \quad \text{for all } v \in H^1_{0, \mathcal{D}}(D), \quad \text{where} \quad \widetilde{F}(v) := \left(A\nabla \widetilde{f}, \nabla v\right)_{L^2(D)}.$$
(5.26)

Observe that the definitions (4.3) and (2.12) of the norms $\|\cdot\|_{(H_k^1(D))^*}$ and $\|\cdot\|_{H_k^1(D)}$, respectively, and the Cauchy-Schwarz inequality imply that

$$\left\|\widetilde{F}\right\|_{(H^1_k(D))^*} \le \left\|A\nabla\widetilde{f}\right\|_{L^2(D)}.$$

With $\|\cdot\|_{L^q(D,\text{op})}$ defined by (2.19), Hölder's inequality implies that, with q, s > 2 such that 1/2 = 1/q + 1/s,

$$\left\|A\nabla f\right\|_{L^{2}(D)} \leq \|A\|_{L^{q}(D, \operatorname{op})} \left\|\nabla f\right\|_{L^{s}(D)}$$

Combining this with the inverse inequality (5.1) we then have that

$$\|\widetilde{F}\|_{(H^{1}_{k}(D))^{*}} \leq \|A\|_{L^{q}(D,\mathrm{op})} \|\nabla\widetilde{f}\|_{L^{s}(D)} \leq C_{\mathrm{inv},s} \|A\|_{L^{q}(D,\mathrm{op})} h^{d\left(\frac{1}{s}-\frac{1}{2}\right)} \|\nabla\widetilde{f}\|_{L^{2}(D)}.$$
(5.27)

Let \tilde{u}_h be the solution of the finite-element approximation of (5.26), i.e.,

$$a_1(\widetilde{u}_h, v_h) = F(v_h) \quad \text{for all } v_h \in V_{h,p}, \tag{5.28}$$

and let $\tilde{\mathbf{u}}$ be the vector of nodal values of \tilde{u}_h . The definition of \tilde{f} then implies that (5.28) is equivalent to $\mathbf{A}_1 \tilde{\mathbf{u}} = \mathbf{S}_A \mathbf{f}$.

Similar to the proof of the bounds on $(\mathbf{A}_1)^{-1}\mathbf{M}_n$ in Lemma 5.7, using the triangle inequality, the bound (4.5) from Condition 4.2, the bound (5.25) from Lemma 5.10, the bound (5.27), and the definition (5.6) of C_1 , we find

$$\begin{split} \|\widetilde{u}_{h}\|_{H_{k}^{1}(D)} &\leq \|\widetilde{u} - \widetilde{u}_{h}\|_{H_{k}^{1}(D)} + \|\widetilde{u}\|_{H_{k}^{1}(D)}, \\ &\leq \left[C_{\text{FEM2}}^{(1)}k + \frac{1}{\min\{A_{1\min}, n_{1\min}\}} \left(1 + 2C_{\text{bound}}^{(1)}n_{1\max}k \right) \right] \|\widetilde{F}\|_{(H_{k}^{1}(D))^{*}}, \\ &\leq C_{1} k C_{\text{inv},s} \|A\|_{L^{q}(D,\text{op})} h^{d\left(\frac{1}{s} - \frac{1}{2}\right)} \|\nabla\widetilde{f}\|_{L^{2}(D)}, \\ &\leq C_{1} k C_{\text{inv},s} \|A\|_{L^{q}(D,\text{op})} h^{d\left(\frac{1}{s} - \frac{1}{2}\right)} \|\widetilde{f}\|_{H_{k}^{1}(D)}, \end{split}$$
(5.29)

and the bound on $\|(\mathbf{A}_1)^{-1}\mathbf{S}_A\|_{\mathbf{D}_k}$ in (5.16) follows since 1/q = 1/2 - 1/s. To prove the bound on $\|(\mathbf{A}_1)^{-1}\mathbf{S}_A\|_2$ in (5.17), we use the bounds

 $m_{-}h^{d/2}k\|\widetilde{\mathbf{u}}\|_{2} \leq k\|\widetilde{u}_{h}\|_{L^{2}(D)} \leq \|\widetilde{u}_{h}\|_{H^{1}_{k}(D)} \text{ and } \|\nabla\widetilde{f}\|_{L^{2}(D)} \leq s_{+}h^{d/2-1}\|\mathbf{f}\|_{2},$

on either side of the inequality (5.29), with these bounds coming from (5.2) and (5.3) respectively. \Box

Remark 5.11 (Link to the results of [26]) A result analogous to the Euclidean-norm bounds in Lemma 5.3 was proved in [26, Theorem 1.4] for the case that $A_1 = A_2 = I$, $n_2 = 1$, and $n_1 = 1 + i\varepsilon/k^2$, with the 'absorption parameter' or 'shift' ε satisfying $0 < \varepsilon \leq k^2$. This is equivalent to approximating the discrete inverse of $\Delta + k^2$ by the discrete inverse of $\Delta + k^2 + i\varepsilon$. The motivation for proving this result was that the so-called 'shifted Laplacian preconditioning' of the Helmholtz equation (introduced in [19]) is based on preconditioning, with these choices of parameters, \mathbf{A}_2 with an approximation of \mathbf{A}_1 . Similar to the proofs of Theorems 2.9 and 2.10 in §5.2.1, bounds on $\|\mathbf{I} - (\mathbf{A}_1)^{-1}\mathbf{A}_2\|_2$ and $\|\mathbf{I} - \mathbf{A}_2(\mathbf{A}_1)^{-1}\|_2$ then give upper bounds on how large the 'shift' ε can be for GMRES for $(\mathbf{A}_1)^{-1}\mathbf{A}_2$ to converge in a k-independent number of iterations in the case when the action of $(\mathbf{A}_1)^{-1}$ is computed exactly.

The main differences between [26] and this work are that (i) [26] focuses only on the case when T = ik, (ii) the theory in [26] focuses on the particular case that D_{-} is star-shaped with respect to a ball, finding a k- and ε -explicit expression for $C_{\text{bound}}^{(1)}$ in this case using Morawetz identities, (iii) the proof of [26, Theorem 1.4] requires bounds on $(\mathbf{A}_1)^{-1}\mathbf{M}_n$, $\mathbf{M}_n(\mathbf{A}_1)^{-1}$ (analogous to the bounds in Lemma 5.7), $(\mathbf{A}_1)^{-1}\mathbf{N}$, and $\mathbf{N}(\mathbf{A}_1)^{-1}$, but not on $(\mathbf{A}_1)^{-1}\mathbf{S}_A$ and $\mathbf{S}_A(\mathbf{A}_1)^{-1}$, (iv) [26, Theorem 1.4] holds under the assumption that the finite-element approximation is quasi-optimal, whereas here we prove results under Condition 4.2, which holds under less restrictive conditions on h and p than those for quasioptimality (see §4.3), and (v) [26] only proves bounds on $\mathbf{I} - (\mathbf{A}_1)^{-1}\mathbf{A}_2$ and $\mathbf{I} - \mathbf{A}_2(\mathbf{A}_1)^{-1}$ in the $\|\cdot\|_2$ norm whereas here we also prove bounds in weighted norms.

5.3 Proofs of Theorems 2.2 and 2.3 from Theorems 2.9 and 2.10

Theorems 2.2 and 2.3 follow from repeating the proofs of Theorems 2.9 and 2.10 but now, instead of using Hölder's inequality (5.23), using the simpler inequality

$$\|n\widetilde{f}\|_{L^{2}(D)} \leq \|n\|_{L^{\infty}(D)} \||\widetilde{f}\|_{L^{2}(D)}.$$

The result is that the inverse inequality (5.1) is no longer needed in (5.24) to obtain $\|\tilde{f}\|_{L^2(D)}$ from $\|\tilde{f}\|_{L^s(D)}$. Then Lemmas 5.7, 5.8, and 5.3, and Theorems 2.9 and 2.10 all hold without the factors $h^{-d/q}$ on the right-hand sides of the inequalities, and with the constants \tilde{C}_j , j = 1, 2, replaced by C_j , j = 1, 2. This is equivalent to these results holding with q set formally as ∞ , since $C_{\text{inv},s} = 1$ when s = 2 (which occurs when $q = \infty$), as noted immediately after (5.1).

The end result is that the condition (2.20) in Theorem 2.9 is replaced by the condition (2.3) in Theorem 2.2 and similarly (2.21) in Theorem 2.10 is replaced by (2.6) in Theorem 2.3.

5.4 Proof of Lemma 2.4

Let \mathbf{r}^{ℓ} denote the ℓ th residual of weighted GMRES in the norm $\|\cdot\|_{\mathbf{D}_k}$ (as in the proof of Theorem 2.9 in §5.2.1), and let \mathbf{r}_s^{ℓ} denote the ℓ th residual of standard GMRES. By the minimal residual property (3.11),

$$\left\|\mathbf{r}_{s}^{\ell}\right\|_{2} \leq \left\|\mathbf{r}^{\ell}\right\|_{2} \quad \text{for all } \ell \in \mathbb{N}.$$

By assumption $\mathbf{r}_s^0 = \mathbf{r}^0$, and so

$$\frac{\left\|\mathbf{r}_{s}^{\ell}\right\|_{2}}{\left\|\mathbf{r}_{s}^{0}\right\|_{2}} \leq \frac{\left\|\mathbf{r}^{\ell}\right\|_{2}}{\left\|\mathbf{r}^{0}\right\|_{2}} \quad \text{for all } \ell \in \mathbb{N}.$$

$$(5.30)$$

By Lemma 5.1, the norm property (2.2), and the fact that $hk \leq Ck^{-\delta}$, there exists $\tilde{C} > 0$, dependent only on s_+, m_+, k_0, C , and δ , such that

$$m_1 k h^{d/2} \|\mathbf{v}\|_2 \le \|\mathbf{v}\|_{\mathbf{D}_k} \le \widetilde{C} h^{d/2-1} \|\mathbf{v}\|_2 \quad \text{for all } k \ge k_0.$$
 (5.31)

Therefore, by the combination of (5.30), (5.31), and the fact that $hk = Ck^{-\delta}$,

$$\frac{\|\mathbf{r}_{s}^{\ell}\|_{2}}{\|\mathbf{r}_{s}^{0}\|_{2}} \leq \frac{\widetilde{C}}{m_{-}(hk)} \frac{\|\mathbf{r}^{\ell}\|_{\mathbf{D}_{k}}}{\|\mathbf{r}^{0}\|_{\mathbf{D}_{k}}} \leq \frac{\widetilde{C}}{m_{-}C} k^{\delta} \frac{\|\mathbf{r}^{\ell}\|_{\mathbf{D}_{k}}}{\|\mathbf{r}^{0}\|_{\mathbf{D}_{k}}} \quad \text{for all } \ell \in \mathbb{N} \text{ and } k \geq k_{0}.$$
(5.32)

Since (2.3) holds, the proof of Theorem 2.2 (in particular (5.12)) shows that

 $\left\|\mathbf{r}^{\ell}\right\|_{\mathbf{D}_{k}} \le c^{\ell} \left\|\mathbf{r}^{0}\right\|_{\mathbf{D}_{k}} \quad \text{for all } \ell \in \mathbb{N},$ (5.33)

with $c := 2\sqrt{2}/3 < 1$. Therefore, combining (5.32) and (5.33), we find that

$$\frac{\left\|\mathbf{r}_{s}^{\ell+n}\right\|_{2}}{\left\|\mathbf{r}_{s}^{0}\right\|_{2}} \leq \frac{\widetilde{C}}{m_{-}C} k^{\delta} \frac{\left\|\mathbf{r}^{\ell+n}\right\|_{\mathbf{D}_{k}}}{\left\|\mathbf{r}^{0}\right\|_{\mathbf{D}_{k}}} \leq \frac{\widetilde{C}}{m_{-}C} k^{\delta} c^{\ell+n} \quad \text{for all } \ell, n \in \mathbb{N} \text{ and } k \geq k_{0}.$$

Therefore, if n is such that

$$\frac{\widetilde{C}}{m_{-}C}k^{\delta}c^{n} \le 1, \tag{5.34}$$

and $\ell \geq \log(1/\varepsilon)/\log(1/c)$, then

$$\frac{\left\|\mathbf{r}_{s}^{\ell+n}\right\|_{2}}{\left\|\mathbf{r}_{s}^{0}\right\|_{2}} \le \varepsilon.$$

Arguing exactly as in (5.13) in the proof of Theorem 2.2, we see that the result of the lemma, i.e., the bound (2.8), holds if $m \ge \log(1/\varepsilon)/\log(1/c) + n$ where n is such that (5.34) holds. The lower bound (2.7) on m then follows with $\mathcal{C} := \log(\widetilde{C}/(m_{-}C))$, since by (5.34) $n \ge (\mathcal{C} + \delta \log k)/\log(1/c)$.

6 Proofs of Theorem 2.6 and Lemma 2.7

Proof of Theorem 2.6 Since $a_1(u_1, v) = F(v)$ and $a_2(u_2, v) = F(v)$, we have

$$a_1(u_1 - u_2, v) = \widetilde{F}(v)$$
 for all $v \in H^1_{0,D}(D)$ (6.1)

where

$$\widetilde{F}(v) := \int_D \left((A_2 - A_1) \nabla u_2 \right) \cdot \overline{\nabla v} + k^2 (n_1 - n_2) u_2 \overline{v}.$$

Now, by the Cauchy-Schwarz inequality and the definition (2.12) of the norm $\|\cdot\|_{H^1_k(D)}$, we have that

$$\begin{split} |\widetilde{F}(v)| &\leq \left\|A_{1} - A_{2}\right\|_{L^{\infty}(D;\mathrm{op})} \left\|\nabla u_{2}\right\|_{L^{2}(D)} \|\nabla v\|_{L^{2}(D)} \\ &+ k^{2} \left\|n_{1} - n_{2}\right\|_{L^{\infty}(D;\mathbb{R})} \left\|u_{2}\right\|_{L^{2}(D)} \|v\|_{L^{2}(D)} \\ &\leq \max\left\{\left\|A_{1} - A_{2}\right\|_{L^{\infty}(D;\mathrm{op})}, \left\|n_{1} - n_{2}\right\|_{L^{\infty}(D;\mathbb{R})}\right\} \left\|u_{2}\right\|_{H^{1}_{k}(D)} \|v\|_{H^{1}_{k}(D)}. \end{split}$$

and thus, by the definition (4.3) of the norm $\|\cdot\|_{(H^1_h(D))*}$,

$$\|\widetilde{F}\|_{(H^1_k(D))*} \le \max\left\{ \|A_1 - A_2\|_{L^{\infty}(D; \operatorname{op})}, \|n_1 - n_2\|_{L^{\infty}(D; \mathbb{R})} \right\} \|u_2\|_{H^1_k(D)}.$$

Since Condition 4.1 holds, we can then apply the result of Lemma 5.10, i.e. the bound (5.25), to the solution of the variational problem (6.1) to find that

$$\frac{\|u_1 - u_2\|_{H^1_k(D)}}{\|u_2\|_{H^1_k(D)}} \le \frac{1}{\min\left\{A_{1\min}, n_{1\min}\right\}} \left(1 + 2C^{(1)}_{\text{bound}} n_{1\max}k\right) \\ \times \left(\max\left\{\left\|A_1 - A_2\right\|_{L^{\infty}(D; \text{op})}, \left\|n_1 - n_2\right\|_{L^{\infty}(D; \mathbb{R})}\right\}\right),$$

and then the result (2.13) follows with

...

...

$$C_3 := \frac{1}{\min\left\{A_{1\min}, n_{1\min}\right\}} \left(\frac{1}{k_0} + 2C_{\text{bound}}^{(1)} n_{1\max}\right).$$
(6.2)

Proof of Lemma 2.7 We actually prove the stronger result that, given any function c(k) such that c(k) > 0 for all $k \ge k_0$, there exist f, n_1, n_2 , with $n_1 \ne n_2$ and

$$\left\|n_1 - n_2\right\|_{L^{\infty}(D;\mathbb{R})} \sim c(k),$$

such that the corresponding solutions u_1 and u_2 of the exterior Dirichlet problem with $A_1 = A_2 = I$ exist, are unique, and satisfy (2.14).

The heart of the proof of (2.14) is the equation

$$(\Delta + k^2) \left(\mathrm{e}^{\mathrm{i}kr} \chi(r) \right) = \mathrm{e}^{\mathrm{i}kr} \left(\mathrm{i}k \frac{d-1}{r} \chi(r) + 2\mathrm{i}k \frac{\mathrm{d}\chi}{\mathrm{d}r}(r) + \Delta\chi(r) \right) =: -\widetilde{f}(r), \tag{6.3}$$

where $\chi(r)$ is chosen to have supp $\chi \subset D$. This example proves the sharpness of the nontrapping resolvent estimate (4.2) as $k \to \infty$, since both the $L^2(D)$ norm of \tilde{f} and the $H^1_k(D)$ norm of $e^{ikr}\chi(r)$ are proportional to k, and hence each to other (see, e.g., [11, Lemma 3.10], [63, Lemma 4.12]).

The overall idea of the proof of (2.14) is to set things up so that $(u_1 - u_2)(\mathbf{x}) = e^{ikr}\chi(r)$, the rationale being that (6.3) proves the sharpness of (4.2), and (4.2) and its corollary (5.25) (applied to $u_1 - u_2$) are the main ingredients in the proof of Theorem 2.6.

With the choices $A_j := I$, j = 1, 2, and $n_1 := 1$, the variational problem (6.1) implies that

$$(\Delta + k^2)(u_1 - u_2) = k^2 (n_2 - 1)u_2.$$
(6.4)

We now fix $n_2 := 1 + c(k)\tilde{\chi}$ with $\tilde{\chi} \in C^{\infty}(D)$ chosen so that $\tilde{\chi} = \tilde{\chi}(r)$, supp $\tilde{\chi} \subset D$, $\tilde{\chi}$ is positive everywhere in the interior of its support, and $\|\tilde{\chi}\|_{L^{\infty}(D;\mathbb{R})} = 1$; observe that this last condition implies that $\|n_1 - n_2\|_{L^{\infty}(D;\mathbb{R})} = c(k)$. As above, let $\chi = \chi(r)$ with $\chi \in C^{\infty}(D)$ and supp $\chi \subset D$. Then, with \tilde{f} defined by (6.3), we formally define u_2 and f by

$$u_2(\mathbf{x}) := -\frac{1}{k^2 c(k)} \frac{\widetilde{f}(r)}{\widetilde{\chi}(r)}, \quad \text{and} \quad f(\mathbf{x}) := -\left(\Delta + k^2 n_2(\mathbf{x})\right) u_2(\mathbf{x}), \tag{6.5}$$

and we define u_1 to be the solution of the TEDP (in the sense of Definition 3.2) with $n_1 = 1$, g = 0, and f defined as in (6.5). Since $\tilde{\chi}(r)$ has compact support in D, we need to the both the support of $\tilde{\chi}$ and how fast $\tilde{\chi}$ vanishes near the boundary of its support to the definition of χ for both u_2 and f in (6.5) to be well defined. We ignore this issue for the moment and show that these definitions achieve our goal of having

$$u_1(\mathbf{x}) - u_2(\mathbf{x}) = e^{ikx_1}\chi(r).$$
 (6.6)

First observe that since supp \tilde{f} is a compact subset of D, so is supp u_2 . Therefore u_2 is the solution of the TEDP with g = 0, f defined in (6.5), and coefficient $n_2 := 1 + c(k)\tilde{\chi}$. Combining (6.4) with the definitions of n_2 and u_2 , we see that

$$(\Delta + k^2)(u_1 - u_2) = -\tilde{f}.$$
(6.7)

Since the solution of the TEDP is unique (see Remark 3.4), (6.3) and (6.7) imply that (6.6) holds. We therefore have that

$$||u_1 - u_2||_{L^2(D)} \sim 1$$
 and $||u_1 - u_2||_{H^1_k(D)} \sim k$.

Furthermore, the definitions (6.5) and (6.3) of u_2 and \tilde{f} , respectively, imply that

$$\|u_2\|_{L^2(D)} \sim \frac{1}{k c(k)}$$
 and $\|u_2\|_{H^1_k(D)} \sim \frac{1}{c(k)}$

and, since $||n_1 - n_2||_{L^{\infty}(D;\mathbb{R})} = c(k)$, (2.14) holds.

Therefore, to complete the proof, we only need to show that there exists a choice of χ and $\tilde{\chi}$ for which u_2 and f defined by (6.5) are in $H^1(D)$ and $L^2(D)$ respectively (in fact, we prove that they are in $W^{1,\infty}(D)$ and $L^{\infty}(D)$ respectively). Since χ and $\tilde{\chi} \in C^{\infty}(D)$, and $\tilde{\chi}$ is positive everywhere in the interior of its support, the only issue is what happens at the boundary of supp $\tilde{\chi}$, where u_2 could be singular.

By assumption there exist $0 < R_1 < R_2$ such that $\overline{D_-} \subset B_{R_1} \subset B_{R_2} \subset \widetilde{D}$, i.e. there exists an annulus between D_- and $\partial \widetilde{D}$. Let $\operatorname{supp} \chi = B_{R_2} \setminus B_{R_1}$ and let χ vanish to order $m \geq 3$ at $r = R_1$ and $r = R_2$; i.e. $\chi(r) \sim (r - R_1)^m$ as $r \to (R_1)^+$ and $\chi(r) \sim (R_2 - r)^m$ as $r \to (R_2)^-$. The definition (6.3) of \widetilde{f} then implies that \widetilde{f} vanishes to order m - 2. Let $\widetilde{\chi}(r)$ vanish to order $\ell \geq 1$ at $r = R_1$ and $r = R_2$. We now claim that if $m > \ell + 4$, then $u_2 \in W^{1,\infty}(D)$ and $f \in L^{\infty}(D)$. Indeed, straightforward calculation from (6.5) shows that $u_2(r) \sim (r - R_1)^{m-\ell-2}$, $\nabla u_2(r) \sim (r - R_1)^{m-\ell-3}$, and $\Delta u_2(r) \sim (r - R_1)^{m-\ell-4}$ as $r \to (R_1)^+$, with analogous behaviour at $r = R_2$. The assumption $m > \ell + 4$ therefore implies that $u_2, \nabla u^{(2)}$, and Δu_2 vanish (and hence are finite) at $r = R_1$ and $r = R_2$.

Remark 6.1 (Why doesn't Lemma 2.7 cover the case $A_1 \neq A_2$?) When $n_j := 1, j = 1, 2, A_1 := I$, and $A_2 := I + c(k)\tilde{\chi}$, the variational problem (6.1) implies that

$$\Delta(u_1 - u_2) + k^2(u_1 - u_2) = c(k)\nabla \cdot (\widetilde{\chi}\nabla u_2).$$

It is now much harder than in (6.4) to set things up so that $u_1(\mathbf{x}) - u_2(\mathbf{x}) = e^{ikr}\chi(r)$ (so that one can then use (6.3)).

Remark 6.2 (The relationship between Q1 and Q1') In §2.2, we stated that Q1' is an analogue of Q1 on the PDE level; we now make this statement more precise.

Since C_3 defined by (6.2) is independent of F, the relative-error bound (2.13) of Theorem 2.6 can be written as

$$\sup_{F \in (H_{0,D}^1(D))^*} \frac{\left\| u_1 - u_2 \right\|_{H_k^1(D)}}{\left\| u_2 \right\|_{H_k^1(D)}} \le C_3 k \max\left\{ \|A_1 - A_2\|_{L^{\infty}(D; \operatorname{op})}, \|n_1 - n_2\|_{L^{\infty}(D; \mathbb{R})} \right\}.$$
(6.8)

Let $\mathcal{A} : H^1_{0,D}(D) \to (H^1_{0,D}(D))^*$ be the operator associated with the sesquilinear form $a(\cdot, \cdot)$ (3.7) so that the variational problem (3.5) is equivalent to the operator equation $\mathcal{A}u = F$ in $(H^1_{0,D}(D))^*$ (for details of this equivalence, see, e.g., [61, Lemma 2.1.38]). Then $\mathcal{A}_j u_j = F$ and the assumptions in Theorem 2.6 imply that \mathcal{A}_1 and \mathcal{A}_2 are both invertible. Using this fact, we see that the left-hand side of (6.8) equals

$$\sup_{F \in (H_{0,D}^{1}(D))^{*}} \frac{\left\| (\mathcal{A}_{1})^{-1}F - (\mathcal{A}_{2})^{-1}F \right\|_{H_{k}^{1}(D)}}{\| (\mathcal{A}_{2})^{-1}F \|_{H_{k}^{1}(D)}} = \sup_{F \in (H_{0,D}^{1}(D))^{*}} \frac{\left\| \left(I - (\mathcal{A}_{1})^{-1}\mathcal{A}_{2} \right) (\mathcal{A}_{2})^{-1}F \right\|_{H_{k}^{1}(D)}}{\| (\mathcal{A}_{2})^{-1}F \|_{H_{k}^{1}(D)}}$$
$$= \left\| I - (\mathcal{A}_{1})^{-1}\mathcal{A}_{2} \right\|_{H_{k}^{1}(D) \to H_{k}^{1}(D)}$$

so that (6.8) becomes

$$\left\| I - (\mathcal{A}_1)^{-1} \mathcal{A}_2 \right\|_{H^1_k(D) \to H^1_k(D)} \le C_3 k \max \Big\{ \|A_1 - A_2\|_{L^\infty(D; \operatorname{op})}, \|n_1 - n_2\|_{L^\infty(D; \mathbb{R})} \Big\}.$$
(6.9)

On the other hand, the main ingredient to proving Theorem 2.2 is the bound

$$\left\| \mathbf{I} - (\mathbf{A}_1)^{-1} \mathbf{A}_2 \right\|_{\mathbf{D}_k} \le \widetilde{C}_1 \, k \|A_1 - A_2\|_{L^{\infty}(D; \mathrm{op})} + \widetilde{C}_2 \, k \|n_1 - n_2\|_{L^{\infty}(D; \mathbb{R})},$$

which implies

$$\left\| \mathbf{I} - (\mathbf{A}_1)^{-1} \mathbf{A}_2 \right\|_{\mathbf{D}_k} \le 2k \max\left\{ \widetilde{C}_1 \| A_1 - A_2 \|_{L^{\infty}(D; \mathrm{op})}, \widetilde{C}_2 \| n_1 - n_2 \|_{L^{\infty}(D; \mathbb{R})} \right\}.$$
 (6.10)

The left-hand side of (6.10) is the discrete analogue of the left-hand side of (6.9). The right-hand sides of these bounds are (up to constants independent of k) identical, hence why we say that the condition (2.11) (i.e. $k \|A_1 - A_2\|_{L^{\infty}(D; \text{op})}$ and $k \|n_1 - n_2\|_{L^{\infty}(D; \mathbb{R})}$ both sufficiently small) is the answer to both Q1 and Q1'.
