

Mean Field Exponential Utility Game: A Probabilistic Approach*

Abstract

We study an N -player and a mean field exponential utility game. Each player manages two stocks; one is driven by an individual shock and the other is driven by a common shock. Moreover, each player is concerned not only with her own terminal wealth but also with the relative performance of her competitors. We use the probabilistic approach to study these two games. We show the unique equilibrium of the N -player game and the mean field game can be characterized by a novel multi-dimensional FBSDE with quadratic growth and a novel mean-field FBSDEs, respectively. The well-posedness result and the convergence result are established.

1 Introduction

In this paper we consider the following N -player exponential utility game

$$\begin{cases} \mathbb{E} \left[-e^{-\alpha^i (X_T^i - \theta^i \bar{X}_T^{-i})} \right] \rightarrow \max, \\ \text{subject to } dX_t^i = \pi_t^i \frac{dS_t^i}{S_t^i} + \pi_t^{i0} \frac{dS_t^{i0}}{S_t^{i0}}, & X_0^i = x^i, \\ i = 1, \dots, N, \end{cases} \quad (1.1)$$

as well as its mean field game (MFG) correspondence

$$\begin{cases} 1. \text{ Fix } \mu. \\ 2. \mathbb{E} \left[-e^{-\alpha(X_T - \theta\mu)} \right] \rightarrow \max, \\ \text{subject to } dX_t = \pi_t \frac{dS_t}{S_t} + \pi_t^0 \frac{dS_t^0}{S_t^0}, & X_0 = x. \\ 3. \mu = \text{Law}(X_T^*) \text{ with } X^* \text{ the optimal state.} \end{cases} \quad (1.2)$$

In (1.1) X^i is the wealth process of player i , S^i and S^{i0} are the price dynamics for the stocks managed by player i , driven by an individual shock and a common shock, respectively, and π^i and π^{i0} are the amount of portfolios invested in these two stocks, respectively. For simplicity, we assume the interest rate is 0. In (1.1), each player is not only concerned with her own terminal wealth X_T^i , but also concerned with the relative performance of her competitors $(X^i - \bar{X}^{-i})$, with $\bar{X}^{-i} = \frac{1}{N-1} \sum_{j \neq i} X^j$ being the average wealth of player i 's competitors. The random variable θ^i valued in $[0, 1]$ is the relative performance factor for player i ; player i is more concerned about the relative performance when θ^i is larger. Similar problems have been considered in Espinosa & Touzi [11], Frei [12], Frei & dos Reis [13], Guéant, Lasry & Lions [18] and Lacker & Zariphopoulou [33]. In [11–13], it is assumed that all players manage common stocks, i.e., $\pi^i \equiv 0$ and $S^{i0} = S$ for all i , with various trading constraints. In particular, using a BSDE approach [11] shows the existence and uniqueness of a Nash equilibrium for unconstrained agents with general utility and constrained agents with exponential utility in Black-Scholes model (deterministic return rate and volatility). Moreover, a convergence result as the number of players goes to infinity is established as well. [13] considers a similar problem as [11] and shows when the equilibrium does not exist by constructing counterexamples, where the BSDE characterizing the equilibrium has no solution. In [12], a similar problem as in [11, 13] is considered to illustrate the notion of split solutions of BSDEs. In [18], a static competitive Markowitz model is studied. In [33], each player is assumed to trade one stock that is correlated with the stocks managed by the competitors. Under this framework an N -player game and an MFG are analyzed in a constant setting, i.e., all the coefficients are assumed to be independent of time. Recently, dos Reis & Platonov in [39] study a similar MFG under relative performance with forward utilities, also under constant setting.

In this paper, using a probabilistic approach we analyze (1.1) and (1.2) in a general non-Markovian setting, which is beyond the constant setting. Unlike [11–13], the trading constraint is not considered here. We characterize the unique equilibrium of (1.1) in terms of a novel multi-dimensional FBSDE with quadratic growth and possibly unbounded terminal condition. The unique equilibrium of the MFG correspondence (1.2) is characterized in terms of a novel mean field FBSDE. Note that we obtain the FBSDE characterization by using martingale optimality principle while [11] and [13] obtain the BSDE characterization by establishing a dynamic programming principle combined with martingale representation and martingale optimality principle. Table 1 compares our model with some closest literatures. The contribution in this paper is three-fold. First, we find the unique Nash equilibrium of the N -player game (1.1) by establishing the well-posedness result of a novel multi-dimensional FBSDE with quadratic growth. Moreover, a convergence result is established to show the equilibrium of the N -player game (1.1) converges to the equilibrium of the MFG correspondence (1.2). Second, under a mild assumption on the relative performance factor θ , we solve the MFG (1.2). Moreover, when the assets' dynamics of all players are independent, the MFG (1.2) can be solved with more general θ , which is allowed to be measurable to the largest σ -algebra. In this case, we solve (1.2) under a weak interaction assumption, that is, when θ is small. In particular, we solve a mean field FBSDE and it has its own interest to establish the global well-posedness result. Finally, when the return rates are independent of the noise, we obtain the equilibria for both the N -player game and the MFG in closed forms, which are beyond constant settings as in [33] and deterministic settings as in [11]. Our equilibrium formulas for the N -player game and the MFG share similar structures; the investment strategy for the stock driven by the individual shock is of Merton type and the investment strategy for the stock driven by the common shock is a weighted sum of a Merton portfolio and the aggregation of the competitors' strategies.

Throughout we work on the filtered probability space $(\Omega, \mathbb{P}, \mathbb{G})$, on which a sequence of independent Brownian motions $\{W, W^0, \{W^n\}_n\}$ are defined. We will use W^0 to characterize the common shock of the stock price for all players, use W^i to characterize the private shock of the stock price for player i in the N -player game and use W to characterize the private shock of the stock price for the representative player in the MFG. Denote by $\mathbb{F}^{(N)}$ the filtration generated by (W^1, \dots, W^N, W^0) , by \mathbb{F}^i the filtration generated by (W^i, W^0) , by \mathbb{F} the filtration generated by (W, W^0) and by \mathbb{F}^0 the filtration generated by

W^0 . All filtrations are understood in a completion sense. In the next two subsections, we introduce the N -player game and the MFG in detail.

1.1 The N -Player Utility Game

Let the price dynamics for the two stocks managed by player i satisfy

$$\frac{dS_t^i}{S_t^i} = b_t^i dt + \sigma_t^i dW_t^i \quad \text{and} \quad \frac{dS_t^{i0}}{S_t^{i0}} = b_t^{i0} dt + \sigma_t^{i0} dW_t^0 \quad (1.3)$$

where (b^i, b^{i0}) and (σ^i, σ^{i0}) are the random return rates and volatilities of the two stocks and $\bar{W}^i := (W^i, W^0)^\top$. Assume the volatilities σ^i and σ^{i0} are non-degenerate. Let π^i and π^{i0} be the amount of money invested into the two stocks. The wealth process of player i follows

$$dX_t^i = \pi_t^i (b_t^i dt + \sigma_t^i dW_t^i) + \pi_t^{i0} (b_t^{i0} dt + \sigma_t^{i0} dW_t^0) = \bar{\pi}_t^i (\bar{b}_t^i dt + d\bar{W}_t^i), \quad X_0^i = x^i, \quad (1.4)$$

where

$$\bar{\pi}^i = (\sigma^i \pi^i, \sigma^{i0} \pi^{i0}) \quad \text{and} \quad \bar{b}^i = (b^i / \sigma^i, b^{i0} / \sigma^{i0})^\top.$$

Without loss of generality, from now on we assume $\sigma^i = \sigma^{i0} = 1$.

The goal for player i is to maximize the exponential utility with relative concern by choosing (π^i, π^{i0}) or $\bar{\pi}^i$

$$\mathbb{E} \left[-e^{-\alpha^i (X_T^i - \theta^i \bar{X}_T^{-i})} \right] \rightarrow \max. \quad (1.5)$$

The following heuristic argument shows that the unique Nash equilibrium of (1.4)-(1.5) is the vector

$$(\bar{\pi}^{1,*}, \dots, \bar{\pi}^{i,*}),$$

where for each $i = 1, \dots, N$

$$\bar{\pi}^{i,*} = \bar{Z}^i + \frac{(\bar{b}^i)^\top}{\alpha^i} \quad (1.6)$$

and $(X^i, Y^i, \bar{Z}^i = (Z^{ii}, Z^{i0}), (Z^{ij})_{j \neq i})_{i=1, \dots, N}$ is the unique solution to the following multi-dimensional FBSDE system

$$\begin{cases} X_t^i = x^i + \int_0^t \left(\bar{Z}_s^i \bar{b}_s^i + \frac{|\bar{b}_s^i|^2}{\alpha^i} \right) ds + \int_0^t \left(\bar{Z}_s^i + \frac{(\bar{b}_s^i)^\top}{\alpha^i} \right) d\bar{W}_s^i, \\ Y_t^i = \theta^i \bar{X}_T^{-i} - \int_t^T \left(\bar{Z}_s^i \bar{b}_s^i + \frac{|\bar{b}_s^i|^2}{2\alpha^i} - \frac{\alpha^i}{2} \sum_{j \neq i} (Z_s^{ij})^2 \right) ds - \int_t^T \bar{Z}_s^i d\bar{W}_s^i - \sum_{j \neq i} \int_t^T Z_s^{ij} dW_s^j, \\ i = 1, \dots, N. \end{cases} \quad (1.7)$$

Fixing the competitors' strategies $(\bar{\pi}^j)_{j \neq i}$ and letting $(X^j)_{j \neq i}$ be the corresponding wealth, following the martingale optimality principle in Hu, Imkeller & Müller [22] (see also Mania & Schweizer [37] and Rouge & El Karoui [40]) we construct a family of stochastic processes $R^{i, \bar{\pi}}$ such that

- $R^{i, \bar{\pi}}$ is a supermartingale for all $\bar{\pi}$ and $R^{i, \bar{\pi}^{i,*}}$ is a martingale for some $\bar{\pi}^{i,*}$,
- $R_0^{i, \bar{\pi}} = R_0$ for all $\bar{\pi}$ and
- $R_T^{i, \bar{\pi}} = -e^{-\alpha^i (X_T^i - \theta^i \bar{X}_T^i)}$.

Construct $R^{i, \bar{\pi}}$ in terms of a stochastic process Y^i via $R^{i, \bar{\pi}} = -e^{-\alpha^i (X^{i, \bar{\pi}} - Y^i)}$. From the above three items, it holds that $\mathbb{E}[-e^{-\alpha^i (X_T^{i, \bar{\pi}} - \theta^i \bar{X}_T^i)}] \leq -e^{-\alpha^i (x^i - Y_0^i)} = \mathbb{E}[-e^{-\alpha^i (X_T^{i, \bar{\pi}^{i,*}} - \theta^i \bar{X}_T^i)}]$ for all $\bar{\pi}$. Thus, $\bar{\pi}^{i,*}$ is optimal for player i 's optimization problem. Assume the diffusion process Y^i admit the following expression

$$dY_t^i = f_t^i dt + \bar{Z}_t^i d\bar{W}_t^i + \sum_{j \neq i} Z_t^{ij} dW_t^j.$$

We will find f^i such that Y^i satisfies (1.7) and the constructed $R^{i, \bar{\pi}}$ satisfies the above three items. By the construction,

$$\begin{aligned} R_t^{i, \bar{\pi}} &= -e^{-\alpha^i \left(x^i - Y_0^i + \int_0^t (\bar{\pi}_s \bar{b}_s^i - f_s^i) ds + \int_0^t (\bar{\pi}_s - \bar{Z}_s^i) d\bar{W}_s^i - \sum_{j \neq i} \int_0^t Z_s^{ij} dW_s^j \right)} \\ &= -e^{-\alpha^i (x^i - Y_0^i)} e^{-\alpha^i \int_0^t (\bar{\pi}_s - \bar{Z}_s^i) d\bar{W}_s^i - \frac{(\alpha^i)^2}{2} \int_0^t |\bar{\pi}_s - \bar{Z}_s^i|^2 ds + \alpha^i \sum_{j \neq i} \int_0^t Z_s^{ij} dW_s^j - \frac{(\alpha^i)^2}{2} \sum_{j \neq i} \int_0^t (Z_s^{ij})^2 ds} \\ &\quad \times e^{-\alpha^i \int_0^t (\bar{\pi}_s \bar{b}_s^i - f_s^i) ds + \frac{(\alpha^i)^2}{2} \int_0^t |\bar{\pi}_s - \bar{Z}_s^i|^2 ds + \frac{(\alpha^i)^2}{2} \sum_{j \neq i} \int_0^t (Z_s^{ij})^2 ds} \\ &= M_t^{i, \bar{\pi}} A_t^{i, \bar{\pi}}, \end{aligned}$$

where

$$M_t^{i, \bar{\pi}} = -e^{-\alpha^i (x^i - Y_0^i)} e^{-\alpha^i \int_0^t (\bar{\pi}_s - \bar{Z}_s^i) d\bar{W}_s^i - \frac{(\alpha^i)^2}{2} \int_0^t |\bar{\pi}_s - \bar{Z}_s^i|^2 ds + \alpha^i \sum_{j \neq i} \int_0^t Z_s^{ij} dW_s^j - \frac{(\alpha^i)^2}{2} \sum_{j \neq i} \int_0^t (Z_s^{ij})^2 ds}$$

and

$$A_t^{i, \bar{\pi}} = e^{-\alpha^i \int_0^t (\bar{\pi}_s \bar{b}_s^i - f_s^i) ds + \frac{(\alpha^i)^2}{2} \int_0^t |\bar{\pi}_s - \bar{Z}_s^i|^2 ds + \frac{(\alpha^i)^2}{2} \sum_{j \neq i} \int_0^t (Z_s^{ij})^2 ds}.$$

Take it for grant that the local martingale $M^{i, \bar{\pi}}$ is a true martingale. To make $R^{i, \bar{\pi}}$ a supermartingale for all $\bar{\pi}$ and a martingale for some $\bar{\pi}^{i,*}$, it is sufficient to let $A^{i, \bar{\pi}}$ be non-decreasing for all $\bar{\pi}$ and 1 for some $\bar{\pi}^{i,*}$. This is equivalent to letting the integrand of $\log A^{i, \bar{\pi}}$ be non-negative for all $\bar{\pi}$ and 0 for some $\bar{\pi}^{i,*}$. Indeed,

$$\begin{aligned} & -\alpha^i (\bar{\pi} \bar{b}^i - f^i) + \frac{(\alpha^i)^2}{2} |\bar{\pi} - \bar{Z}^i|^2 + \frac{(\alpha^i)^2}{2} \sum_{j \neq i} (Z^{ij})^2 \\ &= \frac{(\alpha^i)^2}{2} \left| \bar{\pi} - \bar{Z}^i - \frac{(\bar{b}^i)^\top}{\alpha^i} \right|^2 - \frac{|\bar{b}^i|^2}{2} - \alpha^i \bar{Z}^i \bar{b}^i + \alpha^i f^i + \frac{(\alpha^i)^2}{2} \sum_{j \neq i} (Z^{ij})^2, \end{aligned}$$

which implies (1.6) and

$$f^i = \frac{|\bar{b}^i|^2}{2\alpha^i} + \bar{Z}^i \bar{b}^i - \frac{\alpha^i}{2} \sum_{j \neq i} (Z^{ij})^2.$$

Thus, the candidate Nash equilibrium $(\bar{\pi}^{1,*}, \dots, \bar{\pi}^{N,*})$ and the value function $-e^{-\alpha^i (x^i - Y_0^i)}$ for player i are characterized by the multi-dimensional (coupled) FBSDE with quadratic growth and unbounded terminal condition (1.7), which is in a non-Markovian setting.

The literature on multi-dimensional FBSDEs with quadratic growth is sparse. Among the rare results, Fromm & Imkeller [14] and Kupper, Luo & Tangpi [31] considered Markovian cases, Fromm & Imkeller

[15] studied a “non-Markovian” case arising in utility maximization, where the randomness comes from an exogenous diffusion, Herdegen, Muhle-Karbe & Possamaï [20] studied a two-dimensional non-Markovian case arising in equilibrium pricing with transaction cost, and Luo & Tangpi [35] considered a non-Markovian case but with a bounded terminal condition.

Because of the unboundedness of the terminal condition $\theta^i \bar{X}_T^{-i}$ and the non-Markovian nature of (1.7), it is difficult to solve (1.7) directly by the methods in the above literature. Based on the specific structure of our system, using a transformation, we show (1.7) is equivalent to a non-Markovian multi-dimensional BSDE with quadratic growth and bounded terminal condition. Moreover, in addition to the well-posedness result we also expect (1.7) to converge to the mean field system characterizing the equilibrium of the MFG correspondence. Motivated by this expectation, we solve the resulting multi-dimensional BSDE by considering a sequence of benchmark mean field BSDEs firstly and then by applying BMO and fixed point analysis, which is inspired by Tevzadze [41], to the difference of the multi-dimensional BSDE and the benchmark ones; see Section 2 for details.

Before turning to the next section to introduce the MFG in detail, we should mention that in addition to the aforementioned [11–13], non-Markovian multi-dimensional quadratic BSDEs have also been studied by Bieligk, Lionnet & dos Reis [4], Elie & Possamaï [10], Harter & Richou [19], Hu & Tang [23], Jamneshan, Kupper & Luo [25], Kardaras, Xing & Žitkovic [27], Kramkov & Pulido [30], Nam [38] among others. But none of these results covers ours, especially in view of that our multi-dimensional system converges to a mean field system.

1.2 The Mean Field Utility Game

Our mean field utility game is in the framework of MFGs as introduced in Huang, Malhame & Caines [24] and Lasry & Lions [34] (see also Bensoussan, Frehse & Yam [2], Cardaliaguet [5] and Carmona & Delarue [8, 9]). The main idea is to decouple local dynamics by global dynamics and consider a representative player’s optimization problem by solving only one equation instead of a couple multi-dimensional system. The equilibrium is established by solving a fixed point problem. The probabilistic method we will apply is inspired by Carmona & Delarue [6] and [8], although we incorporate FBSDEs through the martingale optimality principle rather than the maximum principle.

In the MFG correspondence, the price dynamics for the two stocks managed by the representative player follow

$$\frac{dS_t}{S_t} = b_t dt + dW_t \quad \text{and} \quad \frac{dS_t^0}{S_t^0} = b_t^0 dt + dW_t^0, \quad (1.8)$$

where b and b^0 are random return rates and $\bar{W} := (W, W^0)$. Let π and π^0 be the amount of money invested into the two stocks, respectively. The dynamics of the representative player’s wealth follows

$$dX_t = \pi_t(b_t dt + dW_t) + \pi_t^0(b_t^0 dt + dW_t^0) = \bar{\pi}_t(\bar{b}_t dt + d\bar{W}_t), \quad (1.9)$$

where

$$\bar{\pi} = (\pi, \pi^0) \quad \text{and} \quad \bar{b} = (b, b^0)^\top.$$

Again, the volatilities in (1.8) are assumed to be 1 for simplicity. We consider the mean field utility game:

1. Fix a \mathcal{F}_T^0 adapted μ ;
2. Solve the optimization problem: $\max_{\bar{\pi}} \mathbb{E} \left[-e^{-\alpha(X_T - \theta\mu)} \right]$ subject to (1.9);
3. Search for the fixed point $\mu = \mathbb{E}[X_T^* | \mathcal{F}_T^0]$, where X^* is the optimal wealth from 2.

The probabilistic approach of MFG and the argument in Hu, Imkeller & Müller [22, Section 2] yield the following mean field FBSDE

$$\begin{cases} X_t = \mathcal{X} + \int_0^t \left(\bar{Z}_s + \frac{\bar{b}_s^\top}{\alpha} \right) (\bar{b}_s ds + d\bar{W}_s), \\ Y_t = \theta \mathbb{E}[X_T | \mathcal{F}_t^0] - \int_t^T \left(\bar{Z}_s \bar{b}_s + \frac{|\bar{b}_s|^2}{2\alpha} \right) ds - \int_t^T \bar{Z}_s d\bar{W}_s, \end{cases} \quad (1.11)$$

where $\bar{Z} = (Z, Z^0)$ and the candidate optimal strategy is given by

$$\bar{\pi}^* = \bar{Z} + \frac{\bar{b}^\top}{\alpha}.$$

In Section 3.1 we will solve (1.11) by using a similar transformation as that to solve (1.7), but under much weaker assumptions than those under which (1.7) is solvable. This provides sufficient reason to consider the MFG (1.10) even if the corresponding N -player game (1.4)-(1.5) is solvable and the convergence result is established.

Moreover, when the dynamics of the stocks managed by each player is independent, that is each player is assumed to manage only one stock driven by the individual shock W or $\pi^0 \equiv 0$, the competition factor can be assumed to be measurable w.r.t. the largest σ -algebra in the resulting MFG

$$\begin{cases} 1. \text{ Fix a } \mu \in \mathbb{R}; \\ 2. \text{ Solve the optimization problem: } \max_{\pi} \mathbb{E} \left[-e^{-\alpha(X_T - \theta\mu)} \right] \\ \quad \text{subject to (1.9) with } \pi^0 = 0; \\ 3. \text{ Search for the fixed point } \mu = \mathbb{E}[X_T^*], \text{ where } X^* \text{ is the optimal wealth from 2.} \end{cases} \quad (1.12)$$

The resulting mean field FBSDE follows

$$\begin{cases} X_t = \mathcal{X} + \int_0^t \left(Z_s + \frac{b_s}{\alpha} \right) (b_s ds + dW_s), \\ Y_t = \theta \mathbb{E}[X_T] - \int_t^T \left(Z_s b_s + \frac{|b_s|^2}{2\alpha} \right) ds - \int_t^T Z_s dW_s, \end{cases} \quad (1.13)$$

which cannot be transformed into a mean field BSDE like (1.7) and (1.11) because θ is measurable w.r.t. the largest σ -algebra. Although in a linear form, the mean field FBSDE (1.13) does not appear in the literature due to its random and non-monotone coefficients as well as the appearance of Z in the drift. In particular, the continuation method to obtain global solutions in [1, 3, 7, 16, 17] does not work here. The solvability of (1.13) on the whole interval $[0, T]$ has its own interest. Our approach is motivated by Ma, Wu, Zhang & Zhang [36], where there is no mean field term. First, we solve (1.13) on a short time interval by a contraction argument. Second, we extend the local solution to the global one by establishing the existence result of a decoupling field with Lipschitz property. In order to do so, we need to analyze the associated characteristic (mean field) BSDE; see Section 3.2 for details.

The rest of this paper is organized as follows. In Section 2, we solve the multi-dimensional FBSDE with quadratic growth (1.7) and the N -player game (1.4)-(1.5). The convergence result is also established there. Under mild assumptions, in Section 3.1 and Section 3.2 we solve the MFG (1.10) and the MFG (1.12), respectively. In Section 4, explicitly solvable examples and the financial interpretation are provided.

Notation of Spaces. Let \mathbb{K} be a generic filtration and $\mathbb{I} \subset [0, T]$ be an interval. Define

$$\mathbb{L}_{\mathbb{K}}(\mathbb{I}) = \{P : \Omega \times \mathbb{I} \rightarrow \mathbb{R} : P \text{ is progressively measurable w.r.t. } \mathbb{K}\},$$

$$\begin{aligned}\mathbb{L}_{\mathbb{K}}^2(\mathbb{I}) &= \left\{ P \in \mathbb{L}_{\mathbb{K}}(\mathbb{I}) : \mathbb{E} \left[\int_0^T |P_t|^2 dt \right] < \infty \right\}, \\ \mathbb{L}_{\mathbb{K}}^\infty(\mathbb{I}) &= \left\{ P \in \mathbb{L}_{\mathbb{K}}(\mathbb{I}) : \|P\|_{\mathbb{I},\infty} := \operatorname{ess\,sup}_{(\omega,t) \in \Omega \times \mathbb{I}} |P_t(\omega)| < \infty \right\}, \\ \mathbb{S}_{\mathbb{K}}^p(\mathbb{I}) &= \left\{ P \in \mathbb{L}_{\mathbb{K}}(\mathbb{I}) : P \text{ has continuous trajectories and } \mathbb{E} \left[\sup_{t \in \mathbb{I}} |P_t|^p \right] < \infty \right\}, \quad p = 1, 2,\end{aligned}$$

and

$$\mathbb{S}_{\mathbb{K}}^\infty(\mathbb{I}) = \{P \in \mathbb{L}_{\mathbb{K}}^\infty(\mathbb{I}) : P \text{ has continuous trajectories}\}.$$

Let $\mathcal{T}_{\mathbb{K},\mathbb{I}}$ be the space of all- \mathbb{K} stopping times valued in \mathbb{I} . The BMO space is defined as

$$\mathbb{H}_{\mathbb{K},BMO}^2(\mathbb{I}) = \left\{ P \in \mathbb{L}_{\mathbb{K}}(\mathbb{I}) : \|P\|_{\mathbb{K},\mathbb{I},BMO} := \operatorname{ess\,sup}_{\omega \in \Omega} \operatorname{ess\,sup}_{\tau \in \mathcal{T}_{\mathbb{K},\mathbb{I}}} \left(\mathbb{E} \left[\int_{\mathbb{I}} |P_t|^2 dt \middle| \mathcal{F}_\tau \right] \right)^{1/2} < \infty \right\}$$

We will use the notation $\mathbb{H}_{\mathbb{K},BMO,R}^2(\mathbb{I})$ to denote the subspace of $\mathbb{H}_{\mathbb{K},BMO}^2(\mathbb{I})$ with all elements satisfying $\|\cdot\|_{\mathbb{K},\mathbb{I},BMO} \leq R$. When $\mathbb{I} = [0, T]$, we will drop \mathbb{I} in the notation of spaces and norms.

Let L^2 denote the space of all random variables that are squarely integrable. For the space of essentially bounded random variables L^∞ , we use $\|\cdot\|$ to denote the norm of essential supremum.

2 N -Player Games

This section studies the solvability of the N -player game (1.4)-(1.5). Firstly, we solve the multi-dimensional FBSDE (1.7) and then we verify the candidate (1.6) is indeed the Nash equilibrium of (1.4)-(1.5). The following assumptions are in force in this section.

Assumption 1 (Assumptions of N -Player Games). Let \mathcal{G} be a σ -algebra that is independent of all Brownian motions.

1. For each i , the tuple $(x^i, \theta^i, \alpha^i)$ is an independent \mathcal{G} random variable, where θ^i is valued in $[0, 1]$ and α^i is positively valued.
2. The sequence $\{\bar{b}^i\}_i$ is uniformly bounded and progressively measurable w.r.t. $\mathbb{F}^i \vee \mathcal{G}$.

From now on, let $\mathcal{G}^{(N)} := (\mathcal{G}_t^{(N)})_{0 \leq t \leq T} := \mathbb{F}^{(N)} \vee \mathcal{G}$, where we recall $\mathbb{F}^{(N)}$ is the filtration generated by all Brownian motions (W^1, \dots, W^N, W^0) .

Remark 2.1. To solve the N -player game, a similar assumption on θ^i also appears in [11, 13], where it is assumed that $\prod_{i=1}^N \theta^i < 1$. In order to show the convergence from the N -player game to MFG, [11] further assumes $\theta^i = \theta^j < 1$ for all $i \neq j$. [13] provides a counterexample to show there might exist no equilibria when $\theta^i = 1$. To solve the N -player game, our approach is to compare the multi-dimensional system and the mean field system, so we assume $\theta^i < 1$ for all i , which is less general than $\prod_{i=1}^n \theta^i < 1$ but we allow θ^i to be heterogeneous across different players even in the MFG, like [33].

Moreover, in the N -player game, when $(x^i, \theta^i, \alpha^i)$ are random variables player i 's optimization is equivalent to the optimization when $(x^i, \theta^i, \alpha^i)$ are scalars. But this assumption makes a difference and is more general in MFG. So we keep it from the very beginning for the simplicity of the statement.

2.1 Solvability of (1.7)

Because of the possibly unbounded terminal condition $\theta^i \bar{X}_T^{-i}$, it is difficult to solve (1.7) directly. In the following we will transform the FBSDE (1.7) into a multi-dimensional quadratic BSDE with a bounded terminal condition. Note that a similar transformation also appears in [11], where the original equation is transformed into a BSDE with unbounded terminal condition while the terminal condition of our resulting BSDE is bounded.

From (1.7) we have

$$\left\{ \begin{array}{l} Y_t^i = \theta^i \bar{x}^{-i} + \frac{\theta^i}{N-1} \sum_{j \neq i} \int_0^T \left(\bar{Z}_s^j \bar{b}_s^j + \frac{|\bar{b}_s^j|^2}{\alpha^j} \right) ds + \frac{\theta^i}{N-1} \sum_{j \neq i} \int_0^T \left(Z_s^{jj} + \frac{b_s^j}{\alpha^j} \right) dW_s^j \\ \quad + \frac{\theta^i}{N-1} \sum_{j \neq i} \int_0^T \left(Z_s^{j0} + \frac{b_s^{j0}}{\alpha^j} \right) dW_s^0 \\ \quad - \int_t^T \left(\bar{Z}_s^i \bar{b}_s^i + \frac{|\bar{b}_s^i|^2}{2\alpha^i} - \frac{\alpha^i}{2} \sum_{j \neq i} (Z_s^{ij})^2 \right) ds - \int_t^T Z_s^{ii} dW_s^i - \sum_{j \neq i} \int_t^T Z_s^{ij} dW_s^j, \\ \quad - \int_t^T Z_s^{i0} dW_s^0 \\ \quad i = 1, \dots, N. \end{array} \right. \quad (2.1)$$

Now we divide the integrals $\int_0^T \dots ds$, $\int_0^T \dots dW_s^j$ and $\int_0^T \dots dW_s^0$ into two parts, $\int_0^t \dots ds$, $\int_0^t \dots dW_s^j$, $\int_0^t \dots dW_s^0$ and $\int_t^T \dots ds$, $\int_t^T \dots dW_s^j$, $\int_t^T \dots dW_s^0$. We make the latter part absorbed into the drift and volatility in (2.1), respectively. Define

$$\begin{aligned} \tilde{Y}^i := & Y^i - \frac{\theta^i}{N-1} \sum_{j \neq i} \int_0^t \left(\bar{Z}_s^j \bar{b}_s^j + \frac{|\bar{b}_s^j|^2}{\alpha^j} \right) ds - \frac{\theta^i}{N-1} \sum_{j \neq i} \int_0^t \left(Z_s^{jj} + \frac{b_s^j}{\alpha^j} \right) dW_s^j \\ & - \frac{\theta^i}{N-1} \sum_{j \neq i} \int_0^t \left(Z_s^{j0} + \frac{b_s^{j0}}{\alpha^j} \right) dW_s^0. \end{aligned}$$

Then \tilde{Y}^i satisfies

$$\left\{ \begin{array}{l} d\tilde{Y}_t^i = \left(\bar{Z}_t^i \bar{b}_t^i + \frac{|\bar{b}_t^i|^2}{2\alpha^i} - \frac{\alpha^i}{2} \sum_{j \neq i} (Z_t^{ij})^2 - \frac{\theta^i}{N-1} \sum_{j \neq i} \left(\bar{Z}_t^j \bar{b}_t^j + \frac{|\bar{b}_t^j|^2}{\alpha^j} \right) \right) dt \\ \quad + Z_t^{ii} dW_t^i + \sum_{j \neq i} \left(Z_t^{ij} - \frac{\theta^i}{N-1} \left(Z_t^{jj} + \frac{b_t^j}{\alpha^j} \right) \right) dW_t^j \\ \quad + \left(Z_t^{i0} - \frac{\theta^i}{N-1} \sum_{j \neq i} \left(Z_t^{j0} + \frac{b_t^{j0}}{\alpha^j} \right) \right) dW_t^0, \\ \tilde{Y}_T^i = \theta^i \bar{x}^{-i}, \\ \quad i = 1, \dots, N. \end{array} \right. \quad (2.2)$$

For each $i = 1, \dots, N$, let

$$\tilde{Z}^{ii} = Z^{ii}, \quad \tilde{Z}^{ij} = Z^{ij} - \frac{\theta^i}{N-1} \left(Z^{jj} + \frac{b^j}{\alpha^j} \right) \text{ for } j \neq i, \quad \tilde{Z}^{i0} = Z^{i0} - \frac{\theta^i}{N-1} \sum_{j \neq i} \left(Z^{j0} + \frac{b^{j0}}{\alpha^j} \right). \quad (2.3)$$

Let $C^j = Z^{j0} + \frac{b^{j0}}{\alpha^j}$ and $D^j = \tilde{Z}^{j0} + \frac{b^{j0}}{\alpha^j}$. The last equality in (2.3) implies

$$D^i = \left(1 + \frac{\theta^i}{N-1} \right) C^i - \frac{\theta^i}{N-1} \sum_{j=1}^N C^j,$$

which further implies

$$C^i = \frac{D^i}{1 + \frac{\theta^i}{N-1}} + \frac{\frac{\theta^i}{N-1} \sum_{j=1}^N C^j}{1 + \frac{\theta^i}{N-1}}.$$

Taking sum from 1 to N and rearranging terms, one has

$$\left(1 - \sum_{j=1}^N \frac{\theta^j}{N-1 + \theta^j}\right) \sum_{j=1}^N C^j = \sum_{j=1}^N \frac{D^j}{1 + \frac{\theta^j}{N-1}}.$$

Since it is assumed that $0 \leq \theta^j < 1$ for all j in Assumption 1, it holds that $1 - \sum_{j=1}^N \frac{\theta^j}{N-1 + \theta^j} > 0$ so one has

$$\sum_{j=1}^N C^j = \frac{\sum_{j=1}^N \frac{D^j}{1 + \frac{\theta^j}{N-1}}}{1 - \sum_{j=1}^N \frac{\theta^j}{N-1 + \theta^j}}.$$

Thus, we get

$$C^i = \frac{D^i + \frac{\theta^i}{N-1} \frac{\sum_{j=1}^N \frac{D^j}{1 + \frac{\theta^j}{N-1}}}{1 - \sum_{j=1}^N \frac{\theta^j}{N-1 + \theta^j}}}{1 + \frac{\theta^i}{N-1}},$$

which implies that

$$Z^{i0} = \frac{\tilde{Z}^{i0} + \frac{\theta^i}{N-1} \frac{\sum_{j=1}^N \frac{\tilde{Z}^{j0}}{1 + \frac{\theta^j}{N-1}}}{1 - \sum_{j=1}^N \frac{\theta^j}{N-1 + \theta^j}} + \frac{\theta^i}{N-1} \frac{\sum_{j=1}^N \frac{\frac{b_t^{j0}}{\alpha^j}}{1 + \frac{\theta^j}{N-1}}}{1 - \sum_{j=1}^N \frac{\theta^j}{N-1 + \theta^j}} - \frac{\theta^i}{N-1} \frac{b_t^{i0}}{\alpha^i}}{1 + \frac{\theta^i}{N-1}} := f_{i,N}(\cdot, \tilde{Z}^{i0}; \tilde{Z}^{k0}, k \neq i).$$

Then, the BSDEs (2.2) are transformed into

$$\left\{ \begin{aligned} d\tilde{Y}_t^i &= \left\{ \tilde{Z}_t^i b_t^i + b_t^{i0} f_{i,N}(t, \tilde{Z}_t^{i0}; \tilde{Z}_t^{k0}, k \neq i) + \frac{|\bar{b}_t^i|^2}{2\alpha^i} - \frac{\alpha^i}{2} \sum_{j \neq i} \left(\tilde{Z}_t^{ij} + \frac{\theta^i}{N-1} \left(\tilde{Z}_t^{jj} + \frac{b_t^j}{\alpha^j} \right) \right)^2 \right. \\ &\quad \left. - \frac{\theta^i}{N-1} \sum_{j \neq i} \left(b_t^j \tilde{Z}_t^{jj} + b_t^{j0} f_{j,N}(t, \tilde{Z}_t^{j0}; \tilde{Z}_t^{k0}, k \neq j) \right) - \frac{\theta^i}{N-1} \sum_{j \neq i} \frac{|\bar{b}_t^j|^2}{\alpha^j} \right\} dt \\ &\quad + \tilde{Z}_t^{ii} dW_t^i + \sum_{j \neq i} \tilde{Z}_t^{ij} dW_t^j + \tilde{Z}_t^{i0} dW_t^0 \\ \tilde{Y}_T^i &= \theta^i \bar{x}^{-i}, \\ i &= 1, \dots, N. \end{aligned} \right. \quad (2.4)$$

In this way, we transform the multi-dimensional FBSDE with a possibly unbounded terminal condition (1.7) to the multi-dimensional BSDE with a bounded terminal condition (2.4). Moreover, the solutions to (1.7) and (2.4) have one to one correspondence. To solve (2.4), we first consider the following sequence of benchmark conditional mean field BSDEs

$$\begin{aligned} d\check{Y}_t^i &= \left\{ b_t^i \check{Z}_t^i + \frac{|\bar{b}_t^i|^2}{2\alpha^i} + b_t^{i0} \left(\check{Z}_t^{i0} + \frac{\theta^i}{1 - \mathbb{E}[\theta^i]} \mathbb{E}[\check{Z}_t^{i0} | \mathcal{F}_t^0] + \frac{\theta^i}{1 - \mathbb{E}[\theta^i]} \mathbb{E} \left[\frac{b_t^{i0}}{\alpha^i} \middle| \mathcal{F}_t^0 \right] \right) \right. \\ &\quad \left. - \theta^i \mathbb{E} \left[\frac{|\bar{b}_t^i|^2}{\alpha^i} \middle| \mathcal{F}_t^0 \right] - \theta^i \mathbb{E}[b_t^i \check{Z}_t^i | \mathcal{F}_t^0] - \theta^i \mathbb{E}[b_t^{i0} \check{Z}_t^{i0} | \mathcal{F}_t^0] - \frac{\theta^i}{1 - \mathbb{E}[\theta^i]} \mathbb{E}[\theta^i b_t^{i0} | \mathcal{F}_t^0] \mathbb{E}[\check{Z}_t^{i0} | \mathcal{F}_t^0] \right. \\ &\quad \left. - \frac{\theta^i}{1 - \mathbb{E}[\theta^i]} \mathbb{E}[\theta^i b_t^{i0} | \mathcal{F}_t^0] \mathbb{E} \left[\frac{b_t^{i0}}{\alpha^i} \middle| \mathcal{F}_t^0 \right] \right\} dt + \check{Z}_t^i dW_t^i + \check{Z}_t^{i0} dW_t^0, \quad \check{Y}_T^i = \theta^i \bar{x}^{-i} \\ i &= 1, \dots, N. \end{aligned} \quad (2.5)$$

Due to the Lipschitz property of the driver, the well-posedness of (2.5) in $\mathbb{S}^2 \times \mathbb{H}^2$ is obvious. However, the essential boundedness of \check{Y}^i and the BMO property of \check{Z}^i and \check{Z}^{i0} are necessary for the well-posedness of (2.4) as well as the convergence to the MFG. This is done by the next lemma.

Lemma 2.2. *Under Assumption 1, for fixed i , for each $R > 0$, choosing θ^i and \bar{b}^i small enough such that*

$$\left\{ \begin{array}{l} 10\|\bar{b}^i\|_{\mathcal{G}^{(N)},BMO}^2 \leq \frac{1}{8}, \quad 20 \left(1 + \frac{\|\theta^i\|^2}{(1-\mathbb{E}[\theta^i])^2} \right) \|b^{i0}\|_{\mathcal{G}^{(N)},BMO}^2 \leq \frac{1}{8}, \\ \frac{5}{2} \left\| \frac{\bar{b}^i}{\sqrt{\alpha^i}} \right\|_{\mathcal{G}^{(N)},BMO}^4 \leq \frac{3R^2}{40}, \quad \frac{40\|\theta^i\|^2}{(1-\mathbb{E}[\theta^i])^2} \|b^{i0}\|_{\mathcal{G}^{(N)},BMO}^2 \left\| \frac{b^{i0}}{\alpha^i} \right\|_{\mathcal{G}^{(N)},BMO}^2 \leq \frac{3R^2}{40}, \\ 10\|\theta^i\|^2 \left\| \frac{\bar{b}^i}{\sqrt{\alpha^i}} \right\|_{\mathcal{G}^{(N)},BMO}^4 \leq \frac{3R^2}{40}, \quad \|\theta^i \bar{x}^{-i}\|^2 \leq \frac{3R^2}{40}, \end{array} \right. \quad (2.6)$$

there exists a unique solution of (2.5) such that

$$\|\check{Y}^i\|_\infty^2 + \|\check{Z}^i\|_{\mathcal{G}^{(N)},BMO}^2 + \|\check{Z}^{i0}\|_{\mathcal{G}^{(N)},BMO}^2 \leq R^2. \quad (2.7)$$

Proof. The well-posedness of (2.5) in $\mathbb{S}^2 \times \mathbb{H}^2$ holds because of the Lipschitz property of the driver in (2.5). It remains to prove $(\check{Y}^i, \check{Z}^i, \check{Z}^{i0}) \in \mathbb{S}_{\mathcal{G}^{(N)}}^\infty \times \mathbb{H}_{\mathcal{G}^{(N)},BMO,R}^2 \times \mathbb{H}_{\mathcal{G}^{(N)},BMO,R}^2$.

By Itô's formula, taking conditional expectations and Proposition A.3 we have for each $\tau \in \mathcal{T}_{\mathcal{G}^{(N)}}$

$$\begin{aligned} & (\check{Y}_\tau^i)^2 + \mathbb{E} \left[\int_\tau^T (\check{Z}_s^i)^2 ds \middle| \mathcal{G}_\tau^{(N)} \right] + \mathbb{E} \left[\int_\tau^T (\check{Z}_s^{i0})^2 ds \middle| \mathcal{G}_\tau^{(N)} \right] \\ & \leq 2\|\check{Y}^i\|_\infty \mathbb{E} \left[\int_\tau^T \left| b_s^i \check{Z}_s^i + \frac{|\bar{b}_s^i|^2}{2\alpha^i} + b_s^{i0} \left(\check{Z}_s^{i0} + \frac{\theta^i \mathbb{E}[\check{Z}_s^{i0} | \mathcal{F}_s^0]}{1-\mathbb{E}[\theta^i]} + \frac{\theta^i}{1-\mathbb{E}[\theta^i]} \mathbb{E} \left[\frac{b_s^{i0}}{\alpha^i} \middle| \mathcal{F}_s^0 \right] \right) \right| ds \middle| \mathcal{G}_\tau^{(N)} \right] \\ & \quad + 2\|\check{Y}^i\|_\infty \mathbb{E} \left[\int_\tau^T \left(\theta^i \mathbb{E} \left[\frac{|\bar{b}_s^i|^2}{\alpha^i} \middle| \mathcal{F}_s^0 \right] + \theta^i \mathbb{E}[b_s^i \check{Z}_s^i | \mathcal{F}_s^0] \right. \right. \\ & \quad \left. \left. + \theta^i \mathbb{E}[b_s^{i0} \check{Z}_s^{i0} | \mathcal{F}_s^0] + \frac{\theta^i}{1-\mathbb{E}[\theta^i]} \mathbb{E}[\theta^i b_s^{i0} | \mathcal{F}_s^0] \mathbb{E}[\check{Z}_s^{i0} | \mathcal{F}_s^0] \right) ds \middle| \mathcal{G}_\tau^{(N)} \right] \\ & \quad + 2\|\check{Y}^i\|_\infty \frac{\theta^i}{1-\mathbb{E}[\theta^i]} \mathbb{E} \left[\int_\tau^T \mathbb{E}[\theta^i b_s^{i0} | \mathcal{F}_s^0] \mathbb{E} \left[\frac{b_s^{i0}}{\alpha^i} \middle| \mathcal{F}_s^0 \right] ds \middle| \mathcal{G}_\tau^{(N)} \right] + (\theta^i)^2 (\bar{x}^{-i})^2. \end{aligned} \quad (2.8)$$

By Lemma A.1, taking supremum on both sides of (2.8) and using Young's inequality $2ab \leq \frac{a^2}{10} + 10b^2$, we have

$$\begin{aligned} & \|\check{Y}^i\|_\infty^2 + \|\check{Z}^i\|_{\mathcal{G}^{(N)},BMO}^2 + \|\check{Z}^{i0}\|_{\mathcal{G}^{(N)},BMO}^2 \\ & \leq \frac{7}{10} \|\check{Y}^i\|_\infty^2 + 10\|b^i\|_{\mathcal{G}^{(N)},BMO}^2 \|\check{Z}^i\|_{\mathcal{G}^{(N)},BMO}^2 + \frac{5}{2} \left\| \frac{\bar{b}^i}{\sqrt{\alpha^i}} \right\|_{\mathcal{G}^{(N)},BMO}^4 \\ & \quad + 20 \left(1 + \frac{\|\theta^i\|^2}{(1-\mathbb{E}[\theta^i])^2} \right) \|b^{i0}\|_{\mathcal{G}^{(N)},BMO}^2 \|\check{Z}^{i0}\|_{\mathcal{G}^{(N)},BMO}^2 + \frac{40\|\theta^i\|^2}{(1-\mathbb{E}[\theta^i])^2} \|b^{i0}\|_{\mathcal{G}^{(N)},BMO}^2 \left\| \frac{b^{i0}}{\alpha^i} \right\|_{\mathcal{G}^{(N)},BMO}^2 \\ & \quad + 10\|\theta^i\|^2 \left\| \frac{\bar{b}^i}{\sqrt{\alpha^i}} \right\|_{\mathcal{G}^{(N)},BMO}^4 + 10\|\theta^i\|^2 \|b^i\|_{\mathcal{G}^{(N)},BMO}^2 \|\check{Z}^i\|_{\mathcal{G}^{(N)},BMO}^2 \\ & \quad + 10 \left(\|\theta^i\| + \frac{\|\theta^i\|^2}{1-\mathbb{E}[\theta^i]} \right)^2 \|b^{i0}\|_{\mathcal{G}^{(N)},BMO}^2 \|\check{Z}^{i0}\|_{\mathcal{G}^{(N)},BMO}^2 + \|\theta^i \bar{x}^{-i}\|^2. \end{aligned}$$

By the first line of (2.6) it holds that

$$\begin{aligned} & \|\check{Y}^i\|_\infty^2 + \|\check{Z}^i\|_{\mathcal{G}^{(N)}, BMO}^2 + \|\check{Z}^{i0}\|_{\mathcal{G}^{(N)}, BMO}^2 \\ & \leq \frac{10}{3} \left(\frac{5}{2} \left\| \frac{\bar{b}^i}{\sqrt{\alpha^i}} \right\|_{\mathcal{G}^{(N)}, BMO}^4 + \frac{40\|\theta^i\|^2}{(1-\mathbb{E}[\theta^i])^2} \|b^{i0}\|_{\mathcal{G}^{(N)}, BMO}^2 \left\| \frac{b^{i0}}{\alpha^i} \right\|_{\mathcal{G}^{(N)}, BMO}^2 \right. \\ & \quad \left. + 10\|\theta^i\|^2 \left\| \frac{\bar{b}^i}{\sqrt{\alpha^i}} \right\|_{\mathcal{G}^{(N)}, BMO}^4 + \|\theta^i \bar{x}^{-i}\|^2 \right), \end{aligned}$$

from which the desired result follows due to the second and the third lines of (2.6). \square

Remark 2.3. Although $(\check{Y}^i, \check{Z}^i, \check{Z}^{i0})$ are progressively measurable w.r.t. $\mathbb{F}^i \vee \mathcal{G}$, in Lemma 2.2 we use the larger filtration $\mathcal{G}^{(N)}$ in order to use this lemma to prove the well-posedness result of (2.4).

With the well-posedness of (2.5) especially the BMO bound of the solution at hand, we can solve (2.4). The approach is to compare (2.4) with the system of benchmark BSDEs (2.5). Let

The estimate of $B^{i,N}$ can be found in Lemma A.2. In particular, $\|\sqrt{|B^{i,N}|}\|_{\mathcal{G}^{(N)}, BMO}$ can be made small enough by assuming $\{\|\theta^i\|\}_i$ small enough.

In order to facilitate the presentation of the estimate, we introduce the following notation: for two sequences of stochastic processes f^n and g^n , denote

That is, there exists a unique $(\widetilde{Y}^i, \widetilde{Z}^{ii}, \widetilde{Z}^{i0}, \widetilde{Z}^{ij}, j \neq i) \in \mathbb{S}_{\mathcal{G}^{(N)}}^\infty \times \mathbb{H}_{\mathcal{G}^{(N)},BMO}^2 \times \cdots \times \mathbb{H}_{\mathcal{G}^{(N)},BMO}^2$, $i = 1, \dots, N$, such that (2.2) holds, and there exists a unique $(X^i, Y^i, Z^{ii}, Z^{i0}, Z^{ij}, j \neq i) \in \mathbb{S}_{\mathcal{G}^{(N)}}^2 \times \mathbb{S}_{\mathcal{G}^{(N)}}^2 \times \mathbb{H}_{\mathcal{G}^{(N)},BMO}^2 \times \cdots \times \mathbb{H}_{\mathcal{G}^{(N)},BMO}^2$, for each $i = 1, \dots, N$, such that (1.7) holds.

Proof. We use the fixed point argument in [41]. For each $i = 1, \dots, N$, fix $((\widetilde{z}^{ij})_{j \neq i}, \widetilde{z}^{ii}, \widetilde{z}^{i0})$ such that

By Proposition A.3, there exists a unique solution $(\widehat{Y}^i, \widehat{Z}^{ii}, \widehat{Z}^{i0}, \widehat{Z}^{ij}, j \neq i) \in \mathbb{S}_{\mathcal{G}^{(N)}}^\infty \times \mathbb{H}_{\mathcal{G}^{(N)},BMO}^2 \times \cdots \times \mathbb{H}_{\mathcal{G}^{(N)},BMO}^2$ for each $i = 1, \dots, N$. In the following we will prove $\sum_{j \neq i} \|\widehat{Z}^{ij}\|_{\mathcal{G}^{(N)},BMO}^2 + \|\widehat{Z}^{ii}\|_{\mathcal{G}^{(N)},BMO}^2 + \|\widehat{Z}^{i0}\|_{\mathcal{G}^{(N)},BMO}^2 \leq (\max_i A^{i,N})^2$ for each i and the mapping $\{(\widehat{z}^{ii}, \widehat{z}^{i0}, \widehat{z}^{ij}, j \neq i)\}_{i=1, \dots, N} \mapsto \{(\widehat{Z}^{ii}, \widehat{Z}^{i0}, \widehat{Z}^{ij}, j \neq i)\}_{i=1, \dots, N}$ is a contraction. 2.2 Verification and Convergence to MFG

Theorem 2.5. *Assume Assumption 1, (2.6), (2.11) and (2.12) hold. Let the space of admissible strategies for each player be $\mathbb{H}_{\mathcal{G}(N), BMO}^2$. Then the vector $(\bar{\pi}^{1,*}, \dots, \bar{\pi}^{N,*})$ is the unique Nash equilibrium of the N -player game (1.4)-(1.5), where for each $i = 1, \dots, N$, $\bar{\pi}^{i,*}$ is given by (1.6). Moreover, the value function for player i is given by*

$$V^i(x^i; x^j, j \neq i) = -e^{-\alpha^i(x^i - Y_0^i)},$$

where Y^i is the backward component of the solution to (1.7).

Proof. As a corollary of Theorem 2.4, $\bar{\pi}^{i,*} \in \mathbb{H}_{\mathcal{G}(N), BMO}^2$ is admissible. By [28, Theorem 2.3], $M^{i, \bar{\pi}^{i,*}} = \mathcal{E} \left(-\alpha^i \int_0^\cdot (\bar{\pi}_s^{i,*} - \bar{Z}_s^i) d\bar{W}_s^i + \alpha^i \sum_{j \neq i} \int_0^\cdot Z_s^{ij} dW_s^j \right)$ is a martingale, where $\mathcal{E}(\cdot)$ is the stochastic exponential of \cdot . By construction, $A^{i, \bar{\pi}^{i,*}} = e^{-\alpha^i \int_0^\cdot (\bar{\pi}_s^{i,*} \bar{b}_s^i - f_s^i) ds + \frac{(\alpha^i)^2}{2} \int_0^\cdot |\bar{\pi}_s^{i,*} - \bar{Z}_s^i|^2 ds + \frac{(\alpha^i)^2}{2} \sum_{j \neq i} \int_0^\cdot (Z_s^{ij})^2 ds} = 0$. The construction of $R^{i, \bar{\pi}^{i,*}}$ implies it is a martingale. For any $\bar{\pi} \in \mathbb{H}_{\mathcal{G}(N), BMO}^2$, $M^{i, \bar{\pi}}$ is a martingale and $A^{i, \bar{\pi}}$ is non-decreasing and thus $R^{i, \bar{\pi}}$ is a supermartingale. As a result, for all $\bar{\pi} \in \mathbb{H}_{\mathcal{G}(N), BMO}^2$

The next corollary of Theorem 2.4 and Theorem 2.5 shows the unique equilibrium of the N -player game converges to the unique equilibrium of the corresponding MFG. To emphasize the dependence on N , we denote by $(X^{i,N}, Y^{i,N}, Z^{i,N}, Z^{i0,N}, Z^{ij,N}, j \neq i)_{i=1, \dots, N}$ the solution to (1.7) and by $(\bar{\pi}^{1,*N}, \dots, \bar{\pi}^{N,*N})$ the equilibrium of (1.4)-(1.5).

Corollary 2.6 (Convergence to MFG). *In addition to Assumption 1, we assume (2.6), (2.11) and (2.12) hold for all N . Moreover, we make the following assumptions on b^i and $(\alpha^i, x^i, \theta^i)$:*

& \leq \left\{ \frac{2\sqrt{2}\|\alpha\|A^N}{(N-1)^2} \frac{1}{N} \sum_{i=1}^N \sum_{j \neq i} \mathbb{E} \left[\int_0^T \left(\widehat{Z}_s^{jj,N} + \check{Z}_s^j + \frac{b_s^j}{\alpha^j} \right)^2 ds \right] + \frac{1}{5(N-1)^2} \sum_{j=1}^N \mathbb{E} \left[\int_0^T (\widehat{Z}_s^{j0,N})^2 ds \right] \right. \\
& \quad \left. + \frac{1}{N} \sum_{i=1}^N \mathbb{E} \left[\int_0^T (B_s^{i,N})^2 ds \right] \right\} \exp \left\{ 10\|\bar{b}\|_\infty^2 + 10\|\theta\|^2\|\bar{b}\|_\infty^2 \right. \\
& \quad \left. + \frac{40\|\theta\|^2\|b^0\|_\infty^2}{(1-\|\theta\|)^2} + \frac{40\|\theta\|^4\|b^0\|_\infty^2}{(1-\|\theta\|)^2} + 1 \right\} \\
& \rightarrow 0 \quad \text{as } N \rightarrow \infty.
\end{aligned}$$

Going back to (2.18) we get as $N \rightarrow \infty$

$$\frac{1}{N} \sum_{i=1}^N \mathbb{E} \left[\int_0^T (\widehat{Z}_s^{ii,N})^2 ds \right] + \frac{1}{N} \sum_{i=1}^N \mathbb{E} \left[\int_0^T (\widehat{Z}_s^{i0,N})^2 ds \right] + \frac{1}{N} \sum_{i=1}^N \sum_{j \neq i} \mathbb{E} \left[\int_0^T (\widetilde{Z}_s^{ij,N})^2 ds \right] \rightarrow 0. \tag{2.19}$$

Now we turn to the estimate (2.17), from which by rearranging terms we obtain

$$\begin{aligned}
& \mathbb{E}(\widehat{Y}_t^{i,N})^2 + \frac{9}{10} \mathbb{E} \left[\int_t^T (\widehat{Z}_s^{ii,N})^2 ds \right] + \frac{9}{10} \mathbb{E} \left[\int_t^T (\widehat{Z}_s^{i0,N})^2 ds \right] + \frac{39}{40} \sum_{j \neq i} \mathbb{E} \left[\int_t^T (\widetilde{Z}_s^{ij,N})^2 ds \right] \\
& \leq \left(10\|\bar{b}\|_\infty^2 + 10\|\theta\|^2\|\bar{b}\|_\infty^2 + \frac{40\|\theta\|^2\|b^0\|_\infty^2}{(1-\|\theta\|)^2} + \frac{40\|\theta\|^4\|b^0\|_\infty^2}{(1-\|\theta\|)^2} + 1 \right) \mathbb{E} \left[\int_t^T (\widehat{Y}_s^{i,N})^2 ds \right] \\
& + 2\|\alpha\|\|\widehat{Y}^{i,N}\|_\infty \frac{1}{(N-1)^2} \sum_{j \neq i} \mathbb{E} \left[\int_0^T \left(\widehat{Z}_s^{jj,N} + \check{Z}_s^j + \frac{b_s^j}{\alpha^j} \right)^2 ds \right] + \frac{1}{10(N-1)} \sum_{j \neq i} \mathbb{E} \left[\int_0^T (\widehat{Z}_s^{jj,N})^2 ds \right] \\
& + \frac{1}{5} \left(\frac{1}{N-1} + \frac{1}{(N-1)^2} \right) \sum_{j=1}^N \mathbb{E} \left[\int_0^T (\widehat{Z}_s^{j0,N})^2 ds \right] + \frac{1}{10(N-1)} \sum_{j \neq i} \mathbb{E} \left[\int_0^T (\widehat{Z}_s^{j0,N})^2 ds \right]
\end{aligned}$$

$$+ \mathbb{E} \left[\int_0^T (B_s^{i,N})^2 ds \right],$$

from which Grönwall's inequality, Lemma A.2 and (2.19) imply as $N \rightarrow \infty$

$$\sup_{t \in [0, T]} \mathbb{E}(\widehat{Y}_t^{i,N})^2 + \mathbb{E} \left[\int_0^T (\widehat{Z}_s^{ii,N})^2 ds \right] + \mathbb{E} \left[\int_0^T (\widehat{Z}_s^{i0,N})^2 ds \right] + \sum_{j \neq i} \mathbb{E} \left[\int_0^T (\widetilde{Z}_s^{ij,N})^2 ds \right] \rightarrow 0.$$

Applying Itô's formula again and using the above convergence we have

$$\lim_{N \rightarrow \infty} \mathbb{E} \left[\sup_{0 \leq t \leq T} (\widehat{Y}_t^{i,N})^2 \right] = 0.$$

Using the transformation (2.3) and (2.9) we get the desired convergence results. \square

3 Mean Field Games

In Section 2 we solved the N -player game (1.4)-(1.5) and showed its convergence to the MFG (1.10) under restrictive assumptions. In this section we solve the MFG (1.10) directly under a mild assumption on θ . Moreover, when the stock managed by each player is independent of each other, we show in Section 3.2 that the competition factor θ can be relaxed to be a random variable that is adapted to the largest σ -algebra. In particular, we consider the mean field FBSDE (1.13), whose solvability has its own interest.

Let \mathcal{G} be a σ -algebra independent of (W, W^0) and denote $\mathcal{F} := (\mathcal{F}_t)_{0 \leq t \leq T} := \mathbb{F} \vee \mathcal{G}$, where we recall \mathbb{F} is the filtration generated by (W, W^0) .

3.1 The MFG with Two Risky Assets

Assumption 2 (Assumptions for MFGs with Two Assets). \bullet The competition factor θ , the initial wealth of the representative player \mathcal{X} and the risk aversion parameter α are \mathcal{G} random variables. Moreover, θ is valued in $[0, 1)$, $\mathcal{X} \in L^2$ and α is positively valued.

- \bullet The random return rate for the representative player is bounded, i.e., $b \in \mathbb{L}_{\mathcal{F}}^\infty$.

Theorem 3.1. *Let Assumption 2 hold. Then there exists a unique $(X, Y, Z, Z^0) \in \mathbb{S}_{\mathcal{F}}^2 \times \mathbb{S}_{\mathcal{F}}^2 \times \mathbb{H}_{\mathcal{F}, BMO}^2 \times \mathbb{H}_{\mathcal{F}, BMO}^2$ satisfying (1.11). Consequently, there exists a unique equilibrium of the MFG (1.10) if the space of admissible strategies for the representative player is $\mathbb{H}_{\mathcal{F}, BMO}^2$.*

Proof. The proof is similar to that of Theorem 2.4 so we sketch it. Let

$$\widetilde{Y} = Y - \theta \int_0^t \mathbb{E} \left[\overline{Z}_s \overline{b}_s + \frac{|\overline{b}_s|^2}{\alpha} \middle| \mathcal{F}_s^0 \right] ds - \theta \int_0^t \mathbb{E} \left[Z_s^0 + \frac{b_s^0}{\alpha} \middle| \mathcal{F}_s^0 \right] dW_s^0,$$

which implies

$$\begin{cases} d\widetilde{Y}_t = \left\{ b_t \widetilde{Z}_t + \frac{|\overline{b}_t|^2}{2\alpha} + b_t^0 \left(\widetilde{Z}_t^0 + \frac{\theta}{1 - \mathbb{E}[\theta]} \mathbb{E}[\widetilde{Z}_t^0 | \mathcal{F}_t^0] + \frac{\theta}{1 - \mathbb{E}[\theta]} \mathbb{E} \left[\frac{b_t^0}{\alpha} \middle| \mathcal{F}_t^0 \right] \right) \right. \\ \quad \left. - \theta \mathbb{E} \left[\frac{|\overline{b}_t|^2}{\alpha} \middle| \mathcal{F}_t^0 \right] - \theta \mathbb{E}[b_t \widetilde{Z}_t | \mathcal{F}_t^0] - \theta \mathbb{E}[b_t^0 \widetilde{Z}_t^0 | \mathcal{F}_t^0] - \frac{\theta}{1 - \mathbb{E}[\theta]} \mathbb{E}[\theta b_t^0 | \mathcal{F}_t^0] \mathbb{E}[\widetilde{Z}_t^0 | \mathcal{F}_t^0] \right. \\ \quad \left. - \frac{\theta}{1 - \mathbb{E}[\theta]} \mathbb{E}[\theta b_t^0 | \mathcal{F}_t^0] \mathbb{E} \left[\frac{b_t^0}{\alpha} \middle| \mathcal{F}_t^0 \right] \right\} dt + \widetilde{Z}_t dW_t + \widetilde{Z}_t^0 dW_t^0, \\ \widetilde{Y}_T = \theta \mathbb{E}[\mathcal{X}], \end{cases}$$

with $\tilde{Z}_t = Z_t$ and $\tilde{Z}_t^0 = Z_t^0 - \theta \mathbb{E}[Z_t^0 + \frac{b_t^0}{\alpha} | \mathcal{F}_t^0] \Leftrightarrow Z_t^0 = \tilde{Z}_t^0 + \theta \frac{\mathbb{E}[\tilde{Z}_t^0 | \mathcal{F}_t^0] + \mathbb{E}[\frac{b_t^0}{\alpha} | \mathcal{F}_t^0]}{1 - \mathbb{E}[\theta]}$. The well-posedness of the above conditional mean field BSDE in $\mathbb{S}_{\mathcal{F}}^2 \times \mathbb{H}_{\mathcal{F}, BMO}^2 \times \mathbb{H}_{\mathcal{F}, BMO}^2$ is obvious due to the Lipschitz property of the driver. In order to make the candidate strategy admissible, we need to show $(\tilde{Z}, \tilde{Z}^0) \in \mathbb{H}_{\mathcal{F}, BMO}^2 \times \mathbb{H}_{\mathcal{F}, BMO}^2$. This can be done by the same approach as that in the proof of Lemma 2.2. However, in MFG the complexity of the problem is significantly reduced and we can establish the well-posedness result under mild assumptions; see Assumption 2. In particular, we do not need additional assumptions on \bar{b} like Lemma 2.2. Indeed, let δ be a constant small enough such that

$$10\|b\|_{\infty}^2 \delta \leq \frac{1}{8}, \quad 20 \left(1 + \frac{\|\theta\|^2}{(1 - \mathbb{E}[\theta])^2} \right) \|b^0\|_{\infty}^2 \delta \leq \frac{1}{8}. \quad (3.1)$$

Then on $[T - \delta, T]$ the same argument leading to (2.13) implies

$$\begin{aligned} & \frac{3}{10} \|\tilde{Y}\|_{[T-\delta, T], \infty}^2 + \frac{3}{4} \|\tilde{Z}\|_{\mathcal{F}, [T-\delta, T], BMO}^2 + \frac{3}{4} \|\tilde{Z}^0\|_{\mathcal{F}, [T-\delta, T], BMO}^2 \\ & \leq \frac{5}{2} \left\| \frac{\bar{b}}{\sqrt{\alpha}} \right\|_{\mathcal{F}, [T-\delta, T], BMO}^4 + \frac{40\|\theta\|^2}{(1 - \mathbb{E}[\theta])^2} \|b^0\|_{\mathcal{F}, [T-\delta, T], BMO}^2 \left\| \frac{b^0}{\sqrt{\alpha}} \right\|_{\mathcal{F}, [T-\delta, T], BMO}^2 \\ & \quad + 10\|\theta\|^2 \left\| \frac{b}{\sqrt{\alpha}} \right\|_{\mathcal{F}, [T-\delta, T], BMO}^4 + \|\theta\|^2 (\mathbb{E}[\mathcal{X}])^2. \end{aligned}$$

In consideration of (3.1), repeating the argument finitely many times implies $\|\tilde{Z}\|_{\mathcal{F}, BMO} + \|\tilde{Z}^0\|_{\mathcal{F}, BMO} < \infty$.

With the wellposedness result especially (\tilde{Z}, \tilde{Z}^0) located in the BMO space, the verification can be done by the proof of [22, Theorem 7].

□

Remark 3.2. In Theorem 3.1, θ is only assumed to be away from 1. The assumption is significantly reduced compared with Section 2. It provides sufficient reason to consider MFG although the N -player game is solvable.

3.2 MFGs with Independent Assets

In this part, we consider the MFG (1.12), where each player manages one stock whose dynamics is independent of the others. In this game, we allow the competition factor θ to be measurable w.r.t. the largest σ -algebra \mathcal{F}_T , where we recall $\mathcal{F}_T = \mathcal{F}_T \vee \mathcal{G}$. Note that there is no common noise in this section and we use the notation \mathcal{F} to stand for the filtration generated by the individual noise W , without any confusion.

As θ is measurable w.r.t. \mathcal{F}_T , in the second step of (1.10) $\theta\mu$ can be viewed as a general liability like that in [22, Section 2]. The same argument as in [22, Section 2] implies the optimal strategy and the value function of the representative player can be characterized by

$$\begin{cases} X_t = \mathcal{X} + \int_0^t \left(b_s Z_s + \frac{|b_s|^2}{\alpha} \right) ds + \int_0^t \left(Z_s + \frac{b_s}{\alpha} \right) dW_s \\ Y_t = \theta \mathbb{E}[X_T] - \int_t^T \left(b_s Z_s + \frac{|b_s|^2}{2\alpha} \right) ds - \int_t^T Z_s dW_s. \end{cases} \quad (3.2)$$

The well-posedness of (3.2) can be established in short time intervals or under the assumption that the return rate b is small enough. But it is more reasonable to establish the global well-posedness by

assuming that the relative performance factor θ is small enough. This weak interaction assumption is common in the game theory literature; see [16, 17, 20, 21] among others.

First, we establish the well-posedness result of (3.2) on a short time interval by a contraction argument.

Proposition 3.3. *Let Assumption 2 hold with θ 's measurability w.r.t. \mathcal{G} replaced by w.r.t. \mathcal{F}_T . For any δ satisfying*

$$\delta < \frac{1}{\left(\frac{4}{3}\|\theta\|^2 + \frac{16}{3}\|b\|_\infty^2\|\theta\|^2e^{4\|b\|_\infty^2}\right)\|b\|_\infty^2} \wedge 1 \wedge T, \quad (3.3)$$

there exists a unique $(X, Y, Z) \in \mathbb{S}_{\mathcal{F}}^2([T - \delta, T]) \times \mathbb{S}_{\mathcal{F}}^2([T - \delta, T]) \times \mathbb{L}_{\mathcal{F}}^2([T - \delta, T])$ satisfying (3.2) on $[T - \delta, T]$.

Proof. Replacing $\mathbb{E}[X_T]$ in (3.2) by $\mu \in \mathbb{R}$, there exists unique (Y, Z) solving the backward dynamics of (3.2) and taking Z into the forward part of (3.2) we obtain an X and thus a $\mathbb{E}[X_T]$. Thus, we obtain a mapping from $\mu \in \mathbb{R}$ to $\mathbb{E}[X_T] \in \mathbb{R}$. For any μ and $\mu' \in \mathbb{R}$, let (X, Y, Z) and (X', Y', Z') be the corresponding solutions to (3.2) with $\mathbb{E}[X_T]$ replaced by μ and μ' , respectively. Thus, $(X - X', Y - Y', Z - Z')$ satisfy for each $t \in [T - \delta, T]$

$$\begin{cases} X_t - X'_t = \int_{T-\delta}^t b_s (Z_s - Z'_s) ds + \int_{T-\delta}^t (Z_s - Z'_s) dW_s \\ Y_t - Y'_t = \theta(\mu - \mu') - \int_t^T b_s (Z_s - Z'_s) ds - \int_t^T (Z_s - Z'_s) dW_s. \end{cases}$$

Applying Itô's formula to the backward dynamics we get

$$\begin{aligned} & \mathbb{E}[(Y_t - Y'_t)^2] + \mathbb{E}\left[\int_t^T (Z_s - Z'_s)^2 ds\right] \\ & \leq \|\theta\|^2 |\mu - \mu'|^2 + 2\|b\|_\infty \mathbb{E}\left[\int_t^T |Y_s - Y'_s| |Z_s - Z'_s| ds\right] \\ & \leq \|\theta\|^2 |\mu - \mu'|^2 + \frac{1}{4} \mathbb{E}\left[\int_t^T (Z_s - Z'_s)^2 ds\right] + 4\|b\|_\infty^2 \mathbb{E}\left[\int_t^T (Y_s - Y'_s)^2 ds\right], \end{aligned}$$

where we recall by $\|b\|_\infty$ we mean the essential bound on $\Omega \times [0, T]$ not just on $\Omega \times [T - \delta, T]$. Grönwall's inequality implies

$$\mathbb{E}[(Y_t - Y'_t)^2] \leq \|\theta\|^2 e^{4\|b\|_\infty^2 \delta} |\mu - \mu'|^2$$

and hence

$$\mathbb{E}\left[\int_{T-\delta}^T (Z_s - Z'_s)^2 ds\right] \leq \left(\frac{4}{3}\|\theta\|^2 + \frac{16}{3}\delta\|b\|_\infty^2\|\theta\|^2e^{4\|b\|_\infty^2\delta}\right) |\mu - \mu'|^2.$$

From the forward dynamics we have

$$|\mathbb{E}[X_T - X'_T]|^2 \leq \|b\|_\infty^2 \delta \mathbb{E}\left[\int_{T-\delta}^T (Z_s - Z'_s)^2 ds\right].$$

By (3.3), the contraction follows. \square

For any initial point (t, x, \bar{x}) , define $u(t, x, \bar{x}) = Y_t^{t, x, \bar{x}}$. Uniqueness of (3.2) on $[T - \delta, T]$ implies $Y_s^{t, x, \bar{x}} = u(s, X_s^{t, x, \bar{x}}, \mathbb{E}[X_s^{t, x, \bar{x}}])$ for $s \in [t, T]$ and $t \in [T - \delta, T]$. Observe that (Y, Z) is well known once $\mathbb{E}[X]$ is fixed. Thus, Y depends only on $\mathbb{E}[X]$ and $Y_s = u(s, \mathbb{E}[X_s])$ for $s \in [T - \delta, T]$ with $Y_T = u(T, \mathbb{E}[X_T]) = \theta \mathbb{E}[X_T]$. Moreover, note that the coefficients of (3.2) are random, the decoupling field u is random and we drop the dependence on ω for simplicity. To extend the solution from $[T - \delta, T]$ to the whole interval, following [36]

we need to prove the decoupling field on each interval is uniformly Lipschitz; in [36] such a decoupling field is called a *regular decoupling field*. To do so, we consider the variational FBSDE.

For any \mathcal{X} and \mathcal{X}' in L^2 , let (X, Y, Z) and (X', Y', Z') be solutions to (3.2) corresponding to \mathcal{X} and \mathcal{X}' , respectively. The triple $(\mathbb{E}[\nabla X], \nabla Y, \nabla Z)$ satisfies the following variational FBSDE

$$\begin{cases} \mathbb{E}[\nabla X_t] = 1 + \int_0^t \mathbb{E}[b_s \nabla Z_s] ds \\ \nabla Y_t = \theta \mathbb{E}[\nabla X_T] - \int_t^T b_s \nabla Z_s ds - \int_t^T \nabla Z_s dW_s, \end{cases} \quad (3.4)$$

where

$$\mathbb{E}[\nabla X] = \frac{\mathbb{E}[X] - \mathbb{E}[X']}{\mathbb{E}[\mathcal{X}] - \mathbb{E}[\mathcal{X}']}, \quad \nabla Y = \frac{Y - Y'}{\mathbb{E}[\mathcal{X}] - \mathbb{E}[\mathcal{X}']}, \quad \nabla Z = \frac{Z - Z'}{\mathbb{E}[\mathcal{X}] - \mathbb{E}[\mathcal{X}']}.$$

By (3.4), $(\frac{\nabla Y}{\mathbb{E}[\nabla X]}, \frac{\nabla Z}{\mathbb{E}[\nabla X]})$ satisfies the following mean field BSDE

$$\hat{Y}_t = \theta - \int_t^T \left(b_s \hat{Z}_s - \hat{Y}_s \mathbb{E} [b_s \hat{Z}_s] \right) ds - \int_t^T \hat{Z}_s dW_s. \quad (3.5)$$

Following the terminology in [36], we call (3.5) the *characteristic BSDE* of (3.2). Moreover, for any (\hat{Y}, \hat{Z}) satisfying (3.5), define $\mathbb{E}[\nabla X]$ as the unique solution to the ODE

$$\mathbb{E}[\nabla X_t] = 1 + \int_0^t \mathbb{E}[b_s \hat{Z}_s] \mathbb{E}[\nabla X_s] ds$$

and define

$$\nabla Y = \hat{Y} \mathbb{E}[\nabla X] \quad \text{and} \quad \nabla Z = \hat{Z} \mathbb{E}[\nabla X].$$

Then $(\mathbb{E}[\nabla X], \nabla Y, \nabla Z)$ must satisfy (3.4). Thus, the solution to (3.5) and the solution to (3.4) have a one-to-one correspondence through

$$\hat{Y} = \frac{\nabla Y}{\mathbb{E}[\nabla X]} \quad \text{and} \quad \hat{Z} = \frac{\nabla Z}{\mathbb{E}[\nabla X]}.$$

The following proposition establishes the well-posedness result of (3.5) on the whole interval $[0, T]$.

Proposition 3.4. *Let θ be measurable w.r.t. \mathcal{F}_T . For each R satisfying*

$$R \leq \frac{1}{4 \|b\|_{\mathcal{F}, BMO}}, \quad (3.6)$$

choosing $\|\theta\|$ small enough such that

$$\begin{cases} 8 (\|b\|_{\mathcal{F}, BMO} + 1)^2 (1 + 2 \|b\|_{\mathcal{F}, BMO} e^{2 \|b\|_{\mathcal{F}, BMO} R} R) \|\theta\|^2 \leq R^2 \\ 8 (\|b\|_{\mathcal{F}, BMO} + 1)^2 \|b\|_{\mathcal{F}, BMO} \|\theta\| e^{\|b\|_{\mathcal{F}, BMO} R} \leq \frac{1}{2}, \end{cases} \quad (3.7)$$

there exists a unique $(\hat{Y}, \hat{Z}) \in \mathbb{S}_{\mathcal{F}}^\infty \times \mathbb{H}_{\mathcal{F}, BMO}^2$ satisfying the characteristic BSDE (3.5). In particular, $\|\hat{Y}\|_\infty + \|\hat{Z}\|_{\mathcal{F}, BMO} \leq R$.

Proof. Define $\frac{d\mathbb{Q}}{d\mathbb{P}} \Big|_{\mathcal{F}_t} = e^{-\int_0^t b_s dW_s - \frac{1}{2} \int_0^t b_s^2 ds}$, which implies $W^\mathbb{Q} := W + \int_0^\cdot b_s ds$ is a \mathbb{Q} Brownian motion. Under \mathbb{Q} we consider

$$\hat{Y}_t = \theta + \int_t^T \hat{Y}_s \mathbb{E} [b_s \hat{Z}_s] ds - \int_t^T \hat{Z}_s dW_s^\mathbb{Q}. \quad (3.8)$$

We solve (3.8) by a contraction argument. For any $R > 0$ and $z \in \mathbb{H}_{\mathcal{F}, BMO, R}^2$ we consider

$$\hat{Y}_t = \theta + \int_t^T \hat{Y}_s \mathbb{E} [b_s z_s] ds - \int_t^T \hat{Z}_s dW_s^\mathbb{Q}. \quad (3.9)$$

The formula for linear BSDE yields

$$0 \leq \widehat{Y}_t = \mathbb{E}^{\mathbb{Q}} \left[\theta e^{\int_t^T \mathbb{E}[b_s z_s] ds} \middle| \mathcal{F}_t \right] \leq \|\theta\| e^{\|b\|_{\mathcal{F}, BMO} R}. \quad (3.10)$$

Applying Itô's formula to (3.9) we have for each $\tau \in \mathcal{T}_{\mathcal{F}}$

$$\begin{aligned} \widehat{Y}_\tau + \mathbb{E}^{\mathbb{Q}} \left[\int_\tau^T \widehat{Z}_s^2 ds \middle| \mathcal{F}_\tau \right] &\leq \|\theta\|^2 + 2\mathbb{E}^{\mathbb{Q}} \left[\int_\tau^T \widehat{Y}_s^2 \mathbb{E}[|b_s z_s|] ds \middle| \mathcal{F}_\tau \right] \\ &\leq \|\theta\|^2 + 2\|\widehat{Y}\|_\infty^2 \mathbb{E} \left[\int_0^T |b_s z_s| ds \right] \\ &\leq \|\theta\|^2 + 2\|\widehat{Y}\|_\infty^2 \|b\|_{\mathcal{F}, BMO} \|z\|_{\mathcal{F}, BMO} \\ &\leq (1 + 2\|b\|_{\mathcal{F}, BMO} e^{2\|b\|_{\mathcal{F}, BMO} R} R) \|\theta\|^2. \end{aligned} \quad (3.11)$$

Thus, by the first inequality in (3.7) and [20, Lemma A.1] we get $\|\widehat{Z}\|_{\mathcal{F}, BMO} \leq R$. So the mapping $z \in \mathbb{H}_{BMO, R}^2 \rightarrow \widehat{Z} \in \mathbb{H}_{BMO, R}^2$ is well-defined. Next we show this mapping is a contraction. Fix $z, z' \in \mathbb{H}_{\mathcal{F}, BMO, R}^2$ and let $(\widehat{Y}, \widehat{Z})$ and $(\widehat{Y}', \widehat{Z}')$ be the corresponding solutions. Itô's formula implies

$$\begin{aligned} &(\widehat{Y}_\tau - \widehat{Y}'_\tau)^2 + \mathbb{E}^{\mathbb{Q}} \left[\int_\tau^T (\widehat{Z}_s - \widehat{Z}'_s)^2 ds \middle| \mathcal{F}_\tau \right] \\ &\leq 2\|\widehat{Y} - \widehat{Y}'\|_\infty^2 \mathbb{E} \left[\int_0^T |b_s| |z_s| ds \right] + 2\|\widehat{Y}'\|_\infty \|\widehat{Y} - \widehat{Y}'\|_\infty \mathbb{E} \left[\int_0^T |b_s| |z_s - z'_s| ds \right] \\ &\leq 2\|b\|_{\mathcal{F}, BMO} \|z\|_{\mathcal{F}, BMO} \|\widehat{Y} - \widehat{Y}'\|_\infty^2 + 2\|b\|_{\mathcal{F}, BMO} \|\widehat{Y}'\|_\infty \|\widehat{Y} - \widehat{Y}'\|_\infty \|z - z'\|_{\mathcal{F}, BMO} \\ &\leq 2\|b\|_{\mathcal{F}, BMO} R \|\widehat{Y} - \widehat{Y}'\|_\infty^2 + 2\|b\|_{\mathcal{F}, BMO} \|\theta\| e^{\|b\|_{\mathcal{F}, BMO} R} \|\widehat{Y} - \widehat{Y}'\|_\infty \|z - z'\|_{\mathcal{F}, BMO} \\ &\leq (2\|b\|_{\mathcal{F}, BMO} R + \|b\|_{\mathcal{F}, BMO} \|\theta\| e^{\|b\|_{\mathcal{F}, BMO} R}) \|\widehat{Y} - \widehat{Y}'\|_\infty^2 + \|b\|_{\mathcal{F}, BMO} \|\theta\| e^{\|b\|_{\mathcal{F}, BMO} R} \|z - z'\|_{\mathcal{F}, BMO}^2. \end{aligned}$$

Thus, the contraction property follows from [20, Lemma A.1], (3.6) and the second inequality of (3.7). \square

With Proposition 3.4, we can extend the short time solution in Proposition 3.3 to the whole interval.

Theorem 3.5. *Let Assumption 2 holds with the measurability of θ w.r.t. to \mathcal{G} replaced by w.r.t. \mathcal{F}_T . For a fixed R satisfying (3.6), let θ satisfy (3.7). Then there exists a unique $(Y, Z) \in \mathbb{S}_{\mathcal{F}}^2 \times \mathbb{L}_{\mathcal{F}}^2$ satisfying (3.2). As a result, there exists a unique equilibrium of the MFG (1.12).*

Proof. In Proposition 3.3 we have shown there exists a unique solution to (3.2) on $[T - \delta, T]$ with δ satisfying (3.3). Next, we will prove the well-posedness result of the FBSDE (3.2) on $[T - 2\delta, T - \delta]$ by choosing δ further smaller

$$\begin{cases} X_t = X_{T-2\delta} + \int_{T-2\delta}^t \left(b_s Z_s + \frac{|b_s|^2}{\alpha} \right) ds + \int_{T-2\delta}^t \left(Z_s + \frac{b_s}{\alpha} \right) dW_s \\ Y_t = u(T - \delta, \mathbb{E}[X_{T-\delta}]) - \int_t^{T-\delta} \left(b_s Z_s + \frac{|b_s|^2}{2\alpha} \right) ds - \int_t^{T-\delta} Z_s dW_s, \end{cases} \quad (3.12)$$

where u is the decoupling field constructed from the solution of (3.2) on $[T - \delta, T]$. By Proposition 3.4 it holds that

$$|u(T - \delta, \mathbb{E}[X_{T-\delta}]) - u(T - \delta, \mathbb{E}[X'_{T-\delta}])| \leq R |\mathbb{E}[X_{T-\delta}] - \mathbb{E}[X'_{T-\delta}]|.$$

Replacing $\mathbb{E}[X_{T-\delta}]$ by μ the FBSDE (3.12) is decoupled and we can get a mapping from $\mu \in \mathbb{R}$ to $\mathbb{E}[X_{T-\delta}] \in \mathbb{R}$, where X is the solution to (3.12) with terminal condition replaced by $u(T - \delta, \mu)$. Next

we show this is a contraction. Itô's formula implies

$$\begin{aligned} & \mathbb{E}[(Y_t - Y'_t)^2] + \mathbb{E} \left[\int_t^{T-\delta} (Z_s - Z'_s)^2 ds \right] \\ & \leq R^2 |\mu - \mu'|^2 + 2 \|b\|_\infty \mathbb{E} \left[\int_t^{T-\delta} |Y_s - Y'_s| |Z_s - Z'_s| ds \right] \\ & \leq R^2 |\mu - \mu'|^2 + \frac{1}{4} \mathbb{E} \left[\int_t^{T-\delta} (Z_s - Z'_s)^2 ds \right] + 4 \|b\|_\infty^2 \mathbb{E} \left[\int_t^{T-\delta} (Y_s - Y'_s)^2 ds \right], \end{aligned}$$

together with Grönwall's inequality we get

$$\mathbb{E} \left[\int_{T-2\delta}^{T-\delta} (Z_s - Z'_s)^2 ds \right] \leq \left(\frac{4}{3} R^2 + \frac{16}{3} \delta \|b\|_\infty^2 R^2 e^{4\|b\|_\infty^2 \delta} \right) |\mu - \mu'|^2.$$

The forward dynamics implies

$$|\mathbb{E}[X_{T-\delta} - X'_{T-\delta}]|^2 \leq \|b\|_\infty^2 \delta \mathbb{E} \left[\int_{T-2\delta}^{T-\delta} (Z_s - Z'_s)^2 ds \right].$$

Thus, in addition to (3.3) we let δ be further smaller such that the following inequality holds

$$\|b\|_\infty^2 \delta \left(\frac{4}{3} R^2 + \frac{16}{3} \|b\|_\infty^2 R^2 e^{4\|b\|_\infty^2 \delta} \right) < \frac{1}{2}, \quad (3.13)$$

the map $\mu \rightarrow \mathbb{E}[X_{T-\delta}]$ is a contraction.

Noting the uniformly Lipschitz property of the decoupling field by Proposition 3.4 and repeating the above analysis by choosing δ satisfying

$$\delta < \frac{1}{2\|b\|_\infty^2 R^2 \left(\frac{4}{3} + \frac{16}{3} \|b\|_\infty^2 e^{4\|b\|_\infty^2 \delta} \right)} \wedge \frac{1}{2\|b\|_\infty^2 \|\theta\|^2 \left(\frac{4}{3} + \frac{16}{3} \|b\|_\infty^2 e^{4\|b\|_\infty^2 \delta} \right)} \wedge 1 \wedge T, \quad (3.14)$$

which implies both (3.3) and (3.13), the FBSDE on any small interval $[T - (j+1)\delta, T - j\delta]$ is solvable.

To show the well-posedness of (3.2), it is sufficient to choose compatible parameters. For each fixed R satisfying (3.6) we choose θ satisfying (3.7), which is equivalent to

$$\frac{1}{\|\theta\|} \geq 16(\|b\|_{\mathcal{F}, BMO} + 1)^2 \|b\|_{\mathcal{F}, BMO} e^{\|b\|_{\mathcal{F}, BMO} R} \sqrt{\frac{2\sqrt{2}(\|b\|_{\mathcal{F}, BMO} + 1)(1 + 2\|b\|_{\mathcal{F}, BMO} R e^{2\|b\|_{\mathcal{F}, BMO} R})^{\frac{1}{2}}}{R}}.$$

So it is sufficient to choose δ small enough such that

$$\begin{aligned} \delta & < \frac{1}{2\|b\|_\infty^2 R^2 \left(\frac{4}{3} + \frac{16}{3} \|b\|_\infty^2 e^{4\|b\|_\infty^2 \delta} \right)} \wedge 1 \wedge T \\ & \wedge \left(\frac{32(\|b\|_{\mathcal{F}, BMO} + 1)^4 \|b\|_{\mathcal{F}, BMO}^2 e^{2\|b\|_{\mathcal{F}, BMO} R}}{\|b\|_\infty^2 \left(\frac{1}{3} + \frac{4}{3} \|b\|_\infty^2 e^{4\|b\|_\infty^2 \delta} \right)} \sqrt{\frac{(\|b\|_{\mathcal{F}, BMO} + 1)^2 (1 + 2\|b\|_{\mathcal{F}, BMO} R e^{2\|b\|_{\mathcal{F}, BMO} R})}{\|b\|_\infty^2 R^2 \left(\frac{1}{3} + \frac{4}{3} \|b\|_\infty^2 e^{4\|b\|_\infty^2 \delta} \right)}} \right), \end{aligned}$$

which implies (3.14).

It remains to prove the solution of (3.2) characterizes the unique equilibrium of (1.12). To do so, it is sufficient to prove $Z \in \mathbb{H}_{\mathcal{F}, BMO}^2$. This result is standard since the terminal condition $\theta \mathbb{E}[X_T]$ is well-known and bounded and the driver is subquadratic; see e.g. [29]. \square

4 Explicitly Solvable Examples Beyond Constant Settings

In this section, we consider a special case under our investment framework and derive the equilibria for both the N -player game and the MFG in closed forms. Moreover, based on the closed form solutions, the financial interpretation is provided.

4.1 An N-player game

For each i , assume $(\alpha^i, \theta^i, x^i)$ are \mathcal{G} -random variables, which are independent of all Brownian motions and $\alpha^i > 0$, $\prod_{i=1}^N \theta^i < 1$. Let the return processes for the two stocks managed by player i be $b^i(t, \alpha^i, \theta^i, x^i)$ and $b^{i0}(t, \alpha^i, \theta^i, x^i)$, respectively, for two bounded and measurable functions b^i and b^{i0} . Recall that the volatilities are assumed to be 1 for simplicity.

Define the Z -component as follows: for each $i = 1, \dots, N$

$$Z^{ii} = 0, \quad Z^{ij} = \frac{\theta^i}{N-1} \frac{b^j}{\alpha^j}, \quad j \neq i \quad (4.1)$$

and

$$Z^{i0} = \frac{\theta^i}{N-1+\theta^i} \frac{\sum_{j=1}^N \frac{\theta^j}{N-1+\theta^j} \sum_{j=1}^N \frac{b^{j0}}{\alpha^j} - \sum_{j=1}^N \frac{\theta^i b^{i0}}{(N-1+\theta^j)\alpha^j}}{1 - \sum_{j=1}^N \frac{\theta^j}{N-1+\theta^j}} + \frac{\theta^i}{N-1+\theta^i} \sum_{j \neq i} \frac{b^{j0}}{\alpha^j}. \quad (4.2)$$

Note that the denominator $1 - \sum_{j=1}^N \frac{\theta^j}{N-1+\theta^j} > 0$ if and only if $\prod_{j=1}^N \theta^j < 1$. The resulting strategy for player i is

$$\bar{\pi} = (\pi^i, \pi^{i0}) = \left(\frac{b^i}{\alpha^i}, Z^{i0} + \frac{b^{i0}}{\alpha^i} \right). \quad (4.3)$$

Now we verify that (4.1) and (4.2) induce a solution of (1.7). Taking (4.1) and (4.2) into the forward equation and then the backward equation, we obtain

$$\begin{aligned} Y_t^i &= \theta^i \bar{x}^{-i} + \frac{\theta^i}{N-1} \sum_{j \neq i} \int_0^T \left(Z_s^{j0} b_s^{j0} + \frac{|\bar{b}_s^j|^2}{\alpha^j} \right) ds - \int_t^T \left(Z_s^{i0} b_s^{i0} + \frac{|\bar{b}_s^i|^2}{2\alpha^i} - \frac{\alpha^i}{2} \sum_{j \neq i} (Z_s^{ij})^2 \right) ds \\ &\quad + \frac{\theta^i}{N-1} \sum_{j \neq i} \int_0^t \frac{b_s^j}{\alpha^j} dW_s^j + \frac{\theta^i}{N-1} \sum_{j \neq i} \int_0^t \left(Z_s^{j0} + \frac{b_s^{j0}}{\alpha^j} \right) dW_s^0 \\ &\quad + \sum_{j \neq i} \int_t^T \left(\frac{\theta^i}{N-1} \frac{b_s^j}{\alpha^j} - Z_s^{ij} \right) dW_s^j + \int_t^T \left(\frac{\theta^i}{N-1} \sum_{j \neq i} \left(Z_s^{j0} + \frac{b_s^{j0}}{\alpha^j} \right) - Z_s^{i0} \right) dW_s^0. \end{aligned}$$

With Z defined as in (4.1) and (4.2), the integrands of the stochastic integral w.r.t. dW^j and dW^0 from t to T vanish, that is,

$$\frac{\theta^i}{N-1} \frac{b^j}{\alpha^j} - Z^{ij} = 0, \quad \frac{\theta^i}{N-1} \sum_{j \neq i} \left(Z^{j0} + \frac{b^{j0}}{\alpha^j} \right) - Z^{i0} = 0. \quad (4.4)$$

It results in that Y_t^i is measurable w.r.t. $\mathcal{F}_t^{(N)}$.

4.2 MFG: Random Return Processes

Let $(\alpha, \theta, \mathcal{X})$ be \mathcal{G} -random variables with \mathcal{G} independent of all Brownian motions, and the return processes (b, b^0) are assumed to be

$$(b_t, b_t^0) = (b(t, \alpha, \theta, \mathcal{X}), b^0(t, \alpha, \theta, \mathcal{X})),$$

for some bounded and measurable functions (b, b^0) . We recall the assumption on the volatilities, $\sigma, \sigma^0 = 1$. Define the Z -component as follows

$$(Z, Z^0) = \bar{Z} = \left(0, \frac{\theta}{1 - \mathbb{E}[\theta]} \mathbb{E} \left[\frac{b^0}{\alpha} \right] \right) \quad (4.5)$$

For the above \bar{Z} , we have the investment strategy for the representative agent

$$\bar{\pi} = (\pi, \pi^0) = \left(\frac{b}{\alpha}, \frac{\theta}{1 - \mathbb{E}[\theta]} \mathbb{E} \left[\frac{b^0}{\alpha} \right] + \frac{b^0}{\alpha} \right). \quad (4.6)$$

We verify directly that (4.5) satisfies (1.11). Indeed, taking (4.5) into the forward dynamics of (1.11), one has

$$\theta \mathbb{E}[X_T | \mathcal{F}_T^0] = \theta \mathbb{E}[\mathcal{X}] + \theta \int_0^T \left(\mathbb{E} \left[\frac{b_s^2}{\alpha} \right] + \frac{\mathbb{E}[\theta b_s^0]}{1 - \mathbb{E}[\theta]} \mathbb{E} \left[\frac{b_s^0}{\alpha} \right] + \mathbb{E} \left[\frac{(b_s^0)^2}{\alpha} \right] \right) ds + \int_0^T \frac{\theta}{1 - \mathbb{E}[\theta]} \mathbb{E} \left[\frac{b_s^0}{\alpha} \right] dW_s^0.$$

Taking this equality into the backward equation of (1.11), we have

$$\begin{aligned} Y_t &= \theta \mathbb{E}[\mathcal{X}] + \theta \int_0^T \left(\mathbb{E} \left[\frac{b_s^2}{\alpha} \right] + \frac{\mathbb{E}[\theta b_s^0]}{1 - \mathbb{E}[\theta]} \mathbb{E} \left[\frac{b_s^0}{\alpha} \right] + \mathbb{E} \left[\frac{(b_s^0)^2}{\alpha} \right] \right) ds + \int_0^T \frac{\theta}{1 - \mathbb{E}[\theta]} \mathbb{E} \left[\frac{b_s^0}{\alpha} \right] dW_s^0 \\ &\quad - \int_t^T \left(\frac{\theta}{1 - \mathbb{E}[\theta]} \mathbb{E} \left[\frac{b_s^0}{\alpha} \right] b_s^0 + \frac{|\bar{b}_s|^2}{2\alpha} \right) ds - \int_t^T \frac{\theta}{1 - \mathbb{E}[\theta]} \mathbb{E} \left[\frac{b_s^0}{\alpha} \right] dW_s^0 \\ &= \theta \mathbb{E}[\mathcal{X}] + \theta \int_0^T \left(\mathbb{E} \left[\frac{b_s^2}{\alpha} \right] + \frac{\mathbb{E}[\theta b_s^0]}{1 - \mathbb{E}[\theta]} \mathbb{E} \left[\frac{b_s^0}{\alpha} \right] + \mathbb{E} \left[\frac{(b_s^0)^2}{\alpha} \right] \right) ds + \int_0^t \frac{\theta}{1 - \mathbb{E}[\theta]} \mathbb{E} \left[\frac{b_s^0}{\alpha} \right] dW_s^0 \\ &\quad - \int_t^T \left(\frac{\theta}{1 - \mathbb{E}[\theta]} \mathbb{E} \left[\frac{b_s^0}{\alpha} \right] b_s^0 + \frac{|\bar{b}_s|^2}{2\alpha} \right) ds. \end{aligned}$$

Note that the coefficients are \mathcal{G} -measurable. Thus, we obtain an \mathcal{F} -adapted solution. Moreover, the strategy (4.6) of MFG is a limit of the strategy (4.3) of the N -player game as $N \rightarrow \infty$.

4.3 Discussion of the solutions

This section provides some financial interpretation of the equilibria obtained in Section 4.1 and Section 4.2. The analytical solutions we obtained for MFG and the N -player game share similar structures and shed lights on each other.

First, the strategy π^i in the N -player game (or π in MFG) for the individual stock is of Merton type, since the individual stock dynamic in our setting is only driven by the idiosyncratic noise. For the N -player game, the hedging demand of player i for the her individual stock is 0, apart from the Merton proportion since the return process b^i is independent of the noise. This explains why $Z^{ii} = 0$ in the N -player game. Second, the terminal condition of the N -player FBSDE (1.7) results in the coupled structure of the solution component, which requires Z^{i0} satisfying a linear system (4.4). From (4.4), the investment π^{i0} can be rewritten as

$$\pi^{i0} = \frac{\theta^i}{N-1} \sum_{j \neq i} \pi^{j0} + \frac{b^{i0}}{\alpha^i}.$$

The structure of π^{i0} is clear. It consists of a weighted average of competitors' investment strategies and a Merton type portfolio. That is, player i 's investment into the stock driven by the common noise W^0 is a deviation from the one without competition. When θ^i is large, or player i is more competitive, she is more willing to mimic her competitors' strategies and is encouraged to deviate more from her own Merton portfolio. Otherwise, she will be less aggressive and keep her investment around the Merton one. In our MFG, it no longer requires Z^0 solving a linear system but a linear equation instead. This linear equation suggests

$$\pi^0 = \theta \mathbb{E}[\pi^0] + \frac{b^0}{\alpha},$$

where $\mathbb{E}[\pi^0]$ is considered as the aggregation of the competitors' strategies in the MFG. Thus, π^0 has a similar interpretation as π^{i0} above. Moreover, the expression (4.6) suggests that the investment strategy

π^0 is a weighted sum of the representative player's own Merton proportion $\frac{b^0}{\alpha}$ and the aggregation of competitors' Merton proportion $\mathbb{E}\left[\frac{b^0}{\alpha}\right]$. The weight is characterized by the constant $\frac{\theta}{1-\mathbb{E}[\theta]}$ appearing in (4.6), which captures that the strategy is not only proportional to the competition itself but also to the interaction effect. When θ is small, the representative player's own Merton proportion dominates. When $\mathbb{E}[\theta]$ is large, the aggregation effect dominates. Third, the term Z^{ij} in Section 4.1 appears because player i 's value function is influenced by the risk W^j of player j ; it is proportional to player j 's investment into the stock driven by W^j . In the MFG, competitors' risk does not influence the representative player any more so that Z^{ij} vanishes as N goes to infinity.

Our examples can be compared with [11] and [33]. On one hand, our investment strategies in Section 4.1 and Section 4.2 are distinguished from [33] by the fact that our examples go beyond constant settings while in [33], the unique constant equilibrium is found in a Black-Scholes market where the return processes as well as the volatilities for the idiosyncratic and common noise are constants. In the present setting, the returns for all stocks are time-dependent. Note that the volatilities are assumed to be 1 merely for simplicity; they can be time-dependent as well. Moreover, our examples are distinguished from [11] by the fact that we allow random return rates as well as each player trades two stocks, not merely a common one as in [11]. These two differences especially the random return rates make the properties of the investment strategies in [11] not always true in our case. In particular, the overinvestment property in [11, Proposition 5.5] is not necessarily true in our examples. On the other hand, our calculation results also suggest some similarities to [11] and [33]. First, if the return rate b^0 in our MFG is assumed to be positive as that in [33], then our π^0 share similar properties with [33]; in particular, the representative investor invests more in the stock driven by the common noise if she is more competitive or if her competitors are more competitive. Second, in [11, Proposition 5.5], it is shown that the overinvestment in risky assets occurs in more competitive markets, that is, in their setting the absolute value of the investment $|\pi^{i0}|$ is non-decreasing w.r.t. θ^j for all $j = 1, \dots, N$. This result is obviously true in our MFG when the return rate b^0 does not depend on $(\alpha, \theta, \mathcal{X})$. Generally, this is not necessarily true in our N -player game and MFG, as mentioned above. Note that when b^0 is independent of $(\alpha, \theta, \mathcal{X})$, the stock driven by the common noise becomes the common stock for all players.

5 Concluding Remarks

In this paper we study an N -player exponential utility game and a mean field exponential utility game in a non-Markovian setting. The well-posedness result of the N -player game is established by solving a novel multi-dimensional FBSDE with quadratic growth and unbounded terminal condition. The convergence from N -player game to the MFG is also established. Moreover, when the stock dynamics for each player is independent, we allow a more general competition factor and the equilibrium of MFG is characterized by a novel mean field FBSDE, whose global solvability has its own interest.

In this paper we only consider exponential utility case. The case of power utility deserves at least an equal treatment. In the power utility case, a more complicated quadratic multi-dimensional FBSDE as well as a novel mean field quadratic FBSDE is obtained. We consider this case in a separate paper. Moreover, in a forthcoming companion paper using the probabilistic analysis we answer an open question in the literature about whether a non-constant equilibrium exists or not in the constant setting like [32, 33, 39]. Finally, other interesting topics including investment-consumption games (like [32]) and games with model uncertainty will be studied in our future works.

A Appendix

The following estimate is used in the proof of Lemma 2.2.

Lemma A.1. *Let $f, g \in \mathbb{H}_{\mathcal{G}^{(N)}, BMO}^2$. For each $\tau \in \mathcal{T}_{\mathcal{G}^{(N)}}$, it holds that*

$$\mathbb{E} \left[\int_{\tau}^T \mathbb{E}[f_s g_s | \mathcal{F}_s^0] ds \middle| \mathcal{G}_{\tau}^{(N)} \right] \leq \|f\|_{\mathcal{G}^{(N)}, BMO} \|g\|_{\mathcal{G}^{(N)}, BMO}.$$

Proof. Step 1: By [26, Problem 2.17(i), Chapter 1], it holds that

$$\mathbb{E}[Z | \mathcal{G}_{\tau}^{(N)}] = \mathbb{E}[Z | \mathcal{G}_{\tau \wedge t}^{(N)}] \quad \text{on } \{\tau \leq t\}$$

as well as

$$\mathbb{E}[Z | \mathcal{G}_t^{(N)}] = \mathbb{E}[Z | \mathcal{G}_{\tau \wedge t}^{(N)}] \quad \text{on } \{t \leq \tau\}.$$

Thus,

$$\mathbb{E}[Z | \mathcal{G}_{\tau}^{(N)}] 1_{\{\tau=t\}} = \mathbb{E}[Z | \mathcal{G}_t^{(N)}] 1_{\{\tau=t\}}.$$

Step 2: τ is valued in $\mathbb{T} \subset [0, T]$, where \mathbb{T} is a countable set.

$$\begin{aligned} & \mathbb{E} \left[\int_{\tau}^T \mathbb{E}[f_s g_s | \mathcal{F}_s^0] ds \middle| \mathcal{G}_{\tau}^{(N)} \right] = \mathbb{E} \left[\int_0^T \mathbb{E}[f_s g_s | \mathcal{F}_s^0] ds \middle| \mathcal{G}_{\tau}^{(N)} \right] - \int_0^{\tau} \mathbb{E}[f_s g_s | \mathcal{F}_s^0] ds \\ &= \sum_{t \in \mathbb{T}} \left\{ \mathbb{E} \left[\int_0^T \mathbb{E}[f_s g_s | \mathcal{F}_s^0] ds \middle| \mathcal{G}_{\tau}^{(N)} \right] - \int_0^{\tau} \mathbb{E}[f_s g_s | \mathcal{F}_s^0] ds \right\} 1_{\{\tau=t\}} \\ &= \sum_{t \in \mathbb{T}} \left\{ \mathbb{E} \left[\int_0^T \mathbb{E}[f_s g_s | \mathcal{F}_s^0] ds \middle| \mathcal{G}_t^{(N)} \right] - \int_0^t \mathbb{E}[f_s g_s | \mathcal{F}_s^0] ds \right\} 1_{\{\tau=t\}} \quad (\text{by Step 1}) \\ &= \sum_{t \in \mathbb{T}} \mathbb{E} \left[\int_t^T \mathbb{E}[f_s g_s | \mathcal{F}_s^0] ds \middle| \mathcal{G}_t^{(N)} \right] 1_{\{\tau=t\}} \\ &= \sum_{t \in \mathbb{T}} \mathbb{E} \left[\int_t^T \mathbb{E}[f_s g_s | \mathcal{F}_s^0] ds \middle| \mathcal{F}_t^0 \right] 1_{\{\tau=t\}} \quad (\text{since } W^0 \text{ and } \mathcal{G}, \{W^i\}_{i=1}^N \text{ are independent}) \\ &= \sum_{t \in \mathbb{T}} \int_t^T \mathbb{E}[f_s g_s | \mathcal{F}_t^0] ds 1_{\{\tau=t\}} \quad (\text{by Fubini theorem and tower property of conditional expectation}) \\ &= \sum_{t \in \mathbb{T}} \mathbb{E} \left[\int_t^T f_s g_s ds \middle| \mathcal{F}_t^0 \right] 1_{\{\tau=t\}} \quad (\text{by Fubini theorem again}) \\ &= \sum_{t \in \mathbb{T}} \mathbb{E} \left\{ \mathbb{E} \left[\int_t^T f_s g_s ds \middle| \mathcal{G}_t^{(N)} \right] \middle| \mathcal{F}_t^0 \right\} 1_{\{\tau=t\}} \quad (\text{by tower property again}) \\ &\leq \sum_{t \in \mathbb{T}} \|f\|_{\mathcal{G}^{(N)}, BMO} \|g\|_{\mathcal{G}^{(N)}, BMO} 1_{\{\tau=t\}} \\ &= \|f\|_{\mathcal{G}^{(N)}, BMO} \|g\|_{\mathcal{G}^{(N)}, BMO}. \end{aligned}$$

Step 3: $\tau \in \mathcal{T}_{\mathcal{G}^{(N)}}$. Define τ_n as

$$\tau_n = \sum_{i=1}^n \frac{iT}{n} 1_{[\frac{(i-1)T}{n}, \frac{iT}{n})}(\tau) + T 1_{\{\tau=T\}}.$$

Then τ_n is an $\mathcal{G}^{(N)}$ stopping time with at most countable values. Moreover, $\tau_n \geq \tau$ and $\tau_n \rightarrow \tau$. Thus, it holds that

& \mathbb{E} \left[\int_{\tau}^T \mathbb{E}[f_s g_s | \mathcal{F}_s^0] ds \middle| \mathcal{G}_{\tau}^{(N)} \right] \\
&= \mathbb{E} \left\{ \mathbb{E} \left[\int_{\tau}^T \mathbb{E}[f_s g_s | \mathcal{F}_s^0] ds \middle| \mathcal{G}_{\tau_n}^{(N)} \right] \middle| \mathcal{G}_{\tau}^{(N)} \right\} \\
&= \mathbb{E} \left\{ \mathbb{E} \left[\int_{\tau_n}^T \mathbb{E}[f_s g_s | \mathcal{F}_s^0] ds \middle| \mathcal{G}_{\tau_n}^{(N)} \right] + \mathbb{E} \left[\int_{\tau}^{\tau_n} \mathbb{E}[f_s g_s | \mathcal{F}_s^0] ds \middle| \mathcal{G}_{\tau_n}^{(N)} \right] \middle| \mathcal{G}_{\tau}^{(N)} \right\} \\
&\leq \|f\|_{\mathcal{G}^{(N)}, BMO} \|g\|_{\mathcal{G}^{(N)}, BMO} + \mathbb{E} \left[\int_{\tau}^{\tau_n} \mathbb{E}[f_s g_s | \mathcal{F}_s^0] ds \middle| \mathcal{G}_{\tau}^{(N)} \right] \quad (\text{by Step 2}) \\
&\rightarrow \|f\|_{\mathcal{G}^{(N)}, BMO} \|g\|_{\mathcal{G}^{(N)}, BMO}.
\end{aligned}$$

□

By Lemma A.1, the next lemma provides an estimate of $B^{i,N}$ in (2.10).

&+ \frac{2\|\theta^i\|}{1 - \sum_{k=1}^N \frac{\|\theta^k\|}{N-1+\|\theta^k\|}} \|\bar{b}^0\|^{(-i),N} \left\| \frac{b^0}{\alpha^i} \right\|^{(-i),N} + \frac{\|\theta^i\|^2}{1 - \mathbb{E}[\theta^i]} \|b^{i0}\|_{\mathcal{G}^{(N)}, BMO} \left\| \frac{b^{i0}}{\alpha^i} \right\|_{\mathcal{G}^{(N)}, BMO} \\
&+ \|\theta^i\| \left\| \frac{\bar{b}^i}{\sqrt{\alpha^i}} \right\|^{2(-i),N} + \|\theta^i\| \left\| \frac{\bar{b}^i}{\sqrt{\alpha^i}} \right\|_{\mathcal{G}^{(N)}, BMO}^2 + \frac{\|\theta^i\|}{N-1} \left\| \frac{b^{i0}}{\sqrt{\alpha^i}} \right\|_{\mathcal{G}^{(N)}, BMO}^2 \\
&+ \frac{\|\theta^i\|}{(N-1)^2} \sum_{j \neq i} \|\theta^j\| \left\| \frac{b^{j0}}{\sqrt{\alpha^j}} \right\|_{\mathcal{G}^{(N)}, BMO}^2 + \frac{\|\theta^i\|}{N-1} \|b^{i0}\|_{\mathcal{G}^{(N)}, BMO} R.
\end{aligned}$$

Moreover, under the assumptions of Corollary 2.6, it holds that for any i

$$\lim_{N \rightarrow \infty} \mathbb{E} \left[\int_0^T |B_t^{i,N}|^2 dt \right] = 0.$$

Proof. By Lemma A.1, Hölder's inequality and Lemma 2.2, the estimate for $B^{i,N}$ holds.

Under the assumptions of Corollary 2.6 especially (2.16), Yamada-Watanabe result of mean field (F)BSDE [16, Lemma 3.2] implies that there exist measurable functions ϕ and ϕ_0 such that the solution to (2.5) admits the expression

$$\check{Z}_t^i = \phi(t, \alpha^i, x^i, \theta^i, W_{\cdot \wedge t}^i, W_{\cdot \wedge t}^0) \quad \text{and} \quad \check{Z}_t^{i0} = \phi_0(t, \alpha^i, x^i, \theta^i, W_{\cdot \wedge t}^i, W_{\cdot \wedge t}^0).$$

As a result,

$$\lim_{N \rightarrow \infty} \mathbb{E} \left[\int_0^T \left| -\frac{\theta^i}{N-1} \sum_{j \neq i} b_t^j \check{Z}_t^j + \theta^i \mathbb{E}[b_t^i \check{Z}_t^i | \mathcal{F}_t^0] \right|^2 dt \right] = 0. \quad (\text{A.1})$$

Indeed,

$$\begin{aligned} & \mathbb{E} \left[\int_0^T \left| -\frac{\theta^i}{N-1} \sum_{j \neq i} b_t^j \check{Z}_t^j + \theta^i \mathbb{E}[b_t^i \check{Z}_t^i | \mathcal{F}_t^0] \right|^2 dt \right] \\ & \leq \mathbb{E} \left[\int_0^T \left| \frac{1}{N-1} \sum_{j \neq i} b\phi(t, \alpha^j, x^j, \theta^j, W_{\cdot, \wedge t}^j, W_{\cdot, \wedge t}^0) - \mathbb{E}[b\phi(t, \alpha^i, x^i, \theta^i, W_{\cdot, \wedge t}^i, W_{\cdot, \wedge t}^0) | \mathcal{F}_t^0] \right|^2 dt \right] \\ & \leq \frac{1}{(N-1)^2} \sum_{j=1}^N \mathbb{E} \left[\int_0^T \left| b\phi(t, \alpha^j, x^j, \theta^j, W_{\cdot, \wedge t}^j, W_{\cdot, \wedge t}^0) - \mathbb{E}[b\phi(t, \alpha^i, x^i, \theta^i, W_{\cdot, \wedge t}^i, W_{\cdot, \wedge t}^0) | \mathcal{F}_t^0] \right|^2 dt \right] \\ & \quad + \frac{1}{(N-1)^2} \sum_{j \neq k} \mathbb{E} \left[\int_0^T \left| b\phi(t, \alpha^j, x^j, \theta^j, W_{\cdot, \wedge t}^j, W_{\cdot, \wedge t}^0) - \mathbb{E}[b\phi(t, \alpha^i, x^i, \theta^i, W_{\cdot, \wedge t}^i, W_{\cdot, \wedge t}^0) | \mathcal{F}_t^0] \right| \right. \\ & \quad \left. \times \left| b\phi(t, \alpha^k, x^k, \theta^k, W_{\cdot, \wedge t}^k, W_{\cdot, \wedge t}^0) - \mathbb{E}[b\phi(t, \alpha^i, x^i, \theta^i, W_{\cdot, \wedge t}^i, W_{\cdot, \wedge t}^0) | \mathcal{F}_t^0] \right| dt \right] \\ & = \frac{1}{(N-1)^2} \sum_{j=1}^N \mathbb{E} \left[\int_0^T \left| b\phi(t, \alpha^j, x^j, \theta^j, W_{\cdot, \wedge t}^j, W_{\cdot, \wedge t}^0) - \mathbb{E}[b\phi(t, \alpha^i, x^i, \theta^i, W_{\cdot, \wedge t}^i, W_{\cdot, \wedge t}^0) | \mathcal{F}_t^0] \right|^2 dt \right] \\ & \rightarrow 0. \end{aligned}$$

Now we verify the convergence of the fourth line in the definition of $B^{i,N}$. To do so, we divide it into several parts, that is,

For \mathcal{S}_1^N , it holds that

$$\mathcal{S}_1^N \leq \frac{1}{(N-1)^2} \mathbb{E} \left[\int_0^T \left(\frac{1}{N-1} \sum_{j \neq i} \theta^j b_t^{j0} \frac{\frac{1}{N-1} \sum_{k=1}^N \frac{\check{Z}_t^{k0}}{1 + \frac{\theta^k}{N-1}}}{1 - \sum_{k=1}^N \frac{\theta^k}{N-1 + \theta^k}} \right)^2 dt \right] \rightarrow 0.$$

For \mathcal{S}_2^N , it holds that

$$\mathcal{S}_2^N \leq \frac{1}{(N-1)^2} \mathbb{E} \left[\int_0^T \left(\frac{1}{N-1} \sum_{j \neq i} \theta^j b_t^{j0} \frac{\frac{1}{N-1} \sum_{k=1}^N \check{Z}_t^{k0}}{1 - \sum_{k=1}^N \frac{\theta^k}{N-1 + \theta^k}} \right)^2 dt \right].$$

For \mathcal{S}_4^N , it holds that

$$\begin{aligned} \mathcal{S}_4^N &\leq \mathbb{E} \left[\int_0^T \left(\frac{1}{1 - \mathbb{E}[\theta^i]} \frac{1}{N-1} \sum_{j \neq i} \theta^j b_t^{j0} \left(\frac{1}{N-1} \sum_{k=1}^N \check{Z}_t^{k0} - \mathbb{E}[\check{Z}_t^{i0} | \mathcal{F}_t^0] \right) \right)^2 dt \right] \\ &\quad + \mathbb{E} \left[\int_0^T \left(\frac{1}{1 - \mathbb{E}[\theta^i]} \left(\frac{1}{N-1} \sum_{j \neq i} \theta^j b_t^{j0} - \mathbb{E}[\theta^i b_t^{i0} | \mathcal{F}_t^0] \right) \mathbb{E}[\check{Z}_t^{i0} | \mathcal{F}_t^0] \right)^2 dt \right] \\ &\rightarrow 0, \end{aligned}$$

where the convergence of the first part is due to the uniform boundedness of $\theta^j b^{j0}$ and the same argument leading to (A.1), and the convergence of the second part is due to the uniform boundedness of $\theta^j b^{j0}$, the dominated convergence and law of large numbers.

For \mathcal{S}_3^N , it holds that

$$\begin{aligned} \mathcal{S}_3^N &\leq \mathbb{E} \left[\int_0^T \left(\frac{\frac{1}{N-1} \sum_{k=1}^N \frac{\theta^k}{1 + \frac{\theta^k}{N-1}} - \frac{1}{N-1} \sum_{k=1}^N \theta^k}{(1 - \mathbb{E}[\theta^i])(1 - \sum_{k=1}^N \frac{\theta^k}{N-1 + \theta^k})} \frac{1}{N-1} \sum_{j \neq i} \theta^j b_t^{j0} \frac{1}{N-1} \sum_{k=1}^N \check{Z}_t^{k0} \right)^2 dt \right] \\ &\quad + \mathbb{E} \left[\int_0^T \left(\frac{\frac{1}{N-1} \sum_{k=1}^N \theta^k - \mathbb{E}[\theta^i]}{(1 - \mathbb{E}[\theta^i])(1 - \sum_{k=1}^N \frac{\theta^k}{N-1 + \theta^k})} \frac{1}{N-1} \sum_{j \neq i} \theta^j b_t^{j0} \left(\frac{1}{N-1} \sum_{k=1}^N \check{Z}_t^{k0} - \mathbb{E}[\check{Z}_t^{i0} | \mathcal{F}_t^0] \right) \right)^2 dt \right] \\ &\quad + \mathbb{E} \left[\int_0^T \left(\frac{\frac{1}{N-1} \sum_{k=1}^N \theta^k - \mathbb{E}[\theta^i]}{(1 - \mathbb{E}[\theta^i])(1 - \sum_{k=1}^N \frac{\theta^k}{N-1 + \theta^k})} \frac{1}{N-1} \sum_{j \neq i} \theta^j b_t^{j0} \mathbb{E}[\check{Z}_t^{i0} | \mathcal{F}_t^0] \right)^2 dt \right] \\ &\rightarrow 0, \end{aligned}$$

where the convergence of the first part is due to the same reason as $\mathcal{S}_N^2 \rightarrow 0$, the convergence of the second part is due to the uniform boundedness of θ^i and b^{i0} as well as the same argument leading to (A.1), and the convergence of the third part is due to the same reason as $\mathcal{S}_4^N \rightarrow 0$.

Similarly, other terms in $B^{i,N}$ also converges to 0 in \mathbb{L}^2 . Thus, $B^{i,N}$ converges to 0 in \mathbb{L}^2 . \square

The following proposition is frequently used in the main text and we believe it is a standard result. However, it is difficult to locate the proof so we provide one for completeness.

Proposition A.3. *Let $\sqrt{|f|} \in \mathbb{H}_{BMO}^2$ and $\xi \in \mathbb{L}^\infty$. Then the following BSDE has a unique solution in $\mathbb{S}^\infty \times \mathbb{H}_{BMO}^2$*

$$dY_t = f_t dt + Z_t dW_t, \quad Y_T = \xi.$$

Proof. Consider the truncated BSDE

$$dY_t = f_t \wedge n dt + Z_t dW_t, \quad Y_T = \xi.$$

By the boundedness of $f \wedge n$, there exists a unique solution $(Y^n, Z^n) \in \mathbb{S}^2 \times \mathbb{L}^2$. Moreover, $Y_t^n = \mathbb{E} \left[\xi - \int_t^T f_s \wedge n ds \middle| \mathcal{F}_t \right]$, which implies

$$|Y_t^n| \leq \|\xi\| + \left\| \sqrt{|f|} \right\|_{BMO}^2 < \infty.$$

For each n and m , consider

$$d(Y_t^n - Y_t^m) = (f_t \wedge n - f_t \wedge m) dt + (Z_t^n - Z_t^m) dW_t, \quad Y_T^n - Y_T^m = 0.$$

Itô's formula implies

$$(Y_t^n - Y_t^m)^2 + \int_t^T (Z_s^n - Z_s^m)^2 ds \leq 2 \int_t^T |Y_s^n - Y_s^m| |f_s \wedge n - f_s \wedge m| ds + 2 \int_t^T (Y_s^n - Y_s^m)(Z_s^n - Z_s^m) dW_s,$$

where $\int_t^T (Y_s^n - Y_s^m)(Z_s^n - Z_s^m) dW_s$ is a true martingale. Taking expectations on both sides, we have

$$\begin{aligned} \mathbb{E}[(Y_t^n - Y_t^m)^2] + \mathbb{E} \left[\int_t^T (Z_s^n - Z_s^m)^2 ds \right] &\leq 2 \mathbb{E} \left[\int_0^T |Y_s^n - Y_s^m| |f_s \wedge n - f_s \wedge m| ds \right] \\ &\leq 2 \|Y^n - Y^m\|_\infty \mathbb{E} \left[\int_0^T |f_s \wedge n - f_s \wedge m| ds \right] \\ &\leq 4 \left(\|\xi\| + \left\| \sqrt{|f|} \right\|_{BMO}^2 \right) \mathbb{E} \left[\int_0^T |f_s \wedge n - f_s \wedge m| ds \right] \\ &\rightarrow 0, \quad \text{as } m, n \rightarrow \infty, \end{aligned}$$

where the convergence in the last line is by the estimate $|f \wedge n - f \wedge m| \leq 2|f|$, which is integrable, and by the dominated convergence. Moreover, by taking expectations and BDG inequality, it holds that

$$\mathbb{E} \left[\sup_{0 \leq t \leq T} |Y_t^n - Y_t^m| \right] \leq \mathbb{E} \left[\int_0^T |f_s \wedge n - f_s \wedge m| ds \right] + \mathbb{E} \left[\sup_{0 \leq t \leq T} \left| \int_t^T (Z_s^n - Z_s^m) dW_s \right| \right] \rightarrow 0.$$

As a result, $\{(Y^n, Z^n)\}_n$ is a Cauchy sequence in $\mathbb{S}^1 \times \mathbb{L}^2$. Let $(Y, Z) \in \mathbb{S}^1 \times \mathbb{L}^2$ be the limit and both Y and Z are adapted. Define Y^o by

$$Y_t^o = \xi - \int_t^T f_s ds - \int_t^T Z_s dW_s.$$

It remains to prove Y^o is adapted. The same argument as above yields

$$\mathbb{E} \left[\sup_{0 \leq t \leq T} |Y_t^n - Y_t^o| \right] \leq \mathbb{E} \left[\int_0^T |f_s - f_s \wedge n| ds \right] + \mathbb{E} \left[\sup_{0 \leq t \leq T} \left| \int_t^T (Z_s^n - Z_s) dW_s \right| \right] \rightarrow 0.$$

As a result, $Y^o = Y$, which is adapted. The dynamics implies $Y_t = \mathbb{E} \left[\xi - \int_t^T f_s ds \middle| \mathcal{F}_t \right] \in \mathbb{S}^\infty$. Itô's formula yields for each $\tau \in \mathcal{T}$

$$Y_\tau^2 + \int_\tau^T |Z_s|^2 ds \leq \xi^2 + 2 \int_\tau^T |Y_s f_s| ds - 2 \int_\tau^T Y_s Z_s dW_s.$$

Since $Y \in \mathbb{S}^\infty$ and $Z \in \mathbb{L}^2$, the above stochastic integral is a true martingale. By taking conditional expectations and supremum on both sides, we get

$$\|Z\|_{BMO}^2 \leq \|\xi\|^2 + 2\|Y\|_\infty \left\| \sqrt{|f|} \right\|_{BMO}^2 < \infty.$$

The uniqueness result is obvious. □
