Non-uniform continuity of the generalized Camassa-Holm equation in Besov spaces

Abstract: In this paper, we consider the Cauchy problem for the generalized Camassa-Holm equation proposed by Hakkaev and Kirchev (2005) [13]. We prove that the solution map of the generalized Camassa-Holm equation is not uniformly continuous on the initial data in Besov spaces. Our result include the present work (2020) [20, 21] on Camassa-Holm equation with Q = 1 and extends the previous non-uniform continuity in Sobolev spaces (2015) [23] to Besov spaces. In addition, the non-uniform continuity in critical space $B_{2,1}^{\frac{3}{2}}(\mathbb{R})$ is the first to be considered in our paper.

Keywords: Generalized Camassa-Holm equation, Non-uniform continuous dependence, Besov spaces

1 Introduction

In this paper, we are concerned with the Cauchy problem for the generalized Camassa-Holm equation introduced by Hakkaev and Kirchev [13]

$$\begin{cases} u_t - u_{xxt} + \frac{(Q+2)(Q+1)}{2} u^Q u_x = \left(\frac{Q}{2} u^{Q-1} u_x^2 + u^Q u_{xx}\right)_x, & t > 0, \ x \in \mathbb{R}, \\ u(0,x) = u_0, \ x \in \mathbb{R}, \end{cases}$$
(1.1)

where $Q \ge 1$ is a positive integer and u(t,x) stands for the fluid velocity at time $t \ge 0$ in the spatial direction.

Hakkafv and Kirchev [13] proved that the Cauchy problem for (1.1) is locally well-posed in Sobolev space $H^s(\mathbb{R})$ with $s > \frac{3}{2}$. The local well-posed in the sense of Hadamard in Besov space $B_{p,r}^s(\mathbb{R})$, $s > \max\{1 + \frac{1}{p}, \frac{3}{2}\}$, $1 \le p, r \le \infty$ or $B_{2,1}^{\frac{3}{2}}(\mathbb{R})$ were established in [22, 24, 25], respectively. Mi and Mu [23] showed that the Cauchy problem for (1.1) is locally well-posed in Sobolev space H^s with $s > \frac{3}{2}$ for both the periodic and the non-periodic case. In addition, they proved that the solution map is not uniformly continuous.

When Q = 1, Eq. (1.1) is reduced to the famous Camassa-Holm (CH) equation

$$u_t - u_{xxt} + 3uu_x = 2u_x u_{xx} + uu_{xxx}, (1.2)$$

which was first found by Fuchssteiner and Fokas [11] and later derived as a water wave model by Camassa and Holm [2]. The CH equation is completely integrable [2, 6], has bi-Hamiltonian structure [11, 3], possesses an infinity of conservation laws and admits exact peakon solutions of the form $ce^{-|x-ct|}$, describing an essential feature of the travelling waves of largest amplitude [2, 7, 8].

The local well-posedness and ill-posedness for the Cauchy problem of the CH equation (1.2) in Sobolev spaces and Besov spaces were studied in the series of papers [4, 5, 9, 12, 19]. After the non-uniform continuity for some dispersive equations was studied by Kenig et al. [17], non-uniform dependence of the CH equation has been studied by several authors. The first non-uniform dependence result for CH equation was established by Himonas and Misiołek [14] in H^s with $s \ge 2$ on the circle using explicitly constructed travelling wave solutions and this was then sharpened to $s > \frac{3}{2}$ in [15] on the line and [16] on the circle. The above mentioned works utilize the method of approximate solutions in conjunction with delicate commutator and multiplier estimates. Danchin[9, 10] showed the local existence and uniqueness of strong solutions to (1.2) with the initial data in $B_{p,r}^s$ for $s > \max\{1 + \frac{1}{p}, \frac{3}{2}\}$, $1 \le p \le \infty$, $1 \le r < \infty$. The continuous properties of the solutions on the initial data have been supplemented by Li and Yin in [19]. Very recently, Li, Yu and Zhu [20] have sharpened the results in [19] by showing that the solution map is not uniformly continuous, which depends deeply on the estimates of the transfer equation in Besov space and the constructed high-low frequency smooth initial data.

For studying the non-uniform continuity of the generalized Camassa-Holm equation, it is more convenient to express (1.1) in the following equivalent nonlocal form

$$\begin{cases}
 u_t + u^Q \partial_x u = -\partial_x (1 - \partial_x^2)^{-1} \left[\frac{Q^2 + 3Q}{2(Q+1)} u^{Q+1} + \frac{Q}{2} u^{Q-1} (\partial_x u)^2 \right] := \mathbf{P}(u), & (t, x) \in \mathbb{R}^+ \times \mathbb{R}, \\
 u(0, x) = u_0, & x \in \mathbb{R}.
\end{cases}$$
(1.3)

Up to the present, there is no result for the non-uniform continuous dependence of Eq. (1.3) in Besov space and it seems more difficult due to the fact that the structure of (1.3) when $Q \geq 2$ is much more complicated than that of the CH equation. On the one hand, when bounding the core part $u - u_0 + t(u_0)^Q \partial_x u_0$ by t^2 in the small time near t = 0, because of the high nonlinearity in convection term, the method developed for the CH equation in [20] will only aggravate this difficulty. To overcome this difficulty, we add a new term $t\mathbf{P}(u_0)$, and by using the differential mean value theorem, it is transformed into the estimates of nonlocal term $\mathbf{P}(u) - \mathbf{P}(u_0)$ and convective term $u^Q \partial_x u - (u_0)^Q \partial_x u_0$, which is valid for any bounded set in the above working Besov

space. Thus, for any bounded set u_0 in working space, the corresponding solution $\mathbf{S}_t(u_0)$ can be approximated by a function of first degree of time t with respect to initial data u_0 . That is,

$$\mathbf{S}_t(u_0) = u_0 - t(u_0)^Q \partial_x u_0 + t \mathbf{P}(u_0) + t^2 \mathcal{O}(u_0),$$

where $\mathcal{O}(u_0)$ is a bounded quantity of some Besov norm of u_0 . Therefore, the non-uniform continuity of $\mathbf{S}_t(u_0)$ is transformed into that of $u_0 - t(u_0)^Q \partial_x u_0 + t \mathbf{P}(u_0)$, which is the essence in our paper and is different from that in [20]. On the other hand, more precise product and multiplier estimates are necessary. In addition, the non-uniform continuity in critical space $B_{2,1}^{\frac{3}{2}}(\mathbb{R})$ is considered for the first time.

Our main result is stated as follows.

Theorem 1.1 Let $s > \max\{1 + \frac{1}{p}, \frac{3}{2}\}$, $1 \le p, r \le \infty$ or $(s, p, r) = (\frac{3}{2}, 2, 1)$. The solution map $u_0 \to \mathbf{S}_t(u_0)$ of the initial value problem (1.3) is not uniformly continuous from any bounded subset of $B_{p,r}^s(\mathbb{R})$ into $\mathcal{C}([0,T]; B_{p,r}^s(\mathbb{R}))$. More precisely, there exist two sequences g_n and f_n such that

$$||f_n||_{B_{p,r}^s} \lesssim 1,$$
 $\lim_{n \to \infty} ||g_n||_{B_{p,r}^s} = 0,$

but

$$\liminf_{n \to \infty} \|\mathbf{S}_t(f_n + g_n) - \mathbf{S}_t(f_n)\|_{B_{p,r}^s} \gtrsim t, \qquad t \in [0, T_0],$$

with small positive time T_0 for $T_0 \leq T$.

Remark 1.1 Our result include the present work [20, 21] on Camassa-Holm equation with Q = 1.

Remark 1.2 Since $B_{2,2}^s = H^s$, our result covers and extends the previous non-uniform continuity in Sobolev space [23] to Besov space.

Notations: Given a Banach space X, we denote the norm of a function on X by $|||_X$, and

$$\|\cdot\|_{L^{\infty}_{T}(X)} = \sup_{0 \le t \le T} \|\cdot\|_{X}.$$

The symbol $A \lesssim B$ means that there is a uniform positive constant C independent of A and B such that $A \leq CB$.

2 Littlewood-Paley analysis

In this section, we will review the definition of Littlewood-Paley decomposition and nonhomogeneous Besov space, and then list some useful properties. For more details, the readers can refer to [1].

There exists a couple of smooth functions (χ, φ) valued in [0, 1], such that χ is supported in the ball $\mathcal{B} \triangleq \{\xi \in \mathbb{R}^d : |\xi| \leq \frac{4}{3}\}$, φ is supported in the ring $\mathcal{C} \triangleq \{\xi \in \mathbb{R}^d : \frac{3}{4} \leq |\xi| \leq \frac{8}{3}\}$ and $\varphi \equiv 1$ for $\frac{4}{3} \leq |\xi| \leq \frac{3}{2}$. Moreover,

$$\forall \ \xi \in \mathbb{R}^d, \ \chi(\xi) + \sum_{j \ge 0} \varphi(2^{-j}\xi) = 1,$$

$$\forall \ \xi \in \mathbb{R}^d \setminus \{0\}, \ \sum_{j \in \mathbb{Z}} \varphi(2^{-j}\xi) = 1,$$
$$|j - j'| \ge 2 \Rightarrow \text{Supp } \varphi(2^{-j}\cdot) \cap \text{Supp } \varphi(2^{-j'}\cdot) = \emptyset,$$
$$j \ge 1 \Rightarrow \text{Supp } \chi(\cdot) \cap \text{Supp } \varphi(2^{-j}\cdot) = \emptyset.$$

Then, we can define the nonhomogeneous dyadic blocks Δ_j and nonhomogeneous low frequency cut-off operator S_j as follows:

$$\Delta_{j}u = 0, \quad if \quad j \leq -2, \quad \Delta_{-1}u = \chi(D)u = \mathcal{F}^{-1}(\chi \mathcal{F}u),$$

$$\Delta_{j}u = \varphi(2^{-j}D)u = \mathcal{F}^{-1}(\varphi(2^{-j}\cdot)\mathcal{F}u), \quad if \quad j \geq 0,$$

$$S_{j}u = \sum_{j'=-\infty}^{j-1} \Delta_{j'}u.$$

Definition 2.1 ([1]) Let $s \in \mathbb{R}$ and $1 \leq p, r \leq \infty$. The nonhomogeneous Besov space $B_{p,r}^s(\mathbb{R}^d)$ consists of all tempered distribution u such that

$$||u||_{B_{p,r}^s(\mathbb{R}^d)} \triangleq \left| \left| (2^{js}||\Delta_j u||_{L^p(\mathbb{R}^d)})_{j \in \mathbb{Z}} \right| \right|_{\ell^r(\mathbb{Z})} < \infty.$$

Then, we have the following product and multiplier estimates, which will play an important role in the estimates of nonlocal term $\mathbf{P}(u)$ and convective term $u^Q \partial_x u$.

Lemma 2.1 ([1]) (1) Algebraic properties: $\forall s > 0$, $B_{p,r}^s(\mathbb{R}^d) \cap L^{\infty}(\mathbb{R}^d)$ is a Banach algebra. $B_{p,r}^s(\mathbb{R}^d)$ is a Banach algebra $\Leftrightarrow B_{p,r}^s(\mathbb{R}^d) \hookrightarrow L^{\infty}(\mathbb{R}^d) \Leftrightarrow s > \frac{d}{p} \text{ or } s = \frac{d}{p}, \ r = 1.$

(2) For any s > 0 and $1 \le p, r \le \infty$, there exists a positive constant $\hat{C} = C(d, s, p, r)$ such that

$$||uv||_{B^{s}_{p,r}(\mathbb{R}^{d})} \le C\Big(||u||_{L^{\infty}(\mathbb{R}^{d})}||v||_{B^{s}_{p,r}(\mathbb{R}^{d})} + ||v||_{L^{\infty}(\mathbb{R}^{d})}||u||_{B^{s}_{p,r}(\mathbb{R}^{d})}\Big).$$

- (3) Let $m \in \mathbb{R}$ and f be an S^m multiplier (i.e., $f : \mathbb{R}^d \to \mathbb{R}$ is smooth and satisfies that $\forall \alpha \in \mathbb{N}^d$, there exists a constant \mathcal{C}_{α} such that $|\partial^{\alpha} f(\xi)| \leq \mathcal{C}_{\alpha} (1 + |\xi|)^{m-|\alpha|}$ for all $\xi \in \mathbb{R}^d$). Then the operator f(D) is continuous from $B_{p,r}^s$ to $B_{p,r}^{s-m}$.
- (4) Let $1 \le p, r \le \infty$ and $s > \max\{1 + \frac{1}{p}, \frac{3}{2}\}$. Then we have

$$||uv||_{B^{s-2}_{p,r}(\mathbb{R})} \le C||u||_{B^{s-2}_{p,r}(\mathbb{R})}||v||_{B^{s-1}_{p,r}(\mathbb{R})}.$$

Hence, for the terms P(u) and P(v), we have

$$\|\mathbf{P}(u) - \mathbf{P}(v)\|_{B_{p,r}^{s-1}(\mathbb{R})} \lesssim \|u - v\|_{B_{p,r}^{s-1}(\mathbb{R})} \|u, v\|_{B_{p,r}^{s-1}(\mathbb{R})}^{Q-1} \|u, v\|_{B_{p,r}^{s}(\mathbb{R})},$$

$$\|\mathbf{P}(u) - \mathbf{P}(v)\|_{B_{p,r}^{s}(\mathbb{R})} \lesssim \|u - v\|_{B_{p,r}^{s}(\mathbb{R})} \|u, v\|_{B_{p,r}^{s}(\mathbb{R})}^{Q},$$

$$\|\mathbf{P}(u)\|_{B_{p,r}^{s+1}(\mathbb{R})} \lesssim \|u\|_{B_{p,r}^{s+1}(\mathbb{R})} \|u\|_{B_{p,r}^{s}(\mathbb{R})}^{Q}.$$

Lemma 2.2 ([1, 18]) Let $1 \le p, r \le \infty$ and $\sigma > -\min\{\frac{1}{p}, 1 - \frac{1}{p}\}$. There exists a constant $C = C(p, r, \sigma)$ such that for any smooth solution to the following linear transport equation:

$$\partial_t f + v \partial_x f = g, \quad f|_{t=0} = f_0.$$

We have

$$\sup_{s \in [0,t]} \|f(s)\|_{B_{p,r}^{\sigma}(\mathbb{R})} \le Ce^{CV_p(v,t)} \Big(\|f_0\|_{B_{p,r}^{\sigma}(\mathbb{R})} + \int_0^t \|g(\tau)\|_{B_{p,r}^s(\mathbb{R})} d\tau \Big), \tag{2.4}$$

with

$$V_{p}(v,t) = \begin{cases} \int_{0}^{t} \|\nabla v(s)\|_{B_{p,\infty}^{\frac{1}{p}}(\mathbb{R}) \cap L^{\infty}(\mathbb{R})} ds, & \text{if } \sigma < 1 + \frac{1}{p}, \\ \int_{0}^{t} \|\nabla v(s)\|_{B_{p,r}^{\sigma}(\mathbb{R})} ds, & \text{if } \sigma = 1 + \frac{1}{p} \text{ and } r > 1, \\ \int_{0}^{t} \|\nabla v(s)\|_{B_{p,r}^{\sigma-1}(\mathbb{R})} ds, & \text{if } \sigma > 1 + \frac{1}{p} \text{ or } \{\sigma = 1 + \frac{1}{p} \text{ and } r = 1\}. \end{cases}$$

3 Non-uniform continuous dependence

In this section, we will give the proof of Theorem 1.1. Before proceeding further, we need to introduce several important propositions to show that the solution $\mathbf{S}_t(u_0)$ can be approximated by $u_0 - t(u_0)^Q \partial_x u_0 + t \mathbf{P}(u_0)$ in a small time near t = 0.

Firstly, we establish the estimates of the difference between the solution $S_t(u_0)$ and initial data u_0 in different Besov norms. That is

Proposition 3.1 Assume that $s > \max\{1 + \frac{1}{p}, \frac{3}{2}\}$ with $1 \le p, r \le \infty$ and $||u_0||_{B_{p,r}^s} \lesssim 1$. Then under the assumptions of Theorem 1.1, we have

$$||\mathbf{S}_{t}(u_{0}) - u_{0}||_{B_{p,r}^{s-1}} \lesssim t||u_{0}||_{B_{p,r}^{s-1}}^{Q}||u_{0}||_{B_{p,r}^{s}},$$

$$||\mathbf{S}_{t}(u_{0}) - u_{0}||_{B_{p,r}^{s}} \lesssim t(||u_{0}||_{B_{p,r}^{s}}^{Q+1} + ||u_{0}||_{B_{p,r}^{s-1}}^{Q}||u_{0}||_{B_{p,r}^{s+1}}),$$

$$||\mathbf{S}_{t}(u_{0}) - u_{0}||_{B_{p,r}^{s+1}} \lesssim t(||u_{0}||_{B_{p,r}^{s}}^{Q}||u_{0}||_{B_{p,r}^{s+1}} + ||u_{0}||_{B_{p,r}^{s-1}}^{Q}||u_{0}||_{B_{p,r}^{s+2}}).$$

Proof For simplicity, denote $u(t) = \mathbf{S}_t(u_0)$. Firstly, according to the local well-posedness result [22, 24, 25], there exists a positive time $T = T(||u_0||_{B_{p,r}^s}, s, p, r)$ such that the solution u(t) belongs to $\mathcal{C}([0,T]; B_{p,r}^s)$. Moreover, by Lemmas 2.1-2.2, for all $t \in [0,T]$ and $\gamma \geq s-1$, there holds

$$||u(t)||_{B_{p,r}^{\gamma}} \le C||u_0||_{B_{p,r}^{\gamma}}.$$
 (3.1)

Now we shall estimate the different Besov norms of the term $u(t) - u_0$, which can be bounded by t multiplying the corresponding Besov norms of initial data u_0 .

For $t \in [0,T]$, using (4) with v = 0 and product estimates (2) in Lemma 2.1, we have from

(3.1) that

$$||u(t) - u_{0}||_{B_{p,r}^{s}} \leq \int_{0}^{t} ||\partial_{\tau}u||_{B_{p,r}^{s}} d\tau$$

$$\leq \int_{0}^{t} ||\mathbf{P}(u)||_{B_{p,r}^{s}} d\tau + \int_{0}^{t} ||u^{Q}\partial_{x}u||_{B_{p,r}^{s}} d\tau$$

$$\lesssim t (||u||_{L_{t}^{\infty}(B_{p,r}^{s})}^{Q+1} + ||u||_{L_{t}^{\infty}(L^{\infty})}^{Q} ||u_{x}||_{L_{t}^{\infty}(B_{p,r}^{s})})$$

$$\lesssim t (||u||_{L_{t}^{\infty}(B_{p,r}^{s})}^{Q+1} + ||u||_{L_{t}^{\infty}(B_{p,r}^{s-1})}^{Q} ||u_{x}||_{L_{t}^{\infty}(B_{p,r}^{s})})$$

$$\lesssim t (||u_{0}||_{B_{p,r}^{s}}^{Q+1} + ||u_{0}||_{B_{p,r}^{s-1}}^{Q} ||u_{0}||_{B_{p,r}^{s+1}}),$$

where we have used that $B_{p,r}^{s-1}$ is an Banach algebra with $s-1 > \max\{\frac{1}{p}, \frac{1}{2}\}$ in the fourth inequality. Following the same procedure of estimates as above, we have

$$||u(t) - u_{0}||_{B_{p,r}^{s-1}} \leq \int_{0}^{t} ||\partial_{\tau}u||_{B_{p,r}^{s-1}} d\tau$$

$$\leq \int_{0}^{t} ||\mathbf{P}(u)||_{B_{p,r}^{s-1}} d\tau + \int_{0}^{t} ||u^{Q}\partial_{x}u||_{B_{p,r}^{s-1}} d\tau$$

$$\lesssim t||u||_{L_{t}^{\infty}(B_{p,r}^{s-1})}^{Q} ||u||_{L_{t}^{\infty}(B_{p,r}^{s})}$$

$$\lesssim t||u_{0}||_{B_{p,r}^{s-1}}^{Q} ||u_{0}||_{B_{p,r}^{s}},$$

and

$$||u(t) - u_{0}||_{B_{p,r}^{s+1}} \leq \int_{0}^{t} ||\partial_{\tau}u||_{B_{p,r}^{s+1}} d\tau$$

$$\leq \int_{0}^{t} ||\mathbf{P}(u)||_{B_{p,r}^{s+1}} d\tau + \int_{0}^{t} ||u^{Q}\partial_{x}u||_{B_{p,r}^{s+1}} d\tau$$

$$\lesssim t (||u||_{L_{t}^{\infty}(B_{p,r}^{s})}^{Q}||u||_{L_{t}^{\infty}(B_{p,r}^{s+1})} + ||u||_{L_{t}^{\infty}(B_{p,r}^{s-1})}^{Q}||u||_{L_{t}^{\infty}(B_{p,r}^{s+2})})$$

$$\lesssim t (||u_{0}||_{B_{p,r}^{s}}^{Q}||u_{0}||_{B_{p,r}^{s+1}} + ||u_{0}||_{B_{p,r}^{s-1}}^{Q}||u_{0}||_{B_{p,r}^{s+2}}),$$

where we have used $||u^Q||_{B^{s+1}_{p,r}} \lesssim ||u||_{B^{s-1}_{p,r}}^{Q-1} ||u||_{B^{s+1}_{p,r}}$, which can be proved by recurrence method in the third inequality. In fact, using product law (2) of Lemma 2.1, we have

$$\begin{split} \|u^Q\|_{B^{s+1}_{p,r}} & \lesssim & \|u\|_{L^\infty} \|u^{Q-1}\|_{B^{s+1}_{p,r}} + \|u\|_{B^{s+1}_{p,r}} \|u^{Q-1}\|_{L^\infty} \\ & \lesssim & \|u\|_{B^{s-1}_{p,r}} \|u^{Q-1}\|_{B^{s+1}_{p,r}} + \|u\|_{B^{s+1}_{p,r}} \|u\|_{B^{s-1}_{p,r}}^{Q-1} \\ & \lesssim & \|u\|_{B^{s-1}_{p,r}} (\|u\|_{B^{s-1}_{p,r}} \|u^{Q-2}\|_{B^{s+1}_{p,r}} + \|u\|_{B^{s+1}_{p,r}} \|u\|_{B^{s-1}_{p,r}}^{Q-2}) + \|u\|_{B^{s+1}_{p,r}} \|u\|_{B^{s-1}_{p,r}}^{Q-1} \\ & \lesssim & \|u\|_{B^{s-1}_{p,r}}^{2-1} \|u^{Q-2}\|_{B^{s+1}_{p,r}} + \|u\|_{B^{s+1}_{p,r}} \|u\|_{B^{s-1}_{p,r}}^{Q-1} \\ & \vdots \\ & \lesssim & \|u\|_{B^{s-1}_{p,r}}^{Q-1} \|u\|_{B^{s+1}_{p,r}}. \end{split}$$

Thus, we finish the proof of Proposition 3.1.

Since Proposition 3.1 fails for critical index $(s, p, r) = (\frac{3}{2}, 2, 1)$ due to the lack of the estimate of solutions in $B_{2,1}^{\frac{3}{3}}$, it needs special treatment. That is

Proposition 3.2 Assume that $(s, p, r) = (\frac{3}{2}, 2, 1)$ and $||u_0||_{B_{p,r}^s} \lesssim 1$. Under the assumptions of Theorem 1.1, we have

$$||\mathbf{S}_{t}(u_{0}) - u_{0}||_{L^{\infty}} \lesssim t||u_{0}||_{C^{0,1}}^{Q+1},$$

$$||\mathbf{S}_{t}(u_{0}) - u_{0}||_{B_{p,r}^{s}} \lesssim t(||u_{0}||_{B_{p,r}^{s}}^{Q+1} + [E(u_{0})]^{Q}||u_{0}||_{B_{p,r}^{s+1}}),$$

$$||\mathbf{S}_{t}(u_{0}) - u_{0}||_{B_{p,r}^{s+1}} \lesssim t(||u_{0}||_{B_{p,r}^{s}}^{Q}||u_{0}||_{B_{p,r}^{s+1}} + [E(u_{0})]^{Q}||u_{0}||_{B_{p,r}^{s+2}}),$$

where $E(u_0) = ||u_0||_{L^{\infty}} + ||u_0||_{C^{0,1}}^{Q+1}$.

Proof For simplicity, we denote $u(t) = \mathbf{S}_t(u_0)$. Moreover, by Lemmas 2.1-2.2, there holds for all $t \in [0, T]$ and $\gamma \geq \frac{3}{2}$ that

$$||u(t)||_{B_{2,1}^{\gamma}} \le C||u_0||_{B_{2,1}^{\gamma}}, \qquad ||u(t)||_{C^{0,1}} \le C||u_0||_{C^{0,1}}.$$
 (3.2)

It follows by differential mean value theorem and the Minkowski inequality that

$$||u(t) - u_0||_{L^{\infty}} \lesssim \int_0^t ||\partial_{\tau} u||_{L^{\infty}} d\tau$$

$$\lesssim \int_0^t ||\mathbf{P}(u)||_{L^{\infty}} d\tau + \int_0^t ||u^Q \partial_x u||_{L^{\infty}} d\tau$$

$$\lesssim t||u||_{L_t^{\infty}(C^{0,1})}^{Q+1}$$

$$\lesssim t||u_0||_{C^{0,1}}^{Q+1},$$

where we have used the fact that the operator $(1-\partial_x^2)^{-1}$ coincides with convolution by the function $x \to \frac{1}{2}e^{-|x|}$, and it can be proved by the Young inequality and Hölder inequality that

$$||\mathbf{P}(u)||_{L^{\infty}} \lesssim ||u||_{L^{\infty}_{t}(C^{0,1})}^{Q+1}.$$

Hence, we have

$$||u(t)||_{L^{\infty}} \lesssim E(u_0). \tag{3.3}$$

Using the multiplier and product estimates in Lemma 2.1, we obtain that

$$||u(t) - u_0||_{B_{2,1}^{\frac{3}{2}}} \leq \int_0^t ||\partial_\tau u||_{B_{2,1}^{\frac{3}{2}}} d\tau$$

$$\leq \int_0^t ||\mathbf{P}(u)||_{B_{2,1}^{\frac{3}{2}}} d\tau + \int_0^t ||u^Q \partial_x u||_{B_{2,1}^{\frac{3}{2}}} d\tau$$

$$\leq Ct (||u||_{L_t^{\infty}(B_{2,1}^{\frac{3}{2}})}^{Q+1} + ||u||_{L_t^{\infty}(L^{\infty})}^{Q} ||u_x||_{L_t^{\infty}(B_{2,1}^{\frac{3}{2}})}),$$

which along with (3.2)-(3.3) yield the second estimate. Similarly,

$$||u(t) - u_{0}||_{B_{2,1}^{\frac{5}{2}}} \leq \int_{0}^{t} ||\partial_{\tau}u||_{B_{2,1}^{\frac{5}{2}}} d\tau$$

$$\leq \int_{0}^{t} ||\mathbf{P}(u)||_{B_{2,1}^{\frac{5}{2}}} d\tau + \int_{0}^{t} ||u^{Q}\partial_{x}u||_{B_{2,1}^{\frac{5}{2}}} d\tau$$

$$\leq Ct(||u||_{L_{t}^{\infty}(B_{2,1}^{\frac{3}{2}})}^{Q} ||u||_{L_{t}^{\infty}(B_{2,1}^{\frac{5}{2}})}^{\frac{5}{2}} + ||u||_{L_{t}^{\infty}(L^{\infty})}^{Q} ||u||_{L_{t}^{\infty}(B_{2,1}^{\frac{7}{2}})}^{\frac{7}{2}})$$

$$\leq Ct(||u_{0}||_{B_{2,1}^{\frac{3}{2}}}^{Q} ||u_{0}||_{B_{2,1}^{\frac{5}{2}}}^{\frac{5}{2}} + |E(u_{0})|^{Q} ||u_{0}||_{B_{2,1}^{\frac{7}{2}}}),$$

which leads to the last inequality. Thus, we complete the proof of Proposition 3.2. \square

With the different norms estimates of $u - u_0$ at hand, we have the following core estimates, which implies that for any bounded initial data u_0 in $B_{p,r}^s$, the corresponding solution $\mathbf{S}_t(u_0)$ can be approximated by $u_0 - t(u_0)^Q \partial_x u_0 + t \mathbf{P}(u_0)$ near t = 0.

Proposition 3.3 Assume that $||u_0||_{B_{p,r}^s} \lesssim 1$. Then under the assumptions of Theorem 1.1, there holds

$$||\mathbf{S}_{t}(u_{0}) - u_{0} - t\mathbf{v}_{0}||_{B_{p,r}^{s}} \lesssim t^{2} (||u_{0}||_{B_{p,r}^{s}}^{Q+1} + ||u_{0}||_{B_{p,r}^{s-1}}^{Q} ||u_{0}||_{B_{p,r}^{s+1}} + ||u_{0}||_{B_{p,r}^{s-1}}^{2Q} ||u_{0}||_{B_{p,r}^{s+2}})$$

for $s > \max\{1 + \frac{1}{p}, \frac{3}{2}\}, \ 1 \le p, r \le \infty, \ or$

$$||\mathbf{S}_{t}(u_{0}) - u_{0} - t\mathbf{v}_{0}||_{B_{p,r}^{s}} \lesssim t^{2}(||u_{0}||_{B_{p,r}^{s}}^{Q+1} + [E(u_{0})]^{Q}||u_{0}||_{B_{p,r}^{s+1}} + [E(u_{0})]^{2Q}||u_{0}||_{B_{p,r}^{s+2}})$$

for
$$(s, p, r) = (\frac{3}{2}, 2, 1)$$
, here $\mathbf{v}_0 = -u_0^Q \partial_x u_0 + \mathbf{P}(u_0)$.

Proof It should be noticed that according to (3.1)-(3.2), $||u||_{B_{p,r}^s} \lesssim ||u_0||_{B_{p,r}^s} \lesssim 1$ which will be frequently used and be hidden later.

For $s > \max\{1 + \frac{1}{p}, \frac{3}{2}\}$, $1 \le p, r \le \infty$, using (4) and product estimates (2) in Lemma 2.1, we obtain from Propositions 3.1 that

$$\begin{aligned} ||u(t) - u_0 - t\mathbf{v}_0||_{B^s_{p,r}} &\leq \int_0^t ||\partial_\tau u - \mathbf{v}_0||_{B^s_{p,r}} d\tau \\ &\leq \int_0^t ||\mathbf{P}(u) - \mathbf{P}(u_0)||_{B^s_{p,r}} d\tau + \int_0^t ||u^Q \partial_x u - u_0^Q \partial_x u_0||_{B^s_{p,r}} d\tau \\ &\leq \int_0^t ||u(\tau) - u_0||_{B^s_{p,r}} d\tau + \int_0^t ||u(\tau) - u_0||_{B^{s-1}_{p,r}} ||u(\tau)||_{B^{s+1}_{p,r}} d\tau \\ &+ \int_0^t ||u(\tau) - u_0||_{B^{s+1}_{p,r}} ||u_0||_{B^{s-1}_{p,r}}^Q d\tau \\ &\leq Ct^2 (||u_0||_{B^s_{p,r}}^{Q+1} + ||u_0||_{B^{s-1}_{p,r}}^Q ||u_0||_{B^{s+1}_{p,r}} + ||u_0||_{B^{s-1}_{p,r}}^{Q} ||u_0||_{B^{s+2}_{p,r}}). \end{aligned}$$

Again using Lemma 2.1 and Propositions 3.2, for $(s, p, r) = (\frac{3}{2}, 2, 1)$, we arrive at

$$\begin{aligned} ||u(t) - u_0 - t\mathbf{v}_0||_{B_{2,1}^{\frac{3}{2}}} &\leq \int_0^t ||\partial_\tau u - \mathbf{v}_0||_{B_{2,1}^{\frac{3}{2}}} \, \mathrm{d}\tau \\ &\leq \int_0^t ||\mathbf{P}(u) - \mathbf{P}(u_0)||_{B_{2,1}^{\frac{3}{2}}} \, \mathrm{d}\tau + \int_0^t ||u^Q \partial_x u - u_0^Q \partial_x u_0||_{B_{2,1}^{\frac{3}{2}}} \, \mathrm{d}\tau \\ &\leq \int_0^t ||u(\tau) - u_0||_{B_{2,1}^{\frac{3}{2}}} \, \mathrm{d}\tau + \int_0^t ||u(\tau) - u_0||_{L^{\infty}} ||u_0, u(\tau)||_{L^{\infty}}^{Q-1} ||u(\tau)||_{B_{2,1}^{\frac{5}{2}}} \, \mathrm{d}\tau \\ &+ \int_0^t ||u(\tau) - u_0||_{B_{2,1}^{\frac{5}{2}}} ||u_0||_{L^{\infty}}^Q \, \mathrm{d}\tau \\ &\lesssim t^2 \left(||u_0||_{B_{s,r}^{s+1}}^{Q+1} + [E(u_0)]^Q ||u_0||_{B_{s,r}^{s+1}} + [E(u_0)]^{2Q} ||u_0||_{B_{s,r}^{s+2}} \right). \end{aligned}$$

Thus, we complete the proof of Proposition 3.3. \square

Now, we move on the proof of Theorem 1.1.

Proof of Theorem 1.1 Let $\hat{\phi} \in \mathcal{C}_0^{\infty}(\mathbb{R})$ be an even, real-valued and non-negative funtion on \mathbb{R} and satisfy

$$\hat{\phi}(x) = \begin{cases} 1, & \text{if } |x| \le \frac{1}{4}, \\ 0, & \text{if } |x| \ge \frac{1}{2}. \end{cases}$$

Define the high frequency function f_n and the low frequency function g_n by

$$f_n = 2^{-ns}\phi(x)\sin\left(\frac{17}{12}2^nx\right), \qquad g_n = \frac{12}{17}2^{-\frac{n}{Q}}\phi(x), \quad n \gg 1.$$

It has been showed in [20] that $||f_n||_{B^{\sigma}_{p,r}} \lesssim 2^{n(\sigma-s)}$.

Set $u_0^n = f_n + g_n$, consider Eq. (1.3) with initial data u_0^n and f_n , respectlively. Obviously, we have

$$||u_0^n - f_n||_{B_{p,r}^s} = ||g_n||_{B_{p,r}^s} \le C2^{-\frac{n}{Q}},$$

which means that

$$\lim_{n \to \infty} ||u_0^n - f_n||_{B_{p,r}^s} = 0.$$

For the case $s > \frac{3}{2}$, it is easy to show that $||u_0^n, f_n||_{B_{p,r}^{s-1}} \lesssim 2^{-\frac{n}{Q}}$ and

$$||u_0^n, f_n||_{B_{p,r}^{\sigma}} \le C2^{(\sigma-s)n}$$
 for $\sigma \ge s$,

which imply

$$\left(||u_0^n||_{B^{s,r}_{p,r}}^{Q+1} + ||u_0^n||_{B^{s-1}_{p,r}}^{Q} ||u_0^n||_{B^{s+1}_{p,r}} + ||u_0^n||_{B^{s-1}_{p,r}}^{2Q} ||u_0^n||_{B^{s+2}_{p,r}} \right) \lesssim 1,$$

$$\left(||f_n||_{B^{s,r}_{p,r}}^{Q+1} + ||f_n||_{B^{s-1}_{p,r}}^{Q} ||f_n||_{B^{s+1}_{p,r}} + ||f_n||_{B^{s-1}_{p,r}}^{2Q} ||f_n||_{B^{s+2}_{p,r}} \right) \lesssim 1,$$

For the case $s = \frac{3}{2}$, it is easy to show that $E(u_0^n) + E(f_n) \lesssim 2^{-\frac{n}{Q}}$ and

$$||u_0^n, f_n||_{B_{n,r}^{\sigma}} \le C2^{(\sigma-s)n}$$
 for $\sigma \ge s$,

which lead to

$$||u_0^n||_{B_{p,r}^{s}}^{Q+1} + [E(u_0^n)]^Q ||u_0^n||_{B_{p,r}^{s+1}} + [E(u_0^n)]^{2Q} ||u_0^n||_{B_{p,r}^{s+2}} \lesssim 1,$$

$$||f_n||_{B_{p,r}^{s}}^{Q+1} + [E(f_n)]^Q ||f_n||_{B_{p,r}^{s+1}} + [E(f_n)]^{2Q} ||f_n||_{B_{p,r}^{s+2}} \lesssim 1.$$

Furthermore, since u_0^n and f_n are both bounded in $B_{p,r}^s$, according to Proposition 3.3, we deduce that

$$||\mathbf{S}_{t}(u_{0}^{n}) - \mathbf{S}_{t}(f_{n})||_{B_{p,r}^{s}} \ge t ||(u_{0}^{n})^{Q} \partial_{x} u_{0}^{n} - (f_{n})^{Q} \partial_{x} f_{n} - \mathbf{P}(u_{0}^{n}) + \mathbf{P}(f_{n})||_{B_{p,r}^{s}} - ||g_{n}||_{B_{p,r}^{s}} - Ct^{2}$$

$$\ge t ||(u_{0}^{n})^{Q} \partial_{x} u_{0}^{n} - (f_{n})^{Q} \partial_{x} f_{n}||_{B_{p,r}^{s}} - C2^{-\frac{n}{Q}} - Ct^{2}.$$
(3.4)

Notice that

$$(u_0^n)^Q \partial_x u_0^n - (f_n)^Q \partial_x f_n = g_n^Q \partial_x f_n + (u_0^n)^Q \partial_x g_n + ((u_0^n)^Q - f_n^Q - g_n^Q) \partial_x f_n,$$

using Lemma 2.1, after simple calculation, we obtain

$$\begin{split} || \left((u_0^n)^Q - f_n^Q - g_n^Q \right) \partial_x f_n ||_{B_{p,r}^s} &\leq || \left((u_0^n)^Q - f_n^Q - g_n^Q \right) ||_{L^\infty} || f_n ||_{B_{p,r}^{s+1}} \\ &+ || \partial_x f_n ||_{L^\infty} || \left((u_0^n)^Q - f_n^Q - g_n^Q \right) ||_{B_{p,r}^s} \\ &\leq C 2^{-n(s-1)}, \\ &\left| \left| (u_0^n)^Q \partial_x g_n \right| \right|_{B_{p,r}^s} &\leq || u_0^n ||_{B_{p,r}^s}^Q || g_n ||_{B_{p,r}^{s+1}} \leq C 2^{-\frac{n}{Q}}, \end{split}$$

which together with fact

$$\liminf_{n \to \infty} ||g_n^Q \partial_x f_n||_{B_{p,\infty}^s} \ge M$$

for some positive M that has been showed in [20] yield

$$\liminf_{n\to\infty} ||\mathbf{S}_t(f_n+g_n) - \mathbf{S}_t(f_n)||_{B_{p,r}^s} \gtrsim t \quad \text{for } t \text{ small enough.}$$

This completes the proof of Theorem 1.1.
