Non-trivial t-intersecting families for symplectic polar spaces

Abstract

Let ${\mathscr P}$ be a symplectic polar space over a finite field ${\mathbb F}_q,$ and ${\mathscr P}_m$ denote the set of all m-dimensional subspaces in \mathscr{P} . We say a t-intersecting subfamily of \mathscr{P}_m is trivial if there exists a t-dimensional subspace contained in each member of this family. In this paper, we determine the structure of maximum sized non-trivial t-intersecting subfamilies of \mathscr{P}_m .

1 Introduction

Let n and k be two positive integers with $n \geq k$. For an n-element set X, denote the set of all k-subsets of X by $\binom{X}{k}$. Given a positive integer t, we say a family $\mathscr{F} \subset \binom{X}{k}$ is t-intersecting if $|A \cap B| \geq t$ for any $A, B \in \mathscr{F}$. A t-intersecting family is called trivial if every element of this family contains a fixed t -subset of X . The famous Erdős-Ko-Rado theorem $[6, 7, 20]$ $[6, 7, 20]$ $[6, 7, 20]$ $[6, 7, 20]$ states that a t-intersecting family with maximum size is trivial when $n > (t + 1)(k - t + 1)$. The structure of non-trivial t-intersecting families with maximum size was completely determined in 1996 $[1, 11]$ $[1, 11]$. Recently, some other maximal non-trivial t-intersecting families were described in [\[4,](#page-12-4) [10,](#page-12-5) [14\]](#page-12-6).

Let V be an *n*-dimensional vector space over the finite field \mathbb{F}_q , where q is a prime power, and $\begin{bmatrix} V_k \\ V_k \end{bmatrix}$ $\binom{V}{k}_q$ denote the family of all k-dimensional subspaces of V. We usually replace "k-dimensional subspace" with "k-subspace" for short. Let $\mathscr{F} \subset \begin{bmatrix} V_k \\ V_k \end{bmatrix}$ $\binom{V}{k}_q$ be a family with $\dim(F_1 \cap F_2) \geq t$ for any $F_1, F_2 \in \mathscr{F}$, which we say is *t*-intersecting. In particular, \mathscr{F} is called *trivial* if there exists a *t*-subspace contained in each element of \mathscr{F} . The Erdős-Ko-Rado Theorem for vector space [\[8,](#page-12-7) [13,](#page-12-8) [18\]](#page-13-1) shows that a *t*-intersecting subfamily of $\begin{bmatrix} V_k \\ V_l \end{bmatrix}$ $_{k}^V\big]_q$ with maximum size is trivial when $\dim V > 2k$. The structure of maximum sized non-trivial *t*-intersecting subfamily of $\begin{bmatrix} V_k \\ V_k \end{bmatrix}$ $\binom{V}{k}_q$ was determined via the parameter "t-covering number" [\[2,](#page-12-9) [5\]](#page-12-10).

Let f be a non-degenerate sesquilinear form defined on V. An m-subspace M of V is called totally isotropic if $f(x, y) = 0$ holds for any $x, y \in M$. Denote the set of all totally isotropic subspaces of V with respect to f by \mathscr{P} . Equipped with the inclusion relation, \mathscr{P} is a *classical polar space*, denoted by the same symbol $\mathscr P$. There are six kinds of classical polar spaces [\[12\]](#page-12-11). In this paper, we consider the case that $\mathscr P$ is a symplectic polar space, where $n = 2\nu$ and f is an alternating bilinear form.

For $0 \leq m \leq \nu$, denote the set of all m-subspaces in \mathscr{P} by \mathscr{P}_m . Let \mathscr{F} be a subfamily of \mathscr{P}_m . If $\dim(F_1 \cap F_2) \geq t$ for any $F_1, F_2 \in \mathscr{F}$, we say \mathscr{F} is *t*-intersecting. If there exists a fixed t-subspace contained in each member of \mathscr{F} , we say \mathscr{F} is trivial. The maximum sized t-intersecting subfamily of \mathscr{P}_m was proven to be trivial if $\nu \geq m$ for $t = 1$ [\[16,](#page-13-2) [17\]](#page-13-3), or $2\nu \geq 3m + 1$ with $(2\nu, q) \neq (3m + 1, 2)$ for $t \geq 2$ [\[15\]](#page-13-4).

For a subspace A of V, let $\mathcal{M}(m; A)$ denote the set of all members of \mathcal{P}_m contained in A. For $T \in \mathscr{P}_t$ and $U \in \mathscr{P}_m$ with $\dim(T \cap U) = m - 1$, write

$$
\mathscr{H}_1(T,U) = \{ F \in \mathscr{P}_m : T \subset F, \dim(F \cap U) \geq t \} \cup \mathscr{M}(m;T+U).
$$

For $Z \in \begin{bmatrix} V \\ t+2 \end{bmatrix}$, write

$$
\mathscr{H}_2(Z) = \{ F \in \mathscr{P}_m : \dim(F \cap Z) \geq t + 1 \}.
$$

Our main result states the structure of non-trivial *t*-intersecting subfamilies of \mathscr{P}_m with maximum size under certain conditions.

Thoerem 1.1. Let ν , m and t be integers such that $\nu \ge m + 1 = t + 2$, or $2\nu \ge \max\{3m + 1\}$ $2, 2m + 2t + 6$ with $m \geq t + 2$. Suppose $\mathscr F$ is a maximum sized non-trivial t-intersecting subfamily of \mathscr{P}_m . Then one of the following holds.

- (i) If $1 \leq t \leq \frac{m}{2} 1$, then $\mathscr{F} = \mathscr{H}_1(T, U)$ for some $T \in \mathscr{P}_t$ and $U \in \mathscr{P}_m$ with $T + U \in$ \mathscr{P}_{m+1} .
- (ii) If $\frac{m}{2} 1 < t \leq m 1$, then $\mathscr{F} = \mathscr{H}_2(Z)$ for some $Z \in \mathscr{P}_{t+2}$, or $\mathscr{F} = \mathscr{H}_1(T, U)$ for some $T \in \mathscr{P}_1$ and $U \in \mathscr{P}_3$ with $T + U \in \mathscr{P}_4$ if $(m, t) = (3, 1)$.

2 Inequalities for sizes of two t-intersecting families

In this section, we always auusme that $m \geq t+2$. We prove bounds for the families $\mathcal{H}_1(T, U)$ for $T \in \mathscr{P}_t$ and $U \in \mathscr{P}$ with $\dim(T \cap U) = t - 1$. Then we compare the size of $\mathscr{H}_1(T, U)$ with the size of $\mathscr{H}_2(Z)$ under the condition that $T + U \in \mathscr{P}_{m+1}$ and $Z \in \mathscr{P}_{t+2}$.

For positive integers a and b with $a \geq b$, define the *Gaussian binomial coefficient* by

$$
\begin{bmatrix} a \\ b \end{bmatrix}_q := \prod_{0 \leqslant i < b} \frac{q^{a-i}-1}{q^{b-i}-1},
$$

and set $\begin{bmatrix} a \\ 0 \end{bmatrix}$ $\binom{a}{0}_q = 1$. It is routine to check that the size of $\binom{V}{k}$ $\left[\begin{smallmatrix} V \\ k \end{smallmatrix}\right]_q$ is $\left[\begin{smallmatrix} n \\ k \end{smallmatrix}\right]$ $\binom{n}{k}_q$. From now on, we will omit the subscript q. We present some properties for the Gaussian binomial coefficient and the symplectic polar space, which will be used throughout our proof.

For positive integers m, i with $m > i$, we have

$$
q^{m-i} < \frac{q^m - 1}{q^i - 1} < q^{m-i+1}, \quad q^{i(m-i)} \leq \begin{bmatrix} m \\ i \end{bmatrix} < q^{i(m-i+1)}.\tag{1}
$$

For positives m_1, m with $m_1 \leqslant m \leqslant \nu$, let $N(\nu, m, m_1)$ be the number of members of \mathscr{P}_m containing a fixed member of \mathscr{P}_{m_1} . From [\[19,](#page-13-5) Theorem 3.38], we derive that

$$
N(\nu, m, m_1) = \prod_{i=1}^{m-m_1} \frac{q^{2(\nu - m + i)} - 1}{q^i - 1}.
$$
 (2)

For $1 \leq m \leq \nu - 1$, let Q be an m-subspace of V and $\alpha_1, \ldots, \alpha_m$ a basis of Q. Note that the rank of matrix $(f(\alpha_i, \alpha_j))_{m \times m}$ does not depend on the choose of the basis. It is routine to check that its rank is 2s for some non-negative integer s. Then we say Q has type (m, s) . Note that Q has type $(m, 0)$ if and only if Q is totally isotropic. By [\[19,](#page-13-5) Theorem 3.27], the number of members of \mathscr{P}_m contained in a fixed $(m+1,1)$ -type subspace is $q+1$.

For $\mathscr{F} \subset \mathscr{P}_m$ and a subspace A of V, let \mathscr{F}_A denote the set of members of \mathscr{F} containing A. Write

$$
f_0(\nu, m, t) = \begin{bmatrix} m-t+1 \\ 1 \end{bmatrix} N(\nu, m, t+1) - q \begin{bmatrix} m-t+1 \\ 2 \end{bmatrix} N(\nu, m, t+2).
$$

Lemma 2.1. Let ν, m, t be positive integers with $m \geq t+2$ and $2\nu \geq 3m-t+3$. Suppose $T \in \mathscr{P}_t$ and $U \in \mathscr{P}_m$ with $\dim(T \cap U) = t - 1$. Then the following hold.

- (i) If $T + U \in \mathscr{P}_{m+1}$, then $|\mathscr{H}_1(T, U)| > f_0(\nu, m, t)$.
- (ii) If $T + U \notin \mathscr{P}_{m+1}$, then $|\mathscr{H}_1(T, U)| < f_0(\nu, m, t)$.

Proof. Observe that $\dim(T+U) = m+1$.

(i) Write all $(t + 1)$ -subspaces of $T + U$ containing T as $W_1, \ldots, W_{\lfloor m-t+1 \rfloor}$. For each $i = 1, \ldots, \lceil \frac{m-t+1}{1} \rceil$ ^{t+1}], let \mathcal{W}_i denote the set of all *m*-subspaces in \mathcal{P} containing W_i . For $F \in \mathcal{P}_m$ with $T \subset F$, if $\dim(F \cap (T+U)) = l \geq t+1$, it appears $\begin{bmatrix} l-t \\ 1 \end{bmatrix}$ $\mathbb{Z}_1^{\{-t\}}$ times in $\mathscr{W}_1, \ldots, \mathscr{W}_{\left[\begin{smallmatrix} m-t+1 \end{smallmatrix}\right]}.$ For each $i = 1, 2, \ldots, m - t$, write $\mathscr{E}_i = \{F \in \mathscr{P}_m : T \subset F$, $\dim(F \cap (T + U)) = t + i\}$. Then we have

$$
\begin{bmatrix} m-t+1 \ 1 \end{bmatrix} N(\nu, m, t+1) = \sum_{i=1}^{\begin{bmatrix} m-t+1 \end{bmatrix}} |\mathscr{W}_i| = \sum_{i=1}^{m-t} \begin{bmatrix} i \\ 1 \end{bmatrix} |\mathscr{E}_i|.
$$

Similarly, we have

$$
q\genfrac{[}{]}{0pt}{}{m-t+1}{2}N(\nu,m,t+2)=\sum_{i=2}^{m-t}q\genfrac{[}{]}{0pt}{}{i}{2}|\mathscr{E}_{i}|.
$$

From $\begin{bmatrix} i \\ 1 \end{bmatrix}$ $\begin{bmatrix} i \\ 1 \end{bmatrix}$ < $q \begin{bmatrix} i \\ 2 \end{bmatrix}$ $i \geq 3$, we obtain

$$
f_0(\nu, m, t) \leq |\{F \in \mathcal{P}_m : T \subset F, \ t+1 \leq \dim(F \cap (T+U)) \leq t+2\}|. \tag{3}
$$

Then (i) follows from [\(3\)](#page-2-0) and the definition of $\mathcal{H}_1(T, U)$.

(ii) Since $T \in \mathscr{P}_t$, $U \in \mathscr{P}_m$ and $T + U \notin \mathscr{P}_{m+1}$, there exist $\alpha \in T \setminus U$ and $\gamma \in U \setminus T$ such that $f(\alpha, \gamma) \neq 0$. Therefore,

$$
|\{S \in \mathcal{M}(t+1;T+U) : T \subset S\}| \leqslant \left| \left\{ S \in \binom{T+U}{t+1} : T \subset S \right\} \setminus \left\{ \langle T, \gamma \rangle \right\} \right| = \binom{m-t+1}{1} - 1.
$$

Notice that

$$
\{F \in \mathscr{P}_m : T \subset F, \dim(F \cap (T + U)) \geq t + 1\} \subset \bigcup_{S \in \mathscr{M}(t+1;T+U), T \subset S} (\mathscr{H}_1(T, U))_S
$$

and $T + U$ has type $(m + 1, 1)$. Then we have

$$
|\mathcal{H}_1(T,U)| \leqslant \left(\begin{bmatrix} m-t+1 \\ 1 \end{bmatrix} - 1 \right) N(\nu, m, t+1) + (q+1).
$$

By (1) , we get

$$
\frac{|\mathcal{H}_1(T, U)| - f_0(\nu, m, t)}{N(\nu, m, t + 2)} \leqslant -\frac{q^{2(\nu - t - 1)} - 1}{q^{m - t - 1} - 1} + q \binom{m - t + 1}{2} + \frac{q + 1}{N(\nu, m, t + 2)}
$$

$$
< -q^{2\nu - m - t - 1} + q^{2(m - t) + 1} + q + 1
$$

< 0,

as desired. \Box

Let $T \in \mathscr{P}_t$, $U \in \mathscr{P}_m$ with $T + U \in \mathscr{P}_{m+1}$, and $Z \in \mathscr{P}_{t+2}$. From [\[19,](#page-13-5) Lemma 3.11], we derive that $|\mathcal{H}_1(T, U)|$ and $|\mathcal{H}_2(Z)|$ do not depend on the choice of T, U and Z. Write

$$
h_1(\nu,m,t) = |\mathcal{H}_1(T,U)|, \quad h_2(\nu,m,t) = |\mathcal{H}_2(Z)|.
$$

Notice that

$$
h_2(\nu, m, t) = \binom{t+2}{1} N(\nu, m, t+1) - q \binom{t+1}{1} N(\nu, m, t+2).
$$

Lemma 2.2. Let ν , m and t be positive integers with $m \geq t+2$ and $2\nu \geq 3m+1$. Then the following hold.

- (i) If $1 \leqslant t \leqslant \frac{m}{2}$ $\frac{n}{2} - 1$, then $h_2(\nu, m, t) < h_1(\nu, m, t)$.
- (ii) If $\frac{m}{2} 1 < t \leqslant m 2$, then $h_2(\nu, m, t) \geqslant h_1(\nu, m, t)$ and equality holds if and only if $(m, t) = (3, 1).$

Proof. (i) By (1) , (2) and Lemma [2.1,](#page-2-3) we have

$$
\begin{aligned} &\frac{h_1(\nu,m,t)-h_2(\nu,m,t)}{N(\nu,m,t+2)}\\ > & \left(\begin{bmatrix} m-t+1 \\ 1 \end{bmatrix} - \begin{bmatrix} t+2 \\ 1 \end{bmatrix} \right) \frac{q^{2(\nu-t-1)}-1}{q^{m-t-1}-1} - q \left(\begin{bmatrix} m-t+1 \\ 2 \end{bmatrix} - \begin{bmatrix} t+1 \\ 1 \end{bmatrix} \right)\\ > & q^{t+2} \cdot q^{m-2t-2} \cdot q^{2\nu-t-m-1} - q^{2(m-t)+1} \\ > & 0. \end{aligned}
$$

Hence $h_1(\nu, m, t) > h_2(\nu, m, t)$.

(ii) Let $U \in \mathscr{P}_m$, $T \in \mathscr{P}_t$ with $T + U \in \mathscr{P}_{m+1}$. Suppose $\frac{m}{2} - 1 < t \leq m - 3$ and $\mathscr{F} = \mathscr{H}_1(T, U)$. Write

$$
\mathscr{A}_j=\{F\in\mathscr{P}_m: T\subset F,\ \dim(F\cap(T+U))=j\}
$$

for each $t + 1 \leqslant j \leqslant m$, and

$$
\mathscr{L} = \{ (I, F) \in \mathscr{P}_{t+1} \times \mathscr{P}_m : T \subset I \subset T + U, I \subset F \}.
$$

Let $\mathscr{B} = \bigcup^{m}$ $j=t+1$ \mathscr{A}_j . We have

$$
|\mathscr{F} \setminus \mathscr{B}| = |\{F \in \mathscr{M}(m; T + U) : T \not\subset F\}| = q^{m-t+1} \begin{bmatrix} t \\ 1 \end{bmatrix}.
$$

By double counting $|\mathscr{L}|$, we have

$$
\begin{bmatrix} m-t+1 \ 1 \end{bmatrix} N(\nu,m,t+1) = |\mathcal{L}| = \sum_{j=t+1}^m |\mathcal{A}_j| \cdot \begin{bmatrix} j-t \ 1 \end{bmatrix} = |\mathcal{B}| + \sum_{j=t+2}^m q \begin{bmatrix} j-t-1 \ 1 \end{bmatrix} |\mathcal{A}_j|.
$$

Since $m \geq t + 3$, by [\[9,](#page-12-12) Theorem 2.10], we have

$$
|\mathscr{A}_{m-1}| = \begin{bmatrix} m-t+1 \\ 2 \end{bmatrix} \left((q^{\nu-m+1} + q^2) \begin{bmatrix} \nu-m-1 \\ 1 \end{bmatrix} + q^{2(\nu-m)} \begin{bmatrix} 2 \\ 1 \end{bmatrix} \right).
$$

Then by (1) , we get

$$
\frac{|\mathscr{A}_{m-1}|}{|\mathscr{F}\setminus \mathscr{B}|} > \frac{q^{2(m-t-1)}\cdot q^{2(\nu-m)-1}}{q^{m-t+1}\cdot q^t} \geqslant q^{3m-2t-2}\cdot q^{-(m+1)}>1.
$$

Observe that $\mathscr{F} = (\mathscr{F} \setminus \mathscr{B}) \cup \mathscr{B}$. It is routine to check that

$$
h_1(\nu,m,t)=|\mathscr{F}|=|\mathscr{B}|+|\mathscr{F}\setminus\mathscr{B}|<|\mathscr{L}|-(q-1)|\mathscr{A}_{t+2}|.
$$

If $2t > m - 1$, since $2\nu \geq 3m + 1$, by [\(1\)](#page-2-1), [\(2\)](#page-2-2) and Lemma [2.1,](#page-2-3) we obtain

$$
\frac{h_2(\nu, m, t) - h_1(\nu, m, t)}{N(\nu, m, t + 2)} > \left(\begin{bmatrix} t + 2 \\ 1 \end{bmatrix} - \begin{bmatrix} m - t + 1 \\ 1 \end{bmatrix} \right) \frac{q^{2(\nu - t - 1)} - 1}{q^{m - t - 1} - 1} - q \begin{bmatrix} t + 1 \\ 1 \end{bmatrix}
$$

\n
$$
\geq q^{m - t + 1} \cdot q^{2t - m} \cdot q^{2\nu - m - t - 1} - q^{t + 2}
$$

\n
$$
> 0.
$$

If $2t = m - 1$, from (1) , (2) , $2\nu \ge 3m + 2$, $t \ge 2$ and $[9$, Theorem 2.10, we obtain

$$
h_2(\nu, m, t) - h_1(\nu, m, t)
$$

> $(q-1)|\mathcal{A}_{t+2}| - q\begin{bmatrix} t+1\\1 \end{bmatrix} N(\nu, m, t+2)$
> $(q-1)\begin{bmatrix} t+2\\2 \end{bmatrix} \cdot q^{\frac{t(t-1)}{2} + 2(t-1)(\nu - 2t - 2) + 2(t-1)} - q^t \begin{bmatrix} t+1\\1 \end{bmatrix} q^{2(t-1)(\nu - 2t - 2) + \frac{t(t-1)}{2} + 2(t-1)}$
>0.

Hence $h_1(\nu, m, t) < h_2(\nu, m, t)$.

Now suppose $m = t + 2$. Let $M \in \mathcal{M}(t + 2; T + U)$ containing T. Write

$$
\mathscr{B}_0 = \{ F \in \mathscr{M}(t+2; T+U) : T \not\subset F \},
$$

\n
$$
\mathscr{B}_1 = \{ F \in \mathscr{P}_{t+2} : T \not\subset F, \dim(F \cap M) = t+1 \},
$$

\n
$$
\mathscr{B}_2 = \{ F \in \mathscr{P}_{t+2} : T \subset F, \dim(F \cap M) \geq t+1 \},
$$

\n
$$
\mathscr{B}_3 = \{ F \in \mathscr{P}_{t+2} : F \cap M = T, \dim(F \cap (T+U)) = t+1 \}.
$$

Observe that $|\mathscr{B}_0| = \begin{bmatrix} t+3 \\ 1 \end{bmatrix}$ $\begin{bmatrix} +3 \\ 1 \end{bmatrix} - \begin{bmatrix} 3 \\ 1 \end{bmatrix}$ $\binom{3}{1} = q^3 \binom{t}{1}$ $_{1}^{t}$]. By [\[9,](#page-12-12) Theorem 2.10], we have

$$
|\mathcal{B}_1| = \left((q^{\nu - t + 1} + q^3) \begin{bmatrix} \nu - t - 2 \\ 1 \end{bmatrix} + q^{2(\nu - t) - 1} \right) \begin{bmatrix} t \\ 1 \end{bmatrix},
$$

$$
|\mathcal{B}_3| = (q^{\nu - t + 1} + q^4) \begin{bmatrix} \nu - t - 3 \\ 1 \end{bmatrix} + q^{2(\nu - t - 1)} \begin{bmatrix} 2 \\ 1 \end{bmatrix}.
$$

Notice that $\mathscr{H}_1(T,U) = \mathscr{B}_0 \cup \mathscr{B}_2 \cup \mathscr{B}_3$, $\mathscr{H}_2(M) = \mathscr{B}_1 \cup \mathscr{B}_2$, which imply that $h_2(\nu,m,t)$ – $h_1(\nu, m, t) = |\mathscr{B}_1| - |\mathscr{B}_0| - |\mathscr{B}_3|$. When $t = 1$, it is routine to chech that $h_2(\nu, 3, 1)$ – $h_1(\nu, 3, 1) = 0$. If $t \ge 2$, from $2\nu \ge 3m + 1 = 3t + 7$ and [\(1\)](#page-2-1), we have

$$
h_2(\nu, t+2, t) - h_1(\nu, t+2, t)
$$

\n
$$
\geq ((q^{\nu-t+1} + q^3)q^{\nu-t-3} + q^{2(\nu-t)-1}) q^{t-1} - ((q^{\nu-t+1} + q^4)q^{\nu-t-3} + q^{2(\nu-t)}) - q^{t+3}
$$

\n
$$
\geq q^{2\nu-2t-2} - q^{t+3}
$$

\n
$$
>0,
$$

as desired. \Box

3 Proof of Theorem [1.1](#page-1-0)

Suppose $\mathscr{F} \subset \mathscr{P}_m$ is a maximum sized non-trivial t-intersecting family. When $m = t+1$ with $\nu \geq m+1$, by [\[3,](#page-12-13) Remarks (ii) in Section 9.3], there exists $Z \in \begin{bmatrix} V \\ t+1 \end{bmatrix}$ such that $\mathscr{F} \subset \begin{bmatrix} Z \\ t+1 \end{bmatrix}$. Observe that $Z \in \mathscr{P}_{t+2}$ or Z has type $(t+2,1)$. Then it is routine to check that $\mathscr{F} = \mathscr{H}_2(Z)$ where $Z \in \mathscr{P}_{t+2}$. To finish the proof of Theorem [1.1,](#page-1-0) in view of Lemmas [2.1](#page-2-3) and [2.2,](#page-3-0) it is sufficient to show that $|\mathscr{F}| < f_0(\nu, m, t)$ if $m \geq t+2$ with $2\nu \geq \max\{3m+2, 2m+2t+6\}$ and $\mathscr F$ is not one of the expected families in Theorem [1.1.](#page-1-0) We first prove the following lemma.

Lemma 3.1. Let $A \in \mathcal{M}(a, 0; 2\nu)$ with $a \leq m-1$, and $\mathcal{Y} \subset \mathcal{P}_m$ be a t-intersecting family. Suppose that there exists $Y \in \mathscr{Y}$ such that $\dim(A \cap Y) = r \leq t - 1$. Then there exists $R \in \mathscr{P}_{a+t-r}$ with $A \subset R$ such that

$$
|\mathscr{Y}_A| \leqslant \begin{bmatrix} m-r \\ t-r \end{bmatrix} |\mathscr{Y}_R|.
$$

Proof. W.l.o.g., assume that $\mathscr{Y}_A \neq \emptyset$. Write

$$
\mathcal{H} = \{ H \in \mathcal{M} (a + t - r, 0; A + Y) : A \subset H \}.
$$

Since $\mathscr Y$ is t-intersecting, for each $G \in \mathscr Y_A$, we have $\dim(G \cap Y) \geq t$, which implies that $\dim(G \cap (A + Y)) \geq a + t - r$. Consequently, $\mathscr{H} \neq \emptyset$. Then there exists $R \in \mathscr{H}$ such that $|\mathscr{Y}_B| \leq |\mathscr{Y}_R|$ for any $B \in \mathscr{H}$. Observe that

$$
|\mathscr{H}| \leqslant \begin{bmatrix} m-r \\ t-r \end{bmatrix}, \quad \mathscr{Y}_A \subset \bigcup_{B \in \mathscr{H}} \mathscr{Y}_B.
$$

Then the desired result holds. \Box

For $S \in \mathscr{P}_s$, we say S is a t-cover of \mathscr{F} if $\dim(S \cap F) \geq t$ for any $F \in \mathscr{F}$. Write

 $\tau_t(\mathscr{F}) := \min\{\dim S : S \text{ is a } t\text{-cover of } \mathscr{F}\}.$

Since $\mathscr F$ is non-trivial and each member of $\mathscr F$ is a t-cover of $\mathscr F$, we have $t+1 \leq \tau_t(\mathscr F) \leq$ m. Notice that each member of \mathscr{P}_m containing S is also a member of $\mathscr F$ because of the maximality of \mathscr{F} . The proof in the following is divided into two cases.

3.1 The case $\tau_t(\mathscr{F}) = t + 1$

Assumption 1. Let ν, m, t be positive integers with $2\nu \ge \max\{3m + 2, 2m + 2t + 6\}$ and $m \geq t + 2$. Suppose $\mathscr F$ is a maximum sized non-trivial t-intersecting subfamily of $\mathscr P_m$ with $\tau_t(\mathscr{F}) = t + 1$ and \mathscr{S} is the set of all t-cover of \mathscr{F} with dimension $t + 1$. Set $X = \sum$ S∈S S.

Lemma 3.2. Let $\nu, m, t, \mathcal{F}, \mathcal{S}$ and X be as in Assumption 1. Then \mathcal{S} is a t-intersecting family with $t \leq \tau_t(\mathscr{S}) \leq t+1$. Moreover, if $\tau_t(\mathscr{S}) = t$, then $t+1 \leq \dim X \leq m+1$ and $\dim(F \cap X) = \dim X - 1$ for any $F \in \mathscr{F} \setminus \mathscr{F}_T$, where $T \in \mathscr{P}_t$ is contained in each member of $\mathscr S$.

Proof. Suppose for contradiction that there exist $S_1, S_2 \in \mathscr{S}$ such that $\dim(S_1 \cap S_2) < t$. By [\(2\)](#page-2-2), the number of $A \in \mathscr{P}_{t+2}$ containing S_2 is $N(\nu, t+2, t+1) = \begin{bmatrix} 2(\nu - t - 1) \\ 1 \end{bmatrix}$ $\binom{t-1}{1}$. Observe that the number of members of $\mathcal{M}(t+2; S_1 + S_2)$ containing S_2 is at most $\begin{bmatrix} t+1 \\ 1 \end{bmatrix}$ $\binom{+1}{1}$. Since $2\nu > 3(t+1)$, we have $\left[\begin{matrix}2(\nu-t-1)\\1\end{matrix}\right]$ $\binom{t-1}{1} > \binom{t+1}{1}$ $\begin{bmatrix} +1 \\ 1 \end{bmatrix}$. Then

$$
\{A\in \mathscr{P}_{t+2}: S_2\subset A\not\subset S_1+S_2\}=\!\{A\in \mathscr{P}_{t+2}: S_2\subset A\}\setminus \{A\in \mathscr{P}_{t+2}: A\subset S_1+S_2\}\neq \emptyset.
$$

For $S'_2 \in \mathscr{P}_{t+2}$ with $S_2 \subset S'_2 \not\subset S_1 + S_2$, it is routine to check that $S'_2 \cap S_1 = S_2 \cap S_1$. Repeating this discussion several times, we obtain $U_1, U_2 \in \mathscr{P}_m$ containing S_1 and S_2 , respectively, satisfying that $U_1 \cap U_2 = S_1 \cap S_2$. By the maximality of \mathscr{F} , we have $U_1, U_2 \in \mathscr{F}$, a contradiction to the fact that $\mathscr F$ is t-intersecting, as desired. From $\mathscr S$ is t-intersecting, we get $t \leqslant \tau_t(\mathscr{S}) \leqslant t + 1$.

Suppose $\tau_t(\mathscr{S}) = t$ and T is a member of \mathscr{P}_t contained in each member of \mathscr{S} . For each $F \in \mathscr{F} \setminus \mathscr{F}_T$ and $S \in \mathscr{S}$, observe that $\dim(S \cap F) = t$. Then

$$
m + 1 \leq \dim(T + F) \leq \dim(S + F) = m + 1.
$$

Note that $T + F \subset S + F$. We get $S + F = T + F$, which implies that $T + F = X + F$. From $\dim(T + F) = m + 1$, we get $\dim(F \cap X) = \dim X - 1$ and $\dim X \leq m + 1$. Together with $\dim X \geqslant \dim S = t + 1$, the desired result holds. \square

Proposition 3.3. Let $\nu, m, t, \mathscr{F}, \mathscr{S}$ and X be as in Assumption 1. If $\tau_t(\mathscr{S}) = t$ and dim X = $m + 1$, then $\mathscr{F} = \mathscr{H}_1(T, U)$ for some $T \in \mathscr{P}_t$ and $U \in \mathscr{P}_m$ with $T + U \in \mathscr{P}_{m+1}$.

Proof. Suppose $T \in \mathscr{P}_t$ is contained in each member of \mathscr{S} . For each $U \in \mathscr{F} \setminus \mathscr{F}_T$, by Lemma [3.2,](#page-6-0) we have dim $(U \cap X) = m$ and $X = T + U$, which imply that

$$
\mathscr{F}\setminus \mathscr{F}_T\subset \{F\in \mathscr{M}(m;T+U): T\not\subset F\}.
$$

For each $G \in \mathscr{F}_T$, since $\dim(U \cap G) \geq t$ and $\dim(T \cap U) = t-1$, we have $\dim(G \cap (T+U)) \geq$ $t + 1$, which implies that

$$
\mathscr{F}_T \subset \{ F \in \mathscr{P}_m : T \subset F, \dim(F \cap (T+U)) \geq t+1 \}.
$$

Thus $\mathscr{F} \subset \mathscr{H}_1(T, U)$. Observe that $\mathscr{H}_1(T, H)$ is non-trivially t-intersecting. By the maximality of \mathscr{F} , we have $\mathscr{F} = \mathscr{H}_1(T, U)$.

If $X \notin \mathscr{P}_{m+1}$, by Lemma [2.1,](#page-2-3) we have $|\mathscr{F}| < h_1(\nu,m,t)$. Note \mathscr{F} is maximum sized. Then we get $T + U \in \mathscr{P}_{m+1}$.

Proposition 3.4. Let $\nu, m, t, \mathscr{F}, \mathscr{S}$ and X be as in Assumption 1. If $\tau_t(\mathscr{S}) = t$ and $t+1 \leq$ $\dim X \leq m$, then $|\mathscr{F}| < f_0(\nu, m, t)$.

Proof. We investigate $\mathscr F$ in two cases.

Case 1. dim $X = t + 1$.

In this case, we have $|\mathscr{S}| = 1$. Let S be the unique member of S. Observe that

$$
\mathcal{F} = \mathcal{F}_S \cup \left(\bigcup_{R \in \mathcal{M}(t,S)} \mathcal{F}_R \setminus \mathcal{F}_S \right). \tag{4}
$$

For each $R \in \mathcal{M}(t; S)$, since $\tau_t(\mathcal{F}) = t + 1$, there exists $F \in \mathcal{F} \setminus \mathcal{F}_S$ such that $\dim(F \cap R) \leq$ t − 1. Note that $\dim(F \cap S) = t$. We get $\dim(F \cap R) = t - 1$. Let $H_1 = F + R$. We have $\dim H_1 = m + 1$. It is routine to check that $S \subset H_1$ and $\dim(F' \cap H_1) \geq t + 1$ for any $F' \in \mathscr{F}_R \setminus \mathscr{F}_S$. Then

$$
\mathscr{F}_R \setminus \mathscr{F}_S \subset \bigcup_{I \in \mathscr{M}(t+1;H_1) \setminus \{S\}, \ R \subset I} \mathscr{F}_I.
$$
\n
$$
(5)
$$

For each $I \in \mathscr{M}(t+1; H_1) \setminus \{S\}$ with $R \subset I$, there exists $F'' \in \mathscr{F}$ such that $\dim(F'' \cap I) \leq$ t − 1. Then from $R \subset I$ and $\dim(S \cap F'') \geq t$, we have $\dim(F'' \cap I) = t - 1$. By Lemma [3.1,](#page-5-0) we have

$$
|\mathscr{F}_I| \leqslant \begin{bmatrix} m-t+1 \\ 1 \end{bmatrix} N(\nu, m, t+2).
$$

Note that

$$
|\{I \in \mathcal{M}(t+1; H_1) : R \subset S, I \neq S\}| \leq \binom{m-t+1}{1} - 1 = q \binom{m-t}{1},
$$

$$
|\mathcal{F}_S| \leq N(\nu, m, t+1), \quad |\mathcal{M}(t; S)| = \binom{t+1}{1}.
$$

It follows from (4) and (5) that

$$
|\mathscr{F}| \leqslant N(\nu,m,t+1)+q\binom{m-t}{1}\binom{t+1}{1}\binom{m-t+1}{1}N(\nu,m,t+2).
$$

By [\(1\)](#page-2-1), [\(2\)](#page-2-2) and $2\nu \geq 2m + 2t + 6$, we obtain

$$
\begin{aligned} &\frac{f_0(\nu,m,t)-|\mathscr{F}|}{N(\nu,m,t+2)}\\ \geqslant & q\genfrac{[}{]}{0pt}{}{m-t}{1}\cdot\frac{q^{2(\nu-t-1)}-1}{q^{m-t-1}-1}-q{m-t+1\brack 2}-q{m-t\brack 1}{t+1\brack 1}{m-t+1\brack 1}\\ > & q^{2\nu-2t-1}-q^{2(m-t)+1}-q^{2m-t+3}\\ > & 0, \end{aligned}
$$

as desired.

Case 2. $t + 2 \leq \dim X \leq m$.

Write $k = \dim X$. Suppose that $T \in \mathscr{P}_t$ is contained in each member of \mathscr{S} . For $G \in \mathscr{F} \setminus \mathscr{F}_T$, let $H_2 = T + G$. For each $G' \in \mathscr{F}_T$, if $G' \cap X = T$, since $\dim(G \cap G') \geq t$ and $T \not\subset G$, we have $\dim(G' \cap H_2) \geq t+1$. On the other hand, if $T \subsetneq G' \cap X$, then there exists a member of $\mathcal{M}(t+1;X)$ containing T. Write

$$
\mathscr{A} := \left\{ A \in \mathscr{M}(t+1;H_2) : T \subset A \not\subset X \right\}, \quad \mathscr{B} := \left\{ B \in \mathscr{M}(t+1;X) : T \subset B \right\}.
$$

We have

$$
\mathscr{F}_T = \left(\bigcup_{A \in \mathscr{A}} \mathscr{F}_A\right) \cup \left(\bigcup_{B \in \mathscr{B}} \mathscr{F}_B\right). \tag{6}
$$

For each $A \in \mathscr{A}$, by assumption, A is not a t-cover of \mathscr{F} . Then there exists $G'' \in \mathscr{F} \backslash \mathscr{F}_T$ such that $\dim(G'' \cap A) \leq t - 1$. Together with $\dim(G'' \cap T) = t - 1$, we have $\dim(G'' \cap A) = t - 1$. By Lemma [3.1,](#page-5-0) we have

$$
|\mathscr{F}_A| \leqslant \binom{m-t+1}{1} N(\nu,m,t+2).
$$

By Lemma [3.2,](#page-6-0) we get $\dim(T \cap G) = t - 1$, which implies that $\dim H_2 = m + 1$ and $X = T + (G \cap X) \subset H_2$. Then

$$
|\mathscr{A}| \leqslant \begin{bmatrix} m-t+1 \\ 1 \end{bmatrix} - \begin{bmatrix} k-t \\ 1 \end{bmatrix} = q^{k-t} \begin{bmatrix} m-k+1 \\ 1 \end{bmatrix}, \quad |\mathscr{B}| \leqslant \begin{bmatrix} k-t \\ 1 \end{bmatrix}.
$$

Together with $|\mathscr{F}_B| \le N(\nu, m, t + 1)$ for each $B \in \mathscr{B}$, from [\(6\)](#page-8-0) we obtain

$$
|\mathcal{F}_T| \leqslant \begin{bmatrix} k-t \\ 1 \end{bmatrix} N(\nu, m, t+1) + q^{k-t} \begin{bmatrix} m-k+1 \\ 1 \end{bmatrix} \begin{bmatrix} m-t+1 \\ 1 \end{bmatrix} N(\nu, m, t+2). \tag{7}
$$

Write $\mathscr{C} = \{C \in \mathscr{M}(k-1;X) : T \not\subset C\}$. Suppose $X \notin \mathscr{P}_k$, then X has type $(k,1)$. Note that $|\mathscr{C}| \leq q+1$. Then

$$
|\mathscr{F}\setminus \mathscr{F}_T|\leqslant (q+1)N(\nu,m,k-1).
$$

If $X \in \mathscr{P}_k$, we have $|\mathscr{C}| = \begin{bmatrix} k \\ 1 \end{bmatrix}$ $\binom{k}{1} - \binom{k-t}{1}$ $\begin{bmatrix} -t \\ 1 \end{bmatrix} = q^{k-t} \begin{bmatrix} t \\ 1 \end{bmatrix}$ $_{1}^{t}$. Then

$$
|\mathscr{F}\setminus \mathscr{F}_T|\leqslant q^{k-t}\genfrac{[}{]}{0pt}{}{t}{1} (N(\nu,m,k-1)-N(\nu,m,k)).
$$

Since $2\nu \geq 3m + 2$ and $m \geq k \geq t + 2 \geq 3$, by [\(1\)](#page-2-1) and [\(2\)](#page-2-2), we have

$$
\frac{q^{k-t}\binom{t}{1}(N(\nu,m,k-1)-N(\nu,m,k))}{N(\nu,m,k-1)}
$$
\n
$$
=q^{k-t}\binom{t}{1}\left(1-\frac{q^{m-k+1}-1}{q^{2(\nu-k+1)}-1}\right)
$$
\n
$$
>q^{k-t}\cdot q^{t-1}\cdot\left(1-q^{m+k-2\nu-1}\right)
$$
\n
$$
\geq q+1,
$$

which implies that

$$
|\mathcal{F} \setminus \mathcal{F}_T| \leqslant q^{k-t} \binom{t}{1} (N(\nu, m, k-1) - N(\nu, m, k)) \tag{8}
$$

whenever X is a member of \mathscr{P}_k or not.

Suppose $k \geq t + 3$. For each $t + 3 \leq l \leq m$, write

$$
u(l) = q^{l-t} \begin{bmatrix} t \\ 1 \end{bmatrix} (N(\nu, m, l-1) - N(\nu, m, l)).
$$

For each $t + 3 \leq l \leq m$, since $2\nu \geq 3m + 2 > m + l$, by [\(1\)](#page-2-1), [\(2\)](#page-2-2) and $u(l + 1) \leq$ $q^{l-t+1}\begin{bmatrix} t \\ 1 \end{bmatrix}$ $_{1}^{t}$ $\bigl[N(\nu,m,l),\text{ we have}\bigr]$

$$
\frac{u(l)}{u(l+1)} \ge \frac{1}{q} \cdot \left(\frac{q^{2(\nu-l+1)} - 1}{q^{m-l+1} - 1} - 1 \right) > q^{2\nu - m - l} - \frac{1}{q} > 1.
$$

Hence

$$
\begin{aligned} &\frac{f_0(\nu,m,t)-|\mathscr{F}|}{N(\nu,m,t+2)}\\ \geqslant & q^{k-t}\genfrac{[}{]}{0pt}{}{m-k+1}{1} \cdot \frac{q^{2(\nu-t-1)}-1}{q^{m-t-1}-1}-q{m-t+1 \brack 2}-q^{k-t}{m-k+1 \brack 1}{m-t+1 \brack 1}-u(t+3)\\ > & q^{2\nu-2t-1}-q^{2(m-t)+1}-q^{2m-2t+2}-q^{t+3} \end{aligned}
$$

follows from [\(1\)](#page-2-1), [\(2\)](#page-2-2), [\(7\)](#page-8-1), [\(8\)](#page-9-0) and $2\nu \ge \max\{3m+2, 2m+2t+6\}$, as desired.

Now suppose that $k = t + 2$. For each $C \in \mathscr{C}$, since $T \not\subset C$, C is not a t-cover of \mathscr{F} . Thus there exists $E \in \mathscr{F}$ such that $\dim(E \cap C) \leq t - 1$. Notice that $\dim(E \cap X) \geq t$, which implies that $\dim(E \cap C) = t - 1$. Then $|\mathscr{F}_C| \leq \binom{m-t+1}{1}$ $\binom{t+1}{1}N(\nu,m,t+2)$ follows from Lemma [3.1.](#page-5-0) Together with $|\mathscr{C}| \leq \max\left\{q+1, \begin{bmatrix} t+2 \\ 1 \end{bmatrix}\right\}$ $\binom{+2}{1} - \binom{2}{1}$ $\begin{bmatrix} 2 \\ 1 \end{bmatrix}$ = $q^2 \begin{bmatrix} t \\ 1 \end{bmatrix}$ $\begin{bmatrix} t \\ 1 \end{bmatrix}$, we get

$$
|\mathcal{F} \setminus \mathcal{F}_T| \leqslant q^2 \begin{bmatrix} t \\ 1 \end{bmatrix} \begin{bmatrix} m-t+1 \\ 1 \end{bmatrix} N(\nu, m, t+2). \tag{9}
$$

Then from [\(1\)](#page-2-1), [\(2\)](#page-2-2), [\(7\)](#page-8-1), [\(9\)](#page-9-1) and $2\nu \ge \max\{3m+2, 2m+2t+6\}$, we obtain

$$
\begin{aligned} &\frac{f_0(\nu,m,t)-|\mathscr{F}|}{N(\nu,m,t+2)}\\ \geqslant & q^{k-t}\genfrac{[}{]}{0pt}{}{m-k+1}{1}\cdot\frac{q^{2(\nu-t-1)-1}}{q^{m-t-1}-1}-q{m-t+1\brack 2}-\genfrac{[}{]}{0pt}{}{q^{k-t}\genfrac{[}{]}{0pt}{}{m-k+1}{1}+q^2{t\brack 1}}\nonumber\end{aligned} \bigg)\genfrac{[}{]}{=}g^{2\nu-2t-1}-q^{2(m-t)+1}-q^{2m-2t+2}-q^{m+3}
$$

as desired. \Box

Proposition 3.5. Let ν, m, t and \mathscr{F}, \mathscr{S} be as in Assumption 1. If $\tau_t(\mathscr{S}) = t + 1$, then $\mathscr{F} = \mathscr{H}_2(Z)$ for some $Z \in \mathscr{P}_{t+2}$.

Proof. By $\tau_t(\mathscr{S}) = t + 1$ and Lemma [3.2,](#page-6-0) \mathscr{S} is a non-trivial t-intersecting subfamily of $\begin{bmatrix} V \\ t+1 \end{bmatrix}$. Therefore, by [\[3,](#page-12-13) Remarks (ii) in Section 9.3], there exists $Z \in \begin{bmatrix} V \\ t+2 \end{bmatrix}$ such that $\mathscr{S} \subset \begin{bmatrix} Z \\ t+1 \end{bmatrix}$.

Pick different members A, B of $\mathscr S$. Let $E = A \cap B$. Since $\mathscr S$ is non-trivial, there exists $C \in \mathscr{S}$ such that $E \not\subset C$. For any $F \in \mathscr{F}$, if $E \subset F$, together with $\dim(F \cap C) \geq t$, we get $\dim(F \cap Z) \geq t+1$. If $E \not\subset F$, then $F \cap A$ and $F \cap B$ are two different subspaces of Z with dimension at least t, which implies that $\dim(F \cap Z) \geq t + 1$. Therefore, $\mathscr{F} \subset \mathscr{H}_2(Z)$. By the maximality of $\mathscr F$ and $\mathscr{H}_2(Z)$ is *t*-intersecting, we have $\mathscr F = \mathscr{H}_2(Z)$.

Observe that $A + B = Z$ and $\dim(A \cap B) = t$. If $Z \notin \mathcal{P}_{t+2}$, Z has type $(t+2, 1)$. Then $|\mathscr{F}| = (q+1)N(\nu, m, t+1)$. To finish the proof, it is sufficient to show that

$$
(q+1)N(\nu, m, t+1) < h_2(\nu, m, t).
$$

Since $2\nu \geq 3m + 2$, by [\(1\)](#page-2-1) and [\(2\)](#page-2-2), we have

$$
\frac{h_2(\nu, m, t)}{N(\nu, m, t + 1)} = \begin{bmatrix} t + 2 \\ 1 \end{bmatrix} - q \begin{bmatrix} t + 1 \\ 1 \end{bmatrix} \cdot \frac{q^{m-t-1} - 1}{q^{2(\nu - t - 1)} - 1} > q^{t+1} - q^{-3} > q + 1,
$$
as desired.

3.2 The case $\tau_t(\mathscr{F}) \geq t+2$

Proposition 3.6. Let ν, m, t be positive integers with $2\nu \ge \max\{3m + 2, 2m + 2t + 6\}$ and $m \geq t + 2$. Suppose $\mathscr F$ is a maximum sized non-trivial t-intersecting subfamily of $\mathscr P_m$ with $\tau_t(\mathscr{F}) \geq t + 2$. Then $|\mathscr{F}| < f_0(\nu, m, t)$.

Proof. Assume that $\tau_t(\mathscr{F}) = r$. For each $S \in \mathscr{S}$, observe that

$$
\mathscr{F} \subset \bigcup_{W \in \mathscr{M}(t;S)} \mathscr{F}_W.
$$

For each $W \in \mathscr{M}(t;S)$, w.l.o.g., assume that $\mathscr{F}_W \neq \emptyset$. It is routine to check that $\begin{bmatrix} m-a \\ t-a \end{bmatrix}$ $_{t-a}^{n-a}]\leqslant$ $\lceil \frac{m-t+1}{1} \rceil$ $\left[t+1\atop1^{t+1}\right]^{t-a}$ for each $0 \leq a \leq t-1$. Then by Lemma [3.1,](#page-5-0) there exist some totally isotropic

subspaces W_1, \ldots, W_u such that $W = W_0 \subset W_1 \subset \cdots \subset W_u$ with $\dim W_u \geq r$, $\dim W_{u-1} < r$ and

$$
|\mathscr{F}_{W_{i-1}}| \leqslant {m-t+1 \brack 1}^{\dim W_i - \dim W_{i-1}} |\mathscr{F}_{W_i}|
$$

for each $i = 1, \ldots, u$. Notice that $\dim W_u \leqslant m$ from

$$
|\mathscr{F}_{W_u}| \ge |\mathscr{F}_W| / {k - t + 1 \brack 1}^{\dim W_u - t} > 0.
$$

When $t + 2 \leqslant a \leqslant m - 1$ and $2\nu \geqslant 3m - t$, we have

$$
\frac{N(\nu, m, a)}{N(\nu, m, a+1)} = \frac{q^{2(\nu - a)-1}}{q^{m-a}-1} \geqslant q^{2\nu - m - a} \geqslant q^{m-t+1} \geqslant \begin{bmatrix} m-t+1\\1 \end{bmatrix}.
$$

Consequently,

$$
|\mathscr{F}_W| \leqslant \begin{bmatrix} m-t+1 \\ 1 \end{bmatrix}^{\dim W_u-t} N(\nu, m, \dim W_u) \leqslant \begin{bmatrix} m-t+1 \\ 1 \end{bmatrix}^{r-t} N(\nu, m, r).
$$

Together with $|\mathcal{M}(t;S)| \leqslant \begin{bmatrix} r & r \end{bmatrix}$ $_t^r$, we get

$$
|\mathscr{F}| \leqslant \begin{bmatrix} r \\ t \end{bmatrix} \begin{bmatrix} m-t+1 \\ 1 \end{bmatrix}^{r-t} N(\nu, m, r).
$$

For each integer s with $t\leqslant s\leqslant m,$ write

$$
g(s) = \begin{bmatrix} s \\ t \end{bmatrix} \begin{bmatrix} m-t+1 \\ 1 \end{bmatrix}^{s-t} N(\nu, m, s).
$$

For $t \le s \le m - 1$, from [\(1\)](#page-2-1), [\(2\)](#page-2-2) and $2\nu \ge 3m + 2$, we obtain

$$
\frac{g(s+1)}{g(s)}=\frac{(q^{s+1}-1)(q^{m-t+1}-1)(q^{m-s}-1)}{(q^{s-t+1}-1)(q-1)(q^{2(\nu-s)}-1)}
$$

Then

$$
|\mathscr{F}| \leqslant \binom{t+2}{2}\binom{m-t+1}{1}^2 N(\nu, m, t+2).
$$

Since $2\nu \geq 2m + 2t + 6$, by [\(1\)](#page-2-1) and [\(2\)](#page-2-2), we get

$$
\begin{split} &\frac{f_0(\nu,m,t)-|\mathscr{F}|}{N(\nu,m,t+2)}\\ \geqslant & \left[\begin{matrix} m-t+1 \\ 1 \end{matrix} \right] \cdot \frac{q^{2(\nu-t-1)-1}}{q^{m-t-1}-1}-q \left[\begin{matrix} m-t+1 \\ 2 \end{matrix} \right] - \left[\begin{matrix} t+2 \\ 2 \end{matrix} \right] \left[\begin{matrix} m-t+1 \\ 1 \end{matrix} \right]^2\\ > & q^{2\nu-2t-1}-q^{2(m-t)+1}-q^{2(m+2)}\\ \geqslant 0, \end{split}
$$

as desired. \Box
