# On the Difficulty of Unbiased Alpha Divergence Minimization

### Abstract

Several approximate inference algorithms have been proposed to minimize an alphadivergence between an approximating distribution and a target distribution. Many of these algorithms introduce bias, the magnitude of which is poorly understood. Other algorithms are unbiased. These often seem to suffer from high variance, but again, little is rigorously known. In this work we study unbiased methods for alpha-divergence minimization through the Signal-to-Noise Ratio (SNR) of the gradient estimator. We study several representative scenarios where strong analytical results are possible, such as fullyfactorized or Gaussian distributions. We find that when alpha is not zero, the SNR worsens exponentially in the dimensionality of the problem. This casts doubt on the practicality of these methods. We empirically confirm these theoretical results.

# 1 Introduction

Variational inference (VI) typically minimizes the KL-divergence from an approximating distribution  $q_w$  to a target distribution p (Jordan et al., 1999; Blei et al., 2017; Zhang et al., 2017). While computationally convenient, the use of this objective may lead to distributions  $q_w$  with undesirable statistical properties (e.g. variance underestimation (Minka, 2005)). To avoid this, recent methods instead attempt to minimize an alpha-divergence (Amari, 1985). This is a class of divergences indexed by a parameter  $\alpha$ , that reduces to the typical KL-divergence when  $\alpha \to 0$ . The  $\alpha$  parameter determines the divergence's properties. For

instance, for  $\alpha \gg 0$ , the divergence penalizes distributions  $q_w$  that place no mass in regions where p does, penalizing variance underestimation. For many usecases, approximating distributions minimizing these divergences would be more useful.

Existing alpha-divergence minimization algorithms can be classified into two broad groups: biased methods (Minka, 2004; Hernández-Lobato et al., 2016; Li and Turner, 2016; Regli and Silva, 2018) and unbiased methods (Kuleshov and Ermon, 2017; Dieng et al., 2017). In this paper we study unbiased methods. These attempt to minimize an alpha-divergence by running stochastic optimization algorithms with unbiased estimators of the divergence's gradient. Biased methods do not exactly minimize an alpha-divergence; they either minimize local surrogates or use biased gradient estimators.

The major open question for unbiased methods concerns the difficulty of the optimization problem. Too much variability in the gradient estimator would force a very small step-size and thus a huge number of optimization steps. While some positive empirical results have been observed, authors have cautioned the the gradient estimators used can be temperamental (Kuleshov and Ermon, 2017; Dieng et al., 2017). It is currently unclear when these methods will succeed, and how their performance depends on  $\alpha$  or the dimensionality of the latent space.

We address this question. Informally, our main conclusion is that methods based on unbiased estimates of the gradient of an alpha-divergence will often require catastrophically large amounts of computation to scale to high dimensional models for any value  $\alpha \neq 0$ . This is not always due to high variance gradients, but due to an extremely low Signal-to-Noise ratio (SNR).

In Section 3 we present two gradient estimators used by unbiased methods, one obtained using reparameterization, and a novel one obtained by applying "double" reparameterization. An empirical evaluation shows that, even in simple scenarios, these methods do not seem scale to problems of moderately high dimension ( $d \approx 100$ ), nor to moderately large values of  $\alpha$  ( $\alpha \approx 0.4$ ). Curiously, optimization fails even in cases where the gradient estimator has provably low variance. Instead, we propose that this failure is best explained by the estimator's (SNR), which is known to be related to optimization convergence (Section 4.3).

The main contribution of this paper is a theoretical analysis of gradient estimators' SNR, given in Section 4. We analyze two representative scenarios: The first is when the target and approximating family are arbitrary fully-factorized distributions. The second is when the target and approximating family are both full-rank Gaussians. We give exact results and bounds for the SNR in these cases. We show that for any  $\alpha \neq 0$ , under mild assumptions, the SNR decreases exponentially in the dimensionality of the problem. Thus, even in these seemingly "easy" scenarios, unbiased methods will not scale to high dimensional problems. Finally, in Section 5 we empirically confirm that the same phenomena seems to occur in real problems.

Our results are pessimistic. Ideally, one might hope to guarantee a good SNR under some favorable assumptions about the target. For example, one might hope that the SNR could be guaranteed to be reasonably large if the log-posterior obeyed some common regularity conditions, e.g. that it were fully-factorized, concave, strongly concave, Lipschitz smooth, Gaussian, or even a fully-factorized Gaussian. Our results show that no such guarantee is possible.

We do not rule out the possibility of a good SNR guarantee under some other assumptions about the target. However, these assumptions would have to be *stronger* than any of those listed above, and also *prohibit* the cases we typically think of as easy, e.g. fully-factorized or Gaussian distributions. This suggests that a general-purpose algorithm for optimizing an alpha-divergence based on currently available unbiased gradient estimators may be unachievable.

# 2 Preliminaries

Variational Inference (VI) is an approximate inference algorithm that finds w such that the approximating distribution  $q_w(z)$  is close to some target distribution p(z). This is usually done by minimizing  $\mathrm{KL}(q_w||p)$ . In most cases the gradient of this objective with respect to w cannot be computed exactly. However, unbiased estimates are often available. Two popular alternatives are reparameterization (Titsias and Lázaro-Gredilla, 2014; Kingma and Welling, 2013; Rezende et al., 2014) and the "sticking the landing" (STL) estimator (Roeder et al., 2017). Both require a mapping  $\mathcal{T}_w$  that transforms a base density  $q_0$  into  $q_w$ .

Then, the estimators are computed as

$$g^{\text{rep}}(p, q_w, \epsilon) = \nabla_w \log \frac{q_w(\mathcal{T}_w(\epsilon))}{p(\mathcal{T}_w(\epsilon))}$$

$$g^{\text{STL}}(p, q_w, \epsilon) = \nabla_w \log \frac{q_v(\mathcal{T}_w(\epsilon))}{p(\mathcal{T}_w(\epsilon))}\Big|_{v=w},$$
(1)

where  $\epsilon \sim q_0(\epsilon)$ . While both estimators have shown good empirical performance, it has been observed that  $g^{\rm STL}$  often leads to better results (Roeder et al., 2017). Also, it has the desirable property of being deterministically zero at the optimum  $p=q_w$ , which is not true for the reparameterization estimator.

While minimizing  $\mathrm{KL}(q_w||p)$  is computationally convenient, it may lead to distributions  $q_w$  with undesirable properties. For instance, the resulting  $q_w$  tends to underestimate the variance of p (Minka, 2005). This is problematic, for instance, if  $q_w$  will be used as a proposal distribution to estimate the expectation  $\mathbb{E}_p f(z)$  with importance sampling. An under-dispersed distribution  $q_w$  leads to importance weights with high variance (Owen, 2013). For reasons like this, recent work has developed methods to minimize other divergence measures (Minka, 2004; Hernández-Lobato et al., 2016; Li and Turner, 2016; Regli and Silva, 2018; Kuleshov and Ermon, 2017; Dieng et al., 2017; Naesseth et al., 2020; Wan et al., 2020; Wang et al., 2018; Bamler et al., 2017; Futami et al., 2018).

**Alpha-divergences** may be used as an objective for VI. The alpha-divergence between distributions p and  $q_w$  is given by

$$D_{\alpha}(p||q_w) = \frac{1}{\alpha(\alpha - 1)} \mathop{\mathbb{E}}_{q_w} \left[ \left( \frac{p(z)}{q_w(z)} \right)^{\alpha} - 1 \right], \quad \alpha \in \mathbb{R} \setminus \{0, 1\}.$$
(2)

For  $\alpha \gg 0$  the divergence will penalize distributions  $q_w$  that place no mass in regions where p does, penalizing under-dispersion. For instance, minimizing  $D_{\alpha}(p||q_w)$  for  $\alpha=2$  is equivalent to minimizing the variance of the importance weights  $p(z)/q_w(z)$ . Also, alphadivergences recover several well known divergences for different values of  $\alpha$  (Cichocki and Amari, 2010): the  $\chi^2$ -divergence for  $\alpha=2$ , and the Hellinger distance for  $\alpha=0.5$ . For  $\alpha=0$  it is defined as the limit  $\alpha\to 0$ , which result in  $\mathrm{KL}(q_w||p)$ , the divergence typically used for VI. Algorithms to minimize alpha-divergences can be classified into two groups:

Biased methods (Minka, 2004; Hernández-Lobato et al., 2016; Li and Turner, 2016; Regli and Silva, 2018; Bornschein and Bengio, 2014). These either minimize local surrogates and/or use biased gradient estimators. Therefore, the distributions  $q_w$  returned by these methods are not exactly minimizers of  $D_{\alpha}(p||q_w)$ . For instance, Naesseth et al. (2020)

show an example for which the use of biased methods leads to a distribution  $q_w$  that underestimates the variance of p. This is problematic, since one of the goals of using alpha-divergences as an objective is to avoid under-dispersion.

Unbiased methods (Kuleshov and Ermon, 2017; Dieng et al., 2017). These methods were developed for the  $\chi^2$ -divergence. However, as mentioned by the authors, the same approach can be used for  $\alpha \neq 2$ . These methods minimize  $D_{\alpha}(p||q_w)$  exactly, by running SGD with an unbiased estimator of  $\nabla_w D_{\alpha}(q_w||p)$ . Under an appropriate choice for the step-size this is guaranteed to converge (Bottou et al., 2018). As mentioned previously, these methods often present scalability issues; it is unclear when they may be successfully applied.<sup>1</sup>

The **signal-to-noise ratio** (SNR) can be used as a measure of an estimator's quality. We define the SNR of a random vector X as

$$SNR[X] = \frac{\|\mathbb{E}X\|^2}{\mathbb{E}\|X\|^2} = \frac{\|\mathbb{E}X\|^2}{\|\mathbb{E}X\|^2 + \mathbb{V}\|X\|},$$
 (3)

which is always less than or equal to one, with equality holding if and only if the variance of the random variable is zero. If some of the expectations do not exist, the SNR is not defined. We will use this quantity to evaluate the quality of an estimator. This has been previously done in the context of importance weighted auto-encoders (Rainforth et al., 2018; Tucker et al., 2018).

# 3 Gradient Estimators

We present two unbiased estimators for  $\nabla_w D_\alpha(p||q_w)$ . The first one, obtained via reparameterization, is given by (Dieng et al., 2017)

$$g_{\alpha}^{\text{rep}}(p, q_w, \epsilon) = \begin{cases} \frac{1}{\alpha^2 - \alpha} \nabla_w \left( \frac{p(\mathcal{T}_w(\epsilon))}{q_w(\mathcal{T}_w(\epsilon))} \right)^{\alpha} & \text{if } \alpha \notin \{0, 1\} \\ \nabla_w \log \frac{q_w(\mathcal{T}_w(\epsilon))}{p(\mathcal{T}_w(\epsilon))} & \text{if } \alpha \to 0, \end{cases}$$

where  $\epsilon \sim q_0(\epsilon)$ . For  $\alpha \to 0$  this estimator recovers  $g^{\rm rep}$  from eq. 1. As presented, this estimator is not defined for  $\alpha \to 1$ . A second unbiased estimator, obtained by applying reparameterization twice, is given by

$$g_{\alpha}^{\text{drep}}(p, q_w, \epsilon) = \begin{cases} -\frac{1}{\alpha} \nabla_w \left( \frac{p(\mathcal{T}_w(\epsilon))}{q_v(\mathcal{T}_w(\epsilon))} \right)^{\alpha} \Big|_{v=w} & \text{if } \alpha \neq 0 \\ \nabla_w \log \frac{q_v(\mathcal{T}_w(\epsilon))}{p(\mathcal{T}_w(\epsilon))} \Big|_{v=w} & \text{if } \alpha \to 0. \end{cases}$$
(5)

This estimator is novel. We show its derivation in Appendix B. For  $\alpha \to 0$  it recovers  $g^{\rm STL}$  from eq. 1. For  $\alpha \neq 0$  it is derived by applying the reparameterization trick twice. This is similar to the derivation for the "doubly-reparameterized" gradient estimator (Tucker et al., 2018) for importance weighted autoencoders (Burda et al., 2016). A third unbiased estimator may be obtained via the score function method (Williams, 1992). In this work we do not focus on this one since reparameterization estimators seem to outperform their score function counterparts in practice.

In practice, we observed that  $g_{\alpha}^{\text{drep}}$  often works better than  $g_{\alpha}^{\text{rep}}$  (Appendix A shows an empirical comparison). This may not be surprising since (i)  $g_{\alpha}^{\text{drep}}$  is a natural extension of  $g^{\text{STL}}$ , which often works better than  $g^{\text{rep}}$  when  $\alpha \to 0$ ; (ii)  $g_{\alpha}^{\text{drep}}$  has the property of being deterministically zero at the optimum  $p = q_w$ , which is not true for  $g_{\alpha}^{\text{rep}}$ ; (iii) The use of double reparameterization has led to significant improvements over "plain" reparameterization for multisamples objectives (Tucker et al., 2018).

Empirical evaluation. We now present empirical results that motivate this work. These demonstrate two important phenomena. First, for larger  $\alpha$ , optimization scales poorly to high dimensions. Understanding this is the central goal of this paper. Second, this may happen even when the gradient estimator's variance is very small. This explains why we study SNR rather than "raw" variance.

We set p to be a standard Gaussian in d dimensions and  $q_w$  to be a mean-zero fully-factorized Gaussian. The parameters of  $q_w$  are  $w = \sigma \in \lambda^d$ , representing the standard deviation of each dimension of  $q_w$ . We initialize  $\sigma_i = 2$ , and optimize  $D_{\alpha}(p||q_w)$  from eq. 2. We do so by running SGD with the gradient estimator  $g_{\alpha}^{\text{drep}}$  for 1000 steps. (Appendix A shows results using  $g_{\alpha}^{\text{rep}}$ , which are worse.)

We perform this optimization for three different dimensionalities,  $d \in \{8, 32, 128\}$ , for  $\alpha \in \{0, 0.4, 0.9, 1.5\}$ , and for gradient estimators obtained averaging N samples, for  $N \in \{1, 10, 10^2, 10^3, 10^4\}$ . For each triplet  $(d, \alpha, N)$  we tuned the step-size; we ran simulations for all step-sizes in the set  $\{10^i\}_{i=-7}^7$  and selected the one that lead to the best final performance. All results are averages over 15 simulations.




Figure 1: Running SGD with unbiased gradient estimates becomes inefficient for moderately large dimensions and  $\alpha$ . Each plot shows the optimization results for each pair  $(d, \alpha)$  for all values of N considered. Plots show "Error vs. Iteration", where error is the normalized distance between the scale parameters of p and  $q_w$ , computed as  $(1/d) \sum_i (\sigma_{qi} - 1)^2$ .

Fig. 1 shows the results. Optimization succeeds when the dimensionality d is small or  $\alpha$  is small. Indeed, for  $\alpha \to 0$ , optimization converges in approximately 30 steps, regardless of the dimensionality and the number of samples used to estimate each gradient. However, when  $\alpha$  is larger, increasing d seems to cause major difficulties. For instance, for d=32 and  $\alpha=1.5$ , optimization does not meaningfully converge within 1000

steps, even using  $10^4$  samples to estimate gradients. Furthermore, for d=128 and  $\alpha \neq 0$  optimization barely makes any progress regardless of the number of samples used to estimate gradients.




Figure 2: Optimization difficulty is explained not by high variance but by low SNR. p is a standard Gaussian in d = 128 dimensions and  $q_w$  is an isotropic Gaussian with standard deviation  $\sigma_q$ . Left: Variance of gradient estimator. Center: SNR. Right: Squared norm of the true gradient,  $\mathbb{E}[g]$ .

For  $\alpha=2$ , previous work has attributed the scaling issues of unbiased methods to the use of gradient estimates with high variance (Kuleshov and Ermon, 2017; Dieng et al., 2017). While correct in spirit, care is needed. Some of the failures in Fig. 1 happen despite low-variance gradients, because the true gradient is even smaller. Take d=128, and let  $\sigma_i=\sigma$  for all i, so that  $q_w$  is isotropic. Fig. 2 (left) shows the variance of the gradient estimator for different values of  $\sigma$  and  $\alpha$ . We see that increasing  $\alpha$  sometimes decreases gradient variance. Instead, we attribute optimization's scaling issues to the estimator's SNR. As shown in Fig. 2 (center) we see that this decreases very rapidly with higher  $\alpha$ .<sup>2</sup>

# 4 SNR Analysis

In this section we present a detailed analysis of the SNR of gradient estimators for two general and representative scenarios. First, we consider the case where

p and  $q_w$  are arbitrary fully-factorized distributions. Second, we consider the case where p and  $q_w$  are Gaussians with an arbitrary full-rank covariance matrices. This case is particularly relevant, since Gaussians are a good approximation of a huge range of posteriors (because of the Bayesian central limit theorem). We show that, in both cases, for  $\alpha \neq 0$  the gradient estimator's SNR becomes very small for problems with high dimensionality d. In fact, we present examples for which the SNR decreases exponentially in d. In contrast to this, we show that, for  $\alpha \to 0$ , the SNR of the estimator decreases at most as 1/d, and does not depend on d if both p and  $q_w$  are factorized. Intuitively, a low SNR means that the level of noise present in the estimator is considerably larger than the "learning signal", which difficults optimization.

We proceed in a similar way for all scenarios considered. We first present a rigorous result, and then give a simple and intuitive interpretation and examples.

#### 4.1 Fully-Factorized Distributions

We begin by studying the case where both p and  $q_w$  are arbitrary fully-factorized distributions. Of course, if we knew that p is fully factorized, it would make sense to perform inference on each component separately. The point of examining this case is the insight it gives us into how gradient estimators behave as dimensionality changes. For simplicity, we assume that

there is one parameter  $w_i$  for each coordinate  $z_i$ . This assumption is used to simplify notation and can be removed, as long as each component is determined by disjoint sets of parameters.

**Theorem 1.** Let 
$$p(z) = \prod_{i=1}^{d} p_i(z_i), \ q_w(z) = \prod_{i=1}^{d} q_{w_i}(z_i), \ and \ g_{\alpha} \in \{g_{\alpha}^{\text{rep}}, g_{\alpha}^{\text{drep}}\}.$$

If  $p_j \neq q_{w_j}$  and  $g_{\alpha}$  has finite variance, the SNR of the j-th component of the estimator,  $g_{\alpha j}$ , is given by

$$SNR[g_{\alpha j}(p, q_w, \epsilon)] = SNR \left[g_{\alpha}(p_j, q_{w_j}, \epsilon_j)\right]$$
 (6)

for  $\alpha \to 0$ , and by

$$SNR[g_{\alpha j}(p, q_w, \epsilon)] =$$

$$SNR \left[ g_{\alpha}(p_j, q_{w_j}, \epsilon_j) \right] \prod_{\substack{i=1\\i\neq j}}^{d} SNR \left[ \tilde{D}_{\alpha}(p_i, q_{w_i}, \epsilon_i) \right] \quad (7)$$

for  $\alpha \neq 0$ , where  $\tilde{D}_{\alpha}(p_i, q_{w_i}, \epsilon_i) = \left(\frac{p_i(\mathcal{T}_{w_i}(\epsilon_i))}{q_{w_i}(\mathcal{T}_{w_i}(\epsilon_i))}\right)^{\alpha}$  is an unbiased estimator of  $\alpha(\alpha - 1)D_{\alpha}(p_i||q_{w_i}) + 1$ .

If  $p_j = q_{w_j}$ , the SNR is zero for  $g_{\alpha}^{\text{rep}}$  and is undefined for  $g_{\alpha}^{\text{drep}}$  (because  $g_{\alpha}^{\text{drep}}$  is deterministically zero).

To clarify the Theorem's notation,  $g_{\alpha j}(p,q_w,\epsilon)$  is the j-th component of the estimator  $g_{\alpha}$  for the vector  $\nabla_w D_{\alpha}(p || q_w)$ . On the other hand,  $g_{\alpha}(p_j,q_{w_j},\epsilon_j)$  is the estimator for the scalar quantity  $\nabla_{w_j} D_{\alpha}(p_j || q_{w_j})$ , the derivative (with respect to  $w_j$ ) of the divergence between the one dimensional distributions  $p_j$  and  $q_{w_j}$ .

What does the theorem say? If  $\alpha \to 0$  (eq. 6), the SNR of each component of the estimator consists on a single term, which is the same as if inference were performed on each dimension of p separately. That is, the SNR of the estimator's j-th component only depends on  $p_j$  and  $q_{w_j}$ , and is not affected by the dimensionality of the problem d in any way. In contrast, if  $\alpha \neq 0$  (eq. 7), there are d-1 additional terms. These determine how the SNR scales with dimensionality. Since these terms can be expressed as the SNR of an estimator for  $D_{\alpha}(p_i||q_{w_i})$  (for each  $i \neq j$ , up to scaling constants), each of them is at most one, with equality only if  $p_i = q_{w_i}$ . Thus, for  $\alpha \neq 0$ , discrepancies in

several dimensions of p and  $q_w$  accumulate (as products of terms strictly smaller than one), leading to a large detrimental effect on the estimator's SNR. Intuitively, the larger the dimensionality of the problem d, the worse this effect becomes.

An example that clearly illustrates this curse of dimensionality is given by the case where p and q are isotropic distributions. Suppose each component of p and  $q_w$  are the same, that is,  $p_i = p_1$  and  $q_{w_i} = q_{w_1}$  for all i. Following eq. 7, if  $\alpha \neq 0$ , the SNR of the j-th component of the gradient estimator is given by

SNR 
$$[g_{\alpha}(p_1, q_{w_1}, \epsilon_1)] \left( \text{SNR} \left[ \tilde{D}_{\alpha}(p_1, q_{w_1}, \epsilon_1) \right] \right)^{d-1}, \quad (8)$$

which worsens exponentially in d. In contrast, if  $\alpha \to 0$ , the SNR does not depend on d at all (eq. 6).

#### 4.1.1 Fully-Factorized Gaussians

As a second example of fully-factorized distributions, we consider the case where p and  $q_w$  are d-dimensional diagonal Gaussians with mean zero. The parameters are the standard deviations of each component of  $q_w$ , i.e.  $w = \{\sigma_{q1}, \ldots, \sigma_{qd}\}$ . In this case we can compute each term in eq. 7 in closed form.

Corollary 2. Let p and q be two fully-factorized d-dimensional Gaussian distributions with mean zero and variances  $\sigma_{pi}^2$  and  $\sigma_{qi}^2$ . Let  $\lambda_i = \frac{\sigma_{qi}^2}{\sigma_{pi}^2}$  and  $g_{\alpha} = g_{\alpha}^{\text{drep}}$ .

If 
$$\lambda_j \neq 1$$
 and  $1 + 2\alpha(\lambda_i - 1) > 0$  for all  $i$ ,

$$\operatorname{SNR}[g_{\alpha j}(p, q_{w}, \epsilon)] = \underbrace{\frac{1 + 2\alpha(\lambda_{j} - 1)}{3} f(\lambda_{j}, \alpha)^{3}}_{\operatorname{SNR}\left[g_{\alpha}(p_{j}, q_{w_{j}}, \epsilon_{j})\right]} \prod_{\substack{i=1\\i \neq j}}^{d} \underbrace{f(\lambda_{i}, \alpha)}_{\operatorname{SNR}\left[\tilde{D}_{\alpha}(p_{i}, q_{w_{i}}, \epsilon_{i})\right]} (9)$$

where

$$f(\lambda, \alpha) = \frac{1}{\sqrt{1 + \alpha^2 \frac{(\lambda - 1)^2}{1 + 2\alpha(\lambda - 1)}}}.$$
 (10)

Otherwise, the SNR is not defined. If  $\lambda_j = 1$  this is because the estimator  $g_{\alpha j}$  is zero deterministically. If  $1 + 2\alpha(\lambda_i - 1) \leq 0$  for any i, this is because the estimator has infinite variance.




Figure 3:  $f(\lambda, \alpha)$ . White (rightmost plot) indicates regions where  $1 + 2\alpha(\lambda - 1) > 0$  is not satisfied (in this region the estimator has infinite variance, and thus the SNR is not defined).

Corollary 2 gives conditions under which the SNR of the gradient estimator is well-defined (i.e. estimator has finite variance), and gives an expression for the SNR in such cases. In order to understand this expression, it is important to understand the behavior of the function  $f(\lambda, \alpha)$ . Fig. 3 shows a visualization. It can be observed that (i)  $f(\lambda, \alpha)$  achieves its maximum value of 1 if and only if  $\lambda = 1$  or  $\alpha = 0$ ; and (ii)  $f(\lambda, \alpha)$  decreases as  $\alpha$  moves aways from 0 or  $\lambda$  moves away from 1. We present a formal characterization of this function in Lemma 5 (supplement).

Again, the behavior of the SNR for problems with high dimensionalities is determined by the d-term product  $\prod_i f(\lambda_i, \alpha)$  in eq. 9. We see that, if  $\alpha \to 0$ , each term in this product is just one (because  $f(\lambda, 0) = 1$ ), and thus the SNR is just 1/3. On the other hand, if  $\alpha \neq 0$ , each of the terms is at most one (with equality only if the corresponding  $\lambda_i = 1$ ). Therefore, if  $\alpha \neq 0$ , discrepancies in several dimensions of p and  $q_w$  accumulate, leading to a large detrimental effect on the SNR of every component of the estimator. In addition, in this case we can exactly quantify this deterioration in terms of  $\alpha$  and  $\lambda_i$ : The SNR worsens for  $\alpha$  values with large absolute value and when discrepancies between components is large (i.e.  $\lambda_i$  far from 1), since for these cases  $f(\lambda, \alpha)$  is significantly less than one (see Fig. 3).

In addition, there are entirely non-pathological cases for which the estimator has infinite variance. This occurs whenever the condition  $1+2\alpha(\lambda_i-1)>0$  is not satisfied for some i. For instance, this happens if we set  $\alpha=1$ ,  $\sigma_{pi}=1$  and  $\sigma_{qi}=0.7$ . More generally, the condition is equivalent to  $\alpha\sigma_q^2>(\alpha-1/2)\sigma_p^2$ . This is always satisfied for  $0\leq\alpha<1/2$ . If  $\alpha\geq1/2$ , this means that the variance of  $q_w$  cannot be much smaller than that of p. If  $\alpha<0$ , this means that the variance of  $q_w$  cannot be much larger than that of p.

**Example.** Consider the case where  $\alpha = 0.4$ , p is a standard Gaussian with dimension d = 128, and  $q_w$  is a mean zero factorized Gaussian with  $\sigma_{qi} = 2$  for all i. Eq. 9 yields  $\mathrm{SNR}[g_{\alpha j}] \approx 1.2 \times 10^{-10}$ . This means that the variance of the estimator is approximately  $8 \times 10^9$  times larger than the actual signal. In contrast, for  $\alpha \to 0$ , the SNR is just 1/3. Obtaining an estimator with a similar SNR for  $\alpha = 0.4$  would require averaging  $N \approx 4 \times 10^9$  independent samples (this quantity grows exponentially if problems of larger dimensionality are considered).

#### 4.2 Gaussians with arbitrary Covariances

We now move away from factorized distributions and consider the case in which both p and  $q_w$  are d-dimensional Gaussians with mean zero and arbitrary full-rank covariances  $\Sigma_p$  and  $\Sigma_q$ . The set of parameters is given by w = S, where S is a matrix such that  $SS^{\top} = \Sigma_q$ , and reparameterization is given by  $\mathcal{T}_w(\epsilon) = S\epsilon$ , where  $\epsilon \sim \mathcal{N}(0, I)$ .

**Theorem 3.** Let  $p(z) = \mathcal{N}(z|0, \Sigma_p)$  and  $q(z) = \mathcal{N}(z|0, \Sigma_q)$ . Let  $\lambda_1, \ldots, \lambda_d$  be the eigenvalues of  $\Sigma_p^{-1} \Sigma_q$  and  $g_{\alpha} = g_{\alpha}^{\text{drep}}$ .

If  $\Sigma_p \neq \Sigma_q$  and  $1 + 2\alpha(\lambda_i - 1) > 0$  for all i we get

$$SNR[g_{\alpha}(p, q_w, \epsilon)] = \frac{1}{d+2}$$
(11)

for  $\alpha \to 0$ ,

$$SNR[g_{\alpha}(p, q_w, \epsilon)] \le \left(\frac{1 + \alpha(\lambda_{\min} - 1)}{1 + 2\alpha(\lambda_{\max} - 1)}\right)^2 \prod_{i=1}^d f(\lambda_i, \alpha)$$
(12)

for  $\alpha > 0$ , and

$$SNR[g_{\alpha}(p, q_{w}, \epsilon)] \leq \left(\frac{1 + \alpha(\lambda_{\max} - 1)}{1 + 2\alpha(\lambda_{\min} - 1)}\right)^{2} \prod_{i=1}^{d} f(\lambda_{i}, \alpha)$$
(13)

for  $\alpha < 0$ , where  $\lambda_{\max} = \max_i \lambda_i$ ,  $\lambda_{\min} = \min_i \lambda_i$  (these are both positive), and  $f(\lambda, \alpha)$  is defined in eq. 10.

Otherwise, the SNR is not defined. If  $\Sigma_p = \Sigma_q$ , this is because the estimator  $g_{\alpha}$  is zero deterministically. If  $1 + 2\alpha(\lambda_i - 1) \leq 0$  for any i, this is because the estimator has infinite variance.

The results in Theorem 3 can be interpreted similarly to those in Corollary 2. If  $\alpha \to 0$ , the SNR is just 1/(d+2), independent of p and  $q_w$ . If  $\alpha \neq 0$ , the SNR's upper bound contains the product of d terms, all at most 1, with equality only if the corresponding  $\lambda_i = 1$ . As with factorized distributions, for  $\alpha \neq 0$ , discrepancies between several dimensions of p and  $q_w$  accumulate, leading to a small SNR. As with fully-factorized Gaussians, this deterioration worsens for  $\alpha$  values with large magnitude and for  $\lambda_i$  far from one. The condition that must be satisfied to get an estimator with finite variance is the same as the one for factorized Gaussians, but now,  $\lambda_i$  represents an eigenvalue of  $\Sigma_p^{-1}\Sigma_q$  instead of the ratio  $\sigma_{qi}^2/\sigma_{pi}^2$ .

**Example.** Consider the case where p and  $q_w$  are d dimensional isotropic Gaussians with covariances  $\sigma_p^2 I$  and  $\sigma_q^2 I$ , with  $\sigma_p \neq \sigma_q$ . If  $\alpha \neq 0$ , the estimator's SNR is upper bounded by  $\propto f(\lambda, \alpha)^d$ , where  $f(\lambda, \alpha)$  is strictly less than 1. This upper bound goes to zero exponentially as a function of d. In contrast, for  $\alpha \to 0$ , the SNR decreases as 1/d.

It is worth mentioning that the bounds in Theorem 3 are obtained as a relaxation of an exact but much more technical result, shown in Section 6 (Theorem 4). While this latter result is fully precise, it is hard to interpret, so we do not include it here.

# 4.3 Effect of SNR on Optimization

We presented general and representative scenarios for which the gradient estimator's SNR becomes extremely small as the dimensionality of the problem increases. How does this affect optimization convergence? Under some regularity assumptions, an SGD convergence guarantee assuming a bound on the SNR is known. See, for instance, Theorem 4.8 by Bottou et al. (2018). Their eq. 4.9 is equivalent to an SNR bound. They show that (under some assumptions) SGD requires a number of iterations that is  $\mathcal{O}(1/\text{SNR})$  to converge. Thus, an exponentially small SNR translates to an exponentially large number of SGD iterations. Intuitively, this is because a small SNR leads to a small step-size, which in turn leads to a large number of SGD iterations.

In addition, other papers analyze this from a more empirical perspective. For instance, Shalev-Shwartz et al. (2017) relate gradient estimators with extremely low SNRs to complete failures of SGD. They mention that when the SNR approaches small values, the noise can completely mask the signal, and thus gradients are not sufficiently informative for optimization to succeed.

# 5 Experiments and Results

Results in this work show that, for the scenarios considered, if  $\alpha \neq 0$  unbiased estimates of  $\nabla_w D_\alpha(p||q_w)$  suffer from a low SNR, which worsens fast with the dimensionality of the problem. Thus, methods based on these estimates will scale extremely poorly to high dimensional problems. In this section we empirically show similar severe scalability issues for Bayesian logistic regression models.

We use two datasets: Iris and Australian, which have

dimensionalities 4 and 14, respectively. For both datasets we used a subset of 100 samples. For *Iris* this reduced to keeping only data-points from two classes (out of the original three), while for *Australian* we subsampled 100 data-points. We use a diagonal Gaussian as variational distribution  $q_w$ , initialized to have mean zero and covariance identity.

When p is a posterior, we cannot directly estimate gradients of the alpha-divergence since p(z|x) is intractable. However, if we define the " $\alpha$ -ELBO"

$$\mathcal{L}_{\alpha}(w) = \frac{1}{\alpha(1-\alpha)} \mathop{\mathbb{E}}_{q_w(z)} \left[ \left( \frac{p(x,z)}{q_w(z)} \right)^{\alpha} - 1 \right], \quad (14)$$

then it's easy to show that maximizing  $\mathcal{L}_{\alpha}$  is equivalent to minimizing the alpha-divergence, since

$$f_{\alpha}(p(x)) = \mathcal{L}_{\alpha}(w) + p(x)^{\alpha} D_{\alpha}(p(z|x)||q(z))$$
 (15)

for  $f_{\alpha}(x) = \frac{1}{\alpha(1-\alpha)}(x^{\alpha}-1)$ . Thus a gradient of  $\mathcal{L}_{\alpha}$  is equal to a gradient of  $D_{\alpha}$  up to a sign change and a multiplication by the constant factor of  $p(x)^{\alpha}$ . Eq. 15 gives a lower-bound on p(x) for  $\alpha < 1$  and an upper-bound for  $\alpha > 1$  (corresponding to the cases where  $f_{\alpha}$  is increasing and decreasing, respectively).

We optimize  $\mathcal{L}_{\alpha}$  by running SGD with unbiased gradient estimates for 1000 steps. We do this for  $\alpha \in \{0, 0.1, 0.2, 0.3\}$  and for  $N \in \{1, 10, 10^2, 10^3, 10^4\}$  (number of samples used to estimate the gradient at each step). For each pair  $(\alpha, N)$  we tuned the stepsize; we ran simulations for all step-sizes in the set  $\{10^i\}_{i=-6}^6$  and selected the top-performing one. All results shown are averages over 12 simulations.




Figure 4: Optimization results for each  $\alpha$  for all values of N considered. The loss at each step (eq. 14) is estimated using  $5 \times 10^5$  samples for Iris (d = 4), and  $1.5 \times 10^5$  samples for Australian (d = 14).

Optimization results are shown in Fig. 4. For the smaller dataset, Iris (d=4), optimization converges properly for all values of  $\alpha$  considered regardless of the number of samples N used to estimate the gradient. The situation is different for the Australian dataset (d=14). In this case, optimization converges properly for  $\alpha \to 0$ , but as  $\alpha$  is increased a much larger number of samples N is required to retain convergence ( $N \ge 1000$  for  $\alpha = 0.3$ ). This shows that, even for a simple logistic regression model of low dimension

(d=14),  $\alpha$ -divergence minimization methods based on unbiased gradient estimates scale very poorly with the dimensionality of the problem when  $\alpha \neq 0$ . We also ran simulations with larger datasets  $(d \approx 100)$ , for which optimization barely made any progress at all regardless of the number of samples N used.




Figure 5: Direct test of SNR for different values of  $\alpha$  along a single shared optimization path.

Fig. 5 shows the SNR of the estimator for different values of  $\alpha$  along a single optimization path, obtained by minimizing  $\mathcal{L}_{\alpha}$  for  $\alpha \to 0$  (equivalent to maximizing the ELBO). For the smaller dataset, Iris~(d=4), all values of  $\alpha$  considered lead to comparable SNRs. In contrast, for the Australian dataset (d=14), the SNR descreases rapidly as  $\alpha$  is increased.

# 6 Discussion

We study unbiased methods for  $\alpha$ -divergence minimization with the goal of understanding when these methods may be successfully applied. We present a detailed analysis of the SNR of unbiased gradient estimates for different scenarios. Our results are pessimistic. Suppose the variational family is any fully-factorized family, or the set of full-rank Gaussians. We show that in the favorable case where the posterior is inside the variational family, the SNR degrades catastrophically in the dimensionality. Optimization theory

suggests that an exponential amount of computation time would be needed to optimize the objectives.

Interestingly, results in this work rule out some potential "intuitive" solutions. For instance, one might think that, for  $\alpha>0$ , using an over-dispersed distribution  $q_w$  could mitigate variance issues. However, Theorem 1 shows this is not the case. While an over-dispersed distribution might help avoid estimators with infinite variance, it would not avoid the exponential deterioration of the SNR in terms of the dimensionality of the problem.

Given the failure of unbiased methods, one could consider using some biased alternative. While some positive results have been observed (Hernández-Lobato et al., 2016; Li and Turner, 2016), to the best of our knowledge, it is not known how much error these methods introduce. Since these methods trade variance for bias, an analysis of the amount of bias they introduce is needed. We believe that such an analysis might be related to the curse of dimensionality results for self-normalized importance sampling, which conjectures that to get meaningful results the number of samples used from the proposal distribution should be exponential in the dimensionality of the problem (Bengtsson et al., 2008; Bugallo et al., 2017).

Exact result for Gaussians. Theorem 3 bounds the gradient estimator's SNR for Gaussians with arbitrary covariances. While it admits a nice interpretation, it is not tight. As mentioned previously, an exact result is possible. For completeness we include it here. While this result is fully precise, it is harder to interpret than the bounds from Theorem 3. It may be possible to find tighter bounds that are still "simple", or to find an intuitive interpretation of the exact result. We believe a step in these directions may further increase our understanding of these methods.

**Theorem 4.** Take the setting of Theorem 3 with  $\Sigma_p \neq \Sigma_q$  and  $1 + 2\alpha(\lambda_i - 1) > 0$  for all i. Let S be a matrix such that  $\Sigma_q = SS^{\top}$  and let  $\alpha \neq 0$ . Then,

$$SNR[g_{\alpha}(p, q_{w}, \epsilon)] = \frac{\|BU^{-1}\|_{F}^{2} \times \prod_{i=1}^{d} f(\lambda_{i}, \alpha)}{\operatorname{tr}(V^{-1})\operatorname{tr}(BV^{-1}B^{\top}) + 2\|BV^{-1}\|_{F}^{2}},$$

$$\begin{split} & where \ B = (\Sigma_p^{-1} - \Sigma_q^{-1})S, \ U = (1-\alpha)I + \alpha S^\top \Sigma_p^{-1}S, \\ & and \ V = (1-2\alpha)I + 2\alpha S^\top \Sigma_p^{-1}S. \end{split}$$

# A Comparison of Estimators

In this section we present a simple empirical comparison between the estimators  $g_{\alpha}^{\text{drep}}$  and  $g_{\alpha}^{\text{rep}}$ . We consider the same setting as in Section 3, where p is a d-dimensional standard Gaussian, and  $q_w$  is set to be a mean-zero factorized Gaussian, with scales initialized to 2. We optimize  $D_{\alpha}(p||q_w)$  from eq. 2. We do so by running SGD with the estimators  $g_{\alpha}^{\text{drep}}$  and  $g_{\alpha}^{\text{rep}}$  for 1000 steps.

We perform this optimization for four different dimensionalities,  $d \in \{2, 8, 16, 32\}$ , for  $\alpha \in \{0, 0.4, 0.9, 1.5\}$ , and for gradient estimators obtained averaging N samples, for  $N \in \{1, 10, 10^2\}$ . For each estimator and triplet  $(d, \alpha, N)$  we tune the step-size; we ran simulations for all step-sizes in the set  $\{10^i\}_{i=-7}^7$  and select the one that leads to the best final performance. All results shown are average over 15 simulations.




Figure 6:  $\mathbf{g}_{\alpha}^{\text{drep}}$  tends to work significantly better than  $\mathbf{g}_{\alpha}^{\text{rep}}$ . Each plot shows the optimization results for each pair  $(d, \alpha)$  for all values of N considered. Plots show "Error vs. Iteration", where error is the normalized distance between the scale parameters of p and  $q_w$ , computed as  $(1/d) \sum_i (\sigma_{qi} - 1)^2$ .

Fig. 6 shows the results. It can be observed that the results obtained using estimator  $g_{\alpha}^{\text{drep}}$  are strictly better that the results with  $g_{\alpha}^{\text{rep}}$ . In some cases we can even observe that  $g_{\alpha}^{\text{drep}}$  using N=1 performs better than  $g_{\alpha}^{\text{rep}}$  using N=100.

# **B** Derivation of Estimators

We re-write the true gradient in different forms for each method. The corresponding estimator is obtained by estimating the resulting expectations with samples  $\epsilon \sim q_0(\epsilon)$ .

#### Reparameterization.

• For  $\alpha \neq \{0,1\}$  we have

$$\nabla_w D_\alpha(p||q_w) = \nabla_w \frac{1}{\alpha(\alpha - 1)} \mathop{\mathbb{E}}_{q_w(z)} \left[ \left( \frac{p(z)}{q_w(z)} \right)^\alpha - 1 \right]$$
 (16)

$$= \nabla_w \frac{1}{\alpha(\alpha - 1)} \underset{q_0(\epsilon)}{\mathbb{E}} \left[ \left( \frac{p(\mathcal{T}_w(\epsilon))}{q_w(\mathcal{T}_w(\epsilon))} \right)^{\alpha} - 1 \right]$$
 (17)

$$= \frac{1}{\alpha(\alpha - 1)} \mathop{\mathbb{E}}_{q_0(\epsilon)} \left[ \nabla_w \left( \frac{p(\mathcal{T}_w(\epsilon))}{q_w(\mathcal{T}_w(\epsilon))} \right)^{\alpha} \right]. \tag{18}$$

• For  $\alpha \to 0$  we know that  $D_{\alpha}(p||q_w) \to \mathrm{KL}(q_w||p)$ , then the gradient can be expressed as

$$\nabla_w D_\alpha(p||q_w) = \nabla_w \mathop{\mathbb{E}}_{q_w(z)} \left[ \log \frac{q_w(z)}{p(z)} \right]$$
(19)

$$= \nabla_w \underset{q_0(\epsilon)}{\mathbb{E}} \left[ \log \frac{q_w(\mathcal{T}_w(\epsilon))}{p(\mathcal{T}_w(\epsilon))} \right]$$
 (20)

$$= \underset{q_0(\epsilon)}{\mathbb{E}} \left[ \nabla_w \log \frac{q_w(\mathcal{T}_w(\epsilon))}{p(\mathcal{T}_w(\epsilon))} \right]. \tag{21}$$

• For  $\alpha \to 1$  we know that  $D_{\alpha}(p||q_w) \to \mathrm{KL}(p||q_w)$ , then the gradient can be expressed as

$$\nabla_w D_{\alpha}(p||q_w) = \nabla_w \mathop{\mathbb{E}}_{p(z)} \left[ \log \frac{p(z)}{q_w(z)} \right]$$
 (22)

$$= - \mathop{\mathbb{E}}_{p(z)} \left[ \nabla_w \log q_w(z) \right]. \tag{23}$$

The expression from eq. 23 is not useful, since we cannot draw samples from p. However, we can rewrite it as

$$\nabla_w D_{\alpha}(p||q_w) = - \mathop{\mathbb{E}}_{p(z)} \left[ \nabla_w \log q_w(z) \right]$$
 (24)

$$= - \underset{p(z)}{\mathbb{E}} \left[ \frac{1}{q_v(z)} \nabla_w q_w(z) \right] \tag{25}$$

$$= -\nabla_w \mathop{\mathbb{E}}_{q_w(z)} \left[ \frac{p(z)}{q_v(z)} \right]_{v=w} \tag{26}$$

$$= - \underset{q_0(\epsilon)}{\mathbb{E}} \left[ \nabla_w \frac{p(\mathcal{T}_w(\epsilon))}{q_v(\mathcal{T}_w(\epsilon))} \right]_{v=w}. \tag{27}$$

### Double reparameterization.

• For  $\alpha \neq \{0,1\}$  we have

$$\nabla_w D_\alpha(p||q_w) \tag{28}$$

$$= \nabla_w \frac{1}{\alpha(\alpha - 1)} \mathop{\mathbb{E}}_{q_w(z)} \left[ \left( \frac{p(z)}{q_w(z)} \right)^{\alpha} - 1 \right]$$
 (29)

$$= \underbrace{\nabla_w \frac{1}{\alpha(\alpha - 1)} \mathop{\mathbb{E}}_{q_w(z)} \left[ \left( \frac{p(z)}{q_v(z)} \right)^{\alpha} \right]_{v = w}}_{A} + \underbrace{\nabla_w \frac{1}{\alpha(\alpha - 1)} \mathop{\mathbb{E}}_{q_v(z)} \left[ \left( \frac{p(z)}{q_w(z)} \right)^{\alpha} \right]_{v = w}}_{B}. \tag{30}$$

Term A can be expressed as

$$A = \nabla_w \frac{1}{\alpha(\alpha - 1)} \mathop{\mathbb{E}}_{q_0(\epsilon)} \left[ \left( \frac{p(\mathcal{T}_w(\epsilon))}{q_v(\mathcal{T}_w(\epsilon))} \right)^{\alpha} \right]_{v=w}. \tag{31}$$

For term B we have

$$B = \nabla_w \frac{1}{\alpha(\alpha - 1)} \mathop{\mathbb{E}}_{q_w(z)} \left[ \left( \frac{p(z)}{q_w(z)} \right)^{\alpha} \right]_{v = w}$$
(32)

$$= \frac{1}{\alpha(\alpha - 1)} \mathop{\mathbb{E}}_{q_v(z)} \left[ \nabla_w \left( \frac{p(z)}{q_w(z)} \right)^{\alpha} \right]_{v=w}$$
(33)

$$= \frac{-1}{\alpha(\alpha - 1)} \underset{q_v(z)}{\mathbb{E}} \left[ \alpha \left( \frac{p(z)}{q_v(z)} \right)^{\alpha - 1} \frac{p(z)}{q_v(z)^2} \nabla_w q_w(z) \right]_{v = w}$$
(34)

$$= \frac{-1}{\alpha(\alpha - 1)} \nabla_w \mathop{\mathbb{E}}_{q_w(z)} \left[ \alpha \left( \frac{p(z)}{q_v(z)} \right)^{\alpha - 1} \frac{p(z)}{q_v(z)} \right]_{z = z_0}$$
(35)

$$= \frac{-1}{\alpha(\alpha - 1)} \nabla_w \underset{q_w(z)}{\mathbb{E}} \left[ \alpha \left( \frac{p(z)}{q_v(z)} \right)^{\alpha} \right]_{z = w}$$
(36)

$$= \frac{-1}{\alpha - 1} \mathop{\mathbb{E}}_{q_0(\epsilon)} \left[ \nabla_w \left( \frac{p(\mathcal{T}_w(\epsilon))}{q_v(\mathcal{T}_w(\epsilon))} \right)^{\alpha} \right]_{v=w}. \tag{37}$$

Combining the results for A and B as  $\nabla_w D_\alpha(p||q_w) = A + B$  yields

$$\nabla_w D_{\alpha}(p||q_w) = \frac{-1}{\alpha} \mathop{\mathbb{E}}_{q_0(\epsilon)} \left[ \nabla_w \left( \frac{p(\mathcal{T}_w(\epsilon))}{q_v(\mathcal{T}_w(\epsilon))} \right)^{\alpha} \right]_{v=w}. \tag{38}$$

• For  $\alpha \to 0$  we get the "Sticking the landing" estimator (Roeder et al., 2017)

$$\nabla_w D_\alpha(p||q_w) = \nabla_w \mathop{\mathbb{E}}_{q_w(z)} \left[ \log \frac{p(z)}{q_w(z)} \right]$$
(39)

$$= \nabla_w \mathop{\mathbb{E}}_{q_v(z)} \left[ \log \frac{p(z)}{q_w(z)} \right]_{v=w} + \nabla_w \mathop{\mathbb{E}}_{q_w(z)} \left[ \log \frac{p(z)}{q_v(z)} \right]_{v=w}$$
 (40)

$$= - \underset{q_v(z)}{\mathbb{E}} \left[ \nabla_w \log q_w(z) \right]_{v=w} + \nabla_w \underset{q_0(\epsilon)}{\mathbb{E}} \left[ \log \frac{p(\mathcal{T}_w(\epsilon))}{q_v(\mathcal{T}_w(\epsilon))} \right]_{v=w}$$
(41)

$$= \nabla_w \mathop{\mathbb{E}}_{q_0(\epsilon)} \left[ \log \frac{p(\mathcal{T}_w(\epsilon))}{q_v(\mathcal{T}_w(\epsilon))} \right]_{v=w}. \tag{42}$$

• For  $\alpha \to 1$  we just get eq. 27.

# C Proofs

We now present the proofs of the three SNR theorems in the paper. All theorems are proved separately for  $\alpha \neq 0$  and  $\alpha \to 0$ , starting from the corresponding expression for the gradient estimator  $g_{\alpha}^{\text{drep}}$  from eq. 5. However, all of these results could also be obtained by computing the SNR for  $\alpha \neq 0$  and taking the limit when  $\alpha \to 0$  of the resulting expression.

### C.1 Properties of the function $f(\lambda, \alpha)$

**Lemma 5.** Restricted to values of  $\alpha$  and  $\lambda$  that satisfy  $1 + 2\alpha(\lambda - 1) > 0$ , the function

$$f(\lambda, \alpha) = \frac{1}{\sqrt{1 + \alpha^2 \frac{(\lambda - 1)^2}{1 + 2\alpha\lambda - 2\alpha}}}$$

$$\tag{43}$$

has the following properties: (i) it achieves its maximum value of 1 if and only if  $\lambda = 1$  or  $\alpha = 0$ ; (ii) it is quasi-concave in  $\lambda$  for a fixed  $\alpha$ ; (iii) it is quasi-concave in  $\alpha$  for a fixed  $\lambda$ .

Proof. We have  $f(\lambda, \alpha) = \frac{1}{\sqrt{1 + \alpha^2 \frac{(\lambda - 1)^2}{1 + 2\alpha\lambda - 2\alpha}}}$ . Let C1 be the condition  $1 + 2\alpha\lambda - 2\alpha > 0$  and  $g(\lambda, \alpha) = \alpha^2 \frac{(\lambda - 1)^2}{1 + 2\alpha\lambda - 2\alpha}$  (i.e.  $f(\lambda, \alpha) = \sqrt{\frac{1}{1 + g(\lambda, \alpha)}}$ ).

- 1. C1 implies  $1 + \alpha \lambda \alpha > 0$ . We will call this condition C2. This can be seen by noticing that C2 is equivalent to  $\alpha(\lambda 1) > -1$ , while C1 is equivalent to  $\alpha(\lambda 1) > -1/2$ . Thus, a pair  $(\lambda, \alpha)$  that satisfies C1 must satisfy C2.
- 2.  $f(\lambda, \alpha) \leq 1$ . This can be easily seen by noticing that C1 implies  $g(\lambda, \alpha) \geq 0$ .
- 3.  $f(\lambda, \alpha) = 1$  if  $\lambda = 1$  or  $\alpha = 0$ . This is straightforward to check.
- 4.  $f(\lambda, \alpha)$  is quasi-concave in  $\lambda$  for a fixed  $\alpha$ . We show this by proving that  $g(\lambda, \alpha)$  is quasi-convex in  $\lambda$  for a fixed  $\alpha$ . To do so we compute

$$\frac{\partial g(\lambda, \alpha)}{\partial \lambda} = 2\alpha^2 \frac{(\lambda - 1)(1 + \alpha\lambda - \alpha)}{(1 + 2\alpha\lambda - 2\alpha)^2}.$$
(44)

The denominator is strictly positive by C1, and  $1 + \alpha \lambda - \alpha$  is also strictly positive by C2. Thus, because of the term  $(\lambda - 1)$ , this derivative is strictly negative for  $\lambda < 1$  and strictly positive for  $\lambda > 1$ . Thus,  $g(\lambda, \alpha)$  is decreasing for  $\lambda < 1$  and increasing for  $\lambda > 1$ . Thus,  $f(\lambda, \alpha)$  is increasing for  $\lambda < 1$  and decreasing for  $\lambda > 1$ .

5.  $f(\lambda, \alpha)$  is quasi-concave in  $\alpha$  for a fixed  $\lambda$ . We show this by proving that  $g(\lambda, \alpha)$  is quasi-convex in  $\alpha$  for a fixed  $\lambda$ . To do so we compute

$$\frac{\partial g(\lambda, \alpha)}{\partial \alpha} = 2\alpha \frac{(\lambda - 1)^2 (1 + \alpha \lambda - \alpha)}{(1 + 2\alpha \lambda - 2\alpha)^2}.$$

The denominator is strictly positive by C1, and  $1 + \alpha\lambda - \alpha$  is also strictly positive by C2. Thus, this derivative is strictly negative for  $\alpha < 0$  and strictly positive for  $\alpha > 0$ . Thus,  $g(\lambda, \alpha)$  is decreasing for  $\alpha < 0$  and increasing for  $\alpha > 0$ . Thus,  $f(\lambda, \alpha)$  is increasing for  $\alpha < 0$  and decreasing for  $\alpha > 0$ .

6. Finally, it can be observed that the derivatives are zero if and only if  $\lambda = 1$  or  $\alpha = 0$ . Thus, we can conclude that the maximum value of 1 is achieved if and only if  $\lambda = 1$  or  $\alpha = 0$ .

#### C.2 General Fully-factorized Distributions

**Theorem 1.** Let  $p(z) = \prod_{i=1}^d p_i(z_i)$ ,  $q_w(z) = \prod_{i=1}^d q_{w_i}(z_i)$ , and  $g_\alpha \in \{g_\alpha^{\text{rep}}, g_\alpha^{\text{drep}}\}$ . If  $p_j \neq q_{w_j}$  and  $g_\alpha$  has finite variance, the SNR of the j-th component of the estimator,  $g_{\alpha j}$ , is given by

$$SNR[g_{\alpha j}(p, q_w, \epsilon)] = SNR[g_{\alpha}(p_j, q_{w_j}, \epsilon_j)]$$
(6)

for  $\alpha \to 0$ , and by

 $SNR[g_{\alpha j}(p, q_w, \epsilon)] =$ 

$$SNR\left[g_{\alpha}(p_{j}, q_{w_{j}}, \epsilon_{j})\right] \prod_{\substack{i=1\\i\neq j}}^{d} SNR\left[\tilde{D}_{\alpha}(p_{i}, q_{w_{i}}, \epsilon_{i})\right] \quad (7)$$

for  $\alpha \neq 0$ , where  $\tilde{D}_{\alpha}(p_i, q_{w_i}, \epsilon_i) = \left(\frac{p_i(\mathcal{T}_{w_i}(\epsilon_i))}{q_{w_i}(\mathcal{T}_{w_i}(\epsilon_i))}\right)^{\alpha}$  is an unbiased estimator of  $\alpha(\alpha - 1)D_{\alpha}(p_i||q_{w_i}) + 1$ .

If  $p_j = q_{w_j}$ , the SNR is zero for  $g_{\alpha}^{\text{rep}}$  and is undefined for  $g_{\alpha}^{\text{drep}}$  (because  $g_{\alpha}^{\text{drep}}$  is deterministically zero).

*Proof.* We prove this results for  $g_{\alpha} = g_{\alpha}^{\text{drep}}$ . The proof for  $g_{\alpha} = g_{\alpha}^{\text{rep}}$  follows the same steps. We begin by proving the result for  $\alpha \to 0$ . In this case the gradient estimator is given by

$$g_{\alpha j}(p, q_w, \epsilon) = \nabla_{w_j} \log \frac{p(\mathcal{T}_w(\epsilon))}{q_v(\mathcal{T}_w(\epsilon))}.$$
(45)

Since p and q are factorized

$$g_{\alpha j}(p, q_w, \epsilon) = \left. \nabla_{w_j} \log \frac{p(\mathcal{T}_w(\epsilon))}{q_v(\mathcal{T}_w(\epsilon))} \right|_{v=w}$$
(46)

$$= \left. \nabla_{w_j} \log \frac{p_j(\mathcal{T}_{w_j}(\epsilon_j))}{q_{v_j}(\mathcal{T}_{w_j}(\epsilon_j))} \right|_{v=w} \tag{47}$$

$$= g_{\alpha}(p_j, q_{w_i}, \epsilon_j). \tag{48}$$

Thus, for  $\alpha \to 0$ ,

$$SNR[g_{\alpha j}(p, q_w, \epsilon)] = SNR[g_{\alpha}(p_j, q_{w_j}, \epsilon_j)]. \tag{49}$$

For  $\alpha \neq 0$ , since p and q are factorized, the gradient estimator is given by

$$g_{\alpha j}(p, q_w, \epsilon) = -\frac{1}{\alpha} \nabla_{w_j} \left( \frac{p(\mathcal{T}_w(\epsilon))}{q_v(\mathcal{T}_w(\epsilon))} \right)^{\alpha} \Big|_{v=w}$$
(50)

$$= -\frac{1}{\alpha} \nabla_{w_j} \left( \frac{p_j(\mathcal{T}_{w_j}(\epsilon_j))}{q_{v_j}(\mathcal{T}_{w_j}(\epsilon_j))} \right)^{\alpha} \prod_{i \in \{1, \dots, d\} \setminus j} \left( \frac{p_i(\mathcal{T}_{w_i}(\epsilon_i))}{q_{v_i}(\mathcal{T}_{w_i}(\epsilon_i))} \right)^{\alpha} \right|_{v = v}.$$
 (51)

The SNR of  $g_{\alpha j}(p, q_w, \epsilon)$  is given by  $\mathbb{E}[g_{\alpha j}(p, q_w, \epsilon)]^2/\mathbb{E}[g_{\alpha j}(p, q_w, \epsilon)^2]$ . We compute these quantities as

$$\mathbb{E}[g_{\alpha j}]^2 = \mathbb{E}\left[\frac{-1}{\alpha} \nabla_{w_j} \left(\frac{p_j(\mathcal{T}_{w_j}(\epsilon_j))}{q_{v_j}(\mathcal{T}_{w_j}(\epsilon_j))}\right)^{\alpha} \prod_{i \in \{1, \dots, d\} \setminus j} \left(\frac{p_i(\mathcal{T}_{w_i}(\epsilon_i))}{q_{v_i}(\mathcal{T}_{w_i}(\epsilon_i))}\right)^{\alpha}\right]_{v=w}^2$$
(52)

$$= \mathbb{E}\left[\frac{-1}{\alpha} \nabla_{w_j} \left(\frac{p_j(\mathcal{T}_{w_j}(\epsilon_j))}{q_{v_j}(\mathcal{T}_{w_j}(\epsilon_j))}\right)^{\alpha}\right]^2 \prod_{i \in \{1, \dots, d\} \setminus j} \mathbb{E}\left[\left(\frac{p_i(\mathcal{T}_{w_i}(\epsilon_i))}{q_{v_i}(\mathcal{T}_{w_i}(\epsilon_i))}\right)^{\alpha}\right]_{v=w}^2$$
(53)

$$\mathbb{E}[g_{\alpha j}^2] = \mathbb{E}\left[\left(\frac{-1}{\alpha}\nabla_{w_j}\left(\frac{p_j(\mathcal{T}_{w_j}(\epsilon_j))}{q_{v_j}(\mathcal{T}_{w_j}(\epsilon_j))}\right)^{\alpha}\prod_{i\in\{1,\dots,d\}\setminus j}\left(\frac{p_i(\mathcal{T}_{w_i}(\epsilon_i))}{q_{v_i}(\mathcal{T}_{w_i}(\epsilon_i))}\right)^{\alpha}\right)^2\right]_{v=w_j}$$
(54)

$$= \mathbb{E}\left[\left(\frac{-1}{\alpha}\nabla_{w_j}\left(\frac{p_j(\mathcal{T}_{w_j}(\epsilon_j))}{q_{v_j}(\mathcal{T}_{w_j}(\epsilon_j))}\right)^{\alpha}\right)^2\right] \prod_{i \in \{1, \dots, d\} \setminus j} \mathbb{E}\left[\left(\frac{p_i(\mathcal{T}_{w_i}(\epsilon_i))}{q_{v_i}(\mathcal{T}_{w_i}(\epsilon_i))}\right)^{2\alpha}\right]_{v=w}.$$
 (55)

Finally,

$$SNR[g_{\alpha j}(p, q_w, \epsilon)] = \frac{\mathbb{E}[g_{\alpha j}(p, q_w, \epsilon)]^2}{\mathbb{E}[g_{\alpha j}(p, q_w, \epsilon)^2]}$$
(56)

$$= \frac{\mathbb{E}\left[\frac{-1}{\alpha}\nabla_{w_j}\left(\frac{p_j(\mathcal{T}_{w_j}(\epsilon_j))}{q_{v_j}(\mathcal{T}_{w_j}(\epsilon_j))}\right)^{\alpha}\right]^2}{\mathbb{E}\left[\left(\frac{-1}{\alpha}\nabla_{w_j}\left(\frac{p_j(\mathcal{T}_{w_j}(\epsilon_j))}{q_{v_j}(\mathcal{T}_{w_j}(\epsilon_j))}\right)^{\alpha}\right)^2\right]} \prod_{i \in \{1, \dots, d\} \setminus j} \frac{\mathbb{E}\left[\left(\frac{p_i(\mathcal{T}_{w_i}(\epsilon_i))}{q_{v_i}(\mathcal{T}_{w_i}(\epsilon_i))}\right)^{\alpha}\right]^2}{\mathbb{E}\left[\left(\frac{p_i(\mathcal{T}_{w_i}(\epsilon_i))}{q_{v_i}(\mathcal{T}_{w_i}(\epsilon_i))}\right)^{2\alpha}\right]}$$
(57)

$$= SNR[g_{\alpha j}(p_j, q_{w_j}, \epsilon_j)] \prod_{i \in \{1, \dots, d\} \setminus j} SNR\left[\left(\frac{p_i(\mathcal{T}_{w_i}(\epsilon_i))}{q_{v_i}(\mathcal{T}_{w_i}(\epsilon_i))}\right)^{\alpha}\right].$$
 (58)

Replacing the definition of  $\tilde{D}_{\alpha}$  yields the desired result for  $\alpha \neq 0$ .

To prove the fact that the j-th component of the estimator is deterministically zero if  $p_j = q_{w_j}$  it suffices to observe that, if  $p_j = q_{w_j}$ , then

$$\left. \nabla_{w_j} \frac{p_j(\mathcal{T}_w(\epsilon))}{q_{v_j}(\mathcal{T}_w(\epsilon))} \right|_{v=w} = \left. \nabla_{w_j} \frac{q_{v_j}(\mathcal{T}_w(\epsilon))}{q_{v_j}(\mathcal{T}_w(\epsilon))} \right|_{v=w} = \nabla_{w_j} 1 = 0.$$
 (59)

#### C.3 Fully-factorized Gaussians

In this section we prove our main result for the case where both p and  $q_w$  are mean-zero fully-factorized Gaussians. We begin by proving some auxiliary lemmas for the one-dimensional case, which we then use to prove the main SNR result for d-dimensional factorized Gaussians. In this case the set of parameters w is given by the scales of each dimension of  $q_w$ ,  $w = \{\sigma_{w1}, ..., \sigma_{wd}\}$ .

#### C.3.1 Factorized Gaussians - Auxiliary Lemmas

**Lemma 6.** Let p and  $q_w$  be one dimensional Gaussian distributions with mean zero and scales  $\sigma_p$  and  $\sigma_w$ , respectively. Then, for  $g_\alpha = g_\alpha^{\text{drep}}$  and  $\alpha \to 0$ ,

- If  $\sigma_p = \sigma_w$ , the gradient estimator is deterministically zero.
- Otherwise,

$$SNR[g_{\alpha}(p, q_w, \epsilon)] = \frac{1}{3}.$$
(60)

*Proof.* Using the fact that  $\mathcal{T}_w(\epsilon) = \sigma_w \epsilon$  and the pdf of Gaussian distributions we can compute the gradient estimator for  $\alpha \to 0$  as

$$g_{\alpha j}(p, q_w, \epsilon) = \left. \nabla_w \log \frac{q_v(\mathcal{T}_w(\epsilon))}{p(\mathcal{T}_w(\epsilon))} \right|_{v=w} \tag{61}$$

$$= \left. \nabla_w \left( \log \frac{\sigma_v}{\sigma_p} - \frac{1}{2} \sigma_w^2 \epsilon^2 \left( \frac{1}{\sigma_v^2} - \frac{1}{\sigma_p^2} \right) \right) \right|_{v=w} \tag{62}$$

$$= -\sigma_w \epsilon^2 \left( \frac{1}{\sigma_w^2} - \frac{1}{\sigma_p^2} \right). \tag{63}$$

If  $\sigma_p = \sigma_w$  the gradient estimator is deterministically zero. Otherwise, using the fact that  $\epsilon \sim \mathcal{N}(0,1)$ , we can compute

$$\mathbb{E}[g_{\alpha j}(p, q_w, \epsilon)]^2 = \sigma_w^2 \left(\frac{1}{\sigma_w^2} - \frac{1}{\sigma_p^2}\right)^2 \tag{64}$$

$$\mathbb{E}[g_{\alpha j}(p, q_w, \epsilon)^2] = 3\sigma_w^2 \left(\frac{1}{\sigma_w^2} - \frac{1}{\sigma_p^2}\right)^2.$$
(65)

Thus, if  $\sigma_w \neq \sigma_p$ , we get  $SNR[g_{\alpha}(p, q_w, \epsilon)] = \frac{1}{3}$ .

**Lemma 7.** Let p and  $q_w$  be one dimensional Gaussian distributions with mean zero and scales  $\sigma_p$  and  $\sigma_w$ , respectively. Let  $\lambda = \sigma_w^2/\sigma_p^2$ . Then, for  $g_\alpha = g_\alpha^{\text{drep}}$  and  $\alpha \neq 0$ ,

• If  $1 + 2\alpha\lambda - 2\alpha > 0$ , then

$$SNR\left[\left(\frac{p(\mathcal{T}_w(\epsilon))}{q_w(\mathcal{T}_w(\epsilon))}\right)^{\alpha}\right] = f(\lambda, \alpha), \tag{66}$$

where  $f(\lambda, \alpha) = 1/\sqrt{1+\alpha^2 \frac{(\lambda-1)^2}{1+2\alpha\lambda-2\alpha}}$ .

• If  $1 + 2\alpha\lambda - 2\alpha < 0$ , the SNR is not defined.

*Proof.* Using the pdf of a univariate Gaussian, we can compute

$$\left(\frac{p(\mathcal{T}_w(\epsilon))}{q_w(\mathcal{T}_w(\epsilon))}\right)^{\alpha} = \left(\frac{\sigma_w}{\sigma_p}\right)^{\alpha} \exp\left[-\frac{\alpha}{2}\sigma_w^2\epsilon^2\left(\frac{1}{\sigma_p^2} - \frac{1}{\sigma_w^2}\right)\right].$$
(67)

To compute the SNR we need to compute  $\mathbb{E}\left[\left(\frac{p(\mathcal{T}_w(\epsilon))}{q_w(\mathcal{T}_w(\epsilon))}\right)^{\alpha}\right]^2$  and  $\mathbb{E}\left[\left(\frac{p(\mathcal{T}_w(\epsilon))}{q_w(\mathcal{T}_w(\epsilon))}\right)^{2\alpha}\right]$ . The former can be computed as

$$\mathbb{E}\left[\left(\frac{p(\mathcal{T}_w(\epsilon))}{q_w(\mathcal{T}_w(\epsilon))}\right)^{\alpha}\right] = \left(\frac{\sigma_w}{\sigma_p}\right)^{\alpha} \int \frac{1}{\sqrt{2\pi}} \exp\left[-\frac{\epsilon^2}{2}\right] \exp\left[-\frac{\alpha}{2}\sigma_w^2 \epsilon^2 \left(\frac{1}{\sigma_p^2} - \frac{1}{\sigma_w^2}\right)\right] d\epsilon \tag{68}$$

$$= \left(\frac{\sigma_w}{\sigma_p}\right)^{\alpha} \int \frac{1}{\sqrt{2\pi}} \exp\left[-\frac{1}{2}\epsilon^2 \left(1 + \alpha \frac{\sigma_w^2}{\sigma_p^2} - \alpha\right)\right] d\epsilon \tag{69}$$

$$= \lambda^{\alpha/2} \int \frac{1}{\sqrt{2\pi}} \exp\left[-\frac{1}{2}\epsilon^2 \left(1 + \alpha\lambda - \alpha\right)\right] d\epsilon. \tag{70}$$

This integral converges if and only if  $1 + \alpha \lambda - \alpha > 0$ . If this is not satisfied, the quantity does not have an expectation and the SNR is not defined. If the condition is satisfied, then

$$\mathbb{E}\left[\left(\frac{p(\mathcal{T}_w(\epsilon))}{q_w(\mathcal{T}_w(\epsilon))}\right)^{\alpha}\right] = \frac{\lambda^{\alpha/2}}{\sqrt{1 + \alpha\lambda - \alpha}}.$$
(71)

With this result we get

$$\mathbb{E}\left[\left(\frac{p(\mathcal{T}_w(\epsilon))}{q_w(\mathcal{T}_w(\epsilon))}\right)^{\alpha}\right]^2 = \frac{\lambda^{\alpha}}{1 + \alpha\lambda - \alpha}$$
(72)

$$\mathbb{E}\left[\left(\frac{p(\mathcal{T}_w(\epsilon))}{q_w(\mathcal{T}_w(\epsilon))}\right)^{2\alpha}\right] = \frac{\lambda^{\alpha}}{\sqrt{1 + 2\alpha\lambda - 2\alpha}},\tag{73}$$

where eq. 73 is obtained by replacing  $\alpha$  by  $2\alpha$  in eq. 71 (notice that the condition for existence now becomes  $1 + 2\alpha\lambda - 2\alpha > 0$ ). Finally, we can compute the SNR by taking the ratio between the above quantities, which yields

$$SNR\left[\left(\frac{p(\mathcal{T}_w(\epsilon))}{q_w(\mathcal{T}_w(\epsilon))}\right)^{\alpha}\right] = \frac{\sqrt{1 - 2\alpha + 2\alpha\lambda}}{1 - \alpha + \alpha\lambda}$$
(74)

$$=\sqrt{\frac{1}{\frac{(1+\alpha\lambda-\alpha)^2}{1+2\alpha\lambda-2\alpha}}}\tag{75}$$

$$= \sqrt{\frac{1}{\frac{1+\alpha^2\lambda^2+\alpha^2+2\alpha\lambda-2\alpha-2\alpha^2\lambda}{1+2\alpha\lambda-2\alpha}}}$$
(76)

$$=\sqrt{\frac{1}{1+\alpha^2 \frac{(\lambda-1)^2}{1+2\alpha\lambda-2\alpha}}}\tag{77}$$

$$= f(\lambda, \alpha). \tag{78}$$

Finally, the condition  $1 + \alpha\lambda - \alpha > 0$  does not show up in the theorem statement because it is less restrictive than the condition  $1 + 2\alpha\lambda - 2\alpha > 0$  (i.e. the latter is a sufficient but not necessary condition for the former). To see this, note that the former is equivalent to  $\alpha(\lambda - 1) > -1$ , while the latter is equivalent to  $\alpha(\lambda - 1) > -1/2$ . Thus, any pair  $(\lambda, \alpha)$  that satisfies  $1 + 2\alpha\lambda - 2\alpha > 0$  also satisfies  $1 + \alpha\lambda - \alpha > 0$ . The inverse is not true.  $\Box$ 

**Lemma 8.** Let p and  $q_w$  be one dimensional Gaussian distributions with mean zero and scales  $\sigma_p$  and  $\sigma_w$ , respectively. Let  $\lambda = \sigma_w^2/\sigma_p^2$ . Then, for  $g_\alpha = g_\alpha^{\rm drep}$  and  $\alpha \neq 0$ ,

• If  $\sigma_p = \sigma_w$ , the gradient estimator is deterministically zero.

- If  $1 + 2\alpha\lambda 2\alpha \leq 0$ , the gradient estimator's SNR is not defined.
- Otherwise.

$$SNR[g_{\alpha}(p, q_w, \epsilon)] = \frac{1 + 2\alpha\lambda - 2\alpha}{3} f(\lambda, \alpha)^3, \tag{79}$$

where  $f(\lambda, \alpha) = 1/\sqrt{1+\alpha^2 \frac{(\lambda-1)^2}{1+2\alpha\lambda-2\alpha}}$ .

*Proof.* For  $\alpha \neq 0$  we have  $g_{\alpha}(p, q_w, \epsilon) = -\frac{1}{\alpha} \nabla_w \left( \frac{p(\mathcal{T}_w(\epsilon))}{q_v(\mathcal{T}_w(\epsilon))} \right)^{\alpha}$ . We can get an expression for the gradient estimate by first computing

$$\left(\frac{p(\mathcal{T}_w(\epsilon))}{q_v(\mathcal{T}_w(\epsilon))}\right)^{\alpha} = \left(\frac{\sigma_v}{\sigma_p}\right)^{\alpha} \exp\left[-\frac{\alpha}{2}\sigma_w^2\epsilon^2\left(\frac{1}{\sigma_p^2} - \frac{1}{\sigma_v^2}\right)\right].$$
(80)

Thus,

$$g_{\alpha}(p, q_w, \epsilon) = \left(\frac{\sigma_w}{\sigma_p}\right)^{\alpha} \exp\left[-\frac{\alpha}{2}\sigma_w^2 \epsilon^2 \left(\frac{1}{\sigma_p^2} - \frac{1}{\sigma_w^2}\right)\right] \epsilon^2 \sigma_w \left(\frac{1}{\sigma_p^2} - \frac{1}{\sigma_v^2}\right). \tag{81}$$

It can be observed that, if  $\sigma_w = \sigma_p$ , the gradient estimator is deterministically zero. Otherwise, to compute the SNR we need to compute  $\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)]$  and  $\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)^2]$ . For the former, we can compute

$$\mathbb{E}[g_{\alpha}(p, q_{w}, \epsilon)] = \left(\frac{\sigma_{w}}{\sigma_{p}}\right)^{\alpha} \sigma_{w} \left(\frac{1}{\sigma_{p}^{2}} - \frac{1}{\sigma_{w}^{2}}\right) \int \frac{\epsilon^{2}}{\sqrt{2\pi}} \exp\left[-\frac{\epsilon^{2}}{2}\right] \exp\left[-\frac{\alpha}{2}\sigma_{w}^{2}\epsilon^{2}\left(\frac{1}{\sigma_{p}^{2}} - \frac{1}{\sigma_{w}^{2}}\right)\right] d\epsilon \tag{82}$$

$$= \left(\frac{\sigma_w}{\sigma_p}\right)^{\alpha} \sigma_w \left(\frac{1}{\sigma_p^2} - \frac{1}{\sigma_w^2}\right) \int \frac{\epsilon^2}{\sqrt{2\pi}} \exp\left[-\frac{\epsilon^2}{2} \left(1 + \frac{\alpha \sigma_w^2}{\sigma_p^2} - \alpha\right)\right] d\epsilon \tag{83}$$

$$= \lambda^{\alpha/2} \sigma_w \left( \frac{1}{\sigma_p^2} - \frac{1}{\sigma_w^2} \right) \int \frac{\epsilon^2}{\sqrt{2\pi}} \exp\left[ -\frac{\epsilon^2}{2} \left( 1 + \alpha \lambda - \alpha \right) \right] d\epsilon.$$
 (84)

This integral converges if and only if  $1 + \alpha R - \alpha > 0$ . If so,

$$\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)] = \lambda^{\alpha/2} \sigma_q \left(\frac{1}{\sigma_p^2} - \frac{1}{\sigma_w^2}\right) \frac{1}{(1 + \alpha\lambda - \alpha)^{3/2}}.$$
 (85)

Thus, we get

$$\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)]^2 = \lambda^{\alpha} \sigma_q^2 \left(\frac{1}{\sigma_p^2} - \frac{1}{\sigma_w^2}\right)^2 \frac{1}{(1 + \alpha\lambda - \alpha)^3}.$$
 (86)

We now need to compute  $\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)^2]$ . Using eq. 81 we get

$$g_{\alpha}(p, q_w, \epsilon)^2 = \left(\frac{\sigma_w}{\sigma_p}\right)^{2\alpha} \exp\left[-\alpha \sigma_w^2 \epsilon^2 \left(\frac{1}{\sigma_p^2} - \frac{1}{\sigma_w^2}\right)\right] \epsilon^4 \sigma_w^2 \left(\frac{1}{\sigma_p^2} - \frac{1}{\sigma_w^2}\right)^2. \tag{87}$$

The expectation of the term above can be computed as

$$\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)^2] = \left(\frac{\sigma_w}{\sigma_p}\right)^{2\alpha} \sigma_w^2 \left(\frac{1}{\sigma_p^2} - \frac{1}{\sigma_w^2}\right)^2 \int \frac{\epsilon^4}{\sqrt{2\pi}} \exp\left[\frac{-\epsilon^2}{2}\right] \exp\left[-\alpha \sigma_w^2 \epsilon^2 \left(\frac{1}{\sigma_p^2} - \frac{1}{\sigma_w^2}\right)\right] d\epsilon \tag{88}$$

$$= \left(\frac{\sigma_w}{\sigma_p}\right)^{2\alpha} \sigma_w^2 \left(\frac{1}{\sigma_p^2} - \frac{1}{\sigma_w^2}\right)^2 \int \frac{\epsilon^4}{\sqrt{2\pi}} \exp\left[-\frac{\epsilon^2}{2} \left(1 + 2\frac{\alpha\sigma_w^2}{\sigma_p^2} - 2\alpha\right)\right] d\epsilon \tag{89}$$

$$= \lambda^{\alpha} \sigma_w^2 \left( \frac{1}{\sigma_p^2} - \frac{1}{\sigma_w^2} \right)^2 \int \frac{\epsilon^4}{\sqrt{2\pi}} \exp\left[ -\frac{\epsilon^2}{2} \left( 1 + 2\alpha\lambda - 2\alpha \right) \right] d\epsilon. \tag{90}$$

This integral converges if and only if  $1 + 2\alpha\lambda - 2\alpha > 0$ . If so,

$$\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)^2] = \lambda^{\alpha} \sigma_q^2 \left(\frac{1}{\sigma_p^2} - \frac{1}{\sigma_w^2}\right)^2 \frac{3}{(1 + 2\alpha\lambda - 2\alpha)^{5/2}}.$$
(91)

Finally,

$$SNR[g_{\alpha}(p, q_{w}, \epsilon)] = \frac{1 + 2\alpha\lambda - 2\alpha}{3} \left(\frac{\sqrt{1 + 2\alpha\lambda - 2\alpha}}{1 - \alpha\lambda - \alpha}\right)^{3}$$
(92)

$$=\frac{1+2\alpha\lambda-2\alpha}{3}f(\lambda,\alpha)^3,\tag{93}$$

where we followed the same algebraic manipulations as in the proof of lemma 7 to get the final expression in terms of  $f(\lambda, \alpha)$ .

#### C.3.2 Factorized Gaussians - Main Result

Corollary 2. Let p and q be two fully-factorized d-dimensional Gaussian distributions with mean zero and variances  $\sigma_{pi}^2$  and  $\sigma_{qi}^2$ . Let  $\lambda_i = \sigma_{qi}^2/\sigma_{pi}^2$  and  $g_{\alpha} = g_{\alpha}^{\text{drep}}$ .

If  $\lambda_j \neq 1$  and  $1 + 2\alpha(\lambda_i - 1) > 0$  for all i,

 $SNR[g_{\alpha j}(p, q_w, \epsilon)] =$ 

$$\underbrace{\frac{1 + 2\alpha(\lambda_j - 1)}{3} f(\lambda_j, \alpha)^3}_{\text{SNR}\left[g_{\alpha}(p_j, q_{w_i}, \epsilon_j)\right]} \prod_{\substack{i=1\\i \neq j}}^{d} \underbrace{f(\lambda_i, \alpha)}_{\text{SNR}\left[\tilde{D}_{\alpha}(p_i, q_{w_i}, \epsilon_i)\right]} (9)$$

where

$$f(\lambda, \alpha) = \frac{1}{\sqrt{1 + \alpha^2 \frac{(\lambda - 1)^2}{1 + 2\alpha(\lambda - 1)}}}.$$
(10)

Otherwise, the SNR is not defined. If  $\lambda_j = 1$  this is because the estimator  $g_{\alpha j}$  is zero deterministically. If  $1 + 2\alpha(\lambda_i - 1) \leq 0$  for any i, this is because the estimator has infinite variance.

#### C.4 Full-rank Gaussians

In this section we prove our main results for the case where both p and  $q_w$  are d-dimensional mean-zero Gaussians with arbitrary covariance matrices  $\Sigma_p$  and  $\Sigma_w$ , respectively. In this case the set of parameters w is given by the some factorization of the covariance  $S_w$  such that  $S_w S_w^{\top} = \Sigma_w$ . In this case the gradients  $\nabla_w$  are computed with respect  $S_w$ , and thus have shape  $d \times d$ . Thus, the SNR is defined in terms of the Frobenius norm  $\|\cdot\|_F$ , that is

$$SNR[g_{\alpha}(p, q_w, \epsilon)] = \frac{\|\mathbb{E} g_{\alpha}(p, q_w, \epsilon)\|_F^2}{\mathbb{E} \|g_{\alpha}(p, q_w, \epsilon)\|_F^2}.$$
(94)

We begin by showing a proof for the case  $\alpha \to 0$ .

**Lemma 9.** Let  $p(z) = \mathcal{N}(z|0, \Sigma_p)$  and  $q(z) = \mathcal{N}(z|0, \Sigma_w)$ . Also, let  $S_w$  be a matrix such that  $S_w S_w^{\top} = \Sigma_w$ , which we use to reparameterize as  $\mathcal{T}_w(\epsilon) = S_w \epsilon$ . Then, for  $g_{\alpha} = g_{\alpha}^{\text{drep}}$  and  $\alpha \to 0$ ,

- If  $\Sigma_p = \Sigma_w$ , the gradient estimator is deterministically zero.
- Otherwise,

$$SNR[g_{\alpha}(p, q_w, \epsilon)] = \frac{1}{d+2}, \tag{95}$$

where d is the dimension of z.

*Proof.* We begin by computing the gradient estimator  $g_{\alpha}(p, q_w, \epsilon)$ . Using the pdf of a mean-zero multivariate normal and the reparameterization transformation  $\mathcal{T}_w(\epsilon) = S_w \epsilon$  we get

$$g_{\alpha}(p, q_w, \epsilon) = \left. \nabla_w \log \frac{p(\mathcal{T}_w(\epsilon))}{q_v(\mathcal{T}_w(\epsilon))} \right|_{v=w} \tag{96}$$

$$= \left. \nabla_w \left( \log \sqrt{\frac{\det \Sigma_p}{\det \Sigma_v}} - \frac{1}{2} \epsilon^\top S_w^\top (\Sigma_v^{-1} - \Sigma_p^{-1}) S_w \epsilon \right) \right|_{v=0}$$
(97)

$$= -\frac{1}{2} \nabla_w \epsilon^\top S_w^\top (\Sigma_v^{-1} - \Sigma_p^{-1}) S_w \epsilon \bigg|_{v=w}$$

$$(98)$$

$$= -(\Sigma_w^{-1} - \Sigma_p^{-1}) S_w \epsilon \epsilon^{\top} \tag{99}$$

$$= -B\epsilon\epsilon^{\mathsf{T}},\tag{100}$$

where in the last line we defined  $B = (\Sigma_w^{-1} - \Sigma_p^{-1})S$ . It can be observed that the estimator is deterministically zero if  $\Sigma_p = \Sigma_w$ . Otherwise, to compute the SNR we have to compute  $\|\mathbb{E} g_{\alpha}(p, q_w, \epsilon)\|^2$  and  $\mathbb{E} \|g_{\alpha}(p, q_w, \epsilon)\|^2$ . Using the fact that  $\epsilon$  follows a d-dimensional standard Gaussian, the former can be computed as

$$\mathbb{E}[g_{\alpha}(p, q_{w}, \epsilon)] = -B \quad \text{and} \quad \|\mathbb{E}[g_{\alpha}(p, q_{w}, \epsilon)]\|_{F}^{2} = \|B\|_{F}^{2}. \tag{101}$$

Computing  $\mathbb{E} \|g_{\alpha}(p, q_w, \epsilon)\|_F^2$  requires more work. We will first consider the expected squared norm of a single component ij of  $g_{\alpha}(p, q_w, \epsilon)$ , that is  $\mathbb{E} g_{\alpha}(p, q_w, \epsilon)_{ij}^2$ , and then add all of the results. We have

$$g_{\alpha}(p, q_w, \epsilon)_{ij} = (-B\epsilon\epsilon^{\top})_{ij} \tag{102}$$

$$= -\sum_{k=1}^{d} B_{ik} \epsilon_k \epsilon_j, \tag{103}$$

$$g_{\alpha}(p, q_w, \epsilon)_{ij}^2 = \sum_{l=1}^d \sum_{k=1}^d B_{ik} B_{il} \epsilon_k \epsilon_l \epsilon_j^2.$$
(104)

Using the fact that  $\epsilon = [\epsilon_1, ..., \epsilon_d]$  follows a multivariate standard Gaussian, we can compute  $\mathbb{E} g_{\alpha}(p, q_w, \epsilon)_{ij}^2$  as

$$\mathbb{E} g_{\alpha}(p, q_w, \epsilon)_{ij}^2 = \sum_{k,l} B_{ik} B_{il} \, \mathbb{E}[\epsilon_k \epsilon_l \epsilon_j^2]$$
(105)

$$= \sum_{k,l} B_{ik} B_{il} \left( \mathbb{1}_{k=l} + 2 \mathbb{1}_{j=k} \mathbb{1}_{j=l} \right)$$
 (106)

$$=\sum_{k}B_{ik}^{2}+2B_{ij}^{2}. (107)$$

Finally, adding the results for all components ij yields

$$\mathbb{E} \|g_{\alpha}(p, q_w, \epsilon)\|_F^2 = \sum_{ij} \mathbb{E}[g_{\alpha}(p, q_w, \epsilon)_{ij}^2]$$
(108)

$$=2\sum_{ij}B_{ij}^2 + \sum_{ijk}B_{ik}^2 \tag{109}$$

$$=2\sum_{ij}B_{ij}^{2}+d\sum_{ik}B_{ik}^{2}$$
(110)

$$= (2+d)\sum_{ij} B_{ij}^2 \tag{111}$$

$$= (2+d)||B||_F^2. (112)$$

Taking the ratio between the expressions for  $\mathbb{E} \|g_{\alpha}(p, q_w, \epsilon)\|_F^2$  and  $\|\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)]\|_F^2$  yields the desired result.  $\square$  **Theorem 4.** Take the setting of Theorem 3 with  $\Sigma_p \neq \Sigma_q$  and  $1 + 2\alpha(\lambda_i - 1) > 0$  for all i. Let S be a matrix such that  $\Sigma_q = SS^{\top}$  and let  $\alpha \neq 0$ . Then,

$$SNR[g_{\alpha}(p, q_{w}, \epsilon)] = \frac{\|BU^{-1}\|_{F}^{2} \times \prod_{i=1}^{d} f(\lambda_{i}, \alpha)}{\operatorname{tr}(V^{-1})\operatorname{tr}(BV^{-1}B^{\top}) + 2\|BV^{-1}\|_{F}^{2}},$$

where  $B = (\Sigma_p^{-1} - \Sigma_q^{-1})S$ ,  $U = (1 - \alpha)I + \alpha S^{\top} \Sigma_p^{-1} S$ , and  $V = (1 - 2\alpha)I + 2\alpha S^{\top} \Sigma_p^{-1} S$ .

*Proof.* We split the proof into several steps:

1. We begin by finding an expression for the gradient estimator. Using the fact that both p and q are mean-zero multivariate Gaussians we get

$$g_{\alpha}(p, q_w, \epsilon) = -\frac{1}{\alpha} \nabla_w \left( \frac{p(\mathcal{T}_w(\epsilon))}{q_v(\mathcal{T}_w(\epsilon))} \right)^{\alpha} \Big|_{v=w}$$
(113)

$$= -\frac{1}{\alpha} \nabla_w \left( \frac{\det \Sigma_v}{\det \Sigma_p} \right)^{\alpha/2} \exp \left[ -\frac{\alpha}{2} \epsilon^\top S_w^\top (\Sigma_p^{-1} - \Sigma_w^{-1}) S \epsilon \right]$$
(114)

$$= \left(\frac{\det \Sigma_w}{\det \Sigma_p}\right)^{\alpha/2} \exp\left[-\frac{\alpha}{2} \epsilon^\top S_w^\top (\Sigma_p^{-1} - \Sigma_w^{-1}) S_w \epsilon\right] (\Sigma_p^{-1} - \Sigma_w^{-1}) S_w \epsilon \epsilon^\top. \tag{115}$$

It can be observed that if  $\Sigma_p = \Sigma_w$  the gradient estimator is deterministically zero.

2. We compute  $\mathbb{E} \|g_{\alpha}(p, q_w, \epsilon)\|_F^2$ . Using the definitions for B and U we can compute  $\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)]$  as

$$\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)] = \left(\frac{\det \Sigma_w}{\det \Sigma_p}\right)^{\alpha/2} \int \frac{1}{(2\pi)^{d/2}} \exp\left[-\frac{1}{2}\epsilon^{\top}\epsilon\right] \exp\left[-\frac{1}{2}\epsilon^{\top}(U - I)\epsilon\right] B\epsilon\epsilon^{\top} d\epsilon \tag{116}$$

$$= \left(\frac{\det \Sigma_w}{\det \Sigma_p}\right)^{\alpha/2} B \int \frac{1}{(2\pi)^{d/2}} \exp\left[-\frac{1}{2} \epsilon^\top U \epsilon\right] \epsilon \epsilon^\top d\epsilon. \tag{117}$$

This integral converges if and only if U is positive definite. If this is satisfied, then

$$\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)] = \left(\frac{\det \Sigma_w}{\det \Sigma_p}\right)^{\alpha/2} \sqrt{\det(U^{-1})} B \int \frac{1}{(2\pi)^{d/2} \sqrt{\det(U^{-1})}} \exp\left[-\frac{1}{2} \epsilon^{\top} U \epsilon\right] \epsilon \epsilon^{\top} d\epsilon \tag{118}$$

$$= \left(\frac{\det \Sigma_w}{\det \Sigma_p}\right)^{\alpha/2} \frac{1}{\sqrt{\det U}} B U^{-1},\tag{119}$$

and

$$\|\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)]\|_F^2 = \left(\frac{\det \Sigma_w}{\det \Sigma_p}\right)^{\alpha} \frac{1}{\det U} \|BU^{-1}\|_F^2.$$
(120)

3. We compute  $\mathbb{E} \|g_{\alpha}(p, q_w, \epsilon)\|_F^2$ . Computing  $\mathbb{E} \|g_{\alpha}(p, q_w, \epsilon)\|_F^2$  requires more work. We first compute  $\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)_{ij}^2]$  for each component ij of  $g_{\alpha}$  and then add up all the results. Recall, the gradient estimator is given by

$$g_{\alpha}(p, q_w, \epsilon) = \left(\frac{\det \Sigma_w}{\det \Sigma_p}\right)^{\alpha/2} \exp\left[-\frac{\alpha}{2} \epsilon^{\top} S^{\top} (\Sigma_p^{-1} - \Sigma_w^{-1}) S \epsilon\right] B \epsilon \epsilon^{\top}.$$
 (121)

Thus, component ij of the estimator, that is,  $g_{\alpha}(p, q_w, \epsilon)_{ij}$ , is given by

$$g_{\alpha}(p, q_w, \epsilon)_{ij} = \left(\frac{\det \Sigma_w}{\det \Sigma_p}\right)^{\alpha/2} \exp\left[-\frac{\alpha}{2} \epsilon^{\top} S_w^{\top} (\Sigma_p^{-1} - \Sigma_w^{-1}) S_w \epsilon\right] \sum_{k=1}^d B_{ik} \epsilon_k \epsilon_j, \tag{122}$$

and  $g_{\alpha}(p, q_w, \epsilon)_{ij}^2$  is given by

$$g_{\alpha}(p, q_w, \epsilon)_{ij}^2 = \left(\frac{\det \Sigma_w}{\det \Sigma_p}\right)^{\alpha} \exp\left[-\alpha \epsilon^{\top} S_w^{\top} (\Sigma_p^{-1} - \Sigma_w^{-1}) S_w \epsilon\right] \sum_{k, l=1}^d B_{ik} B_{ik} \epsilon_k \epsilon_l \epsilon_j^2.$$
 (123)

Using the definition for V, and using the fact that  $\epsilon$  follows a multivariate standard Gaussian distribution, we can compute  $\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)_{ij}^2]$  as

$$\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)_{ij}^2] \tag{124}$$

$$= \left(\frac{\det \Sigma_w}{\det \Sigma_p}\right)^{\alpha} \int \frac{1}{(2\pi)^{d/2}} \exp\left[-\frac{1}{2}\epsilon^{\top}\epsilon\right] \exp\left[-\alpha\epsilon^{\top} S_w^{\top} (\Sigma_p^{-1} - \Sigma_w^{-1}) S_w \epsilon\right] \sum_{k,l=1}^d B_{ik} \epsilon_k \epsilon_l \epsilon_j^2$$
(125)

$$= \left(\frac{\det \Sigma_w}{\det \Sigma_p}\right)^{\alpha} \int \frac{1}{(2\pi)^{d/2}} \exp\left[-\frac{1}{2} \epsilon^{\top} V \epsilon\right] \sum_{k,l=1}^d B_{ik} \epsilon_k \epsilon_l \epsilon_j^2$$
(126)

$$= \left(\frac{\det \Sigma_w}{\det \Sigma_p}\right)^{\alpha} \sum_{k,l=1}^d B_{il} B_{ik} \int \frac{1}{(2\pi)^{d/2}} \exp\left[-\frac{1}{2} \epsilon^{\top} V \epsilon\right] \epsilon_k \epsilon_l \epsilon_j^2. \tag{127}$$

The integrals converge if and only if V is positive definite. If this is satisfied, then

$$\mathbb{E}[g_{\alpha}(p, q_w, \epsilon)_{ij}^2] \tag{128}$$

$$= \left(\frac{\det \Sigma_w}{\det \Sigma_p}\right)^{\alpha} \frac{1}{\sqrt{\det V}} \sum_{k,l=1}^d B_{il} B_{ik} \int \frac{1}{(2\pi)^{d/2} \sqrt{\det(V^{-1})}} \exp\left[-\frac{1}{2} \epsilon^{\top} V \epsilon\right] \epsilon_k \epsilon_l \epsilon_j^2$$
(129)

$$= \left(\frac{\det \Sigma_w}{\det \Sigma_p}\right)^{\alpha} \frac{1}{\sqrt{\det V}} \sum_{k|l=1}^d B_{il} B_{ik} \left(V_{jj}^{-1} V_{kl}^{-1} + 2V_{kj}^{-1} V_{lj}^{-1}\right), \tag{130}$$

where  $V_{ij}^{-1}$  is component ij of matrix  $V^{-1}$ . Finally, we compute  $\mathbb{E} \|g_{\alpha}(p, q_w, \epsilon)\|_F^2 = \sum_{ij} \mathbb{E}[g_{\alpha}(p, q_w, \epsilon)_{ij}^2]$ , which gives

$$\mathbb{E} \|g_{\alpha}(p, q_{w}, \epsilon)\|_{F}^{2} = \left(\frac{\det \Sigma_{w}}{\det \Sigma_{p}}\right)^{\alpha} \frac{1}{\sqrt{\det V}} \sum_{i, j, k, l=1}^{d} B_{il} B_{ik} \left(V_{jj}^{-1} V_{kl}^{-1} + 2V_{kj}^{-1} V_{lj}^{-1}\right). \tag{131}$$

4. We work on eq. 131. For this we use the notation  $B_{i:}$ , which denotes the *i*-th row of B. First,

$$\sum_{ij} \sum_{kl} B_{il} B_{ik} V_{jj}^{-1} V_{kl}^{-1} = \sum_{ij} V_{jj}^{-1} \sum_{kl} B_{ik} V_{kl}^{-1} B_{il}$$
(132)

$$= \sum_{ij} V_{jj}^{-1} (B_{i:}^{\top} V^{-1} B_{i:})$$
 (133)

$$= \sum_{ij} V_{jj}^{-1} (B^{\top} V^{-1} B)_{ii}$$
 (134)

$$= \sum_{i} V_{jj}^{-1} \sum_{i} (B^{\top} V^{-1} B)_{ii}$$
 (135)

$$= \operatorname{tr}(V^{-1})\operatorname{tr}(B^{\top}V^{-1}B). \tag{136}$$

Second,

$$\sum_{ijkl} B_{il} B_{ik} V_{kj}^{-1} V_{lj}^{-1} = \sum_{ij} \sum_{kl} B_{il} B_{ik} V_{kj}^{-1} V_{lj}^{-1}$$
(137)

$$= \sum_{ij} \left( \sum_{k} B_{ik} V_{kj}^{-1} \right) \left( \sum_{l} B_{il} V_{lj}^{-1} \right)$$
 (138)

$$=\sum_{ij} \left(\sum_{k} B_{ik} V_{kj}^{-1}\right)^2 \tag{139}$$

$$= \sum_{ij} \left( B_{i:} V_{:j}^{-1} \right)^2 \tag{140}$$

$$=\sum_{ij} \left(BV^{-1}\right)_{ij}^2 \tag{141}$$

$$= \|BV^{-1}\|_F^2. (142)$$

Using these two results we get

$$\mathbb{E} \|g_{\alpha}(p, q_w, \epsilon)\|_F^2 = \left(\frac{\det \Sigma_w}{\det \Sigma_p}\right)^{\alpha} \frac{1}{\sqrt{\det V}} \left(\operatorname{tr}(V^{-1})\operatorname{tr}(B^{\top}V^{-1}B) + 2\|BV^{-1}\|_F^2\right). \tag{143}$$

5. Taking the ratio between  $\|\mathbb{E} g_{\alpha}(p, q_w, \epsilon)\|_F^2$  and  $\mathbb{E} \|g_{\alpha}(p, q_w, \epsilon)\|_F^2$  yields

$$SNR[g_{\alpha}(p, q_{w}, \epsilon)] = \frac{\sqrt{\det V}}{\det U} \frac{\|BU^{-1}\|_{F}^{2}}{\operatorname{tr}(V^{-1})\operatorname{tr}(BV^{-1}B^{\top}) + 2\|BV^{-1}\|_{F}^{2}}.$$
 (144)

6. We prove the eigenvalues  $\lambda_1, ..., \lambda_d$  of  $\Sigma_p^{-1} \Sigma_w$  are all real and positive. This can be seen by noticing that  $\Sigma_p^{-1} \Sigma_w$  is similar to the matrix  $S^{\top} \Sigma_p^{-1} S^{.3}$ . These latter matrix is symmetric and positive definite, and thus its eigenvalues are real and positive. Since similar matrices have the same eigenvalues, it can be concluded that  $\lambda_1, ..., \lambda_d$  are real and positive.

 $<sup>\</sup>overline{{}^{3}S_{w}^{-\top}(S_{w}^{\top}\Sigma_{p}^{-1}S_{w})S_{w}^{\top}} = \Sigma_{p}^{-1}S_{w}S_{w}^{\top} = \Sigma_{p}^{-1}\Sigma_{w}.$ 

- 7. The first condition for existence of the SNR that requires that  $U = (1-\alpha)I + \alpha S_w^{\top} \Sigma_p^{-1} S_w$  is positive definite can be rewritten as  $1 \alpha + \alpha \lambda_i > 0$  for i = 1, ..., d. Since  $S_w^{\top} \Sigma_p^{-1} S_w$  is similar to  $\Sigma_p^{-1} \Sigma_w$ ,  $S_w^{\top} \Sigma_p^{-1} S_w$  eigenvalues are  $\lambda_1, ..., \lambda_d$ . Therefore, U's i-th eigenvalue is  $\lambda_i(U) = 1 \alpha + \alpha \lambda_i$ . Since U must be positive definite (i.e. all its eigenvalues are positive) we get the conditions  $1 \alpha + \alpha \lambda_i > 0$  for all i.
- 8. The second condition for existence of the SNR that requires that  $V = (1-2\alpha)I + 2\alpha S_w^{\top} \Sigma_p^{-1} S_w$  is positive definite can be rewritten as  $1-2\alpha+2\alpha\lambda_i>0$  for i=1,...,d. Since  $S_w^{\top} \Sigma_p^{-1} S_w$  is similar to  $\Sigma_p^{-1} \Sigma_w$ ,  $S_w^{\top} \Sigma_p^{-1} S_w$  eigenvalues are  $\lambda_1,...,\lambda_d$ . Therefore, V's *i*-th eigenvalue is  $\lambda_i(V)=1-2\alpha+2\alpha\lambda_i$ . Since V must be positive definite (i.e. all its eigenvalues are positive) we get the conditions  $1-2\alpha+2\alpha\lambda_i>0$  for all i. Notice that this condition is strictly more restrictive than  $1-\alpha+\alpha\lambda_i>0$ , and thus is the only one mentioned in the theorem.
- 9. We get an exact expression for the ratio  $\frac{\sqrt{\det V}}{\det U}$  (see eq. 144). Using the fact that the determinant of a matrix is the product of its eigenvalues, we can get an exact expression for this ratio in terms of  $\lambda_1, ..., \lambda_d$  as

$$\frac{\sqrt{\det V}}{\det U} = \prod_{i=1}^{d} \frac{\sqrt{\lambda_i(V)}}{\lambda_i(U)}$$
(145)

$$= \prod_{i=1}^{d} \frac{\sqrt{2\alpha\lambda_i + 1 - 2\alpha}}{\alpha\lambda_i + 1 - \alpha}$$
(146)

$$= \prod_{i=1}^{d} \sqrt{\frac{1}{\frac{(1+\alpha\lambda_i - \alpha)^2}{1+2\alpha\lambda_i - 2\alpha}}}$$

$$\tag{147}$$

$$= \prod_{i=1}^{d} \sqrt{\frac{1}{1 + \alpha^2 \frac{(\lambda_i - 1)^2}{1 + 2\alpha\lambda_i - 2\alpha}}}$$
 (148)

$$= \prod_{i=1}^{d} f(\lambda_i, \alpha). \tag{149}$$

Plugging this result into eq. 144 yields the desired result.

**Theorem 3.** Let  $p(z) = \mathcal{N}(z|0, \Sigma_p)$  and  $q(z) = \mathcal{N}(z|0, \Sigma_q)$ . Let  $\lambda_1, \ldots, \lambda_d$  be the eigenvalues of  $\Sigma_p^{-1} \Sigma_q$  and  $g_{\alpha} = g_{\alpha}^{\text{drep}}$ .

If  $\Sigma_p \neq \Sigma_q$  and  $1 + 2\alpha(\lambda_i - 1) > 0$  for all i we get

$$SNR[g_{\alpha}(p, q_w, \epsilon)] = \frac{1}{d+2}$$
(11)

for  $\alpha \to 0$ ,

$$SNR[g_{\alpha}(p, q_{w}, \epsilon)] \leq \left(\frac{1 + \alpha(\lambda_{\min} - 1)}{1 + 2\alpha(\lambda_{\max} - 1)}\right)^{2} \prod_{i=1}^{d} f(\lambda_{i}, \alpha)$$
(12)

for  $\alpha > 0$ , and

$$SNR[g_{\alpha}(p, q_{w}, \epsilon)] \leq \left(\frac{1 + \alpha(\lambda_{\max} - 1)}{1 + 2\alpha(\lambda_{\min} - 1)}\right)^{2} \prod_{i=1}^{d} f(\lambda_{i}, \alpha)$$
(13)

for  $\alpha < 0$ , where  $\lambda_{\max} = \max_i \lambda_i$ ,  $\lambda_{\min} = \min_i \lambda_i$  (these are both positive), and  $f(\lambda, \alpha)$  is defined in eq. 10.

Otherwise, the SNR is not defined. If  $\Sigma_p = \Sigma_q$ , this is because the estimator  $g_{\alpha}$  is zero deterministically. If  $1 + 2\alpha(\lambda_i - 1) \leq 0$  for any i, this is because the estimator has infinite variance.

*Proof.* The case for  $\alpha \to 0$  is given by Lemma 9.

For  $\alpha \neq 0$ , given eq. 144, all we need to prove the result is an upper bound for  $\frac{\|BU^{-1}\|_F^2}{\operatorname{tr}(V^{-1})\operatorname{tr}(BV^{-1}B^{\top})+2\|BV^{-1}\|_F^2}$ . This requires finding an upper bound for the numerator, and a lower bound for the denominator. To do this we introduce the induced matrix norm  $\|A\|_2 = \max_{x\neq 0} \frac{\|Ax\|_2}{\|x\|_2}$ , and use the following inequalities:

**M1:** For any  $d \times d$  real matrix A we have  $||A||_2^2 \le ||A||_F^2 \le d||A||_2^2$ .

**M2:** For any  $d \times d$  real matrices A and B we have  $||AB||_2 \le ||A||_2 ||B||_2$ .

**M3:** For any symmetric  $d \times d$  real matrix A we have  $||A||_2 = \max_i |\lambda_i(A)|$ , where  $\lambda_i(A)$  is the i-th eigenvalue of A.

**M4:** For any  $d \times d$  matrix B and symmetric  $d \times d$  real matrix A we have  $||BA||_2 \ge ||B||_2 \min_i |\lambda_i(A)|$ , where  $\lambda_i(A)$  is the i-th eigenvalue of A.

An upper bound for  $||BU^{-1}||_F^2$  is given by

$$||BU^{-1}||_F^2 \le d||BU^{-1}||_2^2 \tag{M1}$$

$$\leq d\|B\|_2^2 \|U^{-1}\|_2^2 \tag{M2}$$

$$= d\|B\|_2^2 \left(\max_i \lambda_i(U^{-1})\right)^2 \tag{M3}$$

$$= d\|B\|_2^2 \lambda_{\min}(U)^2, \tag{153}$$

where in the last line we used the fact that all eigenvalues of U are positive and that  $\lambda_i(U) = \frac{1}{\lambda_i(U^{-1})}$ .

A lower bound for  $tr(V^{-1})$  is given by

$$\operatorname{tr}(V^{-1}) = \sum_{i=1}^{d} \lambda_i(V^{-1}) \tag{154}$$

$$\geq d\lambda_{\min}(V^{-1}) \tag{155}$$

$$= d\lambda_{\max}(V). \tag{156}$$

Using the eigen-decomposition  $V = PD_vP^{\top}$ , where P is orthogonal and D diagonal with positive entries, we can get a lower bound for  $\operatorname{tr}(B^{\top}V^{-1}B)$  as

$$tr(B^{\top}V^{-1}B) = tr(B^{\top}PD_v^{-1}P^{\top}B)$$
(157)

$$= \operatorname{tr}((B^{\top} P D_{v}^{-1/2})(B^{\top} P D_{v}^{-1/2})^{\top}) \tag{158}$$

$$= \|B^{\top} P D_v^{-1/2}\|_F^2 \tag{159}$$

$$\geq \|B^{\top} P D_v^{-1/2}\|^2 \tag{M1}$$

$$\geq \|B^{\top}P\|^2 \left(\min_i \lambda_i(D_v^{-1/2})\right)^2 \tag{M4}$$

$$= \|B^{\top}\|^2 \min_{i} \lambda_i(V^{-1}) \tag{162}$$

$$= \|B\|^2 \lambda_{\max}(V). \tag{163}$$

Combining the last two results we can get a lower bound for the denominator  $\operatorname{tr}(V^{-1})\operatorname{tr}(BV^{-1}B^{\top}) + 2\|BV^{-1}\|_F^2$  as

$$\operatorname{tr}(V^{-1})\operatorname{tr}(BV^{-1}B^{\top}) + 2\|BV^{-1}\|_F^2 \ge \operatorname{tr}(V^{-1})\operatorname{tr}(BV^{-1}B^{\top})$$
 (164)

$$\geq d\|B\|_2^2 \lambda_{\max}(V)^2.$$
 (165)

Finally, the upper bound for  $\frac{\|BU^{-1}\|_F^2}{\operatorname{tr}(V^{-1})\operatorname{tr}(BV^{-1}B^\top)+2\|BV^{-1}\|_F^2}$  is given by

$$\frac{\|BU^{-1}\|_{F}^{2}}{\operatorname{tr}(V^{-1})\operatorname{tr}(BV^{-1}B^{\top}) + 2\|BV^{-1}\|_{F}^{2}} \leq \left(\frac{\lambda_{\min}(U)}{\lambda_{\max}(V)}\right)^{2} \qquad (166)$$

$$= \left(\frac{\min_{i}(1 + \alpha\lambda_{i} - \alpha)}{\max_{i}(1 + 2\alpha\lambda_{i} - 2\alpha)}\right)^{2}.$$

Considering the cases  $\alpha>0$  and  $\alpha<0$  yields the desired result.

# D Low Variance Proof (Section 3)

Section 3 considers the setting where both p and  $q_w$  are fully-factorized Gaussians with mean zero. That section empirically showed that for d=128 and  $\alpha=0.4$  optimization failed even though the gradient estimator had "low" variance. In this section we state this variance result formally. Theorem 10 presents an upper bound for the variance of the gradient estimator, and Preposition 11 states that, for  $\alpha \in (0, 1/2)$ , this upper bound "gets small" for high dimensional problems.

**Theorem 10.** Let p and q be two fully-factorized d-dimensional Gaussian distributions with mean zero and variances  $\sigma_{pi}^2$  and  $\sigma_{qi}^2$  for  $i \in \{1, \ldots, d\}$ . Let  $\lambda_i = \sigma_{qi}^2/\sigma_{pi}^2$  and  $g_{\alpha} = g_{\alpha}^{\text{drep}}$ . Then,

- If  $\sigma_{pj} = \sigma_{qj}$ , the j-th component of  $g_{\alpha}$  is deterministically zero.
- If  $\alpha \neq 0$  and  $1 + 2\alpha\lambda_i 2\alpha \leq 0$  for any i, the gradient estimator has infinite variance.
- Otherwise,

$$\mathbb{V}[g_{\alpha j}] \le A(\sigma_{pj}, \sigma_{qj}, \alpha) \prod_{i=1}^{d} \sqrt{\frac{\lambda_i^{2\alpha}}{1 + 2\alpha \lambda_i - 2\alpha}},$$
(168)

where  $g_{\alpha j}$  is the j-th component of the estimator  $g_{\alpha}$ , and  $A(\sigma_{pj},\sigma_{qj},\alpha)=\frac{3\sigma_{qj}^2}{(1+2\alpha\lambda_j-2\alpha)^2}(\frac{1}{\sigma_{pj}^2}-\frac{1}{\sigma_{qj}^2})^2$ .

**Proposition 11.** If  $\alpha \in (0, 1/2)$ , then: (i) the gradient estimator  $g_{\alpha}^{\text{drep}}$  has finite variance; (ii) all of the terms in the d-term product in eq. 168 are less than or equal one, with equality holding if and only if  $p_i = q_{w_i}$  for the corresponding i.

Theorem 10 gives an upper bound for the variance of the j-th component of the gradient estimator  $g_{\alpha}$ . It basically states that this bound is some function A that depends on  $\alpha, \sigma_{pj}$  and  $\sigma_{qj}$ , times d terms, one for each i=1,...,d. In addition, Preposition 11 states that, if  $\alpha \in (0,1/2)$ , each of these d terms is at most 1, with equality holding if and only if  $p_i = q_{w_i}$  for the corresponding i. Therefore, if this does not hold for any i (e.g. at initialization), the variance bound is just the factor  $A(\sigma_{pj}, \sigma_{qj}, \alpha)$  times d terms strictly less than one. Intuitively, if  $\alpha \in (0, 1/2)$ , larger dimensionalities d lead to smaller upper bounds for the variance (if p and  $q_w$  are isotropic this bound goes to zero exponentially in d).

We now present a proof for Theorem 10.

*Proof.* We know that the variance is just  $\mathbb{V}[g_{\alpha j}] = \mathbb{E}[g_{\alpha j}^2] - \mathbb{E}[g_{\alpha j}]^2 \leq \mathbb{E}[g_{\alpha j}^2]$ . Thus, an upper bound for the variance is given by  $\mathbb{E}[g_{\alpha j}^2]$ . We can compute this for the case where p and  $q_w$  are fully-factorized mean zero Gaussians. From eq. 55 we know

$$\mathbb{E}[g_{\alpha j}^2] = \mathbb{E}\left[\left(\frac{-1}{\alpha}\nabla_{w_j}\left(\frac{p_j(\mathcal{T}_{w_j}(\epsilon_j))}{q_{v_j}(\mathcal{T}_{w_j}(\epsilon_j))}\right)^{\alpha}\right)^2\right] \prod_{i \in \{1, \dots, d\} \setminus j} \mathbb{E}\left[\left(\frac{p_i(\mathcal{T}_{w_i}(\epsilon_i))}{q_{v_i}(\mathcal{T}_{w_i}(\epsilon_i))}\right)^{2\alpha}\right]_{v=w}.$$
 (169)

Replacing the results from eqs. 73 and 91 into the above expression yields the result from the lemma.

We now present a proof for Preposition 11.

*Proof.* We begin by proving item (i) of the preposition. The condition for finite variance is  $1 + 2\alpha(\lambda_i - 1) > 0$  for all i. For  $\alpha > 0$  this is equivalent to  $\sigma_{qi}^2 > (1 - \frac{1}{2\alpha})\sigma_{pi}^2$ . If  $\alpha \in (0, 1/2)$  the right hand side of the inequality is negative. Thus, since  $\sigma_q^2 > 0$ , the condition is always satisfied.

We now prove item (ii).  $\lambda^{2\alpha}$  is strictly concave for  $\alpha \in (0, 1/2)$  and  $R \ge 0$ . Thus, a first order Taylor expansion around any  $\lambda_0 > 0$  yields an upper bound of the function. For  $\lambda_0 = 1$  the Taylor expansion is given by  $1 + 2\alpha(\lambda - 1) = 1 + 2\alpha\lambda - 2\alpha$ . Since the Taylor expansion is an upper bound, we must have  $\frac{\lambda^{2\alpha}}{1 + 2\alpha\lambda - 2\alpha} \le 1$ , with equality holding if and only if  $\lambda = 1$ .
