CLOSE-TO-CONVEXITY PROPERTIES OF CLAUSEN'S HYPERGEOMETRIC FUNCTION $_3F_2(a, b, c; d, e; z)$

ABSTRACT. In this paper, we obtain various conditions on the parameters a, b, c, d and e for which the hypergeometric functions $z_3F_2(a, b, c; d, e; z)$ to be in the class of all close-to-convex function with respect to some well known convex functions.

1. Introduction and preliminaries

Let A denote the family of functions f that are analytic in the unit disk $\mathbb{D} = \{z : |z| < \infty\}$ 1} and normalized by $f(0) = f'(0) - 1 = 0$ and let $S \subset A$ be the class of all univalent functions. In [\[1,](#page-10-0) [2\]](#page-10-1), Various subclass of univalent functions are characterised by its geometrical properties and the important subclasses are convex, starlike and close-to-convex functions.

Definition 1.1. A function f in S is a convex function in \mathbb{D} if and only if

$$
\operatorname{Re}\left(1+\frac{zf^{\prime\prime}(z)}{f^{\prime}(z)}\right)>0
$$

Let us denote by C the class of all convex univalent functions in \mathbb{D} .

Definition 1.2. A function f in S is a starlike function with respect to the origin in $\mathbb D$ if and only if

$$
\operatorname{Re}\left(\frac{zf'(z)}{f(z)}\right) > 0
$$

Let us denote by S^* , the class of all starlike univalent functions in \mathbb{D} .

Definition 1.3. A function f in S is a close to convex in \mathbb{D} if and only if

$$
\operatorname{Re}\left(\frac{f'(z)}{g'(z)}\right) > 0
$$

for some $q \in \mathcal{C}$.

The class of all close to convex univalent functions in $\mathbb D$ is denoted by K. It is well known that the chain of inclusion relations $\mathcal{C} \subset \mathcal{S}^* \subset \mathcal{K} \subset \mathcal{S}$.

The family of functions in A which are close-to-convex with respect to $-\log(1-z)$, and also, starlike in D is denoted by KS^* .

Definition 1.4. Let $f(z) = z + \sum_{n=1}^{\infty}$ $n=2$ $a_n z^n$ and $g(z) = z + \sum_{n=1}^{\infty}$ $n=2$ $b_n z^n$ be analytic in \mathbb{D} . Then the Hadamard product or convolution of $f(z)$ and $g(z)$ is defined by

f(z) * g(z) = z + \sum_{n=2}^{\infty} a_n b_n z^n, \, |z| < 1.
$$

Definition 1.5. The Alexander transform, is defined as

(1)
$$
\Lambda_f(z) = \int_0^z \frac{f(t)}{t} dt, \ f \in \mathcal{S}, z \in \mathbb{D}
$$

Using convolution technique the above transform is given by $F(z) = f(z) * h(z)$ where $h(z) = -\log(1-z)$, is not univalent in D. It is know that the function $h(z)$ is well known and is a convex function of order 1/2.

For any complex variable $a \neq 0$, the shifted factorial (or Pochhammer symbol) is defined as

$$
(a)_0 = 1, \quad (a)_n = a(a+1)\cdots(a+n-1), \quad n = 1, 2, 3, \cdots
$$

In terms of Euler gamma function, the Pochhammer symbol can also be defined as

$$
(a)_n = \frac{\Gamma(n+a)}{\Gamma(a)}, \quad n = 0, 1, 2, \cdots
$$

where *a* is neither zero nor a negative integer.

Definition 1.6. The Hypergeometric Function ${}_3F_2(a, b, c; d, e; z)$ is defined by

(2)

{}_3F_2(a,b,c;d,e;z) = \sum_{n=0}^{\infty} \frac{(a)_n (b)_n (c)_n}{(d)_n (e)_n (1)_n} z^n; \ \ a,b,c,d,e \in \mathbb{C}
$$

where $a, b, c, d, e \in \mathbb{C}$ and $d, e \neq 0, -1, -2, -3, \cdots$ which is analytic and convergent in unit disc D.

Using [\(2\)](#page-1-0), the normalized hypergeometric function be written as $z_3F_2(a, b, c; d, e; z)$ and defined by

f(z) = z_3 F_2(a, b, c; d, e; z) = z + \sum_{n=2}^{\infty} A_n z^n,
$$

where

(4)

A_n = \frac{(a)_{n-1}(b)_{n-1}(c)_{n-1}}{(d)_{n-1}(e)_{n-1}(1)_{n-1}}, \text{ for } n \ge 2.
$$

and $A_1 = 1$.

Lemma 5. [\[7\]](#page-10-2) If $A_n \geq 0$, $\{nA_n\}$ and $\{nA_n - (n+1)A_{n+1}\}$ both are non-increasing, i.e., ${n_A}$ is monotone of order 2, then f defined by [\(3\)](#page-1-1) is in S^* .

Lemma 6. [\[8\]](#page-10-3) Suppose that

$$
1 \ge 2A_2 \ge \cdots \ge nA_n \ge \cdots \ge 0
$$

or

$$
1 \leqq 2A_2 \leq \cdots \leq nA_n \leq \cdots \leq 2
$$

Then $f(z)$ is defined by [\(3\)](#page-1-1) is close-to-convex with respect to $-\log(1-z)$.

Lemma 7. [\[8\]](#page-10-3) Suppose that f is an odd function (i.e., the value of A_{2n} in [\(3\)](#page-1-1) is zero for each $n \geq 1$) such that

$$
1 \ge 3A_3 \ge \cdots \ge (2n+1)A_{2n+1} \ge \cdots \ge 0
$$

or

$$
1 \le 3A_3 \le \cdots \le (2n+1)A_{2n+1} \le \cdots \le 2
$$

Then $f \in \mathcal{S}$. In fact, $f(z)$ is close-to-convex with respect to the convex function $\frac{1}{2} \log((1+\frac{1}{2})^2)$ $z)/(1-z)$.

In 1986, Ruscheweyh and Singh [\[3\]](#page-10-4) obtained the sufficient conditions on the parameters a, b and c for $z_2F_1(a, b; c; z)$ to be starlike of order $\beta < 1$. Further the year 1995, Ponnusamy and Vourinen [\[4\]](#page-10-5) have established the univalence and convexity properties of Gaussian hypergeometric functions. Subsequently Ponnusamy derived the conditions on the parameters a, b and c for univalence and starlike properties of Alexander transform and also the close-to-convexity properties of the Gaussian hypergeometric functions [\[5,](#page-10-6) [6\]](#page-10-7).

Inspired by the above results, in this paper, we find conditions on a, b, c, d and e such that the function $z_3F_2(a, b, c; d, e; z)$ to be close-to-convex with respect to the functions $-\log(1-z), \frac{1}{2}$ $\frac{1}{2}$ log $\left(\frac{1+z}{1-z}\right)$ and is in the class KS^* . We also find similar conditions such that the Alexander transform is in the class KS^* .

2. Main Results and Proofs:

Theorem 8. If $a, b, c > 0$, $de > 2abc$ and

$$
d+e \ge Max\left\{a+b+c, \frac{1}{2}(ab+bc+ac+2(a+b+c)-1-2abc), 2[ab+bc+ac]-3abc\right\},\
$$

then $z \ {}_3F_2(a,b,c;d,e;z)$ *is close-to-convex with respect to* $-log(1-z)$.

Proof. Consider the function $f(z)$ is defined in [\(3\)](#page-1-1). Replace n by $n + 1$ in the equation [\(4\)](#page-1-2) and Using the Pochhammer symbol, we have

(9)
$$
A_{n+1} = \frac{(a)_n (b)_n (c)_n}{(d)_n (e)_n (1)_n} = \frac{(a+n-1)(b+n-1)(c+n-1)}{(d+n-1)(e+n-1)n} A_n
$$

and observe that $A_n > 0$ for all $n \geq 1$.

To prove f is close-to-convex with respect to $-\log(1-z)$. It is enough to show that ${nA_n}$ is non-increasing sequence.

From [\(4\)](#page-1-2) and [\(9\)](#page-2-0), we have the following after some manipulation

nA_n - (n+1)A_{n+1} = nA_n - \frac{(n+1)(a+n-1)(b+n-1)(c+n-1)}{(d+n-1)(e+n-1)n}A_n
$$

= \frac{A_n U(n)}{(d+n-1)(e+n-1)n}
$$

where

$$
U(n) = n2(e+n-1)(d+n-1) - (n+1)(a+n-1)(b+n-1)(c+n-1)
$$

= (e+d-c-b-a) n³ + (d e - (e + d) - (a b + b c + a c) + c + b + a + 1) n²
-(a b c - c - b - a + 2) n - (a - 1) (b - 1) (c - 1)

For every $n \geq 1$, we have $n^3 \geq 3n^2 - 3n + 1$,

$$
V(n) \ge (de + 2(e + d) - (ab + bc + ac) - 2(a + b + c) + 1) n2
$$

+ (-3(e + d) - abc + 4(c + b + a) - 2) n
+ e + d - abc + bc + ac - 2c + ab - 2b - 2a + 1

Using the fact that $n^2 \ge 2n - 1$, for all $n \ge 1$.

$$
W(n) \ge (e+d+2de - abc - 2(ab + bc + ac))n - (de + e + d + abc - 2(ab + bc + ac))
$$

Put $n = 1$ in above the equation, we find

$$
W(1) = de - 2abc \ge 0
$$

Since $de \geq 2abc$, The above equation implies that

$$
U(n) \ge V(n) \ge W(n) \ge W(1) \ge 0.
$$

Hence $\{nA_n\}$ is a non-increasing sequence). Hence by Lemma [6,](#page-2-1) the function $z \, {}_{3}F_2(a, b, c; d, e; z)$ is close-to-convex with respect to $-log(1-z)$.

Theorem 10. If $a, b, c > 0$, $de \geq 3abc$ and

(11)
$$
d + e \ge Max \{a + b + c, \alpha(a, b, c), 3(a b + b c + a c) - 7 a b c\}
$$

where

$$
\alpha(a, b, c) = \frac{1}{3} ((2(ab + bc + ac) + 3(a + b + c) - 6abc - 1)
$$

then $z_3F_2(a, b, c; d, e; z^2)$ is close-to-convex with respect to $\frac{1}{2} \log((1+z)/(1-z))$.

Proof. Consider the function defined as follows by replacing z by z^2 in the equation [\(3\)](#page-1-1)

$$
f(z) = z \, {}_{3}F_{2}(a, b, c; d, e; z^{2}) = z + \sum_{n=2}^{\infty} A_{2n-1} z^{2n-1},
$$

where

(12)
$$
A_{2n-1} = \frac{(a)_{n-1}(b)_{n-1}(c)_{n-1}}{(d)_{n-1}(e)_{n-1}(1)_{n-1}}, \text{for } n \ge 2.
$$

and $A_1 = 1$. Then, we have the following from the equation [\(12\)](#page-4-0) by replacing n by $n + 1$.

A_{2n+1} = \frac{(a+n-1)(b+n-1)(c+n-1)}{(d+n-1)(e+n-1)n}A_{2n-1}
$$

and therefore we obtain

$$
(2n-1)A_{2n-1} - (2n+1)A_{2n+1} = \frac{A_{2n-1}X(n)}{(e+n-1)(d+n-1)n}
$$

where

$$
X(n) = 2(e + d - c - b - a) n3
$$

+ (2 d e - 3 (e + d) - 2 (a b + b c + a c) + 3 (c + b + a) + 1) n²
-(d e - (e + d) + 2 a b c - (a b + b c + a c) + 2) n

Replace $n^3 \geq 3n^2 - 3n + 1$, for every $n \geq 1$, we have

Y(n) = (2 de + 3 (e + d) - 2 (a b + b c + a c) - 3 (c + b + a) + 1) n2
$$

-(d e + 5 (e + d) + 2 a b c - (b c + a c + a b) - 6 (c + b + a) + 2) n
+2 (e + d) - a b c + a b + b c + a c - 3 (c + b + a) + 1

Using $n^2 \ge 2n - 1$, for all $n \ge 1$, implies that

$$
Z(n) = (3 de + e + d - 2 abc - 3(ab + bc + ac)) n
$$

$$
- (2 de + e + d + abc - 3(ab + bc + ac))
$$

Replace n by 1 in above, we get

$$
Z(1) = de - 3abc \ge 0
$$

Since $de \geq 3abc$, The above equation implies that

$$
X(n) \ge Y(n) \ge Z(n) \ge Z(1) \ge 0
$$

Hence by the condition on $d + e$ in [\(11\)](#page-3-0), we have $X(n)$ is non-negative, for all $n \geq 1$. Thus $\{(2n-1)A_{2n-1}\}\$ is non-increasing sequence. The function $z_3F_2(a, b, c; d, e; z^2)$ is close-to-convex with respect to $\frac{1}{2} \log((1+z)/(1-z))$ by Lemma [7.](#page-2-2)

Theorem 13. Let a, b, and $c > 0$,

d + e \ge Max \{ T_1(a, b, c), T_2(a, b, c), T_3(a, b, c), T_4(a, b, c) \}

$$

Then $z_3F_2(a, b, c; d, e; z)$ is in KS^* .

Proof. The function $f(z) = z_3F_2(a, b, c; d, e; z)$ is defined by [\(3\)](#page-1-1), where A_n is as in [\(4\)](#page-1-2).

For $a, b, c > 0$, we observe that $de \ge 2 ab c$ and

$$
d+e \ge Max\left\{a+b+c, \frac{1}{2}(ab+bc+ac+2(a+b+c)-1-2abc), 2[ab+bc+ac]-3abc\right\}.
$$

By Theorem [8,](#page-2-3) this condition implies that the sequence $\{nA_n\}$ is non-increasing. To prove f is starlike. We need to show that the sequence ${nA_n - (n + 1)A_{n+1}}$ is also non-increasing using Lemma [5.](#page-2-4) Let

$$
B_n = nA_n - (n+1)A_{n+1} \quad and \quad B_{n+1} = (n+1)A_{n+1} - (n+2)A_{n+2}
$$

Using A_n , we find that

B_n - B_{n+1} = nA_n - 2(n+1)A_{n+1} + (n+2)A_{n+2}
$$

= A_n \left[n - 2(n+1) \left(\frac{A_{n+1}}{A_n} \right) + (n+2) \left(\frac{A_{n+2}}{A_n} \right) \right]
$$

Close-to-convexity properties of ${}_3F_2(a, b, c; d, e; z)$ 7

Where

$$
\frac{A_{n+1}}{A_n} = \frac{(a+n-1)(b+n-1)(c+n-1)}{(d+n-1)(e+n-1)n}
$$

and

$$
\frac{A_{n+2}}{A_n} = \frac{(a+n)(a+n-1)(b+n)(b+n-1)(c+n)(c+n-1)}{(d+n)(d+n-1)(e+n)(e+n-1)n(n+1)}
$$

After some simplification the equation [\(14\)](#page-5-0) implies

Our aim is to check that $P(n)$ is non-negative for all $n \geq 1$. After few steps of calculation, we get

T(n) \geq \left(\left(5d^2 + 9d + 2\right)e^2 + \left(9d^2 + \left(\left(\left(-8a - 8\right)b - 8a\right)c - 8ab + 13\right)d\right) + \left(\left(-16a - 8\right)b - 8a\right)c - 8ab + 2\right)e + 2d^2 + \left(\left(\left(-16a - 8\right)b - 8a\right)c \right) - 8ab + 2\right)d + \left(\left(a^2 + 7a + 3\right)b^2 + \left(7a^2 + 13a + 3\right)b + 3a^2 + 3a\right)c^2 + \left(\left(7a^2 + 13a + 3\right)b^2 + \left(13a^2 - 5a - 5\right)b + 3a^2 - 5a\right)c \right. + \left(3a^2 + 3a\right)b^2 + \left(3a^2 - 5a\right)b\right)n + \left(-3d^2 - 7d - 2\right)e^2 + \left(-7d^2 + \left(\left(8b + 8a\right)c + 8ab - 11\right)d + \left(\left(8a + 8\right)b + 8a\right)c \right. + 8ab - 2) e - 2d^2 + \left(\left(8a + 8\right)b + 8a\right)c + 8ab - 2\right)d + \left(\left(2a^2 - 4a - 3\right)b^2 \right) + \left(-4a^2 - 10a - 3\right)b - 3a^2 - 3a\right)c^2 + \left(\left(-4a^2 - 10a - 3\right)b^2 \right) + \left(5 - 10a^2\right)b - 3a^2 + 5a\right)c + \left(-3a^2 - 3a\right)b^2 + \left(5a - 3a^2\right)b

Put $n = 1$, we have

$$
T(1) \ge (2d^2 + 2d) e^2 + (2d^2 + (2 - 8abc) d - 8abc) e - 8abcd + ((3a^2 + 3a) b^2 + (3a^2 + 3a) b) c^2 + ((3a^2 + 3a) b^2 + (3a^2 - 5a) b) c \ge 0
$$

Hence by hypothesis, the following inequalities holds true

$$
P(n) \ge Q(n) \ge R(n) \ge S(n) \ge T(n) \ge T(1) \ge 0.
$$

Therefore sequences ${B_n}$ and ${nA_n - (n+1)A_{n+1}}$, is non-increasing. We deduce that f is starlike by Lemma [5.](#page-2-4) Also the function f is close-to-convex with respect to $-\log(1-z)$. Since the conditions of Lemma [6](#page-2-1) are verified. \Box

Theorem 16. Let a, b, and $c > 0$. Suppose that

$$
d + e \ge max\{T_1(a, b, c), T_2(a, b, c), T_3(a, b, c)\}
$$

where

T_1(a, b, c) = (e + d - c - b - a + 1) (e + d - c - b - a + 2),
$$

T_2(a, b, c) = 2 (e + d - c - b - a + 2) (de + 2e + 2d - bc - ac - c - a b - b - a + 1),

then the Alexander transform is defined by (1) is in KS^* .

Proof. Let $f(z) = z_3F_2(a, b, c; d, e; z)$, then from the definition of hypergeometric function $_3F_2$, we have

$$
f(z) = \sum_{n=1}^{\infty} \frac{(a)_{n-1}(b)_{n-1}(c)_{n-1}}{(d)_{n-1}(e)_{n-1}(1)_{n-1}} z^n
$$

so that the corresponding Alexander transform defined by [\(1\)](#page-1-3) takes the form

\Lambda_f(z) = \sum_{n=1}^{\infty} A_n z^n,
$$

with $A_1 = 1$ and

A_n = \frac{(a)_{n-1}(b)_{n-1}(c)_{n-1}}{n(d)_{n-1}(e)_{n-1}(1)_{n-1}}, \text{ for } n \ge 2.
$$

Using the definition of the shifted factorial notation, we have

A_{n+1} = \frac{(a)_n (b)_n (c)_n}{(n+1)(d)_n (e)_n (1)_n}
$$

and

(n+1)A_{n+1} = \frac{(a+n-1)(b+n-1)(c+n-1)}{(d+n-1)(e+n-1)}A_n
$$

After some simplification,

nA_n - (n+1)A_{n+1} = nA_n - \frac{(a+n-1)(b+n-1)(c+n-1)}{(d+n-1)(e+n-1)}A_n

By hypothesis, $d + e \ge ab + bc + ac - abc$ and so for every $n \ge 1$,

$$
U(n) \ge U(1) = de - abc \ge 0
$$

and since $de \ge abc$, we proved that the above condition satisfied. Thus the sequence ${nA_n}$ is decreasing. Next, we prove that ${nA_n - (n+1)A_{n+1}}$ is also decreasing.

Let $B_n = nA_n - (n+1)A_{n+1}$. Then after some manipulation, we get

Our aim is to check that $C(n)$ is non-negative for all $n \geq 1$. After manipulation, we get

F(n) \geq \left(\left(3d^2 + 7d + 2 \right) e^2 + \left(7d^2 + \left(\left((-2a - 4) b - 4a \right) c - 4ab + 11 \right) d \right. \\ \left. + \left(\left(-6a - 4 \right) b - 4a \right) c - 4ab + 2 \right) e + 2d^2 + \left(\left(\left(-6a - 4 \right) b - 4a \right) c \right. \\ \left. - 4ab + 2 \right) d + \left((2a + 1) b^2 + (2a^2 + 4a + 1) b + a^2 + a \right) c^2 \\ \left. + \left((2a^2 + 4a + 1) b^2 + (4a^2 - 4a - 3) b + a^2 - 3a \right) c \right. \\ \left. + \left(a^2 + a \right) b^2 + \left(a^2 - 3a \right) b \right) n

For every $n \geq 1$, $C(n) \geq D(n) \geq E(n) \geq F(n) \geq F(1)$. Which is true

Therefore, the sequences ${B_n}$ and ${nA_n - (n + 1)A_{n+1}}$ are non-increasing. The Alexander transform $\Lambda_f(z)$ is starlike in unit disc D by Lemma [5](#page-2-4) and already verified ${nA_n}$ is non-increasing. Therefore, the Alexander transform $\Lambda_f(z)$ is close-to-convex with respect to $-\log(1-z)$ using Lemma [6.](#page-2-1) Thus we have $\Lambda_f(z) \in KS^*$. Which completes the proof of Theorem.
