## CLOSE-TO-CONVEXITY PROPERTIES OF CLAUSEN'S HYPERGEOMETRIC FUNCTION $_{3}F_{2}(a, b, c; d, e; z)$

ABSTRACT. In this paper, we obtain various conditions on the parameters a, b, c, d and e for which the hypergeometric functions  $z_{3}F_{2}(a, b, c; d, e; z)$  to be in the class of all close-to-convex function with respect to some well known convex functions.

## 1. INTRODUCTION AND PRELIMINARIES

Let  $\mathcal{A}$  denote the family of functions f that are analytic in the unit disk  $\mathbb{D} = \{z : |z| < 1\}$  and normalized by f(0) = f'(0) - 1 = 0 and let  $\mathcal{S} \subset \mathcal{A}$  be the class of all univalent functions. In [1, 2], Various subclass of univalent functions are characterised by its geometrical properties and the important subclasses are convex, starlike and close-to-convex functions.

**Definition 1.1.** A function f in S is a convex function in  $\mathbb{D}$  if and only if

$$\operatorname{Re}\left(1 + \frac{zf''(z)}{f'(z)}\right) > 0$$

Let us denote by C the class of all convex univalent functions in  $\mathbb{D}$ .

**Definition 1.2.** A function f in S is a starlike function with respect to the origin in  $\mathbb{D}$  if and only if

$$\operatorname{Re}\left(\frac{zf'(z)}{f(z)}\right) > 0$$

Let us denote by  $\mathcal{S}^*$ , the class of all starlike univalent functions in  $\mathbb{D}$ .

**Definition 1.3.** A function f in S is a close to convex in  $\mathbb{D}$  if and only if

$$\operatorname{Re}\left(\frac{f'(z)}{g'(z)}\right) > 0$$

for some  $g \in C$ .

The class of all close to convex univalent functions in  $\mathbb{D}$  is denoted by  $\mathcal{K}$ . It is well known that the chain of inclusion relations  $\mathcal{C} \subset \mathcal{S}^* \subset \mathcal{K} \subset \mathcal{S}$ .

The family of functions in  $\mathcal{A}$  which are close-to-convex with respect to  $-\log(1-z)$ , and also, starlike in  $\mathbb{D}$  is denoted by  $KS^*$ .

**Definition 1.4.** Let  $f(z) = z + \sum_{n=2}^{\infty} a_n z^n$  and  $g(z) = z + \sum_{n=2}^{\infty} b_n z^n$  be analytic in  $\mathbb{D}$ . Then the Hadamard product or convolution of f(z) and g(z) is defined by

$$f(z) * g(z) = z + \sum_{n=2}^{\infty} a_n b_n z^n, |z| < 1.$$

Definition 1.5. The Alexander transform, is defined as

(1) 
$$\Lambda_f(z) = \int_0^z \frac{f(t)}{t} dt, \ f \in \mathcal{S}, z \in \mathbb{D}$$

Using convolution technique the above transform is given by F(z) = f(z) \* h(z) where  $h(z) = -\log(1-z)$ , is not univalent in  $\mathbb{D}$ . It is know that the function h(z) is well known and is a convex function of order 1/2.

For any complex variable  $a \neq 0$ , the shifted factorial (or Pochhammer symbol) is defined as

$$(a)_0 = 1, \quad (a)_n = a(a+1)\cdots(a+n-1), \quad n = 1, 2, 3, \cdots$$

In terms of Euler gamma function, the Pochhammer symbol can also be defined as

$$(a)_n = \frac{\Gamma(n+a)}{\Gamma(a)}, \quad n = 0, 1, 2, \cdots$$

where a is neither zero nor a negative integer.

**Definition 1.6.** The Hypergeometric Function  ${}_{3}F_{2}(a, b, c; d, e; z)$  is defined by

(2) 
$${}_{3}F_{2}(a,b,c;d,e;z) = \sum_{n=0}^{\infty} \frac{(a)_{n}(b)_{n}(c)_{n}}{(d)_{n}(e)_{n}(1)_{n}} z^{n}; a,b,c,d,e \in \mathbb{C}$$

where  $a, b, c, d, e \in \mathbb{C}$  and  $d, e \neq 0, -1, -2, -3, \cdots$  which is analytic and convergent in unit disc  $\mathbb{D}$ .

Using (2), the normalized hypergeometric function be written as  $z_{3}F_{2}(a, b, c; d, e; z)$ and defined by

(3) 
$$f(z) = z_{3}F_{2}(a, b, c; d, e; z) = z + \sum_{n=2}^{\infty} A_{n}z^{n},$$

where

(4) 
$$A_n = \frac{(a)_{n-1}(b)_{n-1}(c)_{n-1}}{(d)_{n-1}(e)_{n-1}(1)_{n-1}}, \text{ for } n \ge 2.$$

and  $A_1 = 1$ .

**Lemma 5.** [7] If  $A_n \ge 0$ ,  $\{nA_n\}$  and  $\{nA_n - (n+1)A_{n+1}\}$  both are non-increasing, i.e.,  $\{nA_n\}$  is monotone of order 2, then f defined by (3) is in  $S^*$ .

Lemma 6. [8] Suppose that

$$1 \ge 2A_2 \ge \dots \ge nA_n \ge \dots \ge 0$$

or

$$1 \leq 2A_2 \leq \dots \leq nA_n \leq \dots \leq 2$$

Then f(z) is defined by (3) is close-to-convex with respect to  $-\log(1-z)$ .

**Lemma 7.** [8] Suppose that f is an odd function (i.e., the value of  $A_{2n}$  in (3) is zero for each  $n \ge 1$ ) such that

$$1 \ge 3A_3 \ge \dots \ge (2n+1)A_{2n+1} \ge \dots \ge 0$$

or

$$1 \le 3A_3 \le \dots \le (2n+1)A_{2n+1} \le \dots \le 2$$

Then  $f \in S$ . In fact, f(z) is close-to-convex with respect to the convex function  $\frac{1}{2}\log((1+z)/(1-z))$ .

In 1986, Ruscheweyh and Singh [3] obtained the sufficient conditions on the parameters a, b and c for  $z_2F_1(a, b; c; z)$  to be starlike of order  $\beta < 1$ . Further the year 1995, Ponnusamy and Vourinen [4] have established the univalence and convexity properties of Gaussian hypergeometric functions. Subsequently Ponnusamy derived the conditions on the parameters a, b and c for univalence and starlike properties of Alexander transform and also the close-to-convexity properties of the Gaussian hypergeometric functions [5, 6].

Inspired by the above results, in this paper, we find conditions on a, b, c, d and e such that the function  $z_{3}F_{2}(a, b, c; d, e; z)$  to be close-to-convex with respect to the functions  $-\log(1-z), \frac{1}{2}\log(\frac{1+z}{1-z})$  and is in the class  $KS^{*}$ . We also find similar conditions such that the Alexander transform is in the class  $KS^{*}$ .

## 2. Main Results and Proofs:

**Theorem 8.** If a, b, c > 0,  $de \ge 2 a b c$  and

$$d + e \ge Max \left\{ a + b + c, \frac{1}{2}(ab + bc + ac + 2(a + b + c) - 1 - 2abc), 2[ab + bc + ac] - 3abc \right\},$$
  
then  $z_{3}F_{2}(a, b, c; d, e; z)$  is close-to-convex with respect to  $-log(1 - z)$ .

Proof. Consider the function f(z) is defined in (3). Replace n by n + 1 in the equation (4) and Using the Pochhammer symbol, we have

(9) 
$$A_{n+1} = \frac{(a)_n (b)_n (c)_n}{(d)_n (e)_n (1)_n} = \frac{(a+n-1)(b+n-1)(c+n-1)}{(d+n-1)(e+n-1)n} A_n$$

and observe that  $A_n > 0$  for all  $n \ge 1$ .

To prove f is close-to-convex with respect to  $-\log(1-z)$ . It is enough to show that  $\{nA_n\}$  is non-increasing sequence.

From (4) and (9), we have the following after some manipulation

$$nA_n - (n+1)A_{n+1} = nA_n - \frac{(n+1)(a+n-1)(b+n-1)(c+n-1)}{(d+n-1)(e+n-1)n}A_n$$
$$= \frac{A_n U(n)}{(d+n-1)(e+n-1)n}$$

where

$$U(n) = n^{2}(e+n-1)(d+n-1) - (n+1)(a+n-1)(b+n-1)(c+n-1)$$
  
=  $(e+d-c-b-a)n^{3} + (de-(e+d) - (ab+bc+ac) + c+b+a+1)n^{2}$   
 $- (abc-c-b-a+2)n - (a-1)(b-1)(c-1)$ 

For every  $n \ge 1$ , we have  $n^3 \ge 3n^2 - 3n + 1$ ,

$$V(n) \geq (de + 2(e + d) - (ab + bc + ac) - 2(a + b + c) + 1)n^{2} + (-3(e + d) - abc + 4(c + b + a) - 2)n + e + d - abc + bc + ac - 2c + ab - 2b - 2a + 1$$

Using the fact that  $n^2 \ge 2n - 1$ , for all  $n \ge 1$ .

$$W(n) \geq (e + d + 2 d e - a b c - 2 (a b + b c + a c)) n - (d e + e + d + a b c - 2 (a b + b c + a c))$$

Put n = 1 in above the equation, we find

$$W(1) = de - 2abc \ge 0$$

Since  $d e \ge 2 a b c$ , The above equation implies that

$$U(n) \ge V(n) \ge W(n) \ge W(1) \ge 0.$$

Hence  $\{nA_n\}$  is a non-increasing sequence). Hence by Lemma 6, the function  $z_{3}F_{2}(a, b, c; d, e; z)$  is close-to-convex with respect to -log(1 - z).

**Theorem 10.** If a, b, c > 0,  $de \ge 3abc$  and

(11) 
$$d + e \ge Max \{a + b + c, \alpha(a, b, c), 3(ab + bc + ac) - 7abc\}$$

where

$$\alpha(a,b,c) = \frac{1}{3} \left( (2(a\,b+b\,c+a\,c) + 3(a+b+c) - 6\,a\,b\,c - 1) \right)$$

then z  $_{3}F_{2}(a, b, c; d, e; z^{2})$  is close-to-convex with respect to  $\frac{1}{2}\log((1+z)/(1-z))$ .

Proof. Consider the function defined as follows by replacing z by  $z^2$  in the equation (3)

$$f(z) = z_{3}F_{2}(a, b, c; d, e; z^{2}) = z + \sum_{n=2}^{\infty} A_{2n-1}z^{2n-1}$$

where

(12) 
$$A_{2n-1} = \frac{(a)_{n-1}(b)_{n-1}(c)_{n-1}}{(d)_{n-1}(e)_{n-1}(1)_{n-1}}, \text{ for } n \ge 2.$$

and  $A_1 = 1$ . Then, we have the following from the equation (12) by replacing n by n + 1.

$$A_{2n+1} = \frac{(a+n-1)(b+n-1)(c+n-1)}{(d+n-1)(e+n-1)n} A_{2n-1}$$

and therefore we obtain

$$(2n-1)A_{2n-1} - (2n+1)A_{2n+1} = \frac{A_{2n-1}X(n)}{(e+n-1)(d+n-1)n}$$

where

$$X(n) = 2(e + d - c - b - a) n^{3} + (2 d e - 3 (e + d) - 2 (a b + b c + a c) + 3 (c + b + a) + 1) n^{2} - (d e - (e + d) + 2 a b c - (a b + b c + a c) + 2) n - (a - 1) (b - 1) (c - 1)$$

Replace  $n^3 \ge 3n^2 - 3n + 1$ , for every  $n \ge 1$ , we have

$$Y(n) = (2 d e + 3 (e + d) - 2 (a b + b c + a c) - 3 (c + b + a) + 1) n^{2} - (d e + 5 (e + d) + 2 a b c - (b c + a c + a b) - 6 (c + b + a) + 2) n + 2 (e + d) - a b c + a b + b c + a c - 3 (c + b + a) + 1$$

Using  $n^2 \ge 2n - 1$ , for all  $n \ge 1$ , implies that

$$Z(n) = (3 d e + e + d - 2 a b c - 3(a b + b c + a c)) n - (2 d e + e + d + a b c - 3(a b + b c + a c))$$

Replace n by 1 in above, we get

$$Z(1) = de - 3abc \ge 0$$

Since  $d e \ge 3 a b c$ , The above equation implies that

$$X(n) \ge Y(n) \ge Z(n) \ge Z(1) \ge 0$$

Hence by the condition on d + e in (11), we have X(n) is non-negative, for all  $n \ge 1$ . Thus  $\{(2n-1)A_{2n-1}\}$  is non-increasing sequence. The function  $z_{3}F_{2}(a, b, c; d, e; z^{2})$  is close-to-convex with respect to  $\frac{1}{2}\log((1+z)/(1-z))$  by Lemma 7.

**Theorem 13.** Let a, b, and c > 0,

$$d + e \ge Max \{T_1(a, b, c), T_2(a, b, c), T_3(a, b, c), T_4(a, b, c)\}$$

where

$$\begin{split} T_1(a,b,c) &= (e+d-c-b-a) (e+d-c-b-a+1) \\ T_2(a,b,c) &= (e+d-c-b-a+1) (2 \, de+5 \, (e+d)-2 \, (a \, b+b \, c+a \, c)-5 \, (c+b+a)+2) \\ T_3(a,b,c) &= ((d^2+9 \, d+9) \, e^2+(9 \, d^2+((-2 \, b-2 \, a-8) \, c+(-2 \, a-8) \, b-8 \, a+29) \, d \\ &+((-2 \, a-10) \, b-10 \, a-16) \, c+(-10 \, a-16) \, b-16 \, a+15) \, e+9 \, d^2 \\ &+(((-2 \, a-10) \, b-10 \, a-16) \, c+(-10 \, a-16) \, b-16 \, a+15) \, d \\ &+(b^2+(4 \, a+9) \, b+a^2+9 \, a+7) \, c^2+((4 \, a+9) \, b^2 \\ &+(4 \, a^2+24 \, a+3) \, b+9 \, a^2+3 \, a-11) \, c+(a^2+9 \, a+7) \, b^2 \\ &+(9 \, a^2+3 \, a-11) \, b+7 \, a^2-11 \, a+4) \end{split}$$

$$T_4(a,b,c) &= ((4 \, d^2+14 \, d+7) \, e^2+(14 \, d^2+(((-2 \, a-8) \, b-8 \, a-8) \, c+(-8 \, a-8) \, b \\ &-8 \, a+32) \, d+((-10 \, a-16) \, b-16 \, a-8) \, c+(-16 \, a-8) \, b-8 \, a+11) \, d \\ &+((2 \, a+4) \, b^2+(2 \, a^2+16 \, a+10) \, b+4 \, a^2+10 \, a+3) \, c^2 \\ &+((2 \, a^2+16 \, a+10) \, b^2+(16 \, a^2+16 \, a-8) \, b+10 \, a^2-8 \, a \\ &-5) \, c+(4 \, a^2+10 \, a+3) \, b^2+(10 \, a^2-8 \, a-5) \, b \\ &+3 \, a^2-5 \, a+2) \end{split}$$

and

$$T(a, b, c, d, e) = (2d^{2} + 2d) e^{2} + (2d^{2} + (2 - 8abc) d - 8abc) e - 8abcd + ((3a^{2} + 3a) b^{2} + (3a^{2} + 3a) b) c^{2} + ((3a^{2} + 3a) b^{2} + (3a^{2} - 5a) b) c \ge 0$$

Then  $z_3F_2(a, b, c; d, e; z)$  is in  $KS^*$ .

Proof. The function  $f(z) = z_3 F_2(a, b, c; d, e; z)$  is defined by (3), where  $A_n$  is as in (4).

For a, b, c > 0, we observe that  $de \ge 2 a b c$  and

$$d+e \ge Max \left\{ a+b+c, \ \frac{1}{2}(ab+bc+ac+2(a+b+c)-1-2abc), 2[ab+bc+ac]-3abc \right\}.$$

By Theorem 8, this condition implies that the sequence  $\{nA_n\}$  is non-increasing. To prove f is starlike. We need to show that the sequence  $\{nA_n - (n+1)A_{n+1}\}$  is also non-increasing using Lemma 5. Let

$$B_n = nA_n - (n+1)A_{n+1}$$
 and  $B_{n+1} = (n+1)A_{n+1} - (n+2)A_{n+2}$ 

Using  $A_n$ , we find that

(14) 
$$B_n - B_{n+1} = nA_n - 2(n+1)A_{n+1} + (n+2)A_{n+2} \\ = A_n \left[ n - 2(n+1)\left(\frac{A_{n+1}}{A_n}\right) + (n+2)\left(\frac{A_{n+2}}{A_n}\right) \right]$$

Close-to-convexity properties of  $_{3}F_{2}(a, b, c; d, e; z)$ 

Where

$$\frac{A_{n+1}}{A_n} = \frac{(a+n-1)(b+n-1)(c+n-1)}{(d+n-1)(e+n-1)n}$$

and

$$\frac{A_{n+2}}{A_n} = \frac{(a+n)(a+n-1)(b+n)(b+n-1)(c+n)(c+n-1)}{(d+n)(d+n-1)(e+n)(e+n-1)n(n+1)}$$

After some simplification the equation (14) implies

(15) 
$$B_n - B_{n+1} = \frac{A_n P(n)}{n(n+1)(d+n)(d+n-1)(e+n)(e+n-1)}$$

$$\begin{split} P(n) &= n^2(n+1)(d+n)(d+n-1)(e+n)(e+n-1) \\ &-2(n+1)^2(d+n)(e+n)(a+n-1)(b+n-1)(c+n-1) \\ &+(n+2)(a+n)(a+n-1)(b+n)(b+n-1)(c+n-1) \\ &+(n+2)(a+n)(a+n-1)(b+n)(b+n-1)(c+n-1) \\ = (e+d-c-b-a)(e+d-c-b-a+1)n^5 \\ &+2(e+d-c-b-a+1)(de-bc-ac-ab+1)n^4 \\ &+((d^2+d-1)e^2+(d^2+((-2b-2a)c-2ab+1)d) \\ &+((-2a-2)b-2a+4)c+(4-2a)b+4a-3)e-d^2 \\ &+(((-2a-2)b-2a+4)c+(4-2a)b+4a-3)d \\ &+(b^2+(4a+1)b+a^2+a-3)c^2+((4a+1)b^2+(4a^2-9)b) \\ &+a^2-9a+7)c+(a^2+a-3)c^2+((4a+1)b^2+(4a^2-9)b) \\ &+a^2-9a+7)c+(a^2+a-3)b^2+(a^2-9a+7)b-3a^2 \\ &+(a-4)n^3 \\ &+((d^2-d)e^2+(-d^2+(((-2a-2)b-2a+4)c+(4-2a)b+4a-3)d \\ &+((2a+1)b^2+(2a^2+4a-5)b+a^2-5a+2)c^2+((2a^2+4a-5)b^2 \\ &+((2a+1)b^2+(2a^2+4a-5)b+a^2-5a+2)c^2+((2a^2+4a-5)b^2 \\ &+((4a^2-20a+11)b-5a^2+11a-4)c+(a^2-5a+2)b^2 \\ &+((6a^2-2a)a+11)b-5a^2+11a-4)c+(a^2-5a+2)d \\ &+((((2a+a)b+2a)c+2ab-2)d+((2-2a)b+2a-2)c+(2a-2)b \\ &-2a+2)e+(((2-2a)b+2a-2)c+(2a-2)b-2a+2)d \\ &+((a^2+3a-2)b^2+(3a^2-7a+2)b-2a^2+2a)c^2 \\ &+((a^2+3a-2)b^2+(3a^2-7a+2)b-2a^2+2a)c^2 \\ &+((3a^2-7a+2)b^2+(-7a^2+11a-2)b+2a^2-2a)c \\ &+(2a-2a^2)b^2+(2a^2-2a)b)n \\ &-2(a-1)(b-1)(c-1)(de-abc) \end{split}$$

Our aim is to check that P(n) is non-negative for all  $n \ge 1$ . After few steps of calculation, we get

$$\begin{array}{rcl} T(n) & \geq & \left( \left( 5\,d^2 + 9\,d + 2 \right)\,e^2 + \left( 9\,d^2 + \left( \left( \left( -8\,a - 8 \right)\,b - 8\,a \right)\,c - 8\,a\,b + 13 \right)\,d \\ & + \left( \left( -16\,a - 8 \right)\,b - 8\,a \right)\,c - 8\,a\,b + 2 \right)\,e + 2\,d^2 + \left( \left( \left( -16\,a - 8 \right)\,b - 8\,a \right)\,c \\ & - 8\,a\,b + 2 \right)\,d + \left( \left( a^2 + 7\,a + 3 \right)\,b^2 + \left( 7\,a^2 + 13\,a + 3 \right)\,b + 3\,a^2 + 3\,a \right)\,c^2 \\ & + \left( \left( 7\,a^2 + 13\,a + 3 \right)\,b^2 + \left( 13\,a^2 - 5\,a - 5 \right)\,b + 3\,a^2 - 5\,a \right)\,c \\ & + \left( 3\,a^2 + 3\,a \right)\,b^2 + \left( 3\,a^2 - 5\,a \right)\,b \right)\,n \\ & + \left( -3\,d^2 - 7\,d - 2 \right)\,e^2 + \left( -7\,d^2 + \left( \left( 8\,b + 8\,a \right)\,c + 8\,a\,b - 11 \right)\,d + \left( \left( 8\,a + 8 \right)\,b + 8\,a \right)\,c \\ & + 8\,a\,b - 2 \right)\,e - 2\,d^2 + \left( \left( \left( 8\,a + 8 \right)\,b + 8\,a \right)\,c + 8\,a\,b - 2 \right)\,d + \left( \left( 2\,a^2 - 4\,a - 3 \right)\,b^2 \\ & + \left( -4\,a^2 - 10\,a - 3 \right)\,b - 3\,a^2 - 3\,a \right)\,c^2 + \left( \left( -4\,a^2 - 10\,a - 3 \right)\,b^2 \\ & + \left( 5 - 10\,a^2 \right)\,b - 3\,a^2 + 5\,a \right)\,c + \left( -3\,a^2 - 3\,a \right)\,b^2 + \left( 5\,a - 3\,a^2 \right)\,b \end{array}$$

Put n = 1, we have

$$T(1) \geq (2d^{2}+2d) e^{2} + (2d^{2}+(2-8abc) d - 8abc) e - 8abcd + ((3a^{2}+3a) b^{2} + (3a^{2}+3a) b) c^{2} + ((3a^{2}+3a) b^{2} + (3a^{2}-5a) b) c \geq 0$$

Hence by hypothesis, the following inequalities holds true

$$P(n) \ge Q(n) \ge R(n) \ge S(n) \ge T(n) \ge T(1) \ge 0$$

Therefore sequences  $\{B_n\}$  and  $\{nA_n - (n+1)A_{n+1}\}$ , is non-increasing. We deduce that f is starlike by Lemma 5. Also the function f is close-to-convex with respect to  $-\log(1-z)$ . Since the conditions of Lemma 6 are verified.

**Theorem 16.** Let a, b, and c > 0. Suppose that

$$d + e \ge max\{T_1(a, b, c), T_2(a, b, c), T_3(a, b, c)\}$$

where

$$\begin{array}{rcl} T_1(a,b,c) &=& (e+d-c-b-a+1) \ (e+d-c-b-a+2) \,, \\ T_2(a,b,c) &=& 2 \ (e+d-c-b-a+2) \ (de+2\,e+2\,d-b\,c-a\,c-c-a\,b-b-a+1) \,, \\ T_3(a,b,c) &=& \left( \left( d^2+7\,d+5 \right) \ e^2 + \left( 7\,d^2 + \left( (-2\,b-2\,a-4) \ c+(-2\,a-4) \ b-4\,a+21 \right) \ d \right. \\ &+ \left( (-2\,a-6) \ b-6\,a-4 \right) \ c+(-6\,a-4) \ b-4\,a+9 \right) \ e+5\,d^2 \\ &+ \left( (((-2\,a-6) \ b-6\,a-4) \ c+(-6\,a-4) \ b-4\,a+9 \right) \ d \\ &+ \left( b^2 + \left( 4\,a+3 \right) \ b+a^2+3\,a+1 \right) \ c^2 + \left( \left( 4\,a+3 \right) \ b^2 \\ &+ \left( 4\,a^2+4\,a-5 \right) \ b+3\,a^2-5\,a-3 \right) \ c+\left( a^2+3\,a+1 \right) \ b^2 \\ &+ \left( 3\,a^2-5\,a-3 \right) \ b+a^2-3\,a+2 \right) \end{array}$$

and satisfies

$$T(a, b, c, d, e) = (2d^{2} + 2d) e^{2} + (2d^{2} + (2 - 4abc) d - 4abc) e - 4abcd + ((a^{2} + a) b^{2} + (a^{2} + a) b) c^{2} + ((a^{2} + a) b^{2} + (a^{2} - 3a) b) c \ge 0$$

then the Alexander transform is defined by (1) is in  $KS^*$ .

Proof. Let  $f(z) = z_3 F_2(a, b, c; d, e; z)$ , then from the definition of hypergeometric function  ${}_3F_2$ , we have

$$f(z) = \sum_{n=1}^{\infty} \frac{(a)_{n-1}(b)_{n-1}(c)_{n-1}}{(d)_{n-1}(e)_{n-1}(1)_{n-1}} z^n$$

so that the corresponding Alexander transform defined by (1) takes the form

$$\Lambda_f(z) = \sum_{n=1}^{\infty} A_n z^n,$$

with  $A_1 = 1$  and

(17) 
$$A_n = \frac{(a)_{n-1}(b)_{n-1}(c)_{n-1}}{n(d)_{n-1}(e)_{n-1}(1)_{n-1}}, \text{ for } n \ge 2.$$

Using the definition of the shifted factorial notation, we have

$$A_{n+1} = \frac{(a)_n (b)_n (c)_n}{(n+1)(d)_n (e)_n (1)_n}$$

and

$$(n+1)A_{n+1} = \frac{(a+n-1)(b+n-1)(c+n-1)}{(d+n-1)(e+n-1)}A_n$$

After some simplification,

$$nA_n - (n+1)A_{n+1} = nA_n - \frac{(a+n-1)(b+n-1)(c+n-1)}{(d+n-1)(e+n-1)}A_n$$
  
=  $A_n \left[ \frac{n(d+n-1)(e+n-1) - (a+n-1)(b+n-1)(c+n-1)}{(d+n-1)(e+n-1)} \right]$   
=  $\frac{A_n U(n)}{(d+n-1)(e+n-1)}$ 

where

By hypothesis,  $d + e \ge a b + b c + a c - a b c$  and so for every  $n \ge 1$ ,

$$U(n) \ge U(1) = de - abc \ge 0$$

and since  $de \ge abc$ , we proved that the above condition satisfied. Thus the sequence  $\{nA_n\}$  is decreasing. Next, we prove that  $\{nA_n - (n+1)A_{n+1}\}$  is also decreasing.

Let  $B_n = nA_n - (n+1)A_{n+1}$ . Then after some manipulation, we get

$$B_n - B_{n+1} = \frac{A_n U(n)}{(d+n-1)(e+n-1)} - \frac{A_{n+1}U(n+1)}{(d+n)(e+n)}$$
  
=  $\frac{A_n U(n)}{(d+n-1)(e+n-1)} - \frac{A_n U(n+1)}{(d+n)(e+n)(n+1)}$   
 $\times \left(\frac{(a+n-1)(b+n-1)(c+n-1)}{(d+n-1)(e+n-1)}\right)$   
=  $\frac{A_n C(n)}{(d+n-1)(c+n-1)(d+n)(e+n)(n+1)}$ 

where

$$\begin{split} C(n) &= U(n)(d+n)(e+n)(n+1) - U(n+1)(a+n-1)(b+n-1)(c+n-1) \\ &= (e+d-c-b-a+1) \ (e+d-c-b-a+2) \ n^4 \\ &+ (e+d-c-b-a+2) \ (de-bc-ac+c-ab+b+a-1) \ n^3 \\ &+ 2 \ (e+d-c-b-a+2) \ (de-bc-ac+c-ab+b+a-1) \ n^2 \\ &+ ((d^2-d) \ e^2 + (-d^2 + ((2-2ab) \ c+2b+2a-3) \ d \\ &+ ((2-2a) \ b+2a-2) \ c+ (2a-2) \ b-2a+2) \ e \\ &+ (((2-2a) \ b+2a-2) \ c+ (2a-2) \ b-2a+2) \ d \\ &+ (((2a-1) \ b^2 + (2a^2-4a+1) \ b-a^2+a) \ c^2 \\ &+ ((2a^2-4a+1) \ b^2 + (-4a^2+6a-1) \ b+a^2-a) \ c \\ &+ (a-a^2) \ b^2 + (a^2-a) \ b) \ n \\ &- (a-1) \ (b-1) \ (c-1) \ (2de-abc) \end{split}$$

Our aim is to check that C(n) is non-negative for all  $n \ge 1$ . After manipulation, we get

$$\begin{split} F(n) &\geq \left( \left( 3\,d^2 + 7\,d + 2 \right)\,e^2 + \left( 7\,d^2 + \left( \left( \left( -2\,a - 4 \right)\,b - 4\,a \right)\,c - 4\,a\,b + 11 \right)\,d \right. \\ &+ \left( \left( -6\,a - 4 \right)\,b - 4\,a \right)\,c - 4\,a\,b + 2 \right)\,e + 2\,d^2 + \left( \left( \left( -6\,a - 4 \right)\,b - 4\,a \right)\,c \right. \\ &- 4\,a\,b + 2 \right)\,d + \left( \left( 2\,a + 1 \right)\,b^2 + \left( 2\,a^2 + 4\,a + 1 \right)\,b + a^2 + a \right)\,c^2 \\ &+ \left( \left( 2\,a^2 + 4\,a + 1 \right)\,b^2 + \left( 4\,a^2 - 4\,a - 3 \right)\,b + a^2 - 3\,a \right)\,c \\ &+ \left( a^2 + a \right)\,b^2 + \left( a^2 - 3\,a \right)\,b \right)\,n \\ &+ \left( -d^2 - 5\,d - 2 \right)\,e^2 + \left( -5\,d^2 + \left( \left( \left( 4 - 2\,a \right)\,b + 4\,a \right)\,c + 4\,a\,b - 9 \right)\,d \\ &+ \left( \left( 2\,a + 4 \right)\,b + 4\,a \right)\,c + 4\,a\,b - 2 \right)\,e - 2\,d^2 + \left( \left( \left( 2\,a + 4 \right)\,b + 4\,a \right)\,c \\ &+ 4\,a\,b - 2 \right)\,d + \left( \left( a^2 - a - 1 \right)\,b^2 + \left( -a^2 - 3\,a - 1 \right)\,b - a^2 - a \right)\,c^2 \\ &+ \left( \left( -a^2 - 3\,a - 1 \right)\,b^2 + \left( -3\,a^2 + a + 3 \right)\,b - a^2 + 3\,a \right)\,c \\ &+ \left( -a^2 - a \right)\,b^2 + \left( 3\,a - a^2 \right)\,b \end{split}$$

Put n = 1 in the above, we get

$$F(1) = (2d^{2} + 2d) e^{2} + (2d^{2} + (2 - 4abc) d - 4abc) e - 4abcd + ((a^{2} + a) b^{2} + (a^{2} + a) b) c^{2} + ((a^{2} + a) b^{2} + (a^{2} - 3a) b) c \ge 0$$

For every  $n \ge 1$ ,  $C(n) \ge D(n) \ge E(n) \ge F(n) \ge F(1)$ . Which is true

Therefore, the sequences  $\{B_n\}$  and  $\{nA_n - (n+1)A_{n+1}\}$  are non-increasing. The Alexander transform  $\Lambda_f(z)$  is starlike in unit disc  $\mathbb{D}$  by Lemma 5 and already verified  $\{nA_n\}$  is non-increasing. Therefore, the Alexander transform  $\Lambda_f(z)$  is close-to-convex with respect to  $-\log(1-z)$  using Lemma 6. Thus we have  $\Lambda_f(z) \in KS^*$ . Which completes the proof of Theorem.  $\Box$
