# NONPARAMETRIC ESTIMATION FOR INTERACTING PARTICLE SYSTEMS: MCKEAN-VLASOV MODELS

#### Abstract

We consider a system of $N$ interacting particles, governed by transport and diffusion, that converges in a mean-field limit to the solution of a McKean-Vlasov equation. From the observation of a trajectory of the system over a fixed time horizon, we investigate nonparametric estimation of the solution of the associated nonlinear Fokker-Planck equation, together with the drift term that controls the interactions, in a large population limit $N \rightarrow \infty$. We build data-driven kernel estimators and establish oracle inequalities, following Lepski's principle. Our results are based on a new Bernstein concentration inequality in McKean-Vlasov models for the empirical measure around its mean, possibly of independent interest. We obtain adaptive estimators over anisotropic Hölder smoothness classes built upon the solution map of the Fokker-Planck equation, and prove their optimality in a minimax sense. In the specific case of the Vlasov model, we derive an estimator of the interaction potential and establish its consistency.

## 1. Introduction

1.1. Setting. We continuously observe a stochastic system of $N$ interacting particles

\end{equation*}

evolving in an Euclidean ambient space $\mathbb{R}^{d}$, that solves

d X_{t}^{i}=b\left(t, X_{t}^{i}, \mu_{t}^{N}\right) d t+\sigma\left(t, X_{t}^{i}\right) d B_{t}^{i}, \quad 1 \leq i \leq N, t \in[0, T]  \tag{2}\\
\mathcal{L}\left(X_{0}^{1}, \ldots, X_{0}^{N}\right)=\mu_{0}^{\otimes N}
\end{array}\right.
$$

where $\mu_{t}^{N}=N^{-1} \sum_{i=1}^{N} \delta_{X_{t}^{i}}$ is the empirical measure of the system. The $B^{i}$ are independent $\mathbb{R}^{d}$-valued Brownian motions, and the transport and diffusion coefficients $b$ and $\sigma$ are sufficiently regular so that $\mu_{t}^{N} \rightarrow \mu_{t}$ weakly as $N \rightarrow \infty$, where $\mu_{t}$ is a weak solution of the parabolic nonlinear equation

\mu_{t=0}=\mu_{0}
\end{array}\right.
$$

see Section 2 below. In this context, we are interested in estimating nonparametrically from data (1) the solution $(t, x) \mapsto \mu_{t}(x)$ of (3) and the drift function $(t, x, \mu) \mapsto b(t, x, \mu) \in \mathbb{R}^{d}$ at the value $(t, x, \mu)=\left(t, x, \mu_{t}\right)$. The time horizon $T$ is fixed and asymptotics are taken as $N \rightarrow \infty$.

A particular case of interest is a homogeneous drift with a linear dependence in the measure argument. The drift term in (2) then takes the form

for some function $\widetilde{b}: \mathbb{R}^{d} \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$. In the paper, when we specialise on this case, we consider $\widetilde{b}$ of the form

\widetilde{b}(x, y)=F(x-y)+G(x)
$$

for some regular $F, G: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$. In this case, we have

$$
b\left(t, X_{t}^{i}, \mu_{t}^{N}\right)=F \star \mu_{t}^{N}\left(X_{t}^{i}\right)+G\left(X_{t}^{i}\right)
$$

where $\star$ denotes convolution. The function $F$ plays the role of an interaction force applied to the particle system while $G$ accounts for an external force in the motion of each particle. If the forces $F$ and $G$ derive from smooth potentials $V, W: \mathbb{R}^{d} \rightarrow \mathbb{R}$, the interaction then takes the form $F(x)=-\nabla W(x)$ and we have a confinement $G(x)=-\nabla V(x)$, see $e . g$. [5, 34, 17]. However, we work on a fixed time horizon $[0, T]$ in the paper, and will not need this point of view 1 .

In the semi-linear representation (4), we are interested in estimating nonparametrically from data (1) the interaction force $x \mapsto F(x)$; the parameter $x \mapsto G(x)$ is considered as a nuisance.
1.2. Motivation. Stochastic systems of interacting particles and associated nonlinear Markov processes in the sense of McKean [53] date back to the 1960's and originated from statistical physics in plasma physics. Their importance in probability theory progressively grew in the following decades, and a versatility of fundamental tools were developed in this context like e.g. coupling methods, geometric inequalities, propagation of chaos, concentration and fluctuations in abstract functional spaces, see Sznitman [63, 12], Tanaka and Hitsuda [64], Fernandez et al. [24], Méléard [54], Malrieu [50], Cattiaux et al. [17], Bolley et al. [8], among a myriad of references. However, until the early 2000's, a modern formulation of a statistical inference program in this context was out of reach (with some notable exceptions like e.g. Kasonga [41]), at least for two reasons: first, the fine probabilistic tools required for nonparametric adaptive estimation were still in full development; second and perhaps more importantly, microscopic particles systems issued from statistical physics are not naturally observable and the motivation for statistical inference is not obvious in this context. The situation progressively evolved around the 2010's, with the start of a kind of renaissance of McKean-Vlasov type models in several application fields that model collective and observable dynamics, ranging from mathematical biology (neurosciences, Baladron et al. [3], structured models in population dynamics, Mogilner et al. [55], Burger et al. [11]) to social sciences (opinion dynamics, Chazelle et al. [19], cooperative behaviours, Canuto et al. [13]) and finance (systemic risk, Fouque and Sun [25]). More recently, mean-field games (Cardaliguet et al. [14], Cardaliaguet and Lehalle [15]) appear as a new frontier for statistical developments, see in particular the recent contribution of Giesecke [30]. The field has reached enough maturity for the necessity and interest of a systematic statistical inference program, starting with nonparametric estimation. This is the topic of the paper.

Parallel to understanding collective dynamics from a statistical point of view, some interest in the study of statistical models related to PDE's has progressively emerged over the last decade. Typical examples include nonparametric Bayes and uncertainty quantification for inverse problems, see Abraham and Nickl [1], Monard et al. [56], Nickl [59, 58], and the references therein, or inference in structured models from microscopic data (Doumic et al. [22, 23], Hoffmann and Olivier [36], Boumezoued et al. [9], Ngoc et al. [35], Maïda et al. [49]). The analysis of elliptic, parabolic or transport-fragmentation equations sheds new light on the underlying nonparametric structure of companion statistical experiments and enrich the classical theory. To that extent, we provide in this paper a first step in that direction for a certain kind of nonlinear parabolic equations, in the sense of McKean [53]. Finally, our work can also be embedded in the framework of functional data analysis, where we observe $N$ diffusion processes with common dynamics, see

[^0]e.g. the recent work of Comte and Genon-Catalot [21] formally contained in our framework, for $d=1$ and in absence of interactions in the drift $b$.
1.3. Results and organisation of the paper. In Section2, we detail the notations and assumptions of the model and build kernel estimators for $\mu_{t}(x)$ and $b\left(t, x, \mu_{t}\right)$. Whereas the estimation for $\mu_{t}$ is standard, the estimation of the drift requires a smoothing in both time and space of the empirical measure $\pi^{N}(d t, d x)=N^{-1} \sum_{i=1}^{N} \delta_{X_{t}^{i}}(d x) X^{i}(d t)$, that estimates the intermediate function $\pi(t, x)=b\left(t, x, \mu_{t}\right) \mu_{t}(x)$. We then use a quotient estimator to recover $b$.

In Section 3, we adopt the Goldenshluger-Lepski method [31, 32, 33] to tune the bandwidths of both estimators in a data driven way and obtain oracle inequalities in Theorems 7 and 9 for both $\mu$ and $b$. We further develop a minimax theory in Section 4 when $\mu$ and $b$ belong to anisotropic Hölder spaces in time and space variable, that are built upon the solution of the parabolic nonlinear limiting equation (3) and prove the optimality and smoothness adaptivity or our estimators in Theorems 14 and 15 . We finally explore in Section 5 the identification of the interaction force $F$ in the Vlasov model where the drift takes the form $b(x, \mu)=F \star(x) \mu+G(x)$, for some sufficiently well localised functions $F$ and $G$. We prove in Theorem 17 that one can consistently estimate $F$ (hence $G$ ) by means of a Fourier type estimator, inspired by blind deconvolution methods, see e.g. Johannes [37].

We develop the probabilistic tools we need to undertake our statistical estimates in Section 6. We study the fluctuations of $\mu_{t}^{N}$ around its mean $\mu_{t}$ in Theorem 18, with time dependent extension to the fluctuations of $\mu_{t}^{N}(d x) \rho(d t)$ around $\nu(d t, d x)=\mu_{t}(d x) \rho(d t)$ for arbitrary weight measures $\rho(d t)$. We prove a Bernstein concentration inequality that reads

over test functions $\phi$ and for some $\kappa_{i}=\kappa_{i}\left(T, \sigma, b, \mu_{0}\right)>0$. It improves on variance estimates based on coupling or geometric inequalities that usually need $\phi$ to be 1-Lipschitz, whereas nonparametric statistical estimation requires $\phi=\phi_{N}$ to mimic a Dirac mass as $N \rightarrow \infty$ that can be controlled in $L^{2}$-norm but behaves badly in Lipschitz norm. Bernstein's inequality for a range of deviation valid for all $x \geq 0$ is also the gateway to nonparametric adaptive estimation; it is not provided by concentration in Wasserstein distance like in Bolley et al. [8] that moreover has the drawback of adding an additional unavoidable dimensional penalty in the rates of convergence.

Our method of proof avoids coupling by relying on a Girsanov argument, following classical ideas, recently revisited for instance by Lacker [44], a key reference for our work. We classically require strong ellipticity for the diffusion coefficient and Lipschitz continuity in the space variable. As for the drift, we assume at least Lipschitz continuity

in Wasserstein-1 metric $\mathcal{W}_{1}$. In our approximation argument, the logarithm of the Girsanov density between the law of the data and a companion coupled system of independent particles is of order $N \int_{0}^{T} \int_{\mathbb{R}^{d}}\left|b\left(s, x, \mu_{s}^{N}\right)-b\left(s, x, \mu_{s}\right)\right|^{2} \mu_{s}^{N}(d x) d s \lesssim N \sup _{0 \leq t \leq T} \mathcal{W}_{1}\left(\mu_{t}^{N}, \mu_{t}\right)^{2}$ for which we need
sharp integrability properties uniformly in $N$. In order to circumvent the unavoidable dimensional effect of the approximation $\mathcal{W}_{1}\left(\mu_{t}^{N}, \mu_{t}\right) \approx N^{-1 / \max (2, d)}$, see Fournier and Guillin [26], we assume moreover $k$-linear differentiability for $b$ in the measure variable, see Assumption 4 in Section 2 This enables us to control by a sub-Gaussianity argument for $U$-statistics each term of a Taylor-like expansion of $b\left(t, x, \mu_{t}^{N}\right)-b\left(t, x, \mu_{t}\right)$ in the measure variable; we obtain the desired result, provided $k \geq d / 2$ (with a special modification in dimension $d=2$ ). In particular, in the Vlasov model, we formally have $k=\infty$ and the result is valid in all dimension $d \geq 1$.

Section 6and 7are devoted to the proofs and an Appendix (Section 8) contains auxiliary technical results.

## 2. MODEL ASSUMPTIONS AND CONSTRUCTION OF ESTIMATORS

2.1. The system of interacting particles and its limit. We fix an integer $d \geq 1$ and a time horizon $T>0$. The random processes take their values in $\mathbb{R}^{d}$. We write $|\cdot|$ for the Euclidean distance (on $\mathbb{R}$ or $\mathbb{R}^{d}$ ) or sometimes for the modulus of a complex number, and $x^{\top} x=|x|^{2}$.

Functions. We consider functions that are mappings defined on products of metric spaces (typically $[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{1}$ or subsets of these) with values in $\mathbb{R}$ or $\mathbb{R}^{d}$. Here, $\mathcal{P}_{1}$ denotes the set of probability measures on $\mathbb{R}^{d}$ with a first moment, endowed with the Wasserstein 1-metric

\mathcal{W}_{1}(\mu, \nu)=\inf _{m \in \Gamma(\mu, \nu)} \int_{\mathbb{R}^{d} \times \mathbb{R}^{d}}|x-y| m(d x, d y)=\sup _{|\phi|_{\text {Lip }} \leq 1} \int_{\mathbb{R}^{d}} \phi d(\mu-\nu)
$$

where $\Gamma(\mu, \nu)$ denotes the set of probability measures on $\mathbb{R}^{d} \times \mathbb{R}^{d}$ with marginals $\mu$ and $\nu$. All the functions in the paper are implicitly measurable with respect to the Borel-sigma field induced by the product topology. $\mathrm{A} \mathbb{R}^{d}$-valued function $f$ is written componentwise as $f=\left(f^{k}\right)_{1 \leq k \leq d}$ where the $f^{k}$ are real-valued. The product $f \otimes g$ of two $\mathbb{R}^{d}$-valued functions is the $\mathbb{R}^{d}$-valued function with $\mathbb{R}^{2 d}$ variables with components $(f \otimes g)^{k}(x, y)=f^{k}(x) g^{k}(y)$. If $f:[0, T] \times \mathbb{R}^{d} \rightarrow \mathbb{R}$, we set $|f|_{\infty}=\sup _{t, x}|f(t, x)|$ and $|f|_{p}=\left(\int_{[0, T] \times \mathbb{R}^{d}}|f(t, x)|^{p} d x d t\right)^{1 / p}$ for $1 \leq p<\infty$. Depending on the context, if $f:[0, T] \rightarrow \mathbb{R}$ or $f: \mathbb{R}^{d} \rightarrow \mathbb{R}$ is a function of time or space only, we sometimes write $|f|_{p}$ for $\left(\int_{0}^{T}|f(t)|^{p} d t\right)^{1 / p}$ or $\left(\int_{\mathbb{R}^{d}}|f(x)|^{p} d x\right)^{1 / p}$ when no confusion is possible.

Constants. We repeatedly use positive quantities $\kappa_{i}, \varpi_{i}, C_{i}, i=1,2, \ldots$ that do not depend on $N$, that we call constants, but that actually may (continuously) depend on model parameters. In most cases, they are explicitly computable. We also use special letters like $\kappa, \delta, \tau, c_{ \pm}, \ldots$, but they will only appear once. The generic notation $C$ is sometimes used before it is set depending on a model parameter. The notation $\varpi_{i}$ stands for quantities that need to be tuned in an algorithm (like an estimator).

Assumptions. We work under strong ellipticity and Lipschitz smoothness assumptions on the diffusion matrix $\sigma:[0, T] \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d} \otimes \mathbb{R}^{d}$ and the drift $b:[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{1} \rightarrow \mathbb{R}^{d}$, as well as strong integrability properties for the initial condition $\mu_{0}$.

Assumption 1. For some $\gamma_{0}>0, \gamma_{1} \geq 1$, the initial condition $\mu_{0}$ satisfies

Assumption 2. The diffusion matrix $\sigma$ is measurable and for some $C \geq 0$, we have

Moreover, $c=\sigma \sigma^{\top}$ is such that $\sigma_{-}^{2}|y|^{2} \leq(c(t, x) y)^{\top} y \leq \sigma_{+}^{2}|y|^{2}$ for some $\sigma_{ \pm}>0$.
As for the regularity of the drift

$$
b:[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{1} \rightarrow \mathbb{R}^{d}
$$

the notion of linear differentiability, commonly used in the literature of mean-field games and McKean-Vlasov equations in order to quantify the smoothness of $\mu \mapsto b(t, x, \mu)$ as a mapping $\mathcal{P}_{1} \rightarrow \mathbb{R}^{d}$ will be the most useful in our setting. We refer in particular to the illuminating section 2.2. in Jourdain and Tse [39] and the references therein.

Definition 3. A mapping $f: \mathcal{P}_{1} \rightarrow \mathbb{R}^{d}$ is said to have a linear functional derivative, if there exists $\delta_{\mu} f: \mathbb{R}^{d} \times \mathcal{P}_{1} \rightarrow \mathbb{R}^{d}$ (sometimes denoted by $\frac{\delta f}{\delta \mu}$ ) such that

with the following smoothness properties

& \left|\partial_{y}\left(\delta_{\mu} f\left(y, \mu^{\prime}\right)-\delta_{\mu} f(y, \mu)\right)\right| \leq C \mathcal{W}_{1}\left(\mu^{\prime}, \mu\right)

for some $C \geq 0$.
We can iterate the process described in (6) and obtain a notion of $k$-linear functional derivative via the existence of mappings

\delta_{\mu}^{\ell} f:\left(\mathbb{R}^{d}\right)^{\ell} \times \mathcal{P}_{1} \rightarrow \mathbb{R}^{d} \text { for } \ell=1, \ldots, k

defined recursively by $\delta_{\mu}^{\ell} f=\delta_{\mu} \circ \delta_{\mu}^{\ell-1} f$ and enjoying associated smoothness properties.
Assumption 4. The drift $b:[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{1} \rightarrow \mathbb{R}^{d}$ is measurable and

Moreover, one of the following three conditions is satisfied for some $C>0$ :
(i) (Lipschitz continuity.) We have $d=1$ and

\left|b\left(t, x^{\prime}, \mu^{\prime}\right)-b(t, x, \mu)\right| \leq C\left(\left|x^{\prime}-x\right|+\mathcal{W}_{1}\left(\mu^{\prime}, \mu\right)\right)

(ii) (Existence of a functional derivative of order $k$.) Let $k \geq 1$. For $(d=1$ and $k \geq 1)$ or $(d=2$ and $k \geq 2)$ or $(d \geq 3$ and $k \geq d / 2)$, we have ( $i$ ) and the map

admits a functional derivative of order $k$ in the sense of Definition 3 Moreover, the following representation holds

where the sum in $m$ is finite with at most $m_{b}$ terms and the mappings $\left(\delta_{\mu}^{k} b\right)_{\mathcal{J}, j, m}:[0, T] \times \mathbb{R}^{d} \times$ $\mathbb{R}^{d} \times \mathcal{P}_{1} \rightarrow \mathbb{R}^{d}$ are such that

\left|\left(\delta_{\mu}^{k} b\right)_{\mathcal{J}, j, m}\left(t, x^{\prime}, y^{\prime}, \mu\right)-\left(\delta_{\mu}^{k} b\right)_{\mathcal{J}, j, m}(t, x, y, \mu)\right| \leq C\left(\left|x^{\prime}-x\right|+\left|y^{\prime}-y\right|\right)
$$

(iii) (Vlasov case.) We have $d \geq 1$ and

b(t, x, \mu)=\int_{\mathbb{R}^{d}} \widetilde{b}(t, x, y) \mu(d y)

for some measurable $\widetilde{b}:[0, T] \times \mathbb{R}^{d} \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ such that:

We let $|b|_{\text {Lip }}$ denote the smallest $C \geq 0$ for which Assumption 4 (i) holds and $\left|\delta_{\mu}^{k} b\right|_{\text {Lip }}$ the smallest constant $C \geq 0$ for which Assumption 4 (ii) holds for the highest order of differentiability.

Remark 5. 1) The representation (7) in Assumption4(ii) is merely technical and enables one to obtain a control in $\mathcal{W}_{1}$-distance of the remainder term in Taylor-like expansions of $b(t, x, \mu)$ in an easy way, see in particular the proof of Proposition 19. Step 2 below. It can presumably be relaxed, but will be sufficient for the level of generality intended in the paper. It accomodates in particular drifts of the form

for smooth mappings $F_{j}(t, x, \cdot): \mathbb{R}^{q_{3}} \rightarrow \mathbb{R}^{d}, G_{j}(t, x, \cdot): \mathbb{R}^{q_{1}} \times \mathbb{R}^{q_{2}} \rightarrow \mathbb{R}^{q_{3}}, H_{j}(t, x, \cdot): \mathbb{R}^{d} \rightarrow \mathbb{R}^{q_{1}}$ and positive measures $\lambda_{j}$ on $\mathbb{R}^{q_{2}}$ in some cases and combinations of these, see Jourdain and Tse [39]. Explicit examples of mean-field models where the structure of the drift is of the form 4 (ii) rather than 4 (i) or (iii) are given for instance in [20, 60, 54, 38]. 2) Condition (iii) is stronger than (ii): under Assumption 4(iii),

thus $\left.\left|b\left(t, x^{\prime}, \mu^{\prime}\right)-b(t, x, \mu)\right|=\mid \int_{\mathbb{R}^{d}} \widetilde{b}\left(t, x^{\prime}, \cdot\right)-\widetilde{b}(t, x, \cdot)\right) d \mu^{\prime}-\int_{\mathbb{R}^{d}} \widetilde{b}(t, x, \cdot) d\left(\mu-\mu^{\prime}\right) \mid \leq C\left(\left|x^{\prime}-x\right|+\right.$ $\mathcal{W}_{1}\left(\mu^{\prime}, \mu\right)$ ) and Assumption 4 (i) holds true. Moreover $\delta_{\mu} b(t, x, y, \mu)=\widetilde{b}(t, x, y)$ and Assumption 4 (ii) holds true as well.

We let $\mathcal{C}=\mathcal{C}\left([0, T],\left(\mathbb{R}^{d}\right)^{N}\right)$ denote the space of continuous functions on $\left(\mathbb{R}^{d}\right)^{N}$, equipped with the filtration $\left(\mathcal{F}_{t}\right)_{0 \leq t \leq T}$ induced by our observation, namely the canonical mappings

and modified to be right-continuous for safety. For $\mu_{0} \in \mathcal{P}_{1}$, the probability $\mathbb{P}^{N}$ on $\left(\mathcal{C}, \mathcal{F}_{T}\right)$ under which the canonical process $X=\left(X_{t}^{1}, \ldots, X_{t}^{N}\right)_{0 \leq t \leq 1}$ is a weak solution of (2) for the initial condition $\mu_{0}^{\otimes N}$ is uniquely defined under Assumptions 1,2 and 4. Recommended reference (that covers our set of assumptions) is the textbook by Carmona and Delarue [16] or the lectures notes of Lacker [43]).
2.2. Kernel estimators. We pick two bounded and compactly supported kernel functions $H$ : $(0, T) \rightarrow \mathbb{R}$ and $K: \mathbb{R}^{d} \rightarrow \mathbb{R}$ such that

Construction of an estimator of $\mu_{t}(x) \in \mathbb{R}$. Let $\left(t_{0}, x_{0}\right) \in(0, T] \times \mathbb{R}^{d}$. For $h>0$ we obtain a family of estimators of $\mu_{t_{0}}\left(x_{0}\right)$ by setting

Construction of an estimator of $b\left(t, x, \mu_{t}\right) \in \mathbb{R}^{d}$. Let $\left(t_{0}, x_{0}\right) \in(0, T) \times \mathbb{R}^{d}$. Abusing notation slightly, define the $\mathbb{R}^{d}$-valued random measure

i.e. by smoothing componentwise $\pi^{N}(d t, d x)$. We finally estimate $b\left(t_{0}, x_{0}, \mu_{t_{0}}\right)$ by

with $h, h_{i}>0$ and some threshold $\varpi>0$ that prevents the estimator to blow-up for small values of $\widehat{\mu}_{h}^{N}\left(t_{0}, x_{0}\right)$.

## 3. NONPARAMETRIC ORACLE ESTIMATION

Our results involve positive quantities that continuously depend on real-valued parameters of the problem, namely

defined in Assumptions 1, 2 and 4, together with the dimension $d \geq 1$ of the ambient space and the value of the terminal time $T>0$. In the following, the notation $A_{N} \lesssim B_{N}$ means the existence of $C>0$ (possibly depending on $\mathfrak{b}$ but not $N$ ) such that $A_{N} \leq C B_{N}$ for every $N \geq 1$.
3.1. Oracle estimation of $\mu_{t}(x)$. We fix $\left(t_{0}, x_{0}\right) \in(0, T] \times \mathbb{R}^{d}$ and implement a variant of the Goldenshluger-Lepski's algorithm [31, 32, 33] for pointwise estimation. Pick a discrete set

of admissible bandwidths such that $\operatorname{Card}\left(\mathcal{H}_{1}^{N}\right) \lesssim N$. The algorithm, based on Lepski's principle, requires the family of estimators

defined in (9) and selects an appropriate bandwidth $\widehat{h}^{N}$ from data $\mu_{t_{0}}^{N}(d x)$. Writing $\{x\}_{+}=$ $\max (x, 0)$, define

The data driven Goldenshluger-Lepski estimator of $\mu_{t_{0}}\left(x_{0}\right)$ defined by

is specified by $K$ and $\varpi_{1}$.
Remark 6. The choice of the penalty $\mathrm{A}_{h}^{N}$ and the threshold $\mathrm{V}_{h}^{N}$ in (11) and (12) are standard in the GL methodology: $\mathrm{A}_{h}^{N}$ is a kind of proxy for the estimation of the variance of $\widehat{\mu}_{h}^{N}\left(t_{0}, x_{0}\right)$ while $\mathrm{V}_{h}^{N}$ is the exact penalty needed in order to balance the size of the variance of the estimator in $h$, of order $|K|_{2}^{2} N^{-1} h^{-d}$, inflated by a logarithmic term $\log N$ and tuned with $\varpi_{1}>0$. This enables one to control all the stochastic deviation terms. See in particular the proof of Theorem 7 We also refer to the original sources in Goldenshluger and Lepski [31, 32, 33].

Oracle estimate. We need some notation. Given a kernel $K$, the bias at scale $h>0$ of $\mu$ at point $\left(t_{0}, x_{0}\right)$ is defined as

We are ready to give the performance of our estimator of $\mu_{t}(x)$, by means of an oracle inequality.
Theorem 7. Work under Assumptions 1, 2 and 4 Let $\left(t_{0}, x_{0}\right) \in(0, T] \times \mathbb{R}^{d}$. The following oracle inequality holds true:

$$

for large enough $N$, up to a constant depending on $\left(t_{0}, x_{0}\right),|K|_{\infty}$ and $\mathfrak{b}$, provided $\widehat{\mu}_{\mathrm{GL}}^{N}\left(t_{0}, x_{0}\right)$ is calibrated with $\varpi_{1} \geq 16 \kappa_{2}^{-1} \kappa_{3}$, where $\kappa_{2}$ is specified in Theorem 18 and $\kappa_{3}$ is a (local) upper bound of $\mu_{t_{0}}$, see Lemma 23 below.

Some remarks are in order: 1) Up to an inessential logarithmic factor, our estimator achieves the optimal bias-variance tradeoff among every possible bandwidth $h \in \mathcal{H}_{1}^{N}$. 2) The requirement $N h^{d} \geq(\log N)^{2}$ for $h \in \mathcal{H}_{1}^{N}$ could be tightened to $N h^{d} \geq(\log N)^{1+\epsilon}$ for an arbitrary $\epsilon>0$; this is slightly more stringent than the usual bound $N h^{d} \geq \log N$ in the literature [31, 32, 33], but this has no consequence for the subsequent minimax results. 3) The choice of a pointwise loss function at $\left(t_{0}, x_{0}\right)$ is inessential here: other integrated norms like $|\cdot|_{p}$ would work as well, following the general strategies of Lepski's principle. 4) The construction of the estimator of $\mu_{t_{0}}\left(x_{0}\right)$ requires a lower bound on $\varpi_{1}$ that has to be set prior to the data analysis. The bound we obtain are presumably too large. In practice, $\varpi_{1}$ has to be tuned by other methods, possibly using data. Such approaches in the context of Lepski's methods have been recently introduced by Lacour et al. [45]. This weakness is common to all nonparametric methods that depend on a data-driven bandwidth.
3.2. Oracle estimation of $b\left(t, x, \mu_{t}\right)$. Similarly to the estimation of $\mu_{t}(x)$, we pick a discrete set

We assume that $\mathcal{H}_{2}^{N}$ is equipped with some ordering $\preceq$ such that for every $\boldsymbol{h}, \boldsymbol{h}^{\prime} \in \mathcal{H}_{2}^{N}$, we have either $\boldsymbol{h} \preceq \boldsymbol{h}^{\prime}$ or $\boldsymbol{h}^{\prime} \preceq \boldsymbol{h}$. The construction uses $\widehat{\mu}_{\mathrm{GL}}^{N}\left(t_{0}, x_{0}\right)$, given in addition the family of estimators

\end{equation*}

The data-driven Goldenshluger-Lepski estimator of $b\left(t_{0}, x_{0}, \mu_{t_{0}}\right)$ is defined as

\end{equation*}

and is specified by $H, K, \varpi_{1}, \varpi_{2}$ and the threshold $\varpi_{3}>0$ that prevents the estimator to blow-up for small values of $\widehat{\mu}_{\widehat{h}^{N}}\left(t_{0}, x_{0}\right)$.
Remark 8. The same comments as in Remark 6 apply here for the specification of $\mathrm{A}_{h}^{N}$ in (16) and $\mathrm{V}_{h}^{N}$ in (17), noting that in the anisotropic case, the variance of $\widehat{\pi}_{h}^{N}\left(t_{0}, x_{0}\right)$ is now of order $|H \otimes K|_{2}^{2} N^{-1} h_{1}^{-1} h_{2}^{-d}$.

Oracle estimates. Given a kernel $H \otimes K$, the bias at scale $\boldsymbol{h}$ of $\pi=b \mu$ at point $\left(t_{0}, x_{0}\right)$ is defined as

\end{equation*}

We are ready to give an oracle bound for the estimation of $b\left(t, x, \mu_{t}\right)$.

Theorem 9. Work under Assumptions 1, 2and 4 Let $\left(t_{0}, x_{0}\right) \in(0, T) \times \mathbb{R}^{d}$. The following oracle inequality holds

\mathbb{E}_{\mathbb{P}^{N}}\left[\left|\widehat{b}_{\mathrm{GL}^{N}}^{N}\left(t_{0}, x_{0}\right)-b\left(t_{0}, x_{0}, \mu_{t_{0}}\right)\right|^{2}\right] \lesssim \min _{h \in \mathcal{H}_{1}^{N}}\left(\mathcal{B}_{h}^{N}(\mu)\left(t_{0}, x_{0}\right)^{2}+\mathrm{V}_{h}^{N}\right)+\min _{\boldsymbol{h} \in \mathcal{H}_{2}^{N}}\left(\mathcal{B}_{h}^{N}(\pi)\left(t_{0}, x_{0}\right)^{2}+\mathrm{V}_{\boldsymbol{h}}^{N}\right),
$$

for large enough $N$, up to a constant depending on $\left(t_{0}, x_{0}\right),|H \otimes K|_{\infty}$, and $\mathfrak{b}$, provided

where $\kappa_{2}$ is defined in Theorem 18 and $\kappa_{3}, \kappa_{4}, \kappa_{5}$ are (local) upper or lower bounds on $\mu$ and $b$ defined in Lemma 23 below.

Some remarks: 1) The same remarks as 1), 2), $\mathbf{3}$ and 4) after Theorem 7 are in order. This includes the calibration of $\varpi_{2}, \varpi_{3}$ and the requirement $N h_{1} h_{2}^{d} \geq(\log N)^{2}$ for $h \in \mathcal{H}_{2}^{N}$ that could be tightened to $N h_{1} h_{2}^{d} \geq(\log N)^{1+\epsilon}$ for an arbitrary $\epsilon>0$. However, the requirement $h_{1} \leq(\log N)^{-2}$ is a bit unusual and necessary for technical reason: it enables us to manage the delicate term $I I$ in the proof. Fortunately, this has no consequence for the subsequent minimax results, since we always look for oracle bandwidths of the form $N^{-\epsilon}$ that are much smaller than $(\log N)^{-2}$. 2) The estimator $\widehat{b}_{\mathrm{GL}}^{N}$ is a quotient estimator that estimates the ratio of $\pi(t, x)=b\left(t, x, \mu_{t}\right) \mu_{t}(x)$ and $\mu_{t}(x)$, very much in the sense of a Nadaraya-Watson (NW) type estimator in regression [57]. Its performance is similar to the worst performance of the estimation of the product $\pi$ and $\mu$. However, the smoothness of $\mu$ is usually no worse than the smoothness of $b$ and we do not lose in terms of approximation results, see Section 4 and Proposition 13 below for the formulation of a minimax theory in this setting.

## 4. ADAPTIVE MINIMAX ESTIMATION

### 4.1. Anisotropic Hölder smoothness classes for McKean-Vlasov models.

Definition 10. Let $x_{0} \in \mathbb{R}^{d}$ and $U$ a neighbourhood of $x_{0}$. We say that $f: \mathbb{R}^{d} \rightarrow \mathbb{R}$ belongs to $\mathcal{H}^{\alpha}\left(x_{0}\right)$ with $\alpha>0$ if for every $x, y \in U$

$$
\begin{equation*}
\left|D^{s} f(y)-D^{s} f(x)\right| \leq C|y-x|^{\alpha-\lfloor\alpha\rfloor} \tag{20}
\end{equation*}
$$

for any such that $|s| \leq\lfloor\alpha\rfloor$, the largest integer strictly smaller than $\alpha ; s \in \mathbb{N}^{d}$ is a multi-index with $|s|=s_{1}+\ldots+s_{d}$ and $D^{s}=\frac{\partial_{1}^{|s|}}{\partial_{1}^{s_{1}^{1}} \ldots \partial_{d}^{\delta d}}$.

The definition depends on $x_{0}$ via $U$ but this is further omitted in the notation for simplicity. We obtain a semi-norm by setting

$$
|f|_{\mathscr{H}^{\alpha}\left(x_{0}\right)}=\sup _{x \in \mathcal{U}}|f(x)|+C(f),
$$

where $C(f)$ is the smallest constant $C$ for which (20) holds. The extension of Definition 10 for $\mathbb{R}^{d}$-valued functions is straightforward by considering coordinate functions. For time-varying functions defined on $(0, T)$ we have the
Definition 11. Let $\left(t_{0}, x_{0}\right) \in(0, T) \times \mathbb{R}^{d}$ and $\alpha, \beta>0$. The function $f:(0, T) \times \mathbb{R}^{d} \rightarrow \mathbb{R}$ belongs to the anisotropic Hölder class $\mathcal{H}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$ if

$$
\begin{equation*}
|f|_{\mathcal{A}^{\alpha, \beta}\left(t_{0}, x_{0}\right)}=\left|f\left(\cdot, x_{0}\right)\right|_{\mathcal{H}^{\alpha}\left(t_{0}\right)}+\left|f\left(t_{0}, \cdot\right)\right|_{\mathcal{H}^{\beta}\left(x_{0}\right)}<\infty . \tag{21}
\end{equation*}
$$

Again, the extension to $\mathbb{R}^{d}$-valued functions is straightforward: a mapping $f=\left(f^{k}\right)_{1 \leq k \leq d}$ : $(0, T) \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ belongs to $\mathscr{H}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$ if $f^{k} \in \mathcal{H}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$ for every $k=1, \ldots, d$.

We model Hölder smoothness classes for the density function $\mu_{t}(x)$ and the drift $b\left(t, x, \mu_{t}\right)$. The McKean-Vlasov model (2) is parametrised by $\left(b, \sigma, \mu_{0}\right)$, or rather $\left(b, c, \mu_{0}\right)$, with $c=\sigma \sigma^{\top}$. We denote by $\mathcal{P}=\mathcal{P}(\mathfrak{b})$ the class of $\left(b, c, \mu_{0}\right)$ satisfying Assumptions 1,2 and 4 with model parameter b. We let

$$
\left(b, c, \mu_{0}\right) \mapsto \mu=\mathcal{S}\left(b, c, \mu_{0}\right)
$$

denote the solution (or forward) map of (3).
Definition 12. Let $\alpha, \beta>0$. The anisotropic Hölder class $\mathcal{S}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$ to the solution of (3) is defined by

$$
\mathcal{S}^{\alpha, \beta}\left(t_{0}, x_{0}\right)=\left\{\left(b, c, \mu_{0}\right) \in \mathcal{P}, \quad \mu=\mathcal{S}\left(b, c, \mu_{0}\right) \in \mathcal{H}^{\alpha, \beta}\left(t_{0}, x_{0}\right)\right\}
$$

Before establishing minimax rates of convergence, we briefly investigate how rich is the class $\mathcal{S}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$. 1) If $b(t, x, \mu)=b(t, x)$ does not involve an interaction, then we have explicit formulas for $\mu$ in some cases when $c$ is regular, see e.g. Genon-Catalot and Jacod [29] and the formulas become relatively tractable in dimension $d=1$, especially when $b(t, x)=b(x), c(t, x)=c(x)$ and $\mu_{0}$ is the invariant distribution of the diffusion process $X_{t}^{i}$ provided it exists. In that case, one can construct $\mu \in \mathcal{H}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$ with arbitrary $\alpha, \beta>0$ for specific choices of $c$ and $b$ thanks to Feller's classification of scalar diffusions (see e.g. Revuz and Yor [61]). 2) For a non-trivial representation of $b(t, x, \mu)$ as in the Vlasov model, we have the following result, that shows how versatile the classes $\mathcal{H}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$ can be.
Proposition 13. Let $c(t, x)=\frac{1}{2} \sigma^{2}$ Id with $\sigma>0$ and $b(t, x, \mu)=b(x, \mu)=F \star \mu(x)+G(x)$, with $F$ having compact support, $\mu_{0} \in \mathcal{P}_{1}$ with a continuous bounded density satisfying Assumption 1 and

$$
|G|_{\mathcal{H}^{\beta}}+|F|_{\mathcal{H}^{\beta^{\prime}}}+\left|\mu_{0}\right|_{\mathscr{H}^{\beta^{\prime \prime}}}<\infty
$$

for some $\beta, \beta^{\prime}>1$ and $\beta^{\prime \prime}>0$ (and $\beta$ non-integer for technical reason). Here, $\mathcal{H}^{\beta}$ denotes the global Hölder space (obtained when taking $\mathcal{U}=\mathbb{R}^{d}$ in Definition 10 . Then, for every $\left(t_{0}, x_{0}\right) \in(0, T) \times \mathbb{R}^{d}$, we have $\mu \in \mathcal{H}^{\alpha, \beta+1}\left(t_{0}, x_{0}\right)$ and $b(\cdot, \cdot, \mu$. $) \in \mathcal{H}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$ with $\alpha=(\beta+1) / 2$.

The proof relies on classical estimates for parabolic equations, see e.g. the textbook by Bogatchev et al. [7]. See also Méléard and Jourdain [38] for analogous results. It is sketched in Appendix. 8.3 .
4.2. Minimax adaptive estimation of $\mu_{t}(x)$. For $\alpha, \beta, L>0$, we set

$$
\begin{equation*}
\mathcal{S}_{L}^{\alpha, \beta}\left(t_{0}, x_{0}\right)=\left\{\left(b, c, \mu_{0}\right) \in \mathcal{P},\left|\mathcal{S}\left(b, c, \mu_{0}\right)\right|_{\mathcal{H}^{\alpha, \beta}\left(t_{0}, x_{0}\right)} \leq L\right\} \tag{22}
\end{equation*}
$$

that shall serve as a smoothness model for the unknown $\mu$, where the semi-norm $|\cdot|_{\mathcal{H}^{\alpha, \beta}\left(t_{0}, x_{0}\right)}$ is defined in (21).

Since the estimator $\widehat{\mu}_{\mathrm{GL}}^{N}\left(t_{0}, x_{0}\right)$ is built on $\mu_{t_{0}}^{N}$ solely and not the whole process $\left(\mu_{t}^{N}\right)_{0 \leq t \leq T}$, we study minimax rates of convergence in restriction to the experiment generated by $\mu_{t_{0}}^{N}$. We have the following adaptive upper bound and accompanying lower bound for estimating $\mu$ :
Theorem 14. Work under Assumptions 1, 2and 4 Let $\widehat{\mu}_{\mathrm{GL}}^{N}\left(t_{0}, x_{0}\right)$ be specified with a kernel $K$ of order $\ell \geq 1$ as defined in (8). For every $\left(t_{0}, x_{0}\right) \in(0, T) \times \mathbb{R}^{d}$, we have,

$$
\begin{equation*}
\sup _{\left(b, c, \mu_{0}\right)}\left(\mathbb{E}_{\mathbb{P}^{N}}\left[\left(\widehat{\mu}_{\mathrm{GL}}^{N}\left(t_{0}, x_{0}\right)-\mu_{t_{0}}\left(x_{0}\right)\right)^{2}\right]\right)^{1 / 2} \lesssim\left(\frac{\log N}{N}\right)^{\beta \wedge \ell /(2 \beta \wedge \ell+d)} \tag{23}
\end{equation*}
$$

for large enough $N$, up to a constant that depends on $\mathfrak{b}, K, \beta$ and $L$ only. Moreover

$$
\begin{equation*}
\inf _{\widehat{\mu}} \sup _{\left(b, c, \mu_{0}\right)} \mathbb{E}_{\mathbb{P}^{N}}\left[\left|\widehat{\mu}-\mu_{t_{0}}\left(x_{0}\right)\right|\right] \gtrsim N^{-\beta /(2 \beta+d)} \tag{24}
\end{equation*}
$$

for large enough $N$. The infimum in (24) is taken over all estimators constructed with $\mu_{t_{0}}^{N}$. The supremum in (23) and (24) is taken over $\mathcal{S}_{L}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$ for arbitrary $\alpha, \beta, L>0$.

Some remarks: 1) We obtain the (nearly) optimal rate of convergence $N^{-\beta /(2 \beta+d)}$ for estimating $\mu_{t_{0}}\left(x_{0}\right)$ as a function of the $d$-dimensional state variable $x_{0}$ for fixed $t_{0}$. The result obviously does not depend on the smoothness of $t \mapsto \mu_{t}\left(x_{0}\right)$ and is constructed from data $\left(X_{t_{0}}^{1}, \ldots, X_{t_{0}}^{N}\right)$ for fixed $t_{0}$. 2) The extra logarithmic payement is unavoidable for pointwise estimation, as a result of the classical Lepski-Low phenomenon [47, 48]. 3) Although the result is stated for arbitrary $\alpha, \beta>0$, the mapping $(t, x) \mapsto \mu_{t}(x)$ is locally smooth; there is no contradiction and result must be understood as bounds that are valid over smooth functions $\mu$ having prescribed $\mathcal{S}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$ semi-norms. 4) Our concentration result Theorem 18 for the fluctuation of $\mu_{t}^{N}$ around $\mu_{t}$ enables us to improve on the estimation result in Proposition 2.1 of Bolley et al. [8] that achieves the (non-adaptive) suboptimal rate $N^{-\beta /(2 \beta+2 d+2)}$. This is due to the fact that Bolley et al. [8] rely on controlling the fluctuations of $\mu_{t}^{N}$ around $\mu_{t}$ in Wasserstein distance, and therefore have to accomodate a dimension effect that we do not have here.
4.3. Minimax adaptive estimation of $b\left(t, x, \mu_{t}\right)$. For $\alpha, \beta>0$ and $L>0$, in analogy to the class $\mathcal{S}_{L}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$ defined in (22) above, we model the smoothness of the function $(t, x) \mapsto b\left(t, x, \mu_{t}\right)$ via the class

$$
\mathcal{D}_{L}^{\alpha, \beta}\left(t_{0}, x_{0}\right)=\left\{\left(b, c, \mu_{0}\right) \in \mathcal{P},\left|b\left(\cdot, \cdot, \mathcal{S}\left(b, c, \mu_{0}\right) .\right)\right|_{\mathcal{H}^{\alpha, \beta}\left(t_{0}, x_{0}\right)} \leq L\right\}
$$

Define the effective anisotropic smoothness $s_{d}(\alpha, \beta)$ by

$$
\frac{1}{s_{d}(\alpha, \beta)}=\frac{1}{\alpha}+\frac{d}{\beta}
$$

We have the following adaptive upper bound and accompanying lower bound for estimating the drift $b$ :

Theorem 15. Work under Assumptions 1,2 and 4 Let $\widehat{b}_{\mathrm{GL}}^{N}\left(t_{0}, x_{0}\right)$ be constructed with kernels $H$ and $K$ of order $\ell \geq 1$. For every $\left(t_{0}, x_{0}\right) \in(0, T) \times \mathbb{R}^{d}$, we have

$$
\begin{equation*}
\sup _{\left(b, c, \mu_{0}\right)}\left(\mathbb{E}_{\mathbb{P}^{N}}\left[\widehat{b}_{\mathrm{GL}}^{N}\left(t_{0}, x_{0}\right)-\left.b\left(t_{0}, x_{0}, \mu_{t_{0}}\right)\right|^{2}\right]\right)^{1 / 2} \lesssim\left(\frac{\log N}{N}\right)^{s_{d}(\alpha, \beta) \wedge \ell_{d} /\left(2 s_{d}(\alpha, \beta) \wedge \ell_{d}+1\right)} \tag{25}
\end{equation*}
$$

for large enough $N$, with $\ell_{d}=\ell / d$, up to constants that depend on $\mathfrak{b}, H \otimes K$ and $\alpha, \beta, L$ only. Moreover,

$$
\begin{equation*}
\inf _{\widehat{b}} \sup _{\left(b, c, \mu_{0}\right)} \mathbb{E}_{\mathbb{P}^{N}}\left[\left|\widehat{b}-b\left(t_{0}, x_{0}, \mu_{t_{0}}\right)\right|\right] \gtrsim N^{-s_{d}(\alpha, \beta) /\left(2 s_{d}(\alpha, \beta)+1\right)} \tag{26}
\end{equation*}
$$

for large enough $N$. The infimum in (26) is taken over all estimators constructed with $\left(\mu_{t}^{N}\right)_{0 \leq t \leq T}$. The supremum in (25) and (26) is taken over $\mathcal{S}_{L}^{\alpha, \beta}\left(t_{0}, x_{0}\right) \cap \mathcal{D}_{L}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$ for some known non-decreasing parametrisation $\alpha=\alpha(\beta)>0$ such that $\alpha(\beta) / \beta$ is non-increasing, with $\beta>0$ and $L>0$.

Some remarks: 1) Theorem 15 establishes that estimating $b\left(t, x, \mu_{t}\right)$ has the same complexity as estimating $d$ functions of $1+d$ variables in the time and space domain. Each component $t \mapsto b^{k}\left(t, x, \mu_{t}\right)$ has smoothness $\alpha$, while $x^{\ell} \mapsto b^{k}\left(t,\left(x^{1}, \ldots, x^{\ell}, \ldots, x^{d}\right), \mu_{t}\right)$ has smoothness $\beta$ for $\ell=1, \ldots, d$, resulting in an anisotropic function $(t, x) \mapsto b^{k}\left(t, x, \mu_{t}\right)$ of $1+d$ variables with smoothness index $(\alpha, \beta, \ldots, \beta)$. We therefore recover the usual anisotropic minimax rate of convergence, with effective smoothness $s_{d}(\alpha, \beta)$ obtained as the arithmetico-geometric mean of the smoothness index $(\alpha, \beta, \ldots, \beta)$. 2) For technical simplicity, we consider $\alpha$ and $\beta$ to be linked, as for instance in Proposition 13 where we have $\alpha=\alpha(\beta)=(\beta+1) / 2$. This somehow weakens our anisotropic adaptation result, but enables us to easily construct a well-behaved ordering $\preceq$
for $\mathcal{H}_{2}^{N}$ that behaves well with respect to the bias at scale $h$ as defined in (19). Dropping this restriction is possible in principle, as in the original paper of Goldenshluger and Lepski [32], yet at a significant additional technical cost. 3) The remarks 2) and 3) of Theorem 14 are valid here as well.

## 5. Estimation of the interaction in the Vlasov model

In this section, we work under Assumptions 1 and 2 with a constant $c(t, x)=\frac{1}{2} \sigma^{2}$ Id for some $\sigma>0$ and Assumption 4 (iii), i.e. in the Vlasov case

$$
b(t, x, \mu)=b(x, \mu)=\int_{\mathbb{R}^{d}} \widetilde{b}(x, y) \mu(d y)
$$

for $d \geq 1$ and with a time homogeneous drift kernel

$$
\widetilde{b}(x, y)=F(x-y)+G(x), \quad x, y \in \mathbb{R}^{d}
$$

Model (2) then reads

$$
\left\{\begin{array}{l}
d X_{t}^{i}=G\left(X_{t}^{i}\right) d t+N^{-1} \sum_{j=1}^{N} F\left(X_{t}^{i}-X_{t}^{j}\right) d t+\sigma d B_{t}^{i}, \quad 1 \leq i \leq N, t \in[0, T] \\
\mathcal{L}\left(X_{0}^{1}, \ldots, X_{0}^{N}\right)=\mu_{0}^{\otimes N}
\end{array}\right.
$$

We assume that each component $F^{k} \in L^{1}\left(\mathbb{R}^{d}\right)$ for every $k=1, \ldots, d$. We are interested in identifying the interaction function $x \mapsto F(x)$ from data (1) and possibly $x \mapsto G(x)$, rather considered here as a nuisance parameter ${ }^{2}$. We have

$$
\begin{align*}
b\left(x, \mu_{t}\right) & =G(x)+\int_{\mathbb{R}^{d}} F(x-y) \mu_{t}(y) d y \\
& =G(x)+F \star \mu_{t}(x) \tag{27}
\end{align*}
$$

where $f \star \mu_{t}(x)=\left(\int_{\mathbb{R}^{d}} f^{k}(x-y) \mu_{t}(y) d y\right)_{1 \leq k \leq d}$ denotes the convolution between $f: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ and $\mu_{t}$.
5.1. Identification of the interaction $F$. Introduce the linear form $\mathcal{L}$ acting on test functions $\varphi$ : $[0, T] \rightarrow \mathbb{C}$ defined by

$$
\begin{equation*}
\mathcal{L} \varphi=\int_{[0, T]} \varphi(t) w(t) \rho(d t) \tag{28}
\end{equation*}
$$

where $\rho$ is a probability distribution on $[0, T]$ and $w:[0, T] \rightarrow \mathbb{R}$ a bounded weight function such that $\int_{[0, T]} w(t) \rho(d t)=0$. Note that $\mathcal{L} 1=0$ where 1 denotes the constant function. Applying $\mathcal{L}$ on both sides of (27), we obtain

$$
\begin{equation*}
\mathcal{L} b(x, \mu)=F \star \mathcal{L} \mu(x) \tag{29}
\end{equation*}
$$

by Fubini's theorem. For $f=\left(f^{k}\right)_{1 \leq k \leq d}: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ with $f^{k} \in L^{1}\left(\mathbb{R}^{d}\right)$, define a Fourier transform

$$
\mathcal{F}(f)(\xi)=\left(\int_{\mathbb{R}^{d}} \mathrm{e}^{-2 i \pi \xi^{\top} x} f^{k}(x) d x\right)_{1 \leq k \leq d}, \quad \xi \in \mathbb{R}^{d}
$$

so that whenever $g \in L^{1}\left(\mathbb{R}^{d}\right)$, we have $\mathcal{F}(f \star g)=\mathcal{F}(f) \cdot \mathcal{F}(g)$. We infer from (29)

$$
\mathcal{F}(\mathcal{L} b(\cdot, \mu))=\mathcal{F}(F) \cdot \mathcal{F}(\mathcal{L} \mu)
$$

[^1]This yields the formal decomposition

$$
\begin{equation*}
\mathcal{F}(F)=\frac{\mathcal{F}(\mathcal{L} b(\cdot, \mu))}{\mathcal{F}(\mathcal{L} \mu)} \tag{30}
\end{equation*}
$$

provided the quotient is well defined.
5.2. Consistent estimation of $F$. A first estimation strategy consists in plugging-in our estimators of $b\left(t, x, \mu_{t}\right)$ and $\mu_{t}$ in (30) above. A somewhat simpler estimator of $\mathcal{F}(\mathcal{L} \mu)(\xi)=\mathcal{L} \mathcal{F}(\mu)(\xi)$ is given by the periodogram

$$
\mathcal{L}\left(\int_{\mathbb{R}^{d}} \mathrm{e}^{-2 i \pi \xi^{\top} x} \mu^{N}(d x)\right)=\int_{\mathbb{R}^{d}} \mathrm{e}^{-2 i \pi \xi^{\top} x} \mathcal{L} \mu^{N}(d x)=\mathcal{F}\left(\mathcal{L} \mu^{N}\right)(\xi)
$$

for which we need not tune a bandwidth. Following Johannes [37], we obtain an estimator of $F$ by the formula

$$
\begin{equation*}
\mathcal{F}\left(\widehat{F}_{\varpi, \varpi^{\prime}}^{N}\right)=\frac{\mathcal{F}\left(\mathcal{L}\left(\left(\widehat{b}_{h, \boldsymbol{h}}^{N}\right)_{\varpi^{\prime}}^{r}\right)\right) \cdot \overline{\mathcal{F}\left(\mathcal{L} \mu^{N}\right)}}{\left|\mathcal{F}\left(\mathcal{L} \mu^{N}\right)\right|^{2}} \mathbf{1}_{\left\{\left|\mathcal{F}\left(\mathcal{L} \mu^{N}\right)\right|^{2} \geq \varpi\right\}} \in \mathbb{R}^{d} \tag{31}
\end{equation*}
$$

for some threshold $\varpi>0$ vanishing as $N \rightarrow \infty$, with the estimator

$$
\widehat{b}_{h, \boldsymbol{h}}^{N}\left(t_{0}, x_{0}\right)_{\varpi^{\prime}}^{r}=\widehat{b}_{h, \boldsymbol{h}}^{N}\left(t_{0}, x_{0}\right)_{\varpi^{\prime}} \mathbf{1}_{\{|x| \leq r\}}
$$

of $b\left(t_{0}, x_{0}, \mu_{t_{0}}\right)$, constructed in Section 2.2 for some threshold $\varpi^{\prime}>0$ and bandwidths $h>0$ and $\boldsymbol{h}>0$. We also set the estimator to be equal to 0 outside $|x| \leq r$ for some $r>0$. We obtain a consistency result under the following additional assumption:

Assumption 16. We have $|\mathcal{F}(\mathcal{L} \mu)(\xi)|>0 d \xi$-almost everywhere.
Theorem 17. Work under the assumptions of Proposition 13 and Assumption 16 Assume moreover that $G$ is in $L^{1}\left(\mathbb{R}^{d}\right) \cap L^{2}\left(\mathbb{R}^{d}\right)$ componentwise. If $w$ has compact support in $(0, T)$, there exists a choice of $\left(\varpi, \varpi^{\prime}, h, \boldsymbol{h}\right)=\left(\varpi_{N}, \varpi_{N}^{\prime}, h_{N}, \boldsymbol{h}_{N}\right) \rightarrow 0$ and $r=r_{N} \rightarrow \infty$ such that

$$
\mathbb{E}_{\mathbb{P}^{N}}\left[\left|\widehat{F}_{\varpi, \varpi^{\prime}}^{N}-F\right|_{2}^{2}\right] \rightarrow 0 \text { as } N \rightarrow \infty
$$

Some remarks: 1) Theorem 17 proves that we can reconstruct the interaction force $F$ from data (1), while the function $G$ remains a nuisance parameter. This is a first step for the construction of a statistical test based on data (1) for the presence against the absence of interaction between particles in the Vlasov model. 2) Although we obtain consistency, we do not have a rate of convergence and our result is not uniform in the model parameter. A glance at the proof of Theorem 17 shows that it is possible to cook-up a result with a rate of convergence and some uniformity in the parameter, provided we have a sharp control from below on the decay $|\mathcal{F}(\mathcal{L} \mu)(\xi)|$ or rather $|\mathcal{F}(\mu)(\xi)|$ as $|\xi| \rightarrow \infty$ as well as the decay of $\inf _{t \in\left[r_{1}, r_{2}\right],|x| \leq r} \mu_{t}(x)$ for given $\left[r_{1}, r_{2}\right] \subset(0, T)$ as $r \rightarrow \infty$. This requires the exact knowledge of the smoothness of the solution map $\mu=\mathcal{S}\left(b, c, \mu_{0}\right)$, and it is a delicate issue, see Proposition 13, we can anticipate ill-posedness. 3) From our estimator of $F$, we may construct a plug-in estimator for the function $G$ by setting

A consistency result can be obtained in the same way as for Theorem 174), the deconvolution method we employ here requires quite a stringent localisation assumption on the external force $G$ and the interaction force $F$. As pointed out by a referee, it does not apply for gradient forces of the form $G=-\nabla V$ and $F=-\nabla W$ where $V$ and $W$ diverge polynomially at infinity like e.g. in [5, 34, 17] for which alternative methods yet need to be constructed.

## 6. Probabilistic tools: a CONCENTRATION INEQUALITY

6.1. A Bernstein inequality. Let $\rho(d t)$ be a probability measure on $[0, T]$. We establish a deviation inequality for the sequence of signed measures $\nu^{N}(d t, d x)-\nu(d t, d x)$, where

We have a Bernstein concentration inequality:
Theorem 18. Work under Assumptions 1, 2 and 4 Let $\left(\mu_{t}\right)_{0 \leq t \leq T}$ denote the unique solution of (3) with $\mu_{t=0}=\mu_{0}$ satisfying Assumption 1 Then there exist $\kappa_{1}, \kappa_{2}>0$ depending on $\mathfrak{b}$ such that

\mathbb{P}^{N}\left(\int_{[0, T] \times \mathbb{R}^{d}} \phi(t, y)\left(\nu^{N}(d t, d y)-\nu(d t, d y)\right) \geq x\right) \leq \kappa_{1} \exp \left(-\kappa_{2} \frac{N x^{2}}{|\phi|_{L^{2}(\nu)}^{2}+|\phi|_{\infty} x}\right)
$$

for every $x \geq 0$, for every bounded $\phi:[0, T] \times \mathbb{R}^{d} \rightarrow \mathbb{R}$, and for any probability measure $\rho(d t)$ on $[0, T]$.
As a corollary, for a bounded $\phi: \mathbb{R}^{d} \rightarrow \mathbb{R}$ and any $0 \leq t_{0} \leq T$, picking $\rho(d t)=\delta_{t_{0}}(d t)$, we obtain

Several remarks: 1) Up to the constants $\kappa_{i}$, the result is quite satisfactory and comparable to the Bernstein deviation inequality for independent data, see e.g. Massart [52]. Theorem 18 is the gateway to derive sharp nonparametric estimators, although it has an independent interest as a deviation inequality. 2) The constants $\kappa_{i}$ are explicitly computable, but certainly far from being optimal with the method of proof employed here. 3) Our method of proof uses a change of measure argument based on Girsanov's theorem, in the spirit of the recent work of Lacker [44]. It can presumably be extended to path dependent coefficients in (2), but it is essential that the diffusion coefficient does not depend on $\mu_{t}^{N}$. 4) We have an interplay between the smoothness $k$ of the drift $b$ in its measure argument and the dimension $d$ of the ambient state space. This is explained by the fact that we need to control an exponential moment of $\sum_{i=1}^{N} \int_{t}^{t+\delta}\left|b\left(s, X_{s}^{i}, \mu_{s}^{N}\right)-b\left(s, X_{s}^{i}, \mu_{s}\right)\right|^{2} d s$ over small intervals $[t, t+\delta]$ in order to approximate the law of the data by the law of independent particles. This approximation is roughly controlled by $N \mathcal{W}_{1}\left(\mu_{t}^{N}, \mu_{t}\right)^{2}$ for which a dimensional effect drastically deteriorates the rate of convergence, see e.g. Fournier and Guillin [26]. The $k$-linear differentiability of $\mu \mapsto b(t, x, \mu)$ enables us to mitigate this effect. In particular, in the Vlasov case covered by Assumption 4 (iii), we formally have $k=\infty$, and the result is valid in any dimension $d \geq 1$.

The remainder of Section 6 is devoted to the proof of Theorem 18
6.2. Preparation for the proof of Theorem 18 , We let $\overline{\mathbb{P}}^{N}$ denote the unique probability measure on $\left(\mathcal{C}, \mathscr{F}_{T}\right)$ under which the canonical process $X=\left(X^{1}, \ldots, X^{N}\right)$ solves

$$

are independent $d$-dimensional $\overline{\mathbb{P}}^{N}$-Brownian motions. The existence of $\overline{\mathbb{P}}^{N}$ follows from Carmona and Delarue [16] or the lectures notes of Lacker [43]. In turn, the real-valued process

is a $\overline{\mathbb{P}}^{N}$-local martingale. Here, $c^{-1 / 2}$ denotes any square-root of $c^{-1}=\left(\sigma \sigma^{\top}\right)^{-1}$.
The following estimate is the central result of the section. It is the key ingredient that enables us to implement a change of probability argument in order to obtain our concentration estimates. Its proof is delayed until Section 6.4
Proposition 19. Work under Assumptions 1. 2and 4 For every $\tau>0$, there exists $\delta_{0}>0$ depending on $\tau$ and $\mathfrak{b}$ such that

for every $0 \leq \delta \leq \delta_{0}$ and some $C_{1}$ that depends on $\mathfrak{b}$ and $\tau$.
Let $\mathcal{E}_{t}\left(\bar{M}^{N}.\right)=\exp \left(\bar{M}_{t}^{N}-\frac{1}{2}\left\langle\bar{M}_{.}^{N}\right\rangle_{t}\right)$ denote the (martingale) exponential of $\bar{M}_{t}^{N}$ and $\left\langle\bar{M}^{N}\right\rangle_{t}$ its predictable compensator. By Novikov's criterion - in its version developed in the classical textbook [40], Lemma 5.14, p. 198 - Proposition 19 shows that the local martingale $\mathcal{E}_{t}\left(\bar{M}^{N}\right)$ is indeed a true martingale. This enables us to define a new probability measure on $\left(\mathcal{C}, \mathcal{F}_{T}\right)$ by setting

By Girsanov's theorem, under $\widetilde{\mathbb{P}}^{N}$, the canonical process solves (2). By uniqueness of the weak solution of (2), this proves $\widetilde{\mathbb{P}}^{N}=\mathbb{P}^{N}$ and shows in particular that $\mathbb{P}^{N} \ll \overline{\mathbb{P}}^{N}$ and

6.3. Proof of Theorem 18, Step 1: Let $\mathcal{A}^{N} \in \mathcal{F}_{T}$. Since $\mathbb{P}^{N}$ and $\overline{\mathbb{P}}^{N}$ coincide on $\mathcal{F}_{0}$, we have

It follows that

\mathbb{P}^{N}\left(\mathcal{A}^{N}\right) & \leq \mathbb{E}_{\overline{\mathbb{P}}^{N}}\left[\mathbb{P}^{N}\left(\mathcal{A}^{N} \mid \mathcal{F}_{T}\right)\right]^{1 / 4^{K}} \prod_{j=1}^{K} \mathbb{E}_{\overline{\mathbb{P}}^{N}}\left[\exp \left(2\left(\left\langle\bar{M}^{N} \cdot\right\rangle_{t_{j}}-\left\langle\bar{M}^{N}\right\rangle_{t_{j-1}}\right)\right)\right]^{j / 4} \\
& \leq \overline{\mathbb{P}}^{N}\left(\mathcal{A}^{N}\right)^{1 / 4^{K}} \sup _{N \geq 1} \sup _{t \in\left[0, T-\delta_{0}\right]}\left(\mathbb{E}_{\overline{\mathbb{P}}^{N}}\left[\exp \left(2\left(\left\langle\bar{M}^{N} \cdot\right\rangle_{t+\delta_{0}}-\left\langle\bar{M}^{N} \cdot\right\rangle_{t}\right)\right)\right]\right)^{K(K+1) / 8} \\
& \leq C_{1}^{K(K+1) / 8} \overline{\mathbb{P}}^{N}\left(\mathcal{A}^{N}\right)^{1 / 4^{K}} \tag{35}
\end{align*}
$$

by (34) and Proposition 19 with $\tau=2, t_{j}=j T / K$ and $K$ large enough so that $t_{j}-t_{j-1} \leq \delta_{0}$.

Step 2: Let

so that $\mathcal{A}^{N} \in \mathcal{F}_{T}$. Recall Bernstein's inequality: if $Z_{1}, \ldots, Z_{N}$ are real-valued independent random variables bounded by some constant $Q$ and such that $\mathbb{E}\left[Z_{i}\right]=0$, we have

Under $\overline{\mathbb{P}}^{N}$, the random processes $\left(X_{t}^{i}\right)_{0 \leq t \leq T}$ are independent and identically distributed processes. Noticing that $\int_{[0, T] \times \mathbb{R}^{d}} \phi(t, x) \mu_{t}(d x) \rho(d t)=\mathbb{E}_{\mathbb{P}^{N}}\left[\int_{0}^{T} \phi\left(t, X_{t}^{i}\right) \rho(d t)\right]$, we apply Bernstein inequality with $Z_{i}=\int_{0}^{T} \phi\left(t, X_{t}^{i}\right) \rho(d t)-\mathbb{E}_{\overline{\mathbb{P}}^{N}}\left[\int_{0}^{T} \phi\left(t, X_{t}^{i}\right) \rho(d t)\right], y=N x$ and $Q=2|\phi|_{\infty}$ to infer

\overline{\mathbb{P}}^{N}\left(\mathcal{A}^{N}\right) \leq \exp \left(-\frac{N x^{2}}{2\left(|\phi|_{L^{2}(\nu)}^{2}+\frac{2}{3}|\phi|_{\infty} x\right)}\right)

using $\mathbb{E}\left[Z_{i}^{2}\right] \leq \mathbb{E}_{\mathbb{P}^{N}}\left[\left(\int_{0}^{T} \phi\left(t, X_{t}^{i}\right) \rho(d t)\right)^{2}\right] \leq|\phi|_{L^{2}(\nu)}^{2}$ by Jensen's inequality. By (35), we also have

and we obtain Theorem 18 with $\kappa_{1}=C_{1}^{K(K+1) / 8}$ and $\kappa_{2}=2^{-1} 4^{-K}$.
Step 3: It remains to prove the key estimate (34), adapted from large deviation techniques, see e.g. Gärtner [28] and the estimate (4.2) in Theorem 2.6 in Lacker [44]. We proceed by induction. First,

& =\mathbb{E}_{\overline{\mathbb{P}}^{N}}\left[\frac{\mathcal{E}_{t_{j}}\left(\bar{M}_{.}^{N}\right)}{\varepsilon_{t_{j-1}}\left(\bar{M}_{.}^{N}\right)} \mathbb{P}^{N}\left(\mathcal{A}^{N} \mid \mathcal{F}_{t_{j}}\right)\right]
\end{aligned}
$$

see e.g. Lemma 3.5.3 p. 193 in [40]. Next,

\end{equation*}

As shown before, under $\overline{\mathbb{P}}^{N}$, the process $\mathcal{E}_{t}\left(2\left(\bar{M}^{N} \cdot-\bar{M}_{t_{j-1}}^{N}\right)\right)_{t \geq t_{j-1}}$ is a martingale and

& \leq \mathbb{E}_{\overline{\mathbb{P}}^{N}}\left[\mathbb{P}^{N}\left(\mathcal{A}^{N} \mid \mathcal{F}_{t_{j}}\right)^{4}\right]^{1 / 4} \mathbb{E}_{\mathbb{P}^{N}}\left[\exp \left(2\left(\left\langle\bar{M}_{\cdot}^{N}\right\rangle_{t_{j}}-\left\langle\bar{M}_{\cdot}^{N}\right\rangle_{t_{j-1}}\right)\right)\right]^{1 / 4}
\end{aligned}
$$

By Jensen's inequality, we infer

Repeating the argument over the subdivision $0=t_{0}<t_{1}<\ldots<t_{K}$ proves (34). The proof of Theorem 18 is complete.

### 6.4. Proof of Proposition 19

Preparation. Recall that the notation $A_{N} \lesssim B_{N}$ : it means the existence of $C>0$ possibly depending on $\mathfrak{b}$ and also $\tau$ in this part of the paper, but not $N$, such that $A_{N} \leq C B_{N}$ for every $N \geq 1$. The following classical moment estimate will be needed.
Lemma 20. In the setting of Theorem 18, for every $p \geq 1$, we have

The proof is classical (see e.g. estimates of this type in Méléard [54] or Sznitman [12]) and postponed to Appendix 8.1

Completion of Proof of Proposition 19 Let $\tau>0$. All we need to show is that for small enough $\delta$, we have

$$

for some explicit $C \geq 1$ depending on $\mathfrak{b}$.

Proof. The estimate follows from the Lipschitz continuity of $b$ under Assumption 4(i) with $C=$ $|b|_{\text {Lip }}^{2}$ and from the definition of the Vlasov case with $C=1$ under Assumption 4 (iii). We turn to the estimate under (ii). The $k$-linear differentiability of $b$ enables us to write

[18] where (40) is established by induction.

Thanks to representation (7), the remainder term $\mathcal{R}_{k}$ equals

& \leq \frac{m_{b}\left|\delta_{\mu}^{k} b\right|_{\text {Lip }}^{k}}{k!} \mathcal{W}_{1}\left(\mu_{s}^{N}, \mu_{s}\right)^{k} .

We then use the following estimate, reminiscent of moment bounds for $U$-statistics, however in a weaker and simpler form in our context. For an integer $\ell \geq 1$, we call $\mathcal{G}_{\ell}$ the class of functions $f:[0, T] \times \mathbb{R}^{d} \times\left(\mathbb{R}^{d}\right)^{\ell} \rightarrow \mathbb{R}^{d}$ that are Lipschitz continuous in the space variables.

& \leq \sup _{s \in[0, T]} \mathbb{E}_{\overline{\mathbb{P}}^{N}}\left[\exp \left(\kappa \delta N\left|\int_{\mathbb{R}^{d}} \widetilde{b}\left(s, X_{s}^{N}, y\right)\left(\mu_{s}^{N}-\mu_{s}\right)(d y)\right|^{2}\right)\right] \\
& \leq 1+\sum_{p \geq 1} \frac{(\kappa \delta N)^{p}}{p!} \sup _{s \in[0, T]} \mathbb{E}_{\overline{\mathbb{P}}^{N}}\left[\left|\int_{\mathbb{R}^{d}} \widetilde{b}\left(s, X_{s}^{N}, y\right)\left(\mu_{s}^{N}-\mu_{s}\right)(d y)\right|^{2 p}\right] \lesssim 1
\end{aligned}

as soon as $\delta<\frac{1}{2} \kappa^{-1} K_{1}^{-1} \sup _{s \in[0, T]}|\widetilde{b}(s, \cdot)|_{\text {Lip }}^{-2}$ by Lemma 22 Therefore (39) is established under Assumption 4 (iii) and this completes the proof of Proposition 19

## 7. Proof of the nonparametric estimation results

We will repeatedly use estimates of the form

The estimate (48) is far from being optimal, but will be sufficient for our purpose.

### 7.1. Proof of Theorem 7 ,

Preliminaries. We first state local upper and lower estimates on $(t, x) \mapsto \mu_{t}(x)$.

that defines $\kappa_{5}$ thanks to Assumption 4 and Lemma 20. This establishes (49). The estimate (50) follows from classical Gaussian tail estimates for the solution of parabolic equations. We refer for example in our context to Corollary 8.2.2 of [7]: for every compact interval $\left[r_{1}, r_{2}\right] \subset(0, T)$, there exist constants $\mathfrak{c}_{ \pm}>0$ depending on $r_{1}, r_{2}$ and $\mathfrak{b}$ only such that

We next prove a standard bias-variance estimate for the quadratic risk of $\widehat{\mu}_{h}^{N}\left(t_{0}, x_{0}\right)$.

Completion of proof of Theorem 7 We essentially repeat the main argument of the GoldenshlugerLepski method (see e.g. [31, 32, 33] for the pointwise risk). We nevertheless give a proof for sake of completeness. Recall that $\widehat{h}^{N}$ denotes the data-driven bandwidth defined in (13).

It is enough to prove the deviation bound for each term separately.

z & \leq 4 \kappa^{-2}|\operatorname{Tr}(c)|_{\infty}^{2} \kappa_{3}^{2}|H \otimes K|_{2}^{4} N^{-2}\left(h_{1} h_{2}^{d}\right)^{-2}\left(\mathrm{~V}_{\boldsymbol{h}}^{N}\right)^{-1}(\log N)^{2} \\
& \leq 4 \kappa^{-2}|\operatorname{Tr}(c)|_{\infty}^{2} \kappa_{3}^{2} \varpi_{2}^{-2} \mathrm{~V}_{\boldsymbol{h}}^{N} \\
& <\frac{1}{36 d} \mathrm{~V}_{\boldsymbol{h}}^{N}
\end{aligned}
$$

as soon as $\varpi_{2} \geq 300 d|\operatorname{Tr}(c)|_{\infty} \kappa_{3}$. It follows that VII is of order

& \int_{\frac{1}{36 d} \mathrm{~V}_{\boldsymbol{h}}^{N}}^{\infty} \mathbb{P}^{N}\left(\left|\int_{[0, T] \times \mathbb{R}^{d}} \phi(t, x)^{2}\left(\mu_{t}^{N}(d x)-\mu_{t}(d x)\right) d t\right| \geq \frac{1}{2} N|\operatorname{Tr}(c)|_{\infty}^{-1} \kappa\left(\mathrm{~V}_{\boldsymbol{h}}^{N}\right)^{1 / 2}(\log N)^{-1} z^{1 / 2}\right) d z \\
& \lesssim \int_{\frac{1}{36 d} \mathrm{~V}_{\boldsymbol{h}}^{N}}^{\infty} \exp \left(-\frac{\kappa_{2} \frac{1}{4} N^{3}|\operatorname{Tr}(c)|_{\infty}^{-2} \kappa^{2}\left(\mathrm{~V}_{\boldsymbol{h}}^{N}\right)(\log N)^{-2} T^{-2} z}{\kappa_{3} T^{-1}|\phi|_{4}^{4}+|\phi|_{\infty}^{2} \frac{1}{2} N|\operatorname{Tr}(c)|_{\infty}^{-1} \kappa\left(\mathrm{~V}_{\boldsymbol{h}}^{N}\right)^{1 / 2}(\log N)^{-1} T^{-1} z^{1 / 2}}\right) d u \\
& \lesssim\left(N h_{1} h_{2}^{d}\right)^{-2}(\log N) \exp \left(-\frac{\kappa^{2} \kappa_{2}|\operatorname{Tr}(c)|_{\infty}^{-2} \varpi_{2}^{2}|H \otimes K|_{2}^{4}}{288 \kappa_{3} d T|H \otimes K|_{4}^{4}} N h_{1} h_{2}^{d}\right) \\
& +\left(N h_{1} h_{2}^{d}\right)^{-2}(\log N) \exp \left(-\frac{\kappa_{2} \kappa|\operatorname{Tr}(c)|_{\infty}^{-1} \varpi_{2}|H \otimes K|_{2}^{2}}{24 d^{1 / 2} T|H \otimes K|_{\infty}^{2}} N h_{1} h_{2}^{d}\right) \\
& \lesssim N^{-2}
\end{aligned}

where we applied again Theorem 18 and used $\min _{\left(h_{1}, h_{2}\right) \in \mathcal{H}_{2}^{N}} N h_{1} h_{2}^{d} \geq(\log N)^{2}$ granted by (15). We infer $V I I \lesssim N^{-2}$ and conclude

In turn $\mathbb{E}_{\mathbb{P}^{N}}\left[\mathrm{~A}_{\boldsymbol{h}}^{N}\right] \lesssim N^{-1}+\mathcal{B}_{\boldsymbol{h}}^{N}(\pi)\left(t_{0}, x_{0}\right)^{2}$ and we have established by Step 2 that for any $\boldsymbol{h} \in \mathcal{H}_{2}^{N}$,

From the classical theory of multidimensional diffusion processes (see e.g. the classical textbook of Stroock and Varadhan [62]), properties (i) and (ii) imply that $\nu_{1}$ is the unique invariant measure of the diffusion process $d \xi_{t}=-\nabla V_{1}\left(\xi_{t}\right) d t+d W_{t}$ for some Brownian motion $W$ on $\mathbb{R}^{d}$. In turn $\nu_{1}(t, x)=\nu_{1}(x)$ as a function defined on $[0, T] \times \mathbb{R}^{d}$ satisfies

Since $\nu_{1}$ is constant in a neighbourhood of $\left(t_{0}, x_{0}\right)$ we may (and will) assume that $\left(b_{1}, \operatorname{Id}, \nu_{1}\right) \in \mathcal{S}_{L / 2}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$. Next, we set

for some $0<\varpi \leq 1$, where $\psi: \mathbb{R}^{d} \rightarrow \mathbb{R}$ is infinitely many times differentiable, compactly supported and satisfies

$$

hence $\nabla V_{2}^{N}$ satisfies (i) and (ii) and (iii). It defines in turn a solution

\nu_{2}^{N}(x)=C_{V_{2}^{N}}^{-1} \exp \left(-2 V_{2}^{N}(x)\right) \text { with } C_{V_{2}^{N}}=\int_{\mathbb{R}^{d}} \exp \left(-2 V_{2}^{N}(x)\right) d x
$$

and $\nu_{2}^{N}(t, x)=\nu_{2}^{N}(x)$ is understood as a function defined on $[0, T] \times \mathbb{R}^{d}$.
Step 2: We claim that for every $\beta>0$, setting $\tau_{N}=N^{1 /(2 \beta+d)}$ and taking $\varpi$ sufficiently small, we have $\left(b_{2}^{N}, \operatorname{Id}, \nu_{2}^{N}\right) \in \mathcal{S}_{L}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$ for large enough $N$. Indeed, in a neighbourhood of $x_{0}$, we have $V_{1}=0$ hence for $x$ in such a neighbourhood, we have

On the one hand, $\varpi N^{-1 / 2} \tau_{N}^{d / 2}\left|\psi\left(\tau_{N}\left(\cdot-x_{0}\right)\right)\right|_{\mathcal{H} \beta\left(x_{0}\right)} \lesssim \varpi|\psi|_{\mathcal{H} \beta\left(x_{0}\right)}$ which can be taken arbitrarily small. On the other hand, we also have $C_{V_{2}^{N}} \rightarrow C_{V_{1}}$ as $N \rightarrow \infty$, see in particular (68) below, and the claim follows.

Step 3. For $\left(b, c, \mu_{0}\right) \in \mathcal{P}$, we write $\mathbb{P}_{b, c, \mu_{0}}^{N}$ for $\mathbb{P}^{N}$ to emphasise the model parameter $\left(b, c, \mu_{0}\right)$. For data extracted from $\mu_{t_{0}}^{N}$ solely, we restrict the model to

the law of $\left(X_{t_{0}}^{1}, \ldots, X_{t_{0}}^{N}\right)$ under $\mathbb{P}_{b, c, \mu_{0}}^{N}$. Note that for a drift $b(t, x, \mu)=b(t, x)$ independent of an interaction measure term $\mu$, we have

& =N \int_{\mathbb{R}^{d}} \nu_{1}(x)\left(V_{2}^{N}(x)-V_{1}(x)\right) d x+\frac{N}{2} \log \frac{C_{V_{2}^{N}}}{C_{V_{1}}} \\
& =\frac{N}{2} \log \frac{C_{V_{2}^{N}}}{C_{V_{1}}}
\end{aligned}

for large enough $N$, where $\|\cdot\|_{T V}$ denotes the total variation distance, using successively

since $\nu_{1}(x)^{-1}=C_{V_{1}}$ in a neighbourhood of $x_{0}$ and the fact that $\psi\left(\tau_{N}\left(x-x_{0}\right)\right)=0$ outside this neighbourhood, for large enough $N$, thanks to the fact that $\operatorname{Supp}(\psi)$ is compact, together with the cancellation $\int_{\mathbb{R}^{d}} \psi(x) d x=0$. Moreover, a Taylor's expansion yields

\end{aligned}
$$

thanks to the cancellation property of $\psi$ again, with a remainder term satisfying

Step 4. We conclude by a classical two-point lower bound argument using Le Cam's lemma: if $\mathbb{P}_{i}$, $i=1,2$ are two probability measures defined on the same probability space and $\Psi\left(\mathbb{P}_{i}\right) \in \mathbb{R}$ is a functional of $\mathbb{P}_{i}$, we have

where the infimum is taken over all estimators of $\Psi\left(\mathbb{P}_{i}\right)$, see $e . g$. [46] among many other references. We let

\left|\Psi\left(\mathbb{P}_{b_{1}, \mathrm{Id}, \nu_{1}}^{N}\left(t_{0}\right)\right)-\Psi\left(\mathbb{P}_{b_{2}^{N}, \mathrm{Id}, \nu_{2}^{N}}^{N}\left(t_{0}\right)\right)\right| & \gtrsim \nu_{1}\left(x_{0}\right)\left(\frac{C_{V_{2}^{N}}}{C_{V_{1}}}-\exp \left(2 \varpi \nu_{1}(x)^{-1} N^{-1 / 2} \tau_{N}^{d / 2} \psi(0)\right)\right) \\
& \gtrsim N^{-1 / 2} \tau_{N}^{d / 2}=N^{-\beta /(2 \beta+d)}
\end{aligned}
$$

in the same way as before, using the properties of $\psi$ and (68). We conclude by applying Le Cam's lemma together with (69). The proof of the lower bound (24) is complete.

Proof of the upper bound (23). The argument is classical (see e.g. [31, 32, 33]). Pick

\end{aligned}

for large enough $N$, since for every $\beta \in(0, \ell]$, we have $\mathrm{e}^{-\left(k^{N}+1\right)} \leq(N / \log N)^{-1 /(2 \beta+d)} \leq \mathrm{e}^{-k^{N}}$ with $k^{N}=\left\lfloor\frac{1}{2 \beta+d}(\log N-\log \log N)\right\rfloor$. This proves (23) and completes the proof of Theorem 14

### 7.4. Proof of Theorem 15

Proof of the lower bound (26). We apply the same strategy as for Theorem 14, establishing a twopoint inequality and applying Le Cam's lemma for two drift functions that have no interaction. We write $\mathbb{P}_{b, c, \mu_{0}}^{N}$ for the law of $\left(X_{t}^{1}, \ldots, X_{t}^{N}\right)_{0 \leq t \leq T}$ parametrised by $\left(b, c, \mu_{0}\right)$. We start with the following simple consequence of Girsanov's theorem:

Lemma 28. For $i=1,2$, let $b_{i}(t, x, \mu)=b_{i}(t, x)$ be two drift functions that satisfy Assumption 4 with no interaction. Set $\Delta(t, x)=b_{2}(t, x)-b_{1}(t, x)$. We have

where $\mu=\mathcal{S}\left(b_{1}, \mathrm{Id}, \mu_{0}\right)$ is a solution of (3) with parameter $\left(b_{1}, \mathrm{Id}, \mu_{0}\right)$, up to an explicitly computable constant that only depends on $\mu_{0}$ and $b_{1}$.

Proof. With the notation of Section6.2, by Girsanov's theorem,

is a $\mathbb{P}_{b_{1}, \mathrm{Id}, \mu_{0}}^{N}$-martingale, with $B_{t}^{i}=\int_{0}^{t}\left(d X_{s}^{i}-b_{1}\left(s, X_{s}^{i}\right) d s\right)$. Moreover, since there is no interaction term in the drift $b_{1}$, we have

$$

By Pinsker's inequality $\left\|\mathbb{P}_{b_{1}, \mathrm{Id}, \mu_{0}}^{N}-\mathbb{P}_{b_{2}, \mathrm{Id}, \mu_{0}}^{N}\right\|_{T V}^{2} \leq \frac{1}{2} \mathbb{E}_{\mathbb{P}_{b_{1}, \mathrm{Id}, \mu_{0}}^{N}}\left[\log \frac{d \mathbb{P}_{\hat{p}_{2}}^{N}, \mathrm{Id}, \mu_{0}}{d \mathbb{P}_{b_{2}, \mathrm{Id}, \mu_{0}}^{N}}\right]$. The conclusion follows from

\mathbb{E}_{\mathbb{P}_{b_{1}, I \mathrm{Id}, \mu_{0}}^{N}}\left[\log \frac{d \mathbb{P}_{b_{1}, \mathrm{Id}, \mu_{0}}^{N}}{d \mathbb{P}_{b_{2}, \mathrm{Id}, \mu_{0}}^{N}}\right]=-\mathbb{E}_{\mathbb{P}_{b_{1}, \mathrm{Id}, \mu_{0}}^{N}}\left[\log \frac{d \mathbb{P}_{b_{2}, \mathrm{Id}, \mu_{0}}^{N}}{d \mathbb{P}_{b_{1}, \mathrm{Id}, \mu_{0}}^{N}}\right]=\frac{1}{2} \mathbb{E}_{\mathbb{P}_{b_{1}, \mathrm{Id}, \mu_{0}}^{N}}\left[\left\langle M M_{.}^{N}(\Delta)\right\rangle_{T}\right]
$$

and the previous estimate on $\left\langle M^{N}(\Delta)\right\rangle_{T}$ under $\mathbb{P}_{b_{1}, \mathrm{Id}, \mu_{0}}^{N}$.
Step 1. Pick now a function $b_{1}:[0, T] \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ satisfying Assumption 4 and any initial condition $\mu_{0}$ such that $\left(b_{1}, \operatorname{Id}, \mu_{0}\right) \in \mathcal{S}_{L / 2}^{\alpha, \beta}\left(t_{0}, x_{0}\right) \cap \mathcal{D}_{L / 2}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$.

Let $\psi=\left(\psi^{1}, \ldots, \psi^{d}\right):(0, T) \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ be infinitely many times differentiable, compactly supported and such that for every $1 \leq k \leq d$, we have

$$
\psi^{k}(0)=1, \quad\left|\psi^{k}\right|_{\infty} \leq 1, \int_{[0, T] \times \mathbb{R}^{d}} \psi(t, x) d t d x=0, \quad\left|\psi^{k}\right|_{2}=1 .
$$

For $N \geq 1$ and some $0<\varpi \leq 1$, we define

b_{2}^{N}(t, x)=b_{1}(t, x)+\varpi N^{-1 / 2} \tau_{N}^{1 / 2}\left(\widetilde{\tau}_{N}\right)^{1 / 2} \psi\left(\tau_{N}\left(t-t_{0}\right), \widetilde{\tau}_{N}\left(x-x_{0}\right)\right),
$$

where $\tau_{N}$ and $\widetilde{\tau}_{N}$ are defined via

\tau_{N}^{\alpha}=\left(\widetilde{\tau}_{N}\right)^{\beta}=N^{s_{d}(\alpha, \beta) /\left(2 s_{d}(\alpha, \beta)+1\right)} .
$$

By accomodating $b_{1}$ and $\varpi>0$, we may (and will) assume that ( $b_{2}^{N}$, Id, $\mu_{0}$ ) $\in \mathcal{D}_{L}^{\alpha, \beta} \cap \mathcal{D}_{L}^{\alpha, \beta}\left(t_{0}, x_{0}\right)$ and $b_{2}^{N} \in \mathcal{P}$ for every $N \geq 1$. Setting $\Delta^{N}(t, x)=b_{2}^{N}(t, x)-b_{1}(t, x)$ and noting that

\int_{0}^{T}\left|\Delta^{N}(t, \cdot)\right|_{L^{2}\left(\mu_{t}\right)}^{2} d t \lesssim \varpi^{2} N^{-1},
$$

thanks to the compactness of the support of $\psi$ and Lemma 23, we obtain

by Lemma 28, for a suitable choice of $\varpi>0$.

Step 2. We conclude in the same way as in the proof of the lower bound of Theorem 14 be Cam's lemma (70), with

\left|\Psi\left(\mathbb{P}_{b_{1}, \mathrm{Id}, \mu_{0}}^{N}\right)-\Psi\left(\mathbb{P}_{b_{2}^{N}, \mathrm{Id}, \mu_{0}}^{N}\right)\right| \gtrsim N^{-1 / 2} \tau_{N}^{1 / 2}\left(\widetilde{\tau}_{N}\right)^{1 / 2}=N^{-s_{d}(\alpha, \beta) /\left(2 s_{d}(\alpha, \beta)+1\right)}
$$

and the conclusion follows. The proof of the lower bound (26) is complete.
Proof of the upper bound (25). Let

\delta^{N}(k)=\frac{g^{-1}(k / \log N)}{\alpha\left(g^{-1}(k / \log N)\right)} k
$$

where $g^{-1}$ is the inverse of the function $g(\beta)=\frac{1}{\beta} \frac{s_{d}(\alpha(\beta), \beta)}{2 s_{d}(\alpha(\beta), \beta)+1}$, which is non-increasing for $\beta>0$ thanks to the assumption that $\beta \mapsto \alpha(\beta)$ is non-decreasing and $\beta \mapsto \alpha(\beta) / \beta$ is non-increasing. Pick

$$
\begin{gathered}
\mathcal{H}_{2}^{N}=\left\{\left(\mathrm{e}^{-k_{1}}, \mathrm{e}^{-k_{2}}\right), k_{1}=\delta^{N}\left(k_{2}\right), 1 \leq k_{2} \leq(d+1)^{-1}(\log N-2 \log \log N)\right. \\
\left.2 \log \log N \leq \delta^{N}\left(k_{2}\right) \leq(d+1)^{-1}(\log N-2 \log \log N)\right\}
\end{gathered}
$$

The condition (15) for the grid $\mathcal{H}_{2}^{N}$ is satisfied and Card $\mathcal{H}_{2}^{N} \lesssim N$ holds as well (and is actually much smaller). Now, set $\beta_{k_{2}}=g^{-1}\left(k_{2} / \log N\right)$. We define an ordering $\preceq$ on $\mathcal{H}_{2}^{N}$ that has the right behaviour with respect to the bias of $\pi$ at scale $\boldsymbol{h}$. We say that $\boldsymbol{h}=\left(h_{1}, h_{2}\right) \preceq \boldsymbol{h}^{\prime}=\left(h_{1}^{\prime}, h_{2}^{\prime}\right)$ if

h_{1}\left(k_{2}\right)^{\alpha\left(\beta_{k_{2}}\right)}+h_{2}\left(k_{2}\right)^{\beta_{k_{2}}} \leq h_{1}^{\prime}\left(k_{2}^{\prime}\right)^{\alpha\left(\beta_{k_{2}^{\prime}}\right)}+h_{2}^{\prime}\left(k_{2}^{\prime}\right)^{\beta_{k_{2}^{\prime}}} \tag{71}
\end{equation*}
$$

where we write $\boldsymbol{h}=\left(h_{1}, h_{2}\right)=\left(h_{1}\left(k_{2}\right), h_{2}\left(k_{2}\right)\right)=\left(\mathrm{e}^{-\delta^{N}\left(k_{2}\right)}, \mathrm{e}^{-k_{2}}\right)$ and likewise for $\boldsymbol{h}^{\prime}$. We have that $\boldsymbol{h} \preceq \boldsymbol{h}^{\prime}$ is equivalent to $k_{2} \geq k_{2}^{\prime}$ since

h_{1}\left(k_{2}\right)^{\alpha\left(\beta_{k_{2}}\right)}+h_{2}\left(k_{2}\right)^{\beta_{k_{2}}}=2 N^{-s_{d}\left(\alpha\left(\beta_{k_{2}}\right), \beta_{k_{2}}\right) /\left(2 s_{d}\left(\alpha\left(\beta_{k_{2}}\right), \beta_{k_{2}}\right)+1\right)}
$$

and the fact that $\beta \mapsto s_{d}(\alpha(\beta), \beta)$ is non-decreasing, following from the assumption that $\beta \mapsto \alpha(\beta)$ is non-decreasing. Hence $\boldsymbol{h} \preceq \boldsymbol{h}^{\prime}$ or $\boldsymbol{h}^{\prime} \preceq \boldsymbol{h}$. Moreover,

\left(b, c, \mu_{0}\right) \in \mathcal{S}_{L}^{\alpha, \beta}\left(t_{0}, x_{0}\right) \cap \mathcal{D}_{L}^{\alpha, \beta}\left(t_{0}, x_{0}\right) \text { implies } \pi \in \mathcal{H}^{\alpha, \beta}\left(t_{0}, x, 0\right)
$$

Therefore, for every $\boldsymbol{h}=\left(h_{1}, h_{2}\right) \in \mathcal{H}_{2}^{N}$ :

\mathcal{B}_{\boldsymbol{h}}^{N}(\pi)\left(t_{0}, x_{0}\right)^{2} \lesssim h_{1}^{2 \alpha \wedge \ell}+h_{2}^{2 \beta \wedge \ell} \text { and } \vee_{\boldsymbol{h}}^{N} \lesssim N^{-1} h_{1}^{-1} h_{2}^{-d}(\log N)
$$

thanks to the definition of the ordering $\preceq$ in (71). It follows that for every $s_{d}(\alpha, \beta) \in(0, \ell / d]$, we have

with $k_{1}^{N}=\left\lfloor\frac{\alpha^{-1} s_{d}(\alpha, \beta)}{2 s_{d}(\alpha, \beta)+1} \log N\right\rfloor$ and

\mathrm{e}^{-\left(k_{2}^{N}+1\right)} \leq N^{-\beta^{-1} s_{d}(\alpha, \beta) /\left(2 s_{d}(\alpha, \beta)+1\right)} \leq \mathrm{e}^{-k_{2}^{N}}
$$

with $k_{2}^{N}=\left\lfloor\frac{\beta^{-1} s_{d}(\alpha, \beta)}{2 s_{d}(\alpha, \beta)+1} \log N\right\rfloor$. Applying Theorem 9 , we obtain

& \lesssim\left(\frac{\log N}{N}\right)^{2 s_{d}(\alpha, \beta) \wedge \ell_{d} /\left(2 s_{d}(\alpha, \beta) \wedge \ell_{d}+1\right)}
\end{aligned}
$$

This proves (23) and completes the proof of Theorem 14

& \leq \int_{[0, T]} \mathbb{E}_{\mathbb{P}^{N}}\left[\left|\int_{\mathbb{R}^{d}} \mathrm{e}^{-2 i \pi \xi^{\top} x}\left(\mu_{t}^{N}-\mu_{t}\right)(d x)\right|^{2}\right] w(t)^{2} \rho(d t) \\
& \lesssim \sup _{t \in[0, T]} \max _{k=1,2} \int_{0}^{\infty} \mathbb{P}^{N}\left(\left|\int_{\mathbb{R}^{d}} \varphi_{k} d\left(\mu_{t}^{N}-\mu_{t}\right)\right| \geq z^{1 / 2}\right) d z \\
& \lesssim 2 \kappa_{1} \int_{0}^{\infty} \exp \left(-\kappa_{2} \frac{N z}{1+z^{1 / 2}}\right) \lesssim N^{-1}
\end{aligned}
$$

using $\left|\varphi_{k}\right|_{L^{2}\left(\mu_{t}\right)} \leq 1$ that stems from $\left|\varphi_{k}\right|_{\infty} \leq 1$. Since this bound is uniform in $\xi \in \mathbb{R}^{d}$, the result follows.

Completion of proof of Theorem 17 We have

\begin{aligned}
I & =\left|\left(\frac{\mathcal{F}\left(\mathcal{L}\left(\left(\widehat{b}_{h, \boldsymbol{h}}^{N}\right)_{\varpi^{\prime}}^{r}\right)\right) \overline{\mathcal{F}\left(\mathcal{L} \mu^{N}\right)}}{\left|\mathcal{F}\left(\mathcal{L} \mu^{N}\right)\right|^{2}}-\mathcal{F}(F)\right) \mathbf{1}_{\left\{\left|\mathcal{F}\left(\mathcal{L} \mu^{N}\right)\right|^{2} \geq \varpi\right\}}\right|_{2}^{2}, \\
I I & =\left|\mathcal{F}(F) \mathbf{1}_{\left\{\left|\mathcal{F}\left(\mathcal{L} \mu^{N}\right)\right|^{2}<\varpi\right\}}\right|_{2}^{2} .
\end{aligned}
$$

On $\left\{\left|\mathcal{F}\left(\mathcal{L} \mu^{N}\right)\right|^{2} \geq \varpi\right\}$ and using the fact that $|\mathcal{F}(\mathcal{L} \mu)(\xi)|>0$ almost everywhere, we write

& \frac{\mathcal{F}\left(\mathcal{L}\left(\widehat{b}_{h, \boldsymbol{h}}^{N}\right)_{\varpi^{\prime}}^{r}\right) \overline{\mathcal{F}\left(\mathcal{L} \mu^{N}\right)}}{\left|\mathcal{F}\left(\mathcal{L} \mu^{N}\right)\right|^{2}}-\mathcal{F}(F) \\
& =\frac{\left(\mathcal{F}\left(\mathcal{L}\left(\widehat{b}_{h, \boldsymbol{h}}^{N}\right)_{\varpi^{\prime}}^{r}\right)-\mathcal{F}(\mathcal{L} b)\right) \overline{\mathcal{F}\left(\mathcal{L} \mu^{N}\right)}}{\left|\mathcal{F}\left(\mathcal{L} \mu^{N}\right)\right|^{2}}+\frac{\mathcal{F}(\mathcal{L} b) \overline{\mathcal{F}\left(\mathcal{L} \mu^{N}\right)}}{\left|\mathcal{F}\left(\mathcal{L} \mu^{N}\right)\right|^{2}}-\mathcal{F}(F) \\
& =\frac{\left(\mathcal{F}\left(\mathcal{L}\left(\widehat{b}_{h, \boldsymbol{h}}^{N}\right)_{\varpi^{\prime}}^{r}\right)-\mathcal{F}(\mathcal{L} b)\right) \overline{\mathcal{F}\left(\mathcal{L} \mu^{N}\right)}}{\left|\mathcal{F}\left(\mathcal{L} \mu^{N}\right)\right|^{2}}+\mathcal{F}(\mathcal{L} b)\left(\frac{\overline{\mathcal{F}\left(\mathcal{L} \mu^{N}\right)}}{\left|\mathcal{F}\left(\mathcal{L} \mu^{N}\right)\right|^{2}}-\frac{\overline{\mathcal{F}(\mathcal{L} \mu)}}{|\mathcal{F}(\mathcal{L} \mu)|^{2}}\right)

thanks to $\mathcal{F}(\mathcal{L} b)=\mathcal{F}(F) \cdot \mathcal{F}(\mathcal{L} \mu)$. It follows that for $r>0$, we have

I V & =\varpi^{-2} \mathbb{E}_{\mathbb{P}^{N}}\left[\left|\mathcal{F}(F) \overline{\mathcal{F}\left(\mathcal{L} \mu^{N}\right)} \mathcal{F}\left(\mathcal{L}\left(\mu^{N}-\mu\right)\right)\right|_{2}^{2}\right]
\end{aligned}
$$

By Parseval's identity, and the boundedness of $\mathcal{L}$, we have

By Lemma 24 and Lemma 26, we have

Moreover, by Proposition 13 the smoothness of $F, G$ and $\mu_{0}$ entails some Hölder smoothness on $\mu$ and $b$ (hence on $\pi$ ) that implies in turn the estimate

for some $\gamma, \gamma^{\prime}, \gamma^{\prime \prime}>0$ and $C(r)$ a locally bounded function in $r$. We infer

\varpi^{-2} \sup _{t \in \operatorname{Supp}(w),|x| \leq r} \mathbb{E}_{\mathbb{P}^{N}}\left[\left|\widehat{b}_{h, \boldsymbol{h}}^{N}(t, x)_{\varpi^{\prime}}-b\left(x, \mu_{t}\right)\right|^{2}\right] \lesssim \varpi^{-2} \varpi^{\prime}(r)^{-2} C(r) u_{N}
$$

with $u_{N} \rightarrow 0$, for a choice $(h, \boldsymbol{h})=\left(h_{N}, \boldsymbol{h}_{N}\right) \rightarrow 0$ as $N \rightarrow \infty$. Since $b\left(x, \mu_{t}\right)=G(x)+F \star \mu_{t}(x)$, the second term in III can be bounded as follows:

by Fubini's theorem, and both terms converge to 0 at some rate $\widetilde{C}(r) \rightarrow 0$ as $r \rightarrow \infty$ by dominated convergence since $F$ and $G$ are in $L^{2}\left(\mathbb{R}^{d}\right)$. We conclude

I I I \lesssim \varpi^{-2}\left(\varpi^{\prime}(r)^{-2} C(r) u_{N}+\widetilde{C}(r)\right)
$$

By Parseval's identity, the boundedness of $\overline{\mathcal{F}\left(\mathcal{L} \mu^{N}\right)}$ and Lemma 29, we also have

I V \lesssim \varpi^{-2} \sup _{\xi \in \mathbb{R}^{d}} \mathbb{E}_{\mathbb{P}^{N}}\left[\left|\mathcal{F}\left(\mathcal{L}\left(\mu^{N}-\mu\right)\right)(\xi)\right|^{2}\right]|F|_{2}^{2} \lesssim \varpi^{-2} N^{-1}
$$

We finally turn to the term $I I$. We have

\mathbb{E}_{\mathbb{P}^{N}}[I I] & \lesssim \mathbb{E}_{\mathbb{P}^{N}}\left[\left|\mathcal{F}(F) \mathbf{1}_{\left\{\left|\mathcal{F}\left(\mathcal{L}\left(\mu^{N}-\mu\right)\right)\right|^{2} \geq \varpi\right\}}\right|_{2}^{2}\right]+\left|\mathcal{F}(F) \mathbf{1}_{\left\{|\mathcal{F}(\mathcal{L} \mu)|^{2} \leq 2 \varpi\right\}}\right|_{2}^{2} \\
& \lesssim \varpi^{-2} \sup _{\xi \in \mathbb{R}^{d}} \mathbb{E}_{\mathbb{P}^{N}}\left[\left|\mathcal{F}\left(\mathcal{L}\left(\mu^{N}-\mu\right)\right)(\xi)\right|^{2}\right]|F|_{2}^{2}+H(\varpi) \\
& \lesssim \varpi^{-2} N^{-1}+H(\varpi)
\end{aligned}
$$

where $H(\varpi) \rightarrow 0$ as $\varpi \rightarrow 0$ by dominated convergence thanks to the property $|\mathcal{F}(\mathcal{L} \mu)(\xi)|>0$ almost everywhere of Assumption 16. We conclude

\left.\mathbb{E}_{\mathbb{P}^{N}}\left[\left|\widehat{F}_{\varpi, \varpi^{\prime}}^{N}-F\right|_{2}^{2}\right] \lesssim \varpi^{-2}\left(\varpi^{\prime}(r)^{-2} C(r) u_{N}+\widetilde{C}(r)\right)+N^{-1}\right)+H(\varpi)
$$

Let $r_{N} \rightarrow \infty$ slowly enough so that $\varpi^{\prime}\left(r_{N}\right)^{-2} C\left(r_{N}\right) u_{N} \rightarrow 0$. This yields $v_{N}=C\left(r_{N}\right) u_{N}+\widetilde{C}\left(r_{N}\right)+$ $N^{-1} \rightarrow 0$. Pick now $\varpi_{N} \rightarrow 0$ slowly enough so that $\varpi_{N}^{-2} v_{N} \rightarrow 0$. The proof of Theorem 17 follows.

## 8. Appendix

Characterisation of sub-Gaussian random variables. We recall a classical definition of a sub-Gaussian random variable. Recommended reference is [10].
Definition 30. A real-valued random variable $Z$ such that $\mathbb{E}[Z]=0$ is $\lambda^{2}$ sub-Gaussian if one of the following conditions is satisfied, each statement implying the next:
(i) Laplace transform condition

$$
\mathbb{E}[\exp (z Z)] \leq \exp \left(\frac{1}{2} \lambda^{2} z^{2}\right) \text { for every } z \in \mathbb{R}
$$

(ii) Moment condition

$$

g\left(t, X_{t}^{i_{1}}, \ldots, X_{t}^{i_{k-\ell}},\left(X_{t}^{i}, y^{\ell}\right)\right)=g_{\mathcal{J}_{k-\ell} \cup\{i\}}^{\prime \prime \prime}\left(t, y^{\ell}\right)
$$

with $g^{\prime \prime \prime}\left(t, x_{i_{1}}, \ldots, x_{i_{k-\ell}}, x_{i}, y^{\ell}\right)=g\left(t, x_{i_{1}}, \ldots, x_{i_{k-\ell}},\left(x_{i}, y^{\ell}\right)\right)$ and $g^{\prime \prime \prime}$ belongs to $\mathcal{G}_{k-\ell+1, \ell}$ as well. We infer

$$
I I I \leq(k-\ell) N^{-1} \mathcal{V}_{2 p, \ell}^{N}\left(g_{\mathcal{J}_{k-\ell+1}}^{\prime \prime}(t, \cdot)\right)+N^{-1} \sum_{i \in \mathcal{J}_{k-\ell}^{c}} \mathcal{V}_{2 p, \ell}^{N}\left(g_{\mathcal{J}_{k-\ell} \cup\{i\}}^{\prime \prime \prime}(t, \cdot)\right) \leq \frac{p!K_{\ell}^{p}}{(N-k)^{p}}|g(t, \cdot)|_{\operatorname{Lip}}^{2 p}
$$

by the induction hypothesis and noting again that $\left|g^{\prime \prime}(t, \cdot)\right|_{\text {Lip }}$ and $\left|g^{\prime \prime \prime}(t, \cdot)\right|_{\text {Lip }}$ are controlled by $|g(t, \cdot)|_{\text {Lip }}$. We conclude

$$
\mathcal{V}_{2 p, \ell+1}^{N}\left(g_{\mathcal{J}_{k-\ell}}(t, \cdot)\right) \leq 2^{2 p} \frac{p!K_{\ell}^{p}}{(N-k)^{p}}|g(t, \cdot)|_{\text {Lip }}^{2 p}=\frac{p!K_{\ell+1}^{p}}{(N-k)^{p}}|g(t, \cdot)|_{\text {Lip }}^{2 p}
$$

with $K_{\ell+1}=4 K_{\ell}$. The proof of Lemma 22 is complete.
8.3. (Sketch of) proof of Proposition 13, Step 1: Thanks to Chapters 6 and 9 of [7], since $F, G$ are bounded and $\mu_{0}$ satisfies Assumption 1, it can be shown that (3) admits a unique probability solution $\mu$ in the sense of [7], absolutely continuous w.r.t. the Lebesgue measure, that we still denote $\mu(t, x)=\mu_{t}(x)$. Moreover $\mu \in \mathcal{H}_{\text {loc }}^{\delta / 2, \delta}=\cap_{\left(t_{0}, x, 0\right) \in(0, T) \times \mathbb{R}^{d}} \mathcal{H}^{\delta / 2, \delta}\left(t_{0}, x_{0}\right)$ for every $0<\delta<1$. The main arguments of these properties rely on the existence of a suitable Lyapunov function associated to (3), following the terminology of [51] and [7] (for instance $x \mapsto 1+|x|^{2}$ ) together with Sobolev embeddings.

Step 2: Define

$$
\widetilde{a}_{k}(t, x)=G^{k}(x)+\int_{\mathbb{R}^{d}} F^{k}(x-y) \mu_{t}(y) d y, \quad k=1, \ldots, d
$$

and

$$
\widetilde{a}(t, x)=\operatorname{div}\left(G(x)+\int_{\mathbb{R}^{d}} F(x-y) \mu_{t}(y) d y\right)
$$

which are well defined since $\beta, \beta^{\prime}>1$. Consider next the Cauchy problem associated to (3) in its strong form:

$$
\left\{\begin{array}{l}
\partial_{t} \widetilde{\mu}_{t}=\frac{1}{2} \sigma^{2} \Delta \widetilde{\mu}_{t}-\sum_{k=1}^{d} \widetilde{a}_{k}(t, \cdot) \partial_{k} \widetilde{\mu_{t}}-\widetilde{a}(t, \cdot) \widetilde{\mu}_{t}  \tag{74}\\
\tilde{\mu}_{t=0}=\mu_{0}
\end{array}\right.
$$

Taking $\delta=\beta-\lfloor\beta\rfloor$ we obtain $\widetilde{a}_{i}, \widetilde{a} \in \mathcal{C}_{\text {loc }}^{(\beta-\lfloor\beta\rfloor) / 2, \beta-\lfloor\beta\rfloor}$ by Step 1.
Step 3: Using inf $\widetilde{a}>-\infty$ and the existence of a Lyapunov function associated to the problem, by Theorem 2.3 of [2], there exists a unique solution $\widetilde{\mu}$ of (74). Moreover, $\widetilde{\mu}$ is continuous on $(0, T) \times \mathbb{R}^{d}$ and

$$
\widetilde{\mu} \in \mathcal{C}_{\mathrm{loc}}^{1+(\beta-\lfloor\beta\rfloor) / 2,2+\beta-\lfloor\beta\rfloor} .
$$

It is also the unique solution defined in Theorem 12 of Chapter 1 of [27], therefore the unique integrable solution of the problem (3). By uniqueness, $\mu=\widetilde{\mu}$.

Step 4: If $\lfloor\beta\rfloor=1$, we obtain $\mu \in \mathcal{H}^{(1+\beta) / 2,1+\beta}\left(t_{0}, x_{0}\right)$ for every $\left(t_{0}, x_{0}\right) \in(0, T) \times \mathbb{R}^{d}$. Otherwise, we can iterate the process thanks to results of Section 8.12 in [42]: successively:

- Since $\partial_{x_{k^{\prime}}} \widetilde{a}_{k}$ and $\partial_{x_{k}} \widetilde{a}$ are in $\mathrm{C}_{\text {loc }}^{(\beta-\lfloor\beta\rfloor) / 2, \beta-\lfloor\beta\rfloor}$, we have

$$
\partial_{x_{k}} \mu \in \mathcal{C}_{\mathrm{loc}}^{1+(\beta-\lfloor\beta\rfloor) / 2,2+\beta-\lfloor\beta\rfloor}
$$

- Since $\partial_{t} \widetilde{a}_{k}$ and $\partial_{t} \widetilde{a}$ are now in $\mathcal{C}_{\text {loc }}^{(\beta-\lfloor\beta\rfloor) / 2, \beta-\lfloor\beta\rfloor}$, we have

$$
\partial_{t} \mu \in \mathcal{C}_{\mathrm{loc}}^{1+(\beta-\lfloor\beta\rfloor) / 2,2+\beta-\lfloor\beta\rfloor}
$$

Therefore, if $\lfloor\beta\rfloor=2$, we obtain $\mu \in \mathcal{H}^{(1+\beta) / 2,1+\beta}\left(t_{0}, x_{0}\right)$ for every $\left(t_{0}, x_{0}\right) \in(0, T) \times \mathbb{R}^{d}$. Otherwise, we can iterate again the process and so on. The result follows.
