# Delay stochastic interest rate model with jump and strong convergence in Monte Carlo simulations

#### Abstract

In this paper, we study analytical properties of the solutions to the generalised delay Ait-Sahalia-type interest rate model with Poisson-driven jump. Since this model does not have explicit solution, we employ several new truncated Euler-Maruyama (EM) techniques to investigate finite time strong convergence theory of the numerical solutions under the local Lipschitz condition plus the Khasminskii-type condition. We justify the strong convergence result for Monte Carlo calibration and valuation of some debt and derivative instruments.

Key words: Stochastic interest rate model, delay volatility, Poisson jump, truncated EM scheme, strong convergence, Monte Carlo scheme.

## 1 Introduction

Despite of the popularity of several asset price stochastic models such as Black-Scholes (1973) [\[1\]](#page-25-0), Merton (1973) [\[2\]](#page-25-1), Vasicek (1977) [\[3\]](#page-25-2), Dothan (1978) [\[4\]](#page-25-3), Brennan and Schwartz (1980) [\[5\]](#page-25-4), Cox, Ingersoll and Ross (CIR) (1985) [\[6\]](#page-25-5) and Lewis (2000) [\[19\]](#page-26-0), they may not be well-specified adequately to fully explain certain types of empirical phenomena in most financial markets. For instance, volatility 'skews' and 'smiles', and tail distribution of asset prices which have been observed empirically from various sources of financial data, may not be captured by these models (e.g., see [\[7,](#page-25-6) [10,](#page-25-7) [28\]](#page-26-1)).

In recent times, several interesting research works have been directed towards adequate explanation of dynamical behaviours of financial variables against unexpected occurrences of these empirical phenomena. For instance, contrary to efficient market hypothesis, the delayed GBM [\[7\]](#page-25-6), CIR [\[12\]](#page-25-8) and CEV [\[13\]](#page-25-9) models have been introduced as extensions of [\[1\]](#page-25-0), [\[6\]](#page-25-5) and [\[19\]](#page-26-0) to incorporate volatility 'skews' and 'smiles' based on non-Markovian property to explain asset price dynamics. Similarly, a variety of jump diffusion models have also been proposed to explain jump behaviour or tails of distribution of asset prices. For references, see, for example, Merton (1976) [\[8\]](#page-25-10), Lin and Yeh (1999) [\[9\]](#page-25-11) , Kou (2002) [\[10\]](#page-25-7) and Wu et al. (2008) [\[11\]](#page-25-12).

Ait-Sahalia model proposed in [\[14\]](#page-25-13) serves extensively as an indispensable tool for capturing dynamics of term structure of interest rates. This model is driven by a highly nonlinear stochastic differential equation (SDE)

 $x(0) = x_0$ , for any  $t > 0$ , where  $\alpha_{-1}, \alpha_0, \alpha_1, \alpha_2$  are positive constants and  $\theta > 1$ . Besides interest rates, it has also been considerably used to explain dynamics of asset price, volatility and other financial instruments. There have been several rich literature concerning with this model. For instance, Cheng (2009) in [\[16\]](#page-26-2) studied this model and established weak convergence of EM scheme. Szpruch et al. (2011) in [\[15\]](#page-26-3) generalised this model and established strong convergence of implicit EM method as well as preservation of positive approximate solutions of this method when a monotone condition is fulfilled. Dung (2016) in [\[17\]](#page-26-4) derived explicit estimates for tail probabilities of solutions to the generalised form of this model. Deng et al. in [\[18\]](#page-26-5) studied analytical properties of the generalised form of this model with Poisson-driven jump and revealed weak convergence of EM method.

While the SDE [\(1\)](#page-1-0) enjoys significant patronage of both market participants and practitioners, it may also not be well specified to adequately explain interest rate dynamics in response to joint effects of extreme volatility and jump behaviour or information flows as observed empirically from most financial markets. This motivates the need to modify this model to help explain adequately these empirical phenomena more collectively. In modelling context, it is worthwhile to extend SDE [\(1\)](#page-1-0) to incorporate delayed volatility function and Poisson-driven jump described by

dx(t) = (\alpha_{-1}x(t^{-})^{-1} - \alpha_0 + \alpha_1x(t^{-}) - \alpha_2x(t^{-})^{\rho})dt + \varphi(x((t-\tau)^{-}))x(t^{-})^{\theta}dB(t) + \alpha_3x(t^{-})dN(t) \tag{2}
$$

on  $t \geq -\tau$  with initial data  $x(t) = \xi(t)$  for  $t \in [-\tau, 0]$ . Here  $x(t^{-}) = \lim_{s \to t^{-}} x(s)$ ,  $x((t - \tau)^{-})$  denotes delay in  $x(t^-)$ ,  $\varphi(\cdot)$  depends on  $x((t-\tau)^-)$  with  $\tau > 0$ . Moreover,  $\alpha_{-1}, \alpha_0, \alpha_1, \alpha_2, \alpha_3 > 0$ ,  $\rho, \theta > 1$ ,  $B(t)$  is a scalar Brownian motion and  $N(t)$  is a scalar Poisson process independent of  $B(t)$  with a scalar compensated Poisson process defined by  $N(t) = N(t) - \lambda t$ , where  $\lambda$  is the jump intensity.

The SDDE [\(2\)](#page-1-1) is characterised by two distinguished features. The delayed volatility function may explain volatility 'smiles' and 'skews' which are common in most financial markets. On the other hand, the Poisson-driven jump may account for responses of interest rates to discontinuous random effects generated in connection with unexpected catastrophic news or lack of information.

It is worth observing that the SDDE [\(2\)](#page-1-1) is not analytically tractable and so there is a need to employ an efficient numerical scheme to estimate the exact solution. We cannot in this case employ classical explicit EM method which requires coefficients to be of linear growth (e.g., see [\[21\]](#page-26-6)). Meanwhile, the truncated EM scheme recently developed in [\[23\]](#page-26-7) serves as a useful explicit numerical tool for strong convergent approximation of SDEs with superlinear coefficients. In this work, we aim at investigating the  $L^p$  (where  $p \geq 2$ ) finite time strong convergence of the truncated EM solutions of system of SDDE [\(2\)](#page-1-1) under the local Lipschitz condition plus the Khasminskii-type condition. Essentially, this work extends results in [\[24\]](#page-26-8) to cope with random jumps.

The rest of the paper is organised as follows: In section 2, we will study the existence of a unique global solution to SDDE [\(2\)](#page-1-1) and show that the solution will always be positive. We will also establish moment bounds of the exact solution in section 2. In section 3, we will present the truncated EM approximation scheme for SDDE [\(2\)](#page-1-1). Section 4 will be entirely devoted to explore numerical properties of the truncated EM scheme including  $L^p$  finite time strong convergence of the truncated EM approximate solutions to the exact solution. In section 5, we will apply the strong convergence result within a Monte Carlo framework to value some debt and derivative instruments. Finally, we will perform some numerical illustrations to support the findings in section 6.

## 2 Analytical properties

In this section, we establish existence of uniqueness and moment bounds of the exact solution to SDDE [\(2\)](#page-1-1). In sequel, let introduce the following mathematical notations and settings.

#### 2.1 Mathematical preliminaries

Throughout this paper unless otherwise specified, we let  $\{\Omega, \mathcal{F}, \{\mathcal{F}_t\}_{t>0}, \mathbb{P}\}$  be a complete probability space with filtration  $\{\mathcal{F}_t\}_{t\geq 0}$  satisfying the usual conditions (i.e, it is increasing and right continuous while  $\mathcal{F}_0$  contains all P-null sets), and let E denote the expectation corresponding to P. Let  $B(t)$ ,  $t \geq$ 0, be a scalar Brownian motion defined on the above probability space. Let  $N(t)$  be a scalar Poisson process independent of  $B(t)$  with compensated Poisson process  $\tilde{N}(t) = N(t) - \lambda t$ , where  $\lambda$  is the jump intensity, also defined on the above probability space. If x, y are real numbers, then  $x \vee y$  denotes the maximum of x and y, and  $x \wedge y$  denotes the minimum of x and y. Let  $\mathbb{R} = (-\infty, \infty)$  and  $\mathbb{R}_+ = (0, \infty)$ . For  $\tau > 0$ , let  $C([-\tau,0];\mathbb{R}_+)$  denote the space of all continuous functions  $\xi : [-\tau,0] \to \mathbb{R}_+$  with the norm  $\|\xi\| = \sup_{-\tau \le t \le 0} \xi(t)$ . For an empty set  $\emptyset$ , we set inf  $\emptyset = \infty$ . For a set A, we denote its indication function by  $1_A$ . Let the following dynamics

 $x(t) = \xi(t)$ , on  $t \in [-\tau, \infty)$ , denote equation of SDDE [\(2\)](#page-1-1) such that  $f(x) = \alpha_{-1}x^{-1} - \alpha_0 + \alpha_1x - \alpha_2x^{\rho}$ ,  $g(x) = x^{\theta}$  and  $h(x) = \alpha_3 x$ ,  $\forall x \in \mathbb{R}_+$ , with  $\varphi(\cdot)$  defined in  $C(\mathbb{R}_+;\mathbb{R}_+)$ . Let  $C^{2,1}(\mathbb{R} \times \mathbb{R}_+;\mathbb{R})$  be the family of all real-valued functions  $Z(x,t)$  defined on  $\mathbb{R}\times\mathbb{R}_+$  such that  $Z(x,t)$  is twice continuously differentiable in x and once in t. For each  $Z \in C^{2,1}(\mathbb{R} \times \mathbb{R}_+;\mathbb{R})$ , define the jump-diffusion operator  $LZ : \mathbb{R} \times \mathbb{R} \times \mathbb{R}_+ \to \mathbb{R}$  by

for SDDE [\(3\)](#page-2-0) associated with the  $C^{2,1}$ -function Z, where

$$
\ell(x, y, t) = Z_t(x, t) + Z_x(x, t)f(x) + \frac{1}{2}Z_{xx}(x, t)\varphi(y)^2 g(x)^2,
$$
\n(5)

 $\ell Z : \mathbb{R} \times \mathbb{R} \times \mathbb{R}_+ \to \mathbb{R}$ , is the diffusion operator,  $Z_t(x, t)$  and  $Z_x(x, t)$  are first-order partial derivatives with respect to t and x respectively, and  $Z_{xx}(x, t)$ , a second-order partial derivative with respect to x. With the jump-diffusion operator defined, the Itô formula then yields

dZ(x(t),t) = LZ(x(t^-),x((t-\tau)^-),t)dt + \varphi(x((t-\tau)^-))Z_x(x(t^-),t)g(x(t^-))dB(t)

almost surely. We refer the reader, for instance, to [\[29\]](#page-26-9) for detailed coverage of [\(6\)](#page-2-1).

#### 2.2 Existence of nonnegative solution

Before we show existence of nonnegative solution to SDDE [\(3\)](#page-2-0), we are required to assume the volatility function  $\varphi(\cdot)$  is locally Lipschitz continuous and bounded (see, e.g., 7) for detailed accounts of these conditions). The following conditions are thus sufficient to establish existence of a unique positive global or nonexplosive solution to SDDE [\(3\)](#page-2-0).

<span id="page-3-0"></span>**Assumption 2.1.** The volatility function  $\varphi : \mathbb{R}_+ \to \mathbb{R}_+$  of SDDE [\(3\)](#page-2-0) is Borel-measurable and bounded by a positive constant  $\sigma$ , *i.e.*

\varphi(y) \le \sigma,\tag{7}
$$

 $\forall y \in \mathbb{R}_+$ .

<span id="page-3-1"></span>Assumption 2.2. The parameters of SDDE [\(3\)](#page-2-0) satisfy

1 + \rho > 2\theta. \tag{8}
$$

The following theorem reveals the SDDE [\(3\)](#page-2-0) admits a pathwise-unique positive global solution  $x(t)$  on  $t \in [-\tau, \infty)$ . Since SDDE [\(3\)](#page-2-0) describes interest rate dynamics, the solution will always remain nonnegative almost surely.

<span id="page-3-3"></span>**Theorem 2.3.** Let Assumptions [2.1](#page-3-0) and [2.2](#page-3-1) hold. Then for any given initial data

\{x(t) : -\tau \le t \le 0\} = \xi(t) \in C([-\tau, 0]) : \mathbb{R}_+),\tag{9}
$$

there exists a unique global solution  $x(t)$  to SDDE [\(3\)](#page-2-0) on  $t \in [-\tau, \infty)$  and  $x(t) > 0$  a.s.

*Proof.* Since the coefficient terms of SDDE [\(3\)](#page-2-0) are locally Lipschitz continuous in  $[-\tau, \infty)$ , then there exists a unique positive maximal local solution  $x(t) \in [-\tau, \tau_e)$  for any given initial data [\(9\)](#page-3-2), where  $\tau_e$ is the explosion time. Let  $n_0 > 0$  be sufficiently large such that

$$
\frac{1}{n_0} < \min_{-\tau \le t \le 0} |\xi(t)| \le \max_{-\tau \le t \le 0} |\xi(t)| < n_0.
$$

For each integer  $n \geq n_0$ , define the stopping time

\tau_n = \inf \{ t \in [0, \tau_e) : x(t) \notin (1/n, n) \}. \tag{10}
$$

Obviously,  $\tau_n$  is increasing as  $n \to \infty$ . Set  $\tau_\infty = \lim_{n \to \infty} \tau_n$ , whence  $\tau_\infty \leq \tau_e$  almost surely. In other words, we need to show that  $\tau_{\infty} = \infty$  almost surely to complete the proof. For any  $\beta \in (0, 1)$ , define a  $C^2$ -function  $Z : \mathbb{R}_+ \to \mathbb{R}_+$  by

Clearly  $Z(x) \to \infty$  as  $x \to \infty$  or  $x \to 0$ . By Assumption [2.1,](#page-3-0) we get from the operator in [\(4\)](#page-2-2) that

LZ(x,y) \le \ell Z(x,y) + \lambda \Big( (x + \alpha_3 x)^{\beta} - 1 - \beta \log(x + \alpha_3 x) - (x^{\beta} - 1 - \beta \log(x)) \Big)
$$
  
=  $\ell Z(x,y) + \lambda \Big( ((x + \alpha_3 x)^{\beta} - x^{\beta}) - \beta \log(x(\alpha_3)/x) \Big)$   
=  $\ell Z(x,y) + \lambda ((1 + \alpha_3)^{\beta} - 1)x^{\beta} - \lambda \beta \log(1 + \alpha_3),$ 

where

$$
\ell(x,y) = \beta(x^{\beta-1} - x^{-1})(\alpha_{-1}x^{-1} - \alpha_0 + \alpha_1x - \alpha_2x^{\rho}) + \frac{1}{2}(\beta(\beta-1)x^{\beta-2} + \beta x^{-2})\varphi(y)^2x^{2\theta}
$$
  
\n
$$
\leq \alpha_{-1}\beta x^{\beta-2} - \alpha_0\beta x^{\beta-1} + \alpha_1\beta x^{\beta} - \alpha_2\beta x^{\rho+\beta-1} - \alpha_{-1}\beta x^{-2} + \alpha_0\beta x^{-1}
$$
  
\n
$$
- \alpha_1\beta + \alpha_2\beta x^{\rho-1} + \frac{\sigma^2}{2}\beta(\beta-1)x^{\beta+2\theta-2} + \frac{\sigma^2}{2}\beta x^{2\theta-2}.
$$

Since  $\beta \in (0,1)$  and by Assumption [2.2,](#page-3-1) we note  $-\alpha_{-1}\beta x^{-2}$  leads and tends to  $-\infty$  for small x and for large  $x, -\alpha_2\beta x^{\rho+\beta-1}$  leads and also tends to  $-\infty$ . Hence there exists a constant  $K_0$  such that

$$
LZ(x,y) \le K_0. \tag{12}
$$

So for  $t_1 \in [0, \tau]$ , we derive from the Itô formula

$$
\mathbb{E}[Z(x(\tau_n \wedge t_1))] \leq Z(\xi(0)) + \int_0^{\tau_n \wedge t_1} K_0 dt,
$$

 $\forall n \geq n_0$ . It then follows that

$$
\mathbb{P}(\tau_n \le \tau) \le \frac{Z(\xi(0)) + K_0 \tau}{Z(1/n) \wedge Z(n)}.
$$

As  $n \to \infty$ ,  $\mathbb{P}(\tau_n \leq \tau) \to 0$ . This implies  $\tau_\infty > \tau$  a.s. Also for  $t_1 \in [0, 2\tau]$ , the Itô formula yields

$$
\mathbb{E}[Z(x(\tau_n \wedge t_1))] \leq Z(\xi(0)) + \int_0^{\tau_n \wedge t_1} K_0 dt,
$$

 $\forall n \geq n_0$  and consequently,

$$
\mathbb{P}(\tau_n \leq 2\tau) \leq \frac{Z(\xi(0)) + 2K_0\tau}{Z(1/n) \wedge Z(n)}.
$$

As  $n \to \infty$ , we get  $\tau_{\infty} > 2\tau$  a.s. Repeating this procedure for  $t_1 \in [0,\infty]$ , we obtain  $\mathbb{P}(\tau_{\infty} \leq \infty) \to 0$ by letting  $n \to \infty$ . This means  $\tau_{\infty} = \infty$  *a.s* and hence  $\tau_e = \infty$  *a.s.* The proof is now complete.  $\mathcal{L}_{\mathcal{A}}$ 

#### 2.3 Moment bound

The following lemmas show moments of the exact solution to SDDE [\(3\)](#page-2-0) are upper bounded.

<span id="page-4-2"></span>**Lemma 2.4.** Let Assumptions [2.1](#page-3-0) and [2.2](#page-3-1) hold. Then for any  $p \ge 2$ , there exists a constant  $\rho_1$  such that the solution of SDDE [\(3\)](#page-2-0) satisfies

$$
\sup_{0 \le t < \infty} \left( \mathbb{E} |x(t)|^p \right) \le \rho_1. \tag{13}
$$

*Proof.* Define the stopping time for every sufficiently large integer  $n$  by

$$
\tau_n = \inf\{t \ge 0 : x(t) \notin (1/n, n)\}.
$$
\n(14)

Define a function  $Z \in C^{2,1}(\mathbb{R}_+ \times \mathbb{R}_+; \mathbb{R}_+)$  by  $Z(x,t) = e^t x^p$ . By Assumption [2.1,](#page-3-0) the jump-diffusion operator in [\(4\)](#page-2-2) gives us

$$
LZ(x, y, t) \le \ell Z(x, y, t) + \lambda [e^t (x + \alpha_3 x)^p - e^t x^p]
$$
  
=  $\ell Z(x, y, t) + \lambda e^t x^p [(1 + \alpha_3)^p - 1],$ 

where

$$
\ell Z(x, y, t) = e^t x^p + p e^t x^{p-1} (\alpha_{-1} x^{-1} - \alpha_0 + \alpha_1 x - \alpha_2 x^p) + \frac{1}{2} p(p-1) e^t x^{p-2} \varphi^2(y) x^{2\theta}
$$
  

$$
\leq e^t [x^p + \alpha_{-1} px^{p-2} - \alpha_0 px^{p-1} + \alpha_1 px^p - \alpha_2 px^{p+p-1} + \frac{p(p-1)}{2} \sigma^2 x^{2\theta + p-2}].
$$

By Assumption [2.2,](#page-3-1)  $-p\alpha_2 x^{\rho+p-1}$  dominates and tends to  $-\infty$  for large x. Hence we can find a constant  $K_1$  such that

$$
LZ(x, y, t) \le K_1 e^t.
$$

The Itô formula gives us

$$
\mathbb{E}[e^{t\wedge\tau_n}|x(t\wedge\tau_n)|^p] \leq |\xi(0)|^p + K_1e^t.
$$

Applying the Fatou lemma and letting  $n \to \infty$  yields

$$
\mathbb{E}|x(t)|^p < e^{-t}|\xi(0)|^p + K_1
$$

and consequently,

$$
\sup_{0\leq t<\infty} (\mathbb{E}|x(t)|^p) \leq \rho_1.
$$

as the required assertion in [\(13\)](#page-4-0).

**Lemma 2.5.** Let Assumptions [2.1](#page-3-0) and [2.2](#page-3-1) hold. For any  $p > 2 \vee (p-1)$ , there exists a constant  $p_2$ such that the solution of SDDE [\(3\)](#page-2-0) satisfies

\sup_{0 \le t < \infty} \left( \mathbb{E} |\frac{1}{x(t)}|^p \right) \le \rho_2. \tag{15}
$$

*Proof.* Let  $\tau_n$  be the same as in [\(14\)](#page-4-1). By applying [\(4\)](#page-2-2) to  $Z(x,t) = e^t/x^p$ , we compute

$$
LZ(x, y, t) \le \ell Z(x, y, t) + \lambda [e^t (x + \alpha_3 x)^{-p} - e^t x^{-p}]
$$
  
=  $\ell Z(x, y, t) + \lambda e^t x^{-p} [(1 + \alpha_3)^{-p} - 1],$ 

where Assumption [2.1](#page-3-0) has been used and here, we have

$$
\ell Z(x, y, t) = e^t x^{-p} - p e^t x^{-(p+1)} (\alpha_{-1} x^{-1} - \alpha_0 + \alpha_1 x - \alpha_2 x^{\rho}) + \frac{1}{2} p(p+1) e^t x^{-(p+2)} \varphi(y)^2 x^{2\theta}
$$
  

$$
\leq e^t [x^{-p} - \alpha_{-1} px^{-(p+2)} + \alpha_0 px^{-(p+1)} - \alpha_1 px^{-p} + \alpha_2 x^{\rho-p-1} - \frac{p(p+1)}{2} \sigma^2 x^{2\theta-p-2}].
$$

By Assumption [2.2](#page-3-1) and noting that  $p > 2 \vee (p-1)$ , we observe  $-\alpha_{-1}px^{-(p+2)}$  leads and tends to  $-\infty$ for small x and for large x,  $p\alpha_2 x^{\rho-p-1}$  dominates and tends to 0. Hence there exists a constant  $K_2$ such that

$$
LZ(x, y, t, ) \leq K_2 e^t.
$$

We can now use the Itô formula, apply Fatou lemma and let  $n \to \infty$  to arrive at

$$
\mathbb{E}|x(t)|^{-p} < e^{-t}|\xi(0)|^{-p} + K_2
$$

and consequently the required assertion in [\(15\)](#page-5-0).

## 3 The truncated EM method

In this section, we present the truncated EM scheme for numerical approximation of SDDE [\(3\)](#page-2-0). Meanwhile, we need the following assumptions which will be used later.

<span id="page-6-4"></span>**Assumption 3.1.** There is a pair of constant  $K_3 > 0$  and  $\gamma \in (0,1]$  such that for all  $-\tau \le s \le t \le 0$ , the initial data  $\xi$  satisfies

$$
|\xi(t) - \xi(s)| \le K_3 |t - s|^\gamma. \tag{16}
$$

<span id="page-6-7"></span>**Assumption 3.2.** For any  $R > 0$ , there exists a constant  $L_R > 0$  such that the volatility function  $\varphi(\cdot)$  of SDDE [\(3\)](#page-2-0) satisfies

|\varphi(y) - \varphi(\bar{y})| \le L_R |y - \bar{y}| \tag{17}
$$

 $\forall y, \bar{y} \in [1/\mathbb{R}, \mathbb{R}].$ 

In the sequel, we also need these lemmas below.

<span id="page-6-5"></span>**Lemma 3.3.** For any  $R > 0$ , there exists a constant  $K_R > 0$  such that the coefficient terms f, g and h of SDDE [\(3\)](#page-2-0) satisfy

<span id="page-6-1"></span>
$$
|f(x) - f(\bar{x})| \vee |g(x) - g(\bar{x})| \vee |h(x) - h(\bar{x})| \le K_R |x - \bar{x}|,
$$
\n(18)

 $\forall x, \bar{x} \in [1/\mathbb{R}, \mathbb{R}].$ 

**Lemma 3.4.** Let Assumptions [2.1](#page-3-0) and [2.2](#page-3-1) hold. Then for any  $p \ge 2$ , there exists  $K_4 > 0$  such that the drift and diffusion terms of SDDE [\(3\)](#page-2-0) satisfy

<span id="page-6-2"></span>
$$
xf(x) + \frac{p-1}{2} |\varphi(y)g(x)|^2 \le K_4(1+|x|^2),\tag{19}
$$

 $\forall x, y \in \mathbb{R}_+$ , where  $K_4$  is a constant (see [\[24\]](#page-26-8) for the proof).

### 3.1 Numerical approximation

Before we proceed, let extend the volatility function  $\varphi(\cdot)$  and the jump term  $h(\cdot)$  from  $\mathbb{R}_+$  to  $\mathbb R$  by setting  $\varphi(x) = \varphi(0)$  and  $h(x) = 0$  for  $x < 0$ . Apparently, Theorem [2.3](#page-3-3) as well as conditions [\(7\)](#page-3-4), [\(17\)](#page-6-0), [\(18\)](#page-6-1) and [\(19\)](#page-6-2) are well maintained. Moreover, we need not truncate the jump term since it is of linear growth. To define the truncated EM scheme for SDDE [\(3\)](#page-2-0), we first choose a strictly increasing continuous function  $\mu : \mathbb{R}_+ \to \mathbb{R}_+$  such that  $\mu(r) \to \infty$  as  $r \to \infty$  and

$$
\sup_{1/r \le x \le r} (|f(x)| \vee g(x)) \le \mu(r), \quad \forall r > 1.
$$
\n(20)

<span id="page-6-8"></span>Denote by  $\mu^{-1}$  the inverse function of  $\mu$ . We define a strictly decreasing function  $\pi : (0,1) \to \mathbb{R}_+$ such that

$$
\lim_{\Delta \to 0} \pi(\Delta) = \infty \text{ and } \Delta^{1/4}\pi(\Delta) \le 1, \quad \forall \Delta \in (0, 1].
$$
 (21)

Find  $\Delta^* \in (0,1)$  such that  $\mu^{-1}(\pi(\Delta^*)) > 1$  and  $f(x) > 0$  for  $0 < x < \Delta^*$ . For a given step size  $\Delta \in (0, \Delta^*)$ , let us define the truncated functions

$$
f_{\Delta}(x) = f\Big(1/\mu^{-1}(\pi(\Delta)) \vee (x \wedge \mu^{-1}(\pi(\Delta)))\Big), \quad \forall x \in \mathbb{R}
$$

and

$$
g_{\Delta}(x) = \begin{cases} g\Big(x \wedge \mu^{-1}(\pi(\Delta))\Big), & \text{if } x \ge 0 \\ 0, & \text{if } x < 0. \end{cases}
$$

So for  $x \in [1/\mu^{-1}(\pi(\Delta)), \mu^{-1}(\pi(\Delta))],$  we have

$$
|f_{\Delta}(x)| = |f(x)| \le \max_{1/\mu^{-1}(\pi(\Delta)) \le w \le \mu^{-1}(\pi(\Delta))} |f(w)|
$$
  

$$
\le \mu(\mu^{-1}(\pi(\Delta))) = \pi(\Delta)
$$

and

$$
g_{\Delta}(x) \leq \mu(\mu^{-1}(\pi(\Delta))) = \pi(\Delta).
$$

We easily observe that

<span id="page-7-0"></span>
$$
|f_{\Delta}(x)| \vee g_{\Delta}(x) \le \pi(\Delta), \quad \forall x \in \mathbb{R}.
$$
 (22)

That is, both truncated functions  $f_{\Delta}$  and  $g_{\Delta}$  are bounded although both f and g may not. The following lemma shows  $f_$ Delta and  $g_$ Delta maintain [\(19\)](#page-6-2) nicely.

<span id="page-7-1"></span>**Lemma 3.5.** Let Assumptions [2.1](#page-3-0) and [2.2](#page-3-1) hold. Then, for all  $\Delta \in (0, \Delta^*)$  and  $p \geq 2$ , the truncated functions satisfy

$$
xf_{\Delta}(x) + \frac{p-1}{2}|\varphi(y)g_{\Delta}(x)|^2 \le K_5(1+|x|^2)
$$
\n(23)

 $\forall x, y \in \mathbb{R}$ , where  $K_5$  is a constant independent of  $\Delta$  (see [\[24\]](#page-26-8) for the proof).

From now on, let  $T > 0$  be fixed arbitrarily and the step size  $\Delta \in (0, \Delta^*)$  be a fraction of  $\tau$ . We define  $\Delta = \tau/M$  for some positive integer M. Let now form the discrete-time truncated EM approximation of SDDE [\(3\)](#page-2-0). Define  $t_k = k\Delta$  for  $k = -M, -(M-1), ..., 0, 1, 2, ...$  Set  $X_{\Delta}(t_k) = \xi(t_k)$ for  $k = -M, -(M-1), \ldots, 0$  and then compute

$$
X_{\Delta}(t_{k+1}) = X_{\Delta}(t_k) + f_{\Delta}(X_{\Delta}(t_k))\Delta + \varphi(X_{\Delta}(t_{k-M}))g_{\Delta}(X_{\Delta}(t_k))\Delta B_k + h(X_{\Delta}(t_k))\Delta N_k \tag{24}
$$

for  $k = 0, 1, 2...$ , where  $\Delta B_k = B(t_{k+1}) - B(t_k)$  and  $\Delta N_k = N(t_{k+1}) - N(t_k)$ . Let now form two versions of the continuous-time truncated EM solutions. The first one is defined by

<span id="page-7-3"></span><span id="page-7-2"></span>
$$
\bar{x}_{\Delta}(t) = \sum_{k=-M}^{\infty} X_{\Delta}(t_k) 1_{[t_k, t_{k+1})}(t).
$$
\n(25)

This is the continuous-time step-process  $\bar{x}_{\Delta}(t)$  on  $t \in [-\tau, \infty]$ , where  $1_{[t_k, t_{k+1})}$  is the indicator function on  $[t_k, t_{k+1})$ . The other one is the continuous-time continuous process  $x_{\Delta}(t)$  on  $t \geq -\tau$  defined conveniently by setting  $x_\Delta(t) = \xi(t)$  for  $t \in [-\tau, 0]$  while for  $t \geq 0$ 

$$
x_{\Delta}(t) = \xi(0) + \int_0^t f_{\Delta}(\bar{x}_{\Delta}(s^-))ds + \int_0^t \varphi(\bar{x}_{\Delta}((s-\tau)^{-}))g_{\Delta}(\bar{x}_{\Delta}(s^-))dB(s) + \int_0^t h(\bar{x}_{\Delta}(s^-))dN(s). \tag{26}
$$

Obviously  $x_\Delta(t)$  is an Itô process on  $t \geq 0$  satisfying Itô differential

$$
dx_{\Delta}(t) = f_{\Delta}(\bar{x}_{\Delta}(t^{-}))dt + \varphi(\bar{x}_{\Delta}((t-\tau)^{-}))g_{\Delta}(\bar{x}_{\Delta}(t^{-}))dB(t) + h(\bar{x}_{\Delta}(t^{-}))dN(t). \tag{27}
$$

For all  $k = -M, -(M-1), \dots$  It is useful to see that  $x_{\Delta}(t_k) = \bar{x}_{\Delta}(t_k) = X_{\Delta}(t_k)$ .

## 4 Numerical properties

In this section, we establish moment bound and finite time strong convergence theory of the truncated EM solutions to SDDE [\(3\)](#page-2-0).

### 4.1 Moment bound

To upper bound the moment of the truncated EM solution, let first define

<span id="page-8-0"></span>
$$
k(t) = [t/\Delta]\Delta,
$$

for any  $t \in [0, T]$ , where  $[t/\Delta]$  denotes the integer part of  $t/\Delta$ . The following lemma shows  $x_\Delta(t)$ and  $\bar{x}_{\Delta}(t)$  are close to each other in  $L^p$ .

<span id="page-8-2"></span>**Lemma 4.1.** Let Assumption [2.1](#page-3-0) hold. Then for any fixed  $\Delta \in (0, \Delta^*]$ , we have

$$
\mathbb{E}\Big(|x_{\Delta}(t)-\bar{x}_{\Delta}(t)|^{p}\big|\mathcal{F}_{k(t)}\Big) \leq \mathfrak{D}_{1}\Big(\Delta^{p/2}(\pi(\Delta))^{p}+\Delta\Big)|\bar{x}_{\Delta}(t)|^{p}, \quad p \in [2,\infty)
$$
\n(28)

<span id="page-8-1"></span>and

$$
\mathbb{E}\Big(|x_{\Delta}(t)-\bar{x}_{\Delta}(t)|^{p}\big|\mathcal{F}_{k(t)}\Big) \leq \mathfrak{D}_{2}\Big(\Delta^{p/2}(\pi(\Delta))^{p}\Big)|\bar{x}_{\Delta}(t)|^{p}, \quad p \in (0,2),\tag{29}
$$

for all  $t \geq 0$ , where  $\mathfrak{D}_1$  and  $\mathfrak{D}_2$  denote positive generic constants which depend only on p and may change between occurrences.

*Proof.* Fix any  $\Delta \in (0, \Delta^*)$  and  $t \in [0, T]$ . Then for  $p \in [2, \infty)$ , we derive

$$
\mathbb{E}\Big(|x_{\Delta}(t)-\bar{x}_{\Delta}(t)|^{p}|\mathcal{F}_{k(t)}\Big)
$$
\n
$$
\leq 3^{p-1}\Big(\mathbb{E}\big(\big|\int_{k(t)}^{t}f_{\Delta}(\bar{x}_{\Delta}(s^{-}))ds|^{p}|\mathcal{F}_{k(t)}\big)+\mathbb{E}\big(\big|\int_{k(t)}^{t}\varphi(\bar{x}_{\Delta}((s-\tau)^{-}))g_{\Delta}(\bar{x}_{\Delta}(s^{-}))dB(s)|^{p}|\mathcal{F}_{k(t)}\big)
$$
\n
$$
+\mathbb{E}\big(\big|\int_{k(t)}^{t}h(\bar{x}_{\Delta}(s^{-}))dN(s)|^{p}|\mathcal{F}_{k(t)}\big)\Big)
$$
\n
$$
\leq 3^{p-1}\Big(\Delta^{p-1}\mathbb{E}\big(\int_{k(t)}^{t}|f_{\Delta}(\bar{x}_{\Delta}(s^{-}))|^{p}ds|\mathcal{F}_{k(t)}\big)+c(p)\Delta^{(p-2)/2}\mathbb{E}\big(\int_{k(t)}^{t}|\varphi(\bar{x}_{\Delta}((s-\tau)^{-}))g_{\Delta}(\bar{x}_{\Delta}(s^{-}))|^{p}ds|\mathcal{F}_{k(t)}\big)
$$
\n
$$
+\mathbb{E}\big(\big|\int_{k(t)}^{t}h(\bar{x}_{\Delta}(s^{-}))dN(s)|^{p}|\mathcal{F}_{k(t)}\big)\Big)
$$
\n
$$
\leq 3^{p-1}\Big(\Delta^{p-1}\Delta(\pi(\Delta))^{p}+c(p)\Delta^{(p-2)/2}\Delta(\sigma\pi(\Delta))^{p}+\mathbb{E}\big(\big|\int_{k(t)}^{t}h(\bar{x}_{\Delta}(s^{-}))dN(s)|^{p}|\mathcal{F}_{k(t)}\big)\Big),
$$

where Assumption [2.1](#page-3-0) and [\(22\)](#page-7-0) have been used and  $c(p)$  depends on p. By the characteristic function's argument (see [\[27\]](#page-26-10)), we have

$$
\mathbb{E}|\Delta N_k|^p \leq \bar{c}\Delta, \quad \forall \Delta \in (0, \Delta^*),
$$

where  $\bar{c}$  is a positive constant independent of  $\Delta$ . We now obtain

$$
\mathbb{E}\left(\left|\int_{k(t)}^t h(\bar{x}_\Delta(s^-))dN(s)|^p\right|\mathcal{F}_{k(t)}\right) = |h(\bar{x}_\Delta(k(t)))|^p \mathbb{E}|\Delta N_k|^p.
$$

This implies

$$
\mathbb{E}\Big(|x_{\Delta}(t)-\bar{x}_{\Delta}(t)|^p\big|\mathcal{F}_{k(t)}\Big)\leq 3^{p-1}\Big(\Delta^{p-1}\Delta(\pi(\Delta))^p+c(p)\Delta^{(p-2)/2}\Delta(\sigma\pi(\Delta))^p+|h(\bar{x}_{\Delta}(k(t))|^p\mathbb{E}|\Delta N_k|^p\Big),
$$

where  $h(\bar{x}_{\Delta}(t_k))$  is independent of  $N_k$ . We now have

$$
\mathbb{E}\Big(|x_{\Delta}(t)-\bar{x}_{\Delta}(t)|^{p}\Big|\mathcal{F}_{k(t)}\Big) \leq 3^{p-1}\Big((1\vee c(p)\sigma^{p})\Delta^{p/2}(\pi(\Delta))^{p}+\bar{c}\alpha_{3}^{p}|\bar{x}_{\Delta}(t^{-})|^{p}\Delta\Big) \leq 3^{p-1}(1\vee c(p)\sigma^{p}\vee\bar{c}\alpha_{3}^{p})\Big(\Delta^{p/2}(\pi(\Delta))^{p}+|\bar{x}_{\Delta}(t)|^{p}\Delta\Big) \leq \mathfrak{D}_{1}\Big(\Delta^{p/2}(\pi(\Delta))^{p}+\Delta\Big)|\bar{x}_{\Delta}(t)|^{p},
$$

which is [\(28\)](#page-8-0), where  $\mathfrak{D}_1 = 3^{p-1}[(1 \vee c(p)\sigma^p) \vee \overline{c}\alpha_3^p]$ <sup>p</sup><sub>3</sub>. For  $p \in (0, 2)$ , the Jensen inequality yields

$$
\mathbb{E}\Big(|x_{\Delta}(t) - \bar{x}_{\Delta}(t)|^p \Big| \mathcal{F}_{k(t)}\Big) \leq \Big\{\mathbb{E}\Big(|x_{\Delta}(t) - \bar{x}_{\Delta}(t)|^2 \Big| \mathcal{F}_{k(t)}\Big)\Big\}^{p/2} \leq \Big\{\mathfrak{D}_1\Big(\Delta(\pi(\Delta))^2 + \Delta\Big)|\bar{x}_{\Delta}(t)|^p\Big\}^{p/2} \leq 2^{p/2-1}\mathfrak{D}_1^{p/2}\Big(\Delta^{p/2}(\pi(\Delta))^p + \Delta^{p/2}\Big)(|\bar{x}_{\Delta}(t)|^p)^{p/2} \leq \mathfrak{D}_2\Big(\Delta^{p/2}(\pi(\Delta))^p\Big)|\bar{x}_{\Delta}(t)|^p,
$$

which is the required assertion in [\(29\)](#page-8-1), where  $\mathfrak{D}_2 = 2^{p/2} \mathfrak{D}_1^{p/2}$  $1^{p/2}$ . The proof is thus complete.  $\Box$ 

We can now upper bound the moment of the truncated EM solution as follows.

<span id="page-9-0"></span>**Lemma 4.2.** Let Assumptions [2.1](#page-3-0) and [2.2](#page-3-1) hold. Then for any  $p \ge 3$ 

$$
\sup_{0 \le \Delta \le \Delta^*} \sup_{0 \le t \le T} (\mathbb{E}|x_{\Delta}(t)|^p) \le \rho_3, \quad \forall T > 0,
$$
\n(30)

where  $\rho_3 := \rho_3(T, p, K, \xi)$  and may change between occurrences.

*Proof.* Fix any  $\Delta \in (0, \Delta^*)$  and  $T \geq 0$ . For  $t \in [0, T]$ , we obtain from [\(4\)](#page-2-2), [\(20\)](#page-6-3) and Lemma [3.5](#page-7-1)

$$
\mathbb{E}|x_{\Delta}(t)|^{p} - |\xi(0)|^{p} \leq \mathbb{E}\int_{0}^{t} p|x_{\Delta}(s^{-})|^{p-2} \Big(\bar{x}_{\Delta}(s^{-})f_{\Delta}(\bar{x}_{\Delta}(s^{-})) + \frac{p-1}{2}|\varphi(\bar{x}_{\Delta}((s-\tau)^{-}))g_{\Delta}(\bar{x}_{\Delta}(s^{-}))|^{2}\Big)ds
$$
  
+ 
$$
\mathbb{E}\int_{0}^{t} p|x_{\Delta}(s^{-})|^{p-2}(x_{\Delta}(s^{-}) - \bar{x}_{\Delta}(s^{-}))f_{\Delta}(\bar{x}_{\Delta}(s^{-}))ds
$$
  
+ 
$$
\lambda \mathbb{E}\Big(\int_{0}^{t} |x_{\Delta}(s^{-}) + h(\bar{x}_{\Delta}(s^{-}))|^{p} - |x_{\Delta}(s^{-})|^{p}\Big)ds
$$
  

$$
\leq H_{11} + H_{12} + H_{13},
$$

where

$$
H_{11} = \mathbb{E} \int_0^t K_5 p |x_\Delta(s^-)|^{p-2} (1 + |\bar{x}_\Delta(s^-)|^2) ds
$$
  
\n
$$
H_{12} = \mathbb{E} \int_0^t p |x_\Delta(s^-)|^{p-2} (x_\Delta(s^-) - \bar{x}_\Delta(s^-)) f_\Delta(\bar{x}_\Delta(s^-)) ds
$$
  
\n
$$
H_{13} = \lambda \mathbb{E} \Big( \int_0^t |x_\Delta(s^-) + h(\bar{x}_\Delta(s^-))|^p - |x_\Delta(s^-)|^p \Big) ds.
$$

Applying the Young inequality, we obtain

$$
H_{11} = K_5 p \mathbb{E} \int_0^t |x_{\Delta}(s^-)|^{p-2} (1 + |\bar{x}_{\Delta}(s^-)|^2) ds
$$
  
\n
$$
\leq K_5 p \int_0^t \left( \frac{(p-2)}{p} \mathbb{E} |x_{\Delta}(s^-)|^p + \frac{2}{p} \mathbb{E} (1 + |\bar{x}_{\Delta}(s^-)|)^p \right) ds
$$
  
\n
$$
\leq K_5 \int_0^t \left( (p-2) \mathbb{E} |x_{\Delta}(s^-)|^p + 2^p (1 + \mathbb{E} |\bar{x}_{\Delta}(s^-)|^p) \right) ds
$$
  
\n
$$
\leq c_1 \int_0^t (1 + \mathbb{E} |x_{\Delta}(s)|^p + \mathbb{E} |\bar{x}_{\Delta}(s)|^p) ds,
$$

where  $c_1 = K_5[(p-2) \vee 2^p]$ . For  $s \in [0, t]$ , we note from the triangle inequality

$$
|x_{\Delta}(s^-)| \le |x_{\Delta}(s^-) - \bar{x}_{\Delta}(s^-)| + |\bar{x}_{\Delta}(s^-)|.
$$

This implies for  $p \geq 3$ , we obtain

$$
H_{12} \le p \mathbb{E} \int_0^t \left( |x_\Delta(s^-) - \bar{x}_\Delta(s^-)| + |\bar{x}_\Delta(s^-)| \right)^{p-2} |x_\Delta(s^-) - \bar{x}_\Delta(s^-)||f_\Delta(\bar{x}_\Delta(s^-))| ds
$$
  
\n
$$
\le 2^{(p-3)} p \mathbb{E} \int_0^t \left( |x_\Delta(s^-) - \bar{x}_\Delta(s^-)|^{p-2} + |\bar{x}_\Delta(s^-)|^{p-2} \right) |x_\Delta(s^-) - \bar{x}_\Delta(s^-)||f_\Delta(\bar{x}_\Delta(s^-))| ds
$$
  
\n
$$
= H_{121} + H_{122},
$$

where

$$
H_{121} = 2^{(p-3)} p \mathbb{E} \int_0^t |\bar{x}_{\Delta}(s^-)|^{p-2} |x_{\Delta}(s^-) - \bar{x}_{\Delta}(s)| |f_{\Delta}(\bar{x}_{\Delta}(s^-))| ds
$$
  

$$
H_{122} = 2^{(p-3)} p \mathbb{E} \int_0^t |x_{\Delta}(s^-) - \bar{x}_{\Delta}(s^-)|^{p-1} |f_{\Delta}(\bar{x}_{\Delta}(s^-))| ds.
$$

By Lemma [4.1](#page-8-2) and [\(22\)](#page-7-0), we now have

$$
H_{121} \leq 2^{(p-3)}p \int_0^t \mathbb{E}\Big\{|\bar{x}_{\Delta}(s)|^{p-2}|f_{\Delta}(\bar{x}_{\Delta}(s))|\mathbb{E}\Big(|x_{\Delta}(s)-\bar{x}_{\Delta}(s)|\mathcal{F}_{k(s)})\Big\rangle\Big\}ds
$$
  
\n
$$
\leq 2^{(p-3)}p\mathfrak{D}_2(\pi(\Delta))\Delta^{1/2}(\pi(\Delta)) \int_0^t \mathbb{E}\Big\{|\bar{x}_{\Delta}(s)|(|\bar{x}_{\Delta}(s)|^{p-2})\Big\}ds
$$
  
\n
$$
\leq 2^{(p-3)}p\mathfrak{D}_2(\pi(\Delta))\Delta^{1/2}(\pi(\Delta)) \int_0^t \mathbb{E}|\bar{x}_{\Delta}(s)|^{p-1}ds
$$
  
\n
$$
\leq 2^{(p-3)}p\mathfrak{D}_2(\pi(\Delta))^2\Delta^{1/2} \int_0^t \left(\frac{1}{p}+\frac{(p-1)}{p}\mathbb{E}|\bar{x}_{\Delta}(s)|^p\right)ds
$$
  
\n
$$
\leq c_2+c_3 \int_0^t \mathbb{E}|\bar{x}_{\Delta}(s)|^pds,
$$
\n(31)

where  $c_2 = 2^{(p-3)}\mathfrak{D}_2T$  and  $c_3 = 2^{(p-3)}\mathfrak{D}_2(p-1)$ , noting that  $(\pi(\Delta))\Delta^{1/4} \leq 1$  and hence

$$
[(\pi(\Delta))\Delta^{1/4}]^2 \le 1.
$$

Also by  $(22)$ , we have

$$
H_{122} \le 2^{(p-3)} p \pi(\Delta) \int_0^t \mathbb{E} |x_\Delta(s) - \bar{x}_\Delta(s)|^{p-1} ds. \tag{32}
$$

Do note for  $p \geq 3$  and  $\bar{w} \in (0, 1/4]$ , we have  $p\bar{w} \leq (p-1)/2$  and then

<span id="page-11-1"></span><span id="page-11-0"></span>
$$
\Delta^{(p-1)/2 - \bar{w}p} \le 1. \tag{33}
$$

So for  $p \ge 3$  and  $\bar{w} = 1/4$ , we obtain from [\(32\)](#page-11-0), Lemma [4.1,](#page-8-2) [\(33\)](#page-11-1) and the Young's inequality

$$
H_{122} \leq 2^{(p-3)} p \mathfrak{D}_1 \Big( \Delta^{(p-1)/2} (\pi(\Delta))^{p-1} (\pi(\Delta)) + \Delta(\pi(\Delta)) \Big) \int_0^t \mathbb{E} |\bar{x}_{\Delta}(s)|^{p-1} ds
$$
  
\n
$$
\leq 2^{(p-3)} p \mathfrak{D}_1 \Big( \Delta^{(p-1)/2} (\pi(\Delta))^p + \Delta(\pi(\Delta)) \Big) \int_0^t \mathbb{E} |\bar{x}_{\Delta}(s)|^{p-1} ds
$$
  
\n
$$

where  $c_4 = 2^{(p-2)} \mathfrak{D}_1 T$  and  $c_5 = 2^{(p-2)} \mathfrak{D}_1 (p-1)$ . We now combine  $H_{121}$  and  $H_{122}$  to have

where  $c_9 = |\xi(0)|^p + c_1T + c_6$  and  $c_{10} = (c_1 + c_8) \vee (c_1 + c_7 + c_8)$ . As this holds for any  $t \in [0, T]$ , we then have

### 4.2 Finite time strong convergence

We can now establish finite time strong convergence theory for the truncated EM solutions to SDDE [\(3\)](#page-2-0). Before that, let first establish the following useful lemma.

**Lemma 4.3.** Suppose Assumptions [2.1,](#page-3-0) [2.2](#page-3-1) and [3.1](#page-6-4) hold and fix  $T > 0$ . Then for any  $\epsilon \in (0,1)$ , there exists a pair  $n = n(\epsilon) > 0$  and  $\bar{\Delta} = \bar{\Delta}(\epsilon) > 0$  such that

H_{32} \leq 2^{p-1} 3^{p-1} T^{\frac{p-2}{2}} c_p L_n^p (\mu(n))^p \mathbb{E} \int_{-\tau}^0 |\xi([s/\Delta]\Delta) - \xi(s)|^p ds \qquad (42)
$$
  
+  $2^{p-1} 3^{p-1} T^{\frac{p-2}{2}} c_p (L_n^p (\mu(n))^p + K_n^p \sigma^p) \mathbb{E} \int_0^{t_1 \wedge \varsigma_{\Delta,n}} |\bar{x}_{\Delta}(s^-) - x(s^-)|^p ds.$   
 $\leq 2^{p-1} 3^{p-1} T^{\frac{p-2}{2}} c_p L_n^p K_3^p (\mu(n))^p \Delta^{p\gamma} \tau + 2^{p-1} 3^{p-1} T^{\frac{p-2}{2}} c_p \left( L_n^p (\mu(n))^p + K_n^p \sigma^p \right)$   
 $\times \mathbb{E} \int_0^{t_1 \wedge \varsigma_{\Delta,n}} |\bar{x}_{\Delta}(s^-) - x(s^-)|^p ds.$  (43)

Moreover, we obtain from elementary inequality

$$

where

$$
H_{331} = 2^{p-1}3^{p-1} \mathbb{E} \Big( \sup_{0 \le t \le t_1} | \int_0^{t \wedge \varsigma_{\Delta, n}} [h(\bar{x}_{\Delta}(s^-)) - h(x(s^-))] d\widetilde{N}(s)|^p \Big)
$$

and

$$
H_{332} = 2^{p-1}3^{p-1}\lambda^p \mathbb{E}\Big(\sup_{0 \le t \le t_1} \big| \int_0^{t \wedge \varsigma_{\Delta,n}} [h(\bar{x}_{\Delta}(s^-)) - h(x(s^-))]ds \big|^p \Big).
$$

The Doob martingale inequality, martingale isometry and Lemma [3.3](#page-6-5) give us

$$
H_{331} \le 2^{p-1} 3^{p-1} \bar{c}_p \lambda^{\frac{p}{2}} \Big( \mathbb{E} \int_0^{t_1 \wedge \varsigma_{\Delta,n}} |h(\bar{x}_{\Delta}(s^-)) - h(x(s^-))|^2 d\tilde{N}(s) \Big)^{\frac{p}{2}}
$$
  

$$
\le 2^{p-1} 3^{p-1} \bar{c}_p \lambda^{\frac{p}{2}} T^{\frac{p-2}{2}} K_n^p \mathbb{E} \int_0^{t_1 \wedge \varsigma_{\Delta,n}} |\bar{x}_{\Delta}(s^-) - x(s^-)|^p ds,
$$

where  $\bar{c}_p$  is a positive constant. Moreover by the Hölder inequality and Lemma [3.3,](#page-6-5)

H_{332} \le 2^{p-1} 3^{p-1} \lambda^p T^{p-1} \mathbb{E} \int_0^{t_1 \wedge \varsigma_{\Delta, n}} |h(\bar{x}_{\Delta}(s^-)) - h(x(s^-))|^p ds
$$
  

$$
\le 2^{p-1} 3^{p-1} \lambda^p T^{p-1} K_n^p \mathbb{E} \int_0^{t_1 \wedge \varsigma_{\Delta, n}} |\bar{x}_{\Delta}(s^-) - x(s^-)|^p ds,
$$

where Lemma [3.3](#page-6-5) has been used. Substituting  ${\cal H}_{331}$  and  ${\cal H}_{332}$  into  ${\cal H}_{33}$  yields

$$
H_{33} \le 2^{p-1} 3^{p-1} K_n^p (\bar{c}_p \lambda^{\frac{p}{2}} T^{\frac{p-2}{2}} + \lambda^p T^{p-1}) \mathbb{E} \int_0^{t_1 \wedge \varsigma_{\Delta,n}} |\bar{x}_{\Delta}(s^-) - x(s^-)|^p ds. \tag{44}
$$

We now combine  $(41)$ ,  $(42)$  and  $(44)$  to have

$$
\mathbb{E}\Big(\sup_{0\leq t\leq t_1}|x_{\Delta}(t\wedge\varsigma_{\Delta,n})-x(t\wedge\varsigma_{\Delta,n})|^p\Big)\leq\zeta_1\Delta^{p\gamma}\tau+(\zeta_2+\zeta_3+\zeta_4)\mathbb{E}\int_0^{t_1\wedge\varsigma_{\Delta,n}}|\bar{x}_{\Delta}(s^-)-x(s^-)|^pds\\ \leq\zeta_1\Delta^{p\gamma}\tau+(\zeta_2+\zeta_3+\zeta_4)\mathbb{E}\int_0^{t_1\wedge\varsigma_{\Delta,n}}|\bar{x}_{\Delta}(s)-x(s)|^pds,
$$

where

$$
\zeta_1 = 2^{p-1} 3^{p-1} T^{\frac{p-2}{2}} c_p L_n^p K_3^p (\mu(n))^p
$$
  
\n
$$
\zeta_2 = 3^{p-1} T^{p-1} K_n^p
$$
  
\n
$$
\zeta_3 = 2^{p-1} 3^{p-1} T^{\frac{p-2}{2}} c_p (L_n^p (\mu(n))^p + K_n^p \sigma^p)
$$

and

$$
\zeta_4 = 2^{p-1} 3^{p-1} K_n^p (\bar{c}_p \lambda^{\frac{p}{2}} T^{\frac{p-2}{2}} + \lambda^p T^{p-1}).
$$

Meanwhile by elementary inequality and Lemma [4.1,](#page-8-2)

$$
\mathbb{E}\Big(\sup_{0\leq t\leq t_1}|x_{\Delta}(t\wedge\varsigma_{\Delta,n})-x(t\wedge\varsigma_{\Delta,n})|^p\Big)
$$
\n
$$
\leq \zeta_1\Delta^{p\gamma}\tau+2^{p-1}(\zeta_2+\zeta_3+\zeta_4)\int_0^T\mathbb{E}\Big(\mathbb{E}|\bar{x}_{\Delta}(s)-x_{\Delta}(s)|^p|\mathcal{F}_{k(s)}\Big)ds
$$
\n
$$
+2^{p-1}(\zeta_2+\zeta_3+\zeta_4)\int_0^{t_1}\mathbb{E}\Big(\sup_{0\leq t\leq s}|x_{\Delta}(t\wedge\varsigma_{\Delta,n})-x(t\wedge\varsigma_{\Delta,n})|^p\Big)ds
$$
\n
$$
\leq \zeta_1\Delta^{p\gamma}\tau+2^{p-1}(\zeta_2+\zeta_3+\zeta_4)\mathfrak{D}_1\Big(\Delta^{p/2}(\pi(\Delta))^p+\Delta\Big)\int_0^T\mathbb{E}|\bar{x}_{\Delta}(s)|^pds
$$
\n
$$
+2^{p-1}(\zeta_2+\zeta_3+\zeta_4)\int_0^{t_1}\mathbb{E}\Big(\sup_{0\leq t\leq s}|x_{\Delta}(t\wedge\varsigma_{\Delta,n})-x(t\wedge\varsigma_{\Delta,n})|^p\Big)ds
$$

So by Lemma [4.2,](#page-9-0) we have

$$
\mathbb{E}\Big(\sup_{0\leq t\leq t_{1}}|x_{\Delta}(t\wedge\varsigma_{\Delta,n})-x(t\wedge\varsigma_{\Delta,n})|^{p}\Big)
$$
\n
$$
\leq \zeta_{1}\tau\Delta^{p\gamma}+2^{p-1}\rho_{3}\mathfrak{D}_{1}T(\zeta_{2}+\zeta_{3}+\zeta_{4})\Big([\Delta^{p/4}(\pi(\Delta))^{p}]\Delta^{p/4}+\Delta^{p(1/p)}\Big)
$$
\n
$$
+2^{p-1}(\zeta_{2}+\zeta_{3}+\zeta_{4})\int_{0}^{t_{1}}\mathbb{E}\Big(\sup_{0\leq t\leq s}|x_{\Delta}(t\wedge\varsigma_{\Delta,n})-x(t\wedge\varsigma_{\Delta,n})|^{p}\Big)ds
$$
\n
$$
\leq \left(\zeta_{1}\tau+2^{p-1}\rho_{3}\mathfrak{D}_{1}T(\zeta_{2}+\zeta_{3}+\zeta_{4})(\Delta^{p/4}(\pi(\Delta))^{p}+1)\right)\Delta^{p(1/4\wedge\gamma\wedge1/p)} + 2^{p-1}(\zeta_{2}+\zeta_{3}+\zeta_{4})\int_{0}^{t_{1}}\mathbb{E}\Big(\sup_{0\leq t\leq s}|x_{\Delta}(t\wedge\varsigma_{\Delta,n})-x(t\wedge\varsigma_{\Delta,n})|^{p}\Big)ds.
$$

Noting from [\(21\)](#page-6-8) that  $[\Delta^{1/4}(\pi(\Delta))]^p \leq 1$ , we have

$$
\mathbb{E}\Big(\sup_{0\leq t\leq t_1}|x_{\Delta}(t\wedge\varsigma_{\Delta,n})-x(t\wedge\varsigma_{\Delta,n})|^p\Big)\leq \Big(\zeta_1\tau+2^p\rho_3\mathfrak{D}_1T(\zeta_2+\zeta_3+\zeta_4)\Big)\Delta^{p(1/4\wedge\gamma\wedge1/p)}+2^{p-1}(\zeta_2+\zeta_3+\zeta_4)\int_0^{t_1}\mathbb{E}\Big(\sup_{0\leq t\leq s}|x_{\Delta}(t\wedge\varsigma_{\Delta,n})-x(t\wedge\varsigma_{\Delta,n})|^p\Big)ds.

By the Gronwall inequality, we obtain

\mathbb{E}\Big(\sup_{0\leq t\leq T}|x_\Delta(t\wedge\varsigma_{\Delta,n})-x(t\wedge\varsigma_{\Delta,n})|^p\Big)\leq K\Delta^{p(1/4\wedge\gamma\wedge 1/p)},

where  $\mathcal{K} = \varrho_1(p) e^{\varrho_2(p)}$  with

Moreover, the required inequality [\(40\)](#page-15-2) is deduced by setting  $\Delta \rightarrow 0.$ 

The following gives the strong convergence theory of the truncated EM scheme.

<span id="page-19-7"></span>**Theorem 4.5.** Let Assumptions [2.1,](#page-3-0) [2.2,](#page-3-1) [3.1](#page-6-4) and [3.2](#page-6-7) hold. Then for any  $p \ge 2$ , we have

<span id="page-19-5"></span>
$$
\lim_{\Delta \to 0} \mathbb{E} \Big( \sup_{0 \le t \le T} |x_{\Delta}(t) - x(t)|^p \Big) = 0 \tag{45}
$$

and consequently

<span id="page-19-6"></span>
$$
\lim_{\Delta \to 0} \mathbb{E} \Big( \sup_{0 \le t \le T} |\bar{x}_{\Delta}(t) - x(t)|^p \Big) = 0. \tag{46}
$$

*Proof.* We only need to prove the theorem for  $p \ge 3$  as for  $p \in [2, 3)$  it follows from the case of  $p = 3$ and the Hölder inequality. Let  $\vartheta_{\Delta,n}$ ,  $\tau_n$  and  $\varsigma_{\Delta,n}$  be the same as before and set

$$
e_{\Delta}(t) = x_{\Delta}(t) - x(t).
$$

For any arbitrarily  $\delta > 0$ , the Young inequality

$$
\mathfrak{a}\mathfrak{b}\leq \frac{\delta}{2}\mathfrak{a}^2+\frac{1}{2\delta}\mathfrak{b}^2\quad\forall\mathfrak{a},\mathfrak{b}>0,
$$

yields

$$
\mathbb{E}\Big(\sup_{0\leq t\leq T}|e_{\Delta}(t)|^{p}\Big) = \mathbb{E}\Big(\sup_{0\leq t\leq T}|e_{\Delta}(t)|^{p}1_{\{\tau_{n}>T\text{ and }\vartheta_{\Delta,n}>T\}}\Big) + \mathbb{E}\Big(\sup_{0\leq t\leq T}|e_{\Delta}(t)|^{p}1_{\{\tau_{n}\leq T\text{ or }\vartheta_{\Delta,n}\leq T\}}\Big) \leq \mathbb{E}\Big(\sup_{0\leq t\leq T}|e_{\Delta}(t)|^{p}1_{\{\varsigma_{\Delta,n}>T\}}\Big) + \frac{\delta}{2}\mathbb{E}\Big(\sup_{0\leq t\leq T}|e_{\Delta}(t)|^{2p}\Big) \quad + \frac{1}{2\delta}\mathbb{P}(\tau_{n}\leq T\text{ or }\vartheta_{\Delta,n}\leq T).
$$
\n(47)

So for  $p \geq 3$ , Lemmas [2.4](#page-4-2) and [4.2](#page-9-0) give us

$$
\mathbb{E}\left(\sup_{0\leq t\leq T}|e_{\Delta}(t)|^{2p}\right) \leq 2^{2p}\mathbb{E}\left(\sup_{0\leq t\leq T}|x(t)|^{2p}\vee \sup_{0\leq t\leq T}|x_{\Delta}(t)|^{2p}\right)
$$
  

$$
\leq 2^{2p}(\rho_1 \vee \rho_3)^2.
$$
 (48)

Also by Theorem [2.3](#page-3-3) and Lemma [4.4,](#page-15-3)

<span id="page-19-1"></span><span id="page-19-0"></span>
$$
\mathbb{P}(\varsigma_{\Delta,n} \leq T) \leq \mathbb{P}(\tau_n \leq T) + \mathbb{P}(\vartheta_{\Delta,n} \leq T). \tag{49}
$$

Moreover, by Lemma [4.4](#page-15-3)

<span id="page-19-2"></span>
$$
\mathbb{E}\Big(\sup_{0\leq t\leq T}|e_{\Delta}(t)|^{p}1_{\{\varsigma_{\Delta,n}>T\}}\Big)\leq\mathcal{K}\Delta^{p(1/4\wedge\gamma\wedge 1/p)}.\tag{50}
$$

Therefore, we substitute  $(48)$ ,  $(49)$  and  $(50)$  into  $(47)$  to have

$$
\mathbb{E}\Big(\sup_{0\leq t\leq T}|e_{\Delta}(t)|^{p}\Big)\leq \frac{2^{2p}(\rho_{1}\vee\rho_{3})^{2}\delta}{2}+\mathcal{K}\Delta^{p(1/4\wedge\gamma\wedge1/p)}+\frac{1}{2\delta}\mathbb{P}(\tau_{n}\leq T)+\frac{1}{2\delta}\mathbb{P}(\vartheta_{\Delta,n}\leq T).
$$

Given  $\epsilon \in (0,1)$ , we can select  $\delta$  so that

<span id="page-19-4"></span>
$$
\frac{2^{2p}(\rho_1 \vee \rho_3)^2 \delta}{2} \le \frac{\epsilon}{4}.\tag{51}
$$

Similarly, for any given  $\epsilon \in (0,1)$ , there exists  $n_o$  so that for  $n \geq n_o$ , we may select  $\delta$  to have

<span id="page-20-1"></span><span id="page-20-0"></span>
$$
\frac{1}{2\delta} \mathbb{P}(\tau_n \le T) \le \frac{\epsilon}{4} \tag{52}
$$

and select  $n(\epsilon) \leq n_o$  such that for  $\Delta \in (0, \overline{\Delta}]$ 

$$
\frac{1}{2\delta} \mathbb{P}(\vartheta_{\Delta,n} \le T) \le \frac{\epsilon}{4}.\tag{53}
$$

Finally, we may select  $\Delta \in (0, \bar{\Delta}]$  sufficiently small for  $\epsilon \in (0, 1)$  such that

<span id="page-20-2"></span>
$$
\mathcal{K}\Delta^{p(1/4\wedge\gamma\wedge 1/p)} \leq \frac{\epsilon}{4}.\tag{54}
$$

Combining  $(51)$ ,  $(52)$ ,  $(53)$  and  $(54)$ , we establish

$$
\mathbb{E}\Big(\sup_{0\leq t\leq T}|x_{\Delta}(t)-x(t)|^p\Big)\leq\epsilon.
$$

Therefore, we obtain [\(45\)](#page-19-5) and clearly, by Lemma [4.1,](#page-8-2) also get [\(46\)](#page-19-6) by letting  $\Delta \to 0$ .  $\Box$ 

## 5 Financial applications

In this section, we apply Theorem [4.5](#page-19-7) to justify numerical schemes within Monte Carlo framework that value the expected payoffs of a bond and a barrier option.

### 5.1 A bond

<span id="page-20-3"></span>Suppose the short-term interest rate is explained by [\(3\)](#page-2-0). Then a bond price  $P_{\mathbf{B}}$  at maturity time T is of the form

$$
P_{\mathbf{B}}(T) = \mathbb{E}\left[\exp\left(-\int_0^T x(t)dt\right)\right].\tag{55}
$$

The approximate value of [\(55\)](#page-20-3) using [\(25\)](#page-7-3) is computed by

$$
P_{\mathbf{B}\Delta}(T) = \mathbb{E}\Big[\exp\Big(-\int_0^T \bar{x}_{\Delta}(t)dt\Big)\Big].
$$

Hence by Theorem [4.5](#page-19-7)

<span id="page-20-4"></span>
$$
\lim_{\Delta \to 0} |P_{\mathbf{B}\Delta}(T) - P_{\mathbf{B}}(T)| = 0.
$$

### 5.2 A barrier option

Consider the payoff of a path-dependent barrier option at an expiry date  $T$  given by

$$
P_O(T) = \mathbb{E}\Big[(x(T) - \mathfrak{E})^+ 1_{\sup_{0 \le t \le T}} x(t) < \mathfrak{B})\Big],\tag{56}
$$

where the barrier,  $\mathfrak{B}$ , and exercise price,  $\mathfrak{E}$ , are constants. Then the approximate value of [\(56\)](#page-20-4) using [\(25\)](#page-7-3) is computed by

$$
P_{O\Delta}(T) = \mathbb{E}\Big[(\bar{x}_{\Delta}(T) - \mathfrak{E})^{+}1_{\sup_{0 \leq t \leq T}}\bar{x}_{\Delta}(t) < \mathfrak{B})\Big].
$$

Similarly, by Theorem [4.5](#page-19-7)

$$
\lim_{\Delta \to 0} |P_{O\Delta}(T) - P_O(T)| = 0.
$$

See, for instance, [\[22\]](#page-26-11) for detailed accounts.

## 6 Numerical examples

In this section, we analyse the strong convergence result established in Theorem [4.5](#page-19-7) by comparing the truncated Euler-Maruyama (TEM) scheme with backward Euler-Maruyama (BEM) scheme for SDDE [\(4\)](#page-2-2) without  $\alpha_{-1}x(t)^{-1}$  term. It is already noted in [\[24\]](#page-26-8) that the BEM scheme is not known to cope with  $\alpha_{-1}x(t)^{-1}$  term. Consider the following form of SDDE [\(3\)](#page-2-0)

$$
dx(t) = (\alpha_{-1}x(t^{-})^{-1} - \alpha_0 + \alpha_1x(t^{-}) - \alpha_2x(t^{-})^2)dt + \varphi(x((t-1)^{-}))x(t^{-})^{5/4}dB(t) + \alpha_3x(t^{-})dN(t),
$$
 (57)

with initial data  $\xi(t) = 0.2$ . Here  $\varphi(\cdot)$  is a sigmoid-type function defined by

<span id="page-21-2"></span><span id="page-21-0"></span>
$$
\varphi(y) = \begin{cases} \frac{1}{2} \frac{(1 + (e^y - e^{-y}))}{(e^y + e^{-y})}, & \text{if } y \ge 0\\ \frac{1}{4}, & \text{Otherwise}, \end{cases}
$$
(58)

Obviously, equation [\(58\)](#page-21-0) meets all the conditions imposed on  $\varphi(\cdot)$  (see [\[24\]](#page-26-8)). The coefficient terms  $f(x) = \alpha_{-1}x^{-1} - \alpha_0 + \alpha_1x - \alpha_2x^2$  and  $g(x) = x^{5/4}$  are locally Lipschitz continuous and hence fulfil Assumption [2.4.](#page-4-2) Moreover, we easily observe

$$
\sup_{1/u \le x \le u} (|f(x)| \vee g(x)) \le K_9 u^2, \quad u \ge 1,
$$

where  $K_9 = \alpha_{-1} + \alpha_0 + \alpha_1 + \alpha_2 + \alpha_3$ . We can now use  $\mu = K_9 u^2$  with inverse  $\mu^{-1}(u) = (u/K_9)^{1/2}$ .

#### 6.1 Numerical results

<span id="page-21-1"></span>By choosing  $\pi(\Delta) = \Delta^{-2/3}$ , step size  $10^{-3}$  and the following coefficient values in Table [1,](#page-21-1) we obtain Monte Carlo simulated sample path of  $x(t)$  to SDDE [\(57\)](#page-21-2) in Figure [1](#page-22-0) using the TEM scheme.

$\alpha_{-1} \alpha_0$		$\alpha_1$	$\alpha_2 \alpha_3$

Table 1: Coefficient values including  $\alpha_{-1}$ 

<span id="page-21-3"></span>By similarly choosing  $\pi(\Delta) = \Delta^{-2/3}$ , step size 10<sup>-3</sup> and the coefficient values in Table [2](#page-21-3) below, we also obtain Monte Carlo simulated sample paths of  $x(t)$  to SDDE [\(57\)](#page-21-2) in Figure [2](#page-23-0) using the TEM and BEM schemes. We can clearly see the TEM scheme converges strongly to BEM scheme.

Finally, the plot of strong errors between these two numerical schemes is displayed in Figure [3](#page-24-0) with reference line at 0. Do note this simulated result of strong errors is not yet established theoretically.
