NONCOMMUTATIVE CONICS IN CALABI-YAU QUANTUM PROJECTIVE PLANES

ABSTRACT. In noncommutative algebraic geometry, noncommutative quadric hypersurfaces are major objects of study. In this paper, we focus on studying noncommutative conics $\operatorname{Proj}_{\operatorname{nc}} A$ embedded into Calabi-Yau quantum projective planes. In particular, we give complete classifications of homogeneous coordinate algebras A of noncommutative conics up to isomorphism of graded algebras, and of noncommutive conics $\operatorname{Proj}_{\operatorname{nc}} A$ up to isomorphism of noncommutative schemes.

1. INTRODUCTION

Throughout this paper, let k be an algebraically closed field of characteristic 0. By Sylvester's theorem, it is elementary to classify (commutative) quadric hypersurfaces in \mathbb{P}^{d-1} , namely, they are isomorphic to

$$\operatorname{Proj} k[x_1, \dots, x_d] / (x_1^2 + \dots + x_j^2) \subset \mathbb{P}^{d-1}$$

for some j = 1, ..., d. The ultimate goal of our project is to classify noncommutative quadric hypersurfaces in quantum \mathbb{P}^{d-1} 's defined below.

Let A be a right noetherian connected graded algebra. We denote by grmod A the category of finitely generated graded right A-modules. A morphism in grmod A is a right A-module homomorphism preserving degrees. For $M, N \in \operatorname{grmod} A$, we write $\operatorname{Ext}_{A}^{i}(M, N) := \operatorname{Ext}_{\operatorname{grmod} A}^{i}(M, N)$ for the extension groups in grmod A.

Definition 1.1. A noetherian connected graded algebra S generated in degree 1 is called a *d*-dimensional quantum polynomial algebra if

(1) gldim S = d, (2) $\operatorname{Ext}_{S}^{i}(k, S(-j)) \cong \begin{cases} k & \text{if } i = j = d, \\ 0 & \text{otherwise,} \end{cases}$ and

(3) $H_S(t) := \sum_{i=0}^{\infty} (\dim_k S_i) t^i = 1/(1-t)^d.$

A *d*-dimensional quantum polynomial algebra S is a noncommutative analogue of the commutative polynomial algebra $k[x_1, \ldots, x_d]$, so the *noncommutative projective scheme* $\operatorname{Proj}_{\operatorname{nc}} S$ associated to S in the sense of [2] is regarded as a quantum \mathbb{P}^{d-1} , so it is reasonable to define a noncommutative quadric hypersurface in a quantum \mathbb{P}^{d-1} as follows:

Definition 1.2. We say that A = S/(f) is the homogeneous coordinate algebra of a noncommutative quadric hypersurface if S is a d-dimensional quantum polynomial algebra and $f \in S_2$ is a regular normal element.

We often say that A = S/(f) is a noncommutative quadric hypersurface by abuse of terminology. It is now reasonable to say that A = S/(f) is a noncommutative conic if S is a 3-dimensional quantum polynomial algebra. For every 3-dimensional quantum polynomial algebra S, there exists a 3-dimensional Calabi-Yau quantum polynomial algebra S' such that grmod $S \cong \operatorname{grmod} S'$ by [10, Theorem 4.4] so that $\operatorname{Proj}_{\operatorname{nc}} S \cong \operatorname{Proj}_{\operatorname{nc}} S'$, so, in this paper, we will restrict the notion of noncommutative conic as follows:

Definition 1.3. We say that A = S/(f) is (the homogeneous coordinate algebra of) a noncommutative conic (in a Calabi-Yau quantum \mathbb{P}^2) if S is a 3-dimensional Calabi-Yau quantum polynomial algebra, and $0 \neq f \in Z(S)_2$ is a central element.

Using the above definition, we can describe all the possible homogeneous coordinate algebras of noncommutative conics as follows:

Theorem 1.4 (Corollary 3.8). Every homogeneous coordinate algebra A of a noncommutative conic is isomorphic to either

(1) (commutative case)

or

$$k[x,y,z]/(x^2), k[x,y,z]/(x^2+y^2), k[x,y,z]/(x^2+y^2+z^2),$$

(2) (noncommutative case)

$$S^{(\alpha,\beta,\gamma)}/(ax^2+by^2+cz^2)$$

for some $(a, b, c) \in \mathbb{P}^2$ where

$$S^{(\alpha,\beta,\gamma)} := k\langle x, y, z \rangle / (yz + zy + \alpha x^2, zx + xz + \beta y^2, xy + yx + \gamma z^2)$$

for some $\alpha, \beta, \gamma \in k$ such that $\alpha\beta\gamma = 0$ or $\alpha = \beta = \gamma$.

The above classification of A makes it possible to classify noncommutative conics $\operatorname{Proj}_{\operatorname{nc}} A$ up to isomorphism of noncommutative schemes by the methods explained below.

If A = S/(f) is a noncommutative quadric hypersurface, then there exists a unique central element $f^! \in Z(A^!)_2$ such that $S^! = A^!/(f^!)$ where $A^!$ is the quadratic dual of A. The finite dimensional algebra $C(A) := A^![(f^!)^{-1}]_0$ plays an important role to study A by the following theorem:

Theorem 1.5 ([20, Proposition 5.2 (1)]). If A is a noncommutative quadric hypersurface, then the stable category $\underline{CM}^{\mathbb{Z}}(A)$ of the category of maximal Cohen-Macaulay graded right A-modules and the bounded derived category $\mathscr{D}^{b}(\text{mod } C(A))$ of the category of finitely generated right C(A)-modules are equivalent.

Let A and A' be noncommutative quadric hypersurfaces. Despite the notation, it is not trivial to see if $A \cong A'$ implies $C(A) \cong C(A')$ from the definition. By the above theorem, if $\operatorname{grmod} A \cong \operatorname{grmod} A'$, then C(A) and C(A') are derived equivalent. In this paper, we show that $\operatorname{grmod} A \cong \operatorname{grmod} A'$ implies $C(A) \cong C(A')$ (Lemma 5.3), so it is reasonable to classify C(A), which we will do in the case d = 3.

On the other hand, the point variety is an important invariant in noncommutative algebraic geometry. In this paper, we show that every noncommutative conic A has a point variety $E_A \subset \mathbb{P}^2$ in the sense of this paper (Proposition 4.5). The point variety E_A plays an essential role in completing the classification of C(A). The following is a summary of the classifications of C(A) and E_A (Theorem 4.14):

Let A and A' be noncommutative conics. We show that $\underline{CM}^{\mathbb{Z}}(A) \cong \underline{CM}^{\mathbb{Z}}(A')$ if and only if $C(A) \cong C(A')$ (Theorem 5.7), and that $\operatorname{Proj}_{\operatorname{nc}} A \cong \operatorname{Proj}_{\operatorname{nc}} A'$ implies $C(A) \cong C(A')$ (Theorem 5.10). Together with the above classifications of A and C(A), we can conclude that there are exactly 9 isomorphism classes of homogeneous coordinate algebras A of noncommutative conics, and that there are exactly 9 isomorphism classes of noncommutative conics $\operatorname{Proj}_{\operatorname{nc}} A$ (Theorem 5.11).

2. Preliminaries

Throughout this paper, we fix an algebraically closed field k of characteristic 0. All algebras and schemes in this paper are defined over k.

In this paper, a variety means a reduced scheme (which can be reducible). For a scheme X, we denote by \overline{X} when we view X as a variety (a scheme X with the reduced induced structure). We denote by #(X) the number of

points of \overline{X} (without counting multiplicity). For $\sigma \in \operatorname{Aut} X$, we denote by $\overline{\sigma} \in \operatorname{Aut} \overline{X}$ the automorphism of a variety \overline{X} induced by $\sigma \in \operatorname{Aut} X$. For a variety $X \subset \mathbb{P}^{n-1}$ and $\sigma \in \operatorname{Aut} X$, we denote by $\Delta_{X,\sigma} := \{(p, \sigma(p)) \in \mathbb{P}^{n-1} \times \mathbb{P}^{n-1} \mid p \in X\}$ the graph of X by σ .

For $f = \sum_{1 \leq i,j \leq n} a_{ij} x_i x_j \in k \langle x_1, \ldots, x_n \rangle_2$, we define $\tilde{f} := \sum_{1 \leq i,j \leq n} a_{ij} x_{ij} \in k[x_{11}, x_{12}, \ldots, x_{nn}]_1$. We denote by $\Sigma : \mathbb{P}^{n-1} \times \mathbb{P}^{n-1} \to \mathbb{P}^{n^2-1}$ the Segre embedding. For a finite dimensional vector space V, we write $U := V \otimes V$, so that if $(p,q) \in \mathbb{P}(V^*) \times \mathbb{P}(V^*)$, then $\Sigma(p,q) \in \mathbb{P}(U^*)$. (If $V = \sum_{i=1}^n k x_i$, then $U = \sum_{i,j=1}^n k x_{ij}$ where $x_{ij} := x_i \otimes x_j$.) Moreover, for a subspace $W \subset V^{\otimes 2i}$, we write \widetilde{W} when we view W as a subspace of $U^{\otimes i}$. By this notation, $\mathcal{V}(W) \subset \mathbb{P}(V^*)^{\times 2i}$ while $\mathcal{V}(\widetilde{W}) \subset \mathbb{P}(U^*)^{\times i}$. We often use the following lemma.

Lemma 2.1. Let V be a finite dimensional vector space and $U = V \otimes V$. For a subspace $W \subset V^{\otimes 2i}$, $\mathcal{V}(\widetilde{W}) \cap \operatorname{Im}(\Sigma^{\times i}) = \Sigma^{\times i}(\mathcal{V}(W))$.

Definition 2.2. Let $S = k \langle x_1, \ldots, x_n \rangle / (f_1, \ldots, f_m)$ be a quadratic algebra. We define

- $\Gamma = \Gamma_S := \Sigma^{-1}(\operatorname{Proj} k[x_{11}, x_{12}, \dots, x_{nn}]/(\tilde{f}_1, \dots, \tilde{f}_m)) \subset \mathbb{P}^{n-1} \times \mathbb{P}^{n-1}.$
- (1) We say that S satisfies $(G1)^+$ if there exists a scheme $E \subset \mathbb{P}^{n-1}$ such that both projections $p_1, p_2 : \mathbb{P}^{n-1} \times \mathbb{P}^{n-1} \to \mathbb{P}^{n-1}$ restrict to isomorphisms $p_1|_{\Gamma}, p_2|_{\Gamma} : \Gamma \to E$. In this case, we call E the point scheme of S, and write $\mathcal{P}^+(S) = (E, \sigma)$ where $\sigma := p_2|_{\Gamma}(p_1|_{\Gamma})^{-1} \in$ Aut E.
- (2) We say that S satisfies (G1) if there exists a variety E ⊂ Pⁿ⁻¹ and an automorphism of a variety σ ∈ Aut E such that Γ = Δ_{E,σ}. In this case, we call E the point variety of S, and write P(S) = (E, σ).
 (2) We say that G = time (G2) if
- (3) We say that S satisfies (G2) if

$$S = k \langle x_1, \dots, x_n \rangle / (f \in k \langle x_1, \dots, x_n \rangle_2 \mid f \mid_{\overline{\Gamma}} = 0).$$

Remark 2.3. Let $S = k \langle x_1, \ldots, x_n \rangle / (f_1, \ldots, f_m)$ be a quadratic algebra. Since $\overline{\Gamma} = \{(p,q) \in \mathbb{P}^{n-1} \times \mathbb{P}^{n-1} \mid f_1(p,q) = \cdots = f_m(p,q) = 0\}$, if S satisfies $(G1)^+$ with $\mathcal{P}^+(S) = (E,\sigma)$, then S satisfies (G1) with $\mathcal{P}(S) = (\overline{E},\overline{\sigma})$. It follows that $\mathcal{P}^+(S) = \mathcal{P}(S)$ if and only if E is a reduced scheme (a variety).

Lemma 2.4 ([14, Lemma 2.5(1)]). Let S, S' be quadratic algebras satisfying (G1) with $\mathcal{P}(S) = (E, \sigma), \mathcal{P}(S') = (E', \sigma')$. If $S \cong S'$ as graded algebras, then $E \cong E'$ as varieties and $|\sigma| = |\sigma'|$.

Lemma 2.5. If A is a commutative quadratic algebra, then A satisfies $(G1)^+$ with $\mathcal{P}^+(A) = (\operatorname{Proj} A, \operatorname{id})$. In particular, A satisfies (G1) with $\mathcal{P}(A) = (\overline{\operatorname{Proj} A}, \operatorname{id})$.

Proof. First, let $S = k[x_1, \ldots, x_n]$ so that $\operatorname{Proj} S = \mathbb{P}^{n-1}$ and $\operatorname{Im} \Sigma = \operatorname{Proj}(S \circ S)$ where $S \circ S$ is the Segre product. Since $(S \circ S)/(x_{ij}-x_{ji})_{1 \le i,j \le n} \cong$

 $S^{(2)}$, we have a natural isomorphism

$$\phi: \Gamma_S \to \operatorname{Proj} k[x_{11}, \dots, x_{nn}] / (x_{ij} - x_{ji})_{1 \le i,j \le n} \cap \operatorname{Im} \Sigma$$
$$\to \operatorname{Proj}(S \circ S) / (x_{ij} - x_{ji})_{1 \le i,j \le n}$$
$$\to \operatorname{Proj} S^{(2)} \to \operatorname{Proj} S = \mathbb{P}^{n-1}$$

by Lemma 2.1. If $p_1, p_2 : \mathbb{P}^{n-1} \times \mathbb{P}^{n-1} \to \mathbb{P}^{n-1}$ are projections, then we can see that $p_1|_{\Gamma_S} = p_2|_{\Gamma_S} = \phi$, so S satisfies (G1)⁺ with $\mathcal{P}^+(S) = (\mathbb{P}^{n-1}, \mathrm{id})$.

If $A = S/(f_1, \ldots, f_m)$ is a commutative quadratic algebra, then we can see that the isomorphism $(S \circ S)/(x_{ij} - x_{ji})_{1 \le i,j \le n} \to S^{(2)}$; $\tilde{f} \mapsto \bar{f}$ induces an isomorphism

$$(S \circ S)/(x_{ij} - x_{ji}, \tilde{f}_1, \dots, \tilde{f}_m) \to S^{(2)}/(\bar{f}_1, \dots, \bar{f}_m) \cong A^{(2)},$$

so ϕ restricts to an isomorphism

$$\begin{split} \phi|_{\Gamma_A} : \Gamma_A \to \operatorname{Proj} k[x_{11}, \dots, x_{nn}]/(x_{ij} - x_{ji}, f_1, \dots, f_m) \cap \operatorname{Im} \Sigma \\ \to \operatorname{Proj}(S \circ S)/(x_{ij} - x_{ji}, \tilde{f}_1, \dots, \tilde{f}_m) \\ \to \operatorname{Proj} A^{(2)} \to \operatorname{Proj} A \subset \mathbb{P}^{n-1} \end{split}$$

by Lemma 2.1. Since $p_1|_{\Gamma_A} = p_2|_{\Gamma_A} = \phi|_{\Gamma_A}$, A satisfies (G1)⁺ with $\mathcal{P}^+(A) = (\operatorname{Proj} A, \operatorname{id})$.

Theorem 2.6 ([1]). Every 3-dimensional quantum polynomial algebra S satisfies $(G1)^+$. The point scheme of a 3-dimensional quantum polynomial algebra is either \mathbb{P}^2 or a cubic divisor in \mathbb{P}^2 .

If S is a 3-dimensional quantum polynomial algebra with $\mathcal{P}^+(S) = (E, \sigma)$, then S can be recovered by the pair (E, σ) by [1], so we write $S = \mathcal{A}^+(E, \sigma)$. We define a type of a 3-dimensional quantum polynomial algebra $S = \mathcal{A}^+(E, \sigma)$ in terms of the point scheme $E \subset \mathbb{P}^2$.

Type P: E is \mathbb{P}^2 .

Type S: E is a triangle.

Type S': E is a union of a line and a conic meeting at two points.

Type T: E is a union of three lines meeting at one point.

Type T': E is a union of a line and a conic meeting at one point.

Type NC: E is a nodal cubic curve.

Type CC: E is a cuspidal cubic curve.

Type TL: E is a triple line.

Type WL: E is a union of a double line and a line.

Type EC: E is an elliptic curve.

Remark 2.7. Let $S = \mathcal{A}^+(E, \sigma)$ be a 3-dimensional quantum polynomial algebra. By Remark 2.3, $\mathcal{P}(S) = (E, \sigma)$ if and only if E is reduced, that is, S is not of Type TL nor Type WL. In this case, S satisfies (G2).

Lemma 2.8. Let $S = \mathcal{A}^+(E, \sigma) = k\langle x, y, z \rangle / (f_1, f_2, f_3)$ be a 3-dimensional Calabi-Yau quantum polynomial algebra. Then Table 1 below gives a list of defining relations f_1, f_2, f_3 up to isomorphism of the algebra S and the

corresponding \overline{E} and $\overline{\sigma}^i$. In Table 1 below, $\theta = \begin{pmatrix} 0 & 1 & 0 \\ 0 & 0 & 1 \\ 1 & 0 & 0 \end{pmatrix}$ and $\epsilon \in k$ is a

primitive 3rd root of unity. Note that Type S is divided into Type S_1 and Type S_3 in terms of the form of σ .

Proof. If S is of Type T, TL, WL, this follows by direct calculations (see Example 2.9 below). For the rest, f_1, f_2, f_3 and E are given in [11, Lemma 3.3], and σ^i are given in the proof of [11, Theorem 3.4].

Example 2.9. We give some calculations to show Table 1 for Type T. Let $S = k\langle x, y, z \rangle / (f_1, f_2, f_3)$ be a 3-dimensional Calabi-Yau quantum polynomial algebra of Type T where

$$f_1 = yz - \alpha zy + x^2, \ f_2 = zx - \alpha xz + y^2, \ f_3 = xy - \alpha yx, \ (\alpha^3 = 1)$$

as in Table 1. Let $E = \mathcal{V}(x^3 + y^3) = \mathcal{V}(x + y) \cup \mathcal{V}(\epsilon x + y) \cup \mathcal{V}(\epsilon^2 x + y) \subset \mathbb{P}^2$ and define a map $\sigma : E \to E$ by

$$\sigma(a,b,c) = \begin{cases} (a,\alpha b, -\frac{a^2}{b} + \alpha^2 c) & \text{if } (a,b,c) \neq (0,0,1) \\ (0,0,1) & \text{if } (a,b,c) = (0,0,1). \end{cases}$$

Since $\alpha^3 = 1$ and $a^3 + b^3 = 0$,

$$f_1(p, \sigma(p)) = f_1((a, b, c), (a, \alpha b, -\frac{a^2}{b} + \alpha^2 c))$$

= $b(-\frac{a^2}{b} + \alpha^2 c) - \alpha c(\alpha b) + a^2 = 0$
 $f_2(p, \sigma(p)) = f_2((a, b, c), (a, \alpha b, -\frac{a^2}{b} + \alpha^2 c))$
= $ca - \alpha a(-\frac{a^2}{b} + \alpha^2 c) + b(\alpha b) = 0$
 $f_3(p, \sigma(p)) = f_3((a, b, c), (a, \alpha b, -\frac{a^2}{b} + \alpha^2 c))$
= $a(\alpha b) - \alpha ba = 0$

so $\mathcal{P}(S) = (E, \sigma)$. We will show that $\sigma^i(a, b, c) = (a, \alpha^i b, -i\alpha^{2i-2} \frac{a^2}{b} + \alpha^{2i} c)$ by induction. Since

$$\begin{split} \sigma^{i+1}(a,b,c) &= \sigma(a,\alpha^{i}b,-i\alpha^{2i-2}\frac{a^{2}}{b} + \alpha^{2i}c) \\ &= \sigma(a,\alpha(\alpha^{i}b),-\frac{a^{2}}{\alpha^{i}b} + \alpha^{2}(-i\alpha^{2i-2}\frac{a^{2}}{b} + \alpha^{2i}c)) \\ &= (a,\alpha^{i+1}b,-(i+1)\alpha^{2i}\frac{a^{2}}{b} + \alpha^{2i+2}c), \end{split}$$

the result follows. By plugging $b = -a, -\epsilon a, -\epsilon^2 a$, we obtain σ^i in Table 1.

3. Classification of A

In this section, we classify homogeneous coordinate algebras A = S/(f) of noncommutative conics up to isomorphism of graded algebras where S are 3-dimensional Calabi-Yau quantum polynomial algebras and $0 \neq f \in Z(S)_2$. It is not easy to check which S has a property that $Z(S)_2 \neq 0$ by algebraic calculations especially if S does not have a PBW basis (see [9]), so we use a geometric method in this paper.

Lemma 3.1. Let S be a quadratic algebra and $0 \neq u \in Z(S)_1$. For a variety E and $\sigma \in \operatorname{Aut} E$, if $\Delta_{E,\sigma} \subset \overline{\Gamma}_S$, then $\sigma|_{E \setminus \mathcal{V}(u)} = \operatorname{id}$.

Proof. We may assume that $S = k \langle x_1, \ldots, x_n \rangle / I$ and $u = x_1 \in Z(S)_1$. Since $x_1 x_i = x_i x_1$ in S, $x_1 x_i - x_i x_1 \in I_2$ for every $i = 1, \ldots, n$. For $p = (a_1, \ldots, a_n) \in E \setminus \mathcal{V}(x_1)$ and $\sigma(p) = (b_1, \ldots, b_n) \in E$, we have $a_1 b_i = a_i b_1$ for every $i = 1, \ldots, n$. Since $a_1 \neq 0, \sigma(p) = ((b_1/a_1)a_1, (b_1/a_1)a_2, \ldots, (b_1/a_1)a_n)$, so $b_1 \neq 0$ and $\sigma(p) = p \in E \setminus \mathcal{V}(x_1)$.

Let X, Y be irreducible varieties and $\sigma \in \operatorname{Aut} X$. If $X \not\subset Y$, then $X \setminus Y$ is a non-empty open subset in X, so $\sigma|_{X \setminus Y} = \operatorname{id} \operatorname{implies} \sigma = \operatorname{id} ([6, \operatorname{Lemma} 4.1, \operatorname{Chapter} 1]).$

It is now easy to see which S has a property that $Z(S)_1 \neq 0$.

Lemma 3.2. Let $S = \mathcal{A}^+(E, \sigma)$ be a 3-dimensional Calabi-Yau quantum polynomial algebra. Then $Z(S)_1 \neq 0$ if and only if $\overline{\sigma} = \text{id}$ if and only if S is isomorphic to either

- (1) S = k[x, y, z], and, in this case, $Z(S)_1 = S_1$ (Type P), or
- (2) $S = k\langle x, y, z \rangle / (yz zy + x^2, zx xz, xy yx)$, and, in this case, $Z(S)_1 = kx$ (Type TL).

Proof. If E is reduced, then, for every $0 \neq u \in Z(S)_1$, $E \not\subset \mathcal{V}(u)$, so there exists an irreducible component E_0 of E such that $E_0 \not\subset \mathcal{V}(u)$. Since $\sigma|_{E \setminus \mathcal{V}(u)} = \text{id}$ by Lemma 3.1, $\sigma|_{E_0 \setminus \mathcal{V}(u)} = \text{id}$, so $\sigma|_{E_0} = \text{id}$. By Lemma 2.8, we can check that $\sigma = \text{id}$, and $S \cong k[x, y, z]$ (Type P). In this case, $Z(S)_1 = S_1$.

If S is of Type TL, then we can show that $Z(S)_1 \neq 0$ if and only if $S \cong k\langle x, y, z \rangle/(yz - zy + x^2, zx - xz, xy - yx)$, and, in this case, we can show that $Z(S)_1 = kx$ by direct calculations.

If S is of Type WL, then we can show that $Z(S)_1 = 0$ by direct calculations.

To check which S has a property that $Z(S)_2 \neq 0$, we need more work.

Lemma 3.3. If S = T(V)/(R) is a quadratic algebra,

$$W = R \otimes V^{\otimes 2} + V \otimes R \otimes V + V^{\otimes 2} \otimes R \subset V^{\otimes 4},$$

 $U = V \otimes V$, $\overline{U} = U/\widetilde{R}$, and $\pi : U \to \overline{U}$ is a natural surjection, then we have the following commutative diagram

Proof. Since $\operatorname{Ker}(\pi \otimes \pi) = \widetilde{R} \otimes U + U \otimes \widetilde{R} \subset \widetilde{W}$, we see that $\pi \otimes \pi : U \otimes U \to \overline{U} \otimes \overline{U}$ induces an isomorphism $(U \otimes U)/\widetilde{W} \to (\overline{U} \otimes \overline{U})/\overline{W}$ where $\overline{W} := (\pi \otimes \pi)(\widetilde{W})$. Since

$$\begin{aligned} (\pi^* \times \pi^*)(\mathcal{V}(\overline{W})) &= \{ (\pi^* \times \pi^*)(p,q)) \mid (p,q) \in \mathcal{V}(\overline{W}) \} \\ &= \{ (\pi^*(p),\pi^*(q)) \mid ((\pi \otimes \pi)(\tilde{w}))(p,q) = 0 \; \forall \tilde{w} \in \widetilde{W} \} \\ &= \{ (\pi^*(p),\pi^*(q)) \mid \tilde{w}((\pi^*(p),\pi^*(q)) = 0 \; \forall \tilde{w} \in \widetilde{W} \} \\ &\subset \mathcal{V}(\widetilde{W}), \end{aligned}$$

we have a commutative diagram

$$\begin{array}{ccc} \mathcal{V}(\overline{W}) & \longrightarrow & \mathbb{P}(\overline{U}^*) \times \mathbb{P}(\overline{U}^*) \\ \cong & & & & \downarrow \\ \pi^* \times \pi^* \\ \mathcal{V}(\widetilde{W}) & \longrightarrow & \mathbb{P}(U^*) \times \mathbb{P}(U^*). \end{array}$$

Since $S^{(2)}$ is a quadratic algebra by [18, Proposition 2.2, Chapter 3] such that $S_1^{(2)} = \overline{U}, S_2^{(2)} = (\overline{U} \otimes \overline{U})/\overline{W}$, we see that $S^{(2)} = T(\overline{U})/(\overline{W})$, so $\overline{\Gamma}_{S^{(2)}} = \mathcal{V}(\overline{W})$, hence the result.

Proposition 3.4. If S = T(V)/(R) is a quadratic algebra satisfying (G1) with $\mathcal{P}(S) = (E, \sigma)$ and $\pi : U := V \otimes V \to U/\widetilde{R}$ is a natural surjection, then $\Delta_{E^{(2)},\sigma^{(2)}} \subset \overline{\Gamma}_{S^{(2)}}$ where $\widetilde{E} := \Sigma(\overline{\Gamma}_S)$, $E^{(2)} := (\pi^*)^{-1}(\widetilde{E})$, and $\widetilde{\sigma} \in$ Aut $\widetilde{E}, \sigma^{(2)} \in$ Aut $E^{(2)}$ are given by the commutative diagram

$$\begin{array}{ccc} \overline{\Gamma}_{S} & \xrightarrow{\sigma^{2} \times \sigma^{2}} & \overline{\Gamma}_{S} \\ \Sigma & \stackrel{\simeq}{\searrow} & \cong & \downarrow \Sigma \\ \widetilde{E} & \xrightarrow{\widetilde{\sigma}} & \widetilde{E} \\ \pi^{*} & \stackrel{\simeq}{\cong} & \cong & \uparrow \pi^{*} \\ E^{(2)} & \xrightarrow{\sigma^{(2)}} & E^{(2)} \end{array}$$

Proof. Since

$$\overline{\Gamma}_S := \mathcal{V}(R) = \Delta_{E,\sigma} := \{ (p, \sigma(p)) \subset \mathbb{P}(V^*) \times \mathbb{P}(V^*) \mid p \in E \},\$$

$$E := \Sigma(\Gamma_S) = \{\Sigma(p, \sigma(p)) \in \mathbb{P}(U^*) \mid p \in E\}.$$
 Since
$$\mathcal{V}(W) = \{(p, \sigma(p), \sigma^2(p), \sigma^3(p)) \in \mathbb{P}(V^*) \times \mathbb{P}(V^*) \times \mathbb{P}(V^*) \times \mathbb{P}(V^*) \mid p \in E\},\$$

$$\begin{split} \mathcal{V}(\widetilde{W}) \supset (\Sigma \times \Sigma)(\mathcal{V}(W)) \\ &= (\Sigma \times \Sigma)(\{(p, \sigma(p), \sigma^2(p), \sigma^3(p)) \in \mathbb{P}(V^*)^{\times 4} \mid p \in E\} \\ &= \{(\Sigma(p, \sigma(p)), \Sigma(\sigma^2 \times \sigma^2)(p, \sigma(p))) \in \mathbb{P}(U^*)^{\times 2} \mid p \in E\} \\ &= \{(\Sigma(p, \sigma(p)), \widetilde{\sigma}\Sigma(p, \sigma(p)) \in \mathbb{P}(U^*)^{\times 2} \mid p \in E\} \\ &=: \Delta_{\widetilde{E}, \widetilde{\sigma}} \end{split}$$

by Lemma 2.1. By Lemma 3.3,

$$\begin{split} \Delta_{E^{(2)},\sigma^{(2)}} &:= \{ (p,\sigma^{(2)}(p)) \mid p \in E^{(2)} \} = \{ ((\pi^*)^{-1}(q),\sigma^{(2)}(\pi^*)^{-1}(q)) \mid q \in \widetilde{E} \} \\ &= \{ ((\pi^*)^{-1}(q),(\pi^*)^{-1}\widetilde{\sigma}(q)) \mid q \in \widetilde{E} \} = (\pi^* \times \pi^*)^{-1}(\Delta_{\widetilde{E},\widetilde{\sigma}}) \\ &\subset (\pi^* \times \pi^*)^{-1}(\mathcal{V}(\widetilde{W})) = \overline{\Gamma}_{S^{(2)}}. \end{split}$$

Lemma 3.5. Let S be a quadratic algebra satisfying (G1) with $\mathcal{P}(S) = (E, \sigma)$. If S also satisfies (G2), then $\widetilde{E} \not\subset \mathcal{V}(\widetilde{f})$ for every $0 \neq f \in S_2$.

Proof. If $\widetilde{E} \subset \mathcal{V}(\widetilde{f})$, then

$$\Sigma(\overline{\Gamma}_S) =: \widetilde{E} = \widetilde{E} \cap \operatorname{Im} \Sigma \subset \mathcal{V}(\widetilde{f}) \cap \operatorname{Im} \Sigma = \Sigma(\mathcal{V}(f))$$

by Lemma 2.1. Since $\Sigma : \mathbb{P}^{n-1} \times \mathbb{P}^{n-1} \to \mathbb{P}^{n^2-1}$ is injective, $\overline{\Gamma}_S \subset \mathcal{V}(f)$, so $f(p, \sigma(p)) = 0$ for every $p \in E$. Since S satisfies (G2), f = 0 in S, which is a contradiction.

We have a rather short list of 3-dimensional Calabi-Yau quantum polynomial algebras S such that $Z(S)_2 \neq 0$.

Theorem 3.6. Let $S = \mathcal{A}^+(E, \sigma) = k\langle x, y, z \rangle / (f_1, f_2, f_3)$ be a 3-dimensional Calabi-Yau quantum polynomial algebra. Then $Z(S)_2 \neq 0$ if and only if $\overline{\sigma}^2$ = id if and only if S is isomorphic to one of the algebras in Table 2 below. For each algebra, $Z(S)_2$ is also given in Table 2.

where $\lambda \in k$ such that $\lambda^3 \neq 0, 1, -8$.

Proof. We use the notations in Proposition 3.4. If E is reduced (so that $\overline{\Gamma} = \Gamma$ is reduced), then S satisfies (G1) and (G2) with $\mathcal{P}(S) = (E, \sigma)$ by Remark 2.7. If $0 \neq f \in Z(S)_2$, then $0 \neq \overline{f} \in Z(S^{(2)})_1$, so $\sigma^{(2)}|_{E^{(2)} \setminus \mathcal{V}(\overline{f})} = \mathrm{id}$ by Proposition 3.4 and Lemma 3.1. Since $\tilde{f}(\pi^*(p)) = (\pi(\tilde{f}))(p) = \overline{f}(p)$ for $p \in \mathbb{P}(\overline{U}), \pi^*(E^{(2)} \setminus \mathcal{V}(\overline{f})) = \widetilde{E} \setminus \mathcal{V}(\widetilde{f})$, so $\tilde{\sigma}|_{\widetilde{E} \setminus \mathcal{V}(\widetilde{f})} = \mathrm{id}$.

Since Σ restricts to an isomorphism $\Gamma \to \widetilde{E}$ (as varieties), there exists an irreducible component Γ_0 of Γ such that $\widetilde{E}_0 := \Sigma(\Gamma_0) \not\subset \mathcal{V}(\widetilde{f})$ by Lemma 3.5. Since projections $p_1, p_2 : \mathbb{P}^2 \times \mathbb{P}^2 \to \mathbb{P}^2$ restrict to isomorphisms $\Gamma \to E$ (as varieties), $E_0 := p_1(\Gamma_0)$ is an irreducible component of E such that $\Gamma_0 = \{(p, \sigma(p)) \mid p \in E_0\}.$

Since $\tilde{\sigma}|_{\tilde{E}_0 \setminus \mathcal{V}(\tilde{f})} = \text{id}$, we have $\tilde{\sigma}|_{\tilde{E}_0} = \text{id}$, so $(\sigma|_{E_0})^2 = \text{id}$ by the commutative diagram



By Lemma 2.8, we can check that $(\sigma|_{E_0})^2 = \text{id}$ for some irreducible component E_0 of E if and only if $\sigma^2 = \text{id}$ if and only if S is isomorphic to one of the algebras of Type P, S, S', NC, EC in Table 2 above. On the other hand, if S = k[x, y, z] (Type P), then clearly, $Z(S)_2 = S_2 \neq 0$, and if S is one of the algebras of Type S, S', NC, EC in Table 2 above, then $Z(S)_2 = kx^2 + ky^2 + kz^2 \neq 0$ by [9, Lemma 3.6].

If S is of Type TL, then we can show that $Z(S)_2 \neq 0$ if and only if $S \cong k\langle x, y, z \rangle / (yz - zy + x^2, zx - xz, xy - yx)$, and, in this case, we can show that $Z(S)_2 = kx^2$ by direct calculations and $\bar{\sigma} =$ id by Lemma 2.8.

If S is of Type WL, then we can show that $Z(S)_2 = 0$ by direct calculations and $|\bar{\sigma}| = \infty$ by Lemma 2.8.

Example 3.7. We explain our geometric method by using a 2-dimensional quantum polynomial algebra $S = k \langle u, v \rangle / (vu - \lambda uv) = \mathcal{A}^+(\mathbb{P}^1, \sigma)$ where $\sigma(a, b) = (\lambda a, b)$. It is easy to see that $Z(A)_2 \neq 0$ if and only if $\lambda^2 = 2$ if and only if $\sigma^2 = \text{id}$. By calculations, we can show that $\mathcal{P}(S^{(2)}) = (E^{(2)}, \sigma^{(2)})$ where

$$\widetilde{E} = \Sigma(\overline{\Gamma}_S) = \Sigma(\{((a, b), (\lambda a, b)) \mid (a, b) \in \mathbb{P}^1\}) \\
= \{(\lambda a^2, ab, \lambda ab, b^2) \mid (a, b) \in \mathbb{P}^1\} \cong \mathbb{P}^1, \\
\widetilde{\sigma}(\alpha, \beta, \gamma, \delta) = (\lambda^4 \alpha, \lambda^2 \beta, \lambda^2 \gamma, \delta), \text{ and} \\
E^{(2)} = (\pi^*)^{-1}(\widetilde{E}) = \{(\lambda a^2, ab, b^2) \mid (a, b) \in \mathbb{P}^1\} \cong \mathbb{P}^1, \\
\sigma^{(2)}(\alpha, \beta, \gamma) = (\lambda^4 \alpha, \lambda^2 \beta, \gamma).$$

If $0 \neq f \in Z(S)_2$, then $0 \neq \overline{f} \in Z(S^{(2)})_1$, so $\sigma^{(2)}|_{E^{(2)}\setminus \mathcal{V}(\overline{f})} = \text{id.}$ Since $E^{(2)} \not\subset \mathcal{V}(\overline{f})$, we have $\sigma^{(2)} = \text{id}$, so $\lambda^2 = 1$.

We write

 $k_{-1}[x, y, z] := k \langle x, y, z \rangle / (yz + zy, zx + xz, xy + yx) =: S^{(0,0,0)}.$

The following corollary describes all the possible homogeneous coordinate algebras of noncommutative conics.

Corollary 3.8. If $S = \mathcal{A}^+(E, \sigma)$ is a 3-dimensional Calabi-Yau quantum polynomial algebra, and $0 \neq f \in Z(S)_2$, then A = S/(f) is isomorphic to either

- (1) $k[x, y, z]/(x^2), k[x, y, z]/(x^2 + y^2), k[x, y, z]/(x^2 + y^2 + z^2), and, in this case, <math>|\sigma| \neq 2$ and $A^! \cong k_{-1}[x, y, z]/(G_1, G_2)$ for some $G_1, G_2 \in k_{-1}[x, y, z]_2$ ($A^!$ is graded commutative), or
- $k_{-1}[x, y, z]_2 \quad (A^! \text{ is graded commutative}), \text{ or}$ $(2) \quad S^{(\alpha,\beta,\gamma)}/(ax^2 + by^2 + cz^2) \text{ for some } \alpha, \beta, \gamma \in k \text{ and } (a, b, c) \in \mathbb{P}^2 \text{ where}$ $S^{(\alpha,\beta,\gamma)} := k\langle x, y, z \rangle/(yz + zy + \alpha z^2) xz + zz + \beta y^2 xy + \alpha z^2)$

$$S^{(\alpha,\beta,\gamma)} := k\langle x,y,z\rangle/(yz+zy+\alpha x^2,zx+xz+\beta y^2,xy+yx+\gamma z^2),$$

and, in this case, $|\sigma| = 2$ and $A^! \cong k[x, y, z]/(G_1, G_2)$ for some $G_1, G_2 \in k[x, y, z]_2$ ($A^!$ is commutative).

Proof. By Theorem 3.6, S is isomorphic to one of the algebras in Table 2. If S is of Type P, then A is isomorphic to

$$k[x, y, z]/(x^2), k[x, y, z]/(x^2 + y^2), k[x, y, z]/(x^2 + y^2 + z^2)$$

by Sylvester's theorem. If S is of Type TL, then $A \cong k[x, y, z]/(x^2)$ by Table 2. In either case, $|\sigma| \neq 2$ by Table 2, and we can show that $A^!$ is isomorphic to

$$k_{-1}[x, y, z]/(y^2, z^2), k_{-1}[x, y, z]/(x^2 - y^2, z^2), k_{-1}[x, y, z]/(x^2 - y^2, x^2 - z^2)$$

by direct calculations.

If S is of Type S, S', NC, EC, then $A \cong S^{(\alpha,\beta,\gamma)}/(ax^2 + by^2 + cz^2)$ where $(a,b,c) \in \mathbb{P}^2$ and $|\sigma| = 2$ by Table 2. By [9, Theorem 3.7], $A^! \cong k[x,y,z]/(G_1,G_2)$ for some $G_1, G_2 \in k[x,y,z]_2$. For example, if $a \neq 0$, then $A^! \cong k[x,y,z]/(a(y^2 - \beta xz) - b(x^2 - \alpha yz), a(z^2 - \gamma xy) - c(x^2 - \alpha yz)).$

Corollary 3.9. There are at most 9 isomorphism classes of homogeneous coordinate algebras A of noncommutative conics.

Proof. If A is commutative, then there are exactly 3 isomorphism classes for A by Corollay 3.8 (1). On the other hand, if A is not commutative, then $A^! \cong k[x, y, z]/(G_1, G_2)$ where $G_1, G_2 \in k[x, y, z]_2$ by Corollary 3.8 (2). Since A is Koszul,

$$H_{A^{!}}(t) = 1/H_{A}(-t) = (1+t)^{3}/(1-t^{2}) = (1-t^{2})^{2}/(1-t)^{3},$$

so $G_1, G_2 \in k[x, y, z]_2$ is a regular sequence, that is, $A^!$ is a quadratic complete intersection. As a consequence of the classical result of "a pencil of

conics", there are at most 6 isomorphism classes for $A^!$ ([7, Section 11, Chapter XIII]). Since $A \cong A'$ if and only if $A^! \cong A'^!$, there are at most 6 isomorphism classes for A.

4. Classifications of E_A and C(A)

Let A = S/(f) be a noncommutative conic where S is a 3-dimensional Calabi-Yau quantum polynomial algebra and $0 \neq f \in Z(S)_2$. In this section, we will show that A satisfies (G1) so that the point variety $E_A \subset \mathbb{P}^2$ of A is well-defined, and classify E_A up to isomorphism. Recall in Introduction that there is a finite dimensional algebra C(A) which plays an important role to study A. If A = S/(f) is a noncommutative conic, then C(A) is a 4-dimensional algebra by [20, Lemma 5.1 (3)]. In [9], we fail to compute C(A) when S is of Type EC. In this section, we complete the classification of C(A) by using the geometry of E_A . We first set some definitions and notations.

The Clifford deformation of a quadratic algebra was introduced by He and Ye [8].

Definition 4.1. Let S = T(V)/(R) be a quadratic algebra where $R \subset V \otimes V$. A linear map $\theta : R \to k$ is called a *Clifford map* if

$$(\theta \otimes 1 - 1 \otimes \theta)(V \otimes R \cap R \otimes V) = 0.$$

We define the *Clifford deformation* of S associated to θ by

$$S(\theta) := T(V)/(f - \theta(f) \mid f \in R).$$

Let S = T(V)/(R) be a quadratic algebra where $R \subset V \otimes V$. Note that the \mathbb{Z}_2 -graded structure on $T(V) = (\bigoplus_{i=0}^{\infty} V^{\otimes 2i}) \oplus (\bigoplus_{i=0}^{\infty} V^{\otimes 2i+1})$ induces a \mathbb{Z}_2 -graded structure on $S(\theta)$. The set of Clifford maps θ of $S^! = T(V^*)/(R^{\perp})$ is in one-to-one correspondence with the set of central elements $f \in Z(S)_2$ by [8, Lemma 2.8]. We denote by θ_f the Clifford map of $S^!$ corresponding to $f \in Z(S)_2$.

If C is a finitely generated commutative algebra over k, and G is a finite group acting on C, then G naturally acts on Spec C, and there exists a bijection between the set of G-orbits of the closed points of Spec C and the set of closed points of Spec C^G . By this reason, we define $(\operatorname{Spec} C)/G := \operatorname{Spec} C^G$.

Definition 4.2. Let S be a connected graded algebra. For $f, f' \in S$, we write $f \sim f'$ if $f' = \lambda f$ for some $0 \neq \lambda \in k$. For $f \in S_2$, we define

$$K_f := \{g \in S_1 \mid g^2 \sim f\} / \sim .$$

Note that $\#(K_f)$ is exactly the number of $g \in S_1$ up to sign such that $g^2 = f$.

Proposition 4.3. Let $S = \mathcal{A}^+(E, \sigma)$ be a 3-dimensional Calabi-Yau quantum polynomial algebra such that $|\sigma| = 2$, $0 \neq f \in Z(S)_2$, and A = S/(f).

(1) For every $g \in S_1$, $g^2 \in Z(S)_2$. (2) $\#(K_f) = \#(\operatorname{Spec} C(A)) = \#(\operatorname{Proj} A^!) = \#(E_{A^!}) = 1, 2, 3, 4$.

Proof. We may assume that

$$S = k\langle x, y, z \rangle / (yz + zy + \alpha x^2, zx + xz + \beta y^2, xy + yx + \gamma z^2)$$

for some $\alpha, \beta, \gamma \in k$, and $f = ax^2 + by^2 + cz^2$ for $a, b, c \in k$ by Corollary 3.8. (1) For every $g = \lambda x + \mu y + \nu z \in S_1$,

$$g^{2} = \lambda^{2}x^{2} + \mu^{2}y^{2} + \nu^{2}z^{2} + \lambda\mu(xy + yx) + \nu\lambda(xz + zx) + \mu\nu(yz + zy)$$

= $(\lambda^{2} - \alpha\mu\nu)x^{2} + (\mu^{2} - \beta\nu\lambda)y^{2} + (\nu^{2} - \gamma\lambda\mu)z^{2} \in Z(S)_{2}$

by Theorem 3.6.

(2) It is easy to calculate that the quadratic dual of S is

$$S^! \cong k[u, v, w]/(u^2 - \alpha vw, v^2 - \beta wu, w^2 - \gamma uv),$$

and the Clifford map θ_f of $S^!$ induced by f is given by

$$u^2 - \alpha v w \mapsto a, v^2 - \beta w u \mapsto b, w^2 - \gamma u v \mapsto c,$$

so the Clifford deformation of $S^!$ associated to θ_f is

$$S^{!}(\theta_{f}) \cong k[u, v, w]/(u^{2} - \alpha vw - a, v^{2} - \beta wu - b, w^{2} - \gamma uv - c)$$

as \mathbb{Z}_2 -graded algebras. A finite group $G = \{\epsilon, \delta\}$ acts on $S^!(\theta_f)$ by $\delta(h) = (-1)^{\deg h}h$ for a homogeneous element $h \in S^!(\theta_f)$ so that $(S^!(\theta_f))^G = (S^!(\theta_f))_0 \cong C(A)$ by [8, Proposition 4.3].

On the other hand, $g^2 = f = ax^2 + by^2 + cz^2$ if and only if

$$(\lambda, \mu, \nu) \in \mathcal{V}(u^2 - \alpha vw - a, v^2 - \beta wu - b, w^2 - \gamma uv - c) = \overline{\operatorname{Spec} S!(\theta_f)}$$

by (1). Since the natural action of G on $\overline{\operatorname{Spec} S^!(\theta_f)}$ is given by $\delta^*(\lambda, \mu, \nu) = (-\lambda, -\mu, -\nu)$, we see that $\#(K_f) = \#((\operatorname{Spec} S^!(\theta_f))/G)$. Since $A^!$ and C(A) are commutative by Corollary 3.8,

$$(\operatorname{Spec} S^!(\theta_f))/G = \operatorname{Spec}(S^!(\theta_f))^G \cong \operatorname{Spec} C(A) \cong \operatorname{Proj} A^! = E_{A^!} \neq \emptyset$$

by Lemma 2.5. Since $\#(\operatorname{Spec} C(A)) \leq \dim_k C(A) = 4$, the result follows.

Lemma 4.4. Let S be a quadratic algebra satisfying (G1) with $\mathcal{P}(S) = (E, \sigma), 0 \neq f \in S_2$, and A = S/(f). If $\sigma^2 = \text{id}$ and $f = g^2$ for some $g \in S_1$ (that is, $K_f \neq \emptyset$), then A satisfies (G1) with $\mathcal{P}(A) = (E_A, \sigma_A)$ where

$$E_A = (E \cap \mathcal{V}(g)) \cup \sigma(E \cap \mathcal{V}(g))$$

and $\sigma_A = \sigma|_{E_A}$.

Proof. Since

$$\overline{\Gamma}_A = \overline{\Gamma} \cap \mathcal{V}(f) = \{(p, \sigma(p)) \mid p \in E, f(p, \sigma(p)) = g(p)g(\sigma(p)) = 0\},\$$

 $(p, \sigma(p)) \in \overline{\Gamma}_A$ if and only if $p \in E$ and $g(p)g(\sigma(p)) = 0$ if and only if $(\sigma(p), \sigma^2(p)) = (\sigma(p), p) \in \overline{\Gamma}_A$, so A satisfies (G_1) with $\mathcal{P}(A) = (E_A, \sigma_A)$ where

$$E_A = \{ p \in E \mid f(p, \sigma(p)) = g(p)g(\sigma(p)) = 0 \}$$

= $\{ p \in E \mid g(p) = 0 \} \cup \{ p \in E \mid g(\sigma(p)) = 0 \}$
= $(E \cap \mathcal{V}(g)) \cup (E \cap \sigma^{-1}(\mathcal{V}(g)))$
= $(E \cap \mathcal{V}(g)) \cup \sigma(E \cap \mathcal{V}(g)),$

and $\sigma_A = \sigma|_{E_A}$.

Proposition 4.5. If $S = \mathcal{A}^+(E, \sigma)$ is a 3-dimensional Calabi-Yau quantum polynomial algebra, $0 \neq f \in Z(S)_2$, and A = S/(f), then both A and A[!] satisfy (G1).

Proof. The case $|\sigma| \neq 2$: Since A is commutative by Corollary 3.8, A satisfies (G1) by Lemma 2.5. Since $k_{-1}[x, y, z] = \mathcal{A}(\mathcal{V}(xyz), \tau)$ is a geometric quantum polynomial algebra with $|\tau| = 2$, and $A^!$ is isomorphic to one of the following algebras

$$\begin{aligned} &k_{-1}[x, y, z]/(y^2, z^2), \\ &k_{-1}[x, y, z]/((x + \sqrt{-1}y)^2, z^2), \\ &k_{-1}[x, y, z]/((x + \sqrt{-1}y)^2, (x + \sqrt{-1}z)^2) \end{aligned}$$

by the proof of Corollary 3.8, $A^{!}$ satisfies (G1) by applying Lemma 4.4 twice.

The case $|\sigma| = 2$: By Proposition 4.3, there exists $g \in S_1$ such that $f = g^2$, so A satisfies (G1) by Lemma 4.4. Since $A^!$ is commutative by Corollary 3.8, $A^!$ satisfies (G1) by Lemma 2.5.

Example 4.6. By using Lemma 4.4, we calculate the point variety $E_A = (E \cap \mathcal{V}(g)) \cup \sigma(E \cap \mathcal{V}(g))$ for a noncommutative conic A = S/(f) where S is a 3-dimensional Calabi-Yau quantum polynomial algebra of Type S and $g \in S_1$ such that $g^2 = f$. By Corollary 3.8, we may assume that $S = S^{(0,0,0)} = k_{-1}[x, y, z]$ and f is one of $x^2, x^2 + y^2, x^2 + y^2 + z^2 \in Z(S)_2$. If $\mathcal{P}(S) = (E, \sigma)$, then $E = \mathcal{V}(xyz) = \mathcal{V}(x) \cup \mathcal{V}(y) \cup \mathcal{V}(z)$ and $\begin{cases} \sigma(0, b, c) = (0, b, -c), \\ \sigma(a, 0, c) = (-a, 0, c), \\ \sigma(a, b, 0) = (a, -b, 0) \end{cases}$ by

Lemma 2.8.

(1) If $f = x^2$, then $E \cap \mathcal{V}(g) = \mathcal{V}(xyz) \cap \mathcal{V}(x) = \mathcal{V}(x)$. Since $\sigma(\mathcal{V}(x)) = \mathcal{V}(x)$, $E_A = \mathcal{V}(x) \subset \mathbb{P}^2$ is a line. (2) If $f = x^2 + y^2$, then $f = (x + y)^2$, so $E \cap \mathcal{V}(g) = \mathcal{V}(xyz) \cap \mathcal{V}(x + y) = \{(1, -1, 0), (0, 0, 1)\} \subset \mathbb{P}^2$. Since $\sigma(1, -1, 0) = (1, 1, 0), \sigma(0, 0, 1) = (0, 0, 1),$ $E_A = \{(1, -1, 0), (0, 0, 1), (1, 1, 0)\} \subset \mathbb{P}^2$, so $\#(E_A) = 3$.

(3) If
$$f = x^2 + y^2 + z^2$$
, then $f = (x + y + z)^2$, so
 $E \cap \mathcal{V}(g) = \mathcal{V}(xyz) \cap \mathcal{V}(x + y + z) = \{(0, 1, -1), (-1, 0, 1), (1, -1, 0)\} \subset \mathbb{P}^2$.
Since $\sigma(0, 1, -1) = (0, 1, 1), \sigma(-1, 0, 1) = (1, 0, 1), \sigma(1, -1, 0) = (1, 1, 0)$
 $E_A = \{(0, 1, -1), (-1, 0, 1), (1, -1, 0), (0, 1, 1), (1, 0, 1), (1, 1, 0)\} \subset \mathbb{P}^2$,
so $\#(E_A) = 6$.

Recall that every 3-dimensional Calabi-Yau quantum polynomial algebra of Type EC is isomorphic to a 3-dimensional Sklyanin algebra (see [12, Corollary 4.3]), and every 3-dimensional Sklyanin algebra S such that $Z(S)_2 \neq 0$ is of the form

$$S = k \langle x, y, z \rangle / (yz + zy + \lambda x^2, zx + xz + \lambda y^2, xy + yx + \lambda z^2)$$

where $\lambda^3 \neq 0, 1, -8$ by Theorem 3.6. In this case, $(E, \sigma) = \mathcal{P}(S) = \mathcal{P}^+(S)$ is described as follows: $E = \mathcal{V}(F) \subset \mathbb{P}^2$ is a smooth elliptic curve where

$$F := \lambda(x^3 + y^3 + z^3) - (\lambda^3 + 2)xyz \in k[x, y, z]_3$$

If we endow a group structure on E with the identity $o := (1, -1, 0) \in E$, then $\sigma \in \operatorname{Aut} E$ is a translation by a 2-torsion point $(1, 1, \lambda) \in E[2]$. We use the fact that $\sigma(p) + \sigma(q) = p + q$ for every points $p, q \in E$. More explicitly, σ can be described as

$$\sigma(u, v, w) = \begin{cases} (\lambda v^2 - uw, \lambda u^2 - vw, w^2 - \lambda^2 uv) & \text{if } (u, v, w) \in E \setminus E_1\\ (\lambda w^2 - uv, v^2 - \lambda^2 uw, \lambda u^2 - vw) & \text{if } (u, v, w) \in E \setminus E_2 \end{cases}$$

where $E_1 := \{(1, \epsilon, \lambda \epsilon^2) \mid \epsilon^3 = 1\}, E_2 := \{(1, \lambda \epsilon^2, \epsilon) \mid \epsilon^3 = 1\}$ (cf. [4]).

Lemma 4.7. Let $S = \mathcal{A}^+(E, \sigma)$ be a 3-dimensional Sklyanin algebra, and $0 \neq f = ax^2 + by^2 + cz^2 \in Z(S)_2$. If $a^3 = b^3 = c^3$, then $\#(K_f) = 4$.

Proof. Without loss of generality, we may assume that a = 1 and $b^3 = c^3 = 1$. By the proof of Corollary 3.8, $A^! \cong k[x, y, z]/(G_1, G_2)$ where

$$G_1 = (y^2 - \lambda xz) - b(x^2 - \lambda yz), G_2 = (z^2 - \lambda xy) - c(x^2 - \lambda yz) \in k[x, y, z]_2.$$

By calculations,

$$\mathcal{V}(G_{1x}, G_{1y}, G_{1z}) = \mathcal{V}(-\lambda z - 2bx, 2y + b\lambda z, -\lambda x + b\lambda y) = \{(b^2\lambda, b\lambda, -2)\},$$

so $\mathcal{V}(G_1)$ is a pair of lines meeting at $(b^2\lambda, b\lambda, -2)$. If

$$G_2(b^2\lambda, b\lambda, -2) = -(\lambda^3 + 3bc\lambda^2 - 4) = -(\lambda - bc)(\lambda + 2bc)^2 = 0,$$

then $\lambda = bc$ or $\lambda = -2bc$, so $\lambda^3 = b^3c^3 = 1$ or $\lambda^3 = -8b^3c^3 = -8$, which is a contradiction, hence $(b^2\lambda, b\lambda, -2) \notin \mathcal{V}(G_2)$. By symmetry, $\mathcal{V}(G_2)$ is a pair of lines meeting at $(c^2\lambda, -2, c\lambda) \notin \mathcal{V}(G_1)$, so $\#(K_f) = \#(\operatorname{Proj} A^!) =$ $\#(\mathcal{V}(G_1) \cap \mathcal{V}(G_2)) = 4$ by Proposition 4.3. \Box **Example 4.8.** Let $S = \mathcal{A}^+(E, \sigma)$ be a 3-dimensional Sklyanin algebra, and $0 \neq f = ax^2 + by^2 + cz^2 \in Z(S)_2$. If $a^3 = b^3 = c^3$, then $S/(f) \cong$ $S/(x^2 + y^2 + \epsilon z^2)$ where $\epsilon^3 = 1$ by [9, Lemma 4.4, Theorem 4.5]. If $g \in S_1$ is one of the following

$$x + y + \epsilon^2 z, x + y - \epsilon(\epsilon + \lambda)z, \epsilon x - (\epsilon + \lambda)y + z, -(\epsilon + \lambda)x + \epsilon y + z \in S_1,$$

then we can directly check that $g^2 \sim f$, so $\#(K_f) \geq 4$. By Proposition 4.3, we have $\#(K_f) = 4$.

We can find $g \in S_1$ such that $g^2 \sim f$ using geometry as follows: if $p = (1, 0, -\epsilon), q = (0, 1, -\epsilon) \in E$, then $\sigma(o) = (1, 1, \lambda), \sigma(p) = (\epsilon, \lambda, \epsilon^2), \sigma(q) = (\lambda, \epsilon, \epsilon^2)$, and $f(o, \sigma(o)) = f(p, \sigma(p)) = f(q, \sigma(q)) = 0$. By Lemma 4.4 and by Bezout's theorem, we see that $\#(E_A) \leq 2\#(E \cap \mathcal{V}(g)) \leq 6$, so $E_A = \{o, p, q, \sigma(o), \sigma(p), \sigma(q)\}$. If $g_1, g_2, g_3, g_4 \in S_1$ such that

$$E \cap \mathcal{V}(g_1) = \{p, q\}, E \cap \mathcal{V}(g_2) = \{o, \sigma(p)\}, \\ E \cap \mathcal{V}(g_3) = \{p, \sigma(o)\}, E \cap \mathcal{V}(g_4) = \{q, \sigma(o)\},$$

then we can check that

 $g_1 \sim x + y + \epsilon^2 z, g_2 \sim x + y - \epsilon(\epsilon + \lambda)z, g_3 \sim \epsilon x - (\epsilon + \lambda)y + z, g_4 \sim -(\epsilon + \lambda)x + \epsilon y + z.$ **Lemma 4.9.** Let S be a 3-dimensional Sklyanin algebra. For every $0 \neq f \in Z(S)_2, \ \#(K_f) \geq 2.$

Proof. If $\#(K_f) = 1$, then $\#(\operatorname{Spec} C(A)) = \#(K_f) = 1$ by Proposition 4.3, so C(A) is isomorphic to either $k[u, v]/(u^2, v^2)$ or $k[u]/(u^4)$ (cf. [9, Corollary 4.10]). We will show that this is not the case.

Let $0 \neq f = ax^2 + by^2 + cz^2 \in Z(S)_2$ and A = S/(f). By Lemma 4.7, we may assume that either $a^3 \neq c^3$ or $b^3 \neq c^3$. Without loss of generality, we may assume that c = 1. If $a^3 \neq 1$, then $C(A) \cong k[u]/(\varphi(u))$ where

$$\begin{split} \varphi(u) = & u^4 + \frac{3b\lambda^2}{(\lambda^3 - 1)}u^3 + \frac{3b^2\lambda^4 - a\lambda^3 - 2a}{(\lambda^3 - 1)^2}u^2 \\ & + \frac{\lambda^2(b^3\lambda^4 - 2ab\lambda^3 + (1 + a^3)\lambda - ab)}{(\lambda^3 - 1)^3}u + \frac{-ab^2\lambda^4 + (a^3b + b)\lambda^2 - a^2}{(\lambda^3 - 1)^3} \end{split}$$

by [9, Example 11]. Since C(A) is generated by one element over k as an algebra, $C(A) \not\cong k[u, v]/(u^2, v^2)$. If $\varphi(u) = (u - \mu)^4$ for some $\mu \in k$, then, by comparing the coefficients in both sides, we have

$$\begin{cases} -4\mu &= \frac{3b\lambda^2}{\lambda^3 - 1}, \\ 6\mu^2 &= \frac{3b^2\lambda^4 - a\lambda^3 - 2a}{(\lambda^3 - 1)^2}, \\ -4\mu^3 &= \frac{\lambda^2(b^3\lambda^4 - 2ab\lambda^3 + (1+a^3)\lambda - ab)}{(\lambda^3 - 1)^3}, \\ \mu^4 &= \frac{-ab^2\lambda^4 + (a^3b + b)\lambda^2 - a^2}{(\lambda^3 - 1)^3}. \end{cases}$$

By solving the above system of equations, we get

$$\lambda = a = \mu = 0$$
, or
 $\lambda^3 = -8, a^3 = 1, b = -a\lambda/2, \mu = a/3,$

which contradicts the condition that $\lambda^3 \neq 0, 1, -8$, so $C(A) \ncong k[u]/(u^4)$. By symmetry, the result holds for the case that $b^3 \neq 1$.

Lemma 4.10. Let $S = \mathcal{A}^+(E, \sigma)$ be a 3-dimensional Sklyanin algebra, $0 \neq f = ax^2 + by^2 + cz^2 \in Z(S)_2$ and A = S/(f). Define

$$H_1 = ax(\lambda y^2 - xz) + by(\lambda x^2 - yz) + cz(z^2 - \lambda^2 xy),$$

$$H_2 = ax(\lambda z^2 - xy) + by(y^2 - \lambda^2 xz) + cz(\lambda x^2 - yz) \in k[x, y, z]_3.$$

Then the following holds:

- (1) $E \cap \mathcal{V}(H_1) = E_A \cup E_1$. If $a^3 \neq b^3$, then $E \cap \mathcal{V}(H_1) = E_A \sqcup E_1$ (disjoint union).
- (2) $E \cap \mathcal{V}(H_2) = E_A \cup E_2$. If $a^3 \neq c^3$, then $E \cap \mathcal{V}(H_2) = E_A \sqcup E_2$ (disjoint union).

Proof. (1) It is easy to check that $E_1 := \{(1, \epsilon, \lambda \epsilon^2) \mid \epsilon^3 = 1\} \subset E \cap \mathcal{V}(H_1)$, so $p \in E_A \cup E_1$ if and only if $p \in E \setminus E_1$ and $H_1(p) = 0$, or $p \in E_1$ if and only if $p \in E$ and $H_1(p) = 0$ if and only if $p \in E \cap \mathcal{V}(H_1)$, hence $E \cap \mathcal{V}(H_1) = E_A \cup E_1$. If $(1, \epsilon, \lambda \epsilon^2) \in E_A$, then

$$f((1,\epsilon,\lambda\epsilon^2),\sigma(1,\epsilon,\lambda\epsilon^2)) = f((1,\epsilon,\lambda\epsilon^2),(1,-\epsilon,0)) = a - b\epsilon^2 = 0,$$

so $a^3 = b^3$, hence the result.

(2) This holds by symmetry.

The next result follows from Max Noether's Fundamental Theorem ([5, Section 5.5]).

Lemma 4.11. Let $0 \neq F, G, H \in k[x, y, z]_3$. If $\#(\mathcal{V}(F, G)) = 9$ and $\mathcal{V}(F, G) \subset \mathcal{V}(H)$, then $H = \mu F + \nu G$ for some $\mu, \nu \in k$.

Let $S = \mathcal{A}^+(E, \sigma)$ be a 3-dimensional Calabi-Yau quantum polynomial algebra such that $|\sigma| = 2$, and $0 \neq f \in Z(S)_2$. Recall that $g^2 \in Z(S)_2$ for every $g \in S_1$ by Proposition 4.3 (1) so that the point variety $E_{S/(g^2)} \subset \mathbb{P}^2$ of $S/(g^2)$ is well-defined by Proposition 4.5. We define

$$L_f := \{g \in S_1 \mid E_{S/(g^2)} = E_{S/(f)}\} / \sim .$$

If $g^2 \sim f$, then $E_{S/(g^2)} = E_{S/(f)}$, so $K_f \subset L_f$, hence $\#(K_f) \le \#(L_f)$.

Proposition 4.12. Let $S = \mathcal{A}^+(E, \sigma)$ be a 3-dimensional Sklyanin algebra, $0 \neq f = ax^2 + by^2 + cz^2 \in Z(S)_2$ such that $a^3 \neq b^3$ or $a^3 \neq c^3$, and A = S/(f). If $\#(E_A) = 6$, then $K_f = L_f$ so that $\#(K_f) = \#(L_f)$.

Proof. It is enough to show that $L_f \subset K_f$. Suppose that $a^3 \neq b^3$. Since $\#(E_A) = 6$,

$$\#(\mathcal{V}(F,H_1)) = \#(E \cap \mathcal{V}(H_1)) = \#(E_A \sqcup E_1) = \#(E_A) + \#(E_1) = 9$$

where $F = \lambda(x^3 + y^3 + z^3) - (\lambda^3 + 2)xyz \in k[x, y, z]_3$ and

$$H_1 = ax(\lambda y^2 - xz) + by(\lambda x^2 - yz) + cz(z^2 - \lambda^2 xy) \in k[x, y, z]_3$$

by Lemma 4.10. Let $g \in L_f$, $g^2 = a'x^2 + b'y^2 + c'z^2 \in Z(S)_2$, and

$$H'_{1} = a'x(\lambda y^{2} - xz) + b'y(\lambda x^{2} - yz) + c'z(z^{2} - \lambda^{2}xy) \in k[x, y, z]_{3}.$$

Since $E_{S/(q^2)} = E_{S/(f)} = E_A$,

$$\mathcal{V}(F,H_1) = E \cap \mathcal{V}(H_1) = E_A \cup E_1 = E_{S/(g^2)} \cup E_1 = E \cap \mathcal{V}(H_1') \subset \mathcal{V}(H_1')$$

by Lemma 4.10, so $H'_1 = \mu F + \nu H_1$ for some $\mu, \nu \in k$ by Lemma 4.11. Comparing the coefficients of x^3 in both sides, we can see that $\mu = 0$, so $H'_1 = \nu H_1$. It follows that $g^2 = \nu f \sim f$, so $g \in K_f$.

By symmetry, the result holds for the case that $a^3 \neq c^3$.

Theorem 4.13. If S is a 3-dimensional Sklyanin algebra, $0 \neq f \in Z(S)_2$, and A = S/(f), then exactly one of the following holds:

- (1) $\#(E_A) = 2$ and $\#(E_{A^!}) = 2$.
- (2) $\#(E_A) = 4$ and $\#(E_{A^!}) = 3$.
- (3) $\#(E_A) = 6$ and $\#(E_{A!}) = 4$.

Proof. By Lemma 4.4, and Proposition 4.5, $E_A = (E \cap \mathcal{V}(g)) \cup \sigma(E \cap \mathcal{V}(g))$ for some $q \in S_1$. Since $\sigma(p) \neq p$ for every $p \in E$, either

- (1) $E_A = \{p, \sigma(p)\},\$
- (2) $E_A = \{p, q, \sigma(p), \sigma(q)\}, \text{ or }$
- (3) $E_A = \{p, q, r, \sigma(p), \sigma(q), \sigma(r)\}$

for some distinct points $p, q, r \in E$. Since $\#(E_{A^{!}}) = \#(K_{f})$ by Proposition 4.3, we will compute $\#(K_f)$ in each case. We use the following geometric properties.

- For every $0 \neq g \in S_1$, $0 \neq g^2 \in Z(S)_2$ by Proposition 4.3 (1), so $\#(K_{q^2}) \ge 2$ by Lemma 4.9.
- For $g \in L_f$, $E_{S/(g^2)} = (E \cap \mathcal{V}(g)) \cup \sigma(E \cap \mathcal{V}(g)) = E_A$ by Lemma 4.4, so

 $\#(E_A)/2 \le \#(E \cap \mathcal{V}(g)) \le \max\{\#(E_A), 3\}$

by Bezout's Theorem.

- For $0 \neq g \in S_1$, $\#(E \cap \mathcal{V}(g)) = 1, 2$ if and only if $\mathcal{V}(g)$ is a tangent line at some point of E.
- For $0 \neq g, g' \in S_1, g \sim g'$ if and only if $\mathcal{V}(g) = \mathcal{V}(g')$ if and only if $E \cap \mathcal{V}(g) = E \cap \mathcal{V}(g').$

(1) Suppose that $E_A = \{p, \sigma(p)\}$ so that $\#(E \cap \mathcal{V}(g)) = 1, 2$ for every $g \in L_f$. Since $\mathcal{V}(g)$ is a tangent line at p or at $\sigma(p)$ (but not at both points), $\#(K_f) \leq 2$. By Lemma 4.9, $\#(K_f) = 2$.

(2) Suppose that $E_A = \{p, q, \sigma(p), \sigma(q)\}$ so that $\#(E \cap \mathcal{V}(g)) = 2, 3$ for every $g \in L_f$. By geometry, it is easy to see that there exists $g_1 \in L_f$ such that $\#(E \cap \mathcal{V}(g_1)) = 2$ so that $\mathcal{V}(g_1)$ is a tangent line at some point of E. Without loss of generality, we may assume that $\mathcal{V}(g_1)$ is a tangent line at p and $E \cap \mathcal{V}(q_1) = \{p, q\}$ so that 2p + q = 0. Since $2\sigma(p) + q = 2p + q = 0$, there exists $g_2 \in L_f$ such that $E \cap \mathcal{V}(g_2) = \{\sigma(p), q\}$ ($\mathcal{V}(g_2)$ is a tangent line at $\sigma(p)$). Since $p + \sigma(p) + \sigma(q) = 2p + q = 0$, there exists $g_3 \in L_f$ such that

 $E \cap \mathcal{V}(g) = \{p, \sigma(p), \sigma(q)\}$. By geometry, it is easy to see that there is no other possible $g \in L_f$, so $\#(K_f) \leq \#(L_f) = 3$. By Lemma 4.9, $\#(K_{g_i^2}) \geq 2$ for i = 1, 2, 3, so, for every *i*, there exists $j \neq i$ such that $g_i^2 \sim g_j^2$. It follows that $g_1^2 \sim g_2^2 \sim g_3^2 \sim f$, so $\#(K_f) = 3$. (3) Let $f = ax^2 + by^2 + cz^2 \in Z(S)_3$. If $a^3 = b^3 = c^3$, then $\#(K_f) = 4$ by

(3) Let $f = ax^2 + by^2 + cz^2 \in Z(S)_3$. If $a^3 = b^3 = c^3$, then $\#(K_f) = 4$ by Lemma 4.7, so we will assume that either $a^3 \neq b^3$ or $a^3 \neq c^3$. Suppose that $E_A = \{p, q, r, \sigma(p), \sigma(q), \sigma(r)\}$ so that $\#(E \cap \mathcal{V}(g)) = 3$ for every $g \in L_f$. Without loss of generality, we may assume that there exists $g_1 \in L_f$ such that $E \cap \mathcal{V}(g_1) = \{p, q, r\}$ so that p + q + r = 0. Since

$$p + \sigma(p) + \sigma(q) = \sigma(p) + q + \sigma(r) = \sigma(p) + \sigma(q) + r = 0,$$

there exist $g_2, g_3, g_4 \in L_f$ such that

$$E \cap \mathcal{V}(g_2) = \{p, \sigma(q), \sigma(r)\},\$$

$$E \cap \mathcal{V}(g_3) = \{\sigma(p), q, \sigma(r)\},\$$

$$E \cap \mathcal{V}(g_4) = \{\sigma(p), \sigma(q), r\},\$$

so $\#(K_f) = \#(L_f) \ge 4$ by Proposition 4.12. By Proposition 4.3, $\#(K_f) = 4$.

Theorem 4.14. Let $S = \mathcal{A}^+(E, \sigma)$, $S' = \mathcal{A}^+(E', \sigma')$ be 3-dimensional Calabi-Yau quantum polynomial algebras, $0 \neq f \in Z(S)_2, 0 \neq f' \in Z(S')_2$, and A = S/(f), A' = S'/(f').

- (1) If |σ|, |σ'| ≠ 2, then the following are equivalent:
 (a) A ≅ A'.
 - (b) $\operatorname{grmod} A \cong \operatorname{grmod} A'$.
 - (c) $E_A \cong E_{A'}$ (as schemes).
 - (d) $E_{A'} \cong E_{A''}$ (as varieties).
 - (e) $C(A) \cong C(A')$.

Moreover, we have the following table:

- (2) If $|\sigma| = |\sigma'| = 2$, then the following are equivalent:
 - (a) $E_A \cong E_{A'}$ (as varieties).
 - (b) $E_{A^!} \cong E_{A'^!}$ (as schemes).
 - (c) $C(A) \cong C(A')$.

In Table 4, if $\#(E_A) = \infty$, then E_A is a line.

Proof. (1) If $|\sigma|, |\sigma'| \neq 2$, then A, A' are commutative conics by Corollary 3.8 so that $E_A = \operatorname{Proj} A$ by Lemma 2.5, so it is well-known that (a) \Leftrightarrow (b) \Leftrightarrow (c). It is easy to show Table 3 by direct calculations.

(2) If $|\sigma| = 2$, then A[!] and C(A) are commutative by Corollary 3.8, so $\operatorname{Spec} C(A) \cong \operatorname{Proj} A^! = E_{A^!}$ by Lemma 2.5. It follows that $E_{A^!} \cong E_{A^{\prime !}}$ (as schemes) if and only if $C(A) \cong C(A')$.

We can show Table 4 by direct calculations except for Type EC (see Example 4.6 for the calculations of E_A , and see [9, Theorem 4.8] for calculations of C(A)). Suppose that S is of Type EC. If $\#(E_A) = 4, 6$, then Table 4 follows from Proposition 4.3, Theorem 4.13 and [9, Corollary 4.10]. If $\#(E_A) = 2$, then, by the proof of Theorem 4.13, we may assume that $E_A = \{p, \sigma(p)\}$ and there exists $g \in S_1$ such that $g^2 \sim f$ and $\mathcal{V}(g)$ is a tangent line at p to E not passing through $\sigma(p)$ so that $p \in E[3]$. Since $p \in E[3] = \{(0, 1, -\epsilon), (-\epsilon, 0, 1), (1, -\epsilon, 0) | \epsilon^3 = 1\}, g \text{ is one of the following}$ $\epsilon(\lambda^3+2)x+3\lambda y+3\epsilon^2\lambda z, 3\epsilon^2\lambda x+\epsilon(\lambda^3+2)y+3\lambda z, 3\lambda x+3\epsilon^2\lambda y+\epsilon(\lambda^3+2)z, 3\lambda x+2\lambda y+\epsilon(\lambda^3+2)z, 3\lambda x+2\lambda x+\epsilon(\lambda^3+2)z, 3\lambda x+\epsilon(\lambda^3+2)z, 3\lambda$

so g^2 associates to one of the following

$$\frac{(4-\lambda^3)}{3\lambda^2}x^2 + \epsilon y^2 + \epsilon^2 z^2, \\ \epsilon^2 x^2 + \frac{(4-\lambda^3)}{3\lambda^2}y^2 + \epsilon z^2, \\ \epsilon x^2 + \epsilon^2 y^2 + \frac{(4-\lambda^3)}{3\lambda^2}z^2 + \epsilon z^2 + \frac{(4-\lambda^3)}{3\lambda^2}z^2 +$$

by direct calculations. By [9, Lemma 4.4, Theorem 4.5],

$$A = S/(f) = S/(g^2) \cong S/((4 - \lambda^3)x^2 + 3\lambda^2y^2 + 3\lambda^2z^2).$$

Since $\lambda^3 \neq 0, 1, -8$, we can show that $((4 - \lambda^3)/3\lambda^2)^3 \neq 1$, so $C(A) \cong$ $k[u]/(\varphi(u))$ where

$$\begin{split} \varphi(u) &= u^4 + \frac{3\lambda^2}{(\lambda^3 - 1)} u^3 + \frac{2(5\lambda^3 + 4)}{3\lambda^2(\lambda^3 - 1)} u^2 + \frac{4(11\lambda^3 + 16)}{27\lambda^3(\lambda^3 - 1)} u + \frac{8(\lambda^3 + 2)}{27\lambda^4(\lambda^3 - 1)} \\ &= \left(u + \frac{2}{3\lambda}\right)^3 \left(u + \frac{\lambda^3 + 2}{\lambda(\lambda^3 - 1)}\right) \end{split}$$

by [9, Example 11]. Since $\lambda^3 \neq 0, 1, -8$, we can show that $\frac{2}{3\lambda} \neq \frac{\lambda^3+2}{\lambda(\lambda^3-1)}$, so $C(A) \cong k[u]/(u^3) \times k.$

Let $S = \mathcal{A}^+(E, \sigma)$ and A = S/(f) be as in Theorem 4.14 above. We describe (E_A, σ_A) together with $\cup_{g \in K_f} \mathcal{V}(g)$ in the picture below for the case that $\#(E_A) < \infty$. In the picture, E_A consists of hollow points and solid points where hollow points indicate singular points of E, and σ_A is described by arrows. Moreover, $\mathcal{V}(g)$ for $g \in K_f$ are described by dotted lines. Recall that $\#(K_f) = \#(E_{A'})$ by Proposition 4.3.



5. Classification of $\operatorname{Proj}_{\operatorname{nc}} A$.

In this section, we classify noncommutative conics $\operatorname{Proj}_{nc} A$ up to isomorphism of noncommutative schemes.

Definition 5.1 ([2]). A noncommutative scheme is a pair $X = (\text{mod } X, \mathcal{O}_X)$ consisting of an abelian category mod X and an object $\mathcal{O}_X \in \text{mod } X$. We say that two noncommutative schemes X, Y are isomorphic, denoted by $X \cong Y$, if there exists an equivalence functor $F : \text{mod } X \to \text{mod } Y$ such that $F(\mathcal{O}_X) \cong \mathcal{O}_Y$.

For a right noetherian ring R, we define the *noncommutative affine scheme* associated to R by $\operatorname{Spec}_{\operatorname{nc}} R = (\operatorname{mod} R, R)$ where $\operatorname{mod} R$ is the category of finitely generated right R-modules.

For a right noetherian connected graded algebra A, we define the *noncom*mutative projective scheme associated to A by $\operatorname{Proj}_{\operatorname{nc}} A = (\operatorname{tails} A, \mathcal{A})$ where tors A is the full subcategory of grmod A consisting of finite dimensional modules over k and tails $A := \operatorname{grmod} A/\operatorname{tors} A$ is the quotient category. Here, we denote by $\mathcal{M} \in \operatorname{tails} A$ when we view $M \in \operatorname{grmod} A$ as an object in tails A.

Let A be a right noetherian connected graded algebra. For $\mathcal{M}, \mathcal{N} \in$ tails A, we write $\operatorname{Ext}^{i}_{\mathcal{A}}(\mathcal{M}, \mathcal{N}) := \operatorname{Ext}^{i}_{\operatorname{tails} A}(\mathcal{M}, \mathcal{N})$ for the extension groups in tails A.

Lemma 5.2. For right noetherian rings R, R', $\operatorname{Spec}_{nc} R \cong \operatorname{Spec}_{nc} R'$ if and only if $R \cong R'$.

Proof. If $\operatorname{Spec}_{\operatorname{nc}} R \cong \operatorname{Spec}_{\operatorname{nc}} R'$, then there exists an equivalence functor $F : \operatorname{mod} R \to \operatorname{mod} R'$ such that $F(R) \cong R'$, so

$$R' \cong \operatorname{End}_{R'}(R') \cong \operatorname{Hom}_{R'}(F(R), F(R)) \cong \operatorname{Hom}_R(R, R) \cong \operatorname{End}_R(R) \cong R.$$

The converse is clear.

Let A, A' be noncommutative quadric hypersurfaces. Despite the notation, it is not trivial to see if $A \cong A'$ implies $C(A) \cong C(A')$ from the definition. We will show it using the notion of noncommutative schemes.

Lemma 5.3. Let A, A' be noncommutative quadric hypersurfaces.

- (1) $\operatorname{Proj}_{\operatorname{nc}} A^{!} \cong \operatorname{Proj}_{\operatorname{nc}} A^{\prime !}$ if and only if $C(A) \cong C(A^{\prime})$.
- (2) If grmod $A \cong \operatorname{grmod} A'$, then $C(A) \cong C(A')$.

Proof. (1) Since there exists an equivalence functor F: tails $A^! \to \text{mod} C(A)$ defined by $F(\mathcal{M}) = M[(f^!)^{-1}]_0$ by [16, Lemma 4,13], $F(\mathcal{A}) \cong C(A)$, so $\operatorname{Proj_{nc}} A^! \cong \operatorname{Spec_{nc}} C(A)$. It follows that $\operatorname{Proj_{nc}} A^! \cong \operatorname{Proj_{nc}} A'^!$ if and only if $\operatorname{Spec_{nc}} C(A) \cong \operatorname{Spec_{nc}} C(A')$ if and only if $C(A) \cong C(A')$ by Lemma 5.2. (2) By [14, Lemma 4.1] and (1),

$$\operatorname{grmod} A \cong \operatorname{grmod} A' \Leftrightarrow \operatorname{grmod} A^! \cong \operatorname{grmod} A'^!$$
$$\Rightarrow \operatorname{Proj_{nc}} A^! \cong \operatorname{Proj_{nc}} A'^!$$
$$\Leftrightarrow C(A) \cong C(A').$$

Definition 5.4. A connected graded algebra A is called an AS-Gorenstein algebra of dimension d and of Gorenstein parameter l if

(1) id A = d, and (2) $\operatorname{Ext}_{A}^{i}(k, A(-j)) \cong \begin{cases} k & \text{if } i = d \text{ and } j = l, \\ 0 & \text{otherwise.} \end{cases}$

Lemma 5.5. If S is a quantum polynomial algebra of dimension $d \ge 1$, and $0 \ne f \in S_m$ is a normal element, then A = S/(f) is a noetherian AS-Gorenstein algebra of dimension d - 1 and of Gorenstein parameter d - m(cf. [8, Lemma 1.2]).

Definition 5.6. Let A be a right noetherian AS-Gorenstein algebra. We say that $M \in \operatorname{grmod} A$ is maximal Cohen-Macaulay if $\operatorname{Ext}_A^i(M, A(j)) = 0$ for all $i \neq 0$ and all $j \in \mathbb{Z}$. We denote by

- (1) $CM^{\mathbb{Z}}(A)$ the full subcategory of grmod A consisting of maximal Cohen-Macaulay graded right A-modules,
- (2) $\operatorname{CM}^{0}(A) := \{ M \in \operatorname{CM}^{\mathbb{Z}}(A) \mid M = M_{0}A \}$ the full subcategory of $\operatorname{CM}^{\mathbb{Z}}(A)$, and
- (3) $\underline{CM}^{\mathbb{Z}}(A)$ the stable category of $CM^{\mathbb{Z}}(A)$ by projectives.

For a noncommutative conic A, we have a complete classification of C(A) up to isomorphism by Theorem 4.14, so the following theorem gives a complete classification of $\underline{CM}^{\mathbb{Z}}(A)$ up to equivalence.

Theorem 5.7. Let S, S' be 3-dimensional Calabi-Yau quantum polynomial algebras, $0 \neq f \in Z(S)_2, 0 \neq f' \in Z(S')_2$, and A = S/(f), A' = S'/(f'). Then the following are equivalent:

- (1) $\underline{CM}^{\mathbb{Z}}(A) \cong \underline{CM}^{\mathbb{Z}}(A').$
- (2) $\mathscr{D}^b(\operatorname{mod} C(A)) \cong \mathscr{D}^b(\operatorname{mod} C(A')).$
- (3) $C(A) \cong C(A')$.

Proof. By Theorem 1.5, (1) ⇔ (2), and clearly, (3) ⇒ (2), so it is enough to show (2) ⇒ (3). Suppose that $\mathscr{D}^b(\text{mod }C(A)) \cong \mathscr{D}^b(\text{mod }C(A'))$. By [19, Proposition 9.2], $Z(C(A)) \cong Z(C(A'))$. Moreover, C(A) is semisimple if and only if C(A') is semisimple, so we may assume one of the following two cases, namely, both C(A) and C(A') are semisimple $(M_2(k) \text{ or } k^4)$, or both C(A)and C(A') are non semisimple. By the classification of Theorem 4.14, we can show in either case that $Z(C(A)) \cong Z(C(A'))$ implies $C(A) \cong C(A')$ (Most of C(A) are commutative, so it is enough to calculate $Z(k_{-1}[u, v]/(u^2, v^2)) \cong$ $k[t]/(t^2)$ and $Z(k_{-1}[u, v]/(u^2, v^2 - 1)) \cong k!!$, so the result follows. □

Definition 5.8. Let \mathscr{T} be a triangulated category. A strictly full triangulated subcategory \mathscr{E} of \mathscr{T} is called *admissible* if the embedding functor $\mathscr{E} \to \mathscr{T}$ has both a left adjoint functor $\mathscr{T} \to \mathscr{E}$ and a right adjoint functor $\mathscr{T} \to \mathscr{E}$.

A semi-orthogonal decomposition of \mathscr{T} is a sequence $\{\mathscr{E}_0, \dots, \mathscr{E}_{l-1}\}$ of strictly full admissible triangulated subcategories such that

- (1) for all $0 \le i < j \le l-1$ and all objects $E_i \in \mathscr{E}_i, E_j \in \mathscr{E}_j$, one has $\operatorname{Hom}_{\mathscr{T}}(E_j, E_i) = 0$, and
- (2) the smallest strictly full triangulated subcategory of \mathscr{T} containing $\mathscr{E}_0, \dots, \mathscr{E}_{l-1}$ coincides with \mathscr{T} .

We use the notation $\mathscr{T} = \langle \mathscr{E}_0, \cdots, \mathscr{E}_{l-1} \rangle$ for a semi-orthogonal decomposition of \mathscr{T} with components $\mathscr{E}_0, \cdots, \mathscr{E}_{l-1}$.

Theorem 5.9 ([3, Theorem 4.4.1],[17, Theorem 2.5]). Let A be a right noetherian AS-Gorenstein algebra of Gorenstein parameter l. If l > 0, then there exists a fully faithful functor $\Phi : \underline{CM}^{\mathbb{Z}}(A) \to \mathscr{D}^{b}(\text{tails } A)$ and a semiorthogonal decomposition

 $\mathscr{D}^{b}(\text{tails } A) = \langle \mathcal{A}(-l+1), \cdots, \mathcal{A}(-1), \mathcal{A}, \Phi \underline{\mathrm{CM}}^{\mathbb{Z}}(A) \rangle$

where $\mathcal{A}(i)$ denotes the full triangulated subcategory generated by the object $\mathcal{A}(i)$ by abuse of notation.

Theorem 5.10. Let S, S' be 3-dimensional Calabi-Yau quantum polynomial algebras, $0 \neq f \in Z(S)_2, 0 \neq f' \in Z(S')_2$, and A = S/(f), A' = S'/(f'). If $\operatorname{Proj_{nc}} A \cong \operatorname{Proj_{nc}} A'$, then $C(A) \cong C(A')$.

Proof. Since A is a noetherian AS-Gorenstein algebra of Gorenstein parameter 1 by Lemma 5.5, there exists a fully faithful functor $\Phi : \underline{CM}^{\mathbb{Z}}(A) \to \mathscr{D}^{b}(\text{tails } A)$ such that $\mathscr{D}^{b}(\text{tails } A) = \langle \mathcal{A}, \Phi \underline{CM}^{\mathbb{Z}}(A) \rangle$ is a semi-orthogonal decomposition by Theorem 5.9, so

 $\underline{\mathrm{CM}}^{\mathbb{Z}}(A) \cong {}^{\perp}\langle \mathcal{A} \rangle := \{ \mathcal{X} \in \mathscr{D}^b(\mathrm{tails}\,A) \mid \mathrm{Hom}_{\mathcal{A}}(\mathcal{X}, \mathcal{A}) = 0 \}$

by [17, Lemma 1.4]. Since $\operatorname{Proj}_{\operatorname{nc}} A \cong \operatorname{Proj}_{\operatorname{nc}} A'$, there exists an equivalence functor $F : \mathscr{D}^b(\operatorname{tails} A) \to \mathscr{D}^b(\operatorname{tails} A')$ such that $F(\mathcal{A}) \cong \mathcal{A}'$. It follows that $\mathscr{D}^b(\operatorname{mod} C(A)) \cong \operatorname{\underline{CM}}^{\mathbb{Z}}(A) \cong {}^{\perp}\langle \mathcal{A} \rangle \cong {}^{\perp}\langle \mathcal{A}' \rangle \cong \operatorname{\underline{CM}}^{\mathbb{Z}}(A') \cong \mathscr{D}^b(\operatorname{mod} C(A')),$

so $C(A) \cong C(A')$ by Theorem 5.7.

Theorem 5.11. There are exactly 9 isomorphism classes of homogeneous coordinate algebras A of noncommutative conics, and there are exactly 9 isomorphism classes of noncommutative conics $\operatorname{Proj}_{nc} A$.

Proof. If A and A' are homogeneous coordinate algebras of noncommutative conics, then

$$A \cong A' \Rightarrow \operatorname{Proj}_{\operatorname{nc}} A \cong \operatorname{Proj}_{\operatorname{nc}} A' \Rightarrow C(A) \cong C(A')$$

by Theorem 5.10. Since there are at most 9 isomorphism classes of A by Corollary 3.9, and there are exactly 9 isomorphism classes of C(A) by Theorem 4.14, the result follows.

For the rest of the paper, we study "smooth" noncommutative conics. The global dimension of tails A is defined by

gldim(tails A) := sup{ $i \mid \operatorname{Ext}_{A}^{i}(\mathcal{M}, \mathcal{N}) \neq 0$ for some $\mathcal{M}, \mathcal{N} \in \operatorname{tails} A$ }.

Definition 5.12. A noetherian connected graded algebra A is called a *non-commutative graded isolated singularity* if tails A has finite global dimension.

We may define that $\operatorname{Proj}_{nc} A$ is "smooth" if A is a noncommutative graded isolated singularity.

For an additive category \mathscr{C} , we denote by Ind \mathscr{C} the set of isomorphism classes of indecomposable objects.

Lemma 5.13. Let S be a quantum polynomial algebra, $f \in S_2$ a regular normal element, and A = S/(f). Suppose that X = A/gA for some $g \in K_f$.

- (1) $X \in \operatorname{Ind} \operatorname{CM}^0(A)$.
- (2) $\operatorname{Hom}_A(X, A(i)) = 0$ for every $i \leq 0$.

Proof. (1) If $g^2 = f$, then

$$\cdots \xrightarrow{g_{\cdot}} A(-2) \xrightarrow{g_{\cdot}} A(-1) \xrightarrow{g_{\cdot}} A \xrightarrow{g_{\cdot}} A(1) \xrightarrow{g_{\cdot}} \cdots$$

is a complete resolution of X, so $X \in \text{Ind CM}^0(A)$ (cf. [15, Lemma 5.7, Remark 5.5]).

(2) The exact sequence

$$A(-1) \xrightarrow{g} A \longrightarrow X \longrightarrow 0$$

induces an exact sequence

$$0 \longrightarrow \operatorname{Hom}_A(X, A(i)) \longrightarrow A_i \xrightarrow{\cdot g} A_{i+1},$$

so $\operatorname{Hom}_A(X, A(i)) = 0$ for every $i \leq 0$.

Definition 5.14. Let ${\mathscr T}$ be a k-linear triangulated category.

(1) An object E of \mathscr{T} is exceptional if $\operatorname{End}_{\mathscr{T}}(E) = k$ and $\operatorname{Hom}_{\mathscr{T}}(E, E[q]) = 0$ for every $q \neq 0$.

- (2) A sequence of objects $\{E_0, \dots, E_{l-1}\}$ in \mathscr{T} is an exceptional sequence if E_i is an exceptional object for every $i = 0, \dots, l-1$, and $\operatorname{Hom}_{\mathscr{T}}(E_i, E_i[q]) = 0$ for every q and every $0 \le i < j \le l-1$.
- (3) An exceptional sequence $\{E_0, \dots, E_{l-1}\}$ in \mathscr{T} is *full* if the smallest strictly full triangulated subcategory of \mathscr{T} containing E_0, \dots, E_{l-1} is equal to \mathscr{T} .
- (4) An exceptional sequence $\{E_0, \dots, E_{l-1}\}$ in \mathscr{T} is strong if $\operatorname{Hom}_{\mathscr{T}}(U, U[q]) = 0$ for every $q \neq 0$ where $U = E_0 \oplus \dots \oplus E_{l-1}$.

Let $k\widetilde{A_1}$ be the path algebra of the quiver

$$1 \Longrightarrow 2$$
 (A_1 type),

and let $k\widetilde{D_4}$ be the path algebra of the quiver



Theorem 5.15. Let S be a 3-dimensional Calabi-Yau quantum polynomial algebra, $0 \neq f \in Z(S)_2$, and A = S/(f). If A is a noncommutative graded isolated singularity, then exactly one of the following holds:

- (1) The following are equivalent:
 - (1-a) $C(A) \cong M_2(k)$.
 - (1-b) $E_A \subset \mathbb{P}^2$ is a smooth conic.
 - (1-c) $E_{A!} = \emptyset$.
 - (1-d) A is commutative.
 - (1-e) f is irreducible.
 - (1-f) $\mathscr{D}^b(\text{tails } A) \cong \mathscr{D}^b(\text{mod } k\widetilde{A_1}).$
- (2) The following are equivalent:
 - (2-a) $C(A) \cong k^4$.
 - (2-b) $\#(E_A) = 6.$
 - (2-c) $\#(E_{A!}) = 4.$
 - (2-d) A is not commutative.
 - (2-e) f is reducible.
 - (2-f) $\mathscr{D}^b(\operatorname{tails} A) \cong \mathscr{D}^b(\operatorname{mod} k\widetilde{D_4}).$

Proof. Since A is a noncommutative graded isolated singularity, C(A) is a 4-dimensional semi-simple algebra by [20, Theorem 5.6], so either $C(A) \cong M_2(k)$, or $C(A) \cong k^4$.

By Theorem 4.14, (1-a) \Leftrightarrow (1-b) \Leftrightarrow (1-c) \Leftrightarrow (1-d) \Leftrightarrow (1-e), and (2-a) \Leftrightarrow (2-b) \Leftrightarrow (2-c) \Leftrightarrow (2-d) \Leftrightarrow (2-e).

Since $\mathscr{D}^b(\operatorname{mod} k\widetilde{A_1}) \ncong \mathscr{D}^b(\operatorname{mod} k\widetilde{D_4})$, it is enough to show that (1-a) \Rightarrow (1-f) and (2-a) \Rightarrow (2-f).

(1-a) \Rightarrow (1-f): If $C(A) \cong M_2(k)$, then $A \cong k[x, y, z]/(x^2 + y^2 + z^2)$ by Theorem 4.14, so $\mathscr{D}^b(\text{tails } A) \cong \mathscr{D}^b(\text{mod } k\widetilde{A}_1)$ by [21, Example 3.23 (1)].

 $(2\text{-a}) \Rightarrow (2\text{-f})$: If $C(A) \cong k^4$, then $\#(K_f) = 4$ so that $K_f = \{g_1, g_2, g_3, g_4\}$ by Theorem 4.14, so $\operatorname{Ind} \underline{CM}^0(A) \supset \{X_1, X_2, X_3, X_4\}$ where $X_i := A/g_i A$ by Lemma 5.13. Since $\underline{CM}^0(A) \cong \operatorname{mod} C(A) \cong \operatorname{mod} k^4$ by [16, Lemma 4.13], $\operatorname{Ind} \underline{CM}^0(A) = \{X_1, X_2, X_3, X_4\}$. Since $\underline{CM}^{\mathbb{Z}}(A) \cong \mathscr{D}^b(\operatorname{mod} C(A))$ by [16, Lemma 4.13], $\{X_1, X_2, X_3, X_4\}$ is a full exceptional sequence for $\underline{CM}^{\mathbb{Z}}(A)$. Since there exists a fully faithful functor $\Phi : \underline{CM}^{\mathbb{Z}}(A) \to \mathscr{D}^b(\operatorname{tails} A)$ such that $\mathscr{D}^b(\operatorname{tails} A) = \langle A, \Phi \underline{CM}^{\mathbb{Z}}(A) \rangle$ is a semi-orthogonal decomposition by Theorem 5.9 and $\Phi(X_i) = \mathcal{X}_i$ by Lemma 5.13 and [21, Lemma 2.6], we see that $\{\mathcal{A}, \mathcal{X}_1, \mathcal{X}_2, \mathcal{X}_3, \mathcal{X}_4\}$ is a full exceptional sequence for $\mathscr{D}^b(\operatorname{tails} A)$.

Since A is a noetherian AS-Gorenstein algebra of dimension 2 and of Gorenstein parameter 1 by Lemma 5.5 and gldim(tails A) = 2 (cf. [21, Lemma 2.2]),

$$\operatorname{Hom}_{\mathcal{A}}(\mathcal{A}, \mathcal{A}) = k$$
$$\operatorname{Hom}_{\mathcal{A}}(\mathcal{X}_{i}, \mathcal{X}_{j}) = \begin{cases} k & \text{if } i = j \\ 0 & \text{if } i \neq j \end{cases}$$
$$\operatorname{Hom}_{\mathcal{A}}(\mathcal{A}, \mathcal{X}_{i}) = \operatorname{Hom}_{A}(A, X) = X_{0} = k$$
$$\operatorname{Hom}_{\mathcal{A}}(\mathcal{X}_{i}, \mathcal{A}) = \operatorname{Hom}_{A}(X, A) = 0$$

and

$$\operatorname{Ext}_{\mathcal{A}}^{1}(\mathcal{X}_{i},\mathcal{X}_{j}) = 0$$

$$\operatorname{Ext}_{\mathcal{A}}^{1}(\mathcal{A},\mathcal{X}) = D \operatorname{Hom}_{A}(X,A(-1)) = 0$$

$$\operatorname{Ext}_{\mathcal{A}}^{1}(\mathcal{X},\mathcal{A}) = D \operatorname{Hom}_{A}(A,X(-1)) = D(X_{-1}) = 0$$

$$\operatorname{Ext}_{\mathcal{A}}^{q}(\mathcal{X},\mathcal{Y}) = 0 \quad \text{if } q \geq 2.$$

for $\mathcal{X}, \mathcal{Y} \in \{\mathcal{A}, \mathcal{X}_1, \mathcal{X}_2, \mathcal{X}_3, \mathcal{X}_4\}$ by [21, Lemma 2.3] and Lemma 5.13. It follows that $\{\mathcal{A}, \mathcal{X}_1, \mathcal{X}_2, \mathcal{X}_3, \mathcal{X}_4\}$ is a full strong exceptional sequence for $\mathscr{D}^b(\text{tails } A)$, and

$$\operatorname{End}_{\mathcal{A}}(\mathcal{A} \oplus \mathcal{X}_1 \oplus \mathcal{X}_2 \oplus \mathcal{X}_3 \oplus \mathcal{X}_4) \cong kD_4,$$

so $\mathscr{D}^b(\text{tails } A) \cong \mathscr{D}^b(\text{mod } k\widetilde{D_4})$
