# Extensive entropy from unitary evolution

#### Abstract

In quantum many-body systems, a Hamiltonian is called an "extensive entropy generator" if starting from a random product state the entanglement entropy obeys a volume law at long times with overwhelming probability. We prove that (i) any Hamiltonian whose spectrum has non-degenerate gaps is an extensive entropy generator; (ii) in the space of (geometrically) local Hamiltonians, the non-degenerate gap condition is satisfied almost everywhere. Specializing to many-body localized systems, these results imply the observation stated in the title of Bardarson et al. [PRL [1](#page-0-0)09, 017202 (2012)].<sup>1</sup>

## 1 Introduction

Entropy is a fundamental concept in thermodynamics and statistical mechanics. In textbooks and introductory courses, we learned that entropy is an extensive quantity:

Initializing a system in a low entropy state, generically (although not always) the entropy will grow with time and eventually become proportional to the system size.

The main contribution of this paper is to provide a mathematical characterization of this statement in quantum many-body systems. Our rigorous results not only show how extensive entropy emerges from the unitary evolution under a (geometrically) local Hamiltonian, but also demonstrate the genericness of extensive entropy.

Suppose an isolated quantum spin system is initialized in a pure state. Under unitary evolution the system stays in a pure state and hence its entropy is always zero. To observe

non-trivial entropy dynamics, we divide the system into two parts A and B. Assume without loss of generality that subsystem  $A$  is smaller than or equal to half the system size. We view B as a bath of A and consider the entropy of A. This entropy is called entanglement entropy, and extensive subsystem entropy is also known as a volume law for entanglement. The most general unentangled state with zero entropy for all subsystems is a random product state, where each spin is chosen independently and uniformly at random on the Bloch sphere.

Our main result is the following. A Hamiltonian is called an "extensive entropy generator" if starting from a random product state the entanglement entropy obeys a volume law at long times with overwhelming probability. We prove that (i) any Hamiltonian whose spectrum has non-degenerate gaps is an extensive entropy generator; (ii) in the space of Hamiltonians with short-range interactions, the non-degenerate gap condition is satisfied almost everywhere.

As a byproduct, we solve a mathematical problem in many-body localization. It is well known that in one-dimensional Anderson localized systems, starting from a random product state the entanglement entropy remains bounded at all times [\[1\]](#page-11-0). However, upon adding a generic local perturbation the system becomes many-body localized (MBL), and unbounded growth of entanglement was observed numerically [\[20,](#page-12-1) [4,](#page-12-0) [12\]](#page-12-2) and then explained heuristically [\[18,](#page-12-3) [15,](#page-12-4) [8\]](#page-12-5). We prove this observation.

### 2 Preliminaries

Throughout this paper, standard asymptotic notations are used extensively. Let  $f, g : \mathbb{R}^+ \to$  $\mathbb{R}^+$  be two functions. One writes  $f(x) = O(g(x))$  if and only if there exist constants  $M, x_0 > 0$ such that  $f(x) \leq Mg(x)$  for all  $x > x_0$ ;  $f(x) = \Omega(g(x))$  if and only if there exist constants  $M, x_0 > 0$  such that  $f(x) \geq Mg(x)$  for all  $x > x_0$ .

Definition 1 (entanglement entropy). The entanglement entropy of a bipartite pure state  $\rho_{AB}$  is defined as the von Neumann entropy

$$
S(\rho_A) := -\operatorname{tr}(\rho_A \ln \rho_A) \tag{1}
$$

of the reduced density matrix  $\rho_A = \text{tr}_B \rho_{AB}$ .

Consider a system of N spins or qudits with local dimension d so that the dimension of the total Hilbert space is  $d^N$ .

<span id="page-1-0"></span>**Definition 2** (Haar-random product state). Let  $|\Psi\rangle = \bigotimes_{j=1}^{N} |\Psi_j\rangle$  be a Haar-random product state, where each  $|\Psi_j\rangle$  is chosen independently and uniformly at random with respect to the Haar measure.

Definition 3 (non-degenerate spectrum). The spectrum of a Hamiltonian is non-degenerate if all eigenvalues are distinct.

<span id="page-1-1"></span>**Definition 4** (non-degenerate gaps). The spectrum  $\{E_j\}$  of a Hamiltonian has non-degenerate gaps if the differences  $\{E_j - E_k\}_{j \neq k}$  are all distinct, i.e., for any  $j \neq k$ ,

<span id="page-1-2"></span>
$$
E_j - E_k = E_{j'} - E_{k'} \implies (j = j') \text{ and } (k = k'). \tag{2}
$$

By definition, the non-degenerate gap condition implies that the spectrum is non-degenerate.

### 3 Results

Let m, n be positive integers such that mn is a multiple of the system size N. Let  $A_1, A_2, \ldots, A_m$ be m possibly overlapping subsystems, each of which consists of exactly  $n \leq N/2$  spins. Suppose that each spin in the system is in exactly  $mn/N$  out of these m subsystems. For each j, let  $\bar{A}_j$  be the complement of  $A_j$  so that  $A_j \otimes \bar{A}_j$  defines a bipartition of the system.

<span id="page-2-0"></span>**Theorem 1.** Initialize the system in a Haar-random product state  $|\Psi\rangle$  (Definition [2\)](#page-1-0). Let

$$
\rho_{A_j}(t) := \operatorname{tr}_{\bar{A}_j} \rho(t), \quad \rho(t) := e^{-iHt} |\Psi\rangle\langle\Psi| e^{iHt}
$$
\n(3)

*be the reduced density matrix of subsystem* A<sup>j</sup> *at time* t*. We consider the scenario that*

$$
n \le \frac{(1 - \epsilon)N \ln \frac{d+1}{2}}{2 \ln d},\tag{4}
$$

*where*  $\epsilon > 0$  *is an arbitrarily small constant. For any Hamiltonian H whose spectrum has non-degenerate gaps (Definition [4\)](#page-1-1),*

$$
\Pr_{\Psi} \left( \Pr_{t \in \mathbb{R}} \left( \frac{1}{m} \sum_{j=1}^{m} S(\rho_{A_j}(t)) \ge (1 - \epsilon) n \sum_{k=2}^{d} \frac{1}{k} \right) = 1 - e^{-\Omega(N)} \right) = 1 - e^{-\Omega(N)}.
$$
 (5)

There is no underlying lattice structure in the statement of Theorem [1.](#page-2-0) From now on we focus on quantum lattice systems, which are of particular interest. Without loss of generality, we consider a chain of N spins. It is straightforward to extend Corollary [1](#page-2-1) below to higher spatial dimensions.

Let A be a contiguous region of n spins, and A be the rest of the system. Let  $\mathbb{E}_{|A|=n}$  denote averaging over all contiguous subsystems of size  $n$ . With periodic boundary conditions, there are N such subsystems.

<span id="page-2-1"></span>**Corollary 1.** *Initialize the system in a Haar-random product state*  $|\Psi\rangle$ *. Let* 

$$
\rho_A(t) := \text{tr}_{\bar{A}} \rho(t), \quad \rho(t) := e^{-iHt} |\Psi\rangle\langle\Psi| e^{iHt}
$$
\n(6)

*be the reduced density matrix of subsystem* A *at time* t*. We consider the scenario that*

$$
\frac{(1-\epsilon)N\ln\frac{d+1}{2}}{2\ln d} < n \le N/2,\tag{7}
$$

where  $\epsilon > 0$  *is an arbitrarily small constant. For any (not necessarily local) Hamiltonian* H *whose spectrum has non-degenerate gaps,*

$$
\Pr_{\Psi} \left( \Pr_{t \in \mathbb{R}} \left( \mathop{\mathbb{E}}_{|A|=n} S\left(\rho_A(t)\right) \ge \left(\frac{1}{2} - \epsilon\right) \frac{N \ln \frac{d+1}{2}}{\ln d} \sum_{k=2}^d \frac{1}{k} \right) = 1 - e^{-\Omega(N)} \right) = 1 - e^{-\Omega(N)}. \tag{8}
$$

*Proof.* The weak monotonicity [\[10\]](#page-12-6) of the von Neumann entropy implies that

$$
\mathop{\mathbb{E}}_{|A|=n} S(\rho_A(t)) \leq \mathop{\mathbb{E}}_{|A|=n+1} S(\rho_A(t)) \tag{9}
$$

 $\Box$ 

for any  $n \langle N/2$ . Corollary [1](#page-2-1) follows from this inequality and Theorem [1.](#page-2-0)

To demonstrate the genericness of non-degenerate gaps, we define ensembles of Hamiltonians with nearest-neighbor interactions in a chain of N spin-1/2's or qubits  $(d = 2)$ . We prove that in each ensemble, the set of Hamiltonians whose spectrum has degenerate gaps is of measure zero (Theorem [2\)](#page-3-0). Similar results can be proved in a similar way for other types of systems including qudit systems with short-range interactions in higher spatial dimensions or even with non-local interactions (Appendix [C\)](#page-9-0).

The non-degenerate gap condition [\(2\)](#page-1-2) was assumed in many previous works [\[13,](#page-12-7) [11,](#page-12-8) [16,](#page-12-9) [17,](#page-12-10) [14,](#page-12-11) [6,](#page-12-12) [19\]](#page-12-13) on the equilibration of quantum systems. Both Theorem [1](#page-2-0) and the results of these works apply to almost every Hamiltonian in each ensemble we define.

Let

$$
\hat{\sigma}_j^x = \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}, \quad \hat{\sigma}_j^y = \begin{pmatrix} 0 & -i \\ i & 0 \end{pmatrix}, \quad \hat{\sigma}_j^z = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}
$$
(10)

be the Pauli matrices for the spin- $1/2$  at position j, and

$$
J := (J_k|_{k \in \{x,y,z\}}, J_{kl}|_{k,l \in \{x,y,z\}}) = (J_x, J_y, J_z, J_{xx}, J_{xy}, J_{xz}, J_{yy}, J_{yz}, J_{zx}, J_{zy}, J_{zz}), \tag{11}
$$

$$
\alpha := (\alpha_j^k |_{1 \le j \le N}^{k \in \{x, y, z\}}, \alpha_j^k |_{1 \le j \le N-1}^{k, l \in \{x, y, z\}}), \quad R := (0, 1] \times [0, 1] \times (0, 1] \times [0, 1]^{1/8} \times (0, 1] \subset \mathbb{R}^{12}.
$$
 (12)

Each particular J defines an ensemble of Hamiltonians

$$
H_J := \{ H_J(\alpha) : \alpha \in [-1, 1]^{\times (12N - 9)} \},
$$
\n(13)

$$
H_J(\alpha) := \sum_{j=1}^N \sum_{k \in \{x, y, z\}} J_k \alpha_j^k \hat{\sigma}_j^k + \sum_{j=1}^{N-1} \sum_{k,l \in \{x, y, z\}} J_{kl} \alpha_j^{kl} \hat{\sigma}_j^k \hat{\sigma}_{j+1}^l.
$$
 (14)

Note that  $J \in R$  implies  $J_x, J_z, J_{zz} > 0$ . This rules out the possibility that  $H_J$  is an ensemble of free-fermion Hamiltonians.

<span id="page-3-0"></span>**Theorem 2.** For any  $J \in R$ , the set of all  $\alpha$  such that the spectrum of  $H_J(\alpha)$  has degenerate *gaps is of measure zero.*

It is an open problem to prove an analogue of this theorem for translationally invariant systems. Progress in this direction was made in Ref. [\[7\]](#page-12-14).

### 4 Many-body localization

 $H_J$  is MBL for some  $J \in R$ . In particular,  $H_J$  reduces to the Imbrie model [\[9\]](#page-12-15) when

$$
J = (\lambda, 0, 1, 0, 0, 0, 0, 0, 0, 0, 0, 1) \tag{15}
$$

with small  $\lambda > 0$ .

Other models of MBL can be considered. For example, let

$$
h := (h_x, h_z, h_{zz}), \quad \gamma := (\gamma_j^k |_{1 \le j \le N}^{k \in \{x, z\}} , \gamma_j^{zz} |_{1 \le j \le N-1}). \tag{16}
$$

Each particular  $h$  defines an ensemble of Hamiltonians

$$
H_h^{XXZ} := \{ H_h^{XXZ}(\gamma) : \gamma \in [-1, 1]^{\times (3N-1)} \},\tag{17}
$$

$$
H_h^{XXZ}(\gamma) = \sum_{j=1}^N (h_x \gamma_j^x \hat{\sigma}_j^x + h_z \gamma_j^z \hat{\sigma}_j^z) + \sum_{j=1}^{N-1} (\hat{\sigma}_j^x \hat{\sigma}_{j+1}^x + \hat{\sigma}_j^y \hat{\sigma}_{j+1}^y + h_{zz} \gamma_j^z \hat{\sigma}_j^z \hat{\sigma}_{j+1}^z). \tag{18}
$$

Note that  $H_h^{XXZ}$  is a perturbed random-field XX chain if  $h_x, h_{zz} > 0$  are small.

<span id="page-4-0"></span>**Corollary 2.** For any  $h \in (0, +\infty)^{\times 3}$ , the set of all  $\gamma$  such that the spectrum of  $H_h^{XXZ}(\gamma)$ *has degenerate gaps is of measure zero.*

The result stated in the last paragraph of the introduction follows by combining Theorem [1](#page-2-0) and Corollary [2.](#page-4-0)

Finally, we prove that the volume-law coefficient in Eq. [\(5\)](#page-2-2) is tight in a particular MBL system. Consider a chain of N qudits labeled by  $1, 2, ..., N$ . Let  $\hat{S}_j^z$  be the z component of the spin operator at position j. Let  $(h_1, h_2, \ldots, h_N) \in \mathbb{R}^N$  be such that the spectrum of

$$
H^{\rm loc} := \sum_{j=1}^{N} h_j \hat{S}_j^z \tag{19}
$$

is non-degenerate. Let  $H^{\text{mbl}} := H^{\text{loc}} + \Delta H$ , where  $\Delta H$  is an infinitesimal random local per-turbation. Appendix [C.3](#page-10-0) proves that the spectrum of  $H^{\text{mbl}}$  almost surely has non-degenerate gaps. Let  $A \subset \{1, 2, ..., N\}$  so that  $A \sqcup \overline{A}$  defines a bipartition of the system.

<span id="page-4-1"></span>**Theorem 3.** *Initialize the system in a Haar-random product state*  $|\Psi\rangle$ *. Let* 

$$
\rho_A(t) := \text{tr}_{\bar{A}} \,\rho(t), \quad \rho(t) := e^{-iH^{\text{mb1}}t} |\Psi\rangle\langle\Psi| e^{iH^{\text{mb1}}t} \tag{20}
$$

*be the reduced density matrix of subsystem* A *at time* t*. For any* A*,*

$$
\mathbb{E}_{\Psi} \lim_{\tau \to +\infty} \frac{1}{\tau} \int_0^{\tau} S(\rho_A(t)) dt \le |A| \sum_{k=2}^d \frac{1}{k}.
$$
\n(21)

# A Proof of Theorem [1](#page-2-0)

**Lemma 1.** Let  $|0\rangle$  be a particular state in  $\mathbb{C}^d$ . For a Haar-random state  $|\Psi'\rangle$ ,

$$
M_{\alpha} := \mathop{\mathbb{E}}_{\Psi'} |\langle 0 | \Psi' \rangle|^{2\alpha} = \prod_{j=1}^{d-1} \frac{j}{j+\alpha}.
$$
 (22)

*Proof.* Calculating a tedious multivariable integral, the probability density function of the random variable  $X := |\langle 0 | \Psi' \rangle|^2$  is

$$
f(x) = (d-1)(1-x)^{d-2}, \quad x \in [0,1].
$$
 (23)

Therefore,

$$
M_{\alpha} = \int_0^1 x^{\alpha} f(x) dx = \prod_{j=1}^{d-1} \frac{j}{j + \alpha}.
$$
 (24)

**Lemma 2.** Let  $|\phi\rangle$  be an arbitrary state in  $(\mathbb{C}^d)^{\otimes N}$ . For a Haar-random product state  $|\Psi\rangle$ *(Definition [2\)](#page-1-0)* and any  $\alpha \geq 1$ ,

<span id="page-5-0"></span>
$$
\mathbb{E}_{\Psi} |\langle \phi | \Psi \rangle|^{2\alpha} \le M_{\alpha}^{N}.
$$
\n(25)

*Proof.* Let  $A \otimes \overline{A}$  be a bipartition of the system, where subsystem A consists of a single spin. Let  $\{|j\rangle_A\}_{j=0}^{d-1}$  be the computational basis of subsystem A so that

$$
|\phi\rangle = \sum_{j=0}^{d-1} c_j |j\rangle_A \otimes |\phi_j\rangle_{\bar{A}}, \quad \sum_{j=0}^{d-1} |c_j|^2 = 1.
$$
 (26)

Let  $|\Psi\rangle = |\Psi_A\rangle \otimes |\Psi_{\bar{A}}\rangle$ , where  $|\Psi_A\rangle$  is a Haar-random state in  $\mathbb{C}^d$  and  $|\Psi_{\bar{A}}\rangle$  is a Haar-random product state in  $(\mathbb{C}^d)^{\otimes (N-1)}$ . It is easy to see that for any fixed  $|\Psi_{\bar{A}}\rangle$ ,

$$
\mathop{\mathbb{E}}_{\Psi_A} |\langle \phi | \Psi \rangle|^{2\alpha} = M_{\alpha} \left( \sum_{j=0}^{d-1} |c_j|^2 |\langle \phi_j | \Psi_{\bar{A}} \rangle|^2 \right)^{\alpha} \leq M_{\alpha} \sum_{j=0}^{d-1} |c_j|^2 |\langle \phi_j | \Psi_{\bar{A}} \rangle|^{2\alpha}.
$$
 (27)

Hence,

<span id="page-5-1"></span>
$$
\mathbb{E}_{\Psi} |\langle \phi | \Psi \rangle|^{2\alpha} = \mathbb{E}_{\Psi_{\bar{A}}} \mathbb{E}_{\Psi_{A}} |\langle \phi | \Psi \rangle|^{2\alpha} \le M_{\alpha} \sum_{j=0}^{d-1} |c_{j}|^{2} \mathbb{E}_{\Psi_{\bar{A}}} |\langle \phi_{j} | \Psi_{\bar{A}} \rangle|^{2\alpha} \le M_{\alpha} \max_{\phi'} \mathbb{E}_{\Psi_{\bar{A}}} |\langle \phi' | \Psi_{\bar{A}} \rangle|^{2\alpha}, (28)
$$

where  $|\phi'\rangle$  is a state in  $(\mathbb{C}^d)^{\otimes (N-1)}$ . We obtain [\(25\)](#page-5-0) by iteratively applying [\(28\)](#page-5-1).

<span id="page-5-3"></span>**Lemma 3.** Let  $\{|b_1\rangle, |b_2\rangle, \ldots, |b_{d^N}\rangle\}$  be an arbitrary orthonormal basis of the Hilbert space  $(\mathbb{C}^d)^{\otimes N}$ *. For a Haar-random product state*  $|\Psi\rangle$  *and any*  $\alpha \geq 1$ *,* 

$$
\mathbb{E}\sum_{j=1}^{d^N} |\langle b_j | \Psi \rangle|^{2\alpha} \le (M_\alpha d)^N.
$$
\n(29)

*Furthermore, for an arbitrarily small constant*  $\varepsilon > 0$ *,* 

<span id="page-5-2"></span>
$$
\Pr_{\Psi} \left( \sum_{j=1}^{d^N} \left| \langle b_j | \Psi \rangle \right|^{2\alpha} \le (M_\alpha d)^{(1-\varepsilon)N} \right) = 1 - e^{-\Omega(N)}.
$$
\n(30)

*Proof.* The probabilistic bound [\(30\)](#page-5-2) follows from Markov's inequality.

For  $\alpha = 2$ , Lemma [3](#page-5-3) reduces to Lemma 5 in Ref. [\[7\]](#page-12-14).

Let  $\{|j\rangle\}_{j=1}^{d^N}$  be a complete set of eigenstates of H. Assuming that the spectrum of H is non-degenerate, the energy basis  $\{|j\rangle\}$  is unambiguously defined. The effective dimension of a state  $|\psi\rangle$  is defined as

$$
1/D_{\psi}^{\text{eff}} = \sum_{j=1}^{d^N} |\langle j|\psi\rangle|^4.
$$
 (31)

<span id="page-6-0"></span>**Lemma 4.** *Initialize the system in a pure state*  $|\psi\rangle$ *. Let* 

$$
\sigma := \lim_{\tau \to +\infty} \frac{1}{\tau} \int_0^{\tau} \rho(t) dt, \quad \rho(t) := e^{-iHt} |\psi\rangle \langle \psi| e^{iHt}
$$
 (32)

be the infinite time average and  $\sigma_{A_j} := \text{tr}_{\bar{A}_j} \sigma$  be the reduced density matrix of subsystem  $A_j$ . *For any Hamiltonian* H *with non-degenerate spectrum and any*  $\alpha > 1$ *,* 

$$
\frac{1}{m}\sum_{j=1}^{m}S(\sigma_{A_j})\geq \frac{n}{N(1-\alpha)}\ln\sum_{j=1}^{d^N}|\langle j|\psi\rangle|^{2\alpha}.
$$
\n(33)

*Proof.* Expanding  $|\psi\rangle$  in the energy basis, it is easy to see that

$$
\sigma = \sum_{j=1}^{d^N} p_j |j\rangle\langle j|, \quad p_j := \left| \langle j | \psi \rangle \right|^2 \tag{34}
$$

is the so-called diagonal ensemble. Using the strong subadditivity [\[10\]](#page-12-6) of the von Neumann entropy and the monotonicity of the Rényi entropy,

$$
\frac{1}{m} \sum_{j=1}^{m} S(\sigma_{A_j}) \ge \frac{n}{N} S(\sigma) = -\frac{n}{N} \sum_{j=1}^{d^N} p_j \ln p_j \ge \frac{n}{N(1-\alpha)} \ln \sum_{j=1}^{d^N} p_j^{\alpha}, \quad \forall \alpha > 1.
$$
 (35)

Let  $||X||_1 := \text{tr} \sqrt{X^{\dagger} X}$  denote the trace norm.

Lemma 5 ([\[11,](#page-12-8) [16\]](#page-12-9)). *Using the notation of Lemma [4,](#page-6-0) for any Hamiltonian* H *whose spectrum has non-degenerate gaps,*

$$
\lim_{\tau \to +\infty} \frac{1}{\tau} \int_0^{\tau} \|\rho_{A_j}(t) - \sigma_{A_j}\|_1 dt \le d^n / \sqrt{D_{\psi}^{\text{eff}}}.
$$
\n(36)

<span id="page-6-2"></span>**Lemma 6** (continuity of the von Neumann entropy [\[5,](#page-12-16) [3\]](#page-11-1)). Let  $T := ||\rho - \sigma||_1/2$  be the trace *distance between two density matrices* ρ, σ *on the Hilbert space* C <sup>D</sup>*. Then,*

$$
|S(\rho) - S(\sigma)| \le T \ln(D - 1) - T \ln T - (1 - T) \ln(1 - T). \tag{37}
$$

Since by definition  $0 \leq T \leq 1$ , the right-hand side of this inequality is well defined. We are ready to prove Theorem [1.](#page-2-0) Lemmas [3](#page-5-3) and [4](#page-6-0) imply that

$$
\Pr_{\Psi} \left( D_{\Psi}^{\text{eff}} \ge \left( \frac{d+1}{2} \right)^{(1-\epsilon/2)N} \right) = 1 - e^{-\Omega(N)},\tag{38}
$$

$$
\Pr_{\Psi} \left( \frac{1}{m} \sum_{j=1}^{m} S(\sigma_{A_j}) \ge \frac{(1 - \epsilon/3)n}{\alpha - 1} \sum_{k=2}^{d} \ln \left( 1 + \frac{\alpha - 1}{k} \right) \right) = 1 - e^{-\Omega(N)}, \quad \forall \alpha > 1. \tag{39}
$$

Therefore, it suffices to prove that

<span id="page-7-1"></span>
$$
\Pr_{t \in \mathbb{R}} \left( \frac{1}{m} \sum_{j=1}^{m} S(\rho_{A_j}(t)) \ge (1 - \epsilon) n \sum_{k=2}^{d} \frac{1}{k} \right) = 1 - e^{-\Omega(N)} \tag{40}
$$

assuming that

<span id="page-7-0"></span>
$$
D_{\Psi}^{\text{eff}} \ge \left(\frac{d+1}{2}\right)^{(1-\epsilon/2)N},\tag{41}
$$

<span id="page-7-2"></span>
$$
\frac{1}{m} \sum_{j=1}^{m} S(\sigma_{A_j}) \ge (1 - 2\epsilon/3)n \sum_{k=2}^{d} \frac{1}{k}.
$$
\n(42)

[\(4\)](#page-2-3), [\(36\)](#page-6-1), and [\(41\)](#page-7-0) imply that

$$
\lim_{\tau \to +\infty} \frac{1}{\tau} \int_0^{\tau} \frac{1}{m} \sum_{j=1}^m \|\rho_{A_j}(t) - \sigma_{A_j}\|_1 dt \le d^n / \sqrt{D_{\Psi}^{\text{eff}}} \le \left(\frac{2}{d+1}\right)^{\epsilon N/4} = e^{-\Omega(N)}.
$$
 (43)

Markov's inequality implies that

<span id="page-7-3"></span>
$$
\Pr_{t \in \mathbb{R}} \left( \frac{1}{m} \sum_{j=1}^{m} \|\rho_{A_j}(t) - \sigma_{A_j}\|_1 = e^{-\Omega(N)} \right) = 1 - e^{-\Omega(N)}.
$$
\n(44)

Due to the continuity of the von Neumann entropy (Lemma [6\)](#page-6-2),

<span id="page-7-4"></span>
$$
\frac{1}{m}\sum_{j=1}^{m} \|\rho_{A_j}(t) - \sigma_{A_j}\|_1 = e^{-\Omega(N)} \implies \frac{1}{m}\sum_{j=1}^{m} |S(\rho_{A_j}(t)) - S(\sigma_{A_j})| = e^{-\Omega(N)}.
$$
 (45)

Equation [\(40\)](#page-7-1) follows from  $(42)$ ,  $(44)$ , and  $(45)$ .

# <span id="page-7-5"></span>B Proof of Theorem [2](#page-3-0)

We begin by following the proof of Lemma 8 in Ref. [\[7\]](#page-12-14). Let  ${E_j}_{j=1}^{2^N}$  with be the eigenvalues of  $H_J(\alpha)$  and

$$
G_J(\alpha) := \prod_{((j \neq j') \vee (k \neq k')) \wedge ((j \neq k') \vee (k \neq j'))} (E_j + E_k - E_{j'} - E_{k'}) \tag{46}
$$

so that  $G_J(\alpha) = 0$  if and only if the spectrum of  $H_J(\alpha)$  has degenerate gaps (Definition [4\)](#page-1-1). It is easy to see that  $G_J(\alpha)$  is a symmetric polynomial in  $E_1, E_2, \ldots, E_{2^N}$ . The fundamental theorem of symmetric polynomials implies that  $G_J(\alpha)$  can be expressed as a polynomial in  $F_1, F_2, \ldots$ , where

$$
F_k := \sum_{j=1}^{2^N} E_j^k = \text{tr}\left(H_J^k(\alpha)\right). \tag{47}
$$

Expanding  $H_j^k(\alpha)$  in the Pauli basis and taking the trace, we see that  $F_k$  and hence  $G_j(\alpha)$ :  $[-1, 1] \times (12N-9) \rightarrow \mathbb{R}$  are polynomials in the entries of  $\alpha$ . Since the zeros of a multivariable polynomial are of measure zero unless the polynomial is identically zero, it suffices to find a particular  $\alpha \in \mathbb{R}^{12N-9}$  such that the spectrum of  $H_J(\alpha)$  has non-degenerate gaps. This is done in the following lemma.

<span id="page-8-2"></span>**Lemma 7.** For any positive integer N, there exists  $(h_1, J_1, h_2, J_2, \ldots, h_{N-1}, J_{N-1}) \in \mathbb{R}^{2(N-1)}$ *such that the spectrum of*

<span id="page-8-1"></span>
$$
H_N = \hat{\sigma}_1^z + \sum_{j=1}^{N-1} \left( h_j \hat{\sigma}_{j+1}^x + J_j (2 + \hat{\sigma}_j^z) \hat{\sigma}_{j+1}^z \right) \tag{48}
$$

*has non-degenerate gaps.*

*Proof.* We prove by induction on N.

Induction hypotheses. We have two induction hypotheses:

- 1. The spectrum of  $H_N$  has non-degenerate gaps.
- 2.  $\{\langle j|\hat{\sigma}_N^z|j\rangle\}$  is a set of pairwise distinct numbers, where  $\{|j\rangle\}_{j=1}^{2^N}$  are eigenstates of  $H_N$ .

**Base case.** The base case  $N = 1$  is trivially true.

**Induction step.** Assuming the induction hypotheses for  $H_N$ , we prove those for  $H_{N+1}$ using perturbation theory. The unperturbed Hamiltonian and the perturbation are

$$
H_{\text{unp}} := H_N + h_N \hat{\sigma}_{N+1}^x, \quad H_{\text{per}} := J_N (2 + \hat{\sigma}_N^z) \hat{\sigma}_{N+1}^z,
$$
(49)

respectively. Let  $\{|j\rangle\}$  be eigenstates of  $H_N$  with corresponding energies  $\{E_i\}$ . Let

$$
\Delta := \min_{j \neq k} |E_j - E_k|, \quad \delta := \min_{((j \neq j') \vee (k \neq k')) \wedge ((j \neq k') \vee (k \neq j'))} |E_j + E_k - E_{j'} - E_{k'}| \tag{50}
$$

so that  $\delta \leq \Delta$ . Let  $|\circ\rangle, |\bullet\rangle$  be eigenstates of  $\sigma_{N+1}^x$  with eigenvalues  $\pm 1$ . The eigenstates of  $H_{\text{unp}}$  are  $\{|j\circ\rangle, |j\bullet\rangle\}$  with corresponding energies  $\{E_j \pm h_N\}$ . We choose  $h_N, J_N$  such that

<span id="page-8-0"></span>
$$
0 < J_N \ll h_N \ll \min\left\{\delta, \Delta \min_{j \neq k} \left| \langle j | \hat{\sigma}_N^z | j \rangle - \langle k | \hat{\sigma}_N^z | k \rangle \right| \right\}.
$$
\n
$$
(51)
$$

The induction hypotheses imply that the most right-hand side of [\(51\)](#page-8-0) is positive. The condition [\(51\)](#page-8-0) implies that the energy gap (minimum difference between adjacent eigenvalues) of  $H_{\text{unp}}$  is  $2h_N$ . Let  $\{|j \circ \rangle, |j \bullet \rangle\}$  be eigenstates of  $H_{N+1} := H_{\text{unp}} + H_{\text{per}}$  with corresponding energies  $\{E_{j\circ}, E_{j\bullet}\}.$ 

**Proof of induction hypothesis 1 for**  $H_{N+1}$ **.** Using second-order non-degenerate perturbation theory,

$$
E_{j\circ} = E_j + h_N + \langle j \circ | H_{\text{per}} | j \circ \rangle + \sum_{k \neq j} \frac{\left| \langle k \circ | H_{\text{per}} | j \circ \rangle \right|^2}{E_j - E_k} + \sum_k \frac{\left| \langle k \bullet | H_{\text{per}} | j \circ \rangle \right|^2}{E_j - E_k + 2h_N} + O(J_N^3)
$$
  
=  $E_j + h_N + \frac{J_N^2 (2 + \langle j | \hat{\sigma}_N^z | j \rangle)^2}{2h_N} + \sum_{k \neq j} \frac{J_N^2 \left| \langle k | \hat{\sigma}_N^z | j \rangle \right|^2}{E_j - E_k + 2h_N} + O(J_N^3)$   
=  $E_j + h_N + \frac{J_N^2 (2 + \langle j | \hat{\sigma}_N^z | j \rangle)^2}{2h_N} + O(J_N^2/\Delta),$  (52)

where we used

$$
\sum_{k \neq j} \frac{|\langle k|\hat{\sigma}_N^z|j\rangle|^2}{|E_j - E_k + 2h_N|} \le \sum_k \frac{|\langle k|\hat{\sigma}_N^z|j\rangle|^2}{\Delta - 2h_N} = \frac{1}{\Delta - 2h_N} = O(1/\Delta). \tag{53}
$$

Similarly,

$$
E_{j\bullet} = E_j - h_N - \frac{J_N^2 (2 + \langle j|\hat{\sigma}_N^z|j\rangle)^2}{2h_N} + O(J_N^2/\Delta). \tag{54}
$$

Suppose that

$$
E_{j\alpha} + E_{k\beta} = E_{j'\alpha'} + E_{k'\beta'}, \quad \alpha, \beta, \alpha', \beta' \in \{\circ, \bullet\}.
$$
 (55)

Assume without loss of generality that  $j \leq k$  and  $j' \leq k'$ . Since  $h_N \ll \delta$ , we have  $j = j'$  and  $k = k'$ . Since  $J_N \ll h_N$ , it suffices to exclude the possibilities that (1)  $j \neq k$  and  $\alpha = \beta' = \infty$ and  $\beta = \alpha' = \bullet$  or (2)  $j \neq k$  and  $\alpha = \beta' = \bullet$  and  $\beta = \alpha' = \circ$ . In both cases,

$$
\left|J_N^2(2+\langle j|\hat{\sigma}_N^z|j\rangle)^2/h_N - J_N^2(2+\langle k|\hat{\sigma}_N^z|k\rangle)^2/h_N\right| = O(J_N^2/\Delta)
$$
  

$$
\implies \left|\langle j|\hat{\sigma}_N^z|j\rangle - \langle k|\hat{\sigma}_N^z|k\rangle\right| = O(h_N/\Delta). \quad (56)
$$

This is impossible for our choice of  $h_N$  [\(51\)](#page-8-0).

**Proof of induction hypothesis 2 for**  $H_{N+1}$ **.** Using first-order non-degenerate perturbation theory,

$$
|j\circ\rangle = |j\circ\rangle + \sum_{k\neq j} \frac{\langle k \circ | H_{\text{per}} | j\circ \rangle}{E_j - E_k} |k\circ\rangle + \sum_k \frac{\langle k \bullet | H_{\text{per}} | j\circ \rangle}{E_j - E_k + 2h_N} |k\bullet\rangle + O(J_N^2)
$$
  

$$
= |j\circ\rangle + \frac{J_N(2 + \langle j|\hat{\sigma}_N^z|j\rangle)}{2h_N} |j\bullet\rangle + \sum_{k\neq j} \frac{J_N \langle k|\hat{\sigma}_N^z|j\rangle}{E_j - E_k + 2h_N} |k\bullet\rangle + O(J_N^2) \quad (57)
$$

so that

$$
(j \circ |\hat{\sigma}_{N+1}^z|j \circ) = J_N(2 + \langle j|\hat{\sigma}_N^z|j\rangle)/h_N + O(J_N^2). \tag{58}
$$

Similarly,

$$
(j \bullet |\hat{\sigma}_{N+1}^z|j\bullet) = -J_N(2 + \langle j|\hat{\sigma}_N^z|j\rangle)/h_N + O(J_N^2). \tag{59}
$$

Induction hypothesis 2 for  $H_N$  implies that  $\{(j \circ |\hat{\sigma}_{N+1}^z|j \circ), (j \bullet |\hat{\sigma}_{N+1}^z|j \bullet)\}_{j=1}^{2^N}$  is a set of pairwise distinct numbers.  $\Box$ 

### <span id="page-9-0"></span>C Extensions of Theorem [2](#page-3-0)

#### C.1 Proof of Corollary [2](#page-4-0)

Following the proof of Theorem [2](#page-3-0) in Appendix [B,](#page-7-5) it suffices to find a particular  $\gamma \in \mathbb{R}^{3N-1}$ (not necessarily  $\gamma \in [-1, 1]^{\times (3N-1)}$ ) such that the spectrum of  $H_h^{XXZ}(\gamma)$  has non-degenerate gaps. Let  $\mathbf{v}$ 

$$
H'_{N} := \Lambda H_{N} + \sum_{j=1}^{N-1} (\hat{\sigma}_{j}^{x} \hat{\sigma}_{j+1}^{x} + \hat{\sigma}_{j}^{y} \hat{\sigma}_{j+1}^{y}),
$$
\n(60)

where  $H_N$  is given by Eq. [\(48\)](#page-8-1). Since the spectrum of  $H_N$  has non-degenerate gaps (Lemma [7\)](#page-8-2), that of  $H'_{N}$  also has non-degenerate gaps for sufficiently large  $\Lambda > 0$ .

### C.2 Higher spatial dimensions

To prove an analogue of Theorem [2](#page-3-0) on a higher-dimensional lattice L, it suffices to construct a particular Hamiltonian on L with nearest-neighbor interactions such that its spectrum has non-degenerate gaps. To this end, we simply embed the spin chain model  $(48)$  into L. Figure [1](#page-10-1) illustrates the embedding for L being a two-dimensional square lattice.

### <span id="page-10-0"></span>C.3 Qudit systems

To extend Theorem [2](#page-3-0) to a qudit chain with  $d \geq 3$ , it suffices to prove an analogue of Lemma [7.](#page-8-2) Let  $-1 \le e_1 < e_2 < \cdots < e_d \le 1$  be d constants such that the spectrum of the diagonal matrix  $X := diag(e_1, e_2, \ldots, e_d)$  has non-degenerate gaps. Let

$$
\hat{Z} := \bigoplus_{j=1}^{d/2} \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}, \quad \hat{Z} := \bigoplus_{j=1}^{(d-1)/2} \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix} \oplus (0)
$$
(61)

if d is even/odd, respectively, so that the expectation value of  $\hat{Z}$  in any eigenstate of  $\hat{X}$  is 0. Let  $\Lambda > 1$  be a constant such that

$$
\Lambda > \max_{1 \le j < k \le d/2} \frac{e_{2j} - e_{2j-1} + e_{2k} - e_{2k-1}}{|e_{2j} - e_{2j-1} - e_{2k} + e_{2k-1}|}.\tag{62}
$$

Consider a chain of N qudits. Let  $\hat{X}_j, \hat{Z}_j$  be the  $\hat{X}, \hat{Z}$  operators for the spin at position j. It is trivial to construct a Hamiltonian  $H_1$  acting only on the first spin such that

1. The spectrum of  $H_1$  has non-degenerate gaps.

2.  $\{\langle j|\hat{Z}_1|j\rangle\}$  is a set of pairwise distinct numbers, where  $\{|j\rangle\}_{j=0}^{d-1}$  are eigenstates of  $H_1$ . **Corollary 3.** For any positive integer N, there exists  $(h_1, J_1, h_2, J_2, \ldots, h_{N-1}, J_{N-1}) \in$ R 2(N−1) *such that the spectrum of*

$$
H_N = H_1 + \sum_{j=1}^{N-1} \left( h_j \hat{X}_{j+1} + J_j (\Lambda + \hat{Z}_j) \hat{Z}_{j+1} \right) \tag{63}
$$

*has non-degenerate gaps.*

This corollary can be proved in almost the same way as Theorem [2.](#page-3-0)

### D Proof of Theorem [3](#page-4-1)

<span id="page-11-3"></span>**Lemma 8.** Let  $\{|j\rangle\}_{j=0}^{d-1}$  be an orthonormal basis of  $\mathbb{C}^d$ . For a Haar-random state  $|\Psi'\rangle$ ,

$$
-\mathop{\mathbb{E}}_{\Psi'}\sum_{j=0}^{d-1}p_j\ln p_j = \sum_{k=2}^d\frac{1}{k}, \quad p_j := |\langle j|\Psi'\rangle|^2.
$$
 (64)

*Proof.*

$$
\mathbb{E}\sum_{\Psi'}^{d-1} p_j \ln p_j = d \mathbb{E}_{\Psi'} p_0 \ln p_0 = d \int_0^1 x f(x) \ln x \, dx = -\sum_{k=2}^d \frac{1}{k},\tag{65}
$$

where  $f(x)$  is given by Eq. [\(23\)](#page-4-2).

Let

$$
\sigma_A := \lim_{\tau \to +\infty} \frac{1}{\tau} \int_0^{\tau} \rho_A(t) dt \tag{66}
$$

 $\Box$ 

be the infinite time average and  $\sigma_j := \text{tr}_{A \setminus \{j\}} \sigma_A$  be the reduced density matrix of the spin at position  $j \in A$ . Using the concavity and subadditivity [\[2\]](#page-11-2) of the von Neumann entropy,

<span id="page-11-4"></span>
$$
\lim_{\tau \to +\infty} \frac{1}{\tau} \int_0^{\tau} S(\rho_A(t)) dt \le S(\sigma_A) \le \sum_{j \in A} S(\sigma_j).
$$
 (67)

Let  $x = y$  denote that  $x - y$  is infinitesimal. Recall that  $H^{\text{mbl}} = H^{\text{loc}}$ , which is diagonal in the computational basis and whose spectrum is non-degenerate. For a Haar-random product state  $|\Psi\rangle = \bigotimes_{j=1}^{N} |\Psi_j\rangle$ , it is not difficult to see that

$$
\sigma_j = \text{diag}(p_{j,0}, p_{j,1}, \dots, p_{j,d-1}), \quad p_{j,k} := |j \langle k | \Psi_j \rangle|^2, \tag{68}
$$

where  $\{|k\rangle_j\}_{k=0}^{d-1}$  is the computational basis for the spin at position j. Hence,

<span id="page-11-5"></span>
$$
\mathbb{E}\sum_{\Psi} S(\sigma_j) \doteq -\sum_{j\in A} \mathbb{E}\sum_{\Psi_j} \sum_{k=0}^{d-1} p_{j,k} \ln p_{j,k}.\tag{69}
$$

Theorem [3](#page-4-1) follows by combining Lemma [8](#page-11-3) and [\(67\)](#page-11-4), [\(69\)](#page-11-5).
