On the reduced Hartree-Fock equations with a Small Anderson Type Background Charge Distribution

Abstract

We demonstrate that the reduced Hartree-Fock equation (REHF) with a small Anderson type background charge distribution has an unique stationary solution by explicitly computing a screening mass at positive temperature.

1 Introduction

Density functional theory (DFT) has become the stable of modern quantum science thanks to its tractability. One of its notable application is in describing the electronic structure of disordered crystals in solid state physics and material sciences. Nevertheless, the disordered nature of certain crystal structures and the long range Coulomb interaction have caused considerable difficulties in their theoretical studies. To illustrate this difficulty, we restrict our attention to dimension three (3) for the rest of the paper.

In condensed matter physics, the density of electrons is governed by the Kohn-Sham (KS) equation of DFT, whose mathematical properties have become an area of intense research, for example, [1, 3, 4, 5, 6, 7, 8, 9, 11, 21, 14, 15, 16, 17, 18, 19, 20, 22]. These works consider various problems in KS model, e.g., [1] is concerned with KS models in the local density approximation framework, [3, 4, 5, 14, 20] consider interactions in crystals with local defects or systems with infinite particles, the works [6, 7] consider thermodynamic limit for a periodic model. The literature on KS model is huge, and we are not able to give a thorough review here. We refer the readers to, e.g., [11] and reference therein for more details. One central focus of these studies is the existence and uniqueness problem. In this context, a prolific approach is through the use of variational arguments. Given a nuclear charge distribution κ on a set $S \subset \mathbb{R}^3$, the Kohn-Sham equation are the Euler-Lagrange equation of the Kohn-Sham energy,

which is a functional of the electron density matrix γ [12]:

$$E_{\rm KS}(\gamma) = {\rm Tr}((-\Delta)\gamma) + \frac{1}{2} \int_{\mathbb{R}^3 \times \mathbb{R}^3} dx dy \, \frac{(\kappa(x) - \rho_{\gamma}(x))(\kappa(y) - \rho_{\gamma}(y))}{|x - y|} + Ex(\rho_{\gamma}), \tag{1}$$

where $\rho_{\gamma}(x) = \gamma(x, x)$ is the electron density $(\gamma(x, y)$ is the integral kernel of γ) and Ex is the exchange-correlation energy depending solely on ρ_{γ} , instead of γ . However, a major impediment to the variational approach is that the Coulomb self-interaction energy in (1) becomes ill defined if S is unbounded and $\kappa - \rho_{\gamma}$ lacks decay. A notable example is when κ is the Anderson type disorder.

At zero temperature, some mitigation of the long range Coulomb problem involves studying minimizers of $E_{\rm KS}$ on a finite domain and then passing to their thermodynamic limits to include periodic κ and ρ_{γ} (see for example, [6, 7, 9]), or introducing a screening mass as in the case of Yukawa potential [4]. On the other hand, a natural screening is observed at positive temperature [8, 15].

In this work, we follow the latter school of thoughts. We show that the Kohn-Sham equation have unique solutions despite the presence of long range Coulomb interaction and disordered background distribution κ at positive temperature. To elucidate the main ideas, we drop the exchange correlation term Ex in $E_{\rm KS}$. The resulting energy and equation bear the name of reduced Hartree-Fock (REHF) equation and energy, respectively. Let β denote the inverse temperature. At positive temperature β^{-1} , the REHF free energy of γ is

$$F_{\text{REHF}}(\gamma) := E_{\text{REHF}}(\gamma) - \beta^{-1}S(\gamma),$$

$$E_{\text{REHF}}(\gamma) := \text{Tr}((-\Delta)\gamma) + \frac{1}{2} \int_{\mathbb{R}^3 \times \mathbb{R}^3} dx dy \, \frac{(\kappa(x) - \rho_{\gamma}(x))(\kappa(y) - \rho_{\gamma}(y))}{|x - y|},$$

$$S(\gamma) := -\text{Tr}(\gamma \ln(\gamma) + (1 - \gamma) \ln(1 - \gamma)),$$
(3)

whenever F_{REHF} is well defined. We remark that we have not specified the space on which γ acts as well as the exact meaning of Tr. Since we will be working with and describing the Euler-Lagrange equations later, this inconvenience is only formal. The REHF equation is the Euler-Lagrange equation of F_{REHF} with a fixed number of particles Tr γ . Despite the fact that F_{REHF} is a functional of γ , the REHF equation can be solely written in terms of the electron density ρ (hence the name DFT), the (auxiliary) electric potential φ , and the chemical potential μ (i.e. the Lagrange-multiplier):

$$\rho = \operatorname{den} f_{\rm FD}(\beta(-\Delta - \varphi - \mu)), \tag{4}$$

$$-\Delta\varphi = 4\pi(\kappa - \rho),\tag{5}$$

where $f_{\rm FD}$ is the Fermi-Dirac distribution

$$f_{\rm FD}(x) = \frac{1}{1+e^x}.$$
 (6)

Moreover, we have introduced the den operator mapping operators A on $L^2(\mathbb{R}^3)$ to its density A(x, x) where A(x, y) is its integral kernel. A more precise definition of den can be found in Appendix A or [4]. Nevertheless, one can recover γ via

$$\gamma = f_{\rm FD}(\beta(-\Delta - \varphi - \mu)). \tag{7}$$

However, a yet more advantageous view is to substitute ρ from (4) into (5) to obtain

$$-\frac{1}{4\pi}\Delta\varphi = \kappa - \operatorname{den} f_{\rm FD}(\beta(-\Delta - \varphi - \mu)).$$
(8)

It is in this view that one can see a clearer presence of a screening mass at positive temperature. We will henceforth call equation (8) the reduced Hartree-Fock (REHF) equation for the purpose of this paper.

To specify the class of disorders in κ and the solution space on which we study (8), let \mathcal{L} denote a (non-degenerate) Bravais lattice in \mathbb{R}^3 and Q denote any fundamental domain. That is, \mathcal{L} translates of Q tile \mathbb{R}^3 . A typical example of Q is the Wigner-Seitz cell. Moreover, assume that $\tau = {\tau_\ell}_{\ell \in \mathcal{L}}$ is a group of measure preserving \mathcal{L} -actions on the probability space Ω .

Definition 1. A measurable function f on $\mathbb{R}^3 \times \Omega$ is said to be (\mathcal{L}) stationary if

$$f(x - \ell, \tau_{\ell}\omega) = f(x, \omega) \tag{9}$$

for all $(x, \omega) \in \mathbb{R}^3 \times \Omega$ and $\ell \in \mathcal{L}$.

A notable example of this category is the Anderson potential

$$\kappa(x,\omega) = \sum_{\ell \in \mathcal{L} = \mathbb{Z}^d} q_\ell(\omega) \chi(x-\ell), \tag{10}$$

where $\chi \in C_c^{\infty}(\mathbb{R}^d)$ and the $q_{\ell}(\omega)$ are i.i.d. random variables. The Anderson type potential is of interest to physicists and mathematicians alike [2, 13].

We define the space of stationary κ 's and record the conventions used before we state our main result. Let $L^q(Q)$ denote the usual L^q space over Q with the standard L^q norm and L^2 inner products when q = 2. We will use the notation $L^p_{\omega}L^q_x$ to denote the norm-completed

$$\{f(x,w) \in L^q_{\text{loc}}(\mathbb{R}^3) \times L^p(\Omega) : f \text{ is stationary and } \|f\|_{L^p_{\omega}L^q_x} < \infty\},$$
(11)

where

$$\|f\|_{L^{p}_{\omega}L^{q}_{x}}^{p} := \mathbb{E}\|f\|_{L^{q}(Q)}^{p}.$$
(12)

When $p = \infty$ or $q = \infty$, the associated norm is the usual sup norm. We remark that due to egodicity, the above norms do not depend on the location of the fundamental domain Q (see Lemma 9 in Appendix A). Consequently, we do not display Q in the subscripts of the norms.

With these notations, equation (8) is to be understood as follows. We require $\kappa \in L^{\infty}_{\omega}L^2_x$ while we look for a solution (φ, μ) in $L^{\infty}_{\omega}H^2_x \times \mathbb{R}$. Nevertheless, $-\Delta - \varphi - \mu$ and $f_{\rm FD}(\beta(-\Delta - \varphi - \mu))$ are operators on $L^2(\mathbb{R}^3)$, where the latter is defined by the holomorphic functional calculus. Consequently, den $f_{\rm FD}(\beta(-\Delta - \varphi - \mu))$ is a stationary function since φ is stationary.

Finally, we will use

$$\hat{f}(k) = (2\pi)^{-3/2} \int_{\mathbb{R}^3} f(x) e^{-ix \cdot k} dx$$

as our unitary Fourier transform. Moreover, we will denote by $C_{a,b,\cdots}$ finite constants depending only on the parameters a, b, \cdots . By an abuse of notation and by choosing an even large constant if necessary, C or $C_{a,b,\cdots}$ may stand for different constants simultaneously. Lastly, we will write $A \leq B, A \geq B$ if $A \leq CB$ or $A \geq CB$ for some absolute constant C, respectively.

1.1 Main results

We notice that REHF exhibits a symmetry

$$(\varphi, \mu) \mapsto (\varphi + t, \mu - t) \tag{13}$$

for any $t \in \mathbb{R}$. That is, if (φ, μ) is a solution of (8), then so is $(\varphi + t, \mu - t)$. Therefore, a solution of REHF is an equivalence class of $(\varphi, \mu) \in L^{\infty}_{\omega} H^2_x \times \mathbb{R}$ with respect to (13). Consequently, the notion of uniqueness is defined up to this equivalence class. With this definition of uniqueness, we state our main results.

Let Q denote a fundamental domain of the lattice \mathcal{L} . Let $\kappa \in L_w^{\infty} L_x^2$ and κ_0 denote its expected spacial average:

$$\kappa_0 = \frac{1}{|Q|} \mathbb{E} \int_Q \kappa.$$
(14)

Let $\kappa' = \kappa - \kappa_0$. We have the following main results below. Theorem 2 considers the simplest case where $\kappa \in \mathbb{R}$ is homogeneous. That is, the material is a jellium. Theorem 3 extends Theorem 2 by considering random disordered background κ , as a perturbation from the jellium solution with background potential κ_0 .

Theorem 2. Let $0 < \kappa \in \mathbb{R}$. There exists positive constants $c_1 = \frac{1}{8\pi^{3/2}}$ and $c_2 = \frac{1}{12\pi^2}$ such that if $\beta \in \mathbb{R}$ is positive and satisfies

$$\kappa > \frac{c_1}{\beta^{3/2}},\tag{15}$$

then there exists a solution $(0, \mu) \in \mathbb{R} \times \mathbb{R}$ to the REHF equation (8). Moreover,

$$0 < \frac{1}{\beta} \log(\kappa \beta^{3/2} / c_1) < \mu < (\kappa / c_2)^{2/3}.$$
(16)

Remark 1. We will see in the proof that the density of the homogeneous Poisson equation (8) is a continuous increasing function of μ . We request the technical condition (15) in order to obtain a positive solution μ . See equations (22), (23) in the proof of Theorem 2 for more details.

Theorem 3. Let $0 < \beta < \infty$ and $\kappa \in L_w^{\infty} L_x^2$ be real valued. Assume that (15) holds with κ_0 and let $\mu > 0$ be given as in Theorem 2. There exist constant $C_1, C_2 > 0$ depending on β, μ and κ_0 , see (43),(44). If $\|\kappa'\|_{L_w^{\infty} L_x^2} \leq C_1$, then the REHF equation (8) has a unique solution $(\varphi, \mu) \in L_w^{\infty} H_x^2 \times \mathbb{R}$ in a neighborhood of $(0, \mu)$ with

$$\|\varphi\|_{L^{\infty}_{w}H^{2}_{x}} \leq C_{2} \|\kappa'\|_{L^{\infty}_{w}L^{2}_{x}}.$$
(17)

Remark 2. The positive assumption $\beta^{-1} > 0$ is crucial for our main results. For technical reasons, the smallness condition on κ' and the constant C_2 in (17) decays to 0 as $\beta \to \infty$. Our approach does not apply to the zero temperature case. At the zero temperature, the existence of the solution to the reduced Hartree-Fock equations in disordered media have been studied and established in the previous work [4, 14], when the interaction is short-range. See Proposition 4.5 in [4] and Theorem 2.1 in [14]. We refer readers to these work and references therein for more related results.

By our remark immediately after Definition 1, we see that Theorem 3 provides existence and uniqueness results for small Anderson background charge distributions.

The paper is organized as follows. In section 2, we provide a proof for Theorem 2 in the case $\kappa = \kappa_0$ is a constant. Then, we prove Theorem 3 perturbatively by linearizing the REHF equation at the constant solution to the case $\kappa = \kappa_0$. The main proof of Theorem 3 is given in Section 3, modulo the core linear and nonlinear analysis. The linearized operator of the REHF equation is studied in Section 4 while the nonlinear analysis is given in Section 5.

2 Translation invariant solution: proof of Theorem 2

Proof of Theorem 2. If $\kappa \in \mathbb{R}$ and $\varphi = 0$, then equation (8) becomes an equation for μ :

$$\kappa = \operatorname{den} f_{\rm FD}(\beta(-\Delta - \mu)). \tag{18}$$

Translation invariance of $-\Delta$ on $L^2(\mathbb{R}^3)$ shows that this equation can be rewritten as

$$\kappa = \frac{1}{(2\pi)^3} \int_{\mathbb{R}^3} dp \, f_{\rm FD}(\beta(p^2 - \mu)). \tag{19}$$

Thus, the right hand side of (19) becomes

$$A(\mu) := \frac{1}{(2\pi)^3} 4\pi \int_0^\infty dq \frac{q^2}{1 + e^{-\beta\mu} e^{\beta q^2}}.$$
 (20)

An upper bound for $A(\mu)$ in (20) is

$$\frac{1}{2\pi^2} \int_0^\infty dq \, q^2 e^{\beta\mu} e^{-\beta q^2} = \frac{1}{2\pi^2} e^{\beta\mu} \beta^{-3/2} \int_0^\infty dq \, q^2 e^{-q^2} \tag{21}$$

$$= \frac{1}{8\pi^{3/2}} e^{\beta\mu} \beta^{-3/2} := B(\mu).$$
(22)

As μ ranges from 0 to ∞ , we see that $B(\mu)$ in (22) increases from $c_1\beta^{-3/2}$ to ∞ for $c_1 = \frac{1}{8\pi^{3/2}}$:

$$c_1 \beta^{-3/2} = B(0) \le B(\mu) \le B(\infty) = \infty.$$

Similarly, a lower bound for (20) is

$$\frac{1}{2\pi^2} \int_0^{\sqrt{\mu}} dq \, \frac{q^2}{2} = \frac{1}{12\pi^2} \mu^{3/2} := C(\mu). \tag{23}$$

As μ ranges from 0 to ∞ , the lower bound estimate $C(\mu)$ in (23) increases from 0 to ∞ :

$$0 = C(0) \le C(\mu) \le C(\infty) = \infty.$$

Thus, continuity (in μ) of the right hand side of equation (19) implies that a solution $\mu > 0$ exists if $\kappa > c_1\beta^{-3/2}$. Solving for μ in (22) and (23), i.e., $C(\mu) < \kappa = A(\mu) < B(\mu)$ implies

$$\frac{1}{12\pi^2}\mu^{3/2} < \kappa < \frac{1}{8\pi^{3/2}}e^{\beta\mu}\beta^{-3/2}.$$

Therefore,

$$\frac{1}{\beta} \log \left(8\pi^{3/2} \kappa \beta^{3/2}\right) < \mu < (12\pi^2 \kappa)^{2/3}$$
proves (16) with $c_1 = \frac{1}{8\pi^{3/2}}$ and $c_2 = \frac{1}{12\pi^2}$.

3 Fixed point argument: proof of Theorem **3**

Proof of Theorem 3. By Theorem 2 and the assumption (15) on κ_0 , there exists a solution ($\varphi = 0, \mu$) with $\mu > 0$ to equation (8) with

$$\kappa = \kappa_0 := \frac{1}{|Q|} \mathbb{E} \int_Q \kappa.$$
(24)

That is, $\kappa_0 = \text{den} f_{\text{FD}}(\beta(-\Delta - \mu))$. For this μ fixed, we look for a solution (φ, μ) to the full equation (8) perturbatively. In particular, we linearize (8) at $\varphi = 0$. Let

$$M := d_{\varphi} \operatorname{den} f_{\mathrm{FD}}(\beta(-\Delta - \varphi - \mu)) \mid_{\varphi=0}$$

$$\tag{25}$$

and

$$N(\varphi) := -\Big(\operatorname{den} f_{\rm FD}(\beta(-\Delta - \varphi - \mu)) - \operatorname{den} f_{\rm FD}(\beta(-\Delta - \mu)) - M\varphi\Big).$$
(26)

Then we can rewrite equation (8) as

$$(-\frac{1}{4\pi}\Delta + M)\varphi = \kappa' + N(\varphi).$$
⁽²⁷⁾

Let us further denote L to be the linear operator

$$L := -\frac{1}{4\pi}\Delta + M. \tag{28}$$

We have the following estimates for the linear operator L and the nonlinear operator N, whose proofs are delayed to sections 4 and 5 below for a self-contained treatment.

Theorem 4. Let L be defined in (25) on $L_w^{\infty}L_x^2$. Let $f \in L_w^{\infty}L_x^2$. Then

$$\|Lf\|_{L_{w}^{\infty}L_{x}^{2}} \ge \|(m_{Q} - \frac{1}{8\pi}\Delta)f\|_{L_{w}^{\infty}L_{x}^{2}}$$
(29)

where

$$m_Q = c_* \min(\mu, \sqrt{\mu}) - C_{\beta,\mu} \,\ell(Q)^{-1}$$
(30)

for some universal constant $c_* > 0$ and some constant $C_{\beta,\mu} > 0$ depending only on β, μ , and $\ell(Q)$ is the diameter of Q.

Theorem 5. Let N be defined in (26) and let $\varphi_1, \varphi_2 \in L_w^{\infty} H_x^2$. There exists a constant $C_{\beta,\mu}$ depending only on β and μ such that if $\|\varphi_i\|_{L_{\omega}^{\infty}H_x^2} \leq \frac{1}{10}C_{\beta,\mu}^{-1}$, then

$$\|N(\varphi_1) - N(\varphi_2)\|_{L^{\infty}_{w}L^2_x} \le C_{\beta,\mu}(\|\varphi_1\|_{L^{\infty}_{w}H^2_x} + \|\varphi_2\|_{L^{\infty}_{w}H^2_x})\|\varphi_1 - \varphi_2\|_{L^{\infty}_{w}H^2_x}.$$
 (31)

In order to utilize Theorem 4 and ensure a positive lower bound for L, we make the following observation. If κ is \mathcal{L} stationary, it is also $(n\mathcal{L})$ stationary for $0 < n \in \mathbb{Z}$. Given Q, if its diameter $\ell(Q)$ is not large enough to ensure that m_Q in (30) is positive, we may then work on an enlarged fundamental domain nQ first for some large positive integer n to be specified. By the definition of κ_0 in (24) and the stationary of κ , κ_0 remains the same either on Q or nQ. We obtain the same μ (depending only on κ_0) on $L^{\infty}_{\omega}L^2_x(nQ)$ by Theorem 2. We then apply Theorem 4 to $f \in L^{\infty}_{\omega}L^2_x(nQ)$, where the associated lower bound is

$$m_{nQ} = c_* \min(\mu, \sqrt{\mu}) - C_{\beta,\mu} \,\ell(nQ)^{-1}.$$
(32)

We then choose *n* so large (depending only on μ, β) so that $m_{nQ} > 0$. Theorem 5 holds on $L^{\infty}_{\omega}H^2_x(nQ)$ with the same constant depending only β, μ . To apply the fix point argument in the next step, we need $\|\kappa'\|_{L^{\infty}_{\omega}L^2_x(nQ)}$ to be small. This is achieved by requiring $\|\kappa'\|_{L^{\infty}_{\omega}L^2_x(Q)}$ to be smaller once *n* is fixed since $\|\kappa'\|_{L^{\infty}_{\omega}L^2_x(nQ)} = n^{3/2} \|\kappa'\|_{L^{\infty}_{\omega}L^2_x(Q)}$. In conclusion, we may assume from the very beginning that the fundamental domain of \mathcal{L} has a sufficiently large diameter. This ensures that (30) is positive.

On the other hand, we claim that an $(n\mathcal{L})$ stationary solution associated to a \mathcal{L} stationary κ is in fact \mathcal{L} stationary, provided such solution in unique. Suppose that $(\varphi(x,\omega),\mu) \in L^{\infty}_{\omega}H^2_x \times \mathbb{R}$ is any $(n\mathcal{L})$ stationary unique solution of (8). Since κ is \mathcal{L} stationary, for $x \in \mathbb{R}^3$ and $\ell \in \mathcal{L}$,

$$-\frac{1}{4\pi}\Delta\varphi(x-\ell,\tau_{\ell}\omega) = \kappa(x,\omega) - \operatorname{den} f_{\rm FD}(\beta(-\Delta-\varphi(x-\ell,\tau_{\ell}\omega)-\mu)).$$
(33)

This shows that $\varphi(x-\ell, \tau_{\ell}\omega)$ is also an $(n\mathcal{L})$ stationary solution of (8). By uniqueness, we see that

$$\varphi(x - \ell, \tau_{\ell}\omega) = \varphi(x, \omega). \tag{34}$$

Hence, φ is also \mathcal{L} stationary. Consequently, it suffices for us to prove Theorem 3 and utilize Theorems 4 under the assumption that Q is sufficiently large. We will make this assumption for the rest of the proof of Theorem 3. At the same time, the uniqueness assumption is established via the fixed point theorem below.

By Theorem 4, if $f \in L^{\infty}_{\omega}L^2_x$, then

$$\|Lf\|_{L^{\infty}_{\omega}L^2_x} \gtrsim \|(m_Q - \Delta)f\|_{L^{\infty}_{\omega}L^2_x},\tag{35}$$

where m_Q is given in (30) and

$$m_Q > 0. \tag{36}$$

We can assume $m_Q < 1/5$ otherwise one can always pick smaller lower bounds so that (35) holds. Hence, L is invertible and bounded from below by m_Q . Thus, we can write (27) as

$$\varphi = L^{-1}\kappa' + L^{-1}N(\varphi). \tag{37}$$

To apply the fixed point theorem, we work on the ball

$$B := \{ \varphi \in L^{\infty}_w H^2_x : \|\varphi\|_{L^{\infty}_w H^2_x} < \varepsilon \}$$
(38)

where $\varepsilon \leq \frac{1}{10}C_{\beta,\mu}^{-1}$ is to be determined. If the right hand side of (37) were to map B into B, then we require

$$\|L^{-1}(\kappa' + N(\varphi))\|_{L^{\infty}_{w}H^{2}_{x}} \le \varepsilon.$$
(39)

By the choice of $\varepsilon \leq \frac{1}{10}C_{\beta,\mu}^{-1}$ and by the nonlinear estimates in Theorem 5, we see that condition (39) is satisfied if

$$m_{Q}^{-1}\left(\|\kappa'\|_{L_{w}^{\infty}L_{x}^{2}}+C_{\beta,\mu}\|\varphi\|_{L_{w}^{\infty}H_{x}^{2}}^{2}\right) \le m_{Q}^{-1}\left(\|\kappa'\|_{L_{w}^{\infty}L_{x}^{2}}+C_{\beta,\mu}\varepsilon^{2}\right) \le \varepsilon$$
(40)

where $C_{\beta,\mu}$ is given in (31). Moreover, in order that $L^{-1}N$ is a contraction, we require

$$2m_Q^{-1}C_{\beta,\mu}\varepsilon < 1. \tag{41}$$

Consequently, we choose

$$\varepsilon = \min\left(2 \, m_Q^{-1} \, \|\kappa'\|_{L^{\infty}_w L^2_x}, \frac{1}{10} C^{-1}_{\beta,\mu}\right). \tag{42}$$

We see that this choice of ε satisfies (41). If, in addition, κ' is sufficiently small:

$$\|\kappa'\|_{L^{\infty}_{w}L^{2}_{x}} < \frac{m_{Q}^{2}}{4C_{\beta,\mu}},\tag{43}$$

then together with the assumption $m_Q < 1/5$, we have

$$2 m_Q^{-1} \|\kappa'\|_{L^{\infty}_w L^2_x} \le 2 m_Q^{-1} \frac{m_Q^2}{4C_{\beta,\mu}} \le \frac{m_Q}{2C_{\beta,\mu}} < \frac{1}{10C_{\beta,\mu}}.$$

Therefore, $\varepsilon = 2 m_Q^{-1} \|\kappa'\|_{L_w^\infty L_x^2}$ and

$$m_Q^{-1} \left(\|\kappa'\|_{L_w^{\infty} L_x^2} + C_{\beta,\mu} \varepsilon^2 \right) = m_Q^{-1} \|\kappa'\|_{L_w^{\infty} L_x^2} + (m_Q^{-1} C_{\beta,\mu} \varepsilon) \varepsilon \le \varepsilon/2 + \varepsilon/2,$$

which verifies (40). Theorem 3 is now proved by the fixed point theorem, where the solution φ of (37) is unique on B (see (38)) and satisfies

$$\|\varphi\|_{L^{\infty}_{w}H^{2}_{x}} < \varepsilon \leq 2m_{Q}^{-1} \|\kappa'\|_{L^{\infty}_{w}L^{2}_{x}} = C_{\beta,\mu,\kappa_{0}} \|\kappa'\|_{L^{\infty}_{w}L^{2}_{x}}$$

$$\tag{44}$$

for some constant C_{β,μ,κ_0} . We remark that C_{β,μ,κ_0} receives its dependence on κ_0 through μ (see Theorem 2).

4 Linear analysis

The main result of this section is Theorem 4, which concerns the lower bound of the operator L on $L_w^{\infty} L_x^2$ (see (25)). Since this analysis is the core of the paper, we detail its proofs in piece meals. First, we compute an explicit form for L in Subsection 4.1. Then we prove a lower bound for L on $L^2(\mathbb{R}^3)$ in Subsection 4.2. Finally, building on these two results, we will prove Theorem 4 in the last Subsection 4.3.

4.1 Explicit form of the linearization

We first look for an integral representation of den $f_{\rm FD}(\beta(-\Delta - \varphi - \mu))$ (see the right hand side of (8)). Let $\varphi \in H^2(\Omega) \subset L^{\infty}(\Omega)$ be such that $\|\varphi\|_{\infty} \lesssim \|\varphi\|_{H^2(\Omega)}$ is sufficiently small. Thus, the spectrum of $-\Delta - \varphi$ lays on the real axis and bounded from $-\infty$. Moreover, we note that $f_{\rm FD}(\beta(z-\mu))$ is meromorphic on \mathbb{C} with poles $\mu + i\pi\beta^{-1}(2\mathbb{Z} + 1)$. It follows by Cauchy's theorem that

$$\operatorname{den} f_{\rm FD}(\beta(-\Delta-\varphi-\mu)) = \frac{1}{2\pi i} \operatorname{den} \int_{\Gamma} f_{\rm FD}(\beta(z-\mu))(z-(-\Delta-\varphi))^{-1}, \qquad (45)$$

where the contour Γ is given in Figure 1. In particular, Γ is chosen to be at most $\frac{3}{4}\beta^{-1}$ distance away from the real line and contains the spectrum of $-\Delta - \varphi$. Since we will be using expressions similar to (45) repeatedly, we will denote

$$\oint := \frac{1}{2\pi i} \int_{\Gamma} dz f_{\rm FD}(\beta(z-\mu)) \text{ and } \left| \oint \right| := \frac{1}{2\pi} \int_{\Gamma} dz |f_{\rm FD}(\beta(z-\mu))|$$
(46)

through out the paper.

Now, we are ready to compute the linearization of (8). By the resolvent identity

$$(z-A)^{-1} - (z-B)^{-1} = (z-A)^{-1}(A-B)(z-B)^{-1}$$
(47)

for any operators A, B on $L^2(\mathbb{R}^3)$, the linear operator (linearized at $\varphi = 0$) of the REHF equation (8) can be seen to be

$$L = -\frac{1}{4\pi}\Delta + M \text{ where } M \text{ is defined in (25) and}$$
$$Mf = -\operatorname{den} \frac{1}{2\pi i} \int_{\Gamma} dz f_{\rm FD} (\beta (z-\mu)) (z+\Delta)^{-1} f(z+\Delta)^{-1}.$$
(48)

Notice that we state (48) for $f \in L^2_x$, it is also valid for $f \in L^{\infty}_{\omega}L^2_x$ with any fixed realization ω .

One can verify that $M \ge 0$ is non-negative. The main result of this section is Lemma 6 which yields an explicit formula for M.



Figure 1: We identify the complex plane \mathbb{C} with \mathbb{R}^2 via z = x + iy for $(x, y) \in \mathbb{R}^2$ in the diagram above. The contour Γ is denoted by the blue dashed line, extending to positive real infinity. The spectrum of $-\Delta - \varphi$ is contained in the solid black line.

Lemma 6. Assume that $\mu > 0$, then on $L^2(\mathbb{R}^3)$,

$$M = \frac{1}{8\pi^2} \frac{1}{|\nabla|} \int_0^\infty \ln\left(\left|\frac{\sqrt{4t} + |\nabla|}{\sqrt{4t} - |\nabla|}\right|\right) f_{\rm FD}(\beta(t-\mu)) dt.$$
(49)

Before we start the proof for Lemma 6, we state and prove a preliminary estimate for M below.

Lemma 7. M is bounded on $L_w^{\infty} L_x^2$.

Proof. First, we make the important remark that the branch cut of any relevant complex function in the rest of the paper is taken to be the negative real axis. For $z \in \mathbb{C}$, we consider the associated branch cut of $\sqrt{-z}$, and the integral kernel of $(z - (-\Delta))^{-1}$ is

$$g_z(x-y) = -\frac{1}{4\pi} \frac{e^{-\sqrt{-z}|x-y|}}{|x-y|}.$$
(50)

Then by (48),

$$Mf = -\oint dz g_z^2 * f. \tag{51}$$

We note that $g_z^2(r) = \frac{1}{16\pi^2} \frac{e^{-2\sqrt{-z}|r|}}{|r|^2}$ is $L^1(\mathbb{R}^3)$ and $f_{\text{FD}}(\beta(z-\mu))$ decays exponentially in $\beta \Re(z-\mu)$ as $\Re z \to \infty$. It follows by Young's inequality that

$$\|Mf\|_{L^{\infty}_{\omega}L^2_x} \lesssim \|f\|_{L^{\infty}_{\omega}L^2_x}.$$
(52)

Proof of Lemma 6. The ideas of this proof is based on an unpublished manuscript of I. Chenn and I. M. Sigal. Let $g_z(x-y)$ be the integral kernel of $(z - (-\Delta))^{-1}$ as in (50). It follows that

$$(z+\Delta)^{-1}\varphi(z+\Delta)^{-1}(x,x) = \frac{1}{16\pi^2} \int dy \frac{e^{-2\sqrt{-z}|x-y|}}{|x-y|^2}\varphi(y)$$
(53)

for any sufficiently regular φ . To evaluate (53), we Fourier transform $\frac{e^{-2\sqrt{-z}|x|}}{|x|^2}$:

$$\int \frac{e^{-2\sqrt{-z}|x|}}{|x|^2} e^{-ix \cdot p} dx = \int_0^\infty dr \int_0^\pi d\theta \int_0^{2\pi} d\varphi \frac{e^{-2r\sqrt{-z}}}{r^2} e^{-i\cos(\theta)r|p|} r^2 \sin(\theta)$$
(54)

$$=4\pi \int_{0}^{\infty} dr \frac{\sin(r|p|)}{r|p|} e^{-2r\sqrt{-z}}$$
(55)

$$=\frac{4\pi \arctan(|p|/\sqrt{-4z})}{|p|}.$$
(56)

By (51), (53), and (56),

$$M = -\frac{1}{8\pi^2} \frac{1}{|\nabla|i|} \int_{\Gamma'} f_{\rm FD}(\beta(z-\mu)) \arctan(|\nabla|/\sqrt{-4z}), \tag{57}$$

where the contour Γ' is homeomorphic to Γ (see Figture 1) and is defined as follows. Let $0 < \alpha < \beta^{-1}$ be small and L[a, b] denote the line segment connecting $a, b \in \mathbb{C}$. Then, $\Gamma' = L[\infty + i\alpha, -\alpha + i\alpha] \cup L[-\alpha + i\alpha, -\alpha - i\alpha] \cup L[-\alpha - i\alpha, \infty - i\alpha]$.

Next, we simplify (57) by taking $\alpha \to 0$. For ease of notation, we will denote both $|\nabla|$ and an arbitrary point in its spectrum by p. We note that

$$\arctan(z) = \frac{i}{2} \left(\log(1 - iz) - \log(1 + iz) \right), \tag{58}$$

where log has the branch cut $(-\infty, 0]$. Moreover, for any p > 0 fixed, the integrand

$$f_{\rm FD}(\beta(z-\mu)) \arctan(p/\sqrt{-4z})$$

has singularities contained in $[0, \infty] \cup (\mu + i\beta^{-1}(2\mathbb{Z} + 1))$, otherwise it is holomorphic near the real axis. Let $0 < \alpha$ be small. These observations justify our computation of the integral along another contour which we explicitly parameterize as:

$$\gamma_1(t) = t + \alpha i, t \in (-\alpha, \infty), \tag{59}$$

$$\gamma_2(t) = t - \alpha i, t \in (-\alpha, \infty), \tag{60}$$

$$\gamma_3(t) = -\alpha + it, t \in (-\alpha, \alpha).$$
(61)

Note that by holomorphicity outside of the singularity of the integrand, the value of the integral is independent of α . Hence we may take $\alpha \to 0$. For notation, let $f(z) = f_{\rm FD}(\beta(z-\mu))$ and for any path $\gamma : [a,b] \to \mathbb{C}$, let γ^{-1} denote the same path traversed backward. Ignoring pre-factors constants, computing the contour integral (57) along γ_1^{-1} and γ_2 , one has

$$-\frac{1}{8\pi^2} \frac{1}{pi} \int_{-\alpha}^{\infty} f(t - i\alpha) \arctan(p/\sqrt{-4(t - i\alpha)}) - f(t + i\alpha) \arctan(p/\sqrt{-4(t + i\alpha)}) dt = -\frac{1}{8\pi^2} \frac{1}{pi} \int_{-\alpha}^{\infty} f(t - i\alpha) \arctan(p/\sqrt{-4t + 4i\alpha}) - f(t + i\alpha) \arctan(p/\sqrt{-4t - 4i\alpha}) dt.$$
(62)

Since f(x) is continuous away from its poles and exponentially decaying for $\Re z > \mu$, in the limit $\alpha \to 0$, it suffices for us to compute

$$\int_{-\alpha}^{\infty} f(t) \left(\arctan(p/\sqrt{-4t+4i\alpha}) - \arctan(p/\sqrt{-4t-4i\alpha}) \right) dt$$
 (63)

in place of (62). We split the integral in (63) into

$$\int_{-\alpha}^{\frac{1}{4}p^2} + \int_{\frac{1}{4}p^2}^{\infty}.$$
 (64)

We compute the first integral in (64) and assume that $t < \frac{1}{4}p^2$. We note that

$$\frac{2}{i} \left(\arctan(p/\sqrt{-4t+4i\alpha}) - \arctan(p/\sqrt{-4t-4i\alpha}) \right) \\ = \log\left(1 - i\frac{p}{\sqrt{-4t+4i\alpha}}\right) - \log\left(1 - i\frac{p}{\sqrt{-4t-4i\alpha}}\right) \\ + \log\left(1 + i\frac{p}{\sqrt{-4t-4i\alpha}}\right) - \log\left(1 + i\frac{p}{\sqrt{-4t+4i\alpha}}\right).$$
(65)

Since $t, \alpha > 0$, to keep track of the jump discontinuity in log, let us write,

$$\frac{ip}{\sqrt{-4t \pm 4i\alpha}} = \frac{ip}{\pm i\sqrt{4t}\sqrt{1 \mp i\frac{\alpha}{t}}} = \pm \frac{p}{\sqrt{4t}} \left(1 \mp i\frac{\alpha}{t}\right)^{-1/2} \tag{66}$$

for $t \ge 0$. Denote $\delta_{\pm} = \pm \frac{p}{\sqrt{4t}}((1 \mp i\frac{\alpha}{t})^{-1/2} - 1)$. Hence

$$1 - \frac{ip}{\sqrt{-4t \pm 4i\alpha}} = 1 \mp \frac{p}{\sqrt{4t}} - \delta_{\pm}.$$
 (67)

We note that $\delta_{\pm} \to 0$ as $\alpha \to 0$ and δ_{+} and δ_{-} are in the upper half-plane. Since $t < \frac{1}{4}p^2$, using $\lim_{b\to 0^{\pm}} \log(-a+ib) = \log(a) \pm i\pi$ for a > 0, we see that

$$\lim_{\alpha \to 0} \log\left(1 - \frac{ip}{\sqrt{-4t + 4i\alpha}}\right) = \log\left(\frac{p}{\sqrt{4t}} - 1\right) - i\pi \tag{68}$$

and similarly

$$\lim_{\alpha \to 0} \log\left(1 - \frac{ip}{\sqrt{-4t - 4i\alpha}}\right) = \log\left(\frac{p}{\sqrt{4t}} + 1\right).$$
(69)

So we have that

$$\lim_{\alpha \to 0} \log\left(1 - \frac{ip}{\sqrt{-4t + 4i\alpha}}\right) - \log\left(1 - \frac{ip}{\sqrt{-4t - 4i\alpha}}\right) = \log\left(\frac{p}{\sqrt{4t}} - 1\right) - \log\left(\frac{p}{\sqrt{4t}} + 1\right) - i\pi.$$
(70)

By the same token, and since $t < \frac{1}{4}p^2$,

$$1 + \frac{ip}{\sqrt{-4t \pm 4i\alpha}} = 1 \pm \frac{p}{\sqrt{4t}} + \delta_{\pm}.$$
(71)

Using $\lim_{b\to 0^{\pm}} \log(-a+ib) = \log(a) \pm i\pi$ for a > 0, we see that

$$\lim_{\alpha \to 0} \log\left(1 + \frac{ip}{\sqrt{-4t - 4i\alpha}}\right) = \log\left(\frac{p}{\sqrt{4t}} - 1\right) + i\pi,\tag{72}$$

and similarly

$$\lim_{\alpha \to 0} \log\left(1 + \frac{ip}{\sqrt{-4t + 4i\alpha}}\right) = \log\left(\frac{p}{\sqrt{4t}} + 1\right).$$
(73)

So we have that

$$\lim_{\alpha \to 0} \log\left(1 + \frac{ip}{\sqrt{-4t - 4i\alpha}}\right) - \log\left(1 + \frac{ip}{\sqrt{-4t + 4i\alpha}}\right)$$
$$= \log\left(\frac{p}{\sqrt{4t}} - 1\right) - \log\left(\frac{p}{\sqrt{4t}} + 1\right) + i\pi. \quad (74)$$

It follows by (65), (70), (74) that

$$\lim_{\alpha \to 0} \arctan(p/\sqrt{-4t + 4i\alpha}) - \arctan(p/\sqrt{-4t - 4i\alpha}) = i\left(\log\left(\frac{p}{\sqrt{4t}} - 1\right) - \log\left(\frac{p}{\sqrt{4t}} + 1\right)\right).$$
(75)

Hence, in the limit $\alpha \to 0$, the γ_1^{-1}, γ_2 portion of the first integral in (64) is

$$\int_{0}^{p^{2}/4} = i \int_{0}^{p^{2}/4} \left(\log\left(\frac{p}{\sqrt{4t}} - 1\right) - \log\left(\frac{p}{\sqrt{4t}} + 1\right) \right) f(t) dt$$
$$= -i \int_{0}^{p^{2}/4} \log\left(\frac{p + \sqrt{4t}}{p - \sqrt{4t}}\right) f(t) dt.$$
(76)

Now we consider the second integral in (64). In this case, for $t > p^2/4$,

$$\frac{2}{i} \left(\arctan\left(\frac{p}{\sqrt{-4t+4i\alpha}}\right) - \arctan\left(\frac{p}{\sqrt{-4t-4i\alpha}}\right) \right)$$
$$= \log\left(1 - i\frac{p}{\sqrt{-4t+4i\alpha}}\right) - \log\left(1 - i\frac{p}{\sqrt{-4t-4i\alpha}}\right)$$
$$+ \log\left(1 + i\frac{p}{\sqrt{-4t-4i\alpha}}\right) - \log\left(1 + i\frac{p}{\sqrt{-4t+4i\alpha}}\right). \quad (77)$$

Via the same argument as (75), we get

$$\arctan(p/\sqrt{-4t+4i\alpha}) - \arctan(p/\sqrt{-4t-4i\alpha}) \longrightarrow i\left(\log\left(1-\frac{p}{\sqrt{4t}}\right) - \log\left(1+\frac{p}{\sqrt{4t}}\right)\right) = i\log\left(\frac{\sqrt{4t}-p}{\sqrt{4t}+p}\right)$$
(78)

as $\alpha \to 0$. Putting it as the integrand for the second integral in (64), we get

$$\int_{p^{2}/4}^{\infty} = i \int_{p^{2}/4}^{\infty} \log\left(\frac{\sqrt{4t} - p}{\sqrt{4t} + p}\right) f(t)dt = -i \int_{p^{2}/4}^{\infty} \log\left(\frac{\sqrt{4t} + p}{\sqrt{4t} - p}\right) f(t)dt.$$
(79)

It follows that by (57) and (62)

$$M = -\frac{1}{8\pi^2} \frac{1}{pi} \int_0^{p^2/4} f(t) \left(\arctan(p/\sqrt{-4t+4i\alpha}) - \arctan(p/\sqrt{-4t-4i\alpha}) \right) dt - \frac{1}{8\pi^2} \frac{1}{pi} \int_{p^2/4}^{\infty} f(t) \left(\arctan(p/\sqrt{-4t+4i\alpha}) - \arctan(p/\sqrt{-4t-4i\alpha}) \right) dt = -\frac{1}{8\pi^2} \frac{1}{pi} \left[-i \int_0^{p^2/4} \log\left(\frac{p+\sqrt{4t}}{p-\sqrt{4t}}\right) f(t) dt \right] - \frac{1}{8\pi^2} \frac{1}{pi} \left[-i \int_{p^2/4}^{\infty} \log\left(\frac{\sqrt{4t}+p}{\sqrt{4t}-p}\right) f(t) dt \right] = \frac{1}{8\pi^2} \frac{1}{p} \int_0^{\infty} \log\left(\left|\frac{\sqrt{4t}+p}{\sqrt{4t}-p}\right|\right) f(t) dt, \quad (80)$$

which is (49). The proof of Lemma 6 is now complete.

4.2 Lower bound of L on $L^2(\mathbb{R}^3)$

Theorem 8. The operator L given in (48) is bounded below on $L^2(\mathbb{R}^3)$ by

$$L \ge c_0(-\Delta + m_*) \tag{81}$$

where $c_0 > 0$ is a universal constant and

$$m_* = \min(\mu, \sqrt{\mu}). \tag{82}$$

Proof. Let $p = |\nabla|$. By elementary calculus, we have the following two estimates

$$\ln\left|\frac{x+1}{x-1}\right| > 2x \text{ for } x < 1 \tag{83}$$

$$\ln\left|\frac{x+1}{x-1}\right| > \frac{2}{x} \text{ for } x > 1.$$

$$(84)$$

In the eigenspace with $p^2/4 < \mu$, we use $f_{\rm FD}(\beta(t-\mu)) \geq \frac{1}{2}\chi_{[0,\mu]}$, where χ_S is the indicator function on $S \subset \mathbb{R}$. For a particular $p^2/4 < \mu$ fixed, equation (49) shows

$$M \gtrsim \int_{0}^{p^{2}/4} \frac{\sqrt{t}}{p^{2}} + \int_{p^{2}/4}^{\mu} \frac{1}{\sqrt{t}}$$
(85)

$$= \frac{1}{p^2} \frac{2}{3} t^{3/2} \Big|_{0}^{p^2/4} + 2t^{1/2} \Big|_{p^2/4}^{\mu}$$
(86)

$$\geq \frac{1}{6}\sqrt{\mu}.$$
(87)

On the other hand, in the eigenspace with $p^2/4 \ge \mu$, we use $L = \frac{1}{8\pi}p^2 + (\frac{1}{8\pi}p^2 + M) \ge \frac{1}{8\pi}p^2 + (\frac{1}{8\pi}p^2)$. We see that $\frac{1}{8\pi}p^2 \gtrsim \mu$. Combining with (87), Theorem 8 is proved. \Box

4.3 Lower bound for L on $L_w^{\infty} L_x^2$: proof of Theorem **4**

By Lemma 7, L is bounded operator on $L_w^{\infty} L_x^2$. In this subsection, we want to extend the lower bound (81) also to $L_w^{\infty} L_x^2$. From this subsection on, we will deal with two types of Laplacians: the usual Laplacian $-\Delta$ on $L_x^2(\mathbb{R}^3)$, and the stationary Laplacian $-\Delta_s$ on $L_\omega^2 L_x^2$. The stationary Laplacian is simply the usual Laplacian in x variables, acting on $L^2(\Omega \times Q)$, with stationary boundary conditions on $Q \subset \mathbb{R}^3$. The properties of the stationary Laplacian $-\Delta_s$ have been studied in e.g., [10], see also in Section 3.1 of [4]. We may frequently drop the lower index s and denote by $-\Delta_s = -\Delta$ when there is no ambiguity, especially when the random realization ω is fixed (almost surely). Proof of Theorem 4. Let Q be a fundamental domain of \mathcal{L} and $f \in L^{\infty}_{\omega}L^2_x$ and $C^2_c(Q)$ denote the set of compactly supported C^2 function on Q. Then

$$\|(-\frac{1}{4\pi}\Delta_s + M)f\|_{L^{\infty}_{\omega}L^2_x} := \sup_{\omega \in \Omega} \|(-\frac{1}{4\pi}\Delta_s + M)f\|_{L^2(Q)}$$
(88)

$$= \sup_{\omega \in \Omega} \sup_{\psi \in C_c^2(Q)} \frac{\langle \psi, (-\frac{1}{4\pi}\Delta_s + M)f \rangle_{L^2(Q)}}{\|\psi\|_{L^2(Q)}}.$$
 (89)

The goal is to choose a nice ψ for a lower bound. Intuitively, we should choose $\psi = (-\frac{1}{4\pi}\Delta_s + M)^{-1}f$. We accomplish this in 5 steps below.

For notation simplicity below, we will first fix ω and follow (46) and also use

$$r(z) := (z + \Delta)^{-1}.$$
 (90)

In this notation, the linear operator is

$$Lf = -\frac{1}{4\pi}\Delta f + Mf = -\frac{1}{4\pi}\Delta f - \operatorname{den}\oint r(z)fr(z).$$

Step 1: Move $-\frac{1}{4\pi}\Delta + M$ onto ψ .

We have a solid understanding of $-\frac{1}{4\pi}\Delta + M$ on $L^2(\mathbb{R}^3)$ functions; so we would like to use it. Since $\psi \in C_c^2(Q)$, we see that

$$\langle \psi, (-\frac{1}{4\pi}\Delta)f \rangle_{L^2(Q)} = \langle (-\frac{1}{4\pi}\Delta)\psi, f \rangle_{L^2(Q)}.$$
(91)

Using the definition (48) of M, we see that

$$\langle \psi, Mf \rangle_{L^2(Q)} = -\oint \operatorname{Tr} \bar{\psi}r(z)fr(z) = -\oint \operatorname{Tr} \overline{r(\bar{z})\psi r(\bar{z})}f = \langle M\psi, f \rangle_{L^2(\mathbb{R}^3)}$$
(92)

by the cyclicity of trace and the fact the contour Γ can be chosen to be invariant under complex conjugation. We remark that since $\psi \in C_c^2(Q)$, Tr is taken to be the trace on $L^2(\mathbb{R}^3)$ instead of $L^2(Q)$. By equations (91) and (92), we see that

$$\langle \psi, \left(-\frac{1}{4\pi}\Delta + M\right)f \rangle_{L^2(Q)} = \langle \left(-\frac{1}{4\pi}\Delta + M\right)\psi, f \rangle_{L^2(\mathbb{R}^3)}.$$
(93)

Step 2: choosing ψ .

By Theorem 8, $-\frac{1}{4\pi}\Delta + M$ is bounded from below on $L^2(\mathbb{R}^3)$. One has

$$\|(-\frac{1}{4\pi}\Delta + M)g\|_{L^2(\mathbb{R}^3)} \ge c_0 \|(-\Delta + m_*)g\|_{L^2(\mathbb{R}^3)} \ge c_0 m_* \|g\|_{H^2(\mathbb{R}^3)}.$$

In particular, $-\frac{1}{4\pi}\Delta + M$ is invertible and

$$\|(-\frac{1}{4\pi}\Delta + M)^{-1}(f|_Q)\|_{H^2(\mathbb{R}^3)} \le c_0^{-1}m_*^{-1}\|f|_Q\|_{L^2(\mathbb{R}^3)}.$$
(94)

Thus, we choose

$$\psi := \chi(-\frac{1}{4\pi}\Delta + M)^{-1}(f|_Q), \tag{95}$$

where χ is a compactly supported bump function on Q whose exact properties will be determined later and $f|_Q$ is the restriction of f to Q. We remark that despite the fact that ψ may not be in $C_c^2(Q)$, it can be approximated arbitrarily close in the H^2 norm by functions from $C_c^2(Q)$. Thus, it causes no disruption to our proof to consider ψ instead of a proper $C_c^2(Q)$ function. Moreover, this choice of ψ satisfies (91). It follows that

$$(-\frac{1}{4\pi}\Delta + M)\psi = \chi f \mid_Q + [-\frac{1}{4\pi}\Delta + M, \chi](-\frac{1}{4\pi}\Delta + M)^{-1}(f \mid_Q).$$
(96)

Combining with (93), we see that

$$\langle \psi, (-\frac{1}{4\pi}\Delta + M)f \rangle_{L^2(Q)}$$

= $\|\chi^{1/2}f\|_{L^2(Q)}^2 + \langle [-\frac{1}{4\pi}\Delta + M, \chi](-\frac{1}{4\pi}\Delta + M)^{-1}(f|_Q), f \rangle_{L^2(\mathbb{R}^3)}.$ (97)

We estimate the second term in (97) below.

Step 3: Error estimates for $[\Delta, \chi]$ term. A simple computation shows that

$$[-\Delta, \chi] = -2\nabla\chi \cdot \nabla - \Delta\chi.$$
(98)

Using Theorem 8 once more and the fact χ is supported in Q, it follows that

$$\begin{aligned} |\langle [-\Delta, \chi] (-\frac{1}{4\pi} \Delta + M)^{-1} (f \mid_Q), f \rangle_{L^2(\mathbb{R}^3)} | &= |\langle [-\Delta, \chi] (-\frac{1}{4\pi} \Delta + M)^{-1} (f \mid_Q), f \rangle_{L^2(Q)} | \\ &\leq \left| \langle 2 \nabla \chi \cdot \nabla (-\frac{1}{4\pi} \Delta + M)^{-1} (f \mid_Q), f \rangle_{L^2(Q)} \right| + \left| \langle \Delta \chi (-\frac{1}{4\pi} \Delta + M)^{-1} (f \mid_Q), f \rangle_{L^2(Q)} \right| \\ &\leq 2 \| \nabla \chi \|_{L^{\infty}} \| \nabla (-\frac{1}{4\pi} \Delta + M)^{-1} (f \mid_Q) \|_{L^2(Q)} \| f \|_{L^2(Q)} \\ &+ \| \Delta \chi \|_{L^{\infty}} \| (-\frac{1}{4\pi} \Delta + M)^{-1} (f \mid_Q) \|_{L^2(Q)} \| f \|_{L^2(Q)} \\ &\leq 2 \| \nabla \chi \|_{L^{\infty}} c_0^{-1} m_*^{-1} \| f \|_{L^2(Q)}^2 + \| \Delta \chi \|_{L^{\infty}} c_0^{-1} m_*^{-1} \| f \|_{L^2(Q)}^2 \\ &= c_0^{-1} m_*^{-1} \Big(2 \| \nabla \chi \|_{L^{\infty}} + \| \Delta \chi \|_{L^{\infty}} \Big) \| f \|_{L^2(Q)}^2 \tag{99}$$

where c_0, m_* are given in (82) and we used (94).

Step 4: Error estimates for $[M, \chi]$ term.

Let $u \in L^2(\mathbb{R}^3)$ and $v \in L^2_{\text{loc}}(\mathbb{R}^3)$. Then

$$\langle [M,\chi]u,v\rangle_{L^2(\mathbb{R}^3)} = \oint \operatorname{Tr} r(z)\chi ur(z)v - \chi r(z)ur(z)v$$
(100)

$$=\oint \operatorname{Tr}[r(z),\chi]ur(z)v \tag{101}$$

$$=\oint \operatorname{Tr} r(z)(2\nabla\chi\nabla + \Delta\chi)r(z)ur(z)v.$$
(102)

By the cyclicity of trace, we move r(z) to the right of v to obtain

$$\langle [M,\chi]u,v\rangle_{L^2(\mathbb{R}^3)} = \oint \operatorname{Tr}(2\nabla\chi\nabla + \Delta\chi)r(z)ur(z)vr(z).$$
(103)

Since χ is supported on Q, we may write

$$\langle [M,\chi]u,v\rangle_{L^2(\mathbb{R}^3)} = \oint \operatorname{Tr} \mathbf{1}_Q (2\nabla\chi\nabla + \Delta\chi)r(z)ur(z)vr(z)\mathbf{1}_Q,$$
(104)

where $\mathbf{1}_Q$ is the indicator function of the set Q. Let g_z be the integral kernel of $r(z) = (z + \Delta)^{-1}$ on $L^2(\mathbb{R}^3)$ and recall the definition of $|\oint|$ from (46). Writing (104) out explicitly in terms of integral kernels, we obtain

$$\begin{aligned} |\langle [M,\chi]u,v\rangle_{L^{2}(\mathbb{R}^{3})}| &\leq 2(\|\nabla\chi\|_{L^{\infty}} + \|\Delta\chi\|_{L^{\infty}}) \\ \times \left|\oint \left|\int_{Q} dx \int_{\mathbb{R}^{3+3}} dy_{1} dy_{2}|(1+\nabla)g_{z}(x-y_{1})u(y_{1})g_{z}(y_{1}-y_{2})v(y_{2})g_{z}(y_{2}-x)|. \end{aligned} \right|$$
(105)

Using a change of variable $y_1 \mapsto y_1 + x$ and $y_2 \mapsto y_2 + x$, we see that

$$\left|\oint \left|\int_{Q} dx \int_{\mathbb{R}^{3+3}} dy_1 dy_2 |(1+\nabla)g_z(x-y_1)u(y_1)g_z(y_1-y_2)v(y_2)g_z(y_2-x)|\right.\right.$$
$$= \left|\oint \left|\int_{Q} dx \int_{\mathbb{R}^{3+3}} dy_1 dy_2 |(1+\nabla)g_z(y_1)u(y_1+x)g_z(y_1-y_2)v(y_2+x)g_z(y_2)|\right. (106)$$

Applying Hölder with $\frac{1}{2} + \frac{1}{2} = 1$ to the dx integral, we see that

$$\begin{split} \left| \oint \left| \int_{Q} dx \int_{\mathbb{R}^{3+3}} dy_{1} dy_{2} | (1+\nabla) g_{z}(y_{1}) u(y_{1}+x) g_{z}(y_{1}-y_{2}) v(y_{2}+x) g_{z}(y_{2}) \right| \right| \\ & \leq \left| \oint \right| \int_{\mathbb{R}^{3+3}} dy_{1} dy_{2} | (1+\nabla) g_{z}(y_{1}) g_{z}(y_{1}-y_{2}) g_{z}(y_{2}) | || u||_{L^{2}(Q+y_{1})} || v||_{L^{2}(Q+y_{2})} \\ & \leq \left| \oint \right| \int_{\mathbb{R}^{3+3}} dy_{1} dy_{2} | (1+\nabla) g_{z}(y_{1}) g_{z}(y_{1}-y_{2}) g_{z}(y_{2}) | || u||_{L^{2}(\mathbb{R}^{3})} || v||_{L^{2}(Q+y_{2})}. \end{split}$$
(107)

We specialize to $u = (-\frac{1}{4\pi}\Delta + M)^{-1}(f|_Q)$ and v = f. By Theorem 8, we note that

$$|u||_{L^{2}(\mathbb{R}^{3})} \leq c_{0}^{-1} m_{*}^{-1} ||f||_{L^{2}(Q)}, \qquad (108)$$

where c_0, m_* are given in (82). Combining (105), (106), (107), and (108), we see that

$$\sup_{\omega \in \Omega} |\langle [M, \chi] u, v \rangle_{L^{2}(\mathbb{R}^{3})} |
\leq 2c_{0}^{-1} m_{*}^{-1} (\|\nabla \chi\|_{L^{\infty}} + \|\Delta \chi\|_{L^{\infty}}) \|f\|_{L^{\infty}_{\omega} L^{2}_{x}}
\times \left| \oint \left| \int_{\mathbb{R}^{3+3}} dy_{1} dy_{2} |(1+\nabla) g_{z}(y_{1}) g_{z}(y_{1}-y_{2}) g_{z}(y_{2}) | \sup_{\omega \in \Omega} \|f\|_{L^{2}(Q+y_{2})}. \quad (109)$$

Let

$$A = 2c_0^{-1}(\|\nabla\chi\|_{L^{\infty}} + \|\Delta\chi\|_{L^{\infty}}).$$
(110)

Recall the definition of g_z in (50). It is easy to verify that $g_z \in W^{1,1}(\mathbb{R}^3)$, and $|||g_z|*|g_z|||_{L^{\infty}} \lesssim ||g_z||_{L^2}^2$. Since the $L^{\infty}_{\omega} L^2_x$ norm is independent of the location of the domain of integration, we see that

$$\sup_{\omega \in \Omega} |\langle [M, \chi] u, v \rangle_{L^2(\mathbb{R}^3)} | \le m_*^{-1} A \| f \|_{L^{\infty}_{\omega} L^2_x}^2 \left| \oint \right| \langle |(1 + \nabla) g_z|, |g_z| * |g_z| \rangle_{L^2(\mathbb{R}^3)}$$
(111)

$$\leq m_*^{-1} A \|f\|_{L^{\infty}_{\omega}L^2_x}^2 \left| \oint \left| \left\| |g_z| * |g_z| \right\|_{L^{\infty}} \|(1+\nabla)g_z\|_{L^1(\mathbb{R}^3)} \right|$$
(112)

$$\leq m_*^{-1} A \|f\|_{L^{\infty}_{\omega}L^2_x}^2 \left| \oint \right| \left\| \|g_z\|_{L^2(\mathbb{R}^3)}^2 \|g_z\|_{W^{1,1}(\mathbb{R}^3)}$$
(113)

$$=:m_*^{-1}AC_{\beta,\mu}\|f\|_{L^{\infty}_{\omega}L^2_x}^2,$$
(114)

where

$$C_{\beta,\mu} = \left| \oint \right| \left\| \|g_z\|_{L^2(\mathbb{R}^3)}^2 \|g_z\|_{W^{1,1}(\mathbb{R}^3)} < \infty.$$
(115)

Step 5: Conclusion

By definition (95) and (94), we see that

$$\|\psi\|_{L^2(Q)} \le c_0^{-1} m_*^{-1} \|f\|_{L^2(Q)}.$$
(116)

Combining with equations (97), (99), and (114) to obtain

$$\sup_{\omega \in \Omega} \frac{\langle \psi, (-\frac{1}{4\pi}\Delta_s + M)f \rangle_{L^2(Q)}}{\|\psi\|_{L^2(Q)}} \ge c_0 m_* \sup_{\omega \in \Omega} \frac{\|\chi^{1/2}f\|_{L^2(Q)}^2}{\|f\|_{L^2(Q)}} - 2C_{\beta,\mu}A\|f\|_{L^{\infty}_{\omega}L^2_x}.$$
 (117)

Choose $\omega_0 \in \Omega$ so that

$$\|f_{\omega_0}\|_{L^2(Q)}^2 \ge \frac{1}{2} \sup_{\omega \in \Omega} \|f_{\omega}\|_{L^2(Q)}^2.$$
(118)

Assuming Q is a cube centered at the origin (or by a shift and choosing a different fundamental domain if necessary), we can find a subcube $Q' \subset Q$ with half the diameter, such that

$$\|f_{\omega_0}\|_{L^2(Q')}^2 \ge \frac{1}{2^3} \|f_{\omega_0}\|_{L^2(Q)}^2.$$
(119)

We can translation Q' to be concentric to Q by $h \in \mathbb{R}^3$ so that

$$\|T_h f_{\omega_0}\|_{L^2(Q/2)}^2 \ge \frac{1}{2^3} \|f_{\omega_0}\|_{L^2(Q)}^2, \tag{120}$$

where T_h is the translation by h and Q/2 is the concentric cube to Q with half the side length. Thus, we can choose bump functions χ by a translation and a dilation from a reference O(1) bounded C_c^{∞} function so that $\chi \mid_{Q/2} = 1$ and

$$\|\nabla^m \chi\|_{L^{\infty}} \le C_1 \ell(Q)^{-m},\tag{121}$$

where C_1 is independent of the size of Q and $\ell(Q)$ is the diameter of Q. Since the operator $-\frac{1}{4\pi}\Delta_s + M$ is translation invariant, and the $L_w^{\infty}L_x^2$ norm is independent of the choice of Q, we may replace f by any translations of f. In doing so to (117) and using (118), (120), and the fact $\chi |_{Q/2} = 1$, we obtain

$$c_{0}m_{*}\sup_{\omega\in\Omega}\frac{\|\chi^{1/2}T_{h}f\|_{L^{2}(Q)}^{2}}{\|T_{h}f\|_{L^{2}(Q)}} - 2AC_{\beta,\mu}\|T_{h}f\|_{L^{\infty}_{\omega}L^{2}_{x}}$$

$$\geq c_{0}m_{*}\sup_{\omega\in\Omega}\frac{\|T_{h}f\|_{L^{2}(Q/2)}^{2}}{\|T_{h}f\|_{L^{2}(Q)}} - 2AC_{\beta,\mu}\|f\|_{L^{\infty}_{\omega}L^{2}_{x}}$$

$$\geq c_{0}m_{*}\frac{\|T_{h}f_{\omega_{0}}\|_{L^{2}(Q/2)}^{2}}{\|f\|_{L^{\infty}_{\omega}L^{2}_{x}}} - 2AC_{\beta,\mu}\|f\|_{L^{\infty}_{\omega}L^{2}_{x}}$$

$$\geq \left(\frac{c_{0}m_{*}}{2^{4}} - 2AC_{\beta,\mu}\right)\|f\|_{L^{\infty}_{\omega}L^{2}_{x}}.$$
(122)

It follows by translation invariance of $-\frac{1}{4\pi}\Delta_s + M$ and Q-independence of the $L^{\infty}_{\omega}L^2_x$ norm, (89), (117), (121), and (122),

$$\|(-\frac{1}{4\pi}\Delta_{s}+M)f\|_{L^{\infty}_{\omega}L^{2}_{x}} = \|(-\frac{1}{4\pi}\Delta_{s}+M)T_{h}f\|_{L^{\infty}_{\omega}L^{2}_{x}}$$

$$\geq \sup_{\omega\in\Omega}\frac{\langle\psi,(-\frac{1}{4\pi}\Delta_{s}+M)T_{h}f\rangle_{L^{2}(Q)}}{\|\psi\|_{L^{2}(Q)}}$$

$$\geq \left(\frac{c_{0}m_{*}}{16}-C_{\beta,\mu}\ell(Q)^{-1}\right)\|f\|_{L^{\infty}_{\omega}L^{2}_{x}},$$
(123)

where $C_{\beta,\mu}$ is a constant multiple of the one defined in (115). This proves Theorem 4.

5 Nonlinear estimate

Proof of Theorem 5. By the resolvent identity in (47) and using the Cauchy-integral, we arrive at an explicit formula for N (see (26)):

$$N(\varphi) := \operatorname{den} \oint (z - (-\Delta - \varphi))^{-1} \varphi(z + \Delta)^{-1} + M\varphi, \qquad (124)$$

where \oint is defined through (46).

Applying the resolvent identity (47) to (124) repeatedly with $A = -\Delta - \varphi$ and $B = -\Delta$, we arrive at

$$N(\varphi) = \sum_{n \ge 2} (-1)^{n-1} \oint \det(z + \Delta)^{-1} (\varphi(z + \Delta)^{-1})^n,$$
(125)

whenever the series converges in $L^{\infty}_{\omega}L^2_x$. Our goal is to estimate the difference in the individual *n*-th order nonlinearities. That is, let

$$N_n(\varphi) := (-1)^{n-1} \oint \det(z + \Delta)^{-1} (\varphi(z + \Delta)^{-1})^n.$$
 (126)

We would like to estimate $N_n(\varphi_1) - N_n(\varphi_2)$. To do so, we use

$$a^{b} - b^{n} = (a - b)b^{n-1} + a(a - b)b^{n-2} + \dots + a^{n-1}(a - b).$$
 (127)

Applying this to the *n*-fold products of resolvents in $N_n(\varphi_1)$ and $N_n(\varphi_2)$, and writing out the first term explicitly, we see that

$$N_{n}(\varphi_{1}) - N_{n}(\varphi_{2}) = (-1)^{n-1} \oint \operatorname{den}(z + \Delta)^{-1} \Big((\varphi_{1}(z + \Delta)^{-1})^{n} - (\varphi_{2}(z + \Delta)^{-1})^{n} \Big)$$
(128)

$$= (-1)^{n-1} \oint \operatorname{den} (z + \Delta)^{-1} (\varphi_1 - \varphi_2) (z + \Delta)^{-1} (\varphi_\# (z + \Delta)^{-1})^{n-1}$$
(129)

$$+n-1$$
 similar terms (130)

in the $L^{\infty}_{\omega}L^2_x$ -norm, where $\varphi_{\#}$ denotes φ_1 or φ_2 . Let $g_z(x-y)$ be the integral kernel of $(z+\Delta)^{-1}$ as in (50). Then the *n*-th order (difference in) nonlinearity (128) becomes

$$(N_{n}(\varphi_{1}) - N_{n}(\varphi_{2}))(x)$$

$$= (-1)^{n-1} \oint \int dy_{1} \cdots dy_{n} g_{z}(y_{1}) g_{z}(y_{1} - y_{2}) \cdots g_{z}(y_{n-1} - y_{n}) g_{z}(y_{n})$$

$$\times (\varphi_{1} - \varphi_{2})(x - y_{1}) \prod_{i=2}^{n} \varphi_{\#}(x - y_{i})$$

+n-1 similar terms.

We may take the sup-norm on the factor $\prod_{i=2}^{n-1} \varphi_{\#}(x-y_i)$. Using the notation $|\oint|$ in

(46), we see that

$$\left| (N_n(\varphi_1) - N_n(\varphi_2))(x) \right| \leq \left\| \varphi_{\#} \right\|_{L^{\infty}_{\omega}L^{\infty}_{x}(Q)}^{n-1} \left| \oint \left| \int dy_1 |g_2|(y_1)| \varphi_1 - \varphi_2 |(x - y_1) \underbrace{(|g_2| * \dots * |g_2|)}_{n} (y_1) \right| \right|$$

 $+ \, n - 1$ similar terms

$$= \left\|\varphi_{\#}\right\|_{L^{\infty}_{\omega}L^{\infty}_{x}(Q)}^{n-1} \left|\oint_{\mathbb{R}} \left|k_{z} * |\varphi_{1} - \varphi_{2}| + n - 1 \text{ similar terms} \right|$$
(131)

$$= \left\|\varphi_{\#}\right\|_{L^{\infty}_{\omega}L^{\infty}_{x}(Q)} \left|\oint \left|k_{z} * \left|\varphi_{1} - \varphi_{2}\right| + n - 1 \text{ similar terms}, \right.$$
(132)

where $k_z(x) := |g_z|(x)(|g_z| * \cdots * |g_z|)(x)$. It follows by (131) that

$$\|N_{n}(\varphi_{1}) - N_{n}(\varphi_{2})\|_{L^{2}(Q)} \leq n \|\varphi_{\#}\|_{L^{\infty}_{\omega}L^{\infty}_{x}(Q)}^{n-1} \left| \oint \left\| \|k_{z} * |\varphi_{1} - \varphi_{2}| \|_{L^{2}(Q)} \right\|_{L^{2}(Q)}.$$
(133)

By Hölder's inequality, we note that

$$\begin{aligned} \|k_{z} * |\varphi_{1} - \varphi_{2}\|^{2}_{L^{2}(Q)} &= \int_{Q} dx \left(\int_{\mathbb{R}^{3}} dy k_{z}(x-y) |\varphi_{1} - \varphi_{2}|(y) \right)^{2} \\ &\leq \int_{Q} dx \|k_{z}\|_{L^{1}(\mathbb{R}^{3})} \int_{\mathbb{R}^{3}} dy |k_{z}|(x-y)|\varphi_{1} - \varphi_{2}|^{2}(y) \\ &= \int_{\mathbb{R}^{3}} dy \|k_{z}\|_{L^{1}(\mathbb{R}^{3})} |\varphi_{1} - \varphi_{2}|^{2}(y) \int_{Q} dx |k_{z}|(x-y) \\ &= \|k_{z}\|_{L^{1}(\mathbb{R}^{3})} \int_{\mathbb{R}^{3}} dy |\varphi_{1} - \varphi_{2}|^{2}(y) \|k_{z}\|_{L^{1}(Q-y)} \\ &\leq \|k_{z}\|_{L^{1}(\mathbb{R}^{3})} \sup_{\ell \in \mathcal{L}} \|\varphi_{1} - \varphi_{2}\|^{2}_{L^{2}(Q+\ell)} \sum_{\ell \in \mathcal{L}} \sup_{x \in Q} \|k_{z}\|_{L^{1}(Q-\ell-x)} \\ &\leq 8 \|k_{z}\|^{2}_{L^{1}(\mathbb{R}^{3})} \sup_{\ell \in \mathcal{L}} \|\varphi_{1} - \varphi_{2}\|^{2}_{L^{2}(Q+\ell)}, \end{aligned}$$
(134)

where \mathcal{L} is the Bravais lattice as in (9). And in the last inequality for (134) we used the estimate

$$\sum_{\ell \in \mathcal{L}} \sup_{x \in Q} \|k_z\|_{L^1(Q-\ell-x)} \le \sum_{\ell \in \mathcal{L}} 2^3 \|k_z\|_{L^1(Q-\ell)} \le 2^3 \|k_z\|_{L^1(\mathbb{R}^3)}$$

since for $x \in Q$, $Q - \ell - x$ can be covered by at most 2^3 translated cubes of $Q - \ell$ in \mathbb{R}^3 .

Therefore,

$$\|k_z * |\varphi_1 - \varphi_2|\|_{L^{\infty}_{\omega}L^2(Q)}^2 \le 8 \|\varphi_1 - \varphi_2\|_{L^{\infty}_{\omega}L^2_x(Q)}^2 \|k_z\|_{L^1(\mathbb{R}^3)}^2.$$
(135)

Combining (133) and (134), we arrive at

$$\|N_{n}(\varphi_{1}) - N_{n}(\varphi_{2})\|_{L^{\infty}_{\omega}L^{2}(Q)} \leq 8n \|\varphi_{\#}\|^{n-1}_{L^{\infty}_{\omega}L^{\infty}_{x}(Q)} \|\varphi_{1} - \varphi_{2}\|_{L^{\infty}_{\omega}L^{2}_{x}(Q)} \left|\oint\right| \|k_{z}\|_{L^{1}(\mathbb{R}^{3})}.$$
 (136)

Finally, by definition of k_z below equation (131) and repeated applications of Young's inequality, we note that

$$||k_z||_{L^1(\mathbb{R}^3)} \le ||g_z||_{L^2(\mathbb{R}^3)}^2 ||g_z||_{L^1(\mathbb{R}^3)}^{n-1}.$$
(137)

Define

$$C_{\beta,\mu,n} := \left(8n \left| \oint \right| \|g_z\|_{L^2(\mathbb{R}^3)}^2 \|g_z\|_{L^1(\mathbb{R}^3)}^{n-1} \right)^{1/n} < \infty.$$
(138)

Recall the definition of $|\oint|$ in the (46) and the exponential decay of the Fermi-Dirac f_{FD} as $Rez \to \infty$. We note that $|\oint| ||g_z||_{L^2(\mathbb{R}^3)}^2 ||g_z||_{L^1(\mathbb{R}^3)}^{n-1}$ is integrable with respect to z. Therefore, $C_{\beta,\mu,n}$ is bounded for given β and μ fixed, uniformly in n (since there is a 1/n-th power). Thus, (136) and the Sobolev inequality show

$$\|N_{n}(\varphi_{1}) - N_{n}(\varphi_{2})\|_{L^{\infty}_{\omega}L^{2}(Q)} \leq C^{n}_{\beta,\mu,n} \left(\|\varphi_{1}\|^{n-1}_{L^{\infty}_{\omega}H^{2}_{x}(Q)} + \|\varphi_{2}\|^{n-1}_{L^{\infty}_{\omega}H^{2}_{x}(Q)}\right)\|\varphi_{1} - \varphi_{2}\|_{L^{\infty}_{\omega}H^{2}(Q)}.$$
(139)

By (125), (139), and the assumption that $\|\varphi_{\#}\|_{L^{\infty}_{\omega}H^{2}_{x}} < \frac{1}{10} \sup_{n} C^{-1}_{\beta,\mu,n}$ for # = 1 and 2, we complete the proof of Equation (31) of Theorem 5.

A Stationary norms

We briefly outline properties of the norms used in this article and provide a definition to den for the sake of completeness. A more in depth study can be found in Sections 2 and 3 of [4]. Let \mathcal{L} denote a Bravais lattice in \mathbb{R}^3 and Q its fundamental domain (for example, the Wigner-Seitz cell). We will often suppress the dependence on $\omega \in \Omega$ for notation clarify (where Ω is the probability space). For $\ell \in \mathbb{R}^3$ and $f_{\omega}(x) = f(\omega, x)$ a measurable function on $\Omega \times Q$, given a measure preserving \mathcal{L} -action τ on Ω , let U_{ℓ} denote the translation operator

$$(U_{\ell}f_{\omega})(x) := f_{\tau_{\ell}\omega}(x-\ell).$$
(140)

Recall from definition 1 that a function $f \in L^p_{\omega} L^q_x$ is said to be (\mathcal{L}) stationary if for $\ell \in \mathcal{L}$,

$$U_{\ell}f = f. \tag{141}$$

Lemma 9. Let $f \in L^p_{\omega}L^q_x$ and $1 \leq p, q \leq \infty$, the $L^p_{\omega}L^q_x$ norm is independent of the location of the fundamental domain Q translated by $\ell \in \mathcal{L}$.

Proof. Let τ denote the measure preserving map on Ω . It suffices to note that $h(\omega) = \|f_{\omega}\|_{L^{q}(Q)}$ satisfies:

$$\|f_{\tau_{\ell}\omega}\|_{L^{q}(Q)} = \|f_{\omega}\|_{L^{q}(T_{\ell}Q)}, \qquad (142)$$

where $T_{\ell}(x) = x + \ell$ is the shift by $\ell \in \mathcal{L}$. Since τ_{ℓ} is measure preserving, we see that

$$\mathbb{E} \| f_{\omega} \|_{L^q(Q)}^p = \mathbb{E} \| f_{\omega} \|_{L^q(T_\ell Q)}^p \tag{143}$$

for any $\ell \in \mathcal{L}$.

A random operator, A, on $L^2(\mathbb{R}^3)$ is said to be (\mathcal{L}) stationary if A commutes with U_{ℓ} for all $\ell \in \mathbb{R}^3$. Let Tr denote the usual trace on $L^2(\mathbb{R}^3)$. Given a random operator A, its density den A is a measurable function on $\Omega \times Q$, if it exists, defined via the Riesz representation theorem and the formula

$$\mathbb{E}\operatorname{Tr} fA = \mathbb{E}\int_{\mathbb{R}^3} f \operatorname{den} A, \qquad (144)$$

for all simple $C_c^{\infty}(\mathbb{R}^3)$ -valued function f. That is, f is of the form

$$f = \sum_{\alpha} I_{S_{\alpha}} f_{\alpha} \tag{145}$$

where the sum is a finite sum over α , $I_{S_{\alpha}}$ is the indicator function of some measurable set $S_{\alpha} \subset \Omega$, and f_{α} is a $C_c^{\infty}(\mathbb{R}^3)$ function. Moreover, the f on the left hand side of (144) is regarded as a multiplication operator on $L^2(\mathbb{R}^3)$. When A has an integral kernel A(x, y) a.s., that is

$$(Af)(x) = \int_{\mathbb{R}^3} A(x, y) f(y) dy, \qquad (146)$$

then,

$$(\operatorname{den} A)(x) = A(x, x), \tag{147}$$

whenever A(x, x) is defined and unambiguous.

We outline a few special cases used in the paper where den A is defined. Define trace per volume Q via

$$\operatorname{Tr}_{Q} A := \frac{1}{|Q|} \operatorname{Tr} \mathbf{1}_{Q} A \mathbf{1}_{Q}, \qquad (148)$$

where $\mathbf{1}_Q$ is the indicator function of Q. If A is stationary, Tr_Q is independent of translates of Q. For $1 \leq p, q \leq \infty$, there is a family of stationary Schatten spaces $L^q_{\omega} \mathfrak{S}^p$ associated to Tr_Q , given via the completions of

$$L^{q}_{\omega}\mathfrak{S}^{p} = \{A_{\omega} \in \mathcal{B}(L^{2}(\mathbb{R}^{3})) \text{ and stationary} : \|A_{\omega}\|_{L^{q}_{\omega}\mathfrak{S}^{p}} < \infty\}$$
(149)

with the norm

$$\|A\|_{L^q_{\omega}\mathfrak{S}^p}^q = \mathbb{E}\left(\operatorname{Tr}_Q(A^*A)^{p/2}\right)^{q/p}.$$
(150)

If p or $q = \infty$, the usual sup norm is assumed. We remark that the usual (nonrandom) Schatten norm for operators on $X \subset \mathbb{R}^3$ is given as

$$||A||_{\mathfrak{S}^{p}(X)}^{p} = \operatorname{Tr} \mathbf{1}_{X} (A^{*}A)^{p/2} \mathbf{1}_{X},$$
(151)

where $\mathbf{1}_X$ is the indicator function on X.

Let $R = (1 - \Delta)^{-1}$. We have the following result.

Lemma 10. Suppose that $A \in L^{\infty}_{\omega} \mathfrak{S}^2$, then den AR and den $RA \in L^{\infty}_{\omega} L^2_x$. Moreover,

$$\|\operatorname{den} AR\|_{L^{\infty}_{\omega}L^{2}_{x}}, \|\operatorname{den} RA\|_{L^{\infty}_{\omega}L^{2}_{x}} \lesssim \|A\|_{L^{\infty}_{\omega}\mathfrak{S}^{2}}.$$
(152)

Proof. We prove the case for RA only. The case for AR is treated similarly. We use the $L^2(Q)-L^2(Q)$ duality. Let $\varphi \in L^2(Q)$ and apply Hölder's inequality to

$$\operatorname{Tr} \mathbf{1}_{Q}(\varphi R) A \mathbf{1}_{Q} \leq \|\varphi R\|_{\mathfrak{S}^{2}(\mathbb{R}^{3})} \|A \mathbf{1}_{Q}\|_{\mathfrak{S}^{2}(\mathbb{R}^{3})}.$$
(153)

Since $\frac{3}{2} < 2$ and we are in dimension 3, the Kato-Seiler-Simon inequality shows

$$\operatorname{Tr}_{Q}[(\varphi R)A] \lesssim \frac{1}{|Q|} \|\varphi\|_{L^{2}(Q)} \|A\mathbf{1}_{Q}\|_{\mathfrak{S}^{2}(\mathbb{R}^{3})}.$$
(154)

Since

$$\frac{1}{|Q|} \|A\mathbf{1}_Q\|_{\mathfrak{S}^2(\mathbb{R}^3)}^2 = \frac{1}{|Q|} \operatorname{Tr} \mathbf{1}_Q A^* A \mathbf{1}_Q = \|A\|_{\mathfrak{S}^2(Q)}^2,$$
(155)

we see that

$$\operatorname{Tr}_{Q}[(\varphi R)A] \lesssim \|\varphi\|_{L^{2}(Q)} \|A\|_{\mathfrak{S}^{2}(Q)}.$$
(156)

The $L^2(\Omega)$ - $L^2(\Omega)$ duality and the Riesz representation theorem show that there is some den $RA \in L^2(Q)$ such that

$$\frac{1}{|\Omega|} \int_{Q} \varphi \operatorname{den}(RA) = \operatorname{Tr}_{Q} \varphi RA \tag{157}$$

for all $\varphi \in L^2(Q)$ and

$$\| \operatorname{den} RA \|_{L^2(Q)} \le \|A\|_{\mathfrak{S}^2(Q)}.$$
 (158)

Since we have not specified the dependence of A on ω , we see that (157) and (158) hold for all ω a.s.. In particular, den RA_{ω} is well defined for a.e. ω . Taking $\sup_{\omega \in \Omega}$ in (158) in, we see that (152) is proved.
