# MAXIMAL ORTHOGONAL GRASSMANNIANS OF QUADRATIC FORMS OF DIMENSIONS UP TO 22

#### Abstract

Let $X$ be a connected component of the maximal orthogonal grassmannian of a generic $n$-dimensional quadratic form $q$ with trivial Clifford invariant. Consider the canonical epimorphism $\phi$ from the Chow ring of $X$ to the associated graded ring of the coniveau filtration on the Grothendieck ring of $X$. In [6] Karpenko proved that $\phi$ is an isomorphism for all $n \leq 12$ (conjecturally for all $n$ ). Recently, in 10] Yagita showed that $\phi$ is not an isomorphism for $n=17,18$. In the present paper, together with Yagita's results for $n=17,18$, we show that the map $\phi$ is not an isomorphism for all $13 \leq n \leq 22$. In particualr, the case $n=13$ gives the smallest dimensional maximal orthogonal grassmannian whose two graded rings are not isomorphic.


## 1. Introduction

Consider the Grothendieck ring $K(X)$ of a smooth variety $X$ and its filtration by codimension of support of coherent sheaves:

$$
0=K(X)^{(\operatorname{dim}(X)+1)} \subset K(X)^{(\operatorname{dim}(X))} \subset \cdots \subset K(X)^{(1)} \subset K(X)^{(0)}=K(X)
$$

called the topological filtration or the coniveau filtration. The associated graded ring is denoted by $G K(X)$, i.e.,

$$
G K(X)=\bigoplus K(X)^{(i / i+1)}, \text { where } K(X)^{(i / i+1)}:=K(X)^{(i)} / K(X)^{(i+1)}
$$

Let $\mathrm{CH}(X)$ denote the Chow ring of $X$. Then, there is a canonical graded ring epimorphism:

$$
\begin{equation*}
\phi: \mathrm{CH}(X) \rightarrow G K(X) \tag{1}
\end{equation*}
$$

mapping the class of a closed subvariety of $X$ of codimension $i$ in $\mathrm{CH}^{i}(X)$ to the class of its structure sheaf in the quotient $K(X)^{(i / i+1)}$. The morphism $\phi$ commutes with Chern classes. Moreover, by the Riemann-Roch theorem, the kernel of $\phi^{i}: \mathrm{CH}^{i}(X) \rightarrow$ $K(X)^{(i / i+1)}$ is annihilated by multiplication by $(i-1)$ !.

Let $G$ be a split semisimple group over a field $k$ and let $E$ be a generic $G$-torsor over $k$, i.e., $E$ is the generic fiber of the quotient map $\mathbf{G L}(n) \rightarrow \mathbf{G L}(n) / G$ induced by the embedding $G \rightarrow \mathbf{G L}(n)$ for some $n \geq 1$. For the variety of Borel subgroups $X=E / B$, twisted by $E$ (i.e., $E / B$ is a twisted form of $G / B$, where $B \subset G$ is a Borel subgroup), Karpenko conjectured that the morphism $\phi$ is an isomorphism in [4], where he confirmed the conjecture for a simple group $G$ of type $A$ or $C$. Indeed, by [4. Lemma 4.2] this conjecture is equivalent to the same statement, after replacing
the Borel subgroup $B$ by a special parabolic subgroup $P$ of $G$ (i.e., any $P$-torsor over any field extension of $k$ is trivial). Moreover, in [3, Theorem 1.2] he showed that the conjecture holds for a wider class of groups $G$ including special orthogonal groups and the exceptional groups of types $G_{2}, F_{4}$, and simply connected $E_{6}$.

Let $G=\operatorname{Spin}(n)$ be the simply connected group of type $B$ or $D$. Since a generic $G$-torsor $E$ gives a generic quadratic form $q$ of dimension $n$ with trivial discriminant and Clifford invariant (i.e., the Brauer class of the even Clifford algebra of $q$ ), we may identify $X=E / P$ for a maximal parabolic subgroup $P$ of $G$ with a connected component of the maximal orthogonal grassmannian of $q$. Moreover, if $n$ is even, then a connected component of the maximal orthogonal grassmannian of $q$ can be identified with the maximal orthogonal grassmannian of any non-degenerate ( $n-1$ )-dimensional subform of $q$ [1, Proposition 85.2]. Hence, for spin groups it suffices to consider the case where $n$ is odd. In [6, Theorem 3.1] Karpenko proved that the conjecture holds for $G=\operatorname{Spin}(n)$ for any $n \leq 12$. Recently, Yagita showed that $G=\operatorname{Spin}(17)$ provides a counter-example on the conjecture by Karpenko [10]. Later, Karpenko extended Yagita's counter-example to base fields of arbitrary characteristic [2]. However, as mentioned in [2, §1. Introduction] the cases of $\operatorname{Spin}(13)$ and $\operatorname{Spin}(15)$ remain open.

In the present paper, we prove that Karpenko's conjecture does not hold for $G=$ $\operatorname{Spin}(n)$ for all $13 \leq n \leq 16$ and $19 \leq n \leq 22$, i.e., combined with Yagita's results for $n=17,18$, we show

Theorem 1.1. Let $k$ be a field of characteristic different from 2 and let $X$ be $a$ connected component of the maximal orthogonal grassmannian of a generic quadratic form $q$ over $k$ of trivial Clifford invariant. Then, for all $13 \leq \operatorname{dim}(q) \leq 22$ the canonical epimoprhism $\phi: \mathrm{CH}(X) \rightarrow G K(X)$ is not an isomorphism.

In particular, Theorem 1.1 provides the smallest dimensional maximal orthogonal grassmannin $X$ of a generic quadratic form of trivial Clifford invariant such that two rings $\mathrm{CH}(X)$ and $G K(X)$ are not isomorphic. It would be interesting to know whether the upper bound 22 in Theorem 1.1 can be removed.

For the proof of our main theorem, we provide certain elements which are not divisible by 2 in the Chow groups of the maximal orthogonal grassmannians, whereas their images under $\phi$ are divisible by 2 in the associated graded rings, following the approach of [2].

## 2. Preliminaries

In this section we shall collect some basic results on the Chow and the Grothendieck rings of maximal orthogonal grassmannians. For details and the general theory we refer the reader to [1], [2] and [9].
2.1. Chow ring of maximal orthogonal grassmannins. For an integer $n \geq 1$, let $q$ be a generic $(2 n+1)$-dimensional quadratic form over a field $k$ of trivial Clifford
invariant corresponding to a generic $\operatorname{Spin}(2 n+1)$-torsor. Let $X_{n}$ denote the variety of $n$-dimensional totally isotropic subspaces (i.e., the maximal orthogonal grassmannian of $q$ ). Then, $\operatorname{dim}\left(X_{n}\right)=n(n+1) / 2$. Let ind $\left(X_{n}\right)$ be the index of $X_{n}$, i.e., the greatest common divisor of the degrees of closed points on $X_{n}$. Then, the the index ind $\left(X_{n}\right)$ coincides with the torsion index of $\operatorname{Spin}(2 n+1)$, which is determined by Totaro in [8]. In particular, we have

\operatorname{ind}\left(X_{6}\right)=2^{2}, \quad \operatorname{ind}\left(X_{7}\right)=2^{3}, \quad \operatorname{ind}\left(X_{9}\right)=2^{4}, \quad \operatorname{ind}\left(X_{10}\right)=2^{5} \tag{2}
\end{equation*}
$$

Let $\bar{X}_{n}$ be the base change of $X_{n}$ to an algebraic closure $\bar{k}$ of $k$ and let $\bar{Y}_{n}$ be the base change of the quadric $Y_{n}$ of $q$ to $\bar{k}$. Consider the projective bundle $\pi: P \rightarrow \bar{X}_{n}$ associated with the tautological vector bundle on $\bar{X}_{n}$ and the projection $\pi^{\prime}: P \rightarrow \bar{Y}_{n}$. Let $l_{n-i}$ be the class of a projective ( $n-i$ )-dimensional subspace on $\bar{Y}$ in $\mathrm{CH}(\bar{Y})$ and let $e_{i} \in \mathrm{CH}^{i}\left(\bar{X}_{n}\right)$ be the image of $l_{n-i}$ under the composition of the pullback of $\pi^{\prime}$ and the push-forward of $\pi$. Then, the Chow group $\mathrm{CH}\left(\bar{X}_{n}\right)$ is free with basis given by the products $\prod_{i \in I} e_{i}$, where $I$ runs over the subsets of the set $\{1, \ldots, n\}$. In particular, both groups $\mathrm{CH}^{\operatorname{dim}\left(\bar{X}_{n}\right)}\left(\bar{X}_{n}\right)$ and $\mathrm{CH}^{\operatorname{dim}\left(\bar{X}_{n}\right)-1}\left(\bar{X}_{n}\right)$ are cyclic generated by

$$
\begin{equation*}
p:=\prod_{i=1}^{n} e_{i} \text { and } l:=\prod_{i=2}^{n} e_{i} \tag{3}
\end{equation*}
$$

respectively.
The Chow ring $\mathrm{CH}\left(\bar{X}_{n}\right)$ is generated by $e_{1}, \ldots, e_{n}$ with relations

$$
\begin{equation*}
e_{i}^{2}-2 e_{i-1} e_{i+1}+2 e_{i-2} e_{i+2}-\cdots+(-1)^{i-1} 2 e_{1} e_{2 i-1}+(-1)^{i} e_{2 i}=0 \tag{4}
\end{equation*}
$$

for all $i \geq 1$. In particular, for $n \leq 10$ we have the following relations:

$$
\begin{array}{ll}
e_{1}^{2}=e_{2}, & e_{1}^{4}=2 e_{1} e_{3}-e_{4}, \\
e_{1}^{8} \equiv 2\left(e_{3} e_{5}-e_{2} e_{6}+e_{1} e_{7}\right)-e_{8}, & e_{1}^{16} \equiv 2\left(e_{7} e_{9}-e_{6} e_{10}\right)\left(\bmod 2^{2}\right), \tag{6}
\end{array}
$$

where $e_{i}=0$ for $i>n$.
Let $c_{i}$ be the Chern class of the dual of rank $n$ tautological vector bundle on $X_{n}$. As the Clifford invariant of $q$ is trivial, by [1, Exercise 88.14] there is an element $e \in \mathrm{CH}^{1}\left(X_{n}\right)$ with $c_{1}=2 e$. Consider the restriction map

$$
\text { res : } \mathrm{CH}\left(X_{n}\right) \rightarrow \mathrm{CH}\left(\bar{X}_{n}\right) .
$$

Since the map res commutes with Chern classes, by [1, Proposition 86.13] we have $\operatorname{res}\left(c_{i}\right)=2 e_{i}$ for all $2 \leq i \leq n$ and $\operatorname{res}(e)=e_{1}$.

For a smooth variety $X$ over a field $k$ of characteristic different from 2, we consider the Steenrod operation $S: \operatorname{Ch}(X) \rightarrow \operatorname{Ch}(X)$ of cohomological type, where $\operatorname{Ch}(X):=$ $\mathrm{CH}(X) / 2 \mathrm{CH}(X)$ denotes modulo 2 Chow ring of $X$. For any $i \geq 0$, we write $S^{i}$ : $\mathrm{Ch}^{*}(X) \rightarrow \mathrm{Ch}^{*+i}(X)$ for the $i$ th component of $S$. The image of an element $x \in \mathrm{CH}(X)$ under the map $\mathrm{CH}(X) \rightarrow \mathrm{Ch}(X)$ will be denoted by $\bar{x}$.

Lemma 2.1. [2, Proposition 3.1] Let $\bar{c}_{i}$ be the image of the Chern class of the dual of rank $n$ tautological vector bundle on $X_{n}$ in $\operatorname{Ch}\left(X_{n}\right)$. Then,

$$
S\left(\bar{c}_{i}\right)=\sum_{j \geq 0}\binom{i-1}{j} \bar{c}_{i+j} .
$$

In particular, by Lemma 2.1 we have

$$
\begin{align*}
& S\left(\bar{c}_{2}\right)=\bar{c}_{2}+\bar{c}_{3}, S\left(\bar{c}_{3}\right)=\bar{c}_{3}+\bar{c}_{5}, S\left(\bar{c}_{4}\right)=\bar{c}_{4}+\bar{c}_{5}+\bar{c}_{6}+\bar{c}_{7}  \tag{7}\\
& S\left(\bar{c}_{6}\right)=\bar{c}_{6}+\bar{c}_{7}+\bar{c}_{10}+\bar{c}_{11}, S\left(\bar{c}_{7}\right)=\bar{c}_{7}+\bar{c}_{9}+\bar{c}_{11}+\bar{c}_{13}, S(\bar{e})=\bar{e}+\bar{e}^{2} \tag{8}
\end{align*}
$$

where $\bar{c}_{i}=0$ for $i>n$.
2.2. Grothendieck ring of maximal orthogonal grassmannins. For a smooth variety $X$, let $\widetilde{K}(X)$ denote the (extended) Rees ring of the Grothendieck ring $K(X)$ with respect to the topological filtration of $K(X)$, i.e.,

$$
\widetilde{K}(X)=\bigoplus \widetilde{K}(X)^{(i)}, \text { where } \widetilde{K}(X)^{(i)}=K(X)^{(i)} t^{-i}
$$

where $K(X)^{(i)}=K(X)$ for all $i \leq 0$. We view $\widetilde{K}(X)$ as a subring of the Laurent polynomial ring $K(\underset{\sim}{X})\left[t, t^{-1}\right]$. Then, we have $G K(X)=\widetilde{K}(X) / t \widetilde{K}(\underset{\sim}{X})$. Let $I(X)$ denote the ideal of $\widetilde{K}(X)$ generated by $t$ and 2. Then, we also have $\widetilde{K}(X) / I(X)=$ $G K(X) / 2 G K(X)$. To avoid a minus sign we sometimes write $u$ instead of $t^{-1}$.

Let $X_{n}$ be the maximal orthogonal grassmannian of a generic quadratic form of dimension $2 n+1$ with trivial Clifford invariant as in Section [2.1. we shall write $c_{i} \in K\left(X_{n}\right)^{(i)}$ for the $K$-theoretic Chern class of the dual of the tautological vector bundle on $X_{n}$ and also write $e_{i} \in K\left(\bar{X}_{n}\right)^{(i)}$ for the image of $l_{n-i} \in K\left(\bar{Y}_{n}\right)^{(n+i-1)}$ under the composition $\pi_{*} \circ\left(\pi^{\prime}\right)^{*}$, as defined in Section 2.1. As the canonical epimorphism $\phi$ in (1) commutes with Chern classes, we have $\phi\left(c_{i}\right)=c_{i}$ and $\phi\left(e_{i}\right)=e_{i}$ modulo $K\left(X_{n}\right)^{(i+1)}$ and $K\left(\bar{X}_{n}\right)^{(i+1)}$, respectively. Hence, the relations (4) hold in $K\left(\bar{X}_{n}\right)$. We shall write $p$ and $l$ for the classes of $\prod_{i=1}^{n} e_{i}$ and $\prod_{i=2}^{n} e_{i}$ in $K\left(\bar{X}_{n}\right)^{\left(\operatorname{dim}\left(\bar{X}_{n}\right)\right)}$ and $K\left(\bar{X}_{n}\right)^{\left(\operatorname{dim}\left(\bar{X}_{n}\right)-1\right)}$, respectively. In particular, as $K\left(\bar{X}_{n}\right)^{\left(\operatorname{dim}\left(\bar{X}_{n}\right)\right)}=\mathrm{CH}^{\operatorname{dim}\left(\bar{X}_{n}\right)}\left(\bar{X}_{n}\right)$ we get

$$
\begin{equation*}
K\left(\bar{X}_{n}\right)^{\left(\frac{n^{2}+n}{2}\right)}=\mathbb{Z} \cdot p \text { and } K\left(\bar{X}_{n}\right)^{\left(\frac{n^{2}+n-1}{2}\right)}=\mathbb{Z} \cdot p \oplus \mathbb{Z} \cdot l . \tag{9}
\end{equation*}
$$

Since the Clifford invariant of $q$ is trivial, by [7], [5, Lemma 4.1] we can identify $K\left(X_{n}\right)$ with $K\left(\bar{X}_{n}\right)$. In addition, the following relations hold:

$$
K\left(X_{n}\right)^{(1)}=K\left(\bar{X}_{n}\right)^{(1)} \text { and } K\left(X_{n}\right)^{(i)} \subset K\left(\bar{X}_{n}\right)^{(i)}
$$

for any $i \geq 2$. We write $e \in K\left(X_{n}\right)^{(1)}$ for the element $e_{1} \in K\left(\bar{X}_{n}\right)^{(1)}$. Moreover, a restriction-corestriction argument shows that $\operatorname{ind}\left(X_{n}\right) K\left(\bar{X}_{n}\right) \subset K\left(X_{n}\right)$, thus

\begin{equation*}
\operatorname{ind}\left(X_{n}\right) \widetilde{K}\left(\bar{X}_{n}\right) \subset \widetilde{K}\left(X_{n}\right) \tag{10}
\end{equation*}
$$

for any $n \geq 1$. We shall need the following lemma:

Lemma 2.2. [6, Lemma 4.1] For any $i \geq 1$ and $n \geq 1$, we have

$$
2 e_{i}+e_{i+1} \in K\left(X_{n}\right)^{(i)} \text { and } 2 e_{i}+e_{i+1}=c_{i} \text { in } K\left(X_{n}\right)^{(i / i+1)} \text {. }
$$

## 3. Proof of Theorem 1.1

Let $k$ be a field of characteristic different 2 and let $q$ be a generic quadratic form over $k$ of trivial Clifford invariant such that $13 \leq \operatorname{dim}(q) \leq 22$. Let $X$ be a connected component of the maximal orthogonal grassmannian of $q$. As explained in Section 1, it's enough to consider $X=X_{n}$ for $6 \leq n \leq 10$, where $X_{n}$ is the maximal orthogonal grassmannian of $q$ with $\operatorname{dim}(q)=2 n+1$. Since the statement is proven for $n=8$ in [10] and [2], we prove the statement for $n=6,7,9,10$. We first show that there are certain elements in $\mathrm{CH}\left(X_{n}\right)$, not divisible by 2 :

Proposition 3.1. The following elements

$$
c_{4} e^{15} \in \mathrm{CH}\left(X_{6}\right), \quad c_{4} c_{7} e^{15} \in \mathrm{CH}\left(X_{7}\right), \quad c_{2} c_{3} c_{6} e^{31} \in \mathrm{CH}\left(X_{9}\right), \quad c_{2} c_{3} c_{6} c_{10} e^{31} \in \mathrm{CH}\left(X_{10}\right)
$$

are not divisible by 2.
Proof. Consider the following four elements

$$
\begin{aligned}
& A_{6}=\left(c_{4}+c_{5}+c_{6}\right)\left(e+e^{2}\right)^{15} \in \mathrm{CH}\left(X_{6}\right), \\
& A_{7}=\left(c_{4}+c_{5}+c_{6}+c_{7}\right) c_{7}\left(e+e^{2}\right)^{15} \in \mathrm{CH}\left(X_{7}\right), \\
& A_{9}=\left(c_{2}+c_{3}\right)\left(c_{3}+c_{5}\right)\left(c_{6}+c_{7}\right)\left(e+e^{2}\right)^{31} \in \mathrm{CH}\left(X_{9}\right), \\
& A_{10}=\left(c_{2}+c_{3}\right)\left(c_{3}+c_{5}\right)\left(c_{6}+c_{7}+c_{10}\right) c_{10}\left(e+e^{2}\right)^{31} \in \mathrm{CH}\left(X_{10}\right) .
\end{aligned}
$$

Then, by (77), (8) they are integral representatives of $S\left(\bar{c}_{4} \bar{e}^{15}\right), S\left(\bar{c}_{4} \bar{c}_{7} \bar{e}^{15}\right), S\left(\bar{c}_{2} \bar{c}_{3} \bar{c}_{6} \bar{e}^{31}\right)$, $S\left(\bar{c}_{2} \bar{c}_{3} \bar{c}_{6} \bar{c}_{10} \bar{e}^{31}\right)$, respectively.

For $n=6,7,9,10$, the $\operatorname{dim}\left(X_{n}\right)$ th degree homogeneous parts $A_{n}\left[\operatorname{dim}\left(X_{n}\right)\right]$ of $A_{n}$ are the integral representatives of $S^{2}\left(\bar{c}_{4} \bar{e}^{15}\right), S^{2}\left(\bar{c}_{4} \bar{c}_{7} \bar{e}^{15}\right), S^{3}\left(\bar{c}_{2} \bar{c}_{3} \bar{c}_{6} e^{31}\right)$, and $S^{3}\left(\bar{c}_{2} \bar{c}_{3} \bar{c}_{6} \bar{c}_{10} \bar{e}^{31}\right)$, respectively. Let deg : $\mathrm{CH}\left(X_{n}\right)^{\operatorname{dim}\left(X_{n}\right)} \rightarrow \mathbb{Z}$ denote the degree homomorphism induced by the structure morphism $X_{n} \rightarrow \operatorname{Spec}(k)$. Then, by Lemma 3.2 below, the image of $A_{n}\left[\operatorname{dim}\left(X_{n}\right)\right]$ is an odd integer under the degree map dividing by $\operatorname{ind}\left(X_{n}\right)$,

$$
\frac{\operatorname{deg}}{\operatorname{ind}\left(X_{n}\right)}: \mathrm{CH}\left(X_{n}\right)^{\operatorname{dim}\left(X_{n}\right)} \xrightarrow{\text { res }} \mathrm{CH}\left(\bar{X}_{n}\right)^{\operatorname{dim}\left(X_{n}\right)} \xrightarrow{\sim} \mathbb{Z}
$$

i.e., the images of $S^{2}\left(\bar{c}_{4} \bar{e}^{15}\right), S^{2}\left(\bar{c}_{4} \bar{c}_{7} \bar{e}^{15}\right), S^{3}\left(\bar{c}_{2} \bar{c}_{3} \bar{c}_{6} e^{31}\right)$, and $S^{3}\left(\bar{c}_{2} \bar{c}_{3} \bar{c}_{6} \bar{c}_{10} \bar{e}^{31}\right)$ under the map $\frac{\mathrm{deg}}{\operatorname{ind}\left(X_{n}\right)}$ are nonzero in $\mathbb{Z} / 2 \mathbb{Z}$. Hence, the statement follows.

Lemma 3.2. With the above notations, for $n=6,7,9,10$ the following holds:

$$
\operatorname{res}\left(A_{n}\left[\operatorname{dim}\left(X_{n}\right)\right]\right) \equiv \operatorname{ind}\left(X_{n}\right) \cdot p\left(\bmod 2 \operatorname{ind}\left(X_{n}\right)\right)
$$

where $p$ denotes the class of a rational point in (3).
Proof. First, observe that by (6) the following relations hold: $e_{1}^{16} \equiv 0(\bmod 4)$ for both $\bar{X}_{6}$ and $\bar{X}_{7}$, and $e_{1}^{8} \equiv e_{8}(\bmod 2)$ for both $\bar{X}_{9}$ and $\bar{X}_{10}$. We will prove the statement case by case.

Case $\mathrm{n}=6$ : As $A_{6}[21]=c_{4} e^{17}+c_{5} e^{16}+c_{6} e^{15}$ and $e_{6}^{2}=0$, by (5), (6) we have

\begin{aligned}
\operatorname{res}\left(A_{6}[21]\right) & =2 e_{4} e_{1} \cdot e_{1}^{16}+2 e_{5} \cdot e_{1}^{16}+2 e_{6} \cdot e_{1}^{1+2+4+8} \\
& \equiv 2^{2} e_{6} e_{1} e_{2}\left(2 e_{1} e_{3}-e_{4}\right)\left(e_{3} e_{5}-e_{2} e_{6}\right) \equiv 2^{2} e_{1} \cdots e_{6}\left(\bmod 2^{3}\right)
\end{aligned}
$$

Case $\mathrm{n}=7$ : As $A_{7}[28]=c_{4} c_{7} e^{17}+c_{5} c_{7} e^{16}+c_{6} c_{7} e^{15}+c_{7}^{2} e^{14}, e_{6}^{2}=2 e_{5} e_{7}$, and $e_{7}^{2}=0$, by (5), (6) we get

$$
\begin{aligned}
\operatorname{res}\left(A_{7}[28]\right) & \equiv \operatorname{res}\left(c_{6} c_{7} e^{1+2+4+8}\right) \equiv 2^{3} e_{6} e_{7} e_{1} e_{2}\left(2 e_{1} e_{3}-e_{4}\right)\left(e_{3} e_{5}-e_{2} e_{6}+e_{1} e_{7}\right) \\
& \equiv 2^{3} e_{1} \cdots e_{7}+2^{3} e_{1} e_{2}^{2} e_{4} e_{7} \cdot e_{6}^{2} \equiv 2^{3} e_{1} \cdots e_{7}\left(\bmod 2^{4}\right)
\end{aligned}
$$

Case $\mathrm{n}=9$ : Since we have

$$
\begin{aligned}
A_{9}[45]= & \left(e^{16}\right)^{2}\left(c_{3} c_{3} c_{6} e+c_{3} c_{3} c_{7}+c_{2} c_{3} c_{6} e^{2}+c_{2} c_{3} e_{7} e+c_{2} c_{5} c_{6}\right) \\
& +c_{3} c_{5} c_{6} e^{31}+c_{3} c_{5} c_{7} e^{30}+c_{2} c_{5} c_{7} e^{31}
\end{aligned}
$$

and $\left(e_{1}^{16}\right)^{2} \equiv 0\left(\bmod 2^{2}\right)$ by (6) , we obtain

$$
\begin{equation*}
\operatorname{res}\left(A_{9}[45]\right) \equiv 2^{3}\left(e_{3} e_{5} e_{6} e_{1}^{31}+e_{3} e_{5} e_{7} \cdot e_{1}^{16} \cdot e_{1}^{14}+e_{2} e_{5} e_{7} \cdot e_{1}^{16} \cdot e_{1}^{15}\right)\left(\bmod 2^{5}\right) \tag{11}
\end{equation*}
$$

As $e_{7}^{2} \equiv 0(\bmod 2)$ and $e_{1}^{16} \equiv 2 e_{7} e_{9}\left(\bmod 2^{2}\right)$ by (4), (6), it follows from(11) that

$$
\operatorname{res}\left(A_{9}[45]\right) \equiv 2^{3} e_{3} e_{5} e_{6} \cdot e_{1}^{1+2+4+8} \cdot e_{1}^{16} \equiv 2^{3} e_{3} e_{5} e_{6} \cdot e_{1} e_{2} e_{4} e_{8} \cdot 2 e_{7} e_{9}\left(\bmod 2^{5}\right)
$$

Case $\mathrm{n}=10$ : As $A_{10}[55]=c_{10} A_{9}[45]+c_{10}^{2}\left(c_{2} c_{3} e^{30}+c_{2} c_{5} e^{28}+c_{3}^{2} e^{29}+c_{3} c_{5} e^{27}\right)$ and $e_{10}^{2}=0$, by the previous case $n=9$ and (6) we have

$$
\begin{aligned}
\operatorname{res}\left(A_{10}[55]\right) & \equiv 2^{4} e_{3} e_{5} e_{6} e_{10} \cdot e_{1}^{1+2+4+8} \cdot e_{1}^{16} \equiv 2^{4} e_{3} e_{5} e_{6} e_{10} \cdot e_{1} e_{2} e_{4} e_{8} \cdot\left(2 e_{7} e_{9}-2 e_{6} e_{10}\right) \\
& \equiv 2^{4} e_{3} e_{5} e_{6} e_{10} \cdot e_{1} e_{2} e_{4} e_{8} \cdot 2 e_{7} e_{9}\left(\bmod 2^{6}\right)
\end{aligned}
$$

Hence, by (2) the statement follows.
Now we show that the images of elements given in Proposition 3.1 under the map $\phi: \mathrm{CH}\left(X_{n}\right) \rightarrow G K\left(X_{n}\right)$ are divisible by 2 , which completes the proof of our theorem.

Proposition 3.3. The classes of the following elements

$$
c_{4} e^{15} \in K\left(X_{6}\right), c_{4} c_{7} e^{15} \in K\left(X_{7}\right), c_{2} c_{3} c_{6} e^{31} \in K\left(X_{9}\right), c_{2} c_{3} c_{6} c_{10} e^{31} \in K\left(X_{10}\right)
$$

are divisible by 2 in the quotients $K\left(X_{6}\right)^{(19 / 20)}, K\left(X_{7}\right)^{(26 / 27)}, K\left(X_{9}\right)^{(42 / 43)}, K\left(X_{10}\right)^{(52 / 53)}$, respectively.

Proof. Consider the following four elements
$B_{6}=\left(2 e_{4}+e_{5}\right) e_{1}^{15}, B_{7}=2 e_{7} B_{6}, B_{9}=\left(2 e_{2}+e_{3}\right)\left(2 e_{3}+e_{4}\right)\left(2 e_{6}+e_{7}\right) e_{1}^{31}, B_{10}=2 e_{10} B_{9}$ in $K\left(\bar{X}_{6}\right), K\left(\bar{X}_{7}\right), K\left(\bar{X}_{9}\right), K\left(\bar{X}_{10}\right)$, respectively. Then, by Lemma 2.2 we have

$$
B_{6}=c_{4} e^{15}, B_{7}=c_{4} c_{7} e^{15}, \quad B_{9}=c_{2} c_{3} c_{6} e^{31}, \quad B_{10}=c_{2} c_{3} c_{6} c_{10} e^{31}
$$

in $K\left(X_{6}\right)^{(19 / 20)}, K\left(X_{7}\right)^{(26 / 27)}, K\left(X_{9}\right)^{(42 / 43)}, K\left(X_{10}\right)^{(52 / 53)}$, respectively. Hence, it suffices to show that

$$
B_{6} u^{19} \in I\left(X_{6}\right), B_{7} u^{26} \in I\left(X_{7}\right), B_{9} u^{42} \in I\left(X_{9}\right), B_{10} u^{52} \in I\left(X_{10}\right),
$$

where $u=t^{-1}$.
Since $e_{4}^{2} \equiv e_{5}^{2} \equiv 0(\bmod 2)$ for both $\bar{X}_{6}$ and $\bar{X}_{7}$, by (5), (6) the following relations hold modulo $2^{2}$ :

$$
e_{4} e_{1}^{1+2+4+8} \equiv 2 e_{4}^{2} e_{1} e_{2}\left(e_{3} e_{5}-e_{2} e_{6}\right) \equiv 0, e_{5} e_{1}^{1+2+4+8} \equiv 2 e_{5} e_{1} e_{2} e_{4}\left(e_{3} e_{5}-e_{2} e_{6}\right) \equiv 0
$$

for $\bar{X}_{6}$ and
$e_{4} e_{7} e_{1}^{15} \equiv 2 e_{4}^{2} e_{7} e_{1} e_{2}\left(e_{3} e_{5}-e_{2} e_{6}+e_{1} e_{7}\right) \equiv 0, e_{5} e_{7} e_{1}^{15} \equiv 2 e_{5} e_{7} e_{1} e_{2} e_{4}\left(e_{3} e_{5}-e_{2} e_{6}+e_{1} e_{7}\right) \equiv 0$ for $\bar{X}_{7}$, thus $B_{6} u^{19} \in I\left(\bar{X}_{6}\right)^{3}$ and $B_{7} u^{26} \in I\left(\bar{X}_{7}\right)^{4}$, i.e.,

$$
B_{6} u^{19} \in \sum_{i=0}^{2}\left(2^{3-i} t^{i}\right) \widetilde{K}\left(\bar{X}_{6}\right)^{(19+i)} \text { and } B_{7} u^{26} \in \sum_{i=0}^{2}\left(2^{4-i} t^{i}\right) \widetilde{K}\left(\bar{X}_{7}\right)^{(26+i)}
$$

Hence, by (2), (10), we may assume that

$$
B_{6} u^{19} \in\left(2 t^{2}\right) \widetilde{K}\left(\bar{X}_{6}\right)^{(21)} \text { and } B_{7} u^{26} \in\left(2^{2} t^{2}\right) \widetilde{K}\left(\bar{X}_{7}\right)^{(28)}
$$

By (9) with $n=6,7$, we may further assume that $B_{6}$ and $B_{7}$ are integer multiples of $2 p$ and $2^{2} p$, respectively. Therefore, it follows by Lemma 3.4 (i) that $B_{6} u^{19} \in I\left(X_{6}\right)$ and $B_{7} u^{26} \in I\left(X_{7}\right)$.

Now we expand the element $B_{9}$ as follows:

$$
\begin{equation*}
\left[2^{3}\left(e_{2} e_{3} e_{6}\right)+2^{2}\left(e_{2} e_{3} e_{7}+e_{2} e_{4} e_{6}+e_{3} e_{4} e_{6}\right)+2\left(e_{2} e_{4} e_{7}+e_{3}^{2} e_{7}+e_{3} e_{4} e_{6}\right)+\left(e_{3} e_{4} e_{7}\right)\right] \cdot e_{1}^{31} \tag{12}
\end{equation*}
$$

It follows by (5), (6) that

$$
\begin{equation*}
e_{1}^{16} \equiv 2 e_{7} e_{9}\left(\bmod 2^{2}\right), e_{1}^{14} \equiv e_{2} e_{4} e_{8}, e_{1}^{4} \equiv e_{2}^{2} \equiv e_{4}, e_{4}^{2} \equiv e_{8}, e_{8}^{2} \equiv 0(\bmod 2) \tag{13}
\end{equation*}
$$

Since $e_{7}^{2} \equiv 0(\bmod 2)$ for $\bar{X}_{9}$, by (13) we see that each term in the round brackets of the equation (12) multiplied by $e_{1}^{31}$ is divisible by $2^{2}$. Observe that $B_{10}=2 e_{10} B_{9}$. Since $e_{7}^{2} \equiv e_{10}^{2} \equiv 0(\bmod 2)$ and the relations in (13) hold for $\bar{X}_{10}$ after replacing the first one $e_{1}^{16} \equiv 2 e_{7} e_{9}\left(\bmod 2^{2}\right)$ by $e_{1}^{16} \equiv 2\left(e_{7} e_{9}-e_{6} e_{10}\right)\left(\bmod 2^{2}\right)$, each term in the round brackets of equation (12) multiplied by $e_{1}^{31} \cdot e_{10}$ is also divisible by $2^{2}$. Therefore, we have $B_{9} u^{42} \in I\left(\bar{X}_{9}\right)^{5}$ and $B_{10} u^{52} \in I\left(\bar{X}_{10}\right)^{6}$, thus by (2), (10), we may assume that

$$
B_{9} u^{42} \in\left(2^{3} t^{2}\right) \widetilde{K}\left(\bar{X}_{9}\right)^{(44)}+\left(2^{2} t^{3}\right) \widetilde{K}\left(\bar{X}_{9}\right)^{(45)}, B_{10} u^{52} \in\left(2^{4} t^{2}\right) \widetilde{K}\left(\bar{X}_{10}\right)^{(54)}+\left(2^{3} t^{3}\right) \widetilde{K}\left(\bar{X}_{10}\right)^{(55)}
$$

By (9) with $n=9,10$, we can further assume that $B_{9}=\left(2^{3} l\right) a+\left(2^{2} p\right) b$ and $B_{10}=$ $\left(2^{4} l\right) c+\left(2^{3} p\right) d$ for some integers $a, b, c, d$. Therefore, by Lemma 3.4 (ii) we conclude that $B_{9} u^{42} \in I\left(X_{9}\right)$ and $B_{10} u^{52} \in I\left(X_{10}\right)$.

Lemma 3.4. With the above notations, the following holds:
(i) $(2 p) u^{19} \in I\left(X_{6}\right), \quad\left(2^{2} p\right) u^{26} \in I\left(X_{7}\right)$,
(ii) $\left(2^{3} l\right) u^{42},\left(2^{2} p\right) u^{42} \in I\left(X_{9}\right) \quad$ and $\quad\left(2^{4} l\right) u^{52},\left(2^{3} p\right) u^{52} \in I\left(X_{10}\right)$.

Proof. (i) Consider the following elements

$$
C_{6}=\left(2 e_{5}+e_{6}\right) e_{1}^{14} \in K\left(\bar{X}_{6}\right), \quad C_{7}=2\left(2 e_{5}+e_{6}\right) e_{7} e_{1}^{14} \in K\left(\bar{X}_{7}\right)
$$

Then, by Lemma [2.2] $C_{6} \in K\left(X_{6}\right)$ and $C_{7} \in K\left(X_{7}\right)$. Since $e_{6}^{2} \equiv e_{7}^{2} \equiv 0(\bmod 2)$ for both $\bar{X}_{6}$ and $\bar{X}_{7}$, by the same argument as in the proof of Proposition 3.3 the following relations hold modulo $2^{2}$ :

$$
\begin{aligned}
e_{5} e_{1}^{14} & \equiv 0, \quad e_{6} e_{1}^{14} \equiv 2 e_{6} e_{2} e_{4}\left(e_{3} e_{5}-e_{2} e_{6}\right) \equiv 2 e_{6} e_{2} e_{4} e_{3} e_{5}=2 l, \\
e_{5} e_{7} e_{1}^{14} & \equiv 0, \quad e_{6} e_{7} e_{1}^{14} \equiv 2 e_{6} e_{7} e_{2} e_{4}\left(e_{3} e_{5}-e_{2} e_{6}+e_{1} e_{7}\right) \equiv 2 e_{6} e_{7} e_{2} e_{4} e_{3} e_{5}=2 l
\end{aligned}
$$

for $\bar{X}_{6}$ and $\bar{X}_{7}$, respectively, thus, we obtain

$$
\begin{equation*}
\left(C_{6}-2 l\right) u^{19} \in \sum_{i=0}^{2}\left(2^{3-i} t^{i}\right) \widetilde{K}\left(\bar{X}_{6}\right)^{(19+i)},\left(C_{7}-2^{2} l\right) u^{26} \in \sum_{i=0}^{2}\left(2^{4-i} t^{i}\right) \widetilde{K}\left(\bar{X}_{7}\right)^{(26+i)} \tag{14}
\end{equation*}
$$

By (2), (10), we have

$$
2^{3} \widetilde{K}\left(\bar{X}_{6}\right)^{(19)}+\left(2^{2} t\right) \widetilde{K}\left(\bar{X}_{6}\right)^{(20)} \subset I\left(X_{6}\right), \quad 2^{4} \widetilde{K}\left(\bar{X}_{7}\right)^{(26)}+\left(2^{3} t\right) \widetilde{K}\left(\bar{X}_{7}\right)^{(27)} \subset I\left(X_{7}\right)
$$

Since $e_{1} C_{6} u^{19}=t\left(e_{1} C_{6} u^{20}\right) \in I\left(X_{6}\right)$ and $e_{1} C_{7} u^{26}=t\left(e_{1} C_{7} u^{27}\right) \in I\left(X_{7}\right)$, the statement (i) follows by multiplying the elements in (14) by $e_{1}$.
(ii) Similarly, consider the following elements

$$
C_{9}=\left(2 e_{2}+e_{3}\right)\left(2 e_{4}+e_{5}\right)\left(2 e_{6}+e_{7}\right) e_{1}^{30}, C_{10}=2\left(2 e_{2}+e_{3}\right)\left(2 e_{4}+e_{5}\right)\left(2 e_{6}+e_{7}\right) e_{10} e_{1}^{30}
$$

in $K\left(\bar{X}_{9}\right)$ and $K\left(\bar{X}_{10}\right)$, respectively. By Lemma 2.2, they are contained in $K\left(X_{9}\right)$ and $K\left(X_{10}\right)$, respectively. Write $C_{9}$ as follows:
$\left[2^{3}\left(e_{2} e_{4} e_{6}\right)+2^{2}\left(e_{2} e_{4} e_{7}+e_{2} e_{5} e_{6}+e_{3} e_{4} e_{6}\right)+2\left(e_{2} e_{5} e_{7}+e_{3} e_{4} e_{7}+e_{3} e_{5} e_{6}\right)+\left(e_{3} e_{5} e_{7}\right)\right] \cdot e_{1}^{30}$.
By (13), the same argument as in the proof of Proposition 3.3 shows that

$$
e_{3} e_{5} e_{6} e_{1}^{2+4+8+16} \equiv e_{3} e_{5} e_{6} e_{2} e_{4} e_{8}\left(2 e_{7} e_{9}\right)=2 l\left(\bmod 2^{2}\right)
$$

and each remaining term in the round brackets of the equation (15) multiplied by $e_{1}^{30}$ is divisible by $2^{2}$, thus we have

$$
\begin{equation*}
\left(C_{9}-2^{2} l\right) u^{42} \in \sum_{i=0}^{3}\left(2^{5-i} t^{i}\right) \widetilde{K}\left(\bar{X}_{9}\right)^{(42+i)} \tag{16}
\end{equation*}
$$

By (2), (10), both groups $2^{5} \widetilde{K}\left(\bar{X}_{9}\right)^{(42)}+\left(2^{4} t\right) \widetilde{K}\left(\bar{X}_{9}\right)^{(43)}$ and $\left(2^{4} t^{2}\right) \widetilde{K}\left(\bar{X}_{9}\right)^{(44)}$ are contained in $I\left(X_{9}\right)$. As $e_{1} C_{9} u^{42}=t\left(e_{1} C_{9} u^{43}\right) \in I\left(X_{9}\right)$, it follows from (16) and (9) with $n=9$ that

$$
\begin{equation*}
\left(2^{2} p+2^{3} a p\right) u^{42} \in I\left(X_{9}\right) \text { and }\left(2^{3} l+2^{3} b p\right) u^{42} \in I\left(X_{9}\right) \tag{17}
\end{equation*}
$$

for some integers $a$ and $b$, by multiplying the element in (16) by $e_{1}$ and 2 , respectively. As $\left(2^{3} p\right) u^{42}=e_{1} \cdot\left(2^{3} l+2^{3} b p\right) u^{42} \in I\left(X_{9}\right)$, the statement (ii) for $X_{9}$ follows by (17).

Since $C_{10}=2 e_{10} C_{9}$, by the same argument as above we obtain

$$
\left(C_{10}-2^{3} l\right) u^{52} \in \sum_{i=0}^{3}\left(2^{6-i} t^{i}\right) \widetilde{K}\left(\bar{X}_{10}\right)^{(52+i)}
$$

thus we get

$$
\begin{equation*}
\left(2^{3} p+2^{4} c p\right) u^{52} \in I\left(X_{10}\right) \text { and }\left(2^{4} l+2^{4} d p\right) u^{52} \in I\left(X_{10}\right) \tag{18}
\end{equation*}
$$

for some integers $c$ and $d$, by multiplying the element $\left(C_{10}-2^{3} l\right) u^{52}$ by $e_{1}$ and 2 , respectively. Again, since $\left(2^{4} p\right) u^{52}=e_{1} \cdot\left(2^{4} l+2^{4} d p\right) u^{52} \in I\left(X_{10}\right)$, by (18) the proof of (ii) is complete.
