

**When to sell an indivisible object:  
Optimal timing with Markovian consumers**

**Abstract**

We study the problem of when to sell an indivisible object. There is a monopolistic seller who owns an indivisible object and plans to sell it over a given span of time to the set of potential buyers whose valuations for the object evolve over time. We formulate the seller's problem as a dynamic mechanism design problem. We provide the procedure for finding the optimal solution and show how to check incentive compatibility. We also examine sufficient conditions for the optimality of myopic stopping rule and ex-post individual rationality. In addition, we present some comparative static results regarding the seller's revenue and the selling time.

# 1 Introduction

We study the problem of when to sell an indivisible object. There is a monopolistic seller who owns an indivisible object and plans to sell it over a given span of time to the set of potential buyers whose valuations for the object evolve over time. For instance, the seller is a wholesale company and the buyers are retailers whose final demands fluctuate due to changing retailer-specific circumstances and general economic conditions. To find the optimal selling procedure, we adopt the dynamic mechanism design approach. The literature on dynamic mechanism design is growing rapidly, as evidenced by the literature overviews of Bergemann and Said (2011), Vohra (2012), Bergemann and Pavan (2015), Pavan (2017), and Bergemann and Välimäki (2019).

In the next section, we formulate a general dynamic mechanism design problem and present a necessary and sufficient condition as well as tractable sufficient conditions for incentive compatibility. This material is closely related to Pavan *et al.* (2014). We then set up the monopolistic seller's problem as a dynamic mechanism design problem in section 3. The seller chooses the stochastic selling time to maximize his revenue subject to the constraints that (i) he can sell at most one indivisible object over the entire span of time, (ii) the buyers have non-negative payoffs from participating in the mechanism, and (iii) the buyers have an incentive to tell the true valuations in each period. The seller commits to the mechanism.

As is standard in the mechanism design literature, we solve for the relaxed problem as ignoring the last constraint, and then check whether the solution satisfies the ignored constraint. The seller observes Markovian random variables, which are buyers' valuations, in each period and decides when to stop and sell the object. Hence, the seller's problem is essentially an optimal stopping problem. However, we also have to check the participation constraint and the incentive constraint of buyers' telling the truth. Therefore, our problem is more complicated than the standard optimal stopping problem in a sense.

We provide the procedure for finding the optimal solution and show how to check incentive compatibility by utilizing the results obtained in section 2. We first analyze several two-period examples, and then move on to the general case with an arbitrary number of periods. It may sometimes be a difficult task to find an optimal allocation as well as to check incentive compatibility. Hence, it would be nice if the myopic stopping rule, which compares the seller's current revenue only with the next period's expected revenue, is optimal. Proposition 1 presents a sufficient condition for the optimality of myopic stopping rule. We also examine ex-post participation constraint, that is, whether buyers have an incentive to participate in the mechanism for all periods, not only for the first period. Proposition 2 shows that ex-post individual rationality holds if the transition kernel regarding buyers' valuations satisfies the first-order stochastic dominance. Next, Propositions 3 and 4 present comparative static results regarding the seller's revenue and the selling time. The final section contains a discussion on straightforward extensions and future research agenda.

As far as we know, this is the first paper that investigates the optimal selling time against a fixed set of buyers whose valuations evolve over time. The revenue management literature also studies the optimal sales of homogeneous goods over time, but the potential buyers in this framework do not live in all periods but arrive randomly in each period and, more importantly, each buyer's valuation for the good stays the same over his/her life span. See, in particular, Gallien (2006), Board and Skrzypacz (2016), and Gershkov *et al.* (2018) that employ the mechanism design approach and study environments in which arrival times are private information and buyers act strategically. These paper also contain good literature reviews on revenue management. Other notable papers that study optimal dynamic mechanisms for settings with randomly arriving buyers are Pai and Vohra (2013) and Mierendorff (2016).

As mentioned above, this paper is close in spirit to the theory of optimal stopping time. See the excellent books of Chow *et al.* (1971), Shiryaev (1978), and Ferguson

(2006) for general theory. See also Stigler (1961), McCall (1965), and the survey paper of Lippman and McCall (1976) for this line of research in the economics literature. Compared to these works, the present paper is a work of mechanism design with its focus on incentive compatibility and individual rationality.

## 2 The dynamic mechanism design formulation

We consider a single-player setting without loss of generality.<sup>1</sup> Let  $t \in \{1, 2, \dots, T\}$  denote a period, where  $T$  may be infinite. The player's type in period  $t$ , which is private information, is  $\theta_t \in \Theta = [\underline{\theta}, \bar{\theta}]$  with  $0 \leq \underline{\theta} < \bar{\theta} \leq \infty$ . After  $\theta_t$  is realized in period  $t$ , a public action  $a_t \in A$  is determined. In addition, let  $z_t \in \mathbb{R}$  be a monetary transfer from the player in period  $t$ . Given sequences  $(\theta_1, \dots, \theta_T)$  of types and  $(a_1, \dots, a_T)$  of actions, together with  $(z_1, \dots, z_T)$  of monetary transfers, the player's total payoff is

$$\sum_{t=1}^T \delta^{t-1} (v(\theta_t, a_t) - z_t),$$

where  $\delta \in [0, 1]$  is the discount factor and  $v(\cdot)$  is a (one-period) valuation function.<sup>2</sup> Let  $F_1(\theta_1)$  denote the distribution of  $\theta_1$ , with  $f_1(\theta_1)$  being the corresponding density function. Define  $\theta^t = (\theta_1, \dots, \theta_t)$  and  $a^t = (a_1, \dots, a_t)$ , and let  $F_t(\theta_t | \theta^{t-1}, a^{t-1})$  denote the conditional distribution of  $\theta_t$ , with  $f_t(\theta_t | \theta^{t-1}, a^{t-1})$  being the corresponding density function. We impose the following *Markov property* throughout the paper:

$$F_t(\theta_t | \theta^{t-1}, a^{t-1}) = F_t(\theta_t | \theta_{t-1}, a_{t-1}),$$

that is,  $F_t$  does not depend on  $\theta_s$  or  $a_s$  for  $s = 1, \dots, t-2$ .<sup>3</sup>

A dynamic (direct) mechanism is given by the decision rule  $\alpha_t : \Theta^{t-1} \times A^{t-1} \times \Theta \rightarrow A$  and the transfer scheme  $\tau_t : \Theta^{t-1} \times A^{t-1} \times \Theta \rightarrow \mathbb{R}$  for  $t = 1, \dots, T$ . Thus,

<sup>3</sup> We may alternatively impose the Markov assumption as  $F_t(\theta_t | \theta^{t-1}, a^{t-1}) = F_t(\theta_t | \theta_{t-1}, a^{t-1})$ , i.e.,  $F_t$  does not depend on  $\theta_s$  but depends on  $a_s$  for  $s = 1, \dots, t-2$ . This alternative assumption does not affect the following results.

$\alpha_t(\hat{\theta}^{t-1}, a^{t-1}, \hat{\theta}_t)$  and  $\tau_t(\hat{\theta}^{t-1}, a^{t-1}, \hat{\theta}_t)$  are the action chosen and the transfer, respectively, in period  $t$  when the player's reports and the actions chosen in previous periods are  $\hat{\theta}^{t-1}$  and  $a^{t-1}$ , respectively, and the report in this period is  $\hat{\theta}_t$ .<sup>4</sup> The player's strategy is  $\sigma_t : \Theta^{t-1} \times \Theta^{t-1} \times A^{t-1} \times \Theta \rightarrow \Theta$  for  $t = 1, \dots, T$ . Thus,  $\hat{\theta}_t = \sigma_t(\theta^{t-1}, \hat{\theta}^{t-1}, a^{t-1}, \theta_t)$  is the report in period  $t$  when the type, report, and action in period  $s$  for  $s = 1, \dots, t-1$  are  $\theta_s, \hat{\theta}_s$ , and  $a_s$ , respectively, and the type in this period is  $\theta_t$ .

Define a period- $t$  history

$$\hat{h}^t = (\hat{\theta}_1, \alpha_1(\hat{\theta}_1), \hat{\theta}_2, \alpha_2(\hat{\theta}_1, \alpha_1(\hat{\theta}_1), \hat{\theta}_2), \dots, \hat{\theta}_{t-1}, \alpha_{t-1}(\hat{\theta}_1, \alpha_1(\hat{\theta}_1), \dots, \hat{\theta}_{t-1})).$$

In recursive form,  $\hat{h}^t = (\hat{h}^{t-1}, \hat{\theta}_{t-1}, \alpha_{t-1}(\hat{h}^{t-1}, \hat{\theta}_{t-1}))$  with  $\hat{h}^1 = \emptyset$ . Thus,  $\hat{h}^t$  is the sequence of reports  $\hat{\theta}^{t-1}$  and corresponding actions given by the decision rule. Define recursively

$$\begin{aligned} U_t(\hat{\theta}_t, \theta_t; \hat{\theta}^{t-1}) &= v(\theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) - \tau_t(\hat{h}^t, \hat{\theta}_t) \\ &+ \delta \int_{\theta_{t+1}=\underline{\theta}}^{\bar{\theta}} U_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^{t-1}, \hat{\theta}_t) dF_{t+1}(\tilde{\theta}_{t+1} | \theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)), \end{aligned}$$

and define with a slight abuse of notation that

$$U_t(\theta_t; \hat{\theta}^{t-1}) = U_t(\theta_t, \theta_t; \hat{\theta}^{t-1}).$$

$U_t(\hat{\theta}_t, \theta_t; \hat{\theta}^{t-1})$  is the player's continuation payoff in period  $t$  when the report and the action chosen in period  $s = 1, \dots, t-1$  are  $\hat{\theta}_s$  and  $\alpha_s(\hat{h}^s, \hat{\theta}_s)$  respectively and the true type and the report in this period are  $\theta_t$  and  $\hat{\theta}_t$  respectively. Note that  $U_t(\hat{\theta}_t, \theta_t; \hat{\theta}^{t-1})$  does not depend on  $\theta^{t-1}$ , the true types in periods  $1, \dots, t-1$ .<sup>5</sup>

In this case,  $F_{t+1}(\tilde{\theta}_{t+1} | \theta^t, \alpha^t(\hat{h}^t, \hat{\theta}_t))$  depends on the true types  $\theta^t$  and the chosen actions  $\alpha^t(\hat{h}^t, \hat{\theta}_t)$  (that depend on the reports  $\hat{\theta}^t$ ). On the other hand,  $F_{t+1}$  does not depend on the true types  $\theta^{t-1}$  under the Markov assumption.

Incentive compatibility is

$$U_t(\theta_t; \hat{\theta}^{t-1}) \geq U_t(\hat{\theta}_t, \theta_t; \hat{\theta}^{t-1}), \quad (IC_t)$$

for  $t = 1, \dots, T$ .

Observe that  $(IC_t)$  is equivalent to

$$\begin{aligned} & U_t(\theta_t; \hat{\theta}^{t-1}) - U_t(\hat{\theta}_t; \hat{\theta}^{t-1}) \geq v(\theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) - v(\hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) \\ & + \delta \int_{\theta_{t+1}=\underline{\theta}}^{\bar{\theta}} U_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^{t-1}, \hat{\theta}_t) d(F_{t+1}(\tilde{\theta}_{t+1}|\theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) - F_{t+1}(\tilde{\theta}_{t+1}|\hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t))). \end{aligned} \quad (IC'_t)$$

Interchanging the roles of  $\theta_t$  and  $\hat{\theta}_t$ , we have

$$\begin{aligned} & U_t(\hat{\theta}_t; \hat{\theta}^{t-1}) - U_t(\theta_t; \hat{\theta}^{t-1}) \geq v(\hat{\theta}_t, \alpha_t(\hat{h}^t, \theta_t)) - v(\theta_t, \alpha_t(\hat{h}^t, \theta_t)) \\ & + \delta \int_{\theta_{t+1}=\underline{\theta}}^{\bar{\theta}} U_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^{t-1}, \theta_t) d(F_{t+1}(\tilde{\theta}_{t+1}|\hat{\theta}_t, \alpha_t(\hat{h}^t, \theta_t)) - F_{t+1}(\tilde{\theta}_{t+1}|\theta_t, \alpha_t(\hat{h}^t, \theta_t))). \end{aligned}$$

Combining these inequalities, we get

$$\begin{aligned} & v(\hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) - v(\theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) \\ & + \delta \int_{\theta_{t+1}=\underline{\theta}}^{\bar{\theta}} U_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^{t-1}, \hat{\theta}_t) d(F_{t+1}(\tilde{\theta}_{t+1}|\hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) - F_{t+1}(\tilde{\theta}_{t+1}|\theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t))) \\ & \geq U_t(\hat{\theta}_t; \hat{\theta}^{t-1}) - U_t(\theta_t; \hat{\theta}^{t-1}) \\ & \geq v(\hat{\theta}_t, \alpha_t(\hat{h}^t, \theta_t)) - v(\theta_t, \alpha_t(\hat{h}^t, \theta_t)) \\ & + \delta \int_{\theta_{t+1}=\underline{\theta}}^{\bar{\theta}} U_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^{t-1}, \theta_t) d(F_{t+1}(\tilde{\theta}_{t+1}|\hat{\theta}_t, \alpha_t(\hat{h}^t, \theta_t)) - F_{t+1}(\tilde{\theta}_{t+1}|\theta_t, \alpha_t(\hat{h}^t, \theta_t))). \end{aligned}$$

We will assume that both  $v(\cdot)$  and  $f_t(\cdot)$  for  $t = 1, \dots, T$  are continuously differentiable and that  $\alpha_t(\cdot)$  for  $t = 1, \dots, T$  is differentiable almost everywhere. Then, dividing the previous inequalities by  $\hat{\theta}_t - \theta_t$  and taking limits, we get

$$\begin{aligned} & \frac{dU_t(\theta_t; \hat{\theta}^{t-1})}{d\theta_t} = v_\theta(\theta_t, \alpha_t(\hat{h}^t, \theta_t)) \\ & + \delta \int_{\underline{\theta}}^{\bar{\theta}} U_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^{t-1}, \theta_t) \frac{\partial f_{t+1}(\tilde{\theta}_{t+1}|\theta_t, \alpha_t(\hat{h}^t, \theta_t))}{\partial \theta_t} d\tilde{\theta}_{t+1} \end{aligned}$$

almost everywhere. Note that the notation  $v_\theta(\theta, a)$  is the partial derivative of  $v(\theta, a)$  with respect to  $\theta$  and that  $\partial f_{t+1}/\partial\theta_t$  is only with respect to  $\theta_t$  in  $f_{t+1}(\theta_{t+1}|\theta_t, a_t)$ . We have

$$\begin{aligned} \frac{dU_t(\theta_t; \hat{\theta}^{t-1})}{d\theta_t} &= v_\theta(\theta_t, \alpha_t(\hat{h}^t, \theta_t)) + \delta \left[ U_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^{t-1}, \theta_t) \frac{\partial F_{t+1}(\tilde{\theta}_{t+1}|\theta_t, \alpha_t(\hat{h}^t, \theta_t))}{\partial\theta_t} \right]_{\underline{\theta}}^{\bar{\theta}} \\ &\quad - \delta \int_{\underline{\theta}}^{\bar{\theta}} \frac{dU_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^{t-1}, \theta_t)}{d\theta_{t+1}} \frac{\partial F_{t+1}(\tilde{\theta}_{t+1}|\theta_t, \alpha_t(\hat{h}^t, \theta_t))}{\partial\theta_t} d\tilde{\theta}_{t+1} \\ &= v_\theta(\theta_t, \alpha_t(\hat{h}^t, \theta_t)) - \delta \int_{\underline{\theta}}^{\bar{\theta}} \frac{dU_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^{t-1}, \theta_t)}{d\theta_{t+1}} \frac{\partial F_{t+1}(\tilde{\theta}_{t+1}|\theta_t, \alpha_t(\hat{h}^t, \theta_t))}{\partial\theta_t} d\tilde{\theta}_{t+1}, \end{aligned}$$

where the first equality follows from integration by parts and the second equality follows from the fact that  $F_{t+1}(\underline{\theta}|\theta_t, \alpha_t(\hat{h}^t, \theta_t)) = 0$  and  $F_{t+1}(\bar{\theta}|\theta_t, \alpha_t(\hat{h}^t, \theta_t)) = 1$  for all  $\theta_t$  and so  $\partial F_{t+1}/\partial\theta_t = 0$  when  $\tilde{\theta}_{t+1} = \underline{\theta}$  or  $\bar{\theta}$ .

By recursion, we have

$$\begin{aligned} \frac{dU_t(\theta_t; \hat{\theta}^{t-1})}{d\theta_t} &= v_\theta(\theta_t, \alpha_t(\hat{h}^t, \theta_t)) \\ &+ \sum_{s=t+1}^T (-\delta)^{s-t} \underbrace{\int_{\underline{\theta}}^{\bar{\theta}} \cdots \int_{\underline{\theta}}^{\bar{\theta}}}_{(s-t)\text{-times}} v_\theta(\tilde{\theta}_s, \alpha_s(\hat{h}^t, \theta_t, \alpha_t(\hat{h}^t, \theta_t), \tilde{\theta}_{t+1}, \alpha_{t+1}(\hat{h}^t, \theta_t, \alpha_t(\hat{h}^t, \theta_t), \tilde{\theta}_{t+1}), \dots, \tilde{\theta}_s)) \\ &\times \frac{\partial F_{t+1}(\tilde{\theta}_{t+1}|\theta_t, \alpha_t(\hat{h}^t, \theta_t))}{\partial\theta_t} \cdots \frac{\partial F_s(\tilde{\theta}_s|\tilde{\theta}_{s-1}, \alpha_{s-1}(\hat{h}^t, \theta_t, \alpha_t(\hat{h}^t, \theta_t), \tilde{\theta}_{t+1}, \dots, \tilde{\theta}_{s-1}))}{\partial\theta_{s-1}} d\tilde{\theta}_s \cdots d\tilde{\theta}_{t+1} \end{aligned} \quad (1)$$

almost everywhere.

Define

$$h_+^s(\hat{h}^t, \theta_t) = (\hat{h}^t, \theta_t, \alpha_t(\hat{h}^t, \theta_t), \tilde{\theta}_{t+1}, \alpha_{t+1}(\hat{h}^t, \theta_t, \alpha_t(\hat{h}^t, \theta_t), \tilde{\theta}_{t+1})) \cdots, \tilde{\theta}_s),$$

that is,  $h_+^s(\hat{h}^t, \theta_t)$  is the period- $s$  history plus period- $s$  report  $\tilde{\theta}_s$ , conditional on period- $t$  history  $\hat{h}^t$  and period- $t$  report  $\theta_t$ . Then,

$$h_+^s(\hat{h}^t, \hat{\theta}_t) = (\hat{h}^t, \hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t), \tilde{\theta}_{t+1}, \alpha_{t+1}(\hat{h}^t, \hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t), \tilde{\theta}_{t+1})) \cdots, \tilde{\theta}_s).$$

Define

$$\begin{aligned}
D_t(\hat{\theta}_t, \theta_t; \hat{\theta}^{t-1}) &= v_\theta(\theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) \\
&+ \sum_{s=t+1}^T (-\delta)^{s-t} \underbrace{\int_{\underline{\theta}}^{\bar{\theta}} \cdots \int_{\underline{\theta}}^{\bar{\theta}}}_{(s-t)\text{-times}} v_\theta(\tilde{\theta}_s, \alpha_s(h_+^s(\hat{h}^t, \hat{\theta}_t))) \frac{\partial F_{t+1}(\tilde{\theta}_{t+1} | \theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t))}{\partial \theta_t} \\
&\times \frac{\partial F_{t+2}(\tilde{\theta}_{t+2} | \tilde{\theta}_{t+1}, \alpha_{t+1}(h_+^{t+1}(\hat{h}^t, \hat{\theta}_t)))}{\partial \theta_{t+1}} \cdots \frac{\partial F_s(\tilde{\theta}_s | \tilde{\theta}_{s-1}, \alpha_{s-1}(h_+^{s-1}(\hat{h}^t, \hat{\theta}_t)))}{\partial \theta_{s-1}} d\tilde{\theta}_s \cdots d\tilde{\theta}_{t+1}.
\end{aligned} \tag{2}$$

Note that this essentially captures the future impact of the change in  $\theta_t$  when the current true type is  $\theta_t$ , the current report is  $\hat{\theta}_t$ , and the past reports are  $\hat{\theta}^{t-1}$ . Note also that (2) can be written in recursive form as

$$\begin{aligned}
D_t(\hat{\theta}_t, \theta_t; \hat{\theta}^{t-1}) &= v_\theta(\theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) \\
&- \delta \int_{\underline{\theta}}^{\bar{\theta}} D_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^t) \frac{\partial F_{t+1}(\tilde{\theta}_{t+1} | \theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t))}{\partial \theta_t} d\tilde{\theta}_{t+1}.
\end{aligned} \tag{3}$$

Define with a slight abuse of notation that  $D_t(\theta_t; \hat{\theta}^{t-1}) = D_t(\theta_t, \theta_t; \hat{\theta}^{t-1})$ . Then, (1) can be rewritten as

$$\frac{dU_t(\theta_t; \hat{\theta}^{t-1})}{d\theta_t} = D_t(\theta_t; \hat{\theta}^{t-1})$$

almost everywhere. Since  $D_t(\theta_t; \hat{\theta}^{t-1})$  is continuous almost everywhere on the interval  $[\underline{\theta}, \bar{\theta}]$ , it is Riemann integrable and we have

$$U_t(\theta_t; \hat{\theta}^{t-1}) = U_t(\underline{\theta}; \hat{\theta}^{t-1}) + \int_{\underline{\theta}}^{\theta_t} D_t(\tilde{\theta}_t; \hat{\theta}^{t-1}) d\tilde{\theta}_t.$$

In particular, we have

$$U_1(\theta_1) = U_1(\underline{\theta}) + \int_{\underline{\theta}}^{\theta_1} D_1(\tilde{\theta}_1) d\tilde{\theta}_1,$$

where

$$\begin{aligned}
D_1(\tilde{\theta}_1) &= v_\theta(\tilde{\theta}_1, \alpha_1(\tilde{\theta}_1)) + \sum_{t=2}^T (-\delta)^{t-1} \underbrace{\int_{\underline{\theta}}^{\bar{\theta}} \cdots \int_{\underline{\theta}}^{\bar{\theta}}}_{(t-1)\text{-times}} v_\theta(\tilde{\theta}_t, \alpha_t(\tilde{h}^t, \tilde{\theta}_t)) \\
&\times \frac{\partial F_2(\tilde{\theta}_2 | \tilde{\theta}_1, \alpha_1(\tilde{\theta}_1))}{\partial \theta_1} \cdots \frac{\partial F_t(\tilde{\theta}_t | \tilde{\theta}_{t-1}, \alpha_{t-1}(\tilde{h}^{t-1}, \tilde{\theta}_{t-1}))}{\partial \theta_{t-1}} d\tilde{\theta}_t \cdots d\tilde{\theta}_2.
\end{aligned}$$



We now present a necessary and sufficient condition for incentive compatibility.

**Theorem 1.** *Incentive compatibility holds if and only if*

$$U_t(\theta_t; \hat{\theta}^{t-1}) = U_t(\underline{\theta}; \hat{\theta}^{t-1}) + \int_{\underline{\theta}}^{\theta_t} D_t(\tilde{\theta}_t; \hat{\theta}^{t-1}) d\tilde{\theta}_t \quad \forall t, \forall \theta_t \text{ and } \forall \hat{\theta}^{t-1}; \quad (4)$$

and

$$\int_{\hat{\theta}_t}^{\theta_t} D_t(\tilde{\theta}_t; \hat{\theta}^{t-1}) d\tilde{\theta}_t \geq \int_{\hat{\theta}_t}^{\theta_t} D_t(\hat{\theta}_t, \tilde{\theta}_t; \hat{\theta}^{t-1}) d\tilde{\theta}_t \quad \forall t, \forall \theta_t, \forall \hat{\theta}_t \text{ and } \forall \hat{\theta}^{t-1}. \quad (5)$$

Proof: ( $\Leftarrow$  part) Observe first that, by (4), the left-hand side of (5) is equal to  $U_t(\theta_t; \hat{\theta}^{t-1}) - U_t(\hat{\theta}_t; \hat{\theta}^{t-1})$ . Observe next that the right-hand side of (5) is equal to

$$\begin{aligned} & v(\theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) - v(\hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) \\ & - \delta \int_{\hat{\theta}_t}^{\theta_t} \int_{\underline{\theta}}^{\bar{\theta}} D_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^t) \frac{\partial F_{t+1}(\tilde{\theta}_{t+1} | \tilde{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t))}{\partial \theta_t} d\tilde{\theta}_{t+1} d\tilde{\theta}_t \\ & = v(\theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) - v(\hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) \\ & - \delta \int_{\hat{\theta}_t}^{\theta_t} \int_{\underline{\theta}}^{\bar{\theta}} \frac{dU_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^t)}{d\theta_{t+1}} \frac{\partial F_{t+1}(\tilde{\theta}_{t+1} | \tilde{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t))}{\partial \theta_t} d\tilde{\theta}_{t+1} d\tilde{\theta}_t \\ & = v(\theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) - v(\hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) \\ & - \delta \int_{\underline{\theta}}^{\bar{\theta}} \frac{dU_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^t)}{d\theta_{t+1}} \int_{\hat{\theta}_t}^{\theta_t} \frac{\partial F_{t+1}(\tilde{\theta}_{t+1} | \tilde{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t))}{\partial \theta_t} d\tilde{\theta}_t d\tilde{\theta}_{t+1} \\ & = v(\theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) - v(\hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) \\ & - \delta \int_{\underline{\theta}}^{\bar{\theta}} \frac{dU_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^t)}{d\theta_{t+1}} \left( F_{t+1}(\tilde{\theta}_{t+1} | \theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) - F_{t+1}(\tilde{\theta}_{t+1} | \hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) \right) d\tilde{\theta}_{t+1} \\ & = v(\theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) - v(\hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) \\ & - \delta \left[ U_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^t) \left( F_{t+1}(\tilde{\theta}_{t+1} | \theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) - F_{t+1}(\tilde{\theta}_{t+1} | \hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) \right) \right]_{\underline{\theta}}^{\bar{\theta}} \\ & + \delta \int_{\underline{\theta}}^{\bar{\theta}} U_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^t) d \left( F_{t+1}(\tilde{\theta}_{t+1} | \theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) - F_{t+1}(\tilde{\theta}_{t+1} | \hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) \right) \\ & = v(\theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) - v(\hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) \\ & + \delta \int_{\underline{\theta}}^{\bar{\theta}} U_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^t) d \left( F_{t+1}(\tilde{\theta}_{t+1} | \theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) - F_{t+1}(\tilde{\theta}_{t+1} | \hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) \right). \end{aligned}$$

The first expression follows from (3), the first equality follows from the differential form of (4) for  $U_{t+1}(\tilde{\theta}_{t+1}|\hat{\theta}^t)$ , the second equality follows from the change in the order of integration, the third equality follows from integrating out the inner integral, the fourth equality follows from integration by parts, and the last inequality follows from the fact that  $F_{t+1}(\underline{\theta}|\theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) = F_{t+1}(\underline{\theta}|\hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) = 0$  and  $F_{t+1}(\bar{\theta}|\theta_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) = F_{t+1}(\bar{\theta}|\hat{\theta}_t, \alpha_t(\hat{h}^t, \hat{\theta}_t)) = 1$ . Putting together, this is nothing but  $(IC'_t)$ .

( $\Rightarrow$  part) Recall from the discussion preceding this theorem that  $(IC_t)$  implies (4). It is also straightforward to see that  $(IC_t)$  implies (5): Follow the reverse steps of the previous argument. *Q.E.D.*

Pavan *et al.* (2014) call the inequality (5) as *integral monotonicity*. To examine inequality (5) in some detail, let us consider the following assumption.

**Assumption 1.** (The single-crossing condition) We have

- (i)  $\forall a : v(\hat{\theta}, a) \geq v(\theta, a)$  for  $\hat{\theta} \geq \theta$ , and
- (ii)  $v(\hat{\theta}, \hat{a}) - v(\theta, \hat{a}) \geq v(\hat{\theta}, a) - v(\theta, a)$  for all  $\hat{\theta} \geq \theta$  and  $\hat{a} \geq a$ .

Observe that, for the last period  $T$  when  $T$  is finite, we have  $D_T(\hat{\theta}_T, \theta_T; \hat{\theta}^{T-1}) = v_\theta(\theta_T, \alpha_T(\hat{h}^T, \hat{\theta}_T))$ . Thus, (5) is equivalent to

$$\int_{\hat{\theta}_T}^{\theta_T} (v_\theta(\tilde{\theta}_T, \alpha_T(\hat{h}^T, \tilde{\theta}_T)) - v_\theta(\tilde{\theta}_T, \alpha_T(\hat{h}^T, \hat{\theta}_T))) d\tilde{\theta}_T \geq 0 \quad (6)$$

for all  $\theta_T, \hat{\theta}_T$  and  $\hat{h}^T$ . Note that, if

$$\forall \hat{h}^T : \alpha_T(\hat{h}^T, \theta_T) \geq \alpha_T(\hat{h}^T, \hat{\theta}_T) \text{ for } \theta_T \geq \hat{\theta}_T \quad (7)$$

holds, then (6) holds. Conversely, (6) implies by (4) that

$$U_T(\theta_T; \hat{\theta}^{T-1}) - U_T(\hat{\theta}_T; \hat{\theta}^{T-1}) \geq v(\theta_T, \alpha_T(\hat{h}^T, \hat{\theta}_T)) - v(\hat{\theta}_T, \alpha_T(\hat{h}^T, \hat{\theta}_T)),$$

which is nothing but  $(IC'_T)$ . Interchanging the roles of  $\theta_T$  and  $\hat{\theta}_T$ , we have

$$U_T(\hat{\theta}_T; \hat{\theta}^{T-1}) - U_T(\theta_T; \hat{\theta}^{T-1}) \geq v(\hat{\theta}_T, \alpha_T(\hat{h}^T, \theta_T)) - v(\theta_T, \alpha_T(\hat{h}^T, \theta_T)).$$

Combining these inequalities, we get

$$\begin{aligned} v(\hat{\theta}_T, \alpha_T(\hat{h}^T, \hat{\theta}_T)) - v(\theta_T, \alpha_T(\hat{h}^T, \hat{\theta}_T)) &\geq U_T(\hat{\theta}_T; \hat{\theta}^{T-1}) - U_T(\theta_T; \hat{\theta}^{T-1}) \\ &\geq v(\hat{\theta}_T, \alpha_T(\hat{h}^T, \theta_T)) - v(\theta_T, \alpha_T(\hat{h}^T, \theta_T)). \end{aligned}$$

This implies (7) under Assumption 1. Hence, (6) implies (7). The preceding argument and Theorem 1 then imply the following result.

**Corollary 1.** *Under Assumption 1 of single-crossing condition, (IC<sub>T</sub>) holds if and only if (4) and (7) hold.*

The inequality (7) is the monotonicity condition. Note in particular that this characterization applies to the static model, i.e, the one-period model in which  $T = 1$ .

For general  $t$ , we see that (5) holds if  $D_t(\hat{\theta}_t, \theta_t; \hat{\theta}^{t-1})$  is increasing in  $\hat{\theta}_t$ .<sup>67</sup> Moreover, we have the following sufficient condition for incentive compatibility.

**Corollary 2.** *Under Assumption 1 of single-crossing condition, the four conditions below together with (4) imply incentive compatibility.*

- (i)  $\alpha_t(\hat{h}^t, \theta_t) \geq \alpha_t(\hat{h}^t, \hat{\theta}_t)$  for all  $t$ ,  $\hat{h}^t$  and  $\theta_t \geq \hat{\theta}_t$ ;
- (ii)  $\partial F_{t+1}(\theta_{t+1} | \theta_t, a_t) / \partial \theta_t \leq 0$  for all  $t$ ,  $\theta_t$ ,  $a_t$  and  $\theta_{t+1}$ ;
- (iii)  $|\partial F_{t+1}(\theta_{t+1} | \theta_t, a_t) / \partial \theta_t|$  is increasing in  $a_t$  for all  $t$ ,  $\theta_t$ , and  $\theta_{t+1}$ ; and
- (iv)  $\alpha_s(h_+^s(\hat{h}^t, \hat{\theta}_t))$  is increasing in  $\hat{\theta}_t$  for all  $\hat{h}^t$  and  $s = t + 1, \dots, T$ .

Proof: It is straightforward to see by an inspection of (2) that  $D_t(\hat{\theta}_t, \theta_t; \hat{\theta}^{t-1})$  is increasing in  $\hat{\theta}_t$  if the conditions (i) to (iv) hold. Theorem 1 then implies incentive compatibility. *Q.E.D.*

Note that condition (i) is the monotonicity condition and condition (ii) is the first-order stochastic dominance condition. Note also that condition (iii) holds trivially when  $F_{t+1}$

<sup>7</sup> Pavan *et al.* (2014) call this condition as average monotonicity. Note that  $D_t(\hat{\theta}_t, \theta_t; \hat{\theta}^{t-1})$  is increasing in  $\hat{\theta}_t$  if each individual term in (2) is increasing in  $\hat{\theta}_t$ : Pavan *et al.* (2014) in turn call this condition as ex-post monotonicity (with the additional assumption that  $F_{t+1}(\theta_{t+1} | \theta_t, a_t) = F_{t+1}(\theta_{t+1} | \theta_t)$ , i.e., the transition kernel  $F_{t+1}$  does not depend on the public action).

$(\theta_{t+1}|\theta_t, a_t)$  does not depend on  $a_t$ , and that condition (iv) holds trivially when the current decision does not depend on past reports.

By definition of  $U_1(\theta_1)$ , the total expected payment the player makes is

$$\begin{aligned} & \int_{\underline{\theta}}^{\bar{\theta}} v(\tilde{\theta}_1, \alpha_1(\tilde{\theta}_1)) f_1(\tilde{\theta}_1) d\tilde{\theta}_1 + \sum_{t=2}^T \delta^{t-1} \underbrace{\int_{\underline{\theta}}^{\bar{\theta}} \cdots \int_{\underline{\theta}}^{\bar{\theta}}}_{t\text{-times}} v(\tilde{\theta}_t, \alpha_t(\tilde{h}^t, \tilde{\theta}_t)) \\ & \quad \times f_t(\tilde{\theta}_t|\tilde{\theta}_{t-1}, \alpha_{t-1}(\tilde{h}^{t-1}, \tilde{\theta}_{t-1})) \cdots f_2(\tilde{\theta}_2|\tilde{\theta}_1, \alpha_1(\tilde{\theta}_1)) f_1(\tilde{\theta}_1) d\tilde{\theta}_t \cdots d\tilde{\theta}_1 \\ & - \int_{\underline{\theta}}^{\bar{\theta}} U_1(\tilde{\theta}_1) f_1(\tilde{\theta}_1) d\tilde{\theta}_1. \end{aligned}$$

Since

$$\begin{aligned} & \int_{\underline{\theta}}^{\bar{\theta}} U_1(\tilde{\theta}_1) f_1(\tilde{\theta}_1) d\tilde{\theta}_1 = \left[ -U^1(\tilde{\theta}_1)(1 - F_1(\tilde{\theta}_1)) \right]_{\underline{\theta}}^{\bar{\theta}} + \int_{\underline{\theta}}^{\bar{\theta}} \frac{dU_1(\tilde{\theta}_1)}{d\theta_1} (1 - F_1(\tilde{\theta}_1)) d\tilde{\theta}_1 \\ & = U_1(\underline{\theta}) + \int_{\underline{\theta}}^{\bar{\theta}} D_1(\tilde{\theta}_1)(1 - F_1(\tilde{\theta}_1)) d\tilde{\theta}_1 \end{aligned}$$

where the second equality holds by (4), the total expected payment is equal to

$$\begin{aligned} & \int_{\underline{\theta}}^{\bar{\theta}} \left[ v(\tilde{\theta}_1, \alpha_1(\tilde{\theta}_1)) - v_\theta(\tilde{\theta}_1, \alpha_1(\tilde{\theta}_1)) \frac{1 - F_1(\tilde{\theta}_1)}{f_1(\tilde{\theta}_1)} \right] f_1(\tilde{\theta}_1) d\tilde{\theta}_1 \\ & + \sum_{t=2}^T \delta^{t-1} \int_{\underline{\theta}}^{\bar{\theta}} \cdots \int_{\underline{\theta}}^{\bar{\theta}} \left[ v(\tilde{\theta}_t, \alpha_t(\tilde{h}^t, \tilde{\theta}_t)) + (-1)^t v_\theta(\tilde{\theta}_t, \alpha_t(\tilde{h}^t, \tilde{\theta}_t)) \frac{1 - F_1(\tilde{\theta}_1)}{f_1(\tilde{\theta}_1)} \right. \\ & \quad \times \left. \frac{\partial F_2(\tilde{\theta}_2|\tilde{\theta}_1, \alpha_1(\tilde{\theta}_1))/\partial \theta_1}{f_2(\tilde{\theta}_2|\tilde{\theta}_1, \alpha_1(\tilde{\theta}_1))} \cdots \frac{\partial F_t(\tilde{\theta}_t|\tilde{\theta}_{t-1}, \alpha_{t-1}(\tilde{h}^{t-1}, \tilde{\theta}_{t-1}))/\partial \theta_{t-1}}{f_t(\tilde{\theta}_t|\tilde{\theta}_{t-1}, \alpha_{t-1}(\tilde{h}^{t-1}, \tilde{\theta}_{t-1}))} \right] \\ & \quad \times f_t(\tilde{\theta}_t|\tilde{\theta}_{t-1}, \alpha_{t-1}(\tilde{h}^{t-1}, \tilde{\theta}_{t-1})) \cdots f_1(\tilde{\theta}_1) d\tilde{\theta}_t \cdots d\tilde{\theta}_1 \\ & - U_1(\underline{\theta}). \end{aligned} \tag{8}$$

### 3 The optimal selling time

#### 3.1. The optimal solution

We turn to the monopolistic seller's problem. The seller owns an indivisible object and decides when and at what price to sell it to maximize his revenue. This is an instance of the

dynamic mechanism design of the previous section, where the mechanism designer is the seller and the players are the buyers. Thus, the public action  $a_t \in A$  is the probability of sales  $q_t \in [0, 1]$  and the monetary transfer  $z_t \in \mathbb{R}$  is the price of the object. Assume without loss of generality that (i) the seller does not attach a value to the object, i.e., the reservation value of the seller is zero, and that (ii) there is a single buyer.<sup>8</sup> Let us consider a canonical monopolistic pricing in which the buyer's valuation function is given by  $v(\theta, a) = \theta a = \theta q$ . Then, we have  $v(\theta_t, \alpha_t(h^t, \theta_t)) = \theta_t q_t(h^t, \theta_t)$  and  $v_\theta(\theta_t, \alpha_t(h^t, \theta_t)) = q_t(h^t, \theta_t)$ .

If we define<sup>9</sup>

$$\begin{aligned} \psi_1(\theta_1) &= \theta_1 - \frac{1 - F_1(\theta_1)}{f_1(\theta_1)}; \text{ and for } t = 2, \dots, T, \\ \psi_t(\theta_1, \dots, \theta_t) &= \theta_t + (-1)^t \frac{1 - F_1(\theta_1)}{f_1(\theta_1)} \\ &\times \frac{\partial F_2(\theta_2|\theta_1, q_1(\theta_1))/\partial \theta_1}{f_2(\theta_2|\theta_1, q_1(\theta_1))} \dots \frac{\partial F_t(\theta_t|\theta_{t-1}, q_{t-1}(h^{t-1}, \theta_{t-1}))/\partial \theta_{t-1}}{f_t(\theta_t|\theta_{t-1}, q_{t-1}(h^{t-1}, \theta_{t-1}))}, \end{aligned} \quad (9)$$

then the buyer's (total expected) payment (8) of the previous section, which is the seller's (total expected) revenue of the present problem, becomes

$$\begin{aligned} &\int_{\underline{\theta}}^{\bar{\theta}} \psi_1(\tilde{\theta}_1) q_1(\tilde{\theta}_1) f_1(\tilde{\theta}_1) d\tilde{\theta}_1 + \sum_{t=2}^T \delta^{t-1} \int_{\underline{\theta}}^{\bar{\theta}} \dots \int_{\underline{\theta}}^{\bar{\theta}} \psi_t(\tilde{\theta}_1, \dots, \tilde{\theta}_t) q_t(\tilde{h}^t, \tilde{\theta}_t) \\ &\times f_t(\tilde{\theta}_t|\tilde{\theta}_{t-1}, q_{t-1}(\tilde{h}^{t-1}, \tilde{\theta}_{t-1})) \dots f_1(\tilde{\theta}_1) d\tilde{\theta}_t \dots d\tilde{\theta}_1 - U_1(\underline{\theta}). \end{aligned} \quad (10)$$

Observe that  $\psi_t(\theta_1, \dots, \theta_t)$  corresponds to the virtual valuation of Myerson (1981) for the static mechanism design. Observe also that the seller's revenue does not depend on the transfer rule and thus the revenue equivalence principle applies. The seller's problem is to choose the probability of sales  $\{q_1(\cdot), \dots, q_T(\cdot)\}$  for the maximization of this revenue

subject to the constraints

- (i)  $0 \leq \sum_{t=1}^T q_t(h^t, \theta_t) \leq 1$  for all  $h^t$  and  $\theta_t$ ;
- (ii)  $U_1(\underline{\theta}) \geq 0$ ; and
- (iii)  $\int_{\hat{\theta}_t}^{\theta_t} D_t(\tilde{\theta}_t; \hat{\theta}^{t-1}) d\tilde{\theta}_t \geq \int_{\hat{\theta}_t}^{\theta_t} D_t(\hat{\theta}_t, \tilde{\theta}_t; \hat{\theta}^{t-1}) d\tilde{\theta}_t \quad \forall t, \forall \theta_t, \forall \hat{\theta}_t$  and  $\forall \hat{\theta}^{t-1}$ , where
 
$$D_t(\hat{\theta}_t, \theta_t; \hat{\theta}^{t-1}) = q_t(\hat{h}^t, \hat{\theta}_t) - \delta \int_{\underline{\theta}}^{\bar{\theta}} D_{t+1}(\tilde{\theta}_{t+1}; \hat{\theta}^t) \frac{\partial F_{t+1}(\tilde{\theta}_{t+1} | \theta_t, q_t(\hat{h}^t, \hat{\theta}_t))}{\partial \theta_t} d\tilde{\theta}_{t+1}.$$

Note that the first constraint is the feasibility condition that the seller can sell at most one indivisible object over the entire span of time, the second constraint is the individual rationality condition (or the participation constraint of the buyer), and the third constraint is inequality (5) of Theorem 1, which concerns incentive compatibility.<sup>10</sup>

As is standard in the mechanism design literature, we solve for the *relaxed* problem as ignoring the last constraint, and then check whether the solution satisfies the ignored constraint. First, it is obvious for revenue maximization that the second constraint is satisfied with equality, i.e.,  $U_1(\underline{\theta}) = 0$ . Next, the optimal solution for the relaxed problem can be found by the following procedure. Let  $V_t(\theta_1, \dots, \theta_t)$  be the continuation value in period  $t$ , that is, the seller's revenue evaluated in period  $t$ , given the realized types of  $\theta^t = (\theta_1, \dots, \theta_t)$  and under the optimal decisions in subsequent periods. Observe that  $V_t(\theta_1, \dots, \theta_t) \geq 0$  for all  $t$  and  $\theta^t$ .

---

**The procedure for finding the optimal solution:**<sup>11</sup>

Start with period 1 and for  $t = 1, \dots, T$ :

- [1] If  $\psi_t(\theta_1, \dots, \theta_t) \leq 0$ , then do not sell in this period and move to the next period.
- [2] If  $\psi_t(\theta_1, \dots, \theta_t) > 0$ , then compare  $\psi_t(\theta_1, \dots, \theta_t)$  with

$$M \stackrel{\text{def}}{=} \delta \int_{\underline{\theta}}^{\bar{\theta}} V_{t+1}(\theta_1, \dots, \theta_t, \tilde{\theta}_{t+1}) f_{t+1}(\tilde{\theta}_{t+1} | \theta_t, q_t(\hat{h}^t, \theta_t)) d\tilde{\theta}_{t+1}.$$

---

<sup>10</sup> Note well that inequality (4) of Theorem 1 is incorporated in the process of deriving the seller's revenue.

<sup>11</sup> We assume that, when the seller is indifferent between selling in this period and selling in a future period (or not selling), he chooses the latter. Any alternative assumption regarding the seller's behavior would be fine.

[2-1] If  $\psi_t(\theta_1, \dots, \theta_t) \leq M$ , then do not sell in this period and move to the next period.

[2-2] If  $\psi_t(\theta_1, \dots, \theta_t) > M$ , then sell in this period.

Moreover, if  $\psi_s(\theta_1, \dots, \theta_s) > 0$  for all  $s = t + 1, \dots, T$  and  $\theta^s = (\theta_1, \dots, \theta_s)$  given  $\theta^t$ , then  $M$  is equal to

$$M' \stackrel{\text{def}}{=} \max_{s=t+1, \dots, T} \delta^{s-t} \int_{\underline{\theta}}^{\bar{\theta}} \dots \int_{\underline{\theta}}^{\bar{\theta}} \psi_s(\theta_1, \dots, \theta_t, \tilde{\theta}_{t+1}, \dots, \tilde{\theta}_s) \\ \times f_s(\tilde{\theta}_s | \tilde{\theta}_{s-1}, q_{s-1}(h_+^{s-1}(\hat{h}^t, \theta_t))) \dots f_{t+1}(\tilde{\theta}_{t+1} | \theta_t, q_t(\hat{h}^t, \theta_t)) d\tilde{\theta}_s \dots d\tilde{\theta}_{t+1}.$$

---

Note: We have  $M = M' = 0$  when  $t = T$  by convention. Hence, it is optimal to sell the object in the last period if and only if  $\psi_T(\theta_1, \dots, \theta_T) > 0$ . Observe that the object may not be sold eventually for some realizations of private information.

Some papers in the literature, including Kakade *et al.* (2013) and Pavan *et al.* (2014), have examined the repeated sales in which a monopolistic seller sells a (perishable) good in each period. The feasibility constraint in this scenario is  $0 \leq q_t(h^t, \theta_t) \leq 1$  for all  $t, h^t$  and  $\theta_t$ , and the optimal solution for the relaxed problem is straightforward: Sell in this period if and only if  $\psi_t(\theta_1, \dots, \theta_t) > 0$ . In comparison, the seller in our setup can sell only one object over the entire span of time and hence the seller's problem is similar to the optimal stopping time problem.

### 3.2. Two-period examples

We first investigate some interesting examples with  $T = 2$ . Observe that inequality (5) is equal to

$$\int_{\hat{\theta}_2}^{\theta_2} q_2(\hat{\theta}_1, q_1(\hat{\theta}_1), \tilde{\theta}_2) d\tilde{\theta}_2 \geq \int_{\hat{\theta}_2}^{\theta_2} q_2(\hat{\theta}_1, q_1(\hat{\theta}_1), \hat{\theta}_2) d\tilde{\theta}_2 \quad (11)$$

for  $t = 2$  and

$$\int_{\hat{\theta}_1}^{\theta_1} q_1(\tilde{\theta}_1) d\tilde{\theta}_1 - \delta \int_{\hat{\theta}_1}^{\theta_1} \int_{\underline{\theta}}^{\bar{\theta}} q_2(\tilde{\theta}_1, q_1(\tilde{\theta}_1), \tilde{\theta}_2) \frac{\partial F_2(\tilde{\theta}_2 | \tilde{\theta}_1, q_1(\tilde{\theta}_1))}{\partial \theta_1} d\tilde{\theta}_2 d\tilde{\theta}_1 \\ \geq \int_{\hat{\theta}_1}^{\theta_1} q_1(\hat{\theta}_1) d\tilde{\theta}_1 - \delta \int_{\hat{\theta}_1}^{\theta_1} \int_{\underline{\theta}}^{\bar{\theta}} q_2(\hat{\theta}_1, q_1(\hat{\theta}_1), \tilde{\theta}_2) \frac{\partial F_2(\tilde{\theta}_2 | \hat{\theta}_1, q_1(\hat{\theta}_1))}{\partial \theta_1} d\tilde{\theta}_2 d\tilde{\theta}_1 \quad (12)$$

for  $t = 1$ . Observe also that (11) holds when  $q_2(\hat{\theta}_1, q_1(\hat{\theta}_1), \theta_2)$  is increasing in  $\theta_2$ . To see whether the optimal solution for the relaxed problem is indeed the optimal solution for the original problem, we will check below whether these inequalities are satisfied. For comparison, we will solve for both the case when  $0 \leq q_t \leq 1$  for  $t = 1, 2$  (the repeated sales scenario) and the case when  $0 \leq q_1 + q_2 \leq 1$ .

**Example 1.** Let  $F_1(\theta_1) = \theta_1$  for  $\theta_1 \in [0, 1]$  and  $F_2(\theta_2|\theta_1) = \theta_2/\theta_1$  for  $\theta_2 \in [0, \theta_1]$ . We have  $\partial F_2/\partial \theta_1 = -\theta_2/\theta_1^2 \leq 0$ ,

$$\psi_1(\theta_1) = 2\theta_1 - 1 \text{ and } \psi_2(\theta_1, \theta_2) = \frac{\theta_2}{\theta_1}(2\theta_1 - 1).$$

The seller's revenue is

$$\int_0^1 (2\theta_1 - 1)q_1(\theta_1)d\theta_1 + \delta \int_0^1 \int_0^{\theta_1} \frac{\theta_2}{\theta_1}(2\theta_1 - 1)q_2(\theta_1, q_1(\theta_1), \theta_2) \frac{1}{\theta_1} d\theta_2 d\theta_1.$$

(i) When  $0 \leq q_t \leq 1$  for  $t = 1, 2$ : It is straightforward to see that the optimal solution is

$$q_1(\theta_1) = \begin{cases} 1 & \text{if } \theta_1 > \frac{1}{2}; \\ 0 & \text{otherwise} \end{cases}$$

and

$$q_2(\theta_1, q_1(\theta_1), \theta_2) = \begin{cases} 1 & \text{if } \theta_1 > \frac{1}{2} \text{ and } \theta_2 > 0; \\ 0 & \text{otherwise.} \end{cases}$$

It is also straightforward to see that (11) and (12) are satisfied since  $q_1$  is increasing in  $\theta_1$  and  $q_2$  is increasing in  $\theta_1$  and  $\theta_2$ . We may alternatively apply Corollary 2 for incentive compatibility.

(ii) When  $0 \leq q_1 + q_2 \leq 1$ : If  $\theta_1 \leq 1/2$ , then the optimal solution is to have  $q_1 = q_2 = 0$ . If  $\theta_1 > 1/2$ , then the seller compares  $2\theta_1 - 1$  with

$$\delta \int_0^{\theta_1} \frac{\theta_2}{\theta_1}(2\theta_1 - 1) \frac{1}{\theta_1} d\theta_2 = \frac{\delta(2\theta_1 - 1)}{2}.$$

Observe that the former is bigger than the latter. In summary, the optimal solution is

$$q_1(\theta_1) = \begin{cases} 1 & \text{if } \theta_1 > \frac{1}{2}; \\ 0 & \text{otherwise} \end{cases}$$



and  $q_2(\theta_1, q_1(\theta_1), \theta_2) = 0$  for all  $\theta_1$  and  $\theta_2$ . It is straightforward to see that (11) and (12) are satisfied since  $q_1$  is increasing in  $\theta_1$  and  $q_2 = 0$ . We may alternatively apply Corollary 2 for incentive compatibility.

**Example 2.** Let  $F_1(\theta_1) = \theta_1$  for  $\theta_1 \in [0, 1]$  and  $F_2(\theta_2|\theta_1) = \theta_2^{\theta_1}$  for  $\theta_2 \in [0, 1]$ . We have  $\partial F_2/\partial \theta_1 = \theta_2^{\theta_1} \ln \theta_2 \leq 0$ ,

$$\psi_1(\theta_1) = 2\theta_1 - 1 \text{ and } \psi_2(\theta_1, \theta_2) = \theta_2 + \frac{1 - \theta_1}{\theta_1} \theta_2 \ln \theta_2.$$

The seller's revenue is

$$\int_0^1 (2\theta_1 - 1) q_1(\theta_1) d\theta_1 + \delta \int_0^1 \int_0^1 \left( \theta_2 + \frac{1 - \theta_1}{\theta_1} \theta_2 \ln \theta_2 \right) q_2(\theta_1, q_1(\theta_1), \theta_2) \theta_1 \theta_2^{\theta_1 - 1} d\theta_2 d\theta_1.$$

(i) When  $0 \leq q_t \leq 1$  for  $t = 1, 2$ : It is straightforward to see that the optimal solution is

$$q_1(\theta_1) = \begin{cases} 1 & \text{if } \theta_1 > \frac{1}{2}; \\ 0 & \text{otherwise} \end{cases}$$

and

$$q_2(\theta_1, q_1(\theta_1), \theta_2) = \begin{cases} 1 & \text{if } \theta_2 > e^{-\theta_1/(1-\theta_1)}; \\ 0 & \text{otherwise.} \end{cases}$$

Note that  $\theta_2 > e^{-\theta_1/(1-\theta_1)}$  if and only if  $\theta_1 > -\ln \theta_2 / (1 - \ln \theta_2)$ . It is also straightforward to see that (11) and (12) are satisfied since  $q_1$  is increasing in  $\theta_1$  and  $q_2$  is increasing in  $\theta_1$  and  $\theta_2$ . We may alternatively apply Corollary 2 for incentive compatibility.

(ii) When  $0 \leq q_1 + q_2 \leq 1$ : If  $\theta_1 \leq 1/2$  and  $\theta_1 \leq -\ln \theta_2 / (1 - \ln \theta_2)$ , then the optimal solution is to have  $q_1 = q_2 = 0$ . If  $\theta_1 \leq 1/2$  and  $\theta_1 > -\ln \theta_2 / (1 - \ln \theta_2)$ , then the optimal solution is to have  $q_1 = 0$  and  $q_2 = 1$ . If  $\theta_1 > 1/2$ , then the seller compares  $2\theta_1 - 1$  with

$$\delta \int_0^1 \max\left\{ \theta_2 + \frac{1 - \theta_1}{\theta_1} \theta_2 \ln \theta_2, 0 \right\} \theta_1 \theta_2^{\theta_1 - 1} d\theta_2.$$

Since there are only two periods, let us assume  $\delta = 1$  to avoid unnecessary complications. Observe that, in period 2, we have  $q_2 = 1$  if  $\theta_1 > -\ln \theta_2 / (1 - \ln \theta_2)$ , i.e.,  $\theta_2 > e^{-\theta_1/(1-\theta_1)}$ .

Hence,

$$\begin{aligned} & \int_0^1 \max\{\theta_2 + \frac{1-\theta_1}{\theta_1}\theta_2 \ln \theta_2, 0\} \theta_1 \theta_2^{\theta_1-1} d\theta_2 = \int_{e^{-\theta_1/(1-\theta_1)}}^1 (\theta_2 + \frac{1-\theta_1}{\theta_1}\theta_2 \ln \theta_2) \theta_1 \theta_2^{\theta_1-1} d\theta_2 \\ & = \left(1 - \frac{2\theta_1}{1-\theta_1} e^{-\theta_1(1+\theta_1)/(1-\theta_1)}\right) / (1+\theta_1)^2. \end{aligned}$$

We find that  $2\theta_1 - 1$  is greater than the last term if and only if  $\theta_1 > 0.652$ . In summary, the optimal solution is

$$q_1(\theta_1) = \begin{cases} 1 & \text{if } \theta_1 > 0.652; \\ 0 & \text{otherwise} \end{cases}$$

and

$$q_2(\theta_1, q_1(\theta_1), \theta_2) = \begin{cases} 1 & \text{if } \theta_1 \leq 0.652 \text{ and } \theta_2 > e^{-\theta_1/(1-\theta_1)}; \\ 0 & \text{otherwise.} \end{cases}$$

For incentive compatibility, we cannot apply Corollary 2 since  $q_2$  is not increasing in  $\theta_1$ . We have to check inequalities (11) and (12) directly. Since  $q_2$  is increasing in  $\theta_2$  for all  $\theta_1$ , (11) is satisfied. As for (12), we divide cases.

- [1] When  $\hat{\theta}_1 < \theta_1 \leq 0.652$ : The left-hand side (LHS henceforth) of (12) is equal to  $-\int_{\hat{\theta}_1}^{\theta_1} \int_{c(\tilde{\theta}_1)}^1 \tilde{\theta}_2^{\tilde{\theta}_1} \ln \tilde{\theta}_2 d\tilde{\theta}_2 d\tilde{\theta}_1$  where  $c(\tilde{\theta}_1) = e^{-\tilde{\theta}_1/(1-\tilde{\theta}_1)}$  and the right-hand side (RHS henceforth) of (12) is equal to  $-\int_{\hat{\theta}_1}^{\theta_1} \int_d^1 \tilde{\theta}_2^{\tilde{\theta}_1} \ln \tilde{\theta}_2 d\tilde{\theta}_2 d\tilde{\theta}_1$  where  $d = e^{-\hat{\theta}_1/(1-\hat{\theta}_1)}$ . Since

$$LHS - RHS = - \int_{\hat{\theta}_1}^{\theta_1} \int_{c(\tilde{\theta}_1)}^d \tilde{\theta}_2^{\tilde{\theta}_1} \ln \tilde{\theta}_2 d\tilde{\theta}_2 d\tilde{\theta}_1 \geq 0$$

by the fact that  $c(\tilde{\theta}_1) \leq d$  and  $\tilde{\theta}_2^{\tilde{\theta}_1} \ln \tilde{\theta}_2 \leq 0$ , (12) is satisfied.

- [2] When  $\hat{\theta}_1 \leq 0.652 < \theta_1$ : We have  $LHS = \int_{0.652}^{\theta_1} d\tilde{\theta}_1 - \int_{\hat{\theta}_1}^{0.652} \int_{c(\tilde{\theta}_1)}^1 \tilde{\theta}_2^{\tilde{\theta}_1} \ln \tilde{\theta}_2 d\tilde{\theta}_2 d\tilde{\theta}_1$  and  $RHS = - \int_{\hat{\theta}_1}^{\theta_1} \int_d^1 \tilde{\theta}_2^{\tilde{\theta}_1} \ln \tilde{\theta}_2 d\tilde{\theta}_2 d\tilde{\theta}_1$ . Thus,

$$\begin{aligned} LHS - RHS &= \int_{0.652}^{\theta_1} d\tilde{\theta}_1 - \int_{\hat{\theta}_1}^{0.652} \int_{c(\tilde{\theta}_1)}^d \tilde{\theta}_2^{\tilde{\theta}_1} \ln \tilde{\theta}_2 d\tilde{\theta}_2 d\tilde{\theta}_1 \\ &\quad + \int_{0.652}^{\theta_1} \int_d^1 \tilde{\theta}_2^{\tilde{\theta}_1} \ln \tilde{\theta}_2 d\tilde{\theta}_2 d\tilde{\theta}_1. \end{aligned}$$

Note that  $-\int_{\hat{\theta}_1}^{0.652} \int_{c(\tilde{\theta}_1)}^d \tilde{\theta}_2^{\tilde{\theta}_1} \ln \tilde{\theta}_2 d\tilde{\theta}_2 d\tilde{\theta}_1 \geq 0$  by the fact that  $c(\tilde{\theta}_1) \leq d$  and  $\tilde{\theta}_2^{\tilde{\theta}_1} \ln \tilde{\theta}_2 \leq 0$ . Note also that

$$\begin{aligned} & \int_{0.652}^{\theta_1} \left(1 + \int_d^1 \tilde{\theta}_2^{\tilde{\theta}_1} \ln \tilde{\theta}_2 d\tilde{\theta}_2\right) d\tilde{\theta}_1 \geq \int_{0.652}^{\theta_1} \left(1 + \int_0^1 \tilde{\theta}_2^{\tilde{\theta}_1} \ln \tilde{\theta}_2 d\tilde{\theta}_2\right) d\tilde{\theta}_1 \\ & = \int_{0.652}^{\theta_1} \left(1 - \frac{1}{(1+\tilde{\theta}_1)^2}\right) d\tilde{\theta}_1 \geq 0. \end{aligned}$$

Hence,  $LHS - RHS \geq 0$  and (12) is satisfied.

[3] When  $0.652 < \hat{\theta}_1 < \theta_1$ : We have  $q_1 = 1$  and  $q_2 = 0$ , so both LHS and RHS of (12) are equal to  $\theta_1 - \hat{\theta}_1$ . Hence, (12) is satisfied.

**Example 3.** Let  $F_1(\theta_1) = \theta_1$  for  $\theta_1 \in [0, 1]$  and  $F_2(\theta_2|\theta_1) = \theta_2 - 2(\theta_1 - \frac{1}{2})\theta_2(1 - \theta_2)$  for  $\theta_2 \in [0, 1]$ . This is the distribution in Example 6 of Pavan *et al.* (2014). We have  $\partial F_2/\partial \theta_1 = -2\theta_2(1 - \theta_2) \leq 0$ ,

$$\psi_1(\theta_1) = 2\theta_1 - 1 \text{ and } \psi_2(\theta_1, \theta_2) = \frac{\theta_1\theta_2^2}{1 - \theta_1 - \theta_2 + 2\theta_1\theta_2}.$$

The seller's revenue is

$$\int_0^1 (2\theta_1 - 1)q_1(\theta_1)d\theta_1 + \delta \int_0^1 \int_0^1 2\theta_1\theta_2^2q_2(\theta_1, q_1(\theta_1), \theta_2)d\theta_2d\theta_1.$$

(i) When  $0 \leq q_t \leq 1$  for  $t = 1, 2$ : It is straightforward to see that the optimal solution is

$$q_1(\theta_1) = \begin{cases} 1 & \text{if } \theta_1 > \frac{1}{2}; \\ 0 & \text{otherwise} \end{cases}$$

and

$$q_2(\theta_1, q_1(\theta_1), \theta_2) = 1 \text{ for all } \theta_1 > 0 \text{ and } \theta_2 > 0.$$

It is also straightforward to see that (11) and (12) are satisfied since  $q_1$  is increasing in  $\theta_1$  and  $q_2$  is increasing in  $\theta_1$  and  $\theta_2$ . We may alternatively apply Corollary 2 for incentive compatibility.

(ii) When  $0 \leq q_1 + q_2 \leq 1$ : If  $\theta_1 \leq 1/2$ , then the optimal solution is to have  $q_1 = 0$ . If  $\theta_1 > 1/2$ , then the seller compares  $2\theta_1 - 1$  with

$$\delta \int_0^1 2\theta_1\theta_2^2d\theta_2 = \frac{2\delta\theta_1}{3}.$$

If  $\theta_1 > 3/(6 - 2\delta)$ , then we have  $q_1 = 1$  and  $q_2 = 0$ . Otherwise, move to period 2 and see whether  $\theta_2 > 0$ . In summary, the optimal solution is

$$q_1(\theta_1) = \begin{cases} 1 & \text{if } \theta_1 > \frac{3}{6-2\delta}; \\ 0 & \text{otherwise} \end{cases}$$

and

$$q_2(\theta_1, q_1(\theta_1), \theta_2) = \begin{cases} 1 & \text{if } 0 < \theta_1 \leq \frac{3}{6-2\delta} \text{ and } \theta_2 > 0; \\ 0 & \text{otherwise.} \end{cases}$$

For incentive compatibility, we cannot apply Corollary 2 since  $q_2$  is not increasing in  $\theta_1$ . We have to check inequalities (11) and (12) directly. Since  $q_2$  is increasing in  $\theta_2$  for all  $\theta_1$ , (11) is satisfied. As for (12), we divide cases.

[1] When  $\hat{\theta}_1 < \theta_1 \leq 3/(6 - 2\delta)$ : We have  $q_1 = 0$  and  $q_2 = 1$ , so both LHS and RHS of (12) are equal to  $\delta \int_{\hat{\theta}_1}^{\theta_1} \int_0^1 2\tilde{\theta}_2(1 - \tilde{\theta}_2)d\tilde{\theta}_2d\tilde{\theta}_1 = \delta(\theta_1 - \hat{\theta}_1)/3$ . Hence, (12) is satisfied.

[2] When  $\hat{\theta}_1 \leq 3/(6 - 2\delta) < \theta_1$ : We have

$$LHS = \int_{\frac{3}{6-2\delta}}^{\theta_1} d\tilde{\theta}_1 + \delta \int_{\hat{\theta}_1}^{\frac{3}{6-2\delta}} \int_0^1 2\tilde{\theta}_2(1 - \tilde{\theta}_2)d\tilde{\theta}_2d\tilde{\theta}_1 = \theta_1 - \frac{3}{6-2\delta} + \frac{\delta}{3} \left( \frac{3}{6-2\delta} - \hat{\theta}_1 \right)$$

and

$$RHS = \delta \int_{\hat{\theta}_1}^{\theta_1} \int_0^1 2\tilde{\theta}_2(1 - \tilde{\theta}_2)d\tilde{\theta}_2d\tilde{\theta}_1 = \frac{\delta}{3}(\theta_1 - \hat{\theta}_1).$$

Since

$$LHS - RHS = \left(1 - \frac{\delta}{3}\right) \left(\theta_1 - \frac{3}{6-2\delta}\right) > 0,$$

(12) is satisfied.

[3]  $3/(6 - 2\delta) < \hat{\theta}_1 < \theta_1$ : We have  $q_1 = 1$  and  $q_2 = 0$ , so both LHS and RHS of (12) are equal to  $\theta_1 - \hat{\theta}_1$ . Hence, (12) is satisfied.

### 3.3. The general analysis

We resume back to the case with an arbitrary number of periods. We begin with some special cases.

**Example 4.** (Independent private information) Let the private information be independent across periods so that  $\partial F_{t+1}/\partial \theta_t = 0$  for all  $t$ . Then, we have  $\psi_t(\theta_1, \dots, \theta_t) = \theta_t$  for  $t = 2, \dots, T$ . The optimal solution can be found by the procedure given above using  $M'$ . (See the paragraph after Proposition 1 below for a further discussion on the optimal

solution.) In addition,  $D_t(\hat{\theta}_t, \theta_t; \hat{\theta}^{t-1}) = q_t(\hat{h}^t, \hat{\theta}_t)$  and thus the inequality (5) becomes

$$\int_{\hat{\theta}_t}^{\theta_t} q_t(\hat{h}^t, \tilde{\theta}_t) d\tilde{\theta}_t \geq \int_{\hat{\theta}_t}^{\theta_t} q_t(\hat{h}^t, \hat{\theta}_t) d\tilde{\theta}_t.$$

This is satisfied when  $q_t(\hat{h}^t, \theta_t)$  is increasing in  $\theta_t$ . Observe that we have an increasing optimal  $q_t(\hat{h}^t, \theta_t)$  for  $t = 2, \dots, T$  since  $\psi_t(\theta_1, \dots, \theta_t) = \theta_t$ . We also have an increasing optimal  $q_1(\theta_1)$  when  $\psi_1(\theta_1) = \theta_1 - (1 - F_1(\theta_1))/f(\theta_1)$  is increasing in  $\theta_1$ , i.e., when the virtual valuation is *regular* as Myerson (1981) has named it. A sufficient condition for a regular virtual valuation is that the distribution  $F_1$  is IFR, i.e., the hazard rate (or failure rate)  $f_1(\theta_1)/(1 - F_1(\theta_1))$  is increasing.<sup>12</sup>

We note as comparison that, for the repeated sales scenario in which  $0 \leq q_t(h^t, \theta_t) \leq 1$  for all  $t = 1, \dots, T$ , the optimal solution achieves the first-best outcome, that is,  $q_t(\hat{h}^t, \theta_t) = 1$ , except for the first period.<sup>13</sup> As observed by the authors of previous works, the reason is that the seller and the buyer face symmetric information except for period 1 since period- $t$  information for  $t \geq 2$  is independent of period-1 information.

**Example 5.** (First-order autoregressive process) Suppose for  $t \geq 2$  that  $\tilde{\theta}_t = \gamma\theta_{t-1} + (1 - \gamma)\tilde{\epsilon}_t$  where  $\tilde{\epsilon}_t$ 's are independently and identically distributed random variables over  $\Theta = [\underline{\theta}, \bar{\theta}]$  and  $\gamma \in [0, 1)$ . Then, we have

$$\psi_t(\theta_1, \dots, \theta_t) = \theta_t - \gamma^{t-1} \frac{1 - F_1(\theta_1)}{f_1(\theta_1)}$$

for  $t = 1, \dots, T$ . Observe that, when  $\psi_t(\theta_1, \dots, \theta_t) > 0$ , we have

$$\psi_{t+1}(\theta_1, \dots, \theta_{t+1}) = \gamma\theta_t + (1 - \gamma)\epsilon_{t+1} - \gamma^t \frac{1 - F_1(\theta_1)}{f_1(\theta_1)} = \gamma\psi_t(\theta_1, \dots, \theta_t) + (1 - \gamma)\epsilon_{t+1} > 0$$

and thus  $\psi_s(\theta_1, \dots, \theta_s) > 0$  for all  $s = t + 1, \dots, T$  and  $\theta^s = (\theta_1, \dots, \theta_s)$ . The optimal solution can be found by the procedure given above using  $M'$ . (See the paragraph after

Proposition 1 below for a further discussion on the optimal solution.) In addition, when  $F_1$  is IFR, the four conditions of Corollary 2 are satisfied and thus incentive compatibility holds.

We note as comparison that, for the repeated sales scenario in which  $0 \leq q_t(h^t, \theta_t) \leq 1$  for all  $t = 1, \dots, T$ , the optimal solution is such that  $q_t(h^t, \theta_t) = 1$  if and only if  $\theta_t \geq \gamma^{t-1}(1 - F_1(\theta_1))/f_1(\theta_1)$ . Hence,  $q_t(h^t, \theta_t)$  approaches the first-best outcome as  $t$  increases. This property was first observed by Besanko (1985) in a model of multi-period contracts.

Let us next extend some examples of the previous subsection.

**Example 6.** Let  $F_1(\theta_1) = \theta_1$  for  $\theta_1 \in [0, 1]$  and  $F_t(\theta_t|\theta_{t-1}) = \theta_t/\theta_{t-1}$  for  $\theta_t \in [0, \theta_{t-1}]$  and  $t \geq 2$ . We have  $\partial F_t/\partial \theta_{t-1} = -\theta_t/\theta_{t-1}^2 \leq 0$  and

$$\psi_t(\theta_1, \dots, \theta_t) = \frac{\theta_t}{\theta_1}(2\theta_1 - 1).$$

The seller's revenue is

$$\int_0^1 (2\theta_1 - 1)q_1(\theta_1)d\theta_1 + \sum_{t=2}^T \delta^{t-1} \int_0^1 \dots \int_0^{\theta_{t-1}} \frac{\theta_t}{\theta_1}(2\theta_1 - 1)q_t(h^t, \theta_t) \prod_{s=2}^t \frac{1}{\theta_{s-1}} d\theta_t \dots d\theta_1.$$

When  $\theta_1 \leq 1/2$ , the optimal solution is to have  $q_1 = \dots = q_T = 0$ . For the case when  $\theta_1 > 1/2$ , let us assume that  $T$  is finite and use backward induction. In period  $T$ , it is optimal to have  $q_T = 1$  if and only if  $\theta_T > 0$ . In period  $T - 1$ , the seller compares  $\psi_{T-1}(\theta_1, \dots, \theta_{T-1}) = \theta_{T-1}(2\theta_1 - 1)/\theta_1$  with

$$\delta \int_0^{\theta_{T-1}} \frac{\theta_T}{\theta_1}(2\theta_1 - 1) \frac{1}{\theta_{T-1}} d\theta_T = \delta \frac{\theta_{T-1}}{2\theta_1}(2\theta_1 - 1).$$

Hence, it is optimal to have  $q_{T-1} = 1$  if and only if  $\theta_{T-1} > 0$ . Proceeding backwards, the optimal solution is

$$q_1(\theta_1) = \begin{cases} 1 & \text{if } \theta_1 > \frac{1}{2}; \\ 0 & \text{otherwise} \end{cases}$$

and  $q_t(h^t, \theta_t) = 0$  for all  $t \geq 2$ ,  $h^t$  and  $\theta_t$ . It is straightforward to see that (5) is satisfied for all  $t = 1, \dots, T$ . We may alternatively apply Corollary 2 for incentive compatibility.

**Example 7.** Let  $F_1(\theta_1) = \theta_1$  for  $\theta_1 \in [0, 1]$  and  $F_t(\theta_t|\theta_{t-1}) = \theta_t^{\theta_{t-1}}$  for  $\theta_t \in [0, 1]$  and  $t \geq 2$ . We have  $\partial F_t/\partial \theta_{t-1} = \theta_t^{\theta_{t-1}-1} \ln \theta_t \leq 0$  and

$$\psi_t(\theta_1, \dots, \theta_t) = \theta_t + (-1)^t \frac{1 - \theta_1}{\theta_1} \theta_t \ln \theta_2 \cdots \ln \theta_t.$$

The seller's revenue is

$$\begin{aligned} & \int_0^1 (2\theta_1 - 1) q_1(\theta_1) d\theta_1 \\ & + \sum_{t=2}^T \delta^{t-1} \int_0^1 \cdots \int_0^1 \left( \theta_t + (-1)^t \frac{1 - \theta_1}{\theta_1} \theta_t \prod_{s=2}^t \ln \theta_s \right) q_t(h^t, \theta_t) \left( \prod_{s=2}^t \theta_{s-1} \theta_s^{\theta_{s-1}-1} \right) d\theta_t \cdots d\theta_1. \end{aligned}$$

Let us assume that  $T$  is finite and  $\delta = 1$ . In period  $T$ , it is optimal to have  $q_T = 1$  if and only if

$$\theta_T > \exp\left( (-1)^{T-1} \frac{\theta_1}{1 - \theta_1} \prod_{s=2}^{T-1} (\ln \theta_s)^{-1} \right) \stackrel{\text{def}}{=} k_T.$$

Let  $V_T(\theta_1, \dots, \theta_T)$  be the continuation value function from the optimal allocation in period  $T$ . In period  $T - 1$ , the seller compares  $\psi_{T-1}(\theta_1, \dots, \theta_{T-1})$  with

$$\begin{aligned} & \int_0^1 V_T(\theta_1, \dots, \theta_T) f_T(\theta_T|\theta_{T-1}) d\theta_T = \int_0^1 \max\{\psi_T(\theta_1, \dots, \theta_T), 0\} f_T(\theta_T|\theta_{T-1}) d\theta_T \\ & = \int_{k_T}^1 \left( \theta_T + (-1)^T \frac{1 - \theta_1}{\theta_1} \theta_T \prod_{s=2}^T \ln \theta_s \right) \theta_{T-1} \theta_T^{\theta_{T-1}-1} d\theta_T. \end{aligned}$$

We can find  $k_{T-1}$  such that it is optimal to have  $q_{T-1} = 1$  if and only if  $\theta_{T-1} > k_{T-1}$ .

Proceeding backwards, in period  $t$ , the seller compares  $\psi_t(\theta_1, \dots, \theta_t)$  with

$$\int_0^1 V_{t+1}(\theta_1, \dots, \theta_{t+1}) f_{t+1}(\theta_{t+1}|\theta_t) d\theta_{t+1},$$

where  $V_{t+1}(\theta_1, \dots, \theta_{t+1})$  is the continuation value function from the optimal allocation in period  $t + 1$ . In summary, the optimal allocation is, for  $t = 1, \dots, T$ ,

$$q_t(h^t, \theta_t) = \begin{cases} 1 & \text{if } \theta_s \leq k_s \text{ for } s = 1, \dots, t-1 \text{ and } \theta_t > k_t; \\ 0 & \text{otherwise.} \end{cases}$$

Let us take the case when  $T = 3$  as an illustration. We have

$$\psi_3(\theta_1, \theta_2, \theta_3) = \theta_3 - \frac{1 - \theta_1}{\theta_1} \theta_3 \ln \theta_2 \ln \theta_3$$

and it is optimal to have  $q_3 = 1$  if and only if  $\theta_3 > k_3 = \exp(\theta_1 / ((1 - \theta_1) \ln \theta_2))$ . In period 2, the seller compares

$$\psi_2(\theta_1, \theta_2) = \theta_2 + \frac{1 - \theta_1}{\theta_1} \theta_2 \ln \theta_2$$

with

$$\begin{aligned} & \int_{k_3}^1 \left( \theta_3 - \frac{1 - \theta_1}{\theta_1} \theta_3 \ln \theta_2 \ln \theta_3 \right) \theta_2 \theta_3^{\theta_2 - 1} d\theta_3 \\ &= \frac{\theta_2}{\theta_2 + 1} (1 - k_3^{\theta_2 + 1}) - \frac{1 - \theta_1}{\theta_1} \theta_2 \ln \theta_2 \frac{-1 + k_3^{\theta_2 + 1} (1 - (\theta_2 + 1) \ln k_3)}{(\theta_2 + 1)^2}. \end{aligned}$$

We find that there exists  $k_2$  such that it is optimal to have  $q_2 = 1$  if and only if  $\theta_2 > k_2$ .

Let  $V_2(\theta_1, \theta_2)$  be the continuation value function from the optimal allocation in period 2.

In period 1, the seller compares  $\psi_1(\theta_1) = 2\theta_1 - 1$  with

$$\begin{aligned} & \int_0^1 V_2(\theta_1, \theta_2) f_2(\theta_2 | \theta_1) d\theta_2 \\ &= \int_{k_2}^1 \psi_2(\theta_1, \theta_2) f_2(\theta_2 | \theta_1) d\theta_2 + \int_0^{k_2} \int_{k_3}^1 \psi_3(\theta_1, \theta_2, \theta_3) f_3(\theta_3 | \theta_2) f_2(\theta_2 | \theta_1) d\theta_3 d\theta_2. \end{aligned}$$

We were not able to algebraically find the explicit solution for  $k_1$  and  $k_2$  nor to check incentive compatibility.

As the previous example demonstrates, it may sometimes be a difficult task to find an optimal allocation as well as to check incentive compatibility. Even when  $\psi_s(\theta_1, \dots, \theta_s) > 0$  for all  $s = t + 1, \dots, T$  and  $\theta^s = (\theta_1, \dots, \theta_s)$  so that  $M'$  of the procedure for finding the optimal solution can be used, the seller has to compare  $\psi_t(\theta_1, \dots, \theta_t)$  with

$$\begin{aligned} & \delta^{s-t} \int_{\underline{\theta}}^{\bar{\theta}} \dots \int_{\underline{\theta}}^{\bar{\theta}} \psi_s(\theta_1, \dots, \theta_t, \tilde{\theta}_{t+1}, \dots, \tilde{\theta}_s) \\ & \times f_s(\tilde{\theta}_s | \tilde{\theta}_{s-1}, q_{s-1}(h_+^{s-1}(\hat{h}^t, \theta_t))) \dots f_{t+1}(\tilde{\theta}_{t+1} | \theta_t, q_t(\hat{h}^t, \theta_t)) d\tilde{\theta}_s \dots d\tilde{\theta}_{t+1} \end{aligned}$$

for all  $s = t + 1, \dots, T$ . This may be cumbersome. In contrast, it is in general not optimal

to use the *myopic* stopping rule in which the seller compares  $\psi_t(\theta_1, \dots, \theta_t)$  only with

$$\delta \int_{\underline{\theta}}^{\bar{\theta}} \psi_{t+1}(\theta_1, \dots, \theta_t, \tilde{\theta}_{t+1}) f_{t+1}(\tilde{\theta}_{t+1} | \theta_t, q_t(\hat{h}^t, \theta_t)) d\tilde{\theta}_{t+1},$$

i.e., the discounted expected value of  $\psi_{t+1}(\theta_1, \dots, \theta_{t+1})$ . However, it is straightforward to present a necessary and sufficient condition for the myopic stopping rule to be optimal.



**Proposition 1.** Suppose  $\psi_s(\theta_1, \dots, \theta_s) > 0$  for all  $s = t + 1, \dots, T$  and  $\theta^s = (\theta_1, \dots, \theta_s)$  at  $\theta^t$ . The myopic stopping rule is optimal if and only if

$$\begin{aligned} & \int_{\underline{\theta}}^{\bar{\theta}} \psi_{s+1}(\theta_1, \dots, \theta_s, \tilde{\theta}_{s+1}) f_{s+1}(\tilde{\theta}_{s+1} | \theta_s, q_s(\hat{h}^s, \theta_s)) d\tilde{\theta}_{s+1} \\ & > \delta \int_{\underline{\theta}}^{\bar{\theta}} \int_{\underline{\theta}}^{\bar{\theta}} \psi_{s+2}(\theta_1, \dots, \theta_s, \tilde{\theta}_{s+1}, \tilde{\theta}_{s+2}) f_{s+2}(\tilde{\theta}_{s+2} | \tilde{\theta}_{s+1}, q_{s+1}(\hat{h}^s, \theta_s, q_s(\hat{h}^s, \theta_s), \tilde{\theta}_{s+1})) \\ & \quad \times f_{s+1}(\tilde{\theta}_{s+1} | \theta_s, q_s(\hat{h}^s, \theta_s)) d\tilde{\theta}_{s+2} d\tilde{\theta}_{s+1} \end{aligned}$$

holds for all  $s = t, \dots, T - 1$  and  $\theta^s = (\theta_1, \dots, \theta_s)$ .

Proof: Note that LHS is the expected value of  $\psi_{s+1}(\theta_1, \dots, \theta_{s+1})$  and RHS is the discounted expected value of  $\psi_{s+2}(\theta_1, \dots, \theta_{s+2})$ . If LHS is greater than RHS for all  $s = t, \dots, T - 1$ , then we have a decreasing sequence of values and thus the maximum  $M'$  defined in the procedure for finding the optimal solution is obtained at  $s = t + 1$ . Hence, the myopic rule is optimal. It is easy to see that the converse also holds. *Q.E.D.*

Observe that, for Example 4 above, the myopic stopping rule is optimal if and only if  $\mu_{t+1} > \delta \mu_{t+2}$  where  $\mu_t$  is the expected value of  $\tilde{\theta}_t$ , i.e.,  $\mu_t = \int_{\underline{\theta}}^{\bar{\theta}} \tilde{\theta}_t f_t(\tilde{\theta}_t) d\tilde{\theta}_t$ . In particular, the myopic rule is optimal when  $\mu_t = \mu$  for all  $t = 2, \dots, T$  and  $\delta < 1$ . Hence, it is optimal to sell in the first period  $t$  with  $\theta_t > \delta \mu_{t+1}$ . Observe next that, for Example 5 above, the myopic stopping rule is optimal if and only if

$$\gamma \psi_t + (1 - \gamma) \mu_\epsilon > \delta \left( \gamma^2 \psi_t + (1 - \gamma^2) \mu_\epsilon \right)$$

where  $\mu_\epsilon$  is the expected value of  $\tilde{\epsilon}_t$  for all  $t$ . This inequality holds when  $\gamma = 0$  and  $\delta < 1$ .

For  $\gamma \in (0, 1)$ , the inequality is equivalent to

$$\psi_t > \frac{(\delta(1 - \gamma^2) - (1 - \gamma)) \mu_\epsilon}{\gamma(1 - \delta\gamma)}.$$

When  $\delta = 1$ , the myopic stopping rule is optimal if and only if  $\theta_t > \gamma^{t-1} (1 - F_1(\theta_1)) / f_1(\theta_1) + \mu_\epsilon$ . It is also easy to observe that the myopic stopping rule is optimal for Example 6.

In an optimal allocation, we have  $q_t = 1$  for at most one  $t \in \{1, \dots, T\}$  and  $q_s = 0$  for all other  $s$ 's. If  $q_t = 1$ , then the seller's revenue (or the price of the object) in period  $t$  is  $\psi_t(\theta_1, \dots, \theta_t)$ . Observe also that the seller's revenue is zero whenever  $q_s = 0$  for  $s \in \{1, \dots, T\}$ . The buyer's ex-post payoff in period  $t$  with  $q_t = 1$  is thus

$$\begin{aligned} & \theta_t - \psi_t(\theta_1, \dots, \theta_t) \\ &= \frac{1 - F_1(\theta_1)}{f_1(\theta_1)} \left( -\frac{\partial F_2(\theta_2|\theta_1, q_1(\theta_1))/\partial\theta_1}{f_2(\theta_2|\theta_1, q_1(\theta_1))} \right) \dots \left( -\frac{\partial F_t(\theta_t|\theta_{t-1}, q_{t-1}(h^{t-1}, \theta_{t-1}))/\partial\theta_{t-1}}{f_t(\theta_t|\theta_{t-1}, q_{t-1}(h^{t-1}, \theta_{t-1}))} \right), \end{aligned}$$

and that in period  $t$  with  $q_t = 0$  is zero. Hence, we have:

**Proposition 2.** *Ex-post individual rationality holds in an optimal allocation under the first-order stochastic dominance condition of*

$$\partial F_{t+1}(\theta_{t+1}|\theta_t, a_t)/\partial\theta_t \leq 0 \text{ for all } t, \theta_t, a_t \text{ and } \theta_{t+1}.$$

Proof: Obvious since the buyer's ex-post payoff is equal to  $\theta_t - \psi_t(\theta_1, \dots, \theta_t) \geq 0$  when  $q_t = 1$ , and zero when  $q_t = 0$ . Q.E.D.

### 3.4. Comparative statics

Let us perform some comparative static analysis regarding the seller's revenue and the selling time. Observe first that the seller's revenue

$$\psi_t(\theta_1, \dots, \theta_t) = \theta_t - \frac{1 - F_1(\theta_1)}{f_1(\theta_1)} \prod_{s=2}^t \left( -\frac{\partial F_s(\theta_s|\theta_{s-1}, q_{s-1}(h^{s-1}, \theta_{s-1}))/\partial\theta_{s-1}}{f_s(\theta_s|\theta_{s-1}, q_{s-1}(h^{s-1}, \theta_{s-1}))} \right)$$

in period  $t$  increases as (i)  $f_1(\theta_1)/(1 - F_1(\theta_1))$  increases and (ii)  $-\frac{\partial F_s/\partial\theta_{s-1}}{f_s}$  decreases.<sup>14</sup> Hence, the revenue in period  $t$  increases as the private information becomes less persistent in the sense of (ii). This is due to the fact that the information rent becomes smaller. In particular, the revenue is highest when the private information is independent across periods (i.e.,  $\partial F_{t+1}/\partial\theta_t = 0$  for all  $t$ ) and thus there exists no private information except for period 1.

Observe however that this does not necessarily imply that the seller's total expected revenue increases as (i) or (ii) holds, since the (conditional) density function also changes. Note that the total expected revenue of (10) can be written as

$$\begin{aligned} & \int_{\underline{\theta}}^{\bar{\theta}} [\tilde{\theta}_1 f_1(\tilde{\theta}_1) - (1 - F_1(\tilde{\theta}_1))] q_1(\tilde{\theta}_1) d\tilde{\theta}_1 \\ & + \sum_{t=2}^T \delta^{t-1} \int_{\underline{\theta}}^{\bar{\theta}} \cdots \int_{\underline{\theta}}^{\bar{\theta}} \left[ \tilde{\theta}_t f_1(\tilde{\theta}_1) \prod_{s=2}^t f_s(\tilde{\theta}_s | \tilde{\theta}_{s-1}, q_{s-1}(\tilde{h}^{s-1}, \tilde{\theta}_{s-1})) \right. \\ & \left. - (1 - F_1(\tilde{\theta}_1)) \prod_{s=2}^t (-\partial F_s(\tilde{\theta}_s | \tilde{\theta}_{s-1}, q_{s-1}(\tilde{h}^{s-1}, \tilde{\theta}_{s-1})) / \partial \theta_{s-1}) \right] q_t(\tilde{h}^t, \tilde{\theta}_t) d\tilde{\theta}_t \cdots d\tilde{\theta}_1 \end{aligned}$$

with  $U_1(\underline{\theta}) = 0$ . We thus have:

**Proposition 3.** *The seller's (total expected) revenue increases as*

- (i)  $\int_{\underline{\theta}}^{\bar{\theta}} [\tilde{\theta}_1 f_1(\tilde{\theta}_1) - (1 - F_1(\tilde{\theta}_1))] d\tilde{\theta}_1$  increases;
- (ii) for all  $t = 2, \dots, T$ :

$$\begin{aligned} & \int_{\underline{\theta}}^{\bar{\theta}} \cdots \int_{\underline{\theta}}^{\bar{\theta}} \left[ \tilde{\theta}_t f_1(\tilde{\theta}_1) \prod_{s=2}^t f_s(\tilde{\theta}_s | \tilde{\theta}_{s-1}, q_{s-1}(\tilde{h}^{s-1}, \tilde{\theta}_{s-1})) \right. \\ & \left. - (1 - F_1(\tilde{\theta}_1)) \prod_{s=2}^t (-\partial F_s(\tilde{\theta}_s | \tilde{\theta}_{s-1}, q_{s-1}(\tilde{h}^{s-1}, \tilde{\theta}_{s-1})) / \partial \theta_{s-1}) \right] d\tilde{\theta}_t \cdots d\tilde{\theta}_1 \end{aligned}$$

*increases; and*

- (iii)  $\delta$  increases.

Proof: Obvious.

*Q.E.D.*

As for the selling time, we have:

**Proposition 4.** *Assume  $\partial F_{t+1}(\theta_{t+1} | \theta_t, a_t) / \partial \theta_t \leq 0$  for all  $t, \theta_t, a_t$  and  $\theta_{t+1}$ . Assume also that the myopic stopping rule is optimal. The probability that the seller sells the object earlier, that is, sells in period  $t$  rather than period  $t + 1$ , increases as*

- (i)  $\theta_t$  increases and/or  $E[\theta_{t+1} | \theta_t, q_t(h^t, \theta_t)]$  decreases;
- (ii)  $\int_{\underline{\theta}}^{\bar{\theta}} (-\partial F_{t+1}(\tilde{\theta}_{t+1} | \theta_t, q_t(h^t, \theta_t)) / \partial \theta_t) d\tilde{\theta}_{t+1}$  increases;

(iii)  $f_1(\theta_1)/(1 - F_1(\theta_1))$  increases (decreases, resp.) when

$$1 + \delta \int_{\underline{\theta}}^{\bar{\theta}} \partial F_{t+1}(\tilde{\theta}_{t+1}|\theta_t, q_t(h^t, \theta_t))/\partial \theta_t d\tilde{\theta}_{t+1} > (<, \text{resp.}) 0;$$

(iv) for all  $s = 2, \dots, t$ :

$$-\frac{\partial F_s(\theta_s|\theta_{s-1}, q_{s-1}(h^{s-1}, \theta_{s-1}))/\partial \theta_{s-1}}{f_s(\theta_s|\theta_{s-1}, q_{s-1}(h^{s-1}, \theta_{s-1}))}$$

decreases (increases, resp.) when

$$1 + \delta \int_{\underline{\theta}}^{\bar{\theta}} \partial F_{t+1}(\tilde{\theta}_{t+1}|\theta_t, q_t(h^t, \theta_t))/\partial \theta_t d\tilde{\theta}_{t+1} > (<, \text{resp.}) 0; \text{ and}$$

(v)  $\delta$  decreases.

Proof: In period  $t$ , the seller compares

$$\theta_t - \frac{1 - F_1(\theta_1)}{f_1(\theta_1)} \prod_{s=2}^t \left( -\frac{\partial F_s(\theta_s|\theta_{s-1}, q_{s-1}(h^{s-1}, \theta_{s-1}))/\partial \theta_{s-1}}{f_s(\theta_s|\theta_{s-1}, q_{s-1}(h^{s-1}, \theta_{s-1}))} \right)$$

with

$$\delta \int_{\underline{\theta}}^{\bar{\theta}} \left[ \tilde{\theta}_{t+1} - \frac{1 - F_1(\theta_1)}{f_1(\theta_1)} \prod_{s=2}^{t+1} \left( -\frac{\partial F_s(\theta_s|\theta_{s-1}, q_{s-1}(h^{s-1}, \theta_{s-1}))/\partial \theta_{s-1}}{f_s(\theta_s|\theta_{s-1}, q_{s-1}(h^{s-1}, \theta_{s-1}))} \right) \right] \\ \times f_{t+1}(\tilde{\theta}_{t+1}|\theta_t, q_t(h^t, \theta_t)) d\tilde{\theta}_{t+1}.$$

If the first term is non-positive, then the seller does not sell in period  $t$  and moves to period  $t + 1$ . So, assume that the first term is positive. If the second term is non-positive, then the seller sells in period  $t$ . So, assume that the second term is positive. It is obvious that the probability that the seller sells the object earlier increases as  $\delta$  decreases. Next, subtracting the second term from the first term, we get the inequality

$$\theta_t - \delta E[\theta_{t+1}|\theta_t, q_t(h^t, \theta_t)] > \frac{1 - F_1(\theta_1)}{f_1(\theta_1)} \prod_{s=2}^t \left( -\frac{\partial F_s/\partial \theta_{s-1}}{f_s} \right) \left( 1 - \delta \int_{\underline{\theta}}^{\bar{\theta}} -\frac{\partial F_{t+1}}{\partial \theta_t} d\tilde{\theta}_{t+1} \right),$$

from which the results follow straightforwardly. Q.E.D.

We note that the inequality  $\delta \int_{\underline{\theta}}^{\bar{\theta}} -\partial F_{t+1}(\tilde{\theta}_{t+1}|\theta_t, q_t(h^t, \theta_t))/\partial \theta_t d\tilde{\theta}_{t+1} < 1$ , or equivalently,  $1 + \delta \int_{\underline{\theta}}^{\bar{\theta}} \partial F_{t+1}(\tilde{\theta}_{t+1}|\theta_t, q_t(h^t, \theta_t))/\partial \theta_t d\tilde{\theta}_{t+1} > 0$  holds for all the examples above.

## 4 Discussion

We have studied the problem of when to sell an indivisible object to the set of Markovian buyers. We have formulated the seller's problem as a dynamic mechanism design problem. We have provided the procedure for finding the optimal solution and shown how to check incentive compatibility. We have also examined sufficient conditions for the optimality of myopic stopping rule and ex-post individual rationality. In addition, we have presented some comparative static results regarding the seller's revenue and the selling time.

It is straightforward to extend the analysis to the case of many buyers. Let  $I = \{1, \dots, n\}$  be the set of buyers and let  $\theta_{i,t} \in \Theta_i = [\underline{\theta}_i, \bar{\theta}_i]$  be player  $i$ 's type in period  $t$ . As usual, let  $\theta_t = (\theta_{1,t}, \dots, \theta_{n,t})$  denote the type profile in period  $t$  and let  $\theta^t = (\theta_1, \dots, \theta_t)$  and  $a^t = (a_1, \dots, a_t)$ . Let  $F_{i,t}$  be the distribution of  $\theta_{i,t}$  and assume that the transition kernel is independent across buyers so that

$$F_t(\theta_t | \theta_{t-1}, a_{t-1}) = \prod_{i \in I} F_{i,t}(\theta_{i,t} | \theta_{i,t-1}, a_{t-1}).$$

Then, essentially the same results obtain by defining  $\psi_{i,t}(\theta_1, \dots, \theta_t)$  similar to (9) and utilizing

$$\psi_t(\theta_1, \dots, \theta_t) = \max_{i \in I} \psi_{i,t}(\theta_1, \dots, \theta_t).$$

Observe next that it is almost trivial to incorporate the seller's cost of producing the object: Just introduce  $c_t$  as the cost in period  $t$  and subtract it from the revenue.

We have analyzed the optimal selling time of an indivisible object under the Markovian assumption. It is an interesting research agenda to extend the analysis to (i) many heterogeneous objects, and/or (ii) non-Markovian environments.
