A General Family of *q*-Hypergeometric Polynomials and Associated Generating Functions

Abstract

In this paper, we introduce a general family of q-hypergeometric polynomials and investigate several q-series identities such as an extended generating function and a Srivastava-Agarwal type bilinear generating function for this family of q-hypergeometric polynomials. We give a transformational identity involving generating functions for the generalized q-hypergeometric polynomials which we have introduced here. We also point out relevant connections of the various q-results, which we investigate here, with those in several related earlier works on this subject. We conclude this paper by remarking that it will be a rather trivial and inconsequential exercise to give the so-called (p,q)-variations of the q-results, which we have investigated here, because the additional parameter p is obviously redundant.

1. Introduction, Definitions and Preliminaries

In this paper, we adopt the commonly-used conventions and notations for the basic (or q-) series and the basic (or q-) polynomials. For the convenience of the reader, we first provide a summary of the mathematical notations, basic properties and definitions to be used in this paper. We refer to the general references (see, for example, [15], [18] and [24]) for the definitions and notations.

Throughout this paper, we assume that |q| < 1. For complex numbers *a*, the *q*-shifted factorials are defined by

We will frequently use the following *q*-identity [1]:

Here, in this paper, we are mainly concerned with the Cauchy polynomials defined by (see [9]):

$$P_n(x,y) := (x-y)(x-qy)\cdots(x-q^{n-1}y) = (y/x;q)_n x^n$$

together with their Srivastava-Agarwal type generating function as given below:

For $\lambda = 0$, we get the following generating function (see [9]):

$$\sum_{n=0}^{\infty} P_n(x,y) \frac{t^n}{(q;q)_n} = \frac{(yt;q)_{\infty}}{(xt;q)_{\infty}}.$$

The generating function (1.5) is also the homogeneous version of the Cauchy identity or the *q*-binomial theorem is given by (see [11])

Putting a = 0, the relation (1.6) becomes Euler's identity (see [11]):

and its inverse relation given below (see [11]):

Saad and Sukhi [16] introduced the dual homogeneous *q*-difference operator Θ_{xy} as follows (see also [10, 20, 3]):

which, when it acts upon functions of suitably-restricted variables x and y, yields

The Hahn polynomials (see [12], [13] and [14]) or, equivalently, the Al-Salam-Carlitz q-polynomials (see [2]) are defined as follows:

$$\phi_n^{(a)}(x|q) = \sum_{k=0}^n \begin{bmatrix} n \\ k \end{bmatrix}_q (a;q)_k \, x^k \quad \text{and} \quad \psi_n^{(a)}(x|q) = \sum_{k=0}^n \begin{bmatrix} n \\ k \end{bmatrix}_q q^{k(k-n)} (aq^{1-k};q)_k \, x^k. \tag{1.11}$$

These polynomials are usually called the "*Al-Salam-Carlitz polynomials*" in several recent publications. Moreover, because of their considerable role in the theories of *q*-series and *q*-orthogonal polynomials, many authors investigated various extensions of the Al-Salam-Carlitz polynomials (see, for example, [6], [8] and [22]).

Recently, Cao [6, Eq. (4.7)] introduced the following two families of generalized Al-Salam-Carlitz polynomials:

together with their generating functions given by (see [6, Eqs.(4.10) and (4.11)])

$$\sum_{n=0}^{\infty} \psi_n^{(a,b,c)}(x,y|q) \frac{(-1)^n q^{\binom{n}{2}} t^n}{(q;q)_n} = (xt;q)_{\infty 2} \Phi_1 \begin{bmatrix} a,b;\\ q;yt\\ c; \end{bmatrix} \qquad (|xt|<1).$$

Remark 1. For (b, c, y) = (0, 0, 1) and For (a, b, c, y) = (1/a, 0, 0, 1), (1.12) and (1.13) reduce to $\phi_n^{(a)}(x)$ and $\psi_n^{(a)}(x)$ defined in (1.11).

Motivated by the above-cited work [6], Cao *et al.* [8] introduced the extensions $\phi_n^{\binom{a,b,c}{d,e}}(x,y|q)$ and $\psi_n^{\binom{a,b,c}{d,e}}(x,y|q)$ of the Al-Salam-Carlitz polynomials, which are defined by

$$\phi_n^{\binom{a,b,c}{d,e}}(x,y|q) = \sum_{k=0}^n \begin{bmatrix} n\\k \end{bmatrix}_q \frac{(a,b,c;q)_k}{(d,e;q)_k} x^{n-k} y^k$$

and

$$\psi_n^{(a,b,c)}(x,y|q) = \sum_{k=0}^n \begin{bmatrix} n\\ k \end{bmatrix}_q \frac{(-1)^k q^{k(k-n)}(a,b,c;q)_k}{(d,e;q)_k} \, x^{n-k} \, y^k, \tag{1.17}$$

respectively. More recently, Srivastava and Arjika [22] introduced two families $\phi_n^{(\mathbf{a},\mathbf{b})}(x,y|q)$ and $\psi_n^{(\mathbf{a},\mathbf{b})}(x,y|q)$ of the generalized Al-Salam-Carlitz *q*-polynomials, which are defined by

$$\phi_n^{(\mathbf{a},\mathbf{b})}(x,y|q) = \sum_{k=0}^n \begin{bmatrix} n\\k \end{bmatrix}_q \frac{(a_1,a_2,\cdots,a_{r+1};q)_k}{(b_1,b_2,\cdots,b_r;q)_k} x^k y^{n-k}$$
(1.18)

and

$$\psi_n^{(\mathbf{a},\mathbf{b})}(x,y|q) = \sum_{k=0}^n \begin{bmatrix} n\\k \end{bmatrix}_q \frac{(a_1,a_2,\cdots,a_{r+1};q)_k}{(b_1,b_2,\cdots,b_r;q)_k} q^{\binom{k+1}{2}-nk} x^k y^{n-k},$$

respectively, where

$$\mathbf{a} := (a_1, a_2, \cdots, a_{r+1})$$
 and $\mathbf{b} = (b_1, b_2, \cdots, b_r).$

On the other hand, Cao [6] introduced and studied the following family of q-polynomials:

$$V_n^{(\mathbf{a},\mathbf{c})}(x,y,z|q) = \sum_{k=0}^n \begin{bmatrix} n \\ k \end{bmatrix}_q \frac{(a_1,a_2,\cdots,a_r;q)_k}{(c_1,c_2,\cdots,c_u;q)_k} P_{n-k}(x,y)z^k,$$

where

$$\mathbf{a} := (a_1, a_2, \cdots, a_r)$$
 and $\mathbf{c} = (c_1, c_2, \cdots, c_s),$

together with their generating function given by

$$\sum_{n=0}^{\infty} V_n^{(\mathbf{a},\mathbf{c})}(x,y,z|q) \ \frac{t^n}{(q;q)_n} = \frac{(yt;q)_{\infty}}{(xt;q)_{\infty}} \ r \Phi_u \begin{bmatrix} a_1,a_2,\cdots,a_r; \\ q;zt \\ c_1,c_2,\cdots,c_u; \end{bmatrix}.$$

Our present investigation is motivated essentially by the earlier works by Srivastava and Arjika [22] and Cao [6]. Our aim here is to introduce and study some further extensions of the above-mentioned q-polynomials.

Definition 1. In terms of *q*-binomial coefficient, a family of generalized *q*-hypergeometric polynomials $\Psi_n^{(\mathbf{a},\mathbf{b})}(x,y,z|q)$ are defined by

$$\Psi_{n}^{(\mathbf{a},\mathbf{b})}(x,y,z|q) := (-1)^{n} q^{-\binom{n}{2}} \sum_{k=0}^{n} {\binom{n}{k}}_{q} \left[(-1)^{k} q^{\binom{k}{2}} \right]^{1+s-r} W_{k}(\mathbf{a},\mathbf{b}) P_{n-k}(y,x) z^{k},$$
(1.22)

where, for convenience,

$$\mathbf{a} = (a_1, a_2, \cdots, a_r), \quad \mathbf{b} = (b_1, b_2, \cdots, b_s) \text{ and } W_k(\mathbf{a}, \mathbf{b}) := \frac{(a_1, a_2, \cdots, a_r; q)_k}{(b_1, b_2, \cdots, b_s; q)_k}.$$

The above-defined q-polynomials $\Psi_n^{(\mathbf{a},\mathbf{b})}(x,y,z|q)$ include many one-variable q-hypergeometric $r\Phi_s$ series as special or limit cases. Therefore, we choose just to call them generalized q-hypergeometric polynomials.

Remark 2. The generalized *q*-hypergeometric polynomials $\Psi_n^{(\mathbf{a},\mathbf{b})}(x,y,z|q)$ defined in (1.22) are generalized and unified form of the Hahn polynomials and the Al-Salam-Carlitz polynomials.

(1) Upon setting (r, x, y) = (u + 1, y, x) and $\mathbf{b} = \mathbf{c}$, the generalized *q*-hypergeometric polynomials (1.22) would reduce to the generalized Al-Salam-Carlitz *q*-polynomials $V_n^{(\mathbf{a}, \mathbf{c})}(x, y|q)$ in (1.20) (see [7]):

$$\Psi_n^{(\mathbf{a},\mathbf{c})}(y,x,z|q) = (-1)^n q^{-\binom{n}{2}} V_n^{(\mathbf{a},\mathbf{c})}(x,y,z|q).$$

(2) By choosing r = s + 1, x = 0 and z = x, the generalized *q*-hypergeometric polynomials (1.22) reduce to the generalized Al-Salam-Carlitz *q*-polynomials $\phi_n^{(\mathbf{a},\mathbf{b})}(x,y|q)$ (see [22]):

$$\Psi_n^{(\mathbf{a},\mathbf{b})}(0,y,x|q) = (-1)^n q^{-\binom{n}{2}} \phi_n^{(\mathbf{a},\mathbf{b})}(x,y|q).$$

(3) Upon setting r = s + 1, y = 0, z = -x and x = y, the *q*-hypergeometric polynomials (1.22) reduce to the generalized Al-Salam-Carlitz *q*-polynomials $\psi_n^{(\mathbf{a},\mathbf{b})}(x,y|q)$ (see [22]):

$$\Psi_n^{(\mathbf{a},\mathbf{b})}(0,y,-x|q) = \psi_n^{(\mathbf{a},\mathbf{b})}(x,y|q).$$

(4) For r = 3, s = 2, $\mathbf{a} = (a, 0, 0)$, $\mathbf{b} = (0, 0)$ and z = b, the *q*-hypergeometric polynomials (1.22) reduce to the generalized Hahn polynomials $h_n(x, y, a, b|q)$ (see [23]):

$$\Psi_n^{(\mathbf{a},\mathbf{c})}(y,x,z|q) = (-1)^n q^{-\binom{n}{2}} h_n(x,y,a,b|q).$$

(5) For r = s and $\mathbf{a} = \mathbf{b} = \mathbf{0}$, the *q*-hypergeometric polynomials $\Psi_n^{(\mathbf{a},\mathbf{b})}(x,y,z|q)$ are the well known trivariate *q*-polynomials $F_n(x,y,z;q)$ (see [1]):

$$\Psi_n^{(\mathbf{0},\mathbf{0})}(x,y,z|q) = F_n(x,y,z;q) := (-1)^n q^{-\binom{n}{2}} \sum_{k=0}^n \begin{bmatrix} n\\k \end{bmatrix}_q (-1)^k q^{\binom{k}{2}} z^k P_{n-k}(y,x).$$

(6) For r = 3, s = 2, $\mathbf{a} = (a, b, c)$, $\mathbf{b} = (d, e)$ and (x, y, z) = (0, x, y), the generalized *q*-hypergeometric polynomials $\Psi_n^{(\mathbf{a}, \mathbf{b})}(y, x, z|q)$ reduce to $\phi_n^{\left(\frac{a, b, c}{d, e}\right)}(x, y, z|q)$ (see [8]):

$$\Psi_n^{(\mathbf{a},\mathbf{b})}(y,x,z|q) = (-1)^n q^{-\binom{n}{2}} \phi_n^{\binom{a,b,c}{d,e}}(x,y,z|q).$$

(7) For r = s = 2, $\mathbf{a} = (a, b, c)$, $\mathbf{b} = (d, e)$ and (x, y, z) = (0, x, y), the *q*-hypergeometric polynomials (1.22) reduce to the polynomials $\psi_n^{\binom{a,b,c}{d,e}}(x, y, z|q)$ (see [8]):

$$\Psi_n^{(\mathbf{a},\mathbf{b})}(y,x,z|q) = (-1)^n q^{-\binom{n}{2}} \Psi_n^{\binom{(a,b,c)}{d,e}}(x,y,z|q).$$
(1.29)

(8) If we let r = 2, s = 1, $\mathbf{a} = (a, 0)$, $\mathbf{b} = (0)$, x = 0 and z = x, the polynomials $\Psi_n^{(\mathbf{a}, \mathbf{b})}(x, y, z|q)$ reduce to the second Hahn polynomials $\phi_n^{(a)}(x, y|q)$ (see [5]):

$$\Psi_n^{(0,0)}(x,ax,y|q) = (-1)^n q^{-\binom{n}{2}} \phi_n^{(a)}(x,y|q).$$

(9) If we let r = 2, s = 1, $(\mathbf{a}, \mathbf{b}) = (\mathbf{0}, \mathbf{0})$, y = ax and z = y, the polynomials $\Psi_n^{(\mathbf{a}, \mathbf{b})}(x, y, z|q)$ reduce to the second Hahn polynomials $\Psi_n^{(a)}(x, y|q)$ (see [5]):

$$\Psi_n^{(0,0)}(x,ax,y|q) = \Psi_n^{(a)}(x,y|q).$$

(10) For r = 2, s = 1, $(\mathbf{a}, \mathbf{b}) = (\mathbf{0}, \mathbf{0})$, x = y = 0 and z = x, the polynomials $\Psi_n^{(\mathbf{a}, \mathbf{b})}(x, y, z|q)$ reduce to the generalized Hahn polynomials $\phi_n^{(a)}(x|q)$ (see [12], [13] and [14]) or, equivalently, the Al-Salam-Carlitz *q*-polynomials (see [2]):

$$\Psi_n^{(0,0)}(0,0,x|q) = (-1)^n q^{-\binom{n}{2}} \phi_n^{(a)}(x|q).$$

(11) Upon putting r = s, $(\mathbf{a}, \mathbf{b}) = (\mathbf{0}, \mathbf{0})$, y = ax and z = 1, the generalized *q*-hypergeometric polynomials $\Psi_n^{(\mathbf{a},\mathbf{b})}(x,y,z|q)$ reduce to the Hahn polynomials $\psi_n^{(a)}(x|q)$ (see [12], [13] and [14]) or, equivalently, the Al-Salam-Carlitz *q*-polynomials (see [2]):

This paper is organized as follows. In Section 2, we introduce the following homogeneous *q*-difference operator:

$${}_{r}\Phi_{s}\left[\begin{array}{c}a_{1},a_{2},\cdots,a_{r};\\q;-z\Theta_{xy}\\b_{1},b_{2},\cdots,b_{s};\end{array}\right]$$

and apply it to investigate several q-series properties. In addition, we derive several extended generating functions for the generalized q-hypergeometric polynomials. In Section 3, we first state and prove the Rogers type formulas. The Srivastava-Agarwal type bilinear generating functions involving the generalized q-hypergeometric polynomials are derived in Section 4. In Section 5, we give a transformational identity involving generating functions for generalized q-hypergeometric polynomials. Finally, in our concluding Section 6, we present several remarks and observations. We also reiterate the welldocumented fact that it will be a rather trivial exercise to give the so-called (p,q)-variation of the qresults, which we have investigated here, because the additional parameter p is obviously redundant.

2. Generalized q-Hypergeometric Polynomials

In this section, we begin by introducing a homogeneous *q*-difference hypergeometric operator as follows.

Definition 2. The homogeneous q-difference hypergeometric operator is defined by

We now derive the q-series identities (2.2), (2.3) and (2.4) below, which will be used later in order to derive the extended generating functions, the Rogers type formulas and the Srivastava-Agarwal type bilinear generating functions involving the generalized q-hypergeometric polynomials.

Lemma 1. Each of the following operational formulas holds true for the homogeneous q-difference operator defined by (2.1):

$$=t^{-k}\frac{(xt;q)_{\infty}}{(yt;q)_{\infty}}\sum_{j=0}^{k}\frac{(q^{-k},yt;q)_{j}q^{j}}{(xt,q;q)_{j}}\,{}_{r}\Phi_{s}\left[\begin{array}{c}a_{1},a_{2},\cdots,a_{r};\\b_{1},b_{2},\cdots,b_{s};\end{array}\right]\qquad(|yt|<1).$$

Proof. Firstly, by applying (2.1) and (1.10), we get (2.2). Secondly, in light of (1.10), we get the desired identity (2.3). Thirdly, by making use of the *q*-Chu-Vandermonde formula [11, Eq. (II.6)]

Therefore, by using (2.6) and (2.3) successively, we obtain

3. The Rogers Formula

$$\begin{split} &= \frac{(uxtq;q)_{\infty}}{(vxtq;q)_{\infty}} \sum_{n=0}^{\infty} \frac{(-1)^{n} q^{\binom{n}{2}} (1/(\alpha x), 1/(uxt);q)_{n}}{(1/(vxt),q;q)_{n}} \left(\frac{\alpha uq}{v}\right)^{n} r \Phi_{s} \begin{bmatrix} a_{1},a_{2},\cdots,a_{r}; \\ a_{1},b_{2},\cdots,b_{s}; \end{bmatrix} \\ &\quad \cdot \sum_{k=0}^{\infty} \frac{(q^{n}/(\alpha x);q)_{k}(\alpha q)^{k}}{(q;q)_{k}} \\ &= \frac{(uxtq;q)_{\infty}}{(vxtq;q)_{\infty}} \sum_{n=0}^{\infty} \frac{(-1)^{n} q^{\binom{n}{2}} (1/(\alpha x), 1/(uxt);q)_{n}}{(1/(vxt),q;q)_{n}} \left(\frac{\alpha uq}{v}\right)^{n} r \Phi_{s} \begin{bmatrix} a_{1},a_{2},\cdots,a_{r}; \\ a_{1},b_{2},\cdots,b_{s}; \end{bmatrix} \\ &\quad \cdot \frac{(q^{1+n}/x;q)_{\infty}}{(\alpha q;q)_{\infty}} \\ &= \frac{(q/x,uxtq;q)_{\infty}}{(\alpha q,vxtq;q)_{\infty}} \sum_{n=0}^{\infty} \frac{(-1)^{n} q^{\binom{n}{2}} (1/(\alpha x), 1/(uxt);q)_{n}}{(q/x, 1/(vxt),q;q)_{n}} \left(\frac{\alpha uq}{v}\right)^{n} r \Phi_{s} \begin{bmatrix} a_{1},a_{2},\cdots,a_{r}; \\ b_{1},b_{2},\cdots,b_{s}; \end{bmatrix} \end{split}$$

which is precisely the right-hand side of the assertion (4.3) of Theorem 3. The proof of Theorem 3 is thus completed. $\hfill \Box$

Remark 4. In view of the special case (1.33) of $\Psi_n^{(\mathbf{a},\mathbf{b})}(u,v,z|q)$, we deduce the bilinear generating function for the Hahn polynomials $\psi_n^{(\alpha)}(x|q)$ as asserted by Corollary 1 below.

Corollary 1. Let $\max\{|\alpha q|, |axytq|\} < 1$. Then

$$\sum_{n=0}^{\infty} \psi_n^{(\alpha)}(x|q) \psi_n^{(a)}(y|q) \frac{(-1)^n q^{\binom{n+1}{2}} t^n}{(q;q)_n} = \frac{(q/x, xytq, xtq;q)_{\infty}}{(\alpha q, axytq;q)_{\infty}} {}_3\Phi_2 \begin{bmatrix} 1/(\alpha x), 1/(xyt), 1/(xt); \\ q; \frac{\alpha xtq}{a} \end{bmatrix}.$$
(4.6)

Remark 5. For r = s, $\mathbf{a} = \mathbf{b} = \mathbf{0}$, x = y, y = ay and z = 1, the assertion (4.3) reduces to Corollary 1.

5. A Transformational Identity Involving Generating Functions for the Generalized *q*-Hypergeometric Polynomials

In this section, we derive the following transformational identity involving generating functions for the generalized q-hypergeometric polynomials. Once again, in our derivation, we apply the homogeneous q-difference operator (2.1).

Theorem 4. Let A(n) and B(n) satisfy the following relationship:

$$\sum_{n=0}^{\infty} A(n) P_n(v, u) = \sum_{n=0}^{\infty} B(n) \frac{(xutq^{1-n}; q)_{\infty}}{(xvtq^{1-n}; q)_{\infty}}.$$
(5.1)

Then

$$\sum_{n=0}^{\infty} (-1)^n q^{\binom{n}{2}} A(n) \Psi_n^{(\mathbf{a},\mathbf{b})}(u,v,z|q) = \sum_{n=0}^{\infty} B(n) \frac{(xutq^{1-n};q)_{\infty}}{(xvtq^{1-n};q)_{\infty}} r \Phi_s \begin{bmatrix} a_1, a_2, \cdots, a_r; \\ q; xztq^{1-n} \\ b_1, b_2, \cdots, b_s; \end{bmatrix}, \quad (5.2)$$

provided that each of the series in (5.1) and (5.2) is absolutely convergent.

A General Family of q-Hypergeometric Polynomials

Proof. If we denote by f(x, u, v, z) the right-hand side of (5.2), we find by using (5.1) and (2.2) that

$$f(x, u, v, z) = \sum_{n=0}^{\infty} B(n) {}_{r} \Phi_{s} \begin{bmatrix} a_{1}, a_{2}, \cdots, a_{r}; \\ b_{1}, b_{2}, \cdots, b_{s}; \end{bmatrix} q; -z \Theta_{uv} \end{bmatrix} \left\{ \frac{(xutq^{1-n}; q)_{\infty}}{(xvtq^{1-n}; q)_{\infty}} \right\}$$
$$= {}_{r} \Phi_{s} \begin{bmatrix} a_{1}, a_{2}, \cdots, a_{r}; \\ b_{1}, b_{2}, \cdots, b_{s}; \end{bmatrix} q; -z \Theta_{uv} \end{bmatrix} \left\{ \sum_{n=0}^{\infty} B(n) \frac{(xutq^{1-n}; q)_{\infty}}{(xvtq^{1-n}; q)_{\infty}} \right\}$$
$$= {}_{r} \Phi_{s} \begin{bmatrix} a_{1}, a_{2}, \cdots, a_{r}; \\ b_{1}, b_{2}, \cdots, b_{s}; \end{bmatrix} q; -z \Theta_{uv} \end{bmatrix} \left\{ \sum_{n=0}^{\infty} A(n) P_{n}(v, u) \right\}$$
$$= \sum_{n=0}^{\infty} A(n) {}_{r} \Phi_{s} \begin{bmatrix} a_{1}, a_{2}, \cdots, a_{r}; \\ b_{1}, b_{2}, \cdots, b_{s}; \end{bmatrix} q; -z \Theta_{uv} \end{bmatrix} \{P_{n}(v, u)\}$$
$$= \sum_{n=0}^{\infty} (-1)^{n} q^{\binom{n}{2}} A(n) \Psi_{n}^{(\mathbf{a}, \mathbf{b})}(u, v, z|q),$$

which is precisely the left-hand side of (5.2). Our demonstration of Theorem 4 is thus completed. \Box

Remark 6. Upon setting $u = 1, v = \lambda$,

$$A(n) = \psi_n^{(\alpha)}(x|q) \frac{(qt)^n}{(q;q)_n} \quad \text{and} \quad B(n) = \sum_{k=0}^{\infty} \frac{(1/(\alpha x);q)_k (\alpha q)^k}{(q;q)_k} \frac{(q^{-k};q)_n q^{nk}}{(q;q)_n} \quad (5.3)$$

in (5.1), we get (4.2). Moreover, Upon specializing A(n) and B(n) in (5.2) as in the last equation (5.3), we get the assertion (4.3) of Theorem 3.

6. Concluding Remarks and Observations

In our present investigation, we have introduced a general family of q-hypergeometric polynomials and we have derived several q-series identities such as an extended generating function and Srivastava-Agarwal type bilinear generating functions for this family of q-hypergeometric polynomials. We have presented a transformational identity involving generating functions for the generalized q-hypergeometric polynomials which we have introduced here. We have also pointed out relevant connections of the various q-results, which we have investigated in this paper, with those in several related earlier works on this subject.

We conclude this paper by remarking that, in the recently-published survey-cum-expository review article by Srivastava [19], the so-called (p,q)-calculus was exposed to be a rather trivial and inconsequential variation of the classical q-calculus, the additional parameter p being redundant or superfluous (see, for details, [19, p. 340]). This observation by Srivastava [19] will indeed apply to any attempt to produce the rather straightforward (p,q)-variations of the results which we have presented in this paper.
