# RAMIFICATION FILTRATION AND DIFFERENTIAL FORMS

#### Abstract

Let $L$ be a complete discrete valuation field of prime characteristic $p$ with finite residue field. Denote by $\Gamma_{L}^{(v)}$ the ramification subgroups of $\Gamma_{L}=\operatorname{Gal}\left(L^{\text {sep }} / L\right)$. We consider the category $\mathrm{M} \mathrm{\Gamma}_{L}^{L i e}$ of finite $\mathbb{Z}_{p}\left[\Gamma_{L}\right]$-modules $H$, satisfying some additional (Lie)-condition on the image of $\Gamma_{L}$ in $\mathrm{Aut}_{\mathbb{Z}_{p}} H$. In the paper it is proved that all information about the images of the groups $\Gamma_{L}^{(v)}$ in Aut $_{\mathbb{Z}_{p}} H$ can be explicitly extracted from some differential forms $\widetilde{\Omega}[N]$ on the Fontaine etale $\phi$-module $M(H)$ associated with $H$. The forms $\widetilde{\Omega}[N]$ are completely determined by a canonical connection $\nabla$ on $M(H)$. In the case of fields $L$ of mixed characteristic, which contain a primitive $p$-th root of unity, we show that a similar problem for $\mathbb{F}_{p}\left[\Gamma_{L}\right]$-modules also admits a solution. In this case we use the field-of-norms functor to construct the corresponding $\phi$-module together with the action of the Galois group of a cyclic extension $L_{1}$ of $L$ of degree $p$. Then our solution involves the characteristic $p$ part (provided by the field-of-norms functor) and the condition for a "good" lift of a generator of $\operatorname{Gal}\left(L_{1} / L\right)$. Apart from the above differential forms the statement of this condition uses the power series coming from the $p$-adic period of the formal group $\mathbb{G}_{m}$.


## Introduction

Let $L$ be a complete discrete valuation field with finite residue field of characteristic $p$. Let $\Gamma_{L}$ be the absolute Galois group of $L$. Let $\left\{\Gamma_{L}^{(v)}\right\}_{v \geqslant 0}$ be the filtration of $\Gamma_{L}$ by the ramification subgroups, [20]. This filtration provides $\Gamma_{L}$ with additional structure and allows us to introduce various classes of infinite field extensions (arithmetically profinite, deeply ramified etc.), which play an important role in modern arithmetic algebraic geometry. For $\Gamma_{L}$-modules $H$, the evaluation of $v_{0}(H) \in \mathbb{Q}$ such that $\Gamma_{L}^{(v)}$ act trivially on $H$ for $v>v_{0}(H)$, provides us with good estimates for discriminants of the fields of definition of $h \in H$. Such estimates are used very often to answer various number theoretic questions.

[^0]However, an explicit description of the structure of the ramification filtration for a very long time was known only at the level of the Galois groups of abelian field extensions. At the time when the structure of the Galois group $\Gamma_{L}$ was completely described (the case of the maximal $p$-extensions - Shafarevich [21], Demushkin [13], and the general case - Janssen-Wingberg [16]) it became clear that $\Gamma_{L}$ is a very weak invariant of the field $L$. The situation cardinally changed later when it was established (Mochizuki [19], author [4]) that taking $\left\{\Gamma_{L}^{(v)}\right\}_{v \geqslant 0}$ into account gives us absolute invariant of the field $L$. However, in order to work with this invariant we still need to know an explicit description of the filtration by the groups $\Gamma_{L}^{(v)}$.
I.R. Shafarevich always paid attention to this problem, for example, cf. Introduction to [17]. His motivation was the following: for every prime number $p$ there is only one such filtration and we know almost nothing about its structure. In 1990's the author developed a nilpotent version of the Artin-Schreier theory and obtained an explicit description of the ramification filtration modulo the subgroup of $p$-th commutators of $\Gamma_{L}$. Such description was obtained, first, in the characteristic $p$ case, [1, 2, 3], and then developed in the mixed characteristic case, [7, 8, 9]. These results play a crucial role in this paper, where we study the images of the ramification subgroups $\Gamma_{L}^{(v)}$ in the group of automorphisms Aut $\mathbb{Z}_{p} H$ of finite $\mathbb{Z}_{p}\left[\Gamma_{L}\right]$-modules $H$. Our main result states that this arithmetic structure can be completely described (under some additional condition) in purely geometric properties of Fontaine's etale $\phi$-modules $M(H)$.

More precisely, if char $L=p$ we construct differential forms $\widetilde{\Omega}[N]$, $N \in \mathbb{N}$, on an extension of scalars of $M(H)$, and specify the way how the image of the ramification filtration in $\mathrm{Aut}_{\mathbb{Z}_{p}} H$ can be recovered from these forms. Note that the definition of $\widetilde{\Omega}[N]$ depends only on a natural connection constructed on $M(H)$. If char $L=0$ we assume that $L$ contains a $p$-th root of unity $\zeta_{1} \neq 1$ and restrict ourselves to the case of Galois $\mathbb{F}_{p}$-modules. Then we apply the field-of-norms functor to reduce the situation to the characteristic $p$ case and use a characterization of "good" lifts of automorphisms of our cyclic field extension of $L$ from [7, 8]. This characterization uses again the differential forms $\widetilde{\Omega}[N]$ and a power series coming from the $p$-adic period of the formal group $\mathbb{G}_{m}$.

By our opinion this result establishes quite interesting link between the Galois theory of local fields and very popular area of $D$-modules, lifts of Frobenius, Higgs vector bundles etc.

## 1. Statement of the main result

1.1. General notation. Everywhere in the paper $p$ is a fixed prime number. If $E_{0}$ is a field then $E_{0}^{s e p}$ is its separable closure in some algebraic closure $E_{0}^{a l g}$ of $E_{0}$. If $E$ is a field such that $E_{0} \subset E \subset E_{0}^{s e p}$
set $\Gamma_{E}=\operatorname{Gal}\left(E_{0}^{\text {sep }} / E\right)$. The field $E_{0}^{\text {sep }}$ will be considered as a left $\Gamma_{E_{0}}-$ module, i.e. for any $\tau_{1}, \tau_{2} \in \Gamma_{E_{0}}$ and $o \in E_{0}^{s e p},\left(\tau_{1} \tau_{2}\right) o=\tau_{1}\left(\tau_{2} o\right)$. If $\operatorname{char} E_{0}=p$ we set for any $a \in E_{0}^{s e p}, \sigma(a)=a^{p}$.

If $V$ is a module over a ring $R$ then $\operatorname{End}_{R} V$ is the $R$-algebra of $R$-linear endomorphisms of $V$. We always consider $V$ as a left $\operatorname{End}_{R} V$ module, i.e. if $l_{1}, l_{2} \in \operatorname{End}_{R} V$ and $v \in V$ then $\left(l_{1} l_{2}\right) v=l_{1}\left(l_{2}(v)\right)$. We also consider $\operatorname{End}_{R} V$ as a Lie $R$-algebra with the Lie bracket $\left[l_{1}, l_{2}\right]=$ $l_{1} l_{2}-l_{2} l_{1}$. If $S$ is an $R$-module then we often denote by $V_{S}$ the extension of scalars $V \otimes_{R} S$.
1.2. Functorial system of lifts to characteristic $\mathbf{0}$. Suppose $K_{0}=$ $k_{0}\left(\left(t_{0}\right)\right)$ is the field of formal Laurent series in a (fixed) variable $t_{0}$ with coefficients in a finite field $k_{0}$ of characteristic $p$. The uniformiser $t_{0}$ provides a $p$-basis for any field extension $E$ of $K_{0}$ in $K_{0}^{\text {sep }}$, i.e. the set $\left\{1, t_{0}, \ldots, t_{0}^{p-1}\right\}$ is a $E^{p}$-basis of $E$. We use this $p$-basis to construct a compatible system of lifts $O(E)$ of the fields $E$ to characteristic 0 . This is a special case of the construction of lifts from [11]; it can be explained as follows.
For all $M \in \mathbb{N}$, set $O_{M}(E)=W_{M}\left(\sigma^{M-1} E\right)\left[\bar{t}_{0}\right]$, where $\bar{t}_{0}=\left[t_{0}\right]$ is the Teichmuller representative of $t_{0}$ in the ring of Witt vectors $W_{M}(E)$. The rings $O_{M}(E)$ are the lifts of $E$ modulo $p^{M}$, i.e. they are flat $\mathbb{Z} / p^{M_{-}}$ algebras such that $O_{M}(E) \otimes_{\mathbb{Z} / p^{M}} \mathbb{Z} / p=E$. Note that the system

$$
\left\{O_{M}(E) \mid M \in \mathbb{N}, K_{0} \subset E \subset K_{0}^{\text {sep }}\right\}
$$

is functorial in $M$ and $E$. In particular, if $E / K_{0}$ is Galois then there is a natural action of $\operatorname{Gal}\left(E / K_{0}\right)$ on $O_{M}(E)$ and $O_{M}(E)^{\operatorname{Gal}\left(E / K_{0}\right)}=$ $O_{M}\left(K_{0}\right)$. The morphisms $W_{M}(\sigma)$ induce $\sigma$-linear morphisms on $O_{M}(E)$ which will be denoted again by $\sigma$. In particular, $\sigma\left(\bar{t}_{0}\right)=\bar{t}_{0}^{p}$.

Introduce the lifts of the above fields $E$ to characteristic 0 by setting $O(E)=\lim _{\underset{M}{ }} O_{M}(E)$. Then $O_{M}(E)=O(E) / p^{M}$ and $O(E)[1 / p]$ is a complete discrete valuation field with uniformiser $p$ and the residue field $E$. Clearly, we have the induced morphism $\sigma$ on each $O(E)$. Also, if $E / K_{0}$ is Galois then $\operatorname{Gal}\left(E / K_{0}\right)$ acts on $O(E)$ and $O(E)^{\operatorname{Gal}\left(E / K_{0}\right)}=$ $O\left(K_{0}\right)$. Notice that $O\left(K_{0}\right)={\underset{\zeta}{M}}_{\lim _{M}} W_{M}\left(k_{0}\right)\left(\left(\bar{t}_{0}\right)\right)$ is the completion of the ring of formal Laurent series $W(k)\left(\left(\bar{t}_{0}\right)\right)$.

Set $O_{\text {sep }}=O\left(K_{0}^{\text {sep }}\right)$.
The system of lifts $O(E), E \subset K_{0}^{\text {sep }}$, can be extended to the system of lifts of all extensions of $K_{0}$ in $K_{0}^{\text {alg }}$. Indeed, note that $K_{0}^{\text {alg }}=$ $\bigcup_{n \geqslant 0} K_{0}\left(t_{n}\right)^{\text {sep }}$, where $t_{n}^{p^{n}}=t_{0}$. Then $t_{n}$ gives the $p$-basis $\left\{1, t_{n}, \ldots, t_{n}^{p-1}\right\}$ for all separable extensions $E$ of $K_{0}\left(t_{n}\right)$ in $K_{0}^{\text {alg }}$ and we obtain (as earlier) the corresponding lifts $O(E)$. The system of lifts $O(E)$ is functorial in $E \subset K_{0}^{\text {alg }}$ (use that any separable extension $E_{n}$ of $K_{0}\left(t_{n}\right)$ appears uniquely as the composite $E_{0} K_{0}\left(t_{n}\right)$, where $E_{0} / K_{0}$ is separable). In particular, consider $K_{0}^{\text {rad }}=\bigcup_{N \in \mathbb{N}} K_{0}^{u r}\left(t_{0}^{1 / N}\right)$. Then for the
above defined lift of $K_{0}^{\text {rad }}$ we have $O\left(K_{0}^{r a d}\right)=\bigcup_{N \in \mathbb{N}} O\left(K_{0}^{u r}\right)\left[\bar{t}_{0}{ }^{1 / N}\right]$, where $K_{0}^{u r}=\bar{k}_{0}\left(\left(t_{0}\right)\right)$ is the maximal unramified extension of $K_{0}$.
1.3. Equivalence of the categories of $p$-groups and Lie algebras, [18]. Let $L$ be a finitely generated Lie $\mathbb{Z}_{p}$-algebra of nilpotent class $<p$, i.e. the ideal of $p$-th commutators $C_{p}(L)$ of $L$ is equal to zero. Let $A$ be an enveloping algebra of $L$. Then the elements of $L \subset A$ generate the augmentation ideal $J$ of $A$. There is a morphism of $\mathbb{Z}_{p}$-algebras $\Delta$ : $A \longrightarrow A \otimes A$ uniquely determined by the condition $\Delta(l)=l \otimes 1+1 \otimes l$ for all $l \in L$. Then the set $\exp (L) \bmod J^{p}$ is identified with the group of all " diagonal elements modulo degree $p^{\text {" consisting of } a \in 1+J \bmod J^{p} .}$ such that $\Delta(a) \equiv a \otimes a \bmod (J \otimes 1+1 \otimes J)^{p}$.

In particular, there is a natural embedding $L \subset A / J^{p}$ and the identity

\exp \left(l_{1}\right) \cdot \exp \left(l_{2}\right) \equiv \exp \left(l_{1} \circ l_{2}\right) \bmod J^{p}
$$

induces the Campbell-Hausdorff composition law

$$
\left(l_{1}, l_{2}\right) \mapsto l_{1} \circ l_{2}=l_{1}+l_{2}+\frac{1}{2}\left[l_{1}, l_{2}\right]+\ldots, \quad l_{1}, l_{2} \in L
$$

This composition law provides the set $L$ with a group structure. We denote this group by $G(L)$. Clearly $G(L) \simeq \exp (L) \bmod J^{p}$.

With the above notation the functor $L \mapsto G(L)$ determines the equivalence of the categories of finitely generated $\mathbb{Z}_{p}$-Lie algebras and profinite $p$-groups of nilpotence class $<p$. Note that a subset $I \subset L$ is an ideal in $L$ iff $G(I)$ is a normal subgroup in $G(L)$.
1.4. (Lie)-condition. For any finite field extension $K$ of $K_{0}$ in $K_{0}^{\text {sep }}$, let $M \Gamma_{K}$ be the category of finitely generated $\mathbb{Z}_{p}$-modules $H$ with continuous left action of $\Gamma_{K}$. Each element $h \in H$ is defined over some finite extension $K(h)$ of $K$. In some sense the family of these fields determines "arithmetic" properties of $H$. More detailed information about the fields $K(h)$ can be obtained from the knowledge of the images of the ramification subgroups in upper numbering $\Gamma_{K}^{(v)}, v>0$, in Aut $_{\mathbb{Z}_{p}} H$. For example, the minimal number $v_{0}(H) \in \mathbb{Q}$ such that all $\Gamma_{K}^{(v)}$ with $v>v_{0}(H)$ act trivially on $H$ provides us with upper estimates for the discriminants of the fields of definition of $h \in H$, cf. [4].

Let $H_{0} \in \mathrm{M} \Gamma_{K_{0}}$ and let $\pi_{H_{0}}: \Gamma_{K_{0}} \longrightarrow \operatorname{Aut}_{\mathbb{Z}_{p}} H_{0}$ be the group homomorphism which determines the $\Gamma_{K_{0}}$-module structure on $H_{0}$. Consider the full subcategory $\mathrm{M} \Gamma_{K_{0}}^{\mathrm{Lie}}$ in $\mathrm{M} \Gamma_{K_{0}}$ which consists of modules $H_{0}$ satisfying the following condition:
(Lie) The image $I\left(H_{0}\right):=\pi_{H_{0}}(\mathcal{I}) \subset$ Aut $_{\mathbb{Z}_{p}}\left(H_{0}\right)$ of the wild inertia subgroup $\mathcal{I} \subset \Gamma_{K_{0}}$ appears in the form $\exp \left(L\left(H_{0}\right)\right)$, where $L\left(H_{0}\right) \subset$ $\operatorname{End}_{\mathbb{Z}_{p}} H_{0}$ is a Lie subalgebra such that $L\left(H_{0}\right)^{p}=0$.

The condition $L\left(H_{0}\right)^{p}=\left\{l_{1} \ldots l_{p} \mid l_{1}, \ldots, l_{p} \in L\left(H_{0}\right)\right\}=0$ (the product is taken in $\operatorname{End}_{\mathbb{Z}_{p}} H_{0} \supset L\left(H_{0}\right)$ ) implies that $L\left(H_{0}\right)$ is a finitely
generated nilpotent $\mathbb{Z}_{p}$-algebra Lie of nilpotence class $<p$. This gives the group isomorphism $\exp : G\left(L\left(H_{0}\right)\right) \simeq I\left(H_{0}\right)$. Note that any normal subgroup of $I\left(H_{0}\right)$ appears in the form $\exp G(J)$, where $J$ is a Lie ideal of $L\left(H_{0}\right)$.

Remark 1.1. If $p H_{0}=0$ and $\operatorname{dim}_{\mathbb{F}_{p}} H_{0} \leqslant p$ then $H_{0}$ is of the Lie type.
1.5. The first main result: the characteristic $p$ case. Suppose $H_{0} \in \mathrm{M} \Gamma_{K_{0}}^{\text {Lie }}$. Our target is to determine for all $v>0$, the images $\pi_{H_{0}}\left(\Gamma_{K_{0}}^{(v)}\right)$ of the ramification subgroups $\Gamma_{K_{0}}^{(v)}$ via an explicit construction of the ideals $L\left(H_{0}\right)^{(v)} \subset L\left(H_{0}\right)$ such that $\exp \left(L\left(H_{0}\right)^{(v)}\right)=\pi_{H_{0}}\left(\Gamma_{K_{0}}^{(v)}\right)$.

Our approach uses Fontaine's "analytical" description of the Galois modules $H_{0} \in \mathrm{M}_{K_{0}}^{\mathrm{Lie}}$ in terms of etale $\left(\phi, O\left(K_{0}\right)\right)$-modules $M\left(H_{0}\right)$. A geometric nature of $M\left(H_{0}\right)$ is supported by the existence of an analogue of the classical connection $\nabla: M\left(H_{0}\right) \longrightarrow M\left(H_{0}\right) \otimes_{O\left(K_{0}\right)} \Omega_{O\left(K_{0}\right)}^{1}$, cf. [14]. (This map is uniquely characterized by the condition $\nabla \cdot \phi=(\phi \otimes$ $\phi) \cdot \nabla$.) The required information about the behaviour of ramification subgroups can be then extracted from some differential forms

$$
\widetilde{\Omega}[N] \in M\left(H_{0}\right)_{O\left(K_{0}^{r a d}\right)} \otimes_{O\left(K_{0}\right)} \Omega_{O\left(K_{0}\right)}^{1}
$$

The construction of these differential forms is given completely in terms of the above connection $\nabla$ and can be explained as follows.

Let $K \subset K_{0}^{\text {sep }}$ be a fixed tamely ramified finite extension of $K_{0}$ such that $\pi_{H_{0}}\left(\Gamma_{K}\right)=I\left(H_{0}\right)$. Then $H:=\left.H_{0}\right|_{\Gamma_{K}}$ can be described via an etale $(\phi, O(K))$-module $M(H)=M\left(H_{0}\right) \otimes_{O\left(K_{0}\right)} O(K)$. Recall that $M(H)=\left(H \otimes_{\mathbb{Z}_{p}} O_{s e p}\right)^{\Gamma_{K}}$ is a finitely generated $O(K)$-module with a $\sigma$-linear morphism $\phi: M(H) \longrightarrow M(H)$ such that the image $\phi(M(H))$ generates $M(H)$ over $O(K)$. This allows us to identify the elements of $H$ with a set of $O_{s e p}$-solutions of a suitable system of equations with coefficients in $O(K)$.

We establish below the construction of $M(H)$ by introducing a $\mathbb{Z}_{p^{-}}$ linear embedding $\mathcal{F}: H \longrightarrow M(H)$ which induces by extension of scalars the identification $H_{O(K)} \simeq M(H)$. (We denote this identification by the same symbol $\mathcal{F}$.)
Now let $\widetilde{B}$ be (a inique) $O(K)$-linear operator on $M(H)$ such that for any $m \in \mathcal{F}(H), \nabla(m)=\widetilde{B}(m) d \bar{t} / \bar{t}$. Then for every $N \in \mathbb{Z}_{\geqslant 0}$ we introduce the differential forms

\widetilde{\Omega}[N]=\phi^{N} \widetilde{B} \phi^{-N} d \bar{t} / \bar{t} \in \operatorname{End} M(H)_{O\left(K^{\text {rad }}\right)} \otimes_{O(K)} \Omega_{O(K)}^{1}
$$

Now we can use the identification $\mathcal{F}: H_{O(K)} \simeq M(H)$ to obtain the corresponding differential forms $\Omega[N]$ on $\operatorname{End}(H)_{O\left(K^{\text {rad }}\right)}$ and to verify that

\Omega[N] \in L(H)_{O\left(K^{\text {rad }}\right)} \otimes_{O(K)} \Omega_{O(K)}^{1}=L\left(H_{0}\right)_{O\left(K_{0}^{\text {rad }}\right)} \otimes_{O\left(K_{0}\right)} \Omega_{O\left(K_{0}\right)}^{1} .
$$

Remark 1.2. Our differential forms will usually appear in the form $\Omega=F \cdot d \bar{t}_{0} / \bar{t}_{0}$, where $F \in L(H)_{K_{0}^{r a d}}$. Then we set by definition

\left(\mathrm{id}_{L(H)} \otimes \sigma\right) \Omega=\left(\mathrm{id}_{L(H)} \otimes \sigma\right) F \cdot d \bar{t}_{0} / \bar{t}_{0}
$$

Our first main result can be stated as follows.
Theorem 1.1. Suppose $H_{0} \in \mathrm{M} \Gamma_{K_{0}}^{\mathrm{Lie}}$ is finite. Then there is $N_{0}\left(H_{0}\right) \in$ $\mathbb{N}$ such that for any (fixed) $N \geqslant N_{0}\left(H_{0}\right)$ the following propery holds:
if $\left(\operatorname{id}_{L(H)} \otimes \sigma^{-N}\right) \Omega[N]=\sum_{r \in \mathbb{Q}} \bar{t}_{0}^{-r} l_{r} d \bar{t}_{0} / \bar{t}_{0}$, where all $l_{r} \in L\left(H_{0}\right)_{W\left(\bar{k}_{0}\right)}$, then the ideal $L\left(H_{0}\right)^{(v)}$ is the minimal ideal in $L\left(H_{0}\right)$ such that for all $r \geqslant v, l_{r} \in L\left(H_{0}\right)_{W\left(\bar{k}_{0}\right)}^{(v)}$.
Corollary 1.2. If $v_{0}\left(H_{0}\right)=\max \left\{r \mid l_{r} \neq 0\right\}$ then the ramification subgroups $\Gamma_{K_{0}}^{(v)}$ act trivially on $H_{0}$ iff $v>v_{0}\left(H_{0}\right)$.
Remark 1.3. The construction of $\Omega[N]$ almost does not depend on the choice of the tamely ramified finite field extension $K$ of $K_{0}$. It depends essentially on the choice of the uniformising element $t_{0}$ in $K_{0}$ and a compatible system of $\alpha(k) \in W(k)$, where $\left[k: k_{0}\right]<\infty$, such that the trace of $\alpha(k)$ in the field extension $W(k)[1 / p] / K_{0}$ equals 1 .

Remark 1.4. If $H_{0}$ is not $p$-torsion Theorem 1.1 can be applied to the factors $H_{0} / p^{M}$ and our result describes the structure of the images of $L\left(H_{0}\right)^{(v)}$ in all $L\left(H_{0}\right) / p^{M}$.

### 1.6. The second main result: the mixed characteristic case.

Let $E_{0}$ be a finite field extension of $\mathbb{Q}_{p}$ with residue field $k_{0}$ and a uniformizing element $\pi_{0}$. Assume that $E_{0}$ contains a $p$-th primitive root of unity $\zeta_{1}$. Consider the category $\mathrm{M} \mathrm{\Gamma}_{E_{0}, 1}^{\mathrm{Lie}}$ of finitely generated $\mathbb{F}_{p}\left[\Gamma_{E_{0}}\right]$-modules which satisfy a direct analog of the Lie condition from Sec.1.4.

Take the infinite arithmetically profinite field extension $\widetilde{E}_{0}$ obtained from $E_{0}$ by joining all $p$-power roots of $\pi_{0}$. Then the theory of the field-of-norms functor $X$ provides us with the complete discrete valuation field of characteristic $p, X\left(\widetilde{E}_{0}\right)=K_{0}$, which has the same residue field and the uniformizing element $t_{0}$ obtained from the $p$-power roots of $\pi_{0}$. The functor $X$ also provides us with the identification of Galois groups $\Gamma_{K_{0}}=\Gamma_{\widetilde{E}_{0}} \subset \Gamma_{E_{0}}$.

If $H_{E_{0}} \in \mathrm{M} \Gamma_{E_{0}, 1}^{\mathrm{Lie}}$ then we obtain $H_{0}:=\left.H_{E_{0}}\right|_{\Gamma_{K_{0}}} \in \mathrm{M} \Gamma_{K_{0}}^{\mathrm{Lie}}$. As earlier, take a finite tamely ramified extension $K$ of $K_{0}$ (it corresponds to a unique tamely ramified extension $E$ of $E_{0}$ with uniformizer $\pi$ such that $\pi^{e_{0}}=\pi_{0}$, where $e_{0}$ is the ramification index of $E / E_{0}$, and construct $(\phi, O(K))$-module $M(H)$. This module inherits the action of $\operatorname{Gal}(E(\sqrt[p]{\pi}) / E)=\left\langle\tau_{0}\right\rangle^{\mathbb{Z} / p}$. (Here $\tau_{0}$ is such that $\tau_{0}(\sqrt[p]{\pi})=\zeta_{1} \sqrt[p]{\pi}$.) This situation was considered in all details in the papers [7, 8]. In particular, in those papers we gave a characterization of the "good" lifts $\hat{\tau}_{0}$
of $\tau_{0}$. By definition, $\hat{\tau}_{0} \in \Gamma_{E}$ is "good" if its restriction to $H_{E_{0}}$ belongs to the image of the ramification subgroup $\Gamma_{E}^{\left(e^{*}\right)}$. Here $e^{*}:=p e /(p-1)$ and $e=e\left(E / \mathbb{Q}_{p}\right)$ is the ramification index of $E / \mathbb{Q}_{p}$. (This makes sense because $\tau_{0} \in \operatorname{Gal}\left(E(\sqrt[p]{\pi} / E)^{\left(e^{*}\right)}\right.$.) Note that the field-of-norms functor is compatible with ramification filtrations on $\Gamma_{E_{0}}$ and $\Gamma_{K_{0}}$. Therefore, the knowledge of "good lifts" $\hat{\tau}_{0}$ together with Theorem 1.1 gives a complete description of the image of the ramification filtration of $\Gamma_{E_{0}}$ in $\operatorname{Aut} H_{E_{0}}$.

In [8] we proved that the action of $\hat{\tau}_{0}$ appears from an action of a formal group scheme of order $p$. As a result, the lift $\hat{\tau}_{0}$ is completely determined by the value $d \hat{\tau}_{0}(0) \in L(H)$ of its differential at 0 , and we can use the characterization of differentials of "good" lifts from [8], Theorem 5.1.

Namely, let us first specify our $p$-th root of unity

$$
\zeta_{1}=1+\sum_{j \geqslant 0}\left[\beta_{j}\right] \pi^{\left(e^{*} / p\right)+j} \bmod p
$$

(here all $\left[\beta_{j}\right]$ are the Teichmuller representatives of elements from the residue field of $E)$. Then we introduce the power series $\omega(t) \in O(K)$ such that

$$
1+\sum_{j \geqslant 0} \beta_{j}^{p} t^{e^{*}+p j}=\widetilde{\exp }\left(\omega(t)^{p}\right)
$$

(here $\widetilde{\exp }$ is the truncated exponential). The series $\omega(t)^{p}$ is a kind of approximation of the $p$-adic period of the formal multiplicative group, which appears usually in explicit formulas for the Hilbert symbol, e.g. [6]. In other words, we obtain another geometric condition characterizing "arithmetic" of the $\Gamma_{E_{0}}$-module $H_{E_{0}}$.
Theorem 1.3. The lift $\hat{\tau}_{0}$ is "good" iff

$$
d \hat{\tau}_{0}(0) \equiv \sum_{m \geqslant 0} \operatorname{Res}\left(\omega(t)^{p^{m+1}} \Omega[m]\right) \bmod L(H)_{k}^{\left(e^{*}\right)} .
$$

Remark 1.5. Notice that the power series $\omega(t)^{p}$ has non-zero coefficients only for the powers $t^{e^{*}+p j}$ and all these exponents $\geqslant e^{*}$. Therefore, the differential forms $\Omega[m]$ contribute to the right hand side only via the images of $\mathcal{F}_{e^{*}+p j,-m}^{0} t^{-\left(e^{*}+p j\right)}$ in $L(H)_{k}$. But for $m \gg 0$, these images belong to the images of the ramification ideals $\mathcal{L}_{k}^{\left(e^{*}\right)}$ and, therefore, disappear modulo $L(H)_{k}^{\left(e^{*}\right)}$, and the sum in the right hand side is, as a matter of fact, finite.
2. $\phi$-module $M(H)$
2.1. Specification of $\log \pi_{H}: \Gamma_{K} \longrightarrow G(L(H))$. As earlier, $H_{0} \in$ $\mathrm{M} \Gamma_{K_{0}}^{\text {Lie }}, K$ is a finite tamely ramified extension of $K_{0}$ in $K_{0}^{\text {sep }}$ such that $\pi_{H_{0}}\left(\Gamma_{K}\right)=I\left(H_{0}\right), H=\left.H_{0}\right|_{\Gamma_{K}}$. Set $L(H)=L\left(H_{0}\right), \pi_{H}=\left.\pi_{H_{0}}\right|_{\Gamma_{K}}$.

Consider the continuous group epimorphism $l_{H}:=\log \left(\pi_{H}\right): \Gamma_{K} \longrightarrow$ $G(L(H))$. Since the $p$-group $G(L(H))$ has nilpotence class $<p$ this epimorphism can be described in terms of the covariant version of the nilpotent Artin-Schreier theory from [2]. Namely, there are $e \in$ $L(H)_{O(K)}$ and $f \in L(H)_{O_{s e p}}$ such that $\left(\mathrm{id}_{L(H)} \otimes \sigma\right)(f)=e \circ f$ and for any $\tau \in \Gamma_{K}, l_{H}(\tau)=(-f) \circ\left(\operatorname{id}_{L(H)} \otimes \tau\right) f$.

It could be easily verified that $l_{H}$ is a group homomorphism. Indeed,

$$
\begin{gathered}
\qquad l_{H}\left(\tau_{1} \tau_{2}\right)=(-f) \circ\left(\operatorname{id}_{L(H)} \otimes \tau_{1} \tau_{2}\right) f= \\
(-f) \circ\left(\operatorname{id}_{L(H)} \otimes \tau_{1}\right) f \circ(-f) \circ\left(\operatorname{id}_{L(H)} \otimes \tau_{2}\right) f=l_{H}\left(\tau_{1}\right) \circ l_{H}\left(\tau_{2}\right), \\
\text { because }\left(\operatorname{id}_{L(H)} \otimes \tau_{1}\right) l_{H}\left(\tau_{2}\right)=l_{H}\left(\tau_{2}\right)
\end{gathered}
$$

Notation. We will use below the following notation: $\sigma_{H}=\operatorname{id}_{H} \otimes \sigma$ and $\sigma_{L(H)}=\operatorname{id}_{L(H)} \otimes \sigma$. For example, if $u=\sum_{\alpha} h_{\alpha} \otimes o_{\alpha}$, where all $h_{\alpha} \in H$ and $o_{\alpha} \in O(K)$ then $\sigma_{H}(u)=\sum_{\alpha} h_{\alpha} \otimes \sigma\left(o_{\alpha}\right)$. Or, if $X$ is a linear operator on $L(H)_{O(K)}$ then $\sigma_{L(H)} X$ is also a linear operator such that

$$
\sigma_{L(H)} X\left(\sum_{\alpha} h_{\alpha} \otimes o_{\alpha}\right)=\sum_{\alpha} \sigma_{H}\left(X\left(h_{\alpha}\right)\right)\left(1 \otimes o_{\alpha}\right) .
$$

In addition, $\mathcal{X}:=X \cdot \sigma_{H}$ is a unique sigma linear operator such that $\left.\mathcal{X}\right|_{H}=\left.X\right|_{H}$, and we have the following identity $\sigma_{H} \cdot X=\sigma_{L H}(X) \cdot \sigma_{H}$. If there is no risk of confusion we will use just the notation $\sigma$.

Remark 2.1. Originally we developed in [2] the contravariant version of the nilpotent Artin-Schreier theory, cf. the discussion in [5]. The contravariant version uses similar relations $\sigma_{L(H)}(f)=f \circ e$ and the map $l_{H}$ was defined via $\tau \mapsto\left(\mathrm{id}_{L(H)} \otimes \tau\right) f \circ(-f)$. In this case $l_{H}$ determines the group homomorphism from $\Gamma_{K}$ to the opposite group $G^{0}(L(H))$ (this group is isomorphic to $G(L(H))$ via the map $g \mapsto$ $\left.g^{-1}\right)$. The results from the papers [1, 2, 3] were obtained in terms of the contravariant version, but the results from [7, 8, 9, 10] used the covariant version. We can easily switch from one theory to another via the automorphism $-\mathrm{id}_{L(H)}$.

We consider $O_{\text {sep }}$ as a left $\Gamma_{K}$-module via the action $o \mapsto \tau(o)$ with $o \in O_{\text {sep }}$ and $\tau \in \Gamma_{K}$. This corresponds to our earlier agreement about the left action of the elements of $\Gamma_{K}$ as endomoprhisms of $O_{s e p}$. As a result we obtain the left $\Gamma_{K}$-module structure on $H_{O_{\text {sep }}}$ by the use of the (left) action of $\Gamma_{K}$ on $H$ via $h \mapsto l_{H}(\tau)(h)$.

Because $L(H)_{O_{\text {sep }}} \subset \operatorname{End}_{O_{\text {sep }}}\left(H_{O_{\text {sep }}}\right)$ we can introduce for any $h \in H$, $\mathcal{F}(h):=\exp (-f)(h) \in H_{O_{\text {sep }}}$.
Proposition 2.1. For any $h \in H, \mathcal{F}(h) \in\left(H_{O_{s e p}}\right)^{\Gamma_{K}}$.
Proof. Suppose $f=\sum_{\alpha} l_{\alpha} \otimes o_{\alpha}$, where all $l_{\alpha} \in L(H)$ and $o_{\alpha} \in O_{\text {sep }}$.

If $\tau \in \Gamma_{K}$ then

$$
\begin{gathered}
\tau(\mathcal{F}(h))=\left(\tau \otimes \operatorname{id}_{O_{\text {sep }}}\right)\left(\exp \left(-\sum_{\alpha} l_{\alpha} \otimes \tau\left(o_{\alpha}\right)\right)(h)\right)= \\
\left(\tau \otimes \operatorname{id}_{O_{\text {sep }}}\right)\left(\exp \left(\left(\operatorname{id}_{L(H)} \otimes \tau\right)(-f)\right)(h)\right)= \\
\left(\tau \otimes \operatorname{id}_{O_{\text {sep }}}\right)\left(\exp \left(\left(-l_{H}(\tau)\right) \circ(-f)\right)(h)\right)= \\
\left(\tau \otimes \operatorname{id}_{O_{s e p}}\right)\left(\left(\exp \left(-l_{H}(\tau)\right) \cdot \exp (-f)\right) h\right)= \\
\left(\tau \otimes \operatorname{id}_{O_{s e p}}\right)\left(\pi_{H}\left(\tau^{-1}\right) \otimes \operatorname{id}_{O_{s e p}}\right) \mathcal{F}(h)= \\
=\left(\tau \cdot \pi_{H}\left(\tau^{-1}\right) \otimes \operatorname{id}_{O_{s e p}}\right) \mathcal{F}(h)=\mathcal{F}(h)
\end{gathered}
$$

The elements $e$ and $f$ are not determined uniquely by $l_{H}$. A pair $e^{\prime} \in L(H)_{O(K)}$ and $f^{\prime} \in L(H)_{O_{\text {sep }}}$ give the same group epimorphism $l_{H}$ iff there is $x \in L(H)_{O(K)}$ such that $e^{\prime}=\sigma(x) \circ e \circ(-x)$ and $f^{\prime}=x \circ f$.
2.2. Special choice of $e \in L(H)_{O(K)}$. We can always assume (by replacing, if necessary, $K$ by its finite unramified extension) that a uniformiser $t$ in $K$ is such that $t^{e_{0}}=t_{0}$, where $e_{0}$ is the ramification index for $K / K_{0}$. Then $O(K)=\lim _{\overleftarrow{M}} W_{M}(k)((\bar{t}))$, where $\bar{t}^{e_{0}}=\bar{t}_{0}$ and $\bar{t}$ is the Teichmuller representative of $t$. We denote by $k$ the residue field of $K$ and fix a choice of $\alpha_{0}=\alpha(k) \in W(k)$ such that its trace in the field extension $W(k)[1 / p] / \mathbb{Q}_{p}$ equals 1 .

Let $\mathbb{Z}^{+}(p):=\{a \in \mathbb{N} \mid \operatorname{gcd}(a, p)=1\}$ and $\mathbb{Z}^{0}(p)=\mathbb{Z}^{+}(p) \cup\{0\}$.
Definition. An element $e \in L(H)_{O(K)}$ is SPECIAL if $e=\sum_{a \in \mathbb{Z}^{0}(p)} \bar{t}^{-a} l_{a 0}$, where $l_{00} \in \alpha_{0} L(H)$ and for all $a \in \mathbb{Z}^{+}(p), l_{a 0} \in L(H)_{W(k)}$.
Lemma 2.2. Suppose $e \in L(H)_{O(K)}$. Then there is $x \in L(H)_{O(K)}$ such that $\sigma(x) \circ e \circ(-x)$ is SPECIAL.

Proof. of $L$, Use induction on $s$ to prove lemma modulo the ideals of $s$-th commutators $C_{s}\left(L(H)_{O(K)}\right)$.

If $s=1$ there is nothing to prove.
Suppose lemma is proved modulo $C_{s}\left(L(H)_{O(K)}\right)$.
Then there is $x \in L(H)_{O(K)}$ such that

$$
\sigma(x) \circ e \circ(-x)=\sum_{a \in \mathbb{Z}^{0}(p)} \bar{t}^{-a} l_{a 0}+l,
$$

where $l \in C_{s}\left(L(H)_{O(K)}\right)$. Using that

$$
\begin{equation*}
O(K)=\left(\sigma-\operatorname{id}_{O(K)}\right) O(K) \oplus\left(\mathbb{Z}_{p} \alpha_{0}\right) \oplus\left(\sum_{a \in \mathbb{Z}^{+}(p)} W(k) \bar{t}^{-a}\right) \tag{2.1}
\end{equation*}
$$

we obtain the existence of $x_{s} \in C_{s}\left(L(H)_{O(K)}\right)$ such that

$$
l=\sigma\left(x_{s}\right)-x_{s}+\sum_{a \in \mathbb{Z}^{0}(p)} \bar{t}^{-a} l_{a},
$$

where $l_{0} \in \alpha_{0} L$ and all remaining $l_{a} \in L_{W(k)}$. Then we can take $x^{\prime}=x-x_{s}$ to obtain our statement modulo $C_{s+1}\left(L(H)_{O(K)}\right)$.

Lemma 2.3. Suppose $e \in L_{O(K)}$ is SPECIAL and $x \in L_{O(K)}$. Then the element $\sigma(x) \circ e \circ(-x)$ is SPECIAL iff $x \in L$ (or, equivalently, if $\sigma x=x)$.

Proof. Use relation cf. [12],

$$
\operatorname{Ad}(\exp (X)) \exp (Y)=\exp \left(\sum_{n \geqslant 0} \frac{1}{n!} \operatorname{ad}^{n}(X)(Y)\right) \bmod (\operatorname{deg} p),
$$

where $\operatorname{Ad}(U)(V)=U V U^{-1}$ and $\operatorname{ad}(U)(V)=[U, V]$. Indeed, if $X=$ $x \in L(H)$ and $Y=e$ then $\sum_{n \geqslant 0} \operatorname{ad}^{n}(x)(e) / n!$ is also special.

When proving the inverse statement we can use induction modulo the ideals $C_{s}(L(H))_{O(K)}, s \geqslant 1$, as follows.

Assume the lemma is proved modulo $C_{s}\left(L(H)_{O(K)}\right)$. Then using the IF part we can assume that $x \in C_{s}\left(L(H)_{O(K)}\right)$. Therefore, $e+\sigma(x)-x$ is special modulo $C_{s+1}(L(H))_{O(K)}$, i.e.

$$
\sigma(x)-x \in \alpha_{0} C_{s}(L)+\sum_{a \in \mathbb{Z}^{+}(p)} t^{-a} C_{s}(L)_{W(k)}
$$

modulo $C_{s+1}\left(L(H)_{O(K)}\right)$. By (2.1) this implies the congruence

$$
\sigma(x) \equiv x \bmod C_{s+1}(L(H))_{O(K)},
$$

i.e. $x \in C_{s}(L(H)) \bmod C_{s+1}\left(L(H)_{O(K)}\right)$.

The lemma is proved.
2.3. Construction of the $\phi$-module $M(H)$. Note that $\pi_{H}=\exp \left(l_{H}\right)$, and therefore for all $\tau \in \Gamma_{K}$, it holds

$$
\pi_{H}(\tau)=\exp (-f) \cdot \exp \left(\mathrm{id}_{L(H)} \otimes \tau\right) f
$$

where $f \in L(H)_{O_{\text {sep }}} \subset \operatorname{End}_{O_{\text {sep }}}\left(H_{O_{\text {sep }}}\right), \sigma_{L(H)}(f)=e \circ f$ and $\exp f \in$ $\operatorname{Aut}_{O_{\text {sep }}}\left(H_{O_{\text {sep }}}\right)$.

Let $\mathrm{MF}_{K}^{e t}$ be the category of etale $\phi$-modules over $O(K)$. Recall that its objects are $O(K)$-modules of finite type $M$ together with a $\sigma$-linear morphism $\phi: M \longrightarrow M$ such that its $O(K)$-linear extension $\phi_{O(K)}$ : $M \otimes_{O(K), \sigma} O(K) \longrightarrow M$ is isomorphism. The correspondence $H \mapsto$ $M(H):=\left(H \otimes_{\mathbb{Z}_{p}} O_{\text {sep }}\right)^{\Gamma_{K}}$, where $\phi: M(H) \longrightarrow M(H)$ comes from the action of $\sigma$ on $O_{\text {sep }}$, determines the equivalence of the categories $\mathrm{M} \Gamma_{K}$ and $\mathrm{MF}_{K}^{e t}$.

Consider the $\mathbb{Z}_{p}$-linear embedding $\mathcal{F}: H \longrightarrow H_{O_{\text {sep }}}$ from Sec.2.1. Let $M(H)=\mathcal{F}(H)_{O(K)}$. By extension of scalars we obtain natural isomorphisms (use that $O(K)$ and $O_{\text {sep }}$ are flat $\mathbb{Z}_{p}$-modules):

$$
\begin{gathered}
\mathcal{F} \otimes \mathrm{id}_{O_{\text {sep }}}: H_{O_{s e p}} \simeq M(H)_{O_{\text {sep }}} \\
\mathcal{F} \otimes \mathrm{id}_{O(K)}: H_{O(K)} \simeq M(H),
\end{gathered}
$$

which will be denoted for simplicity just by $\mathcal{F}$.
Note that by Prop. 2.1, $M(H)=\left(H_{O_{\text {sep }}}\right)^{\Gamma_{K}}$.
The $O(K)$-module $M(H)$ is provided with the $\sigma$-linear morphism $\phi: M(H) \longrightarrow M(H)$ uniquely determined for all $h \in H$ via
$\phi(\mathcal{F}(h))=\exp \left(-\sigma_{L(H)} f\right)(h)=(\exp (-f) \cdot \exp (-e))(h)=\mathcal{F}(\exp (-e)(h))$.
Consider the $O(K)$-linear operator

$$
A:=\exp (-e) \in \exp \left(L(H)_{O(K)}\right) \subset \operatorname{Aut}_{O(K)} H_{O(K)}
$$

Then $\mathcal{A}:=A \cdot \sigma_{H}$ will be a unique $\sigma$-linear operator on $L(H)_{O(K)}$ such that $\left.\mathcal{A}\right|_{H}=\left.A\right|_{H}$. Clearly, for any $u \in H_{O(K)}$,

$$
\phi(\mathcal{F}(u))=\mathcal{F}(\mathcal{A}(u)),
$$

and $M(H)$ is etale $\phi$-module associated with the $\mathbb{Z}_{p}\left[\Gamma_{K}\right]$-module $H$.
For example, suppose $p H=0$ and $\left\{h_{i} \mid 1 \leqslant i \leqslant N\right\}$ is $\mathbb{F}_{p}$-basis of $H$. Then $\left\{\mathcal{F}\left(h_{i}\right) \mid 1 \leqslant i \leqslant N\right\}$ is a $K$-basis for $M(H)$. If $A\left(h_{i}\right)=$ $\exp (-e)\left(h_{i}\right)=\sum_{j} a_{i j} h_{j}$ with all $a_{i j} \in K$ then $\phi\left(\mathcal{F}\left(h_{i}\right)\right)=\sum_{j} a_{i j} \mathcal{F}\left(h_{j}\right)$, and $\left(\left(a_{i j}\right)\right)$ appears as the corresponding "Frobenius matrix".

It can be easily seen also that if $\left\{h_{i} \mid 1 \leqslant i \leqslant N\right\}$ is a minimal system of $\mathbb{Z}_{p}$-generators in $H$ then $\left\{\mathcal{F}\left(h_{i}\right) \mid 1 \leqslant i \leqslant N\right\}$ is a minimal system of $O(K)$-generators in $M(H)$.
2.4. The connection $\nabla$ on $M(H)$. The $(\phi, O(K))$-module $M(H)$ can be provided with a connection $\nabla: M(H) \longrightarrow M(H) \otimes_{O(K)} \Omega_{O(K)}^{1}$, [14]. This is an additive map uniquely determined by the properties:
a) for any $o \in O(K)$ and $m \in M(H), \nabla(m o)=\nabla(m) o+m \otimes d(o)$;
b) $\nabla \cdot \phi=(\phi \otimes \phi) \cdot \nabla$.

By a), $\nabla$ is uniquely determined by its restriction to $\mathcal{F}(H)$ (use that $\left.M(H)=\mathcal{F}(H)_{O(K)}\right)$. Let $\widetilde{B}$ be a unique $O(K)$-linear operator on $M(H)$ such that for any $m \in \mathcal{F}(H), \nabla(m)=\widetilde{B}(m) d \bar{t} / \bar{t}$. Consider the $O(K)$-linear operator $B \in \operatorname{End} H_{O(K)}$ such that for all $u \in H_{O(K)}$, $\widetilde{B}(\mathcal{F}(u))=\mathcal{F}(B(u))$. Obviously, $\widetilde{B}$ and $B$ can be recovered one from another.

Note that for any $\mathbb{Z}_{p}$-module $\mathcal{C}$, the elements $c \in \mathcal{C}_{O(K)}$ appear uniquely in the form $c=\sum_{n} c_{n} \otimes \bar{t}^{n}$ with all $c_{n} \in \mathcal{C}_{W(k)}$. Therefore, the map $\operatorname{id}_{\mathcal{C}} \otimes \partial_{\bar{t}}: \mathcal{C}_{O(K)} \longrightarrow \mathcal{C}_{O(K)}$ such that $c \mapsto \sum_{n} c_{n} \otimes n \bar{t}^{n}$ is well-defined. If $\mathcal{C} \subset \mathcal{C}_{1}$ is an embedding of $\mathbb{Z}_{p}$-modules then we have $\left.\left(\mathrm{id}_{\mathcal{C}_{1}} \otimes \partial_{\bar{t}}\right)\right|_{\mathcal{O}_{(K)}}=\mathrm{id}_{\mathcal{C}} \otimes \partial_{\bar{t}}$.

With the above notation:

1) for all $m \in M(H), \nabla(m)=\left(\widetilde{B}+\operatorname{id}_{\mathcal{F}(H)} \otimes \partial_{\bar{t}}\right)(m) d \bar{t} / \bar{t}$.
2) for all $u \in H_{O(K)}$ and $X \in \operatorname{End} H_{O(K)}$,

$$
\left(\operatorname{id}_{H} \otimes \partial_{\bar{t}}\right)(X(u))=\left(\operatorname{id}_{\operatorname{End} H} \otimes \partial_{\bar{t}}\right)(X)(u)+X\left(\left(\operatorname{id}_{H} \otimes \partial_{\bar{t}}\right) u\right) .
$$

Proposition 2.4. Let $C=-\left(\operatorname{id}_{\mathrm{End} H} \otimes \partial_{\bar{t}}\right) A \cdot A^{-1}$ and let for any $n \geqslant 1$, $D^{(n)}=A \cdot \sigma_{\operatorname{End} H}(A) \cdot \ldots \cdot \sigma_{\operatorname{End} H}^{n-1}(A)$. Then

$$
B=\sum_{n \geqslant 0} p^{n} \operatorname{Ad}\left(D^{(n)}\right) \sigma_{\operatorname{End} H}^{n}(C) .
$$

Remark 2.2. In Sect.4 we will prove that $C, B \in L(H)_{O(K)} \subset \operatorname{End} H_{O(K)}$. In particular, $\sigma_{\operatorname{End} H} C=\sigma_{L(H)} C$ and the correspondence $u \mapsto(B+$ $\left.\mathrm{id}_{L(H)} \otimes \partial_{\bar{t}}\right)(u) d \bar{t} / \bar{t}$ gives a connection on $L(H)_{O(K)}$.
Proof. Indeed, for any $u \in H_{O(K)}$, it holds

$$
\begin{aligned}
(\nabla \cdot \phi)(\mathcal{F}(u)) & =(\nabla \cdot \mathcal{F} \cdot \mathcal{A}) u=\left(\left(\widetilde{B}+\operatorname{id}_{\mathcal{F}(H)} \otimes \partial_{\bar{t}}\right) \cdot \mathcal{F} \cdot \mathcal{A}\right)(u) d \bar{t} / \bar{t} \\
& =\left(\mathcal{F} \cdot\left(B+\operatorname{id}_{H} \otimes \partial_{\bar{t}}\right) \cdot \mathcal{A}\right)(u) d \bar{t} / \bar{t}
\end{aligned}
$$

On the other hand, $(\phi \otimes \phi)(\nabla(\mathcal{F}(u)))=$

$$
\phi\left(\mathcal{F}\left(B+\operatorname{id}_{H} \otimes \partial_{\bar{t}}\right) u\right) \phi(d \bar{t} / \bar{t})=p\left(\mathcal{F} \cdot \mathcal{A} \cdot\left(B+\mathrm{id}_{H} \otimes \partial_{\bar{t}}\right)\right)(u) d \bar{t} / \bar{t}
$$

Equivalently, we have the following identity on $H_{O(K)}$,

$$
\left(B \cdot A+\left(\operatorname{id}_{H} \otimes \partial_{\bar{t}}\right) \cdot A\right) \cdot \sigma_{H}=p A \cdot \sigma_{H} \cdot\left(B+\operatorname{id}_{H} \otimes \partial_{\bar{t}}\right)
$$

Rewrite this equality as follows
$\left(B \cdot A-p A \cdot \sigma_{\operatorname{End} H}(B)\right) \cdot \sigma_{H}=\left(-\left(\operatorname{id}_{H} \otimes \partial_{\bar{t}}\right) \cdot A+A \cdot \sigma_{H} \cdot\left(\operatorname{id}_{H} \otimes p \partial_{\bar{t}}\right) \cdot \sigma_{H}^{-1}\right) \cdot \sigma_{H}$.
Notice that that on $H_{O(K)}$ we have $\sigma_{H} \cdot\left(\operatorname{id}_{H} \otimes p \partial_{\bar{t}}\right) \cdot \sigma_{H}^{-1}=\operatorname{id}_{H} \otimes \partial_{\bar{t}}$.
As a result, the right hand side equals $-\left(\mathrm{id}_{\mathrm{End} H} \otimes \partial_{\bar{t}}\right)(A) \cdot \sigma_{H}$.
From $\left.\sigma_{H}\right|_{H}=\operatorname{id}_{H}$ it follows that by restriction on $H$ we have

$$
B \cdot A-p A \cdot \sigma_{\operatorname{End} H}(B)=-\left(\operatorname{id}_{\mathrm{End} H} \otimes \partial_{\bar{t}}\right) A .
$$

By $O(K)$-linearity this identity holds on the whole $H_{O(K)}$.
As a result, our identity appears in the form

$$
\left(\operatorname{id}_{H}-p \operatorname{Ad}(A) \cdot \sigma_{\operatorname{End} H}\right) B=-\left(\operatorname{id}_{H} \otimes \partial_{\bar{t}}\right)(A) \cdot A^{-1}
$$

It remains to recover $B$ using that

$$
\left(\operatorname{id}_{H}-p \operatorname{Ad} A \cdot \sigma_{\operatorname{End} H}\right)^{-1}=\sum_{n \geqslant 0} p^{n} \operatorname{Ad}\left(D^{(n)}\right) \cdot \sigma_{\mathrm{End} H}^{n} .
$$

## 3. Ramification filtration modulo $p$-Th Commutators

Recall that $K=k((t)) \subset K_{0}^{t r}, \pi_{H}\left(\Gamma_{K}\right)=\exp (L(H))=I(H) \subset$ Aut $_{\mathbb{Z}_{p}}(H)$. Note also that $O(K)=W(k)((\bar{t}))$, where $\bar{t}^{e_{0}}=\bar{t}_{0}$ and $e_{0}$ is the ramification index of $K / K_{0}$.
3.1. Lie algebra $\mathcal{L}$ and identification $\eta_{<p}$. Let $K_{<p}$ be the maximal $p$-extension of $K$ in $K_{0}^{\text {sep }}$ with the Galois group of nilpotent class $<p$. Then $\mathcal{G}_{<p}:=\operatorname{Gal}\left(K_{<p} / K\right)={\underset{M}{M}}_{\lim } \Gamma_{K} / \Gamma_{K}^{p^{M}} C_{p}\left(\Gamma_{K}\right)$.

Let $\widetilde{\mathcal{L}}_{W(k)}$ be a profinite free Lie $W(k)$-algebra with the set of topological generators $\left\{D_{0}\right\} \cup\left\{D_{a n} \mid a \in \mathbb{Z}^{+}(p), n \in \mathbb{Z} / N_{0}\right\}$. Let $\mathcal{L}_{W(k)}=$ $\widetilde{\mathcal{L}}_{W(k)} / C_{p}\left(\widetilde{\mathcal{L}}_{W(k)}\right)$, where $C_{p}\left(\widetilde{\mathcal{L}}_{W(k)}\right)$ is the ideal of $p$-th commutators. Define the $\sigma$-linear action on $\mathcal{L}_{W(k)}$ via $D_{a n} \mapsto D_{a, n+1}$ and $D_{0} \mapsto D_{0}$, denote this action by the same symbol $\sigma$, and set $\mathcal{L}=\left.\mathcal{L}_{W(k)}\right|_{\sigma=i d}$.

Fix $\alpha_{0}=\alpha_{0}(k) \in W(k)$ such that the trace of $\alpha_{0}$ in the field extension $W(k)[1 / p] / \mathbb{Q}_{p}$ equals 1. For any $n \in \mathbb{Z} / N_{0}$, set $D_{0 n}=\left(\sigma^{n} \alpha_{0}\right) D_{0}$.

We are going to apply the profinite version of the covariant nilpotent Artin-Schreier theory to the Lie algebra $\mathcal{L}$ and the special element $e_{<p}=\sum_{a \in \mathbb{Z}^{0}(p)} \bar{t}^{-a} D_{a 0} \in \mathcal{L} \hat{\otimes} O(K)$. In other words, if we fix

$$
f_{<p} \in\left\{f \in \mathcal{L} \hat{\otimes} O_{s e p} \mid \sigma_{\mathcal{L}}(f)=e \circ f\right\} \neq \emptyset
$$

then the map $\eta_{<p}:=\pi_{f_{<p}}\left(e_{<p}\right)$ given by the correspondence $\tau \mapsto$ $\left(-f_{<p}\right) \circ\left(\mathrm{id}_{\mathcal{L}} \otimes \tau\right) f_{<p}$ induces the group isomorphism $\bar{\eta}_{<p}: \Gamma_{<p} \simeq G(\mathcal{L})$.

The following property is an easy consequence of the above construction.

Proposition 3.1. Suppose $e \in L(H)_{O(K)}$ is special and given with notation from the definition from Sect. 2.2. Then the map $\log \pi_{H}$ : $\mathcal{G}_{<p} \longrightarrow G(L(H))$ is given via the correspondences $D_{a 0} \mapsto l_{a 0}$ (and $\left.D_{a n} \mapsto \sigma_{L(H)}^{n}\left(l_{a 0}\right)\right)$ for all $a \in \mathbb{Z}^{0}(p)$.
3.2. The ramification ideals $\mathcal{L}^{(v)}$. For $v \geqslant 0$, denote by $\mathcal{G}_{<p}^{(v)}$ the image of $\Gamma_{K}^{(v)}$ in $\mathcal{G}_{<p}$. Then $\bar{\eta}_{<p}\left(\mathcal{G}_{<p}^{(v)}\right)=G\left(\mathcal{L}^{(v)}\right)$, where $\mathcal{L}^{(v)}$ is an ideal in $\mathcal{L}$. The images $\mathcal{L}^{(v)}(M)$ of the ideals $\mathcal{L}^{(v)}$ in the quotients $\mathcal{L} / p^{M} \mathcal{L}$ for all $M \in \mathbb{N}$ were explicitly described in [3]. By going to the projective limit on $M$ this description can be presented as follows.

Definition. Let $\bar{n}=\left(n_{1}, \ldots, n_{s}\right)$ with $s \geqslant 1$. Suppose there is a partition $0=i_{0}<i_{1}<\cdots<i_{r}=s$ such that for $i_{j}<u \leqslant i_{j+1}$, it holds $n_{u}=m_{j+1}$ and $m_{1}>m_{2}>\cdots>m_{r}$. Then set

$$
\eta(\bar{n})=\frac{1}{\left(i_{1}-i_{0}\right)!\ldots\left(i_{r}-i_{r-1}\right)!}
$$

If such a partition does not exist we set $\eta(\bar{n})=0$.
For $s \in \mathbb{N}, \bar{a}=\left(a_{1}, \ldots, a_{s}\right) \in \mathbb{Z}^{0}(p)^{s}$ and $\bar{n}=\left(n_{1}, \ldots, n_{s}\right) \in \mathbb{Z}^{s}$, set

$$
\left[D_{\bar{a}, \bar{n}}\right]=\left[\ldots\left[D_{a_{1} n_{1}}, D_{a_{2} n_{2}}\right], \ldots, D_{a_{s} n_{s}}\right] .
$$

For $\alpha \geqslant 0$ and $N \in \mathbb{Z}_{\geqslant 0}$, introduce $\mathcal{F}_{\alpha,-N}^{0} \in L_{W(k)}$ such that

$$
\mathcal{F}_{\alpha,-N}^{0}=\sum_{\substack{1 \leq s<p \\ \gamma(\bar{a}, \bar{n})=\alpha}} a_{1} \eta(\bar{n}) p^{n_{1}}\left[D_{\bar{a}, \bar{n}}\right] .
$$

Here $n_{1} \geqslant 0$, all $n_{i} \geqslant-N$ and $\gamma(\bar{a}, \bar{n})=a_{1} p^{n_{1}}+a_{2} p^{n_{2}}+\cdots+a_{s} p^{n_{s}}$.
Note that the non-zero terms in the above expression for $\mathcal{F}_{\alpha,-N}^{0}$ can appear only if $n_{1} \geqslant n_{2} \geqslant \ldots \geqslant n_{s}$ and $\alpha$ has at least one presentation in the form $\gamma(\bar{a}, \bar{n})$.

Denote by $\mathcal{I}^{(v)}[N]$ the minimal closed ideal in $\mathcal{L}$ such that its extension of scalars $\mathcal{I}^{(v)}[N]_{W(k)}$ contain all $\mathcal{F}_{\alpha,-N}^{0}$ with $\alpha \geqslant v$.

Our result from [3] about explicit generators of the ideal $\mathcal{L}^{(v)}$ can be stated in the following form.
Theorem 3.2. For any $v>0$ and $M \in \mathbb{N}$, there is $\tilde{N}(v, M) \in \mathbb{N}$ such that if $N \geqslant \widetilde{N}(v, M)$, then the images of the ideals $\mathcal{L}^{(v)}$ and $\mathcal{I}^{(v)}[N]$ in $\mathcal{L} / p^{M}$ coincide.
3.3. Some relations. Let $A(\mathcal{L})$ be the enveloping algebra of $\mathcal{L}$ and $\widetilde{A}(\mathcal{L})=A(\mathcal{L}) / J(\mathcal{L})^{p}$, where $J(\mathcal{L})$ is the augmentation ideal in $A(\mathcal{L})$. Note that there is a natural embedding of $\mathbb{Z}_{p}$-modules $\mathcal{L} \subset \widetilde{A}(\mathcal{L})$.

Let $A_{<p}=\exp \left(-e_{<p}\right) \in \widetilde{A}(\mathcal{L})_{O(K)}$ and $C_{<p}=-\left(\mathrm{id}_{\widetilde{A}(\mathcal{L})} \otimes \partial_{\bar{t}}\right) A_{<p} \cdot A_{<p}^{-1}$.
For $s \geqslant 1$, set $\overline{0}_{s}=(\underbrace{0, \ldots, 0}_{s \text { times }})$.
Proposition 3.3. Let $D_{<p}^{(m)}:=A_{<p} \cdot \sigma_{\widetilde{A}(\mathcal{L})}\left(A_{<p}\right) \cdot \ldots \cdot \sigma_{\widetilde{A}(\mathcal{L})}^{m-1}\left(A_{<p}\right)$, where $m \geqslant 1$. Then we have the following relations:

$$
\begin{gather*}
C_{<p}=\sum_{s \geqslant 1, \bar{a}} a_{1} \eta\left(\overline{0}_{s}\right)\left[D_{\bar{a}, \overline{0}_{s}} \bar{t}^{-\gamma\left(\bar{a}, \overline{0}_{s}\right)} ;\right.  \tag{3.1}\\
B_{<p}:=\sum_{n \geqslant 0} p^{n} \operatorname{Ad}\left(D_{<p}^{(n)}\right)\left(\sigma_{\mathcal{L}}^{n}\left(C_{<p}\right)\right)=\sum_{\alpha>0} \mathcal{F}_{\alpha, 0}^{0} \bar{t}^{-\alpha} ;  \tag{3.2}\\
\operatorname{Ad} \sigma_{\widetilde{A}(\mathcal{L})}^{-m}\left(D_{<p}^{(m)}\right)\left(B_{<p}\right)=\sum_{\alpha>0} \mathcal{F}_{\alpha,-m}^{0} \bar{t}^{-\alpha} . \tag{3.3}
\end{gather*}
$$

Proof. For (3.1) use, cf. [12], theorem 4.22, to obtain

$$
d \exp \left(-e_{<p}\right) \cdot \exp \left(e_{<p}\right)=\sum_{k \geqslant 1} \frac{1}{k!}\left(-\operatorname{ad} e_{<p}\right)^{k-1}\left(-d e_{<p}\right)
$$

and note that $\left(-\operatorname{ad} e_{<p}\right)^{k-1}\left(d e_{<p}\right)=$

$$
(-1)^{k-1}[\underbrace{e_{<p}, \cdots,\left[e_{<p}\right.}_{k-1 \text { times }}, d e_{<p}] \ldots]=[\ldots[d e_{<p}, \underbrace{\left.e_{<p}\right], \ldots, e_{<p}}_{k-1 \text { times }}]
$$

For (3.2) we need the following relation cf. [12], Sect.4.4

$$
\exp (X) \cdot Y \cdot \exp (-X)=\sum_{n \geqslant 0} \frac{1}{n!} \operatorname{ad}^{n}(X)(Y)
$$

After applying this relation to the summand with $m=1$ we obtain

$$
\begin{gathered}
p \operatorname{Ad} D_{<p}^{(1)}\left(\sigma_{\mathcal{L}} C_{<p}\right)=\exp \left(-e_{<p}\right) \cdot \sigma_{\mathcal{L}}\left(C_{<p}\right) \cdot \exp \left(e_{<p}\right)= \\
=\sum_{s \geqslant 0} \eta\left(\overline{0}_{s}\right)(-1)^{s} \operatorname{ad}^{s}\left(e_{<p}\right)\left(C_{<p}\right)= \\
\sum_{\bar{n} \geqslant 0, \bar{a}} \sum_{n_{1}=0}^{n_{1}=1} \eta(\bar{n}) p^{n_{1}}\left[D_{\bar{a}, \bar{n}}\right] \bar{t}-\gamma(\bar{a}, \bar{n})
\end{gathered}
$$

Repeating this procedure we obtain relation (3.2).
Similar calculations prove the remaining item (3.3).

## 4. Proof of Theorem 1.1

Recall briefly what we've already achieved.
The field $K=k((t))$ is tamely ramified extension of $K_{0}=k_{0}\left(\left(t_{0}\right)\right)$, where $t^{e_{0}}=t_{0}, H:=\left.H_{0}\right|_{\Gamma_{K}}$ and the corresponding group epimorphism $\pi_{H}: \Gamma_{K} \longrightarrow I(H) \subset$ Aut $_{\mathbb{Z}_{p}} H$ is such that $I(H)=\exp (L(H))$, where $L(H) \subset \operatorname{End}_{\mathbb{Z}_{p}} H$ and $L(H)^{p}=0$.

Applying formalism of nilpotent Artin-Schreier theory we obtained a special $e=\sum_{a \in \mathbb{Z}^{0}(p)} \bar{t}^{-a} l_{a 0} \in L(H)_{O(K)}$ and $f \in L(H)_{O_{\text {sep }}}$ such that

$$
\exp \left(\sigma_{L(H)} f\right)=\exp (e) \cdot \exp (f)
$$

and for any $\tau \in \Gamma_{K}, \pi_{H}(\tau)=\exp (-f) \cdot \exp \left(\mathrm{id}_{L(H)} \otimes \tau\right) f$.
We used $O(K)$-linear operator $\mathcal{F}=\exp (-f)$ to introduce $O(K)$ module $M(H):=\mathcal{F}\left(H_{O(K)}\right)$. Let $A=\exp (-e)$ and let $\mathcal{A}$ be a unique $\sigma$ linear operator on $H_{O(K)}$ such that for any $h \in H, \mathcal{A}(h)=A(h)$. Then the $\sigma$-linear $\phi: M(H) \longrightarrow M(H)$ is such that for any $u \in L(H)_{O(K)}$, $\phi(\mathcal{F}(u))=\mathcal{F}(\mathcal{A}(u))$. As a result, we obtain the structure of etale ( $\phi, O(K)$ )-module on $M(H)$ related to the $\Gamma_{K}$-module $H$.
Let $\nabla$ be the connection on $M(H)$ from Sect.2.4, and let $\widetilde{B}$ be the $O(K)$-linear operator on $M(\underset{\sim}{H})$ uniquely determined by the condition: for any $m \in \mathcal{F}(H), \nabla(m)=\widetilde{B}(m) d \bar{t} / \bar{t}$. Then for any $u \in M(H)$,

$$
\nabla(u)=\left(\widetilde{B}+\operatorname{id}_{\mathcal{F}(H)} \otimes \partial_{\bar{t}}\right)(u) d \bar{t} / \bar{t}
$$

and we introduce the differential forms

$$
\widetilde{\Omega}[N]=\phi^{N} \widetilde{B} \phi^{-N} d \bar{t} / \bar{t} \in \operatorname{End} M(H)_{O\left(K^{r a d}\right)} \otimes \Omega_{O(K)}^{1}
$$

Finally, define the $O(K)$-linear operator $B$ on $H$ by setting for any $u \in H_{O(K)}, \mathcal{F}(B(u))=\widetilde{B}(\mathcal{F}(u))$, and transfer $\widetilde{\Omega}[N]$ to $\operatorname{End} H_{O\left(K^{\text {rad })}\right.}$ in the following form

$$
\Omega[N]=\operatorname{Ad}\left(\mathcal{A}^{N}\right)(B) d \bar{t} / \bar{t} \in \operatorname{End}(H)_{O\left(K^{\text {rad }}\right)} \otimes_{O(K)} \Omega_{O(K)}^{1}
$$

Remark 4.1. Obviously we have the following identification

$$
\operatorname{End}(H)_{O\left(K^{\text {rad }}\right)} \otimes_{O(K)} \Omega_{O(K)}^{1}=\operatorname{End}\left(H_{0}\right)_{O\left(K_{0}^{\text {rad }}\right)} \otimes_{O\left(K_{0}\right)} \Omega_{O\left(K_{0}\right)}^{1}
$$

Recall that $\mathcal{A}=A \cdot \sigma_{H}$, where $A=\exp (-e)$.
Lemma 4.1. If $\mathcal{D}^{(N)}=\sigma_{\operatorname{End} H}^{-N}(A) \cdot \ldots \cdot \sigma_{\operatorname{End} H}^{-1}(A)$ then

$$
\left(\sigma_{\operatorname{End} H}^{-N} \cdot \operatorname{Ad}\left(\mathcal{A}^{N}\right)\right)(B)=\operatorname{Ad} \mathcal{D}^{(N)}(B),
$$

Proof. Use induction on $N \geqslant 0$. If $N=0$ there is nothing to prove. Suppose lemma is proved for $N \geqslant 0$. Then

$$
\begin{gathered}
\left(\sigma_{\operatorname{End} H}^{-(N+1)} \cdot \operatorname{Ad}\left(\mathcal{A}^{N+1}\right)\right)(B)=\sigma_{\operatorname{End} H}^{-(N+1)}\left(\mathcal{A} \cdot \operatorname{Ad}\left(\mathcal{A}^{N}\right)(B) \cdot \mathcal{A}^{-1}\right)= \\
\sigma_{\operatorname{End} H}^{-(N+1)}\left(\mathcal{A} \cdot\left(\sigma_{\operatorname{End} H}^{N} \cdot \operatorname{Ad}\left(\mathcal{D}^{(N)}\right)(B)\right) \cdot \mathcal{A}^{-1}\right)= \\
\sigma_{\operatorname{End} H}^{-(N+1)}\left(A \cdot \sigma_{H} \cdot\left(\sigma_{\operatorname{End} H}^{N} \operatorname{Ad}\left(\mathcal{D}^{(N)}\right)(B)\right) \cdot \sigma_{H}^{-1} \cdot A^{-1}\right)= \\
\sigma_{\operatorname{End} H}^{-(N+1)}\left(A \cdot\left(\sigma_{\operatorname{End} H}^{N+1} \operatorname{Ad}\left(\mathcal{D}^{(N)}\right)(B)\right) \cdot A^{-1}\right)= \\
\sigma_{\operatorname{End} H}^{-(N+1)}(A) \cdot \operatorname{Ad}\left(\mathcal{D}^{(N)}\right)(B) \cdot \sigma_{\operatorname{End} H}^{-(N+1)}\left(A^{-1}\right)=\operatorname{Ad}\left(\mathcal{D}^{(N+1)}\right)(B)
\end{gathered}
$$

The lemma is proved.
Under the projection $\log \bar{\pi}_{H}: \mathcal{G}_{<p} \longrightarrow G(L(H))$ we have:

$$
\begin{aligned}
& D_{a n} \mapsto l_{a n}=\sigma_{L(H)}^{n} l_{a 0}, e_{<p} \mapsto e, f_{<p} \mapsto f, A_{<p} \mapsto A, C_{<p} \mapsto C, \\
& B_{<p} \mapsto B \text { and } \sigma_{\tilde{\mathcal{A}}(\mathcal{L})}^{-m} D_{<p}^{(m)} \mapsto \mathcal{D}^{(m)} .
\end{aligned}
$$

Remark 4.2. Because $\log \bar{\pi}_{H}\left(\mathcal{L}_{<p}\right)=L(H)$ we obtain the statement from Remark 2.2.

As a result, our differential form appears as the image of $\sum \mathcal{F}_{\alpha,-N}^{0} \bar{t}^{-\alpha} d \bar{t} / \bar{t}$.

It remains to notice that when getting back to the field $K_{0}$, we have $d \bar{t} / \bar{t}=e_{0}^{-1} d \bar{t}_{0} / \bar{t}_{0}, \bar{t}^{-\alpha}=\bar{t}^{-\alpha / e_{0}}, \Gamma_{K}^{(\alpha)}=\Gamma_{K_{0}}^{\left(\alpha / e_{0}\right)}$ and $\left.\pi_{H}\right|_{\mathcal{I}}=\left.\pi_{H_{0}}\right|_{\mathcal{I}}$.

Theorem 1.1 is proved.
Remark 4.3. a) The conjugacy class of the differential form $\Omega[N]$ does not depend on a choice of a special form for $e$.
b) It would be very interesting to verify whether our results could be established in the case of $\Gamma_{K}$-modules which do not satisfy the Lie condition, e.g. for the $\Gamma_{K}$-module from [15] (the case $n=p$ in the notation of that paper).

## 5. Mixed characteristic

Let $E_{0}$ be a complete discrete valuation field of characteristic 0 with finite residue field $k_{0}$ of characteristic $p$. Let $\bar{E}_{0}$ be an algebraic closure of $E_{0}$ and for any field $E$ such that $E_{0} \subset E \subset \bar{E}_{0}$, set $\operatorname{Gal}\left(\bar{E}_{0} / E\right)=\Gamma_{E}$. Suppose that $E_{0}$ contains a primitive $p$-th root of unity $\zeta_{1}$.

We are going to develop an analog of the above characterisitc $p$ theory in the context of finite $\mathbb{F}_{p}\left[\Gamma_{E_{0}}\right]$-modules $H_{E_{0}}$ satisfying an analogue of the Lie condition from Sect.2.1:
if $\pi_{H_{E_{0}}}: \Gamma_{E_{0}} \longrightarrow \operatorname{Aut}_{\mathbb{F}_{p}}\left(H_{E_{0}}\right)$ determines a $\Gamma_{E_{0}}$-action on $H_{E_{0}}$ then there is a Lie $\mathbb{F}_{p}$-subalgebra $L\left(H_{E_{0}}\right) \subset \operatorname{End}_{\mathbb{F}_{p}}\left(H_{E_{0}}\right)$ such that $L\left(H_{E_{0}}\right)^{p}=$ 0 and $\exp \left(L\left(H_{E_{0}}\right)\right)=\pi_{H_{E_{0}}}(I)$, where $I$ is the wild ramification subgroup in $\Gamma_{E_{0}}$.

Remark 5.1. Contrary to the characteristic $p$ case we restrict ourselves to the Galois modules killed by $p$ because the theory from [7, 8] is developed recently only under that assumption.

Fix a choice of a uniformising element $\pi_{0}$ in $E_{0}$.
Let $\left.\widetilde{E}_{0}=E_{0}\left(\left\{\pi_{0}^{(n)}\right) \mid n \in \mathbb{Z}_{\geqslant 0}\right\}\right) \subset \bar{E}_{0}$, where $\pi_{0}^{(0)}=\pi_{0}$ and for all $n \in \mathbb{N}, \pi_{0}^{(n) p}=\pi_{0}^{(n-1)}$. The field-of-norms functor $X$ provides us with:

- a complete discrete valuation field $X\left(\widetilde{E}_{0}\right)=K_{0}$ of characteristic $p$ with residue field $k_{0}$ and a fixed uniformizer $t_{0}=\varliminf_{\swarrow} \pi_{n}^{(0)}$;
- an identification of $\Gamma_{K_{0}}=\operatorname{Gal}\left(K_{0}^{\text {sep }} / K_{0}\right)$ with $\Gamma_{\widetilde{E}_{0}} \subset \Gamma_{E_{0}}$.

Let $E$ be a finite tamely ramified extension of $E_{0}$ in $\bar{E}_{0}$ such that $\pi_{H_{E_{0}}}\left(\Gamma_{E}\right)=I\left(H_{0}\right)$. By replacing $E$ with a suitable finite unramified extension we can assume that $E$ has uniformiser $\pi$ such that $\pi^{e_{0}}=\pi_{0}$. Let $k$ be the residue field of $E$.
It is easy to see that the field $\widetilde{E}:=E \widetilde{E}_{0}$ appears in the form $E\left(\left\{\pi^{(n)} \mid n \geqslant 0\right\}\right)$, where $\pi^{(0)}=\pi, \pi^{(n) p}=\pi^{(n-1)}$ and for all $n$, $\pi^{(n) e_{0}}=\pi_{0}^{(n)}$. In particular, $K:=X(\widetilde{E})=k((t))$, where $t=\lim _{\rightleftharpoons} \pi^{(n)}$ is uniformiser such that $t^{e_{0}}=t_{0}$.

Let $\mathcal{G}_{<p}=\Gamma_{K} / \Gamma_{K}^{p} C_{p}\left(\Gamma_{K}\right)$ and $\Gamma_{<p}=\Gamma_{E} / \Gamma_{E}^{p} C_{p}\left(\Gamma_{E}\right)$. According to [7, 8] we have the following natural exact sequence

$$
\mathcal{G}_{<p} \longrightarrow \Gamma_{<p} \longrightarrow\left\langle\tau_{0}\right\rangle^{\mathbb{Z} / p} \longrightarrow 1
$$

where $\tau_{0} \in \operatorname{Gal}\left(E\left(\pi^{(1)}\right) / E\right)$ is such that $\tau_{0}\left(\pi^{(1)}\right)=\zeta_{1} \pi^{(1)}$. We can use the identification $\bar{\eta}_{<p}: \mathcal{G}_{<p} \simeq G(\mathcal{L})$ from Sec. 3.1 obtained via the special element $e_{<p}$ and the corresponding $f_{<p}$ such that $\sigma_{L(H)}\left(f_{<p}\right)=$ $e_{<p} \circ f_{<p}$.

Then we can use the equivalence of categories from Sec 1.3 to identify $\Gamma_{<p}$ with $G(L)$ where $L$ is a profinite Lie $\mathbb{F}_{p}$-algebra included into the following exact sequence

$$
\begin{equation*}
\mathcal{L} \longrightarrow L \longrightarrow \mathbb{F}_{p} \tau_{0} \longrightarrow 0 \tag{5.1}
\end{equation*}
$$

When studying the structure of (5.1) in [8] we proved that $\tau_{0}$ can be replaced by a suitable $h_{0} \in$ Aut $K$. More precisely, suppose

$$
\zeta_{1} \equiv 1+\sum_{j \geqslant 0}\left[\beta_{j}\right] \pi_{0}^{\left(e_{0}^{*} / p\right)+j} \bmod p
$$

with Teichmüller representatives $\left[\beta_{j}\right]$ of $\beta_{j} \in k$ and $e^{*}=e p /(p-1)$, where $e$ is the ramification index for $E / \mathbb{Q}_{p}$. Then $h_{0}$ can be defined as follows: $\left.h_{0}\right|_{k}=\mathrm{id}_{k}$ and

$$
h_{0}(t)=t\left(1+\sum_{j \geqslant 0} \beta_{j}^{p} t^{e^{*}+p j}\right)=\overparen{\operatorname{texp}}\left(\omega(t)^{p}\right),
$$

where $\widetilde{\exp }$ is the truncated exponential and $\omega(t) \in t^{e^{*} / p} k[[t]]^{*}$.
This allowed us to apply formalism of the nilpotent Artin-Schreier theory to specify "good" lifts $\tau_{<p}$ of $\tau_{0}$ to $L$ (what is equivalent to specifying "good lifts" $h_{<p}$ of $h_{0}$ ).

In particular, we obtained in [7, 8] the following description of the image $\bar{L} \subset L$ of $\mathcal{L}$ from exact sequence (5.1). Introduce the weight function wt on $\mathcal{L}_{k}$ by setting $\operatorname{wt}\left(D_{a n}\right)=s \in \mathbb{N}$ iff $(s-1) e^{*} \leqslant a<s e^{*}$. Then

$$
\operatorname{Ker}(\mathcal{L} \longrightarrow L)=\mathcal{L}(p)=\{l \in \mathcal{L} \mid \operatorname{wt}(l) \geqslant p\}
$$

$\bar{L}=\mathcal{L} / \mathcal{L}(p)$ and $\mathcal{L} \longrightarrow \bar{L}$ is the natural projection.
If $h_{<p}$ is a lift of $h_{0}$ to $K_{<p}$ then it is uniquely determined by $c=$ $c\left(h_{<p}\right) \in L_{K}$ such that

$$
\left(\operatorname{id}_{\mathcal{L}_{<p}} \otimes h_{<p}\right) f=c \circ\left(\operatorname{Ad}\left(h_{<p}\right) \otimes \operatorname{id}_{K_{<p}}\right) f .
$$

This allowed us to describe the corresponding action of the group $\left\langle h_{<p}\right\rangle^{\mathbb{Z} / p}$ on $f$ as an action of an infinitesimal group scheme of order $p$. The differential of this action is given by the "linear part" $c_{1} \in \bar{L}_{K}$ of $c$ which could be described by a suitable recurrent procedure. Finally, we proved that $c_{1}(0) \in \bar{L}_{k}\left(\right.$ where $c_{1}=\sum_{n \in \mathbb{Z}} c_{1}(n) t^{n}$ with all $\left.c_{1}(n) \in \bar{L}_{k}\right)$ is an absolute invariant of the lift $h_{<p}$.

Consider the expansion $\omega(t)^{p}=\sum_{j \geqslant 0} A_{j} t^{e^{*}+p j}, A_{j} \in k$.
Denote by $\bar{L}^{\left(e^{*}\right)} \subset \bar{L}$ the image of the ramification subgroup $\mathcal{L}^{\left(e^{*}\right)}$ in $L$, cf. (5.1). Then Theorem 5.1 from [8] states:

- the lift $\tau_{<p}$ of $\tau_{0}$ is "good" iff the value $c_{1}(0) \in \mathcal{L}_{k}$ of the differential $d \tau_{<p}$ at 0 satisfies the following congruence

$$
c_{1}(0) \equiv \sum_{j \geqslant 0} \sum_{i \geqslant 0} \sigma^{i}\left(A_{j} \mathcal{F}_{e^{*}+p j,-i}^{0}\right) \bmod \bar{L}_{k}^{\left(e^{*}\right)} .
$$

It remains to note that for $i, j \gg 0, \mathcal{F}_{e^{*}+p j,-i}^{0} \in \bar{L}_{k}^{\left(e^{*}\right)}$ and the right-hand double sum contains only finitely many non-zero terms modulo $\bar{L}_{k}^{\left(e^{*}\right)}$. It can be rewritten also in the following form

$$
\sum_{i, j \geqslant 0} \operatorname{Res}\left(\sigma^{i}\left(A_{j} t^{e^{*}+p j} \cdot \sigma^{-i} \Omega_{<p}[i]\right)\right),
$$

and the image of this expression in $L(H)_{k}$ equals

$$
\sum_{i \geqslant 0} \operatorname{Res}\left(\sigma^{i+1} \omega(t) \cdot \Omega[i]\right)
$$
