MODULARITY AND HEIGHTS OF CM CYCLES ON KUGA-SATO VARIETIES

ABSTRACT. We prove a higher weight general Gross-Zagier formula for CM cycles on Kuga-Sato varieties over the modular curve X(N). To formulate and prove this result, we prove the modularity of CM cycles, in the sense that the Hecke modules they generate are semisimple whose irreducible components are associated to higher weight holomorphic cuspidal automorphic representations of $\operatorname{GL}_{2,\mathbb{Q}}$. The higher weight general Gross-Zagier formula is proved using arithmetic relative trace formulas. The proof of the modularity of CM cycles is inspired by arithmetic theta lifting.

1. INTRODUCTION

1.1. Gross-Zagier formula and modularity. Let K be an imaginary quadratic field. On modular curves, there are explicit algebraic points representing elliptic curves with CM, i.e. complex multiplication, by K. In [10], Gross and Zagier established a remarkable formula which relates Néron-Tate heights of CM points on the modular curve $X_0(N)$ and central derivatives of quadratic base change L-functions associated to holomorphic modular forms of weight 2. The formula was proved under the Heegner condition on K and N, whence these CM points are called Heegner points.

For a holomorphic newform f of weight 2, let $J_0(N)_f$ be the f-isotypical component of the Jacobian of $X_0(N)$. For a degree-0 divisor P of Heegner points (modified by the cusp ∞), the Gross-Zagier formula says that its f-component $P_f \in J_0(N)_f$ has height

$$\langle P_f, P_f \rangle = c \cdot L'(f, K, 1)$$

for an explicit nonzero constant c. A key step in the proof is the following explicit "unramified modularity of generating series of heights": for Heegner points x, y, and the Hecke operator T_m with m prime to N, the Néron-Tate height pairing

$$\langle x - \infty, T_m(y - \infty) \rangle$$

is the m-th coefficient of an explicit holomorphic modular form of weight 2.

A Kuga-Sato varietiy over $X_0(N)$ is a self-product of the universal elliptic curve (up to the cusps). On a Kuga-Sato varietiy, one can define CM cycles over CM points, whose fibers are modified graphs of CM endomorphisms. In [32], S. Zhang proved a Gross-Zagier type formula for Heegner cycles on Kuga-Sato varieties over $X_0(N)$ and higher weight modular forms. S. Zhang followed Gross and Zagier's approach, and established analogous "unramified modularity of generating series of heights". A corollary of this result is the following "unramified modularity of Heegner cycles": the module over the unramified Hecke algebra generated by a Heegner cycle, modulo the kernel of the (unconditionally defined) Beilinson-Bloch height pairing with itself, is a direct sum of some unramified Hecke modules of modular forms. Indeed, the formulation of the higher weight Gross-Zagier formula requires this modularity of Heegner cycles.

In the weight 2 case, the Gross-Zagier formula was generalized by S. Zhang [33][34] to CM points on some quaternionic Shimura curves under certain local conditions. Later, Yuan, S. Zhang and W. Zhang [31] proved the general version of the Gross-Zagier formula over all quaternionic Shimura curves. Their approach is close to the original one of Gross and Zagier. A key new ingredient they employed is the "modularity of generating series of Hecke operators". In the setting of Gross and Zagier [10], it in particular implies that

$$\sum_{m=0}^{\infty} T_m q^m$$

is a modular form of weight 2, valued in Pic $(X_0(N)^2)$. Here T_0 is an explicit constant term.

The approach of Gross and Zagier has now been developed to the theory of arithmetic theta lifting by Kudla [15] et. al. An essential ingredient in this theory is the "modularity of generating series of special cycles" [30], which contains the "modularity of generating series of Hecke operators" as a special case. It is worth mentioning that recently Li and Liu [17][18] used arithmetic theta lifting to prove an analog of the Gross-Zagier formula for higher dimensional unitary Shimura varieties.

However, since the work of S. Zhang [32], no progress has been made on generalizing the higher weight Gross-Zagier formula. One may attempt to generalize the higher weight Gross-Zagier formula following the approach of Yuan, S. Zhang and W. Zhang [31]. There are two essential ingredients about "modularity" which are unknown. First, one needs the modularity of CM cycles generated by the full Hecke algebra (not just the unramified Hecke algebra), even merely to formulate the general higher weight Gross-Zagier formula. This modularity is also needed for several other purposes (see [31, 1.5.2, 1.5.3, 1.5.8, 1.5.10]). Second, one needs the "modularity of generating series of Hecke operators" on Kuga-Sato

varieties, which is key to this aproach. We remind the reader that the "full modularity of CM cycles" is not a direct consequence of the "modularity of generating series of Hecke operators". Besides the modularity ingredients, one also needs Hirzebruch-Zagier type computation of intersection numbers on the product of Kuga-Sato varieties (see [31, 1.5.7])

1.2. Our results. In this paper, we prove a higher weight analog of the general Gross-Zagier formula of Yuan, S. Zhang and W. Zhang [31] on Kuga-Sato varieties over the modular curve X(N).

To formulate this result, we need the following modularity of CM cycles. Let CM be the module over the full Hecke algebra generated by a CM cycle on a Kuga-Sato variety. Let \overline{CM} be the quotient of CMby the kernel of the Beilinson-Bloch height pairing on CM. We propose a modularity conjecture.

Conjecture 1.2.1 (Conjecture 2.3.2). As a module over the full Hecke algebra, \overline{CM} is semi-simple whose irreducible components are the Hecke modules associated to higher weight holomorphic cuspidal automorphic representations of $\operatorname{GL}_{2,\mathbb{O}}$ with trivial central character.

In fact, we allow twists of the CM cycle by characters, and Conjecture 1.2.1 changes accordingly.

Theorem 1.2.2 (Theorem 2.3.3). Conjecture 1.2.1 holds if we restrict \overline{CM} to the unramified Hecke algebra.

By the strong multiplicity one theorem, this theorem gives us a decomposition

$$\overline{CM} = \bigoplus_{\pi} \overline{CM}(\pi)$$

according to representations as in Conjecture 1.2.1. Thus we can refine Conjecture 1.2.1 to each component (see Conjecture 2.3.5).

Theorem 1.2.3 (Theorem 2.3.6). The refinement of Conjecture 1.2.1 holds for $\overline{CM}(\pi)$ if $L(1/2, \pi_K) = 0$.

Now we can state the higher weight general Gross-Zagier formula. Let $\overline{CM}[\pi]$ be the Hom space from the Hecke module associated to π to $\overline{CM}(\pi)$. This is the analog of the Mordell-Weil group of $J_0(N)_f$ generated by the Heegner divisor P, in the original setting of Gross and Zagier. In particular, there is a natural height pairing on $\overline{CM}[\pi]$. Assume the truth of the refinement of Conjecture 1.2.1 for $\overline{CM}(\pi)$ (in particular, if $L(1/2, \pi_K) = 0$). For $\phi \in \pi^{\infty}$ (the finite component of π), we can construct a point $l_{\phi} \in \overline{CM}[\pi]$. This is the analog of the point $P_f \in J_0(N)_f$.

Theorem 1.2.4 (Theorem 2.4.3). There is an explicit nonzero constant c such that

$$\langle l_{\phi}, l_{\varphi} \rangle = c \cdot L'(1/2, \pi_K) \alpha_{\pi^{\infty}}(\phi, \varphi).$$

Here is $\alpha_{\pi^{\infty}}(\phi,\varphi)$ the integral of the matrix coefficient of ϕ,φ along $\mathbb{A}_{K}^{\infty,\times}$.

We also prove some results relating $\overline{CM}(\pi)$ and $\overline{CM}[\pi]$ with the local root numbers, see 2.3 and 2.4.

1.3. **Our approach.** Instead of arithmetic theta lifting, we use the arithmetic variant of Jacquet's relative trace formula (RTF for short) method to prove the higher weight general Gross-Zagier formula. The key observation is the following: our results on modularity of CM cycles are enough for the application of the arithmetic RTF method. However, our strategy to the modularity results is in fact inspired by the arithmetic theta lifting in the work of Yuan, S. Zhang and W. Zhang [31].

The arithmetic RTF method was proposed by W. Zhang [36] to attack the arithmetic Gan-Gross-Prasad conjecture, which is an exact generalization of the Gross-Zagier formula to unitary Shimura varieties. Subsequently, the author used this method to prove the general Gross-Zagier formula over function fields [22].

1.4. Plan of proofs. Let H(f) be the height pairing of a CM cycle and its Hecke translation by a Schwartz function f on the adelic group of $\operatorname{GL}_{2,\mathbb{Q}}$.

Our arithmetic RTF approach toward the higher weight general Gross-Zagier formula largely follow our previous work over function fields [22]. The new ingredient is at the archimedean place. To compare the archimedean part of the "arithmetic relative trace" H(f) for $\operatorname{GL}_{2,\mathbb{Q}}$ and "arithmetic relative trace" for $\operatorname{GL}_{2,K}$, we truncate the Green function. The comparison involving the truncated Green function is similar to the one in [22]. The part of H(f) involving the remaining term of the Green function is the integral of a function on X(N) along $K^{\times} \setminus \mathbb{A}_{K}^{\infty,\times}$. The arithmetic RTF approach also works in the weight 2 case, where we use the analogs of the computations in [22] at finite places and the new ingredient at the infinite place. In W. Zhang's original setting [36] on the arithmetic Gan-Gross-Prasad conjecture, our new ingredient at the infinite place can also be applied to make the choice of the Green current more flexible.

The roles of the modularity results in the arithmetic RTF approach are as follows. The unramified modularity of the whole \overline{CM} is for the spectral decomposition of the arithmetic relative trace H(f). The full modularity is used to apply the theorem of Tunnell [25] and Saito [23] so that we only need to deal with some very nice f.

Now we explain the strategy to the modularity results. First, we compare the height pairing H(f) to the value of the Whittaker function at g = 1 of a mixed theta-Eisenstein series of $\operatorname{GL}_{2,\mathbb{Q}}$. Here $\operatorname{GL}_{2,\mathbb{Q}}$ should be considered as $\operatorname{GSp}_{2,\mathbb{Q}}$ in the theta lifting setting. The formation of the theta-Eisenstein series involves Schwartz functions on an adelic quadratic space, on which the Hecke algebra of $\operatorname{GL}_{2,\mathbb{Q}}$ acts. Here $\operatorname{GL}_{2,\mathbb{Q}}$ should be considered as a subgroup of the similitude orthogonal group of the quadratic space in the theta lifting. The above comparison is Hecke equivariant. Moreover, we must allow f to be all test functions, instead of the very nice test functions in [31]. Thus we need to do more local computations than [31]. Second, we use the modularity of the analytic side to prove our modularity results. This is the main technical part of the paper. In particular, we need the global results of Yuan, S. Zhang and W. Zhang [31] and Yuan, S. Zhang [29] from the weight 2 case to prove some local results used in the proof.

1.5. Generalization. We explain the reason to only work with Kuga-Sato varieties over modular curves, and outline some possible future works over quaternionic Shimura curves. In our comparison between H(f) and the value of the Whittaker function, we first impose some weak regularity condition on the test function f to avoid self-intersection. Then we reinterpret S. Zhang's comparison [32] to cover certain test functions without the regularity condition. Finally, we use the action by the adelic group of $\mathbb{A}_{K}^{\infty,\times}$ to generate all test functions. Our comparison under the regularity condition is local and can be generalized to Shimura curves with some more effort. However, there is no analog of S. Zhang's work for general Shimura curves yet. For Shimura curves over \mathbb{Q} , Wen [26] is working on the analog of S. Zhang's work. After Wen's work, we should be able to generalize our results to Shimura curves over \mathbb{Q} . We hope to return to Shimura curves over totally real fields in the future.

1.6. Structure of the paper. In Section 2, we first define Kuga-Sato varieties, Hecke operators and CM cycles. The we state our results in 2.3 and 2.4. In Section 3, we first review the arithmetic RTFs. Then we prove the higher weight general Gross-Zagier formula. In Section 4, we prove the modularity of CM cycles. This section is relatively long, and its structure is explained in the beginning of the section.

2. CM cycles on Kuga-Sato varieties

We first define Kuga-Sato varieties, Hecke operators and CM cycles. Then we state our theorems on the modularity of CM cycles, and on height pairings of CM cycles. Fix an integer $k \geq 2$ through out this paper.

2.1. Kuga-Sato varieties. Let N be the product of two relatively prime integers which are ≥ 3 , ξ_N a primitive N-th root of unity. Let X(N) be the compactification of the moduli space of elliptic curves over \mathbb{Q} -schemes, with full level N structure. Let X = X(N) if N is clear from the context. Let $E \to X$ be the universal semistable elliptic curve. Let Y = Y(N) be the canonical desingularization of E^{2k-2} , the (2k-2)-tuple product of E over X [32, 2.2].

2.1.1. Integral models. There is a morphism $\pi : \mathcal{E} \to \mathcal{X}$ of regular, flat, and projective $\mathbb{Z}[\xi_N]$ -schemes such that $\mathcal{X}_{\mathbb{Q}[\xi_N]} \simeq X_{\mathbb{Q}[\xi_N]}$ and \mathcal{E} is a semistable elliptic curve over \mathcal{X} whose generic fiber is $E_{\mathbb{Q}[\xi_N]}$ (see [32, Theorem 2.1.1]). Let \mathcal{Y} be the canonical desingularization of \mathcal{E}^{2k-2} over \mathcal{X} [32, 2.2].

For a finite extension F of $\mathbb{Q}[\xi_N]$, we construct regular proper models \mathcal{X}' and \mathcal{Y}' of X_F and Y_F over Spec \mathcal{O}_F as follows. Let \mathcal{X}' be the minimal desingularization of $\mathcal{X}_{\mathcal{O}_F}$. Let $\mathcal{E}' = \mathcal{E} \times_{\mathcal{X}} \mathcal{X}'$. The nonsmooth locus of $\mathcal{E}' \to \mathcal{X}'$ is supported at the cusps. Since a neighborhood of the cusps of \mathcal{X} is smooth over $\mathbb{Z}[\xi_N]$ [16, Theorem 8.6.8], the desingularization procedure in [32, 2.2] still applies to \mathcal{E}'^{2k-2} . The desingularization \mathcal{Y}' satisfies $\mathcal{Y}'_F \simeq Y_F$, and it comes with a natural morphism $\mathcal{Y}' \to \mathcal{Y}_{\mathcal{O}_F}$.

Remark 2.1.1. Let \mathcal{N} be a neighborhood of the cusps of \mathcal{X} which is smooth over $\mathbb{Z}[\xi_N]$. Then $\mathcal{X}'|_{\mathcal{N}} = \mathcal{N}_{\mathcal{O}_F}$ and $\mathcal{Y}'|_{\mathcal{N}} = (\mathcal{Y}|_{\mathcal{N}})_{\mathcal{O}_F}$.

2.1.2. Group and semi-group action. Let \mathbb{A} be the ring of adeles of \mathbb{Q} and \mathbb{A}^{∞} the ring of finite adeles. Let $\mathbb{G} \subset \operatorname{GL}_2(\mathbb{A}^{\infty})$ be the subset of elements with integral coefficients. Let $X(N)^{\circ}$ be the noncuspidal part of X(N) and $Y(N)^{\circ}$ its preimage in Y(N). Let

$$X_{\infty}^{\circ} := \varprojlim_{N} X(N)^{\circ}, \ Y_{\infty}^{\circ} := \varprojlim_{N} Y(N)^{\circ},$$

where the transition morphisms are finite flat. We define a left $GL_2(\mathbb{A}^{\infty})$ -action on X_{∞}° and a left \mathbb{G} -action on Y_{∞}° following Drinfeld [4, 5.D].

For $g \in \mathbb{G}$, g defines an endomorphism of $(\mathbb{Q}/\mathbb{Z})^2$. Let S be a \mathbb{Q} -scheme and A an elliptic curve over S together with an infinite level structure $\psi : (\mathbb{Q}/\mathbb{Z})^2 \to A(S)$, i.e. for every positive integer n, the restriction of ϕ to $\mathbb{Z}[\frac{1}{n}]$ is a (Drinfeld) $\Gamma(n)$ -structure [16, 3.1]. This gives an S-point of X_{∞}° . Let $H \subset A$ be the sum of $\psi(\alpha)$'s with α running over the kernel of the endomorphism g on $(\mathbb{Q}/\mathbb{Z})^2$, which is a subgroup scheme of A [16, Proposition 1.11.2]. Define ψ_1 so that the following diagram commutes:

$$\begin{array}{ccc} (\mathbb{Q}/\mathbb{Z})^2 & \stackrel{\psi}{\longrightarrow} A(S) & . \\ & & & \downarrow \\ g & & \downarrow \\ (\mathbb{Q}/\mathbb{Z})^2 & \stackrel{\psi_1}{\longrightarrow} A/H(S) \end{array}$$

Here the right vertical arrow is the natural quotient morphism.

Let E be the universal elliptic curve over X_{∞}° . Applying the above construction, we get a quotient elliptic curve E' over X_{∞}° with an infinite level structure, and a quotient map $E \to E'$ over X_{∞}° . The elliptic curve E' over X_{∞}° is the pullback of E via a morphism $X_{\infty}^{\circ} \to X_{\infty}^{\circ}$, which we define as the action of g on X_{∞}° . For $g \in \mathbb{G} \cap \mathbb{Q}^{\times}$, the action is trivial. Thus we have an action of $\operatorname{GL}_2(\mathbb{A}^{\infty})$ on X_{∞}° by letting \mathbb{Q}^{\times} act trivially.

Remark 2.1.2. The "right multiplication" on X_{∞}° by g in [31, 3.1.1], is our action of g^{-1} .

Since $Y_{\infty}^{\circ} = E^{2k-2}$, the composition the above morphisms $E \to E' \to E$ defines a morphism $g: Y_{\infty}^{\circ} \to Y_{\infty}^{\circ}$ for $g \in \mathbb{G}$.

2.1.3. Hecke action on cohomological Chow cycles. Let $\operatorname{Ch}^{k}(Y(N))$ be the spaces of codimension k Chow cycles of $Y(N)_{\overline{\mathbb{Q}}}$ with \mathbb{C} -coefficients. We define a right action of $\operatorname{GL}_{2}(\mathbb{A}^{\infty})$ on $\varinjlim_{N} \operatorname{Ch}^{k}(Y(N))$.

For given N and $g \in \operatorname{GL}_2(\mathbb{A}^{\infty})$, the above construction defines a morphism $g_{N',N}^{\prime,N} : Y(N')^{\circ} \to Y(N)^{\circ}$ for a large enough multiple N' of N. Let $\Gamma_{g_{N',N}}$ be the Zariski closure of the graph of $g_{N',N}$ in $Y(N') \times Y(N)$. For $z \in \operatorname{Ch}^k(Y(N))$, let $g^*z \in \operatorname{Ch}^k(Y(N'))$ be the pullback of z by $\Gamma_{g_{N',N}}$. The image of g^*z in $\varinjlim_N \operatorname{Ch}^k(Y(N))$ does not depend on the choice of N'. Define the natural right action of g on $\lim_N \operatorname{Ch}^k(Y(N))$ to be

$$R_q(z) := [\det(g)]^{-(k-1)}g^*z.$$

Here $[\det(g)]$ is the positive integer which generate the ideal of \mathbb{Z} corresponding to the ideal $\det(g)$. Then R_g is identity for $g \in \mathbb{G} \cap \mathbb{Q}^{\times}$. Let \mathbb{Q}^{\times} act trivially on $\varinjlim_N \operatorname{Ch}^k(Y(N))$. Thus we have a right action R of $\operatorname{GL}_2(\mathbb{A}^{\infty})$ on $\varinjlim_N \operatorname{Ch}^k(Y(N))$.

Let $\mathcal{S}(\mathrm{GL}_2(\mathbb{A}^{\infty}))$ be the space of Schwartz functions. The induced action of $f \in \mathcal{S}(\mathrm{GL}_2(\mathbb{A}^{\infty}))$ on $\varinjlim_N \mathrm{Ch}^k(Y(N))$ is

$$R_f := \int_{g \in \mathrm{GL}_2(\mathbb{A}^\infty)} f(g) R_g dg.$$

Remark 2.1.3. A more well-known definition of the Hecke action (in the unramified case) is as follows [32, p 122]. For $i \in \mathbb{Z}_{\geq 0}$, let A_{p^i} be the characteristic function of $\operatorname{GL}_2(\mathbb{Z}_p) \begin{bmatrix} p^i & 0 \\ 0 & 1 \end{bmatrix} \operatorname{GL}_2(\mathbb{Z}_p)$. For a positive integer n coprime to N, let $A_n = \bigotimes_{p|n} A_{p^{\operatorname{ord}_p n}}$. Let $Y(N, n)^\circ$ be the noncuspidal part of the Kuga-Sato variety of elliptic curves with the canonical full level N structure, and a subgroup of order n. Let Z° be the quotient of $Y(N, n)^\circ$ by the (2k-2)-tuple product of the subgroup of order n of the universal elliptic curve (and remember the full level N structure). Then we have natural morphisms

$$Y(N)^{\circ} \leftarrow Y(N,n)^{\circ} \to Z^{\circ} \to Y(N)^{\circ}$$

Let C be the pushforward of the fundamental cycle of $Y(N, n)^{\circ}$ to $Y(N) \times Y(N)$. Then up to the choice of the measure, the Hecke action $R(A_n)$ coincides with the pushforward by $n^{-(k-1)}C$.

Let ξ be a cusp form of $\mathrm{SL}_2(\mathbb{Z})$ of level N and weight 2k, and ϕ_{ξ} the associated cusp form of $\mathrm{GL}_{2,\mathbb{Q}}$ as in [7, (3.4)]. The pullback of ξ by $n^{-(k-1)}C$ [14, 1.11] and the usual Hecke action of A_n on ϕ_{ξ} are compatible [7, Lemma 3.7].

2.1.4. Hecke action on homological Chow cycles. Define a left action of $\operatorname{GL}_2(\mathbb{A}^{\infty})$ on $\varprojlim_N \operatorname{Ch}^k(Y(N))$ as follows. Let $g \in \mathbb{G}$ act on $\varprojlim_N \operatorname{Ch}^k(Y(N))$ by

$$L_g := [\det(g)]^{-(k-1)}g_*.$$

Then L_g is identity for $g \in \mathbb{G} \cap \mathbb{Q}^{\times}$. Let \mathbb{Q}^{\times} act trivially on $\varprojlim_N \operatorname{Ch}^k(Y(N))$. Thus we have a left action L of $\operatorname{GL}_2(\mathbb{A}^{\infty})$ on $\varprojlim_N \operatorname{Ch}^k(Y(N))$.

For $f \in \mathcal{S}(\mathrm{GL}_2(\mathbb{A}^\infty))$, we have the induced action L_f on $\lim_{N \to \infty} \mathrm{Ch}^k(Y(N))$.

2.1.5. Relation. Consider the natural inclusion

(2.1)
$$\iota: \varinjlim_{N} \operatorname{Ch}^{k}(Y(N)) \to \varprojlim_{N} \operatorname{Ch}^{k}(Y(N))$$
$$z = \{z_{N}\}_{N} \mapsto \{\operatorname{Vol}(U(N))z_{N}\}_{N}\}_{N}$$

Then the restriction of L_g via ι is $R_{g^{-1}}$.

2.2. CM cycles and height pairing.

2.2.1. *CM cycles.* Let K be an imaginary quadratic field with a fixed embedding to \mathbb{C} . For an elliptic curve E over an integral domain R of characteristic 0 with CM by K, define the CM cycle Z(E) of E as follows. Choose a positive integer D such that $\sqrt{-D} \in K$ and is an endomorphism of E (note that D depends on E). Let Γ be the graph of $\sqrt{-D}$. Let Γ_0 be the divisor

$$\Gamma - E \times \{0\} - D\{0\} \times E$$

of $E \times E$. Then Γ_0^{k-1} is a (k-1)-cycle of E^{2k-2} . Define the CM cycle of E to be

$$Z(E) = c \sum_{\sigma} \operatorname{sgn}(\sigma) \sigma^* \left(\Gamma_0^{k-1} \right),$$

where σ runs over the symmetric group of 2k - 2 elements which acts on E^{2k-2} naturally, and c is a positive constant such that the self intersection number of $Z(E)_{\text{Frac}R}$ in $E^{2k-2}_{\text{Frac}R}$ is $(-1)^{k-1}$. Then the Chow cycle of $Z(E)_{\text{Frac}R}$ does not depend on the choice of D (see [32, Proposition 2.4.1]).

Let $\operatorname{GL}(\mathbb{A}^{\infty})$ act on X_{∞}° as in 2.1.2. Fix an embedding $\mathbb{A}_{K}^{\times} \hookrightarrow \operatorname{GL}(\mathbb{A}^{\infty})$. Fix a CM point $P_{0} \in X_{\infty}^{\circ}(\overline{\mathbb{Q}})^{K^{\times}}$, which is defined over K^{ab} (see [31, 3.1.2]). For $g \in \operatorname{GL}_{2}(\mathbb{A}^{\infty})$, let P_{g} be the image of $g^{-1} \cdot P_{0} \in X_{\infty}$ to X(N) by $X_{\infty} \to X(N)$. Then P_{g} is defined over a finite extension F of $\mathbb{Q}[\xi_{N}]$. Let Z_{g} be the pushforward to $Y(N)_{F}$ of the CM cycle (of the fiber of $Y(N)_{F}$) at P_{g} . Then Z_{g} is cohomological trivial [32, 3.1].

2.2.2. Translation. Let $Z^k(Y(N))$ be the space of codimension k cycles of $Y(N)_{\overline{\mathbb{Q}}}$ with \mathbb{C} -coefficients. Let Ω be a character of $K^{\times} \setminus \mathbb{A}_K^{\times}$ trivial on K_{∞}^{\times} . Define

$$Z_{\Omega} := \int_{K^{\times} \backslash \mathbb{A}_{K}^{\infty,\times}} Z_{t} \Omega(t) dt,$$

where we endow $K^{\times} \setminus \mathbb{A}_{K}^{\infty,\times}$ with the Haar measure such that $\operatorname{Vol}(K^{\times} \setminus \mathbb{A}_{K}^{\infty,\times}) = 1$. As N varies, Z_{Ω} is compatible under pushforward. Thus we consider Z_{Ω} as an element in $\varprojlim_{N} Z^{k}(Y(N))$.

Let U(N) be the principal congruence subgroup of $\operatorname{GL}_2(\mathbb{A}^{\infty})$ corresponding to N. For $f \in \mathcal{S}(\operatorname{GL}_2(\mathbb{A}^{\infty}))$ right U-invariant, define the translation of z_{Ω} by f to be

$$Z_{\Omega,f} = \frac{1}{\operatorname{Vol}(U(N))} \int_{K^{\times} \setminus \mathbb{A}_{K}^{\infty,\times}} \int_{\operatorname{GL}_{2}(\mathbb{A}^{\infty})} f(g) Z_{tg} dg \Omega(t) dt$$

As N varies, $Z_{\Omega,f}$ is compatible under pullback. Thus we consider $Z_{\Omega,f}$ as an element in $\varinjlim_N Z^k(Y(N))$.

Now we interpret $Z_{\Omega,f}$ by Hecke action. For a cycle Z, let [Z] be its Chow cycle. Under (2.1), we have

(2.2)
$$[Z_{\Omega,f}] = \iota \left(L_{f^{\vee}}[Z_{\Omega}] \right).$$

where $f^{\vee}(g) = f(g^{-1})$.

The following relations will be useful later:

$$(2.3) R_q[Z_{\Omega,f}] = [Z_{\Omega,f^g}],$$

where $f^g(h) = f(hg^{-1})$, and

(2.4)
$$R_{f_1}[Z_{\Omega,f}] = [Z_{\Omega,f*f_1}],$$

where the convolution is

$$f * f_1(h) = \int_{g \in \operatorname{GL}_2(\mathbb{A}^\infty)} f(g) f_1(g^{-1}h) dg.$$

2.2.3. Galois formulation. Regarding Ω as a character of $\operatorname{Gal}(E^{ab}/E)$ via the class field theory, then

$$[Z_{\Omega}] := \int_{\operatorname{Gal}(E^{\operatorname{ab}}/E)} [Z_1]^{\tau} \Omega(\tau) d\tau,$$

and

$$[Z_{\Omega,f}] = \frac{1}{\operatorname{Vol}(U(N))} \int_{\operatorname{Gal}(E^{\operatorname{ab}}/E)} \int_{\operatorname{GL}_2(\mathbb{A}^\infty)} f(g) [Z_g]^{\tau} dg \Omega(\tau) d\tau,$$

where $\operatorname{Gal}(E^{\operatorname{ab}}/E)$ is endowed with the Haar measure such that $\operatorname{Vol}(\operatorname{Gal}(E^{\operatorname{ab}}/E)) = 1$.

2.2.4. Height pairing. Let F be a finite extension of $\mathbb{Q}[\xi_N]$. Let \mathcal{Y}' be the regular proper model of $Y(N)_F$ over $\operatorname{Spec}\mathcal{O}_F$ with the morphism to $\mathcal{Y}_{\mathcal{O}_F}$ as in 2.1.1. For a CM cycle Z_g defined over F, let \mathcal{Z}_g be the pushforward to $\mathcal{Y}_{\mathcal{O}_F}$ of the CM cycle (of the fiber of $\mathcal{Y}_{\mathcal{O}_F}$) at the Zariski closure of the CM point P_g in $\mathcal{X}_{\mathcal{O}_F}$. Let \mathcal{Z}'_g be the pullback of the Chow cycle of \mathcal{Z}_g to \mathcal{Y}' ([24, 3.1, Theorem 3]). Let Z_{g_1}, Z_{g_2} be two CM cycles defined over F. Then the restrictions of \mathcal{Z}'_{g_1} and \mathcal{Z}'_{g_2} to the irreducible

Let Z_{g_1}, Z_{g_2} be two CM cycles defined over F. Then the restrictions of \mathcal{Z}'_{g_1} and \mathcal{Z}'_{g_2} to the irreducible components of the special fibers are cohomological trivial [32, 3.1]. So the Beilinson-Bloch height pairing [1][3] is unconditionally defined, and given by an arithmetic intersection pairing [8]:

(2.5)
$$\langle Z_{g_1}, Z_{g_2} \rangle_{Y(N)} = \frac{1}{[F:\mathbb{Q}]} (-1)^k (\mathcal{Z}'_{g_1}, G_{g_1}) \cdot (\mathcal{Z}'_{g_2}, G_{g_2}).$$

Here G_{g_i} is the "admissible" Green current of Z_{g_i} in the sense of the first paragraph of [32, p 125]. Note that if we replace one of \mathcal{Z}'_{g_1} and \mathcal{Z}'_{g_2} by its horizontal part, we still get the same height pairing through the arithmetic intersection pairing.

By [1], the height pairing between CM cycles factors through their images in $\operatorname{Ch}^{k}(Y(N))$.

2.2.5. Vary the level. By the projection formula [1], the natural height pairing between cohomological and homological cycles

$$H(f) = \langle Z_{\Omega,f}, Z_{\Omega^{-1}} \rangle := \langle Z_{\Omega,f}, Z_{\Omega^{-1}} \rangle_{Y(N)}$$

does not depend on the choice of N (as long as f is right U(N)-invariant). Similarly, the normalized height pairing between cohomological cycles

$$\langle Z_{\Omega,f_1}, Z_{\Omega^{-1},f_2} \rangle^{\sharp} := \operatorname{Vol}(U(N)) \langle Z_{\Omega,f_1}, Z_{\Omega^{-1},f_2} \rangle_{Y(N)}$$

does not depend on the choice of N (as long as f is right U(N)-invariant). Indeed, by the projection formula, (2.2) and (2.4), we have

(2.6)
$$\langle Z_{\Omega,f_1}, Z_{\Omega^{-1},f_2} \rangle^{\sharp} = \langle Z_{\Omega,f_1*f_2^{\vee}}, Z_{\Omega^{-1}} \rangle.$$

2.3. Modularity. Consider the following subspace of $\lim_{N \to \infty} Z^k(Y(N))$:

$$CM(\Omega) := \{ Z_{\Omega, f} : f \in \mathcal{S}(\mathrm{GL}_2(\mathbb{A}^\infty)) \}.$$

Let $\overline{CM}(\Omega)$ be the quotient of $CM(\Omega)$ by the kernel of the normalized height pairing with $CM(\Omega^{-1})$. Define $\overline{CM}(\Omega^{-1})$ similarly. By (2.3) and the projection formula, the right $\operatorname{GL}_2(\mathbb{A}^{\infty})$ -action R on $\lim_{N \to \infty} \operatorname{Ch}^k(Y(N))$ (see 2.1.3) induces right $\operatorname{GL}_2(\mathbb{A}^{\infty})$ -actions on $\overline{CM}(\Omega)$ and $\overline{CM}(\Omega^{-1})$.

Definition 1. Let the left action of $\operatorname{GL}_2(\mathbb{A}^{\infty})$ on $\overline{CM}(\Omega)$ be the opposite of the right action R.

Then the left action is compatible with the one induced from the left action on homological Chow cycles, see 2.1.5. Under the left action, the central character of $\overline{CM}(\Omega)$ is Ω .

Let \mathcal{A} be the set of cuspidal automorphic representations π of $\operatorname{GL}_{2,\mathbb{O}}$ such that

- π_{∞} is the holomorphic discrete series of weight 2k,
- π has central character $\Omega^{-1}|_{\mathbb{A}^{\times}}$ (so $\pi_K \otimes \Omega$ is self-dual with root number $\epsilon(1/2, \pi_K \otimes \Omega) = \pm 1$).

For $\pi \in \mathcal{A}$, let π^{∞} be the finite component. Let $\tilde{\pi}^{\infty}$ be the admissible dual of π^{∞} . Let

$$\overline{CM}[\pi] := \operatorname{Hom}_{\operatorname{GL}_2(\mathbb{A}^\infty)}(\widetilde{\pi}^\infty, \overline{CM}(\Omega)),$$
$$\overline{CM}[\widetilde{\pi}] := \operatorname{Hom}_{\operatorname{GL}_2(\mathbb{A}^\infty)}(\pi^\infty, \overline{CM}(\Omega^{-1})).$$

Remark 2.3.1. The reader should think of $\overline{CM}[\pi]$ as a subgroup of the "Mordell-Weil group" of the submotive of $\{Y(N)\}_N$ corresponding to π . We remind the reader of the weight 2 case in [31, p. 78]: there is a decomposition of abelian varieties up to isogeny,

$$\varinjlim_{N} \operatorname{Jac}(X(N)) = \bigoplus \widetilde{\Pi}^{\operatorname{op}} \otimes_{\operatorname{End}(\Pi)} A_{\Pi},$$

where Π runs over irreducible admissible representations of $\operatorname{GL}_2(\mathbb{A}^{\infty})$ over \mathbb{Q} such that $\Pi_{\mathbb{C}}$ is a direct sum of the finite components of cuspidal automorphic representations of weight 2, and $L(s, A_{\Pi}) = L(s - 1/2, \Pi)$. If $\varinjlim \operatorname{Jac}(X(N))$ is equipped with the opposite of the right action (see Remark 2.1.2), this decomposition respects the $\operatorname{GL}_2(\mathbb{A}^{\infty})$ -action on both sides.

We have natural embeddings of $GL_2(\mathbb{A}^{\infty})$ -modules

(2.7)
$$\bigoplus_{\pi \in \mathcal{A}} \widetilde{\pi}^{\infty} \otimes \overline{CM}[\pi] \hookrightarrow \overline{CM}(\Omega), \ \bigoplus_{\pi \in \mathcal{A}} \pi^{\infty} \otimes \overline{CM}[\widetilde{\pi}] \hookrightarrow \overline{CM}(\Omega^{-1}).$$

We propose the following modularity conjecture, following S. Zhang [35].

Conjecture 2.3.2. The embeddings (2.7) are surjective.

Conjecture 2.3.2 is a consequence of the conjecture of Beilinson and Bloch on the injectivity of Abel-Jacobi map [1, Lemma 5.6].

2.3.1. Unramified modularity. For a finite set S of finite places of \mathbb{Q} , let $\mathbb{A}^{S,\infty}$ be the ring of finite adeles without S-component. Let $U^S = \prod_{p \notin S} \operatorname{GL}_2(\mathbb{Z}_p)$. Let $\mathcal{H}^S \subset \mathcal{S}(\operatorname{GL}_2(\mathbb{A}^{S,\infty}))$ be the usual unramified Hecke algebra, i.e. the sub-algebra (under convolution) of bi- U^S -invariant functions. Let

$$CM(\Omega, \mathcal{H}^S) := \{Z_{\Omega, f} : f \in \mathcal{S}(\mathrm{GL}_2(\mathbb{A}_S)) \otimes \mathcal{H}^S\}.$$

Let $\overline{CM}(\Omega, \mathcal{H}^S)$ be the image of $CM(\Omega, \mathcal{H}^S)$ in $\overline{CM}(\Omega)$. Then $\overline{CM}(\Omega, \mathcal{H}^S)$ is a \mathcal{H}^S -submodule of $\overline{CM}(\Omega)$. Let $\mathcal{A}^{U^S} \subset \mathcal{A}$ be the subset of representations with nonzero U^S -invariant vectors. For $\pi \in \mathcal{A}^{U^S}$, let L_{π^S} (resp. L_{π^S}) be the character of \mathcal{H}^S on the 1-dimensional space of U^S -invariant vectors in $\pi^{S,\infty}$ (resp. $\tilde{\pi}^{S,\infty}$). Let

$$\overline{CM}[\pi^S] := \operatorname{Hom}_{\mathcal{H}^S}(L_{\widetilde{\pi}^S}, \overline{CM}(\Omega, \mathcal{H}^S)),$$
$$\overline{CM}[\widetilde{\pi}^S] := \operatorname{Hom}_{\mathcal{H}^S}(L_{\pi^S}, \overline{CM}(\Omega^{-1}, \mathcal{H}^S)),$$

Theorem 2.3.3. Assume that S contains 2 and all finite places of \mathbb{Q} ramified in K or ramified for Ω . Then we have

$$\overline{CM}(\Omega, \mathcal{H}^S) = \bigoplus_{\pi \in \mathcal{A}^{U^S}} L_{\widetilde{\pi}^S} \otimes \overline{CM}[\pi^S],$$

and the corresponding equality for $\overline{CM}(\Omega^{-1}, \mathcal{H}^S)$.

Remark 2.3.4. As one may expect, the assumption that S contains 2 comes from local theta lifting, see Lemma 4.1.2.

2.3.2. Full modularity. For $\pi \in \mathcal{A}$, let

$$\overline{CM}(\pi) = \varinjlim_{S} L_{\widetilde{\pi}^S} \otimes \overline{CM}[\pi^S] \subset \overline{CM}(\Omega),$$

which is stable by the $\operatorname{GL}_2(\mathbb{A}^{\infty})$ -action. By the strong multiplicity one theorem [21], $\overline{CM}(\Omega)$ is the direct sum of all $\overline{CM}(\pi)$'s. Define $\overline{CM}(\widetilde{\pi}) \subset \overline{CM}(\Omega^{-1})$ similarly. Conjecture 2.3.2 is equivalent to the truth of the following conjecture for all $\pi \in \mathcal{A}$.

Conjecture 2.3.5. We have

$$\overline{CM}(\pi) = \widetilde{\pi}^{\infty} \otimes \overline{CM}[\pi],$$

and the corresponding equality for $\overline{CM}(\widetilde{\pi})$.

Theorem 2.3.6. Assume that $L(1/2, \pi_K \otimes \Omega) = 0$. Then Conjecture 2.3.5 holds.

The theorem of Tunnell [25] and Saito [23], implies the following result.

Proposition 2.3.7. Assume Conjecture 2.3.5. Then $\overline{CM}(\pi) = \{0\}$ if $\epsilon(1/2, \pi_{K_p} \otimes \Omega_p)\Omega_p(-1) = -1$ for some $p < \infty$.

We prove the following unconditional result.

Theorem 2.3.8. Assume that $\epsilon(1/2, \pi_{K_p} \otimes \Omega_p)\Omega_p(-1) = -1$ for more than one $p < \infty$, then $\overline{CM}(\pi) = \{0\}$ and $\overline{CM}(\tilde{\pi}) = \{0\}$. In particular, Conjecture 2.3.5 holds.

2.4. Height pairing and derivatives.

2.4.1. Local periods. Let η be the Hecke character of \mathbb{Q}^{\times} associated to K via the class field theory.

Fix the following measures. For a finite place p, endow \mathbb{Q}_p^{\times} with the Haar measure such that $\operatorname{Vol}(\mathbb{Z}_p^{\times}) = 1$. This gives the measure on $K_p^{\times}/\mathbb{Q}_p^{\times}$ for p split in K. For p unramified in K, endow $K_p^{\times}/\mathbb{Q}_p^{\times}$ with the Haar measure such that $\operatorname{Vol}(K_p^{\times}/\mathbb{Q}_p^{\times}) = 1$. For p ramified in K, endow $K_p^{\times}/\mathbb{Q}_p^{\times}$ with the Haar measure such that $\operatorname{Vol}(K_p^{\times}/\mathbb{Q}_p^{\times}) = 2|D_p|_p^{1/2}$ where D_p is the local discriminant. See also [31, 1.6.2].

Let π_p be an irreducible unitary admissible representation of $\operatorname{GL}_2(\mathbb{Q}_p)$. For $\phi_p \in \pi_p$ and $\phi_p \in \widetilde{\pi}_p$, let

$$\alpha_{\pi_p}^{\sharp}(\phi_p \otimes \widetilde{\phi}_p) = \alpha_{\pi_p}^{\sharp}(\phi_p, \widetilde{\phi}_p) := \frac{L(1, \eta_p)L(1, \pi_p, \mathrm{ad})}{\zeta_{\mathbb{Q}_p}(2)L(1/2, \pi_{p, K_p} \otimes \Omega_p)} \int_{K_p^{\times}/\mathbb{Q}_p^{\times}} \left(\pi_p(t)\phi_p, \widetilde{\phi}_p\right) \Omega_p(t) dt.$$

Then $\alpha_{\pi_p}^{\sharp}(\phi_p \otimes \widetilde{\phi}_p) = 1$ if K_p, Ω_p, π_p are unramified, $\phi_p, \widetilde{\phi}_p$ are $\operatorname{GL}_2(\mathbb{Z}_p)$ -invariant, and $(\phi_p, \widetilde{\phi}_p) = 1$. Let

$$\alpha_{\pi^{\infty}}^{\sharp} = \prod_{p < \infty} \alpha_{\pi_p}^{\sharp}.$$

2.4.2. Yuan-Zhang-Zhang type formula I. Fix the Haar measure on $\operatorname{GL}_2(\mathbb{Q}_p)$ so that

$$\operatorname{Vol}(\operatorname{GL}_2(\mathbb{Z}_p)) = 1$$

For $f \in \mathcal{S}(\mathrm{GL}_2(\mathbb{A}^\infty))$, let $z_{\Omega,f}$ be the image of $Z_{\Omega,f}$ in $\overline{CM}(\Omega)$. For $\pi \in \mathcal{A}$, let $z_{\Omega,f,\pi} \in \overline{CM}(\pi)$ be the π -component of $z_{\Omega,f}$ via Theorem 2.3.3. For $\phi \in \pi^\infty$ and $\phi \in \tilde{\pi}^\infty$, let $f \in \mathcal{S}(\mathrm{GL}_2(\mathbb{A}^\infty))$ such that the image of f^{\vee} in $\pi^\infty \otimes \tilde{\pi}^\infty \subset \mathrm{Hom}(\tilde{\pi}^\infty, \tilde{\pi}^\infty)$ via the usual (left) Hecke action is $\phi \otimes \tilde{\phi}$. Define

(2.8)
$$z_{\phi \otimes \widetilde{\phi}} := z_{\Omega, f, \pi} \in \overline{CM}(\pi),$$

which does not depend on the choice of f under Conjecture 2.3.5. Similarly, we define $z_{\tilde{\phi}\otimes\phi}\in \overline{CM}(\tilde{\pi})$.

The following formula is the counterpart of the projector version of the general Gross-Zagier formula [31, Theorem 3.15] of Yuan, S. Zhang, and W. Zhang.

Theorem 2.4.1. Assume that Conjecture 2.3.5 holds for π . For $\phi \in \pi^{\infty}$ and $\phi \in \tilde{\pi}^{\infty}$, we have

(2.9)
$$\langle z_{\phi\otimes\widetilde{\phi}}, z_{\Omega^{-1}} \rangle = \frac{L'(1/2, \pi_K \otimes \Omega)}{L(1, \eta)^2 L(1, \pi, \operatorname{ad})} \frac{(2k-2)!}{2(k-1)! \cdot (k-1)!} \alpha_{\pi^{\infty}}^{\sharp}(\phi \otimes \widetilde{\phi}).$$

Remark 2.4.2. As one may expect, the number $\frac{(2k-2)!}{(k-1)! \cdot (k-1)!}$ is (part of) a local factor at ∞ , see (3.12).

2.4.3. Yuan-Zhang-Zhang type formula II. Now we reformulate Theorem 2.4.1 in the form of the general Gross-Zagier formula [31, Theorem 1.2] of Yuan, S. Zhang, and W. Zhang. This is suggested by S. Zhang. We define a height pairing between $\overline{CM}[\pi]$ and $\overline{CM}[\tilde{\pi}]$, following S. Zhang [35]. For $l \in \overline{CM}[\pi]$ and

We define a height pairing between $CM[\pi]$ and $CM[\pi]$, following S. Zhang [35]. For $l \in CM[\pi]$ $\tilde{l} \in \overline{CM}[\tilde{\pi}], \phi \in \pi^{\infty}$ and $\tilde{\phi} \in \tilde{\pi}^{\infty}$ with $(\phi, \tilde{\phi}) \neq 0$, let

(2.10)
$$\langle l, \tilde{l} \rangle = \frac{\langle l(\phi), l(\phi) \rangle^{\sharp}}{(\phi, \tilde{\phi})}.$$

By Schur's lemma, the pairing (2.10) does not depend on the choices of ϕ, ϕ .

Assume that Conjecture 2.3.5 holds for π . For $\phi \in \pi$, let

$$l_{\phi} \in \overline{CM}[\pi] := \operatorname{Hom}_{\operatorname{GL}_2(\mathbb{A}^{\infty})}(\widetilde{\pi}^{\infty}, \overline{CM}(\Omega))$$

be defined by $\phi \mapsto z_{\phi \otimes \phi}$. Since $z_{\phi \otimes \phi}$'s span $\overline{CM}(\pi)$, every element in $\overline{CM}[\pi]$ equals some l_{ϕ} . Similarly, every element in $\overline{CM}[\tilde{\pi}]$ equals $l_{\tilde{\phi}}: \phi \mapsto z_{\tilde{\phi} \otimes \phi}$ for some $\tilde{\phi} \in \tilde{\pi}$.

The following theorem is a consequence of Theorem 2.4.1.

Theorem 2.4.3. Assume that Conjecture 2.3.5 holds for π . For $\phi \in \pi^{\infty}$ and $\tilde{\phi} \in \tilde{\pi}^{\infty}$, we have

$$\langle l_{\phi}, l_{\widetilde{\phi}} \rangle = \frac{L'(1/2, \pi_K \otimes \Omega)}{L(1, \eta)^2 L(1, \pi, \text{ad})} \frac{(2k-2)!}{2(k-1)! \cdot (k-1)!} \alpha_{\pi^{\infty}}^{\sharp}(\phi, \widetilde{\phi}).$$

Corollary 2.4.4. Assume that Conjecture 2.3.5 holds for π . If $L'(1/2, \pi_K \otimes \Omega) = 0$, then $\overline{CM}(\pi) = \{0\}$.

Remark 2.4.5. Compare Corollary 2.4.4 with Theorem 2.3.8 and the remark below it.

Corollary 2.4.6. Assume that $L'(1/2, \pi_K \otimes \Omega) \neq 0$. If $\epsilon(1/2, \pi_{K_p} \otimes \Omega_p)\Omega_p(-1) = 1$ for all $p < \infty$, then $\dim \overline{CM}[\pi] = 1$. Otherwise, $\overline{CM}[\pi] = \{0\}$.

Proof. By Theorem 2.3.6, Conjecture 2.3.5 holds for π . Thus the "otherwise" part follows from Proposition 2.3.7. Now assume that $\epsilon(1/2, \pi_{K_p} \otimes \Omega_p)\Omega_p(-1) = 1$ for all $p < \infty$. By the theorem of Tunnell [25] and Saito [23], dim Hom_{$\mathbb{A}_K^{\infty,\times}$} ($\pi^{\infty} \otimes \Omega^{\infty}, \mathbb{C}$) = 1. Let $l \neq 0$ be in this Hom space. Let $\phi_0 \in \pi^{\infty}$ such that $l(\phi_0) \neq 0$. Then by Theorem 2.4.3, $l_{\phi} = \frac{l(\phi)}{l(\phi_0)} l_{\phi_0}$.

3. Relative trace formulas and height pairing

We first review the relative trace formulas of Jacquet [12][13]. Then we use the arithmetic relative trace formula approach to prove Theorem 2.4.1.

3.1. Orbital integrals. Let F be a field, E a separable quadratic field extension of F, $z \mapsto \overline{z}$ the Galois conjugation, and Nm : $E^{\times} \to F^{\times}$ the norm map. (We omit the case $E = F \oplus F$, and refer to [22, 4.3].)

3.1.1. Orbits I. Let $G = GL_{2,E}$. Let $\mathcal{V} \subset G$ be the subset of invertible Hermitian matrices over F with respect to E. Let $E^{\times} \times F^{\times}$ act on \mathcal{V} via

$$(a,z) \cdot s = \begin{bmatrix} a & 0 \\ 0 & 1 \end{bmatrix} s \begin{bmatrix} \overline{a} & 0 \\ 0 & 1 \end{bmatrix} z.$$

There is a bijection

Inv:
$$E^{\times} \setminus \mathcal{V} / F^{\times} \simeq (F^{\times} - \{1\}) \cup \{0, \infty\},\$$

which maps $A = \begin{bmatrix} a & b \\ \bar{b} & d \end{bmatrix}$ to

$$\frac{ad}{b\bar{b}} = \frac{\det(A)}{b\bar{b}} + 1.$$

Then $\gamma \in \mathcal{V}$ is regular for this action if $\operatorname{Inv}(\gamma) \in F^{\times} - \{1\}$. Let $\mathcal{V}_{\operatorname{reg}} \subset \mathcal{V}$ be the regular locus.

Let $g \in G$ act on \mathcal{V} by $g \cdot s := gs\bar{g}^t$. Let $H_0 \subset G$ be the unitary group associated to

$$v = \begin{bmatrix} 0 & 1 \\ 1 & 0 \end{bmatrix} \in \mathcal{V}.$$

If F is a local field, for $f \in \mathcal{S}(G)$, let $\Phi_f \in \mathcal{S}(G \cdot w)$, such that

(3.1)
$$\Phi_f(g \cdot w) = \int_{H_0} f(gh) dh.$$

The map $f \mapsto \Phi_f$ is surjective to $\mathcal{S}(G \cdot w)$. If F is a global field, the same definite applies to $f \in \mathcal{S}(G(\mathbb{A}_F))$. Let $(1 - \operatorname{Nm}(E^{\times})) := \{1 - \operatorname{Nm}(a) : a \in E^{\times}\}$. Then

$$\operatorname{Inv}(G \cdot w) = (1 - \operatorname{Nm}(E^{\times})) \cup \{\infty\}.$$

3.1.2. Orbits II. Let B be a quaternion algebra over F containing E. There exists $j \in B$ such that $B = E \oplus Ej$, $j^2 = \epsilon \in F^{\times}$ and $jz = \bar{z}j$ for $z \in E$ (see [22, 4.1]). Then the reduced norm on B can be expressed by $q(a + bj) = \operatorname{Nm}(a) - \operatorname{Nm}(b) \cdot \epsilon$.

Let $E^{\times} \times E^{\times}$ act on B^{\times} by

$$(h_1, h_2) \cdot \gamma = h_1^{-1} \gamma h_2.$$

Define an invariant for this action: $inv(a + bj) = \epsilon Nm(b)/Nm(a)$. This induces a bijection

inv:
$$E^{\times} \setminus B^{\times} / E^{\times} \simeq (\epsilon \operatorname{Nm}(E^{\times}) - \{1\}) \cup \{0, \infty\}$$

Then $\delta = a + bj$ is regular for this action if inv $\neq 0, \infty$, equivalently $ab \neq 0$. Let $B_{\text{reg}}^{\times} \subset B^{\times}$ be the regular locus.

Lemma 3.1.1. For $g \in B_{\text{reg}}^{\times}$, $\text{inv}(g) \in 1 - \text{Nm}(E^{\times})$ if and only if $q(g) \in \text{Nm}(E^{\times})$.

3.1.3. Orbital integrals and derivatives. Let F be a local field. Let η be the quadratic character of F^{\times} associated to E via the class field theory. Let Ω be a continuous character of E^{\times} and $\omega = \Omega|_{F^{\times}}$.

For $\Phi \in \mathcal{S}(\mathcal{V})$, $\gamma \in \mathcal{V}_{reg}$, and $s \in \mathbb{C}$, define the orbital integral

(3.2)
$$O(s,\gamma,\Phi) := \int_{E^{\times}} \int_{F^{\times}} \Phi\left(z \begin{bmatrix} a & 0\\ 0 & 1 \end{bmatrix} \gamma \begin{bmatrix} \bar{a} & 0\\ 0 & 1 \end{bmatrix}\right) \eta \omega^{-1}(z) \Omega(a) |a|_{E}^{s} dz da$$

The integral (3.2) converges absolutely and defines a holomorphic function on s. For $x \in F^{\times} - \{1\}$, let

$$\gamma(x) = \begin{bmatrix} x & 1\\ 1 & 1 \end{bmatrix} \in \mathcal{V}_{\text{reg}}.$$

Then $Inv(\gamma(x)) = x$. Define $O(s, x, \Phi) := O(s, \gamma(x), \Phi)$. Let $O'(0, x, \Phi)$ be the s-derivative at s = 0. We have the following easy lemma.

Lemma 3.1.2. For $x \in F^{\times} - \{1\}$ and near 1, $O'(0, x, \Phi)$ is a Schwartz function.

For $f \in \mathcal{S}(B^{\times})$ and $\delta \in B_{\text{reg}}^{\times}$, define the orbital integral

For $x \in \epsilon \operatorname{Nm}(E^{\times}) - \{1\}$ (where ϵ is as in 3.1.2), choose $b \in E^{\times}$ such that $x = \epsilon \operatorname{Nm}(b)$. Let

$$\delta(x) := \begin{bmatrix} 1 & b\epsilon \\ \bar{b} & 1 \end{bmatrix} = 1 + bj \in B^{\times}$$

Then $inv(\delta(x)) = x$. Define $O(x, f) := O(\delta(x), f)$. Easy to check that O(x, f) does not depend the choice of b.

We have the following characterization of O(x, f) by [12, p. 332, Proposition] (which contains a mistake: it swapped the behaviors of O(x, f) for x near 0 and near ∞).

Proposition 3.1.3. Let ϕ be a function on $\epsilon \text{Nm}(E^{\times}) - \{1\}$. Then $\phi(x) = O(x, f)$ for some $f \in \mathcal{S}(B^{\times})$ if and only if the following conditions hold:

- (1) the function ϕ is locally constant on $\epsilon E^{\times} \{1\}$;
- (2) the function ϕ vanishes near 1;
- (3) there exists a smooth function $A_1(x)$ near 0, such that $\phi(x) = A_1(x)$ for x near 0;
- (4) there exists a smooth function $A_2(x)$ near 0 such that $\phi(x) = \Omega(a)A_2(x)$ for $x = \epsilon a \bar{a}$ near ∞ ;

Definition 2. (1) For $f \in \mathcal{S}(B^{\times})$, $\Phi \in \mathcal{S}(\mathcal{V})$ is a transfer of f if $O(0, x, \Phi) = O(x, f)$ for $x \in \epsilon \operatorname{Nm}(E^{\times}) - \{1\}$, and $O(0, x, \Phi) = 0$ for $x \in F^{\times} - \{1\} - \epsilon \operatorname{Nm}(E^{\times})$.

(2) For $f' \in \mathcal{S}(G)$, the definition in (1) applies if it applies to $\Phi_{f'}$.

We have the following easy lemma and its corollary.

Lemma 3.1.4. The map Inv realizes $(G \cdot w) \cap \mathcal{V}_{reg}$ as a trivial $E^{\times} \times F^{\times}$ -bundle over $(1 - Nm(E^{\times})) - \{0\}$.

Corollary 3.1.5. For $f \in \mathcal{S}(B_{\text{reg}}^{\times})$ such that O(x, f) vanishes outside $(1 - \text{Nm}(E^{\times}))$, there is a transfer $\Phi \in \mathcal{S}((G \cdot w) \cap \mathcal{V}_{\text{reg}}))$.

Let B^{\dagger} be the quaternion algebra non-isomorphic to B and let ϵ^{\dagger} be associated to B^{\dagger} as in 3.1.2 (so $\epsilon^{\dagger} \neq \epsilon \in F^{\times}/\mathrm{Nm}(E^{\times})$).

Proposition 3.1.6. Let $f \in S(B^{\times})$ such that O(x, f) vanishes outside $(1 - \operatorname{Nm}(E^{\times}))$, and O(x, f) extends to a smooth function A(x) on F^{\times} whose restriction to $\epsilon^{\dagger}\operatorname{Nm}(E^{\times})$ is supported near 0. Then there is a transfer $\Phi \in S(G \cdot w)$ of f, and $f^{\dagger} \in S(B^{\dagger, \times})$, such that for $x \in \epsilon^{\dagger}\operatorname{Nm}(E^{\times})$, we have

(3.3)
$$O'(0, x, \Phi) = A(x) \log |x| + O(x, f)$$

and both sides of (3.3), as functions on $\epsilon^{\dagger} \operatorname{Nm}(E^{\times})$, are supported near 0.

By Proposition 3.1.3, Lemma 3.1.4 and Corollary 3.1.5, Proposition 3.1.6 is implied by the following lemma.

Lemma 3.1.7. Let A(x) be a smooth function on a neighborhood of $0 \in F$.

(1) There is $\Phi \in \mathcal{S}(G \cdot w)$ such that $O(0, x, \Phi) = A(x)$ for x in $(1 - \operatorname{Nm}(E^{\times})) - \{0\}$ and near 0, and $O'(0, x, \Phi)$ extends to a smooth function on a neighborhood of $0 \in F$.

(2) There is $\Phi \in S(G \cdot w)$ such that $O(0, x, \Phi) = \eta(x)A(x)$ for x in $(1 - \operatorname{Nm}(E^{\times})) - \{0\}$ and near 0, and $O'(0, x, \Phi) = \eta(x)(-2A(x)\log|x|_F + C(x))$ where C(x) is a smooth function on a neighborhood of $0 \in F$.

(3) There is $\Phi \in \mathcal{S}(G \cdot w)$ such that $O(0, x, \Phi) = \Omega(b)A(x^{-1})$ for $x = -b\overline{b}$ in $(1 - \operatorname{Nm}(E^{\times})) - \{0\}$ and near ∞ .

Proof. (1) Let $\phi \in \mathcal{S}(G \cdot w)$ be supported near $\begin{bmatrix} 0 & 1 \\ 1 & 1 \end{bmatrix}$ and nonzero at $\begin{bmatrix} 0 & 1 \\ 1 & 1 \end{bmatrix}$. A direct computation shows that $O(0, x, \phi)$ extends to a smooth nonvanishing function on a neighborhood of $0 \in F$. Then the pullback of $A(x)/O(0, x, \phi)$, via Inv, to a neighborhood of $\operatorname{Inv}^{-1}(\{0\})$ in $G \cdot w$ extends to a smooth function on $G \cdot w$. Let Φ be the product of ϕ with this smooth extension, and we proved the first part of the lemma. A direct computation shows that $O'(0, x, \phi)$ extends to a smooth function on a neighborhood of $0 \in F$. So is $O'(0, x, \Phi)$

(2) Consider
$$\phi \in \mathcal{S}(G \cdot w)$$
 supported near $\begin{bmatrix} 1 & 1 \\ 1 & 0 \end{bmatrix}$. The argument is similar to the one in the proof of (1).

(3) Consider
$$\phi \in \mathcal{S}(G \cdot w)$$
 supported near $\begin{bmatrix} -1 & 0 \\ 0 & 1 \end{bmatrix}$. The argument is similar to the one in the proof of (1).

3.1.4. A matrix coefficient at ∞ . Let H be the division quaternion algebra over \mathbb{R} with an embedding of \mathbb{C} . In the notation of 3.1.2, we choose $\epsilon = -1$. (Then $H = \mathbb{C} \oplus \mathbb{C}j$ is the usual way of expressing the Hamilton quaternion algebra.)

Let ρ_{2k} be the (2k-1)-dimensional representation of H^{\times} with trivial centra character whose Jacquet-Langlands correspondence to $\operatorname{GL}_2(\mathbb{R})$ is the holomorphic discrete series of weight 2k. Fix an invariant inner product (\cdot, \cdot) on ρ_{2k} , and let e be the unique unit vector which is \mathbb{C}^{\times} -invariant (see [9]). Let $f_{\infty} \in \mathcal{S}(H^{\times})$ such that

(3.4)
$$\int_{\mathbb{R}^{\times}} f_{\infty}(zg) dz = (\rho_{2k}(g)e, e).$$

Let $P_{k-1}(t)$ be the (k-1)-th Legendre polynomial, i.e. the multiple of $\frac{d^{k-1}}{dt^{k-1}}(t^2-1)^{k-1}$ whose value at 1 is 1. By [5, Lemma 4.14] and a direct computation, we have

(3.5)
$$O(\delta, f_{\infty}) = P_{k-1} \left(\frac{1 + \operatorname{inv}(\delta)}{1 - \operatorname{inv}(\delta)} \right) \operatorname{Vol}(\mathbb{C}^{\times} / \mathbb{R}^{\times})^{2}$$

for $\delta \in H_{\text{reg}}^{\times}$. We remind the reader that there is a sign mistake in the statement of [5, Lemma 4.14], which is easy to spot by checking [5, Lemma 4.8] (the proof of [5, Lemma 4.14] is based on [5, Lemma 4.8]).

3.2. Automorphic distributions. Let F be a global field, and let E be a separable quadratic field extension. Let Ω be a character $E^{\times} \setminus \mathbb{A}_{E}^{\times}$, $\omega = \Omega|_{\mathbb{A}_{E}^{\times}}$, and $\omega_{E} := \omega \circ \text{Nm}$.

3.2.1. General linear side. Let $G = GL_{2,E}$. Let A be the diagonal torus of G and let Z be the center. Let $H \subset G$ be the similitude unitary group associated to w, and let κ be the similitude character.

For $f' \in \mathcal{S}(G(\mathbb{A}_E))$, define a kernel function on $G(\mathbb{A}_E) \times G(\mathbb{A}_E)$:

$$K(x,y) := \int_{Z(E)\setminus Z(\mathbb{A}_E)} \left(\sum_{g\in G(E)} f'(x^{-1}gzy)\right) \omega_E^{-1}(z)dz$$

For $a = \begin{bmatrix} a_1 & 0 \\ 0 & a_2 \end{bmatrix}$, let $\Omega(a) = \Omega(a_1/a_2)$. For $s \in \mathbb{C}$, formally define the distribution $O(s, \cdot)$ on $G(\mathbb{A}_E)$ by assigning to $f' \in \mathcal{S}(G(\mathbb{A}_E))$ the integral

$$(3.6) O(s,f') = \int_{Z(\mathbb{A}_E)A(E)\setminus A(\mathbb{A}_E)} \int_{Z(\mathbb{A}_E)H(F)\setminus H(\mathbb{A}_F)} K(a,h)\Omega(a)\eta\omega^{-1}(\kappa(h))|a|_E^s dhda.$$

A slight modification of the proof of [22, Lemma 4.4.2] shows that the integral O(s, f') in (3.6) converges absolutely uner the following assumption.

Assumption 1. Assume that $\Phi_{f'}(g) = 0$ for $g \in \mathbb{A}_E^{\times}(\mathcal{V} - \mathcal{V}_{reg})\mathbb{A}_F^{\times}$.

We always assume Assumption 1. Also assume that f' is a pure tensor (so is $\Phi_{f'}$). Then we have a decomposition

(3.7)
$$O'(0,f') = \sum_{x \in F^{\times} - \{1\}} \sum_{v \in \Xi} O'(0,x,\Phi_{f',v}) O(x,\Phi_{f'}^{v}),$$

where Ξ is the set of places of F. The sum (3.7) converges absolutely.

3.2.2. Quaternion side. Let B be a quaternion algebra over F. For $f \in \mathcal{S}(B^{\times}(\mathbb{A}_F))$, define a kernel function on $B^{\times}(\mathbb{A}_F) \times B^{\times}(\mathbb{A}_F)$:

(3.8)
$$k(x,y) := \sum_{g \in B^{\times}} f(x^{-1}gy).$$

Define a distribution $O(\cdot)$ on $B^{\times}(\mathbb{A}_F)$ by assigning to $f \in \mathcal{S}(B^{\times}(\mathbb{A}_F))$ the integral

$$O(f) := \int_{E^{\times} \setminus \mathbb{A}_{E}^{\times} / \mathbb{A}_{F}^{\times}} \int_{E^{\times} \setminus \mathbb{A}_{E}^{\times}} k(h_{1}, h_{2}) \Omega(h_{1}) \Omega^{-1}(h_{2}) dh_{2} dh_{1}$$

This integral converges absolutely under the following assumption.

Assumption 2. Assume that f vanishes on $\mathbb{A}_E^{\times}(B^{\times} - B_{\text{reg}}^{\times})\mathbb{A}_E^{\times}$.

We always assume Assumption 2. Then we have a decomposition

$$O(f) = \sum_{x \in \epsilon \operatorname{Nm}(E^{\times}) - \{1\}} O(x, f),$$

where ϵ is as in 3.1.2, and

$$O(x,f) = \int_{\mathbb{A}_E^{\times}/\mathbb{A}_F^{\times}} \int_{\mathbb{A}_E^{\times}} f(h_1^{-1}\delta(x)h_2)\Omega(h_1)\Omega^{-1}(h_2)dh_2dh_1.$$

3.2.3. The case of an incoherent transfer. Let \mathbb{B} be a quaternion algebra over \mathbb{A}_F such that for an odd number of places v of F, \mathbb{B}_v is the division quaternion algebra over F_v (such \mathbb{B} is called incoherent). Assume that $f \in \mathcal{S}(\mathbb{B}^{\times})$ is a pure tensor. Assume that $f' \in \mathcal{S}(G(\mathbb{A}_E))$ is a pure tensor and a transfer of f (at every place), and satisfies Assumption 1. Let $\Phi = \Phi_{f'}$.

We rearrange the decomposition of O'(0, f') in (3.7) according to the decomposition

$$F^{\times} - \{1\} = \coprod \operatorname{inv}(B_{\operatorname{reg}}^{\times}),$$

where the union is over all quaternion algebras over F containing E as an F-subalgebra. Let B be such a quaternion algebra, and $x \in inv(B_{reg}^{\times})$. If B and \mathbb{B} are not isomorphic at more than one place, then by the transfer condition, for every place u, the product

$$O(0, x, \Phi^u) = \prod_{v \neq u} O(0, x, \Phi_v)$$

contains at least one local component with value 0. So $O(0, x, \Phi^u) = 0$.

Let $\Xi_{\mathfrak{n}}$ be the set of places of F nonsplit in E. For $v \in \Xi_{\mathfrak{n}}$, let B(v) be the unique quaternion algebra over F such that $\mathbb{B}^{v} \simeq B(\mathbb{A}_{F}^{v})$. For $x \in \operatorname{inv}(B(v)_{\operatorname{reg}}^{\times})$, let $O(x, f^{v})$ be the orbital integral defined by regarding f^{v} as a function on $B^{\times}(\mathbb{A}_{F}^{v})$. Then by the transfer condition, for every $u \in \Xi$, $O(0, x, \Phi^{u}) \neq 0$ only if u = v. In this case $O(0, x, \Phi^{v}) = O(x, f^{v})$. To sum up, we have the following lemma.

Lemma 3.2.1. There is a decomposition

$$O'(0,f') = \sum_{v \in \Xi \mathfrak{n}} \sum_{x \in \operatorname{inv}(B(v)_{\operatorname{reg}}^{\times})} O'(0,x,\Phi_v) O(x,f^v).$$

Definition 3. Let $O'(0, f')_v$ be the summand corresponding to v in the equation in Lemma 3.2.1.

3.2.4. Globalization. Let B be a quaternion algebra over F.

Lemma 3.2.2. Let $v_1, ..., v_n$ be distinct places of F such that B_{v_i} is a division algebra, and for i = 1, ..., n, let π_i be an irreducible representation of $B_{v_i}^{\times}$. Assume that $\operatorname{Hom}_{E_{v_i}^{\times}}(\pi_i \otimes \Omega, \mathbb{C}) \neq 0$. Then there is an automorphic representation π of B^{\times} and $\phi \in \pi$ such that $\pi_{v_i} \simeq \pi_i$ for i = 1, ..., n, and

$$\int_{E^{\times} \backslash \mathbb{A}_{E}^{\times} / \mathbb{A}_{F}^{\times}} \phi(h) \Omega(h) dh \neq 0$$

Proof. The proof mimics the argument in [11]. We apply the relative trace formula associated to the automorphic distribution in 3.2.2. In particular, we choose a pure tensor f in 3.2.2 such that the twisted average of f_{v_i} by ω_{v_i} along the center is a matrix coefficient of π_{v_i} . Moreover, we choose another place v_0 such that $\sup f_{v_0} \subset B_{v_0,reg}^{\times}$. The rest of the proof is the same with [11].

3.3. Local distributions. Let F be a local field and E/F a separable quadratic field extension. Let Ω be a unitary character of E^{\times} , $\omega = \Omega|_{F^{\times}}$, and $\omega_E := \omega \circ \text{Nm}$. Let ψ be a nontrivial additive character of F, and $\psi_E = \psi \circ \text{Tr}$ where $\text{Tr} : E \to F$ is the trace map. (We omit the case $E = F \oplus F$, and refer to [22, 6.4].)

3.3.1. Local distributions on $\operatorname{GL}_{2,E}$. Let σ be an infinite dimensional irreducible unitary representation of $G = \operatorname{GL}_{2,E}$ with central character ω_E^{-1} . Let $W(\sigma, \psi_E)$ be the ψ_E -Whittaker model of σ . For $W \in W(\sigma, \psi_E)$, define the local toric period

(3.9)
$$\lambda(s,W) := \int_{E^{\times}} W\left(\begin{bmatrix} x & 0\\ 0 & 1 \end{bmatrix} \right) |x|_{E}^{s} \Omega(x) dx$$

and the local base change period

(3.10)
$$\mathcal{P}(W) := \int_{F^{\times}} W\left(\begin{bmatrix} x & 0\\ 0 & 1 \end{bmatrix} \right) \eta \omega(x) dx.$$

Assume that σ is tempered, then the integral (3.9) converges for $\operatorname{Re}(s) > -1/2$. For $f \in \mathcal{S}(G)$, define

$$I_{\sigma}(s,f) = \sum_{W} \lambda(s,\pi(f)W) \overline{\mathcal{P}(W)}$$

where the sum is over an orthonormal basis of $W(\sigma, \psi_E)$.

3.3.2. Quaternion side. Let B be a quaternion algebra over F containing E. Let π be an irreducible unitary representation of B^{\times} with central character ω^{-1} . For $u \in \pi$ and $v \in \tilde{\pi}$, define

$$\alpha_{\pi}(u,v) := \int_{E^{\times}/F^{\times}} (\pi(t)u,v)\Omega(t)dt$$

By abuse of notation, for $f \in \mathcal{S}(B^{\times})$, let

(3.11)
$$\alpha_{\pi}(f) := \sum_{u} \alpha_{\pi} \left(\pi(f)u, \widetilde{u} \right)$$

where the sum is over an orthonormal basis $\{u\}$ of π , and $\{\widetilde{u}\}$ is the dual basis of $\widetilde{\pi}$.

Proposition 3.3.1. Assume that F has characteristic 0, and $\alpha_{\pi} \neq 0$. Then for a transfer $f' \in S(G')$ of f, we have

$$I_{\pi_E}(0, f') = c_\pi \alpha_\pi(f),$$

where c_{π} is an explicit nonzero constant.

Proof. The proposition follows from the globalization argument in [2, Proposition 5.7.1] and the proof of [13, Proposition 5] (see also [22, Proposition 6.3.1]). \Box

The constant c_{π} in Proposition 3.3.1 depends on the choices of the measures. In the non-archimedean case, it can be read from the equation in [22, Proposition 6.3.3]. It has the same shape in the archimedean case. Note that our measure on $\text{GL}_2(\mathbb{Q}_p)$ in 2.4.3 is $\zeta_{\mathbb{Q}_p}(2)$ times the one in [13][22][31].

3.3.3. Archimedean case. Let H, ρ_{2k} , e, f_{∞} be as in 3.1.4. Then by the discussion in [22, 6.2], we have

$$\begin{aligned} \alpha_{\rho_{2k}}(f_{\infty}) &= \operatorname{Vol}(\mathbb{C}^{\times}/\mathbb{R}^{\times}) \int_{H^{\times}} f_{\infty}(g)(\rho_{2k}(g)e, e) dg \\ &= \operatorname{Vol}(\mathbb{C}^{\times}/\mathbb{R}^{\times}) \operatorname{Vol}(H^{\times}/\mathbb{R}^{\times}) \frac{1}{2k-1} \end{aligned}$$

Choose measures so that $\operatorname{Vol}(\mathbb{C}^{\times}/\mathbb{R}^{\times}) = 2$, and $\operatorname{Vol}(H^{\times}/\mathbb{R}^{\times}) = 4\pi$. (Our measure on $\operatorname{Vol}(H^{\times})$ is $\zeta_{\mathbb{R}}(2)$ times the one in [13] [31], as the measure on $\operatorname{GL}_2(\mathbb{Q}_p)$ forementioned.) Let α^{\sharp} be the normalization of α by the local *L*-factors as in 2.4.1, then

(3.12)
$$\alpha_{\rho_{2k}}^{\sharp}(f_{\infty}) = 4 \frac{(2k-2)!}{(k-1)! \cdot (k-1)!}$$

3.4. Local comparison I. We compare the height distribution $H(f) = \langle Z_{\Omega,f}, z_{\Omega^{-1}} \rangle$ on $\operatorname{GL}_2(\mathbb{A}^{\infty})$ with the automorphic distribution on $\operatorname{GL}_2(\mathbb{A}_K)$. The conclusion is (3.24).

3.4.1. Notations. We will need the following notations for quaternion algebras. For a quaternion algebra B over a field F, we always use q to denote the reduced norm map. (If B is the matrix algebra, then q is the determinant, and we will consistently use q to replace det from now on.) Let E be a separable quadratic field extension of F. For an embedding of $E \hookrightarrow B$, define an invariant on B^{\times} for the bi- E^{\times} -action

$$\lambda : B^{\star} \to \mathbb{Q},$$
$$\lambda(a+bj) = \frac{q(bj)}{q(a+bj)}$$

where the notation is the same as in 3.1.2. The relation with the invariant defined in 3.1.2 is

$$\lambda(\delta) = \frac{-\mathrm{inv}(\delta)}{1 - \mathrm{inv}(\delta)}.$$

Let B be a quaternion algebra over \mathbb{Q} . For a finite place p of \mathbb{Q} , let B(p) be the unique quaternion algebra over \mathbb{Q} such that $B(p)_v$ is division only for v = p and $v = \infty$. Let $B(\infty)$ be the matrix algebra.

We need three more notations. Let

$$c_K := \operatorname{Vol}(K^{\times} \backslash \mathbb{A}_K^{\times} / \mathbb{A}^{\times}) \operatorname{Vol}(K^{\times} \backslash \mathbb{A}_K^{\times} / \mathbb{R}^{\times}).$$

Let $P_{k-1}(t)$ be the (k-1)-th Legendre polynomial, i.e. the multiple of $\frac{d^{k-1}}{dt^{k-1}}(t^2-1)^{k-1}$ whose value at 1 is 1. Let Q_{k-1} be the Legendre function of the second kind, i.e.,

$$Q_{k-1}(t) = \int_{u=0}^{\infty} (t + \sqrt{t^2 - 1} \cosh u)^{-k} du, \ t > 1.$$

Then (see [10, p. 294, (5.7)])

(3.13)
$$Q_{k-1}(t) = \frac{1}{2} P_{k-1}(t) \log \frac{t+1}{t-1} + (\text{polynomial in } t),$$

and

(3.14)
$$Q_{k-1}(t) = O(t^{-k}), \text{ for } t \to \infty.$$

3.4.2. Height pairing. Let N be a positive integer as in Section 2 and let U = U(N) be the corresponding principal congruence subgroup of $\operatorname{GL}_2(\mathbb{A}^{\infty})$. Let S be a finite set of finite places of \mathbb{Q} which contains all places of \mathbb{Q} ramified in K or ramified for Ω , and all prime factors of N.

Fix $f_S = \bigotimes_{p \in S} f_p \in \mathcal{S}(\mathrm{GL}_2(\mathbb{A}_S))$ where each f_p is right U_p -invariant. Let $f = f_S \otimes f^S$ where $f^S \in \mathcal{H}^S$. Such test functions will be enough for our proof of Theorem 2.4.1 in 3.5.

For a given f_S , let us consider the defining fields and height pairings of the involved CM cycles $f^S \in \mathcal{H}^S$ varies. Let F be the finite abelian extension of K corresponding to

$$\mathbb{A}_K^{\infty,\times} \bigcap \bigcap_{g_S \in \mathrm{supp} f_S} g_S U g_S^{-1}$$

via the class field theory. Then by the CM theory, all CM cycles Z_{tg_S} 's, $t \in \mathbb{A}_K^{\infty,\times}$ and $g_S \in \operatorname{supp} f_S$, are defined over F. Then for $g^S \in \mathcal{S}(\operatorname{GL}_2(\mathbb{A}^{S,\infty}))$, $Z_{tg_Sg^S}$ is defined over a finite extension F' of F unramified from S. So we can define height pairing $\langle Z_{tg_Sg^S}, Z_{t'} \rangle$, $t' \in \mathbb{A}_K^{\infty,\times}$, as in 2.2.4 using the integral model \mathcal{Y}' of Y(N) over $\operatorname{Spec}\mathcal{O}_F$ which is smooth outside S.

Fix an f_S satisfying the following assumption (we will further specify such an f_S in 3.5).

Assumption 3. For every $p \in S$, $\operatorname{supp} f_p \subset \operatorname{GL}_2(\mathbb{Q}_p)_{\operatorname{reg}}$, the regular locus for the $K_p^{\times} \times K_p^{\times}$ -action.

Then Z_{Ω,f_S} and $Z_{\Omega^{-1}}$ do not intersect. So we have the decomposition of the height pairing into local heights over places of \mathbb{Q} :

(3.15)
$$H(f) = \sum_{v} H(f)_{v}$$

Here the local height at v comes from all places of F over v. For $p < \infty$, we have

(3.16)
$$H(f)_p = i(f)_p + j(f)_p,,$$

where $i(f)_p$ comes from the intersections of horizontal cycles, $j(f)_p$ comes from the intersections between horizontal and vertical cycles.

3.4.3. Desingularization. Let $\mathcal{Y}' \to \mathcal{X}'$ be the integral model of $Y(N) \to X(N)$ as in 2.1.1. For $t \in \mathbb{A}_K^{\infty,\times}$, let P_t be the CM point as in 2.2.1, and let \mathcal{Z}'_t be the cycle on \mathcal{Y}' as in 2.2.4. The desingularization of $\mathcal{X}_{\mathcal{O}_F}$ (to get \mathcal{X}') only happens at supersingular points. And locally at supersingular points, $\mathcal{Y}' \to \mathcal{X}'$ is $\mathcal{Y} \times_{\mathcal{X}} \mathcal{X}' \to \mathcal{X}'$. Then the vertical part of \mathcal{Z}'_t is the product of the CM cycle at the reduction of P_t in \mathcal{X} and a divisor D_t supported on the exceptional divisors of \mathcal{X}' .

3.4.4. Split p. Let p be split in K. Under Assumption 3, the underlying CM points of Z_{Ω,f_S} and $Z_{\Omega^{-1}}$ do not have common any reduction (see [31, 8.4] or [22, 9.5.1]). So $i(f)_p = 0$. Since the CM points have ordinary reductions, and the vertical part of Z'_q is supported over supersingular points, $j(f)_p = 0$.

3.4.5. Nonsplit p, *i*-part. Let p be nonsplit in K. Let S_{U_p} be the supersingular Lubin-Tate formal deformation space of level U_p [22, 9.3.2], which is defined over the integer rings of the completed maximal unramified extension of \mathbb{Q}_p . Then the corresponding base change of the formal neighborhood of the supersingular locus in \mathcal{X} is given as follows:

$$B(p)^{\times} \setminus \mathcal{S}_{U_p} \times B(p)^{\times} (\mathbb{A}^{p,\infty}) / U(N)^p.$$

Let $F_p = F \otimes_{\mathbb{Q}} \mathbb{Q}_p$, which is a product of finite extensions of \mathbb{Q}_p . Let $\mathcal{O}_{F_p^{ur}}$ be the product of the integer rings of the completed maximal unramified extensions of the components of F_p . Let \mathcal{S}'_{U_p} be the minimal desingularization of the base change of \mathcal{S}_{U_p} to $\mathcal{O}_{F_p^{ur}}$.

Let $t \in K_p^{\times}$ act on $B(p)_p^{\times}$ via right multiplication by t^{-1} , and act on $\operatorname{GL}_2(\mathbb{Q}_p)$ via left multiplication by t. Then there is a natural map from $B(p)_p^{\times} \times_{K_p^{\times}} \operatorname{GL}_2(\mathbb{Q}_p)$ to \mathcal{S}_{U_p} parametrizing CM liftings [34, 5.5]. So, we have a map from $B(p)_p^{\times} \times_{K_p^{\times}} \operatorname{GL}_2(\mathbb{Q}_p)$ to \mathcal{S}'_{U_p} by strict transform. Abusing notation, we use $(\delta, g) \in B(p)_p^{\times} \times_{K_p^{\times}} \operatorname{GL}_2(\mathbb{Q}_p)$ to denote the corresponding CM point in \mathcal{S}'_{U_p} . The multiplicity function $m_p(\delta, g)$ on $B(p)_p^{\times} \times_{K_p^{\times}} \operatorname{GL}_2(\mathbb{Q}_p) - \{(1, 1)\}$ is defined as $1/[F : \mathbb{Q}]$ times the intersection multiplicity between (δ, g) and (1, 1) (see [22, Definition 21] or [31, 8.2.1]). It is a smooth function. Note that m_p in fact depends on U_p though we do not indicate this dependence in the notation.

We recall the following properties of the multiplicity function (see [22, 9.3.3]).

Lemma 3.4.1. (1) If $m_p(\delta, g) \neq 0$, then $q(\delta)q(g) \in q(U_p)$. (2) We have $m_p(\delta^{-1}, g^{-1}) = m_p(\delta, g)$.

By definition, and after a simple change of variable, we have

$$i(f)_p = \frac{\operatorname{Vol}(U)}{c_K} \int_{K^{\times} \backslash \mathbb{A}_K^{\times} / \mathbb{A}^{\times}} \int_{K^{\times} \backslash \mathbb{A}_K^{\times} / \mathbb{R}^{\times}} \sum_{g \in \operatorname{GL}_2(\mathbb{A}^{\infty}) / U} f(t_1^{-1} t_2 g) [q(g)]^{k-1}} (\overline{Z_{t_2g}} \cdot \overline{Z_{t_2}})_p \Omega^{-1}(t_2) \Omega(t_1) dt_2 dt_1 \cdot \log p$$

Here $\overline{Z_{t_{2}g}}$ and $\overline{Z_{t_2}}$ are horizontal parts of \mathcal{Z}'_{t_2g} and \mathcal{Z}'_{t_2} in $\mathcal{Y}'_{\mathcal{O}_{F_p^{ur}}}$, i.e. the Zariski closures of Z_{t_2g} and Z_{t_2} in $\mathcal{Y}'_{\mathcal{O}_{F_p^{ur}}}$, and $(\overline{Z_{t_2g}} \cdot \overline{Z_{t_2}})_p$ is $1/[F : \mathbb{Q}]$ times their intersection number. And [q(g)] is the positive rational number generating the fractional ideal of \mathbb{Z} corresponding to the idele q(g).

Let $P_{t_2,0}$ be the reduction of the CM point P_{t_2} on X(N) in the integral model \mathcal{X}' . Let $\mathcal{Y}'_{P_{t_2,0}}$ be the fiber of \mathcal{Y}' over $P_{t_2,0} \in \mathcal{X}'$. Then $\mathcal{Y}'_{P_{t_2,0}} = E^{2k-2}_{t_2,0}$, where $E_{t_2,0}$ is the reduction of the CM elliptic curve corresponding to P_{t_2} (see 3.4.3). Let $Z_{t_2,0} \subset \mathcal{Y}'_{P_{t_2,0}}$ be the special fiber of $\overline{Z_{t_2}}$, which is the CM cycle in $\mathcal{Y}'_{P_{t_2,0}}$. By [32, Proposition 3.3.1] and [22, Lemma 9.3.7], if $P_{t_2g} \neq P_{t_2}$, then

$$(3.17) \qquad (\overline{Z_{t_{2}g}} \cdot \overline{Z_{t_{2}}}) = (-1)^{k} \sum_{\delta \in B(p)^{\times}} m_{p}(t_{2,p}^{-1} \delta t_{2,p}, g_{p}^{-1}) \mathbf{1}_{U^{p}}((t_{2}^{p,\infty} g^{p})^{-1} \delta t_{2}^{p,\infty}) (\delta^{*} Z_{t_{2},0} \cdot Z_{t_{2},0}) \mathbf{y}_{P_{t_{2},0}}'.$$

Here B(p) is identified with the endomorphism ring of $E_{t_2,0}$, and $(\delta^* Z_{t_2,0} \cdot Z_{t_2,0})_{\mathcal{Y}'_{P_{t_2,0}}}$ is the intersection number on $\mathcal{Y}'_{P_{t_2,0}}$.

By [32, 4.5.3] (for the CM cycle $Z_{t_2,0}$, $\sigma = \text{id}$ and $\mathfrak{a} = (1)$ in the notations in loc. cit., and the proof is purely over $\overline{\mathbb{F}_p}$), we have

(3.18)
$$(\delta^* Z_{t_2,0} \cdot Z_{t_2,0})_{\mathcal{Y}'_{P_{t_2,0}}} = (-q(\delta))^{k-1} P_{k-1}(1-2\lambda(\delta)).$$

By Lemma 3.4.1, the nonzero contribution in (3.17) is only from δ such that $q(\delta) \in q(t_2^{\infty}gt_2^{\infty,-1})q(U)$. Since $B(p)_{\infty}$ division, $q(\delta) > 0$. So $q(\delta) = [q(g)]$. Thus, we have

(3.19)
$$i(f)_p = \frac{-\operatorname{Vol}(U)}{c_K} \int_{K^{\times} \setminus \mathbb{A}_K^{\times} / \mathbb{A}^{\times}} \int_{K^{\times} \setminus \mathbb{A}_K^{\times} / \mathbb{R}^{\times}} \sum_{g \in \operatorname{GL}_2(\mathbb{A}^{\infty}) / U} f(g) \sum_{\delta \in B(p)^{\times}} P_{k-1}(1-2\lambda(\delta)) m_p(t_{1,p}^{-1}\delta t_{2,p}, g_p^{-1}) \mathbf{1}_{U^p}((t_1^{p,\infty}g^p)^{-1}\delta t_2^{p,\infty}) \Omega^{-1}(t_2) \Omega(t_1) dt_2 dt_1 \cdot \log p$$

Note that $m_p(\cdot, g_p^{-1})$ only depends on $g_p U_p$ by Lemma 3.4.1 (2). So the sum over g is well-defined. Let f_{∞} be as in (3.4). By the orbital integral of f_{∞} computed in (3.5) and Assumption 3, we have

$$(3.20) \qquad i(f)_p = \frac{-1}{c_K} \sum_{\delta \in K^{\times} \setminus B(p)_{\text{reg}}^{\times}/K^{\times}} O(\delta, f^p \otimes f_{\infty}) \\ \int_{K_p^{\times}/\mathbb{Q}_p^{\times}} \int_{K_p^{\times}} \sum_{g \in \text{GL}_2(\mathbb{Q}_p)/U_p} f_p(g) m_p(t_1^{-1}\delta t_2, g^{-1}) \Omega_p^{-1}(t_2) \Omega_p(t_1) dt_2 dt_1 \cdot \log p.$$

3.4.6. Nonsplit p, j-part. Let $p \in S$ which is nonsplit in K. Let \mathcal{P} be the union of the exceptional divisors of \mathcal{X}' over p. Let \mathcal{V} be the exceptional divisor of \mathcal{S}'_{U_p} , which inherits a $B(p)_p^{\times}$ -action from the $B(p)_p^{\times}$ -action on \mathcal{S}'_{U_p} . Then

(3.21)
$$\mathcal{P} \simeq B(p)^{\times} \setminus \mathcal{V} \times \mathrm{GL}_2(\mathbb{A}^{p,\infty}) / U^p.$$

For a vertical divisor C of \mathcal{S}'_{U_p} supported on \mathcal{V} and $g \in \operatorname{GL}_2(\mathbb{A}^{p,\infty})$, let [C,g] be the corresponding divisor of \mathcal{P} via (3.21). Define a function l_C on $B(p)_p^{\times} \times_{K_p^{\times}} \operatorname{GL}_2(\mathbb{Q}_p)$ by letting $l_C(\delta,g)$ be the intersection number of C and (δ,g) in \mathcal{S}'_{U_p} .

There is a natural map $\mathcal{S}_{U_p} \to \mathbb{Z}$ given by the degree of the quasi-isogeny in the definition of the deformation space \mathcal{S}_{U_p} [22, 9.3.2]. Thus we have a map $\mathcal{S}'_{U_p} \to \mathbb{Z}$. It induce a map $\mathcal{V} \to \mathbb{Z}$.

Lemma 3.4.2 ([22, Lemma 9.3.15]). The function l_C satisfies the following properties:

- (1) for $h \in B(p)_p^{\times} \times_{K_p^{\times}} \operatorname{GL}_2(\mathbb{Q}_p)$, $l_C(h) \neq 0$ only if the image of the support of C in \mathbb{Z} by the map $\mathcal{V} \to \mathbb{Z}$ contains the image of h by $B(p)_p^{\times} \times_{K_p^{\times}} \operatorname{GL}_2(\mathbb{Q}_p) \to \mathbb{Z}$;
- (2) for $b \in B(p)_p^{\times}$ and $h \in B(p)_p^{\times} \times_{K_p^{\times}} \operatorname{GL}_2(\mathbb{Q}_p)$, $l_{bC}(bh) = l_C(h)$;
- (3) l_C is smooth.

Let D_t be as in 3.4.3. Write D_1 as [C, 1] for a divisor C of \mathcal{S}'_{U_p} supported on \mathcal{V} . Then $D_{t_2} = [t_{2_p}C, t_2^p]$. By Lemma 3.4.2 (2), a similar process of unfolding as in (3.19) and refolding as in (3.20), we have

(3.22)
$$j(f)_p = \frac{-1}{c_K} \sum_{\delta \in K^{\times} \setminus B(p)_{\text{reg}}^{\times}/K^{\times}} O(\delta, f^p f_{\infty})$$
$$\int_{K_p^{\times}/\mathbb{Q}_p^{\times}} \int_{K_p^{\times}} \sum_{g \in \text{GL}_2(\mathbb{Q}_p)/U_p} f_p(g) l_C(t_1^{-1} \delta t_2, g^{-1}) \Omega_p^{-1}(t_2) \Omega_p(t_1) dt_2 dt_1 \cdot \log p.$$

3.4.7. Test functions. Assume that $q(\operatorname{supp} f) \subset \operatorname{Nm}(\mathbb{A}_E^{\infty,\times})$. Then by Lemma 3.1.1, we can use Corollary 3.1.5 and Proposition 3.1.6. Let f'_v be a transfer of f_v for every $v \in S \cup \{\infty\}$. Here for $v \in S$, we only need Corollary 3.1.5 by Assumption 3, while for $v = \infty$, we use Proposition 3.1.6. Let $f'^S \in S\left(\operatorname{GL}_2\left(\mathbb{A}_K^{S,\infty}\right)\right)$ be the unramified transfer of f^S given by the fundamental lemma [22, Proposition 7.3.1], see also [12, Section 4] [13, Proposition 3] (here again we need the assumption on $q(\operatorname{supp} f)$). Let

$$f' = \bigotimes_{p \in S} f'_p \bigotimes f'_\infty \bigotimes f'^S.$$

3.4.8. Matching for $p \notin S$. The full arithmetic fundamental lemma proved in [22, Proposition 10.2.1] and (3.20) imply the following lemma. (Note that the $j(f)_p = 0$ here.)

Lemma 3.4.3. For a finite place $p \notin S$ and nonsplit, we have

$$2H(f)_p = \frac{1}{c_K} O'(0, f')_p,$$

where the right hand side is defined in Definition 3.

3.4.9. Coherence for $p \in S$.

Lemma 3.4.4. For $p \in S$ and nonsplit, there exists $f_{(p)} \in \mathcal{S}(B(p)_p)$ such that

$$2H(f)_p = O(f_{S-\{p\}} \otimes f_{(p)} \otimes f^S \otimes f_{\infty}).$$

Proof. Let

$$f_{(p)}(\delta) = -2c_K \sum_{g \in \operatorname{GL}_2(\mathbb{Q}_p)/U_p} f_p(g) \left((m_p + l_C)(\delta, g^{-1}) \right)$$

which is well-defined on $B(p)_p$ by Assumption 3. It is in $\mathcal{S}(B(p)_p)$ by Lemma 3.4.1 and Lemma 3.4.2. Then the lemma follows from (3.20) and (3.22).

3.4.10. Local height at ∞ . Recall the complex uniformization of the noncuspidal part $X(N)^{\circ}$ of X(N):

$$X(N)^{\circ}_{\mathbb{C}} \simeq B(\infty)_{>0} \setminus \mathcal{H} \times B(\infty)(\mathbb{A}^{\infty})^{\times} / U(N)$$

Here $B(\infty)$ is the matrix algebra, $B(\infty)_{>0} \subset B(\infty)$ consists of elements with positive norms (i.e. positive determinants), and \mathcal{H} is the upper half place. For $(z_1, g_1), (z_2, g_2) \in X(N)^{\circ}_{\mathbb{C}}$, let

(3.23)
$$G_k((z_1, g_1), (z_2, g_2)) = -\sum_{\delta \in B(\infty)_{>0}} Q_{k-1}(d(z_1, \delta z_2)) \mathbb{1}_U(g_1^{-1} \delta g_2),$$

where d is the hyperbolic distance. The sum is absolutely convergent by (3.14). If $(z_1, g_1), (z_2, g_2)$ are distinct CM points, the local height pairing between the CM cycles over them defined by "admissible" Green currents as in 2.2.4 is $G_k((z_1, g_1), (z_2, g_2))$ [32, Proposition 3.4.1]. The hyperbolic distance between CM points $z_0 \in \mathcal{H}$ and δz_0 , where $\delta \in B(\infty)_{\infty,>0} \cap B(\infty)_{\infty,\mathrm{reg}}^{\times}$ is [31, 8.1.1]

$$d(z_0, \delta z_0) = 1 - 2\lambda(\delta).$$

Now we truncate Q_{k-1} . Note that $\lambda \left(B(\infty)_{\infty,>0} \cap B(\infty)_{\infty,\mathrm{reg}}^{\times} \right) = (-\infty,0)$ so that $1-2\lambda$ takes values in $(1,\infty)$. Let ϕ be a smooth function on $[1,\infty)$ with compact support such that $\phi([1,2]) = \{1\}$. Let $Q_{k-1}^{\phi} = Q_{k-1}\phi$, and

$$G_k^{\phi}((z_1, g_1), (z_2, g_2)) = -\sum_{\delta \in B(\infty)_{>0}} Q_{k-1}^{\phi}(d(z_1, z_2)) \mathbb{1}_U(g_1^{-1} \delta g_2).$$

For $y \in X(N)^{\circ}_{\mathbb{C}}$, let $D_y(x) = G_k(x,y) - G_k^{\phi}(x,y)$. The D_y is a smooth bounded function on $X(N)^{\circ}_{\mathbb{C}}$ by (3.14).

Since $1-2\lambda = \frac{1+inv}{1-inv}$ (see 3.4.1), $\lambda(\delta) \in (-\infty, 0)$ corresponds to $inv(\delta) \in (0, 1)$. Recall that f_{∞} satisfies (3.5) and we choose f'_{∞} by Proposition 3.1.6 (see 3.4.7). Proposition 3.1.6 and (3.13) provides an f'_{∞} and an $f_{(\infty)} \in \mathcal{S}(B(\infty)_{\infty})$ such that

$$O'(0, x, \Phi_{f'}) = -2Q_{k-1}^{\phi}\left(\frac{1+x}{1-x}\right) + O(x, f_{(\infty)})$$

and $O(x, f_{(\infty)})$ vanishes outside (0, 1)

Remark 3.4.5. It is not hard to prove that for every f', $O'(0, x, \Phi_{f'})$ is Schwartz if $x \in (0, 1)$ and $x \to 1$. However, $Q_{k-1}\left(\frac{1+x}{1-x}\right)$ is not Schwartz as $x \to 1$ (see (3.14)). This is the reason for the truncation above.

By a similar process of unfolding as in (3.19) and refolding as in (3.20), we have the following lemma.

Lemma 3.4.6. Let f and f' be as in 3.4.7. Then there exists $f_{(\infty)} \in \mathcal{S}(B(\infty)_{\infty})$ and a smooth bounded function D on $X(N)^{\circ}_{\mathbb{C}}$ such that

$$2H(f)_{\infty} = \frac{1}{c_K} O'(0, f')_{\infty} + O(f \otimes f_{(\infty)}) + \int_{\mathbb{Q}^{\times} \setminus \mathbb{A}_K^{\infty, \times} / \mathbb{A}^{\infty, \times}} \rho(f) \Phi(t) dt.$$

3.4.11. *Conclusion*. Now we apply the results in 3.4. By Lemma 3.2.1, Lemma 3.4.3, Lemma 3.4.4 and Lemma 3.4.6, with the notations as in these lemmas, we have

$$(3.24) \qquad 2H(f) = \frac{1}{c_K} O'(0, f') + \sum_{p \in S_n} O(f_{S-\{p\}} \otimes (f_{(p)} - f_{(p)'}) \otimes f^S \otimes f_\infty) \\ + O(0, f_S \otimes f^S \otimes f_{(\infty)}) + \int_{\mathbb{Q}^\times \setminus \mathbb{A}_K^{\infty, \times} / \mathbb{A}^{\infty, \times}} \rho(f) D(t) dt.$$

Here $S_{\mathfrak{n}} \subset S$ is the subset of places nonsplit in K.

3.5. Proof of Theorem 2.4.1. Since Conjecture 2.3.5 holds for π , both sides of (2.9) are in

$$P_{\pi^{\infty}} := \operatorname{Hom}_{\mathbb{A}_{K}^{\infty,\times} \times \mathbb{A}_{K}^{\infty,\times}} \left((\pi^{\infty} \otimes \Omega^{\infty}) \otimes (\widetilde{\pi}^{\infty} \otimes \Omega^{-1,\infty}), \mathbb{C} \right).$$

We may assume that $P_{\pi^{\infty}}$ is nonzero, otherwise, (2.9) becomes trivial. The theorem of Tunnell [25] and Saito [23] implies that dim $P_{\pi^{\infty}} = 1$. Thus we only need to prove (2.9) for one element in $\pi^{\infty} \otimes \tilde{\pi}^{\infty}$, which is not annihilated by $\alpha^{\sharp}_{\pi^{\infty}}$.

For a finite place p of \mathbb{Q} and $f_p \in \mathcal{S}(\mathrm{GL}_2(\mathbb{Q}_p))$, let $\alpha_{\pi_p}^{\sharp}(f_p)$ be defined by the formula (3.11) with α replaced by α^{\sharp} .

Lemma 3.5.1. For every finite place p, there exists f_p such that $\operatorname{supp} f_p \subset \operatorname{GL}_2(\mathbb{Q}_p)_{\operatorname{reg}}, q(\operatorname{supp} f_p) \subset \operatorname{Nm}(K_p^{\times})$, and $\alpha_{\pi_p}^{\sharp}(f_p) \neq 0$.

Proof. For p nonsplit in K, by [22, 6.2], there exists a smooth function ω on $\operatorname{GL}_2(\mathbb{Q}_p)$ nonzero at 1, such that

$$\alpha_{\pi_p}^{\sharp}(f_p) = \int_{\mathrm{GL}_2(\mathbb{Q}_p)} f_p(g) \omega(g) dg.$$

Let V be an open neighborhood of 1 on which ω is constant. Let $V^{\circ} \subset V \cap \operatorname{GL}_2(\mathbb{Q}_p)_{\operatorname{reg}} \cap q^{-1}(\operatorname{Nm}(K_p^{\times}))$ be open compact and nonempty. Let $f_p = 1_{V^{\circ}}$.

For p split in K, it always holds that $q(\operatorname{supp} f_p) \subset \operatorname{Nm}(K_p^{\times})$. Then we apply [37, Theorem A.2]. \Box

Let N be large enough such that $\pi^{U(N)} \neq \{0\}$. For $p \in S$, let f_p be as in Lemma 3.5.1.

By Theorem 2.3.3, we can perform the spectral decomposition on (3.24) according to the \mathcal{H}^S -action. Note that z_{Ω,f_Sf^S} is the image of $z_{\Omega,f_S\otimes 1_{U^S}}$ by $f^{S,\vee}$ under the left action defined in Definition 1, and $L_{\tilde{\pi}}(f^{S,\vee}) = L_{\pi}(f^S)$.

By the strong multiplicity one theorem, the L_{π} -component in each term on the right hand side of (3.24) is indeed the π -component. Then by the theorem of Tunnell [25] and Saito [23], our assumption that $P_{\pi^{\infty}} \neq \{0\}$ implies that the π -component of the second term on the right hand side of (3.24) is 0, and the fact that $\operatorname{Hom}_{K_{\infty}^{\times}}(\pi_{\infty} \otimes \Omega_{\infty}, \mathbb{C}) = \{0\}$ (see [9]) implies that the L_{π} -component of the third and fourth term on the right hand side of (3.24) is 0. (Surely, the vanishing of the fourth term also follows by considering weights.) Then the local-global period as in [22, Proof of Theorem 3.1.6], combined with Proposition 3.3.1 and (3.12), implies that

(3.25)
$$\langle z_{\Omega,f_Sf^S,\pi}, z_{\Omega^{-1}} \rangle = \frac{1}{c_K} \frac{L'(1/2, \pi_K \otimes \Omega)}{L(1, \pi, \mathrm{ad})} \frac{(2k-2)!}{(k-1)! \cdot (k-1)!} \prod_{p < \infty} \alpha_{\pi_p}^{\sharp}(f_p).$$

Here we take f^S to be a pure tensor. If $f_p = 1_{\mathrm{GL}_2(\mathbb{Z}_p)}$ for $p \notin S$, then $\alpha_{\pi_p}^{\sharp}(f_p) = 1$. By our choice of $f_p, p \in S$ in Lemma 3.5.1, $\prod_{p < \infty} \alpha_{\pi_p}^{\sharp}(f_p) \neq 0$.

Since $\operatorname{Vol}(K^{\times} \setminus \mathbb{A}_{K}^{\times} / \mathbb{A}^{\times}) = 2L(1, \eta)$ (see [31, 1.6.3]), we have

$$c_K = \left(2L(1,\eta)\right)^2 \operatorname{Vol}(\mathbb{Q}^{\times} \setminus \mathbb{A}^{\times} / \mathbb{R}^{\times}) = 2L(1,\eta)^2.$$

Note that the image of f^{\vee} in $\pi \otimes \tilde{\pi}$ is $\sum_{\phi} \pi(f)\phi \otimes \tilde{\phi}$ where the sum is over an orthonormal basis $\{\phi\}$ of π^{∞} , and $\{\tilde{\phi}\}$ is the dual basis of $\tilde{\pi}^{\infty}$. Comparing it with the definition of $\alpha_{\pi_n}^{\sharp}(f_p)$, Theorem 2.4.1 follows.

4. Theta lifting and modularity

We first recall some basics of theta series and Eisenstein series. We form a mixed theta-Eisenstein series of $\operatorname{GL}_{2,\mathbb{Q}}$ of weight 2k [31]. Then we study its Whittaker function after holomorphic projection. Then we compare the height pairing H(f) with the value of the Whittaker function at g = 1. Then we prove the modularity of CM cycles based on the comparison. Finally, we use the global results from the weight 2 case to prove some local results used in the proof of the modularity.

4.1. Theta series and Eisenstein series.

4.1.1. Weil representation. Let F be a local field with an absolute value $|\cdot|$. Let ψ be a nontrivial additive character of F and endow F with the self-dual Haar measure. Let (V,q) be a nondegenerate quadratic space over F of even dimension and endow V with the self-dual Haar measure. Let ν be the similitude character of similitude orthogonal group GO(V). The Weil representation of $GL_2(F) \times GO(V)$ on $\mathcal{S}(V \times F^{\times})$ (the space of Schwartz functions) is defined as follows [31, 2.1.3]:

• $r(1,h)\Phi(x,u) = \Phi(h^{-1}x,\nu(h)u)$ for $h \in \mathrm{GO}(V)$; • $r\left(\begin{bmatrix}a & 0\\ 0 & a^{-1}\end{bmatrix},1\right)\Phi(x,u) = \chi_{(V,uq)}(a)|a|^{\dim V/2}\Phi(ax,u)$ for $a \in F^{\times}$, where $\chi_{(V,uq)}$ is the quadratic character associated to the quadratic space (V,uq);

•
$$r\left(\begin{bmatrix}1 & 0\\0 & 1\end{bmatrix}, 1\right) \Phi(x, u) = \psi(buq(x))\Phi(x, u) \text{ for } b \in F;$$

• $r\left(\begin{bmatrix}1 & 0\\0 & a\end{bmatrix}, 1\right) \Phi(x, u) = |a|^{-\dim V/4} \Phi(x, a^{-1}u) \text{ for } a \in F^{\times};$
• $r\left(\begin{bmatrix}0 & 1\\-1 & 0\end{bmatrix}, 1\right) \Phi(x, u) = \gamma_{(V,uq)}(\mathcal{F}_{(V,uq)}\Phi)(x, u) \text{ for } a \in F^{\times}, \text{ where } \gamma_{(V,uq)} \text{ (resp. } \mathcal{F}_{(V,uq)}) \text{ is the Weil index (resp. Fourier transform on the x-variable) for the quadratic space (V uq)$

Remark 4.1.1. (1) The action of GO(V) extends to all functions on $V \times F^{\times}$.

(2) The action of $\operatorname{GL}_2(F) \times \operatorname{GO}(V)$ extends to all functions Φ such that for $u_0 \in F^{\times}$, $\Phi(x, u_0) \in \mathcal{S}(V)$.

Let O(V) act on $\mathcal{S}(V)$ in the usual way: $h \in O(V)$ sends $\phi \in \mathcal{S}(V)$ to $\phi(h^{-1} \cdot)$.

Lemma 4.1.2. Assume that the residue characteristic of F is not 2. Assume that V has a self-dual lattice L. Let $O(L) \subset O(V)$ be the stabilizer of L. Let $\phi \in \mathcal{S}(V)$ be O(L)-invariant. Then for every $a \in F^{\times}$, there exists $f \in \mathcal{S}(\mathrm{GL}_2(F))$, right $\mathrm{GL}_2(\mathcal{O}_F)$ -invariant, such that

(4.1)
$$\phi \otimes 1_{a\mathcal{O}_F^{\times}} = \int_{\mathrm{GL}_2(F)} r(g,1)(1_L \otimes 1_{\mathcal{O}_F^{\times}}) dg.$$

Proof. The lemma is a simple corollary of [6, Theorem 10.2].

4.1.2. Theta series and Eisenstein series. We follow [31, 4.1, 6.1].

Let V_1 be a nondegenerate quadratic space over \mathbb{Q} of even dimension. For $\Phi_1 = \Phi_1^{\infty} \otimes \Phi_{1,\infty}$, where $\Phi_1^{\infty} \in \mathcal{S}(V_1(\mathbb{A}^{\infty}) \times \mathbb{A}^{\infty,\times})$ and $\Phi_{1,\infty}$ is a smooth function on $V_1(\mathbb{R}) \times \mathbb{R}^{\times}$ such that $\Phi_{1,\infty}(x, u) \in \mathcal{S}(V_1(\mathbb{R}))$ for every u, the theta series

$$\theta(g, u, \Phi_1) = \sum_{x \in V_1(\mathbb{Q})} r(g, 1) \Phi_1(x, u)$$

is absolutely convergent for every $g \in \mathrm{GL}_2(\mathbb{A})$. Note that $\theta(g, u, \Phi_1)$ in only $\mathrm{SL}_2(\mathbb{Q})$ -invariant.

For $g \in \operatorname{GL}_2(\mathbb{A}), h \in \operatorname{GO}(V_{\mathbb{A}})$, define

(4.2)
$$\theta(g,h,\Phi_1) = \sum_{(x,u)\in V_1(\mathbb{Q})\times\mathbb{Q}^{\times}} r(g,h)\Phi_1(x,u),$$

The sum (4.2) only involves finitely many u and converges absolutely. Then (4.2) defines a smooth $\operatorname{GL}_2(\mathbb{Q}) \times \operatorname{GO}(V)$ -invariant function on $\operatorname{GL}_2(\mathbb{A}) \times \operatorname{GO}(V_{\mathbb{A}})$.

Let \mathbb{V}_2 be a nondegenerate quadratic space over \mathbb{A} of even dimension. For $\Phi_2 = \Phi_2^{\infty} \otimes \Phi_{2,\infty}$ where $\Phi_2^{\infty} \in \mathcal{S}(\mathbb{V}_2^{\infty} \times \mathbb{A}^{\infty,\times})$ and $\Phi_{2,\infty}$ is a smooth function on $\mathbb{V}_{2,\infty} \times \mathbb{R}^{\times}$ such that $\Phi_{2,\infty}(x,u) \in \mathcal{S}(\mathbb{V}_2(\mathbb{R}))$ for every u, the Eisenstein series

(4.3)
$$E(s,g,u,\Phi_2) = \sum_{\gamma \in P(\mathbb{Q}) \setminus \operatorname{GL}_2(\mathbb{Q})} \delta(\gamma g)^s r(\gamma g,1) \Phi_2(0,u)$$

is absolutely convergent for Res large enough, has a meromorphic continuation to the whole complex plane, and is holomorphic at s = 0. Here P is the standard Borel subgroup and δ the standard modular character [31, 1.6.6]. Note that $E(s, g, u, \Phi_2)$ in only $SL_2(\mathbb{Q})$ -invariant.

Define a function on $V_1(\mathbb{A}) \times \mathbb{V}_2 \times \mathbb{A}^{\times}$ by

$$\Phi_1 \otimes \Phi_2((x,y),u) = \Phi_1(x,u)\Phi_2(y,u)$$

Define the mixed theta-Eisenstein series [31, 2.3, 6.1]

(4.4)
$$I(s,g,\Phi_1\otimes\Phi_2) = \sum_{u\in\mathbb{Q}^\times} \theta(g,u,\Phi_1)E(s,g,u,\Phi_2),$$

which is a smooth $\operatorname{GL}_2(\mathbb{Q})$ -invariant function on $\operatorname{GL}_2(\mathbb{A})$. The definition of the mixed theta-Eisenstein series extends by linearity.

4.1.3. Local Whittaker function. We recall the local Whittaker functions of Eisenstein series [31, p. 186], which will be used later. Its value at g = 1 is given as follows. Let v be a place of \mathbb{Q} . For $a \in \mathbb{Q}_v$, $u \in \mathbb{Q}_v^{\times}$ and $\phi \in \mathcal{S}(\mathbb{V}_{2,v} \times \mathbb{Q}_v^{\times})$, define a (not necessarily convergent) Whittaker integral

(4.5)
$$W_a(s, u, \phi) := \int_{F_v} \delta\left(\begin{bmatrix} 0 & 1\\ -1 & 0 \end{bmatrix} \begin{bmatrix} 1 & b\\ 0 & 1 \end{bmatrix}\right)^s r\left(\begin{bmatrix} 0 & 1\\ -1 & 0 \end{bmatrix} \begin{bmatrix} 1 & b\\ 0 & 1 \end{bmatrix}\right) \phi(0, u)\psi_v(-ab)db.$$

4.1.4. Gaussian. We need special Schwartz functions at the infinite place.

For $a \in \mathbb{R}^{\times}$, m a positive integer, the standard holomorphic a-th Whittaker function on $\operatorname{GL}_2(\mathbb{R})$ of weight m is

$$W_a^{(m)}(g) = |y|^{m/2} e^{2\pi i a(x+yi)} e^{mi\theta} 1_{\mathbb{R}_{>0}}(ay)$$

where g has Iwasawa decomposition

$$g = \begin{bmatrix} c & 0 \\ 0 & c \end{bmatrix} \begin{bmatrix} y & x \\ 0 & 1 \end{bmatrix} \begin{bmatrix} \cos \theta & \sin \theta \\ -\sin \theta & \cos \theta \end{bmatrix}.$$

For non-negative integer l, let

$$p_l(t) = \sum_{j=0}^{l} {\binom{l}{j} \frac{(-t)^j}{j!}}.$$

For $V = \mathbb{C}$ and $q(z) = \pm z\overline{z}$, define the standard Gaussian of weight 2l + 1

$$\Psi(z,u) = p_l(4\pi u |q(z)|) e^{-2\pi u |q(z)|} \mathbf{1}_{\mathbb{R}_{>0}}(u).$$

By [27, p 350, A2], $r(g, 1)\Psi(0, u)$ is of weight 2l + 1. Then a direct computation shows that

(4.6)
$$r(g,1)\Psi(z,u) = |y|^{1/2} p_l(4\pi u |q(z)|y) e^{2\pi i u |q(z)|(x+yi)} e^{(2l+1)i\theta} \mathbb{1}_{\mathbb{R}_{>0}}(uy), z \neq 0,$$

(4.7)
$$r(g,1)\Psi(0,u) = |y|^{1/2} e^{(2l+1)i\theta} \mathbf{1}_{\mathbb{R}_{>0}}(uy),$$

where g has Iwasawa decomposition as above.

4.2. Whittaker functions. Recall that we fixed an integer k > 1.

4.2.1. Quaternion algebra as a quadratic space. Let B be a quaternion algebra over a field F with reduced norm q. Let $(b_1, b_2) \in B^{\times} \times B^{\times}$ act on B by

$$x \mapsto b_1 x b_2^{-1}$$
.

This gives an embedding of $B^{\times} \times B^{\times}$, modulo the diagonal embedding of F^{\times} , into the similitude orthogonal group GO(B) of the quadratic space (B,q). We use $[b_1, b_2]$ to denote the image of (b_1, b_2) in GO(B). Then $GO(B) = B^{\times} \times B^{\times}/F^{\times} \rtimes \{1, \iota\}$ with $\iota([b_1, b_2]) = [b_2, b_1]$. And $SO(B) = \{[b_1, b_2] : q(b_1) = q(b_2)\}$, $O(B) = SO(B) \rtimes \{1, \iota\}$.

4.2.2. Gaussian. Fix an embedding $\mathbb{A}_K \hookrightarrow \mathbb{B}$ and a decomposition $\mathbb{B} = \mathbb{A}_K \bigoplus \mathbb{A}_K j$ as in 3.1.2. We require that $j_{\infty}^2 = -1$. Let

(4.8)
$$\Phi_{\infty} = \Phi_{\infty,1} \otimes \Phi_{\infty,2}$$

where $\Phi_{\infty,1}$ is the standard Gaussian on K_{∞} of weight 1 and $\Phi_{\infty,2}$ is the standard Gaussian on $K_{\infty}j$ of weight 2k - 1 defined in 4.1.4. For $\Phi^{\infty} \in \mathcal{S}(\mathbb{B}^{\infty} \times \mathbb{A}^{\infty,\times})$, let $\Phi = \Phi^{\infty} \otimes \Phi_{\infty}$.

4.2.3. Holomorphic projection. For an automorphic form ϕ on $\operatorname{GL}_2(\mathbb{A})$, let $\operatorname{Pr} \phi$ be the orthogonal projection of ϕ to the space of holomorphic cusp forms on $\operatorname{GL}_2(\mathbb{A})$ of weight 2k. I.e. for every holomorphic cusp form φ on $\operatorname{GL}_2(\mathbb{A})$ of weight 2k, the Petersson inner product of ϕ and φ equals the one of $\operatorname{Pr} \phi$ and φ . Fix the standard additive character ψ of \mathbb{A} (see [31, 1.6.1]). The ψ -Whittaker function of $\operatorname{Pr} \phi$ is denoted by $\operatorname{Pr} \phi_{\psi}$.

4.2.4. *Theta series.* Before the Whittaker function of the mixed theta-Eisenstein series, we study the one for a theta series, which is simpler and will also be used.

Assume that $\mathbb{B} = B_{\mathbb{A}}$ where B is a quaternion algebra over \mathbb{Q} . Then we have the theta series $\theta(g, h, \Phi)$ defined in (4.2).

Lemma 4.2.1. For $a, b \in \mathbb{R}^{\times}$, we have

$$\theta\left(\begin{bmatrix}a & 0\\ 0 & b\end{bmatrix}g, h, \Phi\right) = O_{g,h}(\|a\|\|b\|)$$

where $||a|| = \max\{|a|, |a^{-1}|\}.$

Proof. Only need to check the constant term of $\theta(g, h, \Phi)$, which is the finite sum

$$\sum_{u \in \mathbb{Q}^{\times}} r(g, h) \Phi(0, u).$$

The growth is checked directly by definition.

Then the ψ -Whittaker function $\Pr \theta(g, h, \Phi)_{\psi}$ of the holomorphic projection of $\theta(g, h, \Phi)$ can be computed using [10, p. 288, (5.1)]. (The growth condition in the classical setting in loc.cit., translated into our adelic setting, is $O_{g,h}$ (($||a|||b||)^{k-\epsilon}$) for some $\epsilon > 0$, which holds since k > 1.) Combined with (4.6) and the discussion above [10, p. 291, Proposition (5.6)], we have

(4.9)
$$\Pr \theta(g,h,\Phi)_{\psi} = \frac{(4\pi)^{k-1}(k-1)!}{(2k-2)!} \sum_{y \in B^{\times}} r(g^{\infty},h^{\infty}) \Phi^{\infty}(y,q(y)^{-1}) W_1^{(2k)}(g_{\infty}) \cdot P_{k-1}(1-2\lambda(y))$$

if h_{∞} fixes Φ_{∞} . Here $W_1^{(2k)}$ is the standard holomorphic Whittaker function (see 4.1.4), $P_{k-1}(t)$ is the (k-1)-th Legendre polynomial (see 3.4.1) and λ is the invariant defined in 3.4.1.

4.2.5. Local Whittaker function: nonsplit case. Now we study the Whittaker function of our mixed theta-Eisenstein series $I(s, q, \Phi)$ on $GL_2(\mathbb{A})$ defined in (4.4). We first study (a function which will be) its local component.

Let p be a finite place of \mathbb{Q} . Let ord_p be the standard discrete valuation on \mathbb{Q}_p .

Assume that p is nonsplit in K. Let $K_p^1 \subset K_p$ be the subset of norm 1 elements, with the measure as in [31, 1.6.2]. Let η_p be the quadratic character of \mathbb{Q}_p associated to K_p via the class field theory.

For $a \in \mathbb{Q}_p$, $u \in \mathbb{Q}_p^{\times}$ and $\phi \in \mathcal{S}(K_p j_p \times \mathbb{Q}_p^{\times})$, let

$$W_a^{\circ}(s, u, \phi) = \gamma_{(K_p j_p, uq)}^{-1} W_a(s, u, \phi)$$

where $\gamma_{(K_n i_n, uq)}$ is the Weil index for the quadratic space $(K_p j_p, uq)$, and W_a is the Whittaker integral (4.5).

Remark 4.2.2. We remind the reader that in [31, 6.1.1], the normalization of the Whittaker integral for a = 0 differs from the one for $a \neq 0$. Our normalization here is uniform for a = 0 and $a \neq 0$. This uniformity will be useful in 4.2.8.

By [31, Proposition 6.10(1)], we have

(4.10)
$$W_a^{\circ}(s, u, \phi) := (1 - p^{-s}) \sum_{n=0}^{\infty} p^{-ns+n} \int_{D_n(a)} \phi(t, u) d_u t,$$

where $d_u t$ is the self-dual measure on the quadratic space $(K_p j_p, uq)$ and

$$D_n(a) := \{t \in K_p j_p : uq(t) \in a + p^n \mathbb{Z}_p\}.$$

Lemma 4.2.3. If $a \neq 0$ or $\phi(0, u) = 0$, then (4.10) converges absolutely and defines a holomorphic function on s.

Proof. If $a \neq 0$, then (4.10) is a finite sum. For the case $\phi(0) = 0$, see Lemma 4.2.4 (2).

Lemma 4.2.4. Fix $u \in \mathbb{Q}_p^{\times}$. Let $W(a) = \frac{d}{ds}|_{s=0} W_a^{\circ}(s, u, \phi)$, as a function on \mathbb{Q}_p^{\times} .

- (1) Regard W(a) as a function on \mathbb{Q}_p with singularity at 0. Then it has compact support.

(2) If $\phi(0, u) = 0$, then W(a) extends to a Schwartz function function on \mathbb{Q}_p . (3) Let $u \in \mathbb{Z}_p^{\times}$. If $\phi(0, u) = 1$, then $\frac{L(1, \eta_p)}{\operatorname{Vol}(K_p^1)}W(a) - \frac{\operatorname{ord}_p(a)}{2} \cdot \mathbb{1}_{\mathbb{Z}_p} \cdot \log p$ extends to a Schwartz function on \mathbb{Q}_p . (One may replace \mathbb{Z}_p by any open compact neighborhood of 0.)

Proof. We use (4.10).

(1) For a large enough, $\phi(\cdot, u)$ is 0 on $D_n(a)$.

(2) Without loss of generality, assume that $q(\operatorname{supp}\phi(\cdot, u)) \subset p^A \mathbb{Z}_p^{\times}$ where A is an integer. If $\operatorname{ord}_p(a) \geq 1$ A + 1, then the nonzero summands in (4.10) are n = 0, ..., A (if A < 0, then every summands in (4.10) is 0). And for these n's, $D_n(a)$ does not depend on a. So $W_a(s, 1, u)$ does not depend on a. Thus the extension follows.

(3) follows from a direct computation. For example, see [31, p. 195] and [29, p. 598]. Or one may bypass the computation as follows: by [31, p. 195] and [29, p. 598], (3) holds if $\phi(\cdot, u) = 1_{\mathcal{O}_{K_p} j_p}$. The general case follows by applying (2). \square

For
$$\phi_1 \in \mathcal{S}(K_p \times \mathbb{Q}_p^{\times}), \phi_2 \in \mathcal{S}(K_p j_p \times \mathbb{Q}_p^{\times}), \text{ and } (y_1, x_2) \in \mathbb{B}_p = K_p \oplus K_p j_p, \text{ let}$$

 $\phi_1 \otimes \phi_2((y_1, x_2), u) := \phi_1(y_1, u)\phi_2(x_2, u).$

Let $B(p)_p$ be the quaternion algebra over \mathbb{Q}_p non-isomorphism to \mathbb{B}_p . Fix an embedding $K_p \hookrightarrow B(p)_p$ and a decomposition $B(p)_p = K_p \bigoplus K_p j(p)$ as in 3.1.2.

First, let p be nonsplit in K. For

$$(y_1, y_2) \in B(p)_p - K_p = K_p \oplus (K_p j(p) - \{0\}),$$

and $u \in \mathbb{Q}_p^{\times}$, define

(4.11)
$$k_{\phi_1 \otimes \phi_2}((y_1, y_2), u) = \frac{L(1, \eta_p)}{\operatorname{Vol}(K_p^1)} \cdot \phi_1(y_1, u) \cdot \frac{d}{ds}|_{s=0} W^{\circ}_{uq(y_2), p}(s, u, \phi_2).$$

For a general $\phi \in \mathcal{S}(\mathbb{B}_p \times \mathbb{Q}_p^{\times})$, we define k_{ϕ} by linear extension. Then k_{ϕ} is a smooth function on $(B(p) - K_p) \times \mathbb{Q}_p^{\times}$.

Lemma 4.2.4 (2) implies the following lemma.

Lemma 4.2.5. Assume that ϕ vanishes on $K_p \times \mathbb{Q}_p^{\times}$. Then k_{ϕ} extends to a Schwartz function on $B(p)_p \times \mathbb{Q}_p^{\times}$.

4.2.6. Local Whittaker function: split case. Assume that p is split in K. For $u \in \mathbb{Q}_p^{\times}$ and $\phi \in \mathcal{S}(K_p j_p \times \mathbb{Q}_p^{\times})$, let

$$W_0^{\circ}(s, u, \phi) = \gamma_{(K_p j_p, uq)}^{-1} \frac{\zeta_{\mathbb{Q}_p}(s+1)}{\zeta_{\mathbb{Q}_p}(s)} W_0(s, u, \phi).$$

Remark 4.2.6. Here our normalization of the Whittaker integral is the same with the one in [31, 6.1.1], and differs from the one for in the nonsplit case, see Remark 4.2.2.

Note that $\frac{\zeta_{\mathbb{Q}_p}(s+1)}{\zeta_{\mathbb{Q}_p}(s)}$ has a zero at s = 0, and $W_0^{\circ}(s, u, \phi)$ has analytic continuation to s = 0. In fact, later we will only consider ϕ such that $\phi(0, u) = 0$. In this case, we have an analog of Lemma 4.2.3 so that $W_0(s, u, \phi)$ is automatically holomorphic at s = 0.

For $y \in K_p$ and $u \in \mathbb{Q}_p^{\times}$, define

(4.12)
$$c_{\phi_1 \otimes \phi_2}(y, u) = \phi_1(y, u) \cdot \frac{d}{ds}|_{s=0} W_{0,p}^{\circ}(s, u, \phi_2).$$

For a general $\phi \in \mathcal{S}(\mathbb{B}_p \times \mathbb{Q}_p^{\times})$, we define c_{ϕ} by linear extension.

We have the following analog of Lemma 4.2.5, which is deduced from an analog of Lemma 4.2.4 (2).

Lemma 4.2.7. Assume that ϕ vanishes on $K_p \times \mathbb{Q}_p^{\times}$. Then c_{ϕ} extends to a Schwartz function on $K_p \times \mathbb{Q}_p^{\times}$.

4.2.7. Mixed theta-Eisenstein series. Assume that for an odd number of places v of \mathbb{Q} (including ∞), \mathbb{B}_v is the division quaternion algebra over \mathbb{Q}_v . For a place v of \mathbb{Q} nonsplit in K, let B(v) be the unique quaternion algebra over \mathbb{Q} such that $B(v)(\mathbb{A}_F^v) \simeq \mathbb{B}^v$, and fix an embedding $K \hookrightarrow B(v)$ so that $\mathbb{A}_K^v \subset B(v)(\mathbb{A}_F^v)$ is identified with the $\mathbb{A}_K^v \subset \mathbb{B}^v$. Let $B(p)_p$ be the quaternion algebra over \mathbb{Q}_p non-isomorphism to \mathbb{B}_p . Fix a decomposition $B(v) = K \bigoplus Kj(v)$ as in 3.1.2.

Recall the mixed theta-Eisenstein series $I(s, g, \Phi)$ on $GL_2(\mathbb{A})$ defined in (4.4). Let $I'(0, g, \Phi)$ be the derivative at s = 0.

Lemma 4.2.8. For $a, b \in \mathbb{R}^{\times}$, we have

$$I'\left(0, \begin{bmatrix}a & 0\\ 0 & b\end{bmatrix}g, \Phi\right) = O_g\left(\|a\|(\log\|a\|)\|b\|(\log\|b\|)\right)$$

where $||a|| = \max\{|a|, |a^{-1}|\}.$

Proof. The growth is computed in [31, Lemma 6.13] and [31, Proposition 6.14] in the weight 2 case, and the same computation can be done in our weight 2k setting. Let W(g) be the derivative at 0 of the 0-th Whittaker function of $\Phi_{\infty,2}$ (normalized or not). Then we only need to show that

$$W\left(\begin{bmatrix} a & 0\\ 0 & b \end{bmatrix} g\right) = O_g\left(\|a\|^{1/2} (\log \|a\|) \|b\|^{1/2} (\log \|b\|)\right)$$

This fact follows from [28, Lemma 2.3 (1)].

We further assume the following assumption.

Assumption 4. There is a finite places p_0 such that $\Phi = \Phi^{p_0} \otimes \Phi_{p_0}$ with Φ_{p_0} vanishes on $K_{p_0} \times \mathbb{Q}_{p_0}^{\times}$.

One effect of Assumption 4 is the following lemma.

Lemma 4.2.9. Let $\phi = \phi^{\infty} \otimes \phi_{\infty}$ where $\phi^{\infty} \in \mathcal{S}(\mathbb{V}_{2}^{\infty} \times \mathbb{A}^{\infty,\times})$ is a pure tensor and ϕ_{∞} is a smooth function on $\mathbb{V}_{2,\infty} \times \mathbb{R}^{\times}$ such that $\phi_{\infty}(x, u) \in \mathcal{S}(\mathbb{V}_{2,\infty})$ for every u. Let $E'_{0}(0, 1, u)$ be the value at g = 1 of the constant term of $\frac{d}{ds}|_{s=0}E(s, g, u, \phi)$ (see 4.3). Assume that $\phi = \phi_{p^{0}} \otimes \phi_{p_{0}}$ such that $\phi_{p_{0}}(0, u) = 0$. (1) If p_{0} is nonsplit in K, then

$$E_0'(0,1,u) = 2\frac{L(1,\eta_{p_0})}{\operatorname{Vol}(K_{p_0}^1)} \cdot \frac{d}{ds}|_{s=0} W_{0,p_0}^\circ(s,u,\phi_{p_0}) \cdot \phi_0^{p_0}(0,u).$$

(2) If p_0 is split in K, then

$$E'_{0}(0,1,u) = \frac{d}{ds}|_{s=0}W^{\circ}_{0,p_{0}}(s,u,\phi_{p_{0}})\cdot\phi^{p_{0}}_{0}(0,u).$$

Proof. The lemma follows from the same reasoning as in the proof of [31, Proposition 6.7] (with different normalization when p is not split in K, see Remark 4.2.2).

For a finite place p nonsplit in K, let

(4.13)
$$\mathcal{K}_{\Phi}^{(p)} = \sum_{y \in B(p)^{\times}} \left(\Phi^{p,\infty} \cdot k_{\Phi_p} \right) (y, q(y)^{-1}) \cdot P_{k-1}(1 - 2\lambda(y)) \cdot W_1^{(2k)}(1)$$

where $W_1^{(2k)}$, P_{k-1} , and λ are the ones in (4.9). This is a finite sum. If $p = p_0$, $k_{\Phi_p}(y, q(y)^{-1})$ is welldefined for $y \in K^{\times}$ by Assumption 4 and Lemma 4.2.5. If $p \neq p_0$, the summand in (4.13) corresponding to $y \in K^{\times}$ is understood as 0 by Assumption 4. For the infinite place, let

(4.14)
$$\mathcal{K}_{\Phi}^{(\infty)} := \sum_{y \in B(\infty)_{>0} - K^{\times}} \Phi^{\infty}(y, q(y)^{-1}) \cdot Q_{k-1}(1 - 2\lambda(y)) \cdot W_{1}^{(2k)}(1),$$

where Q_{k-1} is the Legendre function of the second kind (see 3.4.1).

The ψ -Whittaker function $\Pr I'(0, 1, \Phi)_{\psi}$ of holomorphic projection of $I'(0, g, \Phi)$ is computed using [10, p. 288, (5.1)]. (The growth condition in the classical setting in loc.cit., translated into our adelic setting, is $O_g\left((\|a\|\|b\|)^{k-\epsilon}\right)$ for some $\epsilon > 0$, which holds since k > 1.)

First, assume that p_0 is nonsplit in K. By (4.7), [28, Lemma 2.3 (2) (3)] and the discussion above [10, p. 294, (5.8)], we have

(4.15)
$$\Pr I'(0,1,\Phi)_{\psi} = -2\sum_{v} \int_{\mathbb{A}^{\times} K^{\times} \setminus \mathbb{A}_{K}^{\times}} \mathcal{K}_{r(1,[t,t])\Phi}^{(v)} dt$$

where the sum is over all nonsplit places of \mathbb{Q} and the volume of $\mathbb{A}^{\times}K^{\times}\setminus\mathbb{A}_{K}^{\times}$ is chosen to be 1. Note that $r(1, [t, t])\Phi$ also satisfies the condition in Assumption 4.

Second, assume that p_0 is split in K. Then

(4.16)

$$\Pr I'(0,1,\Phi)_{\psi} = -2\sum_{v} \int_{\mathbb{A}^{\times} K^{\times} \setminus \mathbb{A}_{K}^{\times}} \mathcal{K}_{r(1,[t,t])\Phi}^{(v)} dt$$

$$-\sum_{y \in K^{\times}} \left(\Phi^{p_{0},\infty} \cdot c_{\Phi_{p_{0}}} \right) (y,q(y)^{-1}) \cdot W_{1}^{(2k)}(1).$$

Remark 4.2.10. (1) Formally, the above holomorphic projection procedure is the same as [31, Proposition 6.5, Proposition 6.12] [29, p. 586] which are in the weight 2 case, modulo the convergence issue in loc. cit..

(2) The formula [28, Lemma 2.3 (2)] used above is also implied by (4.6) and the local Siegel-Weil formula [31, Theorem 2.2].

4.2.8. A local analytic kernel $k_p(y, x)$. Let p be a finite place of \mathbb{Q} nonsplit in K. Let U_p be an open compact subgroup of \mathbb{B}_p^{\times} . Let $t \in K_p^{\times}$ act on $B(p)_p^{\times}$ via right multiplication by t^{-1} , and act on \mathbb{B}_p^{\times} via left multiplication by t. Define a function k_p on $B(p)_p^{\times} \times_{K_p^{\times}} \mathbb{B}_p^{\times}/U_p - \{(1,1)\}$ by

$$k_p(y,x) = k_{1_{x^{-1}U_p \times q(x)q(U_p)}}(y,q(y^{-1})).$$

(If $y \in K_p^{\times}$ and $x \notin K_p^{\times}$, we use Lemma 4.2.5.) The invariance by K_p^{\times} can be checked directly using (4.5) and (4.11). Note that k_p in fact depends on U_p though we do not indicate this dependence in the notation. Later, we will fix a U_p , and compare k_p with the multiplicity function m_p defined in 3.4.5, see Corollary 4.3.5 and Corollary 4.4.9.

We can recover (part of) k_{ϕ} from k_p by the following tautological formula

(4.17)
$$k_{\phi}(y,q(y)^{-1}) = \sum_{x \in \mathbb{B}_{p}^{\times}/U_{p}} k_{p}(y,x^{-1})\phi(x,1/q(x)).$$

In particular, for $a \in F^{\times}$, we have

(4.18)

$$k_{\phi}(ay, a^{-1}q(y)^{-1}) = k_{r(a,1)\phi}(y, q(y)^{-1})$$

Now we study properties of k_p . First, we consider its support.

Lemma 4.2.11. If $k_p(y, x) \neq 0$, then $q(y)q(x) \in q(U_p)$.

Proof. Express k_{Φ_p} using (4.10) and (4.11), consider the \mathbb{Q}_p^{\times} -components of $\mathbb{B}_p^{\times} \times \mathbb{Q}_p^{\times}$ and $B(p)_p^{\times} \times \mathbb{Q}_p^{\times}$. The lemma follows directly.

Second, we consider $k_p(y, x)$ with $x \in K_p^{\times}$. By the K_p^{\times} -action we only need to consider the case x = 1.

Lemma 4.2.12. There is an open compact subgroup U' of $B(p)_p^{\times}$ such that:

(1) $U' \cap K_p^{\times} = U \cap K_p^{\times}$ as a subgroup of K_p^{\times} ;

(2) the function $k_p(y,1) - \frac{\operatorname{ord}_p(\lambda(y))}{2} \cdot 1_{U'} \cdot \log p$ on $B(p)_p^{\times} - K_p^{\times}$ extends to a smooth function on $B(p)_p^{\times}$. Here λ is the invariant defined in 3.4.1.

Proof. Let $U_0 \subset U_p$ be an open compact subgroup of the form

(4.19)
$$U_0 = (1+U) \oplus U_j \subset \mathbb{B}_p = K_p \oplus K_p j_p$$

where U is an open compact subgroup of K_p^{\times} (small enough so that U_0 is indeed a group). Let $\{t_1, ..., t_n\}$ be a set of representatives of $(K_p^{\times}U_0 \cap U_p)/U_0$. Let

$$k_i(y) = k_{t_i 1_{U_0 \times q(U_p)}}(y, q(y^{-1}))$$

and express $k_i(y)$ using (4.10) and (4.11). By Lemma 4.2.4 (3), $k_i(y)$ satisfies the conditions in the lemma. Let $k(y) = \sum_{i=1}^{n} k_i(y)$. By the K_p^{\times} -invariance of λ , k(y) also satisfies the conditions in the lemma. Note that

$$1_{U_p \times q(U_p)} - \sum_{i=1}^n 1_{t_i U_0 \times q(U_p)}$$

vanishes on $K_p \times \mathbb{Q}_p^{\times}$. By Lemma 4.2.5, $k_p(y, 1) - k(y)$ extends to a Schwartz function on $B(p)_p \times \mathbb{Q}_p^{\times}$. Then the lemma follows.

By Lemma 4.2.5 and Lemma 4.2.12, we have the following corollary.

Corollary 4.2.13. The function k_p on $B(p)_p^{\times} \times_{K_p^{\times}} \mathbb{B}_p^{\times}/U_p - \{(1,1)\}$ is smooth.

Finally, we consider $k_p(y, x)$ with x far away from K_p^{\times} , in the sense that $\lambda(x)$ is far away from 0.

Lemma 4.2.14. Assume that \mathbb{B}_p is the matrix algebra. Let V be an open compact neighborhood of 0 in \mathbb{Q}_p . For U_p small enough and V large enough, $k_p(y, x) = 0$ for all $y \in B(p)_p^{\times}$ and $x \in \mathbb{B}_p^{\times}$ with $\lambda(x) \notin V$.

Proof. Fix a compact subset C of $B(p)_p^{\times}$ such that

$$C \times \mathbb{B}_p^{\times} \to B(p)_p^{\times} \times_{K_p^{\times}} \mathbb{B}_p^{\times}$$

is surjective (here we use the fact that $B(p)_p$ is the division algebra, which follows from the assumption that \mathbb{B}_p is the matrix algebra). Since λ is K_p^{\times} -invariant, we may and we do assume that $y \in C$.

By Lemma 4.2.11, $k_p(y,x) = 0$ unless $q(x^{-1}) \in q(C)q(U_p)$. Now assume $q(x^{-1}) \in q(C)q(U_p)$. Write $x = (x_1, x_2)$ under $\mathbb{B}_p = K_p \oplus K_p j_p$. Then $\lambda(x) = q(x_2)/q(x) \notin V$ with V large enough is equivalent to that $\operatorname{ord}_p(q(x_2))$ is small enough. Since q(x) is bounded, $\operatorname{ord}_p(q(x_2)) = \operatorname{ord}_p(q(x_1))$. Choose U_p to be as in (4.19). For $u_1 \in U, u_2 \in Uj$,

$$x(u_1 + u_2) = (x_1u_1 + x_2u_2) + (x_2u_1 + x_1u_2)$$

Choose U small enough such that $\operatorname{ord}_p(q(x_2u_1+x_1u_2)) = \operatorname{ord}_p(q(x_2))$ for every pair of $u_1 \in 1+U, u_2 \in Uj$. Thus for the integrand $\phi_2(t, 1)$ in (4.10) to be nonzero, we necessarily have $\operatorname{ord}_p(q(t)) = \operatorname{ord}_p(q(x_2))$. Now we check the condition $q(t) \in q(y_2) + p^n \mathbb{Z}_p$ defining the integration domain $D_n(q(y_2))$ of (4.10), where $n \geq 0$. Let V be large enough such that $\operatorname{ord}_p(q(t)) = \operatorname{ord}_p(q(x_2)) < 0$. Since $B(p)_p$ is the division algebra, $q(y_2) \notin \operatorname{Nm}(K_p^{\times})$. Thus $D_n(q(y_2))$ is empty, and $k_p(y, x) = 0$.

4.3. Local comparison II. We compare the height pairing $H(f) = \langle Z_{\Omega,f}, z_{\Omega^{-1}} \rangle$ with $\Pr I'(0, 1, \Phi)_{\psi}$, the derivative of the mixed Eisenstein series (more precisely, the value at g = 1 of its ψ -Whittaker function) computed in (4.15) and (4.16). The main conclusion is (4.39).

4.3.1. Notations. Let \mathbb{B} be the quaternion algebra $\mathbb{B} = H \times M_2(\mathbb{A}^{\infty})$ over \mathbb{A} where H is the division quaternon algebra over \mathbb{R} and M_2 denotes the matrix algebra over \mathbb{Z} . We consistently use $\mathbb{B}^{\infty,\times}$ to replace $\operatorname{GL}_2(\mathbb{A}^{\infty})$ used before. Thus we do not confuse the $\operatorname{GL}_2(\mathbb{A}^{\infty})$ used in Section 3.4 with the GL_2 used in the Weil representation in 4.1.

Let B(v) be the quaternion algebra over \mathbb{Q} as in 4.2.7, i.e. for a finite place p of \mathbb{Q} , let B(p) be the unique quaternion algebra over \mathbb{Q} such that $B(p)_v$ is division only for v = p and $v = \infty$, and $B(\infty)$ is the matrix algebra.

For a quaternion algebra B over a local field, let $h \in B^{\times}$ act on $\mathcal{S}(B \times F^{\times})$ via r(1, [h, 1]), where r is the Weil representation and [h, 1] is defined in 4.2.1. Then the induced action of $f \in \mathcal{S}(B^{\times})$ on $\phi \in \mathcal{S}(B \times F^{\times})$ is given by

(4.20)
$$r(f)\phi(x,u) := \int_{h \in B^{\times}} \phi(h^{-1}x,q(h)u)f(h)dh.$$

We choose measures so that

$$\operatorname{Vol}(K^{\times} \backslash \mathbb{A}_{K}^{\infty, \times} / \mathbb{A}^{\infty, \times}) = \operatorname{Vol}(K^{\times} \backslash \mathbb{A}_{K}^{\infty, \times}) = 1.$$

4.3.2. Review height decomposition. Let S be a finite set of finite places of \mathbb{Q} which contains 2 and all finite places of \mathbb{Q} ramified in K or ramified for Ω . Let $S_{\mathfrak{n}} \subset S$ be the subset of places nonsplit in K. Let N be the product of two relatively prime integers which are ≥ 3 such that the prime factors of N are contained in S. Let U = U(N) be the corresponding principal congruence subgroup of $\operatorname{GL}_2(\mathbb{A}^{\infty})$.

We consider right U-invariant Schwartz functions of the form $f = f_S \otimes f^S$. (Note that we do not require the bi- U^S -invariance of f^S as in 3.4.) Assume that $f_S = \bigotimes_{p \in S} f_p$ is a pure tensor for simplicity. Also assume the following assumption until 4.4 where we prove Theorem 2.3.3 and Theorem 2.3.6.

Assumption 5. There exists $p_0 \in S$ such that f_{p_0} vanishes on $K_{p_0}^{\times}$.

Though Assumption 5 is weaker than Assumption 3 (and we relaxed the invariance on f^S), the decompositions of H(f) in 3.4 still hold after suitable modifications, which are given below. By Assumption 5, Z_{Ω,f_S} and $Z_{\Omega^{-1}}$ do not intersect. So we have the decomposition of H(f) into local heights as in (3.15) and (3.16). We continue to use the notations in (3.15) and (3.16).

We treat the case that p is split in K in 4.3.8.

Now let p be a finite place of \mathbb{Q} nonsplit in K. Let m_p be the multiplicity function on $B(p)_p^{\times} \times_{K_p^{\times}} \mathbb{B}_p^{\times} - \{(1,1)\}$ defined in 3.4.5. For $t_1, t_2 \in \mathbb{A}_K^{\infty, \times}$, let

(4.21)
$$h(f, t_1, t_2)_p := \operatorname{Vol}(U) \sum_{\delta \in B(p)^{\times}} P_{k-1}(1 - 2\lambda(\delta))$$
$$\sum_{x \in \mathbb{B}^{\infty, \times}/U} f(x_p) m_p(t_{1,p}^{-1} \delta t_{2,p}, x_p^{-1}) f(x^p) 1_{U^p}((t_1^p x^p)^{-1} \delta t_2^p)$$

Here $P_{k-1}(t)$ is the (k-1)-th Legendre polynomial (see 3.4.1) and λ is the invariant defined in 3.4.1.

Remark 4.3.1. (1) Note that $m_p(\cdot, x_p^{-1})$ only depends on x_pU_p by Lemma 3.4.1 (2). So the sum over x is well-defined.

(2) If $p = p_0$ and $x_p \in K_p^{\times}$, $f(x_p) = 0$ by Assumption 5. Then $f(x_p)m_p(t_{1,p}^{-1}\delta t_{2,p}, x_p^{-1})$ is understood as 0. If $p \neq p_0$ and $\delta \in K^{\times}$, $f(x^p)1_{U^p}((t_1^p x^p)^{-1}\delta t_2^p) = 0$ by Assumption 5. Then the summand in (4.21) corresponding to $\delta \in K^{\times}$ is understood as 0.

Then (3.19) is rewritten as follows:

(4.22)
$$i(f)_p = -\int_{K^{\times} \backslash \mathbb{A}_K^{\infty, \times} / \mathbb{A}^{\infty, \times}} \int_{K^{\times} \backslash \mathbb{A}_K^{\infty, \times}} h(f, t_1, t_2)_p \log p \cdot \Omega^{-1}(t_2) \Omega(t_1) dt_2 dt_1$$

4.3.3. Rewrite the local height following [31]. Consider the following basic Schwartz function on \mathbb{B}^{∞} :

$$\Phi_0 = \mathbb{1}_{U_S \times q(U_S)} \bigotimes \mathbb{1}_{M_2(\widehat{\mathbb{Z}}^S) \times \widehat{\mathbb{Z}}^{S,\times}} \bigotimes \Phi_{\infty},$$

where Φ_{∞} is the Gaussian on \mathbb{B}_{∞} as in (4.8) and $\widehat{\mathbb{Z}}^{S}$ is the direct product of \mathbb{Z}_{p} for $p \notin S$. Let

$$\Phi = r\left(f\right)\Phi_0$$

Then Φ is right invariant by U, and

(4.23)
$$\Phi^{\infty}(x,q(x)^{-1}) = \operatorname{Vol}(U)f(x)$$

Moreover, if $u_S q(x_S) \notin q(U_S)$, then

$$(4.24)\qquad \qquad \Phi_S(x_S, u_S) = 0$$

In particular, Assumption 4 holds for Φ by Assumption 5.

For $\phi \in \mathcal{S}(\mathbb{B}_p \times \mathbb{Q}_p^{\times})$ right invariant by U_p , define a function m_{ϕ} on $(B(p)_p^{\times} - K_p^{\times}) \times \mathbb{Q}_p^{\times}$ as in [31, Notation 8.3]:

(4.25)
$$m_{\phi}(y,u) = \sum_{x \in \mathbb{B}_p^{\times}/U_p} m_p(y,x^{-1})\phi(x,uq(y)/q(x)).$$

The sum in (4.25) only involves finitely many nonzero terms. Moreover, if $\phi(x) = 0$ for $x \in K_p \times \mathbb{Q}_p^{\times}$, then $m_{\phi}(y, u)$ extends to $B(p)_p^{\times} \times \mathbb{Q}_p^{\times}$ by the same formula.

By Lemma 3.4.1(2), (4.21), (4.23) and a direct computation, we have

(4.26)
$$h(f, t_1, t_2)_p = \sum_{y \in B(p)^{\times}} P_{k-1}(1 - 2\lambda(y)) \\ r(1, [t_1, t_2]) \Phi^{p, \infty}(y, q(y)^{-1}) m_{r(1, [t_1, t_2])} \Phi_p(y, q(y)^{-1}),$$

4.3.4. Comparison for p nonsplit in K. We compare the local component of H(f) and $\Pr I'(0, 1, \Phi)_{\psi}$ for a finite place p nonsplit in K. By (4.15) and (4.22), up to the j-part which will be dealt in 4.3.7, we need to compare $h(f, t_1, t_2)_p$ and $\mathcal{K}_{r(1,[t_1,t_2])\Phi}^{(p)}$ defined in (4.13). Then by (4.26), we are led to compare k_{ϕ} and $m_{\phi} \cdot \log p$ for $\phi \in \mathcal{S}(\mathbb{B}_p \times \mathbb{Q}_p^{\times})$. This is the content of 4.3.5 and 4.3.6. 4.3.5. Matching for $p \notin S$. Assume that $p \notin S$ and nonsplit in K.

Lemma 4.3.2. For $y \in B(p)_p^{\times}$, we have

$$k_{r(1,[t_1,t_2])\Phi_p}(y,q(y)^{-1}) = m_{r(1,[t_1,t_2])\Phi_p}(y,q(y)^{-1}) \cdot \log p.$$

Proof. By the descriptions of $GO(\mathbb{B}_p)$ and $O(\mathbb{B}_p)$ in 4.2.1 and a direct computation, we see that Φ_p is a linear combination of functions in the form of the right hand side of (4.1) in Lemma 4.1.2. By Lemma 4.1.2, we may assume that $\Phi_p = r(g, 1)\Phi_{0,p}$ for some g in the standard Borel subgroup of $GL_2(\mathbb{Q}_p)$. Then the lemma follows from (4.18) and [31, Lemma 6.6, Proposition 8.8].

Then by (4.13) and (4.26), we have

$$W_1^{(2k)}(1)h(f,t_1,t_2)_p \log p = \mathcal{K}_{r(1,[t_1,t_2])\Phi}^{(p)}$$

Since $j(f)_p = 0$, by (4.22), we have

4.3.6. Coherence for $p \in S_n$: difference between *i*-part and the analytic kernel. Let $p \in S_n$.

Lemma 4.3.3 ([22, Lemma 9.3.13]). There is an open compact subgroup U' of $B(p)_p^{\times}$ such that: (1) $U' \cap K_p^{\times} = U \cap K_p^{\times}$ as a subgroup of K_p^{\times} ;

(2) $m_p(y, 1) - \frac{\operatorname{ord}_p(\lambda(y))}{2} \cdot 1_{U'}$ extends to a smooth function on $B(p)_p^{\times}$. Here λ is the invariant defined in 3.4.1.

By Lemma 3.4.1 (1), Lemma 4.2.11 (2), Lemma 4.2.12 and Lemma 4.3.3, we have the following corollary. (This corollary could be regarded as an analog of the "arithmetic smooth matching" [22, Proposition 10.4.1].)

Corollary 4.3.4. The function $k_p(y, 1) - m_p(y, 1) \cdot \log p$ on $y \in B(p)_p^{\times} - K_p^{\times}$ extends to a smooth function on $B(p)_p^{\times}$.

Combined with Corollary 4.2.13, we have the following corollary.

Corollary 4.3.5. The function $k_p(y, x) - m_p(y, x) \cdot \log p$ extends to a smooth function on $B(p)_p^{\times} \times_{K_p^{\times}} \mathbb{B}_p^{\times}$.

Let d_p be such a smooth extension. Then d_p is supported on the union of the supports of k_p and m_p . For $\phi \in \mathcal{S}(\mathbb{B}_p \times \mathbb{Q}_p^{\times})$, define a smooth function d_{ϕ} on $B(p)_p^{\times} \times \mathbb{Q}_p^{\times}$ by

(4.28)
$$d_{\phi}(y,u) = \sum_{x \in \mathbb{B}_p^{\times}/U_p} d_p(y,x^{-1})\phi(x,uq(y)/q(x)).$$

The sum in (4.28) only involves finitely many nonzero terms. By (4.17), we have

$$d_{\phi}(y, q(y)^{-1}) = k_{\phi}(y, q(y)^{-1}) - m_{\phi}(y, q(y)^{-1}).$$

Moreover, by Lemma 3.4.1 (1), Lemma 4.2.11, Corollary 4.3.5, and that $\Phi_p \in \mathcal{S}(\mathbb{B}_p^{\times} \times \mathbb{Q}_p^{\times})$ (see (4.23) and (4.24)), we have

$$d_{r(1,[t_1,t_2])\Phi_n} \in \mathcal{S}(B(p)_n^{\times} \times \mathbb{Q}_n^{\times}).$$

(In particular, its extension to $B(p)_p \times \mathbb{Q}_p^{\times}$ by 0 is a Schwartz function.) By [31, Lemma 6.6, Lemma 8.5], we have $k_{r(1,[t_1,t_2])\Phi_p} = r(1,[t_1,t_2])k_{\Phi_p}$ and $m_{r(1,[t_1,t_2])\Phi_p} = r(1,[t_1,t_2])m_{\Phi_p}$ (see Remark 4.1.1). Thus

$$d_{r(1,[t_1,t_2])\Phi_p} = r(1,[t_1,t_2])d_{\Phi_p}. \text{ Then by (4.9), (4.13), (4.22), (4.26), we have} W_1^{(2k)}(1)i(f)_p = -\int_{K^{\times}\setminus\mathbb{A}_K^{\infty,\times}/\mathbb{A}^{\infty,\times}} \int_{K^{\times}\setminus\mathbb{A}_K^{\infty,\times}} \mathcal{K}_{r(1,[t_1,t_2])\Phi}^{(p)}\Omega^{-1}(t_2)\Omega(t_1)dt_2dt_1 + \int_{K^{\times}\setminus\mathbb{A}_K^{\infty,\times}/\mathbb{A}^{\infty,\times}} \int_{K^{\times}\setminus\mathbb{A}_K^{\infty,\times}} \Pr \theta(1,[t_1,t_2], d_{\Phi_p}\otimes\Phi^p)_{\psi}\Omega^{-1}(t_2)\Omega(t_1)dt_2dt_1$$

4.3.7. Coherence for $p \in S_n$: $j(f)_p$. For $j(f)_p$, the treatment is similar, and we use the discussion in **3.4.6**. Let l_C be the smooth function on $B(p)_p^{\times} \times_{K_p^{\times}} \operatorname{GL}_2(\mathbb{Q}_p)$ as in (3.22). Here C is a vertical divisor of the desingularized deformation space S'_{U_p} .

For $\phi \in \mathcal{S}(\mathbb{B}_p \times \mathbb{Q}_p^{\times})$, define a smooth function l_{ϕ} on $B(p)_p^{\times} \times \mathbb{Q}_p^{\times}$:

$$l_{\phi}(y,u) = \sum_{x \in \mathbb{B}_p^{\times}/U_p} l_C(y,x^{-1})\phi(x,uq(y)/q(x)) \cdot \log p.$$

This sum only involves finitely many nonzero terms. By Lemma 3.4.2 and that $\Phi_p \in \mathcal{S}(\mathbb{B}_p^{\times} \times \mathbb{Q}_p^{\times})$ (see (4.23) and (4.24)), it is easy to check that

(4.30)
$$l_{r(1,[t_1,t_2])\Phi_p} \in \mathcal{S}(B(p)_p^{\times} \times \mathbb{Q}_p^{\times}).$$

Then similar to (4.29), we have

$$(4.31) \qquad W_1^{(2k)}(1)j(f)_p = -\int_{K^\times \backslash \mathbb{A}_K^{\infty,\times}/\mathbb{A}^{\infty,\times}} \int_{K^\times \backslash \mathbb{A}_K^{\infty,\times}} \Pr \theta(1, [t_1, t_2], l_{\Phi_p} \otimes \Phi^p)_{\psi} \Omega^{-1}(t_2) \Omega(t_1) dt_2 dt_1.$$

Lemma 4.3.6. There exists an open compact subgroup U'_p of $B(p)_p^{\times}$ such that l_C is left U'_p -invariant. In particular, l_{ϕ} is left U'_p -invariant for all $\phi \in \mathcal{S}(\mathbb{B}_p \times \mathbb{Q}_p^{\times})$.

Proof. Let $B(p)_p^{\times}$ act on the desingularized deformation space S'_{U_p} by the functoriality of the minimal desingularization. Let U'_p be the stabilizer of C. Then the lemma follows from Lemma 3.4.2 (2).

4.3.8. Split p. Let p be split in K. Then $j(f)_p = 0$. Moreover, if $p \neq p_0$, then $i(f)_p = 0$. The proof is the same as the proof in 3.4.4. Now further assume that $p = p_0$ (the one in Assumption 5).

Lemma 4.3.7. There exists $n_{\Phi_p} \in \mathcal{S}(K_p^{\times} \times \mathbb{Q}_p^{\times})$ such that

$$i(f)_p = \int_{K^{\times} \backslash \mathbb{A}_K^{\infty, \times} / \mathbb{A}^{\infty, \times}} \int_{K^{\times} \backslash \mathbb{A}_K^{\infty, \times}} \sum_{y \in K^{\times}} r(1, [t_1, t_2]) \left(\Phi^{p, \infty} \cdot n_{\Phi_p}(y, q(y)^{-1}) \right) \Omega^{-1}(t_2) \Omega(t_1) dt_2 dt_1.$$

Proof. The proof is similar to the above discussion for nonsplit places.

First, we obtain an analog of (3.19). Let v_1, v_2 be the two places of K over $p = p_0$. Then $i(f)_p = \frac{1}{2}i(f)_{v_1} + \frac{1}{2}i(f)_{v_2}$, where

$$i(f)_{v_i} = \frac{-\operatorname{Vol}(U)}{c_K} \int_{K^{\times} \backslash \mathbb{A}_K^{\times} / \mathbb{A}^{\times}} \int_{K^{\times} \backslash \mathbb{A}_K^{\times} / \mathbb{R}^{\times}} \sum_{g \in \operatorname{GL}_2(\mathbb{A}^{\infty}) / U} f(g) \sum_{\delta \in E^{\times}} m_{v_i} (t_{2,p}^{-1} \delta^{-1} t_{1,p} g_p) \mathbb{1}_{U^p} ((t_1^{p,\infty} g^p)^{-1} \delta t_2^{p,\infty}) \Omega^{-1}(t_2) \Omega(t_1) dt_2 dt_1 \cdot \log p.$$

Here m_{v_i} is an intersection multiplicity function on $\operatorname{GL}_2(\mathbb{Q}_p)/U_p$ in the ordinary case [34, 5.5 Ordinary case] (see also [29, p. 613]), analog to the one in 3.4.5. This equation is a combination of the ordinary intersection number on integral model of the modular curve (see [31, 8.4] or [29, Proposition 8.5]) and the following analog of (3.18): for $\delta \in K^{\times}$,

(4.32)
$$(\delta^* Z_{t_2,0} \cdot Z_{t_2,0})_{\mathcal{Y}'_{P_{t_2,0}}} = (-q(\delta))^{k-1}.$$

The notations in (4.32) are literally defined in the same way as in the paragraph above (3.18). (To deduce (4.32), we note that $\delta^*[Z_{t_2,0}] = q(\delta)^{k-1}[Z_{t_2,0}]$ for the Chow cycles and the self-intersection number of $[Z_{t_2,0}]$ is $(-1)^{k-1}$ by our normalization in 2.2.1.)

Second, we use (4.23) to deduce the equation in the lemma, where

(4.33)
$$n_{\Phi_p}(y,u) = \frac{\log p}{2} \sum_{x \in N_p U_p/U_p - \{1\}} \Phi_p(yx,u) m_{v_1}(x) + \frac{\log p}{2} \sum_{x \in N_p^t U_p/U_p - \{1\}} \Phi_p(yx,u) m_{v_2}(x)$$

is a priori only a smooth function on $K_p \times \mathbb{Q}_p^{\times}$. (See [29, Proposition 8.5].) Here $N_p \subset \text{GL}_2(\mathbb{Q}_p)$ is the upper triangular unipotent subgroup and N_p^t is the transpose.

Finally, we show that $n_{\Phi_p}(y, u)$ is a Schwartz functions on $K_p^{\times} \times \mathbb{Q}_p^{\times}$. We only need to show that for a fixed u, $n_{\Phi_p}(\cdot, u)$ has compact support on K_p^{\times} . Identify \mathbb{B}_p with $M_2(\mathbb{Q}_p)$. Let $\phi_p = \Phi_p(\cdot, u)$. Then the projection of $\operatorname{supp}\phi_p$ to the diagonal of $M_2(\mathbb{Q}_p)$ is compact. Since $\Phi_p \in \mathcal{S}(\mathbb{B}_p^{\times} \times \mathbb{Q}_p^{\times})$ (see (4.23) and (4.24)), $q(\operatorname{supp}\phi_p) \subset \mathbb{Q}_p^{\times}$ is compact. Consider the expression (4.33). Let $y \in K_p^{\times}$ be the diagonal matrix diag(a, b). Then for $x \in N_p$, the diagonal of yx is diag(a, b) and det(yx) = ab. So the condition $yx \in \operatorname{supp}\phi_p$ implies that a, b are contained in a compact subset of \mathbb{Q}_p^{\times} independent of x.

Lemma 4.3.8. We have $2n_{\Phi_p}(y, q(y)^{-1}) = c_{\Phi_p}(y, q(y)^{-1})$ for all $y \in K_p^{\times}$, where c_{Φ_p} is defined in (4.12).

The lemma will be proved in 4.7.

Note that $r(1, [t, t])\phi(y, q(y)^{-1}) = \phi(y, q(y)^{-1})$ for $y \in K_p^{\times}$ and all $\phi \in \mathcal{S}(\mathbb{B}_p \times \mathbb{Q}_p^{\times})$. Thus we have

(4.34)
$$W_1^{(2k)}(1)H(f)_p = -\int_{K^\times \setminus \mathbb{A}_K^{\infty,\times}} \sum_{y \in K^\times} r(1, [t, 1]) \left(\Phi^{p_0,\infty} \cdot c_{\Phi_{p_0}} \right) (y, q(y)^{-1}) \Omega(t) dt$$

4.3.9. Local height at ∞ . By (3.23) and a similar (and easier, since we do not need holomorphic projection) process as in [31, 8.1] (which contains a sign mistake due to the sign mistake in the definition of the Green function in [31, 7.1.3]), we have

(4.35)
$$W_1^{(2k)}(1)H(f)_{\infty} = -\int_{K^{\times} \setminus \mathbb{A}_K^{\infty, \times} / \mathbb{A}^{\infty, \times}} \int_{K^{\times} \setminus \mathbb{A}_K^{\infty, \times}} \mathcal{K}_{r(1, [t_1, t_2])\Phi}^{(\infty)} \Omega^{-1}(t_2) \Omega(t_1) dt_2 dt_1.$$

See (4.14) for the definition of $\mathcal{K}_{\Phi}^{(\infty)}$.

4.3.10. Conclusion. Define the following automorphic forms of $GL_{2,\mathbb{Q}}$:

(4.36)
$$I(g,\Phi) := \int_{K \times \backslash \mathbb{A}_{K}^{\infty,\times}} \Pr I'(0,g,r(1,[t,1])\Phi)\Omega(t)dt;$$

(4.37)
$$\theta_{d,p}(g,\Phi) := \int_{K^{\times} \setminus \mathbb{A}_{K}^{\infty,\times} / \mathbb{A}^{\infty,\times}} \int_{K^{\times} \setminus \mathbb{A}_{K}^{\infty,\times}} \Pr \theta(g, [t_{1}, t_{2}], d_{\Phi_{p}} \otimes \Phi^{p}) \Omega^{-1}(t_{2}) \Omega(t_{1}) dt_{2} dt_{1};$$

(4.38)
$$\theta_{l,p}(g,\Phi) := \int_{K^{\times} \setminus \mathbb{A}_{K}^{\infty,\times}/\mathbb{A}^{\infty,\times}} \int_{\mathbb{Q}^{\times} \setminus \mathbb{A}^{\infty,\times}} \Pr \theta(g, [t_{1}, t_{2}], l_{\Phi_{p}} \otimes \Phi^{p}) \Omega^{-1}(t_{2}) \Omega(t_{1}) dz dt_{1}.$$

Assume Assumption 5. Combining (4.15), (4.16), (4.27), (4.29), (4.31), (4.34) and (4.35), we have

(4.39)
$$2W_1^{(2k)}(1)H(f) = I(1,\Phi)_{\psi} + \sum_{p \in S_n} (\theta_{d,p}(1,\Phi)_{\psi} - \theta_{l,p}(1,\Phi)_{\psi}).$$

Here each term on the right hand is the value of the corresponding ψ -Whittaker function at g = 1. Finally, we remark that without Assumption 5, an analog of (4.39) will be deduced from a result of S. Zhang [32], see (4.44).

4.4. Proof of Theorem 2.3.3.

4.4.1. Notations. We continue to use the notations in 4.3. Also recall that \mathcal{A} is our set of automorphic representations of $\operatorname{GL}_2(\mathbb{Q})$ defined in 2.3. In view our convention on the use of the quaternion algebra \mathbb{B} , we consistently consider \mathcal{A} as a set of admissible representations of \mathbb{B}^{\times} via the Jacquet-Langlands correspondence to \mathbb{B}^{\times} (which only happens at ∞ and is injective when restricted to \mathcal{A}). For an open compact subgroup $V \subset \operatorname{GL}_2(\mathbb{A}^{\infty})$, let $\mathcal{A}^V \subset \mathcal{A}$ be the finite subset of representations with nonzero V-invariant vectors.

We fix the standard maximal compact subgroup U^S of $(\mathbb{B}^{S,\infty})^{\times} = \mathrm{GL}_2(\mathbb{A}^{S,\infty})$. Recall that \mathcal{H}^S is the Hecke algebra of bi- U^S -invariant Schwartz functions on $(\mathbb{B}^{S,\infty})^{\times}$.

4.4.2. Refine Theorem 2.3.3. We shall prove Theorem 2.3.3 for $\overline{CM}(\Omega^{-1}, \mathcal{H}^S)$, which our previous set-up is more handy to deal with.

For $f_S \in \operatorname{GL}_2(\mathbb{A}_S)$, consider a subspace of $CM(\Omega^{-1}, \mathcal{H}^S)$:

$$CM(\Omega^{-1}, f_S \mathcal{H}^S) := \{ Z_{\Omega^{-1}, f_S \otimes f^S} : f^S \in \mathcal{H}^S \}$$

Let $\overline{CM}(\Omega^{-1}, f_S \mathcal{H}^S)$ be the image of $CM(\Omega^{-1}, f_S \mathcal{H}^S)$ in $\overline{CM}(\Omega^{-1})$.

Theorem 4.4.1. There is an open compact subgroup $V_S \subset \operatorname{GL}_2(\mathbb{A}_S)$ such that $\overline{CM}(\Omega^{-1}, f_S \mathcal{H}^S)$, as an \mathcal{H}^S -module, is a direct sum of L_{π^S} 's of multiplicity at most one, where $\pi \in \mathcal{A}^{V_S U^S}$.

Proof. By (2.4), $Z_{\Omega^{-1}, f_S \otimes f^{S,\vee}}$ is the image of $Z_{\Omega^{-1}, f_S \otimes 1_{U^S}}$ by f^S under the left action defined in Definition 1. By the finiteness of $\mathcal{A}^{V_S U^S}$, it is enough to show that if f^S acts on π as 0 for all $\pi \in \mathcal{A}^{V_S U^S}$, then $\langle Z_{\Omega, f_0}, Z_{\Omega^{-1}, f_S \otimes f^{S,\vee}} \rangle^{\sharp} = 0$ for all $f_0 \in \mathcal{S}(\mathbb{B}^{\infty,\times})$. By (2.6), it is enough to show that $H(f_0 * (f_S^{\vee} \otimes f^S)) = 0$. Thus the theorem follows from Proposition 4.4.2 below.

Let N be a product of two relatively prime integers which are ≥ 3 . Assume that the prime factors of N are contained in S. Let U = U(N) be the corresponding principal congruence subgroup of $\mathbb{B}^{\infty,\times} = \operatorname{GL}_2(\mathbb{A}^{\infty})$. (Then the component of U outside S coincides with U^S , and we do not have ambiguity about the notation U^S .)

Proposition 4.4.2. There is an open compact subgroup $V_{S_n} \subset U_{S_n}$ such that if $f^S \in \mathcal{H}^S$ acts as 0 on all representations in $\mathcal{A}^{V_{S_n}U^{S_n}}$, then for every pure tensor $f_S = \bigotimes_{p \in S} f_p$ right invariant by U_S , we have $H(f_S \otimes f^S) = 0$.

We will prove Proposition 4.4.2 in 4.4.6, using the comparison (4.39). Before the proof, we need some preparations on the analytic kernels (i.e. the right hand side) in (4.39).

Below we always let $f = f_S \otimes f^S$. Assume that $f_S = \bigotimes_{p \in S} f_p$ and $f^S \in \mathcal{H}^S$. The right invariance of f_S will be imposed in 4.4.5.

4.4.3. Integral representation of L-function. We study the first term on the right hand side of the comparison (4.39), using the fact that it is a kernel function for integral representations of the twisted base change L-functions. The main results are Lemma 4.4.4-4.4.6.

Let Φ_0^{∞} be a Schwartz function on $\mathbb{B}^{\infty} \times \mathbb{A}^{\infty,\times}$ invariant by r(1, [1, h]) for $h \in U$. (Recall that r is the Weil representation and [1, h] is defined in 4.2.1.) Let

$$\Phi_0 = \bigotimes_{p \in S} \Phi_{0,p} \bigotimes \Phi_0^{S,\infty} \bigotimes \Phi_\infty,$$

where Φ_{∞} is the Gaussian as in (4.8). Let

(4.40) $\Phi = r(f) \Phi_0.$

Here we use r(1, [h, 1]) to define r(f), see (4.20). Then Φ is still available by r(1, [1, h]) for $h \in U$.

Let $I(g, \Phi)$ be the automorphic form of $\operatorname{GL}_{2,\mathbb{Q}}$ as in (4.36) (with the current Φ as the input). Let σ be a cuspidal automorphic representation of $\operatorname{GL}_{2,\mathbb{Q}}$ and $\phi \in \sigma$. Consider the Petersson pairing $\langle I(g, \Phi), \phi \rangle$

of $I(g, \Phi)$ and ϕ . We assume that the central character of σ is $\Omega^{-1}|_{\mathbb{A}^{\times}}$ and σ_{∞} is holomorphic discrete of weight 2k. Otherwise, $\langle I(g, \Phi), \phi \rangle = 0$. Let π be the Jacquet-langlands correspondence of σ to \mathbb{B} .

Let W be the ψ^{-1} -Whittaker function of ϕ . Without loss of generality, assume that W is a pure tensor. Also assume that Φ is a pure tensor. For a place v of \mathbb{Q} , define a local integral

$$P_{v}(s,\Omega_{v},\Phi_{v},W_{v}) = \int_{K_{v}^{\times}/\mathbb{Q}_{v}^{\times}} \Omega_{v}(t)dt \int_{N_{v}\backslash\operatorname{GL}_{2}(\mathbb{Q}_{v})} \delta(g)^{s} W_{v}(g)r((g,1))\Phi_{v}(t^{-1},q(t))dg.$$

Here N_v is the upper triangular unipotent subgroup and δ the standard modular character [31, 1.6.6]. Let

$$P_v^{\circ}(s,\Omega_v,\Phi_v,W_v) = \frac{L((s+1)/2,\pi_{K_v}\otimes\Omega_v)}{L(s+1,\eta_v)}P_v(s,\Omega_v,\Phi_v,W_v),$$

where η is the Hecke character of \mathbb{Q}^{\times} associated to K via the class field theory. Then (up to normalizing the measures)

$$P_v^{\circ}(0,\Omega_v,\Phi_v,W_v) = \alpha_{\pi_v}^{\sharp}(\Theta_v(\Phi_v \otimes W_v)),$$

where $\alpha_{\pi_v}^{\sharp}$ is defined in 2.4.1 (and $\alpha_{\pi_{\infty}}^{\sharp}$ is defined similarly), and $\Theta_v(\Phi_v \otimes W_v) \in \pi_v \boxtimes \tilde{\pi}_v$ is the normalized local Shimizu lifting [31, 2.2.2]. Let $\Theta = \prod_v \Theta_v$ where the product is over all places of \mathbb{Q} .

By [31, 2.3], (up to normalization of the measures) we have

$$\langle I(\cdot, \Phi), \phi \rangle = \frac{d}{ds}|_{s=0} \left(\prod_{v} P_v(s, \Omega, \Phi, W) \right).$$

where the product is over all places of \mathbb{Q} .

If $L(1/2, \pi_K \otimes \Omega) = 0$, then

(4.41)
$$\langle I(\cdot, \Phi), \phi \rangle = \frac{L'(1/2, \pi_K \otimes \Omega)}{L(1, \eta)} \alpha^{\sharp}_{\pi}(\Theta(\Phi \otimes W)).$$

Assume that $L(1/2, \pi_K \otimes \Omega) \neq 0$. Then $\epsilon(1/2, \pi_K \otimes \Omega) = 1$. Since $\epsilon(1/2, \pi_{K_{\infty}} \otimes \Omega_{\infty})\Omega_{\infty}(-1) = -1$ (indeed, Ω_{∞} is trivial), there exists $p \in S$ (necessary nonsplit in K) such that $\epsilon(1/2, \pi_{K_p} \otimes \Omega_p)\Omega_p(-1) = -1$. Let π'_p be the Jacquet-Langlands correspondence of σ_p to $B(p)_p^{\times}$. By the theorem of Tunnell [25] and Saito [23], $\operatorname{Hom}_{K_p}(\pi_p \otimes \Omega_p, \mathbb{C}) = 0$ and $\operatorname{Hom}_{K_p}(\pi'_p \otimes \Omega_p, \mathbb{C}) \neq 0$. In particular, $\alpha_{\pi_p}^{\sharp}(\Theta_p(\Phi_p \otimes W_p)) = 0$ and $\pi'_p \neq \{0\}$. From $\alpha_{\pi_p}^{\sharp}(\Theta_p(\Phi_p \otimes W_p)) = 0$, we have

(4.42)
$$\langle I(\cdot, \Phi), \phi \rangle = \frac{L(1/2, \pi_K \otimes \Omega)}{L(1, \eta)} (P_p^{\circ})'(0, \Omega_p, \Phi_p, W_p) \alpha_{\pi^p}^{\sharp}(\Theta^p(\Phi^p \otimes W^p)).$$

We need to control $(P_p^{\circ})'(0, \Omega_p, \Phi_p, W_p)$ using π'_p , as follows.

Lemma 4.4.3. Assume that p is nonsplit in K such that $\epsilon(1/2, \pi_{K_p} \otimes \Omega_p)\Omega_p(-1) = -1$. There is an open compact subgroup U'_p of $B(p)_p^{\times}$ such that $(P_p^{\circ})'(0, \Omega_p, \Phi_p, W_p) = 0$ unless π'_p has a nonzero U'_p -invariant vector. Here U'_p is uniform for all such π_p and all $f_p \in \mathcal{S}(\operatorname{GL}_2(\mathbb{Q}_p))$. (Note that $\Phi_p = r(f_p) \Phi_{0,p}$, see (4.40).)

We will prove Lemma 4.4.3 in 4.6.

Lemma 4.4.4. There is an open compact subgroup $V_{S_n} \subset U_{S_n}$ such that if $f^S \in \mathcal{H}^S$ acts as 0 on all representations in $\mathcal{A}^{V_{S_n}U^{S_n}}$, then $I(g, \Phi) = 0$.

Proof. We show that there exists V_{S_n} such that for every f^S as in the lemma and every cusp form ϕ of $\operatorname{GL}_{2,\mathbb{Q}}, \langle I(g, \Phi), \phi \rangle = 0$. Then the lemma follows. We may and we do assume that $\phi \in \sigma$ as above. Let π and W be as above.

Since Θ is $\mathbb{B}^{\times} \times \mathbb{B}^{\times}$ -equivariant [31, 2.2.2] (we only use the second \mathbb{B}^{\times} here) and Φ is right U-invariant, $\Theta(\Phi \otimes W) \in \pi \boxtimes \tilde{\pi}$ is U-invariant, where U acts on $\tilde{\pi}$. By (4.41) and (4.42), a necessary condition for $\langle I(\cdot, \Phi), \phi \rangle$ to be nonzero is:

- (1) if $L(1/2, \pi_K \otimes \Omega) = 0$, then $\pi \in \mathcal{A}^U$;
- (2) if $L(1/2, \pi_K \otimes \Omega) \neq 0$, then there exists $p \in S_n$ such that the Jacquet-Langlands correspondence of σ to $B(p)^{\times}$ has a nonzero $U'_p U^p$ -invariant vector, where U'_p is as in Lemma 4.4.3.

In case (2), there are still only finitely many such σ . Let V_p an open compact subgroup of U_p such that the Jacquet-Langlands correspondence of σ_p , for every such σ , to \mathbb{B}_p^{\times} has a nonzero V_p -invariant vector. Thus $\pi \in \mathcal{A}^{V_{S_n}U^{S_n}}$. Let f^S act as 0 on π , we only need to show that $\langle I(\cdot, \Phi), \phi \rangle = 0$.

Note that by the $\mathbb{B}^{\times} \times \mathbb{B}^{\times}$ -equivariance of Θ (we only use the first \mathbb{B}^{\times} here), we have

$$\Theta^{S,\infty}(\Phi^{S,\infty} \otimes W^{S,\infty}) = \pi(f^S)\Theta^{S,\infty}\left(\Phi_0^{S,\infty} \otimes W^{S,\infty}\right).$$
(4.41) and (4.42).

Then $\langle I(\cdot, \Phi), \phi \rangle = 0$ by (4.41) and (4.42).

Lemma 4.4.5. Assume that $\Phi_0^{S,\infty}$ is invariant by the standard maximal compact subgroups of $\operatorname{GL}_2(\mathbb{A}^{S,\infty})$ and $(\mathbb{B}^{S,\infty})^{\times}$, where $g \in \operatorname{GL}_2(\mathbb{A}^{S,\infty})$ acts by r(g,1) and $h \in (\mathbb{B}^{S,\infty})^{\times}$ acts by r(1,[h,1]). We have $I(g,\Phi) = \rho_{\operatorname{GL}_2}(f^{S,\vee})I(g,\Phi_0)$. Here $\rho_{\operatorname{GL}_2}(f^S)$ is the usual Hecke action of f^S , regarded as a Schwartz function on $\operatorname{GL}_2(\mathbb{A}^{S,\infty})$ via $(\mathbb{B}^{S,\infty})^{\times} = \operatorname{GL}_2(\mathbb{A}^{S,\infty})$.

Proof. It is enough to show that for every cusp form ϕ of $GL_{2,\mathbb{Q}}$, we have

$$\langle I(g,\Phi),\phi\rangle = \langle I(g,\Phi_0),\rho_{\mathrm{GL}_2}(f^S)\phi\rangle$$

Again, we assume that $\phi \in \sigma$ as above, and let π and W be as above. By (4.41) and (4.42), the lemma follows from the following equations for $p \notin S$:

$$\Theta_p(\Phi_p \otimes W_p) = \pi_p(f_p)\Theta_p(\Phi_{0,p} \otimes W_p) = \Theta_p(\Phi_{0,p} \otimes \sigma_p(f_p)W_p)$$

where the first equation is the $\mathbb{B}_p^{\times} \times \mathbb{B}_p^{\times}$ -equivariance of Θ_p , and the second equation is the unramified Shimizu lifting.

Define a "special value" version of $I(g, \Phi)$ by

$$J(g,\Phi) := \int_{K^{\times} \backslash \mathbb{A}_{K}^{\infty,\times}} \Pr{I(0,g,r(1,[t,1])\Phi)\Omega(t)} dt.$$

Lemma 4.4.6. In Lemma 4.4.4 and Lemma 4.4.5, replacing $I(g, \Phi)$ by $J(g, \Phi)$, the same results hold.

Proof. The proofs are similar to the proofs of Lemma 4.4.4 and Lemma 4.4.5. It is in fact easier since we only need to use $\langle J(\cdot, \Phi), \phi \rangle = \frac{L(1/2, \pi_K \otimes \Omega)}{L(1, \eta)} \alpha_{\pi}^{\sharp}(\Theta(\Phi \otimes W))$ instead of (4.41) and (4.42). In particular, we do not need Lemma 4.4.3.

4.4.4. More on the multiplicity function m_p . We study the first term in the second term on the right hand side of the comparison (4.39). The main result is Corollary 4.4.9.

Let λ be the invariant defined in 3.4.1. We abuse notation and use λ to denote this invariant on both \mathbb{B}_p and $B(p)_p$.

Lemma 4.4.7. Let V be an open compact neighborhood of 0 in \mathbb{Q}_p . For V large enough, there exists an open compact subgroup U'_p of $B(p)_p^{\times}$ such that for all $x \in \mathbb{B}_p^{\times}$ with $\lambda(x) \notin V$, $m_p(y, x)$ is left U'_p -invariant as a function on y.

Proof. We need some notations defined in 3.4.5. Let S_{U_p} be the base change to $\mathcal{O}_{F_p^{ur}}$ of the supersingular formal deformation space of level U_p . (This notation is slightly different from 3.4.5 for convenience.) Let S'_{U_p} be the minimal desingularization of S_{U_p} . For $(y, x) \in B(p)_p^{\times} \times_{K_p^{\times}} \mathbb{B}_p^{\times}$, let (y, x) denote its image in S_{U_p} and let (y, x)' denote its image in S'_{U_p} . Then $m_p(y, x)$ is the intersection number of (y, x)' and (1, 1)' on S'_{U_p} , and we let $\mu_p(y, x)$ be the intersection number of (y, x) and (1, 1) on S_{U_p} .

We have the following explicit formula of $\mu_p(y, x)$ [19, Theorem 1.3]:

$$\mu_p(y,x) = c \int_{g \in U_p x} |(1 - \lambda(y)) - (1 - \lambda(g))|_p dg,$$

where c is a nonzero constant independent of y, g. Recall $1 - \lambda(y) = \frac{1}{1 - \operatorname{inv}(y)}$ (see 3.4.1) where $\operatorname{inv}(y) \in \epsilon \operatorname{Nm}(K_p^{\times}) \cup \{0, \infty\}$ with $\epsilon \notin \operatorname{Nm}(K_p^{\times})$ (see 3.1.2). Since $|1 - \operatorname{inv}(y)|_p \ge 1$, $|1 - \lambda(y)|_p \le 1$. Thus $\mu_p(y, x)$ does not depend on y for $\lambda(x)$ large enough.

By the projection formula, $m_p(y, x) - \mu_p(y, x)$ is the intersection number of $(y, x)' \in \mathcal{S}'_{U_p}$ with the vertical part C of the preimage of $(1, 1) \in \mathcal{S}_{U_p}$ by the morphism $\mathcal{S}'_{U_p} \to \mathcal{S}_{U_p}$. Let U'_p be the stabilizer of C. Then the lemma follows from Lemma 3.4.2 (2).

Remark 4.4.8. The condition that \mathbb{B}_p is a matrix algebra is essential in Lemma 4.4.7. If \mathbb{B}_p is a division algebra, an explicit formula of the corresponding $\mu_p(y, x)$ is not known yet.

Corollary 4.4.9. For U_p small enough, there exists an open compact subgroup U'_p of $B(p)_p^{\times}$ such that $d_p = k_p - m_p$ is left U'_p -invariant. In particular, d_{ϕ} (see (4.28)) is left U'_p -invariant for all $\phi \in \mathcal{S}(\mathbb{B}_p \times \mathbb{Q}_p^{\times})$. *Proof.* Let V be an open compact neighborhood of 0 in \mathbb{Q}_p such that both Lemma 4.2.14 and Lemma 4.4.7 hold. We only need to show that for $x \in \lambda^{-1}(V) \subset \mathbb{B}_p^{\times}$, $d_p(y, x)$ is left U'_p -invariant for some U'_p .

By Lemma 3.4.1 (1), Lemma 4.2.11 and Corollary 4.3.5, we only need to show that

$$\{(y,x)\in B(p)_p^{\times}\times_{K_p^{\times}}\mathbb{B}_p^{\times}:\lambda(x)\in V,\ q(y)q(x)\in q(U_p)\}$$

is compact. Up to the K_p^{\times} -action, we may assume that y is in a fixed compact subset of $B(p)_p^{\times}$ (here we use that $B(p)_p$ is a division algebra), so that q(x) is in a fixed compact subset $U_1 \subset \mathbb{Z}_p^{\times}$. Write $x = a + bj_p$ as in 3.1.2. Then b is in a fixed compact subset $U_2 \subset K^{\times}$ by $\lambda(x) \in V$. By $q(x) \in U_1$, a is in a fixed compact subset $U_3 \subset K$. Let $U_3 = U_{3,1} \cup U_{3,2}$ where $U_{3,1}$ is a compact subset of K_p^{\times} and $U_{3,2}$ is a small compact neighborhood of 0. If $a \in U_{3,1}, a + bj \in U_{3,1}(1 + U_{3,1}U_2j)$, which is compact. If $a \in U_{3,1}$, then by $q(x) \in U_1$, b is in a compact subset $U_{2,1} \subset K_p^{\times}$. Then $a + bj \in U_{2,1}(U_{2,1}U_3 + j)$, which is compact. \Box

4.4.5. Proposition 4.4.2 under Assumption 5. Still, let $\Phi = r(f) \Phi_0$ be as in (4.40). Assume that $f_S = \bigotimes_{p \in S} f_p$ is right invariant by U_S . For $p \in S_n$, let the automorphic forms $\theta_{d,p}(g, \Phi)$ and $\theta_{l,p}(g, \Phi)$ of $\operatorname{GL}_{2,\mathbb{Q}}$ be as in (4.37) and (4.38).

Lemma 4.4.10. There is an open compact subgroup $V_{S_n} \subset U_{S_n}$ such that if $f^S \in \mathcal{H}^S$ acts as 0 on all representations in $\mathcal{A}^{V_{S_n}U^{S_n}}$, then for every f_S satisfying Assumption 5, $\theta_{d,p}(g,\Phi) = \theta_{l,p}(g,\Phi) = 0$ for all $p \in S_n$.

Proof. Let $U'_p \subset B(p)^{\times}$ such that both Lemma 4.3.6 and Corollary 4.4.9 hold. There are only finitely many automorphic representations π of $B(p)^{\times}$ with nonzero $U'_p U^p$ -invariant vectors such that the central character of π is $\Omega^{-1}|_{\mathbb{A}^{\times}}$ and the Jacquet-Langlands correspondence of π_{∞} to $\operatorname{GL}_2(\mathbb{R})$ is holomorphic discrete of weight 2k. Choose $V_p \subset U_p$ such that for every such π , the Jacquet-Langlands correspondence of π_p to \mathbb{B}_p^{\times} has nonzero V_p -invariant vectors. Let $V_{S_n} = \prod_{p \in S_n} V_p$.

We show that for every $f = f_S \otimes f^S$ as in the lemma and every cusp form ϕ of $\operatorname{GL}_{2,\mathbb{Q}}$, the Petersson pairings $\langle \theta_{d,p}(g,\Phi),\phi\rangle$ and $\langle \theta_{l,p}(g,\Phi),\phi\rangle$ are 0, where $p \in S_n$. Let ϕ be in a cuspidal automorphic representation σ . We assume that the central character of σ is $\Omega^{-1}|_{\mathbb{A}^{\times}}$ and σ_{∞} is holomorphic discrete of weight 2k. (Otherwise, $\langle \theta_{d,p}(g,\Phi),\phi\rangle = \langle \theta_{l,p}(\cdot,\Phi),\phi\rangle = 0$ already holds.) Consider $\langle \operatorname{Pr} \theta(\cdot,h,d_{\Phi_p}\otimes\Phi_0^p),\phi\rangle$ as a function on $h \in (B(p)^{\times} \times B(p)^{\times})$ (A). Let us show that

$$\langle \Pr \theta(\cdot, h, d_{\Phi_p} \otimes \Phi^p), \phi \rangle = 0.$$

Then $\langle \theta_{d,p}(g, \Phi), \phi \rangle = 0$ by definition.

Note that $\langle \operatorname{Pr} \theta(\cdot, h, d_{\Phi_p} \otimes \Phi_0^p), \phi \rangle$ lies in the global Shimizu lifting $\pi' \boxtimes \widetilde{\pi}'$ of σ [31, 2.2]. Here π' is the Jacquet-Langalnds correspondence of σ to $B(p)^{\times}$. By the $(B(p)^{\times} \times B(p)^{\times})(\mathbb{A})$ -equivariance of the formation of the theta series, $\langle \operatorname{Pr} \theta(\cdot, h, d_{\Phi_p} \otimes \Phi_0^p), \phi \rangle$ is invariant by $U'_p \times U^p \subset (B(p)^{\times} \times B(p)^{\times})(\mathbb{A})$. Thus π' has a nonzero $U'_p U^p$ -invariant vector. By the $(B(p)^{\times} \times B(p)^{\times})(\mathbb{A})$ -equivariance again, we have

(4.43)
$$\langle \Pr \theta(\cdot, h, d_{\Phi_p} \otimes \Phi^p), \phi \rangle = \pi'(f^p) \langle \Pr \theta(\cdot, h, d_{\Phi_p} \otimes \Phi^p_0), \phi \rangle.$$

Since $f^S \in \mathcal{H}^S$ acts as 0 on π' by our choice of V_{S_n} , $\langle \Pr \theta(\cdot, h, d_{\Phi_p} \otimes \Phi^p), \phi \rangle = 0$ by (4.43).

By the same argument, we have $\langle \theta_{l,p}(\cdot, \Phi), \phi \rangle = 0$. The lemma is proved.

Combining (4.39), Lemma 4.4.4 and Lemma 4.4.10, we have the following corollary.

Corollary 4.4.11. Proposition 4.4.2 holds under Assumption 5 on f_S .

4.4.6. Proof of Proposition 4.4.2. For a positive integer N_0 with prime factors in S, let $U_0(N_0)$ be the open compact subgroup of $\mathbb{B}^{\infty,\times}$ corresponding to the usual congruence subgroup $\Gamma_0(N_0)$.

Theorem 4.4.12. Assume that N_0 is the product of two relatively prime integers which are ≥ 3 whose prime factors are all split in K. Then Proposition 4.4.2 holds for $f_S = 1_{U_0(N_0)_S}$.

Proof. The theorem follows from a result of S. Zhang [32, Theorem 0.2.1].

Let $S_{2k}(N_0)$ be the space of $U_0(N_0)$ -invariant automorphic forms of $\operatorname{GL}_2(\mathbb{Q})$ holomorphic of weight 2k. For a positive integer n with prime factors outside S, let $A_n \in \mathcal{H}^S$ be as in Remark 2.1.3. Let $\psi_n := \psi(n \cdot)$. By [32, Theorem 0.2.1], there exists $\Phi_{N_0,S} \in \mathcal{S}(\mathbb{B}_S^{\times})$ such that for

$$\Phi_{N_0} = \Phi_{N_0,S} \bigotimes \bigotimes \mathbb{1}_{M_2(\widehat{\mathbb{Z}}^S) \times \widehat{\mathbb{Z}}^{S,\times}} \bigotimes \Phi_{\infty},$$

where Φ_{∞} is the Gaussian as in (4.8), we have $I(g, \Phi_{N_0}), J(g, \Phi_{N_0}) \in S_{2k}(N_0)$, and

$$H(1_{U_0(N)_S} \otimes A_n) = a \cdot I(1, \Phi_{N_0})_{\psi_n} + b \cdot J(1, \Phi_{N_0})_{\psi_n}.$$

Here a, b are constants independent of n (indeed, a, b are multiples of $L(1, \eta^{\infty})$ and $L'(1, \eta^{\infty})$ respectively, see [10, p. 271]). Regarded A_n as a Schwartz function on $\operatorname{GL}_2(\mathbb{A}^{S,\infty})$ via $(\mathbb{B}^{S,\infty})^{\times} = \operatorname{GL}_2(\mathbb{A}^{S,\infty})$. Then

$$I(1, \Phi_{N_0})_{\psi_n} = (\rho_{\mathrm{GL}_2}(A_n)I(1, \Phi_{N_0}))_{\psi},$$

and

$$J(1, \Phi_{N_0})_{\psi_n} = (\rho_{\mathrm{GL}_2}(A_n)J(1, \Phi_{N_0}))_{\psi}.$$

Indeed, span $I(g, \Phi_{N_0})$ (resp. $J(g, \Phi_{N_0})$) as a linear combination of Hecke eigenforms (for all Hecke operators A_n 's). Then the corresponding equation follows from the classical relation between Fourier coefficients and Hecke eigenvalues. On $S_{2k}(N_0)$, $\rho_{\text{GL}_2}(A_n) = \rho_{\text{GL}_2}(A_n^{\vee})$. Then by Lemma 4.4.5 and Lemma 4.4.6, we have

(4.44)
$$H(1_{U_0(N)_S} \otimes A_n) = a \cdot I(1, \Phi)_{\psi} + b \cdot J(1, \Phi)_{\psi},$$

where $\Phi = r \left(\mathbb{1}_{U_0(N)_S} \otimes A_n \right) \Phi_0$, see (4.40). Since the center Then the theorem is implied by Lemma 4.4.4 and Lemma 4.4.6.

Lemma 4.4.13. Functions satisfying Assumption 5 and left translations of $1_{U_0(N_0)_S}$ by $\mathbb{A}_{K,S}^{\times}$ span $\mathcal{S}(\mathbb{B}_S^{\times})$.

Proof. Let $W \subset \mathcal{S}(\mathbb{B}_{S}^{\times})$ be the span. Let $p \in S$. Then $\{f_{p} \in \mathcal{S}(\mathbb{B}_{p}^{\times} - K_{p}^{\times})\}$ and left translations of $1_{U_{0}(N_{0})_{p}}$ by K_{p}^{\times} span $\mathcal{S}(\mathbb{B}_{p}^{\times})$. Thus W contains $\mathcal{S}(\mathbb{B}_{p}^{\times}) \otimes \{1_{U_{0}(N_{0})_{S-\{p\}}}\}$ and its left translations by $\mathbb{A}_{K,S}^{\times}$. Thus the lemma is reduced to the same statement for $S - \{p\}$. So the lemma is proved by induction. \Box

Note that the truth of $H(f_S \otimes f^S) = 0$ and the right invariance of f_S do not change if we left translate f_S by $\mathbb{A}_{K,S}^{\times}$. Thus Proposition 4.4.2 follows from Corollary 4.4.11 and Theorem 4.4.12. So Theorem 4.4.1 and Theorem 2.3.3 are proved.

4.5. **Proof of Theorem 2.3.6 and Theorem 2.3.8.** We shall prove Theorem 2.3.6 and Theorem 2.3.8 for $\overline{CM}(\tilde{\pi})$, which our previous set-up is more handy to deal with.

Let T be a finite set of finite places of \mathbb{Q} which contains all places of \mathbb{Q} ramified in K or ramified for Ω . (We changed the previous notation S to T for later convenience.) For $f \in \mathcal{S}(\mathrm{GL}_2(\mathbb{A}_T)) \otimes \mathcal{H}^T$, let $z_{\Omega^{-1},f}$ be the image of $Z_{\Omega^{-1},f}$ in $\overline{CM}(\Omega^{-1})$. For $\pi \in \mathcal{A}^{U^T}$, let $z_{\Omega^{-1},f,\tilde{\pi}}$ be the L_{π^T} -component of $z_{\Omega^{-1},f}$ via Theorem 2.3.3. By (2.4) and Definition 1, Theorem 2.3.6 and Theorem 2.3.8 are equivalent to the following theorem.

Theorem 4.5.1. (1) Assume that $L(1/2, \pi_K \otimes \Omega) = 0$. If $f_T \in \operatorname{GL}_2(\mathbb{A}_T)$ acts as 0 on π_T , then $z_{\Omega^{-1}, f_T^{\vee} \otimes f^T, \tilde{\pi}} = 0$ for all $f^T \in \mathcal{H}^T$.

(2) Assume that $\epsilon(1/2, \pi_{K_p} \otimes \Omega_p)\Omega_p(-1) = -1$ for more than one $p < \infty$. Then $z_{\Omega^{-1}, f_T^{\vee} \otimes f^T, \widetilde{\pi}} = 0$ for all $f_T \in \mathrm{GL}_2(\mathbb{A}_T)$ and $f^T \in \mathcal{H}^T$.

The proof of Theorem 4.5.1 is a continuation of the proof of Theorem 4.4.1.

Proof of Theorem 4.5.1. By definition, $z_{\Omega^{-1},f_T^{\vee}\otimes f^T,\widetilde{\pi}}$ is given as follows. Choose a finite subset \mathcal{A}_1 of \mathcal{A} containing π such that of $z_{\Omega^{-1},f_T^{\vee}\otimes f^T}$ lies in the sum of the $L_{\widetilde{\pi}_1^T}$ -components of $\overline{CM}(\Omega^{-1},\mathcal{H}^T)$ over all $\pi_1 \in \mathcal{A}_1$. Choose $f_1^T \in \mathcal{H}^T$ which acts as identity on π_1 if $\pi_1 = \pi$, and as 0 otherwise. (This is possible by the strong multiplicity one theorem [21].) Then $z_{\Omega^{-1},f_T^{\vee}\otimes f^T,\widetilde{\pi}} = z_{\Omega^{-1},(f_T^{\vee}\otimes f^T)*f_1^{T,\vee}}$.

We choose \mathcal{A}_1 and f_1^T as follows. Let $p_0 \notin T$ be a finite place of \mathbb{Q} inert in K such that $f_{p_0} = 1_{\mathrm{GL}_2(\mathbb{Z}_p)}$. Let $S = T \cup \{p_0\}$ and let \mathcal{A}_1 be $\mathcal{A}^{V_{S_n}U^{S_n}}$ in Proposition 4.5.2 below. Choose $f_1^S \in \mathcal{H}^S$ which acts as identity on $\pi_1 \in \mathcal{A}_1$ if $\pi_1 = \pi$, and as 0 otherwise. Let $f_{1,p_0} \in \mathcal{H}_{p_0}$ (the unramified Hecke algebra at p_0) vanish on $K_{p_0}^{\times}$ and act as identity on π . (The existence of such f_{1,p_0} is easy to prove.) Let $f_1^T = f_{1,p_0} \otimes f_1^S$ By (2.6), the theorem follows from Proposition 4.5.2 below.

Proposition 4.5.2. Let $f_S \in \mathcal{S}(\mathrm{GL}_2(\mathbb{A}_S))$ be right U_S -invariant such that Assumption 5 holds. Let $V_{S_n} \subset U_{S_n}$ be as in the proof of Lemma 4.4.4 and Lemma 4.4.10. Assume that $f^S \in \mathcal{H}^S$ acts as 0 on all representations in $\mathcal{A}^{V_{S_n}U^{S_n}}$ other than π . Then $H(f_S \otimes f^S) = 0$ under (1) or (2):

- (1) $L(1/2, \pi_K \otimes \Omega) = 0$ and f_S acts as 0 on π ;
- (2) $\epsilon(1/2, \pi_{K_v} \otimes \Omega_v) \Omega_v(-1) = -1$ for more than one $v < \infty$.

We use the proofs of Lemma 4.4.4 and Lemma 4.4.10. The new ingredient is to apply the Waldspurger formula under the condition $L(1/2, \pi_K \otimes \Omega) = 0$.

Proof. Let $\Phi = r(f_S \otimes f^S) \Phi_0$ be as in (4.40). By (4.39), we only need to show that for every cusp form ϕ of $\operatorname{GL}_{2,\mathbb{Q}}$, the Petersson pairings $\langle I(g, \Phi), \phi \rangle$, $\langle \theta_{d,p}(g, \Phi), \phi \rangle$ and $\langle \theta_{l,p}(g, \Phi), \phi \rangle$ for $p \in S_n$ are 0. As in the proof of Lemma 4.4.4 and Lemma 4.4.10, let σ be a cuspidal automorphic representation of $\operatorname{GL}_{2,\mathbb{Q}}$ with central character $\Omega^{-1}|_{\mathbb{A}^{\times}}$ and σ_{∞} holomorphic discrete of weight 2k. And we may assume that $\phi \in \sigma$.

First, we claim that $\langle \theta_{d,p}(g,\Phi),\phi\rangle$ and $\langle \theta_{l,p}(g,\Phi),\phi\rangle$ are 0 for all $p \in S_n$. Let π' be the Jacquet-Langalnds correspondence of σ to $B(p)^{\times}$. By the reasoning in the paragraph of (4.43) in the proof of Lemma 4.4.10 and our assumption on $f^S \in \mathcal{H}^S$, $\langle \Pr \theta(\cdot, h, d_{\Phi_p} \otimes \Phi^p), \phi\rangle$ is 0 unless $\pi'^{S,\infty} = \pi^{S,\infty}$ as representations of $B(p)^{\times}(\mathbb{A}^{S,\infty}) \simeq (\mathbb{B}^{S,\infty})^{\times}$. Assume this is case. Then π is the Jacquet-Langlands correspondence of σ to \mathbb{B}^{\times} . In particular, $L(1/2, \pi'_K \otimes \Omega) = L(1/2, \pi_K \otimes \Omega)$, and $\pi'^p = \pi^p$ as representations of $B(p)^{\times}(\mathbb{A}^p) \simeq (\mathbb{B}^p)^{\times}$. If $L(1/2, \pi_K \otimes \Omega) = 0$, by the Waldspurger formula [31, 1.4.2] (or more directly, the fourth equation on [31, p 44]), the claim follows. Now assume that $\epsilon(1/2, \pi_{K_v} \otimes \Omega_v)\Omega_v(-1) = -1$ for more than one $v < \infty$. (Such v is necessary in S_n .) In particular, there is $v \in S_n - \{p\}$ such that $\epsilon(1/2, \pi'_{K_v} \otimes \Omega_v)\Omega_v(-1) = -1$. By the theorem of Tunnell [25] and Saito [23], $\operatorname{Hom}_{K_v}(\pi'_v \otimes \Omega_v, \mathbb{C}) = 0$. Recall that as a function on $h \in (B(p)^{\times} \times B(p)^{\times})$ (\mathbb{A}), $\langle \Pr \theta(\cdot, h, d_{\Phi_p} \otimes \Phi_0^p), \phi \rangle$ lies in the global Shimizu lifting $\pi' \boxtimes \tilde{\pi}'$ of σ [31, 2.2]. By the definition (4.37) of $\theta_{d,p}(g,\Phi)$, $\langle \theta_{d,p}(g,\Phi), \phi \rangle = 0$. Similarly, $\langle \theta_{l,p}(g, \Phi), \phi \rangle = 0$. Thus the claim follows. (Since local Shimizu lift is involved in the fourth equation on [31, p 44], we can use it to replace the global Shimizu lifting. However, this is overkilling.)

Now, we prove that $\langle I(g, \Phi), \phi \rangle = 0$. By the reasoning in the proof of Lemma 4.4.4 and the assumption on f^S , the Petersson pairing $\langle I(g, \Phi), \phi \rangle$ is 0 unless the Jacquet-langlands correspondence of σ to \mathbb{B} is π . Assume (1) so that we are in the case of (4.41). Then $I(g, \Phi) = 0$ by the assumption on f_S . Assume (2). There is $v \in S_n - \{p\}$ such that $\epsilon(1/2, \pi_{K_v} \otimes \Omega_v)\Omega_v(-1) = -1$. Then both (4.41) and (4.42) are 0 by the theorem of Tunnell [25] and Saito [23].

Remark 4.5.3. In condition (1), the part for f_S is only used in proving that $\langle I(g, \Phi), \phi \rangle = 0$.

4.6. Aid from the weight 2 case I. We prove Lemma 4.4.3 in this subsection. Though it is purely local and purely analytic, we prove it via a global method and use the work of Yuan, S. Zhang and W. Zhang [31] essentially. We expect that there should be a local proof of Lemma 4.4.3.

First, we recall [31, (1.5.6)] (see also [31, 7.4.3], the second equation on page 227). Let \mathbb{B} be as in 4.3.1. Let $\Phi^{(2)} = \Phi_p^{(2)} \otimes \Phi_{\infty}^{(2)} \otimes \Phi^{(2),p,\infty} \in \mathcal{S}(\mathbb{B}^{\times})$ such that

- (1) $\Phi_p^{(2)} = \Phi_p$ where Φ_p is the one in Lemma 4.4.3;
- (2) $\Phi_{\infty}^{(2)}$ is the standard Gaussian used in [31, 4.1.1] (same with our definition (4.8) if we let k = 1 in (4.8));
- (3) $\Phi^{(2),p,\infty}$ satisfies the degeneracy conditions in [31, 5.2] such that $\alpha^{\sharp}_{\sigma^{(2),p}}(\Theta^p(\Phi^{(2),p}\otimes W^{(2),p}))\neq 0.$

The existence of such $W_p^{(2)}$ and $\Phi^{(2),p,\infty}$ is established in [31, Proposition 5.8]. Note that at p, we do not require the degeneracy condition [31, Assumption 5.3]. However, the analog of (4.29) in this setting still holds by the same proof. Then [31, (1.5.6)] still holds, which is an equation between automorphic forms of $GL_2(\mathbb{Q})$ of weight 2:

(4.45)
$$cZ(g,\Omega,\Phi^{(2)}) = I(g,\Phi^{(2)}) + \sum_{v \in S_{\mathfrak{n}}} (\theta_{d,v}(g,\Phi^{(2)}) - \theta_{l,v}(g,\Phi^{(2)})).$$

Here c is a nonzero constant, $Z(g, \Omega, \Phi^{(2)})$ is the height pairing between a CM divisor and its translation by the generating series of Hecke operators (which is an automorphic form!), and the terms on the right hand side are defined as in 4.3.10, with holomorphic projection of weight 2.

Remark 4.6.1. (1) For $\theta_{d,v}(g, \Phi^{(2)})_{\psi}$ and $\theta_{l,v}(g, \Phi^{(2)})_{\psi}$, the holomorphic projection in 4.3.10 is redundant.

(2) To be precise, in the definition of $\theta_{l,v}(g, \Phi^{(2)})_{\psi}$, the l_{Φ_v} is the one in [31, YZZ]. It is formed in the same way as the one in (4.30), with a different vertical divisor of the desingularized deformation space S'_{U_v} . So it has the same properties with the one in (4.30). (Note that we do not need to know the vertical divisor explicitly.)

Let the notations be as in Lemma 4.4.3. Then

- B(p) is the quaternion algebra over \mathbb{Q} only division at v = p and $v = \infty$;
- π'_p is an irreducible admissible representation of $B(p)_p^{\times}$ such that $\operatorname{Hom}_{K_p}(\pi'_p \otimes \Omega_p, \mathbb{C}) \neq 0$;
- π_p is the Jacquet-Langlands correspondence of π'_p to \mathbb{B}_p^{\times} with $\operatorname{Hom}_{K_p}(\pi_p \otimes \Omega_p, \mathbb{C}) = 0$;
- W_p is in the ψ_p^{-1} -Whittaker model of the Jacquet-Langlands correspondence of π'_p to $\operatorname{GL}_2(\mathbb{Q}_p)$.

By Lemma 3.2.2, there exists an automorphic representation $\pi^{(2)}$ of $B(p)^{\times}$ such that

- $\pi_p^{(2)} = \pi'_p$, and $\pi_{\infty}^{(2)}$ is the trivial representation;
- $\operatorname{Hom}_{K_v}(\pi_v^{(2)} \otimes \Omega_v, \mathbb{C}) \neq 0$ for every place v of \mathbb{Q} .

Let $\sigma^{(2)}$ be the Jacquet-Langlands correspondence of $\pi^{(2)}$ to $\operatorname{GL}_2(\mathbb{Q})$. Then W is in the ψ_p^{-1} -Whittaker model of $\sigma_p^{(2)}$. Let $\phi^{(2)} \in \sigma^{(2)}$, and $\Phi^{(2)} \in \mathcal{S}(\mathbb{B}^{\times})$ such that the ψ^{-1} -Whittaker function $W^{(2)}$ of $\phi^{(2)}$

satisfies $W^{(2)} = W_p^{(2)} \otimes W^{(2),p}$ with $W_p^{(2)} = W_p$. Consider the Petersson inner product of each term of (4.45) with $\phi^{(2)}$.

• Let $v \in S_{\mathfrak{n}}$. Recall that as a function on $h \in (B(v)^{\times} \times B(v)^{\times})$ (A), $\langle \operatorname{Pr} \theta(\cdot, h, d_{\Phi_{v}^{(2)}} \otimes \Phi_{0}^{(2),v}), \phi^{(2)} \rangle$ lies in the global Shimizu lifting $\pi(v) \boxtimes \widetilde{\pi}(v)$ of $\sigma^{(2)}$ [31, 2.2]. Here $\pi(v)$ is the Jacquet-Langalnds correspondence of $\sigma^{(2)}$ to $B(v)^{\times}$. If $v \neq p$, then $\pi(v)_{p} = \pi_{p}$ as representations of $B(v)_{p}^{\times} \simeq \mathbb{B}_{p}^{\times}$. Since $\operatorname{Hom}_{K_{p}}(\pi_{p} \otimes \Omega_{p}, \mathbb{C}) = 0$, by the definition (4.37) of $\theta_{d,v}(g, \Phi^{(2)}), \langle \theta_{d,v}(g, \Phi^{(2)}), \phi^{(2)} \rangle = 0$.

• By [31, Theorem 3.22] and $\operatorname{Hom}_{K_p}(\pi_p \otimes \Omega_p, \mathbb{C}) = 0, \langle Z(g, \Omega, \Phi^{(2)}), \phi^{(2)} \rangle = 0.$

Thus (4.45) implies

$$|I(\cdot, \Phi^{(2)}), \phi^{(2)}\rangle + \langle \theta_{d,p}(\cdot, \Phi^{(2)}), \phi^{(2)}\rangle - \langle \theta_{l,p}(\cdot, \Phi^{(2)}), \phi^{(2)}\rangle = 0.$$

Then by (4.42) and the condition (3) on Φ , Lemma 4.4.3 is implied by the following lemma

Lemma 4.6.2. There is an open compact subgroup U'_p of $B(p)_p^{\times}$ such that the Petersson pairings $\langle \theta(\cdot, h, d_{\Phi_p^{(2)}} \otimes \Phi^{(2),p}), \phi^{(2)} \rangle$ and $\langle \theta(\cdot, h, l_{\Phi_p^{(2)}} \otimes \Phi^{(2),p}), \phi^{(2)} \rangle$ are 0 for all $h \in (B(p)^{\times} \times B(p)^{\times})$ (A) unless $\pi_p^{(2)}$ has a nonzero U'_p -invariant vector.

Proof. The proof is similar to (part of) the proof of Lemma 4.4.10. As functions on $h \in (B(p)^{\times} \times B(p)^{\times})$ (A), $\langle \theta(\cdot, h, d_{\Phi_p} \otimes \Phi^{(2), p}), \phi^{(2)} \rangle$ and $\langle \theta(\cdot, h, l_{\Phi_p} \otimes \Phi^{(2), p}), \phi^{(2)} \rangle$ lie in the global Shimizu lifting [31, 2.2] of $\sigma^{(2)}$, which is $\pi^{(2)} \boxtimes \widetilde{\pi}^{(2)}$ [31, 2.2]. Let U'_p be as in Lemma 4.3.6 and Lemma 4.4.7. By the $(B(p)^{\times} \times B(p)^{\times})$ (A)equivariance of the formation of the theta series, $\langle \theta(\cdot, h, d_{\Phi_p} \otimes \Phi^{(2), p}), \phi^{(2)} \rangle$ and $\langle \theta(\cdot, h, l_{\Phi_p} \otimes \Phi^{(2), p}), \phi^{(2)} \rangle$ are invariant by U'_p , where U'_p acts on the $\pi^{(2)}$ -component of $\pi^{(2)} \boxtimes \widetilde{\pi}^{(2)}$. Then the lemma follows. \Box

4.7. Aid from the weight 2 case II. We prove Lemma 4.3.8 in this subsection. Though it is purely local and purely analytic, we prove it via a global method and use the work of Yuan and S. Zhang [29] essentially. We expect that there should be a local proof of Lemma 4.3.8.

We use the comparison on [29, p 625-627], between the holomorphic projection $\Pr I'(0, g, \phi)$ and the height pairing $Z(g, (1, 1), \phi)$ between a CM point and its translation by the generating series of Hecke operators (unlike in (4.45), where we use a CM divisor), for certain test function ϕ . The conclusion from this comparison is (4.46), from which we prove Lemma 4.3.8.

First, we choose the test function. Let the notations be as in Lemma 4.3.8. In particular, p is split in K and Φ_p vanishes on $K_p \times \mathbb{Q}_p^{\times}$. And \mathbb{B} is as in 4.3.1. We choose $\phi^p \in \mathcal{S}(\mathbb{B}^p \times \mathbb{A}^{p,\times})$ as follows. Let p_1, p_2, p_3 be finite places of \mathbb{Q} split in K. Choose $\phi^p = \phi_{\infty} \otimes \phi_{p_1} \otimes \phi_{p_2} \otimes \phi_{p_3} \otimes \phi^{p,p_1,p_2,p_3,\infty}$ such that

- ϕ_{∞} is the standard Gaussian in $\mathcal{S}(\mathbb{B}_{\infty} \times \mathbb{R}^{\times})$ used in [29, 6.1] (same as [31, 4.1.1], it is also our definition (4.8) if we let k = 1 in (4.8));
- $\phi_{p_1} \in \mathcal{S}(\mathbb{B}_p \times \mathbb{Q}_p^{\times})$ is arbitrary;
- for $i = 2, 3, \phi_{p_i} \in \mathcal{S}(\mathbb{B}_{p_i} \times \mathbb{Q}_{p_i}^{\times})$ such that $r(g)\phi_{p_i}(0, u) = 0$ for all $g \in \mathrm{GL}_2(\mathbb{Q}_{p_i})$ and $u \in \mathbb{Q}_{p_i}^{\times}$ (this is [31, Assumption 5.4], equivalently [31, Assumption 7.1]);
- for $v \neq p, p_1, p_2, p_3, \infty$, let $\phi_v = r(1, [t_v, 1]) \mathbf{1}_{M_2(\mathbb{Z}_v) \times \widehat{\mathbb{Z}}_v^{\times}}$ for some $t_v \in K_v^{\times}$.

Let $\phi = \phi^p \otimes \Phi_p$. Let U be an open compact subgroup $\mathbb{B}^{\infty,\times}$ such that ϕ is right U-invariant. Moreover, for $v \neq p, p_1, p_2, p_3, \infty$, assume that U_v is standard maximal compact subgroup of $\mathbb{B}_v^{\times} = \operatorname{GL}_2(\mathbb{Q}_v)$. Now we perform the comparison on [20, p.625,627]

Now we perform the comparison on [29, p 625-627].

- First, [29, Theorem 7.2] still holds. Moreover, in the expression of $\Pr I'(0, g, \phi)_U$ on [29, p 625], the third and fifth term vanish since Φ_p vanishes on $K_p \times \mathbb{Q}_p^{\times}$. And the fourth term contains only the contribution from the place p by the same reason.
- Second, [29, Theorem 8.6] still holds. Moreover, in the expression of $Z(g, (1, 1), \phi)_U$ on [29, p 625], the third (i.e. the *j*-part) and fourth term vanish. Indeed, the third term only comes from

the split places p, p_1, p_2, p_3 and each contribution vanishes by the condition on ϕ_{p_2}, ϕ_{p_3} , see [31, 8.5.1]. The fourth term vanishes since Φ_p vanishes on $K_p \times \mathbb{Q}_p^{\times}$. And the second term contains only the contribution from the place p by the same reason.

Third, the results (1)-(3) on [29, p 626] hold in our setting and we do not need (4) by the vanishing of the *j*-part. Now explain the validity of (1)-(3). (1) is the same in [29, p 626] and our setting. (2) is the same modulo the facts k_{r(1,[t_v,1])φ_v} = r(1,[t_v,1])k_{φ_v} and m_{r(1,[t_v,1])φ_v} = r(1,[t_v,1])m_{φ_v} [31, Lemma 6.6, Lemma 8.5]. (3) only involves the place p and is given by Lemma 4.2.7 and Lemma 4.3.7.

Finally, since the difference $\Pr I'(0, g, \phi)_U - Z(g, (1, 1), \phi))_U$ automorphic (we are in the weight 2 situtaion), by the same pseudo-theta series argument (i.e. [29, Lemma 6.1 (2)]), we have the analog of the identity above [29, Proposition 9.2]:

(4.46)
$$0 = \sum_{y \in K, \ u \in \mathbb{Q}^{\times}} r_K(g) \left(\phi^p \cdot (2n_{\Phi_p} - c_{\Phi_p}) \right) (y, u)$$

where r_K is the Weil representation of $GL_2(\mathbb{A})$ on the quadratic space \mathbb{A}_K .

Remark 4.7.1. Our identity is simpler than the one above [29, Proposition 9.2], due to the vanishing terms in the first and second point in the last paragraph. In [29, Proposition 9.2], the vanishing terms are explicitly computed for very good test functions.

Taking the ψ -Whittaker function, the value at g = 1 gives

(4.47)
$$0 = \sum_{y \in K^{\times}} \left(\phi^p \cdot (2n_{\Phi_p} - c_{\Phi_p}) \right) (y, q(y)^{-1}).$$

Lemma 4.7.2. For every $y_0 \in K^{\times}$, there exists ϕ^p as above such that the only nonzero summand in (4.47) is the one corresponding to y_0 .

Proof. Note that (4.47) is a finite sum. For $v \neq p, p_1, p_2, p_3, \infty$, let $t_v = y_0$. For i = 2, 3, by [31, Prop 5.15], there exists ϕ_{p_i} nonzero at (1, 1). Since the assumption on ϕ_{p_i} is invariant under the action of $\mathbb{B}_{p_i}^{\times}$, we can choose ϕ_{p_i} to be nonzero at $(y_0, q(y_0)^{-1})$. Note that $\phi_{\infty}(y, u) \neq 0$ for all y, u. Choose ϕ_{p_1} whose support is in a small enough neighborhood of y_0 so that the only possible nonzero term in (4.47) is the one given by y_0 . Then the lemma follows.

Thus $(2n_{\Phi_p} - c_{\Phi_p})(y, q(y)^{-1}) = 0$ for $y \in K^{\times}$. By continuity, Lemma 4.3.8 follows.
