COMPLEXIFIED HERMITIAN SYMMETRIC SPACES, HYPERKÄHLER STRUCTURES, AND REAL GROUP ACTIONS

ABSTRACT. There is a known hyperkähler structure on any complexified Hermitian symmetric space G/K, whose construction relies on identifying G/K with both a (co)adjoint orbit and the cotangent bundle to the compact Hermitian symmetric space G_u/K_0 . Via a family of explicit diffeomorphisms, we show that almost all of the complex structures are equivalent to the one on G/K; via a family of related diffeomorphisms, we show that almost all of the symplectic structures are equivalent to the one on $T^*(G_u/K_0)$. We highlight the intermediate Kähler structures, which share a holomorphic action of G related to the one on G/K, but moment geometry related to that of $T^*(G_u/K_0)$. As an application, for the real form $G_0 \subset G$ corresponding to G_0/K_0 , the Hermitian symmetric space of noncompact type, we give a strategy for study of the action on G/K using the moment-critical subsets for the intermediate structures. We give explicit computations for SL(2).

1. INTRODUCTION

This paper serves two purposes:

- To extend understanding of the hyperkähler structure on complexified Hermitian symmetric spaces.
- To begin an exploration of moment-map techniques in this specific hyperkähler context.

We begin by addressing the first of these purposes. The hyperkähler structure has been developed by several authors, including D. Burns [6], A. Dancer and R. Szöke [7], and culminating in the papers of O. Biquard and P. Gauduchon [1], [2], [3]. (See Section 2 below for notation and basic facts about Hermitian symmetric spaces, and Section 3 for an overview of hyperkähler structures.) The structure relies on two realizations of the complexified Hermitian symmetric spaces, and structures on them, that are linked in a nontrivial way. One such realization is as the adjoint orbit of an element $\Upsilon \in \mathfrak{g}$ by a complex semisimple group G. On this space, there is an obvious complex structure, which we denote J_1 , and the Kirillov-Kostant-Souriau holomorphic symplectic form, which we denote $-\omega_3 + i\omega_2$ (breaking the complex-valued form into its real and imaginary parts). The second such realization of the complexified Hermitian symmetric space is as the cotangent bundle to a flag manifold G/Q; this gives a complex structure J_3 , as well as the usual form on a cotangent bundle. We can write this form as $\omega_1 + i\omega_2$ (where, crucially, the two occurrences of ω_2 coincide). The flag manifold G/Q can be viewed as the adjoint orbit of Υ by a compact real form G_u of G. The bridge between these two realizations (recalled in Section 6) is a G_u -equivariant map that allows us to consider J_1 and ω_3 in the second realization and J_3 and ω_1 in the first realization. Thus in both realizations, we can see the

totality of the hyperkähler structure (complex structures J_1 , J_3 , $J_2 := J_3 J_1$; real symplectic forms $\omega_1, \omega_2, \omega_3$; metric m).

A feature of every hyperkähler structure is the existence, not only of J_1 , J_2 , and J_3 , but of a complex structure for each unit linear combination $J_{(\lambda_1,\lambda_2,\lambda_3)} := \lambda_1 J_1 + \lambda_2 J_2 + \lambda_3 J_3$, which has an associated symplectic form $\omega_{(\lambda_1,\lambda_2,\lambda_3)} := \lambda_1 \omega_1 + \lambda_2 \omega_2 + \lambda_3 \omega_3$. We can identify the triple $(\lambda_1, \lambda_2, \lambda_3)$ with a point λ in the extended complex plane $\mathbb{C} \cup \{\infty\}$ via stereographic projection (Definition 3.1). Remarkably, the complex number λ plays a role in an explicit G_u -equivariant self-bijection T_{λ} of the complexified Hermitian symmetric space, which provides a new understanding of how the complex structure $J_{(\lambda_1,\lambda_2,\lambda_3)}$ and the symplectic form $\omega_{(\lambda_1,\lambda_2,\lambda_3)}$ vary with $(\lambda_1, \lambda_2, \lambda_3)$. The main results are in Section 10. Among them:

- Via the map T_{λ} , each $J_{(\lambda_1,\lambda_2,\lambda_3)}$ except $\pm J_3$ is equivalent to J_1 (Theorem 10.1.)
- Via a map related to T_{λ} , for any $(\lambda_1, \lambda_2, \lambda_3)$ with $\lambda_3 \neq 0$, the symplectic form $\omega_{(\lambda_1, \lambda_2, \lambda_3)}$ is equivalent to a scalar multiple of ω_3 (Theorem 10.4).

Thus, from the point of view of complex structures, we can regard J_1 and the *G*-orbit of Υ as a model for almost all the complex structures and for the associated holomorphic actions of *G*, with a degeneracy at $\pm J_3$. From the point of view of real symplectic geometry and associated moment maps, we can regard the cotangent bundle to the G_u orbit of Υ as a model, with degeneracy along the circle of complex structures that contains J_1 and J_2 .

We now turn briefly to the second purpose of this paper. There is a theory of the use of moment-map techniques to investigate actions of complex reductive groups, notably developed in the work of F. Kirwan ([14]; see also [16], [13]). This theory has received a significant extension to certain actions of real reductive groups, by P. Heinzner, G. Schwarz, and H. Stötzel [9], [10]. Their techniques apply here to the study of the action of G_0 (the real form of G corresponding to the Hermitian symmetric space of noncompact type) on the complexified Hermitian symmetric space. In fact, there is a family of actions of G_0 , the family being parametrized by a 2-sphere, each action corresponding to a choice of $(\lambda_1, \lambda_2, \lambda_3)$, with its complex structure, symplectic form, and moment map. Here, our main results shed light, both qualitatively and computationally, on these actions: we have that most actions are equivalent to the usual one on the G-orbit of Υ ; most moment-critical subsets are equivalent to the ones for the action on the cotangent bundle to G/Q; and the maps T_{λ} allow us to make explicit computations. This points out the singular nature of both of our initial realizations of the complexified Hermitian symmetric space (the ones associated to J_1 and J_3), since for most choices of complex structure (a choice of $(\lambda_1, \lambda_2, \lambda_3)$ with $\lambda_3 \notin \{0, 1, -1\}$), the action is equivalent to the one associated to J_1 (but not J_3), and the symplectic geometry and moment-critical subsets are equivalent to the ones associated to J_3 (but not J_1). It is not hard to imagine that study of these intermediate structures would lead to new perspectives on the more familiar J_1 and J_3 structures, e.g., in the construction of representations. A full working out for arbitrary Hermitian symmetric spaces is beyond the scope of this paper, but in Section 12, we present a detailed account (without proofs) for $G = SL(2, \mathbb{C})$.

It should be noted that hyperkähler structures on coadjoint orbits are known to exist outside of the setting of complexified Hermitian symmetric spaces, and it would be interesting to know how the results of this paper extend. However, only in the Hermitian symmetric setting is the hyperkähler structure known so explicitly.

We conclude this introduction with a few words about the structure of this paper, and our computational strategy and proofs (both of the new results and the exposition of the

hyperkähler structure). The formulas for $\omega_1, \omega_2, \omega_3$, and the metric *m* depend on specific choices of tangent vectors, and are expressed as modifications of the Killing form. We have expressed these modifications in terms of operators that are written as power series, and which ultimately derive from the exponential map. These operators are defined in Section 4, where we prove some basic properties; in the same section, we define the operators T_{λ} , which are so important in understanding the deformation results stated in Section 10. Our version of the development of the hyperkähler structure on complexified Hermitian symmetric spaces is carried out in Section 7 and the first part of Section 8. Most of this is straightforward, using the results developed in Section 4. The second half of Section 8 includes some additional information (e.g., about Kähler potentials) that is not needed elsewhere. In Section 9, we recall and prove known formulas for the moment maps; we expect to use this in future work, but it is not needed elsewhere in the paper. Our main results about deformations are stated in Section 10 and proved in Section 11. The technical results from Section 4 are used, along with some minor bookkeeping involving the Killing form. The more substantive arguments in Section 11 are made necessary by an essential but complicating property of the map T_{λ} : it relies on a map $t_{\lambda} : \mathfrak{m} \to \mathfrak{m}$ that does not generally preserve the real form \mathfrak{m}_0 . Since the description of the hyperkähler structure relies on a decomposition of the complexified Hermitian symmetric space that involves \mathfrak{m}_0 (Section 6.2.1), the map T_{λ} is a bit of challenge. The more complicated arguments in Section 11, at their heart, contend with the problem of resolving tangent vectors into parts corresponding to \mathfrak{m}_0 and $i\mathfrak{m}_0$.

2. NOTATION AND RECAP OF HERMITIAN SYMMETRIC SPACES

See [8], [18].

German letters denote Lie algebras of the corresponding Lie groups.

We use I to denote the identity map, and J (with various subscripts) to denote complex structures.

Let G be a simple algebraic group over \mathbb{C} , endowed with commuting antiholomorphic involutions σ and θ . Assume that the fixed point group $G_u := G^{\theta}$ is a maximal compact subgroup of G. The fixed point group $G_0 := G^{\sigma}$ is another real form of G. We use σ and θ to denote the involutions of the Lie algebra \mathfrak{g} as well.

Let K denote the fixed points of the algebraic involution $\sigma\theta$. Note that K is a complex reductive group, and $K_0 := K \cap G_0$ is both a compact real form of K and a maximal compact subgroup of G_0 . We use \Re and \Im to denote the real and imaginary parts with respect to the decomposition $\mathfrak{g} = \mathfrak{g}_u \oplus i\mathfrak{g}_u$ (as well as for the real and imaginary parts of complex numbers).

We have Lie algebra decompositions $\mathfrak{g}_0 = \mathfrak{k}_0 \oplus \mathfrak{m}_0$ and $\mathfrak{g}_u = \mathfrak{k}_0 \oplus \mathfrak{m}_u$ (with $\mathfrak{m}_u = i\mathfrak{m}_0$); these are ± 1 eigenspaces decompositions for θ and σ , respectively, and are orthogonal decompositions with respect to the Killing form. By complexifying, we have $\mathfrak{k} = \mathbb{C} \otimes_{\mathbb{R}} \mathfrak{k}_0$ and $\mathfrak{m} = \mathbb{C} \otimes_{\mathbb{R}} \mathfrak{m}_0$, and then $\mathfrak{g} = \mathfrak{k} \oplus \mathfrak{m}$ is the ± 1 eigenspace decomposition of \mathfrak{g} with respect to $\sigma\theta$.

We assume thoughout that G_u/K_0 is an <u>Hermitian symmetric space</u> (irreducible and of compact type); it follows that G_0/K_0 is an Hermitian symmetric space of noncompact type. There is a unique (up to sign) element $\Upsilon \in \mathfrak{k}_0$ in the center of \mathfrak{k}_0 such that the eigenvalues of ad_{Υ} on \mathfrak{m} are $\pm i$. We write $\mathfrak{m} = \mathfrak{m}^+ \oplus \mathfrak{m}^-$ for the eigenspace decomposition, noting that \mathfrak{m}^+ and \mathfrak{m}^- are complex vector spaces. We let $J : \mathfrak{m} \to \mathfrak{m}$ denote the operator ad_{Υ} ;

the restriction of J to \mathfrak{m}_0 (resp. \mathfrak{m}_u) gives the almost complex structure on G_0/K_0 (resp. G_u/K_0) at the base point.

Using the definition of Υ , we have that $\sigma(\mathfrak{m}^+) = \mathfrak{m}^- = \theta(\mathfrak{m}^+)$, and likewise, σ and θ send \mathfrak{m}^- to \mathfrak{m}^+ . It follows that every element X of \mathfrak{m}_0 can be written as $(I + \sigma)X^+ = (I - \theta)X^+$ for a unique $X^+ \in \mathfrak{m}^+$, and each element of \mathfrak{m}_u is $(I + \theta)X^+ = (I - \sigma)X^+$ for a unique $X^+ \in \mathfrak{m}^+$. Note that $ad_{\Upsilon}((I + \sigma)(X^+)) = (I + \sigma)(iX^+)$, with the analogous statement when σ is replaced with θ . Thus the \mathbb{R} -linear map $\mathfrak{m}^+ \to \mathfrak{m}_0, X^+ \mapsto (I + \sigma)X^+$ intertwines the almost complex structures i and J, with analogous statement for \mathfrak{m}_u and θ .

Since θ is a Lie algebra automorphism of \mathfrak{g}_0 , we have that $[\mathfrak{k}_0, \mathfrak{k}_0] \subseteq \mathfrak{k}_0$, $[\mathfrak{k}_0, \mathfrak{m}_0] \subseteq \mathfrak{m}_0$, and $[\mathfrak{m}_0, \mathfrak{m}_0] \subseteq \mathfrak{k}_0$, with similar statements for \mathfrak{g} , \mathfrak{k} , and \mathfrak{m} . From the fact that Υ is in the center of \mathfrak{k} , it follows easily that $[\mathfrak{k}, \mathfrak{m}^+] \subseteq \mathfrak{m}^+$ and $[\mathfrak{k}, \mathfrak{m}^-] \subseteq \mathfrak{m}^-$. The restriction of the Killing form to either \mathfrak{m}^+ or \mathfrak{m}^- is identically zero. Since the bracket of any two elements of \mathfrak{m}^+ would be an eigenvector of ad_{Υ} with eigenvalue 2i, and since this eigenvalue does not occur, we have that $[\mathfrak{m}^+, \mathfrak{m}^+] = \{0\}$, and likewise $[\mathfrak{m}^-, \mathfrak{m}^-] = \{0\}$. If $Z \in \mathfrak{m}_0$, then the action of ad_Z on \mathfrak{g}_0 is diagonalizable with real eigenvalues, and the action of ad_Z^2 on \mathfrak{m}_0 is diagonalizable with nonnegative real eigenvalues.

Any Cartan subalgebra $\mathfrak{t} \subseteq \mathfrak{k}$ contains Υ ; moreover \mathfrak{t} is a Cartan subalgebra of \mathfrak{g} (since any element of \mathfrak{g} commuting with \mathfrak{t} would commute with Υ , but ad_{Υ} has eigenvalues $\pm i$ on \mathfrak{m}). The Cartan subalgebra \mathfrak{t} is the Lie algebra of a maximal complex torus T of K and G. We fix a Cartan subalgebra $\mathfrak{t} \subset \mathfrak{k}$ that is stable under θ (such exist, and all such are conjugate under K_0). Since $\Upsilon \in \mathfrak{t}$, we see that each root space \mathfrak{g}_{α} is contained in $\mathfrak{k}, \mathfrak{m}^+$, or \mathfrak{m}^- . We may take an ordering of the roots $\Phi(\mathfrak{g}, \mathfrak{t})$ so that \mathfrak{m}^+ is contained in the sum of the positive root spaces.

Given $\alpha \in \Phi(\mathfrak{m}^+, \mathfrak{t})$, one can choose $e_\alpha \in \mathfrak{g}_\alpha$ such that $(h_\alpha := [e_\alpha, \sigma e_\alpha], e_\alpha, f_\alpha := \sigma e_\alpha)$ forms a standard split sl_2 -triple, meaning $[h_\alpha, e_\alpha] = 2e_\alpha$, $[h_\alpha, f_\alpha] = -2f_\alpha$, and $[e_\alpha, f_\alpha] = h_\alpha$. Note that $h_\alpha \in i\mathfrak{k}_0 \cap \mathfrak{t}$, $e_\alpha + f_\alpha \in \mathfrak{m}_0$, and $e_\alpha - f_\alpha \in \mathfrak{m}_u$. Define $x_\alpha = e_\alpha + f_\alpha$ and $y_\alpha = i(e_\alpha - f_\alpha)$. With regard to complex structures, we have that $ad_\Upsilon x_\alpha = y_\alpha$ and $ad_\Upsilon y_\alpha = -x_\alpha$. We define $\Upsilon_\alpha = \frac{i}{2}h_\alpha$. We have the commutation relations $[\Upsilon_\alpha, x_\alpha] = y_\alpha$, $[\Upsilon_\alpha, y_\alpha] = -x_\alpha$, and $[x_\alpha, y_\alpha] = -4\Upsilon_\alpha$.¹ We obtain a real basis of \mathfrak{m}_0 from the elements x_α and y_α , where α runs through the positive \mathfrak{m} -roots.

There exists a maximal set $\Psi = \{\psi_1, \ldots, \psi_r\}$ of strongly orthogonal \mathfrak{m}^+ -roots (meaning that for $i \neq j$, $\psi_i \pm \psi_j$ are not roots). For any ψ_i and ψ_j in Ψ with $i \neq j$, each element in $\{e_{\psi_i}, f_{\psi_i}, h_{\psi_i}, x_{\psi_i}, Y_{\psi_i}\}$ commutes with each element in $\{e_{\psi_j}, f_{\psi_j}, h_{\psi_j}, x_{\psi_j}, Y_{\psi_j}\}$. Otherwise said: let $\mathfrak{g}[\psi] = span_{\mathbb{C}}\{e_{\psi}, f_{\psi}, h_{\psi}\} \simeq sl(2, \mathbb{C})$; then for $i \neq j$, each element of $\mathfrak{g}[\psi_i]$ commutes with each element of $\mathfrak{g}[\psi_j]$. Let $\mathfrak{a}_0 = span_{\mathbb{R}}\{x_{\psi} : \psi \in \Psi\}$, an abelian subalgebra of \mathfrak{g}_0 , contained in \mathfrak{m}_0 , and maximal with respect to these properties; let $\mathfrak{a} = \mathbb{C} \otimes_{\mathbb{R}} \mathfrak{a}_0$. Any two maximal abelian subalgebras of \mathfrak{m}_0 are K_0 -conjugate, and every element of \mathfrak{m}_0

For any $C \in \mathbb{C}$ with |C| = 1, we can take $e_\alpha = \begin{pmatrix} 0 & C \\ 0 & 0 \end{pmatrix}, f_\alpha = \begin{pmatrix} 0 & 0 \\ \overline{C} & 0 \end{pmatrix}$, and $h_\alpha = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}$. Then $x_\alpha = \begin{pmatrix} 0 & C \\ \overline{C} & 0 \end{pmatrix}, y_\alpha = \begin{pmatrix} 0 & iC \\ -i\overline{C} & 0 \end{pmatrix}$, and $\Upsilon_\alpha = \frac{i}{2} \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}$. For the choice C = 1, we would have $e_\alpha = \begin{pmatrix} 0 & 1 \\ 0 & 0 \end{pmatrix}, f_\alpha = \begin{pmatrix} 0 & 0 \\ 1 & 0 \end{pmatrix}$, $h_\alpha = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}, x_\alpha = \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}, y_\alpha = \begin{pmatrix} 0 & i \\ -i & 0 \end{pmatrix}$, and $\Upsilon_\alpha = \frac{i}{2} \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}$. With regard to the Cayley transform, we have $c = \frac{1}{\sqrt{2}} \begin{pmatrix} 1 & -1 \\ 1 & 1 \end{pmatrix}$ and $c^2 = \begin{pmatrix} 0 & -1 \\ 1 & 0 \end{pmatrix}$.

lives in some such maximal abelian subalgebra. We define $\Upsilon' \in \mathfrak{t} \cap \mathfrak{k}_0$ by the formula $\Upsilon = \Upsilon' + \sum_{\psi \in \Psi} \Upsilon_{\psi}$; note that Υ' commutes with each $\mathfrak{g}[\psi]$.

Let $\mathfrak{t}^- = \sum_{\psi \in \Psi} \mathbb{C}h_{\psi}$, and let $\mathfrak{t}^+ = \{h \in \mathfrak{t} : \psi(h) = 0 \text{ for all } \psi \in \Psi\}$, the orthogonal complement in \mathfrak{t} of \mathfrak{t}^- . Elements of $\Phi(\mathfrak{g}, \mathfrak{t}^-)$ are called *restricted roots*. Results of Harish-Chandra and Moore give descriptions of restricted roots and their multiplicities; in particular, the only possible restricted roots are the restrictions to \mathfrak{t}^- of $\pm \frac{1}{2}\psi_s \pm \frac{1}{2}\psi_t$ and $\pm \frac{1}{2}\psi_t$ for roots $\psi_s, \psi_t \in \Psi$. Define $c \in G_u$ by $c = \exp\left(\sum_{\psi \in \Psi} \frac{i\pi}{4}y_\psi\right)$, a *(full) Cayley transform*. Under the adjoint representation, c sends h_{ψ} to x_{ψ}, x_{ψ} to $-h_{\psi}$, and y_{ψ} to itself. Note that Ad_c centralizes \mathfrak{t}^+ and conjugates \mathfrak{t}^- to \mathfrak{a} . Let $\mathfrak{h} = Ad_c \mathfrak{t} = \mathfrak{t}^+ \oplus \mathfrak{a}$, another Cartan subalgebra of \mathfrak{g} . The map Ad_c allows us to identify the roots systems $\Phi(\mathfrak{g}, \mathfrak{t})$ and $\Phi(\mathfrak{g}, \mathfrak{h})$. Elements of $\Phi(\mathfrak{g}, \mathfrak{a})$ are again called restricted roots. The Weyl group $N_{K_0}(\mathfrak{a}_0)/Z_{K_0}(\mathfrak{a}_0)$ acts on $\{\pm x_{\psi}\}_{\psi \in \Psi}$ as signed permutations.

Let $\mathfrak{q} = \mathfrak{k} \oplus \mathfrak{m}^-$; it is the Lie algebra of a parabolic subgroup $Q \subseteq G$. It is well-known that $G_u \cap Q = K_0$ and that G_u acts transitively on G/Q. Moreover, if we let $\mathcal{O}_u \subset \mathfrak{g}_u$ denote the $Ad(G_u)$ -orbit of Υ , then the G_u -stabilizer of Υ is K_0 . We obtain the identifications $\mathcal{O}_u := Ad_{G_u}(\Upsilon) \simeq G_u/K_0 \simeq G/Q$. There is a corresponding realization of the noncompact Hermitian symmetric space as $G_0/K_0 \simeq \mathcal{O}_0 \subseteq \mathfrak{g}_0$, where \mathcal{O}_0 is the $Ad(G_0)$ -orbit of Υ . We define $\mathcal{O} \subset \mathfrak{g}$, the Ad(G)-orbit of Υ ; here $\mathcal{O} \simeq G/K$. The isomorphism of G_u/K_0 with G/Q, and the inclusion of G_0/K_0 in G/Q, give complex structures on \mathcal{O}_u and \mathcal{O}_0 ; these agree with the almost complex structures defined by Υ . The space \mathcal{O} is the "complexified Hermitian symmetric space" in the title of this paper.

3. Hyperkähler structures

See [3], [11].

We recall that a hyperkähler structure on a real manifold M encompasses the following features:

- Almost complex structures J_1 , J_2 , J_3 on M that obey the usual quaternionic multiplication rules. It follows that for each unit vector $(\lambda_1, \lambda_2, \lambda_3) \in \mathbb{R}^3$, the operator $J_{(\lambda_1, \lambda_2, \lambda_3)} := \lambda_1 J_1 + \lambda_2 J_2 + \lambda_3 J_3$ gives an almost complex structure.
- Integrable complex structures underlying the above almost complex structures.
- A Riemannian metric m on M that is invariant under each $J_{(\lambda_1,\lambda_2,\lambda_3)}$.
- For each unit vector $(\lambda_1, \lambda_2, \lambda_3)$, a real, closed, nondegenerate, $J_{(\lambda_1, \lambda_2, \lambda_3)}$ -invariant 2-form $\omega_{(\lambda_1, \lambda_2, \lambda_3)}$ on M. This form is given explicitly by the rule $\omega_{(\lambda_1, \lambda_2, \lambda_3)}(v, w) = -m(v, J_{(\lambda_1, \lambda_2, \lambda_3)}w)$. If $\omega_1, \omega_2, \omega_3$ denote the 2-forms associated to J_1, J_2, J_3 , then $\omega_{(\lambda_1, \lambda_2, \lambda_3)} = \sum_i \lambda_i \omega_i$.
- For each $J_{(\lambda_1,\lambda_2,\lambda_3)}$, a class of nondegenerate holomorphic symplectic forms (where "class" means up to scalar multiples by \mathbb{C}^*). For $J_{(\lambda_1,\lambda_2,\lambda_3)}$ fixed, one such holomorphic symplectic form is obtained via unit vectors $(\lambda'_1,\lambda'_2,\lambda'_3)$ and $(\lambda''_1,\lambda''_2,\lambda''_3)$, where $(\lambda_1,\lambda_2,\lambda_3), (\lambda'_1,\lambda'_2,\lambda'_3)$, and $(\lambda''_1,\lambda''_2,\lambda''_3)$ are mutually orthogonal and obey the right-hand rule. The associated holomorphic symplectic form is $\omega_{(\lambda'_1,\lambda'_2,\lambda'_3)} + i \,\omega_{(\lambda''_1,\lambda''_2,\lambda''_3)}$.

There is redundancy among these conditions. In Proposition 8.1, we use a smaller set of conditions that determine the hyperkähler structure.

Our main results will rely on identifying the complex structures $\{J_{(\lambda_1,\lambda_2,\lambda_3)}\}$ with points in the extended complex plane:

Definition 3.1. For $\lambda \in \mathbb{C} \cup \{\infty\}$, let $(\lambda_1, \lambda_2, \lambda_3)$ denote the point on the unit 2-sphere in \mathbb{R}^3 defined by stereographic projection from the south pole:

$$\lambda_1 = \frac{\lambda + \overline{\lambda}}{1 + |\lambda|^2} \qquad \qquad \lambda_2 = \frac{\lambda - \overline{\lambda}}{i(1 + |\lambda|^2)} \qquad \qquad \lambda_3 = \frac{1 - |\lambda|^2}{1 + |\lambda|^2}$$

If $\lambda \in \mathbb{C} \cup \{\infty\}$, let $J_{(\lambda)}$ denote $J_{(\lambda_1,\lambda_2,\lambda_3)}$, with $\lambda_1, \lambda_2, \lambda_3$ as above. Similarly, we use $\omega_{(\lambda_1,\lambda_2,\lambda_3)}$ and $\omega_{(\lambda)}$ interchangeably.

Note that for $\lambda \in \mathbb{C}^*$ exactly when $J_{(\lambda)}$ is not $\pm J_3$, as $J_3 = J_{(0)}$ and $-J_3 = J_{(\infty)}$. Note moreover that $J_1 = J_{(1)}$ and $J_2 = J_{(i)}$.

4. Computational preliminaries

In this section, we define and study some operators that are essential for expressing the hyperkähler structure on \mathcal{O} .

• In §4.2: For $Z \in \mathfrak{m}_0$, the linear map $E_Z : \mathfrak{m} \to \mathfrak{m}, \mathfrak{m}_0 \to \mathfrak{m}_0$ is the power series in ad_Z associated to the differential of the exponential map $\mathfrak{m}_0 \to G_0/K_0$, or equally well, the even part of the differential of the exponential map $\mathfrak{g} \to G$.

• In §4.4: For $Z \in \mathfrak{m}_0$, the linear map $S_Z : \mathfrak{m} \to \mathfrak{m}, \mathfrak{m}_0 \to \mathfrak{m}_0$ is the power series in ad_Z that gives $W \mapsto proj_{\mathfrak{m}}^{\mathfrak{g}} Ad_{\exp Z} W$.

These power series have only even terms. In Proposition 4.2 and Corollary 4.3 (§4.1), we verify the crucial fact that such power series commute with their J-conjugates.

• In §4.5: The real analytic map $P : \mathfrak{m}_0 \to \mathfrak{m}_0$ is closely related to the map $Z \mapsto proj_{\mathfrak{m}}^{\mathfrak{g}}(Ad_{\exp Z}\Upsilon).$

• In §4.6: The maps $t_{\lambda} : \mathfrak{g} \to \mathfrak{g}$ and $T_{\lambda} : \mathcal{O} \to \mathcal{O}$ are crucial for stating the deformation results in §10.

4.1. Power series and ad_Z^2 . Let p(z) denote a power series with complex coefficients, let $Z = Z^+ + Z^- \in \mathfrak{m}$, and suppose that $p(ad_Z)$ converges as an operator on \mathfrak{g} . We write $p(z) = p_{even}(z) + p_{odd}(z)$ to represent the decomposition into sums of even and odd powers of z. It is trivial that $p_{even}(ad_Z)$ preserves \mathfrak{k} and \mathfrak{m} while $p_{odd}(ad_Z)$ maps \mathfrak{k} to \mathfrak{m} and \mathfrak{m} to \mathfrak{k} . If $Z \in \mathfrak{g}_0$ (resp. \mathfrak{g}_u) and if the power series has real coefficients, then these statements also hold with subscripts of 0 (resp. u) inserted. Recall that $\mathfrak{m}_0 = i\mathfrak{m}_u$; throughout, we use the fact that if $Z \in \mathfrak{m}_0$ and p has real coefficients, then $p_{even}(ad_Z)$ preserves both \mathfrak{m}_0 and \mathfrak{m}_u .

Simple computations underlie the following lemma:

Lemma 4.1. Let $Z, W \in \mathfrak{m}$ and $X \in \mathfrak{k}$.

- $(1) \ ad_{JZ}^2(W) = -J\left(ad_Z^2(JW)\right) = -ad_{Z^-}^2W^+ + ad_{Z^-}ad_{Z^+}W^- + ad_{Z^-}ad_{Z^-}W^+ ad_{Z^+}^2W^-.$
- (2) If p only has even-order terms, then as endomorphisms of \mathfrak{m} , we have $p(ad_{JZ}) = -J \circ p(ad_Z) \circ J$.

(3) [JZ, JW] = [Z, W] and J[X, W] = [X, JW].

Proposition 4.2. For all $Z \in \mathfrak{m}$, ad_{JZ}^2 and ad_Z^2 commute as endomorphisms of \mathfrak{m} .

Proof. We repeatedly will use that $ad_{[A,B]} = ad_A ad_B - ad_B ad_A$.

Write $Z = Z^+ + Z^-$ and $JZ = i(Z^+ - Z^-)$. Substituting in the equation $ad_Z^2 ad_{JZ}^2 = ad_{JZ}^2 ad_Z^2$, expanding, and eliminating terms with the zero-operators $ad_{Z^+}^3$ or $ad_{Z^-}^3$, we see that the proposition is equivalent to $0 = ad_{Z^+}^2 ad_{Z^-} ad_{Z^+} - ad_{Z^+} ad_{Z^-} ad_{Z^+}^2$ and $0 = ad_{Z^-}^2 ad_{Z^+} ad_{Z^-} - ad_{Z^-} ad_{Z^+} ad_{Z^-}^2$, and invoking symmetry, it is sufficient to prove the second equation. The operator $ad_{Z^-}^2 ad_{Z^+} ad_{Z^-} - ad_{Z^-} ad_{Z^+} ad_{Z^-}^2$ is zero on $\mathfrak{k} \oplus \mathfrak{m}^-$; we must prove

that it is zero as a function from \mathfrak{m}^+ to \mathfrak{m}^- , which is to say, $ad_{Z^-}ad_{[Z^-,Z^+]}ad_{Z^-}W^+ = 0$ for all $W^+ \in \mathfrak{m}^+$.

We begin with $0 = ad_{Z^-}ad_Z^+W^+$, valid since \mathfrak{m}^+ is abelian. Rewrite this equation as $0 = ad_{[Z^-,Z^+]}W^+ + ad_{Z^+}ad_{Z^-}W^+$. Next apply ad_{Z^-} ; after using the Jacobi identity, we obtain the equation

(1)
$$0 = ad_{[Z^-, [Z^-, Z^+]]}W^+ + ad_{Z^-}ad_{Z^+}ad_{Z^-}W^+ + ad_{[Z^-, Z^+]}ad_{Z^-}W^+$$

Again apply $ad_{Z^{-}}$, yielding the equation

(2)
$$0 = ad_{Z^{-}}ad_{[Z^{-},[Z^{-},Z^{+}]]}W^{+} + ad_{Z^{-}}^{2}ad_{Z^{+}}ad_{Z^{-}}W^{+} + ad_{Z^{-}}ad_{[Z^{-},Z^{+}]}ad_{Z^{-}}W^{+}$$

The first term on the righthand side is equal to $ad_{[Z^-,[Z^-,Z^+]]}ad_{Z^-}W^+$ (since $ad_{Z^-}^3$ is the zero-operator) and can be rewritten as $ad_{Z^-}ad_{[Z^-,Z^+]}ad_{Z^-}W^+ - ad_{[Z^-,Z^+]}ad_{Z^-}^2W^+$. Thus the right-hand side of (2) is

(3)
$$2ad_{Z^{-}}ad_{[Z^{-},Z^{+}]}ad_{Z^{-}}W^{+} + ad_{Z^{-}}^{2}ad_{Z^{+}}ad_{Z^{-}}W^{+} - ad_{[Z^{-},Z^{+}]}ad_{Z^{-}}^{2}W^{+}$$

The last two terms in (3) sum to

$$ad_{Z^{-}}ad_{Z^{-}}ad_{Z^{-}}ad_{Z^{-}}W^{+} - ad_{Z^{-}}ad_{Z^{-}}^{+}ad_{Z^{-}}W^{+} + ad_{Z^{+}}ad_{Z^{-}}^{3}W^{+} = ad_{Z^{-}}ad_{[Z^{-},Z^{+}]}ad_{Z^{-}}W^{+}$$

Thus the right side of (2) is equal to $3ad_{Z^-}ad_{[Z^-,Z^+]}ad_{Z^-}W^+$, proving the proposition. \Box

Corollary 4.3. If p and q have only even-order terms, then as endomorphisms of \mathfrak{m} , $p(ad_{JZ})$ commutes with $q(ad_Z)$.

Throughout this paper, we will apply Lemma 4.1(2) and Corollary 4.3 to the maps E_Z and S_Z defined below.

Lemma 4.4. Let $T : \mathfrak{m} \to \mathfrak{m}$ be \mathbb{C} -linear (which is to say, \mathbb{R} -linear and commuting with multiplication by i). The following are equivalent:

- (1) T commutes with J.
- (2) T commutes with $\frac{1}{2}(I-iJ)$ (projection from \mathfrak{m} to \mathfrak{m}^+).
- (3) T commutes with $\frac{1}{2}(I+iJ)$ (projection from \mathfrak{m} to \mathfrak{m}^-).
- (4) $T(\mathfrak{m}^+) \subseteq \mathfrak{m}^+ \text{ and } \tilde{T}(\mathfrak{m}^-) \subseteq \mathfrak{m}^-.$

Proof. Each of the conditions 1, 2, 3 is equivalent to the statement that for arbitrary $W = W^+ + W^- \in \mathfrak{m}$, the \mathfrak{m}^- part of $T(W^+)$ equals the \mathfrak{m}^+ part of $T(W^-)$. If this condition holds, then by taking $W^- = 0$ (resp. $W^+ = 0$), we obtain the two statements in condition 4. On the other hand, condition 4 implies that the \mathfrak{m}^- part of $T(W^+)$ equals the \mathfrak{m}^+ part of $T(W^-)$ since both are zero.

Lemma 4.5. Let $Z \in \mathfrak{m}$, and let p be a series with only even order terms. If $p(ad_Z)$ and $p(ad_{JZ})$ converge as operators on \mathfrak{m} , then $p(ad_Z) \circ p(ad_{JZ}) : \mathfrak{m} \to \mathfrak{m}$ satisfies the conditions of Lemma 4.4.

Proof. Using Lemma 4.1(2) and Corollary 4.3 we see that the operator commutes with J.

4.2. The maps E_Z and F_Z . Beginning with the exponential map $\exp : \mathfrak{g} \to G$ and with fixed $Z \in \mathfrak{g}$, we have the linear map $d \exp_Z : \mathfrak{g} \simeq T_Z \mathfrak{g} \to T_{\exp Z} G$. There exist linear endomorphisms of \mathfrak{g} , denoted $E_{Z,l}$ and $E_{Z,r}$, such that $d \exp_Z = dl_{\exp Z} \circ E_{Z,l} = dr_{\exp Z} \circ E_{Z,r}$. We regard $\exp(tE_{Z,l}(A))$ as giving a first-order approximation of $\exp(-Z)\exp(Z+tA)$, and $\exp(tE_{Z,r}(A))$ as giving a first-order approximation of $\exp(Z+tA)\exp(-Z)$. It is clear that $E_{Z,r} = Ad_{\exp Z} \circ E_{Z,l}$. It is also well known that the power series expansions are $E_{Z,l} =$ $\sum_{n=0}^{\infty} \frac{(-ad_Z)^n}{(n+1)!}$ and $E_{Z,r} = \sum_{n=0}^{\infty} \frac{(ad_Z)^n}{(n+1)!}$. Considering the even and odd parts, we define $E_Z = \sum_{n=0}^{\infty} \frac{(ad_Z)^{2n}}{(2n+1)!}$ and $F_Z = \sum_{n=1}^{\infty} \frac{(ad_Z)^{2n-1}}{(2n)!}$; then $E_{Z,l} = E_Z - F_Z$ and $E_{Z,r} = E_Z + F_Z$. For $Z \in \mathfrak{m}$, we can regard E_Z as an endomorphism of \mathfrak{m} .

We note the geometric significance of E_Z for the noncompact Hermitian symmetric space (the argument for the compact case being analogous). Let $Exp : \mathfrak{m}_0 \to G_0/K_0$ denote the exponential map at the base point of G_0/K_0 (in the sense of Riemannian geometry); then $dExp_Z : \mathfrak{m}_0 \simeq T_Z \mathfrak{m}_0 \to T_{ExpZ} (G_0/K_0)$ satisfies $dExp_Z = dl_{exp_Z} \circ E_Z$.

4.3. A decomposition of $Ad_{\exp Z}\Upsilon$.

Lemma 4.6. Let $Z \in \mathfrak{m}$.

(1) The \mathfrak{k} -part of $Ad_{\exp Z}\Upsilon$ is

$$proj_{\mathfrak{k}}^{\mathfrak{g}}\left(Ad_{\exp Z}\Upsilon\right) = \frac{1}{2}\left(Ad_{\exp Z} + Ad_{\exp\sigma\theta Z}\right)\Upsilon = \frac{1}{2}\left(Ad_{\exp Z} + Ad_{\exp(-Z)}\right)\Upsilon = \left(\Upsilon - F_Z(JZ)\right)$$

$$(2) \quad The \ \mathfrak{m}\text{-part of of } Ad_{\exp Z}\Upsilon \text{ is}$$

$$proj_{\mathfrak{m}}^{\mathfrak{g}}\left(Ad_{\exp Z}\Upsilon\right) = \frac{1}{2}\left(Ad_{\exp Z} - Ad_{\exp\sigma\theta Z}\right)\Upsilon = \frac{1}{2}\left(Ad_{\exp Z} - Ad_{\exp(-Z)}\right)\Upsilon = -E_{Z}(JZ)$$

Suppose further that $Z \in \mathfrak{m}_0$, so that $Ad_{\exp Z} \Upsilon \in \mathfrak{g}_0 = \mathfrak{k}_0 \oplus \mathfrak{m}_0$. Without loss of generality, assume that $Z = \sum c_{\psi} x_{\psi} \in \mathfrak{a}_0$.

(1) The \mathfrak{k}_0 -part of $Ad_{\exp Z} \Upsilon$ also can be described as

$$proj_{\mathfrak{k}_{0}}^{\mathfrak{g}_{0}}\left(Ad_{\exp Z}\Upsilon\right) = \frac{1}{2}\left(Ad_{\exp Z} + Ad_{\exp \theta Z}\right)\Upsilon$$
$$= \Upsilon' + \frac{i}{2}\sum \cosh(2c_{\psi})h_{\psi} = \Upsilon + \sum \left(\cosh(2c_{\psi}) - 1\right)\Upsilon_{\psi}$$

(2) The \mathfrak{m}_0 -part of of $Ad_{\exp Z} \Upsilon$ also can be described as

$$proj_{\mathfrak{m}_{0}}^{\mathfrak{g}_{0}}\left(Ad_{\exp Z}\Upsilon\right) = \frac{1}{2}\left(Ad_{\exp Z} - Ad_{\exp \theta Z}\right)\Upsilon = -\frac{1}{2}\sum \sinh(2c_{\psi})y_{\psi}$$

Proof. The essential calculation is

$$Ad_{\exp Z}\Upsilon = \sum_{n=0}^{\infty} \frac{ad_Z^{2n}}{(2n)!}\Upsilon + \sum_{n=0}^{\infty} \frac{ad_Z^{2n+1}}{(2n+1)!}\Upsilon = \Upsilon + \sum_{n=1}^{\infty} \frac{ad_Z^{2n-1}}{(2n)!}ad_Z\Upsilon + \sum_{n=0}^{\infty} \frac{ad_Z^{2n}}{(2n+1)!}ad_Z\Upsilon$$
$$= (\Upsilon - F_Z(JZ)) - E_Z(JZ)$$

We shall need a variant of Lemma 4.6 for 2×2 matrices, the proof of which is an easy computation:

Lemma 4.7. Let $X = \begin{pmatrix} 0 & a \\ b & 0 \end{pmatrix}$ with $a, b \in \mathbb{C}^*$, and let \sqrt{ab} denote either of the complex square roots of ab.

(1)
$$\exp(X) = \begin{pmatrix} \cosh(\sqrt{ab}) & \frac{a\sinh(\sqrt{ab})}{\sqrt{ab}} \\ \frac{b\sinh(\sqrt{ab})}{\sqrt{ab}} & \cosh(\sqrt{ab}) \end{pmatrix}$$

(2) $Ad_{\exp X} \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix} = \begin{pmatrix} \cosh(2\sqrt{ab}) & -\frac{a\sinh(2\sqrt{ab})}{\sqrt{ab}} \\ \frac{b\sinh(2\sqrt{ab})}{\sqrt{ab}} & -\cosh(2\sqrt{ab}) \end{pmatrix}$

4.4. The map S_Z . For $Z \in \mathfrak{m}$, we define $S_Z = \frac{1}{2} \left(A d_{\exp Z} + A d_{\exp Z}^{-1} \right)$. We have already encountered this expression, having seen in Lemma 4.6 that $\frac{1}{2} \left(A d_{\exp Z} + A d_{\exp Z}^{-1} \right) (\Upsilon) =$ $(\Upsilon - F_Z(JZ))$. However, in this section, we are interested in applying S_Z to elements of \mathfrak{m} . Since $Ad_{\exp Z}^{-1} = Ad_{\exp(-Z)}$, S_Z coincides with the even part of $Ad_{\exp Z}$, so $S_Z = \sum_{n=0}^{\infty} \frac{ad_Z^{2n}}{(2n)!}$ If $Z \in \mathfrak{m}_0$, we can regard S_Z as an \mathbb{R} -linear map from \mathfrak{m}_0 to \mathfrak{m}_0 . We will see in Section 5

that $S_Z|_{\mathfrak{m}_0}$ is invertible.

Lemma 4.8. Let $Z \in \mathfrak{m}_0$, and consider $S_Z : \mathfrak{m}_0 \to \mathfrak{m}_0$.

S_Z = proj^{g0}_{m0} ∘ Ad_{exp Z} = proj^{g0}_{m0} ∘ Ad_{exp(-Z)}.
 S⁻¹_{JZ}JS_{JZ} = S_ZJS⁻¹_Z, or equivalently, JS_{JZ}S_Z = S_{JZ}S_ZJ.
 S_{JZ} ∘ S_Z : m → m commutes with the projections of m onto m⁺ and m⁻.

Proof. For (1), give $W \in \mathfrak{m}_0$, we have

$$\operatorname{proj}_{\mathfrak{m}_{0}}^{\mathfrak{g}_{0}} \circ Ad_{\exp Z}W = \left(\frac{I-\theta}{2}\right) \left(Ad_{\exp Z}W\right) = \frac{1}{2} \left(Ad_{\exp Z}W - Ad_{\exp(-Z)}(-W)\right)$$
$$= \frac{1}{2} \left(Ad_{\exp Z}W + Ad_{\exp(-Z)}W\right) = S_{Z}W.$$

Part (2) uses Lemma 4.1(2) and Corollary 4.3. Part (3) is a special case of Lemma 4.5(2). \Box

The example of SL(2) already shows that in general, $S_Z \neq S_{JZ}$.

Lemma 4.9. Let $Z \in \mathfrak{m}$.

- (1) As a function with domain \mathfrak{m} , $ad_{\Upsilon} \circ (Ad_{\exp Z} Ad_{\exp(-Z)})$ is identically zero.
- (2) As functions from \mathfrak{m} to \mathfrak{m} , we have $S_Z J S_Z = \frac{1}{2} ad_{\left(\left(Ad_{\exp Z} + Ad_{\exp(-Z)} \right) \Upsilon \right)}$.

Proof. If $A \in \mathfrak{m}$, then $\sigma\theta\left(\left(Ad_{\exp Z} - Ad_{\exp(-Z)}\right)A\right) = \left(Ad_{\exp(-Z)} - Ad_{\exp Z}\right)(-A)$, showing that $(Ad_{\exp Z} - Ad_{\exp(-Z)}) A \in \mathfrak{k}$, whence (1).

To prove (2), we take the difference of the two sides of the equation, apply to an arbitrary element $A \in \mathfrak{m}$, and multiply by four, obtaining

$$(Ad_{\exp Z} + Ad_{\exp(-Z)}) \circ ad_{\Upsilon} \circ (Ad_{\exp Z} + Ad_{\exp(-Z)}) A - 2[(Ad_{\exp Z} + Ad_{\exp(-Z)}) \Upsilon, A]$$

$$= (Ad_{\exp Z} + Ad_{\exp(-Z)}) \circ ad_{\Upsilon} \circ (Ad_{\exp Z} + Ad_{\exp(-Z)}) A - 2Ad_{\exp Z} \circ ad_{\Upsilon} \circ Ad_{\exp(-Z)}A$$

$$-2Ad_{\exp(-Z)} \circ ad_{\Upsilon} \circ Ad_{\exp Z}A$$

$$= (Ad_{\exp Z} - Ad_{\exp(-Z)}) \circ ad_{\Upsilon} \circ (Ad_{\exp Z} - Ad_{\exp(-Z)}) A$$

which is zero by (1).

We have seen that $S_Z = \sum_{n=0}^{\infty} \frac{a d_Z^{2n}}{(2n)!} = a d_Z \circ F_Z + I$, and is the even part of $A d_{\exp Z}$. Analogously, we have:

Lemma 4.10. Let $Z \in \mathfrak{m}$. The odd part of $Ad_{\exp Z}$ maps \mathfrak{k} to \mathfrak{m} and \mathfrak{m} to \mathfrak{k} , and is given by

$$\frac{1}{2} \left(A d_{\exp Z} - A d_{\exp(-Z)} \right) = \sum_{n=0}^{\infty} \frac{a d_Z^{2n+1}}{(2n+1)!} = a d_Z \circ E_Z \quad \Box$$

4.5. The map P. We define the holomorphic² map $P : \mathfrak{m} \to \mathfrak{m}$ by $Z \mapsto ad_{\Upsilon} Ad_{\exp Z} \Upsilon$.

Since K fixes Υ in the adjoint representation, P is K-equivariant. Since Υ is fixed by σ and θ , P commutes with σ and θ , so that P restricts to (real analytic) maps from \mathfrak{m}_0 to \mathfrak{m}_0 and from \mathfrak{m}_u to \mathfrak{m}_u .

Since ad_{Υ} annihilates \mathfrak{k} , we have that P(Z) coincides with J applied to the \mathfrak{m} -part of $Ad_{\exp Z}\Upsilon$. Thus by Lemma 4.6,

$$P(Z) = Jproj_{\mathfrak{m}}^{\mathfrak{g}} \left(Ad_{\exp Z} \Upsilon \right) = \frac{1}{2} J \left(Ad_{\exp Z} - Ad_{\exp(-Z)} \right) \Upsilon = -JE_Z(JZ) = E_{JZ}Z,$$

the last equation using Lemma 4.1. Additionally, if $Z = \sum c_{\psi} x_{\psi} \in \mathfrak{a}_0$, by Lemma 4.6 we have $P(Z) = \frac{1}{2} \sum \sinh(2c_{\psi})x_{\psi}$. Since $\sinh : \mathbb{R} \to \mathbb{R}$ is bijective, the last expression shows that $P|_{\mathfrak{a}_0} : \mathfrak{a}_0 \to \mathfrak{a}_0$ is a real analytic isomorphism, and P maps \mathfrak{a} to \mathfrak{a} (a holomorphic map that is not bijective).

Lemma 4.11. For $P : \mathfrak{m} \to \mathfrak{m}$ as above,

- (1) P commutes with J.
- (2) If $Z \in \mathfrak{m}^+$ or \mathfrak{m}^- , then P(Z) = Z.
- (3) P is an odd function.

Proof. For (1), from Lemma 4.1(2) we have $E_{JZ} = -JE_Z J$, and then $P(JZ) = E_{-Z}JZ = E_Z JZ = JE_{JZ}Z = JP(Z)$. For (2), we note that if $Z \in \mathfrak{m}^{\pm}$, then $JZ = \pm iZ$, and then $P(Z) = E_{JZ}Z = E_{\pm iZ}Z = \sum_{n=0}^{\infty} \frac{(-ad_Z^2)^n}{(2n+1)!}Z$, and the terms vanish for $n \ge 1$. Part (3) is trivial.

Proposition 4.12. $P : \mathfrak{m}_0 \to \mathfrak{m}_0$ is invertible.

Proof. We need three background facts:

- (1) Each element of \mathfrak{m}_0 is conjugate by K_0 to an element of \mathfrak{a}_0 .
- (2) The intersection of the K_0 -orbit of a point $A \in \mathfrak{a}_0$ with \mathfrak{a}_0 is a $N_{K_0}(\mathfrak{a}_0)$ -orbit.
- (3) If two points in \mathfrak{a}_0 have the same $N_{K_0}(\mathfrak{a}_0)$ -isotropy, then they have the same K_0 -isotropy.

Item (1) already was stated in §2. We'll sketch a justification of (2) and (3). By the Luna-Richardson Theorem, we have that the inclusion $\mathfrak{a} \subset \mathfrak{m}$ induces an isomorphism between $\mathfrak{a}/\!\!/N_K(\mathfrak{a})$ and $\mathfrak{m}/\!\!/K$ (where the double slashes indicate spaces of closed orbits); moreover, the isomorphism carries the $N_K(\mathfrak{a})$ -isotropy strata in $\mathfrak{a}/\!\!/N_K(\mathfrak{a})$ to the K-isotropy strata in $\mathfrak{m}/\!\!/K$. The isomorphism $\mathfrak{a}/\!\!/N_K(\mathfrak{a}) \simeq \mathfrak{m}/\!\!/K$ shows that the K-orbit of a point in \mathfrak{a} intersects \mathfrak{a} in an $N_K(\mathfrak{a})$ -orbit; the isotropy result shows that if two points in \mathfrak{a} have the same $N_K(\mathfrak{a})$ isotropy, then they have the same K-isotropy. Note that (2) and (3) are versions of these statements over \mathbb{R} . While the transition to actions of real groups can lead to unexpected phenomena, (2) and (3) follow due to special properties of *compact* real forms [4].

We now proceed to the proof of Proposition 4.12. By (1) and the fact that $P|_{\mathfrak{a}_0}:\mathfrak{a}_0\to\mathfrak{a}_0$ is surjective, we have that ${\cal P}$ is surjective.

We prove that P is injective. Let $k \in K_0$ and $A, A' \in \mathfrak{a}_0$. We must show that if $P(A') = P(Ad_kA)$, then $A' = Ad_kA$.

Since $P(A) \in \mathfrak{a}_0$ and $Ad_k P(A) = P(A') \in \mathfrak{a}_0$, by (2), there exists $n \in N_{K_0}(\mathfrak{a}_0)$ such that $Ad_k P(A) = Ad_n P(A)$. Since $P(Ad_n A) = P(A')$ and since $A, Ad_n A \in \mathfrak{a}_0$, we conclude that $Ad_nA = A'.$

Writing $m = k^{-1}n \in K_0$, our goal is to show that $Ad_mA = A$, given that $Ad_mP(A) =$ P(A). By (3), it is enough to verify that A and P(A) have the same $N_{K_0}(\mathfrak{a}_0)$ -isotropy. For this, we recall, that the Weyl group $N_{K_0}(\mathfrak{a}_0)/Z_{K_0}(\mathfrak{a}_0)$ acts on $\mathfrak{a}_0 = span_{\mathbb{R}}\{x_{\psi}\}$ as signed permutations, and observe that for $A = \sum c_{\psi} x_{\psi}$ and $P(A) = \sum \frac{\sinh(2c_{\psi})}{2} x_{\psi}$, we have $c_{\psi'} = c_{\psi}$ (resp. $-c_{\psi}$) if and only if $\frac{\sinh(2c'_{\psi})}{2} = \frac{\sinh(2c_{\psi})}{2}$ (resp. $-\frac{\sinh(2c_{\psi})}{2}$), using that the hyperbolic sine function is bijective and odd.

Lemma 4.13. The differential $dP_Z : \mathfrak{m}_0 \to \mathfrak{m}_0$ is given by $S_{JZ} \circ E_Z$.

Proof. Let $B \in \mathfrak{m}_0$ and let ~ denote the equivalence relation "having the same tangent vector at t = 0." We then have $P(Z+tB) = ad_{\Upsilon}Ad_{\exp(Z+tB)}\Upsilon \sim ad_{\Upsilon}Ad_{\exp Z}\left(\left(I + t \, ad_{E_{Z,I}B}\right)\Upsilon\right)$, so we are reduced to showing that $ad_{\Upsilon} \circ Ad_{\exp Z} \circ ad_{E_{Z,l}B} \Upsilon = S_{JZ} E_Z B$. Now $E_{Z,l} \dot{B} =$ $E_ZB - F_ZB$, with $F_ZB \in \mathfrak{k}_0$, hence $ad_{E_Z,lB}\Upsilon = ad_{E_ZB}\Upsilon = -J \circ E_Z(B) \in \mathfrak{m}_0$. 4.6. The maps t_{λ} and T_{λ} .

Definition 4.14. Let $\lambda \in \mathbb{C}^*$. We define a \mathbb{C} -linear bijective endomorphism t_{λ} of \mathfrak{g} by t_{λ} equalling the identity map on \mathfrak{k} , multiplication by λ on \mathfrak{m}^+ , and multiplication by λ^{-1} on \mathfrak{m}^- .

(1) For any $c \in \mathbb{C}$ with $e^{ci} = \lambda$, we have $t_{\lambda} = Ad_{exp(c\gamma)}$. Lemma 4.15.

- (2) The map t_{λ} is a Lie algebra isomorphism, and commutes with Ad_k for all $k \in K$. (3) $t_{\lambda}(\mathfrak{m}_0) = \{\lambda Z^+ + \lambda^{-1}\sigma Z^+ : Z^+ \in \mathfrak{m}^+\} = \{Z^+ + \frac{1}{|\lambda|^2}\sigma Z^+ : Z^+ \in \mathfrak{m}^+\}, and$ these equal the real form of \mathfrak{m} defined by the complex conjugation $Z^+ \mapsto \frac{1}{|\lambda|^2} \sigma Z^+$, $Z^- \mapsto |\lambda|^2 \sigma Z^-.$
- (4) If Z ∈ m, then ad²_{t_λZ} = t_λ ∘ ad²_Z ∘ t_{1/λ} as operators on m.
 (5) If p is a power series with even order terms, then p(ad_{t_λZ}) = t_λ ∘ p(ad_Z) ∘ t_{1/λ} as operators on m.
- (6) With notation as in Definition 3.1, $I + i\lambda_3 J = t_\lambda(\lambda_1 \lambda_2 J)$ as operators on \mathfrak{m} . (7) If $A \in \mathfrak{m}$, then $\theta(t_\lambda A) = t_{\overline{\lambda}}^{-1} \theta A$ and $\sigma(t_\lambda A) = t_{\overline{\lambda}}^{-1} \sigma A$.

Proof. For Part 1, note that $Ad_{\exp(c\Upsilon)} = \exp(ad_{c\Upsilon})$, and recall that $c\Upsilon$ acts via ad on $\mathfrak{m}^+, \mathfrak{k}$, and \mathfrak{m}^- with eigenvalues ci, 0, and -ci, respectively. Part 2 follows immediately from Part 1. Part 3 is a simple computation. Part 4 is proved by computing that both operators act as $\lambda^2 a d_{Z^+}^2 + \frac{1}{\lambda^2} a d_{Z^-}^2 + a d_{Z^+} a d_{Z^-} + a d_{Z^-} a d_{Z^+}$ on \mathfrak{m} , and then Part 5 follows immediately. Part 6 is proved by computing that the operators both act as multiplication by $\frac{2|\lambda|^2}{1+|\lambda|^2}$ on \mathfrak{m}^+ and as multiplication by $\frac{2}{1+|\lambda|^2}$ on \mathfrak{m}^- . Part 7 is an easy computation.

Definition 4.16. For $\lambda \in \mathbb{C}^*$, we define $T_{\lambda} : \mathcal{O} \to \mathcal{O}$ by the rule $Ad_{g_u}Ad_{\exp Z}\Upsilon \mapsto$ $Ad_{q_u}Ad_{\exp t_\lambda Z}\Upsilon.$

It is easy to see that T_{λ} is well-defined and G_u -equivariant.

Proposition 4.17. T_{λ} is a bijection.

Proof. This will be restated below as Corollary 10.7 and proved in Section 11, as a consequence of an explicit formula for T_{λ} (Theorem 10.6).

4.7. The Killing form.

Lemma 4.18. (1) For all $A, B \in \mathfrak{g}$, we have $\kappa([\Upsilon, A], B) = \kappa(\Upsilon, [A, B]) = -\kappa(A, [\Upsilon, B])$. (2) For all $A, B \in \mathfrak{m}$, we have $\kappa(JA, B) = -\kappa(A, JB)$ and $\kappa(JA, JB) = \kappa(A, B)$.

- (3) If $Z \in \mathfrak{m}$, and if p is a power series with only even order terms, such that $p(ad_Z)$
- converges as an operator on \mathfrak{m} (e.g., $p(ad_Z) = E_Z$ or S_Z), then $\kappa(p(ad_Z)A, B) = \kappa(A, p(ad_Z)B)$.
- (4) If $Z \in \mathfrak{m}_0$, and $A, B \in \mathfrak{m}$ are eigenvectors of ad_Z^2 with eigenvalues $\nu_1 \neq \nu_B$, then $\kappa(A, B) = 0$.
- (5) If $\lambda \in \mathbb{C}^*$ and $C, D \in \mathfrak{m}$, then $\kappa(t_{\lambda}C, t_{\lambda}D) = \kappa(C, D)$.
- (6) If $\lambda \in \mathbb{C}^*$ and $C, D \in \mathfrak{m}_0$, then $\kappa(C, D) = 2\Re(\kappa(C^+, D^-))$ and $\kappa(t_{\lambda}C, D) = \lambda\kappa(C^+, D^-) + \frac{1}{\lambda}\overline{\kappa(C^+, D^-)}$.

Proof. (1) is the associativity of the Killing form, and (2) follows since $J = ad_{\Upsilon}$ on \mathfrak{m} and $J^2 = -I$. The proof of (3) reduces to the case $\kappa (ad_Z^2 A, B) = \kappa (A, ad_Z^2 B)$, which follows from $\kappa (ad_Z A, B) = -\kappa (A, ad_Z B)$. Part (4) follows easily from (3). Part (5) follows immediately from Lemma 4.15(1), or by decomposing $t_{\lambda}C$ and $t_{\lambda}D$ into their \mathfrak{m}^+ and $\mathfrak{m}^$ parts and using that \mathfrak{m}^+ is orthogonal to \mathfrak{m}^- under the Killing form. Part (6) is proved using the fact that $C = C^+ + \sigma(C^+)$, $D = D^- + \sigma(D^-)$, and the orthogonality of \mathfrak{m}^+ and \mathfrak{m}^- .

5. Eigenvalues and eigenvectors

(Beyond Theorem 5.2, this section is not needed in the sequel.)

The data for the hyperkähler structure (§7, §8) rely on the maps E_Z , E_{JZ} , S_Z , and S_{JZ} , for $Z \in \mathfrak{m}_0$. Since these are power series in ad_Z^2 or ad_{JZ}^2 , one can understand their actions on \mathfrak{m}_0 once one understands the eigenvalues and eigenvectors of ad_Z^2 and ad_{JZ}^2 on \mathfrak{m}_0 . The computations in this section address that question.

From Proposition 4.2, we conclude that ad_Z^2 and ad_{JZ}^2 are simultaneously diagonalizable on \mathfrak{m}_0 (with nonnegative real eigenvalues), and then E_Z , E_{JZ} , S_Z , and S_{JZ} , are simultaneously diagonalizable.

From $ad_{JZ}^2 = -Jad_Z^2 J$, it is easy to see that:

Lemma 5.1. If $Z, A \in \mathfrak{m}_0$, and if $ad_Z^2 A = \nu_1 A$ and $ad_{JZ}^2 A = \nu_2 A$, then $ad_Z^2(JA) = \nu_2 JA$ and $ad_{JZ}^2(JA) = \nu_1 JA$.

With the notation of Lemma 5.1, using the power series for E_Z , E_{JZ} , S_Z , and S_{JZ} , we have

Theorem 5.2. A is an eigenvector with eigenvalues $\frac{\sinh\sqrt{\nu_1}}{\sqrt{\nu_1}}$, $\frac{\sinh\sqrt{\nu_2}}{\sqrt{\nu_2}}$, $\cosh\sqrt{\nu_1}$, and $\cosh\sqrt{\nu_2}$ respectively, and JA is an eigenvector with eigenvalues $\frac{\sinh\sqrt{\nu_2}}{\sqrt{\nu_2}}$, $\frac{\sinh\sqrt{\nu_1}}{\sqrt{\nu_1}}$, $\cosh\sqrt{\nu_2}$, and $\cosh\sqrt{\nu_1}$ respectively.³

³In particular, note that if $\nu_1 = 0$, then $E_Z(A) = A = S_Z(A)$.

We see that \mathfrak{m}_0 decomposes into *J*-stable subspaces on which the actions of E_Z , E_{JZ} , S_Z , and S_{JZ} are easily understood, once we obtain the eigenvalues and eigenvectors of ad_Z^2 and ad_{JZ}^2 on \mathfrak{m}_0 . That is the remaining goal of this section, culminating in Theorem 5.3 and Corollary 5.4. We will see that these are expressed easily in terms of restricted roots. More precisely, we will describe the *J*-complex subspace $(\mathfrak{m}_0)_{\{\nu_1,\nu_2\}}$ of \mathfrak{m}_0 which is the direct sum of two (real) subspaces, namely, the first being the vectors on which $ad_Z^2 = \nu_1$ and $ad_{JZ}^2 = \nu_2$, the second being the vectors on which $ad_Z^2 = \nu_2$ and $ad_{JZ}^2 = \nu_1$. (Each of these subspaces is a real form of $(\mathfrak{m}_0)_{\{\nu_1,\nu_2\}}$ relative to $\mathbb{C} = \mathbb{R} \oplus \mathbb{R}J$, and each is *J* times the other.) We also will identify the eigenvalue pairs $\{\nu_1,\nu_2\}$ that occur.

Using the notation from §2, we may assume that $Z = \sum \lambda_{\psi} x_{\psi}$ and $JZ = \sum \lambda_{\psi} y_{\psi}$, where the sums are over the maximal collection of strongly orthogonal positive **m**-roots $\{\psi\}$. We write $Z = (I + \sigma)Z^+$ and $A = (I + \sigma)A^+$. By expanding ad_Z^2 and ad_{JZ}^2 , it is easily seen that the system of equations $\{ad_Z^2A = \nu_1A, ad_{JZ}^2A = \nu_2A\}$ is equivalent to the system

$$ad_{Z^+}ad_{\sigma Z^+}A^+ = \frac{\nu_1 + \nu_2}{2}A^+ \qquad (ad_{Z^+}^2 \circ \sigma)A^+ = \frac{\nu_1 - \nu_2}{2}A^+$$

We shall consider the slightly simpler system

$$ad_{Z^+}ad_{\sigma Z^+}A^+ = \frac{\nu_1 + \nu_2}{2}A^+ \qquad ad_{Z^+}^2ad_{\sigma Z^+}^2A^+ = \left(\frac{\nu_1 - \nu_2}{2}\right)^2A^+$$

where the second equation is obtained by applying $ad_{Z^+}^2 \circ \sigma$ twice to A^+ ; we see that A^+ is a solution to this system exactly when $A \in (\mathfrak{m}_0)_{\{\nu_1,\nu_2\}}$, and will write $A^+ \in \mathfrak{m}^+_{\{\nu_1,\nu_2\}}$.

Write $A^+ = \sum A_{\alpha}$, where α runs through the positive restricted **m**-roots.

Examining the first equation in the system, we have that

$$ad_{Z^+}ad_{\sigma Z^+}A^+ = ad_{[Z^+,\sigma Z^+]}A^+ = ad_{\sum\lambda_{\psi}^2 h_{\psi}}A^+ = \sum_{\alpha} ad_{\sum\lambda_{\psi}^2 h_{\psi}}A_{\alpha} = \sum_{\alpha} \alpha \left(\sum\lambda_{\psi}^2 h_{\psi}\right)A_{\alpha}$$

So the first equation in the system holds exactly when $\alpha \left(\sum \lambda_{\psi}^2 h_{\psi}\right) = \frac{\nu_1 + \nu_2}{2}$ whenever $A_{\alpha} \neq 0$.

Turning to the second equation in the system, we compute that

$$ad_{Z^{+}}^{2}ad_{\sigma Z^{+}}^{2}A^{+} = ad_{Z^{+}} \left(ad_{[Z^{+},\sigma Z^{+}]} + ad_{\sigma Z^{+}}ad_{Z^{+}}\right)ad_{\sigma Z^{+}}A^{+}$$
$$= ad_{Z^{+}}ad_{[Z^{+},\sigma Z^{+}]}ad_{\sigma Z^{+}}A^{+} + \left(ad_{Z^{+}}ad_{\sigma Z^{+}}\right)^{2}A^{+}$$
$$= ad_{Z^{+}}ad_{[Z^{+},\sigma Z^{+}]}ad_{\sigma Z^{+}}A^{+} + \left(\frac{\nu_{1}+\nu_{2}}{2}\right)^{2}A^{+}$$

where the last step follows from the first equation in the system. Thus we may replace the second equation in the system with

$$ad_{Z^+}ad_{[Z^+,\sigma Z^+]}ad_{\sigma Z^+}A^+ = \left(\left(\frac{\nu_1 - \nu_2}{2}\right)^2 - \left(\frac{\nu_1 + \nu_2}{2}\right)^2\right)A^+ = -\nu_1\nu_2A^+$$

We can express the left side of this equation in terms of roots, as follows. (Sums with indices ψ and γ are over the maximal set of strongly orthogonal positive **m**-roots.)

$$\begin{aligned} ad_{Z^{+}}ad_{[Z^{+},\sigma Z^{+}]}ad_{\sigma Z^{+}}A^{+} &= \left(ad_{\sum_{\psi}\lambda_{\psi}e_{\psi}}\right)\circ\left(ad_{\sum_{\gamma}\lambda_{\gamma}^{2}h_{\gamma}}\right)\circ\left(ad_{\sum_{\psi}\lambda_{\psi}f_{\psi}}\right)\left(\sum_{\alpha}A_{\alpha}\right) \\ &= \left(ad_{\sum_{\psi}\lambda_{\psi}e_{\psi}}\right)\circ\left(ad_{\sum_{\gamma}\lambda_{\gamma}^{2}h_{\gamma}}\right)\circ\left(\sum_{\alpha}\left(\sum_{\psi}\lambda_{\psi}[f_{\psi},A_{\alpha}]\right)\right) \\ &= \left(ad_{\sum_{\psi}\lambda_{\psi}e_{\psi}}\right)\circ\left(\sum_{\alpha}\sum_{\psi}\lambda_{\psi}\cdot(\alpha-\psi)\left(\sum_{\gamma}\lambda_{\gamma}^{2}h_{\gamma}\right)\cdot[f_{\psi},A_{\alpha}]\right) \\ &= \left(ad_{\sum_{\psi}\lambda_{\psi}e_{\psi}}\right)\circ\left(\sum_{\alpha}\sum_{\psi}\left(\frac{\nu_{1}+\nu_{2}}{2}-2\lambda_{\psi}^{2}\right)\cdot\lambda_{\psi}\cdot[f_{\psi},A_{\alpha}]\right) \\ &= \sum_{\alpha}\sum_{\psi}\left(\frac{\nu_{1}+\nu_{2}}{2}-2\lambda_{\psi}^{2}\right)\cdot\lambda_{\psi}^{2}\cdot[h_{\psi},A_{\alpha}] \\ &\quad (\text{since } [e_{\gamma},[f_{\psi},A_{\alpha}]] = [[e_{\gamma},f_{\psi}],A_{\alpha}] = \delta_{\gamma,\psi}[h_{\psi},A_{\alpha}]) \\ &= \sum_{\alpha}\left(\left(\frac{\nu_{1}+\nu_{2}}{2}\right)\cdot\alpha\left(\sum_{\psi}\lambda_{\psi}^{2}h_{\psi}\right)-2\alpha\left(\sum_{\psi}\lambda_{\psi}^{4}h_{\psi}\right)\right)A_{\alpha} \\ &= \sum_{\alpha}\left(\left(\frac{\nu_{1}+\nu_{2}}{2}\right)^{2}-2\alpha\left(\sum_{\psi}\lambda_{\psi}^{4}h_{\psi}\right)\right)A_{\alpha} \end{aligned}$$

This expression equals $-\nu_1\nu_2A^+$ if and only if, for each α with $A_{\alpha} \neq 0$, we have $\alpha(\sum_{\psi} \lambda_{\psi}^4 h_{\psi}) = \frac{\nu_1^2 + 6\nu_1\nu_2 + \nu_2^2}{8}$.

We summarize this argument with the following theorem. Using the notation developed through this section, we have:

Theorem 5.3. Let $Z = \sum \lambda_{\psi} x_{\psi}$. The space $\mathfrak{m}^+_{\{\nu_1,\nu_2\}}$ is the direct sum of the restricted root spaces \mathfrak{m}^+_{α} , where α satisfies the two conditions $\alpha \left(\sum_{\psi} \lambda_{\psi}^2 h_{\psi} \right) = \frac{\nu_1 + \nu_2}{2}$ and $\alpha \left(\sum_{\psi} \lambda_{\psi}^4 h_{\psi} \right) = \frac{\nu_1^2 + 6\nu_1\nu_2 + \nu_2^2}{8}$.

Of course, for fixed Z, $(\mathfrak{m}_0)_{\{\nu_1,\nu_2\}} = \{0\}$ for almost all choices of $\{\nu_1,\nu_2\}$, with the equations in Theorem 5.3 predicting the exact choices of $\{\nu_1,\nu_2\}$ for which $(\mathfrak{m}_0)_{\{\nu_1,\nu_2\}}$ is nonzero. By simple algebra, we have:

Corollary 5.4. Fix Z as above, let α be a positive restricted \mathfrak{m} -root, and write $x = \alpha \left(\sum_{\psi} \lambda_{\psi}^2 h_{\psi} \right)$ and $y = \alpha \left(\sum_{\psi} \lambda_{\psi}^4 h_{\psi} \right)$. Then \mathfrak{m}_{α}^+ is contained in $\mathfrak{m}_{\{\nu_1,\nu_2\}}^+$, where $\{\nu_1,\nu_2\} = \{x \pm \sqrt{2x^2 - 2y}\}$.

Hence, if we desire to know the simultaneous eigenvalue pairs of ad_Z^2 and ad_{JZ}^2 on \mathfrak{m}_0 , we run through each positive restricted \mathfrak{m} -root α , compute the values of x and y, and obtain the eigenvalue pairs $\{x \pm \sqrt{2x^2 - 2y}\}$. We recall that from classification, the possibilities for α are ψ_s , $\frac{1}{2}(\psi_s + \psi_t)$ with s < t, and (for some but not all Hermitian symmetric spaces)

 $\frac{1}{2}\psi_s$. Relative to $Z = \sum \lambda_{\psi} x_{\psi}$, we find $\{\nu_1, \nu_2\} = \{4\lambda_s^2, 0\}$, $\{(\lambda_s \pm \lambda_t)^2\}$, and $\{\lambda_s^2\}$ (with $\nu_1 = \nu_2$) respectively, for the three cases for α .

6. Some geometric identifications

The purpose of this section is to present several realizations of the cotangent bundle to G_u/K_0 , as well as identifications among them.

6.1. Cotangent bundles and twisted products.

6.1.1. Two twisted products. We identify the real cotangent bundle to G_u/K_0 with $G_u *^{K_0} \mathfrak{m}_u$. As a cotangent vector, $[g_u, W]$ sends the tangent vector $\frac{d}{dt}\Big|_0 g_u \exp(tA)K_0$ to $\kappa(A, W)$. (Here it is enough to consider $A \in \mathfrak{m}_u$.)⁴

We identify the complex cotangent bundle to G/Q with $G *^Q \mathfrak{m}^-$. As a complex cotangent vector, $[g, W^-]$ sends the tangent vector $\frac{d}{dt}|_0 g \exp(tA^+)Q$ to $2\kappa(A^+, W^-)$. Here $G *^Q \mathfrak{m}^-$ carries an obvious complex structure, which we denote by J_3 . Moreover, the obvious action of G on $G *^Q \mathfrak{m}^-$ is holomorphic.

6.1.2. Identifying the two twisted products. As we now describe, there is a simple G_u -equivariant bijection (denoted Θ) between $G *^Q \mathfrak{m}^-$ and $G_u *^{K_0} \mathfrak{m}_u$. Note that by the Iwasawa decomposition of G (or the transitivity of G_u on G/Q), any $g \in G$ can be written as $g = g_u q$ for some $g_u \in G_u$ and $q \in Q$. We then have:

$$\Theta: G *^{Q} \mathfrak{m}^{-} \to G_{u} *^{K_{0}} \mathfrak{m}_{u}$$
$$[g, W^{-}] = [g_{u}q, W^{-}] = [g_{u}, Ad_{q}(W^{-})] \mapsto [g_{u}, (I+\theta)(Ad_{q}(W^{-}))]$$
$$[g_{u}, W^{-}] \leftarrow [g_{u}, (I+\theta)W^{-}]$$

(This tells us how G acts on $G_u *^{K_0} \mathfrak{m}_u J_3$ -holomorphically.)

We make an observation regarding the compatibility of these identifications. Let $g_u \in G_u$, let $W = (I + \theta)W^- \in \mathfrak{m}$ and let $A = (I + \theta)A^+ \in \mathfrak{m}$. In G_u/K_0 , the tangent vector given by the equivalence class of the curve $g_u \exp(tA)K_0$ is sent by the cotangent vector $[g_u, W]$ to $\kappa(A, W) = \kappa(A^+, W^-) + \kappa(\theta A^+, \theta W^-) = 2\Re(\kappa(A^+, W^-))$. However, the curve $g_u \exp(tA)K_0 \sim g_u \exp(tA^+)\exp(t\theta A^+)K_0$ is identified in G/Q with the curve $g_u \exp(tA^+)Q$, which is sent by the cotangent vector $[g_u, W^-]$ to $2\kappa(A^+, W^-)$.

6.2. Cotangent bundles and adjoint orbits.

6.2.1. \mathcal{O} is the cotangent bundle to \mathcal{O}_u . Crucially, the cotangent bundle to the Hermitian symmetric space \mathcal{O}_u can be identified with $\mathcal{O} \subset \mathfrak{g}$, the Ad(G)-orbit of Υ . Verifying that \mathcal{O} gives the cotangent bundle to \mathcal{O}_u relies on an orbit decomposition, as follows. By a decomposition result of Kobayashi [15], $G = G_u \times exp(\mathfrak{m}_0) \times exp(\mathfrak{it}_0)$; from which it follows that $\mathcal{O} \simeq G/K \simeq G_u *^{K_0} \mathfrak{m}_0$, which is the cotangent bundle to $G_u/K_0 \simeq \mathcal{O}_u$.

We will constantly make use of the following fact (see [15]): every element of \mathcal{O} is expressible as $Ad_{g_u}Ad_{\exp Z}\Upsilon$, where $g_u \in G_u$ and $Z \in \mathfrak{m}_0$. The projection of the cotangent bundle on the zero fiber is then given by $\mathcal{O} \to \mathcal{O}_u$, $Ad_{q_u}Ad_{\exp Z}\Upsilon \mapsto Ad_{q_u}\Upsilon$.

⁴Recall that if $A \subset B$ are groups and A acts on a set X, then $B *^{A} X$ is the space of A-orbits on $B \times X$, where ${}^{a}(b,x) = (ba^{-1}, {}^{a}x)$. The image of (b,x) in $B *^{A} X$ is denoted [b,x]. The twisted product $B *^{A} X$ is a bundle over B/A with fiber X.

Note that \mathcal{O} carries an obvious complex structure (which we will denote J_1) and relative to this complex structure, the obvious G-action is holomorphic (even algebraic).

6.2.2. Two identifications of \mathcal{O} and $G_u *^{K_0} \mathfrak{m}_u$. As indicated in Section 6.2.1, we have a bijection

$$\begin{aligned} \Phi_{\mathrm{triv}} : \mathcal{O} &\to \quad G_u *^{K_0} \mathfrak{m}_u \\ Ad_{g_u} Ad_{\exp Z} \Upsilon &\mapsto \quad [g_u, Z] \end{aligned}$$

Unfortunately, Φ_{triv} is not the best isomorphism to use from the point of view of pseudokähler structures, as indicated by the work of other authors. We also will need a map Φ , defined by

$$\begin{aligned} \Phi : \mathcal{O} &\to \quad G_u *^{K_0} \mathfrak{m}_u \\ Ad_{g_u} Ad_{\exp Z} \Upsilon &\mapsto \quad [g_u, J \Im \left(Ad_{\exp Z} \Upsilon \right)] \end{aligned}$$

We spot the appearance of the map P:

Lemma 6.1. (1) We have the equalities

$$\begin{split} \Phi\left(Ad_{g_{u}}Ad_{\exp Z}\Upsilon\right) &= \left[g_{u}, J\Im\left(Ad_{\exp Z}\Upsilon\right)\right] = \left[g_{u}, -\frac{i}{2}J\left(Ad_{\exp(Z)} - Ad_{\exp(-Z)}\right)\Upsilon\right] \\ &= \left[g_{u}, -i\,ad_{\Upsilon}Ad_{\exp Z}\Upsilon\right] = \left[g_{u}, -iJ\,proj_{\mathfrak{m}}^{\mathfrak{g}}\left(Ad_{\exp Z}\Upsilon\right)\right] \\ &= \left[g_{u}, -iJ\,proj_{\mathfrak{m}_{0}}^{\mathfrak{g}_{0}}\left(Ad_{\exp Z}\Upsilon\right)\right] = \left[g_{u}, -i\,P(Z)\right] = \left[g_{u}, -i\,E_{JZ}Z\right]. \end{split}$$

$$(2) \quad If \ Z = \sum_{i} c_{\psi}x_{\psi} \in \mathfrak{a}_{0}, \ then \ \Phi\left(Ad_{g_{u}}Ad_{\exp Z}\Upsilon\right) = \left[g_{u}, \frac{1}{2i}\sum_{i}\sinh(2c_{\psi})x_{\psi}\right]. \end{aligned}$$

$$(3) \ \Phi \ is \ a \ bijection. \end{aligned}$$

$$(4) \ \Phi^{-1} \ takes \ \left[g_{u}, W\right] \ to \ Ad_{g_{u}}Ad_{\exp(P^{-1}(-iW))}\Upsilon. \end{split}$$

Proof. For (1) and (2), see the equalities in the beginning of Section 4.5. Part (3) follows from the fact that $P: \mathfrak{m}_0 \to \mathfrak{m}_0$ is a bijection (Proposition 4.12), and (4) follows from (1).

7. QUATERNIONIC STRUCTURE

In this section, we give the complex structures J_1, J_2, J_3 on $\mathcal{O} \simeq G *^Q \mathfrak{m}^-$. We begin with notation for some easily-described tangent vectors. (At various points in the development of the hyperkähler structure, some of these are easier to work with than others.) The complex structures themselves are defined in Definition 7.3. We describe the almost complex structures in terms of our various tangent vectors.

7.1. Identifications of tangent spaces. Fix $g_u \in G_u$ and $Z \in \mathfrak{m}_0$. Let $(I + \theta)W^- =$ $W = -iP(Z) \in \mathfrak{m}_u$. Let $(A, B) \in \mathfrak{m}_u \times \mathfrak{m}_u$. Write $A = A^+ + A^-$ with $A^+ = \theta A^-$ and similarly for B. We use these data to produce a variety of tangent vectors to $T^*(G_u/K_0)$, in its various manifestations.

Let $(A, B) = \frac{d}{dt} \Big|_{0} Ad_{g_{u}} Ad_{\exp Z} Ad_{\exp t(A+iB)} \Upsilon$, a tangent vector to \mathcal{O} at $Ad_{g_{u}} Ad_{\exp Z} \Upsilon$. Let $(A, B) = \frac{d}{dt} \Big|_{0} Ad_{g_{u}} Ad_{\exp tA} Ad_{\exp(Z+tiB)} \Upsilon$, a tangent vector to \mathcal{O} at $Ad_{g_{u}} Ad_{\exp Z} \Upsilon$. Let $(A, B)^{\sharp} = \frac{d}{dt} \Big|_{0} [g_{u} \exp(tA), W + tB]$, a tangent vector to $G_{u} *^{K_{0}} \mathfrak{m}_{u}$ at $[g_{u}, W]$. Let $(A, B)^{\flat} = \frac{d}{dt} \Big|_{0} [g_{u} \exp(tA^{+}), W^{-} + tB^{-}]$, a tangent vector to $G *^{Q} \mathfrak{m}^{-}$ at $[g_{u}, W^{-}]$.

Lemma 7.1. These tangent vectors are related by the rules

- (1) $(A, B) = (S_Z A, E_Z B)$
- (2) $d\Phi(A,B) = (A, S_{JZ}E_ZB)^{\sharp}$

(3) $d\Theta(A,B)^{\flat} = (A,B)^{\sharp}.$

Proof. For (1), we compute that

$$(A, B) \stackrel{\sim}{\to} Ad_{g_u} Ad_{\exp(tA)} Ad_{\exp(Z+tiB)} \stackrel{\sim}{\Upsilon} \sim Ad_{g_u} Ad_{\exp(tA)} Ad_{\exp(Z)} Ad_{\exp(tE_{Z,l}(iB))} \stackrel{\sim}{\Upsilon} = Ad_{g_u} Ad_{\exp(Z)} Ad_{\exp(tAd_{\exp(-Z)}A)} Ad_{\exp(tE_{Z,l}(iB))} \stackrel{\sim}{\Upsilon}$$

To prove that this gives the tangent vector $(S_Z A, E_Z B)$, we need to show that

$$Ad_{\exp(t(E_{Z,l}(iB)+Ad_{\exp(-Z)}A))}\Upsilon \sim Ad_{\exp t(S_ZA+iE_ZB)}\Upsilon$$

but this is immediate from $[E_{Z,l}B,\Upsilon] = [E_ZB,\Upsilon]$ (Section 4.2) and $[Ad_{\exp(-Z)}A,\Upsilon] = [S_ZA,\Upsilon]$ (Lemma 4.8(1)).

For (2), applying Φ to $Ad_{g_u}Ad_{\exp(tA)}Ad_{\exp(Z+tiB)}\Upsilon$, we obtain $[g_u \exp(tA), -iP(Z+tiB)]$; then use Lemma 4.13.

For (3), we compute that

$$\begin{split} \Theta^{-1}[g_u \exp(tA), W + tB] &= [g_u \exp(tA), W^- + tB^-] \sim [g_u \exp(tA^+) \exp(tA^-), W^- + tB^-] \\ &= [g_u \exp(tA^+), Ad_{\exp(tA^-)}(W^- + tB^-)] \\ &= [g_u \exp(tA^+), W^- + tB^-], \end{split}$$

where at the last step, we use $[\mathfrak{m}^-, \mathfrak{m}^-] = 0$.

7.2. Complex structures.

Definition 7.2. We define $\Gamma : \mathcal{O} \to \mathcal{O}$ to be the bijection $Ad_{g_u}Ad_Z \Upsilon \mapsto Ad_{g_u}Ad_{JZ}\Upsilon$.

Definition 7.3. We define the following complex structures on \mathcal{O} :

- (1) J_1 is the usual complex structure on $\mathcal{O} \simeq G/K$ (coming from the complex structure on G).
- (2) J_2 is the complex structure on \mathcal{O} defined so that the bijection $\Gamma : (\mathcal{O}, J_2) \to (\mathcal{O}, J_1)$ is holomorphic. (See Definition 7.2.)
- (3) J_3 is the complex structure on \mathcal{O} defined so that the bijection $\Theta^{-1} \circ \Phi : (\mathcal{O}, J_3) \to G *^Q \mathfrak{m}^-$ is holomorphic, where $G *^Q \mathfrak{m}^-$ has the usual complex structure coming from G, Q, and \mathfrak{m}^- . (Here the almost complex structure on \mathfrak{m}^- is i, not -i.)

By abuse of notation, we define complex structures J_1 , J_2 , and J_3 on $G *^Q \mathfrak{m}^-$ so that $\Theta^{-1} \circ \Phi$ is holomorphic for the corresponding complex structure on \mathcal{O} , and on $G_u *^{K_0} \mathfrak{m}_u$ so that Φ is holomorphic.

Lemma 7.4.

- (1) $J_1(A, B) = (-B, A)$
- (2) $J_3(A,B)^{\flat} = (JA, -JB)^{\flat}$
- (3) $J_3(A, B)^{\sharp} = (JA, -JB)^{\sharp}$

Proof. The first two statements are immediate, and the third follows from Lemma 7.1(3). \Box

We then compute the almost complex structures for the 'hat' tangent vectors:

Lemma 7.5.

(1) $J_1(A, B) = (-S_Z^{-1}E_ZB, E_Z^{-1}S_ZA)$ (2) $J_2(A, B) = (-JS_Z^{-1}E_ZB, -E_Z^{-1}S_ZJA)$ (3) $J_3(A, B) = (JA, -E_Z^{-1}S_ZJS_Z^{-1}E_ZB)$

Proof. (1) We have that

$$J_1(A,B) = J_1(S_Z A, E_Z B) = (-E_Z B, S_Z A) = (-S_Z^{-1} E_Z B, E_Z^{-1} S_Z A).$$

(2) Using (1), it is easy to compute that $d\Gamma^{-1} \circ J_1 \circ d\Gamma$ carries

$$\frac{d}{dt}\Big|_{0} Ad_{g_{u}}Ad_{\exp(tA)}Ad_{\exp(Z+tiB)}\Upsilon \quad \text{to} \quad \frac{d}{dt}\Big|_{0} Ad_{g_{u}}Ad_{\exp(tA')}Ad_{\exp(Z+tiB')}\Upsilon,$$

where

$$(A',B') = (-S_{JZ}^{-1}E_{JZ}JB, -JE_{JZ}^{-1}S_{JZ}A) = (-JS_{Z}^{-1}E_{Z}B, -E_{Z}^{-1}S_{Z}JA)$$

(3) We use Lemmas 7.4 and 7.1, and compute

$$(A, B)^{\widehat{}} \xrightarrow[d\Phi]{} (A, S_{JZ}E_ZB)^{\sharp} \xrightarrow[J_3]{} (JA, -JS_{JZ}E_ZB)^{\sharp} \xrightarrow[d\Phi^{-1}]{} (JA, -E_Z^{-1}S_{JZ}^{-1}JS_{JZ}E_ZB)$$
which equals $(JA, -E_Z^{-1}S_ZJS_Z^{-1}E_ZB)^{\widehat{}}$ by Lemma 4.8(2).

Lemma 7.5 immediately yields that (J_1, J_2, J_3) comprise a quaternionic structure:

Lemma 7.6.
$$J_1J_2 = J_3 = -J_2J_1$$
.

Lemma 7.1 allows us to express the almost complex structures in Lemma 7.5 for the 'tilde' and 'sharp' tangent vectors. The computations are trivial.

Lemma 7.7. For the 'tilde' tangent vectors:

- (1) $J_1(A, B) = (-B, A)$
- (1) $J_1(A, B) = (-B, A)$ (2) $J_2(A, B) = (-S_Z J S_Z^{-1} B, -S_Z J S_Z^{-1} A)$ (3) $J_3(A, B) = (S_Z J S_Z^{-1} A, -S_Z J S_Z^{-1} B)$

For the 'sharp' tangent vectors:

- (1) $J_1(A, B)^{\sharp} = (-S_Z^{-1}S_{JZ}^{-1}B, S_{JZ}S_ZA)^{\sharp}$ (2) $J_2(A, B)^{\sharp} = (-JS_Z^{-1}S_{JZ}^{-1}B, -S_{JZ}S_ZJA)^{\sharp}$ (3) $J_3(A, B)^{\sharp} = (JA, -JB)^{\sharp}$

with identical formulae for the 'flat' tangent vectors. (Recall that for the 'sharp' tangent vectors, we are considering tangent vectors at $[g_u, W]$, where W = -iP(Z).)

8. Hyperkähler structure

In this section, we deduce formulas for the metric and for the real symplectic forms ω_1 , ω_2, ω_3 , and some additional facts. The starting point is to identify $i(\omega_2 + i\omega_3)$ with the KKS form on \mathcal{O} ; it turns out that $\omega_1 + i\omega_2$ gives the usual holomorphic symplectic form on $G *^Q \mathfrak{m}^-.$

Using ([12], Lemma 6.8), the hyperkähler structure on \mathcal{O} is established once the following has been verified:

Proposition 8.1. $On \mathcal{O}$,

- (1) There exists a pair of complex structures (J_2, J_3) on \mathcal{O} whose associated almost complex structures anticommute.
- (2) There exist closed real 2-forms ω_2 , ω_3 on \mathcal{O} that are J_2 and J_3 -invariant, respectively.
- (3) For all vectors v and w tangent to \mathcal{O} at a point, we have $\omega_2(v, J_2w) = \omega_3(v, J_3w)$.
- (4) The (real symmetric bilinear) form defined by $m(v, w) = \omega_2(v, J_2w) = \omega_3(v, J_3w)$ is positive-definite.

Proof. (1) was verified in Lemma 7.6. For (2), we define $i(\omega_2 + i\omega_3)$ to be the complex Kostant-Kirillov-Souriau form on \mathcal{O} , which is the form (for $g \in G$ and $A_1, B_1, A_2, B_2 \in \mathfrak{g}_u$) that at the point $Ad_q \Upsilon \in \mathcal{O}$, sends the pair of tangent vectors

$$\left(\left.\frac{d}{dt}\right|_{0} A d_{\exp(t(A_{1}+iB_{1}))} A d_{g}\Upsilon, \left.\frac{d}{dt}\right|_{0} A d_{\exp(t(A_{2}+iB_{2}))} A d_{g}\Upsilon\right)$$

to $\kappa (Ad_g \Upsilon, [A_1 + iB_1, A_2 + iB_2])$. Thus ω_2 (resp. ω_3) is the imaginary part (resp. the opposite of the real part) of the KKS form. Using the 'tilde' tangent vectors, we immediately obtain the expressions for ω_2 and ω_3 that appear in Proposition 8.3 below (using Lemma 4.18(1) to obtain the second version of each formula). Since the KKS form is closed, it follows that ω_2 and ω_3 are closed. Using Lemmas 4.1(2) and 4.18(3) and Corollary 4.3, it is easy to prove the required invariance of these forms. Using the same tools along with Lemma 4.1(3), one can then verify the equation in (3) and the formulas for m in Proposition 8.3. The metric is nondegenerate and positive; this follows from the fact that the Killing form is negative-definite on \mathfrak{g}_u , along with Lemma 4.18(4) and Theorem 5.2.

It is straightforward to obtain the following explicit formulae for m, ω_1 , ω_2 , ω_3 , and certain holomorphic symplectic forms, given g_u , Z, and W as earlier. The formulae involve the operators E_Z , S_Z , S_{JZ} ; the effect of these operators is easy to understand in light of Section 5. Note that ω_1 and ω_2 are most easily described using the \sharp or \flat tangent vectors, whereas ω_3 is more natural in the ~ vectors.

Proposition 8.2. On the pair of tangent vectors (A_1, B_1) , (A_2, B_2) , we have

•
$$m = -\kappa (\Upsilon, [S_ZA_1, S_ZJA_2] + [E_ZB_1, S_ZJS_Z^{-1}E_ZB_2])$$

 $= -\kappa (S_{JZ}S_ZA_1, A_2) - \kappa (S_{JZ}S_Z^{-1}E_ZB_1, E_ZB_2)$
• $\omega_1 = \kappa (\Upsilon, [E_ZB_1, S_ZJA_2] - [A_1, S_ZJE_ZB_2])$
 $= -\kappa (A_1, S_{JZ}E_ZB_2) + \kappa (S_{JZ}E_ZB_1, A_2)$
• $\omega_2 = \kappa (\Upsilon, [S_ZA_1, E_ZB_2] + [E_ZB_1, S_ZA_2]) = \kappa (JS_ZA_1, E_ZB_2) - \kappa (E_ZB_1, JS_ZA_2)$
• $\omega_3 = \kappa (\Upsilon, [E_ZB_1, E_ZB_2] - [S_ZA_1, S_ZA_2]) = \kappa (JE_ZB_1, E_ZB_2) - \kappa (JS_ZA_1, S_ZA_2)$
• $\omega_2 + i\omega_3 = -i\kappa (\Upsilon, [S_ZA_1 + iE_ZB_1, S_ZA_2 + iE_ZB_2])$
 $= -i\kappa (J(S_ZA_1 + iE_ZB_1), S_ZA_2 + iE_ZB_2)$

Proposition 8.3. On the pair of tangent vectors (A_1, B_1) , (A_2, B_2) , we have

•
$$m = -\kappa \left(\Upsilon, [A_1, S_Z J S_Z^{-1} A_2] + [B_1, S_Z J S_Z^{-1} B_2]\right)$$

 $= -\kappa \left(S_{JZ} S_Z^{-1} A_1, A_2\right) - \kappa \left(S_{JZ} S_Z^{-1} B_1, B_2\right)$
• $\omega_1 = \kappa \left(\Upsilon, [B_1, S_Z J S_Z^{-1} A_2] - [A_1, S_Z J S_Z^{-1} B_2]\right)$
 $= \kappa \left(S_{JZ} S_Z^{-1} B_1, A_2\right) - \kappa \left(A_1, S_{JZ} S_Z^{-1} B_2\right)$
• $\omega_2 = \kappa \left(\Upsilon, [A_1, B_2] + [B_1, A_2]\right) = \kappa \left(J A_1, B_2\right) - \kappa \left(B_1, J A_2\right)$
• $\omega_3 = \kappa \left(\Upsilon, [B_1, B_2] - [A_1, A_2]\right) = \kappa \left(J B_1, B_2\right) - \kappa \left(J A_1, A_2\right)$
• $\omega_2 + i\omega_3 = -i\kappa \left(\Upsilon, [A_1 + iB_1, A_2 + iB_2]\right) = -i\kappa \left(J (A_1 + iB_1), A_2 + iB_2\right)$

Proposition 8.4. On the pair of tangent vectors $(A_1, B_1)^{\sharp}, (A_2, B_2)^{\sharp}$, we have

•
$$m = -\kappa \left(\Upsilon, [S_Z A_1, S_Z J A_2] + [S_{JZ}^{-1} B_1, S_{JZ}^{-1} J B_2]\right)$$

 $= -\kappa \left(S_{JZ} S_Z A_1, A_2\right) - \kappa \left(S_{JZ}^{-1} S_Z^{-1} B_1, B_2\right)$
• $\omega_1 = \kappa \left(\Upsilon, [B_1, J A_2] - [A_1, J B_2]\right) = -\kappa (A_1, B_2) + \kappa (B_1, A_2)$
• $\omega_2 = \kappa \left(\Upsilon, [A_1, B_2] + [B_1, A_2]\right) = -\kappa (A_1, J B_2) + \kappa (J B_1, A_2)$
• $\omega_3 = \kappa \left(\Upsilon, [S_{JZ}^{-1} B_1, S_{JZ}^{-1} B_2] - [S_Z A_1, S_Z A_2]\right)$
 $= \kappa \left(S_{JZ}^{-1} S_Z^{-1} J B_1, B_2\right) - \kappa \left(S_{JZ} S_Z J A_1, A_2\right)$

•
$$\omega_1 + i\omega_2 = \kappa (\Upsilon, [A_1, (iI - J)B_2] + [B_1, (iI + J)A_2])$$

= $-\kappa (A_1, B_2) + \kappa (B_1, A_2) - i\kappa (A_1, JB_2) + i\kappa (JB_1, A_2)$

The formulae in Proposition 8.4 are also valid for the 'flat' vector fields. However, it is also convenient to express these formulae in terms of $A_1^+, A_1^-, B_2^+, B_2^-$. Recall that by Lemma 4.8(3), $S_{JZ} \circ S_Z$ preserves \mathfrak{m}^+ .

Proposition 8.5. On the pair of tangent vectors $(A_1, B_1)^{\flat}, (A_2, B_2)^{\flat}$, we have

- $m = -2\Re \left(\kappa \left(S_{JZ} S_Z A_1^+, A_2^- \right) + \kappa \left(S_{JZ}^{-1} S_Z^{-1} B_1^+, B_2^- \right) \right)$
- $\omega_1 = 2\Re \left(\kappa \left(B_1^+, A_2^- \right) \kappa \left(A_1^+, B_2^- \right) \right)$
- $\omega_2 = -2\Im\left(\kappa\left(A_1^+, B_2^-\right) + \kappa\left(B_1^+, A_2^-\right)\right)$ $\omega_3 = 2\Im\left(\kappa\left(S_{JZ}S_ZA_1^+, A_2^-\right) \kappa\left(S_{JZ}^{-1}S_Z^{-1}B_1^+, B_2^-\right)\right)$ $\omega_1 + i\omega_2 = 2\kappa\left(B_1^-, A_2^+\right) 2\kappa\left(A_1^+, B_2^-\right)$

In the remainder of this section, we present some facts about the symplectic forms and Kähler potentials.

Proposition 8.6. Under the identification of $G *^Q \mathfrak{m}^-$ as the complex contangent bundle of G/Q,

- (1) At $[g, W^-] \in G *^Q \mathfrak{m}^-$, the canonical 1-form $\lambda_{\mathbb{C}}$ on $G *^Q \mathfrak{m}^-$ sends $(A, B)^{\flat}$ to $2\kappa(A^+, W^-).$
- (2) The canonical (complex) 2-form $d\lambda_{\mathbb{C}}$ equals $\omega_1 + i\omega_2$.

Proof. Part (1) comes from the identification in Section 6.1. For (2), we need to compute $d\lambda_{\mathbb{C}}$. To get around the fact that the 'flat' tangent vectors do not give vector fields on $G *^Q \mathfrak{m}^-$, we work in $G \times \mathfrak{m}^-$, whose quotient by Q gives $G *^Q \mathfrak{m}^-$. On $G \times \mathfrak{m}^-$, for each $(A^+, B^-) \in \mathfrak{m}^+ \times \mathfrak{m}^-$, we have a globally defined vector field $(A^+, B^-)^{\heartsuit} =$ $\frac{d}{dt}\Big|_0 (g \exp(tA^+), W^- + tB^-)$. We note that the bracket of two 'heart' vector fields is zero; in the first component, we use that $[\mathfrak{m}^+,\mathfrak{m}^+] = 0$, and the statement is obvious in the second component. Also, note that for the obvious lift of $\lambda_{\mathbb{C}}$ to $G \times \mathfrak{m}^-$, we have $(A_1^+, B_1^-)^{\heartsuit} \left(\lambda_{\mathbb{C}}(A_2^+, B_2^-)^{\heartsuit} \right) = (A_1^+, B_1^-)^{\heartsuit} \left(2\kappa(A_2^+, W^-) \right) = 2\kappa(A_2^+, B_1^-).$ Using the usual formula for the external derivative of a 1-form,⁵ we obtain $d\lambda_{\mathbb{C}}\left((A_1^+, B_1^-)^{\heartsuit}, (A_2^+, B_2^-)^{\heartsuit}\right) =$ $2\kappa(A_2^+, B_1^-) - 2\kappa(A_1^+, B_2^-)$. Pushing this down to $G *^Q \mathfrak{m}^-$ and comparing with Proposition 8.5, we obtain (2).

In a similar way,

Proposition 8.7. Under the identification of $G_u *^{K_0} \mathfrak{m}_u$ as the real contangent bundle of G_u/K_0 ,

- (1) At $[g_u, W] \in G_u *^{K_0} \mathfrak{m}_u$, the canonical 1-form $\lambda_{\mathbb{R}}$ on $G_u *^{K_0} \mathfrak{m}_u$ sends $(A, B)^{\sharp}$ to $\kappa(A, W)$, and coincides with $\Re(\lambda_{\mathbb{C}})$.
- (2) The canonical (real) 2-form $d\lambda_{\mathbb{R}}$ equals ω_1 .

We also regard $\lambda_{\mathbb{C}}$ and $\lambda_{\mathbb{R}}$ as 1-forms on \mathcal{O} , via Φ .

Definition 8.8. Define $\phi : \mathcal{O} \to \mathbb{R}$, $Ad_{q_u}Ad_{\exp Z}\Upsilon \mapsto \kappa (Ad_{\exp Z}\Upsilon,\Upsilon)$.

The following proposition, combined with Proposition 8.7, shows that ϕ is a Kähler potential for ω_1 , relative to J_1 , as proved in [1].

 ${}^{5}d\lambda(X,Y) = X(\lambda(Y)) - Y(\lambda(X)) - \lambda([X,Y])$

Proposition 8.9. $\lambda_{\mathbb{R}} = d_1^c \phi$, where d_1^c denotes d^c with respect to the complex structure J_1 .

Proof. Let $A, B \in \mathfrak{m}_u$. We compare $\lambda_{\mathbb{R}}(A, B)$ with $(d_1^c \phi)(A, B)$.

On the one hand, by Lemma 7.1, (A, B) at $Ad_{g_u}Ad_{\exp Z}\Upsilon$ corresponds under Φ to $(A, S_{JZ}E_ZB)^{\sharp}$ at $[g_u, -iP(Z)]$, which by Proposition 8.7(1), is sent by $\lambda_{\mathbb{R}}$ to $\kappa(A, -iP(Z))$. On the other hand, by Lemma 7.5(1),

$$\begin{aligned} (d_1^c \phi)(A, B)^{\widehat{}} &= (J_1(A, B))^{\widehat{}}(\phi) \\ &= \frac{d}{dt} \Big|_0 \kappa \left(A d_{\exp(Z + tiE_Z^{-1}S_Z A)} \Upsilon, \Upsilon \right) \\ &= \frac{d}{dt} \Big|_0 \kappa \left(A d_{\exp(tiE_{Z,r}E_Z^{-1}S_Z A)} A d_{\exp Z} \Upsilon, \Upsilon \right) \\ &= i\kappa \left([E_{Z,r}E_Z^{-1}S_Z A, A d_{\exp Z} \Upsilon], \Upsilon \right) = i\kappa \left(E_{Z,r}E_Z^{-1}S_Z A, [A d_{\exp Z} \Upsilon, \Upsilon] \right) \\ &= \kappa \left(E_{Z,r}E_Z^{-1}S_Z A, -iP(Z) \right), \end{aligned}$$

the last equality following from the definition of P(Z). Since $\kappa(\mathfrak{k}, \mathfrak{m}) = 0$, we may replace $E_{Z,r}$ with E_Z , yielding $\kappa(S_ZA, -iP(Z))$. By Lemma 4.18(3), this equals $\kappa(A, -iS_ZP(Z))$. Taking \mathfrak{a}_0 so that $Z \in \mathfrak{a}_0$, we have that $P(Z) \in \mathfrak{a}_0$ (Section 4.5), and it follows that $\kappa(A, -iS_ZP(Z)) = \kappa(A, -iP(Z))$ by Section 5.

In fact, ϕ is related to another Kähler potential, viewed in the setting of $G_u *^{K_0} \mathfrak{m}_u$:

Definition 8.10. Define $\phi': G_u *^{K_0} \mathfrak{m}_u \to \mathbb{R}, [g_u, W] \mapsto 2\kappa(P(\frac{1}{2}P^{-1}(iW)), P(\frac{1}{2}P^{-1}(iW))).$

Proposition 8.11. ϕ' is a Kähler potential for ω_1 , relative to J_1 .

Proof. Beginning with the definition of ϕ , we have

$$\phi(Ad_{g_u}Ad_{\exp Z}\Upsilon) = \kappa(Ad_{\exp Z}\Upsilon,\Upsilon) = \kappa(Ad_{\exp Z/2}\Upsilon,Ad_{\exp -Z/2}\Upsilon)$$
$$= \kappa(X+Y,X-Y) = \kappa(X,X) - \kappa(Y,Y)$$

where

$$\begin{split} X &= \mathrm{pr}_{\mathfrak{k}}^{\mathfrak{g}} A d_{\exp Z/2} \Upsilon = \frac{1}{2} \left(A d_{\exp Z/2} + A d_{\exp -Z/2} \right) \Upsilon \in \mathfrak{k}_{0} \\ Y &= \mathrm{pr}_{\mathfrak{m}}^{\mathfrak{g}} A d_{\exp Z/2} \Upsilon = \frac{1}{2} \left(A d_{\exp Z/2} - A d_{\exp -Z/2} \right) \Upsilon \in \mathfrak{m}_{0} \end{split}$$

But one computes easily that $\kappa(X, X) = \frac{1}{2}\kappa(\Upsilon, \Upsilon) + \frac{1}{2}\phi(Ad_{g_u}Ad_{\exp Z}\Upsilon)$. Combining with the first equation in the proof, one concludes that $\phi(Ad_{g_u}Ad_{\exp Z}\Upsilon) = -2\kappa(Y,Y) + \kappa(\Upsilon,\Upsilon)$. Recall that $Z = P^{-1}(iW)$. We claim that $Y = -iP(\frac{1}{2}P^{-1}(iW))$. This is equivalent to

 $pr_{\mathfrak{m}}^{\mathfrak{g}} Ad_{\exp Z/2} \Upsilon = -iP(\frac{1}{2}Z), \text{ which follows directly from the definition of } P.$ Finally, $\phi(Ad_{g_u}Ad_{\exp Z}\Upsilon) = 2\kappa(P(\frac{1}{2}P^{-1}(iW)), P(\frac{1}{2}P^{-1}(iW))) + \kappa(\Upsilon,\Upsilon), \text{ so } \phi \text{ and } \phi'$

Finally, $\phi(Ad_{g_u}Ad_{\exp Z}1) = 2\kappa(P(\frac{1}{2}P^{-1}(iW)), P(\frac{1}{2}P^{-1}(iW))) + \kappa(1, 1)$, so ϕ and ϕ differ by a constant.

9. Moment maps

We give moment maps for the G_u -action on $G_u *^{K_0} \mathfrak{m}_u$ (Proposition 9.2) and on \mathcal{O} (Proposition 9.4, relative to the symplectic structures ω_1, ω_2 , and ω_3 . The definition of a moment map is required in the proofs in §11, but the formulae for μ_1, μ_2 , and μ_3 derived in this section are not needed there.

Definition 9.1. Let (M, ω) be a symplectic manifold and suppose that H is a simple Lie group that acts symplectically on M. A moment map is an H-equivariant map $\mu: M \to \mathfrak{h}$ with the property that

$$\kappa \left(d\mu_p(\chi_p), X \right) = \omega \left(\chi_p, \eta_X \right)$$

for all $p \in M$, for all vectors χ_p tangent to M at p, and for all $X \in \mathfrak{h}$. Here η_X denotes the tangent vector (at p) induced by X via the action of H.⁶

Proposition 9.2. On $G_u *^{K_0} \mathfrak{m}_u$, with respect to the symplectic forms ω_1 , ω_2 , and ω_3 , we have moment maps $\mu_i : G_u *^{K_0} \mathfrak{m}_u \to \mathfrak{g}_u$, given by

$$\mu_1 ([g_u, W]) = A d_{g_u} W \mu_2 ([g_u, W]) = A d_{g_u} J W \mu_3 ([g_u, W]) = \frac{1}{2} A d_{g_u} (A d_{\exp(P^{-1}(iW))} + A d_{\exp(-P^{-1}(iW))}) \Upsilon$$

Proof. With the putative formula for μ_1 and $A, B \in \mathfrak{m}_u$, at $[g_u, W]$, we have that $d\mu_1 (A, B)^{\sharp} = Ad_{g_u}B + Ad_{g_u}[A, W]$. Let $X \in \mathfrak{g}_u$; it is easy to see that at $[g_u, W]$, we have $\eta_{Ad_{g_u}X} = \left(proj_{\mathfrak{m}_u}^{\mathfrak{g}_u}X, [proj_{\mathfrak{k}_0}^{\mathfrak{g}_u}X, W]\right)^{\sharp}$. We must verify the equation $\kappa (Ad_{g_u}B + Ad_{g_u}[A, W], Ad_{g_u}X) = \omega_1 \left((A, B)^{\sharp}, (proj_{\mathfrak{m}_u}^{\mathfrak{g}_u}X, [proj_{\mathfrak{k}_0}^{\mathfrak{g}_u}X, W])^{\sharp}\right)$. Using the fact that \mathfrak{k} and \mathfrak{m} are orthogonal under κ , the left side reduces to $\kappa (B, proj_{\mathfrak{m}_u}^{\mathfrak{g}_u}X) + \kappa \left([A, W], proj_{\mathfrak{k}_0}^{\mathfrak{g}_u}X\right)$. So does the right side, using Proposition 8.4 and the associativity of the Killing form. The proof for μ_2 is similar. The proof for μ_3 will be given at the end of the proof of Proposition 9.4.

Corollary 9.3. The g-valued, G-equivariant, J_3 -holomorphic moment map on $G *^Q \mathfrak{m}^$ relative to the holomorphic symplectic form $\omega_1 + i\omega_2$, is given by $(\mu_1 + i\mu_2)([g, W^-]) = 2Ad_gW^-$.

Proof. Let $g = g_u q \in G$, with $g_u \in G_u$ and $q \in Q$. Then $[g, W^-]$ is mapped by Θ to $[g_u, (I + \theta)(Ad_q(W^-))]$, which (Proposition 9.2) is sent by $\mu_1 + i\mu_2$ to

$$\begin{aligned} Ad_{g_u}\left((I+iJ)(I+\theta)(Ad_q(W^-))\right) &= Ad_{g_u}\left((I+iJ+\theta+iJ\theta)(Ad_qW^-)\right) \\ &= Ad_{g_u}\left((I+iJ+\theta-\theta iJ)(Ad_qW^-)\right) \\ &= 2Ad_{g_u}Ad_qW^- = 2Ad_gW^-, \end{aligned}$$

using that $Ad_qW^- \in \mathfrak{m}^-$.

Proposition 9.4. On \mathcal{O} , with respect to the symplectic forms ω_1 , ω_2 , and ω_3 , we have moment maps $\mu_i : \mathcal{O} \to \mathfrak{g}_u$, given by

$$\begin{split} \mu_1 \left(Ad_{g_u} Ad_{\exp Z} \Upsilon \right) &= \Im \left(Ad_{g_u} Ad_{\exp(JZ)} \Upsilon \right) \\ \mu_2 \left(Ad_{g_u} Ad_{\exp Z} \Upsilon \right) &= -\Im \left(Ad_{g_u} Ad_{\exp Z} \Upsilon \right), \text{ or otherwise said,} \\ \mu_2 \left(Ad_g \Upsilon \right) &= -\Im \left(Ad_g \Upsilon \right) \\ \mu_3 \left(Ad_{g_u} Ad_{\exp Z} \Upsilon \right) &= \Re \left(Ad_g \Upsilon \right) \end{split}$$

Proof. We first consider μ_2 . We note that $Ad_{g_u}Ad_{\exp Z}\Upsilon$ is sent by Φ to $[g_u, -iP(Z)]$; Proposition 9.2 tells us that this is sent by μ_2 to $-iAd_{g_u}JP(Z) = iAd_{g_u}proj_{i\mathfrak{q}_u}^{\mathfrak{g}}(Ad_{\exp Z}\Upsilon) =$

⁶It is customary to define moment maps as having target \mathfrak{h}^* , but if *H* is simple, our definition is equivalent.

 $-\Im (Ad_{g_u}Ad_{\exp Z}\Upsilon)$. The expression for μ_1 is obtained in a similar way. It remains to consider μ_3 .

With the putative formula $\mu_3 \left(Ad_{g_u}Ad_{\exp Z}\Upsilon\right) = \frac{1}{2}Ad_{g_u}\left(Ad_{\exp Z} + Ad_{\exp(-Z)}\right)\Upsilon$, we have easily that

$$d\mu_{3} \left((A,B) \right) = \frac{1}{2} A d_{g_{u}} \left[A, \left(A d_{\exp Z} + A d_{\exp(-Z)} \right) \Upsilon \right]$$

+
$$\frac{1}{2} A d_{g_{u}} \left(A d_{\exp Z} \left[E_{Z} i B, \Upsilon \right] + A d_{\exp(-Z)} \left[E_{(-Z)} (-iB), \Upsilon \right] \right)$$

which simplifies to $\frac{1}{2}Ad_{g_u}[A, (Ad_{\exp Z} + Ad_{\exp(-Z)})\Upsilon] - \frac{i}{2}Ad_{g_u}(Ad_{\exp Z} - Ad_{\exp(-Z)})JE_ZB.$ It follows that for $X \in \mathfrak{g}_u$,

$$\kappa \left(d\mu_m(\chi_m), Ad_{g_u} X \right) = \kappa \left(\frac{1}{2} Ad_{g_u} \left[A, \left(Ad_{\exp Z} + Ad_{\exp(-Z)} \right) \Upsilon \right], Ad_{g_u} X \right) - \kappa \left(\frac{i}{2} Ad_{g_u} \left(Ad_{\exp Z} - Ad_{\exp(-Z)} \right) JE_Z B, Ad_{g_u} X \right) = \kappa \left(\frac{1}{2} \left[A, \left(Ad_{\exp Z} + Ad_{\exp(-Z)} \right) \Upsilon \right] - \frac{i}{2} \left(Ad_{\exp Z} - Ad_{\exp(-Z)} \right) JE_Z B, X \right)$$

On the other hand, from

$$\begin{aligned} Ad_{\exp(tAd_{g_u}X)}Ad_{g_u}Ad_{\exp Z}\Upsilon &= Ad_{g_u}Ad_{\exp(tX)}Ad_{\exp Z}\Upsilon \\ &\sim Ad_{g_u}Ad_{\exp(t\,proj_{m_u}^{\mathfrak{g}_u}X)}Ad_{\exp(t\,proj_{\mathfrak{f}_0}^{\mathfrak{g}_u}X)}Ad_{\exp Z}\Upsilon \\ &\sim Ad_{g_u}Ad_{\exp(t\,proj_{m_u}^{\mathfrak{g}_u}X)}Ad_{\exp(Z+t[proj_{\mathfrak{f}_0}^{\mathfrak{g}_u}X,Z])}\Upsilon \end{aligned}$$

we conclude that $\eta_{Ad_{g_u}X} = \left(proj_{\mathfrak{m}_u}^{\mathfrak{g}_u}X, -i[proj_{\mathfrak{k}_0}^{\mathfrak{g}_u}X, Z] \right)^{\hat{}}$. From Proposition 8.2 and Lemma 4.18, it follows that

$$\begin{split} \omega_{3}\left((A,B),\eta_{Ad_{g_{u}}proj_{\mathfrak{m}_{u}}^{\mathfrak{g}_{u}}X}\right) &= -\kappa\left(JS_{Z}A,S_{Z}proj_{\mathfrak{m}_{u}}^{\mathfrak{g}_{u}}X\right) + \kappa\left(JE_{Z}B,-iE_{Z}[proj_{\mathfrak{k}_{0}}^{\mathfrak{g}_{u}}X,Z]\right) \\ &= -\kappa\left(S_{Z}JS_{Z}A,proj_{\mathfrak{m}_{u}}^{\mathfrak{g}_{u}}X\right) - i\kappa\left(ad_{Z}E_{Z}JE_{Z}B,proj_{\mathfrak{k}_{0}}^{\mathfrak{g}_{u}}X\right) \\ &= -\kappa\left(S_{Z}JS_{Z}A,X\right) - i\kappa\left(ad_{Z}E_{Z}JE_{Z}B,X\right). \end{split}$$

using the orthogonality of \mathfrak{k}_0 and \mathfrak{m}_0 .

To verify the formula for μ_3 , by Definition 9.1, we must verify that

$$\frac{1}{2}[A, (Ad_{\exp Z} + Ad_{\exp(-Z)}) \Upsilon] = -S_Z J S_Z A$$

$$\frac{1}{2} (Ad_{\exp Z} - Ad_{\exp(-Z)}) J E_Z B = ad_Z E_Z J E_Z B$$

The first equation follows from Lemma 4.9(2), while the second equation follows from Lemma 4.10.

Finally, we obtain the version of μ_3 in Proposition 9.2 using Lemmas 6.1(4) and 4.11(3).

Corollary 9.5. The g-valued, G-equivariant, J_1 -holomorphic moment map on \mathcal{O} , relative to the holomorphic symplectic form $-i\omega_2 + \omega_3$, is $-i\mu_2 + \mu_3$, which is simply the inclusion map.

10. Statements of Main Results

The following theorem shows that for $\lambda \in \mathbb{C}^*$, T_{λ} intertwines $J_{(\lambda)}$ with J_1 . Thus, except for $\pm J_3$, all complex structures on \mathcal{O} arising from the hyperkähler structure are G_u -equivariantly equivalent to J_1 via an explicit map.

Theorem 10.1. Let $\lambda \in \mathbb{C}^*$, let $A, B \in \mathfrak{m}_u$, let $Z \in \mathfrak{m}_0$, and let $g_u \in G_u$. We have $dT_{\lambda}^{-1} \circ J_1 \circ dT_{\lambda}(A, B)_{g_u, Z} = J_{(\lambda)}(A, B)_{g_u, Z} \square$

Recall that J_1 gives the usual complex structure on \mathcal{O} , and the usual holomorphic action of G on \mathcal{O} is $(g, x) \mapsto Ad_g(x)$ (where $x \in \mathcal{O}$). For $\lambda \in \mathbb{C}^*$ (which is to say, $J_{(\lambda)} \neq \pm J_3$), we have:

Corollary 10.2. (1) For \mathcal{O} equipped with the complex structure $J_{(\lambda)}$, there is a holomorphic action of G given by $(g, x) \mapsto T_{\lambda}^{-1} \circ Ad_g \circ T_{\lambda}(x)$.

- (2) This holomorphic action extends the standard action of G_u on \mathcal{O} via Ad.
- (3) This holomorphic action is transitive.⁷

The map T_{λ} also intertwines holomorphic symplectic forms for the complex structures $J_{(\lambda)}$ and J_1 , as we now make precise. Beginning with $\lambda \in \mathbb{C}^*$, we can construct a holomorphic symplectic form relative to $J_{(\lambda)}$ as follows. We use the notation from Section 2. Noting that the vector $(\lambda_1, \lambda_2, \lambda_3)$ is orthogonal to the vector $\frac{1}{\lambda_1^2 + \lambda_2^2}(-\lambda_2, \lambda_1, 0)$ and that their cross product is $\frac{1}{\lambda_1^2 + \lambda_2^2}(-\lambda_1\lambda_3, -\lambda_2\lambda_3, \lambda_1^2 + \lambda_2^2)$, we obtain the holomorphic symplectic form

$$\frac{1}{\lambda_2^2 + \lambda_2^2} \left((-\lambda_2 - i\lambda_1\lambda_3)\omega_1 + (\lambda_1 - i\lambda_2\lambda_3)\omega_2 + i(\lambda_1^2 + \lambda_2^2)\omega_3 \right)$$

which simplifies to $\frac{i}{2} (\lambda - \lambda^{-1}) \omega_1 + \frac{1}{2} (\lambda + \lambda^{-1}) \omega_2 + i\omega_3$. In fact, this is the pullback via the map T_{λ} of the standard holomorphic symplectic form relative to J_1 :

Theorem 10.3. $(dT_{\lambda})^*(\omega_2 + i\omega_3) = \frac{i}{2} (\lambda - \lambda^{-1}) \omega_1 + \frac{1}{2} (\lambda + \lambda^{-1}) \omega_2 + i\omega_3$

Above, we showed the equivalence between the complex structures J_1 and $J_{(\lambda)} \neq \pm J_3$, their associated holomorphic G actions, and their associated holomorphic symplectic forms. Below, we show that in contrast, the real symplectic forms associated to the various $J_{(\lambda)}$ are deformations of the real symplectic form ω_3 associated to J_3 , except when $|\lambda| = 1$.

are deformations of the real symplectic form ω_3 associated to J_3 , except when $|\lambda| = 1$. Specifically, given $\lambda \in \mathbb{C}^*$ with $|\lambda| \neq 1$, define $\nu = \nu(\lambda) = \frac{\lambda(1+|\lambda|)}{|\lambda|(1-|\lambda|)} \in \mathbb{C}^*$. The following theorem shows that the pullback via T_{ν} of the standard real symplectic form for J_3 is a nonzero constant multiple of the standard real symplectic form for $J_{(\lambda)}$:

Theorem 10.4.
$$\frac{1-|\lambda|^2}{1+|\lambda|^2} (dT_{\nu})^*(\omega_3) = \omega_{(J)}$$

It follows that for each real symplectic form $\omega_{(\lambda_1,\lambda_2,\lambda_3)}$ with $\lambda_3 \neq 0$, the corresponding moment map is, up to scalar multiple, a deformation (via T_{ν}) of the moment map μ_3 associated with ω_3 :

Corollary 10.5. For all $\lambda \in \mathbb{C}^*$ with $|\lambda| \neq 1$, we have $\mu_{(\lambda)} = \frac{1 - |\lambda|^2}{1 + |\lambda|^2} \mu_3 \circ T_{\nu}$.

⁷Note the change at J_3 . Here the holomorphic action is the usual action of G on $G *^Q \mathfrak{m}^-$, which is not transitive.

Finally, we give explicit formulas for the function T_{λ} , both on \mathcal{O} , and (via Φ) on $G_u *^{K_0} \mathfrak{m}_u$.

Theorem 10.6. (1) Let $g_u \in G_u$ and let $Z \in \mathfrak{m}_0$; without loss of generality we may assume that $Z = \sum c_{\psi} x_{\psi} \in \mathfrak{a}_0$ for some $\{c_{\psi}\} \subset \mathbb{R}$. Let $\lambda \in \mathbb{C}^*$, and write $\lambda = |\lambda| u^2$ where |u| = 1. We then have that $T_{\lambda} : \mathcal{O} \to \mathcal{O}$ is given by $Ad_{g_u}Ad_{\exp Z}\Upsilon \mapsto Ad_{g'_u}Ad_{\exp Z'}\Upsilon$, where

$$g'_{u} = g_{u} \cdot \Pi_{\psi} \exp(i \cdot s_{\psi} \cdot t_{u^{2}}(y_{\psi}))$$
$$Z' = \sum_{\psi} r_{\psi} \cdot t_{u^{2}}(x_{\psi})$$

and where

$$s_{\psi} = \frac{1}{2} \arctan\left(\frac{1}{2}\left(\frac{1}{|\lambda|} - |\lambda|\right) \tanh(2c_{\psi})\right)$$
$$r_{\psi} = \frac{1}{2} \operatorname{arcsinh}\left(\frac{1}{2}\left(\frac{1}{|\lambda|} + |\lambda|\right) \sinh(2c_{\psi})\right)$$

(2) Let $g_u \in G_u$ and let $W \in \mathfrak{m}_u$; without loss of generality we may assume that $W = \sum_{i \neq \psi} id_{\psi}x_{\psi} \in \mathfrak{ia}_0$ for some $\{d_{\psi}\} \subset \mathbb{R}$. Take λ as above. We then have that $\Phi \circ T_{\lambda} \circ \Phi^{-1}$: $G_u *^{K_0} \mathfrak{m}_u \to G_u *^{K_0} \mathfrak{m}_u$ is given by $[g_u, W] \mapsto [g'_u, W']$, where

$$g'_{u} = g_{u} \cdot \Pi_{\psi} \exp(i \cdot s_{\psi} \cdot t_{u^{2}}(y_{\psi}))$$
$$W' = \frac{i}{2} \left(\frac{1}{|\lambda|} + |\lambda|\right) \sum_{\psi} d_{\psi} \cdot t_{u^{2}}(x_{\psi}) = \frac{1}{2} \left(t_{\lambda} + t_{1/\overline{\lambda}}\right) W$$

and where

$$s_{\psi} = \frac{1}{2} \arctan\left(\left(\frac{1}{|\lambda|} - |\lambda|\right) \left(\frac{-d_{\psi}}{1 + 4d_{\psi}^2}\right)\right) \quad \Box$$

Note that for λ as written, the role of u is relatively uninteresting, compared to the situation when $|\lambda| \neq 1$. Note also the remarkably simple formula $W' = \frac{1}{2} \left(t_{\lambda} + t_{1/\overline{\lambda}} \right) W$.

Corollary 10.7. T_{λ} is a bijection.

11. Proofs of Main Results

11.1. Proof of Theorem 10.1.

Proposition 11.1. Let $g \in G$, and $X, A_0, B_0, C, D \in \mathfrak{m}$. The following are equivalent:

(1) $\frac{d}{dt}\Big|_{0} Ad_{g}Ad_{\exp tC}Ad_{\exp(X+itD)}\Upsilon = \frac{d}{dt}\Big|_{0} Ad_{g}Ad_{\exp tiA_{0}}Ad_{\exp(X-tB_{0})}\Upsilon$

$$(2) \quad S_XC + iE_XD = iS_XA_0 - E_XB_0$$

Proof.

1.
$$\Leftrightarrow Ad_{\exp(X+itD)}\Upsilon \sim Ad_{\exp t(iA_0-C)}Ad_{\exp(X-tB_0)}\Upsilon$$
$$\Leftrightarrow Ad_{\exp X}Ad_{\exp t E_{X,r}(iD)}\Upsilon \sim Ad_{\exp t(iA_0-C)}Ad_{\exp X}Ad_{\exp t E_{X,r}(-B_0)}\Upsilon$$
$$\Leftrightarrow Ad_{\exp X}Ad_{\exp t E_{X,r}(iD)}\Upsilon \sim Ad_{\exp X}Ad_{\exp t(Ad_{\exp -X}(iA_0-C)-E_{X,r}(B_0))}\Upsilon$$
$$\Leftrightarrow E_{X,r}(iD) \equiv Ad_{\exp -X}(iA_0-C) - E_{X,r}(B_0) \mod \mathfrak{t}$$
$$\Leftrightarrow E_X(iD) = S_X(iA_0-C) - E_X(B_0) \Leftrightarrow 2.$$

We proceed to the proof of Theorem 10.1. Let $g_0 \in G_u$, $Z \in \mathfrak{m}_0$, and $A, B \in \mathfrak{m}_u$. We compute:

$$(A, B)_{g_u, Z} = \frac{d}{dt} \Big|_{0} Ad_{g_u} Ad_{\exp tA} Ad_{\exp(Z + itB)} \Upsilon$$
$$\stackrel{\mapsto}{\underset{dT_{\lambda}}{\mapsto}} \frac{d}{dt} \Big|_{0} Ad_{g_u} Ad_{\exp tA} Ad_{\exp(t_{\lambda}Z + tit_{\lambda}B)} \Upsilon$$
$$\stackrel{\mapsto}{\underset{J_{1}}{\to}} \frac{d}{dt} \Big|_{0} Ad_{g_u} Ad_{\exp tiA} Ad_{\exp(t_{\lambda}Z - tt_{\lambda}B)} \Upsilon$$

We apply Proposition 11.1 with $X = t_{\lambda}Z$, $A_0 = A$, and $B_0 = t_{\lambda}B$; this determines C, D by the equation $S_{t_{\lambda}Z}C + iE_{t_{\lambda}Z}D = iS_{t_{\lambda}Z}A - E_{t_{\lambda}Z}t_{\lambda}B$ with the additional assumption that Cand $t_{\lambda}^{-1}D$ are in \mathfrak{m}_u . With these assumptions, the displayed calculation above continues as

$$= \frac{d}{dt} \bigg|_{0} A d_{g_{u}} A d_{\exp tC} A d_{\exp t_{\lambda}Z + itt_{\lambda}(t_{\lambda}^{-1}D)} \Upsilon$$
$$\underset{dT_{\lambda}^{-1}}{\mapsto} \frac{d}{dt} \bigg|_{0} A d_{g_{u}} A d_{\exp tC} A d_{\exp Z + itD} \Upsilon$$
$$= (C, t_{\lambda}^{-1}D)^{c}_{g_{u},Z}$$

Comparing with Definition 3.1, we see that the proof of Theorem 10.1 is complete after we have verified the following proposition:

Proposition 11.2. With notation as above,

$$C = \lambda_1 (-S_Z^{-1} E_Z B) + \lambda_2 (-J S_Z^{-1} E_Z B) + \lambda_3 J A$$

$$t_{\lambda}^{-1} D = \lambda_1 (E_Z^{-1} S_Z A) + \lambda_2 (-E_Z^{-1} S_Z J A) + \lambda_3 (-E_Z^{-1} S_Z J S_Z^{-1} E_Z B)$$

Proof. So defined, we would have that C and $t_{\lambda}^{-1}D$ are in \mathfrak{m}_u , so the only question is whether the putative formulas for C and D satisfy the equation $S_{t_{\lambda}Z}C + iE_{t_{\lambda}Z}D = iS_{t_{\lambda}Z}A - E_{t_{\lambda}Z}t_{\lambda}B$. Substituting the putative formulas for C and D into the equation and separating the conditions on A and B, it is sufficient to verify that

$$it_{\lambda}S_{t_{\lambda}Z}(A) = i\left(\lambda_{1}E_{t_{\lambda}Z}t_{\lambda}E_{Z}^{-1}S_{Z} - \lambda_{2}E_{t_{\lambda}Z}t_{\lambda}E_{Z}^{-1}S_{Z}J - i\lambda_{3}S_{t_{\lambda}Z}J\right)A$$
$$-E_{t_{\lambda}Z}t_{\lambda}B = -\left(\lambda_{1}S_{t_{\lambda}Z}S_{Z}^{-1}E_{Z} + \lambda_{2}S_{t_{\lambda}Z}JS_{Z}^{-1}E_{Z}B + i\lambda_{3}E_{t_{\lambda}Z}t_{\lambda}E_{Z}^{-1}S_{Z}JS_{Z}^{-1}E_{Z}\right)B$$

and after applying Lemma 4.15(4) and simplifying, this reduces to

$$t_{\lambda}^{-1} = \lambda_1 - \lambda_2 J - i\lambda_3 t_{\lambda}^{-1} J$$
$$I = \lambda_1 t_{\lambda}^{-1} + \lambda_2 t_{\lambda}^{-1} J + i\lambda_3 J$$

The first of these is equivalent to the equation that was verified in Lemma 4.15(6). The second is similar, but with the substitution $\lambda \mapsto 1/\lambda$, $\lambda_1 \mapsto \lambda_1$, $\lambda_2 \mapsto -\lambda_2$, $\lambda_3 \mapsto -\lambda_3$. \Box

11.2. **Proof of Corollary 10.2.** Part 1 is immediate from Theorem 10.1, which gives Part 3. Part 2 is a consequence of the fact that T_{λ} is G_u -equivariant (Definition 4.16).

11.3. **Proof of Theorem 10.3.** We use the "hat" tangent vectors, with $g_u \in G_u$ and $Z \in \mathfrak{m}_0$ fixed, and with $A, B \in \mathfrak{m}_u$. We calculate dT_{λ} :

$$\begin{aligned} (A,B) \hat{f}_{g_{u},Z} & \longmapsto \frac{d}{dt} \Big|_{0} Ad_{g_{u}} Ad_{\exp(tA)} Ad_{\exp(t_{\lambda}Z+itt_{\lambda}B)} \Upsilon \\ &= \frac{d}{dt} \Big|_{0} Ad_{g_{u}} Ad_{\exp(tA)} Ad_{\exp(t_{\lambda}Z)} Ad_{\exp(itE_{t_{\lambda}Z}(t_{\lambda}B))} \Upsilon \\ &= \frac{d}{dt} \Big|_{0} Ad_{g_{u}} Ad_{\exp(t_{\lambda}Z)} Ad_{\exp(tAd_{\exp(-t_{\lambda}Z)}(A))} Ad_{\exp(itE_{t_{\lambda}Z}(t_{\lambda}B))} \Upsilon \\ &= \frac{d}{dt} \Big|_{0} Ad_{g_{u}} Ad_{\exp(t_{\lambda}Z)} Ad_{\exp(t(Ad_{\exp(-t_{\lambda}Z)}(A)+itE_{t_{\lambda}Z}(t_{\lambda}B)))} \Upsilon \end{aligned}$$

Then, from the definition of $\omega_2 + i\omega_3$ as -i times the KKS form, we have, on the one hand, that

$$\begin{aligned} (\omega_2 + i\omega_3) \left(dT_{\lambda}(A_1, B_1), dT_{\lambda}(A_2, B_2) \right) \\ &= -i\kappa \left(\Upsilon, [Ad_{\exp(-t_{\lambda}Z)}A_1 + iE_{t_{\lambda}Z}t_{\lambda}B_1, Ad_{\exp(-t_{\lambda}Z)}A_2 + iE_{t_{\lambda}Z}t_{\lambda}B_2] \right) \\ &= -i\kappa \left([\Upsilon, Ad_{\exp(-t_{\lambda}Z)}A_1 + iE_{t_{\lambda}Z}t_{\lambda}B_1], Ad_{\exp(-t_{\lambda}Z)}A_2 + iE_{t_{\lambda}Z}t_{\lambda}B_2 \right) \\ &= -i\kappa \left(JS_{t_{\lambda}Z}A_1 + iJE_{t_{\lambda}Z}t_{\lambda}B_1, S_{t_{\lambda}Z}A_2 + iE_{t_{\lambda}Z}t_{\lambda}B_2 \right) \\ &= -i\kappa \left(JS_{t_{\lambda}Z}A_1 + iJE_{t_{\lambda}Z}t_{\lambda}B_1, S_{t_{\lambda}Z}A_2 + iE_{t_{\lambda}Z}t_{\lambda}B_2 \right) \\ &= -i\kappa \left(JS_{t_{\lambda}Z}A_1 + it_{\lambda}JE_ZB_1, S_{t_{\lambda}Z}A_2 + it_{\lambda}E_ZB_2 \right) \\ &= -i\kappa \left(JS_{t_{\lambda}Z}A_1, S_{t_{\lambda}Z}A_2 \right) + i\kappa \left(t_{\lambda}JE_ZB_1, t_{\lambda}E_ZB_2 \right) \\ &+ \kappa \left(t_{\lambda}JE_ZB_1, S_{t_{\lambda}Z}A_2 \right) + i\kappa \left(t_{\lambda}JE_ZB_1, t_{\lambda}E_ZB_2 \right) \\ &= -i\kappa \left(JS_{t_{\lambda}Z}A_1, S_{t_{\lambda}Z}A_2 \right) + i\kappa \left(JE_ZB_1, t_{\lambda}E_ZB_2 \right) \\ &+ \kappa \left(t_{\lambda}JE_ZB_1, t_{\lambda}S_Zt_{\lambda}^{-1}A_2 \right) + \kappa \left(JE_ZB_1, E_ZB_2 \right) \\ &= -i\kappa \left(JS_{t_{\lambda}Z}A_1, S_{t_{\lambda}Z}A_2 \right) + i\kappa \left(JS_Zt_{\lambda}^{-1}A_1, E_ZB_2 \right) \\ &- \kappa \left(E_ZB_1, JS_Zt_{\lambda}^{-1}A_2 \right) + \kappa \left(JS_Zt_{\lambda}^{-1}A_1, E_ZB_2 \right), \end{aligned}$$

the last equality via Lemmas 4.18(5) and 4.18(2). On the other hand, we can use Proposition 8.2 to compute that $\frac{i}{2} (\lambda - \lambda^{-1}) \omega_1 + \frac{1}{2} (\lambda + \lambda^{-1}) \omega_2 + i\omega_3$ evaluates on our pair of "hat" vectors to

$$\frac{i}{2}(\lambda - \lambda^{-1}) \left(-\kappa(A_1, S_{JZ}E_ZB_2) + \kappa(S_{JZ}E_ZB_1, A_2)\right) \\ + \frac{1}{2}(\lambda + \lambda^{-1}) \left(\kappa(JS_ZA_1, E_ZB_2) - \kappa(E_ZB_1, JS_ZA_2)\right) \\ + i \left(\kappa(JE_ZB_1, E_ZB_2) - \kappa(JS_ZA_1, S_ZA_2)\right)$$

After collecting terms and using Lemmas 4.1(2) and 4.18(3) and the projection formulas in Lemma 4.4(2,3), the expression simplifies to

$$-i\kappa(JS_ZA_1, S_ZA_2) + i\kappa(JE_ZB_1, E_ZB_2) + \kappa(JS_Z \circ (\lambda \operatorname{proj}_{\mathfrak{m}^-}^{\mathfrak{m}} + \lambda^{-1}\operatorname{proj}_{\mathfrak{m}^+}^{\mathfrak{m}})A_1, E_ZB_2) + \kappa(E_ZB_1, JS_Z(-\lambda \operatorname{proj}_{\mathfrak{m}^-}^{\mathfrak{m}} - \lambda^{-1}\operatorname{proj}_{\mathfrak{m}^+}^{\mathfrak{m}})A_2)$$

To prove Theorem 10.3, we compare like terms. It is immediate that the corresponding B_1, B_2 terms are equal. The corresponding A_1, B_2 and B_1, A_2 terms are equal, simply by interpreting t_{λ}^{-1} as $\lambda proj_{\mathfrak{m}^-}^{\mathfrak{m}} + \lambda^{-1} proj_{\mathfrak{m}^+}^{\mathfrak{m}}$. For the A_1, A_2 terms, we must show

that $\kappa(JS_{t_{\lambda}Z}A_1, S_{t_{\lambda}Z}A_2) = \kappa(JS_ZA_1, S_ZA_2)$. Using Lemmas 4.1(2) and 4.18(3), this is equivalent to $\kappa(JS_{Jt_{\lambda}Z}S_{t_{\lambda}Z}A_1, A_2) = \kappa(JS_{JZ}S_ZA_1A_2)$. By Lemma 4.5, the operators $S_{Jt_{\lambda}Z}S_{t_{\lambda}Z}$ and $S_{JZ}S_Z$ map \mathfrak{m}^+ to \mathfrak{m}^+ and \mathfrak{m}^- to \mathfrak{m}^- ; then by Lemma 4.15(5) we have that $S_{Jt_{\lambda}Z}S_{t_{\lambda}Z} = t_{\lambda}S_{JZ}S_Zt_{\lambda}^{-1}$. Using that κ restricted to either \mathfrak{m}^+ or \mathfrak{m}^- is zero, we have that

$$\begin{aligned} \kappa(JS_{Jt_{\lambda}Z}S_{t_{\lambda}Z}A_{1},A_{2}) &= \kappa(JS_{Jt_{\lambda}Z}S_{t_{\lambda}Z}A_{1}^{+},A_{2}^{-}) + \kappa(JS_{Jt_{\lambda}Z}S_{t_{\lambda}Z}A_{1}^{-},A_{2}^{+}) \\ &= \kappa(Jt_{\lambda}S_{JZ}S_{Z}t_{\lambda}^{-1}A_{1}^{+},A_{2}^{-}) + \kappa(Jt_{\lambda}S_{JZ}S_{Z}t_{\lambda}^{-1}A_{1}^{-},A_{2}^{+}) \\ &= \kappa(i\lambda S_{JZ}S_{Z}\lambda^{-1}A_{1}^{+},A_{2}^{-}) + \kappa(-i\lambda^{-1}S_{JZ}S_{Z}\lambda A_{1}^{-},A_{2}^{+}) \\ &= \kappa(iS_{JZ}S_{Z}A_{1}^{+},A_{2}^{-}) + \kappa(-iS_{JZ}S_{Z}A_{1}^{-},A_{2}^{+}) \end{aligned}$$

Since this is independent of the variable λ , it coincides with the value when $\lambda = 1$, which is $\kappa(JS_{JZ}S_ZA_1, A_2)$.

We record a result of our computation:

Proposition 11.3.

$$(\omega_2 + i\omega_3) (dT_{\lambda}(A_1, B_1), dT_{\lambda}(A_2, B_2)) = -i\kappa (JS_Z A_1, S_Z A_2) + i\kappa (JE_Z B_1, E_Z B_2) + \kappa (JS_Z t_{\lambda}^{-1} A_1, E_Z B_2) - \kappa (E_Z B_1, JS_Z t_{\lambda}^{-1} A_2) \quad \Box$$

11.4. **Proof of Theorem 10.4.** On the one hand, since ω_3 is the imaginary part of $\omega_2 + i\omega_3$, we can apply Proposition 11.3, with help from Lemma 4.15(7), to conclude that

$$(\omega_3) (dT_{\nu}(A_1, B_1), dT_{\nu}(A_2, B_2)) = -\kappa (JS_Z A_1, S_Z A_2) + \kappa (JE_Z B_1, E_Z B_2) + \kappa (JS_Z \circ \frac{t_{\nu}^{-1} - t_{\overline{\nu}}}{2i} (A_1), E_Z B_2) - \kappa (E_Z B_1, JS_Z \circ \frac{t_{\nu}^{-1} - t_{\overline{\nu}}}{2i} (A_2))$$

On the other hand, $\omega_{(J)} = \lambda_1 \omega_1 + \lambda_2 \omega_2 + \lambda_3 \omega_3$, so applying Proposition 8.2, we have that

$$\omega_{(J)} ((A_1, B_1), (A_2, B_2)) = \lambda_1 (-\kappa (A_1, S_{JZ} E_Z B_2) + \kappa (S_{JZ} E_Z B_1, A_2)) + \lambda_2 (\kappa (JS_Z A_1, E_Z B_2) - \kappa (E_Z B_1, JS_Z A_2)) + \lambda_3 (\kappa (JE_Z B_1, E_Z B_2) - \kappa (JS_Z A_1, S_Z A_2))$$

which, by familiar techniques, simplifies to

$$-\lambda_3 \kappa (JS_Z A_1, S_Z A_2) + \lambda_3 \kappa (JE_Z B_1, B_2) + \kappa (JS_Z \circ (\lambda_1 J + \lambda_2) A_1, E_Z B_2) - \kappa (E_Z B_1, JS_Z \circ (\lambda_1 J + \lambda_2) A_2)$$

We have immediately the desired result with regard to the A_1, A_2 and B_1, B_2 terms. To finish the proof, we need $t_{\nu}^{-1} - t_{\overline{\nu}} = 2i \frac{\lambda_1 J + \lambda_2}{\lambda_3}$ as operators on \mathfrak{m} . This is easily verified; both operators are multiplication by $\frac{-4\overline{\lambda}}{1-|\lambda|^2}$ on \mathfrak{m}^+ and multiplication by $\frac{4\lambda}{1-|\lambda|^2}$ on \mathfrak{m}^- . \Box

11.5. **Proof of Corollary 10.5.** First, the putative formula for $\mu_{(\lambda)}$ is G_u -equivariant since T_{ν} and μ_3 both are G_u -equivariant.

Second, we must verify the key formula for moment maps, as stated in Definition 9.1. We let $p \in \mathcal{O}$, let χ_p be a vector tangent to \mathcal{O} at p, let $X \in \mathfrak{g}_u$, and let $(\eta_X)_p = \frac{d}{dt}|_0 Ad_{\exp(tX)}p$. We must show

(4)
$$\frac{1-|\lambda|^2}{1+|\lambda|^2} \kappa \left(d(\mu_3 \circ T_\nu)(\chi_p), X \right) = \omega_{(\lambda)} \left(\chi_p, (\eta_X)_p \right)$$

Since
$$\omega_{(\lambda)} = \frac{1-|\lambda|^2}{1+|\lambda|^2} dT^*_{\nu}(\omega_3)$$
 by Theorem 10.4, we see that Equation 4 is equivalent to

(5)
$$\kappa \left(d(\mu_3 \circ T_\nu)(\chi_p), X \right) = dT_\nu^* \omega_3 \left(\chi_p, (\eta_X)_p \right)$$

The left side of (5) is $\kappa (d\mu_3(dT_\nu(\chi_p)), X)$. The right side of (5) is $\omega_3(dT_\nu(\chi_p), dT_\nu(\eta_X)_p)$. However, $dT_\nu(\eta_X)_p = (\eta_X)_{T_\nu(p)}$. We see this since, on the one hand

(6)
$$dT_{\nu}(\eta_X)_p = \frac{d}{dt}\Big|_0 T_{\nu} \left(Ad_{\exp(tX)}p\right),$$

and on the other hand,

(7)
$$(\eta_X)_{T_{\nu}(p)} = \left. \frac{d}{dt} \right|_0 A d_{\exp(tX)} \left(T_{\nu}(p) \right);$$

these are equal since T_{ν} is G_u -equivariant. With these substitutions, Equation 5 becomes

$$\kappa\left(d\mu_3(dT_\nu(\chi_p)), X\right) = \omega_3\left(dT_\nu(\chi_p), (\eta_X)_{T_\nu(p)}\right)$$

which is valid since μ_3 is the moment map relative to ω_3 .

11.6. **Proof of Theorem 10.6.** We begin with \mathcal{O} . By strong orthogonality, the proof reduces to a calculation in SL(2), namely,

where r and s are as in the statement of the theorem.

On the one hand, by Lemma 4.7, the left side of Equation 8 is $\begin{pmatrix} \cosh 2c & -\lambda \sinh 2c \\ \frac{\sinh 2c}{\lambda} & -\cosh 2c \end{pmatrix}$. Using Lemma 4.7, matrix multiplication, and trigonometric identities, one can show that the right side of Equation 8 is

$$\begin{pmatrix} \cosh(2r)\cos(2s) & u^2\cosh(2r)\sin(2s) - u^2\sinh(2r) \\ \overline{u}^2\cosh(2r)\sin(2s) + \overline{u}^2\sinh(2r) & -\cosh(2r)\cos(2s) \end{pmatrix}$$

We are finished if we can verify the equations

- (a) $\cosh(2c) = \cosh(2r)\cos(2s)$
- (b) $|\lambda| \sinh(2c) = \sinh(2r) \cosh(2r)\sin(2s)$

(c)
$$\frac{\sinh(2c)}{|\lambda|} = \sinh(2r) + \cosh(2r)\sin(2s)$$

which is to say

(a)
$$\cosh(2c) = \cosh(2r)\cos(2s)$$

(b) $\frac{1}{2}\left(\frac{1}{|\lambda|} + |\lambda|\right)\sinh(2c) = \sinh(2r)$
(c) $\frac{1}{2}\left(\frac{1}{|\lambda|} - |\lambda|\right)\sinh(2c) = \cosh(2r)\sin(2s)$

Equation (b) follows immediately from the definition of r. Dividing the corresponding sides of (c) and (a), one obtains the equation $\frac{1}{2}\left(\frac{1}{|\lambda|} - |\lambda|\right) \tanh(2c) = \tan(2s)$, which is true by the definition of s. We conclude by verifying Equation (a). Note that since $\cosh takes$ on positive values and since $\cos(2s)$ is positive by the definition of s, it is sufficient to verify that (a) $\cosh^2(2c) = \cosh^2(2r) \cos^2(2s)$. We can write $\cosh^2(2r) as 1 + \sinh^2(2r)$ and $\cos^2(2s)$ as $\frac{1}{1+\tan^2(2s)}$ and then use the definitions of r and s to simplify $\cosh^2(2r) \cos^2(2s)$;

after algebraic manipulation and the use of the Pythagorean trigonometric identities, this reduces to $\cosh^2(2c)$. This concludes the proof of the first part of Theorem 10.6.

In the second part of Theorem 10.6, we observe that by the formula in Section 4.5, $\Phi^{-1}[g_u, W] = Ad_{g_u}Ad_{\exp(\sum c_{\psi}x_{\psi})}\Upsilon$, where $c_{\psi} = \frac{1}{2}\operatorname{arcsinh}(-2d_{\psi})$. This is sent by T_{λ} to $Ad_{g'_u}Ad_{\exp Z'}\Upsilon$, where g'_u and Z' are as in Part 1 of the theorem. We consider these in turn. First, in the formula for g'_u , we note that

$$s_{\psi} = \frac{1}{2} \arctan\left(\frac{1}{2}\left(\frac{1}{|\lambda|} - |\lambda|\right) \tanh(2c_{\psi})\right)$$
$$= \frac{1}{2} \arctan\left(\frac{1}{2}\left(\frac{1}{|\lambda|} - |\lambda|\right) \tanh(\operatorname{arcsinh}(-2d_{\psi}))\right)$$
$$= \frac{1}{2} \arctan\left(\left(\frac{1}{|\lambda|} - |\lambda|\right) \frac{-d_{\psi}}{1 + 4d_{\psi}^{2}}\right)$$

using that $\tanh(\operatorname{arcsinh} z) = \frac{z}{\sqrt{1+z^2}}$. Second, we know that $Z' = \sum_{\psi} r_{\psi} \cdot t_{u^2}(x_{\psi})$; then note that in computing $\Phi\left(Ad_{g'_u}Ad_{\exp Z'}\Upsilon\right)$, in the second slot the entry W' will be

$$-iP\left(\sum_{\psi} r_{\psi} \cdot t_{u^2}(x_{\psi})\right) = -i \cdot \frac{1}{2} \sum_{\psi} \sinh(2r_{\psi}) \cdot t_{u^2}(x_{\psi})$$
$$= -\frac{i}{2} \sum_{\psi} -\left(\frac{1}{|\lambda|} + |\lambda|\right) d_{\psi} \cdot t_{u^2}(x_{\psi})$$
$$= \frac{i}{2} \left(\frac{1}{|\lambda|} + |\lambda|\right) \sum_{\psi} d_{\psi} \cdot t_{u^2}(x_{\psi})$$

The formula $W' = \frac{1}{2} \left(t_{\lambda} + t_{1/\overline{\lambda}} \right) W$ follows immediately.

11.7. **Proof of Corollary 10.7.** This is easily seen in the setting $G_u *^{K_0} \mathfrak{m}_u$. The key observation is that $\frac{1}{2} \left(t_{\lambda} + t_{1/\overline{\lambda}} \right) : \mathfrak{m}_u \to \mathfrak{m}_u$ is bijective. Note that by Theorem 10.6, T_{λ} sends $[g_u, W]$ to $[g'_u, \frac{1}{2}(t_{\lambda} + t_{1/\overline{\lambda}})W]$, where g'_u equals g_u times an element of G_u that depends on W. For this, it is an easy exercise to see that T_{λ} is a bijection.

12. Application: A new view of an old action

In this section, we apply the main results of §10, focusing on the action of G_0 on \mathcal{O} .

On the one hand, recall that for each $\lambda \in \mathbb{C}^*$, there is a holomorphic action of G on \mathcal{O} , relative to the complex structure $J_{(\lambda)}$. By Corollary 10.2, each of these actions is equivalent to the usual action of G on \mathcal{O} via the explicit intertwining map T_{λ} . For $\lambda = 0$ or ∞ , the the holomorphic action degenerates to the usual holomorphic action of G on $T^*(G/Q)$.

On the other hand, as developed in [9], [10], for any choice of λ , there is a moment-critical subset of \mathcal{O} (or equally well, of $T^*(G/Q)$), which arises via the composition

$$\mathcal{O} \stackrel{\mu_{(\lambda)}}{\to} \mathfrak{g}_u \stackrel{\mathrm{proj}}{\to} \mathfrak{m}_u$$

These moment-critical sets are K_0 -stable and often do a good job at representing the G_0 orbits. By Corollary 10.5, if $\lambda \neq 1$, then the moment-critical subset for $J_{(\lambda)}$ is obtained by pushing forward the moment-critical subset for J_3 using the explicit intertwining map T_{ν} . These two ideas come together in the following way. We take the usual action (with complex structure J_1) of G_0 on \mathcal{O} as the fundamental topic of interest. The moment-critical subset represents the topologically closed G_0 -orbits—a typical outcome for actions on an affine variety [13]. However, both the G_0 -orbit structure and moment-critical sets for the action of G_0 on $T^*(G/Q)$ (with complex structure J_3) are quite different than for J_1 . Then for intermediate complex structures $J_{(\lambda)}$ ($0 < |\lambda| < 1$), the G_0 -orbit structure resembles that for J_1 , and the moment-critical subsets resemble those for J_3 . The new window on the action of G_0 on \mathcal{O} comes from considering these $J_{(\lambda)}$. Specifically, we use T_{ν} to push forward the moment-critical subset for J_3 , obtaining the moment-critical subset for $J_{(\lambda)}$. Here, since the holomorphic action of G_0 in \mathcal{O} . The remarkable fact is that one obtains a quite different moment-critical subset than for J_1 , that in particular, represents different G_0 -orbits. In particular, it represents at least some of the non-closed orbits.

Below, we show how this works out for SL(2). We will borrow freely from some of the (complicated) results in [5], where the reader can find justifications of some of the background outlined below.

In this example, we have
$$G_u = SU(2)$$
, $G_0 = SU(1, 1)$, and $K_0 = \left\{ \begin{pmatrix} e^{i\theta} & 0\\ 0 & e^{-i\theta} \end{pmatrix} : \theta \in \mathbb{R} \right\}$.
The K_0 -orbit of each point in \mathcal{O} is represented by an element of the form

$$\begin{pmatrix} * \\ * \end{pmatrix} \qquad \qquad \begin{array}{c} Ad \\ \left(\cos s & -\sin s \\ \sin s & \cos s \end{array} \right) \begin{pmatrix} e^{ic} & 0 \\ 0 & e^{-ic} \end{pmatrix} \begin{pmatrix} \cosh r & \sinh r \\ \sinh r & \cosh r \end{pmatrix} \Upsilon$$

which under the identification of \mathcal{O} with $G *^{Q} \mathfrak{m}^{-}$, corresponds to the point

$$\left[\begin{pmatrix} \cos s & -\sin s \\ \sin s & \cos s \end{pmatrix}, \frac{1}{2i} \begin{pmatrix} 0 & 0 \\ e^{-2ic} \cdot \sinh 2r & 0 \end{pmatrix} \right]$$

We regard $G *^Q \mathfrak{m}^-$ as the cotangent bundle to the 2-sphere, with the base being $G/Q \simeq S^2$ and the fiber over the base point being $\mathfrak{m}^- \simeq \mathbb{R}^2$. In the version (*), *s* determines latitude on the 2-sphere (with s = 0 giving the north pole, $s = \pi/4$ giving a point on the equator, and $s = \pi/2$ giving the south pole). The parameter *r* reflects magnitude in the fiber, while a change of θ produces rotation in the fiber. Under this correspondence, the north pole is obtained when s = 0 = r and corresponds to $\Upsilon \in \mathcal{O}$, and the south pole is obtained when $s = \pi/2$ and r = 0, and this corresponds to $-\Upsilon$. More generally, the correspondence (**) carries \mathcal{O}_0 (resp. $-\mathcal{O}_0$) to the cotangent plane at the north (resp. south) pole, and \mathcal{O}_u to the base 2-sphere. The K_0 -conjugacy class of $\frac{i}{2} \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}$ gives the equator of the 2-sphere; in (*), it is achieved by $s = \pi/4$ and r = 0.

Below, we discuss the G_0 -orbit structure and moment-critical subsets for the complex structures J_3 and J_1 , then display the push-forward of the J_3 -moment-critical subsets by $T_{\lambda}^{-1} \circ T_{\nu}$.

12.1. The complex structure J_3 .

12.1.1. G_0 -orbit structure. We interpret in the context of the cotangent bundle. The group G_0 acts on the base with three orbits: the northern hemisphere, the southern hemisphere, and the equator. These are represented by Υ , $-\Upsilon$, and the point as in (*) with $s = \pi/4$ and c, r = 0. As homogeneous spaces, the first two are isomorphic to G_0/K_0 and the third

is G_0/B_0 , where B_0 consists of the real points of a split Borel subgroup. The closure of either of the hemispheres contains the equator.

Any other G_0 -orbit in $G *^Q \mathfrak{m}^-$ projects under $G *^Q \mathfrak{m}^- \to G/Q$ to one of the three orbits above.

There is a ray of orbits projecting to the upper hemisphere, each of them intersecting the cotangent space at the north pole in a single K_0 -orbit (a circle). Each orbit is represented by a point of the form (*) with s = 0 = c, and a choice of r > 0 that uniquely determines the orbit. Each such orbit is closed and is isomorphic to $G_0/\{\pm I\}$ as a homogeneous space. There is a similar situation for orbits over the southern hemisphere.

Finally, there are orbits that project to the equator. There is a circle of such orbits, each isomorphic to G_0/U_0 , where U_0 is the group of real points of the unipotent radical of a split Borel subgroup, extended by $\pm I$. Each orbit is represented by a point as in (*) with $s = \pi/4$, r = 1 (or any positive number), and a choice of $\theta \in [0, \pi)$ that uniquely determines the G_0 -orbit. Each of these orbits contains the equator in its closure.

12.1.2. The moment-critical subset. The K_0 -orbits of the moment-critical subsets are represented by:

• Points (*) with s = 0, c = 0, and $r \ge 0$. The K-orbits of these points comprise the cotangent space at the north pole. Thus, each G_0 -orbit in $G *^Q \mathfrak{m}^-$ projecting to the upper hemisphere intersects the moment-critical subset in a single K_0 -orbit, namely, the points in the orbit that lie above the north pole. This applies both to the closed G_0 -orbits (r > 0), and the upper hemisphere itself (r = 0). There are similar considerations for the southern hemisphere, using $s = \pi/2$.

• The point (*) with $s = \pi/4$ and r = 0 = c. The K_0 -orbit of this point is exactly the equator of the 2-sphere. Thus the equator is a G_0 -orbit but consists entirely of moment-critical points; the non-closed G_0 -orbits projecting to the equator are not represented by moment-critical points.

12.2. The complex structure J_1 .

12.2.1. G_0 -orbit structure. The set \mathcal{O} contains one-parameter families of orbits isomorphic to $G_0/\{\pm I\}$ —all but four of them topologically closed, along with two orbits isomorphic to G_0/K_0 , and one isomorphic to G_0/T_0 , where T_0 is the group of real points of a split torus. To explain how these orbits fit together, it's useful to consider a G_0 -invariant function on \mathcal{O} . We have that $\mathcal{O} = \left\{ \frac{i}{2} \begin{pmatrix} A & B \\ C & -A \end{pmatrix} : A, B, C \in \mathbb{C} \text{ and } A^2 + BC = 1 \right\}$; the real-valued function $f = \frac{2|A|^2 - |B|^2 - |C|^2}{2}$ is G_0 -invariant and has range $(-\infty, 1]$. The exceptional G_0 -orbits occur when $f = \pm 1$. There are two orbits on which f = 1,

The exceptional G_0 -orbits occur when $f = \pm 1$. There are two orbits on which f = 1, namely the orbits $\pm \mathcal{O}_0$ of $\pm \Upsilon$, respectively, which are closed in \mathcal{O} and isomorphic to G_0/K_0 . Given a point $\frac{i}{2} \begin{pmatrix} A & B \\ C & -A \end{pmatrix}$ at which f = 1, one can determine whether it is in the G_0 -orbit of Υ or $-\Upsilon$ according to whether the real part of A is positive or negative.

There are five orbits on which f = -1. One of them is topologically closed, namely, the orbit of $\frac{i}{2} \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}$, which is the orbit isomorphic to G_0/T_0 . Four orbits contain this orbit in their closures; they are isomorphic to $G_0/\{\pm I\}$. They are represented by $\frac{i}{2} \begin{pmatrix} 1 & 2 \\ 0 & -1 \end{pmatrix}$,

 $\frac{i}{2} \begin{pmatrix} -1 & 2 \\ 0 & 1 \end{pmatrix}, \frac{i}{2} \begin{pmatrix} 1 & 0 \\ 2 & -1 \end{pmatrix}$, and $\frac{i}{2} \begin{pmatrix} -1 & 0 \\ 2 & 1 \end{pmatrix}$. Given that f = -1, the closed orbit is determined by the conditions Re(A) = 0 and |B| = |C|. The other four orbits are separated by the signs of Re(A) and |B| - |C|.

There are two orbits for each value of f with -1 < f < 1, each topologically closed and isomorphic to $G_0/\{\pm I\}$. The sign of $\Re A$ separates the two orbits. An interesting choice of representatives occurs when C = B and $A, B \in \mathbb{R}^*$. We obtain matrices $\frac{i}{2} \begin{pmatrix} A & B \\ B & -A \end{pmatrix}$ with $A^2 + B^2 = 1$, on which f takes the value $2A^2 - 1 \in (-1, 1)$.

Similarly, when f < -1, there are two G_0 -orbits for each choice of the invariant f, each closed and isomorphic to $G_0/\{\pm 1\}$. The sign of |B| - |C| separates the two orbits. Interesting representatives occur with the choice $A = 0, B > 0, B \neq 1$. We obtain matrices $\frac{i}{2} \begin{pmatrix} 0 & B \\ B^{-1} & 0 \end{pmatrix}$, on which f takes the value $-(B^2 + B^{-2})/2 \in (-\infty, -1)$.

12.2.2. The moment-critical subset.

• One collection of critical points comes from points (*) with r = 0. Viewed in $G *^Q \mathfrak{m}^-$, this constitutes the base 2-sphere; viewed in \mathcal{O} , it is \mathcal{O}_u . The point (*) is

$$Ad_{\begin{pmatrix}\cos s & -\sin s\\\sin s & \cos s\end{pmatrix}}\Upsilon = \frac{i}{2}\begin{pmatrix}\cos 2s & \sin 2s\\\sin 2s & -\cos 2s\end{pmatrix}$$

which maps under f to $\cos^2 2s - \sin^2 2s = \cos 4s$. We obtain all matrices of this form by a choice of $s \in [0, \pi)$. The choices s = 0 and $s = \pi/2$ produce $\pm \Upsilon$, at which f = 1, and the choice $s = \pi/4$ produces $\frac{i}{2} \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}$, which lies on the closed orbit with f = -1. The choices s and $\pi/2 + s$ (with $s \in (0, \pi/4)$) produce representatives of the two orbits at which $f = \cos 4s \in (-1, 1)$.

• A second collection of critical points (overlapping with the first) comes from points (*) with $s = \pi/4$, $c = \pi/2$, and r arbitrary. Together, these can be viewed as a line bundle over the equator in $G *^Q \mathfrak{m}^-$, or as the K-conjugacy class of $\frac{i}{2} \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}$ in \mathcal{O} . The point (*) is

$$Ad_{\frac{1}{\sqrt{2}}\begin{pmatrix}1 & -1\\1 & 1\end{pmatrix}\begin{pmatrix}\cosh r & \sinh r\\\sinh r & \cosh r\end{pmatrix}}\Upsilon = \frac{i}{2}\begin{pmatrix}0 & e^{-2r}\\e^{2r} & 0\end{pmatrix}$$

which maps under f to $\cosh 4r$.

Thus, we see that the critical sets comprise the representatives of the closed orbits described in 12.2.1.

12.3. Alternate moment-critical points for the action of G_0 on \mathcal{O} . Fix λ with $0 < |\lambda| < 1$ and take ν as in Section 10. Using Theorem 10.6, we can compute $T_{\lambda}^{-1} \circ T_{\nu}$ for SL(2). We consider the moment-critical subsets for J_3 (§12.1.2) and report their images under $T_{\lambda}^{-1} \circ T_{\nu}$.

 \bullet Regarding the *first* type, the moment-critical point (cotangent vector at the north pole)

$$Ad \begin{pmatrix} e^{ic} & 0\\ 0 & e^{-ic} \end{pmatrix} \begin{pmatrix} \cosh r & \sinh r\\ \sinh r & \cosh r \end{pmatrix} \Upsilon = \frac{i}{2} \begin{pmatrix} \cosh 2r & e^{2ic} \sinh 2r\\ -e^{-2ic} \sinh 2r & -\cosh 2r \end{pmatrix}$$

pushes forward under $T_{\lambda}^{-1} \circ T_{\nu}$ to

$$\begin{aligned} & Ad \begin{pmatrix} e^{ic} & 0 \\ 0 & e^{-ic} \end{pmatrix} \begin{pmatrix} \cos s' & \sin s' \\ -\sin s' & \cos s' \end{pmatrix} \begin{pmatrix} \cosh r' & \sinh r' \\ \sinh r' & \cosh r' \end{pmatrix} \Upsilon \\ &= \frac{i}{2} \begin{pmatrix} \cos 2s' \cosh 2r' & e^{2ic} (\sinh 2r' - \sin 2s' \cosh 2r') \\ -e^{-2ic} (\sinh 2r' + \sin 2s' \cosh 2r') & -\cos 2s' \cosh 2r' \end{pmatrix} \end{aligned}$$

where

$$s' = \frac{1}{2} \arctan\left(\frac{-(\sinh 2r)\sqrt{(\cosh^2 2r)\left(1 - |\lambda|^2\right)^2 + 4|\lambda|^2}}{2|\lambda|}\right)$$
$$r' = \frac{1}{2} \operatorname{arcsinh}\left(\frac{1}{2}\left(\frac{1}{|\lambda|} - |\lambda|\right)\sinh 2r\right)$$

are odd functions of r.

One computes that the invariant f takes the value

$$f = 1 - 2\sin^2(2s')\cosh^2(2r') = 1 - \tanh^2(2r)\left(4|\lambda|^2 + (1 - |\lambda|^2)^2\cosh^2(2r)\right)/2|\lambda|^2$$

from which it follows that f takes on all values in $(-\infty, 1]$ on this critical set. The function f takes on the value -1 in this critical set at points $\frac{i}{2} \begin{pmatrix} A & B \\ C & -A \end{pmatrix}$ where we see that A is real and positive, hence at non-closed orbits.

• The second type, consisting of points on the equator, are fixed by $T_{\lambda}^{-1} \circ T_{\nu}$. These are the "overlap" in the two critical sets for J_1 , as reported in §12.2.2.

Thus, we obtain a critical subset which, on the set f = -1, represents the closed orbit (via critical points of the second type), and two of the four non-closed orbits (via critical points of the first type). This is remarkably different from what was described for J_1 in Section 12.2.2.
